# On Cremona transformations of prime order 

Arnaud Beauville

## 1. The result

The Cremona group $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ is the group of birational transformations of $\mathbb{P}_{\mathbb{C}}^{2}$, or equivalently the group of $\mathbb{C}$-automorphisms of the field $\mathbb{C}(x, y)$. There is an extensive classical literature about this group, in particular about its finite subgroups; we refer to the introduction of [dF] for a list of references.

The classification of conjugacy classes of transformations of prime order $p$ has been given a modern treatment in [B-B] for $p=2$ and in [dF] for $p \geq 3$. Let us recall the main results. The linear transformations of given order are contained in a unique conjugacy class. Apart from these there are 3 continuous families of conjugacy classes of involutions (the famous de Jonquières, Bertini and Geiser involutions), and 3 families of transformations of order 3 . Every transformation of prime order $\geq 7$ is conjugate to a linear automorphism.

We prove in this note the following result, which completes the classification:
Theorem.- Every Cremona transformation of order 5 is conjugate in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ to a linear automorphism.

Most of the work has been done already in [dF], where it is proved that such a transformation is conjugate either to a linear automorphism or to the transformation $\gamma:(x, y) \mapsto\left(1-y, 1-\frac{y}{x}\right)$. What remains to prove is that $\gamma$ is conjugate to a linear automorphism.

Fix a primitive 5 -th root of unity $\zeta$. The problem is readily translated into the existence of a rational function $\mathrm{F}(x, y)$ satisfying the functional equation

$$
\mathrm{F}(\zeta x, y) \mathrm{F}\left(\zeta^{-1} x, y\right)+\mathrm{F}(x, y)=1
$$

and such that the rational map $(x, y) \mapsto(\mathrm{F}(x, y), 1-\mathrm{F}(\zeta x, y))$ is birational. At this point Don Zagier explained to me a very simple way to construct solutions to $(\star)$; it turns out that essentially the most economical choice satisfies indeed the second condition and thus leads to a proof of the theorem.

## 2. The proof

Let us first recall why linear automorphisms of the same (finite) order are conjugate:

Proposition .- Let $n$ be a positive integer. Two linear automorphisms of order $n$ are conjugate in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$.

Proof: Let $\mathrm{T}=\mathbb{C}^{*} \times \mathbb{C}^{*}$ be the standard maximal torus of $\mathrm{PGL}_{3}$. We can view T as a Zariski open subset of $\mathbb{P}^{2}$, so its automorphism group $\operatorname{GL}(2, \mathbb{Z})$ embeds naturally in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ : an element $\left(\begin{array}{ll}a & b \\ c & d\end{array}\right)$ of $\operatorname{GL}(2, \mathbb{Z})$ corresponds to the Cremona transformation $(x, y) \mapsto\left(x^{a} y^{b}, x^{c} y^{d}\right)$. The image of $\mathrm{GL}(2, \mathbb{Z})$ in $\operatorname{Bir}\left(\mathbb{P}^{2}\right)$ normalizes $T$, and its action on $T$ by conjugation is just the original action of $\mathrm{GL}(2, \mathbb{Z})$ on T .

We want to prove that two elements of order $n$ of T are conjugate under this action. The kernel of the multiplication by $n$ in T is $(\mathbb{Z} / n)^{2}$; any element of order $n$ in the $\mathbb{Z} / n$-module $(\mathbb{Z} / n)^{2}$ is part of a basis, which implies that it is conjugate to $(1,0)$ under the action of $\operatorname{SL}(2, \mathbb{Z} / n)$. Since the natural map $\operatorname{SL}(2, \mathbb{Z}) \rightarrow \mathrm{SL}(2, \mathbb{Z} / n)$ is surjective, this proves our result.

## Proof of the theorem

We want to prove that $\gamma=h \circ \ell \circ h^{-1}$, with $h \in \operatorname{Bir}\left(\mathbb{P}^{2}\right)$ and $\ell \in \mathrm{PGL}_{3}$. By the Proposition we can take for $\ell$ the map $(x, y) \mapsto(\zeta x, y)$, where $\zeta$ is a primitive 5 -th root of unity. Write $h(x, y)=(\mathrm{F}(x, y), \mathrm{G}(x, y))$. The equality $h=\gamma \circ h \circ \ell^{-1}$ becomes

$$
\mathrm{F}(x, y)=1-\mathrm{G}\left(\zeta^{-1} x, y\right) \quad \mathrm{G}(x, y)=1-\frac{\mathrm{G}\left(\zeta^{-1} x, y\right)}{\mathrm{F}\left(\zeta^{-1} x, y\right)}
$$

The first equality gives $\mathrm{G}(x, y)=1-\mathrm{F}(\zeta x, y)$, and the second becomes

$$
\mathrm{F}(\zeta x, y) \mathrm{F}\left(\zeta^{-1} x, y\right)+\mathrm{F}(x, y)=1
$$

Conversely, if F satisfies $(\star)$ and the map $h:(x, y) \mapsto(\mathrm{F}(x, y), 1-\mathrm{F}(\zeta x, y))$ is birational, we have $\gamma=h \circ \ell \circ h^{-1}$.

The following trick, which was explained to me by Don Zagier, allows to solve equation $(\star)$. We will use for the cross-ratio of distinct elements $x_{1}, \ldots, x_{4}$ in a field K the normalization

$$
\left[x_{1}: \ldots: x_{4}\right]=\frac{\left(x_{1}-x_{4}\right)\left(x_{2}-x_{3}\right)}{\left(x_{1}-x_{3}\right)\left(x_{2}-x_{4}\right)}
$$

Lemma.- Let K be a field, and $\sigma$ an automorphism of order 5 of K. Let $t$ be an element of K with $\sigma(t) \neq t$. The cross-ratio $r=\left[\sigma(t): \ldots: \sigma^{4}(t)\right]$ satisfies

$$
\sigma(r) \sigma^{-1}(r)+r=1
$$

Proof: Let $t_{0}, \ldots, t_{4}$ be distinct elements of $\mathbb{P}^{1}(\mathrm{~K})$. The cross-ratios

$$
r_{i}=\left[t_{i+1}: t_{i+2}: t_{i+3}: t_{i+4}\right]
$$

where the index $i$ runs in $\mathbb{Z} / 5$, satisfy

$$
r_{i-1} r_{i+1}+r_{i}=1 \quad \text { for each } i \text {; }
$$

this is easily seen either by direct computation, or by using the $\mathrm{PGL}_{2}$-invariance of the cross-ratio to reduce to the case $\left(t_{0}, \ldots, t_{4}\right)=(\lambda, 0, \infty, 1, \mu)$.

Coming back to the statement of the lemma we put $t_{i}=\sigma^{i}(t)$; then $r_{i}=\sigma^{i}(r)$, hence the result.

We apply this lemma to the field $\mathbb{C}(x, y)$, with the automorphism $\sigma$ which fixes $y$ and maps $x$ to $\zeta x$. Starting with any rational function $t(x, y)$ with $t(x, y) \neq t(\zeta x, y)$, the cross-ratio $\mathrm{F}\left(x, y=\left[t\left(\zeta x, y: \ldots: t\left(\zeta^{4} x, y\right)\right)\right]\right.$ is a solution to our equation $(\star)$; we want moreover the map $h:(x, y) \mapsto(\mathrm{F}(x, y), 1-\mathrm{F}(\zeta x, y))$ to be birational. Observe that this excludes functions $t$ of the form $x^{p} a(y)+x^{q} b(y)$, because for that choice $h$ factors through the map $(x, y) \mapsto x^{q-p} b(y) a(y)^{-1}$. This leads us to try $t(x, y)=x+x^{2}+x^{3} y$; putting $\omega=\zeta+\zeta^{-1}$ we find:

$$
\mathrm{F}(x, y)=\omega \frac{1-x-x^{2}(y-1)+2 x^{3} y-x^{4} y^{2}}{1-x-\omega^{2} x^{2}(y-1)+\omega x^{3} y-\omega^{2} x^{4} y^{2}} .
$$

We want to invert the system $\mathrm{F}(x, y)=u, 1-\mathrm{F}(\zeta x, y)=v$. Together with the functional equation $(\star)$ for F it implies
$\mathrm{F}\left(\zeta^{i} x, y\right)=u_{i} \quad(0 \leq i \leq 3), \quad$ with $u_{0}=u, u_{1}=1-v, u_{2}=\frac{v}{u}, u_{3}=\frac{u-v}{u(1-v)} ;$
that is, explicitely:
$x \zeta^{i}\left(\omega^{-1} u_{i}-1\right)+x^{2}(y-1) \zeta^{2 i}\left(\omega u_{i}-1\right)+x^{3} y \zeta^{3 i}\left(2-u_{i}\right)+x^{4} y^{2} \zeta^{4 i}\left(\omega u_{i}-1\right)=\omega^{-1} u_{i}-1$.
This gives a system of 4 linear equations in $x, x^{2}(y-1), x^{3} y, x^{4} y^{2}$. If the corresponding determinant is nonzero we can express $x$ and $x^{3} y$, and thus also $y$, as rational functions of $(u, v)$, so that $h$ is birational.

Thus it remains to prove that the determinant of the system

$$
\operatorname{det}\left(\begin{array}{cccc}
\omega^{-1} u_{0}-1 & \omega u_{0}-1 & 2-u_{0} & \omega u_{0}-1 \\
\zeta\left(\omega^{-1} u_{1}-1\right) & \zeta^{2}\left(\omega u_{1}-1\right) & \zeta^{3}\left(2-u_{1}\right) & \zeta^{4}\left(\omega u_{1}-1\right) \\
\zeta^{2}\left(\omega^{-1} u_{2}-1\right) & \zeta^{4}\left(\omega u_{2}-1\right) & \zeta\left(2-u_{2}\right) & \zeta^{3}\left(\omega u_{2}-1\right) \\
\zeta^{3}\left(\omega^{-1} u_{3}-1\right) & \zeta\left(\omega u_{3}-1\right) & \zeta^{4}\left(2-u_{3}\right) & \zeta^{2}\left(\omega u_{3}-1\right)
\end{array}\right)
$$

is nonzero. It is enough to prove that it does not vanish for particular values of $u, v$ such that $u_{0}, \ldots, u_{3}$ are finite. We choose $u=\omega^{-1}, v=-\omega$. This gives $u_{0}=u_{1}=\omega^{-1}, u_{2}=\omega-1, u_{3}=3 \omega-1$; our determinant becomes:

$$
\operatorname{det}\left(\begin{array}{cccc}
\omega^{-1} & 0 & \omega^{2} & 0 \\
\zeta \omega^{-1} & 0 & \zeta^{3} \omega^{2} & 0 \\
-\zeta^{2} \omega^{-1} & -2 \zeta^{4} \omega & \zeta(3-\omega) & -2 \zeta^{3} \omega \\
\zeta^{3} \omega^{2} & \zeta(2-4 \omega) & 3 \zeta^{4} \omega^{2} & \zeta^{2}(2-4 \omega)
\end{array}\right)
$$

$$
\begin{aligned}
& =-\operatorname{det}\left(\begin{array}{cc}
\omega^{-1} & \omega^{2} \\
\zeta \omega^{-1} & \zeta^{3} \omega^{2}
\end{array}\right) \operatorname{det}\left(\begin{array}{cc}
-2 \zeta^{4} \omega & -2 \zeta^{3} \omega \\
\zeta(2-4 \omega) & \zeta^{2}(2-4 \omega)
\end{array}\right) \\
& =2 \zeta^{2} \omega^{2}(4 \omega-2)\left(\omega^{2}-4\right) \neq 0
\end{aligned}
$$

which proves the theorem.
