# Weak convergence of positive self-similar Markov processes and overshoots of Lévy processes.

#### Abstract

Using Lamperti's relationship between Lévy processes and positive self-similar Markov processes ( pssMp ), we study the weak convergence of the law $\mathbb{P}_{x}$ of a pssMp starting at $x>0$, in the Skorohod space of càdlàg paths, when $x$ tends to 0 . To do so, we first give conditions which allow us to construct a càdlàg Markov process $X^{(0)}$, starting from 0 , which stays positive and verifies the scaling property. Then we establish necessary and sufficient conditions for the laws $\mathbb{P}_{x}$ to converges weakly to the law of $X^{(0)}$ as $x$ goes to 0 . In particular, this answers a question raised by Lamperti [11] about the Feller property for pssMp at $x=0$.

## 1 Introduction

An $\mathbb{R}_{+}$-valued self-similar Markov process $X$, under the family of probabilities $\left(\mathbb{P}_{x}, x>\right.$ 0 ) is a càdlàg Markov process which fulfills a scaling property, i.e., there exists a constant $\alpha>0$ such that

\text { the law of }\left(k X_{k^{-\alpha}}, t \geq 0\right) \text { under } \mathbb{P}_{x} \text { is } \mathbb{P}_{k x} \text {, for all } k>0 \tag{1.1}
\end{equation*}
$$

Self-similar Markov processes are involved in various parts of probability theory such as branching processes and fragmentation theory. They also arise as limit of re-scaled Markov processes. Their properties have been deeply studied by the early sixties, especially through Lamperti's work on one dimensional branching processes. In this paper, we focus on positive self-similar Markov processes to which we will refer as pssMp. Some particularly well known examples which are discussed in Section 4 are Bessel
processes, stable subordinators or more generally, stable Lévy processes conditioned to stay positive.

From a straightforward argument using (1.1), it is easily seen that the family of measures $\left(\mathbb{P}_{x}\right)$ defined on the Skorohod's space of càdlàg functions is weakly continuous in $x$ on the open half-line $(0, \infty)$. The question of the existence of a weak limit when $x$ goes towards 0 is much less obvious. This is the main object of our paper.

Let $\rho \stackrel{\text { (def) }}{=} \inf \left\{t: X_{t}=0\right\}$, then it appears from Lamperti's study [11] that any positive self-similar Markov process $X$ is such that either: $\rho<\infty$ and $X_{\rho_{-}}=0$ a.s., or $\rho<\infty$ and $X_{\rho-}>0$ a.s., or $\rho=+\infty$ a.s., and this trichotomy does not depend on the starting point $x>0$. In the two first cases, the Markov property implies that the process $\left(X_{\rho+t}, t \geq 0\right)$ is independent of the process ( $X_{t}, t \leq \rho$ ) and its law does not depend on $x$. Moreover, the scaling property implies that $\lim _{x \rightarrow 0} \rho=0$ a.s., hence, this shows that the family of measures $\left(\mathbb{P}_{x}\right)$ converges weakly, as $x$ goes to 0 , towards the law of the process ( $X_{\rho+t}, t \geq 0$ ). Let us mention that in these cases, Rivero [12] and [13] studied the different ways to construct an entrance law for the process $\left(X_{\rho+t}, t \geq 0\right)$. So we shall focus on the last case, that is when $\rho=+\infty$, a.s. Then the state space of $\left(X, \mathbb{P}_{x}\right), x>0$ is $(0, \infty)$ and 0 is a boundary point. It is then natural to wonder if the semigroup of $\left(X, \mathbb{P}_{x}\right)$ can be extended to the nonnegative half-line $[0, \infty)$; in other words, can an entrance law at 0 for $\left(X, \mathbb{P}_{x}\right)$ be defined ? This problem has first been raised by Lamperti [11] who observed in the proof of his Theorem 2.1 that "...the Feller property may fail at $x=0$ ". It has been partially solved by Bertoin and Caballero [2] and Bertoin and Yor [4] who gave sufficient conditions for the weak convergence of $\mathbb{P}_{x}$ to hold when $x$ tends to 0 , in the sense of finite dimensional distributions. In this paper, in the case when $\rho=+\infty$, we characterize the self-similar families of laws ( $\mathbb{P}_{x}$ ) which converges weakly as $x$ tends to 0 , on the Skorohod space of càdlàg functions. We also describe their limit law $\mathbb{P}_{0}$ by constructing the paths of a self-similar Markov process whose law is $\mathbb{P}_{0}$.

A crucial point in our arguments is the famous Lamperti representation of selfsimilar $\mathbb{R}_{+}-$valued processes. This transformation enables us to construct the paths of any such self-similar process $X$ from those of a Lévy process. More precisely, Lamperti [11] found the representation

X_{t}=x \exp \xi_{\tau\left(t x^{-\alpha}\right)}, \quad t \geq 0 \tag{1.2}
\end{equation*}
$$

under $\mathbb{P}_{x}$, for $x>0$, where

$$
\tau_{t}=\inf \left\{s: A_{s}>t\right\}, \quad A_{s}=\int_{0}^{s} \exp \alpha \xi_{u} d u
$$

and where $\xi$ is either a real Lévy process such that $\lim _{t} \xi_{t}=-\infty$, if $\rho<+\infty$ and $X_{\rho-}=0$, or $\xi$ is a Lévy process killed at an independent exponential time if $\rho<+\infty$ and $X_{\rho-}>0$, or $\xi$ is a Lévy process such that $\limsup _{t} \xi_{t}=+\infty$, if $\rho=+\infty$. Note that for $t<A_{\infty}$, we have the equality $\tau_{t}=\int_{0}^{t} \frac{d s}{X_{s}^{\alpha}}$, so that (1.2) is invertible and yields a one to one relation between the class of pssMp and the one of Lévy processes.

The conditions of weak convergence of the family $\left(\mathbb{P}_{x}\right)$ and the construction of the limit process which are presented hereafter will naturally bear on the features of the underlying Lévy process in the Lamperti transformation. The rest of the paper is
organized in three sections. In Section 2, the main results are stated and discussed. The proofs are given in Section 3 and some examples are presented in Section 4.

## 2 Main results

### 2.1 Preliminaries on overshoots

On the Skorohod space $\mathcal{D}$ of càdlàg trajectories we consider a reference probability measure $P$ under which $\xi$ will always denote a real Lévy process such that $\xi_{0}=0$. We now give some preliminaries on overshoots of Lévy processes, that is $\left(\xi_{T_{z}}-z, z \geq 0\right)$ with $T_{z}=\inf \left\{t: \xi_{t} \geq z\right\}$. The condition of weak convergence of the overshoot process $\left(\xi_{T_{z}}-z, z \geq 0\right)$ when $z$ tends to $+\infty$ will appear naturally in our main results (Theorems 1 and 2 ) to be necessary for the probability measures $\left(\mathbb{P}_{x}\right)$ to converge weakly as $x \rightarrow 0$. The asymptotic behaviour of the overshoot process of Lévy processes has strongly been studied by Doney and Maller [10]; let us briefly recall one of their main results. Let $\Pi$ be the Lévy measure of $\xi$, that is the measure satisfying $\int_{(-\infty, \infty)}\left(x^{2} \wedge 1\right) \Pi(d x)<\infty$ and such that the characteristic exponent $\Psi$ (defined by $\left.E\left(e^{i u \xi_{t}}\right)=e^{-t \Psi(u)}, t \geq 0\right)$ is given, for some $\sigma \geq 0$ and $a \in \mathbb{R}$, by

\Psi(u)=i a u+\frac{1}{2} \sigma^{2} u^{2}+\int_{(-\infty, \infty)}\left(1-e^{i u x}+i u x \mathbb{I}_{\{|x| \leq 1\}}\right) \Pi(d x), \quad u \in \mathbb{R} .
$$

Define for $x \geq 0$,

$$
\bar{\Pi}^{+}(x)=\Pi((x, \infty)), \quad \bar{\Pi}^{-}(x)=\Pi((-\infty,-x)) \text { and } J=\int_{[1, \infty)} \frac{x \bar{\Pi}^{+}(x) d x}{1+\int_{0}^{x} d y \int_{y}^{\infty} \bar{\Pi}^{-}(z) d z} .
$$

Then according to Doney and Maller [10], a necessary and sufficient condition for the overshoot $\xi_{T_{z}}-z$ to converge weakly towards the law of a finite r.v. as $z$ goes to $+\infty$ is
(H) $\quad \xi$ is not arithmetic and $\left\{\begin{array}{l}\text { either } 0<E\left(\xi_{1}\right) \leq E\left(\left|\xi_{1}\right|\right)<\infty, \\ \text { or } E\left(\left|\xi_{1}\right|\right)<\infty, E\left(\xi_{1}\right)=0 \text { and } J<\infty .\end{array}\right.$
(Actually, the case where $\xi$ has no negative jumps and the case where $\xi$ is arithmetic are not considered in [10]. This makes our expression of the integral $J$ slightly different from the one which is given in [10]). Note also that the discrete time case has been treated in [8].

As noted in [10], the above condition may also be expressed in terms of the upward ladder height process, say $\sigma$, associated with $\xi$. (We refer to [1], Chap. VII for a definition of the ladder process.) Indeed, we easily see that for each level $x$, the overshoots of the processes $\xi$ and $\sigma$ across $x$ are the same, hence $(H)$ can be stated as: $\sigma$ is not arithmetic and $E\left(\sigma_{1}\right)<\infty$. Let us also mention that the latter result is proved for any subordinator in [3] where the authors also give the explicit law of the limit of the overshoots. In the rest of this paper, under hypothesis $(H), \theta$ will denote a r.v. whose law is the weak limit of the overshoots of $\xi$, that is:

\begin{equation*}
\xi_{T_{z}}-z \xrightarrow[z \rightarrow \infty]{(\mathrm{w})} \theta . \tag{2.3}
\end{equation*}
$$

Then from [3], the law of $\theta$ is given by

$$
\begin{equation*}
P(\theta>t)=E\left(\sigma_{1}\right)^{-1} \int_{(t, \infty)} s \nu(d s), \quad z \geq 0 \tag{2.4}
\end{equation*}
$$

where $\nu$ is the Lévy measure of the subordinator $\sigma$.
An important point in the construction of a weak limit for $\left(\mathbb{P}_{x}\right)$ is the following stationarity property of the overshoot process when it starts from an independent random variable distributed as $-\theta$.

Proposition 1 If the overshoot process $\left(\xi_{T_{z}}-z, z \geq 0\right)$ converges weakly at infinity towards the law of an a.s. finite r.v. $\theta$, then the multidimensional overshoot converges weakly. More precisely, for every increasing sequence of nonnegative reals $0 \leq z_{1} \leq$ $\ldots \leq z_{k}$ :

\begin{gathered}
\left(\xi_{T_{z+z_{1}}}-\left(z+z_{1}\right), \ldots, \xi_{T_{z+z_{k}}}-\left(z+z_{k}\right)\right) \\
\xrightarrow[z \rightarrow \infty]{(\mathrm{w})} \\
\left(\xi_{T_{z_{1}-\theta}}-\left(z_{1}-\theta\right), \ldots, \xi_{T_{z_{k}-\theta}}-\left(z_{k}-\theta\right)\right),
\end{gathered}
$$

where $\theta$ is independent of $\xi$. In particular $\left(\xi_{T_{z-\theta}}-(z-\theta), z \geq 0\right)$ is a strictly stationary Markov process, i.e. for any nonnegative real $r$, $\left(\xi_{T_{z+r-\theta}}-(z+r-\theta), z \geq 0\right) \stackrel{(d)}{=}$ $\left(\xi_{T_{z-\theta}}-(z-\theta), z \geq 0\right)$.

Conversely, if there exists an a.s. finite r.v. $\theta$, independent of $\xi$ such that $\left(\xi_{T_{z-\theta}}-\right.$ $(z-\theta), z \geq 0)$ is strictly stationary, then the overshoot process $\left(\xi_{T_{z}}-z, z \geq 0\right)$ converges weakly at infinity towards the law of $\theta$.

Our construction of a process whose law is the limit as $x$ tends to 0 of $X$ under $\mathbb{P}_{x}$ bears on the following definition of a r.v. with values in $\left(\mathcal{D} \times \mathbb{R}_{+}\right)^{\mathbb{N}}$.

Proposition 2 Let $x_{1} \geq x_{2} \geq \ldots>0$ be an infinite decreasing sequence of positive real numbers which converges towards 0 . Under condition $(H)$, there exists a random sequence $\left(\theta_{n}, \xi^{(n)}\right)$ of $\left(\mathbb{R}_{+} \times \mathcal{D}\right)^{\mathbb{N}}$ such that for each $n$, $\theta_{n}$ and $\xi^{(n)}$ are independent, $\theta_{n} \stackrel{(d)}{=} \theta, \xi^{(n)} \stackrel{(d)}{=} \xi$, and for any $i, j$ such that $1 \leq i \leq j$ :

$$
\begin{align*}
& \xi^{(i)} \stackrel{(a . s .)}{=}  \tag{2.5}\\
& \theta_{i}\left.\stackrel{(a . s .)}{=} \xi^{(j)}\left(T_{\log \left(x_{i} e^{-\theta_{j}} / x_{j}\right)}^{(j)}+t\right)-\xi^{(j)}\left(T_{\log \left(x_{i} e^{\left.-\theta_{j} / x_{j}\right)}\right.}^{(j)}\right), t \geq 0\right),  \tag{2.6}\\
& \log \left(x_{i} e^{\left.-\theta_{j} / x_{j}\right)}\right)-\log \left(x_{i} e^{-\theta_{j}} / x_{j}\right) .
\end{align*}
$$

where $T_{z}^{(j)}=\inf \left\{t: \xi_{t}^{(j)} \geq z\right\}, z \in \mathbb{R}$. The above statement determines the law of the sequence $\left(\xi^{(n)}, \theta_{n}\right)$. Furthermore, for any $n, \xi^{(n)}$ is independent of $\left(\theta_{k}\right)_{k \geq n}$ and $\left(\theta_{n}\right)$ is a Markov chain.

A particularity of the above definition is the 'backward' inductive construction of the law of $\left(\theta_{n}, \xi^{(n)}\right)$. More specifically, we see from (2.5) and (2.6) that for any $n$, the couples $\left(\theta_{n-1}, \xi^{(n-1)}\right),\left(\theta_{n-2}, \xi^{(n-2)}\right), \ldots\left(\theta_{1}, \xi^{(1)}\right)$ are functionals of $\left(\theta_{n}, \xi^{(n)}\right)$.

As will be seen in the next subsection, for each $n,\left(\theta_{n}, \xi^{(n)}\right)$ is used to construct our limit process between its first passage time above $x_{n}$ and its first passage time above $x_{n-1}$. Then the result of Proposition 2 will allow us to describe the joint law of the values of this process at its first passage times above $x_{n}, n \geq 1$.

We emphasize that if $\xi$ has no positive jumps, then $\theta_{i}=0$ a.s. and the results of this paper, as well as their proofs are much simpler. In any other case, it may happen that the event

$$
\left\{T_{\log \left(x_{i} e^{-\theta_{j} / x_{j}}\right)}^{(j)}=0\right\}=\left\{\log \left(x_{i} e^{-\theta_{j}} / x_{j}\right) \leq 0\right\}
$$

has positive probability. On this event, we have $x_{i} e^{\theta_{i}}=x_{j} e^{\theta_{j}}$, and $\xi^{(i)}=\xi^{(j)}$.

### 2.2 The process issued from 0

We recall that $P$ is our reference probability measure and we denote by $X$ the canonical process on $\mathcal{D}$.

Consider any self-similar Markov process $\left(X, \mathbb{P}_{x}\right), x>0$ as defined in (1.2), with $\rho=\inf \left\{t: X_{t}=0\right\}=+\infty, \mathbb{P}_{x}$-a.s. As we recalled in the introduction, there exists a unique Lévy process $\xi$ with $\lim \sup _{t \rightarrow+\infty} \xi_{t}=+\infty$, a.s. and such that the representation (1.2) holds. Observe that since the time change $t \mapsto \tau\left(t x^{-\alpha}\right)$ is continuous with $\lim _{t \rightarrow+\infty} \tau\left(t x^{-\alpha}\right)=+\infty$, a.s., and since $x \mapsto e^{x}$ is increasing, then $\mathbb{P}_{x^{-}}$-a.s., $\lim \sup _{t \rightarrow+\infty} X_{t}=+\infty$.

Note that from (1.1), the process $\left(X^{\alpha}, \mathbb{P}_{x}\right), x>0$ is a pssMp whose scaling coefficient is equal to 1 . Moreover, the power function is a continuous functional of the càdlàd trajectories, hence we do not loose any generality in our convergence type results by assuming that $\alpha=1$.

In the next theorems, we give the construction of a Markov process $X^{(0)}$ which starts from 0 continuously, stays positive and fulfills the scaling property with index $\alpha=1$. We shall then see that the law of the process $X^{(0)}$ is the weak limit on $\mathcal{D}$ of $X$, as $x$ tends to 0 .

From the sequence $\left(\theta_{n}, \xi^{(n)}\right)$ defined in Proposition 2, we first introduce the sequence of processes

\begin{equation*}
X_{t}^{\left(\bar{x}_{n}\right)}=\bar{x}_{n} \exp \xi_{\tau^{(n)}\left(t / \bar{x}_{n}\right)}^{(n)} \quad t \geq 0, \quad n \geq 1 \tag{2.7}
\end{equation*}
$$

where $\bar{x}_{n}=x_{n} e^{\theta_{n}}$ and with the natural definition $\tau_{t}^{(n)} \stackrel{\text { def }}{=} \inf \left\{s: \int_{0}^{s} \exp \xi_{u}^{(n)} d u>t\right\}$. Let also

$$
\begin{equation*}
S^{(n-1)}=\inf \left\{t \geq 0: X_{t}^{\left(\bar{x}_{n}\right)} \geq x_{n-1}\right\}, \quad n \geq 2, \tag{2.8}
\end{equation*}
$$

which is a.s. finite from our assumptions. Under a condition which ensures that $\Sigma_{n}=\Sigma_{k=n}^{+\infty} S^{(k)}<+\infty$, a.s. we define the process $X^{(0)}$ on the positive halfline as the concatenation of the processes $\left(X_{t-\Sigma_{n}}^{\left(\overline{\bar{x}}_{n}\right)}, \Sigma_{n} \leq t \leq \Sigma_{n-1}\right), n \geq 2$, and $\left(X_{t-\Sigma_{1}}^{\left(\bar{x}_{1}\right)}, t \geq \Sigma_{1}\right)$.

Theorem 1 Assume that $(H)$ holds and that $E\left(\log ^{+} \int_{0}^{T_{1}} \exp \xi_{s} d s\right)<\infty$. Let $\Sigma_{n}=$ $\sum_{k=n}^{\infty} S^{(k)}$, then for any $n, 0<\Sigma_{n}<\infty$, a.s., so that the following construction

$$
X_{t}^{(0)}=\left\{\begin{array}{ll}
X_{t-\Sigma_{1}}^{\left(\bar{x}_{1}\right)}, & t \in\left[\Sigma_{1}, \infty\right)  \tag{2.9}\\
X_{t-\Sigma_{2}}^{\left(\bar{x}_{2}\right)}, & t \in\left[\Sigma_{2}, \Sigma_{1}\right) \\
\vdots & \\
X_{t-\Sigma_{n}}^{\left(\bar{x}_{n}\right)}, & t \in\left[\Sigma_{n}, \Sigma_{n-1}\right) \\
\vdots &
\end{array} \quad, \quad X_{0}^{(0)}=0\right.
$$

makes sense and it defines a càdlàg stochastic process on the real halfine $[0, \infty)$ with the following properties:
(i) The law of $X^{(0)}$ does not depend on the sequence $\left(x_{n}\right)$.
(ii) The paths of the process $X^{(0)}$ are such that $\lim \sup _{t} X_{t}^{(0)}=+\infty$, a.s. and $X_{t}^{(0)}>$ 0 , a.s. for any $t>0$.
(iii) The process $X^{(0)}$ satisfies the scaling property, that is for any $k>0$,

$$
\begin{equation*}
\left(k X_{k^{-1} t}^{(0)}, t \geq 0\right) \text { has the same law as } X^{(0)} . \tag{2.10}
\end{equation*}
$$

(iv) The process $X^{(0)}$ is strong Markov and has the same semi-group as $\left(X, \mathbb{P}_{x}\right)$ for $x>0$.

We will denote by $\mathbb{P}_{0}$ the law of this process.
Note that $\Sigma_{n}$ is the first passage time above $x_{n}$ by the process $X^{(0)}$, i.e.

$$
\Sigma_{n}=\inf \left\{t: X_{t}^{(0)} \geq x_{n}\right\}
$$

and that the r.v. $\bar{x}_{n}=x_{n} e^{\theta_{n}}$ represents the value of this process at its first passage time above the level $x_{n}$. In particular, when $\xi$ has no positive jumps, the above construction of $X^{(0)}$ says that $\left(X_{\Sigma_{n}+t}^{(0)}, t \geq 0\right)$ has law $\mathbb{P}_{x_{n}}$.

For the description of the law $\mathbb{P}_{0}$ of the process $X^{(0)}$ to be complete it is worth to describe its entrance law. As we will see in Theorem $2, \mathbb{P}_{0}$ is the weak limit of $\left(\mathbb{P}_{x}\right)$ as $x$ tends to 0 . So, in the case where $0<E\left(\xi_{1}\right) \leq E\left(\left|\xi_{1}\right|\right)<\infty$, (i.e. $\xi$ has positive drift) the entrance law under $\mathbb{P}_{0}$ has been computed by Bertoin, Caballero [2] and Bertoin, Yor [4] and can be expressed as follows: for every $t>0$ and for every measurable function $f: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$,

$$
\begin{equation*}
\mathbb{E}_{0}\left(f\left(X_{t}\right)\right)=\frac{1}{m} E\left(I^{-1} f\left(t I^{-1}\right)\right), \tag{2.11}
\end{equation*}
$$

where $m=E\left(\xi_{1}\right)$ and $I=\int_{0}^{\infty} \exp \left(-\xi_{s}\right) d s$. When $E\left(\xi_{1}\right)=0$, we have no explicit computation for the entrance law of $X^{(0)}$. However, in the following result, we see that it can be obtained as the weak limit of the entrance law for the positive drift case, when the drift tends towards 0 .

Proposition 3 Under conditions of Theorem 1, suppose that $E\left(\xi_{1}\right)>0$, then the entrance law under $\mathbb{P}_{0}$ is given by (2.11). Suppose that $E\left(\xi_{1}\right)=0$, then for any bounded and continuous function $f$,

$$
\begin{equation*}
\mathbb{E}_{0}\left(f\left(X_{t}\right)\right)=\lim _{\lambda \rightarrow 0} \frac{1}{\lambda} E\left(I_{\lambda}^{-1} f\left(t I_{\lambda}^{-1}\right)\right), \tag{2.12}
\end{equation*}
$$

where $I_{\lambda}=\int_{0}^{\infty} \exp \left(-\xi_{s}-\lambda s\right) d s$.
The next theorem gives necessary and sufficient conditions bearing upon $\xi$, for a family of $\mathrm{pssMp}\left(X, \mathbb{P}_{x}\right)$ described by (1.2) to converge weakly in the Skorohod space $\mathcal{D}$ of càdlàg trajectories, as $x$ goes towards 0 . Recall that the first passage time process of $\xi$ is defined by $T_{z}=\inf \left\{t: \xi_{t} \geq z\right\}, \quad z \in \mathbb{R}$. In the sequel, by degenerate probability measure on $\mathcal{D}$, we mean the law of a constant process which is finite or infinite.

Theorem 2 Let $\left(X, \mathbb{P}_{x}\right), x>0$ be defined as in (1.2) and such that $\rho=+\infty$ (or equivalently $\left.\lim \sup _{t} \xi_{t}=+\infty\right)$. The family of probability measures $\left(\mathbb{P}_{x}\right)$ converges weakly in $\mathcal{D}$, as $x \rightarrow 0$, towards a non degenerate probability measure if and only if the overshoot process $\left(\xi_{T_{z}}-z, z \geq 0\right)$ converges weakly towards the law of a finite r.v. as $z \rightarrow+\infty$ (that is $(H)$ holds $)$ and $E\left(\log ^{+} \int_{0}^{T_{1}} \exp \xi_{s} d s\right)<+\infty$. Under these conditions, the limit law of $\left(\mathbb{P}_{x}\right)$ is $\mathbb{P}_{0}$.

A consequence of Theorem 2 is that under these conditions, the semigroup $P_{t} f(x) \stackrel{\text { (def) }}{=}$ $\mathbb{E}_{x}\left(f\left(X_{t}\right)\right)$ is Fellerian on the space $\mathcal{C}_{0}\left(\mathbb{R}_{+}\right)$of continuous functions $f: \mathbb{R}_{+} \rightarrow \mathbb{R}$ with $\lim _{x \rightarrow+\infty} f(x)=0$. It will appear along the proofs in the next section that when (H) holds but $E\left(\log ^{+} \int_{0}^{T_{1}} \exp \xi_{s} d s\right)=\infty$, the process $\left(X, \mathbb{P}_{x}\right)$ actually converges weakly towards the process which is identically nought. See the remark at the end of section 3.

Before we prove the above results, let us discuss about the condition

$$
\begin{equation*}
E\left(\log ^{+} \int_{0}^{T_{1}} \exp \xi_{s} d s\right)<\infty \tag{2.13}
\end{equation*}
$$

which is involved in Theorems 1 and 2. This condition is rather weak in the sense that it is satisfied by a very large class of Lévy processes. First of all, if $0<E\left(\xi_{1}\right) \leq$ $E\left(\left|\xi_{1}\right|\right)<\infty$ then it is well known that $E\left(T_{1}\right)<\infty$ and hence condition (2.13) is satisfied.

Condition (2.13) also holds when $\xi$ satisfies the Spitzer condition, i.e.

$$
\frac{1}{t} \int_{0}^{t} \mathbb{I}_{\left\{\xi_{s} \geq 0\right\}} d s \rightarrow \rho \in(0,1) .
$$

Indeed, in that case it is known, see [1], Theorem VI.18, that $E\left(T_{1}^{\gamma}\right)<+\infty$, for $0<\gamma<\rho$. Hence $\int_{0}^{T_{1}} \exp \xi_{s} d s\left(\leq e T_{1}\right)$ has a finite logarithmic moment.

Another instance when this condition is satisfied is when $\xi$ has an exponential moment, i.e. $E\left(\exp \xi_{1}\right)<\infty$. Under this condition, there exists $\alpha>0$ such that the process $\exp \left(\xi_{t \wedge T_{1}}-\alpha\left(t \wedge T_{1}\right)\right)$ is a martingale and we have $E\left(\exp \left(\xi_{T_{1}}-\alpha T_{1}\right)\right)=1$.
(These conditions are satisfied for example whenever $\xi$ has no positive jumps). Then we can write

$$
E\left(\mathbb{I}_{\left\{t<T_{1}\right\}} \exp \xi_{t}\right)=E\left(\mathbb{I}_{\left\{t<T_{1}\right\}} \exp \left[\xi_{T_{1}}-\alpha\left(T_{1}-t\right)\right]\right)
$$

so that, integrating with respect to $t$, we obtain the stronger condition:

$$
\begin{equation*}
E\left(\int_{0}^{T_{1}} \exp \xi_{t} d t\right)=\frac{1}{\alpha}\left(E\left(\exp \xi_{T_{1}}\right)-1\right)<\infty \tag{2.14}
\end{equation*}
$$

Finally, note that condition (2.13) is equivalent to each of the following:

$$
\begin{align*}
& E\left(\log ^{+} \int_{0}^{T_{x}} \exp \xi_{s} d s\right)<\infty, \text { for any } x>0  \tag{2.15}\\
& E\left(\log ^{+} \int_{0}^{T_{1}} \exp \lambda \xi_{s} d s\right)<\infty, \text { for any } \lambda>0 \tag{2.16}
\end{align*}
$$

The equivalence between (2.13) and (2.15) will appear in the proof of Lemma 2, (iii). On the other hand, note that the family $\left(X^{\lambda}, \mathbb{P}_{x}\right)$ converges weakly as $x$ tends to 0 if and only if the family $\left(X, \mathbb{P}_{x}\right)$ converges weakly as $x$ tends to 0 . But the process $\left(X^{\lambda}, \mathbb{P}_{x}\right)$ admits the decomposition (1.2) with respect to $x^{\lambda}$ and the Lévy process $\lambda \xi$. Hence from Theorem 2, (2.13) is equivalent to $E\left(\log ^{+} \int_{0}^{T_{1 / \lambda}} \exp \lambda \xi_{s} d s\right)<\infty$, which is also equivalent to (2.16).

In particular, following the same arguments as in the proof of (2.14), we see that whenever there exists $\lambda>0$ such that $E\left(\exp \lambda \xi_{1}\right)<+\infty$, condition (2.13) is satisfied.

## 3 Proofs.

Proof of Proposition 1. Put $\theta^{(z)}=\xi_{T_{z}}-z$ and $\bar{\xi}=\left(\xi_{T_{z}+t}-\xi_{T_{z}}, t \geq 0\right)$ and note the path by path identity:

$$
\begin{aligned}
& \left(\xi_{T_{z+z_{1}}}-\left(z+z_{1}\right), \ldots, \xi_{T_{z+z_{n}}}-\left(z+z_{n}\right)\right)= \\
& \left(\bar{\xi}\left(T_{z_{1}-\theta^{(z)}}\right)-\left(z_{1}-\theta^{(z)}\right), \ldots, \bar{\xi}\left(T_{z_{n}-\theta^{(z)}}\right)-\left(z_{n}-\theta^{(z)}\right)\right) .
\end{aligned}
$$

As mentioned above, under hypothesis $(H), \theta^{(z)}$ converges weakly towards $\theta$. Moreover, the process $\bar{\xi}$ is distributed as $\xi$, so the weak convergence follows from the independence between $\bar{\xi}$ and $\theta^{(z)}$. The process $\left(\xi_{T_{z-\theta}}-(z-\theta), z \geq 0\right)$ is obviously càdlàg and its Markov property follows from general properties of Lévy processes and from the independence between $\theta$ and $\xi$.

Now suppose that there exists an a.s. finite r.v. $\theta$ which is independent of $\xi$ and such that the process $\left(\xi_{T_{z-\theta}}-(z-\theta), z \geq 0\right)$ is strictly stationary. Let $\sigma$ be the upward ladder height process associated to $\xi$, then as we already observed in section 2.1, the overshoot of $\sigma$ and the overshoot of $\xi$ at any level $z$ are equal. Define the first passage process $\nu_{z}=\inf \left\{t: \sigma_{t} \geq z\right\}$, then $\left(\sigma_{\nu_{z-\theta}}-(z-\theta), z \geq 0\right)$ is strictly stationary. But it is shown in [10], at the end of the proof of Lemma 7, that if $E\left(\sigma_{1}\right)=+\infty$ then $\sigma_{\nu_{z}}-z$ tends to $+\infty$ in probability as $z$ goes to $+\infty$. This is in contradiction with the
stationarity of $\left(\sigma_{\nu_{z-\theta}}-(z-\theta), z \geq 0\right)$, hence $E\left(\sigma_{1}\right)<+\infty$, which is equivalent to $(H)$ as mentioned in Section 2.1.

We emphasize that the stationary property of the process $\left(\xi_{T_{z-\theta}}-(z-\theta), z \geq 0\right)$ is a crucial point in the proofs of our results, so we will often make use of Proposition 1 in the sequel.

Proof of Proposition 2. Let $x_{1} \geq x_{2} \geq \ldots>0$ be an infinite decreasing sequence of positive real numbers which converges towards 0 and for fixed $k \geq 2$, consider $\theta_{k}$ and $\xi^{(k)}$ be independent and respectively distributed as $\theta$ and $\xi$. Then we construct the sequence $\left(\theta_{k-1}, \xi^{(k-1)}\right), \ldots,\left(\theta_{1}, \xi^{(1)}\right)$ as follows: for $j=k, k-1, \ldots, 2$,

$$
\begin{align*}
T_{z}^{(j)} & \stackrel{(\text { def })}{=} \inf \left\{t: \xi_{t}^{(j)} \geq z\right\}  \tag{3.17}\\
\xi^{(j-1)} & \stackrel{\text { (def) }}{=}\left(\xi^{(j)}\left(T_{\log \left(x_{j-1} e^{\left.-\theta_{j} / x_{j}\right)}\right.}^{(j)}+t\right)-\xi^{(j)}\left(T_{\log \left(x_{j-1} e^{\left.-\theta_{j} / x_{j}\right)}\right.}^{(j)}\right), t \geq 0\right),  \tag{3.18}\\
\theta_{j-1} & \stackrel{(\text { def })}{=} \xi^{(j)}\left(T_{\log \left(x_{j-1} e^{-\theta_{j}} / x_{j}\right)}^{(j)}\right)-\log \left(x_{j-1} e^{-\theta_{j}} / x_{j}\right) \tag{3.19}
\end{align*}
$$

So, this defines the law of $\left(\left(\theta_{1}, \xi^{(1)}\right), \ldots,\left(\theta_{k}, \xi^{(k)}\right)\right)$ on $\left(\mathbb{R}_{+} \times \mathcal{D}\right)^{k}$. We can check by induction and from (3.18), (3.19) and Proposition 1 that for any $j=1, \ldots, k, \theta_{j}$ and $\xi^{(j)}$ are independent and respectively distributed as $\theta$ and $\xi$.

Now let $k^{\prime}>k$ and $\bar{\theta}_{k^{\prime}}$ and $\bar{\xi}^{\left(k^{\prime}\right)}$ be independent and respectively distributed as $\theta$ and $\xi$. Then let us construct the sequence $\left(\left(\bar{\theta}_{1}, \bar{\xi}^{(1)}\right), \ldots,\left(\bar{\theta}_{k^{\prime}}, \bar{\xi}^{\left(k^{\prime}\right)}\right)\right)$ on $\left(\mathbb{R}_{+} \times \mathcal{D}\right)^{k^{\prime}}$ as above. Since $\bar{\theta}_{k}$ and $\bar{\xi}^{(k)}$ are independent and since $\left(\bar{\theta}_{k-1}, \bar{\xi}^{(k-1)}\right), \ldots,\left(\bar{\theta}_{1}, \bar{\xi}^{(1)}\right)$ are constructed from $\left(\bar{\theta}_{k}, \bar{\xi}^{(k)}\right)$ through the same way as the sequence $\left(\theta_{k-1}, \xi^{(k-1)}\right), \ldots,\left(\theta_{1}, \xi^{(1)}\right)$ is constructed from $\left(\theta_{k}, \xi^{(k)}\right)$, both sequences

$$
\left(\left(\bar{\theta}_{1}, \bar{\xi}^{(1)}\right), \ldots,\left(\bar{\theta}_{k}, \bar{\xi}^{(k)}\right)\right) \quad \text { and } \quad\left(\left(\theta_{1}, \xi^{(1)}\right), \ldots,\left(\theta_{k}, \xi^{(k)}\right)\right)
$$

have the same law. For any $k \geq 1$, call $\mu^{(k)}$ the law of $\left(\left(\theta_{1}, \xi^{(1)}\right), \ldots,\left(\theta_{k}, \xi^{(k)}\right)\right)$ on the space $\left(\mathbb{R}_{+} \times \mathcal{D}\right)^{k}$. Then we proved that $\left(\mu^{(k)}\right)$ is a projective family, that is, for any $k<k^{\prime}$, the projection of the law $\mu^{\left(k^{\prime}\right)}$ on $\left(\mathbb{R}_{+} \times \mathcal{D}\right)^{k}$ corresponds to $\mu^{(k)}$. From Kolmogorov's Theorem, there exists a unique probability law, say $\mu$, on $\left(\mathbb{R}_{+} \times \mathcal{D}\right)^{\mathbb{N}}$ such that for each $k, \mu^{(k)}$ is the projection of $\mu$ on $\left(\mathbb{R}_{+} \times \mathcal{D}\right)^{k}$. This defines the law of the sequence $\left(\theta_{n}, \xi^{(n)}\right)$.

The relations (2.5) and (2.6) for $i=j$ are obvious, and for $i=j-1$, they correspond to (3.18) and (3.19). The case $i<j-1$ is easily obtained by induction. Let us check it for $i=j-2$. From (3.18),

$$
\begin{aligned}
\xi^{(j-2)}= & \left(\xi^{(j)}\left(T_{\log \left(x_{j-1} e^{-\theta_{j}} / x_{j}\right)}^{(j)}+T_{\log \left(x_{j-2} e^{\left.-\theta_{j-1} / x_{j-1}\right)}\right.}^{(j-1)}+t\right)-\right. \\
& \left.\xi^{(j)}\left(T_{\log \left(x_{j-1} e^{-\theta_{j}} / x_{j}\right)}^{(j)}+T_{\log \left(x_{j-2} e^{\left.-\theta_{j-1} / x_{j-1}\right)}\right.}^{(j-1)}\right), t \geq 0\right),
\end{aligned}
$$

and it is easy to see that

$$
T_{\log \left(x_{j-1} e^{-\theta_{j}} / x_{j}\right)}^{(j)}+T_{\log \left(x_{j-2} e^{\left.-\theta_{j-1} / x_{j-1}\right)}\right.}^{(j-1)}=T_{\log \left(x_{j-2} e^{-\theta_{j}} / x_{j}\right)}^{(j)}
$$

This gives (2.5), for $i=j-2$ and Identity (2.6) follows.
Let $m \geq n \geq 1$. Since $\xi^{(m)}$ is independent of $\theta_{m}$, from (2.5) for $i=n$ and $j=m$, the process $\xi^{(n)}$ is independent of $\left\{\theta_{m},\left(\xi_{t}^{(m)}, t \leq T_{\log \left(x_{n} e^{\left.-\theta_{m} / x_{m}\right)}\right.}^{(m)}\right)\right\}$. But from (2.6) for $i=m-1, m-2, \ldots, n$ and $j=m$, the variables $\theta_{m-1}, \ldots, \theta_{n}$ are functionals of $\left\{\theta_{m},\left(\xi_{t}^{(m)}, t \leq T_{\log \left(x_{n} e^{\left.-\theta_{m} / x_{m}\right)}\right.}^{(m)}\right)\right\}$. We deduce that $\xi^{(n)}$ is independent of $\left(\theta_{k}\right)_{k \geq n}$.

Finally, it directly follows from (2.6) that for any $n$ and $m$ such that $n<m$,

$$
\begin{gather*}
\left(\theta_{m}, \ldots, \theta_{n}, \theta_{n-1}, \ldots, \theta_{1}\right) \stackrel{(\text { a.s. })}{=}  \tag{3.20}\\
\left.\left(\theta_{m}, \ldots, \theta_{n}, \xi_{T^{(n)}\left(\log \frac{x_{n-1}}{x_{n}}-\theta_{n}\right)}^{(n)}-\left(\log \frac{x_{n-1}}{x_{n}}-\theta_{n}\right)\right), \ldots, \xi_{T^{(n)}\left(\log \frac{x_{1}}{x_{n}}-\theta_{n}\right)}^{(n)}-\left(\log \frac{x_{1}}{x_{n}}-\theta_{n}\right)\right) .
\end{gather*}
$$

This shows that $\left(\theta_{n}\right)$ is a Markov chain, since in the right hand side of $(3.20), \xi^{(n)}$ is independent of $\left(\theta_{m}, \theta_{m-1} \ldots, \theta_{n}\right)$.

We shall see later that the tail sigma field $\mathcal{G}=\cap_{n} \sigma\left\{\theta_{n}, \theta_{n+1}, \ldots\right\}$ is trivial. Although, there should be more direct arguments, our proof bears on the construction of $X^{(0)}$, see Lemma 3. Note also that the Markov chain $\left(\theta_{n}\right)$ is homogeneous if and only if $x_{n-1} / x_{n}$ is constant, and in this case, it is stationary.

Let $\xi$ and the canonical process $X$ be related by (1.2) and define the first passage time process of $X$ by:

$$
S_{y}=\inf \left\{t: X_{t} \geq y\right\}, \quad y \geq 0 .
$$

Observe that from our assumptions (see the beginning of Section 2.2), for any level $y \geq x, \mathbb{P}_{x}\left(S_{y}<\infty\right)=1$.

Lemma 1 Let $x \leq y$ and set $z=\log (y / x)$. Then under $\mathbb{P}_{x}$, the process $\left(X_{S_{y}+t}, t \geq 0\right)$ admits the following (path by path) representation

$$
\begin{equation*}
\left(X\left(S_{y}+t\right), t \geq 0\right)=\left(y e^{\theta^{(z)}} \exp \bar{\xi}\left(\bar{\tau}\left(t e^{-\theta^{(z)}} / y\right)\right), t \geq 0\right) \tag{3.21}
\end{equation*}
$$

where $\bar{\xi} \stackrel{\text { (def }}{=}\left(\xi_{T_{z}+t}-\xi_{T_{z}}, t \geq 0\right)$ has the same law as $\xi$ and is independent of $\theta(z) \stackrel{\text { def) }}{=}$ $\xi_{T_{z}}-z$ and $\bar{\tau}_{t}=\inf \left\{s: \int_{0}^{s} \exp \bar{\xi}_{u} d u>t\right\}$.

In particular, when $\xi$ has no positive jumps, the overshoot $\theta^{(z)}$ is zero and $\left(X_{S_{y}+t}, t \geq\right.$ 0) has law $\mathbb{P}_{y}$.

Proof. First observe that $S_{y}=x A_{T_{z}}$ and $X_{S_{y}}=x \exp \xi_{T_{z}}$, where $z=\log (y / x)$ and $T_{z}=\inf \left\{t: \xi_{t} \geq z\right\}$. Now, from (1.2), we have

$$
\left(X\left(S_{y}+t\right), t \geq 0\right)=\left(x \exp \xi_{\tau\left(A_{T_{z}}+t / x\right)}, t \geq 0\right)
$$

Then we can rewrite the time change as follows:

$$
\begin{aligned}
\tau\left(A_{T_{z}}+t / x\right) & =\inf \left\{s \geq 0: A_{s} \geq A_{T_{z}}+t / x\right\} \\
& =\inf \left\{s \geq T_{z}: \int_{T_{z}}^{s} \exp \left(\xi_{u}-\xi_{T_{z}}\right) d u \geq(t / x) \exp \left(-\xi_{T_{z}}\right)\right\} \\
& =T_{z}+\bar{\tau}\left(t / X_{S_{y}}\right),
\end{aligned}
$$

where $\bar{\tau}$ is the right continuous inverse of the exponential functional $\int_{0}^{t} \exp \left(\bar{\xi}_{s}\right) d s$, i.e. $\bar{\tau}_{t}=\inf \left\{s: \int_{0}^{s} \exp \left(\bar{\xi}_{u}\right) d u>t\right\}$, and $\bar{\xi}=\left(\xi_{T_{z}+t}-\xi_{T_{z}}, t \geq 0\right)$. Now we may write

$$
\begin{aligned}
\left(X\left(S_{y}+t\right), t \geq 0\right) & =\left(x \exp \xi_{T_{z}+\bar{\tau}\left(t / X_{S_{y}}\right)}, t \geq 0\right) \\
& =\left(X_{S_{y}} \exp \bar{\xi}_{\bar{\tau}\left(t / X_{S_{y}}\right)}, t \geq 0\right)
\end{aligned}
$$

Finally, it follows from standard properties of Lévy processes that $\bar{\xi}$ has the same law as $\xi$ and is independent of $\xi_{T_{z}}$.

Corollary 1 Let $\left(\theta_{n}, \xi^{(n)}\right), n=1,2, \ldots$ be the sequence which is defined by Proposition 2 and recall the definition (2.7), of the sequence $X^{\left(\bar{x}_{n}\right)}$ :

$$
X_{t}^{\left(\bar{x}_{n}\right)}=\bar{x}_{n} \exp \xi_{\tau^{(n)}\left(t / \bar{x}_{n}\right)}^{(n)}, \quad t \geq 0, \quad n \geq 1
$$

with $\bar{x}_{n}=x_{n} e^{\theta_{n}}$ and $\tau_{t}^{(n)} \stackrel{(\text { def })}{=} \inf \left\{s: \int_{0}^{s} \exp \xi_{u}^{(n)} d u>t\right\}$. Recall also that $S^{(n-1)}=\inf \{t$ : $\left.X_{t}^{\left(\bar{x}_{n}\right)} \geq x_{n-1}\right\}$, then for every $n \geq 1$,

$$
\left(X^{\left(\bar{x}_{n}\right)}\left(S^{(n-1)}+t\right), t \geq 0\right)=X^{\left(\bar{x}_{n-1}\right)}, \quad \text { a.s. }
$$

Proof. Replacing $x$ by $\bar{x}_{n}=x_{n} e^{\theta_{n}}$ and $y$ by $x_{n-1}$ in the (path by path) identity of Lemma 1, we obtain ( $\theta^{(z)}$ being defined in this lemma):

$$
\theta^{(z)}=\xi^{(n)}\left(T_{\log \left(x_{n-1} / \bar{x}_{n}\right)}^{(n)}\right)-\log \left(x_{n-1} / \bar{x}_{n}\right), \quad \text { a.s. }
$$

where $T_{z}^{(n)}=\inf \left\{t: \xi_{t}^{(n)} \geq z\right\}$. The right hand side of this inequality is the r.v. $\theta_{n-1}$ which is defined in (2.6). We can also check that $\bar{\xi}$ defined in Lemma 1 is nothing but $\xi^{(n-1)}$ defined in (2.5) and the conclusion follows.

The next result will be used in the sequel to underline the fact that the construction (2.9) does not depend on the sequence $\left(x_{n}\right)$.

Corollary 2 Let $\left(y_{n}\right)$ be another real decreasing sequence which tends to 0 . For any $j$, let $n$ such that $x_{n} \leq y_{j}$ and let $V_{j}=\inf \left\{t: X_{t}^{\left(\bar{x}_{n}\right)} \geq y_{j}\right\}$, then we may write

$$
\begin{equation*}
\left(X^{\left(\bar{x}_{n}\right)}\left(V_{j}+t\right), t \geq 0\right)=\left(y_{j} e^{\tilde{\theta}_{j}} \exp \tilde{\xi}_{\tilde{\tau}^{(j)}\left(t e^{-\tilde{\theta}_{j}} / y_{j}\right)}^{(j)}, t \geq 0\right) \tag{3.22}
\end{equation*}
$$

where $\tilde{\xi}^{(j)}=\left(\xi^{(n)}\left(T_{\log \left(y_{j} / \bar{x}_{n}\right)}^{(n)}+t\right)-\xi^{(n)}\left(T_{\log \left(y_{j} / \bar{x}_{n}\right)}^{(n)}\right), t \geq 0\right), \tilde{\theta}_{j}=\xi^{(n)}\left(T_{\log \left(y_{j} / \bar{x}_{n}\right)}^{(n)}\right)-$ $\log \left(y_{j} / \bar{x}_{n}\right)$ and $\tilde{\tau}_{t}^{(j)}=\inf \left\{s: \int_{0}^{s} \exp \tilde{\xi}_{u}^{(j)} d u>t\right\}$.

The sequence $\left(\tilde{\theta}_{j}, \tilde{\xi}^{(j)}\right)$, $j \geq 1$ may be defined by the same way as in Proposition 2 with respect to the sequence $\left(y_{n}\right)$. That is $\tilde{\theta}_{j}$ and $\tilde{\xi}^{(j)}$ are independent and respectively distributed as $\theta$ and $\xi$, and for $1 \leq i \leq j$,

$$
\begin{align*}
\tilde{\xi}^{(i)} & =\left(\tilde{\xi}^{(j)}\left(\tilde{T}_{\log \left(y_{i} e^{-\tilde{\theta}_{j}} / y_{j}\right)}+t\right)-\tilde{\xi}^{(j)}\left(\tilde{T}_{\log \left(y_{i} e^{-\tilde{\theta}_{j}} / y_{j}\right)}^{(j)}\right), t \geq 0\right),  \tag{3.23}\\
\tilde{\theta}_{i} & =\left(\tilde{\xi}^{(j)}\left(\tilde{T}_{\log \left(y_{i} e^{-\tilde{\theta}_{j}} / y_{j}\right)}\right)-\log \left(y_{i} e^{-\tilde{\theta}_{j}} / y_{j}\right)\right. \tag{3.24}
\end{align*}
$$

where $\tilde{T}_{z}^{(j)}=\inf \left\{t: \tilde{\xi}_{t}^{(j)} \geq z\right\}$. In particular, the law of $\left(\tilde{\theta}_{j}, \tilde{\xi}^{(j)}\right), j \geq 1$ does not depend on the sequence $\left(x_{n}\right)$.

Proof. The first part with the definitions of $\tilde{\xi}^{(j)}, \tilde{\theta}_{j}$ and $\tilde{\tau}^{(j)}$ is a straightforward consequence of Lemma 1.

Now we prove that the sequence $\left(\tilde{\theta}_{j}, \tilde{\xi}^{(j)}\right)$ may be defined as in Proposition 2. First it is clear from the independence between $\theta_{n}$ and $\xi^{(n)}$ and from the stationarity of the process $\left(\xi_{T_{z-\theta}}-(z-\theta), z \geq 0\right)$ that $\tilde{\xi}^{(j)}$ and $\tilde{\theta}^{(j)}$ are independent and respectively distributed as $\xi$ and $\theta$. It remains to check that $\left(\tilde{\theta}_{j}, \tilde{\xi}^{(j)}\right)$ verifies (3.23) and (3.24). Let $i \leq j$ so that $y_{j} \leq y_{i}$, then from the statement, $\tilde{\xi}^{(j)}$ and $\tilde{\xi}^{(i)}$ are respectively defined by $\tilde{\xi}^{(j)}=\left(\xi_{T^{(n)}\left(\log \left(y_{j} / \bar{x}_{n}\right)\right)+t}^{(n)}-\xi_{T^{(n)}\left(\log \left(y_{j} / \bar{x}_{n}\right)\right)}^{(n)}, t \geq 0\right)$ and $\tilde{\xi}^{(i)}=\left(\xi_{\left.T^{\left(n^{\prime}\right)}\right)\left(\log \left(y_{i} / \bar{x}_{n^{\prime}}\right)\right)+t}^{\left({ }^{\prime}\right)}-\right.$ $\left.\xi_{T^{\left(n^{\prime}\right)}\left(\log \left(y_{i} / \bar{x}_{n^{\prime}}\right)\right.}^{\left(n^{\prime}\right.}, t \geq 0\right)$ for some indices $n$ and $n^{\prime}$ such that $x_{n} \leq y_{j}$ and $x_{n^{\prime}} \leq y_{i}$. But we can check from Corollary 1 that since $x_{n} \leq y_{i}$ and $x_{n}^{\prime} \leq y_{i}$, we have $X_{V_{i}+.}^{\left(\bar{x}_{n}\right)}=X_{V_{i}^{\prime}++}^{\left(\bar{x}_{n^{\prime}}\right)}$, where $V_{j}^{\prime}=\inf \left\{t: X_{t}^{\left(\bar{x}_{n^{\prime}}\right)} \geq y_{j}\right\}$, so that $\tilde{\xi}^{(i)}$ may be defined with respect to $X^{\left(\bar{x}_{n}\right)}$, that is

$$
\left(X^{\left(\bar{x}_{n}\right)}\left(V_{i}+t\right), t \geq 0\right)=\left(y_{i} e^{\tilde{\theta}_{i}} \exp \tilde{\xi}_{\tilde{\tau}^{(i)}\left(t e^{-\tilde{\theta}_{i}} / y_{i}\right)}^{(i)}, t \geq 0\right)
$$

and in particular, we have:

$$
\tilde{\xi}^{(i)}=\left(\xi^{(n)}\left(T_{\log \left(y_{i} / \bar{x}_{n}\right)}^{(n)}+t\right)-\xi^{(n)}\left(T_{\log \left(y_{i} / \bar{x}_{n}\right)}^{(n)}\right), t \geq 0\right) .
$$

On the other hand, one easily checks that

$$
T_{\log \left(y_{i} / \bar{x}_{n}\right)}^{(n)}=T_{\log \left(y_{j} / \bar{x}_{n}\right)}^{(n)}+\tilde{T}_{\log \left(y_{i} e^{-\tilde{\theta}_{j}} / y_{j}\right)}^{(j)},
$$

hence,

$$
\begin{aligned}
\tilde{\xi}^{(i)} & =\left(\xi^{(n)}\left(T_{\log \left(y_{j} / \bar{x}_{n}\right)}^{(n)}+\tilde{T}_{\log \left(y_{i} e^{\left.-\tilde{\theta}_{j} / y_{j}\right)}\right.}^{(j)}+t\right)-\xi^{(n)}\left(T_{\log \left(y_{j} / \bar{x}_{n}\right)}^{(n)}+\tilde{T}_{\log \left(y_{i} e^{-\tilde{\theta}_{j} / y_{j}}\right)}^{(j)}\right), t \geq 0\right) \\
& =\left(\tilde{\xi}^{(j)}\left(\tilde{T}_{\log \left(y_{i} e^{-\tilde{\theta}_{j}} / y_{j}\right)}^{j j}+t\right)-\tilde{\xi}^{(j)}\left(\tilde{T}_{\log \left(y_{i} e^{\left.-\tilde{\theta}_{j} / y_{j}\right)}\right.}^{(j)}\right), t \geq 0\right),
\end{aligned}
$$

which is identity (3.23), and identity (3.24) follows.

Proof of Theorem 1. Since $X^{(0)}$ is obtained as the concatenation of the processes $\left(X_{\Sigma_{n}-t}^{\left(\bar{x}_{n}\right)}, \Sigma_{n} \leq t \leq \Sigma_{n-1}\right)$, we need conditions which insure that the sum $\Sigma_{n}=\sum_{k=n}^{\infty} S^{(k)}$ is a.s. finite. Moreover, for $X^{(0)}$ to be issued from 0 in a 'continuous' way, that is otherwise than by a jump, it is also necessary to have $\lim _{n} \bar{x}_{n}=0$. These are the objects of the next lemma.

Lemma 2 Assume that ( $H$ ) holds.
(i) $\lim _{n \rightarrow+\infty} \bar{x}_{n}=0$, a.s.
(ii) For any $n \geq 1, \Sigma_{n}>0$, a.s.
(iii) $\Sigma_{n}<+\infty$, a.s. if and only if (2.13) holds.

Proof. To prove part ( $i$ ), it suffices to observe that $\left(\bar{x}_{n}\right)=\left(x_{n} e^{\theta_{n}}\right)$ is a nonnegative decreasing sequence (indeed, $\bar{x}_{n-1}=X^{\bar{x}_{n}}\left(S^{(n-1)}\right)$ ), so it converges almost surely. Moreover, since the $\theta_{n}$ 's are identically distributed, the limit law of the sequence $\left(x_{n} e^{\theta_{n}}\right)$ is the Dirac mass at 0 .

To prove (ii), first note that $\Sigma_{n}=0$ a.s. if and only if for each $k \geq n, S^{(k)}=0$, which is also equivalent to $X_{0}^{(k)}=x_{k} e^{\theta_{k}} \geq x_{k-1}$. Indeed, $X^{(k)}$ is right continuous, so it has no jump at 0 . Hence, we have

$$
\begin{aligned}
P\left(\Sigma_{n}=0\right) & =P\left(x_{j} e^{\theta_{j}} \geq x_{j-1}, \text { for all } j \geq n\right) \\
& =\lim _{k \rightarrow+\infty} P\left(x_{j} e^{\theta_{j}} \geq x_{j-1}, \text { for all } j=n, \ldots, n+k\right) .
\end{aligned}
$$

But from (3.20), $\left\{x_{j} e^{\theta_{j}} \geq x_{j-1}\right.$, for all $\left.j=n, \ldots, n+k\right\}=\left\{x_{n+k} e^{\theta_{n+k}} \geq x_{n-1}\right\}$ so that

$$
P\left(\Sigma_{n}=0\right)=\lim _{k \rightarrow+\infty} P\left(x_{n+k} e^{\theta_{n+k}} \geq x_{n-1}\right)
$$

and this limit is 0 since the $\theta_{i}$ 's have the same non degenerate law and $\left(x_{n}\right)$ tends to 0 .
Now we prove (iii). We start by the following remark. Let

\tilde{X}^{\left(\bar{y}_{n}\right)}=\left(y_{n} e^{\tilde{\theta}_{n}} \exp \tilde{\xi}_{\tilde{\tau}^{(n)}\left(t e^{-\tilde{\theta}_{n}} / y_{n}\right)}^{(n)}, t \geq 0\right)
$$

with $\bar{y}_{n}=y_{n} e^{\tilde{\theta}_{n}}$, be the processes which are defined in (3.22) of Corollary 2, with respect to a sequence $\left(y_{n}\right)$ which decreases towards 0 . Set $\tilde{S}^{(n-1)}=\inf \left\{t: \tilde{X}^{\left(\bar{y}_{n}\right)} \geq y_{n-1}\right\}$, then we see from the identity (3.22) that if $x_{n} \leq y_{j} \leq y_{j-1} \leq x_{k}$, then

S^{(n-1)}+\ldots+S^{(k)} \geq \tilde{S}^{(j-1)} \tag{3.25}
\end{equation*}
$$

Conversely, one can check exactly as in Corollary 2 that for $y_{n} \leq x_{j}$, if $\tilde{V}_{j}=\inf \{t$ : $\left.\tilde{X}_{t}^{\left(\bar{y}_{n}\right)} \geq x_{j}\right\}$, then we have

\left(\tilde{X}^{\left(\bar{y}_{n}\right)}\left(\tilde{V}_{j}+t\right), t \geq 0\right)=\left(x_{j} e^{\theta_{j}} \exp \xi_{\tau^{(j)}\left(t e^{\left.-\theta_{j} / x_{j}\right)}\right.}^{(j)} t \geq 0\right)
$$

which shows that if $y_{n} \leq x_{j} \leq x_{j-1} \leq y_{k}$, then

$$
\begin{equation*}
\tilde{S}^{(n-1)}+\ldots+\tilde{S}^{(k)} \geq S^{(j-1)} \tag{3.26}
\end{equation*}
$$

Inequalities (3.25) and (3.26) prove that $\sum_{k \geq n} \tilde{S}^{(k)}$ is finite if and only if $\sum_{k \geq n} S^{(k)}$ is finite. Hence the convergence of the sum $\Sigma_{n}=\sum_{k \geq n} S^{(k)}$ does not depend on the sequence $\left(x_{n}\right)$ and we can consider any particular sequence in the sequel of this proof.

Observe that $S^{(n-1)}=x_{n} e^{\theta_{n}} \int_{0}^{T^{(n)}} \exp \xi_{s}^{(n)} d s$, where $T^{(n)}=\inf \left\{t \geq 0: \xi_{t}^{(n)} \geq\right.$ $\left.\log \left(x_{n-1} e^{-\theta_{n}} / x_{n}\right)\right\}$. Note also that $T^{(n)}=0$ whenever $x_{n} e^{\theta_{n}} \geq x_{n-1}$. Hence

$$
\begin{equation*}
x_{n} \int_{0}^{T^{(n)}} \exp \xi_{s}^{(n)} d s \leq S^{(n-1)} \leq x_{n-1} \int_{0}^{T^{(n)}} \exp \xi_{s}^{(n)} d s, \quad \text { a.s. } \tag{3.27}
\end{equation*}
$$

Now from the previous remark, we may take $x_{n}=e^{-n}$, then from (3.27), the sum $\sum_{n} S^{(n)}$ converges if and only if $\sum_{n} e^{-n} \int_{0}^{T^{(n)}} \exp \xi_{s}^{(n)} d s<\infty$, a.s. But, by construction,
the processes $\left(\xi_{s}^{(n)}, 0 \leq s \leq T^{(n)}\right)$ are independent, (see their construction in (2.5) and (2.6) or equivalently in (3.18) and (3.19)) hence the r.v.'s $\int_{0}^{T^{(n)}} \exp \xi_{s}^{(n)} d s$ are independent and the above sum is finite if and only if

$$
\sum_{n} \mathbb{P}\left(\int_{0}^{T^{(n)}} \exp \xi_{s}^{(n)} d s \geq e^{n}\right)<\infty
$$

Since with $x_{n}=e^{-n}$ we have $T^{(n)}=\inf \left\{t: \xi_{t}^{(n)} \geq 1-\theta_{n}\right\}$, the above condition is equivalent to $E\left(f\left(\int_{0}^{T_{1-\theta}} \exp \xi_{s} d s\right)\right)<\infty$, where $f(x)=\log x$, if $x \geq 1$ and 0 , if $x<1$. Obviously, (2.13) implies the previous condition. Now take $x_{n}=e^{-2 n}$, then the same arguments as above show that $\Sigma_{n}<+\infty$ if and only if $E\left(f\left(\int_{0}^{T_{2-\theta}} \exp \xi_{s} d s\right)\right)<\infty$ holds. From [3], for any $\varepsilon>0, P(\theta \in[0, \varepsilon])>0$, thus, from the independence between $\theta$ and $\xi$, there exists $\eta$ with $0<\eta<1$, such that $E\left(\int_{0}^{T_{2-\eta}} \exp \xi_{s} d s\right)<\infty$. This implies (2.13).

Lemma 2 shows that the definition of $X^{(0)}$, i.e.

$$
X_{t}^{(0)}= \begin{cases}X_{\left.t-\Sigma_{1}\right)}^{\left(\bar{x}_{1}\right)}, & t \in\left[\Sigma_{1}, \infty\right) \\ X_{t-\Sigma_{2}}^{\left(\bar{x}_{2}\right)}, & t \in\left[\Sigma_{2}, \Sigma_{1}\right) \\ \vdots & \\ X_{t-\Sigma_{n}}^{\left(\bar{x}_{n}\right)}, & t \in\left[\Sigma_{n}, \Sigma_{n-1}\right) \\ \vdots & \end{cases}
$$

makes sense. Indeed, since $\lim _{n} \Sigma_{n}=0$, the process $X^{(0)}$ is well defined on $(0, \infty)$. Moreover since $\Sigma_{n}>0$, a.s. for any $n$ and $\lim _{n} x_{n} e^{\theta_{n}}=0$, a.s., we have $\lim _{t \rightarrow 0} X_{t}^{(0)}=0$. Now we put $X_{0}^{(0)}=0$ so that $X^{(0)}$ is a càdlàg process on $[0, \infty)$, which is positive on $(0, \infty)$.

As in the proof of the previous lemma, let

$$
\tilde{X}^{\left(\bar{y}_{n}\right)}=\left(y_{n} e^{\tilde{e}_{n}} \exp \tilde{\xi}_{\tilde{\tau}^{(n)}\left(t e^{-\tilde{\theta}_{n}} / y_{n}\right)}^{(n)}, t \geq 0\right)
$$

be the processes which are defined in Corollary 2 and recall $\tilde{S}^{(n-1)}=\inf \left\{t: \tilde{X}^{\left(\bar{y}_{n}\right)} \geq\right.$ $\left.y_{n-1}\right\}$ and $\tilde{\Sigma}_{n}=\sum_{k \geq n} \tilde{S}^{(k)}$. Let $\bar{y}_{n}=y_{n} e^{\tilde{\theta}_{n}}$, then we see from the construction (2.9) and from (3.22) in Corollary 2 that $X^{(0)}$ may be represented as the concatenation of the processes $\left(\tilde{X}_{\tilde{\Sigma}_{n}-t}^{\left(\bar{y}_{n}\right)}, \tilde{\Sigma}_{n} \leq t \leq \tilde{\Sigma}_{n-1}\right)$ which are defined as $\left(X_{\Sigma_{n}-t}^{\left(\bar{x}_{n}\right)}, \Sigma_{n} \leq t \leq \Sigma_{n-1}\right)$, in the same way as in (2.9), but with respect to the sequence $\left(y_{n}\right)$. The law of these processes does not depend on the sequence $\left(x_{n}\right)$, hence neither does the law of $X^{(0)}$. This proves $(i)$ of Theorem 1.

Part (ii) follows from the path properties of the processes $X^{\left(\bar{x}_{n}\right)}$ and is straightforward.

We see from the construction (2.9) of the process $X^{(0)}$ that the process $\left(k X_{k^{-1} t}^{(0)}, t \geq\right.$ $0)$ is obtained from the concatenation of the processes $\left(\tilde{X}_{\tilde{\Sigma}_{n}-t}^{\left(\bar{y}_{n}\right)}, \tilde{\Sigma}_{n} \leq t \leq \tilde{\Sigma}_{n-1}\right)$, with the particular sequence $y_{n}=k x_{n}$ (note that in this particular case, $\left(\tilde{\theta}_{n}, \tilde{\xi}^{(n)}\right)=$
$\left.\left(\theta_{n}, \xi^{(n)}\right)\right)$. Hence, from $(i)$ of this theorem, the process, $\left(k X_{k^{-1} t}^{(0)}, t \geq 0\right)$ has the same law as $X^{(0)}$ and (iii) is proved.

It remains to prove (iv) of Theorem 1 , that is the Markov property of $X^{(0)}$. To do so, we need the following lemma.

Lemma 3 The process $X^{(0)}$ is independent of the tail-sigma field of $\left(\theta_{n}\right)$, i.e. $\mathcal{G} \stackrel{\text { (def) }}{=}$ $\cap_{n} \sigma\left\{\theta_{i}, i \geq n\right\}$. Consequently $\mathcal{G}$ is trivial.

Proof. As we already noticed, it follows from Corollary 1 and construction (2.9) that $X^{\left(\bar{x}_{n}\right)}=\left(X_{\Sigma_{n}+t}^{(0)}, t \geq 0\right)$. We derive from this identity that $\lim _{n \rightarrow \infty} X^{\left(\bar{x}_{n}\right)}=X^{(0)}$, a.s. on the space $\mathcal{D}$ of càdlàg trajectories. Let $\mathcal{G}_{n}=\sigma\left\{\theta_{n}, \theta_{n+1}, \ldots\right\}$ and $\mathcal{G}=\cap_{n} \mathcal{G}_{n}$. By construction, $X^{\left(\bar{x}_{n}\right)}$ is a functional of $\xi^{(n)}$ and $\theta_{n}$, then from Proposition 1, it is clear that the law of this process conditionally on $\left(\theta_{n}, \theta_{n+1}, \ldots\right)$ is the same as its law conditionally on $\theta_{n}$, so that from the Markov property, for any bounded and continuous functional $H$ on $\mathcal{D}$, we have

$$
\begin{equation*}
E\left(H\left(X^{\left(\bar{x}_{n}\right)}\right) \mid \mathcal{G}_{n}\right)=E\left(H\left(X^{\left(\bar{x}_{n}\right)}\right) \mid \theta_{n}\right)=\mathbb{E}_{x_{n} e^{\theta_{n}}}(H) \xrightarrow[n \rightarrow \infty]{(\text { a.s. })} E\left(H\left(X^{(0)}\right) \mid \mathcal{G}\right) . \tag{3.28}
\end{equation*}
$$

Now fix $k \geq 1$ and let $f_{1}, \ldots, f_{k}$ be $k$ bounded measurable functions, then it follows from (3.28) that

$$
\begin{equation*}
E\left(f_{1}\left(\theta_{1}\right) \ldots f_{k}\left(\theta_{k}\right) E\left(H\left(X^{(0)}\right) \mid \mathcal{G}\right)\right)=\lim _{n} E\left(f_{1}\left(\theta_{1}\right) \ldots f_{k}\left(\theta_{k}\right) \mathbb{E}_{x_{n} e^{\theta_{n}}}(H)\right) \tag{3.29}
\end{equation*}
$$

From our construction of $\theta_{1}, \ldots, \theta_{k}$, and more precisely, from (3.20), we have

$$
\begin{aligned}
& E\left(f_{1}\left(\theta_{1}\right) \ldots f_{k}\left(\theta_{k}\right) \mathbb{E}_{x_{n} e^{\theta_{n}}}(H)\right) \\
= & E\left(f_{1}\left[\xi_{T^{(n)}\left(\log x_{1} e^{-\theta_{n}} / x_{n}\right)}^{(n)}-\left(\log x_{1} e^{-\theta_{n}} / x_{n}\right)\right]\right. \\
& \left.\ldots f_{k}\left[\xi_{T^{(n)}\left(\log x_{k} e^{-\theta_{n}} / x_{n}\right)}^{(n)}\left(\log x_{k} e^{-\theta_{n}} / x_{n}\right)\right] \mathbb{E}_{x_{n} e^{\theta_{n}}}(H)\right),
\end{aligned}
$$

where we recall that $\xi^{(n)}$ and $\theta_{n}$ are independent. Denote by $E_{z}$ the law of the process $\xi^{(n)}+z, z \in \mathbb{R}$. Then since the $\theta_{n}$ 's have the same law, the second member of the above equality may be written as
$E\left(E_{\theta}\left(f_{1}\left[\xi_{T^{(n)}\left(\log x_{1} / x_{n}\right)}^{(n)}-\left(\log x_{1} / x_{n}\right)\right] \ldots f_{k}\left[\xi_{T^{(n)}\left(\log x_{k} / x_{n}\right)}^{(n)}-\left(\log x_{k} / x_{n}\right)\right]\right) \mathbb{E}_{x_{n} e^{\theta}}(H)\right)$, and from Proposition 1,

$$
\begin{gather*}
E_{\theta}\left(f_{1}\left[\xi_{T^{(n)}\left(\log x_{1} / x_{n}\right)}^{(n)}-\left(\log x_{1} / x_{n}\right)\right] \ldots f_{k}\left[\xi_{T^{(n)}\left(\log x_{k} / x_{n}\right)}^{(n)}-\left(\log x_{k} / x_{n}\right)\right]\right) \\
\xrightarrow[n \rightarrow \infty]{(\text { a.s. })} \tag{3.30}
\end{gather*} E\left(f_{1}\left(\theta_{1}\right) \ldots f_{k}\left(\theta_{k}\right)\right) .
$$

We then deduce from (3.28), (3.29), (3.30) and Lebesgue's Theorem of dominated convergence that

$$
\left.E\left(f_{1}\left(\theta_{1}\right) \ldots f_{k}\left(\theta_{k}\right) E\left(H\left(X^{(0)}\right)\right) \mid \mathcal{G}\right)\right)=E\left(f_{1}\left(\theta_{1}\right) \ldots f_{k}\left(\theta_{k}\right)\right) E\left(H\left(X^{(0)}\right)\right)
$$

As a consequence, we have $E\left(E\left(H\left(X^{(0)}\right) \mid \mathcal{G}\right) \mid \sigma\left(\theta_{1}, \ldots, \theta_{k}\right)\right)=E\left(H\left(X^{(0)}\right)\right)$, for any $k$, so that $E\left(E\left(H\left(X^{(0)}\right) \mid \mathcal{G}\right) \mid \sigma\left(\theta_{1}, \theta_{2} \ldots\right)\right)=E\left(H\left(X^{(0)}\right)\right)$, hence $E\left(H\left(X^{(0)}\right) \mid \mathcal{G}\right)=$ $E\left(H\left(X^{(0)}\right)\right)$ since $\mathcal{G} \subset \sigma\left(\theta_{1}, \theta_{2} \ldots\right)$. It proves that $X^{(0)}$ is independent of $\mathcal{G}$. On the other hand, since $\Sigma_{n}=\inf \left\{t: X_{t}^{(0)} \geq x_{n}\right\}$ and $X_{\Sigma_{n}}^{(0)}=X_{0}^{\left(\bar{x}_{n}\right)}=x_{n} e^{\theta_{n}}$ then the sequence $\left(\theta_{n}\right)$ may be generated by the process $X^{(0)}$. In particular $\mathcal{G}$ is a sub- $\sigma$ field of the $\sigma$-field generated by $X^{(0)}$, hence it is trivial.

To prove that $X^{(0)}$ is a strong Markov process, note that from (3.28), and Lemma 3, we obtain

\begin{equation*}
\mathbb{E}_{\bar{x}_{n}}(H) \xrightarrow[n \rightarrow \infty]{(\text { a.s. })} E\left(H\left(X^{(0)}\right)\right), \tag{3.31}
\end{equation*}
$$

for any bounded, continuous functional $H$ defined on $\mathcal{D}$. So the Markov property of the process $X^{(0)}$ is inherited from the same property for the family $\mathbb{P}_{x}, x>0$. This proves part (iv) and ends the proof of Theorem 1.

Proof of Proposition 3. Suppose first that $E\left(\xi_{1}\right)>0$. It has been shown in [2] and [4] that for fixed $t \geq 0$, the law of $X_{t}$ under $\mathbb{P}_{x}$ converges weakly as $x \rightarrow 0$ towards a non degenerate probability law. It is clear from (3.31) that this entrance law is the law of $X_{t}^{(0)}$, so the result is due to [2] and [4] in that case.

Now suppose that $E\left(\xi_{1}\right)=0$ and consider the process $X^{(0, \lambda)}$ which is defined as in (2.9), but relatively to the Lévy process $\xi \stackrel{(\lambda)}{(\text { def) }}\left(\xi_{t}+\lambda t, t \geq 0\right)$ and its corresponding limit overshoot $\theta^{(\lambda)}$. (Note that from section 2.1, conditions of Theorem 1 are satisfied for $\left(\xi_{t}+\lambda t, t \geq 0\right)$ so that such a construction is possible). Comparing (2.11) and (2.12), it appears that to prove Proposition 3, we only have to check that for all $\mu \geq 0$ and for all $t \geq 0$,

$$
\lim _{\lambda \rightarrow 0} E\left(\exp \left(-\mu X_{t}^{(0, \lambda)}\right)\right)=E\left(\exp \left(-\mu X_{t}^{(0)}\right)\right)
$$

Now, let $\left(x_{n}\right)$ be any sequence which is as in Proposition 2 and let, $\left(\theta_{n}^{(\lambda)}, \xi^{(n, \lambda)}\right)$,

$$
X_{t}^{(n, \lambda)}=x_{n} e^{\theta_{n}^{(\lambda)}} \exp \xi_{\tau^{(n, \lambda)}\left(t e^{\left.-\theta_{n}^{(\lambda)} / x_{n}\right)}\right.}^{(n, \lambda)}, \quad t \geq 0, \quad n \geq 1
$$

$\tau^{(n, \lambda)}$, and $S^{(n, \lambda)}$ be defined as in Proposition (2.5), (2.6), (2.7) and (2.8), but relatively to the laws of $\xi^{(\lambda)}$ and its corresponding limit overshoot $\theta^{(\lambda)}$. Put $\Sigma_{n}^{(\lambda)}=\sum_{k>n} S^{(k, \lambda)}$ then it follows from the construction (2.9) which is stated in Theorem 1 and the Markov property that

$$
\begin{align*}
E\left(\exp \left(-\mu X_{t}^{(0, \lambda)}\right)\right) & =\sum_{n \geq 1} E\left(\exp \left(-\mu X_{t-\Sigma_{n}^{(\lambda)}}^{(n, \lambda)}\right) \mathbb{I}_{\left\{t \in\left[\Sigma_{n}^{(\lambda)}, \Sigma_{n-1}^{(\lambda)}\right)\right\}}\right) \\
& \left.=\sum_{n \geq 1} E\left(\mathbb{E}_{x_{n} e_{n}^{(\lambda)}}^{(\lambda)}\left(\exp \left(-\mu X_{t}\right) \mathbb{I}_{\left\{t<S_{x_{n-1}}\right\}}\right\}\right)\right), \tag{3.32}
\end{align*}
$$

where $\mathbb{P}_{x}^{(\lambda)}$ is the law of the process defined in (1.2), with respect to $\xi^{(\lambda)}, X$ is the canonical process on $\mathcal{D}$ and $S_{x_{n-1}}$ is its first passage time above the state $x_{n-1}$. On the
one hand, a result which is due to Doney [9] asserts that

$$
\begin{equation*}
\theta^{(\lambda)} \xrightarrow{(w)} \theta, \quad \text { as } \lambda \text { tends to } 0 . \tag{3.33}
\end{equation*}
$$

On the other hand, it is not difficult to check from (1.2) that the family $\left(\mathbb{P}_{x}^{(\lambda)}\right)$ is weakly continuous in $(\lambda, x)$, on the space $[0, \infty) \times(0, \infty)$, and that the set of discontinuities of the functional $S_{x_{n-1}}$ is negligible under any of the probability measures $\left(\mathbb{P}_{x}^{(\lambda)}\right)$, $(\lambda, x) \in[0, \infty) \times(0, \infty)$. Indeed, this set is

$$
\begin{aligned}
& \left\{\omega \in \mathcal{D}: \exists \varepsilon>0, X\left(S_{x_{n-1}}+t\right)(\omega)=x_{n-1}, \forall t \in[0, \varepsilon]\right\} \cup \\
& \left\{\omega \in \mathcal{D}: \exists \varepsilon>0, X\left(S_{x_{n-1}}\right)(\omega)=x_{n-1}, X\left(S_{x_{n-1}}+t\right)(\omega)<x_{n-1}, \forall t \in(0, \varepsilon]\right\},
\end{aligned}
$$

but the latter is negligible from (1.2) and the path properties of (non lattice) Lévy processes. Hence, $\mathbb{E}_{x}^{(\lambda)}\left(\exp \left(-\mu X_{t}\right) \mathbb{I}_{\left\{t<S_{x_{n-1}}\right\}}\right)$ is bounded and continuous in $(\lambda, x)$, on the space $[0, \infty) \times(0, \infty)$, and from (3.33), for any $n \geq 1$, since $x_{n}>0$,

$$
E\left(\mathbb{E}_{x_{n} e^{(\lambda)}}^{(\lambda)}\left(\exp \left(-\mu X_{t}\right) \mathbb{I}_{\left\{t<S_{x_{n-1}}\right\}}\right)\right) \longrightarrow E\left(\mathbb{E}_{x_{n} e^{\theta_{n}}}\left(\exp \left(-\mu X_{t}\right) \mathbb{I}_{\left\{t<S_{x_{n-1}}\right\}}\right)\right)
$$

as $\lambda$ tends to 0 , so that from (3.32) and Fatou's lemma, we have for all $\mu \geq 0$,

$$
\begin{aligned}
\lim _{\lambda \rightarrow 0} E\left(\exp \left(-\mu X_{t}^{(0, \lambda)}\right)\right) & =\sum_{n \geq 1} E\left(\mathbb{E}_{x_{n} e^{\theta_{n}}}\left(\exp \left(-\mu X_{t}\right) \mathbb{I}_{\left\{t<S_{x_{n-1}}\right\}}\right)\right) \\
& =E\left(\exp \left(-\mu X_{t}^{(0)}\right)\right),
\end{aligned}
$$

and the conclusion follows.

Proof of Theorem 2. We first suppose that $(H)$ holds and that $E\left(\log \int_{0}^{T_{1}} \exp \xi_{s} d s\right)<$ $+\infty$. Let $H$ be any bounded, continuous functional $H$ which is defined on $\mathcal{D}$. Since the $\theta_{n}$ 's have the same law, we deduce from (3.31) that

$$
\mathbb{E}_{x_{n} e^{\theta}}(H) \xrightarrow[n \rightarrow \infty]{(\mathrm{P})} E\left(H\left(X^{(0)}\right)\right) .
$$

It proves that $\mathbb{E}_{x_{i_{n}} e^{\theta}}(H) \xrightarrow[n \rightarrow \infty]{\stackrel{\text { a.s.) }}{\longrightarrow}} E\left(H\left(X^{(0)}\right)\right)$, for a sub sequence $\left(x_{i_{n}}\right)$. Let $\omega \in \Omega$ be such that $k \stackrel{\text { deff }}{=} e^{\theta(\omega)}$ satisfies $\mathbb{E}_{k x_{i_{n}}}(H) \longrightarrow E\left(H\left(X^{(0)}\right)\right)$, then from the scaling property under $\mathbb{P}_{x}, x>0$ and under $\mathbb{P}_{0}$ stated respectively in (1.1) and (2.10), we can replace $X^{(0)}$ by $\left(k X_{k^{-1} t}^{(0)}, t \geq 0\right)$ in the above convergence in order to obtain

$$
\mathbb{E}_{x_{i_{n}}}(H) \longrightarrow E\left(H\left(X^{(0)}\right)\right), \quad \text { as } n \rightarrow+\infty
$$

We proved that for any decreasing sequence $\left(x_{n}\right)$ which converges towards 0 , there exists a subsequence ( $x_{i_{n}}$ ) such that the above convergence holds, hence it holds for any decreasing sequence which converges towards 0 .

Conversely suppose that the family of probability measures $\left(\mathbb{P}_{x}\right)$ converges weakly as $x \rightarrow 0$ towards a non degenerate probability measure $\mathbb{P}_{0}$ on $\mathcal{D}$. Necessarily, $\mathbb{P}_{0}$ is
the law of a pssMp with index 1 , which starts from 0 and never comes back to 0 and whose limsup is infinite. We denote by $X^{(0)}$ a process on $\mathcal{D}$ whose law is $\mathbb{P}_{0}$. (Here we no longer suppose the validity of the construction (2.9)). Let $\left(x_{n}\right)$ be a real decreasing sequence which tends to 0 and define $\Sigma_{n}=\inf \left\{t: X_{t}^{(0)} \geq x_{n}\right\}$. We see from the Markov property and (1.2) that for any $n \geq 1$,

$$
\begin{equation*}
\left(X^{(0)}\left(\Sigma_{n}+t\right), t \geq 0\right) \stackrel{(d)}{=}\left(X_{\Sigma_{n}}^{(0)} \exp \xi_{\tau^{(n)}\left(t / X_{\Sigma_{n}}^{(0)}\right)}^{(n)}, t \geq 0\right) \tag{3.34}
\end{equation*}
$$

where $\xi^{(n)}$ is distributed as $\xi$ and is independent of $X_{\Sigma_{n}}^{(0)}$, and $\tau^{(n)}$ is as usual. Let $n \geq 1$; from Lemma 1, the value of the process $\left(X_{\Sigma_{n}}^{(0)} \exp \xi_{\tau^{(n)}\left(t / X_{\Sigma_{n}}^{(0)}\right)}^{(n)}, t \geq 0\right)$ at its first passage time above $x_{1}$ is

$$
X_{\Sigma_{n}}^{(0)} \exp \xi^{(n)}\left(T_{\log \left(x_{1} / X_{\Sigma_{n}}^{(0)}\right)}\right)=x_{1} \exp \left(\xi^{(n)}\left(T_{\log \left(x_{1} / X_{\Sigma_{n}}^{(0)}\right)}\right)-\log \left(x_{1} / X_{\Sigma_{n}}^{(0)}\right)\right)
$$

So from (3.34), we deduce that

$$
\begin{equation*}
X^{(0)}\left(\Sigma_{1}\right) \stackrel{(d)}{=} x_{1} \exp \left(\xi^{(n)}\left(T_{\log \left(x_{1} / X_{\Sigma_{n}}^{(0)}\right)}\right)-\log \left(x_{1} / X_{\Sigma_{n}}^{(0)}\right)\right) \tag{3.35}
\end{equation*}
$$

Indeed, since $x_{1} \geq x_{n}$, the value of the process $X^{(0)}$ at its first passage time above $x_{1}$ is the same as the value of the process $\left(X^{(0)}\left(\Sigma_{n}+t\right), t \geq 0\right)$ at its first passage time above $x_{1}$. On the other hand, the scaling property of the process $X^{(0)}$ implies that the law of the r.v.'s $x_{n}^{-1} X_{\Sigma_{n}}^{(0)}, n \geq 1$ is the same and does not depend on the sequence $\left(x_{n}\right)$. Moreover these r.v.'s are a.s. positive. Let $\theta$ be a r.v. which is distributed as $\log \left(x_{n}^{-1} X_{\Sigma_{n}}^{(0)}\right)$ and independent of the sequence $\left(\xi^{(n)}\right)$, then we deduce from the fact that the law of $x_{n}^{-1} X_{\Sigma_{n}}^{(0)}$ does not depend on $n$ and from (3.35) that the law of $\xi^{(n)}\left(T_{\log \left(x_{1} / x_{n}\right)-\theta}\right)-\left(\log \left(x_{1} / x_{n}\right)-\theta\right)$ does not depend on $n$ and is the same as this of $\theta$. The same result is true for any sequence $\left(x_{n}\right)$ which decreases towards 0 , hence we have proved that the process $\left(\xi^{(n)}\left(T_{z-\theta}\right)-(z-\theta), z \geq 0\right)$ is stationary and Proposition 1 allows us to conclude that $\xi^{(n)}\left(T_{z}\right)-z$ converges weakly as $z$ tends to $+\infty$ towards the law of $\theta$.

Finally, recall that from (3.34) we have

$$
\left(X^{(0)}\left(\Sigma_{n}+t\right), t \geq 0\right) \stackrel{(d)}{=}\left(x_{n} e^{\theta_{n}} \exp \xi_{\tau^{(n)}\left(t / x_{n} e^{\theta_{n}}\right)}^{(n)} t \geq 0\right)
$$

where $\theta_{n}=\log \left(x_{n}^{-1} X_{\Sigma_{n}}^{(0)}\right)$ has the same law as $\theta$. Therefore $X^{(0)}$ may be constructed as in (2.9) and the first passage time $\Sigma_{n}$ admits the same decomposition as in Theorem 1. This r.v. is obviously finite and Lemma 1 (iii) shows that $E\left(\log ^{+} \int_{0}^{T_{1}} \exp \xi_{s}^{(n)} d s\right)<\infty$.

Remark: When $(H)$ holds but $E\left(\log ^{+} \int_{0}^{T_{1}} \exp \xi_{s} d s\right)=+\infty$, we see from Lemma 2 that $\Sigma_{n}=+\infty$. Following the previous proofs, it shows that the first passage time of the process $\left(X, \mathbb{P}_{x}\right)$ over $y$, (i.e. $S_{y}=x A_{T_{z}}$ in the notations of Lemma 1 ) tends almost surely towards $+\infty$, as $x$ tends to 0 . It means that the process $\left(X, \mathbb{P}_{x}\right)$ converges almost surely towards the process $X^{(0)} \equiv 0$.

## 4 Examples.

The aim of this section is to present some examples where pssMp are known through a different setting than Lamperti's work and for which the results presented in Theorems 1 and 2 are well known.

Recall that the only positive self-similar Markov processes which are continuous are Bessel processes raised to any nonnegative power and multiplied by any constant. Indeed, since the only continuous Lévy processes are Brownian motions with drift multiplied by any constant, this observation is a direct consequence of Lamperti representation (1.2). Recall also that the Bessel process of dimension $\mu \geq 0$ and starting from $x \geq 0$ is the diffusion $R$ which satisfies the stochastic differential equation

$$
\begin{equation*}
R_{t}=x+2 \int_{0}^{t} \sqrt{R_{s}} d B_{s}+\mu t, \quad t \geq 0 \tag{4.36}
\end{equation*}
$$

where $B$ is the standard Brownian motion. Then $R$ admits the following Lamperti representation

$$
R_{t}=x \exp B_{\tau^{(\nu)}\left(t x^{-1 / 2}\right)}^{(\nu)}, t \geq 0
$$

where $B^{(\nu)}$ is a Brownian motion with drift $\nu=\mu / 2-1$, i.e. $B^{(\nu)}=\left(B_{t}+\nu t, t \geq 0\right)$, and $\tau_{t}^{(\nu)}=\inf \left\{s: \int_{0}^{s} \exp B_{s}^{(\nu)}>t\right\}$. Since $\limsup _{t} B_{t}^{(\nu)}=+\infty$ if and only if $\nu \geq 0$, the cases which are treated in this paper concerns the Bessel process with dimension $\mu \geq 2$, raised to any positive power. (Note that the only case where the process $R$ does not drift to $+\infty$ is when $\mu=2$.) Then it is well known that conditions of Theorems 1 and 2 are satisfied and that the limit process which is defined in Theorem 1 is the unique strong solution of Equation (4.36), for $x=0$.

The class of stable Lévy processes conditioned to stay positive provides another interesting example. Let $Y$ be any such process with index $\alpha \in(0,2]$, and let $P_{x}$ be the law of $Y+x$. The real function $x \mapsto x^{\alpha \rho}$ defined on $[0, \infty)$, where $\rho=P_{0}\left(Y_{1} \leq 0\right)$, is harmonic for the semi-group of the process $Y$ killed at its first entrance time into the negative half-line. Let $\tau=\inf \left\{t: Y_{t} \leq 0\right\}$ be this time, and call $\left(\mathcal{F}_{t}\right)$ the usual filtration on $\mathcal{D}$, then the $h$-process whose law is defined as follows:

$$
\mathbb{P}_{x}(\Lambda)=x^{-\alpha \rho} E_{x}\left(Y_{t}^{\alpha \rho} \mathbb{I}_{\Lambda} \mathbb{I}_{\{t<\tau\}}\right), \quad \Lambda \in \mathcal{F}_{t}, \quad t \geq 0, \quad x>0
$$

is a strong Markov process which is called the Lévy process $Y$ conditioned to stay positive. A more intuitive way to define this process is to first condition $Y$ to stay positive on the time interval $[0, s]$ and then to let $s$ going to $+\infty$ :

$$
\mathbb{P}_{x}(\Lambda)=\lim _{s \uparrow \infty} P_{x}(\Lambda \mid \tau>s), \quad \Lambda \in \mathcal{F}_{t}, \quad t \geq 0, \quad x>0
$$

It is clear that $\left(X, \mathbb{P}_{x}\right)$ is a pssMp. We emphasize that when $Y$ is the standard Brownian motion, the process $\left(X, \mathbb{P}_{x}\right)$ corresponds to the three dimensional Bessel process. We refer to [6] for a more complete study of Lévy processes conditioned to stay positive. In particular, in [6], it is shown that $\left(X, \mathbb{P}_{x}\right)$ satisfies $\lim _{t \uparrow \infty} X_{t}=+\infty, \mathbb{P}_{x^{-} \text {-a.s. }}$.

Moreover, $\left(X, \mathbb{P}_{x}\right)$ reaches its overall minimum only once and $\left(X, \mathbb{P}_{x}\right)$ converges weakly on $\mathcal{D}$, as $x$ tends to 0 , towards the law of the post-minimum process ( $X_{m+t}, t \geq 0$ ), $m=\inf \left\{t: X_{t}=\inf _{s \geq 0} X_{s}\right\}$, see also [7]. As a $\operatorname{pssMp},\left(X, \mathbb{P}_{x}\right)$ admits a Lamperti representation. The law of the underlying Lévy process $\xi$ in this representation has been computed in [5] in terms of the law of $Y$. Suppose that $\alpha \in[1,2)$. Let $\Phi$ be the characteristic exponent of $Y$, i.e. $\Phi(u)=-\log E\left(\exp i u Y_{1}\right)$, then it is well known that $\Phi$ admits the Lévy Khintchnie decomposition:

$$
\Phi(u)=i m u+\int_{(-\infty, \infty)}\left(1-e^{i u x}+i u x \mathbb{I}_{\{|x| \leq 1\}}\right) \mu(d x),
$$

where $m \in \mathbb{R}$ and

$$
\mu(d x)=\left(c_{+} x^{-(\alpha+1)} \mathbb{I}_{\{x>0\}}+c_{-}|x|^{-(\alpha+1)} \mathbb{I}_{\{x<0\}}\right) d x
$$

$c_{+}$and $c_{-}$being positive constants. According to [5], the characteristic exponent of $\xi$ introduced in subsection 2.1, admits the Lévy Khintchine decomposition

$$
\psi(u)=i a u+\int_{(-\infty, \infty)}\left(1-e^{i u x}+i u x \mathbb{\Psi}_{\{|x| \leq 1\}}\right) \pi(d x),
$$

with $a=m+\int_{0<u<2}(u-1)\left(u^{\alpha \rho}-1\right)\left(c_{+}(u-1)^{-(\alpha+1)} \mathbb{I}_{\{u>1\}}+c_{-} \mathbb{I}_{\{u<1\}}(1-u)^{-(\alpha+1)}\right) d u$ and with the Lévy measure

$$
\pi(d x)=\left(\frac{c_{+} e^{(\alpha \rho+1) x} \mathbb{I}_{\{x>0\}}}{\left(e^{x}-1\right)^{\alpha+1}}+\frac{c_{-} e^{(\alpha \rho+1) x} \mathbb{I}_{\{x<0\}}}{\left|e^{x}-1\right|^{\alpha+1}}\right) d x .
$$

Here again, it can be checked that the conditions of Theorems 1 and 2 are satisfied.
