# Optimal strategies and utility-based prices converge when agents' preferences do*

#### Abstract

A discrete-time financial market model is considered with a sequence of investors whose preferences are described by utility functions $U_{n}$ defined on the whole real line. It is shown, under suitable hypotheses, that whenever $U_{n}$ tends to a utility function $U_{\infty}$, the respective optimal strategies, the Davis and Hodges-Neuberger prices converge, too. Under additional assumptions the rate of convergence can also be estimated.

## 1 Introduction

In the present article we are interested in the following question: does the convergence of agents' preferences entail the convergence of the respective optimal strategies? We assume that these preferences are described by means of utility functions, i.e. strictly concave, increasing functions $U_{n}, n \in \mathbb{N}$ converging to some utility function $U_{\infty}$. In [6] the case of a complete Brownian model was studied, where investors' utility functions were defined on the positive axis. It was shown that the convergence of optimal strategies indeed takes place under appropriate conditions.

In this paper we focus on different classes of models and agents: discretetime markets with finite time horizon and utility functions defined on the whole real line. Supposing that prices are bounded and satisfy a uniform noarbitrage condition, we prove that the convergence of utility functions (having "uniform asymptotic elasticity") implies the convergence of the respective optimal strategies. Under stronger assumptions on the convergence of $U_{n}$, we also show that the convergence rate is the same in both cases.

Note that these financial market models are, unlike the ones in [6], generically incomplete. Since in incomplete markets the choice of a suitable pricing rule is a fundamental issue we also establish the convergence of two types of utility-based prices: Davis price (see [2]) and utility indifference price (see [3]). Section 2 provides precise definitions and formulations of the principal results, section 3 recalls some useful facts about utility maximization, the proofs of the main results are presented in section 4.

## 2 Main results

Let $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{0 \leq t \leq T}, P\right)$ be a discrete-time filtered probability space with time horizon $T \in \mathbb{N}$. We assume that $\mathcal{F}_{0}$ coincides with the family of $P$-zero sets. Let $\left\{S_{t}, 0 \leq t \leq T\right\}$ be a $d$-dimensional adapted process representing the discounted - by some numéraire - price process of $d$ securities in a given economy. The notation $\Delta S_{t}:=S_{t}-S_{t-1}$ will often be used. Trading strategies are given by $d$-dimensional processes $\left\{\psi_{t}, 1 \leq t \leq T\right\}$ which are supposed to be predictable (i.e. $\psi_{t}$ is $\mathcal{F}_{t-1}$-measurable). The class of all such strategies is denoted by $\Phi$. Denote by $L^{\infty}, L_{+}^{\infty}$ the sets of bounded, nonnegative bounded random variables, respectively, equipped with the supremum norm $\|\cdot\|_{\infty}$.

Trading is assumed to be self-financing, so the value process of a portfolio
$\psi \in \Phi$ is

$$
V_{t}^{z, \psi}:=z+\sum_{j=1}^{t}\left\langle\psi_{t}, \Delta S_{j}\right\rangle,
$$

where $z$ is the initial capital of the agent in consideration and $\langle\cdot, \cdot\rangle$ stands for the inner product in $\mathbb{R}^{d}$.

Denote by $D_{t}(\omega)$ the smallest affine hyperplane containing the support of the (regular) conditional distribution of $\Delta S_{t}$ with respect to $\mathcal{F}_{t-1}$. We refer to Proposition 8.1 of [8] for more details about the (random) set $D_{t}$.

The following absence of arbitrage condition is standard:

$$
(N A): \forall \psi \in \Phi\left(V_{T}^{0, \psi} \geq 0 \text { a.s. } \Rightarrow V_{T}^{0, \psi}=0 \text { a.s. }\right)
$$

However, we need to assume a certain strengthening of the above concept hence an alternative characterization is provided in the Proposition below. Let $\Xi_{t}$ denote the set of $\mathcal{F}_{t}$-measurable $d$-dimensional random variables,

$$
\tilde{\Xi}_{t}:=\left\{\xi \in \Xi_{t}: \xi \in D_{t+1} \text { a.s. }|\xi|=1 \text { on }\left\{D_{t+1} \neq\{0\}\right\}\right\}
$$

Proposition 2.1 (NA) holds if and only if there exist $\mathcal{F}_{t}$-measurable random variables $\beta_{t}, 0 \leq t \leq T-1$ such that

$$
\begin{equation*}
\text { ess. } \inf _{\xi \in \tilde{\Xi}_{t}} P\left(\left\langle\xi, \Delta S_{t+1}\right\rangle<-\beta_{t} \mid \mathcal{F}_{t}\right)>0 \text { a.s. on }\left\{D_{t+1} \neq\{0\}\right\} . \tag{1}
\end{equation*}
$$

Proof. The direction $(N A) \Rightarrow(1)$ is Proposition 3.3 of [8]. The other direction is clear from the implication $(g) \Rightarrow(a)$ of Theorem 3 in [4].

We formulate a stronger concept of absence of arbitrage which strengthens the "uniform absence of arbitrage" property figuring in [11].

Assumption 2.2 There exist constants $\beta, \kappa>0$ such that

\text { ess. } \inf _{\xi \in \tilde{\Xi}_{t}} P\left(\left\langle\xi, \Delta S_{t+1}\right\rangle<-\beta \mid \mathcal{F}_{t}\right)>\kappa \text { a.s. on }\left\{D_{t+1} \neq\{0\}\right\}
$$

The following technical assumption roughly says that there are no redundant assets, even conditionally.

Assumption 2.3 $D_{t}$ is almost surely equal to $\mathbb{R}^{d}$, for all $1 \leq t \leq T$.
Remark 2.4 Results hold without this hypothesis but proofs get messy.
Introduce the notation $\overline{\mathbb{N}}:=\mathbb{N} \cup\{\infty\}$. Consider a sequence of agents with preferences converging to some limiting preference.

Assumption 2.5 Suppose that $U_{n}: \mathbb{R} \rightarrow \mathbb{R}, n \in \mathbb{N}$ is a sequence of strictly concave and increasing continuously differentiable functions such that for all $x \in \mathbb{R}$

$$
U_{n}(x) \rightarrow U_{\infty}(x), \quad n \rightarrow \infty
$$

Remark 2.6 Note that the above Assumption implies the uniform convergence of both $U_{n}$ and $U_{n}^{\prime}$ on compacts, by p. 90 and p. 248 of [9].

A further technical condition needs to be imposed which will guarantee the existence of optimal strategies as well as their uniform boundedness, see Theorem 3.4 below.

Assumption 2.7 Assume that there exist $0<\gamma<1, \tilde{x}>0$ such that for all $\lambda \geq 1, y \geq \tilde{x}$ and for all $n \in \overline{\mathbb{N}}$

$$
\begin{equation*}
U_{n}(\lambda y) \leq \lambda^{\gamma} U_{n}(y) \tag{2}
\end{equation*}
$$

Remark 2.8 This assumption says that agents' utility functions satisfy a certain uniform asymptotic elasticity condition at $+\infty$, consult [7] and Remark 2.4 of [8] about this notion, compare also to property (P3) on p. 135 of [6]. We remark that our results remain true if we replace (2) by some condition on the asymptotic elasticity of the $U_{n}$ at $-\infty$ :
there exists $\tilde{x}<0<\theta$ such that for all $\lambda \geq 1, y \leq \tilde{x}$ and for all $n \in \mathbb{N}$

$$
U_{n}(\lambda y) \leq \lambda^{1+\theta} U_{n}(y),
$$

see Remark 2.6 of [8] and [10].
In case we would like to estimate the rate of convergence a strengthening of Assumption 2.5 is needed.

Assumption 2.9 The functions $U_{n}, n \in \overline{\mathbb{N}}$ are strictly concave, increasing and twice continuously differentiable. For all $N>0$, the second derivative satisfies the bounds

$$
\ell(N) \leq\left|U_{n}^{\prime \prime}(x)\right| \leq L(N), x \in[-N, N], n \in \overline{\mathbb{N}}
$$

with constants $\ell(N), L(N)>0$ and there exists a sequence of real numbers $g(n) \rightarrow 0, n \rightarrow \infty$ such that

$$
\begin{equation*}
\left|U_{n}(0)-U_{\infty}(0)\right|+\sup _{x \in[-N, N]}\left|U_{n}^{\prime}(x)-U_{\infty}^{\prime}(x)\right| \leq C(N) g(n), n \in \mathbb{N}, \tag{3}
\end{equation*}
$$

where the $C(N)$ are suitable constants.

Remark 2.10 The condition on $U_{n}^{\prime \prime}$ is a kind of "uniform strict concavity" property. Under Assumption 2.9 the inequality

$$
\begin{equation*}
\left|U_{n}(x)-U_{\infty}(x)\right| \leq\left|U_{n}(0)-U_{\infty}(0)\right|+\int_{0}^{x}\left|U_{n}^{\prime}(y)-U_{\infty}^{\prime}(y)\right| d y \tag{4}
\end{equation*}
$$

shows that $U_{n}$ tends to $U_{\infty}$ uniformly on compacts with convergence speed $O(g(n))$. Note that if $U_{n}$ tends to $U_{\infty}$ uniformly on compacts with convergence speed $O(g(n))$ then (3) does not always holds true.

If we assume that $U_{n}^{\prime \prime}$ converges to $U_{\infty}^{\prime \prime}$ at the rate $g(n)$, that $U_{\infty}^{\prime \prime}<0$ and also that there exists some $x_{0} \in \mathbb{R}$ satisfying $U_{n}\left(x_{0}\right)$ and $U_{n}^{\prime}\left(x_{0}\right)$ converge respectively to $U_{\infty}\left(x_{0}\right)$ and $U_{\infty}^{\prime}\left(x_{0}\right)$ at the rate $g(n)$, then one can prove (by an argument similar to (4)) that Assumption 2.9 holds.

Example 2.11 Typical examples are the sequences $U_{n}(x)=-e^{-\alpha_{n} x}, x \in$ $\mathbb{R}, 0<\alpha_{n}, n \in \overline{\mathbb{N}}$ where $\alpha_{n} \rightarrow \alpha_{\infty}$ at a given rate $O(g(n))$.

Fix any element $G \in L_{+}^{\infty}$ and define

$$
u_{n}(G, z):=\sup _{\phi \in \Phi\left(U_{n}, G, z\right)} E U_{n}\left(V_{T}^{z, \phi}-G\right),
$$

where $\Phi\left(U_{n}, G, z\right)$ denotes the family of strategies $\phi \in \Phi$ such that $E U_{n}\left(V_{T}^{z, \phi}-\right.$ $G$ ) exists. The quantity $u_{n}(G, z)$ represents the supremum of expected utility from initial capital $z$ delivering a contingent claim with payoff $G$ at the terminal date.

Theorem 2.12 Suppose that $S$ is bounded and Assumptions 2.2, 2.3, 2.5 and 2.7 hold. Then there exist almost surely unique optimal strategies $\psi_{n, t}^{*}(z), 1 \leq t \leq T, n \in \mathbb{N}$ satisfying

$$
u_{n}(G, z)=E U_{n}\left(V_{T}^{z, \psi_{n}^{*}(z)}-G\right),
$$

and $\lim _{n \rightarrow \infty} \psi_{n, t}^{*}(z)=\psi_{\infty, t}^{*}(z)$ almost surely, for all $1 \leq t \leq T$.
Moreover, $u_{n}(G, z)$ tends to $u_{\infty}(G, z)$ uniformly on compact sets.
Theorem 2.13 Assume hypotheses of the previous Theorem, with Assumption 2.5 replaced by 2.9. For all $N>0$ there exist suitable constants $J_{t}(N)$ and $J(N)$ such that, for all $1 \leq t \leq T$,

$$
\begin{aligned}
\sup _{z \in[-N, N]}\left|\psi_{n, t}^{*}(z)-\psi_{\infty, t}^{*}(z)\right| & \leq J_{t}(N) g(n), \\
\sup _{z \in[-N, N]}\left|u_{n}(G, z)-u_{\infty}(G, z)\right| & \leq J(N) g(n) .
\end{aligned}
$$

Example 2.14 We now demonstrate that convergence of optimal strategies may fail for unbounded price processes. Define for all $n \in \overline{\mathbb{N}}$
$U_{n}(x):=1-(1-x)^{2+1 / n}, x \leq 0, \quad U_{n}(x):=(4+2 / n) \sqrt{x+1}-4-2 / n, x>0$, with the convention $1 / \infty=0$. It is easily verified that Assumption 2.5 and 2 holds for this sequence. Now set

$$
\alpha_{1}:=\sum_{n=2}^{\infty} \frac{1}{n^{3} \log ^{2} n}, \quad \alpha_{2}:=\frac{\pi^{2}}{6}=\sum_{n=1}^{\infty} \frac{1}{n^{2}} .
$$

Take $T=1$ and $\Delta S_{1}$ such that

$$
P\left(\Delta S_{1}=-n\right)=\frac{1}{2 \alpha_{1} n^{3} \log ^{2} n}, n \geq 2 ; \quad P\left(\Delta S_{1}=\delta n\right)=\frac{1}{2 \alpha_{2} n^{2}}, n \geq 1
$$

where $\delta>0$ is to be determined later. Assumption 2.2 holds for $\beta=1$ and $\kappa=1 / 3$. As $\sum_{p \geq 0} \frac{1}{p^{\alpha} \log ^{2} p}=\infty$ for $\alpha<1$ and $<\infty$ for $\alpha \geq 1$, it is easy to check that for all $n \in \mathbb{N}$ and $\phi \neq 0$ we have $E U_{n}\left(\phi \Delta S_{1}\right)=-\infty$. Consequently $\phi_{n}^{*}=0$ is optimal. On the other hand,

$$
E U_{\infty}\left(\Delta S_{1}\right)=\frac{1}{2}-\sum_{n=2}^{\infty} \frac{(n+1)^{2}}{2 \alpha_{1} n^{3} \log ^{2} n}+2 \sum_{n=1}^{\infty} \frac{\sqrt{\delta n+1}}{\alpha_{2} n^{2}}-2
$$

which is finite and, for $\delta$ sufficiently large, strictly greater than 0 , so $\phi_{\infty}^{*}$ (which exists by Theorem 2.7 of [8]) cannot be 0 .

Take again $G \in L_{+}^{\infty}$, interpreted as the payoff at time $T$ of some derivative security. A remarkable pricing method has been suggested in [2]: to evaluate claim $G$ using the measure

$$
\frac{d Q}{d P}=\frac{U^{\prime}\left(V_{T}^{z, \psi^{*}(z)}\right)}{E U^{\prime}\left(V_{T}^{z, \psi^{*}(z)}\right)},
$$

where $U$ is a suitable utility function and $\psi^{*}(z)$ is the optimal strategy with initial endowment $z$, i.e.

$$
u(0, z)=\sup _{\phi \in \Phi(U, 0, z)} E U\left(V_{T}^{z, \phi}\right)=E U\left(V_{T}^{z, \psi^{*}(z)}\right)
$$

Under appropriate conditions (see section 6 of [8]) $Q$ indeed defines an equivalent risk-neutral measure. In this way individual preferences of agents are taken into account when choosing the pricing functional by some "marginal rate of substitution argument", see [2] or p. 229 of [1] for more economic justifications of this method. Theorem 2.12 permits us to establish the continuity of Davis price with respect to changes in the agents' preferences.

Theorem 2.15 Suppose that hypotheses of Theorem 2.12 hold. Let $\psi_{n}^{*}(z), n \in$ $\overline{\mathbb{N}}$ be the optimal strategies figuring in Theorem 2.12. Then the RadonNykodim derivatives

$$
\frac{d Q_{n}}{d P}=\frac{U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right)}{E U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right)}
$$

define equivalent martingale measures for $S$ and $Q_{n} \rightarrow Q_{\infty}$ in the total variation norm. Consequently,

$$
\begin{equation*}
E^{Q_{n}} G \rightarrow E^{Q_{\infty}} G \tag{5}
\end{equation*}
$$

for any contingent claim $G \in L_{+}^{\infty}$, i.e. the respective Davis prices converge, too.

Moreover under the additional assumption of Theorem 2.13, there exists some constant $A$ such that

$$
\left|E^{Q_{n}} G-E^{Q_{\infty}} G\right| \leq A g(n)
$$

Now consider another pricing concept, originating from [3]. The HodgesNeuberger or utility indifference price of some bounded contingent claim $G$ is the minimal amount of money to be paid to the seller and added to her initial capital so that her utility when selling $G$ is at least as the one she could get without selling it.

Definition 2.16 For any $G \in L_{+}^{\infty}$ and $x \in \mathbb{R}$, the utility indifference price $p_{n}(G, x)$ is defined as

$$
p_{n}(G, x)=\inf \left\{z \in \mathbb{R}: u_{n}(G, x+z) \geq u_{n}(0, x)\right\}, n \in \overline{\mathbb{N}} .
$$

It is easy to check that this quantity is well-defined and $0 \leq p_{n}(G, x) \leq\|G\|_{\infty}$. In our case $u_{n}(G, \cdot), u_{n}(0, \cdot)$ are strictly increasing (see the statement of Proposition 3.6), so $u_{n}\left(G, x+p_{n}(G, x)\right)=u_{n}(0, x)$.

Theorem 2.17 Under the hypotheses of Theorem 2.12, $p_{n}(G, x) \rightarrow p_{\infty}(G, x)$ as $n \rightarrow \infty$.

## 3 Facts about utility maximization

In this section we use a dynamic programming procedure to prove the existence of optimal strategies and to derive bounds on them. Results of Theorem 3.4 hold true under weaker hypotheses on $\left(U_{n}\right)_{n \in \mathbb{N}}$ than Assumption 2.5. What we need is the Assumption below:

Assumption 3.1 The function $U_{n}: \mathbb{R} \rightarrow \mathbb{R}, n \in \overline{\mathbb{N}}$ are concave, nondecreasing and continuously differentiable,

$$
\sup _{n \in \mathbb{N}}\left|U_{n}(x)\right|<\infty \text { for all } x \in \mathbb{R}, \quad \inf _{n \in \mathbb{N}} U_{n}^{\prime}(0)>0
$$

In what follows, it is crucial that the asymptotic elasticity property (2) admits a reformulation which is preserved during the dynamic programming procedure. This is the content of the next Condition. Let $V: \mathbb{R} \rightarrow \mathbb{R}$ be a function.
Condition 3.2 There exists $C_{1}>0$ and $C_{2}>0$ such for all $x \in \mathbb{R}$ and $\lambda \geq 1$ :

$$
\begin{array}{r}
V(\lambda x) \leq \lambda^{\gamma} V\left(x+C_{1}\right)+C_{2} \lambda^{\gamma} \\
V(\lambda x) \leq \lambda V\left(x+C_{1}\right)+C_{2} \lambda^{\gamma}
\end{array}
$$

Fix some $G \in L_{+}^{\infty}$ and set $U_{n, T}(x, \omega):=U_{n}(x-G(\omega))$. Proposition 3.3 below initiates the dynamic programming procedure.

Proposition 3.3 Under Assumptions 2.7 and 3.1, $U_{n, T}$ satisfies Condition 3.2 almost surely with constants $C_{1}, C_{2}$ independent from $n$.

Proof. Set $C_{1}:=\|G\|_{\infty}, C_{3}(x):=\sup _{n \in \overline{\mathbb{N}}}\left|U_{n}(x)\right|$ and $C_{4}:=C_{3}(0)$. These are finite by our hypotheses. Define $U_{n}(x):=U_{n}(x)-U_{n}(0)$. Then by Assumption 2.7 we have for $x \geq \tilde{x}$ and $\lambda \geq 1$ :

$$
\tilde{U}_{n}(\lambda x) \leq \lambda^{\gamma} U_{n}(x)+C_{4} \leq \lambda^{\gamma} \tilde{U}_{n}(x)+C_{4} \lambda^{\gamma}+C_{4} \leq \lambda^{\gamma} \tilde{U}_{n}(x)+2 C_{4} \lambda^{\gamma}
$$

For $0 \leq x \leq \tilde{x}$, using monotonicity:

$$
\begin{aligned}
\tilde{U}_{n}(\lambda x) & \leq \tilde{U}_{n}(\lambda \tilde{x}) \leq \lambda^{\gamma} U_{n}(\tilde{x})+C_{4} \leq \lambda^{\gamma} C_{3}(\tilde{x})+C_{4} \\
& \leq \lambda^{\gamma} \tilde{U}_{n}(x)+\lambda^{\gamma}\left[2 C_{4}+C_{3}(\tilde{x})\right],
\end{aligned}
$$

using that $\tilde{U}_{n}(x) \geq 0$ if $x \geq 0$. For $x \leq 0$, again by concavity:

$$
\begin{aligned}
\tilde{U}_{n}(\lambda x) & \leq \tilde{U}_{n}(x)+\tilde{U}_{n}^{\prime}(x)(\lambda-1) x \leq \tilde{U}_{n}(x)+\frac{\tilde{U}_{n}(x)-\tilde{U}_{n}(0)}{x}(\lambda-1) x \\
& \leq \lambda \tilde{U}_{n}(x) \leq \lambda^{\gamma} \tilde{U}_{n}(x)
\end{aligned}
$$

Putting together the estimations so far, we obtain that Condition 3.2 holds for $\tilde{U}_{n}, n \in \overline{\mathbb{N}}$ with uniform constants $\tilde{C}_{1}:=0, \tilde{C}_{2}:=2 C_{4}+C_{3}(\tilde{x})$. Now for $U_{n, T}$ we get

$$
\begin{aligned}
U_{n, T}(\lambda x) & \leq U_{n}(\lambda x) \leq \tilde{U}_{n}(\lambda x)+C_{4} \\
& \leq \lambda^{\gamma} \tilde{U}_{n}(x)+\left[\tilde{C}_{2}+C_{4}\right] \lambda^{\gamma} \leq \lambda^{\gamma} U_{n}(x)+\left[\tilde{C}_{2}+2 C_{4}\right] \lambda^{\gamma} \\
& \leq \lambda^{\gamma} U_{n, T}\left(x+C_{1}\right)+\left[\tilde{C}_{2}+2 C_{4}\right] \lambda^{\gamma},
\end{aligned}
$$

showing that the first inequality of Condition 3.2 is true for $U_{n, T}, n \in \overline{\mathbb{N}}$ with the choice $C_{2}:=\tilde{C}_{2}+2 C_{4}$, uniformly in $n$. The second inequality follows in the same way.

The starting point of the following Theorem is Remark 7.2 of [8].
Theorem 3.4 Suppose that Assumptions 2.2, 2.7 and 3.1 hold. For all $n \in \overline{\mathbb{N}}$, we introduce the following random functions :

$$
\begin{aligned}
U_{n, T}(x) & :=U_{n}(x-G) \\
U_{n, s}(x) & :=\quad \text { ess. } \sup _{\xi \in \Xi_{s}} E\left(U_{n, s+1}\left(x+\left\langle\xi, \Delta S_{s+1}\right\rangle\right) \mid \mathcal{F}_{s}\right), \quad 0 \leq s \leq T-1
\end{aligned}
$$

For all $n \in \overline{\mathbb{N}}, 0 \leq s \leq T, U_{n, s}$ are well-defined and satisfy

$$
\begin{equation*}
U_{n, s}(x)<\infty . \tag{6}
\end{equation*}
$$

The functions $U_{n, s}$ have almost surely concave and increasing continuously differentiable versions satisfying Condition 3.2 with constants uniform in $n$. For all $n \in \overline{\mathbb{N}}, 0 \leq s \leq T-1$ and $x \in \mathbb{R}$, there exists $\tilde{\xi}_{n, s+1}(x) \in \Xi_{s}$ such that $\tilde{\xi}_{n, s+1} \in D_{s+1}$ a.s. and

For all $0 \leq s \leq T-1$, there exist nondecreasing functions $M_{s}, \hat{M}_{s}$ and $H_{s}$ : $\mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$such that for all $n \in \overline{\mathbb{N}}, x \in \mathbb{R}$ :

U_{n}^{\prime}\left(H_{s+1}(|x|)\right) & \leq U_{n, s+1}^{\prime}(x) \leq U_{n}^{\prime}\left(-H_{s+1}(|x|)\right) . \tag{11}
\end{align*}

For all $n \in \overline{\mathbb{N}}, z \in \mathbb{R}$ the utility maximization problems

admit optimal solutions $\psi_{n}^{*}(z)$ given by

\end{equation*}
$$

There exists nondecreasing functions $\Upsilon_{t}: \mathbb{R}_{+} \rightarrow \mathbb{R}_{+}$such that for all $n \in \overline{\mathbb{N}}$, $z \in \mathbb{R}$

and the value functions of the optimization problems are finite, i.e. $u_{n}(G, z)=$ $U_{n, 0}(z)<\infty$.

Proof. Suppose $d=1$ for notational simplicity and let $R$ denote a constant bound for the process $|\Delta S|$.

Sections 4 and 5 of [8] will be used, but the estimations have to be carried out in a more explicit way. The hypotheses which are needed there: $E\left(U_{n, s}\right)>-\infty$, (6) and Condition 3.2 for $U_{n, s}$; these will be shown in the reasonings below.

First note that $E\left(U_{n, s}\right)>-\infty$ holds true by backward induction for all $s=0, \ldots, T$ because $U_{n, s}(x) \geq E\left(U_{n, s+1}(x) \mid \mathcal{F}_{s}\right)$ and $U_{n, T}(x) \geq U_{n}(x-$ $\|G\|_{\infty}$ ). From standard arguments, $U_{n, s}$ are concave functions.

We shall apply backward induction to prove (7) to (11). First, (6) is trivial for $s=T$, (9) and (11) are trivial for $s=T-1$ and Condition 3.2 for $U_{n, T}$ holds by Proposition 3.3. Moreover, as $S$ and $G$ are bounded, it is easy to see that (6) holds true for $s=T-1$. So from Proposition 4.4, Lemma 4.9 and Proposition 6.5 of [8], $U_{n, T-1}$ have almost surely concave and increasing continuously differentiable versions and (7) and (10) hold. Finally, (8) will follow just like in the induction step below.

Let us proceed supposing that the induction hypotheses hold for $s \geq t$. We get from (8) for $s=t$ that

$M_{t}$ is nondecreasing as $\hat{M}_{t+1}$ and $M_{t+1}$ are. Using (7) for $s=t$ and the fact that $U_{n, t+1}$ is nondecreasing, we get that almost surely

article and (7) holds for $s=t-1$ and $U_{n, t-1}$ have almost surely concave and increasing versions. Moreover, we get that from Proposition 6.5 of the same paper that $U_{n, t-1}$ has almost surely continuously differentiable versions and (10) is satisfied.

It is also clear from (8), (10), (11) for $s=t$ and from the facts that $H_{t+1}$ is nondecreasing and $U_{n, t+1}^{\prime}$ nonincreasing:

iterating the same reasoning. As $U_{n, T}^{\prime}(0)=U_{n}^{\prime}(-G)$ and $G \geq 0$, we obtain that

Apply the estimations of the proof of Lemma 4.8 in [8] with the choice $V:=U_{t}$ to an arbitrary $\xi \in \Xi_{t-1}, \xi \in D_{t},|\xi| \neq 0$. In that Lemma $C_{1}$ is taken to be 0 , but the argument can be easily adapted to yield

here $L_{n, t}(x)$ is a random variable such that

& \leq 2 \sup _{n \in \mathbb{N}} U_{n}^{+}\left(|x|+C_{1}+R+M_{t}\left(|x|+C_{1}+R\right)\right)=: G_{t}(|x|),
\end{aligned}
$$

and the latter is a deterministic function, nondecreasing in $|x|$ and independent of $n$, by Assumption 3.1.

Now there exists some deterministic function $u \rightarrow \hat{M}_{t}(u), u \in \mathbb{R}_{+}$(chosen to be nondecreasing) such that if $|\xi(\omega)|>\hat{M}_{t}(|x|)$ then

here the infimum is finite by Assumption 3.1 again. Define $A=\{|\xi|>$ $\left.\hat{M}_{t}(|x|)\right\} \in \mathcal{F}_{t-1}$. Then on $A$, from (17) and (9) for $s=t-1$,

with strict inequality on $A$. Assume that $P(A)>0$ and apply the last inequality for $\xi=\tilde{\xi}_{n, t}$; then the strategy $\tilde{\xi}_{n, t}(x) I_{A^{c}}$ contradicts optimality. So (8) holds for $s=t-1$.

It remains to prove that the strategies defined by (12) are optimal. Just like in Proposition 5.3 of [8], we obtain that for any trading strategy $\psi \in$ $\Phi\left(U_{n}, G, z\right)$ :

Thus $\psi_{n}^{*}(z)$ is the solution of

Proof. Indeed, define $F_{t}(u):=u+R\left[\sum_{j=1}^{t} \Upsilon_{j}(u)\right]$.
Proposition 3.6 If we assume, in addition to conditions of Theorem 3.4, that the $U_{n}$ are strictly concave for $n \in \overline{\mathbb{N}}$ then the $U_{n, t}$ (and thus $u_{n}(G, \cdot)=$ $U_{n, 0}$ ) are strictly concave for all $t=0, \ldots, T$ and there exists a unique optimal strategy $\psi_{n}^{*}$ such that almost surely $\psi_{n, t}^{*} \in D_{t}$, for all $t=1, \ldots, T$.

Proof. To see strict concavity we argue by backward induction : the case $s=T$ is trivial, suppose that for some $s<T$ and $x \neq y$ and $0<\alpha<1$ we have

E\left(U_{n, s+1}\left(\alpha x+(1-\alpha) y+\tilde{\xi}_{n, s+1}(\alpha x+(1-\alpha) y) \Delta S_{s+1}\right) \mid \mathcal{F}_{s}\right) .
\end{array}
$$

On $A$, the first and the third lines are equal, so from the equality of the first and the second lines we get

I_{A} U_{n, s+1}\left(\alpha x+(1-\alpha) y+\left[\alpha \tilde{\xi}_{n, s+1}(x)+(1-\alpha) \tilde{\xi}_{n, s+1}(y)\right] \Delta S_{s+1}\right)
\end{gathered}
$$

So by strict concavity of $U_{n, s+1}$ one has on $A$

As $x \neq y$, the quantity $\tilde{\xi}_{n, s+1}(x)-\tilde{\xi}_{n, s+1}(y)$ is nonzero, so we have

Unicity of $\tilde{\xi}_{n, t}$ is a consequence of Theorem 2.8 in [8].

Corollary 3.7 Suppose that Assumptions 2.2, 2.5 and 2.7 hold. Then $U_{n, t}$ converges to $U_{\infty, t}$ almost surely, uniformly on compacts, for all $0 \leq t \leq T$. In particular, $u_{n}(G, \cdot)=U_{n, 0}(\cdot)$ converges to $u_{\infty}(G, \cdot)=U_{\infty, 0}(\cdot)$ uniformly on compacts.

Proof. It suffices to establish almost sure convergence pointwise as by monotonicity and concavity of $U_{n, t}$ this entails almost sure uniform convergence on compact sets, see p. 90 of [9]. Assumption 2.5 and strict monotonicity of $U_{\infty}$ imply that Assumption 3.1 holds and hence Theorem 3.4 applies. It is clear from (7) that

$$

Then we have

& \geq \liminf _{n \rightarrow \infty} E\left(U_{n}\left(l_{\infty}\right) \mid \mathcal{F}_{t}\right)=E\left(U_{\infty}\left(l_{\infty}\right) \mid \mathcal{F}_{t}\right)=U_{\infty, t}(x)
\end{aligned}
$$

by optimality of $\phi_{n}^{*}$, Assumption 2.5, Remark 2.6 and the fact that the random variable $l_{\infty}$ is bounded by (13).

In fact, all the $l_{n}$ are bounded, uniformly in $n \in \overline{\mathbb{N}}$ (we will denote by $K$ such a bound) and recalling (9), the random variables $U_{n, t}(x)=E\left(U_{n}\left(l_{n}\right) \mid \mathcal{F}_{t}\right)$ are also uniformly bounded in $n \in \overline{\mathbb{N}}$. As

Using again Lemma 2 of [5] for the uniformly bounded sequence $l_{\sigma_{n}}$ we can extract another random subsequence (for which we will keep the same notation) such that $l_{\sigma_{n}}$ converges to some $l^{*}$.

The first term is $o(1)$ using the uniform convergence on compact sets of $U_{n}$ to $U_{\infty}$ and the fact that $l_{\sigma_{n}}$ are uniformly bounded by $K$. As $l_{\sigma_{n}} \rightarrow l^{*}, U_{\infty}$ is continuous, $\left|U_{\infty}\left(l_{\sigma_{n}}\right)\right|$ is uniformly bounded, we can use Lebesgue's theorem and the second term is also $o(1)$. As the set of portfolio values is closed in probability (see e.g. the argument of Theorem 1 in [5]), $l^{*}$ is itself the value of a portfolio. Now

\end{aligned}
$$

by optimality of $l_{\infty}$, finishing the proof of this Corollary.
The following Lemma will be used to establish the rate of convergence of the optimal strategies.

Lemma 3.8 Suppose that $S$ is bounded, Assumptions 2.2, 2.3, 2.7 and 2.9 hold. Consider $\tilde{\xi}_{n, s}, n \in \overline{\mathbb{N}}, 1 \leq s \leq T$ as defined in Theorem 3.4. Then for all $N>0$, almost surely,

\sup _{x \in[-N, N]}\left|U_{n, s}(x)-U_{\infty, s}(x)\right| & \leq \tilde{C}_{s}(N) g(n), n \in \mathbb{N}, \tag{21}
\end{align*}
$$

with suitable constants $\ell_{s}(N), L_{s}(N), C_{s}(N), K_{s}(N), \tilde{C}_{s}(N)>0$ and for all $0 \leq s \leq T$.
Proof. Assumption 2.3 assures the uniqueness of the optimal strategy on whole $\mathbb{R}^{d}$ by Proposition 3.6, which will crucial in the arguments of Sublemma below.

Firstly, we remark that under Assumption 2.9, Assumption 3.1 is satisfied, so Theorem 3.4 applies. From now on we suppose $d=1$ for the sake of simplicity. Let $R$ be a constant bound for the process $|\Delta S|$. The proof is by backward induction. (21), (18) and (19) are clear for $s=T$ from Assumption 2.9 and Remark 2.10, (20) follows just like in the induction step below, so let us proceed to the induction step immediately.

Assume that (21), (18), (19) and (20) hold for $s \geq t$. Let us establish them for $s=t-1$. Let $N>0$ and $x \in[-N, N]$, we apply (7), (10) and (8) of Theorem 3.4 for $s=t-1$ and call $X_{t}=N+R \hat{M}_{t}(N)$. Then, using the induction hypotheses, (18) holds true because of

& E\left(\left|U_{\infty, t}^{\prime}\left(x+\tilde{\xi}_{n, t}(x) \Delta S_{t}\right)-U_{\infty, t}^{\prime}\left(x+\tilde{\xi}_{\infty, t}(x) \Delta S_{t}\right)\right| \mid \mathcal{F}_{t-1}\right) \\
\leq & C_{t}\left(X_{t}\right) g(n)+E\left(\left|\Delta S_{t}\left(\tilde{\xi}_{n, t}(x)-\tilde{\xi}_{\infty, t}(x)\right) \sup _{y \in\left[-X_{t}, X_{t}\right]}\right| U_{\infty, t}^{\prime \prime}(y)| | \mathcal{F}_{t-1}\right) \\
\leq & C_{t}\left(X_{t}\right) g(n)+L_{t}\left(X_{t}\right) R K_{t}(N) g(n)=: C_{t-1}(N) g(n),
\end{aligned}
$$

Let us define the random functions

h_{n, t}(x, \xi):=E\left(U_{n, t}\left(x+\xi \Delta S_{t}\right) \mid \mathcal{F}_{t-1}\right), \quad x, \xi \in \mathbb{R}, n \in \overline{\mathbb{N}} .
$$

Set also

f_{n, t}(x, \xi):=E\left(U_{n, t}^{\prime}\left(x+\xi \Delta S_{t}\right) \Delta S_{t} \mid \mathcal{F}_{t-1}\right), \quad x, \xi \in \mathbb{R}, n \in \overline{\mathbb{N}}
$$

Sublemma 3.9 We claim that for all $n \in \overline{\mathbb{N}}$ the random functions $h_{n, t}$ have versions which are almost surely twice continuously differentiable (in both variables), $f_{n, t}$ have differentiable versions (in both variables). $U_{n, t-1}$ have twice continuously differentiable versions (in $x$ ), $\tilde{\xi}_{n, t}(x)$ have continuously differentiable versions (in $x$ ). Furthermore,

\partial_{1} f_{n, t}(x, \xi)=E\left(U_{n, t}^{\prime \prime}\left(x+\xi \Delta S_{t}\right) \Delta S_{t} \mid \mathcal{F}_{t-1}\right), \\
\partial_{2} f_{n, t}(x, \xi)=E\left(U_{n, t}^{\prime \prime}\left(x+\xi \Delta S_{t}\right)\left(\Delta S_{t}\right)^{2} \mid \mathcal{F}_{t-1}\right), \\
U_{n, t-1}^{\prime \prime}(x)=E\left(U_{n, t}^{\prime \prime}\left(x+\tilde{\xi}_{n, t}(x) \Delta S_{t}\right)\left(1+\tilde{\xi}_{n, t}^{\prime}(x) \Delta S_{t}\right) \mid \mathcal{F}_{t-1}\right) . \tag{25}
\end{array}
$$

Proof of Sublemma. In Proposition 6.4 of [8] the existence of a continuously differentiable version for $h_{n, t}$ is shown. Twice continuous differentiability of $h_{n, t}$ as well as the form of the derivatives can be established similarly to that Proposition, using the bounds in Theorem 3.4 and the induction hypotheses of Lemma 3.8. Then continuous differentiability of $f_{n, t}$ as well as (23) and (24) follow. Smooth version of $\tilde{\xi}_{n, t}$ will be provided by the implicit function theorem. To see this, notice that by optimality of $\tilde{\xi}_{n, t}$ and regularity of $h_{n, t}$,

& \geq \kappa \beta^{2} \ell_{t}(N+R|\xi|)>0, x \in[-N, N]
\end{aligned}

by (19) and Assumption 2.2. Hence by the implicit function theorem (see p. 150 of [12]) there exist continuously differentiable (random) functions $\zeta_{n}: \mathbb{R} \rightarrow \mathbb{R}$ such that on a set of probability one

Indeed, the result holds true on some neighbourhood of any real point and by unicity of the implicit function it remains true on the whole real line. Again, by unicity of the implicit function we necessarily have

so $\tilde{\xi}_{n, t}$ can be choosen to be continuously differentiable in $x$. Finally, $U_{n, t-1}^{\prime \prime}$ exists and is of the form (25) by (10) for $s=t-1$ and arguments akin to those of Proposition 6.4 in [8]. One has to establish that Lebesgue's theorem applies when taking the derivative behind the expectation: (22), the estimates (8), (19) and Assumption 2.2 testify that

First note that $\chi_{n, t-1} \geq \ell_{t}\left(N+R \hat{M}_{t}(N)\right)$, by (8) and (19) for $s=t$. If we denote $W$-conditional expectation and variance by $E^{W}\left(\cdot \mid \mathcal{F}_{t-1}\right)$ and $D_{W}^{2}\left(\cdot \mid \mathcal{F}_{t-1}\right)$, we get

\frac{E^{W_{n}}\left(\Delta S_{t} \mid \mathcal{F}_{t-1}\right)^{2} \chi_{n, t-1}}{E^{W_{n}}\left(\left(\Delta S_{t}\right)^{2} \mid \mathcal{F}_{t-1}\right)} & =\frac{E\left(\left.\frac{d W_{n}}{d P} \Delta S_{t} \right\rvert\, \mathcal{F}_{t-1}\right)^{2} E\left(\left.\alpha_{n} \frac{d W_{n}}{P} \right\rvert\, \mathcal{F}_{t-1}\right) E\left(\left.\frac{d W_{n}}{d P} \right\rvert\, \mathcal{F}_{t-1}\right)}{E\left(\left.\frac{d W_{n}}{d P} \right\rvert\, \mathcal{F}_{t-1}\right)^{2} E\left(\left.\frac{d W_{n}}{d P}\left(\Delta S_{t}\right)^{2} \right\rvert\, \mathcal{F}_{t-1}\right)} \\
& =\alpha_{n} \frac{E\left(\left.\frac{d W_{n}}{d P} \Delta S_{t} \right\rvert\, \mathcal{F}_{t-1}\right)^{2}}{E\left(\left.\frac{d W_{n}}{d P}\left(\Delta S_{t}\right)^{2} \right\rvert\, \mathcal{F}_{t-1}\right)}
\end{aligned}
$$

From (25) we get that for $x \in[-N, N]$

-U_{n, t-1}^{\prime \prime}(x) & =E\left(\left.\alpha_{n} \frac{d W_{n}}{d P}\left(1-\frac{E\left(\left.\alpha_{n} \frac{d W_{n}}{d P} \Delta S_{t} \right\rvert\, \mathcal{F}_{t-1}\right)}{E\left(\left.\alpha_{n} \frac{d W_{n}}{d P}\left(\Delta S_{t}\right)^{2} \right\rvert\, \mathcal{F}_{t-1}\right)} \Delta S_{t}\right) \right\rvert\, \mathcal{F}_{t-1}\right) \\
& =\chi_{n, t-1}-\frac{E^{W_{n}}\left(\Delta S_{t} \mid \mathcal{F}_{t-1}\right)^{2} \chi_{n, t-1}}{E^{W_{n}}\left(\left(\Delta S_{t}\right)^{2} \mid \mathcal{F}_{t-1}\right)} \\
& =\chi_{n, t-1} \frac{D_{W_{n}}^{2}\left(\Delta S_{t} \mid \mathcal{F}_{t-1}\right)}{E^{W_{n}}\left(\left(\Delta S_{t}\right)^{2} \mid \mathcal{F}_{t-1}\right)} \\
& \geq \ell_{t}\left(N+R \hat{M}_{t}(N)\right) \frac{1}{R^{2}} D_{W_{n}}^{2}\left(\Delta S_{t} \mid \mathcal{F}_{t-1}\right),
\end{aligned}
$$

The right-hand side is greater than or equal to

$$
\frac{\ell_{t}^{2}\left(N+R \hat{M}_{t}(N)\right)}{L_{t}\left(N+R \hat{M}_{t}(N)\right)} \frac{1}{R^{2}} \beta^{2} \kappa=: \ell_{t-1}(N)
$$

by Assumption 2.2 and

$$
\frac{d W_{n}}{d P} \geq \frac{\ell_{t}\left(N+\hat{M}_{t}(N) R\right)}{L_{t}\left(N+\hat{M}_{t}(N) R\right)}
$$

which is true again by (19) for $s=t$. This shows the first inequality of (19) for $s=t-1$. The proof of the second inequality is easy and hence omitted. We know from Assumption 2.2, (24) and (19) (which has just been proved for $t-1$ ) that for all $n \in \overline{\mathbb{N}}$ :

where we used (26) for the first equality and (18) for $s=t-1$ in the second inequality. This ends the proof of (20) for $s=t-1$. Let $x \in[-N, N]$. Then (21) follows from

& +E\left(U_{\infty, t}^{\prime}\left(-\hat{M}_{t}(0) R\right)\left|\tilde{\xi}_{n, t}(0)-\tilde{\xi}_{\infty, t}(0)\right| R \mid \mathcal{F}_{t-1}\right) \\
\leq & \tilde{C}_{t}\left(\hat{M}_{t}(0) R\right) g(n)+U_{\infty}^{\prime}\left(-H_{t}\left(\hat{M}_{t}(0) R\right)\right) K_{t}(0) R g(n),
\end{aligned}
$$

using (7) and (18) for $s=t-1, U_{\infty, t}^{\prime}$ is nonincreasing, (21), (11) and (20) for $s=t$. This completes the induction step, if we call

## 4 Proof of the main results

Proof of Theorem 2.12. Suppose that the Theorem fails and we have $\psi_{n, t}^{*}(z) \nrightarrow \psi_{\infty, t}^{*}(z)$ for some $t$ and $z \in \mathbb{R}$. We may and will suppose $\psi_{n, s}^{*}(z) \rightarrow$ $\psi_{\infty, s}^{*}(z)$ a.s. $1 \leq s<t$. The $\psi_{n, t}^{*}(z), n \in \mathbb{N}$ are uniformly bounded by (13), hence an argument similar to that of Lemma 2 in [5] provides an $\mathcal{F}_{t-1^{-}}$ measurable random subsequence $n(k)$ such that

and $\hat{\psi}_{t}$ differs from $\psi_{\infty, t}^{*}(z)$ on a set $A \in \mathcal{F}_{t-1}$ of positive measure. Define $\hat{\psi}_{s}:=\psi_{\infty, s}^{*}(z)$ for $s<t$. Then $V_{t-1}^{z, \psi_{\infty}^{*}(z)}=V_{t-1}^{z, \hat{\psi}}$ and by (7) and (12),

& =E\left(U_{\infty, t}\left(V_{t}^{z, \psi_{\infty}^{*}(z)}\right) \mid \mathcal{F}_{t-1}\right) .
\end{aligned}
$$

As Assumption 2.3 holds, the maximizer is unique (see Proposition 3.6) so on $A$ we obtain

\end{equation*}

Then,

\left|E\left(U_{n(k), t}\left(V_{t}^{z, \psi_{n(k)}^{*}}\right) \mid \mathcal{F}_{t-1}\right)-E\left(U_{\infty, t}\left(V_{t}^{z, \hat{\psi}}\right) \mid \mathcal{F}_{t-1}\right)\right| \leq \\
E\left(\left|U_{n(k), t}\left(V_{t}^{\left.z, \psi_{n(k)}^{*}\right)}\right)-U_{\infty, t}\left(V_{t}^{\left.z, \psi_{n(k)}^{*}\right)}\right)\right| \mid \mathcal{F}_{t-1}\right)+E\left(\mid U_{\infty, t}\left(V_{t}^{\left.z, \psi_{n(k)}^{*}\right)}\right)-U_{\infty, t}\left(V_{t}^{z, \hat{\psi}}\right) \| \mathcal{F}_{t-1}\right)
\end{gathered}
$$

By Corollaries 3.5, 3.7, Lebesgue's theorem, the first term is $o(1)$. As $\psi_{n(k), s}^{*}(z) \rightarrow \hat{\psi}_{s}, s \leq t, V_{t}^{z, \psi_{n(k)}^{*}} \rightarrow V_{t}^{z, \hat{\psi}}$ and by continuity of $U_{\infty, t}$, Corollary 3.5 and Lebesgue's theorem, the second term is also $o(1)$.
Using Corollaries 3.5, 3.7 and continuity of $U_{\infty, t-1}$, we can prove that
$U_{n(k), t-1}\left(V_{t-1}^{z, \psi_{n}^{*}(k)}\right)=E\left(U_{n(k), t}\left(V_{t}^{\left.z, \psi_{n(k)}^{*}\right)} \mid \mathcal{F}_{t-1}\right) \rightarrow U_{\infty, t-1}\left(V_{t-1}^{z, \psi_{\infty}^{*}}\right)=E\left(U_{\infty, t}\left(V_{t}^{z, \psi_{\infty}^{*}}\right) \mid \mathcal{F}_{t-1}\right)\right.$ a.s.
as $k \rightarrow \infty$, and $E\left(U_{\infty, t}\left(V_{t}^{z, \psi_{\infty}^{*}}\right) \mid \mathcal{F}_{t-1}\right)=E\left(U_{\infty, t}\left(V_{t}^{z, \hat{\psi}}\right) \mid \mathcal{F}_{t-1}\right)$ a.s., we get a contradiction to (27).

Proof of Theorem 2.13. By forward induction, the first step is as follows. Let $N>0$, from (12) we have:

using (20), so we can set $J_{1}(N)=K_{1}(N)$. By Theorem 3.4, Corollary 3.5, Lemma 3.8, Sublemma 3.9, Assumption 2.2 and the induction hypotheses:

& \sup _{z \in[-N, N]}\left|\tilde{\xi}_{n, t}\left(V_{t-1}^{z, \psi_{n}^{*}(z)}\right)-\tilde{\xi}_{\infty, t}\left(V_{t-1}^{z, \psi_{n}^{*}(z)}\right)\right|+\sup _{z \in[-N, N]}\left|\tilde{\xi}_{\infty, t}\left(V_{t-1}^{z, \psi_{n}^{*}(z)}\right)-\tilde{\xi}_{\infty, t}\left(V_{t-1}^{z, \psi_{\infty}^{*}(z)}\right)\right| \leq \\
& \quad K_{t}\left(F_{t-1}(N)\right) g(n)+\left|V_{t-1}^{z, \psi_{n}^{*}(z)}-V_{t-1}^{z, \psi_{\infty}^{*}(z)}\right|_{y \in\left[-F_{t-1}(N), F_{t-1}(N)\right]} \sup \left|\tilde{\xi}_{\infty, t}^{\prime}(y)\right| \leq \\
& K_{t}\left(F_{t-1}(N)\right) g(n)+R\left(\sum_{j=1}^{t-1} J_{j}(N)\right) g(n) \frac{L_{t}\left(F_{t-1}(N)+\hat{M}_{t}(N) R\right) R}{\ell_{t}\left(F_{t-1}(N)+\hat{M}_{t}(N) R\right) \beta^{2} \kappa}=: J_{t}(N) g(n) .
\end{aligned}
$$

Convergence rate of $u_{n}(G, x)=U_{n, 0}(x)$ follows from (21).

Proof of Theorem 2.15. Theorem 6.2 of [8] shows that $Q_{n}$ is indeed an equivalent martingale measure. By Scheffé's theorem it suffices to establish almost sure convergence of $d Q_{n} / d P$ and this will imply convergence in the
total variation norm as well as (5). To see almost sure convergence we proceed as follows:

$$
\begin{aligned}
\left|U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right)-U_{\infty}^{\prime}\left(V_{T}^{z, \psi_{\infty}^{*}(z)}\right)\right| \leq & \left|U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right)-U_{\infty}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right)\right|+ \\
& +\left|U_{\infty}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right)-U_{\infty}^{\prime}\left(V_{T}^{z, \psi_{\infty}^{*}(z)}\right)\right| .
\end{aligned}
$$

As $\left|V_{T}^{z, \psi_{n}^{*}(z)}\right| \leq F_{T}(|z|)$, remark 2.6 implies that the first term goes to zero a.s. By Theorem 2.12, $V_{T}^{z, \psi_{n}^{*}(z)} \rightarrow V_{T}^{z, \psi_{\infty}^{*}(z)}$ and as $U_{\infty}^{\prime}$ is continuous, the second term tends to 0 a.s. Thus

$$
U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right) \rightarrow U_{\infty}^{\prime}\left(V_{T}^{z, \psi_{\infty}^{*}(z)}\right), \quad n \rightarrow \infty
$$

almost surely. As this sequence is bounded by $\sup _{n \in \mathbb{N}} U_{n}^{\prime}\left(-F_{T}(|z|)\right)$ ( which is finite as $U_{n}^{\prime}$ tends to $U_{\infty}^{\prime}$ ), Lebesgue's theorem implies

$$
E U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right) \rightarrow E U_{\infty}^{\prime}\left(V_{T}^{z, \psi_{\infty}^{*}(z)}\right), \quad n \rightarrow \infty
$$

Now, it is easy to see that if two sequences $x_{n}$ and $y_{n}$ converge to $x_{\infty}$ and $y_{\infty}$ respectively and $y_{n}$ is bounded away from 0 , then $x_{n} / y_{n}$ converges to $x_{\infty} / y_{\infty}$. This observation is still true if the convergences are at the same rate $g(n)$. We want to apply to the present case with the choice $x_{n}:=U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right), y_{n}:=$ $E x_{n}$. As $x_{n} \geq \inf _{n \in \mathbb{N}} U_{n}^{\prime}\left(F_{T}(|z|)\right)>0$ by convergence of the $U_{n}^{\prime} \rightarrow U_{\infty}^{\prime}$ and strict monotonicity of $U_{\infty}^{\prime}$, we get that $\frac{d Q_{n}}{d Q} \rightarrow \frac{d Q_{\infty}}{d Q}$ a.s.

Under the additional Assumption 2.9 of Theorem 2.13, the previous estimations get more precise, indeed for all $z \in[-N, N]$,

$$
\begin{aligned}
\left|U_{n}^{\prime}\left(V_{T}^{z, \psi_{n}^{*}(z)}\right)-U_{\infty}^{\prime}\left(V_{T}^{z, \psi_{\infty}^{*}(z)}\right)\right| \leq & \sup _{y \in\left[-F_{T}(|z|), F_{T}(|z|)\right]}\left|U_{n}^{\prime}(y)-U_{\infty}^{\prime}(y)\right|+ \\
& \left|V_{T}^{z, \psi_{n}^{*}(z)}-V_{T}^{z, \psi_{\infty}^{*}(z)}\right| \sup _{y \in\left[-F_{T}(|z|), F_{T}(|z|)\right]}\left|U_{\infty}^{\prime \prime}(y)\right| \\
\leq & C\left(F_{T}(N)\right) g(n)+\left(\sum_{j=1}^{T} J_{j}(N)\right) \operatorname{Rg}(n) L\left(F_{T}(N)\right) .
\end{aligned}
$$

This prove that $x_{n} \rightarrow x_{\infty}$ at the given rate $g(n)$ and by Lebesgue Theorem it holds also for $y_{n}$.

Proof of Theorem 2.17. Let $p$ be any accumulation point of the sequence $p_{n}(G, x)$ and let $n_{k}$ be a subsequence along which

$$
\lim _{k \rightarrow \infty} p_{n_{k}}(G, x)=p
$$

As $u_{\infty}^{\prime}$ is non decreasing by concavity (see Theorem 3.4), it is clear that

$$
\begin{aligned}
\left|u_{n_{k}}\left(G, x+p_{n_{k}}(G, x)\right)-u_{\infty}(G, x)\right| \leq \mid u_{n_{k}}\left(G, x+p_{n_{k}}(G, x)\right)- \\
-u_{\infty}\left(G, x+p_{n_{k}}(G, x)\right)\left|+\left|u_{\infty}\left(G, x+p_{n_{k}}(G, x)\right)-u_{\infty}(G, x+p)\right| .\right.
\end{aligned}
$$

The first term tends to 0 by Corollary 3.7 and the fact that $x+p_{n_{k}}(G, x) \in$ $\left[-|x|,|x|+\|G\|_{\infty}\right]$. The second one from the continuity of $u_{\infty}(G,$.$) and$ $p_{n_{k}}(G, x) \rightarrow p$. As by definition of $p_{n_{k}}(G, x)$,

$$
u_{n_{k}}\left(G, x+p_{n_{k}}(G, x)\right)=u_{n_{k}}(0, x),
$$

and we know from Corollary 3.7 that $u_{n_{k}}(0, x) \rightarrow u_{\infty}(0, x)$, we get that

$$
u_{\infty}(G, x+p)=u_{\infty}(0, x),
$$

and then necessarily $p=p_{\infty}(G, x)$, by definition.
