Principal eigenvalues and the Dirichlet problem for fully nonlinear elliptic operators

Abstract. We study uniformly elliptic fully nonlinear equations of the type $F(D^2u, Du, u, x) = f(x)$. We show that convex positively 1-homogeneous operators possess two principal eigenvalues and eigenfunctions, and study these objects; we obtain existence and uniqueness results for non-proper operators whose principal eigenvalues (in some cases, only one of them) are positive; finally, we obtain an existence result for non-proper Isaac's equations.

1 Introduction and Main Results

This paper is a contribution to the study of uniformly elliptic fully nonlinear equations in non-divergence form

$$F(D^2u, Du, u, x) = f(x)$$
 (1.1)

in a bounded domain $\Omega \subset \mathbb{R}^N$. We pursue the following goals. First, we show that positively homogeneous operators which are convex (or concave) - like Hamilton-Jacobi-Bellman operators, that is, suprema of linear operators with non-smooth coefficients - possess two principal eigenvalues, corresponding to a positive and a negative principal eigenfunction, and study properties of these objects. Second, we show that existence and uniqueness theory can be developed for coercive non-proper operators, more precisely, for operators whose both principal eigenvalues (or, in some cases, only one of them) are positive. Finally, we obtain existence results for the Dirichlet problem for non-proper operators which are not convex (like Isaac's equations, that is, sup-inf of linear operators), under the hypothesis that some related operator is coercive.

It has long been known that certain types of positively homogeneous operators possess "half"-eigenvalues. The first to observe this phenomenon was Berestycki in [Be], where he considered bifurcation for some Sturm-Liouville problems. An important step in studying these types of questions was made by Lions [L1]. By combining probability and analytical methods, in that paper he proved the existence of principal eigenvalues for operators which are the supremum of linear operators with $C^{1,1}$ -coefficients, and obtained results about the solvability of related Dirichlet problems. Recently the question of existence of principal eigenvalues was addressed in another particular case, namely when F is a Pucci extremal operator $(\mathcal{M}^+_{\lambda,\Lambda}(D^2u))$, see below), by Felmer and Quaas [FQ] (see also [BEQ], [Q]). Related results were obtained for operators of the type $|Du|^{\alpha}\mathcal{M}^+_{\lambda,\Lambda}(D^2u)$ by Birindelli and Demengel [BD1]. The results in all the quoted papers are partial in the sense that many known properties of the principal eigenvalue of a linear operator were left open. These properties include the facts that the eigenvalue is simple, isolated, and its positivity is necessary and sufficient for the operator to satisfy comparison principle, for the Alexandrov-Bakelman-Pucci inequality to hold, and guarantees that the Dirichlet problem be solvable for any right hand side. It is our aim here to bring the eigentheory of fully nonlinear equations closer to the level of the well studied linear case, for which we refer to the paper by Berestvcki, Nirenberg and Varadhan [BNV] - a deep study of properties of the principal eigenvalue of linear elliptic operators in non-divergence form, as well as of related maximum principles and existence theory for strong solutions of linear equations. The results we obtain extend most of the main results in [BNV] to nonlinear operators and viscosity solutions, and exhibit the differences and particularities due to the nonlinear nature of the operators we consider.

In the last thirty years there have been a multitude of results on existence, uniqueness and regularity properties of classical, strong or viscosity solutions of equations of type (1.1). For the classical case we refer to the works [L2], [E], [Bu], and to the books [K], [GT]. For strong solutions of linear equations, see [GT], Chapter 9. As far as viscosity solutions are concerned, we shall quote here the fundamental work [CIL], where very general equations are studied, as well as [CC], [CCKS], [CKLS], [JS], [S] (see also the references in these works), where a more specific - and close to ours - setting is considered. Typical structure conditions on F assumed in these papers are

(S)
$$\mathcal{M}^{-}_{\lambda,\Lambda}(M-N) - \gamma |p-q| \leq F(M,p,u,x) - F(N,q,u,x) \\ \leq \mathcal{M}^{+}_{\lambda,\Lambda}(M-N) + \gamma |p-q|,$$

for some positive constants λ, Λ, γ and any $M, N \in \mathcal{S}_N$ (the set of all $N \times N$ symmetric matrices), $p, q \in \mathbb{R}^N$, $u \in \mathbb{R}$, $x \in \Omega$, and

(P) F is proper, that is, F is nonincreasing in u.

Recall that Pucci's operators are defined by $\mathcal{M}^+_{\lambda,\Lambda}(M) = \sup_{A \in \mathcal{A}} \operatorname{tr}(AM)$, $\mathcal{M}^-_{\lambda,\Lambda}(M) = \inf_{A \in \mathcal{A}} \operatorname{tr}(AM)$, where $\mathcal{A} \subset \mathcal{S}_N$ denotes the set of matrices whose eigenvalues lie in the interval $[\lambda, \Lambda]$. Note $\mathcal{M}^+_{\lambda,\Lambda}(M) = -\mathcal{M}^-_{\lambda,\Lambda}(-M)$.

Condition (P) is too restrictive compared to what is known for linear operators. For instance, consider the linear operator $L = \operatorname{tr}(AD^2 \cdot) + c(x)$. It is well known that the Dirichlet problem for $Lu = f \in L^N$ is uniquely solvable provided $\lambda_1(L) > 0$. On the other hand, if $\operatorname{tr}(AD^2 \cdot)$ is replaced by a nonlinear operator satisfying (S), all the above quoted papers concern the case $c(x) \leq 0$. We will show that for a nonlinear operator the right hypothesis under which the Dirichlet problem is solvable for any right-hand side is again the positivity of the principal eigenvalues.

The paper is organized as follows. In the next section we give assumptions and define the principal eigenvalues. In Sections 1.2 and 1.3 we state our main results, about properties of principal eigenvalues and eigenfunctions, and about solvability of the Dirichlet problem. In Section 2 we give some important examples of operators to which our results apply, and discuss different situations that can arise. An intriguing difference between the two eigenvalues is put into light. Finally, in Section 3 we recall some previous results which we use, and in Section 4 we give the proofs of our results.

1.1 Assumptions and definition of λ_1^+, λ_1^-

The operator F is supposed to be defined on $\mathcal{S}_N \times \mathbb{R}^N \times \mathbb{R} \times (\Omega \setminus \mathcal{N})$, where $\mathcal{N} \subset \Omega$ is a null set.

Next, we assume that the operator is positively homogeneous of order 1, that is,

(H₀)
$$F(tM, tp, tu, x) = t F(M, p, u, x),$$
 for all $t \ge 0.$

Everywhere in the sequel we consider operators which satisfy the following hypothesis: for some $\gamma, \delta > 0$ and all $M, N \in \mathcal{S}_N, p, q \in \mathbb{R}^N, u, v \in \mathbb{R}, x \in \Omega$,

$$(H_1) \qquad \mathcal{M}^-_{\lambda,\Lambda}(M-N) - \gamma |p-q| \quad - \quad \delta |u-v| \le F(M,p,u,x) - F(N,q,v,x)$$
$$\le \quad \mathcal{M}^+_{\lambda,\Lambda}(M-N) + \gamma |p-q| + \delta |u-v|.$$

We are going to suppose that

(H₂) F(M, 0, 0, x) is continuous in $S_N \times \overline{\Omega}$.

Note that when F is linear $(H_1) - (H_2)$ mean F is uniformly elliptic, with bounded coefficients, and continuous second-order coefficients.

We denote

$$G(M, p, u, x) = -F(-M, -p, -u, x).$$

An important role will be played by the following definition. We say that an operator H(M, p, u, x) satisfies condition (D_F) provided

$$(D_F) \qquad \begin{array}{rcl} G(M-N,p-q,u-v,x) &\leq & H(M,p,u,x) - H(N,q,v,x) \\ &\leq & F(M-N,p-q,u-v,x). \end{array}$$

This hypothesis permits to measure how far an operator H is from linear the extremes of (D_F) are attained, on one hand, when F is linear (so that F = G and H(M, p, u, x) = F(M, p, u, x) + H(0, 0, 0, x)), and on the other hand, when $F(M, p, u, x) = \mathcal{M}^+_{\lambda,\Lambda}(M) + \gamma |p| + \delta |u|$ – then (D_F) reduces to (H_1) .

Lemma 1.1 Suppose F satisfies (H_0) . Then the following are equivalent (i) F is convex in (M, p, u); (ii) F satisfies (D_F) ;

(iii) F satisfies one of the two inequalities in (D_F) .

We shall assume that the domain Ω is smooth. We stress however that most results can be extended to arbitrary bounded domains, by using an approximation argument, as in [BNV], see Section 5.

We make the convention that each time we use the term viscosity solution we mean L^N -viscosity - see for example [CCKS] for definitions and properties of these. Also, any time we say a non-regular function satisfies an (in)equality, we shall mean it is satisfied in the viscosity sense.

For any $\lambda \in \mathbb{R}$ we define the sets

$$\begin{split} \Psi^+(F,\Omega,\lambda) &= \{\psi \in C(\overline{\Omega}) \mid \psi > 0 \ \text{ in } \Omega, \ F(D^2\psi,D\psi,\psi,x) + \lambda\psi \leq 0 \ \text{ in } \Omega \}, \\ \Psi^-(F,\Omega,\lambda) &= \{\psi \in C(\overline{\Omega}) \mid \psi < 0 \ \text{ in } \Omega, \ F(D^2\psi,D\psi,\psi,x) + \lambda\psi \geq 0 \ \text{ in } \Omega \}, \\ \text{and the following (finite, see Proposition 4.2) quantities} \end{split}$$

$$\begin{split} \lambda_1^+(F,\Omega) &= \sup \left\{ \lambda \mid \Psi^+(F,\Omega,\lambda) \neq \emptyset \right\},\\ \lambda_1^-(F,\Omega) &= \sup \left\{ \lambda \mid \Psi^-(F,\Omega,\lambda) \neq \emptyset \right\}. \end{split}$$

We shall not write the dependence of λ_1^+, λ_1^- in Ω or in F, when no confusion arises. Note that $\lambda_1^+(F) = \lambda_1^-(G)$ and $\lambda_1^-(F) = \lambda_1^+(G)$. Note also that $\lambda_1^+(F) \leq \lambda_1^-(F)$ since F is convex. We will show later that the sets Ψ in the definitions of λ_1^+, λ_1^- can be replaced by much smaller ones - see (4.16) and Proposition 4.11.

Next, we turn to the statements of our results. In order to facilitate the task of the reader acknowledged with the corresponding results for linear operators, we have adopted a way of exposing similar to the one in [BNV] – we believe this better highlights similarities and differences. It should be stressed however that our proofs, while borrowing some ideas from the linear case, require a different overall approach, and that essential points in the proofs are very nonlinear in nature. We give an overview in Section 4.

1.2 Existence and properties of eigenvalues

The following theorem asserts the existence of two couples of principal eigenfunctions and eigenvalues of a nonlinear operator. Set $E_p = W^{2,p}_{\text{loc}}(\Omega) \cap C(\overline{\Omega})$.

Theorem 1.1 Suppose F satisfies $(H_0), (H_1), (H_2)$, and (D_F) . Then there exist functions $\varphi_1^+, \varphi_1^- \in E_p$ for each $p < \infty$, such that

$$\begin{cases} F(D^{2}\varphi_{1}^{+}, D\varphi_{1}^{+}, \varphi_{1}^{+}, x) &= -\lambda_{1}^{+}\varphi_{1}^{+} & in \quad \Omega\\ \varphi_{1}^{+} &> 0 & in \quad \Omega\\ \varphi_{1}^{+} &= 0 & on \quad \partial\Omega_{2} \end{cases}$$

and

$$\left\{ \begin{array}{rrrr} F(D^2\varphi_1^-,D\varphi_1^-,\varphi_1^-,x)&=&-\lambda_1^-\varphi_1^- & in & \Omega\\ &\varphi_1^- &<& 0 & in & \Omega\\ &\varphi_1^- &=& 0 & on & \partial\Omega. \end{array} \right.$$

If φ_1^+ (or φ_1^-) is normalized so that $\varphi_1^+(x_0) = 1$ (resp. $\varphi_1^-(x_0) = -1$) for a fixed point $x_0 \in \Omega$, then $\varphi_1^+ \leq C$ (resp. $\varphi_1^- \geq -C$) in Ω , where C depends only on $x_0, \Omega, \lambda, \Lambda, \gamma$ and δ .

In addition, λ_1^+ (resp. λ_1^-) is the only eigenvalue corresponding to a positive (resp. negative) eigenfunction in $C(\overline{\Omega})$.

The next result implies that the principal eigenfunctions are simple in a strong sense, even in the set of viscosity solutions.

Theorem 1.2 Assume there exists a viscosity solution $u \in C(\overline{\Omega})$ of

$$\begin{cases} F(D^2u, Du, u, x) = -\lambda_1^+ u & in \quad \Omega\\ u = 0 & on \quad \partial\Omega \end{cases}$$
(1.2)

or of

$$\begin{cases} F(D^2u, Du, u, x) \geq -\lambda_1^+ u & in \quad \Omega\\ u(x_0) > 0, \quad u \leq 0 & on \quad \partial\Omega, \end{cases}$$
(1.3)

for some $x_0 \in \Omega$. Then $u \equiv t\varphi_1^+$, for some $t \in \mathbb{R}$. If a function $v \in C(\overline{\Omega})$ satisfies either (1.2) or the inverse inequalities in (1.3), with λ_1^+ replaced by λ_1^- , then $v \equiv t\varphi_1^-$ for some $t \in \mathbb{R}$.

Remark. Taking $u = \varphi_1^-$ shows $u(x_0) > 0$ cannot be removed from (1.3).

The following theorem states that the eigenvalues are isolated.

Theorem 1.3 There exists $\varepsilon_0 > 0$ depending on $p, N, \Omega, \lambda, \Lambda, \gamma, \delta$, such that the problem

$$\begin{cases} F(D^2u, Du, u, x) = -\lambda u & in \quad \Omega \\ u = 0 & on \quad \partial\Omega \end{cases}$$
(1.4)

has no solutions $u \neq 0$, for $\lambda \in (-\infty, \lambda_1^- + \varepsilon_0) \setminus \{\lambda_1^+, \lambda_1^-\}$.

It is an interesting question whether the two eigenvalues can coincide for truly nonlinear operators, and, when they do not, whether the eigenfunctions can or may not differ only by a multiplication by a constant. The answers are all affirmative, see Section 2.

The next theorem gives a necessary and sufficient condition for the positivity of the principal eigenvalues. It also shows that the existence of a positive viscosity supersolution implies the existence of a positive uniformly bounded (below, and in the global $W^{2,p}$ -norm) strong supersolution.

Theorem 1.4 (a) Assume there is a function $u \in C(\overline{\Omega})$ such that

$$\left\{\begin{array}{rrr} F(D^2u,Du,u,x) &\leq & 0 \quad in \quad \Omega \\ & u &> & 0 \quad in \quad \Omega, \end{array} \right. \quad resp. \left\{\begin{array}{rrr} F(D^2u,\ldots) &\geq & 0 \quad in \quad \Omega \\ & u &< & 0 \quad in \quad \Omega, \end{array}\right.$$

in the viscosity sense. Then either $\lambda_1^+ > 0$ or $\lambda_1^+ = 0$ and $u \equiv t\varphi_1^+$, for some t > 0 (resp. $\lambda_1^- > 0$ or $\lambda_1^- = 0$ and $u \equiv t\varphi_1^-$, for some t > 0).

(b) Conversely, if $\lambda_1^+ > 0$ then there exists a function $u \in W^{2,p}(\Omega)$, $p < \infty$, such that $F(D^2u, Du, u, x) \leq 0$, $u \geq 1$ in Ω , and $||u||_{W^{2,p}(\Omega)} \leq C$, where C depends on $p, N, \Omega, \lambda, \Lambda, \gamma, \delta$, and λ_1^+ .

Remark 1. When F is proper, $u \equiv 1$ satisfies the condition of Theorem 1.4. Hence proper operators have positive eigenvalues.

Remark 2. Propositions 4.2 and 4.8 provide upper and lower bounds (in terms of F and Ω) for λ_1^+ and λ_1^- .

Remark 3. It follows from Theorem 1.4 that the eigenvalues are strictly decreasing with respect to the domain : if $\Omega \subsetneq \Omega'$ then $\lambda_1^+(\Omega) > \lambda_1^+(\Omega')$ and $\lambda_1^-(\Omega) > \lambda_1^-(\Omega')$ (take $u = \varphi_1^+(\Omega')$ in Theorem 1.4). Note that λ_1^+ and λ_1^- are continuous with respect to the domain, as Proposition 4.10 shows.

Further, we show that, similarly to the linear case, the positivity of the principal eigenvalues is a necessary and sufficient condition for the operator to satisfy a comparison principle. We say that a second order operator H satisfies a *comparison principle* (CP), provided for any $u, v \in C(\overline{\Omega})$, one of which is in E_N , such that

$$\left\{ \begin{array}{rrrr} H(D^2u,Du,u,x) &\geq & H(D^2v,Dv,v,x) & \text{in} & \Omega \\ & u &\leq & v & & \text{on} & \partial\Omega, \end{array} \right.$$

we have $u \leq v$ in Ω . A particular case of (CP) is the maximum principle, when one of u, v is set to zero (and $H(0, 0, 0, x) \equiv 0$, as we always assume).

Theorem 1.5 Suppose a second-order operator F satisfies $(H_0), (H_1), (H_2)$, and (D_F) . Then $\lambda_1^+(F) > 0$ is necessary and sufficient for F to satisfy (CP). Hence, if a second-order operator H satisfies (D_F) , then $\lambda_1^+(F) > 0$ is sufficient for H to satisfy (CP). If $\lambda_1^- > 0$, the comparison and even the maximum principle do not necessarily hold. However, it can be shown that $\lambda_1^- > 0$ is necessary and sufficient for a *one-sided* maximum principle.

Theorem 1.6 Suppose a second-order operator F satisfies $(H_0), (H_1), (H_2)$, and (D_F) . Then F has the following property : for any $u \in C(\overline{\Omega})$,

 $\left\{ \begin{array}{rrrr} F(D^2u,Du,u,x) &\leq & 0 & in & \Omega \\ & u &\geq & 0 & on & \partial\Omega \end{array} \qquad implies \ u \geq 0 \ in \ \Omega, \end{array} \right.$

if and only if $\lambda_1^-(F) > 0$.

Finally, we have the following Alexandrov-Bakelman-Pucci (ABP) inequality for nonproper second order operators. The ABP inequality is an essential tool in studying non-divergence form equations - see [GT], [BNV], [CCKS] for discussions.

Theorem 1.7 Suppose the operator F satisfies $(H_0), (H_1), (H_2), and <math>(D_F)$. Then for any $u \in C(\overline{\Omega}), f \in L^N(\Omega)$, the inequalities $F(D^2u, Du, u, x) \ge f$, $\lambda_1^+(F) > 0$ (resp. $F(D^2u, Du, u, x) \le f$, $\lambda_1^-(F) > 0$) imply

$$\sup_{\Omega} u \le C(\sup_{\partial\Omega} u^+ + \|f^-\|_{L^N(\Omega)}), \ \left(\text{resp. } \sup_{\Omega} u^- \le C(\sup_{\partial\Omega} u^- + \|f^+\|_{L^N(\Omega)})\right).$$

where C depends on Ω , N, λ , Λ , γ , δ , and $\lambda_1^+(F)$ (resp. $\lambda_1^-(F)$).

1.3 The Dirichlet problem

We will show that the Dirichlet problem for our type of operators is solvable for any right-hand side if the eigenvalues of the operator are positive, and that the Dirichlet problem may not be solvable if only one of them is positive.

Theorem 1.8 Suppose F satisfies $(H_0), (H_1), (H_2)$, and (D_F) . If $\lambda_1^+(F) > 0$ then for any $f \in L^p(\Omega), p \ge N$, there exists an unique solution $u \in E_p$ of

$$\begin{cases} F(D^2u, Du, u, x) = f & in \quad \Omega\\ u = 0 & on \quad \partial\Omega, \end{cases}$$
(1.5)

In addition, for any compact set $\omega \subset \subset \Omega$ there holds

$$||u||_{W^{2,p}(\omega)} \le C ||f||_{L^p(\Omega)},$$

where C depends on $p, \omega, \Omega, \lambda, \Lambda, \gamma, \delta$, and $\lambda_1^+(F)$.

On the other hand, if $\lambda_1^+(F) = 0$ or $\lambda_1^-(F) > 0 \ge \lambda_1^+(F)$ then problem (1.5) does not possess a solution in $C(\overline{\Omega})$, provided $f \le 0, f \ne 0$ in Ω .

Remark. In [Bu] Busca showed (through different techniques) the existence of a unique classical solution of the Dirichlet problem in the particular case when F is a supremum of a countable family of linear operators with Hölder continuous coefficients and uniformly positive first eigenvalues. This uniform positivity turns out to be equivalent to $\lambda_1^+ > 0$, as our results show (see the next section).

As Theorem 1.8 shows, if only one of the two eigenvalues is positive, the Dirichlet problem may not have a solution. However, it still does provided the right-hand side is nonnegative.

Theorem 1.9 Suppose F satisfies $(H_0), (H_1), (H_2), (D_F)$. If $\lambda_1^-(F) > 0$ then for any $f \in L^p(\Omega), p \ge N$, such that $f \ge 0$ in Ω , there exists a nonpositive solution $u \in E_p$ of (1.5).

Remark. We do not know if the solution obtained in Theorem 1.9 is unique.

As is known, the problem of solvability and uniqueness for the Dirichlet problem for non-convex operators is quite complicated. The following existence result, applicable to Isaac's operators, completes (and uses) some recent results for proper operators, obtained in [CKLS] (see also [JS]). It says an Isaac's equation is solvable provided the operator is controlled, in the sense of (D_F) , by an operator with positive eigenvalues.

Theorem 1.10 Assume F satisfies $(H_0), (H_1), (H_2), (D_F)$, and H satisfies (D_F) and (H_0) . If $\lambda_1^+(F) > 0$ then the problem

$$\left\{ \begin{array}{rcl} H(D^2u,Du,u,x) &=& f \quad in \quad \Omega \\ u &=& 0 \quad on \quad \partial\Omega \end{array} \right.$$

is solvable in the viscosity sense for any $f \in L^p(\Omega), p \ge N$. If H(M, p, u, x) is convex in M then $u \in E_p$, and u is unique.

2 Examples and Discussion

We have proved the existence of principal eigenvalues of Hamilton-Jacobi-Bellman operators

$$F_{HJB}(D^2u, Du, u, x) = \sup_{\alpha \in \mathcal{A}} L_x^{\alpha} u, \quad \text{with}$$
$$L_x^{\alpha} u := \operatorname{tr} \left(A^{\alpha}(x) D^2 u \right) + \vec{b}^{\alpha}(x) D u + c^{\alpha}(x) u,$$

where \mathcal{A} is an arbitrary index set, $A^{\alpha}(x)$ are matrices which depend continuously on x and such that $\lambda I \leq A^{\alpha}(x) \leq \Lambda I$, and $\vec{b}^{\alpha} : \mathbb{R}^N \to \mathbb{R}^N, c^{\alpha} : \mathbb{R}^N \to \mathbb{R}$ are measurable bounded (uniformly in α) functions.

Note that the question of existence and uniqueness of solutions of Hamilton-Jacobi-Bellman equations is often set in the form : given a family of linear operators as above and a family of continuous functions f^{α} , solve

$$\sup_{\alpha \in \mathcal{A}} \left(\operatorname{tr} \left(A^{\alpha}(x) D^{2} u \right) + \vec{b}^{\alpha}(x) D u + c^{\alpha}(x) u - f^{\alpha}(x) \right) = 0.$$

This equation is in the form $H(D^2u, Du, u, x) = f(x)$, where

$$H(D^{2}u, Du, u, x) = \sup_{\alpha \in \mathcal{A}} \left(L_{x}^{\alpha}u - f^{\alpha}(x) \right) + \inf_{\alpha \in \mathcal{A}} f^{\alpha}(x), \qquad f(x) = \inf_{\alpha \in \mathcal{A}} f^{\alpha}(x).$$

This H is convex in (M, p, u) and satisfies $(D_{F_{HJB}})$, so the results of the previous section apply.

It easily follows from the definitions of the eigenvalues that

$$\lambda_1^+(F_{HJB}) \le \inf_{\alpha \in \mathcal{A}} \lambda_1(L_x^\alpha) \le \sup_{\alpha \in \mathcal{A}} \lambda_1(L_x^\alpha) \le \lambda_1^-(F_{HJB}), \tag{2.6}$$

where $\lambda_1(L_x^{\alpha})$ denotes the usual first eigenvalue of the linear operator L_x^{α} . One should clearly ask whether the first and the third inequalities in (2.6) are actually equalities.

As far as the first inequality is concerned, it actually is an equality when the set \mathcal{A} is countable, since then it is possible to show that the Dirichlet problem for F_{HJB} is uniquely solvable for any right-hand side (through an argument similar to the one in [Bu]), provided $\inf_{\alpha \in \mathcal{A}} \lambda_1(L_x^{\alpha}) > 0$. Then, if the first inequality in (2.6) were strict, the operators $\widetilde{L}_x^{\alpha} = L_x^{\alpha} + \lambda_1^+(F_{HJB})$ have uniformly positive eigenvalues but $\sup_{\alpha \in \mathcal{A}} \widetilde{L}_x^{\alpha} u = 0$ has two solutions which vanish on $\partial\Omega$, the trivial one and φ_1^+ given by Theorem 1.1 – a contradiction. Further, it is clear that the Dirichlet problem for F_{HJB} remains solvable under $\inf_{\alpha \in \mathcal{A}} \lambda_1(L_x^{\alpha}) > 0$, when \mathcal{A} is a separable metric space such that the maps $\alpha \to A^{\alpha}, \vec{b}^{\alpha}, c^{\alpha}$ are continuous for almost every x (a similar remark is made in [GT], after Theorem 17.18). This implies, for instance, that

$$\lambda_1^+(\mathcal{M}_{\lambda,\Lambda}^+) = \inf_{\lambda I \le A \le \Lambda I} \lambda_1 \left(\operatorname{tr} \left(A D^2 \cdot \right) \right),$$

the infimum being taken over *constant* matrices, and not over functions (as was stated in [BEQ]), which is what the mere fact that the infimum is attained suggests.

Surprisingly, it turns out that an analogous intuitive statement about the third inequality in (2.6) is wrong, as we shall show next.

First, note that $\lambda_1^+ = \lambda_1^-$ is possible for truly nonlinear operators. An explicit example is, for instance, $\Omega = (0, \pi) \times (0, \pi) \subset \mathbb{R}^2$, and

$$F_{a,b}(D^2u) = \max\left\{au_{x_1x_1} + bu_{x_2x_2}, bu_{x_1x_1} + au_{x_2x_2}\right\}, \qquad a, b > 0, \ a \neq b,$$

where $\varphi_1^+ = -\varphi_1^- = \sin(x_1)\sin(x_2)$, and $\lambda_1^+(F_{a,b}) = \lambda_1^-(F_{a,b}) = a + b$.

Further, Theorem 1.2 (with $u = -\varphi_1^-$) easily implies that $\varphi_1^+ = -\varphi_1^$ after renormalization, whenever $\lambda_1^+ = \lambda_1^-$. Let us now look at the same operator $F_{a,b}(D^2u) = \max\{L_1u, L_2u\}$, but on a ball $B \subset \mathbb{R}^2$. A simple symmetry argument shows $\lambda_1(L_1, B) = \lambda_1(L_2, B)$, so, by what we already saw, $\lambda_1^+(F_{a,b})$ is equal to $\lambda_1(L_1)$. However, $\lambda_1^-(F_{a,b})$ is strictly larger than $\lambda_1(L_1) = \lambda_1(L_2)$. Indeed, suppose for contradiction $\lambda_1^- = \lambda_1(L_1) = \lambda_1^+ =: \lambda$. Then the principal eigenfunction $\varphi := \varphi_1^+ = -\varphi_1^-$ of $F_{a,b}$ would satisfy

$$\begin{cases} F_{a,b}(D^2\varphi) + \lambda\varphi = 0 & \text{in } B, \\ G_{a,b}(D^2\varphi) + \lambda\varphi = 0 & \text{in } B, \end{cases}$$
(2.7)

By adding up the two equations in (2.7) we see that φ is the principal eigenfunction of the Laplacian, and so φ is smooth and radial. It also follows from (2.7) that $F_{a,b}(D^2\varphi) = G_{a,b}(D^2\varphi)$ in B, which means $\varphi_{x_1x_1} \equiv \varphi_{x_2x_2}$. The only smooth radial functions which satisfy this are $C_1|x|^2 + C_2$ – a contradiction.

We shall now see it is possible that the first eigenfunctions be the same or different when $\lambda_1^+ \neq \lambda_1^-$. An example when $\lambda_1^+ \neq \lambda_1^-$ and $\varphi_1^+ = -\varphi_1^-$ is provided by the operator

$$F_a(D^2u) = \max\{\Delta u, \, a\Delta u\}, \qquad a > 0, \, a \neq 1.$$

Then $\varphi_1^+ = -\varphi_1^-$ is the usual first eigenfunction of the Laplacian, however $\lambda_1^+ = \min\{\lambda_1, a\lambda_1\} < \max\{\lambda_1, a\lambda_1\} = \lambda_1^-$, where λ_1 is the first eigenvalue of the Laplacian. Note that the spectrum of F_a is actually the so-called Fucik spectrum of the Laplacian.

Finally, we note that $\mathcal{M}^+_{\lambda,\Lambda}$ is an operator for which φ_1^+ and φ_1^- are not proportional, for instance when Ω is a ball. Indeed, suppose for contradiction that $\varphi \in E_p(B)$ is a function such that $\varphi > 0$ in $B, \varphi = 0$ on ∂B , and

$$\begin{cases} \mathcal{M}^{+}_{\lambda,\Lambda}(D^{2}\varphi) + \lambda^{+}_{1}\varphi = 0 & \text{in } B, \\ \mathcal{M}^{-}_{\lambda,\Lambda}(D^{2}\varphi) + \lambda^{-}_{1}\varphi = 0 & \text{in } B, \end{cases}$$
(2.8)

for some ball B. By summing these two equations we obtain

$$(\lambda + \Lambda)\Delta\varphi + (\lambda_1^+ + \lambda_1^-)\varphi = 0 \quad \text{in } B, \qquad (2.9)$$

so φ is the first (radial and smooth) eigenfunction of the Laplacian.

We recall that $\mathcal{M}^+_{\lambda,\Lambda}(M) = \Lambda \sum_{\{e_i > 0\}} e_i + \lambda \sum_{\{e_i < 0\}} e_i$, where e_i denote the eigenvalues of M, for any $M \in \mathcal{S}_N$. This, together with the fact that φ

eigenvalues of M, for any $M \in S_N$. This, together with the fact that φ attains its maximum at the origin, imply $\mathcal{M}^+_{\lambda,\Lambda}(D^2\varphi(0)) = \lambda \Delta \varphi(0)$. It then

follows from the first equation in (2.8) that $\frac{\lambda_1^+}{\lambda} = \lambda_1$, where λ_1 is the first eigenvalue of the Laplacian.

Therefore the first equation in (2.8) reads $\mathcal{M}^+_{\lambda,\Lambda}(D^2\varphi) - \lambda\Delta\varphi = 0$ in B, or

$$\Lambda \sum_{\{e_i(x)>0\}} e_i(x) + \lambda \sum_{\{e_i(x)<0\}} e_i(x) - \lambda \sum_{i=1}^{N} e_i(x) \equiv 0 \quad \text{in } B,$$

where $e_i(x)$ denote the eigenvalues of $D^2\varphi(x)$. Hence $e_i(x) \leq 0$ in B, for all $i = 1, \ldots, N$.

However, by writing (2.9) in the radial variable and by using Hopf's lemma, it is easy to see that $D^2\varphi(x)$ has a positive eigenvalue in a neighbourhood of $\partial\Omega$ (see also Lemma 4.1). This is a contradiction.

Naturally, given some positive constants $\lambda, \Lambda, \gamma, \delta$, our results apply to the extremal operator

$$F_e(D^2u, Du, u) = \mathcal{M}^+_{\lambda, \Lambda}(D^2u) + \gamma |Du| + \delta |u|,$$

and hence all results concerning maximum principles and existence for the Dirichlet problem apply to operators H satisfying (D_{F_e}) , that is, (H_1) . In particular, our results give an ABP inequality and existence results for Isaacs operators

$$\inf_{\beta \in \mathcal{B}} \sup_{\alpha \in \mathcal{A}} \left\{ \operatorname{tr} \left(A^{\alpha,\beta}(x) D^2 u \right) + \vec{b}^{\alpha,\beta}(x) . Du + c^{\alpha,\beta}(x) u \right\},\$$

under a more general hypothesis than $c^{\alpha,\beta}(x) \leq 0$, which was considered in previous works (see for example [CIL], [CKLS] and the references in these papers).

An interesting particular case is obtained by setting $\lambda = \Lambda = 1$, in other words, $\mathcal{M}^+_{\lambda,\Lambda}(D^2u) = \Delta u$ in F_e . In a very recent work Hamel, Nadirashvili and Russ considered (among other things) the operator $\Delta u + |Du|$, showed it has two eigenvalues and proved that the domain which minimizes the eigenvalue $\lambda_1^+(\Delta + |D \cdot |, \Omega)$ on the set of all smooth domains with fixed measure is the ball. Their result depends on the fact that the second-order operator is the Laplacian. It is a very interesting open question to prove that the same holds for more general second-order operators, for example, to prove that $\lambda_1^+(\mathcal{M}^+_{\lambda,\Lambda}, \Omega)$ is minimized when Ω is a ball. The analogous question for λ_1^- is completely open.

3 Some known results

In this section we recall some results for proper uniformly elliptic equations.

We start with the Alexandrov-Bakelman-Pucci estimate for viscosity solutions, see Proposition 3.3 in [CCKS].

Theorem 3.1 (ABP) Let $f \in L^{N}(\Omega)$. If $u \in C(\overline{\Omega})$ is a L^{N} -viscosity solution of

$$\mathcal{M}^+_{\lambda,\Lambda}(D^2u) + \gamma |Du| \ge f \quad in \quad \{u > 0\},$$

then there exists a constant B depending on $N, \lambda, \Lambda, \gamma$, and $diam(\Omega)$, such that

$$\sup_{\Omega} u \le \sup_{\partial \Omega} u^+ + B \|f^-\|_{L^N(\Omega)}.$$
(3.10)

Similarly, if u is a L^N -viscosity solution of $\mathcal{M}^-_{\lambda,\Lambda}(D^2u) - \gamma |Du| \leq f$ in $\{u < 0\}$, then

$$\sup_{\Omega} u^{-} \leq \sup_{\partial \Omega} u^{-} + B \| f^{+} \|_{L^{N}(\Omega)}.$$
(3.11)

Hence if F satisfies conditions (S) and (P) from the introduction, then $F(D^2u, Du, u, x) \ge f$ implies (3.10), and $F(D^2u, Du, u, x) \le f$ implies (3.11).

Theorem 3.1 implies a comparison result (Theorem 2.10 in [CCKS]).

Theorem 3.2 Suppose H satisfies (D_F) and F satisfies $(H_1), (H_2)$, and (P). If $u, v \in C(\overline{\Omega})$ are L^N -viscosity solutions of

$$\left\{ \begin{array}{rrr} H(D^2u,Du,u,x) &\geq & H(D^2v,Dv,v,x) & \quad in \quad \Omega, \\ & u &\leq & v & \quad on \quad \partial\Omega, \end{array} \right.$$

and one of u, v is in E_N , then $u \leq v$ in Ω .

Now we give a regularity result, which will be needed in the sequel.

Theorem 3.3 Suppose F satisfies (H_0) , (H_1) , (H_2) , and F(M, p, u, x) is convex in M. If $u \in C(\overline{\Omega})$ is a viscosity solution of

$$F(D^2u, Du, u, x) = f \quad in \quad \Omega$$

and $f \in L^p(\Omega)$, $p \geq N$, then $u \in W^{2,p}_{loc}(\Omega)$, and for every $\Omega' \subset \subset \Omega$

$$||u||_{W^{2,p}(\Omega')} \le C \left(||u||_{L^{\infty}(\Omega)} + ||f||_{L^{p}(\Omega)} \right),$$

where C depends on $dist(\Omega', \partial\Omega)$, $diam(\Omega)$, $p, N, \lambda, \Lambda, \gamma, \delta$.

Proof. In case F is proper (satisfies (P)), this follows from Theorem 3.1 in [S] (see also the discussion in Sections 8-9 in [CKS]). If F is not proper, by (H_1) the operator $F(D^2u, Du, u, x) - \delta u$ is proper. By applying Theorem 3.1 in [S] to $F(D^2u, Du, u, x) - \delta u = f - \delta u$ we conclude.

Theorem 3.4 Suppose F satisfies (H_0) , (H_1) , (H_2) , (P), and F(M, p, u, x) is convex in M. Then, for any $f \in L^p(\Omega)$, $p \ge N$, there exists a unique solution $u \in E_p$ of

$$\left\{ \begin{array}{rrrr} F(D^2u,Du,u,x) &=& f & \quad in \quad \Omega, \\ u &=& 0 & \quad on \quad \partial\Omega. \end{array} \right.$$

Proof. This is again a consequence of Theorem 3.1 in [S].

Next, we recall the following maximum principle in small domains.

Theorem 3.5 Suppose H satisfies (D_F) , and F satisfies (H_1) and (H_2) . Then there exists $\varepsilon_0 > 0$, depending on $N, \lambda, \Lambda, \gamma, \delta$, and $diam(\Omega)$, such that if $|\Omega| \leq \varepsilon_0$ then for any $u \in C(\overline{\Omega})$

$$\left\{ \begin{array}{rrrr} H(D^2u,Du,u,x) &\leq & 0 & \quad in \quad \Omega, \\ u &\geq & 0 & \quad on \quad \partial\Omega \end{array} \right.$$

implies $u \geq 0$ in Ω .

Proof. By (H_1) *u* satisfies

$$\mathcal{M}^{-}_{\lambda,\Lambda}(D^2u) - \gamma |Du| \le \delta |u| = \delta u^{-} \quad \text{in} \quad \{u < 0\}.$$

Then we use Theorem 3.1 to conclude, in a standard way.

We shall need the following version of Hopf's boundary lemma.

Lemma 3.1 Let Ω be a regular domain and let $u \in E_N$, $u \neq 0$, be a nonnegative solution to

$$\mathcal{M}^{-}_{\lambda,\Lambda}(D^2u) - \gamma |Du| - \delta u \leq 0 \quad in \quad \Omega, \\ u = 0 \quad on \quad \partial\Omega,$$
(3.12)

with $\gamma, \delta \in \mathbb{R}$. Then u > 0 in Ω . Moreover, for each $x_0 \in \partial \Omega$

$$\limsup_{x \to x_0} \frac{u(x_0) - u(x)}{|x - x_0|} < 0,$$

where the limit is taken over the set of x for which the angle between $x - x_0$ and the outer normal at x_0 is less than $\pi/2 - \alpha$ for some fixed $\alpha > 0$.

Remark. For a general strong maximum principle for degenerate convex elliptic operators, see the paper of M. Bardi, F. Da Lio [BD].

We recall next the following Harnack inequality.

Theorem 3.6 Let $u \in C(\overline{\Omega})$ and $f \in L^N(\Omega)$ satisfy $u \ge 0$ in Ω and

$$\mathcal{M}^{+}_{\lambda,\Lambda}(D^{2}u) + \gamma |Du| + \delta u \ge f \quad in \quad \Omega,$$
(3.13)

$$\mathcal{M}^{-}_{\lambda,\Lambda}(D^2u) - \gamma |Du| - \delta u \le f \quad in \quad \Omega.$$
(3.14)

Then for any compact set $K \subset \Omega$

$$\sup_{K} u \le C\{\inf_{K} u + \|f\|_{L^{N}(\Omega)}\},\$$

where C is a constant depending only on K, Ω , N, Λ , λ , γ and δ .

Proof. First, inequality (3.14) implies the so-called weak Harnack inequality - this was proved by Wang in [W], see also [CC], [CKS] for related results. The fact that inequality (3.13) implies the local maximum principle (see for example [GT], Chapter 9, for the terminology) was proved by Wang in the proper case ($\delta = 0$), and was extended to $\delta > 0$ in [BS] - see pages 560-562 of that paper.

4 Proofs of the main results

We shall first give an overview of the proofs and list some of the main points in them.

After some preliminary results concerning simplicity and bounds on eventual eigenvalues, we define a class of nonproper operators (in particular those with $\tilde{\lambda}_1^+ > 0$, see below), such that one can get comparison results for equations involving these operators through relating them to proper equations and using the results quoted in the previous section. Then the sub- and supersolution method allows us to prove existence and uniqueness results for these equations, which in turn implies, via Krein-Rutman theory, that operators with $\widetilde{\lambda}_1^+ > 0$ have two eigenvalues (equal to λ_1^+, λ_1^-). The next step is to observe that λ_1^+, λ_1^- do not change if one takes only functions $\psi \in E_p$ in the definition of Ψ^+, Ψ^- , and then to prove Theorem 1.1, through an approximation procedure in subdomains of Ω . The final quite delicate points are, on one hand, to bridge the gap between λ_1^+ and λ_1^+ , and on the other hand, to show Theorem 1.4 (b) with the right dependence of the constant bounding the C^1 -norm of the supersolution obtained in it. This is accomplished in the key Proposition 4.12, which permits to us to relate our Theorems 1.5-1.10 to corresponding results for proper equations.

4.1 Some preliminary results

We start with the trivial proof of Lemma 1.1. **Proof of Lemma 1.1.** Suppose $f : \mathbb{R}^{N^2+N+1} \to \mathbb{R}$ is such that f(tx) = tf(x)for all $t \ge 0$. First, f is convex if and only if

 $f(y_1) - f(y_2) \le f(y_1 - y_2)$ for all $y_1, y_2 \in \mathbb{R}^{N^2 + N + 1}$ (*).

Indeed, if f is convex then

$$f(y_1) = 2f(\frac{y_1 - y_2 + y_2}{2}) \le f(y_1 - y_2) + f(y_2).$$

Whereas if f satisfies (*), then for any $\alpha \in [0, 1]$

$$f(\alpha y_1 + (1 - \alpha)y_2) - \alpha f(y_1) = f(\alpha y_1 + (1 - \alpha)y_2) - f(\alpha y_1) \\ \leq f((1 - \alpha)y_2) = (1 - \alpha)f(y_2),$$

so f is convex.

Define g(y) = -f(-y); we have from (*) that

$$g(y_1 - y_2) = -f(y_2 - y_1) \le f(y_1) - f(y_2),$$

and the lemma follows.

Everywhere in the sequel F will denote an operator which satisfies (H_0) , (H_1) , (H_2) , and (D_F) .

The following theorem will be used several times.

Theorem 4.1 Suppose $u, v \in C(\overline{\Omega})$ are viscosity solutions of

$$\left\{\begin{array}{rrrr} F(D^2u,Du,u,x) &\leq & 0 & in & \Omega \\ & u &> & 0 & in & \Omega, \end{array} \right. \quad resp. \quad \left\{\begin{array}{rrrr} F(D^2u,\ldots) &\geq & 0 & in & \Omega \\ & u &< & 0 & in & \Omega \end{array}\right.$$

and

$$\left\{\begin{array}{rrrr} F(D^2v,Dv,v,x)&\geq &0 ∈ &\Omega\\ &v&\leq &0 &on &\partial\Omega &resp. \\ &v(x_0)&> &0, \end{array}\right. \left\{\begin{array}{rrrr} F(D^2v,\ldots)&\leq &0 ∈ &\Omega\\ &v&\geq &0 &on &\partial\Omega\\ &v(x_0)&< &0, \end{array}\right.$$

for some point $x_0 \in \Omega$, where F satisfies $(H_0), (H_1), (H_2)$, and (D_F) . Suppose one of u, v is in E_N . Then $u \equiv tv$ for some t > 0.

Proof. Let u, v satisfy the first set of inequalities in Theorem 4.1. We suppose first that both $u, v \in E_N$. Theorem 4.1 is proved via a variant of a rather typical argument, used for example in the linear setting in [BNV].

Take a compact set $K \subset \Omega$ such that $|\Omega \setminus K| \leq \varepsilon_0$, where ε_0 is given in Theorem 3.5. Set $z_t = v - tu$. If t is large enough $z_t < 0$ in K. By (D_F) and (H_0) , we have for all $t \geq 0$

$$F(D^{2}z_{t}, Dz_{t}, z_{t}, x) \ge F(D^{2}v, Dv, v, x) - tF(D^{2}u, Du, u, x) \ge 0$$
(4.15)

in Ω . Since $z_t \leq 0$ on $\partial(\Omega \setminus K)$, by using Theorem 3.5 we get $z_t \leq 0$ in $\Omega \setminus K$. So, by Hopf's Lemma (Lemma 3.1), either $z_t \equiv 0$ in Ω in which case we are done, or $z_t < 0$ in Ω . We define

$$\tau = \inf\{t \mid z_t < 0 \quad \text{in} \quad \Omega\}.$$

Since $v(x_0) > 0$ we have $\tau > 0$. Now we repeat the same argument for z_{τ} . So, either $z_{\tau} \equiv 0$ in Ω in which case we are done, or $z_{\tau} < 0$ in Ω . In this case there exists $\eta > 0$ such that $z_{\tau-\eta} < 0$ in K. Now we repeat again the same argument for $z_{\tau-\eta}$, which yields a contradiction with the definition of τ .

If the inequalities satisfied by u, v are reversed (second set of inequalities in Theorem 4.1), we consider the function tu - v and use the same argument.

In case one of the functions, say v, is only in $C(\overline{\Omega})$, exactly the same argument applies, since (4.15) holds. This is very standard - if ψ is a test function for z_t , then $\psi + tu$ is a test function for v, and vice versa.

Corollary 4.1 If $\mu, \nu \in \mathbb{R}$ and $u, v \in C(\overline{\Omega})$ are such that

$$\begin{cases} F(D^2u,\ldots) = \mu u & in \ \Omega \\ u > 0 & in \ \Omega \\ u = 0 & on \ \partial\Omega \end{cases} \quad and \quad \begin{cases} F(D^2v,\ldots) = \nu v & in \ \Omega \\ v > 0 & in \ \Omega \\ v = 0 & on \ \partial\Omega, \end{cases}$$

and one of u, v is in E_N , then $\mu = \nu$ and u = tv for some t > 0. The same is valid if both functions are negative instead of positive.

Proof. Suppose $\mu \leq \nu$. Then use Theorem 4.1 with $F(D^2u, Du, u, x)$ replaced by $F(D^2u, Du, u, x) - \mu u$.

Another consequence of Theorem 4.1 is an upper bound of the eigenvalues in terms of the "thickness" of the domain. Before stating it, we recall the following simple fact.

Lemma 4.1 Suppose $u \in C^2(B)$ is a radial function, defined on a ball B, say u(x) = g(|x|). Then the matrix $D^2u(x)$ has g''(|x|) as a simple eigenvalue, and $|x|^{-1}g'(|x|)$ as an eigenvalue of multiplicity N - 1.

Proposition 4.1 Suppose Ω contains a ball B_{2R} , with $R \leq 1$. Then

$$\lambda_1^+(F,\Omega) \le \lambda_1^-(F,\Omega) \le \frac{C}{R^2},$$

where C depends on $N, \lambda, \Lambda, \gamma, \delta$.

Proof. Clearly $\lambda_1^-(\Omega) \leq \lambda_1^-(B_R)$. We set $\sigma(x) = -\frac{1}{4}(|x|^2 - R^2)^2$, $\sigma < 0$ in B_R (this comparison function appears in many other works). Then we have $|D\sigma| \leq |x|(R^2 - |x|^2)$ and the eigenvalues of $D^2\sigma$ are $R^2 - |x|^2$ and $R^2 - 3|x|^2$. By (H_1) ,

$$F(D^{2}\sigma, D\sigma, \sigma, x) \leq \mathcal{M}^{+}_{\lambda, \Lambda}(D^{2}\sigma) + \gamma |D\sigma| + \delta |\sigma|,$$

so, through an easy computation,

$$F(D^2\sigma, D\sigma, \sigma, x) \leq -\frac{C_0}{R^2}\sigma$$

in B_R , where C_0 depends on $N, \lambda, \Lambda, \gamma, \delta$. To get this, we use the previous lemma and the fact that $\mathcal{M}^+_{\lambda,\Lambda}(M) = \Lambda \sum_{\{e_i > 0\}} e_i + \lambda \sum_{\{e_i < 0\}} e_i$, where e_i denote

the eigenvalues of M.

Suppose now there exists $\lambda \in \mathbb{R}, \psi \in C(\overline{\Omega})$ such that $\psi < 0$ in Ω , $F(D^2\psi, D\psi, \psi, x) + \lambda\psi \geq 0$, and $\lambda > \frac{C_0}{R^2}$. By applying Theorem 4.1 with F replaced by $F(D^2u, Du, u, x) + \frac{C_0}{R^2}u$ and Ω replaced by B_R , we get $\psi = t\sigma$ in B_R , a contradiction with $\sigma = 0, \psi < 0$ on ∂B_R .

Next, for any $\lambda \in \mathbb{R}$ we define the sets

$$\widetilde{\Psi}^{+}(F,\Omega,\lambda) = \{ \psi \mid \psi \in W^{2,p}(\Omega) \quad \forall p < \infty, \quad \inf_{\Omega} \psi = 1, \\ \text{and} \quad F(D^{2}\psi, D\psi, \psi, x) + \lambda\psi \le 0 \quad \text{in } \Omega \},$$

$$\begin{split} \widetilde{\Psi}^{-}(F,\Omega,\lambda) &= \{ \psi \mid \psi \in W^{2,p}(\Omega) \ \forall \, p < \infty \,, \quad \sup_{\Omega} \psi = -1, \\ & \text{and} \ F(D^{2}\psi, D\psi, \psi, x) + \lambda \psi \geq 0 \ \text{in} \ \Omega \, \} \end{split}$$

(note these sets contain functions which are regular up to $\partial\Omega$), and the following quantities

$$\widetilde{\lambda}_{1}^{+}(F,\Omega) = \sup \left\{ \lambda \mid \widetilde{\Psi}^{+}(F,\Omega,\lambda) \neq \emptyset \right\},$$

$$\widetilde{\lambda}_{1}^{-}(F,\Omega) = \sup \left\{ \lambda \mid \widetilde{\Psi}^{-}(F,\Omega,\lambda) \neq \emptyset \right\}.$$
(4.16)

By using these definitions and by setting $\psi \equiv 1$ in (4.16), we obtain the following bounds.

Proposition 4.2 We have $\widetilde{\lambda}_1^- \leq \lambda_1^-$ and

$$-\delta \le -\|c\|_{\infty} \le \widetilde{\lambda}_1^+ \le \lambda_1^+ \le \lambda_1^- \le \frac{C}{R^2},$$

where c(x) = F(0, 0, 1, x), and C is the constant from Proposition 4.1.

4.2 First comparison and existence results for nonproper equations

We are now going to show that a version of the ABP inequality (and hence the maximum principle) holds for operators with positive $\tilde{\lambda}_1^+, \tilde{\lambda}_1^-$.

Proposition 4.3 Suppose F satisfies $(H_0), (H_1), (H_2), (D_F)$. Suppose there exists a function $\psi_1 \in \widetilde{\Psi}^+(F, \Omega, 0)$. Then for any $u \in C(\overline{\Omega}), f \in L^N(\Omega)$ the inequality $F(D^2u, Du, u, x) \geq f$ in Ω implies

$$\sup_{\Omega} u \le C \left(\sup_{\partial \Omega} u^+ + \|f^-\|_{L^N(\Omega)} \right),$$

where C depends on $diam(\Omega)$, $\lambda, \Lambda, \gamma, \delta$, and $\|\psi_1\|_{C^1(\Omega)}$. Similarly, if there exists a function $\psi_2 \in \widetilde{\Psi}^-(F, \Omega, 0)$ then the inequality $F(D^2u, Du, u, x) \leq f$ implies

$$\sup_{\Omega} u^{-} \leq C \left(\sup_{\partial \Omega} u^{-} + \|f^{+}\|_{L^{N}(\Omega)} \right).$$

Note that $\widetilde{\lambda}_1^+ > 0$ (resp. $\widetilde{\lambda}_1^- > 0$) implies the existence of $\psi_1 \in \widetilde{\Psi}^+(F, \Omega, 0)$ (resp. $\psi_2 \in \widetilde{\Psi}^-(F, \Omega, 0)$).

Proof. The proof is symmetric for both cases, so we present it only in the case when there exists a function $\phi \in \widetilde{\Psi}^+(F,\Omega,0)$. Set $A = \|\phi\|_{C^1(\Omega)}$ (recall $W^{2,p}(\Omega)$ embeds into $C^{1,\alpha}(\Omega)$).

We define the following operator

$$F_{\phi}(M, p, v, x) = F(\phi M + p \otimes D\phi + vD^{2}\phi, \phi p + vD\phi, v\phi, x)$$
(4.17)

(here and in the sequel $p \otimes q$ denotes the matrix $(p_i q_j)_{ij}$, for $p, q \in \mathbb{R}^N$). *Claim.* Hypotheses (S) and (P) from the introduction are satisfied by F_{ϕ} (so Theorem 3.1 applies to F_{ϕ}).

Before continuing, we recall the following properties of Pucci operators.

Lemma 4.2 Let $M, N \in S_N$, $p, q \in \mathbb{R}^N$, and $\phi(x) \in C(\overline{\Omega})$ be such that $0 < a \le \phi(x) \le A$. Then

$$\mathcal{M}^{-}_{\lambda,\Lambda}(M) + \mathcal{M}^{-}_{\lambda,\Lambda}(N) \leq \mathcal{M}^{-}_{\lambda,\Lambda}(M+N) \leq \mathcal{M}^{-}_{\lambda,\Lambda}(M) + \mathcal{M}^{+}_{\lambda,\Lambda}(N),$$
$$\mathcal{M}^{-}_{\lambda a,\Lambda A}(M) \leq \mathcal{M}^{-}_{\lambda,\Lambda}(\phi M) \leq \mathcal{M}^{-}_{\lambda A,\Lambda a}(M),$$
$$-C(\lambda,\Lambda,N)|p||q| \leq \mathcal{M}^{-}_{\lambda,\Lambda}(p \otimes q) \leq \Lambda|p||q|.$$

Proof. For the first two lines, simply use the definition of $\mathcal{M}_{\lambda,\Lambda}^{-}$. For the third line, note that for any $y \in \mathbb{R}^N$ we have

$$< (p \otimes q)y, y > = < p, y > < q, y > \le |p||q||y|^2,$$

so $\widetilde{M} = p \otimes q - |p||q|I$ is negative definite and $\mathcal{M}^{-}_{\lambda,\Lambda}(\widetilde{M}) = \Lambda \operatorname{tr}(\widetilde{M})$. Of course $|\operatorname{tr}(p \otimes q)| \leq |p||q|$. So, by what we already know,

$$\mathcal{M}^{-}_{\lambda,\Lambda}(\widetilde{M}) + \mathcal{M}^{-}_{\lambda,\Lambda}(|p||q|I) \leq \mathcal{M}^{-}_{\lambda,\Lambda}(p \otimes q) \leq \mathcal{M}^{-}_{\lambda,\Lambda}(\widetilde{M}) + \mathcal{M}^{+}_{\lambda,\Lambda}(|p||q|I),$$

and the lemma follows, with $C(\lambda, \Lambda, N) = \Lambda(N+1) - \lambda N$.

We continue with the proof of Proposition 4.3. Let $M, N \in S_N$, and $p, q \in \mathbb{R}^N$. Then by (H_1) and the above lemma

$$F_{\phi}(M, p, v, x) - F_{\phi}(N, q, v, x) \geq \mathcal{M}^{-}_{\lambda, \Lambda} \left(\phi(M - N) + D\phi \otimes (p - q) \right) \\ -\gamma |p - q|$$

$$\geq \mathcal{M}^{-}_{\lambda,\Lambda}(\phi(M-N)) \\ + \mathcal{M}^{-}_{\lambda,\Lambda}(D\phi \otimes (p-q)) - \gamma |p-q|$$

$$\geq \mathcal{M}^{-}_{\lambda,\Lambda A}(M-N) - (CA+\gamma)|p-q|,$$

where $C = C(\lambda, \Lambda, N)$ is the constant from Lemma 4.2. In the same way we obtain

$$F_{\phi}(M, p, v, x) - F_{\phi}(N, q, v, x) \le \mathcal{M}^{+}_{\lambda, \Lambda A}(M - N) + (CA + \gamma)|p - q|$$

(recall $\mathcal{M}_{\lambda,\Lambda}^{-}(M) = -\mathcal{M}_{\lambda,\Lambda}^{+}(-M)$). So F_{ϕ} satisfies (S), with modified con-stants. Let us prove now that F_{ϕ} satisfies (P). Let $v_1, v_2 \in \mathbb{R}$ be such that $v = v_1 - v_2 \ge 0$. Then by the definition of F_{ϕ} , (D_F) , (H_0) and $\phi \in \widetilde{\Psi}^+(F, \Omega, 0)$ we get

$$F_{\phi}(M, p, v_1, x) - F_{\phi}(M, p, v_2, x) \leq F(vD^2\phi, vD\phi, v\phi, x)$$

= $vF(D^2\phi, D\phi, \phi, x) \leq 0.$

So $F_{\phi}(M, p, v, x)$ is nonincreasing in v and the claim follows.

Now set $v = \frac{u}{\phi}$. Then by using that $F(D^2u, Du, u, x) \ge f$ we easily obtain $F_{\phi}(D^2v, Dv, v, x) \geq f$. Now we use Theorem 3.1 for F_{ϕ} , which yields

$$\sup_{\Omega} v \leq \sup_{\partial \Omega} v^+ + C \|f^-\|_{L^N(\Omega)},$$

where C depends on the appropriate quantities. Note that $A^{-1}u \leq v \leq u$. Proposition 4.3 follows.

The following comparison result is an immediate consequence of (D_F) and Proposition 4.3.

Proposition 4.4 Suppose $\widetilde{\lambda}_1^+(F) > 0$. If $u, v \in C(\overline{\Omega})$ are such that

$$\begin{cases} F(D^2u, Du, u, x) \geq F(D^2v, Dv, v, x) & \text{in } \Omega, \\ u \leq v & \text{on } \partial\Omega, \end{cases}$$

and one of u, v is in E_N , then $u \leq v$ in Ω .

Proof. Recall $\widetilde{\lambda}_1^+(F) > 0$ implies that $\widetilde{\Psi}^+(F,\Omega,0)$ is not empty. Then we conclude with the help of (D_F) and Proposition 4.3, applied to v - u. \Box *Remark.* Note that $\widetilde{\lambda}_1^-(F) > 0$ does not imply comparison.

Next, we prove that $\widetilde{\lambda}_1^+ > 0$ is sufficient for the solvability of the Dirichlet problem.

Proposition 4.5 Suppose F satisfies hypotheses $(H_0), (H_1), (H_2)$, and (D_F) . If $\tilde{\lambda}_1^+(F) > 0$ then for any $f \in L^p(\Omega)$, $p \ge N$, there exists a unique viscosity solution $u \in E_p$ of

$$\left\{ \begin{array}{rrrr} F(D^2u,Du,u,x) &=& f & in & \Omega \\ & u &=& 0 & on & \partial\Omega. \end{array} \right.$$

In addition $f \ge 0$ in Ω implies $u \le 0$ in Ω , and $f \le 0$ implies $u \ge 0$.

Proof. Suppose first $f \in C(\overline{\Omega})$. By $\widetilde{\lambda}_1^+ > 0$ and the definition of $\widetilde{\lambda}_1^+$, there exists a function $\psi_1 \in \widetilde{\Psi}^+(F, \Omega, \frac{1}{2}\widetilde{\lambda}_1^+)$, that is, $\psi_1 \ge 1$ in Ω and

$$F(D^2(k\psi_1), D(k\psi_1), k\psi_1, x) \le -\frac{\widetilde{\lambda}_1^+}{2}k\psi_1 \quad \text{for all } k > 0$$

(in this inequality we have used the fact that F is homogeneous). We fix k_1 such that $\tilde{\lambda}_1^+ k_1 \geq 2 \|f\|_{L^{\infty}}$. Then the positive function $k_1 \psi_1$ is a supersolution of the equation $F(D^2u, Du, u, x) = f$.

Similarly, since $\tilde{\lambda}_1^- \geq \tilde{\lambda}_1^+ > 0$ we can find a function $\psi_2 \in \tilde{\Psi}^-(F, \Omega, \frac{1}{2}\tilde{\lambda}_1^-)$, such that $\psi_2 \leq -1$ in Ω and

$$F(D^2(k\psi_2), D(k\psi_2), k\psi_2, x) \ge -\frac{\widetilde{\lambda}_1^-}{2}k\psi_2 \quad \text{for all } k > 0.$$

Fixing k_2 such that $\lambda_1^- k_2 \ge 2 ||f||_{L^{\infty}}$, the negative function $k_2 \psi_2$ is a subsolution of the equation $F(D^2 u, Du, u, x) = f$.

Now we use the following (standard) lemma.

Lemma 4.3 Under the hypotheses of Proposition 4.5, suppose $u_0 \in E_p$ is a subsolution and $v_0 \in E_p$ is a supersolution of $F(D^2u, Du, u, x) = f$, where $f \in C(\overline{\Omega})$. Suppose in addition that $u_0 \leq v_0$ in Ω , $u_0 \leq 0$ on $\partial\Omega$, and $v_0 \geq 0$ on $\partial\Omega$. Then there exists a solution $u \in E_p$ of

$$\left\{ \begin{array}{rrrr} F(D^2u,Du,u,x) &=& f & in & \Omega \\ & u &=& 0 & on & \partial\Omega \end{array} \right.$$

Proof. It is clear that hypothesis (H_1) implies that $F(M, p, u, x) - \delta u$ is nonincreasing in u. Therefore, by Theorem 3.4 we can solve the hierarchy of problems

$$\begin{cases} F(D^2u_{n+1}, Du_{n+1}, u_{n+1}, x) - \delta u_{n+1} &= f - \delta u_n & \text{in } \Omega \\ u_{n+1} &= 0 & \text{on } \partial \Omega. \end{cases}$$

By Theorem 3.2 we have $u_0 \leq u_1 \leq \ldots \leq v_0$. Hence u_n tends pointwise to a function u, and by interior estimates (Theorem 3.3) in $W_{\text{loc}}^{2,p}$, hence locally uniformly. Then by the viscosity solutions theory (see for example Theorem 3.8 in [CCKS]) u is a solution of $F(D^2u, Du, u, x) = f$ in Ω . By Theorem 3.2 we have $w_1 \leq u_n \leq w_2$ for all n, where $w_1, w_2 \in E_p$ are the solutions of

$$\begin{cases} F(D^2w_i, Dw_i, w_i, x) - \delta w_i &= \varepsilon_i L \quad \text{in} \quad \Omega \\ w_i &= 0 \quad \text{on} \quad \partial \Omega, \end{cases}$$

where $\varepsilon_1 = 1, \varepsilon_2 = -1, L = \sup_n ||f - \delta u_n||_{L^{\infty}(\Omega)}$ (*L* depends on *f*, δ , u_0, v_0). Hence $u \in C(\overline{\Omega})$ and u = 0 on $\partial \Omega$.

To finish the proof of Proposition 4.5, if $f \in L^p$ is not in $C(\Omega)$, we take a sequence $f_n \in C(\overline{\Omega})$ which tends to f in the L^p -norm. By what we already proved, there exists a solution $u_n \in E_p$ of $F(D^2u_n, Du_n, u_n, x) = f_n$. Then by (D_F) we obtain

$$F(D^{2}(u_{n} - u_{m}), D(u_{n} - u_{m}), u_{n} - u_{m}, x) \ge f_{n} - f_{m},$$

$$F(D^{2}(u_{m} - u_{n}), D(u_{m} - u_{n}), u_{m} - u_{n}, x) \ge f_{m} - f_{n},$$

for any m, n. By the ABP inequality (Proposition 4.3), which we already proved,

$$||u_m - u_n||_{L^{\infty}(\Omega)} \le C ||f_m - f_n||_{L^{N}(\Omega)},$$

hence $\{u_n\}$ is a Cauchy sequence in $C(\overline{\Omega})$ and tends uniformly to a function $u \in C(\overline{\Omega})$. We conclude by passing to the limit again. The function u is in E_p , by Theorem 3.3.

The uniqueness and the final statement of Proposition 4.5 follow from Proposition 4.4. $\hfill \Box$

4.3 On existence of eigenvalues. Proof of Theorems 1.1 and 1.2

We are now able to prove the existence of two principal eigenvalues and eigenfunctions, when $\tilde{\lambda}_1^+ > 0$.

Proposition 4.6 Suppose $\tilde{\lambda}_1^+ > 0$. Then there exist positive numbers Λ_1^+, Λ_1^- , and functions $\varphi_1^+, \varphi_1^- \in E_p$ for all $p < \infty$, such that

$$\begin{cases} F(D^{2}\varphi_{1}^{+}, D\varphi_{1}^{+}, \varphi_{1}^{+}, x) = -\Lambda_{1}^{+}\varphi_{1}^{+}, & \varphi_{1}^{+} > 0 & in \quad \Omega\\ \varphi_{1}^{+} = 0 & on \quad \partial\Omega, \end{cases}$$

and

$$\left\{ \begin{array}{rrrr} F(D^2\varphi_1^-,D\varphi_1^-,\varphi_1^-,x) &=& -\Lambda_1^-\varphi_1^-, \quad \varphi_1^-<0 \quad in \quad \Omega\\ \varphi_1^- &=& 0 \qquad \qquad on \quad \partial\Omega. \end{array} \right.$$

Proof. Recall F is convex and positively homogeneous. We have proved (Propositions 4.4 and 4.5) that (CP) holds for F and the Dirichlet problem is uniquely solvable for F. Moreover the Hopf lemma (Lemma 3.1) holds for F. Then we can use an adaptation of the classical Krein-Rutman Theorem for a convex operator in a cone to establish the existence of $\Lambda_1^+ > 0$ and φ_1^+ . The argument is carried out in extenso in [Q] or [FQ]. Since we can use exactly the same argument, we refer to these papers for details.

The same argument can be used for G, this yields the existence of $\Lambda_1^- > 0$ and φ_1^- .

Proposition 4.7 If $\tilde{\lambda}_1^+ > 0$ and Λ_1^+, Λ_1^- are as in the previous proposition then $\Lambda_1^+ = \lambda_1^+$ and $\Lambda_1^- = \lambda_1^-$.

Proof. From Proposition 4.6 (the existence of φ_1^+) and the definition of λ_1^+ we have $\Lambda_1^+ \leq \lambda_1^+$.

Suppose there exists $\varepsilon > 0$ such that $\Lambda_1^+ < \lambda_1^+ - \varepsilon$. By the definition of λ_1^+ we can take $\phi \in C(\overline{\Omega})$ such that

$$F(D^2\phi, D\phi, \phi, x) + (\lambda_1^+ - \varepsilon)\phi \le 0, \quad \phi > 0 \quad \text{in} \quad \Omega.$$

Since

$$F(D^{2}\varphi_{1}^{+}, D\varphi_{1}^{+}, \varphi_{1}^{+}, x) + (\lambda_{1}^{+} - \varepsilon)\varphi_{1}^{+} > F(D^{2}\varphi_{1}^{+}, D\varphi_{1}^{+}, \varphi_{1}^{+}, x) + \Lambda_{1}^{+}\varphi_{1}^{+} = 0 \text{ in } \Omega_{2}$$

and $\varphi_1^+ > 0$ in Ω , $\varphi_1^+ = 0$ on $\partial\Omega$, Theorem 4.1 implies that $\phi = t\varphi_1^+$ for some t > 0, which is a contradiction. By replacing F by G in this argument we get $\Lambda_1^- = \lambda_1^-$.

Lemma 4.4 Set

$$\Psi_0^+(F,\Omega,\lambda) = \{ \psi \in E_p , \ \forall p < \infty \mid F(D^2\psi, D\psi, \psi, x) + \lambda \psi \le 0 \text{ in } \Omega \\ and \ \psi > 0 \text{ in } \Omega \}$$

$$\Psi_0^-(F,\Omega,\lambda) = \{ \psi \in E_p , \ \forall p < \infty \mid F(D^2\psi, D\psi, \psi, x) + \lambda \psi \ge 0 \ in \ \Omega$$

and $\psi < 0 \ in \ \Omega \}.$

Then

$$\lambda_1^+(F,\Omega) = \bar{\lambda}_1^+(F,\Omega) := \sup \{\lambda \mid \Psi_0^+(F,\Omega,\lambda) \neq \emptyset\},\$$

$$\lambda_1^-(F,\Omega) = \bar{\lambda}_1^-(F,\Omega) := \sup \{\lambda \mid \Psi_0^-(F,\Omega,\lambda) \neq \emptyset\}.$$

Proof. If $\tilde{\lambda}_1^+ > 0$ this follows from the previous proposition, since clearly $\Lambda_1^+(F,\Omega) \leq \bar{\lambda}_1^+(F,\Omega) \leq \lambda_1^+(F,\Omega)$ (from Proposition 4.6 and the definitions of $\lambda_1^+, \bar{\lambda}_1^+$).

Note that if F is a proper operator then $\widetilde{\lambda}_1^+(F) \geq 0$ (since $\psi \equiv 1$ is in $\widetilde{\Psi}^+(F,\Omega,0)$). On the other hand $F(D^2u, Du, u, x) - \delta u$ is nonincreasing in u. Then, setting $\widehat{F}(D^2u, Du, u, x) = F(D^2u, Du, u, x) - (\delta + 1)u$ we have $\widetilde{\lambda}_1^+(\widehat{F}) \geq 1$, so, by what we already proved,

$$\lambda_1^+(F) + \delta + 1 = \lambda_1^+(\widehat{F}) = \overline{\lambda}_1^+(\widehat{F}) = \overline{\lambda}_1^+(F) + \delta + 1.$$

Theorem 4.2 Suppose F satisfies hypotheses $(H_0), (H_1), (H_2)$, and (D_F) . If $\lambda_1^+(F, \Omega) > 0$ then there exist functions $\varphi_1^+, \varphi_1^- \in E_p$ for all $p < \infty$, such that $\varphi_1^+ > 0, \varphi_1^- < 0$ in $\Omega, \varphi_1^+ = 0, \varphi_1^- = 0$ on $\partial\Omega$, and

$$F(D^{2}\varphi_{1}^{+}, D\varphi_{1}^{+}, \varphi_{1}^{+}, x) = -\lambda_{1}^{+}\varphi_{1}^{+}, \qquad F(D^{2}\varphi_{1}^{-}, D\varphi_{1}^{-}, \varphi_{1}^{-}, x) = -\lambda_{1}^{-}\varphi_{1}^{-}.$$

Proof. Take a sequence of smooth domains $\Omega_n \subset \subset \Omega$, such that $\Omega_n \to \Omega$ as $n \to \infty$. By the previous lemma $\lambda_1^+(\Omega) > 0$ implies $\tilde{\lambda}_1^+(\Omega_n) > 0$, for each n. By Propositions 4.6 and 4.7 there exist functions $\varphi_1^{(n)} \in W^{2,p}_{\text{loc}}(\Omega_n) \cap C(\overline{\Omega_n})$, $\forall p < \infty$, such that $\varphi_1^{(n)} > 0$ in Ω_n , $\varphi_1^{(n)} = 0$ on $\partial\Omega_n$, and

$$F(D^2\varphi_1^{(n)}, D\varphi_1^{(n)}, \varphi_1^{(n)}, x) = -\lambda_1^{(n)}\varphi_1^{(n)}$$
 in Ω_n .

where $\lambda_1^{(n)} = \lambda_1^+(\Omega_n)$. Likewise, there exist negative eigenfunctions in Ω_n corresponding to $\lambda_1^-(\Omega_n)$.

Clearly $\{\lambda_1^{(n)}\}\$ is nonincreasing and bounded below by $\lambda_1^+(\Omega)$. Hence $\{\lambda_1^{(n)}\}\$ converges to a number Λ_1 , with $\Lambda_1 \geq \lambda_1^+(\Omega) > 0$. Proposition 4.2 provides an upper bound for Λ_1 .

The argument which follows is inspired by [BNV]. Fix a point $x_0 \in \Omega$ and renormalize $\varphi_1^{(n)}$ so that $\varphi_1^{(n)}(x_0) = 1$ (of course $k\varphi_1^{(n)}$ satisfies the same equation as $\varphi_1^{(n)}$, for any k > 0). Fix a compact set $K \subset \Omega$ such that $x_0 \in K$ and $|\Omega \setminus K| < \beta$, where β is to be chosen later.

By the Harnack inequality (Theorem 3.6) we have for large n

$$\|\varphi_1^{(n)}\|_{L^{\infty}(K)} \le C_1 \varphi_1^{(n)}(x_0) = C_1.$$

By the hypotheses on F – the homogeneity, (H_1) , and the fact that

$$F(M, p, u, x) \le F(M, p, 0, x) + F(0, 0, u, x),$$

we get

$$F(D^{2}(\varphi_{1}^{(n)} - C_{1}), D(\varphi_{1}^{(n)} - C_{1}), 0, x) \geq F(D^{2}(\varphi_{1}^{(n)} - C_{1}), \ldots) -F(0, 0, \varphi_{1}^{(n)} - C_{1}, x)$$

$$\geq F(D^{2}\varphi_{1}^{(n)}, \ldots) - C_{1}F(0, 0, 1, x) -\delta|\varphi_{1}^{(n)} - C_{1}|$$

$$\geq (-\lambda_{1}^{(n)} - \delta)\varphi_{1}^{(n)} - 2C_{1}\delta$$

(we have written $F(D^2u,...)$ for $F(D^2u, Du, u, x)$). By applying the ABP inequality (Theorem 3.1) in the domain $\Omega_n \setminus K$ we get

$$\sup_{\Omega_n \setminus K} (\varphi_1^{(n)} - C_1) \le (1/2) \sup_{\Omega_n \setminus K} \varphi_1^{(n)} + C_2,$$

provided we choose $\beta = (2B(\Lambda_1 + \delta + 1))^{-N}$, where B is the constant from Theorem 3.1. Hence

$$\|\varphi_1^{(n)}\|_{L^{\infty}(\Omega)} \le 2(C_1 + C_2).$$

In addition, we proved that

$$F(D^2\varphi_1^{(n)}, D\varphi_1^{(n)}, 0, x) \ge -(\Lambda_1 + \delta + 1 + 2C_1\delta) =: -C_3$$

in Ω_n . Therefore, by Theorem 3.2,

$$\varphi_1^{(n)} \le C_3 w_0 \tag{4.18}$$

in Ω_n , where $w_0 \in E_p, p < \infty$, is such that

$$\begin{cases} F(D^2w_0, Dw_0, 0, x) = -1 & \text{in } \Omega \\ w_0 = 0 & \text{on } \partial\Omega \end{cases}$$

(this problem is solvable, see Theorem 3.4).

Now, by interior $W^{2,p}$ -estimates, the sequence $\varphi_1^{(n)}$ converges in $W_{\text{loc}}^{2,p}$ to a nonnegative function φ_1^+ , which is bounded in Ω , $\varphi_1^+(x_0) = 1$, and

$$F(D^{2}\varphi_{1}^{+}, D\varphi_{1}^{+}, \varphi_{1}^{+}, x) = -\Lambda_{1}\varphi_{1}^{+}$$
(4.19)

in Ω . By the strong maximum principle $\varphi_1^+ > 0$ in Ω . By (4.18) $\varphi_1^+ \leq C_3 w_0$ in Ω – so in particular $\varphi_1^+ \in C(\overline{\Omega})$ and $\varphi_1^+ = 0$ on $\partial\Omega$.

Recall that $\Lambda_1 \geq \lambda_1^+$. On the other hand the definition of λ_1^+ and (4.19) imply $\Lambda_1 \leq \lambda_1^+$. Exactly the same argument (reversing signs and inequalities where appropriate) can be carried out for $\lambda_1^{(n)} = \lambda_1^-(\Omega_n)$ and $\varphi_1^{(n)} < 0$ in Ω (then $G(D^2(-\varphi_1^{(n)}), \ldots) = -\lambda_1^-(-\varphi_1^{(n)})$ in Ω). Theorem 4.2 is proved. \Box **Proof of Theorem 1.1** We have just proved that operators with positive λ_1^+ have a principal eigenvalue (equal to λ_1^+). So, to show that any F has two principal eigenvalues and eigenfunctions, it is enough to consider the operator $F(M, p, u, x) - (\lambda_1^+(F) + 1)u$, whose λ_1^+ is equal to 1.

The upper bound on φ_1^+, φ_1^- follows from the proof of Theorem 4.2. The fact that no other eigenvalue can correspond to a positive (negative) eigenfunction is a consequence of Corollary 4.1. Theorem 1.1 is proved.

The following lower bound on λ_1^+ in terms of the measure of the domain is an easy consequence of Theorem 1.1 and Theorem 3.1.

Proposition 4.8 Under the hypotheses of Theorem 1.1

$$\lambda_1^+(F,\Omega) \ge \frac{1}{B|\Omega|^{\frac{1}{N}}} - \delta,$$

where B is the constant from Theorem 3.1.

Proof. Recall $F(D^2u, Du, u, x) - \delta u$ satisfies the hypotheses of Theorem 3.1 and apply this theorem to

$$F(D^2\varphi_1^+, D\varphi_1^+, \varphi_1^+, x) - \delta\varphi_1^+ = -(\lambda_1^+ + \delta)\varphi_1^+.$$

Proof of Theorem 1.2 We shall use Theorem 4.1 (the first set of inequalities), with $F(D^2u, Du, u, x)$ replaced by $F(D^2u, Du, u, x) + \lambda_1^+ u$.

Suppose $u_1 = u$ satisfies (1.3). Then we apply Theorem 4.1 with $u = \varphi_1^+$ and $v = u_1$.

If $u_1 = u$ satisfies (1.2) then either u_1 is positive somewhere, so u_1 satisfies (1.3) and we are in the previous case, or u_1 is a negative eigenfunction, so $\lambda_1^+ = \lambda_1^-$, by Theorem 1.1. Then we apply Theorem 4.1 with $u = \varphi_1^+$ and $v = -u_1$. Theorem 1.2 is proved.

4.4 Proof of $\lambda_1^+ = \widetilde{\lambda}_1^+$. Proof of Theorem 1.4

In the sequel we shall need the following boundary Lipschitz estimate for fully nonlinear equations. It is simple and probably known, yet we have not found a reference, so for the reader's convenience we shall include the proof. For the case of a linear equation, see Problem 3.6 in [GT].

Proposition 4.9 Suppose F satisfies (H_1) and Ω satisfies an uniform exterior sphere condition. Suppose $u \in C(\overline{\Omega})$ satisfies $F(D^2u, Du, u, x) = f$, u = 0 on $\partial\Omega$, where $f \in L^{\infty}(\Omega)$. Then there exists a constant k depending on $N, \lambda, \Lambda, \gamma, \delta$, $diam(\Omega), ||u||_{L^{\infty}(\Omega)}, ||f||_{L^{\infty}(\Omega)}$, and the radius of the exterior spheres, such that for each $x_0 \in \partial\Omega$

$$|u(x)| \le k|x - x_0|$$
 for each $x \in \Omega$.

Proof. We use the barrier $w(x) = l(R^{-p} - |x - y|^{-p})$ for sufficiently large p and l. Here y is the center of the exterior ball touching $\partial\Omega$ at x_0 and R is its radius. We replace F by $F - \delta u$ (so that $F - \delta u$ be proper) and f by $f - \delta u$. Since w is radial, with the aid of Lemma 4.1 it is simple to see that

$$\mathcal{M}^+_{\lambda,\Lambda}(D^2w) + b|Dw| \le -l$$

provided p is taken large enough. We then fix $l \ge ||f - \delta u||_{\infty}$. Hence

$$F(D^{2}w, Dw, w, x) - \delta w \leq F(D^{2}u, Du, u, x) - \delta u \quad \text{in } \Omega$$
$$w \geq u \quad \text{on } \partial \Omega,$$

so the comparison between u and w permits to conclude.

Next, we prove that the principal eigenvalues are continuous with respect to the domain.

Proposition 4.10 Suppose Ω_n are smooth domains such that $\Omega_n \to \Omega$ as $n \to \infty$. Then $\lambda_1^+(\Omega_n) \to \lambda_1^+(\Omega)$, and $\lambda_1^-(\Omega_n) \to \lambda_1^-(\Omega)$.

Proof. The two limits are proved in the same way, so let us prove the first. We already know that there exist positive eigenfunctions $\varphi_1^{(n)}, \varphi_1^+$ for F in Ω_n, Ω . If $\Omega_{n+1} \subset \Omega_n \subset \Omega$ for each n, the proposition is proved through exactly the same argument as the one in the proof of Theorem 4.2.

Suppose now $\Omega \subset \Omega_n \subset \Omega_{n+1}$ for each n. Then $\lambda_1^+(\Omega_n)$ is nondecreasing and bounded above by $\lambda_1^+(\Omega)$. Again through the same argument as the one in the proof of Theorem 4.2 we can show that $\varphi_1^{(n)}$ is uniformly bounded in $L^{\infty}(\Omega)$, and converges to a positive function φ in $W^{2,p}_{\text{loc}}(\Omega)$. By Proposition 4.9 $\{\varphi_1^{(n)}\}\$ is equicontinuous in $\overline{\Omega}$, and hence converges (up to a subsequence) to a function φ in $C(\overline{\Omega})$. Then $\varphi = t\varphi_1^+$ is a consequence of Corollary 4.1.

Finally, for any given sequence Ω_n , such that $\Omega_n \to \Omega$, we can find sequences Ω'_n, Ω''_n such that Ω'_n is increasing, Ω''_n is decreasing, $\Omega'_n \subset \Omega_n$, $\Omega'_n \subset \Omega, \ \Omega_n \subset \Omega''_n$, and $\Omega \subset \Omega''_n$. Proposition 4.10 then follows from what we already proved.

Lemma 4.5 Assume $\lambda_1^+(\Omega) > 0$. Then there exists a function v such that $v \in E_p, \forall p < \infty$, satisfying

$$F(D^2v, Dv, v, x) \le 0$$
 in Ω , $1 \le v \le C$ in Ω ,

where the constant C depends on $\lambda, \Lambda, N, \Omega, \gamma, \delta$, and λ_1^+ . Respectively, if $\lambda_1^- > 0$ then there exists a function $w \in E_p$ such that $-C \leq w \leq -1$ and $F(D^2w, Dw, w, x) \geq 0$.

Proof. First, by Proposition 4.9 there exists a neighbourhood of $\partial\Omega$, depending only on $N, \lambda, \Lambda, \gamma, \delta$ and λ_1^+ (or λ_1^-), such that φ_1^+ (or φ_1^-) attains its maximum (minimum) outside this neighbourhood.

Next, we use the idea of the proof of Proposition 6.1 in [BNV]. Choose a compact set $K \subset \Omega$ such that φ_1^+ attains its maximum (set to 1) in K, and such that $|\Omega \setminus K| \leq \varepsilon = (2\delta B)^{-N}$ where B is the constant in Theorem 3.1. We solve the problem

$$F(D^2w, Dw, 0, x) = \begin{cases} -2\delta & \text{in } \Omega \setminus K \\ 0 & \text{in } K, \end{cases}$$

and w = 0 on $\partial \Omega$ (see Theorem 3.4). By Theorem 3.1 we have

$$0 < w \le B2\delta\varepsilon^{1/N} = 1 \quad \text{in } \Omega.$$

Then, by (H_1) ,

$$\begin{array}{rcl} F(D^2(w+1), D(w+1), w+1, x) & \leq & F(0, 0, w+1, x) + F(D^2w, Dw, 0, x) \\ & \leq & \delta(w+1) - 2\delta \leq 0 & \text{ in } \ \Omega \setminus K. \end{array}$$

By the Harnack inequality (Theorem 3.6), we know that $\varphi_1^+ \ge \eta$ on K, for some $\eta > 0$ which depends on the appropriate quantities. Set $A = \frac{2\delta}{\lambda_1^+ \eta}$ and $v = 1 + w + A\varphi_1^+$. Then $1 \le v \le 2 + A =: C$. Further, by (H_1) ,

$$F(D^{2}v, Dv, v, x) \leq F(D^{2}(w+1), D(w+1), w+1, x) - A\lambda_{1}^{+}\varphi_{1}^{+}$$

$$\leq F(D^{2}(w+1), D(w+1), w+1, x) \leq 0 \text{ in } \Omega \setminus K$$

$$2\delta - A\lambda_{1}^{+}\eta \leq 0 \text{ in } K.$$

To get the corresponding statement when $\lambda_1^- > 0$ we can repeat the same argument, reversing signs and inequalities where appropriate.

Note that we cannot directly infer from the proof of Lemma 4.5 that the function v is in $W^{2,p}(\Omega)$, because of unavailability of global $W^{2,p}$ -estimates for fully nonlinear equations. In order to offset this lack (at least we are unaware of any reference dealing with that question), we use the following construction. Set

$$\Omega_d = \{ x \in \mathbb{R}^N \mid \operatorname{dist}(x, \Omega) < d \}.$$

Then if d is small enough (say $d \leq d_0$, depending only on the shape of Ω) Ω_d is smooth, and by (H_2) we can continuously extend the function F(M, 0, 0, x)in $\mathcal{S}_N \times \Omega_d$. Define $\widehat{F} = F$ if $x \in \Omega$, and $\widehat{F}(M, p, u, x) = F(M, 0, 0, x)$ for each $x \notin \Omega$. The extended operator \widehat{F} has the same properties as F, namely, is convex in (M, p, u) and satisfies $(H_0), (H_1), (H_2)$.

Proposition 4.11 We have $\lambda_1^+(\Omega) = \widetilde{\lambda}_1^+(\Omega)$.

Proof. Fix $d \leq d_0$. For each $\varepsilon > 0$ we can apply Lemma 4.5 to the operator $\widehat{F} + (\lambda_1^+(\widehat{F}, \Omega_d) - \varepsilon)$ in the domain Ω_d , which yields $\widetilde{\lambda}_1^+(F, \Omega) \geq \lambda_1^+(\widehat{F}, \Omega_d) - \varepsilon$, by the definitions. By letting first $\varepsilon \to 0$, then $d \to 0$ and by using Proposition 4.10, we get $\widetilde{\lambda}_1^+(F, \Omega) \geq \lambda_1^+(F, \Omega)$. Since by definition $\widetilde{\lambda}_1^+ \leq \lambda_1^+$, Proposition 4.11 is proved.

Proposition 4.12 Assume $\lambda_1^+(\Omega) > 0$. Then there exists a function v such that $v \in W^{2,p}(\Omega)$, for all $p < \infty$, satisfying

$$F(D^2v, Dv, v, x) \le 0 \quad in \quad \Omega, \qquad v \ge 1 \quad in \quad \Omega, \qquad \|v\|_{W^{2,p}(\Omega)} \le C,$$

where the constant C depends on $p, \lambda, \Lambda, N, \Omega, \gamma, \delta$, and λ_1^+ . Respectively, if $\lambda_1^- > 0$ then there exists a function $w \in W^{2,p}(\Omega)$ such that $-C \leq w \leq -1$, $F(D^2w, Dw, w, x) \geq 0$, and $\|w\|_{W^{2,p}(\Omega)} \leq C$.

Proof. In view of the previous proposition we only need to prove the bound on the $W^{2,p}$ -norm. We are going to show that there exists $d_0 > 0$, depending on $\lambda, \Lambda, N, \Omega, \gamma, \delta$ and λ_1^+ , such that $\lambda_1^+(\Omega_{d_0}) > 0$. The result will then follow from Lemma 4.5 and the interior $W^{2,p}$ -estimates (Theorem 3.3).

Take the function v we constructed in Lemma 4.5. Looking at its construction, $v = 1 + w + A\varphi_1^+$ (see the proof of Lemma 4.5), we have $v \equiv 1$ on $\partial\Omega$, and $v(x) \leq 1 + k_0 \operatorname{dist}(x, \partial\Omega)$, by Proposition 4.9 applied to w and φ_1^+ . Here k_0 depends on the right quantities.

We extend v outside Ω in the following way : given d_0 such that the distance function to the boundary of Ω is smooth in $\Omega_{d_0} \setminus \overline{\Omega}$ (we refer to [GT],

Chapter 14.6, for properties of the distance function), for each $y \in \Omega_{d_0} \setminus \Omega$ we set

$$v(y) = 1 - (k_0 + 1)d(y) - \overline{C} d^2(y), \quad \text{where } 0 \le d(y) = \operatorname{dist}(y, \partial \Omega) \le d_0.$$

Of course y = x + d(y)n(x), where $n(x), x \in \partial\Omega$, is the unit exterior normal to $\partial\Omega$, and x is the point where dist $(y, \partial\Omega)$ is attained. The extended function v is clearly continuous in Ω_{d_0} .

Claim. We can choose d_0 sufficiently small, and \overline{C} sufficiently large, depending only on the appropriate quantities, such that

$$\mathcal{M}^+_{\lambda,\Lambda}(D^2 v) \le -1 \quad \text{in } \Omega_{d_0} \setminus \overline{\Omega}.$$
 (4.20)

Proof of the Claim. Fix y and a principal coordinate system at x (see [GT], page 354). Then

$$D^2 d(y) = \operatorname{diag}\left(\frac{\kappa_1}{1 - \kappa_1 d(y)}, \dots, \frac{\kappa_{n-1}}{1 - \kappa_{n-1} d(y)}, 0\right),$$

where $\kappa_i = \kappa_i(x)$ are the principal curvatures of $\partial\Omega$ at x, see Lemma 14.17 in [GT]. Clearly there exists a constant κ depending only on Ω such that $|\kappa_i(x)| \leq \kappa$ for all *i* and all $x \in \partial \Omega$. Take d_0 so small that $\kappa d_0 \leq \frac{1}{2}$.

Since |Dd| = 1 we have $Dd \otimes Dd(y) = \text{diag}(0, \dots, 0, 1)$, in the same coordinate system. Now, by using

$$D^2(d^2) = 2dD^2d + 2Dd \otimes Dd,$$

we see $-2\overline{C}$ is an eigenvalue of D^2v , while each of the other N-1 eigenvalues of D^2v is bounded by $2((k_0+1)\kappa+2\kappa d\overline{C})$. This implies

$$\mathcal{M}^+_{\lambda,\Lambda}(D^2v) \le 2\Lambda(N-1)\left((k_0+1)\kappa + 2\kappa d\overline{C}\right) - 2\lambda\overline{C}.$$

Taking $d_0 < \frac{\lambda}{4\kappa\Lambda N}$ and $\overline{C} = \frac{2\Lambda N\kappa(k_0+1)+1}{\lambda}$ yields the claim. Therefore, by the way we extended F,

$$F(D^2v, Dv, v, x) = F(D^2v, 0, 0, x) \le \mathcal{M}^+_{\lambda, \Lambda}(D^2v) \le -1 \quad \text{in } \Omega_{d_0} \setminus \overline{\Omega},$$

with the choice of d_0 we made above. So we already know that we have $F(D^2v, Dv, v, x) \leq 0$ in $\Omega \cup (\Omega_{d_0} \setminus \overline{\Omega})$. Finally, the function v is a viscosity solution of $F(D^2v, Dv, v, x) \leq 0$ in Ω_{d_0} - this follows from the fact that we have constructed v to be sufficiently "steep" outside Ω , namely

$$v(x) \leq \begin{cases} 1 + k_0 d(x, \partial \Omega) & \text{for } x \in \Omega\\ 1 - (k_0 + 1) d(x, \partial \Omega) & \text{for } x \notin \Omega, \end{cases}$$

so no regular function can "touch from below" the graph of v at a point on $\partial \Omega$. By the definition of λ_1^+ we infer $\lambda_1^+(\Omega_d) > 0$ for each $d < d_0$.

Getting the statement for $\lambda_1^- > 0$ is again a matter of reversing signs and inequalities.

Proof of Theorem 1.4 Part (a) is a consequence of Theorem 4.1. Indeed, if u is as in Theorem 1.4 (a) then $\lambda_1^+ \ge 0$, by the definition of λ_1^+ . If $\lambda_1^+ = 0$ then Theorem 4.1 with $v = \varphi_1^+$ implies $u = t\varphi_1^+$.

Part (b) follows from Proposition 4.12.

4.5 Conclusion. Proofs of Theorems 1.5–1.10

Proof of Theorem 1.5 That $\lambda_1^+ > 0$ suffices for (CP) follows from Propositions 4.4 and 4.11.

On the other hand, if $\lambda_1^+ \leq 0$ then φ_1^+ is a counterexample to the maximum principle, since then $F(D^2\varphi_1^+, D\varphi_1^+, \varphi_1^+, x) \geq 0$ in Ω , $\varphi_1^+ = 0$ on $\partial\Omega$, but $\varphi_1^+ \leq 0$ in Ω .

Proof of Theorem 1.7 Theorem 1.7 is a consequence of Proposition 4.3 in which we take ψ_1, ψ_2 to be the functions v, w constructed in Proposition 4.12, in view of the imbedding $W^{2,p}(\Omega) \hookrightarrow C^{1,\alpha}(\Omega)$.

Proof of Theorem 1.6 Use Theorem 1.7 and note that if $\lambda_1^- \leq 0$ then φ_1^- ($\varphi_1^- < 0$ in Ω) provides a counterexample to the one-sided maximum principle.

Proof of Theorem 1.8 The existence result follows from Propositions 4.5 and 4.11. The $W^{2,p}$ bound follows from Theorem 3.3 and Theorem 1.7.

Suppose for contradiction $\lambda_1^+ = 0$ and $\overline{u} \in C(\overline{\Omega})$ is a function such that $F(D^2\overline{u}, D\overline{u}, \overline{u}, x) = f \leq 0$ in Ω , $\overline{u} = 0$ on $\partial\Omega$. First, if $\overline{u} \geq 0$ in Ω , then by Lemma 3.1 $\overline{u} > 0$ in Ω (note $\overline{u} \neq 0$ since $f \neq 0$). Then $u = \overline{u}$ and $v = \varphi_1^+$ satisfy the first set of inequalities in Theorem 4.1, so $\overline{u} = t\varphi_1^+$, which yields a contradiction with $f \neq 0$.

Second, if \overline{u} is negative somewhere, we have the second set of inequalities in Theorem 4.1, with $u = \varphi_1^-$ and $v = \overline{u}$ (recall that $F(D^2\varphi_1^-, \ldots) = -\lambda_1^-\varphi_1^-$, $\varphi_1^- < 0$ in Ω , and note $\lambda_1^- \ge \lambda_1^+ = 0$). We get $f \ge 0$ and $f \le 0$, a contradiction with $f \not\equiv 0$.

Finally, if $\lambda_1^- > 0 \ge \lambda_1^+$ then Theorem 1.6 and Lemma 3.1 imply u > 0 or $u \equiv 0$ in Ω , so we can conclude as in the previous two cases.

Proof of Theorem 1.9 As in the proof of Proposition 4.5, $\lambda_1^- = \lambda_1^- > 0$ implies the existence of a negative subsolution u_0 , provided $f \in C(\overline{\Omega})$. On the other hand, $f \ge 0$ implies that $v_0 \equiv 0$ is a supersolution. Then Lemma 4.3 shows Theorem 1.9 holds in case the right-hand side f is in $C(\overline{\Omega})$.

If $f \in L^p$ is not in $C(\overline{\Omega})$, we take a sequence $f_n \in C(\overline{\Omega})$, $f_n \ge 0$, which tends to f in the L^p -norm. By what we already proved, there exists a solution $u_n \in E_p$, $u_n \le 0$, of $F(D^2u_n, Du_n, u_n, x) = f_n$, and $u_n = 0$ on $\partial\Omega$. Note that we cannot use the same approximation argument as in the proof of Proposition 4.5, since the ABP inequality does not hold. However, the half-ABP inequality which still holds under $\lambda_1^- > 0$ (see Theorem 1.7) implies that u_n is uniformly bounded in Ω (recall $u_n \le 0$). Then by interior $W^{2,p}$ estimates u_n converges in $W_{loc}^{2,p}$ to a solution u of $F(D^2u, Du, u, x) = f$. It only remains to show that u = 0 on $\partial\Omega$ and $u \in C(\overline{\Omega})$.

Take again a compact subset $K \subset \Omega$ such that $|\Omega \setminus K| \leq (2\delta B)^{-N}$, where B is the constant in Theorem 3.1. We already know that $u_n \rightrightarrows u$ in K. Now the inequality

$$F(D^{2}(u_{n}-u_{m}), D(u_{n}-u_{m}), u_{n}-u_{m}, x) - \delta(u_{n}-u_{m}) \ge f_{n} - f_{m} - \delta(u_{n}-u_{m}),$$

(and the same with m and n interchanged), together with Theorem 3.1, yield

$$\sup_{\Omega\setminus K} |u_n - u_m| \le \sup_{\partial K} |u_n - u_m| + B ||f_n - f_m||_{L^p(\Omega)} + \frac{1}{2} \sup_{\Omega\setminus K} |u_n - u_m|$$

This implies that $\{u_n\}$ is a Cauchy sequence in $C(\overline{\Omega \setminus K})$ and so converges uniformly in this set.

Proof of Theorem 1.10 We are going to use the results for proper operators obtained in [CKLS].

First, suppose H and f are continuous in all their variables. Let $\phi = v$ be the function constructed in Proposition 4.12. Then, as we already showed in the proof of Proposition 4.3, the operator H_{ϕ} satisfies hypotheses (1.2) and (1.3) in [CKLS] (we define H_{ϕ} as in (4.17) with F replaced by H). Hence Theorem 1.10 follows from Theorem 1.1 in [CKLS] - note that if \overline{u} is a solution of $H_{\phi}(D^2\overline{u}, D\overline{u}, \overline{u}, x) = f$, then $u = \phi\overline{u}$ is a solution of $H(D^2u, Du, u, x) = f$.

Next, if H is only measurable, we smooth out G, H, and F as in the proof of Theorem 4.1 in [CKLS]

$$F_{\varepsilon}(M, p, u, x) = \frac{1}{\varepsilon^n} \int_{\mathbb{R}^N} \eta\left(\frac{x-y}{\varepsilon}\right) F(M, p, u, y) \, dy, \quad \text{same for } H_{\varepsilon}, G_{\varepsilon},$$

where $\eta \geq 0$ has compact support and mass 1. Now, for fixed ε , the operators $H_{\varepsilon}, G_{\varepsilon}, F_{\varepsilon}$ satisfy all the hypotheses we have made on H, G, F, with the same constants $\lambda, \Lambda, \gamma, \delta$.

In particular, F_{ε} also possesses a principal eigenvalue $\lambda_1^+(F_{\varepsilon}, \Omega)$. Claim. $\lambda_1^+(F_{\varepsilon}) \to \lambda_1^+(F)$, as $\varepsilon \to 0$. Proof of the Claim. By the bounds on the first eigenvalue that we have already proved (Proposition 4.2) $\{\lambda_1^+(F_{\varepsilon})\}$ is bounded in ε . Fix a subsequence of $\{\lambda_1^+(F_{\varepsilon})\}$ and let μ be the limit of some subsequence of this subsequence. We are going to show that $\mu = \lambda_1^+(F)$. Let $\varphi_{1,\varepsilon}^+$ be the first eigenfunctions of F_{ε} normalized so that $\varphi_{1,\varepsilon}^+(x_0) = 1$ for a fixed point $x_0 \in \Omega$. Then $\{\varphi_{1,\varepsilon}\}$ is uniformly bounded in the L^{∞} -norm, by Theorem 1.1. Hypothesis (H_1) and the equation satisfied by $\varphi_{1,\varepsilon}$ then imply

$$\mathcal{M}_{\lambda,\Lambda}^{+}\left(D^{2}\varphi_{1,\varepsilon}\right)+\gamma|D\varphi_{1,\varepsilon}|\geq -C, \qquad \mathcal{M}_{\lambda,\Lambda}^{-}\left(D^{2}\varphi_{1,\varepsilon}\right)-\gamma|D\varphi_{1,\varepsilon}|\leq C,$$

where C is independent of ε . Hence, by Proposition 4.2 in [CKLS] (see also the end of the proof of Theorem 4.1 in this paper), a subsequence of $\{\varphi_{1,\varepsilon}\}$ converges uniformly in $\overline{\Omega}$ to a positive function $\varphi \in C(\overline{\Omega})$, which solves (see also Theorem 3.8 in [CCKS])

$$F(D^2\varphi, D\varphi, \varphi, x) = -\mu \varphi \text{ in } \Omega, \text{ and } u = 0 \text{ on } \partial \Omega.$$

So $\mu = \lambda_1^+(F, \Omega)$, by Theorem 1.1.

Hence, if ε is small enough, we have $\lambda_1^+(F_{\varepsilon}) > \frac{1}{2}\lambda_1^+(F) > 0$.

We take a sequence $f_n \in C(\overline{\Omega})$ which converges to f in L^p . By what we already proved, if ε is small enough, there exists a solution $u_{\varepsilon,n}$ of

$$H_{\varepsilon}(D^2 u_{\varepsilon,n}, D u_{\varepsilon,n}, u_{\varepsilon,n}, x) = f_n,$$

and $u_{\varepsilon,n} = 0$ on $\partial\Omega$. Since H satisfies (D_F) this implies

$$F_{\varepsilon}(D^2 u_{\varepsilon,n}, Du_{\varepsilon,n}, u_{\varepsilon,n}, x) \ge f_n, \text{ and}$$

 $F_{\varepsilon}(D^2(-u_{\varepsilon,n}), D(-u_{\varepsilon,n}), -u_{\varepsilon,n}, x) \ge -f_n$

in Ω . By the ABP inequality (Theorem 1.7) $u_{\varepsilon,n}$ is uniformly bounded in ϵ and n, so we can finish the proof of Theorem 1.10 through the same argument as the one used to end the proof of Theorem 4.1 in [CKLS].

The last statement in Theorem 1.10 is a consequence of Theorem 3.3. \Box

5 General bounded domains

In [BNV] Berestycki, Nirenberg and Varadhan proved the existence of a principal eigenvalue and a principal eigenfunction of linear elliptic operators with bounded (and continuous second-order) coefficients in arbitrary bounded domains. As noted in the introduction, once we have proved our theorems in smooth domains, it is not difficult to adapt some arguments from [BNV] in

order to show that most of our results extend to general domains. In this section we make several remarks concerning these extensions, leaving the details to the interested reader.

So suppose Ω is just bounded, F satisfies (H_0) - (H_1) , and F(M, 0, 0, x) is continuous in $\mathcal{S}_N \times \Omega$. Similarly to Section 3 in [BNV] we use the positive function \overline{u}_0 defined as the limit of the solutions of $F(D^2u, Du, 0, x) = -1$ in smooth subdomains of Ω which converge to Ω . Note that the negative function \underline{u}_0 defined as the limit of the solutions of $F(D^2u, Du, 0, x) = 1$ satisfies $0 < -\underline{u}_0 \leq \overline{u}_0$, by the assumptions on F.

The functions we consider are not continuous up to the boundary, and the Dirichlet boundary condition u = 0 is to be replaced in all results by $u \stackrel{\overline{u}_0}{=} 0$, that is, $u(x_j) \to 0$ whenever $x_j \to \partial\Omega$ and $\overline{u}_0(x_j) \to 0$. Inequalities $u \leq v$ on $\partial\Omega$ are to be replaced by $\limsup(u(x_j) - v(x_j)) \leq 0$ whenever $x_j \to \partial\Omega$ and $\overline{u}_0(x_j) \to 0$. In defining the comparison principle one has to explicitly state that the functions involved are bounded (see [BNV] for an example showing that this is unavoidable). The space E_p has to be replaced by $W_{\text{loc}}^{2,p} \cap L^{\infty}(\Omega)$.

Then Theorem 1.1 is proved through the same approximation argument as the one used in the proof of Theorem 4.2, since we already know eigenvalues exist in the smooth subdomains. Theorem 1.2 and all other results following from Theorem 4.1 do not change. Theorem 1.4 (b) has to be replaced by the result in Lemma 4.5, which remains true (but Proposition 4.12 no longer holds). The results on solvability of the Dirichlet problem and the ABP inequality are proved by an adaptation of the arguments in Section 6 of [BNV], by using at the appropriate places the fact that the Dirichlet problem is already known to be solvable in smooth subdomains of Ω .

6 Proof of Theorem 1.3

It follows from Theorem 1.8 that $u \equiv 0$ is the unique solution of (1.4), when $\lambda < \lambda_1^+$. If $\lambda < \lambda_1^-$ and $u \not\equiv 0$ is a solution of (1.4) then it follows from Theorem 1.6 and the strong maximum principle that u > 0 in Ω . Then $\lambda = \lambda_1^+$, by the last statement in Theorem 1.1.

Finally, suppose there exists a sequence $\lambda_n \searrow \lambda_1^-$ such that problem (1.4) with $\lambda = \lambda_n$ has a solution $u_n \neq 0$. We normalize u_n so that $||u_n||_{L^{\infty}(\Omega)} = 1$. By (H_1)

$$\mathcal{M}^+_{\lambda,\Lambda}(D^2u_n) + \gamma |Du_n| \ge -C, \qquad \mathcal{M}^-_{\lambda,\Lambda}(D^2u_n) - \gamma |Du_n| \le C,$$

and again from Proposition 4.2 in [CKLS] and Theorem 3.8 in [CCKS] it follows that u_n converges uniformly in $\overline{\Omega}$ to a nontrivial solution of (1.4) with $\lambda = \lambda_1^-$, in other words, to φ_1^- . However, u_n changes sign, by Theorem 1.1, so we can take a connected component Ω_n of $\{u_n > 0\}$. Then, by what we have already proved for non-regular domains, $\lambda_1^+(F,\Omega_n) = \lambda_n \to \lambda_1^-$. On the other hand $\varphi_1^- < 0$ implies $\Omega_n \to \emptyset$, hence $\lambda_1^+(F,\Omega_n) \to \infty$ by Proposition 4.8, which is a contradiction.
