# Bidendriform bialgebras, trees, and free quasi-symmetric functions

#### Abstract

: we introduce bidendriform bialgebras, which are bialgebras such that both product and coproduct can be split into two parts satisfying good compatibilities. For example, the Malvenuto-Reutenauer Hopf algebra and the non-commutative Connes-Kreimer Hopf algebras of planar decorated rooted trees are bidendriform bialgebras. We prove that all connected bidendriform bialgebras are generated by their primitive elements as a dendriform algebra (bidendriform Milnor-Moore theorem) and then is isomorphic to a Connes-Kreimer Hopf algebra. As a corollary, the Hopf algebra of Malvenuto-Reutenauer is isomorphic to the Connes-kreimer Hopf algebra of planar rooted trees decorated by a certain set. We deduce that the Lie algebra of its primitive elements is free in characteristic zero (G. Duchamp, F. Hivert and J.-Y. Thibon conjecture).


RESUME : nous introduisons les bigèbres bidendriformes, qui sont des bigèbres dont le produit et le coproduit peuvent être scindés en deux avec de bonnes compatibilités. Par exemple, l'algèbre de Hopf de Malvenuto-Reutenauer et les algèbres de Hopf non-commutative de ConnesKreimer sur les arbres plans enracinés décorés sont des bigèbres bidendriformes. Nous montrons que toute bigèbre bidendriforme connexe est engendrée par ses éléments totalement primitifs comme algèbre dendriforme (version bidendriforme du théorème de Milnor-Moore) et qu'elle est alors isomorphe à une algèbre de Hopf de Connes-Kreimer. En conséquence, l'algèbre de Hopf de Malvenuto-Reutenauer est isomorphe à l'algèbre de Connes-Kreimer des arbres plans enracinés décorés par un certain ensemble. On en déduit que l'algèbre de Lie de ses éléments primitifs est libre en caractéristique zéro (conjecture de G. Duchamp, F. Hivert et J.-Y. Thibon).

## Introduction

The Hopf algebra FQSym of Malvenuto-Reutenauer, also called Hopf algebra of free quasisymmetric functions (5, 16, 17, 18]) has certain interesting properties. For example, it is known that it free as an algebra and cofree as a coalgebra; it has a non-degenerate Hopf pairing; it can be given a structure of dendriform algebra. The Hopf algebras $\mathcal{H}^{\mathcal{D}}$ of planar rooted trees,
 coalgebras; they have a non-degenerate Hopf pairing (although not so explicit as the MalvenutoReutenauer algebra's); they also are dendriform algebras. So a natural question is: are these two objects isomorphic? More precisely, is there a set $\mathcal{D}$ of decorations such that $\mathcal{H}^{\mathcal{D}}$ is isomorphic to FQSym?

In order to answer positively this question, we study more in details dendriform algebras. This notion is introduced by Loday and Ronco in (15] and is studied in [2, 16, 17, 22, 21]. A dendriform algebra $A$ is a (non unitary) associative algebra, such that the product can be split into two parts $\prec$ and $\succ$ (left and right products), with good compatibilities (which mean that $(A, \prec, \succ)$ is a bimodule over itself). The notion of dendriform bialgebra or Hopf dendriform algebra is also given. These are dendriform algebra with a coassociative coproduct $\tilde{\Delta}$, satisfying good relations with $\prec$ and $\succ$. We introduce here the notion of bidendriform bialgebra (section (2): a bidendriform bialgebra $A$ is a dendriform bialgebra such that the coproduct $\tilde{\Delta}$ can be split into two parts $\Delta_{\prec}$ and $\Delta_{\succ}$ (left and right coproducts), such that $\left(A, \Delta_{\succ}, \Delta_{\prec}\right)$ is a bimodule over itself. There are also compatibilities between the left and right coproducts and the left and right products. As this set of axioms is self-dual, the dual of a finite-dimensional bidendriform bialgebra is also a bidendriform bialgebra. An example of bidendriform bialgebra is FQSym (section (4), or, more precisely, its augmentation ideal: as FQSym is a dendriform algebra and it is self dual as a Hopf algebra, we can also split the coproduct into two parts. Fortunately, the left and right coproducts defined in this way satisfy the wanted compatibilities with the left and right products.

We would like to give $\mathcal{H}^{\mathcal{D}}$ a structure of bidendriform algebra too. The method used for FQSym fails here: the left and right coproducts defined by duality, denoted here by $\Delta_{\prec}^{\prime}$ and $\Delta_{\succ}^{\prime}$, do not satisfy the compatibilities with the left and right products. Hence, we have to proceed in a different way. For this, we consider the category of dendriform algebras and give it a tensor product $\bar{\otimes}$ (section 3). This tensor product is a little bit different of the usual one, as dendriform algebras are not unitary objects: we have to add a copy of both algebras to their tensor products. We also define the notion of dendriform module over a dendriform algebra. Then the notions of dendriform bialgebra and bidendriform bialgebra become more clear: the coproduct of a dendriform bialgebra $A$ has to be a morphism of dendriform algebras from $A$
to $A \bar{\otimes} A$; the left and right coproducts of a bidendriform bialgebra $A$ have to be morphism of dendriform modules from $A$ to $A \bar{\otimes} A$. Now, as the dendriform algebra $\mathcal{H}^{\mathcal{D}}$ is freely generated by the elements $\cdot d$ as a dendriform algebra, it is possible to define a unique structure of bidendriform bialgebra over $\mathcal{H}^{\mathcal{D}}$ (or, more exactly, on its augmentation ideal $\mathcal{A}^{\mathcal{D}}$ ) by $\Delta_{\prec}\left(\cdot{ }_{d}\right)=\Delta_{\succ}(\cdot d)=0$ (theorem 31).

Let us now study more precisely the notion of bidendriform bialgebra. For a given bidendriform bialgebra $A$, we consider totally primitive elements of $A$, that is to say elements which vanish under both $\Delta_{\prec}$ and $\Delta_{\succ}$. We say that $A$ is connected if, for every element $a$, the various iterated coproducts all vanish on $a$ for a great enough rank. Then, if $A$ is connected, we prove that $A$ is generated as a dendriform algebra by its totally primitive elements (theorem 21). This theorem can be seen as a bidendriform version of the Milnor-Moore theorem (20]), which says that a cocommutative, connected Hopf algebra is generated by its primitive elements (in characteristic zero).

To precise this result, we consider the bidendriform bialgebra $\mathcal{A}^{\mathcal{D}}$. We prove that its space of totally primitive elements is reduced to the space of its generators: the elements $\cdot{ }_{d}$. In other terms, the triple (Dend, coDend, Vect) is a good triple of operads, with the language of 14. This implies that every connected bidendriform bialgebra is freely generated by its totally primitive elements, so is isomorphic to a $\mathcal{H}^{\mathcal{D}}$ for a well chosen $\mathcal{D}$ (theorem 39). We apply this result to FQSym: then, for a certain $\mathcal{D}$, FQSym is isomorphic to $\mathcal{H}^{\mathcal{D}}$ as a bidendriform bialgebra, and hence as a Hopf algebra. This allows us to answer a conjecture of [5]: if the characteristic of the base field is zero, then the Lie algebra of primitive elements of FQSym is free (corollary 40), as we already proved this result for $\mathcal{H}^{\mathcal{D}}$ in 国.

As a connected bidendriform bialgebra is isomorphic to a certain $\mathcal{H}^{\mathcal{D}}$, it is self-dual. We define the notion of bidendriform pairing; for example, the pairing of [5] on FQSym is a bidendriform pairing, whereas the pairing of $[7]$ on $\mathcal{H}^{\mathcal{D}}$ is not. We construct another pairing on $\mathcal{H}^{\mathcal{D}}$, which is non-degenerate, symmetric and bidendriform. This pairing can be studied in the same way as in [7]: we give a inductive way to compute it and a combinatorial interpretation of this pairing.

Notation. $K$ is a commutative field of any characteristic.

## 1 Dendriform and codendriform bialgebras

### 1.1 Dendriform algebras and coalgebras

Definition 1 (See [2, 15, 16, 17, 21, 22]). A dendriform algebra is a family $(A, \prec, \succ)$ such that:

1. $A$ is a $K$-vector space and:

\prec:\left\{\left.\begin{array}{rll}
A \otimes A & \longrightarrow & A \\
a \otimes b & \longrightarrow & a \prec b,
\end{array} \right\rvert\, \succ:\left\{\begin{array}{rll}
A \otimes A & \longrightarrow & A \\
a \otimes b & \longrightarrow & a \succ b .
\end{array}\right.\right.
$$

2. For all $a, b, c \in A$ :

$$
\begin{align*}
(a \prec b) \prec c & =a \prec(b \prec c+b \succ c),  \tag{1}\\
(a \succ b) \prec c & =a \succ(b \prec c),  \tag{2}\\
(a \prec b+a \succ b) \succ c & =a \succ(b \succ c) . \tag{3}
\end{align*}
$$

Remark. If $A$ is a dendriform algebra, we put:

$$
m:\left\{\begin{array}{rll}
A \otimes A & \longrightarrow & A \\
a \otimes b & \longrightarrow & a b=a \prec b+a \succ b .
\end{array}\right.
$$

Then (11) $+(2)+(3)$ is equivalent to the fact that $m$ is associative. Hence, a dendriform algebra is a special (non unitary) associative algebra.

By duality, we obtain the notion of dendriform coalgebra:
Definition 2 A dendriform coalgebra is a family $\left(C, \Delta_{\prec}, \Delta_{\succ}\right)$ such that:

1. $C$ is a $K$-vector space and:

$$
\Delta_{\prec}:\left\{\left.\begin{array}{rll}
C & \longrightarrow & C \otimes C \\
a & \longrightarrow & \Delta_{\prec}(a)=a_{\prec}^{\prime} \otimes a_{\prec}^{\prime \prime},
\end{array} \right\rvert\, \Delta_{\succ}:\left\{\begin{array}{rll}
C & \longrightarrow & C \otimes C \\
a & \longrightarrow & \Delta_{\succ}(a)=a_{\succ}^{\prime} \otimes a_{\succ}^{\prime \prime} .
\end{array}\right.\right.
$$

2. for all $a \in C$ :

$$
\begin{align*}
\left(\Delta_{\prec} \otimes I d\right) \circ \Delta_{\prec}(a) & =\left(I d \otimes \Delta_{\prec}+I d \otimes \Delta_{\succ}\right) \circ \Delta_{\prec}(a),  \tag{4}\\
\left(\Delta_{\succ} \otimes I d\right) \circ \Delta_{\prec}(a) & =\left(I d \otimes \Delta_{\prec}\right) \circ \Delta_{\succ}(a),  \tag{5}\\
\left(\Delta_{\prec} \otimes I d+\Delta_{\succ} \otimes I d\right) \circ \Delta_{\succ}(a) & =\left(I d \otimes \Delta_{\succ}\right) \circ \Delta_{\succ}(a) . \tag{6}
\end{align*}
$$

## Remarks.

1. If $C$ is a dendriform coalgebra, we put:

$$
\tilde{\Delta}:\left\{\begin{array}{rll}
C & \longrightarrow & C \otimes C \\
a & \longrightarrow & \tilde{\Delta}(a)=\Delta_{\prec}(a)+\Delta_{\succ}(a)=a^{\prime} \otimes a^{\prime \prime}
\end{array}\right.
$$

Then $(\sqrt[4]{4})+(5)+(\sqrt{6})$ is equivalent to the fact that $\tilde{\Delta}$ is coassociative. Hence, a dendriform coalgebra is a special (non counitary) coassociative coalgebra.
2. If $A=\bigoplus A_{n}$ is a $\mathbb{N}$-graded dendriform algebra, such that its homogeneous parts are finitedimensional, then $\left(A^{* g}, \prec^{*}, \succ^{*}\right)$ is a $\mathbb{N}$-graded dendriform coalgebra ( $A^{* g}$ is the graded dual of $A$, that is to say $\left.A^{* g}=\bigoplus A_{n}^{*} \subseteq A^{*}\right)$.
3. In the same way, if $C$ is a $\mathbb{N}$-graded dendriform coalgebra, such that its homogeneous parts are finite-dimensional, then $\left(C^{* g}, \Delta_{\prec}^{*}, \Delta_{\succ}^{*}\right)$ is a $\mathbb{N}$-graded dendriform algebra. (In fact, for any dendriform coalgebra $C$, the whole linear dual $C^{*}$ is a dendriform algebra).

Definition 3 Let $A$ be a dendriform coalgebra. We put:

$$
\begin{aligned}
\operatorname{Prim}(A) & =\{a \in A / \tilde{\Delta}(a)=0\}, \\
\operatorname{Prim}_{\prec}(A) & =\left\{a \in A / \Delta_{\prec}(a)=0\right\}, \\
\operatorname{Prim}_{\succ}(A) & =\left\{a \in A / \Delta_{\succ}(a)=0\right\}, \\
\operatorname{Prim}_{\text {tot }}(A) & =\operatorname{Prim}_{\succ}(A) \cap \operatorname{Prim}_{\prec}(A)=\left\{a \in A / \tilde{\Delta}(a)=\Delta_{\prec}(a)=\Delta_{\succ}(a)=0\right\} .
\end{aligned}
$$

### 1.2 Dendriform and codendriform bialgebras

Definition 4 (See [2, 16, 17, 21, 22]). A dendriform bialgebra is a family $(A, \prec, \succ, \tilde{\Delta})$ such that:

1. $(A, \prec, \succ)$ is a dendriform algebra.
2. $(A, \tilde{\Delta})$ is a coassociative (non counitary) coalgebra.
3. The following compatibilities are satisfied: for all $a, b \in A$,

$$
\begin{align*}
& \tilde{\Delta}(a \prec b)=a^{\prime} b^{\prime} \otimes a^{\prime \prime} \prec b^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} \prec b+a^{\prime} b \otimes a^{\prime \prime}+b^{\prime} \otimes a \prec b^{\prime \prime}+b \otimes a,  \tag{7}\\
& \tilde{\Delta}(a \succ b)=a^{\prime} b^{\prime} \otimes a^{\prime \prime} \succ b^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} \succ b+a b^{\prime} \otimes b^{\prime \prime}+b^{\prime} \otimes a \succ b^{\prime \prime}+a \otimes b . \tag{8}
\end{align*}
$$

## Remarks.

1. (7) $+(8)$ is equivalent to: for all $a \in A$,

$$
\begin{equation*}
\tilde{\Delta}(a b)=a^{\prime} b^{\prime} \otimes a^{\prime \prime} b^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} b+a b^{\prime} \otimes b^{\prime \prime}+a^{\prime} b \otimes a^{\prime \prime}+b^{\prime} \otimes a b^{\prime \prime}+a \otimes b+b \otimes a . \tag{9}
\end{equation*}
$$

If $A$ is a dendriform bialgebra, we put $\bar{A}=A \oplus K$, which is given a structure of associative algebra and coassociative coalgebra in the following way: for all $a, b \in A$,

$$
\begin{aligned}
1 . a=a, & a .1=a, \\
\Delta(1)=1 \otimes 1, & \Delta(a)=1 \otimes a+a \otimes 1+\tilde{\Delta}(a) .
\end{aligned}
$$

Then (9) means that $\bar{A}$ is a bialgebra. A dendriform bialgebra is then the augmentation ideal of a special bialgebra.
2. Another interpretation of (7) and (8) will be given in section 3 .

By duality, we define the notion of codendriform bialgebra:
Definition 5 A codendriform bialgebra is a family $\left(A, m, \Delta_{\prec}, \Delta_{\succ}\right)$ such that:

1. $\left(A, \Delta_{\prec}, \Delta_{\succ}\right)$ is a dendriform coalgebra.
2. $(A, m)$ is an associative (non unitary) algebra.
3. The following compatibilities are satisfied: for all $a, b \in A$,

$$
\begin{align*}
\Delta_{\succ}(a b) & =a^{\prime} b_{\succ}^{\prime} \otimes a^{\prime \prime} b_{\succ}^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} b+a b_{\succ}^{\prime} \otimes b_{\succ}^{\prime \prime}+b_{\succ}^{\prime} \otimes a b_{\succ}^{\prime \prime}+a \otimes b  \tag{10}\\
\Delta_{\prec}(a b) & =a^{\prime} b_{\prec}^{\prime} \otimes a^{\prime \prime} b_{\prec}^{\prime \prime}+a^{\prime} b \otimes a^{\prime \prime}+a b_{\prec}^{\prime} \otimes b_{\prec}^{\prime \prime}+b_{\prec}^{\prime} \otimes a b_{\prec}^{\prime \prime}+b \otimes a . \tag{11}
\end{align*}
$$

## Remarks.

1. $(\sqrt[10]{ })+(11)$ is equivalent to (9). Hence, if $A$ is a codendriform bialgebra, as before $\bar{A}=A \oplus K$ is given a structure of bialgebra. A codendriform bialgebra is then the augmentation ideal of a special bialgebra.
2. If $A$ is a $\mathbb{N}$-graded codendriform bialgebra, such that its homogeneous parts are finitedimensional, then $\left(A^{* g}, \Delta_{\prec}^{*}, \Delta_{\succ}^{*}, m^{*}\right)$ is a $\mathbb{N}$-graded dendriform bialgebra.
3. In the same way, if $A$ is a $\mathbb{N}$-graded dendriform bialgebra, such that its homogeneous parts are finite-dimensional, then $\left(A^{* g}, \tilde{\Delta}^{*}, \prec^{*}, \succ^{*}\right)$ is a $\mathbb{N}$-graded codendriform bialgebra.

### 1.3 Free dendriform algebras

Let us recall here the construction of the Connes-Kreimer Hopf algebra of planar decorated rooted trees (See [7, 8, 9] for more details). It is a non-commutative version of the ConnesKreimer Hopf algebra of rooted trees for Renormalisation ( $[1,11,12,13]$ ).

## Definition 6

1. A rooted tree $t$ is a finite graph, without loops, with a special vertex called root of $t$. A planar rooted tree $t$ is a rooted tree with an imbedding in the plane. The weight of $t$ is the number of its vertices. the set of planar rooted trees will be denoted by $\mathbb{T}$.
2. Let $\mathcal{D}$ be a nonempty set. A planar rooted tree decorated by $\mathcal{D}$ is a planar tree with an application from the set of its vertices into $\mathcal{D}$. The set of planar rooted trees decorated by $\mathcal{D}$ will be denoted by $\mathbb{T}^{\mathcal{D}}$.

## Examples.

1. Planar rooted trees with weight smaller than 5:

$$
\ldots, \forall, \downarrow, \forall, \forall, \forall, Y, 1, \forall, \forall, \downarrow, \forall, \forall, \forall, \forall, \downarrow, \downarrow, \forall, \forall, \forall, Y,
$$

2. Planar rooted trees decorated by $\{a, b\}$ with weight smaller than 3:

The algebra $\mathcal{H}$ (denoted by $\mathcal{H}_{P, R}$ in [7, 区]) is the free associative (non commutative) $K$ algebra generated by the elements of $\mathbb{T}$. Monomials in planar rooted trees in these algebra are called planar rooted forests. The set of planar rooted forests will be denoted by $\mathbb{F}$. Note that $\mathbb{F}$ is a basis of $\mathcal{H}$.

In the same way, if $\mathcal{D}$ is a nonempty set, the algebra $\mathcal{H}^{\mathcal{D}}$ (denoted by $\mathcal{H}_{P, R}^{\mathcal{D}}$ in [7] $]$ ) is the free associative (non commutative) $K$-algebra generated by the elements of $\mathbb{T}^{\mathcal{D}}$. Monomials in planar rooted trees decorated by $\mathcal{D}$ in these algebra are called planar rooted forests decorated by $\mathcal{D}$. The set of planar rooted forests decorated by $\mathcal{D}$ will be denoted by $\mathbb{F}^{\mathcal{D}}$. Note that $\mathbb{F}^{\mathcal{D}}$ is a basis of $\mathcal{H}^{\mathcal{D}}$. if $\mathcal{D}$ is reduced to a single element, then $\mathbb{T}^{\mathcal{D}}$ can be identified with $\mathbb{T}$ and $\mathcal{H}^{\mathcal{D}}$ can be identified with $\mathcal{H}$.

## Examples.

1. Planar rooted forests of weight smaller than 4 :
2. Planar rooted forests decorated by $\{a, b\}$ of weight smaller than 2 :

$$
1, \bullet_{a}, \cdot{ }_{b}, \cdot{ }_{a} \cdot a, \cdot b \bullet a, \cdot a \bullet b, \bullet b \bullet b, \mathfrak{l}_{a}^{a}, \mathfrak{l}_{b}^{a}, \mathfrak{l}_{a}^{b}, \mathfrak{l}_{b}^{b}
$$

We now describe the Hoof algebra structure of $\mathcal{H}^{\mathcal{D}}$. Let $t \in \mathbb{T}^{\mathcal{D}}$. An admissible cut of $t$ is a nonempty cut such that every path in the tree meets at most one edge which is cut by $c$. The set of admissible cut of $t$ is denoted by $\mathcal{A} d m(t)$. An admissible cut $c$ of $t$ sends $t$ to a couple $\left(P^{c}(t), R^{c}(t)\right) \in \mathbb{F}^{\mathcal{D}} \times \mathbb{T}^{\mathcal{D}}$, such that $R^{c}(t)$ is the connected component of the root of $t$ after the application of $c$, and $P^{c}(t)$ is the planar forest of the other connected components (in the same order). Moreover, if $c_{v}$ is the empty cut of $t$, we put $P^{c_{v}}(t)=1$ et $R^{c_{v}}(t)=t$. We define the total cut of $t$ as a cut $c_{t}$ such that $P^{c_{t}}(t)=t$ and $R^{c_{t}}(t)=1$. We then put $\mathcal{A} d m_{*}(t)=\mathcal{A d m}(t) \cup\left\{c_{v}, c_{t}\right\}$.

We now take $F \in \mathbb{F}^{\mathcal{D}}, F \neq 1$. There exists $t_{1}, \ldots, t_{n} \in \mathbb{T}^{\mathcal{D}}$, such that $F=t_{1} \ldots t_{n}$. An admissible cut of $F$ is a $n$-uple $\left(c_{1}, \ldots, c_{n}\right)$ such that $c_{i} \in \mathcal{A} d m_{*}\left(t_{i}\right)$ for all $i$. If all $c_{i}$ 's are empty (resp. total), then $c$ is called the empty cut of $F$ (resp. the total cut of $F$ ). The set of admissible cuts of $F$ except the empty and the total cut is denoted by $\mathcal{A} d m(F)$. The set of all admissible cuts of $F$ is denoted by $\mathcal{A} d m_{*}(F)$. For $c=\left(c_{1}, \ldots, c_{n}\right) \in \mathcal{A} d m_{*}(F)$, we put $P^{c}(F)=P^{c_{1}}\left(t_{1}\right) \ldots P^{c_{n}}\left(t_{n}\right)$ and $R^{c}(F)=R^{c_{1}}\left(t_{1}\right) \ldots R^{c_{n}}\left(t_{n}\right)$.

The coproduct $\Delta: \mathcal{H}^{\mathcal{D}} \longrightarrow \mathcal{H}^{\mathcal{D}} \otimes \mathcal{H}^{\mathcal{D}}$ is defined in the following way: for all $F \in \mathbb{F}^{\mathcal{D}}$,

$$
\Delta(F)=F \otimes 1+1 \otimes F+\sum_{c \in \mathcal{A} d m(F)} P^{c}(F) \otimes R^{c}(F)=\sum_{c \in \mathcal{A} d m_{*}(F)} P^{c}(F) \otimes R^{c}(F) .
$$

Example. If $a, b, c, d, e \in \mathcal{D}$ :

The counit $\varepsilon$ is given by:

$$
\varepsilon:\left\{\begin{array}{rll}
\mathcal{H}^{\mathcal{D}} & \longrightarrow & K \\
F \in \mathbb{F}^{\mathcal{D}} & \longrightarrow & \delta_{F, 1} .
\end{array}\right.
$$

We proved in [ 8$]$ that $\mathcal{H}^{\mathcal{D}}$ is isomorphic to the free dendriform algebra generated by $\mathcal{D}$, which is described in 16, 21] in terms of planar binary trees. So the augmentation ideal $\mathcal{A}^{\mathcal{D}}$ of $\mathcal{H}^{\mathcal{D}}$ inherits a structure of dendriform algebra, also described in [8] with the help of another basis of $\mathcal{H}^{\mathcal{D}}$, introduced by duality. Hence, $\mathcal{A}^{\mathcal{D}}$ is freely generated by the $\cdot d^{\prime}$ 's, $d \in \mathcal{D}$, as a dendriform algebra. Here is an example of a computation of a product $\prec$ in $\mathcal{A}^{\mathcal{D}}$. For all $x \in \mathcal{A}^{\mathcal{D}}$,

$$
\cdot{ }_{d} \prec x=B_{d}^{+}(x),
$$

where $B_{d}^{+}: \mathcal{H}^{\mathcal{D}} \longrightarrow \mathcal{H}^{\mathcal{D}}$ is the linear application which send a forest $t_{1} \ldots t_{n}$ to the planar decorated tree obtained by grafting $t_{1}, \ldots, t_{n}$ on a common root decorated by $d$. (This comes from the description of $\prec$ in terms of graftings in [8] and proposition 36 of (7]).

As $\mathcal{H}^{\mathcal{D}}$ is self-dual $(\mathbb{7}), \mathcal{A}^{\mathcal{D}}$ is given a structure of codendriform bialgebra. The description in [8] of the left and right products in the dual basis of forests allows us to describe this structure with the following definition:

Definition 7 Let $F=t_{1} \ldots t_{n} \in \mathbb{F}^{\mathcal{D}}, F \neq 1$. The set $\mathcal{A} d m_{\prec}^{\prime}(F)$ is the set of cuts $\left(c_{1}, \ldots, c_{n}\right) \in \mathcal{A} d m(F)$ such that $c_{n}$ is the total cut of $t_{n}$ if $F$ is not a single tree, and $\emptyset$ otherwise. The set $\mathcal{A} d m_{\succ}^{\prime}(F)$ is $\mathcal{A} d m(F)-\mathcal{A} d m_{\prec}^{\prime}(F)$.

The dendriform coalgebra structure of $\mathcal{A}^{\mathcal{D}}$ is then given in the following way: For all $F \in$ $\mathbb{F}^{\mathcal{D}}-\{1\}$,

$$
\Delta_{\prec}^{\prime}(F)=\sum_{c \in \mathcal{A} d m_{\prec}(F)} P^{c}(F) \otimes R^{c}(F), \quad \Delta_{\succ}^{\prime}(F)=\sum_{c \in \mathcal{A} d m_{\succ}(F)} P^{c}(F) \otimes R^{c}(F) .
$$

The product of $\mathcal{A}^{\mathcal{D}}$ is the product induced by the product of $\mathcal{H}^{\mathcal{D}}$.

## Examples.

1. If $t \in \mathbb{T}^{\mathcal{D}}, \Delta_{\prec}^{\prime}(t)=0$.
2. If $a, b, c, d, e \in \mathcal{D}$.

$$
\begin{aligned}
& \Delta_{\prec}^{\prime}\left(\cdot{ }_{a}{ }_{a} Y_{b}^{c}{ }^{d}\right)={ }^{e} Y_{b}^{c}{ }_{b}^{d} \otimes \cdot{ }_{a},
\end{aligned}
$$

$$
\begin{aligned}
& +\cdot{ }_{a} \cdot \boldsymbol{e} \otimes \mathfrak{l}_{b}^{d}+\cdot \boldsymbol{e} \otimes{ }_{\cdot a} \mathfrak{l}_{b}^{d}+{ }_{\cdot a \cdot d} \otimes \mathfrak{l}_{b}^{e}+\cdot{ }_{d} \otimes \cdot{ }_{a} \mathfrak{l}_{b}^{e} .
\end{aligned}
$$

Moreover, $\mathcal{H}^{\mathcal{D}}$ can be graded. A set $\mathcal{D}$ is said to be graded when it is given an application


$$
|F|=\sum_{s \in \text { vert }(F)} \mid \text { decoration of } s \mid \text {, }
$$

where $\operatorname{vert}(F)$ is the set of vertices of $F$. Then $\mathcal{H}^{\mathcal{D}}$ is given a graded Hopf algebra structure and $\mathcal{A}^{\mathcal{D}}$ is given a graded (co)dendriform bialgebra structure by putting, for all $F \in \mathbb{F}^{\mathcal{D}}, F$ homogeneous of degree $|F|$. When $\mathcal{D}_{0}$ is empty and $\mathcal{D}_{n}$ is finite for all $n$, then the homogeneous parts of $\mathcal{A}^{\mathcal{D}}$ are finite-dimensional and $\left(\mathcal{A}^{\mathcal{D}}\right)_{0}=(0)$. Moreover, if those conditions occur, we have the following result:

Proposition 8 We consider the following formal series:

$$
D(X)=\sum_{n=1}^{+\infty} \operatorname{card}\left(\mathcal{D}_{n}\right) X^{n}, \quad R(X)=\sum_{n=0}^{+\infty} \operatorname{dim}\left(\mathcal{H}_{n}^{\mathcal{D}}\right) X^{n}
$$

Then $R(X)=\frac{1-\sqrt{1-4 D(X)}}{2 D(X)}$.

Proof. Similar to the proof of theorem 75 of [6].

## 2 Bidendiform bialgebras

### 2.1 Definition

We now introduce the notion of bidendriform bialgebra. A bidendriform bialgebra is both a dendriform bialgebra and a codendriform bialgebra, with some compatibilities.

Definition 9 A bidendriform bialgebra is a family $\left(A, \prec, \succ, \Delta_{\prec}, \Delta_{\succ}\right)$ such that:

1. $(A, \prec, \succ)$ is a dendriform algebra.
2. $\left(A, \Delta_{\prec}, \Delta_{\succ}\right)$ is a dendriform coalgebra.
3. The following compatibilities are satisfied: for all $a, b \in A$,

$$
\begin{align*}
\Delta_{\succ}(a \succ b) & =a^{\prime} b_{\succ}^{\prime} \otimes a^{\prime \prime} \succ b_{\succ}^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} \succ b+b_{\succ}^{\prime} \otimes a \succ b_{\succ}^{\prime \prime}+a b_{\succ}^{\prime} \otimes b_{\succ}^{\prime \prime}+a \otimes b,  \tag{12}\\
\Delta_{\succ}(a \prec b) & =a^{\prime} b_{\succ}^{\prime} \otimes a^{\prime \prime} \prec b_{\succ}^{\prime \prime}+a^{\prime} \otimes a^{\prime \prime} \prec b+b_{\succ}^{\prime} \otimes a \prec b_{\succ}^{\prime \prime}  \tag{13}\\
\Delta_{\prec}(a \succ b) & =a^{\prime} b_{\prec}^{\prime} \otimes a^{\prime \prime} \succ b_{\prec}^{\prime \prime}+a b_{\prec}^{\prime} \otimes b_{\prec}^{\prime \prime}+b_{\prec}^{\prime} \otimes a \succ b_{\prec}^{\prime \prime}  \tag{14}\\
\Delta_{\prec}(a \prec b) & =a^{\prime} b_{\prec}^{\prime} \otimes a^{\prime \prime} \prec b_{\prec}^{\prime \prime}+a^{\prime} b \otimes a^{\prime \prime}+b_{\prec}^{\prime} \otimes a \prec b_{\prec}^{\prime \prime}+b \otimes a . \tag{15}
\end{align*}
$$

## Remarks.

1. $(13)+(15)$ and (12) $+(14)$ are equivalent to $(7)$ and (8), so a bidendriform bialgebra is a special dendriform bialgebra.
2. (12) $+(13)$ and $(14)+(15)$ are equivalent to (10) and (11), so a bidendriform bialgebra is a special codendriform bialgebra.
3. If $A$ is a graded bidendriform bialgebra, such that its homogeneous parts are finitedimensional, then $\left(A^{* g}, \Delta_{\prec}^{*}, \Delta_{\succ}^{*}, \prec^{*}, \succ^{*}\right)$ is also a graded bidendriform bialgebra, as the transposes of (12) and (15) are themselves, and (13) and (14) are transposes from each other.

### 2.2 Totally primitive elements

We here give several results which will be useful to prove theorem 21.

First part. Let $A$ be a dendriform coalgebra. We define inductively:

$$
\Delta_{\prec}^{0}=I d, \quad \Delta_{\prec}^{1}=\Delta_{\prec}, \quad \Delta_{\prec}^{n}=(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-1}) \circ \Delta_{\prec}^{n-1} .
$$

For all $n \in \mathbb{N}, \Delta_{\prec}^{n}: A \longrightarrow A^{\otimes(n+1)}$.
Lemma 10 For all $n \in \mathbb{N}^{*}, i \in\{2, \ldots, n\}$,

$$
\begin{array}{r}
(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-1}) \circ \Delta_{\prec}^{n-1}=\Delta_{\prec}^{n}, \\
(\underbrace{I d \otimes \ldots \otimes I d}_{i-1} \otimes \tilde{\Delta} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i}) \circ \Delta_{\prec}^{n-1}=\Delta_{\prec}^{n} .
\end{array}
$$

Proof. The first equality is a consequence of the definition of $\Delta_{\prec}$. Let us show the second one. By ( $\ddagger$ ):

$$
\begin{aligned}
& (\underbrace{I d \otimes \ldots \otimes I d}_{i-1} \otimes \tilde{\Delta} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i}) \circ \Delta_{\prec}^{n-1} \\
& =(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-1}) \circ \ldots \circ(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i+2}) \\
& \circ(\left((I d \otimes \tilde{\Delta}) \circ \Delta_{\prec}\right) \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i}) \circ \Delta_{\prec}^{n-i} \\
& =(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-1}) \circ \ldots \circ(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i+2}) \\
& \circ(\left(\left(\Delta_{\prec} \otimes I d\right) \circ \Delta_{\prec}\right) \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i}) \circ \Delta_{\prec}^{n-i} \\
& =(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-1}) \circ \ldots \circ(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i+2}) \\
& \circ(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i+1}) \circ(\Delta_{\prec} \otimes \underbrace{I d \otimes \ldots \otimes I d}_{n-i}) \circ \Delta_{\prec}^{n-i} \\
& =\Delta_{\prec}^{n} .
\end{aligned}
$$

Lemma 11 Let $a \in A$, such that $\Delta_{\prec}^{n}(a)=0$. Then $\Delta_{\prec}^{n-1}(a) \in \operatorname{Prim}_{\prec}(A) \otimes \operatorname{Prim}(A)^{\otimes(n-1)}$.
Proof. By lemma 10, $\Delta_{\prec}^{n-1}(a)$ vanishes under $\Delta_{\prec} \otimes I d^{\otimes(n-1)}$, so belongs to $\operatorname{Prim} \prec_{\prec}(A) \otimes$ $A^{\otimes(n-1)}$. Moreover, if $i \geq 2, \Delta_{\prec}^{n-1}(a)$ vanishes under $I d^{\otimes(i-1)} \otimes \tilde{\Delta} \otimes I d^{\otimes(n-i)}$, so belongs to $A^{\otimes(i-1)} \otimes \operatorname{Prim}(A) \otimes A^{\otimes(n-i)}$.

Suppose now that $A$ is a bidendriform bialgebra. Let $a_{1}, \ldots, a_{n} \in A$. We define inductively:

$$
\begin{aligned}
\omega\left(a_{1}\right) & =a_{1} \\
\omega\left(a_{1}, a_{2}\right) & =a_{2} \prec a_{1} \\
\omega\left(a_{1}, \ldots, a_{n}\right) & =a_{n} \prec \omega\left(a_{1}, \ldots, a_{n-1}\right) .
\end{aligned}
$$

Lemma 12 Let $a_{1} \in \operatorname{Prim}_{\prec}(A)$ and $a_{2}, \ldots, a_{n} \in \operatorname{Prim}(A)$. Let $k \in \mathbb{N}$. Then:

$$
\Delta_{\prec}^{k}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right)=\sum_{1 \leq i_{1}<i_{2}<\ldots<i_{k}<n} \omega\left(a_{1}, \ldots, a_{i_{1}}\right) \otimes \ldots \otimes \omega\left(a_{i_{k}+1}, \ldots, a_{n}\right)
$$

In particular:

$$
\left\{\begin{aligned}
\Delta_{\prec}^{n-1}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right) & =a_{1} \otimes \ldots \otimes a_{n}, \\
\Delta_{\prec}^{k}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right) & =0 \text { if } k \geq n .
\end{aligned}\right.
$$

Proof. By induction on $k$. It is immediate for $k=0$. Let us show the result for $k=1$ by induction on $n$. It is obvious for $n=1$. We suppose that $n \geq 2$. As $a_{n} \in \operatorname{Prim}(A)$, we have, by (15):

$$
\begin{aligned}
\Delta_{\prec}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right) & =\omega\left(a_{1}, \ldots, a_{n-1}\right)_{\prec}^{\prime} \otimes a_{n} \prec \omega\left(a_{1}, \ldots, a_{n-1}\right)_{\prec}^{\prime \prime}+\omega\left(a_{1}, \ldots, a_{n-1}\right) \otimes a_{n} \\
& =\sum_{1 \leq i<n-2} \omega\left(a_{1}, \ldots, a_{i}\right) \otimes a_{n} \prec \omega\left(a_{i+1}, \ldots, a_{n-1}\right)+\omega\left(a_{1}, \ldots, a_{n-1}\right) \otimes a_{n} \\
& =\sum_{1 \leq i<n-2} \omega\left(a_{1}, \ldots, a_{i}\right) \otimes \omega\left(a_{i+1}, \ldots, a_{n-1}, a_{n}\right)+\omega\left(a_{1}, \ldots, a_{n-1}\right) \otimes a_{n} \\
& =\sum_{1 \leq i<n-1} \omega\left(a_{1}, \ldots, a_{i}\right) \otimes \omega\left(a_{i+1}, \ldots, a_{n}\right) .
\end{aligned}
$$

We suppose that the result is true at rank $k$. Then:

$$
\begin{aligned}
& =\sum_{1 \leq i_{1}<i_{2}<\ldots<i_{k}<n}^{\Delta_{\prec}^{k+1}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right)} \Delta_{\prec}\left(\omega\left(a_{1}, \ldots, a_{i_{1}}\right)\right) \otimes \omega\left(a_{i_{1}+1}, \ldots a_{i_{2}}\right) \otimes \ldots \otimes \omega\left(a_{i_{k}+1}, \ldots, a_{n}\right) \\
& =\sum_{1 \leq i_{1}<i_{2}<\ldots<i_{k+1}<n} \omega\left(a_{1}, \ldots, a_{i_{1}}\right) \otimes \ldots \otimes \omega\left(a_{i_{k+1}+1}, \ldots, a_{n}\right) . \square
\end{aligned}
$$

For all $a \in A$, we put $N_{\prec}(a)=\inf \left\{n \in \mathbb{N} / \Delta_{\prec}^{n-1}(a)=0\right\} \in \mathbb{N} \cup\{+\infty\}$.
Lemma 13 Let $a \in A$, such that $N_{\prec}(a)$ is finite. Then a can be written as a linear span of terms $\omega\left(a_{1}, \ldots, a_{n}\right), n \leq N_{\prec}(a), a_{1} \in \operatorname{Prim}_{\prec}(A), a_{2}, \ldots, a_{n} \in \operatorname{Prim}(A)$.

Proof. By induction on $n=N_{\prec}(a)$. If $n=0$, then $a=0$. If $n=1$, then $a \in \operatorname{Prim}_{\prec}(A)$ and the result is obvious. Suppose $n \geq 2$. By lemma 11, we then put:

$$
\Delta_{\prec}^{n-1}(a)=\sum a_{1} \otimes \ldots \otimes a_{n} \in \operatorname{Prim}_{\prec}(A) \otimes \operatorname{Prim}(A)^{\otimes(n-1)}
$$

By lemma 12, $\Delta_{\prec}^{n-1}\left(a-\sum \omega\left(a_{1}, \ldots, a_{n}\right)\right)=0$. The induction hypothesis applied to $a-$ $\sum \omega\left(a_{1}, \ldots, a_{n}\right)$ gives the result.

Second part. Suppose that $A$ is a dendriform coalgebra. We define inductively:

$$
\tilde{\Delta}^{0}=I d, \quad \tilde{\Delta}^{1}=\tilde{\Delta}, \quad \tilde{\Delta}^{n}=(\underbrace{I d \otimes \ldots \otimes I d}_{n-1} \otimes \tilde{\Delta}) \circ \tilde{\Delta}^{n-1} .
$$

For all $n \in \mathbb{N}, \tilde{\Delta}^{n}: A \longrightarrow A^{\otimes(n+1)}$. Note that $\tilde{\Delta}^{n}$ could be defined for any coassociative coalgebra $(A, \tilde{\Delta})$.

Lemma 14 Let $a \in \operatorname{Prim}_{\prec}(A)$. Then for all $n \in \mathbb{N}, \tilde{\Delta}^{n}(a) \in A^{\otimes n} \otimes \operatorname{Prim}_{\prec}(A)$.
Proof. It is obvious if $n=0$. Suppose $n \geq 1$. By (5):

$$
\begin{aligned}
\left(I d \otimes \Delta_{\prec}\right) \circ \tilde{\Delta} & =\left(I d \otimes \Delta_{\prec}\right) \circ \Delta_{\prec}+\left(I d \otimes \Delta_{\prec}\right) \circ \Delta_{\succ} \\
& =\left(I d \otimes \Delta_{\prec}\right) \circ \Delta_{\prec}+\left(\Delta_{\succ} \otimes I d\right) \circ \Delta_{\prec} \\
& =\left(I d \otimes \Delta_{\prec}+\Delta_{\succ} \otimes I d\right) \circ \Delta_{\prec} .
\end{aligned}
$$

By coassociativity of $\tilde{\Delta}$, we have:

$$
\begin{aligned}
\left(I d^{\otimes n} \otimes \Delta_{\prec}\right) \circ \tilde{\Delta}^{n}(a) & =\left(\tilde{\Delta}^{n-1} \otimes I d \otimes I d\right) \circ\left(I d \otimes \Delta_{\prec}\right) \circ \tilde{\Delta}(a) \\
& =\left(\tilde{\Delta}^{n-1} \otimes I d \otimes I d\right) \circ\left(I d \otimes \Delta_{\prec}+\Delta_{\succ} \otimes I d\right) \circ \Delta_{\prec}(a) \\
& =0 .
\end{aligned}
$$

Hence, $\tilde{\Delta}^{n}(a) \in A^{\otimes n} \otimes \operatorname{Prim}_{\prec}(A)$.

Lemma 15 Let $a \in A$, such that $\tilde{\Delta}^{n}(a)=0$. Then $\tilde{\Delta}^{n-1}(a) \in \operatorname{Prim}(A)^{\otimes n}$. Moreover, if $a \in \operatorname{Prim}_{\prec}(a)$, then $\tilde{\Delta}^{n-1}(a) \in \operatorname{Prim}(A)^{\otimes(n-1)} \otimes \operatorname{Prim}_{\text {tot }}(A)$.

Proof. By coassociativity of $\tilde{\Delta}$, for all $i \in\{1, \ldots, n\}$ :

$$
\left(I d^{\otimes(i-1)} \otimes \tilde{\Delta} \otimes I d^{\otimes(n-i)}\right) \circ \tilde{\Delta}^{n-1}(a)=\tilde{\Delta}^{n}(a)=0,
$$

so $\tilde{\Delta}^{n-1}(a) \in \operatorname{Prim}(A)^{\otimes n}$. The second assertion comes from lemma 14
Suppose now that $A$ is a bidendriform bialgebra. Let $a_{1}, \ldots, a_{n} \in A$. We define inductively:

$$
\begin{aligned}
\omega^{\prime}\left(a_{1}\right) & =a_{1}, \\
\omega^{\prime}\left(a_{1}, a_{2}\right) & =a_{1} \succ a_{2}, \\
\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right) & =\omega^{\prime}\left(a_{1}, \ldots, a_{n-1}\right) \succ a_{n} .
\end{aligned}
$$

Lemma 16 Let $a_{1}, \ldots, a_{n} \in \operatorname{Prim}(A)$. Let $k \in \mathbb{N}$. Then:

$$
\tilde{\Delta}^{k}\left(\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right)\right)=\sum_{1 \leq i_{1}<i_{2}<\ldots<i_{k}<n} \omega^{\prime}\left(a_{1}, \ldots, a_{i_{1}}\right) \otimes \ldots \otimes \omega^{\prime}\left(a_{i_{k}+1}, \ldots, a_{n}\right) .
$$

In particular:

$$
\left\{\begin{aligned}
\tilde{\Delta}^{n-1}\left(\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right)\right) & =a_{1} \otimes \ldots \otimes a_{n}, \\
\tilde{\Delta}^{k}\left(\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right)\right) & =0 \text { if } k \geq n .
\end{aligned}\right.
$$

Moreover, if $a_{n} \in \operatorname{Prim}_{\text {tot }}(A)$, then $\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right) \in \operatorname{Prim}_{\prec}(A)$.
Proof. By induction on $k$. It is immediate if $k=0$. Let us show the result for $k=1$ by induction on $n$. It is obvious for $n=1$. Suppose $n \geq 2$. As $a_{n} \in \operatorname{Prim}(A)$, by (8):

$$
\begin{aligned}
\tilde{\Delta}\left(\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right)\right) & =\omega^{\prime}\left(a_{1}, \ldots, a_{n-1}\right)^{\prime} \otimes \omega^{\prime}\left(a_{1}, \ldots, a_{n-1}\right)^{\prime \prime} \succ a_{n}+\omega\left(a_{1}, \ldots, a_{n-1}\right) \otimes a_{n}, \\
& =\sum_{1 \leq i<n-2} \omega^{\prime}\left(a_{1}, \ldots, a_{i}\right) \otimes \omega^{\prime}\left(a_{i+1}, \ldots, a_{n-1}\right) \succ a_{n}+\omega^{\prime}\left(a_{1}, \ldots, a_{n-1}\right) \otimes a_{n} \\
& =\sum_{1 \leq i<n-2} \omega^{\prime}\left(a_{1}, \ldots, a_{i}\right) \otimes \omega^{\prime}\left(a_{i+1}, \ldots, a_{n-1}, a_{n}\right)+\omega^{\prime}\left(a_{1}, \ldots, a_{n-1}\right) \otimes a_{n} \\
& =\sum_{1 \leq i<n-1} \omega^{\prime}\left(a_{1}, \ldots, a_{i}\right) \otimes \omega^{\prime}\left(a_{i+1}, \ldots, a_{n}\right) .
\end{aligned}
$$

Suppose that the result is true at rank $k$. Then:

$$
\begin{aligned}
& \tilde{\Delta}^{k+1}\left(\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right)\right) \\
&= \sum_{1 \leq i_{1}<i_{2}<\ldots<i_{k}<n} \tilde{\Delta}\left(\omega^{\prime}\left(a_{1}, \ldots, a_{i_{1}}\right)\right) \otimes \omega^{\prime}\left(a_{i_{1}+1}, \ldots a_{i_{2}}\right) \otimes \ldots \otimes \omega^{\prime}\left(a_{i_{k}+1}, \ldots, a_{n}\right) \\
& \sum_{1 \leq i_{1}<i_{2}<\ldots<i_{k+1}<n} \omega^{\prime}\left(a_{1}, \ldots, a_{i_{1}}\right) \otimes \ldots \otimes \omega^{\prime}\left(a_{i_{k+1}+1}, \ldots, a_{n}\right) .
\end{aligned}
$$

Suppose $a_{n} \in \operatorname{Prim}_{\prec}(A)$. By (14), by putting $x=\omega^{\prime}\left(a_{1}, \ldots, a_{n-1}\right), \Delta_{\prec}\left(\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right)\right)=$ $\Delta_{\prec}\left(x \succ a_{n}\right)=0$. So $\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right) \in \operatorname{Prim}_{\prec}(A)$.

For all $a \in A$, we put $N(a)=\inf \left\{n \in \mathbb{N} / \tilde{\Delta}^{n-1}(a)=0\right\} \in \mathbb{N} \cup\{+\infty\}$.

Lemma 17 Let $a \in \operatorname{Prim}_{\prec}(A)$, such that $N(a)$ is finite. Then a can be written as a linear span of terms $\omega^{\prime}\left(a_{1}, \ldots, a_{n}\right), n \leq N(a), a_{1}, \ldots, a_{n-1} \in \operatorname{Prim}(A), a_{n} \in \operatorname{Prim}_{t o t}(A)$.

Proof. Induction on $n=N(a)$. If $n=0$, then $a=0$. If $n=1$, then $a \in \operatorname{Prim}_{t o t}(A)=$ $\operatorname{Prim}(A) \cap \operatorname{Prim}_{\prec}(A)$. Suppose that $n \geq 2$ and put, by lemma 15:

$$
\tilde{\Delta}^{n-1}(a)=\sum a_{1} \otimes \ldots \otimes a_{n} \in \operatorname{Prim}(A)^{\otimes(n-1)} \otimes \operatorname{Prim}_{t o t}(A)
$$

We put $a^{\prime}=a-\sum \omega^{\prime}\left(a_{1}, \ldots, a_{n}\right)$. By lemma 16, $a^{\prime} \in \operatorname{Prim}_{\prec}(A)$ and $N\left(a^{\prime}\right)<n$. Hence, $a^{\prime}$ satisfies the induction hypothesis, so the result is true for $a$.

### 2.3 Connected bidendriform bialgebras

We prove in this paragraph that if $A$ is a connected (definition 18) bidendriform bialgebra, it is generated by its totally primitive elements (theorem 21).

Let $C$ be a dendriform coalgebra. We define inductively:

\begin{aligned}
\mathcal{P}_{C}(0)= & \left\{I d_{C}\right\} \subseteq \mathcal{L}(C) \\
\mathcal{P}_{C}(1)= & \left\{\Delta_{\prec}, \Delta_{\succ}\right\} \subseteq \mathcal{L}\left(C, C^{\otimes 2}\right) \\
\mathcal{P}_{C}(n)= & \left\{\left(I d^{\otimes(i-1)} \otimes \Delta_{\prec} \otimes I d^{\otimes(n-i)}\right) \circ P / P \in \mathcal{P}_{C}(n-1), 1 \leq i \leq n\right\} \\
& \cup\left\{\left(I d^{\otimes(i-1)} \otimes \Delta_{\succ} \otimes I d^{\otimes(n-i)}\right) \circ P / P \in \mathcal{P}_{C}(n-1), 1 \leq i \leq n\right\} \subseteq \mathcal{L}\left(C, C^{\otimes(n+1)}\right) .
\end{aligned}
$$

## Definition 18

1. Let $C$ be a dendriform coalgebra. It is said connected if, for all $a \in C$, there exists $n_{a} \in \mathbb{N}$, such that for all $P \in \mathcal{P}_{C}\left(n_{a}\right), P(a)=0$.
2. Let $C$ be a connected dendriform coalgebra. For all $a \in C$, we put:

$$
\operatorname{deg}_{p}(a)=\inf \left\{n \in \mathbb{N} / \forall P \in \mathcal{P}_{C}(n), P(a)=0\right\} \in \mathbb{N}
$$

3. Let $C$ be a connected dendriform coalgebra. For all $n \in \mathbb{N}$, we put:

$$
C^{\leq n}=\left\{a \in C / \operatorname{deg}_{p}(a) \leq n\right\}
$$

Then $C^{\leq 0}=(0), C^{\leq 1}=\operatorname{Prim}_{t o t}(C)$, and $\left(C^{\leq n}\right)_{n \in \mathbb{N}}$ is a increasing filtration.

## Remarks.

1. For all $n \in \mathbb{N}, \Delta_{\prec}^{n} \in \mathcal{P}_{C}(n)$ et $\tilde{\Delta}^{n} \in \operatorname{Vect}\left(\mathcal{P}_{C}(n)\right)$. Hence, if $C$ is connected, then for all $a \in C, N_{\prec}(a)$ and $N(a)$ are finite and smaller than $d e g_{p}(a)$.
2. Let $C$ be a $\mathbb{N}$-graded dendriform coalgebra, such that $C_{0}=(0)$ (the homogeneous parts of $C$ may not be finite-dimensional). Then $C$ is connected, as, for all $a \in C_{n}$, for all $P \in \mathcal{P}(n)$ :

$$
P(a) \in \bigoplus_{k_{1}+\ldots+k_{n+1}=n} C_{k_{1}} \otimes \ldots \otimes C_{k_{n+1}}=(0)
$$

Moreover, for all $a \in C, \operatorname{deg}_{p}(a) \leq|a|$, where $|a|$ is the degree of $a$ for the gradation of $C$.

Lemma 19 Let $C$ be a connected dendriform coalgebra. For all $n \geq 1$ :

$$
\begin{aligned}
\Delta_{\prec}\left(C^{\leq n}\right) & \subseteq C^{\leq n-1} \otimes C^{\leq n-1} \\
\Delta_{\succ}\left(C^{\leq n}\right) & \subseteq C^{\leq n-1} \otimes C^{\leq n-1} \\
\tilde{\Delta}\left(C^{\leq n}\right) & \subseteq C^{\leq n-1} \otimes C^{\leq n-1}
\end{aligned}
$$

Proof. Let $a \in C^{\leq n}$. Let $P \in \mathcal{P}_{C}(n-1)$. Then $(P \otimes I d) \circ \Delta_{\prec} \in \mathcal{P}_{C}(n)$, so:

$$
(P \otimes I d) \circ \Delta_{\prec}(a)=0
$$

Hence, $\Delta_{\prec}(a) \in C^{\leq n-1} \otimes C$. In the same way, we obtain $\Delta_{\prec}(a) \in C \otimes C^{\leq n-1}$ by considering $(I d \otimes P) \circ_{\tilde{\sim}} \Delta_{\prec}$, so $\Delta_{\prec}(a) \in C^{\leq n-1} \otimes C^{\leq n-1}$. The procedure is the same for $\Delta_{\succ}(a)$, and the result for $\tilde{\Delta}(a)$ is obtained by addition.

The following lemma is now immediate:
Lemma 20 Let $C$ be a connected dendriform coalgebra and $k, n \in \mathbb{N}^{*}$. Then:

$$
\Delta_{\prec}^{k}\left(C^{\leq n}\right) \subseteq\left(C^{\leq n-1}\right)^{\otimes(k+1)}, \quad \tilde{\Delta}^{k}\left(C^{\leq n}\right) \subseteq\left(C^{\leq n-1}\right)^{\otimes(k+1)}
$$

Theorem 21 Let $A$ be a connected (as a dendriform coalgebra) bidendriform bialgebra. Then $A$ is generated (as a dendriform algebra) by $\operatorname{Prim}_{\text {tot }}(A)$.

Proof. Let $B$ be the dendriform subalgebra of $A$ generated by $\operatorname{Prim}_{t o t}(A)$. Let $a \in A$. We denote $\operatorname{deg}_{p}(a)=n$. Let us show that $a \in B$ by induction on $n$. If $n=0$, then $a=0 \in B$. If $n=1$, then $a \in \operatorname{Prim}_{t o t}(A) \subseteq B$. Suppose $n \geq 2$. As $A$ is connected, by remark 1 after definition 18, $N_{\prec}(a)=k$ is finite and smaller than $n$. By lemma 13, we can suppose $a=\omega\left(a_{1}, \ldots, a_{k}\right)$, $k \leq n, a_{1} \in \operatorname{Prim}_{\prec}(A), a_{2}, \ldots, a_{k} \in \operatorname{Prim}(A)$. We have two different cases.

1. If $k \geq 2$, by lemma 20, $\Delta_{\prec}^{k-1}\left(\omega\left(a_{1}, \ldots, a_{k}\right)\right)=a_{1} \otimes \ldots \otimes a_{k} \in\left(A^{\leq n-1}\right)^{\otimes k}$, so, for all $i$, $\operatorname{deg}_{p}\left(a_{i}\right)<n$, so $a_{i} \in B$. Hence, $a \in B$.
2. If $k=1$, then $a \in \operatorname{Prim}_{\prec}(A)$. As $A$ is connected, by remark 1 after definition 18, $N(a)=l$ is finite ans smaller than $n$. By lemma 17, we can suppose $a=\omega^{\prime}\left(b_{1}, \ldots, b_{l}\right)$, $l \leq n, b_{1}, \ldots, b_{l-1} \in \operatorname{Prim}(A), b_{l} \in \operatorname{Prim}_{t o t}(A)$. We have two different cases.
(a) If $l \geq 2$, by lemma 20, $\tilde{\Delta}^{l-1}\left(\omega^{\prime}\left(b_{1}, \ldots, b_{l}\right)\right)=b_{1} \otimes \ldots \otimes b_{l} \in\left(A^{\leq n-1}\right)^{\otimes l}$, so, for all $i$, $\operatorname{deg}_{p}\left(b_{i}\right)<n$, so $b_{i} \in B$. Hence, $a \in B$.
(b) If $l=1$, then $a=b_{1} \in \operatorname{Prim}_{t o t}(A) \subseteq B$.

### 2.4 Projections on $\operatorname{Prim}_{\prec}(A)$ and $\operatorname{Prim}_{\text {tot }}(A)$

We here define an eulerian idempotent for connected bidendriform bialgebras.

Let $A$ be a bidendriform bialgebra. We put:

$$
A^{D 2}=\operatorname{Vect}(x \prec y, x \succ y / x, y \in A)
$$

We define $m_{\prec}^{n}: A^{\otimes n} \longrightarrow A$ inductively:

$$
\begin{aligned}
m_{\prec}^{1}\left(a_{1}\right) & =a_{1}, \\
m_{\prec}^{2}\left(a_{1} \otimes a_{2}\right) & =a_{2} \prec a_{1}, \\
m_{\prec}^{n}\left(a_{1} \otimes \ldots \otimes a_{n}\right) & =m_{\prec}^{n-1}\left(a_{2} \otimes \ldots \otimes a_{n}\right) \prec a_{1} .
\end{aligned}
$$

Proposition 22 Let $A$ be a bidendriform bialgebra such that for all $a \in A, N_{\prec}(a)$ is finite. We consider the following application:

$$
T_{1}:\left\{\begin{array}{rll}
A & \longrightarrow & A \\
a & \longrightarrow & \sum_{k=1}^{+\infty}(-1)^{k+1} m_{\prec}^{k} \circ \Delta_{\prec}^{k-1}(a) .
\end{array}\right.
$$

Then $T_{1}$ is a projection on $\operatorname{Prim}_{\prec}(A)$. Moreover, for all $a \in A, T_{1}(a)=a+A^{D 2}$.
Proof. Remark first that $T_{1}$ is well defined, as for all $a \in A, \Delta_{\prec}^{k-1}(a)=0$ for $k$ great enough. Let us show that $T_{1}(a) \in \operatorname{Prim}_{\prec}(A)$ for all $a$. By lemma 13, we can suppose $a=\omega\left(a_{1}, \ldots, a_{n}\right)$, avec $a_{1} \in \operatorname{Prim}_{\prec}(A), a_{2}, \ldots, a_{n} \in \operatorname{Prim}(A)$. If $n=1$, then $T_{1}(a)=a_{1} \in \operatorname{Prim}_{\prec}(A)$. Suppose $n \geq 2$.

We consider the following binary trees: for all $k \in \mathbb{N}$,


Then $m_{\prec}^{k}$ and $\omega$ can be graphically represented in the following way:

$$
\left\{\begin{aligned}
\omega\left(x_{1}, \ldots, x_{k}\right) & =t_{k}^{(d)} \cdot x_{k} \otimes \ldots \otimes x_{1} \\
m_{\prec}^{k}\left(x_{1} \otimes \ldots \otimes x_{k}\right) & =t_{k}^{(g)} \cdot x_{k} \otimes \ldots \otimes x_{1}
\end{aligned}\right.
$$

By lemma 12, we have:

$$
\Delta_{\prec}^{k-1}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right)=\sum_{n_{1}+\ldots+n_{k}=n} t_{n_{1}}^{(d)} \cdot\left(a_{n_{1}} \otimes \ldots \otimes a_{1}\right) \otimes \ldots \otimes t_{n_{k}}^{(d)} \cdot\left(a_{n} \otimes \ldots \otimes a_{n_{1}+\ldots+n_{k-1}+1}\right)
$$

(The $n_{i}$ 's are positive, non zero integers). Then:

$$
T_{1}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right)=\sum_{k=1}^{+\infty} \sum_{n_{1}+\ldots+n_{k}=n}(-1)^{k+1} t_{n_{1}, \ldots, n_{k}} \cdot\left(a_{n} \otimes \ldots \otimes a_{1}\right)
$$

where the $n_{i}$ 's are positive, non zero integers and $t_{n_{1}, \ldots, n_{k}}$ is the following tree:


As $t_{1, n_{2}, \ldots, n_{k}}=t_{1+n_{2}, \ldots, n_{k}}$, we obtain:

$$
\begin{aligned}
T_{1}\left(\omega\left(a_{1}, \ldots, a_{n}\right)\right)= & \sum_{k=1}^{+\infty} \sum_{\substack{n_{1}+\ldots+n_{k}=n, n_{1} \geq 2}}(-1)^{k+1} t_{n_{1}, \ldots, n_{k}} \cdot\left(a_{n} \otimes \ldots \otimes a_{1}\right) \\
& +\sum_{k=1}^{+\infty} \sum_{\substack{n_{1}+\ldots+n_{k}=n-1}}(-1)^{k+2} t_{1, n_{1}, \ldots, n_{k}} \cdot\left(a_{n} \otimes \ldots \otimes a_{1}\right) \\
= & \sum_{k=1}^{+\infty} \sum_{\substack{n_{1}+\ldots+n_{k}=n, n_{1} \geq 2}}(-1)^{k+1} t_{n_{1}, \ldots, n_{k}} \cdot\left(a_{n} \otimes \ldots \otimes a_{1}\right) \\
& -\sum_{k=1}^{+\infty} \sum_{\substack{n_{1}^{\prime}+\ldots+n_{k}=n, n_{1}^{\prime} \geq 2}}(-1)^{k+1} t_{n_{1}^{\prime}, \ldots, n_{k}} \cdot\left(a_{n} \otimes \ldots \otimes a_{1}\right) \quad\left(\text { where } n_{1}^{\prime}=1+n_{1}\right) \\
= & 0 .
\end{aligned}
$$

Hence, $T_{1}(a) \in \operatorname{Prim}_{\prec}(A)$ for all $a \in A$. Moreover, if $a \in \operatorname{Prim}_{\prec}(A), T_{1}(a)=a$. So $T_{1}$ is a projection on $\operatorname{Prim}_{\prec}(A)$. Finally, for all $a \in A$, we have:

$$
T_{1}(a)=a+\sum_{k=2}^{+\infty}(-1)^{k+1} m_{\prec}^{k} \circ \Delta_{\prec}^{k-1}(a)=a+A^{D 2}
$$

We define $m_{\succ}^{n}: A^{\otimes n} \longrightarrow A$ inductively:

$$
\begin{aligned}
m_{\succ}^{1}\left(a_{1}\right) & =a_{1} \\
m_{\succ}^{2}\left(a_{1} \otimes a_{2}\right) & =a_{1} \succ a_{2} \\
m_{\succ}^{n}\left(a_{1} \otimes \ldots \otimes a_{n}\right) & =a_{1} \succ m_{\succ}^{n-1}\left(a_{2} \otimes \ldots \otimes a_{n}\right) .
\end{aligned}
$$

With lemmas 14 and 16, we can show the following proposition in the same way as proposition 22:

Proposition 23 Let $A$ be a bidendriform bialgebra such that for all $a \in \operatorname{Prim}_{\prec}(A), N(a)$ is finite. We consider the following application:

$$
T_{2}:\left\{\begin{array}{rll}
\operatorname{Prim}_{\prec}(A) & \longrightarrow & A \\
a & \longrightarrow & \sum_{k=1}^{+\infty}(-1)^{k+1} m_{\succ}^{k} \circ \tilde{\Delta}^{k-1}(a) .
\end{array}\right.
$$

Then $T_{2}$ is a projector from $\operatorname{Prim}_{\prec}(A)$ into $\operatorname{Prim}_{t o t}(A)$. Moreover, for all $a \in A, T_{2}(a)=$ $a+A^{D 2}$ 。

Corollary 24 Let $A$ be a bidendriform bialgebra such that for all $a \in A, N_{\prec}(a)$ is finite and for all $A \in \operatorname{Prim}_{\prec}(A), N(a)$ is finite (for example, $A$ is connected). We consider the application $T=T_{2} \circ T_{1}: A \longrightarrow A$. Then $T$ is a projection from $A$ into $\operatorname{Prim}_{t o t}(A)$. Moreover, for all $a \in A$, $T(a)=a+A^{D 2}$. So $A=\operatorname{Prim}_{t o t}(A)+A^{D 2}$.

Proof. Immediate, by composition.
Corollary 25 Let $A$ be a $\mathbb{N}$-graded bidendriform bialgebra, such that the homogeneous part of $A$ are finite-dimensional and $A_{0}=(0)$. Then $A=\operatorname{Prim}_{t o t}(A) \oplus A^{D 2}$.

Proof. Then $A$ is connected (remark 2 after definition 18). By corollary 24, $A=\operatorname{Prim}_{t o t}(A)+$ $A^{D 2}$. In the same way, the bidendriform bialgebra $A^{* g}$ is connected. We then have $A^{* g}=$ $\operatorname{Prim}_{t o t}\left(A^{* g}\right)+\left(A^{* g}\right)^{D 2}$. By taking the orthogonal:

$$
(0)=\left(A^{* g}\right)^{\perp}=\operatorname{Prim}_{t o t}\left(A^{* g}\right)^{\perp} \cap\left(\left(A^{* g}\right)^{D 2}\right)^{\perp}=A^{D 2} \cap \operatorname{Prim}_{t o t}(A)
$$

So $A=\operatorname{Prim}_{\text {tot }}(A) \oplus A^{D 2}$.

## 3 Tensor product and dendriform modules

### 3.1 Tensor product of dendriform algebras

We here show how the category of dendriform algebras can be given a structure of tensor category. As dendriform algebras are not objects with unit, we have to extend the usual tensor product in order to obtain a copy of $A$ and $B$ in the tensor product of $A$ and $B$.

Definition 26 Let $A, B$ be two vector spaces. Then:

$$
A \bar{\otimes} B=(A \otimes B) \oplus(K \otimes B) \oplus(A \otimes K) .
$$

Proposition 27 Let $A, B$ be two dendriform algebras. Then $A \bar{\otimes} B$ is given a structure of dendriform algebra in the following way: for all $a_{1}, a_{2} \in A, b_{1}, b_{2} \in B$,

$$
\begin{aligned}
\left(a_{1} \otimes b_{1}\right) \prec\left(a_{2} \otimes b_{2}\right) & =a_{1} \cdot a_{2} \otimes b_{1} \prec b_{2}, \\
\left(a_{1} \otimes b_{1}\right) \prec\left(a_{2} \otimes 1\right) & =a_{1} \cdot a_{2} \otimes b_{1}, \\
\left(a_{1} \otimes b_{1}\right) \prec\left(1 \otimes b_{2}\right) & =a_{1} \otimes b_{1} \prec b_{2}, \\
\left(a_{1} \otimes 1\right) \prec\left(a_{2} \otimes b_{2}\right) & =0, \\
\left(a_{1} \otimes 1\right) \prec\left(a_{2} \otimes 1\right) & =a_{1} \prec a_{2} \otimes 1, \\
\left(a_{1} \otimes 1\right) \prec\left(1 \otimes b_{2}\right) & =0, \\
\left(1 \otimes b_{1}\right) \prec\left(a_{2} \otimes b_{2}\right) & =a_{2} \otimes b_{1} \prec b_{2}, \\
\left(1 \otimes b_{1}\right) \prec\left(a_{2} \otimes 1\right) & =a_{2} \otimes b_{1}, \\
\left(1 \otimes b_{1}\right) \prec\left(1 \otimes b_{2}\right) & =1 \otimes b_{1} \prec b_{2},
\end{aligned}
$$

Proof. Direct computations.
Remark. $A \otimes K$ is a dendriform subalgebra of $A \bar{\otimes} B$ which is isomorphic to $A$ and $K \otimes B$ is a dendriform subalgebra of $A \bar{\otimes} B$ which is isomorphic to $B$.

Proposition 28 1. Let $A, B, C$ be unitary dendriform algebras. Then the following application is an isomorphism of dendriform algebras:

$$
\left\{\begin{array}{lll}
(A \bar{\otimes} B) \bar{\otimes} C & \longrightarrow & A \bar{\otimes}(B \bar{\otimes} C) \\
(a \otimes b) \otimes c & \longrightarrow & a \otimes(b \otimes c)
\end{array}\right.
$$

2. Let $A, A^{\prime}, B, B^{\prime}$ be unitary dendriform algebras and $\phi: A \longrightarrow A^{\prime}, \psi: B \longrightarrow B^{\prime}$ be morphisms of unitary dendriform algebras. We then define:

$$
\phi \bar{\otimes} \psi:\left\{\begin{array}{rl}
A \bar{\otimes} B & \longrightarrow \\
A^{\prime} \bar{\otimes} B^{\prime} \\
a \otimes b & \longrightarrow
\end{array} \phi(a) \otimes \psi(b),\right.
$$

for all $a \in A, b \in B$. Then $\phi \bar{\otimes} \psi$ is a morphism of dendriform algebras.
In other terms, the category of unitary dendriform algebras is a tensor category with $\bar{\otimes}$.
Proof. Direct computations.

We can now reformulate the axioms of bidendriform bialgebras. Let $(A, \prec, \succ)$ be a dendriform algebra and let $\Delta_{\prec}, \Delta_{\succ}: A \longrightarrow A \otimes A$. We put $\tilde{\Delta}=\Delta_{\prec}+\Delta_{\succ}$. We then define:

$$
\begin{aligned}
& \bar{\Delta}_{\prec}:\left\{\begin{array}{rll}
A \oplus K & \longrightarrow & A \bar{\otimes} A \\
a & \longrightarrow & \Delta_{\prec}(a)+a \otimes 1, \\
1 & \longrightarrow & 0,
\end{array}\right. \\
& \bar{\Delta}_{\succ}:\left\{\begin{array}{rll}
A \oplus K & \longrightarrow & A \bar{\otimes} A \\
a & \longrightarrow & \Delta_{\succ}(a)+1 \otimes a, \\
1 & \longrightarrow & 0,
\end{array}\right. \\
& \Delta:\left\{\begin{array}{rll}
A \oplus K & \longrightarrow & A \bar{\otimes} A \\
a & \longrightarrow & \tilde{\Delta}(a)+a \otimes 1+1 \otimes a, \\
1 & \longrightarrow & 0 .
\end{array}\right.
\end{aligned}
$$

Note that $\Delta=\bar{\Delta}_{\prec}+\bar{\Delta}_{\succ}$. We can easily prove the following assertions:

1. (4)-(6) for $\Delta_{\prec}$ and $\Delta_{\succ}$ are equivalent to (4)-(原) for $\bar{\Delta}_{\prec}$ and $\bar{\Delta}_{\succ}$.
2. (12)-(15) is equivalent to: for all $a, b \in A$,

$$
\begin{array}{rlrl}
\bar{\Delta}_{\succ}(a \succ b) & =\Delta(a) \succ \bar{\Delta}_{\succ}(b), & & \bar{\Delta}_{\prec}(a \succ b) \\
\bar{\Delta}_{\succ}(a \prec b) & =\Delta(a) \prec \bar{\Delta}_{\succ}(b), & \bar{\Delta}_{\prec}(a \prec b) & =\Delta(a) \prec \bar{\Delta}_{\prec}(b), \\
\prec & (b) .
\end{array}
$$

3. (8)-(7) is equivalent to: for all $a, b \in A$,

$$
\Delta(a \succ b)=\Delta(a) \succ \Delta(b), \quad \Delta(a \prec b)=\Delta(a) \prec \Delta(b)
$$

In other terms, (8)-(7) is equivalent to $\Delta: A \longrightarrow A \bar{\otimes} A$ is a morphism of dendriform algebras.

### 3.2 Dendriform modules

(See for example 19 for complements on operads). We denote by $\mathcal{P}_{\text {dend }}=\left(\mathcal{P}_{\text {dend }}(n)\right)_{n \in \mathbb{N}^{*}}$ the operad of dendriform algebras (we consider here non- $\Sigma$-operads, that is to say there is no action of the symmetric groups). In other words, $\mathcal{P}_{\text {dend }}$ is the operad generated by $\prec$ and $\succ \in \mathcal{P}_{\text {dend }}(2)$ and the following relations:

$$
\begin{aligned}
\prec \circ(\prec, I) & =\prec \circ(I, \prec+\succ), \\
\prec \circ(\succ, I) & =\succ \circ(I, \prec), \\
\succ \circ(\prec+\succ, I) & =\succ \circ(I, \succ) .
\end{aligned}
$$

Let $A$ be a dendriform algebra. A dendriform module over $A$ is a vector space $M$ together with applications, for all $n \in \mathbb{N}^{*}$ :

$$
\left\{\begin{aligned}
& \mathcal{P}_{\text {dend }}(n) \otimes A^{\otimes(n-1)} \otimes M \longrightarrow \\
& p \otimes\left(a_{1} \otimes \ldots \otimes a_{n-1}\right) \otimes m \longrightarrow \\
& p \cdot\left(a_{1} \otimes \ldots \otimes a_{n-1} \otimes m\right)
\end{aligned}\right.
$$

satisfying the same associativity relations and unit relation as those for $\mathcal{P}_{\text {dend }}$-algebras. In other terms, a dendriform module over $A$ is a vector space $M$ together with two applications:

$$
\dashv:\left\{\begin{array}{rl}
A \otimes M & \longrightarrow \\
a \otimes m & \longrightarrow \\
a \dashv m,
\end{array} \quad \vdash:\left\{\begin{aligned}
A \otimes M & \longrightarrow
\end{aligned}\right) M,\right.
$$

with the following compatibilities: for all $a, b \in A, m \in M$,

$$
\begin{align*}
(a \prec b) \dashv m & =a \dashv(b \dashv m+b \vdash m),  \tag{16}\\
(a \succ b) \dashv m & =a \vdash(b \dashv m),  \tag{17}\\
(a \prec b+a \succ b) \vdash m & =a \vdash(b \vdash m) . \tag{18}
\end{align*}
$$

(We have $a \dashv m=\prec .(a \otimes m)$ and $a \vdash m=\succ .(a \otimes m)$ ).

## Remarks.

1. If $M$ is a dendriform module over $A$, then $\dashv+\vdash$ gives $M$ a structure of left module over the associative algebra $(A, \prec+\succ)$ by $(16)+(\sqrt{17})+(18)$. This action will be denoted by $a . m=a \dashv m+a \vdash m$.
2. $A$ is a dendriform module over itself with $\dashv=\prec$ and $\vdash=\succ$.
3. Suppose that $A$ is a dendriform bialgebra. Then, as $\Delta$ is a morphism of dendriform algebras, $A \bar{\otimes} A$ is given a structure of a dendriform module over $A$ with, for all $a \in A$, $\sum b \otimes c \in A \bar{\otimes} A:$

$$
a \dashv\left(\sum b \otimes c\right)=\sum \Delta(a) \prec(b \otimes c), \quad a \vdash\left(\sum b \otimes c\right)=\sum \Delta(a) \succ(b \otimes c) .
$$

Moreover, $\Delta$ is a morphism of dendriform modules.
4. Let $(A, \prec, \succ, \tilde{\Delta})$ be a dendriform bialgebra and let $\Delta_{\prec,} \Delta_{\succ}: A \longrightarrow A \otimes A$. Observe that (12)-(15) is equivalent to: $\bar{\Delta}_{\prec}, \bar{\Delta}_{\succ}$ are morphisms of dendriform modules.

Proposition 29 Let $A$ be a free dendriform algebra generated by a subspace $V$ and let $M$ be a dendriform module over $A$. For any linear application $\phi: V \longrightarrow M$, there exists a unique morphism of dendriform modules $\Phi: A \longrightarrow M$, such that $\Phi_{\mid V}=\phi$.

## Proof.

Unicity. Because $V$ generates $A$ as a dendriform algebra, and hence as a dendriform module.
Existence. As $A$ is freely generated by $V$, we can suppose that $A=\bigoplus_{n \geq 1} \mathcal{P}_{\text {dend }}(n) \otimes V^{\otimes n}$. We then define:

$$
\Phi:\left\{\begin{aligned}
A & \longrightarrow M \\
p \otimes\left(v_{1} \otimes \ldots \otimes v_{n}\right) & \longrightarrow p \cdot\left(v_{1} \otimes \ldots \otimes v_{n-1} \otimes \phi\left(v_{n}\right)\right)
\end{aligned}\right.
$$

for all $p \in \mathcal{P}_{\text {dend }}(n), v_{1}, \ldots, v_{n} \in V$. Then $\Phi$ fits the asked conditions.

Proposition 30 Let $(A, \prec, \succ, \tilde{\Delta})$ be a dendriform bialgebra, with applications $\Delta_{\prec}, \Delta_{\succ}$ : $A \longrightarrow A \otimes A$. We put:

$$
\begin{aligned}
& \bar{\Delta}_{\prec}:\left\{\begin{array}{rll}
A & \longrightarrow & A \bar{\otimes} A \\
a & \longrightarrow & \Delta_{\prec}(a)+a \otimes 1,
\end{array}\right. \\
& \bar{\Delta}_{\succ}:\left\{\begin{array}{rll}
A & \longrightarrow & A \bar{\otimes} A \\
a & \longrightarrow & \Delta_{\succ}(a)+1 \otimes a,
\end{array}\right. \\
& \Delta:\left\{\begin{array}{rll}
A & \longrightarrow & A_{\otimes} A \\
a & \longrightarrow & \tilde{\Delta}(a)+a \otimes 1+1 \otimes a .
\end{array}\right. \\
& \Delta
\end{aligned}
$$

We suppose the following conditions:

1. $\left(A, \Delta_{\prec}, \Delta_{\succ}\right)$ satisfies relations (4), (5) and (6) on a set of generators of the dendriform algebra $A$. Moreover, $\Delta_{\prec}+\Delta_{\succ}=\tilde{\Delta}$ on this set of generators.
2. $\Delta_{\prec}$ and $\Delta_{\succ}$ are morphisms of $A$-dendriform modules.

Then $A$ is a bidendriform bialgebra.
Proof. Let us first show relation (4). We put $X=\{a \in A / a$ satisfies (\$) $)\}$. We have:

$$
\begin{aligned}
X & =\operatorname{Ker}\left(\left(\Delta_{\prec} \otimes I d\right) \circ \Delta_{\prec}-\left(I d \otimes \Delta_{\prec}+I d \otimes \Delta_{\succ}\right) \circ \Delta_{\prec}\right) \\
& =\operatorname{Ker}\left(\left(\bar{\Delta}_{\prec} \bar{\otimes} I d\right) \circ \bar{\Delta}_{\prec}-\left(I d \bar{\otimes} \bar{\Delta}_{\prec}+I d \bar{\otimes} \bar{\Delta}_{\succ}\right) \circ \bar{\Delta}_{\prec}\right)
\end{aligned}
$$

which is the kernel of a certain morphism of dendriform modules from $A$ into $A \bar{\otimes} A \bar{\otimes} A$ by hypothesis 2 . So $X$ is a dendriform submodule of $A$, hence a dendriform subalgebra of $A$. As it contains a set of generators by hypothesis 1 , it is $A$. We can prove (5), (6), and the fact that $\tilde{\Delta}=\Delta_{\prec}+\Delta_{\succ}$ on the whole $A$ in the same way. As the hypothesis 2 is a reformulation of axioms (12)-(15), $A$ is a bidendriform bialgebra.

### 3.3 Bidendriform structure on $\mathcal{A}^{\mathcal{D}}$

Unfortunately, $\left(\mathcal{A}^{\mathcal{D}}, \prec, \succ, \Delta_{\prec}^{\prime}, \Delta_{\succ}^{\prime}\right)$ is not a bidendriform bialgebra. For example, for $a=b={ }_{d}$ :

$$
a \prec b=\mathfrak{1}_{d}^{d}, \quad \Delta_{\prec}^{\prime}(a \prec b)=0
$$

whereas $a^{\prime} b_{\prec}^{\prime} \otimes a^{\prime \prime} \prec b_{\prec}^{\prime \prime}+a^{\prime} b \otimes a^{\prime \prime}+b_{\prec}^{\prime} \otimes a \prec b_{\prec}^{\prime \prime}+b \otimes a=\cdot{ }_{d} \otimes \cdot{ }_{d}$. So (15) is not satisfied.

Theorem 31 There is a unique structure of bidendriform bialgebra (with the already known dendriform bialgebra structure) on $\mathcal{A}^{\mathcal{D}}$ such that for all $d \in \mathcal{D}, \Delta_{\prec}(\cdot d)=\Delta_{\succ}(\cdot d)=0$. Hence, $\left(\mathcal{A}^{\mathcal{D}}, \prec, \succ, \Delta_{\prec}, \Delta_{\succ}\right)$ is a bidendriform bialgebra, which induces the structure of Hopf algebra of $\mathcal{H}^{\mathcal{D}}$ already described.

Proof. We use the notations of proposition 30.
Unicity. As the $\cdot{ }_{d}$ 's generate $\mathcal{A}^{\mathcal{D}}$, there is at most one way to extend $\bar{\Delta}_{\prec}$ and $\bar{\Delta}_{\succ}$ to $A$ as morphisms of dendriform modules, with notations of proposition 30 .

Existence. By proposition 29, we can extend $\bar{\Delta}_{\prec}$ and $\bar{\Delta}_{\succ}$ to $A$ as morphisms of dendriform modules. So the second condition of proposition 30 is satisfied. The first one is trivially satisfied on the set of generators $\{\cdot d / d \in \mathcal{D}\}$.

When $\mathcal{D}$ is a graded set, this structure obviously respects the gradation of $\mathcal{A}^{\mathcal{D}}$ :
Corollary 32 If $\mathcal{D}$ is a graded set, then $\mathcal{A}^{\mathcal{D}}$ is a graded bidendriform bialgebra.
Proposition 33 Let $F \in \mathbb{F}^{D}, F \neq 1$. We consider the set $\mathcal{A} d m_{\prec}(F)$ of admissible cuts of $F$ satisfying one of these two conditions:

1. c cuts one of the edges which are on the path from the root of the last tree of $F$ to the leave which is at most on the right of $F$.
2. $c$ cuts totally the last tree of $F$ if $F$ is not a single tree.

Then:

$$
\begin{equation*}
\Delta_{\prec}(F)=\sum_{c \in \mathcal{A} d m_{\prec}(F)} P^{c}(F) \otimes R^{c}(F) . \tag{19}
\end{equation*}
$$

Prove. We denote by $F_{\ll}^{\prime} \otimes F_{\ll}^{\prime \prime}$ the second member of (19). Let us prove the result by induction on $n=$ weight $(F)$. If $n=1$, then $F=\cdot d$ and the result is obvious. If $n \geq 2$, we have two possible cases:

1. $F=G H$, with weight $(G)$, weight $(H)<n$. By a study of $\mathcal{A} d m_{\prec}(F)$, we easily have:

$$
\begin{aligned}
F_{\ll}^{\prime} \otimes F_{\ll}^{\prime \prime} & =G^{\prime} H_{\ll}^{\prime} \otimes G^{\prime \prime} H_{\ll}^{\prime \prime}+G^{\prime} H \otimes G^{\prime \prime}+G H_{\ll}^{\prime} \otimes H_{\ll}^{\prime \prime}+G H_{\ll}^{\prime} \otimes H_{\ll}^{\prime \prime}+H \otimes G \\
& =G^{\prime} H_{\prec}^{\prime} \otimes G^{\prime \prime} H_{\prec}^{\prime \prime}+G^{\prime} H \otimes G^{\prime \prime}+G H_{\prec}^{\prime} \otimes H_{\prec}^{\prime \prime}+G H_{\prec}^{\prime} \otimes H_{\prec}^{\prime \prime}+H \otimes G,
\end{aligned}
$$

by the induction hypothesis on $H$. By (11), this is equal to $\Delta_{\prec}(F)$.
2. $F=B_{d}^{+}(G)$, weight $(G)=n-1$. By a study of $\mathcal{A} d m_{\prec}(G)$, we easily have:

$$
\begin{aligned}
F_{\ll}^{\prime} \otimes F_{\ll}^{\prime \prime} & =G_{\ll}^{\prime} \otimes B_{d}^{+}\left(G_{\ll}^{\prime \prime}\right)+G \otimes \cdot d \\
& =G_{\prec}^{\prime} \otimes B_{d}^{+}\left(G_{\prec}^{\prime \prime}\right)+G \otimes \cdot d \\
& =G_{\prec}^{\prime} \otimes \cdot d \prec G_{\prec}^{\prime \prime}+G \otimes \cdot d,
\end{aligned}
$$

by the induction hypothesis on $H$. As $F={ }_{\cdot d} \prec G$, by (15) for $a=\cdot{ }_{d}$, this is equal to $\Delta_{\prec}(F)$.

## Example.

$$
\begin{aligned}
& +\cdot{ }_{a}^{e} \boldsymbol{V}_{c}{ }^{d} \otimes \cdot{ }_{b}+{ }^{e} \boldsymbol{V}_{c}{ }^{d} \otimes \cdot{ }_{a \cdot b}+\cdot{ }_{a} \cdot{ }_{d} \otimes \mathfrak{l}_{b}^{e}+\cdot{ }_{d} \otimes{ }_{\cdot} \mathfrak{l}^{e}{ }_{b}^{e},
\end{aligned}
$$

### 3.4 Totally primitive elements of $\mathcal{A}^{\mathcal{D}}$ and universal property

We here prove that a connected bidendriform bialgebra is isomorphic to $\mathcal{A}^{\mathcal{D}}$ for a certain set $\mathcal{D}$.
Proposition $34 \operatorname{Prim}_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right)=\operatorname{Vect}(\cdot d / d \in \mathcal{D})$.
Proof. In a immediate way, $\bullet_{d} \in \operatorname{Prim}_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right)$. Let us show the other inclusion.
First case. Suppose that $\mathcal{D}$ is finite. We graduate $\mathcal{D}$ by putting all its elements in degree 1 . Then $\mathcal{A}^{\mathcal{D}}$ is graded, with $\mathcal{A}_{0}^{\mathcal{D}}=(0)$ and $\mathcal{A}_{n}^{\mathcal{D}}$ finite-dimensional for all $n$. By corollary 25, $\mathcal{A}^{\mathcal{D}}=$ $\operatorname{Prim}_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right) \oplus\left(\mathcal{A}^{\mathcal{D}}\right)^{D 2}$. As $\mathcal{A}^{\mathcal{D}}$ is freely generated by the $\cdot{ }_{d}$ 's, $\operatorname{Vect}\left({ }^{\boldsymbol{\circ}}{ }_{d} / d \in \mathcal{D}\right) \oplus\left(\mathcal{A}^{\mathcal{D}}\right)^{D 2}=\mathcal{A}^{\mathcal{D}}$, and this implies that $\operatorname{Prim}_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right) \subseteq \operatorname{Vect}\left({ }^{\boldsymbol{d}} \boldsymbol{d} / d \in \mathcal{D}\right)$.

General case. Let $p \in \operatorname{Prim}_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right)$. There exists a finite subset $\mathcal{D}^{\prime}$ of $\mathcal{D}$, such that $p \in \mathcal{A}^{\mathcal{D}^{\prime}}$. Then $p \in \operatorname{Vect}\left(\cdot{ }_{\cdot d} / d \in \mathcal{D}^{\prime}\right) \subseteq \operatorname{Vect}\left(\cdot{ }_{d} / d \in \mathcal{D}\right)$.

Theorem 35 Let $A$ be a bidendriform bialgebra. For all $d \in \mathcal{D}$, let $p_{d} \in \operatorname{Prim}_{\text {tot }}(A)$. There exists a unique morphism of bidendriform bialgebras:

$$
\Psi:\left\{\begin{array}{rll}
\mathcal{A}^{\mathcal{D}} & \longrightarrow & A \\
\cdot_{d} & \longrightarrow & p_{d} .
\end{array}\right.
$$

Moreover, we have:

1. If the $p_{d}$ 's are linearly independant, then $\Psi$ is monic.
2. if the dendriform coalgebra $A$ is connected and if the family $\left(p_{d}\right)_{d \in \mathcal{D}}$ linearly generates $\operatorname{Prim}_{\text {tot }}(A)$, then $\Psi$ is epic.
3. if the dendriform coalgebra $A$ is connected and if the family $\left(p_{d}\right)_{d \in \mathcal{D}}$ is a linear basis of $\operatorname{Prim}_{\text {tot }}(A)$, then $\Psi$ is an isomorphism.

Proof. As $\mathcal{A}^{\mathcal{D}}$ is freely generated by the $\cdot d$ 's, $\Psi$ defines a unique morphism of dendriform algebras. As $\cdot d$ and $p_{d}$ are both totally primitive, $\Psi$ is a morphism of bidendriform bialgebras. We now prove the two assertions.

1. We graduate $\mathcal{D}$ by putting all its elements of degree 1 . Suppose that $\operatorname{Ker}(\Psi) \neq(0)$. Let $x \in \operatorname{Ker}(\Psi)$, non-zero, of minimal degree $n$. So $\Psi$ is monic on $\mathcal{A}_{<n}^{\mathcal{D}}=\mathcal{A}_{0}^{\mathcal{D}} \oplus \ldots \oplus \mathcal{A}_{n-1}^{\mathcal{D}}$. Moreover, $\Delta_{\prec}(x) \in \mathcal{A}_{<n}^{\mathcal{D}} \otimes \mathcal{A}_{<n}^{\mathcal{D}}$ and $(\Psi \otimes \Psi) \circ \Delta_{\prec}(x)=\Delta_{\prec}(\Psi(x))=0$. By injectivity, $\Delta_{\prec}(x)=0$. In the same way, $\Delta_{\succ}(x)=0$. So $x \in \operatorname{Prim}_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right)=\operatorname{Vect}\left(\cdot{ }_{d} / d \in \mathcal{D}\right)$ (proposition 34). As the $p_{d}$ 's are linearly independant, $\operatorname{Ker}(\Psi) \cap \operatorname{Vect}\left(\cdot{ }_{d} / d \in \mathcal{D}\right)=(0)$ : contradiction. So $\Psi$ is monic.
2. Then $\operatorname{Im}(\Psi)$ is a dendriform subalgebra of $A$ which contains $\operatorname{Prim}_{\text {tot }}(A)$. As $A$ is connected, $\operatorname{Prim}_{\text {tot }}(A)$ generates $A$ (theorem 21), so $\Psi$ is epic.
3. Comes from 1 and 2.

This corollary is immediate:
Corollary 36 1. Let $A$ be a connected bidendriform bialgebra. Let $\left(p_{d}\right)_{d \in \mathcal{D}}$ be a basis of $\operatorname{Prim}_{\text {tot }}(A)$. Then the morphism $\Psi: \mathcal{A}^{\mathcal{D}} \longrightarrow A$ described in theorem 35 is an isomorphism of bidendriform bialgebras.
2. Let $A$ be a $\mathbb{N}$-graded bidendriform bialgebra which is connected as a dendriform coalgebra. Let $\left(p_{d}\right)_{d \in \mathcal{D}}$ be a basis of $\operatorname{Prim}_{\text {tot }}(A)$ made of homogeneous elements. Then $\mathcal{D}$ is given a gradation by putting $|d|=\left|p_{d}\right|$. Then the morphism $\Psi: \mathcal{A}^{\mathcal{D}} \longrightarrow A$ described in theorem 3 3 is an isomorphism of graded bidendriform bialgebras.

Corollary 37 Let $A$ be a $\mathbb{N}$-graded bidendriform bialgebra such that $A_{0}=(0)$ and $A_{n}$ is finite-dimensional for all $n \in \mathbb{N}$. We consider the following formal series:

$$
P(X)=\sum_{n=1}^{+\infty} \operatorname{dim}\left(\operatorname{Prim}_{t o t}(A)_{n}\right) X^{n}, \quad R(X)=\sum_{n=1}^{+\infty} \operatorname{dim}\left(A_{n}\right) X^{n}
$$

Then $P(X)=\frac{R(X)}{(1+R(X))^{2}}$.
Proof. Immediate if $A=(0)$. Suppose that $A \neq(0)$ (so $P(X) \neq 0)$. By corollary 36, we can suppose $A=\mathcal{A}^{\mathcal{D}}$. By proposition 34, $P(X)=D(X)$ of proposition 8. Hence:

$$
\begin{aligned}
& R(X)+1=\frac{1-\sqrt{1-4 P(X)}}{2 P(X)} \\
\Rightarrow & 2 P(X)(R(X)+1)-1=-\sqrt{1-4 P(X)} \\
\Rightarrow & 4 P(X)^{2}(R(X)+1)^{2}+1-4 P(X)(R(X)+1)=1-4 P(X) \\
\Rightarrow & P(X)(R(X)+1)^{2}-R(X)-1=-1 \\
\Rightarrow & P(X)=\frac{R(X)}{(R(X)+1)^{2}} .
\end{aligned}
$$

## 4 Application to the Hopf algebra FQSym

### 4.1 Recalls

(See [3, 5, 18]). The algebra FQSym is the vector space generated by the elements $\left(\mathbf{F}_{u}\right)_{u \in \mathbb{S}}$, where $\mathbb{S}$ is the disjoint union of the symmetric groups $S_{n}(n \in \mathbb{N})$. Its product and its coproduct are given in the following way: for all $u \in S_{n}, v \in S_{m}$, by putting $u=\left(u_{1} \ldots u_{n}\right)$,

$$
\begin{aligned}
\Delta\left(\mathbf{F}_{u}\right) & =\sum_{i=0}^{n} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{n}\right)} \\
\mathbf{F}_{u} \cdot \mathbf{F}_{v} & =\sum_{\zeta \in s h(n, m)} \mathbf{F}_{(u \times v) \cdot \zeta^{-1}}
\end{aligned}
$$

where $s h(n, m)$ is the set of $(n, m)$-shuffles, and $s t$ is the standardisation. Its unit is $1=\mathbf{F}_{\emptyset}$, where $\emptyset$ is the unique element of $S_{0}$. Moreover, FQSym is a $\mathbb{N}$-graded Hopf algebra, by putting $\left|\mathbf{F}_{u}\right|=n$ if $u \in S_{n}$.

## Examples.

$$
\begin{aligned}
\mathbf{F}_{(12)} \mathbf{F}_{(123)}= & \mathbf{F}_{(12345)}+\mathbf{F}_{(13245)}+\mathbf{F}_{(13425)}+\mathbf{F}_{(13452)}+\mathbf{F}_{(31245)} \\
& +\mathbf{F}_{(31425)}+\mathbf{F}_{(31452)}+\mathbf{F}_{(34125)}+\mathbf{F}_{(34152)}+\mathbf{F}_{(34512)}, \\
\Delta\left(\mathbf{F}_{(12543)}\right)= & 1 \otimes \mathbf{F}_{(12543)}+\mathbf{F}_{(1)} \otimes \mathbf{F}_{(1432)}+\mathbf{F}_{(12)} \otimes \mathbf{F}_{(321)} \\
& +\mathbf{F}_{(123)} \otimes \mathbf{F}_{(21)}+\mathbf{F}_{(1243)} \otimes \mathbf{F}_{(1)}+\mathbf{F}_{(12543)} \otimes 1
\end{aligned}
$$

### 4.2 Bidendriform structure on FQSym

Let $(\mathbf{F Q S y m})_{+}=\operatorname{Vect}\left(\mathbf{F}_{u} / u \in S_{n}, n \geq 1\right)$ be the augmentation ideal of FQSym. We define $\prec, \succ, \Delta_{\prec}$ and $\Delta_{\succ}$ on (FQSym $)_{+}$in the following way: for all $u \in S_{n}, v \in S_{m}$, by putting
$u=\left(u_{1} \ldots u_{n}\right)$,

$$
\begin{aligned}
& \mathbf{F}_{u} \prec \mathbf{F}_{v}= \sum_{\substack{\zeta \in s h(n, m) \\
\zeta^{-1}(n+m)=n}} \mathbf{F}_{(u \times v) \cdot \zeta^{-1}}, \\
& \mathbf{F}_{u} \succ \mathbf{F}_{v}=\sum_{\substack{\zeta \in s h(n, m) \\
\zeta^{-1}(n+m)=n+m}} \mathbf{F}_{(u \times v) \cdot \zeta^{-1}}, \\
& \Delta_{\prec}\left(\mathbf{F}_{u}\right)=\sum_{i=u^{-1}(n)}^{n-1} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{n}\right)}, \\
& \Delta_{\succ}\left(\mathbf{F}_{u}\right)=\sum_{i=1}^{u^{-1}(n)-1} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{n}\right)} .
\end{aligned}
$$

## Examples.

$$
\begin{aligned}
& \mathbf{F}_{(12)} \prec \mathbf{F}_{(123)}=\mathbf{F}_{(13452)}+\mathbf{F}_{(31452)}+\mathbf{F}_{(34152)}+\mathbf{F}_{(34512)}, \\
& \mathbf{F}_{(12)} \succ \mathbf{F}_{(123)}=\mathbf{F}_{(12345)}+\mathbf{F}_{(1325)}+\mathbf{F}_{(13425)}+\mathbf{F}_{(31245)}+\mathbf{F}_{(31425)}+\mathbf{F}_{(34125)}, \\
& \\
& \Delta_{\prec}\left(\mathbf{F}_{(12543)}\right)=\mathbf{F}_{(123)} \otimes \mathbf{F}_{(21)}+\mathbf{F}_{(1243)} \otimes \mathbf{F}_{(1)}, \\
& \Delta_{\succ}\left(\mathbf{F}_{(12543)}\right)=\mathbf{F}_{(1)} \otimes \mathbf{F}_{(1432)}+\mathbf{F}_{(12)} \otimes \mathbf{F}_{(321)} .
\end{aligned}
$$

Theorem $38\left((\mathbf{F Q S y m})_{+}, \prec, \succ, \Delta_{\prec}, \Delta_{\succ}\right)$ is a connected bidendriform bialgebra.
Proof. The structure of dendriform bialgebra is already introduced in [22], so we already have $(\mathbb{1})-(3)$, and (12) $+(14),(13)+(15)$. We consider the symmetric non-degenerate pairing on $(\text { FQSym })_{+}$defined in 5, 18] by $<\mathbf{F}_{\sigma}, \mathbf{F}_{\tau}>=\delta_{\sigma, \tau^{-1}}$. Note that $\Delta_{\prec}, \Delta_{\succ}$ are the transposes of $\prec, \succ$ for this pairing. So ((FQSym $\left.)_{+}, \Delta_{\prec}, \Delta_{\succ}\right)$ is a codendriform coalgebra. So we already have (4) $-(\sqrt{6})$, and $(\sqrt{12})+(\sqrt{13}),(\sqrt{14})+(\sqrt{15})$. It is then enough to prove (13). We have:

$$
\left.\begin{array}{rl}
\Delta_{\succ}\left(\mathbf{F}_{\left(u_{1} \ldots u_{n}\right)} \prec \mathbf{F}_{\left(v_{1} \ldots v_{m}\right)}\right)= & \Delta_{\succ}(\sum_{1 \leq j_{1}<\ldots<j_{m}<n+m} \underbrace{}_{v_{i}+n \text { in position } j_{i}} \mathbf{F}_{\left(u_{1} \ldots v_{1}+n \ldots v_{m}\right.}+n \ldots u_{n})
\end{array}\right)
$$

So (133) is satisfied, and (FQSym $)_{+}$is a bidendriform bialgebra. Moreover, it is $\mathbb{N}$-graded, with $\left((\mathbf{F Q S y m})_{+}\right)_{0}=(0)$, so it is connected.

Remark. It is of course possible to prove (4)-(6) directly. For example, the two members of ( (4) for $a=\mathbf{F}_{u}$, with $u=\left(u_{1} \ldots u_{n}\right)$, are equal to:

$$
\sum_{\sigma^{-1}(n) \leq i<j<n} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{j}\right)} \otimes \mathbf{F}_{s t\left(u_{j+1} \ldots u_{n}\right)}
$$

For ( 5 ) , we obtain:

$$
\sum_{1 \leq i<\sigma^{-1}(n) \leq j<n} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{j}\right)} \otimes \mathbf{F}_{s t\left(u_{j+1} \ldots u_{n}\right)} .
$$

And for (6):

$$
\sum_{1 \leq i<j<\sigma^{-1}(n)} \mathbf{F}_{s t\left(u_{1} \ldots u_{i}\right)} \otimes \mathbf{F}_{s t\left(u_{i+1} \ldots u_{j}\right)} \otimes \mathbf{F}_{s t\left(u_{j+1} \ldots u_{n}\right)}
$$

Moreover, $(\mathbf{F Q S y m})_{+}$is graded and connected, with:

$$
R(X)=\sum_{n=1}^{+\infty} \operatorname{dim}\left(\mathbf{F Q S y m}_{n}\right) X^{n}=\sum_{n=1}^{+\infty} n!X^{n} .
$$

By corollary 37:

$$
P(X)=\sum_{n=1}^{+\infty} \operatorname{dim}\left(\operatorname{Prim}_{\text {tot }}\left((\mathbf{F Q S y m})_{+}\right)_{n}\right) X^{n}=\sum_{n=1}^{+\infty} p_{n} X^{n}=\frac{R(X)}{(R(X)+1)^{2}} .
$$

We obtain then:

Remark. Let $\Psi: \mathcal{A} \longrightarrow(\text { FQSym })_{+}$be the unique morphism of bidendriform bialgebras which send • to $\mathbf{F}_{(1)}$. It coincides with the morphism $\overline{\Phi^{*}}$ of (17]. We obtain by theorem 355 that it is monic.

By corollary 36:
Theorem 39 Let $\mathcal{D}$ be a graded set such that $\mathcal{D}_{0}=\emptyset$ and for all $n \geq 1, \operatorname{card}\left(\mathcal{D}_{n}\right)=p_{n}$. Then $(\mathbf{F Q S y m})_{+}$and $\mathcal{A}^{\mathcal{D}}$ are isomorphic as graded bidendriform bialgebras. Hence, FQSym and $\mathcal{H}^{\mathcal{D}}$ are isomorphic as graded Hopf algebras.

We can now prove the conjecture 3.8 of (5):
Corollary 40 If the field $K$ is of characteristic 0 , the Lie algebra Prim(FQSym) is free.
Proof. By proposition 141 of [6] , the Lie algebra $\operatorname{Prim}\left(\mathcal{H}^{\mathcal{D}}\right)$ is free.
Finally, we give a basis of totally primitive elements of $(\text { FQSym })_{+}$of degree smaller than 4. With notations of [5]):

$$
\begin{aligned}
\mathbf{V}_{1} & =\mathbf{F}_{1}, \\
\mathbf{V}_{231} & =\mathbf{F}_{231}-\mathbf{F}_{132}, \\
\mathbf{V}_{3142} & =\mathbf{F}_{3142}-\mathbf{F}_{2143}, \\
\mathbf{V}_{2431} & =\mathbf{F}_{2431}-\mathbf{F}_{1432}, \\
\mathbf{V}_{2341} & =\mathbf{F}_{2341}-\mathbf{F}_{1342}, \\
\mathbf{V}_{3241} & =\mathbf{F}_{1243}-\mathbf{F}_{1342}-\mathbf{F}_{2143}+\mathbf{F}_{3241}, \\
\mathbf{V}_{3412}-\mathbf{V}_{2413} & =\mathbf{F}_{3412}-\mathbf{F}_{2413}, \\
\mathbf{V}_{3421}-\mathbf{V}_{2413} & =\mathbf{F}_{1423}-\mathbf{F}_{2413}-\mathbf{F}_{1432}+\mathbf{F}_{3421} .
\end{aligned}
$$

## 5 Bidendriform pairings

### 5.1 Definition

Definition 41 Let $A$ and $B$ be two bidendriform bialgebras and let $<,>: A \times B \longrightarrow K$ be a bilinear form. We will say that $<,>$ is a bidendriform pairing if, for all $a, a_{1}, a_{2} \in A$, $b, b_{1}, b_{2} \in B$, the following conditions are satisfied:

$$
\begin{array}{ll|l}
<a_{1} \prec a_{2}, b>=<a_{1} \otimes a_{2}, \Delta_{\prec}(b)>, & <a, b_{1} \prec b_{2}>=<\Delta_{\prec}(a), b_{1} \otimes b_{2}> \\
<a_{1} \succ a_{2}, b>=<a_{1} \otimes a_{2}, \Delta_{\succ}(b)>, & <a, b_{1} \succ b_{2}>=<\Delta_{\succ}(a), b_{1} \otimes b_{2}>
\end{array}
$$

Suppose that $A$ and $B$ are graded. Then $<,>$ will be said homogeneous if for all homogeneous elements $a \in A, b \in B,<a, b>=0$ if $a$ and $b$ have different degrees.

Remark. If $<,>: A \times B \longrightarrow K$ is a bidendriform pairing, then it induces a Hopf pairing between $\bar{A}=A \oplus K$ and $\bar{B}=B \oplus K$ with, for all $a \in A, b \in B,<1, b>=0,<a, 1>=0$, and $<1,1>=1$.

Example. The pairing on (FQSym $)_{+}$defined by $<\mathbf{F}_{u}, \mathbf{F}_{v}>=\delta_{u, v^{-1}}$ is a bidendriform pairing.

### 5.2 Hopf dual of a bidendriform bialgebra

We here extend the notion of Hopf dual of a Hopf algebra (see (10) to bidendriform bialgebras. Let $A$ be a dendriform algebra. We denote by $A^{\star}$ the following subspace of the linear dual $A^{*}$ of $A$ :

$$
A^{\star}=\left\{f \in A^{*} / f \text { vanishes on a dendriform ideal of finite codimension of } A\right\}
$$

For all $a \in A$, we consider the following applications:

$$
\begin{aligned}
& L_{a}^{\prec}:\left\{\begin{array}{rlll}
A^{*} & \longrightarrow & A^{*} \\
f & \longrightarrow & \left\{\begin{array}{rll}
A & \longrightarrow & K \\
b & \longrightarrow & L_{a}^{\prec}(f)(b)=f(a \prec b),
\end{array}\right.
\end{array}\right. \\
& L_{a}^{\succ}:\left\{\begin{array}{rlll}
A^{*} & \longrightarrow & A^{*} \\
f & \longrightarrow & \left\{\begin{array}{rll}
A & \longrightarrow & K \\
b & \longrightarrow & L_{a}^{\succ}(f)(b)=f(a \succ b),
\end{array}\right.
\end{array}\right. \\
& R_{a}^{\prec}:\left\{\begin{array}{rlll}
A^{*} & \longrightarrow & A^{*} \\
f & \longrightarrow & \left\{\begin{array}{rll}
A & \longrightarrow & K \\
b & \longrightarrow & R_{a}^{\prec}(f)(b)=f(b \prec a),
\end{array}\right.
\end{array}\right. \\
& R_{a}^{\succ}:\left\{\begin{array}{rlll}
A^{*} & \longrightarrow & A^{*} \\
f & \longrightarrow & \left\{\begin{array}{rll}
A & \longrightarrow & K \\
b & \longrightarrow & R_{a}^{\succ}(f)(b)=f(b \succ a) .
\end{array}\right.
\end{array}\right.
\end{aligned}
$$

Lemma 42 Let $f \in A^{*}$. The following assertions are equivalent:

1. $f \in A^{\star}$.
2. There exists a finite dimensional subspace $U$ of $A^{*}$, stable for all $a \in A$ by $L_{a}^{\prec}, L_{a}^{\succ}, R_{a}^{\prec}$ and $R_{a}^{\succ}$, which contains $f$.

## Proof.

$1 \Longrightarrow 2$. Let $I$ be a dendriform ideal of $A$, such that $f(I)=(0)$ and $f$ has a finite codimension. Then $I^{\perp}$ is finite-dimensional and contains $f$. Let $g \in I^{\perp}$ and let $a \in A$. For all $b \in I$ :

$$
L_{a}^{\prec}(g)(b)=g(\underbrace{a \prec b}_{\in I})=0,
$$

as $I$ is a dendriform ideal of $A$. So $L_{a}^{\prec}(g) \in I^{\perp}: I^{\perp}$ is stable under $L_{a}^{\prec}$. In the same way, $I^{\perp}$ is stable under $L_{a}^{\succ}, R_{a}^{\prec}$ and $R_{a}^{\succ}$.
$2 \Longrightarrow 1$. Let $I=U^{\perp}$. Then $I$ has a finite codimension. Moreover, as $f \in U, f(I)=(0)$. Let $a \in A, b \in I$. For all $g \in U$ :

$$
g(a \prec b)=\underbrace{L_{a}^{\prec}(g)}_{\in U}(b)=0,
$$

so $a \prec b \in I$. In the same way, $a \succ b, b \prec a$ and $b \succ a \in I$, so $I$ is a dendriform ideal.

Lemma $43 \prec^{*}, \succ^{*}$ send $A^{\star}$ into $A^{\star} \otimes A^{\star}$.
Proof. Let $f \in A^{\star}$ and $U$ as in lemma 42. Let $\left(u_{1}, \ldots, u_{n}\right)$ be a basis of $U$. By lemma 42, observe that $U \subseteq A^{\star}$. For all $a \in A$, we put:

$$
L_{a}^{\prec}(f)=\sum_{i=1}^{n} v_{i}(a) u_{i} .
$$

Then the $v_{i}$ 's are elements of $A^{*}$. Let us fix $j \in\{1, \ldots, n\}$. There exists $b_{j} \in A$, such that $v_{i}\left(b_{j}\right)=\delta_{i, j}$. Then:

$$
L_{a}^{\prec}(f)\left(b_{j}\right)=\sum_{i=1}^{n} v_{i}(a) u_{i}\left(b_{j}\right)=v_{j}(a)=f\left(a \prec b_{j}\right)=R_{b_{j}}^{\prec}(f)(a),
$$

so $v_{j}=R_{b_{j}}^{\prec}(f) \in U$. Moreover, for all $a, b \in A$ :

$$
\prec^{*}(f)(a \otimes b)=f(a \prec b)=L_{a}^{\prec}(f)(b)=\sum_{i=1}^{n} v_{i}(a) \otimes u_{i}(b)=\sum_{i=1}^{n} v_{i} \otimes u_{i}(a \otimes b),
$$

so $\prec^{*}(f) \in U \otimes U \subseteq A^{\star} \otimes A^{\star}$. In the same way, $\succ^{*}(f) \in A^{\star} \otimes A^{\star}$.
Remark. So $\left(A^{\star}, \prec^{*}, \succ^{*}\right)$ is a dendriform coalgebra.
Suppose now that $A$ is a bidendriform bialgebra. By duality, $\left(A^{*}, \Delta_{\prec}^{*}, \Delta_{\succ}^{*}\right)$ is given a dendriform algebra structure. More precisely, for all $f, g \in A^{*}$, we have, for all $a \in A$ :

$$
(f \prec g)(a)=(f \otimes g) \circ \Delta_{\prec}(a), \quad(f \succ g)(a)=(f \otimes g) \circ \Delta_{\succ}(a)
$$

Lemma $44 A^{\star}$ is a dendriform subalgebra of $A^{*}$.
Proof. Let $f, g \in A^{\star}$. By lemma 42, there exists a finite-dimensional subspace $U$ of $A^{*}$, containing $f$ and $g$, stable for all $a \in A$ by $L_{a}^{\prec}, L_{a}^{\succ}, R_{a}^{\prec}$ and $R_{a}^{\succ}$. Let $F, G \in U$. Let $a \in A$. For all $b \in A$, by (15):

$$
\begin{aligned}
L_{a}^{\prec}(F \prec G)(b)= & (F \prec G)(a \prec b) \\
= & (F \otimes G) \circ \Delta_{\prec}(a \prec b) \\
= & (F \otimes G)\left(a^{\prime} b_{\prec}^{\prime} \otimes a^{\prime \prime} \prec b_{\prec}^{\prime \prime}+a^{\prime} b \otimes a^{\prime \prime}+b_{\prec}^{\prime} \otimes a \prec b_{\prec}^{\prime \prime}+b \otimes a\right) \\
= & \left(\left(L_{a^{\prime}}^{\prec}+L_{a^{\prime}}^{\succ}\right)(F) \prec L_{a^{\prime \prime}}^{\prec}(G)\right)(b) \\
& +G\left(a^{\prime \prime}\right)\left(\left(L_{a^{\prime}}^{\prec}+L_{a^{\prime}}^{\succ}\right)(F)\right)(b)+\left(F \prec L_{a}^{\prec}(G)\right)(b)+F(a) G(b) .
\end{aligned}
$$

Hence:

$$
\begin{aligned}
L_{a}^{\prec}(F \prec G) & =\left(L_{a^{\prime}}^{\prec}+L_{a^{\prime}}^{\succ}\right)(F) \prec L_{a^{\prime \prime}}^{\prec}(G)+G\left(a^{\prime \prime}\right)\left(L_{a^{\prime}}^{\prec}+L_{a^{\prime}}^{\succ}\right)(F)+F \prec L_{a}^{\prec}(G)+F(a) G \\
& \in U+U \prec U+U \succ U .
\end{aligned}
$$

In the same way, we can prove that $V=U+U \prec U+U \succ U$ is stable under $L_{a}^{\succ}, R_{a}^{\prec}$ and $R_{a}^{\succ}$. As $U$ is finite-dimensional, $V$ is finite-dimensional, and contains $f \prec g$ and $f \succ g$, as $f, g \in U$. So, by lemma 42, $f \prec g$ and $f \succ g \in A^{\star}$.

By dualising the axioms of bidendriform bialgebras, we obtain:

Proposition 45 For any bidendriform bialgebra $A,\left(A^{\star}, \Delta_{\prec}^{*}, \Delta_{\succ}^{*}, \prec^{*}, \succ^{*}\right)$ is a bidendriform bialgebra. More precisely, for all $f, g \in A^{\star}, a, b \in A$ :

$$
\begin{aligned}
(f \prec g)(a)=(f \otimes g) \circ \Delta_{\prec}(a), & & (f \succ g)(a)=(f \otimes g) \circ \Delta_{\succ}(a), \\
\Delta_{\prec}(f)(a \otimes b)=f(a \prec b), & & \Delta_{\succ}(f)(a \otimes b)=f(a \succ b)
\end{aligned}
$$

Proposition 46 Let $A, B$ be bidendriform bialgebras.

1. Let $\Phi: A \longrightarrow B^{\star}$ be a morphism of bidendriform bialgebras. Then the following pairing is a bidendriform pairing:

$$
<,>:\left\{\begin{array}{rll}
A \times B & \longrightarrow & K \\
(a, b) & \longrightarrow & <a, b>=\Phi(a)(b)
\end{array}\right.
$$

2. Suppose that $A$ is connected and that $<,>: A \times B \longrightarrow K$ is a bidendriform pairing. Then the following application is a morphism of bidendriform bialgebras:

$$
\Phi:\left\{\begin{array}{rll}
A & \longrightarrow & B^{\star} \\
a & \longrightarrow & \Phi(a):\left\{\begin{array}{rll}
B & \longrightarrow & K \\
b & \longrightarrow & <a, b>
\end{array} .\right.
\end{array}\right.
$$

## Proof.

1. Let $a_{1}, a_{2} \in A, b \in B$.

$$
\begin{aligned}
<a_{1} \prec a_{2}, b> & =\Phi\left(a_{1} \prec a_{2}\right)(b) \\
& =\left(\Phi\left(a_{1}\right) \prec \Phi\left(a_{2}\right)\right)(b) \\
& =\left(\Phi\left(a_{1}\right) \otimes \Phi\left(a_{2}\right)\right) \circ \Delta_{\prec}(b) \\
& =<a_{1} \otimes a_{2}, \Delta_{\prec}(b)>
\end{aligned}
$$

Let $a \in A, b_{1}, b_{2} \in B$.

$$
\begin{aligned}
<a, b_{1} \prec b_{2}> & =\Phi(a)\left(b_{1} \prec b_{2}\right) \\
& =\Delta_{\prec}(\Phi(a))\left(b_{1} \otimes b_{2}\right) \\
& =\left((\Phi \otimes \Phi) \circ \Delta_{\prec}(a)\right)\left(b_{1} \otimes b_{2}\right) \\
& =<\Delta_{\prec}(a), b_{1} \otimes b_{2}>
\end{aligned}
$$

The two other equalities are proved in the same way.
2. We first prove the following lemma:

Lemma 47 Let $C$ be a connected dendriform coalgebra. For all $a \in C$, there exists a finitedimensional dendriform subcoalgebra of $C$ which contains $a$.

Proof. We use the notations of definition 18. Let $a \in C$. We put:

$$
C_{a}=V e c t\left\{\begin{array}{c}
\left(f_{1} \otimes \ldots \otimes f_{i-1} \otimes I d \otimes f_{i+1} \otimes \ldots \otimes f_{n}\right) \circ P(a) / \\
n \in \mathbb{N}^{*}, i \in\{1, \ldots, n\}, f_{1}, \ldots, f_{i-1}, f_{i+1}, \ldots f_{n} \in C^{*}, P \in \mathcal{P}_{C}(n)
\end{array}\right\} .
$$

Then $C_{a}$ is the smallest dendriform subcoalgebra of $C$ which contains $a$. As $C$ is connected, there are only a finite number of $P$ such that $P(a) \neq 0$, so $C_{a}$ is finite-dimensional.

End of the proof of proposition 46. Let us first prove that $\Phi(a) \in B^{\star}$ for all $a \in A$. As $A$ is connected, there exists a finite-dimensional subcoalgebra $C$ of $A$ which contains a (lemma 47). Let $I$ be the orthogonal of $C$ for the pairing $<,>$. As $C$ is finite-dimensional, $I$ has a finite codimension. Let $b_{1} \in B, b_{2} \in I$. For all $c \in C$, we have:

$$
<c, b_{1} \prec b_{2}>=<\underbrace{\Delta_{\prec}(c)}_{\in C \otimes C}, b_{1} \otimes b_{2}>=0,
$$

so $b_{1} \prec b_{2} \in I$. In the same way, we prove that $I$ is a dendriform ideal of $B$. As $a \in C$, $\Phi(a)(I)=<a, I>=(0)$, so $\Phi(a) \in B^{\star}$.

Let $a_{1}, a_{2} \in A$. For all $b \in B$ :

$$
\begin{aligned}
\Phi\left(a_{1} \prec a_{2}\right)(b) & =<a_{1} \prec a_{2}, b> \\
& =<a_{1} \otimes a_{2}, \Delta_{\prec}(b)> \\
& =\left(\Phi\left(a_{1}\right) \otimes \Phi\left(a_{2}\right)\right) \circ \Delta_{\prec}(b) \\
& =\left(\Phi\left(a_{1}\right) \prec \Phi\left(a_{2}\right)\right)(b),
\end{aligned}
$$

so $\Phi\left(a_{1} \prec a_{2}\right)=\Phi\left(a_{1}\right) \prec \Phi\left(a_{2}\right)$. Let $a \in A$. For all $b_{1}, b_{2} \in B$ :

$$
\begin{aligned}
\left(\Delta_{\prec}(\Phi)(a)\right)\left(b_{1} \otimes b_{2}\right) & =\Phi(a)\left(b_{1} \prec b_{2}\right) \\
& =<a, b_{1} \prec b_{2}> \\
& =<\Delta_{\prec}(a), b_{1} \otimes b_{2}> \\
& =\left((\Phi \otimes \Phi) \circ \Delta_{\prec}(a)\right)\left(b_{1} \otimes b_{2}\right),
\end{aligned}
$$

so $\Delta_{\prec}(\Phi)(a)=(\Phi \otimes \Phi) \circ \Delta_{\swarrow}(a)$. The other equalities are proved in the same way.

### 5.3 Bidendriform pairing on a connected graded bidendriform bialgebra

Theorem 48 Let $A, B$ be connected bidendriform bialgebras. Let $<,>_{\mid \operatorname{Prim}_{t o t}}: \operatorname{Prim}_{\text {tot }}(A) \times$ $\operatorname{Prim}_{\text {tot }}(B) \longrightarrow K$. then $<,>_{\mid \text {Prim }_{\text {tot }}}$ can be uniquely extended into a bidendriform pairing between $A$ and $B$. Moreover:

1. $<,>$ is non-degenerate $\Longleftrightarrow<,\rangle_{\mid \text {Prim }_{t o t}}$ is non-degenerate.
2. Suppose that $A=B$. Then $<,>$ is symmetric $\Longleftrightarrow<,>_{\mid \text {Prim }_{\text {tot }}}$ is symmetric.
3. Suppose that $A$ and $B$ are $\mathbb{N}$-graded (we do not suppose that the $A_{n}$ 's or the $B_{n}$ 's are finite-dimensional). Then $<,>$ is homogeneous $\Longleftrightarrow<,>_{\mid \text {Prim }_{t o t}}$ is homogeneous.

## Proof.

Existence. By corollary 25, $B=\operatorname{Prim}_{\text {tot }}(B) \oplus B^{D 2}$. We can then define, for all $p \in$ $\operatorname{Prim}_{\text {tot }}(A)$ :

$$
f_{p}:\left\{\begin{array}{rll}
B & \longrightarrow & K \\
q \in \operatorname{Prim}_{\text {tot }}(B) & \longrightarrow & <p, q>_{\mid \text {Prim }_{\text {tot }}}, \\
b \in B^{D 2} & \longrightarrow 0 .
\end{array}\right.
$$

Then $\operatorname{Ker}\left(f_{p}\right)$ contains $B^{D 2}$, so is a dendriform ideal of codimension at most 1 . Hence, $f_{p} \in B^{\star}$. Moreover, for all $a_{1}, a_{2} \in A, \Delta_{\prec}\left(f_{p}\right)\left(a_{1} \otimes a_{2}\right)=f_{p}\left(a_{2} \prec a_{2}\right)=0$, so $\Delta_{\prec}\left(f_{p}\right)=0$. In the same way, $\Delta_{\succ}\left(f_{p}\right)=0$ and then $f_{p} \in \operatorname{Prim}_{\text {tot }}\left(B^{\star}\right)$.

As $A$ is isomorphic to a bidendriform algebra $\mathcal{A}^{D}$ (corollary 36), by theorem 355, there exists a unique morphism of bidendriform bialgebras:

$$
\Phi:\left\{\begin{array}{rll}
A & \longrightarrow & B^{\star} \\
p \in \operatorname{Prim}_{\text {tot }}(A) & \longrightarrow & f_{p} .
\end{array}\right.
$$

We then put $<a, b>=\Phi(a)(b)$ for all $a \in A, b \in B$. This pairing extends $<,\rangle_{\mid \text {Prim }_{t o t}}$ : if $p \in \operatorname{Prim}_{\text {tot }}(A), q \in \operatorname{Prim}_{\text {tot }}(B),<p, q>=\Phi(p)(q)=f_{p}(q)=<p, q>_{\mid \operatorname{Prim}_{\text {tot }}}$. Moreover, as $\Phi$ is a morphism of bidendriform bialgebras, $<,>$ is a bidendriform pairing (proposition (6)).

Unicity. Let $<,>^{\prime}$ a second bidendriform pairing which extends $<,>_{\mid \text {Prim }_{t o t}}$. Let us show that it is equal to $<,>$ already defined. Consider:

$$
A^{\prime}=\left\{a \in A / \forall b \in B,\langle a, b\rangle=\left\langle a, b>^{\prime}\right\} .\right.
$$

Let $a_{1}, a_{2} \in A^{\prime}$. Then, forall $b \in B$,

$$
<a_{1} \prec a_{2}, b>=<a_{1} \otimes a_{2}, \Delta_{\prec}(b)>=<a_{1} \otimes a_{2}, \Delta_{\prec}(b)>^{\prime}=<a_{1} \prec a_{2}, b>^{\prime} .
$$

So $a_{1} \prec a_{2} \in A^{\prime}$. In the same way, $a_{1} \succ a_{2} \in A^{\prime}$, so $A^{\prime}$ is a dendriform subalgebra. As $A$ is generated by $\operatorname{Prim}_{\text {tot }}(A)$, it is enough to prove that $p \in A^{\prime}$ for all $p \in \operatorname{Prim}_{\text {tot }}(A)$. Let $b \in B$ and let us show that $\langle p, b\rangle=\langle p, b\rangle^{\prime}$. It is true by hypothesis if $b \in \operatorname{Prim}_{\text {tot }}(A)$. If it is not the case, we can suppose $b=b_{1} \prec b_{2}$ or $b=b_{1} \succ b_{2}$. Hence:

$$
\begin{aligned}
<p, b>^{\prime} & =\left\langle p, b_{1} \prec b_{2}\right\rangle^{\prime}=\left\langle\Delta_{\prec}(p), b_{1} \otimes b_{2}\right\rangle^{\prime}=0=\langle p, b\rangle \\
\text { or }\left\langle p, b>^{\prime}\right. & =\left\langle p, b_{1} \succ b_{2}>^{\prime}=\left\langle\Delta_{\succ}(p), b_{1} \otimes b_{2}>^{\prime}=0=\langle p, b\rangle .\right.\right.
\end{aligned}
$$

We now prove the three equivalences.
Non-degeneracy, $\Longrightarrow$. Suppose $<,>$ non-degenerate and let $a \in \operatorname{Prim}_{\text {tot }}(A) \cap \operatorname{Prim}_{\text {tot }}(B)^{\perp}$. Then, as $\operatorname{Prim}_{\text {tot }}(A) \subseteq\left(B^{D 2}\right)^{\perp}$, we obtain $a \in\left(B^{D 2}+\operatorname{Prim}_{\text {tot }}(B)\right)^{\perp}=B^{\perp}=(0)$. In the same way, $\operatorname{Prim}_{\text {tot }}(B) \cap \operatorname{Prim}_{\text {tot }}(A)^{\perp}=(0)$, So $<,>_{\mid \text {Prim }_{\text {tot }}}$ is non-degenerate.

Non-degeneracy, $\Longleftarrow$. Then $\Phi_{\mid \text {Prim }_{t o t}(A)}$ is injective, so, by theorem 35, $\Phi$ is injective: $B^{\perp}=(0)$. By permuting the role of $A$ and $B$, which does not change the pairing $<,>$ by unicity, we obtain $A^{\perp}=(0)$. So $<,>$ is non-degenerate.

Symmmetry, $\Longrightarrow$. Obvious.
Symmetry, $\Longleftarrow$. We consider $A^{\prime \prime}=\{a \in A / \forall b \in A,\langle a, b\rangle=\langle b, a\rangle\}$. Let $a_{1}, a_{2} \in A^{\prime \prime}$. Then, for all $b \in A$ :

$$
<a_{1} \prec a_{2}, b>=<a_{1} \otimes a_{2}, \Delta_{\prec}(b)>=<\Delta_{\prec}(b), a_{1} \otimes a_{2}>=<b, a_{1} \prec a_{2}>.
$$

So $a_{1} \prec a_{2} \in A^{\prime \prime}$. In the same way, $a_{1} \succ a_{2} \in A^{\prime \prime}$, so $A^{\prime \prime}$ is a dendriform subalgebra. It is then enough to show that $\operatorname{Prim}_{\text {tot }}(A) \subset A^{\prime \prime}$. Let $a \in \operatorname{Prim}_{\text {tot }}(A)$ and $b \in A$. We can limit ourselves to the three following cases:

1. $b \in \operatorname{Prim}_{\text {tot }}(A)$. Then $\langle a, b\rangle=\langle b, a\rangle$ by hypothesis on $\left.<,\right\rangle_{\mid \text {Prim }_{\text {tot }}}$.
2. $b=b_{1} \prec b_{2}$. Then $\langle b, a\rangle=\left\langle b_{1} \otimes b_{2}, \Delta_{\prec}(a)\right\rangle=0=\langle a, b\rangle$.
3. $b=b_{1} \succ b_{2}$. Then $\langle b, a\rangle=\left\langle b_{1} \otimes b_{2}, \Delta_{\succ}(a)\right\rangle=0=\langle a, b\rangle$.

So $A^{\prime \prime}=A$ and $<,>$ is symmetric.
Homogeneity, $\Longrightarrow$. Obvious.
Homogeneity, $\Longleftarrow$. Then $\Phi$ takes its values in the graded dual of $A$ and is homogeneous of degree 0 , so $<,>$ is homogeneous.

### 5.4 Application to $\mathcal{H}^{\mathcal{D}}$

We define a pairing on $\operatorname{Prim}_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right)$ in the following way: for all $d, d^{\prime} \in \mathcal{D}$,

$$
\left.<\cdot \cdot_{d}, \cdot d^{\prime}\right\rangle_{\text {Prim }_{\text {tot }}\left(\mathcal{A}^{\mathcal{D}}\right)}=\delta_{d, d^{\prime}} .
$$

This pairing is symmetric, homogeneous, and non-degenerate. By theorem 48, it can be extended on a unique bidendriform pairing $<,>$ on $\mathcal{A}^{\mathcal{D}}$. This pairing is also symmetric, homogeneous, and non-degenerate.

Remark. This pairing is not the pairing (, ) on $\mathcal{H}^{\mathcal{D}}$ introduced in [7] which is a symmetric and non degenerate Hopf pairing but not a bidendriform pairing:

$$
\begin{gathered}
\left(\cdot{ }_{d} \prec \cdot \bullet_{d}, \mathfrak{l}_{d}^{d}\right)=\left(\mathfrak{l}_{d}^{d}, \mathfrak{l}_{d}^{d}\right)=0, \\
\left(\cdot{ }_{d} \otimes \cdot d, \Delta_{\prec}\left(\mathfrak{l}_{d}^{d}\right)\right)=\left(\cdot{ }_{d} \otimes \cdot{ }_{d}, \cdot{ }_{d} \otimes \cdot{ }_{d}\right)=1 .
\end{gathered}
$$

The pairing $<,>$ admits a similar description as the pairing of $[\mathcal{7}]$. Let $d \in \mathcal{D}$. We consider the following application:

$$
\xi_{d}:\left\{\begin{aligned}
\mathcal{H}^{\mathcal{D}} & \longrightarrow \mathcal{H}^{\mathcal{D}} \\
F \in \mathbb{F}^{\mathcal{D}} & \longrightarrow\left\{\begin{array}{l}
0 \text { if the leave of } F \text { at most on the right is decorated by } d ; \\
F \text { without its leave at most on the right if it is decorated by } d .
\end{array}\right.
\end{aligned}\right.
$$

For example, if $a, b, c, d, e, f \in \mathcal{D}, \xi_{f}\left(\mathbf{:}_{a}^{b}{ }^{d} \boldsymbol{\bigvee}_{c}^{e}\right)=\delta_{e, f} \mathbf{t}_{a}^{b} \mathbf{:}_{c}^{d}$.
Lemma 49 Let $x, y \in \mathcal{A}^{\mathcal{D}}, d \in \mathcal{D}$. Then:

1. $\left\langle\cdot_{d} \otimes x, \Delta_{\prec}(y)>=<x, \xi_{d}(y)>\right.$.
2. $\left\langle B_{d}^{+}(x), y\right\rangle=\left\langle x, \xi_{d}(y)\right\rangle$.

## Proof.

1. We can suppose that $y \in \mathbb{F}^{\mathcal{D}}$. We denote by $d^{\prime}$ the decoration of leave of $y$ at most on the right. The only eventual admissible cut in $\mathcal{A} d m_{\prec}(y)$ (defined in proposition 33) such that $P^{c}(y)=\cdot{ }_{d}$ is the cut $c_{y}$ which cut the edge leading to the leave of $y$ at most on the right, if $d=d^{\prime}$. Hence, by proposition 33:

$$
\begin{aligned}
<\cdot \cdot_{d} \otimes x, y> & =\sum_{c \in \mathcal{A} d m_{\prec}(y)}<\cdot_{d}, P^{c}(y)><x, R^{c}(y)> \\
& =\sum_{c \in \mathcal{A} d m_{\prec}(y)} \delta_{\cdot{ }_{d}, P^{c}(y)}<x, R^{c}(y)> \\
& =\delta_{d, d^{\prime}}<x, R^{c_{f}}(y)> \\
& =<x, \xi_{d}(y)>.
\end{aligned}
$$

2. We have $<B_{d}^{+}(x), y>=<\cdot{ }_{d} \prec x, y>=<\cdot{ }_{d} \otimes x, \Delta_{\prec}(y)>=<x, \xi_{d}(y)>$.

Hence, the Hopf pairing (also denoted by $<,>$ ) induced on $\mathcal{H}^{\mathcal{D}}$ satisfies the following properties:

Theorem $\mathbf{5 0}<,>: \mathcal{H}^{\mathcal{D}} \times \mathcal{H}^{\mathcal{D}} \longrightarrow K$ is the unique pairing such that:

1. $\forall y \in \mathcal{H}^{\mathcal{D}},\langle 1, y\rangle=\varepsilon(y)$, where $\varepsilon$ is the counit of $\mathcal{H}^{\mathcal{D}}$.
2. $\forall x, y \in \mathcal{H}^{\mathcal{D}},\left\langle B_{d}^{+}(x), y\right\rangle=\left\langle x, \xi_{d}(y)\right\rangle$.
3. $\forall x, y, z \in \mathcal{H}^{\mathcal{D}},\langle x y, z\rangle=\langle x \otimes y, \Delta(z)\rangle$.

Moreover, $<,>$ is symmetric, homogenenous and non-degenerate, and for all $x, y \in \mathcal{H}^{\mathcal{D}}$, we have $<S(x), y>=<x, S(y)>$.

Remark. The three points of this theorem allow to compute $<F, G>$ for $F, G \in \mathbb{F}^{\mathcal{D}}$, by induction on weight $(F)$.

We now give a combinatorial interpretation of this pairing, inspired by our work in (7). If $F \in \mathbb{F}^{\mathcal{D}}$, We have two partial orders $\geq_{h i g h}$ et $\geq_{\text {left }}$ on the set $\operatorname{vert}(F)$ of vertices of $F$ (see [7] for more details). if $x, y$ are two vertices of $F$, then:

1. We will say that $x \geq_{h i g h} y$ if there is a path from $y$ to $x$.
2. If $s$ and $s^{\prime}$ are not comparable for $\geq_{h i g h}$, then one of this two vertices (say for example $x$ ) is more on the left than the other: we will denote this situation by $x \geq_{l e f t} y$.

These partial orders induce a total order $\geq_{d, l}$ on $\operatorname{vert}(F)$ defined by:

$$
x \geq_{d, l} y \text { if }\left(x \geq_{l e f t} y\right) \text { or }\left(y \geq_{h i g h} x\right)
$$

Theorem $51 \operatorname{Let} F, G \in \mathbb{F}^{\mathcal{D}}$. Let $\mathcal{I}(F, G)$ be the set of bijections $f$ from vert $(F)$ to $\operatorname{vert}(G)$ such that:

1. $\forall x, y \in \operatorname{vert}(F), x \geq_{\text {high }} y \Rightarrow f(x) \geq_{d, l} f(y)$,
2. $\forall x, y \in \operatorname{vert}(F), f(x) \geq_{\text {high }} f(y) \Rightarrow x \geq_{d, l} y$,
3. $\forall x \in \operatorname{vert}(F), x$ and $f(x)$ have the same decoration.

Then $<F, G>=\operatorname{card}(\mathcal{I}(F, G))$.
Proof. This is true if weight $(F) \neq$ weight $(G)$, as then $<F, G>=0$ and there is no bijection from $\operatorname{vert}(F)$ to $\operatorname{vert}(G)$. We suppose that $\operatorname{weight}(F)=w \operatorname{eight}(G)=n$, and let us proceed by induction on $n$. If $n=1$, then $<\cdot d, \cdot d^{\prime}>=\delta_{d, d^{\prime}}=\operatorname{card}\left(\mathcal{I}\left(\cdot d, \cdot d^{\prime}\right)\right)$ by condition 3 . Suppose that the property is satisfied for all $k<n$ and let $F, G \in \mathbb{F}^{\mathcal{D}}$ with $n$ vertices. We put $F=t_{1} \ldots t_{m}$.

If $m=1$ : then $F=t_{1}=B_{d}^{+}\left(F^{\prime}\right)$. So $<F, G>=<F^{\prime}, \xi_{d}(G)>$. Let $f \in \mathcal{I}(F, G)$. Denote by $r$ the root of $F$. Remark that for all $x \in \operatorname{vert}(F), x \geq_{h i g h} r$. By condition $1, f(r)$ is the smallest element of $\operatorname{vert}(G)$ for $\geq_{d, l}$ : it is the leave of $G$ at most on the right. If it is not decorated by $d$, then $<F, G>=0$ and $I(F, G)=\emptyset$ by condition 3 . Otherwise, there is a bijection $\mathcal{I}(F, G) \longrightarrow \mathcal{I}\left(F^{\prime}, \xi_{d}(G)\right)$, sending $f$ to its restriction à $\operatorname{vert}\left(F^{\prime}\right)$. As $<F, G>=<F^{\prime}, \xi_{d}(G)>$, we have the result.

If $m>1$ : we put $F^{\prime}=t_{1} \ldots t_{m-1}$. Let $f \in \mathcal{I}(F, G)$; consider $f\left(\operatorname{som}\left(t_{m}\right)\right)$. Let $y_{2}$ be a vertex of $G$, such that there exists $x_{1} \in \operatorname{vert}\left(t_{m}\right), f\left(x_{1}\right) \geq_{\text {high }} y_{2}$. There exists a unique $x_{2} \in \operatorname{som}(F)$, such that $f\left(x_{2}\right)=y_{2}$. By condition $2, x_{1} \geq_{d, l} x_{2}$ and then $x_{2} \in \operatorname{som}\left(t_{m}\right)$. Hence, there exists a unique admissible cut $c_{f}$ of $G$ such that $R^{c_{f}}(G)=f\left(t_{m}\right)$ and $P^{c_{f}}(F)=f\left(F^{\prime}\right)$. We then have a bijection:

$$
\left\{\begin{array}{rll}
\mathcal{I}(F, G) & \longrightarrow & \bigcup_{c \in \mathcal{A d m}(G)} \mathcal{I}\left(F^{\prime}, P^{c}(G)\right) \times \mathcal{I}\left(t_{m}, R^{c}(G)\right) \\
f & \longrightarrow & \left(f_{\mid \operatorname{som}\left(F^{\prime}\right)}, f_{\mid \operatorname{som}\left(t_{m}\right)}\right) \in \mathcal{I}\left(F^{\prime}, P^{c_{f}}(G)\right) \times \mathcal{I}\left(t_{m}, R^{c_{f}}(G)\right)
\end{array}\right.
$$

Hence:

$$
\begin{aligned}
<F, G> & =\sum_{c \in \mathcal{A} d m(G)}<F^{\prime}, P^{c}(G)><t_{m}, R^{c}(G)> \\
& =\sum_{c \in \mathcal{A} d m(G)}<F^{\prime}, P^{c}(G)><t_{m}, R^{c}(G)>
\end{aligned}
$$

$$
\begin{aligned}
& =\sum_{c \in \mathcal{A d m}(G)} \operatorname{card}\left(\mathcal{I}\left(F^{\prime}, P^{c}(G)\right)\right) \operatorname{card}\left(\mathcal{I}\left(t_{m}, R^{c}(G)\right)\right) \\
& =\operatorname{card}\left(\bigcup_{c \in \mathcal{A d m}(G)} \mathcal{I}\left(F^{\prime}, P^{c}(G)\right) \times \mathcal{I}\left(t_{m}, R^{c}(G)\right)\right) \\
& =\operatorname{card}(\mathcal{I}(F, G)) . \square
\end{aligned}
$$

We consider now the case where $\mathcal{D}$ is reduced to a single element. We can identify $\mathcal{H}^{\mathcal{D}}$ and $\mathcal{H}$. We will denote $B^{+}$instead of $B_{d}^{+}, \xi$ instead of $\xi_{d}$. We define $l_{k} \in \mathbb{F}$ by induction on $k$ in the following way: $l_{0}=1, l_{k+1}=B^{+}\left(l_{k}\right)$. For example:

$$
l_{1}=., l_{2}=\mathfrak{t}, l_{3}=\mathfrak{l}, l_{4}=\ddagger, l_{5}=\ddagger \ldots
$$

Proposition 52 Let $F \in \mathbb{F}$, of weight $n$. Then:

1. $\left\langle F, l_{n}\right\rangle=1$.
2. $\left\langle F, l_{n-1} \cdot\right\rangle$ is the number of roots of $F$.
3. $\left\langle F, \cdot l_{n-1}\right\rangle$ is the number of leaves of $F$.

## Proof.

1. Induction on $n$. If $n=0$, then $F=1$ and $\left.\left\langle F, l_{0}\right\rangle=<1,1\right\rangle=1$. Suppose that the result is true for all forest $G$ of weight $n-1$. Then $\left.\left.<F, l_{n}\right\rangle=<\xi(F), l_{n-1}\right\rangle=1$ as $\xi(F) \in \mathbb{F}$.
2. Let $X$ be the set of $F \in \mathbb{F}, F \neq 1$, satisfying 2 . Let $G \in \mathbb{F}$, with $n$ vertices. We have $<B^{+}(G), l_{n} .>=<G, \xi\left(l_{n}.\right)>=<G, l_{n}>=1$, so $B^{+}(G) \in X: X$ contents the trees.

Let $F_{1}, F_{2} \in X$, with respectively $n_{1}$ and $n_{2}$ vertices. We put $n=n_{1}+n_{2}$. We have:

$$
\begin{aligned}
<F_{1} F_{2}, l_{n-1} \cdot> & \left.=<F_{1} \otimes F_{2}, \Delta\left(l_{n-1} \cdot\right)\right\rangle \\
& \left.=\sum_{i+j=n-1}<F_{1} \otimes F_{2}, l_{i} \cdot \otimes l_{j}+l_{i} \otimes l_{j} \cdot\right\rangle \\
& =<F_{1} \otimes F_{2}, l_{n_{1}-1} \cdot \otimes l_{n_{2}}+l_{n_{1}} \otimes l_{n_{2}-1} \cdot>\text { by homogeneity }, \\
& =\left\langle F_{1}, l_{n_{1}-1} \cdot>+<F_{2}, l_{n_{2}-1} \cdot>\right.
\end{aligned}
$$

So $F_{1} F_{2} \in X$. As $X$ contents the trees, $X=\mathbb{F}-\{1\}$.
3. Let $Y$ be the set of $F \in \mathbb{F}, F \neq 1$, satisfying 3 . We have $\left.\left\langle\cdot, \cdot l_{0}\right\rangle=<\cdot,.\right\rangle=1$, so $\boldsymbol{\bullet} \in Y$.

Let $G \in Y$, with $n$ vertices. We have $<B^{+}(G), . l_{n}>=<G, \xi\left(\cdot l_{n}\right)>=<G, \cdot l_{n-1}>$. As $G$ and $B^{+}(G)$ have the same number of leaves, $B^{+}(G) \in Y$, so $Y$ is stable under $B^{+}$.

Let $F_{1}, F_{2} \in Y$, with respectively $n_{1}$ and $n_{2}$ vertices. We put $n=n_{1}+n_{2}$. We have:

$$
\begin{aligned}
<F_{1} F_{2}, \cdot l_{n-1}> & =\left\langle F_{1} \otimes F_{2}, \Delta\left(\cdot l_{n-1}\right)>\right. \\
& \left.=\sum_{i+j=n-1}<F_{1} \otimes F_{2}, \cdot l_{i} \otimes l_{j}+l_{i} \otimes \cdot l_{j}\right\rangle \\
& \left.=<F_{1} \otimes F_{2}, \cdot l_{n_{1}-1} \otimes l_{n_{2}}+l_{n_{1}} \otimes \cdot l_{n_{2}-1}\right\rangle \text { by homogeneity, } \\
& \left.=\left\langle F_{1}, \cdot l_{n_{1}-1}\right\rangle+<F_{2}, \cdot l_{n_{2}-1}\right\rangle
\end{aligned}
$$

So $F_{1} F_{2} \in Y$. As $Y$ is stable under product and under $B^{+}$and contents $\boldsymbol{\bullet}, Y=\mathbb{F}-\{1\}$.

Examples. Here are the values of the pairing $<,>$ of $\mathcal{H}$ on forests of weight smaller than 4:
