ON RESTRICTION PROPERTIES OF EQUIVARIANT K-THEORY RINGS.

ABDELOUAHAB AROUCHE

ABSTRACT. An important ingredient in the completion theorem of equivariant K-theory given by S. Jackowski is that the representation ring $R(\Gamma)$ of a compact Lie group satisfies two restriction properties called (N) and $(R_{\mathcal{F}})$.

We give in this note sufficient conditions on a (compact) Γ -space Z such that these properties hold with $K_{\Gamma}^*(Z)$ instead of $R(\Gamma)$. As an example, we consider the space $Z(\Gamma;G)$ of the so called "elementary cocycles with coefficients in G" invented by H. Ibisch in his construction of a universal $(\Gamma;G)$ -bundle.

1. Introduction

In what follows, let Γ be a compact Lie group and Z a compact Γ -space. Consider, for every subgroup $\Lambda \leq \Gamma$, the ring $M_{\Lambda} = K_{\Lambda}^*(Z)$. We have a restriction morphism $res: M_{\Gamma} \to M_{\Lambda}$ whose kernel is denoted by I_{Λ}^{Γ} or I_{Λ} for short. If \mathcal{F} is a family of (closed) subgroups of Γ (stable under subconjugation), then the \mathcal{F} -adic topology on M_{Γ} is defined by the set of ideals

$$I(\mathcal{F}) = \{I_{\Lambda_1}.I_{\Lambda_2}...I_{\Lambda_n}, \Lambda_i \in \mathcal{F}, i = 1,...,n\}.$$

If $\Lambda \leq \Gamma$, then $\mathcal{F} \cap \Lambda = \{\Omega \in \mathcal{F} : \Omega \leq \Lambda\}$ is a family of subgroups of Λ .

Let X be a compact Γ -space with a Γ -map $\sigma: X \to Z$. Define the two pro-rings

$$K_{\Gamma}^*[\mathcal{F}](X) = \{K_{\Gamma}^*(X \times K) : K \ compact \subseteq E\mathcal{F}\},$$

and

$$\left(K_{\Gamma}^{*}/I\left(\mathcal{F}\right)\right)\left(X\right) = \left\{K_{\Gamma}^{*}\left(X\right)/I.K_{\Gamma}^{*}\left(X\right): \ I \in I\left(\mathcal{F}\right)\right\}$$

Here $E\mathcal{F}$ denotes the classifying space of T. tom Dieck [7]. The completion theorem asserts that the pro-homomorphism

$$p_X(\mathcal{F}): K_{\Gamma}^* \left[\mathcal{F} \right] (X) \to \left(K_{\Gamma}^* / I(\mathcal{F}) \right) (X)$$

induced by the projection $X \times E\mathcal{F} \to X$, is actually an isomorphism, provided M_{Λ} satisfies the conditions (N) and $(R_{\mathcal{F}})$, and $K_{\Lambda}(X)$ is finitely generated over M_{Λ} (via σ), for all $\Lambda \leq \Gamma$.

In order to prove his completion theorem [4], S. Jackowski required the following two conditions, and showed they are satisfied when Z = * is a point :

 $(N): M_{\Gamma}$ is noetherian and M_{Λ} is a finitely generated M_{Γ} -module, $\forall \Lambda \leq \Gamma$.

 $(R_{\mathcal{F}})$: For every family \mathcal{F} of subgroups of Γ , and every subgroup $\Lambda \leq \Gamma$, the \mathcal{F} -adic topology on M_{Λ} defined by the restriction $res: M_{\Gamma} \to M_{\Lambda}$ coincides with the $(\mathcal{F} \cap \Lambda)$ -adic topology.

2. Some nilpotent elements in $K^*_{\Gamma}(Z)$.

Let $z\in Z$, and Γ_z be its isotropy subgroup. Then an element $\zeta\in M_\Gamma$ belongs to $\ker\left\{K_\Gamma^*(Z)\stackrel{\varphi_z}{\to}R(\Gamma_z)\right\}$ if and only if its restriction to the orbit $\Gamma.z$ is zero. It is well known that the elements of $\ker\left\{K_\Gamma^*(Z)\to\prod_{z\in Z}R(\Gamma_z)\right\}$ are nilpotent [6](5.1). We have the following :

Lemma 1. Let $z \in Z$ and $\zeta \in \ker \{K_{\Gamma}^*(Z) \to R(\Gamma_z)\}$. Then there exists a relatively compact open Γ -neighbourhood $V(\zeta)$ of z such that the restriction of ζ to $\overline{V(\zeta)}$ is nilpotent.

Proof. If $\zeta = E - \mathbf{T} \in \ker \{K_{\Gamma}^*(Z) \to R(\Gamma_z)\}$, then $E_z - T = 0 \in R(\Gamma_z)$, where T is seen as a Γ_z -module. Therefore, there exists a Γ_z -module R such that $E_z \oplus R \cong T \oplus R$. Consider the isomorphism between Γ_z - vector bundles:

$$E \oplus \mathbf{R} \mid_{\{z\}} \cong \mathbf{T} \oplus \mathbf{R} \mid_{\{z\}}$$
.

According to [6](1.2), there is a Γ_z -neighbourhood U of z and a Γ_z - isomorphism

$$E \oplus \mathbf{R} \mid_{U} \cong \mathbf{T} \oplus \mathbf{R} \mid_{U}$$
.

Let S be a slice at z ([2] II.4.1). Then Γ . $(S \cap U)$ is an open Γ -neighbourhood of z such that $\zeta \in \ker \{K_{\Gamma}^*(Z) \to R(\Gamma_y)\}$, $\forall y \in \Gamma$. $(S \cap U)$. Now let $V(\zeta)$ be any open Γ -neighbourhood of z satisfying

$$z \in V(\zeta) \subseteq \overline{V(\zeta)} \subseteq \Gamma. (S \cap U).$$

Proposition 1. Assume $K_{\Gamma}^*(Z)$ is noetherian. Then there exists a finite subset $Y \subseteq Z$ such that the ideal $\ker \left\{ K_{\Gamma}^*(Z) \to \prod_{y \in Y} R(\Gamma_y) \right\}$ consists of nilpotent elements.

Proof. For each $z \in Z$, let $\ker \{K_{\Gamma}^*(Z) \to R(\Gamma_z)\}$ be generated by $\zeta_1, ..., \zeta_{n_z}$, and for $j = 1, ..., n_z$, let $V(\zeta_j)$ be as in lemma (2.1). Put

$$V_z = \bigcap_{j=1,\dots,n_z} V(\zeta_j).$$

Since Z is compact, it can be covered by a finite number of such open subsets:

$$Z = \underset{i=1,...,n}{\cup} V_{z_i}.$$

It is easy to show that the ideal $\ker\left\{K_{\Gamma}^*(Z)\to\prod_{i=1,\dots,n}R(\Gamma_{z_i})\right\}$ consists of nilpotent elements. \Box

3. Supports of primes

In [4], G. Segal defined the support suppy of a prime $y \in SpecR(\Gamma)$ to be a minimal subgroup from which y comes. We have shown in [1] that such a notion does exist for primes in M_{Γ} . Indeed, if $p: Z \to *$ is the projection of a Γ -space Z on a fixed point and $p^*: R(\Gamma) \to M_{\Gamma}$ is the induced homomorphism, we have the following:

Proposition 2. Let $\Lambda \leq \Gamma$ be a (closed) subgroup. Assume M_{Γ} is noetherian and let $x \in SpecM_{\Gamma}$. Then the following properties are equivalent:

- (1) x come from M_{Λ} , i.e. $\exists y \in SpecM_{\Lambda} : x = res^{-1}(y)$.
- (2) x contains I_{Λ} .
- (3) $supp(p^{*-1}(x))$ is subconjugate to Λ .

In order to prove proposition (3.1), we need the following lemma:

Lemma 2. Let $x \in SpecM_{\Gamma}$ and $z \in Z$ be such that there exists a prime $t \in SpecR(\Gamma_z)$, with support Σ , satisfying $x = \varphi_z^{-1}(t)$, $\varphi_z : M_{\Gamma} \to R(\Gamma_z)$. Let $\gamma \in \Gamma$ and $z' = \gamma z$. Then there exists a prime $t' \in SpecR(\Gamma_{z'})$, with support $\Sigma' = \gamma \Sigma \gamma^{-1}$, satisfying $x = \varphi_{z'}^{-1}(t')$, $\varphi_{z'} : M_{\Gamma} \to R(\Gamma_{z'})$.

Proof. Let $\Gamma.z \stackrel{i}{\hookrightarrow} Z$ be the inclusion of the orbit of z. We have the following commutative diagram :

$$R(\Gamma_{z})$$

$$\uparrow$$

$$K_{\Gamma}^{*}(Z) \xrightarrow{i^{*}} K_{\Gamma}^{*}(\Gamma.z)$$

$$\downarrow$$

$$\varphi_{\gamma.z}$$

$$R(\Gamma_{\gamma.z})$$

It is clear that both χ_z and $\chi_{\gamma,z}$ are isomorphisms. Put $h = \chi_z^{-1} \circ \chi_{\gamma,z}$. Then h admits a restriction $\widetilde{h}: R(\Sigma) \to R(\gamma \Sigma \gamma^{-1})$, which makes the following diagram commute and ends the proof:

$$K_{\Gamma}^{*}(Z) \xrightarrow{i^{*}} K_{\Gamma}^{*}(\Gamma.z) \xrightarrow{\chi_{z}} R(\Gamma_{z}) \xrightarrow{res} R(\Sigma)$$

$$\cong \downarrow h \qquad \cong \downarrow \widetilde{h}$$

$$\chi_{\gamma.z} \qquad R(\Gamma_{\gamma.z}) \xrightarrow{res} R(\gamma \Sigma \gamma^{-1})$$

Proof. Now we proceed to prove proposition (3.1) (see [1]). 1) \Longrightarrow 2) and 2) \Longrightarrow 3) are obvious. Let us prove 3) \Longrightarrow 1). To this end, let $z_1,...,z_n$ be elements of Z such that $\ker\left\{\varphi:K_\Gamma^*(Z)\to\prod_{i=1,...,n}R(\Gamma_{z_i})\right\}$ consists of nilpotent elements. Since every $R(\Gamma_{z_i})$ is finitely generated over M_Γ (it i even finitely generated over $R(\Gamma)$ [5]), the induced map on spectra $\varphi_*:\coprod_{i=1,...,n}SpecR(\Gamma_{z_i})\to SpecM_\Gamma$ is onto. So there

is an element $z \in Z$ and a prime $t \in SpecR(\Gamma_z)$ such that $x = \varphi_z^{-1}(t)$. Following [5] (3.7), we have $supp(p^{*-1}(x)) = supp(t)$. Let $\Sigma = supp(p^{*-1}(x))$. By assumption, the exists $\gamma \in \Gamma$ such that $\gamma \Sigma \gamma^{-1} \leq \Lambda$. Put $z' = \gamma .z$. According to lemma (3.2), there exists a prime $t' \in SpecR(\Gamma_{z'})$, with support $\Sigma' = \gamma \Sigma \gamma^{-1}$, and satisfying

$$x = \varphi_{z'}^{-1}(t'), \ \varphi_{z'}: M_{\Gamma} \to R(\Gamma_{\gamma z}).$$

Therefore, $x \in SpecM_{\Gamma}$ comes from Λ , as shown by the commutative diagram :

$$\begin{array}{ccc}
M_{\Gamma} & \to & M_{\Lambda} \\
\downarrow & & \downarrow \\
R(\Gamma_{\gamma.z}) & \to & R(\Lambda_{\gamma.z}) \\
& & \swarrow
\end{array}$$

Hence, $supp(p^{*-1}(x))$ is, up to conjugation, the minimal subgroup of Γ from which x comes. We denote it by supp(x). Consequently, if $(x,y) \in SpecM_{\Gamma} \times SpecM_{\Lambda}$ is such that $x = res^{-1}(y)$, then supp(x) = supp(y).

4. The restriction properties

Let us first consider the condition $(R_{\mathcal{F}})$. We have the following:

Theorem 1. Assume M_{Λ} is noetherian $\forall \Lambda \leq \Gamma$. Then, for every family \mathcal{F} of subgroups of Γ , the condition $(R_{\mathcal{F}})$ is satisfied.

Proof. For each $\Omega \in \mathcal{F}$ we have $I_{\Omega}^{\Lambda} \supseteq I_{\Omega}^{\Gamma}.M_{\Lambda}$. So it remains only to show that for any ideal $I.M_{\Lambda}$, where $I \in I(\mathcal{F})$, there is an ideal $J \in I(\mathcal{F} \cap \Lambda)$ such that $J \subseteq r(I.M_{\Lambda})$, since M_{Λ} is noetherian. It is enough to do that for $I = I_{\Omega}^{\Gamma}$. So let $p_1, ..., p_n$ be minimal prime ideals in M_{Λ} containing $I.M_{\Lambda}$, and let $\Sigma_1, ..., \Sigma_n$ be their supports. Put $J = I_{\Sigma_1}...I_{\Sigma_n}$. Since p_i comes from Σ_i , we have $J \subseteq I_{\Sigma_1} \cap ... \cap I_{\Sigma_n} \subseteq p_1 \cap ... \cap p_n = r(I)$. Now, if we put $q_i = res^{-1}(p_i)$, then $\Sigma_i = supp(q_i)$. But q_i comes from Ω because it contains I_{Ω}^{Γ} . Hence, Σ_i is subconjugate to Ω . Since $\Omega \in \mathcal{F}$, so doe Σ_i , for i = 1, ..., n, that is, $J \in I(\mathcal{F} \cap \Lambda)$.

Corollary 1. If the condition (N) is satisfied, then so is the condition $(R_{\mathcal{F}})$.

It is easy to see that the condition (N) is fulfilled if Z is a (compact) differentiable Γ -manifold, and more generally, for any finite Γ -CW-complex, for M_{Λ} is a finitely generated module over $R(\Lambda)$, $\forall \Lambda \leq \Gamma$. This can be shown by induction and use of Mayer-Vietoris sequence.

Corollary 2. Assume M_{Λ} is finitely generated over $R(\Gamma)$, $\forall \Lambda \leq \Gamma$. Then the conditions (N) and $(R_{\mathcal{F}})$ are satisfied for every family \mathcal{F} of subgroups of Γ .

5. An example

For a topological group G and a family \mathcal{F} of subgroups of a compact Lie group Γ , H.Ibisch has constructed in [2] a universal $(\Gamma; G)$ -bundle $E(\mathcal{F}; G)$ whose "components" are the spaces

$$Z\left(\Lambda;G\right) = \left\{f: \Lambda \times \Lambda \to G: f\left(\lambda_{1}.\lambda_{2},\lambda_{3}\right) = f\left(\lambda_{1},\lambda_{2}.\lambda_{3}\right), \ \forall \lambda_{1},\lambda_{2},\lambda_{3} \in \Lambda\right\}, \Lambda \leq \Gamma.$$

The crucial fact is that for a Γ -space X, trivial $(\Gamma; G)$ -bundles over X correpond to Γ -maps $\sigma: X \to Z(\Gamma; G)$. We then take $Z = Z(\Gamma; G)$. Actually, the Γ -space $Z(\Gamma; G)$ turns to be Γ -homeomorphic to the space of maps $\Gamma \to G$ sending 1_{Γ} to 1_{G} . Moreover, $Z(\Gamma; G)^{\Gamma}$ is the space of (continuous) homomorphisms $\Gamma \to G$. When Γ is finite, the space $Z(\Gamma; G)$ has a further description. For instance, if $\Gamma = \mathbf{Z}_n$ is the cyclic group of order n, then $Z(\Gamma; G)$ is the product $G^{n-1} \times \{1_G\}$ with the action $\gamma^i.(g_1,...,g_n=1_G)=(g_{1+i}g_i^{-1},...,g_{n+i}g_i^{-1})$, where γ is a generator of \mathbf{Z}_n and the indexation is mod [n], hence $Z(\mathbf{Z}_2; G)$ is no but G with involution $g \mapsto g^{-1}$. If G is moreover a compact Lie group, then $Z(\Gamma; G)$ is a compact Γ -manifold. Accordingly, the conditions (N) and $R(\mathcal{F})$ are satisfied.
