# CONJUGACY OF PIECEWISE $C^{1}$-HOMEOMORPHISMS OF CLASS $P$ OF THE CIRCLE 

ABDELHAMID ADOUANI AND HABIB MARZOUGUI


#### Abstract

We give a characterization of piecewise $C^{1}$-homeomorphism of class $P$ of the circle with irrational rotation number and finitely many break points which are piecewise differentiably conjugate to $C^{1}$ diffeomorphims. The following properties are equivalent: i) $f$ is conjugate to a $C^{1}$-diffeomorphism of the circle by a piecewise $C^{1}$-homeomorphism of class $P$. ii) The number of break points of $f^{n}$ is bounded by some constant that doesn't depend on $n$. iii) The product of jumps of $f$ in the break points contained in a same orbit is equal 1. iv) $f$ is conjugate to a $C^{1}$-diffeomorphism of the circle by a piecewise quadratic homeomorphism of class $P$.

This characterization extend Liousse's Theorem for $P L$ homeomorphisms of the circle ([3]).


## 1. Introduction

1.1. Preliminaries. Denote by $S^{1}=\mathbb{R} / \mathbb{Z}$ the circle and $\pi: \mathbb{R} \longrightarrow S^{1}$ the canonical projection. Let $f$ be an orientation preserving homeomorphism of $S^{1}$. The homeomorphism $f$ admits a lift $\tilde{f}: \mathbb{R} \longrightarrow \mathbb{R}$ that is an increasing homeomorphism of $\mathbb{R}$ such that $\pi o \tilde{f}=f o \pi$. Conversely, the projection of such a homeomorphism of $\mathbb{R}$ is an orientation preserving homeomorphism of $S^{1}$.

Let $x \in S^{1}$. We call:

- orbit of $x$ by $f$ the subset $O_{f}(x)=\left\{f^{n}(x): n \in \mathbb{Z}\right\}$
- positive orbit from $x$ by $f$ the subset $O_{f}^{+}(x)=\left\{f^{n}(x): n \in \mathbb{N}\right\}$
- negative orbit from $x$ by $f$ the subset $O_{f}^{-}(x)=\left\{f^{n}(x): n \in-\mathbb{N}\right\}$

A segment of the orbit $O_{f}(d)$ containing $d$ is a subset of the form $\left\{f^{s}(d)\right.$ : $-k \leq s \leq n-k\}$, noted $\left[f^{-k}(d), \ldots, f^{n-k}(d)\right], k, n \in \mathbb{N}$.

[^0]Historically, the dynamic study of circle homeomorphisms was initiated by H. Poincaré ([4], 1886), he introduced the rotation number of a homeomorphism $f$ of $S^{1}$ as

$$
\rho(f)=\lim _{n \longrightarrow+\infty} \frac{\tilde{f}^{n}(x)-x}{n}(\bmod 1)
$$

Poincaré shows that this limit exist and does not depends of $x$ and the lift $\tilde{f}$ of $f$.

Assuming $f$ is a $C^{r}$-diffeomorphism $(r \geq 2)$ and $\rho(f)$ is irrational, A. Denjoy ([2]) proved:

Theorem 1.1. (Denjoy)([2]). Every $C^{r}$-diffeomorphism $f(r \geq 2)$ with irrational rotation number $\rho(f)$ is topologically conjugate to rotation $R_{\rho(f)}$.

This means that there exists an orientation preserving homeomorphism $h$ of $S^{1}$ such that $f=h^{-1} \circ R_{\rho(f)} \circ h$.

Denjoy noted that this result can be extended (with the same proof) to a large class of circle homeomorphisms: the class $P$.

### 1.2. Class $P$

Definition 1.2. Let $f$ be a piecewise $C^{1}$ orientation preserving homeomorphism of $S^{1}$. A break point of $f$ is a point of discontinuity of the derivative $D f$. The homeomorphism $f$ is called of class $P$ if it is $C^{1}$ except in a finitely or countably many break points admitting left and right derivatives; the derivative $D f: S^{1} \longrightarrow \mathbb{R}_{+}^{\star}$ has the following properties :

- there exist two constants $0<a<b<+\infty$ such that:

$$
a<D f(x)<b,
$$

for all $x$ where $D f$ exists,

$$
a<D f_{+}(c)<b, \text { and } a<D f_{-}(c)<b \text { at the break point } c,
$$

- $\log D f$ is a bounded variation on $S^{1}$

The ratio $\sigma_{f}(c):=\frac{D f_{+}(c)}{D f_{-}(c)}$ is called jump of $f$ in $c$.
Notice that homeomorphisms of class $P$ form a sub-group of the group of orientation preserving homeomorphisms of $S^{1}$.

As examples of homeomorphisms of class $P$, we mention:

- the $C^{2}$-diffeomorphisms,
- The $P L$ homeomorphisms (i.e. piecewise linear), these are not $C^{2}$ diffeomorphisms. An orientation preserving homeomorphism $f$ of $S^{1}$ is called a $P L$ homeomorphism if $f$ is differentiable except at finite number of break points $\left(c_{i}\right)_{1 \leq i \leq p}$ of $S^{1}$ and such that $D f$ is constant on each $] c_{i}, c_{i+1}[$.


Figure 1. General Boshernitzan of last break point 0
The set of $P L$ homeomorphisms is a sub-group of the group of homeomorphisms of class $P$ and contains rotations.

Analytic homeomorphisms are not of class $P$. By J.C. Yoccoz [5], they satisfy the conclusion of Denjoy theorem but not Denjoy theory.

Definition 1.3. A piecewise $C^{1}$-homeomorphism $B$ of class $P$ of $S^{1}$ with two break points $x_{0}$ and $B\left(x_{0}\right)$ is called a general Boshernitzan of $S^{1}$ of last break point $B\left(x_{0}\right)$. If $B\left(x_{0}\right)=0, B$ is called a standard Boshernitzan of last break point 0 (see Figure 1).

If we conjugate a standard Boshernitzan $B_{0}$ of last break point 0 by a rotation $R_{x_{0}}$, the homeomorphism $R_{x_{0}} \circ B_{0} \circ R_{x_{0}}^{-1}$ is a general Boshernitzan of last break point $B\left(x_{0}\right)$ and conversely.

The lift $\tilde{B}_{0}(\bmod 1)$ of $B_{0}$ on $[0,1[$ is a general exchange of 2 intervals on $[0,1[$. The affine Boshernitzan correspond to affine exchange of 2 intervals on $[0,1[$.

Notice that Boshernitzan was the first who studied these examples in order to built examples of "rational" $P L$ homeomorphisms with irrational rotation numbers (cf. [1]).

Denote by

- $C(f)$ the set of break points of $f$.
- $\pi_{s}(f)$ the product of jumps of $f$ in the break points of $f$ :

$$
\pi_{s}(f)=\prod_{c \in C(f)} \sigma_{f}(c) .
$$

Definition 1.4. ([3]) A piecewise $C^{1}$-homeomorphism $f$ of class $P$ of $S^{1}$ has the property $D$ if the product of jumps of $f$ in the break points of $f$ contained in a same orbit is equal 1 .

In particular, if $f$ has the property $D$ then $\pi_{s}(f)=1$. Conversely, if $\pi_{s}(f)=1$ and if all break points of $f$ are contained in a same orbit then $f$ has the property $D$. If $f$ is a $P L$ homeomorphism we have always $\pi_{s}(f)=1$ and therefore if all the break points of $f$ are contained in a same orbit then $f$ satisfies property $D$.

Proposition 1.5. (Invariance of $\pi_{s}$ by piecewise $C^{1}$ conjugacy).
Let $f, g$ be two orientation preserving piecewise $C^{1}$ - homeomorphisms of class $P$ of $S^{1}$. If $f$ and $g$ are piecewise $C^{1}$ conjugate then $\pi_{s}(f)=\pi_{s}(g)$.
Proof. Let $H$ be the piecewise $C^{1}$-homeomorphism which conjugate $f$ to $g$ : Hof $=g o H$. For $x \in S^{1}$, we define $\pi_{s}(f)(x)=\prod_{y \in O_{f}(x)} \sigma_{f}(y)$ the product of jumps of $f$ in the break points contained in the orbit of $x$. Since $O_{g}(H(x))=H\left(O_{f}(x)\right)$ then

$$
\pi_{s}(g)(H(x))=\prod_{z \in O_{g}(H(x))} \sigma_{g}(z)=\prod_{y \in O_{f}(x)} \sigma_{g}(H(y)) .
$$

Since $\sigma_{g}(H(y))=\frac{\sigma_{H}(f(y)) \sigma_{f}(y)}{\sigma_{H}(y)}$ then
$\pi_{s}(g)(H(x))=\prod_{y \in O_{f}(x)} \frac{\sigma_{H}(f(y)) \sigma_{f}(y)}{\sigma_{H}(y)}=\pi_{s}(f)(x) \prod_{y \in O_{f}(x)} \frac{\sigma_{H}(f(y))}{\sigma_{H}(y)}$.
Or $\prod_{y \in O_{f}(x)} \frac{\sigma_{H}(f(y))}{\sigma_{H}(y)}=\prod_{k \in \mathbb{Z}} \frac{\sigma_{H}\left(f\left(f^{k}(x)\right)\right)}{\sigma_{H}\left(f^{k}(x)\right)}=\frac{\prod_{k \in \mathbb{Z}} \sigma_{H}\left(f^{k}(x)\right)}{\prod_{k \in \mathbb{Z}} \sigma_{H}\left(f^{k}(x)\right)}=1$.
Hence $\pi_{s}(g)(H(x))=\pi_{s}(f)(x)$ and therefore $\pi_{s}(g)=\pi_{s}(f)$.

In the sequel, we suppose that homeomorphisms $f$ of class $P$ considered have only a finite number of break points i.e. $C(f)$ is finite.

Our main result is the following :

Theorem 1.6. Let $f$ be a piecewise $C^{1}$-homeomorphism of class $P$ of the circle with irrational rotation number. The following properties are equivalent:
i) $f$ is conjugate to a $C^{1}$-diffeomorphism of the circle through a piecewise $C^{1}$-homeomorphism.
ii) The number of break points of $f^{n}$ is bounded by some constant that doesn't depend on $n$.
iii) $f$ satisfies property $D$.
iv) $f$ is conjugate to a general Boshernitzan (of last break point $B\left(x_{0}\right)$ such that $\sigma_{B}\left(x_{0}\right) \times \sigma_{B}\left[B\left(x_{0}\right)\right]=1$ ) or a $C^{1}$-diffeomorphism of the circle through a $P L$ homeomorphism.
v) $f$ is conjugate to a $C^{1}$-diffeomorphism of the circle through a piecewise quadratic homeomorphism.

Corollary 1.7. Under the hypothesis of Theorem 1.6, if the number of break points of $f^{n}$ is bounded by some constant that doesn't depend on $n$ then $f$ is conjugate to a $C^{1}$-diffeomorphism of the circle through a piecewise quadratic homeomorphism.

It follows from Theorem 1.6:
Corollary 1.8. ([3]) Let $f$ be a PL homeomorphism of the circle with irrational rotation number $\alpha$. The following properties are equivalent:
i) $f$ is conjugate to the rotation $R_{\alpha}$ through a piecewise $C^{1}$-homeomorphism,
ii) The number of break points of $f^{n}$ is bounded by some constant that doesn't depend on $n$.
iii) $f$ is conjugate to an affine Boshernitzan of last break point 0 or a rotation with rotation number $\alpha$ through a $P L$ homeomorphism,
iv) $f$ is conjugate to $R_{\alpha}$ through a piecewise $C^{\infty}$ (analytic) homeomorphism.

## 2. Homeomorphisms of class $P$ with property $D$

Let $n \in \mathbb{N}$. Denote by $C\left(f^{n}\right)$ the set of break points of $f^{n}$. We have $C\left(f^{n}\right) \subset\left\{f^{-k}(c), k=0,1, \ldots, n-1 ; c \in C(f)\right\}$.

Let $x \in S^{1}$, we have :

$$
D f^{n}(x)=D f(x) \times D f(f(x)) \times \ldots \times D f\left(f^{n-1}(x)\right)
$$

The jump of $f^{n}$ in $x$ is then :

$$
\sigma_{f^{n}}(x)=\sigma_{f}(x) \times \sigma_{f}(f(x)) \times \ldots \times \sigma_{f}\left(f^{n-1}(x)\right)
$$

Definition 2.1. Let $c \in C(f)$. A maximal connection of $c$ is a segment $M=\left[f^{-p}(c), \ldots, f^{q}(c)\right]$ of the orbit $O_{f}(c)$ which contains all the break points of $f$ contained on $O_{f}(c)$ and such that $f^{-p}(c)$ (resp. $f^{q}(c)$ ) is the first (resp. last) break point of $f$ on $O_{f}(c)$.

Hence, the negative orbit $O_{f}^{-}\left(f^{-p}(c)\right)$ (resp. positive orbit $\left.O_{f}^{+}\left(f^{q}(c)\right)\right)$ from $f^{-p}(c)$ (resp. from $\left.f^{q}(c)\right)$ doesn't contain any break point of $f$.

The following properties are trivial:

- Two break points of $f$ are on the same maximal connection, if and only if, they are on the same orbit.
- Two distinct maximal connections are disjoints.

There is a finite number of maximal connections ; denoted by
$M_{1}=\left[f^{-N_{1}}\left(c_{1}\right), \ldots, c_{1}\right], \ldots, M_{p}=\left[f^{-N_{p}}\left(c_{p}\right), \ldots, c_{p}\right]$ where $c_{1}, \ldots, c_{p} \in C(f)$.
So, we have the decomposition :
$C(f)=\coprod_{i=1}^{p} C_{i}$ where $C_{i}=C(f) \cap M_{i}, i=1, \ldots, p$.
This is equivalent to say that: for every $i=1, \ldots, p$, the product of jumps of $f$ in the break points of $C_{i}$ is equal 1 (i.e. $\prod_{d \in C_{i}} \sigma_{f}(d)=1$ ). We have also

$$
\begin{aligned}
\prod_{d \in C_{i}} \sigma_{f}(d) & =\prod_{d \in M_{i}} \sigma_{f}(d) . \text { So, } f \text { satisfies the property } D \text { means that } \\
\prod_{d \in C_{i}} \sigma_{f}(d) & =1 .
\end{aligned}
$$

Proposition 2.2. Let $f$ be a homeomorphism of class $P$ of the circle with irrational rotation number $\alpha$. Then $f$ has property $D$ if and only if the number of break points of $f^{n}$ is bounded by some constant $N_{0}$ that doesn't depend on $n$.

Proof. Suppose that the number of break points of $f^{n}$ is bounded by a constant $N_{0}$. Let $d \in C(f)$ and $M=\left[f^{-p}(d), \ldots, f^{q}(d)\right]$ be the maximal connection of $d$. Lets show that $\prod_{\delta \in M} \sigma_{f}(\delta)=1$ :

Let $n \in \mathbb{N}$ fixed. We have :

$$
C\left(f^{n+1}\right) \subset\left\{f^{-k}(c): c \in C(f), 0 \leq k \leq n\right\}
$$

and

$$
\sigma_{f^{n+1}}\left[f^{-k}(d)\right]=\sigma_{f}\left[f^{-k}(d)\right] \times \ldots \times \sigma_{f}\left[f^{n-k}(d)\right]
$$

We let :

$$
J_{n}:=\left\{0 \leq k \leq n: \sigma_{f^{n+1}}\left[f^{-k}(d)\right]=1\right\} .
$$

By hypothesis :

$$
\operatorname{card}\left\{0 \leq k \leq n ; \sigma_{f^{n+1}}\left[f^{-k}(d)\right] \neq 1\right\} \leq N_{0}
$$

Then

$$
\operatorname{card}\left(J_{n}\right) \geq n+1-N_{0} .
$$

For $n$ such that $n>N_{0}+p$, we have $\operatorname{card}\left(J_{n}\right)>p+1 \geq \operatorname{card}(J)$ where $J=\left\{0 \leq k \leq p: \sigma_{f^{n+1}}\left[f^{-k}(d)\right]=1\right\}$. Therefore, $J$ est strictly contained in $J_{n}$. Let $K_{n}:=J_{n}-J$ and let $k_{n}$ be the minimum of $K_{n}$. Since
$n-k_{n}+1 \geq \operatorname{card}\left(K_{n}\right)$ and $\operatorname{card}\left(K_{n}\right) \geq n-\left(N_{0}+p\right)$ then
$p+1 \leq k_{n} \leq p+N_{0}+1$ for $n>p+N_{0}$.
As

$$
\sigma_{f^{n+1}}\left[f^{-k_{n}}(d)\right]=\sigma_{f}\left[f^{-p}(d)\right] \times \ldots \times \sigma_{f}\left[f^{n-k_{n}}(d)\right]
$$

then

$$
\sigma_{f}\left[f^{-p}(d)\right] \times \sigma_{f}\left[f^{-p+1}(d)\right] \times \ldots \times \sigma_{f}[f(d)]=\sigma_{f^{n+1}}\left[f^{-k_{n}}(d)\right]
$$

for every $n>p+q+N_{0}$. It follows,

$$
\sigma_{f}\left[f^{-p}(d)\right] \times \sigma_{f}\left[f^{-p+1}(d)\right] \times \ldots \times \sigma_{f}\left[f^{q}(d)\right]=\prod_{\delta \in M} \sigma_{f}(\delta)=1 .
$$

Conversely, suppose that for every $d \in C(f)$, the product of jumps of $f$ in the break points of the maximal connection of $d$ is equal 1 . Lets show that the number of break points of $f^{n}$ is bounded.

Let $n \in \mathbb{N}$. The point of discontinuity of $D f^{n}$ are among $f^{-k}\left(c_{i}\right), k=0,1, \ldots, n+N_{i}-1, i=1, \ldots, p$.
The jump of $f^{n}$ in these points are :

$$
\sigma_{f^{n}}\left[f^{-k}\left(c_{i}\right)\right]=\sigma_{f}\left[f^{-k}\left(c_{i}\right)\right] \times \ldots \times \sigma_{f}\left(c_{i}\right) \times \ldots \times \sigma_{f}\left[f^{n-k-1}\left(c_{i}\right)\right] .
$$

If $k \geq N_{i}$ and $n-k-1 \geq 0$ then the segment of orbit $\left[f^{-k}\left(c_{i}\right), \ldots, f^{n-k-1}\left(c_{i}\right)\right]$ contains the maximal connection of $c_{i}$. Hence, $\sigma_{f^{n}}\left[f^{-k}\left(c_{i}\right)\right]=1$. So, a necessary condition for $f^{-k}\left(c_{i}\right)$ to be a discontinuity point of $D f^{n}$ is that $0 \leq k<N_{i}$ or $n-1<k \leq n+N_{i}+1$. Therefore, the number of discontinuity points of $D f^{n}$ which are contained in the orbit of $c_{i}$ is less then $2 N_{i}$.

We conclude that the number of discontinuity points of $D f^{n}$ is bounded by $2\left(N_{1}+\ldots+N_{p}\right)$.

To a piecewise $C^{1}$-homeomorphism $f$ of class $P$ of $S^{1}$ that satisfies property $D$, we associate the real :

$$
\pi(f)=\prod_{i=1}^{p} \prod_{k=0}^{N_{i}-1} \sigma_{f^{N+1}}\left(f^{-k}\left(c_{i}\right)\right)
$$

where $N=\max _{1 \leq i \leq p}\left(N_{i}\right)$.
Remark. If $f$ is a homeomorphism that satisfies the property $D$, then $\pi_{s}(f)=1$ but one can have $\pi(f) \neq 1$ as can be shown by the following example:

If $B$ is a standard Boshernitzan of last break point 0 and which satisfies the property $D$, we have : $\pi_{s}(B)=1$ and $\pi(B)=\sigma_{B^{2}}(0)=\sigma_{B}(0) \times \sigma_{B}(B(0))$.

If $B(0) \neq B^{-1}(0)$, then $\sigma_{B}(B(0))=1$ and $\pi(B)=\sigma_{B}(0) \neq 1$.
If $B(0)=B^{-1}(0)$, then $\pi(B)=\sigma_{B}(0) \sigma_{B}\left(B^{-1}(0)\right)=\sigma_{B}(0) \sigma_{B}(B(0))=1$.

Proposition 2.3. Let $f$ be a piecewise $C^{1}$-homeomorphism of class $P$ of the circle. If $f$ satisfies property $D$ then :
i) if $\pi(f)=1$ then $f$ is conjugate to a $C^{1}$-diffeomorphism of the circle through a PL homeomorphism.
ii) if $\pi(f) \neq 1$ then $f$ is conjugate to a general Boshernitzan $B$ (of last break point $B\left(x_{0}\right)$ such that $\pi_{s}(B)=\sigma_{B}\left(x_{0}\right) \times \sigma_{B}\left[B\left(x_{0}\right)\right]=1$ and
$\pi(B)=\pi(f))$ through a $P L$ homeomorphism.

Proof. Case i) $\pi(f)=1$.
Let $H$ be the $P L$ homeomorphism with the following properties: :
i) $H(0)=0$,
ii) $f^{-k}\left(c_{i}\right), i=1, \ldots, p ; k=0, \ldots, N_{i}-1$ are the break points of $H$,
iii) the jumps of $H$ are given by : $\sigma_{H}\left(f^{-k}\left(c_{i}\right)\right)=\sigma_{f^{N+1}}\left(f^{-k}\left(c_{i}\right)\right)$ where $N=\max _{1 \leq i \leq p} N_{i}$.

Such homeomorphism exist since

$$
\prod_{i=1}^{p} \prod_{k=0}^{N_{i}-1} \sigma_{H}\left(f^{-k}\left(c_{i}\right)\right)=\pi(f)=1
$$

Take $G=H \circ f \circ H^{-1}$. A priori, the break points of $G$ are :

- the break points of $H^{-1}$ :

$$
H\left(f^{-k}\left(c_{i}\right)\right), ; k=0, \ldots, N_{i}-1, i=1, \ldots, p
$$

- the image by $H$ of break points of $f$ :

$$
H\left(f^{-k}\left(c_{i}\right)\right), k=0, \ldots, N_{i}, i=1, \ldots, p
$$

- the image by $H \circ f^{-1}$ of break points of $H$ :

$$
H \circ f^{-1}\left(f^{-k}\left(c_{i}\right)\right)=H\left(f^{-k}\left(c_{i}\right)\right) \text { with } k=1, \ldots, N_{i} .
$$

Therefore the possible break points of $G$ are among :

$$
H\left(f^{-k}\left(c_{i}\right)\right), k=0, \ldots, N_{i}, i=1, \ldots, p
$$

Compute the jumps of $G$ in these points:

$$
\sigma_{G}\left[H\left(f^{-k}\left(c_{i}\right)\right)\right]=\frac{\sigma_{H}\left[f\left(f^{-k}\left(c_{i}\right)\right)\right] \times \sigma_{f}\left(f^{-k}\left(c_{i}\right)\right)}{\sigma_{H}\left(f^{-k}\left(c_{i}\right)\right)}
$$

- If $k=1, \ldots N_{i}-1$, we have by definition :

$$
\sigma_{H}\left(f^{-k}\left(c_{i}\right)\right)=\sigma_{f^{N+1}}\left(f^{-k}\left(c_{i}\right)\right)
$$

and since $N \geq k$ then :
$\sigma_{f^{N+1}}\left(f^{-k}\left(c_{i}\right)\right)=\prod_{s=0}^{N} \sigma_{f}\left(f^{s-k}\left(c_{i}\right)\right)=\prod_{s=-k}^{N-k} \sigma_{f}\left(f^{s}\left(c_{i}\right)\right)=\prod_{s=-k}^{0} \sigma_{f}\left(f^{s}\left(c_{i}\right)\right)$.
Hence :

$$
\sigma_{H}\left[f\left(f^{-k}\left(c_{i}\right)\right)\right]=\sigma_{H}\left[f^{-(k-1)}\left(c_{i}\right)\right]=\prod_{s=-k+1}^{0} \sigma_{f}\left(f^{s}\left(c_{i}\right)\right) .
$$

Then : $\sigma_{G}\left[H\left(f^{-k}\left(c_{i}\right)\right)\right]=1$.

- If $k=0$, we obtain :

$$
\sigma_{G}\left[H\left(f^{-k}\left(c_{i}\right)\right)\right]=\sigma_{G}\left[H\left(c_{i}\right)\right]=\frac{\sigma_{H}\left[f\left(c_{i}\right)\right] \times \sigma_{f}\left(c_{i}\right)}{\sigma_{H}\left(c_{i}\right)}
$$

We have $\sigma_{G}\left[H\left(c_{i}\right)\right]=1$ since $\sigma_{H}\left(c_{i}\right)=\sigma_{f}\left(c_{i}\right)$ and $\sigma_{H}\left[f\left(c_{i}\right)\right]=1$ (since $f\left(c_{i}\right)$ is not a break point of $H$.)

- If $k=N_{i}$, we have :

$$
\sigma_{G}\left[H\left(f^{-k}\left(c_{i}\right)\right)\right]=\sigma_{G}\left[H\left(f^{-N_{i}}\left(c_{i}\right)\right)\right]=\frac{\sigma_{H}\left[f\left(f^{-N_{i}}\left(c_{i}\right)\right)\right] \times \sigma_{f}\left(f^{-N_{i}}\left(c_{i}\right)\right)}{\sigma_{H}\left(f^{-N_{i}}\left(c_{i}\right)\right)}
$$

We have $\sigma_{H}\left(f^{-N_{i}}\left(c_{i}\right)\right)=1$ (since $f^{-N_{i}}\left(c_{i}\right)$ is not a break point of $H$ ).
Also,

$$
\sigma_{H}\left[f\left(f^{-N_{i}}\left(c_{i}\right)\right)\right] \times \sigma_{f}\left(f^{-N_{i}}\left(c_{i}\right)\right)=\prod_{s=-N_{i}+1}^{0} \sigma_{f}\left(f^{s}\left(c_{i}\right)\right) \times \sigma_{f}\left(f^{-N_{i}}\left(c_{i}\right)\right)=\prod_{s=0}^{N_{i}} \sigma_{f}\left(f^{-s}\left(c_{i}\right)\right)=1
$$

since

$$
\sigma_{H}\left[f\left(f^{-N_{i}}\left(c_{i}\right)\right)\right]=\sigma_{H}\left[f^{-\left(N_{i}-1\right)}\left(c_{i}\right)\right]=\prod_{s=-N_{i}+1}^{0} \sigma_{f}\left(f^{s}\left(c_{i}\right)\right)
$$

It follows that : $\sigma_{G}\left[H\left(f^{-N_{i}}\left(c_{i}\right)\right)\right]=1$.
We conclude that $G$ has no break point, $G$ is then a $C^{1}$-diffeomorphism.
Case ii) $\pi(f) \neq 1$.
We choose a point $c$ such that :
$c \neq f^{-k}\left(c_{i}\right), c \neq f(c), c \neq f^{N+1}\left(f^{-k}\left(c_{i}\right)\right), i=1, \ldots, p, k=0, \ldots, N_{i}$.
To obtain the $P L$ homeomorphism $H$ that satisfies properties i), ii), and iii), we need to add a break point $c$ to $H$ such that: $\sigma_{H}(c)=\frac{1}{\pi(f)}$.

The break points of $H$ are :

$$
f^{-k}\left(c_{i}\right),\left(i=1, \ldots, p, k=0, \ldots, N_{i}-1\right), \text { and } c
$$

and the jumps in these points are :

$$
\sigma_{H}\left(f^{-k}\left(c_{i}\right)\right)=\sigma_{f^{N+1}}\left(f^{-k}\left(c_{i}\right)\right), \sigma_{H}(c)=\frac{1}{\pi(f)}
$$

We let $G=H \circ f \circ H^{-1}$. The possible break points of $G$ are among:
$H(c), H \circ f^{-1}(c), H\left(f^{-k}\left(c_{i}\right)\right), k=0, \ldots, N_{i}, i=1, \ldots, p$.

- the jump of $G$ in $H(c)$ :

$$
\sigma_{G}[H(c)]=\frac{\sigma_{H}[f(c)] \times \sigma_{f}(c)}{\sigma_{H}(c)} .
$$

We have : $\sigma_{f}(c)=1$ since $c \neq f^{-k}\left(c_{i}\right), i=1, \ldots, p, k=0, \ldots, N_{i}$.
We have also $\sigma_{H}[f(c)]=1$ since $f(c)$ is not a break point of $H$; indeed :

- $f(c) \neq c$
- $\left.f(c) \neq f^{-k}\left(c_{i}\right)\right), k=0, \ldots, N_{i}-1$ (otherwise, $c=f^{-s}\left(c_{i}\right), s=1, \ldots, N_{i}$, which is impossible by hypothesis.).

It follows that: $\sigma_{G}[H(c)]=\frac{1}{\sigma_{H}(c)} \neq 1 . H(c)$ is then a break point of $G$.

- The jump of $G$ in $H \circ f^{-1}(c)$ :

$$
\sigma_{G}\left[H \circ f^{-1}(c)\right]=\frac{\sigma_{H}(c) \times \sigma_{f}\left[f^{-1}(c)\right]}{\sigma_{H}\left[f^{-1}(c)\right]}
$$

We have : $\sigma_{H}\left[f^{-1}(c)\right]=1$ since :

- $f^{-1}(c) \neq c$
- $\left.f^{-1}(c) \neq f^{-k}\left(c_{i}\right)\right)$ since :

Otherwise, $c=f^{1-k}\left(c_{i}\right), k=0, \ldots, N_{i}-1$. For $k=1, \ldots, N_{i}-1$, this is impossible by hypothesis. For $k=0, c=f\left(c_{i}\right)$ is also impossible since by hypothesis, $c \neq f^{N+1}\left(f^{-k}\left(c_{i}\right)\right), i=1, \ldots, p, k=0, \ldots, N_{i}$, in particular for $k=N_{i}, c \neq f\left(c_{i}\right)$. It follows that $\sigma_{G}\left[H \circ f^{-1}(c)\right]=\sigma_{H}(c) \neq 1$. So, $H \circ f^{-1}(c)$ is a break point of $G$.

- the jump of $G$ in $H \circ f^{-k}\left(c_{i}\right)$ : by the compute above, we have $\sigma_{G}[H \circ$ $\left.f^{-k}\left(c_{i}\right)\right]=1, i=1, \ldots, p$.

Therefore, $G$ has exactly two break points :
$x_{0}:=H \circ f^{-1}(c)$ and $G\left(x_{0}\right)=H(c)$ with $\sigma_{G}\left(x_{0}\right) \times \sigma_{G}\left[G\left(x_{0}\right)\right]=1$. The homeomorphism $G$ is then a Boshernitzan of $S^{1}$ of last break point $H(c)$. Let's show that $\pi(B)=\pi(f)$ :

We have

$$
\pi(B)=\sigma_{B}(H(c))=\sigma_{H \circ f \circ H^{-1}}(H(c))=\frac{\sigma_{H}(f(c)) \times \sigma_{f}(c)}{\sigma_{H}(c)}=\frac{1}{\frac{1}{\pi(f)}}=\pi(f) .
$$

Corollary 2.4. Let $f$ be a piecewise $C^{1}$-homeomorphism of class $P$ of the circle. If the break points of $f$ are on the same orbit with
$\pi_{s}(f)=\pi(f)=1$ then $f$ is conjugate to a $C^{1}$-diffeomorphism of the circle through a PL homeomorphism.

Proof. This follows from the fact that if all the break points of $f$ are on the same orbit and $\pi_{s}(f)=1$ then $f$ has the property $D$ and so, we conclude by proposition $2.3, \mathrm{i}$ ).

## 3. The conjugacy Lemmas

Lemma 3.1. For every $b \in S^{1}$, for every $\left.\delta \in\right] 0,1[$, there exist a piecewise quadratic orientation preserving homeomorphism $H_{\delta, b}$ of $S^{1}$ with only one break point b such that: $\sigma_{H_{\delta, b}}(b)=\delta$.

Proof. If $\delta \in] 0,1[$ we put

$$
\tilde{H}_{\delta}(x)=\left(\frac{1-\delta}{1+\delta}\right) x\left(x+\frac{2 \delta}{1-\delta}\right), x \in[0,1[
$$

One can check that $\tilde{H}_{\delta}(0)=0, \tilde{H}_{\delta}(1)=1$ and that $\tilde{H}_{\delta}$ is an increasing homeomorphism of $\left[0,1\left[\right.\right.$ with $\left(D \tilde{H}_{\delta}\right)_{+}(0)=\frac{2 \delta}{1+\delta}$ and $\left(D \tilde{H}_{\delta}\right)_{-}(1)=\frac{2}{1+\delta}$.

Let $t \in[0,1[$ such that $p(t)=b$ and consider the map :

$$
\tilde{H}_{\delta, t}(x)=\tilde{H}_{\delta}(x-t)+t, \text { if } x \in[t, t+1[.
$$

$\tilde{H}_{\delta, t}$ is extended to an increasing homeomorphism, denoted also by $\tilde{H}_{\delta, t}$ on $\mathbb{R}$ and defined by :

$$
\tilde{H}_{\delta, t}(x)=\tilde{H}_{\delta, t}(x-k), \text { if } x \in[t+k, t+k+1[, k \in \mathbb{Z}
$$

Then $\tilde{H}_{\delta, t}$ is an increasing homeomorphism of $\mathbb{R}$ which satisfies :

- $\tilde{H}_{\delta, t}(x+1)=\tilde{H}_{\delta, t}(x)+1$,
- $t+k, k \in \mathbb{Z}$ are the break points of $\tilde{H}_{\delta, t}$,
- $\sigma_{\tilde{H}_{\delta, t}}(t+k)=\delta$.

As a consequence, $\tilde{H}_{\delta, t}$ induces by projection the piecewise quadratic homeomorphism $H_{\delta, t}$ of $S^{1}$ with only one break point $b$ such that

$$
\sigma_{H}(b)=\delta
$$

Lemma 3.2. Let $f$ be a piecewise $C^{1}$-homeomorphism of class $P$ of $S^{1}$ with irrational rotation number and having $p+1$ break points $x_{0}, x_{1}, \ldots, x_{p}$ ( $p \geq 1$ ) contained in a same orbit. Then there exists a piecewise quadratic homeomorphism $H$ with one break point $x_{1}$ such that for $F=H \circ f \circ H^{-1}$ we have :
a) if there exist $i_{0} \in\{0,1, \ldots, p\}$ such that $f\left(x_{i_{0}}\right)=x_{1}$ then:
a-1) $C(F)=\left\{y_{i}=H\left(x_{i}\right), i=0,2, \ldots, p\right\}$ if $\sigma_{f}\left(x_{1}\right) \times \sigma_{f}\left(x_{i_{0}}\right) \neq 1$.
a-2) $C(F)=\left\{y_{i}=H\left(x_{i}\right), i=0,2, \ldots, p, i \neq i_{0}\right\}$ if $\sigma_{f}\left(x_{1}\right) \times \sigma_{f}\left(x_{i_{0}}\right)=1$.
b) if for every $i=0,1, \ldots, p, f\left(x_{i}\right) \neq x_{1}$ then
$C(F)=\left\{y_{i}=H\left(x_{i}\right), i=0,2, \ldots, p\right\} \cup\left\{\operatorname{Hof}^{-1}\left(x_{1}\right)\right\}$. Moreover, if $x_{1}=f^{k}\left(x_{0}\right), k \geq 2$ then $y_{1}=F^{k-1}\left(y_{0}\right)$.

Proof. By Lemma 3.1, let $H$ be the piecewise quadratic homeomorphism with one break point $x_{1}$ such that $\sigma_{H}\left(x_{1}\right)=\sigma_{f}\left(x_{1}\right)$. Take $F=H \circ f \circ H^{-1}$. The eventually break points of $F$ are:

$$
H\left(x_{i}\right), i=0,1, \ldots, p, H \circ f^{-1}\left(x_{1}\right) .
$$

- The jumps of $F$ in these points are:

$$
\sigma_{F}\left[H\left(x_{i}\right)\right]=\frac{\sigma_{H}\left[f\left(x_{i}\right)\right] \times \sigma_{f}\left(x_{i}\right)}{\sigma_{H}\left(x_{i}\right)}
$$

Case a-1): there exist $i_{0} \in\{0,1, \ldots, p\}$ such that $f\left(x_{i_{0}}\right)=x_{1}$ with $\sigma_{f}\left(x_{1}\right) \times \sigma_{f}\left(x_{i_{0}}\right) \neq 1$.

In this case, $f\left(x_{i}\right) \neq x_{1}$ for $i \neq i_{0}$ and $H \circ f^{-1}\left(x_{1}\right)=H\left(x_{i_{0}}\right)$. Hence

- $\sigma_{F}\left[H\left(x_{i}\right)\right]=\sigma_{f}\left(x_{i}\right) \neq 1$, for $i \notin\left\{1, i_{0}\right\}$ :
indeed, $\sigma_{H}\left(x_{i}\right)=1$ since $x_{i}$ is not a break point of $H$, and $\sigma_{H}\left[f\left(x_{i}\right)\right]=1$ since $f\left(x_{i}\right) \neq x_{1}$.
- $\sigma_{F}\left[H\left(x_{1}\right)\right]=1$ :
indeed, $\sigma_{F}\left[H\left(x_{1}\right)\right]=\frac{\sigma_{H}\left[f\left(x_{1}\right)\right] \times \sigma_{f}\left(x_{1}\right)}{\sigma_{H}\left(x_{1}\right)}, \sigma_{H}\left[f\left(x_{1}\right)\right]=1$ since $f\left(x_{1}\right) \neq x_{1}\left(x_{1}\right.$ is not a periodic point) and $\frac{\sigma_{f}\left(x_{1}\right)}{\sigma_{H}\left(x_{1}\right)}=1$.
- $\sigma_{F}\left[H\left(x_{i_{0}}\right)\right]=\sigma_{f}\left(x_{1}\right) \times \sigma_{f}\left(x_{i_{0}}\right) \neq 1$ :
indeed, $\sigma_{F}\left[H\left(x_{i_{0}}\right)\right]=\frac{\sigma_{H}\left(x_{1}\right) \times \sigma_{f}\left(x_{i_{0}}\right)}{\sigma_{H}\left(x_{i_{0}}\right)}, \sigma_{H}\left(x_{i_{0}}\right)=1$ since $x_{i_{0}} \neq x_{1}$ and $\sigma_{H}\left(x_{1}\right)=\sigma_{f}\left(x_{1}\right)$.

One conclude that $F$ has $p$ break points:

$$
y_{i}=H\left(x_{i}\right), i=0,2, \ldots, p .
$$

contained in the orbit of $y_{0}$.
Case a-2): there exist $i_{0} \in\{0,1, \ldots, p\}$ such that $f\left(x_{i_{0}}\right)=x_{1}$ with $\sigma_{f}\left(x_{1}\right) \times \sigma_{f}\left(x_{i_{0}}\right)=1$.

In this case, we have as in the case a-1), $\sigma_{F}\left[H\left(x_{i}\right)\right]=\sigma_{f}\left(x_{i}\right) \neq 1$, for $i \neq 1, i_{0}, \sigma_{F}\left[H\left(x_{1}\right)\right]=1$ and $\sigma_{F}\left[H\left(x_{i_{0}}\right)\right]=\sigma_{f}\left(x_{1}\right) \times \sigma_{f}\left(x_{i_{0}}\right)=1$.

One conclude that $F$ has $p-1$ break points:

$$
y_{i}=H\left(x_{i}\right), 0 \leq i \leq p, i \neq 1, i_{0}
$$

contained in the orbit of $y_{0}$.
Case b): for every $i=0,1, \ldots, p, f\left(x_{i}\right) \neq x_{1}$.

- we have $\sigma_{F}\left[H\left(x_{i}\right)\right]=\sigma_{f}\left(x_{i}\right) \neq 1$ :
indeed, $\sigma_{H}\left(x_{i}\right)=1$ since $x_{i}$ is not a break point of $H$, and $\sigma_{H}\left[f\left(x_{i}\right)\right]=1$ since $f\left(x_{i}\right) \neq x_{1}$.
- $\sigma_{F}\left[H\left(x_{1}\right)\right]=1$ :
indeed, $\sigma_{F}\left[H\left(x_{1}\right)\right]=\frac{\sigma_{H}\left[f\left(x_{1}\right)\right] \times \sigma_{f}\left(x_{1}\right)}{\sigma_{H}\left(x_{1}\right)}, \sigma_{H}\left[f\left(x_{1}\right)\right]=1$ since $f\left(x_{1}\right) \neq x_{1}$ and $\frac{\sigma_{f}\left(x_{1}\right)}{\sigma_{H}\left(x_{1}\right)}=1$.
- $\sigma_{F}\left[H \circ f^{-1}\left(x_{1}\right)\right]=\sigma_{H}\left(x_{1}\right) \neq 1$ :
indeed, $\sigma_{F}\left[H \circ f^{-1}\left(x_{1}\right)\right]=\frac{\sigma_{H}\left(x_{1}\right) \times \sigma_{f}\left(f^{-1}\left(x_{1}\right)\right)}{\sigma_{H}\left(f^{-1}\left(x_{1}\right)\right)}, \sigma_{H}\left(f^{-1}\left(x_{1}\right)\right)=1$ since $f\left(x_{1}\right) \neq x_{1}$ and $\sigma_{f}\left(f^{-1}\left(x_{1}\right)\right)=1$ since $f^{-1}\left(x_{1}\right) \neq x_{i}, i=0,1, \ldots, p$.

Therefore $F$ has $p+1$ break points:

$$
y_{1}=H \circ f^{-1}\left(x_{1}\right), y_{i}=H\left(x_{i}\right), i=0,2, \ldots, p,
$$

Moreover, if $x_{1}=f^{k}\left(x_{0}\right)(k \geq 2)$ then $y_{1}=F^{k-1}\left(y_{0}\right)$ since

$$
y_{1}=H \circ f^{-1}\left(x_{1}\right)=H \circ f^{k-1}\left(x_{0}\right)=F^{k-1}\left(H\left(x_{0}\right)\right)=F^{k-1}\left(y_{0}\right) .
$$

Corollary 3.3. Let $B$ be a general Boshernitzan of last break point $x_{1}=B\left(x_{0}\right)$ and with irrational rotation number. Then:
i) if $\sigma_{B}\left(x_{0}\right) \times \sigma_{B}\left(x_{1}\right)=1$ then $B$ is conjugate to a $C^{1}$-diffeomorphism through a piecewise quadratic homeomorphism with one break point $x_{1}$.
ii) if $\sigma_{B}\left(x_{0}\right) \times \sigma_{B}\left(x_{1}\right) \neq 1$ then $B$ is conjugate to a homeomorphism of class $P$ with a unique break point through a piecewise quadratic homeomorphism with one break point $x_{1}$.

Proof. This follows from Lemma 3.2, case a) for $p=1$.

## 4. Proof of Theorem 1.6 and Corollary 1.8

Proof of Theorem 1.6.
$i) \Longrightarrow i i)$. If $H$ is the piecewise $C^{1}$-homeomorphism which conjugate $f$ to a diffeomorphism $F: f=H^{-1} \circ F \circ H$ then $f^{n}=H^{-1} \circ F^{n} \circ H$. As $H$ and $H^{-1}$ have the same number $l$ of break points then $f^{n}$ has at most $2 l$ break points for every $n \in \mathbb{Z}$.
$i i) \Longrightarrow i i i)$ is the proposition 2.2.
$i i i) \Longrightarrow i v$ ) is the proposition 2.3.
$i v) \Longrightarrow v$ ) follows from proposition 2.3 and corollary 3.3 , i).
$v) \Longrightarrow i$ ) is obvious.
Proof of Corollary 1.8. The implications $i) \Rightarrow i i)$ and $i i) \Rightarrow$ iii) are consequence of Theorem 1.6. The implication $i v) \Rightarrow i$ ) is clear. The implication $i i i) \Rightarrow i v)$ follows from the fact that if $B$ is the affine Boshernitzan of last break point 0 with slopes $\left(\lambda, \lambda^{\prime}\right)$ then the piecewise analytic homeomorphism $h$ with one break point defined by its restriction to $[0,1[$ of its lift
(denoted also by $h$ ) $h(x):=\frac{\left(\frac{\lambda}{\lambda^{\prime}}\right)^{x}-1}{\frac{\lambda}{\lambda^{\prime}}-1}$ conjugate $B$ to the rotation $R_{\alpha}$ where $\alpha=\frac{\log \lambda}{\log \lambda-\log \lambda^{\prime}}$.
