# Enumerative invariants of stongly semipositive real symplectic manifolds

#### Abstract

: Following the approach of Gromov and Witten [3, 20], we define invariants under deformation of stongly semipositive real symplectic manifolds provided essentially that their real locus is $P i n^{ \pm}$. These invariants provide lower bounds in real enumerative geometry, namely for the number of real rational $J$-holomorphic curves which realize a given homology class and pass through a given real configuration of points. In a first part of this paper, we obtain the correponding results for real projective convex manifolds using algebraic techniques.


## Introduction

A smooth compact symplectic manifold $(X, \omega)$ of dimension $2 n$ is said to be semipositive as soon as for every spherical class $d \in H_{2}(X ; \mathbb{Z})$ such that $[\omega] d>0$, the implication $c_{1}(X) d \geq$ $3-n \Longrightarrow c_{1}(X) d \geq 0$ holds. These manifolds provide a favourable framework to define genus zero Gromov-Witten invariants (see [13]) and in particular these invariants are enumerative. We will assume throughout the paper that the manifold $(X, \omega)$ is strongly semipositive, by which we mean that for every spherical class $d \in H_{2}(X ; \mathbb{Z})$ such that $[\omega] d>0$, the implication $c_{1}(X) d \geq 2-n \Longrightarrow c_{1}(X) d \geq 1$ holds (see Remark 6.4). An important source of examples are smooth projective Fano manifolds. The manifold is said to be real when it is equipped with an antisymplectic involution, that is an involution $c_{X}$ such that $c_{X}^{*} \omega=-\omega$. We denote by $\mathbb{R} X$ the fixed locus of this involution and by $\mathbb{R} \mathcal{J}_{\omega}$ the set of almost complex structures of $X$ of finite regularity $C^{l}, l \gg 1$, which are tamed by $\omega$ and for which $c_{X}$ is $J$-antiholomorphic. In this context, one can count the number of real rational $J$-holomorphic curves which realize a given homology class $d \in H_{2}(X ; \mathbb{Z})$ and pass through some given real configuration of points, under the assumptions that $J$ is generic and this number finite. However, this number does depend in general on the choice of the almost complex structure $J$ or the configuration of points, basically because the field of real numbers is not algebraically closed. In [17], [18], a way of counting these real rational $J$-holomorphic curves with respect to some sign $\pm 1$ has been introduced in order to define an integer which neither depends on the choice of $J \in \mathbb{R} \mathcal{J}_{\omega}$ nor on the choice of the points. This integer is invariant under deformation of the real symplectic manifold, but has been defined only in dimension four. The integer $\pm 1$ depended on the parity of the number of real isolated double points of the real rational $J$ holomorphic curves which were counted. These curves are indeed singular in general in this

[^0]dimension. The question appeared then whether it was possible to obtain similar results in higher dimensional real symplectic manifolds. A partial answer to this question was obtained in [19] where a way to count such real rational curves in real algebraic convex 3-manifolds has been introduced. The sign $\pm 1$ depended then on some spinor state of the real rational curve which was first defined and which required the choice of a $P i n_{3}^{-}$structure on the real locus $\mathbb{R} X$. The integers thus defined were invariants under isomorphism of real algebraic convex 3 -manifolds. However, as was pointed out in [19], very few such convex 3 -manifolds indeed have non trivial genus zero Gromov-Witten invariants, namely $\mathbb{C} P^{3}, \mathbb{C} P^{2} \times \mathbb{C} P^{1},\left(\mathbb{C} P^{1}\right)^{3}$, $F l\left(\mathbb{C}^{3}\right)$ and the quadric in $\mathbb{C} P^{4}$ for the ones I am aware of. The aim of this work is to build such integer valued invariants for strongly semipositive real symplectic manifolds of any dimension, see Theorem 6.1. These integers are obtained by counting the number of real rational $J$-holomorphic curves which realize a given homology class and pass through a given real configuration of points with respect to some spinor state in $\{ \pm 1\}$ that we first define, see $\S \S 1.2 .2$ and 5.2 . They are invariant under strongly semipositive deformation of the real symplectic manifold. This means that if $\omega_{t}$ is a continuous family of strongly semipositive symplectic forms on $X$ for which $c_{X}^{*} \omega_{t}=-\omega_{t}$, then these invariants are the same for all triples $\left(X, \omega_{t}, c_{X}\right)$. Moreover, they provide lower bounds in real enumerative geometry, namely for the number of real rational $J$-holomorphic curves which realize a given homology class and pass through a given real configuration of points, see Corollary 6.3. In order to define the spinor states of such real rational $J$-holomorphic curves and hence build these invariants, it is necessary here to make some topological assumption on the real locus of the manifolds, basically that its second Stiefel-Whitney class either vanishes or equals the square of the first Stiefel-Whitney class, see $\delta 1.2 .1$ for the exact hypothesis and Remark 6.4 for a comment on these hypothesis. In a first part of this paper, we build the invariants for real algebraic convex manifolds of any dimension, using algebraic techniques. They are a particular example of strongly semipositive real symplectic manifolds once equipped with an invariant kähler form. These results are then extended in the second part of the paper to any strongly semipositive real symplectic manifolds, using the techniques of pseudo-holomorphic curves in symplectic geometry initiated by Gromov (3].

## Part I

## Enumerative invariants of real algebraic convex manifolds

## 1 Preliminaries

### 1.1 Moduli space of genus zero stable maps

Let ( $X, c_{X}$ ) be a smooth real algebraic convex manifold of complex dimension $n \geq 3$, that is a smooth real projective manifold such that for every morphism $u: \mathbb{C} P^{1} \rightarrow X$, the vanishing $H^{1}\left(\mathbb{C} P^{1} ; u^{*} T X\right)=0$ occurs. Denote by $\mathbb{R} X=\operatorname{fix}\left(c_{X}\right)$ its real locus, which we assume to be nonempty. Let $d \in H_{2}(X ; \mathbb{Z})$ be such that $\left(c_{X}\right)_{*} d=-d$ and $(n-1) /\left(c_{1}(X) d-2\right)$. We set $k_{d}=\frac{1}{n-1}\left(c_{1}(X) d-2\right)+1$. Note that $k_{d} \in \mathbb{N}^{*}$ as soon as $d$ is realized by some rational curve, see Lemma 11 of [2]. Denote by $\overline{\mathcal{M}}_{k_{d}}^{d}(X)$ the space of genus zero stable maps of $X$ which realize $d$ and have $k_{d}$ marked points. Let $e v^{d}: \overline{\mathcal{M}}_{k_{d}}^{d}(X) \rightarrow X^{k_{d}}$ be the evaluation map. Note that $\operatorname{dim}_{\mathbb{C}} \overline{\mathcal{M}}_{k_{d}}^{d}(X)=c_{1}(X) d+n-3+k_{d}=n k_{d}$ so that $e v^{d}$ is a morphism between projective manifolds of the same dimension. Let $\tau \in \sigma_{k_{d}}$ be such that $\tau^{2}=i d$. Following $\S 1.1$ of [19], we denote by $c_{\tau}:\left(x_{1}, \ldots, x_{k_{d}}\right) \in X^{k_{d}} \mapsto\left(c_{X}\left(x_{\tau(1)}\right), \ldots, c_{X}\left(x_{\tau\left(k_{d}\right)}\right)\right)$ the associated real structure on $X^{k_{d}}$. In the same way, denote by $c_{\overline{\mathcal{M}}, \tau}$ the real structure of $\overline{\mathcal{M}}_{k_{d}}^{d}(X)$ induced by $c_{\mathcal{M}, \tau}:\left(u, z_{1}, \ldots, z_{k_{d}}\right) \in \operatorname{Mor}_{d}(X) \times\left(\mathbb{C} P^{1}\right)^{k_{d}} \mapsto\left(c_{X} \circ u \circ \operatorname{conj}, \operatorname{conj}\left(z_{\tau(1)}\right), \ldots, \operatorname{conj}\left(z_{\tau\left(k_{d}\right)}\right)\right) \in$ $\mathcal{M o r}_{d}(X) \times\left(\mathbb{C} P^{1}\right)^{k_{d}}$, where conj is the standard complex conjugation of $\mathbb{C} P^{1}$ and $\mathcal{M o r}_{d}(X)=$ $\left\{u: \mathbb{C} P^{1} \rightarrow X \mid u_{*}\left[\mathbb{C} P^{1}\right]=d\right\}$ (see Theorem 1.1 of [19]). Denote by $\mathbb{R}_{\tau} X^{k_{d}}=\operatorname{fix}\left(c_{\tau}\right)$ and
$\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X)=\operatorname{fix}\left(c_{\overline{\mathcal{M}}, \tau}\right)$ the real loci of these spaces. The evaluation morphism restricts to $\mathbb{R}_{\tau} e v^{d}: \mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X) \rightarrow \mathbb{R}_{\tau} X^{k_{d}}$. Finally, denote by $\overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*}\left(\right.$ resp. $\left.\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*}\right)$ the subspace of simple stable maps of $\overline{\mathcal{M}}_{k_{d}}^{d}(X)$ (resp. $\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X)$ ), it is contained in the smooth locus of $\overline{\mathcal{M}}_{k_{d}}^{d}(X)$, see [2]. Note that the singular locus of $\overline{\mathcal{M}}_{k_{d}}^{d}(X)$ is of codimension greater that one and will play no rôle in this paper.

Theorem 1.1 Let $\left(X, c_{X}\right)$ be a smooth real algebraic convex manifold of complex dimension $n \geq 3$.

1) The divisor Red $=\overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*} \backslash \mathcal{M}_{k_{d}}^{d}(X)^{*}$ has normal crossings.
2) Let $(u, C, \underline{z}) \in \mathcal{M}_{k_{d}}^{d}(X)^{*}$ and $\mathcal{N}_{u}$ be its normal sheaf. Then the isomorphisms $\left.\operatorname{ker} d\right|_{(u, C, \underline{z})} e v^{d} \cong$ $H^{0}\left(C ; \mathcal{N}_{u} \otimes \mathcal{O}_{C}(-\underline{z})\right)=H^{0}\left(C ; N_{u} \otimes \mathcal{O}_{C}(-\underline{z})\right) \oplus H^{0}\left(C ; \mathcal{N}_{u}^{\text {sing }} \otimes \mathcal{O}_{C}(-\underline{z})\right)$ and coker $\left.d\right|_{(u, C, \underline{z})} e v^{d} \cong$ $H^{1}\left(C ; \mathcal{N}_{u} \otimes \mathcal{O}_{C}(-\underline{z})\right)$ hold.
3) As soon as $\left(n, c_{1}(X) d\right) \neq(3,4)$, the locus of stable maps $(u, C, \underline{z}) \in \mathcal{M}_{k_{d}}^{d}(X)^{*}$ for which $u$ is not an immersion is mapped onto some submanifold of $X^{k_{d}}$ having codimension greater than one.

Remark 1.2 In the third part of this theorem, the condition $n \geq 3$ is crucial. For a discussion on the condition $\left(n, c_{1}(X) d\right) \neq(3,4)$, see Remark 3.2 of [19].

## Proof:

The first part is Theorem 3 of [2]. The proof of the second part goes exactly along the same lines as the one of Lemma 1.3 of [19], it is not reproduced here. Now the locus of stable maps $(u, C, \underline{z}) \in \mathcal{M}_{k_{d}}^{d}(X)^{*}$ for which $u$ is not an immersion and for which $u^{*} T X \otimes \mathcal{O}_{C}(-1)$ is generated by its global sections is of codimension $n-1$ in $\mathcal{M}_{k_{d}}^{d}(X)^{*}$. This follows from the fact that the tautological section $\sigma:\left.(u, C, z) \in \mathcal{M}_{1}^{d}(X)^{*} \mapsto d\right|_{z} u \in \operatorname{Hom}_{\mathbb{C}}\left(T_{z} C, T_{u(z)} X\right)$ vanishes transversely at those points, which can be proved as Proposition 3.1 of [19]. From the second part of Theorem 1.1, the locus of stable maps $(u, C, \underline{z}) \in \mathcal{M}_{k_{d}}^{d}(X)^{*}$ for which $\operatorname{dim} H^{1}\left(C ; \mathcal{N}_{u} \otimes\right.$ $\left.\mathcal{O}_{C}(-\underline{z})\right)>1$ is mapped onto some submanifold of $X^{k_{d}}$ having codimension greater than one. Let then $(u, C, \underline{z}) \in \mathcal{M}_{k_{d}}^{d}(X)^{*}$ be such that $\operatorname{dim} H^{1}\left(C ; \mathcal{N}_{u} \otimes \mathcal{O}_{C}(-\underline{z})\right) \leq 1$. From a theorem of Grothendieck ([4]), the normal bundle $N_{u}$ of $u$ is isomorphic to $\mathcal{O}_{C}\left(a_{1}\right) \oplus \cdots \oplus \mathcal{O}_{C}\left(a_{n-1}\right)$, where $a_{i} \geq k_{d}-1$ for $1 \leq i \leq n-2$ and $a_{n-1} \geq k_{d}-2$. If $u$ is not an immersion, then $\operatorname{deg}\left(N_{u}\right) \leq$ $c_{1}(X) d-3=(n-1)\left(k_{d}-1\right)-1$, so that $N_{u}$ has to be isomorphic to $\mathcal{O}_{C}\left(k_{d}-1\right)^{n-2} \oplus \mathcal{O}_{C}\left(k_{d}-2\right)$. Remember that the convexity of $X$ forces $u^{*} T X$ to be a direct sum of line bundles of nonnegative degrees, see Lemma 10 of [2]. Assume that $u^{*} T X \otimes \mathcal{O}_{C}(-1)$ is not generated by its global sections, then $u^{*} T X \cong F \oplus \mathcal{O}_{C}^{k}$, where $F$ is a direct sum of line bundles of positive degrees and $k \geq 1$. Let $z_{C} \in C$ be the point where $d u$ vanishes. The latter maps $T C \otimes \mathcal{O}_{C}\left(z_{C}\right)$ to $F$ so that $N_{u}$ is isomorphic to $\mathcal{O}_{C}^{k} \oplus\left(F / d u\left(T C \otimes \mathcal{O}_{C}\left(z_{C}\right)\right)\right)$. From what precedes, this forces $k_{d} \leq 2$ and the inequality $\operatorname{deg}\left(u^{*} T X\right) \geq 3$ forces $k_{d} \geq 2$. Hence, $k_{d}=2$ and $k=1$. Now the composition of the tautological section $\sigma:\left.(u, C, z) \in \mathcal{M}_{1}^{d}(X)^{*} \mapsto d\right|_{z} u \in \operatorname{Hom}_{\mathbb{C}}\left(T_{z} C, T_{u(z)} X\right)$ with the projection $\operatorname{Hom}_{\mathbb{C}}\left(T_{z} C, T_{u(z)} X\right) \rightarrow \operatorname{Hom}_{\mathbb{C}}\left(T_{z} C, F\right)$ vanishes transversely since $F \otimes$ $\mathcal{O}_{C}(-1)$ is generated by its global sections. Since $\operatorname{dim} F=n-2$, the result follows in all the cases but $n=3, k_{d}=2$.

Lemma 1.3 Assume that either $n$ is even, or $\tau$ has a fixed point in $\left\{1, \ldots, k_{d}\right\}$. Then, as soon as $\underline{x} \in \mathbb{R}_{\tau} X^{k_{d}}$ is generic enough, the fibre $\left(\mathbb{R}_{\tau} e v^{d}\right)^{-1}(\underline{x})$ uniquely consists of irreducible real rational curves having non-empty real parts.

Note that when $k_{d}$ is odd, $\tau$ has a fixed point so that the hypothesis of Lemma 1.3 is satisfied. We will assume throughout the paper that this hypothesis holds.

## Proof:

To begin with, assume that $\tau$ has a fixed point, say $1 \in\left\{1, \ldots, k_{d}\right\}$ and denote $\underline{x}$ by $\left(x_{1}, \ldots, x_{k_{d}}\right)$. Let $(u, C, \underline{z}) \in\left(\mathbb{R}_{\tau} e v^{d}\right)^{-1}(\underline{x})$. From Theorem 1.1, as soon as $\underline{x}$ is generic enough, $C$ is irreducible. From the definition of $c_{\mathcal{M}, \tau}$, there exists $\phi \in \operatorname{Aut}(C)$ such that $c_{X} \circ u \circ \operatorname{conj}=u \circ \phi^{-1}$ and $\operatorname{conj}\left(z_{\tau(i)}\right)=\phi\left(z_{i}\right), i \in\left\{1, \ldots, k_{d}\right\}$. Let $c_{C}=\phi^{-1} \circ$ conj, then $c_{X} \circ u=u \circ c_{C}$ and $c_{C}\left(z_{\tau(i)}\right)=z_{i}, i \in\left\{1, \ldots, k_{d}\right\}$. In particular, $c_{C}$ is a real structure on $C$ which has one fixed point at least, namely $x_{1}$. Assume now that $n$ is even. From what has been done, we can also assume that $k_{d}$ is even. From the definition of $k_{d}$, it implies that $c_{1}(X) d$ is odd. Now if $C$ has an empty real part, then $c_{1}(X) d=w_{2}\left(u^{*} T X\right)[C]$ $\bmod (2)=2 w_{2}\left(u^{*} T X / c_{X}\right)\left[C / c_{C}\right]=0 \bmod (2)$, hence the contradiction.

Lemma 1.4 Let $\mathbb{R} \mathcal{M}^{*}$ be a connected component of $\mathbb{R}_{\tau} \mathcal{M}_{k_{d}}^{d}(X)^{*}$. Then, the homology class $u_{*}[\mathbb{R} C] \in H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$ does not depend on the choice of $(u, C, \underline{z}) \in \mathbb{R} \mathcal{M}^{*}$.

The homology class given by Lemma 1.4 will be denoted by $d_{\mathbb{R} \mathcal{M}^{*}} \in H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$.
Proof:
Let $\mathbb{R}_{\tau} U^{d} \rightarrow \mathbb{R}_{\tau} \mathcal{M}^{*}$ be the universal curve. Then, all the fibres of $\mathbb{R}_{\tau} U^{d}$ have same homology class in $H_{1}\left(\mathbb{R}_{\tau} U^{d} ; \mathbb{Z} / 2 \mathbb{Z}\right)$. The result is thus obtained after composition with the morphism $H_{1}\left(\mathbb{R}_{\tau} U^{d} ; \mathbb{Z} / 2 \mathbb{Z}\right) \rightarrow H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$ induced by the evaluation map $\mathbb{R}_{\tau} U^{d} \rightarrow \mathbb{R} X$.

### 1.2 Spinor states

### 1.2.1 $\quad \widetilde{G L}_{m}^{ \pm}(\mathbb{R})$-structures

Denote by $\widetilde{G L}_{m}(\mathbb{R})$ the universal covering of $G L_{m}(\mathbb{R})$. It can be equipped with two different group structures which turn the covering map into a morphism. Denote by $\widetilde{G L}_{m}^{+}(\mathbb{R})$ (resp. $\widetilde{G L}_{m}^{-}(\mathbb{R})$ ) the group structure for which the lift of a reflexion is of order two (resp. of order four). Let $M \rightarrow \mathbb{R} X$ be a vector bundle of rank $m$ and $R_{M}$ be the associated $G L_{m}(\mathbb{R})$ principal bundle of frames. The obstruction to the existence of a $\widetilde{G L}_{m}^{+}(\mathbb{R})$-principal bundle (resp. $\widetilde{G L}_{m}^{-}(\mathbb{R})$-principal bundle) $P_{M}$ over $R_{M}$ is carried by the characteristic class $w_{2}(M) \in$ $H^{2}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$. (resp. $\left.w_{2}(M)+w_{1}^{2}(M) \in H^{2}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})\right)$, see 10 for example. From now on, we will assume that one of the following holds and will denote by HYP these hyposthesis.

1) If either $k_{d}$ is odd or $n=3 \bmod (4)$, we assume that $0 \in\left\{w_{2}(\mathbb{R} X), w_{2}(\mathbb{R} X)+w_{1}^{2}(\mathbb{R} X)\right\}$. We then set $M=T \mathbb{R} X$ and equip this bundle with a $\widetilde{G L}_{m}^{+}(\mathbb{R})$ or $\widetilde{G L}_{m}^{-}(\mathbb{R})$-structure depending on whether $w_{2}(\mathbb{R} X)$ or $w_{2}(\mathbb{R} X)+w_{1}^{2}(\mathbb{R} X)$ vanishes.
2) If $k_{d}$ is even and $n=0 \bmod (4)$, we assume that $w_{2}(\mathbb{R} X)=0$. We then set $M=$ $T \mathbb{R} X \oplus \operatorname{Det}(\mathbb{R} X)^{3}$, where $\operatorname{Det}(\mathbb{R} X)$ is the determinant line bundle of $\mathbb{R} X$, and equip this bundle with a spin structure, which is possible since $w_{1}(M)=w_{2}(M)=0$.
3) If $k_{d}$ is even and $n=2 \bmod (4)$, we assume that $w_{2}(\mathbb{R} X)=w_{1}^{2}(\mathbb{R} X)$. We then set $M=T \mathbb{R} X \oplus \operatorname{Det}(\mathbb{R} X)$ and we equip this bundle with a spin structure, which is possible since $w_{1}(M)=w_{2}(M)=0$.
4) If $k_{d}$ is even and $n=1 \bmod (4)$, we assume that there exists $w \in H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$ such that $w^{2} \in\left\{w_{2}(\mathbb{R} X), w_{2}(\mathbb{R} X)+w_{1}^{2}(\mathbb{R} X)\right\}$. We then set $M=T \mathbb{R} X \oplus L_{\mathbb{R} X}(w)^{2}$, where $L_{\mathbb{R} X}(w)$
is the line bundle over $\mathbb{R} X$ whose Euler class is $w$. Moreover, we equip this bundle with a $\widetilde{G L}_{m}^{+}(\mathbb{R})$ or $\widetilde{G L}_{m}^{-}(\mathbb{R})$-structure depending on whether $w^{2}=w_{2}(\mathbb{R} X)$ or $w^{2}=w_{2}(\mathbb{R} X)+$ $w_{1}^{2}(\mathbb{R} X)$. Note that $w_{1}(M)=w_{1}(\mathbb{R} X)$ and $w_{2}(M)=w_{2}(\mathbb{R} X)+w^{2}$.

Remark 1.5 Under the assumption 4, we will have actually to restrict ourselves to real rational curves $A$ whose real locus $\mathbb{R} A$ satisfy $<w,[\mathbb{R} A]>\neq 0$. Using the terminology of Lemma 1.4, this means that we will restrict ourselves to connected components $\mathbb{R} \mathcal{M}^{*}$ of $\mathbb{R}_{\tau} \mathcal{M}_{k_{d}}^{d}(X)^{*}$ for which $<w, d_{\mathbb{R} \mathcal{M}^{*}}>\neq 0 \in \mathbb{Z} / 2 \mathbb{Z}$.

## Examples:

1) If $n=3$, then from Wu formula, $w_{2}(\mathbb{R} X)=w_{1}^{2}(\mathbb{R} X)$ so that condition 1 is always satisfied, see page 132 of (14] for instance.
2) All projective spaces satisfy these hypothesis. Indeed, if $X=\mathbb{C} P^{n}$ and $w$ is the generator of $H^{1}\left(\mathbb{R} P^{n} ; \mathbb{Z} / 2 \mathbb{Z}\right)$, then $w_{1}(\mathbb{R} X)=(n+1) w$ and $w_{2}(\mathbb{R} X)=\frac{n(n+1)}{2} w^{2}$. If $n \neq 1$ $\bmod (4)$ or $k_{d}$ is odd, one easily check the hypothesis. If $k_{d}$ is even and $n=1 \bmod (4)$, one has to choose $w$ to be the generator of $H^{1}\left(\mathbb{R} P^{n} ; \mathbb{Z} / 2 \mathbb{Z}\right)$. It turns out that the definition of $k_{d}$ forces the degrees of rational curves to be odd in this case, so that their real parts are always non trivial against $w$.
3) If $\mathbb{R} X$ is spin and $n \neq 1 \bmod (4)$, HYP are satisfied.

### 1.2.2 Spinor states of balanced real rational curves

Let $u:\left(\mathbb{C} P^{1}, \operatorname{conj}\right) \rightarrow\left(X, c_{X}\right)$ be a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant immersion and $0 \rightarrow T \mathbb{C} P^{1} \rightarrow u^{*} T X \rightarrow$ $N_{u} \rightarrow 0$ be the associated exact sequence. Let $d=u_{*}\left[\mathbb{C} P^{1}\right]$ and $k_{d}$ be the associated integer, see $\$ 1.1$. We assume that the hypothesis HYP of $\S 1.2 .1$ are satisfied and deduce from the previous exact sequence a splitting $u^{*} T \mathbb{R} X=T \mathbb{R} P^{1} \oplus \mathbb{R} N_{u}$ which is well defined up to homotopy. Assume now that the vanishing $H^{1}\left(\mathbb{C} P^{1} ; N_{u} \otimes \mathcal{O}_{\mathbb{C} P^{1}}\left(-k_{d}\right)\right)=0$ occurs, so that $N_{u}$ gets isomorphic to $\mathcal{O}_{\mathbb{C} P^{1}}\left(k_{d}-1\right)^{n-1}$. Such a curve is said to be balanced, as its normal bundle is a direct sum of isomorphic lines bundles. Let $\xi \in \mathbb{R} P^{1}$ and $\left(v_{1}, \ldots, v_{n-1}\right)$ be a basis of the fibre $\left.\mathbb{R} N_{u}\right|_{\xi}$. For $i \in\{1, \ldots, n-1\}$, there exists a unique holomorphic line sub bundle of degree $k_{d}-1$ of $N_{u}$ which contains $v_{i}$. This immediatly follows from the isomorphism $P\left(N_{u}\right) \cong \mathbb{C} P^{1} \times \mathbb{C} P^{n-2}$ and the fact that such line sub bundles are mapped onto constant sections of $\mathbb{C} P^{1} \times \mathbb{C} P^{n-2}$. We deduce a decomposition $\mathbb{R} N_{u}=L_{\mathbb{R} P^{1}}\left(k_{d}-1\right)^{n-1}$ which is well defined up to homotopy.

Now let $M$ be the vector bundle defined in $\S 1.2 .1$. In all cases 1 to 4 considered in $\$ 1.2 .1$, we obtained a decomposition $u^{*} M=L_{\mathbb{R} P^{1}}(0) \oplus L_{\mathbb{R} P^{1}}\left(k_{d}-1\right)^{m-1}$ well defined up to homotopy. That is $u^{*} M$ is given a splitting as the direct sum of $m$ orientable real line bundles when $k_{d}$ is odd and as the direct sum of $m-1$ non orientable real line bundles and one orientable one when $k_{d}$ is even. Note that in all the cases $u^{*} M$ is orientable, since $m=3 \bmod (4)$. When both $k_{d}$ and $n$ are even, $u^{*} M$ is even oriented since by assumption $M$ is. When $k_{d}$ is even and $n$ is odd, we equip $u^{*} M$ with an orientation. We are then ready to define the spinor state of the balanced real rational curve $\operatorname{Im}(u)$.

1st case : $k_{d}$ is odd. In this case, we choose some trivialization of each factor $L_{\mathbb{R} P^{1}}(0)$ of $u^{*} M=L_{\mathbb{R} P^{1}}(0)^{m}$ given by some non vanishing section $v_{i}, i \in\{1, \ldots m\}$. We hence get a loop $\left(v_{1}(\xi), \ldots, v_{m}(\xi)\right), \xi \in \mathbb{R} P^{1}$, of the $G L_{m}(\mathbb{R})$-bundle $u^{*} R_{M}$ of frames of $u^{*} M$. We define $s p_{\mathfrak{p}}(u)=+1$ (resp. $s p_{\mathfrak{p}}(u)=-1$ ) if this loop does lift (resp. does not lift) to a loop of the $\widetilde{G L}_{m}^{ \pm}(\mathbb{R})$-principal bundle $u^{*} P_{M}$ given in $\oint 1.2 .1$ which defines the $\widetilde{G L} \widetilde{m}_{m}^{ \pm}(\mathbb{R})$-structure $\mathfrak{p}$ on $M$.

This integer neither depends on the choice of the decomposition $u^{*} M=L_{\mathbb{R} P^{1}}(0)^{m}$ nor on the one of the sections $v_{1}(\xi), \ldots, v_{m}(\xi)$. It also does not depend on the parameterization $u$ of $\operatorname{Im}(u)$ and is called the spinor state of $\operatorname{Im}(u)$.

2 nd case : $k_{d}$ is even. Then $m-1=2 \bmod (4)$ and $u^{*} M$ is oriented. We choose some trivialization of each factor of the decomposition $u^{*} M=L_{\mathbb{R} P^{1}}(0) \oplus L_{\mathbb{R} P^{1}}\left(k_{d}-1\right)^{m-1}$ over $[0, \pi] \subset \mathbb{R} P^{1}$ given by some non vanishing section $\left.v_{i}\right|_{[0, \pi]}, i \in\{1, \ldots m\}$. We can assume that $v_{1} \in L_{\mathbb{R} P^{1}}(0)$ and the basis $\left(v_{1}(\xi), \ldots, v_{m}(\xi)\right)$ to be direct. Also, we assume that the orientations of $\mathbb{R} P^{1}$ given by $v_{1}$ and $[0, \pi]$ are the same. Then we can apply the path $g(\xi)=\left[\begin{array}{llll}1 & & & \\ & \operatorname{rot}(\xi) & & \\ & & \ddots & \\ & & & \operatorname{rot}(\xi)\end{array}\right] \in G L_{m}(\mathbb{R})$ to this basis, where $\xi \in[0, \pi]$ and $\operatorname{rot}(\xi)=\left[\begin{array}{cc}\cos (\xi) & -\sin (\xi) \\ \sin (\xi) & \cos (\xi)\end{array}\right]$. The number of such rotation blocks is odd. We hence get a new decomposition $u^{*} M=L_{\mathbb{R} P^{1}}(0)^{m}$ as a direct sum of orientable real line bundles.

Lemma 1.6 The homotopy class of the decomposition $u^{*} M=L_{\mathbb{R} P^{1}}(0)^{m}$ hence obtained does not depend on the choice of the base $\left(v_{1}, \ldots, v_{m}\right)$.

Note that it however depends on the choice of the orientation on $u^{*} M$.

## Proof:

When $v_{1}$ is fixed, the orientation of $u^{*} M$ induces an orientation of the factor $L_{\mathbb{R} P^{1}}\left(k_{d}-\right.$ $1)^{m-1}$. The result follows from the fact that the set of direct basis of $L_{\mathbb{R} P^{1}}\left(k_{d}-1\right)^{m-1}$ is connected. Consider now the base $\left(-v_{1}, v_{3}, v_{2}, \ldots, v_{m-1}, v_{m}\right)$. Since $m=3 \bmod (4)$, it is a direct basis of $u^{*} M$. Applying the path $g(\xi)$ taking into account that the orientation of $\mathbb{R} P^{1}$ is reversed amounts the same as applying the path $g(\pi-\xi)$ with the same orientation. To conclude, one just has to check that applying the rotation block $\operatorname{rot}(\xi)$ to the basis $\left(v_{i}, v_{i+1}\right)$ has the same effect as applying the rotation block $\operatorname{rot}(\pi-\xi)$ to the basis $\left(v_{i+1}, v_{i}\right)$.

Thanks to Lemma 1.6, we can now define the spinor state $s p_{\mathfrak{p}, \mathfrak{o}}(u) \in\{ \pm 1\}$ as in the first case, where $\mathfrak{o}$ is the chosen orientation of $u^{*} M$. This integer neither depends on the choice of the decomposition $u^{*} M=L_{\mathbb{R} P^{1}}(0)^{m}$ nor on the one of the sections $v_{1}(\xi), \ldots, v_{m}(\xi)$. It also does not depend on the parameterization $u$ of $\operatorname{Im}(u)$. Note that the definition of spinor state given here extends the one of $\S 2.2$ of [19]. Remember that the set of $\widetilde{G L}{ }_{m}^{ \pm}(\mathbb{R})$-structures of $M$ is a principal space over $H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$, see page 184 of [10] for example. We denote this action by $(w, \mathfrak{p}) \mapsto w \cdot \mathfrak{p}$, where $w \in H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$.

Lemma 1.7 Let $u:\left(\mathbb{C} P^{1}\right.$, conj $) \rightarrow\left(X, c_{X}\right)$ be a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant balanced immersion and $w \in H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$. Then, $s p_{\mathfrak{p},-\mathfrak{o}}(u)=-s p_{\mathfrak{p}, \mathfrak{o}}(u)$ and $s p_{w, \mathfrak{p}, \mathfrak{o}}(u)=(-1)^{<w, u_{*}\left[\mathbb{R} P^{1}\right]>} s p_{\mathfrak{p}, \mathfrak{o}}(u)$.

## Proof:

The composition of the path $g(\xi), \xi \in[0, \pi]$, applied to the basis $\left(v_{1}, \ldots, v_{m}\right)$ and the path $g(\pi-\xi), \xi \in[0, \pi]$, applied to the basis ( $v_{1}, v_{3}, v_{2}, v_{4}, \ldots, v_{m-1}, v_{m}$ ) has a non-vanishing homotopy class in $\pi_{1}\left(G L_{m}(\mathbb{R})\right) \cong \mathbb{Z} / 2 \mathbb{Z}$. The relation $s p_{\mathfrak{p},-\mathfrak{o}}(u)=-s p_{\mathfrak{p}, \mathfrak{o}}(u)$ follows. The relation $s p_{w, \mathfrak{p}, \mathfrak{o}}(u)=(-1)^{<w, u_{*}\left[\mathbb{R} P^{1}\right]>} s p_{\mathfrak{p}, \mathfrak{o}}(u)$ immediatly follows from the definition of the action of $H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$ on the set of $\widetilde{G L_{m}}(\mathbb{R})$-structures of $M$.

## 2 Statement of the results

### 2.1 Statements

Let ( $X, c_{X}$ ) be a smooth real algebraic convex manifold of dimension $n \geq 3$. Let $d \in H_{2}(X ; \mathbb{Z})$ be such that $\left(c_{X}\right)_{*} d=-d,(n-1) /\left(c_{1}(X) d-2\right)$ and $k_{d}=\frac{1}{n-1}\left(c_{1}(X) d-2\right)+1$. Let $\tau \in \sigma_{k_{d}}$ be such that $\tau^{2}=i d$ and $\tau(1)=1$ if $n$ is odd, see Lemma 1.3. Let $\underline{x} \in \mathbb{R}_{\tau} X^{k_{d}}$ be generic enough, so that there are only finitely many connected real rational curves which realize $d$ and pass through $\underline{x}$. Moreover, they are all irreducible, immersed, balanced and have non-empty real part, see Theorem 1.1 and Lemma 1.3. Let $h \in H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$, we denote by $\mathcal{R}_{d}(\underline{x}, h)$ the finite set of those curves whose real part realize $h$. We assume that the hypothesis HYP of $\$ 1.2 .1$ hold and denote by $M \rightarrow \mathbb{R} X$ the given rank $m$ vector bundle. Note that in the fourth case of HYP, that is if $k_{d}$ is even and $n=1 \bmod (4)$, we have to assume that $\left.<w, h\right\rangle \neq 0$, where $w \in H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$ is the given cohomology class, see Remark 1.5. In case $k_{d}$ is even and $n$ is odd, we equip $\left.M\right|_{x_{1}}$ with an orientation $\mathfrak{o}$. This orientation induces an orientation on $\left.M\right|_{\mathbb{R} A}$ for every $A \in \mathcal{R}_{d}(\underline{x}, h)$. Thus, spinor states of all the elements of $\mathcal{R}_{d}(\underline{x}, h)$ are well defined. We set

$$
\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}(\underline{x})=\sum_{A \in \mathcal{R}_{d}(\underline{x}, h)} s p_{\mathfrak{p}, \mathfrak{o}}(A) \in \mathbb{Z},
$$

where the connected components of $\mathbb{R} X$ have been labelled $(\mathbb{R} X)_{1}, \ldots,(\mathbb{R} X)_{N}, r_{i}=\#(\underline{x} \cap$ $\left.(\mathbb{R} X)_{i}\right), i \in\{1, \ldots, N\}$, and $r=\left(r_{1}, \ldots, r_{N}\right)$.

Theorem 2.1 Let $\left(X, c_{X}\right)$ be a smooth real algebraic convex manifold of dimension $n \geq 3$. Assume that the above hypothesis hold so that the integer $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}(\underline{x})$ is well defined. Then, this integer does not depend on the generic choice of $\underline{x}$ in $\mathbb{R}_{\tau} X^{k_{d}}$.
We can thus denote this integer by $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}$ without ambiguity.
Corollary 2.2 Under the hypothesis of Theorem [2.1, assume that $k_{d}$ is even and $n$ is odd. If the restriction of $M$ over the connected component of $x_{1}$ in $\mathbb{R} X$ is not orientable, then $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}=0$. In particular, the genus zero Gromov-Witten invariant $G W_{0}(X, d, p t, \ldots, p t)$ is even in this case.

## Proof:

Let $x_{1}$ move along a loop around which $M$ is not orientable, then it comes back together with the opposite orientation $-\mathfrak{o}$ on $\left.M\right|_{x_{1}}$. The result thus follows from Lemma 1.7 and Theorem 2.1.

Note that the automorphism group of ( $X, c_{X}$ ) provides symmetries for the invariant $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}$ which also sometimes imply its vanishing, see Remark 2.4 of [19]. From Corollary [2.2, if $k_{d}$ is even and $n$ is odd, we can assume that $M$ is orientable. The orientation $\mathfrak{o}$ on $M$ together with the $\widetilde{G L} \widetilde{m}^{ \pm}$-structure provide a spin-structure on $M$. We can thus get rid of the mention of the orientation in $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}$, provided that when $k_{d}$ is even, $\mathfrak{p}$ is understood as a spin structure rather than a $\widetilde{G L}{ }_{m}^{ \pm}$-structure. The generating function for this invariant is some polynomial $\chi^{d, h \mathfrak{p}}(T)=\sum_{r \in \mathbb{N}^{N}} \chi_{r}^{d, h \mathfrak{p}} T^{r} \in \mathbb{Z}\left[T_{1}, \ldots, T_{N}\right]$, where $T^{r}=T_{1}^{r_{1}} \ldots T_{N}^{r_{N}}$ and we have set $\chi_{r}^{d, h \mathfrak{p}}=0$ when it is not well defined. This polynomial has the same parity as $k_{d}$ and each of its monomials $\chi_{r}^{d, h \mathfrak{p}} T^{r}$ actually only depend on one indeterminate. The latter follows from
the fact that real rational curves have connected real parts which cannot interpolate points in different connected components of $\mathbb{R} X$. Theorem 2.1 means that the function

$$
\chi^{\mathfrak{p}}:(d, h) \in H^{2}(X ; \mathbb{Z}) \times H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z}) \mapsto \chi^{d, h \mathfrak{p}}(T) \in \mathbb{Z}[T]
$$

is an invariant associated to the isomorphism class of $\left(X, c_{X}\right)$. This invariant immediatly provides the following lower bounds in real enumerative geometry.

Corollary 2.3 Under the hypothesis of Theorem 2.1,

$$
\left|\chi_{r}^{d, h \mathfrak{p}}\right| \leq \# \mathcal{R}_{d}(\underline{x}, h) \leq N_{d}=G W_{0}(X, d, p t, \ldots, p t)
$$

for every generic $\underline{x} \in \mathbb{R}_{\tau} X^{k_{d}}$.
Remark 2.4 1) In the case $n=3$, these results have already been obtained in 19. The case $n=2$ is covered by [18].
2) The problem of computing these invariants $\chi_{r}^{d, h \mathfrak{p}}$ is widely open. So far, with the exception of $\S 3.4 .2$ of [18], the only approach which has been successful comes from tropical geometry. It allowed to I. Itenberg, V. Kharlamov and E. Shustin to produce various estimations for some toric surfaces of the invariants introduced in [18], see [6], [7]. Also, G. Mikhalkin announced the value $\left|\chi_{10}^{d, h \mathfrak{p}}\right|=45$ when $X=\mathbb{C} P^{3}, d=5$ and $h=1$.

### 2.2 Topological interpretation

Note that the singularities of $\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X)$ are of codimension two at least since it is normal, see Theorem 2 of [2]. This space thus carries a first Stiefel-Whitney class. For $D \in$ $H_{n k_{d}-1}\left(\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X) ; \mathbb{Z} / 2 \mathbb{Z}\right)$, denote by $D^{\vee}$ its image under the morphism $H_{n k_{d}-1}\left(\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X) ; \mathbb{Z} / 2 \mathbb{Z}\right) \rightarrow$ $H^{1}\left(\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X) ; \mathbb{Z} / 2 \mathbb{Z}\right)$.

Proposition 2.5 The first Stiefel-Whitney class of every component $\mathbb{R} \mathcal{M}^{*}$ of $\mathbb{R}_{\tau} \mathcal{M}_{k_{d}}^{d}(X)$ which contains a balanced curve writes

$$
w_{1}\left(\mathbb{R} \mathcal{M}^{*}\right)=\left(\mathbb{R}_{\tau} e v^{d}\right)^{*} w_{1}\left(\mathbb{R}_{\tau} X^{k_{d}}\right)+\sum_{D \subset \text { Red }^{\prime}} \epsilon(D) D^{\vee} \in H^{1}\left(\mathbb{R} \mathcal{M}^{*} ; \mathbb{Z} / 2 \mathbb{Z}\right)
$$

where $\epsilon(D) \in\{0,1\}$ and if $\epsilon(D)=1$, the irreducible component $D$ of Red gets contracted by the evaluation map $\mathbb{R}_{\tau} e v^{d}$.

Here Red denotes the union of the divisor Red introduced in Theorem 1.1 and the divisors of non-balanced curves $(u, C, \underline{z})$ such that $\operatorname{dim} H^{1}\left(C ; N_{u} \otimes \mathcal{O}_{C}(-\underline{z})\right) \geq 2$, in case such divisors exist. Denote by $\operatorname{Red}_{1}$ the union of the irreducible components $D$ of Red' for which $\epsilon(D)=1$. Equip $\mathbb{R}_{\tau} X^{k_{d}}$ with the system of twisted integer coefficients $\mathcal{Z}$ and denote by $\left[\mathbb{R}_{\tau} X^{k_{d}}\right] \in H_{n k_{d}}\left(\mathbb{R}_{\tau} X^{k_{d}} ; \mathcal{Z}\right)$ one associated fundamental class. Denote by $\mathcal{Z}^{*}$ the local system of coefficients of $\mathbb{R} \mathcal{M}^{*}$ pulled back from $\mathcal{Z}$ by $\mathbb{R}_{\tau} e v^{d}$, see 16].

Proposition 2.6 Under the hypothesis of Proposition 2.5, there exists a unique fundamental class $\left[\mathbb{R} \mathcal{M}^{*}\right] \in H_{n k_{d}}\left(\mathbb{R} \mathcal{M}^{*}, \operatorname{Red}_{1} ; \mathcal{Z}^{*}\right)$ such that for every balanced curve $(u, C, \underline{z}) \in$ $\mathbb{R} \mathcal{M}^{*}$, the morphism $\left(\mathbb{R}_{\tau} e v^{d}\right)_{*}: H_{n k_{d}}\left(\mathbb{R} \mathcal{M}^{*}, \mathbb{R}^{\mathcal{M}} \mathcal{M}^{*} \backslash\{(u, C, \underline{z})\} ; \mathcal{Z}^{*}\right) \rightarrow H_{n k_{d}}\left(\mathbb{R}_{\tau} X^{k_{d}}, \mathbb{R}_{\tau} X^{k_{d}} \backslash\right.$ $\{u(\underline{z})\} ; \mathcal{Z})$ sends $\left[\mathbb{R} \mathcal{M}^{*}\right]$ onto $s p_{\mathfrak{p}, \mathfrak{o}}(u, C, \underline{z})\left[\mathbb{R}_{\tau} X^{k_{d}}\right]$.

Since $\mathbb{R}_{\tau} e v^{d}\left(\operatorname{Red}_{1}\right)$ is of codimension two, the group $H_{n k_{d}}\left(\mathbb{R}_{\tau} X^{k_{d}}, \mathbb{R}_{\tau} e v^{d}\left(\operatorname{Red}_{1}\right) ; \mathcal{Z}\right)$ is cyclic, generated by $\left[\mathbb{R}_{\tau} X^{k_{d}}\right]$. The integer $\chi_{r}^{d, h \mathfrak{p}}$ is nothing but the one defined by the relation $\left(\mathbb{R}_{\tau} e v^{d}\right)_{*}\left[\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X)\right]=\chi_{r}^{d, h \mathfrak{p}}\left[\mathbb{R}_{\tau} X^{k_{d}}\right]$, where the fundamental class $\left[\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X)\right]$ is given by Proposition 2.6 and restricted to connected components $\mathbb{R} \mathcal{M}^{*}$ for which $d_{\mathbb{R}} \mathcal{M}^{*}=h$, see Lemma 1.4.

## 3 Proof of Theorem 2.1

We restrict the evaluation map $\mathbb{R}_{\tau} e v^{d}: \mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X) \rightarrow \mathbb{R}_{\tau} X^{k_{d}}$ to some connected component $\mathbb{R} \mathcal{M}^{*}$ of $\mathbb{R}_{\tau} \overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*}$. We denote by $\mathbb{R}_{\tau}$ Crit (resp. $\mathbb{R}_{\tau}$ Red) the divisor of critical points of $\mathbb{R}_{\tau} e v^{d}$ (resp. the divisor of curves with reducible domain). The integer $\chi_{r}^{d, h \mathfrak{p}}(\underline{x})$ is then well defined and constant on each connected component of the complement of the image $\mathbb{R}_{\tau} e v^{d}\left(\mathbb{R}_{\tau}\right.$ Crit $\left.\cup \mathbb{R}_{\tau} \operatorname{Red}\right)$ in $\mathbb{R}_{\tau} X^{k_{d}}$. We have to prove that this integer remains unchanged while crossing these image divisors. This is the concern of the following Theorems 3.4 and 3.5. Theorem 2.1 thus follows from Theorems 3.4 and 3.5.

### 3.1 Generic points of the divisor $\mathbb{R}_{\tau} e v^{d}\left(\mathbb{R}_{\tau}\right.$ Red $)$

We are interested here in the part of $\mathbb{R}_{\tau} e v^{d}\left(\mathbb{R}_{\tau} R e d\right)$ which cannot be avoided by a generic path of $\mathbb{R}_{\tau} X^{k_{d}}$. In particular, it follows from Theorem 3 of [2] that this part is made of points which are images of stable curves $(u, C, \underline{z}) \in \mathbb{R} \mathcal{M}^{*}$ for which $C$ has two irreducible components $C_{1}, C_{2}$. For $i \in\{1,2\}$, denote by $d_{i}=u_{*}\left[C_{i}\right] \in H_{2}(X ; \mathbb{Z})$ and $\left(c_{1}(X) d_{i}-2\right)+n-1=$ $(n-1) l_{i}+n_{i}$ where $l_{i} \in \mathbb{N}$ and $0 \leq n_{i} \leq n-2$. Moreover, denote by $k_{i}=\#\left(\underline{z} \cap C_{i}\right)$ and $u_{i}=\left.u\right|_{C_{i}}$, so that $k_{1}+k_{2}=k_{d}$.

Proposition 3.1 The complement in $\mathbb{R}_{\tau}$ Red of the locus of stable maps $(u, C, \underline{z})$ such that $C$ has two irreducible components $C_{1}, C_{2}$ and $u$ is an immersion which satisfies one of the following conditions $1,2 a$ or $2 b$, is mapped by $\mathbb{R}_{\tau} e v^{d}$ onto finitely many submanifolds of codimension greater than one of $\mathbb{R}_{\tau} X^{k_{d}}$.

1) With the above notations, $n_{1}=n_{2}=n-2, k_{1}=l_{1}$ and $k_{2}=l_{2}+1$. Moreover, the isomorphisms $N_{u_{1}} \cong \mathcal{O}_{C_{1}}\left(k_{1}\right)^{n-2} \oplus \mathcal{O}_{C_{1}}\left(k_{1}-1\right)$ and $N_{u_{2}} \cong \mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-2} \oplus \mathcal{O}_{C_{2}}\left(k_{2}-2\right)$ hold. Finally the tangent line of $u\left(C_{1}\right)$ (resp. $u\left(C_{2}\right)$ ) at $\xi=u\left(C_{1} \cap C_{2}\right)$ is transversal to the hyperplane generated by $\left.\mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-2}\right|_{\xi}$ and $T_{\xi} u\left(C_{2}\right)$ (resp. by $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n-2}$ and $T_{\xi} u\left(C_{1}\right)$ ).
2) With the above notations, $\left(n_{1}+1\right)+\left(n_{2}+1\right)=n-1, k_{1}=l_{1}$ and $k_{2}=l_{2}$. Moreover, one of the following:
a) The isomorphisms $N_{u_{1}} \cong \mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}} \oplus \mathcal{O}_{C_{1}}\left(k_{1}-1\right)^{n-n_{1}-1}$ and $N_{u_{2}} \cong \mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}} \oplus$ $\mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-n_{2}-1}$ hold. Finally the spaces generated by $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}}, T_{\xi} u\left(C_{1}\right)$ and by $\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}}$, $T_{\xi} u\left(C_{2}\right)$ are in direct sum at the point $\xi=u\left(C_{1} \cap C_{2}\right)$.
b) The isomorphisms $N_{u_{1}} \cong \mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}} \oplus \mathcal{O}_{C_{1}}\left(k_{1}-1\right)^{n-n_{1}-1}$ and $N_{u_{2}} \cong \mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1} \oplus$ $\mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-n_{2}-3} \oplus \mathcal{O}_{C_{2}}\left(k_{2}-2\right)$ hold. In this case, the spaces generated by $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}}$, $T_{\xi} u\left(C_{1}\right)$ and by $\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1}, T_{\xi} u\left(C_{2}\right)$ are in direct sum at the point $\xi=u\left(C_{1} \cap C_{2}\right)$. Finally, the tangent line $T_{\xi} u\left(C_{1}\right)$ is transversal to the hyperplane generated by $\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1} \oplus \mathcal{O}_{C_{2}}\left(k_{2}-\right.$ $1)^{n-n_{2}-3}$ and $T_{\xi} u\left(C_{2}\right)$.

## Proof:

For $i \in\{1,2\}$, denote by $\underline{z}_{i}=\underline{z} \cap C_{i}, \tau_{i}=\left.\tau\right|_{C_{i}}$ and $e v_{i}: \mathbb{R}_{\tau_{i}} \overline{\mathcal{M}}_{k_{i}}^{d_{i}}(X)^{*} \rightarrow \mathbb{R}_{\tau_{i}} X^{k_{i}}$. We can assume that at most one of the two differentials $\left.d\right|_{\left(u_{i}, C_{i}, \underline{z}_{i}\right)} e v_{i}$ is not surjective and that
its cokernel is then one dimensional. Indeed, the image under $e v_{1} \times e v_{2}$ of the stable maps not having this property is included inside a finite union of subvarieties of codimension two at least. Since the dimension of $\mathbb{R}_{\tau_{i}} \overline{\mathcal{M}}_{k_{i}}^{d_{i}}(X)^{*}$ is equal to $(n-1) l_{i}+n_{i}+k_{i}$, we deduce the following alternative. Either $(n-1) l_{1}+n_{1}+k_{1} \geq n k_{1}$ and $(n-1) l_{2}+n_{2}+k_{2} \geq n k_{2}-1$, or $(n-1) l_{i}+n_{i}+k_{i} \geq n k_{i}, i \in\{1,2\}$. This alternative rewrites:

1) Either, $(n-1)\left(l_{1}-k_{1}\right) \geq 0$ which imposes $k_{1} \leq l_{1}$, and $(n-1)\left(l_{2}-k_{2}\right)=-1$ which imposes $k_{2}=l_{2}+1$ and $n_{2}=n-2$.
2) Or, $(n-1)\left(l_{i}-k_{i}\right) \geq 0, i \in\{1,2\}$, which imposes $k_{i} \leq l_{i}$.

Note that $n_{1}+n_{2}+(n-1)\left(l_{1}+l_{2}\right)=c_{1}(X) d-4+2(n-1)=(n-1)\left(k_{d}+1\right)-2$ and $2 \leq\left(n_{1}+1\right)+\left(n_{2}+1\right) \leq 2(n-1)$. Thus, either $n_{1}+n_{2}+2=2(n-1)$ and $l_{1}+l_{2}+1=k_{d}$, or $n_{1}+n_{2}+2=n-1$ and $l_{1}+l_{2}=k_{d}$. Our alternative hence finally rewrites:

1) Either, $k_{1}=l_{1}, k_{2}=l_{2}+1$ and $n_{1}=n_{2}=n-2$.
2) Or, $k_{1}=l_{1}, k_{2}=l_{2}$ and $\left(n_{1}+1\right)+\left(n_{2}+1\right)=n-1$.

Let us write now $N_{u_{1}} \cong \mathcal{O}_{C_{1}}\left(a_{1}\right) \oplus \cdots \oplus \mathcal{O}_{C_{1}}\left(a_{n-1}\right)$ and $N_{u_{2}} \cong \mathcal{O}_{C_{2}}\left(b_{1}\right) \oplus \cdots \oplus \mathcal{O}_{C_{2}}\left(b_{n-1}\right)$. In the first case, the surjectivity of $\left.d\right|_{\left(u_{1}, C_{1}, \underline{z}_{1}\right)} e v_{1}$ imposes that for $1 \leq i \leq n-1, a_{i} \geq k_{1}-1$. In the same way, since the cokernel of $\left.d\right|_{\left(u_{2}, C_{2}, \underline{z}_{2}\right)} e v_{2}$ is one dimensional, for $1 \leq i \leq n-2$, $b_{i} \geq k_{2}-1$ and $b_{n-1}=k_{2}-2$. Thus, for $1 \leq i \leq n-2, b_{i}=k_{2}-1$ so that $N_{u_{2}} \cong \mathcal{O}_{C_{2}}\left(k_{2}-\right.$ $1)^{n-2} \oplus \mathcal{O}_{C_{2}}\left(k_{2}-2\right)$ and $u_{2}$ is an immersion. We can assume that the map $\left.d\right|_{(u, C, z)} \mathbb{R}_{\tau} e v^{d}$ has a one dimensional cokernel once restricted to infinitesimal deformations of stable maps with reducible domains. This cokernel is generated by infinitesimal deformations of points $\underline{x}=u(\underline{z})$ for which only one point of $C_{2}$ deforms in a direction transversal to the sub bundle $\mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-2}$ of $N_{u_{2}}$. We deduce that $a_{n-1}=k_{1}-1$ and for $1 \leq i \leq n-2, a_{i}=k_{1}$, so that in particular $u_{1}$ is an immersion. Moreover, the hyperplane generated by $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n-2}$ and $T_{\xi} u\left(C_{1}\right)$ has to be transverse to $T_{\xi} u\left(C_{2}\right)$ so that $u$ is an immersion at $\xi$. The intersection of the hyperplanes generated by $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n-2}, T_{\xi} u\left(C_{1}\right)$ and $\left.\mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-2}\right|_{\xi}, T_{\xi} u\left(C_{2}\right)$ is of dimension $n-2$. This space is generically in direct sum with $T_{\xi} u\left(C_{1}\right)$, hence the result in the first case.

In the second case, the surjectivity of the maps $\left.d\right|_{\left(u_{1}, C_{1}, \underline{z}_{1}\right)} e v_{1}$ and $\left.d\right|_{\left(u_{2}, C_{2}, \underline{z}_{2}\right)} e v_{2}$ imposes that for $1 \leq i \leq n-1, a_{i} \geq k_{1}-1$ and $b_{i} \geq k_{2}-1$. We can once more assume that the map $\left.d\right|_{(u, C, z)} \mathbb{R}_{\tau} e v^{d}$ has a one dimensional cokernel once restricted to infinitesimal deformations of stable maps with reducible domains. We then deduce the alternative.
a) Either for $i \in\{1,2\}, N_{u_{i}} \cong \mathcal{O}_{C_{i}}\left(k_{i}\right)^{n_{i}} \oplus \mathcal{O}_{C_{i}}\left(k_{i}-1\right)^{n-n_{i}-1}$ and the spaces generated by $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}}, T_{\xi} u\left(C_{1}\right)$ and by $\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}}, T_{\xi} u\left(C_{2}\right)$ are in direct sum at the point $\xi=u\left(C_{1} \cap C_{2}\right)$. In this case, the cokernel of the evaluation map is generated by infinitesimal deformations of points $\underline{x}=u(\underline{z})$ for which $k_{d}-1$ points are fixed and the last one moves along a sub bundle $\mathcal{O}_{C_{i}}\left(k_{i}-1\right)$ transversal to this direct sum.
b) Or $N_{u_{1}} \cong \mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}} \oplus \mathcal{O}_{C_{1}}\left(k_{1}-1\right)^{n-n_{1}-1}$ and $N_{u_{2}} \cong \mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1} \oplus \mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-n_{2}-3} \oplus$ $\mathcal{O}_{C_{2}}\left(k_{2}-2\right)$. In this case, the cokernel of the evaluation map is generated by infinitesimal deformations of points $\underline{x}=u(\underline{z})$ for which $k_{d}-1$ points are fixed and the last one moves in the direction of $\mathcal{O}_{C_{2}}\left(k_{2}-2\right)$. Thus, the spaces generated by $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}}, T_{\xi} u\left(C_{1}\right)$ and by $\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1}, T_{\xi} u\left(C_{2}\right)$ are in direct sum at the point $\xi=u\left(C_{1} \cap C_{2}\right)$. Finally, the tangent line $T_{\xi} u\left(C_{1}\right)$ is generically transversal to the hyperplane generated by $\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1} \oplus \mathcal{O}_{C_{2}}\left(k_{2}-\right.$ $1)^{n-n_{2}-3}$ and $T_{\xi} u\left(C_{2}\right)$.

Proposition 3.2 The stable maps given by Proposition 3.1 are regular points of the evaluation map ev ${ }^{d}$.

## Proof:

Let $(u, C, \underline{z}) \in \overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*}$ be such a stable map. From Proposition 3.1, the differential map $\left.d\right|_{(u, C, \underline{z})} e v^{d}$ is injective once restricted to the hyperplane tangent to the divisor Red of stable maps with reducible domains. We have thus to prove that $\left.d\right|_{(u, C, z)} e v^{d}$ is injective once restricted to some transversal to this hyperplane. Let $B$ be a smooth curve trasversal to Red at ( $u, C, \underline{z}$ ), and $U \rightarrow B$ be the universal curve. Let $s_{1}, \ldots, s_{k_{d}}: B \rightarrow U$ be the tautological sections of this universal curve and eval : $U \rightarrow X$ be the evaluation map. From Proposition 3.1. we can assume that it contracts $s_{1}, \ldots, s_{k_{d}-1}$ onto $k_{d}-1$ fixed points $x_{1}, \ldots, x_{k_{d}-1}$. We have then to prove that eval is injective once restricted to $\operatorname{Im}\left(s_{k_{d}}\right)$. The singular fibre of $U \rightarrow B$ has two irreducible components $C_{1}, C_{2}$ and their normal bundles in $U$ are isomorphic to $\mathcal{O}_{C_{1}}(-1)$ and $\mathcal{O}_{C_{2}}(-1)$ respectively. Suppose that deval $\left.\right|_{\operatorname{Im}\left(s_{k_{d}}\right)}$ would vanish at $s_{k_{d}}(0)$. Since deval is injective at $\xi=C_{1} \cap C_{2}$, it would map the normal bundles $\mathcal{O}_{C_{1}}(-1)$ and $\mathcal{O}_{C_{2}}(-1)$ onto sub bundles of degrees $k_{1}-1$ and $k_{2}-1$ of $N_{u_{1}}$ and $N_{u_{2}}$ respectively. This already provides a contradiction in cases 1 and $2 b$ given by Proposition 3.1, since in these cases, sub bundles of degree $k_{2}-1$ of $N_{u_{2}}$ are all tangent to the space of deformation of stable curves with reducible domain. In the case $2 a$ given by Proposition 3.1, we have to notice in addition that this sub bundle of degree $k_{1}-1$ (resp. $k_{2}-1$ ) of $N_{u_{1}}$ (resp. $N_{u_{2}}$ ) does contain the image of $T_{\xi} C_{2}$ (resp. $T_{\xi} C_{1}$ ). We deduce once more a contradiction since from Proposition 3.1, such sub bundles are all tangent to the space of deformation of stable curves with reducible domain.

### 3.2 Passing through $\mathbb{R}_{\tau}$ ev ${ }^{d}\left(\mathbb{R}_{\tau}\right.$ Red $)$

Let $\gamma: t \in \Delta=\{z \in \mathbb{C}| | z \mid<1\} \mapsto \underline{x}(t)=\left(x_{1}(t), \ldots, x_{k_{d}}(t)\right) \in X^{k_{d}}$ be a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant analytic path transversal to $\left.\mathbb{R}_{\tau} e v^{d}\right|_{\mathbb{R}_{\tau} R e d}$ at a generic point given by Proposition 3.1. Let $B \subset \overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*}$ be an irreducible component of the inverse image of $\operatorname{Im}(\gamma)$ under $e v^{d}$ and $U \rightarrow B$ be the universal curve. Let eval : $U \rightarrow X$ be the evaluation map. The rank $n$ holomorphic vector bundle eval* $T X$ has a tautological rank two sub bundle, namely eval ${ }_{*} T U$. From Proposition 3.2, we can assume without loss of generality that $\tau=$ id and that only one point of the configuration, say $x_{k_{d}}(t)$, indeed depends on $t$. We set $B=\left\{\left(u_{t}, C_{t}, \underline{z}_{t}\right), t \in \Delta\right\}$.

Proposition 3.3 There exist $n-3$ real line sub bundles $\mathbb{R} L_{1}, \ldots, \mathbb{R} L_{n-3}$ of eval* $T \mathbb{R} X \rightarrow$ $\mathbb{R} U$ such that the sum eval $T \mathbb{R} U+\mathbb{R} L_{1}+\cdots+\mathbb{R} L_{n-3}$ is direct. Moreover, for every $t \neq 0$ and $1 \leq i \leq n-3, \mathbb{R} L_{i}$ projects onto the real locus of a real holomorphic line sub bundle of degree $k_{d}-1$ of $N_{u_{t}}$.

## Proof:

The strategy is the following. For $1 \leq j \leq n-2$, we extend $\gamma: \Delta \rightarrow X^{k_{d}}$ to an embedding $\Gamma_{j}:(s, t) \in \Delta \times \Delta \mapsto X^{k_{d}}$ such that $\Gamma_{j}(0, t)=\gamma(t)$ and $\Gamma_{j}(s, 0) \in e v^{d}($ Red $)$. The inverse image of $\operatorname{Im}\left(\Gamma_{j}\right)$ under $e v^{d}$ is a surface $S_{j}$ containing $B$. The universal curve $U_{j}$ over $S_{j}$ is a 3 -dimensional manifold containing $U$. Let $N$ be the quotient bundle eval ${ }^{*} T X / \operatorname{eval}_{*} T U$. The image under eval ${ }_{*}$ of the normal bundle of $U$ in $U_{j}$ provides a real holomorphic line sub bundle $\widetilde{L}_{j}$ of $N$ which for $t \in \Delta \backslash\{0\}$ restricts to a line subbundle of degree $k_{d}-1$ of $N_{u_{t}}$. We have to prove that we can find $n-3$ such line sub bundles in direct sum in $N$. The result follows since the real loci of these sub bundles $\widetilde{L}_{j}$ lift to real sub bundles $\mathbb{R} L_{j}$ of eval* $T \mathbb{R} X$-which are not claimed to be real loci of holomorphic ones-. In cases 1 and $2 b$ given by Proposition
3.1, we can even produce $n-2$ such sub bundles. Indeed, in the case 1 , the intersection at $\xi=C_{1} \cap C_{2}$ of the subspaces $<\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n-2}, T_{\xi} u\left(C_{1}\right)>$ and $<\mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-2}, T_{\xi} u\left(C_{2}\right)>$ is of codimension two in eval ${ }^{*} T X$ and transversal to $T_{\xi} u\left(C_{1}\right) \oplus T_{\xi} u\left(C_{2}\right)$. Fix some real basis $e_{1}, \ldots, e_{n-2}$ of this subspace. For $1 \leq j \leq n-2$, there exists a unique real line sub bundle of degree $k_{1}$ (resp. $k_{2}-1$ ) of $N_{u_{1}}$ (resp. $N_{u_{2}}$ ) which contains the image of $e_{j}$. These bundles define the real line sub bundle $\widetilde{L}_{j}$ of $\left.N\right|_{C_{0}}$. Since these sub bundles are in direct sum over $C_{0}$ and of the expected form, Proposition 3.3 is proved in this first case. In the case $2 b$ given by Proposition 3.1, the subspaces $<\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}}, T_{\xi} u\left(C_{1}\right)>$ (resp. $<\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1}, T_{\xi} u\left(C_{2}\right)>$ ) and $<\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1} \oplus \mathcal{O}_{C_{2}}\left(k_{2}-1\right)^{n-n_{2}-3}, T_{\xi} u\left(C_{2}\right)>($ resp. $<$ $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}} \oplus \mathcal{O}_{C_{1}}\left(k_{1}-1\right)^{n-n_{1}-1}, T_{\xi} u\left(C_{1}\right)>$ ) are transversal to each other and neither contain $T_{\xi} u\left(C_{1}\right)$ nor $T_{\xi} u\left(C_{2}\right)$ in their intersections. Choose a free family $e_{1}, \ldots, e_{n-2}$ of $T_{u(\xi)} \mathbb{R} X$ such that $e_{1}, \ldots, e_{n_{1}}$ projects onto $\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}}$ and $e_{n_{1}+1}, \ldots, e_{n-2}$ projects onto $\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}+1}$. For $1 \leq j \leq n_{1}$, there exists a unique line sub bundle of degree $k_{1}$ (resp. $k_{2}-1$ ) of $N_{u_{1}}$ (resp. $N_{u_{2}}$ ) which contains the image of $e_{j}$. In the same way, for $n_{1}+1 \leq j \leq n-2$, there exists a unique line sub bundle of degree $k_{1}-1$ (resp. $k_{2}$ ) of $N_{u_{1}}$ (resp. $N_{u_{2}}$ ) which contains the image of $e_{j}$. These bundles define real line sub bundles $\widetilde{L}_{j}$ of $\left.N\right|_{C_{0}}$ which are in direct sum. We conclude as before. Finally, the case $2 a$ given by Proposition 3.1 can be performed in exactly the same way as the case $2 b$, since the spaces $<\mathcal{O}_{C_{1}}\left(k_{1}\right)^{n_{1}}, T_{\xi} u\left(C_{1}\right)>$ and $<\mathcal{O}_{C_{2}}\left(k_{2}\right)^{n_{2}}, T_{\xi} u\left(C_{2}\right)>$ are in direct sum. In this case however, we produce only $n_{1}+n_{2}=n-3$ line sub bundles of $N$. This is nevertheless enough to conclude.

Theorem 3.4 Let $\gamma: t \in \Delta=\{z \in \mathbb{C}| | z \mid<1\} \mapsto \underline{x}(t)=\left(x_{1}(t), \ldots, x_{k_{d}}(t)\right) \in X^{k_{d}}$ be a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant analytic path transversal to $\mathbb{R}_{\tau} e v^{d}\left(\mathbb{R}_{\tau} R e d\right)$ at a generic point given by Proposition 3.1. Then, there exists $\epsilon>0$ such that $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}(\gamma(t))$ does not depend on $t \in]-\epsilon, \epsilon[\backslash\{0\}$.

## Proof:

As in the begining of $\S\left(2\right.$, , denote by $B \subset \overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*}$ an irreducible component of the inverse image under $e v^{d}$ of $\operatorname{Im}(\gamma), U \rightarrow B$ the universal curve and eval : $U \rightarrow X$ the evaluation map. From the hypothesis, we know that the bundle eval ${ }^{*}\left(T \mathbb{R} X \oplus L_{\mathbb{R} X}(w)^{a}\right)$ is equipped with a $\widetilde{G L}_{n+a^{-}}^{ \pm}$-structure as well as an orientation when $k_{d}$ and $n$ are even. Here, $a \in\{0,1,2,3\}$ and $w \in H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z}), w=w_{1}(\mathbb{R} X)$ except possibly when $k_{d}$ is even and $n=1 \bmod (4)$. This bundle splits as $\operatorname{eval}_{*} T \mathbb{R} U \oplus \mathbb{R} L_{1} \oplus \cdots \oplus \mathbb{R} L_{n-2} \oplus L_{\mathbb{R} X}(w)^{a}$ over $\mathbb{R} U$, where $\mathbb{R} L_{1} \oplus$ $\cdots \oplus \mathbb{R} L_{n-3}$ are given by Proposition 3.3 and $\mathbb{R} L_{n-2}$ is a complement of eval ${ }_{*} T \mathbb{R} U \oplus \mathbb{R} L_{1} \oplus$ $\cdots \oplus \mathbb{R} L_{n-3} \oplus L_{\mathbb{R} X}(w)^{a}$. If $k_{d}$ is even, we apply the path $g(\xi)$ defined in $\$ 1.2 .2$ fibrewise over $\mathbb{R} B$. The sub bundles $\mathbb{R} L_{1} \oplus \cdots \oplus \mathbb{R} L_{n-2}$ and $L_{\mathbb{R} X}(w)^{a}$ are then all orientable once restricted to non-singular fibres of $\mathbb{R} U$. They are thus either orientable over the whole $\mathbb{R} U$, or isomorphic to the determinant line bundle of $\mathbb{R} U$. In both cases, the $\widetilde{G L} L_{n+a}^{ \pm}$-structure of eval ${ }^{*}\left(T \mathbb{R} X \oplus L_{\mathbb{R} X}(w)^{a}\right) \rightarrow \mathbb{R} U$ descend to a $\widetilde{G L} L_{2}^{ \pm}$-structure on $\mathbb{R} U$ (see Lemmas 1.6 and 1.7 of (10]). It suffices then to notice that the homology classes of the fibres $\mathbb{R} U \rightarrow \mathbb{R} B$ in $H_{1}(\mathbb{R} U ; \mathbb{Z} / 2 \mathbb{Z})$ are all the same and that the evaluation of a $\widetilde{G L} \widetilde{2}_{2}^{ \pm}$-structure on a curve in a surface only depends on its homology class modulo 2, see [9] or Lemma 3.4 of [10].

### 3.3 Passing through $\mathbb{R}_{\tau} e v^{d}\left(\mathbb{R}_{\tau}\right.$ Crit)

Let us go on with the notations of $\{3.2$. Let $\gamma: t \in \Delta=\{z \in \mathbb{C}| | z \mid<1\} \mapsto \underline{x}(t)=$ $\left(x_{1}(t), \ldots, x_{k_{d}}(t)\right) \in X^{k_{d}}$ be a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant analytic path transversal to $\left.\mathbb{R}_{\tau} e v^{d}\right|_{\mathbb{R}_{\tau} \text { Crit }}$ at a
generic point. Let $B \subset \overline{\mathcal{M}}_{k_{d}}^{d}(X)^{*}$ be an irreducible component of the inverse image of $\operatorname{Im}(\gamma)$ under $e v^{d}, U \rightarrow B$ be the universal curve and eval : $U \rightarrow X$ be the evaluation map.

Theorem 3.5 With the above notations, let $(u, C, \underline{z}) \in B$ be a critical point of ev ${ }^{d}$ and $l_{0}$ be the vanishing order of $d_{(u, C, \underline{z})}$ ev ${ }^{d}$. Then, there exists $\epsilon>0$ such that the following alternative holds.

1) Either $l_{0}$ is odd and then for $\left.t \in\right]-\epsilon, 0[$ (resp. $t \in] 0, \epsilon[), B \cap\left(e v^{d}\right)^{-1}(t)=\left\{\left(u_{t}^{+}, C_{t}^{+}, \underline{z}_{t}^{+}\right),\left(u_{t}^{-}, C_{t}^{-}, \underline{z}_{t}^{-}\right)\right\}$ with $s p_{\mathfrak{p}, \mathfrak{o}}\left(u_{t}^{+}, C_{t}^{+}, \underline{z}_{t}^{+}\right)=-s p_{\mathfrak{p}, \mathfrak{o}}\left(u_{t}^{-}, C_{t}^{-}, \underline{z}_{t}^{-}\right)\left(\right.$resp. $\left.B \cap\left(e v^{d}\right)^{-1}(t)=\emptyset\right)$ or vice versa.
2) Or $l_{0}$ is even and then for $\left.t \in\right]-\epsilon, \epsilon\left[\backslash\{0\}\right.$, $B \cap\left(e v^{d}\right)^{-1}(t)=\left\{\left(u_{t}, C_{t}, \underline{z}_{t}\right)\right\}$ with $s p_{\mathfrak{p}, \mathfrak{o}}\left(u_{t}, C_{t}, \underline{z}_{t}\right)$ independant of $t \neq 0$.

## Proof:

Denote by $N \rightarrow U$ the quotient bundle eval ${ }^{*} T X /$ eval $^{*} T C_{b}$ where $\left\{C_{b}, b \in B\right\}$ are the fibres of $U \rightarrow B$. From the hypothesis, the central fibre $C_{b_{0}}$ satisfies $\operatorname{dim} H^{1}\left(C_{b_{0}} ; N_{b_{0}} \otimes\right.$ $\left.\mathcal{O}_{C_{b_{0}}}\left(-\underline{z}_{b_{0}}\right)\right)=1$ so that $N_{b_{0}}$ is isomorphic to $\mathcal{O}_{C_{b_{0}}}\left(k_{d}-1\right)^{n-3} \oplus \mathcal{O}_{C_{b_{0}}}\left(k_{d}\right) \oplus \mathcal{O}_{C_{b_{0}}}\left(k_{d}-2\right)$ whereas the other fibres $N_{b}, b \neq b_{0}$, are balanced -restricting $B$ if necessary-. Each factor $\mathcal{O}_{C_{b_{0}}}\left(k_{d}-1\right)$ deforms to an analytic family of sub bundles over the whole $B$. Indeed, the rational curve associated to this line sub bundle in the projectivization $P\left(N_{b_{0}}\right)$ has a normal bundle isomorphic to $\mathcal{O}^{n-3} \oplus \mathcal{O}(1) \oplus \mathcal{O}(-1)$ and is thus a smooth point in its moduli space. We deduce a short exact sequence of real holomorphic vector bundles $0 \rightarrow E \rightarrow N \rightarrow F \rightarrow 0$ where for every $b \in B,\left.E\right|_{C_{b}} \cong \mathcal{O}_{C_{b}}\left(k_{d}-1\right)^{n-3},\left.F\right|_{C_{b}} \cong \mathcal{O}_{C_{b}}\left(k_{d}-1\right)^{2}$ if $b \neq b_{0}$ and $\left.F\right|_{C_{b_{0}}} \cong \mathcal{O}_{C_{b_{0}}}\left(k_{d}\right) \oplus$ $\mathcal{O}_{C_{b_{0}}}\left(k_{d}-2\right)$ otherwise. We deduce a decomposition eval ${ }^{*} T \mathbb{R} X=$ eval $^{*} T \mathbb{R} C_{b} \oplus \mathbb{R} E \oplus \mathbb{R} F$ well defined up to homotopy. If $k_{d}$ is even, we apply the path $g(\xi)$ defined in $\oint 1.2 .2$ fibrewise over $\mathbb{R} B$. The bundle eval ${ }^{*} T \mathbb{R} C_{b} \oplus \mathbb{R} E$ is then a direct sum of orientable real line bundles and as in the proof of Theorem 3.4, the $\widetilde{G L}_{n+a}^{ \pm}$-structure of eval ${ }^{*} M$ descend to a $\widetilde{G L}_{3}^{ \pm}$-structure on $\mathbb{R} F$ from Lemmas 1.6 and 1.7 of 10. The proof becomes then the same as the one of Proposition 3.5 of [19].

## Part II

## Enumerative invariants of strongly semipositive real symplectic manifolds

Throughout this part, we will assume that $\left(X, \omega, c_{X}\right)$ is a strongly semipositive real symplectic manifold of dimension $2 n, n \geq 3$.

## 4 Moduli space of real rational pseudo-holomorphic curves

We recall here the construction of the universal moduli space $\mathbb{R} \mathcal{M}^{d}(\underline{x})$ of real rational pseudoholomorphic curves which realize a given homology class $d$ and pass through a given configuration of points $\underline{x}$, see [13] and [18] for the real case in dimension 4.

Let $d \in H_{2}(X ; \mathbb{Z})$ be such that $\left(c_{X}\right)_{*} d=-d$ and $(n-1) /\left(c_{1}(X) d-2\right)$. Let $k_{d}=$ $\frac{1}{n-1}\left(c_{1}(X) d-2\right)+1$ and $\underline{x}=\left(x_{1}, \ldots, x_{k_{d}}\right) \in X^{k_{d}}$ be a real configuration of $k_{d}$ distinct points. Denote by $\tau \in \sigma_{k_{d}}$ the permutation of $\left\{1, \ldots, k_{d}\right\}$ induced by $c_{X}$ and assume that $\tau(1)=1$ if $n$ is odd, see Lemma 1.3. Let $S$ be an oriented 2 -sphere and $\underline{z}=\left(z_{1}, \ldots, z_{k_{d}}\right)$ be a set of
$k_{d}$ distinct marked points on it. Let $\mathcal{J}_{S}$ be the space of complex structures of class $C^{l}$ on $S$ which are compatible with its orientation, where $l$ is a large enough integer. Likewise, let $\mathcal{J}_{\omega}$ be the space of almost complex structures of class $C^{l}$ of $X$, tamed by $\omega$. Denote by

$$
\mathcal{P}(\underline{x})=\left\{\left(u, J_{S}, J\right) \in L^{k, p}(S, X) \times \mathcal{J}_{S} \times \mathcal{J}_{\omega} \mid u_{*}[S]=d, u(\underline{z})=\underline{x} \text { and } \sigma_{\bar{\partial}}(u)=0\right\}
$$

where $\sigma_{\bar{\partial}}(u)=d u+J \circ d u \circ J_{S}$ is the Cauchy-Riemann section of the $C^{l-k}$ Banach bundle $\mathcal{E}$ over $L^{k, p}(S, X) \times \mathcal{J}_{S} \times \mathcal{J}_{\omega}$ whose fibre over $\left(u, J_{S}, J\right)$ is the separable Banach space $L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes\right.$ $E_{u}$ ), where $E_{u}=u^{*} T X$. Denote by $\mathcal{P}^{*}(\underline{x}) \subset \mathcal{P}(\underline{x})$ the subspace of non-multiple pseudoholomorphic maps. We recall the following Proposition (see Proposition 3.2.1 of [13]).

Proposition 4.1 The space $\mathcal{P}^{*}(x)$ is a separable Banach manifold of class $C^{l-k}$ whose tangent space at $\left(u, J_{S}, J\right) \in \mathcal{P}^{*}(x)$ is the space $T_{\left(u, J_{S}, J\right)} \mathcal{P}^{*}(x)=\left\{\left(v, \dot{J}_{S}, \dot{J}\right) \in L^{k, p}\left(S, E_{u}\right) \times\right.$ $T_{J_{S}} \mathcal{J}_{S} \times T_{J} \mathcal{J}_{\omega} \mid v(\underline{z})=0$ and $\left.\nabla_{\left(v, j_{S}, \dot{J}\right)} \sigma_{\bar{\partial}}=0\right\}$.
Let us fix some $c_{X}$-invariant riemannian metric $g$ on $X$ and denote by $\nabla$ the connection induced on $T X$ as well as on all the assiciated vector bundles. Then, $\nabla_{\left(v, j_{S}, \dot{J}\right)} \sigma_{\bar{\partial}}$ writes $\nabla \sigma_{\bar{\partial}}\left(v, \dot{J}_{S}, \dot{J}\right)=D v+J \circ d u \circ \dot{J}_{S}+\dot{J} \circ d u \circ J_{S}$, where $D$ is the Gromov operator defined by $v \in L^{k, p}\left(S, E_{u}\right) \mapsto D(v)=\nabla v+J \circ \nabla v \circ J_{S}+\left.\nabla_{v} J \circ d u \circ J_{S} \in \mathcal{E}\right|_{\left(u, J_{S}, J\right)}$.

Denote by $\mathcal{D} \operatorname{iff}(S, z)$ the group of diffeomorphisms of class $C^{l+1}$ of $S$, which either preserve the orientation and fix $\underline{z}$, or reverse the orientation and induce the permutation on $\underline{z}$ associated to $\tau$. Let $\operatorname{Diff} f^{+}(S, z)$ (resp. $\mathcal{D i f f} f^{-}(S, z)$ ) be the subgroup of $\operatorname{Diff}(S, z)$ of orientation preserving diffeomorphisms (resp. its complement in $\operatorname{Diff}(S, z)$ ) and $s_{*}$ be the morphism $\mathcal{D}$ iff $(S, z) \rightarrow \mathbb{Z} / 2 \mathbb{Z}$ of kernel $\mathcal{D}$ iff $f^{+}(S, z)$. The group $\operatorname{Diff}(S, z)$ acts on $\mathcal{P}^{*}(x)$ by

$$
\phi \cdot\left(u, J_{S}, J\right)=\left\{\begin{array}{rll}
\left(u \circ \phi^{-1},\left(\phi^{-1}\right)^{*} J_{S}, J\right) & \text { if } & s_{*}(\phi)=+1, \\
\left(c_{X} \circ u \circ \phi^{-1},\left(\phi^{-1}\right)^{*} J_{S}, \overline{c_{X}}(J)\right) & \text { if } & s_{*}(\phi)=-1,
\end{array}\right.
$$

where $\left(\phi^{-1}\right)^{*} J_{S}=s_{*}(\phi) d \phi \circ J_{S} \circ d \phi^{-1}$ and $\overline{c_{X}}{ }^{*}(J)=-d c_{X} \circ J \circ d c_{X}$. The order two elements of $\mathcal{D} i f f^{-}(S, z)$ are the only ones in $\mathcal{D i f f}(S, z) \backslash\{i d\}$ which may have a non-empty fixed point set in $\mathcal{P}^{*}(x)$. In particular, two such involutions have disjoint fixed point sets, compare Lemma 1.3 of 18 . Let $c_{S} \in \mathcal{D}$ iff $(S, z)$ be such an element, we denote by $\mathbb{R} \mathcal{P}^{*}(x)_{c_{S}}$ its fixed locus in $\mathcal{P}^{*}(x)$. Denote by $\mathbb{R} \mathcal{J}_{S}$ (resp. $\mathbb{R} \mathcal{J}_{\omega}$ ) the fixed locus of $c_{S}$ (resp. $c_{X}$ ) in $\mathcal{J}_{S}$ (resp. $\mathcal{J}_{\omega}$ ). Likewise, denote by $L^{k, p}\left(S, E_{u}\right)_{+1}=\left\{v \in L^{k, p}\left(S, E_{u}\right) \mid d c_{X} \circ v \circ c_{S}=v\right\}$ the fixed locus of $c_{S}$ in $L^{k, p}\left(S, E_{u}\right)$. Then, $T_{\left(u, J_{S}, J\right)} \mathbb{R} \mathcal{P}^{*}(x)_{c_{S}}=\left\{\left(v, \dot{J}_{S}, \dot{J}\right) \in L^{k, p}\left(S, E_{u}\right)_{+1} \times T_{J_{S}} \mathbb{R} \mathcal{J}_{S} \times\right.$ $T_{J} \mathbb{R} \mathcal{J}_{\omega} \mid v(\underline{z})=0$ and $\left.\nabla_{\left(v, j_{S}, \dot{j}\right)} \sigma_{\bar{\partial}}=0\right\}$, see Proposition 1.4 of [18]. Note that $\sigma_{\bar{\partial}}$ and $D$ are $\mathcal{D}$ iff $(S, z)$-equivariant so that $D$ induces an operator $D_{\mathbb{R}}: L^{k, p}\left(S, E_{u}\right)_{+1} \rightarrow L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes\right.$ $\left.E_{u}\right)_{+1}=\left\{\alpha \in L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes E_{u}\right) \mid d c_{X} \circ \alpha \circ c_{S}=\alpha\right\}$. Denote by $L^{k, p}\left(S, E_{u,-\underline{z}}\right)_{+1}=\{v \in$ $\left.L^{k, p}\left(S, E_{u}\right)_{+1} \mid v(\underline{z})=0\right\}$ and by $H_{D}^{0}\left(S, E_{u,-\underline{z}}\right)_{+1}\left(\right.$ resp. $\left.H_{D}^{1}\left(S, E_{u,-\underline{z}}\right)_{+1}\right)$ the kernel (resp. cokernel) of the operator $D_{\mathbb{R}}: L^{k, p}\left(S, E_{u,-\underline{z}}\right)_{+1} \rightarrow L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes E_{u}\right)_{+1}$. Remember that this operator $D_{\mathbb{R}}$ induces a quotient operator $\bar{D}_{\mathbb{R}}: L^{k, p}\left(S, E_{u,-\underline{z}}\right)_{+1} / d u\left(L^{k, p}\left(S, T S_{-\underline{z}}\right)_{+1}\right) \rightarrow$ $L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes_{\mathbb{C}} E_{u}\right)_{+1} / d u\left(L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes_{\mathbb{C}} T S\right)_{+1}\right.$ ) (see formula 1.5.1 of [8] or $\S 1.4$ of (18]). Denote by $H_{D}^{0}\left(S, \mathcal{N}_{u,-\underline{z}}\right)_{+1}$ (resp. $\left.H_{D}^{1}\left(S, \mathcal{N}_{u,-\underline{z}}\right)_{+1}\right)$ the kernel (resp. cokernel) of the operator $\bar{D}_{\mathbb{R}}$. Finally, the action of $\mathcal{D} i f f^{+}(S, z)$ on $\mathcal{P}^{*}(x)$ is proper, fixed point free and with closed complements. Denote by $\mathcal{M}^{d}(x)$ the quotient of $\mathcal{P}^{*}(x)$ by the action of $\mathcal{D}$ iff $f^{+}(S, z)$. The projection $\pi:\left(u, J_{S}, J\right) \in \mathcal{P}^{*}(x) \mapsto J \in \mathcal{J}_{\omega}$ induces on the quotient a projection $\mathcal{M}^{d}(x) \rightarrow \mathcal{J}_{\omega}$ still denoted by $\pi$. The manifold $\mathcal{M}^{d}(x)$ is equipped with an action of the group $\operatorname{Diff}(S, \underline{z}) / \mathcal{D}$ iff $f^{+}(S, \underline{z}) \cong \mathbb{Z} / 2 \mathbb{Z}$ which turns $\pi$ into a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant map.

Let us denote by $\mathbb{R} \mathcal{M}^{d}(x)$ the fixed locus of this action and by $\pi_{\mathbb{R}}$ the induced projection $\mathbb{R} \mathcal{M}^{d}(x) \rightarrow \mathbb{R} \mathcal{J}_{\omega}$.

Proposition 4.2 The space $\mathbb{R} \mathcal{M}^{d}(x)$ is a separable Banach manifold of class $C^{l-k}$ and $\pi_{\mathbb{R}}: \mathbb{R} \mathcal{M}^{d}(x) \rightarrow \mathbb{R} \mathcal{J}_{\omega}$ is Fredholm of vanishing index. Moreover, at $\left[u, J_{S}, J\right] \in \mathbb{R} \mathcal{M}^{d}(x)$, the kernel of $\pi_{\mathbb{R}}$ is isomorphic to $H_{D}^{0}\left(S, \mathcal{N}_{u,-\underline{z}}\right)_{+1}$ and its cokernel to $H_{D}^{1}\left(S, N_{u,-\underline{z}}\right)_{+1}$.
The proof of this proposition is the same as the one of Proposition 1.9 of [18]. It is not reproduced here.

## 5 Spinor states of generalized real Cauchy-Riemann operators

Let $\left(u, J_{S}, J\right) \in \mathbb{R} \mathcal{P}^{*}(x)_{c_{S}}$ be such that $u$ is an immersion. The normal bundle $N_{u}=$ $u^{*} T X / d u(T S)$ is equipped with a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant operator $D^{N}: L^{k, p}\left(S, N_{u,-\underline{z}}\right)=\{v \in$ $\left.L^{k, p}\left(S, N_{u}\right) \mid v(\underline{z})=0\right\} \rightarrow L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes N_{u}\right)$. Remember that its complex linear part is some Cauchy-Riemann operator denoted by $\bar{\partial}$ whereas its complex antilinear part is some order zero operator denoted by $R(v)=N_{J}(v, d u()$.$) where N_{J}$ is the Nijenhuis tensor of $J$, see Lemma 1.3.1 of [8]. Such an operator is called a generalized real Cauchy-Riemann operator, it is Fredholm of vanisning index. Denote by $c_{N}$ the complex antilinear involutive morphism induced by $c_{X}$ on the complex vector bundle $N_{u}$. Denote by $\mathbb{R} N_{u}$ (resp. $\mathbb{R} S$ ) the fixed locus of $c_{N}$ (resp. $c_{S}$ ). This vector bundle $\mathbb{R} N_{u}$ over $\mathbb{R} S$ has rank $n-1$ and the riemannian metric $g$ on $\mathbb{R} X$ induces a splitting $u^{*} T \mathbb{R} X=T \mathbb{R} S \oplus \mathbb{R} N_{u}$. We assume that the hypothesis HYP of §1.2.1 hold and equip the associated bundle $M \rightarrow \mathbb{R} X$ with a $\widetilde{G L}_{m}^{ \pm}(\mathbb{R})$-structure. The aim of this paragraph is to define a spinor state for such generalized real Cauchy-Riemann operators when they are isomorphisms. We will begin with standard real Cauchy-Riemann operators in $\S 5.1$ and then extend to generalized ones in $\S 5.2$.

### 5.1 Spinor states of real Cauchy-Riemann operators

Denote by $\mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ the space of Cauchy-Riemann operators of class $C^{l-1}$ on $N_{u}$, it is an affine Banach space spanned by $\Gamma^{l-1}\left(S, \Lambda^{0,1} S \otimes E n d_{\mathbb{C}}\left(N_{u}\right)\right)$, see Appendix $C 1$ of [13]. Denote by $\mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ the sub space of $\mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ made of operators which are $\mathbb{Z} / 2 \mathbb{Z}$-equivariant with respect to the actions of $c_{N}$. For $D \in \mathcal{O} p_{\overline{\bar{b}}}$, we denote by $D_{\underline{z}}$ its restriction to $L^{k, p}\left(S, N_{u,-\underline{z}}\right)$ so that $D_{\underline{z}}$ is Fredholm with vanishing index.

Lemma 5.1 The set of operator $D \in \mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ for which $D_{\underline{z}}$ is an isomorphism is dense open in $\mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$. The set of these operators for which $D_{\underline{z}}$ has a one dimensional cokernel is a one dimensional submanifold of $\mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$. Finally, the set of these operators for which $D_{\underline{z}}$ has a cokernel of dimension greater than one is included in a countable union of strata of codimensions greater than one in $\mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$.

Remember that the space $\mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ (resp. $\left.\mathbb{R} \mathcal{O}_{p \bar{\partial}}\left(N_{u}\right)\right)$ corresponds to the space of holomorphic structures on $N_{u}$ (resp. for which $c_{N}$ is antiholomorphic), see [11]. Let $D \in \mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ such that $D_{\underline{z}}$ is an isomorphism. Such an operator is said to be balanced, since it defines a holomorphic structure on $N_{u}$ such that the isomorphism $N_{u} \cong \mathcal{O}_{S}\left(k_{d}-1\right)^{n-1}$ holds. We can thus define as in 1.2 .2 the spinor state $s p_{\mathfrak{p}, \mathfrak{0}}(D) \in\{ \pm 1\}$ of the balanced operator $D$.

Proposition 5.2 Let $D^{1}, D^{2} \in \mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ be two operators belonging to two adjacent connected components of balanced operators of $\mathbb{R} \mathcal{O}_{p \bar{\partial}}\left(N_{u}\right)$. Then, $s p_{\mathfrak{p}, \mathfrak{o}}\left(D^{1}\right)=-s p_{\mathfrak{p}, \mathfrak{o}}\left(D^{2}\right)$.

## Proof:

Let $D_{0} \in \mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ be an operator in the wall between the two components containing $D_{1}$ and $D_{2}$. In particular, $\operatorname{dim}_{\mathbb{C}} H^{1}\left(S, N_{u} \otimes \mathcal{O}_{S}(-\underline{z})\right)=1$ when $N_{u}$ is equipped with the holomorphic structure induced by $D_{0}$, so that $N_{u} \cong \mathcal{O}_{S}\left(k_{d}-1\right)^{n-3} \oplus \mathcal{O}_{S}\left(k_{d}\right) \oplus \mathcal{O}_{S}\left(k_{d}-2\right)$. Let $U_{0}, U_{1}$ be the standard atlas of $\mathbb{C} P^{1} \cong S$. The holomorphic bundle $N_{u}$ is obtained by gluing the two charts $U_{0} \times \mathbb{C} P^{n-1}$ and $U_{1} \times \mathbb{C} P^{n-1}$ with the help of the gluing map

The operator $D_{0}$ writes in these charts $D_{0}\left(v_{1}, \ldots, v_{n-1}\right)=\left(\bar{\partial} v_{1}, \ldots, \bar{\partial} v_{n-1}\right)$. Let $f: U_{0} \rightarrow \mathbb{C}$ be such that $f(\xi)=\frac{1}{\xi}$ if $|\xi| \geq 1$ and $f(\xi)=\bar{\xi}$ if $|\xi| \leq 1-\epsilon$. We choose $f$ such that $\underline{z}$ is disjoint from the support of $\bar{\partial} f$ and such that $\int_{U_{0}} \bar{\partial} f \wedge d \xi \neq 0$. For $t \in \mathbb{R}$, we set $D_{t}\left(v_{1}, \ldots, v_{n-1}\right)=$ $\left(\bar{\partial} v_{1}, \ldots, \bar{\partial} v_{n-2}, \bar{\partial} v_{n-1}+t \bar{\partial} f \otimes v_{n-2}\right)$. Note that $\left.\frac{d}{d t}\right|_{t=0} D_{t}:\left(v_{1}, \ldots, v_{n-1}\right) \mapsto(0, \ldots, 0, \bar{\partial} f \otimes$ $\left.v_{n-2}\right)$ induces a non-vanishing morphism $H^{0}\left(S ; N_{u} \otimes \mathcal{O}_{S}(-\underline{z})\right) \rightarrow H^{1}\left(S, N_{u} \otimes \mathcal{O}_{S}(-\underline{z})\right)$, since $\int_{U_{0}} \bar{\partial} f \wedge d \xi \neq 0$. Thus, the path $t \in \mathbb{R} \mapsto D_{t} \in \mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ is transversal to the wall of non-balanced operators at $t=0$. Let

and $A_{1}=\operatorname{Id}:\left(\xi,\left(v_{1}, \ldots, v_{n-1}\right)\right) \in U_{1} \times \mathbb{C} P^{n-1} \mapsto\left(\xi,\left(v_{1}, \ldots, v_{n-1}\right)\right) \in U_{1} \times \mathbb{C} P^{n-1}$. This 0 -cochain provides an isomorphism between $N_{u}$ equipped with the operator $D_{t}$ and the holomorphic vector bundle defined by the transition function

0 & t\left(\frac{1}{\xi}\right)^{k_{d}-1} & \left(\frac{1}{\xi}\right)^{k_{d}-2}

We have to prove that for $t \neq 0, s p_{\mathfrak{p}, \mathfrak{o}}\left(D_{t}\right)=-s p_{\mathfrak{p}, \mathfrak{o}}\left(D_{-t}\right)$. For this purpose, we assume that $k_{d}$ is odd, the case $k_{d}$ even can treated in the same way. Let $P: U_{0} \rightarrow \mathbb{C}$ be a polynomial of degree $k_{d}-1$ with real coefficients and no real roots. From the definition of spinor state, the sections $v_{1}=(P, 0, \ldots, 0), \ldots, v_{n-2}=(0, \ldots, 0, \xi P,-t P)$ of $N_{u}$ restricted to $\mathbb{R} S$ can be used to compute this spinor state. Indeed, they generate $n-2$ real holomorphic line sub bundles of degree $k_{d}-1$ of $N_{u}$ which are in direct sum and provide a trivialization of the real loci of these bundles. The choice of the $(n-1)^{\text {th }}$ such line sub bundle being unique up to homotopy, it is not necessary to introduce it. Now it turns out that as $t$ crosses 0 , the section $\left.v_{n-2}\right|_{\mathbb{R} S}$ crosses transversely the zero section of $\mathbb{R} N_{u}$. The loops of the principal bundle of frames of $\mathbb{R} N_{u}$ defined by $\left(v_{1}, \ldots, v_{n-2}\right)$ for $t>0$ and $t<0$ are thus obtained one from another by performing a full twist around the axis generated by $v_{1}, \ldots, v_{n-3}$. The result follows.

### 5.2 Spinor states of generalized real Cauchy-Riemann operators

Denote now by $\mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$ the space of generalized Cauchy-Riemann operators of class $C^{l-1}$ on $N_{u}$, it is an affine Banach space spanned by $\Gamma^{l-1}\left(S, \Lambda^{0,1} S \otimes E n d_{\mathbb{R}}\left(N_{u}\right)\right)$, see Appendix $C 1$ of [13]. Denote by $\mathbb{R} \mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$ the sub space of $\mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$ made of operators which are $\mathbb{Z} / 2 \mathbb{Z}$-equivariant with respect to the actions of $c_{N}$. For $D \in \mathcal{O} p_{\bar{\partial}+R}$, we denote by $D_{\mathbb{R}}^{\underline{\mathbb{R}}}$ the operator $L^{k, p}\left(S, N_{u,-\underline{z}}\right)_{+1} \rightarrow L^{k, p}\left(S, \Lambda^{0,1} S \otimes N_{u}\right)_{+1}$ so that $D_{\mathbb{R}}^{z}$ is Fredholm with vanishing index.

Lemma 5.3 The set of operator $D \in \mathbb{R} \mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$ for which $D_{\mathbb{R}}^{z}$ is an isomorphism is dense open in $\mathbb{R} \mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$. The set of these operators for which $D_{\mathbb{R}}^{z^{2}}$ has a one dimensional cokernel is a one dimensional submanifold of $\mathbb{R} \mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$. Finally, the set of these operators for which $D_{\mathbb{R}}^{Z}$ has a cokernel of dimension greater than one is included in a countable union of strata of codimensions greater than one in $\mathbb{R} \mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$.

Let $D \in \mathbb{R} \mathcal{O}_{\bar{\partial}+R}\left(N_{u}\right)$ be a balanced operator, that is an operator such that $D_{\mathbb{R}}^{z}$ is an isomorphism. Let $\bar{\partial} \in \mathbb{R} \mathcal{O} p_{\bar{\partial}}\left(N_{u}\right)$ be a balanced operator and $\delta: t \in[0,1] \mapsto D_{t} \in \mathbb{R} \mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$ be a generic path joining $\bar{\partial}$ to $D$. Denote by $n_{\delta}$ the number of times this path crosses the wall of non balanced operators given by Lemma 5.3, each crossing being transversal since $\delta$ is generic. Since the determinant line bundle $\operatorname{Det}\left(D_{\mathbb{R}}^{z}\right)=\Lambda^{\max } \operatorname{ker}\left(D_{\mathbb{R}}^{z}\right) \otimes \Lambda^{\max } \operatorname{coker}\left(D_{\mathbb{\mathbb { R }}}^{z}\right)$ is trivial over the affine space $\mathbb{R} \mathcal{O} p_{\bar{\partial}+R}\left(N_{u}\right)$, the parity of $n_{\delta}$ does not depend on $\delta$, see Proposition $A .2 .4$ of [13]. We can then define the spinor state of the balanced operator $D$ to be $s p_{\mathfrak{p}, \mathfrak{o}}(D)=(-1)^{n_{\delta}} s p_{\mathfrak{p} \mathfrak{o}}(\bar{\partial}) \in\{ \pm 1\}$, where $s p_{\mathfrak{p}, \mathfrak{o}}(\bar{\partial})$ has been defined in $\oint 5.1$. It follows from Proposition 5.2 that this spinor state $s p_{\mathfrak{p}, \mathfrak{o}}(D)$ does not depend on the choice of $\bar{\partial}$ we made and hence is well defined.

## 6 Statement of the results

Let $\left(X, \omega, c_{X}\right)$ be a strongly semipositive real symplectic manifold of dimension $2 n, n \geq 3$. Let $d \in H_{2}(X ; \mathbb{Z})$ be such that $\left(c_{X}\right)_{*} d=-d,(n-1) /\left(c_{1}(X) d-2\right)$ and $c_{1}(X) d>2$. Let $k_{d}=\frac{1}{n-1}\left(c_{1}(X) d-2\right)+1$ and $\underline{x}=\left(x_{1}, \ldots, x_{k_{d}}\right) \in X^{k_{d}}$ be a real configuration of $k_{d}$ distinct points. We assume that $\underline{x}$ has at least one real point if $n$ is odd, see Lemma 1.3. We label the connected components of $\mathbb{R} X$ by $(\mathbb{R} X)_{1}, \ldots,(\mathbb{R} X)_{N}$ and set $r_{i}=\#\left(\underline{x} \cap(\mathbb{R} X)_{i}\right), i \in\{1, \ldots, N\}$ as well as $r=\left(r_{1}, \ldots, r_{N}\right)$. Let $J \in \mathbb{R} \mathcal{J}_{\omega}$ be generic enough, so that there are only finitely many connected real rational $J$-holomorphic curves which realize the given homology class $d$ and pass through $\underline{x}$. Moreover, these curves are all irreducible, smooth and have non-empty real part, see Lemma 1.3. Let $h \in H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$, we denote by $\mathcal{R}_{d}(\underline{x}, J, h)$ the finite set of those curves whose real part realize $h$. We assume that the hypothesis HYP of $£ 1.2 .1$ hold and denote by $M \rightarrow \mathbb{R} X$ the given rank $m$ vector bundle. Note that in the fourth case of HYP, that is if $k_{d}$ is even and $n=1 \bmod (4)$, we have to assume that $<w, h>\neq 0$, where $w \in H^{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$ is the given cohomology class, see Remark 1.5. In case $k_{d}$ is even and $n$ is odd, we equip $\left.M\right|_{x_{1}}$ with an orientation $\mathfrak{o}$. This orientation induces an orientation on $\left.M\right|_{\mathbb{R} A}$ for every $A \in \mathcal{R}_{d}(\underline{x}, J, h)$. Note that for every such curve $A \in \mathcal{R}_{d}(\underline{x}, J, h)$, the normal bundle $N_{A}$ comes equipped with a generalized real Cauchy-Riemann operator $D_{A}$ which is balanced since $J$ is generic, see Proposition 4.2. Thus, spinor states of all the elements $A \in \mathcal{R}_{d}(\underline{x}, J, h)$
are well defined, namely as $s p_{\mathfrak{p}, \mathfrak{o}}\left(D_{A}\right)$, see $\$ 5.2$. We set

\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}(\underline{x}, J)=\sum_{A \in \mathcal{R}_{d}(\underline{x}, J, h)} s p_{\mathfrak{p}, \mathfrak{o}}(A) \in \mathbb{Z} .
$$

Theorem 6.1 Let $\left(X, \omega, c_{X}\right)$ be a strongly semipositive real symplectic manifold of dimension $2 n, n \geq 3$. Let $d \in H_{2}(X ; \mathbb{Z})$ be such that $\left(c_{X}\right)_{*} d=-d$, $(n-1) /\left(c_{1}(X) d-2\right)$ and $c_{1}(X) d>2$. Let $k_{d}=\frac{1}{n-1}\left(c_{1}(X) d-2\right)+1$ and $\underline{x}=\left(x_{1}, \ldots, x_{k_{d}}\right) \in X^{k_{d}}$ be a real configuration of $k_{d}$ distinct points with at least one real one if $n$ is odd. Label the connected components of $\mathbb{R} X$ by $(\mathbb{R} X)_{1}, \ldots,(\mathbb{R} X)_{N}$ and set $r_{i}=\#\left(\underline{x} \cap(\mathbb{R} X)_{i}\right), i \in\{1, \ldots, N\}$ as well as $r=\left(r_{1}, \ldots, r_{N}\right)$. Let $h \in H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z})$, assume that the hypothesis HYP of § 1.2 .1 hold and denote by $M \rightarrow \mathbb{R} X$ the given rank $m$ vector bundle. In case $k_{d}$ is even and $n$ is odd, equip $\left.M\right|_{x_{1}}$ with an orientation $\mathfrak{o}$ and if moreover $n=1 \bmod (4)$, assume that $<w, h>\neq 0$. Then, the integer $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}(\underline{x}, J)$ neither depends on the generic choice of $J \in \mathbb{R} \mathcal{J}_{\omega}$ nor on the choice of $\underline{x}$.

See Remark 6.4 below for a comment on the hypothesis of Theorem 6.1. It follows from this theorem that the integer $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}(\underline{x}, J)$ can be denoted by $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}$ without ambiguity. We can even get rid of the orientation $\mathfrak{o}$ from the following (compare Corollary 2.2).

Corollary 6.2 Under the hypothesis of Theorem 6.1, assume that $k_{d}$ is even and $n$ is odd. If the restriction of $M$ over the connected component of $\underline{x} \cap \mathbb{R} X$ in $\mathbb{R} X$ is not orientable, then $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}=0$. In particular, the genus zero Gromov-Witten invariant $G W_{0}(X, d, p t, \ldots, p t)$ is even.

Note that if all the points of $\underline{x} \cap \mathbb{R} X$ are not in the same connected component of $\mathbb{R} X$, then $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}$ vanishes since the real locus of rational curves is connected and thus cannot interpolate points in different connected components. The generating function for this invariant is then some polynomial $\chi^{d, h \mathfrak{p}}(T)=\sum_{r \in \mathbb{N}^{N}} \chi_{r}^{d, h \mathfrak{p}} T^{r} \in \mathbb{Z}\left[T_{1}, \ldots, T_{N}\right]$, where $T^{r}=T_{1}^{r_{1}} \ldots T_{N}^{r_{N}}$ and we have set $\chi_{r}^{d, h \mathfrak{p}}=0$ when it is not well defined. This polynomial has the same parity as $k_{d}$ and each of its monomials $\chi_{r}^{d, h \mathfrak{p}} T^{r}$ only depends on one indeterminate as we just saw. Theorem 6.1 means that the function

\chi^{\mathfrak{p}}:(d, h) \in H^{2}(X ; \mathbb{Z}) \times H_{1}(\mathbb{R} X ; \mathbb{Z} / 2 \mathbb{Z}) \mapsto \chi^{d, h \mathfrak{p}}(T) \in \mathbb{Z}[T]
$$

only depends on the real symplectic manifold ( $X, \omega, c_{X}$ ) and is invariant under strongly semipositive deformation of this real symplectic manifold. This means that if $\omega_{t}$ is a continuous family of strongly semipositive symplectic forms for which $c_{X}^{*} \omega_{t}=-\omega_{t}$, then this function is the same for all triples $\left(X, \omega_{t}, c_{X}\right)$. This invariant immediatly provides the following lower bounds in real enumerative geometry (compare Corollary 2.3).

Corollary 6.3 Under the hypothesis of Theorem 6.1,

$$
\left|\chi_{r}^{d, h \mathfrak{p}}\right| \leq \# \mathcal{R}_{d}(\underline{x}, J, h) \leq N_{d}=G W_{0}(X, d, p t, \ldots, p t)
$$

for every generic $J \in \mathbb{R} \mathcal{J}_{\omega}$ and every $\underline{x} \in X^{k_{d}}$ such that $\underline{x} \cap \mathbb{R} X=r$.

Remark 6.4 Let us end this paragraph with some comments on the hypothesis of Theorem 6.1.

1) The condition $(n-1) /\left(c_{1}(X) d-2\right)$ is a necessary condition for the genus zero GromovWitten invariant $G W_{0}(X, d, p t, \ldots, p t)$ to be non-trivial. This just comes from dimensional reasons since we do consider only point conditions throughout this paper.
2) The strongly semipositive condition as well as the condition $c_{1}(X) d>2$ is made to prevent the appearance of non simple real stable maps in the Gromov compactification of the moduli space of real rational pseudo-holomorphic curves over a generic path in $\mathbb{R} \mathcal{J}_{\omega}$. The treatment of such non simple stable maps requires more involved techniques, see 12] for example. Note that the theory of polyfolds under construction might provide helpful techniques to remove these assumptions, see [5].
3) The hypothesis HYP are topological contitions on degree two characteristic classes of the real locus $\mathbb{R} X$. They are used to define the spinor state of real rational curves which are crucial in the defition of the invariant $\chi^{\mathfrak{p}}$. Can similar invariants be obtained without these topological contitions? I don't know. Note that similar issues appeared in [1] in order to prove the orientability of the moduli space of pseudo-holomorphic discs having boundary in some lagrangian submanifold $L$. There, $L$ was assumed to be relatively spin.
4) The existence of at least one real point in the configuration when $n$ is odd is to prevent the appearance of real rational curves with empty real locus in $\mathcal{R}_{d}(\underline{x}, J, h)$, see Lemma 1.3. For such real rational curves with empty real locus, spinor states are not defined and I cannot obtain similar invariants yet. This subtle problem appears in the important case of CalabiYau threefolds, where $\underline{x}=\emptyset$. I believe however that there should be a way to overcome sometimes this difficulty, but cannot do it yet.

## 7 Proof of Theorem 6.1

Let $J_{0}, J_{1} \in \mathbb{R} \mathcal{J}_{\omega}$ be two generic real almost complex structures, so that the integers $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}\left(\underline{x}, J_{0}\right)$ and $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}\left(\underline{x}, J_{1}\right)$ are well defined. We have to prove that these integers are the same. Let $\gamma: t \in[0,1] \mapsto J_{t} \in \mathbb{R} \mathcal{J}_{\omega}$ be a generic path joining $J_{0}$ to $J_{1}$, transversal to $\pi_{\mathbb{R}}$. Let $\mathbb{R} \mathcal{M}_{\gamma}=\mathbb{R} \mathcal{M}^{d}(\underline{x})^{*} \times_{\gamma}[0,1], \mathbb{R} \overline{\mathcal{M}}_{\gamma}$ be its Gromov compactification and $\pi_{\gamma}: \mathbb{R} \overline{\mathcal{M}}_{\gamma} \rightarrow[0,1]$ be the associated projection. Then $\mathbb{R} \overline{\mathcal{M}}_{\gamma}$ provides a cobordism between $\mathcal{R}_{d}\left(\underline{x}, J_{0}, h\right)$ and $\mathcal{R}_{d}\left(\underline{x}, J_{1}, h\right)$. On each connected component of the complement of both the the critical values of $\pi_{\gamma}$ and the elements of $\pi_{\gamma}\left(\mathbb{R} \overline{\mathcal{M}}_{\gamma} \backslash \mathbb{R} \mathcal{M}_{\gamma}\right)$, the integer $\chi_{r}^{d, h \mathfrak{p}, \mathfrak{o}}\left(\underline{x}, J_{t}\right)$ is constant. We thus just have to prove that this integer also does not change while crossing one of these values. Theorem 6.1 hence follows from Theorems 7.2 and 7.5 .

### 7.1 Generic critical points of $\pi_{\mathbb{R}}$

Lemma 7.1 The space of elements $\left[u, J_{S}, J\right] \in \mathbb{R} \mathcal{M}^{d}(\underline{x})^{*}$ for which $u$ is not an immersion is a sub stratum of codimension $n-1$ of $\mathbb{R} \mathcal{M}^{d}(\underline{x})^{*}$.

## Proof:

This fact was proved in the first part of Proposition 2.7 of [18] when $n=2$-and mainly follows from the results of $\S 3$ of [15]-. The proof being readily the same in higher dimensions, it is not reproduced here.

Let $\gamma: t \in[0,1] \mapsto J_{t} \in \mathbb{R} \mathcal{J}_{\omega}$ be a generic path transversal to $\pi_{\mathbb{R}}$. Let $\mathbb{R} \mathcal{M}_{\gamma}=\mathbb{R} \mathcal{M}^{d}(\underline{x})^{*} \times_{\gamma}$ $[0,1]$ and $\pi_{\gamma}: \mathbb{R} \mathcal{M}_{\gamma} \rightarrow[0,1]$ be the associated projection. From Lemma 7.1 follows that all the elements of $\mathbb{R} \mathcal{M}_{\gamma}$ are immersions.

Theorem 7.2 Let $\left[u_{t_{0}}, J_{S}^{t_{0}}, J_{t_{0}}\right] \in \mathbb{R} \mathcal{M}_{\gamma}$ be a critical point of $\pi_{\gamma}$. Let $\left.\mu: \lambda \in\right]-\epsilon, \epsilon[\mapsto$ $\mu(\lambda) \in \mathbb{R} \mathcal{M}_{\gamma}$ be a local parameterization such that $\mu(0)=\left[u_{t_{0}}, J_{S}^{t_{0}}, J_{t_{0}}\right]$. Then, as soon as $\epsilon$ is small enough, the following alternative holds. Either $\pi_{\gamma} \circ \mu$ crosses $t_{0}$ as $\lambda$ crosses 0 and then $s p_{\mathfrak{p}, \mathfrak{o}}(\mu(\lambda))$ does not depend on $\left.\lambda \in\right]-\epsilon, \epsilon\left[\backslash\{0\}\right.$, or $\pi_{\gamma} \circ \mu$ does not cross $t_{0}$ as $\lambda$ crosses 0 and then $s p_{\mathfrak{p}, \mathfrak{o}}(\mu(\lambda))=-s p_{\mathfrak{p}, \mathfrak{o}}(\mu(-\lambda))$ for every $\left.\lambda \in\right]-\epsilon, \epsilon[\backslash\{0\}$.

## Proof:

Denote by $\mu(\lambda)=\left[u_{\lambda}, J_{S}^{\lambda}, J_{\lambda}\right]$ and fix a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant trivialization $N \rightarrow S$ of the complex normal bundles $N_{u_{\lambda}} \rightarrow S$. We deduce a family of generalized real Cauchy-Riemann operators $D_{\lambda}: L^{k, p}\left(S, N_{-\underline{z}}\right)_{+1} \rightarrow L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes N\right)_{+1}$ parameterized by $\left.\lambda \in\right]-\epsilon, \epsilon[$. Let $E_{0}$ be a closed complement to the one dimensional kernel of $D_{0}$ and for $\left.\lambda \in\right]-\epsilon, \epsilon\left[, F_{\lambda}=\right.$ $D_{\lambda}\left(E_{0}\right)$. Then, $D_{\lambda}$ induces a family of morphisms $\widetilde{D}_{\lambda}: H^{0}=L^{k, p}\left(S, N_{-\underline{z}}\right)_{+1} / E_{0} \rightarrow H_{\lambda}^{1}=$ $L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes N\right)_{+1} / F_{\lambda}$. Note that the one dimensional vector space $H^{0}$ (resp. $H_{\lambda}^{1}$ ) is trivialized by $v_{\lambda}=\frac{d}{d \lambda} u_{\lambda}$ (resp. $\left.\left.\frac{d}{d t} \gamma\right|_{t=\pi_{\gamma} \circ \mu(\lambda)}\right)$, so that the linear maps $\widetilde{D}_{\lambda}$ and $\frac{d}{d \lambda}\left(\pi_{\gamma} \circ\right.$ $\mu)$ get conjugated. More generaly, for every operator $D \in \mathbb{R} \mathcal{O} p_{\bar{\partial}+R}(N)$, denote by $\widetilde{D}$ the induced morphism $L^{k, p}\left(S, N_{-\underline{z}}\right)_{+1} / E_{0} \rightarrow L^{k-1, p}\left(S, \Lambda^{0,1} S \otimes N\right)_{+1} / D\left(E_{0}\right)$. The hypersurface $\mathcal{H}^{1}$ of $\mathbb{R} \mathcal{O} p_{\bar{\partial}+R}(N)$ made of operators having a one dimensional cokernel is defined in a neighbourhood of $D_{0}$ as $\mathcal{H}^{1}=\left\{D \in \mathbb{R} \mathcal{O} p_{\bar{\partial}+R}(N) \mid \widetilde{D}=0\right\}$, see Lemma 5.3. Thus, the curve $\lambda \in]-\epsilon, \epsilon\left[\mapsto D_{\lambda} \in \mathbb{R} \mathcal{O} p_{\bar{\partial}+R}(N)\right.$ crosses $\mathcal{H}^{1}$ at $\lambda=0$ if and only if $\frac{d}{d \lambda}\left(\pi_{\gamma} \circ \mu\right)\left(v_{\lambda}\right)$ crosses $t_{0}$ as $\lambda$ crosses 0 that is if and only if $\pi_{\gamma}$ has a local extremum at $\lambda=0$. Now from Proposition 5.2, if $D_{\lambda}$ crosses $\mathcal{H}^{1}$ at $\lambda=0$, then $\left.s p_{\mathfrak{p}, \mathfrak{o}}\left(D_{\lambda}\right)=-s p_{\mathfrak{p}, \mathfrak{o}}\left(D_{-\lambda}\right), \lambda \in\right]-\epsilon, \epsilon \backslash \backslash\{0\}$, whereas $s p_{\mathfrak{p}, \mathfrak{o}}\left(D_{\lambda}\right)=s p_{\mathfrak{p}, \mathfrak{o}}\left(D_{-\lambda}\right)$ otherwise.

### 7.2 Passing through real reducible curves

Let $\gamma: t \in[0,1] \mapsto J_{t} \in \mathbb{R} \mathcal{J}_{\omega}$ be a generic path transversal to $\pi_{\mathbb{R}}$. Let $\mathbb{R} \mathcal{M}_{\gamma}=\mathbb{R} \mathcal{M}^{d}(\underline{x})^{*} \times_{\gamma}$ $[0,1], \mathbb{R} \overline{\mathcal{M}}_{\gamma}$ be its Gromov compactification and $\pi_{\gamma}: \mathbb{R} \overline{\mathcal{M}}_{\gamma} \rightarrow[0,1]$ be the associated projection.

Lemma 7.3 Under the assumptions of Theorem 6.1, as soon as $\gamma$ is generic enough, $\mathbb{R} \overline{\mathcal{M}}_{\gamma} \backslash \mathbb{R} \mathcal{M}_{\gamma}$ consists of finitely many reducible curves having two irreducible components, both real and embedded, intersecting in a unique real ordinary double point. Moreover, if $d_{1}, d_{2}$ (resp. $k_{1}, k_{2}$ ) denote the homology classes of these components (resp. the number of marked points on them), so that $d_{1}+d_{2}=d$ and $k_{1}+k_{2}=k_{d}$, then either $c_{1}(X) d_{1}-1=(n-1) k_{1}$ and $c_{1}(X) d_{2}-1=(n-1)\left(k_{2}-1\right)$, or $k_{i}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)+1$, where $E()$ denotes the integer part.

## Proof:

From Gromov compactness theorem, elements of $\mathbb{R} \overline{\mathcal{M}}_{\gamma} \backslash \mathbb{R} \mathcal{M}_{\gamma}$ correspond to reducible curves parameterized by a tree of complex spheres. Since the manifold is semipositive, the moduli space of such curves comes with a Fredholm projection onto $\mathcal{J}_{\omega}$ whose Fredholm index is one minus the number of spheres in this tree, see Theorem 6.2.6 of [13]. Note that since marked points are not at singular points of the parameterizing tree and the configuration of
points $\underline{x}$ contains at least one real point, both irreducible components of the reducible curve should be real. The first part of the lemma follows. Now the numerical conditions on $k_{1}, k_{2}$ are obtained exactly in the same way as in the first part of the proof of Proposition 3.1, it is not reproduced here.

Denote by $\mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, d_{2}}(\underline{x})$ the universal moduli space of simple real stable maps having two irreducible components $C_{1}, C_{2}$, both real with $k_{1}, k_{2}$ marked points on them respectively and which realize the homology classes $d_{1}, d_{2}$. Denote by $\pi_{\mathbb{R}}^{d_{1}, d_{2}}$ the index -1 Fredholm projection $\mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, \underline{d_{2}}}(\underline{x}) \rightarrow \mathbb{R} \mathcal{J}_{\omega}$.

Proposition 7.4 Let $\left(u, J_{S}, J\right) \in \mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, d_{2}}(\underline{x})$ be given by Lemma 7.9. Then, there exists a path $\left(J_{\lambda}\right)_{\lambda \in[0,1]}$ in $\mathbb{R} \mathcal{J}_{\omega}$ such that $J_{0}=J,\left(u, J_{S}, J_{\lambda}\right) \in \mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, d_{2}}(\underline{x})$ for every $\lambda \in[0,1]$ and $J_{1}$ is integrable in a neighbourhood of $u\left(C_{1} \cup C_{2}\right)$. Moreover, $J_{1}$ can be chosen in the form 1 or $2 a$ given by Proposition 3.1 depending on whether $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right.$ ) or $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)+1$.

## Proof:

Such an homotopy $\left(J_{\lambda}\right)_{\lambda \in[0,1]}$ can be obtained in the following way. We first stretch the almost complex structure $J$ in a neighbourhood of the double point using a one parameter family of $\mathbb{Z} / 2 \mathbb{Z}$-equivariant diffeomorphisms of $X$ which read as a family of homotheties in a local chart mapping the curve onto two coordinate axis of $\mathbb{C}^{n}$ and mapping $J$ at the singular point onto the complex structure of $\mathbb{C}^{n}$. Having the scale of the homothety converging to $+\infty$, we deduce a homotopy $\left(J_{\lambda}\right)_{\lambda \in\left[0, \frac{1}{2}\right]}$ such that $J_{\frac{1}{2}}$ is integrable in a neighbourhood of the singular point. For every $i \in\{1,2\}$, fix a $\mathbb{Z} / 2 \mathbb{Z}$-equivariant identification of a tubular neighbourhood of $u\left(C_{i}\right)$ in $X$ with a neighbourhood of the zero section in its normal bundle $N_{i}=u^{*} T X / u_{*} T C_{i}$. The latter is equipped with the almost complex structure $J_{\frac{1}{2}}$. We then stretch $J_{\frac{1}{2}}$ using a one parameter family of homotheties in the fibres of $N_{i}$ whose scale converge to $+\infty$. The path of almost complex structures we obtain does converge since the zero section is pseudoholomorphic and we get a homotopy $\left(J_{\lambda}\right)_{\lambda \in\left[\frac{1}{2}, \frac{3}{4}\right]}$ such that $J_{\frac{3}{4}}$ is integrable in a neighbourhood of the singular point and equip $N_{i}$ with the structure of a complex vector bundle. Now, let $J_{1}$ be a holomorphic structure on this complex vector bundle and $\nabla_{1}$ be an associated complex connection. Then, for every $y \in N_{i}, J_{\frac{3}{4}}(y)$ writes $J_{1}(y)+A(y)$ where $A(y) \in \Lambda^{0,1} C_{i} \otimes N_{i}$. We thus set for $\lambda \in\left[\frac{3}{4}, 1\right]$ and $y \in N_{i}, J_{\lambda}(y)=J_{1}(y)+4(1-\lambda) A(y)$. The result follows from the fact that $J_{1}$ can be chosen in the form 1 or $2 a$ given by Proposition 3.1 depending on whether $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)$ or $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)+1$.

Theorem 7.5 Let $\gamma: t \in[0,1] \mapsto J_{t} \in \mathbb{R} \mathcal{J}_{\omega}$ be a generic path transversal to $\pi_{\mathbb{R}}$. Let $\mathbb{R} \mathcal{M}_{\gamma}=\mathbb{R} \mathcal{M}^{d}(\underline{x})^{*} \times_{\gamma}[0,1], \mathbb{R} \overline{\mathcal{M}}_{\gamma}$ be its Gromov compactification and $\pi_{\gamma}: \mathbb{R} \overline{\mathcal{M}}_{\gamma} \rightarrow[0,1]$ be the associated projection. Let $\left(u, J_{S}, J\right) \in \mathbb{R} \overline{\mathcal{M}}_{\gamma} \backslash \mathbb{R} \mathcal{M}_{\gamma}$ be given by Lemma 7.3 and $t_{0}=$ $\left.\pi_{\gamma}\left(u, J_{S}, J\right) \in\right] 0,1\left[\right.$. Then, there exist a neighbourhood $W$ of $\left(u, J_{S}, J\right)$ in $\mathbb{R} \overline{\mathcal{M}}_{\gamma}$ and $\epsilon>0$ such that $\sum_{C \in \pi_{\gamma}^{-1}(t) \cap W} s p_{\mathfrak{p}, \mathfrak{o}}(C)$ does not depend on $\left.t \in\right] t_{0}-\epsilon, t_{0}+\epsilon\left[\backslash\left\{t_{0}\right\}\right.$.

## Proof:

From Lemma 7.3, $\left(u, J_{S}, J\right) \in \mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, d_{2}}(\underline{x})$ with either $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)$ or $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)+1$. From Proposition 7.4, we can assume that $J$ is integrable in a neighbourhood of $u\left(C_{1} \cup C_{2}\right)$ and of the form 1 or $2 a$ of Proposition 3.1 depending
on whether $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)$ or $k_{1}=E\left(\frac{1}{n-1}\left(c_{1}(X) d-2\right)\right)+1$. Indeed, let $\mu$ : $\lambda \in[0,1] \rightarrow\left(u, J_{S}, J_{\lambda}\right) \in \mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, d_{2}}(\underline{x})$ be the path given by this Proposition 3.1. Then, after perturbing $\mu$ if necessary, we can assume that it crosses transversely the critical locus of $\left.\pi_{\mathbb{R}}^{d_{1}, d_{2}}: \mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, \underline{x}}\right) \rightarrow \mathbb{R} \mathcal{J}_{\omega}$ at finitely many points, where the cokernel of $\pi_{\mathbb{R}}^{d_{1}, d_{2}}$ is two dimensional. Outside of these points, $\left.\pi_{\mathbb{R}}^{d_{1}, d_{2}}\right|_{\operatorname{Im}(\mu)}$ is an immersion and thus $\operatorname{Im}\left(\pi_{\mathbb{R}}^{d_{1}, d_{2}}\right)$ is locally a wall which divides $\mathbb{R} \mathcal{J}_{\omega}$ in two connected components. Let $\mathcal{W}$ be a neighbourhood of $\operatorname{Im}(\mu)$ in $\mathbb{R} \overline{\mathcal{M}}^{d}(\underline{x})$. Then, from Theorem 7.2 , as soon as $\mathcal{W}$ is small enough, $\sum_{C \in \pi_{\mathbb{R}}^{-1}(J) \cap \mathcal{W}} s p_{\mathfrak{p}, \mathfrak{o}}(C)$ takes one value on each side of the wall $\operatorname{Im}\left(\pi_{\mathbb{R}}^{d_{1}, d_{2}}\right)$. Now let $\left(u, J_{S}, J_{\frac{1}{2}}\right) \in \mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, d_{2}}(\underline{x})$ be a critical point of $\pi_{\mathbb{R}}^{d_{1}, d_{2}}$ and $J_{\frac{1}{2}} \in D \subset \mathbb{R} \mathcal{J}_{\omega}$ be a closed disc transversal to $\pi_{\mathbb{R}}^{d_{1}, d_{2}}$ at $J_{\frac{1}{2}}$. Then, $\left(\pi_{\mathbb{R}}^{d_{1}, d_{2}}\right)^{-1}(D)$ is a smooth curve of $\mathbb{R} \mathcal{M}_{k_{1}, k_{2}}^{d_{1}, d_{2}}(\underline{x})$ which projects onto a curve of $D$ which is cuspidal at $J_{\frac{1}{2}}$. The connected component of this curve which contains $\left(u, J_{S}, J_{\frac{1}{2}}\right)$ is homeomorphic to an interval whose image curve $B$ intersects $\partial D$ at two points. The complement of these two points in $\partial D$ consists of two intervals $\partial D_{1}$ and $\partial D_{2}$ and once more, from Theorem 7.2 , as soon as $\mathcal{W}$ is small enough, the value $\sum_{C \in \pi_{\mathbb{R}}(J) \cap \mathcal{W}} s p_{\mathfrak{p}, \mathfrak{o}}(C)$ is the same on each of these intervals.


Thus, the value $\sum_{C \in \pi_{\mathbb{R}}^{-1}(J) \cap \mathcal{W}} s p_{\mathfrak{p}, \mathfrak{o}}(C)$ on each side of the wall $\operatorname{Im}\left(\pi_{\mathbb{R}}^{d_{1}, d_{2}}\right)$ is the same at $J_{0}$ and $J_{1}$. To prove Theorem 7.5, we then just have to prove that these values are the same on both sides of the wall at $J_{1}$. Now, to cross this wall, we can fix $J$ and have one real point of the configuration $\underline{x}$ vary since this can be performed equivalently by fixing $\underline{x}$ and producing some Hamiltonian deformation of $J$. The end of the proof thus goes now along the same lines as the one of Theorem 3.4 since all the arguments used there where local.
