# Comparison of Weibull tail-coefficient estimators

#### Abstract

We address the problem of estimating the Weibull tail-coefficient which is the regular variation exponent of the inverse failure rate function. We propose a family of estimators of this coefficient and an associate extreme quantile estimator. Their asymptotic normality are established and their asymptotic mean-square errors are compared. The results are illustrated on some finite sample situations.


## 1 Introduction

Let $X_{1}, X_{2}, \ldots, X_{n}$ be a sequence of independent and identically distributed random variables with cumulative distribution function $F$. We denote by $X_{1, n} \leq \ldots \leq X_{n, n}$ their associated order statistics. We address the problem of estimating the Weibull tail-coefficient $\theta>0$ defined when the distribution tail satisfies
(A.1) $1-F(x)=\exp (-H(x)), x \geq x_{0} \geq 0, H \leftarrow(t)=\inf \{x, H(x) \geq t\}=t^{\theta} \ell(t)$,
where $\ell$ is a slowly varying function i.e.

$$
\ell(\lambda x) / \ell(x) \rightarrow 1 \text { as } x \rightarrow \infty \text { for all } \lambda>0
$$

The inverse cumulative hazard function $H^{\leftarrow}$ is said to be regularly varying at infinity with index $\theta$ and this property is denoted by $H^{\leftarrow} \in \mathcal{R}_{\theta}$, see [7] for more details on this topic. As a comparison, Pareto type distributions satisfy $(1 /(1-F))^{\leftarrow} \in \mathcal{R}_{\gamma}$, and $\gamma>0$ is the so-called extreme value index. Weibull tail-distributions include for instance Gamma, Gaussian and, of course, Weibull distributions.
Let $\left(k_{n}\right)$ be a sequence of integers such that $1 \leq k_{n}<n$ and $\left(T_{n}\right)$ be a positive sequence. We examine the asymptotic behavior of the following family of estimators of $\theta$ :

$$
\begin{equation*}
\hat{\theta}_{n}=\frac{1}{T_{n}} \frac{1}{k_{n}} \sum_{i=1}^{k_{n}}\left(\log \left(X_{n-i+1, n}\right)-\log \left(X_{n-k_{n}+1, n}\right)\right) . \tag{1}
\end{equation*}
$$

Following the ideas of [10], an estimator of the extreme quantile $x_{p_{n}}$ can be deduced from (1) by:

$$
\begin{equation*}
\hat{x}_{p_{n}}=X_{n-k_{n}+1, n}\left(\frac{\log \left(1 / p_{n}\right)}{\log \left(n / k_{n}\right)}\right)^{\hat{\theta}_{n}}=: X_{n-k_{n}+1, n} \tau_{n}^{\hat{\theta}_{n}} \tag{2}
\end{equation*}
$$

Recall that an extreme quantile $x_{p_{n}}$ of order $p_{n}$ is defined by the equation

$$
1-F\left(x_{p_{n}}\right)=p_{n}, \text { with } 0<p_{n}<1 / n .
$$

The condition $p_{n}<1 / n$ is very important in this context. It usually implies that $x_{p_{n}}$ is larger than the maximum observation of the sample. This necessity to extrapolate sample results to areas
where no data are observed occurs in reliability [8], hydrology [20], finance [9],... We establish in Section 2 the asymptotic normality of $\hat{\theta}_{n}$ and $\hat{x}_{p_{n}}$. The asymptotic mean-square error of some particular members of (1) are compared in Section 3. In particular, it is shown that family (1) encompasses the estimator introduced in [12] and denoted by $\hat{\theta}_{n}^{(2)}$ in the sequel. In this paper, the asymptotic normality of $\hat{\theta}_{n}^{(2)}$ is obtained under weaker conditions. Furthermore, we show that other members of family (1) should be preferred in some typical situations. We also quote some other estimators of $\theta$ which do not belong to family (1): [4, 3, 6, 18]. We refer to [12] for a comparison with $\hat{\theta}_{n}^{(2)}$. The asymptotic results are illustrated in Section 4 on finite sample situations. Proofs are postponed to Section 5.

## 2 Asymptotic normality

To establish the asymptotic normality of $\hat{\theta}_{n}$, we need a second-order condition on $\ell$ :
(A.2) There exist $\rho \leq 0$ and $b(x) \rightarrow 0$ such that uniformly locally on $\lambda \geq 1$

$$
\log \left(\frac{\ell(\lambda x)}{\ell(x)}\right) \sim b(x) K_{\rho}(\lambda), \text { when } x \rightarrow \infty
$$

$$
\text { with } K_{\rho}(\lambda)=\int_{1}^{\lambda} u^{\rho-1} d u
$$

It can be shown [11] that necessarily $|b| \in \mathcal{R}_{\rho}$. The second order parameter $\rho \leq 0$ tunes the rate of convergence of $\ell(\lambda x) / \ell(x)$ to 1 . The closer $\rho$ is to 0 , the slower is the convergence. Condition (A.2) is the cornerstone in all proofs of asymptotic normality for extreme value estimators. It is used in $[17,16,5]$ to prove the asymptotic normality of estimators of the extreme value index $\gamma$. Let us introduce the following functions : for $t>0$ and $\rho \leq 0$,

$$
\begin{aligned}
\mu_{\rho}(t) & =\int_{0}^{\infty} K_{\rho}\left(1+\frac{x}{t}\right) \mathrm{e}^{-x} d x \\
\sigma_{\rho}^{2}(t) & =\int_{0}^{\infty} K_{\rho}^{2}\left(1+\frac{x}{t}\right) \mathrm{e}^{-x} d x-\mu_{\rho}^{2}(t)
\end{aligned}
$$

and let $a_{n}=\mu_{0}\left(\log \left(n / k_{n}\right)\right) / T_{n}-1$. As a preliminary result, we propose an asymptotic expansion of $\left(\hat{\theta}_{n}-\theta\right)$ :

Proposition 1 Suppose (A.1) and (A.2) hold. If $k_{n} \rightarrow \infty, k_{n} / n \rightarrow 0, T_{n} \log \left(n / k_{n}\right) \rightarrow 1$ and $k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right) \rightarrow \lambda \in \mathbb{R}$ then,

$$
\begin{aligned}
k_{n}^{1 / 2}\left(\hat{\theta}_{n}-\theta\right) & =\theta \xi_{n, 1}+\theta \mu_{0}\left(\log \left(n / k_{n}\right)\right) \xi_{n, 2}+k_{n}^{1 / 2} \theta a_{n} \\
& +k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right)\left(1+o_{\mathrm{P}}(1)\right),
\end{aligned}
$$

where $\xi_{n, 1}$ and $\xi_{n, 2}$ converge in distribution to a standard normal distribution.
Similar distributional representations exist for various estimators of the extreme value index $\gamma$. They are used in [15] to compare the asymptotic properties of several tail index estimators. In [14], a bootstrap selection of $k_{n}$ is derived from such a representation. It is also possible to derive bias reduction method as in [13]. The asymptotic normality of $\hat{\theta}_{n}$ is a straightforward consequence of Proposition 1.

Theorem 1 Suppose (A.1) and (A.2) hold. If $k_{n} \rightarrow \infty, k_{n} / n \rightarrow 0, T_{n} \log \left(n / k_{n}\right) \rightarrow 1$ and $k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right) \rightarrow \lambda \in \mathbb{R}$ then,

$$
k_{n}^{1 / 2}\left(\hat{\theta}_{n}-\theta-b\left(\log \left(n / k_{n}\right)\right)-\theta a_{n}\right) \xrightarrow{d} \mathcal{N}\left(0, \theta^{2}\right) .
$$

Theorem 1 implies that the Asymptotic Mean Square Error (AMSE) of $\hat{\theta}_{n}$ is given by :

$$
\begin{equation*}
A M S E\left(\hat{\theta}_{n}\right)=\left(\theta a_{n}+b\left(\log \left(n / k_{n}\right)\right)\right)^{2}+\frac{\theta^{2}}{k_{n}} \tag{3}
\end{equation*}
$$

It appears that all estimators of family (1) share the same variance. The bias depends on two terms $b\left(\log \left(n / k_{n}\right)\right)$ and $\theta a_{n}$. A good choice of $T_{n}$ (depending on the function $b$ ) could lead to a sequence $a_{n}$ cancelling the bias. Of course, in the general case, the function $b$ is unknown making difficult the choice of a "universal" sequence $T_{n}$. This is discussed in the next section.
Clearly, the best rate of convergence in Theorem 1 is obtained by choosing $\lambda \neq 0$. In this case, the expression of the intermediate sequence $\left(k_{n}\right)$ is known.

Proposition 2 If $k_{n} \rightarrow \infty, k_{n} / n \rightarrow 0$ and $k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right) \rightarrow \lambda \neq 0$,

$$
k_{n} \sim\left(\frac{\lambda}{b(\log (n))}\right)^{2}=\lambda^{2}(\log (n))^{-2 \rho} L(\log (n))
$$

where $L$ is a slowly varying function.
The "optimal" rate of convergence is thus of order $(\log (n))^{-\rho}$, which is entirely determined by the second order parameter $\rho$ : small values of $|\rho|$ yield slow convergence. The asymptotic normality of the extreme quantile estimator (2) can be deduced from Theorem 1:

Theorem 2 Suppose (A.1) and (A.2) hold. If moreover, $k_{n} \rightarrow \infty, k_{n} / n \rightarrow 0, T_{n} \log \left(n / k_{n}\right) \rightarrow 1$, $k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right) \rightarrow 0$ and

$$
\begin{equation*}
1 \leq \liminf \tau_{n} \leq \limsup \tau_{n}<\infty \tag{4}
\end{equation*}
$$

then,

$$
\frac{k_{n}^{1 / 2}}{\log \tau_{n}}\left(\frac{\hat{x}_{p_{n}}}{x_{p_{n}}}-\tau_{n}^{\theta a_{n}}\right) \xrightarrow{d} \mathcal{N}\left(0, \theta^{2}\right)
$$

## 3 Comparison of some estimators

First, we propose some choices of the sequence $\left(T_{n}\right)$ leading to different estimators of the Weibull tail-coefficient. Their asymptotic distributions are provided, and their AMSE are compared.

### 3.1 Some examples of estimators

- The natural choice is clearly to take

$$
T_{n}=T_{n}^{(1)}=: \mu_{0}\left(\log \left(n / k_{n}\right)\right),
$$

in order to cancel the bias term $a_{n}$. This choice leads to a new estimator of $\theta$ defined by :

$$
\hat{\theta}_{n}^{(1)}=\frac{1}{\mu_{0}\left(\log \left(n / k_{n}\right)\right)} \frac{1}{k_{n}} \sum_{i=1}^{k_{n}}\left(\log \left(X_{n-i+1, n}\right)-\log \left(X_{n-k_{n}+1, n}\right)\right) .
$$

Remarking that

$$
\mu_{\rho}(t)=\mathrm{e}^{t} \int_{1}^{\infty} \mathrm{e}^{-t u} u^{\rho-1} d u
$$

provides a simple computation method for $\mu_{0}\left(\log \left(n / k_{n}\right)\right)$ using the Exponential Integral (EI), see for instance [1], Chapter 5, pages 225-233.

- Girard [12] proposes the following estimator of the Weibull tail-coefficient:

$$
\hat{\theta}_{n}^{(2)}=\sum_{i=1}^{k_{n}}\left(\log \left(X_{n-i+1, n}\right)-\log \left(X_{n-k_{n}+1, n}\right)\right) / \sum_{i=1}^{k_{n}}\left(\log _{2}(n / i)-\log _{2}\left(n / k_{n}\right)\right)
$$

where $\log _{2}(x)=\log (\log (x)), x>1$. Here, we have

$$
T_{n}=T_{n}^{(2)}=: \frac{1}{k_{n}} \sum_{i=1}^{k_{n}} \log \left(1-\frac{\log \left(i / k_{n}\right)}{\log \left(n / k_{n}\right)}\right)
$$

It is interesting to remark that $T_{n}^{(2)}$ is a Riemann's sum approximation of $\mu_{0}\left(\log \left(n / k_{n}\right)\right)$ since an integration by parts yields:

$$
\mu_{0}(t)=\int_{0}^{1} \log \left(1-\frac{\log (x)}{t}\right) d x
$$

- Finally, choosing $T_{n}$ as the asymptotic equivalent of $\mu_{0}\left(\log \left(n / k_{n}\right)\right)$,

$$
T_{n}=T_{n}^{(3)}=: 1 / \log \left(n / k_{n}\right)
$$

leads to the estimator :

$$
\hat{\theta}_{n}^{(3)}=\frac{\log \left(n / k_{n}\right)}{k_{n}} \sum_{i=1}^{k_{n}}\left(\log \left(X_{n-i+1, n}\right)-\log \left(X_{n-k_{n}+1, n}\right)\right) .
$$

For $i=1,2,3$, let us denote by $\hat{x}_{p_{n}}^{(i)}$ the extreme quantile estimator built on $\hat{\theta}_{n}^{(i)}$ by (2). Asymptotic normality of these estimators is derived from Theorem 1 and Theorem 2. To this end, we introduce the following conditions:
(C.1) $k_{n} / n \rightarrow 0$,
(C.2) $\log \left(k_{n}\right) / \log (n) \rightarrow 0$,
(C.3) $k_{n} / n \rightarrow 0$ and $k_{n}^{1 / 2} / \log \left(n / k_{n}\right) \rightarrow 0$.

Our result is the following:
Corollary 1 Suppose (A.1) and (A.2) hold, $k_{n} \rightarrow \infty$ and $k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right) \rightarrow 0$. For $i=1,2,3$ :
i) If (C.i) hold then

$$
k_{n}^{1 / 2}\left(\hat{\theta}_{n}^{(i)}-\theta\right) \xrightarrow{d} \mathcal{N}\left(0, \theta^{2}\right) .
$$

ii) If (C.i) and (4) hold, then

$$
\frac{k_{n}^{1 / 2}}{\log \tau_{n}}\left(\frac{\hat{x}_{p_{n}}^{(i)}}{x_{p_{n}}}-1\right) \xrightarrow{d} \mathcal{N}\left(0, \theta^{2}\right) .
$$

In view of this corollary, the asymptotic normality of $\hat{\theta}_{n}^{(1)}$ is obtained under weaker conditions than $\hat{\theta}_{n}^{(2)}$ and $\hat{\theta}_{n}^{(3)}$, since (C.2) implies (C.1). Let us also highlight that the asymptotic distribution of $\hat{\theta}_{n}^{(2)}$ is obtained under less assumptions than in [12], Theorem 2 , the condition $k_{n}^{1 / 2} / \log \left(n / k_{n}\right) \rightarrow 0$ being not necessary here. Finally, note that, if $b$ is not ultimately zero, condition $k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right) \rightarrow$ 0 implies (C.2) (see Lemma 1).

### 3.2 Comparison of the AMSE of the estimators

We use the expression of the AMSE given in (3) to compare the estimators proposed previously.

Theorem 3 Suppose (A.1) and (A.2) hold, $k_{n} \rightarrow \infty, \log \left(k_{n}\right) / \log (n) \rightarrow 0$ and $k_{n}^{1 / 2} b\left(\log \left(n / k_{n}\right)\right) \rightarrow$ $\lambda \in \mathbb{R}$. Several situations are possible:
i) $b$ is ultimately non-positive. Let us introduce $\alpha=-4 \lim _{n \rightarrow \infty} b(\log n) \frac{k_{n}}{\log k_{n}} \in[0,+\infty]$.

If $\alpha>\theta$, then, for $n$ large enough,

$$
A M S E\left(\hat{\theta}_{n}^{(2)}\right)<A M S E\left(\hat{\theta}_{n}^{(1)}\right)<\operatorname{AMSE}\left(\hat{\theta}_{n}^{(3)}\right)
$$

If $\alpha<\theta$, then, for $n$ large enough,

$$
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(1)}\right)<\min \left(A M S E\left(\hat{\theta}_{n}^{(2)}\right), \operatorname{AMSE}\left(\hat{\theta}_{n}^{(3)}\right)\right)
$$

ii) $b$ is ultimately non-negative. Let us introduce $\beta=2 \lim _{x \rightarrow \infty} x b(x) \in[0,+\infty]$.

If $\beta>\theta$ then, for $n$ large enough,

$$
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(3)}\right)<\operatorname{AMSE}\left(\hat{\theta}_{n}^{(1)}\right)<\operatorname{AMSE}\left(\hat{\theta}_{n}^{(2)}\right)
$$

If $\beta<\theta$ then, for $n$ large enough,

$$
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(1)}\right)<\min \left(A M S E\left(\hat{\theta}_{n}^{(2)}\right), A M S E\left(\hat{\theta}_{n}^{(3)}\right)\right)
$$

It appears that, when $b$ is ultimately non-negative (case ii)), the conclusion does not depend on the sequence $\left(k_{n}\right)$. The relative performances of the estimators is entirely determined by the nature of the distribution: $\hat{\theta}_{n}^{(1)}$ has the best behavior, in terms of AMSE, for distributions close to the Weibull distribution (small $b$ and thus, small $\beta$ ). At the opposite, $\hat{\theta}_{n}^{(3)}$ should be preferred for distributions far from the Weibull distribution.
The case when $b$ is ultimately non-positive (case i)) is different. The value of $\alpha$ depends on $k_{n}$, and thus, for any distribution, one can obtain $\alpha=0$ by choosing small values of $k_{n}$ (for instance $\left.k_{n}=-1 / b(\log n)\right)$ as well as $\alpha=+\infty$ by choosing large values of $k_{n}\left(\right.$ for instance $k_{n}=(1 / b(\log n))^{2}$ as in Proposition 2).

## 4 Numerical experiments

### 4.1 Examples of Weibull tail-distributions

Let us give some examples of distributions satisfying assumptions (A.1) and (A.2).
Absolute Gaussian distribution $\left|\mathcal{N}\left(\mu, \sigma^{2}\right)\right|, \sigma>0$. From [9], Table 3.4.4, we have $H^{\leftarrow}(x)=$ $x^{1 / 2} \ell(x)$ and an asymptotic expansion of the slowly varying function is given by:

$$
\ell(x)=2^{1 / 2} \sigma-\frac{\sigma}{2^{3 / 2}} \frac{\log x}{x}+O(1 / x)
$$

Therefore $\theta=1 / 2, \rho=-1$ and $b(x)=\log (x) /(4 x) . b$ is ultimately positive, which corresponds to case ii) of Theorem 3 with $\beta=+\infty$. Therefore, one always has, for $n$ large enough:

$$
\begin{equation*}
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(3)}\right)<\operatorname{AMSE}\left(\hat{\theta}_{n}^{(1)}\right)<\operatorname{AMSE}\left(\hat{\theta}_{n}^{(2)}\right) \tag{5}
\end{equation*}
$$

Gamma distribution $\Gamma(a, \lambda), a, \lambda>0$. We use the following parameterization of the density

$$
f(x)=\frac{\lambda^{a}}{\Gamma(a)} x^{a-1} \exp (-\lambda x)
$$

From [9], Table 3.4.4, we obtain $H^{\leftarrow}(x)=x \ell(x)$ with

$$
\ell(x)=\frac{1}{\lambda}+\frac{a-1}{\lambda} \frac{\log x}{x}+O(1 / x)
$$

We thus have $\theta=1, \rho=-1$ and $b(x)=(1-a) \log (x) / x$. If $a>1, b$ is ultimately negative, corresponding to case i) of Theorem 3. The conclusion depends on the value of $k_{n}$ as explained in the preceding section. If $a<1, b$ is ultimately positive, corresponding to case ii) of Theorem 3 with $\beta=+\infty$. Therefore, we are in situation (5).

Weibull distribution $\mathcal{W}(a, \lambda), a, \lambda>0$. The inverse failure rate function is $H^{\leftarrow}(x)=\lambda x^{1 / a}$, and then $\ell(x)=\lambda$ for all $x>0$. Therefore $b(x)=0$ and we use the usual convention $\rho=-\infty$. One may apply either i) or ii) of Theorem 3 with $\alpha=\beta=0$ to get for $n$ large enough,

$$
\begin{equation*}
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(1)}\right)<\min \left(A M S E\left(\hat{\theta}_{n}^{(2)}\right), A M S E\left(\hat{\theta}_{n}^{(3)}\right)\right) \tag{6}
\end{equation*}
$$

### 4.2 Numerical results

The finite sample performance of the estimators $\hat{\theta}_{n}^{(1)}, \hat{\theta}_{n}^{(2)}$ and $\hat{\theta}_{n}^{(3)}$ are investigated on 5 different distributions: $\Gamma(0.5,1), \Gamma(1.5,1),|\mathcal{N}(0,1)|, \mathcal{W}(2.5,2.5)$ and $\mathcal{W}(0.4,0.4)$. In each case, $N=200$ samples $\left(\mathcal{X}_{n, i}\right)_{i=1, \ldots, N}$ of size $n=500$ were simulated. On each sample $\left(\mathcal{X}_{n, i}\right)$, the estimates $\hat{\theta}_{n, i}^{(1)}(k)$, $\hat{\theta}_{n, i}^{(2)}(k)$ and $\hat{\theta}_{n, i}^{(3)}(k)$ are computed for $k=2, \ldots, 250$. Finally, the associated Mean Square Error (MSE) plots are built by plotting the points

$$
\left(k, \frac{1}{N} \sum_{i=1}^{N}\left(\hat{\theta}_{n, i}^{(j)}(k)-\theta\right)^{2}\right) j=1,2,3
$$

Figure 1 and Figure 2 illustrate situation (5) corresponding to ultimately positive bias functions. The MSE exactly behave as the AMSE. The case of an ultimately negative bias function is presented on Figure 3 with the $\Gamma(1.5,1)$ distribution. It clearly appears that the MSE associated to $\hat{\theta}_{n}^{(3)}$ is the largest. For small values of $k$, one has $\operatorname{MSE}\left(\hat{\theta}_{n}^{(1)}\right)<\operatorname{MSE}\left(\hat{\theta}_{n}^{(2)}\right)$ and $\operatorname{MSE}\left(\hat{\theta}_{n}^{(1)}\right)>\operatorname{MSE}\left(\hat{\theta}_{n}^{(2)}\right)$ for large value of $k$. This phenomenon is the illustration of the asymptotic result presented in Theorem 3i). Finally, Figure 4 and Figure 5 illustrate situation (6) of asymptotically null bias functions. Note that, the MSE of $\hat{\theta}_{n}^{(1)}$ and $\hat{\theta}_{n}^{(2)}$ are very similar. As a conclusion, it appears that, in all situations, $\hat{\theta}_{n}^{(1)}$ and $\hat{\theta}_{n}^{(2)}$ share a similar behavior, with a small advantage to $\hat{\theta}_{n}^{(1)}$. They provide good results for null and negative bias functions. At the opposite, $\hat{\theta}_{n}^{(3)}$ should be preferred for positive bias functions.

## 5 Proofs

For the sake of simplicity, in the following, we note $k$ for $k_{n}$. We first give some preliminary lemmas. Their proofs are postponed to the appendix.

### 5.1 Preliminary lemmas

We first quote a technical lemma.
Lemma 1 Suppose that $b$ is ultimately non-zero. If $k \rightarrow \infty, k / n \rightarrow 0$ and $k^{1 / 2} b(\log (n / k)) \rightarrow \lambda \in$ $\mathbb{R}$, then $\log (k) / \log (n) \rightarrow 0$.

The following two lemmas are of analytical nature. They provide first-order expansions which will reveal useful in the sequel.

Lemma 2 For all $\rho \leq 0$ and $q \in \mathbb{N}^{*}$, we have

$$
\int_{0}^{\infty} K_{\rho}^{q}\left(1+\frac{x}{t}\right) \mathrm{e}^{-x} d x \sim \frac{q!}{t^{q}} \text { as } t \rightarrow \infty .
$$

Let $a_{n}^{(i)}=\mu_{0}\left(\log \left(n / k_{n}\right)\right) / T_{n}^{(i)}-1$, for $i=1,2,3$.

Lemma 3 Suppose $k \rightarrow \infty$ and $k / n \rightarrow 0$.
i) $T_{n}^{(1)} \log (n / k) \rightarrow 1$ and $a_{n}^{(1)}=0$.
ii) $T_{n}^{(2)} \log (n / k) \rightarrow 1$. If moreover $\log (k) / \log (n) \rightarrow 0$ then $a_{n}^{(2)} \sim \log (k) /(2 k)$.
iii) $T_{n}^{(3)} \log (n / k)=1$ and $a_{n}^{(3)} \sim-1 / \log (n / k)$.

The next lemma presents an expansion of $\hat{\theta}_{n}$.
Lemma 4 Suppose $k \rightarrow \infty$ and $k / n \rightarrow 0$. Under (A.1) and (A.2), the following expansions hold:

$$
\hat{\theta}_{n}=\frac{1}{T_{n}}\left(\theta U_{n}^{(0)}+b(\log (n / k)) U_{n}^{(\rho)}\left(1+o_{\mathrm{P}}(1)\right)\right),
$$

where

$$
U_{n}^{(\rho)}=\frac{1}{k} \sum_{i=1}^{k-1} K_{\rho}\left(1+\frac{F_{i}}{E_{n-k+1, n}}\right), \rho \leq 0
$$

and where $E_{n-k+1, n}$ is the $(n-k+1)$ th order statistics associated to $n$ independent standard exponential variables and $\left\{F_{1}, \ldots, F_{k-1}\right\}$ are independent standard exponential variables and independent from $E_{n-k+1, n}$.

The next two lemmas provide the key results for establishing the asymptotic distribution of $\hat{\theta}_{n}$. Their describe they asymptotic behavior of the random terms appearing in Lemma 4.

Lemma 5 Suppose $k \rightarrow \infty$ and $k / n \rightarrow 0$. Then, for all $\rho \leq 0$,

$$
\mu_{\rho}\left(E_{n-k+1, n}\right) \stackrel{P}{\sim} \sigma_{\rho}\left(E_{n-k+1, n}\right) \stackrel{P}{\sim} \frac{1}{\log (n / k)} .
$$

Lemma 6 Suppose $k \rightarrow \infty$ and $k / n \rightarrow 0$. Then, for all $\rho \leq 0$,

$$
\frac{k^{1 / 2}}{\sigma_{\rho}\left(E_{n-k+1, n}\right)}\left(U_{n}^{(\rho)}-\mu_{\rho}\left(E_{n-k+1, n}\right)\right) \xrightarrow{d} \mathcal{N}(0,1) .
$$

### 5.2 Proofs of the main results

Proof of Proposition 1 - Lemma 6 states that for $\rho \leq 0$,

$$
\frac{k^{1 / 2}}{\sigma_{\rho}\left(E_{n-k+1, n}\right)}\left(U_{n}^{(\rho)}-\mu_{\rho}\left(E_{n-k+1, n}\right)\right)=\xi_{n}(\rho),
$$

where $\xi_{n}(\rho) \xrightarrow{d} \mathcal{N}(0,1)$ for $\rho \leq 0$. Then, by Lemma 4

$$
\begin{aligned}
k^{1 / 2}\left(\hat{\theta}_{n}-\theta\right) & =\theta \frac{\sigma_{0}\left(E_{n-k+1, n}\right)}{T_{n}} \xi_{n}(0)+k^{1 / 2} \theta\left(\frac{\mu_{0}\left(E_{n-k+1, n}\right)}{T_{n}}-1\right) \\
& +k^{1 / 2} b(\log (n / k))\left(\frac{\sigma_{\rho}\left(E_{n-k+1, n}\right)}{T_{n}} \frac{\xi_{n}(\rho)}{k^{1 / 2}}+\frac{\mu_{\rho}\left(E_{n-k+1, n}\right)}{T_{n}}\right)\left(1+o_{\mathrm{P}}(1)\right)
\end{aligned}
$$

Since $T_{n} \sim 1 / \log (n / k)$ and from Lemma 5, we have

$$
\begin{equation*}
k^{1 / 2}\left(\hat{\theta}_{n}-\theta\right)=\theta \xi_{n, 1}+k^{1 / 2} \theta\left(\frac{\mu_{0}\left(E_{n-k+1, n}\right)}{T_{n}}-1\right)+k^{1 / 2} b(\log (n / k))\left(1+o_{\mathrm{P}}(1)\right), \tag{7}
\end{equation*}
$$

where $\xi_{n, 1} \xrightarrow{d} \mathcal{N}(0,1)$. Moreover, a first-order expansion of $\mu_{0}$ yields

$$
\frac{\mu_{0}\left(E_{n-k+1, n}\right)}{\mu_{0}(\log (n / k))}=1+\left(E_{n-k+1, n}-\log (n / k)\right) \frac{\mu_{0}^{(1)}\left(\eta_{n}\right)}{\mu_{0}(\log (n / k))}
$$

where $\left.\eta_{n} \in\right] \min \left(E_{n-k+1, n}, \log (n / k)\right), \max \left(E_{n-k+1, n}, \log (n / k)\right)[$ and

$$
\mu_{0}^{(1)}(t)=\frac{d}{d t} \int_{0}^{\infty} \log \left(1+\frac{x}{t}\right) \mathrm{e}^{-x} d x=: \frac{d}{d t} \int_{0}^{\infty} f(x, t) d x
$$

Since for $t \geq T>0, f(., t)$ is integrable, continuous and

$$
\left|\frac{\partial f(x, t)}{\partial t}\right|=\frac{x}{t^{2}}\left(1+\frac{x}{t}\right)^{-1} \mathrm{e}^{-x} \leq x \frac{\mathrm{e}^{-x}}{T^{2}}
$$

we have that

$$
\mu_{0}^{(1)}(t)=-\int_{0}^{\infty} \frac{x}{t^{2}}\left(1+\frac{x}{t}\right)^{-1} \mathrm{e}^{-x} d x
$$

Then, Lebesgue Theorem implies that $\mu_{0}^{(1)}(t) \sim-1 / t^{2}$ as $t \rightarrow \infty$. Therefore, $\mu_{0}^{(1)}$ is regularly varying at infinity and thus

$$
\frac{\mu_{0}^{(1)}\left(\eta_{n}\right)}{\mu_{0}(\log (n / k))} \stackrel{P}{\sim} \frac{\mu_{0}^{(1)}(\log (n / k))}{\mu_{0}(\log (n / k))} \sim-\frac{1}{\log (n / k)}
$$

Since $k^{1 / 2}\left(E_{n-k+1, n}-\log (n / k)\right) \xrightarrow{d} \mathcal{N}(0,1)$ (see [12], Lemma 1), we have

$$
\begin{equation*}
\frac{\mu_{0}\left(E_{n-k+1, n}\right)}{\mu_{0}(\log (n / k))}=1-\frac{k^{-1 / 2}}{\log (n / k)} \xi_{n, 2}, \tag{8}
\end{equation*}
$$

where $\xi_{n, 2} \xrightarrow{d} \mathcal{N}(0,1)$. Collecting (7), (8) and taking into account that $T_{n} \log (n / k) \rightarrow 1$ concludes the proof.
Proof of Proposition 2 - Lemma 1 entails $\log (n / k) \sim \log (n)$. Since $|b|$ is a regularly varying function, $b(\log (n / k)) \sim b(\log (n))$ and thus, $k^{1 / 2} \sim \lambda / b(\log (n))$.

Proof of Theorem 2 - The asymptotic normality of $\hat{x}_{p_{n}}$ can be deduced from the asymptotic normality of $\hat{\theta}_{n}$ using Theorem 2.3 of [10]. We are in the situation, denoted by (S.2) in the above mentioned paper, where the limit distribution of $\hat{x}_{p_{n}} / x_{p_{n}}$ is driven by $\hat{\theta}_{n}$. Following, the notations of [10], we denote by $\alpha_{n}=k_{n}^{1 / 2}$ the asymptotic rate of convergence of $\hat{\theta}_{n}$, by $\beta_{n}=\theta a_{n}$ its asymptotic bias, and by $\mathcal{L}=\mathcal{N}\left(0, \theta^{2}\right)$ its asymptotic distribution. It suffices to verify that

$$
\begin{equation*}
\log \left(\tau_{n}\right) \log (n / k) \rightarrow \infty \tag{9}
\end{equation*}
$$

To this end, note that conditions (4) and $p_{n}<1 / n$ imply that there exists $0<c<1$ such that

$$
\log \left(\tau_{n}\right)>c\left(\tau_{n}-1\right)>c\left(\frac{\log (n)}{\log (n / k)}-1\right)=c \frac{\log (k)}{\log (n / k)}
$$

which proves (9). We thus have

$$
\frac{k^{1 / 2}}{\log \tau_{n}} \tau_{n}^{-\theta a_{n}}\left(\frac{\hat{x}_{p_{n}}}{x_{p_{n}}}-\tau_{n}^{\theta a_{n}}\right) \xrightarrow{d} \mathcal{N}\left(0, \theta^{2}\right)
$$

Now, remarking that, from Lemma 2, $\mu_{0}(\log (n / k)) \sim 1 / \log (n / k) \sim T_{n}$, and thus $a_{n} \rightarrow 0$ gives the result.

Proof of Corollary 1 - Lemma 3 shows that the assumptions of Theorem 1 and Theorem 2 are verified and that, for $i=1,2,3, k^{1 / 2} a_{n}^{(i)} \rightarrow 0$.

## Proof of Theorem 3 -

i) First, from (3) and Lemma 3 iii), since $b$ is ultimately non-positive,

$$
\begin{equation*}
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(1)}\right)-\operatorname{AMSE}\left(\hat{\theta}_{n}^{(3)}\right)=-\theta\left(a_{n}^{(3)}\right)^{2}\left(\theta+2 \frac{b(\log (n / k))}{a_{n}^{(3)}}\right)<0 \tag{10}
\end{equation*}
$$

Second, from (3),

$$
\begin{equation*}
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(2)}\right)-A M S E\left(\hat{\theta}_{n}^{(1)}\right)=\theta\left(a_{n}^{(2)}\right)^{2}\left(\theta+2 \frac{b(\log (n / k))}{a_{n}^{(2)}}\right) . \tag{11}
\end{equation*}
$$

If $b$ is ultimately non-zero, Lemma 1 entails that $\log (n / k) \sim \log (n)$ and consequently, since $|b|$ is regularly varying, $b(\log (n / k)) \sim b(\log (n))$. Thus, from Lemma 3 ii),

$$
\begin{equation*}
2 \frac{b(\log (n / k))}{a_{n}^{(2)}} \sim 4 b(\log n) \frac{k}{\log (k)} \rightarrow-\alpha . \tag{12}
\end{equation*}
$$

Collecting (10)-(12) concludes the proof of i).
ii) First, (11) and Lemma 3 ii) yields

$$
\begin{equation*}
\operatorname{AMSE}\left(\hat{\theta}_{n}^{(2)}\right)-\operatorname{AMSE}\left(\hat{\theta}_{n}^{(1)}\right)>0 \tag{13}
\end{equation*}
$$

since $b$ is ultimately non-negative. Second, if $b$ is ultimately non-zero, Lemma 1 entails that $\log (n / k) \sim \log (n)$ and consequently, since $|b|$ is regularly varying, $b(\log (n / k)) \sim b(\log (n))$. Thus, observe that in (10),

$$
\begin{equation*}
2 \frac{b(\log (n / k))}{a_{n}^{(3)}} \sim-2 b(\log n)(\log n) \rightarrow-\beta . \tag{14}
\end{equation*}
$$

Collecting (10), (13) and (14) concludes the proof of ii). The case when $b$ is ultimately zero is obtained either by considering $\alpha=0$ in (12), or $\beta=0$ in (14).

## Appendix: proof of lemmas

Proof of Lemma 1 - Remark that, for $n$ large enough,

$$
\left|k^{1 / 2} b(\log (n / k))\right| \leq\left|k^{1 / 2} b(\log (n / k))-\lambda\right|+|\lambda| \leq 1+|\lambda|
$$

and thus, if $b$ is ultimately non-zero,

$$
\begin{equation*}
0 \leq \frac{1}{2} \frac{\log (k)}{\log (n / k)} \leq \frac{\log (1+|\lambda|)}{\log (n / k)}-\frac{\log |b(\log (n / k))|}{\log (n / k)} \tag{15}
\end{equation*}
$$

Since $|b|$ is a regularly varying function, we have that (see [7], Proposition 1.3.6.)

$$
\frac{\log |b(\log (x))|}{\log (x)} \rightarrow 0 \text { as } x \rightarrow \infty
$$

Then, (15) implies $\log (k) / \log (n / k) \rightarrow 0$ which entails $\log (k) / \log (n) \rightarrow 0$.
Proof of Lemma $2-$ Since for all $x, t>0, t K_{\rho}(1+x / t)<x$, Lebesgue Theorem implies that

$$
\lim _{t \rightarrow \infty} \int_{0}^{\infty}\left(t K_{\rho}\left(1+\frac{x}{t}\right)\right)^{q} \mathrm{e}^{-x} d x=\int_{0}^{\infty} \lim _{t \rightarrow \infty}\left(t K_{\rho}\left(1+\frac{x}{t}\right)\right)^{q} \mathrm{e}^{-x} d x=\int_{0}^{\infty} x^{q} \mathrm{e}^{-x} d x=q!
$$

which concludes the proof.

## Proof of Lemma 3 -

i) Lemma 2 shows that $\mu_{0}(t) \sim 1 / t$ and thus $T_{n}^{(1)} \log (n / k) \rightarrow 1$. By definition, $a_{n}^{(1)}=0$.
ii) The well-known inequality $-x^{2} / 2 \leq \log (1+x)-x \leq 0, x>0$ yields

$$
\begin{equation*}
-\frac{1}{2} \frac{1}{\log (n / k)} \frac{1}{k} \sum_{i=1}^{k} \log ^{2}(k / i) \leq \log (n / k) T_{n}^{(2)}-\frac{1}{k} \sum_{i=1}^{k} \log (k / i) \leq 0 \tag{16}
\end{equation*}
$$

Now, since when $k \rightarrow \infty$,

$$
\frac{1}{k} \sum_{i=1}^{k} \log ^{2}(k / i) \rightarrow \int_{0}^{1} \log ^{2}(x) d x=2 \text { and } \frac{1}{k} \sum_{i=1}^{k} \log (k / i) \rightarrow-\int_{0}^{1} \log (x) d x=1
$$

it follows that $T_{n}^{(2)} \log (n / k) \rightarrow 1$. Let us now introduce the function defined on $(0,1]$ by:

$$
f_{n}(x)=\log \left(1-\frac{\log (x)}{\log (n / k)}\right)
$$

We have:

$$
\begin{aligned}
a_{n}^{(2)} & =-\frac{1}{T_{n}^{(2)}}\left(T_{n}^{(2)}-\mu_{0}(\log (n / k))\right)=-\frac{1}{T_{n}^{(2)}}\left(\frac{1}{k} \sum_{i=1}^{k-1} f_{n}(i / k)-\int_{0}^{1} f_{n}(t) d t\right) \\
& =-\frac{1}{T_{n}^{(2)}} \sum_{i=1}^{k-1} \int_{i / k}^{(i+1) / k}\left(f_{n}(i / k)-f_{n}(t)\right) d t+\frac{1}{T_{n}^{(2)}} \int_{0}^{1 / k} f_{n}(t) d t
\end{aligned}
$$

Since

$$
f_{n}(t)=f_{n}(i / k)+(t-i / k) f_{n}^{(1)}(i / k)+\int_{i / k}^{t}(t-x) f_{n}^{(2)}(x) d x
$$

where $f_{n}^{(p)}$ is the $p$ th derivative of $f_{n}$, we have:

$$
\begin{aligned}
a_{n}^{(2)} & =\frac{1}{T_{n}^{(2)}} \sum_{i=1}^{k-1} \int_{i / k}^{(i+1) / k}(t-i / k) f_{n}^{(1)}(i / k) d t \\
& +\frac{1}{T_{n}^{(2)}} \sum_{i=1}^{k-1} \int_{i / k}^{(i+1) / k} \int_{i / k}^{t}(t-x) f_{n}^{(2)}(x) d x d t+\frac{1}{T_{n}^{(2)}} \int_{0}^{1 / k} f_{n}(t) d t=: \Psi_{1}+\Psi_{2}+\Psi_{3}
\end{aligned}
$$

Let us focus first on the term $\Psi_{1}$ :

$$
\begin{aligned}
\Psi_{1} & =\frac{1}{T_{n}^{(2)}} \frac{1}{2 k^{2}} \sum_{i=1}^{k-1} f_{n}^{(1)}(i / k) \\
& =\frac{1}{2 k T_{n}^{(2)}} \int_{1 / k}^{1} f_{n}^{(1)}(x) d x+\frac{1}{2 k T_{n}^{(2)}}\left(\frac{1}{k} \sum_{i=1}^{k-1} f_{n}^{(1)}(i / k)-\int_{1 / k}^{1} f_{n}^{(1)}(x) d x\right) \\
& =\frac{1}{2 k T_{n}^{(2)}}\left(f_{n}(1)-f_{n}(1 / k)\right)-\frac{1}{2 k T_{n}^{(2)}} \sum_{i=1}^{k-1} \int_{i / k}^{(i+1) / k}\left(f_{n}^{(1)}(x)-f_{n}^{(1)}(i / k)\right) d x=: \Psi_{1,1}-\Psi_{1,2} .
\end{aligned}
$$

Since $T_{n}^{(2)} \sim 1 / \log (n / k)$ and $\log (k) / \log (n) \rightarrow 0$, we have:

$$
\Psi_{1,1}=-\frac{1}{2 k T_{n}^{(2)}} \log \left(1+\frac{\log (k)}{\log (n / k)}\right)=-\frac{\log (k)}{2 k}(1+o(1)) .
$$

Furthermore, since, for $n$ large enough, $f_{n}^{(2)}(x)>0$ for $x \in[0,1]$,

$$
\begin{aligned}
O \leq \Psi_{1,2} & \leq \frac{1}{2 k T_{n}^{(2)}} \sum_{i=1}^{k-1} \int_{i / k}^{(i+1) / k}\left(f_{n}^{(1)}((i+1) / k)-f_{n}^{(1)}(i / k)\right) d x=\frac{1}{2 k^{2} T_{n}^{(2)}}\left(f_{n}^{(1)}(1)-f_{n}^{(1)}(1 / k)\right) \\
& =\frac{1}{2 k^{2} T_{n}^{(2)}}\left(-\frac{1}{\log (n / k)}+\frac{k}{\log (n / k)}\left(1+\frac{\log (k)}{\log (n / k)}\right)^{-1}\right) \sim \frac{1}{2 k}=o\left(\frac{\log (k)}{k}\right) .
\end{aligned}
$$

Thus,

$$
\begin{equation*}
\Psi_{1}=-\frac{\log (k)}{2 k}(1+o(1)) . \tag{17}
\end{equation*}
$$

Second, let us focus on the term $\Psi_{2}$. Since, for $n$ large enough, $f_{n}^{(2)}(x)>0$ for $x \in[0,1]$,

$$
\begin{align*}
0 \leq \Psi_{2} & \leq \frac{1}{T_{n}^{(2)}} \sum_{i=1}^{k-1} \int_{i / k}^{(i+1) / k} \int_{i / k}^{(i+1) / k}(t-i / k) f_{n}^{(2)}(x) d x d t \\
& =\frac{1}{2 k^{2} T_{n}^{(2)}}\left(f_{n}^{(1)}(1)-f_{n}^{(1)}(1 / k)\right)=o\left(\frac{\log (k)}{k}\right) \tag{18}
\end{align*}
$$

Finally,

$$
\Psi_{3}=\frac{1}{T_{n}^{(2)}} \int_{0}^{1 / k}-\frac{\log (t)}{\log (n / k)} d t+\frac{1}{T_{n}^{(2)}} \int_{0}^{1 / k}\left(f_{n}(t)+\frac{\log (t)}{\log (n / k)}\right) d t=: \Psi_{3,1}+\Psi_{3,2},
$$

and we have:

$$
\Psi_{3,1}=\frac{1}{\log (n / k) T_{n}^{(2)}} \frac{1}{k}(\log (k)+1)=\frac{\log (k)}{k}(1+o(1)) .
$$

Furthermore, using the well known inequality: $|\log (1+x)-x| \leq x^{2} / 2, x>0$, we have:

\begin{aligned}
\left|\Psi_{3,2}\right| & \leq \frac{1}{2 T_{n}^{(2)}} \int_{0}^{1 / k}\left(\frac{\log (t)}{\log (n / k)}\right)^{2} d t=\frac{1}{2 T_{n}^{(2)}} \frac{1}{k(\log (n / k))^{2}}\left((\log (k))^{2}+2 \log (k)+2\right) \\
& \sim \frac{(\log (k))^{2}}{2 k \log (n / k)}=o\left(\frac{\log (k)}{k}\right)
\end{aligned}
$$

since $\log (k) / \log (n) \rightarrow 0$. Thus,

$$
\begin{equation*}
\Psi_{3}=\frac{\log (k)}{k}(1+o(1)) . \tag{19}
\end{equation*}
$$

We conclude the proof of i) by collecting (17)-(19).
ii) First, $T_{n}^{(3)} \log (n / k)=1$ by definition. Besides, we have

a_{n}^{(3)} & =\frac{\mu_{0}(\log (n / k))}{T_{n}^{(3)}}-1=\log (n / k) \mu_{0}(\log (n / k))-1 \\
& =\int_{0}^{\infty} \log (n / k) \log \left(1+\frac{x}{\log (n / k)}\right) \mathrm{e}^{-x} d x-1 \\
& =\int_{0}^{\infty} x \mathrm{e}^{-x} d x-\frac{1}{2} \int_{0}^{\infty} \frac{x^{2}}{\log (n / k)} \mathrm{e}^{-x} d x-1+R_{n}=-\frac{1}{\log (n / k)}+R_{n},
\end{aligned}
$$

where

$$
R_{n}=\int_{0}^{\infty} \log (n / k)\left(\log \left(1+\frac{x}{\log (n / k)}\right)-\frac{x}{\log (n / k)}+\frac{x^{2}}{2(\log (n / k))^{2}}\right) \mathrm{e}^{-x} d x
$$

Using the well known inequality: $\left|\log (1+x)-x+x^{2} / 2\right| \leq x^{3} / 3, x>0$, we have,

$$
\left|R_{n}\right| \leq \frac{1}{3} \int_{0}^{\infty} \frac{x^{3}}{(\log (n / k))^{2}} \mathrm{e}^{-x} d x=o\left(\frac{1}{\log (n / k)}\right)
$$

which finally yields $a_{n}^{(3)} \sim-1 / \log (n / k)$.
Proof of Lemma 4 - Recall that

\hat{\theta}_{n}=: \frac{1}{T_{n}} \frac{1}{k} \sum_{i=1}^{k-1}\left(\log \left(X_{n-i+1, n}\right)-\log \left(X_{n-k+1, n}\right)\right)
$$

and let $E_{1, n}, \ldots, E_{n, n}$ be ordered statistics generated by $n$ independent standard exponential random variables. Under (A.1), we have

\begin{aligned}
\hat{\theta}_{n} & \stackrel{d}{=} \frac{1}{T_{n}} \frac{1}{k} \sum_{i=1}^{k-1}\left(\log H^{\leftarrow}\left(E_{n-i+1, n}\right)-\log H^{\leftarrow}\left(E_{n-k+1, n}\right)\right) \\
& \stackrel{d}{=} \frac{1}{T_{n}}\left(\theta \frac{1}{k} \sum_{i=1}^{k-1} \log \left(\frac{E_{n-i+1, n}}{E_{n-k+1, n}}\right)+\frac{1}{k} \sum_{i=1}^{k-1} \log \left(\frac{\ell\left(E_{n-i+1, n}\right)}{\ell\left(E_{n-k+1, n}\right)}\right)\right) .
\end{aligned}
$$

Define $x_{n}=E_{n-k+1, n}$ and $\lambda_{i, n}=E_{n-i+1, n} / E_{n-k+1, n}$. It is clear, in view of [12], Lemma 1 that $x_{n} \xrightarrow{P} \infty$ and $\lambda_{i, n} \xrightarrow{P} 1$. Thus, (A.2) yields that uniformly in $i=1, \ldots, k-1$ :

\hat{\theta}_{n} \stackrel{d}{=} \frac{1}{T_{n}}\left(\theta \frac{1}{k} \sum_{i=1}^{k-1} \log \left(\frac{E_{n-i+1, n}}{E_{n-k+1, n}}\right)+\left(1+o_{p}(1)\right) b\left(E_{n-k+1, n}\right) \frac{1}{k} \sum_{i=1}^{k-1} K_{\rho}\left(\frac{E_{n-i+1, n}}{E_{n-k+1, n}}\right)\right)
$$

The Rényi representation of the $\operatorname{Exp}(1)$ ordered statistics (see [2], p. 72) yields

$$
\begin{equation*}
\left\{\frac{E_{n-i+1, n}}{E_{n-k+1, n}}\right\}_{i=1, \ldots, k-1} \stackrel{d}{=}\left\{1+\frac{F_{k-i, k-1}}{E_{n-k+1, n}}\right\}_{i=1, \ldots, k-1}, \tag{20}
\end{equation*}
$$

where $\left\{F_{1, k-1}, \ldots, F_{k-1, k-1}\right\}$ are ordered statistics independent from $E_{n-k+1, n}$ and generated by $k-1$ independent standard exponential variables $\left\{F_{1}, \ldots, F_{k-1}\right\}$. Therefore,

$$
\begin{aligned}
\hat{\theta}_{n} & \stackrel{d}{=} \frac{1}{T_{n}}\left(\theta \frac{1}{k} \sum_{i=1}^{k-1} \log \left(1+\frac{F_{i}}{E_{n-k+1, n}}\right)\right. \\
& \left.+\left(1+o_{p}(1)\right) b\left(E_{n-k+1, n}\right) \frac{1}{k} \sum_{i=1}^{k-1} K_{\rho}\left(1+\frac{F_{i}}{E_{n-k+1, n}}\right)\right) .
\end{aligned}
$$

Remarking that $K_{0}(x)=\log (x)$ concludes the proof.

Proof of Lemma 5 - Lemma 2 implies that,

$$
\mu_{\rho}\left(E_{n-k+1, n}\right) \stackrel{P}{\sim} \frac{1}{E_{n-k+1, n}} \stackrel{P}{\sim} \frac{1}{\log (n / k)},
$$

since $E_{n-k+1, n} / \log (n / k) \xrightarrow{P} 1$ (see [12], Lemma 1). Next, from Lemma 2,

$$
\begin{aligned}
\sigma_{\rho}^{2}\left(E_{n-k+1, n}\right) & =\frac{2}{E_{n-k+1, n}^{2}}\left(1+o_{\mathrm{P}}(1)\right)-\frac{1}{E_{n-k+1, n}^{2}}\left(1+o_{\mathrm{P}}(1)\right) \\
& =\frac{1}{E_{n-k+1, n}^{2}}\left(1+o_{\mathrm{P}}(1)\right)=\frac{1}{(\log (n / k))^{2}}\left(1+o_{\mathrm{P}}(1)\right)
\end{aligned}
$$

which concludes the proof.
Proof of Lemma 6 - Remark that

$$
\begin{aligned}
\frac{k^{1 / 2}}{\sigma_{\rho}\left(E_{n-k+1, n}\right)}\left(U_{n}^{(\rho)}-\mu_{\rho}\left(E_{n-k+1, n}\right)\right) & =\frac{k^{-1 / 2}}{\sigma_{\rho}\left(E_{n-k+1, n}\right)} \sum_{i=1}^{k-1}\left(K_{\rho}\left(1+\frac{F_{i}}{E_{n-k+1, n}}\right)-\mu_{\rho}\left(E_{n-k+1, n}\right)\right) \\
& -k^{-1 / 2} \frac{\mu_{\rho}\left(E_{n-k+1, n}\right)}{\sigma_{\rho}\left(E_{n-k+1, n}\right)} .
\end{aligned}
$$

Let us introduce the following notation:

$$
S_{n}(t)=\frac{(k-1)^{-1 / 2}}{\sigma_{\rho}(t)} \sum_{i=1}^{k-1}\left(K_{\rho}\left(1+\frac{F_{i}}{t}\right)-\mu_{\rho}(t)\right) .
$$

Thus,

\frac{k^{1 / 2}}{\sigma_{\rho}\left(E_{n-k+1, n}\right)}\left(U_{n}^{(\rho)}-\mu_{\rho}\left(E_{n-k+1, n}\right)\right)=S_{n}\left(E_{n-k+1, n}\right)(1+o(1))+o_{\mathrm{P}}(1)
$$

from Lemma 5. It remains to prove that for $x \in \mathbb{R}$,

$$
\mathrm{P}\left(S_{n}\left(E_{n-k+1, n}\right) \leq x\right)-\Phi(x) \rightarrow 0 \text { as } n \rightarrow \infty
$$

where $\Phi$ is the cumulative distribution function of the standard Gaussian distribution. Lemma 2 implies that for all $\varepsilon \in] 0,1\left[\right.$, there exists $T_{\varepsilon}$ such that for all $t \geq T_{\varepsilon}$,

Furthermore, for $x \in \mathbb{R}$,

\begin{aligned}
\mathrm{P}\left(S_{n}\left(E_{n-k+1, n}\right) \leq x\right)-\Phi(x) & =\int_{0}^{T_{\varepsilon}}\left(\mathrm{P}\left(S_{n}(t) \leq x\right)-\Phi(x)\right) h_{n}(t) d t \\
& +\int_{T_{\varepsilon}}^{\infty}\left(\mathrm{P}\left(S_{n}(t) \leq x\right)-\Phi(x)\right) h_{n}(t) d t=: A_{n}+B_{n}
\end{aligned}
$$

where $h_{n}$ is the density of the random variable $E_{n-k+1, n}$. First, let us focus on the term $A_{n}$. We have,

$$
\left|A_{n}\right| \leq 2 \mathrm{P}\left(E_{n-k+1, n} \leq T_{\varepsilon}\right)
$$

Since $E_{n-k+1, n} / \log (n / k) \xrightarrow{P} 1$ (see [12], Lemma 1), it is easy to show that $A_{n} \rightarrow 0$. Now, let us consider the term $B_{n}$. For the sake of simplicity, let us denote:

\left\{Y_{i}=K_{\rho}\left(1+\frac{F_{i}}{t}\right)-\mu_{\rho}(t), i=1, \ldots, k-1\right\} .
$$

Clearly, $Y_{1}, \ldots, Y_{k-1}$ are independent, identically distributed and centered random variables. Furthermore, for $t \geq T_{\varepsilon}$,

\begin{aligned}
\mathbb{E}\left(\left|Y_{1}\right|^{3}\right) & \leq \mathbb{E}\left(\left(K_{\rho}\left(1+\frac{F_{1}}{t}\right)+\mu_{\rho}(t)\right)^{3}\right) \\
& =\mathbb{E}\left(\left(K_{\rho}\left(1+\frac{F_{1}}{t}\right)\right)^{3}\right)+\left(\mu_{\rho}(t)\right)^{3}+3 \mathbb{E}\left(\left(K_{\rho}\left(1+\frac{F_{1}}{t}\right)\right)^{2}\right) \mu_{\rho}(t) \\
& +3 \mathbb{E}\left(K_{\rho}\left(1+\frac{F_{1}}{t}\right)\right)\left(\mu_{\rho}(t)\right)^{2} \\
& \leq \frac{1}{t^{3}} C_{1}(q, \varepsilon)<\infty
\end{aligned}
$$

from (21) where $C_{1}(q, \varepsilon)$ is a constant independent of $t$. Thus, from Esseen's inequality (see [19], Theorem 3), we have:

$$
\sup _{x}\left|\mathrm{P}\left(S_{n}(t) \leq x\right)-\Phi(x)\right| \leq C_{2} L_{n},
$$

where $C_{2}$ is a positive constant and

$$
L_{n}=\frac{(k-1)^{-1 / 2}}{\left(\sigma_{\rho}(t)\right)^{3}} \mathbb{E}\left(\left|Y_{1}\right|^{3}\right) .
$$

From (21), since $t \geq T_{\varepsilon}$,

$$
\left(\sigma_{\rho}(t)\right)^{2}=\mathbb{E}\left(\left(K_{\rho}\left(1+\frac{F_{1}}{t}\right)\right)^{2}\right)-\left(\mathbb{E}\left(K_{\rho}\left(1+\frac{F_{1}}{t}\right)\right)\right)^{2} \geq \frac{1}{t^{2}} C_{3}(\varepsilon)
$$

where $C_{3}(\varepsilon)$ is a constant independent of $t$. Thus, $L_{n} \leq(k-1)^{-1 / 2} C_{4}(q, \varepsilon)$ where $C_{4}(q, \varepsilon)$ is a constant independent of $t$, and therefore

$$
\left|B_{n}\right| \leq C_{4}(q, \varepsilon)(k-1)^{-1 / 2} \mathrm{P}\left(E_{n-k+1, n} \geq T_{\varepsilon}\right) \leq C_{4}(q, \varepsilon)(k-1)^{-1 / 2} \rightarrow 0
$$

which concludes the proof.
