# RANDOM SERIES OF FUNCTIONS AND APPLICATIONS

#### Abstract

In this article we study the continuity properties of trajectories for some random series of functions, $\sum_{k=0}^{\infty} a_{k} f\left(\alpha X_{k}(\omega)\right)$ where $\left(a_{k}\right)_{k \geqslant 0}$ is a complex sequence, $\left(X_{k}\right)_{k \geqslant 0}$ is a sequence of real independent random variables, $f$ is a real valued function with period one and summable Fourier coefficients. We obtain almost sure continuity results for these periodic or almost periodic series for a large class of functions $f$, where the "almost sure" does not depend on the function. The proof relies on gaussian randomization. We show optimality of the results in some cases.


## SERIES DE FONCTIONS ALEATOIRES ET APPLICATIONS


#### Abstract

Résumé) Dans ce travail, nous étudions des propriétés de continuité de trajectoires de séries de fonctions aléatoires du type $\sum_{k=0}^{\infty} a_{k} f\left(\alpha X_{k}(\omega)\right)$ où $\left(a_{k}\right)_{k \geqslant 0}$ est une suite de nombres complexes, $\left(X_{k}\right)_{k \geqslant 0}$ une suite de variables aléatoires réelles et indépendantes, $f$ une fonction 1-périodique à coefficients de Fourier sommables. Nous montrons que, presque sûrement, ces séries de fonctions aléatoires (périodiques ou presque périodiques) sont à trajectoires continues pour une grande classe de fonctions $f$. Le "presque sûr" est indépendant de $f$. Les preuves s'appuient sur un procédé de randomisation gaussien. Dans certains cas, nous montrerons l'optimalité des résultats obtenus.

## 1. Introduction. Main results

In (1], Berkes studies the almost sure convergence of series defined by :

$$
\sum_{k \geqslant 1} a_{k} f\left(\alpha n_{k}\right)
$$

where the sequence $\left(n_{k}\right)$ is lacunary and the function $f$ verifies :

$$
f(x+1)=f(x) \quad \int_{0}^{1} f(x) d x=0 \quad \int_{0}^{1} f^{2}(x) d x=1
$$

He shows that the important property of $f$ to ensure the almost sure convergence is $f \in \operatorname{Lip}(\gamma)$ with $\gamma>1 / 2$ and $\sum_{k \geqslant 1}\left|a_{k}\right|^{2}<+\infty$. In his case, the $n_{k}$ are strictly lacunary, more precisely, they satisfy the Hadamard gap condition :

$$
\frac{n_{k+1}}{n_{k}} \geqslant q>1
$$

We can naturally adress the question whether the convergence still holds when $n_{k}$ is polynomial, and for which class of functions. We are going to answer the question when the sequence $\left(n_{k}\right)$ is randomly generated.
Let us mention that the result exists when $\left(n_{k}\right)$ is a deterministic polynomial sequence and $\left(a_{k}\right)$ is randomly distributed (see [5] and [6]).
We want to study the convergence properties of series of functions sampled by a random process. More precisely, consider the torus $\mathbb{T}=\mathbb{R} / \mathbb{Z}$ and define $A(\mathbb{T})$ as the set of complex valued functions whose Fourier coefficients are absolutely summable :

A(\mathbb{T})=\left\{f: \mathbb{T} \rightarrow \mathbb{C}, f(\alpha)=\sum_{j \in \mathbb{Z}} \hat{f}(j) \exp (2 i \pi \alpha j), \sum_{j \in \mathbb{Z}}|\hat{f}(j)|<+\infty\right\}
$$

$\left(a_{k}\right)_{k \geqslant 0}$ will denote a sequence of real numbers and $\left(X_{k}\right)_{k \geqslant 0}$ a sequence of independent real random variables defined on the probabilised space $(\Omega, \mathcal{A}, \mathbb{P})$. Our aim is to study the convergence, when $\omega \in \Omega$ is fixed, of the series of functions
$\forall \alpha \in \mathbb{R}$,

$$
F(\alpha, \omega)=\sum_{k=0}^{\infty} a_{k} f\left(\alpha X_{k}(\omega)\right)
$$

Is it possible to give conditions on the sequence $\left(a_{k}\right)_{k \geqslant 0}$ in order to find a $\mathcal{A}$-measurable set $\Omega_{0}$ independent of the function $f$, such that $\mathbb{P}\left(\Omega_{0}\right)=1$, on which the series uniformly converges?
Note that when $X_{k}$ does not take integer values, $F$ is not a periodical function of the torus. For us, $\alpha$ will be real and we will deal with this "almost periodical" case. That is why we have to study the properties of $F$ on a compact $[-M, M]$ and not only $[0,1]$ (see for example [3])
For all $f \in A(\mathbb{T})$, define

$$
\|f\|:=\sum_{j \in \mathbb{Z}}|\hat{f}(j)|<+\infty
$$

$$
|||f|||:=\sum_{j \in \mathbb{Z}}|\hat{f}(j)| \sqrt{\log (|j|+3)}<+\infty .
$$

and

$$
B(\mathbb{T})=\left\{f: \mathbb{T} \rightarrow \mathbb{C}, f(\alpha)=\sum_{j \in \mathbb{Z}} \hat{f}(j) \exp (2 i \pi \alpha j),\|||f| \|<+\infty\}\right.
$$

Remark that $B(\mathbb{T}) \subset A(\mathbb{T})$.
In the following, we will give conditions for $\alpha \mapsto F(\alpha, \omega)$ to have continuous trajectories $\mathbb{P}$-almost surely.
We will denote by $\varphi_{X}$ the characteristic function of the random variable $X$

$$
\forall t \in \mathbb{R}, \varphi_{X}(t)=\mathbb{E}\left(e^{2 i \pi t X}\right)
$$

Theorem 1.1. Let $\left(X_{k}\right)_{k \geqslant 0}$ be a sequence of independent real valued random variables and let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of complex numbers such that, for any compact $K$ which does not contain 0 :

\begin{equation*}
\forall \varepsilon>0, \exists N>0, \sup _{m>n \geqslant N} \sup _{\alpha \in K} \sup _{j \in \mathbb{Z}-\{0\}}\left|\sum_{k=n}^{m} a_{k} \varphi_{X_{k}}(j \alpha)\right|<\varepsilon . \tag{H}
\end{equation*}
$$

Assume moreover that:
case 1:(polynomial) there exists $\beta>0$ and $d>0$ with $\mathbb{E}\left|X_{k}\right|^{\beta}=\mathcal{O}\left(k^{d}\right)$ and

\sum_{n \geqslant 1} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n \sqrt{\log n}}<+\infty \tag{1}
\end{equation*}
$$

case 2:(subexponential) there exists $\beta>0$ and $\gamma \in] 0,1\left[\right.$ with $\mathbb{E}\left|X_{k}\right|^{\beta}=$ $\mathcal{O}\left(2^{k^{\gamma \gamma}}\right)$ and

$$
\begin{equation*}
\sum_{n \geqslant 1} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n^{1-\frac{x}{2}}}<+\infty \tag{2}
\end{equation*}
$$

then in both cases, there exists a measurable set $\Omega_{0}$ with $\mathbb{P}\left(\Omega_{0}\right)=1$ such that for all $\omega \in \Omega_{0}$, for any $f \in B(\mathbb{T})$ such that $\int_{\mathbb{T}} f(t) d t=0$ : for $\alpha \in \mathbb{R}-\{0\}$, $F(\alpha, \omega)$ is well defined, $\alpha \mapsto F(\alpha, \omega)$ is continuous and the series defining $F$ converges uniformly on every compact which does not contain $\{0\}$.

## Remark 1.1.

(1) It is worth noticing that the set $\Omega_{0}$ does not depend on the class of functions $f(A(\mathbb{T})$ or $B(\mathbb{T}))$.
(2) when $\left(X_{k}\right)_{k \geqslant 0}$ takes integer values, condition $\|\|f\|\|<\infty$ becomes $\|f\|<\infty$.
(3) we will give conditions on the law of the process $\left(X_{k}\right)_{k \geqslant 0}$ to fulfill hypothesis $(\mathcal{H})$.
(4) For example, when $\left|a_{k}\right|=\mathcal{O}\left(k^{-\delta}\right)$, in case 1 , if $\delta>1 / 2$, then condition $\square$ holds and in case 2, if $\delta>\frac{\gamma+1}{2}$, then condition $\sigma^{2}$ holds.
(5) Concerning case 2, if $\gamma \geqslant 1$ ( $\mathbb{E}\left|X_{k}\right|^{\beta}$ growths exponentially), one can prove using remark 2.1 that the series $\sum a_{k}$ has to converge. The function $F$ is then obviously well defined using only Cauchy Schwarz inequality.

In case condition $(\mathcal{H})$ is hard to check, it is possible to split up the hypothesis on the sequence $\left(a_{k}\right)$ and the characteristic function $\varphi_{X_{k}}$ either using Abel's summation method or using Cauchy Schwarz inequality.
Define:

$$

n^{\frac{\gamma}{2}} & \text { in the subexponential case }
\end{array}\right.
$$

Corollary 1.2. Let $\left(X_{k}\right)_{k \geqslant 0}$ be a sequence of independent real valued random variables

Assume that, for any compact $K$ which does not contain 0 :

$$
\sup _{N \geqslant 1} \sup _{\alpha \in K} \sup _{j \in \mathbb{Z}-\{0\}}\left|\sum_{k=0}^{N} \varphi_{X_{k}}(j \alpha)\right|<\infty .
$$

Let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of complex numbers enjoying the following properties
(1) $\sum_{n \geqslant 1} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n c_{n}}<+\infty$
(2) $\sum_{k \geqslant 1}\left|a_{k}-a_{k+1}\right|$ converges
then there exists a measurable set $\Omega_{0}$ with $\mathbb{P}\left(\Omega_{0}\right)=1$ such that for all $\omega \in \Omega_{0}$, for any $f \in B(\mathbb{T})$ such that $\int_{\mathbb{T}} f(t) d t=0$ : for $\alpha \in \mathbb{R}-\{0\}$, $F(\alpha, \omega)$ is well defined, $\alpha \mapsto F(\alpha, \omega)$ is continuous and the series defining $F$ converges uniformly on every compact which does not contain $\{0\}$.

Corollary 1.3. Let $\left(X_{k}\right)_{k \geqslant 0}$ be a sequence of independent real valued random variables

Assume that, for any compact $K$ which does not contain 0 :
$\left(\mathcal{H}^{\prime \prime}\right) \quad \forall \varepsilon>0, \exists N>0, \sup _{m>n \geqslant N} \sup _{\alpha \in K} \sup _{j \in \mathbb{Z}-\{0\}}\left(\sum_{k=n}^{m}\left|\varphi_{X_{k}}(j \alpha)\right|^{2}\right)<\varepsilon$.
Let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of complex numbers enjoying

$$
\sum_{n \geqslant 1} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n c_{n}}<+\infty
$$

then there exists a measurable set $\Omega_{0}$ with $\mathbb{P}\left(\Omega_{0}\right)=1$ such that for all $\omega \in \Omega_{0}$, for any $f \in B(\mathbb{T})$ such that $\int_{\mathbb{T}} f(t) d t=0$ : for $\alpha \in \mathbb{R}-\{0\}$, $F(\alpha, \omega)$ is well defined, $\alpha \mapsto F(\alpha, \omega)$ is continuous and the series defining $F$ converges uniformly on every compact which does not contain $\{0\}$.

## Remark 1.2.

The previous corollaries will be useful for example when the law of $X_{k}$ is obtained by convolution product (see corollary 4.2). As the condition
$\sum_{k \geqslant 1}\left|a_{k}-a_{k+1}\right|$ is often hard to check, corollary 1.3 is sometimes better to
The proof of theorem 1.1 will start by looking separately at $F(\alpha, \omega)-$ $\mathbb{E}(F(\alpha,)$.$) and \mathbb{E}(F(\alpha,)$.$) . It turns out that hypothesis (\mathcal{H})$ will be used only to deal with the expectation. That is why we think interesting to state the result for:

$$
F(\alpha, \omega)-\mathbb{E}(F(\alpha, .)):=\sum_{k} a_{k}\left[f \left(\alpha X_{k}(\omega)-\mathbb{E}\left(f\left(\alpha X_{k}\right)\right)\right.\right.
$$

Theorem 1.4. Let $\left(X_{k}\right)_{k \geqslant 0}$ be a sequence of independent real valued random variables such that there exists $\beta>0$ and $d>0$ with $\mathbb{E}\left|X_{k}\right|^{\beta}=\mathcal{O}\left(k^{d}\right)$ or $\gamma \in] 0,1\left[\right.$ with $\mathbb{E}\left|X_{k}\right|^{\beta}=\mathcal{O}\left(2^{k^{\gamma}}\right)$. Let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of complex numbers enjoying the following property

$$
\sum_{n \geqslant 1} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n c_{n}}<+\infty
$$

then there exists a measurable set $\Omega_{0}$ with $\mathbb{P}\left(\Omega_{0}\right)=1$ such that for all $\omega \in \Omega_{0}$, for any $f \in B(\mathbb{T})$ such that $\int_{\mathbb{T}} f(t) d t=0:$ for $\alpha \in \mathbb{R}, F(\alpha, \omega)-\mathbb{E}(F(\alpha,)$. is well defined, $\alpha \mapsto F(\alpha, \omega)-\mathbb{E}(F(\alpha,)$.$) is continuous, the series defining$ $F-\mathbb{E}(F)$ converges uniformly on every compact and there exists $C_{\omega}>0$ such that for all $\alpha \in \mathbb{R}$ :

$$
|F(\alpha, \omega)-\mathbb{E}(F(\alpha, .))| \leqslant C_{\omega}| ||f|| | \sqrt{\log (|\alpha|+2)}
$$

## Remark 1.3.

(1) We also discuss the optimality of hypothesis on $\left(a_{k}\right)$ of theorem 1.4 in section 2.
(2) We also have:

$$
\mathbb{E} \sup _{T>1} \frac{\sqrt{\int_{0}^{T}|F(t, \omega)-\mathbb{E}(F(t, .))|^{2} d t}}{\sqrt{T \log T}}<\infty
$$

This result relies on uniform estimations of the size of some trigonometric polynomials, more precisely on the following :
Recall that $\log ^{+}=\max (\log , 0)$.
Theorem 1.5. Let $\lambda$ and $\Lambda$ be two integers with $\lambda \leqslant \Lambda,\left(X_{k}\right)_{k \geqslant 0}$ be a sequence of independent real valued random variables such that there exists $\beta>0$ such that, $\forall N \geqslant 0, \mathbb{E}\left|X_{N}^{\beta}\right|<\infty$. Define

$$
\forall N \geqslant 0, \Phi_{\beta}(N)=2+\max \left(N, \mathbb{E}\left|X_{N}^{\beta}\right|\right)
$$

Let $M \geqslant 1$ and $I_{M}=[-M, M]$. Let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of real or complex numbers.

Define

$$
A_{\lambda, \Lambda, M}=\sqrt{\log \left(M \Phi_{\beta}(\Lambda)\right) \sum_{k=\lambda}^{\Lambda}\left|a_{k}\right|^{2}}
$$

then

$$
\mathbb{E} \sup _{j \in \mathbb{Z}} \sup _{\lambda \geqslant 1} \sup _{\Lambda \geqslant \lambda} \sup _{\alpha \in I_{M}}\left|\frac{\sum_{k=\lambda}^{\Lambda} a_{k}\left[\exp 2 i \pi \alpha j X_{k}(\omega)-\mathbb{E} \exp 2 i \pi \alpha j X_{k}\right]}{\sqrt{A_{\lambda, \Lambda, M}^{2} \log (|j|+3)}}\right|<\infty
$$

Remark 1.4. When $\left(X_{k}\right)_{k \geqslant 0}$ takes integer values, the proof of theorem 1.5 is easier. Namely, using the fact that $\alpha \mapsto j \alpha(\bmod 1)$ is onto for $j \neq 0$, we get

$$
\begin{array}{r}
\sup _{j \in \mathbb{Z}^{*}} \sup _{\alpha \in \mathbb{T}}\left|\sum_{k=\lambda}^{\Lambda} a_{k}\left[\exp 2 i \pi \alpha j X_{k}(\omega)-\mathbb{E} \exp 2 i \pi \alpha j X_{k}\right]\right| \\
=\sup _{\alpha \in \mathbb{T}}\left|\sum_{k=\lambda}^{\Lambda} a_{k}\left[\exp 2 i \pi \alpha X_{k}(\omega)-\mathbb{E} \exp 2 i \pi \alpha X_{k}\right]\right|
\end{array}
$$

the result of theorem 1.5 becomes then :

$$
\mathbb{E} \sup _{\lambda \geqslant 1} \sup _{\Lambda \geqslant \lambda} \sup _{\alpha \in I_{M}}\left|\frac{\sum_{k=\lambda}^{\Lambda} a_{k}\left[\exp 2 i \pi \alpha X_{k}(\omega)-\mathbb{E} \exp 2 i \pi \alpha X_{k}\right]}{\sqrt{A_{\lambda, \Lambda, M}^{2}}}\right|<\infty
$$

When $\left(X_{k}\right)_{k \geqslant 1}$ takes real values, the proof is more tedious. It relies on a fine inequality about decoupling gaussian random functions (see section 3.). We can see here why, for integer-valued $X_{k}$, we can work with the functional space $A(\mathbb{T})$, whereas for real-valued $X_{k}$, we need to introduce the space $B(\mathbb{T})$.

## 2. Proof of theorem 1.1 and corollary 1.2

First, we split $F$ into two parts as follows :

$$
\sum_{k} a_{k} f\left(\alpha X_{k}(\omega)\right)=\sum_{k} a_{k}\left[f \left(\alpha X_{k}(\omega)-\mathbb{E}\left(f\left(\alpha X_{k}\right)\right)+\sum_{k} a_{k} \mathbb{E}\left(f\left(\alpha X_{k}\right)\right)\right.\right.
$$

-Step 1 : (first part of the sum)
Let $\left(N_{k}\right)_{k \geqslant 1}$ be a strictly increasing sequence of integers and define
$\forall k \geqslant 1, \quad P_{k}(\alpha)=\sum_{l=N_{k}+1}^{N_{k+1}} a_{l}\left[f\left(\alpha X_{l}(\omega)\right)-\mathbb{E} f\left(\alpha X_{l}\right)\right]$
where $f \in B(\mathbb{T})$. We want to study the following series, for all $M \geqslant 1$ :

$$
\sum_{k} \sup _{\alpha \in[-M, M]}\left|P_{k}(\alpha)\right|
$$

We have :

$$
\left|P_{k}(\alpha)\right| \leq \sum_{j \in \mathbb{Z}}|\hat{f}(j)|\left|\sum_{l=N_{k}+1}^{N_{k+1}} a_{l}\left[\exp \left(2 \pi j \alpha X_{l}(\omega)\right)-\mathbb{E} \exp \left(2 \pi j \alpha X_{l}\right)\right]\right|
$$

Hence, using theorem 1.5, there exists a positive integrable random variable $\xi$ such that

$$
\begin{equation*}
\sup _{\alpha \in[-M, M]}\left|P_{k}(\alpha)\right| \leq \xi\left|\|f \mid\| \sqrt{\log \left(M \Phi_{\beta}\left(N_{k+1}\right)\right) \sum_{j=N_{k}+1}^{N_{k+1}}\left|a_{j}\right|^{2}}\right. \tag{3}
\end{equation*}
$$

where

$$
\xi=\sup _{j \in \mathbb{Z}} \sup _{k \geqslant 1} \sup _{\alpha \in I_{M}}\left|\frac{1}{\sqrt{A_{k, M}^{2} \log (|j|+3)}} \sum_{l=N_{k}+1}^{N_{k+1}} a_{l}\left[e^{2 i \pi \alpha j X_{l}(\omega)}-\mathbb{E} e^{2 i \pi \alpha j X_{l}}\right]\right|
$$

with

$$
A_{k, M}^{2}=\log \left(M \Phi_{\beta}\left(N_{k+1}\right)\right) \sum_{l=N_{k}+1}^{N_{k+1}}\left|a_{l}\right|^{2}
$$

First, in the polynomial case, that is to say when there exists $d>0$ with

$$
\Phi_{\beta}(N)=\mathcal{O}\left(N^{d}\right)
$$

then we choose $N_{k}=2^{2^{k}}$ and we need to prove that

$$
\sum_{k} 2^{k / 2}\left(\sum_{l=2^{2^{k}}+1}^{2^{2^{k+1}}}\left|a_{l}\right|^{2}\right)^{1 / 2}<+\infty
$$

now we use the following equivalent:

$$
\sum_{l=2^{2^{k}}+1}^{2^{2^{k+1}}} \frac{1}{l(\log (l))^{1 / 2}} \approx 2^{k / 2}
$$

which may be computed by comparing series and integral, hence :

$$
\begin{aligned}
2^{k / 2}\left(\sum_{l=2^{2^{k}}+1}^{2^{2^{k+1}}}\left|a_{l}\right|^{2}\right)^{1 / 2} & \leqslant C \sum_{l=2^{2^{k}+1}}^{2^{2^{k+1}}} \frac{1}{l(\log (l))^{1 / 2}}\left(\sum_{l=2^{2^{k}+1}}^{\infty}\left|a_{l}\right|^{2}\right)^{1 / 2} \\
& \leqslant C \sum_{l=2^{2^{k}}+1} \frac{\left(\sum_{j=l}^{\infty}\left|a_{j}\right|^{2}\right)^{1 / 2}}{l(\log (l))^{1 / 2}}
\end{aligned}
$$

and, using condition 11:

$$
\begin{aligned}
\sum_{k} 2^{k / 2}\left(\sum_{l=2^{2^{k}}+1}^{2^{2^{k+1}}}\left|a_{l}\right|^{2}\right)^{1 / 2} & \leqslant \sum_{k} C \sum_{l=2^{2^{k}+1}}^{2^{2^{k+1}}} \frac{\left(\sum_{j=l}^{\infty}\left|a_{j}\right|^{2}\right)^{1 / 2}}{l(\log (l))^{1 / 2}} \\
& \leqslant \sum_{n \geqslant 2} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n \sqrt{\log n}}<+\infty
\end{aligned}
$$

this implies :

$$
\sum_{k \geqslant 1} \sup _{\alpha \in[-M, M]}\left|P_{k}(\alpha)\right|<\infty
$$

almost everywhere on the measurable set $\Omega_{o}=\{\omega \in \Omega, \xi(\omega)<\infty\}$. By construction, this set does not depend on the choice of $f$.
Secondly, in the subexponential case, that is when there exists $\gamma \in] 0,1[$ with

$$
\Phi_{\beta}(N)=\mathcal{O}\left(2^{N^{\gamma}}\right)
$$

we choose $N_{k}=2^{k}$ and we need to prove that

$$
\sum_{k} 2^{\gamma k / 2}\left(\sum_{l=2^{k}+1}^{2^{k+1}}\left|a_{l}\right|^{2}\right)^{1 / 2}<+\infty
$$

Using the following equivalent:

$$
\sum_{l=2^{k}+1}^{2^{k+1}} \frac{1}{l^{1-\frac{\gamma}{2}}} \approx 2^{\gamma k / 2}
$$

and doing the same kind of computation as before, using condition 2 :

\sum_{n \geqslant 2} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n^{1-\frac{\gamma}{2}}}<+\infty
$$

implies

\sum_{k \geqslant 1} \sup _{\alpha \in[-M, M]}\left|P_{k}(\alpha)\right|<\infty
$$

We also get from (3), for all $\alpha \in \mathbb{R}$ :

\left|P_{k}(\alpha)\right| \leqslant \xi\left|\|f \mid\| \sqrt{\log (|\alpha|+1)} \sqrt{\log \left(\Phi_{\beta}\left(N_{k+1}\right)\right) \sum_{j=N_{k}+1}^{N_{k+1}}\left|a_{j}\right|^{2}}\right.
$$

summing on $k$, we get the inequality:

$$
|F(\alpha, \omega)-\mathbb{E}(F(\alpha, .))| \leqslant C \xi(\omega)|\|f \mid\| \sqrt{\log (|\alpha|+2)}
$$

where $C$ only depends on $\left(a_{k}\right)$ and $\mathbb{E}(\xi)<\infty$
This ends the proof of theorem 1.4 which is also the first step of the proof of theorem 1.1
-Step 2 : (second part of the sum)
Let $K$ be a compact which does not contain zero and $\alpha \in K$. Let $n<m$ be
two integers,

$$
\begin{align*}
\left|\sum_{k=n}^{m} a_{k} \mathbb{E}\left(f\left(\alpha X_{k}\right)\right)\right| & =\left|\sum_{j \in \mathbb{Z}^{*}} \sum_{k=n}^{m} a_{k} \hat{f}(j) \mathbb{E}\left(\exp \left(2 i \pi j \alpha X_{k}\right)\right)\right|  \tag{4}\\
& =\left|\sum_{j \in \mathbb{Z}^{*}} \sum_{k=n}^{m} a_{k} \hat{f}(j) \varphi_{X_{k}}(j \alpha)\right| \\
& =\left|\sum_{j \in \mathbb{Z}^{*}} \hat{f}(j)\left(\sum_{k=n}^{m} a_{k} \varphi_{X_{k}}(j \alpha)\right)\right| \\
& \leqslant\left(\sum_{j \in \mathbb{Z}^{*}}|\hat{f}(j)|\right) \sup _{j \in \mathbb{Z}^{*}}\left|\sum_{k=n}^{m} a_{k} \varphi_{X_{k}}(j \alpha)\right|
\end{align*}
$$

At this point, to prove theorem 1.1, we can conclude directly by using hypothesis $(\mathcal{H})$ to get

$$
\sup _{n<m} \sup _{\alpha \in K}\left|\sum_{k=n}^{m} a_{k} \mathbb{E}\left(f\left(\alpha X_{k}\right)\right)\right|<\varepsilon
$$

as long as $m$ and $n$ are large enough.
To prove corollary 1.2, we use Abel's summation. Let $\phi_{p}=\sum_{k=0}^{p-1} \varphi_{X_{k}}$, we have :

\sum_{k=n}^{m} a_{k} \varphi_{X_{k}}(j \alpha) & =\sum_{k=n}^{m} a_{k}\left(\phi_{k+1}(j \alpha)-\phi_{k}(j \alpha)\right)  \tag{8}\\
& =\sum_{k=n+1}^{m+1} a_{k-1} \phi_{k}(j \alpha)-\sum_{k=n}^{m} a_{k} \phi_{k}(j \alpha) \\
& =-a_{n} \phi_{n}(j \alpha)+a_{m} \phi_{m+1}(j \alpha) \\
& +\sum_{k=n+1}^{m}\left(a_{k-1}-a_{k}\right) \phi_{k}(j \alpha)
\end{align*}
$$

and :

$$
(\mathbb{7}) \leqslant\left|\left\|f\left|\| \sup _{N \geqslant 1} \sup _{\alpha \in K} \sup _{j \in \mathbb{Z}^{*}}\right| \phi_{N}(j \alpha) \mid\left[\left|a_{m}\right|+\left|a_{n}\right|+\sum_{k=n+1}^{m}\left|a_{k}-a_{k-1}\right|\right]\right.\right.
$$

we now conclude using hypothesis $\mathcal{H}^{\prime}$ and hypothesis (1) on the sequence $\left(a_{n}\right)$ in corollary 1.2 :
as long as $m$ and $n$ are large enough.
To prove corollary 1.3, we use Cauchy Schwarz inequality in the following way:

$$
\left|\sum_{k=n}^{m} a_{k} \varphi_{X_{k}}(j \alpha)\right| \leqslant \sqrt{\sum_{k=n}^{m}\left|a_{k}\right|^{2}} \sqrt{\sum_{k=n}^{m}\left|\varphi_{X_{k}}(j \alpha)\right|^{2}}
$$

and we conclude using condition $H^{\prime \prime}$.

## Remark 2.1.

(1) the most general hypothesis we can put on the sequence $\left(a_{k}\right)_{k \geqslant 1}$ is the following : there exists a strictly increasing sequence $\left(N_{k}\right)_{k \geqslant 1}$ such that

$$
\sum_{k=1}^{\infty} \sqrt{\log \Phi_{\beta}\left(N_{k+1}\right) \sum_{l=N_{k}+1}^{N_{k+1}}\left|a_{l}\right|^{2}}<\infty
$$

(2) if the process $\left(X_{k}\right)_{k \geqslant 1}$ takes integer values then $f \in A(\mathbb{T})$ can be assumed without any other hypothesis.
(3) If $\sum\left|a_{k}\right|^{2}$ diverges, then we can construct a stochastic process $\left(X_{k}\right)_{k \geqslant 1}$ verifying the hypothesis of theorem 1.4 and find $f \in B(\mathbb{T})$ such that the convergence of the series is not uniform on any compact. In that sense, the conditions imposed to the sequence $\left(a_{k}\right)_{k \geqslant 1}$ are optimal. Remark that in this case, condition 1 is not fulfilled.

Namely consider a sequence of independent random variables with disjoint supports. For all $k \geqslant 1$ the support of $X_{k}$ is the set of integers belonging to $\left[k^{2},(k+1)^{2}-1\right]$ and hence, the hypothesis on the moment is verified. We will come back to the law of $X_{k}$ later. Now choose $f$ in the following way : for all $\alpha \in \mathbb{T}, f(\alpha)=\exp (2 i \pi \alpha)$. Thus $f \in A(\mathbb{T})$ et $\|\|f\|\|<\infty$. As a consequence, if the convergence of the series defining $F$ was uniform in $\alpha$ on $\mathbb{T}$, then we would have

& \sqrt{\int_{0}^{1}\left|\sum_{k=1}^{\infty} a_{k}\left[\exp 2 i \pi \alpha X_{k}(\omega)-\mathbb{E} \exp 2 i \pi \alpha X_{k}\right]\right|^{2} d \alpha} \\
\leq & \sup _{\alpha \in[0,1]}\left|\sum_{k=1}^{\infty} a_{k}\left[\exp 2 i \pi \alpha X_{k}(\omega)-\mathbb{E} \exp 2 i \pi \alpha X_{k}\right]\right|<\infty
\end{aligned}
$$

By construction, $\mathbb{P}$ - almost surely :

$$
\begin{aligned}
& \int_{0}^{1}\left|\sum_{k=1}^{\infty} a_{k}\left[\exp 2 i \pi \alpha X_{k}(\omega)-\mathbb{E} \exp 2 i \pi \alpha X_{k}\right]\right|^{2} d \alpha \\
= & \sum_{k=1}^{\infty}\left|a_{k}\right|^{2} \int_{0}^{1}\left|\exp \left(2 i \pi \alpha X_{k}(\omega)\right)-\mathbb{E} \exp \left(2 i \pi \alpha X_{k}\right)\right|^{2} d \alpha \\
\geqslant & \sum_{k=1}^{\infty}\left|a_{k}\right|^{2} \int_{0}^{1}\left|1-\left|\mathbb{E} \exp \left(2 i \pi \alpha X_{k}\right)\right|^{2} d \alpha\right.
\end{aligned}
$$

Assume now that the law of $X_{k}$ is uniform on the $2 k+1$ integers of $\left[k^{2},(k+1)^{2}-1\right]$. for all $k \geqslant 1$.

$$
\left|\mathbb{E} \exp \left(2 i \pi \alpha X_{k}\right)\right|=\frac{1}{2 k+1}\left|\frac{\sin \pi \alpha(2 k+1)}{\sin \pi \alpha}\right|
$$

Using Lebesgue convergence theorem, we get

$$
\lim _{k \rightarrow+\infty} \int_{0}^{1}\left|1-\left|\mathbb{E} \exp \left(2 i \pi \alpha X_{k}\right)\right|\right|^{2} d \alpha=1
$$

and we also get the divergence of the series with positive terms

$$
\sum_{k=1}^{\infty}\left|a_{k}\right|^{2} \int_{0}^{1}\left|1-\left|\mathbb{E} \exp \left(2 i \pi \alpha X_{k}\right)\right|^{2} d \alpha=\infty\right.
$$

A contradiction with uniform convergence of the centered part.

## 3. Proof of theorem 1.5

Let us begin by restating some inequalities obtained by Fernique ([纤) which will be useful in the proof of theorem 1.5. For more information on gaussian techniques in this framework, see (7] and [2].

Inequality 3.1. Let $\left(G_{k}\right)_{k \geqslant 1}$ be a sequence of Banach space valued gaussian random variables $(B,\|\cdot\|)$ defined on a probabilised space $(\Omega, \mathcal{A}, \mathbb{P})$. Then :

$$
\mathbb{E} \sup _{k \geqslant 1}\left\|G_{k}\right\| \leq K_{1}\left\{\sup _{k \geqslant 1} \mathbb{E}\left\|G_{k}\right\|+\mathbb{E} \sup _{k \geqslant 1}\left|\lambda_{k} \sigma_{k}\right|\right\}
$$

where $\left(\lambda_{k}\right)_{k \geqslant 1}$ is an isonormal sequence, $K_{1}$ a universal constant and for all $k \geqslant 1$,

$$
\sigma_{k}=\sup _{f \in B^{\prime},\|f\| \leq 1}\left\|<G_{k}, f>_{B}\right\|_{2, \mathbb{P}}
$$

Inequality 3.2. Let $g$ be a real valued stationary gaussian random variable, separable and continuous in quadratic mean. Let $m$ be its associated spectral measure on $\mathbb{R}^{+}$defined by

$$
\mathbb{E}\left[|g(s)-g(t)|^{2}\right]=2 \int_{0}^{\infty}[1-\cos 2 \pi u(s-t)] m(d u)
$$

We have

$$
\mathbb{E} \sup _{\alpha \in[0,1]} g(\alpha) \leq K\left\{\sqrt{\int_{0}^{\infty} \min \left(u^{2}, 1\right) m(d u)}+\int_{0}^{\infty} \sqrt{m(] e^{x^{2}}, \infty[)} d x\right\}
$$

where $K$ is a universal constant.
Inequality 3.3. (decoupling) Let $X=\{X(t): t \in \mathbb{T}\}$ be a gaussian random function defined on a finite or countable set $T$. Let $\left\{T_{k}, k \in[1, n]\right\}$ be a covering of $T$. Let $S=T_{1} \times \cdots \times T_{n}$. The following inequality holds :

$$
\mathbb{E}\left\{\sup _{k \in[1, n]}\left[\sup _{t \in T_{k}} X(t)-\mathbb{E} \sup _{t \in T_{k}} X(t)\right]\right\} \leq \frac{\pi}{2} \cdot \sup _{s \in S}\left\{\mathbb{E}\left[\sup _{k \in[1, n]} X\left(s_{k}\right)\right]\right\}
$$

The following estimation generalizes inequality 3.2 and will be useful in the almost periodic case because it gives estimations on arbitrarily large intervals.

Inequality 3.4. Let $g$ a real valued stationnary gaussian random function, separable and continuous in quadratic mean. Let $m$ its associated spectral measure on $\mathbb{R}^{+}$defined as in inequality 3.7. There exists a universal constant $K$ such that

\begin{gathered}
\mathrm{E} \sup _{\alpha \in[-M, M]} g(\alpha) \\
\leq K\left\{\sqrt{\int_{0}^{\infty} \min \left(2 M u^{2}, 1\right) m(d u)}+\int_{0}^{\infty} \sqrt{m(] \frac{e^{x^{2}}}{2 M}, \infty[)} d x\right\}
\end{gathered}
$$

Let us now come to the proof
-Step 1: In this part, we replace our problem by a question of regularity of trajectories of random gaussian functions.

Let us consider an independent copy of $X=\left(X_{k}\right)_{k \geqslant 1}$ denoted by $X^{\prime}=$ $\left(X_{k}^{\prime}\right)_{k \geqslant 1}$ defined on another probabilized space $\left(\Omega^{\prime}, \mathcal{A}^{\prime}, \mathbb{P}^{\prime}\right)$. We call $\mathbb{E}_{*}$ the integration symbol whose index refers to the space of integration.

Using classical convexity properties, to prove (1), it is enough to show

$$
\begin{equation*}
\mathbb{E}_{X, X^{\prime}} \sup _{j \in \mathbb{Z}} \sup _{\lambda \geqslant 1} \sup _{\Lambda \geqslant \lambda} \sup _{\alpha \in I_{M}}\left|\frac{\sum_{k=\lambda}^{\Lambda} a_{k}\left[e^{2 i \pi \alpha j X_{k}}-e^{2 i \pi \alpha j X_{k}^{\prime}}\right]}{\sqrt{A_{\Lambda, \lambda, M}^{2} \log (|j|+3)}}\right|<\infty \tag{12}
\end{equation*}
$$

Let us now symmetrize the problem: consider the following separable family of random functions, with continuous trajectories

$$
\left(f_{k}\right)_{k \geqslant 1}=\left\{f_{k}(\alpha, j)=a_{k}\left(\exp 2 i \pi \alpha j X_{k}-\exp 2 i \pi \alpha j X_{k}^{\prime}\right), \alpha \in I_{M}, j \in \mathbb{Z}\right\}_{k \geqslant 1}
$$

By construction $f$ is a symmetric family of random functions, that is to say their law is sign-invariant. More precisely, call $\left\{\varepsilon_{k}, k \geqslant 1\right\}$ a sequence of independent Rademacher random variables (taking the values +1 and -1 with probability $1 / 2$ ), defined on a third space $\left(\Omega^{\prime \prime}, \mathcal{A}^{\prime \prime}, \mathbb{P}^{\prime \prime}\right)$, independent of $X$ and $X^{\prime} .\left\{f_{k}, k \geqslant 1\right\}$ and $\left\{\varepsilon_{k} f_{k}, k \geqslant 1\right\}$ have the same law. Thus for all
integers $(\Lambda, \lambda)$ such that $\Lambda \geqslant \lambda, \sum_{k=\lambda}^{\Lambda} f_{k}$ and $\sum_{k=\lambda}^{\Lambda} \varepsilon_{k} f_{k}$ also have the same law.

That is why (12) can be written on a larger space of integration in the following way:

$$
\mathbb{E}_{X, X^{\prime}, \varepsilon} \sup _{j \in \mathbb{Z}} \sup _{\lambda \geqslant 1} \sup _{\Lambda \geqslant \lambda} \sup _{\alpha \in I_{M}}\left|\frac{\sum_{k=\lambda}^{\Lambda} \varepsilon_{k} f_{k}(\alpha, j)}{\sqrt{A_{\Lambda, \lambda, M}^{2} \log (|j|+3)}}\right|
$$

We deduce a sufficient condition for (12) to be realised

$$
\begin{equation*}
\mathbb{E}_{X, \varepsilon} \sup _{j \in \mathbb{Z}} \sup _{\lambda \geqslant 1} \sup _{\Lambda \geqslant \lambda} \sup _{\alpha \in I_{M}}\left|\frac{\sum_{k=\lambda}^{\Lambda} \varepsilon_{k} a_{k} \exp 2 i \pi \alpha j X_{k}}{\sqrt{A_{\Lambda, \lambda, M}^{2} \log (|j|+3)}}\right| \tag{13}
\end{equation*}
$$

We then use a precious tool in the theory of gaussian random functions: the contraction principle. This tool is built on a quite simple idea: replace the choice of signs by a sequence of gaussian random variables with mean zero and variance one. This idea can be explained by the following property: given $g$ a gaussian random variable with mean zero and variance 1 and $\varepsilon$ a Rademacher random variable, if $g$ and $\varepsilon$ are independent, then $g$ and $\varepsilon|g|$ have the same law.

As a consequence, in order to prove (13), we show

$$
\mathbb{E}_{X, g, g^{\prime}} \sup _{j \in \mathbb{Z}} \sup _{\lambda \geqslant 1} \sup _{\Lambda \geqslant \lambda} \sup _{\alpha \in I_{M}}\left|\frac{\sum_{k=\lambda}^{\Lambda} a_{k}\left(g_{k} \cos 2 \pi \alpha j X_{k}+g_{k}^{\prime} \sin 2 \pi \alpha j X_{k}\right)}{\sqrt{A_{\lambda, \Lambda, M}^{2} \log (|j|+3)}}\right|<+\infty
$$

where $\left\{g_{k}, k \geqslant 1\right\}$ et $\left\{g_{k}^{\prime}, k \geqslant 1\right\}$ are two sequences of independent identically distributed random variables with law $\mathcal{N}(0,1)$, independent of $X$ and $\varepsilon$, defined on two other probabilised spaces.

Conditionally to $X$, the problem is reduced to studying the regularity of the trajectories of stationary gaussian random variables. This concludes the first step of the proof.
-Step 2 : In this part, we use the gaussian tools introduced in the beginning.

Conditionally to $X$, call $G(\lambda, \Lambda, j, \alpha)$ the following quantity

$$
\frac{1}{\sqrt{A_{\lambda, \Lambda, M}^{2} \log (|j|+3)}} \sum_{k=\lambda}^{\Lambda} a_{k}\left[g_{k} \cos \left(2 \pi \alpha j X_{k}\right)+g_{k}^{\prime} \sin \left(2 \pi \alpha j X_{k}\right)\right]
$$

If $j, \lambda$ and $\Lambda$ are fixed, $G(\alpha):=G(\lambda, \Lambda, j, \alpha)$ is a random function with almost surely continuous trajectories (up to a modification of trajectories). That is why it is enough to show that $G$ is bounded on $I_{M} \cap \mathbb{Q}$. Moreover, we will assume that $|j| \leq J$ where $J$ is a large fixed integer.

Let us begin by finding an upper bound for

$$
\mathbb{E}_{g, g^{\prime}} \sup _{|j| \leq J} \sup _{\lambda \geqslant 1} \sup _{\Lambda \geqslant \lambda} \sup _{\alpha \in I_{M} \cap \mathbb{Q}}|G(\lambda, \Lambda, j, \alpha)|
$$

First remark that if $Y_{t}(t \in T)$ is a gaussian random function defined on $T$, then for all $t_{0} \in T$ we have (see [4] (480))

$$
\mathbb{E} \sup _{t \in T}\left|Y_{t}\right| \leq \mathbb{E}\left|Y_{t_{0}}\right|+\mathbb{E} \sup _{t \in T} Y_{t}
$$

In this way, we get rid of the absolute value. Apply this remark to $G(\lambda, \Lambda, j, \alpha)$ with $\alpha=0, \lambda=\Lambda=1$ and $j=0$ and let us find an upper bound for

$$
\begin{equation*}
\mathbb{E}_{g, g^{\prime}} \sup _{|j| \leq J \lambda \geqslant 1} \sup _{\lambda \geqslant \lambda} \sup _{\alpha \in I_{M} \cap \mathbb{Q}} G(\lambda, \Lambda, j, \alpha) \tag{14}
\end{equation*}
$$

In order to apply the decoupling inequality 3.3 , define

$$
T=\{-J, \cdots, J\} \times H \times\left(I_{M} \cap \mathbb{Q}\right)
$$

where $J$ is a large enough integer and $H$ is the upper triangle of dimension 2 in $\mathbb{N} \times \mathbb{N}$ (see figure 1 below) $(\lambda \in \mathbb{N}$ and $\Lambda \geqslant \lambda$.) A point in $t \in T$ will be written $t=(j, \lambda, \Lambda, \alpha)$.

This set $T$ is at most countable and we will find an upper bound for $\mathbb{E}_{g, g^{\prime}} \sup _{t \in T} G(t)$ independently of $J$ and then conclude by taking the supremum on $j \in J$. Define

$$
T_{j}=\{j\} \times H \times\left(I_{M} \cap \mathbb{Q}\right)
$$

It is obvious that $\left\{T_{j}\right\}_{j=-J, \cdots, J}$ is a covering of $T$. Define

$$
S=T_{-J} \times \cdots \times T_{J}
$$

Using inequality 3.3, we have

$$
\mathbb{E}_{g, g^{\prime}} \sup _{t \in T} G(t) \leq \frac{\pi}{2} \sup _{s \in S} \mathbb{E}_{g, g^{\prime}} \sup _{-J \leqslant j \leqslant J} G\left(s_{j}\right)+\sup _{-J \leqslant j \leqslant J} \mathbb{E}_{g, g^{\prime}} \sup _{t \in T_{j}} G(t)
$$

where $s_{j}$ is a point in $T_{j}$.
-Step 3 : We study now

$$
\sup _{s \in S} \mathbb{E} \sup _{-J \leqslant j \leqslant J} G\left(s_{j}\right)
$$

We can rewrite this in the following way :

$$
\left(15 \text { pup } \mathbb{E}_{g, g^{\prime}} \sup _{-J \leqslant j \leqslant J} \frac{\sum_{k=\lambda_{j}}^{\Lambda_{j}} a_{k}\left[g_{k} \cos \left(2 \pi j \alpha_{j} X_{k}\right)+g_{k}^{\prime} \sin \left(2 \pi j \alpha_{j} X_{k}\right)\right]}{\sqrt{A_{\lambda_{j}, \Lambda_{j}, M}^{2} \log (|j|+3)}}\right.
$$

where the first supremum is taken on

$$
\left\{\left(\alpha_{-J}, \cdots, \alpha_{J}\right) \in\left(I_{M} \cap \mathbb{Q}\right)^{2 J+1},\left(\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right)\right) \in H^{2 J+1}\right\}
$$

Fix $\left\{\left(\alpha_{-J}, \cdots, \alpha_{J}\right) \in\left(I_{M} \cap \mathbb{Q}\right)^{2 J+1}\right.$ and $\left(\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right)\right) \in$ $\left.H^{2 J+1}\right\}$. Define the gaussian process

$$
G_{j}:=\frac{\sum_{k=\lambda_{j}}^{\Lambda_{j}} a_{k}\left[g_{k} \cos \left(2 \pi j \alpha_{j} X_{k}\right)+g_{k}^{\prime} \sin \left(2 \pi j \alpha_{j} X_{k}\right)\right]}{\sqrt{A_{\lambda_{j}, \Lambda_{j}, M}^{2} \log (|j|+3)}}
$$

In order to get an upper bound for 15, we remark that

$$
\sup \mathbb{E}_{g, g^{\prime}} \sup _{-J \leqslant j \leqslant J} G_{j}
$$

$(16) \leq \sup _{\left(\left(\lambda_{-J}, \lambda_{-J}\right), \cdots,\left(\lambda_{J}, \lambda_{J}\right)\right) \in H^{2 J+1}} \mathbb{E}_{g, g^{\prime}} \sup _{-J \leqslant j \leqslant J} \sup _{\alpha \in I_{M}}\left|G\left(j, \lambda_{j}, \Lambda_{j}, \alpha\right)\right|$
We will get an upper bound for the right hand side of 16 independently of $J$, which will give us an upper bound for 15 by taking the supremum on $j \in J$.

Applying inequality 3.1 to the finite sequence of random gaussian functions

$$
\left(G\left(j, \lambda_{j}, \Lambda_{j}, \alpha\right)\right)_{-J \leq j \leq J}
$$

we prove that $\mathbb{E}_{g, g^{\prime}} \sup _{-J \leq j \leq J} \sup _{\alpha \in I_{M}}\left|G\left(j, \lambda_{j}, \Lambda_{j}, \alpha\right)\right|$ is less than

$$
\begin{equation*}
C\left\{\sup _{-J \leq j \leq J} \mathbb{E}_{g, g^{\prime}} \sup _{\alpha \in I_{M}}\left|G\left(j, \lambda_{j}, \Lambda_{j}, \alpha\right)\right|+\mathbb{E}_{\xi} \sup _{-J \leq j \leq J}\left|\xi_{j} q_{j}\right|\right\} \tag{17}
\end{equation*}
$$

where $C$ is a universal constant, $\left(\xi_{j}\right)_{-J \leq j \leq J}$ is an isonormal sequence and

$$
q_{j} \leq \sup _{\alpha \in I_{M}}\left\|G\left(j, \lambda_{j} \Lambda_{j}, \alpha\right)\right\|_{2, g, g^{\prime}}
$$

This gives us the following upper bound

$$
q_{j} \leq \frac{1}{\sqrt{\log \left(M \Phi_{\beta}\left(\Lambda_{j}\right)\right) \log (|j|+3)}}
$$

As for all $j$ we have $\Lambda_{j} \geqslant 1$ and $M \geqslant 1$ we easily get

$$
\begin{align*}
\mathbb{E}_{\xi} \sup _{-J \leq j \leq J}\left|\xi_{j} q_{j}\right| & \leq \mathbb{E}_{\xi} \sup _{-J \leq j \leq J}\left|\frac{1}{\sqrt{\log (|j|+3)}} \xi_{j}\right|  \tag{18}\\
& \leq C \mathbb{E}_{\xi} \sup _{j \in \mathbb{Z}}\left|\frac{\xi_{j}}{\sqrt{\log (|j|+3)}}\right| \tag{19}
\end{align*}
$$

The exponential integrability of gaussian vectors gives

$$
\mathbb{E}_{\xi} \sup _{j \in \mathbb{Z}}\left|\frac{\xi_{j}}{\sqrt{\log |j|+3}}\right|=C<\infty
$$

and hence

$$
\sup _{\left.\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right)\right) \in H^{2 J+1}} \mathbb{E}_{\xi} \sup _{-J \leq j \leq J}\left|\xi_{j} q_{j}\right|=C<\infty
$$

independently of $J$ and of the sequence $\left.\left.\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right)\right) \in H^{2 J+1}\right)$.
We then get independently of $J$ on the whole integration space

$$
\mathbb{E}_{X} \sup _{\left.\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right)\right) \in H^{2 J+1}} \mathbb{E}_{\xi} \sup _{-J \leq j \leq J}\left|\xi_{j} q_{j}\right| \leq C<\infty
$$

where $C$ is a constant.

Let us now try to find an upper bound for

$$
\begin{equation*}
\sup _{\left(\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right)\right) \in H^{2 J+1}} \sup _{-J \leq j \leq J} \mathbb{E}_{g, g^{\prime}} \sup _{\alpha \in I_{M}}\left|G\left(j, \lambda_{j}, \Lambda_{j}, \alpha\right)\right| \tag{20}
\end{equation*}
$$

independently of $J$.
We will use inequality 3.4. Let us choose a finite sequence

$$
\left(\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right)\right.
$$

and an integer $|j| \leq J$. The gaussian random function $G_{j}(\alpha):=G\left(j, \lambda_{j}, \Lambda_{j}, \alpha\right)$ is stationary. Its associated spectral measure on $\mathbb{R}^{+}$is defined by

$$
m_{j}=\frac{1}{\log (|j|+3) \log \left(M \Phi_{\beta}\left(\Lambda_{j}\right)\right)\left(\sum_{k=\lambda_{j}}^{\Lambda_{j}}\left|a_{k}\right|^{2}\right)} \sum_{k=\lambda_{j}}^{\Lambda_{j}}\left|a_{k}\right|^{2} \delta_{j\left|X_{k}\right|}
$$

where $\delta_{u}$ is the Dirac measure in the point $u$.
We get

$$
\begin{gathered}
\mathbb{E}_{g, g^{\prime}} \sup _{\alpha \in I_{M}}\left|G_{j}(\alpha)\right| \\
\leq C\left\{\sqrt{\int_{0}^{\infty} \min \left(\frac{u^{2}}{2 M}, 1\right) m_{j}(d u)}+\int_{0}^{\infty} \sqrt{m_{j}(] \frac{e^{x^{2}}}{2 M}, \infty[)} d x\right\}
\end{gathered}
$$

It is obvious that the first term is less than

$$
\sqrt{m_{j}\left(\mathbb{R}^{+}\right)} \leq C \frac{1}{\sqrt{\log (2 M) \log (|j|+3)}}
$$

where $C$ is a universal constant because for all $j$ we have $\Phi_{\beta}\left(\Lambda_{j}\right) \geqslant 2$.
For the second term, it can be rewritten in the following way

$$
\begin{aligned}
& \int_{0}^{\infty} \sqrt{m_{j}(] \frac{\exp x^{2}}{2 M}, \infty[)} d x \\
= & {\left[\frac{1}{\log (|j|+3) \log \left(M \Phi_{\beta}\left(\Lambda_{j}\right)\right)\left(\sum_{k=\lambda_{j}}^{\Lambda_{j}}\left|a_{k}\right|^{2}\right)}\right]^{\frac{1}{2}} } \\
\times & \int_{0}^{\infty} \sqrt{\sum_{k=\lambda_{j}}^{\Lambda_{j}}\left|a_{k}\right|^{2} \mathbf{1}_{\left\{2 M\left|j X_{k}\right|>e^{\left.x^{2}\right\}}\right.} d x}
\end{aligned}
$$

Using
$\forall k \geqslant 1$,

$$
\mathbf{1}_{\left\{2 M\left|j X_{k}\right|>e^{x^{2}}\right\}} \leq \mathbf{1}_{\left\{2 M|j| \sup _{l \leq k}\left|X_{l}\right|>e^{x^{2}}\right\}}
$$

we cut $\mathbb{R}^{+}$in the integral according to the increasing subdivision

$$
\{0\} \bigcup\left\{\sqrt{\log ^{+}\left(2 M|j| \sup _{l \leq k}\left|X_{l}\right|\right)}, \lambda_{j} \leq k \leq \Lambda_{j}\right\}
$$

We get thus an upper bound for the previous integral

$$
\begin{aligned}
& \sum_{k=\lambda_{j}}^{\Lambda_{j}} \quad\left[\sqrt{\log ^{+}\left(2 M|j| \sup _{l \leq k}\left|X_{l}\right|\right)}-\sqrt{\log ^{+}\left(2 M|j| \sup _{l \leq k-1}\left|X_{l}\right|\right)}\right]\left(\sum_{l=\lambda_{j}}^{\Lambda_{j}}\left|a_{l}\right|^{2}\right)^{\frac{1}{2}} \\
& \quad \leq\left(\sum_{l=\lambda_{j}}^{\Lambda_{j}}\left|a_{l}\right|^{2}\right)^{\frac{1}{2}} \sum_{k=\lambda_{j}}^{\Lambda_{j}}\left[\sqrt{\log ^{+}\left(2 M|j| \sup _{l \leq k}\left|X_{l}\right|\right)}\right. \\
& \\
& \left.-\sqrt{\log ^{+}\left(2 M|j| \sup _{l \leq k-1}\left|X_{l}\right|\right)}\right] \\
& \quad \leq 2\left(\sum_{k=\lambda_{j}}^{\Lambda_{j}}\left|a_{k}\right|^{2}\right)^{\frac{1}{2}} \sqrt{\log ^{+}\left(2 M|j| \sup _{l \leq \Lambda_{j}}\left|X_{l}\right|\right)}
\end{aligned}
$$

Consequently, $\forall|j| \leq J$,

$$
\begin{aligned}
\int_{0}^{\infty} \sqrt{m_{j}\left(1 \frac{\exp x^{2}}{M}, \infty[)\right.} d x & \leq 2 \sqrt{\frac{\log ^{+}\left(2 M|j| \sup _{l \leq \Lambda_{j}}\left|X_{l}\right|\right)}{\log (|j|+3) \log \left(M \Phi_{\beta}\left(\Lambda_{j}\right)\right)}} \\
& \leq 4 \sqrt{\frac{\log ^{+}\left(2 M \sup _{1 \leq l \leq \Lambda_{j}}\left|X_{l}\right|\right)}{\log \left(M \Phi_{\beta}\left(\Lambda_{j}\right)\right)}} \\
& \leq 4 \sup _{1 \leq l \leq \Lambda_{j}} \sqrt{\frac{\log ^{+}\left(2 M\left|X_{l}\right|\right)}{\log \left(M \Phi_{\beta}(l)\right)}} \\
& \leq 4 \sup _{N \geqslant 1} \sqrt{\frac{\log ^{+}\left(2 M\left|X_{N}\right|\right)}{\log \left(M \Phi_{\beta}(N)\right)}} \\
& \leq 4\left(1+\sup _{N \geqslant 1} \sqrt{\frac{\log ^{+}\left(\left|X_{N}\right|\right)}{\log \Phi_{\beta}(N)}}\right)
\end{aligned}
$$

Finally, on the whole integration space, we get the following upper bound :

$$
\begin{array}{r}
\mathbb{E}_{X} \sup _{\left(\lambda_{-J}, \Lambda_{-J}\right), \cdots,\left(\lambda_{J}, \Lambda_{J}\right) \in H^{2 J+1}} \sup _{-J \leq j \leq J} \mathbb{E}_{g, g^{\prime}} \sup _{\alpha \in I_{M}}\left|G_{j}(\alpha)\right| \\
\quad \leq C\left(1+\mathbb{E}_{X} \sup _{N \geqslant 1} \sqrt{\frac{\log ^{+}\left(\left|X_{N}\right|\right)}{\log \Phi_{\beta}(N)}}\right)<\infty \tag{22}
\end{array}
$$

-Step 4 : To end the proof of theorem 1.5, it remains to deal with

$$
\sup _{-J \leq j \leq J} \mathbb{E}_{g, g^{\prime}} \sup _{(\lambda, \Lambda) \in H} \sup _{\alpha \in I_{M} \cap \mathbb{Q}} G(j, \lambda, \Lambda, \alpha)
$$

Let us fix $j$. In order to apply inequality 3.1, we need to replace the supremum on $(\lambda, \Lambda) \in H$ by a supremum on only one variable, in other words,


Figure 1. renumbering the upper triangle in $\mathbb{N}^{2}$
we need to renumber $H$ using one variable $h \in \mathbb{N}^{2}$ given by the formula :

$$
h=\lambda+\frac{\Lambda(\Lambda-1)}{2}
$$

(see figure 1).
Let us fix $j$. Inequality 3.1 gives us :

$$
\mathbb{E}_{g, g^{\prime}} \operatorname{suf}_{h \geqslant 1}(\mathbf{P} 3) \sup _{\alpha \in I_{M} \cap \mathbb{Q}} G(j, h, \alpha) \leqslant K_{1}\left(\sup _{h \geqslant 1} \mathbb{E}_{g, g^{\prime}} \sup _{\alpha \in I_{M} \cap \mathbb{Q}} G(j, h, \alpha)+\mathbb{E}_{g, g^{\prime}} \sup _{h \geqslant 1}\left|\lambda_{h} \sigma_{h}\right|\right)
$$

where $\left(\lambda_{h}\right)_{h \geqslant 1}$ is an isonormal sequence. The inequality :

$$
\frac{\Lambda(\Lambda-1)}{2} \leqslant h \leqslant \frac{\Lambda(\Lambda+1)}{2}
$$

gives a polynomial dependence between $\Lambda$ and $h$, hence :

$$
\sigma_{h}=\mathcal{O}\left(\frac{1}{\sqrt{\log h}}\right)
$$

and the first term in the right hand side of inequality (23) is dealt with in the same way as before. Finally, we get :

$$
\mathbb{E}_{g, g^{\prime}} \sup _{(\lambda, \Lambda) \in H} \sup _{\alpha \in I_{M} \cap \mathbb{Q}} G(j, \lambda, \Lambda, \alpha) \leq C\left(1+\sup _{N \geqslant 1} \sqrt{\frac{\log ^{+}\left(\left|X_{N}\right|\right)}{\log \Phi_{\beta}(N)}}\right)
$$

That is to say, by integrating on the whole space,
$\mathbb{E}_{X} \sup _{1 \leq j \leq n} \mathbb{E}_{g, g^{\prime}} \sup _{(\lambda, \Lambda) \in H} \sup _{\alpha \in I_{M} \cap \mathbb{Q}} G(j, \lambda, \Lambda, \alpha) \leq C\left(1+\mathbb{E}_{X} \sup _{N \geqslant 1} \sqrt{\frac{\log ^{+}\left(\left|X_{N}\right|\right)}{\log \Phi_{\beta}(N)}}\right)$

Let us prove that

$$
\mathbb{E}_{X} \sup _{N \geqslant 1} \sqrt{\frac{\log ^{+}\left(\left|X_{N}\right|\right)}{\log \Phi_{\beta}(N)}}<\infty
$$

Using Jensen inequality, we can get rid of the square root. Let $\delta>0$. For all $N \geqslant 1$, we have

$$
\beta \log ^{+}\left|X_{N}\right| \leq \beta \log ^{+}\left[\frac{\left|X_{N}\right|}{\Phi_{\beta}^{\delta}(N)}\right]+\beta \log ^{+}\left[\Phi_{\beta}^{\delta}(N)\right]
$$

noticing that $\left.\Phi_{\beta}^{\delta}(N)\right) \geqslant 2$ it is sufficient to show

$$
\mathbb{E} \sup _{N \geqslant 1} \log ^{+}\left[\frac{\left|X_{N}\right|^{\beta}}{\Phi_{\beta}^{\delta \beta}(N)}\right]<\infty
$$

Using now the inequality $\log ^{+}(x) \leq x$ for any $x \geqslant 0$, it is sufficient to prove

$$
\sum_{N \geqslant 1} \frac{\mathbb{E}\left|X_{N}\right|^{\beta}}{\Phi_{\beta}^{\delta \beta}(N)}<\infty
$$

And as $\mathbb{E}\left|X_{N}\right|^{\beta} \leqslant \Phi_{\beta}(N)$ and $\Phi_{\beta}(N) \geqslant N$, if we chose $\delta=\frac{3}{\beta}$ we get the conclusion. Steps 3 (see 21), step 4 (see 24) lead us to the announced result of theorem 1.5.

## 4. Applications

Let us begin by giving an example where the $\left(X_{k}\right)$ are uniformly distributed :

Example 4.1. Suppose that $\mathcal{L}\left(X_{k}\right)=\mathcal{U}\left(\left[\mu_{k}-\sigma_{k} / 2, \mu_{k}+\sigma_{k} / 2\right]\right)$ with $\sigma_{k}>0$ et $\mathbb{E}\left(X_{k}\right)=\mu_{k}$ with $\mu_{k}=\mathcal{O}\left(k^{d}\right)$ for some $d>0$. The characteristic function of $X_{k}$ can easily be computed :

$$
\varphi_{X_{k}}(t)=\frac{e^{2 i \pi t \mu_{k}}}{\pi t \sigma_{k}} \sin \left(\pi t \sigma_{k}\right)
$$

Using condition $\mathcal{H}$ of theorem 1.1, the following condition

$$
\begin{equation*}
\sum_{n \geqslant 1} \frac{\left|a_{n}\right|}{\sigma_{n}} \text { converges } \tag{25}
\end{equation*}
$$

and

$$
\sum_{n \geqslant 1} \frac{\sqrt{\sum_{k \geqslant n}\left|a_{k}\right|^{2}}}{n \sqrt{\log n}}<+\infty
$$

are sufficient to get the desired convergence.
Notice that using corollary 1.2, condition (25) is replaced by

$$
\sum_{n \geqslant 1} \frac{1}{\sigma_{n}^{2}}<+\infty
$$

The subexponential case could be dealt with in the same way. If we consider the border case $a_{k}=\mathcal{O}\left(k^{-1 / 2-\varepsilon}\right)$, it is sufficient that :

$$
\exists \eta>0, \sigma_{k} \geqslant k^{\frac{1}{2}+\eta}
$$

in this case :

$$
\mathbb{P}\left\{\forall k, X_{k} \in\left[\mu_{k}-\frac{k^{\frac{1}{2}+\eta}}{2}, \mu_{k}+\frac{k^{\frac{1}{2}+\eta}}{2}\right]\right\}=1
$$

which gives an information on the possible dispersion of the variables $X_{k}$.
Here are other examples where the conditions of our theorems can be quite easily verified.

Corollary 4.1. Let $\left(X_{k}\right)_{k \geqslant 1}$ be a sequence of real independent random variables whose law can be written in the following way for all $k \geqslant 1$ : $\mathcal{L}\left(X_{k}\right)=\mathcal{L}\left(\sigma_{k} \cdot X+\mu_{k}\right)$ where $X$ verifies $\mathbb{E}|X|^{\beta}<\infty$ for some $\beta>0$. Moreover, we assume that there exist $d>0$ and $\delta>0$ such that $\left|\sigma_{k}\right|=\mathcal{O}\left(k^{d}\right)$, $\left|\mu_{k}\right|=\mathcal{O}\left(k^{d}\right)$, the application $t \mapsto t^{\delta} \mathbb{E} \exp (2 i \pi t X)$ is bounded on $\mathbb{R}$, and let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of real or complex numbers satisfying the following two conditions
(1) $\left|a_{k}\right|=O\left(k^{-\beta}\right)$ with $\beta>1 / 2$
(2) $\sum_{k=1}^{\infty} \frac{1}{\left|\sigma_{k}\right|^{2 \delta}}<\infty$

Then there exists a measurable set $\Omega_{o}$ with full measure $\left(\mathbb{P}\left(\Omega_{o}\right)=1\right)$ such that for any $\omega \in \Omega_{o}$ for all $f \in B(\mathbb{T})$ such that $\int_{\mathbb{T}} f(t) d t=0$ : for any compact $K$ which does not contain 0 , the application $t \in K \mapsto F(t)=$ $\sum_{k \geqslant 1} a_{k} f\left(t X_{k}(\omega)\right)$ is continuous and the series defining $F$ converges uniformly on $K$.

The proof of corollary 4.1 relies on corollary 1.3 .
Example 4.2. The random variable $X$ may have a gaussian law with mean zero and variance one, a Cauchy law, the first Laplace law, an exponential law with parameter $\lambda>0$. Let us precise the gaussian case.
Here $\mathcal{L}(X)=\mathcal{N}(0,1)$, we have $\mathbb{E} \exp 2 i \pi t X=e^{-t^{2} / 2}$. Hence we can use the fact that $t \mapsto e^{t^{2} / 2} \mathbb{E} \exp 2 i \pi t X$ is bounded on $\mathbb{R}$. In this case, the sufficient condition to obtain convergence is

$$
\forall \varepsilon>0, \exists N>0, \sup _{m>n \geqslant N} \sup _{\alpha \in K} \sup _{j \in \mathbb{Z}-\{0\}}\left|\sum_{k=n}^{m} a_{k} e^{2 i \pi \alpha \mu_{k} j} e^{-j^{2} \alpha^{2} \sigma_{k}^{2} / 2}\right|<\varepsilon
$$

Let $d(0, K)$ be the distance between 0 and the compact $K$. Using the fact that $\left|a_{k}\right|=O\left(k^{-\beta}\right)$ with $\beta>1 / 2$, the previous condition will be satisfied as soon as :

$$
\exists \varepsilon>0, \sigma_{k} \geqslant \frac{\sqrt{2(1-\beta+\varepsilon)}}{d(0, K)} \sqrt{\log k}
$$

which, in terms of dispersion of the variables $X_{k}$ means that infinitely often:

$$
X_{k} \in\left[\mu_{k}-3 \frac{\sqrt{2(1-\beta+\varepsilon)}}{d(0, K)} \sqrt{\log k}, \mu_{k}+3 \frac{\sqrt{2(1-\beta+\varepsilon)}}{d(0, K)} \sqrt{\log k}\right]
$$

We discuss now the case when the laws of $X_{k}$ are generated by a convolution product of a given law $\mu$. We distinguish two cases : on one hand when the support of $\mu$ contains non integer values, on the other hand when the support of $\mu$ is contained in $\mathbb{Z}$. The first case is discribed by the following corollary :

Corollary 4.2. Let $\left(X_{k}\right)_{k \geqslant 1}$ be an sequence of real valued independent random variables such that for all integer $k \geqslant 1, \mathcal{L}\left(X_{k}\right)=\mu^{* k}$ where $\mu$ is a probability measure on $\mathbb{R}$ with $\mathbb{E}\left|X_{1}\right|^{\delta}<\infty$ for some $\delta$. Assume the following :
(a) $\quad \varphi_{X_{1}}(t)=1 \Longleftrightarrow t=0 \quad\left(X_{1}\right.$ aperiodic)
(b) $\exists \delta>0, \quad \quad \sup _{t \in \mathbb{R}}\left|t^{\delta} \mathbb{E} \exp \left(2 i \pi t X_{1}\right)\right|=q<\infty$

Let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of real or complex numbers such that the sequence $\left|a_{k}\right|$ is decreasing and fulfills the two following conditions:
(1) $\left|a_{k}\right|=O\left(k^{-\beta}\right)$ avec $\beta>1 / 2$
(2) $\sum_{k=1}^{\infty}\left|a_{k}-a_{k+1}\right|<\infty$

Then there exists a measurable set $\Omega_{0}$ with full measure $\left(\mathbb{P}\left(\Omega_{o}\right)=1\right)$ such that for any $\omega \in \Omega_{o}$, for all $f \in B(\mathbb{T})$ such that $\int_{\mathbb{T}} f(t) d t=0$, for any compact $K$ which does not contain 0 , the application $t \in K \mapsto F(t, \omega)=$ $\sum_{k \geqslant 1} a_{k} f\left(t X_{k}(\omega)\right)$ is continuous and the series defining $F$ converges uniformly on $K$.

Remark 4.1. If $X_{1}$ is striclty aperiodic $\left(\left|\varphi_{X_{1}}(t)\right|=1 \Longleftrightarrow t=0\right)$, then the condition on the differences $\left|a_{k}-a_{k+1}\right|$ may be removed, using corollary 1.5 and the same kind of conputation as in the following proof.

The random variable $X_{1}$ being real valued, its characteristic function is not periodic. Take for example a gaussian law with mean zero and variance one.
Proof : Let $K$ be a compact which does not contain 0. Using Abel 's summation, it is sufficient to prove

$$
\sup _{t \in K} \sup _{|j| \geqslant 1}\left|\sum_{k=1}^{N}\left(\mathbb{E} \exp 2 i \pi j t X_{1}\right)^{k}\right|<\infty
$$

independently of $N$. Let us split the supremum on $j$ respectively into the supremum on the indexes $J(q)$ and $\bar{J}(q)$ where $J(q)=\left\{j \in \mathbb{Z}^{*}:|j|^{\delta} \leq\left[\frac{2 q}{\varepsilon^{\delta}}\right]\right\}$ and $2 \varepsilon$ is the distance between 0 and the fixed compact $K$.
On one hand, using $(a)$, it can be proved that:
$\forall \varepsilon>0$

$$
\inf _{|t|>\varepsilon}|t|^{\delta}\left|1-\mathbb{E} \exp \left(2 i \pi t X_{1}\right)\right|>0
$$

this implies

$$
\sup _{t \in K} \sup _{j \in J(q)}\left|\sum_{k=1}^{N}\left(\mathbb{E} \exp 2 i \pi j t X_{1}\right)^{k}\right| \leq \sup _{t \in K} \sup _{j \in J(q)} C(\varepsilon)|j t|^{\delta} \leq C(K)\left[\frac{2 q}{\varepsilon^{\delta}}\right]
$$

On the other hand, using (b),

$$
\begin{aligned}
\sup _{t \in K} \sup _{j \in \bar{J}(q)}\left|\sum_{k=1}^{N}\left(\mathbb{E} \exp 2 i \pi j t X_{1}\right)^{k}\right| & \leq \sup _{t \in K} \sup _{j \in \bar{J}(q)} \sum_{k=1}^{N}\left(\frac{q}{|t j|^{\delta}}\right)^{k} \\
& \leq C \sum_{k=1}^{N} \frac{1}{2^{k}} \leq 2 C
\end{aligned}
$$

where $C$ is a universal constant.

As for the integer valued case, we have :
Corollary 4.3. Let $\left(X_{k}\right)_{k \geqslant 1}$ be an sequence of integer valued independent random variables such that for all integer $k \geqslant 1, \mathcal{L}\left(X_{k}\right)=\mu^{* k}$ where $\mu$ is a probability measure on $\mathbb{R}$ with $\mathbb{E}\left|X_{1}\right|^{\beta}<\infty$ for some $\beta>0$. Let $\left(a_{k}\right)_{k \geqslant 1}$ be a sequence of complex numbers such that $\left|a_{k}\right|=O\left(k^{-\beta}\right)$ with $\beta>1 / 2$.
Assume either :

$$
\varphi_{X_{1}}(t)=1 \Longleftrightarrow t=0 \quad \text { and } \quad \sum_{k \geqslant 1}\left|a_{k}-a_{k+1}\right| \quad \text { converges }
$$

or :

$$
\left|\varphi_{X_{1}}(t)\right|=1 \Longleftrightarrow t=0
$$

Then there exists a measurable set $\Omega_{o}$ with full measure $\left(\mathbb{P}\left(\Omega_{o}\right)=1\right)$ such that for any $\omega \in \Omega_{o}$, for all $f \in A(\mathbb{T})$ such that $\int_{\mathbb{T}} f(t) d t=0$, for any compact $K$ of the torus which does not contain 0 , the application $t \in K \mapsto$ $F(t, \omega)=\sum_{k \geqslant 1} a_{k} f\left(t X_{k}(\omega)\right)$ is continuous and the series defining $F$ converges uniformly on $K$.

Example 4.3. If the law of $X_{1}$ is a Poisson law with parameter 1, we use :

$$
\forall t \in \mathbb{T},\left|\varphi_{X_{1}}(t)\right| \leqslant e^{\cos (2 \pi t)-1}
$$
