# ASYMPTOTIC BEHAVIOR OF RANDOM DETERMINANTS IN THE LAGUERRE, GRAM AND JACOBI ENSEMBLES 


#### Abstract

We consider properties of determinants of some random symmetric matrices issued from multivariate statistics: Wishart/Laguerre ensemble (sample covariance matrices), Uniform Gram ensemble (sample correlation matrices) and Jacobi ensemble (MANOVA). If $n$ is the size of the sample, $r \leq n$ the number of variates and $X_{n, r}$ such a matrix, a generalization of the Bartlett-type theorems gives a decomposition of $\operatorname{det} X_{n, r}$ into a product of $r$ independent gamma or beta random variables. For $n$ fixed, we study the evolution as $r$ grows, and then take the limit of large $r$ and $n$ with $r / n=t \leq 1$. We derive limit theorems for the sequence of processes with independent increments $\left\{n^{-1} \log \operatorname{det} X_{n,\lfloor n t\rfloor}, t \in[0, T]\right\}_{n}$ for $T \leq 1$ : convergence in probability, invariance principle, large deviations. Since the logarithm of the determinant is a linear statistic of the empirical spectral distribution, we connect the results for marginals (fixed $t$ ) with those obtained by the spectral method. Actually, all the results hold true for $\log$ gases or $\beta$ models, if we define the determinant as the product of charges. The classical matrix models (real, complex, and quaternionic) correspond to the particular values $\beta=1,2,4$ of the Dyson parameter.

## 1. Introduction

Random determinants of symmetric matrices are of constant use in random geometry to compute volumes of parallelotopes (see Nielsen [54, Mathai 49]) and in multivariate statistics to build tests. Twenty years after the book of Girko (31), recent developments in Random Matrix Theory add a new interest to the study of their asymptotical behavior and invite to a new insight.

Let $B=\left[b_{1}, \ldots, b_{r}\right]$ be the $n \times r$ matrix with $r$ column vectors $b_{1}, \ldots, b_{r}$ of $\mathbb{R}^{n}$. If $B^{\prime}$ denotes its transpose, the determinant of the $r \times r$ Gram matrix $B^{\prime} B$ satisfies the well known Hadamard inequality (1893):

$$
\begin{equation*}
\operatorname{det} B^{\prime} B \leq\left\|b_{1}\right\|^{2} \cdots\left\|b_{r}\right\|^{2} \tag{1.1}
\end{equation*}
$$

with equality if and only if $b_{1}, \ldots, b_{r}$ are orthogonal (34). It means that the volume (or $r$-content) of the parallelotope built from $b_{1}, \ldots, b_{r}$ is maximal when the vectors are orthogonal. The quantity

$$
h(B)=\frac{\operatorname{det} B^{\prime} B}{\left\|b_{1}\right\|^{2} \cdots\left\|b_{r}\right\|^{2}}
$$

is usually called the Hadamard ratio. If we replace sequentially $b_{i}$ by its projection $\widehat{b}_{i}$ on the orthogonal of the subspace spanned by $b_{1}, \ldots, b_{i-1}$ (GramSchmidt orthogonalization), we have

$$
\operatorname{det} B^{\prime} B=\prod_{i=1}^{r}\left\|\widehat{\widehat{b}}_{i}\right\|^{2} .
$$

Motivated by basis reduction problems, Schnorr (61) defined the orthogonality defect as the quantity $1 / \sqrt{h(B)}$ (see also Akhavi [3] and references therein). Abbott and Mulders [1], Dixon [21] are concerned with the tightness of the bound $h(B) \leq 1$ when $B$ is random and $n=r$. For these authors, the random vectors $b_{i}$ are sampled independently and uniformly on the unit sphere $\mathbb{S}_{n-1}=\left\{\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{n}: \sum x_{i}^{2}=1\right\}$. It is known that then the variables $\left\|\widehat{b}_{i}\right\|^{2}$ are independent and Beta distributed with varying parameters. When the entries of the matrix $B$ are independent and $\mathcal{N}(0,1)$, the variables $\left\|\widehat{b}_{i}\right\|^{2}$ are independent and Gamma distributed with varying parameters (Bartlett).

Writing $B_{n, r}$ instead of $B$ to stress on dimensions and $X_{n, r}=B_{n, r}^{\prime} B_{n, r}$, we are interested in this paper in the asymptotic behavior of $\operatorname{det} X_{n, r}$ when $n$ and $r$ both tends to infinity, in the regime $r / n \rightarrow c \in[0,1]$. Since the construction of the $\widetilde{b}_{i}$ is recursive, it is possible (for fixed $n$ ) to consider the whole sequence of variables $\left\{\operatorname{det} X_{n, r}, r=1, \ldots, n\right\}$ at the same time.

It corresponds to the decomposition of the determinant of a symmetric positive matrix $A$ as

$$
\operatorname{det} A=\prod_{j=1}^{r} \frac{\operatorname{det} A^{[j]}}{\operatorname{det} A^{[j-1]}},
$$

where $A^{[j]}$ is the $j \times j$ upper-left corner of $A$ with the convention $\left|A^{[0]}\right|=1$. When using this approach, we will refer to it as the decomposition method.

The decomposition method is also valid when entries of the matrix are complex, considering the Hermitian conjugate $B^{\star}$ and then $B^{\star} B$, and also when the entries are real quaternions, considering the dual $B^{\dagger}$ and then $B^{\dagger} B$.

In these three cases, a Bartlett-type theorem gives the determinant as a product of independent variables, with Gamma or Beta distributions. Passing to logarithms, it is then possible to consider a triangular array of variables and a process with independent increments $\left\{n^{-1} \log \operatorname{det} X_{n,\lfloor n t\rfloor}, t \in[0, T]\right\}_{n}$ for $T \leq 1$ indexed by the "time" $t=r / n$. Thanks to the additive structure of the log det, we obtained the classical limit theorems: convergence in probability, invariance principle, large deviations.

The same is true for random matrices following the Jacobi (or MANOVA) distribution. Actually, the whole construction is possible in the so-called $\beta$ models, which are an extension of the above ones, which correspond to the three-fold way $\beta=1,2,4$ of Dyson. For other values of $\beta$ they are not properly matrix models but log gases models, in which the eigenvalues are replaced by charges and determinants by products of charges.

Of course, for $r$ fixed, there is also another underlying structure of product: the determinant as the product of eigenvalues, but it is not "dynamic": if you change $r$, the whole set of eigenvalues is changing. When using this approach, we will refer to it as the spectral method.

In Section 2 we set the framework. We begin with the matrix models (Wishart-Laguerre, Uniform Gram and Jacobi), and proceed with the $\beta$ models and processes of determinants. We end with reviewing the asymptotical behavior of empirical spectral distributions, i.e. convergence to the Marčenko-Pastur distribution in the Wishart-Laguerre case and to the generalized McKay distribution in the Jacobi case.

The main results of this paper are in Section 3: laws of large numbers and fluctuations, large deviations and variational problems. The comparison of results obtained by the two methods (decomposition and spectral) deserves interest and is the topic of Section 4. Some extensions to other models are given in Subsection 4.4.

Sections 5, 6 and 7 are devoted to the proofs. In Appendix 1 we gather some details on the Binet formula on the Gamma function which are of constant use in this paper, and Appendix 2 gives identification of the McKay distribution.

## 2. Notation and known facts

In this long section, we present our different models whose common feature is to give birth to processes of random determinants with independent multiplicative factors. The distribution of these factors are recorded in Proposition 2.1 for real matrix models, and settled in formulae (2.2), (2.3) and (2.4) for the (other) $\beta$-models. In section 2.4, we give the exact expression of the liming spectral distributions to be able to quote them later in section 3.3 when comparing

Throughout, $|A|$ stands for $\operatorname{det} A$, and $I_{n}$ for the $n \times n$ identity matrix.
2.1. Real matrix models and Bartlett-type theorems. In the basic model, we consider independent random vectors $b_{i}, i \geq 1$ with the same distribution $\nu_{n}$ in $\mathbb{R}^{n}$. The most important example is the Gaussian one with $\nu_{n}=\mathcal{N}\left(0, I_{n}\right)$. If $B=\left[b_{1}, \ldots, b_{r}\right]$, all the entries of $B$ are independent $\mathcal{N}(0,1)$ and the distribution of $W=B^{\prime} B$ is denoted by $W_{r}(n, \mathbb{R})$ and called the Wishart ensemble. For $r \leq n$, its density on the space $\mathcal{S}_{r}$ of symmetric positive matrix is

$$
\frac{1}{2^{r n / 2} \Gamma_{r}(n / 2)}|W|^{(n-r-1) / 2} \exp \left(-\frac{1}{2} \operatorname{tr} W\right)
$$

where $\Gamma_{r}$ is the multivariate Gamma function

$$
\Gamma_{r}(\alpha)=\pi^{r(r-1) / 4} \Gamma(\alpha) \Gamma\left(\alpha-\frac{1}{2}\right) \cdots \Gamma\left(\alpha-\frac{r-1}{2}\right)
$$

It is the matrix variate extension of the Gamma distribution. Recall that for $a, c>0$, the Gamma $(a, c)$ distribution has density

$$
\frac{c^{a}}{\Gamma(a)} x^{a-1} e^{-c x} \quad(x>0) .
$$

For $r>n$, the matrix is singular.
Motivated by Hadamard inequality (1.1), we may choose $\nu_{n}$ to be the uniform distribution on the unit sphere $\mathbb{S}_{n-1}=\left\{\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{R}^{n}: \sum x_{i}^{2}=1\right\}$. The corresponding ensemble for $B$ is called Uniform Spherical Ensemble by Donoho in [22. The matrix ensemble for $B^{\prime} B$ is called the Gram ensemble by De Cock, Fannes and Spincemaille [15], since $B^{\prime} B$ is the Gram matrix built from the $b_{i}$ 's. To stress on the distribution, we call it Uniform Gram ensemble. The diagonal entries are one and for $r \leq n$, the joint density of the non-diagonal entries ( $r_{i j}, 1 \leq i<j \leq r$ ) of the matrix $G=B^{\prime} B$ is

$$
\begin{equation*}
\frac{[\Gamma(n / 2)]^{r}}{\Gamma_{r}(n / 2)}|G|^{(n-r-1) / 2} \quad\left(-1<r_{i j}<1\right) \tag{2.1}
\end{equation*}
$$

(see Gupta and Nagar [33] Theorem 3.3.24 p. 107, Mathai [47) Example 1.25 and 48 p.58).

Let us now introduce Jacobi ensembles. For $n_{1}, n_{2} \geq 1$ and $r \leq n:=n_{1}+n_{2}$, we can decompose every $\left(n_{1}+n_{2}\right) \times r$ matrix $M$ in two blocks

$$
M=\binom{M_{1}}{M_{2}}
$$

with $M_{1}$ of type $n_{1} \times r$ and $M_{2}$ of type $n_{2} \times r$. If the entries of $M$ are independent $\mathcal{N}(0,1)$, then $W_{1}:=M_{1}^{\prime} M_{1}$ and $W_{2}:=M_{2}^{\prime} M_{2}$ are independent Wishart matrices of distribution $W_{r}\left(n_{1}, \mathbb{R}\right)$ and $W_{r}\left(n_{2}, \mathbb{R}\right)$, respectively. It is well known that $W_{1}+W_{2}$ is $W_{r}\left(n_{1}+n_{2}, \mathbb{R}\right)$ distributed and a.s. invertible. Let us denote by $\left(W_{1}+W_{2}\right)^{1 / 2}$ the symmetric positive square root of $\left(W_{1}+W_{2}\right)$. The $r \times r$ matrix

$$
\mathcal{X}:=\left(W_{1}+W_{2}\right)^{-1 / 2} W_{1}\left(W_{1}+W_{2}\right)^{-1 / 2}
$$

is has a distribution denoted by $J_{r}\left(n_{1}, n_{2}, \mathbb{R}\right)$ and called the Jacobi ensemble.
If $T$ is upper triangular with positive diagonal entries and $W_{1}+W_{2}=T^{\prime} T$ (Cholesky decomposition) then

$$
\mathcal{Z}=\left(T^{\prime}\right)^{-1} W_{1} T^{-1}
$$

is also $J_{r}\left(n_{1}, n_{2}, \mathbb{R}\right)$ distributed, (see 55], 52] p.108).
Another occurrence of the Jacobi ensemble is interesting (see Doumerc [23], Collins [13]). If $M$ is as above, its singular value decomposition is

$$
M=U D V \quad, \quad D=\binom{\Delta}{0}
$$

with $D$ of type $n \times r$, with $\Delta$ diagonal with nonnegative entries, with $U \in O(n)$ and $V \in O(r)$ (the orthogonal groups). Although $U$ and $V$ are not uniquely determined, one can choose them according to the Haar distribution on their respective group and such that $U, V, \Delta$ are independent. Then $M^{\prime} M=V^{\prime} \Delta^{2} V$ and

$$
\left(W_{1}+W_{2}\right)^{1 / 2}=\left(M^{\prime} M\right)^{1 / 2}=V^{\prime} \Delta V
$$

Let $Y_{r}=U^{\left[n_{1}, r\right]}$ the $n_{1} \times r$ upper-left corner of $U$. Since $M_{1}=Y_{r} \Delta V$ we have

$$
M_{1}^{\prime} M_{1}=V^{\prime} \Delta Y_{r}^{\prime} Y_{r} \Delta V=\left(M M^{*}\right)^{1 / 2}\left(V^{\prime} Y_{r}^{\prime} Y_{r} V\right)\left(M M^{*}\right)^{1 / 2}
$$

and then $\mathcal{X}=\left(Y_{r} V\right)^{\prime}\left(Y_{r} V\right) \stackrel{(d)}{=} Y_{r}^{\prime} Y_{r}$. In other words,

$$
\mathcal{Y}:=\left(U^{\left[n_{1}, r\right]}\right)^{\prime} U^{\left[n_{1}, r\right]}
$$

is also $J_{r}\left(n_{1}, n_{2}, \mathbb{R}\right)$ distributed.
If $r \leq \min \left(n_{1}, n_{2}\right)$, the distribution $J_{r}\left(n_{1}, n_{2}, \mathbb{R}\right)$ has a density on $\mathcal{S}_{r}$ which is

$$
\begin{equation*}
\frac{1}{\beta_{r}\left(\frac{n_{1}}{2}, \frac{n_{2}}{2}\right)}|\mathcal{Z}|^{\frac{n_{1}-r-1}{2}}\left|I_{r}-\mathcal{Z}\right|^{\frac{n_{2}-r-1}{2}} \mathbb{I}_{0<\mathcal{Z}<I_{r}} \tag{2.2}
\end{equation*}
$$

where

$$
\beta_{r}(a, b)=\frac{\Gamma_{r}(a) \Gamma_{r}(b)}{\Gamma_{r}(a+b)},
$$

(see for example Muirhead [52] Theorem 3.3.1). It is the matrix variate extension of the beta distribution. Recall that for $a>0, b>0$, the $\operatorname{Beta}(a, b)$ distribution has density

$$
\begin{equation*}
\frac{\Gamma(a+b)}{\Gamma(a) \Gamma(b)} x^{a-1}(1-x)^{b-1} \quad(x>0) . \tag{2.3}
\end{equation*}
$$

Until now, we had $r$ fixed. Our purpose is now to consider all values of $r$ simultaneously to give a "sample path" study of determinants.

For an $n \times n$ matrix $B=\left[b_{1}, \ldots, b_{n}\right]$, we have for $r \leq n$

$$
\left(B^{\prime} B\right)^{[r]}=\left(B^{[n, r]}\right)^{\prime} B^{[n, r]},
$$

and for every $j \leq n$, the quantity

$$
\begin{equation*}
\rho_{j, n}:=\frac{\left|\left(B^{\prime} B\right)^{[j]}\right|}{\left|\left(B^{\prime} B\right)^{[j-1]}\right|} \tag{2.4}
\end{equation*}
$$

is a measurable function of $\left(b_{1}, \ldots, b_{j}\right)$ and

$$
\begin{equation*}
\left|\left(B^{\prime} B\right)^{[r]}\right|=\prod_{j=1}^{r} \rho_{j, n} . \tag{2.5}
\end{equation*}
$$

The same occurs with $\widetilde{b}_{i}:=b_{i} /\left\|b_{i}\right\|$ instead of $b_{i}(i=1, \ldots, n)$ and $\widetilde{B}:=$ $\left[\widetilde{b}_{1}, \ldots, \widetilde{b}_{n}\right]$ instead of $B$. Let us note that $\widetilde{\rho}_{1, n}=1$ and

$$
\begin{equation*}
\widetilde{\rho}_{j, n}=\frac{\left|\widetilde{W}^{[j]}\right|}{\left|\widetilde{W}^{[j-1]}\right|}=\frac{\left|W^{[j]}\right|}{\left|W^{[j-1]}\right| W_{j j}}=\frac{\rho_{j, n}}{\left\|b_{j}\right\|^{2}}, j=2, \ldots, n, \tag{2.6}
\end{equation*}
$$

so that

$$
\begin{equation*}
\left|\left(\widetilde{B}^{\prime} \widetilde{B}\right)^{[r]}\right|=\prod_{j=1}^{r} \widetilde{\rho}_{j, n} \tag{2.7}
\end{equation*}
$$

The Wishart case and the Uniform Gram case corresponds (2.5) and (2.7) respectively, for $r=1, \ldots, n$.

In the Jacobi case, $r \in\left\{1, \ldots, n_{1}\right\}$. If $M=\left[b_{1}, \ldots, b_{n_{1}}\right]$, and if $T, W_{1}, \mathcal{Z}$ are defined as above with $n_{1}$ instead of $r$, then

$$
\mathcal{Z}^{[r]}=\left(\left(T^{[r]}\right)^{\prime}\right)^{-1} W_{1}^{[r]}\left(T^{[r]}\right)^{-1} .
$$

For every $j$, the quantity

$$
\rho_{j, n_{1}, n_{2}}^{\mathcal{Z}}:=\frac{\left|\mathcal{Z}^{[j]}\right|}{\left|\mathcal{Z}^{[j-1]}\right|}
$$

is a measurable function of $\left(b_{1}, \ldots, b_{j}\right)$ and

$$
\left|\mathcal{Z}^{[r]}\right|=\prod_{j=1}^{r} \rho_{j, n_{1}, n_{2}}^{\mathcal{Z}}
$$

It can be noticed that

$$
\rho_{j, n_{1}, n_{2}}^{\mathcal{Z}}=\frac{\left|W_{1}^{[j]}\right|}{\left|W_{1}^{[j]}+W_{2}^{[j]}\right|} \times \frac{\left|W_{1}^{[j-1]}+W_{2}^{[j-1]}\right|}{\left|W_{1}^{[j-1]}\right|}
$$

Besides, the construction with the symmetric square root is different. If

$$
\rho_{j, n_{1}, n_{2}}^{\mathcal{X}}:=\frac{\left|\mathcal{X}^{[j]}\right|}{|\mathcal{X}[j-1]|}
$$

we have

$$
\mathcal{X}^{[r]} \neq\left(W_{1}^{[r]}+W_{2}^{[r]}\right)^{-1 / 2} W_{1}^{[r]}\left(W_{1}^{[r]}+W_{2}^{[r]}\right)^{-1 / 2}
$$

(Take $n_{1}=n_{2}=2, W_{1}=I_{2}, W_{2}=\left(\begin{array}{cc}1 & s \\ s & 1\end{array}\right)$ and $r=1$ then

$$
\left(W_{1}^{[1]}+W_{2}^{[1]}\right)^{-1 / 2} W_{1}^{[r]}\left(W_{1}^{[r]}+W_{2}^{[r]}\right)^{-1 / 2}=2 /\left(4-s^{2}\right)
$$

and $\left.\mathcal{X}^{[1]}=1 / 2\right)$. Moreover we cannot say that $\rho_{j, n_{1}, n_{2}}^{\mathcal{X}}$ is measurable with respect to $b_{1}, \ldots, b_{j}$.

Let us consider the construction from contraction of Haar matrices. Since

$$
\left(\left(U^{\left[n_{1}\right]}\right)^{\prime} U^{\left[n_{1}\right]}\right)^{\left[n_{1}, r\right]}=\left(U^{\left[n_{1}, r\right]}\right)^{\prime} U^{\left[n_{1}, r\right]}
$$

we see that the quantity

$$
\rho_{n_{1}, n_{2}, j}^{\mathcal{Y}}:=\frac{\left|\mathcal{Y}^{[j]}\right|}{\left|\mathcal{Y}^{[j-1]}\right|}
$$

depends only on the $j$ first columns of the matrix $U$, and

$$
\left|\mathcal{Y}^{[r]}\right|=\prod_{j=1}^{r} \rho_{n_{1}, n_{2}, j}^{\mathcal{Y}}
$$

It is possible to introduce a probability space on which all Uniform Gram and Wishart matrices are defined for all values of $n$ simultaneously. It is enough to consider the infinite product space generated by a double infinite sequence of independent $\mathcal{N}(0,1)$ variables $\left\{b_{i, j}\right\}_{i, j=1}^{\infty}$, and for every $n$ to perform the above constructions with $b_{i}=\left(b_{1 i}, \ldots, b_{n, i}\right)^{\prime}$. To embed the Jacobi matrices in this framework, we have to restrict ourselves to the $\mathcal{X}$-type and $\mathcal{Z}$-type ones; however, only the $\mathcal{Z}$ one gives a natural meaning to the dynamic study.

The starting point of our study of random determinants is the following proposition which gathers known results about the factors entering in the above decompositions.
Proposition 2.1. 1) (Bartlett) The random variables $\rho_{j, n}, j=1, \ldots, n$ are independent and

$$
\rho_{j, n} \stackrel{(d)}{=} \operatorname{Gamma}\left(\frac{n-(j-1)}{2}, \frac{1}{2}\right),
$$

where $\stackrel{(d)}{=}$ stands for equality in distribution.
2) The random variables $\widetilde{\rho}_{j, n}, j=2, \ldots, n$ are independent and

$$
\widetilde{\rho}_{j, n} \stackrel{(d)}{=} \operatorname{Beta}\left(\frac{n-j+1}{2}, \frac{j-1}{2}\right) .
$$

3) For $J=\mathcal{X}($ resp. $\mathcal{Y}, \mathcal{Z})$, the random variables $\rho_{j, n_{1}, n_{2}}^{J}, j=1, \ldots, n_{1}$ are independent and

$$
\rho_{j, n_{1}, n_{2}}^{J} \stackrel{(d)}{=} \operatorname{Beta}\left(\frac{n_{1}-j+1}{2}, \frac{n_{2}}{2}\right) .
$$

The first claim is known as the celebrated Bartlett decomposition (stated with $\chi^{2}$ distributions) (Bartlett [7]). It is quoted in many books and articles in particular Anderson [4] pp. 170-172, [52] pp. 99 Theorem 3.2.14, Kshirsagar [43], Gupta and Nagar [33] Theorem 3.3.4 p. 91 and ex. 3.8 p.127. The second claim may be found in [4] Theorem 9.3.3. In the third claim, we first notice that it is enough to get the proof for $\mathcal{Z}$ since the three random matrices have the same distribution. It is a consequence of a result quoted in 4], due to Kshirsagar, is quoted and proved in 52 Theorem 3.3 .1 p. 110 under the assumption $r \leq n_{1}, n_{2}$ and in Rao [57] p. 541 under the only assumption $r \leq n_{1}$. Actually (see [52] ex 3.24) and Theorem 8.4.1 in 4], Some proofs use probabilistic arguments (as 57] and [4), Jacobian arguments (as in (33] Theorem 5.3.24 p. 181), or Mellin transform arguments (as in in 49] Theorem $2)$.
2.2. Distribution of eigenvalues and $\beta$-models. Since a long time, random matrices with complex entries were studied : complex Wishart by Goodman [32] and less often with quaternionic entries. We do not give details on the complex and quaternionic cases but jump to a general framework. Popularized by physicists, the modern point of view consists in introducing a parameter $\beta$ taking value 1 when real, 2 when complex, and 4 when quaternionic, this parameter playing the role of an inverse temperature. The above constructions can be extended when replacing the transpose $(\mathbb{R}$ case) by the adjoint ( $\mathbb{C}$ case) or the dual ( $\mathbb{H}$ case). Many of the above results are then true when replacing in displays the factor $1 / 2$ by the factor $\beta / 2$. Actually there are two ways to reach the law of determinants :
a) directly from the distribution of matrices, and using the decomposition method quoted above,
b) from the joint distribution of eigenvalues.

The second way has been used to define the so-called $\beta$-models, see for instance Forrester 28 ] chap. 2. The idea of extending the range of $\beta$ to $(0, \infty)$ is quite natural. It has be shown recently that they correspond also to models of (sparse) random matrices (see Dumitriu and Edelman [24], Killip and Nenciu 42], Edelman and Sutton [26]).

Because of the connections with orthogonal polynomials in the complex case, the extended families are called $\beta$-Laguerre ensemble (or just Laguerre ensemble) instead of Wishart ensemble and $\beta$-Jacobi ensemble (or just Jacobi ensemble) instead of MANOVA or Beta ensemble.

Throughout, we use the symbol $\beta^{\prime}$ for $\beta / 2$ to simplify displays.
2.2.1. Laguerre. When $\beta=1,2,4$ the joint probability density of the eigenvalues $\lambda_{j}, j=1, \ldots, r$ of $W$ on the orthant $\lambda_{j}>0, j=1, \ldots, r$ is

\frac{1}{Z_{r}^{L, \beta}(n)} \prod_{j=1}^{r}\left(\lambda_{j}^{\beta^{\prime}(n-r+1)-1} \mathrm{e}^{-\beta^{\prime} \lambda_{j}}\right) \prod_{1 \leq j<k \leq r}\left|\lambda_{k}-\lambda_{j}\right|^{2 \beta^{\prime}} \tag{2.8}
\end{equation*}
$$

and the normalizing constant is

Z_{r}^{L, \beta}(n)=\left(\frac{1}{\beta^{\prime}}\right)^{\beta^{\prime} r n} \prod_{j=1}^{r} \frac{\Gamma\left(1+\beta^{\prime} j\right) \Gamma\left(\beta^{\prime}(n-j+1)\right)}{\Gamma\left(1+\beta^{\prime}\right)}
$$

It is a Selberg integral (see for instance Edelman and Rao [25], formula 4.6 and references therein).

When $\beta>0$ is not $1,2,4$, we consider the density (2.8) on $\mathbb{R}^{r}$. We also denote the product $\prod_{j=1}^{r} \lambda_{j}$ by $|W|$. This gives the Mellin transform

\mathbb{E}|W|^{\beta^{\prime} s}=\frac{Z_{r}^{L, \beta}(n+s)}{Z_{r}^{L, \beta}(n)}=\left(\frac{1}{\beta^{\prime}}\right)^{\beta^{\prime} r s} \prod_{k=1}^{r} \frac{\Gamma\left(\beta^{\prime}(n-k+1+s)\right)}{\Gamma\left(\beta^{\prime}(n-k+1)\right)} .
$$

Remembering that if $X \stackrel{(d)}{=} \operatorname{Gamma}(a, 1 / 2)$ then

we deduce the following proposition from the uniqueness of Mellin transform.

Proposition 2.2. We have

where the variables $\rho_{j, n}^{L, \beta}, j=1, \ldots, r$ are independent and

\rho_{j, n}^{L, \beta} \stackrel{(d)}{=} \operatorname{Gamma}\left(\beta^{\prime}(n-j+1), 1 / 2\right) . \tag{2.9}
\end{equation*}

We stress that our point of view is not compatible with the construction by Dumitriu and Edelman ([24]) of matrix models for the (general) $\beta$-Laguerre ensemble. Actually, they define a random $r \times r$ matrix $B^{(r)}$ where only diagonal and subdiagonal terms are nonzero, independent and satisfy (for $n$ fixed):

B_{i i}^{(r)} & \stackrel{(d)}{=} \sqrt{\operatorname{Gamma}\left(\beta^{\prime}(n-i+1), 1 / 2\right)} & (1 \leq i \leq r), \\
B_{i, i-1}^{(r)} & \stackrel{(d)}{=} \sqrt{\operatorname{Gamma}\left(\beta^{\prime}(r-i+1), 1 / 2\right)} & (2 \leq i \leq r) .
\end{array}
$$

They prove that the distribution of eigenvalues of $B^{(r)}\left(B^{(r)}\right)^{\prime}$ is precisely (2.8). Of course we recover the determinant as a product of elements with the good distribution, but the problem is that we cannot consider all $r$ simultaneously in their framework, since

2.2.2. Uniform Gram. It is useful in the study of correlations. A correlation matrix is a positive definite matrix with diagonal entries equal to one. Here, there is no explicit expression for the law of eigenvalues. However, the expression

is a density on the space of symmetric (resp. Hermitian, resp. self-dual) positive matrices with diagonal entries equal to one, and it fits with the distribution of correlation matrix in the real (see (2.1), complex and quaternion case. This yields (33) Ex. 3.26 p.130) the Mellin transform

\mathbb{E}|G|^{\beta^{\prime} s}=\frac{Z_{r}^{G, \beta}(n+s)}{Z_{r}^{G, \beta}(n)}=\prod_{j=1}^{r} \frac{\Gamma\left(\beta^{\prime}(n-j+1+s)\right) \Gamma\left(\beta^{\prime} n\right)}{\Gamma\left(\beta^{\prime}(n-j+1)\right) \Gamma\left(\beta^{\prime}(n+s)\right)}
$$

From (2.3), it is clear that if $X \stackrel{(d)}{=} \operatorname{Beta}(a, b)$ then

\mathbb{E} X^{\mu}=\frac{\Gamma(a+\mu) \Gamma(a+b)}{\Gamma(a) \Gamma(a+b+\mu)}, \mu>-a . \tag{2.10}

Again the uniqueness of the Mellin transform leads to the proposition.
Proposition 2.3. We have

where the variables $\rho_{j, n}^{G, \beta}, j=2, \ldots, r$ are independent and

\rho_{j, n}^{G, \beta} \stackrel{(d)}{=} \operatorname{Beta}\left(\beta^{\prime}(n-j+1), \beta^{\prime}(j-1)\right) . \tag{2.11}
\end{equation*}
$$

2.2.3. Jacobi. If $\mathcal{Z}$ is distributed as in (2.2), the joint density of eigenvalues on the set $\left(0<\lambda_{j}<1 j=1, \ldots, r\right)$ is given by

\frac{1}{Z_{r}\left(n_{1}, n_{2}\right)} \prod_{i=1}^{r} \lambda_{i}^{\frac{n_{1}-r-1}{2}}\left(1-\lambda_{i}\right)^{\frac{n_{2}-r-1}{2}} \prod_{1 \leq i<j \leq r}\left|\lambda_{j}-\lambda_{i}\right|,
$$

where $Z_{r}\left(n_{1}, n_{2}\right)$ is a normalizing constant (see for example 52 Theorem 3.3.4).

For $n_{2}<r<n_{1}$, the matrix $W_{2}$ is singular, and the Jacobi matrix $I-\mathcal{Z}$ has 1 as an eigenvalue with multiplicity $r-n_{2}$. The distribution of $\mathcal{Z}$ has no density. Nevertheless we may study its determinant. Indeed, the matrix $I-\mathcal{Z}$ has 0 as an eigenvalue of multiplicity $r-n_{2}$. Actually the density of the law of the non-zero eigenvalues of this matrix is known (see Srivastava 62 and Diaz-Garcia and Gutierrez Jaimez [20), so that the non-one eigenvalues of $\mathcal{Z}$ have the joint density

\frac{1}{\widetilde{Z}_{r}\left(n_{1}, n_{2}\right)} \prod_{i=1}^{n_{2}} \lambda_{i}^{\frac{n_{1}-r-1}{2}}\left(1-\lambda_{i}\right)^{\frac{r-n_{2}-1}{2}} \prod_{1 \leq i<j \leq n_{2}}\left|\lambda_{j}-\lambda_{i}\right|,
$$

where the normalizing constant is $\widetilde{Z}_{r}\left(n_{1}, n_{2}\right)=Z_{n_{2}}\left(n_{1}+n_{2}-r, r\right)$.
We now consider matrices with elements in $\mathbb{X}=\mathbb{C}$ or $\mathbb{H}$. When $r \leq$ $\min \left(n_{1}, n_{2}\right)$, the distribution of $\mathcal{Z}$ has a density proportional to

|\mathcal{Z}|^{\beta^{\prime}\left(n_{1}-r+1\right)-1}|I-\mathcal{Z}|^{\beta^{\prime}\left(n_{2}-r+1\right)-1} \mathbb{I}_{0<\mathcal{Z}<I} .

where $\beta^{\prime}=1$ or 2 . The distribution of the eigenvalues of $\mathcal{Z}$ has the density (on $[0,1]^{r}$ ) :

f_{r, n_{1}, n_{2}}^{\beta}\left(\lambda_{1}, \ldots, \lambda_{r}\right)=  \tag{2.12}\\
\frac{1}{Z_{r}^{(J, \beta)}\left(n_{1}, n_{2}\right)} \prod_{i=1}^{r} \lambda_{i}^{\beta^{\prime}\left(n_{1}-r+1\right)-1}\left(1-\lambda_{i}\right)^{\beta^{\prime}\left(n_{2}-r+1\right)-1} \prod_{1 \leq i<j \leq r}\left|\lambda_{j}-\lambda_{i}\right|^{2 \beta^{\prime}},
\end{gather*}
$$

where

$$
\begin{equation*}
Z_{r}^{(J, \beta)}\left(n_{1}, n_{2}\right)=\prod_{j=1}^{r} \frac{\Gamma\left(1+\beta^{\prime} j\right) \Gamma\left(\beta^{\prime}\left(n_{1}+j-r\right)\right) \Gamma\left(\beta^{\prime}\left(n_{2}+j-r\right)\right)}{\Gamma\left(1+\beta^{\prime}\right) \Gamma\left(\beta^{\prime}\left(n_{1}+n_{2}+j-r\right)\right)}, \tag{2.13}
\end{equation*}
$$

is the value of the Selberg integral (see Hiai and Petz [36] p. 118 and also Edelman and Rao [25] p. 19 and references therein).

In the "singular" case ( $n_{2} \leq r \leq n_{1}$ ), the density of the non-one eigenvalues is $f_{n_{2}, n_{1}+n_{2}-r, r}^{\beta}\left(\lambda_{1}, \ldots, \lambda_{n_{2}}\right)$.

We consider an extension of the above models. For every $\beta>0$, we define a family of distribution densities $\mathbf{f}_{r, n_{1}, n_{2}}^{\beta}$ on $[0,1]^{\min \left(n_{2}, r\right)}$ :

\mathbf{f}_{r, n_{1}, n_{2}}^{\beta}= \begin{cases}f_{r, n_{1}, n_{2}}^{\beta} & \text { if } r \leq \min \left(n_{1}, n_{2}\right)  \tag{2.14}\\ f_{n_{2}, n_{1}+n_{2}-r, r}^{\beta} & \text { if } n_{2} \leq r \leq n_{1}\end{cases}

We set by convention

in all cases, and we call it the determinant, even if we do not define any matrix.
For $r \leq n_{1}, n_{2}$, using (2.12) and (2.13) we get

&= \prod_{j=1}^{r} \frac{\Gamma\left(\beta^{\prime}\left(n_{1}+n_{2}+j-r\right)\right) \Gamma\left(\beta^{\prime}\left(n_{1}+j-r+s\right)\right)}{\Gamma\left(\beta^{\prime}\left(n_{1}+j-r\right)\right) \Gamma\left(\beta^{\prime}\left(n_{1}+n_{2}+j-r+s\right)\right)} \tag{2.15}
\end{align*}
$$

If $n_{2}<r \leq n_{1}$ we start directly from (2.14) and (2.13) we have

\mathbb{E}\left(\left|\mathcal{Z}_{n_{1}, n_{2}, r}\right|^{\beta^{\prime} s}\right) & =\frac{Z_{n_{2}}^{J, \beta}\left(n_{1}+n_{2}-r+s, r\right)}{Z_{n_{2}}^{J, \beta}\left(n_{1}+n_{2}-r, r\right)} \\
& =\prod_{j=1}^{n_{2}} \frac{\Gamma\left(\beta^{\prime}\left(n_{1}+j\right)\right) \Gamma\left(\beta^{\prime}\left(n_{1}+j-r+s\right)\right)}{\Gamma\left(\beta^{\prime}\left(n_{1}+j-r\right)\right) \Gamma\left(\beta^{\prime}\left(n_{1}+j+s\right)\right)} . \tag{2.16}
\end{align*}
$$

Multiplying up and down by $\prod_{k=n_{2}+1}^{r} \Gamma\left(\beta^{\prime}\left(n_{1}+k-r\right)\right) \Gamma\left(\beta^{\prime}\left(n_{1}+k-r+s\right)\right)$ we get again the right hand side of (2.15). Going back to (2.10), we have the proposition

Proposition 2.4. For $r \leq n_{1}$ :

2.3. Processes. In the three ensembles defined above, we have met arrays of independent variables with remarkable distributions. In Section 2.1, we have discussed the interest of studying all values of $r$ simultaneously in the matrix cases $(\beta=1,2,4)$. Since the structure remains the same in the $\beta$-models, it is meaningful to consider the processes (indexed by $r$ ) of partial sums. A now classical asymptotic regime is $n, r \rightarrow \infty$ with fixed ratio in the Laguerre and Uniform Gram case, and $n_{1}, n_{2}, r \rightarrow \infty$ with fixed ratios in the Jacobi case. It means that we consider the asymptotic behavior determinants in a dynamic (or path wise) way.

For the Laguerre model, we define

\log \Delta_{n, p}^{L, \beta}:=\sum_{k=1}^{p} \log \frac{\rho_{k, n}^{L, \beta}}{\beta n} \quad(p \leq n) \tag{2.18}
\end{equation*}

and the process

\Delta_{n}^{L, \beta}(t):=\Delta_{n,\lfloor n t\rfloor}^{L, \beta}, \quad t \in[0,1] \tag{2.19}
\end{equation*}

For the Uniform Gram model, we define

and the process

\end{equation*}

For the Jacobi model, we fix $\tau_{1}$ and $\tau_{2}>0$, set $n_{1}=\left\lfloor n \tau_{1}\right\rfloor, n_{2}=\left\lfloor n \tau_{2}\right\rfloor$, and define

\log \Delta_{n, p}^{J, \beta}=\sum_{k=1}^{p} \log \rho_{k, n_{1}, n_{2}}^{J, \beta} \quad\left(p \leq n_{1}\right) \tag{2.22}

and the process

\Delta_{n}^{J, \beta}(t)=\Delta_{n,\lfloor n t\rfloor}^{J, \beta}, \quad t \in\left[0, \tau_{1}\right] . \tag{2.23}
\end{equation*}
$$

There are some connections between the above processes. For instance, in the real matrix model $(\beta=1)$ we saw in (2.6) that

\rho_{j, n}^{L, 1}=\rho_{j, n}^{G, 1}\left\|b_{j}\right\|^{2},
$$

that the two random variables in the right hand side are independent and $\left\|b_{j}\right\|^{2} \stackrel{(d)}{=} \operatorname{Gamma}(n / 2,1 / 2)$.

To see these connections in the general case, we use the so-called "betagamma" algebra that will be really helpful in the sequel. Details can be found in [12] pp. 93-94. In the following relation, $\gamma(a)$ denotes a random variable with distribution $\operatorname{Gamma}(a, 1)$, and $\beta(a, b)$ denotes a random variable with distribution $\operatorname{Beta}(a, b)$. The relation is

where, on the left hand side the random variables $\gamma(a)$ and $\gamma(b)$ are independent and on the right hand side the random variables $\beta(a, b)$ and $\gamma(a+b)$ are independent. It entails in particular

From the definitions (2.18) and (2.20) and owing to the equalities in distribution (2.9) and (2.11), we have then

\end{equation*}

where $\varepsilon_{k}^{(n)}, k=1, \ldots, n$ are independent and satisfy $\varepsilon_{k}^{(n)} \stackrel{(d)}{=} \operatorname{Gamma}\left(\beta^{\prime} n, \beta^{\prime} n\right)$. In the sequel, we begin by setting the claims for the Uniform Gram process and then deduce the corresponding results for the Laguerre process.

Using the definitions (2.18) and (2.22) and the equalities in distribution (2.9) and (2.17), we get, by another application of (2.24)

\end{equation*}

where this equality holds for all indices $r=1, \ldots, n_{1}$ simultaneously, and the two processes $\log \Delta_{n}^{J, \beta}$ and $\log \Delta_{n_{1}+n_{2}}^{L, \beta}$ are independent.

It allows to deduce asymptotic results for the Jacobi model from those of the Laguerre model.

## 3. Main results

In this section, we state first a law of large numbers and fluctuations for our three models, and then the corresponding LDP for processes and marginals.

Let $D_{T}=\{v \in \mathbb{D}([0, T]): v(0)=0\}$ the set of càdlàg functions on $[0, T]$ and $D=\{v \in \mathbb{D}([0,1)): v(0)=0\}$ the set of càdlàg functions on $[0, T]$ and $[0,1)$, respectively, starting from 0 .

We use often the following entropy function

We use also the function defined in Hiai and Petz [37], for $s, t \geq 0$ :

### 3.1. Law of large numbers and fluctuations.

3.1.1. Uniform Gram ensemble. Let us define a drift and a diffusion coefficient by

K_{\beta}^{1}:=\frac{1}{2} \log (2 \pi)-\frac{\gamma}{\beta}+\int_{0}^{\infty} \frac{s f(s)}{e^{\beta s / 2}-1} d s, \tag{3.8}

3.2. Large deviations. All along this section, we use the notation of Dembo and Zeitouni [17. In particular we write LDP for Large Deviation Principle. The reader may have some interest in consulting Dette and Gamboa 19] where a similar method is used for a different model, but here we use a slightly different topology to be able to catch the marginals in $T$.

For $T<1$, let $\mathrm{M}_{T}$ be the set of signed measures on $[0, T]$ and let $\mathrm{M}_{<}$be the set of measures whose support is a compact subset of $[0,1)$.

We provide $D$ with the weakened topology $\sigma\left(D, \mathrm{M}_{<}\right)$. So, $D$ is the projective limit of the family, indexed by $T<1$ of topological spaces $\left(D_{T}, \sigma\left(D_{T}, \mathrm{M}_{T}\right)\right.$ ).

Let $V_{\ell}$ (resp. $V_{r}$ ) be the space of left (resp. right) continuous $\mathbb{R}$-valued functions with bounded variations. We put a superscript $T$ to specify the functions on $[0, T]$. There is a bijective correspondence between $V_{r}^{T}$ and $\mathrm{M}_{T}$ :

- for any $v \in V_{r}^{T}$, there exists a unique $\mu \in \mathrm{M}_{T}$ such that $v=\mu([0, \cdot])$; we denote it by $\dot{v}$,
- for any $\mu \in \mathrm{M}_{T}, v=\mu([0, \cdot])$ stands in $V_{r}$.

For $v \in D$, let $\dot{v}=\dot{v}_{a}+\dot{v}_{s}$ be the Lebesgue decomposition of the measure $\dot{v} \in \mathrm{M}([0,1))$ in absolutely continuous and singular parts with respect to the Lebesgue measure and let $\mu$ be any bounded positive measure dominating $\dot{v}_{s}$.

\end{equation*}

(2) If $\xi \in\left[\xi_{T}^{J}, 0\right)$, the equation

\mathcal{E}\left(\theta+\tau_{1}, \tau_{2}, T\right)=\xi \tag{3.51}
\end{equation*}
$$

has a unique solution $\theta \geq T-\tau_{1}$, and we have

\begin{align*}
I_{T}^{J}(\xi)=\theta \xi & -\left[F\left(\theta+\tau_{1}\right)-F\left(\theta+\tau_{1}-T\right)\right]-\left[F\left(\tau_{1}+\tau_{2}\right)-F\left(\tau_{1}+\tau_{2}-t\right)\right] \\
& +\left[F\left(\tau_{1}\right)-F\left(\tau_{1}-T\right)\right] \\
& +\left[F\left(\theta+\tau_{1}+\tau_{2}\right)-F\left(\theta+\tau_{1}+\tau_{2}-T\right)\right] . \tag{3.52}
\end{align*}
$$

(3) If $\xi<\xi_{T}^{J}$, we have

## 4. Connections with the spectral method

The logarithm of the determinant of a non singular matrix is a linear statistic of the empirical distribution of its eigenvalues, so that we may compare the above result with those obtained by this spectral approach.
4.1. Laguerre/Wishart. We start with

\frac{1}{n} \log \Delta_{n, r}^{L, \beta}=\frac{r}{n} \int(\log x) d \mu_{n, r}(x)
$$

where $\mu_{n, r}$ the so called empirical spectral distribution (ESD) is

\begin{equation*}
\mu_{n, r}=\frac{1}{r} \sum_{k=1}^{r} \delta_{\lambda_{k}} \tag{4.1}
\end{equation*}
$$

For $c>0$ and $\sigma>0$, let $\pi_{\sigma^{2}}^{c}$ be the distribution on $\mathbb{R}$ defined by

\begin{equation*}
\pi_{\sigma^{2}}^{c}(d x)=\left(1-c^{-1}\right)_{+} \delta_{0}(d x)+\frac{\left(\left(x-\sigma^{2} a(c)\right)\left(\sigma^{2} b(c)-x\right)\right)_{+}^{1 / 2}}{2 \pi \sigma^{2} c x} d x \tag{4.2}
\end{equation*}
$$

where $\delta_{0}$ is the Dirac mass in $0, x_{+}=\max (x, 0)$ and

$$
\begin{equation*}
a(c)=(1-\sqrt{c})^{2}, \quad b(c)=(1+\sqrt{c})^{2} . \tag{4.3}
\end{equation*}
$$

It is called the Marčenko-Pastur distribution with ratio index $c$ and scale index $\sigma^{2}$ (Bai [5] p.621).

It is well known (Marčenko and Pastur [46, Bai [5 section 2.1.2 for the cases $\beta=1$ and $\beta=2$ ) that as $n, r \rightarrow \infty$ with $r / n \rightarrow T \in(0, \infty)$, the family of ESD ( $\mu_{n, r}$ ) converges a.s. weakly to $\pi_{1}^{T}$. If we replace the common law $\mathcal{N}(0,1)$ by $\mathcal{N}\left(0, \sigma^{2}\right)$ then the limiting distribution is $\pi_{\sigma^{2}}^{T}$.

To conclude that

$$
\begin{equation*}
\lim _{n} \int(\log x) d \mu_{n, r}(x)=\int(\log x) d \pi_{1}^{T}(x), \tag{4.4}
\end{equation*}
$$

an additional control is necessary, since $x \mapsto \log x$ is not bounded.
Actually the largest and the smallest eigenvalue converge a.s. to $b(T)<\infty$ and $a(T)>0$, respectively. For comments on these results and references, one may consult [5] sections 2.1.2 and 2.2.2.

In our context, this implies easily that a.s.

\frac{1}{n} \log \Delta_{n, r}^{L, \beta}=\frac{r}{n} \int \log x d \mu_{n, r}(x) \rightarrow T \int \log x d \pi_{1}^{T}(x) \tag{4.5}

Moreover, it is known (Jonssonn 40] p. 31 and Bai and Silverstein [6] p. 596597) that:

which implies that claim (4.5) is consistent with (3.21).
The fluctuations were studied recently (in the complex case) by Bai and Silverstein [6], who proved

and this is consistent with (the marginal version of) (3.22).
Let us end with the large deviations. Hiai and Petz (35], see also [36] section 5.5) proved ${ }^{1}$ that if $n \rightarrow \infty$ and $r / n \rightarrow T<1$, then $\left\{\mu_{n, r}\right\}$ satisfies a LDP in $\mathrm{M}_{1}([0, \infty))$ in the scale $2 \beta^{-1} n^{-2}$ with some explicit good rate function

[^2]$I_{T}^{s p L}$ given below in (4.8, 4.9, 4.10). If the contraction $\mu \mapsto \int \log x d \mu(x)$ were continuous, we would claim that $\left\{n^{-1} \log \Delta_{n,\lfloor n T\rfloor}^{L}\right\}_{n}$ satisfies a LDP in $\mathbb{R}$ in the same scale, with good rate function

Actually,

I_{T}^{s p L}(\mu)=-T^{2} \Sigma(\mu)+T \int(x-(1-T) \log x) d \mu(x)+2 B(T) \tag{4.8}
\end{equation*}
$$

where

\begin{equation*}
\Sigma(\mu):=\iint \log |x-y| d \mu(x) d \mu(y) \tag{4.9}
\end{equation*}
$$

is the so-called logarithmic entropy and for $T \in(0,1)$

\begin{equation*}
2 B(T)=-\frac{1}{2}\left(3 T-T^{2} \log T+(1-T)^{2} \log (1-T)\right) \tag{4.10}
\end{equation*}
$$

We do not know if the contraction $\mu \mapsto \int \log x d \mu(x)$ does work, although not continuous. However we will prove the following result, where for $u \in \mathbb{R}$ we set

Proposition 4.1. For $\xi \geq \xi_{T}$ and $\theta$ solution of 3.46), let $\sigma^{2}=1+\theta$. Then the infimum of $I_{T}^{s p L}(\mu)$ over $\mathcal{A}(\xi / T)$ is uniquely achieved for $\pi_{\sigma^{2}}^{T / \sigma^{2}}$ and

Remark 4.2. (1) The endpoint is $\xi_{T}=\mathcal{J}(T)-1$, with $\sigma^{2}=T$.
(2) For $\xi<\xi_{T}$ we do not know what happens. We can imagine that the infimum in 4.12) has a solution in some extended space.
4.2. Uniform Gram. Recently, De Cock et al. (15]) and Jiang (39) proved that the same result holds true for the ESD in the Uniform Gram ensemble when $\beta=1$. If $\widetilde{\lambda}_{k}, k=1, \ldots, r$ are the (real) eigenvalues of $G$ and

\widetilde{\mu}_{n, r}=\frac{1}{r} \sum_{k=1}^{r} \delta_{\widetilde{\lambda}_{k}} \tag{4.13}
\end{equation*}

then, as $n \rightarrow \infty$ and $r / n \rightarrow T \in(0, \infty)$, the family $\left(\widetilde{\mu}_{n, r}\right)$ converges a.s. to $\pi_{1}^{T}$. Again we may start with

\frac{1}{n} \log \Delta_{n, r}^{G, \beta}=\frac{r}{n} \int(\log x) d \widetilde{\mu}_{n, r}(x)
$$

and use the weak convergence of $\widetilde{\mu}_{n, r}$ towards $\pi_{1}^{T}$, (see Section 4.1). In (39, Jiang proved recently that the largest and the smallest eigenvalue converge a.s. as $r / n \rightarrow T<1$ to $b(T)<\infty$ and $a(T)>0$ respectively. So, we have

In view of (4.6), this matches with the result (3.12).
No result on fluctuations or large deviations seems to be known on $\widetilde{\mu}_{n, r}$.
4.3. Jacobi. In the matrix models ( $\beta=1,2$ or 4 ), take $r \leq n_{1}$ and let $\lambda_{k}, k=$ $1, \ldots, r$ be the eigenvalues of $\mathcal{Z}_{n_{1}, n_{2}, r}$ (they are real nonnegative). The ESD is

\nu_{n_{1}, n_{2}, r}=\frac{1}{r} \sum_{k=1}^{r} \delta_{\lambda_{k}} .
$$

When $n_{2} \leq r \leq n_{1}$ we have

\nu_{n_{1}, n_{2}, r}=\frac{n_{2}}{r} \mu_{n_{1}, n_{2}, r}+\left(1-\frac{n_{2}}{r}\right) \delta_{1},
$$

where $\mu_{n_{1}, n_{2}, r}$ is the ESD built with eigenvalues different from 1 . We can write in all cases

\log \Delta_{n, r}^{J, \beta}=\min \left(r, n_{2}\right) \int(\log x) \mu_{n_{1}, n_{2}, r}(d x) \tag{4.15}
\end{equation*}

It is then possible to carry asymptotical results of this empirical distribution to $\log \Delta_{n, r}^{J, \beta}$.

Capitaine and Casalis [11] studied the complex case in the asymptotical regime $n_{1} / r \rightarrow u^{\prime}, n_{2} / r \rightarrow v^{\prime}$ with $u^{\prime}+v^{\prime} \geq 1$. They prove ${ }^{2}$ that $\mathbb{E} \nu_{n_{1}, n_{2}, r}$ converges (in moments hence) in distribution. To give the expression of the limiting distribution, which we denote $\mathrm{CC}_{u^{\prime}, v^{\prime}}$ and to compare known results in some other contexts with coherent notation, we will use in the following, four functions : for $(b, c) \in(0,1) \times(0,1)$ we set

\sigma_{ \pm}(b, c)=\frac{1}{2}[1+\sqrt{b c} \pm \sqrt{(1-b)(1-c)}] \tag{4.16}
\end{equation*}

and for $(x, y) \in(0,1) \times(0,1)$

a_{ \pm}(x, y) & =(1-x-y+2 x y) \pm 2 \sqrt{x(1-x) y(1-y)} \\

The mappings $\sigma_{ \pm}$and $a_{ \pm}$are inverse in the following sense :

where $C_{a_{-}, a_{+}}$is the normalization constant. Since we found some mistakes in the literature, let us compute explicitly the constant $C_{a_{-}, a_{+}}$. From the obvious decomposition

\end{aligned}

Two applications of the classical formula

\int_{u}^{v} \frac{\sqrt{(x-u)(v-x)}}{2 \pi x} d x=\frac{1}{4}[u+v-2 \sqrt{u v}] \quad(0<u<v)
$$

yield

\left(C_{a_{-}, a_{+}}\right)^{-1}=\frac{1}{2}\left[1-\sqrt{a_{-} a_{+}}-\sqrt{\left(1-a_{-}\right)\left(1-a_{+}\right)}\right] . \tag{4.20}

The distribution $\mathrm{CC}_{u^{\prime}, v^{\prime}}$ is then (recall $u^{\prime}+v^{\prime} \geq 1$ )

& +\left[1-\left(1-u^{\prime}\right)^{+}-\left(1-v^{\prime}\right)^{+}\right] \pi_{a_{-}, a_{+}}
\end{align*}
$$

where

$$
\begin{equation*}
\left(a_{-}, a_{+}\right)=a_{ \pm}\left(\frac{u^{\prime}}{u^{\prime}+v^{\prime}}, 1-\frac{1}{u^{\prime}+v^{\prime}}\right) \tag{4.22}
\end{equation*}
$$

Remark 4.3. The case $\left(v^{\prime}<1\right)$ corresponds to $r>n_{2}$, the second matrix $W_{2}$ is singular and the case $\left(v^{\prime} \geq 1\right)$ corresponds to $r \leq n_{2}$, the second matrix is non-singular.

For particular values of the parameters and up to an affine change to make the distribution symmetric, the distribution $\pi_{a_{-}, a_{+}}$was introduced by Kesten as limit distribution for random walks on some classical groups 41. It was (independently) introduced by McKay [51] as a limit distribution in a graph problem. It is sometimes called the generalized McKay distribution. Some important connections are in Section (9,

For the LLN, the same remarks as above are relevant. Let us recall the notation

r \leq n_{1}, n \rightarrow \infty, \frac{r}{n} \rightarrow T, \frac{n_{1}}{n} \rightarrow \tau_{1}, \frac{n_{2}}{n} \rightarrow \tau_{2}, u^{\prime}=\frac{\tau_{1}}{T}, v^{\prime}=\frac{\tau_{2}}{T}

The weak convergence of the ESD ([11) and the control on the extremal eigenvalues (Ledoux [44], Collins [13] and references therein), yield, if $u^{\prime} \geq 1$

where $a_{ \pm}$are in (4.22). Nevertheless a computation of this integral by elementary methods is not so easy. After some attempts, we choose to consider the above result as an indirect way to compute this integral and we conclude

\end{align*}

where $\sigma_{ \pm}$are given by 4.16).

\end{equation*}

and together (4.26(4.27) provide (4.24). This ends the proof.
Let us remark that the first case above ( $v^{\prime}<1$ ) corresponds to $T>\tau_{2}$ (i.e. $r>n_{2}$, the second matrix $W_{2}$ is singular) and the second one $\left(v^{\prime} \geq 1\right)$ corresponds to $T \leq \tau_{2}$ (i.e. $r \leq n_{2}$, the second matrix is non-singular).

Let us end with the large deviations. In the complex case $(\beta=2)$, Hiai et Petz [37] proved that if $n \rightarrow \infty, n_{1} / n \rightarrow \tau_{1}, n_{2} / n \rightarrow \tau_{2}>\tau_{1}, r / n \rightarrow T<\tau_{1}$, then $\left\{\mu_{n_{1}, n_{2}, r}\right\}_{n}$ satisfies a LDP in $\mathcal{M}_{1}([0,1])$ the set of probability measures on $[0,1]$ endowed with the weak convergence topology, in the scale $n^{-2}$, with the good rate function

$$
\begin{align*}
I_{T}^{s p J}(\mu) & :=-T^{2} \Sigma(\mu)-T \int_{0}^{1}\left(\left(\tau_{1}-T\right) \log x+\left(\tau_{2}-T\right) \log (1-x)\right) d \mu(x) \\
& +T^{2} B\left(\frac{\tau_{1}-T}{T}, \frac{\tau_{2}-T}{T}\right) \tag{4.28}
\end{align*}
$$

where $B$ is defined in (3.3) (it is the limiting free energy).
A computation similar to p. 10 of [37] gives the same result for general $\beta$.
Proposition 4.5. If $T<\tau_{1} \leq \tau_{2}$, the family $\left\{\mu_{\left\lfloor n \tau_{1}\right\rfloor,\left\lfloor n \tau_{2}\right\rfloor,\lfloor n T\rfloor}\right\}$ satisfies a LDP in $\mathcal{M}_{1}([0,1])$ in the scale $2 \beta^{-1} n^{-2}$ and good rate function $I_{T}^{s p J}$.

If the contraction $\mu \mapsto \int \log x d \mu(x)$ from the set $\mathrm{M}_{1}([0,1])$ to $\mathbb{R}$ were continuous, we would claim that $\left\{n^{-1} \log \Delta_{n}^{J, \beta}(T)\right\}_{n}$ satisfies a LDP in $\mathbb{R}$ with good rate function $\widetilde{I}_{T}^{J}$ where

\begin{equation*}
\widetilde{I}_{T}^{J}(\xi)=\inf \left\{I_{T}^{s p J}(\mu) ; \mu \in \mathcal{A}\left(\xi T^{-1}\right)\right\} \tag{4.29}
\end{equation*}
$$

with $\mathcal{A}(u)$ as defined in (4.11).
Like in the Laguerre case we will prove the following result.
Proposition 4.6. Let $T<\min \left(\tau_{1}, \tau_{2}\right), \xi \in\left[\xi_{T}^{J}, 0\right)$ and $\theta$ solution of (3.51). Then the infimum of $I_{T}^{s p J}(\mu)$ over $\mathcal{A}\left(\xi T^{-1}\right)$ is uniquely achieved at $\mu=\pi_{\tilde{a}_{-}, \tilde{a}_{+}}$ where

and

I_{T}^{J}(\xi)=I_{T}^{s p J}\left(\pi_{\tilde{a}_{-}, \tilde{a}_{+}}\right)=\inf \left\{I_{T}^{s p J}(\mu) ; \mu \in \mathcal{A}\left(\xi T^{-1}\right)\right\} \tag{4.31}
\end{equation*}

Remark 4.7. The endpoint is $\xi_{T}^{J}$, which corresponds to $\theta=T-\tau_{1}$, i.e.

\tilde{a}_{-}=0 \quad, \quad \tilde{a}_{+}=\frac{4 \tau_{2} T}{\left(\tau_{2}+T\right)^{2}}
$$

For $\xi<\xi_{T}^{J}$ we do not know what happens. We can imagine that the infimum in (4.29) has a solution in some extended space.

Remark 4.8. In the range $\tau_{2} \leq T<\tau_{1}$ we have a similar result, exchanging $\tilde{s}_{-}$and $\tilde{s}_{+}$in 4.30). We omit the details.
4.4. Extensions. We already mentioned that in the Wishart and Gram models, limiting results exist when we leave the Gaussian/Uniform world.

The Bartlett decomposition is not possible in the general case. Nevertheless, a product formula for the determinant is well known (see for example Lemma 3.1 p. 9 and formula 4.3 p. 15 in Friedland et al. [29]), but nothing can be said about the distribution of the components of the product in general.

Nevertheless, if the columns (or the rows) of the matrix $B$ are i.i.d. and isotropic, the previous results extend easily.

Let us begin with the "column" case. The beta-gamma algebra allowed us to pass from the Uniform Gram ensemble to the Wishart ensemble. The polar decomposition allows to obtain similar results as for the Wishart ensemble under convenient assumptions on the radial distribution. Let $\varepsilon_{n}=$ $\log \left\|b_{1}\right\|^{2}-\log \mathbb{E}\left\|b_{1}\right\|^{2}$ (remember that we omit the dimension index $n$ ). To get convergence and fluctuations it is enough to assume

n \mathbb{E} \varepsilon_{n} \rightarrow a_{1}, n \operatorname{Var} \varepsilon_{n} \rightarrow a_{2}, n \mathbb{E}\left(\varepsilon_{n}-\mathbb{E} \varepsilon_{n}\right)^{4} \rightarrow 0 \tag{4.32}
\end{equation*}
$$

To get large deviations, it would be sufficient to assume that the quantity $n^{-2} \sum_{k=1}^{n} \log \mathbb{E} \exp \left(n \varphi(k / n) \varepsilon_{n}\right)$ has a limit for some convenient functions $\varphi$.

In [3, Akhavi uses the uniform distribution in the unit ball, so that the distribution of $\left\|b_{1}\right\|^{2}$ is $\operatorname{Beta}(n / 2,1)$ and (4.32) is satisfied with $a_{1}=-2, a_{2}=$ 0 . The contribution of the radial part is then roughly "deterministic" since $\mathbb{E}\left\|b_{1}\right\|^{2}$ is bounded.

In the "row" case, we can use the results of the "column" case since the eigenvalues of $B B^{\prime}$ are (except 0 with multiplicity $n-r$ ) the same as those of $B^{\prime} B$.

## 5. Proofs of Theorems of Section 3.1

5.1. Proof of Theorem 3.1, We will use Mellin transforms and their first two derivatives in $\theta=0$. From the decomposition (2.20) we have

\Lambda_{n, k}^{G, \beta}(\theta)=\ell\left(\beta^{\prime}(n-k+1+\theta)\right)-\ell\left(\beta^{\prime}(n-k+1)\right)+\ell\left(\beta^{\prime} n\right)-\ell\left(\beta^{\prime}(n+\theta)\right)( \tag{5.3}
\end{equation*}
$$

where we set

\ell(x)=\log \Gamma(x) .
$$

Proof of 1) and 2) Differentiating once, we get

\mathbb{E} \log \Delta_{n, r}^{G, \beta}=\sum_{j=1}^{r}\left[\Psi\left(\beta^{\prime}(n-j+1)\right)-\Psi\left(\beta^{\prime} n\right)\right]
$$

and from Binet formula,

\mathbb{E} \log \Delta_{n, r}^{G, \beta}=\log \frac{(n)_{r}}{n^{r}}+\frac{1}{\beta}\left(H_{n-r}-H_{n}\right)+\frac{r}{\beta n}+\delta_{n-r}^{1}-\delta_{n}^{1} . \tag{5.4}
\end{equation*}
$$

in which

1) $(p)_{r}=p(p-1) \cdots(p-r+1)$ is the falling factorial
2) $H_{0}=0$ and $H_{p}=1+\frac{1}{2}+\cdots+\frac{1}{p}$ are the harmonic numbers
3) the remaining terms are

\begin{equation*}
\delta_{0}^{1}=0, \delta_{p}^{1}=-\int_{0}^{\infty} s f(s) \sum_{k=1}^{p} e^{-\beta^{\prime} k s} d s=-\int_{0}^{\infty} s f(s) \frac{1-e^{-\beta^{\prime} p s}}{e^{\beta^{\prime} s}-1} d s \tag{5.5}
\end{equation*}
$$

Using again Binet formula twice, we have for $r<n$

\log \frac{(n)_{r}}{n^{r}} & =-\left(n-r+\frac{1}{2}\right) \log \left(1-\frac{r}{n}\right)-r-\int_{0}^{\infty} f(s) e^{-s(n-r)}+o(1) \\
& =-n \mathcal{J}\left(1-\frac{r}{n}\right)-\frac{1}{2} \log \left(1-\frac{r}{n}\right)-\int_{0}^{\infty} f(s) e^{-s(n-r)}+o(1)
\end{aligned}
$$

and for $r=n$ (Stirling formula)

\log \frac{(n)_{n}}{n^{n}}=-n+\frac{1}{2} \log (2 \pi n)+o(1) .
$$

The harmonic contribution in (5.4) is

as soon as $n-r \rightarrow \infty$. For $r=n$, we have $H_{0}-H_{n}=-\log n-\gamma+o(1)$. The delta contribution is

\delta_{n-r}^{1}-\delta_{n}^{1}=\int_{0}^{\infty} \frac{s f(s)}{e^{\beta^{\prime} s}-1}\left[-e^{-\beta^{\prime} n s}+e^{-\beta^{\prime}(n-r) s}\right] d s

so that, summing up, we get (for $n-r \rightarrow \infty$ )

& -\int_{0}^{\infty} f(s) e^{-\beta^{\prime} s(n-r)} d s \\
& +\int_{0}^{\infty} \frac{s f(s)}{e^{\beta^{\prime} s}-1}\left[-e^{-\beta^{\prime} n s}+e^{-\beta^{\prime}(n-r) s}\right] d s+o(1)
\end{aligned}
$$

and for $r=n$

$$
\mathbb{E} \log \Delta_{n, n}^{G, \beta}=-n-\left(\frac{1}{\beta}-\frac{1}{2}\right) \log n+K_{\beta}^{1}+o(1) .
$$

Moreover, for the supremum, we have

\sup _{r \leq n}\left|\mathbb{E} \log \Delta_{n, r}^{G, \beta}-\log \frac{(n)_{r}}{n^{r}}\right| & =O(\log n) \\
\sup _{r \leq n}\left|\log \frac{(n)_{r}}{n^{r}}-n \mathcal{J}\left(1-\frac{r}{n}\right)\right| & =O(\log n)
\end{aligned}
$$

so that (3.5), (3.6) and (3.7) are proved.
3) Taking logarithms in (5.1) and differentiating twice, we get

|\varepsilon| \leq \sum_{n-r+1}^{n} \frac{2}{\beta^{\prime 2} j^{2}}
$$

Moreover

$$
\begin{aligned}
\operatorname{Var} \log \Delta_{n, n}^{G, \beta} & =\frac{1}{\beta^{\prime}} H_{n}-\frac{1}{\beta^{\prime}}+\int_{0}^{\infty} s\left(s f(s)+\frac{1}{2}\right) \sum_{1}^{n-1} e^{-j \beta^{\prime} s} d s \\
& +\int_{0}^{\infty}(n-1) s e^{-\beta^{\prime}(n-1) s} e^{-\beta^{\prime} s}\left[s f(s)-\frac{1}{2}\right] d s
\end{aligned}
$$

Using (8.4) and dominated convergence we deduce easily (3.9) and (3.10).
To prove 4 ), let us notice that since $\mathcal{J}$ is uniformly continuous on $[0,1]$ we have

5.2. Proof of Theorem 3.2. Let us first notice that, thanks to the estimations of expectations in (3.6) and (3.7), we can reduce the problem to the centered process and centered variable :

To prove (3.13) it is enough to prove the convergence in distribution in $\mathbb{D}([0, T])$, for every $T<1$, of $\delta_{n}$ to a centered Gaussian process with independent increments, and variance $\int_{0}^{t}\left(\sigma^{G, \beta}(s)\right)^{2} d s$. To this purpose we apply a version of the Lindeberg-Lévy-Lyapunov criteria (see Dacunha-Castelle and Duflo [14] Theorem 7.4.28 of the French edition, or Jacod and Shiryaev [38] §3c). For $t<1$, from (3.9) it is enough to prove that

\beta^{\prime 4} \mathbb{E}\left(\eta_{n, k}^{4}\right)=\left(\Lambda_{n, k}^{G, \beta}\right)^{(4)}(0)+3\left[\left(\Lambda_{n, k}^{G, \beta}\right)^{(2)}(0)\right]^{2} \tag{5.8}
\end{equation*}
$$

On the one hand, from expression (5.3)

\left(\Lambda_{n, k}^{G, \beta}\right)^{(4)}(0)=\beta^{\prime 4}\left[\Psi^{(3)}\left(\beta^{\prime}(n-k+1)\right)-\Psi^{(3)}\left(\beta^{\prime} n\right)\right]

and Binet estimates (8.8), (8.9) for $q=4$ yield

\left|\sum_{k=1}^{p}\left(\Lambda_{n, k}^{G, \beta}\right)^{(4)}(0)-6 \beta^{\prime} \sum_{k=1}^{p}\left[\frac{1}{(n-k+1)^{3}}-\frac{1}{n^{3}}\right]\right| \leq 6 \sum_{k=1}^{p} \frac{1}{(n-k+1)^{4}}, \tag{5.9}
\end{equation*}
$$

which, for $0<t<1$ and $p=\lfloor n t\rfloor$ yields $\lim _{n} \sum_{k=1}^{\lfloor n t\rfloor}\left(\Lambda_{n, k}^{G, \beta}\right)^{(4)}(0)=0$. On the other hand,

\end{equation*}

We already know, from (3.9) that

Now since $\left(\Lambda_{n, k}^{G, \beta}\right)^{\prime \prime}(0)=\beta^{\prime 2}\left[\Psi^{\prime}\left(\beta^{\prime}(n-k+1)\right)-\Psi^{\prime}\left(\beta^{\prime} n\right)\right]$ and since $\Psi^{\prime}$ is nonincreasing (see (8.8)) we obtain

We just checked (5.7), which proves that the sequence of processes $\left\{\delta_{n}(t), t \in[0,1)\right\}_{n}$ converges to a Gaussian centered process $\mathcal{W}$ with independent increments and the convenient variance. It is now straightforward to get equation (3.14).
2) When $t=1$, most of the sums studied above explode when $n$ tends to infinity and we need a renormalisation. In fact, for every $n$, the process $\left(\delta_{n}(t), t \in[0,1]\right)$ has independent increments. The conditional distribution of $\delta_{n}(1)$, knowing $\delta_{n}\left(t_{1}\right)=\varepsilon_{1}, \ldots, \delta_{n}\left(t_{r}\right)=\varepsilon_{r}$ for $t_{1}<\cdots<t_{r}$ is the same as $\varepsilon_{r}+\sum_{\left[n t_{r}\right]+1}^{n} \eta_{k, n}$. Formulae (3.9) and (3.10) yield

Actually we can apply the Lindeberg theorem (with the criterion of Lyapunov) to the triangular array of random variables $\widehat{\eta}_{k, n}=\eta_{k, n} / \sqrt{(2 / \beta) \log n}$ with with $k=\left[n t_{r}\right]+1, \ldots, n$. It is enough to prove

We start again with the decomposition (5.8). From the above estimate (5.9), the sum $\sum_{k=1}^{n}\left(\Lambda_{n, k}^{G, \beta}\right)^{(4)}(0)$ is bounded. In (5.10), we have

which is equivalent to $2 \log n$ (see (3.10)) and the supremum in (5.10) with $p=n$ is bounded. This yields

which proves (5.12).
Then $\sum_{\left[n t_{r}\right]+1}^{n} \widehat{\eta}_{k, n}$ converges in distribution to $\mathcal{N}(0,1)$, and the same is true for the conditional distribution of $\widehat{\delta}_{n}$ knowing $\delta_{n}\left(t_{1}\right)=\varepsilon_{1}, \ldots, \delta_{n}\left(t_{r}\right)=\varepsilon_{r}$. Since the limiting distribution does not depend on $\varepsilon_{1}, \ldots, \varepsilon_{r}$, we have proved that $\widehat{\delta}_{n}$ converges in distribution to a random variable which is $\mathcal{N}(0,1)$ and independent of $\mathcal{W}$.
5.3. Proof of Theorems 3.3 and 3.5. It is of course possible to follow the same schemes of proof. Actually we prefer, at least for the beginning, exploit the beta-gamma algebra and the fundamental relation (2.26). So, for instance

\log \mathbb{E}\left[\varepsilon_{k}^{(n)}\right]^{\beta^{\prime} \theta}=\ell\left(\beta^{\prime}(\theta+n)\right)-\ell\left(\beta^{\prime} n\right)-\beta^{\prime} \theta \log \left(\beta^{\prime} n\right), \tag{5.13}
\end{equation*}
$$

which provides estimates for the expectation and the variance. Differentiating once and taking $\theta=0$, we see that

\mathbb{E} \log \varepsilon_{k}^{(n)}=\Psi\left(\beta^{\prime} n\right)-\log \left(\beta^{\prime} n\right)=-\frac{1}{\beta n}-\int_{0}^{\infty} e^{-s \beta^{\prime} n} s f(s) d s \\
=-\frac{1}{\beta n}+O\left(\frac{1}{n^{2}}\right)
\end{array}
$$

(see (8.5), (8.4)), which gives

\sup _{p \leq n}\left|\mathbb{E} S_{n, p}+\frac{p}{n \beta}\right|=O\left(\frac{1}{n}\right) . \tag{5.14}
\end{equation*}
$$

Besides, differentiating (5.13) twice and taking $\theta=0$ again, we have

\operatorname{Var}\left(\log \varepsilon_{k}^{(n)}\right)=\Psi^{\prime}\left(\beta^{\prime} n\right)=\frac{1}{\beta^{\prime} n}+O\left(\frac{1}{n^{2}}\right)
$$

(see (8.9)), which yields

\sup _{p \leq n}\left|\operatorname{Var} S_{n, p}-\frac{2 p}{\beta n}\right|=O\left(\frac{1}{n}\right) \tag{5.15}
\end{equation*}
$$

From (5.14) and (5.15) it is easy to check (via a fourth moment estimate) that $S_{n}$ converges in distribution in $\mathbb{D}([0,1])$ to

\left(-(t / \beta)+\sqrt{2 / \beta} \widetilde{\mathbf{B}}_{t}, t \in[0,1]\right)
$$

where $\widetilde{\mathbf{B}}$ is a Brownian motion independent of $\left(\Delta_{n}^{G, \beta}, n \in \mathbb{N}\right)$. Finally the family of processes $\Delta_{n}^{L, \beta}=\Delta_{n}^{G, \beta}+S_{n}$ converges in distribution towards

\left(X_{t}^{G, \beta}-(t / \beta)+\sqrt{2 / \beta} \widetilde{\mathbf{B}}_{t}, t \in[0,1)\right) .
$$

It is a Gaussian process, whose drift and variance coefficients are
$\mathrm{d}^{G, \beta}(t)-\frac{1}{\beta}=\left(\frac{1}{2}-\frac{1}{\beta}\right) \frac{1}{1-t}=\mathrm{d}^{L, \beta}(t), \quad\left(\sigma^{G, \beta}(t)\right)^{2}+\frac{2}{\beta}=\left(\sigma^{L, \beta}(t)\right)^{2}$.
which identify the process $X^{L, \beta}$.
Besides, we have

$$
\widehat{\eta}_{n}^{L, \beta}(1)=\widehat{\eta}_{n}^{G, \beta}(1)+\frac{S_{n}(1)}{\sqrt{2 \log n}}
$$

so that the convergence of $\widehat{\eta}_{n}^{L, \beta}(1)$ is clear. Moreover the independence properties seen in Theorem 3.2 remain true.
5.4. Proof of Theorem 3.6. Again, we could follow the same schemes as in the Gram section. Actually we take again the benefit of beta-gamma algebra. Let us delete the superscript $\beta$ for the sake of simplicity.

Recall (2.28)

\text { Var } \log \Delta_{n, r}^{J}=\operatorname{Var} \log \Delta_{n_{1}, r}^{L}-\operatorname{Var} \log \Delta_{n_{1}+n_{2}, r}^{L}
$$

The results are now straightforward. We let the proof to the reader. We just notice that since $r / n_{1} \rightarrow t / \tau_{1}$ and $r /\left(n_{1}+n_{2}\right) \rightarrow t /\left(\tau_{1}+\tau_{2}\right)$ then

\mathbb{E} \log \Delta_{n_{1}+n_{2}, r}^{L}+\left(n_{1}+n_{2}\right) \mathcal{J}\left(1-\frac{r}{n_{1}+n_{2}}\right) & \rightarrow \int_{0}^{t /\left(\tau_{1}+\tau_{2}\right)} \mathrm{d}^{L, \beta}(s) d s
\end{aligned}
$$

hence

$$
\mathrm{d}^{J, \beta}(t)=\frac{1}{\tau_{1}} \mathrm{~d}^{L}\left(\frac{t}{\tau_{1}}\right)-\frac{1}{\tau_{1}+\tau_{2}} \mathrm{~d}^{L}\left(\frac{t}{\tau_{1}+\tau_{2}}\right)
$$

In the same vein

$$
\left(\sigma^{J}(t)\right)^{2}=\frac{1}{\tau_{1}}\left(\sigma^{L}\left(\frac{t}{\tau_{1}}\right)\right)^{2}-\frac{1}{\tau_{1}+\tau_{2}}\left(\sigma^{L}\left(\frac{t}{\tau_{1}+\tau_{2}}\right)\right)^{2}
$$

5.5. Proof of Theorem 3.8. Again, it is possible to follow the classical scheme. Instead let us look at the situation we are faced to. Put

U_{n}=\log \Delta_{n_{1}, r}^{L}, \quad V_{n}=\log \Delta_{n_{1}+n_{2}, r}^{L}, W_{n}=\log \Delta_{n, r}^{J} \tag{5.16}
\end{equation*}

U_{n}-\mathbb{E} U_{n}=V_{n}-\mathbb{E} V_{n}+W_{n}-\mathbb{E} W_{n}
$$

with $U_{n}-\mathbb{E} U_{n} \Rightarrow U$ and $V_{n}-\mathbb{E} V_{n} \Rightarrow V$, where $U$ and $V$ are Gaussian processes with independent increments, and $V_{n}$ and $W_{n}$ are independent. Looking for instance at characteristic functions, it is clear that $W_{n}$ converges in the sense of finite distributions to a Gaussian process with independent increments. Its drift and variance are the difference of the corresponding ones. Moreover, since $U_{n}$ and $V_{n}$ are tight, $U_{n}-V_{n}$ is tight.

## 6. Proofs of Theorems of Section 3.2

6.1. Proof of Theorem 3.9, Recall the notation $\Theta_{n}^{G}=n^{-1} \log \Delta_{n}^{G, \beta}$. As mentioned after the statement of the theorem, we are going prove at first the LDP for the restriction of $\dot{\Theta}_{n}^{G}$ to $[0, T]$, viewed as an element of $\mathrm{M}_{T}$, in the scale $\beta^{\prime-1} n^{-2}$ with rate function

\widetilde{I}_{[0, T]}^{G}(m):=\int_{0}^{T} L_{a}^{G}\left(t, \frac{d m_{a}}{d t}(t)\right) d t+\int_{0}^{T} L_{s}^{G}\left(t, \frac{d m_{s}}{d \mu}(t)\right) d \mu(t) \tag{6.1}
\end{equation*}
$$

Let $V_{\ell}$ be the set of functions from $[0, T]$ to $\mathbb{R}$ which are left continuous and have bounded variation, and let $V_{\ell}^{*}$ be its topological dual when $V_{\ell}$ is equipped with the uniform convergence topology.

Actually $\dot{\Theta}_{n}^{G} \in \mathrm{M}_{T}$ may be identified with an element of $V_{\ell}^{*}$ (see [45] Appendix B): owing to (3.37) its action on $\varphi \in V_{\ell}$ is given by

<\dot{\Theta}_{n}^{G}, \varphi>:=\frac{1}{n} \sum_{k=1}^{\lfloor n T\rfloor} \varphi(k / n) \log \rho_{n, k}^{G, \beta} .
$$

The proof of Theorem 3.9 is based on the ideas of Baldi theorem ([17] p.157). The main tool is the normalized cumulant generated function (n.c.g.f.) which here takes the form

\mathcal{L}_{n,\lfloor n T\rfloor}^{G, \beta}(\varphi):=\frac{1}{\beta^{\prime} n^{2}} \log \mathbb{E}\left[\exp \left(\beta^{\prime} n^{2}<\dot{\Theta}_{n}^{G}, \varphi>\right)\right] . \tag{6.2}
\end{equation*}
$$

Owing to (6.1) we have

$$
\begin{equation*}
\mathcal{L}_{n,\lfloor n T\rfloor}^{G, \beta}(\varphi)=\frac{1}{\beta^{\prime} n^{2}} \sum_{k=1}^{\lfloor n T\rfloor} \Lambda_{n, k}^{G, \beta}(n \varphi(k / n)) \tag{6.3}
\end{equation*}
$$

and from (5.2) it is finite iff $\varphi(k / n)>-(n-k+1) / n$ for every $1 \leq k \leq\lfloor n T\rfloor$.
In Subsection 6.1.1 we prove the convergence of this sequence of n.c.g.f. for a large class of functions $\varphi$. It will be sufficient, jointly to the variational formula given in Subsection 6.1.2 to get the upper bound for compact sets. Then Subsection 6.1.3 is devoted to exponential tightness, which allows to get the upper bound for closed sets. However, since the limiting n.c.g.f. is not defined everywhere, the lower bound (for open sets) is more delicate than in Baldi theorem. Actually a careful study of exposed points as in Gamboa et al. 30] is managed in Subsection 6.1.4. We end the proof in Subsection 6.1.5,
6.1.1. Convergence of the n.c.g.f. Let, for $t \in[0,1]$ and $\theta>-(1-t)$

$$
\begin{equation*}
g^{G}(t, \theta):=\mathcal{J}(1-t+\theta)-\mathcal{J}(1-t)-\mathcal{J}(1+\theta) \tag{6.4}
\end{equation*}
$$

Lemma 6.1. If $\varphi \in V_{\ell}$ satisfies $\varphi(t)+1-t>0$ for every $t \in(0, T]$, then

$$
\begin{equation*}
\lim _{n} \mathcal{L}_{n,\lfloor n T\rfloor}^{G, \beta}(\varphi)=\Lambda_{[0, T]}^{G}(\varphi):=\int_{0}^{T} g^{G}(t, \varphi(t)) d t . \tag{6.5}
\end{equation*}
$$

Proof: The key point is a convergence of Riemann sums. From (5.2) and (8.1) we have, for every $\theta>-\frac{n-k+1}{n}$,

\begin{array}{r}
\Lambda_{n, k}^{G, \beta}(n \theta)=\beta^{\prime}(n-k+n \theta) \log \left(1-\frac{k}{n}+\theta+\frac{1}{n}\right)-\beta^{\prime}(n-k) \log \left(1-\frac{k}{n}+\frac{1}{n}\right) \\
-\beta^{\prime}(n-1+n \theta) \log (1+\theta)+R_{n, k}(\theta)
\end{array}
$$

where the quantity

$$
\begin{aligned}
R_{n, k}(\theta) & =\int_{0}^{\infty} f(s) e^{-\beta^{\prime} s}\left[\mathrm{e}^{-\beta^{\prime}(n-k+n \theta) s}-\mathrm{e}^{-\beta^{\prime}(n-k) s}\right] d s \\
& -\int_{0}^{\infty} f(s)\left[\mathrm{e}^{-\beta^{\prime}(n-1+n \theta) s}-e^{-\beta^{\prime} s} \mathrm{e}^{-\beta^{\prime}(n-1) s}\right] d s
\end{aligned}
$$

is bounded by $2 \int_{0}^{\infty} e^{-\beta^{\prime} s} f(s) d s$. If we set

$$
\begin{aligned}
\Phi_{n}(t):= & (1-t+\varphi(t)) \log \left(1-t+\varphi(t)+\frac{1}{n}\right) \\
& -(1-t) \log \left(1-t+\frac{1}{n}\right)-\left(1-\frac{1}{n}+\varphi(t)\right) \log (1+\varphi(t))
\end{aligned}
$$

then, making $\theta=\varphi(k / n)$, and adding in $k$, we get from (6.3)

$$
\begin{array}{r}
\frac{1}{\beta^{\prime} n^{2}}\left(\mathcal{L}_{n,\lfloor n t\rfloor}^{G}(\varphi)-\sum_{2}^{\lfloor n t\rfloor} R_{n, k}(\varphi(k / n))\right)=\frac{1}{n} \sum_{1}^{\lfloor n t\rfloor} \Phi_{n}\left(\frac{k}{n}\right) \\
=\int_{1 / n}^{\lfloor n t\rfloor / n} \Phi_{n}\left(\frac{\lfloor n t\rfloor}{n}\right) d t+\frac{1}{n} \Phi_{n}\left(\frac{\lfloor n t\rfloor}{n}\right) .
\end{array}
$$

On the one hand, since $\varphi$ is left continuous, $\lim _{n} \Phi_{n}\left(\frac{\lfloor n t\rfloor}{n}\right)=g(t, \varphi(t))$ for every $t \in[0, T]$. On the other hand the following double inequality holds true:

\begin{aligned}
\Phi_{n}(t) & \geq(1-t+\varphi(t)) \log (1-t+\varphi(t))-(1-t) \log (2-t) \\
& -(1+\varphi(t)) \log (1+\varphi(t))-|\log (1-t+\varphi(t))| \\
\Phi_{n}(t) & \leq(1-t+\varphi(t)) \log (2-t+\varphi(t))-(1-t) \log (1-t) \\
& -(1+\varphi(t)) \log (1+\varphi(t))+|\log (1-t+\varphi(t))|,
\end{aligned}
$$

and with our assumptions on $\varphi$, these bounds are both integrable. This allows to apply the dominated convergence theorem which ends the proof of Lemma 6.7

If there exists $s<T$ such that $\varphi(s)<-(1-s)$ then for $n$ large enough, $\mathcal{L}_{n,\lfloor n T\rfloor}(\varphi)=+\infty$ and we set $\Lambda_{[0, T]}^{G}(\varphi)=\infty$. In the other cases we do not know what happens, but as in [30, we will study the exposed points. Before, we need another expression of the dual of $\Lambda_{[0, T]}^{G}$.
6.1.2. Variational formula. Let us define $\Lambda_{[0, T]}^{G}(\varphi)=+\infty$ if $\varphi$ does not satisfy the assumption of Lemma 6.1] The dual of $\Lambda_{[0, T]}^{G}$ is then

\left(\Lambda_{[0, T]}^{G}\right)^{\star}(\nu)=\sup _{\varphi \in V_{\ell}}\left\{\langle\nu, \varphi\rangle-\Lambda_{[0, T]}^{G}(\varphi)\right\} \tag{6.6}

for $\nu \in V_{\ell}^{*}$. Mimicking the method of Léonard (45] p. 112-113), we get

\left(\Lambda_{[0, T]}^{G}\right)^{\star}(\nu)=\sup _{\varphi \in \mathcal{C}}\left\{\langle\nu, \varphi\rangle-\Lambda_{[0, T]}^{G}(\varphi)\right\} \tag{6.7}
\end{equation*}
$$

where $\mathcal{C}$ is the set of continuous functions from $[0, T]$ into $\mathbb{R}$ vanishing at 0 . Then we apply Theorem 5 of Rockafellar [59] and get

\left(\Lambda_{[0, T]}^{G}\right)^{\star}(\nu)=\int_{0}^{T} g^{\star}\left(t, \frac{d \nu_{a}}{d t}\right) d t+\int_{0}^{T} r\left(t, \frac{d \nu_{s}}{d \mu}(t)\right) d \mu(t)
$$

where

$$
\begin{equation*}
g^{\star}(t, y)=\sup _{\lambda}\left\{\lambda y-g^{G}(t, \lambda) \delta(\lambda \mid(-1, \infty))\right\}, \tag{6.8}
\end{equation*}
$$

and $r$ is the recession function :

$$
r(t, y)=\lim _{\kappa \rightarrow \infty} \frac{g^{\star}(t, \kappa y)}{\kappa}
$$

Actually, if $y<0$, the supremum is achieved for

\lambda^{G}(t, y):=-\left(1-\frac{t}{1-e^{y}}\right) \tag{6.9}
\end{equation*}
$$

and we have

$$
\begin{align*}
g^{\star}(t, y) & =\lambda^{G}(t, y) y-g^{G}\left(t, \lambda^{G}(t, y)\right) \\
& =-y(1-t)+(1-t) \log (1-t)+t \log t-t \log \left(1-e^{y}\right) \\
& =\mathbf{H}\left(1-t \mid e^{y}\right) . \tag{6.10}
\end{align*}
$$

If $y \geq 0, g^{\star}(t, y)=\infty$. The recession is now $r(t, y)=-(1-t) y$ if $y \leq 0$, and $=\infty$ si $y>0$. As a result

\begin{equation*}
g^{\star}(t, y)=L_{a}^{G}(t, y) \quad, \quad r(t, y)=L_{s}^{G}(t, y) . \tag{6.11}
\end{equation*}
$$

So we proved the identification $\left(\Lambda_{[0, T]}^{G}\right)^{\star}=\widetilde{I}_{[0, T]}^{G}($ recall (6.1]) $)$.
6.1.3. Exponential tightness. In this paragraph and in Section 6.2 we use the function defined for $\theta>-(1-T)$ by

L_{T}^{G}(\theta):=\int_{0}^{T} g^{G}(t, \theta) d t \tag{6.12}
\end{equation*}
$$

If $V_{\ell}^{*}$ is equipped with the topology $\sigma\left(V_{\ell}^{*}, V_{\ell}\right)$, the set

$$
B_{a}:=\left\{\mu \in V_{\ell}^{*}:|\mu|_{[0, T]} \leq a\right\}
$$

is compact according to the Banach-Alaoglu theorem. Now $-\dot{\Theta}_{n}^{G}$ is a positive measure and its total mass is $-\dot{\Theta}_{n}^{G}([0, T])=-\Xi_{n}(T)$. We have then

$$
\mathbb{P}\left(\dot{\Theta}_{n}^{G} \notin B_{a}\right)=\mathbb{P}\left(\Theta_{n}^{G}(T)<-a\right) .
$$

Now for $\theta<0$

$$
\mathbb{P}\left(\Theta_{n}^{G}(T)<-a\right) \leq e^{\beta^{\prime} \theta n^{2} a} \mathbb{E} \exp \left\{n^{2} \beta^{\prime} \theta \Theta_{n}^{G}(T)\right\}
$$

so that, taking logarithm and applying Lemma.6.1we get, for $\theta \in(-(1-T), 0)$

$$
\limsup _{n} \frac{1}{\beta^{\prime} n^{2}} \log \mathbb{P}\left(\Theta_{n}^{G}(T)<-a\right) \leq \theta a+L_{T}^{G}(\theta)
$$

It remains to let $a \rightarrow \infty$ and we have proved the exponential tightness.
Let us notice that the restriction $T<1$ is crucial in the above proof.
6.1.4. Exposed points. Let $\mathcal{R}$ be the set of functions from $[0, T]$ into $\mathbb{R}$ which are positive, continuous and with bounded variation. Let $\mathcal{F}$ be the set of those $m \in V_{\ell}^{*}$ (identified with $\mathcal{M}_{T}$ as in [45]) which are absolutely continuous and whose density $\rho$ is such that $-\rho \in \mathcal{R}$. Let us prove that such a $m$ is exposed, with exposing hyperplane $f_{m}(t)=\lambda(t, \rho(t))$ (recall (6.9)). Actually we follow the method of 30. For fixed $t, g^{\star}(t,$.$) is strictly convex on (-\infty, 0)$ so that, if $z \neq \rho(t)$, we have

$$
g^{\star}(t, \rho(t))-g^{\star}(t, z)<\lambda(t, \rho(t))(\rho(t)-z) .
$$

Let $d \xi=\tilde{l}(t) d t+\xi^{\perp}$ the Lebesgue decomposition of some element $\xi \in \mathrm{M}_{T}$ such that $\widetilde{I}_{[0, T]}^{G}(\xi)<\infty$. Taking $z=\tilde{l}(t)$ and integrating, we get
$\int_{0}^{T} g^{\star}\left(t, \rho(t) d t-\int_{0}^{T} g^{\star}(t, \tilde{l}(t)) d t<\int_{0}^{T} \lambda(t, \rho(t)) \rho(t) d t-\int_{0}^{T} \lambda(t, \rho(t)) \tilde{l}(t) d t\right.$ and since $\int_{0}^{T} g^{\star}(t, \tilde{l}(t)) d t=\int_{0}^{T} L_{a}^{G}(t, \tilde{l}(t)) d t \leq \widetilde{I}_{[0, T]}^{G}(\xi)$ this yields

$$
\widetilde{I}_{[0, T]}^{G}(m)-\widetilde{I}_{[0, T]}^{G}(\xi)<\int_{0}^{T} f_{m} d m-\int_{0}^{T} f_{m} d \xi .
$$

The following lemma says that this set of exposed points is rich enough.
Lemma 6.2. Let $m \in V_{r}$ such that $\widetilde{I}_{[0, T]}^{G}(m)<\infty$. There exists a sequence of functions $l_{n} \in \mathcal{R}$ such that
(1) $\lim _{n} l_{n}(t) d t=-m$ in $V_{\ell}^{*}$ with the $\sigma\left(V_{\ell}^{*}, V_{\ell}\right)$ topology,
(2) $\lim _{n} \widetilde{I}_{[0, T]}^{G}\left(-l_{n}(t) d t\right)=\widetilde{I}_{[0, T]}^{G}(m)$.

Proof: The method may be found in [30] and in 19. The only difference is in the topology because we want to recover marginals. We will use the basic inequality which holds for every $\epsilon \leq 0$ :

Let $m=m_{a}+m_{s}$ such that $\widetilde{I}_{[0, T]}^{G}(m)<\infty$. From (3.38) and (3.36) it is clear that $-m_{a}$ and $-m_{s}$ must be positive measures.

First step We assume that $m=-l(t) d t-\eta$ with $l \in L^{1}([0, T] ; d t)$ and $\eta$ a singular positive measure. One can find a sequence of non negative continuous functions $h_{n}$ such that $h_{n}(t) d t \rightarrow \eta$ for the topology $\sigma\left(V_{\ell}^{*}, V_{\ell}\right)$. Indeed every function $\psi \in V_{\ell}$ may be written as a difference $\psi_{1}-\psi_{2}$ of two increasing functions. There exists a unique (positive) measure $\alpha_{1}$ such that $\psi_{1}(t)=$ $\alpha_{1}([t, T])$ for every $t \in[0, T]$. Moreover, the function $g=\eta([0, \cdot]) \in V_{r}$ is non decreasing and may be approached by a sequence of continuously derivable and non decreasing functions $\left(g_{n}\right)$ such that $g_{n} \leq g$. Setting $h_{n}:=g_{n}^{\prime}$ and $\nu_{n}=h_{n}(t) d t$, the dominated convergence theorem gives

$$
\left\langle\psi_{1}, \nu_{n}\right\rangle=\int_{0}^{T} \nu_{n}([0, t]) \alpha_{1}(d t) \rightarrow \int_{0}^{T} \eta([0, t]) \alpha_{1}(d t) .
$$

With the same result for $\psi_{2}$ we get

\begin{aligned}
\left\langle\psi, \nu_{n}\right\rangle & =\int_{0}^{T} \nu_{n}([0, t]) \alpha_{1}(d t)-\int_{0}^{T} \nu_{n}([0, t]) \alpha_{2}(d t) \\
& \rightarrow \int_{0}^{T} \eta([0, t]) \alpha_{1}(d t)-\int_{0}^{T} \eta([0, t]) \alpha_{2}(d t)
\end{aligned}
$$

or $\lim _{n}\left\langle\psi, \nu_{n}\right\rangle=\langle\psi, \eta\rangle$. On the one hand, the lower semi-continuity of $\widetilde{I}_{[0, T]}^{G}$ yields

$$
\liminf _{n} \widetilde{I}_{[0, T]}^{G}\left(-\left(l(t)+h_{n}(t)\right) d t\right) \geq \widetilde{I}_{[0, T]}^{G}(m)
$$

On the other hand, integrating (6.13) yields

$$
\begin{aligned}
\widetilde{I}_{[0, T]}^{G}\left(-\left(l(t)+h_{n}(t)\right) d t\right) & \leq \int_{0}^{T} L_{a}^{G}(t,-l(t)) d t+\int_{0}^{T}(1-t) h_{n}(t) d t \\
& \rightarrow \int_{0}^{T} L_{a}^{G}(t,-l(t)) d t+\int_{0}^{T}(1-t) \eta(d t)=\widetilde{I}_{[0, T]}^{G}(m)
\end{aligned}
$$

Second step Let us assume that $m=-l(t) d t$ with $l \in L^{1}([0, T] ; d t)$ and for every $n$, let us set $l_{n}=\max (l, 1 / n)$. It is clear that as $n \rightarrow \infty$, then $l_{n} \downarrow l$. On the one hand the lower semi-continuity gives

$$
\liminf _{A} \widetilde{I}_{[0, T]}^{G}\left(-l_{n}(t) d t\right) \geq I_{[0, T]}^{G}(-l(t) d t)
$$

On the other hand, by integration of inequality (6.13), since $l_{n}-l \leq 1 / n$

$$
I_{[0, T]}^{G}\left(-l_{n}(t) d t\right) \leq I_{[0, T]}^{G}(-l(t) d t)+\frac{1}{n}
$$

It is then possible to reduce the problem to the case of functions bounded below.

Third step Let us assume that $m=-l(t) d t$ with $l \in L^{1}([0, T] ; d t)$ and bounded below by $A>0$. One can find a sequence of continuous functions $\left(h_{n}\right)$ with bounded variation such that $h_{n} \geq A / 2$ for every $n$ and such that $h_{n} \rightarrow l$ a.e. and in $L^{1}([0, T], d t)$. We have $h_{n}(t) d t \rightarrow l(t) d t$ in $\sigma\left(V_{\ell}^{*}, V_{\ell}\right)$ and since $L_{a}^{G}(t, \cdot)$ is uniformly Lipschitz on $(-\infty,-A / 2$ ], say with constant $\kappa$, we get

$$
\left|\widetilde{I}_{[0, T]}^{G}\left(-h_{n}(t) d t\right)-\widetilde{I}_{[0, T]}^{G}(-l(t) d t)\right| \leq \kappa \int_{0}^{T}\left|h_{n}(t)-l(t)\right| d t \rightarrow 0 .
$$

Actually, $h_{n} \in \mathcal{R}$ and $\varphi_{n}(t):=\lambda\left(t,-h_{n}(t)\right)$ satisfies the assumption of Lemma 6.1 since

$$
1+\varphi_{n}(t)-t \geq \frac{t}{1-e^{-A / 2}} .
$$

6.1.5. End of the proof of Theorem 3.9. The first step is the upper bound for compact sets. We use Theorem 4.5.3 b) in [17] and the following lemma.

Lemma 6.3. For every $\delta>0$ and $m \in V_{\ell}^{*}$, there exists $\varphi_{\delta}$ fulfilling the conditions of Lemma 6.1 and such that

\begin{equation*}
\int_{0}^{T} \varphi_{\delta} d m-\Lambda_{T}^{G}\left(\varphi_{\delta}\right) \geq \min \left[I_{[0, T]}^{G}(m)-\delta, \delta^{-1}\right] \tag{6.14}
\end{equation*}
$$

The second step is the upper bound for closed sets: we use the exponential tightness. The third step is the lower bound for open sets. The method is classical (see [17] Theorem 4.5.20 c)), owing to Lemma 6.2,

To prove Lemma 6.3] we start from the definition (6.6) or (6.7). One can find $\bar{\varphi}_{\delta} \in V_{\ell}$ satisfying (6.14). If $\bar{\varphi}_{\delta}$ does not check assumptions of the lemma we add $\varepsilon>0$ to $\bar{\varphi}_{\delta}$ which allows to check them and satisfy (6.14) up to a change of $\delta$.
6.2. Proof of Theorem 3.10, We use the contraction from the LDP for paths. Since the mapping $m \mapsto m([0, T])$ is continuous from $D$ to $\mathbb{R}$, the family $\Theta_{n}^{G}(T)$ satisfies the LDP with good rate function given by (3.40):

I_{T}^{G}(\xi)=\inf \left\{I_{[0, T]}^{G}(v) ; v(T)=\xi\right\}
$$

Since the process $\Theta_{n}^{G}$ takes its values in $(-\infty, 0]$ (remember Hadamard inequality), it is clear that $I_{T}^{G}(\xi)=\infty$ for $\xi>0$.

Fixing $\xi<0$, we can look for optimal $v$. Let $\theta>-(1-T)$ (playing the role of a Lagrange multiplier).

By the duality property (6.8)

g^{\star}\left(t, \frac{d \dot{v}_{a}}{d t}(t)\right) \geq \theta \frac{d \dot{v}_{a}}{d t}(t)-g^{G}(t, \theta)
$$

Integrating and using (6.1), (6.11) and (6.5) we get

I_{[0, T]}^{G}(v) \geq \theta \dot{v}_{a}([0, T])-L_{T}^{G}(\theta)-\int_{0}^{T}(1-t) d \dot{v}_{s}(t) \tag{6.15}
\end{equation*}
$$

For every $v$ such that $v(T)=\xi$ it turns out that

$$
\begin{equation*}
I_{[0, T]}^{G}(v) \geq \theta \xi-L_{T}^{G}(\theta)-\int_{0}^{T}(1-t+\theta) d \dot{v}_{s}(t) \geq \theta \xi-L_{T}^{G}(\theta) \tag{6.16}
\end{equation*}
$$

Besides, from (6.9) the ordinary differential equation

\lambda^{G}\left(t, \phi^{\prime}(t)\right) & =\theta \\
\phi(0) & =0,
\end{aligned}
$$

admits for unique solution in $\mathcal{C}^{1}([0, T])$

t \mapsto \phi(\theta ; t):=\mathcal{J}(1+\theta)-\mathcal{J}(1-t+\theta)-t \log (1+\theta) .
$$

Now, since

\frac{\partial}{\partial \theta} \phi(\theta ; T)=-\left[\log \left(1-\frac{T}{1+\theta}\right)+\frac{T}{1+\theta}\right]>0
$$

we see that the mapping $\theta \mapsto \phi(\theta ; T)$ is bijective from $[-(1-T), \infty)$ onto $[-T, 0)$. Moreover, by duality

- Let us assume $\xi=-T-\varepsilon$ with $\varepsilon>0$. Plugging $\theta=-(1-T)$ in (6.16) yields, for every $v$ such that $v(T)=\xi$

Remark 6.4. It is possible to try a direct method to get (3.42), (3.43) using Gärtner-Ellis' theorem (17], Theorem 2.3.6). From Lemma 6.1 the limiting n.c.g.f. of $\Theta_{n}^{G}(T)$ is $L_{T}^{G}$ which is analytic on $(-(1-T), \infty)$. When $\theta \downarrow-(1-T)$, we have $\left(L_{T}^{G}\right)^{\prime}(\theta) \downarrow-T$. We meet a case of so called non steepness. To proceed in that direction we could use the method of time dependent change of probability (see Dembo and Zeitouni [16]). We will not give details here. Nevertheless, this approach allows to get one-sided large deviations in the critical case $T=1$. Actually we get

I do not know the rate of convergence to 0 of $\mathbb{P}\left(\Theta_{n}^{G}(1) \leq n x\right)$ for $x<-1$.
6.3. Proof of Theorem 3.11 and Theorem 3.12, Again, the three routes are possible to tackle the problem of large deviations for determinant of Wishart matrices. A direct method would use the cumulant generating function from (5.13) and would meet computations similar to those seen in the Uniform Gram case.

To avoid repetitions, we use the decomposition (2.26), drawing benefit from an auxiliary study of $S_{n, r}$.

Lemma 6.5. The sequence $\left\{n^{-1} S_{n}(t), t \in[0,1)\right\}_{n}$ satisfies a $L D P$ in the space $\left(D, \sigma\left(D, \mathrm{M}_{<}\right)\right)$in the scale $2 \beta^{-1} n^{-2}$ with good rate function

\end{equation*}

where

L_{a}^{S}(y)=\left(e^{y}-y-1\right), L_{s}^{S}(y)=-y \delta(y \mid(-\infty, 0)), \tag{6.18}
\end{equation*}
$$

and $\mu$ is any measure dominating d $\dot{v}_{s}$.
Let us stress that the instantaneous rate functions are time homogeneous and then we may write $[0,1]$ instead of $[0,1)$.
6.3.1. Proof of Lemma 6.5. It is a route similar to the proof of Theorem 3.9] in Section 6.1 (see also Najim [53]). We start from (2.27) so that

-n \ell\left(\beta^{\prime} n\right)
\end{array}
$$

if $\gamma(s)+1>0$ for every $s \in[0,1]$. A little computation shows that the limiting n.c.g.f. is

We deduce from Lemma 6.5 and Theorem 3.9 that the sum $\dot{\Theta}_{n}^{L}=\dot{\Theta}_{n}^{G}+\frac{1}{n} \dot{S}_{n}$ satisfies a LDP in the same scale with good rate function $I_{[0, T]}^{G} \square I_{[0, T]}^{S}$ where $\square$ denotes the infimum convolution :

6.3.3. Proof of Theorem 3.12, We may either use the contraction $\Theta_{n}^{L} \mapsto \Theta_{n}^{L}(T)$ or establish a LDP for the marginal $S_{n}(T)$ and then perform an inf-convolution. We leave the details of the proof to the reader. We just give the expression of the optimal path when it exists.

For $\theta>-(1-T)$, the function

Then $v^{\xi}:=\phi\left(\theta_{\xi}, \cdot\right)$ is the optimal path ( $v^{\xi}$ realizes the infimum in (3.45). Let us notice that at the end point $\xi=\xi_{T}$, we have

Notice that the second (right) derivative of $I_{1}^{L}$ at this point is zero (or equivalently $\lim \left(L_{1}^{L}\right)^{\prime \prime}(\theta)=\infty$ as $\theta \downarrow 0$ ), which is consistent with previous results on variance. I do not know the rate of convergence to 0 of $\mathbb{P}\left(\log \Delta_{n}^{L, \beta}(1) \leq n x\right)$ for $x<-1$.
6.4. Proof of Theorem 3.13 and Theorem 3.14, We may try again to use the beta-gamma algebra, but we do not succeed to go until the end. Let as in Subsection 5.5, $U_{n}$ and $V_{n}$ be the two Laguerre variables. From the exponential tightness of $U_{n}$ and $V_{n}$, we deduce easily the exponential tightness of $W_{n}$. From Pukhalskii (56]), the sequence $W_{n}$ contains subsequences satisfying LDP. If for such a subsequence we call $I^{p}$ the rate function, the independence gives

We choose to use the beta-gamma trick to study the n.c.g.f. For the remaining we do not give details since it is similar to the above cases and again based on the ideas of Baldi theorem ( $[17$ ) and a variational formula.
6.4.1. Convergence of the n.c.g.f. We set $\Theta_{n}^{J}=n^{-1} \log \Delta_{n}^{J, \beta}$ and

Lemma 6.7. If $\varphi \in V_{\ell}^{\tau_{1}}$ satisfies $\varphi(s)+\tau_{1}-s>0$ for every $s \in(0, T]$, then

\end{array}

and then, by independence,

- & \log \mathbb{E} \exp \left\langle\beta^{\prime} n\left(n_{1}+n_{2}\right) \dot{\Theta}_{n_{1}+n_{2}}^{L}, \gamma\left(\left(n_{1}+n_{2}\right) \cdot / n\right)\right\rangle \\
& +n \log \frac{n_{1}}{n_{1}+n_{2}}\left(\sum_{k=1}^{\lfloor n T\rfloor} \gamma(k / n)\right) .
\end{aligned}
$$

By a slight modification of (6.20) we have, for $p / n \rightarrow \tau$

Since the process $\Theta_{n}$ takes its values in $(-\infty, 0]$, it is clear that $I_{T}^{J}(\xi)=\infty$ for $\xi>0$. Fixing $\xi<0$, we can look for optimal $v$, i.e. a path $(v(t), t \in[0, T])$ such that $v(T)=\xi$ and $v$ achieves the infimum in (3.50). Fix $\theta \geq T-\tau_{1}$ (playing the role of a Lagrange multiplier). In view of (6.28), (6.29) and (6.30), it is clear that (in the generic case) the Euler-Lagrange equation is

since it is positive, we see that the mapping

L_{T}^{J}(\theta):=\int_{0}^{T} g^{J}(t, \theta) d t \tag{6.34}
\end{equation*}
$$

integrating (6.33) and using (3.35), (3.49) and (6.34) we get

$$
I_{[0, T]}^{J}(v) \geq \theta \dot{v}_{a}([0, T])-L_{T}^{J}(\theta)-\int_{0}^{T}\left(\tau_{1}-t\right) d \dot{v}_{s}(t) .
$$

For every $v$ such that $v(T)=\xi$ it turns out that

$$
\begin{equation*}
I_{[0, T]}^{J}(v) \geq \theta \xi-L_{T}^{J}(\theta)-\int_{0}^{T}\left(\tau_{1}-T+\theta\right) d \dot{v}_{s}(t) \geq \theta \xi-L_{T}^{J}(\theta) . \tag{6.35}
\end{equation*}
$$

There are three cases.

- If $\xi \in\left[\xi_{T}^{J}, 0\right)$, we get

$$
I_{[0, T]}^{J}\left(v^{\xi}\right)=\theta_{\xi} \xi-L_{T}^{J}\left(\theta_{\xi}\right)
$$

so that $v^{\xi}$ realizes the infimum in (3.50). A simple computation leads to (3.42) which ends the proof of the first statement of Theorem 3.10.

Let us notice that at the end point $\xi=\xi_{T}^{J}$, we have

$$
\theta_{\xi}=\left(T-\tau_{1}\right), v^{\xi}(t)=\mathcal{E}\left(T, \tau_{2}, t\right),\left(v^{\xi}\right)^{\prime}(t)=\log \frac{T-t}{\tau_{1}+\tau_{2}-t} .
$$

- Let us assume $\xi=\xi_{T}^{J}-\varepsilon$ with $\varepsilon>0$. Plugging $\theta=T-\tau_{1}$ in (6.35) yields, for every $v$ such that $v(T)=\xi$

$$
I_{[0, T]}^{J}(v) \geq\left(T-\tau_{1}\right) \xi_{T}^{J}-L_{T}^{J}\left(T-\tau_{1}\right)-\varepsilon\left(T-\tau_{1}\right)=I_{T}^{J}\left(\xi_{T}^{J}\right)-\varepsilon\left(T-\tau_{1}\right),
$$

and this lower bound is achieved by the measure $\tilde{v}=\left(v^{\xi_{T}^{J}}\right)^{\prime}(t) d t-\varepsilon d \delta_{T}(t)$, since

$$
\int_{0}^{T} L_{a}^{J}\left(t,\left(v^{\xi_{T}^{J}}\right)^{\prime}(t)\right) d t=I_{T}^{J}\left(\xi_{T}^{J}\right), \quad \int_{0}^{T}\left(\tau_{1}-t\right) \varepsilon d \delta_{T}(t)=\left(\tau_{1}-T\right) \varepsilon
$$

- It remains to look at $\xi=0$. Taking $\xi=0$ in (6.35), we get $I_{[0, T]}^{J}(0) \geq-L_{T}^{J}(\theta)$ for every $\theta \geq T-\tau_{1}$. Now, from (6.24) and (6.34), we may write (after some calculation)

$$
\begin{aligned}
-L_{T}^{J}(\theta)=\int_{0}^{T}-\mathcal{E}\left(\tau_{1}-t+\theta, \tau_{2}, \theta\right) d t & =\int_{0}^{T} \int_{0}^{\theta} \log \left(1+\frac{\tau_{2}}{\tau_{1}-t+s}\right) d s \\
& \geq T \int_{0}^{\theta} \log \left(1+\frac{\tau_{2}}{\tau_{1}+s}\right) d s
\end{aligned}
$$

which tends to infinity as $\theta \rightarrow \infty$. We conclude $I_{[0, T]}^{J}(0)=\infty$.

## 7. Proofs of Theorems of Section 4

7.1. Proof of Proposition 4.1, Let $\theta \in \mathbb{R}$ be a Lagrangian factor. We begin by minimizing

$$
I_{T}^{s p L}(\mu)-\theta T \int \log x d \mu(x)=T^{2}\left[-\Sigma(\mu)+2 \int q_{\lambda, s}(x) d \mu(x)\right]+2 B(T)
$$

where

$$
\begin{equation*}
q_{\lambda, s}(x)=\lambda x-s \log x, \quad \lambda=\frac{1}{2 T}, \quad s=\frac{1-T+\theta}{2 T} . \tag{7.1}
\end{equation*}
$$

In Saff and Totik 60] p. 43 example 5.4, it is stated that for $\lambda>0$ and $2 s+1>0$ fixed, the infimum

$$
\inf _{\mu}-\Sigma(\mu)+2 \int q_{\lambda, s}(x) d \mu(x)
$$

is achieved by the unique extremal measure $\pi_{\sigma^{2}}^{c}$ with

$$
\sigma^{2}=\frac{2 s+1}{2 \lambda}, c=\frac{1}{2 s+1} .
$$

We see from (7.1) that if $\theta>-1$ we can take:

$$
\sigma^{2}=1+\theta, \quad c=\frac{T}{\sigma^{2}}=\frac{T}{1+\theta} .
$$

Now it remains to look for $\theta$ such that the constraint $\mu \in \mathcal{A}(\xi / T)$ is saturated. Since

$$
\int \log x d \pi_{\sigma^{2}}^{c}(x)=\log \sigma^{2}+\int \log x d \pi_{1}^{c}(x) d x
$$

and thanks to (4.6) we see that $\theta$ must satisfy

$$
\xi=T \log \sigma^{2}-T \frac{\mathcal{J}(1-c)}{c}=\mathcal{J}(1+\theta)-\mathcal{J}(1-T+\theta)
$$

which is exactly exactly (3.46).
To compute $I_{T}^{s p L}\left(\pi_{\sigma^{2}}^{c}\right)$, we start from the definition (4.8):

$$
I_{T}^{s p L}\left(\pi_{\sigma^{2}}^{c}\right)=-T^{2} \Sigma\left(\pi_{\sigma^{2}}^{c}\right)+T \int(x-(1-T) \log x) d \pi_{\sigma^{2}}^{c}(x)+2 B(T)
$$

and transform $\pi_{\sigma^{2}}^{c}$ to $\pi_{1}^{c}$ using the dilatation. In particular, (4.9) yields

$$
\Sigma\left(\pi_{\sigma^{2}}^{c}\right)=\log \sigma^{2}+\Sigma\left(\pi_{1}^{c}\right)
$$

and $\Sigma\left(\pi_{1}^{c}\right)$ may be picked from formula (13) p. 10 in [35] :

$$
\Sigma\left(\pi_{1}^{c}\right)=-1+\frac{1}{2}\left(c^{-1}+\log c+\left(c^{-1}-1\right)^{2} \log (1-c)\right) .
$$

Besides we have easily $\int x d \pi_{1}^{c}(x)=1$. After some tedious but elementary computations we get exactly the RHS of (3.47), which yields

$$
I_{T}^{s p L}\left(\pi_{\sigma^{2}}^{c}\right)=I_{T}^{L}(\xi),
$$

and ends the proof of (4.12).
7.2. Proof of Proposition 4.6, Let $\theta<t-\tau_{1}$ (Lagrangian multiplier). We begin by minimizing

$$
\begin{align*}
I_{t}^{s p J}(\mu) & -\theta t \int \log x d \mu(x)  \tag{7.2}\\
& =t^{2}\left[-\Sigma(\mu)-2 \zeta_{1} \int \log x d \mu(x)-2 \zeta_{2} \int \log (1-x) d \mu(x)\right]+C
\end{align*}
$$

where

$$
2 \zeta_{1}=\frac{\tau_{1}+\theta-t}{t}, 2 \zeta_{2}=\frac{\tau_{2}-t}{t} \text { and } C=t^{2} B\left(\frac{\tau_{1}-t}{t}, \frac{\tau_{2}-t}{t}\right)
$$

We use the following lemma.
Lemma 7.1. For $\zeta_{1}, \zeta_{2}>0$, the infimum of

$$
-\Sigma(\mu)-2 \zeta_{1} \int \log x d \mu(x)-2 \zeta_{2} \int \log (1-x) d \mu(x)
$$

among the probability measures $\mu$ on $[0,1]$ is achieved by $\pi_{a_{-}, a_{+}}$where

$$
\left(a_{-}, a_{+}\right)=\lambda_{ \pm}\left(s_{-}, s_{+}\right)
$$

with

$$
s_{-}=\frac{1+2 \zeta_{1}}{2\left(1+\zeta_{1}+\zeta_{2}\right)}, s_{+}=\frac{1+2 \zeta_{1}+2 \zeta_{2}}{2\left(1+\zeta_{1}+\zeta_{2}\right)} .
$$

The infimum in (7.2) is achieved by $\pi_{\tilde{\xi}, \tilde{\eta}}$, where

$$
(\tilde{\xi}, \tilde{\eta})=\lambda_{ \pm}\left(\tilde{s}_{-}, \tilde{s}_{+}\right), \quad \tilde{s}_{-}=\frac{\tau_{1}+\theta}{\tau_{1}+\tau_{2}+\theta}, \quad \tilde{s}_{+}=\frac{\tau_{1}+\theta+\tau_{2}-t}{\tau_{1}+\tau_{2}+\theta} .
$$

It should be clear that

$$
\begin{aligned}
& \Sigma\left(\pi_{\tilde{\xi}, \tilde{\eta}}\right)+\frac{\tau_{1}+\theta-t}{t} \int \log x d \pi_{\tilde{\xi}, \tilde{\eta}}(x)+\frac{\tau_{2}-t}{t} \int \log (1-x) d \pi_{\tilde{\xi}, \tilde{\eta}}(x) \\
&=B\left(\frac{\tau_{1}+\theta-t}{t}, \frac{\tau_{2}-t}{t}\right)
\end{aligned}
$$

and then, on $\mathcal{A}\left(\xi T^{-1}\right)$ the infimum is uniquely realized in $\pi_{\tilde{\xi}, \tilde{\eta}}$ and its value is

$$
\theta \xi+t^{2}\left[B\left(\frac{\tau_{1}-t}{t}, \frac{\tau_{2}-t}{t}\right)-B\left(\frac{\tau_{1}+\theta-t}{t}, \frac{\tau_{2}-t}{t}\right)\right]
$$

Finally a small computation leads to (3.52) and (4.31).
Proof of Lemma 7.1 In [60] p.241, it is proved that the infimum of

$$
\iint-\log |x-y| d \mu(x) d \mu(y)-2 \zeta_{1} \int \log (1-x) d \mu(x)-2 \zeta_{2} \int \log (1+x) d \mu(x)
$$

among the probability measures $\mu$ on $[-1,+1]$ is achieved by

$$
d \mu(y)=K\left(b_{-}, b_{+}\right) \frac{\sqrt{\left(y-b_{-}\right)\left(b_{+}-y\right)}}{2 \pi\left(1-y^{2}\right)} \mathbb{1}_{\left[b_{-}, b_{+}\right]}(y) d y
$$

where $b_{ \pm}=\theta_{2}^{2}-\theta_{1}^{2} \pm \sqrt{\Delta}$ with

$$
\theta_{i}=\frac{\zeta_{i}}{1+\zeta_{1}+\zeta_{2}}, i=1,2 \quad, \quad \Delta=\left[1-\left(\theta_{1}+\theta_{2}\right)^{2}\right]\left[1-\left(\theta_{1}-\theta_{2}\right)^{2}\right] .
$$

and $K\left(b_{-}, b_{+}\right)$is a normalizing constant. With the push-forward by the function $x \rightarrow(x+1) / 2$, we get the result.

## 8. Appendix 1: Some properties of $\ell=\log \Gamma$ and $\Psi$

From the Binet formula (Abramowitz and Stegun [2] or Erdélyi et al. [27] p.21), we have

$$
\begin{align*}
\ell(x) & =\left(x-\frac{1}{2}\right) \log x-x+1+\int_{0}^{\infty} f(s)\left[e^{-s x}-e^{-s}\right] d s  \tag{8.1}\\
& =\left(x-\frac{1}{2}\right) \log x-x+\frac{1}{2} \log (2 \pi)+\int_{0}^{\infty} f(s) e^{-s x} d s \tag{8.2}
\end{align*}
$$

where the function $f$ is defined by

$$
\begin{equation*}
f(s)=\left[\frac{1}{2}-\frac{1}{s}+\frac{1}{e^{s}-1}\right] \frac{1}{s}=2 \sum_{k=1}^{\infty} \frac{1}{s^{2}+4 \pi^{2} k^{2}}, \tag{8.3}
\end{equation*}
$$

and satisfies for every $s \geq 0$

$$
\begin{equation*}
0<f(s) \leq f(0)=1 / 12, \quad 0<\left(s f(s)+\frac{1}{2}\right)<1 . \tag{8.4}
\end{equation*}
$$

By differentiation

$$
\begin{equation*}
\log x-\Psi(x)=\frac{1}{2 x}+\int_{0}^{\infty} s f(s) e^{-s x} d s=\int_{0}^{\infty} e^{-s x}\left(s f(s)+\frac{1}{2}\right) d s \tag{8.5}
\end{equation*}
$$

As easy consequences, we have, for every $x>0$

$$
\begin{align*}
& 0<x(\log x-\Psi(x)) \leq 1  \tag{8.6}\\
& 0<\log x-\Psi(x)-\frac{1}{2 x} \leq \frac{1}{12 x^{2}} \tag{8.7}
\end{align*}
$$

Differentiating again we see that for $q \geq 1$

$$
\begin{equation*}
\Psi^{(q)}(z)=(-1)^{q-1} q!z^{-q}+(-1)^{q-1} \int_{0}^{\infty} e^{-s z} s^{q}\left(s f(s)+\frac{1}{2}\right) d s \tag{8.8}
\end{equation*}
$$

and then

$$
\begin{equation*}
\left|\Psi^{(q)}(z)-(-1)^{q-1} q!z^{-q}\right| \leq z^{-q-1} q!. \tag{8.9}
\end{equation*}
$$

## 9. Appendix 2 : Identification of the McKay distribution

Recall that, for $u^{\prime}$ and $v^{\prime}$ positive numbers ${ }^{3}$ such that $u^{\prime}+v^{\prime}>1$, Capitaine and Casalis [11] defined the probability measure
$\mathrm{CC}_{u^{\prime}, v^{\prime}}:=\left(1-u^{\prime}\right)^{+} \delta_{0}+\left(1-v^{\prime}\right)^{+} \delta_{1}+\left[1-\left(1-u^{\prime}\right)^{+}-\left(1-v^{\prime}\right)^{+}\right] \pi_{a_{-}, a_{+}}$,
where

$$
\left(a_{-}, a_{+}\right)=a_{ \pm}\left(\frac{u^{\prime}}{u^{\prime}+v^{\prime}}, 1-\frac{1}{u^{\prime}+v^{\prime}}\right) .
$$

We present now three identifications of this distribution connected with free probability.

For $k \neq 0$, let $D_{k}$ the dilatation operator by factor $k$. For $p \leq 1$, let $\mathrm{b}_{p}$ denote the Bernoulli distribution of parameter $p$. At last, let $\boxplus$ (resp. $\boxtimes)$ denote the additive (resp. multiplicative) free convolution.

1) Rewriting the distribution with the notation of Demni [18, we find four cases

- Situation $I: \min \left(u^{\prime}, v^{\prime}\right) \geq 1$, no Dirac mass,

$$
\begin{gathered}
\sigma_{-}=\frac{u^{\prime}}{u^{\prime}+v^{\prime}}, \sigma_{+}=1-\frac{1}{u^{\prime}+v^{\prime}}, u^{\prime}=\frac{\sigma_{-}}{1-\sigma_{+}}, v^{\prime}=\frac{1-\sigma_{-}}{1-\sigma_{+}} \\
C C_{u^{\prime}, v^{\prime}}=\pi_{a_{-}, a_{+}}=D_{1-\sigma_{+}}\left(\mathrm{b}_{\sigma_{-}}\right)^{\boxplus \frac{1}{1-\sigma_{+}}}
\end{gathered}
$$

- Situation $I I: u^{\prime}<1 \leq v^{\prime}$, one Dirac mass at 0

$$
\begin{aligned}
\sigma_{-}=\frac{1}{u^{\prime}+v^{\prime}}, \sigma_{+}= & 1-\frac{u^{\prime}}{u^{\prime}+v^{\prime}}, u^{\prime}=\frac{1-\sigma_{+}}{\sigma_{-}}, v^{\prime}=\frac{\sigma_{+}}{\sigma_{-}} \\
C C_{u^{\prime}, v^{\prime}} & =\left(1-u^{\prime}\right) \delta_{0}+u^{\prime} \pi_{a_{-}, a_{+}} \\
& =D_{\sigma_{-}}\left(\mathrm{b}_{1-\sigma_{+}}\right)^{\boxplus \frac{1}{\sigma_{-}}}
\end{aligned}
$$

- Situation III : $v^{\prime}<1 \leq u^{\prime}$, one Dirac mass at 1

$$
\begin{aligned}
\sigma_{-}=1-\frac{1}{u^{\prime}+v^{\prime}}, \sigma_{+} & =\frac{u^{\prime}}{u^{\prime}+v^{\prime}}, u^{\prime}=\frac{\sigma_{+}}{1-\sigma_{-}}, v^{\prime}=\frac{1-\sigma_{+}}{1-\sigma_{-}} \\
C C_{u^{\prime}, v^{\prime}} & =\left(1-v^{\prime}\right) \delta_{1}+v^{\prime} \pi_{a_{-}, a_{+}} \\
& =D_{1-\sigma_{-}}\left(\mathrm{b}_{\sigma_{+}}\right)^{\boxplus \frac{1}{1-\sigma_{-}}}
\end{aligned}
$$

- Situation $I V: \max \left(u^{\prime}, v^{\prime}\right)<1$, two Dirac masses (at 0 and at 1 )

$$
\sigma_{-}=1-\frac{u^{\prime}}{u^{\prime}+v^{\prime}}, \sigma_{+}=\frac{1}{u^{\prime}+v^{\prime}}, u^{\prime}=\frac{1-\sigma_{-}}{\sigma_{+}}, v^{\prime}=\frac{\sigma_{-}}{\sigma_{+}}
$$

[^4]\[

$$
\begin{aligned}
C C_{u^{\prime}, v^{\prime}} & =\left(1-u^{\prime}\right) \delta_{0}+\left(1-v^{\prime}\right) \delta_{1}+\left(u^{\prime}+v^{\prime}-1\right) \pi_{a_{-}, a_{+}} \\
& =D_{\sigma_{+}}\left(\mathrm{b}_{1-\sigma_{-}}\right)^{\boxplus \frac{1}{\sigma_{+}}}
\end{aligned}
$$
\]

2) There is a connection with the family of free Meixner law (Bryc et al. [8, [10, ,9]). Indeed, computing the mean $m$ and variance $V$ of the distribution $C C_{u^{\prime}, v^{\prime}}$, we get

| Situation | m | V |
| :---: | :---: | :---: |
| I | $\sigma_{-}$ | $\sigma_{-}\left(1-\sigma_{-}\right)\left(1-\sigma_{+}\right)$ |
| II | $1-\sigma_{+}$ | $\sigma_{-} \sigma_{+}\left(1-\sigma_{+}\right)$ |
| III | $\sigma_{+}$ | $\left(1-\sigma_{-}\right) \sigma_{+}\left(1-\sigma_{+}\right)$ |
| IV | $1-\sigma_{-}$ | $\sigma_{-} \sigma_{+}\left(1-\sigma_{-}\right)$ |

so that, in all cases

$$
m=\frac{u^{\prime}}{u^{\prime}+v^{\prime}}, \quad V=\frac{u^{\prime} v^{\prime}}{\left(u^{\prime}+v^{\prime}\right)^{3}}
$$

We see that fixing $u^{\prime}+v^{\prime}=s^{-1}$, we get $V=s^{2} m(1-m)$, and then up to an affine transformation we find the "free binomial type law" of 9 example vi p. 18 or [8 example 6 p.8. It could also be seen starting from the above formulae using dilatations and free convolutions and comparing with formula (7) page 6 in [8.
3) Finally, we quote the correspondence with the results of Collins [13] who claimed that for $0<p_{-}<p_{+}<1$

$$
\mathrm{b}_{p_{-}} \boxtimes \mathrm{b}_{p_{+}}=\left(1-p_{-}\right) \delta_{0}+\left(p_{-}+p_{+}-1\right)^{+} \delta_{1}+C_{a_{-}, a_{+}}^{-1} \pi_{a_{-}, a_{+}}
$$

where $a_{ \pm}=a_{ \pm}\left(1-p_{-}, p_{+}\right)$. In 37], formula (2.8) the authors consider the same distribution.

- Situation $I I: p_{-}+p_{+}-1<0, \sigma_{-}=p_{+}, \sigma_{+}=1-p_{-}$

$$
\begin{aligned}
\mathrm{b}_{p_{-}} \boxtimes \mathrm{b}_{p_{+}} & =\sigma_{+} \delta_{0}+\left(1-\sigma_{+}\right) \pi_{a_{-}, a_{+}} \\
& =\sigma_{-} C C_{u^{\prime}, v^{\prime}}+\left(1-\sigma_{-}\right) \delta_{0}
\end{aligned}
$$

- Situation $I V: p_{-}+p_{+}-1>0, \sigma_{-}=1-p_{-}, \sigma_{+}=p_{+}$

$$
\begin{aligned}
\mathrm{b}_{p_{-}} \boxtimes \mathrm{b}_{p_{+}} & =\sigma_{-} \delta_{0}+\left(\sigma_{+}-\sigma_{-}\right) \delta_{1}+\left(1-\sigma_{+}\right) \pi_{a_{-}, a_{+}} \\
& =\sigma_{+} C C_{u^{\prime}, v^{\prime}}+\left(1-\sigma_{+}\right) \delta_{0}
\end{aligned}
$$
