# THE FIRST EIGENVALUE OF DIRAC AND LAPLACE OPERATORS ON SURFACES

Abstract. Let $(M, g, \sigma)$ be a compact Riemmannian surface equipped with a spin structure $\sigma$. For any metric $\tilde{g}$ on $M$, we denote by $\mu_{1}(\tilde{g})$ (resp. $\lambda_{1}(\tilde{g})$ ) the first positive eigenvalue of the Laplacian (resp. the Dirac operator) with respect to the metric $\tilde{g}$. In this paper, we show that

$$
\inf \frac{\lambda_{1}(\tilde{g})^{2}}{\mu_{1}(\tilde{g})} \leqslant \frac{1}{2}
$$

where the infimum is taken over the metrics $\tilde{g}$ conformal to $g$. This answer a question asked by Agricola, Ammann and Friedrich in AAF99.

## 1. Introduction

Let $(M, g, \sigma)$ be a compact Riemannian surface equipped with a spin structure $\sigma$. For any metric $\bar{g}$ on $M$, we denote by $\Sigma_{\bar{g}} M$ the spinor bundle associated to $\bar{g}$. We let $\Delta_{\bar{g}}$ be the Laplace-Beltrami operator acting on smooth functions of $M$ and $D_{\bar{g}}$ be the Dirac operator acting on smooth spinor fields with respect to the metric $\bar{g}$. We also denote by $\mu_{1}(\bar{g})$ (resp. $\lambda_{1}(\bar{g})$ ) the smallest positive eigenvalue of $\Delta_{\bar{g}}\left(\right.$ resp. $\left.D_{\bar{g}}\right)$. Agricola, Ammann and Friedrich asked the following question in AAF99:

When $M$ is a two dimensional torus, can we find on $M$ a Riemannian metric $\tilde{g}$ for which $\lambda_{1}(\tilde{g})^{2}<\mu_{1}(\tilde{g})$ ?

The main goal of this article is to answer this question. We prove the
Theorem 1.1. There exists a family of metrics $\left(g_{\varepsilon}\right)_{\varepsilon}$ conformal to $g$ for which

$$
\begin{aligned}
& \limsup _{\varepsilon \rightarrow 0} \lambda_{1}\left(g_{\varepsilon}\right)^{2} \operatorname{Vol}_{g_{\varepsilon}}(M) \leqslant 4 \pi \\
& \liminf _{\varepsilon \rightarrow 0} \mu_{1}\left(g_{\varepsilon}\right) \operatorname{Vol}_{g_{\varepsilon}}(M) \geqslant 8 \pi .
\end{aligned}
$$

[^0]Theorem 1.1 clearly answers the question of AAF99 but says much more: first, the result is true on any compact Riemannian surface equipped with a spin structure and not only when $M$ is a two-dimensional torus. In addition, the metric $\tilde{g}$ can be chosen in a given conformal class. Finally, this metric $\tilde{g}$ can be chosen such that $(2-\delta) \lambda_{1}(g)^{2}<\mu_{1}(g)$ where $\delta>0$ is arbitrary small. More precisely Theorem 1.1 shows
Corollary 1.2. On any compact Riemannian surface $(M, g)$, we have

$$
\inf \frac{\lambda_{1}(\bar{g})^{2}}{\mu_{1}(\bar{g})} \leqslant \frac{1}{2}
$$

where the infimum is taken over the metric $\bar{g}$ conformal to $g$.
Theorem 1.1 has other interesting consequences. Indeed, it proves
Corollary 1.3. For any compact surface $(M, g)$ equipped with a spin structure $\sigma$, we let

$$
\lambda_{\min }^{+}(M, g, \sigma)=\inf \lambda_{1}(\bar{g}) \operatorname{Vol}_{\bar{g}}^{\frac{1}{2}}(M)
$$

where the infimum is taken over the metrics $\bar{g}$ conformal to $g$. Then, we have $\lambda_{\min }^{+}(M, g, \sigma) \leqslant \lambda_{\min }^{+}\left(\mathbb{S}^{2}\right)$ where $\lambda_{\min }^{+}\left(\mathbb{S}^{2}\right)$ is the same invariant computed on the standard sphere $\mathbb{S}^{2}$.

This corollary is an immediate consequence of the fact that $\lambda_{\text {min }}^{+}\left(\mathbb{S}^{2}\right)=2 \sqrt{\pi}$ (see AHM03). This result was announced in AHM03]. The conformal invariant $\lambda_{\text {min }}^{+}$has been studied in many papers (see for example Hij86, Lot86, Bär92, Amm03, AHM03, AH06 ). Indeed, it has many relations with Yamabe problem (see LP87]). Corollary 1.3 has been proved in all dimensions by Ammann in Amm03 if either $n \geqslant 3$ or is $D$ is invertible. Corollary 1.3 extends the result to the remaining case: $n=2$ and $\operatorname{Ker}(D) \neq\{0\}$. In AHM03], an alternative proof of the case $n \geq 3$ is given and the proof of the case $n=2$ is skectched.
In the same spirit, a consequence of Theorem 1.1 is
Corollary 1.4. For any compact surface $(M, g)$, we let

$$
\mu_{\text {sup }}(M, g)=\sup \mu_{1}(\bar{g}) \operatorname{Vol}_{\bar{g}}^{\frac{1}{2}}(M)
$$

where the infimum is taken over the metrics $\bar{g}$ conformal to $g$. Then, we have $\mu_{\text {sup }}(M, g) \geqslant \mu_{\text {sup }}\left(\mathbb{S}^{2}\right)$ where $\mu_{\text {sup }}\left(\mathbb{S}^{2}\right)$ is the same invariant computed on the standard sphere $\mathbb{S}^{2}$.

The invariant $\mu_{\text {sup }}$ has been studied in CoES03 and Corollary 1.4 is a particular case of Theorem A in this paper. We obtain here another proof.

## 2. Generalized metrics

Let $f$ be a smooth positive function and set $\bar{g}=f^{2} g$. Let also for $u \in C^{\infty}(M)$

$$
I_{\bar{g}}(u)=\frac{\int_{M}|\nabla u|_{\bar{g}} d v_{\bar{g}}}{\int_{M} u^{2} d v_{\bar{g}}}
$$

It is well known that $\mu_{1}(\bar{g})=\inf I_{\bar{g}}(u)$ where the infimum is taken over the smooth non-zero functions $u$ for which $\int_{M} u d v_{\bar{g}}=0$. We now can write all these expressions in the metric $g$. We then see that for $u \in C^{\infty}(M)$, we have

$$
I_{\bar{g}}(u)=\frac{\int_{M}|\nabla u|_{g}^{2} d v_{g}}{\int u^{2} f^{2} d v_{g}}
$$

and $\mu_{1}(\bar{g})=\inf I_{\bar{g}}(u)$ where the infimum is taken over the smooth non-zero functions $u$ for which $\int_{M} u f^{2} d v_{g}=0$. Now if $f$ is only of class $C^{0, a}(M)$ for some $a>0$, we can define $\bar{g}=f^{2} g$. The 2 form $\bar{g}$ is not really a metric since $f$ is not smooth. We then say that $g$ is a generalized metric. We can
define the first eigenvalue $\mu_{1}(\bar{g})$ of $\Delta_{\bar{g}}$ using the definition above. Now, by standard methods, one sees that there exists a function $u \in C^{2}(M)$ with $\int_{M} u f^{2} d v_{g}=0$ and such that $I_{\bar{g}}(u)=\mu_{1}(\bar{g})$. Writing the Euler equation for $u$, we see that

$$
\begin{equation*}
\Delta_{g} u=\mu_{1}(\bar{g}) f^{2} u \tag{1}
\end{equation*}
$$

We prove the following result
Lemma 2.1. If $\left(f_{n}\right)$ is a sequence of smooth positive functions which converges uniformily to $f$, then $\mu_{1}\left(f_{n}^{2} g\right)$ tends to $\mu_{1}(\bar{g})$.

Proof. Let $u_{n}$ be a eigenfunction function associated to $\mu_{1}\left(f_{n}^{2} g\right)$. Without loss of generality, we can assume that $\int_{M} u_{n}^{2} f_{n}^{2}=1$. We set $v_{n}=u_{n}-\frac{\int_{M} u_{n} f^{2} d v_{g}}{\int_{M} f^{2} d v_{g}}$. We then have $\int_{M} v_{n} f^{2} d v_{g}=0$ and hence

$$
\begin{equation*}
\mu_{1}(\bar{g}) \leqslant I_{\bar{g}}\left(v_{n}\right) . \tag{2}
\end{equation*}
$$

We have

$$
\int_{M}\left|\nabla v_{n}\right|^{2} d v_{g}=\int_{M}\left|\nabla u_{n}\right|^{2} d v_{g}=\int_{M} u_{n} \Delta_{g} u_{n} d v_{g}
$$

By equation (11), we get that

$$
\begin{equation*}
\int_{M}\left|\nabla v_{n}\right|^{2} d v_{g}=\mu_{1}\left(f_{n}^{2} g\right) \int_{M} f_{n}^{2} u_{n}^{2} d v_{g}=\mu_{1}\left(f_{n}^{2} g\right) \tag{3}
\end{equation*}
$$

We also have

$$
\int_{M} f^{2} v_{n}^{2} d v_{g}=\int_{M} f^{2} u_{n}^{2}-\frac{\left(\int_{M} u_{n} f^{2} d v_{g}\right)^{2}}{\int_{M} f^{2} d v_{g}}
$$

Now,

$$
\left|\int_{M} u_{n} f^{2} d v_{g}\right|=\left|\int_{M} u_{n}\left(f^{2}-f_{n}^{2}\right) d v_{g}\right| \leqslant C \int_{M}\left|u_{n}\right|\left(f+f_{n}\right)^{2}\left\|f-f_{n}\right\|_{\infty}
$$

Since the sequence $\left(f_{n}\right)_{n}$ tends uniformly to $f$ and since $\int_{M} f_{n}^{2} u_{n}^{2} d v_{g}=1$, we get that $\lim _{n} \int_{M} u_{n} f^{2} d v_{g}=$ 0 . In the same way,

$$
\int_{M} f^{2} u_{n}^{2} d v_{g}=\int_{M} f_{n}^{2} u_{n}^{2} d v_{g}+o(1)=1+o(1)
$$

Finally, we obtain

$$
\int_{M} f^{2} v_{n}^{2} d v_{g}=1+o(1)
$$

Together with (2) and (3), we obtain that $\mu_{1}(\bar{g}) \leqslant \liminf _{n} \mu_{1}\left(f_{n}^{2} g\right)$. Now, let $u$ be associated to $\mu_{1}(\bar{g})$ and set $v=u-\frac{\int_{M} u f_{n}^{2} d v_{g}}{\int_{M} f_{n} d v_{g}}$. We have $\int_{M} v^{2} f_{n}^{2} d v_{g}=0$ and hence

$$
\mu_{1}\left(f_{n}^{2} g\right) \leqslant I_{f_{n}^{2} g}(v)
$$

It is easy to see that $\lim _{n} I_{f_{n}^{2} g}(v)=I_{\bar{g}}(u)=\mu_{1}(\bar{g})$. We then obtain that $\mu_{1}(\bar{g}) \geqslant \lim \sup _{n} \mu_{1}\left(f_{n}^{2} g\right)$. This proves Lemma 2.1.

In the same way, if $\bar{g}=f^{2} g$ is a metric conformal to $g$ where $f$ is positive and smooth, we define

$$
J_{\bar{g}}^{\prime}(\psi)=\frac{\int_{M}\left|D_{\bar{g}} \psi\right|_{\bar{g}}^{2} f^{-1} d v_{\bar{g}}}{\int_{M}\left\langle D_{\bar{g}} \psi, \psi\right\rangle_{\bar{g}} d v_{\bar{g}}}
$$

The first eigenvalue of the Dirac operator $D_{\bar{g}}$ is then given by $\lambda_{1}^{+}(\bar{g})=\inf J_{\bar{g}}^{\prime}(\psi)$ where the infimum is taken over the smooth spinor fields $\psi$ for which $\int_{M}\left\langle D_{g} \psi, \psi\right\rangle d v_{g}>0$. Now, it is well known (see Hit74, Hij01) that where can identify isometrically on each fiber spinor fields for the metric $g$ and spinor fields for the metric $\bar{g}$. Moreover, we have for all smooth spinor field:

$$
D_{\bar{g}}\left(f^{-\frac{1}{2}} \psi\right)=f^{-\frac{3}{2}} D_{g} \psi
$$

This implies that if we set $\varphi=f^{-\frac{1}{2}} \psi$, we have

$$
J_{\bar{g}}(\varphi):=\frac{\int_{M}\left|D_{g} \varphi\right|^{2} f^{-1} d v_{g}}{\int_{M}\left\langle D_{g} \varphi, \varphi\right\rangle d v_{g}}=J_{\bar{g}}^{\prime}(\psi)
$$

and the first eigenvalue of the Dirac operator $D_{\bar{g}}$ is given by $\lambda_{1}^{+}(\bar{g})=\inf J_{\bar{g}}(\varphi)$ where the infimum is taken over the smooth spinor fields $\varphi$ for which $\int_{M}\langle D \varphi, \varphi\rangle d v_{g}>0$. With the definition above, we can extend the definition of $\lambda_{1}(\bar{g})$ when $\bar{g}$ is a generalised metric. By standard methods, there exists a spinor fields $\varphi \in C^{1}(M)$ such that $\lambda_{1}^{+}(\bar{g})=J_{\bar{g}}(\varphi)$ and such that

$$
\begin{equation*}
D_{g} \varphi=\lambda_{1}^{+}(\bar{g}) f \varphi \tag{4}
\end{equation*}
$$

We then have a result similar to Lemma 2.1:
Lemma 2.2. If $\left(f_{n}\right)$ is a sequence of smooth positive functions which converges uniformly to $f$, then $\lambda_{1}\left(f_{n}^{2} g\right)$ tends to $\lambda_{1}(\bar{g})$.

The proof is similar to the one of Lemma 2.1 and we omit it here.

## 3. The metrics $\left(g_{\alpha, \varepsilon}\right)_{\alpha, \varepsilon}$

In this paragraph, we construct the metrics $\left(g_{\alpha, \varepsilon}\right)_{\alpha, \varepsilon}$ which will satisfy:

$$
\begin{equation*}
\limsup _{\varepsilon \rightarrow 0} \lambda_{1}\left(g_{\alpha, \varepsilon}\right)^{2} \operatorname{Vol}_{g_{\alpha, \varepsilon}}(M) \leqslant 4 \pi+C(\alpha) \tag{5}
\end{equation*}
$$

where $C(\alpha)$ is a positive constant which goes to 0 with $\alpha$ and

$$
\begin{equation*}
\liminf _{\varepsilon \rightarrow 0} \mu_{1}\left(g_{\alpha, \varepsilon}\right) \operatorname{Vol}_{g_{\alpha, \varepsilon}}(M) \geqslant 8 \pi \tag{6}
\end{equation*}
$$

Clearly this implies Theorem 1.1. By Lemmas 2.1 and 2.2, one can assume that the metrics $\left(g_{\alpha, \varepsilon}\right)_{\alpha, \varepsilon}$ are generalized metrics. We just have to define the volume of $M$ for generalized metric by $\operatorname{Vol}_{f^{2} g}(M)=$ $\int_{M} f^{2} d v_{g}$. At first, without loss of generality, we can assume that $g$ is flat near a point $p \in M$. Let $\alpha>0$ be a small number to be fixed later such that $g$ is flat on $B_{p}(\alpha)$. We set for all $x \in M$ and $\varepsilon>0$,

$$
f_{\alpha, \varepsilon}(x)=\left\{\begin{array}{clc}
\frac{\varepsilon^{2}}{\varepsilon^{2}+r^{2}} & \text { if } & r \leqslant \alpha \\
\frac{\varepsilon^{2}}{\varepsilon^{2}+\alpha^{2}} & \text { if } & r>\alpha
\end{array}\right.
$$

where $r=d_{g}(., p)$. The function $f_{\alpha, \varepsilon}$ is of class $C^{0, a}$ for all $\left.a \in\right] 0,1[$ and is positive on $M$. We then define for all $\varepsilon>0, g_{\alpha, \varepsilon}=f_{\alpha, \varepsilon}^{2} g$. The 2-forms $\left(g_{\alpha, \varepsilon}\right)_{\alpha, e p}$ will be the desired generalized metrics. For these metrics, we have

$$
\operatorname{Vol}_{g_{\alpha, \varepsilon}}(M)=\int_{M} f_{\alpha, \varepsilon}^{2} d v_{g}=\int_{B_{p}(\alpha)} f_{\alpha, \varepsilon}^{2} d v_{g}+\int_{M \backslash B_{p}(\alpha)} f_{\alpha, \varepsilon}^{2} d v_{g}
$$

Since $g$ is flat on $B_{p}(\alpha)$, we have

$$
\int_{B_{p}(\alpha)} f_{\alpha, \varepsilon}^{2} d v_{g}=\int_{0}^{2 \pi} \int_{0}^{\alpha} \frac{\varepsilon^{4} r}{\left(\varepsilon^{2}+r^{2}\right)^{2}} d r d \Theta
$$

Setting $y=\frac{x}{\varepsilon}$ we obtain:

$$
\int_{B_{p}(\alpha)} f_{\alpha, \varepsilon}^{2} d v_{g}=2 \pi \varepsilon^{2} \int_{0}^{\frac{\alpha}{\varepsilon}} \frac{r}{\left(1+r^{2}\right)^{2}} d r=2 \pi \varepsilon^{2}\left(\int_{0}^{+\infty} \frac{r}{\left(1+r^{2}\right)^{2}} d r+o(1)\right)=\pi \varepsilon^{2}+o\left(\varepsilon^{2}\right)
$$

Since $f_{\alpha, \varepsilon}^{2} \leqslant \frac{\varepsilon^{4}}{\alpha^{4}}$ on $M \backslash B_{p}(\alpha)$, we have $\int_{M \backslash B_{p}(\alpha)} f_{\alpha, \varepsilon}^{2} d v_{g}=o\left(\varepsilon^{2}\right)$. We obtain

$$
\begin{equation*}
\operatorname{Vol}_{g_{\varepsilon}}(M)=\pi \varepsilon^{2}+o\left(\varepsilon^{2}\right) . \tag{7}
\end{equation*}
$$

In the whole paper, the notation " $o($.$) " must be understood as \varepsilon$ tends to 0 .

## 4. Proof of relation (5)

Let $f: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ be defined by $f(x)=\frac{2}{1+|x|^{2}}$. Let $\psi_{0}$ be a non-zero parallel spinor field on $\mathbb{R}^{2}$ such that $\left|\psi_{0}\right|^{2}=1$. As in AHM03, we set on $\mathbb{R}^{2}$

$$
\psi(x)=f^{\frac{n}{2}}(x)(1-x) \cdot \psi_{0} .
$$

As easily computed, we have on $\mathbb{R}^{2}$

$$
\begin{equation*}
D \psi=f \psi \text { and }|\psi|=f^{\frac{1}{2}} \tag{8}
\end{equation*}
$$

Now, we fixe a small number $\delta>0$ such that $g$ is flat on $B_{p}(\delta)$. Then, we take $\varepsilon \leqslant \alpha \leqslant \delta$. We will let $\varepsilon$ goes to 0 . We let also $\eta$ be a smooth cut-off function defined on $M$ such that $0 \leqslant \eta \leqslant 1, \eta\left(B_{p}(\delta)\right)=\{1\}$, $\eta\left(M \backslash B_{p}(2 \delta)\right)=\{0\}$. Identifying $B_{p}(\delta)$ in $M$ with $B_{0}(\delta)$ in $\mathbb{R}^{2}$, we can define a smooth spinor field on $M$ by $\psi_{\varepsilon}=\eta(x) \psi\left(\frac{x}{\varepsilon}\right)$. Using (8), we have

$$
\begin{equation*}
D_{g}\left(\psi_{\varepsilon}\right)=\nabla \eta \cdot \psi\left(\frac{x}{\varepsilon}\right)+\frac{\eta}{\varepsilon} f\left(\frac{x}{\varepsilon}\right) \psi\left(\frac{x}{\varepsilon}\right) . \tag{9}
\end{equation*}
$$

Since $\left\langle\nabla \eta \cdot \psi\left(\frac{x}{\varepsilon}\right), \psi\left(\frac{x}{\varepsilon}\right)\right\rangle \in i \mathbb{R}$ and since $\left|D_{g} \psi_{\varepsilon}\right|^{2} \in \mathbb{R}$, we have

$$
\begin{equation*}
\int_{M}\left|D_{g} \psi_{\varepsilon}\right|^{2} f_{\alpha, \varepsilon}^{-1} d v_{g}=I_{1}+I_{2} \tag{10}
\end{equation*}
$$

where

$$
I_{1}=\int_{M}|\nabla \eta|^{2}\left|\psi\left(\frac{x}{\varepsilon}\right)\right|^{2} d x \text { and } I_{2}=\int_{M} \frac{\eta^{2}}{\varepsilon^{2}} f^{2}\left(\frac{x}{\varepsilon}\right)\left|\psi\left(\frac{x}{\varepsilon}\right)\right|^{2} f_{\alpha, \varepsilon}^{-1} d x .
$$

At first, let us deal with $I_{1}$. By (8),

$$
I_{1} \leqslant C \int_{M} f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} d x=C \int_{B_{p}(\alpha)} f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} d x+C \int_{B_{p}(2 \delta) \backslash B_{p}(\alpha)} f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} d x
$$

where, as in the following, $C$ denotes a constant independant of $\alpha$ and $\varepsilon$. On $B_{p}(\alpha), f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1}=2$. Hence,

$$
\int_{B_{p}(\alpha)} f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} d x \leqslant C \alpha^{2} .
$$

On $B_{p}(2 \delta) \backslash B_{p}(\alpha)$, since $\varepsilon \leqslant \alpha$,

$$
f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} \leqslant \frac{4 \alpha^{2}}{\varepsilon^{2}+r^{2}}=\frac{4 \alpha^{2}}{\varepsilon^{2}\left(1+\left(\frac{r}{\varepsilon}\right)^{2}\right)}
$$

Hence,

$$
\begin{aligned}
\int_{B_{p}(2 \delta) \backslash B_{p}(\alpha)} f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} d x & \leqslant \frac{4 \alpha^{2}}{\varepsilon^{2}} \int_{0}^{2 \pi} \int_{\alpha}^{\delta} \frac{r}{\left(1+\left(\frac{r}{\varepsilon}\right)^{2}\right)} d r d \Theta \\
& \leqslant 8 \pi \alpha^{2} \int_{\frac{\alpha}{\varepsilon}}^{\frac{\delta}{\varepsilon}} \frac{r}{\left(1+r^{2}\right)} d r \\
& \leqslant 8 \pi \alpha^{2} \ln \left(\frac{\varepsilon^{2}+\delta^{2}}{\varepsilon^{2}+\alpha^{2}}\right)
\end{aligned}
$$

We get

$$
\int_{B_{p}(2 \delta) \backslash B_{p}(\alpha)} f\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} d x \leqslant C \alpha^{2} \ln \left(\frac{2 \delta^{2}}{\alpha^{2}}\right)
$$

Finally, we obtain

$$
\begin{equation*}
I_{1} \leqslant C \alpha^{2}+C \ln \left(\frac{2 \delta^{2}}{\alpha^{2}}\right)=a(\alpha) \tag{11}
\end{equation*}
$$

where $a(\alpha)$ goes to 0 with $\alpha$. Now, by (8),

$$
I_{2} \leqslant C \int_{B_{p}(2 \delta)} f^{3}\left(\frac{x}{\varepsilon}\right) f_{\alpha, \varepsilon}^{-1} d x
$$

Since $f_{\alpha, \varepsilon} \geqslant \frac{1}{2} f\left(\frac{x}{\varepsilon}\right)$, we have

$$
I_{2} \leqslant \frac{2}{\varepsilon^{2}} \int_{B_{p}(2 \delta)} f^{2}\left(\frac{x}{\varepsilon}\right) d x
$$

Mimicking what we did to get (7), we obtain that

$$
I_{2} \leqslant 8 \pi+o(1)
$$

when $\varepsilon$ tends to 0 . Together with (10) and (11), we obtain

$$
\begin{equation*}
\int_{M}\left|D_{g} \psi_{\varepsilon}\right|^{2} f_{\alpha, \varepsilon}^{-1} d v_{g} \leqslant 8 \pi+a(\alpha)+o(1) . \tag{12}
\end{equation*}
$$

In the same way, by (9), since $\int_{M}\left\langle D_{g}\left(\psi_{\varepsilon}\right), \psi_{\varepsilon}\right\rangle d v_{g} \in \mathbb{R}$ and since $\left\langle\nabla \eta \cdot \psi\left(\frac{x}{\varepsilon}\right), \psi\left(\frac{x}{\varepsilon}\right)\right\rangle \in i \mathbb{R}$, we have

$$
\int_{M}\left\langle D_{g}\left(\psi_{\varepsilon}\right), \psi_{\varepsilon}\right\rangle d v_{g}=\int_{M} \frac{\eta^{2}}{\varepsilon} f\left(\frac{x}{\varepsilon}\right)\left|\psi\left(\frac{x}{\varepsilon}\right)\right|^{2} d v_{g}
$$

By (8), this gives

$$
\int_{M}\left\langle D_{g}\left(\psi_{\varepsilon}\right), \psi_{\varepsilon}\right\rangle d v_{g}=\int_{M} \frac{\eta^{2}}{\varepsilon} f^{2}\left(\frac{x}{\varepsilon}\right) d v_{g} .
$$

With the computations made above, it follows that

$$
\int_{M}\left\langle D_{g}\left(\psi_{\varepsilon}\right), \psi_{\varepsilon}\right\rangle d v_{g}=4 \pi \varepsilon+o(\varepsilon)
$$

Together with (12) and (7), we obtain
$\lambda_{1}\left(g_{\alpha, \psi}\right)^{2} \operatorname{Vol}_{g_{\alpha, \psi}}(M) \leqslant\left(J_{g_{\alpha, \psi}}\left(\psi_{\varepsilon}\right)\right)^{2} \operatorname{Vol}_{g_{\alpha, \psi}}(M) \leqslant\left(\frac{8 \pi+a(\alpha)+o(1)}{4 \pi \varepsilon+o(\varepsilon)}\right)^{2}\left(\pi \varepsilon^{2}+o\left(\varepsilon^{2}\right)\right)=\frac{1}{\varepsilon}(4 \pi+a(\alpha)+o(1))$.
Relation (5) immediatly follows.

## 5. Proof of relation (6)

First we need the following estimate
Lemma 5.1. For any $\varepsilon>0$ and $u \in C_{c}^{\infty}\left(B_{p}(\alpha)\right)$, then

$$
\int_{M} u^{2} f_{\alpha, \varepsilon}^{2} d v_{g} \leqslant \frac{\varepsilon^{2}}{8} \int_{M}|\nabla u|^{2} d v_{g}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M} u f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2}
$$

Proof. Let $g_{\varepsilon}=f_{\alpha, \varepsilon}^{2} g$. Then $\left(B_{p}(\alpha), g_{\varepsilon}\right)$ is embedded in a canonical sphere of volume $\int_{\mathbb{R}^{2}}\left(\frac{\varepsilon^{2}}{\varepsilon^{2}+r^{2}}\right)^{2} d x=$ $\pi \varepsilon^{2}$. Then from the Poincaré-Sobolev inequality, we have

$$
\int_{M} u^{2} d v_{g_{\varepsilon}} \leqslant \frac{1}{\mu_{1, \varepsilon}} \int_{M}\left|\nabla^{\varepsilon} u\right|_{g_{\varepsilon}}^{2} d v_{g_{\varepsilon}}+\frac{1}{V_{\varepsilon}}\left(\int_{M} u d v_{g_{\varepsilon}}\right)^{2}
$$

where $\mu_{1, \varepsilon}=\frac{8}{\varepsilon^{2}}$ is the first nonzero eigenvalue of the Laplacian on the sphere of volume $V_{\varepsilon}=\pi \varepsilon^{2}$ and $\nabla^{\varepsilon} u$ denotes the gradient of $u$ with respect to the metric $g_{\varepsilon}$. Now since $\left|\nabla^{\varepsilon} u\right|_{g_{\varepsilon}}^{2}=f_{\alpha, \varepsilon}^{-2}|\nabla u|_{g}^{2}$ and $d v_{g_{\varepsilon}}=f_{\alpha, \varepsilon}^{2} d v_{g}$, we get the desired result.

Lemma 5.2. For any $u, v \in C^{\infty}(M)$, we have

$$
\int_{M}(\Delta u) u v^{2} d v_{g}=\int_{M}|\nabla(u v)|_{g}^{2} d v_{g}-\int_{M} u^{2}|\nabla v|_{g}^{2} d v_{g}
$$

Proof. The proof is an elementary calculation.

Because of the relation (7), the inequality (6) is equivalent to the following

$$
\begin{equation*}
\liminf _{\varepsilon \longrightarrow 0} \varepsilon^{2} \mu_{1}\left(g_{\varepsilon}\right) \geqslant .8 \tag{13}
\end{equation*}
$$

In order to prove this inequality, we assume that for any $\varepsilon$ small enough, there exists $k, 0<k<1$ so that

$$
\begin{equation*}
\mu_{1}\left(g_{\varepsilon}\right)<\frac{8}{\varepsilon^{2}} k . \tag{14}
\end{equation*}
$$

Let $u_{\varepsilon}$ be an eigenfunction associated to $\mu_{1}\left(g_{\varepsilon}\right)$. Then $u_{\varepsilon} \in C^{2}(M)$ and $\Delta_{g_{\varepsilon}} u_{\varepsilon}=\mu_{1}\left(g_{\varepsilon}\right) u_{\varepsilon}$ where $\Delta_{g_{\varepsilon}}$ denotes the Laplacian associated to the metric $g_{\varepsilon}$. Since the dimension is $2, \Delta_{g_{\varepsilon}}=\frac{1}{f_{\alpha, \varepsilon}^{2}} \Delta$ and

$$
\begin{equation*}
\Delta u_{\varepsilon}=\mu_{1}\left(g_{\varepsilon}\right) f_{\alpha, \varepsilon}^{2} u_{\varepsilon} \tag{15}
\end{equation*}
$$

We normalize $u_{\varepsilon}$ so that $\left\|u_{\varepsilon}\right\|_{H_{1}^{2}}=1$. Up to a subsequence we can assume that $\int_{M}\left|\nabla u_{\varepsilon}\right|^{2} d v_{g} \longrightarrow l$ and $\int_{M} u_{\varepsilon}^{2} d v_{g} \longrightarrow l^{\prime}$ with $l+l^{\prime}=1$. Since $\left(u_{\varepsilon}\right)$ is bounded in $H_{1}^{2}$, there exists a subsequence so that $u_{\varepsilon} \longrightarrow u$ weakly in $H_{1}^{2}$. In the following, all the convergences are up to subsequence. We sometimes omit to recall this fact.

Lemma 5.3. There exists a constant $c_{0}$ such that $u=c_{0}$.

Proof. Let $\varphi \in C^{\infty}(M)$ and

$$
\eta_{\rho}:=\left\{\begin{array}{llc}
1 & \text { on } & B_{p}(\rho) \\
0 & \text { on } & M \backslash B_{p}(2 \rho)
\end{array}\right.
$$

satisfying $0 \leqslant \eta_{\rho} \leqslant 1$ and $\left|\nabla \eta_{\rho}\right| \leqslant \frac{1}{\rho}$. We have

$$
\begin{equation*}
\int_{M}\langle\nabla u, \nabla \varphi\rangle=\int_{M}\left\langle\nabla u, \nabla\left(\eta_{\rho} \varphi\right)\right\rangle d v_{g}+\int_{M}\left\langle\nabla u, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g} . \tag{16}
\end{equation*}
$$

Now we have

$$
\begin{aligned}
\int_{M}\left\langle\nabla u, \nabla\left(\eta_{\rho} \varphi\right)\right\rangle d v_{g} & =\int_{M}\left\langle\nabla u, \nabla \eta_{\rho}\right\rangle \varphi d v_{g}+\int_{M}\langle\nabla u, \nabla \varphi\rangle \eta_{\rho} d v_{g} \\
& \leqslant C\left(\int_{B_{p}(2 \rho)}|\nabla u|^{2} d v_{g}\right)^{1 / 2}\left(\int_{B_{p}(2 \rho)}\left|\nabla \eta_{\rho}\right|^{2} d v_{g}\right)^{1 / 2} \\
& +\left(\int_{B_{p}(2 \rho)}|\nabla u|^{2} d v_{g}\right)^{1 / 2}\left(\int_{B_{p}(2 \rho)}|\nabla \varphi|^{2} d v_{g}\right)^{1 / 2}
\end{aligned}
$$

The limit of the last term is 0 when $\rho \longrightarrow 0$. Moreover from the definition of $\eta_{\rho}$ and from the fact that $M$ is a 2-dimensional locally flat domain, the limit of $\left(\int_{B_{p}(2 \rho)}\left|\nabla \eta_{\rho}\right|^{2} d v_{g}\right)^{1 / 2}$ is bounded in a neighborhood of 0 . Then we deduce that

$$
\begin{equation*}
\int_{M}\left\langle\nabla u, \nabla\left(\eta_{\rho} \varphi\right)\right\rangle d v_{g} \longrightarrow 0 \tag{17}
\end{equation*}
$$

when $\rho \longrightarrow 0$. On the other hand

$$
\begin{aligned}
\left|\int_{M}\left\langle\nabla u, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g}\right| & =\lim _{\varepsilon \longrightarrow 0}\left|\int_{M}\left\langle\nabla u_{\varepsilon}, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g}\right| \\
& =\lim _{\varepsilon \longrightarrow 0}\left|\int_{M}\left(\Delta u_{\varepsilon}\right)\left(1-\eta_{\rho}\right) \varphi d v_{g}\right| \\
& =\lim _{\varepsilon \longrightarrow 0}\left|\mu_{1}\left(g_{\varepsilon}\right) \int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}\left(1-\eta_{\rho}\right) \varphi d v_{g}\right| .
\end{aligned}
$$

Now from the definition of $f_{\alpha, \varepsilon}$ and from (14) we get

$$
\left|\mu_{1}\left(g_{\varepsilon}\right) \int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}\left(1-\eta_{\rho}\right) \varphi d v_{g}\right| \leqslant \frac{8}{\varepsilon^{2}} k C \varepsilon^{4}\left(\int_{M} u_{\varepsilon}^{2} d v_{g}\right)^{1 / 2}\left(\int_{M}\left(1-\eta_{\rho}\right) \varphi^{2} d v_{g}\right)^{1 / 2}
$$

where $C$ is a constant depending on the compact support of $\left(1-\eta_{\rho}\right) \varphi$. Then making $\varepsilon \longrightarrow 0$, we deduce that

$$
\int_{M}\left\langle\nabla u, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g}=0 .
$$

Now, reporting this and (17) in (16) we obtain that $\int_{M}\langle\nabla u, \nabla \varphi\rangle d v_{g}=0$ and $\Delta u=0$ on $M$ in the sense of distributions. This implies that $u \equiv c_{0}$ on $M$ for a constant $c_{0}$.

Lemma 5.4. Let $\left(c_{\varepsilon}\right)_{\varepsilon}$ be a bounded sequence of real numbers. Then

$$
\int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}^{2} d v_{g} \leqslant O\left(\varepsilon^{2}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\varepsilon^{4}\right)
$$

Proof. Let $\eta$ be a $C^{\infty}$ function defined on $M$ so that

$$
\eta:=\left\{\begin{array}{llc}
1 & \text { on } & B_{p}(\alpha / 2) \\
0 & \text { on } & M \backslash B_{p}(\alpha)
\end{array}\right.
$$

satisfying $0 \leqslant \eta \leqslant 1$ and $|\nabla \eta| \leqslant 1$.
From the lemma 5.1, we have

$$
\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right)^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant \frac{\varepsilon^{2}}{8} \int_{M}\left|\nabla\left(\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta\right)\right|^{2} d v_{g}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2}
$$

and applying the lemma 5.2 to the first term of the right hand side, we get

$$
\begin{aligned}
& \int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right)^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant \\
& \quad \frac{\varepsilon^{2}}{8} \int_{M}\left(\Delta\left(u_{\varepsilon}-c_{\varepsilon}\right)\right)\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta^{2} d v_{g}+\frac{\varepsilon^{2}}{8} \int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right)^{2}|\nabla \eta|^{2} d v_{g}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2} .
\end{aligned}
$$

From (15) we deduce that

$$
\begin{aligned}
& \int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right)^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant \\
& \quad \frac{\varepsilon^{2}}{8} \mu_{1}\left(g_{\varepsilon}\right) \int_{M} u_{\varepsilon}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta^{2} f_{\alpha, \varepsilon}^{2} d v_{g}+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2}
\end{aligned}
$$

First case : assume that $\int_{M} u_{\varepsilon}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta^{2} f_{\alpha, \varepsilon}^{2} d v_{g} \geqslant 0$.
The relation (14) implies

$$
\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right)^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant k \int_{M} u_{\varepsilon}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta^{2} f_{\alpha, \varepsilon}^{2} d v_{g}+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2}
$$

A straightforward computation shows that

$$
\begin{align*}
& (1-k) \int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}+c_{\varepsilon}^{2} \int_{M} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant \\
& \quad(2-k) c_{\varepsilon} \int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2} . \tag{18}
\end{align*}
$$

Now note that

$$
\begin{aligned}
\int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} & =\int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2}\left(\eta^{2}-1\right) d v_{g}+\int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2} d v_{g} \\
& =\int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2}\left(\eta^{2}-1\right) d v_{g}+\frac{1}{\mu_{1}\left(g_{\varepsilon}\right)} \int_{M} \Delta u_{\varepsilon} d v_{g} \\
& =\int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2}\left(\eta^{2}-1\right) d v_{g} \\
& \leqslant \int_{M \backslash B_{p}(\alpha / 2)} u_{\varepsilon} f_{\alpha, \varepsilon}^{2}\left(\eta^{2}-1\right) d v_{g}
\end{aligned}
$$

and from the definition of $f_{\alpha, \varepsilon}$ and $\eta$ and from the fact that $u_{\varepsilon}$ is bounded in $L^{2}$, we deduce that

$$
\int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}=O\left(\varepsilon^{4}\right)
$$

Since $c_{\varepsilon}$ is bounded (18) becomes

$$
\begin{gather*}
(1-k) \int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}+c_{\varepsilon}^{2} \int_{M} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2} \\
=O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}(\eta-1) d v_{g}+\int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon} d v_{g}-c_{\varepsilon} \int_{M} f_{\alpha, \varepsilon}^{2} \eta\right)^{2} \\
=O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}(\eta-1) d v_{g}-c_{\varepsilon} \int_{M} f_{\alpha, \varepsilon}^{2} \eta\right)^{2} \tag{19}
\end{gather*}
$$

where in the last equality we have used the fact that $\int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon} d v_{g}=\frac{1}{\mu_{1}\left(g_{\varepsilon}\right)} \int_{M} \Delta u_{\varepsilon} d v_{g}=0$.
Using the same arguments as above we see that $\int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}(\eta-1) d v_{g}=O\left(\varepsilon^{4}\right)$. Reporting this in (19) we get

(1-k) \int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}+c_{\varepsilon}^{2} \int_{M} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{O\left(\varepsilon^{4}\right)}{\varepsilon^{2}} \int_{M} f_{\alpha, \varepsilon}^{2} \eta d v_{g}+\frac{c_{\varepsilon}^{2}}{\pi \varepsilon^{2}}\left(\int_{M} f_{\alpha, \varepsilon}^{2} \eta d v_{g}\right)^{2} .
$$

Now

$$
\begin{aligned}
\int_{M} f_{\alpha, \varepsilon}^{2} \eta d v_{g} & =\int_{B_{p}(\alpha)} f_{\alpha, \varepsilon}^{2} d v_{g}=\int_{0}^{2 \pi} \int_{0}^{\alpha} \frac{\varepsilon^{4} r}{\left(\varepsilon^{2}+r^{2}\right)^{2}} d r d \Theta \\
& =2 \pi \varepsilon^{2} \int_{0}^{\alpha / \varepsilon} \frac{t}{\left(1+t^{2}\right)^{2}} d t \\
& \leqslant 2 \pi \varepsilon^{2} \int_{0}^{+\infty} \frac{t}{\left(1+t^{2}\right)^{2}} d t \\
& =\pi \varepsilon^{2}
\end{aligned}
$$

This gives

$$
\begin{aligned}
(1-k) \int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}+c_{\varepsilon}^{2} \int_{M} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} & \leqslant O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{c_{\varepsilon}^{2}}{\pi \varepsilon^{2}}\left(\int_{M} f_{\alpha, \varepsilon}^{2} \eta d v_{g}\right)^{2} \\
& =O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+c_{\varepsilon}^{2} \int_{M} f_{\alpha, \varepsilon}^{2} \eta d v_{g}
\end{aligned}
$$

Finally we have

$$
\begin{align*}
(1-k) \int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} & \leqslant O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+c_{\varepsilon}^{2} \int_{M} f_{\alpha, \varepsilon}^{2}\left(\eta-\eta^{2}\right) d v_{g} \\
& \leqslant O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+c_{\varepsilon}^{2} \int_{B_{p}(\alpha) \backslash B_{p}(\alpha / 2)} f_{\alpha, \varepsilon}^{2} d v_{g} \\
& =O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2} \tag{20}
\end{align*}
$$

Second case : Assume that $\int_{M} u_{\varepsilon}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta^{2} f_{\alpha, \varepsilon}^{2} d v_{g} \leqslant 0$.
In this case, we have

$$
\begin{align*}
& \int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}-2 c_{\varepsilon} \int_{M} u_{\varepsilon} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}+c_{\varepsilon}^{2} \int_{M} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g} \leqslant \\
& O\left(\varepsilon^{4}\right)+\frac{\varepsilon^{2}}{8}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\frac{1}{\pi \varepsilon^{2}}\left(\int_{M}\left(u_{\varepsilon}-c_{\varepsilon}\right) \eta f_{\alpha, \varepsilon}^{2} d v_{g}\right)^{2} \tag{21}
\end{align*}
$$

and we conclude as in the previous case.
Then we have proved that

$$
\int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}=O\left(\varepsilon^{4}+\varepsilon^{2}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}\right)
$$

To finish the proof, we write

$$
\int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} d v_{g}=\int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2} \eta^{2} d v_{g}+\int_{M} u_{\varepsilon}^{2} f_{\alpha, \varepsilon}^{2}\left(1-\eta^{2}\right) d v_{g}
$$

and the last term is $O\left(\varepsilon^{4}\right)$ which completes the proof.

Proof. of Relation (13). First we apply the lemma 5.4 to $c_{\varepsilon}=c_{0}$ and we see that $c_{0} \neq 0$. Indeed, let us compute the $L^{2}$-norm of the gradient of $u_{\varepsilon}$.

$$
\begin{aligned}
\int_{M}\left|\nabla u_{\varepsilon}\right|^{2} d v_{g} & =\int_{M}\left(\Delta u_{\varepsilon}\right) u_{\varepsilon} d v_{g} \leqslant \frac{8 k}{\varepsilon^{2}} \int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}^{2} d v_{g} \\
& =\frac{8 k}{\varepsilon^{2}} O\left(\varepsilon^{2}\left\|u_{\varepsilon}-c_{0}\right\|_{L^{2}}^{2}+\varepsilon^{4}\right) \\
& =o(1)
\end{aligned}
$$

Then we deduce that up to a subsequence

$$
\int_{M}\left|\nabla u_{\varepsilon}\right|^{2} d v_{g} \longrightarrow 0
$$

But we have chosen $u_{\varepsilon}$ so that $\left\|u_{\varepsilon}\right\|_{H_{1}^{2}}=1$. Then $\left\|u_{\varepsilon}\right\|_{L^{2}} \longrightarrow 1$ and $c_{0} \neq 0$.
Now let us consider $\bar{u}_{\varepsilon}=\frac{1}{\operatorname{Vol}(M)} \int_{M} u_{\varepsilon} d v_{g}$ and $a_{\varepsilon}=\left\|u_{\varepsilon}-\bar{u}_{\varepsilon}\right\|_{H_{1}^{2}}$. Then $u_{\varepsilon} \longrightarrow c_{0}$ and $a_{\varepsilon} \longrightarrow 0$. It follows that the function $v_{\varepsilon}=\frac{u_{\varepsilon}-\bar{u}_{\varepsilon}}{a_{\varepsilon}}$ satisfies $\left\|v_{\varepsilon}\right\|_{H_{1}^{2}}=1$ and there exists $v \in H_{1}^{2}$ so that $v_{\varepsilon} \longrightarrow v$ weakly in $H_{1}^{2}$ and strongly in $L^{2}$.
To prove (13) we will consider two cases.
First case : Assume that up to a subsequence $a_{\varepsilon}=O(\varepsilon)$.
We have

$$
\begin{aligned}
\int_{M}\left(\Delta u_{\varepsilon}\right)^{2} d v_{g} & =\mu_{1}\left(g_{\varepsilon}\right)^{2} \int_{M} f_{\alpha, \varepsilon}^{4} u_{\varepsilon}^{2} d v_{g} \\
& \leqslant \mu_{1}\left(g_{\varepsilon}\right)^{2} \int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}^{2} d v_{g} \\
& \leqslant \frac{64 k}{\varepsilon^{4}} O\left(\varepsilon^{2}\left\|u_{\varepsilon}-\bar{u}_{\varepsilon}\right\|_{L^{2}}^{2}+\varepsilon^{4}\right) \\
& \leqslant \frac{64 k}{\varepsilon^{4}} O\left(\varepsilon^{2} a_{\varepsilon}^{2}+\varepsilon^{4}\right) \\
& \leqslant M
\end{aligned}
$$

Then $\left\|\Delta u_{\varepsilon}\right\|_{L^{2}},\left\|\nabla u_{\varepsilon}\right\|_{L^{2}}$ and $\left\|u_{\varepsilon}\right\|_{L^{2}}$ are bounded. It well known that the norms

$$
\|v\|:=\|\Delta v\|_{L^{2}}+\|\nabla v\|_{L^{2}}+\|v\|_{L^{2}}
$$

and $\|v\|_{H_{2}^{2}}$ are equivalent (it is a direct consequence of Bochner formula). Hence, this implies that $\left(u_{\varepsilon}\right)_{\varepsilon}$ is bounded in $H_{2}^{2}$ which is embedded in $C^{0}$. Then $u_{\varepsilon} \longrightarrow c_{0}$ uniformily up to a subsequence. Since $c_{0} \neq 0$ it follows that for $\varepsilon$ small enough $u_{\varepsilon}$ has a constant sign, which is not possible because $u_{\varepsilon}$ is an eigenfunction in the metric $g_{\varepsilon}$.
Second case : Assume that $\varepsilon=a_{\varepsilon} o(1)$. In this case we have the
Lemma 5.5. $v_{\varepsilon} \longrightarrow c_{1}$ in $H_{1}^{2}$ where $c_{1}$ is a constant.
Proof. The proof is similar to this of lemma 5.3. Indeed we consider $\varphi \in C^{\infty}(M)$ and the function $\eta_{\rho}$ defined in this previous proof. Then

$$
\int_{M}\langle\nabla v, \nabla \varphi\rangle=\int_{M}\left\langle\nabla v, \nabla\left(\eta_{\rho} \varphi\right)\right\rangle d v_{g}+\int_{M}\left\langle\nabla v, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g}
$$

By the same arguments we have $\int_{M}\left\langle\nabla v, \nabla\left(\eta_{\rho} \varphi\right)\right\rangle d v_{g} \longrightarrow 0$ when $\rho \longrightarrow 0$. Moreover

$$
\begin{aligned}
\left|\int_{M}\left\langle\nabla v, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g}\right| & =\lim _{\varepsilon \longrightarrow 0}\left|\int_{M}\left\langle\nabla v_{\varepsilon}, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g}\right| \\
& =\lim _{\varepsilon \longrightarrow 0}\left|\int_{M}\left(\Delta v_{\varepsilon}\right)\left(1-\eta_{\rho}\right) \varphi d v_{g}\right| \\
& =\lim _{\varepsilon \longrightarrow 0}\left|\frac{\mu_{1}\left(g_{\varepsilon}\right)}{a_{\varepsilon}} \int_{M} f_{\alpha, \varepsilon}^{2} v_{\varepsilon}\left(1-\eta_{\rho}\right) \varphi d v_{g}\right| .
\end{aligned}
$$

Now $\left|\frac{\mu_{1}\left(g_{\varepsilon}\right)}{a_{\varepsilon}} \int_{M} f_{\alpha, \varepsilon}^{2} v_{\varepsilon}\left(1-\eta_{\rho}\right) \varphi d v_{g}\right| \leqslant \frac{8 k}{a_{\varepsilon} \varepsilon^{2}} C \varepsilon^{4}\left\|v_{\varepsilon}\right\|_{L^{2}}\left(\int_{M}\left(1-\eta_{\rho}\right) \varphi^{2} d v_{g}\right)^{1 / 2}$. Since $\varepsilon=a_{\varepsilon} o(1)$, we deduce that $\left|\int_{M}\left\langle\nabla v, \nabla\left(\left(1-\eta_{\rho}\right) \varphi\right)\right\rangle d v_{g}\right|=0$ and then $\int_{M}\langle\nabla v, \nabla \varphi\rangle=0$. Therefore $\Delta v=0$ in sense of distributions and $v=c_{1}$ on $M$.

Now let $c_{\varepsilon}=\bar{u}_{\varepsilon}+a_{\varepsilon} c_{1}$. Then $c_{\varepsilon} \longrightarrow c_{0}$. We denotes by $\mu(g)$ the smallest positive eigenvalue of the Laplacian with respect to the metric $g$. From the definition of $a_{\varepsilon}$ and the definition of $\mu(g)$, we have

$$
\begin{align*}
a_{\varepsilon}^{2} \leqslant 2\left(\int_{M}\left|\nabla u_{\varepsilon}\right|^{2} d v_{g}+\int_{M}\left(u_{\varepsilon}-\bar{u}_{\varepsilon}\right)^{2} d v_{g}\right) & \leqslant 2\left(1+\frac{1}{\mu(g)}\right) \int_{M}\left|\nabla u_{\varepsilon}\right|^{2} d v_{g} \\
& =2\left(1+\frac{1}{\mu(g)}\right) \int_{M} \Delta u_{\varepsilon} u_{\varepsilon} d v_{g} \\
& =2\left(1+\frac{1}{\mu(g)}\right) \mu_{1}\left(g_{\varepsilon}\right) \int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}^{2} d v_{g} \tag{22}
\end{align*}
$$

Applying lemma 5.4 we get

$$
\begin{aligned}
\int_{M} f_{\alpha, \varepsilon}^{2} u_{\varepsilon}^{2} d v_{g} & =O\left(\varepsilon^{2}\left\|u_{\varepsilon}-c_{\varepsilon}\right\|_{L^{2}}^{2}+\varepsilon^{4}\right) \\
& =O\left(\varepsilon^{2}\left\|u_{\varepsilon}-\bar{u}_{\varepsilon}-a_{\varepsilon} c_{1}\right\|_{L^{2}}^{2}+\varepsilon^{4}\right) \\
& =O\left(a_{\varepsilon}^{2} \varepsilon^{2}\left\|\frac{u_{\varepsilon}-\bar{u}_{\varepsilon}}{a_{\varepsilon}}-c_{1}\right\|_{L^{2}}^{2}+\varepsilon^{4}\right) \\
& =O\left(a_{\varepsilon}^{2} \varepsilon^{2}\left\|v_{\varepsilon}-c_{1}\right\|_{L^{2}}^{2}+\varepsilon^{4}\right) \\
& =O\left(\varepsilon^{4}\right)+o\left(a_{\varepsilon}^{2} \varepsilon^{2}\right) .
\end{aligned}
$$

Now reporting this in (22) with the estimate (14) we find

$$
\begin{aligned}
a_{\varepsilon}^{2} & \leqslant C \frac{8 k}{\varepsilon^{2}}\left(O\left(\varepsilon^{4}\right)+o\left(a_{\varepsilon}^{2} \varepsilon^{2}\right)\right) \\
& =O\left(\varepsilon^{2}\right)+a_{\varepsilon}^{2} o(1) .
\end{aligned}
$$

But $\varepsilon=a_{\varepsilon} o(1)$. Then $a_{\varepsilon}^{2} \leqslant C a_{\varepsilon}^{2} o(1)$ and for $\varepsilon$ small enough $a_{\varepsilon}=0$ and $u_{\varepsilon}$ is a constant which is impossible.
