GLOBAL WELL-POSEDNESS FOR THE KP-I EQUATION ON THE BACKGROUND OF A NON LOCALIZED SOLUTION

Abstract. We prove that the Cauchy problem for the KP-I equation is globally well-posed for initial data which are localized perturbations (of arbitrary size) of a non-localized (i.e. not decaying in all directions) traveling wave solution (e.g. the KdV line solitary wave or the Zaitsev solitary waves which are localized in x and y periodic or conversely).

1. INTRODUCTION

We study here the initial value problem for the Kadomtsev-Petviashvili (KP-I) equation

(1)
$$
(u_t + u_{xxx} + uu_x)_x - u_{yy} = 0,
$$

where $u = u(t, x, y), (x, y) \in \mathbb{R}^2$, $t \in \mathbb{R}$, with initial data

(2)
$$
u(0, x, y) = \phi(x, y) + \psi_c(x, y),
$$

where ψ_c is the profile¹ of a non-localized (i.e. not decaying in all spatial directions) traveling wave of the KP-I equation moving with speed $c \neq 0$. This ψ_c could be for instance the line soliton of the Korteweg- de Vries (KdV) equation

(3)
$$
\psi_c(x,y) = 3c \cosh^{-2}\left(\frac{\sqrt{c}x}{2}\right)
$$

In (3) the KdV soliton is of course considered as a two dimensional (constant in y) object. Another possibility to see (3) as a solution of KP-I is to consider (1) posed on $\mathbb{R} \times \mathbb{T}$. Global solutions of (1) for data on $\mathbb{R} \times \mathbb{T}$, including data close to (3) were recently constructed in a work by Ionescu-Kenig [\[12](#page-39-0)]. In (2), the function ψ_c may also be the profile of the Zaitsev[[36](#page-40-0)] traveling waves (see also[[30\]](#page-40-0)) which is localized in x and periodic in y :

(4)
$$
\psi_c(x,y) = 12\alpha^2 \frac{1 - \beta \cosh(\alpha x) \cos(\delta y)}{(\cosh(\alpha x) - \beta \cos(\delta y))^2},
$$

where

$$
(\alpha, \beta) \in]0, \infty[\times] - 1, 1[,
$$

and the propagation speed is given by

$$
c = \alpha^2 \frac{4 - \beta^2}{1 - \beta^2}.
$$

Let us observe that the transform $\alpha \to i\alpha$, $\delta \to i\delta$, $c \to ic$ produces solutions of [\(1\)](#page-1-0) which are periodic in x and localized in y. The profiles of these solutions are also admissible in ([2](#page-1-0)), under the assumption $|\beta| > 1$. Notice that for $\beta = 0$, ([4\)](#page-1-0) coincides with (3) (3) .

The global well-posedness of $(1)-(2)$ $(1)-(2)$ $(1)-(2)$ $(1)-(2)$ with data given by (3) (3) (3) which will be proved in this paper can be viewed as a preliminary step towards the rigorous mathematical justification of the (conjectured) nonlinear instability of the KdV soliton with respect to transversal perturbations governed by the KP-I flow. This question is, as far as we know, still an open problem (see however[[1](#page-39-0)] for a linear analysis of the instability and [\[10](#page-39-0)] for a linear instability analysis in the framework of the full Euler system). The instability scenario of the line soliton seems to be a symmetry breaking phenomenon : the line soliton should evolve towards the Zaitsev solitary wave [\(4\)](#page-1-0). Note that Haragus and Pego[[11\]](#page-39-0) have shown that this solution is the only one close to the line soliton which is periodic in y and decays to zero as $x \to \infty$.

The question of solving [\(1\)](#page-1-0) together with the initial data ([2](#page-1-0)) when ψ is the profile of the KdV line soliton, has been recently addressed by Fokas and Pogrobkov[[8\]](#page-39-0), by the inverse scattering transform (IST) techniques. However, the Cauchy problem is not rigorously solved in[[8](#page-39-0)] and it is unlikely that it could be solved for an arbitrary large data ϕ using IST since the Cauchy problem with purely localized data has been solved by IST techniques only for small initial data (see[[35](#page-40-0), [38](#page-40-0)]).

On the other hand, PDE techniques have been recently fruitfully used to obtain the global solvability of the KP equation with arbitrary large initial data, starting withthe pioneering paper of Bourgain [[4](#page-39-0)] on the KP-II equation (that is ([1](#page-1-0)) with $+u_{yy}$ instead of $-u_{yy}$). In [\[4\]](#page-39-0), the global well-posedness of the KP-II equation for datain $H^s(\mathbb{R}^2)$, $s \geq 0$ is established. The result in [[4](#page-39-0)] is obtained by performing the Picard iteration scheme to an equivalent integral equation in the Fourier transform restriction spaces of Bourgain. The situation for the KP-I equation turned out to be more delicate. We showed in[[27\]](#page-40-0) that the Picard iteration scheme can not be applied in the context of the KP-I equation as far as one considers initial data in Sobolev spaces. Sobolev spaces are natural, since the conservation laws for the KP-I equation

control Sobolev type norms. In[[22](#page-40-0)], a quite flexible method is introduced that allows to incorporate the dispersive effects in a context of a compactness method for proving the well-posedness. The work[[22\]](#page-40-0) was in turn inspired by the considerations in [\[5\]](#page-39-0) in the context of the Nonlinear Schrödinger equation on a compact manifold which is solved in [\[5\]](#page-39-0) as a semi-linear problem (i.e. by the Picard iteration scheme). The main point in[[22\]](#page-40-0) is to realize that the idea of[[5](#page-39-0)] can also be used in the context of a quasi-linear problem. The method of[[22\]](#page-40-0) turned out to be useful in the context of theKP-I equation (and some other models such as the Schrödinger maps $[15, 19]$ $[15, 19]$ $[15, 19]$) and the first global well-posedness result for the KP-I equation has been obtained by the authors of the present paper in[[26\]](#page-40-0). This result has been improved (i.e. the space of the allowed initial data is larger) by Kenig[[17\]](#page-39-0). Together with the idea of [\[22\]](#page-40-0), a new commutator estimate for the KP-I equation is used in[[17](#page-39-0)]. The main point in Kenig's result is the proof that KP-I is locally well-posed for data in the space

$$
\{u \in L^2(\mathbb{R}^2) : \partial_x^{-1} u_y \in L^2(\mathbb{R}^2), \quad |D_x|^s u \in L^2(\mathbb{R}^2), \ s > 3/2\}
$$

All papers [\[4\]](#page-39-0), [\[26](#page-40-0)] and [\[17](#page-39-0)] consider the KP equations in spaces of "localized" (zero at infinity) functions.

The main goal of this paper is to prove that, for a large class of ψ_c , the Cauchy problem ([1](#page-1-0)), [\(2\)](#page-1-0) is globally well-posed for data $\phi \in Z$, where

$$
Z := \{ u \in L^{2}(\mathbb{R}^{2}) : \partial_{x}^{-2} u_{yy} \in L^{2}(\mathbb{R}^{2}), \quad u_{xx} \in L^{2}(\mathbb{R}^{2}) \}.
$$

(notice that $u \in Z$ implies $u_y \in L^2(\mathbb{R}^2)$ and $\partial_x^{-1}u_y \in L^2(\mathbb{R}^2)$). More precisely, we have the following result.

Theorem 1. Let $\psi_c(x-ct, y)$ be a solution of the KP-I equation such that $\psi_c : \mathbb{R}^2 \longrightarrow \mathbb{R}$

is bounded with all its derivatives². Then for every $\phi \in Z$ there exists a unique global solution u of ([1](#page-1-0)) with initial data [\(2\)](#page-1-0) satisfying for all $T > 0$,

$$
[u(t, x, y) - \psi_c(x - ct, y)] \in C([0, T]; Z), \quad \partial_x[u(t, x, y) - \psi_c(x - ct, y)] \in L_T^1 L_{xy}^{\infty}.
$$

Furthermore, for all $T > 0$, the map $\phi \mapsto u$ is continuous from Z to $C([0,T]; Z)$).

Since the KP-I equation is time reversible, a similar statement to Theorem 1 holds for negative times as well. Let us notice that the assumptions on ψ_c in Theorem 1 are clearly satisfied by the line or the Zaitsev solitary wave. In the proof of Theorem 1, we write the solution u of (1) (1) , (2) as

$$
u(t, x, y) = \psi_c(x - ct, y) + v(t, x, y)
$$

²The bounds can of course depend on the propagation speed c .

where v is localized. This v satisfies the equation

(5) $(v_t + v_{xxx} + vv_x + \partial_x(\psi_c v))_x - v_{yy} = 0, \quad v(0, x, y) = \phi(x, y).$

Our strategy is then to adapt the proof of [\[26](#page-40-0), [17\]](#page-39-0). Starting from the local wellposedness result, we implement a compactness method based on "almost conserva-tionlaws". New terms occur with respect to [[26\]](#page-40-0) but they are controlled since ψ and its derivatives are bounded. It is of importance for our analysis that equation (5) does not contain a source term.

Werefer to the work by Gallo [[9](#page-39-0)] and the references therein, where non vanishing at infinity solutions to one dimensional dispersive models are constructed.

Let us notice that the framework considered in Theorem [1](#page-3-0) is also a convenient one for a rigorous study of the interaction of a line and lump solitary waves (see e.g. [\[6\]](#page-39-0)).

The rest of this paper is organized as follows. In the next section, using a compactness method, we prove a basic well-posedness result for (5). In Section 3, inspired by the formal KP-I conservation laws, we provide bounds for some Sobolev type norms of the local solutions. These bounds are however not sufficient to get global solutions. For that reason, in Section 4 we prove a Strichartz type bound. This bound is then used in Section 5 to get a first global well-posedness result. In Sections 6 and 7 we extend the well-posedness to the class Z introduced above. The last section is devoted to the "usual" KP-I equation. We show how the estimates of Section 4 can be used to give a slight improvement of the Kenig well-posedness result [\[17\]](#page-39-0).

2. LOCAL WELL-POSEDNESS FOR DATA IN $H_{-1}^s(\mathbb{R}^2)$, $s > 2$

In this section, we prove a basic local well-posedness result for (5). The proof follows a standard compactness method. We however need to work in Sobolev spaces of integer indexes, in order to make work the commutator estimates related to the term $\partial_x(\psi_c v)$.

By $H^s(\mathbb{R}^2)$, $s \in \mathbb{R}$, we denote the classical Sobolev spaces. The local existence result for [\(6\)](#page-5-0) will be obtained in the spaces $H_{-1}^s(\mathbb{R}^2)$ equipped with the norm

$$
||u||_{H^s_{-1}(\mathbb{R}^2)} = ||(1+|\xi|^{-1})\langle |\xi| + |\eta| \rangle^s \widehat{u}(\xi,\eta) ||_{L^2_{\xi\eta}},
$$

where $\langle \cdot \rangle = (1+|\cdot|^2)^{\frac{1}{2}}$ and \hat{u} denotes the Fourier transform of u. The spaces $H_{-1}^s(\mathbb{R}^2)$ are adapted to the specific structure of the KP type equations. In the estimates it will appear $W^{r,\infty}$ -norms of ψ_c defined for any integer $r \geq 0$ by

$$
\|\psi_c\|_{W^{r,\infty}} = \sum_{0 \leq |\alpha| = |(\alpha_1,\alpha_2)| \leq r} \|\partial_x^{\alpha_1} \partial_y^{\alpha_2} \psi_c\|_{L^\infty_{xy}}
$$

Consider the "integrated" equation ([5](#page-4-0))

(6)
$$
u_t + u_{xxx} - \partial_x^{-1} u_{yy} + u u_x + \partial_x(\psi u) = 0,
$$

with initial data

(7)
$$
u(0,x,y) = \phi(x,y).
$$

For the solutions we study in this section, ([5\)](#page-4-0) may be substituted by (6). For conciseness we skip the c of ψ_c in (6) and we suppose that $c = 1$ in the sequel. Of course, the case $c \neq 1$ can be treated in exactly the same manner. We have the following local well-posedness result for (6).

Proposition 1. Let $s > 2$ be an integer. Then for every $\phi \in H^s_{-1}(\mathbb{R}^2)$ there exists $T \gtrsim (1\!+\!\|\phi\|_{H^s})^{-1}$ and a unique solution u to (6) on the time interval $[0,T]$ satisfying

$$
u \in C([0,T]; H^s(\mathbb{R}^2)), \quad u \in L^{\infty}([0,T]; H^s_{-1}(\mathbb{R}^2)).
$$

In addition, for $t \in [0, T]$,

(8)
$$
||u(t, \cdot)||_{H^{s}(\mathbb{R}^2)} \leq C||\phi||_{H^{s}(\mathbb{R}^2)} \exp \Big(c||\nabla_{x,y}u||_{L_T^1 L_{xy}^{\infty}} + cT||\psi||_{W^{s,\infty}}\Big).
$$

Moreover if $\phi \in H^{\sigma}_{-1}(\mathbb{R}^2)$ where $\sigma > s$ is an integer then

$$
u \in C([0,T]; H_{-1}^{\sigma}(\mathbb{R}^2)).
$$

Finally, the map $\phi \mapsto u_{\phi}$ is continuous from $H^{s}(\mathbb{R}^{2})$ to $C([0, T]; H^{s}(\mathbb{R}^{2}))$.

Proof of Proposition 1. The process is very classical (see[[13\]](#page-39-0) for a closely related result). For $\varepsilon > 0$ we look at the regularized equation

(9)
$$
u_t^{\varepsilon} + \varepsilon \Delta^2 u_t^{\varepsilon} = -u_{xxx}^{\varepsilon} + \partial_x^{-1} u_{yy}^{\varepsilon} - u^{\varepsilon} u_x^{\varepsilon} - \partial_x (\psi u^{\varepsilon})
$$

where $\Delta = \partial_x^2 + \partial_y^2$ is the Laplace operator. Equation (9) with initial condition

$$
\phi_{\varepsilon} = (1 - \sqrt{\varepsilon} \Delta)^{-1} \phi
$$

can be rewritten under the form

(10)
$$
u^{\varepsilon}(t) = L^{\varepsilon}(t)\phi_{\varepsilon} - \int_0^t L^{\varepsilon}(t-\tau)(1+\varepsilon\Delta^2)^{-1}\big(u^{\varepsilon}(\tau)u^{\varepsilon}_x(\tau) + \partial_x(\psi(\tau)u^{\varepsilon}(\tau))\big)d\tau,
$$

where

$$
L^{\varepsilon}(t) := \exp\left(-t(1+\varepsilon\Delta^2)^{-1}(\partial_x^3 - \partial_x^{-1}\partial_y^2)\right).
$$

Notice that, thanks to the regularization effect of $(1 + \varepsilon \Delta^2)^{-1}$, for $\varepsilon \neq 0$, the map

$$
u \longrightarrow (1 + \varepsilon \Delta^2)^{-1} \big(u u_x + \partial_x(\psi u) \big)
$$

is locally Lipschitz from $H^s(\mathbb{R}^2)$ to $H^s(\mathbb{R}^2)$, provided $s > 2$. The operator $L^{\varepsilon}(t)$ is clearly bounded on $H^s(\mathbb{R}^2)$ and therefore by the Cauchy-Lipschitz-Picard theorem there is a unique local solution

(11)
$$
u^{\varepsilon} \in C([0,T]; H^{s}(\mathbb{R}^{2}))
$$

of ([10](#page-5-0)) with

$$
T \gtrsim (1 + \|\phi_{\varepsilon}\|_{H^s})^{-1} \ge (1 + \|\phi\|_{H^s})^{-1}.
$$

Thanks to the perfect derivative structure of the integral term in [\(10\)](#page-5-0), we also obtain that

$$
u^{\varepsilon} \in C([0,T]; H_{-1}^{s}(\mathbb{R}^{2})).
$$

Notice also that, thanks to the assumption $s > 2$, $(1 - \sqrt{\varepsilon} \Delta) u^{\varepsilon}$ belongs to $H^{s}(\mathbb{R}^{2})$. We next study the convergence of u^{ε} as $\varepsilon \to 0$. For that purpose, we establish a priori bounds, independent³ of ε on $||u^{\varepsilon}(t, \cdot)||_{H^{s}}$ on time intervals of size of order $(1 + ||\phi||_{H^s})^{-1}.$

Multiplying ([9](#page-5-0)) with u^{ε} , after an integration by parts, we obtain that

(12)
$$
\frac{d}{dt} \Big[\|u^{\varepsilon}(t,\cdot)\|_{L^{2}}^{2} + \varepsilon \|\Delta u^{\varepsilon}(t,\cdot)\|_{L^{2}}^{2} \Big] \lesssim \|\psi_{x}\|_{L^{\infty}} \|u^{\varepsilon}(t,\cdot)\|_{L^{2}}^{2}.
$$

Let us recall a classical commutator estimate (see e.g. [\[16\]](#page-39-0)).

Lemma 1. Let Δ be the Laplace operator on \mathbb{R}^n , $n \geq 1$. Denote by J^s the operator $(1 - \Delta)^{s/2}$. Then for every $s > 0$,

$$
\|[J^s,f]g\|_{L^2(\mathbb{R}^n)} \lesssim \|\nabla f\|_{L^{\infty}(\mathbb{R}^n)} \|J^{s-1}g\|_{L^2(\mathbb{R}^n)} + \|J^s f\|_{L^2(\mathbb{R}^n)} \|g\|_{L^{\infty}(\mathbb{R}^n)}.
$$

Using Lemma 1, we obtain for fixed y ,

$$
\|[\partial_x^s,u(x,\cdot)]u_x(x,\cdot)\|_{L^2_x} \lesssim \|u_x(x,\cdot)\|_{L^\infty_x} \|J^s_xu(x,\cdot)\|_{L^2_x}
$$

where $J_x^s = (1 - \partial_x^2)^{s/2}$. Squaring, integrating over y and integrating by parts, it yields

(13)
$$
\left| \int_{\mathbb{R}^2} \partial_x^s (uu_x) \partial_x^s u \right| \lesssim \|u_x\|_{L_{xy}^\infty} \|J_x^s u\|_{L_{xy}^2}^2
$$

³Notice that the bounds on $||u^{\varepsilon}(t, \cdot)||_{H^{s}}$ resulting from the Cauchy-Lipschitz theorem applied to ([9](#page-5-0)) are unfortunately very poor (depending on ε).

On the other hand, by Leibniz rule and integration by parts (recall that s is an integer), we get

(14)
$$
\left| \int_{\mathbb{R}^2} \partial_x^s (\psi u)_x \partial_x^s u \right| \lesssim ||\psi_x||_{W^{s-1,\infty}} ||J_x^s u||_{L^2_{xy}}^2
$$

Therefore applying ∂_x^s to [\(9\)](#page-5-0), multiplying it with $\partial_x^s u^{\varepsilon}$ gives

$$
(15) \quad \frac{d}{dt} \Big[\|\partial_x^s u^{\varepsilon}(t,\cdot)\|_{L^2}^2 + \varepsilon \|\partial_x^s \Delta u^{\varepsilon}(t,\cdot)\|_{L^2}^2 \Big] \lesssim
$$

$$
\lesssim \Big(\|u^{\varepsilon}_x(t,\cdot)\|_{L^{\infty}} + \|\psi_x\|_{W^{s-1,\infty}} \Big) \|J^s_x u^{\varepsilon}(t,\cdot)\|_{L^2(\mathbb{R}^2)}^2
$$

Next we estimate the y derivatives. In the same way, using Lemma [1,](#page-6-0) we obtain that for a fixed x

(16)
$$
\|[\partial_y^s, u(x, \cdot)]u_x(x, \cdot)\|_{L_y^2} \lesssim
$$

$$
\lesssim (||u_x(x, \cdot)||_{L_y^{\infty}} + ||u_y(x, \cdot)||_{L_y^{\infty}}) \Big(||J_y^{s-1}u_x(x, \cdot)||_{L_y^2} + ||J_y^s u(x, \cdot)||_{L_y^2}\Big),
$$

where $J_y^s = (1 - \partial_y^2)^{s/2}$. Squaring (16), integration over x and an integration by parts yield Z

$$
\left| \int_{\mathbb{R}^2} \partial_y^s (u u_x) \partial_y^s u \right| \lesssim \|\nabla_{x,y} u\|_{L^\infty_{xy}} \|u\|_{H^s(\mathbb{R}^2)}^2
$$

by Lgibniz rule and interaction by parts

On the other hand, by Leibniz rule and integration by parts,

$$
\left| \int_{\mathbb{R}^2} \partial_y^s (\psi u)_x \partial_y^s u \right| \lesssim ||\psi||_{W^{s,\infty}} ||u||_{H^s(\mathbb{R}^2)}^2.
$$

Therefore applying ∂_y^s to [\(9](#page-5-0)) and multiplying it by $\partial_y^s u^{\varepsilon}$ gives

$$
(17) \quad \frac{d}{dt} \Big[\|\partial_y^s u^{\varepsilon}(t,\cdot)\|_{L^2}^2 + \varepsilon \|\partial_y^s \Delta u^{\varepsilon}(t,\cdot)\|_{L^2}^2 \Big] \lesssim
$$

$$
\lesssim \Big(\|\nabla_{x,y} u^{\varepsilon}(t,\cdot)\|_{L^{\infty}} + \|\psi\|_{W^{s,\infty}} \Big) \|u^{\varepsilon}(t,\cdot)\|_{H^s(\mathbb{R}^2)}^2.
$$

Since for s integer

 $||u||_{H^s} \approx ||u||_{L^2} + ||\partial_x^s u||_{L^2} + ||\partial_y^s u||_{L^2},$

combining (12) (12) (12) , (15) and (17) gives

$$
\frac{d}{dt} \Big[||u^{\varepsilon}(t,\cdot)||^{2}_{H^{s}(\mathbb{R}^{2})} + \varepsilon ||\Delta u^{\varepsilon}(t,\cdot)||^{2}_{H^{s}(\mathbb{R}^{2})} \Big] \lesssim
$$

$$
\lesssim \Big(||\nabla_{x,y} u^{\varepsilon}(t,\cdot)||_{L^{\infty}} + ||\psi||_{W^{s,\infty}} \Big) ||u^{\varepsilon}(t,\cdot)||^{2}_{H^{s}(\mathbb{R}^{2})}
$$

and therefore using that

$$
\|\phi_{\varepsilon}\|_{H^{s}(\mathbb{R}^2)}^2 + \varepsilon \|\Delta \phi_{\varepsilon}\|_{H^{s}(\mathbb{R}^2)}^2 \le \|\phi\|_{H^{s}(\mathbb{R}^2)}^2
$$

by the Gronwall lemma for every $T > 0$ on the time of existence of u^{ε} ,

(18)
$$
\|u^{\varepsilon}\|_{L^{\infty}_T H^s(\mathbb{R}^2)} \leq \|\phi\|_{H^s(\mathbb{R}^2)} \exp\left(c\|\nabla_{x,y}u^{\varepsilon}\|_{L^1_T L^{\infty}_{xy}} + cT\|\psi\|_{W^{s,\infty}}\right).
$$

which is the key inequality. Since $s > 2$, using the Sobolev embedding, we get

(19)
$$
\int_0^T \|\nabla_{x,y} u^{\varepsilon}(\tau,\cdot)\|_{L^\infty} d\tau \leq C T \|u^{\varepsilon}(t,\cdot)\|_{L^\infty_T H^s(\mathbb{R}^2)}.
$$

Using (18), (19) and the continuity of $u^{\varepsilon}(t)$ with respect to time (see ([11\)](#page-6-0)), we obtain that there exists $C > 0$ such that if

$$
T\lesssim (1+\|\phi\|_{H^s(\mathbb{R}^2)})^{-1}
$$

then

(20)
$$
\int_0^T \|\nabla_{x,y} u^{\varepsilon}(\tau,\cdot)\|_{L^{\infty}(\mathbb{R}^2)} d\tau \leq C
$$

and

(21)
$$
||u^{\varepsilon}||_{L^{\infty}_{T}H^{s}(\mathbb{R}^{2})} \leq C||\phi||_{H^{s}(\mathbb{R}^{2})}.
$$

We next estimate the anti-derivatives of u^{ε} . Let $v^{\varepsilon} := \partial_x^{-1} u^{\varepsilon}$. Then, using ([10](#page-5-0)), we obtain that v^{ε} solves the equation

$$
v^{\varepsilon}(t) = L^{\varepsilon}(t)\partial_x^{-1}\phi_{\varepsilon} - \int_0^t L^{\varepsilon}(t-\tau)(1+\varepsilon\Delta^2)^{-1}(\frac{1}{2}(u^{\varepsilon}(\tau))^2 + \psi(\tau)u^{\varepsilon}(\tau))d\tau.
$$

Therefore, since $s > 2$, using the Leibniz rule and the Sobolev inequality, we get the bound

$$
(22)\ \|\boldsymbol{v}^{\varepsilon}\|_{L^{\infty}_{T}H^{s}(\mathbb{R}^{2})}\leq\|\partial_{x}^{-1}\phi\|_{H^{s}(\mathbb{R}^{2})}+CT\|\boldsymbol{u}^{\varepsilon}\|_{L^{\infty}_{T}H^{s}(\mathbb{R}^{2})}\left(\|\boldsymbol{u}^{\varepsilon}\|_{L^{\infty}_{T}H^{s}(\mathbb{R}^{2})}+\|\psi\|_{W^{s,\infty}}\right).
$$

Coming back to the equation [\(9](#page-5-0)), we infer from (22) that the sequence $(\partial_t(u^{\varepsilon}))$ is bounded in a weaker norm, say in $L_T^{\infty} H^{s-2005}(\mathbb{R}^2)$. Therefore from the Aubin-Lionscompactness theorem (see e.g. [[23](#page-40-0)]), we obtain that u^{ε} converges, up to a subsequence, to some limit u in the space $L^2_{loc}((0,T)\times\mathbb{R}^2)$ which satisfy [\(8\)](#page-5-0) and

(23)
$$
\int_0^T \|\nabla_{x,y} u(\tau,\cdot)\|_{L^\infty(\mathbb{R}^2)} d\tau \leq C.
$$

Thanks to (22), we obtain that (up to a subsequence) $\partial_x^{-1} u^{\varepsilon}$ converges in $\mathcal{D}'((0,T) \times \mathbb{R}^2)$ to a limit which can be identified as $\partial_x^{-1} u$. By writing the nonlinearity uu_x as 1 $\frac{1}{2}\partial_x(u^2)$, passing into a limit in the equation [\(9\)](#page-5-0) as $\varepsilon \to 0$, we obtain that the function u satisfy the equation (6) (6) (6) in the distributional sense. Moreover thanks to (21) and (22) , we obtain that

$$
u \in L^{\infty}([0,T]; H_{-1}^{s}(\mathbb{R}^{2}))
$$
.

In addition, thanks to the Lebesgue theorem, ϕ_{ε} converges in $H_{-1}^s(\mathbb{R}^2)$ to ϕ as $\varepsilon \to 0$ and thus u satisfies the initial condition [\(7\)](#page-5-0). Next, if $\phi \in H^{\sigma}_{-1}(\mathbb{R}^2)$ with $\sigma > s$, $\sigma \in \mathbb{N}$, then as above, we get the estimate [\(8](#page-5-0)) with σ instead of s which, in view of [\(23\)](#page-8-0), yields the propagation of the $H^{\sigma}(\mathbb{R}^2)$ regularity. We next estimate the anti-derivatives of u in H^{σ} by invoking [\(22\)](#page-8-0) (with σ instead of s) in the limit $\varepsilon \to 0$. The uniqueness is straightforward from the Gronwall lemma and ([23](#page-8-0)). The continuity of the flow map and the fact that the solution is a continuous curve in $H^s(\mathbb{R}²)$ can be obtained by the Bona-Smith approximation argument [\[3\]](#page-39-0). We do not give the details of this construction in this section since a completely analogous discussion will be performed later in this paper.

Let us next state a corollary of Proposition [1.](#page-5-0)

Proposition 2. Let $s > 2$ be an integer. Then for every $\phi \in H^s_{-1}(\mathbb{R}^2)$ the local solution constructed in Proposition [1](#page-5-0) can be extended to a maximal existence interval $[0, T^{\star}]$ such that either $T^{\star} = \infty$ or

$$
\lim_{t \to T^*} \|\nabla_{x,y} u\|_{L^1_t L^\infty_{xy}} = \infty.
$$

Proof. It suffices to iterate the result of Proposition [1](#page-5-0) by invoking ([8](#page-5-0)) at each iteration step. \Box

It results from Proposition 2 that the key quantity for the global existence in $H^s_{-1}(\mathbb{R}^2), s > 2 \text{ is } \|\nabla_{x,y} u(t, \cdot)\|_{L^\infty}.$

3. A priori estimates using conservation laws

In this section we control the growth of some quantities directly related to the conservation laws of KP I. Recall that the solutions obtained in Proposition [1](#page-5-0) satisfy

(24)
$$
u_t + u_{xxx} + uu_x + \partial_x(\psi u) - \partial_x^{-1} u_{yy} = 0.
$$

In [\[37](#page-40-0)], it is shown that the KP-I equation has a Lax pair representation. This in turn provides an algebraic procedure generating an infinite sequence of conservation laws. More precisely, if u is a formal solution of the KP-I equation then

$$
\frac{d}{dt}\Big[\int \chi_n\Big]=0,
$$

where $\chi_1 = u$, $\chi_2 = u + i \partial_x^{-1} \partial_y u$ and for $n \geq 3$,

$$
\chi_n = \left(\sum_{k=1}^{n-2} \chi_k \chi_{n+1-k}\right) + \partial_x \chi_{n-1} + i \partial_x^{-1} \partial_y \chi_{n-1} .
$$

For $n=3$, we find the conservation of the L^2 norm, $n=5$ corresponds to the energy functional giving the Hamiltonian structure of the KP-I equation. As we noticed

in [\[26](#page-40-0)], there is a serious analytical obstruction to give sense of χ_9 as far as \mathbb{R}^2 is considered as a spatial domain.

Inspired by the above discussion, we define the following functionals

$$
M(u) = \int_{\mathbb{R}^2} u^2, \quad E(u) = \frac{1}{2} \int_{\mathbb{R}^2} u_x^2 + \frac{1}{2} \int_{\mathbb{R}^2} (\partial_x^{-1} u_y)^2 - \frac{1}{6} \int_{\mathbb{R}^2} u^3
$$

and

$$
F^{\psi}(u) = \frac{3}{2} \int_{\mathbb{R}^2} u_{xx}^2 + 5 \int_{\mathbb{R}^2} u_y^2 + \frac{5}{6} \int_{\mathbb{R}^2} (\partial_x^{-2} u_{yy})^2 - \frac{5}{6} \int_{\mathbb{R}^2} u^2 \partial_x^{-2} u_{yy} - \frac{5}{6} \int_{\mathbb{R}^2} u (\partial_x^{-1} u_y)^2 + \frac{5}{4} \int_{\mathbb{R}^2} u^2 u_{xx} + \frac{5}{24} \int_{\mathbb{R}^2} u^4 - \frac{5}{3} \int_{\mathbb{R}^2} \psi u \partial_x^{-2} u_{yy} - \frac{5}{6} \int_{\mathbb{R}^2} \psi (\partial_x^{-1} u_y)^2.
$$

Recall that the functionals M and E corresponds to the momentum and energy conservations respectively while the functional F^{ψ} is motivated by the higher order conservation laws for the KP-I equation associated to χ_7 . Let us notice however that the functional $F^{\psi}(\cdot)$ contains two supplementary terms involving ψ with respect to the corresponding conservation law of the KP-I equation.

We denote by $H_{-1}^{\infty}(\mathbb{R}^2)$ the intersection of all $H_{-1}^s(\mathbb{R}^2)$. The next proposition gives bounds on the quantities M, E and F^{ψ} for data in spaces where the local well-posedness of the previous section holds.

Proposition 3. For every $R > 0$ there exists $C > 0$ such that if $u \in L^{\infty}([0, T]; H^{\infty}_{-1}(\mathbb{R}^2))$ is a solution to ([6](#page-5-0)) corresponding to an initial data $\phi \in Z \cap H_{-1}^{\infty}(\mathbb{R}^2)$, $\|\phi\|_Z \leq R$ then $E(u(t))$ and $F^{\psi}(u(t))$ are well-defined and $\forall t \in [0, T]$,

(25)
$$
M(u(t)) \leq C \exp(C t) M(\phi)
$$

(26)
$$
|E(u(t))| \leq C \exp(C t) |E(\phi)| + g_1(t)
$$

(27)
$$
|F^{\psi}(u(t))| \leq C \exp(C t) |F(\phi)| + g_2(t)
$$

where $g_1, g_2 : \mathbb{R}_+ \to \mathbb{R}_+$ are continuous bijections depending only on R.

Proof of Proposition 3. Before entering into the proof of Proposition 3, we state an anisotropic Sobolev inequality which will be used in the proof.

Lemma 2. For $2 \le p \le 6$ there exists $C > 0$ such that for every $u \in H^{\infty}_{-1}(\mathbb{R}^2)$,

(28)
$$
||u||_{L^{p}(\mathbb{R}^{2})} \leq C||u||_{L^{2}(\mathbb{R}^{2})}^{\frac{6-p}{2p}} ||u_{x}||_{L^{2}(\mathbb{R}^{2})}^{\frac{p-2}{p}} ||\partial_{x}^{-1}u_{y}||_{L^{2}(\mathbb{R}^{2})}^{\frac{p-2}{2p}}.
$$

Proof. We refer to [\[2\]](#page-39-0) for a proof of [\(28\)](#page-10-0) and for a systematic study of anisotropic Sobolev embeddings. For a sake of completeness, here we reproduce the proof of [\(28](#page-10-0)) given in [\[33](#page-40-0)]. Inequality (28) clearly holds for $p = 2$. By convexity, it suffices thus to prove it for $p = 6$. Following the Gagliardo-Nirenberg proof of the Sobolev embedding, we write

$$
u^{2}(x, y) = 2 \int_{-\infty}^{x} u_{x}(z, y) u(z, y) dz
$$

and therefore using the Cauchy-Schwarz inequality in the z integration, we obtain that for a fixed y ,

$$
\left[\sup_{x\in\mathbb{R}}|u(x,y)|\right]^4 \le 4\left(\int_{-\infty}^{\infty}u_x^2(z,y)dz\right)\left(\int_{-\infty}^{\infty}u^2(z,y)dz\right).
$$

Therefore by writing $u^6 = u^4 u^2$, we get

(29)
$$
\int_{\mathbb{R}^2} u^6(x, y) dx dy \le 4 \int_{-\infty}^{\infty} \left(\int_{-\infty}^{\infty} u_x^2(z, y) dz \right) \left(\int_{-\infty}^{\infty} u^2(z, y) dz \right)^2 dy.
$$

Next, using Fubini theorem and an integration by parts, we obtain

$$
\int_{-\infty}^{\infty} u^2(z, y) dz = 2 \int_{-\infty}^{\infty} \int_{-\infty}^{y} u(z, w) u_y(z, w) dw dz
$$

\n
$$
= 2 \int_{-\infty}^{y} \int_{-\infty}^{\infty} u(z, w) u_y(z, w) dz dw
$$

\n
$$
= -2 \int_{-\infty}^{y} \int_{-\infty}^{\infty} u_x(z, w) \partial_x^{-1} u_y(z, w) dz dw.
$$

An application of the Cauchy-Schwarz inequality now gives

$$
\sup_{y \in \mathbb{R}} \left(\int_{-\infty}^{\infty} u^2(z, y) dz \right)^2 \le 4 \|u_x\|_{L^2_{xy}}^2 \|\partial_x^{-1} u_y\|_{L^2_{xy}}^2.
$$

Coming back to (29) yields

$$
\int_{\mathbb{R}^2} u^6(x, y) dx dy \le 16 \|u_x\|_{L^2_{xy}}^4 \|\partial_x^{-1} u_y\|_{L^2_{xy}}^2
$$

which is [\(28](#page-10-0)) for $p = 6$. This completes the proof of Lemma [2.](#page-10-0)

Let us return to the proof of Proposition [3](#page-10-0). Note that since u satisfies (6) , one has

$$
u_t \in C([0,T]; H^s(\mathbb{R}^2)), \quad \forall s \in \mathbb{N}.
$$

First, taking the L^2 -scalar product of [\(6\)](#page-5-0) with u, one obtains

$$
\frac{1}{2}\frac{d}{dt}\int_{\mathbb{R}^2}u^2 = \int_{\mathbb{R}^2}\psi u u_x = -\frac{1}{2}\int_{\mathbb{R}^2}\psi_x u^2
$$

and thus

(30)
$$
||u(t)||_{L^2} \lesssim \exp(Ct ||\psi_x||_{L^{\infty}}) ||\phi||_{L^2}.
$$

Wewill use, following [[24\]](#page-40-0), an exterior regularization of (6) (6) (6) by a sequence of smooth functions φ^{ε} that cut the low frequencies. More precisely, let φ^{ε} be defined via its Fourier transform as

(31)
$$
\hat{\varphi}^{\varepsilon}(\xi,\eta) := \begin{cases} 1 & \text{if } \varepsilon < |\xi| < \frac{1}{\varepsilon} \text{ and } \varepsilon < |\eta| < \frac{1}{\varepsilon}, \\ 0 & \text{otherwise.} \end{cases}
$$

Note that thanks to the Lebesgue dominated convergence theorem, if $u \in H^s_{-1}(\mathbb{R}^2)$, $s \in \mathbb{R}$ then $\varphi^{\varepsilon} * u$ converges to u in $H^s_{-1}(\mathbb{R}^2)$. Thanks to the Sobolev embedding similar statements hold for $u \in L^p(\mathbb{R}^2)$, $2 \le p \le \infty$.

Taking the convolution of [\(6\)](#page-5-0) with φ^{ε} , one gets

(32)
$$
\varphi^{\varepsilon} * u_t + \varphi^{\varepsilon} * u_{xxx} + \varphi^{\varepsilon} * \partial_x(\psi u + u^2/2) - \varphi^{\varepsilon} * \partial_x^{-1} u_{yy} = 0
$$

Setting

$$
u^\varepsilon = \varphi^\varepsilon * u,
$$

multiplying (32) by

$$
-\varphi^{\varepsilon} * u_{xx} + \partial_x^{-2}(\varphi^{\varepsilon} * u_{yy}) - \frac{1}{2}(\varphi^{\varepsilon} * u^2)
$$

and integrating in \mathbb{R}^2 , one obtains that

$$
(33) \quad \frac{1}{2} \frac{d}{dt} \Biggl[\int_{\mathbb{R}^2} (u_x^{\varepsilon})^2 + \int_{\mathbb{R}^2} (\partial_x^{-1} u_y^{\varepsilon})^2 - \int_{\mathbb{R}^2} \frac{(u^{\varepsilon})^3}{3} \Biggr] =
$$

$$
\frac{1}{2} \int_{\mathbb{R}^2} \Biggl[\varphi^{\varepsilon} * u^2 - (u^{\varepsilon})^2 \Biggr] u_t^{\varepsilon} + \int_{\mathbb{R}^2} (\varphi_x^{\varepsilon} * (\psi u)) u_{xx}^{\varepsilon}
$$

$$
- \int_{\mathbb{R}^2} (\varphi_x^{\varepsilon} * (\psi u)) \partial_x^{-2} u_{yy}^{\varepsilon} + \frac{1}{2} \int_{\mathbb{R}^2} (\varphi_x^{\varepsilon} * (\psi u)) (\varphi^{\varepsilon} * u^2)
$$

$$
:= I + II + III + IV.
$$

Our aim is to passe to the limit $\varepsilon \to 0$. Let us first estimate I. This argument is very typical for the present analysis and a similar situation will appear frequently in the rest of the proof of Proposition [3](#page-10-0). Using equation (32) and the Cauchy-Schwartz inequality, we can write

$$
|I| \lesssim \|u_t^{\varepsilon}\|_{L^2(\mathbb{R}^2)} \|\varphi^{\varepsilon} * u^2 - (u^{\varepsilon})^2\|_{L^2(\mathbb{R}^2)} \lesssim (\|u\|_{H^3_{-1}(\mathbb{R}^2)} + \|u\|_{H^3_{-1}(\mathbb{R}^2)}^2) \|\varphi^{\varepsilon} * u^2 - (u^{\varepsilon})^2\|_{L^2(\mathbb{R}^2)} .
$$

Next, we write using the triangle inequality and the Sobolev inequality,

$$
\|\varphi^{\varepsilon} * u^2 - (u^{\varepsilon})^2\|_{L^2(\mathbb{R}^2)} \leq \|\varphi^{\varepsilon} * u^2 - u^2\|_{L^2(\mathbb{R}^2)} + \|u^2 - (u^{\varepsilon})^2\|_{L^2(\mathbb{R}^2)}\leq \|\varphi^{\varepsilon} * u^2 - u^2\|_{L^2(\mathbb{R}^2)} + \|u - u^{\varepsilon}\|_{L^2}(\|u\|_{L^{\infty}} + \|u^{\varepsilon}\|_{L^{\infty}})\leq \|\varphi^{\varepsilon} * u^2 - u^2\|_{L^2(\mathbb{R}^2)} + \|u\|_{H^2(\mathbb{R}^2)} \|u - u^{\varepsilon}\|_{L^2}.
$$

Since $u \in H^{\infty}_{-1}(\mathbb{R}^2)$, we can apply the Lebesgue dominated convergence theorem to conclude that

$$
\lim_{\varepsilon \to 0} \|\varphi^{\varepsilon} * u^2 - (u^{\varepsilon})^2\|_{L^2(\mathbb{R}^2)} = 0.
$$

Therefore the term I tends to zero as ε tends to zero.

Next, we write

$$
II = \int_{\mathbb{R}^2} (\psi u^{\varepsilon})_x u^{\varepsilon}_{xx} + \int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_x - (\psi u^{\varepsilon})_x] u^{\varepsilon}_{xx}
$$

\n
$$
= \int_{\mathbb{R}^2} \psi_x u^{\varepsilon} u^{\varepsilon}_{xx} + \int_{\mathbb{R}^2} \psi u^{\varepsilon}_x u^{\varepsilon}_{xx} + \int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_x - (\psi u^{\varepsilon})_x] u^{\varepsilon}_{xx}
$$

\n
$$
= -\frac{3}{2} \int_{\mathbb{R}^2} \psi_x (u^{\varepsilon}_x)^2 + \frac{1}{2} \int \psi_{xxx} (u^{\varepsilon})^2 + \int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_x - (\psi u^{\varepsilon})_x] u^{\varepsilon}_{xx}
$$

and

$$
III = -\int_{\mathbb{R}^2} (\psi u^{\varepsilon})_x \partial_x^{-2} u_{yy}^{\varepsilon} - \int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_x - (\psi u^{\varepsilon})_x] \partial_x^{-2} u_{yy}^{\varepsilon}
$$

\n
$$
= -\int_{\mathbb{R}^2} \psi u_y^{\varepsilon} \partial_x^{-1} u_y^{\varepsilon} - \int_{\mathbb{R}^2} \psi_y u^{\varepsilon} \partial_x^{-1} u_y^{\varepsilon} - \int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_y - (\psi u^{\varepsilon})_y] \partial_x^{-1} u_y^{\varepsilon}
$$

\n
$$
= \frac{1}{2} \int_{\mathbb{R}^2} \psi_x (\partial_x^{-1} u_y^{\varepsilon})^2 - \int_{\mathbb{R}^2} \psi_y u^{\varepsilon} \partial_x^{-1} u_y^{\varepsilon} - \int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_y - (\psi u^{\varepsilon})_y] \partial_x^{-1} u_y^{\varepsilon}
$$

and

$$
IV = \frac{1}{2} \int_{\mathbb{R}^2} (\psi u^{\varepsilon})_x (u^{\varepsilon})^2 + \frac{1}{2} \int_{\mathbb{R}^2} [(\varphi_x^{\varepsilon} * (\psi u))(\varphi^{\varepsilon} * u^2) - (\psi u^{\varepsilon})_x (u^{\varepsilon})^2] = \frac{1}{3} \int_{\mathbb{R}^2} \psi_x (u^{\varepsilon})^3 + \frac{1}{2} \int_{\mathbb{R}^2} [(\varphi_x^{\varepsilon} * (\psi u))(\varphi^{\varepsilon} * u^2) - (\psi u^{\varepsilon})_x (u^{\varepsilon})^2].
$$

Similarly to the analysis for I, thanks to the Lebesgue theorem, all commutator type terms involved in II, III, IV tend to 0 as $\varepsilon \to 0$. Using Lemma [2,](#page-10-0) we get the bound

$$
\frac{1}{6}\int_{\mathbb{R}^2}|u|^3\leq C\|u\|_{L^2}^{3/2}\|u_x\|_{L^2}\|\partial_x^{-1}u_y\|_{L^2}^{1/2}\leq \frac{1}{4}\|u_x\|_{L^2}^2+\frac{1}{4}\|\partial_x^{-1}u_y\|_{L^2}^2+C\|u\|_{L^2}^6\,.
$$

We therefore obtain that

$$
|E(u)| \geq \frac{1}{4} ||u_x||_{L^2}^2 + \frac{1}{4} ||\partial_x^{-1} u_y||_{L^2}^2 - C||u||_{L^2}^6.
$$

Integrating ([33](#page-12-0)) on $(0, t)$ for $t \in (0, T]$ gives

$$
|E(u^{\varepsilon}(t)) - E(u^{\varepsilon}(0))| \leq \int_0^t \left((\|\psi_x\|_{L^{\infty}} + \|\psi_y\|_{L^{\infty}}) (|E(u^{\varepsilon}(\tau))| + \|u^{\varepsilon}(\tau)\|_{L^2}^6) + (\|\psi_{xxx}\|_{L^{\infty}} + \|\psi_y\|_{L^{\infty}}) |u^{\varepsilon}(\tau)|_{L^2}^2 \right) d\tau + \int_0^t |A^{\varepsilon}(\tau)| d\tau,
$$

where $\lim_{\varepsilon\to 0} A_{\varepsilon}(\tau) = 0$ for every $\tau \in [0, t]$ ($A_{\varepsilon}(\tau)$ corresponds to I and the commutator terms involved in II, III, IV). Passing to the limit $\varepsilon \to 0$, we infer that

$$
|E(u(t))| - |E(\phi)| \leq \int_0^t \left((\|\psi_x\|_{L^\infty} + \|\psi_y\|_{L^\infty})(|E(u(\tau))| + \|u(\tau)\|_{L^2}^6) + (\|\psi_{xxx}\|_{L^\infty} + \|\psi_y\|_{L^\infty})|u(\tau)\|_{L^2}^2 \right) d\tau.
$$

By the Gronwall lemma and [\(30](#page-12-0)), it follows that

$$
|E(u(t))| \lesssim \exp(C t)|E(\phi)| + g(t).
$$

where $g(t)$ is an increasing bijection of \mathbb{R}_+ which depends only on $\|\phi\|_{L^2}$.

We now turn to the bound on $F^{\psi}(u(t))$. It is worth noticing that

$$
F^{\psi}(u) = F(u) - \frac{5}{3} \int_{\mathbb{R}^2} \psi u \, \partial_x^{-2} u_{yy} - \frac{5}{6} \int_{\mathbb{R}^2} \psi (\partial_x^{-1} u_y)^2
$$

,

where F is the corresponding conservation law of the KP-I equation (see [\[26\]](#page-40-0)). The introduction of two additional terms in F^{ψ} is the main new idea in this paper. Indeed, if we multiply [\(32](#page-12-0)) by the multiplier used in[[26](#page-40-0)], we obtain terms which can not be treated as remainders (see A_1 and A_2 below). The term

$$
-\frac{5}{3}\int_{\mathbb{R}^2}\psi u\,\partial_x^{-2}u_{yy}
$$

is introduced in the definition of F^{ψ} in order to cancel such "bad" remainders. The second additional term in the definition of F^{ψ} is needed for the proof of the continuous dependence of the flow map on the space Z.

As in[[26](#page-40-0)], a difficulty in the sequel comes from the fact that the variational derivative $(F^{\psi})'(v)$ contains a term $c\partial_x^{-2}\partial_{yy}(v^2+2\psi v)$. Recall that the formal derivation of the conservation laws consists in multiplying the KP-I equation with $F'(u)$ where u is a solution. This procedure meets a difficulty since ∂_x^{-2} acts only on functions

with zero x mean value which is not a priori the case of $v^2 + 2\psi v$. We overcome this difficulty by introducing the functional $F^{\psi,\varepsilon}$ defined by

-3\int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_x - (\psi u^{\varepsilon})_x] u_{4x}^{\varepsilon}
$$

$$
= 3\int_{\mathbb{R}^2} u_{3x}^{\varepsilon} (2\psi_x u_x^{\varepsilon} + \psi_{xx} u^{\varepsilon} + \psi u_{xx}^{\varepsilon})
$$

$$
-3\int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_x - (\psi u^{\varepsilon})_x] u_{4x}^{\varepsilon}
$$

$$
= -\frac{15}{2} \int_{\mathbb{R}^2} \psi_x |u_{xx}^{\varepsilon}|^2 + \frac{9}{2} \int_{\mathbb{R}^2} \psi_{3x} |u_x^{\varepsilon}|^2 - 3 \int_{\mathbb{R}^2} \psi_{3x} u^{\varepsilon} u_{xx}^{\varepsilon}
$$

$$
-3\int_{\mathbb{R}^2} [\varphi^{\varepsilon} * (\psi u)_x - (\psi u^{\varepsilon})_x] u_{4x}^{\varepsilon}
$$

All other terms in the representation of VII can be treated similarly. This achieves the proof of Lemma [3](#page-15-0).

Now, since

$$
\Big|\frac{5}{6}\int_{\mathbb{R}^2}[\varphi^\varepsilon*(u^2+2\psi u)]\partial_x^{-2}u^\varepsilon_{yy}\Big|\leq C(\|u\|_{L^4}^4+\|u\|_{L^2}^2\|\psi\|_{L^\infty}^2)+\frac{5}{12}\|\partial_x^{-2}u^\varepsilon_{yy}\|_{L^2}^2,
$$

there exists a constant $C > 0$ such that for ε small enough,

(37)
$$
F^{\psi,\varepsilon}(u(t)) \geq \frac{5}{24} ||\partial_x^{-2} u_{yy}^{\varepsilon}(t)||_{L^2}^2 - C, \quad \forall t \in [0,T].
$$

We thus deduce from Lemma [3](#page-15-0) and (37) that

(38)
$$
\frac{d}{dt}F^{\psi,\varepsilon}(u(t)) \lesssim \|\psi\|_{W^{3,\infty}}|F^{\psi,\varepsilon}(u(t))| + R_{\psi}(u^{\varepsilon}) + \Lambda_{\varepsilon}(t)
$$

where R_{ψ} is continuous on X and $|\Lambda_{\varepsilon}|_1 \to 0$ as $\varepsilon \to 0$ uniformly for $t \in [0, T]$. Here we used that thanks to Lemma [2,](#page-10-0)

$$
\|\partial_x^{-1} u^\varepsilon_y\|_{L^4} \lesssim \|\partial_x^{-1} u^\varepsilon_y\|_{L^2}^{1/4} \|u^\varepsilon_y\|_{L^2}^{1/2} \|\partial_x^{-2} u^\varepsilon_{yy}\|_{L^2}^{1/4}
$$

and

$$
\|u_{x}^{\varepsilon}\|_{L^{4}}\lesssim\|u_{x}^{\varepsilon}\|_{L^{2}}^{1/4}\|u_{xx}^{\varepsilon}\|_{L^{2}}^{1/2}\|u_{y}^{\varepsilon}\|_{L^{2}}^{1/4}
$$

and thus,

$$
\begin{array}{ccc} \left. \int_{\mathbb{R}^2} \left| \psi u_x^\varepsilon u^\varepsilon (\partial_x^{-2} u_{yy}^\varepsilon) \right| & \lesssim & \|\psi\|_{L^\infty} \|u^\varepsilon\|_{L^4} \|u_x^\varepsilon\|_{L^4} \|\partial_x^{-2} u_{yy}^\varepsilon\|_{L^2} \\ & \lesssim & |F^{\psi,\varepsilon}(u)| + R_\psi(u^\varepsilon) \end{array}
$$

and in the same way

$$
\begin{array}{lcl} \displaystyle\int_{\mathbb{R}^2} \Big| \psi (\partial_x^{-1} u^\varepsilon_y) u^\varepsilon u^\varepsilon_y \Big| &\lesssim & \displaystyle\| \psi \|_{L^\infty} \| u^\varepsilon \|_{L^4} \| u^\varepsilon_x \|_{L^4} \| \partial_x^{-1} u^\varepsilon_y \|_{L^4} \| u^\varepsilon_y \|_{L^4} \\ &\lesssim & \displaystyle| F^{\psi,\varepsilon} (u)| + R_\psi (u^\varepsilon) \end{array}
$$

Hence,

(39)
$$
|F^{\psi,\varepsilon}(u(t))| \lesssim \exp(Ct)|F^{\psi,\varepsilon}(\phi)| + \exp(Ct).
$$

Letting ε tends to 0, $F^{\psi,\varepsilon}(\phi) \to F^{\psi}(\phi) < \infty$ and thus

$$
\sup_{t \in [0,T], \, \varepsilon > 0} F^{\psi,\varepsilon}(u(t)) \lesssim 1.
$$

¿From [\(37\)](#page-21-0), one infers

$$
\sup_{t\in[0,T],\,\varepsilon>0}\Big|\varphi^\varepsilon*\partial_x^{-2}u_{yy}(t)\Big|_2\lesssim 1
$$

and thus

$$
\partial_x^{-2} u_{yy} \in L^{\infty}(0,T;L^2(\mathbb{R}^2)) ,
$$

by the Lebesgue theorem. It is then easy to check that

$$
F^{\psi,\epsilon}(u(t)) \longrightarrow_{\varepsilon \to 0} F^{\psi}(u(t)), \quad t \in [0,T].
$$

and thus [\(27](#page-10-0)) follows from (39). This completes the proof of Proposition [3](#page-10-0). \Box

It follows from ([37\)](#page-21-0) and the Lebesgue theorem that, for $u \in C([0,T]; H^{\infty}_{-1}(\mathbb{R}^2))$, $\partial_x^{-2} u_{yy}^{\varepsilon}$ tends to $\partial_x^{-2} u_{yy}$ in $L^{\infty}([0,T]; L^2(\mathbb{R}^2))$. Therefore we can pass to the limit in ε in Lemma [3](#page-15-0) which leads to the next Proposition.

Proposition 4. Let $u \in C([0, T]; H_{-1}^{\infty}(\mathbb{R}^2))$ then

$$
(40) \t\t\t\t\t ||u(t)||_Z \lesssim g(t) ,
$$

where g is an increasing continuous one to one mapping of \mathbb{R}_+ only depending on $||u(0)||_Z$. Moreover,

(41)
\n
$$
F^{\psi}(u(t)) - F^{\psi}(u(0)) = -\frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi_x (\partial_x^{-2} u_{yy}) u_{xx} + \frac{5}{6} \int_0^t \int_{\mathbb{R}^2} \psi (\partial_x^{-2} u_{yy}) ((u)^2 + 2\psi u)_x + \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi u (\partial_x^{-2} u_{yy}) + \frac{5}{3} \int_{\mathbb{R}^2} (\psi u)_x u (\partial_x^{-2} u_{yy}) + \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi_y (\partial_x^{-1} u_y) (\partial_x^{-2} u_{yy}) + \int_0^t G_{\psi}(u),
$$

where G_{ψ} is continuous on X.

4. Dispersive estimates

Let us first extend some linear dispersive estimates established in[[28\]](#page-40-0) for antiderivatives in x of the free group of KP. A similar argument was used in [\[25](#page-40-0)]. Let

$$
U(t) := \exp(-t(\partial_x^3 - \partial_x^{-1}\partial_y^2))
$$

be the unitary group on $H^s(\mathbb{R}^2)$ defining the free KP-I evolution. Let D_x be the Fourier multiplier with symbol $|\xi|$. Then we have the following Strichartz inequality for the free KP-I evolution.

Lemma 4. Let $T > 0$. Then for every $0 \le \varepsilon \le 1/2$, we have the estimates

(42)
$$
\|D_x^{-\frac{\varepsilon \delta(r)}{2}}U(t)\phi\|_{L_T^q L_{xy}^r} \lesssim \|\phi\|_{L^2},
$$

and

(43)
$$
\left\| \int_0^t D_x^{-\frac{\varepsilon \delta(r)}{2}} U(t-t') F(t') dt' \right\|_{L_T^q L_{xy}^r} \lesssim \|F\|_{L_T^1 L_{xy}^2},
$$

provided $r \in [2,\infty]$, and

$$
0 \le \frac{2}{q} = (1 - \varepsilon/3) \, \delta(r) < 1
$$

with

$$
\delta(r) := 1 - \frac{2}{r} .
$$

Proof. Since $U(t)$ and D_x commute, using the Minkowski inequality, we obtain that (43) follows from (42). Let us now turn to the proof of (42). For $r = 2$, (42) follows from the unitarity of $U(t)$ on $L^2(\mathbb{R}^2)$. It suffices thus to prove it for $r = \infty$ Let us set

$$
G(x,y,t):=\int_{\mathbb{R}^2}e^{it(x\xi+y\eta)}\,e^{it(\xi^3-\eta^2/\xi)}\,d\xi\,d\eta\,.
$$

Then

$$
U(t)\phi = G(\cdot,\cdot,t) \star \phi,
$$

where \star denotes the convolution with respect to the spatial variables x and y. Integrating a gaussian integral with respect to η (see [\[28](#page-40-0)]), we get for $0 \leq \varepsilon \leq 1/2$,

$$
||D_x^{-\varepsilon} G(x,y,t)||_{L_{xy}^{\infty}} \lesssim |t|^{-1/2} \sup_{x \in \mathbb{R}} \left| \int_0^{\infty} |\xi|^{\frac{1}{2}-\varepsilon} e^{i(t\xi^3 + x\xi)} d\xi \right|.
$$

Next using the Van der Corput lemma as in [\[20](#page-40-0)], we infer that

$$
||D_x^{-\varepsilon}G(x,y,t)||_{L^\infty_{xy}} \lesssim ||t|^{-1+\varepsilon/3}
$$

and thus

(44)
$$
||D_x^{-\varepsilon}U(t)\,\phi||_{L_{xy}^{\infty}} \lesssim |t|^{-1+\varepsilon/3}||\phi||_{L_{xy}^1}
$$

which is the key dispersive inequality. Let us now perform the duality argument which provides ([42\)](#page-23-0) for $r = \infty$ as a consequence of the dispersive inequality (44). We first fix the q corresponding to $r = \infty$, i.e.

$$
\frac{2}{q} = 1 - \frac{\varepsilon}{3}.
$$

Set

$$
A := D_x^{-\varepsilon/2} U(t) \, .
$$

Our goal is to show that A is bounded from L_{xy}^2 to $L_T^q L_{xy}^{\infty}$. Denote by A^* the operator formally adjoint to A. Then

$$
AA^*(f) = \int_0^T D_x^{-\varepsilon} U(t-t')f(t')dt'.
$$

Using the dispersive estimate (44) and the Hardy-Littlewood inequality in time, we infer that

(45)
$$
||AA^*(f)||_{L_T^q L_{xy}^{\infty}} \lesssim ||f||_{L_T^{q'} L_{xy}^1},
$$

where q' is the conjugate of q , i.e.

$$
\frac{1}{q} + \frac{1}{q'} = 1\,.
$$

Recall that L_{xy}^{∞} can be seen as the dual space of L_{xy}^1 . It is not true that $L_T^{q'} L_{xy}^1$ can be seen as the dual of $L_T^q L_{xy}^{\infty}$ but however, it is easy to see that for $q < \infty$, we can write

(46)
$$
||Af||_{L_T^q L_{xy}^{\infty}} = \sup_{||g||_{L_T^{q'} L_{xy}^1} \le 1} |\langle Af, g \rangle|
$$

where $\langle \cdot, \cdot \rangle$ denotes the $L_T^2 L_{xy}^2$ inner product. Let us next write by the Cauchy-Schwarz inequality

(47)
$$
|\langle Af, g \rangle| = |(f, A^*g)| \le ||f||_{L^2_{xy}} ||A^*g||_{L^2_{xy}},
$$

where (\cdot, \cdot) denotes the L_{xy}^2 inner product. Next, using (45), we obtain

$$
||A^{\star}g||_{L_{xy}^2}^2 = (A^{\star}g, A^{\star}g) = \langle AA^{\star}(g), g \rangle \le ||AA^{\star}(g)||_{L_T^q L_{xy}^{\infty}} ||g||_{L_T^{q'} L_{xy}^1} \le C ||g||_{L_T^{q'} L_{xy}^1}^2.
$$

Coming back to (46) and (47) ends the proof of [\(42](#page-23-0)) for $r = \infty$. This completes the proof of Lemma 4. proof of Lemma [4](#page-23-0).

We next state the crucial dispersive estimate.

Proposition 5. Let $v \in C([0,T]; H_{-1}^{\infty}(\mathbb{R}^2))$ be a solution of

(48)
$$
v_t + v_{xxx} - \partial_x^{-1} v_{yy} = F_x \quad .
$$

Then for every $\varepsilon > 0$ there exists C_{ε} such that

(49)
$$
||v||_{L_T^1 L_{xy}^{\infty}} \leq C_{\varepsilon} (1+T) ||J_x^{1/2+\varepsilon} v||_{L_T^{\infty} L_{xy}^2} + C_{\varepsilon} ||J_x^{1/2+\varepsilon} F||_{L_T^1 L_{xy}^2}
$$

Proof. We consider a Littlewood-Paley decomposition in the x-variable

$$
v = \sum_{\lambda\ - \rm dyadic} v_\lambda
$$

where $v_{\lambda} := \Delta_{\lambda} v$ and the Fourier multipliers Δ_{λ} are defined as follows:

$$
\widehat{\Delta_\lambda v}(t,\xi,\eta):=\left\{\begin{array}{ll}\varphi(\frac{\xi}{\lambda})\,\hat v(t,\xi,\eta), & \lambda=2^k,\, k\geq 1,\\ \chi(\xi)\,\hat v(t,\xi,\eta), & \lambda=1,\end{array}\right.
$$

wherethe nonnegative functions $\chi \in C_0^{\infty}(\mathbb{R})$ and $\varphi \in C_0^{\infty}(\mathbb{R}^*)$ are defined as in [[22\]](#page-40-0). For $\lambda \geq 2$ fixed we write a natural splitting

$$
[0,T]=\bigcup_j I_j
$$

where $I_j = [a_j, b_j]$ are with disjoint interiors and $|I_j| \leq \lambda^{-1}$. Clearly, we can suppose that the number of the intervals I_j is bounded by $C(1+T)\lambda$. Using the Hölder inequality in time, we can write

$$
||v_\lambda||_{L_T^1 L_{xy}^\infty} \lesssim \sum_j ||v_\lambda||_{L_{I_j}^1 L_{xy}^\infty} \lesssim \lambda^{-\frac{1}{2}-\frac{\varepsilon}{6}} \sum_j ||v_\lambda||_{L_{I_j}^{q_\varepsilon} L_{xy}^\infty},
$$

where $1/q_{\varepsilon} = 1/2 - \varepsilon/6$. Next, we apply the Duhamel formula in each I_j to obtain on I_i ,

$$
v_{\lambda}(t) = D_x^{-\varepsilon/2} U(t - a_j) D_x^{\varepsilon/2} v_{\lambda}(a_j) - \int_{a_j}^t D_x^{-\varepsilon} U(t - t') [\Delta_{\lambda} D_x^{\varepsilon} \partial_x F](t') dt'
$$

Using the Strichartz estimates established in Lemma [4](#page-23-0), it yields

$$
||v_\lambda||_{L_{I_j}^{q_\varepsilon}L_{xy}^\infty} \lesssim ||D_x^{\varepsilon/2}v_\lambda(a_j)||_{L^2} + ||\Delta_\lambda D_x^{1+\varepsilon}F||_{L_{I_j}^1L_{xy}^2}.
$$

Therefore

$$
\|v_\lambda\|_{L_{I_j}^1 L_{xy}^\infty} \lesssim \lambda^{-1/2+\varepsilon/3} \|v_\lambda(a_j)\|_{L^2} + \lambda^{1/2+5\varepsilon/6} \|\Delta_\lambda F\|_{L_{I_j}^1 L_{xy}^2}
$$

and summing over j ,

(50)
$$
\|v_{\lambda}\|_{L_T^1 L_{xy}^{\infty}} \lesssim \lambda^{-1/2 + \varepsilon/3} \sum_j \|v_{\lambda}\|_{L_T^{\infty} L_{xy}^2} + \lambda^{1/2 + 5\varepsilon/6} \|\Delta_{\lambda} F\|_{L_T^1 L_{xy}^2}
$$

$$
\lesssim \lambda^{1/2 + \varepsilon/3} (1+T) \|v_{\lambda}\|_{L_T^{\infty} L_{xy}^2} + \lambda^{1/2 + 5\varepsilon/6} \|\Delta_{\lambda} F\|_{L_T^1 L_{xy}^2}
$$

.

Moreover, again by Duhamel formula and Strichartz estimates

(51)
$$
\|\Delta_1 v\|_{L^1_T L^\infty} \lesssim (1+T) \Big(\|\Delta_1 v(0)\|_{L^2_{xy}} + \|\Delta_1 F\|_{L^1_T L^2_{xy}} \Big)
$$

Hence, by Minkowski and Bernstein inequalities and (50)-(51), for any

 $0 < \alpha, \varepsilon \ll 1$,

we get

$$
\|v\|_{L_T^1 L_{xy}^\infty} \leq \sum_{\lambda} \|v_\lambda\|_{L_T^1 L_{xy}^\infty}
$$

\n
$$
\leq \|\Delta_1 v\|_{L_T^1 L_{xy}^\infty} + \sum_{\lambda \geq 2} \lambda^{-\alpha} \lambda^{\alpha} \|v_\lambda\|_{L_T^1 L_{xy}^\infty}
$$

\n
$$
\leq \|\Delta_1 v\|_{L_T^1 L_{xy}^\infty} + \sup_{\lambda \geq 2} \lambda^{\alpha} \|v_\lambda\|_{L_T^1 L_{xy}^\infty}
$$

\n
$$
\leq (1+T) \|J_x^{\alpha+1/2+\varepsilon/3} v\|_{L_T^\infty L_{xy}^2} + \|J_x^{\alpha+1/2+5\varepsilon/6} F\|_{L_T^1 L_{xy}^2}.
$$

This completes the proof of Proposition [5](#page-25-0).

5. A first global existence result

In this section, we use the dispersive estimates of the previous section and the a priori bounds of Section 3 to show that the local solutions with $H_{-1}^{\infty}(\mathbb{R}^2) \cap Z$ data, obtained in Section 2 are in fact global in time.

Proposition 6. Let $\phi \in H^{\infty}_{-1}(\mathbb{R}^2) \cap Z$. Then there exists a unique global solution u of [\(6\)](#page-5-0) with initial data ϕ , such that

$$
u \in C(\mathbb{R}_+; H^{\infty}_{-1}(\mathbb{R}^2)) \cap L^{\infty}_{loc}(\mathbb{R}_+; Z), \quad u_t \in C(\mathbb{R}_+; H^{\infty}_{-1}(\mathbb{R}^2)).
$$

Proof. From the local theory of Proposition [1](#page-5-0) and Proposition [2](#page-9-0) to prove that the local solution u can be extended on \mathbb{R}_+ , it suffices to show that $\|\nabla_{x,y}u(t)\|_{L^\infty}$ can not go to infinity in finite time. From the propagation of regularity obtained in Proposition [1](#page-5-0) and Proposition [4](#page-22-0), we deduce that u is bounded in Z as long as it exists. Unfortunately $\|\nabla_{x,y}u\|_{L^{\infty}}$ is not controlled by $\|u\|_Z$ for an arbitrary function u. But thanks to the key Proposition [5](#page-25-0) will be able to control $\|\nabla_{x,y}u\|_{L^{\infty}}$ whenever u is a solution of (6) (6) (6) . This is the crucial dispersive effect in our analysis.

According to [\[16](#page-39-0)] and ([\[21](#page-40-0)], Theorem A.12), we have the following generalizations of the Leibniz rule.

Lemma 5. Let $1 < p < \infty$. Then for $s > 0$,

$$
||J^{s}(fg)||_{L^{p}(\mathbb{R}^{n})} \lesssim ||J^{s}f||_{L^{p}(\mathbb{R}^{n})} ||g||_{L^{\infty}(\mathbb{R}^{n})} + ||f||_{L^{\infty}(\mathbb{R}^{n})} ||J^{s}g||_{L^{p}(\mathbb{R}^{n})}
$$

and for $0 < s < 1$,

$$
||J^s(fg)||_{L^p(\mathbb{R})}\lesssim ||J^sf||_{L^\infty(\mathbb{R})}||g||_{L^p(\mathbb{R})}+||f||_{L^\infty(\mathbb{R})}||J^sg||_{L^p(\mathbb{R})}
$$

Proposition [5](#page-25-0) yields the following estimates on smooth solutions to [\(24\)](#page-9-0).

Lemma 6. For every $0 < \varepsilon \ll 1$ there exists C_{ε} such that if $u \in C([0, T]; H^{\infty}_{-1}(\mathbb{R}^2))$ is a solution to [\(6\)](#page-5-0) then

$$
(52)\|u_x\|_{L^1_T L^\infty_{xy}} \lesssim C_{\varepsilon} \Big(1+T+\|u\|_{L^1_T L^\infty_{xy}}+T\big(\|J_x^{\frac{3}{2}+\varepsilon}\psi\|_{L^\infty}+\|\psi\|_{L^\infty}\big)\Big)\|J_x^{\frac{3}{2}+\varepsilon}u\|_{L^\infty_T L^2_{xy}}
$$

and

$$
\|u_y\|_{L_T^1 L_{xy}^\infty} \leq C_{\varepsilon} (1+T) \|J_x^{\frac{1}{2}+\varepsilon} u_y\|_{L_T^\infty L_{xy}^2} + C_{\varepsilon} T (\|J_x^{\frac{1}{2}+\varepsilon} \psi_y\|_{L^\infty} + \|\psi_y\|_{L^\infty}) \|J_x^{\frac{1}{2}+\varepsilon} u\|_{L_T^\infty L_{xy}^2} + C_{\varepsilon} T (\|J_x^{\frac{1}{2}+\varepsilon} \psi\|_{L^\infty} + \|\psi\|_{L^\infty}) \|J_x^{\frac{1}{2}+\varepsilon} u_y\|_{L_T^\infty L_{xy}^2} + C_{\varepsilon} (\|u\|_{L_T^1 L_{xy}^\infty} + \|J_x^{1/2+\varepsilon} u\|_{L_T^1 L_{xy}^\infty}) \|J_x^{\frac{1}{2}+\varepsilon} u_y\|_{L_T^\infty L_{xy}^2}.
$$

Proof. We have that u_x satisfies ([48\)](#page-25-0) with

$$
F = \partial_x(\psi u + u^2/2).
$$

Estimate (52) follows from ([49](#page-25-0)) and Lemma 5 applied in the x variable. More precisely, for a fixed t, y , we have that

$$
||J_x^{\frac{1}{2}+\varepsilon} \partial_x(\psi u)||_{L_x^2} = ||J_x^{\frac{1}{2}+\varepsilon} (\psi_x u + \psi u_x)||_{L_x^2} \lesssim (||\psi||_{L_x^{\infty}} + ||J_x^{\frac{3}{2}+\varepsilon} \psi||_{L_x^{\infty}}) ||J_x^{\frac{3}{2}+\varepsilon} u||_{L_x^2}
$$

where we use that $||J_x^{\frac{1}{2}+\varepsilon}\psi||_{L_x^{\infty}} \lesssim ||\psi||_{L_x^{\infty}} + ||J_x^{\frac{3}{2}+\varepsilon}\psi||_{L_x^{\infty}}$ (see Lemma [7](#page-28-0) below). Taking the $L_T^1 L_y^2$ norm of the last inequality gives

$$
||J_x^{\frac{1}{2}+\varepsilon}\partial_x(\psi u)||_{L_T^1L_{xy}^2} \lesssim T(||J_x^{\frac{3}{2}+\varepsilon}\psi||_{L^\infty} + ||\psi||_{L^\infty})||J_x^{\frac{3}{2}+\varepsilon}u||_{L_T^\infty L_{xy}^2}.
$$

Further, for a fixed t, y , Lemma 5 yields

$$
||J_x^{\frac{1}{2}+\varepsilon}\partial_x(u^2/2)||_{L_x^2} \lesssim ||u||_{L_x^{\infty}}||J_x^{\frac{3}{2}+\varepsilon}u||_{L_x^2}.
$$

Taking the $L_T^1 L_y^2$ norm gives

$$
||J_x^{\frac{1}{2}+\varepsilon}\partial_x(u^2/2)||_{L_T^1L_{xy}^2} \lesssim ||u||_{L_T^1L_{xy}^{\infty}}||J_x^{\frac{3}{2}+\varepsilon}u||_{L_T^{\infty}L_{xy}^2}.
$$

This proves that [\(52](#page-27-0)) follows from [\(49\)](#page-25-0). We next estimate u_y . Notice that u_y satisfies [\(48](#page-25-0)) with

$$
F = \partial_y(\psi u + u^2/2).
$$

Using Lemma 5, we obtain
\n
$$
||J_x^{1/2+\varepsilon}\partial_y(\psi u + u^2/2)||_{L_T^1L_{xy}^2} = ||J_x^{1/2+\varepsilon}(\psi_y u + \psi u_y + uu_y)||_{L_T^1L_{xy}^2}
$$
\n
$$
\leq T(||J_x^{\frac{1}{2}+\varepsilon}\psi_y||_{L^\infty} + ||\psi_y||_{L^\infty})||J_x^{\frac{1}{2}+\varepsilon}u||_{L_T^\inftyL_{xy}^2}
$$
\n
$$
+T(||J_x^{\frac{1}{2}+\varepsilon}\psi||_{L^\infty} + ||\psi||_{L^\infty})||J_x^{\frac{1}{2}+\varepsilon}u_y||_{L_T^\inftyL_{xy}^2}
$$
\n
$$
+ ||u||_{L_T^1L_{xy}^\infty}||J_x^{\frac{1}{2}+\varepsilon}u_y||_{L_T^\inftyL_{xy}^2} + ||J_x^{\frac{1}{2}+\varepsilon}u||_{L_T^1L_{xy}^\infty}||u_y||_{L_T^\inftyL_{xy}^2}
$$

which implies [\(53](#page-27-0)). This completes the proof of Lemma [6.](#page-27-0) \Box

In order to control $||J_x^{\frac{1}{2}+\varepsilon}u||_{L_T^1L_x^{\infty}}$ we will need the following lemma. **Lemma 7.** For every $0 < s < 1$ there exists C such that for every $u \in L^{\infty}_{xy}$ satisfying $u_x \in L^{\infty}_{xy}$ one has the estimate

$$
||J_x^s u||_{L_{xy}^{\infty}} \leq C(||u||_{L_{xy}^{\infty}} + ||u_x||_{L_{xy}^{\infty}}).
$$

Proof. Consider a Littlewood-Paley decomposition with respect to the x variable

$$
u = \sum_{\lambda - dyadic} \Delta_{\lambda} u.
$$

We have that $J_x^s \Delta_1$ is bounded on L_{xy}^{∞} . Moreover one can directly check that there exists $C > 0$ such that for every $\lambda \geq 2$,

$$
\lambda \|\Delta_{\lambda} u\|_{L^{\infty}_{xy}} \leq C \|u_x\|_{L^{\infty}_{xy}}.
$$

Therefore using the triangle inequality and the Bernstein inequality, we obtain that

$$
||J_x^s u||_{L_{xy}^{\infty}} \leq ||J_x^s \Delta_1 u||_{L_{xy}^{\infty}} + \sum_{\lambda \geq 2} ||J_x^s \Delta_\lambda u||_{L_{xy}^{\infty}}
$$

\n
$$
\lesssim ||u||_{L_{xy}^{\infty}} + \sum_{\lambda \geq 2} \lambda^s ||\Delta_\lambda u||_{L_{xy}^{\infty}}
$$

\n
$$
\lesssim ||u||_{L_{xy}^{\infty}} + \sum_{\lambda \geq 2} \lambda^{s-1} ||u_x||_{L_{xy}^{\infty}}
$$

\n
$$
\lesssim ||u||_{L_{xy}^{\infty}} + ||u_x||_{L_{xy}^{\infty}}.
$$

This completes the proof of Lemma [7](#page-28-0).

Let us now return to the proof of Proposition [6.](#page-26-0) Noticing that $||u||_{L^{\infty}}$ is controlled by $||u||_Z$, using [\(52](#page-27-0)) with $\varepsilon = 1/2$ and Proposition [4,](#page-22-0) we obtain the existence of an increasing continuous function⁴ g_1 from \mathbb{R}_+ to \mathbb{R}_+ such that

(54)
$$
||u_x||_{L_T^1 L_{xy}^{\infty}} \le g_1(T)
$$

as long as $u(t)$ exists. Notice that, thanks to Lemma [7,](#page-28-0) estimate (54) also provides a bound for

$$
||J_x^s u||_{L_T^1 L_{xy}^{\infty}}, \quad 0 < s < 1.
$$

Next, using ([13\)](#page-6-0) and [\(14](#page-7-0)) and the Gronwall lemma, we obtain that for every integer s

(55)
$$
\|\partial_x^s u(t,\cdot)\|_{L^2} \le \|\partial_x^s \phi\|_{L^2} \exp\left(\|u_x\|_{L^1_t L^\infty_{x,y}} + t \|\psi\|_{W^{s,\infty}}\right).
$$

Therefore using Proposition [4](#page-22-0) to bound $||u(t, \cdot)||_{L^2}$ we obtain that there exists an increasing continuous function g_2 from \mathbb{R}_+ to \mathbb{R}_+ such that

(56)
$$
||J_x^4u(t, \cdot)||_{L_{xy}^2} \le g_2(t)
$$

as long as $u(t)$ exists. Noticing that

$$
\|J_x^{1/2+\varepsilon}u_y\|_{L^2}^2 = \|u_y\|_{L^2_{xy}} + \||\xi|^{1/2+\varepsilon} \eta \,\hat{u}(\xi,\eta)\|_{L^2_{\xi\eta}}^2
$$

$$
= \|u_y\|_{L^2_{xy}} + \||\xi|^{3/2+\varepsilon} |\xi|^{-1} \eta \,\hat{u}(\xi,\eta)\|_{L^2_{\xi\eta}}^2
$$

$$
\lesssim \|u_y\|_{L^2_{xy}} + \|J_x^4 u\|_{L^2_{xy}} \|\partial_x^{-2} u_{yy}\|_{L^2_{xy}}
$$

we deduce from (56) , (53) (53) , (54) , Lemma [7](#page-28-0) and Proposition [4](#page-22-0) that there exists an increasing continuous function g_3 from \mathbb{R}^+ to \mathbb{R}_+ such that

$$
||u_y||_{L^1_T L^\infty_{xy}} \lesssim g_3(t)
$$

Therefore $\|\nabla_{x,y} u\|_{L_T^1 L_{xy}^\infty}$ can not go to infinity in finite time T. Thanks to the wellposedness Proposition $\tilde{1}$ we deduce that u can be extended on the whole real axis which completes the proof of Proposition [6](#page-26-0). \Box

⁴The important point is that this function does not go to infinity in finite time.

6. WELL-POSEDNESS IN $H^{2,0}(\mathbb{R}^2)$

The next two sections are devoted to the global well-posedness of (5) (5) (5) in Z , i.e. we remove the condition $\phi \in H^{\infty}_{-1}(\mathbb{R}^2)$ of Proposition [6.](#page-26-0) A considerable part of the analysis will be devoted to the continuous dependence with respect to time and the initial data. For $s \in \mathbb{R}$, we denote by $H^{s,0}(\mathbb{R}^2)$ the anisotropic Sobolev spaces equipped with the norm

$$
||u||_{H^{s,0}(\mathbb{R}^2)} = ||J_x^s u||_{L^2(\mathbb{R}^2)}
$$

For an integer $s \geq 0$ an equivalent norm in $H^{s,0}(\mathbb{R}^2)$ is given by

$$
||u||_{L^2(\mathbb{R}^2)} + ||\partial_x^s u||_{L^2(\mathbb{R}^2)}.
$$

We have the following well-posedness result.

Proposition 7. Let $\phi \in H^{2,0}(\mathbb{R}^2)$. Then there exists a unique positive T depending only on $\|\phi\|_{H^{2,0}}$ and a unique solution u of [\(5\)](#page-4-0) with initial data ϕ on the time interval $[0,T]$ satisfying

(57)
$$
u \in C([0,T]; H^{2,0}(\mathbb{R}^2)), \quad u_x \in L^1_T L^\infty_{xy}.
$$

Furthermore, the map $\phi \mapsto u_{\phi}$ is continuous from $H^{2,0}(\mathbb{R}^2)$ to $C([0,T]; H^{2,0}(\mathbb{R}^2))$.

6.1. Uniqueness. The uniqueness follows from the next lemma.

Lemma 8. Let u, v be two solutions of [\(5](#page-4-0)) in the class defined by (57). Then

$$
||u - v||_{L_T^{\infty} L_{xy}^2} \le \exp\Big(C||u_x||_{L_T^1 L_{xy}^{\infty}} + C||v_x||_{L_T^1 L_{xy}^{\infty}} + CT||\psi_x||_{L^{\infty}}\Big) ||u(0) - v(0)||_{L_{xy}^2}.
$$

Proof. We set

$$
w:=u-v\,.
$$

Further we define

$$
u^{\varepsilon} := \varphi^{\varepsilon} * u, \quad v^{\varepsilon} := \varphi^{\varepsilon} * v, \quad w^{\varepsilon} := \varphi^{\varepsilon} * w,
$$

where φ^{ε} is defined by ([31](#page-12-0)). Then w^{ε} solves the equation

$$
w_t^{\varepsilon} + w_{xxx}^{\varepsilon} - \partial_x^{-1} w_{yy}^{\varepsilon} + \frac{1}{2} \partial_x \big(w^{\varepsilon} (u+v) \big) + \partial_x (\psi w^{\varepsilon}) -
$$

-
$$
\partial_x \big(\big(\frac{1}{2} (u+v) + \psi \big) w^{\varepsilon} \big) + \varphi_x^{\varepsilon} * \big(\big(\frac{1}{2} (u+v) + \psi \big) w \big) = 0.
$$

Taking the L^2 scalar product of the last equation with w^{ε} gives

$$
\frac{1}{2}\frac{d}{dt}\|w^{\varepsilon}\|_{L^{2}(\mathbb{R}^{2})}^{2} = -\int_{\mathbb{R}^{2}} (u_{x}+v_{x})(w^{\varepsilon})^{2} - \frac{1}{2}\int_{\mathbb{R}^{2}} \psi_{x}(w^{\varepsilon})^{2} + \frac{1}{2}\int_{\mathbb{R}^{2}} \left(\partial_{x}[(u+v+2\psi)w^{\varepsilon}] - \varphi_{x}^{\varepsilon} * [(u+v+2\psi)w]\right)w^{\varepsilon}.
$$

Thus, by Gronwall Lemma,

$$
\begin{array}{lcl} \| w^{\varepsilon} \|_{L_{T}^{\infty} L_{xy}^{2}}^{2} & \lesssim & \exp \Bigl(C \| u_{x} \|_{L_{T}^{1} L_{xy}^{\infty}} + C \| v_{x} \|_{L_{T}^{1} L_{xy}^{\infty}} + C T \| \psi_{x} \|_{L^{\infty}} \Bigr) \Bigl[\| w^{\varepsilon}(0) \|_{L^{2}}^{2} \\ & & \qquad \qquad + \Bigl\| \partial_{x} [(u+v+2\psi) w^{\varepsilon}] - \varphi_{x}^{\varepsilon} \ast [(u+v+2\psi) w] \Bigr\|_{L_{T}^{1} L_{xy}^{2}} \| w^{\varepsilon} \|_{L_{T}^{\infty} L_{xy}^{2}} \Bigr] \end{array}
$$

Passing to the limit in $\varepsilon \to 0$, it follows from Lebesgue theorem and the assumptions on u and v that the commutator term in the right-hand side of the last inequality tends to 0. Thus

(58)
$$
||w||_{L_T^{\infty}L_{xy}^2}^2 \lesssim \exp\Big(C||u_x||_{L_T^1L_{xy}^{\infty}} + C||v_x||_{L_T^1L_{xy}^{\infty}} + CT||\psi_x||_{L^{\infty}}\Big) ||w(0)||_{L_{xy}^2}^2
$$

which completes the proof of Lemma [8.](#page-30-0) \Box

6.2. **Existence.** Let $\phi \in H^{2,0}(\mathbb{R}^2)$. We set

$$
\phi_\varepsilon:=\varphi^\varepsilon\ast\phi\,,
$$

where φ^{ε} are defined by ([31\)](#page-12-0). It is clear that $\phi_{\varepsilon} \in H^{\infty}_{-1} \cap Z$ and that $\phi_{\varepsilon} \to \phi$ in $H^{2,0}(\mathbb{R}^2)$. By Proposition [6](#page-26-0), the emanating solution u_{ε} is global in time and belongs to $C(\mathbb{R}_+; H_{-1}^{\infty})$. We will show that there exists $T = T(||\phi||_{H^{2,0}}) > 0$ such that the sequence $\{\partial_x u_{\varepsilon}\}\$ is bounded on $L_T^1 L_{xy}^{\infty}$. On the level of $H^{2,0}$ regularity we do not control the L_{xy}^{∞} norm. Using a Littlewood-Paley decomposition in the x variable and Lemma [7,](#page-28-0) we can however write

$$
\begin{array}{rcl} \|u_{\varepsilon}\|_{L_{T}^{1}L_{xy}^{\infty}} & \lesssim & \displaystyle \| \Delta_{1} u_{\varepsilon}\|_{L_{T}^{1}L_{xy}^{\infty}} + \sum_{\lambda \geq 2}\|u_{\varepsilon}\|_{L_{T}^{1}L_{xy}^{\infty}}\\ \\ & \lesssim & \displaystyle \| \Delta_{1} u_{\varepsilon}\|_{L_{T}^{1}L_{xy}^{\infty}} + \sum_{\lambda \geq 2}\lambda^{-1}\| \partial_{x} u_{\varepsilon}\|_{L_{T}^{1}L_{xy}^{\infty}}\\ \\ & \lesssim & \displaystyle \| \Delta_{1} u_{\varepsilon}\|_{L_{T}^{1}L_{xy}^{\infty}} + \| \partial_{x} u_{\varepsilon}\|_{L_{T}^{1}L_{xy}^{\infty}}\ . \end{array}
$$

Next, as in [\(51](#page-26-0)), Duhamel formula and Strichartz estimates of Proposition [4](#page-23-0) yield for $0 \leq T \leq 1$,

$$
\|\Delta_1 u_{\varepsilon}\|_{L^1_TL^\infty_{xy}} \lesssim \|\phi_{\varepsilon}\|_{L^2_{xy}} + \|\partial_x u_{\varepsilon}\|_{L^1_TL^\infty_{xy}} \|u_{\varepsilon}\|_{L^\infty_TL^2_{xy}} + \|\psi\|_{L^\infty} \|u_{\varepsilon}\|_{L^\infty_TL^2_{xy}}.
$$

Therefore, thanks to the L^2 control ([25](#page-10-0)) of Proposition [3](#page-10-0) we obtained that there exists a constant C depending on bounds on ψ and its derivatives in L^{∞} but independent of ϕ such that for $0 \leq T \leq 1$,

$$
||u_{\varepsilon}||_{L^{1}_{T}L^{\infty}_{xy}} \lesssim ||\phi_{\varepsilon}||_{L^{2}_{xy}} + (1+||\phi_{\varepsilon}||_{L^{2}_{xy}}) ||\partial_{x}u_{\varepsilon}||_{L^{1}_{T}L^{\infty}_{xy}}.
$$

Using ([13\)](#page-6-0) and [\(14\)](#page-7-0) with $s = 2$ we obtain that there exists a constant C depending on bounds on ψ and its derivatives in L^{∞} but independent of ϕ such that

(59)
$$
\frac{d}{dt} \|\partial_x^2 u_{\varepsilon}(t,\cdot)\|_{L^2}^2 \leq C \Big(\|\partial_x u_{\varepsilon}(t,\cdot)\|_{L^\infty} + C \Big) \|J_x^2 u_{\varepsilon}(t,\cdot)\|_{L^2(\mathbb{R}^2)}^2
$$

and therefore thanks to the L^2 bound on u_{ε} provided by Proposition [3](#page-10-0) and the Gronwall lemma, we obtain that

$$
||J_x^2 u_{\varepsilon}||_{L_T^{\infty} L_{xy}^2} \lesssim ||J_x^2 \phi_{\varepsilon}||_{L_{xy}^2} \exp(C ||\partial_x u_{\varepsilon}||_{L_T^1 L_{xy}^{\infty}} + C T)
$$

Let us set

$$
f(T):=\|u_\varepsilon\|_{L^1_TL^\infty_{xy}}+\|\partial_x u_\varepsilon\|_{L^1_TL^\infty_{xy}}\,.
$$

We deduce from the last estimates and ([52\)](#page-27-0) that for $0 \le T \le 1$,

(60)
$$
f(T) \lesssim (1 + ||\phi_{\varepsilon}||_{L_{xy}^2}) ||\partial_x u_{\varepsilon}||_{L_T^1 L_{xy}^{\infty}} + ||\phi_{\varepsilon}||_{L_{xy}^2}
$$

$$
\lesssim ||J_x^2 \phi_{\varepsilon}||_{L_{xy}^2} (1 + ||\phi_{\varepsilon}||_{L_{xy}^2}) \exp(Cf(T)).
$$

We notice that for $\alpha > 0$ small enough the continuous map

$$
g: y \longmapsto y - \alpha \exp(Cy)
$$

satisfies $g(0) < 0$ and that $g(y_0) = 0$ for some $0 < y_0 < 1$. Since

$$
T \longmapsto f(T)
$$

is continuous and satisfies $f(0) = 0$ and (60), we deduce that for

$$
||J_x^2 \phi_{\varepsilon}||_{L^2_{xy}}(1+||\phi_{\varepsilon}||_{L^2_{xy}})
$$

small enough, $0 \le f(T) \le 1$ for all $T \in [0,1]$. Therefore, if $||J_x^2 \phi||_{L^2} \ll 1$ then for $0\leq T\leq 1,$

(61)
$$
||u_{\varepsilon}||_{L_T^1 L_{xy}^{\infty}} + ||\partial_x u_{\varepsilon}||_{L_T^1 L_{xy}^{\infty}} \leq 1.
$$

We next use a scaling argument to show that a bound of type (61) holds for $||J_x^2\phi||_{L^2}$ of an arbitrary size. Notice that $u(t, x, y)$ is a solution of

$$
(u_t + u_{xxx} + uu_x + \partial_x(\psi u))_x - u_{yy} = 0
$$

with $\phi(x,y)$ as initial data if and only if for every $\beta \in \mathbb{R}$,

$$
u_{\beta}(t, x, y) := \beta^2 u(\beta^3 t, \beta x, \beta^2 y)
$$

is a solution to

$$
(\partial_t u_\beta + \partial_x^3 u_\beta + u_\beta \partial_x u_\beta + \partial_x (\psi_\beta u_\beta))_x - \partial_y^2 u_\beta = 0,
$$

with initial data

$$
\phi_{\beta}(x, y) = \beta^2 \phi(\beta x, \beta^2 y)
$$

and

$$
\psi_{\beta}(t,x,y) = \beta^2 \psi(\beta x - \beta^3 t, \beta^2 y)
$$

instead of $\psi(x-t, y)$. One can check that for $0 < \beta \leq 1$,

$$
||J_x^2 \phi_\beta||_{L_{xy}^2} \lesssim \beta^{1/2} ||J_x^2 \phi||_{L_{xy}^2}
$$

and for $s \in \mathbb{N}$,

$$
||J_x^s \psi_\beta||_{L_{xy}^\infty} \lesssim \beta^2 ||J_x^s \psi||_{L_{xy}^\infty}.
$$

Let us set

$$
u_{\varepsilon,\beta}(t,x,y) := \beta^2 u_{\varepsilon}(\beta^3 t, \beta x, \beta^2 y).
$$

In view of the above discussion for

$$
\beta \sim (1 + ||J_x^2 \phi_{\varepsilon}||_{L_{xy}^2})^{-2} \longrightarrow (1 + ||J_x^2 \phi||_{L_{xy}^2})^{-2}
$$

one has the bound

$$
\int_0^1 \|u_{\varepsilon,\beta}(t)\|_{L^\infty_{xy}} + \|\partial_x u_{\varepsilon,\beta}(t)\|_{L^\infty_{xy}} dt \le 1
$$

which leads to

$$
\int_0^{\beta^3} \|u_{\varepsilon}(t)\|_{L^\infty_{xy}} + \|\partial_x u_{\varepsilon}(t)\|_{L^\infty_{xy}} dt \le 1/\beta^3
$$

We thus obtain for $T \sim (1 + ||J_x^2 \phi||_{L_{xy}^2})^{-6}$ and ε small enough,

(62)
$$
||u_{\varepsilon}||_{L_{T}^{1}L_{xy}^{\infty}} + ||\partial_{x}u_{\varepsilon}||_{L_{T}^{1}L_{xy}^{\infty}} \lesssim (1 + ||J_{x}^{2}\phi||_{L_{xy}^{2}})^{6}
$$

which is the substitute of [\(61\)](#page-32-0) in the case of an arbitrary initial data. Therefore we deduce that $\{u_{\varepsilon}\}\)$ is bounded in $L_T^{\infty}H^{2,0}(\mathbb{R}^2)$ and $\{\partial_x u_{\varepsilon}\}\)$ is bounded in $L_T^1 L_{xy}^{\infty}$. It then follows from Lemma [8](#page-30-0) that

$$
||u_{\varepsilon}-u_{\varepsilon'}||_{L^{\infty}_{T}L^{2}_{xy}}\to 0
$$

as $\varepsilon, \varepsilon' \to 0$. Hence, there exists

$$
u \in C([0,T]; L^2(\mathbb{R}^2)) \cap C_w([0,T]; H^{2,0}(\mathbb{R}^2))
$$

with $u_x \in L_T^1 L_{xy}^{\infty}$ such that u_{ε} converges to u in $C([0,T]; L^2(\mathbb{R}^2))$. It is clear that u satisfies [\(5\)](#page-4-0) at least in a weak (distributional for instance) sense.

6.3. Continuity with respect to time. Now the continuity of u with values in $H^{2,0}(\mathbb{R}^2)$ as well as the continuity of the flow-map in $H^{2,0}(\mathbb{R}^2)$ will follow from the Bona-Smith argument. Note that here we are not in the classical situation since u does not belong to $L^{\infty}(0,T;H^{2+}(\mathbb{R}^2))$. Let u be a fixed solution of [\(5\)](#page-4-0) with initial data $\phi \in H^{2,0}(\mathbb{R}^2)$. Recall that u_{ε} is the solution to ([5](#page-4-0)) with $\phi_{\varepsilon} = \varphi^{\varepsilon} * \phi$ as initial data. We will show that $\{u_{\varepsilon}\}\)$ is a in fact a Cauchy sequence in $C([0,T]; H^{2,0}(\mathbb{R}^2))$ which will prove that $u \in C([0,T]; H^{2,0}(\mathbb{R}^2))$. First by straightforward calculations in Fourier space, one can show that for $\phi \in H^{2,0}(\mathbb{R}^2)$, $0 < \varepsilon < 1$ and $r \ge 0$,

(63)
$$
\|\varphi^{\varepsilon} * \phi\|_{H^{2+r,0}(\mathbb{R}^2)} \lesssim \varepsilon^{-r} \|\phi\|_{H^{2,0}(\mathbb{R}^2)}
$$

and

(64)
$$
\|\varphi^{\varepsilon} * \phi - \phi\|_{H^{2-r,0}(\mathbb{R}^2)} \lesssim o(\varepsilon^r) \|\phi\|_{H^{2,0}(\mathbb{R}^2)}
$$

as $\varepsilon \to 0$. For $0 < \varepsilon_2 < \varepsilon_1 < 1$, we set

$$
w:=u_{\varepsilon_1}-u_{\varepsilon_2}\,.
$$

It follows from the estimates of the previous subsection applied to u_{ε_1} and u_{ε_2} that

$$
||w||_{L_T^1 L_{xy}^\infty} + ||w_x||_{L_T^1 L_{xy}^\infty} \leq C
$$

and that for any $s \in \mathbb{N}, s \geq 2$,

$$
\|J_x^s u_\varepsilon\|_{L^\infty_T L^2_{xy}} \lesssim \|J_x^s u_\varepsilon(0)\|_{L^2_{xy}} \lesssim \varepsilon^{2-s}
$$

The issue is to show that $||J_x^2w||_{L_T^{\infty}L_{xy}^2}$ is not only bounded but that it tends to zero as ε_1 tends to zero. Using Lemma [8,](#page-30-0) we obtain that for $0 \le T \le 1$

(65)
$$
||w||_{L_T^{\infty}L_{xy}^2} \lesssim ||w(0)||_{L_{xy}^2} \lesssim o(\varepsilon_1^2).
$$

Next, we observe that w solves the equation

(66)
$$
w_t + w_{xxx} - \partial_x^{-1} w_{yy} + \partial_x(\psi w) - w w_x + u_{\varepsilon_1} \partial_x w + w \partial_x u_{\varepsilon_1} = 0.
$$

Note that since $\varepsilon_2 < \varepsilon_1$, we privilege u_{ε_1} to u_{ε_2} when writing the equation (66). We next apply ∂_x^2 to (66) and multiply it with $\partial_x^2 w$. Using [\(13\)](#page-6-0) and ([14](#page-7-0)) and Gronwall lemma, we obtain that

(67)
$$
||J_x^2 w||_{L_T^{\infty} L_{xy}^2}^2 \lesssim \exp\Big(C||\partial_x u_{\varepsilon_1}||_{L_T^1 L_{xy}^{\infty}} + C||\partial_x w||_{L_T^1 L_{xy}^{\infty}} + CT||\psi||_{W^{3,\infty}}\Big)
$$

$$
\Big[||J_x^2 w(0)||_{L^2}^2 + ||w_x||_{L_T^1 L_{xy}^{\infty}}^2||J_x^2 u_{\varepsilon_1}||_{L_T^{\infty} L_{xy}^2}^2 + ||w||_{L_T^1 L_{xy}^{\infty}}^2||J_x^3 u_{\varepsilon_1}||_{L_T^{\infty} L_{xy}^2}^2\Big].
$$

On the other hand, according to [\(66](#page-34-0)), [\(49](#page-25-0)), ([65](#page-34-0)), Lemma 7 and [\(62](#page-33-0)) applied to u_{ε_1} and u_{ε_2} , one infers that for $0 \le T \le 1$,

$$
||w||_{L_T^1 L_{xy}^{\infty}} \leq (1 + ||u_{\varepsilon_1} + u_{\varepsilon_2}||_{L_T^1 L_{xy}^{\infty}} + T ||\psi||_{W^{1,\infty}}) ||J_x^{1/2+} w||_{L_T^{\infty} L_{xy}^2}
$$

+
$$
(1 + ||D_x^{\frac{1}{2}+}(u_{\varepsilon_1} + u_{\varepsilon_2})||_{L_T^1 L_{xy}^{\infty}}) ||w||_{L_T^{\infty} L_{xy}^2}
$$

$$
\leq \varepsilon_1^{\frac{3}{2}-}
$$

(68)

where in the last step we used that, by ([65\)](#page-34-0) and interpolation argument, for $0 < \alpha < 2$

one has the bound

(69)
$$
||J_x^{\alpha}w||_{L_T^{\infty}L_{xy}^2} \lesssim ||J_x^2w||_{L_T^{\infty}L_{xy}^2}^{\alpha/2}||w||_{L_T^{\infty}L_{xy}^2}^{1-\alpha/2} \lesssim \varepsilon_1^{2-\alpha}
$$

Observing that w_x solves the equation

$$
(\partial_t + \partial_x^3 - \partial_x^{-1} \partial_y^2) w_x + \partial_x^2(\psi w) + \frac{1}{2} \partial_x^2(w(u_{\varepsilon_1} + u_{\varepsilon_2})) = 0,
$$

another use of [\(49](#page-25-0)) with (69) and (68) in hands yields

$$
||w_x||_{L_T^1 L_{xy}^{\infty}} \leq (1 + ||u_{\varepsilon_1} + u_{\varepsilon_2}||_{L_T^1 L_{xy}^{\infty}} + T ||\psi||_{W^{2,\infty}}) ||J_x^{3/2+}w||_{L_T^{\infty} L_{xy}^2}
$$

$$
+ ||J_x^{\frac{3}{2}+}(u_{\varepsilon_1} + u_{\varepsilon_2})||_{L_T^{\infty} L_{xy}^2} ||w||_{L_T^1 L_{xy}^{\infty}}
$$

$$
\leq \varepsilon_1^{\frac{1}{2}-} + \varepsilon_1^{\frac{3}{2}-}
$$

$$
\leq \varepsilon_1^{\frac{1}{2}-}.
$$

 (70)

Since, according to ([63\)](#page-34-0), $||J_x^3 u_{\varepsilon_1}||_{L_T^{\infty} L_{xy}^2} \lesssim \varepsilon_1^{-1}$, we deduce from [\(67](#page-34-0)) and (70) that for $0 < T \leq 1$,

$$
||J_x^2 w||_{L_T^{\infty} L_{xy}^2} \lesssim \left[||J_x^2(\phi_{\varepsilon_1} - \phi_{\varepsilon_2})||_{L_{xy}^2} + \varepsilon_1^{0+}\right]
$$

which proves that $\{u_{\varepsilon}\}\)$ is a Cauchy sequence in $C([0,T]; H^{2,0}(\mathbb{R}^2)).$

6.4. Continuity of the flow map. Let
$$
\{\phi_n\} \subset H^{2,0}(\mathbb{R}^2)
$$
 be such that $\phi_n \longrightarrow \phi$

in $H^{2,0}(\mathbb{R}^2)$. We want to prove that the emanating solution u^n tends to u in $C([0,T]; H^{2,0})$. By the triangle inequality,

$$
||u - u^{n}||_{L^{\infty}_{T} H^{2,0}} \le ||u - u_{\varepsilon}||_{L^{\infty}_{T} H^{2,0}} + ||u_{\varepsilon} - u^{n}_{\varepsilon}||_{L^{\infty}_{T} H^{2,0}} + ||u^{n}_{\varepsilon} - u^{n}||_{L^{\infty}_{T} H^{2,0}}.
$$

Using the argument of the previous subsection, we can obtain the bound

(71)
$$
||u - u_{\varepsilon}||_{L^{\infty}_{T} H^{2,0}} \lesssim ||u(0) - u_{\varepsilon}(0)||_{H^{2,0}} + o(1) = o(1),
$$

where $o(1) \to 0$ as $\varepsilon \to 0$. In the bound for $u - u_{\varepsilon}$ we privilege u_{ε} to u exactly as we privileged u_{ε_1} to u_{ε_2} in the previous subsection. Next, privileging u_{ε}^n to u_n , and using that $u_{\varepsilon}^n(0)$ converges to $u^n(0)$ as $\varepsilon \to 0$, uniformly in n, we infer the bound

(72)
$$
||u_{\varepsilon}^{n} - u^{n}||_{L_{T}^{\infty}H^{2,0}} \lesssim ||u_{\varepsilon}^{n}(0) - u^{n}(0)||_{H^{2,0}} + o(1) = o(1),
$$

where $o(1) \to 0$ as $\varepsilon \to 0$. Finally, no matter which of the solutions is privileged, we get the bound

(73)
$$
\|u_{\varepsilon} - u_{\varepsilon}^{n}\|_{L^{\infty}_{T} H^{2,0}} \leq \|u_{\varepsilon}(0) - u_{\varepsilon}^{n}(0)\|_{H^{2,0}} + o(1)
$$

$$
= \| \varphi_{\varepsilon} * (u(0) - u^{n}(0)) \|_{H^{2,0}} + o(1)
$$

$$
\leq \| \phi - \phi_{n} \|_{H^{2,0}} + o(1)
$$

where again $o(1) \rightarrow 0$ as $\varepsilon \rightarrow 0$. Collecting [\(71](#page-35-0)), (72) and (73) ends the proof of the continuity of the flow map. Thus the proof of Proposition [7](#page-30-0) is now completed.

7. End of the proof of Theorem [1](#page-3-0) : continuous dependence in Z

In this section, we complete the proof of Theorem [1.](#page-3-0) The existence and uniqueness are obtained as in Proposition [7](#page-30-0). Indeed, let us notice that $Z \hookrightarrow H^{2,0}$ and thus thanks to Proposition [4,](#page-22-0) the approximated solutions u_{ε} satisfy

$$
||u_{\varepsilon}(t)||_{Z} \leq g(t)
$$

which ensures that $||u||_{H^{2,0}}$ can not go to infinity in finite time. According to Proposition 7 , this implies that the solution u is global in time and satisfies

$$
u \in L^{\infty}(0,T;Z), \quad u_x \in L^1(0,T;L^{\infty}_{xy}), \quad \forall T > 0
$$

It remains to prove the continuity of $t \mapsto u(t)$ with values in Z and the continuity of the flow-map. By Bona-Smith type arguments as in the preceding section, one can see that $t \mapsto u(t)$ as well as the flow-map is continuous with values in X where

$$
X = \{ v \in S', ||v||_{H^{2,0}} + ||\partial_x^{-1} u_y||_{L^2} + ||u_y||_{L^2} < \infty \}
$$

It remains to prove the continuity of $t \mapsto \partial_x^{-2} u_{yy}$ with values in $L^2(\mathbb{R}^2)$. This continuity property is more delicate since we can not apply ∂_x^{-2} to the equation satisfied by the approximate solution. Thus a different argument is needed. Recall that

$$
F^{\psi}(u) = \frac{5}{6} \int_{\mathbb{R}^2} |\partial_x^{-2} u_{yy}|^2 - \frac{5}{6} \int_{\mathbb{R}^2} (u^2 + 2\psi u) \partial_x^{-2} u_{yy} + r(u)
$$

where r is continuous on X .

We start by proving that $t \mapsto F^{\psi}(u(t))$ is continuous on [0, T]. As in the preceding subsection we denote by u_{ε} the solution emanating from $\phi_{\varepsilon} = \varphi^{\varepsilon} * \phi$. First it is easy to prove that for any $v \in L^2(\mathbb{R}^2)$ and any $\alpha > 0$ fixed, the sequence of functions

 $t \mapsto (\partial_x^{-2} u_{yy}^{\varepsilon}(t), \varphi_{\alpha} * v)_{L^2}$ is equi-continuous on $[0, T]$ and thus $\partial_x^{-2} u_{yy}^{\varepsilon} \to \partial_x^{-2} u_{yy}$ in $C_w([0,T]; L^2(\mathbb{R}^2))$. Hence, for any $t \in [0,T]$

$$
\int_{\mathbb{R}^2} (u^{\varepsilon}(t))^2 \partial_x^{-2} u_{yy}^{\varepsilon}(t) \to \int_{\mathbb{R}^2} u^2(t) \partial_x^{-2} u_{yy}(t)
$$
\n
$$
\int_{\mathbb{R}^2} |\partial_x^{-2} u_{yy}(t)|^2 \le \liminf_{\varepsilon \to 0} \int_{\mathbb{R}^2} |\partial_x^{-2} u_{yy}^{\varepsilon}(t)|^2
$$

Thus passing in the limit in ε in ([41\)](#page-22-0), we obtain

$$
F^{\psi}(u(t)) \leq \liminf_{\varepsilon \to 0} F^{\psi}(u^{\varepsilon}(t))
$$

\n
$$
= F^{\psi}(\phi) - \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi_x(\partial_x^{-2} u_{yy}) u_{xx}
$$

\n
$$
+ \frac{5}{6} \int_0^t \int_{\mathbb{R}^2} \psi(\partial_x^{-2} u_{yy}) ((u)^2 + 2\psi u)_x
$$

\n
$$
+ \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi u(\partial_x^{-2} u_{yy}) + \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} (\psi u)_x u(\partial_x^{-2} u_{yy})
$$

\n
$$
+ \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi_y(\partial_x^{-1} u_y)(\partial_x^{-2} u_{yy}) + \int_0^t G(u).
$$

Taking $u(t)$ as initial data and reversing time, we get the reverse inequality and thus

(74)
$$
F^{\psi}(u(t)) = F^{\psi}(\phi) - \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi_x (\partial_x^{-2} u_{yy}) u_{xx} + \frac{5}{6} \int_0^t \int_{\mathbb{R}^2} \psi (\partial_x^{-2} u_{yy}) ((u)^2 + 2\psi u)_x + \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi u (\partial_x^{-2} u_{yy}) + \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} (\psi u)_x u (\partial_x^{-2} u_{yy}) + \frac{5}{3} \int_0^t \int_{\mathbb{R}^2} \psi_y (\partial_x^{-1} u_y) (\partial_x^{-2} u_{yy}) + \int_0^t G(u)
$$

It follows that $t \mapsto F^{\psi}(u(t))$ is continuous on $[0, T]$. Now, since $\partial_x^{-2} u_{yy} \in C_w([0, T]; L^2(\mathbb{R}^2))$,

$$
t \mapsto \int_{\mathbb{R}^2} u^2 \partial_x^{-2} u_{yy} \in C([0,T]) \quad ,
$$

and thus the continuity of $t \to F^{\psi}(u(t))$ forces $t \to \int_{\mathbb{R}^2} |\partial_x^{-2} u_{yy}|^2$ to belong to $C([0,T])$. It follows that

$$
t \mapsto \partial_x^{-2} u_{yy} \in C([0,T]; L^2(\mathbb{R}^2))) \quad ,
$$

which proves that $u(t)$ describes a continuous curve in Z. Now, let $\{\phi_n\} \subset Z$ such that $\phi_n \to \phi$ in Z. Since F^{ψ} is continuous on Z, $F^{\psi}(\phi_n) \to F^{\psi}(\phi)$. Moreover, using that the emanating solutions u_n converges to u

in $C([0,T];X)$ and that $\partial_x^{-2}u_{yy}^n$ converges to $\partial_x^{-2}u_{yy}$ in $C_w([0,T];L^2(\mathbb{R}^2))$, we infer from [\(74\)](#page-37-0) that

$$
F^{\psi}(u^{n}(t)) - F^{\psi}(\phi_{n}) \rightarrow F^{\psi}(u(t)) - F^{\psi}(\phi), \quad \forall t \in [0, T]
$$

This convergence clearly forces

$$
\int_{\mathbb{R}^2} |\partial_x^{-2} u_{yy}^n(t)|^2 \to \int_{\mathbb{R}^2} |\partial_x^{-2} u_{yy}(t)|^2, \quad \forall t \in [0, T]
$$

which permits to conclude that $u^n \to u$ in $C([0,T]; Z)$.

We end this section by an important remark. Notice that our result requires a control on $\|\nabla_{x,y} u\|_{L_T^1 L_{xy}^\infty}$ in order to have the basic **global** well-posedness theorem of Section 4. But once this global in time result is established, further improvements of the local well-posedness theory in the spaces $H^{s,0}(\mathbb{R}^2)$, or in the spaces considered in[[17\]](#page-39-0), only requires a control on $||u_x||_{L_T^1 L_{xy}^{\infty}}$ in terms of $||J_x^s u||_{L_T^{\infty} L_{xy}^2}$.

8. WELL-POSEDNESS OF THE KP-I EQUATION IN $H^{s,0}(\mathbb{R}^2)$, $s > 3/2$

The aim of this section is to extend Kenig's local well-posedness result by showing that KP-I equation is locally well-posed for initial data in the space

$$
H^{s,0}(\mathbb{R}^2) := \{ u \in L^2(\mathbb{R}^2) : |D_x|^s u \in L^2(\mathbb{R}^2) \} \text{ with } s > 3/2,
$$

that is no y derivative is needed. Consider thus the KP-I equation

(75)
$$
(u_t + u_{xxx} + uu_x)_x - u_{yy} = 0
$$

with initial data

(76)
$$
u(0, x, y) = \phi \in H^{s,0}(\mathbb{R}^2).
$$

Thanks to the estimates established in Section 4, we have the following modest extension of Kenig's result [\[17\]](#page-39-0).

Theorem 2. The Cauchy problem (75)-(76) is locally well-posed in $H^{s,0}(\mathbb{R}^2)$ for $s > 3/2$.

Let u be a $H_{-1}^{\infty}(\mathbb{R}^2)$ solution to the KP-I equation. Then thanks to Proposition [5,](#page-25-0) we obtain that for $T \leq 1$,

$$
(77) \t\t ||u||_{L_T^1 L_{xy}^{\infty}} + ||u_x||_{L_T^1 L_{xy}^{\infty}} \leq C_{\varepsilon} \left(||J_x^{\frac{3}{2}+\varepsilon} u||_{L_T^{\infty} L_{xy}^2} + ||u||_{L_T^1 L_{xy}^{\infty}} ||J_x^{\frac{3}{2}+\varepsilon} u||_{L_T^{\infty} L_{xy}^2} \right).
$$

Applying J_x^s to (75) and multiplying it with $J_x^s u$ gives after applying the Kato-Ponce commutator estimate in x ,

$$
\frac{d}{dt}||J_x^su(t,\cdot)||_{L^2}^2 \lesssim ||u_x(t,\cdot)||_{L^\infty}||J_x^su(t,\cdot)||_{L^2}^2
$$

$$
\sqcup
$$

and the Gronwall lemma gives the bound

(78)
$$
||J_x^s u||_{L_T^{\infty} L_{xy}^2} \leq ||J_x^s \phi||_{L^2} \exp(C||u_x||_{L_T^1 L_{xy}^{\infty}}).
$$

Bounds ([77\)](#page-38-0) and (78) enable one to perform a compactness argument as we did in the proof of Proposition [1](#page-5-0) which shows that the flow map of $(75)-(76)$ $(75)-(76)$ $(75)-(76)$ $(75)-(76)$ $(75)-(76)$ can be extended to a map on $H^{s,0}(\mathbb{R}^2), s > 3/2$ with a life span depending only on a bound on $||J_x^s \phi||_{L^2}$. The continuity of the trajectory in $H^{s,0}(\mathbb{R}^2)$ as well as the continuity of the flow-map can be derived as in Sections [6.3-](#page-34-0)[6.4](#page-35-0)
