# Upper limits of Sinai's walk in random scenery

#### Abstract

Summary. We consider Sinai's walk in i.i.d. random scenery and focus our attention on a conjecture of Révész [17] concerning the upper limits of Sinai's walk in random scenery when the scenery is bounded from above. A close study of the competition between the concentration property for Sinai's walk and negative values for the scenery enables us to prove that the conjecture is true if the scenery has "thin" negative tails and is false otherwise.


Keywords. Random walk in random environment, random scenery, localization, concentration property.

## 1 Introduction

### 1.1 Random walk in random environment

Problems involving random environments arise in different domains of physics and biology. Originally, one-dimensional random walk in random environment appeared as a simple model for DNA transcription. In the following, we consider the elementary model of onedimensional Simple Random Walk in Random Environment (SRWRE), defined as follows.

Let $\omega:=\left(\omega_{i}, i \in \mathbb{Z}\right)$ be a family of independent and identically distributed (i.i.d.) random variables defined on $\Omega$, which stands for the random environment. Denote by $P$ the distribution of $\omega$ and by $E$ the corresponding expectation.

Conditioning on $\omega$ (i.e., choosing an environment), we define the SRWRE ( $X_{n}, n \geq 0$ ) as a nearest-neighbor random walk on $\mathbb{Z}$ with transition probabilities given by $\omega:\left(X_{n}, n \geq 0\right)$ is a Markov chain satisfying $X_{0}=0$ and

$$
P_{\omega}\left(X_{n+1}=j \mid X_{n}=i\right)= \begin{cases}\omega_{i} & \text { if } j=i+1 \\ 1-\omega_{i} & \text { if } j=i-1 \\ 0 & \text { otherwise }\end{cases}
$$

We denote by $P_{\omega}$ the law of $\left(X_{n}, n \geq 0\right)$, by $E_{\omega}$ the corresponding expectation, and by $\mathbb{P}$ the joint law of $\left(\omega,\left(X_{n}\right)_{n \geq 0}\right)$. We refer to Zeitouni [22] for an overview of random walks in random environment.

Throughout the paper, we make the following assumptions on $\omega$ :

\begin{align*}
\exists \delta \in(0,1 / 2): \quad P\left(\delta \leq \omega_{0} \leq 1-\delta\right) & =1  \tag{1.1}\\
E\left[\log \left(\frac{1-\omega_{0}}{\omega_{0}}\right)\right] & =0  \tag{1.2}\\
\sigma^{2}:=\operatorname{Var}\left[\log \left(\frac{1-\omega_{0}}{\omega_{0}}\right)\right] & >0 \tag{1.3}
\end{align*}
$$

Assumption (1.1) implies that $\left|\log \left(\frac{1-\omega_{0}}{\omega_{0}}\right)\right|$ is, $P$-a.s., bounded by the constant $L:=\log \left(\frac{1-\delta}{\delta}\right)$. It is a technical assumption, which can be replaced by an exponential moment of $\log \left(\frac{1-\omega_{0}}{\omega_{0}}\right)$. According to a recurrence-transience result due to Solomon [21], assumption (1.2) ensures that $\left(X_{n}\right)_{n \geq 0}$ is $\mathbb{P}$-almost surely recurrent, i.e., the random walk hits any site infinitely often. Assumption (1.3) excludes the case of deterministic environment, which corresponds to the homogeneous symmetric random walk.

Under assumptions (1.1)-(1.3), the SRWRE is referred to as Sinai's walk. Sinai [20] proves that $X_{n} /(\log n)^{2}$ converges in law, under $\mathbb{P}$, toward a non-degenerate random variable, whose distribution is explicitly computed by Kesten [14] and Golosov [8]. This result contrasts with the usual central limit theorem which gives the convergence in law of $X_{n} / \sqrt{n}$.

Let

$$
\begin{align*}
L(n, x) & :=\#\left\{0 \leq i \leq n: \quad X_{i}=x\right\}, \quad n \geq 0, x \in \mathbb{Z},  \tag{1.4}\\
L(n, A) & :=\sum_{x \in A} L(n, x), \quad n \geq 0, A \subset \mathbb{Z}
\end{align*}
$$

In words, the quantity $L(n, A)$ measures the number of visits at set $A$ by the walk in the first $n$ steps.

The maximum of local time is studied by Révész ([17], p. 337) and Shi [18]: under assumptions (1.1)-(1.3), there exists $c_{0}>0$ such that

$$
\limsup _{n \rightarrow \infty} \frac{\max _{x \in \mathbb{Z}} L(n, x)}{n} \geq c_{0}, \quad \mathbb{P} \text {-a.s. }
$$

It means that the walk spends, infinitely often, a positive part of its life on a single site. A concentration property is obtained by Theorem 1.3 of Andreoletti [1], which says that, under assumptions (1.1)-(1.3) and for any $0<\beta<1$, there exists $\ell(\beta)>0$ such that

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \frac{\sup _{x \in \mathbb{Z}} L(n,[x-\ell(\beta), x+\ell(\beta)])}{n} \geq \beta, \quad \mathbb{P} \text {-a.s. } \tag{1.5}
\end{equation*}
$$

In words, for any $\beta$ close to 1 , it is possible to find a length $\ell(\beta)$ such that, $\mathbb{P}$-almost surely, the particle spends, infinitely often, more than a $\beta$-fraction of its life in an interval of length $2 \ell(\beta)$.

### 1.2 Random walk in random scenery

Random Walk in Random Scenery (RWRS) is a simple model of diffusion in disordered media, with long-range correlations. It is a class of stationary random processes exhibiting rich behavior. It can be described as follows: given a Markov chain on a state space, there may be a random field associated to the state space, called random scenery. As the random walk moves on this state space, he observes the scenery at his location. For a survey of recent results about RWRS, we refer to den Hollander and Steif [12], and to Asselah and Castell [2] for large deviations results in dimension $d \geq 5$.

Let us now define the model of one-dimensional RWRS: consider $S=\left(S_{n}, n \geq 0\right)$ a random walk on $\mathbb{Z}$ and $\xi:=(\xi(x), x \in \mathbb{Z})=\left(\xi_{x}, x \in \mathbb{Z}\right)$, a family of i.i.d. random variables defined on a probability space $\Xi$. We refer to $\xi$ as the random scenery and denote by $Q$ its law. Then, define the process $\left(Y_{n}, n \geq 0\right)$ by

$$
Y_{n}:=\sum_{i=0}^{n} \xi\left(S_{i}\right)
$$

called RWRS or the Kesten-Spitzer Random Walk in Random Scenery. An interpretation is the following: if a random walker has to pay $\xi_{x}$ each time he visits $x$, then $Y_{n}$ stands for the total amount he has paid in the time interval $[0, n]$.

The model is introduced and studied by Kesten and Spitzer [15] in dimensions $d=1$ and $d \geq 3$. They prove in dimension $d=1$ that, when $S$ and $\xi$ belong to the domains of
attraction of stable laws of indice $\alpha$ and $\beta$ respectively, then there exists $\delta$, depending on $\alpha$ and $\beta$, such that $n^{-\delta} Y_{\lfloor n t\rfloor}$ converges weakly. Bolthausen [3] studies the case $d=2$. He proves that, if $S$ is a recurrent random walk and $\xi_{0}$ has zero expectation and finite variance, then $(n \log n)^{-1 / 2} Y_{\lfloor n t\rfloor}$ satisfies a functional central limit theorem. Independently, Borodin analyzes the case of one-dimensional simple random walk, see [4] and [5].

### 1.3 Random environment and random scenery

In this paper, we consider Sinai's Walk in Random Scenery. Problems combining random environment and random scenery have been examined for more general models. Replacing $\mathbb{Z}$ by a more general countable state space, Lyons and Schramm [16] exhibit, under certain conditions, a stationary measure for Random Walks in a Random Environment with Random Scenery (RWRERS) from the viewpoint of the random walker. Häggström [9], Häggström and Peres [10] treat the case where the scenery arises from percolation on a graph. In this particular case, the scenery determines the random environment of the associated RWRE, which is used by the authors to obtain information about the scenery.

Let us first describe the model of Sinai's walk in random scenery. We consider Sinai's walk ( $X_{n}, n \geq 0$ ) under assumptions (1.1)-(1.3), and recall that the environment $\omega$ is defined on $(\Omega, P)$. For the scenery, we consider a family of i.i.d. random variables $\xi:=(\xi(x), x \in$ $\mathbb{Z})=\left(\xi_{x}, x \in \mathbb{Z}\right)$, defined on $(\Xi, Q)$, independent of $\omega$ and $\left(X_{n}, n \geq 0\right)$. We denote by $Q$ the distribution of $\xi$. To translate independence between $\omega$ and $\xi$, we consider the probability space $(\Omega \times \Xi, P \otimes Q)$, on which we define $(\omega, \xi)$. Moreover, we denote by $\mathbb{P} \otimes Q$ the law of $\left(\omega,\left(X_{n}\right)_{n \geq 0}, \xi\right)$. Then we define as Sinai's walk in random scenery the process $\left(Z_{n}, n \geq 0\right)$ :

$$
Z_{n}:=\sum_{i=0}^{n} \xi\left(X_{i}\right) .
$$

Observe that $Z_{n}$ can be written with local time notation:

$$
\begin{equation*}
Z_{n}=\sum_{x \in \mathbb{Z}} \xi(x) L(n, x), \quad n \geq 0 \tag{1.6}
\end{equation*}
$$

where $L(n, x)$ stands for the local time of the random walk at site $x$ until time $n$, see (1.4).
We are interested in the upper limit of $Z_{n}$ in the case where $a:=\operatorname{ess} \sup \xi_{0}$ is finite. We consider the concentration property of order $\beta$ for Sinai's walk with $\beta$ close to 1 (see (1.5)), which enables us to formulate the conjecture of Révész ([17], p. 353): does the assumption
that $a:=\operatorname{ess} \sup \xi_{0}$ is finite implies that, $\mathbb{P} \otimes Q$-almost surely,

$$
\limsup _{n \rightarrow \infty} \frac{Z_{n}}{n}=a ?
$$

It turns out that the conjecture holds only under some additional assumptions on the distribution of the random scenery. A close study of the competition between the concentration property for Sinai's walk and negative values for the scenery enables us to obtain the following theorem, which gives a solution to this problem, depending on the tail decay of $\xi_{0}^{-}:=\max \left\{-\xi_{0}, 0\right\}$.

Theorem 1.1 Assume (1.1)-(1.3) and $a:=\operatorname{ess} \sup \xi_{0}<\infty$.
(i) If $Q\left\{\xi_{0}^{-}>\lambda\right\} \leq \frac{1}{(\log \lambda)^{2+\varepsilon}}$, for some $\varepsilon>0$ and all large $\lambda$, then

$$
\mathbb{P} \otimes Q\left\{\limsup _{n \rightarrow \infty} \frac{Z_{n}}{n}=a\right\}=1
$$

(ii) If $Q\left\{\xi_{0}^{-}>\lambda\right\} \geq \frac{1}{(\log \lambda)^{2-\varepsilon}}$, for some $\varepsilon>0$ and all large $\lambda$, then

$$
\mathbb{P} \otimes Q\left\{\lim _{n \rightarrow \infty} \frac{Z_{n}}{n}=-\infty\right\}=1
$$

The paper is organized as follows: in Section 2, we quote useful results about environment, and about Sinai's walk when the environment is fixed (i.e., quenched results). In Section 3 , we define the notion of "good" environment-scenery and prove Theorem 1.1 by accepting two intermediate propositions. These two propositions are proved in Sections 4 and 5, respectively.

We use $c_{i}(1 \leq i \leq 34)$ to denote finite and positive constants.

## 2 Preliminaries

In this section, we collect some basic properties of random walk in random environment that will be useful in the forthcoming sections.

### 2.1 About the environment

In the study of one-dimensional SRWRE, an important role is played by a function of the environment $\omega$, called the potential. This process, noted $V=(V(x), x \in \mathbb{Z})$, is defined on $(\Omega, P)$ by:

$$
V(x):= \begin{cases}\sum_{i=1}^{x} \log \left(\frac{1-\omega_{i}}{\omega_{i}}\right) & \text { if } x \geq 1, \\ 0 & \text { if } x=0, \\ -\sum_{i=x+1}^{0} \log \left(\frac{1-\omega_{i}}{\omega_{i}}\right) & \text { if } x \leq-1\end{cases}
$$

By (1.1), we observe that $|V(x)-V(x-1)| \leq L$ for any $x \in \mathbb{Z}$ and, for technical reason concerning Section 5, we define $P_{z}(\cdot):=P(\cdot \mid V(0)=z)$, for any $z \in \mathbb{R}$.

We recall the following result, whose proof is given by a simple martingale argument:

$$
\begin{equation*}
P_{y}\left\{d^{+}([z, \infty))<d^{+}((-\infty, x])\right\} \geq \frac{y-x}{z-x+L} \tag{2.1}
\end{equation*}
$$

Moreover, we recall a result of Hirsch [11], which, under assumptions (1.1)-(1.3), takes the following simplified form: for any $0<\varepsilon^{\prime}<\frac{1}{34}$,

$$
\begin{equation*}
P\left\{\max _{0 \leq x \leq N} V(x)<N^{\frac{1}{2}-\varepsilon^{\prime}}\right\} \sim c_{1} N^{-\varepsilon^{\prime}}, \quad N \rightarrow \infty . \tag{2.2}
\end{equation*}
$$

### 2.2 Quenched results

We define, for any $x \in \mathbb{Z}$,

$$
\tau(x):=\min \left\{n \geq 1: X_{n}=x\right\}, \quad \min \emptyset:=\infty
$$

(Note in particular that when $X_{0}=x$, then $\tau(x)$ is the first return time to $x$.) Throughout the paper, we write $P_{\omega}^{x}(\cdot):=P_{\omega}\left(\cdot \mid X_{0}=x\right)$ (thus $\left.P_{\omega}^{0}=P_{\omega}\right)$ and denote by $E_{\omega}^{x}$ the expectation with respect to $P_{\omega}^{x}$.

It is known (Zeitouni [22], formula (2.1.4)) that for $r<x<s$,

$$
\begin{equation*}
P_{\omega}^{x}\{\tau(r)<\tau(s)\}=\sum_{j=x}^{s-1} \mathrm{e}^{V(j)}\left(\sum_{j=r}^{s-1} \mathrm{e}^{V(j)}\right)^{-1} \tag{2.3}
\end{equation*}
$$

The next result, which gives a simple bound for the expectation of $\tau(r) \wedge \tau(s)$ when the walk starts from a site $x \in(r, s)$, is essentially contained in Golosov [7], its proof can be found in [19]. For any integers $r<s$, we have

$$
\begin{equation*}
\max _{x \in(r, s) \cap \mathbb{Z}} E_{\omega}^{x}\left[\tau(s) \mathbf{1}_{\{\tau(s)<\tau(r)\}}\right] \leq(s-r)^{2} \exp \left[\max _{r \leq i \leq j \leq s}(V(j)-V(i))\right] . \tag{2.4}
\end{equation*}
$$

We will also use the following estimate borrowed from Lemma 7 of Golosov [7]: for $\ell \geq 1$ and $x<y$,

$$
\begin{equation*}
P_{\omega}^{x}\{\tau(y)<\ell\} \leq \ell \exp \left(-\max _{x \leq i<y}[V(y-1)-V(i)]\right) \tag{2.5}
\end{equation*}
$$

Looking at the environment backwards, we get: for $\ell \geq 1$ and $w<x$,

$$
\begin{equation*}
P_{\omega}^{x}\{\tau(w)<\ell\} \leq \ell \exp \left(-\max _{w<i \leq x}[V(w+1)-V(i)]\right) . \tag{2.6}
\end{equation*}
$$

Finally we quote an important result about excursions of Sinai's walk. Let $b \in \mathbb{Z}$ and $x \in \mathbb{Z}$, and consider $L(\tau(b), x)$ under $P_{\omega}^{b}$. In words, we look at the number of visits at site $x$ by the random walk (starting from $b$ ) until the first return to $b$. Then there exist constants $c_{2}$ and $c_{3}$ such that

$$
\begin{equation*}
c_{2} \mathrm{e}^{-[V(x)-V(b)]} \leq E_{\omega}^{b}[L(\tau(b), x)] \leq c_{3} \mathrm{e}^{-[V(x)-V(b)]} . \tag{2.7}
\end{equation*}
$$

## 3 Good environment-scenery and proof of Theorem 1.1

For any $j>0$, we define

$$
\begin{aligned}
d^{+}(j) & :=\min \{n \geq 0: V(n) \geq j\}, \\
b^{+}(j) & :=\min \left\{n \geq 0: V(n)=\min _{0 \leq x \leq d^{+}(j)} V(x)\right\} .
\end{aligned}
$$

These variables enable us to consider the valley $\left(0, b^{+}(j), d^{+}(j)\right)$. Similarly, we define

$$
\begin{aligned}
d^{-}(j) & :=\max \{n \leq 0: V(n) \geq j\} \\
b^{-}(j) & :=\max \left\{n \leq 0: V(n)=\min _{d^{-}(j) \leq x \leq 0} V(x)\right\} .
\end{aligned}
$$

In the next sections, we will be frequently using the following elementary estimates: for any $\varepsilon>0, P$-almost surely for all large $j$,

$$
\begin{equation*}
j^{2-\varepsilon} \leq\left|b^{ \pm}(j)\right|<\left|d^{ \pm}(j)\right| \leq j^{2+\varepsilon} \tag{3.1}
\end{equation*}
$$

More generally, it will be useful to define, for any Borel set $A \subset \mathbb{R}$,

$$
\begin{aligned}
d^{+}(A) & :=\min \{n \geq 0: V(n) \in A\} \\
d^{-}(A) & :=\max \{n \leq 0: V(n) \in A\}
\end{aligned}
$$

To introduce the announced "good" environment-scenery, we fix $\varepsilon>0$ such that assumption of part ( $i$ ) of Theorem 1.1 is verified. For $\alpha \in(0,1)$ (which will depend on $\varepsilon$ ), $c_{4}>0$, and $j \geq 100$, we define

$$
\begin{align*}
\gamma_{0}=\gamma_{0}(j) & :=j, \\
\gamma_{i}=\gamma_{i}(j) & :=j^{(1-\alpha)^{i}}=\gamma_{i-1}^{1-\alpha}, \quad i \geq 1  \tag{3.2}\\
\varepsilon_{i}=\varepsilon_{i}(j) & :=\exp \left\{-c_{4} \gamma_{i+2}(j)\right\} . \tag{3.3}
\end{align*}
$$

For convenience of notation we define $\varepsilon_{-1}=\varepsilon_{-1}(j):=\varepsilon_{0}(j)$. In words, $\left(\gamma_{i}\right)_{i \geq 0}$ represents a decreasing sequence of distances, which enables us to classify the sites according to the value of $V(x)-V(b)$.

Write $\log _{j}$ for the $j$ th iterative logarithmic function. Fix $\varepsilon^{\prime}:=\min \{1 / 35, \varepsilon / 2\}>0$, and introduce, for $j \geq 100$,

$$
\begin{equation*}
M=M(j):=\inf \left\{n \geq 0: \gamma_{n} \leq\left(\log _{2} j\right)^{\frac{1-\alpha}{2+\varepsilon^{\prime}}}\right\} \tag{3.4}
\end{equation*}
$$

It is easy to observe that

$$
\begin{equation*}
M(j) \sim \frac{1}{|\log (1-\alpha)|} \log _{2} j, \quad j \rightarrow \infty \tag{3.5}
\end{equation*}
$$

and that

$$
\gamma_{M-1} \in\left[\left(\log _{2} j\right)^{\frac{1-\alpha}{2+\varepsilon}},\left(\log _{2} j\right)^{\frac{1}{2+\varepsilon}}\right] .
$$

Note that we choose $\alpha$ small enough such that

$$
\begin{align*}
\beta & :=(1-\alpha)^{2}(2+\varepsilon)-\left(2+\varepsilon^{\prime}\right)>0,  \tag{3.6}\\
\beta^{\prime} & :=\frac{\varepsilon^{\prime}}{2}-\alpha>0 . \tag{3.7}
\end{align*}
$$

Then we introduce the set

$$
\bar{\Theta}_{M-1}=\bar{\Theta}_{M-1}(j):=\left[b^{+}(j)-c_{5} \gamma_{M-1}^{2+\varepsilon^{\prime}}, b^{+}(j)+c_{5} \gamma_{M-1}^{2+\varepsilon^{\prime}}\right],
$$

and, for $i=M-2, \ldots, 1,0$, the sets

$$
\bar{\Theta}_{i}=\bar{\Theta}_{i}(j):=\left[b^{+}(j)-c_{6} \gamma_{i}^{2+\varepsilon^{\prime}}, b^{+}(j)+c_{6} \gamma_{i}^{2+\varepsilon^{\prime}}\right] \backslash \bigcup_{p=i+1}^{M-1} \bar{\Theta}_{p}
$$

Observe that the sets $\left(\bar{\Theta}_{i}\right)_{0 \leq i \leq M-1}$ form a partition of the interval $\left[b^{+}(j)-c_{6} j^{2+\varepsilon^{\prime}}, b^{+}(j)+\right.$ $\left.c_{6} j^{2+\varepsilon^{\prime}}\right]$. The final sets we consider are given, for $0 \leq i \leq M(j)-1$, by

$$
\Theta_{i}:=\bar{\Theta}_{i} \cap I(j),
$$

where $I(j):=\left[d^{+}((-\infty,-j]), d^{+}(j)\right]$. Note that $d^{+}((-\infty,-j])<d^{+}(j)$ on $A(j)$ which will be defined in (3.16). In this case, the sets $\left(\Theta_{i}\right)_{0 \leq i \leq M-1}$ form a partition of $I(j)$ in annulus. Loosely speaking, the set $\Theta_{i}$ contains the sites $x$ satisfying $V(x)-V(b) \approx \gamma_{i}$. To cover $\left[d^{-}(j), d^{+}(j)\right]$, we define

$$
\begin{equation*}
\Theta_{-1}=\Theta_{-1}(j):=\left[-c_{7} j^{2+\varepsilon^{\prime}}, c_{7} j^{2+\varepsilon^{\prime}}\right] \cap\left[d^{-}(j), d^{+}((-\infty,-j])\right] . \tag{3.8}
\end{equation*}
$$

Moreover, for the environment on $\mathbb{Z}^{+}$, we introduce the events

$$
\begin{align*}
A_{1}^{e n v}(j) & :=\left\{-4 j \leq V\left(b^{+}(j)\right) \leq-3 j\right\},  \tag{3.9}\\
A_{2}^{e n v}(j) & :=\left\{\max _{0 \leq x \leq y \leq b^{+}(j)}[V(y)-V(x)] \leq \frac{j}{4}\right\} . \tag{3.10}
\end{align*}
$$

The first event ensures that the valley considered is "deep enough" and the second one that the particle reaches the bottom of the valley "fast enough". To control the time spent by the particle in different $\Theta_{i}$ during an excursion from $b^{+}(j)$ to $b^{+}(j)$, we define

$$
\begin{equation*}
A_{a n n}^{e n v}(j):=\bigcap_{i=0}^{M-2}\left\{\sum_{x \in \Theta_{i}(j)} \mathrm{e}^{-\left[V(x)-V\left(b^{+}(j)\right)\right]} \leq \varepsilon_{i}^{2}\right\}=: \bigcap_{i=0}^{M-2} A_{a n n, i}^{e n v}(j) . \tag{3.11}
\end{equation*}
$$

For the environment on $\mathbb{Z}^{-}$, let

$$
\begin{equation*}
B^{e n v}(j):=\left\{V\left(b^{-}(j)\right) \leq-\frac{j}{6}, \max _{d^{-}(j) \leq x \leq y \leq 0}[V(y)-V(x)] \leq \frac{j}{3}\right\} \tag{3.12}
\end{equation*}
$$

which ensures that the particle will not spent too much time on $\mathbb{Z}^{-}$.
Recalling that $\xi_{x}^{-}=\max \left\{-\xi_{x}, 0\right\}$, we define for the scenery

A_{i}^{s c e}(j) & :=\left\{\max _{x \in \Theta_{i}(j)} \xi_{x}^{-}<\left(\varepsilon_{i}\right)^{-1 / 2}\right\}, \quad 0 \leq i \leq M-2, \tag{3.14}
\end{align*}
$$

which ensures that the scenery does not reach excessive negative value in each $\Theta_{i}$. In order to force the scenery in a neighborhood of the bottom (where the particle is concentrated), to be close to $a=\operatorname{ess} \sup \xi_{0}$, we fix $\rho \in(0,1)$ and introduce

Moreover, we note

A(j):=A^{e n v}(j) \cap B^{e n v}(j) \cap A^{s c e}(j) . \tag{3.16}
\end{equation*}
$$

A pair $(\omega, \xi)$ is a "good" environment-scenery if $(\omega, \xi) \in A(j)$ for infinitely many $j$.
For future use, let us note that for $\omega \in B^{e n v}(j) \cap A_{2}^{e n v}(j)$, we have

\max _{d^{-}(j) \leq x \leq y \leq b^{+}(j)}[V(y)-V(x)] \leq \frac{2 j}{3} . \tag{3.17}

To prove Theorem 1.1, we need two propositions, whose proofs are respectively postponed until Sections 5 and 4. The first one ensures that almost all pair $(\omega, \xi)$ is a "good" environment-scenery, while the second one describes the behavior of the particle in a "good" environment.

Proposition 3.1 Under assumptions (1.1)-(1.3), we have that $P \otimes Q$-almost all $(\omega, \xi)$ is a "good" environment-scenery. More precisely, there exists a sequence $\left(m_{k}\right)_{k \geq 1}$ such that $m_{k} \geq k^{3 k}$ and $(\omega, \xi)$ is a good environment-scenery along $\left(m_{k}\right)_{k \geq 1}$, i.e., $(\omega, \xi) \in A\left(m_{k}\right)$, for all $k \geq 1$.

Let $\left(m_{k}\right)_{k \geq 1}$ be the sequence introduced in Proposition 3.1. For each realization of $(\omega, \xi)$, we extract $\left(n_{k}\right)_{k \geq 1}$ from $\left(m_{k}\right)_{k \geq 1}$ such that

To ease notations, we write throughout the paper, $d_{k}^{+}:=d^{+}\left(n_{k}\right), \tau_{k}^{+}:=\tau\left(d_{k}^{+}\right), b_{k}^{+}:=$ $b^{+}\left(n_{k}\right)$ and $d_{k}^{-}:=d^{-}\left(n_{k}\right), \tau_{k}^{-}:=\tau\left(d_{k}^{-}\right)$. Moreover, we define, for all $k \geq 1$,

Proposition 3.2 For $P \otimes Q$ almost all $(\omega, \xi)$, we have that, $P_{\omega}$-a.s., for all large $k$,

L\left(t_{k}, \Theta_{-1}\left(n_{k}\right)\right) & \leq \varepsilon_{-1}\left(n_{k}\right) t_{k},  \tag{3.20}\\
L\left(t_{k}, \Theta_{i}\left(n_{k}\right)\right) & \leq \varepsilon_{i}\left(n_{k}\right) t_{k}, \quad 0 \leq i \leq M-2,  \tag{3.21}\\
\tau_{k}^{+} \wedge \tau_{k}^{-} & >t_{k} . \tag{3.22}
\end{align*}
$$

Proof of Theorem 1.1.
Proof of part (i). For any $\delta>0$, we define $\varepsilon^{(\delta)}(j):=\sum_{i=-1}^{M-2} \varepsilon_{i}^{(\delta)}(j)$. Recalling (1.6), we use Proposition 3.2 and (3.1) to obtain, for $\mathbb{P} \otimes Q$-almost all realization of $\omega, \xi$ and $\left(X_{j}\right)_{j \geq 0}$,

\sum_{j=1}^{t_{k}} \xi\left(X_{j}\right) \geq\left(1-\varepsilon^{(1)}\left(n_{k}\right)\right) t_{k}\left(\min _{x \in \Theta_{M-1}\left(n_{k}\right)} \xi_{x}\right)-\sum_{i=-1}^{M-2} \varepsilon_{i}\left(n_{k}\right) t_{k}\left(\max _{x \in \Theta_{i}\left(n_{k}\right)} \xi_{x}^{-}\right)
$$

Then, Proposition 3.1 implies

& \geq\left(1-\varepsilon^{(1)}\left(n_{k}\right)\right) t_{k}(a-\rho)-\varepsilon^{(1 / 2)}\left(n_{k}\right) t_{k} \tag{3.23}
\end{align*}
$$

for all large $k$.
We claim that, for any $\delta>0$ and all large $j$,

\varepsilon^{(\delta)}=\varepsilon^{(\delta)}(j):=\sum_{i=-1}^{M} \varepsilon_{i}^{\delta} \leq 2\left(1+\frac{1}{\delta}\right) \varepsilon_{M}^{\delta} . \tag{3.24}

To prove (3.24), we observe that

Recalling (3.3), we have that $\varepsilon_{i+1}-\varepsilon_{i}=\varepsilon_{i+1}\left(1-\mathrm{e}^{-c_{4}\left(\gamma_{i+2}-\gamma_{i+3}\right)}\right)$. Recalling (3.2) we get that $\gamma_{i+2}-\gamma_{i+3}=\gamma_{i+2}\left(1-\gamma_{i+2}^{-\alpha}\right)$. Since (3.2) and (3.4) imply $\gamma_{i+2} \geq \gamma_{M+2} \geq\left(\log _{2} j\right)^{\frac{(1-\alpha)^{3}}{2+\varepsilon^{\prime}}}$ for $2 \leq i \leq M+2$, we obtain that $\gamma_{i+2}-\gamma_{i+3} \geq \gamma_{i+2} / 2$, for all large $j$ and for $2 \leq i \leq M-1$. Therefore, we get $\varepsilon_{i+1}-\varepsilon_{i} \geq \varepsilon_{i+1} / 2$, implying that

Moreover, $\sum_{i=0}^{M-1} \int_{\varepsilon_{i}}^{\varepsilon_{i+1}} \frac{\varepsilon_{i}^{\delta}}{\varepsilon_{i+1}} d x \leq \sum_{i=0}^{M-1} \int_{\varepsilon_{i}}^{\varepsilon_{i+1}} x^{\delta-1} d x=\int_{\varepsilon_{0}}^{\varepsilon_{M}} x^{\delta-1} d x \leq \varepsilon_{M}^{\delta} / \delta$, which implies (3.24).

Recalling (3.23) and using (3.24) which tells us that $\varepsilon^{(\delta)}(j) \rightarrow 0$ when $j \rightarrow \infty$, we have

Proof of part (ii). Using Theorem 1.5 of [13], we have that, for any $\varepsilon^{\prime}>0, \mathbb{P}$-almost surely, $\max _{0 \leq i \leq n} X_{i} \geq(\log n)^{2-\varepsilon^{\prime}}+1$, for all large $n$. This implies

By assumption, there exists $\varepsilon>0$ such that $Q\left\{\xi_{0}<-\lambda\right\} \geq(\log \lambda)^{-2+\varepsilon}$. Therefore, fixing $\varepsilon^{\prime}<\varepsilon$, we get for $k \geq 1$ and all $N \geq 1$,

where $\delta:=1-\frac{2-\varepsilon}{2-\varepsilon^{\prime}}>0$.
We choose $N_{p}:=\left\lfloor(\log p)^{T}\right\rfloor$ for $p \geq 1$ with $T$ large enough such that $T \delta>1$. Therefore, using (3.27) and applying the Borel-Cantelli lemma, we get that $Q$-almost surely, for $p \geq p_{0}$,

Fixing the realization of $\xi$, we define $p(n)$ such that

for all $n$ such that $p(n) \geq p_{0}$. This yields

the last inequality being a consequence of (3.28). Therefore, we obtain

& \geq k \operatorname{kan} \exp \left\{-\left(N_{p(n)+1}^{\frac{1}{2-\varepsilon^{\prime}}}-N_{p(n)}^{\frac{1}{2-\varepsilon^{\prime}}}\right)\right\},
\end{aligned}
$$

the second inequality being a consequence of (3.29). Moreover, we easily get that $N_{p(n)+1}^{\frac{1}{2-\varepsilon^{r}}}-$ $N_{p(n)}^{\frac{1}{2-\varepsilon^{\prime}}} \rightarrow 0$, when $n \rightarrow \infty$, implying that for all large $n$,

Assembling (3.26) and (3.30), we get that $\mathbb{P} \otimes Q$-almost surely, $\lim _{\sup _{n \rightarrow \infty} \frac{1}{n} \sum_{i=0}^{n} \xi\left(X_{i}\right) \leq, ~}^{\text {al }}$ $a\left(1-\frac{k}{2}\right)$. This inequality being true for all $k \geq 1$, it implies part (ii) of Theorem 1.1.

## 4 Proof of Proposition 3.2

To get (3.22), we observe that

\end{aligned}
$$

By (2.3), (3.10) and (3.1), we get, for all large $k$,

Chebyshev's inequality, (2.4), (3.17) and (3.1) yield

P_{\omega}\left\{\lambda_{k} \leq \tau\left(b_{k}^{+}\right) \leq \tau_{k}^{-}\right\} \leq \frac{\left(b_{k}^{+}-d_{k}^{-}\right)^{2}}{\lambda_{k}} \mathrm{e}^{2 n_{k} / 3} \leq \frac{2 n_{k}^{2\left(2+\varepsilon^{\prime}\right)}}{\lambda_{k}} \mathrm{e}^{2 n_{k} / 3}
$$

Choosing $\lambda_{k}:=\mathrm{e}^{5 n_{k} / 6}$, we obtain, for all large $k$,

P_{\omega}\left\{\lambda_{k} \leq \tau\left(b_{k}^{+}\right) \leq \tau_{k}^{-}\right\}+P_{\omega}\left\{\tau_{k}^{-} \leq \tau\left(b_{k}^{+}\right)\right\} \leq \mathrm{e}^{-n_{k} / 7} \tag{4.1}
\end{equation*}
$$

To treat $P_{k, i}:=P_{\omega}^{b^{+}}\left\{L\left(t_{k}, \Theta_{i}\left(n_{k}\right)\right) \geq \varepsilon_{i}\left(n_{k}\right) t_{k}-\lambda_{k}\right\}$, we recall (3.19) and observe that $\lambda_{k} \leq$ $2 \mathrm{e}^{-n_{k} / 6} t_{k}$, to obtain

P_{k, i} \leq P_{\omega}^{b_{k}^{+}}\left\{L\left(t_{k}, \Theta_{i}\left(n_{k}\right)\right) \geq\left(\varepsilon_{i}\left(n_{k}\right)-2 \mathrm{e}^{-n_{k} / 6}\right) t_{k}\right\}
$$

Then, by Chebyshev's inequality, we get

P_{k, i} \leq \frac{1}{\left(\varepsilon_{i}\left(n_{k}\right)-2 \mathrm{e}^{-n_{k} / 6}\right) t_{k}} E_{\omega}^{b_{k}^{+}}\left[L\left(t_{k}, \Theta_{i}\left(n_{k}\right)\right)\right]
$$

Since Sinai's walk can not make more than $t_{k}$ excursions from $b_{k}^{+}$to $b_{k}^{+}$before $t_{k}$, and since these excursions are i.i.d., we obtain

P_{k, i} \leq \frac{t_{k}}{\left(\varepsilon_{i}\left(n_{k}\right)-2 \mathrm{e}^{-n_{k} / 6}\right) t_{k}} E_{\omega}^{b_{k}^{+}}\left[L\left(\tau\left(b_{k}^{+}\right), \Theta_{i}\left(n_{k}\right)\right)\right]
$$

Observe that (2.7) implies $E_{\omega}^{b_{k}^{+}}\left[L\left(\tau\left(b_{k}^{+}\right), \Theta_{i}\left(n_{k}\right)\right)\right] \leq c_{3} \sum_{x \in \Theta_{i}\left(n_{k}\right)} \mathrm{e}^{-\left[V(x)-V\left(b_{k}^{+}\right)\right]}$, for all $0 \leq$ $i \leq M-2$. Recalling (3.11), we get for all large $k$, and for $0 \leq i \leq M-2$,

P_{k, i} \leq \frac{c_{3}\left(\varepsilon_{i}\left(n_{k}\right)\right)^{2}}{\left(\varepsilon_{i}\left(n_{k}\right)-2 \mathrm{e}^{-n_{k} / 6}\right)} \leq c_{9} \varepsilon_{i}\left(n_{k}\right)
$$

the second inequality being a consequence of $\varepsilon_{i}\left(n_{k}\right) \geq \varepsilon_{0}\left(n_{k}\right)$ and the fact that $c_{4}<1 / 6$ implies $\mathrm{e}^{-n_{k} / 6}=o\left(\varepsilon_{0}\left(n_{k}\right)\right)$.

Summing from 0 to $M-2$ and using (3.24), we get, with $c_{10}:=2\left(1+\frac{1}{\delta}\right) c_{9}$,

\sum_{i=0}^{M-2} P_{k, i} \leq c_{9} \sum_{i=0}^{M-2} \varepsilon_{i}\left(n_{k}\right) \leq c_{10} \varepsilon_{M}\left(n_{k}\right) \tag{4.2}
\end{equation*}
$$

Assembling (4.1), (4.2) and recalling (3.5), (3.18) we obtain

\sum_{k \geq 1} \sum_{i=0}^{M-2} P_{\omega}\left\{L\left(t_{k}, \Theta_{i}\left(n_{k}\right)\right) \geq \varepsilon_{i}\left(n_{k}\right) t_{k}\right\} \leq \sum_{k \geq 1}\left(c_{10} \varepsilon_{M}\left(n_{k}\right)+M\left(n_{k}\right) \mathrm{e}^{-n_{k} / 7}\right)<\infty
$$

This implies (3.21) by an application of the Borel-Cantelli lemma.
We get (3.20) by an argument very similar to the one used in the proof of (3.21), the main ingredients being the facts that $V(x)-V\left(b^{+}\left(n_{k}\right)\right) \geq 2 n_{k}$, for $x \in \Theta_{-1}\left(n_{k}\right)$ (which is a consequence of (3.12), (3.9) and the definition of $\left.d^{+}(j)\right)$, and that $\Theta_{-1}\left(n_{k}\right)$ contains less than $2 c_{7} n_{k}^{2+\varepsilon^{\prime}}$ sites (by (3.8)). We feel free to omit the details.

## 5 Proof of Proposition 3.1

We now prove that, for $P \otimes Q$-almost all $(\omega, \xi)$, there exists a sequence $\left(m_{k}\right)$ such that $(\omega, \xi) \in A\left(m_{k}\right), \forall k \geq 1$, where $A\left(m_{k}\right)$ is defined in (3.16).

Let $j_{k}:=k^{3 k}(k \geq 1)$ and $\mathcal{F}_{j_{k-1}}:=\sigma\left\{V(x), \xi_{z}, d^{-}\left(j_{k-1}\right) \leq x, z \leq d^{+}\left(j_{k-1}\right)\right\}$.
If we are able to show that

\sum_{k} P \otimes Q\left\{A\left(j_{k}\right) \mid \mathcal{F}_{j_{k-1}}\right\}=\infty, \quad P \otimes Q \text {-a.s. } \tag{5.1}
\end{equation*}
$$

then Lévy's Borel-Cantelli lemma ([6], p. 237) will tell us that $P \otimes Q$-almost surely there are infinitely many $k$ such that $(\omega, \xi) \in A\left(j_{k}\right)$.

To bound $P \otimes Q\left\{A\left(j_{k}\right) \mid \mathcal{F}_{j_{k-1}}\right\}$ from below, we start with the trivial inequality $A\left(j_{k}\right) \supset$ $A\left(j_{k}\right) \cap C\left(j_{k-1}\right)$, for any set $C\left(j_{k-1}\right)$. We choose $C\left(j_{k-1}\right):=C^{e n v}\left(j_{k-1}\right) \cap D^{e n v}\left(j_{k-1}\right) \cap$ $C^{s c e}\left(j_{k-1}\right)$, where

C^{e n v}\left(j_{k-1}\right) & :=\left\{\inf _{0 \leq y \leq d^{+}\left(j_{k-1}\right)} V(y) \geq-j_{k-1} \log ^{2} j_{k-1}\right\} \\
D^{e n v}\left(j_{k-1}\right) & :=\left\{\inf _{d^{-}\left(j_{k-1}\right) \leq y \leq 0} V(y) \geq-j_{k-1} \log ^{2} j_{k-1}\right\} \\
C^{s c e}\left(j_{k-1}\right) & :=\left\{\max _{d^{-}\left(j_{k-1}\right) \leq x \leq d^{+}\left(j_{k-1}\right)} \xi_{x}^{-}<\left(\varepsilon_{-1}\left(j_{k}\right)\right)^{-1 / 2}\right\} .
\end{aligned}
$$

Clearly, $C\left(j_{k-1}\right)$ is $\mathcal{F}_{j_{k-1}}$-measurable. Moreover on $C^{e n v}\left(j_{k-1}\right) \cap A^{e n v}\left(j_{k}\right)$, we have $d^{+}\left(j_{k-1}\right) \leq$ $d^{+}\left(\left(-\infty,-j_{k}\right]\right) \leq b^{+}\left(j_{k}\right)$.

Let

$$
E_{-1}^{s c e}\left(j_{k}\right):=\left\{\max _{x \in \Theta_{-1} \backslash\left[d^{-}\left(j_{k-1}\right), d^{+}\left(j_{k-1}\right)\right]} \xi_{x}^{-}<\left(\varepsilon_{-1}\left(j_{k}\right)\right)^{-1 / 2}\right\}
$$

and consider

$$
E^{s c e}\left(j_{k}\right):=\bigcap_{i=0}^{M-1} A_{i}^{s c e}\left(j_{k}\right) \cap E_{-1}^{s c e}\left(j_{k}\right) .
$$

Since $C^{s c e}\left(j_{k-1}\right) \cap E_{-1}^{s c e}\left(j_{k}\right) \subset A_{-1}^{s c e}\left(j_{k}\right)$, it follows that

\begin{aligned}
& P \otimes Q\left\{A\left(j_{k}\right) \mid \mathcal{F}_{j_{k-1}}\right\} \\
\geq & P \otimes Q\left\{P \otimes Q\left\{A^{e n v}\left(j_{k}\right), B^{e n v}\left(j_{k}\right), E^{s c e}\left(j_{k}\right), C\left(j_{k-1}\right) \mid \mathcal{F}_{j_{k-1}}, \omega\right\} \mid \mathcal{F}_{j_{k-1}}\right\} \\
\geq & P \otimes Q\left\{\mathbf{1}_{\left\{A^{e n v}\left(j_{k}\right), B^{e n v}\left(j_{k}\right), C\left(j_{k-1}\right)\right\}} P \otimes Q\left\{E^{s c e}\left(j_{k}\right) \mid \omega\right\} \mid \mathcal{F}_{j_{k-1}}\right\}
\end{aligned}
$$

Now, we suppose for the moment that we are able to prove that there exists $c_{11}>0$ such that, for $P$-almost all $\omega$,

$$
\begin{equation*}
P \otimes Q\left\{E^{s c e}\left(j_{k}\right) \mid \omega\right\} \geq \frac{c_{11}}{k^{1 / 4}} . \tag{5.2}
\end{equation*}
$$

We get

P \otimes Q\left\{A\left(j_{k}\right) \mid \mathcal{F}_{j_{k-1}}\right\} & \geq \frac{c_{11}}{k^{1 / 4}} P \otimes Q\left\{A^{e n v}\left(j_{k}\right), B^{e n v}\left(j_{k}\right), C\left(j_{k-1}\right) \mid \mathcal{F}_{j_{k-1}}\right\} \\
& \geq \frac{c_{11}}{k^{1 / 4}} P_{k}^{+} P_{k}^{-} \mathbf{1}_{C^{s c e}\left(j_{k-1}\right)} \tag{5.3}
\end{align*}
$$

where we use the fact that $(V(x), x \geq 0)$ and $(V(x), x<0)$ are independent processes, and note

$$
\begin{aligned}
P_{k}^{+} & :=P\left\{A^{e n v}\left(j_{k}\right), C^{e n v}\left(j_{k-1}\right) \mid \mathcal{F}_{j_{k-1}}\right\} \\
P_{k}^{-} & :=P\left\{B^{e n v}\left(j_{k}\right), D^{e n v}\left(j_{k-1}\right) \mid \mathcal{F}_{j_{k-1}}\right\}
\end{aligned}
$$

To bound $P_{k}^{+}$from below, we introduce

$$
E_{2}^{e n v}\left(j_{k}\right):=\left\{\max _{0 \leq x \leq y \leq b^{+}\left(j_{k}\right)}[V(y)-V(x)] \leq \frac{j_{k}}{4}-j_{k-1} \log ^{2} j_{k-1}-j_{k-1}-L\right\}
$$

and consider

$$
E^{e n v}(j):=A_{1}^{e n v}(j) \cap A_{a n n}^{e n v}(j) \cap E_{2}^{e n v}\left(j_{k}\right) .
$$

Observe that $C^{e n v}\left(j_{k-1}\right) \cap\left\{\max _{d^{+}\left(j_{k-1}\right) \leq x \leq y \leq b^{+}\left(j_{k}\right)}[V(y)-V(x)] \leq \frac{j_{k}}{4}-j_{k-1} \log ^{2} j_{k-1}-j_{k-1}-\right.$ $L\} \subset A_{2}^{e n v}\left(j_{k}\right)$. Thus, since $V\left(d^{+}\left(j_{k-1}\right)\right) \in I_{j_{k-1}}:=\left[j_{k-1}, j_{k-1}+L\right]$, we have, by applying the strong Markov property at $d^{+}\left(j_{k-1}\right)$,

P_{k}^{+} \geq\left(\inf _{z \in I_{j_{k-1}}} P_{z}\left\{E^{e n v}\left(j_{k}\right)\right\}\right) \mathbf{1}_{C^{e n v}\left(j_{k-1}\right)} \tag{5.4}

To bound $P_{k}^{-}$from below, we observe the following inclusion

B^{e n v}\left(j_{k}\right) \supset\left\{\max _{d^{-}\left(j_{k}\right) \leq x \leq y \leq d^{-}\left(j_{k-1}\right)}[V(y)-V(x)] \leq \frac{j_{k}}{3}\right\} \cap D^{e n v}\left(j_{k-1}\right)
$$

Then since $V\left(d^{-}\left(j_{k-1}\right)\right)$ belongs to $I_{j_{k-1}}$, the strong Markov property applied at $d^{-}\left(j_{k-1}\right)$ yields

Observing that $\mathbf{1}_{C\left(j_{k-1}\right)}=1, P \otimes Q$-almost surely for all large $k$, and recalling (5.3), (5.4) and (5.5), the proof of (5.1) boils down to showing that

\end{align*}

The rest of the section is devoted to the proof of (5.2) and (5.6), whereas (5.7) is an immediate consequence of Donsker's theorem.

### 5.1 Proof of (5.2)

Since the sets $\left\{\Theta_{i}\right\}_{-1 \leq i \leq M-1}$ are disjoint, the events $E_{-1}^{s c e}\left(j_{k}\right)$ and $\left\{A_{i}^{s c e}\left(j_{k}\right)\right\}_{0 \leq i \leq M-1}$ are mutually independent. We write

Thus, (5.2) will be a consequence of the two following lemmas.

Lemma 5.1 For $P$-almost all $\omega$, we have

\end{equation*}
$$

Proof of Lemma 5.1. Recalling (3.15), (3.8) and (3.6), we get, $P$-almost surely,

P \otimes Q\left\{A_{M-1}^{s c e}\left(j_{k}\right) \mid \omega\right\} \geq \exp \left\{c_{5} \log q \log _{2} j_{k}\right\}
$$

where $q:=Q\left\{\xi_{0} \geq a-\rho\right\}$. Definition of $a$ implies $-\infty<\log q<0$. To conclude, it remains only to observe that $\log _{2} j_{k}=\log k+\log _{2} k+\log 3$ and to choose $c_{5}$ small enough such that $c_{5} \log q>-1 / 5$.

Proof of Lemma 5.2. Recalling (3.14) and that $\left(\xi_{x}^{-}\right)_{x \in \mathbb{Z}}$ is a family of i.i.d. random variables, we get, $P$-almost surely, for $0 \leq i \leq M-2$,

& \geq \exp \left\{2 c_{6} \gamma_{i}^{2+\varepsilon^{\prime}} \log \left(1-Q\left\{\xi_{0}^{-} \geq\left(\varepsilon_{i}\right)^{-1 / 2}\right\}\right)\right\} .
\end{aligned}
$$

Then, since $Q\left\{\xi_{0}^{-} \geq\left(\varepsilon_{i}\right)^{-1 / 2}\right\}$ tends to 0 when $k$ tends to $\infty$ and using the fact that $\log (1-$ $x) \geq-c_{13} x$ for $x \in[0,1 / 2)$ with $c_{13}:=2 \log 2>0$, we obtain, for all large $k$,

$$

where $c_{14}:=2 c_{6} c_{13}$. Recalling that $Q\left\{\xi_{0}^{-} \geq \lambda\right\} \leq(\log \lambda)^{-(2+\varepsilon)}$ for $\lambda \geq \lambda_{0}>0$ and (3.3) we get for $k$ large enough and uniformly in $0 \leq i \leq M-2$,

P \otimes Q\left\{A_{i}^{s c e}\left(j_{k}\right) \mid \omega\right\} \geq \exp \left\{-c_{15} \gamma_{i}^{-\beta}\right\} \tag{5.9}
\end{equation*}
$$

where $\beta:=(1-\alpha)^{2}(2+\varepsilon)-\left(2+\varepsilon^{\prime}\right)>0$ by (3.6), and $c_{15}:=c_{14}\left(\frac{2}{c_{4}}\right)^{2+\varepsilon}$. Then, recalling (3.13), we obtain similarly

Putting together (5.9) and (5.10), we get with $c_{17}:=\max \left\{c_{15}, c_{16}\right\}$,

\prod_{i=0}^{M-2} P \otimes Q\left\{A_{i}^{s c e}\left(j_{k}\right) \mid \omega\right\} \times P \otimes Q\left\{E_{-1}^{s c e}\left(j_{k}\right) \mid \omega\right\} \geq \exp \left\{-c_{17} \sigma_{\beta}\right\}
$$

where $\sigma_{\beta}:=\gamma_{0}^{-\beta}+\sum_{i=0}^{M-2} \gamma_{i}^{-\beta}$. By the same way we proved (3.24), we obtain $\sigma_{\beta} \leq c_{18} \gamma_{M-1}^{-\beta}$, where $c_{18} \leq 1+2 / \beta$. Recalling (3.6), it follows that $\sigma_{\beta} \rightarrow 0$ when $k \rightarrow \infty$, which implies (5.8).

### 5.2 Proof of (5.6)

To prove (5.6), we need some preliminary results.

Lemma 5.3 For any $\delta>0, k \geq 1$ and any $0 \leq p \leq M$, we have

Recalling that $\gamma_{i-1}-\gamma_{i} \geq \gamma_{i-1} / 2$, for all large $j$ and for $1 \leq i \leq M$, we get

Moreover, $\sum_{i=p+1}^{M} \int_{\gamma_{i}}^{\gamma_{i-1}} \frac{\gamma_{i}^{\delta}}{\gamma_{i-1}} d x \leq \sum_{i=p+1}^{M} \int_{\gamma_{i}}^{\gamma_{i-1}} x^{\delta-1} d x=\int_{\gamma_{M}}^{\gamma_{p}} x^{\delta-1} d x \leq \gamma_{p}^{\delta} / \delta$, which yields Lemma 5.3.

We now proceed to prove (5.6). Let

Noting $\theta_{k}:=\left\lfloor j_{k} / \gamma_{M}\right\rfloor-1$, we have

P_{z}\left\{E^{e n v}\left(j_{k}\right)\right\} \geq \sum_{\ell=0}^{\theta_{k}} P_{z}\left\{F_{1}^{e n v}\left(j_{k}, \ell\right), A_{a n n}^{e n v}\left(j_{k}\right), E_{2}^{e n v}\left(j_{k}\right)\right\}=: \sum_{\ell=0}^{\theta_{k}} P_{k, \ell}^{+} . \tag{5.11}
\end{equation*}
$$

To bound $P_{k, \ell}^{+}$by below for $0 \leq \ell \leq \theta_{k}$, we define recursively the following levels,

$$
\begin{align*}
\eta_{i}=\eta_{i}\left(j_{k}, \ell\right) & :=a_{\ell}+\gamma_{i}, \quad 0 \leq i \leq M,  \tag{5.12}\\
\eta_{M+1}=\eta_{M+1}\left(j_{k}, \ell\right) & :=a_{\ell} . \tag{5.13}
\end{align*}
$$

In the following, we introduce stopping times for the potential, which will enable us to consider a "typical" event that exhibits a valley having "good" properties. Let us write

Then, we define the stopping times for the potential, for $0 \leq i \leq M$,

R_{i}=R_{i}\left(j_{k}, \ell\right) & :=\min \left\{n \geq T_{i}^{\prime}: V(n) \leq \eta_{M-i+1}\right\}
\end{aligned}
$$

We introduce the events

G_{i}\left(j_{k}\right) & :=\left\{T_{i+1}-T_{i} \leq c_{19}\left(\gamma_{i}\right)^{2+\varepsilon^{\prime}}, \max _{T_{i} \leq x \leq y \leq T_{i+1}}[V(y)-V(x)] \leq \frac{j_{k}}{5}\right\}, \quad 0 \leq i \leq M-1, \\
G_{M}\left(j_{k}\right) & :=\left\{T-T_{M} \leq c_{19}\left(\gamma_{M}\right)^{2+\varepsilon^{\prime}}, \max _{T_{M} \leq x \leq y \leq T}[V(y)-V(x)] \leq \frac{j_{k}}{5}\right\},
\end{aligned}
$$

and

$$
\begin{aligned}
G_{0}^{\prime}\left(j_{k}\right) & :=\left\{T_{0}^{\prime}-T \leq c_{20}\left(\gamma_{M}\right)^{2+\varepsilon^{\prime}}, T_{0}^{\prime}<\tilde{T}\right\} \\
G_{i}^{\prime}\left(j_{k}\right) & :=\left\{T_{i}^{\prime}-T_{i-1}^{\prime} \leq c_{20}\left(\gamma_{M-i}\right)^{2+\varepsilon^{\prime}}, T_{i}^{\prime}<R_{i-1}\right\}, \quad 1 \leq i \leq M
\end{aligned}
$$

We set

$$
G\left(j_{k}, \ell\right):=\bigcap_{i=0}^{M} G_{i}\left(j_{k}\right), \quad G^{\prime}\left(j_{k}, \ell\right):=\bigcap_{i=0}^{M-1} G_{i}^{\prime}\left(j_{k}\right),
$$

and

$$
\begin{aligned}
H\left(j_{k}, \ell\right) & :=\left\{\max _{0 \leq x \leq y \leq T_{0}}[V(y)-V(x)] \leq \frac{j_{k}}{5}\right\}, \\
H^{\prime}\left(j_{k}, \ell\right) & :=\left\{d^{+}\left(j_{k}\right)<R_{M}\right\} .
\end{aligned}
$$

Observe that on $G\left(j_{k}, \ell\right) \cap G^{\prime}\left(j_{k}, \ell\right) \cap H^{\prime}\left(j_{k}, \ell\right)$, we have, for $0 \leq i \leq M-1$,

\left[T_{i}, T_{M-i}^{\prime}\right] \supset\left\{x \in\left[0, d^{+}\left(j_{k}\right)\right]: V(x)-V\left(b^{+}\left(j_{k}\right)\right) \leq \gamma_{i+1}\right\} . \tag{5.14}
\end{equation*}

Moreover, on $G\left(j_{k}, \ell\right) \cap G^{\prime}\left(j_{k}, \ell\right)$,

T_{M-i}^{\prime}-T_{i} \leq\left(c_{20}+c_{19}\right) \sum_{p=i}^{M}\left(\gamma_{p}\right)^{2+\varepsilon^{\prime}}, \quad 0 \leq i \leq M .
$$

If we choose $c_{6}$ such that $c_{6} \geq\left(c_{20}+c_{19}\right)\left(1+\frac{2}{2+\varepsilon^{\prime}}\right)$, we get by Lemma 5.3 that

Recall now (3.8), so that, by assembling (5.14) and (5.15), we have on $G\left(j_{k}, \ell\right) \cap G^{\prime}\left(j_{k}, \ell\right) \cap$ $H^{\prime}\left(j_{k}, \ell\right)$,

An easy calculation gives that, $\sum_{x \in \Theta_{i}\left(j_{k}\right)} \exp \left\{-\left[V(x)-V\left(b^{+}\left(j_{k}\right)\right)\right]\right\} \leq 2 c_{6} \gamma_{i}^{2+\varepsilon^{\prime}} \mathrm{e}^{-\gamma_{i+2}}$, for all $0 \leq i \leq M-2$, on $G\left(j_{k}, \ell\right) \cap G^{\prime}\left(j_{k}, \ell\right) \cap H^{\prime}\left(j_{k}, \ell\right)$. On the other hand, if we choose $c_{4}$ small enough such that $3 c_{4}<1$, we get $2 c_{6} \gamma_{i}^{2+\varepsilon^{\prime}} \mathrm{e}^{-\gamma_{i+2}} \leq \varepsilon_{i}^{2}$, for all large $k$ and uniformly in $0 \leq i \leq M-2$. This implies that $G\left(j_{k}, \ell\right) \cap G^{\prime}\left(j_{k}, \ell\right) \cap H^{\prime}\left(j_{k}, \ell\right) \subset F_{1}^{e n v}\left(j_{k}, \ell\right) \cap A_{\text {ann }}^{e n v}\left(j_{k}\right)$. We easily observe that $G\left(j_{k}, \ell\right) \cap H\left(j_{k}, \ell\right) \subset E_{2}^{e n v}\left(j_{k}\right)$, for all large $k$. Thus we obtain

Recalling (5.11), we get

To bound $P_{z}\left\{G\left(j_{k}, \ell\right), G^{\prime}\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right), H^{\prime}\left(j_{k}, \ell\right)\right\}$ from below, we will apply the strong Markov property several times.

First, we apply the strong Markov property at $T_{M}^{\prime}$. Since $V\left(T_{M}^{\prime}\right) \in I_{\eta_{0}}:=\left[\eta_{0}, \eta_{0}+L\right]$, we have for $z \in I_{j_{k-1}}$,

P_{k, \ell}^{+} \geq P_{z}\left\{G\left(j_{k}, \ell\right), G^{\prime}\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right)\right\} \inf _{y \in I_{\eta_{0}}} P_{y}\left\{d^{+}\left(j_{k}\right) \leq d^{+}\left(\left(-\infty, \eta_{1}\right]\right)\right\}
$$

To bound by below $P_{y}\{\cdots\}$ on the right hand side, observe that $P_{y}\{\cdots\}$ is greater than $P_{\eta_{0}}\{\cdots\}$. Observe that $\eta_{1} \geq-4 j_{k}$ implies $j_{k}-\eta_{1} \leq 5 j_{k}$. Therefore using (2.1), we obtain

$$
P_{\eta_{0}}\left\{d^{+}\left(j_{k}\right) \leq d^{+}\left(\left(-\infty, \eta_{1}\right]\right)\right\} \geq \frac{\eta_{0}-\eta_{1}}{5 j_{k}+L}=\frac{\eta_{0}\left(1-\eta_{0}^{-\alpha}\right)}{5 j_{k}+L} \geq c_{21}
$$

for all large $k$, which implies

$$
P_{k, \ell}^{+} \geq c_{21} P_{z}\left\{G\left(j_{k}, \ell\right), G^{\prime}\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right)\right\}
$$

We now apply the strong Markov property successively at $\left(T_{M-i}^{\prime}\right)_{1 \leq i \leq M}$ and $T$, such that

$$
\begin{equation*}
P_{k, \ell}^{+} \geq c_{21} P_{z}\left\{G\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right)\right\} \inf _{y \in I_{a_{\ell}}} Q_{0, y}^{\prime} \prod_{p=1}^{M} \inf _{y \in I_{\eta_{M-p+1}}} Q_{p, y}^{\prime} \tag{5.16}
\end{equation*}
$$

where

$$
\begin{aligned}
Q_{0, y}^{\prime} & :=P_{y}\left\{d^{+}\left(\eta_{M}\right) \leq c_{20} \gamma_{M}^{2+\varepsilon^{\prime}}, d^{+}\left(\eta_{M}\right)<d^{+}\left(\left(-\infty, a_{\ell+1}\right]\right)\right\} \\
Q_{p, y}^{\prime} & :=P_{y}\left\{d^{+}\left(\eta_{M-p}\right) \leq c_{20} \gamma_{M-p}^{2+\varepsilon^{\prime}}, d^{+}\left(\eta_{M-p}\right)<d^{+}\left(\left(-\infty, \eta_{M-p+2}\right]\right)\right\}, \quad 1 \leq p \leq M
\end{aligned}
$$

First, observe that $\inf _{y \in I_{\eta_{M-p+1}}} Q_{p, y}^{\prime} \geq Q_{p, \eta_{M-p+1}}^{\prime}$, for all $0 \leq p \leq M$. Therefore we only have to bound from below $Q_{p}^{\prime}:=Q_{p, \eta_{M-p+1}}^{\prime}$, for $0 \leq p \leq M$. Clearly,

$$
Q_{p}^{\prime} \geq P_{\eta_{M-p+1}}\left\{d^{+}\left(\eta_{M-p}\right)<d^{+}\left(\left(-\infty, \eta_{M-p+2}\right]\right)\right\}-P_{\eta_{M-p+1}}\left\{d^{+}\left(\eta_{M-p}\right) \leq c_{20} \gamma_{M-p}^{2+\varepsilon^{\prime}}\right\}
$$

By (2.1), we obtain, for $1 \leq p \leq M$,

$$
P_{\eta_{M-p+1}}\left\{d^{+}\left(\eta_{M-p}\right)<d^{+}\left(\left(-\infty, \eta_{M-p+2}\right]\right)\right\} \geq \frac{\eta_{M-p+1}-\eta_{M-p+2}}{\eta_{M-p}-\eta_{M-p+2}+L},
$$

and

$$
P_{\eta_{M+1}}\left\{d^{+}\left(\eta_{M}\right)<d^{+}\left(\left(-\infty, a_{\ell+1}\right]\right)\right\} \geq \frac{\eta_{M+1}-a_{\ell+1}}{\eta_{M}-a_{\ell+1}+L}
$$

Recalling (5.12) and (5.13), we get, for $1 \leq p \leq M$,

$$
P_{\eta_{M-p+1}}\left\{d^{+}\left(\eta_{M-p}\right)<d^{+}\left(\left(-\infty, \eta_{M-p+2}\right]\right)\right\} \geq \frac{\gamma_{M-p+1}}{\gamma_{M-p}}\left(1-\gamma_{M-p}^{-\alpha(1-\alpha)}\right),
$$

and for all large $k$

$$
P_{\eta_{M+1}}\left\{d^{+}\left(\eta_{M}\right)<d^{+}\left(\left(-\infty, a_{\ell+1}\right]\right)\right\} \geq \frac{\gamma_{M}}{2 \gamma_{M}+L}>c_{21}
$$

Moreover, (2.2) yields for $0 \leq p \leq M$,

$$
P_{\eta_{M-p+1}}\left\{d^{+}\left(\eta_{M-p}\right) \leq c_{20} \gamma_{M-p}^{2+\varepsilon^{\prime}}\right\} \leq c_{22} \gamma_{M-p}^{-\varepsilon^{\prime} / 2}
$$

Therefore, recalling (3.7), we obtain $Q_{0}^{\prime} \geq c_{24}>0$ and, for $1 \leq p \leq M$,

$$
Q_{p}^{\prime} \geq \frac{\gamma_{M-p+1}}{\gamma_{M-p}}\left(1-c_{23} \gamma_{M-p}^{-\beta^{\prime \prime}}\right)
$$

where $\beta^{\prime \prime}:=\min \left\{\alpha(1-\alpha), \beta^{\prime}\right\}>0$. Observe that $\gamma_{M-p}^{-\beta^{\prime \prime}} \leq \gamma_{M}^{-\beta^{\prime \prime}}$ for $1 \leq p \leq M$, and that $\gamma_{M}^{-\beta^{\prime \prime}} \rightarrow 0, k \rightarrow \infty$. Recalling the fact that $\log (1-x) \geq-c_{13} x$, for $x \in[0,1 / 2)$, we obtain

$$
\inf _{y \in I_{a_{\ell}}} Q_{0, y}^{\prime} \prod_{p=1}^{M} \inf _{y \in I_{\eta_{M-p+1}}} Q_{p, y}^{\prime} \geq c_{24} \frac{\gamma_{M}}{\gamma_{0}} \exp \left\{-c_{25} \sum_{p=1}^{M} \gamma_{M-p}^{-\beta^{\prime \prime}}\right\}
$$

where $c_{25}:=c_{13} c_{23}$.
Recalling (5.16), and the fact that $\sum_{p=1}^{M} \gamma_{M-p}^{-\beta^{\prime \prime}} \leq c_{26} \gamma_{M}^{-\beta^{\prime \prime}}$, this yields, for all large $k$,

$$
\begin{equation*}
P_{k, \ell}^{+} \geq c_{27} \frac{\gamma_{M}}{\gamma_{0}} P_{z}\left\{G\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right)\right\} \tag{5.17}
\end{equation*}
$$

To bound $P_{z}\left\{G\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right)\right\}$ from below, we apply successively the strong Markov property at $\left(T_{M-i}\right)_{0 \leq i \leq M}$ such that

$$
P_{z}\left\{G\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right)\right\} \geq P_{z}\left\{H\left(j_{k}, \ell\right)\right\} \prod_{p=0}^{M} Q_{p},
$$

where

$$
Q_{p}:=P_{\eta_{p}}\left\{d^{+}\left(\left(-\infty, \eta_{p+1}\right]\right) \leq \min \left\{d^{+}\left(\eta_{p+1}+j_{k} / 5\right), c_{20} \gamma_{p}^{2+\varepsilon^{\prime}}\right\}\right\}, \quad 0 \leq p \leq M
$$

Recall that $P\{A, B\} \geq P\{A\}-P\left\{B^{c}\right\}$. Then (2.2) yields, for $1 \leq p \leq M$,

$$
P_{\eta_{p}}\left\{d^{+}\left(\left(-\infty, \eta_{p+1}\right]\right) \leq c_{20} \gamma_{p}^{2+\varepsilon^{\prime}}\right\} \geq 1-c_{28} \gamma_{p}^{-\varepsilon^{\prime} / 2}
$$

Moreover, using (2.1), we get, for $1 \leq p \leq M$,

$$
P_{\eta_{p}}\left\{d^{+}\left(\eta_{p+1}+j_{k} / 5\right) \leq d^{+}\left(\left(-\infty, \eta_{p+1}\right]\right)\right\} \leq c_{29} \frac{\gamma_{p}}{j_{k}} .
$$

Therefore, observing that, for $1 \leq p \leq M$, we have $\frac{\gamma_{p}}{j_{k}} \leq \frac{\gamma_{1}}{j_{k}}=j_{k}^{-\alpha} \rightarrow 0, k \rightarrow \infty$, and using the fact that $\log (1-x) \geq-c_{13} x$, for $x \in[0,1 / 2)$, we get that

$$
\begin{equation*}
\prod_{p=1}^{M} Q_{p} \geq \exp \left\{-c_{30} \sum_{p=1}^{M}\left(\gamma_{p}^{-\varepsilon^{\prime} / 2}+\frac{\gamma_{p}}{j_{k}}\right)\right\} \tag{5.18}
\end{equation*}
$$

where $c_{30}:=c_{13} \max \left\{c_{28}, c_{29}\right\}$.
Recalling that $\sum_{p=1}^{M} \gamma_{p}^{-\varepsilon^{\prime} / 2} \leq c_{26} \gamma_{M}^{-\varepsilon^{\prime} / 2}$ and $\sum_{p=1}^{M} \gamma_{p} \leq c_{26} \gamma_{1}=o\left(j_{k}\right)$, (5.18) yields that

$$
\begin{equation*}
P_{z}\left\{G\left(j_{k}, \ell\right), H\left(j_{k}, \ell\right)\right\} \geq c_{31} Q_{0} P_{z}\left\{H\left(j_{k}, \ell\right)\right\} . \tag{5.19}
\end{equation*}
$$

Observe that by Donsker's theorem, $\min \left\{P_{z}\left\{H\left(j_{k}, \ell\right)\right\}, Q_{0}\right\} \geq c_{32}$. By assembling (5.17) and (5.19),

$$
P_{k, \ell}^{+} \geq c_{33} \frac{\gamma_{M}}{\gamma_{0}}
$$

where $c_{33}:=c_{27} c_{31} c_{32}^{2}$.

Recalling (5.11) and $\theta_{k}=\left\lfloor j_{k} / \gamma_{M}\right\rfloor-1$, we get, uniformly in $z \in I_{j_{k-1}}$,

$$
P_{z}\left\{E^{e n v}\left(j_{k}\right)\right\} \geq c_{33} \theta_{k} \frac{\gamma_{M}}{\gamma_{0}} \geq c_{34}>0
$$

for all large $k$, which concludes the proof of (5.6).
