# The Kato smoothing effect for Schrödinger equations with unbounded potentials in exterior domains

## 1. Introduction

The Kato $\frac{1}{2}-$ smoothing effect for Schrödinger equations has received much attention during the last years. See Constantin-Saut [C-S], Sjölin [Sj], Vega [V], Yajima [Y] for the case of the flat Laplacian in $\mathbb{R}^{d}$. It has been successively extended to variable coefficients operators by Doi (see [D1], [D2]) and to perturbations of such operators by potentials growing at most quadratically at infinity (see Doi [D3]). The aim of this paper is to consider exterior boundary value problems for variable coefficients operators with unbounded potentials. The case of potentials decaying at infinity has been considered by Burq [B1] using resolvent estimates.

Our main smoothing estimate is proved by contradiction. The idea of proving estimates by contradiction (with the appropriate technology) goes back to Lebeau [L] and it has been subsequently used with success by several authors, (see e.g. Burq [B2]).

In this paper, some ideas of Gérard-Leichtnam [G-L], Burq [B3] and Miller [Mi] will be also used.

Let us briefly outline how this method applies here. Assuming that our estimate is false gives rise, after renormalization, to a sequence $\left(u_{k}\right)$ which is bounded in $L_{l o c}^{2}\left([0, T] \times \mathbb{R}^{d}\right)$. To a subsequence we associate a microlocal semi-classical defect measure $\mu$ in the sense of Gérard [G]. Then, roughly speaking, there are three main steps in the proof. First $\mu$ does not vanish identically. Moreover $\mu$ vanishes somewhere (in the incoming region). Finally the support of $\mu$ is invariant by the generalized bicharacteristic flow (in the sense of Melrose-Sjöstrand [M-S]). Since one of our assumptions (the non trapping condition) ensures that the backward generalized flow always meet the incoming region (where $\mu$ vanishes) we obtain a contradiction thus proving the desired estimate.

[^0]Let us now describe more precisely the content of each section.
In the next one we describe the assumptions and state the main result of this paper. In the third section we begin our contradiction argument and we show in the next one how to obtain a bounded sequence in $L^{2}\left([0, T], L_{\text {loc }}^{2}\left(\mathbb{R}^{d}\right)\right)$. Then in the fifth section we introduce the semi classical defect measure $\mu$ and we state without proof the invariance of its support by the generalized Melrose-Sjöstrand bicharacteristic flow. In the next section we show that $\mu$ does not vanish identically while in section seven we show that $\mu$ vanishes in the incoming region. In the section eight we end the proof of our main result by achieving a contradiction. Finally in the appendix (section nine) we recall the geometrical framework we prove the invariance of the support of $\mu$ and we end by proving some technical Lemmas used in the preceeding sections.

## 2. Statement of the result

Let $K$ be a compact obstacle in $\mathbb{R}^{d}$ whose complement $\Omega$ is a connected open set with $\mathcal{C}^{\infty}$ boundary $\partial \Omega$.

Let $P$ be a second order differential operator of the form

whose coefficients $a^{j k}$ and $V$ are assumed (for simplicity) to be in $\mathcal{C}^{\infty}(\bar{\Omega})$, real valued and $a^{j k}=a^{k j}, 1 \leq j, k \leq d$

We shall set

and we shall assume that

To express the remaining assumptions on the coefficients we introduce the metric

where $\langle\cdot\rangle=\left(1+|\cdot|^{2}\right)^{1 / 2}$ and we shall denote by $S_{\Omega}(M, g)$ the Hörmander's class of symbols if $M$ is a weight. Then $a \in S_{\Omega}(M, g)$ iff $a \in \mathcal{C}^{\infty}\left(\bar{\Omega} \times \mathbb{R}^{d}\right)$ and for all $\alpha, \beta$ in $\mathbb{N}^{d}$ one can find $C_{\alpha, \beta}>0$ such that

for all $x$ in $\bar{\Omega}$ and $\xi$ in $\mathbb{R}^{d}$.
Next we assume

(i i) V \in S_{\Omega}\left(\langle x\rangle^{2}, g\right), V \geq-C_{0} \text { for some positive constant } C_{0}
\end{array}\right.
$$

Under the assumptions (2.3), (2.5) the operator $P$ is essentially self adjoint on $\{u \in$ $\left.\mathcal{C}_{0}^{\infty}(\bar{\Omega}): u_{\mid \partial \Omega}=0\right\}$. We shall denote by $P_{D}(D$ means Dirichlet) its self adjoint extension.

Let us describe now our geometrical assumptions. We shall assume

This assumption needs some explanations. Let $M=\Omega \times \mathbb{R}_{t}$. Let us set $T_{b}^{*} M=T^{*} M \backslash$ $\{0\} \cup T^{*} \partial M \backslash\{0\}$. We have a natural restriction map $\pi: T^{*} \mathbb{R}_{\mid \bar{M}}^{d+1} \backslash\{0\} \rightarrow T_{b}^{*} M$ which is the identity on $T^{*} \mathbb{R}_{\mid M}^{d+1} \backslash\{0\}$.

Let $\Sigma=\left\{(x, t, \xi, \tau) \in T^{*} \mathbb{R}^{d+1} \backslash\{0\}: x \in \bar{\Omega}, t \in[0, T], \tau+p(x, \xi)=0\right\}$ and $\Sigma_{b}=\pi(\Sigma)$. For $a \in \Sigma_{b}$ the generalized bicharacteristic $\Gamma(t, a)$ lives in $\Sigma_{b}$ (see section 9.1 for details). Then (2.6) means the following.

For any $a$ in $\Sigma_{b}$ there exists $s_{0}$ such that for all $s \leq s_{0}$ we have $\Gamma(s, a) \subset T^{*} M \backslash\{0\}$, then $\Gamma(s, a)=(x(s), t, \xi(s), \tau)$ where $(x(s), \xi(s))$ is the usual flow of $p$ and $\lim _{s \rightarrow-\infty}|x(s)|=+\infty$.

We shall need another assumption on the flow whose precise meaning will be given in the appendix, section 9.1, Definition 9.3.

Now we set

which is well defined by the functionnal calculus of self adjoint positive operators.
We shall consider the problem

where $u_{0} \in L^{2}(\Omega)$.
Then we can state our main result.

Theorem 2.1. Let $T>0, \chi \in \mathcal{C}_{0}^{\infty}(\bar{\Omega}), s \in[-1,1]$. Let $P$ be defined by (2.1) satisfying the assumptions (2.3), (2.5), (2.6) and (2.7). Then one can find a positive constant $C(T, \chi, s)=C$ such that

for all $u_{0}$ in $\mathcal{C}_{0}^{\infty}(\Omega)$, where $u$ denotes the solution of (2.9).
Here are some remarks

## Remarks 2.2.

(i) Theorem 2.1 can be extended to operators of the form

P=\sum_{j, k=1}^{d}\left(D_{j}-b_{j}(x)\right) a^{j k}(x)\left(D_{k}-b_{k}(x)\right)+V(x)
$$

where $b_{j} \in S_{\Omega}(\langle x\rangle, g)$.
(ii)In the case $\Omega=\mathbb{R}^{d}$ the above result has been proved by Doi [D3].
(iii) Without lack of generality one may assume $s=0$ in the theorem.

Moreover working with $\widetilde{u}(t)=\mathrm{e}^{-i\left(1+C_{0}\right) t} u(t)$ one may assume $V \geq 1$ in (2.5) (ii) and $\Lambda_{D}=P_{D}^{1 / 2}$ which we will assume in that follows.

## 3. The contradiction argument

Our goal is to begin the proof by contradiction of Theorem 2.1. We shall first consider a version of the estimate which is localized in frequency.

Let $T>0$ and $I=] 0, T\left[\right.$. Let $\theta \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ be such that $\operatorname{supp} \theta \subset\left\{t: \frac{1}{2} \leq|t| \leq 2\right\}$.
Theorem 3.1. Let $\chi_{0} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ be fixed. There exists $C>0, h_{0}>0$ such that for all $h$ in $] 0, h_{0}[$ we have

for all $u_{0} \in L^{2}(\Omega)$.
Here $\theta\left(h^{2} P_{D}\right)$ is defined by the functionnal calculus of selfadjoint operators.
Recall that $K$ is our compact obstacle. We take $R_{0} \geq 1$ so large that

Let $R_{1}>R_{0}$ be such that $\operatorname{supp} \chi_{0} \subset\left\{x \in \mathbb{R}^{d}:|x|<R_{1}\right\}$. Let $\chi_{1} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ be such that $0 \leq \chi_{1} \leq 1$ and

Then $\chi_{0} \chi_{1}=\chi_{0}$. Moreover let us set

It is easy to see that (3.1) will be implied by the following estimate.

We shall prove (3.5) by contradiction. Assuming it is false, taking $h_{0}=\frac{1}{k}, C=k, k \in \mathbb{N}^{*}$, we deduce sequences $\left(h_{k}\right) \rightarrow 0, u_{k}^{0} \in \mathcal{C}_{0}^{\infty}(\Omega)$, such that

It follows that the left hand side does not vanish. Therefore if we set

we see that

4. The sequence $\left(w_{k}\right)$ is bounded in $L^{2}\left(\mathbb{R}, L_{\text {loc }}^{2}\left(\mathbb{R}^{d}\right)\right)$

We shall prove in this section the following result.

Proposition 4.1. For any $\chi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ one can find a positive constant $C$ such that

## Proof

We begin by extending to the whole $\mathbb{R}^{d}$ the operator $P$ given in (2.1).
Let $\chi_{2} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ be such that $0 \leq \chi_{2} \leq 1$ and

(i v) & \widetilde{V}=\chi_{2}+\left(1-\chi_{2}\right) V \in S\left(\langle x\rangle^{2}, g\right) \text { and } \widetilde{V} \geq 1, \\
(v) & \text { The flow of } \widetilde{p} \text { in non trapping. }

Let $\chi_{3} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ be such that $0 \leq \chi_{3} \leq 1$ and with $R_{1}$ defined in (3.3),

According to conditions (ii) to $(v)$ in (4.5) we may apply Theorem 2.8 in [D3] with $s=-\frac{1}{2}$. It follows that for any $\chi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ and any $\nu>0$ we have,

where $E_{s}$ is the pseudo-differential operator with symbol $e_{s}(x, \xi)=\left(1+\widetilde{p}(x, \xi)+|x|^{2}\right)^{s / 2}$ which belongs to $S\left((|\xi|+\langle x\rangle)^{s}, g\right)$.

To handle the first term in the right hand side of (4.12) we shall need the following Lemma.
Lemme 4.2. Let $Q=P_{D}^{\frac{1}{2}}\left(1-\chi_{3}\right) A_{-1}$ where $A_{-1} \in \mathcal{O} p S\left((|\xi|+\langle x\rangle)^{-1}, g\right)$. Then $Q$ is bounded from $L^{2}\left(\mathbb{R}^{d}\right)$ to $L^{2}(\Omega)$.

## Proof

Let $\mathcal{V}(\Omega)=\left\{u \in H_{0}^{1}(\Omega): V^{\frac{1}{2}} u \in L^{2}(\Omega)\right\}$ endowed with the norm $\|u\|_{\mathcal{V}(\Omega)}^{2}=\|u\|_{H^{1}}^{2}+$ $\left\|V^{\frac{1}{2}} u\right\|_{L^{2}}^{2}$. It is well known that $\mathcal{V}(\Omega)$ is the domain of $P_{D}^{\frac{1}{2}}$ and that $\|u\|_{\mathcal{V}(\Omega)}$ is equivalent to $\left\|P_{D}^{\frac{1}{2}} u\right\|_{L^{2}(\Omega)}$. Moreover since $|V|^{\frac{1}{2}} \leq C\langle x\rangle$ we have,

It follows that we can write

Now let us set $(1)=\left\|E_{-\frac{1}{2}} U_{k}(0)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}$. According to (4.11) we have,

\text { (1) } \leq C\left\|E_{-\frac{1}{2}}\left(1-\chi_{3}\right) h_{k}^{-\frac{1}{2}} \theta_{1}\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}^{0}\right\|_{L^{2}}^{2}=C\left\|E_{-\frac{1}{2}}\left(1-\chi_{3}\right) P_{D}^{\frac{1}{4}} \theta\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}^{0}\right\|_{L^{2}}^{2}
$$

Introducing $S=E_{-\frac{1}{2}}\left(1-\chi_{3}\right) P_{D}^{\frac{1}{4}}$ we can write

\begin{aligned}
& \text { (1) } \leq C\left(S \theta\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}^{0}, S \theta\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}^{0}\right)=\left(\theta\left(h_{k}^{2} P_{D}\right) S^{*} S \theta\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}^{0}, \widetilde{u}_{k}^{0}\right) \\
& \text { (1) } \leq C\left\|\theta\left(h_{k}^{2} P_{D}\right) S^{*} S \theta\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}^{0}\right\|_{L^{2}}\left\|\widetilde{u}_{k}^{0}\right\|_{L^{2}}
\end{aligned}
$$

Now

$$
S^{*} S=P_{D}^{-\frac{1}{4}} P_{D}^{\frac{1}{2}}\left(1-\chi_{3}\right) A_{-1}\left(1-\chi_{3}\right) P_{D}^{\frac{1}{4}}=P_{D}^{-\frac{1}{4}} Q\left(1-\chi_{3}\right) P_{D}^{\frac{1}{4}}
$$

where $Q$ has been defined in Lemme 4.2 and $A_{-1}=E_{-\frac{1}{2}}^{*} E_{-\frac{1}{2}}$.
Using (3.4) we obtain

(1) \leq C\left\|h_{k}^{\frac{1}{2}} \theta_{2}\left(h_{k}^{2} P_{D}\right) Q h_{k}^{-\frac{1}{2}}\left(1-\chi_{3}\right) \theta_{1}\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}^{0}\right\|_{L^{2}}\left\|\widetilde{u}_{k}^{0}\right\|_{L^{2}}
$$

Since the operators $\theta_{j}\left(h_{k}^{2} P_{D}\right), j=1,2$, are uniformly bounded in $L^{2}(\Omega)$, using Lemma 4.2 and (3.7) we obtain

\left\|E_{-\frac{1}{2}} U_{k}(0)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \leq C\left\|\widetilde{u}_{k}^{0}\right\|_{L^{2}(\Omega)}^{2} \leq C \tag{4.13}
\end{equation*}
$$

with a uniforn constant $C>0$.
We claim now that we have (see (4.11)), uniformly in $k \geq 1$,

\int_{0}^{T}\left\|\langle x\rangle^{\frac{1+\nu}{2}} E_{-1} G_{k}(t)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \mathrm{~d} t=\mathcal{O}(1) \tag{4.14}
\end{equation*}
$$

By (4.7) we can write $G_{k}=\left[\widetilde{P}, \chi_{3}\right] \chi_{1} w_{k}$. Moreover the symbolic calculus shows that the symbol of $\left[\widetilde{P}, \chi_{3}\right]$ belongs to $S\left(\frac{\langle\xi\rangle^{2}}{\langle x\rangle\langle\xi\rangle}, g\right)$.

It follows that the symbol of $\langle x\rangle^{\frac{1+\nu}{2}} E_{-1}\left[\widetilde{P}, \chi_{3}\right]$ belongs to $S(M, g)$ where

$$
M(x, \xi)=\frac{\langle x\rangle^{\frac{1+\nu}{2}}}{\langle x\rangle+\langle\xi\rangle} \cdot \frac{\langle\xi\rangle^{2}}{\langle x\rangle\langle\xi\rangle} \leq C
$$

This operator is therefore $L^{2}$ bounded, so using (3.7) we obtain

\int_{0}^{T}\left\|\langle x\rangle^{\frac{1+\nu}{2}} E_{-1} G_{k}(t)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \mathrm{~d} t \leq C^{\prime} \int_{0}^{T}\left\|\chi_{1} w_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t \leq C^{\prime}
$$

which proves (4.14).
Using (4.10), (4.12), (4.13) and (4.14) we conclude that

\int_{0}^{T}\left\|\chi\left(1-\chi_{3}\right) w_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t=\mathcal{O}(1) \tag{4.15}
\end{equation*}

Since by (3.7) we have $\int_{0}^{T}\left\|\chi_{1} w_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t=1$ and since by (3.3) and (4.6) we have $\chi_{1}+\left(1-\chi_{3}\right) \geq 1$ we obtain (4.1). The proof of Proposition 4.1 is complete.

## 5. The measure $\mu$ and its properties

We shall set

$$
\left\{\begin{array}{l}
\underline{w}_{k}(t)=\mathbb{1}_{\Omega} w_{k}(t),  \tag{5.1}\\
W_{k}=\mathbb{1}_{[0, T]} \underline{w}_{k} .
\end{array}\right.
$$

It follows from Proposition 4.1 that the sequence $\left(W_{k}\right)$ is bounded in $L^{2}\left(\mathbb{R}_{t}, L_{l o c}^{2}\left(\mathbb{R}^{d}\right)\right)$.
Now to a symbol $a=a(x, t, \xi, \tau) \in \mathcal{C}_{0}^{\infty}\left(T^{*} \mathbb{R}^{d+1}\right)$ we associate the semi-classical pseudodifferential operator (pdo) by the formula

& \mathcal{O} p(a)\left(x, t, h D_{x}, h^{2} D_{t}\right) v(x, t)= \\
& (2 \pi h)^{-(d+1)} \iint \mathrm{e}^{i\left(\frac{x-y}{h} \xi+\frac{t-s}{h^{2}} \tau\right)} \varphi(y) a(x, t, \xi, \tau) v(y, s) \mathrm{d} y \mathrm{~d} s \mathrm{~d} \xi \mathrm{~d} \tau \tag{5.2}
\end{align*}
$$

where $\varphi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ is equal to one on a neighborhood of the $x$-projection of the support of $a$.

We note that by the symbolic calculus the operator $\mathcal{O} p(a)$ is, modulo operators bounded in $L^{2}$ by $\mathcal{O}\left(h^{\infty}\right)$, independant of the function $\varphi$. The following result is classical and introduces the notion of semi-classical defect measure.

Proposition 5.1. There exists a subsequence $\left(W_{\sigma(k)}\right)$ and a Radon measure $\mu$ on $T^{*} \mathbb{R}^{d+1}$ such that for every $a \in \mathcal{C}_{0}^{\infty}\left(T^{*} \mathbb{R}^{d+1}\right)$ one has

$$
\lim _{k \rightarrow+\infty}\left(\mathcal{O} p(a)\left(x, t, h_{\sigma(k)} D_{x}, h_{\sigma(k)}^{2} D_{t}\right) W_{\sigma(k)}, W_{\sigma(k)}\right)_{L^{2}\left(\mathbb{R}^{d+1}\right)}=\langle\mu, a\rangle
$$

Here are the two main properties of the measure $\mu$ which will be used later on.
Theorem 5.2. The support of $\mu$ is contained in the set

$$
\Sigma=\left\{(x, t, \xi, \tau) \in T^{*} \mathbb{R}^{d+1} \backslash\{0\}: x \in \bar{\Omega}, t \in[0, T] \text { and } \tau+p(x, \xi)=0\right\}
$$

## Proof

See section 9.2 in the appendix.
To state the propagation result let us recall some notations. Let $M=\Omega \times \mathbb{R}_{t}$. We set

T_{b}^{*} M=T^{*} M \backslash\{0\} \cup T^{*} \partial M \backslash\{0\} .
$$

We have a natural application of restriction

\pi: T^{*} \mathbb{R}_{\mid \bar{M}}^{d+1} \backslash\{0\} \rightarrow T_{b}^{*} M
$$

which is the identity on $T^{*} \mathbb{R}_{\mid M}^{d+1} \backslash\{0\}$ (see section 9.1 for details).
With $\Sigma$ defined in Theorem 5.2 we set $\Sigma_{b}=\pi(\Sigma)$. The measure $\mu$ has its support in $\Sigma \subset T^{*} \mathbb{R}_{\mid \bar{M}}^{d-1} \backslash\{0\}$ while for $\zeta \in \Sigma_{b}$ the generalized bicharacteristic $\Gamma(t, \zeta)$ lives in $\Sigma_{b}$.

Then we can state an important result of this paper.
Theorem 5.3. Let $\zeta \in \Sigma_{b}$ and $s_{1}, s_{2} \in \mathbb{R}$. Then we have

\pi^{-1}\left(\Gamma\left(s_{1}, \zeta\right)\right) \cap \operatorname{supp} \mu=\emptyset \Longleftrightarrow \pi^{-1}\left(\Gamma\left(s_{2}, \zeta\right)\right) \cap \operatorname{supp} \mu=\emptyset
$$

For the proof, see the appendix, section 9.2.

## 6. The measure $\mu$ does not vanish identically

The purpose of this section is to prove the following results.
Let $A \geq 1, R \geq 1, \psi_{A} \in \mathcal{C}_{0}^{\infty}(\mathbb{R}), \Phi_{R} \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ be such that $0 \leq \psi_{A}, \Phi_{R} \leq 1$ and

$$
\begin{equation*}
\psi_{A}(\tau)=1 \text { if }|\tau| \leq A, \Phi_{R}(t)=1 \text { if }|t| \leq R . \tag{6.1}
\end{equation*}
$$

Proposition 6.1. There exist positive constants $A_{0}, R_{0}, k_{0}$ such that

$$
\begin{equation*}
\int_{\mathbb{R}}\left\|\psi_{A}\left(h_{k}^{2} D_{t}\right) \Phi_{R}\left(h_{k}^{2} \Delta\right) \mathbb{I}_{[0, T]} \chi_{1} \underline{w}_{k}(t)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \mathrm{~d} t \geq \frac{1}{2} \tag{6.2}
\end{equation*}
$$

when $A \geq A_{0}, R \geq R_{0}, k \geq k_{0}$. Here $\chi_{1}, \underline{w}_{k}$ have been defined in (3.3), (5.1) and $\Delta$ is the usual Laplacien.

Corollary 6.2. The measure $\mu$ defined in Proposition 5.1 does not vanish identically.

## Proof

Let $\widetilde{\chi}_{1} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ be such that $\widetilde{\chi}_{1}=1$ on $\operatorname{supp} \chi_{1}$. Let $\varphi=\varphi(t) \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ and $a(x, t, \xi, \tau)=\varphi(t) \chi_{1}(x) \psi_{A}^{2}(\tau) \Phi_{R}^{2}\left(|\xi|^{2}\right) \chi_{1}$. It follows from (6.2) that

$$
\left(a\left(x, t, h D_{x}, h^{2} D_{t}\right) \widetilde{\chi}_{1} \mathbb{I}_{[0, T]} \underline{w}_{k}(t), \mathbb{I}_{[0, T]} \underline{w}_{k}\right)_{L^{2}\left(\mathbb{R}^{d+1}\right)} \geq \frac{1}{3} .
$$

Since the left hand side with the subsequence $\sigma(k)$ tends to $\langle\mu, a\rangle$ when $k \rightarrow+\infty$ the Corollary follows.

## Proof of Proposition 6.1

We shall need the following Lemma.
Lemma 6.3. Let $\theta \in \mathcal{C}_{0}^{\infty}(\mathbb{R}), \chi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$. Then there exists $C>0$ such that
(i) $\left\|\left[\theta\left(h^{2} P_{D}\right), \chi\right] u\right\|_{L^{2}(\Omega)}^{2} \leq C\|h u\|_{L^{2}(\Omega)}^{2}$,
(ii) $\left\|\partial_{j} \theta\left(h^{2} P_{D}\right) u\right\|_{L^{2}(\Omega)}^{2} \leq C\left\|h^{-1} u\right\|_{L^{2}(\Omega)}$,
(iii) $\left\|\partial_{j}\left[\theta\left(h^{2} P_{D}\right), \chi\right] u\right\|_{L^{2}(\Omega)} \leq C\|u\|_{L^{2}(\Omega)}$,
for all $j=1, \cdots, d, h>0$ and $u \in L^{2}(\Omega)$.

## Proof

See the Appendix, section 9.3.
Let us set

$$
\left\{\begin{align*}
I & =\left(\operatorname{Id}-\psi_{A}\left(h^{2} D_{t}\right)\right) \mathbb{1}_{[0, T]} \chi_{1} w_{k}  \tag{6.3}\\
\widetilde{\psi}(\tau) & =\frac{1-\psi(\tau)}{\tau}
\end{align*}\right.
$$

Then $\widetilde{\psi} \in L^{\infty}(\mathbb{R})$ and $|\widetilde{\psi}(\tau)| \leq \frac{1}{A}$ for all $\tau \in \mathbb{R}$.
Now we can write $I=\widetilde{\psi}\left(h_{k}^{2} D_{t}\right) h_{k}^{2} D_{t}\left(\mathbb{1}_{[0, T]} \chi_{1} w_{k}\right)$. Using (3.6) and the fact that $D_{t} \widetilde{u}_{k}=P_{D} \widetilde{u}_{k}$ we deduce that

\left\{\begin{align*}
I & =(1)+(2)  \tag{6.4}\\
(1) & =\frac{1}{i} \widetilde{\psi}\left(h_{k}^{2} D_{t}\right) \chi_{1} h_{k}^{2}\left(w_{k}(0) \delta_{t=0}-w_{k}(T) \delta_{t=T}\right) \\
(2) & =-\widetilde{\psi}\left(h_{k}^{2} D_{t}\right) \mathbb{I}_{[0, T]} \chi_{1} h_{k}^{2} P_{D} h_{k}^{-\frac{1}{2}} \theta_{1}\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}
\end{align*}\right.
$$

## Estimate of (1)

If $a \in \mathbb{R}$, we have $\widetilde{\psi}\left(h_{k}^{2} D_{t}\right) \delta_{t=a}=\overline{\mathcal{F}}\left(\widetilde{\psi}\left(h_{k}^{2} \tau\right) \mathrm{e}^{-i a \tau}\right)$, so by Parseval formula we have

\left\|\widetilde{\psi}\left(h_{k}^{2} D_{t}\right) \delta_{t=a}\right\|_{L^{2}(\mathbb{R})}^{2}=c_{n} \int\left|\widetilde{\psi}\left(h_{k}^{2} \tau\right)\right|^{2} \mathrm{~d} \tau=c_{n} h_{k}^{-2} \int \frac{\left|\psi_{A}(\tau)-1\right|^{2}}{|\tau|^{2}} \mathrm{~d} \tau
$$

It follows from (3.6) that

\int_{\mathbb{R}}\|(1)\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t \leq C h_{k}^{4} h_{k}^{-2} h_{k}^{-1}\left(\left\|\widetilde{u}_{k}(0)\right\|_{L^{2}}^{2}+\left\|\widetilde{u}_{k}(T)\right\|_{L^{2}}^{2}\right)
$$

Applying the energy estimate and (3.7) we obtain

\begin{equation*}
\int_{\mathbb{R}}\|(1)\|_{L^{2}}^{2} \mathrm{~d} t \leq C h_{k}\left\|\widetilde{u}_{k}^{0}\right\|_{L^{2}}^{2}=o(1) . \tag{6.5}
\end{equation*}
$$

## Estimate of (2)

Let $\tilde{\theta} \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ be such that $\tilde{\theta}=1$ on the support of $\theta_{1}$. Then we can write with $\widetilde{\theta}_{1}(t)=t \widetilde{\theta}(t)$

\text { (2) }=-\widetilde{\psi}\left(h_{k}^{2} D_{t}\right)\left[\chi_{1}, \widetilde{\theta}_{1}\left(h_{k}^{2} P_{D}\right)\right] \mathbb{1}_{] 0, T]} h_{k}^{-\frac{1}{2}} \theta_{1}\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}-\widetilde{\psi}\left(h_{k}^{2} D_{t}\right) \widetilde{\theta}_{1}\left(h_{k}^{2} P_{D}\right) \mathbb{1}_{[0, T]} \chi_{1} w_{k}(t)
$$

Using Lemma $6.3(i)$ and the fact that,

$$
\left\|\widetilde{\psi}\left(h_{k}^{2} D_{t}\right)\right\|_{L^{2}(\mathbb{R}) \rightarrow L^{2}(\mathbb{R})}=\mathcal{O}\left(\frac{1}{A}\right),\left\|\widetilde{\theta}_{1}\left(h_{k}^{2} P_{D}\right)\right\|_{L^{2}(\Omega) \rightarrow L^{2}(\Omega)}=\mathcal{O}(1)
$$

uniformly in $k$ we obtain,

$$
\int_{\mathbb{R}}\|(2)\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t \leq \frac{C}{A}\left(\int_{0}^{T}\left\|h_{k}^{\frac{1}{2}} \widetilde{u}_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t+\int_{0}^{T}\left\|\chi_{1} w_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t\right)
$$

Using the energy estimate and (3.7) we deduce that

$$
\begin{equation*}
\int_{\mathbb{R}}\|(2)\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t=o(1)+\mathcal{O}\left(\frac{1}{A}\right) \tag{6.6}
\end{equation*}
$$

Taking $k$ and $A$ sufficiently large and using (3.7), (6.3), (6.4), (6.5), (6.6) we obtain

\int_{\mathbb{R}}\left\|\psi_{A}\left(h_{k}^{2} D_{t}\right) \mathbb{I}_{[0, T]} \chi_{1} w_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \geq \frac{1}{2} . \tag{6.7}
\end{equation*}

Now with $\Phi_{R}$ defined in (6.1) we set

\mathrm{II}=h_{k}^{-\frac{1}{2}}\left(\operatorname{Id}-\Phi_{R}\left(h_{k}^{2} \Delta\right)\right) \psi_{A}\left(h_{k}^{2} D_{t}\right) \mathbb{I}_{[0, T]} \chi_{1} \underline{w}_{k}(t) . \tag{6.8}
\end{equation*}
$$

Since $\operatorname{supp}\left(1-\Phi_{R}(t)\right) \subset\{t \in \mathbb{R}:|t| \geq R\}$ we have by Fourier transform

$$
\begin{equation*}
\left\|\left(\operatorname{Id}-\Phi_{R}\left(h^{2} \Delta\right)\right) h_{k}^{-1} v\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \leq \frac{C}{R} \sum_{j=1}^{d}\left\|\partial_{j} v\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \quad, \quad v \in H^{1}\left(\mathbb{R}^{d}\right) \tag{6.9}
\end{equation*}
$$

Now by (3.6) we have $h_{k}^{-\frac{1}{2}} \underline{w}_{k}=h_{k}^{-1} \underline{v}_{k}, v_{k}=\theta_{1}\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}$.
Thus applying (6.9) we obtain

\int_{\mathbb{R}}\|\mathrm{II}\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \mathrm{~d} t \leq \frac{C}{R} \sum_{j=1}^{d} \int_{\mathbb{R}}\left\|\partial_{j} \psi_{A}\left(h^{2} D_{t}\right) \mathbb{I}_{[0, T]} \chi_{1} \underline{v}_{k}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}
$$

Since $v_{k} \in H_{0}^{1}(\Omega)$ we have

\partial_{j}\left(\chi_{1} \underline{v}_{k}\right)=\partial_{j}\left(\mathbb{I}_{\Omega} \chi_{1} v_{k}\right)=\mathbb{1}_{\Omega} \partial_{j}\left(\chi_{1} v_{k}\right)
$$

It follows that

\int_{\mathbb{R}}\|\mathrm{II}\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \mathrm{~d} t \leq \frac{C}{R} \sum_{j=1}^{d} \int_{\mathbb{R}}\left\|\partial_{j} \psi_{A}\left(h_{k}^{2} D_{t}\right) \mathbb{I}_{[0, T]} \chi_{1} v_{k}\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t
$$

Let $\widetilde{\theta} \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ be such that $\widetilde{\theta}=1$ near the support of $\theta_{1}$. Then $(1-\widetilde{\theta}(t)) \theta_{1}(t)=0$. We first consider

\text { (1) }=\int_{\mathbb{R}}\left\|\partial_{j} \widetilde{\theta}\left(h_{k}^{2} P_{D}\right) \psi_{A}\left(h_{k}^{2} D_{t}\right) \mathbb{I}_{[0, T]} \chi_{1} v_{k}\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t . \tag{6.10}
\end{equation*}
$$

Using Lemma 6.3 (ii) we obtain

\text { (1) } \leq C \int_{\mathbb{R}}\left\|\psi_{A}\left(h_{k}^{2} D_{t}\right) h_{k}^{-1} \mathbb{I}_{[0, T]} \chi_{1} v_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t \leq C^{\prime} \int_{0}^{T}\left\|h_{k}^{-\frac{1}{2}} \chi_{1} w_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t
$$

so by (3.6) we obtain

It remains to consider

(2)=\int_{\mathbb{R}}\left\|\partial_{j}\left(\operatorname{Id}-\widetilde{\theta}\left(h_{k}^{2} P_{D}\right)\right) \psi_{A}\left(h_{k}^{2} D_{t}\right) \mathbb{I}_{[0, T]} \chi_{1} v_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t . \tag{6.12}
\end{equation*}
$$

Since $v_{k}(t)=\theta_{1}\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}$ and $\left(\operatorname{Id}-\widetilde{\theta}\left(h_{k}^{2} P_{D}\right)\right) \theta_{1}\left(h_{k}^{2} P_{D}\right)=0$ we obtain

where $\widetilde{\chi}_{1} \in \mathcal{C}_{0}^{\infty}(\bar{\Omega}), \widetilde{\chi}_{1}=1$ on $\operatorname{supp} \chi_{1}$.
By Lemma 6.3 (iii) we obtain

which is (6.2). The proof of Proposition 6.1 is complete.

## 7. The measure $\mu$ vanishes in the incoming set

We pursue here our reasoning by contradiction in proving that the measure $\mu$ vanishes in the incoming set. Let us state the main result of this section.

Let $\widetilde{P}$ be the operator defined by (4.3) satisfying the conditions (4.5).
Theorem 7.1. Let $m_{0}=\left(x_{0}, t_{0}, \xi_{0}, \tau_{0}\right) \in T^{*} \mathbb{R}^{d+1}$ be such $\xi_{0} \neq 0, \tau_{0}+\widetilde{p}\left(x_{0}, \xi_{0}\right)=0$, $\left|x_{0}\right| \geq 3 R_{0}, \quad \sum_{j, k=1}^{d} \widetilde{a}^{j k}\left(x_{0}\right) x_{0 j} \xi_{0 k} \leq-3 \delta\left|x_{0}\right|\left|\xi_{0}\right|$ (for some $\delta>0$ small enough). Then $m_{0} \notin \operatorname{supp} \mu$

The rest of this section will be devoted to the proof of this result. Il will be a consequence of an estimate which will be proved in constructing an appropriate escape function and will require several Lemmas.

Lemma 7.2. Let us set $e_{0}(x, \xi)=\sum_{j, k=1}^{d} \widetilde{a}^{j k}(x) x_{j} \frac{\xi_{k}}{\langle\xi\rangle}$. Then there exist positive constants $R, C_{0}, C_{1}$ such that

where $H_{\tilde{p}}$ denotes the Hamiltonian field of $\widetilde{P}$.

## Proof

It is an easy computation which uses the conditions (ii) and (iii) in (4.5).
Lemma 7.3. Under condition (v) in (4.5) there exist $e \in S(\langle x\rangle, g)$ and positive constants $C, C^{\prime}, R^{\prime}$ such that

Proof See Doi [D3].
The symbol $e$ is an escape function. However it is not adapted to our situation because its Poisson bracket with our potentiel $\widetilde{V}$ (see (4.5)(iv)) belongs to $S\left(\frac{\langle x\rangle^{2}}{\langle\xi\rangle}, g\right)$ so does not correspond to an operator bounded in $L^{2}$ which will be required later on. We shall describe below a construction by Doi [D3] which will take care of this problem.

Let $\psi \in \mathcal{C}^{\infty}(\mathbb{R})$ be such that $0 \leq \psi \leq 1$ and

\psi_{1}(t)=\psi(-t)-\psi(t)=-(\operatorname{sgn} t) \psi(|t|)

Then $\psi_{j} \in \mathcal{C}^{\infty}(\mathbb{R}), j=1,2$, and we have

\psi_{0}^{\prime}(t)=-(\operatorname{sgn} t) \psi^{\prime}(|t|)  \tag{7.3}\\
\psi_{1}^{\prime}(t)=-\psi^{\prime}(|t|)
\end{array}\right.

Let $\chi \in \mathcal{C}^{\infty}(\mathbb{R})$ be such that $0 \leq \chi \leq 1$ and

\chi(t)=1 \text { if } t \leq \frac{\rho}{2}, \quad \chi(t)=0 \text { if } t \geq \rho, \quad \rho>0 \text { small. } \tag{7.4}
\end{equation*}

With $e$ defined in Lemma 7.3 we set

\end{equation*}
$$

where $\nu>0$ is an arbitrary small constant and $M_{0}$ is a sufficiently large constant.

Lemma 7.4 ( Doi [D3], Lemma 8.3).
(i) $\lambda \in S(1, g)$
(ii) $\left[\widetilde{P}, \mathcal{O} p^{w}(\lambda)\right]-\frac{1}{i}\left(H_{\tilde{p}} \lambda\right)^{w} \in \mathcal{O} p^{w} S(1, g)$
(iii) There exists $M_{0}>0$ such that for any $\nu>0$ there exist $C>0, C^{\prime}>0$ such that $-H_{\tilde{p}} \lambda(x, \xi) \geq C\langle x\rangle^{-1-\nu}(|x|+|\xi|)-C^{\prime}, \quad \forall(x, \xi) \in T^{*} \mathbb{R}^{d}$.

We must now localize this escape function near the incoming set.
We shall need the following Lemma. Let us set

(i) $\operatorname{supp} \Phi \subset\left\{(x, \xi) \in T^{*} \mathbb{R}^{d}:|x| \geq 2 R_{0}, \quad a(x, \xi) \leq-\frac{\delta}{2}|x||\xi|, \quad|\xi| \geq \frac{\left|\xi_{0}\right|}{4}\right\}$,
(ii) $\left\{(x, \xi):|x| \geq \frac{5}{2} R_{0}, \quad a(x, \xi) \leq-\delta|x||\xi|,|\xi| \geq \frac{\left|\xi_{0}\right|}{2}\right\} \subset\{(x, \xi): \Phi(x, \xi)=1\}$,
(iii) $\Phi(x, h \xi)=\Phi(x, \xi)$ when $|h \xi| \geq \frac{\left|\xi_{0}\right|}{2}$ and $0<h \leq 1$,
(iv) $H_{\tilde{p}} \Phi(x, \xi) \leq 0$ on the support of $\lambda$,
$(v) \lambda(x, \xi) \geq 0$ on the support of $\Phi$.

## Proof

Let $\varphi_{j}, j=1,2,3$, be such $\varphi_{j} \in \mathcal{C}^{\infty}(\mathbb{R}), 0 \leq \varphi_{j} \leq 1$ and

Then (i) and (ii) follow immediatly. Now if $|h \xi| \geq \frac{\left|\xi_{0}\right|}{2}$ then $|\xi| \geq \frac{\left|\xi_{0}\right|}{2 h} \geq \frac{\left|\xi_{0}\right|}{2}$ so $\varphi_{3}(h|\xi|)=\varphi_{3}(\xi)=1$ and (iii) follows.

Let us prove (iv). We have

(3)=\varphi_{1}(|x|) \varphi_{2}\left(\frac{a}{|x||\xi|}\right) \varphi_{3}^{\prime}(|\xi|) H_{\tilde{p}}|\xi|
\end{array}\right.
$$

According to (7.4) and (7.5) we have $\widetilde{p}(x, \xi) \geq \frac{1}{\rho^{2}}\langle x\rangle^{2} \geq \frac{1}{\rho^{2}}$ on the support of $\lambda$. Therefore we can choose $\rho$ so small that $|\xi|>\frac{1}{2}\left|\xi_{0}\right|$ on the support of $\lambda$. It follows that $(3)=0$ on this set. Now an easy computation shows that $H_{\tilde{p}}|x|=\frac{2 a(x, \xi)}{|x|}$ when $|x| \geq R_{0}$ which implies that

On the support of $\varphi_{2}$ we have $a \leq-\frac{1}{2} \delta|x||\xi|$. Since $\varphi_{1}^{\prime} \geq 0, \varphi_{2} \geq 0, \varphi_{3} \geq 0$, we conclude that

Let us look to (2). First of all we have on the support of $\Phi$

Since we have (see (4.5)) $\left(\widetilde{a}^{j k}(x)\right) \geq C$ Id, $\left|\nabla_{x} \widetilde{a}^{j k}(x)\right|=o\left(|x|^{-1}\right)$ as $|x| \rightarrow+\infty$ and $|x| \geq R_{0}$ on the support of $\Phi$, taking $R_{0}$ large enough we obtain by an easy computation

H_{\tilde{p}} a(x, \xi) \geq C_{0}|\xi|^{2} \text { on } \operatorname{supp} \Phi . \tag{7.13}
\end{equation*}
$$

We also obtain

H_{\tilde{p}}\left(\frac{1}{|x||\xi|}\right)=-2 \frac{a(x, \xi)}{|\xi||x|^{3}}+o\left(\frac{1}{|x|^{2}}\right) \text { as }|x| \rightarrow+\infty \tag{7.14}
\end{equation*}
$$

It follows from (7.12), (7.13), (7.14) and $|a| \leq C|x||\xi|$ that

On the support of $\varphi_{2}^{\prime}\left(\frac{a}{|x||\xi|}\right)$ we have, by (8.8), $-\delta \leq \frac{a}{|x||\xi|} \leq-\frac{1}{2} \delta$. It follows that $|a| \leq \delta|x||\xi|$ so

Moreover on the support of $\varphi_{1}(|x|)$ we have $|x| \geq R_{0}$. So taking $R_{0}$ large enough and $\delta$ small, we obtain

Finally let us look to the claim $(v)$.
On the support of $\Phi$ we have $|x| \geq R_{0},|\xi| \geq \frac{1}{4}\left|\xi_{0}\right|$ and $a(x, \xi) \leq-\frac{1}{2} \delta|x||\xi|$. It follows that $\langle x\rangle \leq \sqrt{2}|x|,\langle\xi\rangle \leq C|\xi|$ and $a(x, \xi) \leq-C^{\prime} \delta\langle x\rangle\langle\xi\rangle$. Moreover since $|x| \geq R_{0}$, taking $R_{0}$ large enough, we deduce from Lemma 7.3 that $e(x, \xi)=e_{0}(x, \xi)=\frac{a(x, \xi)}{\langle\xi\rangle}$ by (7.7). It follows that $\frac{e}{\langle x\rangle} \leq-C^{\prime} \delta$ which implies that $\frac{|e|}{\langle x\rangle} \geq C^{\prime} \delta$. Using (7.1), (7.2) and taking $\varepsilon \ll \delta$ we see that $\psi_{0}\left(\frac{e}{\langle x\rangle}\right)=0$ and $\psi_{1}\left(\frac{e}{\langle x\rangle}\right) \geq 0$. It follows from (7.5) that $-\lambda=-\left(M_{0}-\langle e\rangle^{-\nu}\right) \psi_{1}\left(\frac{e}{\langle x\rangle}\right) \chi \leq 0$.

The proof of Lemma 7.5 is complete.
Corollary 7.6. Let $\lambda_{1}=\Phi^{2} \lambda$ where $\lambda$ has been defined in Lemma 7.4. Then
(i) $\lambda_{1} \in S(1, g)$,
(ii) $\left[\widetilde{P}, \lambda_{1}^{w}\right]-\frac{1}{i} \mathcal{O} p^{w}\left(H_{\tilde{p}} \lambda_{1}\right) \in \mathcal{O} p^{w} S(1, g)$,
(iii) There exist two positive constants $C, C^{\prime}$ such that

## Proof

(i), (ii) follow from Lemma 7.4 and the fact that $\Phi^{2} \in S(1, g)$. Let us look to (iii). We have

Let now $\left(x_{0}, \xi_{0}\right)$ be given as in Theorem 7.1. We set

Now on the support of $b(x, h \xi)$ we have $h|\xi| \geq \frac{\left|\xi_{0}\right|}{2}$ so it follows from Lemma 7.5(iii) that $\Phi(x, h \xi)=\Phi(x, \xi)$. Therefore

Let now $m_{0}=\left(x_{0}, t_{0}, \xi_{0}, \tau_{0}\right)$ be as in Theorem 7.1.
Let $\varphi_{0} \in \mathcal{C}_{0}^{\infty}(\mathbb{R}), \psi \in \mathcal{C}_{0}^{\infty}(\mathbb{R}), \varphi_{1} \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d}\right)$ be such that

\varphi_{0}\left(t_{0}\right) \neq 0, \quad \psi\left(\tau_{0}\right) \neq 0,  \tag{7.21}\\
\varphi_{1}(x)=1 \text { if }|x| \leq \frac{4}{3} R_{0}, \quad \operatorname{supp} \varphi_{1} \subset\left\{x:|x| \leq \frac{3}{2} R_{0}\right\}
\end{array}\right.
$$

Let

b_{1}(x, \xi)=b(x, \xi)|\xi|^{\frac{1}{2}} \tag{7.22}
\end{equation*}
$$

Then $b_{1} \in \mathcal{C}_{0}^{\infty}\left(B\left(\left(x_{0}, \xi_{0}\right), \varepsilon_{0}\right)\right)$ and $b_{1}\left(x_{0}, \xi_{0}\right) \neq 0$.
Finally let us recall for convenience that in (3.6) and (5.1) we have set

W_{k}(t)=\mathbb{1}_{[0, T]} \underline{w}_{k}(t), \quad \underline{w}_{k}(t)=\mathbb{1}_{\Omega} w_{k}(t),  \tag{7.23}\\
w_{k}(t)=h_{k}^{-\frac{1}{2}} v_{k}(t), \quad v_{k}(t)=\theta_{1}\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}(t) .
\end{array}\right.
$$

Lemma 7.7. We have

$$
\int_{\mathbb{R}}\left\|\varphi_{0}(t) \psi\left(h_{k}^{2} D_{t}\right) b_{1}\left(x, h_{k} D_{x}\right)\left(1-\varphi_{1}(x)\right) W_{k}(t)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \mathrm{~d} t=o(1) \text { as } k \rightarrow+\infty
$$

## Proof

With $\lambda_{1}$ defined in Corollary 7.6 we set

$$
N(t)=\left(\left(M-\left(1-\varphi_{1}\right) \lambda_{1}^{w}\left(1-\varphi_{1}\right)\right) v_{k}(t), v_{k}(t)\right)_{L^{2}(\Omega)},
$$

where $M$ is a large constant and $\lambda_{1}^{w}$ the Weyl quantization of the symbol $\lambda_{1} \in S(1, g)$. Then there exists $C>0$ such that for $k \geq 1$,

\begin{equation*}
\left\|v_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \leq C N(t) \tag{7.24}
\end{equation*}
$$

Setting $\Lambda=M-\left(1-\varphi_{1}\right) \lambda_{1}^{w}\left(1-\varphi_{1}\right)$ and $(.,)=.(., .)_{L^{2}(\Omega)}$ we can write

$$
\frac{\mathrm{d}}{\mathrm{~d} t} N(t)=\left(\Lambda \frac{\mathrm{d}}{\mathrm{~d} t} v_{k}(t), v_{k}(t)\right)+\left(\Lambda v_{k}(t), \frac{\mathrm{d}}{\mathrm{~d} t} v_{k}(t)\right)
$$

Since $\frac{\mathrm{d} v_{k}}{\mathrm{~d} t}=i P_{D} v_{k}$ and $P_{D}$ is self adjoint in $L^{2}(\Omega)$ we have

$$
\frac{\mathrm{d}}{\mathrm{~d} t} N(t)=-i\left(\left[P_{D}, \Lambda\right] v_{k}(t), v_{k}(t)\right)
$$

Now on the support of $1-\varphi_{1}$ we have $|x| \geq \frac{4}{3} R_{0}$. It follows from (4.5)(i) that $\left[P_{D}, \Lambda\right]=$ $[\widetilde{P}, \Lambda]$. Therefore we have,

$$
\left\{\begin{align*}
\frac{\mathrm{d}}{\mathrm{~d} t} N(t) & =(1)+(2)+(3) \text { where },  \tag{7.25}\\
(1) & =-i\left(\left[\widetilde{P}, \varphi_{1}\right] \lambda_{1}^{w}\left(1-\varphi_{1}\right) v_{k}(t), v_{k}(t)\right), \\
(2) & =i\left(\left[\widetilde{P}, \lambda_{1}^{w}\right]\left(1-\varphi_{1}\right) v_{k}(t),\left(1-\varphi_{1}\right) v_{k}(t)\right), \\
(3) & =-\left(\left(1-\varphi_{1}\right) \lambda_{1}^{w}\left[\widetilde{P}, \varphi_{1}\right] v_{k}(t), v_{k}(t)\right) .
\end{align*}\right.
$$

Since $\lambda_{1}=\lambda \Phi^{2}$, Lemma 7.5 shows that the support of $\lambda_{1}$ is contained in $\left\{x:|x| \geq 2 R_{0}\right\}$. By (7.21) the Poisson bracket $\left(\widetilde{p}, \varphi_{1}\right\}$ has its support in $\left\{x: \frac{4}{3} R_{0} \leq|x| \leq \frac{3}{2} R_{0}\right\}$. It follows that $\left\{\widetilde{p}, \varphi_{1}\right\} \lambda_{1} \equiv 0$ from which we deduce that $\left[\widetilde{P}, \varphi_{1}\right] \lambda_{1}^{w}$, is a zero ${ }^{\text {th }}$ order operator. It follows that

$$
\begin{equation*}
|(1)|+\mid\left(3 \mid \leq C\left\|v_{k}(t)\right\|_{L^{2}(\Omega)}^{2} .\right. \tag{7.26}
\end{equation*}
$$

Using the sharp Garding inequality, (ii) in Corollary 7.6 and (7.20) we see that

$$
\begin{align*}
(2) & =-\left(-\left(H_{\tilde{p}} \lambda_{1}\right)^{w}\left(1-\varphi_{1}\right) v_{k}(t),\left(1-\varphi_{1}\right) v_{k}(t)\right)+\mathcal{O}\left(\left\|v_{k}(t)\right\|_{L^{2}(\Omega)}^{2}\right) \\
& (2) \leq-\left\|\langle x\rangle^{-\frac{1+\nu}{2}} b\left(x, h_{k} D_{x}\right)(-\Delta)^{\frac{1}{4}}\left(1-\varphi_{1}\right) v_{k}(t)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}+C\left\|v_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \tag{7.27}
\end{align*}
$$

It follows from (7.24), (7.25), (7.26), (7.27) and (7.22) that

$$
\begin{equation*}
N(t)+\int_{0}^{t}\left\|\langle x\rangle^{-\frac{1+\nu}{2}} b_{1}\left(x, h_{k} D_{x}\right)\left(1-\varphi_{1}\right) \underline{w}_{k}(t)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \mathrm{~d} t \leq C \int_{0}^{t} N(s) \mathrm{d} s+N(0) \tag{7.28}
\end{equation*}
$$

Using the Gronwall inequality we see that $N(t) \leq N(0) e^{C T}$.
Now $N(0) \leq C\left\|v_{k}(0)\right\|_{L^{2}(\Omega)}^{2} \leq C^{\prime}\left\|\widetilde{u}_{k}^{0}\right\|_{L^{2}(\Omega)}^{2}$. Thus using again (7.28) we obtain

\int_{0}^{T}\left\|b_{1}\left(x, h_{k} D_{x}\right)\left(1-\varphi_{1}\right) \underline{w}_{k}(t)\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t=0(1) \tag{7.29}
\end{equation*}
$$

by (3.7), since $\langle x\rangle^{-\frac{1+\nu}{2}} \approx 1$ on the support of $b_{1}\left(x, h_{k} D_{x}\right)$.
Now since $\varphi_{0}(t) \psi\left(h_{k}^{2} D_{t}\right)$ is bounded in $L^{2}(\mathbb{R})$ Lemma 7.7 follows from (7.29) and (7.23).

## End of the proof of Theorem 7.1

Applying Lemma 7.7 to the subsequence $\left(W_{\sigma(k)}\right)$ and using Proposition 5.1 we see that $\langle\mu, a\rangle=0$ with

a(x, t, \xi, \tau)=\left[\left(1-\varphi_{1}(x)\right) \varphi_{0}(t) \psi(\tau) b_{1}(x, \xi)\right]^{2}
$$

Since by $(7.21),(7.22)$ we have $a\left(x_{0}, t_{0}, \xi_{0}, \tau_{0}\right) \neq 0$ we conclude that $m_{0} \notin \operatorname{supp} \mu$.
The proof of Theorem 7.1 is thus complete.

## 8. End of the proofs of Theorem 3.1 and 2.1

### 8.1 End of the proof of Theorem 3.1

According to Corollary 6.2 we will reach to a contradiction if we show that the measure $\mu$ vanishes identically. Recall that

\operatorname{supp} \mu \subset \Sigma=\left\{(x, t, \xi, \tau) \in T^{*} \mathbb{R}^{d+1}, x \in \bar{\Omega}, t \in[0, T], \tau+p(x, \xi)=0\right\}
$$

Let $m=(x, t, \xi, \tau) \in \Sigma$ and $a=\pi(m) \in \Sigma_{b}$. The assumption (2.6) tell us that we can find $s_{0} \in \mathbb{R}$ such that for all $s \leq s_{0}$ we have $\Gamma(s, a) \subset T^{*} M \backslash\{0\}, \Gamma(s, a)=(x(s), t, \xi(s), \tau)$ where $(x(s), \xi(s))$ is the usual flow of $p$ and $\lim _{s \rightarrow-\infty}|x(s)|=+\infty$.

Then we have the following Lemma.
Lemma 8.1. One can find $s_{1} \leq s_{0}$ such that with the notations of Theorem 7.1
(i) $\left|x\left(s_{1}\right)\right| \geq 3 R_{0}$,
(ii) $\sum_{j, k=1}^{d} \widetilde{a}^{j k}\left(x\left(s_{1}\right)\right) x_{j}\left(s_{1}\right) \xi_{k}\left(s_{1}\right) \leq-3 \delta\left|x\left(s_{1}\right)\right|\left|\xi\left(s_{1}\right)\right|$.

Let us assume this Lemma for a moment.
Since $\tau+\widetilde{p}\left(x\left(s_{1}\right), \xi\left(s_{1}\right)\right)=\tau+p\left(x\left(s_{1}\right), \xi\left(s_{1}\right)\right)=0$ (because $\left.\Gamma(s, a) \subset \Sigma_{b}\right)$ we deduce from Theorem 7.1 that $\left(x\left(s_{1}\right), t, \xi\left(s_{1}\right), \tau\right)=\Gamma\left(s_{1}, a\right)=\pi^{-1}\left(\Gamma\left(s_{1}, a\right)\right) \notin \operatorname{supp} \mu(\pi$ is the identity on $T^{*} \mathbb{R}_{M}^{d+1}$ ). By Theorem 5.3 we have $\pi^{-1}(\Gamma(0, a))=\pi^{-1}(a) \cap \operatorname{supp} \mu=\emptyset$. Since $m \in \pi^{-1}(a)$ it follows that $m \notin \operatorname{supp} \mu$. Therefore $\operatorname{supp} \mu=\emptyset$ which contradicts Corollary 6.2 and proves Theorem 3.1.

## Proof of Lemma 8.1

Since $\lim _{s \rightarrow-\infty}|x(s)|=+\infty$ we can find $\widetilde{s}_{0}$ such that

$$

|x(s)| \geq 3 R_{0} \text { for } s \leq \widetilde{s}_{0} . \tag{8.1}
\end{equation*}
$$

Let us set for $\left.s \in]-\infty, \widetilde{s}_{0}\right]$

\left\{\begin{array}{l}
F(s)=F_{1}(s)+F_{2}(s)  \tag{8.2}\\
F_{1}(s)=\sum_{j, k=1}^{d} a^{j k}(x(s)) x_{j}(s) \xi_{k}(s), \\
F_{2}(s)=3 \delta|x(s)||\xi(s)|
\end{array}\right.
$$

Let us remark that since $|x(s)| \geq 3 R_{0}$ we have $a^{j k}(x(s))=\widetilde{a}^{j k}(x(s))$.
We have

$$
\left\{\begin{array}{l}
\dot{x}_{j}(s)=2 \sum_{k=1}^{d} a^{j k}(x(s)) \xi_{k}(s)  \tag{8.3}\\
\dot{\xi}_{j}(s)=-\sum_{p, q=1}^{d} \frac{\partial a^{p q}}{\partial x_{j}}(x(s)) \xi_{p}(s) \xi_{q}(s)
\end{array}\right.
$$

and by assumption (2.5), $\left|\nabla_{x} a^{j}(x)\right|=o\left(\frac{1}{|x|}\right)$ as $|x| \rightarrow+\infty$.
Using (8.1), (8.3), (2.5), the ellipticity condition (2.3) and taking $R_{0}$ large enough we find by an easy computation that

$$
\begin{equation*}
\left.\left.\frac{\mathrm{d}}{\mathrm{~d} s} F_{1}(s) \geq C|\xi(s)|^{2}, \quad s \in\right]-\infty, \widetilde{s}_{0}\right] \tag{8.4}
\end{equation*}
$$

for some fixed constant $C>0$.
Using again (8.3) and the same arguments we see easily that

$$
\begin{equation*}
\frac{\mathrm{d}}{\mathrm{~d} s} F_{2}(s) \leq C^{\prime} \delta|\xi(s)|^{2} \tag{8.5}
\end{equation*}
$$

It follows from (8.4), (8.5) and (8.2), taking $\delta$ small enough, that for $\left.s \in]-\infty, \widetilde{s}_{0}\right]$ we have

$$
\frac{\mathrm{d}}{\mathrm{~d} s} F(s) \geq C_{0}|\xi(s)|^{2} \geq C_{1} p(x(s), \xi(s))=C_{1} p\left(x\left(\widetilde{s}_{0}\right), \xi\left(\widetilde{s}_{0}\right)\right) \geq C_{2}\left|\xi\left(\widetilde{s}_{0}\right)\right|^{2}
$$

Integrating this inequality between $s$ and $\widetilde{s}_{0}$ we obtain

$$
F(s) \leq F\left(\widetilde{s}_{0}\right)+C_{2}\left|\xi\left(\widetilde{s}_{0}\right)\right|^{2}\left(s-\widetilde{s}_{0}\right) .
$$

Since the right hand side tends to $-\infty$ when $s$ goes to $-\infty$ we can find $s_{1} \leq \widetilde{s}_{0}$ such that $F(s) \leq 0$ when $s \leq s_{1}$.

### 8.2 End of the proof of Theorem 2.1

We shall need the following Lemma.
Lemma 8.2. Let $\theta \in \mathcal{C}_{0}^{\infty}(\mathbb{R}), \chi_{0} \in \mathcal{C}_{0}^{\infty}(\bar{\Omega})$. There exists $C>0$ such that

$$
\left\|\left[\theta\left(h^{2} P_{D}\right), \chi_{0} P_{D}^{\frac{1}{4}}\right] v\right\|_{L^{2}(\Omega)} \leq C h^{\frac{1}{2}}\|v\|_{L^{2}(\Omega)}
$$

for every $h \in] 0,1]$ and $v \in L^{2}(\Omega)$.

## Proof

See section 9.3
Now it is classical that one can find $\psi, \theta$ in $\mathcal{C}_{0}^{\infty}(\mathbb{R})$ such that

\operatorname{supp} \psi \subset\{t:|t| \leq 1\}, \quad \operatorname{supp} \theta \subset\left\{t: \frac{1}{2} \leq|t| \leq 2\right\} \quad \text { and } \\
\psi(t)+\sum_{p=0}^{+\infty} \theta\left(2^{-p} t\right)=1 \text { for all } t \in \mathbb{R}
\end{array}\right.
$$

By the functionnel calculus we see easily that

$$
\left\{\begin{array}{l}
\psi\left(P_{D}\right)+\sum_{p=0}^{+\infty} \theta\left(2^{-p} P_{D}\right)=\mathrm{Id} \quad \text { and }  \tag{8.6}\\
\|v\|_{L^{2}(\Omega)}^{2} \leq C\left(\left\|\psi\left(P_{D}\right) v\right\|_{L^{2}(\Omega)}^{2}+\sum_{p=0}^{+\infty}\left\|\theta\left(2^{-p} P_{D}\right) v\right\|_{L^{2}(\Omega)}^{2}\right)
\end{array}\right.
$$

Let $u(t)=e^{i t P_{D}} u_{0}$. Using (8.6) we see that

$$
\left\{\begin{array}{l}
\left\|\chi_{0} P_{D}^{\frac{1}{4}} u(t)\right\|_{L^{2}(\Omega)}^{2} \leq C((1)+\text { (2) }) \quad \text { where }  \tag{8.7}\\
\text { (1) }=\left\|\psi\left(P_{D}\right) \chi_{0} P_{D}^{\frac{1}{4}} u(t)\right\|_{L^{2}(\Omega)}^{2} \\
(2)=\sum_{p=0}^{+\infty}\left\|\theta\left(2^{-p} P_{D}\right) \chi_{0} P_{D}^{\frac{1}{4}} u(t)\right\|_{L^{2}(\Omega)}^{2}
\end{array}\right.
$$

We have

$$
\text { (1) } \leq 2\left(\left\|\left[\psi\left(P_{D}\right), \chi_{0} P_{D}^{\frac{1}{4}}\right] u(t)\right\|_{L^{2}}^{2}+\left\|\chi_{0} \psi\left(P_{D}\right) P_{D}^{\frac{1}{4}} u(t)\right\|_{L^{2}}^{2}\right)
$$

Using Lemma 8.2 with $h=1$, the fact that the operator $\psi\left(P_{D}\right) P_{D}^{\frac{1}{4}}$ is $L^{2}(\Omega)$ bounded and the energy estimate we deduce that

$$
\begin{equation*}
\text { (1) } \leq C\left\|u_{0}\right\|_{L^{2}(\Omega)}^{2} \text {. } \tag{8.8}
\end{equation*}
$$

On the other hand we have

$$
\left\{\begin{array}{l}
(2) \leq C((3)+\text { (4) })  \tag{8.9}\\
(3)=\sum_{p=0}^{+\infty}\left\|\left[\theta\left(2^{-p} P_{D}\right), \chi_{0} P_{D}^{\frac{1}{4}}\right] u(t)\right\|_{L^{2}(\Omega)}^{2} \\
(4)=\sum_{p=0}^{+\infty}\left\|\chi_{0} P_{D}^{\frac{1}{4}} \theta\left(2^{-p} P_{D}\right) u(t)\right\|_{L^{2}(\Omega)}^{2}
\end{array}\right.
$$

Using Lemma 8.2 we can write

$$
\text { (3) } \leq C\left(\sum_{p=0}^{+\infty} 2^{-p}\right)\|u(t)\|_{L^{2}(\Omega)}^{2}
$$

so by the energy estimate

$$
\begin{equation*}
\text { (3) } \leq C\left\|u_{0}\right\|_{L^{2}(\Omega)}^{2} \text {. } \tag{8.10}
\end{equation*}
$$

To handle the term (4) we use the Theorem 3.1. Let $\tilde{\theta} \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$ be such that $\operatorname{supp} \tilde{\theta} \subset\left\{t: \frac{1}{3} \leq|t| \leq 3\right\}, \tilde{\theta}(t)=1$ on the support of $\theta$ and $0 \leq \tilde{\theta} \leq 1$. Then $\theta\left(2^{-p} P_{D}\right) u(t)=\theta\left(2^{-p} P_{D}\right) \mathrm{e}^{i t P_{D}} \tilde{\theta}\left(2^{-p} P_{D}\right) u_{0}$.

It follows from Theorem 3.1 that

$$
\int_{0}^{T}(4) \mathrm{d} t \leq C \sum_{p=0}^{+\infty}\left\|\widetilde{\theta}\left(2^{-p} P_{D}\right) u_{0}\right\|_{L^{2}(\Omega)}^{2}
$$

Now we have

$$
\sum_{p=0}^{+\infty}\left[\widetilde{\theta}\left(2^{-p} t\right)\right]^{2} \leq\left(\sum_{p=0}^{+\infty} \widetilde{\theta}\left(2^{-p} t\right)\right)^{2} \leq M_{0}, \quad \text { for all } t \in \mathbb{R}
$$

It follows that the operator $\sum_{p=0}^{+\infty}\left[\widetilde{\theta}\left(2^{-p} P_{D}\right)\right]^{2}$ is $L^{2}(\Omega)$ bounded, therefore

$$
\begin{equation*}
\int_{0}^{T}(4) \mathrm{d} t \leq C\left\|u_{0}\right\|_{L^{2}(\Omega)}^{2} \tag{8.11}
\end{equation*}
$$

It follows from (8.7), (8.8), (8.9), (8.10) and (8.11) that

$$
\int_{0}^{T}\left\|\chi_{0} P_{D}^{\frac{1}{4}} \mathrm{e}^{i t P_{D}} u_{0}\right\|_{L^{2}(\Omega)}^{2} \mathrm{~d} t \leq C\left\|u_{0}\right\|_{L^{2}(\Omega)}^{2}
$$

which is the claim in Theorem 2.1. The proof is complete.

## 9. Appendix

### 9.1 The geometrical framework

We recall here the definition of the generalized bicharacteristic flow in the sense of Melrose and Sjöstrand. For this purpose we follow Hörmander [Hö].

Let $M=\Omega \times \mathbb{R}_{t}$. We set $T_{b}^{*} M=T^{*} M \backslash\{0\} \cup T^{*} \partial M \backslash\{0\}$. We have a natural restriction map $\pi: T^{*} \mathbb{R}_{\mid \bar{M}}^{d+1} \rightarrow T_{b}^{*} M$ (which will be describe more precisely in local coordinates below) which is the identity on $T^{*} \mathbb{R}_{\mid M}^{d+1} \backslash\{0\}$.

With $p$ defined in (2.2) we introduce the characteristic set

$$
\Sigma=\left\{(x, t, \xi, \tau) \in T^{*} \mathbb{R}^{d+1}, x \in \bar{\Omega}, t \in[0, T], \tau+p(x, \xi)=0\right\}
$$

and we set $\Sigma_{b}=\pi(\Sigma)$.

Definition 9.1. Let $\zeta \in T^{*} \partial M \backslash\{0\}$. We shall say that
(i) $\zeta$ is elliptic (or $\zeta \in \mathcal{E}$ ) iff $\zeta \notin \Sigma_{b}$
(ii) $\zeta$ is hyperbolic (or $\zeta \in \mathcal{H}$ ) iff $\#\left\{\pi^{-1}(\zeta) \cap \Sigma\right\}=2$
(iii) $\zeta$ is glancing (or $\zeta \in \mathcal{G}$ iff $\#\left\{\pi^{-1}(\zeta) \cap \Sigma\right\}=1$.

Let us describe $\pi$ and these sets in local coordinates. As we said before, $\pi$ is the identity map on $T^{*} \mathbb{R}_{\mid M}^{d+1} \backslash\{0\}$.

Near any point of $\partial M$ we can use the geodesical coordinates where $M$ is given by

$$
\left\{\left(x_{1}, x^{\prime}, t\right) \in \mathbb{R} \times \mathbb{R}^{d-1} \times \mathbb{R}: x_{1}>0\right\}
$$

$\partial M$ is given by $\left\{\left(x_{1}, x^{\prime}, t\right): x_{1}=0\right\}$ and $\tau+p(x, \xi)$ is transformed to $\xi_{1}^{2}+r\left(x_{1}, x^{\prime}, \xi^{\prime}\right)+\tau$.
In these coordinates if $\rho \in T^{*} \mathbb{R}_{\mid \partial M}^{d+1} \backslash\{0\}$ then $\rho=\left(0, x^{\prime}, t, \xi_{1}, \xi^{\prime}, \tau\right)$ and $\pi(\rho)=$ $\left(x^{\prime}, t, \xi^{\prime}, \tau\right) \in T^{*} \partial M \backslash\{0\}$.

Now let $\zeta=\left(x^{\prime}, t, \xi^{\prime}, \tau\right) \in T^{*} \partial M \backslash\{0\}$. Then

$$
\left\{\begin{align*}
\zeta \in \mathcal{E} & \Longleftrightarrow r\left(0, x^{\prime}, \xi^{\prime}\right)+\tau>0  \tag{9.1}\\
\zeta \in \mathcal{H} & \Longleftrightarrow r\left(0, x^{\prime}, \xi^{\prime}\right)+\tau<0 \\
\zeta \in \mathcal{G} & \Longleftrightarrow r\left(0, x^{\prime}, \xi^{\prime}\right)+\tau=0
\end{align*}\right.
$$

When $\zeta \in \mathcal{H}$ then $\pi^{-1}(\zeta) \cap \Sigma=\left\{\left(0, x^{\prime}, t, \xi_{1}^{ \pm}, \xi^{\prime}, \tau\right)\right\}$ where

$$
\begin{equation*}
\xi_{1}^{ \pm}= \pm\left(-\left(r\left(0, x^{\prime}, \xi^{\prime}\right)+\tau\right)\right)^{\frac{1}{2}} \tag{9.2}
\end{equation*}
$$

When $\zeta \in \mathcal{G}$ then $\pi^{-1}(\zeta) \cap \Sigma=\left\{\left(0, x^{\prime}, t, 0, \xi^{\prime}, \tau\right)\right\}$.
For the purpose of the proofs it is important to decompose the set $\mathcal{G}$ of glancing points into several subsets. The following definition is given in local coordinates but could be written in an intrinsic way (see $[\mathrm{H}]$ ). We shall set

r_{0}\left(x^{\prime}, \xi^{\prime}\right)=r\left(0, x^{\prime}, \xi^{\prime}\right) \tag{9.3}
\end{equation*}
$$

and $H_{r_{0}}$ will denote the Hamilton field of $r_{0}$ namely $H_{r_{0}}=\frac{\partial r_{0}}{\partial \xi^{\prime}} \frac{\partial}{\partial x^{\prime}}-\frac{\partial r_{0}}{\partial x^{\prime}} \frac{\partial}{\partial \xi^{\prime}}$.
Definition 9.2. Let $\zeta=\left(x^{\prime}, t, \xi^{\prime}, \tau\right) \in \mathcal{G}$. We shall say that
$(i) \zeta$ is diffractive (or $\zeta \in \mathcal{G}_{d}$ ) iff $\frac{\partial r}{\partial x_{1}}\left(0, x^{\prime}, \xi^{\prime}\right)<0$,
(ii) $\zeta$ is gliding (or $\zeta \in \mathcal{G}_{g}$ ) iff $\frac{\partial r}{\partial x_{1}}\left(0, x^{\prime}, \xi^{\prime}\right)>0$, and we set $\mathcal{G}^{2}=\mathcal{G}_{d} \cup \mathcal{G}_{g}$,
(iii) $\zeta$ belongs to $\mathcal{G}^{k}, k \geq 3$, iff

$$
H_{r_{0}}^{j}\left({\left.\frac{\partial r}{\partial x_{1}}{ }_{\mid x_{1}=0}\right)(\zeta)=0,0 \leq j<k-2, H_{r_{0}}^{k-2}\left(\frac{\partial r}{\partial x_{1}}{ }_{x_{1}=0}\right)(\zeta) \neq 0 . . . . ~}\right)
$$

We can now give the meaning of the assumption made in (2.7).

Definition 9.3. We shall say that the bicharacteristics have no contact of infinite order with the boundary if

$$
\mathcal{G}=\bigcup_{k=2}^{+\infty} \mathcal{G}^{k} .
$$

We are going now to make a brief description of the generalized bicharacteristic flow and we refer to $[\mathrm{M}-\mathrm{S}]$ or [Hö] for more details.

First of all we introduce some notations.
We shall denote by $\gamma(s)=(x(s), \xi(s))$ the usual bicharacteristic of $p$ in $T^{*} \Omega$ defined by

(\dot{x}(s), \dot{\xi}(s))=\left(\frac{\partial p}{\partial \xi}(\gamma(s)),-\frac{\partial p}{\partial x}(\gamma(s))\right) .
$$

We shall denote by $\gamma_{g}(s)=\left(x_{g}^{\prime}(x), \xi_{g}^{\prime}(s)\right)$ the gliding ray in $T^{*} \partial \Omega$ defined in the geodesic coordinates by the equations

\left(\dot{x}_{g}^{\prime}(s), \dot{\xi}_{g}^{\prime}(s)\right)=\left(\frac{\partial r_{0}}{\partial \xi^{\prime}}\left(\gamma_{g}(s)\right),-\frac{\partial r_{0}}{\partial x^{\prime}}\left(\gamma_{g}(s)\right)\right)
$$

where $r_{0}$ has been introduced in (9.3).
The generalized flow lives in $\Sigma_{b} \subset T_{b}^{*} M$ and for $a \in \Sigma_{b}$ is denoted by $\Gamma(s, a)$. Since $\Sigma_{b}$ is the disjoint union of $\Sigma_{b} \cap T^{*} M, \Sigma_{b} \cap \mathcal{H}, \Sigma_{b} \cap \mathcal{G}_{d}, \Sigma_{b} \cap \mathcal{G}_{g}$ and $\Sigma_{b} \cap\left(\bigcup_{k \geq 3} \mathcal{G}^{k}\right)$ we shall consider separatly the case where a belongs to each set. Moreover each description of $\Gamma(s, a)$ holds for small $|s|$.

Case 1: $a \in \Sigma_{b} \cap T^{*} M$
Here $a=(x, t, \xi, \tau)$ where $x \in \Omega, t \in[0, T], \tau+p(x, \xi)=0$. Then for small $|s|$ we have

\Gamma(s, a)=(x(s), t, \xi(s), \tau) \subset T^{*} M
$$

where $(x(s), \xi(s))$ is the bicharacteristic of $p$ starting from the point $(x, \xi)$.
Case 2: $a \in \Sigma_{b} \cap \mathcal{H}$
In the geodesic coordinates we have $a=\left(x^{\prime}, t, \xi^{\prime}, \tau\right)$ and the equation $\xi_{1}^{2}+r\left(0, x^{\prime}, \xi^{\prime}\right)+\tau=0$ has two distinct roots $\xi_{1}^{+}, \xi_{1}^{-}$described in (9.2). For $s>0$ (resp. $s<0$ ) let $\gamma^{+}(s)=$ $\left(x^{+}(s), \xi^{+}(s)\right)$ (resp. $\gamma^{-}(s)=\left(x^{-}(s), \xi^{-}(s)\right)$ be the bicharacteristic of $p$ starting for $s=0$ at the point $\left(0, x^{\prime}, \xi_{1}^{+}, \xi^{\prime}\right)$ (resp. $\left(0, x^{\prime}, \xi_{1}^{-}, \xi^{\prime}\right)$ ). They are contained in $T^{*} \Omega$ for small $|s| \neq 0$. Then $\Gamma(0, a)=a$ and

$$
\Gamma(s, a)= \begin{cases}\left(x^{+}(s), t, \xi^{+}(s), \tau\right), & 0<s<\varepsilon \\ \left(x^{-}(s), t, \xi^{-}(s), \tau\right), & -\varepsilon<s<0\end{cases}
$$

Here $\Gamma(s, a) \subset T^{*} M$ for $s \neq 0$.
Case 3: $a \in \Sigma_{b} \cap \mathcal{G}_{d}$
Here $a=\left(x^{\prime}, t, \xi^{\prime}, \tau\right)$ and the equation $\xi_{1}^{2}+r\left(0, x^{\prime}, \xi^{\prime}\right)+\tau=0$ has a double root $\xi_{1}=0$. Let $\gamma(s)=(x(s), \xi(s))$ be the flow of $p$ starting when $s=0$ at the point $\left(0, x^{\prime}, \xi_{1}=0, \xi^{\prime}\right)$. Then we have

$$
\Gamma(s, a)=(x(s), t, \xi(s), \tau) \subset T^{*} M, \quad 0<|s|<\varepsilon
$$

Case 4: $a \in \Sigma_{b} \cap \mathcal{G}_{g}$
As above $a=\left(x^{\prime}, t, \xi^{\prime}, \tau\right)$ and $\xi_{1}=0$ is a double root. Let $\gamma_{g}(s)=\left(x_{g}^{\prime}(s), \xi_{g}^{\prime}(s)\right)$ be the gliding ray starting when $s=0$ at the point $\left(x^{\prime}, \xi^{\prime}\right)$. Then we have

$$
\Gamma(s, a)=\left(x_{g}^{\prime}(s), t, \xi_{g}^{\prime}(s), \tau\right) \subset T^{*} \partial M, \quad|s|<\varepsilon .
$$

Case 5: $a \in \Sigma_{b} \cap\left(\bigcup_{k=3}^{+\infty} \mathcal{G}^{k}\right)$
Let $a=\left(x^{\prime}, t, \xi^{\prime}, \tau\right)$. Let $\gamma_{g}(s)=\left(x_{g}^{\prime}(s), \xi_{g}^{\prime}(s)\right)$ be the gliding ray starting when $s=0$ at the point $\left(x^{\prime}, \xi^{\prime}\right)$. Then (see Theorem 24.3.9 in [Hö]) one can find $\varepsilon>0$ such that with $I=] 0, \varepsilon\left[\right.$ we have either $\gamma_{g}(s) \in \mathcal{G}_{g}, \forall s \in I$ and then $\Gamma(s, a)=\left(x_{g}^{\prime}(s), t, \xi_{g}^{\prime}(s), \tau\right) \subset T^{*} \partial M$, $\forall s \in I$, or $\gamma_{g}(s) \in \mathcal{G}_{d}, \forall s \in I$ and then $\Gamma(s, a)=(x(s), t, \xi(s), \tau) \subset T^{*} M, \forall s \in I$, where $(x(s), \xi(s))$ is the bicharacteristic of $p$ starting when $s=0$ at the point $\left(0, x^{\prime}, \xi_{1}=0, \xi^{\prime}\right)$.

The same discussion is independently valid for $-\varepsilon<s<0$.
Remark 9.4. Let $a \in \Sigma_{b}$ and $\Gamma(t, a)$ be the generalized bicharacteristing starting for $t=0$ at the point $a$. Then the above discussion shows that one can find $\varepsilon>0$ such that for $0<|t| \leq \varepsilon$ we have $\Gamma(t, a) \subset T^{*} M \cup \mathcal{G}_{g}$. Let us note (see $[M-S]$ ) that the maps $s \mapsto \Gamma(s, a)$ and $a \mapsto \Gamma(s, a)$ are continuous, the later when $T_{b}^{*} M$ is endowed with the topologie induced by the projection $\pi$. Moreover we have the usual relation $\Gamma(t+s, a)=\Gamma(t, \Gamma(s, a))$ for $s, t$ in $\mathbb{R}$.

### 9.2 Proofs of Theorem 5.2 and Theorem 5.3

## a) Proof of Theorem 5.2

According to (5.1), (5.2) it is obvious that

Therefore it remains to show that if $m_{0}=\left(x_{0}, t_{0}, \xi_{0}, \tau_{0}\right)$ with $x_{0} \in \bar{\Omega}, t_{0} \in[0, T]$, but $\tau_{0}+p\left(x_{0}, \xi_{0}\right) \neq 0$ then $m_{0} \notin \operatorname{supp} \mu$.

Case 1: assume $x_{0} \in \Omega$
Let $\varepsilon>0$ be such that $B\left(x_{0}, \varepsilon\right) \subset \Omega$. Let $\varphi \in \mathcal{C}_{0}^{\infty}\left(B\left(x_{0}, \varepsilon\right)\right), \varphi=1$ on $B\left(x_{0}, \frac{\varepsilon}{2}\right)$ and $\widetilde{\varphi} \in \mathcal{C}_{0}^{\infty}(\Omega), \widetilde{\varphi}=1$ on $\operatorname{supp} \varphi$. Let $a \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}_{x}^{d} \times \mathbb{R}_{\xi}^{d}\right)$ such that $\pi_{x} \operatorname{supp} a \subset B\left(x_{0}, \frac{\varepsilon}{2}\right)$ and $\chi \in \mathcal{C}_{0}^{\infty}\left(\mathbb{R}_{t} \times \mathbb{R}_{\tau}\right)$. Recall that we have set $W_{k}=\mathbb{I}_{[0, T]} \mathbb{I}_{\Omega} w_{k}$ with $w_{k}=h_{k}^{-\frac{1}{2}} \theta\left(h_{k}^{2} P_{D}\right) \widetilde{u}_{k}$ and that $\left(w_{k}\right)$ is a bounded sequence in $L^{2}\left([0, \tau], L_{\mathrm{loc}}^{2}\left(\mathbb{R}^{d}\right)\right)$ (see Proposition 4.1). Now we set

$$
\begin{equation*}
I_{k}=\left(a\left(x, h_{k} D_{x}\right) \chi\left(t, h_{k}^{2} D_{t}\right) \varphi h_{k}^{2}\left(D_{t}+P\left(x, D_{x}\right)\right) W_{k}, \widetilde{\varphi} W_{k}\right)_{L^{2}\left(\mathbb{R}^{d+1}\right)} \tag{9.4}
\end{equation*}
$$

We have $h_{k}^{2}\left(D_{t}+P\left(x, D_{x}\right)\right)=h_{k}^{2} D_{t}+P_{2}\left(x, h_{k} D_{x}\right)+h_{k} P_{1}\left(x, h_{k} D_{x}\right)+h_{k}^{2} P_{0}(X)$ where $P_{j}(x, \xi)$ are homogeneous in $\xi$ of order $j$.

Using the semi classical symbolic calculus and the fact that $\left(\widetilde{\varphi} W_{k}\right)$ is bounded in $L^{2}\left(\mathbb{R}^{d+1}\right)$ we see easily that the terms in $I_{k}$ corresponding to $h_{k} P_{1}\left(x, h_{k} D_{x}\right)$ and $h_{k}^{2} P_{0}(x)$ tend to zero when $k \rightarrow+\infty$. It remains to consider the term $P_{2}\left(x, h_{k} D_{x}\right)$. But by the semi classical calculus

a\left(x, h_{k} D_{x}\right) \chi\left(t, h_{k}^{2} D_{t}\right) \varphi\left(h_{k}^{2} D_{t}+P_{2}\left(x, h_{k} D_{x}\right)\right)=\mathcal{O} p(a \chi(\tau+p))+h_{k} R_{k}
$$

where $R_{k}$ is a uniformly bounded semi classical pseudo-differential operator in $L^{2}\left(\mathbb{R}^{d+1}\right)$. Therefore the term in $I_{k}$ corresponding to $h_{k} R_{k}$ tends to zero.

It follows from Proposition 5.1 that

\lim _{k \rightarrow+\infty} I_{\sigma(k)}=\langle\mu,(\tau+p) a \chi\rangle \tag{9.5}
\end{equation*}
$$

On the other hand we have since $\left[D_{t}+P\left(x, D_{x}\right)\right] \widetilde{u}_{k}=0$ in $\Omega \times \mathbb{R}_{t}$ and $\varphi \in \mathcal{C}_{0}^{\infty}(\Omega)$,

\varphi\left(D_{t}+P\left(x, D_{x}\right)\right) W_{k}=\varphi\left(w_{k}(0) \delta_{t=0}-w_{k}(T) \delta_{t=T}\right) \tag{9.6}
\end{equation*}
$$

Lemma 9.5. Let $1 \leq p \leq+\infty, \chi \in \mathcal{C}_{0}^{\infty}(\mathbb{R} \times \mathbb{R})$ and $\ell \geq 1$. Then there exists $C>0$ such that

$$
\left\|\chi\left(t, h^{\ell} D_{t}\right) \delta_{t=a}\right\|_{L^{p}(\mathbb{R})} \leq C h^{\frac{\ell}{p}-\ell}
$$

for every $0<h \leq 1$.

## Proof

Let $\psi \in \mathcal{C}_{0}^{\infty}(\mathbb{R}), \psi(t)=1$ on a neighborhood of $\pi_{t} \operatorname{supp} \chi$. Then $\psi \chi=\chi$. Now

On the other hand $\chi(t, \tau)=\psi(t) \chi(a, \tau)+\psi(t)(t-a) \widetilde{\chi}(t, \tau, a)$ where $\widetilde{\chi} \in \mathcal{C}^{\infty}$ has compact support in $\tau$. It follows that

Noting that $(t-a) \mathrm{e}^{i(t-a) \tau}=\frac{1}{i} \frac{\partial}{\partial \tau} \mathrm{e}^{i(t-a) \tau}$ and making an integration by part, we see easily that

so using Lemma 9.5 with $p=2$ and $\ell=2$ we deduce that

by the energy estimate. It follows from (3.7) that

Using (9.5) and (9.9) we see that $\langle\mu,(\tau+p) a \chi\rangle=0$. Since $\tau_{0}+p\left(x_{0}, \xi_{0}\right) \neq 0$ and

\mathcal{C}_{0}^{\infty}\left(\mathbb{R}_{x}^{d} \times \mathbb{R}_{\xi}^{d}\right) \otimes \mathcal{C}_{0}^{\infty}\left(\mathbb{R}_{t} \times \mathbb{R}_{\tau}\right)
$$

is dense in $\mathcal{C}_{0}^{\infty}\left(\mathbb{R}^{d+1} \times \mathbb{R}^{d+1}\right)$ we deduce that $m_{0}=\left(x_{0}, t_{0}, \xi_{0}, \tau_{0}\right) \notin \operatorname{supp} \mu$.
Case 2: assume $x_{0} \in \partial \Omega$
We would like to show that one can find a neighborhood $U_{x_{0}}$ of $x_{0}$ in $\mathbb{R}^{d}$ such that for any $a \in \mathcal{C}_{0}^{\infty}\left(U_{x_{0}} \times \mathbb{R}_{t} \times \mathbb{R}_{\xi}^{d} \times \mathbb{R}_{\tau}\right)$ we have

\langle\mu,(\tau+p) a\rangle=0 \tag{9.10}
\end{equation*}

Indeed this will imply that the point $m_{0}=\left(x_{0}, t_{0}, \xi_{0}, \tau_{0}\right)$ (with $\left.\tau_{0}+\left(x_{0}, \xi_{0}\right) \neq 0\right)$ does not belong to the support of $\mu$ as claimed.

Now (9.10) will be implied, according to Proposition 5.1 and (4.1) by

I_{k}=\left(a\left(x, t, h_{k} D_{x}, h_{k}^{2} D_{t}\right) \varphi h_{k}^{2}\left(D_{t}+P\right) W_{k}, W_{k}\right)_{L^{2}\left(\mathbb{R}^{d+1}\right)}
\end{array}\right.
$$

where $\varphi \in \mathcal{C}_{0}^{\infty}\left(V_{x_{0}}\right), \varphi=1$ on $\pi_{x} \operatorname{supp} a$.
Now we may choose $U_{x_{0}}$ so small that one can find a $\mathcal{C}^{\infty}$ diffeomorphism $F$ from $U_{x_{0}}$ to a neighborhood $U_{0}$ of the origin in $\mathbb{R}^{d}$ such that

F\left(U_{x_{0}} \cap \Omega\right) & =\left\{y \in U_{0}: y_{1}>0\right\}  \tag{9.12}\\
F\left(U_{x_{0}} \cap \partial \Omega\right) & =\left\{y \in U_{0}: y_{1}=0\right\} \\
\left(P(x, D) W_{k}\right) \circ F^{-1} & =\left(D_{1}^{2}+R\left(y, D^{\prime}\right)\right)\left(W_{k} \circ F^{-1}\right)
\end{align*}\right.
$$

where $R$ is a second order differential operator and $D^{\prime}=\left(D_{2}, \cdots, D_{d}\right)$.
Let us set

v_{k}=w_{k} \circ F^{-1}, \quad V_{k}=\mathbb{1}_{[0, T]} \mathbb{I}_{y_{1}>0} v_{k} \tag{9.13}
\end{equation*}

then we will have

\left(D_{t}+D_{1}^{2}+R\left(y, D^{\prime}\right)\right) v_{k}=0 \text { in } U_{0} \times \mathbb{R}_{t}, \quad y_{1}>0  \tag{9.14}\\
\left.v_{k}\right|_{y_{1}=0}=0
\end{array}\right.

Making the change of variable $x=F^{-1}(y)$ in the right hand side of the second line of (9.11) we see that

where $b \in \mathcal{C}_{0}^{\infty}\left(U_{0} \times \mathbb{R}_{t} \times \mathbb{R}_{\eta} \times \mathbb{R}_{\tau}\right)$ and $\psi \in \mathcal{C}_{0}^{\infty}\left(U_{0}\right), \psi=1$ near $\pi_{y} \operatorname{supp} b$.

where $T=\theta\left(y_{1}, h_{k} D_{1}\right) \Phi\left(y^{\prime}, h_{k} D^{\prime}\right) \chi\left(t, h_{k}^{2} D_{t}\right), \theta \Phi \chi \in \mathcal{C}_{0}^{\infty}\left(U_{0} \times \mathbb{R}_{t} \times \mathbb{R}_{y}^{d} \times \mathbb{R}_{\tau}\right), \psi_{0} \psi_{1} \in$ $\mathcal{C}_{0}^{\infty}\left(U_{0}\right)$ and $\psi_{0} \psi_{1}=1$ on $\pi_{y} \operatorname{supp} \theta \Phi \xi$.

If we multiply both sides by a function $\varphi=\varphi\left(y, t, \eta^{\prime}, \tau\right) \in \mathcal{C}_{0}^{\infty}$ which is equal to one on the support in $\left(y, t, \eta^{\prime}, \tau\right)$ of $a$ we obtain the claim of the Lemma.

In the following Remark we note that we can extend $\widetilde{\mu}$ to symbols which are not with compact support in $\eta_{1}$.

Now $\left(0, X_{0}^{\prime}, T_{0}, \pm \xi_{1}, \Xi_{0}^{\prime}, \lambda_{0}\right) \in \pi^{-1}\left(\Gamma\left(-\beta, \zeta_{0}\right)\right) \cap(\tau+p)^{-1}(0)$; therefore $\left(0, X_{0}^{\prime}, T_{0}, \pm \xi_{1}, \Xi_{0}^{\prime}, \Lambda_{0}\right) \in V$ so $\rho_{j} \in V$ for $j$ large enough which is again a contradiction. The proof of Lemma 9.21 is complete.

## Proof of Proposition 9.18

We are going to consider separately the four cases introduced in Lemma 9.21.
Case (1): we have $\Gamma\left(s, \zeta_{0}\right) \in \mathcal{G}_{g}$ for $s \in[-\beta, \beta] \backslash\{0\}$ Therefore

& \cup\left\{(x, t, \xi, \tau) \in T^{*} M, 0<x_{1}<\delta^{\prime},\left|x^{\prime}-x_{0}^{\prime}\right|<\delta^{\prime},\left|t-t_{0}\right|<\delta^{\prime},\left|\xi^{\prime}-\xi_{0}^{\prime}\right|<\delta^{\prime},\left|\tau-\tau_{0}\right|<\delta^{\prime}\right\}
\end{aligned}
$$

Then $\widetilde{U}=U \cap \Sigma_{b}$ is the set introduced in Lemma 9.21. Moreover $U$ being an open subset of $T_{b}^{*} M, \pi^{-1}(U)$ is open in $T^{*} \mathbb{R}^{d+1}$.

By continuity one can find $\varepsilon_{0}>0$ such that $\Gamma\left(s, \zeta_{0}\right) \in U$ for $s \operatorname{in}\left[-\varepsilon_{0}, \varepsilon_{0}\right]$. Then one can find $\delta>0$ such that if we set

Let $\rho=(x, t, \xi, \tau) \in \operatorname{supp} \mu \cap \pi^{-1}(U)$. By Theorem 5.2 we have $\tau+p(x, \xi)=0$ i.e. $\rho \in \Sigma$.

Let $\zeta=\pi(\rho) \in U \cap \Sigma_{b}=\widetilde{U}$.
If $\{\Gamma(-s, \zeta): s \in[0, \beta]\} \cap T^{*} \partial M \subset \bigcup_{j=0}^{k-1} \mathcal{G}^{j}$ then since by Lemma 9.4(ii) we have

In both cases we have $\zeta=\left(x^{\prime}, t, \xi^{\prime}, \tau\right)$ and $\rho=\left(0, x^{\prime}, t, 0, \xi^{\prime}, \tau\right)$ because $\tau+r\left(0, x^{\prime}, \xi^{\prime}\right)=0$. It follows that we can find $s_{1} \in[0, \beta]$ such that $\zeta_{1}=\Gamma\left(-s_{1}, \zeta\right) \in \mathcal{G}^{k}\left(\mathcal{G}_{d}\right.$ if $\left.k=2\right)$ (since $\Gamma(-s, \zeta) \in V_{1}$ by Lemma 9.21). Moreover by Lemma 9.21, case (2), we have $\Gamma\left(s, \zeta_{1}\right) \in T^{*} M$ if $s \in\left[-\beta+s_{1}, 0[\cup] 0, s_{1}\right]$. If $s_{1} \neq 0$ then $\zeta=\Gamma\left(s_{1}, \xi_{1}\right) \in T^{*} M$ which contradicts our assumption. If $s_{1}=0$ we have $\zeta_{1}=\zeta \in \mathcal{G}^{k}\left(\mathcal{G}_{d}\right.$ if $\left.k=2\right)$ which again is impossible. It follows that $\widetilde{U} \cap \operatorname{supp} \nu \cap\left(\mathcal{H} \cup \mathcal{G}_{g}\right)=\emptyset$ which proves (9.55).

It follows from Proposition 9.12 that ${ }^{t} H_{p} \mu=0$ on $\pi^{-1}(\widetilde{U})$. This implies that the support of $\mu$ propagates along the bicharacteristics of $p$ (with $(t, \tau)=$ constant). Now by assumption $\pi^{-1}\left(\Gamma\left(-s, \zeta_{0}\right)\right) \cap \operatorname{supp} \mu=\emptyset$ and $\pi^{-1}\left(\Gamma\left(s, \zeta_{0}\right)\right) \cap(\tau+p)^{-1}(0)=\left(x(s), t_{0}, \xi(s), \tau_{0}\right)$.

Case (3): here $k$ is odd, $k \geq 3$

If $s_{1} \neq 0, \zeta=\Gamma\left(s_{1}, \Gamma\left(-s_{1}, \zeta\right)\right)=\Gamma\left(s_{1}, \zeta_{1}\right) \in \mathcal{G}_{g}$ so $\rho=\left(0, x^{\prime}, t, 0, \xi^{\prime}, \tau\right)$.
If $s_{1}=0$ then $\zeta=\zeta_{1} \in \mathcal{G}^{k}$ and $\rho=\left(0, x^{\prime}, 0, \xi^{\prime}, \tau\right)$.
This proves (9.56). Therefore we can use Lemma 9.19 and its conclusion with $V$ such that $\pi^{-1}\left(\Gamma\left(s, \zeta_{0}\right)\right) \subset V \subset \pi^{-1}(U)$ for $s \in[-\beta, \beta]$.

By Lemma 9.21 we deduce that $\left(0, x_{g}^{\prime}\left(s, x_{0}^{\prime}, \xi_{0}^{\prime}\right), t_{0}, 0, \xi_{g}^{\prime}\left(s, x_{0}^{\prime}, \xi_{0}^{\prime}\right), \tau_{0}\right) \notin$ $\operatorname{supp} \mu$ for small $s$, which proves Proposition 9.18 in this case.

## Case (4)

Then by Remark 9.20 we have $\zeta \notin \operatorname{supp} \nu$ which is a contradiction. Therefore one can find $s_{1} \in[0, \beta]$ such that $\zeta_{1}=\Gamma\left(-s_{1}, \zeta\right) \in \mathcal{G}^{k}$ (since $\zeta_{1} \in V_{1}$ ) and

If $s_{1} \neq 0$ then $\zeta=\Gamma\left(s_{1}, \zeta_{1}\right) \in T^{*} M$ which contradicts our assumption. If $s_{1}=0$ then $\zeta=\zeta_{1} \in \mathcal{G}^{k}$ which again contradicts the fact that $\zeta \in \mathcal{H} \cup \mathcal{G}_{g}$ since $k$ is odd, $k \geq 3$, in this case. Thus (9.57) is proved. It follows then, from Proposition 9.12, that ${ }^{t} H_{p} \mu=0$ on $\pi^{-1}(\widetilde{U})$ therefore on a complete neighborhood of $\pi^{-1}\left(\zeta_{0}\right)$ in $T^{*} \mathbb{R}^{d+1}$ since $\mu \equiv 0$ in $x_{1}<0$. Now $\left(x\left(s, x_{0}, \xi_{0}\right), t_{0}, \xi\left(s, x_{0}, \xi_{0}\right), \tau_{0}\right)$ is contained in $\left\{(x, t, \xi, \tau): x_{1}<0\right\}$ when $\beta+s<0$. By propagation along the bicharacteristics of $p$ (since ${ }^{t} H_{p} \mu=0$ ) we deduce that $\Gamma\left(s, \zeta_{0}\right)=\left(x\left(s, x_{0}, \xi_{0}\right), t_{0}, \xi\left(s, x_{0}, \xi_{0}\right), \tau_{0}\right)$ does not intersect $\operatorname{supp} \mu$ when $s>0$ is small enough. The proof of Theorem 5.2 is complete.

### 9.3 Proofs of the technical Lemmas

We shall need the following elementary result.
Lemma 9.22. Let $P=\sum_{j, k=1}^{d} D_{j} a^{j k}(x) D_{k}+V$ where $P$ satisfies conditions (2.3), (2.5) and $V \geq 1$. Then there exists $C \geq 0$ such that for any $z \in \mathbb{C}$ such that $\operatorname{Im} z \neq 0$, any $h$ in ] 0,1 ] and any solution $u \in H_{0}^{1}(\Omega)$ of the problem $h^{2} P u-z u=f$ with $f \in L^{2}(\Omega)$ we have

In that follows, we shall make a great use of the so called Helffer-Sjöstrand formula (see [Da]) which will recall now.

Let $\theta \in \mathcal{C}_{0}^{\infty}(\mathbb{R})$. We defined an «almost analytic extension» of $\theta$ as follows. Let $\varphi \in$ $\mathcal{C}_{0}^{\infty}(\mathbb{R})$ be such that $\varphi(t)=1$ if $|t| \leq 1, \varphi(t)=0$ if $|t| \geq 2$.

We set

\left\|h D_{j} \theta\left(h^{2} P\right) f\right\|_{L^{2}} \leq \frac{1}{\pi} \int|\bar{\partial} \widetilde{\theta}(x, y)|\left\|h \partial_{j}\left(z-h^{2} P\right)^{-1} f\right\|_{L^{2}} \mathrm{~d} x \mathrm{~d} y
$$

so using Lemma 9.22 we obtain

$$
\left\|h D_{j} \theta\left(h^{2} P\right) f\right\|_{L^{2}} \leq C \int|\bar{\partial} \widetilde{\theta}(x, y)| \frac{\langle | z| \rangle}{|\operatorname{Im} z|} \mathrm{d} x \mathrm{~d} y\|f\|_{L^{2}} \leq C^{\prime}\|f\|_{L^{2}}
$$

(iii) We have as above

$$
h D_{j}\left[\theta\left(h^{2} P\right), \chi\right]=-\frac{1}{\pi} \int_{\mathbb{R}^{2}} \bar{\partial} \widetilde{\theta}(x, y) h D_{j}\left[\left(z-h^{2} P\right)^{-1}, \chi\right] \mathrm{d} x \mathrm{~d} y
$$

and

$$
h D_{j}\left[\left(z-h^{2} P\right)^{-1}, \chi\right]=h D_{j}\left(z-h^{2} P\right)^{-1} h^{2}[P, \chi]\left(z-h^{2} P\right)^{-1}
$$

Using again Lemma 9.22 we obtain

$$
\begin{aligned}
& \left\|h D_{j}\left[\left(z-h^{2} P\right)^{-1}, \chi\right] f\right\|_{L^{2}} \leq C \frac{\langle | z| \rangle}{|\operatorname{Im} z|}\left\|h^{2}[P, \chi]\left(z-h^{2} P\right)^{-1} f\right\|_{L^{2}} \\
& \quad \leq \frac{C h\langle | z| \rangle}{|\operatorname{Im} z|}\left(\sum_{j=1}^{d}\left\|h D_{j}\left(z-h^{2} P\right)^{-1} f\right\|_{L^{2}}+h\left\|\left(z-h^{2} P\right)^{-1} f\right\|_{L^{2}}\right) \leq C^{\prime} h \frac{\langle | z| \rangle^{2}}{|\operatorname{Im} z|}\|f\|_{L^{2}}
\end{aligned}
$$

and we conclude as before.

## Proof of Lemma 8.2

We proceed as above. We have using (9.63) and Lemma 9.22

$$
\begin{aligned}
& \left\|\left[\theta\left(h^{2} P\right), \chi_{0} P^{\frac{1}{4}}\right] v\right\|_{L^{2}} \\
& \leq \frac{1}{\pi} \int_{\mathbb{R}^{2}}|\bar{\partial} \widetilde{\theta}(x, y)|\left\|\left(z-h^{2} P\right)^{-1} h^{2}\left[P, \chi_{0}\right] P^{\frac{1}{4}}\left(z-h^{2} P\right)^{-1} v\right\|_{L^{2}} \mathrm{~d} x \mathrm{~d} y \\
& \leq C \int_{\mathbb{R}^{2}}|\bar{\partial} \widetilde{\theta}(x, y)| \frac{h}{|\operatorname{Im} z|}\left(\sum_{j=1}^{n}\left\|h D_{j} P^{\frac{1}{4}}\left(z-h^{2} P\right)^{-1} v\right\|_{L^{2}}+\left\|h P^{\frac{1}{4}}\left(z-h^{2} P\right)^{-1} v\right\|_{L^{2}}\right) \mathrm{d} x \mathrm{~d} y
\end{aligned}
$$

Now we have with $u=\left(z-h^{2} P\right)^{-1} v \in D(P)$

$$
\begin{aligned}
\left\|h D_{j} P^{\frac{1}{4}} u\right\|_{L^{2}} & =h^{-\frac{1}{2}}\left\|h D_{j}\left(h^{2} P\right)^{\frac{1}{4}} u\right\|_{L^{2}} \leq C h^{-\frac{1}{2}}\left\|\left(h^{2} P\right)^{\frac{1}{2}}\left(h^{2} P\right)^{\frac{1}{4}} u\right\|_{L^{2}} \\
& \leq C h^{-\frac{1}{2}} \frac{\langle | z| \rangle}{|\operatorname{Im} z|}\|v\|_{L^{2}}
\end{aligned}
$$

by interpolation using Lemma 9.22. It follows that

$$
\left\|\left[\theta\left(h^{2} P\right), \chi_{0} P^{\frac{1}{4}}\right] v\right\|_{L^{2}} \leq C \int_{\mathbb{R}^{2}}|\bar{\partial} \widetilde{\theta}(x, y)| h^{\frac{1}{2}} \frac{\langle | z| \rangle}{|\operatorname{Im} z|^{2}} \mathrm{~d} x \mathrm{~d} y\|v\|_{L^{2}} \leq C h^{\frac{1}{2}}\|v\|_{L^{2}}
$$
