On the self-displacement of deformable bodies in an ideal fluid

Abstract

Understanding fish-like locomotion as a result of internal shape changes may result in improved underwater propulsion mechanism. In this article, we study a coupled system of partial differential equations and ordinary differential equations which models the motion of self-propelled deformable bodies (called swimmers) in an ideal fluid. The deformations being prescribed, we apply the least action principle of Lagrangian mechanics to determine the equations of the inferred motion. We prove that the swimmers degrees of freedom solve a second order system of nonlinear ordinary differential equations. Under suitable smoothness assumptions on the fluid's domain boundary and on the given deformations, we prove the existence and regularity of the bodies rigid motions, up to a collision between two swimmers or between a swimmer with the boundary of the fluid. Then we compute explicitly the Euler-Lagrange equations in terms of the geometric data of the bodies and of the value of the fluid's harmonic potential on the boundary of the fluid.

1 Introduction

1.1 History

Initiated by the mathematician, physician and physiologist G. A. Borelli [6] in 1680 and 1681 and continued much later by zoologists and engineers like C. M. Breder [8] and J. Gray [16], [17] in a series of papers, the investigations to understand the locomotion of aquatic animals have given rise, up to recent time, to numerous scientific publications. This constant interest grown from the constatation that aquatic mammals and fishes evolved swimming capabilities far superior to what has been achieved by naval technology. A better understanding of the biomechanics of swimming may allow to improve the efficiency, manoeuvrability and stealth of underwater vehicles.

After 1910 until 1950 research was done largely by zoologists and engineers. In the early 1950's the mathematically oriented scientists entered the scene and began to develop theories by which it became possible to make qualitative analysis of swimming propulsion as a continuation of the previously developed quantitative theories. For example, Sir. G. Taylor studies both large and microscopic swimming

animals in [35], [34]. Significant contributions are due to T. Y. Wu [38], J. Lighthill [26] and S. Childress [12]. Recently, J. A. Sparenberg published a survey on the mathematical theory of fish locomotion [33] to which we refer for a more complete bibliography on this period.

In the past few years, serious efforts have emerged to study, build and control underwater vehicles that move and steer by changes of shape and not by direct propulsion, such as propellers; see for example the works of M. and G. Triantafyllou and D. K. P. Yue [36], S. D. Kelly and R. M. Murray [23] and E. Kanso, J. E. Marsden, C. W. Rowley and J. B. Melli-Huber [21] and references therein.

Experiments have shown that the vortices generated by the tail of fishes play a crucial role to understand their locomotion. Some models incorporate artificially vortices, like those of R. Mason [28] and Q. Zhu, M. J. Wolfgang, D. K. P. Yue and M. S. Triantafyllou [39], detailed in [15], [22] and [24]. If we do not neglect the viscosity effects, the relevant model consists in the non stationary Navier-Stokes equations for the fluid coupled with Newton's laws for the fish-like swimming object. This perspective is adopted by J. Carling, T. Williams and G. Bowtell [9], H. Liu and K. Kawachi [27] and J. San Martin, J. F. Sheid, T. Takahashi and M. Tucsnak [31].

Nevertheless, among numerous mathematical articles studying fish locomotion, most of them address the case of a potential flow which is by definition vortex-free. It is the point of view we have chosen in the following and on which we focus from now on.

1.2 Swimming in a potential flow

The study the of the coupled dynamics of a solid immersed in an infinite extended ideal fluid was initiated by Thomson, Tait, and Kirchhoff. Sir H. Lamb explains their approach in [25, chap. VI, page 160]: The cardinal feature of the methods followed by these writers consists in this, that the solids and the fluid are treated as forming together one dynamical system, and thus the troublesome calculation of the effect of the fluid pressures on the surfaces of the solids is avoided. They introduce as unknowns of the problem a moment-like quantity called *impulse*. Denoting respectively \mathbf{F} and \mathbf{T} the extraneous force and torque acting on the solid and applying to the system fluid-solid the principle of conservation of linear and angular momenta, they derive the equations of motion which take the form:

$$\mathbf{\Pi} = \mathbf{\Pi} \times \boldsymbol{\omega} + \mathbf{P} \times \mathbf{v} + \mathbf{T}, \quad \mathbf{P} = \mathbf{P} \times \boldsymbol{\omega} + \mathbf{F}.$$

In the above system, $(\mathbf{\Pi}, \mathbf{P})^T$ is the impulse and $\boldsymbol{\omega}, \mathbf{v}$ are respectively the angular and translational velocity vectors of the body relative to a body fixed frame. The first component of the impulse is the *body* angular momenta, $\mathbf{\Pi} := ([I_{ac}] + [I_{ad}])\boldsymbol{\omega}$ where $[I_{ac}]$ is the actual inertia matrix of the solid and $[I_{ad}]$ is the so-called added inertia matrix. The second component is the *body*'s linear momentum $\mathbf{P} := (m[\mathbb{I}_3] + [M_{ad}])\mathbf{v}$, in which m is the actual mass of the solid, $[\mathbb{I}_3]$ the 3×3 identity matrix and $[M_{ad}]$ the added mass matrix. Both added inertia matrix and added mass matrix depend on the density of the fluid and on the geometry of the fluid's domain, through the solution of a boundary value problem. In the case of a solid alone in an boundless fluid, $[I_{ad}]$ and $[M_{ad}]$ are both constant, since the fluid's domain as viewed by an observer attached to the solid remains unchanged in the motion.

Later in his book [25, chap IV, page 187], Sir H. Lamb tackles a more involved problem: When we have more than one moving solid, or when the fluid is bounded, wholly or in part, by fixed walls, we may have recourse to Lagrange's method of 'generalized co-ordinates'. Indeed, introducing the generalized coordinates $\mathbf{q} := (q_1, \ldots, q_n)^{\top}$ of the problem and the generalized velocities $\dot{\mathbf{q}} := (\dot{q}_1, \ldots, \dot{q}_n)^{\top}$, they show that the kinetic energy of the system fluid-solids reads $\mathcal{K} = \dot{\mathbf{q}} \cdot [K(\mathbf{q})]\dot{\mathbf{q}}/2$ where the $n \times n$ matrix $[K(\mathbf{q})]$ is the virtual mass matrix. Its entries $K_{ij}(\mathbf{q})$ depend on the mass and on the inertia matrices of the solids but also on the density of the fluid and on the geometry of the fluid's domain through the solution of a boundary value problem. Contrary to what happens in the case of a sole solid, when there are several solids or fixed walls, the virtual mass matrix is no longer constant but does depend on the relative position of the immersed objects. The least action principle of Lagrangian's mechanics yields the equations of motion:

$$\frac{d}{dt}\partial_{\dot{q}_i}\mathcal{K} - \partial_{q_i}\mathcal{K} = Q_i, \quad i = 1, \dots, n,$$

where Q_i are generalized components of force. Plugging the expression of K into (1.2), they obtain a system of ODE's for q_1, \ldots, q_n :

$$\frac{d}{dt}\left(\sum_{j} K_{ij}(\mathbf{q})\dot{q}_{j}\right) - \frac{1}{2}\sum_{j,k} \partial_{q_{i}}K_{jk}(\mathbf{q})\dot{q}_{j}\dot{q}_{k} = Q_{i}, \quad i = 1, \dots, n.$$

Notice however that before writing this equation, we have to prove that the mappings $\mathbf{q} \mapsto M_{ij}(\mathbf{q})$ is smooth enough to be differentiated. Since the expression of $[K(\mathbf{q})]$ involves the solution of a boundary value problem on the fluid's domain, this task requires to study the sensitivity of a solution of a PDE with respect to the geometry of its domain. The regularity of the boundaries of the solids and fluid will play a crucial role when discussing this point. After proving that $\partial_{q_i} K_{ij}$ is well defined, the next step would be to compute explicitly its expression. Invoking the chain rule, we can rewrite the ODE's (1.3):

$$\sum_{j} K_{ij}(\mathbf{q}) \ddot{q}_{j} + \sum_{j,k} \partial_{q_{k}} K_{ij}(\mathbf{q}) \dot{q}_{k} \dot{q}_{j} - \frac{1}{2} \sum_{j,k} \partial_{q_{i}} K_{jk}(\mathbf{q}) \dot{q}_{j} \dot{q}_{k} = Q_{i}, \quad i = 1, \dots, n.$$

To our knowledge, although these equations have been studied in the cases of simple geometries (for example, the solids are a set of spheres or of ellipsoids) by performing explicit computations, they have not been tackled in the general case up to a very recent time. In [14] we prove, assuming only that the boundaries of solids and the fluid are Lipschitz continuous (which allows *corners*), that the mass matrix is indefinitely differentiable with respect to the generalized coordinates and that the system of ODE's (1.4) is well posed and admits a unique solution which is also indefinitely differentiable. As a corollary of a more general result presented later in in this paper, we will slightly improve this result and prove that both the mass matrix and the solutions of (1.4) are in fact analytic.

An alternative approach, when several immersed objects are involved, is to assume that they are *hydrodynamically decoupled*. It means that the added inertia and added mass associated with a given body is not affected by the presence of the others. Since each body is considered as being alone in the fluid, the impulse method applies.

Settle the equations of motion for shape-changing bodies is a more involved task. When the deformable body is an articulated system of solids connected via ball-and-socket or hinge joints, E. Kanso, J. E. Marsden, C. W. Rowley and J. B. Melli-Huber [21] prove that the impulse method can be adapted, assuming the fluid to be of infinite extend. They obtain equations quite similar to (1.1). The proof is based on the observation that the Lagrangian of the system is invariant under superimposed rigid motions. The limitations of this approach are that no extraneous force like the buoyant force can be taken into account, the fluid has to be free of any other object and the motion has to start from rest. Some authors assume in addition that each link is hydrodynamically decoupled from the others. This hypothesis leads to significative simplifications. However, E. Kanso, J. E. Marsden, C. W. Rowley and J. B. Melli-Huber [21] and J. B. Melli, C. W. Rowley and D. S. Rufat [29] show with numerical simulations that in this case the motion differs from that of the same system in its full complexity.

In this paper we study the locomotion of a set of shape-changing bodies in a fluid that can be partially or totally bounded. We derive the equations of motions from Lagrangian mechanics and obtain a system of ODE's roughly similar to (1.4) for the generalized coordinates (which are the degrees of freedom of the bodies). We prove the existence, uniqueness and regularity of solutions assuming that the boundaries of the bodies and the fluid are Lipschitz continuous only. The key point consists in studying the regularity of the potential of the flow with respect to the geometry of the fluid's domain. This task is achieved using tools of shape optimization theory. Similar techniques are being developed in the area of fluid-structures dynamics by M. Moubachir J. P. Zolesio [30].

Our second contribution is to write the system of ODE's in a form that is convenient for numerical simulation and for studying locomotion. The equations involve in particular geometric data of the bodies, like the curvature of their boundaries.

1.3Outline of the paper

This paper is organized as follows: after determining the equations of motion and stating the main results in the next section, we compute the Lagrangian of the system bodies-fluid in Section 3. In Section 4, we address an abstract shape optimization problem whose results are used in Section 5 in the proofs of Theorem 2.1 and Corollary 2.1. Section 6 is devoted to the proof of Theorem 2.2 and in Section 7 we indicate some future directions of investigations. The Appendix contains technical results.

1.4 Notation

Throughout this article, we shall use bold print notations for vectors like \mathbf{x} , \mathbf{h} , \mathbf{q} whereas we keep the usual characters for their coordinates x_i , h_i , q_i and in a general way for any real valued functions like ϕ , φ . The canonical basis of the physical space \mathbb{R}^3 is $\{e_1, e_2, e_3\}$.

A matrix is denoted in square brackets [M], its entries are $M_{j_1j_2}$, $[M]^T$ is the transposed matrix, $[\mathbb{I}_3]$ is the identity matrix of \mathbb{R}^3 and $[\mathbb{O}_3]$ the null matrix. The Jacobian matrix of a differentiable function φ is $[D\varphi]$.

The Euclidian norm in \mathbb{R}^3 is denoted $|\mathbf{x}|$ and we keep the same notation for the associated matrix norm $|[M]| := \sup_{|\mathbf{x}|=1} |[M]\mathbf{x}|, [M] \in \mathcal{M}(3)$ (the vector space of the 3×3 matrices).

We use double square brackets for third-rank tensors like [T]. Its entries are $T_{j_1j_2j_3}$. We use the convention $(\llbracket T \rrbracket \mathbf{q})_{j_1j_2} := \sum_{j_3} T_{j_1j_2j_3} q_{j_3}$ and $(\langle \llbracket T \rrbracket, \mathbf{p}, \mathbf{q} \rangle)_{j_1} := \sum_{j_2} \sum_{j_3} T_{j_1j_2j_3} p_{j_2} q_{j_3}$, where q_i and p_i are the coordinates of \mathbf{q} and \mathbf{p} . If E_k , $k = 1, \ldots, p$ and F are p+1 Banach spaces, we denote $L_p(E_1 \times \ldots \times E_p, F)$

the Banach space of the *p*-linear continuous maps from $E_1 \times \ldots \times E_p$ into *F*.

$\mathbf{2}$ Modelling and main results

2.1Modelling

We denote by $S(t) := \bigcup_{i=1}^{n} S^{i}(t)$ the region of the *n* swimmers at time *t* and by $\Omega(t)$ the domain of the surrounding fluid. The boundary $\partial \Omega(t)$ of the fluid is decomposed into the boundary shared with the swimmers $\Gamma_2(t) := \bigcup_{i=1}^n \Gamma_2^i(t) := \bigcup_{i=1}^n \partial S^i(t)$ and

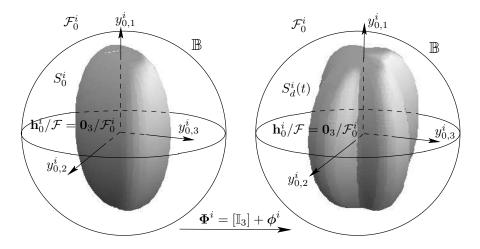


Figure 1: The deformation of the *i*-th body is given in the frame \mathcal{F}_0^i by a smooth function ϕ^i such that $[\mathbb{I}_3] + \phi^i$ maps \mathbb{B} onto \mathbb{B} .

$$\begin{split} &\Gamma_1 := \partial\Omega(t) \setminus \Gamma_2(t). \text{ We set } \Omega := \Omega(0), \ S_0^i := S^i(0), \ S_0 := S(0) \text{ and } \Gamma_2 := \Gamma_2(0). \\ &\text{We will assume in the sequel that } \Omega \text{ is an open and connected set, that } \Gamma_2 \text{ is compact and that } \Gamma_1 \text{ is either bounded, either an hyperplane. Let } \mathcal{F} \text{ be an inertial reference frame. In } \mathcal{F}, \text{ the coordinates of the center of mass of the } i-\text{th swimmer are } \mathbf{h}^i(t) := (h_1^i(t), h_2^i(t), h_3^i(t))^T \text{ at time } t. \text{ We fix a frame } \mathcal{F}^i(t) \text{ of origin } \mathbf{h}^i(t) \\ &\text{to each swimmer and we write } \mathbf{h}_0^i := \mathbf{h}^i(0) \text{ and } \mathcal{F}^i(0) := \mathcal{F}_0^i. \text{ Considering } M^i(t) \\ &\text{a material point of } S^i(t) \text{ of coordinates } \mathbf{x}^i(t) := (x_1^i(t), x_2^i(t), x_3^i(t))^T \text{ in } \mathcal{F} \text{ and } \\ &\mathbf{y}^i(t) := (y_1^i(t), y_2^i(t), y_3^i(t))^T \text{ in } \mathcal{F}^i(t), \text{ there exists a rotation matrix } [R^i(t)] \in SO(3) \\ &\text{(the rotation group of } \mathbb{R}^3) \text{ such that } \mathbf{x}^i(t) = [R^i(t)]\mathbf{y}^i(t) + \mathbf{h}^i(t). \text{ We can assume,} \\ &\text{without loss of generality, that } [R^i(0)] = [\mathbb{I}_3]. We assume that the motion of \\ &M^i(t) \text{ in } \mathcal{F}^i(t) \text{ is only due to the deformation of the body } S^i(t). \text{ Introducing then } \\ &S_0^i \text{ into } S_d^i(t) \text{ is described in } \mathcal{F}_0^i \text{ by a given one-to-one smooth function } \mathbf{\Phi}^i(t, \mathbf{y}_0^i) \\ &\text{where } \mathbf{y}_0^i := \mathbf{y}^i(0) = \mathbf{x}_0^i - \mathbf{h}_0^i \text{ (see Figure 1)}. \end{split}$$

We therefore have with the notations above: $\mathbf{y}^{i}(t) = \mathbf{\Phi}(t, \mathbf{y}_{0}^{i})$ and $S_{d}^{i}(t) = \mathbf{\Phi}^{i}(t, S_{0}^{i})$. The coordinates of $M^{i}(t)$ in the inertial frame \mathcal{F} read:

$$\mathbf{x}^{i}(t) = [R^{i}(t)]\mathbf{\Phi}^{i}(t, \mathbf{x}_{0}^{i} - \mathbf{h}_{0}^{i}) + \mathbf{h}^{i}(t), \qquad (2.1)$$

and we define the following map using the partition $\bigcup_{i=1}^{n} S_{0}^{i}$ of S_{0} :

$$\begin{split} \mathbf{\Lambda} &: [0,\infty) \times S_0 \quad \to \quad \mathbb{R}^3 \\ &(t,\mathbf{x}) \quad \mapsto \quad [R^i(t)] \mathbf{\Phi}^i(t,\mathbf{x}-\mathbf{h}^i_0) + \mathbf{h}^i(t), \text{ if } \mathbf{x} \in S^i_0. \end{split}$$

We denote $\phi^i := \Phi^i - [\mathbb{I}_3]$ and $\dot{\phi}^i := \partial_t \phi^i$. Let \mathbb{B} be a ball in \mathbb{R}^3 , centered at the origin an large enough to contain all the initial regions $S_0^i - \mathbf{h}_0^i$ for $i = 1, \ldots, n$. We assume that $\phi^i = (\phi_1^i, \phi_2^i, \phi_3^i)^T \in C_c^m(\mathbb{B}, \mathbb{R}^3)$ $(m \ge 0)$, the space of the functions from \mathbb{B} into \mathbb{R}^3 , m-times continuously differentiable and compactly supported. Differentiating (2.1) with respect to t, we obtain: $\dot{\mathbf{x}}^i(t) = [\dot{R}^i(t)] \Phi^i(t, \mathbf{x}_0^i - \mathbf{h}_0^i) + [R^i(t)] \dot{\phi}^i(t, \mathbf{x}_0^i - \mathbf{h}_0^i) + \dot{\mathbf{h}}^i(t)$. Combining this identity with (2.1), it comes:

$$\dot{\mathbf{x}}^{i}(t) = [\dot{R}^{i}(t)][R^{i}(t)]^{T}(\mathbf{x}^{i}(t) - \mathbf{h}^{i}(t)) + \dot{\mathbf{h}}^{i}(t) + [R^{i}(t)]\dot{\boldsymbol{\phi}}^{i}(t, \mathbf{\Lambda}^{-1}(t, \mathbf{x}^{i}(t)) - \mathbf{h}_{0}^{i}).$$

The matrix $[\dot{R}^{i}(t)][R^{i}(t)]^{T}$ being skew symmetric, there exists a vector $\boldsymbol{\omega}^{i}(t)$ such that $[\dot{R}^{i}(t)][R^{i}(t)]^{T}(\mathbf{x}^{i}(t) - \mathbf{h}^{i}(t)) = \boldsymbol{\omega}^{i}(t) \wedge (\mathbf{x}^{i}(t) - \mathbf{h}^{i}(t))$ and we define, for all

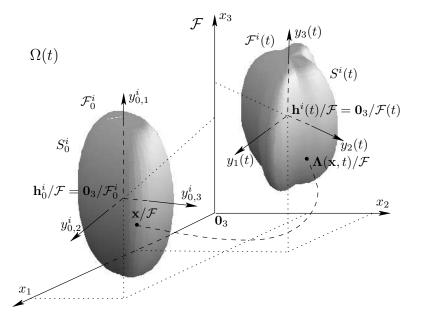


Figure 2: The rigid body $S^i(t)$ and the fluid domain $\Omega(t)$. The frames \mathcal{F}_0^i and \mathcal{F} are fixed whereas $\mathcal{F}^i(t)$ moves with the *i*-th swimmer. The coordinates of a material point that we follow in his motion is \mathbf{x} at time t = 0 in \mathcal{F} and $\mathbf{\Lambda}(t, \mathbf{x})$ in the same frame at time t > 0.

 $\mathbf{x} \in S(t),$ the Eulerian deformation velocity \mathbf{v}_d^i and the Eulerian rigid velocity \mathbf{v}_r^i by:

The Eulerian velocity in $S^i(t)$ is therefore:

$$\mathbf{v}^{i}(t,\mathbf{x}) = \mathbf{v}_{r}^{i}(t,\mathbf{x}) + \mathbf{v}_{d}^{i}(t,\mathbf{x}), \quad \forall t \ge 0.$$

We denote $\rho_S(t, \mathbf{x})$ the density of the bodies, defined for all $\mathbf{x} \in S(t)$ and for all $\mathbf{x} \in S_0$ we set $\rho_S^0(\mathbf{x}) := \rho_S(\mathbf{x}, 0)$. The principle of conservation of mass leads to the identity:

$$\rho_S(t, \mathbf{x}) = \rho_S^0(\mathbf{\Lambda}^{-1}(t, \mathbf{x})) |\det[D\mathbf{\Lambda}^{-1}(t, \mathbf{x})]|, \quad \forall t \ge 0, \ \forall \mathbf{x} \in S(t).$$

We assume that the swimmers are self-propelled, which means that their deformations are due to inner forces only. The principle of conservation of linear and angular momenta ensures that, for all time t and all i = 1, ..., n:

When the domain of the fluid $\Omega(t)$ is bounded and since the fluid is incompressible, both quantities $\int_{\Omega(t)} d\mathbf{x}$ and $\int_{S(t)} d\mathbf{x}$ do not depend on time. By virtue of [18, Theorem 5.2.2 page 172], we deduce that, for all time t:

$$\sum_{i=1}^{n} \int_{S^{i}(t)} \operatorname{div}(\mathbf{v}_{d}^{i}(t, \mathbf{x})) \, \mathrm{d}\mathbf{x} = 0, \qquad (2.7a)$$

or equivalently, upon a change of variables:

Relations (2.7) mean that the volume of the fluid and the volume of the swimmers are globally preserved in the motion; see Section A.3 of the Appendix for a precise definition of the deformations set $\mathcal{D}^{n,m}$.

According to Relation (2.1), the location and the shape of the *i*-th body are given by a pair $\mathbf{Q}^i := ([R^i], \mathbf{h}^i) \in SO(3) \times \mathbb{R}^3$ and a function $\phi^i := (\phi_1^i, \phi_2^i, \phi_3^i)^T \in C_c^m(\mathbb{B}, \mathbb{R}^3)$. We write $\mathbf{Q} := (\mathbf{Q}^1, \dots, \mathbf{Q}^n) := (([R^1], \mathbf{h}^1), \dots, ([R^n], \mathbf{h}^n)) \in (SO(3) \times \mathbb{R}^3)^n$, and $\phi := (\phi^1, \dots, \phi^n)^T = (\phi_1^1, \phi_2^1, \phi_3^1, \dots, \phi_1^n, \phi_2^n, \phi_3^n)^T \in C_c^m(\mathbb{B}, \mathbb{R}^3)^n$. In Section A.3 of the Appendix, we define the 6n- dimensional manifold $\mathcal{Q}_{ad}^{n,m}$ of the swimmers admissible positions and shapes. The pairs (\mathbf{Q}, ϕ) of $\mathcal{Q}_{ad}^{n,m}$ are called the global coordinates in the sequel. Building a local chart, we define the open set $\mathfrak{Q}_{ad}^{n,m} \subset \mathbb{R}^{6n} \times C_c^m(\mathbb{B}, \mathbb{R}^3)^n$ of the local coordinates, denoted (\mathbf{q}, ϕ) . In the same section of the Appendix, we introduce also the tangent bundles $T\mathcal{Q}_{ad}^{n,m} \ni (\mathbf{Q}, \phi, \dot{\mathbf{Q}}, \dot{\phi})$ and $T\mathfrak{Q}_{ad}^{n,m} \ni (\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi})$.

2.2 Lagrangian mechanics

The equations of motion are obtained by applying the least action principle of Lagrangian mechanics. In local coordinates, the Lagrangian reads:

It is obtained as the difference between the total kinetic energy of the system and the potential energy due to the buoyant force acting on the bodies. It will be computed explicitly in Section 3. The deformation ϕ (hence $\dot{\phi}$ too) of the swimmers being given, the vectorial Euler-Lagrange equation of the motion reads, following [3, page 56]:

Since \mathcal{L} depends on time only through the variables $(\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi})$ and if \mathcal{L} is smooth enough, we can apply the chain rule and rewrite (2.9) under the form of a second order ODE in \mathbf{q} :

$$\left\langle \partial^{2}_{\dot{\mathbf{q}}\dot{\mathbf{q}}} \mathcal{L}(\mathbf{q},\boldsymbol{\phi},\dot{\mathbf{q}},\dot{\boldsymbol{\phi}}),\ddot{\mathbf{q}} \right\rangle + \left\langle \partial^{2}_{\mathbf{q}\dot{\mathbf{q}}} \mathcal{L}(\mathbf{q},\boldsymbol{\phi},\dot{\mathbf{q}},\dot{\boldsymbol{\phi}}),\dot{\mathbf{q}} \right\rangle + \left\langle \partial^{2}_{\dot{\boldsymbol{\phi}}\dot{\mathbf{q}}} \mathcal{L}(\mathbf{q},\boldsymbol{\phi},\dot{\mathbf{q}},\dot{\boldsymbol{\phi}}),\ddot{\boldsymbol{\phi}} \right\rangle \\ + \left\langle \partial^{2}_{\boldsymbol{\phi}\dot{\mathbf{q}}} \mathcal{L}(\mathbf{q},\boldsymbol{\phi},\dot{\mathbf{q}},\dot{\boldsymbol{\phi}}),\dot{\boldsymbol{\phi}} \right\rangle - \partial_{\mathbf{q}} \mathcal{L}(\mathbf{q},\boldsymbol{\phi},\dot{\mathbf{q}},\dot{\boldsymbol{\phi}}) = \mathbf{0}_{6n}.$$
(2.10)

2.3 Statement of the main results

The first result concerns the existence and uniqueness of local solutions for the ODE (2.10). We denote $\phi_0 := ([\mathbb{O}_3], \dots, [\mathbb{O}_3]) \in C_c^m(\mathbb{B}, \mathbb{R}^3)^n$.

Theorem 2.1 (Existence and uniqueness of local solutions) Assume that $\partial\Omega$ is Lipschitz continuous and m = 1 in (2.8). Then the Lagrangian (2.8) is analytic¹ with respect to $(\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi}) \in T\mathfrak{Q}_{ad}^{n,m}$ and all the terms in the ODE (2.10) make sense. For any initial positions and shapes S_0 of the bodies, any $\dot{\mathbf{q}}_0 \in \mathbb{R}^{6n}$ and any given deformations $t \in [0, \infty) \mapsto \phi(t) = (\phi^1(t), \dots, \phi^n(t))^T \in C_c^1(\mathbb{B}, \mathbb{R}^3)^n$ of class C^k ($2 \leq k \leq \infty$) (respectively analytic) such that $\phi(0) = \phi_0$ and $(\phi(t), \dot{\phi}(t)) \in$ $\mathcal{D}^{n,1}$ for all $t \geq 0$, there exists T > 0 and a unique twice differentiable function $\mathbf{q}^* : [0,T) \to \mathbb{R}^{6n}$, for which $\mathbf{q}^*(0) = \mathbf{0}_{6n}$, $\dot{\mathbf{q}}^*(0) = \dot{\mathbf{q}}_0$ and that solves the ODE (2.10). Moreover, the function \mathbf{q}^* is of class C^k (respectively analytic) and $((\mathbf{q}^*(t), \phi(t)), (\dot{\mathbf{q}}^*(t), \dot{\phi}(t)) \in T\mathfrak{Q}_{ad}^{n,1}$ for all $0 \leq t < T$.

Combining this theorem with an $a \ priori$ energy estimate and using local charts, we will show:

Corollary 2.1 (Existence and uniqueness of global solutions) Assume that $\partial\Omega$ is Lipschitz continuous. Then for any initial position and shape S_0 of the bodies, any collection of $n \ 3 \times 3$ skew-symmetric matrices $[\dot{R}_0^1], \ldots, [\dot{R}_0^n]$, any initial velocities $(\dot{\mathbf{h}}_0^1, \ldots, \dot{\mathbf{h}}_0^n) \in \mathbb{R}^{3n}$ and any given deformations $t \in [0, \infty) \mapsto \phi(t) = (\phi^1(t), \ldots, \phi^n(t))^T \in C_c^1(\mathbb{B}, \mathbb{R}^3)^n$ of class C^k $(2 \le k \le \infty)$ (respectively analytic) such that $\phi(0) = \phi_0$ and $(\phi(t), \dot{\phi}(t)) \in \mathcal{D}^{n,1}$ for all $t \ge 0$, there exists $0 < T^* \le \infty$ and a unique twice differentiable function:

$$\begin{aligned} \mathbf{Q}^* &: [0, T^*) &\to (SO(3) \times \mathbb{R}^3)^n \\ t &\mapsto (([R^1(t)], \mathbf{h}^1(t)), \dots, ([R^n(t)], \mathbf{h}^n(t))), \end{aligned}$$

for which $\mathbf{Q}^*(0) = ([\mathbb{I}_3], \mathbf{h}_0^1, \dots, [\mathbb{I}_3], \mathbf{h}_0^n)$, $\dot{\mathbf{Q}}^*(0) = ([\dot{R}_0^1], \dot{\mathbf{h}}_0^1, \dots, [\dot{R}_0^n], \dot{\mathbf{h}}_0^n)$ and such that the coordinates $\mathbf{x}^i(t)$ in \mathcal{F} of a material point, occupying position $\mathbf{x}_0^i \in S_0^i$ at instant t = 0 be given by (2.1). Furthermore, the function \mathbf{Q}^* is of class C^k (respectively analytic) and $((\mathbf{Q}^*(t), \phi(t)), (\dot{\mathbf{Q}}^*(t), \dot{\phi}(t)) \in T\mathcal{Q}_{ad}^{n,1}$ for all $0 \le t < T^*$. Time T^* corresponds to the time of the first collision between two bodies or between a body with the fluid's domain boundary. If there is no collision $T^* = \infty$.

Specifying ϕ to be the null function, the bodies behave like a set of n solids in a perfect fluid. We deduce straightforwardly from Corollary 2.1:

Corollary 2.2 (Motion of solids in a perfect fluid) Assume that $\partial\Omega$ is Lipschitz continuous. Then, the 6n degrees of freedom of a set of n solids subject or not to the buoyant force in a perfect fluid are analytic functions of t up to the time of the first collision between two solids of between a solid with the fluid's domain boundary.

This result improves the one obtained in [14] in which we prove under the same assumptions that the degrees of freedom of the solids are indefinitely continuously differentiable. In the same paper, we also prove that collisions (i.e. contacts with non zero relative velocity) can occur. This situation heavily contrasts to the one encountered for viscous fluids ; see [19], [20], [32] and [37]. Considering again deformable bodies and assuming additional regularity for the fluid's boundary and for the deformations, we can make the ODE (2.10) explicit. We give the result in the case of a swimmer alone and a bounded fluid's domain:

Theorem 2.2 Assume that Ω is bounded, $\partial\Omega$ is of class $C^{1,1}$, n = 1 and m = 2 in (2.8) and that $t \in [0, \infty) \mapsto \phi(t) \in C_c^2(\mathbb{B}, \mathbb{R}^3)$ is of class C^2 with $(\phi, \dot{\phi}) \in \mathcal{D}_{ad}^{1,2}$ for all $t \geq 0$ and $\phi(0) = [\mathbb{O}_3]$. Then for any $\dot{\mathbf{q}}_0 \in \mathbb{R}^6$, the C^2 -function $\mathbf{q}^* : [0,T) \to \mathbb{R}^6$ of Theorem 2.1 solves the following second order non-linear ODE with initial data $(\mathbf{q}^*(0), \dot{\mathbf{q}}^*(0)) = (\mathbf{0}_6, \dot{\mathbf{q}}_0)$:

$$+ \langle [T_{sym}^{F/r}(t,\mathbf{q})]] + [T_{skew}^{F/r}(t,\mathbf{q})]], \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle$$
$$+ [M_{sym}^{S/d}(t,\mathbf{q})]\dot{\mathbf{q}} + ([M_{sym}^{F/d}(t,\mathbf{q})] + [M_{skew}^{F/d}(t,\mathbf{q})])\dot{\mathbf{q}}$$
$$+ \mathbf{F}^{F/d}(t,\mathbf{q}) + \mathbf{F}^{b}(t,\mathbf{q}) = \mathbf{0}_{6}. \quad (2.11)$$

The 6×6 symmetric matrices $[K_S(t, \mathbf{q})]$, $[K_F(t, \mathbf{q})]$ (nota: $[K_S(t, \mathbf{q})] + [K_F(t, \mathbf{q})]$ is the virtual mass matrix) and $[M_{sym}^{S/d}(t, \mathbf{q})]$ are defined in the Appendix by (A.4), the $6 \times 6 \times 6$ third-rank tensors $[T_{sym}^{S/r}(t, \mathbf{q})]$, $[T_{skew}^{S/r}(t, \mathbf{q})]$, $[T_{sym}^{F/r}(t, \mathbf{q})]$ and $[T_{sym}^{F/r}(t, \mathbf{q})]$ by (A.5), the 6×6 matrices $[M_{sym}^{F/d}(t, \mathbf{q})]$ and $[M_{skew}^{F/d}(t, \mathbf{q})]$ by (A.6) and the 6–length column vectors $\mathbf{F}^{F/d}(t, \mathbf{q})$ and $\mathbf{F}^{b}(t, \mathbf{q})$ by (A.7).

The last term $\mathbf{F}^{b}(t, \mathbf{q})$ of the left hand side of (2.11) is the buoyant force. Choosing for $\boldsymbol{\phi}$ the identically null function, the body behaves like a solid. In this case, all the quantities $[K_{S}(t, \mathbf{q})], [T_{sym}^{S/r}(t, \mathbf{q})], [T_{skew}^{S/r}(t, \mathbf{q})], [T_{skew}^{F/r}(t, \mathbf{q})], [T_{skew}^{F/r}(t, \mathbf{q})]$ and $\mathbf{F}^{b}(t, \mathbf{q})$ depend on times only through the variable \mathbf{q} . Dropping t in the notations:

$$[K_S(\mathbf{q})]\ddot{\mathbf{q}} + \langle \llbracket T_{sym}^{S/r}(\mathbf{q}) \rrbracket + \llbracket T_{skew}^{S/r}(\mathbf{q}) \rrbracket, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle = \mathbf{0}_6,$$

is the Euler-Lagrange equation for the free motion of a rigid body in the absence of fluid and of gravity. In the same way, the Euler-Lagrange equation for the same solid immersed in a bounded weighted fluid is:

3 Computation of the Lagrangian of the system

Keeping the notation $\Phi^i := [\mathbb{I}_3] + \phi^i$ for all i = 1, ..., n, we set $\Phi := (\Phi^1, ..., \Phi^n)^T$: $\mathbb{R}^3 \to \mathbb{R}^{3n}$. In local coordinates (see Appendix, Section A.3), we rewrite (2.1):

The domain of the *i*-th swimmer is $S^i(\mathbf{q}^i, \phi^i) := \mathcal{R}(\boldsymbol{\alpha}^i) \Phi^i(S_0^i - \mathbf{h}_0^i) + \mathbf{h}^i$ and $S(\mathbf{q}, \phi) := \bigcup_{i=1}^n S^i(\mathbf{q}^i, \phi^i), \ \Gamma_2^i(\mathbf{q}, \phi) := \partial S^i(\mathbf{q}, \phi)$ and $\Gamma_2(\mathbf{q}, \phi) := \partial S(\mathbf{q}, \phi)$. The definition (2.2) of the function $\boldsymbol{\Lambda}$ turns into:

Since the compact regions S_0^i and the boundary Γ_1 do not touch or overlap each other, we can extend the function $\mathbf{\Lambda}$ to $\mathfrak{Q}_{ad}^{n,m} \times \mathbb{R}^3$ in such a way that $\mathbf{\Lambda}((\mathbf{q}, \boldsymbol{\phi}), \cdot)|_{\Gamma_1} = [\mathbb{I}_3]$ for all $(\mathbf{q}, \boldsymbol{\phi}) \in \mathfrak{Q}_{ad}^{n,m}$, using an appropriate C^{∞} -partition of unity. The resulting function $\mathbf{\Lambda}((\mathbf{q}, \boldsymbol{\phi}), \cdot)$ is a C^m -diffeormorphism from \mathbb{R}^3 onto \mathbb{R}^3 for all $(\mathbf{q}, \boldsymbol{\phi}) \in \mathfrak{Q}_{ad}^{n,m}$ and the domain of the fluid is $\Omega(\mathbf{q}, \boldsymbol{\phi}) := \mathbf{\Lambda}((\mathbf{q}, \boldsymbol{\phi}), \Omega)$. We rewrite the Eulerian velocities (2.3):

$$\mathbf{v}_{r}^{i}(\mathbf{q},\boldsymbol{\phi},\dot{\mathbf{q}},\mathbf{x}) := \begin{cases} [\omega(\boldsymbol{\alpha}^{i})]\dot{\boldsymbol{\alpha}}^{i} \wedge (\mathbf{x}-\mathbf{h}^{i}) + \dot{\mathbf{h}}^{i} & \text{if } \mathbf{x} \in S^{i}(\mathbf{q}^{i},\boldsymbol{\phi}^{i}), \\ \mathbf{0}_{3} & \text{if } \mathbf{x} \in S(\mathbf{q},\boldsymbol{\phi}) \setminus S^{i}(\mathbf{q}^{i},\boldsymbol{\phi}^{i}), \end{cases}$$
(3.4)

the matrix $[\omega]$ and the vectors $\boldsymbol{\omega}_k$, k = 1, 2, 3, being defined in Section A.1. We denote merely $[\omega^i]$ for $[\omega(\boldsymbol{\alpha}^i)]$ and $\boldsymbol{\omega}_k^i$ for $\boldsymbol{\omega}_k^i(\boldsymbol{\alpha}^i)$. The rigid velocity $\mathbf{v}_r^i(\mathbf{q}, \boldsymbol{\phi}, \dot{\mathbf{q}}, \mathbf{x})$ of the body can be decomposed into $\mathbf{v}_r^i(\mathbf{q}, \boldsymbol{\phi}, \dot{\mathbf{q}}, \mathbf{x}) = \sum_{k=1}^6 \mathbf{v}_r^{i,k}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x})\dot{q}_k^i$, where we have set:

$$\mathbf{v}_{r}^{i,k}(\mathbf{q},\boldsymbol{\phi},\mathbf{x}) \coloneqq \begin{cases} \mathbf{\omega}_{k}^{i} \wedge (\mathbf{x} - \mathbf{h}^{i}) & \text{if } k = 1, 2, 3, \\ \mathbf{e}_{k-3} & \text{if } k = 4, 5, 6, \end{cases} & \text{if } \mathbf{x} \in S^{i}(\mathbf{q}^{i},\boldsymbol{\phi}^{i}), \\ \mathbf{0}_{3} & \text{if } \mathbf{x} \in \cup_{j \neq i} S^{j}(\mathbf{q}^{j},\boldsymbol{\phi}^{j}). \end{cases}$$

The kinetic energy of the i-th body reads:

Taking into account the properties (2.6) and (2.7) of ϕ^i and $\dot{\phi}^i$, the expression above can be expanded as follows:

where $[I^i(\boldsymbol{\alpha}^i, \boldsymbol{\phi}))]$ is the inertia tensor of the *i*-th body. It is classically defined by:

$$[I_0^i(\boldsymbol{\phi}^i)] := \int_{S_0^i} \rho_S^0(|\boldsymbol{\Phi}^i(\mathbf{x} - \mathbf{h}_0^i)|^2 [\mathbb{I}_3] - \boldsymbol{\Phi}^i(\mathbf{x} - \mathbf{h}_0^i) \otimes \boldsymbol{\Phi}^i(\mathbf{x} - \mathbf{h}_0^i)) \, \mathrm{d}\mathbf{x}.$$
(3.6)

Let m^i be the mass of the i-th body. Setting the $6n \times 6n$ symmetric block-diagonal matrix:

$$[K_{S}^{r}(\mathbf{q},\boldsymbol{\phi})] := \operatorname{diag}\left([\omega^{i}]^{T}[I^{1}][\omega^{i}], m^{1}[\mathbb{I}_{3}], \dots, [\omega^{i}]^{T}[I^{n}][\omega^{i}], m^{n}[\mathbb{I}_{3}]\right),$$
(3.7)

and the scalar:

$$K_{S}^{d}(\dot{\phi}, \dot{\phi}) := \sum_{i=1}^{n} \int_{S_{0}^{i}} \rho_{S}^{0} |\dot{\phi}^{i}(\mathbf{x} - \mathbf{h}_{0}^{i})|^{2} \,\mathrm{d}\mathbf{x},$$
(3.8)

we obtain that the total kinetic energy of the bodies is $\mathcal{K}_{S}(\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi}) = (1/2)\dot{\mathbf{q}} \cdot [K_{S}^{r}(\mathbf{q}, \phi)]\dot{\mathbf{q}} + (1/2)K_{S}^{d}(\dot{\phi}, \dot{\phi})$. Let us compute now the kinetic energy of the fluid. The Eulerian velocity in an perfect fluid is given by $\mathbf{u}(t, \cdot) = \nabla \varphi(t, \cdot)^{T}$, where $\varphi(t, \cdot)$ is the harmonic potential. Using the local coordinates, we can write that $\varphi(t, \cdot) = \varphi(\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi}, \cdot)$ and the Kirchoff principle for potential flow allows us to decompose φ into the form $\varphi(\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi}, \cdot) = \sum_{i=1}^{n} \left(\sum_{k=1}^{6} \varphi_{r,k}^{i}(\mathbf{q}, \phi, \cdot) \dot{q}_{k}^{i} + \varphi_{d}^{i}(\mathbf{q}, \phi, \dot{\phi}, \cdot) \right)$ in which the functions $\varphi_{r,k}^{i}(\mathbf{q}, \phi, \cdot)$ are the potentials resulting from the rigid motion

and $\varphi_d^i(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \cdot)$ are the potentials due the deformations of the swimmers. Each potential is harmonic in $\Omega(\mathbf{q}, \boldsymbol{\phi})$ and satisfies Neumann boundary conditions:

$$\partial_{\mathbf{n}}\varphi_{r,k}^{i}(\mathbf{q},\boldsymbol{\phi},\cdot) = 0 \text{ on } \Gamma_{1}, \tag{3.9a}$$

$$\partial_{\mathbf{n}}\varphi_{r,k}^{i}(\mathbf{q},\boldsymbol{\phi},\cdot) = \mathbf{v}_{r}^{i,k} \cdot \mathbf{n} \text{ on } \Gamma_{2}(\mathbf{q},\boldsymbol{\phi}), \quad k = 1,\dots,6,$$
(3.9b)

and

$$\partial_{\mathbf{n}}\varphi_d^i(\mathbf{q},\boldsymbol{\phi},\dot{\boldsymbol{\phi}},\cdot) = 0 \text{ on } \Gamma_1, \quad \partial_{\mathbf{n}}\varphi_d^i(\mathbf{q},\boldsymbol{\phi},\dot{\boldsymbol{\phi}},\cdot) = \mathbf{v}_d^i \cdot \mathbf{n} \text{ on } \Gamma_2(\mathbf{q},\boldsymbol{\phi}).$$
(3.9c)

The vector **n** is the unitary normal to $\partial \Omega(\mathbf{q}, \boldsymbol{\phi})$ directed toward the exterior of the fluid. Following our notation, we denote $\boldsymbol{\varphi}_r^i := (\varphi_{r,1}^i, \ldots, \varphi_{r,6}^i)^T : \Omega(\mathbf{q}, \boldsymbol{\phi}) \to \mathbb{R}^6$ and $\boldsymbol{\varphi}_r := (\boldsymbol{\varphi}_r^1, \ldots, \boldsymbol{\varphi}_r^n)^T : \Omega(\mathbf{q}, \boldsymbol{\phi}) \to \mathbb{R}^{6n}$ whereas $\boldsymbol{\varphi}_d := \sum_{i=1}^n \varphi_d^i$ is a scalar function. Introducing ρ_F , the constant density of the fluid, the kinetic energy of the fluid is:

$$\mathcal{K}_F(\mathbf{q}, \boldsymbol{\phi}, \dot{\mathbf{q}}, \dot{\boldsymbol{\phi}}) = \frac{1}{2} \int_{\Omega(\mathbf{q}, \boldsymbol{\phi})} \rho_F |\mathbf{u}(\mathbf{q}, \boldsymbol{\phi}, \dot{\mathbf{q}}, \dot{\boldsymbol{\phi}}, \mathbf{x})|^2 \, \mathrm{d}\mathbf{x}.$$
(3.10)

Setting the $6n \times 6n$ symmetric matrix:

$$[K_F^r(\mathbf{q}, \boldsymbol{\phi})] := \int_{\Omega(\mathbf{q}, \boldsymbol{\phi})} \rho_F[D\varphi_r(\mathbf{q}, \boldsymbol{\phi})] [D\varphi_r(\mathbf{q}, \boldsymbol{\phi})]^T \, \mathrm{d}\mathbf{x}, \tag{3.11a}$$

the scalar:

$$K_F^d(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}) := \int_{\Omega(\mathbf{q}, \boldsymbol{\phi})} \rho_F \nabla \varphi_d(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}) \cdot (\nabla \varphi_d(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}))^T \, \mathrm{d}\mathbf{x},$$
(3.11b)

and the 6n-length column vector:

$$\mathbf{K}_{F}^{r,d}(\mathbf{q},\boldsymbol{\phi},\dot{\boldsymbol{\phi}}) := \int_{\Omega(\mathbf{q},\boldsymbol{\phi})} \rho_{F}[D\boldsymbol{\varphi}_{r}(\mathbf{q},\boldsymbol{\phi})] (\nabla \varphi_{d}(\mathbf{q},\boldsymbol{\phi},\dot{\boldsymbol{\phi}}))^{T} \, \mathrm{d}\mathbf{x}, \qquad (3.11c)$$

we rewrite (3.10):

$$\mathcal{K}_F = \frac{1}{2} \dot{\mathbf{q}} \cdot [K_F^r(\mathbf{q}, \phi)] \dot{\mathbf{q}} + \mathbf{K}_F^{r,d}(\mathbf{q}, \phi, \dot{\phi}) \cdot \dot{\mathbf{q}} + \frac{1}{2} K_F^d(\mathbf{q}, \phi, \dot{\phi}, \dot{\phi}).$$

Remark the both quantities $K_F^d(\mathbf{q}, \phi, \dot{\phi})$ and $\mathbf{K}_F^{r,d}(\mathbf{q}, \phi, \dot{\phi}, \dot{\phi})$ are linear with respect to each entry $\dot{\phi}$. Let now g be the gravitational constant and $G(\mathbf{x}) := -gx_3$. By virtue of Archimede's principle, the buoyant force on the *i*-th body is:

$$\mathbf{F}_{b}^{i}(\mathbf{q}^{i},\boldsymbol{\phi}^{i}) = \int_{S^{i}(\mathbf{q}^{i},\boldsymbol{\phi}^{i})} (\rho_{S}(\mathbf{x}) - \rho_{F}) \nabla G(\mathbf{x}) \, \mathrm{d}\mathbf{x},$$

and the associated potential energy of the system reads:

$$\mathcal{P}(\mathbf{q}, \boldsymbol{\phi}) = -\int_{S(\mathbf{q}, \boldsymbol{\phi})} (\rho_S(\mathbf{x}) - \rho_F) G(\mathbf{x}) \, \mathrm{d}\mathbf{x}.$$
(3.12)

Finally the Lagrangian of the system fluid-bodies is:

$$\mathcal{L}(\mathbf{q}, \boldsymbol{\phi}, \dot{\mathbf{q}}, \dot{\boldsymbol{\phi}}) = \frac{1}{2} \dot{\mathbf{q}} \cdot \left([K_S^r(\mathbf{q}, \boldsymbol{\phi})] + [K_F^r(\mathbf{q}, \boldsymbol{\phi})] \right) \dot{\mathbf{q}} + \mathbf{K}_F^{r,d}(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}) \cdot \dot{\mathbf{q}} + \frac{1}{2} K_S^d(\dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}) + \frac{1}{2} K_F^d(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}) - \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}). \quad (3.13)$$

In order to study the regularity with respect to $(\mathbf{q}, \boldsymbol{\phi})$ of the quantities (3.11), we apply results of shape sensitivity analysis.

4 Shape sensitivity analysis

This section is self-contained and address an abstract shape optimization problem.

4.1 The context

Let \mathbb{B} be a large ball in \mathbb{R}^3 centered at the origin and Ω be an open connected set in \mathbb{R}^3 which may be bounded or not. We assume that $\partial\Omega = \Gamma_1 \cup \Gamma_2$ such that $\Gamma_1 \cap \Gamma_2 = \emptyset$, $\Gamma_2 \subset \mathbb{B}$ is compact and Γ_1 is either a hyperplane, either bounded, either the empty set. Any $\phi := (\phi_1, \phi_2, \phi_3)^T \in C_c^m(\mathbb{B}, \mathbb{R}^3)$, $(m \ge 1)$ can be extended by $\mathbf{0}_3$ in $\mathbb{R}^3 \setminus \mathbb{B}$. The resulting function is still denoted ϕ and we set $\Phi := [\mathbb{I}_3] + \phi$. In all the sequel, we assume that $\|\phi\|_{1,\infty} < 1$ so that the function Φ is a C^m -diffeomorphism from \mathbb{R}^3 onto \mathbb{R}^3 . We assume also that supp $\phi \cap \Gamma_1 = \emptyset$ and we denote $\Omega(\phi) := \Phi(\Omega)$ and $\Gamma_2(\phi) := \Phi(\Gamma_2)$. Let E be a Banach space endowed with the norm $\|\cdot\|_E$. We consider for any two given functions $(\mathbf{x}, \psi) \in \Gamma_2(\phi) \times E \mapsto b_i(\phi, \psi, \mathbf{x}) \in \mathbb{R}$, i = 1, 2the functions $u_1(\phi, \psi, \cdot)$ and $u_2(\phi, \psi, \cdot)$ that solve the following Neumann boundary value problem:

$$-\Delta u_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \cdot) = 0 \text{ in } \Omega(\boldsymbol{\phi}), \qquad (4.1a)$$

$$\partial_{\mathbf{n}} u_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \cdot) = 0 \text{ on } \Gamma_1, \quad \partial_{\mathbf{n}} u_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \cdot) = b_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \cdot) \text{ on } \Gamma_2(\boldsymbol{\phi}), \tag{4.1b}$$

for i = 1, 2, the vector **n** being the unitary normal to $\partial \Omega(\phi)$ directed toward the exterior of $\Omega(\phi)$. If Ω is bounded, we assume furthermore that the compatibility conditions:

$$\int_{\Gamma_2(\boldsymbol{\phi})} b_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \mathbf{x}) \, \mathrm{d}\Gamma_x = 0, \quad i = 1, 2,$$

are satisfied. These conditions are not needed any longer when Ω is not bounded, as it is explained in [7]. The aim of this section is to study the regularity with respect to (ϕ, ψ) in a neighborhood of $\{[\mathbb{O}_3]\} \times E \subset C_c^m(\mathbb{B}, \mathbb{R}^3) \times E$ of the functional:

$$J(\boldsymbol{\phi}, \boldsymbol{\psi}) = \int_{\Omega(\boldsymbol{\phi})} \nabla u_1(\boldsymbol{\phi}, \boldsymbol{\psi}, \mathbf{x}) \cdot \nabla u_2(\boldsymbol{\phi}, \boldsymbol{\psi}, \mathbf{x}) \, \mathrm{d}\mathbf{x}.$$

4.2 Some function spaces

In order to study the existence and uniqueness of solutions for the Neumann boundary value problem (4.1), we introduce the following weighted or quotient Lebesgue and Sobolev spaces. We denote $\mathcal{D}'(\Omega(\phi))$ the distribution space and $L^2(\Omega(\phi))$, $H^1(\Omega(\phi)), H^2(\Omega(\phi))$ and $H^{1/2}(\Gamma_2(\phi))$ stand for the classical Lebesgue and Sobolev spaces.

The case Ω bounded

We define the quotient spaces:

- $L^2_N(\Omega(\phi)) := L^2(\Omega(\phi))/\mathbb{R}$. The quotient means that we identify two functions which differ from an additive constant. This space is endowed with the scalar product $(u, v)_{L^2_N} := \int_{\Omega(\phi)} uv \, \mathrm{d}\mathbf{x} \left(\int_{\Omega(\phi)} u \, \mathrm{d}\mathbf{x}\right) \left(\int_{\Omega(\phi)} v \, \mathrm{d}\mathbf{x}\right).$
- $H^1_N(\Omega(\phi)) := H^1(\Omega(\phi))/\mathbb{R}$ endowed with the scalar product $(u, v)_{H^1_N} := \int_{\Omega(\phi)} \nabla u \cdot \nabla v \, \mathrm{d}\mathbf{x}.$
- $H^2_N(\Omega(\phi)) := H^2(\Omega(\phi))/\mathbb{R}$ endowed with the scalar product $(u, v)_{H^2_N} := (u, v)_{H^1_N} + \int_{\Omega(\phi)} D^2 u : D^2 v \, \mathrm{d}\mathbf{x}$, where $D^2 u$ and $D^2 v$ are the Hessian matrices of u and v.

Assuming that Γ_2 is Lipschitz continuous (and then also $\Gamma_2(\phi)$ since ϕ is at least continuously differentiable), we define:

$$L_N^2(\Gamma_2(\boldsymbol{\phi})) := \Big\{ u \in L^2(\Gamma_2(\boldsymbol{\phi})) : \int_{\Gamma_2(\boldsymbol{\phi})} u(\mathbf{x}) \, \mathrm{d}\Gamma_x = 0 \Big\},$$

and if Γ_2 is of class $C^{1,1}$ and ϕ twice continuously differentiable, $H_N^{1/2}(\Gamma_2(\phi)) := H^{1/2}(\Gamma_2(\phi)) \cap L_N^2(\Gamma_2(\phi)).$

The case Ω not bounded

The definitions of the functions spaces turn into:

- $L^2_N(\Omega(\phi)) := \{ u \in \mathcal{D}'(\Omega(\phi)) : \sqrt{1 + |\mathbf{x}|^2} u \in L^2(\Omega(\phi)) \}$ endowed with the scalar product $(u, v)_{L^2_N} := \int_{\Omega(\phi)} u v (1 + |\mathbf{x}|^2) d\mathbf{x}.$
- $H_N^1(\Omega(\phi)) := \{ u \in \mathcal{D}'(\Omega(\phi)) : u/\sqrt{1+|\mathbf{x}|^2} \in L^2(\Omega(\phi)), \ \partial_{x_i} u \in L^2(\Omega(\phi)), \ i = 1, 2, 3 \}$ endowed with the scalar product $(u, v)_{H_N^1} := \int_{\Omega(\phi)} u v/(1+|\mathbf{x}|^2) \ \mathrm{d}\mathbf{x} + \int_{\Omega(\phi)} \nabla u \cdot \nabla v \ \mathrm{d}\mathbf{x}.$
- $H_N^2(\Omega(\phi)) := \{ u \in H_N^1(\Omega(\phi)) : \sqrt{1 + |\mathbf{x}|^2} \partial_{x_i x_j}^2 u \in L_N^2(\Omega(\phi)), i, j = 1, 2, 3 \}$ endowed with the scalar product $(u, v)_{H_N^2} := (u, v)_{H_N^1} + \int_{\Omega(\phi)} D^2 u : D^2 v (1 + |\mathbf{x}|^2) \, \mathrm{d}\mathbf{x}.$

Assuming that Γ_2 is Lipschitz continuous, we set $L^2_N(\Gamma_2(\phi)) := L^2(\Gamma_2(\phi))$ and if Γ_2 is of class $C^{1,1}$ and ϕ twice continuously differentiable, $H^{1/2}_N(\Gamma_2(\phi)) := H^{1/2}(\Gamma_2(\phi))$.

4.3 Regularity results

Proposition 4.1 (Existence and uniqueness) Assume that $\partial\Omega$ is Lipschitz continuous. Then for any $(\phi, \psi) \in C_c^1(\mathbb{B}, \mathbb{R}^3) \times E$ and for any $b_i(\phi, \psi) \in L_N^2(\Gamma_2(\phi))$, the system (4.1) admits a unique weak solution $u_i(\phi, \psi) \in H_N^1(\Omega(\phi))$ defined by:

$$\int_{\Omega(\phi)} \nabla u_i(\phi, \psi, \mathbf{x}) \cdot \nabla \varphi(\mathbf{x}) \, \mathrm{d}\mathbf{x} = \int_{\Gamma_2(\phi)} b_i(\phi, \psi, \mathbf{x}) \varphi(\mathbf{x}) \, \mathrm{d}\Gamma_x, \quad \forall \varphi \in H^1_N(\Omega(\phi)).$$
(4.2)

Moreover, there exists a constant $C_1(\Omega(\boldsymbol{\phi})) > 0$ such that

$$\|u_i(\boldsymbol{\phi},\boldsymbol{\psi})\|_{H^1_N} \leq C_1(\Omega(\boldsymbol{\phi}))\|b_i(\boldsymbol{\phi},\boldsymbol{\psi})\|_{L^2_N}.$$

If $\partial\Omega$ is of class $C^{1,1}$, $\phi \in C_c^2(\mathbb{B}, \mathbb{R}^3)$ and $b_i(\phi, \psi) \in H_N^{1/2}(\Gamma_2(\phi))$, the solution $u_i(\phi, \psi)$ is in $H_N^2(\Omega(\phi))$ and there exists a constant $C_2(\Omega(\phi)) > 0$ such that

$$\|u_i(\phi, \psi)\|_{H^2_N} \le C_2(\Omega(\phi)) \|b_i(\phi, \psi)\|_{H^{1/2}_N}.$$

These results are classical when Ω is bounded. For the others cases and the use of weighted Sobolev spaces, we refer to [2], [1] and [7].

From now on, we will denote $U_i(\phi, \psi, \cdot) := u_i(\phi, \psi, \Phi(\cdot)), B_i(\phi, \psi, \cdot) := b_i(\phi, \psi, \Phi(\cdot))$ and $\mathcal{B}_i(\phi, \psi, \cdot) := B_i(\phi, \psi, \cdot) \operatorname{Jac}_{\Gamma}(\phi), \operatorname{Jac}_{\Gamma}(\phi)$ being the tangential Jacobian defined by $\operatorname{Jac}_{\Gamma}(\phi) := |[D\Phi]^{-1\top}\mathbf{n}|| \det[D\Phi]|$. Notice that if $\partial\Omega$ is Lipschitz continuous, $\phi \in C_c^1(\mathbb{B}, \mathbb{R}^3)$ and $b_i(\phi, \psi) \in L_N^2(\Gamma_2(\phi))$ then $B_i(\phi, \psi) \in L^2(\Gamma_2)$ and $\mathcal{B}_i(\phi, \psi) \in L_N^2(\Gamma_2)$ (since $\operatorname{Jac}_{\Gamma}(\phi) \in L^\infty(\Gamma_2)$) and:

$$\int_{\Gamma_2(\phi)} b_i(\phi, \psi, \mathbf{x}) \, \mathrm{d}\Gamma_x = \int_{\Gamma_2} \mathcal{B}_i(\phi, \psi, \mathbf{x}) \, \mathrm{d}\Gamma_x.$$

In the same way, if $\partial\Omega$ is of class $C^{1,1}$, $\phi \in C_c^2(\mathbb{B}, \mathbb{R}^3)$ and $b_i(\phi, \psi) \in H_N^{1/2}(\Gamma_2(\phi))$ then $B_i(\phi, \psi) \in H^{1/2}(\Gamma_2)$ and $\mathcal{B}_i(\phi, \psi) \in H_N^{1/2}(\Gamma_2)$. **Proposition 4.2 (Regularity of the solutions)** Assume that $\partial\Omega$ is Lipschitz continuous and that the given mapping $(\phi, \psi) \in C_c^1(\mathbb{B}, \mathbb{R}^3) \times E \mapsto B_i(\phi, \psi) \in L^2(\Gamma_2)$ is of class C^k $(1 \le k \le \infty)$ (respectively analytic) and satisfies $b_i(\phi, \psi) \in L_N^2(\Gamma_2(\phi))$ for all $(\phi, \psi) \in C_c^1(\mathbb{B}, \mathbb{R}^3) \times E$. Then both mappings:

$$(\boldsymbol{\phi}, \boldsymbol{\psi}) \in C_c^1(\mathbb{B}, \mathbb{R}^3) \times E \mapsto U_i(\boldsymbol{\phi}, \boldsymbol{\psi}) \in H_N^1(\Omega), (\boldsymbol{\phi}, \boldsymbol{\psi}) \in C_c^1(\mathbb{B}, \mathbb{R}^3) \times E \mapsto J(\boldsymbol{\phi}, \boldsymbol{\psi}) \in \mathbb{R},$$

are well defined and also of class C^k (respectively analytic) in a neighborhood of $\{[\mathbb{O}_3]\} \times E \in C^1_c(\mathbb{B}, \mathbb{R}^3) \times E$.

If $\partial\Omega$ is of class $C^{1,1}$ and the mapping $(\phi, \psi) \in C_c^2(\mathbb{B}, \mathbb{R}^3) \times E \mapsto B_i(\phi, \psi) \in H^{1/2}(\Gamma_2)$ is of class C^1 and satisfies $b_i(\phi, \psi) \in H^{1/2}_N(\Gamma_2(\phi))$ for all $(\phi, \psi) \in C_c^2(\mathbb{B}, \mathbb{R}^3) \times E$, then the mapping:

$$(\boldsymbol{\phi}, \boldsymbol{\psi}) \in C_c^2(\mathbb{B}, \mathbb{R}^3) \times E \mapsto U_k(\boldsymbol{\phi}, \boldsymbol{\psi}) \in H_N^2(\Omega),$$

is well defined and also of class C^1 in a neighborhood of $\{[\mathbb{O}_3]\} \times E \subset C_c^2(\mathbb{B}, \mathbb{R}^3) \times E$. Furthermore, for all compact set $K \in \Omega$ we have $K \subset \Omega(\phi)$ whenever $\|\phi\|_{1,\infty}$ remains small enough and the mappings:

$$\begin{aligned} (\boldsymbol{\phi}, \boldsymbol{\psi}) &\in C_c^1(\mathbb{B}, \mathbb{R}^3) \times E \mapsto u_i(\boldsymbol{\phi}, \boldsymbol{\psi})|_K \in L^2(K), \\ (\boldsymbol{\phi}, \boldsymbol{\psi}) &\in C_c^2(\mathbb{B}, \mathbb{R}^3) \times E \mapsto \partial_{x_j} u_i(\boldsymbol{\phi}, \boldsymbol{\psi})|_K \in L^2(K), \quad i = 1, 2, \quad j = 1, 2, 3, \end{aligned}$$

are well defined and of class C^1 in a neighborhood of $\{[\mathbb{O}_3]\} \times E$. Moreover, we have the following regularity for the partial derivatives:

$$\langle \partial_{\boldsymbol{\phi}} u_i([\mathbb{O}_3], \boldsymbol{\psi}, \cdot), \boldsymbol{\xi} \rangle \in H^1_N(\Omega), \quad \forall \, \boldsymbol{\psi} \in E, \; \forall \, \boldsymbol{\xi} \in C^1_c(\mathbb{B}, \mathbb{R}^3), \\ \langle \partial_{\boldsymbol{\phi}} \left(\partial_{x_j} u_i \right) ([\mathbb{O}_3], \boldsymbol{\psi}, \cdot), \boldsymbol{\xi} \rangle \in L^2(\Omega), \quad \forall \, \boldsymbol{\psi} \in E, \; \forall \, \boldsymbol{\xi} \in C^2_c(\mathbb{B}, \mathbb{R}^3), \; j = 1, 2, 3.$$

For any given C^1 -functions $t \in \mathbb{R} \mapsto \psi(t) \in E$ and $t \in \mathbb{R} \mapsto \phi(t, \cdot) \in C_c^2(\mathbb{B}, \mathbb{R}^3)$ such that $\phi(0, \cdot) = [\mathbb{O}_3]$ and $\|\phi(t)\|_{1,\infty} < 1$ for all $t \in \mathbb{R}$, we denote $\Phi(t) := [\mathbb{I}_3] + \phi(t), \Omega(t) := \Phi(t, \Omega), u_i(t) := u_i(\phi(t), \psi(t)), b_i(t) := b_i(\phi(t), \psi(t)), B_i(t) := B_i(\phi(t), \psi(t))$ for i = 1, 2 and

$$J(t) := \int_{\Omega(t)} \nabla u_1(t) \cdot \nabla u_2(t) \, \mathrm{d}\mathbf{x}$$

We can compute the expression of $\partial_t J(t)$:

Proposition 4.3 Assume that $\partial\Omega$ is of class $C^{1,1}$ and $t \mapsto B_i(t) \in H^{1/2}(\Gamma_2)$ is of class C^1 . Then, denoting $\mathbf{v}(t, \mathbf{x}) := \partial_t \phi(t, \Phi^{-1}(t, \mathbf{x}))$ for all $\mathbf{x} \in \mathbb{B}$ and $\mathbf{v}_{\Gamma}(t, \mathbf{x}) := \mathbf{v}(t, \mathbf{x}) - (\mathbf{v}(t, \mathbf{x}) \cdot \mathbf{n})\mathbf{n}$ for all $\mathbf{x} \in \Gamma_2(t)$, we have:

$$\partial_{t}J(t) = -\int_{\Gamma_{2}(t)} \nabla u_{1}(t) \cdot \nabla u_{2}(t)(\mathbf{v}(t) \cdot \mathbf{n}) \, \mathrm{d}\Gamma_{x} + \int_{\Gamma_{2}(t)} \left(\partial_{t}B_{1}(\boldsymbol{\Phi}^{-1}(t)) - \nabla_{\Gamma}b_{1}(t) \cdot \mathbf{v}_{\Gamma}(t)\right) u_{2}(t) \, \mathrm{d}\Gamma_{x} + \int_{\Gamma_{2}(t)} \left(\partial_{t}B_{2}(\boldsymbol{\Phi}^{-1}(t)) - \nabla_{\Gamma}b_{2}(t) \cdot \mathbf{v}_{\Gamma}(t)\right) u_{1}(t) \, \mathrm{d}\Gamma_{x} + 2\int_{\Gamma_{2}(t)} b_{1}(t)b_{2}(t)(\mathbf{v}(t) \cdot \mathbf{n}) \, \mathrm{d}\Gamma_{x} - 2\int_{\Gamma_{2}(t)} \mathcal{H}(t) \left(b_{1}(t)u_{2}(t) + b_{2}(t)u_{1}(t)\right) (\mathbf{v}(t) \cdot \mathbf{n}) \, \mathrm{d}\Gamma_{x}, \quad (4.3)$$

where ∇_{Γ} is the tangential gradient, $\kappa_1(t, \mathbf{x})$ and $\kappa_2(t, \mathbf{x})$ stand for the principal curvatures of the surface $\Gamma_2(t)$ at the point \mathbf{x} and $\mathcal{H}(t, \mathbf{x}) = (\kappa_1(t, \mathbf{x}) + \kappa_2(t, \mathbf{x}))/2$ is the mean curvature.

The proofs of Propositions 4.2 and 4.3 are deeply inspired by that of [18, Theorem 5.5.1 page 203]. Nevertheless, due to notable modifications, we write it thoroughly in the Appendix, Section A.5.

Existence, uniqueness and regularity of the swim- $\mathbf{5}$ mers trajectories

This section is devoted to the proofs of Theorem 2.1 and Corollary 2.1. The notations are those of Section 3.

The problem in local coordinates 5.1

We assume in all this subsection that the assumptions of Theorem 2.1 are satisfied,

namely $\partial\Omega$ is Lipschitz continuous and m = 1 in (2.8). It is clear that $(\mathbf{q}, \boldsymbol{\phi}) \in \mathfrak{Q}_{ad}^{n,1} \mapsto [K_S^r(\mathbf{q}, \boldsymbol{\phi})] \in \mathcal{M}(6n)$ defined by (3.7) is analytic. In the same way, $(\boldsymbol{\psi}_1, \boldsymbol{\psi}_2) \in C_c^1(\mathbb{B}, \mathbb{R}^3)^2 \mapsto K_S^d(\boldsymbol{\psi}_1, \boldsymbol{\psi}_2) \in \mathbb{R}$ defined by (3.8) is bilinear, continuous and hence analytic.

To study the regularity of $(\mathbf{q}, \phi) \in \mathfrak{Q}_{ad}^{n,1} \mapsto \mathcal{P}(\mathbf{q}, \phi) \in \mathbb{R}$, we rewrite it as follows:

$$\mathcal{P}(\mathbf{q}, \boldsymbol{\phi}) = -\int_{S_0} \rho_S^0 G(\boldsymbol{\Lambda}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x})) \, \mathrm{d}\mathbf{x} + \int_{S_0} \rho_F G(\boldsymbol{\Lambda}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x})) \, \mathrm{d}\mathbf{t} \left| \left[D\boldsymbol{\Lambda}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x}) \right] \right| \, \mathrm{d}\mathbf{x},$$

in which $\Lambda(\mathbf{q}, \boldsymbol{\phi})$ is given in (3.2). Since we have:

$$\begin{split} \int_{S_0} \rho_F G(\mathbf{\Lambda}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x})) \det |[D\mathbf{\Lambda}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x})]| \, \mathrm{d}\mathbf{x} = \\ \sum_{i=1}^n \int_{S_0^i} \rho_F G(\mathbf{\Lambda}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x})) \det |[D\mathbf{\Phi}^i(\mathbf{x} - \mathbf{h}_0^i)]| \, \mathrm{d}\mathbf{x}, \end{split}$$

we conclude that $(\mathbf{q}, \phi) \in \mathfrak{Q}_{ad}^{n,1} \mapsto \mathcal{P}(\mathbf{q}, \phi) \in \mathbb{R}$ is analytic. The Stokes formula yields, for all $(\mathbf{q}, \phi) \in \mathfrak{Q}_{ad}^{n,1}$ and all $i = 1, \ldots, n$:

$$\int_{\Gamma_2(\mathbf{q},\boldsymbol{\phi})} \mathbf{v}_r^{i,k}(\mathbf{q},\boldsymbol{\phi}) \cdot \mathbf{n} \, \mathrm{d}\mathbf{x} = \int_{S^i(\mathbf{q},\boldsymbol{\phi})} \mathrm{div}(\mathbf{v}_r^{i,k}(\mathbf{q},\boldsymbol{\phi})) \, \mathrm{d}\mathbf{x} = 0, \quad \forall \, k = 1, \dots, 6,$$

the vector field $\mathbf{v}_r^{i,k}(\mathbf{q}, \boldsymbol{\phi})$ being defined by (3.4). The hypothesis (2.7) ensures that, for all $(\mathbf{q}, \boldsymbol{\phi}, \dot{\mathbf{q}}, \dot{\boldsymbol{\phi}}) \in T\mathfrak{Q}_{ad}^{n,1}$ and all $i = 1, \ldots, n$:

$$\sum_{i=1}^n \int_{\Gamma_2(\mathbf{q},\boldsymbol{\phi})} \mathbf{v}_d^i(\mathbf{q},\boldsymbol{\phi},\dot{\boldsymbol{\phi}}) \cdot \mathbf{n} = 0,$$

where $\mathbf{v}_d^i(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}})$ is given in (3.3). Hence Proposition 4.1 applies to the functions $\varphi_r^{i,k}$ and φ_d defined by (3.9). We deduce that $[K_F^r(\mathbf{q},\phi)]$, $K_F^d(\mathbf{q},\phi,\phi,\phi)$ and $\mathbf{K}_F^{r,d}(\mathbf{q},\phi,\phi,\phi)$ given in (3.11) are well defined for all $(\mathbf{q},\phi,\dot{\mathbf{q}},\phi) \in T\mathfrak{Q}_{ad}^{n,1}$. We address now the sensitivity of $K_F^d(\mathbf{q},\phi,\phi,\phi)$ and $\mathbf{K}_F^{r,d}(\mathbf{q},\phi,\phi,\phi)$ with respect to $(\mathbf{q},\phi,\dot{\mathbf{q}},\phi)$. To fit with the notations of Proposition 4.2, we define:

$$b_r^{i,k}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x}) := \mathbf{v}_r^{i,k}(\mathbf{q}, \boldsymbol{\phi}, \mathbf{x}) \cdot \mathbf{n}(\mathbf{x}), \quad \mathbf{x} \in \Gamma_2(\mathbf{q}, \boldsymbol{\phi}), \ \forall \ k = 1, \dots, 6,$$

$$b_d^i(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \mathbf{x}) := \mathbf{v}_d^i(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \mathbf{x}) \cdot \mathbf{n}(\mathbf{x}), \quad \mathbf{x} \in \Gamma_2(\mathbf{q}, \boldsymbol{\phi}), \ \forall \ i = 1, \dots, n,$$

and $B_r^{i,k}(\mathbf{q}, \phi, \mathbf{x}) := b_r^{i,k}(\mathbf{q}, \phi, \mathbf{\Lambda}(\mathbf{q}, \phi, \mathbf{x}))$ and $B_d^i(\mathbf{q}, \phi, \dot{\phi}, \mathbf{x}) := b_d^i(\mathbf{q}, \phi, \dot{\phi}, \mathbf{\Lambda}(\mathbf{q}, \phi, \mathbf{x}))$ for all $\mathbf{x} \in \Gamma_2$. We easily obtain that, for all $\mathbf{x} \in \Gamma_2(\mathbf{q}, \phi)$ and all $i = 1, \ldots, n$:

$$\begin{split} B_r^{i,k}(\mathbf{q},\boldsymbol{\phi},\mathbf{x}) = \\ \begin{cases} \left\{ \begin{aligned} & \left(\mathcal{R}(\boldsymbol{\alpha}^i)^T\boldsymbol{\omega}^i\right) \wedge \boldsymbol{\Phi}^i(\mathbf{x} - \mathbf{h}_0^i) \cdot \mathbf{n}(\boldsymbol{\Phi}(\mathbf{x} - \mathbf{h}_0^i)) & \text{if } k = 1, 2, 3, \\ & \mathcal{R}(\boldsymbol{\alpha}^i)^T \mathbf{e}_{k-3} \cdot \mathbf{n}(\boldsymbol{\Phi}(\mathbf{x} - \mathbf{h}_0^i)) & \text{if } k = 4, 5, 6, \\ & 0 & \text{otherwise,} \end{aligned} \right. \end{split}$$

and

$$B_d^i(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \mathbf{x}) = \begin{cases} \dot{\boldsymbol{\phi}}(\mathbf{x} - \mathbf{h}_0^i) \cdot \mathbf{n}(\boldsymbol{\Phi}^i(\mathbf{x} - \mathbf{h}_0^i)) & \text{if } \mathbf{x} \in \Gamma_2^i, \\ 0 & \text{otherwise.} \end{cases}$$

At this point we need the following proposition whose proof in given in Section A.5:

Proposition 5.1 Let Γ be a Lipschitz continuous surface in \mathbb{R}^3 and denote:

$$C_{inv}^{m,\infty}(\mathbb{R}^3,\mathbb{R}^3) := \{ \Phi \in C^{m,\infty}(\mathbb{R}^3,\mathbb{R}^3) : \| \Phi - [\mathbb{I}_3] \|_{1,\infty} < 1 \}, \quad (0 \le m \le \infty),$$

(see Section A.2). Then:

- It is possible to define x-almost everywhere on Γ a unitary normal vector n(x).

The normal vector $\mathbf{n}(\mathbf{x})$ being given $\mathbf{x}-a$. e. on Γ , for all $\mathbf{\Phi} \in C_{inv}^{1,\infty}(\mathbb{R}^3, \mathbb{R}^3)$ such that $\|\mathbf{\Phi} - [\mathbb{I}_3]\|_{1,\infty} < 1$, it is possible to define $\mathbf{x}-almost$ everywhere on $\mathbf{\Phi}(\Gamma)$ a unitary normal vector $\mathbf{n}(\mathbf{\Phi}, \mathbf{x})$ such that $\mathbf{n}([\mathbb{I}_3], \mathbf{x}) = \mathbf{n}(\mathbf{x})$ for almost every $\mathbf{x} \in \Gamma$ and such that the mapping:

$$\langle \partial_{\mathbf{\Phi}} \mathbf{N}(\mathbf{\Phi}, \mathbf{\Phi}^{-1}), \boldsymbol{\xi} \rangle = -\sum_{i=1}^{2} \mathbf{n}(\mathbf{\Phi}) \cdot [D(\boldsymbol{\xi} \circ \mathbf{\Phi}^{-1})] \boldsymbol{\tau}_{i}(\mathbf{\Phi}), \quad \forall \boldsymbol{\xi} \in C^{1, \infty}(\mathbb{R}^{3}, \mathbb{R}^{3}).$$
(5.1)

Let us consider a given C^k -function, $1 \le k \le \infty$ (respectively analytic):

$$t \in [0,\infty) \mapsto \mathbf{\Phi}(t) \in C^{1,\infty}_{inv}(\mathbb{R}^3,\mathbb{R}^3).$$

such that $\mathbf{\Phi}(0) = [\mathbb{I}_3]$ and denote $\mathbf{n}(t) := \mathbf{n}(\mathbf{\Phi}(t)), \ \boldsymbol{\tau}_k(t) = \boldsymbol{\tau}_k(\mathbf{\Phi}(t)), \ \mathbf{N}(t) := \mathbf{N}(\mathbf{\Phi}(t)), \ \mathbf{v}(t, \mathbf{x}) := \partial_t \mathbf{\Phi}(t, \mathbf{\Phi}^{-1}(t, \mathbf{x})) \text{ and } \mathbf{v}_{\Gamma}(\mathbf{x}, t) := \mathbf{v}(t, \mathbf{x}) - (\mathbf{v}(t, \mathbf{x}) \cdot \mathbf{n}(t, \mathbf{x}))\mathbf{n}(t, \mathbf{x})$ (the tangential part of $\mathbf{v}(t, \mathbf{x})$). Then, the identity (5.1) reads:

almost everywhere on $\mathbf{\Phi}(t, \Gamma)$.

Assume now that Γ is $C^{1,1}$ and $\mathbf{\Phi} \in C^{2,\infty}_{inv}(\mathbb{R}^3,\mathbb{R}^3)$. At any point \mathbf{x} of $\mathbf{\Phi}(t,\Gamma)$, $\Pi_2(t,\mathbf{x})$ stands for the second fundamental form. Then the mapping: $t \in [0,\infty) \mapsto$

 $\mathbf{N}(t) \in L^{\infty}(\Gamma)$ is of class C^k (respectively analytic) in a neighborhood of t = 0 and for all $\mathbf{x} \in \mathbf{\Phi}(t, \Gamma)$:

$$\partial_t \mathbf{N}(t, \mathbf{\Phi}^{-1}(t, \mathbf{x})) = -\nabla_{\Gamma}(\mathbf{v}(t, \mathbf{x}) \cdot \mathbf{n}(t, \mathbf{x})) - \langle \Pi_2(t, \mathbf{x}), \mathbf{v}_{\Gamma}(t, \mathbf{x}), \mathbf{v}_{\Gamma}(t, \mathbf{x}) \rangle, \quad (5.3)$$

where ∇_{Γ} is the tangential gradient. Introducing also $\kappa_1(t, \mathbf{x})$ and $\kappa_2(t, \mathbf{x})$ the principal curvatures of $\mathbf{\Phi}(t, \Gamma_2)$ at the point \mathbf{x} and choosing for $\boldsymbol{\tau}_1(t, \mathbf{x}), \boldsymbol{\tau}_2(t, \mathbf{x})$ the associated principal directions such that $\langle \Pi_2(t, \mathbf{x}), \boldsymbol{\tau}_i(t, \mathbf{x}), \boldsymbol{\tau}_i(t, \mathbf{x}) \rangle = -([D\mathbf{n}(t, \mathbf{x})]\boldsymbol{\tau}_i(t, \mathbf{x})) \cdot$ $\boldsymbol{\tau}_i(t, \mathbf{x}) = \kappa_i(t, \mathbf{x}), i = 1, 2$, we also have:

$$\langle \Pi_2(t,\mathbf{x}), \mathbf{v}_{\Gamma}(t,\mathbf{x}), \mathbf{v}_{\Gamma}(t,\mathbf{x}) \rangle = \sum_{i=1}^2 \kappa_i(t,\mathbf{x}) (\mathbf{v}(t,\mathbf{x}) \cdot \boldsymbol{\tau}_i(t,\mathbf{x})) \boldsymbol{\tau}_i(t,\mathbf{x}).$$

Using this proposition, we deduce that the functions $(\mathbf{q}, \phi) \in \mathfrak{Q}_{ad}^{n,1} \mapsto B_r^{i,k}(\mathbf{q}, \phi) \in L^2(\Gamma_2)$ and $(\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi}) \in T\mathfrak{Q}_{ad}^{n,1} \mapsto B_d^i(\mathbf{q}, \phi, \dot{\phi}) \in L^2(\Gamma_2)$ are analytic. We conclude, applying Proposition 4.2, that all the quantities defined by (3.11) have the same regularity and hence that \mathcal{L} is analytic.

Computing each term of (2.10) from the expression (3.13), we obtain that (2.10) reads:

$$\begin{split} \langle [K_{S}^{r}(\mathbf{q},\boldsymbol{\phi})] + [K_{F}^{r}(\mathbf{q},\boldsymbol{\phi})], \dot{\mathbf{q}}, \dot{\mathbf{\gamma}} \rangle \\ &+ \langle \partial_{\mathbf{q}} [K_{S}^{r}(\mathbf{q},\boldsymbol{\phi})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \dot{\mathbf{\gamma}} \rangle - \frac{1}{2} \langle \partial_{\mathbf{q}} [K_{S}^{r}(\mathbf{q},\boldsymbol{\phi})], \cdot, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle \\ &+ \langle \partial_{\mathbf{q}} [K_{F}^{r}(\mathbf{q},\boldsymbol{\phi})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \cdot \rangle - \frac{1}{2} \langle \partial_{\mathbf{q}} [K_{F}^{r}(\mathbf{q},\boldsymbol{\phi})], \cdot, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle \\ &+ \langle \partial_{\boldsymbol{\phi}} [K_{S}^{r}(\mathbf{q},\boldsymbol{\phi})], \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}}, \cdot \rangle + \langle \partial_{\boldsymbol{\phi}} [K_{F}^{r}(\mathbf{q},\boldsymbol{\phi})], \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}}, \cdot \rangle \\ &+ \langle \partial_{\mathbf{q}} \mathbf{K}_{F}^{r,d}(\mathbf{q},\boldsymbol{\phi}), \dot{\mathbf{q}}, \dot{\boldsymbol{\phi}}, \cdot \rangle - \langle \partial_{\mathbf{q}} \mathbf{K}_{F}^{r,d}(\mathbf{q},\boldsymbol{\phi}), \cdot, \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}} \rangle \\ &+ \langle \mathbf{K}_{F}^{r,d}(\mathbf{q},\boldsymbol{\phi}), \ddot{\boldsymbol{\phi}}, \cdot \rangle + \langle \partial_{\boldsymbol{\phi}} \mathbf{K}_{F}^{r,d}(\mathbf{q},\boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}, - \frac{1}{2} \langle \partial_{\mathbf{q}} K_{F}^{d}(\mathbf{q},\boldsymbol{\phi}), \cdot, \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle \\ &+ \langle \partial_{\mathbf{q}} \mathcal{P}(\mathbf{q},\boldsymbol{\phi}), \cdot \rangle = \mathbf{0}_{6n}. \quad (5.4) \end{split}$$

Let us make precise the nature of each term arising in this expression:

- $[K_S^r(\mathbf{q}, \boldsymbol{\phi})] + [K_F^r(\mathbf{q}, \boldsymbol{\phi})]$ is a $6n \times 6n$ symmetric matrix, that is to say an element of $L_2(\mathbb{R}^{6n} \times \mathbb{R}^{6n}, \mathbb{R})$,
- $\partial_{\mathbf{q}}[K_S^r(\mathbf{q}, \boldsymbol{\phi})]$ and $\partial_{\mathbf{q}}[K_F^r(\mathbf{q}, \boldsymbol{\phi})]$ are $6n \times 6n \times 6n$ third-rank tensors, that is to say elements of $L_3(\mathbb{R}^{6n} \times \mathbb{R}^{6n} \times \mathbb{R}^{6n}, \mathbb{R})$,
- $\partial_{\boldsymbol{\phi}}[K_S^r(\mathbf{q},\boldsymbol{\phi})]$ and $\partial_{\boldsymbol{\phi}}[K_F^r(\mathbf{q},\boldsymbol{\phi})]$ lies in $L_3(C_c^1(\mathbb{B},\mathbb{R}^3)^n\times\mathbb{R}^{6n}\times\mathbb{R}^{6n},\mathbb{R}),$
- $\partial_{\mathbf{q}} \mathbf{K}_{F}^{r,d}(\mathbf{q}, \boldsymbol{\phi})$ is an element of $L_{3}(\mathbb{R}^{6n} \times C_{c}^{1}(\mathbb{B}, \mathbb{R}^{3})^{n} \times \mathbb{R}^{6n}, \mathbb{R}),$
- $\mathbf{K}_{F}^{r,d}(\mathbf{q}, \boldsymbol{\phi})$ belongs to $L_{2}(C_{c}^{1}(\mathbb{B}, \mathbb{R}^{3})^{n} \times \mathbb{R}^{6n}, \mathbb{R}),$
- $\partial_{\mathbf{q}} K^d_F(\mathbf{q}, \boldsymbol{\phi})$ is in $L_3(\mathbb{R}^{6n} \times C^1_c(\mathbb{B}, \mathbb{R}^3)^n \times C^1_c(\mathbb{B}, \mathbb{R}^3)^n, \mathbb{R}),$
- $\partial_{\phi} \mathbf{K}_{F}^{r,d}(\mathbf{q}, \phi)$ is in $L_{3}(C_{c}^{1}(\mathbb{B}, \mathbb{R}^{3})^{n} \times C_{c}^{1}(\mathbb{B}, \mathbb{R}^{3})^{n} \times \mathbb{R}^{6n}, \mathbb{R}),$
- $\partial_{\mathbf{q}} \mathcal{P}(\mathbf{q}, \boldsymbol{\phi})$ is a 6n-length column vector, that is an element of $L_1(\mathbb{R}^{6n}, \mathbb{R})$.

The last remaining point to prove before applying the Cauchy-Lipschitz Theorem to the ODE (5.4) is:

Lemma 5.1 For all $(\mathbf{q}, \boldsymbol{\phi}) \in \mathfrak{Q}_{ad}^{n,1}$, let $\lambda^i(\boldsymbol{\phi}^i) > 0$, $i = 1, \ldots, n$ be the smallest eigenvalue of the inertia tensor $[I_0^i(\boldsymbol{\phi}^i)]$ defined by (3.6) and remind that $m^i > 0$ is the mass of the *i*-th body. Then, for all $\dot{\mathbf{q}} \in \mathbb{R}^{6n}$:

$$\dot{\mathbf{q}} \cdot ([K_S^r(\mathbf{q}, \boldsymbol{\phi})] + [K_F^r(\mathbf{q}, \boldsymbol{\phi})])\dot{\mathbf{q}} \ge \min_{1 \le i \le n} \{\lambda^i(\boldsymbol{\phi}^i) \cos^2(\alpha_2^i), m^i \cos^2(\alpha_2^i)\} |\dot{\mathbf{q}}|^2.$$

In particular, the family of symmetric matrices $[K_S^r(\mathbf{q}, \phi)] + [K_F^r(\mathbf{q}, \phi)]$ is uniformly elliptic on $\mathbb{R}^{6n} \times \mathbb{R}^{6n}$ whenever (\mathbf{q}, ϕ) remains in a compact subset of $\mathfrak{Q}_{ad}^{n,1}$.

Proof: Beforehand, notice that since $\dot{\mathbf{q}} \cdot [K_F^r(\mathbf{q}, \boldsymbol{\phi})] \dot{\mathbf{q}} := \int_{\Omega(\mathbf{q}, \boldsymbol{\phi})} |\nabla(\boldsymbol{\varphi}_r \cdot \dot{\mathbf{q}})|^2 \, \mathrm{d}\mathbf{x}$, the matrix $[M_F^r(\mathbf{q}, \boldsymbol{\phi})]$ is positive definite for any $(\mathbf{q}, \boldsymbol{\phi}) \in \mathfrak{Q}_{ad}^{n,1}$. The estimate arises, taking into account the definition (3.7) of $[K_S^r(\mathbf{q}, \boldsymbol{\phi})]$ and remarking that, for all $i = 1, \ldots, n$:

$$\min_{\dot{\mathbf{q}}^i \neq \mathbf{0}_6} \frac{\dot{\mathbf{q}}^i \cdot [\omega^i]^T \mathcal{R}(\boldsymbol{\alpha}^i) [I_0^i(\boldsymbol{\phi}^i)] \mathcal{R}(\boldsymbol{\alpha}^i)^T [\omega^i] \dot{\mathbf{q}}^i}{|\dot{\mathbf{q}}^i|^2} = \min_{\dot{\mathbf{q}}^i \neq \mathbf{0}_6} \frac{\dot{\mathbf{q}}^i \cdot [I_0^i(\boldsymbol{\phi}^i)] \dot{\mathbf{q}}^i}{|[\omega^i]^{-1} \mathcal{R}(\boldsymbol{\alpha}^i) \dot{\mathbf{q}}^i|^2},$$

and that $|[\omega^i]^{-1} \mathcal{R}(\boldsymbol{\alpha}^i) \dot{\mathbf{q}}^i| \leq 1/\cos(\alpha_2^i) |\dot{\mathbf{q}}^i|$.

Let now $t \in [0, \infty) \mapsto \phi(t) \in C_c^1(\mathbb{B}, \mathbb{R}^3)^n$ be a given function satisfying the assumptions of Theorem 2.1 and plug the expression of $\phi(t), \dot{\phi}(t)$ and $\ddot{\phi}(t)$ into the ODE (5.4). Applying the Cauchy-Lipschitz Theorem, we obtain the conclusion of Theorem 2.1. The proof is then complete.

5.2 The problem in global coordinates

In this section, we tackle the proof of Corollary 2.1. Under the assumptions of Theorem 2.1, we denote $[K^r(\mathbf{q}, \boldsymbol{\phi})] := [K^r_S(\mathbf{q}, \boldsymbol{\phi})] + [K^r_F(\mathbf{q}, \boldsymbol{\phi})]$ and, for all $(\mathbf{q}, \boldsymbol{\phi}, \dot{\mathbf{q}}, \dot{\boldsymbol{\phi}}) \in T\mathfrak{Q}^{n,1}_{ad}$:

$$E(\mathbf{q}, \dot{\mathbf{q}}, \boldsymbol{\phi}) := \frac{1}{2} \dot{\mathbf{q}} \cdot [K^r(\mathbf{q}, \boldsymbol{\phi})] \dot{\mathbf{q}}, \tag{5.5a}$$

$$\langle \delta_1(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle := \sup_{\dot{\mathbf{q}} \neq \mathbf{0}_{6n}} - \frac{\langle \partial_{\boldsymbol{\phi}} [K^r(\mathbf{q}, \boldsymbol{\phi})], \boldsymbol{\phi}, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle}{\langle [K^r(\mathbf{q}, \boldsymbol{\phi})], \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle}, \tag{5.5b}$$

$$\delta_{2}(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}) := \sup_{\dot{\mathbf{q}} \neq \mathbf{0}_{6n}} -\sqrt{2} \frac{\langle \mathbf{K}_{F}^{r,d}(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}} \rangle + \langle \partial_{\boldsymbol{\phi}} \mathbf{K}_{F}^{r,d}(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}} \rangle}{\sqrt{\langle [K^{r}(\mathbf{q}, \boldsymbol{\phi})], \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle}}.$$
 (5.5c)

For any C^2 -function $t \in [0, \infty) \mapsto (\mathbf{q}(t), \phi(t)) \in \mathfrak{Q}_{ad}^{n,1}$ such that $(\mathbf{q}(t), \phi(t), \dot{\mathbf{q}}(t), \dot{\phi}(t)) \in \mathbb{T}\mathfrak{Q}_{ad}^{n,1}$ we define:

$$\begin{aligned} a(\mathbf{q}, \phi, \dot{\phi}, \ddot{\phi}, t) &:= \frac{1}{2} \langle K_F^d(\mathbf{q}, \phi), \dot{\phi}, \dot{\phi} \rangle - \mathcal{P}(\mathbf{q}, \phi) \\ &+ e^{\int_0^t \langle \delta_1(\mathbf{q}, \phi), \dot{\phi} \rangle d\tau} \left(-\frac{1}{2} \langle K_F^d(\mathbf{q}_0, \phi_0), \dot{\phi}_0, \dot{\phi}_0 \rangle + \mathcal{P}(\mathbf{q}_0, \phi_0) + E(\mathbf{q}_0, \dot{\mathbf{q}}_0, \phi_0) \right) \\ &+ \int_0^t \langle \delta_1(\mathbf{q}, \phi), \dot{\phi} \rangle \left(\frac{1}{2} \langle K_F^d(\mathbf{q}, \phi), \dot{\phi}, \dot{\phi} \rangle - \mathcal{P}(\mathbf{q}, \phi) \right) e^{\int_s^t \langle \delta_1(\mathbf{q}, \phi), \dot{\phi} \rangle d\tau} \, \mathrm{d}s \\ &+ \int_0^t \left(-\frac{1}{2} \langle \partial_{\phi} K_F^d(\mathbf{q}, \phi), \dot{\phi}, \dot{\phi}, \dot{\phi} \rangle - \langle K_F^d(\mathbf{q}, \phi), \ddot{\phi}, \dot{\phi} \rangle \\ &+ \langle \partial_{\phi} \mathcal{P}(\mathbf{q}, \phi), \dot{\phi} \rangle \right) e^{\int_s^t \langle \delta_1(\mathbf{q}, \phi), \dot{\phi} \rangle d\tau} \, \mathrm{d}s, \quad (5.6a) \end{aligned}$$

and:

$$k(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}, t, s) := e^{\int_{s}^{t} \langle \delta_{1}(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle d\tau} \delta_{2}(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}),$$
(5.6b)

and we set $a^+ =: \max\{a, 0\}, k^+ := \max\{k, 0\}$. According to Lemma 5.1 and regularity results proved earlier, we deduce that the quantities (5.5) are (at least) Lipschitz continuous with respect to $(\mathbf{q}, \phi, \dot{\mathbf{q}}, \dot{\phi}, \ddot{\phi}) \in T\mathfrak{Q}_{ad}^{n,1} \times \mathbb{R}^{6n}$. We draw the same conclusion for the functions $t \in [0, \infty) \mapsto a(\mathbf{q}, \phi, \dot{\phi}, \dot{\phi}, t) \in \mathbb{R}$ and $(s, t) \in [0, \infty)^2 \mapsto k(\mathbf{q}, \phi, \dot{\phi}, \dot{\phi}, t, s) \in \mathbb{R}$ (and then also for a^+ and b^+).

Lemma 5.2 (Energy estimate) Let \mathbf{q}^* be the solution defined on [0,T), arising in Theorem 2.1 and $\boldsymbol{\phi}$ be the corresponding deformation function. Then, for all $t \in [0,T)$, the following estimate holds:

$$E(\mathbf{q}^*, \dot{\mathbf{q}}^*, \boldsymbol{\phi}) \leq a^+(\mathbf{q}^*, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}, t) + \frac{1}{4} \left[2 \left(\int_0^t k^+(\mathbf{q}^*, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}, t, s) \sqrt{a^+(\mathbf{q}^*, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}, t)} \, \mathrm{d}s \right)^{1/2} + \int_0^t k^+(\mathbf{q}^*, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}, t, s) \, \mathrm{d}s \right]^2. \quad (5.7)$$

It means in particular that $E(\mathbf{q}^*, \dot{\mathbf{q}}^*, \boldsymbol{\phi})$ is not able to blow up in finite time whenever $(\mathbf{q}^*, \boldsymbol{\phi})$ remains in a compact subset of $\mathfrak{Q}_{ad}^{n,1}$.

The proof of this technical lemma is given in Section A.5.

Let \mathbf{q}^* be the solution defined on [0, T) given in Theorem 2.1 and denote $\widetilde{T} := \sup\{t \in [0, T) : (\mathbf{q}^*(s), \phi(s)) \in \widetilde{\mathfrak{Q}}_{ad}^{n,1}, \forall s = [0, t]\}$ and $\mathbf{Q}^*(t) := \mathfrak{F}_1(\mathbf{q}^*(t))$ for all $t \in [0, \widetilde{T})$ (see Section A.3 for the definitions of $\widetilde{\mathfrak{Q}}_{ad}^{n,1}$ and \mathfrak{F}_1). Classical behavior results for solutions of ODE's (see for example [13, Theorem 4.1, page 15]) ensure that:

$$\lim_{t\to\widetilde{T}}(t,\mathbf{q}^*(t),\boldsymbol{\phi}(t),\dot{\mathbf{q}}^*(t),\dot{\boldsymbol{\phi}}(t))\in\partial([0,\infty)\times T\widetilde{\mathfrak{Q}}_{ad}^{n,1}).$$

It means that one of the following alternatives happens:

- Either $\widetilde{T} = \infty$,
- Either $(\mathbf{q}^*(\widetilde{T}), \phi(\widetilde{T}), \dot{\mathbf{q}}^*(\widetilde{T}), \dot{\phi}(\widetilde{T})) \in \partial T \widetilde{\mathfrak{Q}}_{ad}^{n,1}$. Only two events are possible:
 - Either $(\mathbf{q}^*(\widetilde{T}), \boldsymbol{\phi}(\widetilde{T})) \in \partial \widetilde{\mathfrak{Q}}_{ad}^{n,1} \setminus \partial \mathfrak{Q}_{ad}^{n,1}$. Hence, making use of Lemma 5.2 together with Lemma 5.1, we deduce that $|\dot{\mathbf{q}}^*(\widetilde{T})| < \infty$. The configuration (locations and shapes) for the bodies at time \widetilde{T} , that is $S(\mathbf{q}^*(\widetilde{T}), \boldsymbol{\phi}(\widetilde{T}))$, can be chosen as new initial configuration. We denote it S_0 and we can reapply Theorem 2.1 with $(\dot{\mathbf{q}}_0, \dot{\boldsymbol{\phi}}_0) = (\dot{\mathbf{q}}^*(\widetilde{T}), \dot{\boldsymbol{\phi}}(\widetilde{T}))$. We obtain a new function \mathbf{q}^* and the function \mathbf{Q}^* can be extended to the right of \widetilde{T} by setting $\mathbf{Q}^*(\widetilde{T}+t) = \mathfrak{F}_1(\mathbf{q}^*(t))$.
 - Either $(\mathbf{q}^*(\widetilde{T}), \boldsymbol{\phi}(\widetilde{T})) \in \partial \mathfrak{Q}_{ad}^{n,1} \cap \partial \widetilde{\mathfrak{Q}}_{ad}^{n,1}$. This possibility means that time \widetilde{T} corresponds to the time of a collision between two bodies or between a body with the fluid's domain boundary. It is the only case where we may have $|\dot{\mathbf{q}}^*(t)| \to \infty$ as $t \to \widetilde{T}$.

The proof of Corollary 2.1 is then complete.

6 Explicit form of the Lagrangian system of ODE's in a particular case

In this section we address the case of a swimmer alone and we assume that the system body-fluid fills a bounded region in \mathbb{R}^3 . We denote $\mathbf{h}(t)$ the coordinates

of the center of mass of the body with $\mathbf{h}(0) = \mathbf{0}_3$. The deformation is given by a C^k -function $(k \ge 1)$:

$$t \in [0,\infty) \mapsto \phi(t) \in C_c^m(\mathbb{B}, \mathbb{R}^3),$$

for which $(\phi(t), \dot{\phi}(t)) \in \mathcal{D}^{1,m}$ for all $t \geq 0$ and $\phi(0) = [\mathbb{O}_3]$. We denote $\Phi(t) := [\mathbb{I}_3] + \phi(t)$ and the deformed swimmer is $S_d(t) := \Phi(t, S_0)$. For any pair (t, \mathbf{q}) such that $(\mathbf{q}, \phi(t)) \in \mathfrak{Q}_{ad}^{1,m}$, we denote merely $\Lambda(t, \mathbf{q})$ instead of $\Lambda(\mathbf{q}, \phi(t))$ defined by (3.2). We recall that $\Lambda(t, \mathbf{q})$ is a C^m -diffeomorphism from \mathbb{R}^3 onto \mathbb{R}^3 . In particular, we have:

$$\mathbf{\Lambda}((t,\mathbf{q}),\mathbf{x}) = \begin{cases} \mathcal{R}(\boldsymbol{\alpha})\mathbf{\Phi}(t,\mathbf{x}) + \mathbf{h} & \text{ if } \mathbf{x} \in S_0, \\ \mathbf{x} & \text{ if } \mathbf{x} \in \Gamma_1. \end{cases}$$

We set $S(t, \mathbf{q}) := \mathbf{\Lambda}((t, \mathbf{q}), S_0), \ \Omega(t, \mathbf{q}) := \mathbf{\Lambda}((t, \mathbf{q}), \Omega) \text{ and } \Gamma_2(t, \mathbf{q}) := \partial S(t, \mathbf{q}).$ We define also $\widetilde{\mathbf{\Lambda}}$, a C^m -diffeomorphism from \mathbb{R}^3 onto \mathbb{R}^3 by:

$$\widetilde{\mathbf{\Lambda}}((t,\mathbf{q}),\widetilde{\mathbf{x}}):=\mathcal{R}(oldsymbol{lpha})^T(\mathbf{\Lambda}((t,\mathbf{q}),\widetilde{\mathbf{x}})-\mathbf{h}),\quadorall\,\widetilde{\mathbf{x}}\in\mathbb{R}^3,$$

and we set $\widetilde{S}(t) := \widetilde{\Lambda}((t, \mathbf{q}), S_0) = \Phi(t, S_0), \ \widetilde{\Omega}(t, \mathbf{q}) := \widetilde{\Lambda}((t, \mathbf{q}), \Omega), \ \widetilde{\Gamma}_2(t) := \partial \widetilde{S}(t)$ and $\widetilde{\Gamma}_1(\mathbf{q}) := \widetilde{\Lambda}((t, \mathbf{q}), \Gamma_1) = \mathcal{R}(\boldsymbol{\alpha})^T (\Gamma_1 - \mathbf{h})$. We introduce the following vector fields compactly supported in \mathbb{R}^3 :

$$\mathbf{v}_{k}^{r}((t,\mathbf{q}),\cdot) := \partial_{q_{k}} \mathbf{\Lambda}((t,\mathbf{q}),\mathbf{\Lambda}^{-1}((t,\mathbf{q}),\cdot)), \ k = 1,\ldots,6,$$
$$\mathbf{v}^{d}((t,\mathbf{q}),\cdot) := \partial_{t} \mathbf{\Lambda}((t,\mathbf{q}),\mathbf{\Lambda}^{-1}((t,\mathbf{q}),\cdot)),$$
$$\dot{\mathbf{v}}^{d}((t,\mathbf{q}),\cdot) := \partial_{tt}^{2} \mathbf{\Lambda}((t,\mathbf{q}),\mathbf{\Lambda}^{-1}((t,\mathbf{q}),\cdot)),$$
$$\tilde{\mathbf{v}}_{k}^{r}((t,\mathbf{q}),\cdot) := \partial_{q_{k}} \mathbf{\tilde{\Lambda}}((t,\mathbf{q}),\mathbf{\tilde{\Lambda}}^{-1}((t,\mathbf{q}),\cdot)), \ k = 1,\ldots,6,$$
$$\tilde{\mathbf{v}}^{d}((t,\mathbf{q}),\cdot) := \partial_{t} \mathbf{\tilde{\Lambda}}((t,\mathbf{q}),\mathbf{\tilde{\Lambda}}^{-1}((t,\mathbf{q}),\cdot)),$$

and we can make them explicit on the boundaries of $\Omega(t, \mathbf{q})$ and $\widetilde{\Omega}(t, \mathbf{q})$. Thus, we have:

$$\mathbf{v}_k^r((t, \mathbf{q}), \mathbf{x}) = \mathbf{0}_3 \qquad \text{on } \Gamma_1, \ k = 1, \dots, 6, \\ \mathbf{v}^d((t, \mathbf{q}), \mathbf{x}) = \mathbf{0}_3 \qquad \text{on } \Gamma_1, \\ \mathbf{v}_k^r((t, \mathbf{q}), \mathbf{x}) = \mathbf{\omega}_k \wedge (\mathbf{x} - \mathbf{h}) \qquad \text{on } \Gamma_2(t, \mathbf{q}), \ k = 1, 2, 3, \\ \mathbf{v}_k^r((t, \mathbf{q}), \mathbf{x}) = \mathbf{e}_{k-3} \qquad \text{on } \Gamma_2(t, \mathbf{q}), \ k = 4, 5, 6, \\ \mathbf{v}^d((t, \mathbf{q}), \mathbf{x}) = \mathcal{R}(\boldsymbol{\alpha}) \dot{\boldsymbol{\phi}} \left(\mathbf{p}, \mathbf{\Lambda}^{-1}((t, \mathbf{q}), \mathbf{x}) \right) \quad \text{on } \Gamma_2(t, \mathbf{q}), \\ \dot{\mathbf{v}}^d((t, \mathbf{q}), \mathbf{x}) = \mathcal{R}(\boldsymbol{\alpha}) \ddot{\boldsymbol{\phi}} \left(\mathbf{p}, \mathbf{\Lambda}^{-1}((t, \mathbf{q}), \mathbf{x}) \right) \quad \text{on } \Gamma_2(t, \mathbf{q}).$$

and:

$$\begin{aligned} \widetilde{\mathbf{v}}_{k}^{r}((t,\mathbf{q}),\widetilde{\mathbf{x}}) &= -(\mathcal{R}(\boldsymbol{\alpha})^{T}\boldsymbol{\omega}_{k}) \wedge \widetilde{\mathbf{x}}, & \text{on } \widetilde{\Gamma}_{1}(\mathbf{q}), \ k = 1, 2, 3, \\ \widetilde{\mathbf{v}}_{k}^{r}((t,\mathbf{q}),\widetilde{\mathbf{x}}) &= -\mathcal{R}(\boldsymbol{\alpha})^{T}\mathbf{e}_{k-3} & \text{on } \widetilde{\Gamma}_{1}(\mathbf{q}), \ k = 4, 5, 6, \\ \widetilde{\mathbf{v}}^{d}((t,\mathbf{q}),\widetilde{\mathbf{x}}) &= \mathbf{0}_{3} & \text{on } \widetilde{\Gamma}_{1}(\mathbf{q}), \\ \widetilde{\mathbf{v}}_{k}^{r}((t,\mathbf{q}),\widetilde{\mathbf{x}}) &= \mathbf{0}_{3} & \text{on } \widetilde{\Gamma}_{2}(t), \ k = 1, \dots, 6, \\ \widetilde{\mathbf{v}}^{d}((t,\mathbf{q}),\widetilde{\mathbf{x}}) &= \dot{\boldsymbol{\phi}}(\mathbf{p}, \widetilde{\boldsymbol{\Lambda}}^{-1}((t,\mathbf{q}),\widetilde{\mathbf{x}})) & \text{on } \widetilde{\Gamma}_{2}(t), \\ \dot{\widetilde{\mathbf{v}}}^{d}((t,\mathbf{q}),\widetilde{\mathbf{x}}) &= \ddot{\boldsymbol{\phi}}(\mathbf{p}, \widetilde{\boldsymbol{\Lambda}}^{-1}((t,\mathbf{q}),\widetilde{\mathbf{x}})) & \text{on } \widetilde{\Gamma}_{2}(t). \end{aligned}$$

We denote $[\tilde{V}^r(t, \mathbf{q})]$ the 3 × 6 matrix defined on \mathbb{R}^3 and whose column vectors are $\tilde{\mathbf{v}}_k^r$, $k = 1, \ldots, 6$. Like in Section 3, the potential of the fluid reads $\varphi(t, \mathbf{q}) =$

 $\sum_{k=1}^{6} \varphi_k^r(t, \mathbf{q}) \dot{q}_k + \varphi^d(t, \mathbf{q})$, where $\varphi_k^r(t, \mathbf{q})$ and $\varphi^d(t, \mathbf{q})$ are harmonic in $\Omega(t, \mathbf{q})$ and satisfy the following Neumann boundary conditions:

$$\partial_{\mathbf{n}}\varphi_{k}^{r}(t,\mathbf{q}) = b_{k}^{r}(t,\mathbf{q}) := \mathbf{v}_{k}^{r}(t,\mathbf{q}) \cdot \mathbf{n} \text{ on } \Gamma_{1} \cup \Gamma_{2}(t,\mathbf{q}), \quad k = 1,\ldots,6,$$

$$\partial_{\mathbf{n}}\varphi^{d}(t,\mathbf{q}) = b^{d}(t,\mathbf{q}) := \mathbf{v}_{d}(t,\mathbf{q}) \cdot \mathbf{n} \text{ on } \Gamma_{1} \cup \Gamma_{2}(t,\mathbf{q}).$$

We introduce also:

$$\begin{aligned} \widetilde{\varphi}_k^r((t,\mathbf{q}),\widetilde{\mathbf{x}}) &:= \varphi_k^r((t,\mathbf{q}),\mathcal{R}(\boldsymbol{\alpha})\widetilde{\mathbf{x}} + \mathbf{h}), \quad k = 1,\dots,6, \\ \widetilde{\varphi}^d((t,\mathbf{q}),\widetilde{\mathbf{x}}) &:= \varphi^d((t,\mathbf{q}),\mathcal{R}(\boldsymbol{\alpha})\widetilde{\mathbf{x}} + \mathbf{h}), \quad \forall \widetilde{\mathbf{x}} \in \widetilde{\Omega}(t,\mathbf{q}). \end{aligned}$$

The functions $\tilde{\varphi}_k^r(t, \mathbf{q})$ and $\tilde{\varphi}^d(t, \mathbf{q})$ are also harmonic in $\tilde{\Omega}(t, \mathbf{q})$ and satisfy the Neumann boundary conditions:

$$\begin{aligned} \partial_{\mathbf{n}}\widetilde{\varphi}_{k}^{r}(t,\mathbf{q}) &= \widetilde{b}_{k}^{r}(t,\mathbf{q}) \coloneqq 0 & \text{on } \widetilde{\Gamma}_{1}(\mathbf{q}), \ k = 1, \dots, 6, \\ \partial_{\mathbf{n}}\widetilde{\varphi}_{k}^{r}(t,\mathbf{q}) &= \widetilde{b}_{k}^{r}(t,\mathbf{q}) \coloneqq (\mathcal{R}(\boldsymbol{\alpha})^{T}\boldsymbol{\omega}_{k}) \wedge \widetilde{\mathbf{x}} \cdot \mathbf{n} & \text{on } \widetilde{\Gamma}_{2}(t), \ k = 1, 2, 3, \\ \partial_{\mathbf{n}}\widetilde{\varphi}_{k}^{r}(t,\mathbf{q}) &= \widetilde{b}_{k}^{r}(t,\mathbf{q}) \coloneqq \mathcal{R}(\boldsymbol{\alpha})^{T}\mathbf{e}_{k-3} \cdot \mathbf{n} & \text{on } \widetilde{\Gamma}_{2}(t), \ k = 4, 5, 6, \\ \partial_{\mathbf{n}}\widetilde{\varphi}^{d}(t,\mathbf{q}) &= \widetilde{b}^{d}(t,\mathbf{q}) \coloneqq \widetilde{\mathbf{v}}_{d}^{k}(t,\mathbf{q}) \cdot \mathbf{n} & \text{on } \widetilde{\Gamma}_{1}(\mathbf{q}) \cup \widetilde{\Gamma}_{2}(t). \end{aligned}$$

We set $\boldsymbol{\varphi}^r := (\varphi_1^r, \dots, \varphi_6^r)^T$ and $\tilde{\boldsymbol{\varphi}}^r := (\tilde{\varphi}_1^r, \dots, \tilde{\varphi}_6^r)^T$ and we denote merely $[K_S^r(t, \mathbf{q})]$, $[K_F^r(t, \mathbf{q})], \mathbf{K}_F^{r,d}(t, \mathbf{q})$ and $K_F^d(t, \mathbf{q})$ instead of $[K_S^r(\mathbf{q}, \boldsymbol{\phi}(t))], [K_F^r(\mathbf{q}, \boldsymbol{\phi}(t))], \mathbf{K}_F^{r,d}(\mathbf{q}, \boldsymbol{\phi}(t), \dot{\boldsymbol{\phi}}(t))$ and $K_F^d(\mathbf{q}, \boldsymbol{\phi}(t), \dot{\boldsymbol{\phi}}(t))$ defined in (3.11). The Lagrangian reads:

$$\begin{split} \mathcal{L}(t,\mathbf{q},\dot{\mathbf{q}}) = \\ \frac{1}{2}\dot{\mathbf{q}} \cdot ([K_S^r(t,\mathbf{q})] + [K_F^r(t,\mathbf{q})])\dot{\mathbf{q}} + \mathbf{K}_F^{r,d}(t,\mathbf{q}) \cdot \dot{\mathbf{q}} + \frac{1}{2}K_F^d(t,\mathbf{q}) - \mathcal{P}(t,\mathbf{q}). \end{split}$$

and the ODE (5.4) becomes:

$$\begin{split} \langle [K_{S}^{r}(t,\mathbf{q})] + [K_{F}^{r}(t,\mathbf{q})], \ddot{\mathbf{q}}, \cdot \rangle \\ &+ \langle \partial_{\mathbf{q}}[K_{S}^{r}(t,\mathbf{q})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \cdot \rangle - \frac{1}{2} \langle \partial_{\mathbf{q}}[K_{S}^{r}(t,\mathbf{q})], \cdot, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle \\ &+ \langle \partial_{\mathbf{q}}[K_{F}^{r}(t,\mathbf{q})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \cdot \rangle - \frac{1}{2} \langle \partial_{\mathbf{q}}[K_{F}^{r}(t,\mathbf{q})], \cdot, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle \\ &+ \langle \partial_{t}[K_{S}^{r}(t,\mathbf{q})], \dot{\mathbf{q}}, \cdot \rangle - \langle \partial_{\mathbf{q}}K_{F}^{r}(t,\mathbf{q})], \dot{\mathbf{q}}, \cdot \rangle \\ &+ \langle \partial_{\mathbf{q}}\mathbf{K}_{F}^{r,d}(t,\mathbf{q}), \dot{\mathbf{q}}, \cdot \rangle - \langle \partial_{\mathbf{q}}\mathbf{K}_{F}^{r,d}(t,\mathbf{q}), \cdot, \dot{\mathbf{q}} \rangle + \langle \partial_{t}\mathbf{K}_{F}^{r,d}(t,\mathbf{q}), \cdot \rangle \\ &- \frac{1}{2} \langle \partial_{\mathbf{q}}K_{F}^{d}(t,\mathbf{q}), \cdot \rangle + \langle \partial_{\mathbf{q}}\mathcal{P}(t,\mathbf{q}), \cdot \rangle = \mathbf{0}_{6n}. \quad (6.1) \end{split}$$

The expressions of $[K_S^r(t, \mathbf{q})]$ and $[K_F^r(t, \mathbf{q})]$ (upon an integration by parts) are given in (A.4). Tedious computations involving the formulas (A.1) yields:

$$\begin{split} \langle \partial_{\mathbf{q}}[K^{r}_{S}(t,\mathbf{q})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \cdot \rangle &- \frac{1}{2} \langle \partial_{\mathbf{q}}[K^{r}_{S}(t,\mathbf{q})], \cdot, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle = \\ & \langle [\![T^{S/r}_{sym}(t,\mathbf{q})]\!] + [\![T^{S/r}_{skew}(t,\mathbf{q})]\!], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \cdot \rangle, \end{split}$$

where the $6 \times 6 \times 6$ third-rank tensors $[\![T^{S/r}_{sym}(t, \mathbf{q})]\!]$ and $[\![T^{S/r}_{skew}(t, \mathbf{q})]\!]$ are given in (A.5). Without difficulty, we obtain also the identity:

the 6×6 symmetric matrix in the right hand side being given in (A.4). Observe now that we have:

$$\begin{split} K_F^r(t,\mathbf{q})_{ij} &= \int_{\Omega(t,\mathbf{q})} \nabla \varphi_i^r(t,\mathbf{q},\mathbf{x}) \cdot \nabla \varphi_j^r(t,\mathbf{q},\mathbf{x}) \, \mathrm{d}\mathbf{x} \\ &= \int_{\widetilde{\Omega}(t,\mathbf{q})} \nabla \widetilde{\varphi}_i^r(t,\mathbf{q},\widetilde{\mathbf{x}}) \cdot \nabla \widetilde{\varphi}_j^r(t,\mathbf{q},\widetilde{\mathbf{x}}) \, \mathrm{d}\widetilde{\mathbf{x}}, \quad 1 \leq i,j \leq 6, \\ K_F^{r,d}(t,\mathbf{q})_i &= \int_{\widetilde{\Omega}(t,\mathbf{q},\widetilde{\mathbf{x}})} \nabla \widetilde{\varphi}^d(t,\mathbf{q},\widetilde{\mathbf{x}}) \cdot \nabla \widetilde{\varphi}_i^r(t,\mathbf{q},\widetilde{\mathbf{x}}) \, \mathrm{d}\widetilde{\mathbf{x}}, \quad i = 1,\dots, 6, \end{split}$$

and

$$K_F^d(t, \mathbf{q}) = \int_{\widetilde{\Omega}(t, \mathbf{q}, \widetilde{\mathbf{x}})} |\nabla \widetilde{\varphi}^d(t, \mathbf{q}, \widetilde{\mathbf{x}})|^2 \, \mathrm{d}\widetilde{\mathbf{x}}.$$

Applying formula (4.3), we obtain:

$$\partial_{\mathbf{q}} K_F^d(t, \mathbf{q}) = -\int_{\widetilde{\Gamma}_1(\mathbf{q})} \rho_F |\nabla \widetilde{\varphi}^d|^2 [\widetilde{V}^r]^T \mathbf{n} \,\mathrm{d}\Gamma_x.$$

The change of variables $\mathbf{x} := \mathcal{R}(\boldsymbol{\alpha})\mathbf{\tilde{x}} + \mathbf{h}$ in the integral above yields:

$$\partial_{\mathbf{q}} K_F^d(t, \mathbf{q}) = -\int_{\Gamma_1} \rho_F |\nabla \varphi^d|^2 [W^r]^T \mathbf{n} \,\mathrm{d}\Gamma_x,$$

where the matrix $[W^r]$ is given by (A.3) in the Appendix. In order to apply again the same Formula (4.3) to the others terms, we introduce:

and we have:

$$\begin{split} \widetilde{B}_{k}^{r}(t,\mathbf{q},\mathbf{x}) &= 0 & \text{on } \Gamma_{1}, \ k = 1,\dots 6, \\ \widetilde{B}^{d}(t,\mathbf{q}) &= 0 & \text{on } \Gamma_{1}, \\ \widetilde{B}_{k}^{r}(t,\mathbf{q},\mathbf{x}) &= (\mathcal{R}(\boldsymbol{\alpha})^{T}\boldsymbol{\omega}_{k}) \wedge \boldsymbol{\Phi}(t,\mathbf{x}) \cdot \mathbf{n}(\boldsymbol{\Phi}(t,\mathbf{x})) & \text{on } \Gamma_{2}, \ k = 1,2,3, \\ \widetilde{B}_{k}^{r}(t,\mathbf{q}) &= \mathcal{R}(\boldsymbol{\alpha})^{T}\mathbf{e}_{k-3} \cdot \mathbf{n}(\boldsymbol{\Phi}(t,\mathbf{x})) & \text{on } \Gamma_{2}, \ k = 4,5,6, \\ \widetilde{B}^{d}(t,\mathbf{q}) &= \dot{\boldsymbol{\phi}}(t,\mathbf{x}) \cdot \mathbf{n}(\boldsymbol{\Phi}(t)) & \text{on } \Gamma_{2}, \ k = 1,\dots,d. \end{split}$$

Straightforward computations yield, for all $\widetilde{\mathbf{x}} \in \widetilde{\Gamma}_1(\mathbf{q})$: $\partial_{q_i} \widetilde{B}_k^r((t, \mathbf{q}), \widetilde{\mathbf{\Lambda}}^{-1}((t, \mathbf{q}), \widetilde{\mathbf{x}})) = 0$ for all $k = 1, \ldots, 6$ and all $i = 1, \ldots, 6$ and for all $\mathbf{x} \in \widetilde{\Gamma}_2(t)$ we have:

$$\partial_{q_i} \widetilde{B}_k^r((t, \mathbf{q}), \widetilde{\mathbf{\Lambda}}^{-1}((t, \mathbf{q}), \widetilde{\mathbf{x}})) = \begin{cases} (\boldsymbol{\omega}_k \wedge \boldsymbol{\omega}_i) \cdot \mathcal{R}(\boldsymbol{\alpha})(\widetilde{\mathbf{x}} \wedge \mathbf{n}) & \text{if } 1 \le k < i \le 3, \\ (\mathcal{R}(\boldsymbol{\alpha})\mathbf{n} \wedge \mathbf{e}_{k-3}) \cdot \boldsymbol{\omega}_i & \text{if } k = 4, 5, 6, \ i = 1, 2, 3, \\ 0 & \text{otherwise.} \end{cases}$$

We denote $[\widetilde{N}(t, \mathbf{q})]$ the 6×6 matrix whose entries are $\widetilde{N}_{ki}(t, \mathbf{q}) := \partial_{q_i} \widetilde{B}_k^r(t, \mathbf{q}, \widetilde{\Lambda}^{-1}(t, \mathbf{q}))$ and invoking formula (4.3), we get:

$$\begin{split} \langle \partial_{\mathbf{q}}[K_{F}^{r}(t,\mathbf{q})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \cdot \rangle &- \frac{1}{2} \langle \partial_{\mathbf{q}}[K_{F}^{r}(t,\mathbf{q})], \cdot, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle = \\ &- \frac{1}{2} \int_{\widetilde{\Gamma}_{1}(\mathbf{q})} \rho_{F}[D\widetilde{\boldsymbol{\varphi}}^{r}][D\widetilde{\boldsymbol{\varphi}}^{r}]^{T} \dot{\mathbf{q}} (\mathbf{n} \cdot [D\widetilde{V}^{r}]\dot{\mathbf{q}}) \, \mathrm{d}\Gamma_{x} + \frac{1}{2} \int_{\widetilde{\Gamma}_{2}(t)} \rho_{F}\widetilde{\boldsymbol{\varphi}}^{r} (\dot{\mathbf{q}} \cdot ([\widetilde{N}] + [\widetilde{N}]^{T})\dot{\mathbf{q}}) \, \mathrm{d}\Gamma_{x} \\ &+ \frac{1}{2} \int_{\widetilde{\Gamma}_{1}(\mathbf{q})} \rho_{F} \Big((\dot{\mathbf{q}}^{T}[D\widetilde{\boldsymbol{\varphi}}][D\widetilde{\boldsymbol{\varphi}}]^{T} \dot{\mathbf{q}}) ([\widetilde{V}^{r}]^{T}\mathbf{n}) - [D\widetilde{\boldsymbol{\varphi}}^{r}][D\widetilde{\boldsymbol{\varphi}}^{r}]^{T} \dot{\mathbf{q}} (\mathbf{n} \cdot [D\widetilde{V}^{r}]\dot{\mathbf{q}}) \Big) \, \mathrm{d}\Gamma_{x} \\ &+ \int_{\widetilde{\Gamma}_{2}(t)} \rho_{F} (\widetilde{\boldsymbol{\varphi}}^{r} \cdot \dot{\mathbf{q}}) ([\widetilde{N}] - [\widetilde{N}]^{T}) \dot{\mathbf{q}} \, \mathrm{d}\Gamma_{x}. \end{split}$$

Applying the change of variables $\mathbf{x} := \mathcal{R}(\boldsymbol{\alpha})\mathbf{\widetilde{x}} + \mathbf{h}$, we get:

$$\langle \partial_{\mathbf{q}}[K_F^r(t,\mathbf{q})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \cdot \rangle - \frac{1}{2} \langle \partial_{\mathbf{q}}[K_F^r(t,\mathbf{q})], \cdot, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle = \langle \llbracket T_{sym}^{F/r} \rrbracket + \llbracket T_{skew}^{F/r} \rrbracket, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle,$$

in which the expressions of the $6 \times 6 \times 6$ third-rank tensors $[\![T_{sym}^{F/r}]\!]$ and $[\![T_{sym}^{F/r}]\!]$ are given by (A.5). The same formula (4.3) yields also:

$$\begin{split} \langle \partial_{\mathbf{q}} \mathbf{K}_{F}^{r,d}(t,\mathbf{q}), \dot{\mathbf{q}}, \cdot \rangle &- \langle \partial_{\mathbf{q}} \mathbf{K}_{F}^{r,d}(t,\mathbf{q}), \cdot, \dot{\mathbf{q}} \rangle = \\ &- \int_{\widetilde{\Gamma}_{1}(\mathbf{q})} \left([D\widetilde{\boldsymbol{\varphi}}^{r}] (\nabla \widetilde{\boldsymbol{\varphi}}^{d})^{T} (\dot{\mathbf{q}} \cdot [\widetilde{V}^{r}]^{T} \mathbf{n}) - (\dot{\mathbf{q}} \cdot [D\widetilde{\boldsymbol{\varphi}}^{r}] (\nabla \widetilde{\boldsymbol{\varphi}}^{d})^{T}) [\widetilde{V}^{r}]^{T} \mathbf{n} \right) \mathrm{d}\Gamma_{x} \\ &+ \int_{\widetilde{\Gamma}_{2}(t)} \rho_{F} \widetilde{\boldsymbol{\varphi}}^{d} ([\widetilde{N}] - [\widetilde{N}]^{T}) \dot{\mathbf{q}} \, \mathrm{d}\Gamma_{x}. \end{split}$$

The change of variables $\mathbf{x} := \mathcal{R}(\boldsymbol{\alpha})\mathbf{\tilde{x}} + \mathbf{h}$ leads to:

$$\langle \partial_{\mathbf{q}} \mathbf{K}_{F}^{r,d}(t,\mathbf{q}), \dot{\mathbf{q}}, \cdot \rangle - \langle \partial_{\mathbf{q}} \mathbf{K}_{F}^{r,d}(t,\mathbf{q}), \cdot, \dot{\mathbf{q}} \rangle = [M_{skew}^{F/d}(t,\mathbf{q})] \dot{\mathbf{q}},$$

the definition of 6×6 skew-symmetric matrix $[M_{skew}^{F/d}(t, \mathbf{q})]$ being given in (A.6). As regards the computation of $\partial_t \tilde{B}^d(t, \mathbf{q})$, we require the use of Lemma 5.1. Since $\tilde{\Lambda}(t, \mathbf{q}, \tilde{\mathbf{x}}) = \Phi(t, \tilde{\mathbf{x}})$ on $\tilde{\Gamma}_2(t)$, we obtain that:

$$\partial_t \widetilde{B}_k^r(t, \mathbf{q}, \widetilde{\mathbf{\Lambda}}^{-1}(t, \mathbf{q}, \widetilde{\mathbf{x}})) = \begin{cases} \mathcal{R}(\boldsymbol{\alpha}) \Big(\widetilde{\mathbf{v}}^d \wedge \mathbf{n} + \widetilde{\mathbf{x}} \wedge ((-\mathbf{n} \cdot [D\widetilde{\mathbf{v}}^d] \boldsymbol{\tau}_1) \boldsymbol{\tau}_1 + (-\mathbf{n} \cdot [D\widetilde{\mathbf{v}}^d] \boldsymbol{\tau}_2) \boldsymbol{\tau}_2) \Big) \cdot \boldsymbol{\omega}_k & \text{if } k = 1, 2, 3, \\ \mathcal{R}(\boldsymbol{\alpha}) \Big((-\mathbf{n} \cdot [D\widetilde{\mathbf{v}}^d] \boldsymbol{\tau}_1) \boldsymbol{\tau}_1 + (-\mathbf{n} \cdot [D\widetilde{\mathbf{v}}^d] \boldsymbol{\tau}_2) \boldsymbol{\tau}_2 \Big) \cdot \mathbf{e}_{k-3} & \text{if } k = 4, 5, 6. \end{cases}$$

We also have on $\widetilde{\Gamma}_2(t)$:

$$\nabla_{\Gamma} \widetilde{b}_{k}^{r}(t, \mathbf{q}, \widetilde{\mathbf{x}}) \cdot \widetilde{\mathbf{v}}^{d} = \begin{cases} \mathcal{R}(\boldsymbol{\alpha}) \Big(\widetilde{\mathbf{v}}^{d} \wedge \mathbf{n} + \widetilde{\mathbf{x}} \wedge (-\kappa_{1}(\boldsymbol{\tau}_{1} \cdot \widetilde{\mathbf{v}}^{d})\boldsymbol{\tau}_{1} - \kappa_{2}(\boldsymbol{\tau}_{2} \cdot \widetilde{\mathbf{v}}^{d})\boldsymbol{\tau}_{2}) \Big) \cdot \boldsymbol{\omega}_{k} & \text{if } k = 1, 2, 3, \\ \mathcal{R}(\boldsymbol{\alpha}) \Big(-\kappa_{1}(\boldsymbol{\tau}_{1} \cdot \widetilde{\mathbf{v}}^{d})\boldsymbol{\tau}_{1} - \kappa_{2}(\boldsymbol{\tau}_{2} \cdot \widetilde{\mathbf{v}}^{d})\boldsymbol{\tau}_{2} \Big) \cdot \mathbf{e}_{k-3} & \text{if } k = 4, 5, 6. \end{cases}$$

But the definition of the tangential gradient allows us to write $\nabla_{\Gamma}(\widetilde{\mathbf{v}}^{d} \cdot \mathbf{n}) = (\nabla(\widetilde{\mathbf{v}}^{d} \cdot \mathbf{n}) \cdot \boldsymbol{\tau}_{1})\boldsymbol{\tau}_{1} + (\nabla(\widetilde{\mathbf{v}}^{d} \cdot \mathbf{n}) \cdot \boldsymbol{\tau}_{2})\boldsymbol{\tau}_{2}$ and according to the definition of the principal curvature κ_{i} , we get $\nabla(\widetilde{\mathbf{v}}^{d} \cdot \mathbf{n}) \cdot \boldsymbol{\tau}_{k} = \mathbf{n} \cdot [D\widetilde{\mathbf{v}}^{d}]\boldsymbol{\tau}_{k} + \widetilde{\mathbf{v}}^{d} \cdot [D\mathbf{n}]\boldsymbol{\tau}_{k} = \mathbf{n} \cdot [D\widetilde{\mathbf{v}}^{d}]\boldsymbol{\tau}_{k} - \kappa_{k}(\widetilde{\mathbf{v}}^{d} \cdot \boldsymbol{\tau}_{k}).$ We deduce that on $\widetilde{\Gamma}_{2}(t)$:

$$\begin{split} \partial_t \widetilde{B}_k^r(t, \mathbf{q}, \widetilde{\mathbf{\Lambda}}^{-1}(t, \mathbf{q}, \widetilde{\mathbf{x}})) - \nabla_{\Gamma} \widetilde{b}_k^r(t, \mathbf{q}, \widetilde{\mathbf{x}}) \cdot \widetilde{\mathbf{v}}^d = \\ \begin{cases} -\mathcal{R}(\boldsymbol{\alpha}) (\widetilde{\mathbf{x}} \wedge \nabla_{\Gamma} (\widetilde{\mathbf{v}}^d \cdot \mathbf{n})) \cdot \boldsymbol{\omega}_k & \text{if } k = 1, 2, 3, \\ -\mathcal{R}(\boldsymbol{\alpha}) \nabla_{\Gamma} (\widetilde{\mathbf{v}}^d \cdot \mathbf{n}) \cdot \mathbf{e}_{k-3} & \text{if } k = 4, 5, 6. \end{cases} \end{split}$$

We denote $\widetilde{\mathbf{A}}(t, \mathbf{q})$ the 6-length column vector defined on $\widetilde{\Gamma}_2(t)$ whose entries are

$$\widetilde{A}_k(t,\mathbf{q}) := \partial_t \widetilde{B}_k^r(t,\mathbf{q},\widetilde{\mathbf{\Lambda}}^{-1}(t,\mathbf{q})) - \nabla_{\Gamma} \widetilde{b}_k^r(t,\mathbf{q}) \cdot \widetilde{\mathbf{v}}^d,$$

and applying one more time formula (4.3) we obtain:

$$\begin{aligned} \partial_t [K_F^r(t, \mathbf{q})] \dot{\mathbf{q}} &= -\int_{\widetilde{\Gamma}_2(t)} \rho_F [D\widetilde{\boldsymbol{\varphi}}^r] [D\widetilde{\boldsymbol{\varphi}}^r]^T \dot{\mathbf{q}} (\widetilde{\mathbf{v}}^d \cdot \mathbf{n}) \, \mathrm{d}\Gamma_x \\ &+ \int_{\widetilde{\Gamma}_2(t)} \rho_F \Big(\widetilde{\boldsymbol{\varphi}}^r(\dot{\mathbf{q}} \cdot \widetilde{\mathbf{A}}) + (\widetilde{\boldsymbol{\varphi}}^r \cdot \dot{\mathbf{q}}) \widetilde{\mathbf{A}} \Big) \, \mathrm{d}\Gamma_x + 2 \int_{\widetilde{\Gamma}_2(t)} \rho_F [\widetilde{V}^r]^T \mathbf{n} (\mathbf{n} \cdot [\widetilde{V}^r] \dot{\mathbf{q}}) (\widetilde{\mathbf{v}}^d \cdot \mathbf{n}) \, \mathrm{d}\Gamma_x \\ &- 2 \int_{\widetilde{\Gamma}_2(t)} \rho_F \mathcal{H} \Big([\widetilde{V}^r]^T \mathbf{n} (\widetilde{\boldsymbol{\varphi}}^r \cdot \dot{\mathbf{q}}) + \widetilde{\boldsymbol{\varphi}}^r (\dot{\mathbf{q}} \cdot [\widetilde{V}^r]^T \mathbf{n}) \Big) (\widetilde{\mathbf{v}}^d \cdot \mathbf{n}) \, \mathrm{d}\Gamma_x. \end{aligned}$$

Upon the change of variables $\mathbf{x} := \mathcal{R}(\boldsymbol{\alpha})\mathbf{\tilde{x}} + \mathbf{h}$, the identity above turns into:

$$\partial_t [K_F^r(t,\mathbf{q})] \dot{\mathbf{q}} = [M_{sym}^{F/d}(t,\mathbf{q})] \dot{\mathbf{q}}$$

the 6 × 6 symmetric matrix $[M_{sym}^{F/d}(t, \mathbf{q})]$ being given in (A.6). We compute as well that, on $\widetilde{\Gamma}_2(t)$: $\partial_t \widetilde{B}^d(t, \mathbf{q}, \widetilde{\Lambda}^{-1}(t, \mathbf{q})) = \dot{\widetilde{\mathbf{v}}}^d \cdot \mathbf{n} - \nabla_{\Gamma}(\widetilde{\mathbf{v}}^d \cdot \mathbf{n}) \cdot \widetilde{\mathbf{v}}^d - \kappa_1(\widetilde{\mathbf{v}}^d \cdot \boldsymbol{\tau}_1)^2 - \kappa_2(\widetilde{\mathbf{v}}^d \cdot \boldsymbol{\tau}_2)^2$. Since $\nabla_{\Gamma} \widetilde{b}^d(t, \mathbf{q}) \cdot \widetilde{\mathbf{v}}^d = \nabla_{\Gamma}(\widetilde{\mathbf{v}}^d \cdot \mathbf{n}) \cdot \widetilde{\mathbf{v}}^d$, we obtain that, on $\widetilde{\Gamma}_2(t)$: $\partial_t \widetilde{B}^d(t, \mathbf{q}, \widetilde{\Lambda}^{-1}(t, \mathbf{q})) - \nabla_{\Gamma} \widetilde{b}^d(t, \mathbf{q}) \cdot \widetilde{\mathbf{v}}^d = \dot{\mathbf{v}}^d \cdot \mathbf{n} - 2\nabla_{\Gamma}(\widetilde{\mathbf{v}}^d \cdot \mathbf{n}) \cdot \widetilde{\mathbf{v}}^d - \kappa_1(\widetilde{\mathbf{v}}^d \cdot \boldsymbol{\tau}_1)^2 - \kappa_2(\widetilde{\mathbf{v}}^d \cdot \boldsymbol{\tau}_2)^2$. Applying formula (4.3), we get:

$$\begin{split} \partial_{t} \mathbf{K}_{F}^{r,d}(t,\mathbf{q}) &= -\int_{\widetilde{\Gamma}_{2}(t)}^{} \rho_{F}(\widetilde{\mathbf{v}}^{d}\cdot\mathbf{n})[D\widetilde{\boldsymbol{\varphi}}^{r}](\nabla\widetilde{\boldsymbol{\varphi}}^{d})^{T} \,\mathrm{d}\Gamma_{x} \\ &+ 2\int_{\widetilde{\Gamma}_{2}(t)}^{} \rho_{F}[\widetilde{V}^{r}]^{T}\mathbf{n}(\widetilde{\mathbf{v}}^{d}\cdot\mathbf{n})^{2} \,\mathrm{d}\Gamma_{x} - 2\int_{\widetilde{\Gamma}_{2}(t)}^{} \rho_{F}\mathcal{H}\Big(\widetilde{\boldsymbol{\varphi}}^{d}[\widetilde{V}^{r}]^{T}\mathbf{n} + (\widetilde{\mathbf{v}}^{d}\cdot\mathbf{n})\widetilde{\boldsymbol{\varphi}}^{r}\Big)\widetilde{\mathbf{v}}^{d}\cdot\mathbf{n} \,\mathrm{d}\Gamma_{x} \\ &+ \int_{\widetilde{\Gamma}_{2}(t)}^{} \rho_{F}\Big(\widetilde{\boldsymbol{\varphi}}^{d}\widetilde{\mathbf{A}} + \Big(\widetilde{\mathbf{v}}^{d}\cdot\mathbf{n} - 2\nabla_{\Gamma}(\widetilde{\mathbf{v}}^{d}\cdot\mathbf{n})\cdot\widetilde{\mathbf{v}}^{d} \\ &- \kappa_{1}(\widetilde{\mathbf{v}}^{d}\cdot\boldsymbol{\tau}_{1})^{2} - \kappa_{2}(\widetilde{\mathbf{v}}^{d}\cdot\boldsymbol{\tau}_{2})^{2}\Big)\widetilde{\boldsymbol{\varphi}}^{r}\Big) \,\mathrm{d}\Gamma_{x}. \end{split}$$

The change of variables $\mathbf{x} := \mathcal{R}(\boldsymbol{\alpha})\mathbf{\widetilde{x}} + \mathbf{h}$ leads to:

$$\begin{split} \partial_t \mathbf{K}_F^{r,d}(t,\mathbf{q}) &= -\int_{\Gamma_2(t,\mathbf{q})} \rho_F(\mathbf{v}^d \cdot \mathbf{n}) [D\boldsymbol{\varphi}^r] (\nabla \boldsymbol{\varphi}^d)^T \, \mathrm{d}\Gamma_x \\ &+ 2 \int_{\Gamma_2(t,\mathbf{q})} \rho_F[W^r]^T \mathbf{n} (\mathbf{v}^d \cdot \mathbf{n})^2 \, \mathrm{d}\Gamma_x - 2 \int_{\Gamma_2(t,\mathbf{q})} \rho_F \mathcal{H} \Big(\boldsymbol{\varphi}^d [W^r]^T \mathbf{n} + (\mathbf{v}^d \cdot \mathbf{n}) \boldsymbol{\varphi}^r \Big) \mathbf{v}^d \cdot \mathbf{n} \, \mathrm{d}\Gamma_x \\ &+ \int_{\Gamma_2(t,\mathbf{q})} \rho_F \Big(\boldsymbol{\varphi}^d \mathbf{A} + \Big(\dot{\mathbf{v}}^d \cdot \mathbf{n} - 2 \nabla_{\Gamma} (\mathbf{v}^d \cdot \mathbf{n}) \cdot \mathbf{v}^d \\ &- \kappa_1 (\mathbf{v}^d \cdot \boldsymbol{\tau}_1)^2 - \kappa_2 (\mathbf{v}^d \cdot \boldsymbol{\tau}_2)^2 \Big) \boldsymbol{\varphi}^r \Big) \, \mathrm{d}\Gamma_x. \end{split}$$

Notice that $-\kappa_1(\mathbf{v}^d \cdot \boldsymbol{\tau}_1)^2 - \kappa_2(\mathbf{v}^d \cdot \boldsymbol{\tau}_2)^2$ can be replaced by $\Pi_2((t, \mathbf{q}), \mathbf{v}_{\Gamma}^d, \mathbf{v}_{\Gamma}^d)$ where $\Pi_2(t, \mathbf{q})$ is the second fondamental form on $\Gamma_2(t, \mathbf{q})$ and $\mathbf{v}_{\Gamma}^d := \mathbf{v}^d - (\mathbf{v}^d \cdot \mathbf{n})\mathbf{n}$ is the tangential part of \mathbf{v}^d . Following the same ideas we obtain:

$$\partial_{\mathbf{q}} K_F^d(t, \mathbf{q}) = -\int_{\Gamma_1} \rho_F |\nabla \varphi^d|^2 [W^r]^T \mathbf{n} \,\mathrm{d}\Gamma_x.$$

Eventually we get upon a change of variables:

$$\mathcal{P}(t,\mathbf{q}) = -\int_{S_0} (\rho_S^0 - \rho_F |\det[D\mathbf{\Lambda}(t,\mathbf{q},\mathbf{x})]|) G(\mathbf{\Lambda}(t,\mathbf{q},\mathbf{x})) \,\mathrm{d}\mathbf{x}.$$

Applying [18, formula (5.16) page 175], that is:

$$\partial_{q_i} \det[D\mathbf{\Lambda}(t, \mathbf{q})] = \det[D\mathbf{\Lambda}(t, \mathbf{q})] \operatorname{div}[\partial_{q_i}\mathbf{\Lambda}(t, \mathbf{q})],$$

we obtain that:

$$\partial_{q_i} \mathcal{P}(t, \mathbf{q}) = \int_{S(t, \mathbf{q})} \rho_F \operatorname{div}(\partial_{q_i} \mathbf{\Lambda}(t, \mathbf{q}, \mathbf{\Lambda}^{-1}(t, \mathbf{q}, \mathbf{x})) G(\mathbf{x}) \, \mathrm{d}\mathbf{x} - \int_{S(t, \mathbf{q})} (\rho_S(\mathbf{x}) - \rho_F) \nabla G(\mathbf{x}) \cdot \partial_{q_i} \mathbf{\Lambda}(t, \mathbf{q}, \mathbf{\Lambda}^{-1}(t, \mathbf{q}, \mathbf{x})) \, \mathrm{d}\Gamma_x.$$

But $\partial_{q_i} \mathbf{\Lambda}(t, \mathbf{q}, \mathbf{\Lambda}^{-1}(t, \mathbf{q}, \mathbf{x})) = \mathbf{v}_i^r$ and $\operatorname{div}(\mathbf{v}_i^r) = 0$ for all $i = 1, \dots, 6$. Hence we obtain:

$$\partial_{q_i} \mathcal{P}(t, \mathbf{q}) = \int_{S(t, \mathbf{q})} (\rho_S(\mathbf{x}) - \rho_F) g[W^r]^T \mathbf{e}_3 \, \mathrm{d}\mathbf{x},$$

and this expression fits with that of $\mathbf{F}^{b}(t, \mathbf{q})$ given by (A.7). All the terms arising in the ODE (6.1) have now been computed and the proof of Theorem 2.2 is complete.

7 Future directions

A natural continuation of the results presented in this paper would be to perform 3d numerical simulations using the formula given in Theorem 2.2. This work is in progress.

About control, an interesting question is: for a given rigid motion of the swimmer in the fluid, is there a deformation that yields this motion? This problem is known as *tracking problem*. Equation (5.4) is then considered as an ODE in ϕ , in which $\mathbf{q}, \dot{\mathbf{q}}$ and $\ddot{\mathbf{q}}$ are given parameters. The uniqueness in the Cauchy-Lipschitz Theorem ensures that if such a deformation exists, when replugging it into the same ODE as parameter, the solution cannot be anything but the initial targeting motion. The theoretical problem of controlling an ellipsoid (modelling a submarine) in a potential flow was recently tackled by T. Chambrion and M. Sigalotti [11] using tools of geometric control.

At last, a precise asymptotic study of the motion when two bodies get close and finally collide remains to be done.

A Appendix

A.1 Euler angles

Let be $\mathcal{A} :=]-\pi, \pi[\times] - \pi/2, \pi/2[\times] - \pi, \pi[$ and $\widetilde{\mathcal{A}} :=]-\pi, \pi[\times] - \pi/4, \pi/4[\times] - \pi, \pi[$ and define the function:

$$\boldsymbol{\alpha} = (\alpha_1, \alpha_2, \alpha_3)^T \mapsto \mathcal{R}(\boldsymbol{\alpha}) := \begin{bmatrix} c_2 c_3 & -c_2 s_3 & -s_2 \\ -s_1 s_2 c_3 + c_1 s_3 & s_1 s_2 s_3 + c_1 c_3 & -s_1 c_2 \\ c_1 s_2 c_3 + s_1 s_3 & -c_1 s_2 s_3 + s_1 c_3 & c_1 c_2 \end{bmatrix},$$

where c_i stands for $\cos(\alpha_i)$ and s_i for $\sin(\alpha_i)$. The pair $(\mathcal{A}, \mathcal{R})$ is an analytic chart from \mathcal{A} onto a neighborhood of $[\mathbb{I}_3]$ in SO(3) such that $\mathcal{R}(\mathbf{0}_3) = [\mathbb{I}_3]$. The coordinates α_i are the so-called Euler angles with the "xyz" (pitch-roll-yaw) convention. Introducing the vectors

$$\begin{split} \boldsymbol{\omega}_1(\boldsymbol{\alpha}) &:= (1,0,0)^T, \\ \boldsymbol{\omega}_2(\boldsymbol{\alpha}) &:= (0,\cos(\alpha_1),\sin(\alpha_1))^T, \\ \boldsymbol{\omega}_3(\boldsymbol{\alpha}) &:= (-\sin(\alpha_2), -\sin(\alpha_1)\cos(\alpha_2),\cos(\alpha_1)\cos(\alpha_2))^T, \end{split}$$

we have the relations, easy to prove:

$$\frac{\partial \mathcal{R}}{\partial \alpha_i}(\boldsymbol{\alpha}) \mathcal{R}(\boldsymbol{\alpha})^T \mathbf{x} = \boldsymbol{\omega}_i(\boldsymbol{\alpha}) \wedge \mathbf{x}, \quad \forall \mathbf{x} \in \mathbb{R}^3, \ \forall \, \boldsymbol{\alpha} \in \mathcal{A}, \ \forall \, i = 1, 2, 3.$$
(A.1a)

We denote:

$$[\omega(\boldsymbol{\alpha})] := \begin{bmatrix} 1 & 0 & -\sin(\alpha_2) \\ 0 & \cos(\alpha_1) & -\sin(\alpha_2)\cos(\alpha_2) \\ 0 & \sin(\alpha_1) & \cos(\alpha_1)\cos(\alpha_2) \end{bmatrix}.$$

We can compute the derivative of the vectors $\boldsymbol{\omega}_k(\boldsymbol{\alpha})$:

$$\frac{\partial \boldsymbol{\omega}_k}{\partial \alpha_j}(\boldsymbol{\alpha}) = \begin{cases} \boldsymbol{\omega}_j(\boldsymbol{\alpha}) \land \boldsymbol{\omega}_k(\boldsymbol{\alpha}), & \text{if } 1 \le j < k \le 3, \\ \mathbf{0}_3, & \text{if } 1 \le k \le j \le 3. \end{cases}$$
(A.1b)

The differential of the matrix $[\omega(\alpha)]$ is a third rank tensor given by:

$$\partial_{\boldsymbol{\alpha}}[\boldsymbol{\omega}(\boldsymbol{\alpha})] = \mathbf{e}_2 \otimes (\boldsymbol{\omega}_1 \wedge \boldsymbol{\omega}_2) \otimes \mathbf{e}_1 + \mathbf{e}_3 \otimes (\boldsymbol{\omega}_1 \wedge \boldsymbol{\omega}_3) \otimes \mathbf{e}_1 + \mathbf{e}_3 \otimes (\boldsymbol{\omega}_2 \wedge \boldsymbol{\omega}_3) \otimes \mathbf{e}_2.$$
(A.1c)

The 6 × 6 block-diagonal matrix $[\widetilde{\omega}(\boldsymbol{\alpha})]$ is defined by :

$$[\widetilde{\omega}(\boldsymbol{\alpha})] := \operatorname{diag}([\omega(\boldsymbol{\alpha})], [\mathbb{I}_3]), \tag{A.2}$$

and we have $det[\widetilde{\omega}(\boldsymbol{\alpha})] = cos(\alpha_2)$.

A.2 Deformation spaces

Let \mathbb{B} be a ball in \mathbb{R}^3 , centered at the origin an large enough to contain all the initial regions $S_0^i - \mathbf{h}_0^i$ for i = 1, ..., n. Let $C_c^m(\mathbb{B}, \mathbb{R}^3)$ $(m \ge 0)$ be the space of the functions $\mathbf{F} = (F_1, F_2, F_3)^T$ from \mathbb{B} into \mathbb{R}^3 , m-times continuously differentiable and compactly supported. This space, endowed with the norm:

$$\|\mathbf{F}\|_{m,\infty} := \sup_{\substack{\gamma_1 + \gamma_2 + \gamma_3 \leq m \\ \gamma_1, \gamma_2, \gamma_3 \in \mathbb{N}}} \left(\sup_{i=1,2,3} \left\| \frac{\partial^{\gamma_1 + \gamma_2 + \gamma_3} F_i}{\partial^{\gamma_1} x_1 \partial^{\gamma_2} x_2 \partial^{\gamma_3} x_3} \right\|_{L^{\infty}(\mathbb{B})} \right),$$

is a Banach space. If $m \geq 1$ and $\|\mathbf{F}\|_{1,\infty} < 1$, then a fixed point argument ensures that $[\mathbb{I}_3] + \mathbf{F}$ is a C^m -diffeomorphism from \mathbb{B} onto \mathbb{B} . The functions of $C_c^m(\mathbb{B}, \mathbb{R}^3)$ can be extended by $\mathbf{0}_3$ in $\mathbb{R}^3 \setminus \mathbb{B}$ and therefore can be considered as functions of $C^{m,\infty}(\mathbb{R}^3, \mathbb{R}^3)$, the space of the *m*-times continuously differentiable functions, uniformly bounded in \mathbb{R}^3 as well as all of their derivatives. This space is also a Banach space endowed with the norm $\|\cdot\|_{m,\infty}$. For any function $\mathbf{F} := (F_1, F_2, F_3)^T \in C^{m,\infty}(\mathbb{R}^3, \mathbb{R}^3)$, the Jacobian matrix $[D\mathbf{F}]$ can be considered as a function of $C^{m-1,\infty}(\mathbb{R}^3, \mathbb{R}^3)^3$ since each row ∇F_i of the matrix is in $C^{m-1,\infty}(\mathbb{R}^3, \mathbb{R}^3)$. More generally, if $[F(\mathbf{x})]$ is a matrix for which the rows are three functions $\mathbf{F}_1, \mathbf{F}_2$ and \mathbf{F}_3 lying in $C^{m,\infty}(\mathbb{R}^3, \mathbb{R}^3)$, we will consider that $[F] \in C^{m,\infty}(\mathbb{R}^3, \mathbb{R}^3)^3$ and denote

$$||[F]||_{m,\infty,3} := \sup_{i=1,2,3} ||\mathbf{F}_i||_{m,\infty}.$$

Obviously, the space $C^{m,\infty}(\mathbb{R}^3,\mathbb{R}^3)^3$ endowed with the norm $\|\cdot\|_{m,\infty,3}$ is a Banach space.

Denoting $\boldsymbol{\phi} := (\boldsymbol{\phi}^1, \dots, \boldsymbol{\phi}^n)^T \in C_c^m(\mathbb{B}, \mathbb{R}^3)^n$ and $\boldsymbol{\psi} := (\boldsymbol{\psi}^1, \dots, \boldsymbol{\psi}^n)^T \in C_c^m(\mathbb{B}, \mathbb{R}^3)^n$ with $\boldsymbol{\phi}^i := (\phi_1^i, \phi_2^i, \phi_3^i)^T \in C_c^m(\mathbb{B}, \mathbb{R}^3)$ and $\boldsymbol{\psi}^i := (\psi_1^i, \psi_2^i, \psi_3^i) \in C_c^m(\mathbb{B}, \mathbb{R}^3)$, we define the deformation fiber bundle:

We define $\mathcal{Q}^{n,m}$ as being the open subset of $(\mathbf{Q}, \phi) \in (SO(3) \times \mathbb{R}^3)^n \times C_c^m(\mathbb{B}, \mathbb{R}^3)^n$ for which any body do not touch or overlap another body or the boundary of the fluid region. The connected component set of $\mathcal{Q}^{n,m}$ containing the pair $(\mathbf{Q}_0, \mathbf{\Phi}_0)$ in which:

$$\begin{aligned} \mathbf{F}^{F/d}(t,\mathbf{q}) &:= \int_{\Gamma_2(t,\mathbf{q})} \rho_F \Big((\dot{\mathbf{v}}^d \cdot \mathbf{n}) \boldsymbol{\varphi}^r + \boldsymbol{\varphi}^d \mathbf{A} \Big) \, \mathrm{d}\Gamma_x + \frac{1}{2} \int_{\Gamma_1} \rho_F |\nabla \boldsymbol{\varphi}^d|^2 [W^r]^T \mathbf{n} \, \mathrm{d}\Gamma_x \\ &+ 2 \int_{\Gamma_2(t,\mathbf{q})} \rho_F (\mathbf{v}^d \cdot \mathbf{n})^2 [W^r]^T \mathbf{n} \, \mathrm{d}\Gamma_x - 2 \int_{\Gamma_2(t,\mathbf{q})} \rho_F \mathcal{H}(\mathbf{v}^d \cdot \mathbf{n}) \boldsymbol{\varphi}^d [W^r]^T \mathbf{n} \, \mathrm{d}\Gamma_x \\ &- \int_{\Gamma_2(t,\mathbf{q})} \rho_F \Big(2\mathcal{H}(\mathbf{v}^d \cdot \mathbf{n})^2 - \Pi_2(\mathbf{v}_\Gamma^d, \mathbf{v}_\Gamma^d) + 2\nabla_\Gamma(\mathbf{v}^d \cdot \mathbf{n}) \cdot \mathbf{v}^d \Big) \boldsymbol{\varphi}^r \, \mathrm{d}\Gamma_x \\ &- \int_{\Gamma_2(t,\mathbf{q})} \rho_F(\mathbf{v}^d \cdot \mathbf{n}) [D \boldsymbol{\varphi}^r] (\nabla \boldsymbol{\varphi}^d)^T \, \mathrm{d}\Gamma_x, \quad (A.7a) \end{aligned}$$

where $\Pi_2((t, \mathbf{q}, \mathbf{x}), \mathbf{v}_{\Gamma}^d, \mathbf{v}_{\Gamma}^d) = -\kappa_1 (\mathbf{v}^d \cdot \boldsymbol{\tau}_1)^2 - \kappa_2 (\mathbf{v}^d \cdot \boldsymbol{\tau}_2)^2$ and

$$\mathbf{F}^{b}(t,\mathbf{q}) := -\int_{S(t,\mathbf{q})} (\rho_{S}(\mathbf{x}) - \rho_{F}) g[W^{r}]^{T} \mathbf{e}_{3} \,\mathrm{d}\mathbf{x}.$$
 (A.7b)

Observe that $F_i^b(t, \mathbf{q}) = 0$ for i = 4, 5 and, taking into account (2.6) and (2.7), $F_6^b(t, \mathbf{q}) = (m - \rho_F \operatorname{vol}(S_0))g$, where $\operatorname{vol}(S_0)$ is the volume of the swimmer and g the gravitational constant.

A.5 Proofs of the Propositions and Lemmas

Proof of Proposition 4.2: We use the notations introduced in Section A.2. For all $\phi \in C_c^m(\mathbb{B}, \mathbb{R}^3)$ we recall that $\Phi := [\mathbb{I}_3] + \phi$ and $\Phi \in C^{m,\infty}(\mathbb{R}^3, \mathbb{R}^3)$. If $\phi \in C_c^1(\mathbb{B}, \mathbb{R}^3)$ is such that $\|\phi\|_{1,\infty} < 1$, the matrix

$$[A(\boldsymbol{\phi}, \cdot)] := [D\boldsymbol{\Phi}]^{-1} [D\boldsymbol{\Phi}]^{-1\top} |\det([D\boldsymbol{\Phi}])|,$$

is well defined and lies in $C^{0,\infty}(\mathbb{R}^3,\mathbb{R}^3)^3$. Furthermore the mapping

$$\boldsymbol{\phi} \in C_c^1(\mathbb{B}, \mathbb{R}^3) \mapsto [A(\boldsymbol{\phi})] \in C^{0,\infty}(\mathbb{R}^3, \mathbb{R}^3)^3$$

is analytic in a neighborhood of $\phi = 0_3$. We deduce that the set:

$$\mathcal{E}^m := \{ \phi \in C_c^m(\mathbb{B}, \mathbb{R}^3) : \|\phi\|_{1,\infty} < 1, \|[A(\phi)] - [\mathbb{I}_3]\|_{0,\infty,3} < 1/2 \},\$$

is an open subset of $C_c^m(\mathbb{B}, \mathbb{R}^3)$ and we denote $\mathcal{T}^m := \mathcal{E}^m \times E$.

Let now φ be a function of $H^1_N(\Omega)$ and define for all $\phi \in \mathcal{E}^m$ the function $\widetilde{\varphi}(\phi, \cdot) := \varphi(\Phi^{-1}(\cdot))$. Simple computations yield $\nabla \widetilde{\varphi} = \nabla \varphi(\Phi^{-1})[D\Phi(\Phi^{-1})]^{-1}$ and hence, upon a change of variables:

$$\int_{\Omega(\boldsymbol{\phi})} |\nabla \widetilde{\varphi}|^2 \, \mathrm{d}\mathbf{x} = \int_{\Omega} \nabla \varphi[A(\boldsymbol{\phi})] \nabla \varphi^T \, \mathrm{d}\mathbf{x}.$$

According to the definition of \mathcal{E}^m , $\tilde{\varphi}(\phi) \in H^1_N(\Omega(\phi))$ for all $\phi \in \mathcal{E}^1$. The variational formulation (4.2) can be rewritten with the test function $\tilde{\varphi}(\phi)$ and we get, upon a change of variables:

$$\int_{\Omega} \nabla U_i(\phi, \psi) [A(\phi)] \nabla \varphi^T \, \mathrm{d}\mathbf{x} = \int_{\Gamma_2} \mathcal{B}_i(\phi, \psi) \varphi \, \mathrm{d}\Gamma_x.$$
(A.8)

We then define the mappings:

$$\begin{split} F_i^1 &: \mathcal{T}^1 \times H_N^1(\Omega) \to H_N^1(\Omega)' \\ & (\phi, \psi, U) \mapsto \langle [A(\phi)], U, \cdot \rangle - \langle \mathcal{B}_i(\phi, \psi), \cdot \rangle, \end{split}$$

where:

$$\langle [A(\boldsymbol{\phi})], U, \varphi \rangle := \int_{\Omega} \nabla U[A(\boldsymbol{\phi})] \nabla \varphi^T \, \mathrm{d}\mathbf{x}, \ \forall \, U, \varphi \in H^1_N(\Omega), \\ \langle \mathcal{B}_i(\boldsymbol{\phi}, \boldsymbol{\psi}), \varphi \rangle := \int_{\Gamma_2} \mathcal{B}_i(\boldsymbol{\phi}, \boldsymbol{\psi}) \varphi \, \mathrm{d}\Gamma_x, \quad \forall \, \varphi \in H^1_N(\Omega).$$

On the one hand, the mapping $\phi \in \mathcal{E}^1 \mapsto \operatorname{Jac}_{\Gamma}(\phi) \in L^{\infty}(\Gamma_2)$ is analytic and by hypothesis, $(\phi, \psi) \in \mathcal{T}^1 \mapsto B_i(\phi, \psi) \in L^2(\Gamma_2)$ is of class C^k (respectively analytic). Hence $(\phi, \psi) \in \mathcal{T}^1 \mapsto \mathcal{B}_i(\phi) \in L^2_N(\Gamma_2)$ and then $(\phi, \psi) \in \mathcal{T}^1 \mapsto \langle \mathcal{B}_i(\phi), \cdot \rangle \in H^1_N(\Omega)'$ are also of class C^k (respectively analytic). On the other hand, $\phi \in \mathcal{E}^1 \mapsto [A(\phi)] \in C^{0,\infty}(\mathbb{R}^3, \mathbb{R}^3)^3$ is analytic. We deduce that F_i^1 is of class C^k (respectively analytic). We remark furthermore that for all $\psi \in E$, $F_i^1([\mathbb{O}_3], \psi, u_i([\mathbb{O}_3], \psi)) = 0$ and $\partial_U F_i^1([\mathbb{O}_3], \psi, u_i([\mathbb{O}_3], \psi))$ is an isomorphism from $H^1_N(\Omega)$ onto $H^1_N(\Omega)'$ according to the Riesz representation theorem, since we have:

$$\langle \partial_U F_i^1([\mathbb{O}_3], \boldsymbol{\psi}, u_i([\mathbb{O}_3], \boldsymbol{\psi})), U, \varphi \rangle = \int_{\Omega} \nabla U \cdot \nabla \varphi \, \mathrm{d}\mathbf{x}, \quad \forall U, \varphi \in H_N^1(\Omega).$$

The implicit function theorem (we refer to (3.1.10), (3.1.11) and remark below, page 115 of [5] for the classical one and to (3.3.2) page 134 for the analytic version) applies and allows us to conclude that there exists a neighborhood $\tilde{\mathcal{T}}^1$ of $\{[\mathbb{O}_3]\} \times E$ in \mathcal{T}^1 and a C^k -function (respectively analytic) $(\phi, \psi) \in \tilde{\mathcal{T}}^1 \mapsto \tilde{U}_i(\phi, \psi) \in H^1_N(\Omega)$ such that $F_i^1(\phi, \psi, \tilde{U}_i(\phi, \psi)) = 0$ for all $(\phi, \psi) \in \tilde{\mathcal{T}}^1$. By uniqueness of the solution of (4.2) in $H^1_N(\Omega(\phi))$, we deduce that $\tilde{U}_i(\phi, \psi, \cdot) = U_i(\phi, \psi, \cdot) = u_i(\phi, \psi, \Phi(\cdot))$. Proceeding as in (A.8), we rewrite $J(\phi, \psi)$ under the form:

$$J(\boldsymbol{\phi}, \boldsymbol{\psi}) = \int_{\Omega} \nabla U_1(\boldsymbol{\phi}, \boldsymbol{\psi}) [A(\boldsymbol{\phi})] \nabla U_2(\boldsymbol{\phi}, \boldsymbol{\psi})^T \, \mathrm{d}\mathbf{x}.$$

Since $(\phi, \psi) \in \widetilde{\mathcal{T}}^1 \mapsto U_i(\phi, \psi) \in H^1_N(\Omega)$ is of class C^k (respectively analytic) and $\phi \in \widetilde{\mathcal{E}}^1 \mapsto [A(\phi)] \in C^{0,\infty}(\mathbb{R}^3, \mathbb{R}^3)^3$ is analytic, we deduce that $(\phi, \psi) \in \widetilde{\mathcal{T}}^1 \mapsto J(\phi, \psi) \in \mathbb{R}$ is also of class C^k (respectively analytic).

Assume now that $\partial\Omega$ is of class $C^{1,1}$ and that $B_i(\phi, \psi)$ is like in the hypothesis of the second part of the proposition. We define the space \mathcal{H} when Ω is not bounded by:

$$\mathcal{H} := L_N^2(\Omega) \times H^{1/2}(\Gamma_2),$$

and this definition turns into:

$$\mathcal{H} := \Big\{ (U, B) \in L^2(\Omega) \times H^{1/2}(\Gamma_2) : \int_{\Omega} U \, \mathrm{d}\mathbf{x} + \int_{\Gamma_2} B \, \mathrm{d}\Gamma_x = 0 \Big\},$$

when Ω is bounded. We introduce for i = 1, 2, the functions:

$$\begin{split} F_i^2 : \mathcal{T}^2 \times H_N^2(\Omega) &\to \mathcal{H} \\ (\phi, \psi, U) &\mapsto (-\text{div}([A(\phi)]\nabla U), \nabla U|_{\Gamma_2}[A(\phi)]\mathbf{n} - \mathcal{B}_i(\phi, \psi)). \end{split}$$

The same arguments we used for F_i^1 allow to prove that F_i^2 is continuously differentiable. Moreover, for all $\psi \in E$, $F_i^2([\mathbb{O}_3], \psi, u_i([\mathbb{O}_3], \psi)) = 0$ and

$$\langle \partial_U F_i^2([\mathbb{O}_3], \psi, u_i([\mathbb{O}_3], \psi)), U \rangle = (-\Delta U, \partial_\mathbf{n} U), \quad \forall U \in H^2_N(\Omega).$$

Classical results for the Neumann boundary value problem (see [2], [1] and [7] for the less classical case where Ω not bounded) ensure that $\partial_U F_i^2([\mathbb{O}_3], \psi, u_i([\mathbb{O}_3], \psi))$ is an isomorphism from $H_N^2(\Omega)$ onto \mathcal{H} . Applying the implicit function theorem, we conclude that there exists a neighborhood $\tilde{\mathcal{T}}^2$ of $\{[\mathbb{O}_3]\} \times E$ in \mathcal{T}^2 and a continuously differentiable function $(\phi, \psi) \in \tilde{\mathcal{T}}^2 \mapsto \tilde{U}_i(\phi, \psi) \in H_N^2(\Omega)$ such that $F_i^2(\phi, \psi, \tilde{U}_i(\phi, \psi)) = 0$ for all $(\phi, \psi) \in \tilde{\mathcal{T}}^2$. By uniqueness of the solution of the Neumann problem in $H_N^2(\Omega(\phi))$ we necessarily have $\tilde{U}_i(\phi, \psi, \cdot) = U_i(\phi, \psi, \cdot) =$ $u_i(\phi, \psi, \Phi(\cdot))$.

Let K now be a compact set in Ω and $\zeta_K \in C_c^{\infty}(\mathbb{R}^3, \mathbb{R})$ such that $\operatorname{supp}(\zeta_K) \subset \Omega$ and $\zeta_K \equiv 1$ in a neighborhood of K. We can assume that for all $(\phi, \psi) \in \widetilde{T}^1$, we have $\Phi^{-1}(\operatorname{supp} \zeta_K) \subset \Omega$. We define, for all $\mathbf{x} \in \mathbb{R}^3$:

$$U_i^*(\boldsymbol{\phi}, \boldsymbol{\psi}, \mathbf{x}) := \begin{cases} U_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \mathbf{x}) \zeta_K(\boldsymbol{\Phi}(\mathbf{x})) & \text{if } \mathbf{x} \in \boldsymbol{\Phi}^{-1}(\text{supp } \zeta_K), \\ 0 & \text{if } \mathbf{x} \notin \boldsymbol{\Phi}^{-1}(\text{supp } \zeta_K). \end{cases}$$

The mapping $\widetilde{\zeta}_K : \phi \in C_c^1(\mathbb{B}, \mathbb{R}^3) \mapsto \zeta_K(\Phi) \in L^\infty(\mathbb{R}^3)$ is continuously differentiable, the differential being given by:

$$\langle \partial_{\boldsymbol{\phi}} \zeta_K(\boldsymbol{\phi}), \boldsymbol{\xi} \rangle = \nabla \zeta_K(\boldsymbol{\Phi}) \cdot \boldsymbol{\xi}, \quad \forall \, \boldsymbol{\xi} \in C_c^1(\mathbb{B}, \mathbb{R}^3).$$

Indeed, we have:

$$\zeta_K(\boldsymbol{\Phi}(\mathbf{x}) + \boldsymbol{\xi}(\mathbf{x})) - \zeta_K(\boldsymbol{\Phi}(\mathbf{x})) - \nabla\zeta_K(\boldsymbol{\Phi}(\mathbf{x})) \cdot \boldsymbol{\xi}(\mathbf{x}) = \boldsymbol{\xi}(\mathbf{x}) \cdot [r(\boldsymbol{\Phi}(\mathbf{x}), \boldsymbol{\xi}(\mathbf{x}))] \boldsymbol{\xi}(\mathbf{x}),$$

where $[r(\mathbf{\Phi}(\mathbf{x}), \mathbf{y})] := \int_0^1 (1-s) [D^2 \zeta_K(\mathbf{\Phi}(\mathbf{x}) + s\mathbf{y})] \,\mathrm{ds.}$ Extending the functions $\boldsymbol{\phi}$ and $\boldsymbol{\xi}$ by $\mathbf{0}_3$ in $\mathbb{R}^3 \setminus \mathbb{B}$, the conclusion arises by remarking that:

$$\sup_{(\mathbf{x},\mathbf{y})\in\mathbb{R}^3\times\bar{B}(0,1)} \|[r(\boldsymbol{\Phi}(\mathbf{x}),\mathbf{y})]\|_{0,\infty,3} = \sup_{(\mathbf{x},\mathbf{y})\in(\bar{\mathbb{B}}\cup K)\times\bar{B}(0,1)} \|[r(\boldsymbol{\Phi}(\mathbf{x}),\mathbf{y})]\|_{0,\infty,3} < \infty.$$

Since $(\phi, \psi) \in \widetilde{\mathcal{T}}^1 \mapsto U_i(\phi, \psi) \in H^1_N(\Omega)$ is also continuously differentiable, we deduce that $(\phi, \psi) \in \widetilde{\mathcal{T}}^1 \mapsto U^*(\phi, \psi) \in L^2(\mathbb{R}^3)$ has the same regularity. We have

$$\langle \partial_{\boldsymbol{\phi}} U_i^*(\boldsymbol{\phi}, \boldsymbol{\psi}), \boldsymbol{\xi} \rangle = U_i(\boldsymbol{\phi}, \boldsymbol{\psi}) \nabla \zeta_K(\boldsymbol{\Phi}) \cdot \boldsymbol{\xi} + \zeta_K(\boldsymbol{\Phi}) \langle \partial_{\boldsymbol{\phi}} U_i(\boldsymbol{\phi}, \boldsymbol{\psi}), \boldsymbol{\xi} \rangle, \quad \forall \boldsymbol{\xi} \in C_c^1(\mathbb{B}, \mathbb{R}^3),$$

and then $\langle \partial_{\phi} U^*(\phi, \psi), \xi \rangle \in H^1(\mathbb{R}^3)$. Remark that:

$$\langle \partial_{\boldsymbol{\phi}} U_i^*(\boldsymbol{\phi}, \boldsymbol{\psi}, \boldsymbol{\Phi}^{-1}(\cdot)) |_K, \boldsymbol{\xi} \rangle = \langle \partial_{\boldsymbol{\phi}} U_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \boldsymbol{\Phi}^{-1}(\cdot)) |_K, \boldsymbol{\xi} \rangle, \quad \forall (\boldsymbol{\phi}, \boldsymbol{\psi}) \in \widetilde{\mathcal{T}}^1.$$

Applying [18, Lemma 5.3.3 page 181] to the function $u_i^*(\phi, \psi, \cdot) = U_i^*(\phi, \psi, \Phi^{-1}(\cdot))$, we obtain that $(\phi, \psi) \in \widetilde{\mathcal{T}}^1 \mapsto u_i^*(\phi, \psi) \in L^2(\mathbb{R}^3)$ is continuously differentiable and that:

$$\langle \partial_{\boldsymbol{\phi}} u_i^*(\boldsymbol{\phi}, \boldsymbol{\psi}), \boldsymbol{\xi} \rangle = \langle \partial_{\boldsymbol{\phi}} U_i^*(\boldsymbol{\phi}, \boldsymbol{\psi}, \boldsymbol{\Phi}^{-1}(\cdot)), \boldsymbol{\xi} \rangle - \nabla U_i^*(\boldsymbol{\phi}, \boldsymbol{\psi}, \boldsymbol{\Phi}^{-1}(\cdot)) \cdot \boldsymbol{\xi}, \quad \forall \, \boldsymbol{\xi} \in C_c^1(\mathbb{B}, \mathbb{R}^3)$$

We define the function $\partial_{\phi} u_i([\mathbb{O}_3], \psi)$ in the whole set Ω by its restriction to any compact subset K of Ω :

$$\langle \partial_{\phi} u_i([\mathbb{O}_3], \psi) |_K, \boldsymbol{\xi} \rangle := \langle \partial_{\phi} u^*([\mathbb{O}_3], \psi) |_K, \boldsymbol{\xi} \rangle, \quad \forall \, \boldsymbol{\xi} \in C^1_c(\mathbb{B}, \mathbb{R}^3), \ \forall \, \boldsymbol{\psi} \in E.$$

We obtain therefore the following identity for all $\boldsymbol{\xi} \in C_c^1(\mathbb{B}, \mathbb{R}^3)$ and for all $\boldsymbol{\psi} \in E$:

$$\langle \partial_{\boldsymbol{\phi}} u_i([\mathbb{O}_3], \boldsymbol{\psi}), \boldsymbol{\xi} \rangle = \langle \partial_{\boldsymbol{\phi}} U_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \boldsymbol{\Phi}^{-1}(\cdot)) |_{\boldsymbol{\phi} = [\mathbb{O}_3]}, \boldsymbol{\xi} \rangle - \nabla U_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \boldsymbol{\Phi}^{-1}(\cdot)) |_{\boldsymbol{\phi} = [\mathbb{O}_3]} \cdot \boldsymbol{\xi}.$$

Since $(\phi, \psi) \in \widetilde{\mathcal{T}}^1 \mapsto U_i(\phi, \psi) \in H^1_N(\Omega)$ is differentiable, we obtain that

$$\langle \partial_{\boldsymbol{\phi}} U_i(\boldsymbol{\phi}, \boldsymbol{\psi}, \boldsymbol{\Phi}^{-1}(\cdot)), \boldsymbol{\xi} \rangle \in H^1_N(\Omega(\boldsymbol{\phi})),$$

and since $U_i(\phi, \psi) \in H^2_N(\Omega)$ if $(\phi, \psi) \in \widetilde{\mathcal{T}}^2$, we obtain that $\partial_{x_j} U_i(\phi, \psi, \Phi^{-1}(\cdot)) \in H^1_N(\Omega(\phi))$ for all j = 1, 2, 3. We deduce that:

$$\langle \partial_{\boldsymbol{\phi}} u_i([\mathbb{O}_3], \boldsymbol{\psi}), \boldsymbol{\xi} \rangle \in H^1_N(\Omega), \quad \forall \boldsymbol{\xi} \in C^1_c(\mathbb{B}, \mathbb{R}^3), \ \forall \boldsymbol{\psi} \in E.$$

We proceed as well to define $\partial_{\phi}(\partial_{x_j}u_i(\phi, \psi))$, taking into account that $(\phi, \psi) \in \widetilde{T}^2 \mapsto U_i(\phi, \psi) \in H^2_N(\Omega)$ is continuously differentiable.

Proof of Proposition 4.3: The domain Ω being of class $C^{1,1}$, we can extend any function $\varphi \in H^2_N(\Omega(t))$ to be a function of $H^2_N(\mathbb{R}^3)$. Reciprocally, for any function φ in $H^2_N(\mathbb{R}^3)$, $\varphi|_{\Omega(t)}$ lies in $H^2_N(\Omega(t))$. Choosing such a test function in (4.2), we compute the derivative with respect to t of the variational formulation:

$$\int_{\Omega(t)} \nabla u_i(t) \cdot \nabla \varphi \, \mathrm{d}\mathbf{x} = \int_{\Gamma_2} \mathcal{B}_i(t) \varphi(\mathbf{\Phi}(t)) \, \mathrm{d}\Gamma_x.$$

Applying [18, Corollary 5.2.5, page 173], we obtain that:

$$\int_{\Omega(t)} \partial_t \nabla u_i(t) \cdot \nabla \varphi \, \mathrm{d}\mathbf{x} + \int_{\Gamma_2(t)} (\nabla u_i(t) \cdot \nabla \varphi) (\mathbf{v}(t) \cdot \mathbf{n}) \, \mathrm{d}\Gamma_x$$
$$= \frac{d}{dt} \left(\int_{\Gamma_2} \mathcal{B}_i(t) \varphi(\mathbf{\Phi}(t)) \, \mathrm{d}\Gamma_x \right). \quad (A.9)$$

As already mentioned earlier in we can extend any function $\phi \in C_c^m(\mathbb{B}, \mathbb{R}^3)$ to be a function of $C_c^{m,\infty}(\mathbb{R}^3, \mathbb{R}^3)$. Since $\varphi \in H^2_N(\mathbb{R}^3)$, [18, Lemma 5.3.3 page 181] ensures that $\tilde{\varphi} : t \in \mathbb{R} \mapsto \varphi(\mathbf{\Phi}(t)) \in H^1_N(\mathbb{R}^3)$ is differentiable and that:

$$\partial_t \widetilde{\varphi}(t) = \nabla \varphi(\mathbf{\Phi}(t)) \cdot \mathbf{v}(t) \in H^1_N(\mathbb{R}^3).$$

In particular, $\partial_t \widetilde{\varphi}(t) \in H^{1/2}(\Gamma_2)$ and we have:

$$\frac{d}{dt} \left(\int_{\Gamma_2} \mathcal{B}_i(t) \varphi(\mathbf{\Phi}(t)) \, \mathrm{d}\Gamma_x \right) = \int_{\Gamma_2} \partial_t \mathcal{B}_i(t) \varphi(\mathbf{\Phi}(t)) + \mathcal{B}_i(t) \nabla \varphi(\mathbf{\Phi}(t)) \cdot \mathbf{v}(t) \, \mathrm{d}\Gamma_x.$$

We recall that $\mathcal{B}_i(t) := B_i(t) \operatorname{Jac}_{\Gamma}(\Phi(t))$ and $B_i(t) := b_i(t, \Phi(t))$. Hence, according to [18, Lemma 5.4.15 page 199], we get:

$$\partial_t \mathcal{B}_i(t) = (\partial_t B_i(t) + b_i(t, \mathbf{\Phi}(t)) \operatorname{div}_{\Gamma}(\mathbf{v}(t, \mathbf{\Phi}(t)))) \operatorname{Jac}_{\Gamma}(\mathbf{\Phi}(t)).$$

Plugging this expression into (A.9) we obtain on the one hand the variational formulation for $\partial_t \nabla u_i(t)$:

$$\int_{\Omega(t)} \partial_t \nabla u_i(t) \cdot \nabla \varphi \, \mathrm{d}\mathbf{x} + \int_{\Gamma_2(t)} (\nabla u_i(t) \cdot \nabla \varphi) (\mathbf{v} \cdot \mathbf{n}) \, \mathrm{d}\Gamma_x =
\int_{\Gamma_2(t)} \partial_t B_i(t, \mathbf{\Phi}^{-1}(t)) \varphi + b_i(t) \varphi \operatorname{div}_{\Gamma}(\mathbf{v}(t)) \, \mathrm{d}\Gamma_x
+ \int_{\Gamma_2(t)} b_i(t) \nabla \varphi \cdot \mathbf{v}(t) \, \mathrm{d}\Gamma_x, \quad \forall \varphi \in H^2_N(\Omega(t)). \quad (A.10)$$

On the other hand, applying [18, Theorem 5.2.2 page 172], we compute the derivative of J(t) as follows:

$$\begin{aligned} \frac{dJ}{dt}(t) &= \int_{\Omega(t)} \partial_t \nabla u_1(t) \cdot \nabla u_2(t) + \nabla u_1(t) \cdot \partial_t \nabla u_2(t) \, \mathrm{d}\Gamma_x \\ &+ \int_{\Gamma_2(t)} \nabla u_1(t) \cdot \nabla u_2(t) (\mathbf{v}(t) \cdot \mathbf{n}) \, \mathrm{d}\Gamma_x. \end{aligned}$$

Since $u_1(t)$ and $u_2(t)$ lie in $H^2_N(\Omega(t))$, we can use the identity (A.10) in order to transform both right hand side terms. Since $\mathcal{B}_i(t) := b_i(t, \Phi(t)) \operatorname{Jac}_{\Gamma}(\Phi(t))$, we get:

$$\frac{dJ}{dt}(t) = -\int_{\Gamma_2(t)} \nabla u_1(t) \cdot \nabla u_2(t)(\mathbf{v}(t) \cdot \mathbf{n}) \, d\Gamma_x
+ \int_{\Gamma_2(t)} \partial_t B_1(t, \mathbf{\Phi}^{-1}(t)) u_2(t) + u_1(t) \partial_t B_2(t, \mathbf{\Phi}^{-1}(t)) \, d\Gamma_x
+ \int_{\Gamma_2(t)} (b_1(t) u_2(t) + u_1(t) b_2(t)) \, \operatorname{div}_{\Gamma}(\mathbf{v}(t)) \, d\mathbf{x}
+ \int_{\Gamma_2(t)} b_1(t) \nabla u_2(t) \cdot \mathbf{v}(t) + b_2(t) \nabla u_1(t) \cdot \mathbf{v}(t) \, d\Gamma_x. \quad (A.11)$$

Then, decomposing $\mathbf{v}(t)$ into its normal and tangential part on Γ_2 , namely $\mathbf{v}(t) = (\mathbf{v}(t) \cdot \mathbf{n})\mathbf{n} + \mathbf{v}_{\Gamma}(t)$, we obtain that:

$$\nabla u_i(t) \cdot \mathbf{v}(t) = \partial_{\mathbf{n}} u_i(t) (\mathbf{v}(t) \cdot \mathbf{n}) + \nabla_{\Gamma} u_i(t) \cdot \mathbf{v}_{\Gamma}(t)$$
$$= b_i(t) (\mathbf{v}(t) \cdot \mathbf{n}) + \nabla_{\Gamma} u_i(t) \cdot \mathbf{v}_{\Gamma}(t), \qquad (A.12)$$

where ∇_{Γ} stands for the tangential gradient. Using some results of differential geometry (see [18] pages 192-197), we get:

$$b_1(t)\nabla_{\Gamma}u_2(t)\cdot\mathbf{v}_{\Gamma}(t) = \operatorname{div}_{\Gamma}(b_1(t)u_2(t)\mathbf{v}_{\Gamma}(t)) - u_2(t)\nabla_{\Gamma}b_1(t)\cdot\mathbf{v}_{\Gamma}(t) - b_1(t)u_2(t)\operatorname{div}_{\Gamma}(\mathbf{v}(t)) - (\kappa_1 + \kappa_2)b_1(t)u_2(t)\mathbf{v}(t)\cdot\mathbf{n}, \quad (A.13)$$

where κ_1 and κ_2 are the principal curvatures of $\Gamma_2(t)$. In particular div_{Γ}(**n**) = $-(\kappa_1 + \kappa_2)$. Summarizing (A.11), (A.12) and (A.13), we obtain formula (4.3) of the proposition.

Proof of Proposition 5.1: The surface Γ being Lipschitz continuous, there exists \mathbf{x} -almost everywhere a tangent plane and then also a unitary normal vector $\mathbf{n}(\mathbf{x})$. For each tangent plane, we can consider an orthogonal basis $\{\boldsymbol{\tau}_1(\mathbf{x}), \boldsymbol{\tau}_2(\mathbf{x})\}$ in such a way that $\{\mathbf{n}(\mathbf{x}), \boldsymbol{\tau}_1(\mathbf{x}), \boldsymbol{\tau}_2(\mathbf{x})\}$ be a direct orthogonal basis of \mathbb{R}^3 . We denote $\boldsymbol{\tau}_i(\boldsymbol{\Phi}, \mathbf{x}) := [D \boldsymbol{\Phi}(\boldsymbol{\Phi}^{-1}(\mathbf{x}))] \boldsymbol{\tau}_i(\boldsymbol{\Phi}^{-1}(\mathbf{x})), i = 1, 2$ for almost every \mathbf{x} on $\boldsymbol{\Phi}(\Gamma)$.

Since Φ is a C^1 -isomorphism we deduce that $\{\tau_1(\Phi, \mathbf{x}), \tau_2(\Phi, \mathbf{x})\}$ is a basis of the tangent plane to $\Phi(\Gamma)$ at the point \mathbf{x} . Therefore:

$$\mathbf{n}(\mathbf{\Phi},\mathbf{x}) := rac{oldsymbol{ au}_1(\mathbf{\Phi},\mathbf{x})\wedgeoldsymbol{ au}_2(\mathbf{\Phi},\mathbf{x})}{|oldsymbol{ au}_1(\mathbf{\Phi},\mathbf{x})\wedgeoldsymbol{ au}_2(\mathbf{\Phi},\mathbf{x})|},$$

is well defined \mathbf{x} -a.e. on $\mathbf{\Phi}(\Gamma)$ and satisfies $\mathbf{n}([\mathbb{I}_3], \mathbf{x}) = \mathbf{n}(\mathbf{x}), \mathbf{x}$ -a. e. on Γ . Consider now the mapping:

$$([R], [A]) \in SO(3) \times \mathcal{M}(3) \mapsto \widetilde{\mathbf{N}}([R], [A]) = \frac{([\mathbb{I}_3] + [A])[R]\mathbf{e}_1 \wedge ([\mathbb{I}_3] + [A])[R]\mathbf{e}_2}{|([\mathbb{I}_3] + [A])[R]\mathbf{e}_1 \wedge ([\mathbb{I}_3] + [A])[R]\mathbf{e}_2}$$

For all $[R] \in SO(3)$, the function $[A] \in \mathcal{M}(3) \mapsto \widetilde{\mathbf{N}}([R], [A])$ is analytic whenever |[A]| < 1, i.e. the convergence radius of the Taylor series of this function at the point $[A] = [\mathbb{O}_3]$ is equal to 1 and the sum coincides with $\widetilde{\mathbf{N}}([R], [A])$. Furthermore, it is worth noting that the convergence of the series is uniform with respect to $[R] \in SO(3)$. This assertion derives from the equality $\widetilde{\mathbf{N}}([R], [A]) =$ $[R]\widetilde{\mathbf{N}}([\mathbb{I}_3], [R]^T[A][R])$ and the compactness of SO(3). For a.e. \mathbf{x} on Γ , we denote $[R(\mathbf{x})]$ the matrix of SO(3) for which $[R(\mathbf{x})]\mathbf{e}_i = \boldsymbol{\tau}_i(\mathbf{x}), i = 1, 2$ and we have: $\mathbf{N}(\mathbf{\Phi}, \mathbf{x}) = \widetilde{\mathbf{N}}([R(\mathbf{x})], [D\mathbf{\Phi}(\mathbf{x})] - [\mathbb{I}_3])$. We deduce that the mapping:

$$\mathbf{\Phi} \in C^{1,\infty}_{inv}(\mathbb{R}^3,\mathbb{R}^3) \mapsto \mathbf{N}(\mathbf{\Phi}) \in L^{\infty}(\Gamma),$$

is analytic.

Straightforward computations yield:

$$\mathbf{N}(\boldsymbol{\Phi} + \boldsymbol{\xi}, \boldsymbol{\Phi}^{-1}) = \mathbf{n}(\boldsymbol{\Phi}) + [D(\boldsymbol{\xi} \circ \boldsymbol{\Phi}^{-1})]\boldsymbol{\tau}_1(\boldsymbol{\Phi}) \wedge \boldsymbol{\tau}_2(\boldsymbol{\Phi}) + \boldsymbol{\tau}_1(\boldsymbol{\Phi}) \wedge [D(\boldsymbol{\xi} \circ \boldsymbol{\Phi}^{-1})]\boldsymbol{\tau}_2(\boldsymbol{\Phi}) - \mathbf{n}(\boldsymbol{\Phi}) \Big([D(\boldsymbol{\xi} \circ \boldsymbol{\Phi}^{-1})]\boldsymbol{\tau}_1(\boldsymbol{\Phi}) \wedge \boldsymbol{\tau}_2(\boldsymbol{\Phi}) + \boldsymbol{\tau}_1(\boldsymbol{\Phi}) \wedge [D(\boldsymbol{\xi} \circ \boldsymbol{\Phi}^{-1})]\boldsymbol{\tau}_2(\boldsymbol{\Phi}) \Big) \cdot \mathbf{n}(\boldsymbol{\Phi}) + \mathcal{O}(\|[D(\boldsymbol{\xi} \circ \boldsymbol{\Phi}^{-1})]\|_{0,\infty,3}^2). \quad (A.14)$$

Formula (5.1) arises after remarking that, for all $[A] \in \mathcal{M}(3)$, $[A]\boldsymbol{\tau}_i = \sum_{k=1}^2 ([A]\boldsymbol{\tau}_i \cdot \boldsymbol{\tau}_k)\boldsymbol{\tau}_k + ([A]\boldsymbol{\tau}_i \cdot \mathbf{n})\mathbf{n}$ and after plugging these expressions with $[A] = [D(\boldsymbol{\xi} \circ \boldsymbol{\Phi}^{-1})]$ into (A.14). Identity (5.2) derives straightforwardly from (5.1). To obtain (5.3) from (5.2), we make use of the following formulas, holding on the $C^{1,1}$ -surface $\boldsymbol{\Phi}(t, \Gamma)$:

$$\nabla_{\Gamma}(\mathbf{v}(t) \cdot \mathbf{n}(t)) \cdot \boldsymbol{\tau}_{k}(t) = [D\mathbf{v}(t)]\boldsymbol{\tau}_{k}(t) \cdot \mathbf{n}(t) + [D\mathbf{n}(t)]\boldsymbol{\tau}_{k}(t) \cdot \mathbf{n}(t),$$
$$[D\mathbf{n}(t)]\boldsymbol{\tau}_{k}(t) = -\kappa_{k}(t)\boldsymbol{\tau}_{k}(t).$$

The proof of the proposition is then complete. \blacksquare

Proof of Lemma 5.2: Forming the scalar product of (5.4) with $\dot{\mathbf{q}}$, we obtain, after simplifications due to symmetry properties:

$$\langle [K^{r}(\mathbf{q},\boldsymbol{\phi})], \ddot{\mathbf{q}}, \dot{\mathbf{q}} \rangle + \frac{1}{2} \langle \partial_{\mathbf{q}} [K^{r}(\mathbf{q},\boldsymbol{\phi})], \dot{\mathbf{q}}, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle + \langle \partial_{\boldsymbol{\phi}} [K^{r}(\mathbf{q},\boldsymbol{\phi})], \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle$$

$$+ \langle \mathbf{K}_{F}^{r,d}(\mathbf{q},\boldsymbol{\phi}), \ddot{\boldsymbol{\phi}}, \dot{\mathbf{q}} \rangle + \langle \partial_{\boldsymbol{\phi}} \mathbf{K}_{F}^{r,d}(\mathbf{q},\boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}} \rangle$$

$$- \frac{1}{2} \langle \partial_{\mathbf{q}} K_{F}^{d}(\mathbf{q},\boldsymbol{\phi}), \dot{\mathbf{q}}, \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle + \langle \partial_{\mathbf{q}} \mathcal{P}(\mathbf{q},\boldsymbol{\phi}), \dot{\mathbf{q}} \rangle = \mathbf{0}_{6n}. \quad (A.15)$$

On the one hand, we remark that:

$$\frac{1}{2}\frac{d}{dt}\langle [K^{r}(\mathbf{q},\boldsymbol{\phi})],\dot{\mathbf{q}},\dot{\mathbf{q}}\rangle = \langle [K^{r}(\mathbf{q},\boldsymbol{\phi})],\ddot{\mathbf{q}},\dot{\mathbf{q}}\rangle + \frac{1}{2}\langle \partial_{\mathbf{q}}[K^{r}(\mathbf{q},\boldsymbol{\phi})],\dot{\mathbf{q}},\dot{\mathbf{q}},\dot{\mathbf{q}}\rangle + \frac{1}{2}\langle \partial_{\boldsymbol{\phi}}[K^{r}(\mathbf{q},\boldsymbol{\phi})],\dot{\boldsymbol{\phi}},\dot{\mathbf{q}},\dot{\mathbf{q}}\rangle.$$
(A.16)

On the other hand, we have:

$$\frac{1}{2}\langle\partial_{\mathbf{q}}K_{F}^{d}(\mathbf{q},\boldsymbol{\phi}),\dot{\mathbf{q}},\dot{\boldsymbol{\phi}},\dot{\boldsymbol{\phi}}\rangle = \frac{1}{2}\frac{d}{dt}\langle K_{F}^{d}(\mathbf{q},\boldsymbol{\phi}),\dot{\boldsymbol{\phi}},\dot{\boldsymbol{\phi}}\rangle - \frac{1}{2}\langle\partial_{\boldsymbol{\phi}}K_{F}^{d}(\mathbf{q},\boldsymbol{\phi}),\dot{\boldsymbol{\phi}},\dot{\boldsymbol{\phi}},\dot{\boldsymbol{\phi}}\rangle - \langle K_{F}^{d}(\mathbf{q},\boldsymbol{\phi}),\ddot{\boldsymbol{\phi}},\dot{\boldsymbol{\phi}}\rangle, \quad (A.17a)$$

and

$$\langle \partial_{\mathbf{q}} \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}), \dot{\mathbf{q}} \rangle = \frac{d}{dt} \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}) - \langle \partial_{\boldsymbol{\phi}} \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle.$$
 (A.17b)

Summarizing (A.15), (A.16) and (A.17), we get:

$$\begin{split} \frac{1}{2} \frac{d}{dt} \langle [K^r(\mathbf{q}, \boldsymbol{\phi})], \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle &+ \frac{1}{2} \langle \partial_{\boldsymbol{\phi}} [K^r(\mathbf{q}, \boldsymbol{\phi})], \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}}, \dot{\mathbf{q}} \rangle \\ &+ \langle \mathbf{K}_F^{r,d}(\mathbf{q}, \boldsymbol{\phi}), \ddot{\boldsymbol{\phi}}, \dot{\mathbf{q}} \rangle + \langle \partial_{\boldsymbol{\phi}} \mathbf{K}_F^{r,d}(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}, \dot{\mathbf{q}} \rangle \\ &= \frac{1}{2} \frac{d}{dt} \langle K_F^d(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle \rangle - \frac{d}{dt} \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}) - \frac{1}{2} \langle \partial_{\boldsymbol{\phi}} K_F^d(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle \\ &- \langle K_F^d(\mathbf{q}, \boldsymbol{\phi}), \ddot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle + \langle \partial_{\boldsymbol{\phi}} \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle . \end{split}$$

With notations (5.5), we deduce from this equality that:

$$\begin{split} \frac{d}{dt} \left(E(\mathbf{q}, \dot{\mathbf{q}}, \boldsymbol{\phi}) e^{-\int_0^t \langle \delta_1(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle d\tau} \right) &\leq \delta_2(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}) \sqrt{E(\mathbf{q}, \dot{\mathbf{q}}, \boldsymbol{\phi})} e^{-\int_0^t \langle \delta_1(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle d\tau} \\ &+ \frac{d}{dt} \left(\left(\frac{1}{2} \langle K_F^d(\mathbf{q}, \boldsymbol{\phi}) \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}}, \rangle - \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}) \right) e^{-\int_0^t \langle \delta_1(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle d\tau} \right) \\ &+ \langle \delta_1(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle \left(\frac{1}{2} \langle K_F^d(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle - \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}) \right) e^{-\int_0^t \langle \delta_1(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle d\tau} \\ &+ \left(-\frac{1}{2} \langle \partial_{\boldsymbol{\phi}} K_F^d(\mathbf{q}, \boldsymbol{\phi}) \dot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle - \langle K_F^d(\mathbf{q}, \boldsymbol{\phi}), \ddot{\boldsymbol{\phi}}, \dot{\boldsymbol{\phi}} \rangle + \langle \partial_{\boldsymbol{\phi}} \mathcal{P}(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle \right) e^{-\int_0^t \langle \delta_1(\mathbf{q}, \boldsymbol{\phi}), \dot{\boldsymbol{\phi}} \rangle d\tau}. \end{split}$$

Then, integrating from 0 to t and using notations (5.6), we get a Bihari-type inequality:

$$E(\mathbf{q}, \dot{\mathbf{q}}, \boldsymbol{\phi}) \leq a^{+}(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}, t) + \int_{0}^{t} k^{+}(\mathbf{q}, \boldsymbol{\phi}, \dot{\boldsymbol{\phi}}, \ddot{\boldsymbol{\phi}}, t, s) \sqrt{E(\mathbf{q}, \dot{\mathbf{q}}, \boldsymbol{\phi})} ds.$$

Estimate (5.7) arises after applying [4, Theorem 5.5 page 47]. \blacksquare
