GLOBAL ADAPTIVE SYNCHRONIZATION BASED UPON POLYTOPIC OBSERVERS

ABSTRACT

A new adaptive synchronization scheme achieving a joint state and parameter estimation is proposed as an alternative to the well-known Extended Kalman Filter based on a first order approximation. It involves a polytopic observer which does no longer require a linearization. The resulting adaptive synchronization is global and holds for a large class of chaotic systems. The computation of the gain of the observer is performed in a systematic way and is derived from the solutions of a Linear Matrix Inequalities set.

1. INTRODUCTION

Synchronization of two systems which neither assumes identical initial conditions nor identical parameters is referred to as adaptive synchronization. Parameter mismatch is a realistic and problematic situation in engineering area while in some communication scheme the mismatch is intentional. Indeed, it is typically the case when a parameter is modulated according to a rule which encodes the information to be transmitted as in chaos shift keying.

When full state is available, an adaptive controller can be designed. In [1], an adaptive approach is proposed in order to track a slowly time-varying parameter of a chaotic system. On the other hand, when only partial state is available from the output of the chaotic system, some adaptive observer-based approaches can be used. The reader can refer to [2][3][4] in the context of chaos synchronization or [5] for a more general automatic control point of view. Besides, many works dealing with synchronization with unknown parameters involve the use of an Extended Kalman Filter (EKF) which achieves a joint state and parameter estimation to handle the problem. See for example [6] for the continuous case or [7] for the discrete case.

Nevertheless, achieving global stability of the adaptive algorithms is a challenging task. For adaptive controllers or observers, the difficulty stems from the fact that the chaotic system must verify some special properties such as nonlinearities with Lipschitz conditions, special structure such as output injection. In this paper, a new joint state and unknown parameters estimation algorithm is proposed as an alternative to the Extended Kalman Filter. The advantage lies in the fact that the observer does no longer requires a first order approximation as it does for the EKF. The convergence analysis is based on the theoretical results stated in [8]. It is shown that the resulting adaptive synchronization is global and holds for a large class of chaotic systems admitting a polytopic description. The computation of the gain of the observer is systematic and is derived from the solutions of a Linear Matrix Inequalities set.

2. POLYTOPIC DESCRIPTION

As a preliminary, this section aims at stating some conditions under which the dynamical matrix A of the general system described by

$$\begin{aligned} \bar{x}_{k+1} &= \mathcal{A}(y_k)\bar{x}_k + E(y_k) \\ y_k &= \bar{C}\bar{x}_k \end{aligned}$$
 (1)

can be rewritten in a polytopic form. $\bar{x}_k \in \Re^q$, $\mathcal{A} \in \Re^{q \times q}$, $\bar{C} \in \Re^{m \times q}$. *E* is a (possible) nonlinear *q*-dimensional function depending on y_k .

Proposition 1 If there exists a function $h : \Re^m \to \Re^L$, defined as $\rho_k = h(y_k)$ with ρ_k being bounded when y_k is bounded, such that $\mathcal{A}(y_k) = \mathcal{A}(\rho_k)$ holds and rendering \mathcal{A} to be of class C^1 with respect to ρ_k , then there always exist some ξ_k^i 's and \overline{A}_i 's such that :

$$\mathcal{A}(\rho_k) = \sum_{i=1}^{N} \xi_k^i(\rho_k) \bar{A}_i \tag{2}$$

with \bar{A}_i 's corresponding to the vertices of the convex hull $\mathbf{Co}\{\bar{A}_1,\ldots,\bar{A}_N\}$, and ξ_k^i 's belonging to the compact set $\mathcal{S} = \{\mu_k \in \Re^N, \mu_k = (\mu_k^1, \ldots, \mu_k^N)^T, \mu_k^i \ge 0 \ \forall i$ and $\sum_{i=1}^N \mu_k^i = 1\}$. \mathcal{A} is said to be expressed in a polytopic form and ρ_k acts as a time-varying parameter for \mathcal{A} . From the definition of the output y_k , ρ_k is clearly on-line available.

Proof

The proof is constructive in the sense that it explicitly provides the ξ_k^i 's and the \bar{A}_i 's. In the proof, the dependence on

 ρ_k of the ξ_k^i 's will be omitted for clarity sake.

Determination of ξ_k^i

On one hand, since A is of class C^1 with respect to the entries of ρ_k , A can be rewritten in the form

$$\mathcal{A}(\rho_k) = A_0 + \sum_{j=1}^{L} \rho_k^{(j)} A_j^{lc}$$
(3)

 A_0 is the matrix derived from $\mathcal{A}(\rho_k)$ by keeping its constant entries while setting to zero its time-varying entries. Let l and c two indices depending on j and corresponding respectively to the position of ρ_k^j in $\mathcal{A}(\rho_k)$. Then, A_j^{lc} is the matrix whose entries are all zero except the one, located at row l and column c, which equals unity.

On the other hand, since ρ_k is bounded, it is constrained to a compact domain which can always be embedded in a polytope and thus verifies :

$$\rho_k = \sum_{i=1}^N \xi_k^i \bar{\rho}_i \quad \text{with} \quad \sum_{i=1}^N \xi_k^i = 1, \ \xi_k^i \ge 0 \quad (4)$$

N corresponds to the number of vertices $\bar{\rho}_i$ of the polytope. Equation (4) can be rewritten in a matrix way

$$\underbrace{\begin{bmatrix} \rho_k^{(1)} \\ \vdots \\ \rho_k^{(j)} \\ \vdots \\ \rho_k^{(L)} \\ 1 \\ \end{bmatrix}}_{E_k} = \underbrace{\begin{bmatrix} \bar{\rho}_1^{(1)} & \dots & \bar{\rho}_i^{(1)} & \dots & \bar{\rho}_N^{(1)} \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \bar{\rho}_1^{(j)} & \dots & \bar{\rho}_i^{(j)} & \dots & \bar{\rho}_N^{(j)} \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \bar{\rho}_1^{(L)} & \dots & \bar{\rho}_i^{(L)} & \dots & \bar{\rho}_N^{(L)} \\ 1 & \dots & 1 & \dots & 1 \\ \end{bmatrix}}_{F} \underbrace{\begin{bmatrix} \xi_k^1 \\ \vdots \\ \xi_k^2 \\ \vdots \\ \xi_k^N \\ \vdots \\ \xi_k^N \\ G_k \end{bmatrix}}_{G_k}$$
(5)

(5) where F is a constant known matrix whose entries $\bar{\rho}_i^{(j)}$ are the components of the vertices $\bar{\rho}_i$. At each discrete-time k, the matrix E_k is known because ρ_k is available. Hence, the matrix G_k (and so the ξ_k^i 's) are given by :

$$G_k = F^+ E_k \tag{6}$$

where F^+ is the pseudo-inverse of F fulfilling the constraint $\xi_k^i \ge 0$.

Determination of $\overline{A_i}$ Substituting (4) into (3) yields :

$$\mathcal{A}(\rho_k) = A_0 + \sum_{j=1}^{L} \left(\sum_{i=1}^{N} \xi_k^i \bar{\rho}_i^{(j)} \right) A_j^{lc}$$
(7)

Since $\sum_{i=1}^{N} \xi_k^i = 1$ and A_0 is constant, $A_0 = \sum_{i=1}^{N} \xi_k^i A_0$. Left factorizing the expression (7) by $\sum_{i=1}^{N} \xi_k^i$ yields :

$$A(\rho_k) = \sum_{i=1}^{N} \xi_k^i \left(\underbrace{A_0 + \sum_{j=1}^{L} \bar{\rho}_i^{(j)} A_j^{lc}}_{\overline{A_i}} \right)$$
(8)

Finally, identifying (8) with (2) gives the matrices $\overline{A_i}$ (i = 1, ..., N)

$$\overline{A_i} = A_0 + \sum_{j=1}^{L} \bar{\rho}_i^{(j)} A_j^{lc} \tag{9}$$

It is worth emphasizing that the description (1)-(2) includes some well-known special systems. Indeed, the case when $\mathcal{A}(y_k) = A$ is a constant dynamical matrix corresponds to a Lur'e system and the case when $\mathcal{A}(y_k) = A_i$, $E(y_k) = E_i$, some constant matrices, corresponds to a piecewise linear system. In next section, it is shown how such a result can be used to complete an adaptive synchronization of chaotic systems.

3. ADAPTIVE SYNCHRONIZATION

We propose an adaptive synchronization scheme with global convergence properties based upon a joint state and parameter estimation via a polytopic observer [8]. In the sequel, the system exhibiting a chaotic motion will be called the transmitter as usual.

3.1. Observer design

The transmitter under consideration is described by the following dynamics:

$$\begin{cases} x_{k+1} = A(y_k)x_k + f(y_k)\theta_k + g(y_k) \\ y_k = Cx_k \end{cases}$$
(10)

with $x_k \in \Re^n$, $y_k \in \Re^m$, f and g two *n*-dimensional functions of y_k . $\theta_k \in \Re^p$ is the unknown parameter vector. Such a parameter has to be estimated and is assumed to be constant over a fixed interval of time. Furthermore, $A(y_k)$ and $f(y_k)$ are assumed to be bounded if y_k is bounded.

By introducing an extended state vector denoted \bar{x}_k composed by the states of the system and the parameter θ_k , that is $\bar{x}_k = [x_k^T \ \theta_k^T]^T$, (10) can be rewritten :

$$\begin{cases} \begin{bmatrix} x_{k+1} \\ \theta_{k+1} \end{bmatrix} = \underbrace{\begin{bmatrix} A(y_k) & f(y_k) \\ \mathbf{0} & \mathbf{1} \end{bmatrix}}_{\mathcal{A}(y_k)} \begin{bmatrix} x_k \\ \theta_k \end{bmatrix} + \begin{bmatrix} g(y_k) \\ \mathbf{0} \end{bmatrix} \\ y_k = \bar{C} \ \bar{x}_k \end{cases}$$
(11)

where $\overline{C} = \begin{bmatrix} C & \mathbf{0} \end{bmatrix}$, **0** and **1** are respectively a null matrix and the identity matrix of compatible size. \mathcal{A} is the dynamical matrix of the augmented system. When (10) exhibits a chaotic motion, all the components of both the state vector x_k and the output y_k are bounded. Furthermore, since $A(y_k)$ and $f(y_k)$ are assumed to be bounded if y_k is bounded, it is always easy to check for a function h such

that $\mathcal{A}(y_k) = \mathcal{A}(\rho_k)$ with $\rho_k = h(y_k)$ and such that \mathcal{A} is of class C^1 with respect to ρ_k . Thus, according to the result of Proposition 1, the matrix $\mathcal{A}(\rho_k)$ can be written in a polytopic way, that is:

$$\mathcal{A}(\rho_k) = \sum_{i=1}^{N} \xi_k^i(\rho_k) \bar{A}_i \tag{12}$$

where the $\xi_i(\rho_k)$'s and the \bar{A}_i 's are computed from (6) and (9).

Now, consider the observer with state vector $\hat{\bar{x}}_k = [\hat{x}_k^T \hat{\theta}_k^T]^T$ described by :

$$\begin{cases} \begin{bmatrix} \hat{x}_{k+1} \\ \hat{\theta}_{k+1} \end{bmatrix} = \mathcal{A}(\rho_k) \begin{bmatrix} \hat{x}_k \\ \hat{\theta}_k \end{bmatrix} + \\ L(\rho_k) \bar{C} \begin{bmatrix} x_k - \hat{x}_k \\ \theta_k - \hat{\theta}_k \end{bmatrix} + \begin{bmatrix} g(y_k) \\ \mathbf{0} \end{bmatrix} \\ \hat{y}_k = \bar{C} \hat{x}_k \end{cases}$$
(12)

whose time-varying gain $L(\rho_k)$ is defined as follows :

$$L(\rho_k) = \sum_{i=1}^N \xi_k^i(\rho_k) L_i \tag{14}$$

Such an observer is called a polytopic observer since it involves matrices \mathcal{A} and L having a polytopic description. The resulting state reconstruction error $\epsilon_k = \bar{x}_k - \hat{x}_k$, deduced from (11) and (13), is thus also described in a polytopic way

$$\epsilon_{k+1} = \left(\sum_{i=1}^{N} \xi_k^i(\rho_k) \left(\bar{A}_i - L_i \bar{C}\right)\right) \epsilon_k \tag{15}$$

We recall a recent general result ensuring the global stability of such a polytopic system :

Theorem 1 [8] Global stability of (15) is achieved whenever the feasibility condition of the following set of Linear Matrix Inequalities is satisfied :

$$\begin{bmatrix} G_i + G_i^T - S_i & G_i^T A_i - F_i^T C \\ \bar{A}_i^T G_i - \bar{C}^T F_i & S_j \end{bmatrix} > 0$$
(16)

for all $(i, j) \in \{1, ..., N\} \times \{1, ..., N\}$

The G_i 's, S_i 's and F_i 's are unknown matrices of appropriate dimensions. The resulting gains L_i are given by $L_i = G_i^{-T} F_i^T$.

Consequently, from Theorem 1, the L_i 's ensure the global stability of (15) and so the global convergence toward zero of both errors $||x_k - \hat{x}_k||$ and $||\theta_k - \hat{\theta}_k||$. The proposed polytopic observer achieves a global adaptive synchronization.

4. ILLUSTRATIVE EXAMPLE

As mentioned in the introduction, adaptive synchronization can be used either to handle parameter mismatch problems or to retrieve the information in some communication scheme based on chaotic switching. The illustrative example deals with the later situation. The chaotic system acting as the transmitter corresponds to the Henon map :

$$\begin{cases} x_{k+1}^{(1)} = \theta_k \cdot (x_k^{(1)})^2 + x_k^{(2)} + 1 \\ x_{k+1}^{(2)} = q \cdot x_k^{(1)} \\ y_k = x_k^{(1)} \end{cases} \quad q = 0.3$$
(17)

The scalar parameter θ_k (p = 1) switches between $\theta_{min} = -1.4$ and $\theta_{max} = -1.3$. Let note that the state $x_k^{(1)}$ is online available because $y_k = x_k^{(1)}$. The extended state vector obeys the following equation:

 $\begin{cases} \begin{bmatrix} x_{k+1}^{(1)} \\ x_{k+1}^{(2)} \\ \theta_{k+1} \end{bmatrix} = \underbrace{\begin{bmatrix} 0 & 1 & (x_k^{(1)})^2 \\ q & 0 & 0 \\ 0 & 0 & 1 \end{bmatrix}}_{C} \begin{bmatrix} x_k^{(1)} \\ x_k^{(2)} \\ \theta_k \end{bmatrix} + \underbrace{\begin{bmatrix} 1 \\ 0 \\ 0 \end{bmatrix}}_{g(y_k)}_{g(y_k)}$

which is similar to (11) with

$$A(y_k) = \begin{bmatrix} 0 & 1 \\ q & 0 \end{bmatrix}$$
 and $f(y_k) = \begin{bmatrix} (x_k^{(1)})^2 \\ 0 \end{bmatrix}$

Our goal is to reconstruct simultaneously the state $x_k^{(2)}$ and the parameter θ_k . Taking $\rho_k = h(y_k) = (x_k^{(1)})^2$ enforces $\mathcal{A}(y_k)$ to be expressed as a function of class C^1 with respect to ρ_k . Since ρ_k is scalar (L = 1), one has $\rho_k^{(1)} = \rho_k$. Besides, (17) being chaotic, $x_k^{(1)}$ and so ρ_k is bounded. Hence, assumptions of Proposition 1 are fulfilled which allows a polytopic description (2) for which the ξ_i 's and the \bar{A}_i 's have to be determined according to the constructive proof.

Determination of ξ_i

By simulating the chaotic system (17), it can be inferred that ρ_k ranges between a minimum $\bar{\rho}_1^{(1)} = 7.7 \cdot 10^{-6}$ and a maximum $\bar{\rho}_1^{(2)} = 1.64$. Those extrema correspond to the vertices (N = 2) of the polytope wherein ρ_k lies. Hence, ρ_k can be expressed as in (4) or (5).

$$\underbrace{\begin{bmatrix} (x_k^{(1)})^2 \\ 1 \\ E_k \end{bmatrix}}_{E_k} = \underbrace{\begin{bmatrix} \bar{\rho}_1^{(1)} & \bar{\rho}_1^{(2)} \\ 1 & 1 \\ F \end{bmatrix}}_{F} \underbrace{\begin{bmatrix} \xi_k^1 \\ \xi_k^2 \end{bmatrix}}_{G_k}$$
(19)

Note that for this particular case, the solutions of (19) leads to simple explicit forms :

$$\xi_k^1 = \frac{\rho_k - \bar{\rho}_1^{(2)}}{\bar{\rho}_1^{(1)} - \bar{\rho}_1^{(2)}}$$

and $\xi_k^2 = 1 - \xi_k^1$ since $\sum_{i=1}^N \xi_k^i = 1$.

Determination of \overline{A}_i

The A_i 's are computed in a straightforward way according to (9) and yields :

$$\bar{A}_1 = \begin{bmatrix} 0 & 1 & 7.7 \cdot 10^{-6} \\ 0.3 & 0 & 0 \\ 0 & 0 & 1 \end{bmatrix} \quad \bar{A}_2 = \begin{bmatrix} 0 & 1 & 1.64 \\ 0.3 & 0 & 0 \\ 0 & 0 & 1 \end{bmatrix}$$
(20)

Determination of L_i

The gain $L(\rho_k)$ verifies (14). The ξ_k^i 's are the same than the ones involved in the polytopic decomposition (12) and resulting from the solution of (19). The L_i 's are derived from the solution of the LMI (16) with \overline{A}_i given in (20). The resolution can be performed thanks to standard LMI solvers.

$$L_1 = \begin{bmatrix} -0.0089\\ 0.3000\\ 0.2741 \end{bmatrix} \text{ and } L_2 = \begin{bmatrix} 0.5677\\ 0.3000\\ 0.3387 \end{bmatrix}$$
(21)

The design of the polytopic observer (13) is now completed. The figure 1 shows the convergence of the estimated parameter $\hat{\theta}_k$ toward the true parameter θ_k which switches periodically between two distinct values and the convergence of the error of synchronization toward zero. The simulations are consistent with the theoretical results. Let recall that since the convergence is global, it is achieved whatever be the initial conditions.

5. CONCLUSION

A scheme ensuring a global adaptive synchronization by a joint state and parameter estimation has been proposed as an alternative to the standard Extended Kalman Filter. The advantage lies in the fact that the design does no longer require a first order approximation, preventing some possible bad convergence properties. The gain of the polytopic observer is easily computed from the resolution of a Linear Matrix Inequalities set. Besides, the novelty of such an approach stems from the fact that the design takes into account some chaos specificities as the bounds of the state vector in the state space.
