# FORMAL GEOMETRIC QUANTIZATION 

PAUL-EMILE PARADAN


#### Abstract

Let $K$ be a compact Lie group acting in an Hamiltonian way on a symplectic manifold $(M, \Omega)$ which is prequantized by a Kostant-Souriau line bundle. We suppose here that the moment map $\Phi$ is proper so that the reduced space $M_{\mu}:=\Phi^{-1}(K \cdot \mu) / K$ are compact for all $\mu$. Following Weitsman 33, we define the "formal geometric quantization" of $M$ as $$
\mathcal{Q}_{K}^{-\infty}(M):=\sum_{\mu \in \widehat{K}} \mathcal{Q}\left(M_{\mu}\right) V_{\mu}^{K}
$$

The aim of this article is to study the functorial properties of the assigment $M \longrightarrow \mathcal{Q}_{K}^{-\infty}(M)$.

## 1. Introduction and statement of the results

Let $M$ be an Hamiltonian $K$-manifold with symplectic form $\Omega$ and moment map $\Phi: M \rightarrow \mathfrak{k}^{*}$. We assume the existence of a $K$-equivariant line bundle $L$ on $M$ with connection of curvature equal to $-i \omega$. In other words $M$ is pre-quantizable in the sense of 20] and we call $L$ the Kostant-Souriau line bundle.

In the process of quantization one tries to associate a unitary representation of $K$ to the data $(M, \Omega, \Phi, L)$. When $M$ is compact one associates to these data a virtual representation $\mathcal{Q}_{K}(M) \in R(K)$ of $K$ defined as the equivariant index of a Dolbeault-Dirac operator : $\mathcal{Q}_{K}(M)$ is the geometric quantization of $M$.

This quantization process satisfies the following functorial properties :
[P1] When $N$ and $M$ are respectively pre-quantized compact Hamiltonian $K_{1}$ and $K_{2}$ manifolds, the product $M \times N$ is a pre-quantized compact Hamiltonian $K_{1} \times K_{2}$-manifold, and we have
(1.1) $\mathcal{Q}_{K_{1} \times K_{2}}(M \times N)=\mathcal{Q}_{K_{1}}(M) \otimes \mathcal{Q}_{K_{2}}(N) \quad$ in $\quad R\left(K_{1} \times K_{2}\right) \simeq R\left(K_{1}\right) \otimes R\left(K_{2}\right)$.
[P2] If $H \subset K$ is a connected Lie subgroup, then the restriction of $\mathcal{Q}_{K}(M)$ to $H$ is equal to $\mathcal{Q}_{H}(M)$.

Note that $[\mathbf{P} 1]$ and $[\mathbf{P} 2]$ gives the following functorial property :
[P3] When $N$ and $M$ are pre-quantized compact Hamiltonian $K$-manifold, the product $M \times N$ is a pre-quantized compact Hamiltonian $K$-manifold, and we have $\mathcal{Q}_{K}(M \times N)=\mathcal{Q}_{K}(M) \cdot \mathcal{Q}_{K}(N)$, where $\cdot$ denotes the product in $R(K)$.

One other fundamental property is the behaviour of the $K$-multiplicities of $\mathcal{Q}_{K}(M)$ that is known as "quantization commutes with reduction".

Let $T$ be a maximal torus of $K, C_{K} \subset \mathfrak{t}^{*}$ be a Weyl Chamber, $\wedge^{*} \subset \mathfrak{t}^{*}$ be the weight lattice, and $\widehat{K}=\wedge^{*} \cap C_{K}$ be the set of dominant weights. The ring of character $R(K)$ as a $\mathbb{Z}$-basis $V_{\mu}^{K}, \mu \in \widehat{K}: V_{\mu}^{K}$ is the irreducible $K$-representation with highest weight $\mu$.

For any $\mu \in \widehat{K}$ which is a regular value of $\Phi$, the reduced space (or symplectic quotient) $M_{\mu}:=\Phi^{-1}(K \cdot \mu) / K$ is an orbifold equipped with a symplectic structure $\Omega_{\mu}$. Moreover $L_{\mu}:=\left(\left.L\right|_{\Phi^{-1}(\mu)} \otimes \mathbb{C}_{-\mu}\right) / K_{\mu}$ is a Kostant line orbibundle over $\left(M_{\mu}, \Omega_{\mu}\right)$. The definition of the index of the Dolbeault-Dirac operator carries over to the orbifold case, hence $\mathcal{Q}\left(M_{\mu}\right) \in \mathbb{Z}$ is defined. In 25, this is extended further to the case of singular symplectic quotients, using partial (or shift) de-singularization. So the integer $\mathcal{Q}\left(M_{\mu}\right) \in \mathbb{Z}$ is well defined for every $\mu \in \widehat{K}$ : in particular $\mathcal{Q}\left(M_{\mu}\right)=0$ if $\mu \notin \Phi(M)$.

The following Theorem was conjectured by Guillemin-Sternberg 16 and is known as "quantization commutes with reduction" 24, 25, 30, 28]. For complete references on the subject the reader should consult 29, 32].

Theorem 1.1. (Meinrenken, Meinrenken-Sjamaar). We have the following equality in $R(K)$

$$
\mathcal{Q}_{K}(M)=\sum_{\mu \in \widehat{K}} \mathcal{Q}\left(M_{\mu}\right) V_{\mu}^{K}
$$

Suppose now that $M$ is non-compact but the moment map $\Phi: M \rightarrow \mathfrak{k}^{*}$ is assumed to be proper (we will said simply " $M$ is proper"). In this situation the geometric quantization of $M$ as an index of an elliptic operator is not well defined. Nevertheless the integers $\mathcal{Q}\left(M_{\mu}\right), \mu \in \widehat{K}$ are well defined since the symplectic quotient $M_{\mu}$ are compact.

Following Weitsman [33], we introduce the following
Definition 1.2. The formal quantization of $(M, \Omega, \Phi)$ is the element of $R^{-\infty}(K):=$ $\operatorname{hom}_{\mathbb{Z}}(R(K), \mathbb{Z})$ defined by

$$
\mathcal{Q}_{K}^{-\infty}(M)=\sum_{\mu \in \widehat{K}} \mathcal{Q}\left(M_{\mu}\right) V_{\mu}^{K}
$$

A representation $E$ of $K$ is admissible if it as finite $K$-multiplicities : $\operatorname{dim}\left(\operatorname{hom}_{K}\left(V_{\mu}^{K}, E\right)\right)<\infty$ for every $\mu \in \widehat{K}$. Here $R^{-\infty}(K)$ is the Grothendieck group associated to the $K$-admissible representations. We have a canonical inclusion $i: R(K) \hookrightarrow R^{-\infty}(K):$ to $V \in R(K)$ we associate the map $i(V): R(K) \rightarrow \mathbb{Z}$ defined by $W \mapsto \operatorname{dim}\left(\operatorname{hom}_{K}(V, W)\right)$. In order to simplify the notation, $i(V)$ will be written $V$. Moreover the tensor product induces a structure of $R(K)$-module on $R^{-\infty}(K)$ since $E \otimes V$ is an admissible representation when $V$ and $E$ are respectively finite dimensional and admissible representation of $K$.

It is an easy matter to see that [ $\mathbf{P} 1]$ holds for the formal quantization process $\mathcal{Q}^{-\infty}$. Let $N$ and $M$ be respectively pre-quantized proper Hamiltonian $K_{1}$ and $K_{2}$ manifolds : the product $M \times N$ is then a pre-quantized proper Hamiltonian $K_{1} \times K_{2}$-manifold. For the reduced spaces we have $(M \times N)_{\left(\mu_{1}, \mu_{2}\right)} \simeq M_{\mu_{1}} \times N_{\mu_{2}}$, for all $\mu_{1} \in \widehat{K}_{1}, \mu_{2} \in \widehat{K}_{2}$. It follows then that

$$
\begin{equation*}
\mathcal{Q}_{K_{1} \times K_{2}}^{-\infty}(M \times N)=\mathcal{Q}_{K_{1}}^{-\infty}(M) \widehat{\otimes} \mathcal{Q}_{K_{2}}^{-\infty}(N) \tag{1.2}
\end{equation*}
$$

in $R^{-\infty}\left(K_{1} \times K_{2}\right) \simeq R^{-\infty}\left(K_{1}\right) \widehat{\otimes} R^{-\infty}\left(K_{2}\right)$.
The purpose of this article is to show that the functorial property $[\mathbf{P} 2]$ still holds for the formal quantization process $\mathcal{Q}^{-\infty}$.
Theorem 1.3. Let $M$ be a pre-quantized Hamiltonian $K$-manifold which is proper. Let $H \subset K$ be a connected Lie subgroup such that $M$ is still proper as an Hamiltonian $H$-manifold. Then $\mathcal{Q}_{K}^{-\infty}(M)$ is $H$-admissible and we have the following equality in $R^{-\infty}(H)$ :

$$
\begin{equation*}
\left.\mathcal{Q}_{K}^{-\infty}(M)\right|_{H}=\mathcal{Q}_{H}^{-\infty}(M) . \tag{1.3}
\end{equation*}
$$

For $\mu \in \widehat{K}$ and $\nu \in \widehat{H}$ we denote $N_{\nu}^{\mu}=\operatorname{dim}\left(\operatorname{hom}_{H}\left(V_{\nu}^{H},\left.V_{\mu}^{K}\right|_{H}\right)\right)$ the multiplicity of $V_{\nu}^{H}$ in the restriction $\left.V_{\mu}^{K}\right|_{H}$. In the situation of Theorem 1.3, the moment maps relative to the $K$ and $H$ actions are $\Phi_{K}$ and $\Phi_{H}=\mathrm{p} \circ \Phi_{K}$, where $\mathrm{p}: \mathfrak{k}^{*} \rightarrow \mathfrak{h}^{*}$ is the canonical projection.
Corollary 1.4. For every $\nu \in \widehat{H}$, we have :

$$
\begin{equation*}
\mathcal{Q}\left(M_{\nu, H}\right)=\sum_{\mu \in \widehat{K}} N_{\nu}^{\mu} \mathcal{Q}\left(M_{\mu, K}\right) . \tag{1.4}
\end{equation*}
$$

where $M_{\nu, H}=\Phi_{H}^{-1}(H \cdot \nu) / H$ and $M_{\mu, K}=\Phi_{K}^{-1}(K \cdot \mu) / K$ are respectively the symplectic reductions relative to the $H$ and $K$-actions.

Since $V_{\mu}^{K}$ is equal to the $K$-quantization of $K \cdot \mu$, the "quantization commutes with reduction" Theorem tells us that $N_{\nu}^{\mu}=\mathcal{Q}\left((K \cdot \mu)_{\nu, H}\right)$ : in particular $N_{\nu}^{\mu} \neq 0$ implies that $\nu \in \mathrm{p}(K \cdot \mu) \Longleftrightarrow \mu \in K \cdot \mathrm{p}^{-1}(\nu)$. Finally

$$
N_{\nu}^{\mu} \mathcal{Q}\left(M_{\mu, K}\right) \neq 0 \Longrightarrow \mu \in K \cdot \mathrm{p}^{-1}(\lambda) \quad \text { and } \quad \Phi_{K}^{-1}(\mu) \neq \emptyset .
$$

Theses two conditions imply that we can restrict the sum of RHS of (1.4) to

$$
\begin{equation*}
\mu \in \widehat{K} \cap \Phi_{K}\left(K \cdot \Phi_{H}^{-1}(\nu)\right) \tag{1.5}
\end{equation*}
$$

which is finite since $\Phi_{H}$ is proper.
Theorem 1.3 and (1.2) gives the following extended version of [P3].
Theorem 1.5. Let $N$ and $M$ be two pre-quantized Hamiltonian $K$-manifold where $N$ is compact and $M$ is proper. The product $M \times N$ is then proper and we have have the following equality in $R^{-\infty}(K)$ :

$$
\begin{equation*}
\mathcal{Q}_{K}^{-\infty}(M \times N)=\mathcal{Q}_{K}^{-\infty}(M) \cdot \mathcal{Q}_{K}(N) \tag{1.6}
\end{equation*}
$$

For $\mu, \lambda, \theta \in \widehat{K}$ we denote $C_{\lambda, \theta}^{\mu}=\operatorname{dim}\left(\operatorname{hom}_{H}\left(V_{\mu}^{K}, V_{\lambda}^{K} \otimes V_{\theta}^{K}\right)\right)$ the multiplicity of $V_{\mu}^{K}$ in the tensor $V_{\lambda}^{K} \otimes V_{\theta}^{K}$. Since $V_{\lambda}^{K} \otimes V_{\theta}^{K}$ is equal to the quantization of the product $K \cdot \lambda \times K \cdot \theta$, the "quantization commutes with reduction" Theorem tells us that $C_{\lambda, \theta}^{\mu}=\mathcal{Q}\left((K \cdot \lambda \times K \cdot \theta)_{\mu}\right)$ : in particular $C_{\lambda, \theta}^{\mu} \neq 0$ implies that $(*)\|\lambda\| \leq\|\theta\|+\|\mu\|$.

Corollary 1.6. In the situation of Theorem 1.5, we have for every $\mu \in \widehat{K}$ :

$$
\begin{equation*}
\mathcal{Q}\left((M \times N)_{\mu}\right)=\sum_{\lambda, \theta \in \widehat{K}} C_{\lambda, \theta}^{\mu} \mathcal{Q}\left(M_{\lambda}\right) \mathcal{Q}\left(N_{\theta}\right) \tag{1.7}
\end{equation*}
$$

Since $N$ is compact, $\mathcal{Q}\left(N_{\theta}\right) \neq 0$ for a $(* *) \theta \in\{$ finite set $\}$. Then $(*)$ and $(* *)$ show that the sum in the RHS of (1.7) is finite.

Weistman [33] studied the formal quantization procedure in the case of $K=$ $\mathrm{U}(n)$. Using a method of symplectic cutting [21, 35] he defines for two increasing sequence of positive integers $r_{n}, s_{n}$ a family of cut-spaces $M^{r_{n}, s_{n}}$ which are compact. Under the hypothesis that the cut spaces $M^{r_{n}, s_{n}}$ are smooth, he notes that $\mathcal{Q}_{K}^{-\infty}(M)=\lim _{n \rightarrow \infty} \mathcal{Q}_{K}\left(M^{r_{n}, s_{n}}\right)$, and he was then able to show Theorem 1.5.

Our proof of Theorem 1.3 uses also a technique of symplectic cutting but which is valid for any compact Lie group actions. We have to overpass the difficulties concerning the non-smoothness of the cut-spaces. For this purpose we introduce another method of symplectic cutting that uses the wonderfull compactifications of Concini-Procesi 13, 14], and we prove an extension of the "quantization commutes with reduction" Theorem to the singular setting.

## 2. Quantization commutes with reduction

In this section we precise the definition of the quantization of a smooth and compact Hamiltonian manifold. We extend the definition to the case of a singular Hamiltonian manifold and we prove a "quantization commutes with reduction" Theorem in the singular setting.

In the Kostant-Souriau framework, an Hamiltonian $K$-manifold $\left(M, \Omega_{M}, \Phi_{M}\right)$ is pre-quantized if there is an equivariant Hermitian line bundle $L$ with an invariant Hermitian connection $\nabla$ such that

$$
\begin{equation*}
\mathcal{L}(X)-\nabla_{X_{M}}=i\left\langle\Phi_{M}, X\right\rangle \quad \text { and } \quad \nabla^{2}=-i \Omega_{M} \tag{2.8}
\end{equation*}
$$

for every $X \in \mathfrak{k}$. Here $X_{M}$ is the vector field on $M$ defined by $X_{M}(m)=\left.\frac{d}{d t} e^{-t X} m\right|_{0}$.
$(L, \nabla)$ is also call a Kostant-Souriau line bundle. Remark that the conditions (2.8) implies through the equivariant Bianchi formula the relation

$$
\begin{equation*}
\iota\left(X_{M}\right) \Omega_{M}=-d\left\langle\Phi_{M}, X\right\rangle, \quad X \in \mathfrak{k} \tag{2.9}
\end{equation*}
$$

We will now recall the notions of geometric quantization.
2.1. Geometric quantization : the compact and smooth case. We suppose here that $\left(M, \Omega_{M}, \Phi_{M}\right)$ is compact and is prequantized by a Hermitian line bundle $L$. Choose a $K$-invariant almost complex structure $J$ on $M$ which is compatible with $\Omega_{M}$ in the sense that the symmetric bilinear form $\Omega_{M}(\cdot, J \cdot)$ is a Riemannian metric. Let $\bar{\partial}_{L}$ be the Dolbeault operator with coefficients in $L$, and let $\bar{\partial}_{L}^{*}$ be its (formal) adjoint. The Dolbeault-Dirac operator on $M$ with coefficients in $L$ is $D_{L}=\bar{\partial}_{L}+\bar{\partial}_{L}^{*}$, considered as an operator from $\mathcal{A}^{0, \text { even }}(M, L)$ to $\mathcal{A}^{0, \text { odd }}(M, L)$.

Definition 2.1. The geometric quantization of $\left(M, \Omega_{M}, \Phi_{M}\right)$ is the element $\mathcal{Q}_{K}(M) \in$ $R(K)$ which is defined as the equivariant index of the Dolbeault-Dirac operator $D_{L}$.
Remark 2.2. - We can define the Dolbeault-Dirac operator $D_{L}^{J}$ for any invariant almost complex structure $J$. If $J_{0}$ and $J_{1}$ are equivariantly homotopic the indices of $D_{L}^{J_{0}}$ and $D_{L}^{J_{1}}$ coincides (see 28).

- Since the set of compatible invariant almost complex structure on $M$ is pathconnected, the element $\mathcal{Q}_{K}(M) \in R(K)$ does not depend of the choice of $J$.
2.2. Geometric quantization : the compact and singular case. We are interested to defined the geometric quantization of singular compact Hamiltonian manifolds : here "singular" means that the manifold is obtain by symplectic reduction.

Let $\left(N, \Omega_{N}\right)$ be a smooth symplectic manifold equipped with an Hamiltonian action of $K \times H:$ we denote $\left(\Phi_{K}, \Phi_{H}\right): N \rightarrow \mathfrak{k}^{*} \oplus \mathfrak{h}^{*}$ the corresponding moment map. We assume that $N$ is pre-quantized by a $K \times H$-equivariant line bundle $L$ and we suppose that the map $\Phi_{H}$ is proper. One wants to define the quantization of the (compact) symplectic quotient

$$
N / /{ }_{0} H:=\Phi_{H}^{-1}(0) / H .
$$

When 0 is a regular value of $\Phi_{H}, N / /{ }_{0} H$ is a compact symplectic orbifold equipped with an Hamiltonian action of $K$ : the corresponding moment map is induced by the restriction of $\Phi_{K}$ to $\Phi_{H}^{-1}(0)$. The symplectic quotient $N / /{ }_{0} H$ is pre-quantized by the line orbibundle

$$
L_{0}:=\left(\left.L\right|_{\Phi_{H}^{-1}(0)}\right) / H
$$

Definition 2.1 extends to the orbifold case, so one can still defined the quantization of $N / /{ }_{0} H$ as an element $\mathcal{Q}_{K}\left(N / /{ }_{0} H\right) \in R(K)$.

Suppose now that 0 is not a regular value of $\Phi_{H}$. Let $T_{H}$ be a maximal torus of $H$, and let $C_{H} \subset \mathfrak{t}_{H}^{*}$ be a weyl chamber. Since $\Phi_{H}$ is proper, the convexity theorem says that the image of $\Phi_{H}$ intersects $C_{H}$ in a closed locally polyhedral convex set, that we denoted $\Delta_{H}(M)$ (22].

We consider an element $a \in \Delta_{H}(M)$ which is generic and sufficiently closed to $0 \in \Delta_{H}(M)$ : we denote $H_{a}$ the subgroup of $H$ which stabilizes $a$. When $a \in \Delta_{H}(M)$ is generic, one can shows (see 25]) that

$$
N / /{ }_{a} H:=\Phi_{H}^{-1}(a) / H_{a}
$$

is a compact $K$-Hamiltonian orbifold, and that

$$
L_{a}:=\left(\left.L\right|_{\Phi_{H}^{-1}(a)}\right) / H_{a} .
$$

is a $K$-equivariant line orbibundle over $N / /{ }_{a} H$ : we can then define like in Definition 2.1 the element $\mathcal{Q}_{K}\left(N / /{ }_{a} H\right) \in R(K)$ as the equivariant index of the Dolbeault-Dirac operator on $N / /{ }_{a} H$.

Proposition-Definition 2.3. The elements $\mathcal{Q}_{K}\left(N / /{ }_{a} H\right) \in R(K)$ do not depend of the choice of the generic element $a \in \Delta_{H}(M)$, when a is sufficiently closed to 0 . The common value will be taken as the geometric quantization of $N / /{ }_{0} H$, and still denoted $\mathcal{Q}_{K}\left(N / /{ }_{0} H\right)$.

Proof. When $N$ is compact and $K=\{e\}$, the proof can be founded in 25] and in 28]. The $\mathbf{K}$-theoretic proof of 28] extends naturally to our case.
2.3. Quantization commutes with reduction : the singular case. In section 2.2. we have defined the geometric quantization $\mathcal{Q}_{K}\left(N / /{ }_{0} H\right) \in R(K)$ of a compact symplectic reduced space $N / /{ }_{0} H$. We will compute its $K$-multiplicities like in Theorem 1.1.

For every $\mu \in \widehat{K}$, we consider the coadjoint orbit $K \cdot \mu \simeq K / K_{\mu}$ which is pre-quantized by the line bundle $\mathbb{C}_{[\mu]} \simeq K \times_{K_{\mu}} \mathbb{C}_{\mu}$. We consider the product ${ }^{1}$ $N \times \overline{K \cdot \mu}$ which is an Hamiltonian $K \times H$ manifold which is pre-quantized by $K \times H$ equivariant line bundle $L \otimes \mathbb{C}_{[\mu]}^{-1}$. The moment map $N \times \overline{K \cdot \mu} \rightarrow \mathfrak{k}^{*} \times \mathfrak{h}^{*},(n, \xi) \mapsto$ $\left(\Phi_{K}(n)-\xi, \Phi_{H}(n)\right)$ is proper, so the reduced space

$$
\left(N / /{ }_{0} H\right)_{\mu}:=(N \times \overline{K \cdot \mu}) / /(0,0) K \times H
$$

is compact. Following Proposition 2.3, we can then define its quantization $\mathcal{Q}\left(\left(N / /{ }_{0} H\right)_{\mu}\right) \in \mathbb{Z}$. The main result of this section is the

Theorem 2.4. We have the following equality in $R(K)$ :

$$
\begin{equation*}
\mathcal{Q}_{K}\left(N / /{ }_{0} H\right)=\sum_{\mu \in \widehat{K}} \mathcal{Q}\left(\left(N / /{ }_{0} H\right)_{\mu}\right) V_{\mu}^{K} \tag{2.10}
\end{equation*}
$$

Proof. The proof will occupied the remaining of this section. The starting point is to state another definition of the geometric quantization of a symplectic reduced space which uses the Atiyah-Singer's theory of transversally elliptic operators.
2.3.1. Transversally elliptic symbols. Here we give the basic definitions from the theory of transversally elliptic symbols (or operators) defined by Atiyah-Singer in 11. For an axiomatic treatment of the index morphism see Berline-Vergne [8, 9] and for a short introduction see [28].
 tion, and let $(-,-) \mathcal{X}$ be a $K_{1} \times K_{2}$-invariant Riemannian metric. If $E^{0}, E^{1}$ are $K_{1} \times K_{2}$-equivariant vector bundles over $\mathcal{X}$, a $K_{1} \times K_{2}$-equivariant morphism $\sigma \in \Gamma\left(\mathrm{T} \mathcal{X}, \operatorname{hom}\left(p^{*} E^{0}, p^{*} E^{1}\right)\right)$ is called a symbol. The subset of all $(x, v) \in \mathrm{T} \mathcal{X}$ where $\sigma(x, v): E_{x}^{0} \rightarrow E_{x}^{1}$ is not invertible is called the characteristic set of $\sigma$, and is denoted by $\operatorname{Char}(\sigma)$.

Let $\mathrm{T}_{K_{2}} \mathcal{X}$ be the following subset of $\mathrm{T} \mathcal{X}$ :

$$
\mathrm{T}_{K_{2}} \mathcal{X}=\left\{(x, v) \in \mathrm{T} M,\left(v, X_{M}(x)\right)_{M}=0 \quad \text { for all } X \in \mathfrak{k}_{2}\right\}
$$

A symbol $\sigma$ is elliptic if $\sigma$ is invertible outside a compact subset of $\mathrm{T} \mathcal{X}$ (i.e. $\operatorname{Char}(\sigma)$ is compact), and is $K_{2}$-transversally elliptic if the restriction of $\sigma$ to $\mathrm{T}_{K_{2}} \mathcal{X}$ is invertible outside a compact subset of $\mathrm{T}_{K_{2}} \mathcal{X}$ (i.e. $\operatorname{Char}(\sigma) \cap \mathrm{T}_{K_{2}} \mathcal{X}$ is compact). An elliptic symbol $\sigma$ defines an element in the equivariant $\mathbf{K}$-theory of $\mathrm{T} \mathcal{X}$ with compact support, which is denoted by $\mathbf{K}_{K_{1} \times K_{2}}(\mathrm{~T} \mathcal{X})$, and the index of $\sigma$ is a virtual


A $K_{2}$-transversally elliptic symbol $\sigma$ defines an element of $\mathbf{K}_{K_{1} \times K_{2}}\left(\mathrm{~T}_{K_{2}} M\right)$, and the index of $\sigma$ is defined as a trace class virtual representation of $K_{1} \times K_{2}$ (see (1) for the analytic index and [8, 9] for the cohomological one) : in fact $\operatorname{Index}^{\mathcal{X}}(\sigma)$ belongs to the tensor product $R\left(K_{1}\right) \widehat{\otimes} R^{-\infty}\left(K_{2}\right)$.

[^0]Remark that any elliptic symbol of $\mathrm{T} \mathcal{X}$ is $K_{2}$-transversally elliptic, hence we have a restriction map $\mathbf{K}_{K_{1} \times K_{2}}(\mathrm{TX}) \rightarrow \mathbf{K}_{K_{1} \times K_{2}}\left(\mathrm{~T}_{K_{2}} \mathcal{X}\right)$, and a commutative diagram


Using the excision property, one can easily show that the index map Index ${ }^{\mathcal{U}}$ : $\mathbf{K}_{K_{1} \times K_{2}}\left(\mathrm{~T}_{K_{2}} \mathcal{U}\right) \rightarrow R\left(K_{1}\right) \widehat{\otimes} R^{-\infty}\left(K_{2}\right)$ is still defined when $\mathcal{U}$ is a $K_{1} \times K_{2}$-invariant relatively compact open subset of a $K_{1} \times K_{2}$-manifold (see [28[section 3.1]).
2.3.2. Quantization of singular space : second definition. Let $\left(\mathcal{X}, \Omega_{\mathcal{X}}\right)$ be an Hamiltonian $K_{1} \times K_{2}$-manifold pre-quantized by a $K_{1} \times K_{2}$-equivariant line bundle $L$. The moment map $\Phi_{2}: \mathcal{X} \rightarrow \mathfrak{k}_{2}^{*}$ relative to the $K_{2}$-action is supposed to be proper. Take a compatible $K_{1} \times K_{2}$-invariant almost complex structure on $\mathcal{X}$. We choose a $K_{1} \times K_{2}$-invariant Hermitian metric $\|v\|^{2}$ on the tangent bundle $\mathrm{T} \mathcal{X}$, and we identify the cotangent bundle $\mathrm{T}^{*} \mathcal{X}$ with $\mathrm{T} \mathcal{X}$. For $(x, v) \in \mathrm{T} \mathcal{X}$, the principal symbol of the Dolbeault-Dirac operator $\bar{\partial}_{L}+\bar{\partial}_{L}^{*}$ is the clifford multiplication $\mathbf{c}_{\mathcal{X}}(v)$ on the complex vector bundle $\Lambda^{\bullet} \mathrm{T}_{x} \mathcal{X} \otimes L_{x}$. It is invertible for $v \neq 0$, since $\mathbf{c}_{\mathcal{X}}(v)^{2}=-\|v\|^{2}$.

When $\mathcal{X}$ is compact, the symbol $\mathbf{c}_{\mathcal{X}}$ is elliptic and then defines an element of the equivariant $\mathbf{K}$-group of $\mathrm{T} \mathcal{X}$. The topological index of $\mathbf{c}_{\mathcal{X}} \in \mathbf{K}_{K_{1} \times K_{2}}(\mathrm{~T} \mathcal{X})$ is equal to the analytical index of the Dolbeault-Dirac operator $\bar{\partial}_{L}+\bar{\partial}_{L}^{*}$ :

$$
\begin{equation*}
\mathcal{Q}_{K_{1} \times K_{2}}(\mathcal{X})=\operatorname{Index}^{\mathcal{X}}\left(\mathbf{c}_{\mathcal{X}}\right) \quad \text { in } \quad R\left(K_{1}\right) \otimes R\left(K_{2}\right) \tag{2.12}
\end{equation*}
$$

When $\mathcal{X}$ is not compact the topological index of $\mathbf{c}_{\mathcal{X}}$ is not defined. In order to give a topological definition of $\mathcal{Q}_{K_{1}}\left(\mathcal{X} / /{ }_{0} K_{2}\right)$, we will deform the symbol $\mathbf{c}_{\mathcal{X}}$ as follows. Consider the identification $\mathfrak{k}_{2}^{*} \simeq \mathfrak{k}_{2}$ defined by a $K_{2}$-invariant scalar product on the Lie algebra $\mathfrak{k}_{2}$. From now on the moment map $\Phi_{2}$ will take values in $\mathfrak{k}_{2}$, and we define the vectors field on $\mathcal{X}$

$$
\begin{equation*}
\kappa_{x}=\left(\Phi_{2}(x)\right)_{M}(x), \quad x \in \mathcal{X} . \tag{2.13}
\end{equation*}
$$

We consider now the symbol

$$
\mathbf{c}_{\mathcal{X}}^{\kappa}(v)=\mathbf{c}\left(v-\kappa_{x}\right), \quad v \in \mathrm{~T}_{x} \mathcal{X} .
$$

Note that $\mathbf{c}_{\mathcal{X}}^{\kappa}(v)$ is invertible except if $v=\kappa_{x}$. If furthermore $v$ belongs to the subset $\mathrm{T}_{K_{2}} M$ of tangent vectors orthogonal to the $K_{2}$-orbits, then $v=0$ and $\kappa_{x}=0$. Indeed $\kappa_{x}$ is tangent to $K_{2} \cdot x$ while $v$ is orthogonal.

Since $\kappa$ is the Hamiltonian vector field of the function $\left\|\Phi_{2}\right\|^{2}$, the set of zeros of $\kappa$ coincides with the set $\operatorname{Cr}\left(\left\|\Phi_{2}\right\|^{2}\right)$ of critical points of $\left\|\Phi_{2}\right\|^{2}$.

Let $\mathcal{U} \subset \mathcal{X}$ be a $K_{1} \times K_{2}$-invariant open subset which is relatively compact. If the border $\partial \mathcal{U}$ does not intersect $\operatorname{Cr}\left(\left\|\Phi_{2}\right\|^{2}\right)$, then the restriction $\left.c_{\mathcal{X}}^{\kappa}\right|_{\mathcal{U}}$ defines a class in $\mathbf{K}_{K_{1} \times K_{2}}\left(\mathrm{~T}_{K_{2}} \mathcal{U}\right)$ since

$$
\operatorname{Char}\left(\mathbf{c}_{\mathcal{X}}^{\kappa} \mid \mathcal{U}\right) \cap \mathrm{T}_{K_{2}} \mathcal{U} \simeq \operatorname{Cr}\left(\left\|\Phi_{2}\right\|^{2}\right) \cap \mathcal{U}
$$

is compact. In this situation the index of $\mathbf{c}_{\kappa} \mid \mathcal{U}$ is defined as an element Index ${ }^{\mathcal{U}}\left(\mathbf{c}_{\kappa} \mid \mathcal{U}\right) \in$ $R\left(K_{1}\right) \widehat{\otimes} R^{-\infty}\left(K_{2}\right)$.
Theorem 2.5. The $K_{2}$-invariant part of $\operatorname{Index}^{\mathcal{U}}\left(\mathbf{c}_{\mathcal{X}}^{\kappa} \mid \mathcal{U}\right)$ is equal to :

- $\mathcal{Q}_{K_{1}}\left(\mathcal{X} / /{ }_{0} K_{2}\right)$ when $\Phi_{2}^{-1}(0) \subset \mathcal{U}$,
- 0 in the other case.

Proof. When $K_{1}=\{e\}$, the proof is done in 28] (see section 7). This proof works equally well in the general case.

Remark 2.6. If $\mathcal{X}$ is compact we can take $\mathcal{U}=\mathcal{X}$ in the last Theorem. In this case the symbols $\mathbf{c}_{\mathcal{X}}^{\kappa}$ and $\mathbf{c}_{\mathcal{X}}$ defines the same class in $\mathbf{K}_{K_{1} \times K_{2}}(\mathrm{~T} \mathcal{X})$ so they have the same index. Theorem 2.5 corresponds then to the traditional "quantization commutes with reduction" phenomenon : $\left[\mathcal{Q}_{K_{1} \times K_{2}}(\mathcal{X})\right]^{K_{2}}=\mathcal{Q}_{K_{1}}\left(\mathcal{X} / /{ }_{0} K_{2}\right)$.
¿From now one we will work with this topological definiton for the geometric quantization of the reduced $K_{1}$-Hamiltonian manifold $\mathcal{X} / /{ }_{0} K_{2}$ (which is possibly singular): $\mathcal{Q}_{K_{1}}\left(\mathcal{X} / /{ }_{0} K_{2}\right)=\left[\operatorname{Index}^{\mathcal{U}}\left(\mathbf{c}_{\mathcal{X}}^{\kappa} \mid \mathcal{U}\right)\right]^{K_{2}}$ where $\mathcal{U}$ is any relatively compact neighborhood of $\Phi_{2}^{-1}(0)$ such that $\partial \mathcal{U} \cap \operatorname{Cr}\left(\left\|\Phi_{2}\right\|^{2}\right)=\emptyset$. The functorial properties still holds in this singular setting. In particular :
[ $\mathbf{P} 2]$ If $H \subset K_{1}$ is a connected lie subgroup, then the restriction of $\mathcal{Q}_{K_{1}}\left(\mathcal{X} / /{ }_{0} K_{2}\right)$ to $H$ is equal to $\mathcal{Q}_{H}\left(\mathcal{X} / /{ }_{0} K_{2}\right)$.
2.3.3. Proof of theorem 2.4. We come back in the situation of sections 2.2 and 2.3 .

First we apply Theorem 2.5 to $\mathcal{X}=N, K_{1}=K$ and $K_{2}=H$. (2.10) is trivially true when $0 \notin \operatorname{Image}\left(\Phi_{H}\right)$. So we suppose now that $0 \in \operatorname{Image}\left(\Phi_{H}\right)$, and we consider an $K \times H$-invariant open subset $\mathcal{U} \subset N$ which is relatively compact and such that

$$
\Phi_{H}^{-1}(0) \subset \mathcal{U} \quad \text { and } \quad \partial \mathcal{U} \cap \operatorname{Cr}\left(\left\|\Phi_{H}\right\|^{2}\right)=\emptyset
$$

We have $\mathcal{Q}_{K}\left(N / /{ }_{0} H\right)=\left[\operatorname{Index}^{\mathcal{U}}\left(\mathbf{c}_{N}^{\kappa H} \mid \mathcal{U}\right)\right]^{H}$ and one want to compute its $K$ - multiplicities $m_{\mu}, \mu \in \widehat{K}$. Here $\kappa^{H}$ is the vectors field on $N$ associated to the moment $\operatorname{map} \Phi_{H}($ see (2.13) $)$.

Take $\mu \in \widehat{K}$. We denote $\mathbf{c}_{-\mu}$ the principal symbol of the Dolbeault-Dirac operator on $\overline{K \cdot \mu}$ with values in the line bundle $\mathbb{C}_{[-\mu]}$ : we have Index ${ }^{K \cdot \mu}\left(\mathbf{c}_{-\mu}\right)=\left(V_{\mu}^{K}\right)^{*}$.

We know then that the multiplicity of $\left[\operatorname{Index}^{\mathcal{U}}\left(\mathbf{c}_{N}^{\kappa H} \mid \mathcal{U}\right)\right]^{H}$ relatively to $V_{\mu}^{K}$ is equal to

$$
\begin{equation*}
m_{\mu}:=\left[\operatorname{Index}^{\mathcal{V}}\left(\mathbf{c}_{N}^{\kappa H} \mid \mathcal{U} \odot \mathbf{c}_{-\mu}\right)\right]^{K \times H} \tag{2.14}
\end{equation*}
$$

with $\mathcal{V}=\mathcal{U} \times K \cdot \mu$. This identity is due to the fact that we have a "multiplication"

$$
\begin{aligned}
\mathbf{K}_{K \times H}\left(\mathrm{~T}_{H} \mathcal{U}\right) \times \mathbf{K}_{K}(\mathrm{~T}(K \cdot \mu)) & \longrightarrow \mathbf{K}_{K \times H}\left(\mathrm{~T}_{K \times H}(\mathcal{U} \times K \cdot \mu)\right) \\
\left(\sigma_{1}, \sigma_{2}\right) & \longmapsto \sigma_{1} \odot \sigma_{2}
\end{aligned}
$$

so that $\operatorname{Index}{ }^{\mathcal{U} \times K \cdot \mu}\left(\sigma_{1} \odot \sigma_{2}\right)=\operatorname{Index}^{\mathcal{U}}\left(\sigma_{1}\right) \cdot \operatorname{Index}^{K \cdot \mu}\left(\sigma_{2}\right)$ in $R^{-\infty}(K \times H)$. See [1].
Consider now the case where $\mathcal{X}=N \times \overline{K \cdot \mu}, K_{1}=\{e\}$ and $K_{2}=K \times H$. After Theorem 2.5. we know that

$$
\begin{equation*}
\mathcal{Q}\left(\left(N / /{ }_{0} H\right)_{\mu}\right)=\left[\operatorname{Index}^{\mathcal{V}}\left(\mathbf{c}_{\mathcal{X}}^{\kappa} \mid \mathcal{V}\right)\right]^{K \times H} \tag{2.15}
\end{equation*}
$$

where $\kappa$ is the vector field on $N \times \overline{K \cdot \mu}$ associated to the moment map

$$
\begin{aligned}
\Phi: N \times \overline{K \cdot \mu} & \longrightarrow \mathfrak{k}^{*} \times \mathfrak{h}^{*} \\
(x, \xi) & \longmapsto\left(\Phi_{K}(x)-\xi, \Phi_{H}(n)\right)
\end{aligned}
$$

Note that $\mathcal{V}=\mathcal{U} \times K \cdot \mu$ is a neighborhood of $\Phi^{-1}(0) \subset\left(\Phi_{H}\right)^{-1}(0)$.

Our aim now is to prove that the quantities (2.14) and (2.15) are equal.
Since the definition of $\kappa$ needs the choice of an invariant scalar product on the Lie algebra $\mathfrak{k} \times \mathfrak{h}$, we will precise its definition. Let $\|\cdot\|_{K}$ and $\|\cdot\|_{H}$ be two invariant Euclidean norm respectively on $\mathfrak{k}$ and $\mathfrak{h}$. For any $r>0$ we consider on $\mathfrak{k} \times \mathfrak{h}$ the invariant Euclidean norm $\|(X, Y)\|_{r}^{2}=r^{2}\|X\|_{K}^{2}+\|Y\|_{H}^{2}$.

Let $\kappa^{K}$ be the vector field on $N \times \overline{K \cdot \mu}$ associated to the map $N \times \overline{K \cdot \mu} \rightarrow$ $\mathfrak{k}^{*},(x, \xi) \mapsto \Phi_{K}(x)-\xi$, and where the identification $\mathfrak{k} \simeq \mathfrak{k}^{*}$ is made through the Euclidean norm $\|\cdot\|_{K}$ (see (2.13)). For $(x, \xi) \in N \times \overline{K \cdot \mu}$, we have the decomposition

$$
\kappa^{K}(x, \xi)=\left(\kappa_{1}(x, \xi), \kappa_{2}(x, \xi)\right) \in \mathrm{T}_{x} N \times \mathrm{T}_{\xi} K \cdot \mu
$$

Let $\kappa^{H}$ be the vector field on $N \times \overline{K \cdot \mu}$ associated to the map $N \times \overline{K \cdot \mu} \rightarrow$ $\mathfrak{k}^{*},(x, \xi) \mapsto \Phi_{H}(x)$, and where the identification $\mathfrak{h} \simeq \mathfrak{h}^{*}$ is made through the Euclidean norm $\|\cdot\|_{H}$. For $(x, \xi) \in N \times \overline{K \cdot \mu}$, we have the decomposition

$$
\kappa^{H}(x, \xi)=\left(\kappa^{H}(x), 0\right) \in \mathrm{T}_{x} N \times \mathrm{T}_{\xi} K \cdot \mu .
$$

For any $r>0$, we denote by $\kappa_{r}$ the vector field on $N \times \overline{K \cdot \mu}$ associated to the map $\Phi$, and where the identification $\mathfrak{k} \times \mathfrak{h} \simeq \mathfrak{k}^{*} \times \mathfrak{h}^{*}$ is made through the Euclidean norm $\|\cdot\|_{r}$. We have then

$$
\begin{aligned}
\kappa_{r} & =\kappa^{H}+r \kappa^{K} \\
& =\left(\kappa^{H}+r \kappa_{1}, r \kappa_{2}\right)
\end{aligned}
$$

Now we can precise (2.15). Take an invariant relatively compact neighborhood $\mathcal{U}$ of $\Phi_{H}^{-1}(0)$ such that $\partial \mathcal{U} \cap\left\{\right.$ zeros of $\left.\kappa^{H}\right\}=\emptyset$. With the help of a invariant Riemannian metric on $\mathcal{X}$ we define

$$
\varepsilon_{H}=\inf _{x \in \partial \mathcal{U}}\left\|\kappa^{H}(x)\right\|>0 \quad \text { and } \quad \varepsilon_{K}=\sup _{(x, \xi) \in \partial \mathcal{U} \times K \cdot \mu}\left\|\kappa_{1}(x, \xi)\right\| .
$$

Note that for any $0 \leq r<\frac{\varepsilon_{H}}{\varepsilon_{K}}$, we have $\partial \mathcal{U} \times K \cdot \mu \cap\left\{\right.$ zeros of $\left.\kappa^{H}+r \kappa_{1}\right\}=\emptyset$, and then $\partial \mathcal{V} \cap\left\{\right.$ zeros of $\left.\kappa_{r}\right\}=\emptyset$ for the neighborhood $\mathcal{V}:=\mathcal{U} \times K \cdot \mu$ of $\Phi^{-1}(0)$. We can then use Theorem 2.5: for $0<r<\frac{\varepsilon_{H}}{\varepsilon_{K}}$ we have

$$
\mathcal{Q}\left(\left(N / /{ }_{0} H\right)_{\mu}\right)=\left[\operatorname{Index}^{\mathcal{V}}\left(\mathbf{c}_{\mathcal{X}}^{\kappa_{r}} \mid \mathcal{V}\right)\right]^{K \times H}
$$

We are now close to the end of the proof. Let us compare the symbols $\left.\mathbf{c}_{\mathcal{X}}^{\kappa_{\mathcal{F}}}\right|_{\mathcal{V}}$ and $\mathbf{c}_{N}^{\kappa H} \mid \mathcal{U} \odot \mathbf{c}_{-\mu}$ in $\mathbf{K}_{K \times H}\left(\mathrm{~T}_{K \times H}(\mathcal{U} \times K \cdot \mu)\right)$. First one sees that the symbols $\mathbf{c}_{\mathcal{X}}$ is equal to the product $\mathbf{c}_{N} \odot \mathbf{c}_{-\mu}$ hence the symbols $\mathbf{c}_{N}^{\kappa \kappa_{N}} \mid \mathcal{U} \odot \mathbf{c}_{-\mu}$ is equal to $\mathbf{c}_{\mathcal{X}}^{\kappa_{r}} \mid \mathcal{V}$ when $r=0$. Since for $r<\frac{\varepsilon_{H}}{\varepsilon_{K}}$ the path $\left.s \in[0, r] \rightarrow \mathbf{c}_{\mathcal{X}}^{\kappa_{s}}\right|_{\mathcal{V}}$ defines an homotopy of $K \times H$-transversally elliptic symbols on $\mathcal{V}$, we get

$$
\operatorname{Index}^{\mathcal{V}}\left(\mathbf{c}_{\mathcal{X}}^{\kappa_{r}} \mid \mathcal{V}\right)=\operatorname{Index}^{\mathcal{V}}\left(\mathbf{c}_{N}^{\kappa_{N}^{H}} \mid \mathcal{U} \odot \mathbf{c}_{-\mu}\right)
$$

and then $m_{\mu}=\mathcal{Q}\left(\left(N / /{ }_{0} H\right)_{\mu}\right)$.

## 3. Wonderful compactifications and symplectic cutting

In this section we use the wonderful compactifications of Concini-Procesi 13, 14 to perform symplectic cutting.
3.1. Wonderful compactifications : definitions. We study here the wonderfull compactifications from the Hamiltonian point of view.

We consider a compact connected Lie group $K$ and its complexification $K_{\mathbb{C}}$. Let $T$ be a maximal torus of $K$, and let $W:=N(T) / T$ be the Weyl group. Consider $\mathfrak{t}^{*}$, the dual of the Lie algebra of $T$, with the lattice $\wedge^{*}$ of real weights. Let $C_{K} \subset \mathfrak{t}^{*}$ be a Weyl chamber and let $\widehat{K}:=\wedge^{*} \cap C_{K}$ be the set dominants weights.

Definition 3.1. A polytope $P$ in $\mathfrak{t}^{*}$ is $K$-adapted if:
i) the vertices of $P$ are regular elements of $\wedge^{*}$,
ii) $P$ is $W$-invariant,
iii) $P$ is Delzant.

Example : When $K$ as a trivial center, the convex hull of $W \cdot \mu$ is a $K$-adapted polytope for any regular dominant weight $\mu$.
Proposition 3.2. There exists $K$-adapted polytopes in $\mathfrak{t}^{*}$.
Proof. Let us use the dictionary between polytopes and projective fan 27. Conditions $i i$ ) and $i i i$ ) of Definition 3.1 means that we are looking after a smooth projective $W$-invariant fan $\mathcal{F}$ in $\mathfrak{t}$. Condition $i$ ) means that each cone of $\mathcal{F}$ of maximal dimension should not be fixed by any element of $W \backslash\{\operatorname{Id}\}$. For a proof of the existence of search fan, see 11, 12. In particular condition (*) in Proposition 2 of 12 implies $i$ ).

In the rest of this section, we consider a $K$-adapted polytope $P$. Let $[P]_{1}$ be the union of all the closed facet of dimension 1 : we label the elements of $[P]_{1} \cap \widehat{K}$ by $\left\{\lambda_{1}, \cdots, \lambda_{N}\right\}$. Since $P$ is $K$-adapted, when $\lambda_{i}$ is a vertex of $P$ there exits $\alpha_{j_{1}}, \cdots, \alpha_{j_{r}}$ belonging to $[P]_{1} \cap \wedge^{*}=W \cdot\left\{\lambda_{1}, \cdots, \lambda_{N}\right\}$ such that $\alpha_{j_{1}}-\lambda_{i}, \cdots, \alpha_{j_{r}}-$ $\lambda_{i}$ is a basis of the lattice $\wedge^{*}$.

Let $V_{\lambda_{i}}$ be an irreducible representation of $K$ with eighest weight $\lambda_{i}$ : these representations extend canonically to the complexification $K_{\mathbb{C}}$. We denote $\rho: K_{\mathbb{C}} \rightarrow$ $\Pi_{i=1}^{N} G L\left(V_{\lambda_{i}}\right)$ the representation of $K_{\mathbb{C}}$ on $V:=\oplus_{i=1}^{N} V_{\lambda_{i}}$. We consider the vector space

$$
E=\oplus_{i=1}^{N} \operatorname{End}\left(V_{\lambda_{i}}\right)
$$

equipped with the action of $K_{\mathbb{C}} \times K_{\mathbb{C}}$ given by : $\left(g_{1}, g_{2}\right) \cdot f=\rho\left(g_{1}\right) \circ f \circ \rho\left(g_{2}\right)^{-1}$. Let $\mathbb{P}(E)$ the projective space associated to $E$ : it is equipped with an algebraic action of the reductive group $K_{\mathbb{C}} \times K_{\mathbb{C}}$. We consider the map $g \mapsto[\rho(g)]$ from $K_{\mathbb{C}}$ into $\mathbb{P}(E)$, that we denote $\bar{\rho}$.

Lemma 3.3. The map $\bar{\rho}: K_{\mathbb{C}} \rightarrow \mathbb{P}(E)$ is an embedding.
Proof. Let $g \in K_{\mathbb{C}}$ such that $\bar{\rho}(g)=[I d]$ : there exist $a \in \mathbb{C}^{*}$ such that $\rho(g)=a I d$. The Cartan decomposition gives

$$
\begin{equation*}
\rho(k)=\frac{a}{|a|} I d \quad \text { and } \quad \rho\left(e^{i X}\right)=|a| I d \tag{3.16}
\end{equation*}
$$

for $g=k e^{i X}$ with $k \in K$ and $X \in \mathfrak{k}$. Since there exist $Y, Y^{\prime} \in \mathfrak{t}$ and $u, u^{\prime} \in K$ such that $k=u e^{Y} u^{-1}$ and $X=u^{\prime} \cdot Y^{\prime}$, (3.16) gives

$$
\begin{equation*}
\rho\left(e^{Y}\right)=\frac{a}{|a|} I d \quad \text { and } \quad \rho\left(e^{i Y^{\prime}}\right)=|a| I d \tag{3.17}
\end{equation*}
$$

Since each element of $[P]_{1} \cap \wedge^{*}=W \cdot\left\{\lambda_{1}, \cdots, \lambda_{N}\right\}$ is a weight for the action of $T_{\mathbb{C}}$ on $\left.\oplus_{i=1}^{N} V_{\lambda_{i}}, 3.17\right)$ implies that for every $\alpha \in[P]_{1} \cap \wedge^{*}$ we have

$$
\begin{equation*}
e^{i\langle\alpha, Y\rangle}=\frac{a}{|a|} \quad \text { and } \quad e^{-\left\langle\alpha, Y^{\prime}\right\rangle}=|a| . \tag{3.18}
\end{equation*}
$$

Since there exists $\alpha_{j_{0}}, \cdots, \alpha_{j_{r}} \in[P]_{1} \cap \wedge^{*}$ such that $\alpha_{j_{1}}-\alpha_{j_{0}}, \cdots, \alpha_{j_{r}}-\alpha_{j_{0}}$ is a basis of the lattice $\wedge^{*}$, (3.18) implies that $Y^{\prime}=0$ and that $Y \in \operatorname{ker}\left(Z \in \mathfrak{t} \rightarrow e^{Z}\right)$. We have proved that $g=e$.

Let $T_{\mathbb{C}} \subset K_{\mathbb{C}}$ the complexification of the (compact) torus $T \subset K$.
Definition 3.4. Let $\mathcal{X}_{P}$ be the Zarisky closure of $\bar{\rho}\left(K_{\mathbb{C}}\right)$ in $\mathbb{P}(E)$ and let $\mathcal{Y}_{P} \subset \mathcal{X}_{P}$ be the Zarisky closure of $\bar{\rho}\left(T_{\mathbb{C}}\right)$ in $\mathbb{P}(E)$.

Since $\bar{\rho}\left(K_{\mathbb{C}}\right)=K_{\mathbb{C}} \times K_{\mathbb{C}} \cdot[I d]$ and $\bar{\rho}\left(T_{\mathbb{C}}\right)=T_{\mathbb{C}} \times T_{\mathbb{C}} \cdot[I d]$ are orbits of algebraic group actions their Zariski closures coincide with their closures for the Euclidean topology.

Theorem 3.5. The varities $\mathcal{X}_{P}$ and $\mathcal{Y}_{P}$ are smooth.
The proof will be done in the next section
3.2. Smoothness of $\mathcal{X}_{P}$ and $\mathcal{Y}_{P}$. Let $E$ be a complex vector space equipped with a linear action of a reductive group $G$. Let $\mathcal{Z} \subset \mathbb{P}(E)$ be a projective variety which is $G$-stable. We have the classical fact

Lemma 3.6. • Z possess closed $G$-orbits.

- $\mathcal{Z}$ is smooth if $\mathcal{Z}$ is smooth near its closed $G$-orbits.

Proof. Let $z_{0} \in \mathcal{Z}$ and consider the Zariski closure $\overline{G \cdot z_{0}} \subset \mathcal{Z}$. If $G \cdot z_{0}$ is not closed, we take $z_{1} \in \overline{G \cdot z_{0}} \backslash G \cdot z_{0}$ : we have $\operatorname{dim} G \cdot z_{1}<\operatorname{dim} G \cdot z_{0}$. By induction we find a sequence $z_{1}, \cdots, z_{p}$ with $z_{k+1} \in \overline{G \cdot z_{k}} \backslash G \cdot z_{k}$ for $k<p$ and $G \cdot z_{p}$ closed. For the second point, we have just to note that if $\mathcal{Z}$ is singular, the subvariety $\mathcal{Z}^{\text {sing }} \subset \mathcal{Z}$ of singular points is $G$-stable and then contains a closed $G$-orbits.

We are interested here respectively in

- the $K_{\mathbb{C}} \times K_{\mathbb{C}}$-variety $\mathcal{X}_{P} \subset \mathbb{P}(E) \subset \mathbb{P}(\operatorname{End}(V))$
- the $T_{\mathbb{C}} \times T_{\mathbb{C}}$-variety $\mathcal{Y}_{P} \subset \mathbb{P}(E)$.

Since the diagonal $Z_{\mathbb{C}}=\left\{(t, t) \mid t \in T_{\mathbb{C}}\right\}$ stabilizes $[I d]$, its action on $\mathcal{Y}_{P}$ is trivial. Hence we will restrict ourself to the action of $T_{\mathbb{C}} \times T_{\mathbb{C}} / Z_{\mathbb{C}} \simeq T_{\mathbb{C}}$ on $\mathcal{Y}_{P}$ : for $t \in T_{\mathbb{C}}$ and $[y] \in \mathcal{Y}_{P}$ we take $t \cdot[y]=[\rho(t) \circ y]$.
3.2.1. The case of $\mathcal{Y}_{P}$. We apply Lemma 3.6 to the $T_{\mathbb{C}}$-variety $\mathcal{Y}_{P}=\overline{T_{\mathbb{C}} \cdot[I d]}$ in $\mathbb{P}(E)$. Let $\left\{\alpha_{j}, j \in J\right\}$ be the $T_{\mathbb{C}}$ weights on $\left(\oplus_{i=1}^{N} V_{\lambda_{i}}, \rho\right)$ counted with their multiplicity. Their exists a orthonormal basis $\left\{v_{j}, j \in J\right\}$ of $\oplus_{i=1}^{N} V_{\lambda_{i}}$ such that $I d=\sum_{j \in J} v_{j} \otimes v_{j}^{*}$ and

$$
\begin{equation*}
\rho\left(e^{Z}\right)=\sum_{j \in J} e^{i\left\langle\alpha_{j}, Z\right\rangle} v_{j} \otimes v_{j}^{*}, \quad Z \in \mathfrak{t}_{\mathbb{C}} . \tag{3.19}
\end{equation*}
$$

So the action of $e^{Z} \in T_{\mathbb{C}}$ on $[I d] \in \mathbb{P}(E)$ is $e^{Z} \cdot[I d]=\left[\sum_{j \in J} e^{i\left\langle\alpha_{j}, Z\right\rangle} v_{j} \otimes v_{j}^{*}\right]$. We introduce a subset $J^{\prime}$ of $J$ such that for every $j \in J$ there exists a unique $j^{\prime} \in J^{\prime}$ such that $\alpha_{j}=\alpha_{j^{\prime}}$. So the variety $\mathcal{Y}_{P}$ belongs to $\mathbb{P}\left(E^{\prime}\right)$ where $E^{\prime}=\oplus_{j^{\prime} \in J^{\prime}} \mathbb{C} m_{j^{\prime}}$ with $m_{j^{\prime}}=\sum_{j, \alpha_{j}=\alpha_{j^{\prime}}} v_{j} \otimes v_{j}^{*}$. The closed $T_{\mathbb{C}}$ orbits in $\mathbb{P}\left(E^{\prime}\right)$ are $\left[m_{j^{\prime}}\right], j^{\prime} \in J$.

Lemma 3.7. $\left[m_{j_{o}}\right] \in \mathcal{Y}_{P}$ if and only if $\alpha_{j_{o}}$ is a vertex of the polytope $P$.
Proof. If $\alpha_{j_{o}}$ is a vertex of $P$, there exists $X \in \mathfrak{t}$ such that $\left\langle\alpha_{j_{o}}, X\right\rangle>\left\langle\alpha_{j}, X\right\rangle$ whenever $\alpha_{j_{o}} \neq \alpha_{j}$. Hence $e^{-i s X} .[I d]$ tends to $\left[m_{j_{o}}\right]$ when $s \rightarrow+\infty$. If $\alpha_{j_{o}}$ is not a vertex of $P$, there exist $L \subset J^{\prime} \backslash\left\{j_{o}\right\}$ such that $\alpha_{j_{o}}=\sum_{l \in L} a_{l} \alpha_{l}$ with $0<a_{l}<1$ and $\sum_{l} a_{l}=1$. So $\mathcal{Y}_{P}$ belongs to the closed subset defined by

$$
\left[\sum_{j^{\prime} \in J^{\prime}} \delta_{j^{\prime}} m_{j^{\prime}}\right] \in \mathbb{P}\left(E^{\prime}\right) \quad \text { such that } \quad \Pi_{l \in L}\left|\delta_{l}\right|^{a_{l}}=\left|\delta_{j_{o}}\right| .
$$

Hence $\left[m_{j_{o}}\right] \notin \mathcal{Y}_{P}$.
Remark 3.8. When $\alpha_{j}$ is a vertex of the polytope $P$, the multiplicity of $\alpha_{j}$ in $\oplus_{i=1}^{N} V_{\lambda_{i}}$ is equal to one, so $m_{j}=v_{j} \otimes v_{j}^{*}$.

Consider now a vertex $\alpha_{j_{o}}$ of $P$ (for $\left.j_{o} \in J^{\prime}\right)$. We consider the open subset $\mathcal{V} \subset \mathbb{P}\left(E^{\prime}\right)$ defined by $\left[\sum_{j^{\prime} \in J^{\prime}} \delta_{j^{\prime}} m_{j^{\prime}}\right] \in \mathcal{V} \Leftrightarrow \delta_{j_{o}} \neq 0$, and the diffeomorphism $\psi: \mathcal{V} \rightarrow \mathbb{C}^{J^{\prime} \backslash\left\{j_{o}\right\}},\left[\sum_{j^{\prime} \in J^{\prime}} \delta_{j^{\prime}} m_{j^{\prime}}\right] \mapsto\left(\frac{\delta_{j^{\prime}}}{\delta_{j_{o}}}\right)_{j^{\prime} \neq j_{o}}$. The map $\psi$ realizes an algebraic diffeomorphism between $\mathcal{Y}_{P} \cap \mathcal{V}$ and the affine subvariety

$$
\mathcal{Z}:=\overline{\left\{\left(t^{\alpha_{j^{\prime}}-\alpha_{j_{o}}}\right)_{j^{\prime} \neq j_{o}} \mid t \in T_{\mathbb{C}}\right\}} \subset \mathbb{C}^{J^{\prime} \backslash\left\{j_{o}\right\}} .
$$

The set of weights $\alpha_{j}, j \in J$ contains all the lattice points that belongs to the one dimensional faces of $P$. Since the polytope $P$ is $K$-adapted, there exists a subset $L_{j_{o}} \subset J^{\prime}$ such that $\alpha_{l}-\alpha_{j_{o}}, l \in L_{j_{o}}$ is a $\mathbb{Z}$-basis of the group of weights $\wedge^{*}$. And for every $j^{\prime} \neq j_{o}$ we have

$$
\begin{equation*}
\alpha_{j^{\prime}}-\alpha_{j_{o}}=\sum_{l \in L_{j_{o}}} n_{j^{\prime}}^{l}\left(\alpha_{l}-\alpha_{j_{o}}\right) \quad \text { with } \quad n_{j^{\prime}}^{l} \in \mathbb{N} . \tag{3.20}
\end{equation*}
$$

We define on $\mathbb{C}^{L_{j o}}$ the monomials $P_{j^{\prime}}(Z)=\Pi_{l \in L_{j_{o}}}\left(Z_{l}\right)^{n_{j^{\prime}}^{l}}$. Note that $P_{j^{\prime}}(Z)=Z_{l}$ when $j^{\prime}=l \in L_{j_{o}}$. Now it is not difficult to see that the map

$$
\begin{aligned}
\mathbb{C}^{L_{j_{o}}} & \longrightarrow \mathbb{C}^{J^{\prime} \backslash\left\{j_{o}\right\}} \\
Z & \longmapsto\left(P_{j^{\prime}}(Z)\right)_{j^{\prime} \neq j_{o}}
\end{aligned}
$$

realizes an algebraic diffeomorphism between $\mathbb{C}^{L_{j_{o}}}$ and $\mathcal{Z}$.
Finally we have shown that $\mathcal{Y}_{P}$ is smooth near $\left[m_{j_{o}}\right]$ : hence $\mathcal{Y}_{P}$ is a smooth subvariety of $\mathbb{P}(E)$. Since $T_{\mathbb{C}}$ acts on $\mathcal{Y}_{P}$ with a dense orbit, $\mathcal{Y}_{P}$ is a smooth projective toric variety.
3.2.2. The case of $\mathcal{X}_{P}$. Let $E:=\otimes_{i=1}^{N} \operatorname{End}\left(V_{\lambda_{i}}\right)$. The closed $K_{\mathbb{C}} \times K_{\mathbb{C}}$-orbit in $\mathbb{P}(E)$ are those passing through $\left[v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*}\right]$ where $v_{\lambda_{i}} \in V_{\lambda_{i}}$ is a highest weight vector (that we take of norm 1 for a $K$-invariant hermitian structure).
Lemma 3.9. $\left[v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*}\right] \in \mathcal{X}_{P}$ if and only if $\lambda_{i}$ is a vertex of the polytope $P$.
Proof. If $\lambda_{i}$ is a vertex of $P$, we have proved in Lemma 3.7 that $\left[v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*}\right]$ belongs to $\mathcal{Y}_{P}$ and so belongs to $\mathcal{X}_{P}$. We prove the converse in Corollary 3.14.

For the remaining of this section we consider a vertex $\lambda_{i_{o}} \in \widehat{K}$ of the polytope $P$. Let $B^{+}, B^{-}$the Borel subgroups fixing respectively the elements $\left[v_{\lambda_{i_{o}}}\right] \in \mathbb{P}\left(V_{\lambda_{i}}\right)$ and $\left[v_{\lambda_{i_{o}}}^{*}\right] \in \mathbb{P}\left(V_{\lambda_{i}}^{*}\right)$. Consider also the unipotent subgroups $N^{ \pm} \subset B^{ \pm}$fixing respectively the elements $v_{\lambda_{i}} \in V_{\lambda_{i}}$ and $v_{\lambda_{i}}^{*} \in V_{\lambda_{i}}^{*}$.

We consider the open subset $\mathcal{V}_{\text {End }} \subset \mathbb{P}(E)$ of elements $[f]$ such that $\left\langle v_{\lambda_{i_{o}}}^{*}, f\left(v_{\lambda_{i_{o}}}\right)\right\rangle \neq 0: \mathcal{V}_{\text {End }}$ is $B^{-} \times B^{+}$stable. Consider the open subset $\mathcal{V} \subset \mathbb{P}\left(V_{\lambda_{i_{o}}}\right)$ and $\left.\mathcal{V}^{*} \subset \mathbb{P}\left(V_{\lambda_{i_{o}}}^{*}\right)\right)$ defined by :

- $[v] \in \mathcal{V} \Leftrightarrow\left\langle v_{\lambda_{i_{o}}}^{*}, v\right\rangle \neq 0: \mathcal{V}$ is $B^{-}$stable,
- $[\xi] \in \mathcal{V}^{*} \Leftrightarrow\left\langle\xi, v_{\lambda_{i_{o}}}\right\rangle \neq 0: \mathcal{V}^{*}$ is $B^{+}$stable.

We consider now the rational maps $l: \mathbb{P}(E) \rightarrow \mathbb{P}\left(V_{\lambda_{i_{o}}}\right), f \mapsto f\left(v_{\lambda_{i_{o}}}\right)$ and $r$ : $\mathbb{P}(E) \rightarrow \mathbb{P}\left(V_{\lambda_{i_{o}}}^{*}\right), f \mapsto v_{\lambda_{i_{o}}}^{*} \circ f$. The map $l$ and $r$ are defined on $\mathcal{V}_{\text {End }}$ : they defined respectively $B^{-}$-equivariant map from $\mathcal{V}_{\text {End }}$ into $\mathcal{V}$, and $B^{+}$-equivariant map from $\mathcal{V}_{\text {End }}$ into $\mathcal{V}^{*}$.

The orbits $K_{\mathbb{C}} \cdot v_{\lambda_{i_{o}}} \subset \mathbb{P}\left(V_{\lambda_{i_{o}}}\right)$ and $K_{\mathbb{C}} \cdot v_{\lambda_{i_{o}}}^{*} \subset \mathbb{P}\left(V_{\lambda_{i_{o}}}^{*}\right)$ are closed and we have

$$
\begin{aligned}
K_{\mathbb{C}} \cdot v_{\lambda_{i_{o}}} \cap \mathcal{V} & =N^{-} \cdot v_{\lambda_{i_{o}}} \simeq N^{-} \\
K_{\mathbb{C}} \cdot v_{\lambda_{i_{o}}}^{*} \cap \mathcal{V}^{*} & =N^{+} \cdot v_{\lambda_{i_{o}}}^{*} \simeq N^{+}
\end{aligned}
$$

The rational map $(l, r): \mathbb{P}(E) \rightarrow \mathbb{P}\left(V_{\lambda_{i_{o}}}\right) \times \mathbb{P}\left(V_{\lambda_{i_{o}}}^{*}\right)$ induced then a map $q$ : $\mathcal{V}_{\text {End }} \cap \mathcal{X}_{P} \rightarrow N^{-} \times N^{+}$which is $N^{-} \times N^{+}$-equivariant :

$$
q\left(\left(n^{-}, n^{+}\right) \cdot x\right)=\left(n^{-}, n^{+}\right) \times q(x)
$$

for $x \in \mathcal{V}_{\text {End }} \cap \mathcal{X}_{P}$, and $n^{ \pm} \in N^{ \pm}$.
We can now finish the arguments. The set $N^{-} T_{\mathbb{C}} N^{+} \subset K_{\mathbb{C}}$ is dense in $K_{\mathbb{C}}$, so it is now easy to see that the map

$$
\begin{array}{rll}
N^{-} \times N^{+} \times \mathcal{Y}_{P} \cap \mathcal{V}_{\text {End }} & \longrightarrow \mathcal{X}_{P} \cap \mathcal{V}_{\text {End }} \\
\left(n^{-}, n^{+}, y\right) & \longmapsto & \left(n^{-}, n^{+}\right) \cdot y
\end{array}
$$

is a diffeomorphism. We have proved previously that $\mathcal{Y}_{P} \cap \mathcal{V}_{\text {End }}$ is a smooth affine variety, hence $\mathcal{X}_{P}$ is smooth near the closed orbit $K_{\mathbb{C}} \times K_{\mathbb{C}} \cdot\left[v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*}\right] \subset \mathcal{X} \cap \mathcal{V}_{\text {End }}$. Lemma 3.6 tells us then that $\mathcal{X}_{P}$ is smooth.
3.3. Hamiltonian actions. First consider an Hermitian vector space $V$. The Hermitian structure on $\operatorname{End}(V)$ is $(A, B):=\operatorname{Tr}\left(A B^{*}\right)$, hence the associated symplectic struture on $\operatorname{End}(V)$ is defined by the relation $\Omega_{\mathrm{End}}(A, B):=-\operatorname{Im}\left(\operatorname{Tr}\left(A B^{*}\right)\right)$.

Let $U(V)$ be the unitary group. Let $\mathfrak{u}(V)$ be the Lie algebra of $U(V)$. We will use the identification $\epsilon: \mathfrak{u}(V) \simeq \mathfrak{u}(V)^{*}, X \mapsto \epsilon_{X}$ where $\epsilon_{X}(Y)=-\operatorname{Tr}(X Y)$. The action $U(V) \times U(V)$ on $\operatorname{End}(V)$ is $(g, h) \cdot A=g A h^{-1}$. The moment map relative to this action is

$$
\begin{aligned}
\operatorname{End}(V) & \longrightarrow \mathfrak{u}(V)^{*} \times \mathfrak{u}(V)^{*} \\
A & \longmapsto \frac{-1}{2}\left(i A A^{*},-i A^{*} A\right) .
\end{aligned}
$$

We consider now the projective space $\mathbb{P}(\operatorname{End}(V))$ equipped with the Fubini-Study symplectic form $\Omega_{\mathrm{FS}}$. Here the action of $U(V) \times U(V)$ on $\mathbb{P}(\operatorname{End}(V))$ is hamiltonian with moment map

$$
\begin{aligned}
\mathbb{P}(\operatorname{End}(V)) & \longrightarrow \mathfrak{u}(V)^{*} \times \mathfrak{u}(V)^{*} \\
{[A] } & \longmapsto\left(\frac{i A A^{*}}{\|A\|^{2}}, \frac{-i A^{*} A}{\|A\|^{2}}\right) .
\end{aligned}
$$

where $\|A\|^{2}=\operatorname{Tr}\left(A A^{*}\right)$ (see [26] [Section 7]). If $\rho: K \hookrightarrow U(V)$ is a connected Lie subgroup, we can consider the action of $K \times K$ on $\mathbb{P}(\operatorname{End}(V))$. Let $\pi_{K}: \mathfrak{u}(V)^{*} \rightarrow \mathfrak{k}^{*}$
be the projection which is dual to the inclusion $\rho: \mathfrak{k} \hookrightarrow \mathfrak{u}(V)$. The moment map for the action of $K \times K$ on $\left(\mathbb{P}(\operatorname{End}(V)), \Omega_{\mathrm{FS}}\right)$ is then

$$
\begin{align*}
\mathbb{P}(\operatorname{End}(V)) & \longrightarrow \mathfrak{k}^{*} \times \mathfrak{k}^{*}  \tag{3.21}\\
{[A] } & \longmapsto \frac{1}{\|A\|^{2}}\left(\pi_{K}\left(i A A^{*}\right),-\pi_{K}\left(i A^{*} A\right)\right) .
\end{align*}
$$

We are interested here respectively in

- the projective variety $\mathcal{X}_{P} \subset \mathbb{P}(\operatorname{End}(V))$ with the action of $K \times K$,
- the projective variety $\mathcal{Y}_{P} \subset \mathbb{P}(\operatorname{End}(V))$ with the action of $T \times T$, where $V=\oplus_{i=1}^{N} V_{\lambda_{i}}$. The Fubini-Study two-form restrict into symplectic forms on $\mathcal{X}_{P}$ and $\mathcal{Y}_{P}$. The action of $K \times K$ on $\mathcal{X}_{P}$ is Hamiltonian with moment map

$$
\begin{align*}
\Phi_{K \times K}: \mathcal{X}_{P} & \longrightarrow \mathfrak{k}^{*} \times \mathfrak{k}^{*}  \tag{3.22}\\
{[x] } & \longmapsto \frac{1}{\|x\|^{2}}\left(\pi_{K}\left(i x x^{*}\right),-\pi_{K}\left(i x^{*} x\right)\right) .
\end{align*}
$$

Since the diagonal $Z=\{(t, t) \mid t \in T\}$ acts trivially on $\mathcal{Y}_{P}$ we restrict ourself to the action of $T \times T / Z \simeq T$ on $\mathcal{Y}_{P}$. Let us compute the moment map $\Phi_{T}: \mathcal{Y}_{P} \rightarrow \mathfrak{t}^{*}$ associated to this action. First we have

$$
\begin{equation*}
\Phi_{T}([y])=\frac{\pi_{T}\left(i y^{*} y\right)}{\|y\|^{2}}=\frac{\pi_{T}\left(i y y^{*}\right)}{\|y\|^{2}} \tag{3.23}
\end{equation*}
$$

where $\pi_{T}: \mathfrak{u}(V)^{*} \rightarrow \mathfrak{t}^{*}$ is the projection which is dual to $\rho: \mathfrak{t} \rightarrow \mathfrak{u}(V)$. Since $\rho(X)=i \sum_{j \in J} \alpha_{j}(X) v_{j} \otimes v_{j}^{*}$, a small computation shows that for $B \in \mathfrak{u}(V) \simeq \mathfrak{u}(V)^{*}$ we have $\pi_{T}(B)=-i \sum_{j \in J}\left(B v_{j}, v_{j}\right) \alpha_{j}$. Finally for any $[y] \in \mathcal{Y}_{P}$ we get

$$
\Phi_{T}([y])=\sum_{j \in J} \frac{\left\|y v_{j}\right\|^{2}}{\|y\|^{2}} \alpha_{j} .
$$

Together with the action on $T$, we have also an action of the Weyl group $W=$ $N(T) / T$ on $\mathcal{Y}_{P}:$ for $\bar{w} \in W$ we take

$$
\begin{equation*}
\bar{w} \cdot[y]=\left[\rho(w) \circ y \circ \rho(w)^{-1}\right], \quad[y] \in \mathcal{Y}_{P} \tag{3.24}
\end{equation*}
$$

This action is well defined since the diagonal $Z \subset T \times T$ acts trivially on $\mathcal{Y}_{P}$. The set of weights $\left\{\alpha_{j}, j \in J\right\}$ is stable under the action of $W$, hence it is an easy fact to verify that the map $\Phi_{T}$ is $W$-equivariant.

A dense part of $\mathcal{Y}_{P}$ is formed by the elements $e^{Z} \cdot[I d]=\left[\rho\left(e^{Z}\right)\right]$. Take $Z=$ $X+i Y \in \mathfrak{t}_{\mathbb{C}}$. We have $\Phi_{T}\left(e^{Z} \cdot[I d]\right)=\psi_{T}(Y) \in \mathfrak{t}^{*}$ with

$$
\begin{equation*}
\psi_{T}(Y)=\frac{1}{\sum_{j \in J} e^{-2\left\langle\alpha_{j}, Y\right\rangle}} \sum_{j \in J} e^{-2\left\langle\alpha_{j}, Y\right\rangle} \alpha_{j} \tag{3.25}
\end{equation*}
$$

Hence the image of the moment map $\Phi_{T}: \mathcal{Y}_{P} \rightarrow \mathfrak{t}^{*}$ is equal to the closure of the image of the map $\psi_{T}: \mathfrak{t} \rightarrow \mathfrak{t}^{*}$.
Proposition 3.10. The map $\psi_{T}$ realises a diffeomorphism between $\mathfrak{t}$ and the interior of the polytope $P \subset \mathfrak{t}^{*}$.
Proof. Consider the function $F_{T}: \mathfrak{t} \rightarrow \mathbb{R}, F_{T}(Y)=\ln \left(\sum_{j} e^{\left\langle\alpha_{j}, Y\right\rangle}\right)$, and let $L_{T}: \mathfrak{t} \rightarrow \mathfrak{t}^{*}$ be its Legendre transform : $L_{T}(X)=\left.d F_{T}\right|_{X}$. Note that we have $L_{T}(-2 Y)=\psi_{T}(Y)$.

We see that $F_{T}$ is strictly convex. So, it is a classical fact that $L_{T}$ realizes a diffeomorphism of $\mathfrak{t}$ onto its image, and for $\xi \in \mathfrak{t}^{*}$ we have

$$
\begin{aligned}
\xi \in \operatorname{Image}\left(L_{T}\right) & \Leftrightarrow \lim _{Y \rightarrow \infty} F_{T}(Y)-\langle\xi, Y\rangle=\infty \\
& \Leftrightarrow \lim _{Y \rightarrow \infty} \sum_{j \in J} e^{\left\langle\alpha_{j}-\xi, Y\right\rangle}=\infty
\end{aligned}
$$

In order to conclude we need the following
Lemma 3.11. Let $\left\{\beta_{j}, j \in J\right\}$ be a sequence of elements of $\mathfrak{t}^{*}$, and let $Q$ be its convex hull. We have

$$
\lim _{Y \rightarrow \infty} \sum_{j \in J} e^{\left\langle\beta_{j}, Y\right\rangle}=\infty \Longleftrightarrow 0 \in \operatorname{Interior}(Q)
$$

Proof. First we see that $0 \notin \operatorname{Interior}(Q)$ if and only there exists $v \in \mathfrak{t}-\{0\}$ such that $\left\langle\beta_{j}, v\right\rangle \leq 0$ for all $j$ : for such vector $v$, the map $t \rightarrow \sum_{j \in J} e^{t\left\langle\beta_{j}, v\right\rangle}$ is bounded. Suppose now that $\lim _{Y \rightarrow \infty} \sum_{j \in J} e^{\left\langle\beta_{j}, Y\right\rangle} \neq \infty$. Then there exists a sequence $\left(X_{k}\right)_{k} \in \mathfrak{t}$ such that $\lim _{k}\left|X_{k}\right|=\infty$ and for all $j$ the sequence $\left(\left\langle\beta_{j}, X_{k}\right\rangle\right)_{k}$ remains bounded. If $v$ is a limit of a subsequence of $\left(\frac{X_{k}}{\left|X_{k}\right|}\right)_{k}$ we have then $\left\langle\beta_{j}, v\right\rangle \leq 0$ for all $j$.

Lemma 3.12. For $[y] \in \mathcal{Y}_{P}$ we have $\Phi_{K \times K}([y])=\left(\Phi_{T}([y]),-\Phi_{T}([y])\right)$.
Proof. It's sufficient to consider the case $y=\rho\left(e^{Z}\right)=\sum_{j \in J} e^{i\left\langle\alpha_{j}, Z\right\rangle} v_{j} \otimes v_{j}^{*}$, for $Z=X+i Y \in \mathfrak{t}_{\mathbb{C}}$. Then $y y^{*}=y^{*} y=\sum_{j} e^{-2\left\langle\alpha_{j}, Y\right\rangle} v_{j} \otimes v_{j}^{*}=\rho\left(e^{2 i Y}\right)$. So it remains to prove that $\pi_{K}\left(i y y^{*}\right)=\pi_{T}\left(i y y^{*}\right)$. We have to check that $\left\langle\pi_{K}\left(i y y^{*}\right),[U, V]\right\rangle=0$ for $U \in \mathfrak{t}$ and $V \in \mathfrak{k}$. We have

$$
\begin{aligned}
\left\langle\pi_{K}\left(i y y^{*}\right),[U, V]\right\rangle & =-i \operatorname{Tr}\left(y y^{*} \rho([U, V])\right) \\
& =-i \operatorname{Tr}\left(\rho\left(e^{2 i Y}\right)[\rho(U), \rho(V)]\right) \\
& =-i \operatorname{Tr}\left(\left[\rho\left(e^{2 i Y}\right), \rho(U)\right] \rho(V)\right)=0
\end{aligned}
$$

Theorem 3.13. We have

- Image $\left(\Phi_{T}\right)=P$,
- Image $\left(\Phi_{K \times K}\right)=\left\{\left(k_{1} \cdot \xi,-k_{2} \cdot \xi\right) \mid \xi \in P\right.$ and $\left.k_{1}, k_{2} \in K\right\}$,
- $\mathcal{Y}_{P} \subset \Phi_{K \times K}^{-1}\left(\mathrm{t}^{*} \times \mathfrak{t}^{*}\right)$,
- $\Phi_{K \times K}^{-1}(\operatorname{interior}(\mathcal{C})) \subset \mathcal{Y}_{P}$, where $\mathcal{C}=C_{K} \times-C_{K}$.

Proof. The first point follows from Proposition 3.10. Since the map $\left(k_{1}, t, k_{2}\right) \mapsto$ $k_{1} t k_{2}$ from $K \times T_{\mathbb{C}} \times K$ into $K_{\mathbb{C}}$ is onto, we have

$$
\begin{equation*}
\mathcal{X}_{P}=(K \times K) \cdot \mathcal{Y}_{P} \tag{3.26}
\end{equation*}
$$

So if $[x] \in \mathcal{X}_{P}$, there exist $[y] \in \mathcal{Y}$ and $k_{1}, k_{2} \in K$ such that $[x]=\left(k_{1}, k_{2}\right) \cdot[y]$, hence

$$
\begin{align*}
\Phi_{K \times K}([x]) & =\left(k_{1}, k_{2}\right) \cdot \Phi_{K \times K}([y]) \\
& =\left(k_{1} \cdot \Phi_{T}([y]),-k_{2} \cdot \Phi_{T}([y])\right) \tag{3.27}
\end{align*}
$$

The second point is proved. The third point follows also from the identity (3.27) when $k_{1}=k_{2}=e$. Consider now $[x]=\left(k_{1}, k_{2}\right) \cdot[y]$ such that $\Phi_{K \times K}([x])$ belongs to
the interior of the cone $C_{K} \times-C_{K}$. Then $k_{1} \cdot \Phi_{T}([y])$ and $k_{2} \cdot \Phi_{T}([y])$ are regular points of $C_{K}$. This implies that $k_{1}, k_{2} \in N(T)$ and $k_{2} k_{1}^{-1} \in T$. So

$$
\begin{aligned}
{[x] } & =\left(k_{1}, k_{2}\right) \cdot[y] \\
& =\left(e, k_{2} k_{1}^{-1}\right) \cdot\left(\left(k_{1}, k_{1}\right) \cdot[y]\right) \in \mathcal{Y}_{P}
\end{aligned}
$$

since $\mathcal{Y}_{P}$ is stable under the actions of $T \times T$ and $W$.
Corollary 3.14. If $\left[v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*}\right] \in \mathcal{X}_{P}$ then $\lambda_{i}$ is a vertex of the polytope $P$.
Proof. Let $x=v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*}$, and suppose that $[x]$ belongs to $\mathcal{X}_{P}$. In order to show that $[x] \in \mathcal{Y}_{P}$, we compute $\Phi_{K \times K}([x])$. We see that $x x^{*}=x^{*} x=x$ and $\|x\|=1$ so $\Phi_{K \times K}([x])=\left(\pi_{K}(i x),-\pi_{K}(i x)\right)$. For $X \in \mathfrak{k}$ we have

$$
\begin{aligned}
\left\langle\pi_{K}(i x), X\right\rangle & =-i \operatorname{Tr}\left(v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*} \rho(X)\right) \\
& =-i\left(\rho(X) v_{\lambda_{i}}, v_{\lambda_{i}}\right) \\
& =\left\langle\lambda_{i}, X\right\rangle .
\end{aligned}
$$

We have then $\Phi_{K \times K}([x])=\left(\lambda_{i},-\lambda_{i}\right)$ with $\lambda_{i}$ beiing a regular point of $C_{K}$ : hence $[x] \in \mathcal{Y}_{P}$. Now we can conclude with the help of Lemma 3.7. Since $\left[v_{\lambda_{i}} \otimes v_{\lambda_{i}}^{*}\right]$ belongs to $\mathcal{Y}_{P}$, the weight $\lambda_{i}$ is a vertex of the polytope $P$.
Remark 3.15. In this section, Theorem 3.1 was obtain without using the fact that the varieties $\mathcal{X}_{P}$ and $\mathcal{Y}_{P}$ are smooth. Hence Corollary 3.14 can be used to prove the smoothness of $\mathcal{X}_{P}$.
3.4. Symplectic cutting. Let $\left(M, \Omega_{M}, \Phi_{M}\right)$ be an Hamiltonian $K$-manifold. At this stage the moment map $\Phi_{M}$ is not assumed to be proper. We consider also the Hamiltonian $K \times K$-manifold $\mathcal{X}_{P}$ associated to a $K$-adapted polytope $P$.

The purpose of this section is to define a symplectic cutting of $M$ which uses $\mathcal{X}_{P}$. The notion of symplectic cutting was introduced by Lerman in 21 in the case of a torus action. Later Woodward [35] extends this procedure to the case of a non-abelian group action (see also 24). The method of symplectic cutting that we define in this section is different from the one of Woodward.

We have two actions of $K$ on $\mathcal{X}_{P}$ : the action from the left (resp. right), denoted ${ }_{l}$ (resp. $\cdot_{r}$ ), with moment map $\Phi_{l}: \mathcal{X}_{P} \rightarrow \mathfrak{k}^{*}$ (resp. $\Phi_{r}$ ). We consider now the product of $M \times \mathcal{X}_{P}$ with

- the action $k \cdot 1(m, x)=(k \cdot m, k \cdot r x)$ : the corresponding moment map is $\Phi_{1}(m, x)=\Phi_{M}(m)+\Phi_{r}(x)$,
- the action $k \cdot{ }_{2}(m, x)=\left(m, k \cdot{ }_{l} x\right)$ : the corresponding moment map is $\Phi_{2}(m, x)=\Phi_{l}(x)$.
Definition 3.16. We denote $M_{P}$ the symplectic reduction at 0 of $M \times \mathcal{X}_{P}$ for the action $\cdot 1: M_{P}:=\left(\Phi_{1}\right)^{-1}(0) / K$.

Note that $M_{P}$ is compact when $\Phi_{M}$ is proper. The action $\cdot 2$ on $M \times \mathcal{X}_{P}$ induces an action of $K$ on $M_{P}$. The moment map $\Phi_{2}$ induces an equivariant map $\Phi_{M_{P}}$ : $M_{P} \rightarrow \mathfrak{k}^{*}$. Let $\mathcal{Z} \subset\left(\Phi_{1}\right)^{-1}(0)$ be the set of points where $\left(K, \cdot_{1}\right)$ as a trivial stabilizer.

Definition 3.17. We denote $M_{P}^{\prime}$ the quotient $\mathcal{Z} / K \subset M_{P}$.
$M_{P}^{\prime}$ is an open subset of smooth points of $M_{P}$ which is invariant under the $K$ action. The symplectic structure of $M \times \mathcal{X}_{P}$ induces a canonical symplectic structure on $M_{P}^{\prime}$ that we denote $\Omega_{M_{P}^{\prime}}$. The action of $K$ on $\left(M_{P}^{\prime}, \Omega_{M_{P}^{\prime}}\right)$ is Hamiltonian with moment map equal to the restriction of $\Phi_{M_{P}}: M_{P} \rightarrow \mathfrak{k}^{*}$ to $M_{P}^{\prime}$.

We start with the easy
Lemma 3.18. The image of $\Phi_{M_{P}}: M_{P} \rightarrow \mathfrak{k}^{*}$ is equal to the intersection of the image of $\Phi_{M}: M \rightarrow \mathfrak{k}^{*}$ with $K \cdot P$.

Let $\mathcal{U}_{P}=K \cdot \operatorname{Interior}(P) \subset K \cdot P$. We will show now that the open and dense subset $\left(\Phi_{M_{P}}\right)^{-1}\left(\mathcal{U}_{P}\right)$ of $M_{P}$ belongs to $M_{P}^{\prime}$. Afterwards we will prove that $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$ is quasi-symplectomorphic to the open subset $\Phi_{M}^{-1}\left(\mathcal{U}_{P}\right)$ of $M$.

We consider the open and dense subset of $\mathcal{X}_{P}$ which is equal to the open orbit $\bar{\rho}\left(K_{\mathbb{C}}\right)$. From Lemma 3.3, we know that

$$
\begin{align*}
\Theta: K \times \mathfrak{k} & \longrightarrow \bar{\rho}\left(K_{\mathbb{C}}\right)  \tag{3.28}\\
(k, X) & \longmapsto\left[\rho\left(k e^{i X}\right)\right]
\end{align*}
$$

is a diffeomorphism. Through $\Theta$, the action of $K \times K$ on $K \times \mathfrak{k}$ is $k \cdot{ }_{l}(a, X)=(k a, X)$ for the action "from the left" and $k \cdot_{r}(a, X)=\left(a k^{-1}, k \cdot X\right)$ for the action "from the right".

We consider now the map $\psi_{K}: \mathfrak{k} \rightarrow \mathfrak{k}^{*}$ defined by $\psi_{K}(X)=\Phi_{l}\left(\left[\rho\left(e^{i X}\right)\right]\right)$. In other words,

$$
\psi_{K}(X)=\frac{\pi_{K}\left(i \rho\left(e^{i 2 X}\right)\right)}{\operatorname{Tr}\left(\rho\left(e^{i 2 X}\right)\right)}
$$

Consider the function $F_{K}: \mathfrak{k} \rightarrow \mathbb{R}, F_{K}(X)=\ln \left(\operatorname{Tr}\left(\rho\left(e^{-i X}\right)\right)\right.$. Let $L_{K}: \mathfrak{k} \rightarrow \mathfrak{k}^{*}$ be its Legendre transform.
Proposition 3.19. - We have $\psi_{K}(X)=L_{K}(-2 X)$, for $X \in \mathfrak{k}$,

- The function $F_{K}$ is strictly convex,
- The map $\psi_{K}$ realizes an equivariant diffeomorphism between $\mathfrak{k}$ and $\mathcal{U}_{P}$.
- The image of $\Phi_{l}: \mathcal{X}_{P} \rightarrow \mathfrak{k}^{*}$ is equal to the closure of $\mathcal{U}_{P}$,
- $\Phi_{l}^{-1}\left(\mathcal{U}_{P}\right)=\bar{\rho}\left(K_{\mathbb{C}}\right)$.

Proof. For $X, Y \in \mathfrak{k}$ we consider the function $\tau(s)=F_{K}(X+s Y)$. Since $F_{K}$ is $K$-invariant we can restrict our computation to $X \in \mathfrak{t}$. We will use the decomposition of $Y \in \mathfrak{k}$ relatively to the $T$-weights on $\mathfrak{k}_{\mathbb{C}}: Y=\sum_{\alpha} Y_{\alpha}$ where $\operatorname{ad}(Z) Y_{\alpha}=i \alpha(Z) Y_{\alpha}$ for any $Z \in \mathfrak{t}$, and $Y_{0} \in \mathfrak{t}$. We have

$$
\begin{aligned}
\tau^{\prime}(s) & =\frac{-i}{\operatorname{Tr}\left(\rho\left(e^{-i X_{s}}\right)\right)} \operatorname{Tr}\left(\rho\left(e^{-i X_{s}}\right) \rho\left(\frac{e^{i \operatorname{ad}\left(X_{s}\right)}-1}{i \operatorname{ad}\left(X_{s}\right)} Y\right)\right) \\
& =\frac{-i}{\operatorname{Tr}\left(\rho\left(e^{-i X_{s}}\right)\right)} \operatorname{Tr}\left(\rho\left(e^{-i X_{s}}\right) \rho(Y)\right) \\
& =\frac{1}{\operatorname{Tr}\left(\rho\left(e^{-i X_{s}}\right)\right)}\left\langle\pi_{K}\left(i \rho\left(e^{-i X_{s}}\right)\right), Y\right\rangle
\end{aligned}
$$

where $X_{s}=X+s Y$. Since by definition $\tau^{\prime}(0)=\left\langle L_{K}(X), Y\right\rangle$, the first point is proved. For the second derivative we have

$$
\begin{aligned}
\tau^{\prime \prime}(0) & =-\left(\frac{\operatorname{Tr}\left(\rho\left(e^{-i X}\right) \rho(i Y)\right)}{\operatorname{Tr}\left(\rho\left(e^{-i X}\right)\right)}\right)^{2}+\frac{\operatorname{Tr}\left(\rho\left(e^{-i X}\right) \rho\left(\frac{e^{i \operatorname{iad}(X)}-1}{\operatorname{id}(X)} i Y\right) \rho(i Y)\right)}{\operatorname{Tr}\left(\rho\left(e^{-i X}\right)\right)} \\
& =R_{1}+R_{2}
\end{aligned}
$$

where

$$
\begin{aligned}
R_{1} & =\frac{\operatorname{Tr}\left(\rho\left(e^{-i X}\right) \rho\left(i Y_{0}\right) \rho\left(i Y_{0}\right)\right)}{\operatorname{Tr}\left(\rho\left(e^{-i X}\right)\right)}-\left(\frac{\operatorname{Tr}\left(\rho\left(e^{-i X}\right) \rho\left(i Y_{0}\right)\right)}{\operatorname{Tr}\left(\rho\left(e^{-i X}\right)\right)}\right)^{2} \\
& =\frac{\sum_{j} e^{-\left\langle\alpha_{j}, X\right\rangle}\left\langle\alpha_{j}, Y_{0}\right\rangle^{2}}{\sum_{j} e^{-\left\langle\alpha_{j}, X\right\rangle}}-\left(\frac{\sum_{j} e^{-\left\langle\alpha_{j}, X\right\rangle}\left\langle\alpha_{j}, Y_{0}\right\rangle}{\sum_{j} e^{-\left\langle\alpha_{j}, X\right\rangle}}\right)^{2}
\end{aligned}
$$

and

$$
\begin{aligned}
R_{2} & =\frac{1}{\operatorname{Tr}\left(\rho\left(e^{-i X}\right)\right)} \sum_{\alpha \neq 0, \beta \neq 0} \frac{e^{-\langle\alpha, X\rangle}-1}{-\langle\alpha, X\rangle} \operatorname{Tr}\left(\rho\left(e^{-i X}\right) \rho\left(i Y_{\alpha}\right) \rho\left(i Y_{\beta}\right)\right) \\
& =\frac{1}{\operatorname{Tr}\left(\rho\left(e^{-i X}\right)\right)} \sum_{\alpha \neq 0, j} \frac{e^{-\langle\alpha, X\rangle}-1}{-\langle\alpha, X\rangle} e^{-\left\langle\alpha_{j}, X\right\rangle}\left\|\rho\left(Y_{\alpha}\right) v_{j}\right\|^{2} .
\end{aligned}
$$

It is now easy to see that $R_{1}$ and $R_{2}$ are positive and that $R_{1}+R_{2}>0$ if $Y \neq 0$. We have proved that $F_{K}$ is strictly convex, So, its Legendre transform $L_{K}$ realizes a diffeomorphism of $\mathfrak{k}$ onto its image. Using the first point we know that $\psi_{K}$ realizes a diffeomorphism of $\mathfrak{k}$ onto its image. The map $\psi_{K}$ is equivariant and coincides with $\psi_{T}$ on $\mathfrak{t}$. We have proved in Proposition 3.10 that the image of $\psi_{T}$ is equal to the interior of $P$, hence the image of $\psi_{K}$ is $\mathcal{U}_{P}$.

For the last two points we first remark that

$$
\begin{equation*}
\Phi_{l}\left(\left[\rho\left(k e^{i X}\right)\right]\right)=k \cdot \psi_{K}(X) \tag{3.29}
\end{equation*}
$$

hence the image of $\Phi_{l}$ is the closure of $\mathcal{U}_{P}$. If we use the fact that $\psi_{K}$ is a diffeomorphism from $\mathfrak{k}$ onto $\mathcal{U}_{P},(3.29)$ shows that $\Phi_{l}^{-1}(K \cdot \xi) \cap \bar{\rho}\left(K_{\mathbb{C}}\right)$ is a non empty and closed subset of $\Phi_{l}^{-1}(K \cdot \xi)$ for any $\xi \in \mathcal{U}_{P}$ (in fact it is a $K \times K$-orbit). On the other hand $\Phi_{l}^{-1}(K \cdot \xi) \cap\left(\mathcal{X}_{P} \backslash \bar{\rho}\left(K_{\mathbb{C}}\right)\right)$ is also a closed subset of $\Phi_{l}^{-1}(K \cdot \xi)$ since $\left.\bar{\rho}\left(K_{\mathbb{C}}\right)\right)$ is open in $\mathcal{X}_{P}$. Since $\Phi_{l}^{-1}(K \cdot \xi)$ is connected the second subset is empty : in other words $\Phi_{l}^{-1}(K \cdot \xi) \subset \bar{\rho}\left(K_{\mathbb{C}}\right)$.

We introduce now the equivariant diffeomorphism

$$
\begin{align*}
\Upsilon: K \times \mathcal{U}_{P} & \longrightarrow \bar{\rho}\left(K_{\mathbb{C}}\right)  \tag{3.30}\\
(k, \xi) & \longmapsto \Theta\left(k, \psi_{K}^{-1}(\xi)\right) .
\end{align*}
$$

We now look at $K \times \mathcal{U}_{P}$ equipped with the symplectic structure $\Upsilon^{*}\left(\Omega_{\mathcal{X}_{P}}\right)$, and the Hamiltonian action of $K \times K$ : the moment maps satisfy

$$
\begin{equation*}
\Upsilon^{*}\left(\Phi_{l}\right)(k, \xi)=k \cdot \xi \quad \text { and } \quad \Upsilon^{*}\left(\Phi_{r}\right)(k, \xi)=-\xi \tag{3.31}
\end{equation*}
$$

Proposition 3.20. We have

$$
\Upsilon^{*}\left(\Omega_{\mathcal{X}_{P}}\right)=d \lambda+d \eta
$$

where $\lambda$ is the Liouville 1-form on $K \times \mathfrak{k}^{*} \simeq \mathrm{~T}^{*} K$ and $\eta$ is an invariant 1-form on $\mathcal{U}_{P} \subset \mathfrak{k}^{*}$ which is killed by the vectors tangent to the $K$-orbits.

Proof. Let $E_{1}, \ldots, E_{r}$ be a basis of $\mathfrak{k}$, with dual basis $\xi^{1}, \ldots, \xi^{r}$. Let $\omega^{i}$ the 1form on $K$, invariant by left translation and equal to $\xi^{i}$ at the identity. The Liouville 1 -form is $\lambda=-\sum_{i} \omega^{i} \otimes E_{i}$. For $X \in \mathfrak{k}$ we denote $X_{l}(k, \xi)=\left.\frac{d}{d t}\right|_{0} e^{-t X} \cdot{ }_{l}(k, \xi)$ and $X_{r}(k, \xi)=\left.\frac{d}{d t}\right|_{0} e^{-t X} \cdot_{r}(k, \xi)$ the vectors fields generated by the action of $K \times K$. Since $\iota\left(X_{l}\right) d \lambda=-d\left\langle\Phi_{l}, X\right\rangle$ and $\iota\left(X_{r}\right) d \lambda=-d\left\langle\Phi_{r}, X\right\rangle$, the closed invariant 2-form $\beta=\Upsilon^{*}\left(\Omega_{\mathcal{X}_{P}}\right)-d \lambda$ is $K \times K$ invariant and is killed by the vectors tangent to the
orbits : $(*) \iota\left(X_{l}\right) \beta=\iota\left(X_{r}\right) \beta=0$ for all $X \in \mathfrak{k}$. We have $\beta=\beta_{2}+\beta_{1}+\beta_{0}$ where $\beta_{2}=\sum_{i, j} a_{i j}(\xi) \omega^{i} \wedge \omega^{j}, \beta_{1}=\sum_{i, j} b_{i j}(\xi) \omega^{i} \wedge d E_{j}$, and $\beta_{0}$ is an invariant 2-form on $\mathcal{U}_{P}$. The equalities $(*)$ gives $\iota\left(X_{l}\right) \beta_{2}=\iota\left(X_{l}\right) \beta_{1}=0$ which implies that $\beta_{2}=\beta_{1}=0$. So $\beta=\beta_{0}$ is a closed invariant 2 -form on $\mathcal{U}_{P}$ which is killed by the vectors tangent to the $K$-orbits. Since $\mathcal{U}_{P}$ admits a retraction to $\{0\}, \beta=d \eta$ where $\eta$ is an invariant 1-form on $\mathcal{U}_{P}$ which is killed by the vectors tangent to the $K$-orbits.

If $(m, x) \in M \times \mathcal{X}_{P}$ belongs to $\Phi_{1}^{-1}(0)$, we denote $[m, x]$ the corresponding element in $M_{P}$. By definition we have $\Phi_{M_{P}}([m, x])=\Phi_{l}(x)$ for $[m, x] \in M_{P}$, hence the image of $\Phi_{M_{P}}$ is included in the closure of $\mathcal{U}_{P}$. We see also that $[m, x] \in$ $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$ if and only if $x \in \Phi_{l}^{-1}\left(\mathcal{U}_{P}\right)=\bar{\rho}\left(K_{\mathbb{C}}\right)$. Since $\left(K,{ }_{r}\right)$ acts freely on $\bar{\rho}\left(K_{\mathbb{C}}\right)$, we see that $\left(K,{ }_{1}\right)$ acts freely on $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$ : the open and dense set $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right) \subset M_{P}$ is then contained in $M_{P}^{\prime}$.

Now, we can state our main result which compares the open invariant subsets $\Phi_{M}^{-1}\left(\mathcal{U}_{P}\right) \subset M$ and $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right) \subset M_{P}$ equipped respectively with the symplectic structures $\Omega_{M}$ and $\Omega_{M_{P}^{\prime}}$.

Theorem 3.21. $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$ is an open and dense subset of smooth points in $M_{P}$. There exist an equivariant diffeomorphism $\Psi: \Phi_{M}^{-1}\left(\mathcal{U}_{P}\right) \rightarrow \Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$ such that

$$
\Psi^{*}\left(\Omega_{M_{P}^{\prime}}\right)=\Omega_{M}+d \Phi_{M}^{*} \eta .
$$

Here $\eta$ is an invariant 1-form on $\mathcal{U}_{P}$ which is killed by the vectors tangent to the $K$-orbits. Moreover the path $\Omega^{t}=\Omega_{M}+t d \Phi_{M}^{*} \eta$, defines an homotopy of symplectic 2 -forms between $\Omega_{M}$ and $\Psi^{*}\left(\Omega_{M_{P}^{\prime}}\right)$.

Remark 3.22. The map $\Psi$ will be call a quasi-symplectomorphism.
Proof. Consider the immersion

$$
\begin{aligned}
\psi: \Phi_{M}^{-1}\left(\mathcal{U}_{P}\right) & \longrightarrow M \times \mathcal{X}_{P} \\
m & \longmapsto\left(m, \Upsilon\left(e, \Phi_{M}(m)\right)\right) .
\end{aligned}
$$

We have $\Phi_{1}(\psi(m))=\Phi_{M}(m)+\Upsilon^{*} \Phi_{r}\left(e, \Phi_{M}(m)\right)=0$, and $\Phi_{2}(\psi(m))=$ $\Upsilon^{*} \Phi_{l}\left(e, \Phi_{M}(m)\right)=\Phi_{M}(m) \in \mathcal{U}_{P}$ (see (3.31)). Hence for all $m \in \Phi_{M}^{-1}\left(\mathcal{U}_{P}\right)$, we have $\psi(m) \in \Phi_{1}^{-1}(0)$, and its class $[\psi(m)] \in M_{P}$ belongs to $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$.

We denote $\Psi: \Phi_{M}^{-1}\left(\mathcal{U}_{P}\right) \rightarrow \Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$ the map $m \mapsto[\psi(m)]$. Let us show that it defines a diffeomorphism. If $\Psi(m)=\Psi\left(m^{\prime}\right)$, there exists $k \in K$ such that

$$
\begin{aligned}
\left(m, \Upsilon\left(e, \Phi_{M}(m)\right)\right) & =k \cdot 1\left(m^{\prime}, \Upsilon\left(e, \Phi_{M}\left(m^{\prime}\right)\right)\right) \\
& =\left(k \cdot m^{\prime}, k \cdot r \Upsilon\left(e, \Phi_{M}\left(m^{\prime}\right)\right)\right) \\
& =\left(k \cdot m^{\prime}, \Upsilon\left(k^{-1}, k \cdot \Phi_{M}\left(m^{\prime}\right)\right)\right) .
\end{aligned}
$$

Since $\Upsilon$ is a diffeomorphism, we must have $k=e$ and $m=m^{\prime}$ : the map $\Psi$ is one to one. Consider now $(m, x) \in \Phi_{1}^{-1}(0)$ such that $\Phi_{M_{P}}([m, x])=\Phi_{l}(x) \in \mathcal{U}_{P}$ : then $x \in \Phi_{l}^{-1}\left(\mathcal{U}_{P}\right)=\bar{\rho}\left(K_{\mathbb{C}}\right)=\operatorname{Image}(\Upsilon)$. We have $x=\Upsilon(k, \xi)$ where $\xi=-\Phi_{r}(x)=$ $\Phi_{M}(m)$. Finally

$$
\begin{aligned}
(m, x) & =\left(m, \Upsilon\left(k, \Phi_{M}(m)\right)\right) \\
& =k^{-1} \cdot 1\left(k \cdot m, \Upsilon\left(e, k \cdot \Phi_{M}(m)\right)\right) \\
& =k^{-1} \cdot 1 \psi(k \cdot m) .
\end{aligned}
$$

We have proved that $\Psi$ is onto.

In order to show that $\Psi$ is a submersion we must show that for $m \in \Phi_{M}^{-1}\left(\mathcal{U}_{P}\right)$

$$
\text { Image }\left(\mathrm{T}_{m} \psi\right) \oplus \mathrm{T}_{\psi(m)}\left(K \cdot{ }_{1} \psi(m)\right)=\mathrm{T}_{\psi(m)} \Phi_{1}^{-1}(0)
$$

Here $\mathrm{T}_{m} \psi: \mathrm{T}_{m} M \rightarrow \mathrm{~T}_{\psi(m)}\left(M \times \mathcal{X}_{P}\right)$ is the tangent map, and $\mathrm{T}_{\psi(m)}\left(K \cdot{ }_{1} \psi(m)\right)$ denotes the tangent space at $\psi(m)$ of the $\left(K, \cdot_{1}\right)$-orbit. We have $\operatorname{dim}\left(\operatorname{Image}\left(\mathrm{T}_{m} \psi\right)\right)+$ $\operatorname{dim}\left(\mathrm{T}_{\psi(m)}\left(K \cdot{ }_{1} \psi(m)\right)\right)=\operatorname{dim}\left(\mathrm{T}_{\psi(m)} \Phi_{1}^{-1}(0)\right)$ so it is sufficient to prove that

$$
\operatorname{Image}\left(\mathrm{T}_{m} \psi\right) \cap \mathrm{T}_{\psi(m)}\left(K \cdot{ }_{1} \psi(m)\right)=\{0\}
$$

Consider $(v, w) \in \operatorname{Image}\left(\mathrm{T}_{m} \psi\right) \cap \mathrm{T}_{\psi(m)}\left(K \cdot{ }_{1} \psi(m)\right)$. There exists $X \in \mathfrak{k}$ such $(v, w)=\left.\frac{d}{d t}\right|_{0} e^{t X} \cdot{ }_{1} \psi(m):$

$$
v=\frac{d}{d t} e_{0}^{t X} \cdot m \quad \text { and } \quad w=\left.\frac{d}{d t}\right|_{0} e^{t X} \cdot{ }_{r} \Upsilon\left(e, \Phi_{M}(m)\right)
$$

In the other hand since $(v, w) \in \operatorname{Image}\left(\mathrm{T}_{m} \psi\right)$, we have

$$
w=\left.\frac{d}{d t}\right|_{0} \Upsilon\left(e, \Phi_{M}\left(e^{t X} \cdot m\right)\right)
$$

Since $e^{t X} \cdot{ }_{r} \Upsilon\left(e, \Phi_{M}(m)\right)=\Upsilon\left(e^{-t X}, \Phi_{M}\left(e^{t X} \cdot m\right)\right)$ we obtain that

$$
\left.\frac{d}{d t}\right|_{0} \Upsilon\left(e^{-t X}, \Phi_{M}\left(e^{t X} \cdot m\right)\right)=\frac{d}{d t} \Upsilon\left(e, \Phi_{M}\left(e^{t X} \cdot m\right)\right)
$$

or in other words $\left.\frac{d}{d t}\right|_{0} \Upsilon\left(e^{-t X}, \Phi_{M}(m)\right)=0$. Since $\Upsilon$ is a diffeomorphism we have $X=0$, and then $(v, w)=0$.

We can now compute the pull-back by $\Psi$ of the symplectic form $\Omega_{M_{P}^{\prime}}$. We have

$$
\begin{aligned}
\Psi^{*}\left(\Omega_{M_{P}^{\prime}}\right) & =\psi^{*}\left(\Omega_{M}+\Omega_{X_{P}}\right) \\
& =\Omega_{M}+\Phi_{M}^{*} \Upsilon^{*}\left(\Omega_{\mathcal{X}_{P}}\right) \\
& =\Omega_{M}+d \Phi_{M}^{*} \eta .
\end{aligned}
$$

It remains to prove that for every $t \in[0,1]$, the 2 -form $\Omega^{t}=\Omega_{M}+t d \Phi_{M}^{*} \eta$ is non-degenerate. Take $t \neq 0, m \in \Phi_{M}^{-1}\left(\mathcal{U}_{P}\right)$ and suppose that the contraction of $\Omega^{t}{ }_{m}$ by $v \in \mathrm{~T}_{m} M$ is equal to 0 . For every $X \in \mathfrak{k}$ we have

$$
\begin{aligned}
0 & =\Omega^{t}\left(X_{M}(m), v\right) \\
& =-\iota(v) d\left\langle\Phi_{M}, X\right\rangle_{\left.\right|_{m}}+t \iota(v) \iota\left(X_{M}\right) d \Phi_{M}^{*} \eta_{\left.\right|_{m}} \\
& =-\iota(v) d\left\langle\Phi_{M}, X\right\rangle_{\left.\right|_{m}}
\end{aligned}
$$

since $\iota\left(X_{M}\right) d \Phi_{M}^{*} \eta=d \Phi_{M}^{*}\left(\iota\left(X_{\mathfrak{k}^{*}}\right) \eta\right)=0$. Thus we have $\mathrm{T}_{m} \Phi_{M}(v)=0$, and then $\iota(v) d \Phi_{M}^{*} \eta=0$. Finally we have that $0=\left.\iota(v) \Omega^{t}\right|_{m}=\left.\iota(v) \Omega_{M}\right|_{m}$. But $\Omega_{M}$ is non-degenerate, so $v=0$.
3.5. Formal quantization : second definition. We suppose here that the Hamiltonian $K$-manifold ( $M, \Omega_{M}, \Phi_{M}$ ) is proper and admits a Kostant-Souriau line bundle $L$. Now we consider the complex $K \times K$-submanifold $\mathcal{X}_{P}$ of $\mathbb{P}(E)$. Since $\mathcal{O}(-1)$ is a $K \times K$-equivariant Kostant-Souriau line bundle on the projective space $\mathbb{P}(E)$ the restriction

$$
\begin{equation*}
L_{P}=\left.\mathcal{O}(-1)\right|_{\mathcal{X}_{P}} \tag{3.32}
\end{equation*}
$$

is a Kostant-Souriau line bundle on $\mathcal{X}_{P}$. Hence $L \boxtimes L_{P}$ is a Kostant line bundle on the product $M \times \mathcal{X}_{P}$. In section 2.2 we have have defined the quantization $\mathcal{Q}_{K}\left(M_{P}\right)$ of the (singular) reduced space $M_{P}:=\left(M \times \mathcal{X}_{P}\right) / /{ }_{0}\left(K,{ }_{1}\right)$.

Notation: $O_{K}(r)$ will be any element $\sum_{\mu \in \widehat{K}} m_{\mu} V_{\mu}^{K}$ of $R^{-\infty}(K)$ where $m_{\mu}=0$ if $\|\mu\|<r$. The limit $\lim _{r \rightarrow+\infty} O_{K}(r)=0$ defines the notion of convergence in $R^{-\infty}(K)$.

Proposition 3.23. Let $\varepsilon_{P}>0$ be the radius of the biggest ball center at $0 \in \mathfrak{t}^{*}$ which is contains in the polytope $P$. We have

$$
\begin{equation*}
\mathcal{Q}_{K}\left(M_{P}\right)=\sum_{\|\mu\|<\varepsilon_{P}} \mathcal{Q}\left(M_{\mu}\right) V_{\mu}^{K}+O_{K}\left(\varepsilon_{P}\right) \tag{3.33}
\end{equation*}
$$

Proof. Theorem 2.4-"Quantization commutes with reduction in the singular setting" - tells us that $\mathcal{Q}_{K}\left(M_{P}\right)=\sum_{\mu \in \widehat{K}} \mathcal{Q}\left(\left(M_{P}\right)_{\mu}\right) V_{\mu}^{K}$ where $\left(M_{P}\right)_{\mu}$ is the symplectic reduction

$$
\left(M_{P} \times \overline{K_{2} \cdot \mu}\right) / /{ }_{0} K_{2} \cong\left(M \times \mathcal{X}_{P} \times \overline{K_{2} \cdot \mu}\right) / /(0,0) K_{2} \times K_{1}
$$

Recall what the $K_{1}, K_{2}$-action are: $k \cdot{ }_{1}(\underline{m, x, \xi})=(k m, k \cdot r x, \xi)$ and $k \cdot{ }_{2}(m, x, \xi)=$ $\left(m, k{ }_{l} x, k \xi\right)$ for $(m, x, \xi) \in M \times \mathcal{X}_{P} \times \overline{K_{2} \cdot \mu}$ and $k \in K$.

Since the image of $\Phi_{M_{P}}$ is equal to the intersection of $K \cdot P=\overline{\mathcal{U}_{P}}$ with the image of $\Phi_{M}$, we have

$$
\begin{equation*}
\mathcal{Q}\left(\left(M_{P}\right)_{\mu}\right)=0 \quad \text { if } \quad \mu \notin P \cap \operatorname{Image}\left(\Phi_{M}\right) . \tag{3.34}
\end{equation*}
$$

We will now exploit Theorem 3.21 to show that $\mathcal{Q}\left(\left(M_{P}\right)_{\mu}\right)=\mathcal{Q}\left(M_{\mu}\right)$ if $\mu$ belongs to the interior of $P$.

There exists a quasi-symplectomorphism $\Psi$ between the open subset $\Phi_{M}^{-1}\left(\mathcal{U}_{P}\right)$ of $M$ and the open and dense subset $\Phi_{M_{P}}^{-1}\left(\mathcal{U}_{P}\right)$ of $M_{P}$. Moreover one can see easily that the restriction of the Kostant line bundle $L_{P} \rightarrow \mathcal{X}_{P}$ to the open subset $\bar{\rho}\left(K_{\mathbb{C}}\right)$ is trivial. If $L_{M_{P}}$ is the Kostant line bundle on $M_{P}$ induced by $L \boxtimes L_{P}$, we have that the pull-back of the restriction $\left.L_{M_{P}}\right|_{\Phi_{M}^{-1}\left(\mathcal{U}_{P}\right)}$ by $\Psi$ is equivariantly diffeomorphic to the restriction of $L$ to $\Phi_{M}^{-1}\left(\mathcal{U}_{P}\right)$.

Take now $\mu \in \widehat{K}$ that belongs to the interior of the polytope $P$. The element $\mathcal{Q}\left(\left(M_{P}\right)_{\mu}\right) \in \mathbb{Z}$ is given by the index of a transversally elliptic symbol defined in a (small) neighborhood of $\Phi_{M_{P}}^{-1}(\mu) \subset M_{P}$. This symbol is defined through two auxiliary data: the Kostant line bundle $L_{M_{P}}$ and a compatible almost complex structure $J$ which defined in a neighborhood of $\Phi_{M_{P}}^{-1}(\mu)$. If we pull back everything by $\Psi$, we get a transversally elliptic symbol living in a (small) neighborhood of $\Phi_{M}^{-1}(\mu) \subset M$ which is defined by the Kostant line bundle $L$ and an almost complex structure $J_{1}$ compatible with the symplectic structure $\Omega_{1}:=\Omega_{M}+d \Phi_{M}^{*} \eta$. But since $\Omega_{t}=\Omega_{M}+t d \Phi_{M}^{*} \eta$ defines an homotopy of symplectic structures, any almost complex structure compatible with $\Omega_{M}$ is homotopic to $J_{1}$. We have then shown that $\mathcal{Q}\left(M_{\mu}\right)=\mathcal{Q}\left(\left(M_{P}\right)_{\mu}\right)$ for any $\mu$ belonging to the interior of $P$. So we have

$$
\mathcal{Q}_{K}\left(M_{P}\right)=\sum_{\mu \in \operatorname{Interior}(P)} \mathcal{Q}\left(M_{\mu}\right) V_{\mu}^{K}+\sum_{\nu \in \partial P} \mathcal{Q}\left(\left(M_{P}\right)_{\nu}\right) V_{\nu}^{K}
$$

Since for $\nu \in \partial P$ we have $\|\nu\| \geq \varepsilon_{P}$, the last equality proves (3.33).
We work now with the dilated polytope $n P$, for any integer $n \geq 1$. The polytope $n P$ is still $K$-adapted, so one can consider the reduced spaced $M_{n P}$ and Proposition 3.23 gives that

$$
\begin{equation*}
\mathcal{Q}_{K}\left(M_{n P}\right)=\sum_{\|\mu\|<n \varepsilon_{P}} \mathcal{Q}\left(M_{\mu}\right) V_{\mu}^{K}+O_{K}\left(n \varepsilon_{P}\right) . \tag{3.35}
\end{equation*}
$$

for any integer $n \geq 1$. We can summarize the result of this section in the following
Proposition 3.24. Let $\left(M, \Omega_{M}\right)$ be a pre-quantized Hamitonian $K$-manifold, with a proper moment map $\Phi_{M}$.

- For any integer $n \geq 1$, the (singular) compact Hamiltonian manifold $M_{n P}$ contains as an open and dense subset, the open subset $\Phi_{M}^{-1}\left(n \mathcal{U}_{P}\right)$ of $M$.
- We have $\mathcal{Q}_{K}^{-\infty}(M)=\lim _{n \rightarrow \infty} \mathcal{Q}_{K}\left(M_{n P}\right)$.


## 4. Functorial properties : Proof of Theorem 1.3

This section is devoted to the proof of Theorem 1.3. We will used in a crucial way the characterisation of $\mathcal{Q}_{K}^{-\infty}$ given in Proposition 3.24.

Let $H \subset K$ be a connected Lie subgroup. Here we consider a pre-quantized Hamiltonian $K$-manifold $M$ which is proper as an Hamiltonian $H$-manifold. We want to compare $\mathcal{Q}_{K}^{-\infty}(M)$ and $\mathcal{Q}_{H}^{-\infty}(M)$. For $\mu \in \widehat{K}$ and $\nu \in \widehat{H}$ we denote $N_{\nu}^{\mu}$ the multiplicity of $V_{\nu}^{H}$ in the restriction $\left.V_{\mu}^{K}\right|_{H}$. We have seen in the introduction that $N_{\nu}^{\mu} \mathcal{Q}\left(M_{\mu, K}\right) \neq 0$ only for the $\mu$ belonging to finite subset $\widehat{K} \cap \Phi_{K}\left(K \cdot \Phi_{H}^{-1}(\nu)\right)$. Then $\mathcal{Q}_{K}^{-\infty}(M)$ is $H$-admissible and we have the following equality in $R^{-\infty}(H)$ :

$$
\begin{equation*}
\left.\mathcal{Q}_{K}^{-\infty}(M)\right|_{H}=\sum_{\nu \in \widehat{H}} m_{\nu} V_{\nu}^{H} \tag{4.36}
\end{equation*}
$$

with $m_{\nu}=\sum_{\mu} N_{\nu}^{\mu} \mathcal{Q}\left(M_{\mu, K}\right)$. We will now prove that $\left.\mathcal{Q}_{K}^{-\infty}(M)\right|_{H}=\mathcal{Q}_{H}^{-\infty}(M)$.
Lemma 4.1. The restriction $\left.\mathcal{Q}_{K}^{-\infty}(M)\right|_{H}$ is equal to $\left.\lim _{n \rightarrow \infty} \mathcal{Q}_{K}\left(M_{n P}\right)\right|_{H}$.
Proof. Let us denote $P^{o}$ and $\partial P$ respectively the interior and the border of the $K$-adapted polytope $P$. We write

$$
\mathcal{Q}_{K}^{-\infty}(M)=\sum_{\mu \in n P^{o}} \mathcal{Q}\left(M_{\mu, K}\right) V_{\mu}^{K}+\sum_{\mu \notin n P^{o}} \mathcal{Q}\left(M_{\mu, K}\right) V_{\mu}^{K} .
$$

On the other side

$$
\mathcal{Q}_{K}\left(M_{n P}\right)=\sum_{\mu \in n P^{o}} \mathcal{Q}\left(M_{\mu, K}\right) V_{\mu}^{K}+\sum_{\mu \in n \partial P} \mathcal{Q}\left(\left(M_{n P}\right)_{\mu, K}\right) V_{\mu}^{K}
$$

So the difference $D(n)=\mathcal{Q}_{K}^{-\infty}(M)-\mathcal{Q}_{K}\left(M_{n P}\right)$ is equal to

$$
D(n)=-\sum_{\mu^{\prime} \in n \partial P} \mathcal{Q}\left(\left(M_{n P}\right)_{\mu^{\prime}, K}\right) V_{\mu}^{K}+\sum_{\mu \notin n P^{o}} \mathcal{Q}\left(M_{\mu, K}\right) V_{\mu}^{K}
$$

We show now that the restriction $\left.D(n)\right|_{H}$ tends to 0 in $R^{-\infty}(H)$ as $n$ goes to infinity. For this purpose, we will prove that for any $c>0$ there exist $n_{c} \in \mathbb{N}$ such that $\left.D(n)\right|_{H}=O_{H}(c)$ for any $n \geq n_{c}$.

For $c>0$ we consider the compact subset of $\mathfrak{k}^{*}$ defined by

$$
\begin{equation*}
\mathcal{K}_{c}=\Phi_{K}\left(K \cdot \Phi_{H}^{-1}\left(\xi \in \mathfrak{h}^{*},\|\xi\| \leq c\right)\right) . \tag{4.37}
\end{equation*}
$$

Let $n_{c} \in \mathbb{N}$ such that $\mathcal{K}_{c}$ is included in $K \cdot\left(n_{c} P^{o}\right)$ : hence $\mathcal{K}_{c} \subset K \cdot\left(n P^{o}\right)$ for any $n \geq n_{c}$. We know that for $\mu \in \widehat{K}$, we have $N_{\nu}^{\mu} \mathcal{Q}\left(M_{\mu, K}\right) \neq 0$ only for $\mu \in \Phi_{K}\left(K \cdot \Phi_{H}^{-1}(\nu)\right)$, and for $\mu^{\prime} \in \widehat{K}$, we have $N_{\nu}^{\mu^{\prime}} \mathcal{Q}\left(\left(M_{n P}\right)_{\mu^{\prime}, K}\right) \neq 0$ only for $\mu^{\prime} \in n P \cap \Phi_{K}\left(K \cdot \Phi_{H}^{-1}(\nu)\right)$.

Then if $n \geq n_{c}$, we have

$$
N_{\nu}^{\mu} \mathcal{Q}\left(M_{\mu, K}\right)=N_{\nu}^{\mu^{\prime}} \mathcal{Q}\left(\left(M_{n P}\right)_{\mu^{\prime}, K}\right)=0
$$

for any $\nu \in \widehat{H} \cap\left\{\xi \in \mathfrak{h}^{*},\|\xi\| \leq c\right\}, \mu \notin n P^{o}$ and $\mu^{\prime} \in n \partial P$. It means that $\left.D(n)\right|_{H}=O_{H}(c)$ for any $n \geq n_{c}$.

Since $\left.\mathcal{Q}_{K}\left(M_{n P}\right)\right|_{H}=\mathcal{Q}_{H}\left(M_{n P}\right)$, we are no led to the
Lemma 4.2. The limit $\lim _{n \rightarrow \infty} \mathcal{Q}_{H}\left(M_{n P}\right)$ is equal to $\mathcal{Q}_{H}^{-\infty}(M)$.
Proof. Theorem 2.4 - "Quantization commutes with reduction in the singular setting" - tells us that $\mathcal{Q}_{H}\left(M_{n P}\right)=\sum_{\nu \in \widehat{H}} \mathcal{Q}\left(\left(M_{n P}\right)_{\nu, H}\right) V_{\nu}^{H}$ where $\left(M_{n P}\right)_{\nu, H}$ is the symplectic reduction

$$
\left(M_{n P} \times \overline{H \cdot \nu}\right) / /{ }_{0} H \cong\left(M \times \mathcal{X}_{n P} \times \overline{H \cdot \mu}\right) / /(0,0) H \times K
$$

For $c>0$ we consider the compact subset of $\mathcal{K}_{c}$ defined in (4.37). Let $n_{c} \in \mathbb{N}$ such that $\mathcal{K}_{c} \subset K \cdot\left(n P^{o}\right)$ for any $n \geq n_{c}$. It implies that

$$
\Phi_{H}^{-1}\left(\xi \in \mathfrak{h}^{*},\|\xi\| \leq c\right) \subset \Phi_{K}^{-1}\left(K \cdot\left(n P^{o}\right)\right)
$$

for $n \geq n_{c}$. Since $M_{n P}$ "contains" as an the open subset $\Phi_{K}^{-1}\left(K \cdot\left(n P^{o}\right)\right)$, the arguments similar to those used in the proof of Proposition 3.23 show that $\mathcal{Q}\left(\left(M_{n P}\right)_{\nu, H}\right)=$ $\mathcal{Q}\left(M_{\nu, H}\right)$ for $\|\nu\| \leq c$ and $n \geq n_{c}$. It means that

$$
\mathcal{Q}_{H}\left(M_{n P}\right)=\sum_{\|\nu\| \leq c} \mathcal{Q}\left(M_{\nu, H}\right) V_{\nu}^{H}+O_{H}(c) \quad \text { when } \quad n \geq n_{c} .
$$

It follows that $\lim _{n \rightarrow \infty} \mathcal{Q}_{H}\left(M_{n P}\right)=\sum_{\nu \in \widehat{H}} \mathcal{Q}\left(M_{\nu, H}\right) V_{\nu}^{H}=\mathcal{Q}_{H}^{-\infty}(M)$.

## 5. The case of an Hermitian space

Let $(E, h)$ be an Hermitian vector space of dimension $n$.
5.1. The quantization of $E$. Let $\mathrm{U}:=\mathrm{U}(E)$ be the unitary group with Lie algebra $\mathfrak{u}$. We use the isomorphism $\epsilon: \mathfrak{u} \rightarrow \mathfrak{u}^{*}$ defined by $\langle\epsilon(X), Y\rangle=-\operatorname{Tr}(X Y) \in$ $\mathbb{R}$. For $v, w \in E$, let $v \otimes w^{*}: E \rightarrow E$ be the linear map $x \mapsto \mathrm{~h}(x, w) v$.

Let $E_{\mathbb{R}}$ be the space $E$ view as a real vector space. Let $\Omega$ be the imaginary part of -h , and let $J$ the complex structure on $E_{\mathbb{R}}$. Then on $E_{\mathbb{R}}, \Omega$ is a (constant) symplectic structure and $\Omega(-, J-)$ defines a scalar product. The action of U on $\left(E_{\mathbb{R}}, \Omega\right)$ is Hamiltonian with moment map $\Phi: E \rightarrow \mathfrak{u}^{*}$ defined by $\langle\Phi(v), X\rangle=$ $\frac{1}{2} \Omega(X v, v)$. Through $\epsilon$, the moment map $\Phi$ is defined by

$$
\begin{equation*}
\Phi(v)=\frac{1}{2 i} v \otimes v^{*} . \tag{5.38}
\end{equation*}
$$

The pre-quantization data $(L,\langle-,-\rangle, \nabla)$ on the Hamiltonian U-manifold $\left(E_{\mathbb{R}}, \Omega, \Phi\right)$ is a trivial line bundle $L$ with a trivial action of U equipped with the Hermitian structure $\left\langle s, s^{\prime}\right\rangle_{v}=e^{\frac{-\mathrm{h}(v, v)}{2}} s \overline{s^{\prime}}$ and the Hermitian connexion $\nabla=d-i \theta$ where $\theta$ is the 1 -form on $E$ defined by $\theta=\frac{1}{2} \Omega(v, d v)$.

The traditional quantization of the Hamiltonian U-manifold $\left(E_{\mathbb{R}}, \Omega, \Phi\right)$, that we denote $\mathcal{Q}_{U}^{L^{2}}(E)$, is the Bargman space of entire holomorphic functions on $E$ which are $L^{2}$ integrable with respect to the Gaussian measure $e^{\frac{-\mathrm{h}(v, v)}{2}} \Omega^{n}$. The representation $\mathcal{Q}_{U}^{\mathrm{L}^{2}}(E)$ of U is admissible. The irreducible representations of U
that occur in $\mathcal{Q}_{U}^{\mathrm{L}^{2}}(E)$ are the vector subspaces $S^{j}\left(E^{*}\right)$ formed by the homogeneous polynomial on $E$ of degree $j \geq 0$.

On the other hand, the moment map $\Phi$ is proper (see 5.38). Hence we can consider the formal quantization $\mathcal{Q}_{\mathrm{U}}^{-\infty}(E) \in R^{-\infty}(\mathrm{U})$ of the U-action on $E$.

Lemma 5.1. The two quantizations of $(E, \Omega, \Phi), \mathcal{Q}_{U}^{\mathrm{L}^{2}}(E)$ and $\mathcal{Q}_{\mathrm{U}}^{-\infty}(E)$ coincide in $R^{-\infty}(\mathrm{U})$. In other words, we have

$$
\begin{equation*}
\mathcal{Q}_{\mathrm{U}}^{-\infty}(E)=S^{\bullet}\left(E^{*}\right):=\sum_{j \geq 0} S^{j}\left(E^{*}\right) \quad \text { in } \quad R^{-\infty}(U) \tag{5.39}
\end{equation*}
$$

Proof. Let $T \subset \mathrm{U}$ be a maximal torus with Lie algebra $\mathfrak{t} \subset \mathfrak{u}$. There exists an orthonormal basis $\left(e_{k}\right)_{k=1, \cdots, n}$ of $E$ and characters $\left(\chi_{k}\right)_{k=1, \cdots, n}$ of $T$ such that $t \cdot e_{k}=\chi_{k}(t) e_{k}$ for all $k$. The family $\left(i e_{k} \otimes e_{k}^{*}\right)_{k=1, \cdots, n}$ is then a basis of $\mathfrak{t}$ such that $\frac{1}{i} d \chi_{l}\left(i e_{k} \otimes e_{k}^{*}\right)=\delta_{l, k}$. The set $\widehat{U} \subset \mathfrak{t}^{*} \subset \mathfrak{u}^{*}$ of dominants weights is composed, through $\epsilon$, by the elements

$$
\underline{\lambda}=i \sum_{k=1}^{n} \lambda_{k} e_{k} \otimes e_{k}^{*}
$$

where $\lambda=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right)$ is a decreasing sequence of integer.
The formal quantization $\mathcal{Q}_{\mathrm{U}}^{-\infty}(E) \in R^{-\infty}(\mathrm{U})$ is defined by

$$
\mathcal{Q}_{\underline{\mathrm{U}}}^{-\infty}(E)=\sum_{\lambda_{1} \geq \cdots \geq \lambda_{n}} \mathcal{Q}\left(E_{\underline{\lambda}}\right) V_{\underline{\lambda}}
$$

where $E_{\underline{\lambda}}=\Phi^{-1}(U \cdot \underline{\lambda}) / U$ is the reduced space and $V_{\underline{\lambda}}$ is the irreducible representation of $U$ with highest weight $\underline{\lambda}$.

It is now easy to check that

$$
E_{\underline{\lambda}}=\left\{\begin{array}{cl}
\{\mathrm{pt}\} & \text { if } \lambda=(0, \cdots, 0,-j) \text { with } j \geq 0 \\
\emptyset & \text { in the other cases }
\end{array}\right.
$$

and then

$$
\mathcal{Q}\left(E_{\underline{\lambda}}\right)= \begin{cases}1 & \text { if } \lambda=(0, \cdots, 0,-j) \text { with } j \geq 0 \\ 0 & \text { in the other cases }\end{cases}
$$

Finally (5.39) follows from the fact that $V_{\underline{(0, \cdots, 0,-j)}}=S^{j}\left(E^{*}\right)$.
5.2. The quantization of $E$ restricted to a subgroup of U . Let $K \subset \mathrm{U}$ be a connected Lie subgroup with Lie algebra $\mathfrak{k}^{*}$. Let $K_{\mathbb{C}} \subset \mathrm{GL}(E)$ be its complexification. The moment map relative to the $K$-action on $\left(E_{\mathbb{R}}, \Omega\right)$ is the map

$$
\Phi_{K}: E \rightarrow \mathfrak{k}^{*}
$$

equal to the composition of $\Phi$ with the projection $\mathfrak{u}^{*} \rightarrow \mathfrak{k}^{*}$.
Lemma 5.2. The following conditions are equivalent:
(a) the map $\Phi_{K}$ is proper,
(b) $\Phi_{K}^{-1}(0)=\{0\}$,
(c) $\{0\}$ is the only closed $K_{\mathbb{C}}$-orbit in $E$,
(d) for every $v \in E$ we have $0 \in \overline{K_{\mathbb{C}} \cdot v}$,
(e) $S^{\bullet}\left(E^{*}\right)$ is an admissible representation of $K$,
(f) the $K$-invariant polynomials on $E$ are the constant polynomials.

Proof. The equivalence $(a) \Longleftrightarrow(b)$ is due to the fact that $\Phi_{K}$ is quadratic.
Let $\mathcal{O}$ be a $K_{\mathbb{C}}$-orbit in $E$. Classical results of Geometric Invariant Theory [26, 18] assert that $\overline{\mathcal{O}} \cap \Phi_{K}^{-1}(0) \neq \emptyset$ and that $\mathcal{O}$ is closed if and only if $\mathcal{O} \cap \Phi_{K}^{-1}(0) \neq \emptyset$. Hence $(b) \Longleftrightarrow(c) \Longleftrightarrow(d)$.

After Lemma 5.1 we know that $\mathcal{Q}_{\mathrm{U}}^{-\infty}(E)=S^{\bullet}\left(E^{*}\right)$. Since $\mathcal{Q}_{\mathrm{U}}^{-\infty}(E)$ is $K$ admissible when $\Phi_{K}$ is proper (see Section (1), we have $(a) \Longrightarrow(e)$.

For every $\mu \in \widehat{K}$, the $\mu$-isotopic component $\left[S^{\bullet}\left(E^{*}\right)\right]_{\mu}$ is a module over $\left[S^{\bullet}\left(E^{*}\right)\right]_{0}=$ $\left[S^{\bullet}\left(E^{*}\right)\right]^{K}$. Hence $\operatorname{dim}\left[S^{\bullet}\left(E^{*}\right)\right]_{\mu}<\infty$ implies that $\left[S^{\bullet}\left(E^{*}\right)\right]^{K}=\mathbb{C}$. We have $(e) \Longrightarrow(f)$.

Finally $(f) \Longrightarrow(d)$ follows from the following fundamental fact. For any $v, w \in E$ we have $\overline{K_{\mathbb{C}} \cdot v} \cap \overline{K_{\mathbb{C}} \cdot w} \neq \emptyset$ if and only if $P(v)=P(w)$ for all $P \in\left[S^{\bullet}\left(E^{*}\right)\right]^{K}$.

Theorem 1.3 implies the following
Proposition 5.3. Let $K \subset \mathrm{U}(E)$ be a closed connected subgroup such that $S^{\bullet}\left(E^{*}\right)$ is an admissible representation of $K$. For every $\mu \in \widehat{K}$, we have

$$
\operatorname{dim}\left(\left[S^{\bullet}\left(E^{*}\right)\right]_{\mu}\right)=\mathcal{Q}\left(E_{\mu, K}\right)
$$

where $\left[S^{\bullet}\left(E^{*}\right)\right]_{\mu}$ is the $\mu$-isotopic component of $S^{\bullet}\left(E^{*}\right)$ and $E_{\mu, K}$ is the reduced space $\Phi_{K}^{-1}(K \cdot \mu) / K$.

In the following examples the condition $\Phi_{K}^{-1}(0)=\{0\}$ is easy to check.

1) the subgroup $K \subset \mathrm{U}(E)$ contains the center of $\mathrm{U}(E)$,
2) $E=\wedge^{2} \mathbb{C}^{n}$ or $E=S^{2}\left(\mathbb{C}^{n}\right)$ and $K=\mathrm{U}(n) \subset \mathrm{U}(E)$,
3) $E=\mathrm{M}_{n, k}$ is the vector space of $n \times k$-matrices and $K=\mathrm{U}(n) \times \mathrm{U}(k) \subset$ $\mathrm{U}(E)$.
