Asymptotic Behavior of the Hitting Time, Overshoot and Undershoot for some Lévy Processes

Abstract

Let $(X_t, t \ge 0)$ be a Lévy process started at 0, with Lévy measure ν . We consider the first passage time T_x of $(X_t, t \ge 0)$ to level x > 0, and $K_x := X_{T_x} - x$ the overshoot and $L_x := x - X_{T_x}$ the undershoot. We first prove that the Laplace transform of the random triple (T_x, K_x, L_x) satisfies some kind of integral equation. Second, assuming that ν admits exponential moments, we show that $(\widetilde{T_x}, K_x, L_x)$ converges in distribution as $x \to \infty$, where $\widetilde{T_x}$ denotes a suitable renormalization of T_x .

Keywords: Lévy processes, ruin problem, hitting time, overshoot, undershoot, asymptotic estimates, functional equation.

Introduction

1. Let $(X_t, t \ge 0)$ be a Lévy process, which is right continuous with left limits and starts at 0. Let

$$X_t = \sigma B_t - c_0 t + J_t \qquad t \ge 0, \qquad (0.1)$$

be the canonical decomposition, when $c_0 \in \mathbb{R}$, $\sigma > 0$ and $(B_t, t \ge 0)$ is a onedimensional Brownian motion started at 0. $(J_t, t \ge 0)$ is a pure jump Lévy process which is independent from $(B_t, t \ge 0)$. In addition $J_0 = 0$. Recall (see for instance Theorem 2.1, Chap. 2, [13]) that $(J_t, t \ge 0)$ is the sum of a compound Poisson process and a square integrable martingale whose jumps are of magnitude less than 1.

For simplicity, we may assume that $\sigma = 1$.

2. We are interested in the first hitting time of level x > 0

$$T_x := \inf \{ t \ge 0; \ X_t > x \} \,. \tag{0.2}$$

We also consider the overshoot K_x and the undershoot L_x :

$$K_x := X_{T_x} - x, \qquad (0.3)$$

$$L_x := x - X_{T_{x^-}} . (0.4)$$

The aim of this paper is to study the joint distribution of the triple (T_x, K_x, L_x) .

3. In the usual theory of risk in continuous time the surplus of an insurance company is modelled by a stochastic process $(Z_t, t \ge 0)$. The real number $x = Z_0$ denotes the initial surplus, and the random time $T_x := \inf \{t \ge 0; Z_t < 0\}$ may be interpreted as the ruin time. Historically, the first model (called classical or the Cramér-Lundberg one) was initiated by F. Lundberg [16] and H. Cramér [4], [3]. It refers to the case when $(Z_t, t \ge 0)$ is the sum of a drift and a compound Poisson process. The later represents the aggregate claims. In [8], Dufresne and Gerber have added a Brownian perturbation in the surplus process. Thus, the process $(x - Z_t, t \ge 0)$ corresponds to a particular case of our process $(X_t, t \ge 0)$. A lot of authors have developed extensions and have considered a great variety of processes $(Z_t, t \ge 0)$. They have mainly focused on the choice of more adapted processes $(Z_t, t \ge 0)$ to take into account the complex reality. It is not our purpose to present here all these developments. For more information one should refer to Rolski, Schmidli, Schmidt and J. Teugels' book [17], in which a large panel of models can be found.

Here are a few papers which are closely connected to the limit distribution of (T_x, K_x, L_x) , as $x \to \infty$.

- (a) J. Bertoin and R. Doney in [2] proved that the ruin probability $\mathbb{P}(T_x < \infty)$ is equivalent to $Ce^{-\alpha x}$, as $x \to \infty$. The authors has given in their paper an expression of the constant C with the ascending ladder height process associated with $(X_t, t \ge 0)$. When the Lévy process $(X_t, t \ge 0)$ has no negative jumps, then C and α may be calculated explicitly.
- (b) In the discrete time model, i.e. when $(X_t, t \ge 0)$ is replaced by a random walk, A. Gut [11] has considered the limit distribution of normalized passage times.

- (c) In both [10] and [7] analytical conditions are given to ensure that the ratio X_{T_x}/x almost surely converges to 1, as $x \to \infty$, in the discrete time model as well as in the case of Lévy processes.
- (d) R. Doney and A. Kyprianou [6] have showed that (K_x, L_x) converges in the distribution sense as x goes to infinity.

Our study presents the following features :

- (a) original analytic arguments of complex analysis are used, and especially meromorphic and holomorphic functions (see Theorem 2.8);
- (b) a decorrelation phenomenon : the couple (K_x, L_x) and a relevant normalization of T_x become asymptotically independent, $(x \to \infty)$ (cf Theorems 2.1 and 2.3);
- (c) new functional equations (cf Theorems 2.4 and 2.5).
- 4. Let us briefly describe the organization of the paper. In section 1, we will set up notation and assumptions. In Section 2, we will suppose that the Lévy measure ν of $(X_t, t \ge 0)$ satisfies the condition (H), which is defined in item 1.4 of Section 1.

In Section 2 we will list the main results of the paper. The two major theorems (cf Theorems 2.1 and 2.3) are related to the convergence in distribution of the triple $(\widetilde{T}_x, K_x, L_x)$ with $x \to \infty$. In addition \widetilde{T}_x is expressed in terms of T_x and x and it depends on the sign of $\mathbb{E}(X_1)$. In subsection 2.2 we present the important theorems which permit to demonstrate Theorems 2.1 and 2.3. Our approach is based on the study of the Laplace transform F of (T_x, K_x, L_x) :

$$F(\theta,\mu,\rho,x) := \mathbb{E}\left(e^{-\theta T_x - \mu K_x - \rho L_x} \mathbb{1}_{\{T_x < \infty\}}\right), \quad \theta,\,\mu,\,\rho \ge 0. \tag{0.5}$$

When $\nu(\mathbb{R})$ is finite, it is shown in Theorem 2.4 that $F(\theta, \mu, \rho, \cdot)$ satisfies some kind of integral equation. Introducing the Laplace transform $\widehat{F}(\theta, \mu, \rho, \cdot)$ of $F(\theta, \mu, \rho, \cdot)$:

$$\widehat{F}(\theta,\mu,\rho,q) := \int_0^{+\infty} e^{-qy} F(\theta,\mu,\rho,y) dy, \qquad (0.6)$$

we proved in Theorem 2.5 that, under (H), the function $\widehat{F}(\theta, \mu, \rho, \cdot)$ solves an equation which looks like an integral equation. Then an asymptotic development of $F(\theta, \mu, \rho, x)$ $(x \to \infty)$ with a finite number of terms like $C(\theta, \mu, \rho)e^{-\alpha(\theta)x}$ is given in Theorem 2.8. In the third subsection 2.3 we will determine the behavior of the ruin probability $\mathbb{P}(T_x < \infty)$, when x runs to infinity. Theorem 2.10 asserts that the ruin probability has a polynomial rate of decay at ∞ as soon as ν admits polynomial moments. All the proofs of results stated in Section 2 are postponed in Section 3.

Finally, in the last Section 4 we will give some complements and comments.

1 Characteristic exponent and elementary properties

1.1 Let ψ be the characteristic exponent of a Lévy process $(X_t, t \ge 0)$ with canonical decomposition (0.1), i.e. $\mathbb{E}(e^{iqX_t}) = e^{t\psi(q)}$ $(q \in \mathbb{R})$. With the Lévy-Khintchine formula, we get :

$$\psi(q) = -\frac{q^2}{2} - icq + \int_{\mathbb{R}} (e^{iqy} - 1 - iqy \mathbb{1}_{\{|y| < 1\}})\nu(dy), \quad q \in \mathbb{R}.$$
 (1.7)

where ν is the Lévy measure which satisfies $\int_{\mathbb{R}} (y^2 \wedge 1)\nu(dy) < \infty$. It is well known (cf [18], example 25.12) that as soon as $\int_{\mathbb{R}} |y| \mathbb{1}_{\{|y| \ge 1\}} \nu(dy) < \infty$ then

$$\mathbb{E}[|X_1|] < \infty, \tag{1.8}$$

and

$$\mathbb{E}(X_1) = -i\psi'(0) = -c + \int_{\mathbb{R}} y \mathbb{1}_{\{|y| \ge 1\}} \nu(dy).$$
(1.9)

When $(J_t, t \ge 0)$ is a compound Poisson process, there exists a relation between the drift term c_0 in (0.1) and c:

$$c = c_0 - \int_{\mathbb{R}} y \mathbb{1}_{\{|y| < 1\}} \nu(dy).$$
(1.10)

1.2 The following assumptions will be needed throughout the paper :

$$\int_{-\infty}^{-1} e^{sy} \nu(dy) < \infty, \ \forall s \in] -\infty, 0[$$

$$(1.11)$$

and

$$\int_{1}^{\infty} e^{sy} \nu(dy) < \infty, \quad \text{for some } s > 0.$$
 (1.12)

It is convenient to introduce :

$$r_{\nu} := \sup \{ s \ge 0; \ \int_{1}^{\infty} e^{sy} \nu(dy) < \infty \}.$$
 (1.13)

It is clear that (1.12) implies that $r_{\nu} \in]0, \infty]$.

Under (1.11) and (1.12), the function ψ may be extended to the half-space $\{z \in \mathbb{C}; \operatorname{Im}(z) > -r_{\nu}\}$. Let φ denote the function : $\varphi(q) := \psi(iq), q > -r_{\nu}$. If we consider the definition of ψ and the identity (1.7), we can infer that :

$$\mathbb{E}(e^{-qX_t}) = e^{t\varphi(q)},\tag{1.14}$$

and

$$\varphi(q) = \frac{q^2}{2} + cq + \int_{\mathbb{R}} (e^{-qy} - 1 + qy \mathbb{1}_{\{|y| < 1\}}) \nu(dy), \qquad (1.15)$$

for any $q \in] - r_{\nu}, \infty[$. Note that :

$$\varphi'(0) = -\mathbb{E}(X_1). \tag{1.16}$$

Assumptions (1.11) and (1.12) imply that φ is a function defined on $] - r_{\nu}, \infty[$ and :

$$\varphi''(q) = 1 + \int_{\mathbb{R}} y^2 e^{-qy} \nu(dy), \quad \text{for any } q \in]-r_{\nu}, \infty[.$$

Consequently, φ is convex on $] - r_{\nu}, \infty[$. It can be easily shown that $\varphi(\infty) := \lim_{x \to \infty} \varphi(x) = \infty.$

Let us discuss the behavior of φ in the vicinity of $-r_{\nu}$.

1. When $r_{\nu} = \infty$ then $\varphi(-r_{\nu}) := \lim_{q \to \infty} \varphi(q) = \infty$.

2. When
$$r_{\nu} < \infty$$
 and $\int_{1}^{\infty} e^{r_{\nu}y}\nu(dy) = \infty$ then $\varphi(-r_{\nu}) := \lim_{q \to -r_{\nu}} \varphi(q) = \infty$.

3. In the case :

$$r_{\nu} < \infty \quad \text{and} \quad \int_{1}^{\infty} e^{r_{\nu} y} \nu(dy) < \infty,$$
 (1.17)

then $\varphi(-r_{\nu})$ is a real number and :

$$\varphi(-r_{\nu}) = \frac{r_{\nu}^2}{2} - cr_{\nu} + \int_{\mathbb{R}} (e^{r_{\nu}y} - 1 - r_{\nu}y \mathbb{1}_{\{|y|<1\}})\nu(dy).$$
(1.18)

Let c_{ν} be the real number defined as :

$$\frac{r_{\nu}^2}{2} - c_{\nu}r_{\nu} + \int_{\mathbb{R}} (e^{r_{\nu}y} - 1 - r_{\nu}y\mathbb{1}_{\{|y|<1\}})\nu(dy) = 0.$$
(1.19)

Hence :

$$\varphi(-r_{\nu}) > 0 \Leftrightarrow c < c_{\nu}. \tag{1.20}$$

In the rest of the paper we assume

$$\varphi(-r_{\nu}) \in \left]0,\infty\right] \tag{1.21}$$

holds in any case.

1.3 In the sequel of the paper it will be convenient to deal with the parameter $\mathbb{E}(X_1)$. Note that this expectation may be expressed in terms of c and ν , via (1.9). The zeros of

$$\varphi_{\theta}(.) := \varphi(.) - \theta \tag{1.22}$$

are important parameters of our study. We can plot two graphs :

- 1. one represents φ and corresponds respectively to the three cases : $\mathbb{E}(X_1) < 0$, $\mathbb{E}(X_1) > 0$ and $\mathbb{E}(X_1) = 0$;
- 2. another which represents φ_{θ} .

(see the Figures 1 and 2 for illustration).



Figure 2: Graph of φ_{θ}

From the Figures 1 and 2, we can easily infer the existence of $\kappa > 0$ so that :

1. there is a unique $\gamma_0^*(\theta) \ge 0$ which satisfies :

$$\varphi(\gamma_0^*(\theta)) = \theta, \quad \forall \ \theta \in [0, \kappa]$$
(1.23)

and

$$\gamma_0^*(\theta) \left\{ \begin{array}{ll} >0 & \text{if } \theta > 0, \text{ or } \theta = 0 \text{ and } \mathbb{E}(X_1) > 0 \\ =0 & \text{if } \theta = 0 \text{ and } \mathbb{E}(X_1) \le 0. \end{array} \right.$$
(1.24)

2. there is a unique $\gamma_0(\theta) \ge 0$ which satisfies :

$$\varphi(-\gamma_0(\theta)) = \theta, \quad \forall \ \theta \in [0, \kappa]$$
(1.25)

and

$$-\gamma_0(\theta) \begin{cases} < 0 & \text{if } \theta > 0, \text{ or } \theta = 0 \text{ and } \mathbb{E}(X_1) < 0 \\ = 0 & \text{if } \theta = 0 \text{ and } \mathbb{E}(X_1) \ge 0. \end{cases}$$
(1.26)

So, when $\theta > 0$ is rather small, the positive (resp. negative) zero of φ_{θ} is $\gamma_0^*(\theta)$ (resp. $-\gamma_0(\theta)$).

1.4 In the rest of the paper, excepted in Section 2.3, we will require that ν and c satisfy (1.11), (1.12) and (1.21). On principle, let us consider these three conditions as assumption (*H*).

Note that, under (H), there is $\kappa > 0$ so that (1.23)-(1.26) holds.

2 The results

We keep notation given in Section 1.

2.1 Normalized limit distribution of (T_x, K_x, L_x) , as $x \to \infty$

In this section we will investigate the limit behavior of the triple (T_x, K_x, L_x) , as $x \to \infty$. Recall that K_x and L_x are defined by (0.3), resp. (0.4). Here as three cases : either $\mathbb{E}(X_1) > 0$, or $\mathbb{E}(X_1) < 0$ or $\mathbb{E}(X_1) = 0$. First, it can be assumed that $\mathbb{E}(X_1) < 0$.

Theorem 2.1 Under (H) and $\mathbb{E}(X_1) < 0$ then, conditionally on $\{T_x < \infty\}$, the triple $\left(\frac{1}{\sqrt{x}}\left(T_x + \frac{x}{\varphi'(-\gamma_0(0))}\right), K_x, L_x\right)$ converges in distribution when $x \to \infty$ to the 3-dimensional law $\mathcal{N}\left(0; -\frac{\varphi''(-\gamma_0(0))}{\varphi'^3(-\gamma_0(0))}\right) \otimes w^-$. In addition, w^- is the probability measure on $\mathbb{R}_+ \times \mathbb{R}_+$:

$$w^{-}(dk, dl) = \frac{-1}{\mathbb{E}(X_{1})} \left[\frac{\gamma_{0}(0)}{2} \, \delta_{0,0}(dk, dl) + (e^{\gamma_{0}(0)l} - 1) \mathbb{1}_{\{k \ge 0; l \ge 0\}} \, \nu_{l}(dk) \, dl + \int_{\mathbb{R}_{-}} \left(\int_{0}^{-y} (1 - e^{\gamma_{0}(0)(b+y)}) \mathbb{P}(T_{b} < \infty) n(b, dk, dl) db \, \mathbb{1}_{\{k \ge 0, l \ge 0\}} \right) \nu(dy) \right]$$

$$(2.1)$$

 $\nu_l(dk)$ is the image of $\nu(dk)$ by the map $y \to y-l$, and n(b, dk, dl) is the distribution of (K_b, L_b) conditionally on $\{T_b < \infty\}$.

If moreover the support of ν is included in $[0; \infty[, w^-(dk, dl) \text{ is given explicitly }:$

$$w^{-}(dk,dl) = \frac{-1}{\mathbb{E}(X_{1})} \left[\frac{\gamma_{0}(0)}{2} \,\delta_{0,0}(dk,dl) + (e^{\gamma_{0}(0)l} - 1) \mathbb{1}_{\{k \ge 0; l \ge 0\}} \,\nu_{l}(dk) \,dl \right] \quad (2.2)$$

- **Remark 2.2** 1. $\mathcal{N}(0; \sigma^2)$ denotes the Gaussian distribution with mean 0 and variance σ^2 .
 - 2. a) We may observe that time and positions become asymptotically independent. However the two components of the positions are not independent. In subsection 4.2, we give a stochastic interpretation of the limit distribution w⁻(dk, dl) defined by (2.2).
 b) Obviously K_x + L_x = X_x - X_x - is the jump size of (X_t − t ≥ 0) at T_x. It is

b) Obviously $K_x + L_x = X_{T_x} - X_{T_x^-}$ is the jump size of $(X_t, t \ge 0)$ at T_x . It is easy to infer from Theorem 2.1 that $\left(\frac{1}{\sqrt{x}}\left(T_x + \frac{x}{\varphi'(-\gamma_0(0))}\right), X_{T_x} - X_{T_x^-}\right)$ converges in distribution, as $x \to \infty$, to $\mathcal{N}\left(0; -\frac{\varphi''(-\gamma_0(0))}{\varphi'^3(-\gamma_0(0))}\right) \otimes \widetilde{w}$ where \widetilde{w} is the probability measure on \mathbb{R}_+ :

$$\begin{split} \widetilde{w}(ds) &= \frac{-1}{\mathbb{E}(X_1)} \left[\frac{\gamma_0(0)}{2} \,\delta_0(ds) + \frac{e^{\gamma_0(0)s} - 1 - \gamma_0(0)s}{\gamma_0(0)} \mathbb{1}_{\{s \ge 0\}} \,\nu(ds) \right. \\ &+ \int_{\mathbb{R}_-} \left(\int_0^{-y} (1 - e^{\gamma_0(0)(b+y)}) \mathbb{P}(T_b < \infty) n(b, ds) db \right) \nu(dy) \mathbb{1}_{\{s \ge 0\}} \right], \end{split}$$

$$(2.3)$$

and n(b, ds) is the distribution of $X_{T_b} - X_{T_b}$ conditionally on $\{T_b < \infty\}$. If the jumps of $(X_t, t \ge 0)$ are positive, $\widetilde{w}(ds)$ can be simplified :

$$\widetilde{w}(ds) = \frac{-1}{\mathbb{E}(X_1)} \left[\frac{\gamma_0(0)}{2} \,\delta_0(ds) + \frac{e^{\gamma_0(0)s} - 1 - \gamma_0(0)s}{\gamma_0(0)} \mathbb{1}_{\{s \ge 0\}} \,\nu(ds) \right].$$
(2.4)

Let list the results related to the two other cases : $\mathbb{E}(X_1) > 0$ and $\mathbb{E}(X_1) = 0$.

Theorem 2.3 Assume (H).

1. When $\mathbb{E}(X_1) > 0$, then $T_x < \infty$ a.s. and the triple $\left(\frac{1}{\sqrt{x}}\left(T_x + \frac{x}{\varphi'(0)}\right), K_x, L_x\right)$ converges in distribution, as $x \to \infty$, to $\mathcal{N}\left(0; -\frac{\varphi''(0)}{\varphi'^3(0)}\right) \otimes w^+$, where w^+ is defined by the relation obtained after replacing $\gamma_0(0)$ by $-\gamma_0^*(0)$ in (2.1). In particular if $(X_t, t \ge 0)$ has only positive jumps :

$$w^{+}(dk, dl) = \frac{1}{\mathbb{E}(X_{1})} \left[\frac{\gamma_{0}^{*}(0)}{2} \,\delta_{0,0}(dk, dl) + (1 - e^{-\gamma_{0}^{*}(0)l}) \mathbb{1}_{\{k \ge 0, \ l \ge 0\}} \,\nu_{l}(dk) \, dl \right].$$
(2.5)

2. When $\mathbb{E}(X_1) = 0$, then $\left(\frac{T_x}{x^2}, K_x, L_x\right)$ converges in distribution, as $x \to \infty$, to $\varrho \otimes w^0$. ϱ denotes the law of the first hitting time of level $\sqrt{\frac{1}{\varphi''(0)}}$ by a standard Brownian motion started at 0. Let us recall that $\int_0^\infty e^{-\theta x} \varrho(dx) = e^{-\sqrt{\frac{2\theta}{\varphi''(0)}}}$. Moreover $\varphi''(0) = 1 + \int_{\mathbb{R}} y^2 \nu(dy)$.

The probability measure w^0 on $\mathbb{R}_+\times\mathbb{R}_+$ is defined as follows :

$$w^{0}(dk, dl) = \frac{1}{\varphi''(0)} \left[\delta_{0,0}(dk, dl) + 2l \mathbb{1}_{\{k \ge 0, l \ge 0\}} \nu_{l}(dk) \, dl -2 \int_{\mathbb{R}_{-}} \left(\int_{0}^{-y} (b+y)n(b, dk, dl) db \, \mathbb{1}_{\{k \ge 0, l \ge 0\}} \right) \nu(dy) \right], \quad (2.6)$$

when n(b, dk, dl) is the distribution of (K_b, L_b) . This expression may be simplified if $(X_t, t \ge 0)$ has only positive jumps (i.e. $\nu(] - \infty, 0[) = 0$):

$$w^{0}(dk, dl) = \frac{1}{\varphi''(0)} \left[\delta_{0,0}(dk, dl) + 2l \mathbb{1}_{\{k \ge 0, l \ge 0\}} \nu_{k}(dl) dk \right]$$
(2.7)

We will present two complements of Theorems 2.1 and 2.3.

1. Let us introduce :

$$\widetilde{T}_{x} = \begin{cases} \frac{1}{\sqrt{x}} \left(T_{x} + \frac{x}{\varphi'(-\gamma_{0}(0))} \right) & \text{when } \mathbb{E}(\mathbf{X}_{1}) < 0\\ \frac{1}{\sqrt{x}} \left(T_{x} + \frac{x}{\varphi'(0)} \right) & \text{when } \mathbb{E}(\mathbf{X}_{1}) > 0\\ \frac{T_{x}}{x^{2}} & \text{when } \mathbb{E}(\mathbf{X}_{1}) = 0 \end{cases}$$
(2.8)

In subsection 4.1, a rate of convergence of \widetilde{T}_x to the associated Gaussian distribution, as $x \to \infty$ is given.

2. In subsection 4.2, we will provide a stochastic realization of the probability measure w^- , resp. w^+ defined by (2.2), resp. (2.5).

2.2 Auxiliary results

To study the joint distribution of (T_x, K_x, L_x) , the Laplace transform F of this three dimensional r.v. is used :

$$F(\theta, \mu, \rho, x) = \mathbb{E}\left(e^{-\theta T_x - \mu K_x - \rho L_x} \mathbb{1}_{\{T_x < \infty\}}\right), \qquad (2.9)$$

for any $\theta \ge 0$, $\mu \ge 0$, $\rho \ge 0$.

a) When $\nu(\mathbb{R}) < \infty$ (i.e. $(J_t, t \ge 0)$ is a compound Poisson process), we first prove (see Theorem 2.4 below) that $F(\theta, \mu, \rho, \cdot)$ satisfies a kind of integral equation.

Theorem 2.4 Assume $\lambda = \nu(\mathbb{R}) < \infty$. For any $\theta \ge 0$, $\mu \ge 0$ and $\rho \ge 0$, the function $F(\theta, \mu, \rho, .)$ is solution of the following integral equation :

$$G(x) = F_0(\theta, \mu, \rho, x) + F_1(\theta, \mu, \rho, x) + \Lambda_\theta G(x) \qquad \forall x \ge 0$$
(2.10)

where

$$\alpha_{\theta} = \sqrt{c_0^2 + 2(\lambda + \theta)}, \qquad (2.11)$$

$$F_0(\theta, \mu, \rho, x) = e^{-(c_0 + \alpha_\theta)x},$$
(2.12)

$$F_{1}(\theta, \mu, \rho, x) = \frac{e^{-(c_{0}+\alpha_{\theta})x}}{\alpha_{\theta}(\mu-\rho+c_{0}+\alpha_{\theta})} \int_{[0,x]} \left(e^{(-\rho+c_{0}+\alpha_{\theta})y} - e^{-\mu y}\right) \nu(dy) + \frac{e^{-\rho x}}{\alpha_{\theta}(\mu-\rho+c_{0}-\alpha_{\theta})} \int_{]x,\infty[} \left(e^{-(\rho+\alpha_{\theta}-c_{0})(y-x)} - e^{-\mu(y-x)}\right) \nu(dy) + \frac{e^{(\mu-\rho)x} - e^{-(c_{0}+\alpha_{\theta})x}}{\alpha_{\theta}(\mu-\rho+c_{0}+\alpha_{\theta})} \int_{]x,\infty[} e^{-\mu y} \nu(dy) - \frac{e^{-(c_{0}+\alpha_{\theta})x}}{\alpha_{\theta}(\mu-\rho+c_{0}-\alpha_{\theta})} \int_{0}^{\infty} \left(e^{-(\rho+\alpha_{\theta}-c_{0})y} - e^{-\mu y}\right) \nu(dy), \quad (2.13)$$

and Λ_{θ} is the operator :

$$\Lambda_{\theta}G(x) = \frac{1}{\alpha_{\theta}} \int_{-\infty}^{\infty} \nu(dy) \int_{-\infty}^{(x-y)\wedge x} e^{-c_0 a} \left(e^{-\alpha_{\theta}|a|} - e^{-(2x-a)\alpha_{\theta}} \right) G(x-a-y) da \,.$$

$$\tag{2.14}$$

The positive operator Λ_{θ} will be studied in details in subsection 4.3. In particular, it is proved that, under suitable assumptions, $F(\theta, \mu, \rho, \cdot)$ is the unique function G which solves the equation (2.10), and can be strongly approximated by a series.

b) However the operator Λ_{θ} cannot be defined if ν is not a finite measure. The formula (2.10) does not permit to consider Lévy processes which are not reduced to a Brownian motion with drift plus a compound Poisson process. To avoid this difficulty, we introduce the Laplace transform $\widehat{F}(\theta, \mu, \rho, \cdot)$ of $F(\theta, \mu, \rho, \cdot)$:

$$\widehat{F}(\theta,\mu,\rho,q) = \int_0^\infty e^{-qy} F(\theta,\mu,\rho,y) dy.$$
(2.15)

This definition is meaningful for any q such that $\operatorname{Re}(q) > 0$, since $F(\theta, \mu, \rho, .)$ is a bounded function on $[0, \infty]$.

Taking the Laplace transform in (2.10), proves (see Theorem 2.5 below) that under (H), $\hat{F}(\theta, \mu, \rho, .)$ verifies some kind of integral equation which remains valid when ν is a Lévy measure with no necessary finite mass.

Before stating this result, let us denote by R the operator :

$$Rh(q) := \int_{-\infty}^{0} \nu(dy) \int_{0}^{-y} \left(e^{-q(b+y)} - 1 \right) h(b) db , \qquad (2.16)$$

where $q \in \mathbb{C}$, $\operatorname{Re}(q) > 0$ and $h \in L^{\infty}(\mathbb{R}_+)$. Note that the identity (1.11) implies that Rh(q) is well defined. **Theorem 2.5** Let us assume that (H) holds. Let $\theta, \mu, \rho \ge 0$, $q \in \mathbb{C}$, $\operatorname{Re}(q) > 0$. We get :

$$\widehat{F}(\theta,\mu,\rho,q) = \frac{1}{\varphi(q)-\theta} \left(\frac{q-\gamma_0^*(\theta)}{2} + \int_0^\infty \left[\frac{e^{-(q+\rho)y} - e^{-\mu y}}{q+\rho-\mu} - \frac{e^{-(\gamma_0^*(\theta)+\rho)y} - e^{-\mu y}}{\gamma_0^*(\theta)+\rho-\mu} \right] \nu(dy) + RF(\theta,\mu,\rho,.)(q) - RF(\theta,\mu,\rho,.)(\gamma_0^*(\theta)) \right)$$
(2.17)

where $\gamma_0^*(\theta)$ is defined in (1.23) and (1.24).

Remark 2.6 1. If $\nu(]-\infty, 0[) = 0$ then $RF(\theta, \mu, \rho, .)$ is cancelled, and $\widehat{F}(\theta, \mu, \rho, q)$ is given by the following explicit formula :

$$\widehat{F}(\theta,\mu,\rho,q) = \frac{1}{\varphi(q) - \theta} \left(\frac{q - \gamma_0^*(\theta)}{2} + \int_0^\infty \left[\frac{e^{-(q+\rho)y} - e^{-\mu y}}{q + \rho - \mu} - \frac{e^{-(\gamma_0^*(\theta) + \rho)y} - e^{-\mu y}}{\gamma_0^*(\theta) + \rho - \mu} \right] \nu(dy) \right)$$
(2.18)

2. If $\nu(]0,\infty[) = 0$ (2.17) is reduced to :

$$\widehat{F}(\theta,\mu,\rho,q) = \frac{1}{\varphi(q)-\theta} \left(\frac{q-\gamma_0^*(\theta)}{2} + RF(\theta,\mu,\rho,.)(q) - RF(\theta,\mu,\rho,.)(\gamma_0^*(\theta)) \right)$$
(2.19)

Let us briefly detail the case θ = μ = ρ = 0 (i.e. F(0,0,0,x) is the ruin probability). If E(X₁) ≥ 0, it is easy to check that f : x → 1 satisfies (2.17). In the more interesting case : E(X₁) < 0, since γ₀^{*}(0) = 0, then the relation (2.17) may be simplified. Suppose moreover that ν(] −∞,0[) = 0, then (2.18) is reduced to :

$$\widehat{F}(0,0,0,q) = \int_0^\infty e^{-qy} \mathbb{P}(T_y < \infty) dy = \frac{1}{q} + \frac{\mathbb{E}(X_1)}{\varphi(q)}.$$
 (2.20)

Therefore (2.20) generalizes identity (3.3) in [8]. Since $\{T_y < \infty\} = \{\bar{X}_\infty > y\}$, where $\bar{X}_\infty := \sup_{t \ge 0} X_t$, then (2.20) is equivalent to :

$$\mathbb{E}\left(e^{-q\bar{X}_{\infty}}\right) = -\mathbb{E}(X_1)\frac{q}{\varphi(q)}, \quad q > 0.$$
(2.21)

Note that in the case $\nu(]0,\infty[) = 0$, then $F(0,0,0,x) = \mathbb{P}(T_x < \infty) = e^{-\gamma_0(0)x}$.

c) Let us briefly indicate how Theorem 2.5 enables to obtain the asymptotic behavior of (\tilde{T}_x, K_x, L_x) as $x \to \infty$. Using the Mellin-Fourier inverse transformation, it is actually possible to recover $F(\theta, \mu, \rho, \cdot)$ (see the formula (3.70) in Section 3.4). It implies that the asymptotic behavior of $F(\theta, \mu, \rho, x)$, $x \to \infty$ depends on the poles of $\hat{F}(\theta, \mu, \rho, \cdot)$. According to (2.17), the complex zeros of φ_{θ} are the poles of $\hat{F}(\theta, \mu, \rho, \cdot)$. Under (*H*) and (2.23), we may determine in Proposition 2.7 the zeros of φ_{θ} . Hence, we may obtain an expansion of $F(\theta, \mu, \rho, x)$ as $x \to \infty$ (see Theorem 2.8 below). Finally that allows to determine the limit distribution of the random triple considered above as x goes to infinity. Let

$$B_{\nu} := \sup \left\{ b > 0 \; ; \; q \mapsto \int_{1}^{\infty} e^{-qy} \nu(dy) \text{ admits a meromorphic extension to } D_{-b} \right\},$$
(2.22)

where $D_{-b} := \{q \in \mathbb{C}; \operatorname{Re} q > -b\}$

Note that $B_{\nu} \geq r_{\nu}$ and B_{ν} may be equal to ∞ . Then φ has a meromorphic extension to $D_{-B_{\nu}}$. For simplicity, this extension will be denoted φ . Our last assumption on ν is :

$$\forall B \in]0, B_{\nu}[, \exists K, R_0 > 0, \text{ so that }: \left| \int_1^{\infty} e^{-qy} \nu(dy) \right| \le K |q| , \quad \text{for any } q \text{ so that } \begin{cases} -B \le \operatorname{Re} q \le 0 \\ |\operatorname{Im} q| \ge R_0 \end{cases}$$
 (2.23)

A large class of measures ν satisfying (H) and (2.23) will be given in subsection 4.4. First, we will concentrate on the complex zeros of the function φ_{θ} defined by (1.22). Then, we will give in Theorem 2.8 an asymptotic expansion of $F(\theta, \mu, \rho, x)$ as $x \to \infty$.

Proposition 2.7 Let us suppose that (H) and (2.23) hold. Then for any $\theta \in [0, \kappa]$, there exists $\beta_{\theta} > 0$ such that for any $B \in]0, B_{\nu}[, \varphi_{\theta} \text{ admits a finite number of conjugated zeros in the strip <math>D_{-B,\beta_{\theta}} := \{q \in \mathbb{C} ; -B \leq \operatorname{Re} q \leq \beta_{\theta}\}.$ This set of zeros of φ_{θ} in $D_{-B,\beta_{\theta}}$ is equal to (cf. Figure 3 below) :

- $1. \ \left\{-\gamma_0(\theta), \ -\gamma_1(\theta), \ -\overline{\gamma_1}(\theta), \ \cdots, -\gamma_p(\theta), \ -\overline{\gamma_p}(\theta)\right\} \quad \text{ if } \quad \theta > 0 \,,$
- 2. $\{0, -\gamma_0(0), -\gamma_1(0), -\overline{\gamma_1}(0), \cdots, -\gamma_p(0), -\overline{\gamma_p}(0)\}$ if $\theta = 0$ and $\mathbb{E}(X_1) < 0$,
- 3. $\{-\gamma_0(0) = 0, -\gamma_1(0), -\overline{\gamma_1}(0), \cdots, -\gamma_p(0), -\overline{\gamma_p}(0)\}$ if $\theta = 0$ and $\mathbb{E}(X_1) \ge 0$, where

$$-B < \operatorname{Re}\left(-\gamma_p(\theta)\right) \le \dots \le \operatorname{Re}\left(-\gamma_1(\theta)\right) < -\gamma_0(\theta) \le 0.$$
(2.24)

4. $-\gamma_0(\theta)$ is a simple (resp. double) zero of φ_{θ} , if $\theta > 0$, or $\theta = 0$ and $\mathbb{E}(X_1) \neq 0$ (resp. otherwise, i.e. $\theta = 0$ and $\mathbb{E}(X_1) = 0$).

The zeros of φ_{θ} which are the poles of $\widehat{F}(\theta, \mu, \rho, \cdot)$ will play an important role in our approach, as shown below (see the proof of Theorem 2.8 in Section 3.4, and properties in Section 4.5).

Theorem 2.8 Let us suppose (H) and (2.23). Then for any $\theta \in [0, \kappa]$, $\mu \ge 0$ and $\rho \ge 0$, there exists a positive number $C_0(\theta, \mu, \rho) > 0$ and complex x-polynomial functions $C_1(\theta, \mu, \rho, x), \dots, C_p(\theta, \mu, \rho, x)$ so that $F(\theta, \mu, \rho, x)$ has the following asymptotic expansion as $x \to \infty$:

$$F(\theta,\mu,\rho,x) = C_0(\theta,\mu,\rho)e^{-\gamma_0(\theta)x} + \sum_{i=1}^p a_i \left(C_i(\theta,\mu,\rho,x)e^{-\gamma_i(\theta)x} + \overline{C_i}(\theta,\mu,\rho,x)e^{-\overline{\gamma_i}(\theta)x} \right) + O\left(e^{-Bx}\right), \qquad (2.25)$$

where $a_i = \frac{1}{2}$ if $\gamma_i(\theta)$ is real and $a_i = 1$ otherwise. The degree of $C_i(\theta, \mu, \rho, .)$ is $n_i - 1$, where n_i is the order of multiplicity of $-\gamma_i(\theta)$. In addition, O is uniform with respect to $\mu \ge 0$, $\rho \ge 0$ and $\theta \in [0, \kappa]$.

Remark 2.9 1. In (2.25), it is understood that B may be chosen in $]0, B_{\nu}[$ closest as possible to B_{ν} .

- 2. In Section 4.5 we study the coefficients $C_i(\theta, \mu, \rho, x)$.
- 3. Obviously, (2.25) and (2.24) imply that :

$$\lim_{x \to \infty} F(\theta, \mu, \rho, x) e^{\gamma_0(\theta)x} = C_0(\theta, \mu, \rho).$$
(2.26)

This property has already been reached in [2] in the particular case : $\theta = \mu = \rho = 0$:

$$F(0,0,0,x) = \mathbb{P}(T_x < \infty) \sim C_0(0,0,0) e^{-\gamma_0(0)x} \quad \text{as} \quad x \to \infty.$$
(2.27)

4. Heuristically, no assumption on the negative jumps is required to get :

$$F(\theta, \mu, \rho, x) \le C e^{-\gamma_0(\theta)x} \,. \tag{2.28}$$

However to obtain an equivalent, or an asymptotic development of $F(\theta, \mu, \rho, x)$ when x goes to infinity, it is natural to suppose that the negative and the positive parts of the jumps of $(X_t, t \ge 0)$ are controlled. Our asymptotic development looks like a perturbation theorem around the case of Brownian motion with negative drift.

2.3 Polynomial decay

According to item 3. of Remark 2.9, under (H) and (2.23), the ruin probability goes to 0, with exponential rate. The aim is to prove that under weaker assumptions,

$$F(x) := F(0, 0, 0, x) = \mathbb{P}(T_x < \infty)$$
(2.29)

has a polynomial type rate of decay, as $x \to \infty$. In this section we suppose neither (H) nor (2.23).

Theorem 2.10 Let us assume that

$$\int_{\mathbb{R}} |y| \mathbb{1}_{\{|y|>1\}} \nu(dy) < \infty \quad \text{and} \quad \mathbb{E}(X_1) = -c + \int_{\mathbb{R}} y \mathbb{1}_{\{|y|\geq 1\}} \nu(dy) < 0.$$
(2.30)

and

$$\int_0^\infty y^p \nu(dy) < \infty , \quad \text{for some} \quad p \ge 2.$$
 (2.31)

Let n be the integer part of p-2, then

$$\forall x \in \mathbb{R}_+ \qquad \mathbb{P}(T_x < \infty) \le \frac{C_n}{1 + x^n},$$
(2.32)

where $C_n > 0$.

3 Proofs

3.1 Proof of Theorems 2.1 and 2.3

Our approach is only based on the following estimate :

$$F(\theta, \mu, \rho, x) \sim C_0(\theta, \mu, \rho) e^{-\gamma_0(\theta)x} \quad \text{as} \quad x \to \infty,$$
 (3.1)

where $F(\theta, \mu, \rho, x)$ (resp. $\gamma_0(\theta)$) is defined by (2.9) (resp. (1.25) and (1.26)). The coefficient $C_0(\theta, \mu, \rho)$ comes from (2.25) included in Theorem 2.8.

Theorems 2.1 and 2.3 related to the three cases $\mathbb{E}(X_1) > 0$, $\mathbb{E}(X_1) < 0$ and $\mathbb{E}(X_1) = 0$ may be proved by using the same technique. Therefore we will only consider the case $\mathbb{E}(X_1) = 0$ and the case $\mathbb{E}(X_1) < 0$ (see Section 4.6 too).

3.1.1

Let us start with the case $\mathbb{E}(X_1) = 0$.

(i) Since $\varphi(-\gamma_0(\theta)) = \theta$, $\varphi(0) = 0$ and $\varphi'(0) = 0$, we may use the asymptotic expansion of φ at 0 at order 2 :

$$\theta = \varphi(-\gamma_0(\theta)) = \varphi(-h) = \frac{h^2}{2}\varphi''(0) + o(h^2).$$
 (3.2)

Therefore :

$$\gamma_0(\theta) = h = \sqrt{\frac{2\theta}{\varphi''(0)}} + o(\sqrt{\theta}).$$
(3.3)

Recall that (3.1) is uniform with respect to $\theta \in [0, \kappa]$. Then replacing θ by $\frac{\theta}{x^2}$ in (3.1) brings to :

$$F\left(\frac{\theta}{x^2}, \mu, \rho, x\right) = \mathbb{E}\left(e^{-\theta \frac{T_x}{x^2} - \mu K_x - \rho L_x} \mathbb{1}_{\{T_x < \infty\}}\right)$$
$$\sim C_0\left(\frac{\theta}{x^2}, \mu, \rho\right) e^{-\sqrt{\frac{2\theta}{\varphi''(0)}}} \quad \text{as} \quad x \to \infty,$$
$$\sim C_0\left(0, \mu, \rho\right) e^{-\sqrt{\frac{2\theta}{\varphi''(0)}}} \quad \text{as} \quad x \to \infty.$$
(3.4)

(*ii*) We would like to demonstrate in this item that $C_0(0, \mu, \rho)$ and $e^{-\sqrt{\frac{2\theta}{\varphi''(0)}}}$ are Laplace transforms of probability measures on $[0, \infty[\times[0, \infty[$ and $[0, \infty[$ respectively. As for $e^{-\sqrt{\frac{1}{\varphi''(0)}}\sqrt{2\theta}}$, it is well known (cf. [12] page 96 formula (8.6)) that it is the Laplace transform of the first hitting time to level $\sqrt{\frac{1}{\varphi''(0)}}$ for a standard Brownian motion started at 0.

Let us prove that $C_0(0, \mu, \rho)$ is a Laplace transform. We modify the identity (4.34) in Section 4.5 via the relation :

$$\frac{e^{-ay} - 1 + ay}{a^2} = -\int_0^y (z - y)e^{-az}dz.$$

Then, we obtain :

$$C_{0}(0,\mu,\rho) = \frac{1}{\varphi''(0)} \left[1 - 2 \int_{0}^{\infty} e^{-\rho y} \left(\int_{0}^{y} (z-y) e^{(\rho-\mu)z} dz \right) \nu(dy) - 2 \int_{-\infty}^{0} \left(\int_{0}^{-y} (y+b) \mathbb{E} \left(e^{-\mu K_{b}-\rho L_{b}} \mathbb{1}_{\{T_{b}<\infty\}} \right) db \right) \nu(dy) \right].$$
(3.5)

Let n(b, du, dz) be the distribution of the couple (K_b, L_b) . Consequently, $C_0(0, \mu, \rho)$ may be written as follows :

$$C_{0}(0,\mu,\rho) = \frac{1}{\varphi''(0)} \left[1 + 2 \int_{0}^{\infty} e^{-\mu z} \left(\int_{[z,\infty[} (y-z)e^{-\rho(y-z)}\nu(dy) \right) dz - 2 \int_{0}^{\infty} \int_{0}^{\infty} e^{-\mu u} e^{-\rho z} \int_{-\infty}^{0} \left(\int_{0}^{-y} (y+b)n(b,du,dz)db \right) \nu(dy) \right] = \int_{0}^{\infty} \int_{0}^{\infty} e^{-\mu u} e^{-\rho z} w^{0}(du,dz).$$
(3.6)

with w^0 defined in (2.6).

3.1.2

Next we study the case $\mathbb{E}(X_1) < 0$.

(i) On one hand, from (3.1), we have :

$$\mathbb{E}\left(e^{-\theta T_x - \mu K_x - \rho L_x} | T_x < \infty\right) = \frac{F(\theta, \mu, \rho, x)}{\mathbb{P}(T_x < \infty)} = \frac{F(\theta, \mu, \rho, x)}{F(0, 0, 0, x)}$$
$$\sim \frac{C_0(\theta, \mu, \rho)}{C_0(0, 0, 0)} e^{-(\gamma_0(\theta) - \gamma_0(0))x} \quad \text{as} \quad x \to \infty.$$
(3.7)

On the other hand, the behavior of $\gamma_0(\theta)$ in a neighborhood of 0 is the following :

$$\gamma_0(\theta) - \gamma_0(0) = -\frac{1}{\varphi'(-\gamma_0(0))}\theta + \frac{\varphi''(-\gamma_0(0))}{2\varphi'^3(-\gamma_0(0))}\theta^2 + o(\theta^2) \quad (\theta \to 0).$$
(3.8)

Combining (3.7) and (3.8) leads after easy calculations to :

$$\mathbb{E}\left(e^{-\frac{\theta}{\sqrt{x}} T_x + \frac{x}{\varphi'(-\gamma_0(0))} - \mu K_x - \rho L_x} | T_x < \infty\right) \sim \frac{C_0(0, \mu, \rho)}{C_0(0, 0, 0)} e^{-\frac{1}{2}\frac{\varphi''(-\gamma_0(0))}{\varphi'^3(-\gamma_0(0))}\theta^2} \quad \text{as} \quad x \to \infty.$$
(3.9)

Let us observe that $e^{-\frac{1}{2}\frac{\varphi''(-\gamma_0(0))}{\varphi'^3(-\gamma_0(0))}\theta^2}$ is the Laplace transform (with respect to the θ variable) of the Gaussian distribution with mean 0 and variance $\frac{\varphi''(-\gamma_0(0))}{\varphi'^3(-\gamma_0(0))}$. As a result Theorem 2.1 will be proved as soon as we demonstrate that $\frac{C_0(0,\mu,\rho)}{C_0(0,0,0)}$ is the Laplace transform of a probability measure on $[0,\infty[\times[0,\infty[.$ We proceed as in the case 3.1.1 above. We begin by using the relation (4.34) :

$$\frac{C_0(\theta,\mu,\rho)}{C_0(0,0,0)} = \frac{1}{C_0(0,0,0)\varphi'(-\gamma_0(0))} \left[-\frac{\gamma_0(0)}{2} + \int_0^\infty \frac{e^{-(-\gamma_0(0)+\rho)y} - e^{-\mu y}}{-\gamma_0(0)+\rho-\mu} \nu(dy) - \int_0^\infty \frac{e^{-\rho y} - e^{-\mu y}}{\rho-\mu} \nu(dy) + RF(0,\mu,\rho,.)(-\gamma_0(0)) \right].$$
(3.10)

It follows :

$$\frac{C_0(\theta,\mu,\rho)}{C_0(0,0,0)} = \frac{1}{C_0(0,0,0)\varphi'(-\gamma_0(0))} \left[-\frac{\gamma_0(0)}{2} + \int_0^\infty e^{-\mu y} \left(\int_0^y -e^{-(-\gamma_0(0)+\rho-\mu)z} dz \right) \nu(dy) - \int_0^\infty e^{-\mu y} \left(\int_0^y e^{-(\rho-\mu)z} dz \right) \nu(dy) + RF(0,\mu,\rho,.)(-\gamma_0(0)) \right].$$
(3.11)

Using the Fubini theorem we get :

Let n(b, du, dz) be the distribution of (K_b, L_b) conditionally on $\{T_b < \infty\}$. Then :

= \int_0^\infty \int_0^\infty e^{-\mu u} e^{-\rho z} w^-(du,dz).$$
(3.13)

with w^- defined in (2.1).

3.2 Proof of Theorem 2.4

In this subsection it is assumed that : $\lambda := \nu(\mathbb{R}) < \infty$. Then $(J_t, t \ge 0)$ is a compound Poisson process. As a result, it admits a first jump time τ_1 , exponentially distributed with parameter $\nu(\mathbb{R})$ (cf [18], theorem 21.1). The process $(X_{t+\tau_1} - X_{\tau_1}; t \ge 0)$ is again a Lévy process distributed as $(X_t, t \ge 0)$. This property is the key of our approach that we will briefly describe. Let us consider three cases :

- $T_x = \inf \{t \ge 0; B_t c_0 t > x\} < \tau_1$ if $\sup_{0 \le t \le \tau_1} (B_t c_0 t) > x$,
- $T_x = \tau_1$ if $\sup_{0 \le t \le \tau_1} (B_t c_0 t) < x$ and $J_{\tau_1} + B_{\tau_1} c_0 \tau_1 > x$,
- $T_x > \tau_1$ otherwise. Then, conditionally on $\{T_x > \tau_1\}, T_x \tau_1$ is distributed as $\widehat{T}_{x-X_{\tau_1}}$ where $(\widehat{T}_x; x > 0)$ is an independent copy of $(T_x; x > 0)$. $(\widehat{T}_x; x > 0)$ is independent from $(X_t, t \ge 0)$ as well. This "renewal" part gives rise to the integral kernel Λ_{θ} defined in (2.14).

This leads us to decompose $F(\theta, \mu, \rho, .)$ defined by (2.9), as follows :

$$F(\theta,\mu,\rho,x) = \mathbb{E}\left(e^{-\theta T_x - \mu K_x - \rho L_x} \mathbb{1}_{\{T_x < \tau_1\}}\right) + \mathbb{E}\left(e^{-\theta T_x - \mu K_x - \rho L_x} \mathbb{1}_{\{T_x = \tau_1\}}\right) \\ + \mathbb{E}\left(e^{-\theta T_x - \mu K_x - \rho L_x} \mathbb{1}_{\{\tau_1 < T_x < \infty\}}\right).$$

We will calculate the two first terms of (3.14) in Lemmas 3.1, 3.2. The third one will be determined in Lemma 3.3.

Lemma 3.1 Let α_{θ} be the real number, defined in (2.11), then :

since the distribution of Y_1 is $\frac{1}{\lambda}\nu$. The density function of $(\sup_{u \leq t} B_u, B_t)$ is given in ([12] page 95), i.e. :

$$\int_0^\infty \frac{2}{\sqrt{2\pi t^3}} \ e^{-\frac{1}{2} \ (2(\lambda+\theta)+c_0^2)t+\frac{(2b-a)^2}{t}} \ dt \,. \tag{3.24}$$

Let us recall the classical identities (cf. [14] p 118, or [9] sections 8.432 6 page 959, and 8.469 3 page 967) :

If the integral is computed according to da, we may easily obtain (3.18).

Lemma 3.3 In (3.14), the third expectation is equal to :

Remark 3.4 By introducing adapted functional Banach spaces, we may study in subsection 4.3 (cf. Theorem 4.2 and Proposition 4.3) the operator Λ_{θ} . We can prove that $F(\theta, \mu, \rho, .)$ is the unique solution of (2.10). Moreover, if $\theta > 0$, or $\theta = 0$ and $\mathbb{E}(X_1) < 0$, then $F(\theta, \mu, \rho, .)$ has a sub-exponential rate of decay :

$$F(\theta, \mu, \rho, x) \le Ce^{-\gamma x}, \quad \forall x \ge 0, \quad \text{for some} \quad C > 0, \gamma > 0.$$
 (3.32)

The optimal value of γ has be given in Remark 2.9.

Note that if $\theta = 0$ and $\mathbb{E}(X_1) \ge 0$, then F(0, 0, 0, x) = 1, hence there is no hope to obtain a sub-exponential rate of decay.

3.3 Proof of Theorem 2.5

Assume that ν satisfies the assumptions given in Theorem 2.5. The proof of Theorem 2.5 will be divided into two steps. We will first prove (2.17) when $\nu(\mathbb{R}) < \infty$. In a second step, we will approximate ν by a sequence of finite measures (ν_n). Then by replacing ν by ν_n , and by taking the limit $n \to \infty$, it will be proved that (2.17) remains valid.

Step 1 Let us suppose that $\nu(\mathbb{R}) < \infty$.

a) Taking the Laplace transform in functional equation (2.10) leads to :

$$= \frac{1}{\alpha_{\theta}(q+c+\alpha_{\theta})(\mu+c+\alpha_{\theta}-\rho)} \int_{0}^{\infty} \left(e^{-(q+\rho)y} - e^{-(q+\mu+c+\alpha_{\theta})y} \right) \nu(dy),$$

$$= \frac{1}{\alpha_{\theta}(\mu+c-\alpha_{\theta}-\rho)} \int_{0}^{\infty} \left(\frac{e^{-(\rho+\alpha_{\theta}-c)y} - e^{-(q+\rho)y}}{q+c-\alpha_{\theta}} + \frac{e^{-(q+\rho)y} - e^{-\mu y}}{q+\rho-\mu} \right) \nu(dy),$$

$$I_4(\theta,\mu,\rho,q) := -\int_0^\infty \frac{e^{-(q+c+\alpha_\theta)x}}{\alpha_\theta(-\rho+\mu+c-\alpha_\theta)} \, dx \left(\widehat{\nu^+}(\rho+\alpha_\theta-c)-\widehat{\nu^+}(\mu)\right)$$
$$= \frac{\widehat{\nu^+}(\mu)-\widehat{\nu^+}(\rho+\alpha_\theta-c)}{\alpha_\theta(q+c+\alpha_\theta)(-\rho+\mu+c-\alpha_\theta)},$$
(3.39)

and $\widehat{\nu^+}$ denotes the Laplace transform of $\nu_{|_{]0,\infty]}}$:

$$\widehat{\nu^{+}}(q) := \widehat{\nu}_{|_{[0,\infty]}}(q) = \int_{0}^{\infty} e^{-qy} \nu(dy), \quad q \in] - r_{\nu}, \infty[.$$

$$\widehat{F_{1}}(\theta,\mu,\rho,q) = -\frac{\widehat{\nu^{+}}(q+\rho)}{\alpha_{\theta}(q+c+\alpha_{\theta})(q+\rho-\mu)} + \frac{\widehat{\nu^{+}}(q+\rho)}{\alpha_{\theta}(q+c-\alpha_{\theta})(q+\rho-\mu)} + \frac{2\,\widehat{\nu^{+}}(\rho+\alpha_{\theta}-c)}{(\mu+c-\alpha_{\theta}-\rho)(q+c-\alpha_{\theta})(q+c+\alpha_{\theta})} - \frac{2\,\widehat{\nu^{+}}(\mu)}{(\mu+c-\alpha_{\theta}-\rho)(q+\rho-\mu)(q+c+\alpha_{\theta})}.$$
(3.41)

Let us introduce :

$$= \frac{1}{\alpha_{\theta}} e^{-(c+\alpha_{\theta})x} \,\widehat{\nu}(\alpha_{\theta}-c) \,\widehat{F}(\theta,\mu,\rho,\alpha_{\theta}-c) \,.$$

and $\widehat{\nu}$ stands for the Laplace transform of ν :

$$\begin{split} \widehat{H_1F}(\theta,\mu,\rho,.)(q) &= \frac{1}{\alpha_{\theta}} \int_{-\infty}^{\infty} e^{cy} \nu(dy) \int_0^{\infty} e^{cb} F(\theta,\mu,\rho,b) db \int_0^{\infty} e^{-(q+c)x} e^{-\alpha_{\theta}|x-y-b|} dx \\ &= \frac{1}{\alpha_{\theta}} \int_{-\infty}^0 e^{cy} \nu(dy) \int_0^{-y} e^{cb} F(\theta,\mu,\rho,b) db \int_0^{\infty} e^{-(q+c)x} e^{-\alpha_{\theta}(x-y-b)} dx \\ &+ \frac{1}{\alpha_{\theta}} \int_{-\infty}^{\infty} e^{cy} \nu(dy) \int_{0\vee(-y)}^{\infty} e^{cb} F(\theta,\mu,\rho,b) db \int_0^{b+y} e^{-(q+c)x} e^{\alpha_{\theta}(x-y-b)} dx \\ &+ \frac{1}{\alpha_{\theta}} \int_{-\infty}^{\infty} e^{cy} \nu(dy) \int_{0\vee(-y)}^{\infty} e^{cb} F(\theta,\mu,\rho,b) db \int_{b+y}^{\infty} e^{-(q+c)x} e^{-\alpha_{\theta}(x-y-b)} dx . \end{split}$$

The x-integrals can be computed :

$$\begin{split} \widehat{H_1F}(\theta,\mu,\rho,.)(q) &= \frac{1}{\alpha_{\theta}} \int_{-\infty}^{0} e^{(c+\alpha_{\theta})y} \nu(dy) \int_{0}^{-y} e^{(c+\alpha_{\theta})b} F(\theta,\mu,\rho,b) db \; \frac{1}{q+c+\alpha_{\theta}} \\ &+ \frac{1}{\alpha_{\theta}} \int_{-\infty}^{\infty} e^{(c-\alpha_{\theta})y} \nu(dy) \int_{0\vee(-y)}^{\infty} e^{(c-\alpha_{\theta})b} F(\theta,\mu,\rho,b) \; \frac{1-e^{-(q+c-\alpha_{\theta})(b+y)}}{q+c-\alpha_{\theta}} db \\ &+ \frac{1}{\alpha_{\theta}} \int_{-\infty}^{\infty} e^{(c+\alpha_{\theta})y} \nu(dy) \int_{0\vee(-y)}^{\infty} e^{(c+\alpha_{\theta})b} F(\theta,\mu,\rho,b) \; \frac{e^{-(q+c+\alpha_{\theta})(b+y)}}{q+c+\alpha_{\theta}} db \, . \end{split}$$

By using (2.16) we may obtain :

$$\begin{split} \widehat{H_1F}(\theta,\mu,\rho,.)(q) &= \frac{1}{\alpha_{\theta}(q+c+\alpha_{\theta})} \left[RF(\theta,\mu,\rho,.)(-\alpha_{\theta}-c) + \int_{-\infty}^{0} \nu(dy) \int_{0}^{-y} F(\theta,\mu,\rho,b) db \right] \\ &+ \frac{1}{\alpha_{\theta}(q+c-\alpha_{\theta})} \int_{-\infty}^{\infty} e^{(c-\alpha_{\theta})y} \nu(dy) \int_{0\vee(-y)}^{\infty} e^{(c-\alpha_{\theta})b} F(\theta,\mu,\rho,b) db \\ &- \frac{1}{\alpha_{\theta}(q+c-\alpha_{\theta})} \int_{-\infty}^{\infty} e^{-qy} \nu(dy) \int_{0\vee(-y)}^{\infty} e^{-qb} F(\theta,\mu,\rho,b) db \\ &+ \frac{1}{\alpha_{\theta}(q+c+\alpha_{\theta})} \int_{-\infty}^{\infty} e^{-qy} \nu(dy) \int_{0\vee(-y)}^{\infty} e^{-qb} F(\theta,\mu,\rho,b) db . \end{split}$$

Since

Let us recall that (*H*) implies the existence of $\gamma_0^*(\theta) \ge 0$ such that $\varphi(\gamma_0^*(\theta)) = \theta$ (cf (1.23) and (1.24)). Therefore taking $q = \gamma_0^*(\theta)$ in (3.52) brings to :

First we determine $\widehat{F}_0(\theta, \mu, \rho, \gamma_0^*(\theta))$ resp. $\widehat{F}_1(\theta, \mu, \rho, \gamma_0^*(\theta))$ by using (3.34) resp. (3.43). Then relations (3.53) and (3.52) imply directly (2.17).

Step 2 Let ν_n be the finite measure on \mathbb{R} :

Let F_n be the Laplace transform of (T_x^n, K_x^n) :

Since $\lim_{n \to \infty} T_x^n = T_x$ and $\lim_{n \to \infty} K_x^n = K_x$, we can therefore infer that (2.17) will result from a limit procedure.

3.4 Proof of Theorem 2.8

Let us recall that $F(\theta, \mu, \rho, .)$ resp. $\widehat{F}(\theta, \mu, \rho, .)$ have been defined by (2.9) resp. (0.6). In the sequel, $B \in]0, B_{\nu}[$ is supposed to be as close as possible to B_{ν} .

Step 1 : We replace $F(\theta, \mu, \rho, .)$ by $\widetilde{F}(\theta, \mu, \rho, .)$; an equation associated with $\widetilde{F}(\theta, \mu, \rho, .)$

We extend continuously $F(\theta, \mu, \rho, .)$ to the whole line as follows :

The advantage of using $\widetilde{F}(\theta, \mu, \rho, .)$ instead of $F(\theta, \mu, \rho, .)$ lies in the fact that we shall prove below in Lemma 3.5, that $t \to \widetilde{\widetilde{F}}(\theta, \mu, \rho, q_1 + it)$ is an integrable function on \mathbb{R} , for any q_1 in $]0, \beta_{\theta}[(\beta_{\theta} \text{ being defined in Proposition 2.7}).$

 $+ RF(\theta,\mu,\rho,.)(q) - RF(\theta,\mu,\rho,.)(\gamma_0^*(\theta)) \right)$ (3.58)

We may observe that

(3.61)

It is clear that (1.11) implies that $RF(\theta, \mu, \rho, .)$ (defined by (2.16)) is an entire function on \mathbb{C} and all the integrals in (3.61) are holomorphic at least in $D_{-B_{\nu}}$. Therefore, the right hand-side of (3.61) is the meromorphic extension of $\widehat{\widetilde{F}}(\theta, \mu, \rho, .)$ to $D_{-B_{\nu}}$. Before ending step 1, we may remark that if $\theta > 0$ or $\theta = 0$ and $\mathbb{E}(X_1) \neq 0$, $\widehat{\widetilde{F}}(\theta, \mu, \rho, .)$ and $\widehat{F}(\theta, \mu, \rho, .)$ are holomorphic in a neighborhood of $q = \gamma_0^*(\theta)$. Although $\gamma_0^*(\theta)$ is a zero of φ_{θ} , this value is a false singularity for $\widehat{\widetilde{F}}(\theta, \mu, \rho, .)$. But if $\theta = 0$ and $\mathbb{E}(X_1) = 0$, then $\gamma_0^*(0) = 0$ is a pole for $\widehat{\widetilde{F}}(0, \mu, \rho, .)$.

Step 2 : $t \to \widehat{\widetilde{F}}(\theta, \mu, \rho, q_1 + it)$ belongs to $\mathbb{L}^1(\mathbb{R})$

We may consider θ as a fixed element in $[0, \kappa]$ and $\beta_{\theta} > 0$ as being given by Proposition 2.7. In addition, let $q_1 \in]0, \beta_{\theta}[$.

Lemma 3.5 Under (H) and (2.23), the function $t \to \widehat{\widetilde{F}}(\theta, \mu, \rho, q_1 + it)$ belongs to $\mathbb{L}^1(\mathbb{R})$.

So that to prove Lemma 3.5, we may begin with enumerating a few technical inequalities. These relations will be also used in the sequel. **Lemma 3.6** Let $\theta_1 < \theta_2$. Let us suppose (2.23). Then :

Proof of Lemma 3.6

The proof of Lemma 3.6 may be directly inferred from (2.23).

Proof of Lemma 3.5

Proposition 2.7 tells us that φ_{θ} has no zero in the strip $\{q \in \mathbb{C} : 0 < \operatorname{Re} q < \beta_{\theta}\}$. So, if $q_1 \in]0, \beta_{\theta}[, \varphi(q_1+it)-\theta$ never cancels and (3.61) implies that $t \to \widehat{\widetilde{F}}(\theta, \mu, \rho, q_1 + it)$ is a continuous function. Let us focus on (3.61). Lemma 3.6 implies that all the numerators in (3.61) are bounded on the line $\{q_1+it : t \in \mathbb{R}\}$, and the denominators are smaller than $C|q^2|$ for some C > 0 and |q| large. This proves $t \to \widehat{\widetilde{F}}(\theta, \mu, \rho, q_1 + it)$ belongs to $\mathbb{L}^1(\mathbb{R})$.

Step 3 : Proof of the asymptotic development (2.25), through the Mellin Fourier inverse transform

Proposition 2.7 provides the existence of $\kappa > 0$ and B so that for any $\theta \in [0, \kappa]$, φ_{θ} does not cancel on $\{-B + it ; t \in \mathbb{R}\}$ and $B \neq \gamma_0^*(\theta)$. Let $0 < q_1 < \beta_{\theta}$. Since $t \to \widehat{\widetilde{F}}(\theta, \mu, \rho, q_1 + it)$ belongs to $\mathbb{L}^1(\mathbb{R})$ (cf. Lemma 3.5), we may use the Mellin Fourier inverse transform (see for instance [19], pages 232-239). So, for any $x \ge 0$:

In Proposition 2.7, it has been proved that there is $R_1 > R_0$, so that φ_{θ} has no zero in the two half-strips $\{q \in \mathbb{C} : -B \leq \operatorname{Re} q < \beta_{\theta} \text{ and } |\operatorname{Im} q| > R_1\}$. In particular $\widehat{\widetilde{F}}(\theta, \mu, \rho, .)$ is holomorphic in this domain.

Let $\Gamma_{-B,q_1,R}$ be the rectangular path (see Figure 3) :

We observe that $\overline{C_i}(\theta, \mu, \rho, x) = e^{\overline{\gamma_i}(\theta)x} \operatorname{Res}\left(e^{zx}\widehat{F}(\theta, \mu, \rho, z); -\overline{\gamma_i}(\theta)\right)$. We will prove below in Section 4.5, that $x \to C_i(\theta, \mu, \rho, x)$ is a polynomial function (see the formula

(4.30)). Since $z \to e^{zx} \widehat{\widetilde{F}}(\theta, \mu, \rho, z)$ belongs to $\mathbb{L}^1(\mathbb{R})$, we come to (cf. (3.69)) :

We claim that in the right hand-side of (3.82), the limits of the second term and the fourth one are null. As for the third limit, we have :

$$\lim_{R \to \infty} \int_{\Gamma_{-B,R}} e^{zx} \widehat{\widetilde{F}}(\theta, \mu, \rho, z) dz = \mathcal{O}(e^{-Bx}), \qquad (3.83)$$

where O is uniform with respect to $\theta \in [0, \kappa]$, $\mu \in \mathbb{R}_+$ and $\rho \in \mathbb{R}_+$. Hence, as $x \to \infty$:

$$F(\theta,\mu,\rho,x) = C_0(\theta,\mu,\rho)e^{-\gamma_0(\theta)} + \sum_{i=1}^p a_i \Big[C_i(\theta,\mu,\rho,x)e^{-\gamma_i(\theta)x} + \overline{C_i}(\theta,\mu,\rho,x)e^{-\overline{\gamma_i}(\theta)x} \Big] + \mathcal{O}(e^{-Bx})$$

$$(3.84)$$

Remark 3.7 Let us determine the sign of $C_0(\theta, \mu, \rho)$. The asymptotic expansion (2.25) implies that :

$$\lim_{x \to \infty} e^{\gamma_0(\theta)x} F(\theta, \mu, \rho, x) = C_0(\theta, \mu, \rho) \ge 0.$$
(3.85)

The residual $C_0(\theta, \mu, \rho)$ at $-\gamma_0(\theta)$ of $F(\theta, \mu, \rho, .)$ cannot cancel because $-\gamma_0(\theta)$ is a single pole of $\widehat{F}(\theta, \mu, \rho, .)$ when $\theta > 0$ or $\theta = 0$ and $\mathbb{E}(X_1) \neq 0$.

If $\theta = 0$ and $c = \mathbb{E}(J_1)$, it is easy to see that $C_0(0, \mu, \rho) \neq 0$ (cf. item c) iii) in subsection 4.5 below).

We will give in subsection 4.5 some complements related to the calculation of the coefficients $C_i(\theta, \mu, \rho, x)$.

3.5 Proof of Theorem 2.10

Let us recall that the ruin probability is the function :

$$F(x) := F(0, 0, 0, x) = \mathbb{P}(T_x < \infty), \qquad (3.86)$$

Let us denote \widehat{F} the Laplace transform of F:

$$\widehat{F}(q) := \int_0^\infty e^{-qx} F(x) dx \qquad \forall q \in \mathbb{C} , \text{ Re}(q) > 0.$$
(3.87)

In this section, it is only assumed that the Lévy measure ν satisfies (2.30) and (2.31). The proof will be divided into five parts.

Step 1 We will prove that we only need to consider a Lévy measure ν whose support is included in $[-k, \infty[$, for some (finite) $k \ge 0$.

The assumption (2.30) implies that there is k > 0 such that

$$\int_{-k}^{\infty} \mathbb{1}_{\{|y| \ge 1\}} y \nu(dy) < c.$$
(3.88)

Let $(X_t^k, t \ge 0)$ be a Lévy process with decomposition :

$$X_t^k := B_t - c_0 t + J_t^k \qquad \forall t \ge 0,$$
(3.89)

where $(J_t^k, t \ge 0)$ is a pure jump process independent from $(B_t, t \ge 0)$ and with Lévy measure : $\nu_k := \nu_{|[-k,\infty[}$. In addition, it can be supposed that the processes $(J_t^k, t\ge 0)$ and $(J_t, t\ge 0)$ are defined on the same probability space. Since $\nu - \nu_k$ is a non-negative measure whose support is included in $] - \infty, -k]$, then $J_t \le J_t^k$, $\forall t\ge 0$. Consequently $X_t \le X_t^k$, $\forall t\ge 0$ a.s., and $T_x^k \le T_x$, $\forall x\ge 0$ where

$$T_x^k := \inf \left\{ t \ge 0 \ / \ X_t^k > x \right\}.$$
(3.90)

As a result,

$$\forall x \ge 0 \qquad F(x) \le F^k(x) := \mathbb{P}(T_x^k < \infty). \tag{3.91}$$

Note that the relation (3.88) implies that ν_k satisfies (2.30) and (2.31). This proves the claim.

Step 2 The aim is to prove that we can suppose that the support of ν is included in $[-k, -1] \cup [0, \infty[$.

It is clear that the relation (2.30) implies that there is $\varepsilon > 0$ so that

$$-c + \varepsilon + \int_{[-k,\infty[} y \mathbb{1}_{\{|y| \ge 1\}} \nu(dy) < 0.$$
(3.92)

Let $\nu^{(1)}$ be the Lévy measure : $\nu^{(1)}(dy) := \mathbb{1}_{]-1,0[}(y)\nu(dy)$. Consider $X^{(1)}$ the Lévy process whose function $\varphi^{(1)}$ is defined as follows :

$$\varphi^{(1)}(q) := \varepsilon q + \int_{\mathbb{R}} \left(e^{-qy} - 1 + qy \mathbb{1}_{\{|y| < 1\}} \right) \nu^{(1)}(dy) = \varepsilon q + \int_{]-1,0[} \left(e^{-qy} - 1 + qy \right) \nu(dy).$$

Consequently $\mathbb{E}(X_1^{(1)}) = -\varepsilon < 0$. Since $\varphi^{(1)}(q) \ge -q\varepsilon$ for any $q \in]-\infty, 0]$, then $\lim_{q \to -\infty} \varphi^{(1)}(q) = \infty$. Note that the graph of $\varphi^{(1)}$ corresponds to the Figure 1, case a). As a result, there exist $\gamma^{(1)} > 0$ such that $\varphi^{(1)}(-\gamma^{(1)}) = 0$. According to [2] there exists $C^{(1)} > 0$ such that

$$\mathbb{P}(T_x^{(1)} < \infty) \le C^{(1)} e^{-\gamma^{(1)} x}, \quad x \ge 0$$
(3.93)

where $T_x^{(1)} := \inf\{t \ge 0, X_t^{(1)} > x\}$. Next let $\nu^{(2)}(dy) := \mathbb{1}_{[-k,-1]\cup]0,\infty[}(y)\nu(dy)$, and $X^{(2)}$ the Lévy process associated with

$$\varphi^{(2)}(q) := \frac{q^2}{2} + (c - \varepsilon)q + \int_{\mathbb{R}} \left(e^{-qy} - 1 + qy \mathbb{1}_{\{|y| \ge 1\}} \right) \nu^{(2)}(dy).$$

Consequently :

$$\mathbb{E}(X_1^{(2)}) = -(c-\varepsilon) + \int_{\mathbb{R}} y \mathbb{1}_{\{|y| \ge 1\}} \nu^{(2)}(dy) = -c + \varepsilon + \int_{\mathbb{R}} y \mathbb{1}_{\{|y| \ge 1\}} \nu(dy) < 0.$$

In addition suppose that $X^{(1)}$ and $X^{(2)}$ are independent. Since $\varphi = \varphi^{(1)} + \varphi^{(2)}$, therefore X is distributed as $X^{(1)} + X^{(2)}$. Let us note that :

$$\left\{T_{x/3}^{(1)} = \infty\right\} \cap \left\{T_{x/3}^{(2)} = \infty\right\} \subset \left\{X_t^{(1)} + X_t^{(2)} < x\right\}, \quad x > 0$$

Applying moreover (3.93) we get :

$$\mathbb{P}(T_x < \infty) \le \mathbb{P}(T_{x/3}^{(1)} < \infty) + \mathbb{P}(T_{x/3}^{(2)} < \infty) \le C^{(1)}e^{-\gamma^{(1)}x/3} + \mathbb{P}(T_{x/3}^{(2)} < \infty).$$

This inequality implies that the rate of decay of $x \mapsto \mathbb{P}(T_x < \infty)$ is polynomial as soon as $x \mapsto \mathbb{P}(T_x^{(2)} < \infty)$ enjoys the same asymptotic behavior.

In the sequel we can suppose that (2.30) and (2.31) hold and the support of ν is included in $[-k, -1] \cup [0, \infty]$, for some k > 0.

Step 3 F belongs to $\mathbb{L}^1(\mathbb{R}_+)$.

We will first prove that :

$$\sup_{0 < q \le q_0} |\widehat{F}(q)| < \infty , \quad \text{for some } q_0 > 0 .$$
 (3.94)

By taking the limit $\theta, \mu, \rho \to 0$ in (2.17), we may easily obtain :

$$\widehat{F}(q) = \frac{1}{\varphi(q)} \left(\frac{q}{2} + \frac{1}{q} \int_0^\infty (e^{-qy} - 1 + qy)\nu(dy) + RF(q) \right) \,. \tag{3.95}$$

Let us determine the asymptotic behavior of the numerator and the denominator as $q \rightarrow 0$. Let us begin with the denominator :

$$\varphi(q) \sim q\varphi'(0) = q\left(c - \int_{\mathbb{R}} \mathbb{1}_{\{|y| \ge 1\}} y\nu(dy)\right) \quad \text{as } q \to 0.$$
(3.96)

Next, we consider the numerator. We have :

$$\frac{q}{2} + \frac{1}{q} \int_0^\infty (e^{-qy} - 1 + qy)\nu(dy) \sim \frac{q}{2} \left[1 + \int_0^\infty y^2 \nu(dy) \right] \quad \text{as } q \to 0.$$
(3.97)

Since the support of ν is included in $[-k, -1] \cup [0, \infty[$, then RF(q) can be simplified :

$$RF(q) = \int_{-k}^{-1} \nu(dy) \int_{0}^{-y} \left(e^{-q(b+y)} - 1 \right) F(b) db.$$
(3.98)

But RF(0) = 0 and the derivative of RF(q) is bounded, then $|RF(q)| \le Cq$, for any $0 \le q \le q_0$. (3.94) follows immediately.

It is now easy to check that F is in $\mathbb{L}^1(\mathbb{R}_+)$. The function F is non-negative, then the monotone convergence theorem implies :

$$\int_{0}^{\infty} F(x)dx = \lim_{q \to 0} \int_{0}^{\infty} e^{-qx} F(x)dx \le \sup_{0 < q \le q_0} \widehat{F}(q) < \infty.$$
(3.99)

As a result F is integrable.

Step 4 Definition of \widetilde{F} .

The function F can be extended to the whole line, setting F(x) = 0, for any $x \le 0$. However F may have a jump at 0. Let \tilde{F} be the following continuous extension of F:

$$\widetilde{F}(x) := F(x) \mathbb{1}_{[0;\infty[}(x) + (1+x) \mathbb{1}_{[-1;0]}(x), \qquad \forall x \in \mathbb{R}.$$
(3.100)

Let $q \to \widehat{\widetilde{F}}(iq)$ be the Fourier transform of \widetilde{F} :

$$\widehat{\widetilde{F}}(iq) = \int_{-\infty}^{\infty} e^{-iqx} \widetilde{F}(x) dx = \int_{-1}^{\infty} e^{-iqx} \widetilde{F}(x) dx \qquad \forall q \in \mathbb{R}.$$
(3.101)

Step 5 $q \to \widehat{\widetilde{F}}(iq)$ is in $\mathbb{L}^1(\mathbb{R})$.

Since $F \in L^1(\mathbb{R}_+)$, then $\widetilde{F} \in L^1(\mathbb{R})$ and $q \mapsto \widehat{\widetilde{F}}(iq)$ is continuous. So, if we establish :

$$\left|\widehat{\widetilde{F}}(iq)\right| \le \frac{C}{1+q^2},\tag{3.102}$$

then $\widehat{\widetilde{F}}$ will be an element of $\mathbb{L}^1(\mathbb{R})$. It is proved in Proposition 2.7, that $\varphi(iq) = 0, q \in \mathbb{R}$ iff q = 0. Therefore we are allowed to replace q by iq in (3.95). By using the identity :

$$\int_{-1}^{0} (1+x)e^{-iqx}dx = -\frac{e^{iq} - 1 - iq}{q^2}, \qquad (3.103)$$

and (3.94) we may deduce :

- 1. (3.102) holds for any $|q| \le q_0$ (for some $q_0 > 0$),
- 2. $\widehat{\widetilde{F}}(iq)$ may be written as follows :

$$\widehat{\widetilde{F}}(iq) = \frac{1 - e^{iq}}{q^2} + \frac{1}{\varphi(iq)} \left[-c - \int_1^\infty y\nu(dy) + \frac{i}{q} \int_{-k}^{-1} \left(e^{-iqy} - 1 \right) \nu(dy) + RF(iq) \right]$$
(3.104)

The inequality (3.102) will be a direct consequence of following estimates :

$$\varphi(iq) \sim -\frac{q^2}{2} \Big(\int_{\mathbb{R}} y^2 \mathbb{1}_{\{|y|<1\}} \nu(dy) \Big) \quad (|q| \to \infty)$$
(3.105)

$$\left| \int_{-k}^{0} (e^{-iqy} - 1)\nu(dy) \right| \le |q| \, k \, \nu \left([-k, -1] \right), \tag{3.106}$$

$$|RF(iq)| \le 2 k \nu ([-k, -1]).$$
(3.107)

Step 6 The *n* first derivatives of $\widehat{\widetilde{F}}$ belong to $\mathbb{L}^1(\mathbb{R})$.

Obviously any k derivative of $q \to \frac{1-e^{iq}}{q^2}$ is continuous, bounded by $\frac{C}{q^2}$, $|q| \ge 1$, and therefore belongs to $\mathbb{L}^1(\mathbb{R})$.

The second term in the right hand-side of (3.104) may be written this way : $\frac{N(q)}{\varphi(iq)}$. By proceeding likewise Step 5 and using (2.31) it can be proved that the *n* first derivatives of *N* are bounded. As a result $\left|\frac{N(q)}{\varphi(iq)}\right| \leq \frac{C}{q^2}$, $|q| \geq 1$.

As for the asymptotic behavior of $\frac{N(q)}{\varphi(iq)}$ in a neighborhood of 0, it can be proved through a similar reasoning that this ratio is bounded, for any $|q| \leq 1$.

Step 7 Proof of (2.32).

Since the *n* derivatives of $q \to \widehat{\widetilde{F}}(iq)$ belong to $\mathbb{L}^1(\mathbb{R})$, then

$$x^{n}\widetilde{F}(x) = \frac{i^{n}}{2\pi} \int_{\mathbb{R}} e^{iqx} \frac{d^{n}}{dq^{n}} \left(\widehat{\widetilde{F}}(iq)\right) dq.$$
(3.108)

This identity directly implies (2.32).

4 Appendix

4.1 Rate of convergence in Theorem 2.1

We would like to point out that the asymptotic development of $F(\theta, \mu, \rho, x)$ which is given by (2.25) provides the rate of convergence of $\left(\frac{1}{\sqrt{x}}\left(T_x + \frac{x}{\varphi'(-\gamma_0(0))}\right)\right)$ to the Gaussian distribution. Let us suppose that $\mathbb{E}[X_1] > 0$. Let A_x be the distribution function of $\left(\frac{1}{\sqrt{x}}\left(T_x + \frac{x}{\varphi'(-\gamma_0(0))}\right)\right)$ and let \widehat{A}_x be its characteristic function : $A_x(t) = \mathbb{P}\left(\frac{1}{\sqrt{x}}\left(T_x + \frac{x}{\varphi'(-\gamma_0(0))}\right) \le t\right), \quad t \in \mathbb{R}$ $\widehat{A}_x(\theta) = \mathbb{E}\left[e^{\frac{i\theta}{\sqrt{x}}\left(T_x + \frac{x}{\varphi'(-\gamma_0(0))}\right)}\right] \qquad \theta \in \mathbb{P}$

$$A_x(\theta) = \mathbb{E}\left[e^{\sqrt{x}}, \cdots, e^{(-\gamma_0(0))^{\gamma}}\right], \qquad \theta \in \mathbb{R}.$$

Thanks to (2.25), it is not difficult to check that, if x is large enough we obtain :

$$\sup_{\theta>0} |\widehat{A}_x(\theta) - \widehat{A}(\theta)| \le \frac{k\theta}{\sqrt{x}}.$$
(4.1)

Here k is a positive constant and \widehat{A} is the characteristic function of $\mathcal{N}\left(0; -\frac{\varphi''(-\gamma_0(0))}{\varphi'^3(-\gamma_0(0))}\right)$. Berry-Essen's inequalities (see for instance [15], p 285) imply the existence of two positives constants k_1 and k_2 such that :

$$\sup_{t \in \mathbb{R}} |A_x(t) - A(t)| \le k_1 \int_0^a \frac{k\theta}{\sqrt{x}} \frac{d\theta}{\theta} + \frac{k_2}{a}, \quad \text{for any} \ a > 0,$$
(4.2)

where A is the distribution function of the previous Gaussian distribution. Choosing $a = x^{1/4}$, we get :

$$\sup_{t \in \mathbb{R}} |A_x(t) - A(t)| \le \frac{k_3}{x^{1/4}}, \ x \ge 1,$$
(4.3)

for some $k_3 > 0$.

4.2 Stochastic interpretation of w^- and w^+

We would like to give a stochastic interpretation of the probability measure w^- defined by (2.2). Let (K, L) be a two-dimensional r.v. with probability distribution w^- . Obviously the event $\{K = 0\} (= \{L = 0\} \text{ a.s.})$ occurs with probability $\frac{-\gamma_0(0)}{2\mathbb{E}(X_1)}$. Conditionally on $\{L > 0\}$, the distribution of (K, L) is of type $\alpha \left(e^{\gamma_0(0)l} - 1\right) \mathbb{1}_{\{k>0; l>0\}} \nu_l(dk) dl$ where ν_l is the positive measure defined in Theorem 2.1.

This leads us to consider the positive measure :

$$w^{(\gamma)}(dk, dl) = \alpha (e^{\gamma l} - 1) \mathbb{1}_{\{k > 0; l > 0\}} \nu_l(dk) dl , \qquad (4.4)$$

in which $\gamma > 0$, ν_l is the image of ν by $y \to y - l$. In addition, ν is a positive measure on $]0; \infty[$ which satisfies :

$$\int_0^\infty (e^{\gamma k} - 1 - \gamma k)\nu(dk) < \infty, \qquad (4.5)$$

here α is the normalization factor : $\alpha = \frac{\gamma}{\int_0^\infty (e^{\gamma k} - 1 - \gamma k)\nu(dk)}$.

Proposition 4.1 Let (K^*, L^*) be a two dimensional r.v. with distribution $w^{(\gamma)}$ defined by (4.4). Then L^* has a density function given by $\alpha(e^{\gamma l} - 1)\nu([l, \infty[)\mathbb{1}_{\{l>0\}})$. Conditionally on $L^* = l$, the distribution of $S^* = L^* + K^*$ is $\frac{1}{\nu([l, \infty[)}\mathbb{1}_{\{s>l\}}\nu(ds))$.

It is obvious that choosing $\gamma = \gamma_0(0)$ (resp. $\gamma = \gamma_0^*(0)$) allows to recover the probability measure w^- (resp. w^+) introduced in (2.2) (resp. (2.5)). Consequently, Proposition 4.1 gives a stochastic interpretation of the limit law of (K_x, L_x) as $x \to \infty$, in the case where $\nu(] - \infty; 0[) = 0$.

4.3 Study of Λ_{θ}

To investigate uniqueness in (2.10), we will prove that Λ_{θ} is a contraction on the Banach space :

$$\mathcal{B}_{\gamma} := \{ f : \mathbb{R}_+ \to \mathbb{R} \, ; \, \sup_{x \in \mathbb{R}_+} e^{\gamma \, x} |f(x)| < \infty \} \quad \gamma \ge 0 \, . \tag{4.6}$$

 \mathcal{B}_{γ} is equipped with the norm :

$$||f||_{\gamma} := \sup_{x \in \mathbb{R}_+} e^{\gamma x} |f(x)|.$$
(4.7)

Theorem 4.2 Let us suppose that $\nu(\mathbb{R}) < \infty$.

- (i) For any $\theta \ge 0$, the operator Λ_{θ} defined by (2.14) is a linear and non-negative operator, whose norm is equal to $\frac{\lambda}{\lambda + \theta}$ in $L^{\infty}(\mathbb{R}_+)$.
- (ii) Let $\gamma \in [0, r_{\nu}[\text{ and } \theta > 0 \text{ or } \theta = 0 \text{ and } \mathbb{E}(X_1) < 0$ (recall that r_{ν} has been defined by (1.13)). Then :
 - a) Λ_{θ} is a bounded operator from \mathcal{B}_{γ} to \mathcal{B}_{γ} . More precisely :

$$\|\Lambda_{\theta}f\|_{\gamma} \le c_{\theta,\gamma} \|f\|_{\gamma} \quad \forall f \in \mathcal{B}_{\gamma},$$
(4.8)

with

$$c_{\theta,\gamma} = \frac{\widehat{\nu}(-\gamma)}{\widehat{\nu}(-\gamma) - \varphi(-\gamma) + \theta},\tag{4.9}$$

and $\hat{\nu}$ the Laplace transform of ν (cf (3.47)).

b) There exists $\gamma \in]0, r_{\nu}[$ such that $\varphi(-\gamma) < \theta$. Therefore Λ_{θ} is a \mathcal{B}_{γ} -contraction since :

$$0 < c_{\theta,\gamma} < 1. \tag{4.10}$$

Proof of Theorem 4.2

(i) Relation (3.31) implies that Λ_{θ} is a non-negative operator. It is easy to check that the function ℓ :

$$\ell(x) := \mathbb{1}_{\{a+y \le x; a \le x\}} e^{-c_0 a} \left(e^{-\alpha_\theta |a|} - e^{-(2x-a)\alpha_\theta} \right)$$
(4.11)

is increasing, then :

$$\ell(x) < \ell(\infty) = e^{-c_0 a} e^{-\alpha_\theta |a|} \qquad \forall x \in \mathbb{R}.$$
(4.12)

A straightforward calculation shows that $|\Lambda_{\theta}h(x)| \leq \frac{\lambda}{\lambda+\theta} ||h||_{\infty}$, for any $x \geq 0$. If we take $h: x \to 1$, we have $||\Lambda_{\theta}h||_{\infty} = \frac{\lambda}{\lambda+\theta}$. Therefore, $|||\Lambda_{\theta}||_{L^{\infty}(\mathbb{R}_{+})} = \frac{\lambda}{\lambda+\theta}$. (*ii*) Let f be an element of \mathcal{B}_{γ} , then $||f(x)| \leq ||f||_{\gamma} e^{-\gamma x}$, $\forall x \geq 0$. It follows that :

$$|\Lambda_{\theta}f(x)| \leq \frac{1}{\alpha_{\theta}} \|f\|_{\gamma} e^{-\gamma x} \int_{-\infty}^{\infty} \nu(dy) \int_{-\infty}^{(x-y)\wedge x} e^{-c_0 a} \left(e^{-\alpha_{\theta}|a|} - e^{-(2x-a)\alpha_{\theta}}\right) e^{\gamma(a+y)} da,$$

$$(4.13)$$

for any $\gamma \in [0, r_{\nu}[$. By using (4.12), we get :

$$|\Lambda_{\theta}f(x)| \leq \frac{1}{\alpha_{\theta}} \|f\|_{\gamma} e^{-\gamma x} \int_{-\infty}^{\infty} \nu(dy) e^{\gamma y} \left[\int_{-\infty}^{0} e^{-(c_0 - \alpha_{\theta} - \gamma)a} da + \int_{0}^{\infty} e^{-(c_0 + \alpha_{\theta} - \gamma)a} da \right]$$

Computing the integral with respect to da, leads directly to (4.8).

Proposition 4.3 Let us assume $\nu(\mathbb{R}) < \infty$, $r_{\nu} > 0$, $\mu \ge 0$, $\theta > 0$, or $\theta = 0$ if $\mathbb{E}(X_1) < 0$. Let γ be in $[0, r_{\nu}[$, such that $\varphi(-\gamma) < \theta$. Then the function $F(\theta, \mu, \rho, .)$ belongs to \mathcal{B}_{γ} and the equation (2.10) has a unique solution in \mathcal{B}_{γ} .

To prove Proposition 4.3, we need the following preliminary.

Lemma 4.4 Suppose either $\theta > 0$, or $\theta = 0$ if $\mathbb{E}(X_1) < 0$, then for any x > 0,

$$\lim_{n \to \infty} \Lambda^n_{\theta} F(\theta, \mu, \rho, .)(x) = 0.$$
(4.14)

Proof of Lemma 4.4

1) Suppose $\theta > 0$. Since F is bounded by 1, and the norm of Λ_{θ} is $\frac{\lambda}{\lambda + \theta}$ (cf. Theorem 4.2) : $\|\Lambda_{\theta}^{n}F(\theta,\mu,\rho,.)\|_{\infty} \leq \left(\frac{\lambda}{\lambda + \theta}\right)^{n}$. This proves (4.14).

2) Let us now turn to the case $\theta = 0$ and $\mathbb{E}(X_1) < 0$. By iterating the functional equation (2.10), we come to :

$$F(\theta, \mu, \rho, x) = \sum_{p=0}^{n-1} \Lambda^p_{\theta} \left[(F_0 + F_1)(\theta, \mu, \rho, .) \right](x) + \Lambda^n_{\theta} F(\theta, \mu, \rho, .)(x) \,. \tag{4.15}$$

The \mathcal{B}_{γ} -norm of Λ_{θ} is strictly less than 1, then the series in (4.15) converges. The remaining term $\Lambda_{\theta}^{n} F(\theta, \mu, \rho, .)(x)$ converges in \mathcal{B}_{γ} to some function $G(\theta, \mu, \rho, x)$. It is easy to check what follows :

- a) $G(0, \mu, \rho, .)$ is a bounded and non negative function,
- b) $G(0,\mu,\rho,.)$ is a continuous function on $[0,\infty[$,
- c) $\lim_{x \to \infty} G(0, \mu, \rho, x) = 0$,
- d) $\Lambda_0 G(0, \mu, \rho, .) = G(0, \mu, \rho, .).$

Using (i) in Theorem 4.2 leads to :

$$G(0,\mu,\rho,x) = \Lambda_0 G(0,\mu,\rho,.)(x) \le \|G(0,\mu,\rho,.)\|_{\infty}, \quad x \ge 0.$$
(4.16)

As (4.12) is a strict inequality then (4.16) is a strict one too if $||G(0,\mu,\rho,.)||_{\infty} \neq 0$. According to b) and c), there exists $x_0 \geq 0$ such that : $G(0,\mu,\rho,x_0) = ||G(0,\mu,\rho,.)||_{\infty}$. This implies $||G(0,\mu,\rho,.)||_{\infty} = 0$.

Proof of Proposition 4.3

Using the explicit expression of F_0 and F_1 (cf. (2.12) and (2.13)), by a straightforward calculation, enables us to infer that both $F_0(\theta, \mu, \rho, .)$ and $F_1(\theta, \mu, \rho, .)$ belong to \mathcal{B}_{γ} (for a detailed proof, cf. [20]).

Due to Lemma 4.4 and (4.15) we may obtain :

$$F(\theta, \mu, \rho, x) = \sum_{n=0}^{\infty} \Lambda_{\theta}^{n} \left(F_{0} + F_{1} \right) (\theta, \mu, \rho, .) \right) (x) , \qquad (4.17)$$

Because $F_0 + F_1 \in \mathcal{B}_{\gamma}$ and Λ_{θ} is a contraction in \mathcal{B}_{γ} , the serie converges in \mathcal{B}_{γ} , which directly implies the result.

Remark 4.5

1. Under the conditions stated in Proposition 4.3, we have actually proved that $F(\theta, \mu, \rho, x)$ can be approximated by $\sum_{n=0}^{p} \Lambda_{\theta}^{n} \left[(F_{0} + F_{1})(\theta, \mu, \rho, .) \right](x)$. More precisely :

$$\left| F(\theta, \mu, \rho, x) - \sum_{n=0}^{p} \Lambda_{\theta}^{n} \left[(F_{0} + F_{1})(\theta, \mu, \rho, .) \right](x) \right| < c_{\theta, \gamma}^{p+1} K \ e^{-\gamma x} , \qquad (4.18)$$

where $K = \left\| \sum_{n=0}^{\infty} \Lambda_{\theta}^{n} \left[(F_{0} + F_{1})(\theta, \mu, \rho, .) \right] \right\|_{\gamma} < \infty$ and $c_{\theta, \gamma}$ is defined by (4.9).

2. Let us consider the case when the support of ν is included in $] -\infty, 0]$. φ is well defined on $] -\infty, 0]$ and $r_{\nu} = \infty$. Moreover $K_x = L_x = 0$ and $F_1(\theta, \mu, \rho, x) = 0$ for any $x \ge 0$. As a result, (2.10) is reduced to :

$$F(\theta, \mu, \rho, x) = e^{-(c_+ \alpha_\theta)x} + \Lambda_\theta F(\theta, \mu, \rho, .)(x).$$
(4.19)

If either $\theta > 0$, or $\theta = 0$ and $\mathbb{E}(X_1) < 0$, from both (1.25) and (1.26) we can infer the existence of a unique real number $\gamma_0(\theta)$ such that :

$$-\gamma_0(\theta) < 0$$
 and $\varphi(-\gamma_0(\theta)) = \theta$. (4.20)

A direct (but fastidious !) calculation shows that $x \to e^{-\gamma_0(\theta)x}$ is a solution of (2.10). For more details see [20].

Hence $F(\theta, \mu, \rho, x) = F(\theta, 0, 0, x) = e^{-\gamma_0(\theta)x}$.

4.4 Few examples of ν satisfying (2.23)

We give three classes of measures ν which satisfy (H) and (2.23) :

a) Let us suppose that ν has finite exponential moments :

$$\forall q \in \mathbb{R} \qquad \int_{-\infty}^{\infty} \left| e^{-qy} - 1 + qy \mathbb{1}_{\{|y| < 1\}} \right| \nu(dy) < \infty.$$

$$(4.21)$$

In that case, $\widehat{\nu_{|_{[1,\infty[}]}}$ and φ are holomorphic functions in the whole plane \mathbb{C} , then $B_{\nu} = \infty$. Moreover, for any B > 0:

$$\sup_{\operatorname{Re} q \ge -B} \left| \int_{1}^{\infty} e^{-qy} \nu(dy) \right| \le \int_{1}^{\infty} e^{By} \nu(dy) < \infty.$$
(4.22)

Then (2.23) holds. The condition (4.21) is fulfilled if, for instance, ν has a compact support.

b) Let ν be a linear combination of gamma distributions :

$$\nu(dy) := \sum_{i=1}^{n} \rho_i e^{-\beta_i y} y^{m_i} \mathbb{1}_{\{y \ge 0\}} dy \,. \tag{4.23}$$

where $\rho_i > 0$, $\beta_i > 0$ and $m_i \in \mathbb{N}$, for any $i \in \{1, 2, \cdots, n\}$,.

Since the Laplace transform of ν is explicit, we obtain immediately its meromorphic extension to the whole plane $(B_{\nu} = \infty)$ and (2.23). Moreover :

$$\widehat{\nu}(q) = \int_0^\infty e^{-qx} \sum_{i=1}^n \rho_i e^{-\beta_i x} x^{m_i} dx = \sum_{i=1}^n \rho_i \int_0^\infty x^{m_i} e^{-(q+\beta_i)x} dx.$$
(4.24)

If we set $y = (q + \beta_i)x$, we have :

$$\widehat{\nu}(q) = \sum_{i=1}^{n} \frac{\rho_i}{(q+\beta_i)^{m_i+1}} \int_0^\infty y^{m_i} e^{-y} dy = \sum_{i=1}^{n} \frac{\rho_i m_i!}{(q+\beta_i)^{m_i+1}}.$$
(4.25)

This implies that $\hat{\nu}$ resp. φ is holomorphic in $\mathbb{C} - \{-\beta_1, \cdots, -\beta_n\}$ resp. meromorphic in \mathbb{C} .

c) The example above may be generalized as follows :

$$\nu(dy) := \phi(y) \mathbb{1}_{\{y \ge 0\}} dy \,, \tag{4.26}$$

where $\phi \ge 0$, bounded on $[0, y_0]$, and for every $y \ge y_0$:

$$\phi(y) := \rho_0 e^{-\beta_0 y} y^{m_0 - 1} + \sum_{i=1}^n (\rho_i e^{-\beta_i y} + \overline{\rho_i} e^{-\overline{\beta_i} y}) y^{m_i - 1} + \mathcal{O}(e^{-\beta_{n+1} y}), \quad (4.27)$$

with $y_0 \ge 0, \rho_0 \ge 0, \beta_0 > 0$, Re $\beta_i > 0, \rho_i \in \mathbb{C}^*, m_i \in \mathbb{N}^*$ et $\beta_{n+1} \ge \sup_{1 \le i \le n}$ Re β_i . Then $\hat{\nu}$ and φ are meromorphic functions in $\{q ; \text{Re } q \ge \beta_{n+1}\}, B_{\nu} = \beta_{n+1}$ and (2.23) holds.

d) If ν_1 and ν_2 satisfy (2.23), then $\nu = \nu_1 + \nu_2$ satisfies (2.23) too.

4.5 Calculation of the C_i coefficients

Let us suppose in this section that (H) holds.

a) We claim that $C_i(\theta, \mu, \rho, .)$ is a polynomial function. We may assume that $-\gamma_i(\theta)$ is a zero of φ_{θ} with multiplicity n_i , and $\widehat{F}(\theta, \mu, \rho, z)$ has the following asymptotic expansion in a neighborhood of $-\gamma_i(\theta)$:

$$\widehat{F}(\theta,\mu,\rho,z) = \frac{K_{i,n_i}(\theta,\mu,\rho)}{(z+\gamma_i(\theta))^{n_i}} + \frac{K_{i,n_i-1}(\theta,\mu,\rho)}{(z+\gamma_i(\theta))^{n_i-1}} + \dots + \frac{K_{i,1}(\theta,\mu,\rho)}{z+\gamma_i(\theta)} + \dots$$
(4.28)

Since

$$e^{zx} = e^{-\gamma_i(\theta)x} \left(1 + (z + \gamma_i(\theta))x + \frac{(z + \gamma_i(\theta))^2}{2!}x^2 + \cdots \right)$$
(4.29)

then relations (3.80) and (3.81) imply that :

$$C_{i}(\theta,\mu,\rho,x) = \frac{K_{i,n_{i}}(\theta,\mu,\rho)}{(n_{i}-1)!} x^{n_{i}-1} + \frac{K_{i,n_{i}-1}(\theta,\mu,\rho)}{(n_{i}-2)!} x^{n_{i}-2} + \dots + K_{i,1}(\theta,\mu,\rho).$$
(4.30)

b) We suppose in this item that $-\gamma_i(\theta)$ is a single zero of $\varphi_{\theta} = \varphi - \theta$. Then $C_i(\theta, \mu, \rho, x)$ does not depend on x. Furthermore $C_i(\theta, \mu, \rho, x)$ is given by the following :

$$C_i(\theta, \mu, \rho) = Res\left(\widehat{F}(\theta, \mu, \rho, z); -\gamma_i(\theta)\right).$$
(4.31)

Note, that in this case, according to (2.17), $-\gamma_i(\theta)$ is a single pole of $\widehat{F}(\theta, \mu, \rho, \cdot)$. i) When the real part of $-\gamma_i(\theta)$ is bigger than $-r_{\nu}$, $C_i(\theta, \mu, \rho)$ can be determined as follows :

$$C_{i}(\theta,\mu,\rho) = \frac{1}{\varphi'(-\gamma_{i}(\theta))} \left[\frac{-\gamma_{i}(\theta) - \gamma_{0}^{*}(\theta)}{2} + \int_{0}^{\infty} \left[\frac{e^{(\gamma_{i}(\theta) - \rho)y} - e^{-\mu y}}{-\gamma_{i}(\theta) + \rho - \mu} - \frac{e^{-(\gamma_{0}^{*}(\theta) + \rho)y} - e^{-\mu y}}{\gamma_{0}^{*}(\theta) + \rho - \mu} \right] \nu(dy) + RF(\theta,\mu,\rho,.)(-\gamma_{i}(\theta)) - RF(\theta,\mu,\rho,.)(\gamma_{0}^{*}(\theta)) \right], \quad (4.32)$$

where it is supposed that $\frac{e^{ay} - 1}{a} = y$ if a = 0.

It has to be observed that if the support of ν is included in $]0, \infty[$, then the formula above reduces to the two first lines, since $RF(\theta, \mu, \rho, \cdot) = 0$. What is more, if $\theta = \mu = \rho = 0$ then

$$C_{i}(0,0,0) = \begin{cases} \frac{\varphi'(0)}{\varphi'(-\gamma_{i}(0))} & \text{if } \mathbb{E}(X_{1}) < 0\\ 1 & \text{if } i = 0 \text{ and } \mathbb{E}(X_{1}) \ge 0\\ 0 & \text{if } i \ge 1 \text{ and } \mathbb{E}(X_{1}) \ge 0 \end{cases}$$
(4.33)

Considering i = 0 in (4.33) allows to recover the result given in [5].

ii) As for the case Re $(-\gamma_i(\theta)) < -r_{\nu}$, the previous ν -integrals and φ , have to be replaced by their meromorphic extensions.

c) In this item we can focus on $C_0(\theta, \mu, \rho)$, which is the dominent term in (2.25).

- i) When $\theta > 0$ or $\theta = 0$ and $\mathbb{E}(X_1) \neq 0$, then $-\gamma_0(\theta)$ is a single zero of φ_{θ} and $-\gamma_0(\theta) > -r_{\nu}$. Therefore $C_0(\theta, \mu, \rho)$ is given by (4.32) with i = 0. Let us recall that when $\theta = 0$ and $\mathbb{E}(X_1) < 0$ (resp. $\mathbb{E}(X_1) > 0$), then $\gamma_0^*(0) = 0$ (resp. $\gamma_0(0) = 0$).
- ii) In the case $\mathbb{E}(X_1) = 0$, then $\gamma_0(0) = \gamma_0^*(0) = 0$ is a double zero of φ , but a simple pole of $\widehat{F}(\theta, \mu, \rho, .)$. Thus, a direct calculation shows :

$$C_{0}(0,\mu,\rho) = \frac{1}{\varphi''(0)} \left(1 - \frac{2}{(\rho-\mu)^{2}} \int_{0}^{\infty} e^{-\rho y} \left(1 - e^{(\rho-\mu)y} + (\rho-\mu)y \right) \nu(dy) - 2 \int_{-\infty}^{0} \nu(dy) \int_{0}^{-y} (y+b)F(0,\mu,\rho,b)db \right).$$
(4.34)

In particular :

$$C_{0}(0,0,0) = \frac{1}{\varphi''(0)} \left(1 + \int_{0}^{\infty} y^{2} \nu(dy) - 2 \int_{-\infty}^{0} \nu(dy) \int_{0}^{-y} (y+b)F(0,0,b)db \right)$$

= $1 - \frac{2}{\varphi''(0)} \int_{-\infty}^{0} \nu(dy) \int_{0}^{-y} (y+b)F(0,0,0,b)db$. (4.35)

iii) The constant $C_0(\theta, \mu, \rho)$ is positive because $\mu \to \widehat{F}(\theta, \mu, q - \gamma_0(\theta))$ is decreasing and

$$\lim_{\mu \to \infty} C_0(\theta, \mu, \rho) = \begin{cases} \frac{1}{\varphi''(0)} > 0 & \text{if } \theta = 0 \text{ and } \mathbb{E}(X_1) = 0\\ -\frac{\gamma_0(\theta) + \gamma_0^*(\theta)}{2\varphi'(-\gamma_0(\theta))} > 0 & \text{otherwise.} \end{cases}$$

4.6 Girsanov transformation

Let $(X_t, t \ge 0)$ be a Lévy process. It is well known that there is a family of probability measures $(\mathbb{P}^{(\lambda)}, 0 \le \lambda \le \gamma)$ so that, under $\mathbb{P}^{(\lambda)}, (X_t, t \ge 0)$ is still a Lévy process and :

$$\mathbb{P}^{(\lambda)}(X_t \in dx) = e^{\lambda x} e^{-t\varphi(-\lambda)} \mathbb{P}(X_t \in dx).$$
(4.36)

Consequently $\varphi^{(\lambda)}(q) = \varphi(q - \lambda) - \varphi(-\lambda)$, where $\varphi^{(\lambda)}$ is associated with $(X_t, t \ge 0)$ under $\mathbb{P}^{(\lambda)}$. Under (H), there exists λ such that $\varphi(-\lambda) = \theta$ and $\varphi'(0)\varphi'(-\lambda) < 0$. Since $\mathbb{E}(X_1) = -\varphi'(0)$, and $\mathbb{E}^{(\lambda)}(X_1) = -\varphi'^{(\lambda)}(0) = -\varphi'(-\lambda)$, then $\mathbb{E}(X_1)\mathbb{E}^{(\lambda)}(X_1) < 0$. This trick allows to only consider the case $\mathbb{E}(X_1) > 0$ (or $\mathbb{E}(X_1) < 0$), and then simplify the proofs of Theorems 2.1 and 2.3 and the result given in subsection 4.1.

4.7 Wiener-Hopf factorization

Let us recall the Wiener-Hopf decomposition (cf. [1], page 165) : for any $\theta > 0$, we have :

$$\frac{\theta}{\theta + \varphi(-q)} = \psi_{\theta}^{+}(q)\psi_{\theta}^{-}(q), \qquad (4.37)$$

where

$$\psi_{\theta}^{+}(q) := \mathbb{E}\left(e^{iqS_{\tau_{\theta}}}\right) \quad , \qquad \psi_{\theta}^{-}(q) := \mathbb{E}\left(e^{iq(S_{\tau_{\theta}} - X_{\tau_{\theta}})}\right) \,, \tag{4.38}$$

and τ_{θ} is an exponential r. v. with parameter θ , independent from process $(X_t, t \ge 0)$ and $S_t := \sup_{s \le t} X_s$.

Since :

$$\mathbb{P}(S_{\tau_{\theta}} > a) = \mathbb{P}(T_a < \tau_{\theta}) = \mathbb{E}(e^{-\theta T_a}) = F(\theta, 0, 0, a), \qquad (4.39)$$

it is easy to deduce the following identity :

$$\psi_{\theta}^{+}(q) = 1 + iq\widehat{F}(\theta, 0, 0, iq).$$
 (4.40)

Equation (2.17) implies that the Wiener-Hopf factor ψ_{θ}^+ verifies a functional equation. In particular, if $\nu(] - \infty, 0]) = 0$, combining equations (2.18) and (4.40) an explicit form of $\psi_{\theta}^+(q)$ may be obtained. Due to (4.37), $\psi_{\theta}^-(q)$ is also explicit.

4.8 Proof of Proposition 2.7

1. It is clear that φ_{θ} is holomorphic in $\{q \in \mathbb{C} ; \text{Re } q > -r_{\nu}\}$ and the only real zeros of φ_{θ} in this domain are $-\gamma_0(\theta)$ and $\gamma_0^*(\theta)$.

2. We claim that the complex zeros of φ_{θ} in $\{q \in \mathbb{C} ; -\gamma_0(\theta) \leq \operatorname{Re} q \leq \gamma_0^*(\theta)\}$ are $-\gamma_0(\theta)$ and $\gamma_0^*(\theta)$.

a) Suppose first that $-\gamma_0(\theta) < \operatorname{Re} q < \gamma_0^*(\theta)$. We have :

$$|e^{\varphi_{\theta}(q)}| = |\mathbb{E}(e^{-qX_1-\theta})| \le \mathbb{E}\left(e^{-\operatorname{Re} q X_1-\theta}\right) = e^{\varphi_{\theta}(\operatorname{Re} q)} < 1,$$

since $\varphi_{\theta} < 0$ on $] - \gamma_0(\theta), \gamma_0^*(\theta)[$. Then $\varphi_{\theta}(q) \neq 0$.

b) Let $q = -\gamma_0(\theta) + ib$, $b \in \mathbb{R}$. We compute $\varphi_{\theta}(q)$:

$$\varphi_{\theta}(q) = \varphi_{\theta}(-\gamma_{0}(\theta)) - \frac{b^{2}}{2} + \int_{-\infty}^{\infty} e^{\gamma_{0}(\theta)y} (\cos(by) - 1)\nu(dy) + i \left(-b\gamma_{0}(\theta) + cb - \int_{-\infty}^{\infty} \left(e^{\gamma_{0}(\theta)y} sin(by) - by \mathbb{1}_{\{|y| < 1\}} \right) \nu(dy) \right).$$

$$(4.41)$$

But $\varphi_{\theta}(-\gamma_0(\theta)) = 0$, then Re $(\varphi_{\theta}(q)) \leq -\frac{b^2}{2}$. Consequently $\varphi_{\theta}(q) = 0$ iff b = 0.

c) The same reasoning applies to the case $q = -\gamma_0^*(\theta) + ib$.

3. Let us prove that φ_{θ} has a finite number of zeros in the strip $\{q \in \mathbb{C}; -B \leq \text{Re } q \leq \beta_{\theta}\}$, for some β_{θ} in $]0, \gamma_{0}^{*}(\theta)[$. Proposition 2.7 is a consequence of both items 1. and 2. as described above and of the following properties :

(i) According to (2.23) there is $R > R_0 > 0$, k > 0 so that :

$$|\varphi_{\theta}(q)| \ge k|q^2| \quad \text{for any } q \text{ such that } -B \le \operatorname{Re} q \le 0, \ |\operatorname{Im} q| > R.$$

$$(4.42)$$

As a result, $\varphi_{\theta}(q) \neq 0$.

(ii) The function φ_{θ} is meromorphic in $\{q \in \mathbb{C} ; \text{Re } q > -B\}$ and therefore admits at most a finite number of poles in the compact domain $\{q \in \mathbb{C}; -B \leq \text{Re } q \leq 0, |\text{Im } q| \leq R\}$.
