#### Abstract

We introduce the notion of a para- $t t^{*}$-bundle, the generalization of a $t t^{*}$-bundle (compare [CS] and [Sch2]) in para-complex geometry. The main result is the definition of a map $\Phi$ from the space of metric para- $t t^{*}$-bundles of rank $r$ over a para-complex manifold $M$ to the space of para-pluriharmonic maps from $M$ to $G L(r) / O(p, q)$ where $(p, q)$ is the signature of the metric and the description of the image of this map $\Phi$. Then we recall and prove some results known in special complex and special Kähler geometry in the setting of para-complex geometry, which we use in the sequel to give a simple characterization of the tangent bundle of a special paracomplex and special para-Kähler manifold as a particular type of $t t^{*}$-bundles. For the case of a special para-Kähler manifold it is shown that the para-pluriharmonic map coincides with the dual Gauß map, which is a para-holomorphic map into the symmetric space $\operatorname{Sp}\left(\mathbb{R}^{2 n}\right) / \mathrm{U}^{\pi}\left(C^{n}\right) \subset \mathrm{SL}(2 n) / \mathrm{SO}(n, n) \subset \mathrm{GL}(2 n) / \mathrm{O}(n, n)$.

## 1 Introduction

The complex version of the geometries introduced in this paper, the $t t^{*}$-geometries, originated in the physics of topological-field-theories (For further information see for example [CV].). As we have shown in [CS] using differential geometric arguments or as follows from the results of Hertling $[\mathrm{H}]$ using variations of Hodge-structures, special complex and special Kähler manifolds are a special class of solutions, which play a crucial role as admissible target spaces in certain super-symmetric field theories (for more about these see $[A C D]$ and $[F])$. In [Sch2] we have proven the existence of a map $\Phi$ from the space of metric $t t^{*}$-bundles of rank $r$ over the complex manifold $(M, J)$ to the space of (twisted) pluriharmonic maps from the complex manifold $(M, J)$ to the pseudo-Riemannian symmetric space $G L(r, \mathbb{R}) / O(p, q)$ where $(\mathrm{p}, \mathrm{q})$ is the signature of the metric and characterized the image of this map. In the positive definite case the map $\Phi$ is essentially bijective. For metric $t t^{*}$-bundles with positive definite metric on a real form of the holomorphic
tangent bundle $T^{1,0} M$ of the manifold $(M, J)$ this result is due to Dubrovin [D]. In the case of a $t t^{*}$-bundle coming from a special Kähler manifold this map is essentially the dual Gauß map, as we have shown in [CS]. Further we characterized the $t t^{*}$-bundles, which come from special Kähler manifolds.
Recently, special para-complex and special para-Kähler geometry was introduced in [CMMS]. It arises as one of the special geometries of Euclidean super-symmetry. The appearance of the para-complex versions of special geometries motivated us to introduce the notion of para- $t t^{*}$-bundles. The natural questions, if special para-complex and special para-Kähler geometries are special solutions of $t t^{*}$-geometry and if there exists a map to the space of para-pluriharmonic maps from $M$ to $G L(r, \mathbb{R}) / O(p, q), S L(r, \mathbb{R}) / S O(p, q)$ respectively, i.e. pluriharmonic maps translated in the para-complex category, arise and are answered positively in this work. In addition, we analyze the para-pluriharmonic map in the context of special geometry and show, that it is closely related to the dual Gauß map.

## 2 Para-complex geometry

In this section we recall some definitions of special para-complex geometry given in [CMMS] and prove some results which are analogous to these proven for special Kähler manifolds in [ACD]. We give here just a sketch of the results needed in this paper. The interested reader could find further informations in [CMMS].

### 2.1 Para-complex manifolds

Definition 1 A para-complex structure on a (real) finite dimensional vector space $V$ is a nontrivial involution $\tau \in \operatorname{End}(V)$, i.e. $\tau^{2}=I d_{V}$ and $\tau \neq I d_{V}$, such that the two eigenspaces $V^{ \pm}:=\operatorname{ker}(I d \mp \tau)$ of $\tau$ have the same dimension. A para-complex vector space $(V, \tau)$ is a vector space endowed with a para-complex structure $\tau$. A para-complex subspace of the para-complex vector space $V$ is a subspace $W$ of the real vector-space $V$, such that the restriction of $\tau$ to $W$ is a para-complex structure.

Definition $2 A n$ almost para-complex structure on a smooth manifold $M$ is an endomorphism field $\tau \in \Gamma(\operatorname{End}(T M)), p \mapsto \tau_{p}$, such that $\tau_{p}$ is a para-complex-structure for all $p \in M$. An almost para-complex structure is called integrable if the eigendistributions $T^{ \pm} M$ are both integrable. An integrable almost para-complex structure is called para-complex structure. A manifold with a para-complex structure is called para-complex manifold.

We remark, that the integrability of an almost para-complex structure $\tau$ is shown in [CMMS] to be equivivalent to the vanishing of the Nijenhuis tensor of $\tau$ defined by

$$
N_{\tau}(X, Y):=[X, Y]+[\tau X, \tau Y]-\tau[X, \tau Y]-\tau[\tau X, Y], \text { where } X, Y \in \Gamma(T M)
$$

Definition 3 A smooth map $f:(M, \tau) \rightarrow\left(N, \tau^{\prime}\right)$ from a para-complex manifold $(M, \tau)$ to a para-complex manifold $\left(N, \tau^{\prime}\right)$ is called para-holomorphic if $d f \circ \tau=\tau^{\prime} \circ d f$ and anti-para-holomorphic if $d f \circ \tau=-\tau^{\prime} \circ d f$.

To go further we introduce the algebra $C$ of para-complex numbers. This is the real algebra generated by 1 and the symbol $e$ subject to the relation $e^{2}=1$. If one regards $e$ as a unit vector in an one-dimensional $\mathbb{R}$-vector space with negative definite scalar product, then $C$ is the Clifford algebra $C l_{0,1}=\mathbb{R} \oplus \mathbb{R}$ (Compare $C l_{1,0}=\mathbb{C}$.). As for complex numbers we define the para-complex conjugation

$$
\begin{equation*}
\ulcorner: C \rightarrow C, x+e y \mapsto x-e y \text { for } x, y \in \mathbb{R} \tag{2.1}
\end{equation*}
$$

which is a $C$-anti-linear involution, i.e. $\overline{e z}=-e \bar{z}$.
Real and imaginary parts are defined as

$$
\begin{equation*}
x=\operatorname{Re} z:=(z+\bar{z}) / 2 \text { and } y=\operatorname{Im} z:=e(z-\bar{z}) / 2 . \tag{2.2}
\end{equation*}
$$

One has $z \bar{z}=x^{2}-y^{2}$.
Every para-complex vector space $V$ is isomorphic to a trivial free $C$-module $C^{k}$ for some $k$. Obviously para-complex sub-spaces $W \subset V$ correspond to free sub-modules of $W$.
The decomposition of $T M$ over a para-complex manifold $M$ in $T^{+} M$ and $T^{-} M$ induces a bigrading on exterior forms

$$
\begin{equation*}
\Lambda^{k} T^{*} M=\oplus_{k=p+q} \Lambda^{p+, q-} T^{*} M \tag{2.3}
\end{equation*}
$$

We regard further the para-complexification $T M^{C}=T M \otimes_{\mathbb{R}} C$ of the tangent bundle $T M$ of an almost para-complex manifold $(M, \tau)$ and extend $\tau: T M \rightarrow T M C$-linearly to $\tau: T M^{C} \rightarrow T M^{C}$. Then for all $p \in M$ the free $C$-module $T_{p} M^{C}$ decomposes as $C$-module into the direct sum of two free $C$-modules

$$
\begin{equation*}
T_{p} M^{C}=T_{p}^{1,0} M \oplus T_{p}^{0,1} M \tag{2.4}
\end{equation*}
$$

where

$$
T_{p}^{1,0} M:=\left\{X+e \tau X \mid X \in T_{p} M\right\} \text { and } T_{p}^{0,1} M:=\left\{X-e \tau X \mid X \in T_{p} M\right\}
$$

The subbundles $T_{p}^{1,0} M$ and $T_{p}^{0,1} M$ can be characterized as the $\pm e$-eigenbundles of the $\operatorname{map} \tau: T M^{C} \rightarrow T M^{C}$, i.e. $\tau=e$ on $T^{1,0} M$ and $\tau=-e$ on $T^{0,1} M$.
In the same manner we decompose $T^{*} M^{C}=\Lambda^{1,0} T^{*} M \oplus \Lambda^{0,1} T^{*} M$ into the $\pm e$-eigenbundles of the dual para-complex structure $\tau^{*}: T^{*} M^{C} \rightarrow T^{*} M^{C}$. This decomposition induces a bi-grading on the $C$-valued exterior forms

$$
\Lambda^{k} T^{*} M^{C}=\bigoplus_{p+q=k} \Lambda^{p, q} T^{*} M
$$

and finally on the $C$-valued differential forms on $M$

$$
\Omega_{C}^{k}(M)=\bigoplus_{p+q=k} \Omega^{p, q}(M) .
$$

In the complex case it is well-known, that every complex manifold admits a complex torsion-free connection (see for example [KN]). We now generalize this theorem to the para-complex case:

Theorem 1 Every almost para-complex manifold ( $M, \tau$ ) admits an almost para-complex affine connection with torsion

$$
N_{\tau}=-4 T
$$

where $N_{\tau}$ is the Nijenhuis-tensor of the almost para-complex structure $\tau$.
Proof: Let $\nabla$ be a torsion-free connection on $M$. We define $Q \in \Gamma\left(\left(T^{*} M\right)^{2} \otimes T M\right)$ as

$$
4 Q(X, Y):=\left[\left(\nabla_{\tau Y} \tau\right) X+\tau\left(\left(\nabla_{Y} \tau\right) X\right)+2 \tau\left(\left(\nabla_{X} \tau\right) Y\right)\right]
$$

and further

$$
\tilde{\nabla}_{X} Y=\nabla_{X} Y+Q(X, Y)
$$

Now we compute

$$
\begin{aligned}
\left(\tilde{\nabla}_{X} \tau\right) Y & =\tilde{\nabla}_{X} \tau Y-\tau \tilde{\nabla}_{X} Y=\nabla_{X} \tau Y+Q(X, \tau Y)-\tau \nabla_{X} Y-\tau Q(X, Y) \\
& =\left(\nabla_{X} \tau\right) Y+\underbrace{(Q(X, \tau Y)-\tau Q(X, Y))}_{=: A(X, Y)}
\end{aligned}
$$

Hence we have to show $A(X, Y)=-\left(\nabla_{X} \tau\right) Y$. It is

$$
\begin{aligned}
& 4 Q(X, \tau Y)=\left(\nabla_{Y} \tau\right) X+\tau\left(\left(\nabla_{\tau Y} \tau\right) X\right)+2 \tau\left(\left(\nabla_{X} \tau\right) \tau Y\right), \\
& 4 \tau Q(X, Y)=\tau\left(\nabla_{\tau Y} \tau\right) X+\left(\left(\nabla_{Y} \tau\right) X\right)+2\left(\left(\nabla_{X} \tau\right) Y\right)
\end{aligned}
$$

With $\tau^{2}=i d$ we get $\tau\left[\left(\nabla_{X} \tau\right) \tau Y\right]=-\tau\left[\tau\left(\nabla_{X} \tau\right) Y\right]=-\left(\nabla_{X} \tau\right) Y$ and finally

$$
4 A=4(Q(X, \tau Y)-\tau Q(X, Y))=-4\left(\nabla_{X} \tau\right) Y
$$

It remains to compute the torsion of $\tilde{\nabla}$ :

$$
T_{X, Y}^{\tilde{\nabla}}=T_{X, Y}^{\nabla}+Q(X, Y)-Q(Y, X)=Q(X, Y)-Q(Y, X)
$$

With the definition of $Q$ we find

$$
\begin{aligned}
4 T_{X, Y}^{\tilde{\nabla}_{Y}} & =\left(\nabla_{\tau Y} \tau\right) X+\tau\left(\left(\nabla_{Y} \tau\right) X\right)+2 \tau\left(\left(\nabla_{X} \tau\right) Y\right) \\
& -\left(\left(\nabla_{\tau X} \tau\right) Y+\tau\left(\left(\nabla_{X} \tau\right) Y\right)+2 \tau\left(\left(\nabla_{Y} \tau\right) X\right)\right) \\
& =\left(\nabla_{\tau Y} \tau\right) X-\left(\nabla_{\tau X} \tau\right) Y+\tau\left(\left(\nabla_{X} \tau\right) Y\right)-\tau\left(\left(\nabla_{Y} \tau\right) X\right)=\left(\nabla_{\tau Y} \tau X\right)-\left(\nabla_{\tau X} \tau Y\right) \\
& -\tau\left(\nabla_{\tau Y} X-\nabla_{\tau X} Y\right)+\tau\left[\nabla_{X}(\tau Y)-\tau \nabla_{X} Y\right]-\tau\left[\nabla_{Y}(\tau X)-\tau \nabla_{Y} X\right] \\
& =[\tau Y, \tau X]+[Y, X]+\tau\left[\nabla_{X}(\tau Y)-\nabla_{\tau Y} X\right]+\tau\left[\nabla_{\tau X} Y-\nabla_{Y} \tau X\right] \\
& =[\tau Y, \tau X]+[Y, X]-\tau[\tau Y, X]-\tau[Y, \tau X]=N_{\tau}(Y, X)=-N_{\tau}(X, Y)
\end{aligned}
$$

Corollary 1 Every para-complex manifold ( $M, \tau$ ) admits a para-complex torsion-free affine connection.

### 2.2 Para-Kähler manifolds

In this subsection we recall some definitions and results from [CMMS].
Definition 4 Let $(V, \tau)$ be a para-complex vector space. A para-Hermitian scalar product $g$ on $V$ is a pseudo-Euclidean scalar product for which $\tau$ is an anti-isometry, i.e.

$$
\tau^{*} g=g(\tau \cdot, \tau \cdot)=-g(\cdot, \cdot)
$$

A para-Hermitian vector space is a para-complex vector space endowed with a para-Hermitian scalar product. The pair $(\tau, g)$ is called para-Hermitian structure on the vector space $V$.

Definition 5 An almost para-Hermitian manifold ( $M, \tau, g$ ) is an almost para-complex manifold $(M, \tau)$ endowed with a pseudo-Riemannian metric $g$ such that $\tau^{*} g=-g$. If $\tau$ is integrable, we call $(M, \tau, g)$ para-Hermitian manifold. The two-form $\omega:=g(\tau \cdot, \cdot)$ is called the fundamental two-form of the almost para-Hermitian manifold $(M, \tau, g)$.

Definition $6 \quad A$ para-Kähler manifold $(M, \tau, g)$ is a para-Hermitian manifold such that $\tau$ is parallel with respect to the Levi-Civita-connection $D$ of $g$, i.e. $D \tau=0$.

Remark 1 The fundamental two-form satisfies $\tau^{*} \omega=-\omega$ and hence is of type $(1,1)$ (considered as $C$-valued two-form).
Since $D \tau=0$ implies $N_{\tau}=0$ and $d \omega=0$, any para-Kählerian manifold is a paraHermitian manifold with closed fundamental two-form. On a para-Kähler-manifold $\omega$ is called para-Kähler-form. In fact, para-Kähler-manifolds are characterized in [CMMS] to be para-Hermitian manifolds with closed fundamental two-form.

### 2.3 Affine special para-complex and special para-Kähler manifolds

Definition $7 \quad A n$ affine special para-complex manifold $(M, \tau, \nabla)$ is a para-complex manifold $(M, \tau)$ endowed with a torsion-free flat connection such that $\nabla \tau$ is a symmetric $(1,2)$ tensor field, i.e. $\left(\nabla_{X} \tau\right) Y=\left(\nabla_{Y} \tau\right) X$ for all $X, Y \in T M$.
An affine special para-Kähler manifold $(M, \tau, g, \nabla)$ is a special para-complex manifold $(M, \tau, \nabla)$, such that $(M, \tau, g)$ is a para-Kähler manifold and $\nabla$ is symplectic, i.e. $\nabla \omega=0$.

Since projective special and projective special para-Kähler manifolds do not occur in this text, we omit the adjective affine. The definition of a special para-Kähler manifold can be found in [CMMS].
In the following part of this subsection we are going to generalize some results to paracomplex geometry, which are known from the affine special and the affine special Kähler case (see [ACD]).

Remark 2 Given a linear connection $\nabla$ on the tangent bundle of a manifold $M$ and an invertible endomorphism field $A \in \Gamma(E n d(T M))$ we define the connection

$$
\nabla^{(A)} X=A \nabla\left(A^{-1} X\right)
$$

Given a linear flat connection on the real tangent bundle of a para-complex manifold $(M, \tau)$, we define a one-parameter-family of connections by

$$
\begin{equation*}
\nabla^{\theta}=\nabla^{\left(e^{\theta \tau}\right)}=\nabla^{(\cosh (\theta) I d+\sinh (\theta) \tau)} \text { for } \theta \in \mathbb{R} . \tag{2.5}
\end{equation*}
$$

This family of connections is flat, since:

$$
\nabla X=0 \Leftrightarrow \nabla^{\theta}\left(e^{\theta \tau} X\right)=0
$$

where $X$ is a local vector field on $M$.

Lemma 1 Let $\nabla$ be a flat connection with torsion $T$ on a para-complex manifold ( $M, \tau$ ). Then it is

$$
\nabla^{\theta}=\nabla+A^{\theta}, \text { where } A^{\theta}=e^{\theta \tau} \nabla\left(e^{-\theta \tau}\right)=-\sinh (\theta) e^{\theta \tau} \nabla \tau
$$

and the torsion $T^{\theta}$ of the connection $\nabla^{\theta}$ is given by

$$
\begin{equation*}
T^{\theta}=T+\operatorname{alt}\left(A^{\theta}\right)=T-\sinh (\theta) e^{\theta \tau} d^{\nabla} \tau \tag{2.6}
\end{equation*}
$$

Proposition 1 Let $\nabla$ be a flat torsion-free connection on a para-complex manifold $(M, \tau)$. Then the triple $(M, \tau, \nabla)$ defines a special para-complex manifold if and only if one of the following conditions holds:
a) $d^{\nabla} \tau=0$.
b) The flat connection $\nabla^{\theta}$ is torsion-free for some $\theta \neq 0$.
b)' The flat connection $\nabla^{\theta}$ is torsion-free for all $\theta \neq 0$.
c) There exists $0 \neq \theta \in \mathbb{R}$ such that $\left[e^{\theta \tau} X, e^{\theta \tau} Y\right]=0$ for all $\nabla$-parallel local vector fields $X$ and $Y$ on $M$.
c)' $\left[e^{\theta \tau} X, e^{\theta \tau} Y\right]=0$ for all $\theta \neq 0$ and for all $\nabla$-parallel local vector fields $X$ and $Y$ on $M$.
d) There exists $0 \neq \theta \in \mathbb{R}$ such that $d\left(\eta \circ e^{-\theta \tau}\right)=0$ for all $\nabla$-parallel local 1-forms on M.
d)' $d\left(\eta \circ e^{-\theta \tau}\right)=0$ for all $\theta \neq 0$ and for all $\nabla$-parallel local 1 -forms on $M$.

Proof: The property a) defines special para-complex manifolds.
As $\nabla$ is torsion-free, the torsion of $\nabla^{\theta}$ is by equation (2.6):

$$
T^{\theta}=-\sinh (\theta) e^{\theta \tau} d^{\nabla} \tau
$$

Since $\sinh (\theta) \neq 0$ for $\theta \neq 0$, we get the equivalence of a) and b) respectively b)'.
Let $X$ and $Y$ be $\nabla$-parallel local vector fields. Then $e^{\theta \tau} X$ and $e^{\theta \tau} Y$ are $\nabla^{\theta}$-parallel, by the definition of $\nabla^{\theta}$. Therefore

$$
T^{\theta}\left(e^{\theta \tau} X, e^{\theta \tau} Y\right)=\left[e^{\theta \tau} X, e^{\theta \tau} Y\right]
$$

This gives $b) \Leftrightarrow c$ ) and $\left.b)^{\prime} \Leftrightarrow c\right)^{\prime}$.
For a $\nabla$-parallel 1-form $\eta$ and $X, Y$ as before we compute:

$$
\begin{aligned}
& d\left(\eta \circ e^{-\theta \tau}\right)\left(e^{\theta \tau} X, e^{\theta \tau} Y\right) \\
= & e^{\theta \tau} X \eta(Y)-e^{\theta \tau} Y \eta(X)-\eta\left(e^{-\theta \tau}\left[e^{\theta \tau} X, e^{\theta \tau} Y\right]\right) \\
= & -\eta\left(e^{-\theta \tau}\left[e^{\theta \tau} X, e^{\theta \tau} Y\right]\right)
\end{aligned}
$$

as the functions $\eta(X)$ and $\eta(Y)$ are constant. This proves $c) \Leftrightarrow d)$ and $\left.c)^{\prime} \Leftrightarrow d\right)^{\prime}$.

Proposition 2 If $(M, \tau, \nabla)$ is a special para-complex manifold, then $\left(M, \tau, \nabla^{\theta}\right)$ is a special para-complex manifold for any $\theta$.
If $(M, \tau, g, \nabla)$ is a special para-Kähler manifold, then $\left(M, \tau, g, \nabla^{\theta}\right)$ is a special para-Kähler manifold for any $\theta$.

Proof: From above we know, that $\nabla^{\theta}$ is flat and torsion-free.
In order to prove this proposition we compute $\nabla^{\theta} \tau$ and $\nabla^{\theta} \omega$.
Let $X, Y, Z \in \Gamma(T M)$

$$
\begin{aligned}
\left(\nabla_{X}^{\theta} \tau\right) Y & =\nabla_{X}^{\theta}(\tau Y)-\tau \nabla_{X}^{\theta} Y=e^{\theta \tau} \nabla_{X}\left(e^{-\theta \tau} \tau Y\right)-\tau e^{\theta \tau} \nabla_{X}\left(e^{-\theta \tau} Y\right) \\
& =e^{\theta \tau} \nabla_{X}\left(\tau e^{-\theta \tau} Y\right)-e^{\theta \tau} \tau \nabla_{X}\left(e^{-\theta \tau} Y\right)=e^{\theta \tau}\left(\nabla_{X} \tau\right) e^{-\theta \tau} Y \stackrel{(*)}{=} e^{2 \theta \tau}\left(\nabla_{X} \tau\right) Y
\end{aligned}
$$

In $\left(^{*}\right)$ we have used $\tau(\nabla \tau)=-(\nabla \tau) \tau$, which follows from $\tau^{2}=I d$.
This shows $d^{\nabla^{\theta}} \tau=e^{2 \theta \tau} d^{\nabla} \tau=0$.
Further we find utilizing $\omega\left(\cdot, e^{\theta \tau} \cdot\right)=\omega\left(e^{-\theta \tau} \cdot, \cdot\right)$, which is a consequence of $\tau^{*} \omega=-\omega$

$$
\begin{aligned}
\nabla_{Z}^{\theta} \omega(X, Y) & =Z . \omega(X, Y)-\omega\left(\nabla_{Z}^{\theta} X, Y\right)-\omega\left(X, \nabla_{Z}^{\theta} Y\right) \\
& =Z \cdot \omega(X, Y)-\omega\left(e^{\theta \tau} \nabla_{Z} e^{-\theta \tau} X, Y\right)-\omega\left(X, e^{\theta \tau} \nabla_{Z} e^{-\theta \tau} Y\right) \\
& =Z \cdot \omega(X, Y)-\omega\left(\nabla_{Z} e^{-\theta \tau} X, e^{-\theta \tau} Y\right)-\omega\left(e^{-\theta \tau} X, \nabla_{Z} e^{-\theta \tau} Y\right) \\
& =Z \cdot \omega(X, Y)-Z \cdot \omega\left(e^{-\theta \tau} X, e^{-\theta \tau} Y\right)=0 .
\end{aligned}
$$

Given a para-complex manifold with a flat connection $\nabla$, we define the conjugate connection via

$$
\nabla_{X}^{c} Y=\nabla_{X}^{(\tau)} Y=\nabla_{X} Y+\tau\left(\nabla_{X} \tau\right) Y=\tau \nabla_{X}(\tau Y) \text { for } X, Y \in \Gamma(T M)
$$

Proposition 3 Let $(M, \tau)$ be a para-complex manifold with a torsion-free flat connection $\nabla$. Then the following statements are equivalent:
a) $(M, \tau, \nabla)$ is a special para-complex manifold.
b) The conjugate flat connection $\nabla^{c}$ is torsion-free.

Proof: The torsion of $\nabla^{c}$ is

$$
T^{\nabla^{c}}=T^{\nabla}+\operatorname{alt}(\tau(\nabla \tau))=\tau d^{\nabla} \tau
$$

Therefore $\nabla^{c}$ is torsion-free if and only if $d^{\nabla} \tau=0$.
Proposition 4 Let $(M, \tau, \nabla)$ be a special para-complex manifold. Then $D:=\frac{1}{2}\left(\nabla+\nabla^{c}\right)$ defines a torsion-free connection such that $D \tau=0$.

Proof: As it is a convex-combination of torsion-free connections, $D$ is a torsion-free connection. For any $X \in \Gamma(T M)$ we compute:

$$
D_{X} \tau=\nabla_{X} \tau+\frac{1}{2}\left[\tau \nabla_{X} \tau, \tau\right]=\nabla_{X} \tau-\nabla_{X} \tau=0
$$

Proposition 5 Let $(M, \tau, g, \nabla)$ be a special para-Kähler manifold and $\nabla^{g}$ the LeviCivita connection of $g$. Then the following hold:
(i) $\nabla^{g}=\frac{1}{2}\left(\nabla+\nabla^{c}\right)=D$.
(ii) The conjugate connection $\nabla^{c}$ is $g-d u a l$, i.e.:

$$
X . g(Y, Z)=g\left(\nabla_{X}^{c} Y, Z\right)+g\left(Y, \nabla_{X} Z\right)
$$

equivalently

$$
X . g(Y, Z)=g\left(\nabla_{X} Y, Z\right)+g\left(Y, \nabla_{X}^{c} Z\right)
$$

for all vector fields $X, Y, Z \in \Gamma(T M)$.
(iii) The tensor $\nabla g$ is completely symmetric.

Proof: (i) follows immediately from (ii) and proposition 4.
(ii) follows from a direct calculation which only uses the fact that $\omega$ is $\nabla$-parallel and $\tau$-anti-invariant: With $X, Y, Z \in \Gamma(T M)$ one finds

$$
\begin{aligned}
X . g(Y, Z) & =X . \omega(\tau Y, Z)=\omega\left(\nabla_{X} \tau Y, Z\right)+\omega\left(\tau Y, \nabla_{X} Z\right) \\
& =-\omega\left(\tau \nabla_{X} \tau Y, \tau Z\right)+g\left(Y, \nabla_{X} Z\right) \\
& =\omega\left(\tau Z, \tau \nabla_{X} \tau Y\right)+g\left(Y, \nabla_{X} Z\right) \\
& =g\left(Z, \tau \nabla_{X}(\tau Y)\right)+g\left(Y, \nabla_{X} Z\right) \\
& =g\left(\nabla_{X}^{c} Y, Z\right)+g\left(Y, \nabla_{X} Z\right) .
\end{aligned}
$$

Finally (iii) follows from (ii) with the same argument as in [ACD].
Proposition 6 Let $(M, \tau, g, \nabla)$ be a special para-Kähler manifold and $D$ the Levi-Civita connection of $g$. Define the endomorphism field $S$ as

$$
S:=\nabla-D=\nabla-\frac{1}{2}\left(\nabla+\nabla^{c}\right)=\frac{1}{2}\left(\nabla-\nabla^{c}\right)=-\frac{1}{2} \tau(\nabla \tau) .
$$

(i) symmetric, i.e.: $S_{X} Y=S_{Y} X ; \forall X, Y \in \Gamma(T M)$,
(ii) $\omega$-skew-symmetric, i.e.: $\omega(S \cdot, \cdot)=-\omega(\cdot, S \cdot)$,
(iii) $g$-symmetric, i.e.: $g(S \cdot, \cdot)=g(\cdot, S \cdot)$
(iv) and anticommutes with $\tau$, i.e.:

$$
\begin{equation*}
\left\{S_{X}, \tau\right\}=S_{X} \tau+\tau S_{X}=0 \text { for all } X \in \Gamma(T M) \tag{2.7}
\end{equation*}
$$

Proof: Let $X, Y, Z \in \Gamma(T M)$.
(i) For a special para-complex manifold $\nabla$ and $\nabla^{c}$ are torsion-free (by definition and proposition 3), so $\nabla-\nabla^{c}=-\tau(\nabla \tau)=2 S$ is symmetric.
(ii) In fact $D g=0$ (proposition 5) and $D \tau=0$ (proposition 4) imply $D \omega=0$. In addition $\nabla \omega=0$ yields
$\omega\left(S_{X} Y, Z\right)+\omega\left(Y, S_{X} Z\right)=\omega\left((\nabla-D)_{X} Y, Z\right)+\omega\left(Y,(\nabla-D)_{X} Z\right)=(\nabla-D)_{X} \omega(Y, Z)=0$.
(iii) Using $X . g(Y, Z)-g\left(\nabla_{X} Y, Z\right)=g\left(Y, \nabla_{X}^{c} Z\right)$ we prove the $g$-symmetry of $S$

$$
\begin{aligned}
2 g\left(S_{X} Y, Z\right)=g\left(\left(\nabla-\nabla^{c}\right)_{X} Y, Z\right) & =g\left(\nabla_{X} Y, Z\right)-g\left(\nabla_{X}^{c} Y, Z\right) \\
& =X \cdot g(Y, Z)-g\left(Y, \nabla_{X}^{c} Z\right)-X . g(Y, Z)+g\left(Y, \nabla_{X} Z\right) \\
& =g\left(Y,\left(\nabla-\nabla^{c}\right)_{X} Z\right)=2 g\left(Y, S_{X} Z\right)
\end{aligned}
$$

(iv) Now we need only the $\omega$-skew-symmetry of $S$, the $g$-symmetry of $S$ and $\omega=g(\tau \cdot, \cdot)=$ $-g(\cdot, \tau \cdot)$ to get with $X, Y, Z \in \Gamma(T M)$

$$
g\left(S_{X} \tau Y, Z\right)=g\left(\tau Y, S_{X} Z\right)=\omega\left(Y, S_{X} Z\right)=-\omega\left(S_{X} Y, Z\right)=-g\left(\tau S_{X} Y, Z\right)
$$

and consequently $\left\{S_{X}, \tau\right\}=0$.

## 3 Para-tt*-bundles

In this section we introduce the definition of a para-complex version of $t t^{*}$-bundles which will be referred to as para- $t t^{*}$-bundles.

Definition 8 A para-tt*-bundle ( $p t t^{*}$-bundle) ( $E, D, S$ ) over a para-complex manifold $(M, \tau)$ is a real vector bundle $E \rightarrow M$ endowed with a connection $D$ and a section $S$ of $T^{*} M \otimes$ End $E$ satisfying the ptt*-equation

$$
\begin{equation*}
R^{\theta}=0 \quad \text { for all } \quad \theta \in \mathbb{R}, \tag{3.1}
\end{equation*}
$$

where $R^{\theta}$ is the curvature tensor of the connection $D^{\theta}$ defined by

$$
\begin{equation*}
D_{X}^{\theta}:=D_{X}+\cosh (\theta) S_{X}+\sinh (\theta) S_{\tau X} \quad \text { for all } \quad X \in T M \tag{3.2}
\end{equation*}
$$

A metric $p t t^{*}$-bundle $(E, D, S, g)$ is a $p t t^{*}$-bundle $(E, D, S)$ endowed with a possibly indefinite $D$-parallel fiber metric $g$, such that $S$ is $g$-symmetric, i.e. for all $p \in M$

$$
\begin{equation*}
g\left(S_{X} Y, Z\right)=g\left(Y, S_{X} Z\right) \quad \text { for all } \quad X, Y, Z \in T_{p} M \tag{3.3}
\end{equation*}
$$

A unimodular metric para-tt*-bundle $(E, D, S, g)$ is a metric ptt*-bundle ( $E, D, S, g$ ), such that $\operatorname{tr} S_{X}=0$ for all $X \in T M$. An oriented unimodular metric para-tt*-bundle ( $E, D, S, g$, or $)$ is a unimodular metric ptt*-bundle endowed with an orientation or of the bundle $E$.

## Remark 3

1) If $(E, D, S)$ is a ptt*-bundle then $\left(E, D, S^{\theta}\right)$ is a ptt*-bundle for all $\theta \in \mathbb{R}$, where

$$
\begin{equation*}
S^{\theta}:=D^{\theta}-D=\cosh (\theta) S+\sinh (\theta) S_{\tau} \tag{3.4}
\end{equation*}
$$

The same remark applies to metric ptt*-bundles.
2) Notice that an oriented unimodular metric ptt*-bundle ( $E, D, S, g$,or) carries a canonical metric volume element $\nu \in \Gamma\left(\wedge^{r} E^{*}\right), r=\operatorname{rk} E$, determined by $g$ and or, which is $D^{\theta}$-parallel for all $\theta \in \mathbb{R}$.

Proposition 7 Let $E$ be a real vector bundle over a para-complex manifold ( $M, \tau$ ) endowed with a connection $D$ and a section $S \in \Gamma\left(T^{*} M \otimes \operatorname{End} E\right)$.
Then $(E, D, S)$ is a ptt*-bundle if and only if $D$ and $S$ satisfy the following equations:

$$
\begin{equation*}
R^{D}+S \wedge S=0, S \wedge S \text { is of type }(1,1), d^{D} S=0 \text { and } d^{D} S_{\tau}=0 \tag{3.5}
\end{equation*}
$$

We remark, that in the case $(1,1)$ and (1+,1-) the two gradings defined in section 2.1 coincide.

Proof: To prove the proposition, we have to compute the curvature of $D^{\theta}$.
Let $X, Y \in \Gamma(T M)$ arbitrary:

$$
\begin{aligned}
R_{X, Y}^{\theta} & =R_{X, Y}^{D}+\left[D_{X}, \cosh (\theta) S_{Y}+\sinh (\theta) S_{\tau Y}\right]+\left[\cosh (\theta) S_{X}+\sinh (\theta) S_{\tau X}, D_{Y}\right] \\
& +\left[\cosh (\theta) S_{X}+\sinh (\theta) S_{\tau X}, \cosh (\theta) S_{Y}+\sinh (\theta) S_{\tau Y}\right] \\
& -\cosh (\theta) S_{[X, Y]}-\sinh (\theta) S_{\tau[X, Y]} \\
& =R_{X, Y}^{D}+\sinh ^{2}(\theta)\left[S_{\tau X}, S_{\tau Y}\right]+\cosh ^{2}(\theta)\left[S_{X}, S_{Y}\right] \\
& +\cosh (\theta) \sinh (\theta)\left(\left[S_{X}, S_{\tau Y}\right]+\left[S_{\tau X}, S_{Y}\right]\right) \\
& +\cosh (\theta)\left(\left[D_{X}, S_{Y}\right]+\left[S_{X}, D_{Y}\right]-S_{[X, Y]}\right) \\
& +\sinh (\theta)\left(\left[S_{\tau X}, D_{Y}\right]+\left[D_{X}, S_{\tau Y}\right]-S_{\tau[X, Y]}\right) .
\end{aligned}
$$

The theorems of addition
$\sinh (a) \cosh (a)=\frac{1}{2} \sinh (2 a), \quad \cosh (a)^{2}=\frac{1}{2}(1+\cosh (2 a))$ and $\sinh (a)^{2}=\frac{1}{2}(\cosh (2 a)-1)$ yield

\begin{aligned}
R_{X, Y}^{\theta} & =R_{X, Y}^{D}+\frac{1}{2}\left(\left[S_{X}, S_{Y}\right]-\left[S_{\tau X}, S_{\tau Y}\right]\right) \\
& +\sinh (\theta)\left(\left[S_{\tau X}, D_{Y}\right]+\left[D_{X}, S_{\tau Y}\right]-S_{\tau[X, Y]}\right) \\
& +\cosh (\theta)\left(\left[D_{X}, S_{Y}\right]+\left[S_{X}, D_{Y}\right]-S_{[X, Y]}\right) \\
& +\frac{1}{2} \sinh (2 \theta)\left(\left[S_{X}, S_{\tau Y}\right]+\left[S_{\tau X}, S_{Y}\right]\right)+\frac{1}{2} \cosh (2 \theta)\left(\left[S_{\tau X}, S_{\tau Y}\right]+\left[S_{X}, S_{Y}\right]\right)
\end{aligned}
$$

Separation in $1, \sinh (n \theta), \cosh (n \theta)$ with $n=1,2$ implies

$$
\begin{aligned}
& 0=R_{X, Y}^{D}+\frac{1}{2}\left(\left[S_{X}, S_{Y}\right]-\left[S_{\tau X}, S_{\tau Y}\right]\right) \\
& 0=\left[S_{\tau X}, D_{Y}\right]+\left[D_{X}, S_{\tau Y}\right]-S_{\tau[X, Y]}, \\
& 0=\left[D_{X}, S_{Y}\right]+\left[S_{X}, D_{Y}\right]-S_{[X, Y]} \quad \text { and } \\
& 0
\end{aligned}=\left[S_{X}, S_{Y}\right]+\left[S_{\tau X}, S_{\tau Y}\right]=\left[S_{\tau X}, S_{Y}\right]+\left[S_{X}, S_{\tau Y}\right] ~ l
$$

and equivalently

$$
\begin{aligned}
& S \wedge S(X, Y)=\left[S_{X}, S_{Y}\right]=-\left[S_{\tau X}, S_{\tau Y}\right], \text { i.e. is of type }(1,1), \\
& R^{D}+S \wedge S=0, \\
& d^{D} S(X, Y)=D_{X}\left(S_{Y}\right)-D_{Y}\left(S_{X}\right)-S_{[X, Y]}=0 \quad \text { and } \\
& d^{D} S_{\tau}(X, Y)=D_{X}\left(S_{\tau Y}\right)-D_{Y}\left(S_{\tau X}\right)-S_{\tau[X, Y]}=0 .
\end{aligned}
$$

## 4 Special para-complex and special para-Kähler manifolds as solutions of $p t t^{*}$-geometry

In this section we are interested in $p t t^{*}$-bundles on the tangent-bundle $T M$ of a paracomplex manifold $(M, \tau)$. In this context it is natural to regard $p t t^{*}$-bundles, for that the connection $\nabla^{\theta}$ is torsion-free.

Definition 9 A ptt*-bundle $(T M, D, S)$ over a para-complex manifold $(M, \tau)$ is called special if $D^{\theta}$ is torsion-free and special, i.e. $D^{\theta} \tau$ is symmetric for all $\theta$.

Proposition 8 A ptt*-bundle $(T M, D, S)$ is special if and only if $D$ is torsion-free and $D \tau, S$ and $S_{\tau}$ are symmetric.

Proof: The torsion $T^{\theta}$ of $D^{\theta}$ equals

$$
\begin{equation*}
T^{\theta}(X, Y)=T(X, Y)+\cosh (\theta)\left(S_{X} Y-S_{Y} X\right)+\sinh (\theta)\left(S_{\tau X} Y-S_{\tau Y} X\right) \tag{4.1}
\end{equation*}
$$

where $T$ is the torsion-tensor of $D$. This implies, that $T^{\theta}=0$ for all $\theta$ if and only if $T=0$ and $S$ and $S_{\tau}$ are symmetric. The equation

$$
\begin{array}{lcl}
\left(D_{X}^{\theta} \tau\right) Y & = & \left(D_{X} \tau\right) Y+\cosh (\theta)\left[S_{X}, \tau\right] Y+\sinh (\theta)\left[S_{\tau X}, \tau\right] Y  \tag{4.2}\\
\left\{S_{X}, \tau\right\}=0 \\
= & \left(D_{X} \tau\right) Y-2 \cosh (\theta) \tau S_{X} Y-2 \sinh (\theta) \tau S_{\tau X} Y
\end{array}
$$

shows that $D^{\theta} \tau$ is symmetric if $D \tau, \mathrm{~S}$ and $S_{\tau}$ are symmetric. Conversely, if $T^{\theta}=0$ and $D^{\theta} \tau$ is symmetric, then the first part of the proof yields, that $S$ and $S_{\tau}$ are symmetric and $T=0$. Equation (4.2) implies finally the symmetry of $D \tau$.

## Theorem 2

(i) Let $(M, \tau, \nabla)$ be a special para-complex manifold. Put $S:=-\frac{1}{2} \tau \nabla \tau$ and $D:=\nabla-S$. Then $(T M, D, S)$ is a special ptt*-bundle with the following additional properties:
a) $S_{X} \tau=-\tau S_{X}$ for all $X \in T M$ and
b) $D \tau=0$.

This defines a map $\Phi$ from special para-complex manifolds to special ptt*-bundles.
(ii) Let $(T M, D, S)$ be a special ptt*-bundle over a para-complex manifold ( $M, \tau$ ). Then $(M, \tau, \nabla:=D+S)$ is a special para-complex manifold. This defines a map $\Psi$ from special ptt*-bundles to special para-complex manifolds such that $\Psi \circ \Phi=I d$. If $(T M, D, S)$ is a special ptt*-bundle satisfying the conditions a) and b) of (i), then $\Phi(\Psi(T M, D, S))=(T M, D, S)$.
(iii) Let $(M, \tau, g, \nabla)$ be a special para-Kähler manifold with $S$ and $D$ as in (i). Then ( $T M, D, S, g$ ) defines a special metric ptt*-bundle satisfying a) and b) of (i). This defines a map, also called $\Phi$, from special para-Kähler manifolds to special metric ptt*-bundles.
(iv) Let $(T M, D, S, g)$ be a special metric ptt*-bundle over a para-Hermitian manifold $(M, \tau, g)$ satisfying the conditions a) and b) in (i). Then $(M, \tau, g, \nabla:=D+S)$ is a special para-Kähler manifold. In particular, we have a map $\Psi$ from special metric ptt*-bundles over para-Hermitian manifolds $(M, \tau, g)$ satisfying the conditions a) and b) in (i) to special para-Kähler manifolds. Moreover $\Psi$ is a bijection and $\Psi^{-1}=\Phi$.
(v) Let $(T M, D, S, g)$ be a metric $p t t^{*}$-bundle over a para-Hermitian manifold ( $M, \tau, g$ ) satisfying the conditions a) and b) in (i) and such that $D$ is torsion-free. Then it is special if and only if $(M, \tau, g, \nabla:=D+S)$ is a special para-Kähler manifold.

Proof:
(i) Let $(M, \tau, \nabla)$ be a special para-complex manifold with $S$ and $D$ defined as above. Then $\nabla^{\theta}=e^{\theta \tau} \circ \nabla \circ e^{-\theta \tau}$ defines a family of torsion-free flat connections. Using $\nabla=D+S$ we obtain

$$
\nabla_{X}^{\theta}=D_{X}+e^{2 \theta \tau} S_{X}
$$

due to the following computation (using $D \tau=0$ due to proposition 4 and $\left\{S_{X}, \tau\right\}=0$ for all $X \in T M$, see proposition 6)

$$
\begin{aligned}
\nabla_{X}^{\theta} Y & = \\
\left\{\tau, S_{X}\right\}=0 & e^{\theta \tau}\left(D_{X}+S_{X}\right)\left(e^{-\theta \tau} Y\right)=e^{\theta \tau} D_{X}(\cosh (\theta) Y-\sinh (\theta) \tau Y)+e^{\theta \tau} S_{X}\left(e^{-\theta \tau} Y\right) \\
& =e^{\theta \tau}\left(\cosh (\theta) D_{X} Y-\sinh (\theta)\left(\left(D_{X} \tau\right) Y+\tau D_{X} Y\right)+e^{2 \theta \tau} S_{X} Y\right. \\
& D_{X} Y+e^{2 \theta \tau} S_{X} Y
\end{aligned}
$$

Now we show that $\nabla^{\theta}=D^{-2 \theta}$, where $D^{\theta}$ was defined in (3.2):

$$
\begin{aligned}
\nabla_{X}^{\theta}-D_{X} & =e^{2 \theta \tau} S_{X}=\cosh (2 \theta) S_{X}+\sinh (2 \theta) \tau S_{X} \\
& \stackrel{(*)}{=} \cosh (2 \theta) S_{X}-\sinh (2 \theta) S_{\tau X}=D_{X}^{-2 \theta}-D_{X}, \quad X \in T M
\end{aligned}
$$

In $(*)$ we have used that $\tau S_{X}=-S_{\tau X}$, which follows from the symmetry of $S$ and $\{S, \tau\}=0$ by

$$
\tau S_{X} Y=\tau S_{Y} X=-S_{Y} \tau X=-S_{\tau X} Y, \quad X, Y \in T_{p} M
$$

This shows, that $(T M, D, S)$ is a special $p t t^{*}$-bundle. The additional properties hold, as $(M, \tau, \nabla)$ is a special para-complex manifold (compare proposition 4 and 6).
(ii) In order to prove the second statement, let $(T M, D, S)$ be a special $p t t^{*}$-bundle, i.e. $D^{\theta}$ is flat, torsion-free and special. In particular, $\nabla=D+S=D^{0}$ is flat, torsion-free and special. Hence $(M, \tau, \nabla)$ is a special para-complex manifold. Obviously we have $\Psi \circ \Phi=I d$.
Conversely, let $(T M, D, S)$ be a special $p t t^{*}$-bundle satifying $D \tau=0$ and $S_{X} \tau=-\tau S_{X}$ for all $X \in T_{p} M$. Then we obtain $D$ and $S$ from $\nabla=D+S$ by the formulas $S=-\frac{1}{2} \tau \nabla \tau$ and $D=\nabla-S$. In fact, let $\left(T M, D^{\prime}, S^{\prime}\right)$ be another special $p t t^{*}$-bundle over $(M, \tau)$ with $D^{\prime} \tau=0, S_{X}^{\prime} \tau=-\tau S_{X}^{\prime}$ for all $X \in T_{p} M$ and $\nabla=D+S=D^{\prime}+S^{\prime}$ then

$$
\begin{equation*}
0=D_{X}^{\prime} \tau=\nabla_{X} \tau-\left[S_{X}^{\prime}, \tau\right]=\nabla_{X} \tau+2 \tau S_{X}^{\prime} \tag{4.3}
\end{equation*}
$$

for all $X \in T_{p} M$. This shows $S_{X}^{\prime}=-\frac{1}{2} \tau \nabla \tau=S_{X}$ and $D^{\prime}=\nabla-S^{\prime}=\nabla-S=D$.
(iii) Let $(M, \tau, g, \nabla)$ be a special para-Kähler manifold with $D$ and $S$ defined as in (i). Then $(T M, D, S)$ is a special $p t t^{*}$-bundle satisfying a) and b), due to (i). Proposition 5 implies, that $D g=0$ and proposition 6 implies, that $S$ is g-symmetric and hence that ( $T M, D, S, g$ ) is a special metric $p t t^{*}$-bundle.
(iv) Let ( $T M, D, S, g$ ) be a special metric $\mathrm{p} t t^{*}$-bundle over a para-Hermitian manifold $(M, \tau, g)$ satisfying a) and b) in (i). By (ii), we know already, that ( $M, \tau, \nabla:=D+S)$ is a special para-complex manifold. Therefore it remains to prove $\nabla \omega=0$. We have $D g=0$ and $D \tau=0$ (property b) in (i)) and consequently $D \omega=0$. As $D \omega=0, \nabla \omega=0$ is equivalent to the $\omega$-skew-symmetry of $S$ and finally to the $g$-symmetry of $S$, since $\left\{\tau, S_{X}\right\}=0$. But by the definition of a metric $p t t^{*}$-bundle $S$ is $g$-symmetric. Therefore ( $M, \tau, \nabla, g$ ) is a special para-Kähler manifold. The rest of part (iv) follows from part (ii). (v) We have only to show the direction which follows not from (iv). Let ( $T M, D, S, g$ ) be a metric $\mathrm{p} t t^{*}$-bundle over a para-Hermitian manifold $(M, \tau, g)$, such that $(M, \tau, g, \nabla=$ $D+S)=\Psi(T M, D, S, g)$ is a special para-Kähler manifold. If $D$ is torsion-free, then it is the Levi-Civita connection of $g$, and therefore $D=\nabla+\frac{1}{2} \tau \nabla \tau$, see proposition 5 . This shows, that $\Phi(M, \tau, g, \nabla)=(T M, D, S, g)$ and that $(T M, D, S, g)$ is a special metric $p t t^{*}$-bundle.

Corollary 2 A metric ptt*-bundle (TM, D, S, g) over a para-Hermitian manifold ( $M, \tau, g$ ) which satisfies a) and b) in theorem 2 is oriented and unimodular.

Proof: By theorem $2,(M, \tau, g, \nabla=D+S)$ is a special para-Kähler manifold. Hence we can orient it by $\omega \wedge \ldots \wedge \omega$, where $\omega$ is its para-Kähler-form. Its para-Kähler-form is parallel with respect to the connections $D$ and $\nabla$ and therefore invariant under $S_{X}=\nabla_{X}-D_{X}$. This shows $\operatorname{tr} S_{X}=0$.

## 5 Para-pluriharmonic maps

In this section we introduce the notion of para-pluriharmonic maps as an analogue to pluriharmonic maps and deduce some properties of para-pluriharmonic maps, especially to $S(p, q)=G L(r) / O(p, q)^{1}$ and $S^{1}(p, q)=S L(r) / S O(p, q)$ which are needed later and which we have not found in the literature.

Definition 10 Let $(M, \tau)$ be a para-complex manifold and $(N, h)$ be a pseudo-Riemannian manifold with Levi-Civita connection $\nabla^{h}, D$ a connection on $M$ which satisfies

$$
\begin{equation*}
D_{\tau Y} X=\tau D_{Y} X \tag{5.1}
\end{equation*}
$$

for all vector fields which satisfy $\mathcal{L}_{X} \tau=0$ (i.e. for which $X+e \tau X$ is para-holomorphic) and $\nabla$ the connection on $T^{*} M \otimes f^{*} T N$ which is induced by $D$ and $\nabla^{h}$.
A map $f: M \rightarrow N$ is para-pluriharmonic if and only if it satisfies the equation

$$
\begin{equation*}
\nabla^{\prime \prime} \partial f=0 \tag{5.2}
\end{equation*}
$$

where $\partial f=d f^{1,0} \in \Gamma\left(\bigwedge^{1,0} T^{*} M \otimes_{C}(T N)^{C}\right)$ is the $(1,0)$-component of $d^{C} f$ and $\nabla^{\prime \prime}$ is the $(0,1)$-component of $\nabla=\nabla^{\prime}+\nabla^{\prime \prime}$.
Equivalently one regards $\alpha=\nabla d \phi \in \Gamma\left(T^{*} M \otimes T^{*} M \otimes \phi^{*} T N\right)$.
Then $\phi$ is para-pluriharmonic if and only if

$$
\alpha(X, Y)-\alpha(\tau X, \tau Y)=0
$$

for all $X, Y \in T M$. This can also be expressed as

$$
\alpha^{1+, 1-}=0 .
$$

We recall, that in the case $(1,1)$ and (1+,1-) the two gradings defined in section 2.1 coincide.
On every para-complex manifold exists a para-complex torsion-free connection, as we have shown in corollary 1. The following proposition ensures now the existence of a connection satisfying equation (5.1).

## Proposition 9

(i) Every para-complex torsion-free connection $D$ on a para-complex manifold ( $M, \tau$ ) satisfies equation (5.1).
(ii) On every para-complex manifold there exists a connection satisfying equation (5.1).

Proof: (i) The conditions $T^{D}=0$ and $D \tau=0$ yield

$$
\begin{equation*}
D_{\tau Y} X-\tau D_{Y} X=[\tau Y, X]+D_{X}(\tau Y)-\tau D_{Y} X=[\tau Y, X]-\tau[Y, X]=-\left(\mathcal{L}_{X} \tau\right) Y \tag{5.3}
\end{equation*}
$$

[^1]The right-hand side vanishes if $\mathcal{L}_{X} \tau=0$.
(ii) The existence of a para-complex torsion-free connection $D$ on $(M, \tau)$ follows from corollary 1. Part (i) implies now the statement (ii).

This result motivates the

Convention: In the following text the connection $D$ on $M$ is taken to be torsion-free and para-complex.

Definition 11 A para-complex curve is a para-complex manifold of para-complex dimension one. A para-complex curve in a para-complex manifold $M$ is a para-complex curve which is a para-complex sub-manifold of $M$.

With this notation we have
Proposition 10 A map $f:(M, \tau) \rightarrow(N, h)$ from a para-complex manifold $(M, \tau)$ to a pseudo-Riemannian manifold $(N, h)$ is para-pluriharmonic if and only if the restriction of $f$ to any para-complex curve $C$ in $M$ is harmonic.

Proof: Let $C \subset M$ be a para-complex curve in $(M, \tau)$. On $C$ a Hermitian metric $g$ in the para-conformal class of $\tau$ is chosen. As $g$ is hermitian it is of type $(1+, 1-)$. Hence the trace of $\nabla d f_{\mid C}$ with respect to $g$ is zero if and only if $\nabla^{\prime \prime} \partial f_{\mid C}=0$, as $\nabla d f$ is symmetric. Since this holds for all curves $C$ in $M$ the proposition is proven.

Let $\operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ be the space of symmetric $r \times r$ matrices of signature $(p, q)$. These define pseudo-scalar-products of same signature by $<\cdot, \cdot>_{A}=<A \cdot, \cdot>_{\mathbb{R}^{r}}$, where $<\cdot, \cdot>_{\mathbb{R}^{r}}$ is the Euclidean scalar-product. The action of an element $g \in G L(r)$ is induced by the action of $G L(r)$ on the pseudo-scalar-products of signature $(p, q)$, i.e. by $g .<\cdot, \cdot>_{A}=$ $<g^{-1} \cdot, g^{-1} \cdot>_{A}=<\left(g^{-1}\right)^{t} A g^{-1} \cdot, \cdot>_{\mathbb{R}^{r}}$. This gives an action of $G L(r) A \mapsto\left(g^{-1}\right)^{t} A g^{-1}$ on $\operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ which we use to identify $\operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ with $S(p, q)$ in the following proposition. In the same manner, we can identify $S^{1}(p, q)=S L(r) / S O(p, q)$ with the space of symmetric $r \times r$ matrices of signature $(p, q)$ and determinant $(-1)^{q}$.

## Proposition 11

a) Let $\Psi$ be the above identification $\Psi: S(p, q) \stackrel{\sim}{\rightarrow} \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right) \subset G L(r)$ where $G L(r)$ carries the pseudo-Riemannian metric, given by the (Ad-invariant) trace-form, i.e. $(A, B) \mapsto \operatorname{tr}(A B)$. Then $\Psi$ is a totally-geodesic immersion and a map $\tilde{f}$ from a para-complex manifold $(M, \tau)$ to $S(p, q)$ is para-pluriharmonic, iff the map $f=$ $\Psi \circ \tilde{f}: M \rightarrow S(p, q) \stackrel{\sim}{\rightarrow}$ Sym $_{p, q}\left(\mathbb{R}^{r}\right) \subset G L(r)$ is para-pluriharmonic.
b) Let $\Psi^{0}$ be the above identification $\Psi^{0}: S^{1}(p, q) \stackrel{\sim}{\rightarrow} \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right) \subset S L(r)$ where $S L(r)$ carries the pseudo-Riemannian metric, given by the (Ad-invariant) trace-form, i.e. $(A, B) \mapsto \operatorname{tr}(A B)$. Then $\Psi^{0}$ is a totally-geodesic immersion and a map $\tilde{f}$ from a para-complex manifold $(M, \tau)$ to $S^{1}(p, q)$ is para-pluriharmonic, iff the map $f=$ $\Psi^{0} \circ \tilde{f}: M \rightarrow S^{1}(p, q) \underset{\rightarrow}{\sim} S y m_{p, q}^{1}\left(\mathbb{R}^{r}\right) \subset S L(r)$ is para-pluriharmonic.

Proof: The proof of the first part was done in [Sch2] by expressing the map $\Psi$ in terms of the well-known Cartan-immersion.
It remains to prove $\tilde{f}$ para-pluriharmonic if and only if $\Psi \circ \tilde{f}$ is para-pluriharmonic.
Let $X, Y$ be para-holomorphic vector-fields and $D$ the connection on $M$. We calculate $\nabla d f(X, Y)=\nabla_{X}(d f(Y))-d f\left(D_{X} Y\right)$. Taking the (1, 1)-part of this expression we find for the second term:

$$
d f\left(D_{X} Y-D_{\tau X} \tau Y\right)=d f\left(D_{X} Y-\tau^{2} D_{X} Y\right)=0
$$

Therefore the para-pluriharmonicity is independent of the connection chosen on $M$. Hence we have only to regard the Levi-Civita-connections on $G=G L(r), S L(r)$ respectively $G / K=G L(r) / O(p, q), S L(r) / S O(p, q)$. Let $X, Y \in \Gamma(T M)$ be para-holomorphic and calculate:

$$
\nabla_{X}^{G} d(\Psi \circ f)(Y)=\nabla_{X}^{G} d \Psi(d f(Y))=\nabla_{X}^{G} \Psi_{*}(d f(Y))=\Psi_{*}\left(\nabla_{X}^{G / K} d f(Y)\right)+I I(X, Y)
$$

where $I I$ is the second fundamental-form which vanishes, as the immersion is totally geodesic. This implies

$$
\begin{aligned}
\alpha^{G}(X, Y)-\alpha^{G}(\tau X, \tau Y) & =\nabla_{X}^{G} d(\Psi \circ f)(Y)-\nabla_{\tau X}^{G} d(\Psi \circ f)(\tau Y) \\
& =\Psi_{*}\left(\nabla_{X}^{G / K} d f(Y)-\nabla_{\tau X}^{G / K} d f(\tau Y)\right) \\
& =\Psi_{*}\left(\alpha^{G / K}(X, Y)-\alpha^{G / K}(\tau X, \tau Y)\right)
\end{aligned}
$$

Since $\Psi$ is an immersion, the proof is finished.

## Remark 4 (see also [CS], [Sch2])

We want to have a closer look on the identification of $G L(r) / O(p, q)$ with $\operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ via $\Psi$.
To do this we choose $o=e O(p, q)$ as base point and suppose that $\Psi$ is chosen to map o to $I=I_{p, q}$. By construction $\Psi$ is $\mathrm{GL}(r)$-equivariant. Further we identify the tangent-space $T_{S} \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ at $S \in \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ with the (ambient) vector space of symmetric matrices:

$$
\begin{equation*}
T_{S} \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)=\operatorname{Sym}\left(\mathbb{R}^{r}\right):=\left\{A \in \operatorname{Mat}(r, \mathbb{R}) \mid A^{t}=A\right\} \tag{5.4}
\end{equation*}
$$

For $\Psi(\tilde{S})=S$, the tangent space $T_{\tilde{S}} S(p, q)$ is canonically identified with the vector space of $S$-symmetric matrices:

$$
\begin{equation*}
T_{\tilde{S}} S(p, q)=\operatorname{sym}(S):=\left\{A \in \mathfrak{g l r}(r) \mid A^{t} S=S A\right\} \tag{5.5}
\end{equation*}
$$

Note that $\operatorname{sym}\left(I_{p, q}\right)=\operatorname{sym}(p, q)$.
Proposition 12 The differential of $\varphi:=\Psi^{-1}$ at $S \in \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ is given by

$$
\begin{equation*}
\operatorname{Sym}\left(\mathbb{R}^{r}\right) \ni X \mapsto-\frac{1}{2} S^{-1} X \in S^{-1} \operatorname{Sym}\left(\mathbb{R}^{r}\right)=\operatorname{sym}(S) \tag{5.6}
\end{equation*}
$$

Using this proposition we relate now the differentials

$$
\begin{equation*}
d f_{x}: T_{x} M \rightarrow \operatorname{Sym}\left(\mathbb{R}^{r}\right) \tag{5.7}
\end{equation*}
$$

of a map $f: M \rightarrow \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ at $x \in M$ and

$$
\begin{equation*}
d \tilde{f}_{x}: T_{x} M \rightarrow \operatorname{sym}(f(x)) \tag{5.8}
\end{equation*}
$$

of the map $\tilde{f}=\varphi \circ f: M \rightarrow S(p, q): d \tilde{f}_{x}=d \varphi d f_{x}=-\frac{1}{2} f(x)^{-1} d f_{x}$. Analogous we have identified $S L(r) / S O(p, q)$ with $S_{y m}^{1}\left(\mathbb{R}^{r}\right)$ via $\Psi^{0}$. Let us choose $o=e S O(p, q)$ as base point and suppose that $\Psi^{0}$ is chosen to map the base point o to $I=I_{p, q}$. By construction $\Psi^{0}$ is $\mathrm{SL}(r)$-equivariant. We identify the tangent space $T_{S} \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right)$ at $S \in \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right)$ with the (ambient) vector space of symmetric trace-free matrices:

$$
\begin{equation*}
T_{S} \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right)=\operatorname{Sym}_{0}\left(\mathbb{R}^{r}\right):=\left\{A \in \operatorname{Mat}(r, \mathbb{R}) \mid A^{t}=A, \operatorname{tr} A=0\right\} \tag{5.9}
\end{equation*}
$$

For $\Psi^{0}(\tilde{S})=S$, the tangent space $T_{\tilde{S}} S^{1}(p, q)$ is canonically identified with the vector space of $S$-symmetric matrices in $\mathfrak{s l}(r)$ :

$$
\begin{equation*}
T_{\tilde{S}} S^{1}(p, q)=\operatorname{sym}_{0}(S):=\left\{A \in \mathfrak{s l}(r) \mid A^{t} S=S A .\right\} \tag{5.10}
\end{equation*}
$$

Proposition 13 The differential of $\varphi^{0}:=\left(\Psi^{0}\right)^{-1}$ at $S \in \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right)$ is given by

$$
\begin{equation*}
\operatorname{Sym}_{0}\left(\mathbb{R}^{r}\right) \ni X \mapsto-\frac{1}{2} S^{-1} X \in S^{-1} \operatorname{Sym}_{0}\left(\mathbb{R}^{r}\right)=\operatorname{sym}_{0}(S) \tag{5.11}
\end{equation*}
$$

We relate as above the differentials

$$
\begin{equation*}
d f_{x}: T_{x} M \rightarrow \operatorname{Sym}_{0}\left(\mathbb{R}^{r}\right) \tag{5.12}
\end{equation*}
$$

of a map $f: M \rightarrow \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right)$ at $x \in M$ and

$$
\begin{equation*}
d \tilde{f}_{x}: T_{x} M \rightarrow \operatorname{sym}_{0}(f(x)) \tag{5.13}
\end{equation*}
$$

of the map $\tilde{f}=\varphi \circ f: M \rightarrow S^{1}(p, q): d \tilde{f}_{x}=d \varphi d f_{x}=-\frac{1}{2} f(x)^{-1} d f_{x}$.
For a map $f: M \rightarrow G L(r)$ respectively $S L(r)$ we want to interpret the one-form $A=f^{-1} d f$ with values in $\mathfrak{g l}(r)$ repectively $\mathfrak{s l}(r)$ as a connection form on the vector bundle $E=M \times \mathbb{R}^{r}$. We note, that the definition of $A$ is the pure gauge and consequently its curvature vanishes. Thus we get:

## Proposition 14

1. Let $f: M \rightarrow G L(r)$ be a $C^{\infty}$-mapping and $A:=f^{-1} d f: T M \rightarrow \mathfrak{g l}(r)$. Then the curvature of $A$ vanishes, i.e. for $X, Y \in \Gamma(T M)$

$$
\begin{equation*}
Y\left(A_{X}\right)-X\left(A_{Y}\right)=A_{[X, Y]}+\left[A_{X}, A_{Y}\right] \tag{5.14}
\end{equation*}
$$

2. Let $f: M \rightarrow S L(r)$ be a $C^{\infty}$-mapping and $A:=f^{-1} d f: T M \rightarrow \mathfrak{s l}(r)$. Then the curvature of $A$ vanishes, i.e. for $X, Y \in \Gamma(T M)$

$$
\begin{equation*}
Y\left(A_{X}\right)-X\left(A_{Y}\right)=A_{[X, Y]}+\left[A_{X}, A_{Y}\right] . \tag{5.15}
\end{equation*}
$$

In the next proposition we give the para-pluriharmonic equations for maps from a para-complex manifold to $G L(r)$ respectively $S L(r)$ :

Proposition 15 Let $(M, \tau)$ be a para-complex manifold $f: M \rightarrow G L(r)$ or $S L(r)$ a $C^{\infty}$-map and $A$ defined as in proposition 14.
The para-pluriharmonicity of $f$ is equivalent to the equation

$$
\begin{equation*}
Y\left(A_{X}\right)+\frac{1}{2}\left[A_{Y}, A_{X}\right]-\tau Y\left(A_{\tau X}\right)-\frac{1}{2}\left[A_{\tau Y}, A_{\tau X}\right]=0 \tag{5.16}
\end{equation*}
$$

for all para-holomorphic vector fields $X, Y \in \Gamma(T M)$.
Proof: Again the para-pluriharmonicity of $f$ does not depend on the connection on $M$. Therefore we only have to regard the pulled back Levi-Civita connection $\nabla$ on $G=$ $G L(r)$ respectively $G=S L(r)$. Let $X, Y \in \Gamma(T M)$ be para-holomorphic. To find these equations we write $d f(X)$ and $d f(Y)$ that are sections in $f^{*} T G$, as linear combination of left invariant vector fields $\tilde{E}_{i j}$ along $f$, with $\tilde{E}_{i j}(g)=g E_{i j}, \forall g \in G$ and a basis $E_{i j}, i, j=1 \ldots r$ of $\mathfrak{g}=\mathfrak{g l}(r)$ or $\mathfrak{s l}(r)$.
In this notation we have

$$
d f(X)=\sum_{i, j} a_{i j} \tilde{E}_{i j} \circ f=\sum_{i j} a_{i j} f E_{i j} \text { and } d f(Y)=\sum_{i, j} b_{i j} \tilde{E}_{i j} \circ f=\sum_{i j} b_{i j} f E_{i j},
$$

with functions $a_{i j}$ and $b_{i j}$ on $M$ and further

$$
A_{X}=f^{-1} d f(X)=\sum_{i j} a_{i j} E_{i j} \text { and } A_{Y}=f^{-1} d f(Y)=\sum_{i j} b_{i j} E_{i j}
$$

With this information we compute

$$
\begin{aligned}
\left(f^{*} \nabla\right)_{Y} d f(X) & =\left(f^{*} \nabla\right)_{Y} \sum_{i, j} a_{i j} \tilde{E}_{i j} \circ f \\
& =\sum_{i j} Y\left(a_{i j}\right) \tilde{E}_{i j} \circ f+\sum_{i j} a_{i j}\left(f^{*} \nabla\right)_{Y} \tilde{E}_{i j} \circ f \\
& =\sum_{i j} Y\left(a_{i j}\right) \tilde{E}_{i j} \circ f+\sum_{i j} a_{i j} \nabla_{d f(Y)} \tilde{E}_{i j} \circ f \\
& =\sum_{i j} Y\left(a_{i j}\right) f E_{i j}+\sum_{a b i j} a_{i j} b_{a b} \underbrace{\left(\nabla_{\tilde{E}_{a b}} \tilde{E}_{i j}\right) \circ f}_{\frac{1}{2} f\left[E_{a b}, E_{i j}\right]} \\
& =f\left(Y\left(A_{X}\right)+\frac{1}{2}\left[A_{Y}, A_{X}\right]\right) .
\end{aligned}
$$

Therefore the para-pluriharmonicity is equivalent to the equation

$$
Y\left(A_{X}\right)+\frac{1}{2}\left[A_{Y}, A_{X}\right]-\tau Y\left(A_{\tau X}\right)-\frac{1}{2}\left[A_{\tau Y}, A_{\tau X}\right]=0 .
$$

## 6 Para- $t t^{*}$-geometry and para-pluriharmonic maps

In this section we are going to state and prove the main result, i.e. the correspondence between $p t t^{*}$-bundles and para-pluriharmonic maps. Like in section 5 one regards the mapping $A=f^{-1} d f$ as a map $A: T M \rightarrow \mathfrak{g l}(r)$ or $\mathfrak{s l}(r)$.

### 6.1 The simply-connected case

Theorem 3 Let $(M, \tau)$ be a simply-connected para-complex manifold.
a) Let $(E, D, S, g)$ be a metric $p t t^{*}$-bundle where $E$ has rank $r$ and $M$ dimension $n$. The representation of the metric $g$ in a $D^{\theta}$-flat frame of $E f: M \rightarrow \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ induces a para-pluriharmonic map $\tilde{f}: M \xrightarrow{f} \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right) \xrightarrow{\sim} S(p, q)$, where $S(p, q)$ carries the pseudo-Riemannian metric induced by the (biinvariant) trace-form on $G L(r)$. Moreover, for all $x \in M$ the image of $T^{1,0} M$ under the para-complex linear extension of $d L_{u}^{-1} d \tilde{f}_{x}: T_{x} M \rightarrow T_{o} S(p, q)=\operatorname{sym}(p, q)$ consists of commuting matrices, where $u \in G L(r)$ is any element such that $f(x)=u \cdot o$ and $L_{u}: S(p, q) \rightarrow S(p, q)$ is the isometry induced by the left-multiplication with $u \in G L(r)$.
Let $s^{\prime}$ be another $D^{\theta}$-flat frame. Then $s^{\prime}=s \cdot U$ for a constant matrix $U$ and the para-pluriharmonic map associated to $S^{\prime}$ is $f^{\prime}=U^{t} f U$.
b) Let $(E, D, S, g$,or) be an oriented unimodular metric ptt*-bundle where $E$ has rank $r$ and $M$ dimension $n$. The representation of the metric $g$ in a $D^{\theta}$-flat frame of $E f$ : $M \rightarrow \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right)$ induces a para-pluriharmonic map $\tilde{f}: M \xrightarrow{f} \operatorname{Sym}_{p, q}^{1}\left(\mathbb{R}^{r}\right) \xrightarrow{\sim} S^{1}(p, q)$, where $S^{1}(p, q)$ carries the pseudo-Riemannian metric induced by the (biinvariant) trace-form on $S L(r)$. Moreover, for all $x \in M$ the image of $T^{1,0} M$ under the paracomplex linear extension of $d L_{u}^{-1} d \tilde{f}_{x}: T_{x} M \rightarrow T_{o} S^{1}(p, q)=\operatorname{sym}_{0}(p, q)$ consists of commuting matrices, where $u \in S L(r)$ is any element such that $f(x)=u \cdot o$ and $L_{u}: S^{1}(p, q) \rightarrow S^{1}(p, q)$ is the isometry induced by the left-multiplication with $u \in S L(r)$.
Let $s^{\prime}$ be another $D^{\theta}$-flat frame. Then $s^{\prime}=s \cdot U$ for a constant matrix $U$ and the para-pluriharmonic map associated to $S^{\prime}$ is $f^{\prime}=U^{t} f U$.

Remark 5 (see also [CS]) Before proving the theorem we make some remarks on the condition on $d \tilde{f}$. Let $x \in M$ and $\tilde{f}(x)=u$. If $d \tilde{f}\left(T_{x}^{1,0} M\right)$ consist of commuting matrices, then $d L_{u}^{-1} d \tilde{f}\left(T_{x}^{1,0} M\right)$ is commutative, too. This follows from the fact, that

$$
d L_{u}: T_{o} S(p, q) \rightarrow T_{u o} S(p, q)=T_{\tilde{f}(x)} S(p, q)
$$

equals

$$
A d_{u}: \operatorname{sym}(p, q)=\operatorname{sym}\left(I_{p, q}\right) \rightarrow \operatorname{sym}\left(u \cdot I_{p, q}\right)=\operatorname{sym}(\tilde{f}),
$$

which preserves the Lie-bracket. An analogous remark holds for the second part of the theorem. In the sequel, we will say shortly, that the image of $d \tilde{f}_{x}$ is Abelian.

Proof: Using remark 3.1) it suffices to prove the case $\theta=0$.
a) Let $s:=\left(s_{1}, \ldots, s_{r}\right)$ be a $D^{0}$-flat frame of $E$ (i.e. $D s=-S s$ ), $f$ the matrix $g\left(s_{k}, s_{l}\right)$ and further $S^{s}$ the matrix-valued one-form representing $S$ in the frame $s$. For $X \in \Gamma(T M)$ we get:

\begin{aligned}
X(f) & =X g(s, s)=g\left(D_{X} s, s\right)+g\left(s, D_{X} s\right) \\
& =-\left(g\left(S_{X} s, s\right)+g\left(s, S_{X} s\right)\right) \\
& =-2 g\left(S_{X} s, s\right)=-2 f \cdot S^{s}(X)=-2 f \cdot S_{X}^{s} .
\end{aligned}
$$

Consequently $A_{X}=-2 S_{X}^{s}$. We now prove the para-pluriharmonicity using

\begin{align*}
d^{D} S(X, Y) & =D_{X}\left(S_{Y}\right)-D_{Y}\left(S_{X}\right)-S_{[X, Y]}=0  \tag{6.1}\\
d^{D} S_{\tau}(X, Y) & =D_{X}\left(S_{\tau Y}\right)-D_{Y}\left(S_{\tau X}\right)-S_{\tau[X, Y]}=0 \tag{6.2}
\end{align*}
$$

The equation (6.2) implies

$$
\begin{aligned}
0=d^{D} S_{\tau}(\tau X, Y) & =D_{\tau X}\left(S_{\tau Y}\right)-\underbrace{\substack{(6.1) \\
=} D_{X}\left(S_{Y}\right)-S_{[X, Y]}} \\
D_{Y}\left(S_{X}\right) & S_{\tau[\tau X, Y]} \\
& =D_{\tau X}\left(S_{\tau Y}\right)-D_{X}\left(S_{Y}\right)+S_{[X, Y]}-S_{\tau[\tau X, Y]} .
\end{aligned}
$$

In local para-holomorphic coordinate fields $X, Y$ on $M$ we get in the frame $s$

$$
\tau X\left(S_{\tau Y}^{s}\right)-X\left(S_{Y}^{s}\right)+\left[S_{X}^{s}, S_{Y}^{s}\right]-\left[S_{\tau X}^{s}, S_{\tau Y}^{s}\right]=0
$$

Now $A=-2 S^{s}$ gives equation (5.16) and hence proves the para-pluriharmonicity of $f$.
Using $A_{X}=-2 S_{X}^{s}=-2 d \tilde{f}(X)$, we find the property of the differential, as $S \wedge S$ is of type $(1,1)$ by the $t t^{*}$-equations, see proposition 7 .
The last statement is obvious.
b) In this case we can take the frame $s$ to be oriented and of volume 1 , with respect to the canonical $D^{\theta}$-parallel-metric volume $\nu$. Therefore $f$ takes values in $S y m_{p, q}^{1}\left(\mathbb{R}^{r}\right)$ and part a) shows the rest.

Theorem 4 Let $(M, \tau)$ be a simply-connected para-complex manifold and put $E=$ $M \times \mathbb{R}^{r}$.
a) Then a para-pluriharmonic map $\tilde{f}: M \rightarrow S(p, q)$ gives rise to a para-pluriharmonic map $f: M \xrightarrow{\tilde{f}} S(p, q) \underset{\sim}{\underset{f}{\rightarrow}} S_{y m}\left(\mathbb{R}^{r}\right) \subset G L(r)$.
If for all $x \in M d^{c} \tilde{f}_{x}$ takes $T^{1,0} M$ to an Abelian sub-algebra in $\operatorname{sym}(f(x)) \otimes C$ (see theorem 3), then the map $f$ induces a metric ptt*-bundle $(E, D=\partial-S, S=$ $\left.d \tilde{f}, g=<f \cdot, \cdot>_{\mathbb{R}^{r}}\right)$ on $M$ where $\partial$ is the canonical flat connection on $E$.
b) Then a para-pluriharmonic map $\tilde{f}: M \rightarrow S^{1}(p, q)$ gives rise to a para-pluriharmonic map $f: M \xrightarrow{\tilde{f}} S^{1}(p, q) \stackrel{\sim}{\rightarrow} S_{y m} m_{p, q}^{1}\left(\mathbb{R}^{r}\right) \subset S L(r)$.
If for all $x \in M d^{c} \tilde{f}_{x}$ takes $T^{1,0} M$ to an Abelian sub-algebra in $\operatorname{sym}_{0}(f(x)) \otimes C$, then the map $f$ induces an oriented unimodular metric ptt*-bundle $(E, D=\partial-S, S=$ $d \tilde{f}, g=<f \cdot, \cdot>_{\mathbb{R}^{r}}$, or $)$ on $M$ where $\partial$ is the canonical flat connection and or the canonical orientation on $E$.

Remark 6 We observe, that for para-complex curves $M=\Sigma$ the condition on the differential holds, since $T^{1,0} \Sigma$ is one-dimensional over $C$.

Proof:
Let $\tilde{f}: M \rightarrow S(p, q)$ be a para-pluriharmonic map. Then by proposition 11 we know, that $f: M \xrightarrow{\sim} \operatorname{Sym}_{p, q}(\mathbb{R}) \subset G L(r)$ is para-pluriharmonic.
Since $E=M \times \mathbb{R}^{r}$, we can regard sections of $E$ as r-tuples of $C^{\infty}(M, \mathbb{R})$-functions.
In the spirit of section 5 we regard the one form $A=-2 d \tilde{f}=f^{-1} d f$ with values in $\mathfrak{g l}(\mathfrak{r})$ respectively $\mathfrak{s l}(\mathfrak{r})$ as a connection on $E$. We remind, that the curvature of this connection vanishes (proposition 14).
a) First, we check the conditions on the metric:

Lemma 2 The connection $D$ is compatible with the metric $g$ and $S$ is symmetric with respect to $g$.

Proof: This is a direct computation with $X \in \Gamma(T M)$ and $v, w \in \Gamma(E)$ using the relations $(*) S=-\frac{1}{2} f^{-1} d f,(* *) d f_{x}: T_{x} M \rightarrow T_{f(x)} \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)=\operatorname{Sym}\left(\mathbb{R}^{r}\right)$ (compare remark 4) and $g=\langle f \cdot, \cdot\rangle_{\mathbb{R}^{r}}=\langle\cdot, f \cdot\rangle_{\mathbb{R}^{r}}$ which follows from $f: M \rightarrow$ $\operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right):$

$$
\begin{aligned}
& X(g(v, w)) \quad X\left(\langle f v, w\rangle_{\mathbb{R}^{r}}\right)=\langle X(f) v, w\rangle_{\mathbb{R}^{r}}+\left\langle f\left(\partial_{X} v\right), w\right\rangle_{\mathbb{R}^{r}}+\left\langle f v, \partial_{X} w\right\rangle_{\mathbb{R}^{r}} \\
& \stackrel{(* *)}{=} \quad \frac{1}{2}\langle X(f) v, w\rangle_{\mathbb{R}^{r}}+\frac{1}{2}\langle v, X(f) w\rangle_{\mathbb{R}^{r}}+\left\langle f\left(\partial_{X} v\right), w\right\rangle_{\mathbb{R}^{r}}+\left\langle f v, \partial_{X} w\right\rangle_{\mathbb{R}^{r}} \\
&=\quad \frac{1}{2}\left\langle f \cdot f^{-1}(X(f)) v, w\right\rangle_{\mathbb{R}^{r}}+\frac{1}{2}\left\langle v, f \cdot f^{-1}(X(f)) w\right\rangle_{\mathbb{R}^{r}} \\
&+\left\langle f \partial_{X} v, w\right\rangle_{\mathbb{R}^{r}}+\left\langle f v, \partial_{X} w\right\rangle_{\mathbb{R}^{r}} \\
& \stackrel{(*)(* *)}{=} g\left(X . v-S_{X} v, w\right)+g\left(v, X . w-S_{X} w\right)=g\left(D_{X} v, w\right)+g\left(v, D_{X} w\right) .
\end{aligned}
$$

For $x \in M d \tilde{f}_{x}$ takes by remark 4 values in $\operatorname{sym}(f(x))$. This shows that $S=d \tilde{f}$ is symmetric with respect to $g=\langle f \cdot, \cdot\rangle_{\mathbb{R}^{r}}$.

To finish the proof, we have to check the $p t t^{*}$-equations. The second $p t t^{*}$-equation

$$
\begin{equation*}
\left[S_{X}, S_{Y}\right]=-\left[S_{\tau X}, S_{\tau Y}\right] \tag{6.3}
\end{equation*}
$$

for $S$ follows from the assumption that the image of $T^{1,0} M$ under $d^{c} \tilde{f}$ is Abelian. In fact, this is equivalent to $[d \tilde{f}(\tau X), d \tilde{f}(\tau Y)]=-[d \tilde{f}(X), d \tilde{f}(Y)], \forall X, Y \in T M$.

$$
\begin{aligned}
d^{D} S(X, Y) & =\left[D_{X}, S_{Y}\right]-\left[D_{Y}, S_{X}\right]-S_{[X, Y]} \\
& =\partial_{X}\left(S_{Y}\right)-\partial_{Y}\left(S_{X}\right)-2\left[S_{X}, S_{Y}\right]-S_{[X, Y]}=0
\end{aligned}
$$

is equivalent to the vanishing of the curvature of $A=-2 S$ interpreted as a connection on $E$ (see proposition 14).
Finally one has for para-holomorphic coordinate fields $X, Y \in \Gamma(T M)$

$$
\begin{aligned}
d^{D} S_{\tau}(\tau X, Y) & =\left[D_{\tau X}, S_{\tau Y}\right]-\left[D_{Y}, S_{X}\right]=\left[\partial_{\tau X}-S_{\tau X}, S_{\tau Y}\right]-\left[\partial_{Y}-S_{Y}, S_{X}\right] \\
& =\partial_{\tau X}\left(S_{\tau Y}\right)-\partial_{Y}\left(S_{X}\right)-\left[S_{\tau X}, S_{\tau Y}\right]-\left[S_{X}, S_{Y}\right] \\
& \stackrel{(6.3)}{=} \frac{1}{2}\left(\partial_{Y}\left(A_{X}\right)-\partial_{\tau X}\left(A_{\tau Y}\right)\right) \stackrel{(5.14)}{=} \frac{1}{2}\left(\partial_{X}\left(A_{Y}\right)+\left[A_{X}, A_{Y}\right]-\partial_{\tau X}\left(A_{\tau Y}\right)\right) \\
& \stackrel{(6.3)}{=} \frac{1}{2}\left(\partial_{X}\left(A_{Y}\right)+\frac{1}{2}\left[A_{X}, A_{Y}\right]-\partial_{\tau X}\left(A_{\tau Y}\right)-\frac{1}{2}\left[A_{\tau X}, A_{\tau Y}\right]\right) \stackrel{(5.16)}{=} 0 .
\end{aligned}
$$

This shows the vanishing of the tensor $d^{D} S_{\tau}$.
It remains to show the curvature equation for $D$. We observe, that $D+S=\partial$ and is consequently flat, to find

$$
0=R_{X, Y}^{D+S}=R_{X, Y}^{D}+d^{D} S(X, Y)+\left[S_{X}, S_{Y}\right] \stackrel{d^{D} S=0}{=} R_{X, Y}^{D}+\left[S_{X}, S_{Y}\right]
$$

b) With the same proof as in part a) we get a metric $p t t^{*}$-bundle with orientation.

It remains to check the condition on the trace of $S$. This property is clear, since in this case $d \tilde{f}_{x}$ takes values in $\operatorname{sym}_{0}(f(x))$ for all $x \in M$.

In the situation of theorem 4 the two constructions are inverse in the following sense:

## Proposition 16

1. Let $(E, D, S, g)$ be a metric $p t t^{*}$-bundle over a para-complex manifold $(M, \tau)$ and let $\tilde{f}$ be the associated para-pluriharmonic map constructed to a $D^{\theta}$-flat frame s in theorem 3. Then the image of $d \tilde{f}$ is Abelian and the metric ptt*-bundle $\left(M \times \mathbb{R}^{r}, \tilde{D}=\right.$ $\partial-\tilde{S}, \tilde{S}=d \tilde{f}, \tilde{g})$ associated to $\tilde{f}$ in theorem 4 is the representation of $(E, D, S, g)$ in the frame s.
2. Given a para-pluriharmonic map $\tilde{f}$ from a para-complex manifold $(M, \tau)$ to $S(p, q)$ such that the image of $d \tilde{f}$ is Abelian, one obtains via theorem 4 a metric ptt*-bundle $\left(M \times \mathbb{R}^{r}, D, S, g\right)$.
The para-pluriharmonic map associated to this metric ptt*-bundle is conjugated to the map $\tilde{f}$ by a constant matrix in $G L(r)$.
3. Let $(E, D, S, g$, or $)$ be an oriented unimodular metric ptt*-bundle over a para-complex manifold $(M, \tau)$. Let $\tilde{f}$ be the associated para-pluriharmonic map constructed to a $D^{\theta}$-flat frame $s$ of canonical volume one in theorem 3. Then the image of $d \tilde{f}$ is Abelian and the oriented unimodular metric ptt*-bundle $\left(M \times \mathbb{R}^{r}, \tilde{D}=\partial-\tilde{S}, \tilde{S}=\right.$ $\left.d \tilde{f}, \tilde{g}, o r^{\prime}\right)$ associated to $\tilde{f}$ of theorem 4 is its representation in the frame $s$.
4. Given a para-pluriharmonic map $\tilde{f}$ from a para-complex manifold $(M, \tau)$ to $S^{1}(p, q)$ such that the image of $d \tilde{f}$ is Abelian, one obtains via theorem 4 an oriented unimodular metric ptt*-bundle $\left(M \times \mathbb{R}^{r}, D, S, g\right.$, or $)$.
The para-pluriharmonic map associated to this oriented unimodular metric ptt*bundle is conjugated to the map $\tilde{f}$ by a constant matrix in $S L(r)$.

Proof: Using again remark 3.1) we can set $\theta=0$.

1. The maps $f, \tilde{f}$ and the metric $\tilde{g}=<f \cdot, \cdot>_{\mathbb{R}^{r}}$ express the metric $g$ in the frame $s$. In the computations of theorem 3 and with theorem 4 one finds $2 \tilde{S}=-A=-f^{-1} d f=$ $2 S^{s}$. From $0=D^{0} s=D s+S s$ we obtain that the connection $D$ in the frame $s$ is just $\partial-S^{s}=\partial+\frac{A}{2}=\partial-\tilde{S}=\tilde{D}$.
2. To find the para-pluriharmonic map associated to $\left(M \times \mathbb{R}^{r}, D, S, g\right)$ we have to express the metric $g$ in a $D^{0}$-flat frame $s$. But $D^{0}=D+S=\partial-S+S=\partial$. Hence we can take $s$ as the standard-basis of $\mathbb{R}^{r}$ and we get $f$. Every other basis gives a conjugated result.
3. As part 1.
4. As part 2.

### 6.2 The general case

In this subsection we are going to transfer the results in the simply-connected case to manifolds with non-trivial fundamental group.

Definition 12 Let $p: \tilde{M} \rightarrow M$ the universal cover of a para-complex manifold $(M, \tau)$ with the pulled back para-complex structure.
Let $(E, D, S)$ be a ptt*-bundle, then we define the pulled back ptt*-bundle of $(E, D, S)$ to be given by $\left(p^{*} E, p^{*} D, p^{*} S\right)$.
Let $(E, D, S, g)$ be a metric ptt*-bundle, then we define the pulled back metric ptt*-bundle of $(E, D, S, g)$ to be given by $\left(p^{*} E, p^{*} D, p^{*} S, p^{*} g\right)$.
Finally, let $(E, D, S, g$, or $)$ be an oriented unimodular metric $p t t^{*}$-bundle, then we define the pulled back oriented unimodular metric ptt*-bundle of $(E, D, S, g$, or $)$ to be given by ( $p^{*} E, p^{*} D, p^{*} S, p^{*} g, p^{*}$ or $)$.

Remark 7 The pulled back ptt*-bundles, metric ptt*-bundles, oriented and unimodular metric ptt*-bundles are ptt*-bundles, metric ptt*-bundles, oriented and oriented unimodular metric ptt*-bundles respectively, as one easily checks. This motivates the above definition.

Theorem 5 Let $(M, \tau)$ be a para-complex manifold.
a) Let $(E, D, S, g)$ be a metric $p t t^{*}$-bundle where $E$ has rank $r$ and $M$ dimension $n$ and $\left(p^{*} E, p^{*} D, p^{*} S, p^{*} g\right)$ the corresponding pulled-back metric ptt*-bundle on the universal cover $\tilde{M}$ of $M$.
Denote $f^{*}: \tilde{M} \rightarrow S(p, q)$ the para-pluriharmonic map obtained from theorem 3 in the $p^{*} D^{\theta}$-flat frame $p^{*} s$, where s is a $D^{\theta}$-flat frame and $f: M \rightarrow S(p, q)$ the map obtained from the representation of $g$ in the frame $s$. Then $f^{*}$ is a $\pi_{1}(M)$-equivariant map (Here equivariant means by the left-action on $M$ and via the holonomy on $S(p, q)$.) and the lift $p^{*} f$ of $f$. In other words $f$ is a twisted para-pluriharmonic map.
b) Let $(E, D, S, g$,or) be an oriented unimodular metric ptt*-bundle where $E$ has rank $r$ and $M$ dimension $n$ and $\left(p^{*} E, p^{*} D, p^{*} S, p_{\sim}^{*} g, p^{*}\right.$ or) the corresponding pulled back metric ptt*-bundle on the universal cover $\tilde{M}$ of $M$.
Denote $f^{*}: \tilde{M} \rightarrow S^{1}(p, q)$ the para-pluriharmonic map obtained from theorem 3 in the $p^{*} D^{\theta}$-flat frame $p^{*} s$, where s is a $D^{\theta}$-flat frame and $f: M \rightarrow S^{1}(p, q)$ the map obtained from the representation of $g$ in the frame $s$. Then $f^{*}$ is a $\pi_{1}(M)$-equivariant map (Here equivariant means by the left-action on $M$ and via the holonomy on $S^{1}(p, q)$.) and $f^{*}$ is the lift $p^{*} f$ of $f$. In other words $f$ is a twisted para-pluriharmonic map.

Proof: The equivariance follows, since we have pulled back all structures. If $s$ is $D^{\theta}$-flat, $p^{*} s$ is $p^{*} D^{\theta}$-flat, too.
The map $f^{*}$ at $\tilde{x} \in \tilde{M}$ with $p(\tilde{x})=x$ is given by

$$
f^{*}(\tilde{x})=p^{*} g\left(p^{*} s, p^{*} s\right)(x)=g_{p(\tilde{x})}(s \circ p(\tilde{x}), s \circ p(\tilde{x}))=f(x)=f \circ p(\tilde{x})=p^{*} f(x)
$$

Theorem 6 Let $(M, \tau)$ be a para-complex manifold, $p: \tilde{M} \rightarrow M$ its universal covering with the pulled back para-complex structure, also called $\tau$. Set $E=\tilde{M} \times \mathbb{R}^{r}$.
a) Let $\tilde{f}^{*}: \tilde{M} \rightarrow S(p, q)$ be a para-pluriharmonic map, which is equivariant with respect to a representation $\rho: \pi_{1}(M) \rightarrow G L(r)$ and $f^{*}: \tilde{M} \rightarrow \operatorname{Sym}_{p, q}\left(\mathbb{R}^{r}\right)$ the corresponding map, such that for all $x \in M$ the image of $d \tilde{f}^{*}{ }_{x}$ is Abelian in $\operatorname{sym}\left(f^{*}(x)\right) \otimes C$.
Then $\tilde{f}^{*}$ induces by theorem 4 a metric ptt*-bundle $\left(E, D=\partial-S, S=d \tilde{f}^{*}, g=\right.$ $<f^{*} \cdot, \cdot>_{\mathbb{R}^{r}}$ ) on $\tilde{M}$ where $\partial$ is the canonical flat connection on $E$. This metric ptt*-bundle induces a metric ptt*-bundle ( $F, D=\partial-T, T, h$ ) on $M$, such that $\left(E, D=\partial-S, S=d \tilde{f}^{*}, g=<f^{*} \cdot, \cdot>_{\mathbb{R}^{r}}\right)$ is its pull back.
b) Let $\tilde{f}^{*}: \tilde{M} \rightarrow S^{1}(p, q)$ be a para-pluriharmonic map, which is equivariant with respect to a representation $\rho: \pi_{1}(M) \rightarrow S L(r)$ and $f^{*}: \tilde{M} \rightarrow S y m_{p, q}^{1}\left(\mathbb{R}^{r}\right)$ the corresponding map, such that for all $x \in M$ the image of $d \tilde{f}^{*}{ }_{x}$ is Abelian in $\operatorname{sym}_{0}\left(f^{*}(x)\right) \otimes C$.
Then $\tilde{f}^{*}$ induces by theorem 4 an oriented unimodular metric ptt*-bundle $(E, D=$ $\partial-S, S=d \tilde{f}^{*}, g=<f^{*} \cdot, \cdot>_{\mathbb{R}^{r}}$, or) on $\tilde{M}$ where $\partial$ is the canonical flat connection
on E. This oriented unimodular metric ptt*-bundle induces an oriented unimodular metric ptt*-bundle $(F, D=\partial-T, T, h$, or') on $M$, such that $(E, D=\partial-S, S=$ $d \tilde{f}^{*}, g=<f^{*} \cdot, \cdot>_{\mathbb{R}^{r}}$, or $)$ is its pull back.

Proof:
a) We want to regard the action of $\pi_{1}(M)$ on $E$, given by

$$
\begin{equation*}
(\gamma, m, v) \in \pi_{1}(M) \times E \mapsto(\gamma \cdot m, \rho(\gamma) v)=: \gamma \cdot(m, v) \in E \tag{6.4}
\end{equation*}
$$

which induces the action

$$
\begin{equation*}
(\gamma, m, A) \in \pi_{1}(M) \times \operatorname{End}(E) \mapsto\left(\gamma \cdot m, \rho(\gamma) A \rho(\gamma)^{-1}\right)=: \gamma \cdot(m, A) \in \operatorname{End}(E) \tag{6.5}
\end{equation*}
$$

of $\pi_{1}(M)$ on $\operatorname{End}(E)$. The quotient of $E$ by the action of $\pi_{1}(E)$ gives a vector-bundle $F \rightarrow M$ over $M$.
The equivariance of the map $\tilde{f}^{*}: \tilde{M} \rightarrow S(p, q)$ means for $m \in \tilde{M}$ :

\tilde{f}^{*}(\gamma \cdot m)=\rho(\gamma) \tilde{f}^{*}(m) \rho(\gamma)^{-1} \tag{6.6}
\end{equation*}
$$

which implies for $X \in T_{m} \tilde{M}, m \in \tilde{M}$

d \tilde{f}_{\gamma . m}^{*}(d \gamma X)=\rho(\gamma) d \tilde{f}_{m}^{*}(X) \rho(\gamma)^{-1} \tag{6.7}
\end{equation*}
$$

Equation (6.6) is the equivariance of $g$ and equation (6.7) the equivariance of $S$. Hence they descend to a metric $h$ on $F$ and an endomorphism field $T$ on $F$, which is $h$-symmetric. Since $\partial$ is $\pi_{1}(M)$-invariant, it defines connection on $F$ and since $S$ is equivariant $D=\partial-T$ defines connection on $F$ which preserves $h$. With the same argument the family $D^{\theta}=D+\cosh (\theta) T+\sinh (\theta) T_{\tau}$ defines a family of connections on $F$ which is flat. Hence $(F, D=\partial-T, T, h)$ is a $p t t^{*}$-bundle on $F$ over $M$.
b) One gets the data $(F, D=\partial-T, T, h)$ as in part a). The orientation is given by the orientation of $E=\tilde{M} \times \mathbb{R}^{r}$, since $\rho$ take values in $S L(r)$.

## 7 The para-pluriharmonic map in the special paraKähler case

### 7.1 The extrinsic description of special para-Kähler manifolds

In this section we are going to recall the extrinsic description of special para-Kähler manifolds given in [CMMS].
First we have to introduce a canonical non-degenerated exact $C$-valued two-form $\Omega$ of type $(2,0)$ on the cotangent bundle $N=T^{*} M$ of an arbitrary para-complex manifold $(M, \tau)$, which is para-holomorphic, i.e. it is a para-holomorphic section of the para-holomorphic
vector-bundle $\Lambda^{2,0} T^{*} N$. Its explicit form is given by the following consideration: We take local para-holomorphic coordinates $\left(z^{1}, \ldots, z^{n}\right)$ on an open subset $U \subset M^{n}$. Any point of $T_{p}^{*} M \cong \operatorname{Hom}\left(T_{p}^{*} M, \mathbb{R}\right) \cong \operatorname{Hom}_{C}\left(T_{p}^{*} M, C\right), p \in U$, where $\operatorname{Hom}_{C}\left(T_{p}^{*} M, C\right)$ are the homomorphisms from the para-complex vector space $\left(T_{p}^{*} M, \tau_{p}\right)$ to $C$, can be expressed as $\sum w_{i} d z_{\mid p}^{i}$. The coordinates $z^{i}$ and $w_{i}$ can be regarded as local para-holomorphic coordinates of the bundle $T^{*} M_{\mid U}$. The coordinates $w_{i}$ induce linear para-holomorphic coordinates on each fiber $T_{p}^{*} M$ for $p \in U$. In these coordinates the two form $\Omega$ is given by

$$
\Omega=\sum d z^{i} \wedge d w_{i}=-d\left(\sum w_{i} d z^{i}\right) .
$$

We observe, that $\sum w_{i} d z^{i}$ does not depend on the choice of coordinates and hence $\Omega$ does not depend on the choice of coordinates, too. The form $\Omega$ will be called the symplectic form of $T^{*} M$.
In the following, we denote by $V$ the para-holomorphic vector-space $T^{*} C^{n}=C^{2 n}$, endowed with its standard para-complex structure $\tau_{V}$, its symplectic form $\Omega$ and the para-complex conjugation ${ }^{-}: V \rightarrow V, v \mapsto \bar{v}$ with fixed point set $T^{*} \mathbb{R}^{n} \cong \mathbb{R}^{2 n}$. On this space we take a system of para-holomorphic linear coordinates $\left(z^{i}, w_{i}\right)$ which are real-valued on $T^{*} \mathbb{R}^{n}$. The algebraic data $(\Omega, \tau)$ defines a para-Hermitian scalar product on $V$ via

$$
g_{V}(v, w)=\operatorname{Re} \gamma(v, w)=\operatorname{Re}(e \Omega(v, \bar{w})), \quad \forall v, w \in V \text { with } \gamma(v, w)=e \Omega(v, \bar{w})
$$

and $\left(V, \tau_{V}, g_{V}\right)$ is a flat para-Kähler manifold, whose para-Kähler form is given by

$$
\omega_{V}(v, w):=g_{V}\left(\tau_{V} v, w\right)=\operatorname{Im}(e \Omega(v, \bar{w})), \quad \forall v, w \in V
$$

Let $(M, \tau)$ be a para-complex manifold. We call a para-holomorphic immersion $\phi: M \rightarrow$ $V$ para-Kählerian if $g=\phi^{*} g_{V}$ is non-degenerate and Lagrangian if $\phi^{*} \Omega=0$. Any paraKählerian immersion $\phi: M \rightarrow V$ induces on $M$ the structure of a para-Kähler manifold $(M, \tau, g)$ with para-Kähler form $\omega(\cdot, \cdot)=g(\tau \cdot, \cdot)=\phi^{*} \omega_{V}$. For a para-Kählerian Lagrangian immersion the para-Kähler form $\omega=g(\tau \cdot, \cdot)$ of $M$ is given by

$$
\omega=2 \sum d \tilde{x}^{i} \wedge d \tilde{y}_{i}
$$

where $\tilde{x}^{i}=\operatorname{Re}\left(\phi^{*} z^{i}\right)$ and $\tilde{y}^{i}=\operatorname{Re}\left(\phi^{*} w^{i}\right)$. Additionally, a para-Kählerian Lagrangian immersion $\phi: M \rightarrow V$ induces a canonical flat torsion-free connection $\nabla$ on $M$ which is characterized by the condition, that $\nabla\left(\operatorname{Re} \phi^{*} d f\right)=0$ for all complex affine functions $f$ on V.

With these informations we now can give the extrinsic description of para-Kähler manifolds:

Theorem $7 \quad[C M M S]$ Let $\phi: M \rightarrow V$ be a para-Kählerian immersion with induced geometric data $(\tau, g, \nabla)$. Then $(M, \tau, g, \nabla)$ is a special para-Kähler manifold. Conversely, any simply-connected special para-Kähler manifold $(M, \tau, g, \nabla)$ admits a para-Kählerian Lagrangian immersion inducing the special geometric data $(\tau, g, \nabla)$ on $M$. The paraKählerian Lagrangian immersion $\phi$ is unique up to an affine linear transformation of $V$ whose linear part belongs to the group $\operatorname{Aut}(V, \Omega, \cdot)=A u t_{\mathbb{R}}\left(V, \tau_{V}, \Omega, \cdot\right)=\operatorname{Sp}\left(\mathbb{R}^{2 n}\right)$.

### 7.2 The Gauß maps of a special para-Kähler manifold

Now we are going to introduce the Gauß maps of a special para-Kähler manifold, which are the para-complex analogue of the Gauß maps introduced in [CS].
Let $(M, \tau, g, \nabla)$ be a special para-Kähler manifold of para-complex dimension $n$. Consequently the metric $g$ has signature $(n, n)$. Let $(\tilde{M}, \tau, g, \nabla)$ be the universal cover of $M$ with the pull-back special para-Kähler structure, which we denote again by $(\tau, g, \nabla)$. According to theorem 7, there exists a (para-holomorphic) Kählerian Lagrangian immersion $\Phi: \tilde{M} \rightarrow V=C^{2 n}=T^{*} C^{n}$, which is unique up to an affine transformation of $V$ with linear part in $\operatorname{Aut}(V, \Omega, \cdot)=\operatorname{Sp}\left(\mathbb{R}^{2 n}\right)$. We consider the dual Gauß map of $\phi$

$$
L: \tilde{M} \rightarrow \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right), \quad p \mapsto L(p):=T_{\phi(p)} \tilde{M}:=d \phi_{p} T_{p} \tilde{M} \subset V
$$

into the Grassmannian $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ of para-complex Lagrangian subspaces $W \subset V$ of signature $(n, n)$, i.e. $g_{V}=\operatorname{Re} \gamma$ restricted to $W$ has signature $(n, n)$. The map $L: \tilde{M} \rightarrow$ $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ is in fact the dual of the Gauß map

$$
L^{\perp}: \tilde{M} \rightarrow \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right), \quad p \mapsto L(p)^{\perp}=\bar{L}(p) \cong L(p)^{*}
$$

With $L(p)^{\perp}$ we mean the $\gamma$-orthogonal complement of $L(p)$ and the isomorphism $L(p)^{\perp} \cong$ $L(p)^{*}$ is induced by the symplectic form $\Omega$ on $V=L(p) \oplus \bar{L}(p)$. The structure of a paracomplex manifold on $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ is introduced in the next section.

## Proposition 17

(i) The dual Gauß map $L: \tilde{M} \rightarrow G r_{0}^{n}\left(C^{2 n}\right)$ is para-holomorphic.
(ii) The Gauß map $L^{\perp}: \tilde{M} \rightarrow G r_{0}^{n}\left(C^{2 n}\right)$ is anti-para-holomorphic.

Proof: The para-holomorphicity follows from that of $\phi$ and part (ii) follows from $L^{\perp}=$ $\bar{L}: p \mapsto \bar{L}(p)$.

The Gauß maps $L$ and $L^{\perp}$ induce Gauß maps

$$
\begin{gathered}
L: M \rightarrow \Gamma \backslash \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right) \\
L^{\perp}: M \rightarrow \Gamma \backslash \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)
\end{gathered}
$$

in the quotient of the Grassmannian by the holonomy group $\Gamma \subset \operatorname{Hol}(\nabla) \subset \operatorname{Sp}\left(\mathbb{R}^{2 n}\right)$ of the flat symplectic connection $\nabla$. This yields the

## Corollary 3

(i) The dual Gauß map $L_{M}: M \rightarrow \Gamma \backslash G r_{0}^{n}\left(C^{2 n}\right)$ is para-holomorphic.
(ii) The Gauß map $L_{M}^{\perp}: M \rightarrow \Gamma \backslash G r_{0}^{n}\left(C^{2 n}\right)$ is anti-para-holomorphic.

### 7.3 Coordinates on the para-complex Lagrangian Grassmannian

In this section we shall introduce a local model of the Grassmannian $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ of paracomplex Lagrangian subspaces $W \subset V$ of signature $(n, n)$, i.e. such that $g_{V}=\operatorname{Re} \gamma$ restricted to $W$ has signature $(n, n)$.
This model is a para-complex pseudo-Riemannian analog to the Siegel upper half-space

$$
\begin{equation*}
\operatorname{Sym}^{+}\left(\mathbb{C}^{n}\right):=\left\{A \in \operatorname{Mat}(n, \mathbb{C}) \mid A^{t}=A \quad \text { and } \quad \operatorname{Im} A \quad \text { is positive definite }\right\} . \tag{7.1}
\end{equation*}
$$

The real symplectic group $\operatorname{Sp}\left(\mathbb{R}^{2 n}\right)$ acts transitively on $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ and we have the following identification: $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right) \cong \operatorname{Sp}\left(\mathbb{R}^{2 n}\right) / U^{\pi}\left(C^{n}\right)$, where $U^{\pi}\left(C^{n}\right)$ is the stabilizer of

$$
\begin{equation*}
W_{o}=\operatorname{span}_{C}\left\{\frac{\partial}{\partial z^{1}}+e \frac{\partial}{\partial w_{1}}, \ldots, \frac{\partial}{\partial z^{n}}+e \frac{\partial}{\partial w_{n}}\right\} \tag{7.2}
\end{equation*}
$$

and $U^{\pi}\left(C^{n}\right)$ is defined as the group

$$
\begin{equation*}
U^{\pi}\left(C^{n}\right)=\operatorname{Aut}\left(C^{n}, \tau_{C^{n}}, g_{C^{n}}\right)=\left\{L \in \mathrm{GL}\left(\mathbb{R}^{2 n}\right) \mid \text { s. t. } L^{*} g=g \text { and }\left[L, \tau_{C^{n}}\right]=0\right\} . \tag{7.3}
\end{equation*}
$$

Given a point $W \in \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ we claim, that $V=T^{*} C^{n}$ decomposes into the direct sum

$$
\begin{equation*}
V=W \oplus \bar{W} \tag{7.4}
\end{equation*}
$$

Let $\gamma^{W}=\gamma_{\mid W}, \omega^{W}=\left(\omega_{V}\right)_{\mid W}$ and $g^{W}=\left(g_{V}\right)_{\mid W}$. Then the non-degeneracity of $\gamma^{W}, g^{W}$ and $\omega^{W}$ are equivalent. One sees from the definition of $\gamma^{W}$ that it is non-degenerated if and only if $W \cap \bar{W}=\{0\}$. Further it is $\operatorname{dim}_{\mathbb{R}}(W)=\operatorname{dim}_{\mathbb{R}}(\bar{W})=\frac{\operatorname{dim}_{\mathbb{R}}(V)}{2}$, where the last equation follows since $W$ is Lagrangian. This proves the claim.
One computes easily $\gamma(\bar{v}, \bar{w})=-\gamma(w, v), \forall v, w \in W$. Hence $g^{\bar{W}}$ has signature $(n, n)$, since $g^{W}$ has signature ( $n, n$ ). Since $\gamma=e \Omega(\cdot, \cdot)$ and $W$ is Lagrangian, it follows that the decomposition (7.4) is $\gamma$-orthogonal. Using the isomorphism induced by the symplectic form $\Omega$ on $V=W \oplus \bar{W}$ yields an isomorphism of $W^{\perp}=\bar{W} \cong W^{*}$ where ${ }^{\perp}$ is the orthogonal complement taken with respect to $\gamma$.

We now construct para-holomorphic coordinates for the para-complex manifold $\mathrm{Gr}_{0}^{n}\left(C^{2 n}\right)$ in a Zariski open neighbourhood of a point $W_{0}$ of the Grassmannian represented by a Lagrangian subspace $W_{0} \subset V$ of signature $(n, n)$. Using the transitive action of the group $S p\left(\mathbb{R}^{2 n}\right)$ on $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ we may assume $W_{0}=W_{o}$, see (7.2). Let $U_{0} \subset \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ be the open subset consisting of $W \in \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ such that the projection

$$
\begin{equation*}
\pi_{(z)}: V=T^{*} C^{n}=C^{n} \oplus\left(C^{n}\right)^{*} \rightarrow C^{n} \tag{7.5}
\end{equation*}
$$

onto the first summand ( z -space) induces an isomorphism

$$
\begin{equation*}
\pi_{(z) \mid W}: W \stackrel{\sim}{\rightarrow} C^{n} . \tag{7.6}
\end{equation*}
$$

Observe, that $U_{0} \subset \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ is an open neighbourhood of the base point $W_{o}$. For elements $W \in U_{0}$ we can express $w_{i}$ as a function of $z=\left(z^{1}, \ldots, z^{n}\right)$. In fact,

$$
\begin{equation*}
w_{i}=\sum C_{i j} z^{j} \tag{7.7}
\end{equation*}
$$

where

$$
\begin{equation*}
C_{i j} \in \operatorname{Sym}_{n, n}\left(C^{n}\right)=\left\{A \in \operatorname{Mat}(n, C) \mid A^{t}=A \text { and } \operatorname{Im}(A) \text { has signature }(n, n)\right\} . \tag{7.8}
\end{equation*}
$$

$$
\begin{equation*}
C: U_{0} \rightarrow \operatorname{Sym}_{n, n}\left(C^{n}\right), \quad W \mapsto C(W):=\left(C_{i j}\right) \tag{7.9}
\end{equation*}
$$

is a local para-holomorphic chart for the Grassmannian $G r_{0}^{n}\left(C^{2 n}\right)$.
We now describe the dual Gauß map $L$ in local para-holomorphic coordinates of $p_{o} \in \tilde{M}$ and $L\left(p_{0}\right) \in \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$. Utilizing a transformation of $S p\left(\mathbb{R}^{2 n}\right)$, if necessary, we can assume $L\left(p_{0}\right) \in U_{0}$. We put $U:=L^{-1}\left(U_{0}\right)$. The set $U \subset \tilde{M}$ is an open neighbourhood of $p_{0}$.

Let $\phi: \tilde{M} \rightarrow T^{*} C^{n}$ be the para-Kählerian Lagrangian immersion. It defines a system of local (special) para-holomorphic coordinates

$$
\begin{equation*}
\varphi:=\pi_{(z)} \circ \phi_{\mid U}: U \xrightarrow{\sim} U^{\prime} \subset C^{n}, \quad p \mapsto\left(z^{1}(\phi(p)), \ldots, z^{n}(\phi(p))\right. \tag{7.10}
\end{equation*}
$$

and we have the following commutative diagram

$$
\begin{array}{rll}
U & \xrightarrow{L} & U_{0}  \tag{7.11}\\
\varphi \downarrow & & \downarrow C \\
U^{\prime} & \xrightarrow{L_{U}} & \operatorname{Sym}_{n, n}\left(C^{n}\right),
\end{array}
$$

where the vertical arrows are para-holomorphic diffeomorphisms and $L_{U}$ at $z=\left(z^{1}, \ldots, z^{n}\right)$ is given by

$$
\begin{equation*}
L_{U}(z)=\left(F_{i j}(z)\right):=\left(\frac{\partial^{2} F(z)}{\partial z^{i} \partial z^{j}}\right) . \tag{7.12}
\end{equation*}
$$

Here $F(z)$ is a para-holomorphic function on $U^{\prime} \subset C^{n}$, called prepotential (see [CMMS]), which is up to a constant determined by the equations

$$
\begin{equation*}
w_{j}\left((\phi(p))=\left.\frac{\partial F}{\partial z^{j}}\right|_{z(\phi(p))} .\right. \tag{7.13}
\end{equation*}
$$

Summarizing, we obtain the proposition

Proposition 19 The dual Gauß map L has the following coordinate expression

$$
\begin{equation*}
L_{U}=C \circ L \circ \varphi^{-1}=\left(F_{i j}\right), \tag{7.14}
\end{equation*}
$$

where $\varphi: U \rightarrow C^{n}$ is the (special) para-holomorphic chart of $\widetilde{M}$ associated to the paraKählerian Lagrangian immersion $\phi$, see (7.10), and $C: U_{0} \rightarrow \operatorname{Sym}_{n, n}\left(C^{n}\right)$ is the paraholomorphic chart of $G r_{0}^{n}\left(C^{2 n}\right)$ constructed in (7.9).

### 7.4 The special para-Kähler metric in an affine frame

In this section we show that the para-pluriharmonic map associated to a para-Kähler manifold coincides with the dual Gauß map.
As above, let $(M, \tau, g, \nabla)$ be a special para-Kähler manifold of dimension $n=\operatorname{dim} m_{C} M$ and $(\tilde{M}, \tau, g, \nabla)$ be its universal covering. Like in section 6 we now consider the metric $g$ in a
$\nabla$-parallel frame. Such a frame is provided by the para-Kählerian Lagrangian immersion $\phi: \tilde{M} \rightarrow V$. In fact, an arbitrary point $p \in \tilde{M}$ has a neighborhood in which the functions $\tilde{x}^{i}:=\operatorname{Re} z^{i} \circ \phi$ and $\tilde{y}_{i}:=\operatorname{Re} w_{i} \circ \phi, i=1, \ldots, n$ form a system of local $\nabla$-affine coordinates. We recall that the $\nabla$-parallel Kähler form is given by $\omega=2 \sum d \tilde{x}^{i} \wedge d \tilde{y}_{i}$. Therefore the globally defined one-forms $\sqrt{2} d \tilde{x}^{i}$ and $\sqrt{2} d \tilde{y}_{i}$ constitute a $\nabla$-parallel unimodular frame

$$
\begin{equation*}
\left(e^{a}\right)_{a=1, \ldots, 2 n}:=\left(\sqrt{2} d \tilde{x}^{1}, \ldots, \sqrt{2} d \tilde{x}^{n}, \sqrt{2} d \tilde{y}_{1}, \ldots, \sqrt{2} d \tilde{y}_{n}\right) \tag{7.15}
\end{equation*}
$$

of $T^{*} \tilde{M}$ with respect to the metric volume form $\nu=(-1)^{n+1} \omega^{n} / n!=2^{n} d \tilde{x}^{1} \wedge \ldots \wedge d \tilde{y}_{n}$. The dual frame $e_{a}$ of $T \tilde{M}$ is also $\nabla$-parallel and unimodular. The metric $g$ defines a smooth map

$$
G: \tilde{M} \rightarrow \operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)=\left\{A \in \operatorname{Mat}(2 n, \mathbb{R}) \mid A^{t}=A, \operatorname{det}(A)=(-1)^{n} \text { of signature }(n, n)\right\}
$$

by

$$
\begin{equation*}
p \mapsto G(p)=\left(g_{a b}(p)\right):=\left(g_{p}\left(e_{a}, e_{b}\right)\right) . \tag{7.16}
\end{equation*}
$$

We call $G=g_{a b}(p)$ the fundamental matrix of $\phi$. As before, we have the identification

$$
\operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)=S L(2 n, \mathbb{R}) / S O(n, n)
$$

of $\operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)$ with a pseudo-Riemannian symmetric space.
The group $S O(n, n) \subset S L(2 n, \mathbb{R})$ is the stabilizer of the symmetric matrix

\begin{equation*}
E_{0}^{n}=\operatorname{diag}\left(-\mathbb{1}_{n}, \mathbb{1}_{n}\right) \tag{7.17}
\end{equation*}
$$

The fundamental matrix induces a map

$$
G_{M}: M \rightarrow \Gamma \backslash \operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)
$$

into the quotient of $\operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)$ by the action of the holonomy group $\Gamma=\operatorname{Hol}(\nabla) \subset$ $\operatorname{Sp}\left(\mathbb{R}^{2 n}\right) \subset S L(2 n, \mathbb{R})$. The target $\Gamma \backslash \operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)$ is a pseudo-Riemannian locally symmetric space, provided that $\Gamma$ acts properly discontinuously.

Theorem $8 \quad$ The fundamental matrix $G: \tilde{M} \rightarrow \operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)=S L(2 n, \mathbb{R}) / S O(n, n)$ takes values in the totally geodesic sub-manifold

$$
i: G r_{0}^{n}\left(C^{2 n}\right)=S p\left(\mathbb{R}^{2 n}\right) / U^{\pi}\left(C^{n}\right) \hookrightarrow S L(2 n, \mathbb{R}) / S O(n, n)
$$

and coincides with the dual Gauß map $L: \tilde{M} \rightarrow G r_{0}^{n}\left(C^{2 n}\right): G=i \circ L$.

Proof: The proof follows from a geometric interpretation of the inclusion $i$. To any Lagrangian subspace $W \in \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ we associate the scalar product $g^{W}:=\operatorname{Re} \gamma_{\mid W}$ of signature $(n, n)$ on $W \subset V$. The projection onto the real points

$$
\begin{equation*}
\operatorname{Re}: V=T^{*} C^{n} \mapsto T^{*} \mathbb{R}^{n}=\mathbb{R}^{2 n}, v \mapsto \operatorname{Re} v=\frac{1}{2}(v+\bar{v}) \tag{7.18}
\end{equation*}
$$

induces an isomorphism of real vector spaces $W \stackrel{\sim}{\rightarrow} \mathbb{R}^{2 n}$ with inverse $\psi=\psi_{W}$. We claim that

$$
\begin{equation*}
i(W)=\psi_{W}^{*} g=:\left(g_{a b}^{W}\right)=: G^{W} \tag{7.19}
\end{equation*}
$$

To check the claim, we have to show the $\operatorname{Sp}\left(\mathbb{R}^{2 n}\right)$-equivariance of

$$
\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right) \ni W \mapsto G^{W} \in \operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)
$$

and that it maps the base point $W_{o}$, see equation (7.2), to $E_{0}^{n}$ (equation (7.17)). By the definition of $\gamma$ we find for the basis

$$
\begin{equation*}
e_{j}^{ \pm}:=\frac{\partial}{\partial z^{j}} \pm e \frac{\partial}{\partial w_{j}} \tag{7.20}
\end{equation*}
$$

of $V$ that the only non-vanishing components of $\gamma$ are $\gamma\left(e_{j}^{ \pm}, e_{j}^{ \pm}\right)=\mp 2$. This shows that $g^{W_{o}}$ is represented by the matrix $2 E_{0}^{n}$ with respect to the real basis

$$
\begin{equation*}
\left(e_{1}^{+}, \ldots, e_{n}^{+}, e e_{1}^{+}, \ldots, e e_{n}^{+}\right) \tag{7.21}
\end{equation*}
$$

In order to calculate $G^{W_{o}}=\left(g_{a b}^{W_{o}}\right)=\left(g\left(\psi e_{a}, \psi e_{b}\right)\right)$, we need to pass from the real basis (7.21) to the real basis $\left(\psi e_{a}\right)$ of $W_{o}$.

Recall that the real structure is the para-complex conjugation with respect to the coordinates $\left(z^{i}, w_{i}\right)$. This implies that

$$
\begin{align*}
\psi^{-1}\left(e_{j}^{+}\right)=\frac{\partial}{\partial x^{j}}=\sqrt{2} e_{j}, & \psi^{-1}\left(e e_{j}^{+}\right)=\frac{\partial}{\partial y^{j}}=\sqrt{2} e_{n+j}, j=1, \ldots, n,  \tag{7.22}\\
\psi^{-1}\left(e_{j}^{-}\right)=\frac{\partial}{\partial x^{j}}=\sqrt{2} e_{j}, & \psi^{-1}\left(e e_{j}^{-}\right)=-\frac{\partial}{\partial y^{j}}=-\sqrt{2} e_{n+j}, j=1, \ldots, n . \tag{7.23}
\end{align*}
$$

This shows that $G^{W_{o}}=E_{0}^{n}$.
It remains to show the equivariance of $W \mapsto G^{W}=\psi^{*} g$. Using the definition of the $\operatorname{map} \psi=\psi^{W}: \mathbb{R}^{2 n} \rightarrow W$, one easily checks that, under the action of $\Lambda \in \operatorname{Sp}\left(\mathbb{R}^{2 n}\right), \psi$ transforms as

$$
\begin{equation*}
\psi_{\Lambda W}=\Lambda \circ \Psi_{W} \circ \Lambda_{\mid \mathbb{R}^{2 n}}^{-1} \tag{7.24}
\end{equation*}
$$

This implies the transformation law for $G^{W}$ :

$$
\begin{equation*}
G^{\Lambda W}=\psi_{\Lambda W}^{*} g^{\Lambda W}=\left(\Lambda^{-1}\right)^{*} \psi_{W}^{*} \Lambda^{*} g^{\Lambda W}=\left(\Lambda^{-1}\right)^{*} \psi_{W}^{*} g^{W}=\left(\Lambda^{-1}\right)^{*} G^{W}=\Lambda \cdot G^{W} \tag{7.25}
\end{equation*}
$$

The above claim (7.19) and the fact

$$
\begin{equation*}
g^{L(p)}=g_{p} \text { and } G^{L(p)}=G(p) \tag{7.26}
\end{equation*}
$$

for all $p \in \tilde{M}$ imply

$$
\begin{equation*}
i(L(p))=G^{L(p)}=G(p) \tag{7.27}
\end{equation*}
$$

Corollary 4 The fundamental matrix $G: \tilde{M} \rightarrow \operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)$ is para-pluriharmonic.
Proof: In fact, $G=i \circ L$ is the composition of a para-holomorphic map $L: \tilde{M} \rightarrow \operatorname{Gr}_{0}^{n}\left(C^{2 n}\right)$ with the totally geodesic inclusion $\operatorname{Gr}_{0}^{n}\left(C^{2 n}\right) \subset \operatorname{Sym}_{n, n}^{1}\left(\mathbb{R}^{2 n}\right)$. The composition of a paraholomorphic map with a totally geodesic one is para-pluriharmonic.
