## ABOUT A BREZIS-MERLE PROBLEM IN DIMENSION 2.

#### Abstract

On a bounded open set $\Omega$ of $\mathbb{R}^{2}$ with smooth boundary, we consider two sequences of functions $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$ such that,

\Delta u_{i}=V_{i} e^{u_{i}} \text { in } \Omega \\
u_{i}=0, \text { on } \partial \Omega
\end{array}\right.
$$

With, $0 \leq a \leq V_{i} \leq b<+\infty$.
Assume that,

& \qquad \int_{\Omega} e^{u_{i}} d x \leq C . \\
& \text { If, } a>0, \\
& \text { or, } a=0 \text { and } V_{i} \rightarrow V \text { in } C^{0}(\bar{\Omega}) .
\end{aligned}
$$

We have,

\left\|u_{i}\right\|_{L^{\infty}(\bar{\Omega})} \leq c(a, b, C, \Omega)
$$

## 1. INTRODUCTION AND RESULTS.

We set $\Delta=-\partial_{11}-\partial_{22}$ the geometric Laplacian on $\mathbb{R}^{2}$.
On an open set $\Omega$ of $\mathbb{R}^{2}$, with a smooth boundary, we consider the following problem:

\Delta u=V e^{u} \text { in } \Omega \\
u=0 \text { on } \partial \Omega
\end{array}\right.
$$

The previous equation is called, the Prescribed Scalar Curvature, in relation with conformal change of metrics. The function $V$ is the prescribed curvature.

Here, we try to find some a priori estimates for sequences of the previous problem.
Equations of the previous type were studied by many authors. We can see in [B-M], different results for the solutions of those type of equations with or without boundaries conditions and, with minimal conditions on $V$, for example we suppose $V \geq 0$ and $V \in L^{p}(\Omega)$ or $V e^{u} \in L^{p}(\Omega)$ with $p \in[1,+\infty]$.

We can see in [B-M] the two following important Theorems,
Theorem $\mathbf{A}$ (Brezis-Merle).If $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$ are two sequences of functions relatively to the problem $(P)$ with, $0 \leq V_{i} \leq b<+\infty$ and $\int_{\Omega} e^{u_{i}} d x \leq C$, then, for all compact set $K$ of $\Omega$,

$$
\sup _{K} u_{i} \leq c=c(a, b, C, K, \Omega)
$$

Theorem $\mathbf{B}$ (Brezis-Merle).If $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$ are two sequences of functions relatively to the problem $(P)$ with, $0<a \leq V_{i} \leq b<+\infty$, then, for all compact set $K$ of $\Omega$,

\sup _{K} u_{i} \leq c=c(a, b, K, \Omega) .
$$

If, we assume $V$ with more regularity, we can have another type of estimates, sup +inf. It was proved, by Shafrir, see [S], that, if $\left(u_{i}\right)_{i},\left(V_{i}\right)_{i}$ are two sequences of functions solutions of the previous equation without assumption on the boundary and, $0<a \leq V_{i} \leq b<+\infty$, then we have the following interior estimate:

C(a / b) \sup _{K} u_{i}+\inf _{\Omega} u_{i} \leq c=c(a, b, K, \Omega) .
$$

We can see in [C-L], an explicit value of $C(a / b)=\sqrt{\frac{a}{b}}$.
Now, if we suppose $\left(V_{i}\right)_{i}$ uniformly Lipschitzian with $A$ the Lipschitz constant, then, $C(a / b)=$ 1 and $c=c(a, b, A, K, \Omega)$, see Brézis-Li-Shafrir [B-L-S]. This result was extended for Hölderian sequences $\left(V_{i}\right)_{i}$ by Chen-Lin, see [C-L]. Also, we can see in [L], an extension of the Brezis-Li-Shafrir to compact Riemann surface without boundary. We can see in [L-S] explicit form, ( $8 \pi m, m \in \mathbb{N}^{*}$ exactly), for the numbers in front of the Dirac masses, when the solutions blowup.

## The questions of Brezis-Merle :

## Question 1:

In their paper Brezis-Merle, asked the following question, see $[B-M]$ :
Let us consider a sequence of functions $\left(u_{i}\right)_{i}$ solutions of the problem $(P)$ relatively to $\left(V_{i}\right)_{i}$ with,

Is it possible to have,

\left\|u_{i}\right\|_{L^{\infty}(\Omega)} \leq c^{\prime}=c^{\prime}\left(a, b, C^{\prime}, \Omega\right) ?
$$

## Question 2:

In their paper Brezis-Merle, asked the following question, see $[B-M]$ :
Let us consider a sequence of functions $\left(u_{i}\right)_{i}$ solutions of the problem $(P)$ relatively to $\left(V_{i}\right)_{i}$ with,

V_{i} \rightarrow V \in C^{0}(\bar{\Omega}) \\
\int_{\Omega} e^{u_{i}} d x \leq C^{\prime}

Is it possible to have,

\left\|u_{i}\right\|_{L^{\infty}(\Omega)} \leq c^{\prime}=c^{\prime}\left(a, b, C^{\prime}, \Omega\right) ?
$$

We can find some results which concerning this question. It was proved by Chen-Li, that if we suppose $a=0$ and $\left\|\nabla V_{i}\right\|_{L^{\infty}(\Omega)} \leq A$, then, we a have a positive answer to the question, see [C-Li].

Also, if we assume $a>0$ and $\left\|\nabla V_{i}\right\|_{L^{\infty}(\Omega)} \leq A$, the answer to the question is positive without the assumption on $e^{u_{i}}$ was given by Ma-Wei, see [M-W].

Here, we have,

Theorem 1. Let us consider three positive numbers $a, b, C$, and, two sequences of functions, $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$, relatively to the problem $(P)$ with the following conditions:

\int_{\Omega} e^{u_{i}} d x \leq C, \forall i
\end{array}\right.
$$

Then, there is a positive constant $c=c(a, b, C, \Omega)$ such that,

\left\|u_{i}\right\|_{L^{\infty}(\Omega)} \leq c
$$

Theorem 2. Let us consider two positive numbers $a, b$, and, two sequences of functions, $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$, relatively to the problem $(P)$ with the following condition:

V_{i} \rightarrow V \in C^{0}(\bar{\Omega}) \\
\int_{\Omega} e^{u_{i}} d x \leq C
\end{array}\right.

Then, there is a positive constant $c=c(a, b, C, \Omega)$ such that,

\left\|u_{i}\right\|_{L^{\infty}(\Omega)} \leq c, \quad \forall i
$$

## Proof of the Theorem 1 and 2.

## Lemma 1:

There is a subsequence $\left(u_{j}\right)_{j}$ of $\left(u_{i}\right)_{i}$ and a measurable function $u$ such that:

1) $u \geq 0$ a.e in $\Omega$.
2) $\int_{\Omega} e^{u} d x<+\infty$.
3) $u_{j} \rightarrow u$ a.e in $\Omega$.
4) $u_{j} \rightarrow u$ weakly in $W_{0}^{1, q}(\Omega)$ for all $q \in[1,2[$.
5) $u_{j} \rightarrow u$ in $L_{l o c}^{\infty}(\Omega)$.

## Proof of the Lemma 1:

We have,

$$

\Delta u_{i}=V_{i} e^{u_{i}} \text { in } \Omega, \\
u_{i}=0 \text { on } \partial \Omega
\end{array}\right.
$$

We know that,

$$
\int_{\Omega} e^{u_{i}} d x \leq C^{\prime}
$$

We can use Boccardo-Gallouet Theorem, see [B-G], to have:

$$
\left\|\nabla u_{i}\right\|_{L^{q}(\Omega)} \leq c\left(q, b, C^{\prime}, \Omega\right)
$$

We use the Rellich-Kondrachov embedding, to extract from $\left(u_{i}\right)$ a subsequence $\left(u_{t}\right)$ which converge in some $L^{r}(\Omega), r>1$ to some function $u$, we know that, we can have a weakly convergence for a subsequence $\left(u_{s}\right)$ of $\left(u_{t}\right)$. From a strong convergence of $\left(u_{s}\right)$ in $L^{r}(\Omega), r>1$, we can extract a subsequence $\left(u_{m}\right)$ which converge to $u$ almost everywhere on $\Omega$, we can see that $u \geq 0$ almost everywhere. We can use the Fatou lemma for $e^{u_{m}}$ to have $e^{u} \in L^{1}(\Omega)$.

Now, we can take a subsequence of exponent $q_{n} \rightarrow 2, q_{n}<2$ and, we use the diagonal process, to extract from $\left(u_{m}\right)$ a subsequence $\left(u_{n}\right)$ which converge to $u$ ( $\Omega$ is bounded), weakly
in $W_{0}^{1, q}(\Omega), 1 \leq q<2$, almost everywhere and in some $L^{h}$ for some $h>1$ large enough. Thus, $1), 2), 3$ ) and 4) are true.

If we use a corollary of Theorem 3 of the Brezis-Merle paper, see [B-M], we can say that ( $u_{m}$ ) is in $L_{l o c}^{\infty}(\Omega)$.

First, we consider an exhaustive sequence of compact sets of $\Omega,\left(K_{l}\right)$, we use the diagonal process, to have a subsequence $\left(u_{j}\right)$ of $\left(u_{n}\right)$ which converge in $L^{\infty}\left(K_{l}\right)$ to a function $u_{K_{l}}$ for every compact $K_{l}$, but $\left(u_{j}\right)$ converge almost everywhere to $u$ and we can conclude that $u_{K_{l}}=u$ a.e. Thus, $\left(u_{j}\right)$ converge on all compact set $K$ of $\Omega$ to $u$. Thus, 5 ) is true.

Here, we denote $D(\Omega)$ the set of smooth functions with compact support in $\Omega$. We write $\operatorname{supp}(\varphi)$ the support of $\varphi \in D(\Omega)$.

## 1) Regularity of $u$.

## Case 1: $V_{i} \rightarrow V$ in $C^{0}(\bar{\Omega})$

We write:

$$
\int_{\Omega}<\nabla u_{i} \mid \nabla \varphi>d x=\int_{\Omega} V_{i} e^{u_{i}} \varphi, \quad \forall \varphi \in D(\Omega)
$$

Because $\operatorname{supp}(\varphi) \subset \subset \Omega$, and $u_{i} \rightarrow u$ uniformly on all compact sets of $\Omega$, we have:

$$
\int_{\Omega}<\nabla u \mid \nabla \varphi>d x=\int_{\Omega} V e^{u} \varphi d x, \forall \varphi \in D(\Omega)
$$

We know that $u \in W_{0}^{1, q} \cap L^{p}(\Omega), \forall p>1$ and $\int_{\Omega} e^{u} d x<+\infty$. We can use the corollary 1 of [B-M] to have $\int_{\Omega} e^{k u} d x<+\infty$, and, by the elliptic regularity, we have $u \in C^{1}(\bar{\Omega})$.

We know that, the regularity of $\left(u_{i}\right)_{i}$ and $\left(u_{i}\right)_{i}$ imply that on each compact set, $\left(\nabla u_{i}\right)_{i}$ converge to a function, but we know that $\left(u_{i}\right)_{i}$ converge weakly to $u$ in $W_{0}^{1, q}, q>1$, by the diagonal process and the uniqueness of the weak limit, we can say that $\left(\nabla u_{i}\right)_{i}$ converge uniformly to $\nabla u$ on each compact set of $\Omega$.

Case 2: $0<a<a<V_{i}<b$
We know that $\left(V_{i}\right)$ is in $L^{\infty}(\Omega)$, we can use the *-weak topology and the (*-weakly compactness) Alaoglu-Banach Theorem to have a subsequence $\left(V_{i}\right)$ and $V \in L^{\infty}(\Omega)$ such that,

$$
\int_{\Omega} V_{i} v d x \rightarrow \int_{\Omega} V v d x, \forall v \in L^{1}(\Omega)
$$

A consequence of the previous result is that $V \geq a$ almost everywhere in $\Omega$. To see this, it is sufficient to consider the functions $v=1_{\{g \geq a\}}$ and after $v=1_{\{g \leq a\}}$. Also, we have $g \leq b$

Let $\varphi \in D(\Omega)$, we can use the corollary theorem 3 of $[\mathrm{B}-\mathrm{M}]$, to have the uniform convrgence of $\left(u_{i}\right)_{i}$ on every compact, also, we use the same arguments as in the previous case 1 , the "limit equation" is :

$$
\int_{\Omega}<\nabla u \mid \nabla \varphi>d x=\int_{\Omega} V e^{u} \varphi, \quad \forall \varphi \in D(\Omega)
$$

with $0<a \leq V \leq b$. We obtain the same results as in the previous case 1. The function $u \in C^{1}(\bar{\Omega})$.

## 2) The local convergence 1 .

Goal
In this part we want to prove that there is a finite number of point $\bar{x}_{1}, \ldots, \bar{x}_{m} \in \partial \Omega$, such that $u_{i}$ converge in $C_{l o c}^{1, \theta}\left(\bar{\Omega}-\left\{\bar{x}_{1}, \ldots, \bar{x}_{m}\right)\right.$ to $u$.

We have,

$$
\begin{equation*}
\int_{\partial \Omega} \partial_{\nu} u_{i} d \sigma \leq C \tag{*}
\end{equation*}
$$

Then, according to the Riesz Theorem ( see [R]), there is a bounded Radon measure $\mu$ such that,

$$
\int_{\partial \Omega} \partial_{\nu} u_{i} \varphi d \sigma \rightarrow \int_{\partial \Omega} \varphi d \mu, \forall \varphi \in C(\partial \Omega) .
$$

We call $x_{0}$ a non regular point for the measure $\mu$ if,

$$
\mu\left(\left\{x_{0}\right\}\right) \geq 4 \pi .
$$

According to $(*)$ there is a finite number of non regular points for $\mu$. We denote $\bar{x}_{1}, \ldots, \bar{x}_{m}$ all the non regular points.

Without loss of, we can suppose the local piece of curve around a point $x$ is an interval of type $[-a, a]$, also, we dnote $\mu_{L}$ the usual measure on $\partial \Omega$ and we can write $d \sigma=d \mu_{L}$.

Let $x_{0}$ be a regular point for $\mu$, then, $\mu\left(\left\{x_{0}\right\}\right)<4 \pi$. Consider the family of arcs $I_{\epsilon}=$ $] x_{0}-\epsilon, x_{0}+\epsilon[\epsilon \partial \Omega$, we have,

$$
1_{I_{\epsilon}}(x) \rightarrow_{\epsilon \rightarrow 0} 1_{\left\{x_{0}\right\}}(x), 1_{I_{\epsilon}} \leq 1 \text { and } \partial \Omega \text { is compact. }
$$

We can use the Lebesgue dominated convergence Theorem for $\mu$ to have:

$$
\mu\left(I_{\epsilon}\right) \rightarrow \mu\left(\left\{x_{0}\right\}\right) \text { if } \epsilon \rightarrow 0
$$

We construct cutoff function $\eta_{\epsilon} \in D(\partial \Omega)$ on $I_{\delta}, \delta=\min _{1 \leq i \neq j \leq m}\left\{d\left(\bar{x}_{i}, \bar{x}_{j}\right) / 2\right\}$ ( we can use charts), as:

\eta_{\epsilon} \equiv 1, \text { on } I_{I_{\epsilon}}, \quad 0<\epsilon<\delta / 2, \\
\eta_{\epsilon} \equiv 0, \text { outside } I_{2 \epsilon}, \\
0 \leq \eta_{\epsilon} \leq 1, \\
\left\|\nabla \eta_{\epsilon}\right\|_{L^{\infty}\left(I_{2 \epsilon}\right)} \leq \frac{C_{0}\left(\Omega, x_{0}\right)}{\epsilon} .
\end{array}\right. \\
& \eta_{\epsilon} \equiv 1 \text { on } I_{I_{\epsilon}} \text { and } \eta_{\epsilon} \equiv 0 \text { on } \partial \Omega-I_{2 \epsilon} .
\end{aligned}
$$

We extend $\eta_{\epsilon}$ to a function $\tilde{\eta}_{\epsilon}$ on $\bar{\Omega}$ as,

\Delta \tilde{\eta}_{\epsilon}=0, \text { in } \Omega \\
\tilde{\eta}_{\epsilon}=\eta_{\epsilon}, \text { on } \partial \Omega .
\end{array}\right.
$$

Key 1: We can extend $\eta_{\epsilon}$ to a function $\bar{\eta}_{\epsilon}$ explicitly, we take $\eta_{\epsilon}$ and we translate it with respect to the normal vector in $x_{o}$, after we regulise it like for $\eta_{\epsilon}$ between $\epsilon$ and $2 \epsilon$ on $[-a, a] \subset \partial \Omega$..

We know from strong maximum principal and the elliptic regularity,( because $\bar{\eta}_{\epsilon}-\tilde{\epsilon} \in C_{0}^{1}(\bar{\Omega})$ l'ensemble des fonctions $C^{1}$ nulle au bord, see [J] and [G-T] for example:

\left\|\nabla \tilde{\eta}_{\epsilon}\right\|_{L^{\infty}(\bar{\Omega})} \leq \frac{C_{1}}{\epsilon}, C_{1} \text { depends only on } \Omega \text { and } x_{0}
\end{array}\right.
$$

Those estimates are easy obtained, because we use the Key1, the functions $\bar{\eta}_{\epsilon}$ or constant in $t$, because $\bar{\eta}_{\epsilon}(t, x)=\eta_{\epsilon}(x)$ in the most important part of the new subdomain of $\bar{\Omega}$, also on the corners where we have the estimate of type $c / \epsilon, c>0$.

Now, we write:

\end{equation*}
$$

Here we want to prove that for $\epsilon>0$ small enough,

$$
\begin{equation*}
\int_{\Omega}\left|\Delta\left[\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}\right]\right| d x \leq 4 \pi-\epsilon_{0} / 2 \tag{1}
\end{equation*}
$$

where $\epsilon_{0}>0$ small enough.
Remark: To ontain our estimate, it is sufficient to choose and to redius the $I_{2 \epsilon}$. In fact we want to find $\tilde{\epsilon}>0$, and a rank $i^{\prime}=i^{\prime}\left(\epsilon^{\prime}\right) \in \mathbb{N}$ sush we have an uniform estimate for the sequence $\left(u_{i}\right)_{i}$ on a domain which the boundary in $\partial \Omega$ is $I_{\epsilon^{\prime}}$.

Here we do not search to tend $\epsilon$ to 0 to have an estimate, but only reduce it to have a local uniform estimate.

Step 1: Estimate of the integral of the first term of the right hand side of $(* *)$.
We have,

and,

\Delta \tilde{\eta}_{\epsilon}=0 \text { in } \Omega \\
\tilde{\eta}_{\epsilon}=\eta_{\epsilon}, \text { on } \partial \Omega
\end{array}\right.
$$

We use the Green formula between $\tilde{\eta}_{\epsilon}$ and $u$, we obtain,

\int_{\Omega} V e^{u} \tilde{\eta}_{\epsilon} d x=\int_{\partial \Omega} \partial_{\nu} u \eta_{\epsilon} \leq 4 \epsilon\left\|\partial_{\nu} u\right\|_{L^{\infty}}=C \epsilon \quad\left(*^{\prime}\right)
$$

We have,

$$

\Delta u_{i}=V_{i} e^{u_{i}} \text { in } \Omega \\
u_{i}=0, \text { on } \partial \Omega,
\end{array}\right.
$$

We use the Green formula between $u_{i}$ and $\eta_{\epsilon}$ to have:

\int_{\Omega} V_{i} e^{u_{i}} \tilde{\eta}_{\epsilon} d x=\int_{\partial \Omega} \partial_{\nu} u_{i} \eta_{\epsilon} d \sigma \rightarrow_{i \rightarrow+\infty} \mu\left(\eta_{\epsilon}\right) \leq \mu\left(I_{2 \epsilon}\right) \leq 4 \pi-\epsilon_{0}, \quad \epsilon_{0}>0 \quad\left(*^{\prime \prime}\right)
$$

From $\left(*^{\prime}\right)$ et $\left(*^{\prime \prime}\right)$ we have for all $\epsilon>0$ there is $i_{0}=i_{0}(\epsilon)$ such that, for $i \geq i_{0}$,

$$
\int_{\Omega}\left|\left(V_{i} e^{u_{i}}-V e^{u}\right) \tilde{\eta}_{\epsilon}\right| d x \leq 4 \pi-\epsilon_{0}+C \epsilon \quad\left(*^{\prime \prime \prime}\right)
$$

Remark: In fact, we reduce the interval $I_{\epsilon}$ and we conserve the fact that the integral is strictly smaller than $4 \pi$. The fact that $\epsilon>0$ is small for the interval is not a problem, because our goal is to find an $\epsilon$ for which the estimate of the integral in $(* *)$ is strictly smaller than $4 \pi$.

Step 2: Estimate of integral of the second term of the right hand side of $(* *)$.
Let $\Sigma_{\epsilon}=\left\{x \in \Omega, d(x, \partial \Omega)=\epsilon^{2}\right\}, \epsilon>0$. Then, for $\epsilon$ small enough, $\Sigma_{\epsilon}$ is hypersurface.
We can construct another hypersurface, more easly. We know that $\Omega$ is a regular 2-manifold with boundary, we use the definition of 2-manifolds with boundary, and, around the boundary, after using the conpactness, we can couver the boundary by a finite number of open set of charts, we work locally on open sets of $\mathbb{R}_{+}^{2}$ and we construct step by step a 2 -manifold $\Omega_{\epsilon^{2}}$ contained in $\Omega$ with a smooth boundary. (The only problem is to have regularity of the boundary between each two charts).

The measure of $\Omega-\Omega_{\epsilon^{2}}$ is $k_{2} \leq \mu_{L}\left(\Omega-\Omega_{\epsilon^{2}}\right) \leq k_{1} \epsilon^{2}$.
Remark: for the unit ball $\bar{B}(0,1)$, our new manifold is $\bar{B}\left(0,1-\epsilon^{2}\right)$.
We write,

We follow the method of the "local convergence 1", we choose other type of function $\eta_{\epsilon}$.

We know from strong maximum principal and the elliptic regularity, (because $\bar{\eta}_{\epsilon}-\tilde{\eta}_{\epsilon} \in C_{0}^{1}(\bar{\Omega})$ l'ensemble des fonctions $C^{1}$ nulle au bord, see [J] and [G-T] for example:

\Delta \tilde{\eta}_{\epsilon}=0 \text { in } \Omega \\
\tilde{\eta}_{\epsilon}=\eta_{\epsilon}, \text { on } \partial \Omega
\end{array}\right.
$$

We use the Green formula between $\tilde{\eta}_{\epsilon}$ and $u$, we obtain,

\int_{\Omega} V e^{u} \tilde{\eta}_{\epsilon} d x=\int_{\partial \Omega} \partial_{\nu} u \eta_{\epsilon} \leq 4 \epsilon\left\|\partial_{\nu} u\right\|_{L^{\infty}}=C \epsilon \quad\left(*^{\prime}\right)
$$

We have,

\Delta u_{i}=V_{i} e^{u_{i}} \text { in } \Omega \\
u_{i}=0, \text { on } \partial \Omega,
\end{array}\right.
$$

We use the Green formula between $u_{i}$ and $\eta_{\epsilon}$ to have:
$\int_{\Omega} V_{i} e^{u_{i}} \tilde{\eta}_{\epsilon} d x=\int_{\partial \Omega} \partial_{\nu} u_{i} \eta_{\epsilon} d \sigma \rightarrow_{i \rightarrow+\infty} \mu\left(\eta_{\epsilon}\right)=\int_{-3 \epsilon}^{3 \epsilon} \eta_{\epsilon}(x) d \mu=\int_{-3 \epsilon}^{3 \epsilon}\left(\partial_{\nu} u\right) \eta_{\epsilon}(x) \leq 6 \epsilon\left\|\partial_{\nu} u\right\|_{L^{\infty}} .\left(*^{\prime \prime}\right)$
From $\left(*^{\prime}\right)$ et $\left(*^{\prime \prime}\right)$ we have for all $\epsilon>0$ there is $i_{0}=i_{0}(\epsilon)$ such that, for $i \geq i_{0}$,

\int_{\Omega}\left|\left(V_{i} e^{u_{i}}-V e^{u}\right) \tilde{\eta}_{\epsilon}\right| d x \leq 4 \pi-\epsilon_{0}+C \epsilon \quad\left(*^{\prime \prime \prime}\right)

Remark: In fact, we reduce the interval $I_{\epsilon}$ and we conserve the fact that the integral is strictly smaller than $4 \pi$. The fact that $\epsilon>0$ is small for the interval is not a problem, because our goal is to find an $\epsilon$ for which the estimate of the integral in ( $* *$ ) is strictly smaller than $4 \pi$.

Step 2: Estimate of the integral of the second term of the right hand side of (8).
Let $\Sigma_{\epsilon}=\left\{x \in \Omega, d(x, \partial \Omega)=\epsilon^{2}\right\}, \epsilon>0$. Then, for $\epsilon$ small enough, $\Sigma_{\epsilon}$ is hypersurface.
We can construct another hypersurface, more easly. We know that $\Omega$ is a regular 2-manifold with boundary, we use the definition of 2-manifolds with boundary, and, around the boundary, after using the conpactness, we can couver the boundary by a finite number of open set of charts, we work locally on open sets of $\mathbb{R}_{+}^{2}$ and we construct step by step a 2 -manifold $\Omega_{\epsilon}$ contained in $\Omega$ with a smooth boundary. (The only problem is to have regularity of the boundary between each two charts).

The measure of $\Omega-\Omega_{\epsilon^{2}}$ is $\mu_{L}\left(\Omega-\Omega_{\epsilon}\right) \leq k_{1} \epsilon^{\gamma}$.
Key 3: The choice of $\gamma$ is linked to $\beta$, we choose it later where apear $\mu_{L}\left(\Omega-\Omega_{\epsilon}\right)$ and $\epsilon^{-\beta}$.
We write,
$\int_{\Omega}\left|<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\left|d x=\int_{\Omega_{\epsilon^{\prime}}}\right|<\nabla\left(u_{i}-u\right)\left|\nabla \tilde{\eta}_{\epsilon}>\left|d x+\int_{\Omega-\Omega_{\epsilon^{\prime}}}<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\right| d x$.
Step 2.1: Estimate of $\int_{\Omega-\Omega_{\epsilon^{2}}}\left|<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\mid d x$.
First, we know from the elliptic estimates that $\left\|\nabla \tilde{\eta}_{\epsilon}\right\|_{L^{5 / 2}} \leq C_{1} / \epsilon^{\beta}, C_{1}$ depends on $\Omega$
We know that $\left(\left|\nabla u_{i}\right|^{5 / 3}\right)_{i}$ is bounded in $L^{3 / 2}, 1<3 / 2<2$, we can extract from this sequence a subsequence which converge weakly to $h \in L^{q}$. But, we know that we have locally the uniform convergence to $|\nabla u|$, then, $h=|\nabla u|^{5 / 3}$ a.e.

If we take $f=1_{\Omega-\Omega_{e_{2}}}$, we have:
for $\epsilon>0 \exists i_{1}=i_{1}(\epsilon) \in \mathbb{N}, \quad i \geq i_{1} \int_{\Omega-\Omega_{\epsilon}}\left|\nabla u_{i}\right|^{5 / 3} \leq \int_{\Omega-\Omega_{\epsilon}}|\nabla u|^{5 / 3}+\epsilon^{\gamma} \leq\left(1+\|\nabla u\|_{L^{\infty}}^{5 / 3}\right) \epsilon^{\gamma}$.
If we use the Hölder inequality we have,

\int_{\Omega-\Omega_{\epsilon^{2}}}\left|<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\mid d x \leq\left\|\nabla \tilde{\eta}_{\epsilon}\right\|_{L^{5 / 2}} \times\left[\int_{\Omega-\Omega_{\epsilon}}\left(\left|\nabla u_{i}\right|+|\nabla u|\right)^{5 / 3} d x\right]^{3 / 5} \leq
$$

The Minkowski give,
$\int_{\Omega-\Omega_{\epsilon^{2}}}\left|<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\mid d x \leq C_{2} \epsilon^{-\beta}\left[\left(\int_{\Omega-\Omega_{\epsilon}}\left(\left|\nabla u_{i}\right|^{5 / 3}\right)^{3 / 5}+\left(\int_{\Omega-\Omega_{\epsilon}}|\nabla u|\right)^{5 / 3} d x\right)^{3 / 5}\right]$
Thus,

$$
\int_{\Omega-\Omega_{\epsilon^{2}}}\left|<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\mid d x \leq C_{3} \epsilon^{5 / 3 \gamma-\beta}
$$

We know that, $\Omega_{\epsilon} \subset \subset \Omega$, and $u_{i} \rightarrow u$ in $C^{1}\left(\Omega_{\epsilon_{2}}\right)$
We have,

\left\|\nabla\left(u_{i}-u\right)\right\|_{L^{\infty}\left(\Omega_{\epsilon_{2}}\right)} \| \leq \epsilon_{\beta+1}, \text { for } i \geq i_{3}=i_{3}(\epsilon)
$$

\int_{\Omega_{\epsilon_{2}}}\left|<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\mid d x \leq\left\|<\nabla\left(u_{i}-u\right)\right\|_{L^{\infty}\left(\Omega_{\epsilon_{2}}\right)}\left\|\nabla \tilde{\eta}_{\epsilon}\right\|_{L^{\infty}} \leq C_{1} \epsilon \text { for } i \geq i_{3}
$$

For $\epsilon>0$, we have for $i \in \mathbb{N}, i \geq \max \left\{i_{1}, i_{2}, i_{3}\right\}$,

\int_{\Omega}\left|<\nabla\left(u_{i}-u\right)\right| \nabla \tilde{\eta}_{\epsilon}>\mid d x \leq \epsilon C_{1}\left(2 k_{1}| | \nabla u \|_{L^{\infty}}+2\right) \quad\left(*^{\prime \prime \prime \prime}\right)
$$

From $\left(*^{\prime \prime \prime}\right)$ and $\left(*^{\prime \prime \prime \prime}\right)$, we have, for $\epsilon>0$, there is $i_{3}=i_{3}(\epsilon) \in \mathbb{N}, i_{3}=\max \left\{i_{0}, i_{1}, i_{2}\right\}$ such that,

& \int_{\Omega}\left|\Delta\left[\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}\right]\right| d x \leq 4 \pi-\epsilon_{0}+\epsilon 2 C_{1}\left(2 k_{1}| | \nabla u \|_{L^{\infty}}+2+C\right)  \tag{*}\\
& \quad \leq \epsilon C_{1}\left(k_{1}| | \nabla u \|_{L^{\infty}}+1\right)+C_{1} \int_{\Omega-\Omega_{\epsilon^{2}}}|\nabla u| \leq \epsilon C_{1}\left(2 k_{1}\|\nabla u\|_{L^{\infty}}+1\right)
\end{align*}

Finaly, we have,

The constant $C_{1}$ do not depend on $\epsilon$ but on $\Omega$, in its definition.
For $\epsilon>0$, we have for $i \in \mathbb{N}, i \geq \max \left\{i_{1}, i_{2}\right\}$,

From $\left(*^{\prime \prime \prime}\right)$ and $\left(*^{\prime \prime \prime \prime}\right)$, we have, for $\epsilon>0$, there is $i_{3}=i_{3}(\epsilon) \in \mathbb{N}, i_{3}=\max \left\{i_{0}, i_{1}, i_{2}\right\}$ such that,

\int_{\Omega}\left|\Delta\left[\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}\right]\right| d x \leq 4 \pi-\epsilon_{0}+\epsilon 2 C_{1}\left(2 k_{1}\|\nabla u\|_{L^{\infty}}+2+C\right) \tag{*}
\end{equation*}
$$

We choose $\epsilon>0$ small enough, we have (1).
We have:

\Delta\left[\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}\right]=g_{i, \epsilon} \text { in } \Omega \\
\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}=0 \text { on } \partial \Omega
\end{array}\right.
$$

With $\left\|g_{i, \epsilon}\right\|_{L^{1}(\Omega)} \leq 4 \pi-\epsilon_{0}$.
We can use the theorem 1 of $[\mathrm{B}-\mathrm{M}]$ to conclude that there is $q>1$ such that:

\int_{V_{\epsilon}\left(x_{0}\right)} e^{q\left(u_{i}-u\right) \eta_{\epsilon}} d x \leq \int_{\Omega} e^{q\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}} d x \leq C(\epsilon, \Omega)
$$

where, $V_{\epsilon}\left(x_{0}\right)=B\left(x_{0}, \epsilon\right) \cap \Omega$ is a neighberhood of $x_{0}$ in $\bar{\Omega}$.
We have,

\int_{B\left(x_{0}, \epsilon_{x_{0}}\right)} e^{q_{x_{0}}\left(u_{i}-u\right) \eta_{\epsilon} \epsilon} d x \leq C, \quad \forall i .
$$

Now, we consider a function $\eta \in C^{\infty}\left(\mathbb{R}^{2}\right)$ such that:

\Delta\left(u_{i} \eta\right)=V_{i} e^{u_{i}} \eta-2<\nabla u_{i} \mid \nabla \eta>+u_{i} \Delta \eta .
$$

It is easy to see that the right hand side of the previous equation is uniformly in $L^{q_{1}}(\Omega)$ for $q_{1}=\inf q_{x_{0}}$, 2. Thus, we can use the elliptic estimates to have $\left(u_{i} \eta_{\epsilon}\right)_{i}$ uniformly bounded in $W^{2, q_{1}}(\Omega)$ and by the Sobolev embedding, we have $\left(u_{i} \eta_{\epsilon}\right)_{i}$ uniformly bounded in $C^{1}(\bar{\Omega})$, and if we repit the previous procedure, we can say that $\left(u_{i} \eta_{\epsilon}\right)_{i}$ is uniformly bounded in $C^{1, \theta}(\bar{\Omega})$ for some $\theta \in] 0,1[$.

Finaly, we have, for some $\epsilon>0$ small enough,

$$
\left\|u_{i} \eta_{\epsilon}\right\|_{C^{1, \theta}\left[B\left(x_{0}, \epsilon\right)\right]} \leq c_{3} \forall i .
$$

We know that, because $u_{i}=0$ on $\partial \Omega$ and $\Delta u_{i} \geq 0$ :

\max _{\Omega} u_{i}=u_{i}\left(x_{i}\right), \quad x_{i} \in \Omega .
$$

Without loss of generality can assume that $x_{i} \rightarrow \bar{x}_{1}$.
We take the convention $x_{0}=0$. We have:

With $\left\|g_{i, \epsilon}\right\|_{L^{1}(\Omega)} \leq 4 \pi-\epsilon_{0}$.
We can use the theorem 1 of $[\mathrm{B}-\mathrm{M}]$ to conclude that there is $q>1$ such that:

\int_{V_{\epsilon}\left(x_{0}\right)} e^{q\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}} d x \leq \int_{\Omega} e^{q\left(u_{i}-u\right) \tilde{\eta}_{\epsilon}} d x \leq C(\epsilon, \Omega)
$$

where, $V_{\epsilon}\left(x_{0}\right)$ is a neighberhooh of $x_{0}$ in $\bar{\Omega}$.
There is $\epsilon_{x_{0}}>0, q_{x_{0}}>1$ such that:

\int_{B\left(x_{0}, \epsilon_{x_{0}}\right)} e^{q_{x_{0}} u_{i} \eta_{\epsilon}} d x \leq C, \quad \forall i .

Now, we consider a cutoff function $\eta \in C_{0}^{\infty}\left(\mathbb{R}^{2}\right)$ (smooth functions with compact support) such that:

It is easy to see that the right hand side of the previous equation is uniformly in $L^{q_{1}}(\Omega)$ for $q_{1}=\inf \left\{q_{x_{0}}, 2\right\}$. Thus, we can use the elliptic estimates to have $\left(u_{i} \eta\right)_{i}$ uniformly bounded in $W^{2, q_{1}}(\Omega)$ and by the Sobolev embedding, we have $\left(u_{i} \eta\right)_{i}$ uniformly bounded in $C^{1}(\bar{\Omega})$, and if we repit the previous procedure, we can say that $\left(u_{i} \eta\right)_{i}$ is uniformly bounded in $C^{1, \theta}(\bar{\Omega})$ for some $\theta \in] 0,1[$.

Finaly, we have, for some $\epsilon>0$ small enough,

\left\|u_{i} \tilde{\eta}_{\epsilon}\right\|_{C^{1, \theta}\left[\bar{B}\left(x_{0}, \epsilon\right)\right]} \leq c_{3} \forall i .

On $I_{\epsilon}=[-\epsilon, \epsilon]$, because $u_{i}=0$ on $I_{\epsilon}$,

After a subsequence, $\partial_{\nu} u_{i}$ converge weakly to $\partial_{\nu} u$, thus,

Where, $C_{c}([-\epsilon, \epsilon])$ is a set of continuous function with compact support.
But, we know,

\int_{\partial \Omega} \partial_{\nu} u_{i} \varphi d x=\int_{-\epsilon}^{\epsilon} \partial_{\nu} u_{i} \varphi d x \rightarrow \varphi d \mu
$$

Also, we know that,

d x=h d \mu,

Then,

\int_{-\epsilon}^{\epsilon}\left[\left(\partial_{\nu} u\right) h-1\right] d \mu \varphi=0 d x, \quad \forall \varphi \in C_{c}([-\epsilon, \epsilon])
$$

We conclude that,

\left(\partial_{\nu} u\right) h=1 . \mu . a . e
$$

It means thta,

$$
\mu_{1}=0 \quad \text { and } \quad \mathrm{h}(0)
$$

It is a contradiction.
