# ADAPTIVE ESTIMATION OF THE CONDITIONAL DENSITY IN PRESENCE OF CENSORING

#### Abstract

Consider an i.i.d. sample $\left(X_{i}, Y_{i}\right), i=1, \ldots, n$ of observations and denote by $\pi(x, y)$ the conditional density of $Y_{i}$ given $X_{i}=x$. We provide an adaptive nonparametric strategy to estimate $\pi$. We prove that our estimator realizes a global squared-bias/variance compromise in a context of anisotropic function classes. We prove that our procedure can be adapted to positive censored random variables $Y_{i}$ 's, i.e. when only $Z_{i}=\inf \left(Y_{i}, C_{i}\right)$ and $\delta_{i}=\mathbb{1}_{\left\{Y_{i} \leq C_{i}\right\}}$ are observed, for an i.i.d. censoring sequence $\left(C_{i}\right)_{1 \leq i \leq n}$ independent of $\left(X_{i}, Y_{i}\right)_{1 \leq i \leq n}$. Simulation experiments illustrate the method.

## 1. Introduction

Consider an i.i.d. sample $\left(X_{i}, Y_{i}\right)_{1 \leq i \leq n}$ of couples of random variables with common probability density function (pdf) $f_{(X, Y)}$. The marginal density of the $X_{i}$ 's is also denoted by $f_{X}$. Now, define the conditional density function of $Y_{i}$ given $X_{i}=x$, for all real $y$ and $x$ such that $f_{X}(x)>0$, by

$$
\pi(x, y)=\frac{f_{(X, Y)}(x, y)}{f_{X}(x)} .
$$

The aim of the paper is to provide a statistical strategy to recover $\pi$ from the observations. A Nadaraya-Watson strategy building an estimator as the ratio of an estimator of $f_{(X, Y)}$ divided by an estimator of $f_{X}$ is conceivable. But estimators resulting of such methods have the drawback of precisely involving a ratio, with a denominator which can be small. This is the reason why we provide rather a regression-type strategy based on a mean square contrast. Using tools developed for standard regression by Baraud et al. (2001), or for transition density estimation by Lacour (2007) in the Markov chain setting, we propose a simple adaptive strategy: we both build a collection of projection estimators on finite dimensional spaces and select, by penalization of the mean square contrast, the adequate space. Then we prove that the usual squared-bias/variance compromise is achieved, in a data driven way. It is worth mentioning that the projection spaces need not be the same in both $x$ and $y$-directions, and thus, it allows to estimate functions $\pi$ belonging to possibly anisotropic Besov spaces.

[^0]We consider moreover the case of positive censored variables $Y_{i}{ }^{\prime}$ 's, which is often encountered when survival times are under study. Let $\left(C_{i}\right)_{1 \leq i \leq n}$ be an i.i.d. sequence of positive censoring variables, with cumulative distribution function (cdf) $G$, independent of $\left(X_{i}, Y_{i}\right)_{1 \leq i \leq n}$. In this context, the observations are

\left(X_{i}, Z_{i}, \delta_{i}\right)_{1 \leq i \leq n}, \quad Z_{i}=\inf \left(Y_{i}, C_{i}\right), \delta_{i}=\mathbb{1}_{\left\{Y_{i} \leq C_{i}\right\}}
$$

Then, we can provide both modified contrast and penalty following the transformation device proposed by Fan and Gijbels (1994) and also using tools for censoring correction taking advantage of Bitouzé et al. (1999)'s results as developed by Brunel and Comte (2005).

Kernel strategies involving local polynomials have been studied in the uncensored framework by De Gooijer and Zerom (2003) and Fan et al. (1996), see also Hyndman and Yao (2002), with possible dependence between the variables of a given sequence. In the context of a censored heteroscedastic regression model, Van Keilegom and Veraverbeke (2002) propose an estimation procedure to avoid the drawbacks of purely nonparametric kernel estimators. Indeed, its local building produces a bad behavior whenever the censoring is heavy in neighborhood of $x$. All these works have the pointwise feature of kernel estimators when we are in position to control a global integrated risk only. However, they require regularity conditions on the functions to be estimated much more restrictive than our flexible estimation tool. Moreover, the theoretical study of bandwidth selection is often omitted and the practical bandwidth chosen by empirical considerations, whereas we have at our disposal mathematical methods to prove the good theoretical properties of our adaptive estimator.

The plan of the paper is the following. First we describe in Section 2 the assumptions and the model collection. Then the estimators in both uncensored and censored contexts are defined and discussed in Section 3. The results are stated in Section 4, illustrated via simulations and examples in Section 5 and proved in Section 6.

## 2. Model and Assumptions

2.1. Model. To sum up, we consider two different frameworks. In both cases, the ( $X_{i}, Y_{i}$ ), $i=1, \ldots n$ are independent and identically distributed couples of variables. We estimate $\pi$ on a given compact set $A=A_{1} \times A_{2}$ only. Moreover, we distinguish:

- the uncensored framework, where the variables $\left(X_{i}, Y_{i}\right), i=1 \ldots, n$ are directly observed;
- the censored framework, where the censoring variables $C_{i}$ are independent and identically distributed, with c.d.f. $G$ and the sequences $\left(X_{i}, Y_{i}\right)$ and $\left(C_{i}\right), i=$ $1 \ldots, n$ are independent. In this context, we observe either ( $X_{i}, Z_{i}, \delta_{i}$ ) where $Z_{i}=$ $Y_{i} \wedge C_{i}$ and $\delta_{i}=\mathbb{1}_{\left\{Y_{i} \leq C_{i}\right\}}$. Only positive variables $Y_{i}$ and $C_{i}, i=1 \ldots, n$ are considered.
The aim of the paper is to estimate the conditional density $\pi(x, y)$ of $Y_{i}$ given $X_{i}=x$ and to evaluate the price to pay from uncensored to censored case. Roughly speaking, what kind of additional constraint would we set to extend the results to censored data.
2.2. Assumptions on the variables. In all cases, we set the following usual assumptions
[ $\mathcal{A} 1$ ] The conditional density $\pi$ belongs to the space of bounded and square integrable functions on $A=A_{1} \times A_{2}$ denoted by $L^{\infty} \cap L^{2}(A)$
[ $\mathcal{A} 2$ ] The density $f_{X}$ verifies $\left\|f_{X}\right\|_{\infty}:=\sup _{x \in A_{1}}\left|f_{X}(x)\right|<\infty$ and there exists a positive real $f_{0}$ such that, for all $x$ in $A_{1}, f_{X}(x) \geq f_{0}$.
Moreover, in the censored case, we suppose:
$[\mathcal{A} 3]$ For all $y \in A_{2}, 1-G(y) \geq c_{G}>0$.
Note that the lower bound condition $[\mathcal{A} 3]$ is required only on the compact set $A_{2}$, which is a very mild assumption.
2.3. Assumptions on the models. In order to estimate $\pi$, we need to introduce a collection $\left\{S_{m}, m \in \mathcal{M}_{n}\right\}$ of projection spaces, that we call models. For each $m=\left(m_{1}, m_{2}\right), S_{m}$ is a space of functions with support in $A$ defined by using two spaces: $F_{m_{1}}$ and $H_{m_{2}}$ which are subspaces of $\left(L^{2} \cap L^{\infty}\right)(\mathbb{R})$ respectively spanned by two orthonormal bases $\left(\varphi_{j}^{m}\right)_{j \in J_{m}}$ with $\left|J_{m}\right|=D_{m_{1}}$ and $\left(\psi_{k}^{m}\right)_{k \in K_{m}}$ with $\left|K_{m}\right|=D_{m_{2}}$. For all $j$ and all $k$, the supports of $\varphi_{j}^{m}$ and $\psi_{k}^{m}$ are respectively included in $A_{1}$ and $A_{2}$. Here $j$ and $k$ are not necessarily integers, it can be couples of integers as in the case of a piecewise polynomial space see Section 2.4. Then, we define

$$
S_{m}=F_{m_{1}} \otimes H_{m_{2}}=\left\{t, \quad t(x, y)=\sum_{j \in J_{m}} \sum_{k \in K_{m}} a_{j, k}^{m} \varphi_{j}^{m}(x) \psi_{k}^{m}(y)\right\}
$$

The assumptions on the models are the following:
[M1 ] For all $m_{2}, D_{m_{2}} \leq n^{1 / 2}$ and $\mathcal{D}_{n}:=\max _{m \in \mathcal{M}_{n}} D_{m_{1}} \leq n^{1 / 2} / \log (n)$
[M2 ] There exist positive reals $\phi_{1}, \phi_{2}$ such that, for all $u$ in $F_{m_{1}},\|u\|_{\infty}^{2} \leq \phi_{1} D_{m_{1}} \int u^{2}$, and for all $v$ in $H_{m_{2}}, \sup _{x \in A_{2}}|v(x)|^{2} \leq \phi_{2} D_{m_{2}} \int v^{2}$. By letting $\phi_{0}=\sqrt{\phi_{1} \phi_{2}}$, that leads to

\forall t \in S_{m} \quad\|t\|_{\infty} \leq \phi_{0} \sqrt{D_{m_{1}} D_{m_{2}}}\|t\| \tag{1}
\end{equation*}
$$

where $\|t\|^{2}=\iint t^{2}(x, y) d x d y$ and $\|t\|_{\infty}=\sup _{(x, y) \in A_{1} \times A_{2}}|t(x, y)|$.
$[\mathrm{M} 3] D_{m_{1}} \leq D_{m_{1}^{\prime}} \Rightarrow F_{m_{1}} \subset F_{m_{1}^{\prime}}$ and $D_{m_{2}} \leq D_{m_{2}^{\prime}} \Rightarrow H_{m_{2}} \subset H_{m_{2}^{\prime}}$
The first assumption guarantees that $\operatorname{dim} S_{m}=D_{m_{1}} D_{m_{2}} \leq n$ where $n$ is the number of observations. The condition [M2] implies a useful link between the $L^{2}$ norm and the infinite norm. The third assumption ensures that, for $m$ and $m^{\prime}$ in $\mathcal{M}_{n}, S_{m}+S_{m^{\prime}}$ is included in a model (since $S_{m}+S_{m^{\prime}} \subset S_{m^{\prime \prime}}$ with $D_{m_{1}^{\prime \prime}}=\max \left(D_{m_{1}}, D_{m_{1}^{\prime}}\right)$ and $D_{m_{2}^{\prime \prime}}=\max \left(D_{m_{2}}, D_{m_{2}^{\prime}}\right)$ ). We denote by $\mathcal{S}$ the space with maximal dimension among the $\left(S_{m}\right)_{m \in \mathcal{M}_{n}}$. Thus for all $m$ in $\mathcal{M}_{n}, S_{m} \subset \mathcal{S}$.
[M4 ] Nested model collection: $m_{1}=m_{2}, H_{m_{1}}=F_{m_{1}}$ (i.e. $S_{m}=F_{m_{1}} \otimes F_{m_{1}}$ ) and $\mathcal{D}_{n}:=\max _{m \in \mathcal{M}_{n}} D_{m_{1}}=\max _{m \in \mathcal{M}_{n}} D_{m_{2}} \leq n^{1 / 4}$.
This assumption is useful, even if a little restrictive, to deal with censored data.
2.4. Examples of models. We show here that Assumptions [M1]-[M3] are not too restrictive. Indeed, they are verified for the spaces $F_{m_{1}}$ (and $H_{m_{2}}$ ) spanned by the following bases (see Barron et al. (1999)):

- Trigonometric basis: for $A_{1}=[0,1], \operatorname{span}\left(\varphi_{0}, \ldots, \varphi_{m_{1}-1}\right)$ with $\varphi_{0}=\mathbb{1}_{[0,1]}, \varphi_{2 j}(x)=$ $\sqrt{2} \cos (2 \pi j x) \mathbb{1}_{[0,1]}(x), \varphi_{2 j-1}(x)=\sqrt{2} \sin (2 \pi j x) \mathbb{1}_{[0,1]}(x)$ for $j \geq 1$. For this model $D_{m_{1}}=m_{1}$ and $\phi_{1}=2$ hold.
- Histogram basis: for $A_{1}=[0,1], \operatorname{span}\left(\varphi_{1}, \ldots, \varphi_{2^{m_{1}}}\right)$ with $\varphi_{j}=2^{m_{1} / 2} \mathbb{1}_{\left[(j-1) / 2^{m_{1}}, j / 2^{m_{1}}\right.}[$ for $j=1, \ldots, 2^{m_{1}}$. Here $D_{m_{1}}=2^{m_{1}}, \phi_{1}=1$.
- Regular piecewise polynomial basis: for $A_{1}=[0,1]$, polynomials of degree $0, \ldots, r$ (where $r$ is fixed) on each interval $\left[(l-1) / 2^{D}, l / 2^{D}\left[, l=1, \ldots, 2^{D}\right.\right.$. In this case, $m_{1}=(D, r), J_{m}=\left\{j=(l, d), 1 \leq l \leq 2^{D}, 0 \leq d \leq r\right\}, D_{m_{1}}=(r+1) 2^{D}$. We can put $\phi_{1}=\sqrt{r+1}$.
- Regular wavelet basis: $\operatorname{span}\left(\Psi_{l k}, l=-1, \ldots, m_{1}, k \in \Lambda(l)\right)$ where $\Psi_{-1, k}$ points out the translates of the father wavelet and $\Psi_{l k}(x)=2^{l / 2} \Psi\left(2^{l} x-k\right)$ where $\Psi$ is the mother wavelet. We assume that the support of the wavelets is included in $A_{1}$ and that $\Psi_{-1}$ belongs to the Sobolev space $W_{2}^{r}$.


## 3. Estimation procedure

3.1. Definition of the contrast. If no censoring occurs, the $Y_{i}$ 's are observed and we can choose the following contrast

$$
\begin{equation*}
\gamma_{n}^{0}(t)=\frac{1}{n} \sum_{i=1}^{n}\left[\int_{\mathbb{R}} t^{2}\left(X_{i}, y\right) d y-2 t\left(X_{i}, Y_{i}\right)\right] . \tag{2}
\end{equation*}
$$

In fact, it is easy to explain the contrast since

$$
\mathbb{E} \gamma_{n}^{0}(t)=\mathbb{E}\left[\int t^{2}\left(X_{1}, y\right) d y\right]-2 \mathbb{E}\left(t\left(X_{1}, Y_{1}\right)\right)=\|t-\pi\|_{f}^{2}-\|\pi\|_{f}^{2}
$$

where

$$
\|t\|_{f}^{2}=\iint t^{2}(x, y) f(x) d x d y
$$

Therefore $\gamma_{n}(t)$ is the empirical counterpart of $\|t-\pi\|_{f}^{2}-\|\pi\|_{f}^{2}$ and its minimization comes down to minimize $\|t-\pi\|_{f}$. This contrast is new and its originality actually stands in the links with the regression-type contrasts, as we will see in the next subsection.

Now, let us take into account the fact that the $Y_{i}$ 's may be censored. We use a standard transformation of the data (see Fan and Gijbels (1994)) and introduce an empirical version of the weights

where $\bar{G}=1-G$ is the survival function associated with the censoring variables, by choosing the contrast function

$$
\gamma_{n}(t)=\frac{1}{n} \sum_{i=1}^{n}\left(\int_{\mathbb{R}} t^{2}\left(X_{i}, y\right) d y-2 \hat{w}_{i} t\left(X_{i}, Z_{i}\right)\right), \hat{w}_{i}=\left\{\begin{array}{l}
1 \text { without censoring }  \tag{4}\\
\frac{\delta_{i}}{\overline{\widehat{G}}\left(Z_{i}\right)} \text { with censoring. }
\end{array}\right.
$$

Here $\hat{\bar{G}}$ is the Kaplan Meier estimator of the c.d.f of the $C_{i}$ 's, modified in the way suggested by Lo et al. (1989), and defined by

$$
\begin{equation*}
\widehat{\bar{G}}(y)=\prod_{Z_{(i)} \leq y}\left(\frac{n-i+1}{n-i+2}\right)^{1-\delta_{(i)}} \tag{5}
\end{equation*}
$$

Note that $\widehat{\bar{G}}$ is built in order to satisfy the following useful property: $\widehat{\bar{G}}(y) \geq 1 /(n+1)$, $\forall y$. Moreover, it follows from Lemma 1 in Section 6, that it is a very good estimator of $\bar{G}$ on the interval $A_{2}$ provided $A_{2} \subsetneq[0, \tau]$ where $\tau=\sup \{y, G(y)<1\}$, which condition is ensured by Assumption $[\mathcal{A} 3]$. Therefore, we define

$$
\begin{equation*}
\hat{\pi}_{m}=\arg \min _{t \in S_{m}} \gamma_{n}(t) \tag{6}
\end{equation*}
$$

in the sense explained in Section 3.2, and lastly, we set

$$
\begin{equation*}
\hat{m}=\arg \min _{m \in \mathcal{M}_{n}}\left\{\gamma_{n}\left(\hat{\pi}_{m}\right)+\operatorname{pen}(m)\right\} \tag{7}
\end{equation*}
$$

where pen is a penalty function to be specified later. Note that $\gamma_{n}^{0}(t)$ and $\gamma_{n}(t)$ coincide if no censoring happens by definition of the weights $\hat{w}_{i}$. Then we can define $\tilde{\pi}=\hat{\pi}_{\hat{m}}$ and compute the empirical mean integrated squared error $\mathbb{E}\|\pi-\tilde{\pi}\|_{n}^{2}$ where $\|\cdot\|_{n}$ is the empirical norm defined by

This norm is the natural distance in this problem and we can notice that if $t$ is deterministic with support included in $A_{1} \times \mathbb{R}$

and then the mean of this empirical norm is equivalent to the $L^{2}$ norm $\|$.$\| .$
3.2. About the definition of the estimator. We discuss now the definition of $\hat{\pi}_{m}$ given by (6). Let $t(x, y)=\sum_{j \in J_{m}} \sum_{k \in K_{m}} a_{j, k} \varphi_{j}^{m}(x) \psi_{k}^{m}(y)$ a function in $S_{m}$. Then,

\begin{equation*}
\frac{\partial \gamma_{n}(t)}{\partial a_{j_{0}, k_{0}}}=0 \Leftrightarrow \sum_{j \in J_{m}} a_{j, k_{0}} \frac{1}{n} \sum_{i=1}^{n} \varphi_{j}^{m}\left(X_{i}\right) \varphi_{j_{0}}^{m}\left(X_{i}\right)=\frac{1}{n} \sum_{i=1}^{n} \varphi_{j_{0}}^{m}\left(X_{i}\right) \hat{w}_{i} \psi_{k_{0}}^{m}\left(Z_{i}\right) \tag{9}
\end{equation*}
$$

which implies that

$$
\forall j_{0} \forall k_{0} \quad \frac{\partial \gamma_{n}(t)}{\partial a_{j_{0}, k_{0}}}=0 \Leftrightarrow G_{m} A_{m}=\Upsilon_{m}
$$

where $A_{m}$ denotes the matrix $\left(a_{j, k}\right)_{j \in J_{m}, k \in K_{m}}$,

$$
G_{m}=\left(\frac{1}{n} \sum_{i=1}^{n} \varphi_{j}^{m}\left(X_{i}\right) \varphi_{l}^{m}\left(X_{i}\right)\right)_{j, l \in J_{m}} \text { and } \Upsilon_{m}=\left(\frac{1}{n} \sum_{i=1}^{n} \varphi_{j}^{m}\left(X_{i}\right) \hat{w}_{i} \psi_{k}^{m}\left(Z_{i}\right)\right)_{j \in J_{m}, k \in K_{m}}
$$

In fact, we cannot define a unique minimizer of the contrast $\gamma_{n}(t)$, since $G_{m}$ is not necessarily invertible. For example, $G_{m}$ is not invertible if there exists $j_{0}$ in $J_{m}$ such that there is no observation in the support of $\varphi_{j_{0}}\left(G_{m}\right.$ has a null column). This phenomenon happens when localized bases (as histogram bases or piecewise polynomial bases) are used. However, the following proposition will still enable us to define an estimator:

## Proposition 1.

$$
\forall j_{0} \forall k_{0} \quad \frac{\partial \gamma_{n}(t)}{\partial a_{j_{0}, k_{0}}}=0 \Leftrightarrow \forall y \quad\left(t\left(X_{i}, y\right)\right)_{1 \leq i \leq n}=P_{\mathcal{W}}\left(\left(\sum_{k} \hat{w}_{i} \psi_{k}^{m}\left(Z_{i}\right) \psi_{k}^{m}(y)\right)_{1 \leq i \leq n}\right)
$$

where $P_{\mathcal{W}}$ denotes the orthogonal projection on $\mathcal{W}=\left\{\left(t\left(X_{i}, y\right)\right)_{1 \leq i \leq n}, t \in S_{m}\right\}$ with the euclidian scalar product $\langle.\rangle_{\mathbb{R}^{n}}$ in $\mathbb{R}^{n}$.

Thus the minimization of $\gamma_{n}(t)$ leads to a unique vector $\left(\hat{\pi}_{m}\left(X_{i}, y\right)\right)_{1 \leq i \leq n}$ defined as the projection of $\left(\sum_{k} \hat{w}_{i} \psi_{k}^{m}\left(Z_{i}\right) \psi_{k}^{m}(y)\right)_{1 \leq i \leq n}$ on $\mathcal{W}$. The associated function $\hat{\pi}_{m}(.,$.$) is$ not defined uniquely but we can choose a function $\hat{\pi}_{m}$ in $S_{m}$ whose values at ( $X_{i}, y$ ) are fixed according to Proposition 1. For the sake of simplicity, we use the notation (6). The underlying function is a theoretical tool but the estimator is actually the vector $\left(\hat{\pi}_{m}\left(X_{i}, y\right)\right)_{1 \leq i \leq n}$.

This remark leads to consider the risk defined with the empirical norm, as given by (8).
3.3. Link with classical regression. Let $\pi_{m}(x, y)$ be the orthogonal projection of $\pi$ on $F_{m_{1}} \otimes H_{m_{2}}$. Then

\pi_{m}(x, y)=\sum_{k \in K_{m}} \pi_{k}^{F_{m_{1}}}(x) \psi_{k}^{m}(y)
$$

where $\pi_{k}^{F_{m_{1}}}$ is the orthogonal projection of $\pi_{k}$ on $F_{m_{1}}$ and $\pi_{k}(x)=\mathbb{E}\left(\psi_{k}^{m}\left(Y_{1}\right) \mid X_{1}=x\right)$. Then a natural way to estimate $\pi$ is to estimate the functional coordinates $\pi_{k}^{F_{m_{1}}}(x)$, for which a set of regression equations arises by writing

\psi_{k}^{m}\left(Y_{i}\right)=\pi_{k}\left(X_{i}\right)+\varepsilon_{i, k}, \text { where } \varepsilon_{i, k}=\psi_{k}^{m}\left(Y_{i}\right)-\mathbb{E}\left(\psi_{k}^{m}\left(Y_{i}\right) \mid X_{i}\right), i=1, \ldots, n
$$

If no censoring occurs, the above equalities lead to well-known mean square contrast estimation of $\pi_{k}$ via minimization over $u \in F_{m_{1}}$ of

$$
\gamma_{n}^{(k)}(u)=\frac{1}{n} \sum_{i=1}^{n}\left[\left(\psi_{k}^{m}\left(Y_{i}\right)\right)^{2}-2 \psi_{k}^{m}\left(Y_{i}\right) u\left(X_{i}\right)\right] .
$$

Defining then

$$
\hat{\pi}_{k}^{\left(m_{1}\right)}=\arg \min _{u \in F_{m_{1}}} \gamma_{n}^{(k)}(u)
$$

we can propose as an estimator of $\pi$ : $\sum_{k \in K_{m}} \hat{\pi}_{k}^{\left(m_{1}\right)}(x) \psi_{k}^{m}(y)$. Selecting the adequate $m=\left(m_{1}, m_{2}\right)$ via a penalized criterion is not tractable with such a formula.
Noticing that for $t \in F_{m_{1}} \otimes H_{m_{2}}$,

t(x, y)=\sum_{k \in K_{m}} t_{k}(x) \psi_{k}^{m}(y) \text { where } t_{k}(x)=\int t(x, y) \psi_{k}^{m}(y) d y
$$

and

$$
\int\left(\sum_{k \in K_{m}} t_{k}\left(X_{i}\right) \psi_{k}(y)\right)^{2} d y=\sum_{k, k^{\prime}} t_{k}\left(X_{i}\right) t_{k^{\prime}}\left(X_{i}\right) \int \psi_{k}^{m}(y) \psi_{k^{\prime}}^{m}(y) d y=\sum_{k} t_{k}^{2}\left(X_{i}\right)
$$

we find a link between $\gamma_{n}^{(k)}$ and our effective general contrast $\gamma_{n}$ :

\begin{aligned}
\gamma_{n}^{0}(t) & =\frac{1}{n} \sum_{i=1}^{n}\left[\int\left(\sum_{k \in K_{m}} t_{k}\left(X_{i}\right) \psi_{k}^{m}(y)\right)^{2} d y-2 \sum_{k \in K_{m}} t_{k}\left(X_{i}\right) \psi_{k}^{m}\left(Y_{i}\right)\right] \\
& =\sum_{k \in K_{m}} \gamma_{n}^{(k)}\left(t_{k}\right)
\end{aligned}
$$

This shows how $\gamma_{n}$ globalizes the procedure and allows model selection.
The same considerations hold in the censored case by replacing $\psi_{k}^{m}\left(Y_{i}\right)$ by $W_{i, k}$ or $\hat{W}_{i, k}$ where

W_{i, k}=w_{i} \psi_{k}^{m}\left(Z_{i}\right), \quad \hat{W}_{i, k}=\hat{w}_{i} \psi_{k}^{m}\left(Z_{i}\right) \quad \text { for } i \in\{1, \ldots, n\}

The regression equation becomes:

W_{i, k}=\pi_{k}\left(X_{i}\right)+\varepsilon_{i, k}, \text { where } \varepsilon_{i, k}=w_{i} \psi_{k}\left(Y_{i}\right)-\mathbb{E}\left[w_{i} \psi_{k}\left(Y_{i}\right) \mid X_{i}\right] \tag{10}
\end{equation*}
$$

and

$$
\begin{equation*}
\hat{W}_{i, k}=W_{i, k}+R_{i, k}=\pi_{k}\left(X_{i}\right)+\varepsilon_{i, k}+R_{i, k}, \tag{11}
\end{equation*}
$$

where $R_{i, k}=\psi_{k}^{m}\left(Z_{i}\right)\left(\hat{w}_{i}-w_{i}\right)$, which is a negligible residual term. Note that the residual is null if there is no censoring.

## 4. Main results

4.1. Uncensored case. For a function $h$ and a subspace $S$, let

$$
d(h, S)=\inf _{g \in S}\|h-g\|=\inf _{g \in S}\left(\iint|h(x, y)-g(x, y)|^{2} d x d y\right)^{1 / 2}
$$

With an inequality of Talagrand (1996), we can prove the following result in the uncensored case.

Theorem 1. We consider the uncensored model described in Section 2.1 satisfying Assumptions $[\mathcal{A} 1]-[\mathcal{A} 2]$. We consider $\tilde{\pi}$ the estimator of the conditional density $\pi$ described in Section 3 with models verifying Assumptions [M1]-[M3] and the following penalty:

\operatorname{pen}(m)=K_{0}\|\pi\|_{\infty} \frac{D_{m_{1}} D_{m_{2}}}{n}, \tag{12}
\end{equation*}
$$

where $K_{0}$ is a numerical constant. Then

$$
\begin{equation*}
\mathbb{E}\left\|\pi \mathbb{1}_{A}-\tilde{\pi}\right\|_{n}^{2} \leq C \inf _{m \in \mathcal{M}_{n}}\left\{d^{2}\left(\pi \mathbb{1}_{A}, S_{m}\right)+\operatorname{pen}(m)\right\}+\frac{C^{\prime}}{n} \tag{13}
\end{equation*}
$$

where $C=\max \left(5\left\|f_{X}\right\|_{\infty}, 6\right)$ and $C^{\prime}$ is a constant depending on $\phi_{1}, \phi_{2},\|\pi\|_{\infty}, f_{0},\left\|f_{X}\right\|_{\infty}$.
The penalty (12) deserves some comments. First, the constant $K_{0}$ in the penalty is purely numerical and calibrated via simulations. On the other hand, the term $\|\pi\|_{\infty}$ is unknown. Note that, as inequality (13) holds for any penalty pen(.) such that $\operatorname{pen}(m) \geq$ $K_{0}\|\pi\|_{\infty} D_{m_{1}} D_{m_{2}} / n$, any upper bound on $\|\pi\|_{\infty}$ gives a good result. In practice, $\|\pi\|_{\infty}$ is often replaced by an estimator $\|\hat{\pi}\|_{\infty}$ where $\hat{\pi}$ is an estimator of $\pi$. From a theoretical point of view, this makes the penalty random, and the procedure can be proved to give the same result as with the penalty above under some additional regularity constraints, see Birgé and Massart (1997) or Comte (2001).

We can deduce from Theorem 1 the rate of convergence of the risk. For that purpose, assume that $\pi$ restricted to $A$ belongs to the anisotropic Besov space on $A$ with regularity $\boldsymbol{\alpha}=\left(\alpha_{1}, \alpha_{2}\right)$. Note that if $\pi$ belongs to $B_{2, \infty}^{\alpha}\left(\mathbb{R}^{2}\right)$, then $\pi$ restricted to $A$ belongs to $B_{2, \infty}^{\alpha}(A)$. Let us recall the definition of $B_{2, \infty}^{\alpha}(A)$. Let $e_{1}$ and $e_{2}$ be the canonical basis
vectors in $\mathbb{R}^{2}$ and for $i=1,2, A_{h, i}^{r}=\left\{x \in \mathbb{R}^{2} ; x, x+h e_{i}, \ldots, x+r h e_{i} \in A\right\}$. Next, for $x$ in $A_{h, i}^{r}$, let

\Delta_{h, i}^{r} g(x)=\sum_{k=0}^{r}(-1)^{r-k}\binom{r}{k} g\left(x+k h e_{i}\right)
$$

the $r$ th difference operator with step $h$. For $t>0$, the directional moduli of smoothness are given by

$$
\omega_{r_{i}, i}(g, t)=\sup _{|h| \leq t}\left(\int_{A_{h, i}^{r_{i}}}\left|\Delta_{h, i}^{r_{i}} g(x)\right|^{2} d x\right)^{1 / 2} .
$$

We say that $g$ is in the Besov space $B_{2, \infty}^{\alpha}(A)$ if $\sup _{t>0} \sum_{i=1}^{2} t^{-\alpha_{i}} \omega_{r_{i}, i}(g, t)<\infty$ for $r_{i}$ integers larger than $\alpha_{i}$.

The estimation procedure described in the uncensored case allows an adaptation of the approximation space to each directional regularity. More precisely, assume for example that $\alpha_{2}>\alpha_{1}$. Then the proof of Corollary 1 below shows that the estimator chooses a space of dimension $D_{m_{2}}=D_{m_{1}}^{\alpha_{1} / \alpha_{2}}<D_{m_{1}}$.

Corollary 1. Assume that $\pi$ restricted to $A$ belongs to the anisotropic Besov space $B_{2, \infty}^{\alpha}(A)$ with regularity $\boldsymbol{\alpha}=\left(\alpha_{1}, \alpha_{2}\right)$ such that $\alpha_{1}>1 / 2$ and $\alpha_{2}>1 / 2$. We consider the spaces described in Subsection 2.4 (with the regularity $r$ of the polynomials and the wavelets larger than $\alpha_{i}-1$ ). Then, under the assumptions of Theorem 1,

$$
\mathbb{E}\left\|\pi \mathbb{1}_{A}-\tilde{\pi}\right\|_{n}^{2}=O\left(n^{-\frac{2 \bar{\alpha}}{2 \alpha+2}}\right) .
$$

where $\bar{\alpha}$ is the harmonic mean of $\alpha_{1}$ and $\alpha_{2}$ (i.e. $2 / \bar{\alpha}=1 / \alpha_{1}+1 / \alpha_{2}$ ).
Thus we obtain the rate of convergence $n^{-\frac{2 \bar{\alpha}}{2 \bar{\alpha}+2}}$, which is optimal in the minimax sense (see Lacour (2007) for the lower bound).

Remark 1. The empirical norm is the more natural in this problem, but if we were interested in a $L^{2}$ control of the risk, we may modify the estimation procedure as follows:

with $k_{n}=n^{2 / 3}$. We may prove in this framework a result similar to Theorem 1 but bounding $\mathbb{E}\left\|\tilde{\pi}^{*}-\pi \mathbb{1}_{A}\right\|^{2}$ instead of its empirical version, see Lacour (2007).
4.2. Censored case. In the censored case, the penalty coming out under the same assumptions as previously is

$$
\begin{equation*}
\operatorname{pen}(m)=K_{0}\left(\|\pi\|_{\infty} / c_{G}\right)\left(D_{m_{1}} D_{m_{2}} / n\right), \tag{15}
\end{equation*}
$$

but $c_{G}$ is a quantity that cannot be easily estimated. Therefore, we use more restrictive assumptions to prove:

Theorem 2. We consider the censored model described in Section 2.1 satisfying Assumptions $[\mathcal{A} 1]-[\mathcal{A} 3]$. We consider $\tilde{\pi}$ the estimator of the conditional density $\pi$ described in

Section 3 with (nested) models verifying Assumptions [M2]-[M4]. We choose the following penalty:

$$
\begin{equation*}
\operatorname{pen}(m)=K_{0} \frac{\phi_{0}^{2}}{f_{0}} \mathbb{E}\left(\frac{\delta_{1}}{\bar{G}^{2}\left(Z_{1}\right)}\right) \frac{D_{m_{1}} D_{m_{2}}}{n}, \tag{16}
\end{equation*}
$$

where $K_{0}$ is a numerical constant. Then

$$
\mathbb{E}\left\|\pi \mathbb{1}_{A}-\tilde{\pi}\right\|_{n}^{2} \leq C \inf _{m \in \mathcal{M}_{n}}\left\{d^{2}\left(\pi \mathbb{1}_{A}, S_{m}\right)+\operatorname{pen}(m)\right\}+\frac{C^{\prime}}{n}
$$

where $C=\max \left(5\left\|f_{X}\right\|_{\infty}, 6\right)$ and $C^{\prime}$ is a constant depending on $\phi_{1}, \phi_{2},\|\pi\|_{\infty}, f_{0},\left\|f_{X}\right\|_{\infty}$.
Here the penalty involves two quantities that should be estimated: $f_{0}$, the lower bound of $f_{X}$ the density of the $X_{i}$ 's on the interval $A_{1}$ and the expectation $\mathbb{E}\left(\delta_{1} / \bar{G}^{2}\left(Z_{1}\right)\right)$, see Section 5 for practical implementation.

## 5. SIMULATIONS AND EXAMPLES

5.1. Simulation. We study the estimation procedure by generating samples ( $X_{i}, Y_{i}$ ) following four models:

- Example 1. Let $Y_{i}=b\left(X_{i}\right)+\varepsilon_{i}$, with $\varepsilon_{i}$ i.i.d. $\mathcal{N}(0,1), X_{i}$ i.i.d. uniform $\mathcal{U}([0,1])$, $b(x)=2 x+5$. We take $A=[0,1] \times[3,9.5]$.
- Example 2. Let $Y_{i}=b\left(X_{i}\right)+\varepsilon_{i}$, with $\varepsilon_{i}$ i.i.d. $\Gamma(4,1), X_{i}$ i.i.d. uniform $\mathcal{U}([0,1])$, $b(x)=2 x+5$. We take $A=[0,1] \times[4,15]$.
- Example 3. Let $Y_{i}=b\left(X_{i}\right)+\sigma\left(X_{i}\right) \varepsilon_{i}$, with $\varepsilon_{i}$ i.i.d. $\Gamma(4,1), X_{i}$ i.i.d. uniform $\mathcal{U}([0,1]), b(x)=2 x^{2}+5, \sigma(x)=\sqrt{1.3-|x|}$. We take $A=[0,1] \times[6,14]$.
- Example 4. Given $X_{i}=x$, let $Y_{i}$ follow the distribution $0.5 \mathcal{N}(8-4 x, 1)+0.5 \mathcal{N}(8+$ $4 x, 1)$. The $X_{i}$ 's are i.i.d. $\mathcal{U}([0,1])$. We take $A=[0,1] \times[2,14]$.
The sets $A=A_{1} \times A_{2}$ are fixed intervals, roughly calibrated with respect to each distribution. In the first three cases, the conditional density $\pi$ is given by

$$
\pi(x, y)=f_{\varepsilon}((y-b(x)) / \sigma(x)) / \sigma(x)
$$

with $b(x)=2 x+5$ (examples 1,2 ) or $b(x)=2 x^{2}+5$ (example 3) and $\sigma(x) \equiv 1$ (Examples 1 and 2) or $\sigma(x)=\sqrt{1.3-|x|}$ (Example 3). For Example 4, we have $\pi(x, y)=0.5 \exp (-(y-$ $\left.8+4 x)^{2} / 2\right) / \sqrt{2 \pi}+0.5 \exp \left(-(y-8-4 x)^{2} / 2\right) / \sqrt{2 \pi}$.

The penalty is chosen as follows:

$$
\begin{equation*}
0.5\|\hat{\pi}\|_{\infty}\left(\frac{1}{n} \sum_{i=1}^{n} \frac{\delta_{i}}{\hat{G}^{2}\left(Z_{i}\right)}\right) \frac{D_{m_{1}} D_{m_{2}}}{n} \tag{17}
\end{equation*}
$$

where $\|\hat{\pi}\|_{\infty}$ is preliminary estimated. We replace $\|\hat{\pi}\|_{\infty}$ by a bound equal to 0.4 in Examples 1, 3 and 4 and to 0.3 in Example 2. We mentioned in Section 4.1 that an upper bound on $\pi$ could suit. If the data are uncensored, we recover the empirical version of (12) with constant $K_{0}$ calibrated as 0.5 . Indeed, the term $(1 / n) \sum_{i=1}^{n} \delta_{i} / \hat{\bar{G}}^{2}\left(Z_{i}\right)$ is equal to 1 and thus vanishes. In the case of censored data, this term stands for the empirical version of $\mathbb{E}\left(\delta_{1} / \bar{G}^{2}\left(Z_{1}\right)\right)$ (see also Brunel and Comte (2005)). Then, we should follow formula (16) and estimate $f_{0}$. But, looking at (15) and for sake of robustness of the formula from uncensored to censored case, we make a compromise by keeping the factor $\|\hat{\pi}\|_{\infty}$.

We compute the empirical MISE (Mean Integrated Squared Error) over $N=500$ replications of the samples, by averaging over the paths $i=1, \ldots, N$, the quantities

$$
\frac{\ell\left(A_{1}\right) \ell\left(A_{2}\right)}{K^{2}} \sum_{k=1}^{K}\left(\tilde{\pi}^{(i)}\left(x_{k}, y_{k}\right)-\pi\left(x_{k}, y_{k}\right)\right)^{2}
$$

where $\ell\left(A_{i}\right)$ is the length of the interval $A_{i}, i=1,2,\left(x_{k}\right)_{1 \leq k \leq K},\left(y_{k}\right)_{1 \leq k \leq K}$ are subdivisions of $A_{1}$ and $A_{2}$ respectively, and $\tilde{\pi}^{(i)}$ is the estimate associated to the ith sample path. Note that we compute $\mathbb{L}^{2}$-type errors in both $x$ - and $y$-directions instead of using the empirical norm in the $x$-direction: this is to allow comparison with other methods.

When censoring occurs, the $C_{i}$ 's are generated as exponential random variables $\mathcal{E}(c)$ with parameter $c$ empirically adjusted to reach a given censoring rate ( $20 \%$ or $40 \%$ ), namely $c=6.97$ for Example 1 (40\%), $c=11.11$ for Example 2 (40\%), $c=10.25$ for Example 3 ( $40 \%$ ), $c=11.65$ for Example 4 (20\%). Figures 1 and 2 illustrate the appearance of our estimates.

We experimented our method using histogram and trigonometric bases for all our examples, see Tables 1 and 2 . We cannot pretend that one basis is much better than the others since the performances of the estimator depend on the example: sometimes, the fact that the histogram basis is localized is most useful to detect a change of modality, e.g. for Example 4; besides, the smoothness of the trigonometric basis gives better results. Example 3 checks that heteroscedasticity in the model is correctly handled, and Example 4 mimicks the real data illustration of Section 5.2 (change in modality). In all examples, censoring degrades the results. This is why only $20 \%$ of censoring is studied for example 4.

Monte Carlo experiment results are reported in Tables 1 and 2. As expected, censoring deteriorates the result, but surprisingly, even in smooth Gaussian cases, histograms seem to work very well and in particular when a change in modality occurs as in Example 4.

5.2. Example. To compare our results with De Gooijer and Zerom (2003)'s and Hyndman and Yao (2002)'s, we provide the plot of our estimation results on the Old Faithful Geyser data, available from Azzalini and Bowman (1990): these are continuously collected data of 299 observations obtained between 1 and 15 August 1985, waiting time between the
starts of successive eruptions and duration of the subsequent eruption for the infamous Old Faithful geyser in Yellowstone National Park, Wyoming, getting its name because of its punctuality and predictability. Over the years, the length of the interval has increased, which may be the result of earthquakes affecting subterranean water levels. This have made the earlier mathematical relationship between duration and interval between eruptions inaccurate. Nonparametric estimation of the conditional density of the duration time avoid this problem. The data have been transformed to be centered and with unit variance for comparison with the previous references. Our results are plotted in Figures 3 and 4. The estimate is computed using the penalty given by (17) with $\|\hat{\pi}\|_{\infty}$ estimated by 1 (see the picture to read the upper bound). We can see that our results are in accordance with previous ones: when the waiting time between eruptions is relatively short, the duration of the next eruption is long, whereas for a longer waiting time (longer than round about 70 minutes), the duration of the next eruption is a mixture of long and short durations. This results in a unimodal followed by a bimodal behavior of the conditional density of the duration of eruption given the waiting time between eruptions.

## 6. Proofs

6.1. Proof of Proposition 1. Equality (9) yields, by multiplying by $\psi_{k_{0}}^{m}(y)$,

Then, we sum over $k_{0}$ in $K_{m}$ :

\sum_{i=1}^{n} t\left(X_{i}, y\right) \varphi_{j_{0}}^{m}\left(X_{i}\right)=\sum_{i=1}^{n} \sum_{k_{0} \in K_{m}} \hat{w}_{i} \psi_{k_{0}}^{m}\left(Z_{i}\right) \psi_{k_{0}}^{m}(y) \varphi_{j_{0}}^{m}\left(X_{i}\right)
$$

If we multiply this equality by $a_{j_{0}, k}^{\prime} \psi_{k}^{m}(y)$ and if we sum over $k \in K_{m}$ and $j_{0} \in J_{m}$, we obtain

\begin{array}{ll}

\sum_{k} R_{i, k}^{2} \leq \sum_{k} \psi_{k}^{2}\left(Y_{i}\right) \frac{\left|\widehat{\bar{G}}\left(Y_{i}\right)-\bar{G}\left(Y_{i}\right)\right|^{2} \mathbb{1}_{A_{2}}\left(Y_{i}\right)}{c_{G}^{2} \widehat{\bar{G}}^{2}\left(Y_{i}\right)} \leq \frac{\phi_{2} D_{\hat{m}_{2}}}{c_{G}^{2}} \frac{\left|\widehat{\bar{G}}\left(Y_{i}\right)-\bar{G}\left(Y_{i}\right)\right|^{2} \mathbb{1}_{A_{2}}\left(Y_{i}\right)}{\widehat{\bar{G}}^{2}\left(Y_{i}\right)}
$$

Thus, it follows from the previous study (and in particular from Lemma 1), that the following inequality holds

\mathbb{E}\left(\left\|\pi \mathbb{1}_{A}-\hat{\pi}_{\hat{m}}\right\|_{n}^{2} \mathbb{1}_{\Omega_{\rho}^{c}}\right) \leq\left(\|\pi\|_{\infty}+8 \frac{\phi_{2} n^{1 / 2}}{c_{G}^{2}}\right) \mathbb{P}\left(\Omega_{\rho}^{c}\right)+\frac{2 \kappa \phi_{2}}{c_{G}^{2} n^{1 / 2}} \mathbb{P}^{1 / 2}\left(\Omega_{\rho}^{c}\right) . \tag{28}
\end{equation*}

Now we will use the following proposition:
Proposition 3. Let $\rho>1$. Then, under the assumptions of Theorem 1, there exists $C_{2}>0$ such that $P\left(\Omega_{\rho}^{c}\right) \leq \frac{C_{2}}{n^{3 / 2}}$.

This proposition implies that $\mathbb{E}\left(\left\|\pi \mathbb{1}_{A}-\hat{\pi}_{\hat{m}}\right\|_{n}^{2} \mathbb{1}_{\Omega_{\rho}^{c}}\right) \leq \frac{C_{3}}{n}$.
Now we use (26) and we observe that this inequality holds for all $m$ in $\mathcal{M}_{n}$, so

$$

with $C=\max \left(5\|f\|_{\infty}, 6\right)$.
6.3. Proof of Proposition 2. Let $\Gamma_{i}(t)=\delta_{i} t\left(X_{i}, Y_{i}\right) / \bar{G}\left(Y_{i}\right)-\int t\left(X_{i}, y\right) \pi\left(X_{i}, y\right) d y$. Then $\nu_{n}(t)=(1 / n) \sum_{i=1}^{n} \Gamma_{i}(t)$. We use the following lemma:
Lemma 2. (Talagrand (1996))
Let $U_{1}, \ldots, U_{n}$ i.i.d. variables and $\left(\zeta_{t}\right)_{t \in B}$ a set of functions and $B$ is a unit ball of a finite dimensional subspace of $\mathbb{L}^{2}(A)$. Let $\nu_{n}(t)=(1 / n) \sum_{i=1}^{n}\left[\zeta_{t}\left(U_{i}\right)-\mathbb{E}\left(\zeta_{t}\left(U_{i}\right)\right)\right]$. We suppose that
(1) $\sup _{t \in B}\left\|\zeta_{t}\right\|_{\infty} \leq M_{1}$,
(2) $\mathbb{E}\left(\sup \left|\nu_{n}(t)\right|\right) \leq H$,
(3) $\sup _{t \in B} \operatorname{Var}\left[\zeta_{t}\left(U_{1}\right)\right] \leq v$.

Then, there exists $K>0, K_{1}>0, K_{2}>0$ such that

\mathbb{E}\left[\sup _{t \in B} \nu_{n}^{2}(t)-6 H^{2}\right]_{+} \leq K\left[\frac{v}{n} e^{-K_{1} \frac{n H^{2}}{v}}+\frac{M_{1}^{2}}{n^{2}} e^{-K_{2} \frac{n H}{M_{1}}}\right]
$$

Here $\zeta_{t}(x, y, \delta)=\delta t(x, y) / \bar{G}(y)-\int t(x, u) \pi(x, u) d u$ and $B=B_{f}\left(m^{\prime}\right)$. We now compute $M_{1}, H$ and $v$.
(1)We recall that $S_{m}+S_{m^{\prime}}$ is included in the model $S_{m^{\prime \prime}}$ with dimension $\max \left(D_{m_{1}}, D_{m_{1}^{\prime}}\right)$ $\max \left(D_{m_{2}}, D_{m_{2}^{\prime}}\right)$.

\begin{aligned}
\sup _{t \in B}\left\|\zeta_{t}\right\|_{\infty} & \leq \sup _{t \in B}\|t\|_{\infty}\left(1 / c_{G}+1\right) \\
& \leq \phi_{0}\left(1 / c_{G}+1\right) \sqrt{\max \left(D_{m_{1}}, D_{m_{1}^{\prime}}\right) \max \left(D_{m_{2}}, D_{m_{2}^{\prime}}\right)}\|t\| \leq \frac{\left(1 / c_{G}+1\right) \phi_{0}}{f_{0}} n^{1 / 2} .
\end{aligned}
$$

Then we set $M_{1}=\frac{\left(1 / c_{G}+1\right) \phi_{0}}{f_{0}} n^{1 / 2}$.
(2) $\operatorname{Var}\left[\zeta_{t}\left(U_{1}\right)\right]=\mathbb{E}\left(\left[\Gamma_{1}(t)\right]^{2}\right) \leq \mathbb{E}\left[\frac{t^{2}\left(X_{1}, Y_{1}\right)}{\bar{G}\left(Y_{1}\right)}\right] \leq \frac{1}{c_{G}} \mathbb{E}\left[t^{2}\left(X_{1}, Y_{1}\right)\right] \leq \frac{\|\pi\|_{\infty}}{c_{G}}\|t\|_{f}^{2}$.

Then $v=\frac{\|\pi\|_{\infty}}{c_{G}}$.
(3) Let $\left(\bar{\varphi}_{j} \otimes \psi_{k}\right)_{(j, k) \in \Lambda\left(m, m^{\prime}\right)}$ be an orthonormal basis of $\left(S_{m}+S_{m^{\prime}},\|\cdot\|_{f}\right)$.

$$
\begin{aligned}
\mathbb{E}\left(\sup _{t \in B}\left|\nu_{n}^{2}(t)\right|\right) & \leq \sum_{j, k} \mathbb{E}\left(\nu_{n}^{2}\left(\bar{\varphi}_{j} \otimes \psi_{k}\right)\right)=\sum_{j, k} \frac{1}{n^{2}} \mathbb{E}\left[\left(\sum_{i=1}^{n} \Gamma_{i}\left(\bar{\varphi}_{j} \otimes \psi_{k}\right)\right)^{2}\right] \\
& =\sum_{j, k} \frac{1}{n} \mathbb{E}\left(\Gamma_{1}^{2}\left(\bar{\varphi}_{j} \otimes \psi_{k}\right)\right)
\end{aligned}
$$

In the uncensored case, we find

\begin{aligned}
\mathbb{E}\left(\sup _{t \in B}\left|\nu_{n}^{2}(t)\right|\right) & \leq \sum_{j, k} \frac{1}{n} \mathbb{E}\left(\bar{\varphi}_{j}^{2}\left(X_{1}\right) \psi_{k}^{2}\left(Y_{1}\right)\right) \leq \frac{\|\pi\|_{\infty}}{n} \sum_{j, k} \int \bar{\varphi}_{j}^{2}(x) \psi_{k}^{2}(y) f(x) d x d y \\
& \leq \frac{\|\pi\|_{\infty}}{n} D\left(m, m^{\prime}\right)
\end{aligned}
$$

In the censored case, the assumptions are more restrictive because we need to use the norm connection on $S_{m}+S_{m^{\prime}}$, that is we need $S_{m}+S_{m^{\prime}}$ to be a space of the collection. Indeed, in the general case above, the bound would be $\|\pi\|_{\infty} D\left(m, m^{\prime}\right) /\left(n c_{G}\right)$ and $c_{G}$ can not be estimated. Whereas under [M4], we find

& \leq \mathbb{E}\left(\frac{\delta_{1}}{\bar{G}^{2}\left(Z_{1}\right)}\right) \frac{\phi_{0}^{2}}{f_{0}} \frac{D\left(m, m^{\prime}\right)}{n}
\end{aligned}
$$

Then $\mathbb{E}\left(\sup _{t \in B} \nu_{n}^{2}(t)\right) \leq A D\left(m, m^{\prime}\right) / n$ and $H^{2}=A D\left(m, m^{\prime}\right) / n$ with $A=\|\pi\|_{\infty}$ in the uncensored case or $A=\left(\phi_{0}^{2} / f_{0}\right) \mathbb{E}\left(\delta_{1} / \bar{G}^{2}\left(Z_{1}\right)\right)$ in the censored case.

According to Lemma 2, there exists $K^{\prime}>0, K_{1}>0, K_{2}^{\prime}>0$ such that

So, if $p\left(m, m^{\prime}\right)=6 H^{2}=6 A D\left(m, m^{\prime}\right) / n$,
$\sum_{m^{\prime} \in \mathcal{M}_{n}} \mathbb{E}\left[\sup _{t \in B_{f}\left(m^{\prime}\right)} \nu_{n}^{2}(t)-p\left(m, m^{\prime}\right)\right]_{+} \leq \frac{K^{\prime}}{n}\left[\sum_{m^{\prime} \in \mathcal{M}_{n}}\left(e^{-K_{1} D\left(m, m^{\prime}\right)}+e^{-K_{2}^{\prime} \sqrt{D\left(m, m^{\prime}\right)}}\right)\right] \leq \frac{A_{1}}{n}$, and the result follows.
6.4. Proof of Proposition 3. First we observe that

P\left(\Omega_{\rho}^{c}\right) \leq P\left(\sup _{t \in \mathcal{B}}\left|\nu_{n}\left(t^{2}\right)\right|>1-1 / \rho\right)
$$

where $\nu_{n}(t)=\frac{1}{n} \sum_{i=1}^{n} \int\left[t\left(X_{i}, y\right)-\mathbb{E}\left(t\left(X_{i}, y\right)\right)\right] d y$ and $\mathcal{B}=\left\{t \in \mathcal{S},\|t\|_{f}=1\right\}$. We denote by $\left(\varphi_{j}, \psi_{k}\right)$ the orthonormal basis of $\mathcal{S}$, the set of maximal dimension of the collection.

But, if $t(x, y)=\sum_{j, k} a_{j, k} \varphi_{j}(x) \psi_{k}(y)$, then

\nu_{n}\left(t^{2}\right)=\sum_{j, j^{\prime}} \sum_{k} a_{j, k} a_{j^{\prime}, k} \bar{\nu}_{n}\left(\varphi_{j} \varphi_{j^{\prime}}\right)
$$

where

\bar{\nu}_{n}(u)=\frac{1}{n} \sum_{i=1}^{n}\left[u\left(X_{i}\right)-\mathbb{E}\left(u\left(X_{i}\right)\right)\right] . \tag{29}
\end{equation*}

Let $b_{j}=\left(\sum_{k} a_{j, k}^{2}\right)^{1 / 2}$, then $\left|\nu_{n}\left(t^{2}\right)\right| \leq \sum_{j, j^{\prime}} b_{j} b_{j^{\prime}}\left|\bar{\nu}_{n}\left(\varphi_{j} \varphi_{j^{\prime}}\right)\right|$ and, if $t \in \mathcal{B}, \sum_{j} b_{j}^{2}=$ $\sum_{j} \sum_{k} a_{j, k}^{2}=\|t\|^{2} \leq f_{0}^{-1}$.
Thus

\sup _{t \in \mathcal{B}}\left|\nu_{n}\left(t^{2}\right)\right| \leq f_{0}^{-1} \sup _{\sum b_{j}^{2}=1} \sum_{j, l} b_{j} b_{l}\left|\bar{\nu}_{n}\left(\varphi_{j} \varphi_{l}\right)\right| .
$$

Lemma 3. Let $B_{j, l}=\left\|\varphi_{j} \varphi_{l}\right\|_{\infty}$ and $V_{j, l}=\left\|\varphi_{j} \varphi_{l}\right\|_{2}$. Let, for any symmetric matrix $\left(A_{j, l}\right)$

\bar{\rho}(A)=\sup _{\sum a_{j}^{2}=1} \sum_{j, l}\left|a_{j} a_{l}\right| A_{j, l}
$$

and $L(\varphi)=\max \left\{\bar{\rho}^{2}(V), \bar{\rho}(B)\right\}$. Then, if [M2] is satisfied, $L(\varphi) \leq \phi_{1} \mathcal{D}_{n}^{2}$.
This lemma is proved in Baraud et al. (2001).

x=\frac{f_{0}^{2}(1-1 / \rho)^{2}}{4\|f\|_{\infty} L(\varphi)} & \text { and } \Delta=\left\{\forall j \forall l\left|\bar{\nu}_{n}\left(\varphi_{j} \varphi_{l}\right)\right| \leq 4\left[B_{j, l} x+V_{j, l} \sqrt{2\|f\|_{\infty} x}\right]\right\} . \text { On } \Delta \text { : } \\
\sup _{t \in \mathcal{B}}\left|\nu_{n}\left(t^{2}\right)\right| & \leq f_{0}^{-1} \sup _{\sum b_{j}^{2}=1} \sum_{j, l} b_{j} b_{l}\left[B_{j, l} x+V_{j, l} \sqrt{2\|f\|_{\infty} x}\right] \\
& \leq f_{0}^{-1}\left[\bar{\rho}(B) x+\bar{\rho}(V) \sqrt{2\|f\|_{\infty} x}\right] \\
& \leq(1-1 / \rho)\left[\frac{f_{0}(1-1 / \rho)}{4\|f\|_{\infty}} \frac{\bar{\rho}(B)}{L(\varphi)}+\frac{1}{\sqrt{2}}\left(\frac{\bar{\rho}^{2}(V)}{L(\varphi)}\right)^{1 / 2}\right] \\
& \leq(1-1 / \rho)\left[\frac{1}{4}+\frac{1}{\sqrt{2}}\right] \leq(1-1 / \rho) .
\end{aligned}

Then $P\left(\sup _{t \in \mathcal{B}}\left|\nu_{n}\left(t^{2}\right)\right|>1-\frac{1}{\rho}\right) \leq P\left(\Delta^{c}\right)$.
To bound $P\left(\bar{\nu}_{n}\left(\varphi_{j} \varphi_{l}\right) \geq B_{j, l} x+V_{j, l} \sqrt{2\|f\|_{\infty} x}\right)$, we will apply the Bernstein inequality given in Birgé and Massart (1998) to the independent variables $U_{i}^{j, l}=\varphi_{j}\left(X_{i}\right) \varphi_{l}\left(X_{i}\right)$. We get

P\left(\Omega_{\rho}^{c}\right) \leq 2 \mathcal{D}_{n}^{2} \exp \left\{-\frac{n f_{0}^{2}(1-1 / \rho)^{2}}{40\|f\|_{\infty} L(\varphi)}\right\} \leq 2 n \exp \left\{-\frac{f_{0}^{2}(1-1 / \rho)^{2}}{40\|f\|_{\infty}} \frac{n}{L(\varphi)}\right\}
$$

But $L(\varphi) \leq \phi_{1} \mathcal{D}_{n}^{2} \leq \phi_{1} n / \log ^{2}(n)$, so

6.5. Proof of Corollary 1. To control the bias term, we state the following lemma proved in Lacour (2007) and following from Hochmuth (2002) and Nikol'skiĭ (1975):

Lemma 4. Let $\pi_{A}$ belong to $B_{2, \infty}^{\alpha}(A)$. We consider that $S_{m}^{\prime}$ is one of the following spaces on $A$ :

- a space of piecewise polynomials of degrees bounded by $s_{i}>\alpha_{i}-1(i=1,2)$ based on a partition with rectangles of sidelengthes $1 / D_{m_{1}}$ and $1 / D_{m_{2}}$,
- a linear span of $\left\{\phi_{\lambda} \psi_{\mu}, \lambda \in \cup_{0}^{m_{1}} \Lambda(j), \mu \in \cup_{0}^{m_{2}} M(k)\right\}$ where $\left\{\phi_{\lambda}\right\}$ and $\left\{\psi_{\mu}\right\}$ are orthonormal wavelet bases of respective regularities $s_{1}>\alpha_{1}-1$ and $s_{2}>\alpha_{2}-1$ (here $D_{m_{i}}=2^{m_{i}}, i=1,2$ ),
- the space of trigonometric polynomials with degree smaller than $D_{m_{1}}$ in the first direction and smaller than $D_{m_{2}}$ in the second direction.
Let $\pi_{m}^{\prime}$ be the orthogonal projection of $\pi_{A}$ on $S_{m}^{\prime}$. Then, there exists a positive constant $C_{0}$ such that

$$
\left(\int_{A}\left|\pi_{A}-\pi_{m}^{\prime}\right|^{2}\right)^{1 / 2} \leq C_{0}\left[D_{m_{1}}^{-\alpha_{1}}+D_{m_{2}}^{-\alpha_{2}}\right]
$$

If we choose for $S_{m}^{\prime}$ the set of the restrictions to $A$ of the functions of $S_{m}$ and $\pi_{A}$ the restriction of $\pi$ to $A$, we can apply Lemma 4 . But $\pi_{m}^{\prime}$ is also the restriction to $A$ of $\pi_{m}$ so that

\left\|\pi \mathbb{1}_{A}-\pi_{m}\right\| \leq C_{0}\left[D_{m_{1}}^{-\alpha_{1}}+D_{m_{2}}^{-\alpha_{2}}\right] .
$$

According to Theorem 1

$$
\mathbb{E}\left\|\tilde{\pi}-\pi \mathbb{1}_{A}\right\|_{n}^{2} \leq C^{\prime \prime} \inf _{m \in \mathcal{M}_{n}}\left\{D_{m_{1}}^{-2 \alpha_{1}}+D_{m_{2}}^{-2 \alpha_{2}}+\frac{D_{m_{1}} D_{m_{2}}}{n}\right\}
$$

In particular, if $m^{*}$ is such that $D_{m_{1}^{*}}=\left\lfloor n^{\frac{\alpha_{2}}{\alpha_{1}+\alpha_{2}+2 \alpha_{1} \alpha_{2}}}\right\rfloor$ and $D_{m_{2}^{*}}=\left\lfloor\left(D_{m_{1}^{*}}\right)^{\frac{\alpha_{1}}{\alpha_{2}}}\right\rfloor$ then

$$
\mathbb{E}\left\|\tilde{\pi}-\pi \mathbb{1}_{A}\right\|_{n}^{2} \leq C^{\prime \prime \prime}\left\{D_{m_{1}^{*}}^{-2 \alpha_{1}}+\frac{D_{m_{1}^{*}}^{1+\alpha_{1} / \alpha_{2}}}{n}\right\}=O\left(n^{-\frac{2 \alpha_{1} \alpha_{2}}{\alpha_{1}+\alpha_{2}+2 \alpha_{1} \alpha_{2}}}\right)
$$

But the harmonic mean of $\alpha_{1}$ and $\alpha_{2}$ is $\bar{\alpha}=2 \alpha_{1} \alpha_{2} /\left(\alpha_{1}+\alpha_{2}\right)$. Then $\mathbb{E}\left\|\tilde{\pi}-\pi \mathbb{1}_{A}\right\|_{n}^{2}=$ $O\left(n^{-\frac{2 \bar{\alpha}}{2 \bar{\alpha}+2}}\right)$.

The condition $D_{m_{1}} \leq n^{1 / 2} / \log (n)$ allows this choice of $m$ only if $\frac{\alpha_{2}}{\alpha_{1}+\alpha_{2}+2 \alpha_{1} \alpha_{2}}<\frac{1}{2}$ i.e. if $\alpha_{1}-\alpha_{2}+2 \alpha_{1} \alpha_{2}>0$. In the same manner, the condition $\alpha_{2}-\alpha_{1}+2 \alpha_{1} \alpha_{2}>0$ must be verified. Both conditions hold if $\alpha_{1}>1 / 2$ and $\alpha_{2}>1 / 2$.
