# Study of the linear ablation growth rate for the quasi-isobaric model of Euler equations with thermal conductivity

#### Abstract

In this paper, we study a linear system related to the 2d system of Euler equations with thermal conduction in the quasi-isobaric approximation of Kull-Anisimov 14]. This model is used for the study of the ablation front instability, which appears in the problem of inertial confinement fusion. The heat flux $\vec{Q}$ is given by the Fourier law $T^{-\nu} \vec{Q}$ proportional to $\nabla T$, where $\nu>1$ is the thermal conduction index, and the external force is a gravity field $\vec{g}=-g \vec{e}_{x}$. This physical system contains a mixing region, in which the density of the gaz varies quickly, and one denotes by $L_{0}$ an associated characteristic length. The fluid velocity in the denser region is denoted by $V_{a}$.


The system of equations is linearized around a stationary solution, and each perturbed quantity $\tilde{u}$ is written using the normal modes method

$$
\tilde{u}(x, z, t)=\Re\left(\bar{u}(x, k, \gamma) e^{i k z+\gamma \sqrt{g k t}}\right)
$$

in order to take into account an increasing solution in time.
The resulting linear system is a non self-adjoint fifth order system. Its coefficients depend on $x$ and on physical parameters $\alpha, \beta, \alpha$ and $\beta$ being two dimensionless physical constants, given by $\alpha \beta=k L_{0}$ and $\frac{\alpha}{\beta}=\frac{g L_{0}}{V_{a}^{2}}$ (introduced in (5). We study the existence of bounded solutions of this system in the limit $\alpha \rightarrow 0$, under the condition $\beta \in\left[\beta_{0}, \frac{1}{\beta_{0}}\right]$, and the assumption $\Re \gamma \in\left[0, \frac{1}{\beta_{0}}\right],|\gamma| \leq \frac{1}{\beta_{0}}$ (regime that we studied for a simpler model in (5) calculating the Evans function $E v(\alpha, \beta, \gamma)$ associated with this linear system.
Using rigorous constructions of decreasing at $\pm \infty$ solutions of systems of ODE, we prove that, for $\beta \in\left[\beta_{0}, \frac{1}{\beta_{0}}\right]$, $\Re \gamma \in\left[0, \frac{1}{\beta_{0}}\right],|\gamma| \leq \frac{1}{\beta_{0}}$, there exists $\alpha_{1}>0$ such that there is no bounded solution of the linearized system for $0<\alpha \leq \alpha_{1}$.

[^0]Necessarily, for any $M>0$ and $\beta_{0}>0$ there exists $\alpha_{1}>0$ such that, for $0<\alpha \leq \alpha_{1}$ and $\beta \in\left[\beta_{0}, \frac{1}{\beta_{0}}\right]$, an admissible value $\gamma(\alpha, \beta)$ such that there exists a bounded solution of the linearized system satisfying $|\gamma| \leq M$ is such that $\Re \gamma \notin[0, M]$.

## 0 Introduction

This paper is devoted to the precise calculus of the Evans function $\operatorname{Ev}(\alpha, \beta, \gamma)$ of the normal mode formulation of the linearized system of equations associated with the quasi-isobaric (low Mach number) model. The calculus of this Evans function is not classical, because the matrix of the differential system has singular coefficients,and because these coefficients do not behave exponentially in the spatial variable. However, usual techniques of ordinary differential equations and introduction of a Fuchsian problem allow us to calculate this Evans function under certain assumptions on the parameters $\alpha, \beta, \gamma$ introduced in the Abstract.
In this Introduction, we first describe the physical model (5), define what is called a linear growth rate of the linearized system associated with a stationary solution of this physical model, then finally describe the contents of each step of the proof of the main Theorem (Theorem (1).

### 0.1 Physical model

We consider a compressible fluid characterized by its density $\rho$, its velocity ( $u, v$ ) and its temperature $T$ in a gravity field $\vec{g}=-|g| \vec{e}_{x}$. We assume that this fluid has the following properties:
a) when $x$ goes to $+\infty$, for all $z$ we have $\rho \rightarrow \rho_{a},(u, v) \rightarrow\left(-V_{a}, 0\right)$ and $T \rightarrow T_{a}$.
b) the functions ( $\rho, u, v, p, T$ ), where $p$ is linked to the pressure in the fluid, satisfy the system of the Euler equations in two dimensions $(x, z)$ with thermal conduction in the quasi-isobaric approximation for a perfect gaz:

where $C_{p}$ is the calorific capacity of the fluid, the heat conduuction flux $\vec{Q}$ being given by the Fourier law

\vec{Q}=-k(T) \nabla T \tag{2}
\end{equation*}
$$

the thermal conduction law is

$$
\begin{equation*}
k(T)=K_{0} T^{\nu} \tag{3}
\end{equation*}
$$

where $\nu$ is the thermal conduction indice.
We introduce a characteristic length $L_{0}$ associated with the thermal properties of the fluid

L_{0}=\frac{K_{0} T_{a}^{\nu}}{C_{p} \rho_{a} V_{a}} . \tag{4}

Physical values of $L_{0}$ for the case of the ICF are of order $10^{-5}$ meters.
Under a quasi-isobaric assumption, the system modelizing the ablation model
was given by H.J. Kull 14] and appears for example in P. L. Lions [17]. It states

\operatorname{div}\left(C_{p} \rho T \vec{u}+\vec{Q}\right)=0
\end{array}\right.
$$

This model can be derived either from the low Mach approximation (Majda 19, Dellacherie (6]) or the quasi-isobaric approximation (Kull 14, Kull-Anisimov [15], Masse 20]. See a short analysis in Section 1. A stationary laminar solution of the system (5) is $\left(\rho_{0}(x), u_{0}(x), 0, p_{0}(x), T_{0}(x)\right)$, where we introduce a function $\xi$ such that

\rho_{0}(x)=\rho_{a} \xi\left(\frac{x}{L_{0}}\right), u_{0}(x)=-\frac{\rho_{a} V_{a}}{\rho_{0}(x)}=-\frac{V_{a}}{\xi\left(\frac{x}{L_{0}}\right)}, T_{0}(x)=\frac{\rho_{a} T_{a}}{\rho_{0}(x)}=\frac{T_{a}}{\xi\left(\frac{x}{L_{0}}\right)}
$$

and $p_{0}(x)$ satisfies

p_{0}(x)+\frac{\rho_{a}^{2} V_{a}^{2}}{\rho_{0}(x)}+g \int_{x_{0}}^{x} \rho_{0}(s) d s=p_{0}\left(x_{0}\right)+\frac{\rho_{a}^{2} V_{a}^{2}}{\rho_{0}(x)} .
$$

The function $\xi$ is the solution of the differential equation

\frac{d \xi}{d y}=\xi^{\nu+1}(1-\xi) \tag{6}
\end{equation*}
$$

such that $\xi(0)=\frac{\nu+1}{\nu+2}$. Note that, in this case

p_{0}\left(L_{0} y\right)=p_{0}(0)+\frac{\nu+2}{\nu+1} \rho_{a} V_{a}^{2}-\rho_{a} V_{a}^{2}\left[\frac{1}{\xi(y)}+\frac{g L_{0}}{V_{a}^{2}} \int_{0}^{y} \xi(t) d t\right] .
$$

Introduce

$$
\begin{equation*}
Z(\rho)=\frac{\rho_{a}^{\nu+1}}{(\nu+1) \rho^{\nu+1}} . \tag{7}
\end{equation*}
$$

The system of unknowns that we consider is

$$
\tilde{U}=\left(\begin{array}{c}

\rho u^{2}+p \\
\rho u v \\
Z(\rho) \\
u-L_{0} V_{a} \partial_{x}(Z(\rho))
\end{array}\right)
$$

From $\tilde{U}$, we recover $\rho$ from $Z(\rho), u=\frac{\rho u}{\rho}, v=\frac{\rho u v}{\rho u}$ and $p=p+\rho u^{2}-\frac{(\rho u)^{2}}{\rho}$.
For this choice of unknowns, we introduce $F_{1}(\tilde{U})=\tilde{U}$. There exists three explicit functions $F_{0}, F_{2}$ and $F_{3}$ such that the system (5) is equivalent to the system on $\tilde{U}$

T=\frac{\rho_{a} T_{a}}{Z^{-1}\left(\tilde{U}_{4}\right)}
\end{array}\right.
$$

A stationnary laminar solution $U_{0}$ of this system depending only on $x$ is $U_{0}(x)$ such that

$$
\frac{d}{d x}\left(F_{1}\left(U_{0}(x)\right)\right)=F_{3}\left(U_{0}(x)\right) .
$$

The identity $F_{1}(\tilde{U})=\tilde{U}$ is the natural choice when one studies a basic solution depending only on the variable $x$.

### 0.2 Definition of a linear growth rate

We linearize (8) around $U_{0}(x)$. Denote by $U$ the unknowns $\tilde{U}-U_{0}(x)$. The linearized system writes $\left(\nabla_{1}\right.$ and $\nabla_{2}$ denotes the gradient of $F_{2}$ with respect to the first and second set of variables $\tilde{U}$ and $\left.\partial_{z} \tilde{U}\right)$ :
$\partial_{x} U+\nabla F_{0}\left(U_{0}(x)\right) \partial_{t} U+\nabla_{1} F_{2}\left(U_{0}(x), 0\right) \partial_{z} U+\nabla_{2} F_{2}\left(U_{0}(x), 0\right) \partial_{z^{2}}^{2} U=\nabla F_{3}\left(U_{0}(x)\right) U$
which can be rewritten $M\left(x, \partial_{x}, \partial_{z}, \partial_{z^{2}}^{2}, \partial_{t}\right) U=0$. Note that its coefficients depend on $x$ through the stationnary solution.

We are now ready to introduce the definition of a linear growth rate for a non linear system around a laminar solution:

Definition 1 Let $M\left(x, \partial_{x}, \partial_{z}, \partial_{z^{2}}^{2}, \partial_{t}\right) U=0$ be the linearized system
We call a linear growth rate of this system for the wave number $k$ a value of $\sigma$ (depending on $k$ ) such that $\Re \sigma \geq 0$ and there exists a non-trivial solution $U(x, k, \sigma)$ of the system

M\left(x, \frac{d}{d x}, i k,-k^{2}, \sigma\right) U(x, k, \sigma)=0 \tag{10}
\end{equation*}
$$

such that $U$ is bounded and going to 0 when $x$ goes to $\pm \infty$. The function

$$
U(x, k, \sigma) e^{i k z} e^{\sigma t}
$$

is called a normal mode solution of the system.
The normal mode system associated with (9) is
$\frac{d V}{d x}+\nabla F_{0}\left(U_{0}(x)\right) \sigma V+i k \nabla_{1} F_{2}\left(U_{0}(x), 0\right) V-k^{2} \nabla_{2} F_{2}\left(U_{0}, 0\right) V=\nabla F_{3}\left(U_{0}(x)\right) V$.
The scope of this paper is to find bounded non trivial solutions of (11), and associated values of $\sigma$ if any. If such a solution exist, it will lead to a normal mode solution of the linearized system. Note that, in the set-up we described, different physical parameters appear, namely $k, L_{0}, V_{a}, g$. As the classical growth rate of Rayleigh is equal to $\left(\frac{\rho_{2}-\rho_{1}}{\rho_{2}+\rho_{1}} g k\right)^{\frac{1}{2}}$ for the discontinuity model [22], and as we proved ( $5 \sqrt[5]{2},[12]$ ) that this value was the limit of the growth rate when $k L_{0}$ goes to zero, we are led to introducing the following quantities

\end{equation*}

and

\alpha=\sqrt{\frac{\varepsilon}{F r}}, \beta=\sqrt{\varepsilon F r}, \gamma=\frac{\sigma}{\sqrt{g k}} . \tag{13}
\end{equation*}
$$

The aim of this paper is to study the existence of a growth rate $\gamma, \Re \gamma \geq 0$, in the limit $L_{0} \rightarrow 0$ when the Froude number $F r$ is of order $\frac{1}{L_{0}}$, which means that

$$
\alpha \rightarrow 0, \beta>0 .
$$

Remark Other regimes rely on different assumptions on $\alpha$ and $\beta$ : we refer to [13] for the results that can be obtained for this model in the high frequency regime $k \rightarrow+\infty$. In this other regime the scaling writes

$$
\varepsilon \text { large, } \varepsilon^{3} F r \leq C^{\prime} \text {, where } C^{\prime} \text { is a constant. }
$$

In the first section, we study the physical origin of the model and derive the properties of the stationary solution, where the associated density profile satisfies:

\rho_{0}(x)-\rho_{a} \simeq C e^{-\frac{x}{L_{0}}} x \rightarrow+\infty \\
\rho_{0}(x)|x|^{\frac{1}{\nu}} \rightarrow \rho_{a}\left(\frac{L_{0}}{\nu}\right)^{\frac{1}{\nu}}, x \rightarrow-\infty .
\end{array}\right.
$$

We then derive the linearized system, which is a fifth order differential system whose coefficients depend on $\rho_{0}(x)$ and are singular when $\rho_{0}(x)$ go to zero. Note that this is not a classical case for the study of such systems and that this leads to rather tricky methods.
In the second section, we recall the general set-up for the calculation of the Evans function of the linearized system, and we give the induced differential systems in $\Lambda^{n}\left(K^{5}\right)$ for $n=2,3$. Note that the field $K$ is $\mathbb{R}$ for real values of $\gamma$ and $K=\mathbb{C}$ for complex values of $\gamma$. This Evans function is (related to) the vectorial product of the normalized solution in $\Lambda^{2}\left(K^{5}\right)$ which has the greatest decay when $x \rightarrow+\infty$ and of the normalized solution in $\Lambda^{3}\left(K^{5}\right)$ which has the greatest decay at $x \rightarrow-\infty$.
In the third section, we identify the solutions of the system in $\Lambda^{2}\left(K^{5}\right)$ deduced from (10) for $x \rightarrow+\infty$. In this region, we use the exponential behavior of the profile to obtain the classical analytic expansion of the normalized solution of the system in $\Lambda^{2}\left(K^{5}\right)$. There exists $\left.\xi_{0} \in\right] 0,1\left[\right.$ (corresponding to $y_{0} \in \mathbb{R}$ through $\left.\xi\left(y_{0}\right)=\xi_{0}\right)$ such that this analytic expansion is valid for $\xi\left(\frac{x}{L_{0}}\right) \geq \xi_{0}$, that is $x \geq L_{0} y_{0}$. Note that, however, the expansion of this solution cannot be obtained by the techniques developed in Zumbrun et al [4] , because the Gap lemma assumptions are not fulfilled.
A general feature in the calculation of the Evans function is to obtain an overlapping region of definition between the solution well behaved at $+\infty$ and the solution well behaved at $-\infty$. A first step to achieve this overlap is then to prove that there exists $\alpha_{0}>0$ and $R>0$ such that, for all $\alpha<\zeta<\frac{1}{R}$ the solution obtained for $x \geq L_{0} y_{0}$ can be extended in $\left[X_{*}(\alpha, \zeta), L_{0} y_{0}\right.$ ] where

$$
\xi\left(\frac{X_{*}(\alpha, \zeta)}{L_{0}}\right)=\alpha^{\frac{1}{\nu}} \zeta^{-\frac{1}{\nu}} .
$$

This is the aim of the fifth section. The behavior of the solution in the region [ $\alpha^{\frac{1}{\nu}} \zeta_{0}^{-\frac{1}{\nu}}, \xi_{0}$ ] when $\alpha \rightarrow 0$ is different from the classical analytic expansion in $\alpha$ for $y \in\left[y_{0},+\infty[\right.$ and it is the aim of Sections 3.3 and 3.4.
Once this extension is done, an easy calculus is the calculus of a growth rate associated with the following stationnary solution, characterized by its density profile, for a $\zeta_{0}$ such that $\zeta_{0}<\frac{1}{R}$ :

\rho_{a} \xi\left(\frac{x}{L_{0}}\right), x \geq X_{*}\left(\alpha, \zeta_{0}\right)  \tag{14}\\
\rho_{a} \alpha^{\frac{1}{\nu}} \zeta_{0}^{-\frac{1}{\nu}}
\end{array}\right.
$$

This calculus is an improvement of the discontinuity model of Piriz, Sanz and Ibanez 21] and it is the aim of Section 4 .
When the profile is not constant in the region ] $-\infty, X_{*}\left(\alpha, \zeta_{0}\right)$ ] (that is for the full model), the system leads to a fuchsian problem in the region $x \rightarrow-\infty$, and we use the hypergeometric equation (see 16]). The solution of the system in $\Lambda^{3}\left(K^{5}\right)$ deduced from (10) is identified in any region of the form $\left.\left.\frac{x}{L_{0}} \in\right]-\infty,-\frac{t_{0}}{\alpha \beta}\right]$ for every $t_{0}$, which means that $\left.\left.x \in\right]-\infty,-\frac{t_{0}}{k}\right]$. The results of the analysis of these solutions is summarized in Theorem 1 .
The study of the roots of the Evans function is the aim of Section 6 and we summarize the method here. From the relation $\xi(y)|y|^{\frac{1}{\nu}} \rightarrow \nu^{-\frac{1}{\nu}}$ when $y \rightarrow-\infty$, we deduce that $-\alpha \beta X_{*}(\alpha) \rightarrow \frac{\beta \zeta_{0}}{\nu}>0$ when $\alpha \rightarrow 0$. Hence for all $<0 \alpha \leq \alpha_{0}$ there exists $t_{0}>0$ such that the regions $\left.]-\infty,-\frac{t_{0}}{\alpha \beta}\right]$ and $\left[\frac{X_{*}(\alpha)}{L_{0}}, y_{0}\right]$, where $\xi\left(y_{0}\right)=\xi_{0}$, overlap.
We then express the Evans function $E v(\alpha, \beta, \gamma)$ of the system at a point of $\left[-\frac{t_{0}}{\alpha \beta}, \frac{X_{*}(\alpha)}{L_{0}}\right]$. The limit when $\alpha \rightarrow 0$ and $t_{0}$ small exists and we write its expression in terms of $r=\frac{\gamma}{\beta}, \beta$ and $t_{0}>0$. As it does not depend on $t_{0}$ we study the limit when $t_{0} \rightarrow+\infty$, hence proving that the only positive value of $r$ which is admissible is $r=1$. We deduce a contradiction, proving that there is no growth rate ( of positive real part) for the system. This can be stated as

Theorem Let $M$ be given. There exists $\alpha_{*}>0$ such that, for $0<$ $\alpha<\alpha_{*}, \beta \in\left[\frac{1}{M}, M\right]$, the Evans function $E v(\alpha, \beta, \gamma)$ of the system has no root for $|\gamma| \leq M, \Re \gamma \in[0, M]$.

## 1 Derivation of the quasi-isobaric model

### 1.1 The physical approximations

The general equations are the thermal hydrodynamic equations, written in a non conservative form:

\rho\left(\partial_{t}+\vec{u} . \nabla\right) h-\left(\partial_{t}+\vec{u} . \nabla\right) p=-\operatorname{div}\left(\vec{Q}+\vec{J}_{l}\right)
\end{array}\right.
$$

where $C_{p}$ and $C_{v}$ are the classical tehrmodynamic calorific capacities at constant pressure and at constant volume, $h$ is the enthalpy $h=C_{p} T$, the pressure and the density being given by the equation of state $p=\left(C_{p}-C_{v}\right) \rho T, \vec{Q}=$ $-k(T) \nabla T, \overrightarrow{J_{l}}=0$ (in our assumption the energy given to the system is 0 ). The quasi-isobaric approximation writes

$$
\frac{C_{p}-C_{v}}{C_{v}} \frac{\delta p}{p} \ll \frac{\delta T}{T} .
$$

Following L. Masse 20, this relies on the two hypotheses

M^{2} \ll 1, \frac{M^{2}}{F r} \ll 1 \tag{16}
\end{equation*}
$$

Hence the quasi-isobaric model relies on a low Mach hypothesis.
The equation of the energy rewrites

$$
\operatorname{div} \vec{u}+\frac{1}{\rho h} \operatorname{div} \vec{Q}=-\frac{\left(\partial_{t}+\vec{u} . \nabla\right)(\rho h-p)}{\rho h} .
$$

This equation is approximated by (il) as we will see below. What follows is a formal derivation of the quasi-isobaric model under a low mach hypothesis. It is closely related to the method given by Majda [19], Dellacherie [6].

### 1.2 Adimensionnalization and low Mach expansion

Use the reference density $\rho_{a}$, the reference velocity $V_{a}$, and the reference pressure $p_{s}$ associated with the sound velocity $c_{s}$ such that $c_{s}^{2} \frac{C_{p}}{C_{v}} \rho_{a}=p_{s}$. The Mach number is thus $M=\frac{V_{a}}{c_{s}}$.
Write $\rho=\rho_{a} \rho^{\prime}, \vec{u}=V_{a}^{c_{s}} \vec{u}^{\prime}, p=p_{s} p^{\prime}$. The system of equations (15) rewrites

If $C_{0}>0, \xi$ is increasing, hence if it is majorated, it has a limit $l>0$ when $y \rightarrow+\infty$, this limit $l$ satisfies $l^{\nu+1}+\frac{C_{0}}{V_{a}} \nu^{\nu+2}=0$, which is impossible. We deduce that $C_{0}<0$, hence the equation is

When we consider a non constant solution, we have the following Lemma which gives the behavior of the solution when $x$ goes to $-\infty$. ### 1.4 Physical interpretation of the model

We insist finally on the fact that this system of equations is only a theoretical model: the equation satisfied by $p_{0}$ is

Introduce the function $M(y)$ such that $M^{2}(y)=\frac{|\vec{u}(y)|^{2}}{C_{s}^{2}(y)}$, where $C_{s}(y)$ is the sound velocity at a point of the fluid given by $C_{s}(y)^{2}=\frac{C_{p}}{C_{v}} \frac{p(y)}{\rho(y)}$, that we still call the Mach number. We have

Lemma 2 The Mach number of the stationnary solution is bounded for $\nu \geq 2$ and $y \leq-C$.

Moreover, as $p_{0}(y) \rightarrow-\infty$ when $y \rightarrow+\infty$, there exists a point where the pressure vanishes. There exists a constant $C$ such that $P(y)$ is bounded below $\varepsilon_{0}>0$ on $]-\infty,-C]$ and $-C$ is a positive constant of order $\left(\frac{\rho_{a} T_{a}}{M^{2}}\right)^{\frac{\nu}{\nu-1}}$.

The low Mach number assumption is relevant (in particular when looking at the temperature of ablation and the density in the ablated fluid).

### 1.5 Linearisation of the equations

To simplify the notations of what follows, we denote by $\tilde{f}$ a quantity appearing in the Euler system of equations, by $f_{0}$ its stationnary leading order term, and by $f$ the perturbation of order 1 normalized by the physical quantity $\rho_{a}$ for the density, $\rho_{a} V_{a}$ for the impulsion, and $\rho_{a} V_{a}^{2}$ for a pressure term. In the normal mode study in the vicinity of a profile depending on $x$, it is pertinent to linearize the variables on which acts the derivative $\frac{d}{d x}$, that is $\tilde{\rho} \tilde{u}, \tilde{\rho}(\tilde{u})^{2}+p$ and $\tilde{\rho} \tilde{u} \tilde{v}$, which writes

Assume $\left(\begin{array}{c}\underline{x}_{1} \\ \underline{x}_{2} \\ \underline{x}_{3} \\ \underline{x}_{4} \\ \underline{x}_{5}\end{array}\right) e^{i k z+\gamma \sqrt{g k t}}$ is a solution of the linearized system. This rewrites as a system of ordinary differential equations on $\left(\begin{array}{c}\underline{x}_{1} \\ \underline{x}_{2} \\ \underline{x}_{3} \\ \underline{x}_{4} \\ \underline{x}_{5}\end{array}\right)$. If $\left(\begin{array}{c}\underline{x}_{1} \\ \underline{x}_{2} \\ i \underline{x}_{3} \\ \underline{x}_{4} \\ \underline{x}_{5}\end{array}\right)$ is solution of this linear system of ODE, then $\left(x_{1}, x_{2}, i x_{3}, x_{4}, x_{5}\right)^{t}$ is solution of (23). Note that, in this case $i x_{3}$ is real.

Remark on complex growth rates Note that, if $\gamma$ is complex, the solution $\left(\begin{array}{l}\underline{x}_{1} \\ \underline{x}_{2} \\ i \underline{x}_{3} \\ \underline{x}_{4} \\ \underline{x}_{5}\end{array}\right)$ is also complex and depend on $y, k, \gamma$. More precisely, introduce $y_{j}, z_{j}$ such that $\underline{x}_{j}=y_{j}+i z_{j}$. We have thus

and $y_{j}$ and $z_{j}$ are known through the decomposition of the initial perturbation in the even part and the odd part in $z$.
Hence, from a complex solution $\left(\underline{x}_{1}, \ldots, \underline{x}_{5}\right)^{t}(x, k, \gamma)$ of the normal mode system, one deduces a solution of the perturbation system with a known initial condition.

Normal modes system The equations for the normal modes associated with the mass conservation and the momentum equation are

From now on, we will call this system the Kull-Anisimov system. The eigenvalues of $-M_{0}$ are given by the classical result ${ }^{1}$ (see [14, 21]), and help us to study the solution at $\pm \infty$ :

The eigenvalues $\lambda_{0}, \lambda_{a, \pm}$ are called the hydrodynamic modes, the eigenvalues $\lambda_{ \pm}(\xi)$ are called the thermal modes.

[^1]- For $\Re \gamma \geq 0$, one has $\Re \lambda_{0}(\xi) \geq 0, \pm \Re\left(\lambda_{ \pm}(\xi)\right)>0$, and for $\Re \gamma>0$ one has $\Re \lambda_{0}(1)>0$. The matrix $-M_{0}(\xi)$ has three eigenvalues of positive real part, and two eigenvalues of negative real part.
- The associated eigenvectors are given by

As $\lambda_{ \pm}(\xi)=-\frac{\xi^{\nu}}{2} \pm(A+i B), \Re\left(\lambda_{+}(\xi) \lambda_{-}(\xi)\right)=\left(-\frac{\xi^{\nu}}{2}+A\right)\left(-\frac{\xi^{\nu}}{2}-A\right)+B^{2}$, and $\Re \lambda_{+}(\xi) \Re \lambda_{-}(\xi)=\Re\left(\lambda_{+}(\xi) \lambda_{-}(\xi)\right)-B^{2}=-\alpha \xi^{\nu+1} \Re \gamma-\alpha^{2} \beta^{2}-B^{2}<0$, one obtains that the product $\Re \lambda_{+}(\xi) \Re \lambda_{-}(\xi)$ is strictly negative, hence the real parts are of opposite sign, hence $\Re \lambda_{+}(\xi)=-\frac{\xi^{\nu}}{2}+A$.
This calculus also defines uniquely in the case $\Re \gamma>0$ the eigenvalues $\lambda_{+}(\xi)$ and $\lambda_{-}(\xi)$.
Note also $A_{0}(\alpha, \beta, \gamma)$ and $B_{0}(\alpha, \beta, \gamma)$ the quantities such that $A_{0}(\alpha, \beta, \gamma)>0$ and $\left(A_{0}(\alpha, \beta, \gamma)+i B_{0}(\alpha, \beta, \gamma)\right)^{2}=\frac{1}{4}+\alpha^{2} \beta^{2}+\alpha \gamma$.
Using $\frac{d \xi}{d y}=\xi^{\nu+1}(1-\xi)$, we also introduce a new system of unknowns :

The next section is devoted to the statement of the methods used to find the solutions at infinity for systems of ODE which coefficients depend on $y$, and of the general set-up to find solutions bounded at $\pm \infty$.

## 2 Evans functions and application to the KullAnisimov system

### 2.1 General framework

This section recalls results of the paper of Alexander, Gardner et Jones [2], as well as the methods developed by K. Zumbrun [4], D. Serre 24], S. BenzoniGavage [3] and other authors. Its purpose is to study solutions with a prescribed behavior at infinity of an ordinary linear system of differential equations. It is used in particular to identify solutions going to 0 as $y \rightarrow \pm \infty$.

In the general case, we consider the ordinary differential system

$$

when $A$ is a regular matrix (for example analytic in $\alpha$ ).
We notice that the vectorial product $y_{1} \wedge y_{2}$ of two solutions $y_{1}$ and $y_{2}$ of (34) is solution of a new differential system on $\Lambda^{2}\left(K^{n}\right)$ which matrix is denoted by $A^{(2)}$, because

Similarily $y_{1} \wedge y_{2} \wedge \ldots \wedge y_{k}$ is solution of an ordinary differential system on $\Lambda^{k}\left(\mathbb{R}^{n}\right)$ whose matrix is denoted by $A^{(k)}$. The matrix $A^{(k)}$ is given by

When the matrix $A$ is diagonalizable, with eigenvalues $\lambda_{1} \leq \lambda_{2}<\ldots \leq \lambda_{d}$ then $A^{(k)}$ is diagonalizable and its eigenvalues are

The largest eigenvalue of $A^{(k)}$ is $\sum_{p=1}^{k} \lambda_{d+1-p}$, and its smallest eigenvalue is $\sum_{p=1}^{k} \lambda_{p}$.
Under the hypothesis that $\lambda_{d-k}<\lambda_{d+1-k}$, the largest eigenvalue of $A^{(k)}$ is simple. Its associated eigenvector is the vectorial product of the eigenvectors associated with $\left(e_{d+1-k}, . ., e_{d}\right)$.

Recall that the space $\Lambda^{(d)}\left(\mathbb{R}^{d}\right)$ is of dimension 1 , hence the matrix associated with $A^{(d)}$ is a number, which is equal to $\operatorname{Tr}(A(t, \alpha))$. The associated differential equation is

Hence the vectorial product of $d$ solutions of (34) satisfies

whose solution is the Wronskian of $d$ solutions of the system.

### 2.2 Notations for the Kull-Anisimov system

Remark that, when $\gamma$ is complex, one has to replace $\mathbb{R}$ by $K=\mathbf{C}$ but nothing will change as what is important is that we study objects on a field, which can be $\mathbb{R}$ when $\gamma$ is real, and which is $\mathbb{C}$ when $\gamma$ is complex.

In the set-up of this paper, the matrix $-M_{0}$ admits three eigenvalues of positive real part, which may be associated with the solutions going to 0 when $y$ goes to $+\infty$, and has two eigenvalues of negative real part, which help to understand the solutions going to 0 when $y$ goes to $+\infty$.

It is in general hard to compute the solutions associated with an eigenvalue of the matrix $-M_{0}$. However, we may compute the solution for the matrix $M_{0}^{(2)}$ associated with the smallest eigenvalue $\lambda_{a,-}+\lambda_{-}(\xi)$, and the solution for the matrix $M_{0}^{(3)}$ associated with the largest eigenvalue $\lambda_{0}(\xi)+\lambda_{+}(\xi)+\lambda_{a,+}$.
We introduce from now on the base vectors in $\Lambda^{2}\left(K^{5}\right)$ which take into account the role of $\frac{1}{1-\xi}$ in $B$ :

To these vectors are associated the following vectors in $\Lambda^{3}\left(K^{5}\right)$ such that $f_{i} \wedge$ $f_{i}^{\perp}=i_{1} \wedge i_{2} \wedge i_{3} \wedge i_{4} \wedge i_{5}=g_{j} \wedge g_{j}^{\perp}, \forall i, j$. We have

g_{1}^{\perp}=i_{3} \wedge i_{4} \wedge i_{5}, g_{2}^{\perp}=-i_{2} \wedge i_{4} \wedge i_{5}, g_{3}^{\perp}=-i_{2} \wedge i_{3} \wedge i_{4} \\
g_{4}^{\perp}=i_{1} \wedge i_{4} \wedge i_{5}, g_{5}^{\perp}=i_{1} \wedge i_{3} \wedge i_{4}, g_{6}^{\perp}=-i_{1} \wedge i_{2} \wedge i_{4} . \tag{38}

Note that we shall use in the sequel the eigenvector of the matrix $M_{0}^{(2)}(1)$ associated with the eigenvalue $-\alpha \beta+\lambda_{-}(1)$ :

The aim of this paper is to compute the Evans function through the calculation ${ }^{2}$ of $w_{+}^{(2)}$ and $w_{-}^{(3)}$.

We see in this theorem the division in three regions for the computation of the solutions of (42) and of (43). The first region $\xi(y) \in\left[\xi_{0}, 1[\right.$ is the aim of Section 3, the second region (which extends the result of $\left[\xi_{0}, 1[\right.$ ) is studied in Section 3.3, and the solution in the neighborhood of $-\infty$ is characterized in Section 5 . In the next paragraph, we describe the systems that we shall use in what follows. One of the main problems is that the problem to solve is not a Cauchy problem, but we have informations at $\pm \infty$ for the solution of (26) that we want to study. Let us say a word on this system. As $\xi$ goes to 0 when $y$ goes to $-\infty$, we notice that the matrix $M_{0}$ is singular when $y$ goes to $-\infty$.
Moreover, the term $\frac{\alpha}{\beta}$ prevents us to have a result which is uniform when $\beta$ goes to 0 . A possible choice to overcome this difficulty is the choice $\beta \in\left[\beta_{0}, \frac{1}{\beta_{0}}\right]$.
Finally, even if we remove the singularity of $M_{0}$ at $y \rightarrow-\infty$ by whatever method, another problem is induced by the behavior of $\xi$ when $y$ goes to $-\infty$, because $\xi$ goes to 0 as $|y|^{-\frac{1}{\nu}}$. This will lead to a fuchsian problem (Section 5).

Note that in the theorem we defined unique solutions of the problems (42) and (43) with the prescribed behavior at infinity.
The behavior of the solutions induced by the theorem 1 lead to another expression of the Evans function of relation (53).
Assume that $y<0$ and denote by $t=-\alpha \beta y$. We introduce the functions $L_{p}(t, \alpha), R_{j}(t, \alpha)$ given by the equalities

## 3 Calculus of the solution in the overdense region

The aim of this section is to obtain $w_{+}^{(2)}$, which is the unique solution of the system (42) under the condition (49) in the region $\left[y_{0},+\infty\left[\right.\right.$ for all $y_{0}$. The first idea would be to try to apply the Gap Lemma. However, the eigenvalue of smallest real partof $-M_{0}^{(2)}(1)$ is $\lambda_{\text {min }}=\lambda_{-}(1)-\alpha \beta$, and the next eigenvalue is $\lambda^{*}=\lambda_{-}(1)+\alpha \gamma$. As $\lambda^{*}-\lambda_{\min }=\alpha(\gamma+\beta)$, the difference between two eigenvalues of $M_{0}^{(2)}(1)$ is not uniformly bounded below for $\left.\alpha \in\right] 0, \alpha_{0}[$. Hence the hypotheseses of the Gap lemma theorem are not fulfilled.

Remark As the coefficients of the differential system behave as $1-e^{-y}$ when $y$ goes to $+\infty$, one may obtain $Y^{(2)}$ through a Volterra expansion as

$r$ being a remainder term. We prove that the result that we obtain is analytic in $\alpha$ for $\beta, \gamma$ in a certain compact set. Once we know that, we identify $w_{+}^{(2)}$ (deduced from $Y^{(2)}$ and obtained also through a Volterra expansion) and we express it with an expansion in powers of $\alpha$, which is bounded by a geometric series for $\xi(y) \in\left[\xi_{0}, 1\right]$.
We then plug this developement in the differential system and we identify the terms. We check that the coefficient of $\alpha^{j}$ in the expansion in $\alpha$ of the solution is of the form $\frac{1}{\xi^{\nu j+2}} X_{j}(\xi)$, the radius of convergence of the series depends on $\xi\left(y_{0}\right)$. The aim of the explicit calculus is to deduce a new region of convergence of the series using the behavior in $\frac{\alpha^{j}}{\xi^{\nu j+2}} X_{j}(\xi)$. In this new region of convergence, we have a converging series, which coincides with the original one for $\xi \in\left[\xi\left(y_{0}, 1[\right.\right.$. Hence it is the extension of our solution in the new region of convergence. This is an important feature, because it helps to have an overlapping region between the most decreasing solution at $-\infty$ and the most decreasing solution at $+\infty$.

We introduce $z_{j}$ and $m_{p}$ through

Assume this theorem is proven. We show that, for all $\xi_{0}$, there exists $\alpha_{0}\left(\xi_{0}\right)$ such that, for $\alpha<\alpha_{0}\left(\xi_{0}\right)$ the power series is convergent for $\xi \in\left[\xi_{0}, 1\right]$. Consider now $\frac{\alpha}{\xi^{\nu}} R<1$ and $\frac{\alpha}{\xi^{\nu}} M<1$. The power series $\sum_{j \geq 1} a_{p, j}(\xi) \frac{\alpha^{j}}{\xi^{\nu j+\delta_{p}}}$ defines an analytic function which is the analytic extension of the sum of the normally convergent series $\sum_{j \geq 1} \frac{\alpha^{j}}{\xi^{\nu j+d}+d_{c}} a_{p, j}(\xi)$ for $\alpha<\alpha_{1}\left(\xi_{0}\right)$ and $\xi \in\left[\xi_{0}, 1\right]$. A similar result holds for the series $\sum_{j \geq 1} b_{l, j}(\xi) \frac{\alpha^{j}}{\xi^{\nu j+\delta_{l}}}$.

The proof of item 1) of the theorem is in Annex 7 . We calculate in the first subsection of the present section the first order terms of $z$ and $m$.
In the second subsection, we prove by recurrence the structure of the $j-$ th term of the expansion of $z$ and $m$, which is a consequence of the structure of the system. We deduce the precise estimates wich help us to extend the expansion.

### 3.1 A new formulation of the system

We introduce $Z_{j}, 1 \leq j \leq 4$ and $m_{p}, 1 \leq p \leq 6$ given by

The relation $w_{+}^{(2)} e^{y} e^{-\alpha \mu(\alpha) y} \rightarrow F_{-}(1) \wedge E_{a,-}(1)=W_{+}$imply that $z_{j} \rightarrow W_{+, j}$ because $\frac{\xi}{(1-\xi) e^{y}} \rightarrow 1$ when $y \rightarrow+\infty$. The system on $Z, M$ writes

In what follows, we describe the analytic expansion of the solution in $\alpha$ when $\alpha$ is in a neighborhood of 0 .

### 3.2 First terms of the expansion in $\alpha$

As the solution going to 0 at infinity of $\frac{d f}{d y}=\frac{1-\xi}{\xi}$ is $f(y)=\frac{1}{\nu+1}\left(1-\frac{1}{\xi^{\nu+1}}\right)$, direct estimates of the behavior in $\xi$ of a coefficient $u_{j}$ or $m_{j}$ of (65) lead to a multiplying factor of the form

The previous quick analysis would suggest that $a_{p, j+1}$ is of order $\frac{1}{\xi}$ when every $a_{k, j}, b_{l, j}$ is bounded when $\xi$ goes to 0 . This is not the case, and the crucial equality states as follows. We introduce the diagonal matrix $T$ such that

The regularity of the quantities $a_{p, j}, b_{q, j}$ is given by the following proposition, which gives precise estimates on the functions provided that $\beta$ and $\gamma$ stay in a compact set:

Moreover, from proposition 3, for all $\xi_{0}$ there exists $R$ depending only on $\beta_{0}$ such that for $\zeta<\frac{1}{R}$ the functions $A_{p}(\zeta, \alpha)$ and the functions $B_{q}(\zeta, \alpha)$ given in Proposition 4 are analytic through their expansion in $\alpha$ for $\zeta<\frac{1}{R}$.

By uniqueness of the solution which is analytic in $\alpha$, we check that this function is also solution of the system (65) for $\alpha<\alpha_{1}\left(\xi_{0}\right)$ and $\xi(y) \in\left[(\alpha R)^{\frac{1}{\nu}}, \xi_{0}\right]$, because the analytic expansion defining the solution in the set-up of the gap lemma can be rearranged and the remainder term is regular enough (and uniformly bounded), and because the two solutions are equal at the point $\tilde{y}$ such that $\xi(\tilde{y})=\frac{1+\xi_{0}}{2}$.

Hence we extended the solution for $\xi$ in the interval $\left[(\alpha R)^{\frac{1}{\nu}}, 1\right]$. Proposition 4 is thus a consequence of Proposition 3 .

Proof of Proposition 3 We prove by recurrence the inequalities (71), (72), (73) below:

## 4 The simplest discontinuity model

Before studying the coupling between the hypergeometric region and the overdense region, we shall in this section study a simple model where the profile of density is

As the leading order term in $\alpha$ of the solution in the region $\left[y_{0},+\infty[\right.$ in the case where $y_{0}$ is independant of $\alpha$ is given by the leading order term of $f_{-}(1) \wedge E_{a,-}(1)$, we find $i_{4} \wedge E_{a,-}(1)=W_{+}$as leading order term. The Evans function is

Remark This result is somewhat surprising: in fact when $\xi_{0} \rightarrow 0$ the limit of the growth rate disappears because it becomes negative: in the previous equality $\xi_{0}$ must verify

It is easy to check that this is never satisfied if $\beta^{2}>\max _{\left.\left.\xi_{0} \in\right] 0,1\right]}\left(\xi_{0}^{2} \frac{1-\xi_{0}}{1+\xi_{0}}\right)$ and is satisfied only in a region $\xi_{-}(\beta), \xi_{+}(\beta)$ for $\beta^{2}<\max _{\left.\left.\xi_{0} \in\right] 0,1\right]}\left(\xi_{0}^{2} \frac{1-\xi_{0}}{1+\xi_{0}}\right)$.

We may thus conclude that this model is not relevant according to the physical results.

## 5 Solution in the hypergeometric region

In this section, we identify the solution when $y$ goes to $-\infty$. We show a result for $t \leq t_{0}$ finite. As the coefficients behave as $|y|^{-\frac{1}{\nu}}$, we call this problem a Fuchsian problem, and, as the leading term of the equation leads to a hypergeometrical equation, we call this the hypergeometrical set-up. We introduce

The aim of what follows is to identify the family of solutions of (GS) such that $Y_{*}(t) \simeq c t^{M} E_{0}$ when $t \rightarrow+\infty$, where $M=\frac{N_{11}}{\nu}$ and $E_{0}$ is the eigenvector associated with $\lambda_{1}(p)$.

Remark The result that we obtain here depends heavily on the fact that the non zero eigenvalues of $\Lambda(p)$ denoted by $\lambda_{i}(p)$ satisfy

The aim of the next paragraph is to construct iteratively the solution of the system (96). We use the methods of Levinson 18 and Hartmann 11.

### 5.2 Formal solution of the system

It is necessary to begin with the computation of $U_{m}$, solution of

Hence it is necessary (but not sufficient) that $U_{m}(t) e^{-\phi_{m}(t)} t^{-\frac{N_{m m}}{\nu}}$ goes to 0 when $t$ goes to infinity.

$\psi \in C^{\infty}\left(\left[t_{0},+\infty[), \psi^{\prime}(t)-\Re \phi_{m-e}^{\prime}(t) \leq-\varepsilon_{0}<0, t \geq t_{0}, t^{2}\left|\psi^{\prime \prime}(t)\right|\right.\right.$ bounded on $\left[t_{0},+\infty[\right.$.
These notations being introduced, we consider the operator

K^{(1)}(f)=-t^{\frac{N_{11}}{\nu}} \int_{t}^{+\infty} \frac{1}{\nu s} s^{-\frac{N_{11}}{\nu}}\left(M_{11}^{(m-1)}-N_{11}\right)(f)(s) d s

The equation that we intend to solve is

We notice that $\frac{1}{\nu s} s^{-\frac{N_{11}}{\nu}}\left(M_{11}^{(m-1)}-N_{11}\right)(f) \in L^{1}\left(\left[t_{0},+\infty[)\right.\right.$ as soon as $f \in$ $\Lambda_{\frac{N_{11}}{\nu}}^{0}\left(t_{0}\right)$. Moreover, for $t_{0}^{0}$ given, there exists a constant $C_{0}$ such that

Assume $\alpha \leq \alpha_{0}$ given. There exists a value of $t^{0}$, given by

hence the behavior when $\alpha \rightarrow 0$.

## 6 The instability growth rate

This section relies on the relation (58) that we obtained in the third section. The scope of the present section is to derive a limit, when $\alpha \rightarrow 0$ of the Evans function $E v(\alpha, \beta, \gamma)$. As the right hand side of (58) depends on $t$, and the left hand side of (58) is independant of $t$, we will study, for a given (suitable) $t>0$, the limit when $\alpha \rightarrow 0$ of the right hand side of (58). This corresponds to the calculus of the limit when $\alpha \rightarrow 0$ of the functions $z_{1}, \xi(y) z_{p}(p=2,3,4), \xi(y) m_{l}$, $(l=1,2,3), \xi^{2}(y) m_{l}, l=4,5,6$ and $R_{j}(t, \alpha), L_{k}(t, \alpha)$ for $y=-\frac{t}{\alpha \beta}$. Recall that we restrict ourselves to the regime $\alpha \rightarrow 0, \beta, \gamma$ in a fixed compact set.
In all what follows, we introduce

### 6.1 Calculus in the overlapping region

Introduce $t_{*}>0$ given such that

$$

hence the limit when $\alpha \rightarrow 0$ of this quantity is 1 .
For $\beta_{0}$ given and $\xi_{0}=\frac{1}{2}$, we identify $\alpha_{0}$ such that, for $\alpha \leq \alpha_{0}$ and $\zeta<\frac{1}{R}$, the asymptotic series defining $z_{j}, m_{p}$ converges to an analytic function. As $\zeta\left(t_{*}, 0\right)=\frac{\nu t_{*}}{\beta}$, if one chooses $0<\frac{\nu t_{*}}{\beta}<\frac{1}{2 R}$, that is $0<t_{*}<\frac{\beta}{2 \nu R}$, there exists $\alpha_{1}>0$ such that, for $\alpha \leq \alpha_{1}, \zeta\left(t_{*}, \alpha\right) \leq \frac{3}{4 R}<\frac{1}{R}$.
For $t \in\left[\frac{t_{*}}{2}, t_{*}\right]$, and $\alpha \leq \alpha_{1}, \zeta(t, \alpha) \leq \frac{3}{4 R}$, hence the functions $\left(\xi\left(-\frac{t}{\alpha \beta}\right)\right)^{\frac{\delta_{p}}{\nu}} z_{p}\left(-\frac{t}{\alpha \beta}\right)$ and $\left(\xi\left(-\frac{t}{\alpha \beta}\right)\right) \frac{d_{q}}{\nu} m_{q}\left(-\frac{t}{\alpha \beta}\right)$ are well defined through the expansion of section
3. Moreover, for $t \geq \frac{t_{*}}{2}$ there exists $C\left(\frac{t_{*}}{2}\right)$ such that (91) holds. Hence for $t \in\left[\frac{t_{*}}{2}, t_{*}\right]$ we have the limit of the functions $R_{p}$ and $L_{k}$ when $\alpha \rightarrow 0$. We are now ready to prove our main Theorem:

Theorem 4 Let $M$ be given. There exists $\alpha_{*}>0$ such that, for $0<\alpha<\alpha_{*}$, $\beta \in\left[\frac{1}{M}, M\right]$ and $|\gamma| \leq M, \Re \gamma \geq 0$, the Evans function of the system $\operatorname{Ev}(\alpha, \beta, \gamma)$ does not vanish.

Proof Recall that we proved that

E v(\alpha, \beta, \gamma)=E v_{0}(\beta, \gamma)+\alpha^{\frac{1}{\nu}} E v_{1}(\beta, \gamma, \alpha)
$$

The value of $E v_{0}(\beta, \gamma)$ (which is expressed through (112), (114)) does not depend on $t_{*}$. Letting the leading order term of $E v_{0}(\beta, \gamma)$ go to 0 when $t_{*} \rightarrow+\infty$ (which gives, of course, the value of $E v_{0}(\beta, \gamma)$ because it does not depend on $t_{*}$ ) yields $r=1$ as only possible positive solution for $E v(0, \beta, \gamma)=0$ (see (126)). However, for $r=1$ the remaining leading order term in $t_{*}$ of $E v(0, \beta, \gamma)$ is not zero (see (127)), hence a contradiction.
The system of Kull-Anisimov has no bounded complex growth rate $\gamma$ when $\operatorname{Fr}=O\left(\frac{1}{\varepsilon}\right)$ in the limit $\varepsilon \rightarrow 0$. To be more precise, recall that

& +\xi z_{4}\left(R_{4}-\frac{\gamma}{\beta} L_{3}-\frac{\xi}{\beta^{2}} L_{5}-L_{6}\right) \\
& \left.+\frac{\xi}{1-\xi}\left(m_{1} L_{1}+m_{2} L_{2}+m_{3} L_{3}\right)+\frac{\xi^{2}}{1-\xi}\left(m_{4} L_{4}+m_{5} L_{5}+m_{6} L_{6}\right)\right] . \tag{112}

We introduce $\bar{A}_{p}(\zeta, \alpha), \bar{B}_{q}(\zeta, \alpha), 1 \leq p \leq 4,1 \leq q \leq 6$ the functions given by

We proved in Section 3 that the solution $w_{+}^{(2)}$ of (42) which behaves as $e^{\left(\lambda_{-}(1)-\alpha \beta\right) y}$ when $y \rightarrow+\infty$, satisfying the condition (49) is given through the relation (59) $\sum_{j=1}^{4} z_{j} f_{j}+\sum_{p=1}^{6} m_{p} g_{p}=e^{-\alpha \mu(\alpha) y} T^{(2)} w_{+}^{(2)}$, where $\left(z_{j}, m_{p}\right)$ are given by Proposition 4 through

Equality (58) for a $t$ such that $\zeta(t, \alpha)<\frac{1}{R}$, along with $\xi=\alpha^{\frac{1}{\nu}} \zeta(t, \alpha)^{-\frac{1}{\nu}}$ yields

E v(\alpha, \beta, \gamma) & =e^{-\left(2+\frac{\mu(\alpha}{\beta}\right) t} t \frac{1}{2 \nu} \exp \left(-\int_{0}^{-\frac{t_{0}}{\alpha \beta}} \alpha \gamma \xi\left(y^{\prime}\right) d y^{\prime}\right) \frac{1-\xi(0)}{\xi(0)} \beta \\
& {\left[\left(1+\zeta \bar{A}_{1}\right)\left(R_{1}-\frac{\xi}{\beta^{2}} L_{1}-L_{2}\right)+\left(\xi(r-1)+\zeta \bar{A}_{2}\right)\left(R_{2}+\frac{\gamma}{\beta} L_{1}-L_{4}\right)\right.} \\
& +\left(\xi+\zeta \bar{A}_{3}\right)\left(R_{3}+\frac{\gamma}{\beta} L_{2}-\frac{\xi}{\beta^{2}} L_{4}\right)+\left(-\xi+\zeta \bar{A}_{4}\right)\left(R_{4}-\frac{\gamma}{\beta} L_{3}-\frac{\xi}{\beta^{2}} L_{5}-L_{6}\right) \\
& +\frac{\zeta}{1-\xi}\left[\bar{B}_{1} L_{1}+\bar{B}_{2} L_{2}+\bar{B}_{3} L_{3}+\bar{B}_{4} L_{4}+\bar{B}_{5} L_{5}+\bar{B}_{6} L_{6}\right] .

We proved in Section 5 that the unique solution $U_{0}(t, \alpha)$ of the system (85) satisfying the uniqueness condition (90) is

and the functions $R_{j}$ and $L_{p}$ given by (56) satisfy the estimates

$$

Note that the limit of the quantities $R_{j}^{0}$ (as well as $R_{j}$ when $t \rightarrow+\infty$ ) is known. We now consider the equality on $\operatorname{Ev}(\alpha, \beta, \gamma)$ when $\alpha \rightarrow 0$. The right hand side is independant of $t$ because the left hand side is independant of $t$. Hence its value can be considered at $t_{*}$. Once $t_{*}$ is fixed, we get the limit by taking $\alpha=0$, hence, using $\frac{\mu(0)}{\beta}=-r-1$

where the relations are written at $t=t_{*}$ and at $\zeta=\zeta\left(t_{*}, 0\right)=\frac{\nu t_{*}}{\beta}$.
Let $A_{p, j}$ and $B_{q, j}$ being given through

It is easy from this system to deduce that, under the hypothesis $|r| \leq M^{-2}$, there exists a constant $C>0$ such that $\sum_{p=1}^{4}\left|A_{p, j}\right|+\sum_{q=1}^{6}\left|B_{q, j}\right| \leq\left(\frac{C}{\nu}\right)^{j} \frac{1}{j!}$, hence ensuring that the analytic expansions defining $\bar{A}_{p}^{0}$ and $\bar{B}_{q}^{0}$ are extendible for all $\zeta$. The study of this recurrence system is the aim of the next paragraph.

### 6.2 Behavior of the equivalent solution

In what follows, we study the recurrence system.

The coefficients $A_{p, j}, B_{q, j}$ are the coefficients in the expansion in $\varepsilon(\xi(y))^{-\nu}$ of $H$, where $\xi(y)^{-\nu}=\nu y$. The vector $\left(\zeta \bar{A}_{p}^{0}, \zeta \bar{B}_{q}^{0}\right)$ is equal to $H\left(\frac{\beta \zeta}{\nu \varepsilon}\right)$ for $\zeta=\xi(y)^{-\nu}$.

We need to obtain the relation with the asymptotic expansion in $\alpha \beta$ of Section 3. For this purpose, we introduce $t=\varepsilon y$. We consider the following function, which will be tentatively a solution of (118)

Z_{p}(y)=\sum_{j \geq 1} A_{p, j}^{\prime} \varepsilon^{j}(\xi(y))^{-\nu j-1}, p=2,3,4 \\
M_{q}(y)=\sum_{j \geq 1} B_{q, j}^{\prime} \varepsilon^{j}(\xi(y))^{-\nu j-1}, q=1,2,3 \\
M_{l}(y)=\sum_{j \geq 1} B_{l, j}^{\prime} \varepsilon^{j}(\xi(y))^{-\nu j-2}, l=4,5,6 .
\end{array}\right.
$$

Consider for example the first equation of (120). It rewrites

If we want to obtain $\left(A_{p, j}^{\prime}, B_{q, j}^{\prime}\right)$ independant on $\xi(y)$, it is a natural choice to write

where $\left(A_{p, j}^{\prime}, B_{q, j}^{\prime}\right)$ are the coefficients of the expansion in $\varepsilon$ of the solution of (118) with the source term (119) whereas $\left(A_{p, j}, B_{q, j}\right)$ are the coefficients of the expansion in $\zeta$ of $\left(\bar{A}_{p}^{0}, \bar{B}_{q}^{0}\right)$. Lemma $\mathrm{T}^{\text {is }}$ proven.

Reduction of the problem Let us study the matrix $B_{0}$. Its eigenvalues are 0,1 , and -1 and that associated eigenvectors are

We rewrite a solution $V$ of $\frac{d V}{d y}=\varepsilon B_{0} V$ as

$\frac{d V}{d y}=\frac{d V_{0}}{d y} e_{0}+\frac{d V_{1}}{d y} e_{1}+\frac{d W_{1}}{d y} f_{1}+\frac{d V_{-1}}{d y} e_{-1}+\frac{d W_{-1}}{d y} f_{-1}+\left(V_{0}+W_{1}+W_{-1}\right) \frac{d \xi}{d y} i_{1}+\frac{d \xi}{d y} \xi^{-2}\left(V_{1}+V_{-1}\right) i_{2}$,
hence the associated system is

\frac{d W_{1}}{d y}=\varepsilon W_{1}-\varepsilon \frac{1}{2} \frac{d \xi}{d y}\left[\xi^{-1}\left(V_{0}+W_{1}+W_{-1}\right)+\xi^{-2}\left(V_{1}+V_{-1}\right)\right] \\
\frac{d V_{-1}}{d y}=-\varepsilon V_{-1}-\varepsilon \frac{1}{2} \frac{d \xi}{d y}\left(V_{0}+W_{1}+W_{-1}\right) \\
\frac{d W_{-1}}{d y}=-\varepsilon W_{-1}-\varepsilon \frac{1}{2} \frac{d \xi}{d y}\left[\xi^{-1}\left(V_{0}+W_{1}+W_{-1}\right)+\xi^{-2}\left(V_{1}+V_{-1}\right)\right]

& =A_{1}\left(e_{1}+e_{-1}+\frac{1}{\xi} R_{0}\right) \wedge\left(e_{1}-e_{-1}\right)+\left(r A_{2}-B_{1}\right) R_{0} \wedge\left(e_{1}+e_{-1}\right)+A_{2} R_{0} \wedge\left(e_{1}-e_{-1}\right) \\
& +\left(r A_{3}-B_{2}\right)\left(F_{1}-F_{-1}\right) \wedge\left(e_{1}+e_{-1}+\frac{1}{\xi} R_{0}\right)+A_{3}\left(F_{1}-F_{-1}\right) \wedge\left(e_{1}-e_{-1}\right)+ \\
& \left(r A_{4}+B_{3}\right)\left(e_{1}+e_{-1}+\frac{1}{\xi} R_{0}\right) \wedge\left(F_{1}-F_{-1}-\xi\left(e_{1}+e_{-1}\right)\right) \\
& +A_{4}\left(e_{1}+e_{-1}\right) \wedge\left(F_{1}+F_{-1}-\xi\left(e_{1}+e_{-1}\right)\right) \\

we deduce a new basis of $\Lambda^{2}\left(\mathbb{R}^{5}\right)$ in which the coefficients are $A_{1}, r A_{2}-B_{1}, A_{2}$, $r A_{3}-B_{2}, A_{3}, r A_{4}+B_{3}, A_{4}, B_{4}, B_{5}, B_{6}$. The source term (119) in the basis of $\Lambda^{2}\left(\mathbb{R}^{5}\right)$ associated with $e_{0}, e_{ \pm 1}, F_{ \pm 1}$ we find

End of the proof The coefficient of $e_{1} \wedge F_{1}$ in the source term is thus

The leading order term in $t_{*}$ of the Evans functions $\operatorname{Ev}(0, \beta, \gamma)$ writes

& +\tilde{A}_{3}^{0}\left(R_{3}^{0}+r L_{2}^{0}\right)+\tilde{A}_{4}^{0}\left(R_{4}^{0}-r L_{3}^{0}-L_{6}^{0}\right) \\
& \left.\left.+\tilde{B}_{1}^{0} L_{1}^{0}+\tilde{B}_{2}^{0} L_{2}^{0}+\tilde{B}_{3}^{0} L_{3}^{0}+\tilde{B}_{4}^{0} L_{4}^{0}+\tilde{B}_{5}^{0} L_{5}^{0}+\tilde{B}_{6}^{0} L_{6}^{0}\right]\right]
\end{aligned}
$$

where $\tilde{A}_{p}^{0}\left(t_{*}\right)=\bar{A}_{p}^{0}\left(\zeta\left(t_{*}, 0\right)\right) e^{-2 t_{*}} t_{*}^{-\alpha_{*}}, \tilde{B}_{q}^{0}\left(t_{*}\right)=\bar{B}_{q}^{0}\left(\zeta\left(t_{*}, 0\right)\right) e^{-2 t_{*}} t_{*}^{-\alpha_{*}}$. Hence, as

-e_{1} \wedge F_{1}=-\xi f_{1}+f_{2}-f_{3}+f_{4}+r g_{1}+(1-r)\left(g_{2}+g_{3}\right)-\frac{1}{\xi}\left(g_{4}+g_{5}\right)

and the limit of $\left(R_{p}^{0}, L_{q}^{0}\right)$ when $t_{*} \rightarrow+\infty$ is given by (50), the limit of

E v(0, \beta, \gamma)\left(e^{(r+1) t_{*}} t_{*}^{\frac{1}{2 \nu}} t_{*}^{\alpha_{*}} \frac{1-\xi(0)}{\xi(0)} \beta\right)^{-1}
$$

is

(r-1)\left(-\frac{r+1}{\nu}+\frac{1}{\nu+1}\right) . \tag{126}

As we seek positive values of $r$, the factor $e^{(r+1) t_{*}}$ goes to infinity when $t_{*} \rightarrow$ $+\infty$, hence this limit is necessarily 0 . The two possible values of $r$ are thus $r=1$ and $r=-\frac{1}{\nu+1}$, hence $r=1$.

We also check that, for $r=1$, the projection of $F_{0}(y)$ on the space associated with the eigenvalue +1 of $B_{0}^{(2)}$, space generated by $e_{1} \wedge e_{0}$ and $F_{1} \wedge e_{0}$, is $\left(\frac{1}{\nu} \xi^{-\nu-1}+\frac{1}{2(\nu+1)} \xi^{-\nu-2}\right) e_{1} \wedge e_{0}$. We have the relations

The leading order term of the projection on this space is 0 . We get $e_{1} \wedge e_{-1} \wedge S=$ $-4 i_{1} \wedge i_{2} \wedge i_{3} \wedge i_{4} \wedge i_{5}$ because $e_{1} \wedge e_{-1}=-2 f_{1}+\frac{2}{\xi} f_{2}+\frac{2}{\xi} g_{1}$, and similarily $e_{1} \wedge F_{-1} \wedge S=0, e_{-1} \wedge F_{1} \wedge S=-2 i_{1} \wedge i_{2} \wedge i_{3} \wedge i_{4} \wedge i_{5}, F_{1} \wedge F_{-1} \wedge S=0$. As the vector $F_{0}(y)$ has the following projection on the eigenspace associated with the eigenvalue 0

the associated leading order term gives a non-zero contribution, hence a contradiction. The main theorem is proven.

## 7 Annex: Volterra type expansions of solutions of differential systems

We consider a solution of (33) associated with the growth rate $\lambda_{-}(1)-\alpha \beta$, which is the eigenvalue of smallest real part $-M_{0}^{(2)}(+\infty)$. We recall that there exists a regular function $\mu(\alpha)$ such that

Proposition 6 Let $U$ be the solution going to $(1,0, \ldots, 0)$ at $+\infty$ of the model system:

$$

where the properties of the complex numbers $\lambda_{j}$ and of the functions $N_{j k}$ are the following

The function $U$ is given by

Note that, in the hypothesis, $N_{d d}=0$ is only there for simplicity purposes and is obtained by considering in the last equation (in which we should have $\left.(1-\xi) N_{d d}=\xi^{\prime} \frac{N_{d d}}{\xi^{\nu+1}}\right)$ the conjugation by the exponential of the primitive of $\frac{N_{d d}}{\xi^{\nu+1}}$.

Construction by recurrence of the Volterra operators We prove Proposition 6 by recurrence. Consider the last equation (line $d$ of the previous system). We have

As $U_{d}$ is bounded, the limit of $U_{d} e^{-\lambda_{d} y}$ is zero, otherwise $U_{d}$ would not be bounded. Integrating from $y$ to $y_{0}$ and letting $y_{0}$ go to infinity, we have

we obtain

U_{d}(y)=(1-\xi(y)) \sum_{k=1}^{d-1} K_{d j}^{(1)}\left(U_{j}\right)(y) \tag{130}
\end{equation*}
$$

Let us study the properties of $K_{d j}^{(1)}$.
Consider $U$ such that, for $\xi \geq \xi_{0}$ (and $y_{0}$ such that $\left.\xi_{0}=\xi\left(y_{0}\right)\right)$ we have the estimate

We obtain easily the estimate (thanks to $\lambda_{d-p} \geq 0$ )

Replacing (130) in the $d-1$ first equations of the differential system of Proposition 6, we obtain

We get the estimate, under the assumption (131) on $U$

where $M_{1}=M_{0}\left(1+\frac{M_{0}}{(N+1) \xi_{0}^{\nu+1}}\right)$. The procedure proceeds as follows:
Let $p$ be an element of $0 . . d-2$. We write the sequence of operators $K_{d-p, k}^{(p+1)}$, $1 \leq k \leq d-p-1$, and $N_{j k}^{(p+1)}, j \leq d-p-1, k \leq d-p-1$ such that

N_{j k}^{(p+1)}\left(U_{k}\right)=N_{j k}^{(p)}\left(U_{k}\right)+(1-\xi(y))^{-1} N_{j, d-p}^{(p)}\left((1-\xi) K_{d-p, k}^{(p+1)}\left(U_{k}\right)\right) \tag{135}
\end{equation*}
$$

and the operators $K_{d-p, k}^{(p+1)}$ are constructed as follows using the auxiliary problem

This can be written, using $g(y)=V(y) e^{-\lambda_{d-p} y}$, under the form

(1-\xi(y)) K_{d-p, k}^{(p+1)}\left(U_{k}\right)=T_{d-p}\left((1-\xi) N_{d-p, k}^{(p)}\left(U_{k}\right)\right) . \tag{139}
\end{equation*}
$$

Construction of the solution The last step of this recurrence is to construct the solution $U_{1}$. The equation on $U_{1}$ writes then

$$
\begin{equation*}
\frac{d U_{1}}{d y}=(1-\xi(y)) N_{11}^{(d-1)}\left(U_{1}\right) \tag{140}
\end{equation*}
$$

where $N_{11}^{(d-1)}$ satisfy the relations of Proposition 7. This is equivalent to

$$
U_{1}(y)-U_{1}\left(y_{0}\right)=\int_{y_{0}}^{y}(1-\xi(s)) N_{11}^{(d-1)}\left(U_{1}\right)(s) d s
$$

Using the limit $U_{1}\left(y_{0}\right) \rightarrow 1$ when $y_{0} \rightarrow+\infty$, we obtain

$$
U_{1}(y)=1+\int_{+\infty}^{y}(1-\xi(s)) N_{11}^{(d-1)}\left(U_{1}\right)(s) d s
$$

We introduce the operator $K^{1}$ such that $U_{1}=1+K_{1}\left(U_{1}\right)$. For $g$ satisfying the estimate (131), a consequence of proposition 7 is that

$$
\left|K^{1}(g)(y)\right| \leq \frac{M C}{\xi_{0}^{\nu+1}(N+1)}(1-\xi(y))^{N+1} .
$$

Introduce $U_{1}^{0}(y)=1$, and the sequence $U_{1}^{N}=K^{1}\left(U_{1}^{N-1}\right)$. It is straightforward to show the inequality for $y \geq y_{0}$

$$
\left|U_{1}^{N}(y)\right| \leq\left(\frac{M}{\xi_{0}^{\nu+1}}\right)^{N} \frac{1}{N!}(1-\xi(y))^{N}
$$

hence as the series $\sum_{N=0}^{\infty}\left(\frac{M}{\xi_{0}^{\nu+1}}\right)^{N} \frac{1}{N!}(1-\xi(y))^{N}$ is normally convergent for $y \geq$ $y_{0}$, the series $\sum_{n=0}^{\infty} U_{1}^{N}(y)$ is normally convergent and is the only solution going to 1 as $y$ goes to $+\infty$ of (140). We have the estimate

$$
\left|U_{1}(y)\right| \leq \exp \left(\frac{M}{\xi_{0}^{\nu+1}}\right)
$$

which is of the form (131) for $N=0$.

End of the construction As $U_{1}$ satisfies an estimate of the form (131) for $N=0$, from the definition of the operators $K_{d-p, k}^{(p+1)}$ we deduce that

$$
U_{2}(y)=(1-\xi(y)) w_{2}(y)
$$

where $\left|w_{2}(y)\right| \leq M \exp \left(\frac{M}{\xi_{0}^{\nu+1}}\right)$. Replacing in the equality 133) for $p=d-3$ the inequality on $U_{1}$ and on $U_{2}$ we deduce that

$$
U_{3}(y) \leq M(1-\xi(y)) \exp \left(\frac{M}{\xi_{0}^{\nu+1}}\right)
$$

By recurrence on $p$ we obtain the inequalities on $U_{j}$ for $j \neq 1$, which proves Proposition (6.

Estimates We prove in this Section the following
Proposition 7 The operators $N_{j k}^{(p)}$ and $K_{d-p, k}^{(p+1)}$ satisfy the following estimates for $g$ satisfying (131):

$$
\forall y \geq y_{0},|T(g)(y)| \leq \frac{C M}{\xi_{0}^{\nu+1}(N+1)}(1-\xi(y))^{N}
$$

This is a consequence of the more precise proposition
Proposition 8 Under the assumption $g$ satisfy the estimate (131), the operators $N_{j k}^{(p)}$ satisfy the estimate

$$
\left|N_{j k}^{(p)}(g)(y)\right| \leq C M_{p}(1-\xi(y))^{N}
$$

where $M_{p+1}=M_{p}\left(1+\frac{M_{p}}{\xi_{0}^{\nu+1}} \exp \left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)\right)$ and

$$
\left|T_{d-p}(f)(y)\right| \leq \frac{C}{\xi_{0}^{\nu+1}} \exp \left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)(1-\xi(y))^{N}
$$

We prove the second proposition by recurrence. The first estimate that we have to deduce from the recurrence assumption on $N_{j k}^{(p)}$ is the estimate on $K_{d-p, k}^{(p+1)}$. To obtain this result, we have to study the behavior of $K_{d-p}$ through the estimate on $N_{j k}^{(p)}$. We have, for $f$ satisfying (131) for all $N$, the inequality

$$
\left|K_{d-p}(f)(y)\right| \leq \int_{y}^{\infty}(1-\xi(s))^{N+1} M e^{\lambda_{d-p}(y-s)} d s
$$

As $N+1 \geq 1$, we use $y-s \leq 0$ and $\lambda_{d-p} \geq 0$ to obtain
$\forall y \geq y_{0},\left|K_{d-p}(f)(y)\right| \leq M \int_{y}^{\infty}(1-\xi(s))^{N+1} d s \leq \frac{M}{\xi_{0}^{\nu+1}(N+1)}(1-\xi(y))^{N+1}$.

Note that we increase the power of $(1-\xi(y))$ in the result.
The second estimate is based on the expression of $T_{d-p}$ obtained through (138).
For $N \geq 1$ and $f$ satisfying (131), we have

$$
\left|\int_{y}^{\infty} f(s) e^{-\lambda_{d-p} s} d s\right| \leq C e^{-\lambda_{d-p} y} \frac{(1-\xi(y))^{N}}{N \xi_{0}^{\nu+1}}
$$

The estimate on $K_{d-p}$, deduced from the recurrence hypothesis is

$$
\left|K_{d-p}\left(\int_{y}^{\infty} f(s) e^{-\lambda_{d-p} s} d s\right)\right| \leq C \int_{y}^{\infty}(1-\xi(s))^{N+1} M_{p} d s \leq \frac{M_{p} C}{\xi_{0}^{\nu+1}}(1-\xi(y))^{N+1}
$$

Hence we obtain

$$
\left|\left(K_{d-p}\right)^{l}\left(\int_{y}^{\infty} f(s) e^{-\lambda_{d-p} s} d s\right)\right| \leq C e^{-\lambda_{d-p} y}\left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)^{l} \frac{(1-\xi(y))^{N}}{N+l} \frac{1}{l!}
$$

hence the series $\sum_{l \geq 0} e^{\lambda_{d-p} y}\left(K_{d-p}\right)^{l}\left(\int_{y}^{\infty} f(s) e^{-\lambda_{d-p} s} d s\right)$ is normally convergent. It defines the function $T_{d-p}(f)$ and we have

$$
\left|T_{d-p}(f)(y)\right| \leq C(1-\xi(y))^{N} \exp \left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)
$$

Finally, using this estimate on $T_{d-p}$ as well as the relation (139), for $f$ satisfying (131) we have

$$
\left|(1-\xi(y)) K_{d-p, k}^{(p+1)}(f)\right| \leq C(1-\xi(y))^{N+1} \exp \left(\frac{1}{\xi_{0}^{\nu+1}}\right)
$$

which gives

$$
\left|K_{d-p, k}^{(p+1)}(f)\right| \leq C(1-\xi(y))^{N} \exp \left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)
$$

Using the estimate on $N_{j, d-p}^{(p)}$ we obtain

$$
\left|(1-\xi)^{-1} N_{j, d-p}^{(p)}\left((1-\xi) K_{d-p, k}^{(p+1)}(f)\right)\right| \leq M_{p} C(1-\xi(y))^{N} \exp \left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)
$$

hence

$$
\left|N_{j k}^{(p+1)}(f)(y)\right| \leq C\left(M_{p}+M_{p} \exp \left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)\right)(1-\xi(y))^{N}
$$

If we introduce $M_{p+1}=M_{p}\left(1+\frac{M_{p}}{\xi_{0}^{\nu+1}} \exp \left(\frac{M_{p}}{\xi_{0}^{\nu+1}}\right)\right)$, we thus deduce

$$
\left|N_{j k}^{(p+1)}(f)(y)\right| \leq C M_{p+1}(1-\xi(y))^{N} .
$$

The proposition 8 is proven. As we used the assumption that $\Re \lambda_{d-p}>0$ to ensure that a solution of $(136)$ is given through

$$
\frac{d}{d y}\left(V e^{-\lambda_{d-p} y}\right)=e^{-\lambda_{d-p} y}(1-\xi(y)) N_{d-p, d-p}^{(p)}(V)+f e^{-\lambda_{d-p} y}
$$

hence
$V(y) e^{-\lambda_{d-p} y}-V\left(y_{*}\right) e^{-\lambda_{d-p} y_{*}}=\int_{y_{*}}^{y} e^{-\lambda_{d-p} s}(1-\xi(s)) N_{d-p, d-p}^{(p)}(V)(s)+f(s) e^{-\lambda_{d-p} s} d s$.
If $V e^{-\lambda_{d-p} y}$ has a limit，then this is in contradiction with the fact that $V$ is bounded for $\Re \lambda_{d-p}>0$ ，and this argument is no longer valid if $\lambda_{d-p}=0$ ． Hence this proves that the recurrence stops at $p$ such that $\lambda_{d-p}=0$ hence $p=d-1$ ．The estimates of Proposition $⿴ 囗 ⿱ 一 一 廾$ are valid for $N_{j k}^{(p+1)}$ ，hence the recurrence proceeds till $\Re \lambda_{d-p}>0$ ．This recurrence processus stops for $\lambda_{d-p}=$ 0 because we cannot assert that the equation（136）has bounded solutions going to a constant for $y \rightarrow+\infty$ ．

[^2]:    ${ }^{2}$ Note that the techniques of differential equations allow us only to compute the solution of a differential system with non constant coefficients only when this solution is associated with the largest eigenvalue of the matrix in the neighborhood of $-\infty$ and with the smallest eigenvalue of the matrix in the neighborhood of $+\infty$.
