Finite dimensional comodules over the Hopf algebra of rooted trees

1 Introduction

In [2, 4, 9, 10], a Hopf algebra of rooted trees \mathcal{H}_R was introduced. It was shown that the antipode of this algebra was the key of a problem of renormalization ([11]). \mathcal{H}_R is related to the Hopf algebra \mathcal{H}_{CM} introduced in [5]. Moreover, the dual algebra of \mathcal{H}_R is the enveloping algebra of the Lie algebra of rooted trees \mathcal{L}^1 . An important problem was to give an explicit construction of the primitive elements of \mathcal{H}_R . In [3], a bigradation allowed to compute the dimensions of the graded parts of the space of primitive elements.

The aim of this paper is an algebraic study of \mathcal{H}_R . We first use the duality theorem of [4] to prove a result about the subcomodules of a finite dimensional comodule over the Hopf algebra of rooted trees. Then we use this result to construct comodules from finite families of primitive elements. Furthermore, we classify these comodules by restricting the possible families of primitive elements, and taking the quotient by the action of certain groups. We also show how the study of the whole algebra as a left-comodule leads to the bigrading of [3]. We then prove that \mathcal{L}^1 is a free Lie algebra.

In the next section, we prove a formula about primitive elements of the Hopf algebra of ladders, which was already given in [3], and construct a projection operator on the space of primitive elements. This operator produces the operator S_1 of [3]. Moreover, it allows to obtain a basis of the primitive elements by an inductive process, which answers one of the questions of [3].

The following sections give results about the endomorphisms of \mathcal{H}_R . First, we classify the Hopf algebra endomorphisms using the bilinear map related to the growth of trees. Then we study the coalgebra endomorphisms, using the graded Hopf algebra $gr(\mathcal{H}_R)$ associated to the filtration by deg_p of [3]. We finally prove that $\mathcal{H}_R \approx gr(\mathcal{H}_R)$, and deduce a decomposition of the group of the Hopf algebra automorphisms of \mathcal{H}_R as a semi-direct product.

2 Preliminaries

We will use notations of [3, 4]. Call a *rooted tree* t a connected and simply-connected finite set of oriented edges and vertices such that there is one distinguished vertex with no incoming edge; this vertex is called the root of t . The *weight* of t is the number of its vertices. The fertility of a vertex v of a tree t is the number of edges outgoing from v . A

ladder is a rooted tree such that every vertex has fertility less than or equal to 1. There is a unique ladder of weight i ; we denote it by l_i .

We define the algebra \mathcal{H}_R as the algebra of polynomials over \mathbb{Q} in rooted trees. The monomials of \mathcal{H}_R will be called *forests*. It is often useful to think of the unit 1 of \mathcal{H}_R as an empty forest.

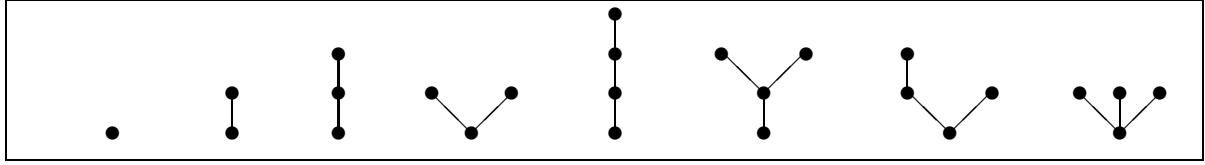


Figure 1: *the rooted trees of weight less than or equal to 4. The first, second, third and fifth trees are ladders.*

We are going to give a structure of Hopf algebra to \mathcal{H}_R . Before this, we define an *elementary cut* of a rooted tree t as a cut at a single chosen edge. An *admissible cut* C of a rooted tree t is an assignment of elementary cuts such that any path from any vertex of the tree has at most one elementary cut. A cut maps a tree t into a forest $t_1 \dots t_n$. One of the t_i contains the root of t : it will be denoted by $R^C(t)$. The product of the others will be denoted by $P^C(t)$. Then Δ is the morphism of algebras from \mathcal{H}_R into $\mathcal{H}_R \otimes \mathcal{H}_R$ such that

$$\text{for any rooted tree } t, \Delta(t) = 1 \otimes t + t \otimes 1 + \sum_{C \text{ admissible cut}} P^C(t) \otimes R^C(t).$$

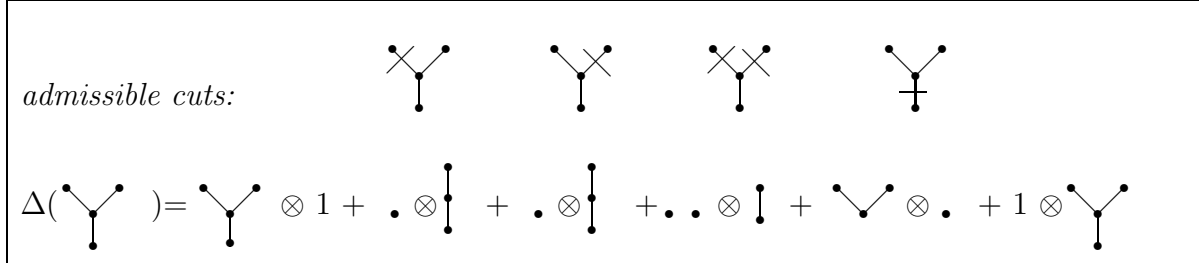


Figure 2: *an example of coproduct.*

The counit is given by $\varepsilon(1) = 1$, $\varepsilon(t) = 0$ for any rooted tree t . Then \mathcal{H}_R is a Hopf algebra, with antipode given by :

$$S(t) = \sum_{\text{all cuts of } t} (-1)^{n_C+1} P^C(t) R^C(t)$$

where n_C is the number of elementary cuts in C .

Moreover, \mathcal{H}_R is graded as Hopf algebra by $degree(t) = weight(t)$.

For example, for all $n \in \mathbb{N}^*$,

$$\Delta(l_n) = 1 \otimes l_n + l_n \otimes 1 + \sum_{j=1}^{n-1} l_j \otimes l_{n-j}.$$

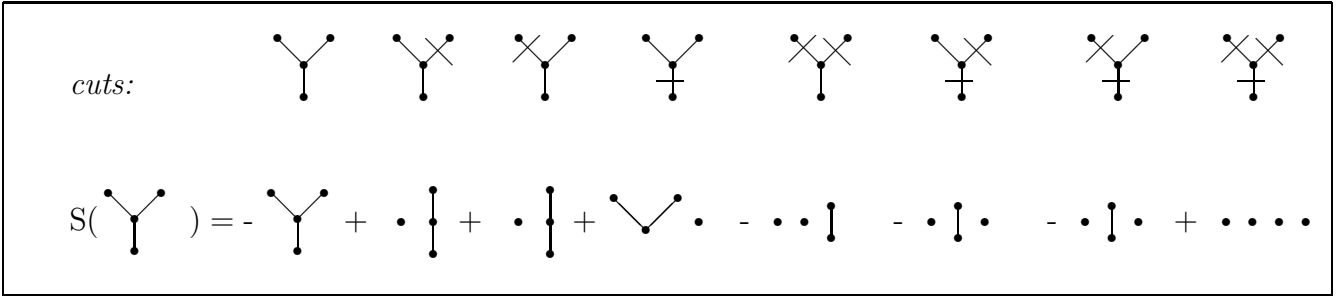


Figure 3: *the antipode.*

So the subalgebra of \mathcal{H}_R generated by the ladders is a Hopf subalgebra; we will denote it by \mathcal{H}_{ladder} .

We will use the Lie algebra of rooted trees \mathcal{L}^1 . It is the linear span of the elements Z_t indexed by rooted trees. For t_1, t_2, t rooted trees, one defines $n(t_1, t_2; t)$ as the number of elementary cuts of t such that $P^C(t) = t_1$ and $R^C(t) = t_2$. Then the Lie bracket on \mathcal{L}^1 is given by:

$$[Z_{t_1}, Z_{t_2}] = \sum_t n(t_1, t_2; t) Z_t - \sum_t n(t_2, t_1; t) Z_t.$$

\mathcal{L}^1 is graded as Lie algebra by $degree(Z_t) = weight(t)$. The enveloping algebra $\mathcal{U}(\mathcal{L}^1)$ is graded as Hopf algebra with the corresponding gradation (see [4]). It is shown in [8, 12] that $\mathcal{U}(\mathcal{L}^1)$ and the Grossman-Larson Hopf algebra on rooted trees are isomorphic (see [6, 7]).

3 Duality between \mathcal{H}_R -comodules and $\mathcal{U}(\mathcal{L}^1)$ -modules

We shall use the following result of [4]:

Theorem 3.1 *There is a bilinear form on $\mathcal{U}(\mathcal{L}^1) \times \mathcal{H}_R$ defined in the following way: for every rooted tree t , for every forest F ,*

$$\begin{aligned} \langle 1, F \rangle &= \varepsilon(F), \\ \langle Z_t, F \rangle &= 0 \text{ if } F \neq t, \\ &= 1 \text{ if } F = t, \end{aligned}$$

$$\text{and } \langle Z_1 Z_2, P \rangle = \langle Z_1 \otimes Z_2, \Delta(P) \rangle \text{ for any } Z_1, Z_2 \in \mathcal{U}(\mathcal{L}^1), P \in \mathcal{H}_R.$$

An easy induction on $weight(P(t_i))$ proves the following property:

Lemma 3.2 *If $l \in \mathcal{U}(\mathcal{L}^1)$ and $P(t_i) \in \mathcal{H}_R$ are homogeneous of different degrees, then $\langle l, P(t_i) \rangle = 0$.*

Let \mathcal{I}_n be the ideal of \mathcal{H}_R generated by the homogeneous elements of weight greater than or equal to n and \mathcal{J}_n the ideal of $\mathcal{U}(\mathcal{L}^1)$ generated by the homogeneous elements of weight greater than or equal to n . Let $\mathcal{H}_R^{*g} = \{f \in \mathcal{H}_R^* / \exists n \in \mathbb{N}, f(\mathcal{I}_n) = (0)\}$ and $\mathcal{U}(\mathcal{L}^1)^{*g} = \{f \in \mathcal{U}(\mathcal{L}^1)^* / \exists n \in \mathbb{N}, f(\mathcal{J}_n) = (0)\}$. One defines an algebra structure on \mathcal{H}_R^{*g} by dualising the coproduct on \mathcal{H}_R and a coalgebra structure on $\mathcal{U}(\mathcal{L}^1)^{*g}$ by dualising the product of $\mathcal{U}(\mathcal{L}^1)$. Then we have the following result:

Corollary 3.3

$$\text{Let } \Phi : \begin{cases} \mathcal{H}_R & \longmapsto \mathcal{U}(\mathcal{L}^1)^{*g} \\ P(t_i) & \longmapsto \langle \cdot, P(t_i) \rangle \end{cases} \quad \text{and let } \Psi : \begin{cases} \mathcal{U}(\mathcal{L}^1) & \longmapsto \mathcal{H}_R^{*g} \\ l & \longmapsto \langle l, \cdot \rangle. \end{cases}$$

Then Φ is a coalgebra isomorphism and Ψ is an algebra isomorphism.

One can now dualise \mathcal{H}_R -comodules and $\mathcal{U}(\mathcal{L}^1)$ -modules. First, we have:

Proposition 3.4 *Let C be a \mathcal{H}_R -comodule and Δ_C its structure map: $C \longmapsto \mathcal{H}_R \otimes C$. Then C^* is a $\mathcal{U}(\mathcal{L}^1)$ -module with:*

$$\forall l \in \mathcal{U}(\mathcal{L}^1), \forall f \in C^*, \forall x \in C, l.f(x) = \sum_{(x)} \langle l, x^{(1)} \rangle f(x^{(2)})$$

$$\text{where } \Delta_C(x) = \sum_{(x)} x^{(1)} \otimes x^{(2)}.$$

Proof: classical; see [14].

Proposition 3.5 *Let M be a $\mathcal{U}(\mathcal{L}^1)$ -module. Let $M^{*g} = \{f \in M^* / \exists n \in \mathbb{N}, f(\mathcal{J}_n M) = (0)\}$. Then M^{*g} is a \mathcal{H}_R -comodule with $\Delta_M : M^{*g} \longmapsto \mathcal{H}_R \otimes M^{*g}$ defined by:*

$$\forall f \in M^{*g}, \forall l \in \mathcal{U}(\mathcal{L}^1), \forall x \in M, \text{ with } \Delta_M(f) = \sum_{(f)} f^{(1)} \otimes f^{(2)} :$$

$$\Delta_M(f).(l \otimes m) = \sum_{(f)} \langle l, f^{(1)} \rangle f^{(2)}(m) = f(l.m).$$

Proof:

$$\text{Let } \alpha : \begin{cases} \mathcal{U}(\mathcal{L}^1)^{*g} \otimes M^{*g} & \longmapsto (\mathcal{U}(\mathcal{L}^1) \otimes M)^* \\ f \otimes g & \longmapsto \begin{cases} \mathcal{U}(\mathcal{L}^1) \otimes M & \longmapsto \mathbb{Q} \\ l \otimes m & \longmapsto f(l)g(m); \end{cases} \end{cases}$$

α is injective. If μ is the structure map of M and μ^* its transpose ($\mu : \mathcal{U}(\mathcal{L}^1) \otimes M \longmapsto M$), we have to show that $Im\mu^* \subset Im\alpha$. With the definition of M^{*g} , one easily has:

$$Im\alpha = \{f \in (\mathcal{U}(\mathcal{L}^1) \otimes M)^* / \exists n \in \mathbb{N}, f(\mathcal{J}_n \otimes M) = (0), f(A \otimes \mathcal{J}_n M) = (0)\}.$$

Let $f \in M^{*g}, l \otimes m \in \mathcal{U}(\mathcal{L}^1) \otimes M$. $\mu^*(f)(l \otimes m) = f(l.m)$. As $f \in M^{*g}$, clearly $\mu^*(f)$ is in $Im\alpha$.

Proposition 3.6 *Let M_1, M_2 two $\mathcal{U}(\mathcal{L}^1)$ -modules, with $M_1 \subset M_2$; there exists an injection of comodules:*

$$(M_2/M_1)^{*g} \longmapsto M_2^{*g}.$$

Proof: let $p : M_2 \longmapsto M_2/M_1$ the canonical surjection; then it is easy to see that its transpose is an injective morphism of comodules from $(M_2/M_1)^{*g}$ to M_2^{*g} .

Proposition 3.7 *Let C a finite-dimensional \mathcal{H}_R -comodule. Then C^* is a $\mathcal{U}(\mathcal{L}^1)$ -module, and $(C^*)^{*g}$ is the whole of $(C^*)^*$. Moreover C and $(C^*)^*$ are isomorphic \mathcal{H}_R -comodules.*

Proof: let $l \in \mathcal{U}(\mathcal{L}^1)$, $f \in C^*$, $x \in C$. Then $(l.f)(x) = \sum_{(x)} \langle l, x^{(1)} \rangle, f(x^{(2)})$.

Let $k_x = \max_{(x)} (\text{weight}(x^{(1)})) + 1$. If l is homogeneous of weight greater than k_x , then $(l.f)(x) = 0$ (lemma 3.2). As C is finite-dimensional, there exists $k \in \mathbb{N}, k \geq k_x \forall x \in C$, hence $\mathcal{J}_k.C^* = (0)$, and hence $(C^*)^{*g} = (C^*)^*$. It is then easy to show that the canonical isomorphism between C and $(C^*)^*$ is a comodule isomorphism.

We are now ready to prove the:

Theorem 3.8 *Let C be a finite-dimensional \mathcal{H}_R -comodule and n its dimension; then C has a complete flag of comodules, that is to say:*

$\forall i \in \{1 \dots n\}, \exists C^{(i)}$ a subcomodule of C of dimension i , with $C^{(1)} \subset \dots \subset C^{(n)} = C$.

Proof: it is enough to exhibit a subcomodule of dimension $n - 1$. By proposition 3.4, C^* is a $\mathcal{U}(\mathcal{L}^1)$ -module, and there exists $k \in \mathbb{N}, \mathcal{J}_k.C^* = (0)$. Hence as a \mathcal{L}^1 -module, $l.C^* = (0)$ for every l in \mathcal{L}^1 , homogeneous of weight greater than n . So C^* is in fact a module over the quotient of \mathcal{L}^1 by the Lie ideal generated by these l , and it is clear that this quotient is a finite-dimensional nilpotent Lie algebra. Moreover, every $l \in \mathcal{L}^1$ is a nilpotent endomorphism of C^* . By Engel's theorem, C^* has a submodule C' of dimension 1. $\mathcal{J}_k.(C^*/C') = (0)$ because $\mathcal{J}_k.C^* = (0)$, so $(C^*/C')^{*g} = (C^*/C')^*$, and the dimension of this comodule is $n - 1$. By proposition 3.7, C is isomorphic to $(C^*)^*$ which has a subcomodule of dimension $n - 1$ by proposition 3.6.

Remark: one can use the fact that \mathcal{L}^1 acts by zero on C' (which is given by Engel's theorem), to show that the quotients $\frac{C^{(i+1)}}{C^{(i)}}$ are trivial comodules, that is to say $\Delta(\bar{x}) = 1 \otimes \bar{x} \forall \bar{x} \in \frac{C^{(i+1)}}{C^{(i)}}$.

4 Natural growth

Let M, N be two forests of \mathcal{H}_R . We define:

$$M \top N = \begin{cases} \frac{1}{\text{weight}(N)} \sum \text{forests obtained by appending } M \text{ to every node of } N & \text{if } N \neq 1 \\ M & \text{if } N = 1. \end{cases}$$

We extend \top to a bilinear map from $\mathcal{H}_R \times \mathcal{H}_R$ into \mathcal{H}_R .

Figure 4: the bilinear map \top .

In the following we use the notation $\tilde{\Delta}(x) = \Delta(x) - 1 \otimes x - x \otimes 1$ for every $x \in \mathcal{H}_R$. We have $\text{Prim}(\mathcal{H}_R) = \text{Ker}(\tilde{\Delta})$.

Lemma 4.1 *Let $x \in \mathcal{H}_R$ and y be a primitive element of \mathcal{H}_R . Then we have:*

$$\tilde{\Delta}(x \top y) = x \otimes y + \sum_{(x)} x^{(1)} \otimes (x^{(2)} \top y)$$

where $\tilde{\Delta}(x) = \sum_{(x)} x^{(1)} \otimes x^{(2)}$.

Proof: see [3], section 5.4.

Definition 4.2 Let $i \in \mathbb{N}^*$ and p_1, \dots, p_i be primitive elements of \mathcal{H}_R . By induction on i we define $p_i \top \dots \top p_1$ by $(p_i \top \dots \top p_2) \top p_1$. And we define:

$$F_i : \begin{cases} \text{Prim}(\mathcal{H}_R)^{\otimes i} & \longmapsto & \mathcal{H}_R \\ p_i \otimes \dots \otimes p_1 & \longmapsto & p_i \top \dots \top p_1. \end{cases}$$

Lemma 4.3 *Let p_1, \dots, p_i be primitive elements of \mathcal{H}_R .*

$$\tilde{\Delta}(p_i \top \dots \top p_1) = \sum_{j=1}^{j=i-1} (p_i \top \dots \top p_{j+1}) \otimes (p_j \top \dots \top p_1).$$

Proof: by induction, using 4.1.

One remarks easily that $\tilde{\Delta}$ is still coassociative. We define $\tilde{\Delta}^0 = \text{Id}_{\mathcal{H}_R} - \eta \circ \varepsilon$, $\tilde{\Delta}^1 = \tilde{\Delta}$, and by induction $\tilde{\Delta}^k = (\tilde{\Delta}^{k-1} \otimes \text{Id}) \circ \tilde{\Delta}$.

Lemma 4.4 *Let $i \in \mathbb{N}^*$; then $\tilde{\Delta}^{i-1} \circ F_i = \text{Id}_{[\text{Prim}(\mathcal{H}_R)]^{\otimes i}}$; if $k > i - 1$, $\tilde{\Delta}^k \circ F_i = 0$. Moreover, F_i is injective, and the sum $(1) + \sum_{i=1}^{\infty} \text{Im}(F_i)$ is direct.*

Proof: one shows the first point by induction, using 4.3. The second point is an immediate corollary. For the last point, let $x_0 \in \mathbb{Q}$, $x_i \in \text{Im}(F_i) \forall i \in \{1 \dots n\}$, with $x_0 1 + x_1 + \dots + x_n = 0$. Then $\varepsilon(0) = x_0 = 0$. Moreover, $\tilde{\Delta}^{n-1}(x_1 + \dots + x_n) = \tilde{\Delta}^{n-1}(x_n) = 0$. As $x_n = F_n(y_n)$ for a certain y_n , we have $y_n = 0$, so $x_n = 0$. One concludes by an induction on n .

5 Construction and parametrization of finite-dimensional \mathcal{H}_R -comodules

Definition 5.1 Let $(i, j) \in (\mathbb{N}^*)^2, i \leq j$. We denote $I_{i,j} := \{i \dots j\}$. A decomposition of $I_{i,j}$ is a partition of $I_{i,j}$ in connected parts. We denote a decomposition in the following way:

$$I_{i_1, j_1} \dots I_{i_k, j_k} \text{ with } i = i_1 \leq j_1 < i_2 \leq \dots < i_k \leq j_k = j;$$

we have $i_{l+1} = j_l + 1$. We denote by $\mathcal{D}_{i,j}$ the set of all decompositions of $I_{i,j}$. There are 2^{j-i} decompositions of $I_{i,j}$.

Proposition 5.2 *Let $n \geq 1$, $(p_{i,j})_{1 \leq i \leq j \leq n}$ any family of $\frac{n(n+1)}{2}$ primitive elements of \mathcal{H}_R . Let C be a vector space of dimension $n + 1$, with basis (e_0, \dots, e_n) . We define:*

$$\begin{aligned} \Delta_C(e_0) &= 1 \otimes e_0; \\ \Delta_C(e_i) &= \left[\sum_{j=0}^{j=i-1} \left(\sum_{I_{i_1, j_1} \dots I_{i_k, j_k} \in \mathcal{D}_{j+1, i}} p_{i_k, j_k} \top \dots \top p_{i_1, j_1} \right) \otimes e_j \right] + 1 \otimes e_i. \end{aligned}$$

Then (C, Δ_C) is a (left) \mathcal{H}_R -comodule. We denote this comodule by $C_{(p_{i,j})}$.

Proof: the axiom of counity is trivial.

Coassociativity: we have to show that $((\Delta \otimes Id) \circ \Delta_C)(e_i) = ((Id \otimes \Delta_C) \circ \Delta_C)(e_i) \forall i$. It is trivial for $i = 0$. For $i \geq 1$, we have:

$$\begin{aligned} ((Id \otimes \Delta_C) \circ \Delta_C)(e_i) &= \sum_{j=0}^{j=i} \sum_{l=0}^{l=j} \left(\sum_{\mathcal{D}_{j+1,i}} p_{i_k, j_k} \top \dots \top p_{i_1, j_1} \right) \otimes \left(\sum_{\mathcal{D}_{l+1,j}} p_{i'_r, j'_r} \top \dots \top p_{i'_1, j'_1} \right) \otimes e_l \\ &= \sum_{l=0}^i \sum_{\mathcal{D}_{l+1,i}} \Delta(p_{i'_s, j'_s} \top \dots \top p_{i'_1, j'_1}) \otimes e_l \text{ (by 4.3)} \\ &= ((\Delta \otimes Id) \circ \Delta_C)(e_i). \end{aligned}$$

The following theorem gives a parametrization of the finite dimensional \mathcal{H}_R -comodules by certain finite families of primitive elements:

Theorem 5.3 *Let (C, Δ_C) be a finite-dimensional comodule. If the dimension of C is 1, then C is trivial, that is to say $\Delta_C(x) = 1 \otimes x \forall x \in C$. If the dimension of C is n , $n \geq 2$, then there is a finite family $(p_{i,j})_{1 \leq i \leq j \leq n}$ of $\frac{n(n+1)}{2}$ primitive elements of \mathcal{H}_R such that C is isomorphic to $C_{(p_{i,j})}$.*

We shall use the following lemma:

Lemma 5.4 *If $x \in \mathcal{H}_R$ is such that $\Delta(x) = x \otimes x$, then $x = 0$ or 1 .*

Proof: suppose $x \neq 0$. As Δ is homogeneous of degree 0, x is of weight 0. It is then trivial that $x = 1$.

Proof of the theorem: let $C^{(0)} \subset \dots \subset C^{(n)}$ be a complete flag of subcomodules, which exists by 3.8, and let (e_0, \dots, e_n) be an adapted basis to this flag. Then we have a family $(Q_{i,j})_{1 \leq j \leq i \leq n}$ of elements of \mathcal{H}_R such that $\Delta(e_i) = \sum_{j=0}^{j=i} Q_{i,j} \otimes e_j$. (If $n = 0$, then $(Q_{i,j})_{1 \leq j \leq i \leq n}$ is empty). The axiom of counity implies that $\varepsilon(Q_{i,i}) = 1$, and $\Delta(Q_{i,j}) = \sum_{l=j}^{l=i} Q_{i,l} \otimes Q_{l,j}$ by the axiom of coassociativity. So by the lemma, $Q_{i,i} = 1 \forall i$, which proves the theorem for $n = 0$. Moreover, $Q_{i,i-1}$ is primitive. If $n = 1$, $C \approx C_{(p_{1,1})}$ with $p_{1,1} = Q_{1,0}$. We end with an induction on n : by induction hypothesis on C' spanned by (e_0, \dots, e_{n-1}) , we have $p_{i,j}$, $1 \leq i \leq j \leq n-1$. With $p_{n,n} = Q_{n,n-1}$, we have $Q_{n,n-1} = \sum_{\mathcal{D}_{n,n}} p_{i_k, j_k} \top \dots \top p_{i_1, j_1}$. Suppose we have built $p_{n,n}, \dots, p_{i+1,n}$, such that $Q_{n,i} = \sum_{\mathcal{D}_{i+1,n}} p_{i_k, j_k} \top \dots \top p_{i_1, j_1}$. Then

$$\begin{aligned} \tilde{\Delta}(Q_{n,i-1}) &= \sum_{l=i}^{l=n-1} \left(\sum_{\mathcal{D}_{l+1,n}} p_{i_k, j_k} \top \dots \top p_{i_1, j_1} \right) \otimes \left(\sum_{\mathcal{D}_{i,l}} p_{i'_r, j'_r} \top \dots \top p_{i'_1, j'_1} \right) \\ &= \sum_{\mathcal{D}_{i,n} - \{I_{i,n}\}} \tilde{\Delta}(p_{i'_s, j'_s} \top \dots \top p_{i'_1, j'_1}). \end{aligned}$$

As $\text{Ker}(\tilde{\Delta}) = \text{Prim}(\mathcal{H}_R)$, we take $p_{i,n} = Q_{n,i-1} - \sum_{\mathcal{D}_{i,n} - \{I_{i,n}\}} (p_{i'_s, j'_s} \top \dots \top p_{i'_1, j'_1})$.

5.6 Remarks:

1. The family $(p_{i,j})$ depends on the choice of the basis (e_0, \dots, e_n) , hence is not unique.

2. By the following, we shall identify $(p_{i,j})_{1 \leq i \leq j \leq n}$ with

$$\begin{bmatrix} 0 & p_{1,1} & \cdots & p_{1,n} \\ \vdots & \ddots & \ddots & \vdots \\ 0 & \cdots & \ddots & p_{n,n} \\ 0 & \cdots & \cdots & 0 \end{bmatrix} = \mathcal{P} \in \mathcal{M}_{n+1}(\text{Prim}(\mathcal{H}_R))$$

where $\mathcal{M}_{n+1}(\text{Prim}(\mathcal{H}_R))$ is the space of square matrices of order $n+1$ with entries in $\text{Prim}(\mathcal{H}_R)$. With the notation of the proof of 5.3, we will write

$$\mathcal{Q} = \begin{bmatrix} Q_{0,0} & 0 & \cdots & 0 \\ \vdots & \ddots & \ddots & \vdots \\ Q_{n-1,0} & \cdots & \ddots & 0 \\ Q_{n,0} & \cdots & \cdots & Q_{n,n} \end{bmatrix} \in \mathcal{M}_{n+1}(\mathcal{H}_R)$$

where $\mathcal{M}_{n+1}(\mathcal{H}_R)$ is the space of square matrices of order $n+1$ with entries in \mathcal{H}_R . Recall that F_i was defined in 4.2. Let π_1 be the projection on $\text{Prim}(\mathcal{H}_R) = \text{Im}(F_1)$ in $(1) \oplus \bigoplus_{i=1}^{i=\infty} \text{Im}(F_i)$. Then $Q_{i,j} \in (1) \oplus \bigoplus_{i=1}^{i=\infty} \text{Im}(F_i)$, and $\pi_1(Q_{i,j}) = p_{j+1,i}$, or in a matricial form: $\mathcal{P} = \pi_1(\mathcal{Q}^T)$ (here π_1 acts on each entry of the matrix).

6 Classification of the finite-dimensional \mathcal{H}_R -comodules

Definition 6.1 Let $(p_{i,j})_{1 \leq i \leq j \leq n}$ be a family of $\frac{n(n+1)}{2}$ primitive elements of \mathcal{H}_R and \mathcal{P} the associated matrix as in the remark 5.6. We say that $(p_{i,j})$ is reduced if there are $c_0, \dots, c_k \in \mathbb{N}^*$ such that:

$$\mathcal{P} = \left[\begin{array}{c|cc|c} 0 & \mathcal{P}_{1,1} & \cdots & \mathcal{P}_{1,k} \\ \vdots & \ddots & \ddots & \vdots \\ \hline 0 & \cdots & \ddots & \mathcal{P}_{k,k} \\ \hline 0 & \cdots & \cdots & 0 \end{array} \right]$$

where the diagonal zero blocs are in $\mathcal{M}_{c_0}(\mathcal{H}_R), \dots, \mathcal{M}_{c_k}(\mathcal{H}_R)$ and the columns in each bloc $\mathcal{P}_{i,i}$, $1 \leq i \leq k$, are linearly independent; (c_0, \dots, c_k) is called the type of $(p_{i,j})$.

Example:

$$\text{Let } \mathcal{P} = \left[\begin{array}{c|cc|cc} 0 & a & b & x & y \\ \hline 0 & 0 & 0 & c & e \\ 0 & 0 & 0 & d & f \\ \hline 0 & 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 & 0 \end{array} \right] \in \mathcal{M}_5(\text{Prim}(\mathcal{H}_R)).$$

Suppose that a and b are linearly independent in the vector space \mathcal{H}_R , and $\begin{pmatrix} c \\ d \end{pmatrix}$ and $\begin{pmatrix} e \\ f \end{pmatrix}$ are linearly independent in the vector space \mathcal{H}_R^2 . Then $(p_{i,j})$ is a reduced family of type (1,2,2).

Definition 6.2 Let C be a \mathcal{H}_R -comodule. One defines $C_0 = \{x \in C / \Delta_C(x) = 1 \otimes x\}$ and, by induction, C_{i+1} the unique subcomodule of C such that

i) $C_i \subset C_{i+1}$;

ii) $\frac{C_{i+1}}{C_i} = \left(\frac{C}{C_i}\right)_0$.

If C is finite-dimensional, then by 5.3, C is isomorphic to a $C_{(p_{i,j})}$ and so C_0 is a non-zero subcomodule of C . Moreover, if $i \geq 0$, we have $\frac{C_{i+1}}{C_i} = \left(\frac{C}{C_i}\right)_0$, so $\frac{C_{i+1}}{C_i}$ is non-zero and we get in this way a flag of comodules: there is $k \in \mathbb{N}$, such that $C_0 \subsetneq \dots \subsetneq C_k = C$.

Proposition 6.3 *Let $(p_{i,j})_{1 \leq i \leq j \leq n}$ be a reduced family of primitive elements of type (c_0, \dots, c_k) and (e_0, \dots, e_n) the basis of $C_{(p_{i,j})}$ as described in 5.2. Then for all $l \in \{0 \dots k\}$, $(e_0, \dots, e_{c_0+\dots+c_l-1})$ is a basis of $(C_{(p_{i,j})})_l$.*

Proof: as $\mathcal{P} = \pi_1(\mathcal{Q}^T)$, we can write:

$$\mathcal{Q} = \begin{bmatrix} Id & 0 & \cdots & 0 \\ \mathcal{Q}_{1,0} & \ddots & \ddots & 0 \\ \vdots & \cdots & \ddots & \ddots \\ \mathcal{Q}_{k,0} & \cdots & \mathcal{Q}_{k,k-1} & Id \end{bmatrix}$$

where the diagonal blocs are in $\mathcal{M}_{c_0}(\mathcal{H}_R), \dots, \mathcal{M}_{c_k}(\mathcal{H}_R)$. Because of coassociativity, the elements in the blocs $\mathcal{Q}_{i,i-1}$ are primitive, so $\mathcal{Q}_{i,i-1} = \mathcal{P}_{i,i}^T$ and the rows of the blocs $\mathcal{Q}_{i,i-1}$ are linearly independent. We easily deduce that (e_0, \dots, e_{c_0-1}) is a basis of C_0 . We conclude by induction on n , with the remark that $\frac{C}{C_0}$ is isomorphic to $C_{(p'_{i,j})}$, with:

$$\mathcal{P}' = \begin{bmatrix} 0 & \mathcal{P}_{2,2} & \cdots & \mathcal{P}_{2,k} \\ \vdots & \ddots & \ddots & \vdots \\ 0 & \cdots & \ddots & \mathcal{P}_{k,k} \\ 0 & \cdots & \cdots & 0 \end{bmatrix}$$

so $(p'_{i,j})$ is a reduced family of type (c_1, \dots, c_k) .

Proposition 6.4 *Let C be a comodule of finite dimension with a basis (e_0, \dots, e_n) such that $(e_0, \dots, e_{\dim(C_i)-1})$ is a basis of C_i for $0 \leq i \leq k$. Let $(p_{i,j})$ be the family of primitive elements built as in the proof of 5.3. Then $(p_{i,j})$ is a reduced family of type (c_0, \dots, c_k) , with $c_0 = \dim(C_0)$, $c_i = \dim(C_i) - \dim(C_{i-1})$ for $1 \leq i \leq k$.*

Proof: as $\frac{C_i}{C_{i-1}}$ is trivial, we have:

$$\mathcal{Q} = \begin{bmatrix} Id & 0 & \cdots & 0 \\ \mathcal{Q}_{1,0} & \ddots & \ddots & 0 \\ \vdots & \cdots & \ddots & \vdots \\ \mathcal{Q}_{k,0} & \cdots & \mathcal{Q}_{k,k-1} & Id \end{bmatrix}$$

where the diagonal blocs are in $\mathcal{M}_{c_0}(\mathcal{H}_R), \dots, \mathcal{M}_{c_k}(\mathcal{H}_R)$, and the blocs $\mathcal{Q}_{i,i-1}$ are formed of primitive elements. Suppose the rows of the bloc $\mathcal{Q}_{i,i-1}$ are not linearly independent. Then we can build an element $x \in C_{i+1} - C_i$, with $\Delta_C(x) \equiv 1 \otimes x [\mathcal{H}_R \otimes C_{i-1}]$, hence \bar{x} is a trivial element of $\frac{C}{C_{i-1}}$, which contradicts the definition of C_i . We conclude using the equality $\mathcal{P} = \pi_1(\mathcal{Q}^T)$.

Corollary 6.5 *For any finite-dimensional comodule C , there exists a reduced family $(p_{i,j})$ such that C is isomorphic to $C_{(p_{i,j})}$.*

If $(p_{i,j})$ and $(p'_{i,j})$ are reduced families with $C_{(p_{i,j})}$ and $C_{(p'_{i,j})}$ isomorphic, then $(p_{i,j})$ and $(p'_{i,j})$ have the same type.

In the following, we call "type of a comodule C " the type of any reduced family $(p_{i,j})$ such that C is isomorphic to $C_{(p_{i,j})}$. Given (c_0, \dots, c_k) , we call

$$G_{(c_0, \dots, c_k)} = \left\{ \left[\begin{array}{c|c|c|c} g_{0,0} & g_{0,1} & \cdots & g_{0,k} \\ \hline \vdots & \ddots & \ddots & \vdots \\ \hline 0 & \cdots & \ddots & g_{k-1,k} \\ \hline 0 & \cdots & \cdots & g_{k,k} \end{array} \right], g_{i,i} \in GL_{c_i}(\mathbb{Q}) \right\} \subset GL_{c_0 + \dots + c_k}(\mathbb{Q}).$$

$G_{(c_0, \dots, c_k)}$ is a parabolic subgroup of $GL_{c_0 + \dots + c_k}(\mathbb{Q})$, and it acts on the set of reduced families of type (c_0, \dots, c_k) by $g \cdot \mathcal{P} = g\mathcal{P}g^{-1}$, where $g \in G_{(c_0, \dots, c_k)}$, and \mathcal{P} is the matrix of a reduced family $(p_{i,j})$.

Theorem 6.6 *Let $(p_{i,j})$ and $(p'_{i,j})$ be two reduced families of primitive elements of \mathcal{H}_R , and (c_0, \dots, c_k) be the type of $(p_{i,j})$. Then $C_{(p_{i,j})} \approx C_{(p'_{i,j})}$ if and only if $(p_{i,j}), (p'_{i,j})$ have the same type and there exists $g \in G_{(c_0, \dots, c_k)}$, such that $\mathcal{P}' = g \cdot \mathcal{P}$.*

Proof: we put $C = C_{(p_{i,j})}, C' = C_{(p'_{i,j})}$.

\Leftarrow : we have $\mathcal{P}' = g \cdot \mathcal{P}$, so $\mathcal{Q} = (g^T)^{-1} \mathcal{Q}' g^T$. Let $(g^T)^{-1} = (a_{i,j})_{0 \leq i, j \leq n}$, $g^T = (b_{i,j})_{0 \leq i, j \leq n}$ and let (f_0, \dots, f_n) be the basis of C defined by $f_i = \sum_j b_{i,j} e_j$. An easy direct computation shows that $\Delta_C(f_i) = \sum_{j,k} (b_{i,j} Q_{j,k} a_{k,l}) \otimes f_l = \sum_i Q'_{i,l} \otimes f_l$. So $C \approx C'$.

\Rightarrow : then there exists $A \in GL_{n+1}(\mathbb{Q})$, with inverse B such that if $f_i = \sum_j b_{i,j} e_j$, then $\Delta_C(f_i) = \sum_l Q'_{i,l} \otimes f_l$. Then the same computation shows that $Q'_{i,l} = \sum_{j,k} b_{i,j} Q_{j,k} a_{k,l}$ or equivalently: $\mathcal{Q}' = A^{-1} \mathcal{Q} A$. Hence, $\mathcal{P} = A^T \mathcal{P}' A^{T-1}$. As $(p'_{i,j})$ is reduced, $C_i = (f_0, \dots, f_{c_0 + \dots + c_i - 1}) = (e_0, \dots, e_{c_0 + \dots + c_i - 1})$ so $A^T \in G_{(c_0, \dots, c_k)}$.

We have now entirely proved the following theorem:

Theorem 6.7 *Let $\mathcal{P}_{(c_0, \dots, c_k)}$ be the set of the reduced families of primitive elements of \mathcal{H}_R of type (c_0, \dots, c_k) , and $\mathcal{O}_{(c_0, \dots, c_k)}$ the orbit space under the action of the parabolic subgroup $G_{(c_0, \dots, c_k)}$ of $GL_{c_0 + \dots + c_k}(\mathbb{Q})$. Then there is a bijection from $\mathcal{O}_{(c_0, \dots, c_k)}$ into the set of \mathcal{H}_R -comodules of type (c_0, \dots, c_k) . Moreover there is a bijection from the disjoint union of the $\mathcal{O}_{(c_0, \dots, c_k)}$'s into the set of finite-dimensional comodules.*

Example: let C be a comodule of dimension 2. Then its type can be (2) or (1, 1). We have:

$$\mathcal{P}_{(2)} = \left\{ \left[\begin{array}{cc} 0 & 0 \\ 0 & 0 \end{array} \right] \right\}, \quad \mathcal{P}_{(1,1)} = \left\{ \left[\begin{array}{cc} 0 & p \\ 0 & 0 \end{array} \right] / p \neq 0 \right\}.$$

Let $\left[\begin{array}{cc} 0 & p \\ 0 & 0 \end{array} \right]$ and $\left[\begin{array}{cc} 0 & p' \\ 0 & 0 \end{array} \right] \in \mathcal{P}_{(1,1)}$. They are in the same orbit under the action of $G_{(1,1)}$ if and only if $\exists \lambda \in \mathbb{Q}^*, p' = \lambda p$. Hence, $\mathcal{O}_{(1,1)}$ is in bijection with the projective space associated to $\text{Prim}(\mathcal{H}_R)$, and $\mathcal{O}_{(2)}$ is reduced to a single point, which corresponds to the trivial comodule of dimension 2.

We now give a characterization of comodules of type $(n+1)$ and type $(1, \dots, 1)$.

Proposition 6.8 *Let C be a comodule of dimension $n + 1$.*

1. C is of type $(n + 1) \iff C$ is trivial.
2. C is of type $(1, \dots, 1) \iff \forall i \in \{1 \dots n + 1\}$, C has a unique subcomodule of dimension i .

In particular, if C is of type $(1, \dots, 1)$, C admits a unique complete flag of subcomodules.

Proof: 1. is obvious.

2. \Leftarrow : let $C^{(i)}$ be the unique subcomodule of dimension $i + 1$ of C . Let $x \in C_0$, $x \neq 0$. Then (x) is a subcomodule of dimension 1 of C , so $(x) = C^{(0)}$ and we get $C_0 = C^{(0)}$. Suppose that $C_{i-1} = C^{(i-1)}$. Let $x \in C_i - C_{i-1}$, then $C_{i-1} \oplus (x)$ is a subcomodule of dimension $i + 1$ of C , so it is equal to $C^{(i)}$ and we get $C_i = C^{(i)}$. Hence, the type of C is $(1, \dots, 1)$.

\Rightarrow : let C' be a subcomodule of dimension 1 of C . Then C' is trivial, so $C' \subset C_0$. As $\dim(C_0) = 1$, $C' = C_0$. Suppose that C has a unique subcomodule of dimension i . Then it is C_{i-1} . Let C'' be a subcomodule of dimension $i + 1$. It has a subcomodule of dimension i , so $C_{i-1} \subset C''$. Moreover, $\frac{C''}{C_{i-1}}$ is trivial, so $C'' \subset C_i$. As they have the same dimension, $C'' = C_i$.

To conclude this section, we indicate how finite-dimensional comodules can help in renormalization. Recall the Toy model of [4]. For a rooted tree t with n vertices, enumerated such that the root has number one, we associate the integral

$$x_t(c) = \int_0^\infty \frac{1}{y_1 + c} \prod_{i=2}^n \frac{1}{y_i + y_{j(i)}} y_n^{-\varepsilon} dy_n \dots y_1^{-\varepsilon} dy_1, \quad \forall c > 0,$$

where $j(i)$ is the number of the vertex to which the i -th vertex is connected via its incoming edge.

Let $\{t_1, \dots, t_m = t\} = \{R^C(t)/C \text{ cut of } t\}$. We take the comodule \mathcal{C} with basis $(x_{t_1}, \dots, x_{t_m})$, and structure map defined by

$$\Delta_{\mathcal{C}}(x_{t_i}) = 1 \otimes x_{t_i} + \sum_{\text{admissible cuts } C \text{ of } t_i} P^C(t_i) \otimes x_{R^C(t_i)}.$$

With $[M] = x_M(0)$ for M a non-empty forest, and $[1] = 1$, we consider the integral:

$$\overline{x}_t(c) = (([.] \otimes Id) \circ (S \otimes Id) \circ (\Delta_{\mathcal{C}}))(x_t)$$

Then the renormalized function is:

$$x_t^R(c) = \lim_{\varepsilon \rightarrow 0} (\overline{x}_t(c) - [\overline{x}_t(c)]).$$

We don't have to worry anymore about non commutativity within the forests.

Example:

$$\begin{aligned} x_{l_1}(c) &= \int_0^\infty \frac{1}{y_1 + c} y_1^{-\varepsilon} dy_1, \\ x_{l_2}(c) &= \int_0^\infty \frac{1}{y_1 + c} \frac{1}{y_2 + y_1} y_2^{-\varepsilon} dy_2 y_1^{-\varepsilon} dy_1, \\ x_{l_3}(c) &= \int_0^\infty \frac{1}{y_1 + c} \frac{1}{y_2 + y_1} \frac{1}{y_3 + y_2} y_3^{-\varepsilon} dy_3 y_2^{-\varepsilon} dy_2 y_1^{-\varepsilon} dy_1. \end{aligned}$$

We take the comodule \mathcal{C} with basis $(x_{l_1}, x_{l_2}, x_{l_3})$. We then get:

$$\Delta_{\mathcal{C}}(x_{l_3}) = 1 \otimes x_{l_3} + l_1 \otimes x_{l_2} + l_2 \otimes x_{l_1}.$$

$$\text{So } \overline{x_{l_3}}(c) = x_{l_3}(c) - [x_{l_1}(c)]x_{l_2}(c) - [x_{l_2}(c)]x_{l_1}(c) + [x_{l_1}(c)x_{l_1}(c)]x_{l_1}(c),$$

$$\text{and } x_{l_3}^R(c) = \lim_{\varepsilon \rightarrow 0} \begin{pmatrix} x_{l_3}(c) & - & [x_{l_1}(c)]x_{l_2}(c) & - & [x_{l_2}(c)]x_{l_1}(c) & + & [x_{l_1}(c)x_{l_1}(c)]x_{l_1}(c) \\ -[x_{l_3}(c)] & + & [[x_{l_1}(c)]x_{l_2}(c)] & + & [[x_{l_2}(c)]x_{l_1}(c)] & - & [[x_{l_1}(c)x_{l_1}(c)]x_{l_1}(c)] \end{pmatrix}.$$

7 \mathcal{H}_R as a comodule. Bigrading \mathcal{H}_R

Here, we consider the (left-)comodule $C = (\mathcal{H}_R, \Delta)$. Of course it is not finite-dimensional, but it is the union of finite-dimensional comodules (for example, the comodules linearly spanned by the forests of weight less than $n, n \in \mathbb{N}$).

Proposition 7.1 $C_0 = (1)$; if $i \geq 1$ then $C_i = (1) \oplus \bigoplus_{j=1}^{j=i} \text{Im}(F_j)$.

Proof: C_0 : let $x \in C, \Delta(x) = 1 \otimes x$. Then $x = (\text{Id} \otimes \varepsilon)(\Delta(x)) = \varepsilon(x)1$: x is constant.
 $i \geq 1$: induction on i . Let $x \in C_{i+1}, \Delta(x) = 1 \otimes x + x \otimes 1 + \sum_j x_j^{(1)} \otimes x_j^{(2)}$. By hypothesis, the $x_j^{(2)}$'s are in $C_i = (1) \oplus \bigoplus_{j=1}^{j=i} \text{Im}(F_j)$. Suppose that $x_1^{(2)} \dots x_l^{(2)}$ are in $\text{Im}(F_i)$, the others in C_{i-1} . By coassociativity of $\tilde{\Delta}, x_1^{(1)} \dots x_l^{(1)}$ are primitive.

$$\text{Then } \Delta \left(x - F_{i+1} \left(\sum_{j=1}^{j=l} x_j^{(1)} \otimes F_i^{-1}(x_j^{(2)}) \right) \right) \equiv 1 \otimes x [\mathcal{H}_R \otimes C_{i-1}],$$

so $x - F_{i+1} \left(\sum_{j=1}^{j=l} x_j^{(1)} \otimes F_i^{-1}(x_j^{(2)}) \right) \in C_i$. Hence, $C_{i+1} = C_i + \text{Im}(F_{i+1})$. The result is then trivial.

Proposition 7.2 $C = (1) \oplus \bigoplus_{j=1}^{j=\infty} \text{Im}(F_j)$.

Proof: let \mathcal{H}_n be the subspace of \mathcal{H}_R generated by the homogeneous elements of weight n . Then $\bigoplus_{i=0}^n \mathcal{H}_i$ is a subcomodule of C . By 6.2, we have $(\bigoplus_{i=0}^n \mathcal{H}_i)_k \subset C_k$. For a k large enough, we have: $\bigoplus_{i=0}^n \mathcal{H}_i = (\bigoplus_{i=0}^n \mathcal{H}_i)_k \subset C_k$. So as $\mathcal{H}_R = \bigoplus_{i=0}^{\infty} \mathcal{H}_i$, we have the result.

It is now easy to see that $C_i = \text{Ker}(\tilde{\Delta}^i) \oplus (1)$. We recognize then the second grading of [3], that is to say $C_i = \{x \in \mathcal{H}_R / \text{deg}_p(x) \leq i\}$, which defines deg_p . Following [3], we put $\mathcal{H}_{n,k} = \mathcal{H}_n \cap C_k, h_{n,k} = \dim(\mathcal{H}_{n,k})$, and $r_n = \dim(\mathcal{H}_n)$. One has $h_{0,0} = 1$ and $h_{n,0} = 0$ if $n \neq 0$. Note that $h_{n,1} = \dim(\mathcal{H}_n \cap \text{Prim}(\mathcal{H}_R))$.

Proposition 7.3

$$\text{Let } \Theta_n = \sum_{b_1+2b_2+\dots+nb_n=n} (-1)^{b_1+\dots+b_n+1} \frac{(b_1+\dots+b_n)!}{b_1! \dots b_n!} X_1^{b_1} \dots X_n^{b_n} \in \mathbb{Q}[X_1 \dots X_n]$$

$$\text{and } \varphi_{n,k} = \sum_{\substack{b_1+2b_2+\dots+nb_n=n \\ b_1+b_2+\dots+b_n=k}} \frac{k!}{b_1! \dots b_n!} X_1^{b_1} \dots X_n^{b_n} \in \mathbb{Q}[X_1 \dots X_n].$$

Then $h_{n,1} = \Theta_n(r_1, \dots, r_n) \forall n \in \mathbb{N}$, and $h_{n,k} = \varphi_{n,k}(h_{1,1}, \dots, h_{n,1}) \forall n, k \in \mathbb{N}^*$.

Proof:

$$\text{We also need } \Phi_n = \sum_{b_1+2b_2+\dots+nb_n=n} \frac{(b_1+\dots+b_n)!}{b_1!\dots b_n!} X_1^{b_1} \dots X_n^{b_n} \in \mathbb{Q}[X_1 \dots X_n].$$

As the F_i are homogeneous, we have $\mathcal{H}_n = \bigoplus_{i=1}^n \bigoplus_{b_1+\dots+b_i=n} F_i(\bigotimes_{j=1}^i \mathcal{H}_{b_j,1})$. As the F_i are injective, we find: $r_n = \Phi_n(h_{1,1}, \dots, h_{n,1})$. Let's work in the algebra of formal power series $\mathbb{Q}[[X_1, \dots, X_n, \dots]]$. In this algebra, we have:

$$\begin{aligned} \sum_{(b_1, \dots, b_n) \neq (0, \dots, 0)} \frac{(b_1+\dots+b_n)!}{b_1!\dots b_n!} X_1^{b_1} \dots X_n^{b_n} &= \sum_{k \neq 0} \left(\sum_{b_1+\dots+b_k=k} \frac{(b_1+\dots+b_k)!}{b_1!\dots b_k!} X_1^{b_1} \dots X_k^{b_k} \right) \\ &= \sum_{k \neq 0} \Phi_k(X_1, \dots, X_k) \\ &= \sum_{l \neq 0} \left(\sum_{b_1+\dots+b_k=l} \frac{l!}{b_1!\dots b_k!} X_1^{b_1} \dots X_k^{b_k} \right) \\ &= \sum_{l \neq 0} \left(\sum_{i \neq 0} X_i \right)^l = \frac{\sum_{i \neq 0} X_i}{1 - \sum_{i \neq 0} X_i}. \end{aligned}$$

We then get:

$$\sum_{k \neq 0} \Phi_k(-\Phi_1, \dots, -\Phi_k) = \frac{-\sum_{i \neq 0} \Phi_i}{1 + \sum_{i \neq 0} \Phi_i} = \frac{-\sum_{i \neq 0} X_i}{1 + \frac{\sum_{i \neq 0} X_i}{1 - \sum_{i \neq 0} X_i}} = -\sum_{i \neq 0} X_i.$$

Hence, by putting X_i in weight i and by comparing the homogeneous parts of each member, we find $\Phi_k(-\Phi_1, \dots, -\Phi_k) = -X_k$, or equivalently $\Theta_k(\Phi_1, \dots, \Phi_k) = X_k$. So $\Theta_k(\Phi_1(h_{1,1}), \dots, \Phi_k(h_{1,1}, \dots, h_{k,1})) = \Theta_k(r_1, \dots, r_k) = h_{k,1}$. If $k > 1$, then $\mathcal{H}_{n,k} = \bigoplus_{c_1+\dots+c_k=n} F_k(\mathcal{H}_{c_1,1}, \dots, \mathcal{H}_{c_k,1})$. As F_k is injective, we find the announced result.

We denote $H(X, Y) = \sum_{n,k} h_{n,k} X^n Y^k$, $H_j(x) = \sum_n h_{n,j} X^n$, $R(X) = \sum_n r_n X^n$. The second formula of 7.3 implies that $H_j(X) = H_1(X)^j$, $\forall j \in \mathbb{N}$. The first formula implies that $1 - H_1(X) = \frac{1}{R(X)}$. We have then $H(X, Y) = \sum_{j=0}^{\infty} H_j(X) Y^j = \sum_{j=0}^{\infty} [H_1(X) Y]^j = \frac{1}{1 - H_1(X) Y} = \frac{R(X)}{Y + (1-Y)R(X)}$, which is a reformulation of the main theorem of [3] (with a small difference because of the different definitions of $R(X)$). We give the first values of r_n and $h_{n,1}$ in the appendix (see also [13]).

8 The Lie algebra \mathcal{L}^1

Proposition 8.1 1. $\mathcal{U}(\mathcal{L}^1)$ is a free algebra;

2. $\forall l_1, l_2 \in \mathcal{U}(\mathcal{L}^1)$, $\text{weight}(l_1 l_2) = \text{weight}(l_1) + \text{weight}(l_2)$.

proof: let $(p_i)_{i \geq 1}$ be a basis of $\text{Prim}(\mathcal{H}_R)$ such that the p_i 's are homogeneous for the weight. By proposition 7.2 and lemma 4.4, $(p_{i_1} \top \dots \top p_{i_k})_{k \geq 0, i_1, \dots, i_k \geq 1}$ is a basis of \mathcal{H}_R . We define $f_{j_1, \dots, j_l} \in \mathcal{H}_R^*$ by :

$$f_{j_1, \dots, j_l}(p_{i_1} \top \dots \top p_{i_k}) = \begin{cases} 1 & \text{if } (j_1, \dots, j_l) = (i_1, \dots, i_k) \\ 0 & \text{if } (j_1, \dots, j_l) \neq (i_1, \dots, i_k). \end{cases}$$

As the $(p_{i_1} \top \dots \top p_{i_k})$'s are homogeneous for the weight, $(f_{j_1, \dots, j_l})_{k \geq 0, i_1, \dots, i_k \geq 1}$ is a basis of \mathcal{H}_R^{*g} .

$$\begin{aligned} (f_{j_1, \dots, j_l} f_{j'_1, \dots, j'_n}, p_{i_1} \top \dots \top p_{i_k}) &= (f_{j_1, \dots, j_l} \otimes f_{j'_1, \dots, j'_n}, \Delta(p_{i_1} \top \dots \top p_{i_k})) \\ &= (f_{j_1, \dots, j_l} \otimes f_{j'_1, \dots, j'_n}, \sum_{s=0}^k p_{i_1} \top \dots \top p_{i_s} \otimes p_{i_{s+1}} \top \dots \top p_{i_k}) \\ &= \begin{cases} 1 & \text{if } (j_1, \dots, j_l, j'_1, \dots, j'_n) = (i_1, \dots, i_k), \\ 0 & \text{if } (j_1, \dots, j_l, j'_1, \dots, j'_n) \neq (i_1, \dots, i_k). \end{cases} \end{aligned}$$

So $f_{j_1, \dots, j_l} f_{j'_1, \dots, j'_n} = f_{j_1, \dots, j_l, j'_1, \dots, j'_n}$, hence \mathcal{H}_R^{*g} and the free algebra generated by the f_i 's, $i \geq 1$, are isomorphic algebras. Moreover, the f_i 's are homogeneous elements of \mathcal{H}_R^{*g} , so we have $weight(ff') = weight(f) + weight(f') \forall f, f' \in \mathcal{H}_R^{*g}$. As \mathcal{H}_R^{*g} and $\mathcal{U}(\mathcal{L}^1)$ are isomorphic graded algebras, the proposition is proved.

Let \mathcal{A} be the augmentation ideal of $\mathcal{U}(\mathcal{L}^1)$, that is to say $\mathcal{A} = ker(\varepsilon)$.

Lemma 8.2 *in the duality between $\mathcal{U}(\mathcal{L}^1)$ and \mathcal{H}_R , the orthogonal of $\mathcal{A}^2 \oplus (1)$ is $Prim(\mathcal{H}_R)$.*

Proof:

$(\mathcal{A}^2 \oplus (1))^\perp \subseteq Prim(\mathcal{H}_R)$: let $x \in (\mathcal{A}^2 \oplus (1))^\perp$, and $l_1, l_2 \in \mathcal{U}(\mathcal{L}^1)$. One has to show that $(l_1 \otimes l_2, \Delta(x)) = (l_1 \otimes l_2, x \otimes 1 + 1 \otimes x)$, that is to say $(l_1 l_2, x) = \varepsilon(l_1)(l_2, x) + (l_1, x)\varepsilon(l_2)$. As $\mathcal{U}(\mathcal{L}^1) = (1) \oplus ker(\varepsilon)$, one has four cases to considerate:

1. $\varepsilon(l_1) = \varepsilon(l_2) = 0$: then $l_1 l_2 \in \mathcal{A}^2$, so $(l_1 l_2, x) = 0 = \varepsilon(l_1)(l_2, x) + (l_1, x)\varepsilon(l_2)$;
2. $\varepsilon(l_1) = 0$ and $l_2 = 1$: obvious;
3. $l_1 = 1$ and $\varepsilon(l_2) = 0$: obvious;
4. $l_1 = l_2 = 1$: one has to show that $(1, x) = 2(1, x)$; as $(1, x) = 0$ it is true.

$Prim(\mathcal{H}_R) \subseteq (\mathcal{A}^2 \oplus (1))^\perp$: equivalently we show $\mathcal{A}^2 \oplus (1) \subseteq (Prim(\mathcal{H}_R))^\perp$. Let $p \in Prim(\mathcal{H}_R)$, then $(1, p) = \varepsilon(p) = 0$, so $1 \in (Prim(\mathcal{H}_R))^\perp$. Let $l \in \mathcal{A}^2$. One can suppose that $l = l_1 l_2$, $\varepsilon(l_1) = \varepsilon(l_2) = 0$. Let $p \in Prim(\mathcal{H}_R)$.

$$(l_1 l_2, p) = (l_1 \otimes l_2, p \otimes 1 + 1 \otimes p) = \varepsilon(l_1)(l_2, p) + (l_1, p)\varepsilon(l_2) = 0.$$

We denote by $\mathcal{U}(\mathcal{L}^1)_n$ the space of the homogeneous elements of $\mathcal{U}(\mathcal{L}^1)$ of weight n . We have $dim(\mathcal{U}(\mathcal{L}^1)_n) = dim(\mathcal{H}_n) = r_n$. Moreover, $\mathcal{A} = \bigoplus_{n \geq 1} \mathcal{U}(\mathcal{L}^1)_n$. We denote $\mathcal{A}_n^2 = \mathcal{A}^2 \cap \mathcal{U}(\mathcal{L}^1)_n$. We have $\mathcal{A}^2 = \bigoplus_{n \geq 1} \mathcal{A}_n^2$. Now, observe that $\mathcal{L}^1 + \mathcal{A}^2 = \mathcal{U}(\mathcal{L}^1)$ (it is obvious when one takes a Poincaré-Birkhoff-Witt basis of $\mathcal{U}(\mathcal{L}^1)$). So for every $n \geq 1$, we can choose a subspace G_n of \mathcal{L}^1 , such that $\mathcal{U}(\mathcal{L}^1)_n = G_n \oplus \mathcal{A}_n^2$. By lemma 8.2, $dim(G_n) = dim(Prim(\mathcal{H}_R) \cap \mathcal{H}_n) = h_{n,1}$. We denote $G = \bigoplus_{n \geq 1} G_n$.

Lemma 8.3 *G generates the algebra $\mathcal{U}(\mathcal{L}^1)$.*

Proof: we denote by $\langle G \rangle$ the subalgebra of $\mathcal{U}(\mathcal{L}^1)$ generated by G . Let $l \in \mathcal{U}(\mathcal{L}^1)$, homogeneous of weight n ; we proceed by induction on n . If $n = 0$, then l is constant: it is then obvious. Suppose that every element of weight less than n is in $\langle G \rangle$. As $\mathcal{U}(\mathcal{L}^1)_n = G_n \oplus \mathcal{A}_n^2$, one can suppose that $l = l_1 l_2$, with $l_1, l_2 \in \mathcal{A}$. By lemma 8.1, $weight(l) = weight(l_1) + weight(l_2)$, so $weight(l_1) < n$, and $weight(l_2) < n$. Then

$l_1, l_2 \in \langle G \rangle$, and $l \in \langle G \rangle$.

We denote by $\mathcal{F}(G)$ the free associative algebra generated by the space G . The gradation of G induces a gradation of the algebra $\mathcal{F}(G)$. By the last lemma, we have a surjective algebra morphism:

$$\Upsilon : \begin{cases} \mathcal{F}(G) & \longmapsto \mathcal{U}(\mathcal{L}^1) \\ g \in G & \longmapsto g. \end{cases}$$

Moreover, Υ is homogeneous of degree 0. We now calculate the dimension f_n of the homogeneous part of weight n of $\mathcal{F}(G)$:

$$\begin{aligned} f_n &= \sum_{\substack{a_1 + \dots + a_k = n \\ a_i \geq 1 \forall i}} h_{a_1,1} \dots h_{a_k,1} \\ &= \sum_{b_1 + 2b_2 + \dots + nb_n = n} \frac{b_1 + \dots + b_n}{b_1! \dots b_n!} h_{1,1}^{b_1} \dots h_{n,1}^{b_n} = r_n. \end{aligned}$$

(For the second equality, b_i is the number of the a_j 's equal to i ; the third equality was shown in the proof of proposition 7.3).

As the homogeneous parts of $\mathcal{U}(\mathcal{L}^1)$ and $\mathcal{F}(G)$ have the same finite dimension, and as Υ is surjective and homogeneous of degree 0, it is in fact an isomorphism.

We now put a Hopf algebra structure on $\mathcal{F}(G)$ by putting $\Delta(g) = g \otimes 1 + 1 \otimes g \forall g \in G$. As $G \subset \mathcal{L}^1$, the elements of G are primitive in both $\mathcal{U}(\mathcal{L}^1)$ and $\mathcal{F}(G)$, so Υ is a Hopf algebra isomorphism. Hence, it induces a Lie isomorphism between $\text{Prim}(\mathcal{F}(G))$ and $\text{Prim}(\mathcal{U}(\mathcal{L}^1)) = \mathcal{L}^1$. But $\text{Prim}(\mathcal{F}(G))$ is isomorphic to the free Lie algebra generated by G (see for example [1]), so we have the following result:

Theorem 8.4 \mathcal{L}^1 is a free Lie algebra.

9 Primitive elements

9.1 Primitive elements of the Hopf Algebra \mathcal{H}_{ladder}

First, we construct a family of primitive elements of \mathcal{H}_{ladder} . For that, we introduce the Hopf algebra $\mathbb{Q}[X_1, \dots, X_n, \dots]$ with coproduct defined by $\Delta(X_i) = X_i \otimes 1 + 1 \otimes X_i$. In this algebra let

$$\Psi_n = \sum_{a_1 + 2a_2 + \dots + na_n = n} \frac{X_1^{a_1} \dots X_n^{a_n}}{a_1! \dots a_n!}.$$

Lemma 9.1 $\Delta(\Psi_n) = \sum_{j=0}^{j=n} \Psi_j \otimes \Psi_{n-j}$.

Proof: one easily shows that:

$$\Delta(X_1^{a_1} \dots X_n^{a_n}) = \sum_{i=0}^n \sum_{k_i=0}^{k_i=a_i} \binom{a_1}{k_1} \dots \binom{a_n}{k_n} X_1^{k_1} \dots X_n^{k_n} \otimes X_1^{a_1-k_1} \dots X_n^{a_n-k_n}.$$

So

$$\begin{aligned}
\Delta(\Psi_n) &= \sum_{a_1+2a_2+\dots+na_n=n} \sum_{i=0}^n \sum_{k_i=a_i} \frac{1}{a_1! \dots a_n!} \binom{a_1}{k_1} \dots \binom{a_n}{k_n} X_1^{k_1} \dots X_n^{k_n} \otimes X_1^{a_1-k_1} \dots X_n^{a_n-k_n} \\
&= \sum_{b_1+\dots+nb_n+c_1+\dots+nc_n=n} \frac{\binom{b_1+c_1}{b_1} \dots \binom{b_n+c_n}{b_n}}{(b_1+c_1)! \dots (b_n+c_n)!} X_1^{b_1} \dots X_n^{b_n} \otimes X_1^{c_1} \dots X_n^{c_n} \\
&= \sum_{j=0}^n \sum_{b_1+\dots+jb_j=j} \sum_{c_1+\dots+(n-j)c_{n-j}=n-j} \frac{1}{b_1!c_1! \dots b_n!c_n!} X_1^{b_1} \dots X_j^{b_j} \otimes X_1^{c_1} \dots X_{n-j}^{c_{n-j}} \\
&= \sum_{j=0}^n \Psi_j \otimes \Psi_{n-j}.
\end{aligned}$$

We define a sequence $(P_i)_{i \geq 1}$ of elements in \mathcal{H}_{ladder} by:

$$P_1 = l_1, P_n = l_n - \Psi_n(P_1, \dots, P_{n-1}, 0) \quad \forall n \geq 2.$$

As $\Psi_n = X_n + \Psi_n(X_1, \dots, X_{n-1}, 0)$, we have $l_n = \Psi_n(P_1, \dots, P_{n-1}, P_n)$.

Proposition: 9.2 P_i is primitive for all $i \geq 1$.

Proof: induction on i . It is trivial for $i = 1$. Suppose it is true for each $j \leq i - 1$. Then

$$\begin{aligned}
\tilde{\Delta}(l_i) &= \sum_{j=1}^{j=i-1} l_j \otimes l_{i-j} \\
&= \sum_{j=1}^{j=i-1} \Psi_j(P_1, \dots, P_j) \otimes \Psi_{i-j}(P_1, \dots, P_{i-j}) \\
&= \tilde{\Delta}(\Psi_i(P_1, \dots, P_{i-1}, 0))
\end{aligned}$$

by 9.1, and the fact that P_1, \dots, P_{i-1} are primitive. So $\tilde{\Delta}(l_i - \Psi_i(P_1, \dots, P_{i-1}, 0)) = \tilde{\Delta}(P_i) = 0$, hence P_i is primitive.

We work again in $\mathbb{Q}[[X_1, \dots, X_n, \dots]]$. In this algebra, we have:

$$\begin{aligned}
\sum_{(b_1, \dots, b_n) \neq (0, \dots, 0)} \frac{X_1^{b_1} \dots X_n^{b_n}}{b_1! \dots b_n!} &= \sum_{k \neq 0} \left(\sum_{b_1+2b_2+\dots+kb_k=k} \frac{X_1^{b_1} \dots X_k^{b_k}}{b_1! \dots b_k!} \right) \\
&= \sum_{k \neq 0} \Psi_k(X_1, \dots, X_k) \\
&= \sum_{l \neq 0} \frac{1}{l!} \left(\sum_{b_1+b_2+\dots+b_k=l} \frac{l!}{b_1! \dots b_k!} X_1^{b_1} \dots X_k^{b_k} \right) \\
&= \sum_{l \neq 0} \frac{1}{l!} \left(\sum_{i \neq 0} X_i \right)^l \\
&= (\exp - 1) \left(\sum_{i \neq 0} X_i \right).
\end{aligned}$$

So $\ln\left(1 + \sum_{k \neq 0} \Psi_k(X_1, \dots, X_k)\right) = \ln\left(1 + (\exp - 1)\left(\sum_{i \neq 0} X_i\right)\right) = \left(\sum_{i \neq 0} X_i\right)$. By putting X_i in weight i , and comparing the homogeneous parts, we find:

$$\sum_{a_1 + \dots + ia_i = i} (-1)^{a_1 + \dots + a_i + 1} \frac{(a_1 + \dots + a_i - 1)!}{a_1! \dots a_i!} \Psi_1^{a_1} \dots \Psi_i^{a_i} = X_i.$$

As $\Psi_i(P_1, \dots, P_i) = l_i$, we deduce:

Proposition 9.3

$$P_i = \sum_{a_1 + \dots + ia_i = i} (-1)^{a_1 + \dots + a_i + 1} \frac{(a_1 + \dots + a_i - 1)!}{a_1! \dots a_i!} l_1^{a_1} \dots l_i^{a_i}.$$

In \mathcal{H}_R , consider the projection π_c on the space spanned by rooted trees, which vanishes on the space spanned by non connected forests. We have:

Lemma 9.4 *let $p \in \mathcal{H}_R$ be a primitive element such that $\pi_c(p) = 0$. Then $p = 0$.*

Proof: suppose $p \neq 0$, and let write $p = \sum_{\alpha=(\alpha_1, \dots, \alpha_k)} a_\alpha t_1^{\alpha_1} \dots t_k^{\alpha_k}$, where the t_i 's are rooted trees, with $\frac{\partial p}{\partial t_i} \neq 0$. One can suppose that $weight(t_k) \geq weight(t_i) \forall i$. Let $t_1^{\alpha_1} \dots t_k^{\alpha_k}$ such that $\alpha_k \neq 0$ and $a_\alpha \neq 0$.

Let F a forest such that in the basis $(F_1 \otimes F_2)_{F_1 \text{ and } F_2 \text{ forests}}$ of $\mathcal{H}_R \otimes \mathcal{H}_R$, the coefficient of $t_1^{\alpha_1} \dots t_{k_1}^{\alpha_{k_1}} \otimes t_k$ in $\Delta(F)$ is $\neq 0$. Then $F = t_1^{\alpha_1} \dots t_k^{\alpha_k}$, and then this coefficient is α_k , or there exists t' a rooted tree with $weight(t') > weight(t)$, such that $\frac{\partial F}{\partial t'} \neq 0$. So the coefficient of $t_1^{\alpha_1} \dots t_{k_1}^{\alpha_{k_1}} \otimes t_k$ in $\Delta(p)$ is $\alpha_k a_\alpha \neq 0$. As p is primitive, $t_k = 1$ or $t_1^{\alpha_1} \dots t_{k_1}^{\alpha_{k_1}} = 1$. If $t_k = 1$, then p is constant: this is a contradiction, because then p would not be primitive. So $t_1^{\alpha_1} \dots t_{k_1}^{\alpha_{k_1}} = 1$, and then $\pi_c(p) \neq 0$.

Theorem 9.5 $(P_i)_{i \in \mathbb{N}^*}$ is a basis of the space of primitive elements in \mathcal{H}_{ladder} .

Proof: let p be a primitive element in \mathcal{H}_{ladder} . Then $\pi_c(p)$ is a linear combination of ladders, so there is a linear combination p' of P_i such that $\pi_c(p) = \pi_c(p')$. By the lemma, $p = p'$.

9.2 The operator π_1

Recall that π_1 is the projection on $Im(F_1) = Prim(\mathcal{H}_R)$ which vanishes on $(1) \oplus \oplus_{j \geq 2} Im(F_j)$.

Theorem 9.6 *Let F be a non-empty forest.*

We put $\tilde{\Delta}(F) = \sum_{(F)} F^{(1)} \otimes F^{(2)}$; then:

$$\pi_1(F) = F - \sum_{(F)} F^{(1)} \top \pi_1(F^{(2)}).$$

Proof: induction on $weight(F)$. If $weight(F) = 1$, it is obvious. Suppose the formula is true for every forests of weight less than or equal to $n - 1$. Let F be a forest of weight n . Then $weight(F^{(2)}) < weight(F)$, so:

$$\begin{aligned}
\tilde{\Delta}(F) &= \sum_{(F)} F^{(1)} \otimes F^{(2)} \\
&= \sum_{(F)} F^{(1)} \otimes \left(\pi_1(F^{(2)}) + \sum_{(F^{(2)})} (F^{(2)})^{(1)} \top \pi_1 \left((F^{(2)})^{(2)} \right) \right) \\
&= \sum_{(F)} \left(F^{(1)} \otimes \pi_1(F^{(2)}) + \sum_{(F^{(1)})} (F^{(1)})^{(1)} \otimes \left[(F^{(1)})^{(2)} \top \pi_1(F^{(2)}) \right] \right) \text{ (by coassociativity)} \\
&= \sum_{(F)} \tilde{\Delta}(F^{(1)} \top \pi_1(F^{(2)})) \text{ (by 4.1)}.
\end{aligned}$$

So $F - \sum_{(F)} F^{(1)} \top \pi_1(F^{(2)}) \in Im(F_1)$; as $\sum_{(F)} F^{(1)} \top \pi_1(F^{(2)}) \in \oplus_{j \geq 2} Im(F_j)$, we have

the result for F .

So we have an easy way to find a family who generates the space of primitive elements of weight n , by induction on n . Moreover, we have relations between the $\pi_1(F)$, which are given by $\pi_1(F' \top p) = 0$ for any non-empty forest F' and for any primitive element p we have ever found. So we easily have a basis of the space of homogeneous primitive elements of weight n .

For example, for $n = 1$, we have $\pi_1(l_1) = l_1$; the basis is (l_1) ; we have the relation $\pi_1(F' \top l_1) = 0 \forall F'$ non-empty forest; so $\mathcal{R}_1 : \pi_1(T) = 0 \forall T$ rooted tree of weight greater than or equal to 2.

Hence, for $n = 2$, we only have to compute $\pi_1(l_1^2) = l_1^2 - 2l_1 \top \pi_1(l_1) = l_1^2 - 2l_2$. The basis is $(l_1^2 - 2l_2)$, and we have: $\pi_1(F' \top (l_1^2 - l_2)) = 0$, which gives: $\mathcal{R}_2 : \pi_1(l_1 T) = 0 \forall T$ rooted tree of weight greater than or equal to 2.

For $n = 3$, we have to compute $\pi_1(l_1^3)$; the others are zero by \mathcal{R}_1 and \mathcal{R}_2 . One finds the basis $(l_1^3 - 3l_1 l_2 + 3l_3)$ and the relation $\mathcal{R}_3 : \pi_1(l_1^2 T) = \pi_1(l_2 T) \forall T$ rooted tree of weight greater than or equal to 2.

For $n = 4$, one would have to compute $\pi_1(l_1^4)$ and $\pi_1(l_2^2)$, and so on.

Remark: by linearity, the formula of 9.6 is true for any $x \in \mathcal{H}_R$. For example, for $x = p_1 p_2$, with p_1, p_2 primitive elements of \mathcal{H}_R , one finds: $\pi_1(x) = p_1 p_2 - p_1 \top p_2 - p_2 \top p_1$; hence, $S_1(p_1) = \pi_1(-Y(p_1)l_1)$ with $Y(F) = weight(F) F$ for all forest F , and S_1 defined in [3].

10 Classification of the Hopf algebra endomorphisms of \mathcal{H}_R

In the sequel, we will denote by CT the set of (connected) rooted trees.

Definition 10.1 Let $(P_t)_{t \in CT}$ be a family of primitive elements of \mathcal{H}_R indexed by CT . Let $\Phi_{(P_t)}$ be the algebra endomorphism of \mathcal{H}_R defined by induction on $\text{weight}(T)$ by:

$$\begin{aligned}\Phi_{(P_t)}(l_1) &= P_{l_1}; \\ \forall T \in CT, \text{ with } \tilde{\Delta}(T) &= \sum_{(T)} T^{(1)} \otimes T^{(2)}, \\ \Phi_{(P_t)}(T) &= \left(\sum_{(T)} \Phi_{(P_t)}(T^{(1)}) \top P_{T^{(2)}} \right) + P_T.\end{aligned}$$

Then $\Phi_{(P_t)}$ is a bialgebra endomorphism of \mathcal{H}_R .

Proof: one has to show $(\Phi_{(P_t)} \otimes \Phi_{(P_t)}) \circ \tilde{\Delta}(T) = \tilde{\Delta}(\Phi_{(P_t)}(T)) \forall T \in CT$. We proceed by induction on $n = \text{weight}(T)$. It is obvious for $n = 1$, since then $T = l_1$ is primitive. Suppose it is true for all rooted trees of weight $< n$. Then as $\Phi_{(P_t)}$ is an algebra endomorphism, it is true for all non connected forests of weight $\leq n$. Let T be a rooted tree of weight n . Then:

$$\begin{aligned}\tilde{\Delta}(\Phi_{(P_t)}(T)) &= \sum_{(T)} \tilde{\Delta}(\Phi_{(P_t)}(T^{(1)}) \top P_{T^{(2)}}) \\ &= \left(\sum_{(T)} \Phi_{(P_t)}(T^{(1)}) \otimes P_{T^{(2)}} \right) + \sum_{(T)} \Phi_{(P_t)}(T^{(1)}) \otimes (\Phi_{(P_t)}(T^{(2)}) \top P_{T^{(3)}}) \\ &= \sum_{(T)} \Phi_{(P_t)}(T^{(1)}) \otimes \left[\sum_{(T^{(2)})} \left(\Phi_{(P_t)}((T^{(2)})^{(1)}) \top P_{(T^{(2)})^{(2)}} \right) + P_{T^{(2)}} \right] \\ &= \sum_{(T)} \Phi_{(P_t)}(T^{(1)}) \otimes \Phi_{(P_t)}(T^{(2)}).\end{aligned}$$

We used the induction hypothesis and 4.1 for the second equality, and coassociativity of $\tilde{\Delta}$ for the third.

Theorem 10.2 Let Ψ be an endomorphism of the bialgebra \mathcal{H}_R . Then there exists a unique family (P_t) of primitive elements, such that $\Psi = \Phi_{(P_t)}$.

Proof: one remarks that if (P_t) and (Q_t) are two families of primitive elements, such that $P_t = Q_t$ if $\text{weight}(t) \leq n$, then $\Phi_{(P_t)}(x) = \Phi_{(Q_t)}(x)$ for all x of weight $\leq n$. So we only have to show that there exists a family (P_t) such that if we denote:

$$P_t^{(n)} = \begin{cases} P_t & \text{if } \text{weight}(T) \leq n \\ 0 & \text{if } \text{weight}(T) > n, \end{cases}$$

then $\Psi(x) = \Phi_{(P_t^{(n)})}(x)$ for all x of weight $\leq n$. We take $P_{l_1} = \Psi(l_1)$, and then it is true for $n = 1$. Suppose we have P_t for all t of weight $< n$. We put $\Phi_{(P_t^{(n-1)})} = \Phi_{n-1}$. Let T be a rooted tree of weight n .

$$\begin{aligned}\tilde{\Delta}(\Psi(T)) &= \sum_{(T)} \Psi(T^{(1)}) \otimes \Psi(T^{(2)}) \\ &= \sum_{(T)} \Phi_{n-1}(T^{(1)}) \otimes \Phi_{n-1}(T^{(2)}) = \tilde{\Delta}(\Phi_{n-1}(T)).\end{aligned}$$

We take $P_T = \Psi(T) - \Phi_{n-1}(T)$; then $\Psi(T) = \Phi_{(P_t^{(n)})}(T)$.

For the uniqueness of the family (P_t) , we have $\pi_1(\Psi(T)) = P_T, \quad \forall T$ rooted tree.

Proposition 10.3 *Let Ψ be an endomorphism of the bialgebra \mathcal{H}_R ; then Ψ is an endomorphism of the Hopf algebra \mathcal{H}_R , that is to say $\Psi \circ S = S \circ \Psi$.*

Let B^+ be the operator of \mathcal{H}_R which appends each term of a forest $t_1 \dots t_n$ to a common root. One can show that for every $x \in \mathcal{H}_R$,

$$\Delta(B^+(x)) = B^+(x) \otimes 1 + (Id \otimes B^+)(\Delta(x)).$$

Lemma 10.4 *Let p be a primitive element of \mathcal{H}_R and let $x \in \mathcal{H}_R$, with $\varepsilon(x) = 0$. Then*

$$S(x \top p) = -x \top p - S(x)p - \sum_{(x)} S(x^{(1)})(x^{(2)} \top p) \text{ where } \tilde{\Delta}(x) = \sum_{(x)} x^{(1)} \otimes x^{(2)}.$$

In particular, for $p = l_1$,

$$S(B^+(x)) = -B^+(x) - S(x)l_1 - \sum_{(x)} S(x^{(1)})B^+(x^{(2)}).$$

Proof: we have $(S \otimes Id) \circ \Delta(x) = 0$. Then we use 4.1 to conclude.

Proof of the proposition: let F be a forest in \mathcal{H}_R .

$$\begin{aligned} \Psi \circ S(B^+(F)) &= -\Psi(F) \top P_{l_1} - \sum_{(F)} \Psi(F^{(1)}) \top P_{B^+(F^{(2)})} - P_{B^+(F)} \\ &\quad - \sum_{(F)} \Psi \circ S(F^{(1)})(\Psi(F^{(2)}) \top P_{l_1}) - \sum_{(F)} \Psi \circ S(F^{(1)})[\Psi(F^{(2)}) \top P_{B^+(F^{(3)})}] \\ &\quad - \Psi \circ S(F)P_{l_1} - \sum_{(F)} \Psi \circ S(F^{(1)})P_{B^+(F^{(2)})}; \\ S \circ \Psi(B^+(F)) &= S(\Psi(F) \top P_{l_1}) + \sum_{(F)} S(\Psi(F^{(1)}) \top P_{B^+(F^{(2)})}) + S(P_{B^+(F)}) \\ &= -\Psi(F) \top P_{l_1} - \sum_{(F)} \Psi(F^{(1)}) \top P_{B^+(F^{(2)})} - P_{B^+(F)} \\ &\quad - \sum_{(F)} S \circ \Psi(F^{(1)})(\Psi(F^{(2)}) \top P_{l_1}) - \sum_{(F)} S \circ \Psi(F^{(1)})[\Psi(F^{(2)}) \top P_{B^+(F^{(3)})}] \\ &\quad - S \circ \Psi(F)P_{l_1} - \sum_{(F)} S \circ \Psi(F^{(1)})P_{B^+(F^{(2)})}. \end{aligned}$$

We conclude by an induction on the weight.

11 Associated graded algebra of \mathcal{H}_R and coalgebra endomorphisms

As it is shown in [3], \mathcal{H}_R is filtered as Hopf algebra by deg_p . What is the associated graded algebra ?

The filtration is given by $(\mathcal{H}_R)_n^{(P)} = \{x \in \mathcal{H}_R, deg_p x \leq n\} = (1) \oplus \bigoplus_1^n Im(F_j) = C_n = Ker(\tilde{\Delta}^{(n)}) \oplus (1)$. We put π_i the projection on $Im(F_i)$ which vanishes on $(1) \oplus \bigoplus_{j \neq i} Im(F_j)$.

Lemma 11.1 *Let $p_1, \dots, p_j, p_{j+1}, \dots, p_{j+l}$ be primitive elements of \mathcal{H}_R . Then*

$$\pi_{j+l}(p_{j+l} \top \dots \top p_{j+1} \cdot p_j \top \dots \top p_1) = \sum_{\sigma \text{ (j,l)-shuffle}} p_{\sigma(j+l)} \top \dots \top p_{\sigma(1)},$$

where a (j,l) -shuffle is a permutation σ of $\{1, \dots, j+l\}$ such that $\sigma(1) < \sigma(2) < \dots < \sigma(j)$ and $\sigma(j+1) < \sigma(j+2) < \dots < \sigma(j+l)$.

Proof: by induction we prove:

$$\begin{aligned} \tilde{\Delta}^{j-l-1}(p_{j+l} \top \dots \top p_{j+1} \cdot p_j \top \dots \top p_1) &= \sum_{\sigma \text{ (j,l)-shuffle}} p_{\sigma(j+l)} \otimes \dots \otimes p_{\sigma(1)} \\ &= \tilde{\Delta}^{j-l-1} \left(\sum_{\sigma \text{ (j,l)-shuffle}} p_{\sigma(j+l)} \top \dots \top p_{\sigma(1)} \right). \end{aligned}$$

$$\text{So } p_{j+l} \top \dots \top p_{j+1} \cdot p_j \top \dots \top p_1 - \sum_{\sigma \text{ (j,l)-shuffle}} p_{\sigma(j+l)} \top \dots \top p_{\sigma(1)} \text{ is in } (\mathcal{H}_R)_{j+l-1}^{(P)},$$

which proves the lemma.

We naturally identify $(\mathcal{H}_R)_n^{(P)} / (\mathcal{H}_R)_{n-1}^{(P)}$ with $Im(F_n)$. We can now describe $gr(\mathcal{H}_R)$, the associated graded Hopf algebra:

i) as vector space, $gr(\mathcal{H}_R) = (1) \oplus \bigoplus_1^\infty Im(F_i)$;

ii) $\forall p_j \top \dots \top p_1 \in Im(F_j), p_{j+l} \top \dots \top p_{j+1} \in Im(F_l)$,

$$(p_{j+l} \top \dots \top p_{j+1}) * (p_j \top \dots \top p_1) = \sum_{\sigma \text{ (j,l)-shuffle}} p_{\sigma(j+l)} \top \dots \top p_{\sigma(1)},$$

where $*$ is the product of $gr(\mathcal{H}_R)$;

iii) $\forall p_j \top \dots \top p_1 \in Im(F_j)$,

$$\begin{aligned} \Delta(p_j \top \dots \top p_1) &= (1 \otimes p_j \top \dots \top p_1) + (p_j \top \dots \top p_1 \otimes 1) \\ &\quad + \sum_{k=2}^{k=j} (p_j \top \dots \top p_k) \otimes (p_{k-1} \top \dots \top p_1); \end{aligned}$$

iv) $\forall x \in Im(F_j), j \geq 1, \varepsilon(x) = 0$;

v) $\forall p_1 \top \dots \top p_j \in Im(F_j), S_*(p_j \top \dots \top p_1) = (-1)^j p_1 \top \dots \top p_j$.

Clearly, the linear map from $gr(\mathcal{H}_R)$ into \mathcal{H}_R which is the identity on every $Im(F_i)$ is a coalgebra isomorphism. It is not an algebra morphism, although we shall prove later that $gr(\mathcal{H}_R)$ and \mathcal{H}_R are in fact isomorphic Hopf algebras, via another map.

We are going to classify the coalgebra endomorphisms \mathcal{H}_R or indifferently $gr(\mathcal{H}_R)$. First we fix a notation. Let u be a linear map from $Prim(\mathcal{H}_R)^{\otimes i}$ into $Prim(\mathcal{H}_R)^{\otimes j}$. Then \bar{u} is the linear map from $Im(F_i)$ into $Im(F_j)$ defined by $\bar{u} = F_j \circ u \circ F_i^{-1}$.

Theorem 11.2 For all $i \in \mathbb{N}^*$, let $u_i : \text{Prim}(\mathcal{H}_R)^{\otimes i} \longmapsto \text{Prim}(\mathcal{H}_R)$. Let $\Phi_{(u_i)}$ be the linear map defined by:

$$\begin{aligned}\Phi_{(u_i)}(1) &= 1; \\ \Phi_{(u_i)}(p_n \top \dots \top p_1) &= \sum_{k=1}^n \sum_{a_1 + \dots + a_k = n} (\overline{u_{a_1} \otimes \dots \otimes u_{a_k}})(p_n \top \dots \top p_1).\end{aligned}$$

Then $\Phi_{(u_i)}$ is a coalgebra endomorphism of \mathcal{H}_R (or $\text{gr}(\mathcal{H}_R)$).

Moreover, if Φ is a coalgebra endomorphism of \mathcal{H}_R (or $\text{gr}(\mathcal{H}_R)$), then for all $i \in \mathbb{N}^*$, there exists a unique $u_i : \text{Prim}(\mathcal{H}_R)^{\otimes i} \longmapsto \text{Prim}(\mathcal{H}_R)$, such that $\Phi = \Phi_{(u_i)}$.

Proof: first we prove that $\Phi_{(u_i)}$ is a coalgebra endomorphism:

$$\begin{aligned}\Phi_{(u_i)} \otimes \Phi_{(u_i)}(\tilde{\Delta}(p_n \top \dots \top p_1)) &= \\ \sum_j \sum_{a_1 + \dots + a_k = j} \sum_{b_1 + \dots + b_l = n-j} & [(\overline{u_{a_1} \otimes \dots \otimes u_{a_k}}) \otimes (\overline{u_{b_1} \otimes \dots \otimes u_{b_l}})] [(p_n \top \dots \top p_{j+1}) \otimes (p_j \top \dots \top p_1)] \\ &= \tilde{\Delta} \left(\sum_{d_1 + \dots + d_m = n} (\overline{u_{d_1} \otimes \dots \otimes u_{d_m}})(p_n \top \dots \top p_1) - \overline{u_n}(p_n \top \dots \top p_1) \right) \\ &= \tilde{\Delta} \left(\sum_{d_1 + \dots + d_m = n} (\overline{u_{d_1} \otimes \dots \otimes u_{d_m}})(p_n \top \dots \top p_1) \right) - 0 \\ &= \tilde{\Delta}(\Phi_{(u_i)}(p_n \top \dots \top p_1)).\end{aligned}$$

Let Φ be a coalgebra endomorphism. $\Delta(\Phi(1)) = \Phi(1) \otimes \Phi(1)$, so $\Phi(1) = 0$ or 1 . As $\varepsilon \circ \Phi = \varepsilon$, $\Phi(1) = 1$. We construct u_i by induction on i . For $i = 1$, u_1 is the restriction of Φ on $\text{Prim}(\mathcal{H}_R)$. Suppose we have u_i for $i < n$. Then with $u'_i = u_i$ if $i < n$ and $u'_i = 0$ if $i \geq n$, $\Phi = \Phi_{(u'_i)}$ on $(1) \oplus \oplus_1^{n-1} \text{Im}(F_j)$. So

$$\begin{aligned}\tilde{\Delta}(\Phi(p_n \top \dots \top p_1)) &= (\Phi \otimes \Phi) \circ \tilde{\Delta}(p_n \top \dots \top p_1) \\ &= (\Phi_{(u'_i)} \otimes \Phi_{(u'_i)}) \circ \tilde{\Delta}(p_n \top \dots \top p_1) = \tilde{\Delta}(\Phi_{(u'_i)}(p_n \top \dots \top p_1)).\end{aligned}$$

So we can take $\overline{u_n}(p_n \top \dots \top p_1) = (\Phi - \Phi_{(u'_i)})(p_n \top \dots \top p_1)$.

For the uniqueness, observe that $\pi_1 \circ \Phi = \overline{u_i}$ on $\text{Im}(F_i)$.

We now give a criterion of invertibility of a coalgebra endomorphism:

Proposition 11.3 $\Phi_{(u_i)}$ is bijective if and only if the restriction u_1 of $\Phi_{(u_i)}$ to $\text{Prim}(\mathcal{H}_R)$ is bijective.

Proof: \Rightarrow : obvious.

\Leftarrow : we put $\Phi = \Phi_{(u_i)}$. Recall that $C_i = (1) \oplus \oplus_1^i \text{Im}(F_j)$. As $\Phi(C_i) \subset C_i$, it is enough to show that $\Phi|_{C_i} : C_i \longmapsto C_i$ is invertible $\forall i$. For $i = 1$, it is the hypothesis. Suppose it is true for a certain $i - 1$. Then $\Phi(p_i \top \dots \top p_1) - \overline{u_1 \otimes \dots \otimes u_1}(p_i \top \dots \top p_1)$ belongs to C_{i-1} , so it belongs to $\text{Im}(\Phi)$; hence $\overline{u_1 \otimes \dots \otimes u_1}(C_i) \subset \text{Im}(\Phi)$. As $\overline{u_1 \otimes \dots \otimes u_1}$ is surjective (because u_1 is surjective), $\Phi|_{C_i}$ is surjective.

Let $x \in C_i$, $\Phi(x) = 0$. $x = x_i + y$, $x_i \in \text{Im}(F_i)$, $y \in C_{i-1}$. Then $\Phi(x) = 0 = \overline{u_1 \otimes \dots \otimes u_1}(x_i) + C_{i-1}$, so $\overline{u_1 \otimes \dots \otimes u_1}(x_i) = 0$ (because it belongs to $\text{Im}(F_i) \cap C_{i-1}$). As u_1 is injective, $x_i = 0$, and $x \in C_{i-1}$. As $\Phi|_{C_{i-1}}$ is injective, $x = 0$: $\Phi|_{C_i}$ is injective.

We now give a criterion to know when a coalgebra endomorphism is in fact a bialgebra endomorphism.

Proposition 11.4 Let $\Phi = \Phi_{(u_i)}$ be a coalgebra endomorphism. Let $\Phi^{(n)} = \Phi_{(u_i^n)}$ be the coalgebra endomorphism with $u_i^n = u_i$ if $i \leq n$, $u_i^n = 0$ if $i > n$.

1. (case of \mathcal{H}_R) Φ is a bialgebra endomorphism if and only if for all $x_i \in \text{Im}(F_i)$, $x_j \in \text{Im}(F_j)$, $\overline{u_{i+j}}(x_i * x_j) = -\Phi^{(i+j-1)}(x_i \cdot x_j) + \Phi^{(i+j-1)}(x_i) \cdot \Phi^{(i+j-1)}(x_j)$.
2. (case of $\text{gr}(\mathcal{H}_R)$) Φ is a bialgebra endomorphism if and only if for all $x_i \in \text{Im}(F_i)$, $x_j \in \text{Im}(F_j)$, $\overline{u_{i+j}}(x_i * x_j) = -\Phi^{(i+j-1)}(x_i * x_j) + \Phi^{(i+j-1)}(x_i) * \Phi^{(i+j-1)}(x_j)$.

Proof: we study the case of \mathcal{H}_R . Observe that $\Phi(x_i \cdot x_j) = \overline{u_{i+j}}(x_i * x_j) + \Phi^{(i+j-1)}(x_i \cdot x_j)$ because $x_i \cdot x_j - x_i * x_j$ belongs to C_{i+j-1} . Moreover $\Phi = \Phi^{(i+j-1)}$ on C_{i+j-1} . It is then obvious. The proof in the case of $\text{gr}(\mathcal{H}_R)$ is analog, even easier.

12 Automorphisms of \mathcal{H}_R

In the following, we shall identify $\text{gr}(\mathcal{H}_R)$ and \mathcal{H}_R as vector spaces via:

$$\text{Id} : \text{Im}(F_i) \subset \text{gr}(\mathcal{H}_R) \longmapsto \text{Im}(F_i) \subset \mathcal{H}_R.$$

Now the vector space \mathcal{H}_R has two Hopf algebra structures: $(\mathcal{H}_R, \cdot, \Delta, S)$ and $(\mathcal{H}_R, *, \Delta, S_*)$. Note that the coproduct is the same in both cases. Both are graded as Hopf algebras by the weight. We still denote by \mathcal{H}_i the homogeneous components, which are the same for both structures. $(\mathcal{H}_R, *, \Delta, S_*)$ is by construction graded as Hopf algebra by deg_p , and the homogeneous components are the $\text{Im}(F_i)$'s.

We denote the augmentation ideal, which is the same for both structures, by \mathcal{M} , and its square in (\mathcal{H}_R, \cdot) by \mathcal{M}^2 . We put $\mathcal{M}_i = \mathcal{M} \cap \mathcal{H}_i$ and $M_i^2 = \mathcal{M}^2 \cap \mathcal{H}_i$. We have:

$$\mathcal{M} = \oplus_i \mathcal{M}_i \text{ and } \mathcal{M}^2 = \oplus_i \mathcal{M}_i^2.$$

Obviously, $\sum_j \mathcal{H}_i \cap \text{Im}(F_j) = \mathcal{H}_i \cap \sum_j \text{Im}(F_j) = \mathcal{H}_i$ if $i \leq 1$. So $\mathcal{M}_i^2 + \sum_j \mathcal{H}_i \cap \text{Im}(F_j) = \mathcal{H}_i = \mathcal{M}_i$. Hence, we can choose $V_{i,j} \subset \mathcal{H}_i \cap \text{Im}(F_j)$, such that $\mathcal{M}_i = \mathcal{M}_i^2 \oplus \oplus_j V_{i,j}$. We put $V_i = \oplus_j V_{i,j}$, and $V = \oplus_{i,j} V_{i,j}$. Note that $V_1 = \mathcal{H}_1$. Moreover, for any $x \in \mathcal{M}^2$, $\pi_c(x) = 0$, so by lemma 9.4, $\mathcal{M}^2 \cap \text{Im}(F_1) = \mathcal{M}^2 \cap \text{Prim}(\mathcal{H}_R) = (0)$. So $V_{i,1} = \mathcal{H}_i \cap \text{Im}(F_1)$.

Lemma 12.1 V generates the algebra (\mathcal{H}_R, \cdot) .

Proof: we denote by $\langle V \rangle$ the subalgebra of (\mathcal{H}_R, \cdot) generated by V .

We have to show that $\mathcal{H}_i \subset \langle V \rangle \forall i \geq 1$. We proceed by induction on i . If $i = 1$, then it is true since $V_1 = \mathcal{H}_1$. Suppose it is true for any $i' \leq i - 1$. Let $x \in \mathcal{H}_i = \mathcal{M}_i^2 \oplus V_i$. It is obvious if $x \in V_i$. If $x \in \mathcal{M}_i^2$, one can suppose that $x = m_1 m_2$, with m_1 and m_2 in \mathcal{M} . Then m_1 and m_2 cannot be constant, so $\text{weight}(m_1) < i$ and $\text{weight}(m_2) < i$. So they are in $\langle V \rangle$, so $x \in \langle V \rangle$.

Lemma 12.2 V generates the algebra $(\mathcal{H}_R, *)$.

Proof: we denote by $\langle V \rangle_*$ the subalgebra of $(\mathcal{H}_R, *)$ generated by V .

Let $x \in \mathcal{H}_R$. Let $j = \text{deg}_p(x)$. If $j = 1$, then $x \in \langle V \rangle_*$ since $\text{Im}(F_1) = \oplus_i V_{i,1}$. Suppose that $y \in \langle V \rangle_*$ for any y with $\text{deg}_p(y) < j$. One can suppose that $x \in \mathcal{M} = \mathcal{M}^2 \oplus V$. If $x \in V$, then $x \in \langle V \rangle_*$. If $x \in \mathcal{M}^2$, one can suppose that $x = m_1 m_2$, with $m_1, m_2 \in \mathcal{M}$. Then $\text{deg}_p(x) = \text{deg}_p(m_1) + \text{deg}_p(m_2)$, so $\text{deg}_p(m_1) < j$ and $\text{deg}_p(m_2) < j$, so m_1 and m_2 are in $\langle V \rangle_*$, and $m_1 * m_2 \in \langle V \rangle_*$. By construction of the product $*$, $m_1 m_2 = m_1 * m_2 + (1) \oplus \oplus_{k < j} \text{Im}(F_k)$. So by induction hypothesis, $x = m_1 m_2 \in \langle V \rangle_*$.

We denote by $S(V)$ the symmetric algebra generated by V .

Lemma 12.3 1. $\forall i \in \mathbb{N}^*$, $\dim(V_i)$ is the number of rooted trees of weight i .

2. There is an algebra isomorphism between (\mathcal{H}_R, \cdot) and $S(V)$ which is the identity on V .

Proof:

1. We have $\dim(V_i) = \dim(\mathcal{M}_i) - \dim(\mathcal{M}_i^2)$. A basis of \mathcal{M}_i is formed by forests of weight i , whereas a basis of \mathcal{M}_i^2 is formed by non connected forests of weight i . The first point is then obvious.

2. As \mathcal{H}_R is commutative, we have an algebra morphism:

$$\Lambda : \begin{cases} S(V) & \longmapsto (\mathcal{H}_R, \cdot) \\ x \in V & \longmapsto x \end{cases}$$

By lemma 12.1, Λ is surjective. $S(V)$ is graded as algebra by putting V_i in degree i . By the first point, the homogeneous components of $S(V)$ and \mathcal{H}_R (for the weight) have the same (finite) dimensions. Moreover, Λ is homogeneous of degree zero; as it is surjective, it is injective; so it is an isomorphism.

Using Λ , we define an algebra isomorphism:

$$\Xi : \begin{cases} (\mathcal{H}_R, \cdot) & \longmapsto (\mathcal{H}_R, *) \\ x \in V & \longmapsto x \end{cases}$$

By lemma 12.2, Ξ is surjective. Moreover, it is homogenous of degree zero for the weight; as the homogeneous components have the same finite dimensions in (\mathcal{H}_R, \cdot) and in $(\mathcal{H}_R, *)$, it is an isomorphism.

As the coproduct is the same for both Hopf algebra structures on \mathcal{H}_R , and since Ξ fix a system of generators, it is a bialgebra isomorphism. Moreover, $\Xi \circ S \circ \Xi^{-1}$ is an antipode of $(\mathcal{H}_R, *, \Delta)$, so it is equal to S_* . Hence, Ξ is a Hopf algebra isomorphism.

We have $\deg_p(\Xi(x)) \leq \deg_p(x) \forall x \in \mathcal{H}_R$, since it is true for any $x \in V$. We get:

$$\Xi(\{x \in \mathcal{H}_R / \deg_p(x) \leq j, \text{weight}(x) = i\}) \subset \{x \in \mathcal{H}_R / \deg_p(x) \leq j, \text{weight}(x) = i\} \forall i, j.$$

As these spaces have the same finite dimension, they are in fact equal. We deduce:

$$\Xi(\{x \in \mathcal{H}_R / \deg_p(x) = j\}) = \{x \in \mathcal{H}_R / \deg_p(x) = j\}.$$

We have entirely proved:

Theorem 12.4 $gr(\mathcal{H}_R)$ and \mathcal{H}_R are isomorphic Hopf algebras; there is a Hopf algebra isomorphism $\Xi : (\mathcal{H}_R, \cdot) \longmapsto (\mathcal{H}_R, *)$ such that $\text{weight}(\Xi(x)) = \text{weight}(x)$ and $\deg_p(\Xi(x)) = \deg_p(x)$ for any $x \in \mathcal{H}_R$.

We work now in $gr(\mathcal{H}_R)$. We denote by \mathcal{M}^{*2} the square of the augmentation ideal in this algebra. Let u_1 be a linear application from $Prim(gr(\mathcal{H}_R))$ into itself. Can we extend it to a bialgebra endomorphism of $gr(\mathcal{H}_R)$? With 11.4, one sees that $\overline{u_2}$ is entirely determined on $\mathcal{M}^{*2} \cap Im(F_2)$, and we can extend it to the whole $Im(F_2)$ as we want. More generally, $\overline{u_i}$ is determined over $\mathcal{M}^{*2} \cap Im(F_i)$. So in fact, if we fix a complement C of \mathcal{M}^{*2} , a bialgebra endomorphism Φ is entirely determined by $(\pi_1 \circ \Phi)|_C : C \longmapsto Prim(gr(\mathcal{H}_R))$. Moreover, for any application $L : C \longmapsto Prim(gr(\mathcal{H}_R))$, there is a unique bialgebra endomorphism Φ_L such that $(\pi_1 \circ \Phi_L)|_C = L$. Because of 12.4, we have the same result for \mathcal{H}_R . In this case, two important choices of C can be done:

1. if we choose C the subspace generated by the rooted trees: with notations of 10.1,

$$(\pi_1 \circ \Phi_{(p_t)})|_C : \begin{cases} \langle \text{rooted trees} \rangle & \longmapsto \text{Prim}(\mathcal{H}_R) \\ t & \longmapsto p_t. \end{cases}$$

2. if we choose a complement C which contains $\text{Prim}(\mathcal{H}_R)$, then we see that

$$\begin{cases} \text{End}_{\text{bialgebra}}(\mathcal{H}_R) & \longmapsto \mathcal{L}(\text{Prim}(\mathcal{H}_R)) \\ \Phi & \longmapsto \Phi|_{\text{Prim}(\mathcal{H}_R)} \end{cases} \text{ is surjective.}$$

Because of 11.3, we have a surjection:

$$\chi : \begin{cases} \text{Aut}_{\text{bialgebra}}(\mathcal{H}_R) & \longmapsto \text{GL}(\text{Prim}(\mathcal{H}_R)) \\ \Phi & \longmapsto \Phi|_{\text{Prim}(\mathcal{H}_R)} \end{cases}$$

We look for a lifting of $\text{GL}(\text{Prim}(\mathcal{H}_R))$ into $\text{Aut}_{\text{bialgebra}}(\mathcal{H}_R)$. It is easier to work in $\text{gr}(\mathcal{H}_R)$, for there is an obvious lifting: if $u \in \text{GL}(\text{Prim}(\mathcal{H}_R))$, we take $u_1 = u$, $u_i = 0$ if $i \geq 2$; then one proves easily that $\Phi_u = \Phi_{(u_i)} \in \text{Aut}_{\text{bialgebra}}(\mathcal{H}_R)$, and $\Phi_u \circ \Phi_v = \Phi_{u \circ v}$. So, with 10.3 we have the following result:

Theorem 12.5

$$\text{Aut}_{\text{bialgebra}}(\mathcal{H}_R) = \text{Aut}_{\text{Hopf}}(\mathcal{H}_R) = \text{Ker}(\chi) \rtimes \text{GL}(\text{Prim}(\mathcal{H}_R)).$$
