# A NON-HOMOGENEOUS ORBIT OF A DIAGONAL SUBGROUP 

FRANÇOIS MAUCOURANT


#### Abstract

Let $G=\mathbf{S L}(n, \mathbf{R})$ with $n \geq 6$. We construct examples of lattices $\Gamma \subset G$, subgroups $A$ of the diagonal group $D$ and points $x \in G / \Gamma$ such that the closure of the orbit $A x$ is not homogeneous and such that the action of $A$ does not factor through the action of a one-parameter non-unipotent group. This contradicts a conjecture of Margulis.


## 1. Introduction

1.1. Topological rigidity and related questions. Let $G$ be a real Lie group, $\Gamma$ a lattice in $G$, meaning a discrete subgroup of finite covolume, and $A$ a closed connected subgroup. We are interested in the action of $A$ on $G / \Gamma$ by left multiplication; we will restrict ourselves to the topological properties of these actions, referring the reader to [6] and [3] for references and recent developments on related measure theoretical problems.

Two linked questions arise when one studies continuous actions of topological groups: what are the closed invariant sets, and what are the orbit closures?

In the homogeneous action setting we are considering, there is a class of closed sets that admit a simple description: a closed subset $X \subset G$ is said to be homogeneous if there exists a closed connected subgroup $H \subset G$ such that $X=H x$ for some (and hence every) $x \in X$. Let us say that the action of $A$ on $G / \Gamma$ is topologically rigid if for any $x \in G / \Gamma$, the closure $\overline{A x}$ of the orbit $A x$ is homogeneous.

The most basic example of a topologically rigid action is when $G=\mathbf{R}^{n}, \Gamma=\mathbf{Z}^{n}$, $A$ any vector subspace of $G$. It turns out that the behavior of elements of $A$ for the adjoint action on the Lie algebra $\mathfrak{g}$ of $G$ plays a important role for our problem. Recall that an element $g \in G$ is said to be $\operatorname{Ad}$-unipotent if $\operatorname{Ad}(g)$ is unipotent, and $\mathbf{A d}$-split over $\mathbf{R}$ if $\mathbf{A d}(g)$ is diagonalizable over $\mathbf{R}$. If the closed, connected subgroup $A$ of $G$ is generated by Ad-unipotent elements, a celebrated theorem of Ratner [12] asserts that the action of $A$ is always topologically rigid, settling a conjecture due to Raghunathan.

When $A$ is generated by elements which are $\mathbf{A d}$-split over $\mathbf{R}$, much less is known. Consider the model case of $G=\mathbf{S L}(n, \mathbf{R})$ and $A$ the group of diagonal matrices with nonnegative entries. If $n=2$, it is easy to produce nonhomogeneous orbit closures (see e.g. [7]); more generally, a similar phenomenon can be observed when $A$ is a one-parameter subgroup of the diagonal group (see [6], 4.1). However, for $A$ the full diagonal group, if $n \geq 3$, to the best of our knowledge, the only nontrivial example of a nonhomogeneous $A$-orbit closure is due to Rees, later generalized in [7]. In an unpublished preprint, Rees exhibited a lattice $\Gamma$ of $G=\mathbf{S L}(3, \mathbf{R})$ and a point $x \in G / \Gamma$ such that for the full diagonal group $A$, the orbit closure $\overline{A x}$ is not homogeneous. Her construction was based on the following property of the lattice: there exists a $\gamma \in \Gamma \cap A$ such that the centralizer $C_{G}(\gamma)$ of $\gamma$ is isomorphic to $\mathbf{S L}(2, \mathbf{R}) \times \mathbf{R}^{*}$, and such that $C_{G}(\gamma) \cap \Gamma$ is, in this product decomposition and up to finite index, $\Gamma_{0} \times\langle\gamma\rangle$, where $\Gamma_{0}$ is a lattice in $\mathbf{S L}(2, \mathbf{R})$ (see [7], [7]). Thus in this case the action of $A$ on $C_{G}(\gamma) / C_{G}(\gamma) \cap \Gamma$ factors through the action of a 1-parameter non-unipotent subgroup on $\mathbf{S L}(2, \mathbf{R}) / \Gamma_{0}$, which, as we saw, has many non-homogeneous orbits.

Rees' example shows that factor actions of 1-parameter non-Ad-unipotent groups are obstructions to the topological rigidity of the action of diagonal subgroups. The following conjecture of Margulis [8, conjecture 1.1] (see also [6, 4.4.11]) essentially states that these are the only ones:

Conjecture 1. Let $G$ be a connected Lie group, $\Gamma$ a lattice in $G$, and $A$ a closed, connected subgroup of $G$ generated by Ad-split over $\mathbf{R}$ elements. Then for any $x \in G / \Gamma$, one of the following holds :
(a) $\overline{A x}$ is homogeneous, or
(b) There exists a closed connected subgroup $F$ of $G$ and a continuous epimorphism $\phi$ of $F$ onto a Lie group $L$ such that
$-A \subset F$,

- Fx is closed in $G / \Gamma$,
$-\phi\left(F_{x}\right)$ is closed in $L$, where $F_{x}$ denotes the stabilizer $\{g \in F \mid g x=x\}$,
$-\phi(A)$ is a one-parameter subgroup of $L$ containing no nontrivial $\mathbf{A d}_{L^{-}}$ unipotent elements.

A first step toward this conjecture has been done by Lindenstrauss and Weiss [7], who proved that in the case $G=\mathbf{S L}(n, \mathbf{R})$ and $A$ the full diagonal group, if the closure of a $A$-orbit contains a compact $A$-orbit that satisfy some irrationality conditions, then this closure is homogeneous. See also [14. Recently, using an approach based on measure theory, Einsiedler, Katok and Lindenstrauss proved that if moreover $\Gamma=\mathbf{S L}(n, \mathbf{Z})$, then the set of bounded $A$-orbits has Hausdorff dimension $n-1$ [3, Theorem 10.2].
1.2. Statement of the results. In this article we exhibit some counterexamples to the above conjecture when $G=\mathbf{S L}(n, \mathbf{R})$ for $n \geq 6$ and $A$ is some strict subgroup of the diagonal group of matrices with nonnegative entries. Let $D$ be
the diagonal subgroup of $G$; note that $D$ has dimension $n-1$. Our main result is:

Theorem 1. Assume $n \geq 6$.
(1) There exists a $(n-3)$ dimensional closed and connected subgroup $A$ of $D$, and a point $x \in \mathbf{S L}(n, \mathbf{R}) / \mathbf{S L}(n, \mathbf{Z})$ such that the closure of the $A$-orbit of $x$ satisfies neither condition (a) nor condition (b) of the conjecture.
(2) There exists a lattice $\Gamma$ of $\mathbf{S L}(n, \mathbf{R})$, a $(n-2)$ dimensional closed and connected subgroup $A$ of $D$ and a point $x \in \mathbf{S L}(n, \mathbf{R}) / \Gamma$ such that the closure of the $A$-orbit of $x$ satisfies neither condition (a) nor condition (b) of the conjecture.

It will be clear from the proofs that these examples however satisfy a third condition:
(c) There exists a closed connected subgroup $F$ of $G$ and two continuous epimorphisms $\phi_{1}, \phi_{2}$ of $F$ onto Lie groups $L_{1}, L_{2}$ such that
$-A \subset F$,

- Fx is closed in $G / \Gamma$,
- For $i=1,2, \phi_{i}\left(F_{x}\right)$ is closed in $L_{i}$,
- $\left(\phi_{1}, \phi_{2}\right): F \rightarrow L_{1} \times L_{2}$ is surjective
$-\left(\phi_{1}, \phi_{2}\right): A \rightarrow \phi_{1}(A) \times \phi_{2}(A)$ is not surjective.
Construction of these examples is the subject of Section \&, whereas the proof that they satisfy the required properties is postponed to Section 3 .
1.3. Toral endomorphisms. To conclude this introduction, we would like to mention that the idea behind this construction can be also used to yield examples of 'non-homogeneous' orbits for diagonal toral endomorphisms.

Let $1<p_{1}<\cdots<p_{q}$, with $q \geq 2$, be integers generating a multiplicative nonlacunary semigroup of $\mathbf{Z}$ (that is, the $\mathbf{Q}$-subspace $\oplus_{1 \leq i \leq q} \mathbf{Q} \log \left(p_{i}\right)$ has dimension at least 2). We consider the abelian semigroup $\Omega$ of endomorphisms of the torus $T^{n}=\mathbf{R}^{n} / \mathbf{Z}^{n}$ generated by the maps $z \mapsto p_{i} z \bmod \mathbf{Z}^{n}, 1 \leq i \leq q$.

In the one-dimensional situation, described by Furstenberg [5] , every $\Omega$-orbit is finite or dense. If $n \geq 2$, Berend [1] showed that minimal sets are the finite orbits of rational points, but there are others obvious closed $\Omega$-invariant sets, namely the orbits of rational affine subspaces. Roughly speaking, the study of the orbit of a point lying in a proper rational affine subspace reduces to the study of an orbit in a lower dimensional torus. A naïve first guess about the shape of orbit closures could be that any point outside any rational affine subspace has a dense orbit; unfortunately, this is not the case at least for $n \geq 2 q$, as the following example shows.

Theorem 2. Let $N$ be an integer greater than $q \frac{\log p_{q}}{\log p_{1}}$, and let $z$ be the point in the $2 q$-dimensional torus $T^{2 q}$ defined by the coordinates modulo 1:

$$
z=\left(z_{1}, \ldots, z_{2 q}\right)=\left(\sum_{k \geq 1} p_{1}^{-N^{2 k}}, \ldots, \sum_{k \geq 1} p_{q}^{-N^{2 k}}, \sum_{k \geq 1} p_{1}^{-N^{2 k+1}}, \ldots, \sum_{k \geq 1} p_{q}^{-N^{2 k+1}}\right)
$$

Then the point $z \in T^{2 q}$ is not contained in any rational affine subspace, but its orbit $\Omega z$ is not dense.

The proof of Theorem 2 will be the subject of Section 8 .

## 2. Sketch of proof of Theorem 1

2.1. The direct product setup. We now describe how these examples are built. Choose two integers $n_{1} \geq 3, n_{2} \geq 3$, such that $n_{1}+n_{2}=n$. For $i=1,2$, let $\Gamma_{i}$ be a lattice in $G_{i}=\operatorname{SL}\left(n_{i}, \mathbf{R}\right)$.

Let $g_{i}$ be an element of $G_{i}$ such that $g_{i} \Gamma_{i} g_{i}^{-1}$ intersects the diagonal subgroup $D_{i}$ of $\mathbf{S L}\left(n_{i}, \mathbf{R}\right)$ in a lattice, in other words $g_{i} \Gamma_{i}$ has a compact $D_{i}$-orbit; such elements exist, see [10]. In fact, we will need an additional assumption on $g_{i}$, namely that the tori $g_{i}^{-1} D_{i} g_{i}$ are irreducible over $\mathbf{Q}$. The precise definition of this property and the proof of the existence of such a $g_{i}$, a consequence of a theorem of Prasad and Rapinchuk [11, Theorem 1], will be the subject of Section 3.1.

Let $\pi_{i}: G_{i} \rightarrow G_{i} / \Gamma_{i}$ be the canonical quotient map. Define for $i=1,2$ :

$$
y_{i}=\pi_{i}\left(\left[\begin{array}{ccccc}
1 & 0 & \ldots & 0 & 1 \\
0 & 1 & \ddots & & 0 \\
\vdots & \ddots & \ddots & \ddots & \vdots \\
\vdots & & \ddots & 1 & 0 \\
0 & \ldots & \ldots & 0 & 1
\end{array}\right] g_{i}\right)
$$

The $D_{i}$-orbit of $y_{i}$ is dense, by the following argument. It is easily seen that the closure of $D_{i} y_{i}$ contains the compact $D_{i}$-orbit $\mathcal{T}_{i}=\pi_{i}\left(D_{i} g_{i}\right)$. The $\mathbf{Q}$-irreducibility of $\mathcal{T}_{i}$ is sufficient to show that the assumptions of the theorem of Lindenstrauss and Weiss [7, Theorem 1.1] are satisfied (Lemma 3.1); thus, by this theorem, we obtain that there exists a group $H_{i}<G_{i}$ such that $H_{i} y_{i}=\overline{D_{i} y_{i}}$. Again because of $\mathbf{Q}$-irreducibility, the group $H_{i}$ is necessarily the full group, i.e. $H_{i}=G_{i}$ (proof of Lemma (3.2) ${ }^{1}$.

[^0]Let $A_{1}$ be the $(n-3)$ dimensional subgroup of $G_{1} \times G_{2}$ given by:

$$
\begin{align*}
A_{1}=\{ & \left(\operatorname{diag}\left(a_{1}, . ., a_{n_{1}}\right), \operatorname{diag}\left(b_{1}, . ., b_{n_{2}}\right)\right): \\
& \left.\prod_{i=1}^{n_{1}} a_{i}=\prod_{j=1}^{n_{2}} b_{j}=\frac{a_{1} b_{1}}{a_{n_{1}} b_{n_{2}}}=1, a_{i}>0, b_{j}>0\right\} . \tag{1}
\end{align*}

Then the $A_{1}$-orbit of $\left(y_{1}, y_{2}\right)$ is not dense in $G_{1} \times G_{2} / \Gamma_{1} \times \Gamma_{2}$ (Lemma 3.3),
 $\overline{A_{1}\left(y_{1}, y_{2}\right)} \subset F\left(y_{1}, y_{2}\right)$ (Lemma 3.7).

This yields a counterexample to Conjecture 1 which can be summarized as follows:

Proposition 1. For $i=1,2$, let $n_{i} \geq 3$ and $\Gamma_{i}$ be a lattice in $G_{i}=\mathbf{S L}\left(n_{i}, \mathbf{R}\right)$. For $A_{1}, y_{1}, y_{2}$ depicted as above, the $A_{1}$-orbit of $\left(y_{1}, y_{2}\right)$ in $G_{1} \times G_{2} / \Gamma_{1} \times \Gamma_{2}$ satisfies neither condition (a) nor condition (b) of Conjecture $\mathbb{\square}$.
2.2. Theorem 1, part (1). In order to obtain the first part of Theorem 1, choose $\Gamma_{i}=\mathbf{S L}\left(n_{i}, \mathbf{Z}\right), \Gamma=\mathbf{S L}(n, \mathbf{Z})$ and consider the embedding of $G_{1} \times G_{2}$ in $G$, where matrices are written in blocks:

$$
\Psi:\left(M_{n_{1}, n_{1}}, N_{n_{2}, n_{2}}\right) \mapsto\left[\begin{array}{cc}
M_{n_{1}, n_{1}} & 0_{n_{1}, n_{2}}  \tag{2}\\
0_{n_{2}, n_{1}} & N_{n_{2}, n_{2}}
\end{array}\right] .
$$

This embedding gives rise to an embedding $\bar{\Psi}$ of $G_{1} \times G_{2} / \Gamma_{1} \times \Gamma_{2}$ into $G / \Gamma$. Let $y_{1}, y_{2}$ be two points as above, let $x=\bar{\Psi}\left(y_{1}, y_{2}\right)$ and take $A=\Psi\left(A_{1}\right)$. We claim that this point $x$ and this group $A$ satisfy Theorem [1, part (1). In fact, since the image of $\bar{\Psi}$ is a closed connected $A$-invariant subset of $\mathbf{S L}(n, \mathbf{R}) / \mathbf{S L}(n, \mathbf{Z})$, everything takes place in this direct product.
2.3. Theorem 1, part (2). The second part of Theorem 11 is obtained as follows. Let $\sigma$ be the nontrivial field automorphism of the quadratic extension $\mathbf{Q}(\sqrt[4]{2}) / \mathbf{Q}(\sqrt{2})$. Consider for any $m \geq 1$ :

$$
\mathbf{S U}(m, \mathbf{Z}[\sqrt[4]{2}], \sigma)=\left\{M \in \mathbf{S L}(m, \mathbf{Z}[\sqrt[4]{2}]):\left({ }^{t} M^{\sigma}\right) M=I_{m}\right\}
$$

Then $\mathbf{S U}(m, \mathbf{Z}[\sqrt[4]{2}], \sigma)$ is a lattice in $\mathbf{S L}(m, \mathbf{R})$, as will be proved in Section 3.5 (see 囲, Appendix] for $m=3$ ). Define for $i=1,2, \Gamma_{i}=\mathbf{S U}\left(n_{i}, \mathbf{Z}[\sqrt[4]{2}], \sigma\right)$, and $\Gamma=\mathbf{S U}(n, \mathbf{Z}[\sqrt[4]{2}], \sigma)$. Now consider the map:

$$
\begin{gathered}
\varphi: G_{1} \times G_{2} \times \mathbf{R} \rightarrow G \\
(X, Y, t) \mapsto\left[\begin{array}{cc}
e^{n_{2} t} X & 0 \\
0 & e^{-n_{1} t} Y
\end{array}\right] .
\end{gathered}
$$

Define $M$ to be the image of $\varphi$. This time, $\varphi$ factors into a finite covering $\bar{\varphi}$ of homogeneous spaces:

$$
\bar{\varphi}: G_{1} \times G_{2} \times \mathbf{R} / \Gamma_{1} \times \Gamma_{2} \times(\log \alpha) \mathbf{Z} \rightarrow M / M \cap \Gamma \subset G / \Gamma
$$

where $\alpha=(3+2 \sqrt{2})+\sqrt[4]{2}(2+2 \sqrt{2})$ satisfies $\alpha^{-1}=\sigma(\alpha)$. Consider the points $y_{i}$ constructed above, and let $x=\bar{\varphi}\left(y_{1}, y_{2}, 0\right)$. Choose:

$$
A=\left\{\operatorname{diag}\left(a_{1}, . ., a_{n}\right) \left\lvert\, \prod_{i=1}^{n} a_{i}=\frac{a_{1} a_{n_{1}+1}}{a_{n_{1}} a_{n}}=1\right., a_{i}>0\right\} \subset \mathbf{S L}(n, \mathbf{R}) .
$$

We claim that this lattice $\Gamma$, this point $x$ and this group $A$ satisfy Theorem 1, part (2). What happens here is that the $A$-orbit of $x$ is nothing else than a circle bundle over an $A_{1}$-orbit (up to the finite cover $\bar{\varphi}$ ), like in Rees' example.

## 3. Proof of Theorem 1

3.1. Q-irreducible tori. Fix $i \in\{1,2\}$. Recall that $\Gamma_{i}$ is a lattice in $G_{i}=$ $\mathbf{S L}\left(n_{i}, \mathbf{R}\right)$. Since $n_{i} \geq 3$, by Margulis's arithmeticity Theorem [15, Theorem 6.1.2], there exists a semisimple algebraic $\mathbf{Q}$-group $\mathbf{H}_{i}$ and a surjective homomorphism $\theta$ from the connected component of identity of the real points of this group $\mathbf{H}_{i}^{0}(\mathbf{R})$ to $\mathbf{S L}\left(n_{i}, \mathbf{R}\right)$, with compact kernel, such that $\theta\left(\mathbf{H}_{i}(\mathbf{Z}) \cap \mathbf{H}_{i}^{0}(\mathbf{R})\right)$ is commensurable with $\Gamma_{i}$.

Following Prasad and Rapinchuk, we say that a $\mathbf{Q}$-torus $\mathbf{T} \subset \mathbf{H}_{i}$ is $\mathbf{Q}$-irreducible if it does not contain any proper subtorus defined over $\mathbf{Q}$. By [11, Theorem 1,(ii)], there exists a maximal $\mathbf{Q}$-anisotropic $\mathbf{Q}$-torus $\mathbf{T}_{i} \subset \mathbf{H}_{i}$, which is $\mathbf{Q}$-irreducible. Because any two maximal $\mathbf{R}$-tori of $\mathbf{S L}\left(n_{i}, \mathbf{R}\right)$ are $\mathbf{R}$-conjugate, there exists $g_{i} \in G_{i}$ such that $\theta\left(\mathbf{T}_{i}^{0}(\mathbf{R})\right)=g_{i}^{-1} D_{i} g_{i}$. The subgroup $\mathbf{T}_{i}(\mathbf{Z})$ is a cocompact lattice in $\mathbf{T}_{i}(\mathbf{R})$ since $\mathbf{T}_{i}$ is $\mathbf{Q}$-anisotropic [2, Theorem 8.4 and Definition 10.5]. Because $\theta\left(\mathbf{H}_{i}(\mathbf{Z}) \cap \mathbf{H}_{i}^{0}(\mathbf{R})\right)$ and $\Gamma_{i}$ are commensurable and $\theta$ has compact kernel, it follows that both $\Gamma_{i} \cap g_{i}^{-1} D_{i} g_{i}$ and $\theta\left(\mathbf{T}_{i}^{0}(\mathbf{Z})\right) \cap \Gamma_{i} \cap g_{i}^{-1} D_{i} g_{i}$ are also cocompact lattices in $g_{i}^{-1} D_{i} g_{i}$. The resulting topological torus $\pi_{i}\left(D_{i} g_{i}\right) \subset G_{i} / \Gamma_{i}$ will be denoted $\mathcal{T}_{i}$. Write $z_{i}=\pi_{i}\left(g_{i}\right)$, so that $\mathcal{T}_{i}=D_{i} z_{i}$.

For every $1 \leq k<l \leq n_{i}$, define as in [7]:

$$
N_{k, l}^{(i)}=\left\{\operatorname{diag}\left(a_{1}, . ., a_{n_{i}}\right): \prod_{s=1}^{n_{i}} a_{s}=1, a_{k}=a_{l}, a_{s}>0\right\} \subset D_{i},
$$

Of interest to us amongst the consequences of $\mathbf{Q}$-irreducibility is the fact that no nontrivial element both contained in the lattice $\Gamma_{i}$ and in $g_{i}^{-1} D_{i} g_{i}$ lies in a wall of a Weyl chamber. This is expressed in the following form:

Lemma 3.1. For every $1 \leq k<l \leq n_{i}$, and any closed connected subgroup $L$ of positive dimension of $N_{k, l}^{(i)}$, the L-orbit of $z_{i}$ is not compact.

Proof. Assume the contrary, that is $L z_{i}$ is compact. This implies that $g_{i}^{-1} L g_{i} \cap \Gamma_{i}$ is a uniform lattice in $g_{i}^{-1} L g_{i}$, so $g_{i}^{-1} L g_{i} \cap \theta\left(\mathbf{H}_{i}(\mathbf{Z})\right)$ is also a uniform lattice. Since $L$ is nontrivial, there exists an element $\gamma \in \mathbf{H}_{i}(\mathbf{Z}) \cap \mathbf{H}_{i}^{0}(\mathbf{R})$ of infinite order, such that $g_{i} \theta(\gamma) g_{i}^{-1}$ is in $L$. Note that since $\theta$ has compact kernel, $\mathbf{T}_{i}(\mathbf{Z})$ is a lattice in $\theta^{-1}\left(\theta\left(\mathbf{T}_{i}^{0}(\mathbf{R})\right)\right.$ ) and is then a subgroup of finite index in $\mathbf{H}_{i}(\mathbf{Z}) \cap \mathbf{H}_{i}^{0}(\mathbf{R}) \cap$
$\theta^{-1}\left(\theta\left(\mathbf{T}_{i}^{0}(\mathbf{R})\right)\right)$, so there exists $n>0$ such that $\gamma^{n}$ belongs to $\mathbf{T}_{i}(\mathbf{Z})$. Consider the representation:

\begin{aligned}
\rho: & \mathbf{H}_{i}^{0}(\mathbf{R}) \rightarrow \mathbf{G L}\left(\mathfrak{s l}\left(n_{i}, \mathbf{R}\right)\right) \\
& x \mapsto \mathbf{A d}\left(g_{i} \theta(x) g_{i}^{-1}\right) .
\end{aligned}
$$

Recall that $\chi\left(\operatorname{diag}\left(a_{1}, . ., a_{n_{1}}\right)\right)=a_{k} / a_{l}$ is a weight of $\operatorname{Ad}$ with respect to $D_{i}$, so $\chi$ is a weight of $\rho$ with respect to $\mathbf{T}_{i}$. By [11, Proposition 1, (iii)], the Qirreducibility of $\mathbf{T}_{i}$ implies that $\chi\left(\gamma^{n}\right) \neq 1$, but this contradicts the fact that $\theta\left(\gamma^{n}\right) \in g_{i}^{-1} N_{k, l}^{(i)} g_{i}$.
3.2. Contraction and expansion. For real $s$, denote by $a_{i}(s)$ the following $n_{i} \times n_{i}$-matrix:

$$
a_{i}(s)=\operatorname{diag}(e^{s / 2}, \underbrace{1, \ldots, 1}_{n_{i}-2 \text { times }}, e^{-s / 2}),
$$

and write simply $N_{i}$ for $N_{1, n_{i}}^{(i)}$. Write also:

$$
h_{i}(t)=\left[\begin{array}{ccccc}
1 & 0 & \ldots & 0 & t \\
0 & 1 & \ddots & & 0 \\
\vdots & \ddots & \ddots & \ddots & \vdots \\
\vdots & & \ddots & 1 & 0 \\
0 & \ldots & \ldots & 0 & 1
\end{array}\right]
$$

Then the following commutation relation holds:

$$
a_{i}(s) h_{i}(t)=h_{i}\left(e^{s} t\right) a_{i}(s),
$$

that is the direction $h_{i}$ is expanded for positive $s$; note that both $h_{i}$ and $a_{i}$ commute with elements of $N_{i}$. It is easy to check from Equation (1) that

$$
A_{1}=\left\{\left(a_{1}(s) d_{1}, a_{2}(-s) d_{2}\right): s \in \mathbf{R}, d_{i} \in N_{i}, i=1,2\right\}
$$

Recall that $y_{i}=h_{i}(1) z_{i}$.
Lemma 3.2. (1) If $s \leq 0$, for any $d \in N_{i}$ the point $a_{i}(s) d y_{i}$ lies in the compact set $K_{i}=h_{i}([0,1]) \mathcal{T}_{i}$.
(2) The $D_{i}$-orbit of $y_{i}$ is dense in $G_{i} / \Gamma_{i}$.
(3) The set $\left\{a_{i}(s) d y_{i}: s \geq 0, d \in N_{i}\right\}$ is dense in $G_{i} / \Gamma_{i}$.

Proof. The first statement is clear from the commutation relation. It also implies that $D_{i} y_{i}$ contains the compact torus $\mathcal{T}_{i}$ in its closure.

To prove the second point, we rely heavily on the paper of Lindenstrauss and Weiss. [7, Theorem 1.1] applies here, since the hypotheses of their Theorem is precisely the conclusion of Lemma 3.1 for $L=N_{k, l}^{(i)}$. So the following holds: there exists a reductive subgroup $H_{i}$, containing $D_{i}$, such that $\overline{D_{i} y_{i}}=H_{i} y_{i}$, and $H_{i} \cap \Gamma_{i}$ is a lattice in $H_{i}$. Write $L=D_{i} \cap C_{G_{i}}\left(H_{i}\right)$.

Since $D_{i} y_{i}$ is not closed, $H_{i} \neq D_{i}$, so there exists a nontrivial root relatively to $D_{i}$ for the Adjoint representation of $H_{i}$ on its Lie algebra, which is a subalgebra of $\mathfrak{s l}\left(n_{i}, \mathbf{R}\right)$. Thus there exist $k, l$ such that $L \subset N_{k, l}^{(i)}$. By [7, step 4.1 of Lemma 4.2], $L z_{i}$ is compact, so by Lemma 3.1, $L$ is trivial. By [7, Proposition 3.1], $H_{i}$ is the connected component of the identity of $C_{G_{i}}(L)$, so $H_{i}=G_{i}$, as desired.

The third claim follows from the first and second claim together with the fact that $K_{i}$ has empty interior.

### 3.3. Topological properties of the $A_{1}$-orbit.

Lemma 3.3. The $A_{1}$-orbit of $\left(y_{1}, y_{2}\right)$ is not dense in $G_{1} \times G_{2} / \Gamma_{1} \times \Gamma_{2}$.
Proof. Consider the open set $U=K_{1}^{c} \times K_{2}^{c}$. We claim that the $A_{1}$-orbit of $\left(y_{1}, y_{2}\right)$ does not intersect $U$. Indeed, if $\left(a_{1}(s) d_{1}, a_{2}(-s) d_{2}\right) \in A_{1}$ with $s \in \mathbf{R}$ and $d_{i} \in N_{i}$, the previous Lemma implies that if $s \geq 0, a_{2}(-s) d_{2} y_{2} \in K_{2}$, and if $s \leq 0$, $a_{1}(s) d_{1} y_{1} \in K_{1}$.

The following elementary result will be useful:
Lemma 3.4. Let $p_{i}: G_{1} \times G_{2} \rightarrow G_{i}$ be the first (resp. second) coordinate morphism. If $F \subset G_{1} \times G_{2}$ is a subgroup such that $p_{i}(F)=G_{i}$ for $i=1,2$, and $A_{1} \subset F$, then $F=G_{1} \times G_{2}$.

Proof. Let $F_{1}=\operatorname{Ker}\left(p_{1}\right) \cap F$. Since $F_{1}$ is normal in $F, p_{2}\left(F_{1}\right)$ is normal in $p_{2}(F)=G_{2}$. Note that $N_{2} \subset p_{2}\left(A_{1} \cap \operatorname{Ker}\left(p_{1}\right)\right) \subset p_{2}\left(F_{1}\right)$ is not finite, and that $G_{2}$ is almost simple, consequently the normal subgroup $p_{2}\left(F_{1}\right)$ of $G_{2}$ is equal to $G_{2}$. Let $(a, b) \in G_{1} \times G_{2}$, by assumption there exists $f \in F$ such that $p_{1}(f)=a$. Let $f_{1} \in F_{1}$ be such that $p_{2}\left(f_{1}\right)=b p_{2}(f)^{-1}$, then $(a, b)=f_{1} f \in F$.

We will have to apply several times the two following well-known Lemmas:
Lemma 3.5. Let $L$ be a Lie group, $\Lambda \subset L$ a lattice, $M, N$ two closed, connected subgroups of $L$, such that for some $w \in L / \Lambda, M w$ and $N w$ are closed. Then $(M \cap N) w$ is closed.

Proof. This is a weaker form of [13, Lemma 2.2].
Lemma 3.6. Let $L$ be a connected Lie group, $\Lambda \subset L$ a discrete subgroup, $M, N$ two subgroups of $L$, such that $M$ is closed and connected, and $N$ is a countable union of closed sets. For any $w \in L / \Lambda$, if $M w \subset N w$, then $M \subset N$.

Proof. Up to changing $\Lambda$ by one of its conjugate in $L$, one can assume that $w=\Lambda \in L / \Lambda$. By assumption, $M \Lambda \subset N \Lambda$ so $M \subset N \Lambda \subset L$. Recall that $M$ is closed, that $\Lambda$ is countable, and that $N$ is a countable union of closed sets, so Baire's category Theorem applies, and there exists $\lambda \in \Lambda$ and an open set $U$ of $M$ such that $U \subset N \lambda$, so $U U^{-1} \subset N$. Since $M$ is a connected subgroup, $U U^{-1}$ generates $M$, so $M \subset N$.

The following lemma will be useful both for proving that the closure of $A_{1}\left(y_{1}, y_{2}\right)$ is not homogeneous, and for proving it does not fiber over a 1-parameter group orbit.

Lemma 3.7. Let $F$ be a closed connected subgroup of $G_{1} \times G_{2}$ such that $F\left(y_{1}, y_{2}\right)$ contains the closure of $A_{1}\left(y_{1}, y_{2}\right)$. Then $F=G_{1} \times G_{2}$.

Proof. By Lemma 3.2, the set of first coordinates of the set

$$
\left\{\left(a(s) d_{1} y_{1}, a(-s) d_{2} y_{2}\right): s \geq 0, d_{i} \in N_{i}\right\}
$$

is dense in $G_{1} / \Gamma_{1}$ and the second coordinates lies in the compact set $K_{2}$, so the closure of $A_{1}\left(y_{1}, y_{2}\right)$ contains points of arbitrary first coordinate with their second coordinate in $K_{2}$. Consequently, the set of first coordinates of $F\left(y_{1}, y_{2}\right)$ is the whole $G_{1} / \Gamma_{1}$, and similarly for the set of second coordinates. For $i=1,2$, Lemma 33.6 now applies to $L=M=G_{i}, \Lambda=\Gamma_{i}, N=p_{i}(F)$, which is a countable union of closed sets because $G_{1} \times G_{2}$ is $\sigma$-compact, and $w=y_{i}$, and so $p_{i}(F)=G_{i}$.

In order to apply Lemma 3.4 and finish the proof, we have to show that $A_{1} \subset F$. Again, this follows from a direct application of Lemma 3.6 to $L=G_{1} \times G_{2}$, $\Lambda=\Gamma_{1} \times \Gamma_{2}, M=A_{1}, N=F, w=\left(y_{1}, y_{2}\right)$.
3.4. Proof of Theorem 11, part (1). The proof of Proposition 1 is similar and omitted.

Recall that in this case, we fixed $A=\Psi\left(A_{1}\right)$ and $x=\bar{\Psi}\left(y_{1}, y_{2}\right)$.
Assume $\overline{A x}$ is homogeneous, that is $\overline{A x}=F x$ for a closed connected subgroup $F$ of $G$. Since $A x \subset \bar{\Psi}\left(G_{1} \times G_{2} / \Gamma_{1} \times \Gamma_{2}\right)$, which is closed in $G / \Gamma$, Lemma 3.6 imply that $F \subset \Psi\left(G_{1} \times G_{2}\right)$. By Lemma 3.7, $F=\Psi\left(G_{1} \times G_{2}\right)$, so $F x=G / \Gamma$ and $A x$ is dense in $\Psi\left(G_{1} \times G_{2}\right)$, which is a contradiction.
Now assume $\overline{A x}$ fibers over the orbit of a one-parameter subgroup. Let $F$ be a closed connected subgroup, $L$ a Lie group and $\phi: F \rightarrow L$ a continuous epimorphism satisfying the (b) of the conjecture. Let $F^{\prime}=F \cap \Psi\left(G_{1} \times G_{2}\right)$, we have $A \subset F^{\prime}$. By Lemma 3.5, $F^{\prime} x$ is closed in $F x \cap \bar{\Psi}\left(G_{1} \times G_{2}\right)$, so is closed in $G / \Gamma$. By Lemma 3.7, $F^{\prime}=\Psi\left(G_{1} \times G_{2}\right)$ necessarily. Let $H=\operatorname{Ker}(\phi \circ \Psi) \subset G_{1} \times G_{2}$, so $A_{1} /\left(A_{1} \cap H\right)$ is a one-parameter group by assumption (b).

The subgroup $H$ is a normal subgroup of the semisimple group $G_{1} \times G_{2}$, which has only four kind of normal subgroups : finite, $G_{1} \times G_{2}, G_{1} \times$ finite and finite $\times G_{2}$. None of these possible normal subgroups have the property that they intersect $A_{1}$ in a codimension 1 subgroup, so this is a contradiction.
3.5. The arithmetic lattice. Here we prove that $\mathbf{S U}(n, \mathbf{Z}[\sqrt[4]{2}], \sigma)$ is a lattice in $\mathbf{S L}(n, \mathbf{R})$. Let $P, Q$ be the polynomials with coefficients in $\mathbf{Q}(\sqrt{2})$ such that for any $X, Y \in M_{n}(\mathbf{C})$

$$
\operatorname{det}(X+\sqrt[4]{2} Y)=P(X, Y)+\sqrt[4]{2} Q(X, Y)
$$

For an integral domain $\mathbf{A} \subset \mathbf{C}$, consider the set of pairs of matrices:

$$
\begin{gathered}
\mathbf{G}(\mathbf{A})=\left\{(X, Y) \in M_{n}(\mathbf{A})^{2}::^{t} X X-\sqrt{2}^{t} Y Y=I_{n},{ }^{t} X Y-{ }^{t} Y X=0\right. \\
\\
P(X, Y)=1, Q(X, Y)=0\}
\end{gathered}
$$

which implies that $\left({ }^{t} X-\sqrt[4]{2}{ }^{t} Y\right)(X+\sqrt[4]{2} Y)=I_{n}$ and $\operatorname{det}(X+\sqrt[4]{2})=1$ for all $(X, Y) \in \mathbf{G}(\mathbf{A})$. Endow $\mathbf{G}(\mathbf{A})$ with the multiplication given by

$$
(X, Y)\left(X^{\prime}, Y^{\prime}\right)=\left(X X^{\prime}+\sqrt{2} Y Y^{\prime}, X Y^{\prime}+Y X^{\prime}\right)
$$

which is such that the map $\phi: \mathbf{G}(\mathbf{A}) \rightarrow \mathbf{S L}(n, \mathbf{C}),(X, Y) \mapsto X+\sqrt[4]{2} Y$ is a morphism. With this structure, $\mathbf{G}$ is an algebraic group, which is clearly defined over $\mathbf{Q}(\sqrt{2})$. Let $\tau$ be the nontrivial field automorphism of $\mathbf{Q}(\sqrt{2}) / \mathbf{Q}$, it can be checked that the map $\phi$ is an isomorphism between $\mathbf{G}(\mathbf{R})$ and $\mathbf{S L}(n, \mathbf{R})$, and that moreover $\phi^{\prime}: \mathbf{G}^{\tau}(\mathbf{R}) \rightarrow \mathbf{S L}(n, \mathbf{C}),(X, Y) \mapsto X+i \sqrt[4]{2} Y$ is an isomorphism onto $\mathbf{S U}(n)$. Let $\mathbf{H}=\operatorname{Res}_{\mathbf{Q}(\sqrt{2}) / \mathbf{Q}} \mathbf{G}=\mathbf{G} \times \mathbf{G}^{\tau}$. Then $\mathbf{H}$ is defined over $\mathbf{Q}$ (see for example [15, 6.1.3], for definition and properties of the restriction of scalars functor). It follows from a Theorem of Borel and Harish-Chandra [15, Theorem 3.1.7] that $\mathbf{H}(\mathbf{Z})$ is a lattice in $\mathbf{H}(\mathbf{R})$. Since $\mathbf{S U}(n)$ is compact, it follows that the projection of $\mathbf{H}(\mathbf{Z})$ onto the first factor of $\mathbf{G}(\mathbf{R}) \times \mathbf{G}^{\tau}(\mathbf{R})$ is again a lattice. Using the isomorphism between $\mathbf{G}(\mathbf{R})$ and $\mathbf{S L}(n, \mathbf{R})$, this projection can be identified with

$$
\mathbf{G}(\mathbf{Z}[\sqrt{2}])=\mathbf{S U}(n, \mathbf{Z}[\sqrt{2}]+\sqrt[4]{2} \mathbf{Z}[\sqrt{2}], \sigma)=\mathbf{S U}(n, \mathbf{Z}[\sqrt[4]{2}], \sigma)
$$

3.6. Proof of Theorem 1, part (2). Note that, as stated implicitely in Section 2.3 ,

$$
\varphi\left(\Gamma_{1} \times \Gamma_{2} \times(\log \alpha) \mathbf{Z}\right) \subset \Gamma \cap M,
$$

so $\Gamma \cap M$ is a lattice in $M$, and $M /(M \cap \Gamma)$ is a closed, $A$-invariant subset of $G / \Gamma$. Notice also that the map $\Psi$ defined by Equation (22) defines an embedding $\bar{\Psi}: G_{1} \times G_{2} / \Gamma_{1} \times \Gamma_{2} \rightarrow G / \Gamma$.

Assume $\overline{A x}$ is homogeneous, that is $\overline{A x}=F x$ for a closed connected subgroup $F$ of $G$. Since $A x \subset M /(M \cap \Gamma)$, which is closed in $G / \Gamma$, Lemma 3.6 applied twice gives that $A \subset F \subset M$. Let $F^{\prime}=F \cap \Psi\left(G_{1} \times G_{2}\right)$, again by Lemma 3.5, $F^{\prime} x$ is a closed subset of $\operatorname{Im}(\bar{\Psi})$. Since $A_{1} \subset F^{\prime}, \Psi\left(A_{1}\right) x \subset F^{\prime} x$ and Lemma 3.7 implies that $F^{\prime}=\Psi\left(G_{1} \times G_{2}\right)$. Since $A$ contains $\varphi(e, e, t)$ for all $t \in \mathbf{R}$, we have $M=A F^{\prime} \subset F$ so $F=M$ necessarily.

By Lemma 3.3, the $A_{1}$-orbit of $\left(y_{1}, y_{2}\right)$ is not dense; the topological transitivity of the action of $A_{1}$ on $G_{1} \times G_{2} / \Gamma_{1} \times \Gamma_{2}$ implies that moreover the closure of this orbit has empty interior. Thus, the $A_{1} \times \mathbf{R}$-orbit of $\left(y_{1}, y_{2}, 0\right)$ is also nowhere dense in $G_{1} \times G_{2} \times \mathbf{R} / \Gamma_{1} \times \Gamma_{2} \times(\log \alpha) \mathbf{Z}$. The map $\bar{\varphi}$ being a finite covering, the $A$-orbit of $x$ is nowhere dense. This is a contradiction with $F=M$.

Now assume $\overline{A x}$ fibers over the orbit of a one-parameter non-Ad-unipotent subgroup. Let $F$ be a closed connected subgroup, $L$ a Lie group and $\phi: F \rightarrow L$ a continuous epimorphism satisfying the (b) of the conjecture. Let $F^{\prime}=F \cap$
$\Psi\left(G_{1} \times G_{2}\right)$ and $F^{\prime \prime}=F \cap M$, we have $A_{1} \subset F^{\prime}$ and $A \subset F^{\prime \prime}$. Similarly, $F^{\prime} x$ and $F^{\prime \prime} x$ are closed in $G / \Gamma$. Again, by Lemma 3.7, $F^{\prime}=\Psi\left(G_{1} \times G_{2}\right)$ necessarily, and like before, $A F^{\prime} \subset F^{\prime \prime} \subset M$ so $F^{\prime \prime}=M$.

Let $H=\operatorname{Ker}(\phi \circ \varphi) \subset G_{1} \times G_{2} \times \mathbf{R}$, so $A_{1} \times \mathbf{R} /\left(A_{1} \times \mathbf{R} \cap H\right)$ is a oneparameter group. This time, possibilities for the closed normal subgroup $H$ are: finite $\times \Lambda, G_{1} \times G_{2} \times \Lambda, G_{1} \times$ finite $\times \Lambda$ and finite $\times G_{2} \times \Lambda$, where $\Lambda$ is a closed subgroup of $\mathbf{R}$. Of all these possibilities, only $G_{1} \times G_{2} \times \Lambda$, where $\Lambda$ is discrete, has the required property that $A_{1} \times \mathbf{R} /\left(A_{1} \times \mathbf{R} \cap H\right)$ is a one-parameter group. This proves that $\Psi\left(G_{1} \times G_{2}\right) \subset \operatorname{Ker}(\phi)$, so $F \subset N_{G}\left(\Psi\left(G_{1} \times G_{2}\right)\right)$. However, the normalizer of $\Psi\left(G_{1} \times G_{2}\right)$ in $G$ is the group of block matrices having for connected component of the identity the group $M$. So by connectedness of $F, F \subset M$, and since $M=F^{\prime \prime} \subset F$, we have $F=M$. Thus $L=F / \operatorname{Ker}(\phi)=\mathbf{R} / \Lambda$ is abelian, and a fortiori every element of $L$ is unipotent; this contradicts (b).

## 4. Proof of Theorem 2

The proof of Theorem 2 is divided in two independent lemmas.
Lemma 4.1. The family $\left(z_{1}, \ldots, z_{2 q}, 1\right)$ is linearly independent over $\mathbf{Q}$.
Proof. Consider a linear combination:

$$
\sum_{i=1}^{q} a_{i} z_{i}+b_{i} z_{i+q}=c .
$$

We can assume that $a_{i}, b_{i}$ and $c$ are integers. Let $k_{0} \geq 1$, write

$$
\begin{align*}
\left(\prod_{i=1}^{q} p_{i}\right)^{N^{2 k_{0}+1}}\left(\sum_{i=1}^{q}\right. & \left.\sum_{k=1}^{k_{0}} a_{i} p_{i}^{-N^{2 k}}+b_{i} p_{i}^{-N^{2 k+1}}-c\right)=  \tag{3}\\
& -\left(\prod_{i=1}^{q} p_{i}\right)^{N^{2 k_{0}+1}}\left(\sum_{i=1}^{q} \sum_{k \geq k_{0}+1} a_{i} p_{i}^{-N^{2 k}}+b_{i} p_{i}^{-N^{2 k+1}}\right) .
\end{align*}
$$

It is clear the left hand side is an integer. Since $1<p_{1}<\cdots<p_{q}$, the right hand side is less in absolute value than

$$
\begin{aligned}
& p_{q}^{q N^{2 k_{0}+1}} 2 q \sup _{i}\left(\left|a_{i}\right|,\left|b_{i}\right|\right) \sum_{k \geq 0}\left(p_{1}^{-N^{2 k_{0}+2}}\right)^{N^{2 k}} \\
& \leq 4 q \sup _{i}\left(\left|a_{i}\right|,\left|b_{i}\right|\right) p_{q}^{q N^{2 k_{0}+1}} p_{1}^{-N^{2 k_{0}+2}} \\
& \quad \leq 4 q \sup _{i}\left(\left|a_{i}\right|,\left|b_{i}\right|\right) \exp \left(N^{2 k_{0}+1}\left(q \log p_{q}-N \log p_{1}\right)\right) .
\end{aligned}
$$

Since $N>q \frac{\log \left(p_{q}\right)}{\log \left(p_{1}\right)}$, the last expression tends to zero. This proves the right-hand side of (3) is zero for large enough $k_{0}$, so for all large $k$,

$$
\sum_{i=1}^{q} a_{i} p_{i}^{-N^{2 k}}+b_{i} p_{i}^{-N^{2 k+1}}=0
$$

The $p_{i}$ being distincts, this implies that for $i \in\{1, . ., q\}, a_{i}=b_{i}=0$.
The following Lemma implies easily that the orbit of $z$ under $\Omega$ cannot be dense.

Lemma 4.2. For all $\epsilon>0$, there exists $L>0$, such that for all $n_{1}, . ., n_{q} \geq 0$ with $\sum_{i=1}^{q} n_{i} \geq L$, there exists $j \in\{1, \ldots, 2 q\}$ such that $p_{1}^{n_{1}} \cdots p_{q}^{n_{q}} z_{j}$ lies in the interval $[0, \epsilon]$ modulo 1 .
Proof. Let $s \in\{1, \ldots, q\}$ such that for all $r \in\{1, \ldots, q\}$, $p_{s}^{n_{s}} \geq p_{r}^{n_{r}}$. Let $k_{0}$ be the integer part of $\log \left(n_{s}\right) / 2 \log (N)$, then either $N^{2 k_{0}} \leq n_{s} \leq N^{2 k_{0}+1}$, or $N^{2 k_{0}+1} \leq n_{s} \leq N^{2 k_{0}+2}$. In the first case, take $j=s$, then:

$$
p_{1}^{n_{1}} \cdots p_{q}^{n_{q}} z_{j}=p_{1}^{n_{1}} \cdots p_{q}^{n_{q}} \sum_{k \geq 1} p_{s}^{-N^{2 k}}=p_{1}^{n_{1}} \cdots p_{q}^{n_{q}} \sum_{k \geq k_{0}+1} p_{s}^{-N^{2 k}} \bmod 1 .
$$

We have

$$
\sum_{k \geq k_{0}+1} p_{s}^{-N^{2 k}} \leq 2 p_{s}^{-N^{2 k_{0}+2}}
$$

so, using the fact that for all $r \in\{1, \ldots, q\}, p_{r}^{n_{r}} \leq p_{s}^{n_{s}} \leq p_{s}^{N^{2 k_{0}+1}}$, we obtain:

$$
p_{1}^{n_{1}} \cdots p_{q}^{n_{q}} \sum_{k \geq k_{0}+1} p_{s}^{-N^{2 k}} \leq 2 p_{s}^{q N^{2 k_{0}+1}-N^{2 k_{0}+2}} \leq 2 p_{s}^{N^{2 k_{0}+1}(q-N)},
$$

but by hypothesis we have $N>q \frac{\log \left(p_{q}\right)}{\log \left(p_{1}\right)}>q$, so the preceding bound is small whenever $k_{0}$ is large. Because of the definition of $k_{0}$, we have

$$
k_{0} \geq \frac{\log \frac{\sum_{i=1}^{q} n_{i} \log p_{i}}{q \log p_{q}}}{2 \log N} \geq \frac{\log \frac{L \log p_{1}}{q \log p_{q}}}{2 \log N}
$$

so $k_{0}$ is arbitrary large when $L$ is large.
In the second case $N^{2 k_{0}+1} \leq n_{s} \leq N^{2 k_{0}+2}$, one can proceed similarly with $j=s+q$.
