# ON THE BASE LOCUS OF THE LINEAR SYSTEM OF GENERALIZED THETA FUNCTIONS 

CHRISTIAN PAULY


#### Abstract

Let $\mathcal{M}_{r}$ denote the moduli space of semi-stable rank- $r$ vector bundles with trivial determinant over a smooth projective curve $C$ of genus $g$. In this paper we study the base locus $\mathcal{B}_{r} \subset \mathcal{M}_{r}$ of the linear system of the determinant line bundle $\mathcal{L}$ over $\mathcal{M}_{r}$, i.e., the set of semi-stable rank- $r$ vector bundles without theta divisor. We construct base points in $\mathcal{B}_{g+2}$ over any curve $C$, and base points in $\mathcal{B}_{4}$ over any hyperelliptic curve. We also show that $\mathcal{B}_{4}$ over a curve of genus 2 consists of 16 reduced points, which are in canonical bijection with the set of theta-characteristics of $C$.


## 1. Introduction

Let $C$ be a complex smooth projective curve of genus $g$ and let $\mathcal{M}_{r}$ denote the coarse moduli space parametrizing semi-stable rank- $r$ vector bundles with trivial determinant over the curve $C$. Let $\mathcal{L}$ be the determinant line bundle over the moduli space $\mathcal{M}_{r}$ and let $\Theta \subset \operatorname{Pic}^{g-1}(C)$ be the Riemann theta divisor in the degree $g-1$ component of the Picard variety of $C$. By [BNR] there is a canonical isomorphism $|\mathcal{L}|^{*} \xrightarrow{\sim}|r \Theta|$, under which the natural rational map $\varphi_{\mathcal{L}}: \mathcal{M}_{r} \rightarrow|\mathcal{L}|^{*}$ is identified with the so-called theta map

$$
\theta: \mathcal{M}_{r} \rightarrow|r \Theta|, \quad E \mapsto \theta(E) \subset \operatorname{Pic}^{g-1}(C)
$$

The underlying set of $\theta(E)$ consists of line bundles $L \in \operatorname{Pic}^{g-1}(C)$ with $h^{0}(C, E \otimes L)>0$. For a general semi-stable vector bundle $E, \theta(E)$ is a divisor. If $\theta(E)=\operatorname{Pic}^{g-1}(C)$, we say that $E$ has no theta divisor. We note that the indeterminacy locus of the theta map $\theta$, i.e., the set of bundles $E$ without theta divisor, coincides with the base locus $\mathcal{B}_{r} \subset \mathcal{M}_{r}$ of the linear system $|\mathcal{L}|$.

Over the past years many authors [A], [B2], He] [Hi], [P], [R], [S] have studied the base locus $\mathcal{B}_{r}$ of $|\mathcal{L}|$ and their analogues for the powers $\left|\mathcal{L}^{k}\right|$. For a recent survey of this subject we refer to [B1].

It is natural to introduce for a curve $C$ the integer $r(C)$ defined as the minimal rank for which there exists a semi-stable rank- $r(C)$ vector bundle with trivial determinant over $C$ without theta divisor (see also [B1] section 6). It is known [B] that $r(C) \geq 3$ for any curve $C$ and that $r(C) \geq 4$ for a generic curve $C$. Our first result shows the existence of vector bundles of low ranks without theta divisor.

Theorem 1.1. We assume that $g \geq 2$. Then we have the following bounds
(1) $r(C) \leq g+2$.
(2) $r(C) \leq 4$, if $C$ is hyperelliptic.

[^0]The first part of the theorem improves the upper bound $r(C) \leq \frac{(g+1)(g+2)}{2}$ given in [A]. The statements of the theorem are equivalent to the existence of a semi-stable rank- $(g+2)$ (resp. rank-4) vector bundle without theta divisor - see section 2.1 (resp. 2.2). The construction of these vector bundles uses ingredients which are already implicit in [Hi].

Theorem 1.1 seems to hint towards a dependence of the integer $r(C)$ on the curve $C$.
In the second part of this paper we specialize to the case $g=2$. By a result of Raynaud $\mathbb{R} \rrbracket$ we have $r(C)=4$ for any curve $C$. We give a full description of the base locus $\mathcal{B}_{4} \subset \mathcal{M}_{4}$.
Theorem 1.2. Let $C$ be a curve of genus 2 .
(1) The base locus $\mathcal{B}_{4}$ is of dimension 0 , reduced and of cardinality 16.
(2) There exists a canonical bijection between $\mathcal{B}_{4}$ and the set of theta-characteristics of $C$. Let $E_{\kappa} \in \mathcal{B}_{4}$ denote the stable vector bundle associated with the theta-characteristic $\kappa$. Then

$$
\Lambda^{2} E_{\kappa}=\bigoplus_{\alpha \in S(\kappa)} \alpha, \quad \operatorname{Sym}^{2} E_{\kappa}=\bigoplus_{\alpha \in J[2] \backslash S(\kappa)} \alpha
$$

where $S(\kappa)$ is the set of 2 -torsion line bundles $\alpha \in J[2]$ such that $\kappa \alpha \in \Theta \subset \operatorname{Pic}^{1}(C)$.
(3) If $\kappa$ is odd, then $E_{\kappa}$ is a symplectic bundle. If $\kappa$ is even, then $E_{\kappa}$ is an orthogonal bundle with non-trivial Stiefel-Whitney class.
(4) The 16 vector bundles $E_{\kappa}$ are invariant under the tensor product with the group $J[2]$.

The 16 base points $E_{\kappa}$ already appeared in Raynaud's paper [R] as Fourier-Mukai transforms and were further studied in [Hi] and [H] , where they are called Raynaud bundles - see section 3.2. We note that for $g=2$ the two constructions of Theorem 1.1 coincide and give the 16 Raynaud bundles. We also remark that the restriction of $\mathcal{B}_{4}$ to symplectic rank- 4 bundles has been worked out in [Hi]. The method of this paper is different.

For $g=2$ the theta map $\theta$ is a generically finite, dominant map (B2]. The degree of this map is known only for rank-3 bundles (see e.g. [0]). An alternate interpretation of this degree is given in BV]. Theorem 1.2 can be applied to compute the degree of $\theta$ for rank- 4 bundles.
Corollary 1.3. The degree of the rational theta map $\theta: \mathcal{M}_{4} \rightarrow|4 \Theta|$ equals 30 .

Notations: If $E$ is a vector bundle over $C$, we will write $H^{i}(E)$ for $H^{i}(C, E)$ and $h^{i}(E)$ for $\operatorname{dim} H^{i}(C, E)$. We denote the slope of $E$ by $\mu(E):=\frac{\operatorname{deg} E}{\operatorname{rk} E}$, the canonical bundle over $C$ by $K$ and the degree $d$ component of the Picard variety of $C$ by $\operatorname{Pic}^{d}(C)$. We denote by $J:=\operatorname{Pic}^{0}(C)$ the Jacobian of $C$ and by $J[n]$ its group of $n$-torsion points. The divisor $\Theta_{\kappa} \subset J$ is the translate of the Riemann theta divisor $\Theta \subset \operatorname{Pic}^{g-1}(C)$ by a theta-characteristic $\kappa$. The line bundle $\mathcal{O}_{J}\left(2 \Theta_{\kappa}\right)$ does not depend on $\kappa$ and will be denoted by $\mathcal{O}_{J}(2 \Theta)$.

## 2. Proof of Theorem 1.1

2.1. Semi-stable rank- $(g+2)$ vector bundles without theta divisor. We consider a line bundle $L \in \operatorname{Pic}^{2 g+1}(C)$. Then $L$ is globally generated, $h^{0}(L)=g+2$ and the evaluation bundle $E_{L}$, which is defined by the exact sequence

$$
\begin{equation*}
0 \longrightarrow E_{L}^{*} \longrightarrow H^{0}(L) \otimes \mathcal{O}_{C} \xrightarrow{e v} L \longrightarrow 0 \tag{1}
\end{equation*}
$$

is stable (see e.g. [Bul), with $\operatorname{deg} E_{L}=2 g+1, \operatorname{rk} E_{L}=g+1$ and $\mu\left(E_{L}\right)=2-\frac{1}{g+1}$.
A cohomology class $e \in \operatorname{Ext}^{1}\left(L K^{-1}, E_{L}\right)=H^{1}\left(E_{L} \otimes K L^{-1}\right)$ determines a rank- $(g+2)$ vector bundle $\mathcal{E}_{e}$ given as an extension

$$
\begin{equation*}
0 \longrightarrow E_{L} \longrightarrow \mathcal{E}_{e} \longrightarrow L K^{-1} \longrightarrow 0 \tag{2}
\end{equation*}
$$

Proposition 2.1. For any non-zero class e, the rank- $(g+2)$ vector bundle $\mathcal{E}_{e}$ is semi-stable.
Proof. Consider a proper subbundle $A \subset \mathcal{E}_{e}$ and let $S=A \cap E_{L} \subset E_{L}$. Then there is an exact sequence

$$
0 \longrightarrow S \longrightarrow A \longrightarrow L K^{-1}(-D) \longrightarrow 0
$$

where $D$ is an effective divisor. If $\operatorname{rk} S=g+1$ or $S=0$, we easily conclude that $\mu(A)<\mu\left(\mathcal{E}_{e}\right)=2$. If $\operatorname{rk} S<g+1$ and $S \neq 0$, then stability of $E_{L}$ gives the inequality $\mu(S)<\mu\left(E_{L}\right)=2-\frac{1}{g+1}$. We introduce the integer $\delta=2 \operatorname{rk} S-\operatorname{deg} S$. Then the previous inequality is equivalent to $\delta \geq 1$. Now we compute

$$
\mu(A)=\frac{\operatorname{deg} S+\operatorname{deg} L K^{-1}(-D)}{\operatorname{rk} S+1} \leq \frac{2 \operatorname{rk} S-\delta+3}{\operatorname{rk} S+1}=2+\frac{1-\delta}{\operatorname{rk} S+1} \leq 2=\mu\left(\mathcal{E}_{e}\right),
$$

which shows the semi-stablity of $\mathcal{E}_{e}$.
We tensorize the exact sequence ( $(\mathbb{\square})$ with $L$ and take the cohomology

$$
\begin{equation*}
0 \longrightarrow H^{0}\left(E_{L}^{*} \otimes L\right) \longrightarrow H^{0}(L) \otimes H^{0}(L) \xrightarrow{\mu} H^{0}\left(L^{2}\right) \longrightarrow 0 \tag{3}
\end{equation*}
$$

Note that $h^{1}\left(E_{L}^{*} \otimes L\right)=h^{0}\left(E_{L} \otimes K L^{-1}\right)=0$ by stability of $E_{L}$. The second map $\mu$ is the multiplication map and factorizes through $\operatorname{Sym}^{2} H^{0}(L)$, i.e.,

$$
\Lambda^{2} H^{0}(L) \subset H^{0}\left(E_{L}^{*} \otimes L\right)=\operatorname{ker} \mu
$$

By Serre duality a cohomology class $e \in \operatorname{Ext}^{1}\left(L K^{-1}, E_{L}\right)=H^{1}\left(E_{L} \otimes K L^{-1}\right)=H^{0}\left(E_{L}^{*} \otimes L\right)^{*}$ can be viewed as a hyperplane $H_{e} \subset H^{0}\left(E_{L}^{*} \otimes L\right)$. Then we have the following
Proposition 2.2. If $\Lambda^{2} H^{0}(L) \subset H_{e}$, then the vector bundle $\mathcal{E}_{e}$ satisfies

$$
h^{0}\left(\mathcal{E}_{e} \otimes \lambda\right)>0, \quad \forall \lambda \in \operatorname{Pic}^{g-3}(C) .
$$

Proof. We tensorize the exact sequence (2) with $\lambda \in \operatorname{Pic}^{g-3}(C)$ and take the cohomology

$$
0 \longrightarrow H^{0}\left(E_{L} \otimes \lambda\right) \longrightarrow H^{0}\left(\mathcal{E}_{e} \otimes \lambda\right) \longrightarrow H^{0}\left(L K^{-1} \lambda\right) \xrightarrow{\cup e} H^{1}\left(E_{L} \otimes \lambda\right) \longrightarrow \cdots
$$

Since $\operatorname{deg} L K^{-1} \lambda=g$, we can write $L K^{-1} \lambda=\mathcal{O}_{C}(D)$ for some effective divisor $D$. It is enough to show that $h^{0}\left(\mathcal{E}_{e} \otimes \lambda\right)>0$ holds for $\lambda$ general. Hence we can assume that $h^{0}\left(L K^{-1} \lambda\right)=$ $h^{0}\left(\mathcal{O}_{C}(D)\right)=1$.

If $h^{0}\left(E_{L} \otimes \lambda\right)>0$, we are done. So we assume $h^{0}\left(E_{L} \otimes \lambda\right)=0$, which implies $h^{1}\left(E_{L} \otimes \lambda\right)=1$ by Riemann-Roch. Hence we obtain that $h^{0}\left(\mathcal{E}_{e} \otimes \lambda\right)>0$ if and only if the cup product map

$$
\cup e: H^{0}\left(\mathcal{O}_{X}(D)\right) \longrightarrow H^{1}\left(E_{L} \otimes \lambda\right)=H^{0}\left(E_{L}^{*} \otimes L(-D)\right)^{*}
$$

is zero. Furthermore $\cup e$ is zero if and only if $H^{0}\left(E_{L}^{*} \otimes L(-D)\right) \subset H_{e}$. The proposition then will follow from the inclusion

$$
H^{0}\left(E_{L}^{*} \otimes L(-D)\right) \subset \Lambda^{2} H^{0}(L)
$$

which is seen as follows. We tensorize the exact sequence (1) with $L(-D)$ and take cohomology

$$
0 \longrightarrow H^{0}\left(E_{L}^{*} \otimes L(-D)\right) \longrightarrow H^{0}(L) \otimes H^{0}(L(-D)) \xrightarrow{\mu} H^{0}\left(L^{2}(-D)\right) \longrightarrow \cdots
$$

Since $h^{0}\left(E_{L}^{*} \otimes L(-D)\right)=1$, we conclude that $h^{0}(L(-D))=2$ and $H^{0}\left(E_{L}^{*} \otimes L(-D)\right)=$ $\Lambda^{2} H^{0}(L(-D)) \subset \Lambda^{2} H^{0}(L)$.

We introduce the linear subspace $\Gamma \subset \operatorname{Ext}^{1}\left(L K^{-1}, E_{L}\right)$ defined by

$$
\Gamma:=\operatorname{ker}\left(\operatorname{Ext}^{1}\left(L K^{-1}, E_{L}\right)=H^{0}\left(E_{L}^{*} \otimes L\right)^{*} \longrightarrow \Lambda^{2} H^{0}(L)^{*}\right),
$$

which has dimension $\frac{g(g-1)}{2}>0$. Then for any non-zero cohomology class $e \in \Gamma$ and any $\gamma \in \operatorname{Pic}^{2}(C)$ satisfying $\gamma^{g+2}=L^{2} K^{-1}=\operatorname{det} \mathcal{E}_{e}$, the rank- $(g+2)$ vector bundle

$$
\mathcal{E}_{e} \otimes \gamma^{-1}
$$

has trivial determinant, is semi-stable by Proposition 2.1 and has no theta divisor by Proposition 2.2.
2.2. Hyperelliptic curves. In this subsection we assume that $C$ is hyperelliptic and we denote by $\sigma$ the hyperelliptic involution. The construction of a semi-stable rank- 4 vector bundle without theta divisor has been given in [Hi] section 6 in the case $g=2$, but it can be carried out for any $g \geq 2$ without major modification. For the convenience of the reader, we recall the construction and refer to $\# \mathrm{Hi}]$ for the details and the proofs.

Let $w \in C$ be a Weierstrass point. Any non-trivial extension

$$
0 \longrightarrow \mathcal{O}_{C}(-w) \longrightarrow G \longrightarrow \mathcal{O}_{C} \longrightarrow 0
$$

is a stable, $\sigma$-invariant, rank-2 vector bundle with $\operatorname{deg} G=-1$. By [Hi] Theorem 4 a cohomology class $e \in H^{1}\left(\operatorname{Sym}^{2} G\right)$ determines a symplectic rank-4 bundle

$$
0 \longrightarrow G \longrightarrow \mathcal{E}_{e} \longrightarrow G^{*} \longrightarrow 0
$$

Moreover it is easily seen that, for any non-zero class $e$, the vector bundle $\mathcal{E}_{e}$ is semi-stable. By [Hi] Lemma 16 the composite map

$$
D_{G}: \mathbb{P} H^{1}\left(\operatorname{Sym}^{2} G\right) \longrightarrow \mathcal{M}_{4} \xrightarrow{\theta}|4 \Theta|, \quad e \mapsto \theta\left(\mathcal{E}_{e}\right)
$$

is the projectivization of a linear map

$$
\widetilde{D_{G}}: H^{1}\left(\operatorname{Sym}^{2} G\right) \longrightarrow H^{0}\left(\operatorname{Pic}^{g-1}(C), 4 \Theta\right) .
$$

The involution $i(L)=K L^{-1}$ on $\mathrm{Pic}^{g-1}(C)$ induces a linear involution on $|4 \Theta|$ with eigenspaces $|4 \Theta|_{ \pm}$. Note that $4 \Theta \in|4 \Theta|_{+}$. We now observe that $\theta(\mathcal{E}) \in|4 \Theta|_{+}$for any symplectic rank- 4 vector bundle $\mathcal{E}$ - see e.g. B2]. Moreover we have the equality $\theta\left(\sigma^{*} \mathcal{E}\right)=i^{*} \theta(\mathcal{E})$ for any vector bundle $\mathcal{E}$. These two observations imply that the linear map $\widetilde{D_{G}}$ is equivariant with respect to the induced involutions $\sigma$ and $i$. Since im $\widetilde{D_{G}} \subset H^{0}\left(\mathrm{Pic}^{g-1}(C), 4 \Theta\right)_{+}$, we obtain that one of the two eigenspaces $H^{1}\left(\operatorname{Sym}^{2} G\right)_{ \pm}$is contained in the kernel ker $\widetilde{D_{G}}$, hence give base points for the theta map. We now compute as in [Hi] using the Atiyah-Bott-fixed-point formula

$$
h^{1}\left(\operatorname{Sym}^{2} G\right)_{+}=g-1, \quad h^{1}\left(\operatorname{Sym}^{2} G\right)_{-}=2 g+1 .
$$

One can work out that $H^{1}\left(\operatorname{Sym}^{2} G\right)_{+} \subset$ ker $\widetilde{D_{G}}$. Hence any $\mathcal{E}_{e}$ with non-zero $e \in H^{1}\left(\operatorname{Sym}^{2} G\right)_{+}$ is a semi-stable rank- 4 vector bundle without theta divisor.

## 3. Proof of Theorem 1.2

3.1. The 16 base points $E_{\kappa}$. We first show that the set-theoretical support of $\mathcal{B}_{4}$ consists of 16 stable vector bundles $E_{\kappa}$, which are canonically labelled by the theta-characteristics of $C$.

We note that $\mathcal{B}_{4} \neq \emptyset$ by Theorem 1.1. We consider a vector bundle $\mathcal{E} \in \mathcal{B}_{4}$. Since $r(C)=4$, we deduce that $\mathcal{E}$ is stable. We introduce $\mathcal{E}^{\prime}=\mathcal{E}^{*} \otimes K$. Then $\mu\left(\mathcal{E}^{\prime}\right)=2$ and since $\mathcal{E} \in \mathcal{B}_{4}$, we obtain that $h^{0}\left(\mathcal{E}^{\prime} \otimes \lambda^{-1}\right)=h^{1}(\mathcal{E} \otimes \lambda)=h^{0}(\mathcal{E} \otimes \lambda)>0$ for any $\lambda \in \operatorname{Pic}^{1}(C)$. In particular for any $x \in C$ we have $h^{0}\left(\mathcal{E}^{\prime} \otimes \mathcal{O}_{C}(-x)\right)>0$. On the other hand stability of $\mathcal{E}$ implies that $h^{0}(\mathcal{E})=h^{1}\left(\mathcal{E}^{\prime}\right)=0$. Hence $h^{0}\left(\mathcal{E}^{\prime}\right)=4$ by Riemann-Roch. Thus we obtain that the evaluation map of global sections

$$
\mathcal{O}_{C} \otimes H^{0}\left(\mathcal{E}^{\prime}\right) \xrightarrow{e v} \mathcal{E}^{\prime}
$$

is not of maximal rank. Let us denote by $I:=\operatorname{im} e v$ the subsheaf of $\mathcal{E}^{\prime}$ given by the image of $e v$. Then clearly $h^{0}(I)=4$. The cases rk $I \leq 2$ are easily ruled out using stability of $\mathcal{E}^{\prime}$. Hence we conclude that rk $I=3$. We then consider the natural exact sequence

$$
\begin{equation*}
0 \longrightarrow L^{-1} \longrightarrow \mathcal{O}_{C} \otimes H^{0}\left(\mathcal{E}^{\prime}\right) \xrightarrow{e v} I \longrightarrow 0, \tag{4}
\end{equation*}
$$

where $L$ is the line bundle such that $L^{-1}:=$ ker $e v$.
Proposition 3.1. We have $h^{0}\left(I^{*}\right)=0$.
Proof. Suppose on the contrary that there exists a non-zero map $I \rightarrow \mathcal{O}_{C}$. Its kernel $S \subset I$ is a rank-2 subsheaf of $\mathcal{E}^{\prime}$ and by stability of $\mathcal{E}^{\prime}$ we obtain $\mu(S)<\mu\left(\mathcal{E}^{\prime}\right)=2$, hence $\operatorname{deg} S \leq 3$. Moreover $h^{0}(S) \geq h^{0}(I)-1=3$.

Assume that $\operatorname{deg} S=3$. Then $S$ is stable and $S$ can be written as an extension

$$
0 \longrightarrow \mu \longrightarrow S \longrightarrow \nu \longrightarrow 0
$$

with $\operatorname{deg} \mu=1$ and $\operatorname{deg} \nu=2$. The condition $h^{0}(S) \geq 3$ then implies that $\mu=\mathcal{O}_{C}(x)$ for some $x \in C, \nu=K$ and that the extension has to be split, i.e., $S=K \oplus \mathcal{O}_{C}(x)$. This contradicts stability of $S$.

The assumption $\operatorname{deg} S \leq 2$ similarly leads to a contradiction. We leave the details to the reader.

Now we take the cohomology of the dual of the exact sequence (4) and we obtain - using $h^{0}\left(I^{*}\right)=0-$ an inclusion $H^{0}\left(\mathcal{E}^{\prime}\right)^{*} \subset H^{0}(L)$. Hence $h^{0}(L) \geq 4$, which implies deg $L \geq 5$. On the other hand $\operatorname{deg} L=\operatorname{deg} I$ and by stability of $\mathcal{E}^{\prime}$, we have $\mu(I)<2$, i.e., $\operatorname{deg} L \leq 5$. So we can conclude that $\operatorname{deg} L=5$, that $H^{0}\left(\mathcal{E}^{\prime}\right)^{*}=H^{0}(L)$ and that $I=E_{L}$, where $E_{L}$ is the evaluation bundle associated to $L$ defined in (11).

Moreover the subsheaf $E_{L} \subset \mathcal{E}^{\prime}$ is of maximal degree, hence $E_{L}$ is a subbundle of $\mathcal{E}^{\prime}$ and we have an exact sequence

$$
0 \longrightarrow E_{L} \longrightarrow \mathcal{E}^{\prime} \longrightarrow K^{4} L^{-1} \longrightarrow 0
$$

with extension class $e \in \operatorname{Ext}^{1}\left(K^{4} L^{-1}, E_{L}\right)=H^{1}\left(E_{L} \otimes K^{-4} L\right)=H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}\right)^{*}$. Using Riemann-Roch and stability of $E_{L}$ one shows that

$$
h^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}\right)=7, \quad h^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}(-x)\right)=4, \quad h^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}(-x-y)\right)=1
$$

for general points $x, y \in C$. In that case we denote by $\mu_{x, y} \in \mathbb{P} H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}\right)$ the point determined by the 1-dimensional subspace $H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}(-x-y)\right)$. We also denote by

$$
\mathbb{S} \subset \mathbb{P} H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}\right)
$$

the linear span of the points $\mu_{x, y}$ when $x$ and $y$ vary in $C$ and by $H_{e} \subset \mathbb{P} H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}\right)$ the hyperplane determined by the non-zero class $e$.

By the same argument as in the proof of Theorem 1.1 one shows that $\mu_{x, y} \in H_{e}$ if and only if $h^{0}\left(\mathcal{E}^{\prime} \otimes K^{-4} L(x+y)\right)>0$. Since we assume $\mathcal{E} \in \mathcal{B}_{4}$, we obtain

$$
\mathbb{S} \subset H_{e}
$$

We consider a general point $x \in C$ such that $h^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}(-x)\right)=4$ and denote for simplicity

$$
A:=E_{L}^{*} \otimes K^{5} L^{-1}(-x)
$$

Then $A$ is stable with $\mu(A)=\frac{7}{3}$. We consider the evaluation map of global sections

$$
e v_{A}: \mathcal{O}_{C} \otimes H^{0}(A) \longrightarrow A
$$

and consider the set $S_{A}$ of points $p \in C$ for which $\left(e v_{A}\right)_{p}$ is not surjective, i.e.

$$
S_{A}=\left\{p \in C \mid h^{0}(A(-p)) \geq 2\right\}
$$

Then we have the following
Lemma 3.2. We assume that $x$ is general.
(1) If $L^{2} \neq K^{5}$, then the set $S_{A}$ consists of the 2 distinct points $p_{1}, p_{2}$ determined by $\mathcal{O}_{C}\left(p_{1}+\right.$ $\left.p_{2}\right)=K^{4} L^{-1}(-x)$.
(2) If $L^{2}=K^{5}$, then the set $S_{A}$ consists of the 2 distinct points $p_{1}, p_{2}$ introduced in (1) and the conjugate $\sigma(x)$ of $x$ under the hyperelliptic involution $\sigma$.

Proof. Given a point $p \in C$, we tensorize the exact sequence (11) with $K^{5} L^{-1}(-x-p)$ and take cohomology:

$$
0 \longrightarrow H^{0}(A(-p)) \longrightarrow H^{0}(L) \otimes H^{0}\left(K^{5} L^{-1}(-x-p)\right) \longrightarrow H^{0}\left(K^{5}(-x-p)\right) \longrightarrow \cdots
$$

We note that $h^{0}\left(K^{5} L^{-1}(-x-p)\right)=2$. We distinguish two cases.
(a) The pencil $\left|K^{5} L^{-1}(-x-p)\right|$ has a base-point, i.e. there exists a point $q \in C$ such that $K^{5} L^{-1}(-x-p)=K(q)$, or equivalently $K^{4} L^{-1}(-x)=\mathcal{O}_{C}(p+q)$. Since $x$ is general, we have $h^{0}\left(K^{4} L^{-1}(-x)\right)=1$, which determines $p$ and $q$, i.e., $\{p, q\}=\left\{p_{1}, p_{2}\right\}$. In this case $\mid K^{5} L^{-1}(-x-$ $p)\left|=|K(q)|=|K|\right.$ and $h^{0}(A(-p))=h^{0}\left(K^{-1} L\right)=2$. This shows that $p_{1}, p_{2} \in S_{A}$.
(b) The pencil $\left|K^{5} L^{-1}(-x-p)\right|$ is base-point-free. By the base-point-free-pencil-trick, we have $H^{0}(A(-p)) \cong H^{0}\left(L^{2} K^{-5}(x+p)\right)$. Since $\operatorname{deg} L^{2} K^{-5}(x+p)=2$, we have $h^{0}\left(L^{2} K^{-5}(x+p)\right)=2$ if and only if $L^{2} K^{-5}(x+p)=K$, or equivalently $\mathcal{O}_{C}(p)=K^{6} L^{-2}(-x)$. If $K^{6} L^{-2} \neq K$, then for general $x \in C$ the line bundle $K^{6} L^{-2}(-x)$ is not of the form $\mathcal{O}_{C}(p)$. If $K^{6} L^{-2}=K$, then for any $x \in C, K^{6} L^{-2}(-x)=\mathcal{O}_{C}(\sigma(x))$, which implies that $\sigma(x) \in S_{A}$.

This shows the lemma.
Proposition 3.3. If $L^{2} \neq K^{5}$, then $\mathbb{S}=\mathbb{P} H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}\right)$.

Proof. We consider a general point $x \in C$ and the rank-3 bundle $A$. Let $B \subset A$ denote the subsheaf given by the image of $e v_{A}$. By Lemma 3.2 (1) we have $\operatorname{deg} B=\operatorname{deg} A-2=5$. Moreover $H^{0}(B)=H^{0}(A)$ and there is an exact sequence

$$
\begin{equation*}
0 \longrightarrow M^{-1} \longrightarrow \mathcal{O}_{C} \otimes H^{0}(B) \xrightarrow{e v_{A}} B \longrightarrow 0 \tag{5}
\end{equation*}
$$

with $M \in \operatorname{Pic}^{5}(C)$. It follows that the rational map

$$
\phi_{x}: C \rightarrow \mathbb{P} H^{0}(B)=\mathbb{P} H^{0}(A)=\mathbb{P}^{3}, \quad y \mapsto \mu_{x, y}
$$

factorizes through

$$
C \xrightarrow{\varphi_{M}}|M|^{*} \longrightarrow \mathbb{P} H^{0}(B),
$$

where $\varphi_{M}$ is the morphism given by the linear system $|M|$ and the second map is linear and identifies with the projectivization of the dual of $\delta$, which is given by the long exact sequence obtained from (5) by dualizing and taking cohomology:

$$
0 \longrightarrow H^{0}\left(B^{*}\right) \longrightarrow H^{0}(B)^{*} \xrightarrow{\delta} H^{0}(M) \longrightarrow H^{1}\left(B^{*}\right) \longrightarrow \cdots
$$

We obtain that the linear span of im $\phi_{x}$ is non-degenerate if and only if $h^{0}\left(B^{*}\right)=0$.
We now show that $h^{0}\left(B^{*}\right)=0$. Suppose on the contrary that there exists a non-zero map $B \rightarrow \mathcal{O}_{C}$. Its kernel $S \subset B$ is a rank-2 subsheaf of $A$ with $\operatorname{deg} S \geq \operatorname{deg} B=5$, hence $\mu(S) \geq \frac{5}{2}$, which contradicts stability of $A$ - recall that $\mu(A)=\frac{7}{3}$.

This shows that im $\phi_{x}$ spans $\mathbb{P} H^{0}(A) \subset \mathbb{P} H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}\right)$ for general $x \in C$. We now take 2 general points $x, x^{\prime} \in C$ and deduce from $\operatorname{dim} H^{0}(A) \cap H^{0}\left(A^{\prime}\right)=\operatorname{dim} H^{0}\left(E_{L}^{*} \otimes K^{5} L^{-1}(-x-\right.$ $\left.\left.x^{\prime}\right)\right)=1$ that the linear span of the union $\mathbb{P} H^{0}(A) \cap \mathbb{P} H^{0}\left(A^{\prime}\right)$ equals the full space $\mathbb{P} H^{0}\left(E_{L}^{*} \otimes\right.$ $K^{5} L^{-1}$ ). This shows the proposition.

We deduce from the proposition that the line bundle $L$ satisfies the relation $L^{2}=K^{5}$, i.e.

$$
L=K^{2} \kappa
$$

for some theta-characteristic $\kappa$ of $C$. In that case the extension space $H^{0}\left(E_{L} \otimes K^{5} L^{-1}\right)^{*}$ equals $H^{0}\left(E_{L}^{*} \otimes L\right)^{*}$ and we have the exact sequence (3). As already noticed in section 2.1 we have a natural inclusion $\Lambda^{2} H^{0}(L) \subset H^{0}\left(E_{L}^{*} \otimes L\right)$. More precisely we can show
Proposition 3.4. The linear span $\mathbb{S}$ equals

$$
\mathbb{S}=\mathbb{P} \Lambda^{2} H^{0}(L) \subset \mathbb{P} H^{0}\left(E_{L}^{*} \otimes L\right)
$$

Proof. Using the standard exact sequences and the base-point-free-pencil-trick, one easily works out that for general points $x, y \in C$

$$
\mu_{x, y}=\mathbb{P} \Lambda^{2} H^{0}(L(-x-y)) \subset \mathbb{P} \Lambda^{2} H^{0}(L) \subset \mathbb{P} H^{0}\left(E_{L}^{*} \otimes L\right) .
$$

This implies that $\mathbb{S} \subset \mathbb{P} \Lambda^{2} H^{0}(L)$. In order to show equality one chooses 4 general points $x_{i} \in C$ such that their images $C \rightarrow|L|^{*}=\mathbb{P}^{3}$ linearly span the $\mathbb{P}^{3}$. We denote by $s_{i} \in H^{0}(L)$ the global section vanishing on the points $x_{j}$ for $j \neq i$ and not vanishing on $x_{i}$. Then one checks that for any choice of the indices $i, j, k, l$ such that $\{i, j, k, l\}=\{1,2,3,4\}$ one has $s_{i} \wedge s_{j}=\mu_{x_{k}, x_{l}}$. Since the 6 tensors $s_{i} \wedge s_{j}$ are a basis of $\Lambda^{2} H^{0}(L)$, we obtain equality.

The hyperplane $\mathbb{S}=\mathbb{P} \Lambda^{2} H^{0}(L) \subset \mathbb{P} H^{0}\left(E_{L}^{*} \otimes L\right)$ determines a unique (up to a scalar) non-zero extension class $e \in H^{0}\left(E_{L}^{*} \otimes L\right)^{*}$ by $\mathbb{S}=H_{e}$, which in turn determines a unique stable vector bundle $\mathcal{E} \in \mathcal{B}_{4}$, which we will denote by $E_{\kappa}$.

This shows that $\mathcal{B}_{4}$ is of dimension 0 and of cardinality 16 .
3.2. The Raynaud bundles. In this subsection we recall the construction of the Raynaud bundles introduced in [母] as Fourier-Mukai transforms. We refer to [Hi] section 9.2 for the details and the proofs.

The rank-4 vector bundle $\mathcal{O}_{J}(2 \Theta) \otimes H^{0}\left(J, \mathcal{O}_{J}(2 \Theta)\right)^{*}$ over $J$ admits a canonical $J[2]$-linearization and descends therefore under the duplication map [2]:J $\rightarrow J$, i.e., there exists a rank-4 vector bundle $M$ over $J$ such that

$$
[2]^{*} M \cong \mathcal{O}_{J}(2 \Theta) \otimes H^{0}\left(J, \mathcal{O}_{J}(2 \Theta)\right)^{*} .
$$

Proposition 3.5. For any theta-characteristic $\kappa$ of $C$ there exists an isomorphism

$$
\xi_{\kappa}: M \xrightarrow{\sim} M^{*} \otimes \mathcal{O}_{J}\left(\Theta_{\kappa}\right) .
$$

Moreover if $\kappa$ is even (resp. odd), then $\xi_{\kappa}$ is symmetric (resp. skew-symmetric).
Let $\gamma_{\kappa}: C \rightarrow J$ be the Abel-Jacobi map defined by $\gamma_{\kappa}(p)=\kappa^{-1}(p)$. We define the Raynaud bundle

$$
R_{\kappa}:=\gamma_{\kappa}^{*} M \otimes \kappa^{-1}
$$

Then by [R] the bundle $R_{\kappa} \in \mathcal{B}_{4}$. Since $\gamma_{\kappa}^{*} \mathcal{O}_{J}\left(\Theta_{\kappa}\right)=K$ we see that the isomorphism $\xi_{\kappa}$ induces an orthogonal (resp. symplectic) structure on the bundle $R_{\kappa}$, if $\kappa$ is even (resp. odd). In particular the bundle $R_{\kappa}$ is self-dual, i.e., $R_{\kappa}=R_{\kappa}^{*}$. The pull-back $\gamma_{\kappa}^{*}\left(\xi_{\kappa}^{\prime}\right)$ for a thetacharacteristic $\kappa^{\prime}=\kappa \alpha$ with $\alpha \in J[2]$ gives an isomorphism

$$
R_{\kappa} \xrightarrow{\sim} R_{\kappa}^{*} \otimes \alpha,
$$

hence a non-zero section in $H^{0}\left(\Lambda^{2} R_{\kappa} \otimes \alpha\right)\left(\right.$ resp. $\left.H^{0}\left(\operatorname{Sym}^{2} R_{\kappa} \otimes \alpha\right)\right)$ if $h^{0}(\kappa \alpha)=1\left(\right.$ resp. $h^{0}(\kappa \alpha)=$ $0)$. We deduce that there are isomorphisms

$$
\begin{equation*}
\Lambda^{2} R_{\kappa}=\bigoplus_{\alpha \in S(\kappa)} \alpha, \quad \operatorname{Sym}^{2} R_{\kappa}=\bigoplus_{\alpha \in J[2] \backslash S(\kappa)} \alpha \tag{6}
\end{equation*}
$$

In particular the 16 bundles $R_{\kappa}$ are non-isomorphic. Each $R_{\kappa}$ is invariant under tensor product with $J[2]$. The isomorphisms (6) can be used to prove the relation

$$
\begin{equation*}
R_{\kappa} \otimes \beta=R_{\kappa \beta^{2}}, \quad \forall \beta \in J[4] . \tag{7}
\end{equation*}
$$

3.3. Symplectic and orthogonal bundles. In this subsection we give a third construction of the bundles in $\mathcal{B}_{4}$ as symplectic and orthogonal extension bundles. Let $\kappa$ be a thetacharacteristic.

If $\kappa$ is odd, then $\kappa=\mathcal{O}_{C}(w)$ for some Weierstrass point $w \in C$. The construction outlined in section 2.2 gives a unique symplectic bundle $\mathcal{E}_{e} \in \mathcal{B}_{4}$ with $e \in H^{1}\left(\operatorname{Sym}^{2} G\right)_{+}$. We denote this bundle by $V_{\kappa}$.

If $\kappa$ is even, there is an analogue construction, which we briefly outline for the convenience of the reader. The proofs are similar to those given in [Hi]. Using the Atiyah-Bott-fixed-point formula one observes that among all non-trivial extensions

$$
0 \longrightarrow \kappa^{-1} \longrightarrow G \longrightarrow \mathcal{O}_{C} \longrightarrow 0
$$

there are 2 extensions (up to scalar), which are $\sigma$-invariant. We take one of them. Then any non-zero class $e \in H^{1}\left(\Lambda^{2} G\right)=H^{1}\left(\kappa^{-1}\right)$ determines an orthogonal bundle $\mathcal{E}_{e}$, which fits in the exact sequence

$$
\begin{equation*}
0 \longrightarrow G \longrightarrow \mathcal{E}_{e} \longrightarrow G^{*} \longrightarrow 0 \tag{8}
\end{equation*}
$$

The composite map

$$
D_{G}: \mathbb{P} H^{1}\left(\Lambda^{2} G\right) \longrightarrow \mathcal{M}_{4} \xrightarrow{\theta}|4 \Theta|, \quad e \mapsto \theta\left(\mathcal{E}_{e}\right)
$$

is the projectivization of a linear map

$$
\widetilde{D_{G}}: H^{1}\left(\Lambda^{2} G\right) \longrightarrow H^{0}\left(\operatorname{Pic}^{1}(C), 4 \Theta\right)
$$

Moreover im $\widetilde{D_{G}} \subset H^{0}\left(\operatorname{Pic}^{1}(C), 4 \Theta\right)_{-}$, which can be seen as follows. By [S]] Thm 2 the second Stiefel-Whitney class $w_{2}\left(\mathcal{E}_{e}\right)$ of an orthogonal bundle $\mathcal{E}_{e}$ is given by the parity of $h^{0}\left(\mathcal{E}_{e} \otimes \kappa^{\prime}\right)$ for any theta-characteristic $\kappa^{\prime}$. This parity can be computed by taking the cohomology of the exact sequence (8) tensorized with $\kappa^{\prime}$ and taking into account that the coboundary map is skewsymmetric. One obtains that $w_{2}\left(\mathcal{E}_{e}\right) \neq 0$ and one can conclude the above-mentioned inclusion by (B3) Lemma 1.4.

We now observe that by the Atiyah-Bott-fixed-point-formula $h^{1}\left(\Lambda^{2} G\right)_{+}=h^{1}\left(\Lambda^{2} G\right)_{-}=1$. By the argument given in section 2.2 we conclude that one of the two eigenspaces $H^{1}\left(\Lambda^{2} G\right)_{ \pm}$is contained in the kernel ker $\widetilde{D_{G}}$. We denote the corresponding bundle $\mathcal{E}_{e}$ by $V_{\kappa} \in \mathcal{B}_{4}$.

### 3.4. Three descriptions of the same bundle.

Proposition 3.6. For any theta-characteristic $\kappa$ the three bundles $E_{\kappa}, R_{\kappa}$ and $V_{\kappa}$ coincide.
Proof. If $\kappa$ is odd, this was worked out in detail in [H] section 8 and Theorem 29. If $\kappa$ is even, the proofs are similar.

This proposition shows all assertions of Theorem 1.2 except reducedness of $\mathcal{B}_{4}$.
3.5. Reducedness of $\mathcal{B}_{4}$. We start with a description of the space of global sections $H^{0}\left(\mathcal{M}_{4}, \mathcal{L}\right)$.

Proposition 3.7. For any theta-characteristic $\kappa$ there is a section $s_{\kappa} \in H^{0}\left(\mathcal{M}_{4}, \mathcal{L}\right)$ with zero divisor

$$
\Delta_{\kappa}:=\operatorname{Zero}\left(s_{\kappa}\right)=\left\{E \in \mathcal{M}_{4} \mid h^{0}\left(\Lambda^{2} E \otimes \kappa\right)>0\right\} .
$$

The 16 sections $s_{\kappa}$ form a basis of $H^{0}\left(\mathcal{M}_{4}, \mathcal{L}\right)$.
Proof. The Dynkin index of the second fundamental representation $\rho: \mathfrak{s l}_{4}(\mathbb{C}) \rightarrow \operatorname{End}\left(\Lambda^{2} \mathbb{C}^{4}\right)$ equals 2 (see e.g. [LS] Proposition 2.6). Moreover the bundle $\Lambda^{2} E \otimes \kappa$ admits a $K$-valued nondegenerate quadratic form, which allows to construct the Pfaffian divisor $s_{\kappa}$, which is a section of $\mathcal{L}$ (see LSS ). The space $H^{0}\left(\mathcal{M}_{4}, \mathcal{L}\right)$ is a representation of level 2 of the Heisenberg group Heis(2), which is a central extension of $J[2]$ by $\mathbb{C}^{*}$. One can work out that the sections $s_{\kappa}$ generate the 16 one-dimensional character spaces for the Heis(2)-action on $H^{0}\left(\mathcal{M}_{4}, \mathcal{L}\right)$. This shows that the sections $s_{\kappa}$ are linearly independent.

Since $E_{\kappa} \in \mathcal{B}_{4}$, we have $E_{\kappa} \in \Delta_{\kappa^{\prime}}$ for any theta-characteristic $\kappa^{\prime}$. By the deformation theory of determinant and Pfaffian divisors (see e.g. [प], [S]) the point $E_{\kappa} \in \mathcal{M}_{4}$ is a smooth point of the divisor $\Delta_{\kappa^{\prime}} \subset \mathcal{M}_{4}$ if and only if the following two conditions hold
(1) $h^{0}\left(\Lambda^{2} E_{\kappa} \otimes \kappa^{\prime}\right)=2$,
(2) the natural linear form

$$
\Phi_{\kappa^{\prime}}: T_{E_{\kappa}} \mathcal{M}_{4}=H^{1}\left(\operatorname{End}_{0}\left(E_{\kappa}\right)\right) \longrightarrow \Lambda^{2} H^{0}\left(\Lambda^{2} E_{\kappa} \otimes \kappa^{\prime}\right)^{*}
$$

is non-zero.

Moreover if these two conditions holds, then $T_{E_{\kappa}} \Delta_{\kappa^{\prime}}=\operatorname{ker} \Phi_{\kappa^{\prime}}$. The map $\Phi_{\kappa^{\prime}}$ is built up as follows: the exceptional isomorphism of Lie algebras $\mathfrak{s l}_{4} \cong \mathfrak{s o}_{6}$ induces a natural vector bundle isomorphism

$$
\begin{equation*}
\operatorname{End}_{0}\left(E_{\kappa}\right) \xrightarrow{\sim} \Lambda^{2}\left(\Lambda^{2} E_{\kappa}\right) . \tag{9}
\end{equation*}
$$

Then $\Phi_{\kappa^{\prime}}$ is the dual of the linear map given by the wedge product of global sections

$$
\Lambda^{2} H^{0}\left(\Lambda^{2} E_{\kappa} \otimes \kappa^{\prime}\right) \longrightarrow H^{0}\left(\Lambda^{2}\left(\Lambda^{2} E_{\kappa}\right) \otimes K\right)=H^{0}\left(\operatorname{End}_{0}\left(E_{\kappa}\right) \otimes K\right)
$$

Proposition 3.8. The 0 -dimensional scheme $\mathcal{B}_{4}$ is reduced.
Proof. Since $E_{\kappa}$ is a smooth point of $\mathcal{M}_{4}$ and $\operatorname{dim} T_{E_{\kappa}} \mathcal{M}_{4}=15$, it is sufficient to show that for any theta-characteristic $\kappa^{\prime} \neq \kappa$ the divisor $\Delta_{\kappa^{\prime}}$ is smooth at $E_{\kappa}$ and that the 15 hyperplanes $\operatorname{ker} \Phi_{\kappa^{\prime}} \subset T_{E_{\kappa}} \mathcal{M}_{4}$ are linearly independent: using the isomorphism (6) we obtain that for $\kappa^{\prime} \neq \kappa$

$$
h^{0}\left(\Lambda^{2} E_{\kappa} \otimes \kappa^{\prime}\right)=\sharp S(\kappa) \cap S\left(\kappa^{\prime}\right)=2
$$

and using the isomorphism (9) we obtain that

$$
\operatorname{End}_{0}\left(E_{\kappa}\right)=\bigoplus_{\alpha \in J[2] \backslash\{0\}} \alpha .
$$

On the other hand one easily sees that if $\gamma, \delta \in J[2]$ are the two 2 -torsion points in the intersection $S(\kappa) \cap S\left(\kappa^{\prime}\right)$, then $\kappa^{\prime}=\kappa \gamma \delta$, hence $\Lambda^{2} H^{0}\left(\Lambda^{2} E_{\kappa} \otimes \kappa^{\prime}\right) \cong H^{0}(K \gamma \delta)$. This implies that the linear form

$$
\Phi_{\kappa^{\prime}}: \bigoplus_{\alpha \in J[2] \backslash\{0\}} H^{1}(\alpha) \longrightarrow H^{0}(K \gamma \delta)^{*}=H^{1}(\beta)
$$

is projection onto the direct summand $H^{1}(\beta)$, where $\beta=\kappa^{-1} \kappa^{\prime} \in J[2]$. This description of the linear forms $\Phi_{\kappa^{\prime}}$ clearly shows that they are non-zero and linearly independent.

This completes the proof of Theorem 1.2.

## 4. Proof of Corollary 1.3

Since by Theorem $1.2 \mathcal{B}_{4}$ is a reduced 0 -dimensional scheme of length 16 , the degree of the theta map $\theta$ is given by the formula

$$
\operatorname{deg} \theta+16=c_{15}
$$

where $\frac{c_{15}}{15!}$ is the leading coefficient of the Hilbert polynomial

$$
P(n)=\chi\left(\mathcal{M}_{4}, \mathcal{L}^{n}\right)=\frac{c_{15}}{15!} n^{15}+\text { lower degree terms }
$$

In order to compute the polynomial $P$ we write

$$
\begin{equation*}
P(X)=\sum_{k=0}^{15} \alpha_{k} Q_{k}(X), \quad \text { with } \quad Q_{k}(X)=\frac{1}{k!}(X+7)(X+6) \cdots(X+8-k) \tag{10}
\end{equation*}
$$

and $Q_{0}(X)=1$. Note that $\operatorname{deg} Q_{k}=k$ and that $c_{15}=\alpha_{15}$. The canonical bundle of $\mathcal{M}_{4}$ equals $\mathcal{L}^{-8}$. By the Grauert-Riemenschneider vanishing theorem we obtain that $h^{i}\left(\mathcal{M}_{4}, \mathcal{L}^{n}\right)=0$ for any $i \geq 1$ and $n \geq-7$. Hence $P(n)=h^{0}\left(\mathcal{M}_{4}, \mathcal{L}^{n}\right)$ for $n \geq-7$. Moreover $P(n)=0$ for $n=-7,-6, \ldots,-1$ and $P(0)=1$. The values $P(n)$ for $n=1,2, \ldots, 8$ can be computed by the Verlinde formula and with the use of MAPLE. They are given in the following table.

| $n$ | 1 | 2 | 3 | 4 | 5 | 6 | 7 | 8 |
| :---: | :---: | :---: | :---: | :---: | :---: | :---: | :---: | :---: |
| $P(n)$ | 16 | 140 | 896 | 4680 | 21024 | 83628 | 300080 | 984539 |

Using the expression (10) of $P$ one straightforwardly deduces the coefficients $\alpha_{k}$ by increasing induction on $k: \alpha_{k}=0$ for $k=0,1, \ldots, 6$ and the values $\alpha_{k}$ for $k=7, \ldots, 15$ are given in the following table.

| $k$ | 7 | 8 | 9 | 10 | 11 | 12 | 13 | 14 | 15 |
| :---: | :---: | :---: | :---: | :---: | :---: | :---: | :---: | :---: | :---: |
| $\alpha_{k}$ | 1 | 8 | 32 | 96 | 214 | 328 | 324 | 184 | 46 |

Hence $\operatorname{deg} \theta=\alpha_{15}-16=30$.
