Abstract

Let $H(q, p)$ be a Hamiltonian on T^*T^m . Under suitable assumptions on H , we show that the sequence $(H_k)_{k \geq 1}$ defined by $H_k(q, p) = H(kq, p)$ converges in the γ -topology -defined in [V1]- to an integrable continuous Hamiltonian $\bar{H}(p)$. This is extended to the case of non-autonomous Hamiltonians, and the more general setting in which only some of the variables are homogenized: we consider the sequence $H(kx, y, q, p)$ and prove it has a γ -limit $\bar{H}(y, q, p)$, thus yielding an “effective Hamiltonian”. The goal of this paper is to prove convergence of the above sequences, state the first properties of the homogenization operator, and give some applications to solutions of Hamilton-Jacobi equations, construction of quasi-states, etc... We also prove that when H is convex in p , the function \bar{H} coincides with Mather’s α function defined in [Ma] and associated to the Legendre dual of H . This gives a new proof—in the torus case—of its symplectic invariance first discovered by P. Bernard in [Bern 2].

1 Introduction

The aim of this paper is to define the notion of homogenization for a Hamiltonian diffeomorphism of T^*T^n . In other words, given a compactly supported Hamiltonian $H(t, q, p)$ on $S^1 \times T^*T^n$, we shall study whether the sequence H_k defined by $H_k(t, q, p) = H(kt, kq, p)$ converges to some Hamiltonian \overline{H} , necessarily of the form $\overline{H}(q, p) = \overline{h}(p)$.

The convergence of $(H_k)_{k \geq 1}$ to \overline{H} should be understood as the convergence for the symplectic metric γ defined in [V1] (see also Section 4.1), of the flow of H_k, φ_k^t to the flow of $\overline{H}, \overline{\varphi}^t$. This convergence is necessarily rather weak, since for example C^0 -convergence for the flows essentially never holds.

However, such γ -convergence implies the C^0 -convergence for the variational solution (see [O-V] for the definition) of Hamilton-Jacobi equations

$$(HJ_k) \quad \begin{cases} \frac{\partial}{\partial t} u(t, q) + H(k \cdot t, k \cdot q, \frac{\partial}{\partial q} u(t, q)) = 0 \\ u(0, q) = f(q) \end{cases}$$

to the variational solutions of

$$(\overline{HJ}) \quad \begin{cases} \frac{\partial}{\partial t} u(t, q) + \overline{H}(\frac{\partial}{\partial q} u(t, q)) = 0 \\ u(0, q) = f(q). \end{cases}$$

It is important to stress that this notion of convergence **does not** imply any kind of pointwise or almost everywhere convergence¹ for φ_k^t or H_k , but

is rather related to variational notions of convergence, similar to Γ -convergence (see [de G], [Dal M]), that was already used in homogenization theory for studying viscosity solutions of Hamilton-Jacobi equations. Homogenization using this method was for example used in the work of Lions-Papanicolaou and Varadhan (see [L-P-V] and also [Ev], [Fathi1]), or the rescaling of metrics on T^n (see [Ac-Butt] and [Gr]).

Many results in the above-mentioned papers can be considered as special cases of “symplectic homogenization” that is presented here. We believe some of the advantages of this unified treatment are

- (1) The removal of any convexity or even coercivity assumption on H in the p direction (this is required in [L-P-V] and [Ev, Fathi1, Fathi3]), usually needed to define \overline{H} because of the use of minimization techniques for the Lagrangian. In fact our homogenization is defined on compactly supported objects, and then extended to a number of non-compactly supported situations.
- (2) The natural extension of homogenization to cases where H has very little regularity (less than continuity is needed).
- (3) A well defined and common definition of the convergence of H_k to \overline{H} or φ_k to $\overline{\varphi}$ that applies to flows, Hamilton-Jacobi equations, etc.
- (4) The symplectic invariance of the homogenized Hamiltonian extending the invariance results proved in [Bern 1] for Mather’s α function, making his constructions slightly less mysterious.
- (5) The geometric properties of the function \overline{H} (see proposition 5.2, (5)), yielding computational methods extending those obtained in the one-dimensional case in [L-P-V] or in other cases (see for example [Conc]).

This paper will address these fundamental questions, some other applications will be dealt with in subsequent papers (see for example [V5] for an approach to Mather’s theory in the non-convex setting).

3.1 Note

Previous versions of this paper crucially used the case $M = T^n$ of the following

Conjecture 1. *There exists a constant C_n such that any Lagrangian submanifold L of T^*M contained in the unit disc bundle $\{(q, p) \in T^*M \mid \|p\| \leq 1\}$ that is Hamiltonian isotopic to the zero section satisfies $\gamma(L) \leq C_M$.*

The content of section 8 replaces the use of this conjecture in the proof of the main theorem. Added in revision: the conjecture has been recently proved, in particular for $M = T^n$, by Shelukhin in [She] (see also later proofs in [G-V, V7]). Also a number of papers using the present paper or its ideas are [M-V-Z], [M-Z], [Sorr-V], [V5], [Bis], [V6].

4 A crash course on generating function metric

This section is devoted to defining the metric γ , stating some of its main properties and explaining the relationship with Hamilton-Jacobi equations. The reader familiar with the γ -metric may skip this section and start directly from section 5, possibly returning here for reference.

4.1 Generating functions, the calculus of critical values and the γ -metric

Let M be an n -dimensional closed manifold, L be a Lagrangian submanifold in T^*M Hamiltonian isotopic to the zero section 0_M (i.e. such that there is a Hamiltonian isotopy φ_t such that $\varphi_1(0_M) = L$).

Definition 4.1. *The smooth function $S : M \times \mathbb{R}^k \rightarrow \mathbb{R}$ is a generating function quadratic at infinity (GFQI for short) for L if:*

- (1) *there is a non-degenerate quadratic form B on \mathbb{R}^k such that*

$$|\nabla_\xi S(q; \xi) - \nabla B(\xi)| \leq C$$

- (2) *zero is a regular value of the map*

$$(q; \xi) \mapsto \frac{\partial S}{\partial \xi}(q; \xi)$$

- (3) *by (1) and (2), $\Sigma_S = \{(q; \xi) \mid \frac{\partial S}{\partial \xi}(q; \xi) = 0\}$ is a smooth compact submanifold in $M \times \mathbb{R}^k$. The map*

$$i_S : \Sigma_S \rightarrow T^*M$$

$$(q; \xi) \mapsto \left(q, \frac{\partial S}{\partial q}(q; \xi)\right)$$

sends diffeomorphically Σ_S to L .

Remarks 4.2. We point out that :

- (1) Throughout this paper, we shall use a semicolon to separate the “base variables” q from the “fiber variables”, ξ , and we shall abbreviate “generating function quadratic at infinity” by “GFQI”.

- (2) When $k = 0$, i.e. there are no fiber variables, L is just the graph of the differential $dS(q)$.

When L is Hamiltonian isotopic to the zero section, any two GFQI of L are equivalent by the equivalence relation generated by the following three elementary operations associating S_1 to S_2 (see [Thé], theorem 3.2, page 254, [V1], prop 1.5, page 688):

- (1) (Stabilization) $S_2(x, \xi, \eta) = S_1(x, \xi) + q(\eta)$ where q is a non-degenerate quadratic form.
- (2) (Diffeomorphism) $S_2(x, \xi) = S_1(x, \varphi(x, \xi))$ where $(x, \xi) \longrightarrow (x, \varphi(x, \xi))$ is a fiber-preserving diffeomorphism.
- (3) (Translation) $S_2(x, \xi) = S_1(x, \xi) + c$.

Moreover, an elementary computation using the Künneth isomorphism shows that denoting by S^λ the set

$$\{(q; \xi) \in M \times \mathbb{R}^k \mid S(q; \xi) \leq \lambda\}$$

we have for c large enough that

$$H^*(S^c, S^{-c}) \simeq H^*(M) \otimes H^*(D^-, \partial D^-)$$

where D^- is the unit disc of the negative eigenspace of B . In the sequel we denote by S^∞ , (resp. $S^{-\infty}$) the set S^c (resp. S^{-c}) for c large enough. Therefore, to each cohomology class α in $H^*(M)$ we may associate the image of $\alpha \otimes T$ (T is a chosen generator of $H^*(D^-, \partial D^-) \simeq \mathbb{Z}$) in $H^*(S^\infty, S^{-\infty})$, and for $\alpha \neq 0$, by homological minimax, a critical level $c(\alpha, S)$ (see [V1] section 2, page 690-693).

According to [V1], if S_1, S_2 are related by (1) or (2), then $H^*(S_1^\mu, S_1^\lambda) = H^*(S_2^\mu, S_2^\lambda)$, while if they are related by operation (3), we have $H^*(S_1^\mu, S_1^\lambda) = H^*(S_2^{\mu+c}, S_2^{\lambda+c})$. As a result the minimax critical levels are well-defined up to a constant shift (i.e. a shift by a constant independent from the cohomology class).

Definition 4.3. (see [V1], definition 2.1) Let L be Hamiltonian isotopic to the zero section, S a GFQI for L . For any non-zero cohomology class α we define

$$c(\alpha, S) = \inf\{\lambda \mid \text{the image of } T \otimes \alpha \text{ in } H^*(S^\lambda, S^{-\infty}) \text{ is non-zero}\}.$$

We denote by 1 the generator of $H^0(M)$, μ the generator of $H^n(M)$ and set

$$\begin{aligned} c_-(S) &= c(1, S) \\ c_+(S) &= c(\mu, S) \\ \gamma(L) &= c(\mu, S) - c(1, S) \end{aligned}$$

Remarks 4.4. We notice that

- (1) According to [V1, Thé] the numbers $c(\alpha, S)$ indeed only depends on L and not on S up to a global shift : replacing S by $S + c$ generates the same Lagrangian and this shifts all the $c(\alpha, S)$ by c .

- (2) Note that translating S by a constant shifts $c(\alpha, S)$ by the same constant, so that, provided we normalized S in some way, $c(\alpha, L)$ is now well defined as the common value of $c(\alpha, S)$ for S a GFQI for L . For example, if we specify the Hamiltonian H yielding the isotopy between the zero section and L , we may normalize S by requiring that its critical values coincide with the critical values of the action A_H defined on $\mathcal{P} = \{c : [0, 1] \mapsto T^*M \mid c(t) = (q(t), p(t)), p(1) = 0\}$ by

$$A_H(c) = \int_0^1 [p(t)\dot{q}(t) - H(t, q(t), p(t))] dt$$

Thus $c_{\pm}(H) = c_{\pm}(S)$ is well defined. When φ^1 is generated by some compactly supported Hamiltonian, we may normalize the GFQI so that the fixed point at infinity, which is a critical point of S , has critical value zero. We may thus define $c(\alpha, \varphi(0_M))$ for $\varphi \in Ham_c(T^*M)$.

- (3) Note that when S has no fiber variable, we have

$$c_+(S) = \sup_{x \in M} S(x), c_-(S) = \inf_{x \in M} S(x)$$

- (4) There is a similar definition for a homology class instead of cohomology class (see [V1], p. 692). For $u \in H_*(M)$ we have

$$c(u, S) = \inf\{\lambda \mid \text{the image of } T \otimes u \text{ is in the image of } H_*(S^\lambda, S^{-\infty})\}.$$

- (5) We shall sometimes deal with the case $M = \mathbb{R}^n$. Then we need quadraticity at infinity of S for both the ξ and x variable, so that (1) in Definition 4.1 should be replaced by

- (1') there exists a nondegenerate quadratic form $B(q, \xi)$ on $M \times \mathbb{R}^k (= \mathbb{R}^n \times \mathbb{R}^k)$ such that

$$|\nabla S(q; \xi) - \nabla B(q; \xi)| \leq C$$

The map γ is well defined on the set $\mathcal{L}(T^*\mathbb{R}^n)$ of Lagrangian submanifolds Hamiltonian isotopic to the zero section, where the Hamiltonian is assumed to be compactly supported by compactifying L and \mathbb{R}^n to S^n so that we set $\gamma(L) \stackrel{def}{=} \gamma(L \cup \{(\infty, 0)\})$ where

$$L \cup \{(\infty, 0)\} \subset T^*S^n = T^*\mathbb{R}^n \cup (\{\infty\} \times (\mathbb{R}^n)^*)$$

It follows from [V1], that γ defines a metric on $\mathcal{L}(T^*M)$ by setting

Definition 4.5. *Let S_1 and S_2 be GFQI for L_1 and L_2 in $\mathcal{L}(T^*M)$. Then $\gamma(L_1, L_2) = c(\mu, S_1 \ominus S_2) - c(1, S_1 \ominus S_2)$ where $(S_1 \ominus S_2)(q; \xi_1, \xi_2) = S(q; \xi_1) - S(q; \xi_2)$. The function γ defines a metric on $\mathcal{L}(T^*M)$. We denote by $\widehat{\mathcal{L}}(T^*M)$ the completion³ of $\mathcal{L}(T^*M)$ for γ .*

³Usually called the Humilière completion, see [Hu].

That γ is a metric on $\mathcal{L}(T^*M)$ is a consequence of Lusternik-Shnirelman's theory (see [V1]). Note that $\gamma(L) = \gamma(L, 0_M)$ so our use of γ is a slight abuse of notation.

Our goal is to define a metric on $\mathfrak{Ham}_c(T^*M) = C_c^\infty([0, 1] \times T^*M, \mathbb{R})$ the set of compactly supported, time dependent Hamiltonians of T^*M , and on $Ham_c(T^*M)$ the group of time-one maps of Hamiltonians in $\mathfrak{Ham}_c(T^*M)$. For $M = T^n$, the graph of $\varphi \in Ham_c(T^*T^n)$,

$$\Gamma(\varphi) = \{(z, \varphi(z)) \mid z \in T^*T^n\}$$

is a Lagrangian submanifold of $T^*T^n \times \overline{T^*T^n}$ (where $\overline{T^*M}$ is T^*M with the symplectic form of opposite sign : $-dp \wedge dq$).

But $T^*T^n \times \overline{T^*T^n}$ is covered by $T^*(\Delta_{T^*T^n})$, where $\Delta_{T^*T^n}$ is the diagonal, through the symplectic covering map

$$\begin{aligned} j : T^*(T^n \times \mathbb{R}^n) &\longrightarrow T^*T^n \times \overline{T^*T^n} \\ (u, v, U, V) &\longrightarrow (u - V, v, u, v - U) \end{aligned}$$

Here $(q, p) \in T^*T^n$, $(Q, P) \in \overline{T^*T^n}$ and the symplectic form is

$$dp \wedge dq - dP \wedge dQ$$

while $(u, v) \in T^n \times \mathbb{R}^n$, $(u, v, U, V) \in T^*(T^n \times \mathbb{R}^n)$ with symplectic form $dU \wedge du + dV \wedge dv$.

The inverse of j ,

$$(q, p, Q, P) \longrightarrow (q, P, p - P, Q - q) = (u, v, U, V)$$

is not well-defined : since Q, q are only defined modulo \mathbb{Z}^n , so is V . It is thus multivalued, but we may lift $\Gamma(\varphi)$ to $\tilde{\Gamma}(\varphi) \subset j^{-1}(\Gamma(\varphi))$, which is now a Lagrangian submanifold in $T^*(\Delta_{T^*T^n})$.

In other words it φ^t is a Hamiltonian isotopy of T^*T^n and $\tilde{\varphi}^t$ the lift to $T^*\mathbb{R}^n$ such that $\tilde{\varphi}^0 = \text{Id}$, we have, setting $[q]$ to be the class of $q \in \mathbb{R}^n$ in T^n ,

$$\tilde{\Gamma}(\varphi) = \{([q], P, p - P, Q - q) \in T^*(T^n \times \mathbb{R}^n) \mid \tilde{\varphi}(q, p) = (Q, P)\}$$

When φ has compact support, we may compactify both $\tilde{\Gamma}(\varphi)$ and $\Delta_{T^*T^n}$ and we get a Lagrangian submanifold $\bar{\Gamma}(\varphi)$ in $T^*(T^n \times S^n)$. We may then set

Definition 4.6 ([V1], page 697). *For $M = T^n$, the maps c_-, c_+ and γ are defined by*

$$c_-(\varphi) = c(1 \otimes 1, \bar{\Gamma}(\varphi))$$

$$c_+(\varphi) = c(\mu_{T^n} \otimes \mu_{S^n}, \bar{\Gamma}(\varphi))$$

and

$$\gamma(\varphi) = \gamma(\bar{\Gamma}(\varphi)) = c(\mu_{T^n} \otimes \mu_{S^n}, \bar{\Gamma}(\varphi)) - c(1 \otimes 1, \bar{\Gamma}(\varphi))$$

We also set

$$c_\pm(\varphi, \psi) = c_\pm(\varphi\psi^{-1})$$

and

$$\gamma(\varphi, \psi) = \gamma(\varphi\psi^{-1})$$

Proposition 4.7. (see [V1])

The map γ defines a bi-invariant metric on $\text{Ham}_c(T^*T^n)$ since

- (1) it is non-degenerate $\gamma(\varphi) = 0 \iff \varphi = \text{id}$
- (2) it is invariant by conjugation $\gamma(\psi\varphi\psi^{-1}) = \gamma(\varphi)$ for all ψ in $\text{Ham}_c(T^*T^n)$.
- (3) it satisfies the triangle inequality

$$\gamma(\varphi\psi) \leq \gamma(\varphi) + \gamma(\psi)$$

for any φ, ψ in $\text{Ham}_c(T^*T^n)$.

Proof. Then according to [V3], proposition 2.11, γ is a distance on the set of Lagrangian Hamiltonian isotopic to the zero section. We apply this to $\bar{\Gamma}(\varphi) \subset T^*(T^n \times S^n)$. Property (1) follows from the non-degeneracy of the metric on $\mathcal{L}(T^*(T^n \times S^n))$. For property (2) the proof is identical to the proof of corollary 4.3 in [V1] for the case $M = \mathbb{R}^n$. The last property follows easily from the triangle inequality from corollary 3.6 page 696 of [V1]. \square

Remarks 4.8.

The metric γ can be extended on one hand to $\text{Ham}_c(T^*M)$ by setting $\hat{\gamma}(\varphi) = \sup\{\gamma(\varphi(L), L) \mid L \in \mathcal{L}(T^*M)\}$ and on the other hand to general symplectic manifolds (see [Oh, Schw]) using Floer cohomology instead of generating function homology.

A vector field Z is called a Liouville vector field, if Z is conformal (i.e. the flow ψ_t of Z satisfies $\psi_t^*\omega = e^t\omega$). We then have, according to [V1] (corollary 4.3 page 698)

$$(4.1) \quad \gamma(\psi_t\varphi\psi_t^{-1}) = e^t\gamma(\varphi)$$

On the set $\mathfrak{Ham}_c(T^*T^n)$ the metric γ is defined as follows⁴

Definition 4.9. Let $H(t, z)$ be a Hamiltonian in $\mathfrak{Ham}_c(T^*M)$ with flow φ_H^t . We denote by

$$\gamma(H, K) = \sup \{ \gamma(\varphi_H^t \circ (\varphi_K^t)^{-1}) \mid t \in [0, 1] \}$$

Finally we state two convergence criteria for the γ -metric.

Proposition 4.10. Let $M = \mathbb{R}^n$ or T^n . Let φ_H, φ_K be the time-one maps of the flows associated to H, K in $\mathfrak{Ham}_c(T^*M)$. We have

$$\gamma(H, K) \leq \|H - K\|_{C^0([0,1] \times T^*M, \mathbb{R})}$$

As a result, if the sequence $(H_k)_{k \geq 1}$ of Hamiltonians on T^*M with fixed support, C^0 -converges to H , then $(H_k)_{k \geq 1}$ converges, in the metric γ , to H .

Similarly we have a constant C such that

$$\gamma(\varphi, \psi) \leq C \cdot d_{C^0}(\varphi, \psi)$$

⁴Remember that elements of $\mathfrak{Ham}_c(T^*M)$ are time-dependent Hamiltonians.

Proof. The first statement follows immediately from [V1] (Proposition 4.6, page 699 and Proposition 4.14 page 707). It is stated explicitly for example as proposition 2.15 in [V3] or in [Hu] p. 378 proposition 2.4, d). The second one follows for Hamiltonian maps supported in the unit disc bundle from Theorem 5 in [Sey]. The general case follows from the homogeneity (by the dilation $t \cdot (q, p) \mapsto (q, t \cdot p)$) of both sides. \square

We may therefore define the completion $\widehat{\mathfrak{H}am}_c(T^*M)$ of $\mathfrak{H}am_c(T^*M)$ for γ , as Humilière did (see [Hu], section 4, page 388). For example $\widehat{Ham}_c(T^*M)$ is the set of equivalence classes of Cauchy limits for γ of sequences of elements of $Ham_c(T^*M)$, two sequences being equivalent if their γ -distance converges to 0. For $\widehat{Ham}_c(T^*M)$ we assume the sequence is supported in a fixed compact set. Note that the support of an element of $\widehat{Ham}(T^*M)$ can be defined directly (see [Hu]), so this is the same as the subset of elements of $\widehat{Ham}(T^*M)$ having compact support. From the above proposition we deduce that a sequence of Hamiltonians C^0 -converging uniformly on compact sets will be a Cauchy sequence for γ , hence defines an element in $\widehat{\mathfrak{H}am}_c(T^*M)$. We thus get

Proposition 4.11 (see [Hu], proposition 1.3). *There is a continuous inclusion map*

$$C_c^0([0, 1] \times T^*M, \mathbb{R}) \rightarrow \widehat{\mathfrak{H}am}_c(T^*M)$$

*Similarly if $\overline{Ham}_c(T^*M)$ is the C^0 -closure of $Ham_c(T^*M)$ we have a continuous inclusion*

$$\overline{Ham}_c(T^*M) \rightarrow \widehat{Ham}_c(T^*M)$$

Finally, we claim that the spectral numbers $c(\alpha, L)$ are well defined on the γ -completions of the above metric spaces, for example in $\widehat{Ham}_c(T^*M)$.

Proposition 4.12. *For $\alpha \in H^*(T^n \times S^n) \setminus \{0\}$ the map $\varphi \mapsto c(\alpha, \varphi)$ uniquely extends as a continuous map (for the metric γ) defined on $\widehat{Ham}_c(T^*T^n)$.*

Proof. Since $|c(\alpha, \varphi_1) - c(\alpha, \varphi_2)| \leq \gamma(\varphi_1, \varphi_2)$ according to Appendix B, Proposition B.3, this is just an application of the general statement that a Lipschitz map defined on a metric space has a unique extension to its completion. \square

4.2 Variational solutions of Hamilton-Jacobi equations

Let $S(x, y; \xi)$ be a GFQI, where $(x, y) \in X \times Y$. Define $S_y(x, \xi) = S(x, y; \xi)$ and for $\alpha \in H^*(X)$ set $c(\alpha \otimes 1(y), S) = c(\alpha, S_y)$. The notation indicates that $H^*(X \times \{y\}) = H^*(X) \times H^*(\{y\})$ and $H^*(\{y\})$ is one-dimensional generated by an element denoted $1(y)$.

Let φ^t be the Hamiltonian flow of $H(q, p)$, and $\tilde{\Gamma}(\varphi^t)$ the lift of its graph in $T^*(T^n \times \mathbb{R}^n)$ as in Definition 4.5. Let $S_t(q, P, \xi)$ be a GFQI for $\tilde{\Gamma}(\varphi^t)$. We thus define $c(1(q, P), S_t) = c(1, S_{t,q,P})$. Then $u_t(q, P) = c(1(q, P), S_t)$ is, by definition, the variational solution of

$$\begin{cases} \frac{\partial}{\partial t} u_t(q, P) + H(q, P) + \frac{\partial}{\partial q} u_t(q) = 0 \\ u_0(q, P) = 0 \end{cases}$$

We refer to [O-V], [V2] and [C-V] for more information on variational solutions, in particular the fact that it does not depend on the choice of S and Appendix 2 (theorem 13.1) of [V5] for the proof that variational solutions satisfy the equation outside a closed set of zero measure.

5 Statement of the main results

We shall first give our results in the case of homogenization with respect to all variables, then present the case of partial homogenization, and finally the applications to variational solutions of Hamilton-Jacobi equations.

5.1 Standard homogenization

Theorem 5.1 (Main theorem).

Let $H(t, q, p)$ be a compactly supported, smooth Hamiltonian, 1-periodic in t on T^*T^n . Then the following holds:

- (1) There exists a Hamiltonian $\bar{H} \in C_c^0(\mathbb{R}^n, \mathbb{R})$ such that the sequence

$$H_k(t, q, p) = H(kt, kq, p)$$

γ -converges to $\bar{H}(t, q, p) = \bar{H}(p)$.

- (2) The function \bar{H} only depends on φ^1 , the time-one map associated to H (i.e. it does not depend on the isotopy $(\varphi^t)_{t \in [0,1]}$).
- (3) The map

$$\mathcal{A} : C_c^\infty(\mathbb{R}/\mathbb{Z} \times T^*T^n, \mathbb{R}) \rightarrow C_c^0(\mathbb{R}^n, \mathbb{R})$$

defined by $\mathcal{A}(H) = \bar{H}$ extends to a nonlinear projector (i.e. a surjective map satisfying $\mathcal{A}^2 = \mathcal{A}$) with Lipschitz constant 1

$$\mathcal{A} : \widehat{\mathfrak{Ham}}_c(T^*T^n) \rightarrow C_c^0(\mathbb{R}^n, \mathbb{R})$$

where the metric on $\widehat{\mathfrak{Ham}}_c(T^*T^n)$ is given by γ , and the canonical metric on $C^0(\mathbb{R}^n, \mathbb{R})$ is the C^0 -metric.

Moreover \mathcal{A} sends Lipschitz Hamiltonians to Lipschitz maps.

The next theorem states some properties of the homogenization map \mathcal{A} .

Theorem 5.2 (Main properties of symplectic homogenization).

The map \mathcal{A} defined in the above theorem satisfies the following properties:

- (1) It is monotone, i.e. if $H_1 \leq H_2$, then $\mathcal{A}(H_1) \leq \mathcal{A}(H_2)$.
- (2) It is invariant under the action of a Hamiltonian symplectomorphism: $\mathcal{A}(H \circ \psi) = \mathcal{A}(H)$ for all $\psi \in \text{Ham}(T^*T^n)$.
- (3) Setting $H_c(t, q, p) = c \cdot H(c \cdot t, q, p)$, we have $\mathcal{A}(H_c) = c\mathcal{A}(H)$ for any $c \in \mathbb{R}$. In particular if H is autonomous, $\mathcal{A}(cH) = c\mathcal{A}(H)$.

- (4) The map \mathcal{A} extends to a map (still denoted by \mathcal{A}) between $\mathcal{P}(T^*T^n)$, the set of subsets of T^*T^n , to $\mathcal{P}(\mathbb{R}^n)$, the set of subsets of \mathbb{R}^n . This map is bounded from below by the symplectic shape of Sikorav (see [Be, Sik2, El]), i.e.

$$\text{shape}(U) = \{p_0 \in \mathbb{R}^n \mid \exists \psi \in \text{Ham}_c(T^*T^n), \psi(T^n \times \{p_0\}) \subset U\} \subset \mathcal{A}(U).$$

- (5) If L is a Lagrangian Hamiltonian isotopic to $L_{p_0} = \{(q, p_0) \in T^*T^n\}$ and $\sup_{(q,p) \in L} H(q, p) \geq h$ (resp. $\inf_{(q,p) \in L} H(q, p) \leq h$) we have $\mathcal{A}(H)(p_0) \geq h$ (resp. $\leq h$).

- (6) We have

$$\lim_{k \rightarrow \infty} \frac{1}{k} c_+(\varphi^k) = \sup_{p \in \mathbb{R}^n} \overline{H}(p)$$

$$\lim_{k \rightarrow \infty} \frac{1}{k} c_-(\varphi^k) = \inf_{p \in \mathbb{R}^n} \overline{H}(p).$$

- (7) For any sequence of non-negative compactly supported functions, $(H_n)_{n \geq 1}$, converging uniformly to 1 on compact sets, we have $\lim_n \zeta(H_n) = 1$.

- (8) Given any Radon measure μ on \mathbb{R}^n the map

$$\zeta(H) = \int_{\mathbb{R}^n} \mathcal{A}(H)(p) d\mu(p)$$

satisfies all the properties of a **symplectic quasi-state**⁵ except for normalization (i.e. $\zeta(1) = 1$) which is however satisfied in a weak sense according to (7). In particular we have $\mathcal{A}(H+K) = \mathcal{A}(H) + \mathcal{A}(K)$ whenever H and K Poisson-commute (i.e. $\{H, K\} = 0$).

Remarks 5.3. Here are some comments:

- (1) The function \overline{H} will be defined in the autonomous case as

$$\overline{H}(p) = \lim_k c(\mu \otimes 1(p), H_k)$$

Of course there is a lot to prove, starting from the existence of this limit.

- (2) In (1) the assumption could be replaced by the property that $H_1 \preceq H_2$ in the sense of [V1] (i.e. $c_-(\varphi_{H_1}^{-1} \circ \varphi_{H_2}^1) = 0$, see [V1], definition 4.9, page 701).

- (3) Note that it is not true that characteristic functions are in $\widehat{\mathfrak{Ham}}_c(T^*T^n)$, for example an integrable Hamiltonian is in the completion if and only if it is continuous, so for example for $U = S^1 \times [-1, 1]$, H_U is not in $\widehat{\mathfrak{Ham}}_c(T^*T^n)$. However \mathcal{A} can be extended to any H that is a limit of a decreasing sequence of continuous functions -i.e. any upper semi-continuous function- by setting $H = \lim_k H_k$, by setting $\overline{H} = \lim_k \overline{H}_k$. It is easy to show that this does not depend on the choice of the sequence (H_k) . So \mathcal{A} extends to the class of upper semi-continuous functions. However it is not clear what properties do still hold in such situation, since for example $-H$ is not upper semi-continuous.

⁵see [E-P] for the definition and properties of quasi-states in the symplectic framework, inspired by [Aar].

- (4) Property (3) is essentially trivial for $c > 0$. The non-trivial fact is that $\mathcal{A}(-H) = -\mathcal{A}(H)$ (see Remark 5.8).
- (5) As a result of (5) if u is a smooth subsolution of the stationary Hamilton-Jacobi equation, that is $H(x, p + du(x)) \leq h$, then $\overline{H}(p) \leq h$. Similarly if u is a smooth supersolution, that is $H(q, p + du(q)) \geq h$, then $\overline{H}(p) \geq h$.
- (6) From (5), we get the following statement: let

$$E_c^+ = \{p_0 \in \mathbb{R}^n \mid \exists L \text{ Hamiltonian isotopic to } L_{p_0}, \inf_{(q,p) \in L} H(q,p) \geq c\}$$

$$E_c^- = \{p_0 \in \mathbb{R}^n \mid \exists L \text{ Hamiltonian isotopic to } L_{p_0}, \sup_{(q,p) \in L} H(q,p) \leq c\}$$

As a result, if $p \in \overline{E}_c^+ \cap \overline{E}_c^-$, we have $\overline{H}(p) = c$.

More generally we have the following

Corollary 5.4. *Let H be an autonomous Hamiltonian. Then if $c = \overline{H}(p_0)$, then $H^{-1}(c)$ intersects all images of L_{p_0} by a Hamiltonian map.*

Proof. Indeed, if this was not the case we could find a Hamiltonian image of L_{p_0} which is contained in either $H < c$ or $H > c$. In the first case, this implies $\overline{H}(p_0) > c$ in the second $\overline{H}(p_0) < c$, contradicting our assumption. \square

5.2 Partial homogenization

We now consider the case of a Hamiltonian H defined on $T^*T^n \times M$, where M is some symplectic manifold. We shall only deal with the case where $M = T^*T^m$, but the general case can be easily adapted. We want to understand the limit of $H_k(t, x, y, z) = H(kt, kx, y, z)$ for $(x, y) \in T^*T^n, z \in M$. Indeed, we shall show that it is sufficient to define the homogenization for φ^t for small t . But denoting by φ_k^t the flow of H_k , the graph of φ_k^t for t small lives in a neighborhood of $T^*(T^n \times \mathbb{R}^n) \times \Delta_M$, hence in $T^*(T^n \times \mathbb{R}^n) \times T^*\Delta_M$. Since the graph lives in a cotangent bundle, we shall see that it can again be described, using the theory of generating functions⁶. We then have the following extension of Theorem 5.1, which corresponds to the case $m = 0$:

Theorem 5.5 (Main theorem, partial homogenization case). *Let $H(t, x, y, q, p)$ be a compact supported Hamiltonian on T^*T^{n+m} . Then*

- (1) *The sequence $(H_k)_{k \geq 1}$ defined by*

$$H_k(t, x, y, q, p) = H(kt, kx, y, q, p)$$

γ -converges to a continuous function \overline{H} of the form $\overline{H}(y, q, p)$.

- (2) *The map*

$$\mathcal{A}_x : C_c^\infty([0, 1] \times T^*T^{n+m}, \mathbb{R}) \rightarrow C_c^0(\mathbb{R}^n \times T^*T^m, \mathbb{R})$$

⁶Indeed, the main advantage of T^n over general closed manifolds, is that $T^*T^n \times \overline{T^*T^n}$ is covered by $T^*\Delta$, while for general M this only holds in a tubular neighborhood of the diagonal.

given by $\mathcal{A}_x(H) = \overline{H}$ extends to a projector (i.e. it is surjective and satisfies $\mathcal{A}_x^2 = \mathcal{A}_x$) with Lipschitz constant 1

$$\mathcal{A}_x : \widehat{\mathfrak{Ham}}_c(T^*T^{m+n}) \rightarrow C_c^0(\mathbb{R}^n \times T^*T^m)$$

where the metric on $\widehat{\mathfrak{Ham}}_c(T^*T^{m+n})$ is γ .

- (3) If $H_{(q,p)}(x, y) = H(x, y, q, p)$, we have

$$\mathcal{A}_x(H)(y, q, p) = \mathcal{A}(H_{(q,p)})(y)$$

Thus partial homogenization is obtained by freezing the non-homogenized variables.

Remarks 5.6. (1) In (2) we identify $C_c^0(\mathbb{R}^n \times T^*T^m, \mathbb{R})$ to an element in $\widehat{\mathfrak{Ham}}_c(T^*T^{m+n})$ as we did in the previous section.

- (2) The Hamiltonian $\overline{H}(y, q, p)$ is called the effective Hamiltonian. In case it is smooth, its flow is given by $\overline{\Phi}(x_0, y_0, q_0, p_0) = (x(t), y(t), q(t), p(t))$

$$\begin{aligned} y(t) &= y_0, \quad x(t) = x_0 + \int_0^t \frac{\partial \overline{H}}{\partial y}(y_0, q(t), p(t)) dt, \\ \dot{q}(t) &= \frac{\partial \overline{H}}{\partial p}(y_0, q(t), p(t)), \quad \dot{p}(t) = -\frac{\partial \overline{H}}{\partial q}(y_0, q(t), p(t)) \end{aligned}$$

- (3) It is not true anymore that \overline{H} depends only on the time-one map of H .
- (4) More generally, using Theorem 5.5 (3), we may prove properties of \mathcal{A}_x analogous to the properties of \mathcal{A} stated in Theorem 5.1. The projector \mathcal{A}_x is not invariant by symplectic maps. It is however invariant by fiber-preserving Hamiltonian symplectic maps: if

$$\psi(x, y, q, p) = (\psi_{(q,p)}(x, y), \psi_2(q, p))$$

we have

$$\mathcal{A}_x(H \circ \psi)(y, q, p) = \mathcal{A}_x(H)(y, \psi_2(q, p))$$

5.3 Homogenized Hamilton-Jacobi equations

Our theorem has some interesting applications to generalized solutions of evolution Hamilton-Jacobi equations. Consider the equation:

$$(HJ) \quad \begin{cases} \frac{\partial}{\partial t} u(t, q) + H(t, q, \frac{\partial}{\partial q} u(t, q)) = 0 \\ u(0, q) = f(q) \end{cases}$$

where $t \in \mathbb{R}$, $q \in T^n$ and $H \in C^\infty(\mathbb{R}/\mathbb{Z} \times T^*T^n)$.

Smooth solutions to such equations are only defined for t less than some T_0 . In general, solutions exhibit shocks: $\|D^2 u(q)\|_{C^0([0, T] \times T^n, \mathbb{R}, \mathbb{R})}$ blows-up as t goes to T_0 .

There are essentially two types of generalized solutions for such equations : viscosity solutions (cf. [C-L], [Ba][Ba-CD]) and variational solutions (cf. [Sik],

[Ch1], [O-V], [V2]). These two solutions do not coincide in general, with one notable exception: when the Hamiltonian is convex in p (cf. [Zh 2], [Roos, WQ1]).

From [L-P-V] it follows that if H is coercive in p , and u_k is the viscosity solution of

$$(HJ_k) \begin{cases} \frac{\partial}{\partial t} u_k(t, q) + H(kt, kq, \frac{\partial}{\partial q} u_k(t, q)) = 0 \\ u_k(0, q) = f(q). \end{cases}$$

the sequence $(u_k)_{k \geq 1}$ converges to \bar{u} , the viscosity solution of

$$(\overline{HJ}) \begin{cases} \frac{\partial}{\partial t} \bar{u}(t, q) + \overline{H}(\frac{\partial}{\partial q} \bar{u}(t, q)) = 0 \\ \bar{u}(0, q) = f(q). \end{cases}$$

Our theorem, together with results by Humilière (cf. [Hu] section 6, in particular Proposition 6.1) implies that this extends to the non-coercive case, provided u_k is the variational solution and \overline{H} is given by our main theorem. We now state the more general proposition, yielding the analog of [L-P-V] :

Proposition 5.7. *Let $H \in C^0([0, 1] \times T^*T^{n+m}, \mathbb{R})$ be either coercive (i.e. $\lim_{|(y,p)| \rightarrow \infty} H(t, x, y, q, p) = +\infty$) or compactly supported, $f \in C^0(T^{n+m}, \mathbb{R})$ and u_k the variational solution of (HJP_k) :*

$$(HJP_k) \begin{cases} \frac{\partial}{\partial t} u_k(t, x, q) + H(kt, kx, q, \frac{\partial}{\partial x} u_k(t, x, q), \frac{\partial}{\partial q} u_k(t, x, q)) = 0 \\ u_k(0, x, q) = f(x, q). \end{cases}$$

where $(x, q) \in T^n \times T^m$. Then $\lim_{k \rightarrow +\infty} u_k(t, x, q) = \bar{u}(t, x, q)$ where convergence is uniform on compact time intervals and \bar{u} is the variational solution of (\overline{HJP}) .

$$(\overline{HJP}) \begin{cases} \frac{\partial}{\partial t} \bar{u}(t, x, q) + \overline{H}(q, \frac{\partial}{\partial x} \bar{u}(t, x, q), \frac{\partial}{\partial q} \bar{u}(t, x, q)) = 0 \\ \bar{u}(0, x, q) = f(x, q). \end{cases}$$

More precisely, for (x, q) in a bounded set, there is a sequence ε_k going to zero, such that for all $t \geq 1$

$$|u_k(t, x, q) - \bar{u}(t, x, q)| \leq \varepsilon_k t$$

The next three sections will be devoted to the proof of our main theorem, first in the “standard case”, then in the “partial homogenization” setting.

Remark 5.8. Note that according to (3) in Theorem 5.2 we have $\mathcal{A}(-H) = -\mathcal{A}(H)$. This is a statement that typically does not hold in the case of viscosity solutions, since if $u(t, x)$ is a viscosity solution associated to H , $u(-t, x)$ is not in general a viscosity solution associated to $-H$.

6 Proof of the main theorem

Let us introduce the reader to the main steps of the proof. We denote by φ_k^t the flow of $H_k(t, q, p) = H(kt, kq, p)$ for $H \in \mathfrak{Ham}_c(T^*T^n)$. In the first part of subsection 6.1, we shall construct a GFQI of the graph of the φ_k^t , starting from a GFQI of the graph of the flow $\varphi^t = \varphi_1^t$.

Our proof will then be split in two parts:

- Finding a candidate $\overline{\varphi}^t$ for the γ -limit of φ_k^t , or equivalently a candidate \overline{H} for the γ -limit of H_k
- Showing that the γ -limit of φ_k^t is indeed $\overline{\varphi}^t$.

Remember from Section 4.2 that if $S(q, p, \xi)$ is a GFQI for $\Gamma(\varphi)$, $c(\alpha \otimes 1(p), \varphi)$ is defined as $c(\alpha, S_p)$ where $S_p(q, \xi) = S(q, p, \xi)$.

The first step goes along the following lines: if H does not depend on (t, q) , then $c(\mu_q \otimes 1(p), \varphi^1) = H(p)$, so⁷ if H_k is a sequence of autonomous Hamiltonians γ -converging to \overline{H} , we must have that

$$\lim_{k \rightarrow \infty} c(\mu_q \otimes 1(p), \varphi_k^1) = \overline{H}(p)$$

We shall thus try to define \overline{H} using this formula, and we shall first prove that this limit exists. This is the object of the second part of subsection 6.1 and is proved in proposition 6.10. We thus get a candidate $\overline{\varphi}^1$ for the γ -limit of φ_k^1 .

The second step is more delicate, and is dealt with in subsection 6.2. The formula obtained for the GFQI of φ_k^t yields the following inequality valid for any Hamiltonian map α

$$\liminf_{k \rightarrow \infty} c(\mu \otimes 1, \varphi_k \alpha) \leq c(\mu \otimes 1, \overline{\varphi} \alpha)$$

and proved in proposition 6.15.

We must then prove the reverse inequality. This requires us to use the previous inequality with φ^{-1} instead of φ , the difficulty being that we do not know *a priori* that $\overline{\varphi^{-1}} = \overline{\varphi}^{-1}$. The proof of this equality is the object of section 8.

Finally note that we do not know⁸, in general, whether the convergence of a sequence of compactly supported Hamiltonians $(H_k)_{k \geq 1}$ follows from the convergence of the sequence of flows $(\varphi_k^t)_{k \geq 1}$. Indeed, it could happen that in the completion $\widehat{Ham}_c(T^*T^n)$, the same family of maps $\overline{\varphi}^t$, is obtained from two different Hamiltonians i.e. is the image of two different elements of $\widehat{\mathfrak{Ham}}_c(T^*T^n)$ by the extension to the completions of the exponential map $H \rightarrow \varphi_H^t$. However, two distinct compactly supported continuous integrable Hamiltonians $H_1(p), H_2(p)$ cannot have the same flow, as is proved in corollary A.2 in Appendix A (this also follows from a much more general theorem of Humilière, Leclercq and Seyfaddini, see [H-L-S]).

6.1 Reformulating the problem and finding the homogenized Hamiltonian

First of all, we shall assume we are dealing with a compactly supported autonomous Hamiltonian $H \in \mathfrak{Ham}_c(T^*T^n)$. We shall see in subsection 13.2 that the general case reduces to this one.

Similarly let φ_k^t be the flow associated to $H_k(q, p) = H(kq, p)$ set $\varphi_k = \varphi_k^1$ and $\varphi = \varphi_1^1$.

⁷Remember that according to Proposition 4.12, spectral numbers are well defined on $\widehat{Ham}_c(T^*T^n)$.

⁸In the case of continuous Hamiltonians and flows, i.e. the case of the group *Hameo*, this is proved in [V4] (see also [B-S]). I owe this remark to Vincent Humilière and Nicolas Vichery.

We first compute φ_k^t as a function of φ^t . The map $\rho_k(q, p) = (kq, p)$ defined on T^*T^n is not invertible. Nevertheless its lift $\tilde{\rho}_k : T^*\mathbb{R}^n \rightarrow T^*\mathbb{R}^n$ is invertible. If we denote by $\tilde{\varphi}$ any lift of φ , then $\tilde{\rho}_k^{-1}\tilde{\varphi}\tilde{\rho}_k$ is \mathbb{Z}^n -equivariant, that is

$$\tilde{\rho}_k^{-1}\tilde{\varphi}\tilde{\rho}_k(q + \nu, p) = \tilde{\rho}_k^{-1}\tilde{\varphi}\tilde{\rho}_k(q, p) + (\nu, 0)$$

for $\nu \in \mathbb{Z}^n$. It therefore descends to a diffeomorphism of T^*T^n . However this diffeomorphism depends on the choice of the lift $\tilde{\varphi}$. Since φ is the time-one of a Hamiltonian isotopy, we may choose for $\tilde{\varphi}$ the lift starting from the identity. With this choice we shall write by abuse of notation $\rho_k^{-1}\varphi\rho_k$ for the symplectomorphism of T^*T^n induced by $\tilde{\rho}_k^{-1}\tilde{\varphi}\tilde{\rho}_k$.

Lemma 6.1. *Let $\rho_k : T^*T^n \rightarrow T^*T^n$ be defined by $\rho_k(q, p) = (kq, p)$, then with the above convention, we have $\varphi_k^t = \rho_k^{-1}\varphi^{kt}\rho_k$.*

Proof. The map ρ_k is conformally symplectic, hence

$$\begin{aligned} dH_k(z)\xi &= dH(\rho_k(z))d\rho_k(z)\xi = \omega(X_H(\rho_k(z)), d\rho_k(z)\xi) \\ &= (\rho_k^*\omega)(d\rho_k(z)^{-1}X_H(\rho_k(z)), \xi) \end{aligned}$$

Since $\rho_k^*\omega = k\omega$, we get

$$\begin{aligned} X_{H_k}(z) &= k((\rho_k)_*X_H)(z) \\ &= (\rho_k)^*(kX_H)(z) \end{aligned}$$

The flow of kX_H is φ^{kt} , hence the flow of $(\rho_k)^*(kX_H)$ is $\rho_k^{-1}\varphi^{kt}\rho_k$. \square

From now on we shall write $\varphi_k = \rho_k^{-1}\varphi^k\rho_k$. We are thus looking for the γ -limit of $\rho_k^{-1}\varphi^k\rho_k$.

Note that we may replace $\varphi = \varphi^1$ by $\varphi^{1/r}$ for some fixed integer r . Indeed, if $\rho_k^{-1}\varphi^{k/r}\rho_k$ γ -converges to ψ , we have that

$$\rho_k^{-1}\varphi^k\rho_k = \rho_r \left(\rho_{kr}^{-1}\varphi^{kr/r}\rho_{kr} \right) \rho_r^{-1}$$

γ -converges to $\rho_r\psi\rho_r^{-1}$. If our theorem is proved for $\varphi^{1/r}$, ψ will be generated by a Hamiltonian depending only on the p variable. We easily check that in this case

$$\rho_r\psi\rho_r^{-1} = \psi^r.$$

In other words, $\rho_k^{-1}\varphi^k\rho_k$ γ -converges to ψ^r .

Remark 6.2. Note that $\rho_k\varphi\rho_k^{-1}$ is not well defined since $\tilde{\rho}_k\tilde{\varphi}\tilde{\rho}_k^{-1}$ is not \mathbb{Z}^n equivariant. However the conjugacy $\rho_r(\rho_{kr}^{-1}\varphi\rho_{kr})\rho_r^{-1}$ is well defined : one may check that the lift is indeed \mathbb{Z}^n -equivariant. Similarly for ψ the flow of an integrable Hamiltonian, $h(p)$, the map $\rho_r\psi\rho_r^{-1}$ is indeed well-defined, and equal to ψ^r as stated. Of course by a continuity argument this extends to the case where h is only continuous.

For simplicity we shall assume from now on that φ is C^1 -close to the identity, so that it lifts to a Hamiltonian diffeomorphism $\tilde{\varphi}$ of $T^*\mathbb{R}^n$, C^1 -close to the identity. The graph of the map $\tilde{\varphi}$ has a generating function S defined on T^*T^n and compactly supported. We identify $q \in \mathbb{R}^n$ with its projection in T^n , and $P \in \mathbb{R}^n$. By abuse of notation, we shall still denote by S the lift of S to $T^*\mathbb{R}^n$.

The function S defines $\tilde{\varphi}$ by the relation

$$\tilde{\varphi}\left(q, P - \frac{\partial S}{\partial q}(q, P)\right) = \left(q - \frac{\partial S}{\partial P}(q, P), P\right)$$

This means that the graph $\tilde{\Gamma}(\varphi)$ of $\tilde{\varphi}$ in $\overline{T^*\mathbb{R}^n} \times T^*\mathbb{R}^n \simeq T^*\Delta_{\mathbb{R}^{2n}}$, has the generating function $S(q, p)$ that is the lift of a compactly supported function defined on T^*T^n .

In other words, setting $\tilde{\varphi}(q, p) = (Q, P)$ we have

$$\begin{cases} P - p = \frac{\partial S}{\partial q}(q, P) \\ q - Q = \frac{\partial S}{\partial P}(q, P) \end{cases}$$

Similarly when φ is not C^1 -close to the identity. Then S has extra variable $\xi \in V$ and $S(x, P; \xi)$ is quadratic at infinity. Then for $(q, P; \xi)$ such that $\frac{\partial S}{\partial \xi}(q, P; \xi) = 0$ we have

$$\tilde{\varphi}\left(q, P - \frac{\partial S}{\partial q}(q, P; \xi)\right) = \left(q - \frac{\partial S}{\partial P}(q, P; \xi), P\right)$$

We now give the composition law for generating functions, due to Chekanov (cf. [Che]).

Lemma 6.3. *Let φ_1, φ_2 be Hamiltonian maps having S_1, S_2 defined respectively on $T^n \times \mathbb{R}^n \times V_1$ and $T^n \times \mathbb{R}^n \times V_2$ as generating functions, compactly supported functions on T^*T^n . Then $\widetilde{\varphi_1 \circ \varphi_2}$ has the generating function*

$$S(q_1, p_2; q_2, p_1, \xi_1, \xi_2) = S_1(q_1, p_1, \xi_1) + S_2(q_2, p_2, \xi_2) + \langle p_1 - p_2, q_2 - q_1 \rangle$$

where $q_1 \in \mathbb{R}^n, q_2 \in \mathbb{R}^n, p_1, p_2 \in \mathbb{R}^n$.

Remark 6.4. Let us point out the following

- (1) The above function S is a GFQI, since the sum of two functions (in different variables) with derivatives at bounded distance from the derivative of a quadratic form is at bounded distance from the derivative of a quadratic form. Note that according to Brunella ([Bru], see also [V3], prop. 1.6), S may be deformed to a generating function that is equal to a quadratic form outside a compact set.
- (2) Note that in the above lemma, $q_2 \in \mathbb{R}^n$ is identified with its projection on T^n . We may remark that if we set $q_2 = q_1 + u$, we have

$$\begin{aligned} S'(q_1, p_2; u, p_2) &= S(q_1, p_2; q_1 + u, p_2) = \\ &= S_1(q_1, p_2) + S_2(q_1 + u, p_2) + \langle p_2 - p_1, u \rangle \end{aligned}$$

so that S' is a GFQI of the same Lagrangian as S (since we did a fiber-preserving change of variable), and is the lift of a function defined on $T^*T^n \times \mathbb{R}^{2n}$ ($q_1 \in T^n, p_2 \in \mathbb{R}^n, u, v \in \mathbb{R}^n$).

Proof. This is a straightforward computation and we refer to [Che], Theorem 4.1 (see also [Ch2] for example). □

More generally, we get:

Lemma 6.5. *The map $\tilde{\varphi}^k$ has the generating function*

$$\begin{aligned} S_k(q_1, p_k; p_1, q_2, p_2, \dots, q_{k-1}, p_{k-1}, q_k) = \\ \Sigma_k(q_1, p_k; p_1, q_2, p_2, \dots, q_{k-1}, p_{k-1}, q_k) + \\ B_k(q_1, p_k; p_1, q_2, p_2, \dots, q_{k-1}, p_{k-1}, q_k) \end{aligned}$$

where

$$\Sigma_k(q_1, p_k; p_1, q_2, p_2, \dots, q_{k-1}, p_{k-1}, q_k) = \sum_{j=1}^k S(q_j, p_j)$$

and

$$B_k(q_1, p_k; p_1, q_2, \dots, q_{k-1}, p_{k-1}, q_k) = \sum_{j=1}^{k-1} \langle p_j, q_{j+1} - q_j \rangle + \langle p_k, q_1 - q_k \rangle$$

Proof. By induction from the formula in Lemma 6.3

$$S(q_1, p_2; q_2, p_1) = S_1(q_1, p_1) + S_2(q_2, p_2) + \langle p_1 - p_2, q_2 - q_1 \rangle.$$

□

Remarks 6.6. **(1)** In the sequel $(q_j, p_j) \in T^*\mathbb{R}^n$, even though, by our usual abuse of notations, we identify q_j with its projection on $T^n = \mathbb{R}^n/\mathbb{Z}^n$. Note however that for $\nu \in \mathbb{Z}^n$, we have that Σ_k and S_k are invariant by $(q_j)_{1 \leq j \leq n} \rightarrow (q_j + \nu)_{1 \leq j \leq n}$. We emphasize that the q_j and p_j are vector coordinates (i.e. each q_j and each p_j is a vector in \mathbb{R}^n).

(2) Note that this formula is a discretization of the action functional (up to sign). The sum of the $S(q_j, p_j)$ corresponds to $\int H dt$ while the quadratic term corresponds to $\int p \dot{q} dt$.

Again, Σ_k is defined on $(T^*T^n)^k$, while B_k is defined on $(T^*\mathbb{R}^n)^k$. Note also that B_k is the discretization of $\int_{S^1} p \dot{q} dt$, so that our expression is the discretization of the Maupertuis action $\int_{S^1} p \dot{q} - H dt$. Finally we have

Lemma 6.7. *Let φ be a Hamiltonian diffeomorphism of T^*T^n generated by $S(q, p)$. Then $\varphi_k = \rho_k^{-1} \varphi^k \rho_k$ is generated by F_k given by*

$$\begin{aligned} F_k(q_1, p_k; p_1, \dots, q_{k-1}, p_{k-1}, q_k) = \\ \frac{1}{k} \Sigma_k(kq_1, p_k; p_1, \dots, kq_{k-1}, p_{k-1}, kq_k) + B_k(q_1, p_k; p_1, \dots, q_{k-1}, p_{k-1}, q_k) \end{aligned}$$

Proof. Indeed an elementary computation shows that if $S(q, p; \xi)$ is a generating function for $\psi : T^*\mathbb{R}^n \rightarrow T^*\mathbb{R}^n$, then $\frac{1}{k} S(kq, p; \xi)$ generates $\rho_k^{-1} \psi \rho_k$.

Thus in our case, we expect the generating function

$$\frac{1}{k} \Sigma_k(kq_1, p_k; p_1, q_2, \dots, q_{k-1}, p_{k-1}, q_k)$$

$$+\frac{1}{k}B_k(kq_1, p_k; p_1, q_2, \dots, q_{k-1}, p_{k-1}, q_k)$$

But the fiber-preserving change of variable $q_j \mapsto kq_j$ ($j \geq 2$) transforms this generating function into

$$\begin{aligned} & F_k(q_1, p_k; p_1, q_2, \dots, q_{k-1}, p_{k-1}, q_k) = \\ & \frac{1}{k}\Sigma_k(kq_1, p_k; p_1, kq_2, \dots, kq_{k-1}, p_{k-1}, q_k) \\ & +\frac{1}{k}B_k(kq_1, p_k; p_1, kq_2, \dots, kq_{k-1}, p_{k-1}, q_k) \end{aligned}$$

Because the second term is quadratic, we easily check that it is equal to

$$B_k(q_1, p_k; p_1, q_2, \dots, q_{k-1}, p_{k-1}, q_k)$$

□

Definition 6.8. We set to simplify our notations

$$x = q_1, y = p_k, \xi = (p_1, q_2, \dots, q_{k-1}, p_{k-1}, q_k)$$

We define

$$F_k : \mathbb{R}_x^n \times (\mathbb{R}^n)_y^* \times \mathbb{R}_\xi^{2n(k-1)} \longrightarrow \mathbb{R}$$

$$\begin{aligned} & F_k(x, y; \xi) = \\ & \frac{1}{k} \left[S(kx, p_1) + \sum_{j=2}^{k-1} S(kq_j, p_j) + S(kq_k, y) \right] + B_k(x, y, \xi) \end{aligned}$$

where $B_k(x, y, \xi)$ is defined by

$$B_k(q_1, p_k; p_2, \dots, q_k) = \sum_{j=1}^{k-1} \langle p_j, q_{j+1} - q_j \rangle + \langle p_k, q_1 - q_k \rangle$$

Let μ_x be the fundamental class in the torus T^n (which variable is denoted here by x). We then define

$$h_k(y) = c(\mu_x, F_{k,y}) = c(\mu_x \otimes 1(y), F_k)$$

where $F_{k,y}(x; \xi) = F_k(x, y; \xi)$.

Remarks 6.9. Let us make the following remarks

- (1) As long as we write $c(\mu_x \otimes 1(y), S)$ for a generating function S , there is no ambiguity. However, if Λ is the Lagrangian associated to S , and $(\Lambda)_y$ is the reduction of Λ at y , having GFQI S_y , writing an expression like $c(\alpha, (\Lambda)_y)$ requires some care, since S is defined up to a constant, and this constant yields a coherent choice of a GFQI for $(\Lambda)_y$ for each y , so that the $c(\alpha, (\Lambda)_y)$ are well-defined up to the same constant for all values of the parameter y , and not up to a function of y as one could expect. Indeed, a choice of S , a GFQI for Λ defines a GFQI for $(\Lambda)_y$, by $S_y = S(y, \bullet)$.

Moreover, for similar reasons, even $c(\beta, (\Lambda)_y) - c(\alpha, (\Lambda)_y)$ depends on the global Λ and not only on its reduction $(\Lambda)_y$.

(2) Note also that for $\nu = (\nu_1, \dots, \nu_k) = (\nu_1, \bar{\nu}) \in \mathbb{Z} \oplus \mathbb{Z}^{k-1}$, we have

$$F_k(x, y; \xi) = F_k(x + \nu_1, y, \bar{\nu} + \xi)$$

where $\bar{\nu} + \xi = (p_1, q_2 + \nu_2, \dots, p_{k-1}, q_k + \nu_k)$. Indeed, this periodicity is obvious for the terms containing S , and the quadratic term is

$$B_k(q_1, p_k; p_2, \dots, q_k) = \sum_{j=1}^{k-1} \langle p_j, q_j - q_{j+1} \rangle + \langle p_k, q_1 - q_k \rangle$$

remembering that $x = q_1, y = p_k$ for which the periodicity is easily checked.

(3) Note that since φ_k^t equals the identity outside a compact set of the cotangent bundle, the function $\xi \mapsto F_k(x, y, \xi)$ will have, for y large enough, a single critical point with critical value equal to zero (by normalization). According to remark 6.4, (1), we could deform F_k to be exactly quadratic for y large enough, but this is not really useful, since for such values of y topologically there is no way to distinguish $\xi \mapsto F_k(x, y, \xi)$ from a quadratic form (the topology of the sub-level sets will coincide).

(4) The analogue of the above formula still holds if φ is not assumed to be C^1 -small. Then its graph $\bar{\Gamma}(\varphi)$ has a generating function $S(q, p; \zeta)$, on $\mathbb{R}_x^n \times (\mathbb{R}^n)_y^* \times E \rightarrow \mathbb{R}$ and φ_k^1 has generating function

$$F_k : \mathbb{R}_x^n \times (\mathbb{R}^n)_y^* \times \mathbb{R}_\xi^{2n(k-1)} \times E^k \rightarrow \mathbb{R}$$

where ξ is as in Definition 6.8

$$F_k(x, y; \xi, \zeta_1, \dots, \zeta_k) = \frac{1}{k} \left[S(kx, p_1, \zeta_1) + \sum_{j=2}^{k-1} S(kq_j, p_j, \zeta_j) + S(kq_k, y, \zeta_k) \right] + B_k(x, y, \xi)$$

Our first step will be to prove

Proposition 6.10. *The sequence $(h_k)_{k \geq 1}$ is a precompact sequence for the C^0 topology.*

The proposition will follow from Ascoli-Arzelà's theorem, once we prove the following

Lemma 6.11. *The sequence $(h_k)_{k \geq 1}$ is equicontinuous and uniformly bounded.*

Proof. Indeed let $\tilde{\varphi}_k$ be the lift of $\varphi_k = \rho_k^{-1} \varphi^k \rho_k$ to $T^*\mathbb{R}^n$. It has support in some tube

$$T_A^*\mathbb{R}^n = \{(q, p) \in T^*\mathbb{R}^n \mid |p| \leq A\}$$

Now remember from [V1] (section 2, pages 690-693) that $c(\alpha, F_{k,y})$ is a critical value of $F_{k,y}$. Thus for each y there exists $x(y), \xi(y)$ such that

$$\frac{\partial F_k}{\partial x}(x(y), y; \xi(y)) = 0, \quad \frac{\partial F_k}{\partial \xi}(x(y), y, \xi(y)) = 0$$

$$F_k(x(y), y, \xi(y)) = h_k(y)$$

Moreover, we may assume φ is generic, so that the map $y \mapsto (x(y), \xi(y))$ is smooth on a set W , the complement of some codimension one subset (see [O-V] and also [Roos, WQ1], Appendix 2 (theorem 13.1) of [V5]). Thus for y in W

$$\begin{aligned} dh_k(y) &= \frac{\partial}{\partial y} F_k(x(y), y, \xi(y)) \\ &= x(y) - X_k(x(y), y) \end{aligned}$$

where X_k is defined by

$$\tilde{\varphi}_k(x, y) = (X_k(x, y), Y_k(x, y))$$

The quantity $x(y) - X_k(x(y), y)$ can be estimated as follows : the first coordinate of the flow $\tilde{\varphi}_k^t$ satisfies

$$\dot{x}_k(t) = \frac{\partial H}{\partial y}(kx_k(t), y_k(t))$$

hence $|\dot{x}_k(t)|$ is bounded by $C = \sup \left\{ \left| \frac{\partial H}{\partial p}(x, y) \right| \mid (x, y) \in T^*T^n \right\}$ which is finite since H is compactly supported. This implies that $|x - X_k(x, y)| \leq C$ hence in the complement of Σ the inequality

$$|dh_k(y)| = \left| \frac{\partial}{\partial y} F_k(x(y), y, \xi(y)) \right| \leq C$$

holds. Since h_k is continuous, this implies that it is C -Lipschitz.

For the uniform boundedness, let C be a bound for $|S|$. Then according to Definition 6.8 $|F_k(x, y; \xi) - B_k(x, y, \xi)| \leq C$. Since $c(\mu_x, B_k) = 0$ we get $|c(\mu_x, F_k)| = |h_k(y)| \leq C$. \square

From Ascoli-Arzelà's theorem and the above Lemma 6.11, we infer that the sequence $(h_k)_{k \geq 1}$ is relatively compact in the C^0 topology. In other word it has a C^0 -converging subsequence, and so does any of its subsequences. We now argue as follows : consider a subsequence $(h_{k_\nu})_{\nu \geq 1}$ of $(h_k)_{k \geq 1}$ C^0 -converging to h_∞ . We are going to prove that $(\varphi_{k_\nu}^1)_{\nu \geq 1}$ γ -converges to $\bar{\varphi}_\infty$, the time-one flow of h_∞ . We still need to prove that the whole sequence $(\varphi_k^1)_{k \geq 1}$ C^0 -converges to $\bar{\varphi}_\infty$, but this follows⁹ from :

Proposition 6.12. *If a subsequence of $(\rho_k^{-1} \varphi^k \rho_k)_{k \geq 1}$ has a γ -limit $\bar{\varphi}$, then any other γ -converging subsequence has the same γ -limit.*

Proof. We start with

Lemma 6.13. *For any φ, ψ in $Ham_c(T^*T^n)$:*

$$(6.1) \quad \gamma(\varphi^k \psi^k) \leq k\gamma(\varphi \psi)$$

$$(6.2) \quad \gamma(\rho_k^{-1} \varphi \rho_k) = \frac{1}{k} \gamma(\varphi)$$

⁹We use here the fact that in a metric space if every subsequence of a sequence $(x_k)_{k \geq 1}$ has a converging sub-subsequence with limit x , then the sequence itself converges to x .

Proof. Indeed, we may write

$$\varphi^k \psi^k = \varphi \psi (\psi^{-1}(\varphi \psi) \psi) (\psi^{-2}(\varphi \psi) \psi^2) \dots (\psi^{-(k-1)}(\varphi \psi) \psi^{k-1})$$

Since each factor is conjugate to $\varphi \psi$, and we have k factors, property (6.1) follows immediately from conjugation invariance of γ and the triangle inequality. Property (6.2) follows from the fact that if $S(q, P; \xi)$ is the GFQI for φ then $R_k(q, P; \xi) = \frac{1}{k} S(k \cdot q, P; \xi)$ is the GFQI for $\rho_k^{-1} \varphi \rho_k$ and it is easy to check that $c(\alpha, R_k) = \frac{1}{k} c(\alpha, S(q, P; \xi))$ (this is a manifestation of the scaling property of γ by conformal conjugation, see equation (4.1) in section 4). \square

Now we prove that the sequence $(\rho_k^{-1} \varphi^k \rho_k)_{k \geq 1}$ cannot have two distinct limit points. Indeed, let us assume we have two infinite sets of integers, A, B such that there exists $\bar{\sigma}_1 \neq \bar{\sigma}_2$ and a sequence ε_k converging to 0 with the property

$$\forall k \in A \quad \gamma(\rho_k^{-1} \varphi^k \rho_k, \bar{\sigma}_1) \leq \varepsilon_k$$

$$\forall k \in B \quad \gamma(\rho_k^{-1} \varphi^k \rho_k, \bar{\sigma}_2) \leq \varepsilon_k$$

Then for any integer q ,

$$\gamma(\rho_{kq}^{-1} \varphi^{kq} \rho_{kq}, \bar{\sigma}_1) = \gamma(\rho_q^{-1} (\rho_k^{-1} \varphi^k \rho_k)^q \rho_q (\rho_q^{-1} \bar{\sigma}_1^{-q} \rho_q))$$

since

$$\bar{\sigma}_1 = \rho_q^{-1} \bar{\sigma}_1^{-q} \rho_q$$

This last equality follows from the fact that for an integrable Hamiltonian, $H(p)$, we obviously have $H_k = H$.

But using (6.2), we get for $k \in A$

$$\begin{aligned} \gamma(\rho_{kq}^{-1} \varphi^{kq} \rho_{kq}, \bar{\sigma}_1) &= \gamma(\rho_q^{-1} (\rho_k^{-1} \varphi^k \rho_k)^q \rho_q (\rho_q^{-1} \bar{\sigma}_1^{-q} \rho_q)) = \\ &= \gamma(\rho_q^{-1} ((\rho_k^{-1} \varphi^k \rho_k)^q \bar{\sigma}_1^{-q}) \rho_q) \leq \\ &= \frac{1}{q} \gamma((\rho_k^{-1} \varphi^k \rho_k)^q \bar{\sigma}_1^{-q}) \leq \\ &= q \cdot \frac{1}{q} \gamma(\rho_k^{-1} \varphi^k \rho_k \bar{\sigma}_1^{-1}) \leq \varepsilon_k \end{aligned}$$

Similarly we get that for k in B , and any q , we have

$$\gamma(\rho_{kq}^{-1} \varphi^{kq} \rho_{kq}, \bar{\sigma}_2) \leq \varepsilon_k$$

As a result, for $k \in A, m \in B$ we have

$$\gamma(\rho_{km}^{-1} \varphi^{km} \rho_{km}, \bar{\sigma}_1) \leq \varepsilon_k$$

$$\gamma(\rho_{km}^{-1} \varphi^{km} \rho_{km}, \bar{\sigma}_2) \leq \varepsilon_m$$

This implies $\gamma(\bar{\sigma}_1, \bar{\sigma}_2) \leq \varepsilon_m + \varepsilon_k$ and since the right hand side goes to zero as k, m go to infinity, we get that $\bar{\sigma}_1 = \bar{\sigma}_2$ and this concludes the proof. \square

6.2 The Main steps of the proof

In the previous section we obtained a continuous function $h_\infty(p)$, as the limit of some subsequence $(h_{k_\nu}(p))_{\nu \geq 1}$. Since h_∞ is continuous, according to Humilière (cf. our proposition 4.11 above, or [Hu] proposition 1.3) it has a “generalized flow” that is generates a one-parameter subgroup in $\widehat{Ham}_c(T^*T^n)$. In other words the map $H \rightarrow \varphi_H^t$ extends to a map between the γ -completions,

$$\widehat{\mathfrak{H}am}_c(T^*T^n) \longrightarrow \widehat{Ham}_c(T^*T^n)$$

Note that $\widehat{Ham}_c(T^*T^n)$ inherits the group structure of $Ham_c(T^*T^n)$. We denote by $\overline{\varphi}_\infty^t$ the “generalized flow” associated to h_∞ . Note that the element $\overline{\varphi}_\infty^t$ is not a map: it is only an element in $\widehat{Ham}_c(T^*T^n)$.

Proposition 6.14. *For all $t \geq 0$, the element $\overline{\varphi}_\infty^t$ is the γ -limit of $(\varphi_k^t)_{k \geq 1}$ defined by $\varphi_k^t = \rho_k^{-1} \varphi^{kt} \rho_k$: we have*

$$\lim_{k \rightarrow +\infty} \gamma(\varphi_k^t, \overline{\varphi}_\infty^t) = 0$$

From now on we assume $t = 1$, and denote $\varphi_k = \varphi_k^1$, and $\overline{\varphi}_\infty = \overline{\varphi}_\infty^1$. The proof of Proposition 6.14 will be based on the following two propositions

Proposition 6.15. *There exists a sequence $(k_\nu)_{\nu \geq 1}$ going to infinity such that for any α in $\widehat{Ham}_c(T^*T^n)$, we have*

$$\limsup_{\nu \rightarrow \infty} c_+(\varphi_{k_\nu} \alpha) \leq c_+(\overline{\varphi}_\infty \alpha)$$

Proposition 6.16. *Consider a subsequence of $(\varphi_{k_\nu})_{\nu \geq 1}$ such that (all limits are uniform in p)*

$$\lim_{\nu \rightarrow \infty} c(\mu \otimes 1(p), \varphi_{k_\nu}) = \lim_{\nu} h_{k_\nu}(p) = h_\infty(p)$$

Then we have

$$\lim_{\nu \rightarrow \infty} c(\mu \otimes 1(p), \varphi_{k_\nu}^{-1}) = -h_\infty(p)$$

Proof that Proposition 6.15 and 6.16 imply Proposition 6.14. Indeed take $\alpha = \overline{\varphi}_\infty^{-1}$, where $\overline{\varphi}_\infty = \overline{\varphi}_\infty^1$ is the limit associated by the previous subsection to some subsequence of $(k_\nu)_{\nu \geq 1}$ still denoted $(k_\nu)_{\nu \geq 1}$. By Proposition 6.15, we get

$$\limsup_{\nu} c_+(\varphi_{k_\nu} \overline{\varphi}_\infty^{-1}) \leq c_+(\text{Id}) = 0.$$

and since for all β in $\widehat{Ham}_c(T^*T^n)$, $c_+(\beta) \geq 0$ we get,

$$\limsup_{\nu} c_+(\varphi_{k_\nu} \overline{\varphi}_\infty^{-1}) = 0$$

Now we must prove $\liminf_{\nu} c_-(\varphi_{k_\nu} \overline{\varphi}_\infty^{-1}) = 0$, and it is enough to show that

$$\liminf_{\nu} c_-(\varphi_{k_\nu} \alpha) \geq c_-(\overline{\varphi}_\infty \alpha)$$

for any α in $\widehat{Ham}_c(T^*T^n)$.

But according to [V1] ((2) of proposition 4.2 page 697) and invariance by conjugation of c (see [V1], corollary 4.3 page 698) the formulas

$$c_+(\varphi^{-1}) = -c_-(\varphi)$$

and

$$c_{\pm}(\psi\varphi\psi^{-1}) = c_{\pm}(\varphi)$$

hold in $Ham(T^*T^n)$. Since c_{\pm} are obviously continuous for the γ -topology, the same formulas hold in $\widehat{Ham}_c(T^*T^n)$. We can thus write

$$c_-(\varphi_{k_\nu}\alpha) = -c_+(\alpha^{-1}\varphi_{k_\nu}^{-1}) = -c_+(\varphi_{k_\nu}^{-1}\alpha^{-1})$$

We then apply proposition 6.15 to the sequence $(\varphi_{k_\nu}^{-1})$. According to proposition 6.16

$$\lim_{\nu} c(\mu \otimes 1(p), \varphi_{k_\nu}^{-1}) = -h_{\infty}(p)$$

and according to Appendix A, Corollary A.2, $-h_{\infty}(p)$ has flow $\bar{\varphi}_{\infty}^{-1}$ in the completion $\widehat{Ham}_c(T^*T^n)$.

As a result

$$\begin{aligned} \liminf_k c_-(\varphi_{k_\nu}\alpha) &= -\limsup_k c_+(\varphi_{k_\nu}^{-1}\alpha^{-1}) \\ &\geq -c_+(\bar{\varphi}_{\infty}^{-1}\alpha^{-1}) = c_-(\bar{\varphi}_{\infty}\alpha) \end{aligned}$$

Taking again $\alpha = \bar{\varphi}_{\infty}^{-1}$ we get

$$\liminf_k c_-(\varphi_{k_\nu}\bar{\varphi}_{\infty}^{-1}) = 0$$

hence

$$\lim_k c_-(\varphi_{k_\nu}\bar{\varphi}_{\infty}^{-1}) = \lim_k c_+(\varphi_{k_\nu}\bar{\varphi}_{\infty}^{-1}) = 0$$

We thus proved that if the sequence $h_{k_\nu}(p) = c(\mu_x \otimes 1(p), \varphi_{k_\nu})$ C^0 -converges to h_{∞} , then $(\varphi_{k_\nu})_{\nu \geq 1}$ γ -converges to $\bar{\varphi}_{\infty}$. Note that conversely, if $(\varphi_{k_\nu})_{\nu \geq 1}$ γ -converges to $\bar{\varphi}_{\infty}$, since $\psi \mapsto c(\alpha, \psi)$ is 1-Lipschitz, we have that $h_{k_\nu}(p) = c(\mu_x \otimes 1(p), \varphi_{k_\nu})$ C^0 -converges to $c(\mu_x \otimes 1(p), \bar{\varphi}_{\infty}) = h_{\infty}(p)$.

Now assume there are two subsequences, $(\varphi_{k_\nu})_{\nu \geq 1}, (\varphi_{l_\nu})_{\nu \geq 1}$ such that $c(\mu_x \otimes 1(p), \varphi_{k_\nu})$ C^0 -converges to h_{∞}^1 , while $c(\mu_x \otimes 1(p), \varphi_{l_\nu})$ C^0 -converges to h_{∞}^2 . Then we find two subsequences of $(\varphi_k)_{k \geq 1}$ γ -converging respectively to $\bar{\varphi}_1$ and $\bar{\varphi}_2$ (where $\bar{\varphi}_1^t$ is the flow of h_{∞}^1 while $\bar{\varphi}_2^t$ is the flow of h_{∞}^2). But according to Proposition 6.12, two γ -converging subsequences of $(\varphi_k)_{k \geq 1}$ must have the same limit, thus $\bar{\varphi}_1 = \bar{\varphi}_2$. Using again the continuity of $\psi \mapsto c(\alpha, \psi)$ for γ , we have

$$\begin{aligned} h_{\infty}^1(p) &= \lim_{\nu} c(\mu_x \otimes 1(p), \varphi_{k_\nu}) = c(\mu_x \otimes 1(p), \bar{\varphi}_1) = \\ &= c(\mu_x \otimes 1(p), \bar{\varphi}_2) = \lim_{\nu} c(\mu_x \otimes 1(p), \varphi_{l_\nu}) = h_{\infty}^2(p) \end{aligned}$$

As a result we proved that

- (a) the sequence $(h_k)_{k \geq 1}$ is precompact for the C^0 topology
- (b) If a subsequence $(h_{k_\nu})_{\nu \geq 1}$ C^0 -converges to \bar{h} then the sequence $(\varphi_{k_\nu})_{\nu \geq 1}$ converges to $\bar{\varphi}_{\infty}$

(c) any two converging subsequences of $(\varphi_k)_{k \geq 1}$ have the same limit

We claim that this implies that $(\varphi_k)_{k \geq 1}$ converges, and its limit is $\bar{\varphi} = \bar{\varphi}_\infty$, the flow of h_∞ defined by $h_\infty(p) := \lim_k c(\mu_x \otimes 1(p), \varphi_k)$.

Indeed from (a) we get the existence of a limit \bar{h} for some subsequence, from (b) that then the corresponding subsequence of $(\varphi_k)_{k \geq 1}$ converges to $\bar{\varphi}$ and since by (c) $\bar{\varphi}$ is unique, so is \bar{h} (according to Proposition A.1 from the Appendix). Now we claim $(h_k)_{k \geq 1}$ converges. Indeed, assume otherwise: there would be a subsequence k_ν such that $\gamma(h_{k_\nu}, \bar{h}) \geq \varepsilon$ for all ν . But the subsequence h_{k_ν} being precompact has a converging subsequence, whose limit must be different from \bar{h} a contradiction with (c). Now we know $(h_k)_{k \geq 1}$ converges to \bar{h} , hence so does $(\varphi_k)_{k \geq 1}$ and it must have limit $\bar{\varphi}_\infty$ the flow of \bar{h}_∞ (in $\widehat{Ham}_c(T^*T^n)$).

This concludes our proofs of Proposition 6.14, modulo the proofs of Propositions 6.15 and 6.16. \square

We note the following

Corollary 6.17. *The γ -convergence of φ_k^t to φ_∞^t is uniform in t on compact sets. In other words the sequence of functions $t \mapsto \gamma(\varphi_k^t \bar{\varphi}^{-t})$ converges uniformly on compact sets to 0.*

Proof. This follows from the fact that if $\|H\|_{C^0} \leq C$ then $\|H_k\|_{C^0} \leq C$ and thus $\gamma(\varphi_k^t \varphi_k^{-s}) \leq C|t - s|$. So let $f_k(t) = \gamma(\varphi_k^t \bar{\varphi}^{-t})$, then

$$\begin{aligned} |f_k(t) - f_k(s)| &= |\gamma(\varphi_k^t \bar{\varphi}^{-t}) - \gamma(\varphi_k^s \bar{\varphi}^{-s})| \leq \gamma(\varphi_k^t \bar{\varphi}^{-t} \circ \bar{\varphi}^s \varphi_k^{-s}) \leq \\ &\gamma(\varphi_k^t \varphi_k^{-s}) + \gamma(\bar{\varphi}^t \bar{\varphi}^{-s}) \leq 2C|t - s| \end{aligned}$$

Now if a sequence $(f_k)_{k \geq 1}$ of functions defined on $[0, 1]$ and uniformly Lipschitz converges simply to a function f , then the convergence is uniform. Indeed, the sequence $(f_k)_{k \geq 1}$ is equicontinuous. It is also uniformly bounded, since $\gamma(\varphi_k) \leq \|H_k\|_{C^0} \leq C$ so $\gamma(\varphi_k^t \bar{\varphi}^{-t}) \leq \gamma(\varphi_k^t) + \gamma(\bar{\varphi}^{-t}) \leq 2C$. So by Ascoli's theorem, one can find a subsequence converging uniformly on compact sets, but the limit of the subsequence is necessarily f . And since we proved that all converging subsequences must have the same limit, the sequence is uniformly converging to f on compact sets. \square

7 Proof of proposition 6.15

First of all, it is enough to deal with the case where $\alpha \in Ham_c(T^*T^n)$ (i.e. not in its completion), since $Ham_c(T^*T^n)$ is dense in $\widehat{Ham}_c(T^*T^n)$ and c_+ is continuous for γ . Now we may choose $S(x, y; \eta)$ a GFQI for α , with η belonging to some vector space V . Let \mathbb{Z}^n act diagonally on the (u, x) variables by $\nu \star (u, x) \mapsto (u + \nu, x + \nu)$ and extend this action by the trivial action on products of $\mathbb{R}_u^n \times \mathbb{R}_x^n$ so that $\varphi_k \alpha$ has the GFQI defined on the \mathbb{Z}^n quotient

$$G_k : T_u^n \times \mathbb{R}_v^n \times \mathbb{R}_x^n \times \mathbb{R}_y^n \times V \times E_k \longrightarrow \mathbb{R}$$

$$G_k(u, v; x, y, \eta, \xi) = S(x + u, v; \eta) + F_k(u, y; \xi) + \langle y - v, x \rangle$$

where F_k was defined in Definition 6.8 and is a GFQI for φ_k , $u \in T_u^n$, $v \in \mathbb{R}_v^n$, $x \in \mathbb{R}_x^n$, $y \in \mathbb{R}_y^n$, $\xi \in E_k$, $\eta \in V$, and E_k is the space $\mathbb{R}^{2n(k-1)}$ as in Definition 6.8.

It will often be more convenient to switch from cohomology to homology in order to make our argument geometrically more transparent. By relative cycle we mean a chain with boundary in $F_k^{-\infty}$ (i.e. in F_k^{-c} for c large enough). The number $c(a, S)$ was defined for a homology class a in Remark 4.4 (4). The identification of $c(\mu_u \otimes 1(y), F_k)$ with $c([T_u^n \times \{y\}], F_k)$ follows from Appendix B, Prop B.3. In the sequel we denote by C a relative cycle representing z in $H_*(F^b, F^a)$ which means that $C \subset F^b$ and $[C, C \cap F^a] = z$ in $H_*(F^b, F^a)$.

Thus, by definition of $c(\mu_u \otimes 1(y), \varphi_k) = h_k(y)$, for each y , there is a relative cycle $C^-(y)$ homologous to $T_u^n \times \{y\} \times E_k^-$ (x lives in T^n , ξ in E_k , and E_k^- is the negative eigenspace for the quadratic part B_k of F_k) in

$$H_*(G_{k,(x,v,\eta)}^\infty, G_{k,(x,v,\eta)}^{-\infty}) = H_*(F_k^\infty, F_k^{-\infty})$$

such that

$$F_k(y, C^-(y)) \leq h_k(y) + \varepsilon$$

(we denote by $(y, C^-(y))$ the set of (u, y, ξ) such that $(u, \xi) \in C^-(y)$). Unfortunately we may not get such an estimate if we simultaneously require that $C^-(y)$ is to depend continuously on y . However, let us first assume such a continuous dependence can be achieved and $(h_k)_{k \geq 1}$ converges to h_∞ . Set

$$\begin{aligned} \bar{G}_k &: T_u^n \times \mathbb{R}_v^n \times \mathbb{R}_x^n \times \mathbb{R}_y^n \times V/\mathbb{Z}^n \\ \bar{G}_k(u, v; x, y, \eta) &= S(x + u, v; \eta) + h_k(y) + \langle y - v, x \rangle \end{aligned}$$

Again we may find a (relative) cycle Γ in $T_u^n \times \mathbb{R}_v^n \times (\mathbb{R}_x^n) \times (\mathbb{R}_y^n) \times V$ in the homology class of $T_{(u,v)}^n \times \Delta_{x,y} \times V^-$, where V^- is the negative eigenspace of the quadratic part¹⁰ of S , such that

$$\sup \bar{G}_k(\Gamma) \leq c(\mu, \bar{G}_k) + \varepsilon = c(\mu, \bar{\varphi}\alpha) + \varepsilon$$

Let now $\Gamma \times_Y C^-$ be the (relative) cycle

$$\Gamma \times_Y C^- = \{(u, v, x, y, \xi, \eta) \mid (u, v, x, y, \eta) \in \Gamma, (u, \xi) \in C^-(y)\}$$

We claim that

$$(1) \quad \sup G_k(\Gamma \times_Y C^-) \leq \bar{G}_k(\Gamma) + \varepsilon$$

(2) $\Gamma \times_Y C^-$ is a cycle in $H_*(G_k^\infty, G_k^{-\infty})$ homologous to

$$T_u^n \times \mathbb{R}_v^n \times \Delta_{x,y} \times E_k^- \times V^-$$

so that

$$\begin{aligned} c(\mu, \varphi_k \alpha) = c(\mu, G_k) &\leq \sup G_k(\Gamma \times_Y C^-) \leq \sup \bar{G}_k(\Gamma) + \varepsilon \leq \\ &c(\mu, \bar{G}_k) + \varepsilon \leq c(\mu, \varphi_k \alpha) + \varepsilon \end{aligned}$$

Indeed, for (1) we have

$$\begin{aligned} &\sup G_k(\Gamma \times_Y C^-) = \\ &\sup \{S(x + u, v; \eta) + F_k(u, y, \xi) + \langle y - v, x \rangle \mid (u, v, x, y, \eta) \in \Gamma, (u, \xi) \in C^-(y)\} \end{aligned}$$

¹⁰Notice that $\Delta_{x,y}$, the diagonal in $\mathbb{R}_x^n \times \mathbb{R}_y^n$, is the negative eigenspace of $\langle y, -x \rangle$.

but $F_k(u, y, \xi) \leq h_k(y) + \varepsilon$ for $(u, \xi) \in C^-(y)$, so

$$\begin{aligned} \sup G_k(\Gamma \times_Y C^-) &\leq \\ \sup\{S(x + u, v; \eta) + h_k(y) + \langle y - v, x \rangle \mid (u, v, x, y, \eta) \in \Gamma\} + \varepsilon &\leq \\ \sup \bar{G}_k(\Gamma) + \varepsilon & \end{aligned}$$

For (2), we use the fact that if Γ is homologous to $T_{(u,v)}^n \times \Delta_{x,y} \times V^-$ and $C^-(y)$ is homologous to $T^n \times \{y\} \times E_k^-$ then $\Gamma \times_Y C^-$ is homologous¹¹ to $(T_{(u,v)}^n \times \Delta_{x,y} \times V^-) \times_Y (T^n \times \{y\} \times E_k^-)$ that is $T_u^n \times \mathbb{R}_v^n \times \Delta_{x,y} \times E_k^- \times V^-$.

Let us now try to establish the above inequality without the assumption that we can find $C^-(y)$ such that $\sup F_k(y, C^-(y)) \leq h_k(y) + \varepsilon$ depending continuously on y . Let the subsequence $(h_{k_\nu})_{\nu \geq 1}$ converges to h_∞ . We will see in the next Lemma that we may find a continuous family $C^-(y)$ such that for $k = k_\nu$ and ν large enough, the estimate

$$\sup F_k(y, C^-(y)) \leq h_k(y) + \varepsilon$$

holds for y outside of a subset $U_{2\delta}$ where U_δ is a δ -neighborhood of some grid in $(\mathbb{R}^n)^*$ (see Figure 1), while inside $U_{2\delta}$, $\sup F_k(y, C^-(y)) \leq a$ for some constant a .

The existence of $C^-(y)$ is a consequence of the following general result. We remind the reader that a function F satisfies the Palais-Smale condition if any sequence such that $F(x_n)$ is bounded and $\nabla F(x_n)$ converges to zero has a converging subsequence.

This implies that the flow of $\frac{-\nabla F}{|\nabla F(x)|^2}$ is defined for all time outside a neighborhood of the set of critical points (which is compact) provided our metric is complete. In particular, for generic F (i.e. F Morse and with Morse-Smale gradient flow), classes in $H^*(F^b, F^a)$ are represented by linear combinations of unstable manifolds of critical points (see for example [Laud]). As usual we denote by F^∞ (resp. $F^{-\infty}$) the set $F^c = \{x \mid F(x) \leq c\}$ for c large.

Lemma 7.1. *Let $F(u, x)$ be a smooth function on the product $V \times X$ of two oriented complete Riemannian manifolds. We moreover assume both F and its restriction F_u to a fiber $\{u\} \times X$ satisfy the Palais-Smale condition and for u outside a compact set, F_u does not depend on u .*

Let $f \in C^0(V, \mathbb{R})$ be such that for each $u \in V$, there exists a cycle $C(u)$ representing a class in $H_d(F_u^{+\infty}, F_u^{-\infty})$ with $\sup F(u, C(u)) \leq f(u)$. Moreover we assume that $H_p(F_u^\infty, F_u^{-\infty})$ vanishes for $p \geq d + 1$.

Then for any positive ε and any subset U in V , such that each connected component of $V \setminus U$ has sufficiently small diameter, there exists a cycle \tilde{C} in $H_{d+\dim(V)}(F^\infty, F^{-\infty})$ and a constant a such that if we denote by $\tilde{C}(u)$ the slice $\tilde{C} \cap \pi^{-1}(u)$ ($\pi : V \times X \rightarrow X$ is the second projection)

$$\sup F(u, \tilde{C}(u)) \leq f(u) + a\chi_U(u) + \varepsilon$$

¹¹The general fact that if we have two fibrations, $p_X : X \rightarrow Z, p_Y : Y \rightarrow Z$ and two cycles A, B in X, Y respectively, in general position with respect to p_X, p_Y , then the homology class of $A \times_Z B$ only depends on the homology classes of A and B . This follows from the fact that, denoting $p = (p_X, p_Y) : (X \times Y) \rightarrow Z$, then $A \times_Z B = (A \times B) \cap p^{-1}(\Delta_Z)$, so represents the class $j_!([A \times B])$ where $j : X \times_Z Y \rightarrow X \times Y$ is the inclusion, and $j_!$ the umkehr map. In general we may perturb A, B so that they are in general position, and then the homology class of $A \times_Z B$ does not depend on the choice of perturbations.

where χ_U is the characteristic function of U .

Proof. What we are doing is a constructive version of the Leray spectral sequence $H_*(V, H_*(F_u^{+\infty}, F_u^{-\infty}))$, on the term $H_n(V, H_d(F_u^{+\infty}, F_u^{-\infty}))$, yielding a class in $H_{n+d}(F^{+\infty}, F^{-\infty})$.

Our assumptions imply that the critical values of F_u are contained in some bounded interval (independent from u), $[-a/2, a/2]$. We may assume V is triangulated and U contains a neighborhood of the $(n-1)$ cells ($n = \dim(V)$). In other words $V \setminus U$ is contained in the union of the top dimensional cells. We denote by V^p the p -skeleton of V , and by $W^p(\delta)$ a δ -neighborhood of V^p . Continuity of F implies that if we take $\tilde{C}(u)$ to be constant (i.e. independent from u) in each connected component of $V^n \setminus W^{n-1}(\delta)$, containing a connected component of $V \setminus U$, the inequality will be satisfied there. We need to extend $\tilde{C}(u)$ for all u in V , so that the union of the $\tilde{C}(u)$ makes a singular cycle.

For this we proceed by induction on cells of the skeleton of V of decreasing dimension, so that we are going to extend $\tilde{C}(u)$ for $u \in V \setminus W^p(\delta_p)$ successively for $p = n-1, n-2, \dots, 1, 0$. For the first step, we need to glue the $\tilde{C}(u)$ so that they yield a cycle over the union of n and $n-1$ cells (outside a neighborhood of $(n-2)$ -cells). For this we need to look at what happens on an $n-1$ -dimensional cell, $T_{i,j}$ intersection of the n -cells T_i and T_j where we have *a priori* two conflicting definitions of $\tilde{C}(u)$, that we denote by $\tilde{C}_i(u), \tilde{C}_j(u)$ obtained by taking for $\tilde{C}(u)$ the constant value given on each of the two n -cells, T_i, T_j . Let us write $\tilde{C}_i(u) - \tilde{C}_j(u) = \partial\Gamma_{i,j}(u)$ which is of course possible since $\tilde{C}_i(u)$ and $\tilde{C}_j(u)$ are homologous chains in $H_d(F_u^{+\infty}, F_u^{-\infty})$ on $T_i \cap T_j$. Then we may glue these together to

$$\bigcup_{u \in \tilde{T}_i} \tilde{C}_i(u) \cup \bigcup_{u \in \tilde{T}_j} \tilde{C}_j(u) \cup \bigcup_{u \in \tilde{T}_{i,j}} \Gamma^{i,j}(u)$$

Note that this is indeed a singular chain of dimension $n + \dim(\tilde{C}_i(u))$, since $\dim(T_i) = \dim(T_j) = n$, $\dim(\Gamma^{i,j}) = \dim(\tilde{C}_i(u)) + 1$, $\dim(T_{i,j}) = n-1$. Thus each of the three pieces has dimension $n + \dim(\tilde{C}_i) = n + \dim(\tilde{C}_j)$.

Now of course, the maximum of F over

$$\bigcup_{u \in T_i} \tilde{C}_i(u) \cup \bigcup_{u \in T_j} \tilde{C}_j(u) \cup \bigcup_{u \in T_{i,j}} \Gamma_{i,j}(u)$$

has increased outside $V \setminus U$, but we can always assume that $\Gamma_{i,j} \subset F^a$. If this was not the case, we could push $\Gamma_{i,j}$ down using the gradient of F_u , and since there is no critical value above $a/2$, we can push it below a . As a result we have defined a cycle over the complement of the $(n-2)$ -skeleton, contained in F^a .

Now we look at the next inductive step, that is extending to the $(n-2)$ -skeleton. Consider then for T_α an $(n-2)$ -simplex, that is in the boundary of the T_β for β in some set of $(n-1)$ -simplices. For each β we have a Γ_β obtained in the previous step. We claim that at any point of the $(n-2)$ -simplex T_α we have $\sum_{T_\alpha \in \partial T_\beta} \partial\Gamma_\beta = 0$. Indeed by definition $\partial\Gamma_\beta = \tilde{C}_{i_\beta}(u) - \tilde{C}_{j_\beta}(u)$ where T_β is bounded by T_{i_β} and T_{j_β} , and in the above sum each index will appear twice (of course we need oriented simplices, and the above is correct provided they are oriented in a compatible way: this is made possible by the orientability of V).

Now, we claim that $\sum_{T_\alpha \in \partial T_\beta} \Gamma_\beta$, which is closed by the above argument is in fact a boundary $\partial \Gamma_\alpha$. Indeed, over each fiber, u , this is a $d+2$ -cycle, and the homology of the fiber $H_k(F_u^{+\infty}, F_u^{-\infty})$ vanishes for $k \geq d+2$. Therefore in this dimension, any cycle is a boundary, and we may find Γ_α such that

$$\partial \Gamma_\alpha = \sum_{T_\alpha \in \partial T_\beta} \Gamma_\beta$$

Now Γ_α is contained in F^c and we get

$$\bigcup_{u \in \hat{T}_i} \tilde{C}_i(u) \cup \bigcup_{u \in \hat{T}_j} \tilde{C}_j(u) \cup \bigcup_{u \in \hat{T}_{i,j}} \Gamma_{i,j}(u) \cup \bigcup_{u \in \hat{T}_\alpha} \Gamma_\alpha(u)$$

is a cycle over the $(n-2)$ -skeleton and contained in $H_k(F^a, F^{-\infty})$. We must then iterate this procedure on the $n-3, \dots, 0$ skeleton. \square

We then apply the Lemma to F_k , which clearly satisfies the assumptions with $U = U^\delta$. We then get that $\sup F_k(y, C^-(y)) \leq h_k(y) + a_k \chi^\delta(y) + \varepsilon$ where χ^δ is a smooth function with values in $[0, 1]$, equal to one on U_δ and to zero outside $U_{2\delta}$, a_k is a constant and ε is arbitrarily small.

Now for $\ell \geq 1$ we want an expression¹² for $G_{\ell,k}$, a GFQI of $\varphi_{\ell,k}$, using the explicit formula for $F_{\ell,k}$ obtained as in Lemma 6.7 (or rather ((4)) in Remarks 6.9). We thus get

$$G_{\ell,k}(u, v; \bar{x}, \bar{y}, \bar{\xi}, \eta) = S(x_1 + u, v, \eta) + \frac{1}{\ell} \sum_{j=1}^{\ell} F_k(\ell x_j, y_j, \xi_j) + B_\ell(\bar{x}, \bar{y}) + \langle y_\ell - v, x_1 \rangle$$

and $u \in T^n, v \in \mathbb{R}^n, \bar{x} = (x_1, \dots, x_\ell) \in (\mathbb{R}^n)^\ell, \bar{y} = (y_1, \dots, y_\ell) \in (\mathbb{R}^n)^\ell, \bar{\xi} = (\xi_1, \dots, \xi_\ell) \in (E_k)^\ell, \eta \in V$.

We may now “spread our error terms” $a_k \chi^\delta(y)$ by translating them. More precisely, for j from 1 to ℓ , let us choose domains $U_j^\delta \subset \mathbb{R}^n$ yielding χ_j^δ (with $\text{supp}(\chi_j^\delta) \subset U_j^\delta$), such that¹³the following holds :

- (1) the connected components of $\mathbb{R}^n \setminus U_j^\delta$ have diameter less than δ
- (2) any $(n+1)$ distinct sets U_j^δ have empty intersection.

Such U_j^δ may be constructed by taking for U_j^δ the $\delta/2$ -neighborhood of $S_j = \{(x_1, \dots, x_n) \in \mathbb{R}^n \mid \exists k, x_k \in 2\delta(\mathbb{Z} + r_j)\} = 2\delta(S + r_j(e_1 + \dots + e_n))$, where

- (a) $S = \{(x_1, \dots, x_n) \mid \exists k, x_k \in \mathbb{Z}\}$
- (b) r_1, \dots, r_ℓ are distinct elements of \mathbb{R}/\mathbb{Z} such that $|r_i - r_j| \geq \delta$ for $i \neq j$ (so it is understood that $\delta < \frac{1}{\ell}$)

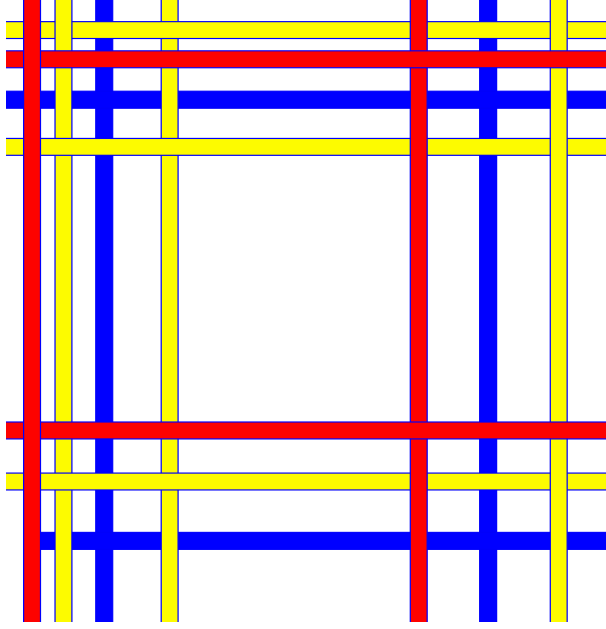


Figure 1: An example of the sets U_1^δ (yellow), U_2^δ (red), U_3^δ (blue) for $n = 2, \ell = 3$ (inspired by P. Mondrian, [Mon]).

We refer to Figure 1 for a representation of the U_j^δ when $n=2, \ell=3$. Clearly we have $S_{j_1} \cap S_{j_2} \cap \dots \cap S_{j_n} \cap S_{j_{n+1}} = \emptyset$ provided $j_i \neq j_k$ for $i \neq k$ and the same holds for their neighborhood: $U_{j_1}^\delta \cap U_{j_2}^\delta \cap \dots \cap U_{j_n}^\delta \cap U_{j_{n+1}}^\delta = \emptyset$

¹²Note that $G_{\ell,k}$ actually depends on the choice of ℓ and k and not just of the product ℓk .

¹³Here we measure distance with the norm $\|x\|_\infty = \sup_{1 \leq j \leq n} |x_j|$, otherwise we get an unpleasant \sqrt{n} factor.

We now have

$$\sup F_k(y, C_j(y)) \leq h_k(y) + a_k \chi_j^\delta(y) + \varepsilon$$

Consider

$$\begin{aligned} \bar{G}_{\ell,k}(u, v; \bar{x}, \bar{y}, \eta) = \\ S(x_1 + u, v; \eta) + \frac{1}{\ell} \sum_{j=1}^{\ell} (h_k(y_j) + a_k \chi_j^\delta(y_j)) + B_\ell(\bar{x}, \bar{y}) + \langle y_\ell - v, x_1 \rangle \end{aligned}$$

Let Γ be a cycle in the homology class of $T_{(u,v)}^n \times \Delta_{x,y} \times V^-$, such that

$$\sup \bar{G}_{\ell,k}(\Gamma) \leq c(\mu, \bar{G}_{\ell,k}) + \varepsilon$$

and let $(\Gamma \times_Y C^-[\ell])$ be defined as

$$\begin{aligned} (\Gamma \times_Y C^-[\ell]) &= \Gamma \times_Y (C_1^- \times \dots \times C_\ell^-) = \\ &= \{(u, v; \bar{x}, \bar{y}, \bar{\xi}, \eta) \mid (u, v, \bar{x}, \bar{y}, \eta) \in \Gamma, (\ell x_j, \xi_j) \in C_j^-(y_j)\} \end{aligned}$$

Now $(\Gamma \times_Y C^-[\ell])$ is in the homology class of $T_u^n \times \mathbb{R}_v^n \times \Delta_{x,y} \times (E_k^-)^\ell \times V^-$ and we may thus infer that

$$c(\mu, \varphi_k \alpha) = c(\mu, G_{\ell,k}) \leq \sup G_{\ell,k}(\Gamma \times_Y C^-[\ell])$$

and $G_{\ell,k}((\Gamma \times_Y C^-[\ell])) \leq \overline{G}_{\ell,k}(\Gamma)$. We may thus conclude that

$$c(\mu, G_{\ell,k}) \leq c(\mu, \overline{G}_{\ell,k}) + 2\varepsilon$$

Our last step will be to prove

Lemma 7.2. *For each k there is a constant A_k such that the following inequality holds for all ℓ :*

$$c(\mu, \overline{G}_{\ell,k}) \leq c(\mu, \overline{G}_k) + \frac{A_k}{\ell}$$

Proof. Indeed $\overline{G}_{\ell,k}$ is the generating function of $\psi_{k,\delta,\ell} \alpha$ where

$$\psi_{k,\delta,\ell} = \rho_\ell^{-1} (\psi_{k,\delta}^1 \circ \cdots \circ \psi_{k,\delta}^\ell) \rho_\ell$$

and $\psi_{k,\delta}^j$ is the time-one flow of $h_k(y) + a_k \chi_j^\delta(y)$.

But since the Hamiltonians $h_k(y) + a_k \chi_j^\delta(y)$ depend only on y , their flows commute, hence $\psi_{k,\delta,\ell}$ is the time-one flow of

$$K_{k,\delta,\ell}(y) = \frac{1}{\ell} \left(\sum_{j=1}^{\ell} h_k(y) + a_k \chi_j^\delta(y) \right)$$

Now since $(n+1)$ sets U_j^δ have empty intersection, we have that

$$\forall y \in \mathbb{R}^n, \quad \left| \sum_{j=1}^{\ell} \chi_j^\delta(y) \right| \leq n$$

hence

$$|K_{k,\delta,\ell}(y) - h_k(y)| \leq \frac{na_k}{\ell}$$

As a result, using the inequality between γ and the C^0 -norm of the Hamiltonian from Proposition 4.10, (1), we get

$$\gamma(\psi_{k,\delta,\ell}, \psi_k) \leq \frac{na_k}{\ell} \stackrel{\text{def}}{=} \frac{A_k}{\ell}$$

where ψ_k is the time-one flow of $h_k(y)$ hence

$$\gamma(\psi_{k,\delta,\ell} \alpha, \psi_k \alpha) \leq \frac{A_k}{\ell}$$

and

$$\begin{aligned} c(\mu, \overline{G}_{\ell,k}) &\leq c(\mu, \psi_{k,\delta,\ell} \alpha) \\ &\leq c(\mu, \psi_k \alpha) + \frac{A_k}{\ell} \\ &\leq c(\mu, \overline{\varphi}_k \alpha) + \frac{A_k}{\ell} \end{aligned}$$

□

Since by assumption, as ν goes to infinity $(\psi_{k_\nu})_{\nu \geq 1}$ γ -converges to $\bar{\varphi}$ we get for $k = k_\nu$

$$\begin{aligned} c(\mu, \varphi_{k_\nu} \alpha) &= c(\mu, G_{\ell, k}) \leq \\ c(\mu, \bar{G}_{\ell, k}) + \varepsilon &\leq c(\mu, \bar{G}_k) + \varepsilon + \frac{A_k}{\ell} \end{aligned}$$

and since this holds for any positive ε we have

$$\leq c(\mu, \bar{\varphi} \alpha) + \frac{A_k}{\ell}$$

Taking ℓ large enough, we see that there is a sequence¹⁴ ℓ_ν

$$\begin{aligned} \lim_{\nu} c(\mu, \varphi_{\ell_\nu \cdot k_\nu} \alpha) \\ \leq c(\mu, \bar{\varphi} \alpha) \end{aligned}$$

as announced. This concludes the proof of Proposition 6.15.

Remark 7.3. It is important to notice that

$$\bar{G}_{\ell, k} = S(x_1 + u, v; \eta) + \frac{1}{\ell} \sum_{j=1}^{\ell} (h_k(y_j) + a_k \chi_j^\delta(y_j)) + B_\ell(\bar{x}, \bar{y}) + \langle y_\ell - v, x_1 \rangle$$

cannot be bounded from above by

$$S(x_1 + u, v; \eta) + \frac{1}{\ell} \sum_{j=1}^{\ell} h_k(y_j) + B_\ell(\bar{x}, \bar{y}) + \langle y_\ell - v, x_1 \rangle + \frac{a_k}{\ell}$$

as it is obvious by choosing (y_1, \dots, y_ℓ) such that each y_j is in U_j^δ . Our proof makes crucial use of the commutation property of the $h_k(y) + a_k \chi_j^\delta(y)$ and would not hold if we replaced $\chi_j^\delta(y)$ by an analogous function $\chi_j^\delta(x, y)$.

8 Proof of proposition 6.16

Let Γ_φ be the graph of φ , where φ in coordinates is $\varphi(x, y) = (X(x, y), Y(x, y))$ and S_φ a GFQI for $\Gamma(\varphi)$

$$\Gamma_\varphi = \{(X(x, y), y, y - Y(x, y), X(x, y) - x) \mid (x, y) \in T^*T^n\}$$

Then the reduction of Γ_φ at $y = y_0$ is

$$(\Gamma_\varphi)_{y_0} = \{(X(x, y_0), y_0 - Y(x, y_0)) \mid x \in T^n\}$$

that is $L_{y_0} - \varphi(L_{y_0})$ where

$$L_{y_0} = \{(x, y_0) \mid x \in T^n\}$$

Note that if S_φ is a GFQI for φ , it is normalized, and this yields a normalization of the GFQI for $L_y - \varphi(L_y)$. This could very well NOT be the normalization expected by the reader (see for example Remark 4.4 (2)).

For example for H integrable, of the form $H(p)$, we have $L_y = \varphi(L_y)$, so $L_y - \varphi_H(L_y) = 0_N$. However the normalization of the generating functions yields $c(\mu, L_y - \varphi_H(L_y)) = H(y)$ and not 0.

Now $c(\alpha_x \otimes 1(y), \varphi) = c(\alpha_x \otimes 1(y), S_\varphi) = c(\alpha, (S_\varphi)_y) = c(\alpha, L_y - \varphi(L_y))$.

¹⁴In fact this holds for any sequence.

Lemma 8.1. *We have*

$$c(\mu_x \otimes 1(y), \varphi_k) = c(\mu, L_y - \varphi_k(L_y)) = -c(1, L_y - \varphi_k^{-1}(L_y)) = -c(1_x \otimes 1(y), \varphi_k^{-1})$$

Proof. Indeed, $c(\mu, L_y - \varphi_k(L_y)) = c(\mu, \varphi_k^{-1}(L_y) - L_y)$ by Hamiltonian invariance¹⁵ of $c(\mu, L_1 - L_2)$. Moreover $c(\mu, \varphi_k^{-1}(L_y) - L_y) = -c(1, L_y - \varphi_k^{-1}(L_y))$ by corollary 2.8 page 693 of [V1]. \square

Denoting by $\hat{h}_k(y)$ the number $c(\mu_x \otimes 1(y), \varphi_k^{-1})$, to prove Proposition 6.16 it is enough to show that $\hat{h}_k(y) = c(\mu_x \otimes 1(y), \varphi_k^{-1}) = -c(1_x \otimes 1(y), \varphi_k)$ differs from $-c(\mu_x \otimes 1(y), \varphi_k) = -h_k(y)$ by a term of the size $O(1/k)$. This is the content of

Proposition 8.2. *We have, uniformly in y , $c(\mu_x \otimes 1(y), \varphi_k) - c(1_x \otimes 1(y), \varphi_k) = O(1/k)$.*

Remarks 8.3. **(1)** Using the proof of Conjecture 1 by Shelukhin (see [She]) we can prove the above Proposition as follows:

$$\begin{aligned} c(\mu_x \otimes 1(y), \varphi_k) - c(1_x \otimes 1(y), \varphi_k) &= \\ c(\mu, L_y - \varphi_k(L_y)) - c(1, L_y - \varphi_k^{-1}(L_y)) &= \\ \gamma(L_y - \varphi_k(L_y)) &= \frac{1}{k} \gamma(L_y - \varphi^k(L_y)) \end{aligned}$$

But the φ^k have a fixed compact support, so the same holds for $L_y - \varphi^k(L_y)$ hence according to the main theorem in [She], $\gamma(L_y - \varphi^k(L_y))$ is bounded independently from k , and we conclude that $\lim_k \frac{1}{k} \gamma(L_y - \varphi^k(L_y)) = 0$.

(2) Indeed the proposition implies

$$\begin{aligned} \hat{h}_k(y) = c(\mu_x \otimes 1(y), \varphi_k^{-1}) &= -c(1_x \otimes 1(y), \varphi_k) = \\ -c(\mu_x \otimes 1(y), \varphi_k) + O(1/k) &= -h_k(y) + O(1/k) \end{aligned}$$

Since by definition $c(\alpha, \varphi_k) = c(\alpha, F_k)$ we have to prove that $c(\mu_x \otimes 1(y), F_k) - c(1_x \otimes 1(y), F_k) = O(1/k)$. According to Proposition B.3, if f is defined on an n -dimensional orientable manifold, and $\alpha \in H^q(f^b, f^a)$ then

$$c(\alpha, f) = \sup\{c(u, f) \mid u \in H_q(f^b, f^a), \langle \alpha, u \rangle \neq 0\}$$

As a result, we may in the sequel replace cohomology classes by homology classes using this property.

Proof of Proposition 8.2. First of all, let u be a homology class in $H_d(T^n)$ represented by a map $A : X \rightarrow T^n$ and $v \in H_1(T^n)$ be represented by a loop $B : S^1 \rightarrow T^n$. Denote by $u \cdot v$ the class represented by $C : (\theta, x) \rightarrow B(\theta) \cdot A(x)$. Here $x \cdot y$ is the product in the group T^n and $u \cdot b \in H_{k+1}(T^n)$ is then well defined, i.e. does not depend on the choice of the representatives of u and v : this is the Pontryagin product of u and v . Moreover it is easy to see that if v_1, \dots, v_n form a basis of $H_1(T^n)$, then $v_1 \cdot v_2 \cdot \dots \cdot v_n$ is a nonzero multiple of the fundamental class¹⁶, μ . Since we must compare $c(1_x \otimes 1(y), F_k)$ and $c(\mu_x \otimes 1(y), F_k)$, our proposition will follow from

¹⁵that is $c(\alpha, L_1 - L_2) = c(\alpha, \varphi(L_1) - \varphi(L_2))$ for φ a Hamiltonian map. The proof is the same as in [V1] page 695, proof of Proposition 3.5.

¹⁶by abuse of language, we denote by μ both the fundamental homology class and the fundamental cohomology class. This should cause no confusion.

Proposition 8.4. *Let $A : V \rightarrow T_x^n \times \mathbb{R}^n \times E_k$ representing the class $u \times [\{y\} \times E_k^-] \in H_{d+n(k-1)}(F_{k,y}^c, F_{k,y}^{-\infty})$, and $v \in H_1(T^n)$. Then there exists $C' : S^1 \times V \rightarrow T^n \times \mathbb{R}^n \times E_k$ representing $u \cdot v \times [\{y\} \times E_k^-] \in H_{d+1+n(k-1)}(F_{k,y}^{c'}, F_{k,y}^{-\infty})$ where*

$$c' \leq c + O(1/k)$$

Proof. In the proof we shall assume v is represented by the loop $s \mapsto s\nu$ where $\nu \in \mathbb{Z}^n$. All degree one classes on the torus can be represented in such a way. The first step will be to modify C to a cycle \tilde{C} in the same homology class. We denote by K a number such that

$$K > \max \left\{ \sup_{(q,p) \in T^*T^n} |S(q,p)|, \sup_{(q,p) \in T^*T^n} |dS(q,p)| \right\}$$

where S is the generating function for φ as in Subsection 6.1. We first show that relative cycles in sublevel sets can be deformed to “standard form”.

Lemma 8.5. *There exists a cycle \tilde{C} homologous to C in $H_d(F_{k,y}^c, F_{k,y}^{-\infty})$ and a constant M such that we have*

$$(i) \quad \tilde{C} \subset \left(\{(q,p) \mid \max_j |p_j| \leq M\} \cup F_{k,y}^{-4K} \right) \cap F_{k,y}^c$$

$$(ii) \quad \tilde{C} \cap F_{k,y}^{-3K} \subset T^n \times \{y\} \times E_k^-$$

Proof. Let us choose M so that S has support in the set $|p| \leq M/2$. We are going to deform C by first using the vector field Z , associated to the differential equation

$$\dot{q}_j = -\chi(|p_j|)(p_j - p_{j-1}) = X_j(q,p), \quad \dot{p}_j = 0 \text{ for } 1 \leq j \leq k$$

where $\chi(|p_j|)$ vanishes for $|p_j| \leq M/2$. Note that $y = p_k$ is preserved. As a result if ψ^t is the flow of Z , we have

$$\begin{aligned} \frac{d}{dt} F_{k,y}(\psi^t(q,p))|_{t=0} &= \langle dF_{k,y}(q,p), Z(q,p) \rangle = \left\langle \frac{\partial}{\partial q} F_{k,y}(q,p), X(q,p) \right\rangle = \\ &= - \sum_{j=1}^k \chi(|p_j|) \left\langle \frac{\partial}{\partial q_j} F_{k,y}(q,p), (p_j - p_{j-1}) \right\rangle = \\ &= \sum_j \chi(|p_j|) \left(-|p_j - p_{j-1}|^2 + \left\langle \frac{\partial S}{\partial q_j}(k \cdot q_j, p_j), (p_j - p_{j-1}) \right\rangle \right) = \\ &= - \sum_j \chi(|p_j|) |p_j - p_{j-1}|^2 \end{aligned}$$

since S vanishes on the support of $\chi(|p|)$. Note that the p_j are integrals of the flow of Z , that $F_{k,y}$ is decreasing along the flow of Z and that since $p_k = y$ is fixed, if $\max_j |p_j| \geq M$, for M large enough with respect¹⁷ to y , the quantity $\sum_j \chi(|p_j|) |p_j - p_{j-1}|^2$ is bounded from below by some constant $m_k > 0$ (note that $m_k = O(1/k)$, but we don't care). Thus outside the region $\{\max_j |p_j| \leq M\}$, Z is a pseudo-gradient for $F_{k,y}$, and since the flow is complete (it is bounded by a linear quantity), it satisfies the following properties

¹⁷This is where the proof would fail if we did not fix y , and wanted to prove the incorrect statement $\frac{1}{k} \gamma(\varphi^k) \rightarrow 0$.

(1) Setting $\psi^t(q, p) = (Q, P)$ we have $p = P$.

(2) For $(q, p) \notin \{(q, p) \mid \max_j |p_j| \leq M\}$ we have $F_{k,y}(\psi^t(q, p)) \leq F_{k,y}(q, p) - m_k t$

As a result, if $(q, p) \in F_{k,y}^c$ we have

$$\psi^{\frac{c+4K}{m_k}}(q, p) \in \left(\left\{ \max_j |p_j| \leq M \right\} \cup F_{k,y}^{-4K} \right) \cap F_{k,y}^c$$

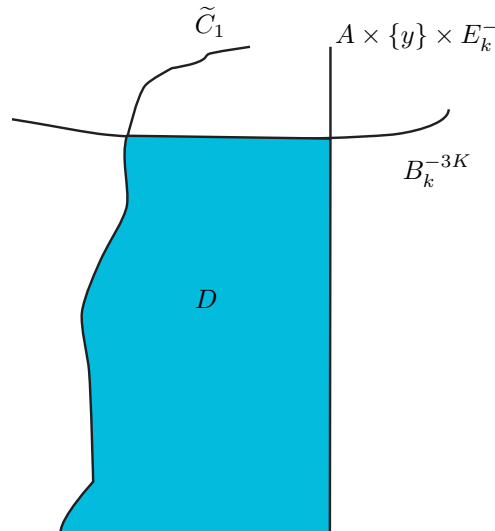


Figure 2: On the left: The cycles \tilde{C}_1 , $A \times \{y\} \times E_k^-$ and bounding cycle D

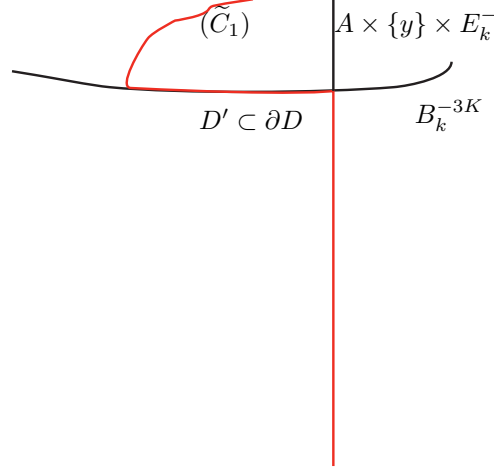


Figure 3: The cycle \tilde{C}

(see Figure 2 and 3).

We thus obtained a cycle $\tilde{C}_1 = \psi^{\frac{c+4K}{m_k}}(C)$ satisfying (i). We now deform \tilde{C}_1 to \tilde{C} as follows. Since $\|F_{k,y} - B_k\| \leq K$ we have $-K \leq c \leq K$, and the inclusions

$$F_{k,y}^{-4K} \subset B_k^{-3K} \subset F_{k,y}^{-2K} \subset B_k^{-K}$$

Thus $\tilde{C}_1 \in H_d(F_{k,y}^{+\infty}, F_{k,y}^{-\infty}) = H_d(B_k^{+\infty}, B_k^{-\infty})$ and $B_k^{-\infty} \simeq B_k^{-K}$, and $[\tilde{C}_1] = [A \times \{y\} \times E_k^-]$ in $H_d(B_k^{+\infty}, B_k^{-\infty})$ for some cycle A representing the class a .

This means there is a cycle D such that $\partial D = \tilde{C}_1 - (A \times \{y\} \times E_k^-)$, so $\partial(D \cap B_k^{-3K}) = \tilde{C}_1 \cap B_k^{-3K} - ((A \times \{y\} \times E_k^-) \cap B_k^{-3K}) + D \cap \{B_k = -3K\}$.

Thus in B_k^{-3K} we may replace \tilde{C}_1 by the homologous cycle $A \times \{y\} \times E_k^- \cap B_k^{-3K} - D'$ where $D' \subset \{B_k = -3K\}$. But then $D' \cap F_{k,y}^{-4K} = \emptyset$ so

$$((A \times \{y\} \times E_k^-) \cap B_k^{-3K}) \cup D' \cap F_{k,y}^{-4K} = (A \times \{y\} \times E_k^-) \cap B_k^{-3K} \cap F_{k,y}^{-4K}$$

Then the cycle

$$\tilde{C} = (\tilde{C}_1 \cap \{B_k \geq -3K\}) \cup D' \cup ((A \times \{y\} \times E_k^-) \cap B_k^{-3K})$$

is homologous to \tilde{C}_1 .

Now, since

$$\begin{aligned} \sup\{F_{k,y}(q,p) \mid (q,p) \in D' \cup ((A \times \{y\} \times E_k^-) \cap B_k^{-3K})\} \leq \\ \sup\{F_{k,y}(q,p) \mid B_k(q,p) \leq -3K\} \leq -2K \end{aligned}$$

we may conclude that $\sup\{F_{k,y}(q,p) \mid (q,p) \in \tilde{C}\}$ is bounded by the maximum of $\{\sup\{F_{k,y}(q,p) \mid (q,p) \in \tilde{C}_1\}$ and $\sup\{F_{k,y}(q,p) \mid (q,p) \in D' \cup (A \times \{y\} \times E_k^-) \cap B_k^{-3K}\}\}$, that is by $\max\{c, -2K\} = c$. Finally \tilde{C} satisfies both (i), (ii). \square

Now that we have a cycle in “standard position” we are going to construct a representative of $[C] \cdot v$. Remember that v is represented by $s \mapsto s \cdot \nu$ for $\nu \in \mathbb{Z}^n$. We set

$$\tau_j^s(q_1, \dots, q_k, p_1, \dots, p_k) = (q_1, \dots, q_{j-1}, q_j + s\nu, q_{j+1}, \dots, q_k, p_1, \dots, p_k)$$

and $\tau^{(s_1, \dots, s_k)} = \tau_k^{s_k} \circ \dots \circ \tau_1^{s_1}$ and $\tau^s = \tau^{(s, s, \dots, s)}$.

Then $C'_1 = \bigcup_{s \in [0,1]} \tau^s(\tilde{C})$ is a cycle representing $u \cdot v \times \{y\} \times E_k^-$. More generally for any continuous path $\sigma : [0, 1] \rightarrow [0, 1]^k$, such that $\sigma(0) = (0, \dots, 0)$ and $\sigma(1) = (1, \dots, 1)$ we have, since all such paths are homotopic, that $C' = \bigcup_{s \in [0,1]} \tau^{\sigma(s)}(\tilde{C})$ is homologous to C'_1 .

Moreover define the paths $\sigma_k(s) = (1/k, \dots, 1/k, s - j/k, 0, 0, \dots, 0)$ for $s \in [j/k, (j+1)/k]$ where there are j components equal to $1/k$. Thus σ_k joins $(0, \dots, 0)$ to $(1/k, \dots, 1/k)$. Now set

$$\sigma(s) = (l/k, \dots, l/k) + \sigma_k(k \cdot s - l)$$

for $s \in [l/k, (l+1)/k]$ for $0 \leq l \leq k-1$. Then σ connects $(0, \dots, 0)$ to $(1, \dots, 1)$.

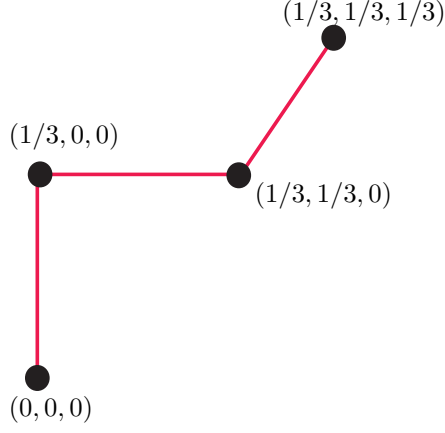


Figure 4: The path $\sigma_3 : [0, 1] \longrightarrow [0, 1]^3$

Now we claim $F_{k,y}(\tau^{1/k}(q, p)) = F_{k,y}(q, p)$. This follows clearly from the fact that $q_j \mapsto S(q_j, p_j)$ is \mathbb{Z}^n -periodic and the formula

$$F_{k,y}(q, p) = \frac{1}{k} \sum_{j=1}^k S(k \cdot q_j, p_j) + B_k(q, p)$$

where

$$B_k(q, p) = \sum_{j=1}^{k-1} \langle p_j, q_j - q_{j+1} \rangle + \langle p_k, q_k - q_1 \rangle$$

Since

- (1) σ sends $[0, 1]$ in $[0, 1]^k$ with $\sigma(0) = (0, \dots, 0)$ and $\sigma(1) = (1, \dots, 1)$.
- (2) $\sigma(l/k) = (l/k, \dots, l/k)$

and $\tau^{l/k}(\tilde{C})$ still satisfies properties (i) and (ii) from Lemma 8.5, it is enough to prove, using $F_{k,y} \circ \tau^{1/k} = F_{k,y}$, that for any such \tilde{C} , we have

$$\bigcup_{s \in [0, 1/k]} \tau^{\sigma(s)}(\tilde{C}) = \bigcup_{s \in [0, 1]} \tau^{\sigma_k(s)}(\tilde{C}) \subset F_{k,y}^{c'}$$

with $c' \leq c + O(1/k)$.

Lemma 8.6. *We have*

(1)

$$F_{k,y}(\tau_j^s(q, p)) = F_{k,y}(q, p) + \frac{1}{k} (S(kq_j + ks\nu, p_j) - S(kq_j, p_j)) + s \langle p_j - p_{j-1}, \nu \rangle$$

(2)

$$F_{k,y}(\tau_{j-1}^{1/k} \circ \dots \circ \tau_1^{1/k}(q, p)) = F_{k,y}(q, p) + \frac{1}{k} \langle p_{j-1} - p_1, \nu \rangle$$

(3)

$$F_{k,y}(\tau_j^s \circ \tau_{j-1}^{1/k} \circ \dots \circ \tau_1^{1/k}(q, p)) \leq F_{k,y}(q, p) + \frac{K}{k} + \frac{|\nu|}{k} (|p_j - p_{j-1}| + |p_{j-1} - p_1|)$$

Proof. Assertion (1) is checked immediately. Then (2) follows at once from the fact that $S(q_j + \nu, p_j) = S(q_j, p_j)$. Finally (3) follows immediately from (2) and (1). \square

Now for $(q, p) \in \tilde{C}$ satisfying properties (i) and (ii) of Lemma 8.5, since $\tau_k(s)$ is of the form $\tau_j^t \circ \tau_{j-1}^{1/k} \circ \dots \circ \tau_1^{1/k}$ for $0 \leq t \leq 1/k$, we have

(1) If $(q, p) \in \{\max_j |p_j| \leq M\}$ we have, using (3) of Lemma 8.6

$$F_{k,y}(\tau^{\sigma_k(s)}(q, p)) \leq F_{k,y}(q, p) + \frac{K + 4M|\nu|}{k} \leq c + O(1/k)$$

(2) If $(q, p) \in F_{k,y}^{-4K}$ and $(q, p) \in T^n \times \{y\} \times E_k^-$ we have $p_j = -(q_j - q_{j-1})$ hence $F_{k,y}(q, p) = -\sum_j p_j^2 + \frac{1}{k} \sum_j S(kq_j, p_j)$ thus using (3) of Lemma 8.6 we have

$$\begin{aligned} F_{k,y}(\tau^{\sigma_k(s)}(q, p)) &\leq -\sum_j p_j^2 + \frac{1}{k} \sum_j S(kq_j, p_j) + \\ &\frac{|\nu|}{k} (|p_j - p_{j-1}| + |p_{j-1} - p_1|) \leq \\ &-\sum_j p_j^2 + \frac{|\nu|}{k} (|p_j| + 2|p_{j-1}| + |p_1|) + K \end{aligned}$$

In the path $\sigma_k(s)$ only the k -th variable varies from 0 to $1/k$. But since $-3K \geq F_{k,y}(q, p) \geq B_k(q, p) - K$ we get $B_k(q, p) \leq -2K$ so $\sum_j p_j^2 \geq 2K$ and using standard inequalities

$$\sum_j p_j^2 - \frac{|\nu|}{k} (|p_j| + 2|p_{j-1}| + |p_1|) - K \geq M - \frac{\sqrt{6M}|\nu|}{k} - K \geq K$$

for M large enough. And this implies

$$F_{k,y}(\tau^{\sigma_k(s)}(q, p)) \leq -K + O(1/k) \leq c + O(1/k)$$

We thus proved that for any $(q, p) \in \tilde{C}$ and $s \in [0, 1]$, we have

$$F_{k,y}(\tau^{\sigma_k(s)}(q, p)) \leq c' = c + O(1/k)$$

Since the map from $S^1 \times \tilde{C} \rightarrow F_{k,y}^{c'}$ given by $(s, q, p) \mapsto \tau^{\sigma_k(s)}$ represents $[\tilde{C}] \cdot \nu$, this concludes our proof and the proof of proposition 6.16. \square

\square

Remarks 8.7. (1) The above method of proof, in the case of variational problems for closed geodesics, is related to the “passing the obstacles one at the time” that can be found in the paper by [Ban] page 87, as well as to Gromov’s book [Gr] sections 2.26 and 2.27. I wish to thank V. Bangert for the reference.

- (2) Since $\varphi_k = \rho_k^{-1} \varphi^k \rho_k$, and we proved $\gamma(\varphi_k(L_y) - L_y)$ converges to zero, so for $y = 0$, we get $\frac{1}{k} \gamma(\varphi^k(0_{T^n}))$ converges to zero. This is much weaker than Conjecture 1.

9 Proof of Theorem 5.1

We are now going to prove Theorem 5.1 in the autonomous case. The general case could be proved along the same lines, but we shall show in Subsection 13.2, how to deduce it formally from the time-independent case.

Thus far we showed that some subsequence of $(\varphi_k^t)_{k \geq 1}$, γ -converges to $\bar{\varphi}_\infty^t$ and in Proposition 6.12 that this implies the convergence of the sequence itself to $\bar{\varphi}_\infty^t$. Remember that according to Corollary 6.17 the γ -convergence of φ_k^t to $\bar{\varphi}_\infty^t$ is uniform in t on compact sets. In other words the sequence of functions $t \mapsto \gamma(\varphi_k^t \bar{\varphi}^{-t})$ converges uniformly on compact sets to 0 and thus the sequence $H(kq, p)$ converges to $\bar{H} = \mathcal{A}(H)$ for the γ -metric (remember that \bar{H} is continuous, so belongs to $\widehat{\mathfrak{Ham}}_c(T^*T^n)$, the γ -completion of $C_c^\infty([0, 1] \times T^*T^n)$). Clearly $\bar{H}(q, p) = h_\infty(p)$ defined in the previous subsection (Proposition 6.14), satisfies the first statement of the Main Theorem.

End of the proof of theorem 5.1 (for time independent Hamiltonians). Here assertion (2) follows from the fact that $\bar{\varphi}_\infty^1$ determines \bar{H} (see Appendix A, Corollary A.2), and that

$$\bar{\varphi}_\infty^1 = \lim_{k \rightarrow \infty} \rho_k^{-1} \varphi^k \rho_k$$

which only depends on $\varphi = \varphi^1$.

We finally prove assertion (3). Given two compactly supported Hamiltonians H_1, H_2 , with φ_1, φ_2 the time-one maps of their flows setting $h_{k,i}(p) = c(\mu_x \otimes 1(y), \rho_k^{-1} \varphi_i^k \rho_k)$

$$\begin{aligned} |h_{k,1}(y) - h_{k,2}(y)| &\leq |c(\mu_x \otimes 1(y), \rho_k^{-1} \varphi_1^k \rho_k) - c(\mu_x \otimes 1(y), \rho_k^{-1} \varphi_2^k \rho_k)| \leq \\ \gamma((\rho_k^{-1} \varphi_1^k \rho_k)^{-1} \circ \rho_k^{-1} \varphi_2^k \rho_k) &\leq \gamma(\rho_k^{-1} \varphi_1^{-k} \varphi_2^k \rho_k) \leq \frac{1}{k} \gamma(\varphi_1^{-k} \varphi_2^k) \leq \gamma(\varphi_1^{-1} \varphi_2) \end{aligned}$$

the last inequality follows from Equation (6.1) in Lemma 6.13. Therefore the map $\mathcal{A} : \widehat{\mathfrak{Ham}}(T^*T^n) \rightarrow C^0(\mathbb{R}^n, \mathbb{R})$ is 1-Lipschitz for the norms γ and C^0 respectively. It thus extends to a Lipschitz map from $\widehat{\mathfrak{Ham}}(T^*T^n)$ to $C^0(\mathbb{R}^n, \mathbb{R})$.

Since if H only depends on p , we have $\bar{H} = H$, we get that \mathcal{A} is a projector. Finally, if C is the supremum of $|\frac{\partial H}{\partial p}(q, p)|$ on T^*T^n , the functions h_k defined in Lemma 6.11 are C -Lipschitz, hence their uniform limit is also C -Lipschitz. This settles the last claim of the theorem and concludes our proof of theorem 5.1 for the time-independent case. \square

10 Proof of theorem 5.2

We assume again H to be time-independent. In order to prove (1) of theorem 5.2, we need to prove that if $H_1 \leq H_2$ then $h_{\infty,1} \leq h_{\infty,2}$. This would follow immediately from the fact that we may choose S_1, S_2 such that¹⁸ $S_1(q, p) \leq S_2(q, p)$ hence, $F_{k,1} \leq F_{k,2}$ and therefore

$$h_{k,1}(y) = c(\mu \otimes 1(y), F_{k,1}) \leq c(\mu \otimes 1(y), F_{k,2}) = h_{k,2}(y)$$

As a result, $h_{\infty,1}(y) \leq h_{\infty,2}(y)$.

However there is the following more general and simpler proof, assuming only¹⁹ that $H_1 \preceq H_2$ so that $\varphi_1^1 \preceq \varphi_2^1$ and

$$\rho_k^{-1} \varphi_1^1 \rho_k \preceq \rho_k^{-1} \varphi_2^1 \rho_k$$

then by going to the limit, $\bar{\varphi}_1 \preceq \bar{\varphi}_2$. Now $\bar{\varphi}_1$ and $\bar{\varphi}_2$ are the flows of \bar{H}_1 and \bar{H}_2 which depend only on p . Therefore, according to Appendix A, Corollary A.2, they commute, and our assertion follows from the

Lemma 10.1. *If φ^1 , the time-one flow of the compactly supported integrable Hamiltonian $H(p)$, satisfies $\text{Id} \preceq \varphi^1$ then H is non-negative.*

Proof. Remember that $\text{Id} \preceq \varphi$ means $c_-(\varphi) = 0$. In Appendix A, Proposition A.1, we prove that $c_-(\varphi^1) = \inf_{p \in \mathbb{R}^n} H(p)$. Therefore if $c_-(\varphi^1)$ vanishes, H must be non-negative. \square

To prove (2), we have to compare $\mathcal{A}(H \circ \psi)$ to $\mathcal{A}(H)$. Note that the flow associated to $H \circ \psi$ is $\psi^{-1} \circ \varphi^t \circ \psi$. Thus $\mathcal{A}(H \circ \psi)$ is associated to the γ -limit of

$$\rho_k^{-1} \psi^{-1} \varphi^k \psi \rho_k = (\rho_k^{-1} \psi^{-1} \rho_k) (\rho_k^{-1} \varphi^k \rho_k) (\rho_k^{-1} \psi \rho_k)$$

But $\lim_{k \rightarrow \infty} \gamma(\rho_k^{-1} \psi^{-1} \rho_k) = 0$, that is $\rho_k^{-1} \circ \psi^{-1} \circ \rho_k$ γ -converges to Id . Hence

$$\lim_{k \rightarrow \infty} \rho_k^{-1} \psi^{-1} \varphi^k \psi \rho_k = \lim_{k \rightarrow \infty} \rho_k^{-1} \varphi^k \rho_k^{-1}$$

For property (3), we start with the case $c > 0$. First if c is a positive integer, $\lim_{k \rightarrow \infty} \rho_k^{-1} \varphi^{ck} \rho_k = \lim_{k \rightarrow \infty} (\rho_k^{-1} \varphi^k \rho_k)^c$ and it thus γ -converges to $(\bar{\varphi})^c$, that is the flow of $c\bar{H}$. If c is positive and of the form $1/q$

$$\lim_{k \rightarrow \infty} \rho_k^{-1} \varphi^{k/q} \rho_k = \lim_{\ell \rightarrow \infty} \rho_{q\ell}^{-1} \varphi^\ell \rho_{q\ell} = \rho_q^{-1} \left(\lim_{\ell \rightarrow \infty} \rho_\ell^{-1} \varphi^\ell \rho_\ell \right) \rho_q = \rho_q^{-1} \bar{\varphi} \rho_q$$

and this is the flow of $\frac{1}{q}\bar{H}$. Finally, we have to compare $\lim_{k \rightarrow \infty} \rho_k^{-1} \varphi^k \rho_k$ and $\lim_{k \rightarrow \infty} \rho_k^{-1} \varphi^{-k} \rho_k$. Clearly, since the limits exist, they must be inverses of each other, that is they are given by $\bar{\varphi}_\infty$ and $(\bar{\varphi}_\infty)^{-1}$. Now it follows from [Hu] or (since we are in the situation of Hamiltonians depending on p) from Appendix A corollary A.2 that two integrable autonomous continuous compactly supported Hamiltonians H, K in $\widehat{\mathfrak{Ham}}_c$, such that their flows satisfy $\varphi\psi = \text{Id}$ in $\widehat{\text{Ham}}_c(T^*T^n)$, must satisfy $H = -K$.

¹⁸This is automatically the case if S_j is a finite dimensional reduction of the action functional, as described in [Ch2] or [Lau-Sik].

¹⁹Remember that $\varphi_1 \preceq \varphi_2$ means $c_-(\varphi_2 \varphi_1^{-1}) = 0$, see Remark 5.3.

We now prove property (4). We limit ourselves to the case where U is closed and bounded. Let us consider a decreasing sequence of non-negative smooth functions $(H_\nu)_{\nu \geq 1}$ such that $\bigcap_{\nu} \text{supp}(H_\nu) = U$, and $\lim_{\nu} H_\nu = \chi_U$, where χ_U is the characteristic function of U , the limit being here a pointwise limit. Then \overline{H}_ν is also a decreasing sequence of non-negative continuous functions, and therefore has a limit \overline{H}_∞ , and we denote by $\mathcal{A}(U)$ the support of \overline{H}_∞ . Since for any other sequence $(K_\nu)_{\nu \geq 1}$ decreasing to χ_U , we may find, for each ν , a μ such that $K_\mu \leq H_\nu$, we have $\overline{K}_\infty \leq \overline{H}_\infty$. By symmetry, we get $\overline{K}_\infty = \overline{H}_\infty$ hence the support of \overline{K}_∞ coincides with the support of \overline{H}_∞ . This support defines $\mathcal{A}(U)$. For U bounded but not closed we may set $\mathcal{A}(U) = \mathcal{A}(\overline{U})$. In the general case, we set $\mathcal{A}(U) = \mathcal{A}(\overline{U}) = \lim_{V \text{ bounded in } \overline{U}} \mathcal{A}(V)$. Assume now L is a Lagrangian submanifold Hamiltonian isotopic to L_{y_0} . By the Hamiltonian invariance we just proved, $\mathcal{A}(L) = \mathcal{A}(L_{y_0})$. Now it is easy to show that

$$\mathcal{A}(L_{y_0}) = \{y_0\}$$

Since $\text{shape}(U)$ contains p if and only if U contains a Lagrangian L , Hamiltonian isotopic to L_p , we get that for $p \in \text{shape}(U)$, we must have $p \in \mathcal{A}(U)$. This concludes the proof of (4).

As for property (5), it is an easy consequence of the above. Indeed, assume first $H(L) \geq h$ where L is Hamiltonian isotopic to L_{p_0} . Let κ_{p_0} be a function on $(\mathbb{R})^n$ equal to 1 near p_0 , very negative in a neighborhood of the p -projection of the support of H , and compactly supported. Then if $\psi(L_{p_0}) = L$, we have

$$H \geq h \cdot (\kappa_{p_0} \circ \psi)$$

hence

$$\overline{H} \geq h \cdot \overline{(\kappa_{p_0} \circ \psi)} = h \cdot \overline{\kappa}_{p_0} = h \cdot \kappa_{p_0}$$

As a result,

$$\overline{H}(p_0) \geq h \kappa_{p_0}(p_0) = h$$

Changing H to $-H$, and using (3) we get the second statement.

Property (6) follows from the fact that $c_\pm(\rho_k^{-1} \varphi^k \rho_k) = \frac{1}{k} c_\pm(\varphi^k)$, the fact that c_\pm are continuous for the γ -topology and Proposition A.1.

For (7), since \mathcal{A} is only defined for compactly supported functions, this means that for any sequence $(H_n)_{n \geq 1}$ of compactly supported functions such that $\lim_n H_n = 1$, where the limit is uniform on any compact set, we have $\lim_n \mathcal{A}(H_n) = 1$

Let us define K to be a smooth non-negative compact supported function equal to 1 on $[-1, 1]$ and set $K_R(p) = K(\frac{|p|}{R})$.

Let $(H_n)_{n \geq 1}$ be a sequence of compactly supported functions converging uniformly on compact sets to 1, with the extra requirement that there exist sequences $(R_n)_{n \geq 1}, (R'_n)_{n \geq 1}, (\varepsilon_n)_{n \geq 1}$ such that $\lim_n R_n = \lim_n R'_n = +\infty$, $\lim_n \varepsilon_n = 0$ and

$$K_{R_n} - \varepsilon_n K_{R'_n} \leq H_n \leq K_{R_n} + \varepsilon_n K_{R'_n}$$

Since K_R only depends on p we have that $K_R, K_{R'}$ commute and $\mathcal{A}(K_R) = K_R$. This implies that

$$\lim_n (K_{R_n} - \varepsilon_n K_{R'_n}) \leq \lim_n \mathcal{A}(H_n) \leq \lim_n (K_{R_n} + \varepsilon_n K_{R'_n})$$

Since $\lim_n K_{R_n} = 1$ this implies that $\lim_n \mathcal{A}(H_n) = 1$.

Finally, to show that $\zeta : H \mapsto \int \mathcal{A}(H)d\mu(p)$ is a quasi-state, it is enough to deal with the case where μ is a Dirac mass at p . We must then prove

- (1) (Monotonicity) $H_1 \leq H_2$ implies $\overline{H}_1 \leq \overline{H}_2$. This follows from (1) of theorem 5.2
- (2) (Quasi-linearity) If H, K Poisson commute, then $\overline{(H + K)}(p) = \overline{H}(p) + \overline{K}(p)$. this follows from the fact that if H, K commute, with respective flows φ^t, ψ^t , then $H + K$ has flow $\psi^t \varphi^t$ and then $\mathcal{A}(H + K)$ corresponds to

$$\lim_{k \rightarrow \infty} \rho_k^{-1} \varphi^{kt} \psi^{kt} \rho_k^{-1} = \lim_{k \rightarrow \infty} (\rho_k^{-1} \varphi^{kt} \rho_k) \lim_{k \rightarrow \infty} (\rho_k^{-1} \psi^{kt} \rho_k) = \overline{\varphi}^t \circ \overline{\psi}^t$$

and this corresponds to $\mathcal{A}(H)(p) + \mathcal{A}(K)(p)$ according to Corollary A.2 of Appendix A

This concludes the proof of theorem 5.2 in the time independent case.

11 Proof of Theorem 5.5, the partial homogenization case

We consider the case of the sequence defined by $H_k(x, y, q, p) = H(kx, y, q, p)$ and prove that it γ -converges to $\overline{H}(y, q, p)$ obtained by performing the above homogenization, on the variables (x, y) and freezing the (q, p) variables.

The flow Ψ_k^t of $H(kx, y, q, p)$ is given by

$$\left\{ \begin{array}{l} \dot{x} = \frac{\partial}{\partial y} H(k \cdot x, y, q, p) \\ \dot{y} = -k \frac{\partial}{\partial x} H(k \cdot x, y, q, p) \\ \dot{q} = \frac{\partial}{\partial p} H(k \cdot x, y, q, p) \\ \dot{p} = -\frac{\partial}{\partial q} H(k \cdot x, y, q, p) \end{array} \right.$$

Set

$$x_k(t) = k \cdot x\left(\frac{t}{k}\right), y_k(t) = y\left(\frac{t}{k}\right), q_k(t) = q\left(\frac{t}{k}\right), p_k(t) = p\left(\frac{t}{k}\right)$$

We shall consider the flow φ_k^t associated to the Hamiltonian equations:

$$\left\{ \begin{array}{l} \dot{x}_k = \frac{\partial}{\partial y} H(x_k, y_k, q_k, p_k) \\ \dot{y}_k = -\frac{\partial}{\partial x} H(x_k, y_k, q_k, p_k) \\ \dot{q}_k = \frac{1}{k} \frac{\partial}{\partial p} H(x_k, y_k, q_k, p_k) \\ \dot{p}_k = -\frac{1}{k} \frac{\partial}{\partial q} H(x_k, y_k, q_k, p_k) \end{array} \right.$$

Then the flow Ψ_k^t is given by $\rho_k^{-1} \varphi_k^{kt} \rho_k$ where

$$\rho_k(x, y, q, p) = (k \cdot x, y, q, p)$$

Let $S_k(x, y, q, p, \xi)$ be a generating function for the flow above. The candidate for the homogenization is again given by $\lim_{k \rightarrow \infty} \bar{H}_k$ where

$$\bar{H}_k(y, q, p) = c(\mu_x \otimes 1(y) \otimes 1(q, p), S_k)$$

is obtained by freezing the (q, p) variables and performing homogenization on the (x, y) variables as in the previous section. The precompactness of the sequence is proved as in proposition 6.10, and the same holds for the uniqueness of the limit as in Proposition 6.12. Let us reformulate the problem by considering the symplectic form σ_k on T^*T^{m+n} given by $\sigma_k = dy \wedge dx + kdp \wedge dq$. For a Hamiltonian $H(x, y, q, p)$ its flow for σ_k is defined by the equations

$$\begin{cases} \dot{x} = \frac{\partial H}{\partial y}(x, y, q, p), & \dot{y} = -\frac{\partial H}{\partial x}(x, y, q, p) \\ \dot{q} = \frac{1}{k} \frac{\partial H}{\partial P}(x, y, q, p), & \dot{p} = \frac{-1}{k} \frac{\partial H}{\partial q}(x, y, q, p) \end{cases}$$

Note that φ_k^t is the flow associated to H for the symplectic form σ_k . We thus have

Lemma 11.1. *The flow Ψ_k^t of $H_k(x, y, q, p) = H(kx, y, q, p)$ is given by*

$$\Psi_k^t = \rho_k^{-1} \varphi_k^t \rho_k$$

where $\rho_k(x, y, q, p) = (kx, y, q, p)$ and φ_k^t is the flow of $H(x, y, q, p)$ for the symplectic form

$$\sigma_k = dy \wedge dx + kdp \wedge dq$$

Now to the above Hamiltonian map C^1 -close to the identity, we may associate the function $S(x, Y, q, P)$ on $T^*(T^{n+m})$ given by

$$\begin{cases} X - x = \frac{\partial S}{\partial Y}(x, Y, q, P), & y - Y = \frac{\partial S}{\partial x}(x, Y, q, P) \\ Q - q = \frac{1}{k} \frac{\partial S}{\partial P}(x, Y, q, P), & p - P = \frac{1}{k} \frac{\partial S}{\partial q}(x, Y, q, P) \end{cases}$$

Indeed this amounts to the identification of $T^*(T^{m+n}) \times T^*(T^{m+n})$ endowed with the symplectic form $\sigma_k \ominus \sigma_k$ (i.e. π_1, π_2 denoting the projections on the first and second T^*T^n factor, $\sigma_k \ominus \sigma_k$ is defined as $(\pi_1^* \sigma_k - \pi_2^* \sigma_k)$, with $T^*(T^{n+m} \times \mathbb{R}^{n+m})$ endowed with the standard form by

$$(x, y, q, p, X, Y, Q, P) \longrightarrow (x, Y, q, P, y - Y, X - x, k(p - P), k(Q - q))$$

Note that S depends on k , even though it is not apparent in the notation. Two such transformations are composed by using the following formula: If $S_1(x_1, Y_1, q_1, P_1), S_2(x_2, Y_2, q_2, P_2)$ are the generating functions for φ_1, φ_2 , we will have the generating function of $\varphi_1 \circ \varphi_2$ given by the next formula similar to that of Lemma 6.3

$$S(x, Y, q, P; x_2, Y_1, q_2, P_1) = S_1(x, Y_1, q, P_1) + S_2(x_2, Y, q_2, P) - \langle x - x_2, Y_1 - Y \rangle - k(P_1 - P, q - q_2)$$

Indeed, the constraining equations are

$$\begin{cases} \frac{\partial S}{\partial x_2} = 0 \iff \frac{\partial S_2}{\partial x}(x_2, Y, q_2, P) - Y + Y_1 = 0 \\ \frac{\partial S}{\partial Y_1} = 0 \iff \frac{\partial S_1}{\partial Y}(x, Y_1, q, P_1) + -x + x_2 = 0 \\ \frac{\partial S}{\partial q_2} = 0 \iff \frac{\partial S_2}{\partial q}(x_2, Y, q_2, P) + k(P - P_1) = 0 \\ \frac{\partial S}{\partial P_1} = 0 \iff \frac{\partial S_1}{\partial P}(x, Y_1, q, P_1) + k(q - q_2) = 0 \end{cases}$$

and the map φ is given by

$$\begin{aligned} & \left(x, Y + \frac{\partial S}{\partial x}(x, Y, q, P; x_2, Y_1, q_2, P_1), q, P + \frac{1}{k} \frac{\partial S}{\partial q}(x, Y, q; P, x_2, Y_1, q_2, P_1) \right) \longrightarrow \\ & \left(x + \frac{\partial S}{\partial Y}(x, Y, q, P; x_2, Y_1, q_2, P_1), Y, q + \frac{1}{k} \frac{\partial S}{\partial P}(x, Y, q, P; x_2, Y_1, q_2, P_1), P \right) \end{aligned}$$

that is

$$\begin{aligned} & \left(x, Y + \frac{\partial S_1}{\partial x}(x, Y_1, q, P_1), q, P + \frac{1}{k} \frac{\partial S_1}{\partial q}(x, Y_1, q, P_1) \right) \longrightarrow \\ & \left(x + \frac{\partial S_2}{\partial Y}(x_2, Y, q_2, P), Y, q + \frac{1}{k} \frac{\partial S_2}{\partial P}(x_2, Y, q_2, P) \right) \end{aligned}$$

Now the map φ_1 sends

$$\begin{aligned} & \left(x, Y_1 + \frac{\partial S_1}{\partial x}(x, Y_1, q, P_1), q, P_1 + \frac{1}{k} \frac{\partial S_1}{\partial q}(x, Y_1, q, P_1) \right) \longrightarrow \\ & \left(x + \frac{\partial S_1}{\partial Y}(x, Y_1, q, P_1), Y_1, q + \frac{1}{k} \frac{\partial S_1}{\partial P}(x, Y_1, q, P_1), P_1 \right) \end{aligned}$$

and the map φ_2 sends

$$\begin{aligned} & \left(x_2, Y + \frac{\partial S_2}{\partial x}(x_2, Y, q_2, P), q, P + \frac{1}{k} \frac{\partial S_2}{\partial q}(x_2, Y, q_2, P) \right) \longrightarrow \\ & \left(x_2 + \frac{\partial S_2}{\partial Y}(x_2, Y, q_2, P), Y, q_2 + \frac{1}{k} \frac{\partial S_2}{\partial P}(x_2, Y, q_2, P), P \right) \end{aligned}$$

Since

$$\begin{cases} Y = Y_1 + \frac{\partial S_2}{\partial x}(x_2, Y, q_2, P) \\ x = x_2 + \frac{\partial S_2}{\partial Y}(x_2, Y, q_2, P) \\ P = P_1 + \frac{1}{k} \frac{\partial S_2}{\partial q}(x_2, Y, q_2, P) \\ q = q_2 + \frac{1}{k} \frac{\partial S_2}{\partial P}(x_2, Y, q_2, P) \end{cases}$$

we may infer

$$\varphi = \varphi_1 \circ \varphi_2$$

11.1 Resolution in the (q_2, P_1) variables

For $j = 1, 2$, let the functions

$$\frac{\partial S_j}{\partial P}(x_2, Y, q_2, P), \quad \frac{\partial S_j}{\partial q}(x_2, Y, q_2, P)$$

be C^1 bounded, and assume k is large. We may then solve

$$\begin{cases} \frac{\partial S_2}{\partial q}(x_2, Y, q_2, P) + k(P - P_1) = 0 \\ \frac{\partial S_1}{\partial P}(x, Y_1, q, P_1) + k(q - q_2) = 0 \end{cases}$$

in

$$(q_2, P_1) = (q_2(x, Y, q, P; x_2, Y_1), P_1(x, Y, q, P; x_2, Y_1))$$

This requires the following matrix to be invertible:

$$\begin{pmatrix} I - \frac{1}{k} \frac{\partial^2 S_2}{\partial q \partial P}(x_2, Y, q_2, P) & \frac{1}{k} \frac{\partial^2 S_2}{\partial q^2}(x_2, Y, q_2, P) \\ \frac{1}{k} \frac{\partial^2 S_1}{\partial P^2}(x, Y, q_2, P) & I - \frac{1}{k} \frac{\partial^2 S_1}{\partial P \partial q}(x, Y_1, q, P_1) \end{pmatrix}$$

If we moreover assume that the norm of the inverse matrix is bounded, we get that the map is globally invertible : this is a theorem of Hadamard (see [Ha] and [DM-G-Z] for a modern exposition in English).

We thus get, under this assumption, a new generating function

$$\begin{aligned} \widehat{S}(x, Y, q, P; x_2, Y_1) = \\ S(x, Y, q, P; x_2, Y_1, q_2(x, Y, q, P; x_2, Y_1), P_1(x, Y, q, P; x_2, Y_1)) \end{aligned}$$

Note that

$$\|q_2(x, Y, q, P; x_2, Y_1) - q\|_{C^1} = O(1/k), \quad \|P_1(x, Y, q, P; x_2, Y_1) - P\|_{C^1} = O(1/k)$$

hence

$$\|\widehat{S}(x, Y, q, P; x_2, Y_1) - S(x, Y, q, P; x_2, Y_1, q, P)\|_{C^1} = O(1/k)$$

where

$$S(x, Y, q, P; x_2, Y_1, q, P) = S_1(x, Y_1, q, P) + S_2(x_2, Y, q, P) - \langle x - x_2, Y_1 - Y \rangle$$

Note that the left-hand side of all these equations depend on k , since S itself depends on k .

11.2 Generating functions for compositions

Suppose now that S_1 is a function of $(x_1, Y_1, q_1, P_1, \xi_1)$, S_2 of $(x_2, Y_2, q_2, P_2, \xi_2)$ which are both GFQI.

Then

$$S(x, Y, q, P; x_2, Y_1, q_2, P_1, \xi_1, \xi_2) = S_1(x, Y_1, q, P_1, \xi_1) + S_2(x_2, Y, q_2, P, \xi_2) - \langle x - x_2, Y_1 - Y \rangle - k \langle P_1 - P, q - q_2 \rangle$$

The conditions defining $\varphi = \varphi_1 \circ \varphi_2$ are then given by

$$\begin{cases} \frac{\partial S_2}{\partial q}(x_2, Y, q_2, P, \xi_2) + k(P - P_1) = 0 \\ \frac{\partial S_1}{\partial P}(x, Y_1, q, P_1, \xi_1) + k(q - q_2) = 0 \end{cases}$$

and for k large enough we may write, as in the previous section

$$(q_2, P_1) = (q_2(x, Y, q, P; x_2, Y_1, \xi_1, \xi_2), P_1(x, Y, q, P; x_2, Y_1, \xi_1, \xi_2))$$

We then set

$$\begin{aligned} \widehat{S}(x, Y, q, P; x_2, Y_1, \xi_1, \xi_2) = & S_1(x, Y_1, q, P_1(x, Y, q, P; x_2, Y_1, \xi_1, \xi_2), \xi_1) + \\ & S_2(x_2, Y, q_2(x, Y, q, P; x_2, Y_1, \xi_1, \xi_2), P, \xi_2) - \\ & \langle x - x_2, Y_1 - Y \rangle - k \langle P_1 - P, q - q_2 \rangle \end{aligned}$$

Again, we have, as above

$$\|\widehat{S}(x, Y, q, P; x_2, Y_1, \xi_1, \xi_2) - S(x, Y, q, P; x_2, Y_1, q, P, \xi_1, \xi_2)\|_{C^1} = O(1/k)$$

11.3 From φ_k^t to $\varphi_{k\ell}^t$

Let φ_k^t be the flow associated to $H(x, y, q, p)$ for the symplectic form σ_k . According to Lemma 11.1, the flow Ψ_k^t associated to $H(kx, y, q, p)$ for σ_1 is given by

$$\Psi_k^t = \rho_k^{-1} \varphi_k^{kt} \rho_k$$

Let $F_k(x, Y, q, P, \xi)$ be a generating function associated to the time-one flow of $H(x, y, q, p)$, for the symplectic form σ_k , i.e. φ_k^1 . We then have a generating function for $\varphi_{k\ell}$ given by

$$\begin{aligned} F_{k,\ell}(x, Y, q, P; \bar{x}, \bar{Y}, \bar{q}, \bar{P}, \bar{\xi}) = & \\ \sum_{j=1}^{\ell} F_k(x_j, Y_j, q_j, P_j, \xi_j) - \sum_{j=1}^{\ell} \langle x_j - x_{j+1}, Y_j - Y_{j+1} \rangle - k \langle q_j - q_{j+1}, P_j - P_{j+1} \rangle \end{aligned}$$

Here

$$\begin{aligned} x_1 &= x, q_1 = q, P_\ell = P, Y_\ell = Y, \\ \bar{x} &= (x_2, \dots, x_\ell), \bar{q} = (q_2, \dots, q_\ell), \bar{P} = (P_1, \dots, P_{\ell-1}), \\ \bar{Y} &= (Y_1, \dots, Y_{\ell-1}), \bar{\xi} = (\xi_1, \dots, \xi_\ell) \end{aligned}$$

The condition for solving the constraints $\frac{\partial F}{\partial \bar{q}} = \frac{\partial F}{\partial \bar{P}} = 0$ in (\bar{q}, \bar{P}) is that for k large enough the inverse of the following matrix is bounded

$$\begin{pmatrix} I - \frac{1}{k} \frac{\partial^2 F_k}{\partial \bar{q} \partial \bar{P}}(\bar{x}, Y, \bar{q}, P) & \frac{1}{k} \frac{\partial^2 F_k}{\partial \bar{q}^2}(\bar{x}, Y, \bar{q}, P) \\ \frac{1}{k} \frac{\partial^2 F_k}{\partial \bar{P}^2}(\bar{x}, Y, \bar{q}, P) & I - \frac{1}{k} \frac{\partial^2 F_k}{\partial \bar{P} \partial \bar{q}}(x, \bar{Y}, q, \bar{P}) \end{pmatrix}$$

This amounts to the inequality

$$(\star) \quad \frac{1}{k} \left\| \begin{pmatrix} \frac{\partial^2 F_k}{\partial \bar{q} \partial \bar{P}}(x, Y, q, P) & \frac{\partial^2 F_k}{\partial \bar{q}^2}(x, Y, q, P) \\ \frac{\partial^2 F_k}{\partial \bar{P}^2}(x, Y, q, P) & \frac{\partial^2 F_k}{\partial \bar{P} \partial \bar{q}}(x, Y, q, P) \end{pmatrix} \right\| \leq \varepsilon$$

since a matrix of the type

$$\begin{pmatrix} I + A & C & 0 & \dots & \dots & 0 \\ B & I + A & C & 0 & \dots & 0 \\ 0 & B & I + A & C & \dots & 0 \\ \vdots & \ddots & \ddots & \ddots & & \\ 0 & \dots & 0 & B & I + A & C \\ 0 & \dots & 0 & 0 & B & I + A \end{pmatrix}$$

is invertible with bounded inverse if $\|A\|, \|B\|, \|C\|$ are small enough²⁰. Indeed, the $\|\cdot\|_\infty$ norm of the matrix

$$\begin{pmatrix} A & C & 0 & \dots & \dots & 0 \\ B & A & C & 0 & \dots & 0 \\ 0 & B & A & C & \dots & 0 \\ \vdots & \ddots & \ddots & \ddots & & \\ 0 & \dots & 0 & B & A & C \\ 0 & \dots & 0 & 0 & B & A \end{pmatrix}$$

is bounded by a constant times $\max(\|A\|, \|B\|, \|C\|)$, with a constant independent from the number of blocks. Under the above assumption (\star) , we have that

$$\|F_{k,\ell}(x, Y, q, P; \bar{x}, \bar{Y}, \bar{q}, \bar{P}, \bar{\xi}) - \widehat{F}_{k,\ell}(x, Y, q, P; \bar{x}, \bar{Y}, \bar{\xi})\|_{C^1} \leq C\ell \frac{1}{k}$$

²⁰It holds independently from the number of blocks: this follows from Gershgorin's theorem (see [Ger, Va]), stating that if R bounds the sum on any line of the absolute value of the off diagonal terms, then the eigenvalues of the matrix are at distance less than R from the diagonal terms. The bound on the inverse follows immediately since in our case ℓ is fixed and k can be taken arbitrarily large.

where

$$\widehat{F}_{k,\ell}(x, Y, q, P; \bar{x}, \bar{Y}, \bar{\xi}) = \sum_{j=1}^{\ell} F_k(x_j, Y_j, q, P, \xi_j) - \sum_{j=1}^{\ell} \langle x_j - x_{j+1}, Y_j - Y_{j+1} \rangle$$

Now let us for typographical convenience revert to (x, y, q, p) notation instead of (x, Y, q, P) . Let the generating function associated to Ψ_k^1 be given by $F_k(x, y, q, p; \bar{\xi})$.

We thus have according to proposition 6.15 for each fixed value of (q, p) , a function $h_k(y, q, p)$ and a cycle $\Gamma(y, q, p)$ with the proper homology class such that

$$F_k(y, q, p; \Gamma(y, q, p)) \leq h_k(y, q, p) + \varepsilon_k$$

where $\lim_{k \rightarrow \infty} h_k(y, q, p) = h_{\infty}(y, q, p)$.

Moreover $\Gamma(y, q, p)$ may be allowed to depend continuously on (y, q, p) provided we allow the weaker inequality

$$F_k(y, q, p; \Gamma_j(y, q, p)) \leq h_k(y, q, p) + a\chi_j^{\delta}(q, p)$$

where now χ_j^{δ} is supported in W_j^{δ} , a δ -neighborhood of a grid in the (q, p) variables. The procedure here is the same as in the proof of proposition 6.15. Note that we used proposition 6.15, in order to get rid of the y dependence of the χ_j^{δ} .

Then

$$\widehat{F}_{k,\ell}(x, y, q, p; \bar{x}, \bar{y}, \bar{\xi}) = \frac{1}{\ell} \sum_{j=1}^{\ell} F_k(x_j, y_j, q, p, \xi_j) - \langle y_j - y_{j+1}, x_j - x_{j+1} \rangle$$

will satisfy on

$$\widehat{\Gamma}_{k,\ell} = \{(x_j, y_j, q, p, \xi_j) \mid (x_j, \xi_j) \in \Gamma_j(y_j, q, p)\}$$

the inequality

$$\begin{aligned} \widehat{F}_{k,\ell}(x, y, q, p; \bar{x}, \bar{y}, \bar{\xi}) \leq \\ \frac{1}{\ell} \sum_{j=1}^{\ell} h_k(y, q, p) + \frac{a}{\ell} \sum_{j=1}^{\ell} \chi_j^{\delta}(q, p) - \langle x_j - x_{j+1}, y_j - y_{j+1} \rangle \end{aligned}$$

As before we choose the W_j^{δ} so that the intersection of $2m + 1$ distinct $W_j^{\delta} = \text{supp}(\chi_j)$ is empty.

Thus $\widehat{F}_{k,\ell}$ is bounded by the generating function of $h_k(y, q, p)$ up to $\frac{2ma}{\ell}$. We therefore get for all α , that

$$c(\mu, \Psi_{k\ell}^1 \alpha) \leq c(\mu, \bar{\Psi}_k^1 \alpha) + \frac{2ma}{\ell}$$

hence $\lim_k c(\mu, \Psi_{k,\ell}^1 \alpha) \leq c(\mu, \bar{\Psi}_{\infty}^1 \alpha)$. We thus proved the analogue of Proposition 6.15 in the partial homogenization case.

Finally, we may conclude the proof of theorem 5.5 as we did in the standard case for Theorem 5.1, noting that the proof of Proposition 8.4 extends to the situation where we have parameters (q, p) without any notable modification.

12 Proof of proposition 5.7

We shall limit ourselves to the case where homogenization is done on all variables.

According to proposition B.1 from Appendix B, if u_1, u_2 are defined as $c(1(q), L_1)$ and $c(1(q), L_2)$ respectively, we have

$$|c(1(q), L_1) - c(1(q), L_2)| \leq \gamma(L_1, L_2)$$

Now if $L_1 = \varphi_1(\Lambda)$ and $L_2 = \varphi_2(\Lambda)$, we have

$$\gamma(L_1, L_2) \leq \gamma(\varphi_1 \varphi_2^{-1})$$

In our case, $L_k = (\text{Id} \times \varphi_k^t) \Delta$, $\bar{L} = (\text{Id} \times \bar{\varphi}^t) \Delta$, and therefore we get

$$|u_k(t, q) - \bar{u}(t, q)| \leq \gamma(\varphi_k^t \bar{\varphi}^{-t})$$

Now using the estimate (6.1) in the proof of Proposition 6.12, we see that

$$\gamma(\varphi_k^{mt} \bar{\varphi}^{-mt}) \leq m \gamma(\varphi_k^t \bar{\varphi}^{-t})$$

and taking the supremum over t in $[0, 1]$, we get, since the flow is autonomous,

$$\sup_{t \in [0, m]} \gamma(\varphi_k^t \bar{\varphi}^{-t}) \leq m \sup_{t \in [0, 1]} \gamma(\varphi_k^t \bar{\varphi}^{-t})$$

thus implying

$$\sup_{t \in [0, m]} |u_k - \bar{u}| \leq \gamma(L_k, \bar{L}) \leq m \varepsilon_k$$

where $\varepsilon_k = \sup_{t \in [0, 1]} \gamma(\varphi_k^t \bar{\varphi}^{-t})$. This concludes the proof of proposition 5.7.

13 Non compact-supported Hamiltonians and the time dependent case

13.1 The coercive case

Assume first that the autonomous Hamiltonian $H(q, p)$, defined on T^*T^n , is not compactly supported, but that H is coercive, that is

$$\lim_{|p| \rightarrow \infty} H(q, p) = +\infty$$

Then let $\chi_A : \mathbb{R} \rightarrow \mathbb{R}$ be a truncation function, that is a smooth function such that

- (1) $0 \leq \chi_A \leq 1$
- (2) χ_A is supported in $[-2A, 2A]$
- (3) $\chi_A = 1$ on $[-A, A]$

We then consider $\chi_A(|p|)H(q, p) = K(q, p)$, and denote by φ^t the flow of H , and by ψ^t the flow of K . Since φ^t preserves H , we have that if $a(\lambda), b(\lambda)$ are defined by $a(\lambda) = \inf\{|p| \mid \forall q, H(q, p) \geq \lambda\}$ and $b(\lambda) = \sup\{|p| \mid \forall q, H(q, p) \leq \lambda\}$, so that

$$W^{a(\lambda)} = \{(q, p) \mid |p| \leq a(\lambda)\} \subset \{(q, p) \mid H(q, p) \leq \lambda\} \subset \{(q, p) \mid |p| \leq b(\lambda)\} = W^{b(\lambda)}$$

then φ^t sends $W^{a(\lambda)}$ into $W^{b(\lambda)}$ thus, for $A \geq b(\lambda)$, we have $\psi^t = \varphi^t$ on $W^{a(\lambda)}$. Since ρ_k preserves $W^{a(\lambda)}$ and $W^{b(\lambda)}$, the flow $\varphi_k^t = \rho_k^{-1} \varphi^{kt} \rho_k$ sends also $W^{a(\lambda)}$ into $W^{b(\lambda)}$ and moreover coincides with ψ_k^t on $W^{a(\lambda)}$.

We want to conclude that the homogenizations $\bar{\varphi}^t = \lim_k \varphi_k^t$ and $\bar{\psi}^t = \lim_k \psi_k^t$ coincide on $W^{a(\lambda)}$. This is given by the following result based on the ideas of [Hu], section 4.4. First we shall say that $\bar{\psi}^t = \bar{\varphi}^t$ on U if and only if $(\bar{\psi}^t)^{-1} \bar{\varphi}^t$ has support in the complement of U (in the sense of [Hu] section 4.4 or [Hu2] definition 2.24, page 51).

Definition 13.1 ([Hu] section 4.4 or [Hu2] definition 2.24, page 51). *Let $H \in \widehat{\mathfrak{Ham}}_c(T^*T^n)$. We define $\text{supp}(H)$ to be the intersection of closed sets F , such that there exists a sequence H_n of Hamiltonians supported in F , such that $\gamma - \lim_n H_n = H$. One similarly defines $\text{supp}(\varphi)$ for $\varphi \in \widehat{\text{Ham}}_c(T^*M)$ as the intersection of the closed sets, F , such that there exists a sequence φ_n converging to φ such that $\text{supp}(\varphi_n) \subset F$.*

Lemma 13.2. *Let φ_k^t, ψ_k^t be two sequences of smooth Hamiltonian flows, with support contained in a fixed compact set for all k . Let $U \subset V$ such that for any t , $\varphi_k^t(U) \subset V$, $\psi_k^t(U) \subset V$ and $\varphi_k^t = \psi_k^t$ on V . Then if $\gamma - \lim_{k \rightarrow \infty} \varphi_k^t = \varphi_\infty^t$ and $\gamma - \lim_{k \rightarrow \infty} \psi_k^t = \psi_\infty^t$ and H_∞, K_∞ generate $\varphi_\infty^t, \psi_\infty^t$, then we may conclude that $H_\infty - K_\infty$ is constant on U .*

Proof. Let $H_k(t, z), K_k(t, z)$ be the compactly supported Hamiltonians generating φ_k^t, ψ_k^t . For $x \in V$, we have $\psi_k^t(x) = \varphi_k^t(x)$, hence ψ_k^t and φ_k^t coincide. Then $((\psi_k^t)^{-1} \circ \varphi_k^t)|_V = \text{Id}_V$, so the Hamiltonian generating this flow, $L_k(t, z) = (H_k - K_k)(t, \psi_k^t(z))$ vanishes on V . Now by assumption L_k γ -converges to a Hamiltonian generating $(\psi_\infty^t)^{-1} \circ \varphi_\infty^t$, thus $\text{supp}((\psi_\infty^t)^{-1} \circ \varphi_\infty^t) \cap U = \emptyset$. This flow being generated by $H_\infty - K_\infty$ which is continuous, we have according to [Hu2] (proposition 2.25 page 52), that $H_\infty - K_\infty$ is constant on U . \square

Now if $a(\lambda) \leq A \leq B$, setting $H_A = H \cdot \chi_A$ (resp. $H_B = H \chi_B$), we have $\bar{H}_A = \bar{H}_B$ (up to constant that can be adjusted) on $W^{a(\lambda)}$ hence we may set

Proposition & Definition 13.3. Let H be an autonomous coercive Hamiltonian on T^*T^n . Then the limit $\bar{H} = \lim_{A \rightarrow +\infty} \bar{H}_A$ is well defined.

Thus any **autonomous** coercive Hamiltonian can be homogenized:

Proposition 13.4. *The map \mathcal{A} from $\widehat{\mathfrak{Ham}}_c(T^*T^n)$ to $C_c^0(\mathbb{R}^n, \mathbb{R})$ extends to a map defined on the set of autonomous coercive Hamiltonians, i.e. such that $\lim_{|p| \rightarrow +\infty} H(q, p) = +\infty$ with values in $C^0(\mathbb{R}^n, \mathbb{R})$. Moreover if H is convex in p , then so is \bar{H} .*

Proof. This follows from lemma 13.2 applied to the sequence $(H_N)_{N \geq 1}$. According to our truncation argument, the convexity statement needs only to be checked for H of class C^∞ and Tonelli. Then according to Section 14.2 Proposition 14.4, \bar{H} coincides with Mather's α function and according to [CIPP], theorem A and corollary 1, the α function is given by

$$\bar{H}(p) = \inf_{u \in C^1(N, \mathbb{R})} \sup_{q \in N} H(q, p + du(q))$$

Now we have

$$\begin{aligned} \bar{H}(tp_1 + (1-t)p_2) &= \inf_{u \in C^1(N, \mathbb{R})} \sup_{q \in N} H(q, tp_1 + (1-t)p_2 + du(q)) \leq \\ &\inf_{u_1, u_2 \in C^1(N, \mathbb{R})} \sup_{q \in N} H(q, tp_1 + (1-t)p_2 + tdu_1(q) + (1-t)du_2(q)) \leq \\ t \inf_{u_1 \in C^1(N, \mathbb{R})} \sup_{q \in N} H(q, p_1 + du_1(q)) + (1-t) \inf_{u_2 \in C^1(N, \mathbb{R})} \sup_{q \in N} H(q, p_2 + du_2(q)) &\leq \\ &t\bar{H}(p_1) + (1-t)\bar{H}(p_2) \end{aligned}$$

The first inequality is obtained by just setting $u = (1-t)u_1 + tu_2$, the second one by convexity of H . \square

13.2 Non-autonomous Hamiltonians

Consider now a compactly supported 1-periodic Hamiltonian $H(t, q, p)$ on T^*T^n and consider the Hamiltonian $K(t, \tau, q, p) = \tau + H(t, q, p)$. This new Hamiltonian, defined on $T^*(T^{m+1})$ is not compactly supported, but, considering the function χ_A as defined above, the Hamiltonian

$$K_A(t, \tau, q, p) = \chi_A(\tau + H(t, q, p))(\tau + H(t, q, p))$$

is **compactly supported and autonomous**. Its flow preserves the subsets $W^\lambda = \{(t, \tau, q, p) \mid -\lambda \leq \tau + H(t, q, p) \leq \lambda\}$

Then K_A can be homogenized, and the same argument as above shows that that $\bar{K}_A = \bar{K}_B$ for $\lambda \leq A \leq B$ on $|\tau| \leq \lambda - \|H\|$. Moreover, we now prove that $\bar{K} = \lim_{A \rightarrow +\infty} \bar{K}_A$ is of the form $\tau + \bar{H}(p)$ on $|\tau| \leq A$: in other words, $\bar{K}(\tau, p) - \tau$ is independent from τ (and denoted by $\bar{H}(p)$).

Proposition 13.5. *Let $H(t, q, p)$ be a Hamiltonian on T^*T^n , 1-periodic in time and compactly supported in (q, p) . Then $\lim_{A \rightarrow +\infty} \bar{K}_A = \bar{K}(\tau, p)$ is well defined and there exists $\bar{H}(p)$ such that $\bar{K}(\tau, p) = \tau + \bar{H}(p)$. The function \bar{K} satisfies the properties of theorems 5.1 and 5.2.*

Proof. Being of the form $L(t, \tau, q, p) = a\tau + L_0(t, q, p)$ is equivalent to the commutation of φ_L^s and ψ^s , where ψ is the flow of $\frac{\partial}{\partial \tau}$, since $\{L, t\} = \frac{\partial L}{\partial \tau}$. Now by assumption on $|\tau| \leq A - \|H\|$, we have $\{K_A, t\} = 1$, so setting $\rho_k(t, \tau, q, p) = (kt, \tau, kq, p)$, we may write in this region (note that the region is preserved by ρ_k)

$$\begin{aligned} \varphi_K^s \psi^s &= \lim_{k \rightarrow +\infty} \rho_k^{-1} \varphi_K^{ks} \rho_k \psi^s = \lim_{k \rightarrow +\infty} \rho_k^{-1} \varphi_K^{ks} \psi^{ks} \rho_k = \lim_{k \rightarrow +\infty} \rho_k^{-1} \psi^{ks} \varphi_K^{ks} \rho_k = \\ &\lim_{k \rightarrow \infty} \psi^s \rho_k^{-1} \varphi_K^{ks} \rho_k = \psi^s \varphi_{\bar{K}}^s \end{aligned}$$

Thus $\varphi_{\overline{K}}$ and ψ^s commute, therefore $\overline{K}(t, \tau, q, p) = a\tau + \overline{H}(p)$ for some constant a . The following lemma implies $a = 1$.

Lemma 13.6. *Let $K(t, \tau, q, p) = \tau + H(t, q, p)$, with flow φ^s , and let*

$$\psi^s(t, \tau, q, p) = (t, \tau + s, q, p)$$

Then $\varphi^s \psi^\sigma \varphi^{-s} \psi^{-\sigma}$ is generated by

$$L_\sigma(s, t, \tau, q, p) = K(t, \tau, q, p) - K(\psi^{-\sigma} \varphi^{-s}(t, \tau, q, p)) = \sigma$$

Proof. This is just the translation, using [C-V], of the fact that $\{K, t\} = 1$. \square

As a result, if we have a sequence $K_n = \tau + H_n(t, q, p)$ γ -converging to K_∞ , we shall have $\gamma(\varphi_n^s \psi^\sigma \varphi_n^{-s} \psi^{-\sigma}) = \sigma$, hence

$$\gamma(\varphi_\infty^s \psi^\sigma \varphi_\infty^{-s} \psi^{-\sigma}) = \sigma$$

and this implies $K_\infty(t, \tau, q, p) = \tau + H_\infty(t, q, p)$. Note that even after truncation, we have $L_\sigma = \sigma$ over a large compact set, and $|L_\sigma| \leq \sigma$, so that $\gamma(\varphi_\infty^s \psi^\sigma \varphi_\infty^{-s} \psi^{-\sigma}) = \sigma$. \square

Remark 13.7. We could have taken a direct approach to the non-autonomous problem. For this one can replace in subsection 6.1 the generating function $S(q, P)$ for $\varphi^{1/r}$ by a generating function $S(q, P, \xi)$ for φ . All formulas for the generating function of φ_k^1 translate immediately, as well as the proofs of section 6.

Finally, we may consider the case of a non-autonomous, coercive Hamiltonian. Note that if H is a Hamiltonian equal to a constant c outside a compact set, we may still define \overline{H} as $c + (H - c)$.

Proof of Theorems 5.1 and 5.2 for non-autonomous Hamiltonians. For general Hamiltonians, the proof of Theorem 5.1 and 5.2 now follows easily from the autonomous case and Proposition 13.5. We only need to check that homogenization for K_A , that is γ -convergence of $(K_A)_k$ for all A implies the γ convergence of H_k .

Lemma 13.8. *Let $H_n(t, q, p)$ be a sequence of compact supported Hamiltonians (with fixed support) in T^*T^n . Assume for all A we have*

$$(K_n)_A = \chi_A(\tau + H_n(t, q, p))(\tau + H_n(t, q, p))$$

is γ -converging to $(K_\infty)_A$ such that $\lim_{A \rightarrow +\infty} \overline{K}_A = \overline{K}(\tau, p) = \tau + \overline{H}(p)$. Then H_n γ -converges to \overline{H} .

Proof. The flow of $K = \tau + H(t, q, p)$ is given by

$$\Phi^s(t, \tau, q, p) = (t + s, \tau + H(t, q, p) - H(t + s, \varphi_t^{t+s}(q, p), \varphi_t^{t+s}(q, p)))$$

where φ_t^{t+s} is the flow of H . If χ_A is a truncation function replacing K by $\chi_A(K)$ replaces $\Phi^s(t, \tau, q, p)$ by $\Phi_A^s(t, \tau, q, p)$. Notice that $\Phi^s(t, \tau, q, p) = \Phi_A^s(t, \tau, q, p)$ provided $|\tau + H(t, q, p)| \leq A$. Now we write the coordinates as $(t, \tau, q, p, t', \tau', Q, P)$ and the graph $\Gamma(\Phi^1)$ of Φ^1 is given by

$$\{(t, \tau, q, p, t + 1, \tau + \Delta\tau(t, q, p), \varphi_t^{t+1}(q, p))\}$$

where $\Delta\tau(q, p) = H(t, q, p) - H(t + 1, \varphi_t^{t+1}(q, p))$. Taking the reduction by $t = 0, t' = 1$, we get

$$\{(q, p, \varphi_0^1(q, p))\} = \Gamma(\varphi_0^1)$$

As a result if $A > \|H\|_{C^0}$, we have $\Phi^s(t, \tau, q, p) = \Phi_A^s(t, \tau, q, p)$ for $t = 0, t' = 1$, so the reduction of $\Gamma(\Phi_A^1)$ by $\{t = 0, t' = 1\}$ coincides with the reduction of $\Gamma(\Phi^1)$, that is $\Gamma(\varphi_0^1)$.

Now the reduction inequality ([V1], prop. 5.1 p. 705) implies continuity of the reduction for γ -topology, hence if $K_n = \tau + H_n(t, q, p)$ is a γ -converging sequence with limit $K_\infty = \tau + H_\infty(t, q, p)$, then the flow $(\varphi_n)_t^{t+s}$ γ converges to $(\varphi_\infty)_t^{t+s}$, in other words H_n is a γ -converging sequence with limit H_∞ . Applying this with $H_n(t, q, p) = H(nt, nq, p)$ and $H_\infty(t, q, p) = \bar{H}(p)$ and using Proposition 13.5 to verify that K_∞ is of the form $\tau + \bar{H}(p)$, we get our theorem in the non-autonomous case. \square

Note that in Theorem 5.2 only (1) (2) (3) (6) involve the non-autonomous case. \square

Now we may even extend homogenization to the coercive situation. Let f_r such that $f_r(x) = x$ for $x \leq r$ and $f_r(x) = r$ for $x \geq r$. We then set

Definition 13.9. *Let $H(t, q, p)$ be a coercive non-autonomous Hamiltonian. Then we set*

$$\bar{H}(p) = \limsup_{K \leq H, K \in C_c^0([0,1] \times T^*T^n, \mathbb{R})} \bar{K}(p) = \lim_{r \rightarrow \infty} \overline{f_r(H)}$$

Proposition 13.10. *The function \bar{H} is well-defined and lower semi-continuous. If H is convex, so is \bar{H} .*

Proof. Indeed, as a converging increasing sequence of continuous functions, \bar{H} is lower semi-continuous. Similarly, if H is convex, given the convex domain $\Omega_R = \{p \in \mathbb{R}^n \mid |p| \leq R\}$ we have that the $\overline{f_r(H)}$ are convex in Ω_R for $r \geq R$ hence according to Proposition 13.4, \bar{H} is a limit of functions convex in Ω_R . Since R is arbitrary, we get that \bar{H} is convex. \square

Remarks 13.11. (1) Because $H(t, q, p) \leq h(p)$ for some function h , we have $\bar{H} \leq h$, so \bar{H} is locally bounded. We do not know whether \bar{H} should be continuous.

However if $\frac{\partial H}{\partial p}(q, p)$ is bounded, then \bar{H} is Lipschitz, hence continuous (but most interesting coercive Hamiltonians are superlinear so this does not hold). We do not know an example of coercive Hamiltonian H such that \bar{H} is not continuous. Note that H would necessarily be non-autonomous, non-convex and superlinear.

(2) Note that we may also use the distance $\hat{\gamma}$ defined by

$$\hat{\gamma}(\varphi, id) = \sup\{\gamma(\varphi(L), L) \mid L \in \mathcal{L}\}$$

and we may also define the weak limit as $\varphi = \lim_k \varphi_k$ if and only if for any L in \mathcal{L} we have

$$\lim_k \gamma(\varphi_k(L), \varphi(L)) = 0$$

Note that this is different from convergence for $\widehat{\gamma}$, which would require that the above convergence is uniform in L .

We may now consider applications of the non-compact situation to homogenization of Hamilton-Jacobi equations. Indeed, let us consider a Hamiltonian $H(t, q, p)$ on T^*T^n , φ^t its flow, and f a C^1 function defined on T^n . Since the graph of df is bounded, for any positive time T , we may replace H by K_A for A large enough, in such a way that $\varphi^t(\Gamma_{df})$ is unchanged for $0 \leq t \leq T$. Since H is now compactly supported, we get a function $u_f(t, x)$, and the variational solutions $u_{k,f}(t, x)$ of

$$(HJ_k) \quad \begin{cases} \frac{\partial}{\partial t} u_k(t, q) + H(kt, kq, \frac{\partial}{\partial x} u_k(t, q)) = 0 \\ u_k(0, q) = f(q) \end{cases}$$

converge to the variational solution \bar{u}_f of

$$(\overline{HJ}) \quad \begin{cases} \frac{\partial}{\partial t} u(t, q) + \overline{H}(\frac{\partial}{\partial x} u(t, q)) = 0 \\ u(0, q) = f(q) \end{cases}$$

We may now extend the convergence to the case where f is only C^0 :

Corollary 13.12. *Assume $f \in C^0(T^n)$, and we have a sequence $f_\nu \in C^\infty(T^n)$ converging uniformly to f . Then $u_{k,f}$ converges uniformly on bounded time intervals to $\bar{u}_f = \lim_\nu \bar{u}_{f_\nu}$.*

Proof. Indeed, we have the estimate:

Lemma 13.13. *Let u_f, u_g be the variational solutions of the Hamilton-Jacobi equation (HJ) with initial conditions f and g respectively. Then*

$$\|u_f - u_g\|_{C^0} \leq \|f - g\|_{C^0}$$

Proof. Let Ψ be a Hamiltonian diffeomorphism of T^*N such that $\Psi(\Lambda_f) = \Lambda_g$, where $\Lambda_f = \{(x, df(x)) \mid x \in N\}$, and such that $\gamma(\Psi) \leq \|f - g\|_{C^0}$. We may take for Ψ^t a truncation to a compact domain of the isotopy $\Psi^t(x, p) = (x, p + td(g - f)(x))$.

Then the function u_f is obtained as $c(1(x), \varphi^t(\Lambda_f))$, and we have

$$\begin{aligned} |c(1(x), \varphi^t(\Lambda_f)) - c(1(x), \varphi^t(\Lambda_g))| &= |c(1(x), \varphi^t(\Lambda_f)) - c(1(x), \varphi^t\Psi(\Lambda_f))| \leq \\ &|c(1(x), \varphi^t(\Lambda_f) - \varphi^t\Psi(\Lambda_f))| \leq |c(1(x), \Lambda_f - \Psi(\Lambda_f))| \leq \gamma(\Lambda_f, \Psi(\Lambda_f)) \leq \\ &\gamma(\Psi) \leq \|f - g\|_{C^0} \end{aligned}$$

□

Now this implies, denoting by u_{k,f_ν} the sequence of variational solutions of the equation obtained by replacing f by f_ν in (HJ_k)

$$\|u_{k,f_\nu} - u_{k,f_\mu}\|_{C^0} \leq \|f_\nu - f_\mu\|_{C^0}$$

and

$$\|\bar{u}_{f_\nu} - \bar{u}_{f_\mu}\| \leq \|f_\nu - f_\mu\|_{C^0}$$

hence the sequences $(u_{k,f_\mu})_{\mu \geq 1}$ and $(\bar{u}_{f_\mu})_{\mu \geq 1}$ are Cauchy, hence have limits denoted $u_{k,f}$ and \bar{u}_f .

Given a positive ε , choose ν large enough, so that $|f - f_\mu| \leq \varepsilon$ for all $\mu \geq \nu$, and l large enough so that for $k \geq l$ we have $|u_{k,f_\nu} - \bar{u}_{f_\nu}| \leq \varepsilon$ we get

$$|u_{k,f_\mu} - \bar{u}_{f_\mu}| \leq |u_{k,f_\mu} - u_{f_\mu}| + |u_{k,f_\nu} - \bar{u}_{f_\nu}| + |\bar{u}_{f_\nu} - \bar{u}_{f_\mu}| \leq 3\varepsilon$$

As a result, for μ going to infinity, we get $|u_{k,f} - \bar{u}_f| \leq 3\varepsilon$ hence

$$\lim_{k \rightarrow \infty} u_{k,f} = \bar{u}_f.$$

□

13.3 A non-coercive example

Assume for example that

$$H(x_1, x_2, p_1, p_2) = h(p_1, p_2)$$

outside a compact set. Notice that the Poisson brackets, $\{H, p_1\} = \{H, p_2\} = 0$ outside a compact set, therefore $\{H, |p_1|^2 + |p_2|^2\} = 0$ outside a compact set. The flow φ^t of H will then remain inside a bounded domain W^λ for λ large enough. We may then use the same truncation method as above, and infer that we may homogenize H :

Proposition 13.14. *Let $H(x_1, x_2, p_1, p_2) = h(p)$ outside a compact set. Then we have a homogenization operator \mathcal{A} with the same properties as in the compactly supported case.*

Corollary 13.15. *Assume u_k is a variational solution of Hamilton-Jacobi equation (HJ_k) where H satisfies the conditions of Proposition 13.14. Then the sequence u_k converges uniformly to a solution \bar{u} of $(\bar{H}\bar{J})$.*

Remark 13.16. By an approximation method, this will work for any Hamiltonian such that

$$\lim_{|p| \rightarrow \infty} |H(q, p) - h(p)| = 0$$

14 Homogenization in the p variable and connection with Mather's α function

14.1 Homogenization in the p variable

This problem of homogenization in the p variable corresponds to the singular perturbation or penalization problem, studied in recent years by several authors (see for example [Alv-Bar1, Alv-Bar2]).

Let us consider a Hamiltonian $H(q, p)$ which is either compact supported or coercive. The sequence defined by $H_k(q, p) = H(q, k \cdot p)$. Its flow is given by

$$\psi_k^t = \zeta_k^{-1} \varphi^{kt} \zeta_k$$

where $\zeta_k(q, p) = (q, k \cdot p)$.

Note that here ζ_k is a *bona fide* map on T^*T^n , so that we do not have to invoke covering arguments. Since ζ_k satisfies $\zeta_k^*\omega = k\omega$, we get, that

$$\gamma(\zeta_k^{-1}\varphi^{kt}\zeta_k) = \frac{1}{k}\gamma(\varphi^{kt})$$

There is *a priori* no limit for the sequence $\psi_k^t = \zeta_k^{-1}\varphi^{kt}\zeta_k$: indeed if φ^t is the flow of $H(p)$, $\zeta_k^{-1}\varphi^{kt}\zeta_k$ will be the flow of $H(kp)$. However let us write $\tau_k(q, p) = \rho_k \circ \zeta_k^{-1}(q, p) = (k \cdot q, \frac{p}{k})$, then $\zeta_k = \rho_k \circ \tau_k^{-1}$ and

$$\psi_k^t = \zeta_k^{-1}\varphi^{kt}\zeta_k = \tau_k \rho_k^{-1} \varphi^{kt} \rho_k \tau_k^{-1} = \tau_k \varphi_k^t \tau_k^{-1}$$

Now

$$\gamma(\varphi_k^t \bar{\varphi}^{-t}) \leq \varepsilon_k t$$

thus²¹

$$\gamma((\tau_k \varphi_k^t \tau_k^{-1})(\tau_k \bar{\varphi}^{-t} \tau_k^{-1})) = \gamma(\tau_k(\varphi_k^t \bar{\varphi}^{-t})\tau_k^{-1}) = \gamma(\varphi_k^t \bar{\varphi}^{-t}) \leq \varepsilon_k t$$

Now since $\tau_k^{-1}\bar{\varphi}^t\tau_k$ is generated by $\bar{H}(k \cdot p)$, we do not get a limit for $H(q, k \cdot p)$ but we get:

Proposition 14.1. *Let H be an autonomous Hamiltonian which is either compact supported or coercive.*

$$\lim_{k \rightarrow \infty} \gamma(H(q, k \cdot p), \bar{H}(k \cdot p)) = \lim_{k \rightarrow \infty} \gamma(\psi_k^t(\bar{\varphi})^{-kt}) = 0$$

In spite of the fact that $\bar{H}(k \cdot p)$ has no limit as k goes to infinity, the above proposition has a number of applications. First, let us consider the standard parabolic Hamilton-Jacobi equations

$$\begin{cases} \frac{\partial}{\partial t} u(t, q) + H(q, \frac{\partial}{\partial q} u(t, q)) = 0 \\ u(0, q) = f(q). \end{cases}$$

Set $v_k(t, q) = \frac{1}{k}u(k \cdot t, q)$. This is now a solution of

$$\begin{cases} \frac{\partial}{\partial t} v_k(t, q) + H(q, k \frac{\partial}{\partial q} v_k(t, q)) = 0 \\ v_k(0, q) = \frac{1}{k}f(kq). \end{cases}$$

and since $\lim_{k \rightarrow \infty} \gamma(H(q, k \cdot p), \bar{H}(k \cdot p)) = 0$ and $\lim_{k \rightarrow \infty} \frac{1}{k}f(kq) = 0$ we get that v_k is approximated by w_k , variational solution of

$$\begin{cases} \frac{\partial}{\partial t} w_k(t, q) + \bar{H}(k \frac{\partial}{\partial q} w_k(t, q)) = 0 \\ w_k(0, q) = 0. \end{cases}$$

that is $\lim_{k \rightarrow \infty} |w_k - v_k| = 0$. Now, it is clear that $w_k(t, q) = -t\bar{H}(0)$, so that we get the following result, which had been proved in [L-P-V] in the p -convex one-dimensional case.

²¹We use here that $\gamma(\tau_k \varphi \tau_k^{-1}) = \gamma(\varphi)$. Note that τ_k is not Hamiltonian, as it is not even isotopic to the identity. However if we lift φ to $\tilde{\varphi} : T^*\mathbb{R}^n \rightarrow T^*\mathbb{R}^n$, and τ_k also obviously lifts to a Hamiltonian map of $T^*\mathbb{R}^n$ given by $\tilde{\tau}_t : (q, p) \mapsto (tq, \frac{p}{t})$, and $c_{\pm}(\tau_k \varphi \tau_k^{-1})$ belong to the set of actions of the fixed points of $(\tau_k \varphi \tau_k^{-1})$ contained in the set of actions of $\tilde{\tau}_k \tilde{\varphi} \tilde{\tau}_k^{-1}$. But since the set of actions of fixed points of $\tilde{\tau}_t \tilde{\varphi} \tilde{\tau}_t^{-1}$ is constant, the result follows by taking $t = k$.

Proposition 14.2. *Let u be a variational solution of*

$$(HJ) \quad \begin{cases} \frac{\partial}{\partial t}u(t, q) + H(q, \frac{\partial}{\partial q}u(t, q)) = 0 \\ u(0, q) = f(q) \end{cases}$$

then

$$\lim_{t \rightarrow \infty} \frac{1}{t}u(t, q) = -\bar{H}(0)$$

In the general convex case this result is due to the fact that the solutions of (HJ) are defined by the Lax-Oleinik semi-group T^t and that for u_0 the viscosity solution of $H(x, du_0(x)) = -\bar{H}(0)$ we have $T^t u_0 + \bar{H}(0)t = u_0$ and for all u $|T^t u - T^t u_0| \leq |u - u_0|$ so that $|T^t u + \bar{H}(0)t|$ is bounded (see [Fathi1, Fathi2]).

14.2 Connection with Mather α function

We start with

Definition 14.3. *The C^2 Lagrangian $L(t, q, \xi)$ is said to be a Tonelli Lagrangian if it is strictly convex and coercive, that is $\frac{\partial^2}{\partial \xi^2}L(t, q, \xi) > \varepsilon \text{Id}$ for some $\varepsilon > 0$ and the Euler-Lagrange flow defined on TN by*

$$\frac{d}{dt} \frac{\partial}{\partial \xi} L(t, q, \xi) - \frac{\partial}{\partial q} L(t, q, \xi) = 0$$

is complete.

Of course if H is the Legendre dual of L that is

$$H(t, q, \xi) = \inf_{\xi} \{ \langle p, \xi \rangle - L(t, q, \xi) \}$$

this definition is equivalent to requiring that the flow φ^t of the corresponding Hamiltonian is complete.

For a Tonelli Lagrangian $L(t, x, \xi)$, 1-periodic in t and strictly convex in p , the α function has been defined by Mather in [Ma] as

$$\alpha(p) = - \liminf_{T \rightarrow \infty} \frac{1}{T} \left\{ \int_0^T L(t, q(t), \dot{q}(t)) dt - \langle p, x_1 - x_0 \rangle \left| \begin{array}{l} q(0) = x_0, q(T) = x_1 \\ q \in C^1([0, T], N) \end{array} \right. \right\}$$

Note that in the above, the infimum is for x_0, x_1 free to vary.

As a special case, we may show

Proposition 14.4. *Let H be the Legendre dual of the Lagrangian L , i.e. H is strictly convex in p and*

$$L(t, q, \xi) = \sup_{p \in T_q^* N} \{ \langle p, \xi \rangle - H(t, q, p) \}$$

Then

$$\bar{H}(p) = - \liminf_{T \rightarrow \infty} \frac{1}{T} \left\{ \int_0^T L(t, q(t), \dot{q}(t)) dt - \langle p, x_1 - x_0 \rangle \left| \begin{array}{l} q(0) = x_0, q(T) = x_1 \\ q \in C^1([0, T], N) \end{array} \right. \right\}$$

As a result \bar{H} coincides with Mather's α function.

Proof. Replacing $L(t, q, \xi)$ by $L(t, q, \xi) + \langle p, \xi \rangle$, it is enough to consider the case $p = 0$. Then let

$$\mathcal{P}_t = \{q : [0, t] \longrightarrow M\}$$

and $\pi : \mathcal{P}_t \longrightarrow M$ the map $q \mapsto q(t)$. Let

$$E_t(q) = \int_0^t L(s, q(s), \dot{q}(s)) ds$$

be defined on \mathcal{P}_t , and consider²² E_t as a GFQI. We shall write (x_1, q) instead of q to remind the reader that $\pi(q) = q(t) = x_1$.

Now

$$DE_t(x_1, q) = \int_0^t \left[\frac{\partial L}{\partial x}(s, q(s), \dot{q}(s)) - \frac{d}{dt} \frac{\partial L}{\partial \xi}(s, q(s), \dot{q}(s)) \right] \delta q(s) ds + \\ \frac{\partial L}{\partial \xi}(t, q(t), \dot{q}(t)) \delta q(t) - \frac{\partial L}{\partial \xi}(0, q(0), \dot{q}(0)) \delta q(0)$$

Setting

$$p(t) = \frac{\partial L}{\partial \xi}(t, q(t), \dot{q}(t))$$

and since $\dot{q}(t) = \frac{\partial H}{\partial p}(t, q(t), p(t))$ by the variational formula connecting L and H , the vanishing of $DE_t(x_1, q)$ implies

$$\dot{p}(t) = -\frac{\partial H}{\partial q}(t, q(t), p(t))$$

so we get $(x_1, \frac{\partial E_t}{\partial x_1}) = (x_1, p_1) = \varphi^t(x_0, 0)$. Therefore E_t is a GFQI of $\varphi^t_{-H}(0_N)$, and since

$$u_L(t, x) = \inf\{E_t(x, q) \mid q \in \mathcal{P}, q(1) = x\} = c(1(x), E_t)$$

is a variational solution of

$$(HJ) \quad \begin{cases} \frac{\partial}{\partial t} u(t, q) = H(t, q, \frac{\partial}{\partial q} u(t, q)) \\ u(0, q) = 0 \end{cases}$$

and we proved in Proposition 14.2 (note that here the equation has a different sign in front of H)

$$\lim_{t \rightarrow \infty} \frac{1}{t} u_L(t, x) = -\overline{H}(0).$$

this concludes our proof. □

As a consequence we get for $N = T^n$

Corollary 14.5 (P. Bernard, [Bern 2]). *The Mather α function is symplectically invariant.*

²²As Frol Zapolsky pointed out, one must first do a finite dimensional reduction of E_t , for example using a broken geodesic method see [Ch2]. This is done in Appendix D.

15 More examples and applications

15.1 Homogenization of $H(t, q, p)$ in the variable t

Applying partial homogenization's Theorem 5.5 to the t variable for a T -periodic Hamiltonian $H(t, q, p)$ defined on T^*T^n , we obtain an autonomous Hamiltonian $\overline{H}(q, p)$. However, this is nothing else than

$$\overline{H}(q, p) = \frac{1}{T} \int_0^T H(t, q, p) dt$$

Indeed, if $H(kt, q, p)$ has flow φ_k^t , we have, by the fundamental theorem of classical averaging (see [B-M] page 429, [S-V] theorem 3.2.10 page 39):

$$\lim_{k \rightarrow \infty} \varphi_k^t = \overline{\varphi}^t$$

in the C^0 topology, where $\overline{\varphi}^t$ is the flow of

$$\frac{1}{T} \int_0^T X_H(t, q, p) dt = X_{\overline{H}}(q, p).$$

Since according to [V1](proposition 4.15, page 703), C^0 -convergence implies γ -convergence²³, our claim follows.

15.2 The one dimensional case

In [L-P-V], the computation of \overline{H} in the case $H(q, p) = |p|^2 - V(q)$ and for V bounded from below is explicitly dealt with. Indeed, assuming $V \geq 0$ is one-periodic and vanishes at least at one point, we have

$$(\star) \quad \begin{cases} \overline{H}(p) = 0 & \text{if } |p| \leq \int_0^1 (V(q))^{1/2} dq \\ \overline{H}(p) = \lambda & \text{where } \lambda \text{ solves } |p| = \int_0^1 (V(q) + \lambda)^{1/2} dq \text{ otherwise} \end{cases}$$

Indeed, according to theorem 5.2 property (5), if we can find a curve L in T^*S^1 such that $|p|^2 - V(q) \leq h$ on L and $\int_L p dq = v$ then $\overline{H}(v) \leq h$. Since $H(q, p) \leq h$ contains $L_v = \{(q, p(q)) \mid p = (V(q) + h)^{1/2}\}$ and this is the graph of a Lagrangian submanifold with integral of the Liouville class

$$v = \int_0^1 (V(q) + h)^{1/2} dq$$

we get that $\overline{H}(v) \leq h$. But the Lagrangian, $\{(q, p) \mid p = (V(q) + h)^{1/2} + \varepsilon\}$ is contained in $H(q, p) \geq h$, hence $\overline{H}(v) \geq h$. By the monotonicity property ((1) of theorem 5.2) $\overline{H}(v) \geq 0$, and this proves (\star) .

In higher dimension, since $\{(q, p + du(q)) \mid q \in T^n\}$ is Lagrangian and Hamiltonian isotopic to L_p , the fact that if $u(q)$ is a smooth function such that $H(q, p + du(q)) \leq h$ then $\overline{H}(p) \leq h$ is a useful piece of information in estimating \overline{H} .

²³This is proved in \mathbb{R}^{2n} in the quoted reference, but is easily extended to the torus case. Indeed the proof is based on the lemma, page 703, which states the existence of a compactly supported Hamiltonian diffeomorphism such that each point of the unit disc bundle is displaced by at least ε . This can be constructed by taking the Hamiltonian flow associated to the Hamiltonian $H(q, p) = \chi(|p|)\langle p, \xi(q) \rangle$, where χ is a cutoff function, $\xi(q)$ a non-vanishing vector field on T^n .

15.2.1 A special “geometric” example

We now give an example of a Hamiltonian that is the characteristic function of a domain in T^*T^1 . The Homogenized Hamiltonian is well-defined according to Theorem 5.2 (4) and Remark 5.3 ((3)).

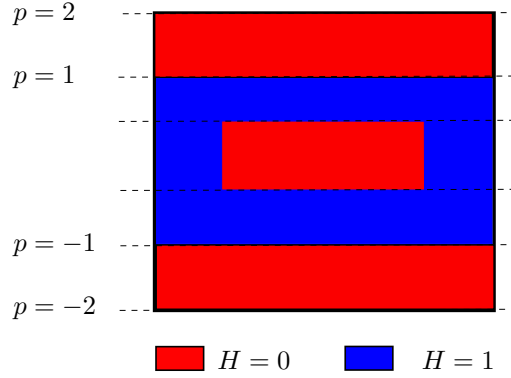


Figure 5: The Hamiltonian $H(q, p)$.

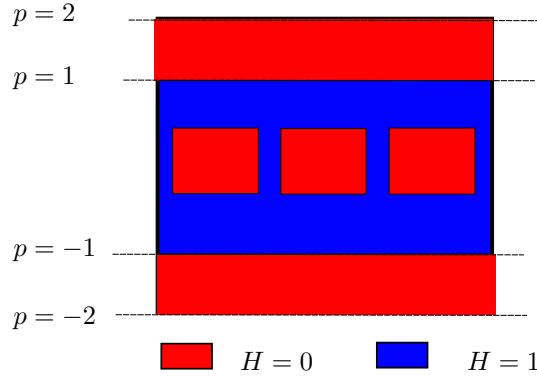


Figure 6: The Hamiltonian $H(k \cdot q, p)$ (for $k = 3$).

We let H be a Hamiltonian on T^*T^1 represented on Figure 5, vanishing on the red set, assumed to be open, and equal to one in the blue set. We want to compute $\overline{H}(p)$ for $|p| \leq 2$. Denote by A the area of the red island, and by B the area of the blue sea, so $A + B = 2$. Note that for A large compared to B (in fact as soon as $A > B$) it may be difficult to construct a curve with Liouville class 0 contained in $H = 1$ since we have to either go above the red island, thus adding an area of $A/2$ and we cannot subtract more than $B/2$, or we go below and then add $-A/2$ to which we cannot add more than $B/2$. However replacing H by H_k the red island is replaced by k smaller islands, and the difficulty vanishes as we have the choice to go above or below each island. More generally for k large enough, we may find an embedded curve isotopic to the zero section,

contained in the blue region of Figure 6 (where $H(k \cdot q, p) = 1$), with any given Liouville class in $[-1, 1]$. Thus, the curve yields an $L \in \mathcal{L}_p$ contained in $H_k = 1$ for any p in $[-1, 1]$. As a result, since obviously $\overline{H}_k = \overline{H}$, we have $\overline{H}(p) \geq 1$ for any p in $[-1, 1]$. Since obviously, $\overline{H}(p) = 0$ for $|p| > 1$, we get

- (1) $\overline{H}(p) = 1$ on $[-1, -1]$
- (2) $\overline{H}(p) = 0$ for $|p| > 1$

Remarks 15.1. (1) Note that here H is not continuous, so it is not surprising that \overline{H} isn't either.

- (2) The above example can be easily adapted to get homogenized Hamiltonians taking more than two values.
- (3) With some more work, one can compute the homogenization of any autonomous Hamiltonian on T^*S^1 .

15.3 Homogenized metric and Thurston-Gromov norm

First consider the case where H generates the geodesic flow of g : even though $H(q, p) = \langle g(q)p, p \rangle^{1/2} = |p|_g^2$ is not compactly supported, it is coercive, so we may define its homogenization according to Proposition 13.4. Then $T^n H_k$ generates the geodesic flow of the rescaled metric by the covering map

$$\begin{array}{ccc} T^n & \longrightarrow & T^n \\ q & \longrightarrow & kq \end{array}$$

of degree k^n .

It is well-known that if D is the distance defined by g on \mathbb{R}^n the universal cover of T^n (i.e. $D(x, y)$ is the length of the shortest geodesic for g connecting x to y in \mathbb{R}^n) and D_k the one defined by $g_k(q) = g(kq)$ (corresponding to H_k), again on \mathbb{R}^n , we have

$$D_k(x, y) = \frac{1}{k} D(kx, ky)$$

and

$$\lim_{k \rightarrow +\infty} D_k(x, y) = \overline{D}(x, y)$$

where \overline{D} is the distance associated to some flat Finsler metric \overline{g} (see [Ac-Butt], Theorem III.1). Since g_k is invariant by the \mathbb{Z}^n -action, g_k and hence D_k descend to a metric d_k on T^n , and similarly \overline{D} descends to a Finsler metric \overline{d} .

It is also well known that g_k does not converge to \overline{g} in any reasonable sense, except for the convergence of minimizers of the associated energy functional

$$E(\gamma) = \int_0^1 |\dot{\gamma}(t)|_g^2 dt$$

This phenomenon is related to the notion of Γ -convergence introduced by De Giorgi and his school in the 70's (cf. [de G, de G-F], [Dal M], [Br]). We shall denote by $L(\gamma)$, $L_k(\gamma)$, $\overline{L}(\gamma)$ the length of a curve for the respective metric d , d_k , \overline{d} . In particular we easily see that $\ell_k(\alpha)$, the length for d_k of the shortest closed geodesic in the homotopy class α (in $\pi_1(T^n) \simeq H_1(T^n) \simeq \mathbb{Z}^n$), $\ell_k(\alpha)$, converges

to $\bar{\ell}(\alpha)$, the length for \bar{d} of the shortest closed geodesic in the homotopy class α , $\bar{\ell}(\alpha)$. In other words, set

$$\mathcal{P}_\alpha = \{u \in C^\infty([0, 1], T^n) \mid [u] \in \alpha\}$$

and notice that this is the image by the projection of

$$\tilde{\mathcal{P}}_\alpha = \{u \in C^\infty([0, 1], \mathbb{R}^n) \mid u(t+1) = u(t) + \alpha\}$$

then

$$\ell_k(\alpha) = \inf_{x \in \mathcal{P}_\alpha} L_k(x) = \inf\{D_k(x, x + \alpha) \mid x \in \mathbb{R}^n\}$$

and since $D_k(x, x + \alpha)$ converges uniformly to $\bar{D}(x, x + \alpha)$, and x needs only to vary in a fundamental domain $[0, 1]^n$ in \mathbb{R}^n , we get that

$$\lim_{k \rightarrow +\infty} \ell_k(\alpha) = \bar{\ell}(\alpha)$$

But the class α contains at least a second closed geodesic, obtained by a minimax procedure (see [Birk], page 133). Indeed let $\beta \in H_1(T^n)$ be independent from α and $u : [0, 1]^2 \rightarrow \mathbb{R}^n$ be a smooth map. Set

$$\tilde{\mathcal{P}}_{\alpha, \beta} = \{u \in C^\infty([0, 1]^2, \mathbb{R}^n) \mid u(s, t+1) = u(s, t) + \alpha, u(s+1, t) = u(s, t) + \beta\}$$

Then there is a closed geodesic of length

$$\ell_k(\alpha, \beta) = \inf_{u \in \tilde{\mathcal{P}}_{\alpha, \beta}} \sup_{s \in [0, 1]} L_k(u_s)$$

where $u_s(t) = u(s, t)$, and similarly for $\bar{\ell}(\alpha, \beta)$. It is thus reasonable to ask whether

$$\lim_{k \rightarrow +\infty} \ell_k(\alpha, \beta) = \bar{\ell}(\alpha, \beta)?$$

The methods of our theorem imply a positive answer, since

$$\ell_k(\alpha, \beta)^2 = c(\beta, E)$$

that is $\ell_k(\alpha, \beta)$ is the homological minimax level associated to the 1-dimensional homology class of the free loop space that is the image of S^1 by $\theta \mapsto \beta(\theta) \cdot \alpha$ where “ \cdot ” denotes the addition law on the torus. We more generally can look at $\ell_k(\alpha, \beta)$ where $\beta \in H_k(T^n)$. Our results imply

Proposition 15.2. *We have*

$$\lim_{k \rightarrow \infty} \ell_k(\alpha, \beta) = \bar{\ell}(\alpha, \beta) = \bar{\ell}(\alpha)$$

Proof. The first statement is just Proposition 13.4 (or Proposition 14.4). The fact that $\bar{\ell}(\alpha, \beta) = \bar{\ell}(\alpha)$ follows from the fact that the Finsler metric \bar{d} is flat (i.e. invariant by translation on the torus), hence if $c(t)$ is a geodesic such that $c(t+1) = c(t) + \alpha$ and $\beta \in H_1(T^n) = \mathbb{Z}^n$ then $c_s(t) = c(t) + s\beta$ has length $\bar{L}(c_s)$, independent from s , so that taking $x(s, t) = c(t) + s\beta$ we see $\bar{\ell}(\alpha, \beta) = \bar{\ell}(\alpha)$ holds for $\beta \in H_1(T^n)$. The general case follows by using the Pontryagin product (see Proof of Proposition 8.2) to prove by induction that $\bar{\ell}(\alpha, \beta_1 \dots \beta_k) = \bar{\ell}(\alpha)$. Since any class in $H_k(T^n)$ is a linear combination of Pontryagin products, and because of the general fact that $c(a, f) = c(b, f)$ implies $c(a + b, f) = c(a, f) = c(b, f)$ we may conclude our proof. \square

Note that the analogous statement cannot hold for the whole length spectrum of g_k (i.e. the set of lengths of closed geodesics), as it is easy to construct examples for which the length spectrum of g_k becomes dense as k goes to infinity i.e. for any $\lambda \in \mathbb{R}_+$ and $\delta > 0$ there is k_0 in \mathbb{N} such that for all $k \geq k_0$, $\text{Spec}(g_k) \cap [\lambda - \delta, \lambda + \delta] \neq \emptyset$ (just add lots of small “blisters” to a flat metric), while the spectrum of \bar{g} is discrete.

Remember also that the Thurston-Gromov norm associated to g is defined as follows : for each homology class c in $H_1(T^n, \mathbb{R}) \simeq \mathbb{R}^n$, let us define $\|c\|_{TG}$ as follows. For c rational, that is $m \cdot c \in H_1(T^n, \mathbb{Z})$ for some integer m , $\|c\|_{TG} = \frac{1}{m} \ell(m \cdot c)$. The norm is then extended by density of the rationals.

The proof of the following result is then left to the reader:

Proposition 15.3. *The Thurston-Gromov norm coincides with the symplectic homogenization of the metric.*

16 Further questions

Sergei Kuksin pointed out that the homogenization or averaging described here is a “dequantized averaging”, in the sense that the traditional homogenization is concerned with the limit of the “quantized Hamiltonian”, $H(\frac{x}{\varepsilon}, D_x)$ as ε goes to zero. By this we mean a Partial differential operator with principal symbol $H(\frac{x}{\varepsilon}, p)$ operating on the set of smooth functions on T^n or \mathbb{R}^n . Here, on the other hand, we deal directly with the “classical Hamiltonian” $H(\frac{x}{\varepsilon}, p)$. It is natural to ask whether there is a connection between quantized and dequantized averaging, or to use a simpler language, between the homogenization of an operator, and the symplectic homogenization of its symbol. We may already consider the simple case of the previous section: according to the classical theory of Γ -convergence, the limiting operator of the Laplacians associated to the metric g_k converges to some elliptic operator, denoted Δ_∞ . But Δ_∞ is not in general equal to the Laplacian of the metric g_∞ . First of all g_∞ is not Riemannian, but only Finslerian. Moreover, it seems that g_∞ detects changes in the metric on small sets: typically a three-dimensional torus with a metric made small along three geodesic circles in three orthogonal directions will have a much smaller g_∞ than one without such “short directions“. But the Laplacian will not detect this, since the Brownian motion will not see such lines. So the only reasonable question is whether the metric g_∞ determines the Laplacian Δ_∞ .

One may ask a more general question, that is

Question 16.1. Assume the sequence $(H_\nu)_{\nu \geq 1}$ converges to H for the γ -topology. Does the spectrum— or some quantity defined using the spectrum— of the operators $H_\nu(x, D_x)$ converge to the spectrum — or some quantity defined using the spectrum — of $H(x, D_x)$?

17 Appendix

A Capacity of completely integrable systems

Our goal is to prove the following

Proposition A.1. *Let φ^1 be the time-one flow associated to the continuous, compactly supported Hamiltonian, $h(p)$, defined on $T^*\mathbb{T}^n$. Then*

$$c_+(\varphi^1) = \sup_p h(p) \quad , \quad c_-(\varphi^1) = \inf_p h(p)$$

$$\gamma(\varphi^1) = c_+(\varphi^1) - c_-(\varphi^1) = \operatorname{osc}_p h$$

As a result, a continuous compactly supported and integrable Hamiltonian has generalized flow equal to Id if and only if it is identically zero.

Proof. We shall only consider smooth Hamiltonians, the general case follows by density of compactly supported smooth Hamiltonians for the γ -topology in the set of continuous compactly supported ones (since density already holds for the C^0 metric). Set $\varphi^t(q, p) = (Q_t(q, p), P_t(q, p))$, then the graph of φ_t defines a Lagrangian submanifold Γ_t in $T^*(T^n \times \mathbb{R}^n)$ as the image of $(q, P) \mapsto (\frac{q+Q_t}{2}, \frac{p+P_t}{2}, p - P_t, Q_t - q)$. Note that even though Q_t is in T^n , $Q_t - q$ has a unique lift to \mathbb{R}^n which is continuous in t and equals 0 for $t = 0$. The same argument allows us to define $\frac{q+Q_t}{2} = q + \frac{Q_t - q}{2}$.

Moreover, if we set $x = \frac{q+Q_t}{2}$, $y = \frac{p+P_t}{2}$, $\xi = p - P_t$, $\eta = Q_t - q$, the symplectic form is given by $d\xi \wedge dx + d\eta \wedge dy$. In our situation, we have

$$x_t = q + \frac{t}{2}h'(p) \quad y_t = p \quad \xi_t = 0 \quad \eta_t = h'(p)$$

Thus if we set $f_t(x, y) = th(y)$, we have

$$\xi_t = \frac{\partial}{\partial x} f_t(x, y) \quad , \quad \eta_t = \frac{\partial}{\partial y} f_t(x, y)$$

that is f_t is a generating function of Γ_t with no ‘‘fiber variables’’. As we mentioned in Remark 4.4 (3)

$$c_+(\varphi^t) = \sup f_t \quad , \quad c_-(\varphi^t) = \inf f_t$$

$$\gamma(\varphi^t) = \sup_{(x,y)} f_t - \inf_{(x,y)} f_t$$

Since $f_1(x, y) = h(y)$ this proves our proposition. □

The following applies the ideas of [Hu] section 4.4 page 390 and [Hu2] section 3.3. For a continuous Hamiltonian, H , we define its ‘‘generalized flow’’ to be the image of H by the extension of $H \mapsto \varphi_H^1$ as a map from $\widehat{\mathcal{H}}_c(T^*M)$ to $\widehat{\mathcal{H}}_c(T^*M)$.

Corollary A.2. *The following assertions hold*

- (1) *If $h_1(p)$ and $h_2(p)$ are compactly supported, continuous, and have the same ‘‘generalized’’ time-one flow (in $\widehat{\mathcal{H}}_c(T^*T^n)$) then $h_1 = h_2$.*
- (2) *If $h_1(p), h_2(p)$ are continuous and compact-supported, and have generalized flows (in $\widehat{\mathcal{H}}_c(T^*T^n)$) φ_1^t, φ_2^t , then $h_1(p) + h_2(p)$ has generalized flow $\varphi_1^t \circ \varphi_2^t$. As a consequence $\varphi_1^t \circ \varphi_2^t = \varphi_2^t \circ \varphi_1^t$. In particular if φ^t is the flow associated to $h(p)$, φ^{-t} is the flow associated to $-h(p)$.*

Proof. Proof of (1).

Indeed, according to the above Proposition, we have

$$\gamma(\varphi_1^t(\varphi_2^t)^{-1}) = t \operatorname{osc}_p(h_1 - h_2)$$

since according to the above proposition this is true for smooth h_1, h_2 , and we conclude by density of compactly supported smooth functions in the set of compactly supported continuous functions. Therefore $\varphi_1^1 = \varphi_2^1$ implies $h_1 = h_2$.

Proof of (2).

Let $h_{k,1}(p), h_{k,2}(p)$ be smooth sequences C^0 -converging to $h_1(p), h_2(p)$ respectively. This implies that these sequences γ -converge. Now the corresponding time-one flows, $\varphi_{k,1}^1, \varphi_{k,2}^1$ commute so that $h_{k,1}(p) + h_{k,2}(p) = h_k(p)$ has flow $\varphi_{k,1}^1 \circ \varphi_{k,1}^1$, and since the γ -limit of $\varphi_{k,1}^1 \circ \varphi_{k,1}^1$ is $\varphi_1 \circ \varphi_2$, we get that $h(p) = h_1(p) + h_2(p)$. The commutativity of the addition, implies the commutativity of the flows. Finally, the flow of the zero Hamiltonian being the identity, the last claim follows. \square

B Some “classical” inequalities

Our goal here is to prove the following results:

Proposition B.1. *Let $S_1(x, \xi), S_2(x, \eta)$ be two GFQI and $S_{1,x}(\xi) = S(x, \xi)$, $S_{2,x}(\eta) = S_2(x, \eta)$.*

Then

$$|c(1_x, S_{1,x}) - c(1_x, S_{2,x})| \leq \gamma(S_1, S_2)$$

Proposition B.2. *For a Hamiltonian isotopy φ^t on T^*T^n , and L Hamiltonian isotopic to the zero-section, we have*

$$\gamma(\varphi^1(L), L) \leq \gamma(\varphi^1).$$

Note that the isotopy may be assumed to be compactly supported, since we may truncate the Hamiltonian outside the compact set $\bigcup_{t \in [0,1]} \varphi^t(L)$.

Proposition B.3. *Let S be a GFQI, $\alpha \in H^k(M)$ and $a \in H_k(M)$. Then*

$$c(\alpha, S) = \inf \{c(a, S) \mid a \in H_k(M), \langle \alpha, a \rangle \neq 0\}.$$

$$c(a, S) = \sup \{c(\alpha, S) \mid \alpha \in H^k(M), \langle \alpha, a \rangle \neq 0\}.$$

In particular $c(1, S) = c([pt]_M, S)$ and $c(\mu_M, S) = c([M], S)$.

As a result, we have for any nonzero α in $H^(M)$*

$$|c(\alpha, \varphi_1) - c(\alpha, \varphi_2)| \leq \gamma(\varphi_1, \varphi_2).$$

Proof of proposition B.1. It is important to notice that all formulas or inequalities we shall use in the proof are established in [V1] for any GFQI, and not only those associated to an embedded Lagrangian submanifold.

Indeed, we have according to [V1], prop. 3.3, p. 693 the formula

$$c(u \cdot v, S_1 \oplus S_2) \geq c(u, S_1) + c(v, S_2)$$

where $S_1 \oplus S_2(x, \xi_1, \xi_2) = S_1(x, \xi_1) + S_2(x, \xi_2)$. We then apply this inequality to the generator $u = v = 1_x$ of $H^0(\{x\})$ (which is its own Poincaré dual) and we get

$$c(1_x, S_{1,x} \ominus S_{2,x}) \geq c(1_x, S_{1,x}) + c(1_x, -S_{2,x})$$

But by [V1], prop. 2.7, p. 692, we have

$$c(1_x, -S_{2,x}) = -c(1_x, S_{2,x})$$

thus

$$c(1_x, S_{1,x} \ominus S_{2,x}) \geq c(1_x, S_{1,x}) - c(1_x, S_{2,x})$$

Similarly we have

$$c(1_x, S_{1,x} \ominus S_{2,x}) \leq c(1_x, S_{1,x}) + c(1_x, -S_{2,x}) = c(1_x, S_{1,x}) - c(1_x, S_{2,x})$$

Now since $(S_1 \ominus S_2)_x(\xi_1, \xi_2) = S_{1,x}(\xi_1) - S_{2,x}(\xi_2)$ and $\gamma(L_1, L_2) = \gamma(S_1 \ominus S_2)$, we have by the reduction inequality ([V1], prop. 5.1 p. 705)

$$c(1_x, S_{1,x} \ominus S_{2,x}) \leq \gamma(S_1 \ominus S_2) = \gamma(L_1, L_2)$$

and our claim follows. \square

Proof of proposition B.2. Indeed, $\varphi(0_{T^n})$ is the symplectic reduction of

$$\tilde{\Gamma}(\varphi) = \{(q, p, Q, P) \mid (Q, P) = \varphi(q, p)\}$$

by the coisotropic submanifold, $N_p = \{p = 0\}$. The symplectic map

$$(q, p, Q, P) \longrightarrow (Q, p, p - P, Q - q) = (u, v, U, V)$$

sends N_p to $N_v = \{v = 0\}$. The reduction inequality in [V1] (prop. 5.1, page 705) and the fact that $\varphi(L) = \tilde{\Gamma}(\varphi) \cap N_v / N_v^\omega$, then implies

$$\gamma(\varphi(L)) \leq \gamma(\tilde{\Gamma}(\varphi)) = \gamma(\varphi)$$

Now if $L = \rho(0_{T^n})$, we have

$$\gamma(\varphi(L), L) = \gamma(\varphi(\rho(0_{T^n}), \rho(0_{T^n})) = \gamma(\rho^{-1}\varphi\rho(0_{T^n})) \leq \gamma(\rho^{-1}\varphi\rho) = \gamma(\varphi)$$

where the second and last equality follow by symplectic invariance of γ , while the inequality has been proved above. \square

Proof of Proposition B.3. Let us denote by T the Thom isomorphism, and by T^* its homological counterpart. Let $a \in H_k(M)$ and T^*a its image in $H_{k+d}(E^{+\infty}, E^{-\infty})$, and for $\alpha \in H^k(M)$ and $T\alpha$ its image in $H^{k+d}(E^{+\infty}, E^{-\infty})$.

Now, considering the $(k + d)$ -cohomology group as the dual of the $(k + d)$ -homology group (we work with coefficients in a field), we have the following diagram

$$\begin{array}{ccc} H_{k+d}(E^\lambda, E^{-\infty}) & \xrightarrow{i_\lambda} & H_{k+d}(E^{+\infty}, E^{-\infty}) \\ & \searrow i_\lambda^*(Tu) & \downarrow Tu \\ & & \mathbb{R} \end{array}$$

and we have $i_\lambda^*(T\alpha) \neq 0$ if and only if there is $T^*a \in \text{Im}(i_\lambda)$ such that $\langle T\alpha, T^*a \rangle \neq 0$.

Since $\langle T\alpha, T^*a \rangle = \langle \alpha, a \rangle$ we have the inequality $\lambda \geq c(a, L)$ if and only if there exists α such that $\langle \alpha, a \rangle \neq 0$, and $\lambda \geq c(\alpha, L)$: this follows immediately from the universal coefficient theorem ($H^k(M)$ is the dual of $H_k(M)$). In other words we proved that

$$(*) \quad c(a, L) = \sup\{c(\alpha, L) \mid \langle \alpha, a \rangle \neq 0\}$$

This proves the first statement. Similarly we have the inequality $\lambda \geq c(\alpha, S)$ if and only if there exists a such that $\langle \alpha, a \rangle \neq 0$, and $\lambda \geq c(a, S)$, so

$$c(\alpha, S) = \inf\{c(a, S) \mid \langle \alpha, a \rangle \neq 0\}$$

Now by [V1] (prop. 2.7, page 692), if $b \in H_{n-k}(M), \alpha \in H^k(M)$ are Poincaré dual classes²⁴, we have the identity $c(\alpha, S) = -c(a, \bar{S})$. Moreover from the same paper (prop. 3.3 page 693) we see that $c(\alpha \cdot \beta, S_1 \ominus S_2) \geq c(\alpha, S_1) + c(\beta, \bar{S}_2)$.

So for $b \in H_{n-k}(M)$ and $\alpha \in H^k(M)$ be Poincaré dual classes we may write, using (*)

$$\begin{aligned} c(\alpha, S_1) - c(\alpha, S_2) &= c(\alpha, S_1) + c(b, \bar{S}_2) = \\ c(\alpha, S_1) + \sup\{c(\beta, \bar{S}_2) \mid \langle \beta, b \rangle \neq 0\} &= \sup\{c(\alpha, S_1) + c(\beta, \bar{S}_2) \mid \alpha \cup \beta \neq 0\} \leq \\ \sup\{c(\alpha \cdot \beta, S_1 \ominus S_2) \mid \alpha \cdot \beta \neq 0\} & \end{aligned}$$

Since $\alpha \in H^k(M), \beta \in H^{n-k}(M), \alpha \cdot \beta \neq 0$ implies that $\alpha \cdot \beta$ is a multiple of the orientation class μ , hence, the last term in the above equals to $c(\mu, S_1 \ominus S_2)$. We finally proved

$$c(\alpha, S_1) - c(\alpha, S_2) \leq c(\alpha \cdot \beta, S_1 \ominus S_2) = c(\mu, S_1 \ominus S_2)$$

Using the fact that $c(\mu, S_2 \ominus S_1) = -c(1, S_1 \ominus S_2)$, we get exchanging S_1 and S_2

$$c(\alpha, S_2) - c(\alpha, S_1) \leq c(\mu, S_2 \ominus S_1) = -c(1, S_1 \ominus S_2)$$

that is

$$c(\alpha, S_1) - c(\alpha, S_2) \geq c(1, S_1 \ominus S_2)$$

so that finally

$$c(1, S_1 \ominus S_2) \leq c(\alpha, S_1) - c(\alpha, S_2) \leq c(\mu, S_1 \ominus S_2)$$

²⁴This means for all $\beta \in H^{n-k}(M)$ we have $\langle \beta, b \rangle = \langle \alpha \cup \beta, [M] \rangle$

Since in our case S_1, S_2 are GFQI for $\bar{\Gamma}(\varphi_1), \bar{\Gamma}(\varphi_2)$, we have $c(1, S_1 \ominus S_2) \leq 0 \leq c(\mu, S_1 \ominus S_2)$, so the above inequality implies

$$\begin{aligned} |c(\alpha, \varphi_1) - c(\alpha, \varphi_2)| &= |c(\alpha, S_1) - c(\alpha, S_2)| \leq \\ c(\mu, S_1 \ominus S_2) - c(1, S_1 \ominus S_2) &= \gamma(S_1, S_2) = \gamma(\varphi_1, \varphi_2) \end{aligned}$$

□

C A different type of homogenization

As has been pointed out to me by M. Bardi and F. Cardin, the Hamilton-Jacobi homogenization is often applied to the sequence $H(x, \varepsilon^{-1}x, p)$: we seek the limit as ε goes to zero of

$$(HHJ_\varepsilon) \quad \begin{cases} \frac{\partial}{\partial t} u(t, x) + H(x, \varepsilon^{-1}x, \frac{\partial}{\partial x} u(t, x)) = 0 \\ u(0, x) = f(x) \end{cases}$$

This seems to be more general than the case we deal with. However we prove here that this problem can be reduced to the case we studied.

Let indeed $K(x, y, p_x, p_y)$ be the Hamiltonian on $T^*(T^n \times T^n)$ defined by $K(x, y, p_x, p_y) = H(x, y, p_x + p_y)$.

Remark C.1. Note that even if H is compactly supported, K is not, since the map $(p_x, p_y) \mapsto p_x + p_y$ is not proper. However K is C^2 bounded, and this is enough to carry on symplectic homogenization as in Sections 6,7 and 8.

We claim that the equation

$$(1) \quad \frac{\partial}{\partial t} u(t, x) + H(x, x, \frac{\partial}{\partial x} u(t, x)) = 0$$

is satisfied by $u(t, x) = v(t, x, x)$ where v is the variational solution of

$$(2) \quad \frac{\partial}{\partial t} v(t, x, y) + K(x, y, \frac{\partial}{\partial x} v(t, x, y), \frac{\partial}{\partial y} v(t, x, y)) = 0$$

Indeed this can be rewritten for $x = y$ as

$$\frac{\partial}{\partial t} v(t, x, x) + H(x, x, \frac{\partial}{\partial x} v(t, x, x) + \frac{\partial}{\partial y} v(t, x, x)) = 0$$

and since

$$\frac{\partial}{\partial x} u(t, x) = \frac{\partial}{\partial x} v(t, x, x) + \frac{\partial}{\partial y} v(t, x, x)$$

this proves our claim.

Now we may replace K by

$$K_\varepsilon(x, y, p_x, p_y) = H(x, \frac{y}{\varepsilon}, p_x + p_y) = H_\varepsilon(x, y, p_x + p_y)$$

and we shall get solutions of the equation

$$\frac{\partial}{\partial t} u_\varepsilon(t, x) + H(x, \varepsilon^{-1}x, \frac{\partial}{\partial x} u_\varepsilon(t, x)) = 0.$$

However we have to prove that

Proposition C.2. *If v is a variational solution of (2), then $u(t, x) = v(t, x, x)$ is variational solution of (1).*

Proof. Indeed it is enough to prove that if L is a Lagrangian submanifold containing the isotropic submanifold

$$I_f = \left\{ (t, -K(x, y, \frac{\partial f}{\partial x}, \frac{\partial f}{\partial y}), \frac{\partial f}{\partial x}, \frac{\partial f}{\partial y}) \right\}$$

and such that L is contained in

$$\{(t, \tau, x, y, p_x, p_y) \mid \tau + K(t, x, y, p_x, p_y) = 0\}$$

then its symplectic reduction by $x = y$ is a Lagrangian submanifold, L_Δ , contained in

$$\{(t, \tau, x, p_x) \mid \tau + H(t, x, x, p_x) = 0\}$$

and L_Δ contains

$$I_g = \left\{ (t, -H(x, x, \frac{\partial g}{\partial x}(x)), \frac{\partial g}{\partial x}(x)) \right\}$$

where $g(x) = f(x, x)$.

This is rather straightforward to check, and is a consequence of the commutation relation $\{x - y, p_x + p_y\} = 0$.

Finally we notice that if $S(t, x, y, \xi)$ is a GFQI for L , then $v(t, x, y) = c(1_{t,x,y}, S)$, while the reduction L_Δ of L by $x = y$ has for GFQI the function $S_\Delta = S(x, x, \xi)$, so that $u(t, x) = c(1_{t,x}, S_\Delta) = c(1_{t,x,x}, S) = v(t, x, x)$. This concludes our proof. \square

Corollary C.3. *Let $H(x, y, p)$ be a compactly supported function on $T^n \times T^n \times (\mathbb{R})^n$. Set $K(x, y, p_x, p_y) = H(x, y, p_x + p_y)$, and let $\bar{K}(x, p_x, p_y)$ be the homogenization of K with respect to the y variable (i.e. $\bar{K}(x, p_x, p_y)$ is the γ -limit of $K_\varepsilon(x, y, p_x, p_y) = K(x, \frac{y}{\varepsilon}, p_x, p_y)$). Then $\bar{H}(x, p) = \bar{K}(x, p, 0)$ is such that a sequence $(v_\varepsilon)_{\varepsilon > 0}$ of variational solutions of*

$$\frac{\partial}{\partial t} v(t, x) + H(x, \varepsilon^{-1}x, \frac{\partial}{\partial x} v(t, x)) = 0$$

C^0 -converges to a variational solution of

$$\frac{\partial}{\partial t} v(t, x) + \bar{H}(x, \frac{\partial}{\partial x} v(t, x)) = 0$$

Proof. The only missing fact is to show that $\bar{K}(x, p_x, p_y)$ can be written as $\bar{H}(x, p_x + p_y)$ (if this is the case, we recover \bar{H} by $\bar{H}(x, p) = \bar{K}(x, p, 0)$). We claim that this amounts to proving that the x_j being coordinates on the first torus, and y_j the same coordinate on the second torus, the function $x_j - y_j$ commutes²⁵ with \bar{K} , knowing it commutes with K_ε . The result follows from the fact that this commutation relation goes to the γ -limit. If φ_j^t is the flow of $x_j - y_k$, and ψ_ε^t the flow of K_ε , the relation $\psi_\varepsilon^t \circ \varphi_j^t \circ \psi_\varepsilon^{-t} = \varphi_j^t$ implies for $\bar{\psi}^t = \gamma - \lim_{\varepsilon \rightarrow 0} \psi^t$ that $\bar{\psi}^t \circ \varphi_j^t \circ \bar{\psi}^{-t} = \varphi_j^t$. \square

²⁵Of course $x_j - y_j$ is only defined in S^1 , but this is equivalent to claiming that for any function f on S^1 , $f(x_j - y_j)$ commutes with \bar{K} , provided it commutes with K_ε .

Lemma C.4. *Let H be a compactly supported smooth Hamiltonian and $(K_j)_{j \geq 1}$ a sequence of Hamiltonians commuting with H and γ -converging to a continuous Hamiltonian K_∞ . Then H and K_∞ γ -commute in the following sense*

$$K_\infty(\varphi_H^t) = K_\infty$$

where φ_H^t is the flow of H . In particular if the K_j commute with the functions $x_j - y_j$ then so does K_∞ , and $K_\infty(x, p_x, p_y)$ only depends on $(x, p_x + p_y)$.

Proof. Indeed, the flow of K_j being ψ_j^t we have that $\varphi_H^t \psi_j^s \varphi_H^{-t}$ γ -converges to $\varphi_H^t \psi_\infty^s \varphi_H^{-t}$, hence our first result. Now the flow of $x_j - y_j$ is given by

$$(x, y, p_x, p_y) \longrightarrow (x, y, p_x + te_j, p_y + te_j)$$

Now a continuous Hamiltonian commuting with the functions $x_j - y_j$ only depends on $p_x + p_y$. Indeed it is easy to show that for all t , $K_j(x, y, p_x + te_j, p_y - te_j) = K_j(x, y, p_x, p_y)$ hence γ -converges to both $\overline{K}(x, p_x + te_j, p_y - te_j)$ and $\overline{K}(x, p_x, p_y)$. Thus by uniqueness of the limit, for all t and j , $\overline{K}(x, p_x, p_y) = \overline{K}(x, p_x + te_j, p_y - te_j)$. This is equivalent to the property that \overline{K} is a function of $(x, p_x + p_y)$. \square

D Generating function for Euler-Lagrange flows

Let N be a compact manifold. The goal of this appendix is to prove that if the Hamiltonian $H(t, q, p)$ is strictly convex in p and its flow is complete, then $\varphi^t(0_N)$ has a GFQI equal to a positive definite quadratic form at infinity. The same property holds for the graph of φ^t . We remind the reader that using the Legendre transform, the flow of H can be identified with the Euler-Lagrange flow associated to the Legendre dual of H , $L(t, q, \xi)$, where

$$L(t, q, \xi) = \sup\{\langle p, \xi \rangle - H(t, q, p) \mid p \in T_q^*N\}.$$

The definition of Tonelli Lagrangians can be found in Definition 14.3.

Proposition D.1. *Let $L(t, q, \xi)$ be a Tonelli Lagrangian defined on $\mathbb{R} \times TN$, 1-periodic in t . Let φ^t be the flow of the corresponding Hamiltonian $H(t, q, p)$ defined on $\mathbb{R} \times T^*N$. Then $\Lambda = \varphi^1(0_N)$ has a generating function equal to a positive definite quadratic form outside a compact set. As a consequence, if we denote by $S(q, \xi)$ this function, we have $c(1_q, \Lambda) = \inf_{\xi \in \mathbb{R}^q} S(q, \xi)$ and $c(1, \Lambda) = \inf_{(q, \xi) \in T^n \times \mathbb{R}^q} S(q, \xi)$.*

Proof. Using Brunella's idea of embedding T^*N into T^*T^n (cf. [Bru]) we only need to prove this for a Lagrangian defined on the torus (this is the only case we use here anyway).

Thus consider a general Lagrangian $L(t, q, \xi)$ and the corresponding Hamiltonian $H(t, q, p)$. If we look for intersection points $\varphi^1(0_N) \cap 0_N$, we can modify H outside a compact set, so that $\widehat{H}(t, q, p) = C|p|^2$ outside a compact set, \widehat{H} is still strictly convex and for t in $[0, 1]$, $\varphi^t(0_N)$ is unchanged. There is thus a corresponding "truncated" Lagrangian \widehat{L} . We still denote by L the truncated Lagrangian in the sequel. Note that this is automatically a Tonelli Lagrangian.

Consider the set $W = \{(q_1, q_2) \in \mathbb{R}^n \times \mathbb{R}^n\} / \simeq$ where $(q_1, q_2) \simeq (q_1 + \nu, q_2 + \nu)$ for $\nu \in \mathbb{Z}^n$ and we have the projection $W \rightarrow T^n$ on the first component, with

fiber \mathbb{R}^n . We sometimes denote by (q, x) an element in W with projection q , and $x = q_2 - q_1 \in \mathbb{R}^n$ which is well defined in \mathbb{R}^n .

Consider for $(q_1, q_2) \in W$

$$A(q_1, q_2) = \inf \left\{ \int_0^1 L(s, q(s), \dot{q}(s)) dt \mid q : [0, 1] \rightarrow \mathbb{R}^n, q(0) = q_1, q(1) = q_2 \right\}$$

The existence of a critical point of the energy $E(q) = \int_0^1 L(s, q(s), \dot{q}(s)) dt$ on the set $\mathcal{P}(q_1, q_2) = \{q : [0, 1] \rightarrow \mathbb{R}^n \mid q(0) = q_1, q(1) = q_2\}$ of paths connecting q_1, q_2 is equivalent, by the standard methods of the calculus of variations, to the existence of a point in $\varphi^1(\{q_1\} \times \mathbb{R}^n) \cap \{q_2\} \times \mathbb{R}^n$. For $L(t, q, p) = L^0(t, q, p) = \frac{C}{2}|p|^2$, the corresponding maps is given by $\varphi_0^1(q, p) = (q + Cp, p)$, hence $\varphi_0^1(\{q_1\} \times \mathbb{R}^n) = \{(q_1 + Cp, p) \mid p \in \mathbb{R}^n\}$ and this intersects transversally at a unique point all other $\{q_2\} \times \mathbb{R}^n$. This will still hold for a C^1 -small compactly supported perturbation of φ_0^1 , hence for a general L as above, provided t is small enough, the minimizer realizing $A(q_1, q_2)$ is unique.

Lemma D.2. *Let L be a Lagrangian such that $L(t, q, \xi) = C|\xi|^2$ for ξ large enough. Then for t small enough, we have that for any q_1, q_2 , the function $E_t(\gamma) = \int_0^t L(s, q(s), \dot{q}(s)) dt$ has a unique critical point $\gamma : [0, t] \rightarrow \mathbb{R}^n$, depending continuously on (q_1, q_2) . Moreover this unique critical point is a minimum and for $|q_2 - q_1|$ large enough, the critical value $A_t(q_1, q_2) = \frac{C}{2t}|q_2 - q_1|^2$ is quadratic positive definite in $q_2 - q_1$.*

The existence of a minimum of E_t on $\mathcal{P}(q_1, q_2)$ implies that if uniqueness and transversality hold, the only critical point of E is a minimum, and A_t is a smooth function of (q_1, q_2) .

Proof. For simplicity we may assume $C = 1$. Let φ^t be the flow associated to H , the Legendre dual of L , and $\pi : T^*\mathbb{R}^n \rightarrow \mathbb{R}^n$ be the projection. We claim that for t small enough, $\zeta^t = \pi \circ \varphi^t : \{q\} \times \mathbb{R}^n \rightarrow \mathbb{R}^n$ is a diffeomorphism. Indeed, we claim that

- (1) For $|p|$ large enough (independently of t), $\varphi^t(q, p) = q + tp$
- (2) For t small enough $D\zeta^t(q, p)$ is invertible.

The first claim is clear: if $H(t, q, p) = |p|^2$ for $|p| \geq r$, then for $|p| \geq r$, we have $\varphi^t(q, p) = q + tp$. The second claim only needs to be checked for $|p| \leq r$. Let us compute

$$\begin{aligned} \frac{d}{dt}(D\varphi^t(q, p))|_{t=t_0} &= D\left(\frac{d}{dt}\varphi^t(q, p)\right)|_{t=t_0} = D(X_H(\varphi^{t_0}(q, p))) = \\ &DX_H(\varphi^{t_0}(q, p))D\varphi^{t_0}(q, p) \end{aligned}$$

so if $M(t) = D\varphi^t(q, p)$ we have

$$\frac{d}{dt}M(t) = DX_H(\varphi^{t_0}(q, p))M(t)$$

and

$$D(\pi \circ \varphi^t)(q, p)|_{\{0\} \times \mathbb{R}^n} = D\pi(\varphi^t(q, p))D\varphi^t(q, p)|_{\{0\} \times \mathbb{R}^n} = D\pi \circ M(t)|_{\{0\} \times \mathbb{R}^n}$$

Now

$$M(t) = M(0) + tDX_H(q, p) + o(t)$$

and $X_H(q, p) = \left(\frac{\partial H}{\partial p}, -\frac{\partial H}{\partial q} \right)$ so that

$$DX_H(q, p) = \begin{pmatrix} \frac{\partial^2 H}{\partial p \partial q} & -\frac{\partial^2 H}{\partial q^2} \\ \frac{\partial^2 H}{\partial p^2} & -\frac{\partial^2 H}{\partial p \partial q} \end{pmatrix}$$

and

$$D\pi \circ DX_H(q, p)|_{\{q\} \times \mathbb{R}^n} = \frac{\partial^2 H}{\partial p^2}$$

As a result, denoting $S(t) = D\pi \circ M(t)|_{\{0\} \times \mathbb{R}^n}$ we get

$$S(t) = S(0) + t \frac{\partial^2 H}{\partial p^2}(q, p) + o(t)$$

and since $S(0) = 0$ and the reminder $o(t)$ is uniform on any set bounded in p (since it will be bounded, by Taylor's formula by higher derivatives of H which are periodic in q), we get that for t small enough, $S(t)$ will be invertible for $|p| \leq r$. This concludes the proof of (2).

We thus know that the map $\pi \circ \varphi^t$ is equal to $q + t \cdot \text{Id}$ outside a compact set, and has invertible differential. It is a classical calculus exercise to conclude that such a map is a diffeomorphism. This means that given q_1 for every q_2 there is a unique critical point of $\gamma \mapsto E_t(\gamma)$, which is necessarily a minimum, since we know by the Tonelli condition implies that there is a minimum. Moreover the map $q_2 \mapsto P(q_2)$ where $P(q_1, q_2)$ is the unique point such that $\pi \varphi^t(q_1, P(q_1, q_2)) = q_2$. Finally for $q_2 - q_1$ large enough, the path $q(t) = q_1 + \frac{s}{t}(q_2 - q_1)$ is a critical point of E on $\mathcal{P}(q_1, q_2)$. \square

Now let N be chosen large enough so that $\varphi^{\frac{k+1}{N}} \varphi^{-\frac{k}{N}}$ satisfy the conclusions of the above lemma (i.e. $t = 1/N$ is small enough in the sense of the previous lemma). Let $A_k(q, q')$ be the minimum of the energy corresponding to $L(t, q, \xi)$ for $t \in [\frac{k}{N}, \frac{k+1}{N}]$. Then, consider the function focused

$$S(q_1; q_2, q_3, \dots, q_N) = A_0(q_1, q_2) + A_1(q_2, q_3) + \dots + A_{N-1}(q_{N-1}, q_N).$$

One easily checks that S is a generating function for $\varphi^1(0_{T^n})$. Moreover it is asymptotically quadratic in the sense that it satisfies the assumptions of proposition 1.6 page 441 of [V3], and this proves that S can be deformed into a GFQI equal to a positive definite quadratic form generating the same Lagrangian (see loc. cit. prop 1.6 and the proof of theorem 1.7). \square

E Relationship with [M-V-Z]

The paper [M-V-Z] contains a slightly different approach to symplectic homogenization : it is focused on the behavior of the Lagrangians L_{p_0} by iterations of φ_H . They also make use of Floer homology, but this does not really matter, as we could use Generating Function homology (see [Traynor], and [V2] for the

equivalence of the two). We here briefly relate their definition with ours. Their version of homogenization (see the proof of theorem 1.3) is defined by

$$\mu_p(\varphi) = \lim_{k \rightarrow \infty} \frac{1}{k} c_+(\tau_{-p} \varphi^k(\tau_p(0_N)))$$

We claim

Proposition E.1. *Let φ be the time-one flow of a compactly supported smooth Hamiltonian H . Let \bar{H} be defined in our Main Theorem. Then we have $\mu_p(\varphi) = \bar{H}(p)$.*

Lemma E.2. *Let $H(p)$ be an integrable Hamiltonian. Then we have setting $L_{p_0} = \{(x, p_0) \mid x \in T^n\}$ that $FH^*(\varphi_H(L_{p_0}), L_{p_0}; a, b) = H^*(T^n)$ if $H(p_0) \in]a, b]$ and vanishes otherwise.*

Proof. Indeed, the flow is given by $(x, p) \mapsto (x + t\nabla H(p), p)$ and we have that $FH^*(\varphi_H(L_{p_0}), L_{p_0}; a, b) = FH^*(L_{p_0}, L_{p_0}, H; a, b)$ where the second homology is obtained by taking trajectories of X_H and the action of a trajectory is $\int_0^1 p dx - H dt = p_0 \nabla H(p_0) - H(p_0)$. Note that for $p_0 = 0$ we get $-H(0)$. For a general p_0 , replacing H by $K_{p_0}(p) = H(p + p_0)$ we get that $FH^*(L_0, L_0, K_{p_0}; a, b)$ is non zero if and only if $-K(0) = -H(p_0) \in]a, b]$. Note that if τ_{p_0} is the vertical translation by p_0 , we have $\varphi_{K_{p_0}} = T_{-p_0} \varphi_H T_{p_0}$. \square

Proof of Proposition E.1. Now let H be a smooth compact supported Hamiltonian. Setting $\varphi_k = \rho_k^{-1} \varphi_H^k \rho_k$, according to our Main Theorem, φ_k γ -converges to $\bar{\varphi}$ and since τ_{p_0} and ρ_k commute, the sequence $(\frac{1}{k} c_+(\tau_{-p_0} \varphi_k \tau_{p_0}(0_N), 0_N))_{k \geq 1}$ converges to $c_+(\bar{\varphi}(L_{p_0})) = \bar{H}(p_0)$. This uses the fact that the map

$$Ham(T^*N) \times \mathcal{L}(T^*N) \longrightarrow \mathcal{L}(T^*N)$$

given by

$$(\varphi, L) \mapsto \varphi(L)$$

extends by continuity to

$$\widehat{Ham}(T^*N) \times \widehat{\mathcal{L}}(T^*N) \longrightarrow \widehat{\mathcal{L}}(T^*N)$$

(see [Hu], prop. 4.3). \square
