# Incidence algebra of a presentation

#### Abstract

In this paper we construct an incidence algebra of a poset associated to a presentation by a quiver and relations of a finite dimensional algebra. We provide an exact sequence relying the fundamental groups of the incidence algebra and the presentation. Moreover, we give an algoritm to calculate any fundamental group.

One of the main tools for the study of the category of finite dimensional modules over a basic algebra, over an algebraically closed field $k$ is its presentation by a quiver and relations. This theory is mainly due to P. Gabriel. More precisely, it is well known that for each finite dimensional and basic algebras over an algebraically closed field $k$, there exists a unique quiver $Q$ and an admissible ideal $I$ of the path quiver algebra $k Q$, such that $A$ is isomorphic to $k Q / I$. Such a couple $(Q, I)$ is called a presentation of $A$ by quiver and relations. For each presentation $(Q, I)$, we can construct an algebraic fundamental group $\Pi_{1}(Q, I)$.

Il has been proved (see [Rey] or [Bus]) that the fundamental group of an incidence algebra has a topological interpretation. Indeed, the algebraic fundamental group is isomorphic to a topological fundamental group of a simplicial complex. In order to give a topological version of all algebraic fundamental groups, we associate in this paper to a presentation $(Q, I)$, an incidence algebra $A$ which verifies the following :

Theorem. Let $(Q, I)$ be a presentation of an algebra and let $A$ be the associated incidence algebra. There exists a sub-group $H$ of $\Pi_{1}(Q, I)$ which we describe by generators and relations such that the following sequence is exact :

$$
1 \longrightarrow H \longrightarrow \Pi_{1}(Q, I) \longrightarrow \Pi_{1}(A) \longrightarrow 1
$$

We give a list of sufficient condition to have this subgroup equal to 1 : for example, it happens in the case of Schurian algebras or in the case in which the quiver does not contain sub-quivers in the form of an "eight". In particular, it become easy to provide an other computation of the

[^0]fundamental group of incidence algebra where the quiver is a crown (their fundamental group has been calculated before in [GR])

This paper also describes an algorithm to calculate the fundamental groups of presentations, which allows to present the fundamental groups by generators and relation. In the case $Q$ has more tha one vertex, the fundamental group of a presentation $(Q, I)$ is isomorphic to a fundamental group of a couple $\left(Q^{\prime}, I^{\prime}\right)$ in which $Q^{\prime}$ contains a vertex less than $Q$. Then by applying this processes again, we obtain that the fundamental group $\Pi_{1}(Q, I)$ is isomorphic to a fundamental group of a presentation of an algebra which quiver contains only one vertex; using this we give a presentation by generators and relations. This algorithm is suitable also to calculate Hochschild cohomology group of algebras with presentation verifying $\operatorname{Hom}\left(\Pi_{1}(Q, I), k^{+}\right) \simeq H H^{1}(k Q / I)$; these algebras are described by I. Assem and M. Saorin in [PS].

This paper gives some result of my Ph.D. and I want to thank all the persons who helped me in its realization : particularly Claude Cibils, my thesis director and Manolo SaOrin, who is in particular at the origin of the construction of the incidence algebra associated to a presentation described here, and Maria Julia Redondo.

In this paper, $k$ is an algebraically closed field. Moreover we suppose that the definitions of simplicial complexes, poset, topological fundamental group of a simplicial complex, algebraic fundamental group of a presentation are known. In other case, we find this in [Rey] for example.

## 1. Algorithm of calculus of $\pi_{1}(Q, I)$

Before giving the algorithm, we introduce some notations. Let $Q$ be a quiver and $x_{0}$ be a vertex of $Q$. We also consider $\left(c_{i}\right)_{i \in A}$ and $\left(c_{i}^{\prime}\right)_{i \in A}$ two families of paths of $Q$ indexed by a set $A$. Then, we denote by $<\left(c_{i} \sim c_{i}^{\prime}\right)_{i \in A}>$ the smallest equivalence relation on the set $P(Q)$ containing paths of $Q$ and compatible with the concatenation and which verify :

1. if $f$ is an arrow of $Q$ from $a$ to $b$ then $f . f^{-1} \sim b$ and $f^{-1} . f \sim a$.
2. For all $i$ of $A$, we have : $c_{i} \sim c_{i}^{\prime}$

Moreover, we consider an arrow $f_{0}$ of $Q$ from $a_{0}$ to $b_{0}$ with $a_{0} \neq b_{0}$, and we denote by $Q^{\prime}$ the quiver obtained from $Q$ by identifying the vertices $a_{0}$ and $b_{0}$. More precisely :

- the vertices of $Q^{\prime}$ are the vertices of $Q$ in which $a_{0}$ and $b_{0}$ are the same vertex. We denoted $c_{0}$ this new vertex.
- the arrows of $Q^{\prime}$ are the arrows of $Q$ minus $f_{0}$. All the other arrows have the same source and the same terminus than in $Q$. Let's notice that a parallel arrow of $f_{0}$ becomes a loop in $Q^{\prime}$.

We also denote by $p$ the "projection" $P(Q)$ on $P\left(Q^{\prime}\right)$ defined by :
$-p(s)=s$ for any vertex $s$ not equal to $a_{0}$ and $b_{0}$,
$-p\left(a_{0}\right)=p\left(b_{0}\right)=c_{0}$,
$-p(f)=f$ for any arrow $f$ not equal to $f_{0}$,
$-p\left(f_{0}\right)=c_{0}$.
Finally, let's define $R^{\prime}$, the equivalence relation on $k Q^{\prime}:<\left(p\left(c_{i}\right) \sim p\left(c_{i}^{\prime}\right)\right)_{i \in A}>$.

Theorem 1.1. In the context defined before, the morphism $p$ induces an isomorphism

$$
P_{x_{0}}(Q) / R \simeq P_{p\left(x_{0}\right)}\left(Q^{\prime}\right) / R^{\prime}
$$

in which $P_{x_{0}}(Q)$ and $P_{p\left(x_{0}\right)}\left(Q^{\prime}\right)$ are the sub-sets of walks of respectively $P(Q)$ and $P\left(Q^{\prime}\right)$ closed in $x_{0}$ and $p\left(x_{0}\right)$.

Proof. First, we construct an application $q$ from $P_{p\left(x_{0}\right)}\left(Q^{\prime}\right)$ to $P_{x_{0}}(Q)$ that verifies $p$ o $q=I d$. Let's denote by $\omega^{\prime}=\alpha_{n}^{\epsilon_{n}} \ldots \alpha_{1}^{\epsilon_{1}}$ a walk of $Q^{\prime}$ closed in $p\left(x_{0}\right)$. In general, this walk is not a walk of $Q$ because we have not necessary $t\left(\alpha_{i}^{\epsilon_{i}}\right)=s\left(\alpha_{i+1}^{\epsilon_{i+1}}\right)$ for all $i$ of $\{1, \ldots, n-1\}$. The application $q$ inserts $f_{0}$ and $f_{0}^{-1}$ between some arrows of $\omega^{\prime}$ in order to make $\omega^{\prime}$ a path of $Q$.

Let's define $q$ more precisely. Let $s_{i}$ and $t_{i}$ be respectively the beginning and the end of $\alpha_{i}^{\epsilon_{i}}$ considered as a path of $Q$, and $s_{n+1}, t_{0}$ be $x_{0}$. Then we consider $\omega=e_{n} \cdot \alpha_{n}^{\epsilon_{n}} \cdot e_{n-1} \ldots e_{1} \cdot \alpha_{1}^{\epsilon_{1}} \cdot e_{0}$ a path of $Q$, in which the $e_{i}$ are defined as follows:

$$
e_{i}= \begin{cases}t_{i} & \text { if } t_{i}=s_{i+1} \\ f_{0} & \text { if } t_{i}=a_{0} \text { and } s_{i+1}=b_{0} \\ f_{0}^{-1} & \text { if } t_{i}=b_{0} \text { and } s_{i+1}=a_{0}\end{cases}
$$

Then we have $p(\omega)=\omega^{\prime}$. We define $q\left(\omega^{\prime}\right)$ by $q\left(\omega^{\prime}\right)=\omega$. So we have $p$ o $q=I d$.
Now we are going to prove that the image of two $R^{\prime}$-equivalent walks by $q$ are two $R$ equivalent walks.

For that, it is sufficient to prove this property on the generators of the equivalence relation. First, We consider an arrow $f$ of $Q^{\prime}$ and the walks $\omega=p_{1} \cdot f^{-1} f \cdot p_{2}$ and $\omega^{\prime}=p_{1} \cdot p_{2}$ of $Q^{\prime}$ closed in $p\left(x_{0}\right)$. Let's prove that $q(\omega)$ and $q\left(\omega^{\prime}\right)$ are equivalent. For that, we denote by $p_{1}^{\prime}$ and $p_{2}^{\prime}$ the walks of $Q$ constructed from $p_{1}$ and $p_{2}$ by inserting $f_{0}$ and $f_{0}^{-1}$, as explained during the construction of $q$, so we have :

$$
q(\omega)=p_{1}^{\prime} \cdot e_{3} \cdot f^{-1} \cdot e_{1} \cdot f \cdot e_{4} \cdot p_{2}^{\prime} \quad \text { and } \quad q\left(\omega^{\prime}\right)=p_{1}^{\prime} \cdot e_{2} \cdot p_{2}^{\prime}
$$

Since $t(f)=s\left(f^{-1}\right)$ we have $e_{1}=t(f)$ and

$$
q(\omega)=p_{1}^{\prime} \cdot e_{3} \cdot f^{-1} \cdot e_{1} \cdot f \cdot e_{4} \cdot p_{2}^{\prime}=p_{1}^{\prime} \cdot e_{3} \cdot f^{-1} \cdot f \cdot e_{4} \cdot p_{2}^{\prime} \sim p_{1}^{\prime} \cdot e_{3} \cdot e_{4} \cdot p_{2}^{\prime}
$$

The walks $e_{2}, e_{3}$ and $e_{4}$ being composed only with the arrow $f_{0}$ and its inverse, we obtain $q(\omega) \sim q\left(\omega^{\prime}\right)$. The proof is similar for the insertion of $f . f^{-1}$.

Now we consider two equivalent generators $c_{1}$ and $c_{2}$ of the equivalence relation $R^{\prime}$, and the walks $\omega=p_{1} \cdot c_{1}^{-1} \cdot c_{2} \cdot p_{2}$ and $\omega^{\prime}=p_{1} \cdot p_{2}$ of $Q^{\prime}$ closed in $p\left(x_{0}\right)$.

By définition of $R^{\prime}$, there exists paths $c_{1}^{\prime}$ and $c_{2}^{\prime}$ of $Q$ equivalent by the relation $R$ such that $p\left(c_{1}^{\prime}\right)=c_{1}$ and $p\left(c_{2}^{\prime}\right)=c_{2}$. Let's prove that the walks $q(\omega)$ and $q\left(\omega^{\prime}\right)$ are equivalent. Let's denote again by $p_{1}^{\prime}$ and $p_{2}^{\prime}$ the walks of $Q$ obtained from $p_{1}$ and $p_{2}$ by inserting $f_{0}$ and $f_{0}^{-1}$. Then :

$$
q(\omega)=p_{1}^{\prime} \cdot e_{3} \cdot c_{1}^{\prime-1} \cdot e_{1} \cdot c_{2}^{\prime} \cdot e_{4} \cdot p_{2}^{\prime} \quad \text { and } \quad q\left(\omega^{\prime}\right)=p_{1}^{\prime} \cdot e_{2} \cdot p_{2}^{\prime}
$$

The walks $c_{1}^{\prime}$ and $c_{2}^{\prime}$ being equivalent, we have $t\left(c_{2}^{\prime}\right)=s\left(c_{1}^{\prime-1}\right)$ and $e_{1}=t(f)$, and then :

$$
q(\omega)=p_{1}^{\prime} \cdot e_{3} \cdot c_{1}^{\prime-1} \cdot e_{1} \cdot c_{2}^{\prime} \cdot e_{4} \cdot p_{2}^{\prime}=p_{1}^{\prime} \cdot e_{3} \cdot c_{1}^{\prime-1} \cdot c_{2}^{\prime} \cdot e_{4} \cdot p_{2}^{\prime} \sim p_{1}^{\prime} \cdot e_{3} \cdot e_{4} \cdot p_{2}^{\prime}
$$

Since the walks $e_{2}, e_{3}$ and $e_{4}$ are composed only with the arrow $f_{0}$ and its inverse, we obtain $q(\omega) \sim q\left(\omega^{\prime}\right)$ again.

By definition of the relation $R^{\prime}$, the projection $p$ is also constant on the equivalent classes. Then $p$ and $q$ induce $p_{*}$ and $q_{*}$ between the sets $P_{x_{0}}(Q) / R$ and $P_{p\left(x_{0}\right)}\left(Q^{\prime}\right) / R^{\prime}$. Il is sufficient to prove that $q_{*} o p_{*}=I d$; this being true since the image a walk by the application $q$ o $p$ delete the expressions $f_{0} \cdot f_{0}^{-1}$ and $f_{0}^{-1} \cdot f_{0}$, but their equivalent classes are the same.

The algorithm. Let $Q$ be a quiver and $I$ an ideal of $k Q$. First, we notice that the equivalence relation defined for the construction of the algebraic fundamental group $\Pi_{1}(Q, I)$ is indeed the equivalence relation $<\left(\omega_{i} \sim \omega_{i}^{\prime}\right)_{i \in A}>$ in which, for all $i$ of $A$, the paths $\omega_{i}$ and $\omega_{i}^{\prime}$ are paths in the support of a minimal relation. By applying the theorem a number of times equal to the number of vertices of $Q$ minus one, and after the simplification of equivalent loops, we obtain that the algebraic fundamental group $\Pi_{1}(Q, I)$ is isomorphic to the algebraic fundamental group of a quiver containing only one vertex. This gives a presentation of the group $\Pi_{1}(Q, I)$ by generators and relations.

Example 1.2. Let's consider the incidence algebra of the following quiver. We will denote by $f_{x y}$ the arrow from $x$ to $y$.

We apply the same process on the arrows $f_{b c}$ and $f_{b^{\prime} c^{\prime}}$; the new arrows between $b$ and $b^{\prime}$ will be denoted by $f_{b b^{\prime}}^{\prime}$. We obtain :


With

$$

\end{array}\right.

Finally, we apply the operation one more time with $f_{0}=f_{b b^{\prime}}$ and we denote by $\alpha=p\left(f_{b^{\prime} b}\right)$, $\beta=p\left(f_{b b^{\prime}}^{\prime}\right)$ and $\gamma=p\left(f_{b^{\prime} b}^{\prime}\right)$. Then we obtain a quiver containing only one vertex $b$ and three arrows $\alpha, \beta$ and $\gamma$ with the relations:

$$
R=<b \sim \gamma, \beta \sim b, \alpha \sim \gamma, \beta \alpha \sim b>=<\alpha \sim \beta \sim \gamma \sim b>
$$

The algebraic fundamental group is then trivial which is natural because the corresponding topological fundamental group of this incidence algebra is the one of an octahedra.

## 2. Incidence algebra associated to a presentation

In this paragraph, to each presentation by a quiver and relations $(Q, I)$ of a $k$-algebra $A$ we are going to construct an incidence algebra $A^{\prime}$. The goal of the next paragraphs will be to compare the algebraic fundamental groups of $(Q, I)$ and of $A^{\prime}$. We will show that there exists a subgroup $H$ of $\Pi_{1}(Q, I)$ and an exact sequence $0 \longrightarrow H \longrightarrow \Pi_{1}(Q, I) \longrightarrow \Pi_{1}\left(A^{\prime}\right) \longrightarrow 0$.

The algebra $A^{\prime}$ is interesting because it provides when $H$ is trivial, a topological version of the algebraic fundamental group. Indeed, it has been proved (see [Rey] or [Bus]) that the fundamental groups $\Pi_{1}\left(A^{\prime}\right)$ and $\Pi_{1}(\operatorname{Sim}(\Sigma))$ are isomorphic, in which $\operatorname{Sim}(\Sigma)$ is the simplicial complex associated to the poset $\Sigma$. So if the subgroup $H$ is trivial, the algebraic fundamental group of $(Q, I)$ is isomorphic to the topological fundamental group of a simplicial complex. Finally, let's notice that if the presentation $(Q, I)$ is already a presentation of an incidence algebra $A$, the simplicial complex associated to the poset of $A^{\prime}$ is the barycentric decomposition of the simplicial complex associated to the poset of $A$ and then the fundamental groups of $A$ and $A^{\prime}$ are isomorphic.

We define a poset $\Sigma$. In general it will not be the poset of the incidence algebra $A^{\prime}$ that we will define later.
2.1. The vertices of $\Sigma$. We first consider the set $C(Q) / \sim$ where $C(Q)$ is the set of paths of $Q$ and $\sim$ is the equivalence relation used to construct the fundamental group restricted to $C(Q)$. Then, we denote by $\Sigma$ the set $C(Q) / \sim$ minus the classes containing a path in $I$. Then, by construction, the paths in a class of $\Sigma$ are never equivalent to any other path in $I$.

Since the beginning and the end of equivalent paths are the same, the notions of origin, end, parallelism can be extended to the set $\Sigma$. Moreover, since the equivalence relation $\sim$ is compatible with the concatenation, the set $\Sigma$ inherits a law of composition partially defined. We can notice that this operation is totally defined on $\Sigma \cup\{0\}$ which give to it a structure of semi-group.
2.2. Order relation on $\Sigma$. Let $(Q, I)$ be a presentation and $\Sigma$ the set associated to $(Q, I)$ constructed as bellow.

Proposition - Définition 2.2.1. Let $\bar{a}$ and $\bar{b}$ be the elements of $\Sigma$ the four assertions are equivalents:

1. $\exists \bar{w}, \overline{w^{\prime}} \in \Sigma \quad / \quad \bar{b}=\bar{w} \cdot \bar{a} \cdot \overline{w^{\prime}}$
2. $\forall a \in \bar{a}, \quad \exists b \in \bar{b}, \quad \exists w, w^{\prime} \in C(Q) \quad / \quad b=w \cdot a \cdot w^{\prime}$
3. $\exists a \in \bar{a}, \quad \exists b \in \bar{b}, \quad \exists w, w^{\prime} \in C(Q) \quad / \quad b=w \cdot a \cdot w^{\prime}$
4. $\forall a \in \bar{a}, \quad \forall b \in \bar{b}, \quad \exists w, w^{\prime} \in C(Q) \quad / \quad b \sim w \cdot a \cdot w^{\prime}$

We say in that case that $\bar{a}$ divide $\bar{b}$ and we note denote it by $\bar{a} / \bar{b}$. This relation is then the restriction to $\Sigma$ of the relation divide of the semi-group $\Sigma \cup\{0\}$

## Proof.

$(1 \Longrightarrow 2)$ : Let's suppose that there exists $\bar{w}$ and $\overline{w^{\prime}}$ in $\Sigma$ that verify $\bar{b}=\bar{w} \cdot \bar{a} \cdot \overline{w^{\prime}}$. Let's take $a$, $\omega$ and $\omega^{\prime}$ respectively in $\bar{a}, \bar{\omega}$ and $\overline{\omega^{\prime}}$. It is sufficient to define $b$ by $b=w \cdot a \cdot w^{\prime}$.
$(2 \Longrightarrow 3)$ : evident.
$(3 \Longrightarrow 4)$ : all the paths of $\bar{a}$ (resp. $\bar{b}$ ) are equivalent. Moreover the relation $\sim$ is compatible with the multiplication.
$(4 \Longrightarrow 1)$ : Let's take $b \sim w . a . w^{\prime}$. Since $b$ is not in $I$, The construction of $\Sigma$ tell us that it is the same for $w \cdot a \cdot w^{\prime}$. Moreover, $\bar{w}$ (resp. $\overline{w^{\prime}}$ ) is in $\Sigma$. In deed, in the opposite case $w$ will be equivalent to a path in $I$ and the $w \cdot a . w^{\prime}$ will be equivalent to a path in $I$ which is not permitted. Then $\bar{b}=\overline{w \cdot a \cdot w^{\prime}}=\bar{w} \cdot \bar{a} \cdot \overline{w^{\prime}}$

Proposition 2.2.2. The relation divide is an order relation on $\Sigma$.

Proof. The reflexivity and the transitivity being obvious, we will prove only the antisymétry. Since $\bar{a} / \bar{b}$ and $\bar{b} / \bar{a}$, there exists $\alpha_{1}, \alpha_{1}^{\prime}, \alpha_{2}$ and $\alpha_{2}^{\prime}$ such that $a \sim \alpha_{1} \cdot b \cdot \alpha_{1}^{\prime}$ and $b \sim \alpha_{2} \cdot a \cdot \alpha_{2}^{\prime}$ in which $a$ and $b$ are elements of $\bar{a}$ and $\bar{b}$. Let's take $w=\alpha_{1} \cdot \alpha_{2}$ and $w^{\prime}=\alpha_{2}^{\prime} \cdot \alpha_{1}^{\prime}$, we have $a \sim w . a . w^{\prime}$.

Then, if we use $n$ times the last equation, we have that $a \sim w^{n} . a . w^{\prime n}$ for all $n$ of $\mathbb{N}$. Since $I$ is admissible, there exists $n_{0}$ in $\mathbb{N}$ such that $F^{n_{0}} \subset I$ in which $F^{n_{0}}$ is the ideal containing the paths of length $n_{0}$ or more. Two cases can happen :

1. The classes $\bar{w}$ and $\overline{w^{\prime}}$ contain one path whose length is strictly positive. Let's suppose that it is $\bar{\omega}$ and denote by $\omega_{0}$ this path. Then, This path $a$ is equivalent to $\omega_{0}^{n_{0}} \cdot a \cdot \omega^{\prime n_{0}}$. But $\omega_{0}^{n_{0}}$ being in $I$, the element $a$ is equivalent to an element in $I$ which is impossible by the construction of the set $\Sigma$. Finally, this case can not happen.
2. The classes $\bar{w}$ and $\overline{w^{\prime}}$ only contain vertices. Since $I$ is admissible, the vertices can not be equivalent to any other path and then $\bar{\omega}$ and $\overline{\omega^{\prime}}$ contain respectively the end $t$ and the beginning $s$ of $\bar{a}$; So $w^{\prime}=s$ and $w=t$. Moreover, for a question of length, the equality $\alpha_{1} \cdot \alpha_{2}=t$ induce $\alpha_{1}=\alpha_{2}=t$. With a similar proof on $w^{\prime}$, we have $a=b$.

Proposition 2.2.3. Let $(Q, I)$ be a presentation of an algebra and $\Sigma$ the poset a associated to this presentation, then :

1. $\operatorname{dim}(k Q / I) \geq \operatorname{card}(\Sigma)$. Particularly, if $k Q / I$ is finite dimensional then $\Sigma$ is finite and the incidence algebra associated is also finite dimensional.
2. The quiver $Q$ is connected if and only if all quiver of incidence algebra associated are connected.

## Proof.

(1) : Let $\left(w_{i}\right)_{i \in J}$ be a family of path chosen in each classes of element of $\Sigma$. We will prove that it is a free family in $k Q / I$. Let's suppose that $\sum_{i \in J} \lambda_{i} w_{i} \in I$, then there exists $J^{\prime} \subset J$ non empty such that $\sum_{i \in J^{\prime}} \lambda_{i} w_{i}$ is a minimal relation : so the path $w_{i}$, with $i \in J^{\prime}$ are equivalent. Moreover, since the $w_{i}$ are chosen in different equivalent classes, the cardinal of $J$ can be only one and the minimal relation can can be written $\lambda_{k} \cdot w_{k}=0$ for one $k$ in $J$. Since $w_{k}$ is not in $I$ by construction of $\Sigma$, the element $\lambda_{k}$ is zero. we repeat the operation until all $\lambda_{i}$ are zero for $i \in J$. Then, the family $\left(\omega_{i}\right)_{i \in J}$ is free.
(2) : This proof will be easier after the demonstration the surjection between the two fundamental group.
2.3. Incidence algebra associated to a presentation. We will say that a presentation $(Q, I)$ verifies the property $P$ if one element of a class of $C(Q) / \simeq$ is in $I$ induces that all elements in that class are in $I$. Then the incidence algebra $A^{\prime}$ associated to a presentation $(Q, I)$ is the incidence algebra of $\Sigma$ if the presentation satisfies the property $P$. If the presentation does not satisfies the property $P$, we design by $A^{\prime}$ the incidence algebra associated to the presentation $(Q, \widetilde{I})$ in which $\widetilde{I}$ is the ideal generated by the minimal relation of length at least one; this being possible since $(Q, \widetilde{T})$ verifies $P$.
2.4. Exemple Let $Q$ be the following quiver and $I$ the ideal of $k Q$ :


$$
I=<\varepsilon \alpha, \delta \varepsilon, \beta \alpha-\delta \gamma>
$$

Except the arrows and the vertices, there exists only one path in $Q$ which is $\beta \alpha=\delta \gamma$. The incidence quiver is :


## 3. Relation between the two fundamental groups.

Let $(Q, I)$ be a presentation of an algebra by quiver and relations. In the previous paragraph, we have construct an incidence algebra $A^{\prime}$ with the presentation $(Q, I)$. These two objects, the presentation and the incidence algebra, have their own algebraic fundamental groups, and our aim is to compare them. We will first prove that there exists always a surjection from $\Pi_{1}(Q, I)$ to $\Pi_{1}\left(A^{\prime}\right)$. Then to study the default of injectivity, we will introduce a subgroup $H$ of $\Pi_{1}(Q, I)$ such that $\Pi_{1}(Q, I) / H$ is isomorphic to $\Pi_{1}\left(A^{\prime}\right)$. In other words, we give a system of generators of the kernel of the surjection.

### 3.1. Surjection from $\Pi_{1}(Q, I)$ to $\Pi_{1}\left(A^{\prime}\right)$

Theorem 3.1.1. Let $(Q, I)$ be presentation of an algebra and $A^{\prime}$ the incidence algebra associated, then there exists a surjection :

$$
\phi_{*}: \Pi_{1}(Q, I) \longrightarrow \Pi_{1}(\Sigma) .
$$

Proof. First, let's suppose that the presentation $(Q, I)$ verifies the property $P$. Let's denote by $Q_{\Sigma}$ the ordered quiver associated to $\Sigma$. To simplify the notations of the proof, a vertex of $Q_{\Sigma}$ can be also a class of paths of $C(Q) / \sim$ or sometimes a path of $Q$ if this path is alone in its class. It happens for example for the classes of vertices or arrows. Let's consider now the application $\phi$ defined from $P(Q)$, the set of walks of $Q$, to $P\left(Q_{\Sigma}\right)$, the set of walks of $Q_{\Sigma}$, characterized by :

- If $a$ is a vertex of $Q$ (considered as a constant walk) then $\phi(a)=a$. We notice that since the ideal is admissible, $a$ is not in $I$; the class of $a$ is then in $\Sigma$.
- Let $\alpha$ be an arrow of $Q$ from $a$ to $b$, then $a$ and $b$ are divisors of $\alpha$. Since the ideal $I$ is admissible, the arrows of $Q$ are not in $I$; then $\alpha$ is in $\Sigma$. Since it does not exist, for the order relation 'divide', element strictly between $a$ and $\alpha$ (resp. between $b$ and $\alpha$ ), there exists in $Q_{\Sigma}$ two arrows $\alpha_{a}$ and $\alpha_{b}$ from respectively the vertices $a$ and $b$ to the arrows $\alpha$. We can then define $\phi(\alpha)$ by $\phi(\alpha)=\alpha_{b}^{-1} \alpha_{a}$.

- The application $\phi$ is compatible with the composition of paths, then if $\alpha_{n}^{\varepsilon_{n}} \ldots \alpha_{1}^{\varepsilon_{1}}$ is a walk of $P(Q)$ then

$$
\phi\left(\alpha_{n}^{\varepsilon_{n}} \ldots \alpha_{1}^{\varepsilon_{1}}\right)=\phi\left(\alpha_{n}\right)^{\varepsilon_{n}} \ldots \phi\left(\alpha_{1}\right)^{\varepsilon_{1}}
$$

Let $X_{0}$ be the vertex of $Q$ chosen to calculate $\Pi_{1}(Q, I)$, the vertex $\phi\left(X_{0}\right)=X_{0}$ of $Q_{\Sigma}$ will be taken to calculate $\Pi_{1}\left(Q_{\Sigma}, I_{Q_{\Sigma}}\right)$. Moreover, we denote by $\phi$ again the morphism induced by $\phi$ from the group of paths of $Q$ closed in $X_{0}$ to $\Pi_{1}\left(Q_{\Sigma}, I_{Q_{\Sigma}}\right)$.

We will first prove that the application $\phi$ is surjective. Let $p=\alpha_{n}^{\varepsilon_{n}} \ldots \alpha_{1}^{\varepsilon_{1}}$ be a walk of $Q_{\Sigma}$ crossing successively the vertices $\overline{a_{1}}, \ldots, \overline{a_{n+1}}$ with $\overline{a_{1}}=\overline{a_{n+1}}=X_{0}$; in other words $\overline{a_{i}}$ is the source of $\omega_{i}^{\varepsilon_{i}}$. Let's prove that $p$ is equivalent to a path $p^{\prime}$ crossing the sources $s_{1} \ldots s_{n+1}$ of classes of paths $\overline{a_{1}}, \ldots, \overline{a_{n+1}}$.

For all $i$ in $\{1, \ldots, n\}$, the vertex $\overline{s_{i}}$ divides $\overline{a_{i}}$, so there exists a path $c_{i}$ of $Q_{\Sigma}$ linking $\overline{s_{i}}$ to $\overline{a_{i}}$. Moreover, since $X_{0}$ is also a vertex of $Q$, the path $c_{1}$ and $c_{n+1}$ are the trivial path $X_{0}$.

The walks $p$ is then equivalent to :

$$
p=\left(c_{n+1} \alpha_{n}^{\epsilon_{n}} c_{n}\right) \ldots\left(c_{3}^{-1} \alpha_{2}^{\epsilon_{2}} c_{2}\right)\left(c_{2}^{-1} \alpha_{1}^{\epsilon_{1}} c_{1}\right)
$$

The situation is summarized in the following schema :


Let $i$ be fixed in $\{1, \ldots, n\}$. We suppose moreover that $a_{i} / a_{i+1}$, that is to say that $\varepsilon_{i}=1$; the other case is solved similary. Since $\overline{a_{i}}$ is linked to $\overline{a_{i+1}}$ in $Q_{\Sigma}$ by $\alpha_{i}$, it does not exist element $\underline{\text { in } \Sigma}$ strictly between $\overline{a_{i}}$ and $\overline{a_{i+1}}$. Then it exist an arrows $f_{i}$ from $Q$ such that $\overline{a_{i+1}}=\overline{a_{i}} \cdot \overline{f_{i}}$ or $\overline{a_{i+1}}=\overline{f_{i}} \cdot \overline{a_{i}}$.

In the second case $\overline{a_{i+1}}=\overline{f_{i}} \cdot \overline{a_{i}}$, the paths $c_{i}$ and $c_{i+1}$ have the same origin $s_{i}$ and then the paths $\alpha_{i} c_{i}$ and $c_{i+1}$ are parallel and then $c_{i+1}^{-1} \alpha_{i} c_{i}$ is equivalent to $s_{i}$.

We consider now the first case $: \overline{a_{i+1}}=\overline{a_{i}} \cdot \overline{f_{i}}$. The arrow $f_{i}$ of $Q$ has $s_{i+1}$ as source and $s_{i}$ as terminus, then there exists arrows $f_{s_{i}}$ and $f_{s_{i+1}}$ of $Q_{\Sigma}$ linking respectively $s_{i}$ and $s_{i+1}$ to the vertex $f_{i}$; these arrows verify $\phi\left(f_{i}\right)=f_{s_{i}}^{-1} f_{s_{i+1}}$. Moreover $\overline{f_{i}}$ divide $\overline{a_{i+1}}$, then there exists a path $c$ of $Q_{\Sigma}$ from $f_{i}$ to $a_{i+1}$.


The paths $c_{i+1}$ and $c f_{s_{i+1}}$ in one hand and $\alpha_{i} c_{i}$ and $c f_{s_{i}}$ in other hand are parallel. The walks $c_{i+1}^{-1} \alpha_{i} c_{i}$ is then equivalent to $f_{s_{i+1}}^{-1} c^{-1} c f_{s_{i}}$ and then to $f_{s_{i+1}}^{-1} f_{s_{i}}$ which is exactly the image by $\phi$ of $f_{i}^{-1}$. We notice that if we have considered $\overline{a_{i+1}} / \overline{a_{i}}$, we would conclude that the path is equivalent to the image of the arrow $f_{i}$.

We also notice for later that by using similar process, that the walk of $Q_{\Sigma}$ from $a$ to $b$ :

$$
a \rightarrow f_{1} \rightarrow \overline{f_{2} f_{1}} \rightarrow \overline{f_{3} f_{2} f_{1}} \rightarrow \ldots \rightarrow \overline{f_{n} f_{n-1} \ldots f_{1}} \rightarrow \overline{f_{n} \ldots f_{2}} \rightarrow \overline{f_{n} \ldots f_{3}} \rightarrow \ldots \rightarrow b
$$

is equivalent to $\phi(c)$ in which $c=f_{n} f_{n-1} \ldots f_{1}$.
We will prove now that $\phi$ is constant on the $\sim$-equivalence classes. Then it induces the morphism $\phi_{*}$. We are going to verify first that for all arrows $f$ from $a$ to $b$, we have $\phi\left(f f^{-1}\right) \sim$ $\phi(b)$ and $\phi\left(f^{-1} f\right) \sim \phi(a)$. Indeed $\phi\left(f^{-1} f\right)=f_{a}^{-1} f_{b} f_{b}^{-1} f_{a} \sim a=\phi(a)$; The proof is the same for the other equality.

Then, it is sufficient to verify that the images of two paths $c_{1}$ and $c_{2}$ of $Q$ contained in a same minimal relation are equivalent. Let's notice first that since $(Q, I)$ verifies the relation $P$, the paths $c_{1}$ and $c_{2}$ are represented in $\Sigma$. Let's denote $c_{1}=\alpha_{n} \ldots \alpha_{1}$ and $c_{2}=\beta_{m} \ldots \beta_{1}$, and let $a$ and $b$ be respectively the beginning and the end of the two paths $c_{1}$ and $c_{2}$. Let's define now the following paths :
$e_{1}$ the path of $Q_{\Sigma}$ crossing the vertices $a, \alpha_{1}, \alpha_{2} \alpha_{1}, \ldots, c_{1}$
$e_{2}$ the path of $Q_{\Sigma}$ crossing the vertices $b, \alpha_{n}, \alpha_{n} \alpha_{n-1}, \ldots, c_{1}$
$e_{3}$ the path of $Q_{\Sigma}$ crossing the vertices $a, \beta_{1}, \beta_{2} \beta_{1}, \ldots, c_{2}$
$e_{4}$ the path of $Q_{\Sigma}$ crossing the vertices $b, \beta_{m}, \beta_{m} \beta_{m-1}, \ldots, c_{2}$
The paths $c_{1}$ and $c_{2}$ being equivalent, they are represented in $\Sigma$ by the same vertex $\bar{c}$. The situation is resumed in the following scheme, the arrows being paths of $Q_{\Sigma}$ :


If we use the remark of the end the surjectivity of $\phi$, we have $e_{2}^{-1} e_{1} \sim \phi\left(c_{1}\right)$ and $e_{4}^{-1} e_{3} \sim$ $\phi\left(c_{2}\right)$, Therefore $\phi\left(c_{1}\right)$ and $\phi\left(c_{2}\right)$ are equivalent. We obtain a surjective application $\phi_{*}$ from $\Pi_{1}(Q, I)$ to $\Pi_{1}\left(Q_{\Sigma}\right)$.

Let's suppose now that the presentation $(Q, I)$ does not verify the property $P$. We can deduce from above that there exists a surjection from $\Pi_{1}(Q, \widetilde{I})$ to $A^{\prime}$, and by construction of $\widetilde{I}$ the fundamental groups $\Pi_{1}(Q, \widetilde{I})$ and $\Pi_{1}(Q, I)$ are isomorphic. The theorem is then proved.

Proof of proposition III.2.3. We are going to prove now the property which says that a quiver $Q$ is connected if and only if the poset $\Sigma$ is connected.

Let's suppose that $Q$ is connected and consider $\bar{a}$ and $\bar{b}$ two vertices of $\Sigma$. Moreover, we denote by $\overline{s_{a}}$ and $\overline{s_{b}}$ the sources of $\bar{a}$ and $\bar{b}$. Since $\overline{s_{a}} / \bar{a}$ and $\overline{s_{b}} / \bar{b}$, there exists paths of $\Sigma$ denoted by $c_{1}$ and $c_{2}$ linking respectively $\overline{s_{a}}$ to $\bar{a}$ and $\overline{s_{b}}$ to $\bar{b}$. Moreover, the vertices $s_{a}=\overline{s_{a}}$ and $s_{b}=\overline{s_{b}}$ of $\Sigma$ are vertices of $Q$. Therefore, since $Q$ is connected, there exists a walk $\omega$ of $Q$ linking $s_{a}$ and $s_{b}$. Finally $c_{2} \phi(\omega) c_{1}^{-1}$ is a walk linking $\bar{a}$ and $\bar{b}$. The poset $\Sigma$ is then connected.

Conversely, let's suppose that $\Sigma$ is connected and let's denote by $x$ and $y$ two vertices of $Q$, they are also in $\Sigma$. Since $\Sigma$ is connected, there exists a walk $\omega^{\prime}$ from $x$ to $y$ in $Q$. The application $\phi$ being surjective, there exists a walk of $Q$ from $x$ to $y$ and such that $\phi(\omega) \sim \omega^{\prime}$. Then, $Q$ is connected.

### 3.2. Generators of the kernel.

Let $(Q, I)$ be a presentation by quiver and relations, and $\sim$ be the equivalence relation defined in the construction of the algebraic fundamental group $\Pi(Q, I)$. We also consider the equivalence relation $R$ in $P(Q) / \sim$, the set of isoclasses by the equivalence relations $\sim$ of walks of $Q$, the smallest equivalence relation compatible with the multiplication and verifying the following property : if two parallel paths $c_{1}$ and $c_{2}$ of $Q$ divide two $\sim$-equivalent path not in $I$, then the classes $\overline{c_{1}}$ and $\overline{c_{2}}$ are $R$-equivalent.

Example 3.2.1. Let $(Q, I)$ be the following presentation :

$$
Q=\stackrel{\text { • }}{\beta} \stackrel{\alpha}{\longrightarrow} \cdot \stackrel{\gamma}{\longrightarrow} \quad I=<\gamma \alpha-\gamma \beta>
$$

The paths $\alpha$ and $\beta$ are parallel and divide respectively $\gamma \alpha$ and $\gamma \beta$ which are $\sim$-equivalent. Therefore, the classes of paths $\bar{\alpha}$ and $\bar{\beta}$ are $R$-equivalent.

Example 3.2.2. We consider now the quiver $Q$ containing only one vertex $s$ and only one arrow $f$, and the ideal $I$ restricted to $\{0\}$ :


The paths $s$ and $f$ are parallel and divide $f$ which is equivalent to itself, therefore the classes $\bar{s}$ and $\bar{f}$ are $R$-equivalent.

Let $H$ be the normal sub-group of $\Pi_{1}(Q, I)$ associated to the relation $R$, that is to say the smallest normal sub-group $H$ of $\Pi_{1}(Q, I)$ containing the walks $p^{-1} \overline{c_{1}}{ }^{-1} \cdot \overline{c_{2}} p$, with $p$ a walk which begins in $X_{0}$, the vertex chosen to calculate $\Pi_{1}(Q, I)$, and with $c_{1}$ and $c_{2}$ parallel paths dividing respectively two paths $\sim-$ equivalent non equal to zero in $k Q / I$. The sub-group $H$ can be written as follows :

$$
H=<\bar{p}^{-1} \cdot \overline{c_{1}}{ }^{-1} \cdot \overline{c_{2}} \cdot \bar{p} / \bar{p} \text { a walk which begins in } X_{0}, \bar{c} \in \Sigma, \text { and } \overline{c_{1}} / \bar{c}, \overline{c_{2}} / \bar{c}, \overline{c_{1}} / / \overline{c_{2}}>
$$

### 3.3. The exact sequence.

Theorem 3.3.1. Let $(Q, I)$ be a presentation of an algebra and $A^{\prime}$ the associated incidence algebra. Then the group $\Pi_{1}(Q, I) / R$ and $\Pi_{1}\left(Q_{\Sigma}\right)$ are isomorphic. In other words, the sequence

$$
0 \longrightarrow H \longrightarrow \Pi_{1}(Q, I) \longrightarrow \Pi_{1}\left(A^{\prime}\right) \longrightarrow 0
$$

is exact.
Proof. We will use the same notation than the ones in the proof of the surjectivity. Moreover, it is sufficient to prove this for a presentation that verifies the property $P$ since $\Pi_{1}(Q, I)$ and $\Pi_{1}(Q, \widetilde{I})$ are isomorphic.

Let's prove first that $\phi_{*}$ is constant on the equivalent classes of the relation $R$; therefore, it will induce $\phi_{* *}$. We are going to prove that the images of two parallel paths $c_{1}$ and $c_{2}$ in $Q$ dividing respectively the equivalent paths $d_{1}$ and $d_{2}$ not in $I$, are equivalent. We notice that $c_{1}$ and $c_{2}$ are not in $I$, because in the reverse case $d_{1}$ and $d_{2}$ would be in $I$ which is not possible. Then the classes $\overline{c_{1}}$ and $\overline{c_{2}}$ are in $\Sigma$.

Since $c_{1} / d_{1}$ and $c_{2} / d_{2}$, there exists $f_{1}$ a path of $Q_{\Sigma}$ from $\overline{c_{1}}$ to $\overline{d_{1}}$ and $f_{2}$ a path of $Q_{\Sigma}$ from $\overline{c_{2}}$ to $\overline{d_{2}}$. Moreover, we use the same definition than in the proof of the surjectivity for the paths $e_{1}, e_{2}, e_{3}$ and $e_{4}$. We obtain the following situation; the arrows being paths of $Q_{\Sigma}$ :


By using the remark at the end of the surjectivity of $\phi$, we have :

$$
\phi\left(c_{1}\right) \sim e_{2}^{-1} e_{1} \sim e_{2}^{-1} f_{1}^{-1} f_{1} e_{1} \sim e_{4}^{-1} f_{2}^{-1} f_{2} e_{3} \sim e_{4}^{-1} e_{3} \sim \phi\left(c_{2}\right)
$$

The construction of the antecedent used in the proof of the surjectiviy defined an application $\psi$ from the set of walks of $Q_{\Sigma}$ to quotient set of the walks of $Q$ by the two equivalence relations. We begin to define this application more precisely. Let's consider the application $\psi$ defined from $P\left(Q_{\Sigma}\right)$, the set of paths of $Q_{\Sigma}$, to $(P(Q) / \sim) / R$, and generated by the following relation :

1. $\psi(e)=s(e)$ for all vertices $e$ of $Q_{\Sigma}$.
2. If $\alpha_{n}^{\varepsilon_{n}} \ldots \alpha_{1}^{\varepsilon_{1}}$ is a closed walk in $x_{0}$ then

$$
\psi\left(\alpha_{n}^{\varepsilon_{n}} \ldots \alpha_{1}^{\varepsilon_{1}}\right)=\psi\left(\alpha_{n}\right)^{\varepsilon_{n}} \ldots \psi\left(\alpha_{1}\right)^{\varepsilon_{1}} .
$$

3. If $\alpha$ is an arrow of $Q_{\Sigma}$ from $\bar{a}$ to $\bar{b}$ then there exists an arrows $f$ of $Q$ verifying $\bar{b}=\bar{f} \cdot \bar{a}$ or $\bar{b}=\bar{a} \cdot \bar{f}$. If $\bar{b}=\bar{f} \cdot \bar{a}$ then $\psi(\alpha)$ is the origin of $\bar{a}$ else $\psi(\alpha)$ is equal to $f^{-1}$.

Let $x_{0}$ be the vertex chosen to calculate $\Pi_{1}(Q, I)$, the vertex $x_{0}=\phi\left(x_{0}\right)$ will be also chosen to calculate $\Pi_{1}\left(Q_{\Sigma}, I_{Q_{\Sigma}}\right)$. Moreover, we will denote one more time by $\psi$, the application $\psi$ restricted to the set of closed walks in $x_{0}$. We notice that the image of $\psi$ is included in $\Pi\left(Q_{\Sigma}, I_{Q_{\Sigma}}\right)$.

Let's prove that $\psi$ is well defined.

1. If there exists $f$ and $g$ verifying $\bar{b}=\bar{a} \cdot \bar{f}=\bar{g} \cdot \bar{a}$, then $s(\bar{a})=s(\bar{f})=s(\bar{b}), t(\bar{f})=s(\bar{a})$ and $t(\bar{a})=s(\bar{g})$; the applications source and terminus being always used on the classes of walks of $Q$ and not on the vertices of $\Sigma$. Then $f$ is a loop of extremity $s(\bar{a})$. The vertex $s(\bar{a})$ of $Q$ and the arrow $f$ are parallel and divide $f$, not equal to zero since the ideal $I$ is admissible, then they are $R$-equivalent ; in fact $I$ being admissible, arrows and vertices of $Q$ can not be in $I$. With a similar proof on $g$ we deduce that the two definitions in that case coincide.
2. If there exists $f$ and $g$ verifying $\bar{b}=\bar{f} \cdot \bar{a}=\bar{g} \cdot \bar{a}$ or $\bar{b}=\bar{a} \cdot \bar{f}=\bar{a} \cdot \bar{g}$, then $f$ and $g$ parallel arrows dividing $b$, not in $I$ because $b$ is in $\Sigma$, therefore they are $R$-equivalent.

Let's prove now that the application $\psi$ is constant on the equivalent class and then induces an application $\psi_{*}$ from $\Pi_{1}\left(Q_{\Sigma}\right)$ to $\Pi_{1}(Q, I) / H$

We will verify this on the generators of the equivalence relation. Let $\alpha$ be an arrow of $Q_{\Sigma}$ from the vertex $\bar{a}$ to the vertex $\bar{b}$. Then there exists $f$ verifying $\bar{b}=\bar{f} \cdot \bar{a}$ or $\bar{b}=\bar{a} \cdot \bar{f}$. In the first case, insert $\alpha^{-1} \alpha$ in a walk of $Q_{\Sigma}$ do not change its image since $\psi(\alpha)$ is a vertex. In the second case, this is equivalent to insert $f \cdot f^{-1}$ in the walk, which do not change its equivalent class. We do the same thing on $\alpha \alpha^{-1}$.

Let's consider now two parallel paths $c$ and $c^{\prime}$ of $Q_{\Sigma}$. We will prove that changing $\psi(c)$ by $\psi\left(c^{\prime}\right)$ in a walk of $Q$ does not change its equivalent class. Let $\overline{a_{1}}, \ldots, \overline{a_{n}}$ and $\overline{a_{1}^{\prime}}, \ldots, \overline{a_{n^{\prime}}^{\prime}}$ be respectively the vertices crossed by $c$ and $c^{\prime}$ and let's denote by $\bar{a}=\overline{a_{1}}=\overline{a_{1}^{\prime}}$. For all $i$, the vertex $\overline{a_{i}}$ is linked to the vertex $\overline{a_{i+1}}$ then there exists an arrow $f$ of $Q$ such that $\overline{a_{i+1}}=\overline{a_{i}} \cdot \bar{f}$ or $\overline{a_{i+1}}=\bar{f} \cdot \overline{a_{i}}$. Then

$$
\begin{array}{lll}
\exists r, s \in \mathbb{N} & \exists f_{1} \ldots f_{r+s} & \text { such that } \\
\exists r^{\prime}, s^{\prime} \in \mathbb{N} & \exists f_{1}^{\prime} \ldots f_{r^{\prime}+s^{\prime}}^{\prime}
\end{array} \quad \begin{aligned}
& \overline{a_{n}} \\
& \text { such that } \\
& \overline{a_{n^{\prime}}} \\
& =\overline{f_{r+1}} \ldots \overline{f_{r^{\prime}+1}^{\prime}} \ldots \overline{f_{r+s}} \cdot \bar{a} \cdot \overline{f_{1}^{\prime}+s^{\prime}} \ldots \cdot \overline{f_{1}} \cdot \overline{f_{1}^{\prime}} \ldots \overline{f_{r^{\prime}}^{\prime}}
\end{aligned}
$$

We have then $\psi(c)^{-1}=f_{1} . f_{2} \ldots f_{r}$ and $\psi\left(c^{\prime}\right)^{-1}=f_{1}^{\prime} . f_{2}^{\prime} \ldots f_{r^{\prime}}^{\prime}$. These paths are parallel and theirs $\sim$-classes divide $\overline{a_{n}}=\overline{a_{n^{\prime}}^{\prime}}$, therefore they are $R$-equivalent.

Finally let's prove that the applications $\psi_{*}$ and $\phi_{* *}$ verify $\psi_{*} o \phi_{* *}=I d$. Then, $\phi_{* *}$ will be injective. Since $\psi_{*}$ and $\phi_{* *}$ are two morphisms, it is sufficient to prove this on the vertices and on the arrows of $Q_{\Sigma}$. If $a$ is a vertex of $Q$, then $\psi_{*} o \phi_{* *}(a)=a$. If $f$ is an arrow of $Q$ from $a$ to $b$ then

$$
\psi_{*} o \phi_{* *}(f)=\psi_{*}\left(f_{b}^{-1} \cdot f_{a}\right)=\psi_{*}\left(f_{b}\right)^{-1} \cdot \psi_{*}\left(f_{a}\right)=\left(f^{-1}\right)^{-1} \cdot a=f
$$

### 3.4. Cases in which the morphism is an isomorphism.

We will give sufficient conditions to have an isomorphism between the two fundamental groups described in the previous paragraphs, that is to say to have a sub-group $H$ restricted to the neutral element.

Proposition 3.4.1. Let $(Q, I)$ be a presentation of an algebra and $Q_{\Sigma}$ the associated incidence quiver. Then if one of the following conditions is satisfied, the sub-group $H$ is trivial and then $\Pi_{1}\left(Q_{\Sigma}\right) \simeq \Pi_{1}(Q, I)$.

1. The ideal $I$ is restricted to 0 .
2. If $c_{1}$ and $c_{2}$ are parallel and not equivalent then the paths $\omega_{1} \cdot c_{1} \cdot \omega_{2}$ and $\omega_{3} \cdot c_{2} \cdot \omega_{4}$ are not equivalent, for all paths $\omega_{1}, \omega_{2}, \omega_{3}$ and $\omega_{4}$ such that the previous products has sense.
3. If $c_{1}$ and $c_{2}$ are parallel then the paths $\omega_{1} \cdot c_{1} \cdot \omega_{2}$ and $\omega_{3} \cdot c_{2} \cdot \omega_{4}$ are not parallel, for all paths $\omega_{1}, \omega_{2}, \omega_{3}$ and $\omega_{4}$ which are not all of them trivial and such that the previous products has sense. This condition is independent to $I$.
4. The couple $(Q, I)$ is the presentation of an incidence algebra, more generally a presentation of a Schurian algebra.
5. The quiver $Q$ does not contain cycles and sub-quivers in the form of eight, that is to say sub-quivers in the form :

in which arrows represent in fact paths.

Remark. We have just seen that $H$ is trivial in the case of Schurian algebra. Nevertheless, this is not the case for constricted algebra. Indeed, let's consider the following quiver $Q$ :

and the ideal $I=<\delta \gamma \beta \alpha-\delta^{\prime} \gamma^{\prime} \beta^{\prime} \alpha^{\prime}>$. The algebra $k Q / I$ is a restricted algebra non Schurian and the sub-group $H$ is isomorphic to $\mathbb{Z}$.

## Proof de la proposition.

1 : in the case in which $I=0$, two equivalent $\sim$-paths are equal. Then if $c_{1}$ and $c_{2}$ are parallel dividing a same path $d$, then $c_{1}$ and $c_{2}$ are equal, and $\overline{c_{1}}=\overline{c_{2}}$ bring no generators to $H$.
$2:$ this is a translation of the definition.
3 : if the multiples of $c_{1}$ and $c_{2}$ are never parallel, they can not be equivalents.
4 : let $c_{1}$ and $c_{2}$ be two parallel paths dividing $d_{1}$ and $d_{2}$ equivalent and not equal to zero. Therefore $c_{1}$ and $c_{2}$ are parallel and not equal to zero. Since the algebra is a Shurian algebra, this two paths are equivalent.

5 : let $c_{1}$ and $c_{2}$ be two parallel path dividing two paths $d_{1}$ and $d_{2}$ equivalent. Since it does not exist quivers in the form of eight and loops then there exists $\omega$ and $\omega^{\prime}$ such that $d_{1}=\omega \cdot c_{1} \cdot \omega^{\prime}$ and $d_{2}=\omega \cdot c_{2} \cdot \omega^{\prime}$. Then since $d_{1}$ and $d_{2}$ are equivalent then $\omega^{-1} \cdot d_{1} \cdot \omega^{\prime-1}$ and $\omega^{\prime-1} \cdot d_{2} \cdot \omega^{-1}$ are equivalent and then $c_{1}$ and $c_{2}$ too.

## 4. Examples and influence of the presentation.

Example 4.1. The aims of the these two examples is to show simple cases in which the subgroup $H$ is not trivial.


In this example, the vertex $a$ and the arrows $\omega$ divide $\omega$. Then $H$ is equal to the fundamental group of $(Q, I)$. On the right, we find the associated incidence quiver which the fundamental group is trivial. Let's consider now the following quiver :


The quiver of the associated incidence algebra is :


In that case, the arrows $\alpha, \gamma$ and $\beta, \delta$ divide $\beta \alpha=\delta \gamma$. The relation $R$ is generated by $\alpha R \gamma$ and $\beta R \delta$.

Example 4.2. This example shows that the incidence algebra associated to a presentation $(Q, I)$ is not an invariant of the algebra. Indeed, let's consider the quiver $Q$ :

and the two ideals $I_{1}=<\gamma \beta \alpha-\delta \alpha>$ and $I_{2}=<\delta \alpha>$ of $k Q$. The two algebra $k Q / I_{1}$ and $k Q / I_{2}$ are isomorphic. Let's construct now the incidence quivers $\Sigma_{\left(Q, I_{1}\right)}$ and $\Sigma_{\left(Q, I_{2}\right)}$ which fellows :


For the presentation $\left(Q, I_{1}\right)$, the fundamental group is trivial, then the fundamental group of the associated incidence quiver is restricted to 1 since the theorem of the exact sequence. For the second presentation $\left(Q, I_{2}\right)$, the fundamental group of the associated incidence quiver is isomorphic to $\mathbb{Z}$. To see that, we are going to calculate the sub-group $H$ of $\Pi_{1}\left(Q, I_{2}\right)$. Only the paths $\delta$ and $\gamma \beta$ are parallel and not equivalent. The subgroup $H$ is then generated by the relation $\beta \alpha-\delta \gamma \alpha$. We choose the vertex $\alpha$ as base point to calculate the fundamental group. But this relation is trivial in $\Pi_{1}\left(Q, I_{2}\right)$ and then $H$ is restricted to 1 . The fundamental group of $\Sigma_{\left(Q, I_{2}\right)}$ is then isomorphic to $\Pi_{1}\left(Q, I_{2}\right)$ since the theorem of the exact sequence which is isomorphic to $\mathbb{Z}$.

Then, there exists two presentations of an algebra whose incidence quivers give different fundamental groups; The fundamental groups of the associated incidence algebras also depend on the presentation of the algebra.

Example 4.3. In this example, we recalculate in a simple way the fundamental group of a type of a particular incidence algebra and then its first group of Hochschild cohomology with the theorem of Assem and De La Peña. This incidence algebras are such that their quiver is a crown, that is to say a quiver as follows :


It has been considered for example in [GS] and their fundamental group has been calculated in [GR]. For that, let consider the following cyclic quiver $Q_{n}$ :


Let $p$ and $q$ be natural integer such that $q<n$. We also consider the ideal $I_{p q}$ of $k Q_{n}$ generated by the paths of $Q_{n}$ of length $p \times n+q$. Then the incidence quiver associated to ( $Q_{n}, I_{p q}$ ) is the crown previously described with $n$ vertices on the horizontal and $n \times p+q$ vertices on the vertical. The vertices of the first line represent the vertices of $Q_{n}$, the vertices of the second line are the arrows of $Q_{n}$, the vertices of the third line are the path of length 2 of $Q_{n}$, etc.

Then, it is sufficient to calculate the fundamental group of $Q_{n}$ and the group $H$. The fundamental group does not change with $I_{p q}$ since $I_{p q}$ contains only minimal relation with one term. It is then isomorphic to $\mathbb{Z}$. For the subgroup $H$, two cases can happen. If $p=0$, it does not exist not equal to zero and parallel paths then $H$ is 1 and $\Pi_{1}\left(Q_{c}, I_{p q}\right)$ is isomorphic to $\mathbb{Z}$. If $p \neq 0$, the path $\alpha_{1} \ldots \alpha_{n}$ and the origin of $\alpha_{1}$ divide $\alpha_{1} \ldots \alpha_{n}$, the subgroup $H$ contains a generator of the cyclic group $\Pi_{1}\left(Q_{c}, I_{p q}\right)$, then $\Pi_{1}\left(Q_{c}, I_{p q}\right) / H$ is trivial.

Then, the fundamental of a crown $C_{n, p, q}$ with $n$ columns and with $p n+q$ lines is :

$$
\Pi_{1}\left(C_{n, p, q}, I_{C_{n, p, q}}\right)=\left\{\begin{array}{cc}
\mathbb{Z} & \text { if } p=0 \\
0 & \text { if } p>0
\end{array}\right.
$$

For an other demonstration, see [GR].
Moreover since $\operatorname{Hom}\left(\Pi_{1}(Q, I), k^{+}\right) \simeq H H^{1}(k Q / I)$ in the case of incidence algebra, we can deduce that the first Hochschild cohomology group of the incidence algebra of the crown is $k$ if $p=0$ and 0 otherwise.
