Computation of 2-groups of narrow logarithmic divisor classes of number fields

Abstract. We present an algorithm for computing the 2-group $\widetilde{\mathcal{C}}\ell_F^{res}$ of narrow logarithmic divisor classes of degree 0 for number fields F. As an application, we compute in some cases the 2-rank of the wild kernel $WK_2(F)$ and the 2-rank of its subgroup $K_2^{\infty}(F) := \bigcap_{n \ge 1} K_2^n(F)$ of infinite height elements in $K_2(F)$.

Résumé. Nous présentons un algorithme de calcul du 2-groupe des classes logarithmiques de degré nul au sens restreint $\widetilde{C}\ell_F^{res}$ pour tout corps de nombres F. Nous en déduisons sous certaines hypothèses les 2-rangs du noyau sauvage $WK_2(F)$ ainsi que du sous-groupe $K_2^{\infty}(F) := \bigcap_{n\geq 1} K_2^n(F)$ des éléments de hauteur infinie dans $K_2(F)$.

1 Introduction

In [8] J.-F. Jaulent pointed out that the wild kernel $WK_2(F)$ of a number field F can also be studied via logarithmic class groups, the arithmetic of which he therefore developed in [9].

More precisely, if F contains a primitive 2ℓ -th root of unity, the ℓ -rank of $WK_2(F)$ coincides with the ℓ -rank of the logarithmic class group $\widetilde{\mathcal{C}\ell}_F$. So an algorithm for computing $\widetilde{\mathcal{C}\ell}_F$ for Galois extensions F was developed first in [4] and later generalized and improved for arbitrary number field in [3].

In case the prime ℓ is odd and the field F does not contain a primitive ℓ th root of unity one considers the cyclotomic extension $F' := F(\zeta_{\ell})$, uses the isomorphism

$$\mu_{\ell} \otimes \widetilde{\mathcal{C}\ell}_{F'} \simeq WK_2(F')/WK_2(F')^{\ell}$$

and gets back to F via the so-called transfer (see [11] and [16]). The algorithmic aspect of this is treated in [14].

In case $\ell = 2$, whenever the condition $\zeta_{2\ell} \in F$ is not fulfilled, the relationship between logarithmic classes and exotic symbols is more intricate. For instance, when the number field F has a real embedding, F. Soriano-Gafiuk observed in [15] that one may then define a narrow version of the logarithmic class group by analogy with the classical ideal class groups; and she used this in [16] for approximating the wild kernel more closely. But, unexpectedly, the 2-rank of this restricted logarithmic class group $\widetilde{\mathcal{C}\ell}_F^{res}$ sometimes differs from the 2-rank of the group $WK_2(F)$. Moreover, in this case the wild kernel $WK_2(F)$ may differ from its subgroup $K_2^{\infty}(F) := \bigcap_{n \ge 1} K_2^n(F)$ of infinite height elements in $K_2(F)$. This was observed by J. Tate and then made more explicit by K. Hutchinson (cf [6, 7]).

That last difficulty was finally solved in [12], where the authors constructed a positive class group *ad hoc* $\mathcal{C}\ell_F^{pos}$ which has the same 2-rank as the wild kernel $WK_2(F)$. Nevertheless, in case the set PE_F of dyadic exceptional primes of the number field F is empty, that group $\mathcal{C}\ell_F^{pos}$ appears as a factor of the full narrow logarithmic class group $\mathcal{C}\ell_F^{res}$ (without any assumption on the degree), so one may still use narrow logarithmic classes in order to compute the 2-rank of the wild kernel.

In the present paper we use the results from [3] on (ordinary) logarithmic class groups and develop an algorithm for computing the narrow groups $\widetilde{\mathcal{C}\ell}_{F}^{res}$ in arbitrary number fields F. As a consequence, this algorithm calculates the 2-rank of the wild kernel $WK_2(F)$ whenever the field F has no dyadic exceptional places.

The computation of the 2-rank of $WK_2(F)$ in the remaining case $(PE_F \neq \emptyset)$ will be solved in a forthcoming article where we compute the finite positive classgroup $\mathcal{C}\ell_F^{pos}$ and its subgroup $\widetilde{\mathcal{C}\ell}_F^{pos}$ of positive classes of degree 0.

2 The group of narrow logarithmic classes $\widetilde{\mathcal{C}}\ell_F^{res}$

In this preliminary section we recall the definition and the main properties of the arithmetic of restricted (or narrow) logarithmic classes. We refer to [9] and [16] for a more detailed account.

Throughout this paper the prime number ℓ equals 2 and F is a number field of degree n = r + 2c with r real places, c complex places and d dyadic places.

According to [8], for every finite place \mathfrak{p} of F there exists a 2-adic \mathfrak{p} -valuation $\tilde{v}_{\mathfrak{p}}$ which is related to the wild \mathfrak{p} -symbol in case the cyclotomic \mathbb{Z}_2 -extension of $F_{\mathfrak{p}}$ contains i. The degree deg_F \mathfrak{p} of the place \mathfrak{p} is a 2-adic integer such that the image of $\mathcal{R}_F := \mathbb{Z}_2 \otimes_{\mathbb{Z}} F^{\times}$ under the map Log $| |_{\mathfrak{p}}$ is the \mathbb{Z}_2 -module deg_F $\mathfrak{p} \mathbb{Z}_2$ (see [9]), where Log denotes the usual 2-adic logarithm and $| |_{\mathfrak{p}}$ is the 2-adic absolute value at the place \mathfrak{p} .

The construction of the 2-adic logarithmic valuations $\tilde{v}_{\mathfrak{p}}$ yields:

$$\forall \alpha \in \mathcal{R}_F := \mathbb{Z}_2 \otimes_{\mathbb{Z}} F^{\times} : \sum_{\mathfrak{p} \in Pl_F^0} \tilde{v}_{\mathfrak{p}}(\alpha) \deg_F \mathfrak{p} = 0 , \qquad (1)$$

where Pl_F^0 is the set of finite places of the number field F. Setting

$$\widetilde{\operatorname{div}}_F(\alpha) := \sum_{\mathfrak{p} \in Pl_F^0} \widetilde{v}_{\mathfrak{p}}(\alpha) \mathfrak{p}$$

with values in $\mathcal{D}\ell_F := \bigoplus_{\mathfrak{p} \in Pl_F^0} \mathbb{Z}_2 \mathfrak{p}$, we obtain by \mathbb{Z}_2 -linearity:

$$\deg_F(\operatorname{div}_F(\alpha)) = 0 . (2)$$

We then define the subgroup of logarithmic divisors of degree 0 by:

$$\widetilde{\mathcal{D}\ell}_F := \left\{ \mathfrak{a} = \sum_{\mathfrak{p}\in Pl_F^0} a_{\mathfrak{p}}\mathfrak{p} \in \mathcal{D}\ell_F \mid \deg_F \mathfrak{a} := \sum_{\mathfrak{p}\in Pl_F^0} a_{\mathfrak{p}} \deg_F \mathfrak{p} = 0 \right\};$$

and the group of principal logarithmic divisors as the image of \mathcal{R}_F by div_F :

$$\widetilde{\mathcal{P}\ell}_F := \left\{ \widetilde{\operatorname{div}}_F(\alpha) \mid \alpha \in \mathcal{R}_F \right\}$$

Because of (2), $\widetilde{\mathcal{P}}\ell_F$ is a subgroup of $\widetilde{\mathcal{D}}\ell_F$. And by the so-called extended Gross conjecture the factor group

$$\widetilde{\mathcal{C}\ell}_F := \widetilde{\mathcal{D}\ell}_F / \widetilde{\mathcal{P}\ell}_F$$

is a finite group, the 2-group of logarithmic divisor classes (of degree 0) of the field F introduced in [9].

Now let $PR_F := \{\mathfrak{p}_1, \ldots, \mathfrak{p}_r\}$ be the (non empty) set of real places of the field F and F^+ be the subgroup of all totally positive elements in F^{\times} , i.e. the kernel of the sign map

$$\operatorname{sign}_F^\infty: F^{\times} \to \{\pm 1\}^r$$

which maps $x \in F$ onto the vector of the signs of the real conjugates of x. For

$$\widetilde{\mathcal{P}\ell}_F^+ := \{ \widetilde{\operatorname{div}}_F(\alpha) \mid \alpha \in \mathcal{R}_F^+ := \mathbb{Z}_2 \otimes_{\mathbb{Z}} F^+ \}$$

the factor group

$$\widetilde{\mathcal{C}\ell}_F^{\,res} := \widetilde{\mathcal{D}\ell}_F / \widetilde{\mathcal{P}\ell}_F^{\,+}$$

is the 2-group of narrow (or restricted) logarithmic divisor classes (of degree 0) introduced in [15]; and it is also finite under the extended Gross conjecture.

In order to make it more suitable for actual computations, we may define it in a slighty different way by introducing real signed divisors of degree 0:

Definition 1. With the notations above, the 2-group of real signed logarithmic divisors (of degree 0) is the direct sum:

$$\widetilde{\mathcal{D}\ell}_F^{res} := \widetilde{\mathcal{D}\ell}_F \oplus \{\pm 1\}^r$$

and the subgroup of principal real signed logarithmic divisors is the image: \sim

$$\widetilde{\mathcal{P}}\ell_F^{res} := \{ (\widetilde{\operatorname{div}}_F(\alpha), \operatorname{sign}_F^{\infty}(\alpha)) \mid \alpha \in \mathcal{R}_F \}$$

of $\mathcal{R}_F := \mathbb{Z}_2 \otimes_{\mathbb{Z}} F^{\times}$ under the $(\widetilde{\operatorname{div}}_F, \operatorname{sign}_F^{\infty})$ map. The factor group: $\widetilde{\mathcal{C}}\ell_F^{res} := \widetilde{\mathcal{D}}\ell_F^{res}/\widetilde{\mathcal{P}}\ell_F^{res}$

is the 2-group of narrow logarithmic divisor classes (of degree 0).

Because of the weak approximation theorem, every class in $\widetilde{\mathcal{C}}\ell_F^{res}$ can be represented by a pair $(\mathfrak{a}, \mathbf{1})$ where the vector $\mathbf{1}$ has all entries 1. So the canonical map $\mathfrak{a} \mapsto (\mathfrak{a}, \mathbf{1})$ induces a morphism from $\widetilde{\mathcal{D}}\ell_F$ onto $\widetilde{\mathcal{C}}\ell_F^{res}$, the kernel of which is $\widetilde{\mathcal{P}}\ell_F^+$. We conclude as expected:

$$\widetilde{\mathcal{C}}\ell_F^{\,res} \;=\; \widetilde{\mathcal{D}}\ell_F^{\,res}/\widetilde{\mathcal{P}}\ell_F^{\,res} \;\simeq\; \widetilde{\mathcal{D}}\ell_F/\widetilde{\mathcal{P}}\ell_F^{\,+}.$$

We are now in a situation to present an algorithm for computing narrow logarithmic classes. It uses our previous results of [3] on (ordinary) logarithmic classes and mimics the classical feature concerning narrow and ordinary ideal classes. We note that this algorithm is a bit more intricate in the logarithmic context since the logarithmic units *are not* algebraic numbers and are therefore not exactly known from a numerical point of view.

3 The algorithm for computing $\widetilde{\mathcal{C}}\ell_F^{res}$

We assume in this section that the number field F has at least one real place and that the logarithmic 2-class group $\widetilde{\mathcal{C}\ell}_F$ is isomorphic to the sum

$$\widetilde{\mathcal{C}\ell}_F \simeq \bigoplus_{j=1}^{\nu} \mathbb{Z}/2^{n_j}\mathbb{Z}$$

subject to $1 \leq n_1 \leq ... \leq n_{\nu}$. Let \mathfrak{a}_j $(1 \leq j \leq \nu)$ be fixed representatives of the ν generating divisor classes (of degree 0). We let $(\epsilon_i)_{i=1,...,r}$ denote the canonical basis of the multiplicative \mathbb{F}_2 -space $\{\pm 1\}^r$.

Thus any real signed divisor (\mathfrak{a}, ϵ) in $\mathcal{D}\ell_F^{res}$ can be uniquely written:

$$(\mathfrak{a},\epsilon) = \left(\sum_{j=1}^{\nu} a_j \mathfrak{a}_j + \widetilde{\operatorname{div}}_F(\alpha), \prod_{i=1}^{r} \epsilon_i^{b_i} \operatorname{sign}_F^{\infty}(\alpha)\right)$$

with suitable integers $a_j \in \mathbb{Z}$, $b_i \in \{0, 1\}$ and $\alpha \in \mathcal{R}_F$.

Then the $(\mathfrak{a}_j, \mathbf{1})_{j=1,...,\nu}$ together with the $(0, \epsilon_i)_{i=1,...,r}$ are a finite set of generators of the narrow class group $\widetilde{\mathcal{C}\ell}_F^{res}$. And we just need to detect the relations among those.

From the description of the logarithmic class group $\widetilde{\mathcal{C}\ell}_F$ above we get:

$$2^{n_j}\mathfrak{a}_j = \widetilde{\operatorname{div}}_F(\alpha_j),$$

with $\alpha_j \in \mathcal{R}_F$ for $j = 1, \ldots, \nu$. So we can define coefficients $c_{\nu+i,j}$ in $\{0,1\}$ by:

$$\operatorname{sign}_{F}^{\infty}(\alpha_{j}) = ((-1)^{c_{\nu+1,j}}, \dots, (-1)^{c_{\nu+r,j}})$$

Consequently, a first set of relations is given by the columns of the following matrix $A \in \mathbb{Z}_2^{(\nu+r) \times \nu}$:

Now, the ν elements α_j are only given up to logarithmic units. Hence, we must additionally consider the sign-function on the 2-group $\widetilde{\mathcal{E}}_F$ of logarithmic units of F (see [8]). More precisely, in case

$$\widetilde{\mathcal{E}}_F = \{\pm 1\} \times \langle \widetilde{\varepsilon}_1, ..., \widetilde{\varepsilon}_{r+c} \rangle , \qquad (3)$$

we define exponents $b_{i,j}$ via

$$\operatorname{sign}_{F}^{\infty}(\tilde{\varepsilon}_{j}) = \prod_{i=1}^{r} \epsilon_{i}^{b_{i,j}}$$

$$\tag{4}$$

and we have, of course:

$$\operatorname{sign}_F^\infty(-1) = \prod_{i=1}^r \epsilon_i$$
.

From a computational point of view things are a bit more complicated. We just know that

$$\widetilde{\mathcal{E}}_F = \{ x \in \mathcal{R}_F \mid \forall \mathfrak{p} : \widetilde{v}_{\mathfrak{p}}(x) = 0 \}$$
(5)

is a subgroup of the 2-group of 2-units \mathcal{E}'_F . If we assume that there are exactly d places $\mathfrak{p}_1, \ldots, \mathfrak{p}_d$ containing 2 in F, we have, say,

$$\mathcal{E}'_F = \{\pm 1\} \times \langle \varepsilon_1, ..., \varepsilon_{r+c+d-1} \rangle$$

In the same way that in [3], for the calculation of $\widetilde{\mathcal{E}}_F$ we fix a precision e for our 2-adic approximations by requiring for elements ε of \mathcal{E}'_F the relation

$$\tilde{v}_{\mathfrak{p}_i}(\varepsilon) \equiv 0 \mod 2^e \ (1 \le i \le d)$$
.

We obtain a system of generators of $\widetilde{\mathcal{E}}_F$ by computing the nullspace of the matrix

$$M = \begin{pmatrix} & | & 2^e & \cdots & 0 \\ & \tilde{v}_{\mathfrak{p}_i}(\varepsilon_j) & | & \cdot & \cdots & \cdot \\ & & | & 0 & \cdots & 2^e \end{pmatrix}$$

with r + c + 2d - 1 columns and d rows. We assume that the nullspace is generated by the columns of the matrix

$$M' = \begin{pmatrix} & C \\ - & - & - \\ & D \\ & & \end{pmatrix}$$

where C has r + c + d - 1 and D exactly d rows. It suffices to consider C. Each column $(n_1, ..., n_{r+c+d-1})^{tr}$ of the matrix C corresponds to a unit

$$\prod_{i=1}^{r+c+d-1} \varepsilon_i^{n_i} \in \widetilde{\mathcal{E}}_F \mathcal{R}_F^{2^e}$$

so that we can choose

$$\tilde{\varepsilon} := \prod_{i=1}^{r+c+d-1} \varepsilon_i^{n_i}$$

as an approximation for a logarithmic unit. This procedure yields $k \ge r + c$ logarithmic units. Of course, by the generalized Gross conjecture we would have exactly r + c such units.

If the integer k which we get in our calculations is not much larger than r+cthen we will proceed with the k generating elements of $\tilde{\mathcal{E}}_F$ obtained. Otherwise, we reduce the number of generators by computing a basis of the submodule of $\mathbb{Z}^{r+c+d-1}$ which is the span of the columns of C. Hence, from now on we may assume that we have determined exactly r+c generators $\tilde{\varepsilon}_1, ..., \tilde{\varepsilon}_{r+c}$ of $\tilde{\mathcal{E}}_F$.

To conclude, with the notations of (4) the columns of the following matrix $R \in \mathbb{Z}_2^{(\nu+r) \times (\nu+2r+c+1)}$ generate all relations for the $(\mathfrak{a}_j, 1)$ and the $(0, \epsilon_j)$:

4 Applications in *K*-Theory

We adopt the notations and definitions in this section from [12]. In particular i denotes a primitive fourth root of unity; and we say that the number field F is *exceptional* when i is not contained in the cyclotomic \mathbb{Z}_2 -extension F^c of F, i.e. whenever the cyclotomic extension $F^c[i]/F$ is not procyclic.

We say that a non-complex place \mathfrak{p} of a number field F is *signed* whenever the local field $F_{\mathfrak{p}}$ does not contain the fourth root of unity i. These are the places which do not decompose in the extension F[i]/F. For such a place \mathfrak{p} , there exists a non trivial sign-map

$$\operatorname{sign}_{\mathfrak{p}} : F_{\mathfrak{p}}^{\times} \to \{\pm 1\},$$

given by the Artin reciprocity map $F_{\mathfrak{p}}^{\times} \to \operatorname{Gal}(F_{\mathfrak{p}}[i]/F_{\mathfrak{p}})$ of class field theory.

We say that a non-complex place \mathfrak{p} of F is *logarithmically signed* if and only if one has $i \notin F_{\mathfrak{p}}^c$. These are the places which do not decompose in $F^c[i]/F^c$. So the finite set PLS_F of logarithmic signed places of the field F only contains:

- (i) the subset PR_F of infinite real places and
- (ii) the subset PE_F of exceptional dyadic places, i.e. the set of logarithmic signed places above the prime 2.

We say that a non-complex place \mathfrak{p} of F is *logarithmically primitive* if and only if \mathfrak{p} does not decompose in the first step E/F of the cyclotomic \mathbb{Z}_2 -extension F^c/F . Finally we say that an exceptional number field F is *primitive* whenever there exists an exceptional dyadic place which is logarithmically primitive.

Naturally, the task arises to determine logarithmically signed places, i.e. those non complex places of F for which i is not contained in $F_{\mathfrak{p}}^c$:

Proposition 2. Let $E_{\mathfrak{p}}$ be the first quadratic extension of $F_{\mathfrak{p}}$ in the tower of field extension from $F_{\mathfrak{p}}$ to $F_{\mathfrak{p}}^c$. Then $i \in F_{\mathfrak{p}}^c$ holds precisely for $i \in E_{\mathfrak{p}}$.

Proof. Since $F_{\mathfrak{p}}^c/F_{\mathfrak{p}}$ is a \mathbb{Z}_2 -extension, it contains exactly one quadratic extension $E_{\mathfrak{p}}$ of $F_{\mathfrak{p}}$. So we immediately obtain:

$$i \in F_{\mathfrak{p}}^c \Leftrightarrow F_{\mathfrak{p}}(i) \subseteq E_{\mathfrak{p}} \Leftrightarrow i \in E_{\mathfrak{p}}$$

Remark. The extension $E_{\mathfrak{p}}$ is $F_{\mathfrak{p}}(\alpha_k)$ where k is the smallest integer such that α_k does not belong to $F_{\mathfrak{p}}$ with $\alpha_0 = 0$ and $\alpha_{k+1} = \sqrt{2 + \alpha_k}$.

We assume in the following that the number field F has no exceptional dyadic place. Let us introduce the group $\mathcal{C}\ell_F^{res}$ of narrow logarithmic classes without any assumption of degree:

$$\mathcal{C}\ell_F^{res} = \mathcal{D}\ell_F^{res} / \widetilde{\mathcal{P}}\ell_F^{res}$$

Via the degree map, we obtain the direct decomposition:

$$\mathcal{C}\ell_F^{res} \simeq \mathbb{Z}_2 \oplus \widetilde{\mathcal{C}\ell}_F^{res}$$

where the torsion subgroup $\widetilde{\mathcal{C}}\ell_F^{res}$ was yet computed in the previous section. So the quotient of exponent 2

$${}^{2}\mathcal{C}\ell_{F}^{\,res} := \mathcal{C}\ell_{F}^{\,res}/(\mathcal{C}\ell_{F}^{\,res})^{2}$$

contains both as hyperplanes the two quotients ${}^{2}\widetilde{\mathcal{C}}\ell_{F}^{res}$ relative to $\widetilde{\mathcal{C}}\ell_{F}^{res}$ and ${}^{2}\mathcal{C}\ell_{F}^{pos}$ relative to the positive class group $\mathcal{C}\ell_{F}^{pos}$ introduced in [12].

Since, according to [12], this later gives the 2-rank of the wild kernel $WK_2(F)$. we can extend the results of K. Hutchinson [6, 7] as follows:

Theorem 3. Let F be a number field which has no exceptional dyadic places.

(i) If F is not exceptional (i.e. in case $i \in F^c$) the wild kernel $WK_2(F)$ coincide with the subgroup $K_2^{\infty}(F) = \bigcap_{n \geq 1} K_2^n(F)$ of infinite height elements in $K_2(F)$; the group $\widetilde{\mathcal{C}\ell}_F^{res}$ of narrow logarithmic classes coincide with the group $\widetilde{\mathcal{C}\ell}_F$ of (ordinary) logarithmic classes; and one has immediately:

$$\operatorname{rk}_2 WK_2(F) = \operatorname{rk}_2 K_2^{\infty}(F) = \operatorname{rk}_2 \widetilde{\mathcal{C}}\ell_F^{res} = \operatorname{rk}_2 \widetilde{\mathcal{C}}\ell_F$$

(ii) If F is exceptional (i.e. in case $i \notin F^c$) the subgroup $K_2^{\infty}(F)$ has index 2 in the wild kernel $WK_2(F)$ and one still has:

$$\operatorname{rk}_2 WK_2(F) = \operatorname{rk}_2 \widetilde{\mathcal{C}\ell}_F^{res} \ge 1$$

(ii,a) In case $WK_2(F)$ and $K_2^{\infty}(F)$ have the same 2-rank, this gives: $\operatorname{rk}_2 K_2^{\infty}(F) = \operatorname{rk}_2 \widetilde{\mathcal{C}\ell}_F^{res} \geq 1.$

(*ii*,*b*) And in case
$$K_2^{\infty}(F)$$
 is a direct summand in $WK_2(F)$, one has.
 $\operatorname{rk}_2 K_2^{\infty}(F) = \operatorname{rk}_2 \widetilde{\mathcal{C}\ell}_F^{res} - 1.$

Proof. In the non exceptional case, the number field F is not locally exceptional, i.e. has no logarithmic signed places: $PE_F = PR_F = \emptyset$. In particular, narrow logarithmic classes coincide with ordinarity logarithmic classes and the result follows from [12].

In the exceptional case, the number field F may have real places, so the narrow logarithmic class group $\widetilde{\mathcal{C}}\ell_F^{res}$ may differ from the ordinary logarithmic class group. Moreover, because the assumption $PE_F = \emptyset$ and accordingly to Hutchinson [6, 7], the subgroup $K_2^{\infty}(F)$ has index 2 in the wild kernel $WK_2(F)$.

Remark. It remains to determine whether a number field F is not exceptional, *i.e.* whether the cyclotomic \mathbb{Z}_2 extension F^c contains the fourth root of unity i. Of course if $i \in F^c$ then i is contained in the quadratic subfield E/F in F^c . Now the finite subfields of \mathbb{Q}^c are the real cyclic fields $\mathbb{Q}^{(s)} = \mathbb{Q}[\zeta_{2^{s+2}} + \zeta_{2^{s+2}}^{-1}]$ and the finite extensions of F^c are of the form $F\mathbb{Q}^{(s)}$. So we only need to check whether i is contained in $F[\zeta_{2^{s+2}} + \zeta_{2^{s+2}}^{-1}]$ where s is minimal with $\zeta_{2^{s+2}} + \zeta_{2^{s+2}}^{-1} \notin F$.

5 Examples

The methods described here are implemented in the computer algebra system Magma [2]. Many of the fields used in the examples were results of queries to the QaoS number field database [13, section 6].

The wild kernel $WK_2(F)$ is contained in the tame kernel $K_2(\mathcal{O}_F)$. Let $\mu(F)$ be the order of the torsion subgroup of F^{\times} and for a prime \mathfrak{p} of F over p denote by $\mu^1(F_{\mathfrak{p}})$ the *p*-Sylow subgroup of the torsion subgroup of $F_{\mathfrak{p}}^{\times}$. By coupling Moore's exact sequence and the localization sequence [5, section 1] one obtains the index formula [1, equation (6)]:

$$(K_2(\mathcal{O}_F): WK_2(F)) = \frac{2^r}{|\mu(F)|} \prod_{\mathfrak{p}} |\mu^1(F_{\mathfrak{p}})|,$$

where p runs through all finite places and r is the number of real places of F.

We apply this in the determination of the structure of $WK_2(F)$ in the cases where the structure of $K_2(\mathcal{O}_F)$ is known.

Abelian groups are given as a list of the orders of their cyclic factors;

[:] denotes the index $(K_2(O_F) : WK_2(F))$;

 d_F denotes the discriminant for a number field F;

 $\mathcal{C}\ell_F$ denotes the class group, P the set of dyadic places;

 $\mathcal{C}\ell'_F$ denotes the 2-part of $Cl/\langle P \rangle$;

 $\widetilde{\mathcal{C}\ell}_F$ denotes the logarithmic classgroup;

 $\mathcal{C}\ell_F^{res}$ denotes the group of narrow logarithmic classes;

 rk_2 denotes the 2-rank of the wild kernel WK_2 ;

 WK_2 denotes the wild kernel in $K_2(F)$;

 K_2^{∞} denotes the subgroup of infinite height elements in $K_2(F)$.

5.1 Imaginary quadratic fields

K. Belabas and H. Gangl have developed an algorithm for the computation of the tame kernel $K_2\mathcal{O}_F$ [1]. The following table contains the structure of $K_2\mathcal{O}_F$ as computed by Belabas and Gangl and the 2-rank of the wild kernel $WK_2(F)$ calculated with our methods. We also give the structure of the wild kernel if it can be deduced from the structure of $K_2\mathcal{O}_F$ and of the rank of the wild kernel computed here or in [14]. The structure of the tame kernel $K_2(\mathcal{O}_F)$ of all fields except for the starred entries has been proven by Belabas and Gangl.

The table gives the structure of the wild kernel of all imaginary quadratic fields F with no exceptional places and discriminant $|d_F| < 1000$.
