## Unilateral contact with adhesion and friction between two hyperelastic bodies

In the present paper, we consider a thermodynamic model using the contact kinematics developed by A. Curnier, Q.C. He and J.J. Téléga [C. R. Acad. Sci. Paris Sér. II 314 (1992) 1] involving unilateral contact, adhesion and Coulomb friction between two homogeneous, isotropic and hyperelastic bodies. Adhesion is described by an internal state variable  $\beta^{\varphi}$  introduced by M. Frémond [C. R. Acad. Sci. Paris Sér. II 295 (1982) 913; J. Theor. Appl. Mech. 6 (1987) 383]. Taking the case of contact between a hyperelastic solid and a plane support, we formulate the associated boundary value problem as a minimization problem when no friction is involved. When the intensity of the adhesion obeys a 'static' law, we obtain an existence result for this problem.

### 1. Introduction

In this paper, we propose a thermodynamic model considering both unilateral contact, adhesion and friction between two elastic bodies in the framework of finite deformations [4]. Many interface debonding models have been developed in the framework of small displacements and small deformations. Our model deals with the evolution of the decohesion at the interface between two bodies. Cohesive forces at the interface may act in both the normal and tangential directions. Some of these models take into account unilateral conditions of non-penetration and friction

between the bodies. This is the case of the model proposed by Cangémi [5] and Raous et al. [20,21]. With our formulation, the interface debonding models are extended to include the case of finite deformations, decohesion, friction and unilateral contact. According to Frémond [10,11], the adhesion is characterized by its intensity  $\beta^{\varphi}$ , which can vary from 1 (perfect adhesion) to 0 (no adhesion).

The thermodynamic bases of the model are presented in part 2. We begin by giving the contact kinematics in the framework of finite deformations. Using an approach proposed by Curnier et al. [7], we define the gap vector via the orthogonal projection of a point belonging to one of the candidate potential contact surfaces onto the other one. Then we define an objective relative contact velocity of one surface with respect to the other. This local approach is suitable for defining the impenetrability condition via a signed gap vector. Another approach, proposed by Ciarlet and Nečas [6], consists in adopting an overall formulation, assuming a unilateral contact condition under the constraint to stay within a set. Since this does not seem to be very suitable for numerical investigations, we adopted the local approach. The thermodynamic bases of the model are developed and we describe only the contact behavior of one of the two surfaces, as we are able to deduce the behavior of the other one from the extended action—reaction principle [7]. When the free energy density and the pseudo-potential of dissipation are suitably chosen, the complete boundary value problem is obtained.

Finally, in the particular case of contact with a plane rigid support, we propose a variational formulation of the problem with respect to the reference configuration. When the adhesive contact is assumed to be frictionless, the corresponding variational problem can be reduced to a minimization problem, for which an existence result can be obtained if the intensity of the adhesion obeys a 'static' law [2,6,7].

#### 2. A thermodynamic model for unilateral contact, adhesion and friction

### 2.1. Contact kinematics

Throughout this paper, the variable  $\alpha$  will be assumed to be 1 and 2. We consider two solids  $\mathscr{B}^{\alpha}$  occupying, in some reference configurations, two domains  $\Omega^{\alpha} \in \mathbb{R}^3$  with their boundaries denoted by  $\Gamma^{\alpha}$  and let  $\mathbf{n}^{\alpha}$  be the corresponding outward normal unit vector. We will identify each particle of  $\mathscr{B}^{\alpha}$  with its position vector in  $\Omega^{\alpha}$  denoted by  $\mathbf{X}^{\alpha}$ . Motions of bodies are defined by the locally invertible and orientation-preserving mappings  $\varphi^{\alpha}$  such that for all  $t \in [0, T]$ 

$$\varphi^{\alpha}(\cdot,t):\bar{\Omega}^{\alpha}\to\mathbb{R}^3.$$

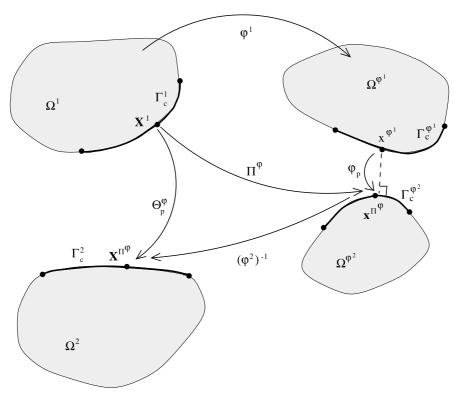


Fig. 1. Contact and kinematics.

The sets  $\Omega^{\varphi^z} = \varphi^\alpha(\Omega^\alpha,t)$  are the deformed counterparts of  $\Omega^\alpha$ , and  $\mathbf{n}^{\varphi^z}$  is the outward normal unit vector to  $\partial \Omega^{\varphi^z}$ . Let us denote by  $\mathbf{x}^{\varphi^z} = \varphi^\alpha(\mathbf{X}^\alpha,t)$  the position vector in the deformed configuration. Finally, we assume that the boundaries are regular enough, and each of them is decomposed into three disjoint open parts, denoted by  $\Gamma_\mathrm{D}^\alpha, \Gamma_\mathrm{T}^\alpha, \Gamma_\mathrm{C}^\alpha, \Gamma_\mathrm{D}^{\varphi^z} = \varphi^\alpha(\Gamma_\mathrm{D}^\alpha,t), \ \Gamma_\mathrm{T}^{\varphi^z} = \varphi^\alpha(\Gamma_\mathrm{T}^\alpha,t)$  and  $\Gamma_\mathrm{C}^{\varphi^z} = \varphi^\alpha(\Gamma_\mathrm{C}^\alpha,t)$ , respectively. We assume that the deformations are prescribed on  $\Gamma_\mathrm{D}^\alpha$  and  $\Gamma_\mathrm{D}^{\varphi^z}$  in both configurations, that the surface density forces  $\mathbf{T}^x, \mathbf{T}^\varphi$  on  $\Gamma_\mathrm{T}^\alpha, \Gamma_\mathrm{T}^{\varphi^z}$  are, respectively, applied and that  $\Gamma_\mathrm{C}^\alpha, \Gamma_\mathrm{C}^{\varphi^z}$  are the potential contact surfaces in the two configurations, where the bodies can

be in unilateral contact. We denote by  $\mathbf{t}^{\alpha}$ ,  $\mathbf{t}^{\varphi^{\alpha}}$  the surface density forces on  $\Gamma_{\mathrm{C}}^{\alpha}$ ,  $\Gamma_{\mathrm{C}}^{\varphi^{\alpha}}$ , respectively. The bodies are subjected to given body forces denoted by  $\mathbf{f}^{\alpha}$ ,  $\mathbf{f}^{\varphi^{\alpha}}$  in  $\Omega^{\alpha}$ ,  $\Omega^{\varphi^{\alpha}}$ , respectively. Let us take  $\Omega^{\varphi^{1}}$  to be the contactor body and  $\Omega^{\varphi^{2}}$  the target one. Under appropriate smoothness assumptions, we define a one-to-one correspondence via the projection which associates to  $\mathbf{x}^{\varphi^1}$  his proximal point denoted by  $\mathbf{x}^{\Pi^{\varphi}} = \varphi^2(\mathbf{X}^{\Pi^{\varphi}})$ . This vector coincides with the orthogonal projection of  $\mathbf{x}^{\varphi^1}$  onto  $\Gamma^{\varphi^2}$ . Let us denote by  $\varphi_p$  this projection (Fig. 1). The point  $\mathbf{X}^{\Pi^{\varphi}}$  is the solution to the following minimization problem:

$$\|\varphi^{1}(\mathbf{X}^{1},t) - \varphi^{2}(\mathbf{X}^{\Pi^{\varphi}},t)\| = \min_{\mathbf{X}^{2} \in \Gamma_{C}^{2}} \|\varphi^{1}(\mathbf{X}^{1},t) - \varphi^{2}(\mathbf{X}^{2},t)\|.$$

$$(1)$$

Each point of  $\Gamma_{\rm C}^{\varphi^1}$  is thus linked to a point of  $\Gamma_{\rm C}^{\varphi^2}$ . In the reference configuration, we define the mappings  $\Theta_p^{\varphi}:\Gamma_{\rm C}^1\to\Gamma_{\rm C}^2$  and  $\Pi^{\varphi}:\Gamma_{\rm C}^1\to\Gamma_{\rm C}^{\varphi^2}$  by

$$\Theta_p^{\varphi} = (\varphi^2)^{-1} \circ \varphi_p \circ \varphi^1, \quad \Pi^{\varphi} = \varphi_p \circ \varphi^1. \tag{2}$$

The problem can therefore be written in both configurations using either the Cauchy stress tensor or the Piola-Kirchhoff stress tensor.

Let us now consider a parametrization of  $\Gamma_{\rm C}^{\varphi^2}$  which will help to construct a local frame for the solid  $\Omega^{\varphi^2}$  [8,13,14]. We define therefore a differentiable and invertible mapping  $\gamma^2$  such that

$$\gamma^2: A^2 \to \Gamma_C^2, \tag{3}$$

where  $A^2$  is an open subset of  $\mathbb{R}^2$ . Let  $\gamma^{\varphi^2}: A^2 \to \Gamma^{\varphi^2}_{C}$  be such that

$$\gamma^{\varphi^2} = \varphi^2 \circ \gamma^2. \tag{4}$$

Each element of  $A^2$  is denoted by

$$\boldsymbol{\xi}^{\varphi^2} = \left(\xi_1^{\varphi^2}, \xi_2^{\varphi^2}\right) = \left(\gamma^{\varphi^2}\right)^{-1} \left(\mathbf{x}^{\varphi^2}\right).$$

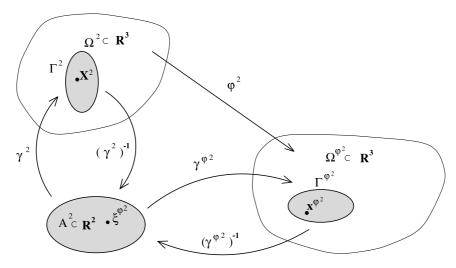


Fig. 2. Parametrization of the target's potential contact zone.

For the position vector  $\mathbf{X}^2 \in \Gamma_{\mathbf{C}}^2$  and the corresponding vector  $\mathbf{x}^{\varphi^2} \in \Gamma_{\mathbf{C}}^{\varphi^2}$ , we have the relation (Fig. 2)

$$\mathbf{X}^2 = \gamma^2 \Big( \boldsymbol{\xi}^{\varphi^2} \Big), \quad \mathbf{x}^{\varphi^2} = \gamma^{\varphi^2} \Big( \boldsymbol{\xi}^{\varphi^2} \Big) = \varphi^2 \Big( \gamma^2 \Big( \boldsymbol{\xi}^{\varphi^2} \Big), t \Big).$$

The minimization problem (1) can then be written as follows:

$$\left\| \varphi^{1}(\mathbf{X}^{1}, t) - \varphi^{2}\left(\gamma^{2}\left(\boldsymbol{\xi}_{p}^{\varphi}\right), t\right) \right\| = \min_{\boldsymbol{\xi} \in A^{2}} \left\| \varphi^{1}(\mathbf{X}^{1}, t) - \varphi^{2}\left(\gamma^{2}(\boldsymbol{\xi}), t\right) \right\|, \tag{5}$$

where  $\xi_p^{\varphi}$  denotes the minimizer. We suppose that these parametrizations are sufficiently smooth, so that we can define a local frame for the surface of the second solid at  $\mathbf{x}^{\Pi^{\varphi}}$ . In the deformed configuration, we define the local frame  $(\boldsymbol{\tau}_1^{\varphi^2}, \boldsymbol{\tau}_2^{\varphi^2}, \mathbf{n}^{\varphi^2})$  by

$$\begin{cases} \boldsymbol{\tau}_{\alpha}^{\varphi^{2}}\left(\mathbf{x}^{\varphi^{2}}\right) = \tilde{\boldsymbol{\tau}}_{\alpha}^{\varphi^{2}}\left(\mathbf{X}^{2}\right) & \hat{\boldsymbol{\tau}}_{\alpha}^{\varphi^{2}}\left(\boldsymbol{\xi}^{\varphi^{2}}\right) & \frac{\partial \gamma^{\varphi^{2}}\left(\boldsymbol{\xi}^{\varphi^{2}}\right)}{\partial \boldsymbol{\xi}_{\alpha}^{\varphi^{2}}}, \\ \boldsymbol{n}^{\varphi^{2}}\left(\mathbf{x}^{\varphi^{2}}\right) = \tilde{\boldsymbol{n}}^{\varphi^{2}}\left(\mathbf{X}^{2}\right) & \hat{\boldsymbol{n}}^{\varphi^{2}}\left(\boldsymbol{\xi}^{\varphi^{2}}\right) & \frac{\hat{\boldsymbol{\tau}}_{1}^{\varphi^{2}}\left(\boldsymbol{\xi}^{\varphi^{2}}\right) \wedge \hat{\boldsymbol{\tau}}_{2}^{\varphi^{2}}\left(\boldsymbol{\xi}^{\varphi^{2}}\right)}{\left\|\hat{\boldsymbol{\tau}}_{1}^{\varphi^{2}}\left(\boldsymbol{\xi}^{\varphi^{2}}\right) \wedge \hat{\boldsymbol{\tau}}_{2}^{\varphi^{2}}\left(\boldsymbol{\xi}^{\varphi^{2}}\right)\right\|} \end{cases}$$

and in the reference configuration we define  $(\tau_1^2, \tau_2^2, \mathbf{n}^2)$  by

$$\begin{cases} \boldsymbol{\tau}_{\alpha}^{2}(\mathbf{X}^{2}) & \hat{\boldsymbol{\tau}}_{\alpha}^{2}(\boldsymbol{\xi}^{\varphi^{2}}) & \frac{\partial \gamma^{2}(\boldsymbol{\xi}^{\varphi^{2}})}{\partial \boldsymbol{\xi}_{\alpha}^{\varphi^{2}}} = (\nabla \varphi^{2})^{-1} (\gamma^{2}(\boldsymbol{\xi}^{\varphi^{2}})) \hat{\boldsymbol{\tau}}_{\alpha}^{\varphi^{2}}(\boldsymbol{\xi}^{\varphi^{2}}), \\ \boldsymbol{n}^{2}(\mathbf{X}^{2}) = \hat{\boldsymbol{n}}^{2}(\boldsymbol{\xi}^{\varphi^{2}}) & \frac{\hat{\boldsymbol{\tau}}_{1}^{2}(\boldsymbol{\xi}^{\varphi^{2}}) \wedge \hat{\boldsymbol{\tau}}_{2}^{2}(\boldsymbol{\xi}^{\varphi^{2}})}{\left\|\hat{\boldsymbol{\tau}}_{1}^{2}(\boldsymbol{\xi}^{\varphi^{2}}) \wedge \hat{\boldsymbol{\tau}}_{2}^{2}(\boldsymbol{\xi}^{\varphi^{2}})\right\|}. \end{cases}$$

We will denote by  $(\boldsymbol{\tau}_1^{\varphi}, \boldsymbol{\tau}_2^{\varphi}, \mathbf{n}^{\varphi})$ ,  $(\tilde{\boldsymbol{\tau}}_1^{\varphi}, \tilde{\boldsymbol{\tau}}_2^{\varphi}, \tilde{\mathbf{n}}^{\varphi})$ ,  $(\hat{\boldsymbol{\tau}}_1^{\varphi}, \hat{\boldsymbol{\tau}}_2^{\varphi}, \hat{\mathbf{n}}^{\varphi})$  these local frames constructed at  $\mathbf{x}^{\Pi^{\varphi}}$ ,  $\Pi^{\varphi}(\mathbf{X}^1)$  and  $\gamma^{\varphi^2}(\boldsymbol{\xi}_p^{\varphi})$ , respectively, and by  $(\cdot)_n$ ,  $(\cdot)_{\tilde{n}}$ ,  $(\cdot)_{\tilde{n}}$ ,  $(\cdot)_{\tilde{\tau}}$ ,  $(\cdot)_{\tilde{\tau}}$ ,  $(\cdot)_{\hat{\tau}}$ , the normal and tangential components.

In this framework, we define the gap vector  $\mathbf{d}^{\varphi}$  for any deformation  $\varphi$  by

$$\mathbf{d}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right) = \mathbf{x}^{\varphi^{1}} - \varphi_{p}\left(\mathbf{x}^{\varphi^{1}},t\right) = \mathbf{x}^{\varphi^{1}} - \gamma^{\varphi^{2}}\left(\boldsymbol{\xi}_{p}^{\varphi}\right),\tag{6}$$

with the nominal counterpart, which can be written as follows:

$$\tilde{\mathbf{d}}^{\varphi}(\mathbf{X}^{1},t) \qquad \varphi^{1}(\mathbf{X}^{1},t) - \varphi^{2}(\boldsymbol{\Theta}_{p}^{\varphi}(\mathbf{X}^{1}),t) = \varphi^{1}(\mathbf{X}^{1},t) - \varphi^{2}(\gamma^{2}(\boldsymbol{\xi}_{p}^{\varphi}),t). \tag{7}$$

These quantities can be expressed in the previous local frames as follows:

$$\mathbf{d}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right) = d_{n^{\varphi}}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right)\mathbf{n}^{\varphi} = d_{\hat{n}^{\varphi}}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right)\hat{\mathbf{n}}^{\varphi} \tag{8}$$

and also

$$\tilde{\mathbf{d}}^{\varphi}(\mathbf{X}^{1},t) \qquad \tilde{d}^{\varphi}_{\tilde{n}^{\varphi}}(\mathbf{X}^{1},t)\tilde{\mathbf{n}}^{\varphi} = \tilde{d}^{\varphi}_{\hat{n}^{\varphi}}(\mathbf{X}^{1},t)\hat{\mathbf{n}}^{\varphi}. \tag{9}$$

Let us calculate the material derivative of this gap vector:

$$\frac{\mathrm{d}}{\mathrm{d}t} \left\{ \varphi^{1} \left( \mathbf{X}^{1}, t \right) - \varphi^{2} \left( \gamma^{2} \left( \boldsymbol{\xi}_{p}^{\varphi} \right), t \right) \right\} \qquad \hat{o}_{t} \varphi^{1} \left( \mathbf{X}^{1}, t \right) - \hat{o}_{t} \varphi^{2} \left( \gamma^{2} \left( \boldsymbol{\xi}_{p}^{\varphi} \right), t \right) - \sum_{k=1}^{2} \dot{\boldsymbol{\xi}}_{p_{k}}^{\varphi} \hat{\boldsymbol{\tau}}_{k}^{\varphi} \right) \\
= \hat{o}_{t} \varphi^{1} \left( \mathbf{X}^{1}, t \right) - \hat{o}_{t} \varphi^{2} \left( \gamma^{2} \left( \boldsymbol{\xi}_{p}^{\varphi} \right), t \right) - \dot{\boldsymbol{\xi}}_{p}^{\varphi}.$$

From (9) we can write another expression for the material derivative of the gap vector as

$$\dot{\mathbf{d}}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right) = \dot{\tilde{\mathbf{d}}}^{\varphi}\left(\mathbf{X}^{1},t\right) = \dot{\widehat{d}_{n^{\varphi}}^{\varphi}}\hat{\mathbf{n}}^{\varphi} + d_{\hat{n}^{\varphi}}^{\varphi}\dot{\hat{\mathbf{n}}}^{\varphi} = \dot{\widetilde{d}_{\hat{n}^{\varphi}}^{\varphi}}\hat{\mathbf{n}}^{\varphi} + \widetilde{d}_{\hat{n}^{\varphi}}^{\varphi}\dot{\hat{\mathbf{n}}}^{\varphi}.$$
(10)

We define a contact relative velocity as follows:

$$\mathbf{V}_{\mathrm{re}}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right) = \hat{o}_{t}\mathbf{x}^{\varphi^{1}} - \hat{o}_{t}\gamma^{\varphi^{2}}\left(\boldsymbol{\xi}_{p}^{\varphi}\right) - d_{\hat{n}^{\varphi}}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right)\dot{\hat{\mathbf{n}}}^{\varphi}.\tag{11}$$

This is an objective quantity and it is reduced to the classical relative velocity, that is,  $\mathbf{V}_{\text{re}}^{\varphi}(\mathbf{x}^{\varphi^1},t) = \partial_t \mathbf{x}^{\varphi^1}(t) - \partial_t \gamma^{\varphi^2}(\boldsymbol{\xi}_p^{\varphi})$  in the case of established contact [8,18,19]. From (11) and (10), the contact velocity can be written:

$$\mathbf{V}_{\text{re}}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right) = \widehat{d}_{n^{\varphi}}^{\varphi}\left(\mathbf{x}^{\varphi^{1}},t\right)\widehat{\mathbf{n}}^{\varphi} + \dot{\boldsymbol{\xi}}_{p}^{\varphi} = \widehat{d}_{\hat{n}^{\varphi}}^{\varphi}\left(\mathbf{X}^{1},t\right)\widehat{\mathbf{n}}^{\varphi} + \dot{\boldsymbol{\xi}}_{p}^{\varphi}. \tag{12}$$

## 2.2. The two principles of thermodynamics

Let us denote by  $\epsilon^{\varphi}$  the internal energy in an arbitrary domain  $\mathscr{D}^{\varphi^z} \subset \Omega^{\varphi^z} \cup \Gamma_C^{\varphi^z}$  such that

$$\epsilon^{arphi} = \int_{\mathscr{Q}^{arphi^{\mathtt{Z}}}} 
ho^{arphi^{\mathtt{Z}}} e^{arphi^{\mathtt{Z}}} \, \mathrm{d}\mathbf{x}^{arphi^{\mathtt{Z}}} + \int_{\partial \mathscr{Q}^{arphi^{\mathtt{Z}}} \cap \Gamma^{arphi^{\mathtt{I}}}_{\mathbf{C}}} 
ho^{arphi^{\mathtt{I}}}_{\mathbf{S}} \, e^{arphi^{\mathtt{I}}}_{\mathbf{S}} \, \mathrm{d}a^{arphi^{\mathtt{I}}},$$

where  $\rho^{\varphi^z}$  is the density and  $\rho_S^{\varphi^l}$  is the surface density of the first solid. In this paper, we study the quasi-static case and using the principle of virtual powers, the first principle reads

$$\dot{\epsilon}^{\varphi} = \mathscr{P}_{e} + \mathscr{P}_{cal} = -\mathscr{P}_{i} + \mathscr{P}_{cal},$$

where

$$\mathcal{P}_{e} = \sum_{\alpha=1}^{2} \left[ \int_{\mathscr{D}^{\varphi^{\alpha}}} \mathbf{f}^{\varphi^{\alpha}} \cdot \mathbf{v}^{\varphi^{\alpha}} \, d\mathbf{x}^{\varphi^{\alpha}} + \int_{\partial \mathscr{D}^{\varphi^{\alpha}} \setminus \Gamma_{C}^{\varphi^{\alpha}}} \tilde{\mathbf{T}}^{\varphi^{\alpha}} \cdot \mathbf{v}^{\varphi^{\alpha}} \, da^{\varphi^{\alpha}} \right],$$

$$\mathcal{P}_{i} = -\sum_{\alpha=1}^{2} \left[ \int_{\mathscr{D}^{\varphi^{\alpha}}} \boldsymbol{\sigma}^{\varphi^{\alpha}} : \mathbb{D}^{\varphi^{\alpha}} \, d\mathbf{x}^{\varphi^{\alpha}} - \int_{\partial \mathscr{D}^{\varphi^{\alpha}} \cap \Gamma_{C}^{\varphi^{\alpha}}} \mathbf{t}^{\varphi^{\alpha}} \cdot \mathbf{v}^{\varphi^{\alpha}} \, da^{\varphi^{\alpha}} \right],$$

and  $\mathbf{v}^{\varphi^z}$  is the virtual admissible velocity,  $\tilde{\mathbf{T}}^{\varphi^z}$  is the Cauchy stress vector,  $\boldsymbol{\sigma}^{\varphi^z}$  is the Cauchy stress tensor,  $\mathbb{D}^{\varphi^z}$  is the rate of deformation tensor,  $\mathbf{t}^{\varphi^z} = \boldsymbol{\sigma}^{\varphi^z} \mathbf{n}^{\varphi^z}$  is the Cauchy stress vector, which depends on the adhesive state, and  $\mathbf{q}^{\varphi^z}$  is the surface heat flux vector.

Using the following extended action–reaction principle of contact forces:

Assuming that there is no flux of material between surface and volume, the volume and surface mass conservation equations reads

Using the decomposition with respect to the local frame, the definition of the contact velocity (11) and the local moment balance [7], the internal power can be written as follows:

We classically introduce the Helmholtz free energies  $\psi^{\varphi^z}$  and  $\Psi^{\varphi^1}$  such that

## 2.3. State and complementary laws

Since the previous relations have been established quite generally, we will now present our specific choice for expressions of the free energies.

As contact situations can occur either with or without adhesion, the surface variables  $d_{\tilde{n}^{\varphi}}^{\varphi}$  and  $\xi_{p}^{\varphi}$  (which correspond to the normal and the tangential components of the displacement jump across the interface under the assumption of small displacements) does not describe completely the adhesion state. According to Frémond [10,11], we will characterize the adhesion by the internal state variable  $\beta^{\varphi} \in [0,1]$ , which represents the intensity of the adhesion between the two surfaces, such that

$$\begin{cases} 0 < \beta^{\varphi} < 1, & \text{the adhesion is partial,} \\ \beta^{\varphi} = 1, & \text{the adhesion is total,} \\ \beta^{\varphi} = 0, & \text{there is no adhesion.} \end{cases}$$

We consider a homogeneous, isotropic and hyperelastic material characterized by its stored energy function  $\hat{\mathbf{W}}^{\alpha}$  such that

where  $\mathbb{P}^{\alpha}$  is the first Piola Kirchhoff stress tensor.

To describe the deformation of the bodies in the deformed configuration, we choose the Hencky strain tensor [17] because it is conjugated to the Cauchy stress tensor when the solids are hyperelastic and isotropic, we have the following relations (see [23]):

where  $\mathbf{W}_0^{\varphi^z}$  is the strain energy density of the hyperelastic material with respect to the configuration  $\Omega^{\varphi^z}$ .

The superscripts  $(\cdot)^R$ ,  $(\cdot)^{IR}$  will denote, respectively, the reversible and irreversible parts. We take  $(t_{\hat{n}^{\varphi}}^{\varphi^1})^R$ ,  $(t_{\hat{r}^{\varphi}}^{\varphi^1})^R$  to denote the thermodynamic forces associated with  $d_{\hat{n}^{\varphi}}^{\varphi}$  and  $\xi_p^{\varphi}$  (the expressions for the irreversible components will be given later by the complementary laws). The thermodynamics forces associated to the sate variables are presented in Table 1.

The free energy depends on the Hencky strain tensor according to the following relation:

where  $K = \{d_n; d_n \ge 0\}$ ,  $P = \{\gamma; 0 \le \gamma \le 1\}$ ,  $Id_{K_1}$ ,  $Id_{P}$  are the indicator functions of K and P and  $\Psi_0^{\phi^1}$  is assumed to be objective. Moreover,  $\Psi_0^{\phi^1}$  is assumed to be equal to 0 when  $\beta^{\phi} = 0$  and differentiable at  $(d_{\hat{n}^{\phi}}^{\phi}, \xi_p^{\phi}, \beta^{\phi})$ .

We choose the following specific form for  $\Psi_0^{\varphi^1}$   $(d_{\hat{n}^{\varphi}}^{\varphi}, \xi_n^{\varphi}, \beta^{\varphi})$ :

with  $\delta_0$  a mechanical parameter for which the decohesion begins and  $\delta_c$  the one for which decohesion is complete. Here  $\delta$  denotes the norm of the gap between the two bodies:

This formulation is similar to the classical continuum damage mechanics formulation, in the case of surface damage, and generalizes some formulas used in small displacements (see [15]).

We consider the following state laws:

## 2.4. The quasi-static problem

Using the expression for  $\Psi^{\varphi^1}$  given by (25), we can write the state laws (26) via a partial sub-differentiation of  $\Psi^{\varphi^1}$ . The first inclusions in (26) become

## 3. Application to the adhesive contact between a hyperelastic body and a plane rigid support

### 3.1. The quasi-static problem

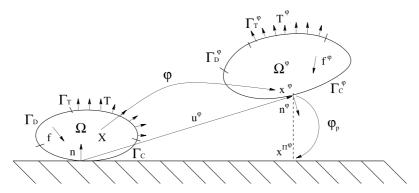


Fig. 3. Contact between an hyperelastic body and a rigid plane support.

Let us now study the contact between a hyperelastic body and a rigid fixed body (Fig. 3). We shall write  $\mathcal{P}_1$  using the Piola–Kirchhoff stress tensor and we neglect the superscript 1 in the following. The local frame is reduced to  $(\mathbf{n}, \tau)$ , the previous state variables become  $u_n^{\varphi}$ ,  $\mathbf{u}_{\tau}^{\varphi}$ ,  $\beta^{\varphi}$ .

The hyperelastic constitutive equation can be likewise written in a nominal formulation (22). In this particular case, the boundary value problem is reduced to:

**Problem**  $\mathscr{P}_2$ . ## 3.2. An existence result for the frictionless contact problem

Let us consider the previous system (44) in a static form

- (c) there exist constants  $\alpha > 0$ ,  $\beta$ ,  $p \ge 2$ ,  $q \ge p/(p-1)$ , r > 1, such that

We have the following result:

**Theorem 3.1.** Let  $\Omega$  be a domain in  $\mathbb{R}^3$  and  $\hat{\mathbf{W}} : \mathbf{M}_+^3 \to \mathbb{R}$  be a strain energy density with properties (b), (c), (d) and let  $L : W^{1,p}(\Omega, \mathbb{R}^3) \to \mathbb{R}$  be continuous.

Let  $\Gamma = \bar{\Gamma}_D \cup \bar{\Gamma}_T \cup \bar{\Gamma}_C$  be a da-measurable partition of the boundary of  $\Omega$  with area  $\Gamma_D > 0$ , and let  $\phi_D : \Gamma_D \to \mathbb{R}^3$  be a measurable function such that the set 2 is non-empty. We assume that the integrand of J has the property (a). Let us assume that

$$\inf_{\eta \in \mathcal{D}} [I(\eta) + J(\eta)] < \infty. \tag{46}$$

Then there exists at least one function  $\varphi$  such that:

$$\varphi \in \mathcal{Q} \quad and \quad I(\varphi) + J(\varphi) = \inf_{\eta \in \mathcal{Q}} [I(\eta) + J(\eta)].$$
 (47)

**Proof.** Let  $(\varphi^k)$  an infimizing sequence for the functional I+J, i.e., a sequence that satisfies  $\varphi^k \in \mathcal{Q} \ \forall k \in \mathbb{N}^*$  and

$$\lim_{k \to \infty} \left( I(\varphi^k) + J(\varphi^k) \right) \quad \inf_{\eta \in \mathcal{Q}} [I(\eta) + J(\eta)],$$

and let us consider a sub-sequence of the infimizing sequence  $(\varphi^k)$  such that  $\varphi^k \rightharpoonup \varphi$  in  $W^{1,p}(\Omega; \mathbb{R}^3)$ .

From assumptions (a) and (46),  $\inf_{\eta \in \mathcal{Z}} I(\eta) < \infty$ ,  $\varphi \in \mathcal{Z}$  and [2,6]

$$I(\varphi) \leqslant \liminf_{k \to \infty} I(\varphi^k).$$

We now show that J is sequentially weakly lower semi-continuous. For this purpose, we consider a sequence  $(\eta^k) \in \mathcal{Q}$  such that  $\eta^k \rightharpoonup \eta$  in  $W^{1,p}(\Omega; \mathbb{R}^3)$ . Then from a compactness result (see, e.g.,

[1]),  $\eta^k \to \eta$  in  $L^p(\Gamma_C; \mathbb{R}^3)$ . This means that there exists a subsequence of  $(\eta^k)$  that converges almost everywhere towards  $\eta$ . Under the hypothesis (a), this sub-sequence satisfies

$$\hat{\Psi}_0(\eta) \leqslant \liminf_{k \to \infty} \hat{\Psi}_0(\eta^k).$$

Using this relation and Fatou's lemma, we obtain

$$J(\eta) \leqslant \liminf_{k \to \infty} \int_{\Gamma_C} \rho \hat{\Psi}_0(\eta^k) da = \liminf_{k \to \infty} J(\eta^k).$$

It can therefore be concluded that J is sequentially weakly lower semi-continuous. Then the minimization problem has the solution  $\varphi$  since,

$$\inf_{\eta\in\mathcal{Q}}[I(\eta)+J(\eta)]\leqslant I(\varphi)+J(\varphi)\leqslant \liminf_{k\to\infty}\left[I\left(\varphi^k\right)+J\left(\varphi^k\right)\right] \quad \inf_{\eta\in\mathcal{Q}}[I(\eta)+J(\eta)]. \qquad \Box$$
