# Representation of continuous linear forms on the set of ladlag processes and the pricing of American claims under proportional costs

#### Abstract

We discuss a $d$-dimensional version (for làdlàg optional processes) of a duality result by Meyer (1976) between bounded càdlàg adapted processes and random measures. We show that it allows to establish, in a very natural way, a dual representation for the set of initial endowments which allow to super-hedge a given American claim in a continuous time model with proportional transaction costs. It generalizes a previous result of Bouchard and Temam (2005) who considered a discrete time setting. It also completes the very recent work of Denis, De Vallière and Kabanov (2008) who restricted to càdlàg American claims and used a completely different approach.

## 1 Introduction and definitions

Let $(\Omega, \mathcal{F}, \mathbb{P})$ be a complete probability space endowed with a filtration $\mathbb{F}:=\left(\mathcal{F}_{t}\right)_{t \leq T}$ satisfying the usual assumptions. Here $T<\infty$ is some fixed time horizon and we shall assume all over this paper that $\mathcal{F}_{T-}=\mathcal{F}_{T}$.

### 1.1 Model specifications

A d-dimensional market with proportional transaction costs can be described by the exchange rates between the different assets. They are modeled as an adapted càdlàg $d$-dimensional matrix valued process $\Pi=\left(\pi^{i j}\right)_{i, j \leq d}$. Each entry $\pi_{t}^{i j}$ denotes the number of units of assets $i$ which is required to obtain one unit of asset $j$ at time $t$. In this paper, we shall assume that it satisfies the following natural conditions:
(i) $\pi_{t}^{i i}=1, \pi_{t}^{i j}>0$ for all $t \leq T \mathbb{P}-$ a.s.
(ii) $\pi_{t}^{i j} \leq \pi_{t}^{i k} \pi_{t}^{k j}$ for all $t \leq T$ and $1 \leq i, j, k \leq d \mathbb{P}-$ a.s.

Following [3], we also assume that the technical condition $\Pi_{T-}=\Pi_{T} \mathbb{P}-$ a.s. is satisfied.

A position in the market at time $t$ is described as a $d$-dimensional vector $\widehat{V}_{t}$ whose $i$-th component coincides with the number of units of asset $i$ held at time $t$. Such a position is solvent if an immediate exchange in the market allows to turn each of its components into non-negative ones. The superscript ${ }^{\wedge}$ is used to insist on the fact that we are dealing with quantities. In mathematical terms, this means that it belongs to the closed convex cone $\widehat{K}_{t}(\omega)$ generated by the unit vectors ${ }^{1} e_{i}, i \leq d$, of $\mathbb{R}^{d}$ and the vectors $\pi_{t}^{i j}(\omega) e^{i}-e^{j}, i, j \leq d$.
Observe that the above conditions (i)-(ii) imply that $\mathbb{R}_{+}^{d} \subset \widehat{K}$, where the inclusion has to be understood for all $t \leq T \mathbb{P}-$ a.s.

Noting that an immediate transaction on the market changes the portfolio by a vector of quantities of the form $\xi_{t}(\omega) \in-\partial \widehat{K}_{t}(\omega)$, the boundary of $-\widehat{K}_{t}(\omega)$, it is thus natural to define self-financing strategies as vector processes $\widehat{V}$ such that $d \widehat{V}_{t}(\omega)$ belongs in some sense to $-\widehat{K}_{t}(\omega)$, the passage from $-\partial \widehat{K}_{t}(\omega)$ to $-\widehat{K}_{t}(\omega)$ reflecting the idea that one can always "throw away" some (non-negative) quantities of assets.

Such a modelization was introduced and studied at different levels of generality in [10], [11] and [3] among others, and it is now known from the work of [16] and [3] that a good definition of self-financing wealth processes is the following:

Definition 1.1. We say that $a \mathbb{R}^{d}$-valued làdlàg predictable process $\widehat{V}$ is $a$ selffinancing strategy if it has $\mathbb{P}-$ a.s. finite total variation and:

[^0](i) $\dot{\hat{V}}^{c}:=d \widehat{V}^{c} / d \operatorname{Var}\left(\widehat{V}^{c}\right) \in-\widehat{K} d \operatorname{Var}\left(\widehat{V}^{c}\right)$-a.e. $\mathbb{P}-$ a.s., where $\widehat{V}^{c}$ denotes the continuous part of $\widehat{V}$ and $\operatorname{Var}\left(\widehat{V}^{c}\right)$ its total variation,
(ii) $\Delta^{+} \widehat{V}_{\tau}:=\widehat{V}_{\tau+}-\widehat{V}_{\tau} \in-\widehat{K}_{\tau} \mathbb{P}-$ a.s. for all stopping time $\tau \leq T \mathbb{P}-$ a.s.,
(iii) $\Delta \widehat{V}_{\tau}:=\widehat{V}_{\tau}-\widehat{V}_{\tau-} \in-\widehat{K}_{\tau-} \mathbb{P}-$ a.s. for all predictable stopping time $\tau \leq T$ $\mathbb{P}-a . s$.
Given $v \in \mathbb{R}^{d}$, we denote by $\widehat{\mathcal{V}}^{v}$ the set of self-financing strategies $\widehat{V}$ such that $\widehat{V}_{0}=v$.
Here and below, we use the convention $X_{T+}=X_{T}$ and $X_{0-}=0$ for any làdlàg process $X$ on $[0, T]$.

In order to avoid arbitrage opportunities, we shall assume all over this paper that the following standing assumption holds.

Standing assumption: There exists at least one càdlàg martingale $Z$ such that
(i) $Z_{t} \in \widehat{K}_{t}^{*}$ for all $t \leq T, \mathbb{P}-$ a.s.
(ii) for every $[0, T] \cup\{\infty\}$-valued stopping times $Z_{\tau} \in \operatorname{Int}\left(\widehat{K}_{\tau}^{*}\right) \mathbb{P}-$ a.s. on $\{\tau<\infty\}$ and for every predictable $[0, T] \cup\{\infty\}$-valued stopping times $Z_{\tau-} \in \operatorname{Int}\left(\widehat{K}_{\tau-}^{*}\right)$ $\mathbb{P}-$ a.s. on $\{\tau<\infty\}$.

Here, $\widehat{K}_{t}^{*}(\omega):=\left\{y \in \mathbb{R}^{d}: x y:=\sum_{i \leq d} x^{i} y^{i} \geq 0 \forall x \in \widehat{K}_{t}(\omega)\right\}$ is the positive polar of $\widehat{K}_{t}(\omega)$. We denote by $\mathcal{Z}^{s}$ the set of processes satisfying the above conditions. Such elements were called strictly consistent price processes by [3], see also [17], because they allow to price contingent claims in a strictly consistent way, see the discussion in [3]. Note that $\widehat{K}^{*} \subset \mathbb{R}_{+}^{d}$ since $\mathbb{R}_{+}^{d} \subset \widehat{K}$.
As pointed out in Lemma 8 in [3], the set $\widehat{\mathcal{V}}^{0}$ admits the following alternative representation under the assumption $\mathcal{Z}^{s} \neq \emptyset$.
Proposition 1.1. Let $\widehat{V}$ be $a \mathbb{R}^{d}$-valued predictable process with $\mathbb{P}$-a.s. finite total variation such that $\widehat{V}_{0}=0$. Then, $\widehat{V} \in \widehat{\mathcal{V}}^{0}$ if and only if

\widehat{V}_{\tau}-\widehat{V}_{\sigma} \in-\widehat{K}_{\sigma, \tau} \mathbb{P}-\text { a.s. for all stopping times } \sigma \leq \tau \leq T \text {, } \tag{1.1}
\end{equation*}

with

$$
\widehat{K}_{\sigma, \tau}(\omega):=\overline{c o n v}\left(\bigcup_{\sigma(\omega) \leq t \leq \tau(\omega)} \widehat{K}_{t}(\omega), 0\right)
$$

where $\overline{\text { conv }}$ denotes the closure in $\mathbb{R}^{d}$ of the convex envelope.
Remark 1.1. The technical conditions $\mathcal{F}_{T-}=\mathcal{F}_{T}$ and $\Pi_{T-}=\Pi_{T}$ are used to simplify the presentation. Note that we can always reduce to this case by considering a larger time horizon $T^{*}>T$ and by considering a model where $\mathcal{F}_{t}=\mathcal{F}_{T^{*}}$ and $\Pi_{t}=\Pi_{T^{*}}$ for $t \in\left[T, T^{*}\right]$.

### 1.2 The super-hedging problem

The super-hedging problem of an European contingent claim was studied at different levels of generality by [10], [11] and [3], see also the references therein. It can be stated as follows.
Given a random variable $\widehat{C}_{T}$, we want to characterize the set of initial endowments $v \in \mathbb{R}^{d}$ such that $\widehat{V}_{T}-\widehat{C}_{T} \in \widehat{K}_{T} \mathbb{P}-$ a.s. for some $\widehat{V} \in \widehat{\mathcal{V}}^{v}$. This means that, up to an immediate trade, the position $\widehat{V}_{T}$ can be turned into a new one such that its $i$-th component is greater than $\widehat{C}_{T}^{i}$, which should be interpreted as a number of units of asset $i$ to be delivered at time $T$ to the buyer of the European option.
Set $\mathbf{1}=(1, \ldots, 1) \in \mathbb{R}^{d}$ and let us consider the set $\widehat{\mathcal{V}}_{\mathcal{Z}^{s}}^{v}$ of elements $\widehat{V} \in \widehat{\mathcal{V}}^{v}$ such that, for some real $c>0, \widehat{V}_{T}+c \mathbf{1} \in \widehat{K}_{T}$ and $Z_{\tau} \widehat{V}_{\tau} \geq-Z_{\tau} c \mathbf{1}$ for all [ $\left.0, T\right]$-valued stopping times $\tau$ and $Z \in \mathcal{Z}^{s}$. In the case where $\widehat{C}_{T}+a \mathbf{1} \in \widehat{K}_{T} \mathbb{P}-$ a.s. for some $a>0$, it was shown in [3] that there exists $\widehat{V} \in \widehat{\mathcal{V}}_{\mathcal{Z}}^{v}$ such that $\widehat{V}_{T}-\widehat{C}_{T} \in \widehat{K}_{T}$ $\mathbb{P}$ - a.s. if and only if $\mathbb{E}\left[Z_{T}\left(\widehat{C}_{T}-v\right)\right] \leq 0$ for all $Z \in \mathcal{Z}^{s}$. Here and below, we use the notation $x y$ to denote the scalar product $\sum_{i \leq d} x^{i} y^{i}$. Comparing this result to well-known results for frictionless market, see [5], we see that $\mathcal{Z}^{s}$ plays a similar role as the set of equivalent local (sigma) martingale measures in markets without frictions. This generalizes a similar result obtained previously in [11] for the more natural set of strategies $\widehat{\mathcal{V}}_{b}^{v}$ made of càdlàg elements $\widehat{V} \in \widehat{\mathcal{V}}^{v}$ such that $\widehat{V}_{t}+c \mathbf{1} \in \widehat{K}_{t}$ for all $t \leq T \mathbb{P}-$ a.s. (in short $\widehat{V} \succeq-c \mathbf{1}$ ), for some real $c>0$. However, it requires additional assumptions, in particular the continuity of $\Pi$.

The aim of this paper is to do a similar analysis for "American options". Namely, we want to characterize the set $\widehat{\mathcal{C}}^{v}$ of optional làdlàg processes $\widehat{C}$ such that $\widehat{V} \succeq \widehat{C}$ for some $\widehat{V} \in \widehat{\mathcal{V}}^{v}$. Here, the $i$-th component of $\widehat{C}$ at time $t$ should be interpreted as the number of units of asset $i$ to be delivered to the buyer of the American option if it is exercised at a time $t$ before the maturity time $T$.

The solution to such a problem is well-known in frictionless financial models. It is related to the optimal stopping of the process $\widehat{C}$ between 0 and $T$, see [13] and Section 3 below. Since $\mathcal{Z}^{s}$ plays the same role as the set of equivalent local (sigma) martingale measures in frictionless markets, one could expect that $\widehat{C} \in \widehat{\mathcal{C}}^{v}$ if and only if $\mathbb{E}\left[Z_{\tau}\left(\widehat{C}_{\tau}-v\right)\right] \leq 0$ for all $Z \in \mathcal{Z}^{s}$ and all stopping times $\tau \leq T \mathbb{P}-$ a.s. However, it was already shown in [4] and [2], for discrete time models, that such a dual formulation does not hold and that one has to replace the notion of stopping times by the notion of randomized stopping times. Their result is of the form: if there exists $a>0$ such that $\widehat{C} \succeq-a \mathbf{1}$ then

C \in \widehat{\mathcal{C}}^{v} \Longleftrightarrow \sup _{A \in \tilde{\mathcal{D}}} \mathbb{E}\left[\int_{0}^{T}\left(\widehat{C}_{t}-v\right) d A_{t}\right] \leq 0, \tag{1.2}
\end{equation*}
$$

where $\tilde{\mathcal{D}}$ is a family of càdlàg adapted processes $A$ with integrable total variation
such that

1. $A_{0-}=0$
2. $\dot{A} \in \widehat{K}^{*} d \operatorname{Var}(A)$ a.e. $\mathbb{P}-$ a.s.
3. The optional projection $\bar{A}$ of $\left(A_{T}-A_{t}\right)_{t \leq T}$ satisfies $\bar{A}_{t} \in \widehat{K}_{t}^{*}$ for all $t \leq T \mathbb{P}-$ a.s.
4. There is a deterministic finite non-negative measure $\nu$ on $[0, T]$ and an adapted process $Z$ such that $A=\int_{0}^{i} Z_{t} \nu(d t)$.

Here, $\dot{A}$ denotes the density of $A$ with respect to the associated total variation process $\operatorname{Var}(A)$. In the very recent paper $[7]^{2}$, this relation was also proved for continuous time models.
The approach of [7] relies on the approximation of American claims by Bermudan claims. Namely, they first prove that the result holds if we only impose $\widehat{V}_{t}-\widehat{C}_{t} \in \widehat{K}_{t}$ on a finite number of times $t \leq T$, and then pass to the limit. This result is very nice since it provides a direct and simple extension of [2]. However, their approximation requires some regularity and they have to impose a right-continuity condition on $\widehat{C}$. At first glance, this restriction does not seem important. However, it does not apply to admissible self-financing portfolios of the set $\widehat{\mathcal{V}}^{v}$, since they are only assumed to be làdlàg, except when $\Pi$ is continuous in which case the portfolios can be taken to be continuous, see the final discussion in [7].

## 2 A strong duality approach

In this paper, we use a completely different approach which relies on a direct application of duality results developped by [15], see its Theorem 27 Chapter V, and [1].
Given $\mathbb{Q} \sim \mathbb{P}$, we now denote by $\mathcal{S}^{1}(\mathbb{Q})$ the set of adapted làdlàg processes $\widehat{C}$ such that $\|\widehat{C}\|_{\mathcal{S}^{1}(\mathbb{Q})}:=\mathbb{E}^{\mathbb{Q}}\left[\|\widehat{C}\|_{*}\right]<\infty$ where $\|\widehat{C}\|_{*}:=\sup _{t \leq T}\left\|\widehat{C}_{t}\right\|$ and $\|\cdot\|$ denotes the Euclydean norm on $\mathbb{R}^{d}$. Given $Z \in \mathcal{Z}^{s}$, we also define the probability measure $\mathbb{Q}_{z}$ by $d \mathbb{Q}_{Z} / d \mathbb{P}:=\left(\sum_{i \leq d} Z_{T}^{i}\right) / c_{Z}$ where $c_{Z}:=\mathbb{E}\left[\sum_{i \leq d} Z_{T}^{i}\right]$. Note that $\operatorname{Int}\left(\widehat{K}^{*}\right) \subset(0, \infty)^{d}$ so that $\mathbb{Q}_{Z} \sim \mathbb{P}$. In the following, we shall also use the notation $\mathcal{S}^{\infty}$ to denote the set of optional làdlàg processes $\widehat{C}$ such that $\|\widehat{C}\|_{*}$ is essentially bounded.

Our main result relies on two key ingredients:
1- we first observe that the set $\widehat{\mathcal{C}}^{0} \cap \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ is closed in $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ for all $Z \in \mathcal{Z}^{s}$,
2- we then provide a representation of the dual of $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ in terms of random measures which can be interpreted in terms of randomized quasi stopping times.

The dual formulation is then obtained by applying an usual Hahn-Banach type argument.

### 2.1 Closure property

We start with the closure property. It can be compared to the Fatou closure property used in [7] and [3], among others. The main difference is that we consider a convergence in $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ for $Z \in \mathcal{Z}^{s}$.

Proposition 2.1. For all $Z \in \mathcal{Z}^{s}, \widehat{\mathcal{C}}^{0} \cap \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ is closed in $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$. Moreover, if $a>0$ and $\left(\widehat{C}^{n}\right)_{n \geq 1}$ is a sequence in $\widehat{\mathcal{C}}^{0}$ such that $\widehat{C}^{n} \succeq-a \mathbf{1}$ for all $n \geq 1$ and $\left\|\widehat{C}^{n}-\widehat{C}\right\|_{*} \rightarrow 0$ in probability for some làdlàg optional process $\widehat{C}$ with values in $\mathbb{R}^{d}$, then $\widehat{C} \in \widehat{\mathcal{C}}^{0}$.

The last assertion is an immediate consequence of Lemma 8, Lemma 12 and Proposition 14 of [3], see also the proof of their Theorem 14. The first one is proved similarly. The only difference is that their admissibility condition $\widehat{V} \in \widehat{\mathcal{V}}_{\mathcal{Z}^{\text {s }}}^{0}$ is replaced by the fact that we restrict to strategies such that $\widehat{V} \succeq \widehat{C}$ with $\widehat{C} \in \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$. We only explain the main arguments. We start with an easy Lemma which essentially follows from arguments used in the proof of Lemma 8 in [3].

Lemma 2.1. Fix $\widehat{C} \in \widehat{\mathcal{C}}^{0} \cap \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ for some $Z \in \mathcal{Z}^{s}$ and $\widehat{V} \in \widehat{\mathcal{V}}^{0}$ such that $\widehat{V} \succeq \widehat{C}$. Then, $Z \widehat{V}$ is a supermartingale. Moreover,

$$
\mathbb{E}\left[\int_{0}^{T} Z_{s} \dot{\widehat{V}}_{s}^{c} d \operatorname{Var}_{s}\left(\widehat{V}^{c}\right)+\sum_{s \leq T} Z_{s-} \Delta \widehat{V}_{s}+\sum_{s<T} Z_{s} \Delta^{+} \widehat{V}_{s}\right] \geq \mathbb{E}\left[Z_{T} \widehat{V}_{T}\right] .
$$

Proof. Since $Z_{t} \in \widehat{K}_{t}^{*}$ and $\widehat{V}_{t}-\widehat{C}_{t} \in \widehat{K}_{t}$ for all $t \leq T \mathbb{P}-$ a.s., it follows that $Z_{t} \widehat{V}_{t} \geq Z_{t} \widehat{C}_{t}$ for all $t \leq T \mathbb{P}-$ a.s. and therefore, by the martingale property of $Z$,

\begin{equation*}
Z_{t} \widehat{V}_{t} \geq \mathbb{E}\left[Z_{T} \widehat{C}_{t} \mid \mathcal{F}_{t}\right] \geq-\mathbb{E}\left[\left\|Z_{T}\right\| \sup _{s \in[0, T]}\left\|\widehat{C}_{s}\right\| \mid \mathcal{F}_{t}\right] \text { for all } t \leq T \mathbb{P}-\text { a.s. } \tag{2.1}
\end{equation*}
$$

Since $\widehat{C} \in \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$, the right-hand side term is a martingale. Moreover, a direct application of the integration by parts formula yields

$$
Z_{t} \widehat{V}_{t}=\int_{0}^{t} \widehat{V}_{s} d Z_{s}+\int_{0}^{t} Z_{s} \widehat{V}_{s}^{c} d \operatorname{Var}_{s}\left(\widehat{V}^{c}\right)+\sum_{s \leq t} Z_{s-} \Delta \widehat{V}_{s}+\sum_{s<t} Z_{s} \Delta^{+} \widehat{V}_{s} .
$$

We now observe that the definitions of $\mathcal{Z}^{s}$ and $\widehat{\mathcal{V}}^{0}$ imply that the three last integrals on the right-hand side are equal to non-increasing processes. In view of (2.1), this implies that the local martingale $\left(\int_{0}^{t} \widehat{V}_{s} d Z_{s}\right)_{t \leq T}$ is bounded from below by a martingale and is therefore a super-martingale. Similarly, $Z \widehat{V}$ is a local super-martingale which is bounded from below by a martingale and is therefore a super-martingale. The proof is concluded by taking the expectation in both sides of the previous inequality applied to $t=T$.

Proof of Proposition 2.1. As already mentioned, the last assertion is an immediate consequence of Lemma 8, Lemma 12 and Proposition 14 of [3], see also the proof of their Theorem 15 . We now prove the first one which is obtained by very similar arguments. Let $\left(\widehat{C}^{n}\right)_{n}$ be a sequence in $\widehat{\mathcal{C}}^{0} \cap \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ that converges to some $\widehat{C}$ in $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$. After possibly passing to a subsequence, we may assume that the convergence holds a.s. uniformly in $t \leq T$. Let $\left(\widehat{V}^{n}\right)_{n}$ be a sequence in $\widehat{\mathcal{V}}^{0}$ such that $\widehat{V}^{n} \succeq \widehat{C}^{n}$ for all $n \geq 1$. It follows from the same arguments as in the proof of Lemma 12 in [3] that there is $\tilde{\mathbb{Q}}_{Z} \sim \mathbb{P}$, which depends only on $Z$, such that

& \mathbb{E}\left[-\int_{0}^{T} Z_{s} \widehat{V}_{s}^{n c} d \operatorname{Var}_{s}\left(\widehat{V}^{n c}\right)-\sum_{s \leq T} Z_{s-} \Delta \widehat{V}_{s}^{n}-\sum_{s<T} Z_{s} \Delta^{+} \widehat{V}_{s}^{n}\right] \\
& \geq \mathbb{E}^{\tilde{\mathbb{Q}}_{Z}}\left[\operatorname{Var}_{T}\left(\widehat{V}^{n}\right)\right] .
\end{aligned}
$$

In view of Lemma 2.1, this implies that $\mathbb{E}^{\tilde{\mathbb{Q}}_{Z}}\left[\operatorname{Var}_{T}\left(\widehat{V}^{n}\right)\right] \leq-\mathbb{E}\left[Z_{T} \widehat{V}_{T}^{n}\right]$ for all $n \geq 1$. We now observe that $\widehat{V}_{T}^{n}-\widehat{C}_{T} \in \widehat{K}_{T} \mathbb{P}-$ a.s. implies that

$$
-\mathbb{E}\left[Z_{T} \widehat{V}_{T}^{n}\right] \leq-\mathbb{E}\left[Z_{T} \widehat{C}_{T}^{n}\right] \leq c_{Z} \mathbb{E}^{\mathbb{Q}_{z}}\left[\left\|\widehat{C}_{T}^{n}\right\|\right]
$$

Since $\widehat{C}_{T}^{n}$ converges to $\widehat{C}_{T}$ in $L^{1}\left(\mathbb{Q}_{Z}\right)$, the right-hand side of the latter inequality is uniformly bounded and so is the quantity $\mathbb{E}^{\tilde{\mathbb{Q}}_{Z}}\left[\operatorname{Var}_{T}\left(\widehat{V}^{n}\right)\right]$. It thus follows from Proposition 14 in [3] that, after possibly passing to convex combinations, we can assume that, $\mathbb{P}-$ a.s., $\left(\widehat{V}^{n}\right)_{n}$ converges pointwise on $[0, T]$ to a predictable process $\widehat{V}$ with finite variations. The pointwise convergence ensures that $\widehat{V} \succeq \widehat{C}$. By Proposition 1.1, $\widehat{V}^{n}$ satisfies (1.1) for all $n \geq 1$, and it follows from the pointwise convergence that $\widehat{V}$ satisfies (1.1) too. We can then conclude from Proposition 1.1 that $\widehat{V} \in \widehat{\mathcal{V}}^{0}$.

### 2.2 Representation of continuous linear forms on $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$

Following the approach of [15], [1] and [8], we now characterize the dual of $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ in terms of random measures.

For this purpose, we introduce the set $\mathcal{R}$ of $\mathbb{R}^{3 d}$-valued adapted càdlàg processes $A:=\left(A^{-}, A^{o}, A^{+}\right)$with $\mathbb{P}$-integrable total variation such that
(i) $A^{-}$is predictable,
(ii) $A^{+}$and $A^{-}$are pure jump processes,
(iii) $A_{0}^{-}=0$ and $A_{T}^{+}=A_{T-}^{+}$.

Theorem 2.1. Fix $Z \in \mathcal{Z}^{s}$ and let $\mu$ be a continuous linear form on $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$. Then, there exists $A:=\left(A^{-}, A^{o}, A^{+}\right) \in \mathcal{R}$ such that:

$$
\mu(\widehat{C})=\mathbb{E}\left[\int_{0}^{T} \widehat{C}_{t-} d A_{t}^{-}+\int_{0}^{T} \widehat{C}_{t} d A_{t}^{o}+\int_{0}^{T} \widehat{C}_{t+} d A_{t}^{+}\right], \quad \text { for all } \widehat{C} \in \mathcal{S}^{\infty}
$$

The proof of this result was provided in [15] and [1] for optional càdlàg processes. A similar result for predictable làdcàd processes can also be found in [15], see Chapter V. A one dimensional version of Theorem 2.1 is given in [8]. We provide a complete proof in the Appendix for seek of completeness.

In the case, where $\mu(\xi) \leq 0$ for all essentially bounded optional làdlàg process $\xi$ such that $-\xi \succeq 0$, the associated elements $A \in \mathcal{R}$ can be further characterized in terms of the polar cone process $\widehat{K}^{*}$. In the one dimensional setting, it should be interpreted as follows: if $\mu(\xi) \leq 0$ for all non-positive essentially bounded optional làdlàg process $\xi$, then each component of $A$ is non-decreasing. This result will be of important use in the proof of our main result, Theorem 2.2 below.

Lemma 2.2. Let $A=\left(A^{-}, A^{o}, A^{+}\right)$be an element of $\mathcal{R}$ such that

$$
\begin{equation*}
\mathbb{E}\left[\int_{0}^{T} \xi_{t-} d A_{t}^{-}+\int_{0}^{T} \xi_{t} d A_{t}^{o}+\int_{0}^{T} \xi_{t+} d A_{t}^{+}\right] \leq 0 \tag{2.2}
\end{equation*}
$$

for all process $\xi$ in $\mathcal{S}^{\infty}$ such that $-\xi \succeq 0$. Then,
(i) $\dot{A}^{-} \in \widehat{K}_{-}^{*} d \operatorname{Var}\left(A^{-}\right)$a.e. $\mathbb{P}-$ a.s.
(ii) $\dot{A^{\circ c}} \in \widehat{K}^{*} d \operatorname{Var}\left(A^{\circ c}\right)$ a.e. $\mathbb{P}-$ a.s. and $\dot{A^{\circ \delta}} \in \widehat{K}^{*} d \operatorname{Var}\left(A^{\circ \delta}\right)$ a.e. $\mathbb{P}-$ a.s.
(iii) $\dot{A^{+}} \in \widehat{K}^{*} d \operatorname{Var}\left(A^{+}\right)$a.e. $\mathbb{P}-$ a.s.
where $A^{\circ c}$ and $A^{\circ \delta}$ denote the continuous and the purely discontinuous parts of $A^{\circ}$. We denote by $\mathcal{R}_{\widehat{K}}$ the set of processes in $\mathcal{R}$ satisfying (i)-(ii)-(iii) above.

Proof. Let $\xi$ be any bounded optional làdlàg process such that $-\xi \succeq 0$. Given $B \in \mathcal{F}$, let $\lambda$ be the optional projection of $\mathbf{1}_{B}$. Note that it is càdlàg, since $\mathbf{1}_{B}(\omega)$ is constant for each $\omega$, and that the process $\lambda_{-}$coincides with the predictable projection of $\mathbf{1}_{B}$, see Chapter V in [6]. We then set $\tilde{\xi}:=\lambda \xi$. We remark that $\tilde{\xi}$ is the optional projection of $\mathbf{1}_{B} \xi$, since $\xi$ is optional, and that $\tilde{\xi}_{-}$is the predictable projection of $\mathbf{1}_{B} \xi_{-}$, since $\xi_{-}$is predictable. Since the set valued process $\widehat{K}$ is a cone and $\lambda$ takes values in $[0,1]$, we have $-\tilde{\xi} \succeq 0$. Moreover, since $A^{-}$is predictable (resp. $A^{o}, A^{+}$are optional), it follows that the induced measure commutes with the predictable projection (resp. the optional projection), see e.g. Theorem 3 Chapter I in [15]. Applying (2.2) to $\tilde{\xi}$ thus implies that

$$
\begin{aligned}
0 & \geq \mathbb{E}\left[\int_{0}^{T} \lambda_{t-} \xi_{t-} d A_{t}^{-}+\int_{0}^{T} \lambda_{t} \xi_{t} d A_{t}^{o}+\int_{0}^{T} \lambda_{t} \xi_{t+} d A_{t}^{+}\right] \\
& =\mathbb{E}\left[\mathbf{1}_{B}\left(\int_{0}^{T} \xi_{t-} d A_{t}^{-}+\int_{0}^{T} \xi_{t} d A_{t}^{o}+\int_{0}^{T} \xi_{t+} d A_{t}^{+}\right)\right] .
\end{aligned}
$$

By arbitrariness of $B$, this shows that the càdlàg process $X$ defined by

$$
X:=\int_{0}^{\cdot} \xi_{t-} d A_{t}^{-}+\int_{0}^{.} \xi_{t} d A_{t}^{o}+\int_{0}^{.} \xi_{t+} d A_{t}^{+}
$$

satisfies $X_{T} \leq 0 \mathbb{P}$ - a.s. Moreover, replacing $\xi$ by $\xi \mathbf{1}_{(s+\varepsilon, t+\varepsilon \wedge T]}$ for $s<t \leq T, \varepsilon>0$, and sending $\varepsilon \rightarrow 0$ shows that $X$ is non-decreasing (recall (iii) of the definition of $\mathcal{R}$ ). In particular, its continuous part in non-decreasing, see e.g. Chapter VII in [14]. Since $A^{-}$and $A^{+}$are purely discontinuous, this implies that the continuous part of $\int_{0}^{\dot{*}} \xi_{t} d A_{t}^{o}$ is non-decreasing. Letting $A^{o c}$ denote the continuous part of $A^{o}$, we thus deduce that

$$
\begin{equation*}
\xi \dot{A^{\circ c}} \leq 0 d \operatorname{Var}\left(A^{\circ c}\right) \text { a.e } \mathbb{P}-\text { a.s. } \tag{2.3}
\end{equation*}
$$

We now replace $\xi$ by $\tilde{\xi}:=\xi \mathbf{1}_{\left(\tau, \tau_{h}\right)}$ where $\tau$ is some stopping time with values in $[0, T)$ and $\tau_{h}:=(\tau+h) \wedge T$ for some $h>0$. The same argument as above shows that

$$
\int_{\tau+}^{\tau_{h}} \xi_{t-} d A_{t}^{-}+\int_{\tau+}^{\tau_{h}-} \xi_{t} d A_{t}^{o}+\int_{\tau}^{\tau_{h}-} \xi_{t+} d A_{t}^{+} \leq 0 \mathbb{P}-\text { a.s. }
$$

For $h \rightarrow 0$, this leads to

$$
\begin{equation*}
\xi_{\tau+} \Delta A_{\tau}^{+} \leq 0 \quad \mathbb{P}-\text { a.s. } \tag{2.4}
\end{equation*}
$$

for all stopping time $\tau$ with values in $[0, T)$. Arguing as above with $\xi$ replaced by $\tilde{\xi}:=\xi \mathbf{1}_{\left(\tau_{n}, \tau\right)}$ where $\tau$ is a predictable stopping time with values in $(0, T]$ and $\left(\tau_{n}\right)_{n}$ is an announcing sequence for $\tau$, leads to

$$
\begin{equation*}
\xi_{\tau-} \Delta A_{\tau}^{-} \leq 0 \quad \mathbb{P}-\mathrm{a.s.} \tag{2.5}
\end{equation*}
$$

Finally, we replace $\xi$ by $\tilde{\xi}:=\xi \mathbf{1}_{\{\tau\}}$ to obtain

$$
\begin{equation*}
\xi_{\tau} \Delta A_{\tau}^{\circ} \leq 0 \quad \mathbb{P}-\text { a.s. } \tag{2.6}
\end{equation*}
$$

for all stopping time $\tau$ with values in $[0, T]$. Since the cone valued process $\widehat{K}$ is generated by a family of càdlàg adapted processes, which we can always assume to be bounded, (2.3), (2.4), (2.5), (2.6) and (iii) of the definition of $\mathcal{R}$ imply the required result.

### 2.3 The super-hedging theorem

In this section, we show that a dual formulation for the set $\widehat{\mathcal{C}^{0}}$ can be deduced from the closure property stated in Proposition 2.1 and the representation of the dual of $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ derived in Theorem 2.1. To this purpose we need to introduce a suitable subset of $\mathcal{R}_{\widehat{K}}$.
Given $A:=\left(A^{-}, A^{o}, A^{+}\right) \in \mathcal{R}_{\widehat{K}}$, we now define
$\delta A_{t}^{-}:=A_{T}^{-}-A_{t}^{-}+A_{T}^{o}-A_{t-}^{o}+A_{T}^{+}-A_{t-}^{+}, \delta A_{t}^{+}:=A_{T}^{-}-A_{t}^{-}+A_{T}^{o}-A_{t}^{o}+A_{T}^{+}-A_{t-}^{+}$
and denote by $\bar{A}^{-}$(resp. $\bar{A}^{+}$) the predictable projection (resp. optional) of $\left(\delta A_{t}^{-}\right)_{t \leq T}$ (resp. $\left.\left(\delta A_{t}^{+}\right)_{t \leq T}\right)$. Note that, since $\widehat{K}^{*} \subset \mathbb{R}_{+}^{d}$, the former processes have non-negative components so that their projections are well defined.

Definition 2.1. We say that $A:=\left(A^{-}, A^{o}, A^{+}\right) \in \mathcal{R}_{\widehat{K}}$ belongs to $\mathcal{D}$ if
(i) $\bar{A}_{\tau}^{-} \in \widehat{K}_{\tau-}^{*} \mathbb{P}-$ a.s. for all predictable stopping time $\tau \leq T$,
(ii) $\bar{A}_{\tau}^{+} \in \widehat{K}_{\tau}^{*} \mathbb{P}-$ a.s. for all stopping time $\tau \leq T$.

We can now state our main result. Since $\widehat{\mathcal{V}}^{v}=v+\widehat{\mathcal{V}}^{0}$ and therefore $\widehat{\mathcal{C}}^{v}=v+\widehat{\mathcal{C}}^{0}$, we only consider the case $\widehat{C} \in \widehat{\mathcal{C}^{0}}$.

Theorem 2.2. Let $\widehat{C}$ be a làdlàg optional process such that $\widehat{C} \succeq-a \mathbf{1}$ for some $a>0$. Then, $\widehat{C} \in \widehat{\mathcal{C}}^{0}$ if and only if

$$
\begin{equation*}
\mathbb{E}\left[\int_{0}^{T} \widehat{C}_{t-} d A_{t}^{-}+\int_{0}^{T} \widehat{C}_{t} d A_{t}^{o}+\int_{0}^{T} \widehat{C}_{t+} d A_{t}^{+}\right] \leq 0 \quad \forall\left(A^{-}, A^{o}, A^{+}\right) \in \mathcal{D} \tag{2.7}
\end{equation*}
$$

Proof. We fix a làdlàg optional process $\widehat{C}$ such that $\widehat{C} \succeq-a \mathbf{1}$, for some $a>0$.
Step 1. We first show that $C \in \widehat{\mathcal{C}}^{0}$ implies (2.7). Let $\widehat{V} \in \widehat{\mathcal{V}}^{0}$ be such that $\widehat{V} \succeq \widehat{C}$.
Then, by definition of $A=\left(A^{-}, A^{o}, A^{+}\right) \in \mathcal{D} \subset \mathcal{R}_{\widehat{K}}$

$$
\int_{0}^{T}\left(\widehat{C}_{t-}-\widehat{V}_{t-}\right) d A_{t}^{-}+\int_{0}^{T}\left(\widehat{C}_{t}-\widehat{V}_{t}\right) d A_{t}^{o}+\int_{0}^{T}\left(\widehat{C}_{t+}-\widehat{V}_{t+}\right) d A_{t}^{+} \leq 0 \quad \mathbb{P}-\text { a.s. }
$$

Thus, it suffices to show that (2.7) holds for $\hat{V}$ in place of $\widehat{C}$.
1.a. We first assume that $\widehat{V}$ has an essentially bounded total variation. By Fubini's theorem and the continuity of $\widehat{V}^{c}$,

$$
\begin{aligned}
\int_{0}^{T} \widehat{V}_{t-} d A_{t}^{-} & =\int_{0}^{T}\left(\int_{0}^{t} d \widehat{V}_{s}^{c}+\sum_{s<t}\left(\Delta \widehat{V}_{s}+\Delta^{+} \widehat{V}_{s}\right)\right) d A_{t}^{-} \\
& =\int_{0}^{T}\left(A_{T}^{-}-A_{t}^{-}\right) d \widehat{V}_{t}^{c}+\sum_{t<T}\left(A_{T}^{-}-A_{t}^{-}\right)\left(\Delta \widehat{V}_{t}+\Delta^{+} \widehat{V}_{t}\right)
\end{aligned}
$$

Similarly,

$$
\int_{0}^{T} \widehat{V}_{t} d A_{t}^{o}=\int_{0}^{T}\left(A_{T}^{o}-A_{t}^{o}\right) d \widehat{V}_{t}^{c}+\sum_{t \leq T}\left(A_{T}^{o}-A_{t-}^{o}\right) \Delta \widehat{V}_{t}+\sum_{t<T}\left(A_{T}^{o}-A_{t}^{o}\right) \Delta^{+} \widehat{V}_{t}
$$

and

$$
\int_{0}^{T} \widehat{V}_{t+} d A_{t}^{+}=\int_{0}^{T}\left(A_{T}^{+}-A_{t-}^{+}\right) d \widehat{V}_{t}^{c}+\sum_{t \leq T}\left(A_{T}^{+}-A_{t-}^{+}\right)\left(\Delta \widehat{V}_{t}+\Delta^{+} \widehat{V}_{t}\right)
$$

This shows hat

$$
\begin{aligned}
& \mathbb{E}\left[\int_{0}^{T} \widehat{V}_{t-} d A_{t}^{-}+\int_{0}^{T} \widehat{V}_{t} d A_{t}^{o}+\int_{0}^{T} \widehat{V}_{t+} d A_{t}^{+}\right] \\
& =\mathbb{E}\left[\sum_{t \leq T} \delta A_{t}^{-} \Delta \widehat{V}_{t}+\int_{0}^{T} \delta A_{t}^{+} d \widehat{V}_{t}^{c}+\sum_{t<T} \delta A_{t}^{+} \Delta^{+} \widehat{V}_{t}\right] \\
& =\mathbb{E}\left[\sum_{t \leq T} \bar{A}_{t}^{-} \Delta \widehat{V}_{t}+\int_{0}^{T} \bar{A}_{t}^{+} d \widehat{V}_{t}^{c}+\sum_{t<T} \bar{A}_{t}^{+} \Delta^{+} \widehat{V}_{t}\right]
\end{aligned}
$$

and the required result follows from the definitions of $\mathcal{D}$ and $\widehat{\mathcal{V}}^{0}$.
1.b. We now consider the case where the total variation of $\widehat{V}$ is not essentially bounded. Recall that $\widehat{V} \succeq \widehat{C} \succeq-a \mathbf{1}$. We can then approximate $\widehat{V}$ from below (in the sense of $\succeq$ ) by the sequence $\left(\widehat{V}^{n}\right)_{n}$ defined by $\widehat{V}^{n}=\widehat{V} \mathbb{1}_{\left[0, \tau_{n}\right]}-a \mathbf{1} \mathbb{1}_{\left(\tau_{n}, T\right]}$ where $\tau_{n}$ is a localizing sequence of stopping times for $\operatorname{Var}(\widehat{V})$, so that $\tau_{n} \rightarrow \infty$. It follows from the previous step that

$$
\mathbb{E}\left[\int_{0}^{T} \widehat{V}_{t-}^{n} d A_{t}^{-}+\int_{0}^{T} \widehat{V}_{t}^{n} d A_{t}^{o}+\int_{0}^{T} \widehat{V}_{t+}^{n} d A_{t}^{+}\right] \leq 0
$$

Since $\widehat{V}^{n} \succeq-a \mathbf{1}$ for all $n \geq 1$ and $\mathcal{D} \subset \mathcal{R}_{\widehat{K}}$, each integral in the expectation is bounded from below, uniformly in $n$, by an integrable random variable which depends only on $A$ and $a$. Since $\widehat{V}^{n} \rightarrow \widehat{V}$ uniformly on compact sets, $\mathbb{P}-$ a.s., we conclude by appealing to Fatou's Lemma.
Step 2. We now prove that (2.7) implies $\widehat{C} \in \widehat{\mathcal{C}}^{0}$.
2.a. We first consider the case where $\widehat{C} \in \mathcal{S}^{\infty}$. Assume that $\widehat{C}$ does not belong to the convex cone $\widehat{\mathcal{C}^{0}}$. Fix $Z \in \mathcal{Z}^{s}$ and observe that $\widehat{C} \notin \widehat{\mathcal{C}}^{0} \cap \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$. The latter being closed in $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$, see Proposition 2.1, it follows from the Hahn-Banach separation theorem that we can find $\mu$ in the dual of $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ such that $\mu(X) \leq c<\mu(C)$ for all $X \in \widehat{\mathcal{C}^{0}} \cap \mathcal{S}^{\infty}$, for some real $c$. Since $\widehat{\mathcal{C}^{0}}$ is a cone, it is clear that $c=0$. Thus,

$$
\begin{equation*}
\sup _{X \in \widehat{\mathcal{C}} \cap \mathcal{S}^{\infty}} \mu(X) \leq 0<\mu(C) . \tag{2.8}
\end{equation*}
$$

Moreover, by Theorem 2.1, there is a process $A:=\left(A^{-}, A^{o}, A^{+}\right) \in \mathcal{R}$ such that

$$
\begin{equation*}
\mu(X)=\mathbb{E}\left[\int_{0}^{T} X_{t-} d A_{t}^{-}+\int_{0}^{T} X_{t} d A_{t}^{o}+\int_{0}^{T} X_{t+} d A_{t}^{+}\right] \quad \text { for all } X \in \mathcal{S}^{\infty} \tag{2.9}
\end{equation*}
$$

Since $\widehat{C} \in \mathcal{S}^{\infty}$, it thus suffices to show that $A \in \mathcal{D}$ to obtain a contradiction to (2.7). We first note that Lemma 2.2 implies that $A \in \mathcal{R}_{\widehat{K}}$ since $X=-\xi$ belongs to $\widehat{\mathcal{C}}^{0} \cap \mathcal{S}^{\infty}$ for all bounded optional làdlàg process $\xi$ satisfying $\xi \succeq 0$. It remains to prove the condition (i)-(ii) of the definition of $\mathcal{D}$. Using the same integration by parts argument as in step 1. above, we deduce from (2.8) that:

$$
\mathbb{E}\left[\sum_{t \leq T} \bar{A}_{t}^{-} \Delta \widehat{V}_{t}+\int_{0}^{T} \bar{A}_{t}^{+} d \widehat{V}_{t}^{c}+\sum_{t<T} \bar{A}_{t}^{+} \Delta^{+} \widehat{V}_{t}\right] \leq 0
$$

for all $\widehat{V} \in \widehat{\mathcal{V}}^{0} \cap \mathcal{S}^{\infty}$ with essentially bounded total variation. It thus follows from Definition 1.1 that $\mathbb{E}\left[\bar{A}_{\tau}^{-} \xi\right] \leq 0$ for all predicable stopping time $\tau \leq T \mathbb{P}-$ a.s. and bounded $\mathcal{F}_{\tau-}$-measurable $\xi$ taking values in $-\widehat{K}_{\tau-} \mathbb{P}-$ a.s. Similarly, $\mathbb{E}\left[\bar{A}_{\tau}^{+} \xi\right] \leq 0$ for all stopping time $\tau<T \mathbb{P}-$ a.s. and bounded $\mathcal{F}_{\tau}$-measurable $\xi$ taking values in $-\widehat{K}_{\tau} \mathbb{P}-$ a.s. Observe that $\bar{A}_{T}^{+}=0 \in \widehat{K}_{T}^{*}$ since $\Delta A_{T}^{+}=0$. Recalling the definition of
$\widehat{K}$ in terms of its generating family based on $\Pi$, this implies (i)-(ii) of the definition of $\mathcal{D}$.
2.b. We conclude the proof by considering the case where $\widehat{C}$ is not bounded but satisfies $\widehat{C} \succeq-a \mathbf{1}$ for some $a>0$. Define the bounded process $\widehat{C}^{n}:=\widehat{C} \mathbb{1}_{\{| | \widehat{C} \| \leq n\}}-$ $a \mathbf{1} \mathbb{1}_{\{| | \widehat{C} \|>n\}}$ for $n \geq 1$. Observing that $\widehat{C} \succeq \widehat{C}^{n}$ for all $n \geq 1$ and recalling that $\widehat{C}$ satisfies (2.7), we deduce from the definition of $\mathcal{D} \subset \mathcal{R}_{\widehat{K}}$ that

$$
\mathbb{E}\left[\int_{0}^{T} \widehat{C}_{t-}^{n} d A_{t}^{-}+\int_{0}^{T} \widehat{C}_{t}^{n} d A_{t}^{o}+\int_{0}^{T} \widehat{C}_{t+}^{n} d A_{t}^{+}\right] \leq 0
$$

for all $A=\left(A^{-}, A^{o}, A^{+}\right) \in \mathcal{D}$ and $n \geq 1$. It follows from 2.a that $\widehat{C}^{n} \in \widehat{\mathcal{C}}^{0}$ for all $n \geq 1$. Since $\widehat{C}^{n} \succeq-a \mathbf{1}$ for all $n \geq 1$ and $\left\|\widehat{C}^{n}-\widehat{C}\right\|_{*} \rightarrow 0 \mathbb{P}-$ a.s., it follows from Proposition 2.1 that $\widehat{C} \in \widehat{\mathcal{C}}^{0}$ too.

## 3 Comments and additional properties

In this section, we discuss additional properties of the set of dual variables $\mathcal{D}$ and provide an alternative to the dual formulation of Theorem 2.2 in the spirit of the one proposed by [7] for càdlàg processes. We also discuss the links between (2.7) and the well-known dual formulation in terms of optimal stopping in frictionless markets.

### 3.1 Reformulation of the duality result

We first provide an alternative formulation for $\mathcal{D}$. To this purpose, we need to introduce additional notations.

Let $\mathcal{N}$ denote the set of triplets of non-negative random measures $\nu:=\left(\nu^{-}, \nu^{\circ}, \nu^{+}\right)$ such that $\nu^{-}$is predictable, $\nu^{\circ}$ and $\nu^{+}$are optional, and $\left(\nu^{-}+\nu^{\circ}+\nu^{+}\right)([0, T])=1$ $\mathbb{P}-$ a.s.

Given $\nu \in \mathcal{N}$, we define $\tilde{Z}(\nu)$ as the set of $\mathbb{R}^{3 d}$-valued processes $Z:=\left(Z^{-}, Z^{\circ}, Z^{+}\right)$ such that:
(i) $Z^{i}$ is $\nu^{i}(d t, \omega) d \mathbb{P}(\omega)$ integrable for $i \in\{-, \circ,+\}, Z^{-}$is predictable and $Z^{\circ}, Z^{+}$ are optional.
(ii) $A=\left(A^{-}, A^{o}, A^{+}\right)$defined by $A_{-}^{i}=\int_{0}^{i} Z_{t}^{i} \nu^{i}(d t)$ for $i \in\{-, o,+\}$ belongs to $\mathcal{D}$.

Proposition 3.1. Let $A=\left(A^{-}, A^{o}, A^{+}\right)$be a $\mathbb{R}^{3 d}$-valued process with integrable total variation. Then, $A \in \mathcal{D}$ if and only if there exists $\nu:=\left(\nu^{-}, \nu^{\circ}, \nu^{+}\right) \in \mathcal{N}$ and $Z:=\left(Z^{-}, Z^{\circ}, Z^{+}\right) \in \tilde{Z}(\nu)$ such that

$$
\begin{equation*}
A_{\cdot}^{i}=\int_{0} Z_{t}^{i} \nu^{i}(d t), i \in\{-, o,+\} \tag{3.1}
\end{equation*}
$$

Proof. It is clear that given $\left(\nu^{-}, \nu^{\circ}, \nu^{+}\right) \in \mathcal{N}$ and $\left(Z^{-}, Z^{\circ}, Z^{+}\right) \in \tilde{Z}(\nu)$, the process defined in (3.1) belong to $\mathcal{D}$. We now prove the converse assertion.

1. We first observe that, given $A=\left(A^{-}, A^{\circ}, A^{+}\right) \in \mathcal{R}$, we can find a $\mathbb{R}^{3 d}$-adapted process $Z:=\left(Z^{-}, Z^{\circ}, Z^{+}\right)$and a triplet of real positive random measures $\nu:=$ $\left(\nu^{-}, \nu^{\circ}, \nu^{+}\right)$on $[0, T]$ such that $Z^{-}$and $\nu^{-}$are predictable, $\left(Z^{\circ}, Z^{+}\right)$and $\left(\nu^{\circ}, \nu^{+}\right)$ are optional, and $A^{i}=\int_{0}^{\cdot} Z_{t}^{i} \nu^{i}(d t)$ for $i \in\{-, \circ,+\}$.
2. We can then always assume that $\bar{\nu}:=\nu^{-}+\nu^{\circ}+\nu^{+}$satisfies $\bar{\nu}([0, T]) \leq 1 \mathbb{P}-$ a.s. Indeed, let $f$ be some strictly increasing function mapping $[0, \infty)$ into $[0,1 / 3)$. Then, for $i \in\{-, \circ,+\}, \nu^{i}$ is absolutely continuous with respect to $\tilde{\nu}^{i}:=f\left(\nu^{i}\right)$ and thus admits a density. Replacing $\nu^{i}$ by $\tilde{\nu}^{i}$ and multiplying $Z^{i}$ by the optional (resp. predictable) projection of the associated density leads to the required representation for $i \in\{o,+\}$ (resp. $i=-$ ).
3. Finally, we can reduce to the case where $\bar{\nu}([0, T])=1 \mathbb{P}-$ a.s. Indeed, since $\nu^{-}$ is only supported by graphs of $[0, T]$-valued random variables (recall that $A^{-}$is a pure jump process), we know that it has no continuous part at $\{T\}$. We can thus replace $\nu^{-}$by $\tilde{\nu}^{-}:=\nu^{-}+\delta_{\{T\}}(1-\bar{\nu}([0, T]))$ where $\delta_{\{T\}}$ denotes the Dirac mass at $T$. We then also replace $Z^{-}$by

$$
\tilde{Z}^{-}:=Z^{-}\left[\mathbf{1}_{\{t<T\}}+\mathbf{1}_{\{t=T\}} \mathbf{1}_{\{\bar{\nu}([0, T])<1\}} \nu^{-}(\{T\})\left(\nu^{-}(\{T\})+1-\bar{\nu}([0, T])\right)^{-1}\right]
$$

so that $A^{-}=\int_{0} \tilde{Z}_{t}^{-} \tilde{\nu}^{-}(d t)$. Observe that the assumption $\mathcal{F}_{T-}=\mathcal{F}_{T}$ ensures that $\tilde{\nu}^{-}$and $\tilde{Z}^{-}$are still predictable.

Remark 3.1. It follows from the above arguments that the representation given in Theorem 2.1 can be alternatively written

$$
\mu(\widehat{C})=\mathbb{E}\left[\int_{0}^{T} \widehat{C}_{t-} Z_{t}^{-} \nu^{-}(d t)+\int_{0}^{T} \widehat{C}_{t} Z_{t}^{\circ} \nu^{\circ}(d t)+\int_{0}^{T} \widehat{C}_{t+} Z_{t}^{+} \nu^{+}(d t)\right]
$$

for some $\left(\nu^{-}, \nu^{\circ}, \nu^{+}\right) \in \mathcal{N}$ and some $\mathbb{R}^{3 d}$-valued processes $Z:=\left(Z^{-}, Z^{\circ}, Z^{+}\right)$which satisfies the assertion (i) of the definition of $\tilde{Z}(\nu)$.

In view of Proposition 3.1, the dual formulation of Theorem 2.2 can be written as follows.

Corollary 3.1. Let $\widehat{C}$ be a làdlàg optional process such that $\widehat{C} \succeq-a \mathbf{1}$ for some $a>0$. Then, $\widehat{C} \in \widehat{\mathcal{C}}^{0}$ if and only if

$$
\begin{equation*}
\mathbb{E}\left[\int_{0}^{T} \widehat{C}_{t-} Z_{t}^{-} \nu^{-}(d t)+\int_{0}^{T} \widehat{C}_{t} Z_{t}^{\circ} \nu^{\circ}(d t)+\int_{0}^{T} \widehat{C}_{t+} Z_{t}^{+} \nu^{+}(d t)\right] \leq 0 \tag{3.2}
\end{equation*}
$$

for all $\nu \in \mathcal{N}$ and $Z \in \tilde{Z}(\nu)$.
This formulation is very close to the formulation (1.2) of [7] up to two differences. Only the measure $\nu^{\circ}$ appears in their formulation and in their case it is determistic.

In this sense our result is less tractable. However, as already mentioned, their approach requires to impose a right-continuity assumption on $\widehat{C}$, while ours allows to consider general làdlàg processes.

### 3.2 Comparison with frictionless markets

Let us first recall that the frictionless markets case corresponds to the situation where $\pi^{i j}=1 / \pi^{j i}$ for all $i, j \leq d$. In this case, the price process (in terms of the first asset) is $S^{i}:=\pi^{1 i}$ and is a càdlàg semimartingale, see [5]. In order to avoid technicalities, it is usually assumed to be locally bounded. The no-arbitrage condition, more precisely no free lunch with vanishing risk, implies that the set $\mathcal{M}$ of equivalent measures $\mathbb{Q}$ under which $S=\left(S^{i}\right)_{i \leq d}$ is a local martingale is nonempty. Such measures should be compared to the strictly consistent price processes $Z$ of $\mathcal{Z}^{s}$. Indeed, if $H$ denotes the density process associated to $\mathbb{Q}$, then $H S$ is "essentially" an element of $\mathcal{Z}^{s}$, and conversely, up to an obvious normalization. The term "essentially" is used here because in this case the interior of $\widehat{K}^{*}$ is empty and the notion of interior as to be replaced by that of relative interior.

In such models, the wealth process is a real valued process which describes the value (in terms of the first asset) of the portfolio. It corresponds to $V=S \widehat{V}$. The main difference is that the set of admissible strategies is no more described by $\widehat{\mathcal{V}}^{0}$ but in terms of stochastic integrals with respect to $S$.
In the case where $\mathcal{M}=\{\mathbb{Q}\}$, the so-called complete market case, the super-hedging price of an American claim $\widehat{C}$, such that $C:=S \widehat{C}$ is bounded from below, coincides with the value at time 0 of the Snell envelope of $C$ computed under $\mathbb{Q}$, see e.g. [13] and the references therein. Equivalently, the American claim $\widehat{C}$ can be super-hedged from a zero initial endowment if and only if the $\mathbb{Q}$-Snell envelope of $C$ at time 0 is non-positive.
In the case where $C$ is làdlàg and of class (D), the $\mathbb{Q}$-Snell envelope $J^{\mathbb{Q}}$ of $C$ satisfies, see [8] and [9],

$$
\begin{equation*}
J_{0}^{\mathbb{Q}}=\sup _{\tau \in \mathcal{T}} \mathbb{E}^{\mathbb{Q}}\left[C_{\tau}\right]=\sup _{\left(\tau^{-}, \tau^{o}, \tau^{+}\right) \in \tilde{\mathcal{T}}} \mathbb{E}^{\mathbb{Q}}\left[C_{\tau^{-}-}+C_{\tau^{o}}+C_{\tau^{+}+}\right] \tag{3.3}
\end{equation*}
$$

where $\mathcal{T}$ is the set of all $[0, T]$-valued stopping times, $\tilde{\mathcal{T}}$ is the set of triplets of $[0, T] \cup\{\infty\}$-valued stopping times $\left(\tau^{-}, \tau^{o}, \tau^{+}\right)$such that $\tau^{-}$is predictable and, a.s., only one of them is finite. Here, we use the convention $C_{\infty-}=C_{\infty}=C_{\infty+}=0$. The first formulation is simple but does not allow to provide an existence result, while the second does. Indeed, it is shown in [9] that

$$
J_{0}^{\mathbb{Q}}=\mathbb{E}^{\mathbb{Q}}\left[C_{\hat{\tau}-} \mathbb{1}_{A^{-}}+C_{\hat{\tau}} \mathbb{1}_{A^{o}}+C_{\hat{\tau}+} \mathbb{1}_{A^{+}}\right]
$$

where

$$
\hat{\tau}:=\inf \left\{t \in[0, T]: J_{t-}^{\mathbb{Q}}=C_{t-} \text { or } J_{t}^{\mathbb{Q}}=C_{t} \text { or } J_{t+}^{\mathbb{Q}}=C_{t+}\right\}
$$

and

$$
A^{-}:=\left\{J_{t-}^{\mathbb{Q}}=C_{t-}\right\}, A^{o}:=\left\{J_{t}^{\mathbb{Q}}=C_{t}\right\} \cap\left(A^{-}\right)^{c}, A^{+}:=\left(A^{-} \cup A^{o}\right)^{c} .
$$

It thus suffices to set $\tau^{i}:=\hat{\tau} \mathbb{1}_{A^{i}}+\infty \mathbb{1}_{\left(A^{i}\right) c}$ for $i \in\{-, o,+\}$ to obtain

$$
J_{0}^{\mathbb{Q}}=\mathbb{E}^{\mathbb{Q}}\left[C_{\hat{\tau}^{--}}+C_{\hat{\tau}^{o}}+C_{\hat{\tau}^{+}+}\right] .
$$

This shows that, in general, one needs to consider quasi stopping times instead of stopping times if one wants to establish an existence result, see also [1] for the case of càdlàg processes.

In the case of incomplete markets, the super-hedging price is given by the sup over all $\mathbb{Q} \in \mathcal{M}$ of $J_{0}^{\mathbb{Q}}$, see [13].

In our framework, the measure $\nu \in \mathcal{N}$ that appears in (3.2) can be interpreted as a randomized version of the quasi stopping times while the result of [7] should be interpreted as a formulation in terms of randomized stopping times. Both are consistent with the results of [2] and [4] that show that the duality does not work in discrete time models if we restrict to (non-randomized) stopping times. In both cases the process $Z \in \tilde{Z}(\nu)$ plays the role of $H^{\mathbb{Q}} S$ where $H^{\mathbb{Q}}$ is the density process associated to the equivalent martingale measures $\mathbb{Q}$ mentioned above. These two formulations thus corresponds to the two representations of the Snell envelope in (3.3). As in frictionless markets, the formulation of [7] is simpler while ours should allow to find the optimal randomized quasi stopping time, at least when $Z$ is fixed. We leave this point for further research.

## A Appendix: Proof of the representation result for the dual of $\mathcal{S}^{1}\left(\mathbb{Q}_{z}\right)$

We provide here the proof of Theorem 2.1. It is obtained by following almost line by line the proof of Theorem 27 in Chapter V of [15], see also [1]. We split the proof in different Lemmata. It is clear that we can always reduce to the one dimensional case since $\mu$ is linear. From now on, we shall therefore only consider the case $d=1$.

We first introduce some notations. Let $W$ be the subset of $[0, T] \times \Omega \times\{-, \circ,+\}$ defined by

W:=((0, T] \times \Omega \times\{-\}) \cup([0, T] \times \Omega \times\{\circ\}) \cup([0, T) \times \Omega \times\{+\}) .
$$

Given a subset $C$ of $[0, T] \times \Omega$, we set

$$
\begin{aligned}
C_{-} & =\{(t, \omega,-) \in W \mid(t, \omega) \in C, t>0\} \\
C_{\circ} & =\{(t, \omega, \circ) \in W \mid(t, \omega) \in C\} \\
C_{+} & =\{(t, \omega,+) \in W \mid(t, \omega) \in C, t<T\} .
\end{aligned}
$$

If $c$ is a function on $[0, T] \times \Omega$, we also introduce the three functions $c_{-}, c_{\circ}$ and $c_{+}$ on $W$

$$
\begin{aligned}
& c_{-}(t, w,+)=c_{-}(t, \omega, \circ)=0 \text { and } c_{-}(t, \omega,-)=c(t, \omega), \\
& c_{\circ}(t, w,+)=c_{\circ}(t, \omega,-)=0 \text { and } c_{\circ}(t, \omega, \circ)=c(t, \omega) \text {, } \\
& c_{+}(t, w,-)=c_{+}(t, \omega, \circ)=0 \text { and } c_{+}(t, \omega,+)=c(t, \omega) .
\end{aligned}
$$

We denote by $\tilde{\mathcal{S}}^{\infty}$ the set of làdlàg $\mathcal{B}([0, T]) \otimes \mathcal{F}$-measurable $\mathbb{P}$-essentially bounded processes. For a process $X \in \tilde{\mathcal{S}}^{\infty}$, we define $\bar{X}$ as follows

$$
\bar{X}(t, \omega,-):=X_{t-}(\omega), \bar{X}(t, \omega, \circ):=X_{t} \quad \text { and } \quad \bar{X}(t, \omega,+):=X_{t+}(\omega)
$$

Finally, we set $\overline{\mathcal{S}}^{\infty}:=\left\{\bar{X} \mid X \in \tilde{\mathcal{S}}^{\infty}\right\}$ and $\mathcal{W}:=\sigma\left(\bar{X}, \bar{X} \in \overline{\mathcal{S}}^{\infty}\right)$.
Note that $\overline{\mathcal{S}}^{\infty}$ is a lattice and $X \mapsto \bar{X}$ is a bijection. Thus, for a linear form $\tilde{\mu}$ on $\tilde{\mathcal{S}}^{\infty}$, we can always define the linear form $\bar{\mu}$ on $\overline{\mathcal{S}}^{\infty}$ by $\bar{\mu}(\bar{X}):=\tilde{\mu}(X)$.

Lemma A.1. Let $\tilde{\mu}$ be a linear form on $\tilde{\mathcal{S}}^{\infty}$ such that:
(C1) $\tilde{\mu}\left(X^{n}\right) \rightarrow 0$ for all sequence $\left(X^{n}\right)_{n}$ of positive elements of $\tilde{\mathcal{S}}^{\infty}$ such that $\sup _{n}\left\|X^{n}\right\|_{\mathcal{S}^{\infty}} \leq M$ for some $M>0$ and satisfying $\left\|X^{n}\right\|_{*} \rightarrow 0 \mathbb{P}$-a.s.

Then, there exists a signed bounded measure $\bar{\nu}$ on $(W, \mathcal{W})$ such that $\tilde{\mu}(X)=\bar{\mu}(\bar{X})=$ $\bar{\nu}(\bar{X})$ and $|\tilde{\mu}|(X)=|\bar{\mu}|(\bar{X})=|\bar{\nu}|(\bar{X})$ for all $X \in \tilde{\mathcal{S}}^{\infty}$.

Proof. Using the standard decomposition argument $\tilde{\mu}=\tilde{\mu}^{+}-\tilde{\mu}^{-}$, one can assume (and do) that the linear form $\tilde{\mu}$ is non-negative. We have to prove that $\bar{\mu}$ satisfies the Daniell's condition:
(C2) If $\left(\bar{X}^{n}\right)_{n \geq 0}$ decreases to zero then $\bar{\mu}\left(\bar{X}^{n}\right) \rightarrow 0$.
Let $\left(\bar{X}^{n}\right)_{n \geq 0}$ be a sequence of non-negative elements of $\overline{\mathcal{S}}^{\infty}$ that decreases to 0 . For $\epsilon>0$, we introduce the sets

$$
\begin{align*}
& A_{n}(\omega):=\left\{t \in[0, T] \mid X_{t+}^{n}(\omega) \geq \epsilon \text { or } X_{t-}^{n}(\omega) \geq \epsilon\right\} \\
& B_{n}(\omega):=\left\{t \in[0, T] \mid X_{t}^{n}(\omega) \geq \epsilon\right\} \\
& K_{n}(\omega):=A_{n}(\omega) \cup B_{n}(\omega) \tag{A.1}
\end{align*}
$$

Obviously, $K_{n+1}(\omega) \subset K_{n}(\omega), \bigcap_{n \geq 0} K_{n}(\omega)=\emptyset$ and $A_{n}(\omega)$ is closed. Let $\left(t_{k}\right)_{k \geq 1}$ be a sequence of $K_{n}(\omega)$ converging to $s \in[0, T]$. If there is a subsequence $\left(t_{\phi(k)}\right)_{k \geq 1}$ such that $X_{t_{\phi(k)}} \in A_{n}(\omega)$ for all $k \geq 0$, then $s \in K_{n}(\omega)$, since $A_{n}(\omega)$ is closed. If not, we can suppose than $t_{k}$ belongs to $B_{n}(\omega)$ for all $k \geq 1$, after possibly passing to a subsequence. Since $X(\omega)$ is làdlàg and bounded, we can extract a subsequence $\left(t_{\phi(k)}\right)_{k \geq 1}$ such that $\lim X_{t_{\phi(k)}}(\omega) \in\left\{X_{s-}(\omega), X_{s}(\omega), X_{s+}(\omega)\right\}$. Since $X_{t_{\phi(k)}(\omega)} \geq \epsilon$, we deduce that $s \in K_{n}(\omega)$. This proves that $K_{n}(\omega)$ is closed. Using the compactness
of $[0, T]$, we then obtain that there exists some $N_{\epsilon}>0$ for which $\cap_{n \geq N_{\epsilon}} K_{n}(\omega)=\emptyset$. Thus, $\left\|X^{n}(\omega)\right\|_{*}<\epsilon$ for $n \geq N_{\epsilon}$. Since $\tilde{\mu}$ satisfies (C1), this implies that $\bar{\mu}$ satisfies Daniell's condition (C2), which provides the existence of the measure $\bar{\nu}$.

Lemma A.2. If $S$ is a $\mathcal{F}$-measurable $[0, T]$-valued random variable, then $\llbracket S \rrbracket_{+}, \llbracket S \rrbracket_{o}$ and $\llbracket S \rrbracket_{-}$belongs to $\mathcal{W}$.

Proof. For $\epsilon>0$, we set $X^{\epsilon}:=\mathbf{1}_{(S,(S+\epsilon) \wedge T)}$ which belongs to $\tilde{\mathcal{S}}^{\infty}$. The associated process $\bar{X}^{\epsilon}$ is the indicator function of the set $I^{\epsilon}:=(S,(S+\epsilon) \wedge T]_{-} \cup(S,(S+\epsilon) \wedge$ $T)_{\circ} \cup[S,(S+\epsilon) \wedge T)_{+}$which belongs $\mathcal{W}$. Taking $\epsilon_{n}:=1 / n$ with $n \geq 1$, we thus obtain $\cap_{n \geq 1} I^{\epsilon_{n}}=\llbracket S \rrbracket_{+} \in \mathcal{W}$. Using the same arguments with $X^{\epsilon}:=\mathbf{1}_{(0 \vee(S-\epsilon), S)}$, we get that $\llbracket S \rrbracket_{-} \in \mathcal{W}$. Finally working with $X^{\epsilon}:=\mathbf{1}_{[S,(S+\epsilon) \wedge T)}$, we also obtain that $\llbracket S \rrbracket_{+} \cup \llbracket S \rrbracket_{\circ} \in \mathcal{W}$. Since $\llbracket S \rrbracket_{\circ}=\left(\llbracket S \rrbracket_{+} \cup \llbracket S \rrbracket_{\circ}\right) \cap\left(\llbracket S \rrbracket_{+}\right)^{c}$, this shows that $\llbracket S \rrbracket_{\circ} \in \mathcal{W}$.

Lemma A.3. If $C$ is a measurable set of $[0, T] \times \Omega$, then $C_{+} \cup C_{\circ} \cup C_{-} \in \mathcal{W}$.
Proof. Since $\mathcal{B}([0, T]) \otimes \mathcal{F}$ is generated by continuous adapted processes, it suffices to check that $X_{-}+X+X_{+}$is $\mathcal{W}$-measurable whenever $X$ is continuous and measurable. This is obvious since $\bar{X}=X_{-}+X_{\circ}+X_{+}$in this case.

Lemma A.4. There exists four measures $\alpha_{-}, \alpha_{\circ}^{\delta}, \alpha_{\circ}^{c}$ and $\alpha_{+}$on $[0, T] \times \Omega$ such that 1. $\alpha_{-}$is supported by $(0, T] \times \Omega$ and by a countable union of $[0, T]$-valued $\mathcal{F}$ measurable random variable $S$ such that $\alpha_{-}(\llbracket S \rrbracket)=\bar{\nu}\left(\llbracket S \rrbracket_{-}\right)$.
2. $\alpha_{+}$is supported by $[0, T) \times \Omega$ and by a countable union of graphs of $[0, T]$-valued $\mathcal{F}$-measurable random variable such that $\alpha_{+}(\llbracket S \rrbracket)=\bar{\nu}\left(\llbracket S \rrbracket_{+}\right)$.
3. $\alpha_{\circ}^{\delta}$ is supported by $[0, T] \times \Omega$ and by a countable union of graphs of $[0, T]$-valued $\mathcal{F}$-measurable random variable such that $\alpha_{\circ}^{\delta}(\llbracket S \rrbracket)=\bar{\nu}\left(\llbracket S \rrbracket_{\circ}\right)$.
4. $\alpha_{\circ}^{c}$ is supported by $[0, T] \times \Omega$ and does not charge any graph of $[0, T]$-valued $\mathcal{F}$-measurable random variable.
5. For all $X \in \tilde{\mathcal{S}}^{\infty}$, we have
$\tilde{\mu}(X)=\int_{\Omega} \int_{0}^{T} X_{t-}(\omega) \alpha_{-}(d t, d \omega)+\int_{\Omega} \int_{0}^{T} X_{t}(\omega) \alpha_{o}(d t, d \omega)+\int_{\Omega} \int_{0}^{T} X_{t+}(\omega) \alpha_{+}(d t, d \omega)$, where $\alpha_{\circ}=\alpha_{\circ}^{c}+\alpha_{\circ}^{\delta}$.

Proof. We first define $\mathcal{H}$ as the collection of sets of the form $A=\bigcup_{n \geq 0} \llbracket S_{n} \rrbracket_{+}$for a given sequence $\left(S_{n}\right)_{n \geq 0}$ of $[0, T]$-valued $\mathcal{F}$-measurable random variables. This set is closed under countable union. The quantity $\sup _{A \in \mathcal{H}}|\bar{\nu}|(A)=: M$ is well defined since $\bar{\nu}$ is bounded. Let $\left(A_{n}\right)_{n \geq 1}$ be a sequence such that $\lim |\bar{\nu}|\left(A_{n}\right)=M$ and set $G_{+}:=\bigcup_{n \geq 0} A_{n}$, so that $|\bar{\nu}|\left(G_{+}\right)=M$. Observe that we can easily reduce to
the case where the $G_{+}$is the union of disjoint graphs. We then define the measure $\bar{\nu}_{+}:=\bar{\nu}\left(\cdot \cap G_{+}\right)$and, recall Lemma A.3,

$$
\alpha_{+}(C):=\bar{\nu}_{+}\left(C_{+} \cup C_{-} \cup C_{\circ}\right)=\bar{\nu}_{+}\left(C_{+}\right)
$$

for $C \in \mathcal{B}([0, T]) \otimes \mathcal{F}$. The measure $\alpha_{+}$is supported by graphs of $[0, T]$-valued $\mathcal{F}$ measurable random variable. Moreover, for all $[0, T]$-valued $\mathcal{F}$-measurable random variable $S$, we have

$$
\alpha_{+}(\llbracket S \rrbracket)=\bar{\nu}\left(\llbracket S \rrbracket_{+}\right) .
$$

Indeed, $\bar{\nu}\left(\llbracket S \rrbracket_{+}\right)>\bar{\nu}\left(\llbracket S \rrbracket_{+} \cap G_{+}\right)$implies $\bar{\nu}\left(\llbracket S \rrbracket_{+} \cup G_{+}\right)>\bar{\nu}\left(G_{+}\right)$, which contradicts the maximality of $G_{+}$.
We construct $G_{-}, G_{\circ}$ and the measures $\alpha_{-}, \alpha_{\circ}^{\delta}$ and $\bar{\nu}_{-}, \bar{\nu}_{\circ}^{\delta}$ similarly. We then set $\bar{\nu}_{\circ}^{c}:=\bar{\nu}-\bar{\nu}_{+}-\bar{\nu}_{-}-\bar{\nu}_{\circ}^{\delta}$ and define $\alpha_{o}^{c}$ by $\alpha_{o}^{c}(C):=\bar{\nu}_{o}^{c}\left(C_{+} \cup C_{\circ} \cup C_{-}\right)$for $C \in \mathcal{B}([0, T]) \times \mathcal{F}$, recall Lemma A. 3 again. Observe that $\bar{\nu}_{\circ}^{\delta}, \bar{\nu}_{\circ}^{c}$ and $\bar{\nu}_{-} \operatorname{do}$ not charge any element of the form $\llbracket S \rrbracket_{+}$with $S$ a $[0, T]$-valued $\mathcal{F}$-measurable random variable. This follows from the maximal property of $G_{+}$. Similarly, $\bar{\nu}_{\circ}^{c}, \bar{\nu}_{\circ}^{\delta}$ and $\bar{\nu}_{+}$ do not charge any element of the form $\llbracket S \rrbracket_{-}$and $\bar{\nu}_{\circ}^{c}, \bar{\nu}_{-}$and $\bar{\nu}_{+}$do not charge any element of the form $\llbracket S \rrbracket_{\circ}$.

We now fix $X \in \tilde{\mathcal{S}}^{\infty}$ and set $u:(t, \omega) \mapsto X_{t-}(\omega), v:(t, \omega) \mapsto X_{t}(\omega)$ and $w:$ $(t, \omega) \mapsto X_{t+}(\omega)$. Then, $\bar{X}=u_{-}+v_{\circ}+w_{+}$and, by Lemma A.1,

$$
\tilde{\mu}(X)=\bar{\nu}(\bar{X})=\left(\bar{\nu}_{-}+\bar{\nu}_{\circ}^{\delta}+\bar{\nu}_{\circ}^{c}+\bar{\nu}_{+}\right)\left(u_{-}+v_{\circ}+w_{+}\right)
$$

Since $\bar{\nu}_{-}$is supported by $G_{-}, \bar{\nu}_{+}$by $G_{+}, \bar{\nu}_{\circ}^{\delta}$ by $G_{\circ}$ and $\bar{\nu}_{\circ}^{c}$ does not charge any graph of $[0, T]$-valued $\mathcal{F}$-measurable random variable, we deduce that

$$
\bar{\nu}_{+}\left(u_{-}+v_{\circ}+w_{+}\right)=\bar{\nu}_{+}\left(w_{+}\right)=\alpha_{+}(w)
$$

where the last equality comes from the definition of $\alpha_{+}$and $w$. Similarly, we have

$$
\begin{aligned}
\bar{\nu}_{-}\left(u_{-}+v_{\circ}+w_{+}\right) & =\bar{\nu}_{-}\left(u_{-}\right)=\alpha_{-}(u), \\
\bar{\nu}_{\circ}^{\delta}\left(u_{-}+v_{\circ}+w_{+}\right) & =\bar{\nu}_{\circ}^{\delta}\left(v_{\circ}\right)=\alpha_{\circ}^{\delta}(v) .
\end{aligned}
$$

Since $u, v$ and $w$ differs only on a countable union of graphs, it also follows that $\bar{\nu}_{\circ}^{c}\left(u_{-}+v_{\circ}+w_{+}\right)=\bar{\nu}_{\circ}^{c}\left(v_{\circ}\right)=\alpha_{\circ}^{c}(v)$. Hence

$$
\mu(X)=\alpha_{-}(u)+\alpha_{\circ}^{c}(v)+\alpha_{\circ}^{\delta}(v)+\alpha_{+}(w)
$$

which is assertion 5 . of the claim.
Conclusion of the proof of Theorem 2.1. Observe that $\mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$ is closed in the set $\tilde{\mathcal{S}}^{1}\left(\mathbb{Q}_{Z}\right)$ of all làdlàg $\mathcal{B}([0, T]) \otimes \mathcal{F}$-measurable processes $X$ satisfying
$\mathbb{E}^{\mathbb{Q}_{z}}\left[\|X\|_{*}\right]<\infty$. Using the Hahn-Banach theorem, we can find an extension $\tilde{\mu}$ of $\mu$ defined on $\tilde{\mathcal{S}}^{1}\left(\mathbb{Q}_{Z}\right)$, i.e. $\tilde{\mu}(X)=\mu(X)$ for $X \in \mathcal{S}^{1}\left(\mathbb{Q}_{Z}\right)$. Obviously, $\tilde{\mu}$ satisfies condition ( $\mathbf{C 1}$ ) of Lemma A.1. Thus it satisfies the representation of 5 . of Lemma A.4, and so does $\mu$ on $\mathcal{S}^{\infty}$.

Since $\mu(X)=0$ for all làdlàg processes $X$ such that $X=0 \mathbb{Q}_{z}$-a.s., the measures $\alpha_{-}, \alpha_{\circ}$ and $\alpha_{+}$admit transition kernels with respect to $\mathbb{P} \sim \mathbb{Q}_{Z}$. We can thus find three $\mathbb{R}^{d}$-valued processes $\tilde{A}^{-}, \tilde{A}^{\circ}$ and $\tilde{A}^{+}$with essentially bounded total variation satisfying for $X \in \mathcal{S}^{\infty}$ :

$$
\mu(X)=\mathbb{E}\left[\int_{0}^{T} X_{t-} d \tilde{A}_{t}^{-}+\int_{0}^{T} X_{t} d \tilde{A}_{t}^{\circ}+\int_{0}^{T} X_{t+} d \tilde{A}^{+}\right]
$$

with $\tilde{A}_{0}^{-}=0$ and $\tilde{A}_{T}^{+}=\tilde{A}_{T-}^{+}, \tilde{A}^{+}$and $\tilde{A}^{-}$are pure jump processes. To conclude, it suffices to replace $\tilde{A}^{-}$by its dual predictable projection $A^{-}$, and $\tilde{A}^{\circ}, \tilde{A}^{+}$by their dual optional projections $A^{\circ}$ and $A^{+}$. One can always add the continuous parts of $A^{-}$and $A^{+}$to $A^{\circ}$ to reduce to the case where $A^{-}$and $A^{+}$coincide with pure jumps processes.
