A nonparametric estimation of the spectral density of a continuous-time Gaussian process observed at random times

Abstract: In numerous applications (Biology, Finance, Internet Traffic, Oceanography,...) data are observed at random times and a graph of an estimation of the spectral density may be relevant for characterizing phenomena and explaining. By using a wavelet analysis, one derives a nonparametric estimator of the spectral density of a Gaussian process with stationary increments (also stationary Gaussian process) from the observation of one path at random discrete times. For every positive frequency, this estimator is proved to satisfy a central limit theorem with a convergence rate depending on the roughness of the process and the order moment of duration between times of observation. In the case of stationary Gaussian processes, one can compare this estimator with estimators based on the empirical periodogram. Both estimators reach the same optimal rate of convergence, but the estimator based on wavelet analysis converges for a different class of random times. Simulation examples and application to biological data are also provided.

Keywords: Gaussian processes observed at random times; Nonparametric estimation; Spectral density; Continuous Wavelet Transform; Fractional Brownian motion; Multiscale fractional Brownian motion, Heartbeat series.

1 Introduction

Consider first a Gaussian process $X = \{X(t), t \in \mathbb{R}\}$ with zero mean and stationary increments, but results will be extended in case where a polynomial trend is added to such processes. Therefore X can be written following an harmonizable representation, see Yaglom (1958) or Cramèr and Leadbetter (1967). We adopt

a more recent notation as in Bonami and Estrade (2003), thus

$$X(t) = \int_{\mathbb{R}} \left(e^{it\xi} - 1 \right) f^{1/2}(\xi) dW(\xi), \quad \text{for all } t \in \mathbb{R},$$

$$\tag{1.1}$$

where

• W(dx) is a complex Brownian measure, with adapted real and imaginary part such that the Wiener integral is real valued. We refer to Samorodnitsky and Taqqu (1994), pp. 325-327 for detailed definition and properties. Isometry property [31, Formula (7.2.9), p. 327], i.e. $\mathbb{E}[I(g_1) \cdot I(g_2)] = \int g_1(x) \cdot \overline{g_2(x)} dx$ where $I(g) = \int_{\mathbb{R}} g(x) dW(x)$ and $g \in L^2(\mathbb{R}, \mathbb{C})$ is a deterministic function, is given for function g such that I(g) is real valued. But, after a decomposition of the stochastic integral into real and imaginary part, that is with $g = g_1 + ig_2$ and $I(g) = I(g_1) + iI(g_2)$ where $I(g_1)$ and $I(g_2)$ are real valued, one can extend the isometry property to complex function and we get

$$\mathbb{E}\left[I(g_1)\cdot\overline{I(g_2)}\right] = \int_{\mathbb{R}} g_1(x)\cdot\overline{g_2(x)}\,dx. \tag{1.2}$$

• f is a Borelian positive even function so-called the spectral density of X and is such that

$$\int_{\mathbb{R}} \left(1 \wedge |\xi|^2 \right) f(\xi) \, d\xi < \infty. \tag{1.3}$$

In the sequel, f will be supposed to satisfy also Assumption F(H) defined below but conditions are weak and the class of processes that can be considered is general.

As a particular case, if X is a stationary processes, one will still denote f the spectral density such that

$$X(t) = \int_{\mathbb{R}} e^{it\xi} f^{1/2}(\xi) dW(\xi), \quad \text{for all } t \in \mathbb{R},$$

$$\tag{1.4}$$

where f is still a Borelian positive even function, but satisfies the stronger condition

$$\int_{\mathbb{R}} f(\xi) \, d\xi < \infty. \tag{1.5}$$

Even if their definition are different, since in the sequel we will consider wavelet coefficients of X which have the same expression with respect to f for both models (1.1) and (1.4), f will denote as well the spectral density of a process having stationary increments or a stationary process (see more details in Proposition 2.1). Define also the σ -algebra \mathcal{F}_X generated by the process X, *i.e.*

$$\mathcal{F}_X := \sigma \{ X(t), \ t \in \mathbb{R} \}. \tag{1.6}$$

A path of such a process X on the interval $[0, T_n]$ at discrete times $t_i^{(n)}$ for i = 0, 1, ..., n is observed, i.e.

$$(X(t_0^{(n)}), X(t_1^{(n)}), \dots, X(t_n^{(n)}))$$
 is known, with $0 = t_0^{(n)} < t_1^{(n)} < \dots < t_n^{(n)} = T_n$.

A unified frame of irregular observed times, grouping deterministic and stochastic ones, will be considered. First let us assume that there exist a sequence of positive real numbers $(\delta_n)_{n\in\mathbb{N}}$ and a sequence of random variables (r.v. in the sequel) $(L_k)_{k\in\mathbb{N}}$ (which could be deterministic real numbers) such that

$$\forall k \in \{0, 1, \dots, n-1\}, \quad t_{k+1}^{(n)} - t_k^{(n)} := \delta_n L_k, \quad \text{and} \quad \delta_n \xrightarrow[n \to \infty]{} 0.$$
 (1.7)

For Z a r.v. and $\alpha \in (0, \infty)$, denote $||Z||_{\alpha} := (E(|Z|^{\alpha}))^{1/\alpha}$ if $E(|Z|^{\alpha}) < \infty$. Now, assume that there exists $s \in [1, \infty)$ such that

Assumption S(s) $(L_k)_{k \in \mathbb{N}}$ is a sequel of positive r.v. such that: there exist $0 < m_1 \le M_1$ and $M_s < \infty$ satisfying

$$m_1 \leq I\!\!E L_k = ||L_k||_1 \leq M_1$$
 and $||L_k||_s \leq M_s$, for all $k \in I\!\!N$.

Then we can also defined:

Assumption S(\infty) $(L_k)_{k\in\mathbb{N}}$ is a sequel of positive r.v. satisfying Assumption S(s) for every $s\in\mathbb{N}$.

For instance, it is clear that if $(L_k)_{k\in\mathbb{N}}$ is a sequence of exponential or bounded r.v., then Assumption $S(\infty)$ is satisfied. Now, $T_n = \delta_n(L_0 + \ldots + L_{n-1})$ and under Assumption S(s) for any $s \ge 1$,

$$m_1 \times (n\delta_n) \le I\!\!E(T_n) \le M_1 \times (n\delta_n).$$
 (1.8)

This point will be extensively used in the sequel to replace the asymptotic $\mathbb{E}(T_n) \to \infty$ by $n\delta_n \to \infty$.

Comments on the modelling of observation times

Assumptions S(s) on the observation times may seem slightly unusual. This leads to following comments:

- 1. Generally, for processes observed at random times (see for instance Lii and Masry, 1994), duration between observation times $\tau_k = (t_{k+1} t_k)$ are random variables not depending on the data length. In a sense, the asymptotic behavior only concerns the length of observation time T_n (which is necessary to estimate the spectral density at low frequencies). But the lag between two successive random observation times have to be sufficiently often very small to allow an estimation of the spectral density for high frequencies. Hence, observation times have to satisfy a strong condition and are typically a Poissonian sampling.
- 2. In our modelling there are two asymptotic behaviors: the length of observation time T_n converges to infinity and the mesh δ_n converges to 0. The first one is standard up to the slight difference that T_n can be random. This assumption is justified by numerous applications; for instance, the duration of a marathon is clearly random. Thus we have to replace the first asymptotic by $\mathbb{E}(T_n) \to \infty$. The second one is less standard but corresponds to applications. We have followed and transposed the idea of round-off introduced, to our best knowledge, by Delattre and Jacod (1997) and currently used today, see for e.g. Robert and Rosenbaum (2008). In this setting, the time is continuous but round-off with a precision δ_n . Then, duration between observation times $(t_{k+1}^{(n)} t_k^{(n)})$ are the mesh δ_n multiplied by integer valued random variables L_k . Eventually, we do not assume that r.v. L_k are independent nor identically distributed.
- 3. Our choice which is also relative to numerous application cases (see the example of heart rate variability below) has been to provide a spectral density estimation under very weak condition on the

- observation times. Typically our results remains valid even for regular sampling (and it is not such case under Masry's conditions defined below).
- 4. In applications, signals are observed at discrete times mostly irregularly spaced and random. This type of observations can be met in medicine, physics, mechanics, oceanography,... In these cases observation times depend on the measuring instrument, therefore of a hazard independent from that of the process X. In this context, the hypothesis of independence of durations $(L_k)_{k\in\mathbb{N}}$ and \mathcal{F}_X is completely realistic. The only case where this assumption seems restrictive concerns financial data. However it is until this day always made, see for instance, Hayashi and Yoshida (2005) or Aït-Sahalia and Mykland (2008).

An example: heartbeat time series

Before going further, let us give a detailed example: the heart rate variability. Cardiologists are interested in the behavior of its spectral density, usually on both frequency bands $(\omega_1, \omega_2) = (0.04 \, Hz, \, 0.15 \, Hz)$ and $(\omega_2, \omega_3) = (0.15 \, Hz, \, 0.5 \, Hz)$ corresponding respectively to the orthosympathetic nervous system and the parasympathetic one, see [33]. The spectral density follows different power laws on the different frequency bands, i.e. $f(\xi) = \sigma_i |\xi|^{-\beta_i}$ when $\xi \in (\omega_i, \omega_{i+1})$. Finally, according to the type of activity or the period of the day, one notices a variation of these parameters. We send back to Section 3.3, which brings to light different power laws during the working and sleep hours, i.e. $(\beta_1^{work}, \beta_2^{work}) \neq (\beta_1^{sleep}, \beta_2^{sleep})$.

Actually, heartbeat is measured at frequency 100Hz. For physiological reasons, the duration between two observations should be between 250 milliseconds and 2 seconds. In this framework, Assumption $S(\infty)$ would be obviously satisfied. Assumption S(s) with $s < \infty$ holds for instance for other physiological signals like EMG, EEG... and VHF intraday financial data.

In the above example both frequency bands seem fixed. In other examples, the frequency of cut between the various bands associated with various power laws must be determined and constitutes the parameter of interest. We refer to our work devoted to biomechanical data [4]. These examples show the concrete character and interesting perspectives of a non-parametric estimation of the spectral density.

Estimation of the spectral density, state of the art

To our knowledge, the estimate the spectral density of a Gaussian process with stationary increments on finite bands of frequencies from observation at discrete times is a new problem. Recall that the spectral density $f(\xi) = C |\xi|^{-(2H+1)}$ corresponds to a fractional Brownian motion (fBm in the sequel) with Hurst index H. However, most of the statistical studies devoted to the fBm or its generalizations concern the estimation of the local regularity parameter (linked to the behavior of the spectral density at ∞) or the long memory parameter (linked to the behavior of the spectral density in the neighborhood of 0). The context of those studies is almost always the observation of a path at deterministic and regularly spaced discrete times, see for instance Dahlhaus (1989), Gloter and Hoffmann (2007), Moulines *et al.* (2007) or the book edited by Doukhan *et al.* (2003). Begyn (2005) seems to be the only reference concerning the

estimation of H unde r irregular (but deterministic) observation times.

On the other hand, the estimation of the spectral density of stationary Gaussian processes is a classical problem corresponding to numerous practical applications, see Shapiro and Silverman (1960) or Parzen (1983). The used methods are based on the periodogram defined by $I_T(\xi) = (2\pi T)^{-1} \left| \int_0^T e^{-i\xi t} X(t) dt \right|^2$. However, if $(X_{t_1}, \dots, X_{t_N})$ is known, with regularly spaced observation times $t_i = i\Delta$ and $T = t_N = N\Delta$, then $\lim_{T\to\infty} \mathbb{E} I_T(\xi) = f(\xi)$ but $\lim_{N\to\infty} \mathbb{E} J_N(\xi) = \sum_{k\in\mathbf{Z}} f(\xi+2k\pi\Delta^{-1})$ where J_N is the empirical periodogram, that is $J_N(\xi) := (2\pi N\Delta)^{-1} \left| \Delta \sum_{k=1}^N e^{-i\xi k\Delta} X(k\Delta) \right|^2$: such a phenomena is called aliasing. To avoid aliasing, random sampling is chosen and then the empirical periodogram becomes asymptotically unbiased. By using a spectral window an estimator of the spectral density can be deduced and it satisfies a central limit theorem (CLT) with a rate of convergence $T^{-2/5}$, see Masry (1978a-b) or Lii and Masry (1994). These results are obtained for random sampling verifying very specific conditions that we will call in the sequel:

Masry's conditions: the process of observation times $(t_k)_k$ is a stationary, orderly point process independent of X, with known mean rate β and covariance density c(u) and verifies the condition $\beta^2 + c(u) > 0$ a.e., where $N(\cdot)$ is the associate counting process, $\beta = \mathbb{E}[N((0,1))]$ and c(u) its covariance density function (Masry, 1978, Cor. 1.1, p. 320).

When the trajectory is not sampled but observed at random times not chosen by the experimenter, a first step before the estimation of the spectral density is to check that the family (t_i) satisfies Masry's conditions and it is necessary to estimate the mean rate β and the covariance density function c(u).

Wavelet based estimators

We have chosen another approach: a wavelet analysis. This approach was introduced for fBm by Flandrin (1992), and popularized by many authors, see for e.g. Abry et~al.~(2003), to estimate the parametric behavior of a power law spectral density when $\log |\xi| \to \infty$ or $\log |\xi| \to -\infty$ of a time series (with regularly spaced observation times). In the sequel, we will show that the wavelet analysis is also an interesting tool to estimate the spectral density for Gaussian processes having stationary increments (or stationary Gaussian processes) when a path is observed at random times. Let us underline that the wavelet analysis in Abry et~al.~(2003) is based on the sample variance of wavelet coefficients and thus is different from that proposed by Lehr and Lii (1997) or Goa et~al.~(2002) who respectively consider the wavelet decomposition of the estimator derived from the empirical periodogram and the periodogram of the Haar wavelet transform of the process. In both these last cases, discrete times observation are supposed to satisfy Masry's conditions to avoid aliasing.

We consider a non-parametric estimator of the spectral density based on a sample variance of wavelet coefficients. There are two main differences with the approach of Flandrin (1992) or Abry *et al.* (2003). Firstly, the definition of "empirical" wavelet coefficients, see (2.3), is adapted for non regular observations times. Then a general CLT for sample variance of such "empirical" wavelet coefficients is established (see

Theorem 2.1) and a CLT for a semiparametric estimator of the spectral density can be deduced for a large class of fractional processes. Secondly, one considers a sequel of mother wavelets ψ_{λ} in a way that enables the convergence, as $\lambda \to \infty$ of $|\widehat{\psi}_{\lambda}|^2$ to a Dirac mass concentrated at the frequency $\xi = 1$. Then a CLT for a nonparametric estimator of the spectral density is derived (see Proposition 2.2). For observation times satisfying Assumption S(s) with s > 2, the supremum of the convergence rate of this last CLT is $T_n^{-2/5}$. This is the same convergence rate than the periodogram based estimator one (see for instance Lii and Masry, 1994), but for a class of observation times clearly more general than the Masry's one (see for e.g. Lii and Masry, 1994). Indeed, our assumptions on observation times allow non-stationary or regularly spaced times, for Gaussian stationary processes and also for Gaussian processes having stationary increments (as fBm). However, a relation between T_n and δ_n is required (see condition 2.8 below). This condition depends on the regularity of the trajectory and the variability s of observation times. Therefore, in terms of the number n of observations, the convergence rate of our estimator $\widehat{f}_n^{(\lambda_n)}(\xi)$ is slower than $n^{-2/5}$.

Finally, let us add two comments on the choice and the advantage of wavelet based estimators. Firstly, our method plainly uses the time-frequency localization of the wavelet: in frequency, to build a nonparametric estimator of the spectral density from continuous time observations, and in time, to bound the error of approximation of the wavelet coefficient with discrete time observation. Conditions required on wavelet mothers are mild and satisfied by a large set of wavelets (Daubechies wavelet D_p for $p \geq 6$, Lemarié-Meyer, Morlet, Gabor, biorthogornal wavelets, ...) and only exclude Haar basis and Daubechies wavelet for $p \leq 4$. Actually, we do not need that the family of functions generated by dilations and translations forms a basis of $L^2(\mathbb{R})$. Secondly, our wavelet based estimator can be applied to stationary processes as well as processes having stationary increments. Moreover it is robust to eventual polynomial trends. Such properties are induced by the number of vanished moments of the mother wavelet. A periodogram estimator does not satisfy such condition and therefore can not be efficiently applied in so many cases.

The remainder of the paper is organized as follow: Section 2 is devoted to the wavelet analysis of X and the CLT satisfied by the estimator of f. This estimator is applied to generated data and real data in Section 3. Section 4 contains the proofs.

2 Main results

This section contains three main results. In the first subsection, we specify conditions on the mother wavelet, and give a representation formula for the wavelet coefficients of the process. In the second subsection, we establish a CLT satisfied by a sample variance wavelet coefficients. This result provides the rate of convergence of a spectral density estimator in parametric or semi-parametric cases (for instance for a fBm). Eventually, the third subsection is devoted to a nonparametric estimation of the spectral density through a localization procedure.

2.1 Definition and harmonizable representation of wavelet coefficients

Let $\psi : \mathbb{R} \to \mathbb{C}$ be a function so-called the "mother" wavelet, and denote $\widehat{f}(\xi) = \int_{\mathbb{R}} e^{-i\xi x} f(x) dx$ the Fourier transform of $f \in L^1(\mathbb{R}) \cap L^2(\mathbb{R})$. Let $(m, q, r) \in \mathbb{N}^* \times \mathbb{R}^2_+$ and the family of assumptions on ψ :

Assumption W(m,q,r) ψ : $\mathbb{R} \mapsto \mathbb{C}$ is a differentiable function satisfying:

• Number of vanishing moments: for all $n \leq m+1$, $\int_{\mathbb{R}} |t^n \psi(t)| dt < \infty$, and

$$\int_{\mathbb{R}} t^n \psi(t) dt = 0 \quad \text{for all } n \le m.$$

• Time localization: there exists a constant $C_{\psi} > 0$ such that for all $t \in \mathbb{R}$,

$$(1+|t|)^q \cdot |\psi(t)| \leq C_{\psi}.$$

• Frequency localization: there exists a constant $C'_{\psi} > 0$ such that for all $\xi \in \mathbb{R}$,

$$(1+|\xi|)^r \cdot (|\widehat{\psi}(\xi)| + |\widehat{\psi}'(\xi)|) \le C'_{\psi}.$$

The first condition of W(m,q,r) implies that $\widehat{\psi}(\xi) = O(\xi^m)$ when $\xi \to 0$ and is (m+1) times continuously differentiable. In the sequel, we assume at most W(1,3,1/2). These conditions are mild and are satisfied by many famous wavelets (Daubechies wavelet D_p for $p \ge 6$, Lemarié-Meyer, Morlet, Gabor, biorthogornal wavelets, ...). It is also not mandatory to choose ψ to be a "mother" wavelet associated to a multiresolution analysis of $\mathbb{L}^2(\mathbb{R})$ and the whole theory can be developed without resorting to this assumption.

Let $(a,b) \in \mathbb{R}_+^* \times \mathbb{R}$, and define $d_X(a,b)$ the wavelet coefficient of the process X for the scale a and the shift b, such that

$$d_X(a,b) := \frac{1}{\sqrt{a}} \int_{\mathbb{R}} \psi\left(\frac{t-b}{a}\right) X(t) dt$$

This family of wavelet coefficients satisfies the following property:

Proposition 2.1 (Harmonizable representation) Let ψ satisfy Assumption W(1,1,0) and X be a Gaussian process defined by (1.1) or (1.4) with a spectral density f satisfying respectively (1.3) or (1.5). Then,

$$d_X(a,b) = \sqrt{a} \int_{\mathbb{R}} e^{ib\xi} \, \overline{\widehat{\psi}}(a\xi) \, f^{1/2}(\xi) \, dW(\xi) \text{ for all } (a,b) \in \mathbb{R}_+^* \times \mathbb{R}, \tag{2.1}$$

and, for a > 0, $(d_X(a,b))_{b \in \mathbb{R}}$ is a stationary centered Gaussian process with variance given by

$$\mathbb{E}\left(\left|d_X(a,b)\right|^2\right) = \mathcal{I}_1(a) := a \int_{\mathbb{R}} |\widehat{\psi}(au)|^2 f(u) \, du \text{ for all } b \in \mathbb{R}.$$
 (2.2)

The proof of this proposition is grouped with all the other proofs in Section 4.

2.2 An estimator of the variance of wavelet coefficients and its application to the semi-parametric estimation of the spectral density

Let us begin with an example. If X is a fBm with Hurst parameter $H \in (0,1)$, its spectral density is $f(\xi) = C |\xi|^{-(2H+1)}$ for all $\xi \in \mathbb{R}^*$ (with C > 0). Then for a scale a > 0 a straightforward computation of the variance of wavelet coefficients $\mathcal{I}_1(a)$ defined in (2.2) shows that $\mathcal{I}_1(a) = K a^{2H+1}$ with $K = C \left(\int_{\mathbb{R}} \frac{|\widehat{\psi}(u)|^2}{u^{2H+1}} du \right)$. Therefore a consistent estimator of $\mathcal{I}_1(a)$ furnishes a consistent estimator of H obtained by a log-log regression of $(\mathcal{I}_1(a_i))_{1 \le i \le m}$ onto $(\log a_i)_{1 \le i \le m}$. The same method works also for multiscale fBm (see Bardet and Bertrand, 2007b).

Thus our first aim is the estimation of $\mathcal{I}_1(a)$. When $(X(t_0^{(n)}), \dots, X(t_n^{(n)}))$ is only known, an explicit formula $\mathcal{I}_1(a)$ is not available for both the following reasons:

1. on the one hand, $d_X(a,b)$ is defined with a Lebesgue integral and cannot be directly computed from data. As in Gloter and Hoffmann (2007), an approximation formula will be considered for computing wavelet coefficients. Thus, for $(a,b) \in \mathbb{R}_+^* \times \mathbb{R}$ we define an empirical wavelet coefficient by

$$e_X(a,b) := \frac{1}{\sqrt{a}} \sum_{i=0}^{n-1} \left(\int_{t_i^{(n)}}^{t_{i+1}^{(n)}} \psi\left(\frac{t-b}{a}\right) dt \right) X(t_i^{(n)}). \tag{2.3}$$

2. on the other hand, a sample mean of $|d_X(a,b)|^2$ instead on $\mathbb{E}|d_X(a,b)|^2$ is only computable. Thus, define the sample estimator of $\mathcal{I}_1(a)$ by

$$J_n(a) := \frac{1}{n+1} \sum_{k=0}^n |e_X(a, c_k)|^2, \tag{2.4}$$

where $(c_k)_k$ is a family of increasing real numbers (so-called shifts). In this paper, we will consider a uniform repartition of shifts, *i.e.* for k = 0, ..., n,

$$c_k = T_n^{\rho} + k \frac{T_n - 2T_n^{\rho}}{n}$$
 with $\rho \in (3/4, 1)$. (2.5)

In this example $(c_k)_{1 \le k \le n}$ are random variables depending on random times $(t_1^{(n)}, \ldots, t_n^{(n)})$ but $c_{k+1} - c_k$ does not depend on k. We will see that it is not easy to consider a simpler expression of (c_k) ; for instance $c_k = kT_n/n$ could not be used because there would be some edge effects for estimating the wavelet coefficients in c_0 or c_n . Therefore a sufficient "distance" from the boundaries 0 and T_n is necessary. However, other choices of $(c_k)_k$ are possible (for instance $c_k = t_k$) but we have not been able to find an optimal choice and simulations do not show significative differences between these choices. Now additional conditions on f have to be considered:

Assumption F(H): f is an even function, differentiable on $[0, \infty)$ except for a finite number K of real numbers $\omega_0 = 0 < \omega_1 < \cdots < \omega_K$, but f admits left and right limits in ω_k , with a derivative f' (defined on

all open intervals (ω_k, ω_{k+1}) with $\omega_{K+1} = \infty$ by convention) such that

$$\int_{\mathbb{R}} \left(1 \wedge |\xi|^3 \right) \cdot \left| f'(\xi) \right| \, d\xi < \infty. \tag{2.6}$$

Moreover, there exist $C_0, C_0' > 0$ and H > 0, such that for all $|x| \ge \omega_K$

$$f(x) \le C_0 |x|^{-(2H+1)}$$
 and $f'(x) \le C_0' |x|^{-(2H+2)}$. (2.7)

Here there are several examples of processes having a spectral density f satisfying Assumption F(H):

Examples: 1. A smooth Gaussian process having stationary increments satisfies F(H) with $H \ge 1$ satisfies F(H) with $H \ge 1$.

- 2. A fractional Brownian motion with Hurst parameter $H \in (0, 1)$ satisfies F(H). Indeed, its spectral density is given by $f(\xi) = C |\xi|^{-(2H+1)}$ and corresponds to a power law of the frequency.
- 3. However, a fBm is a limited model. For instance, in some biological applications, statistical studies suggest that the logarithm of the spectral density is a piecewise affine function of the log-frequency, see for instance Collins and De Luca (1993) or Billat *et al.* (2009). Furthermore in certain frequency bands the slope corresponds to a Hurst parameter H larger than 1. For these reasons, in Bardet and Bertrand (2007a), we have introduced the multiscale fBm such that there exists a family of frequencies $\omega_1 < \cdots < \omega_K$ satisfying $f(\xi) = C_i |\xi|^{-(2H_i+1)}$ for $|\xi| \in (\omega_i, \omega_{i+1})$ and $i = 0, \dots, K$, with the convention that $\omega_0 = 0$ and $\omega_{K+1} = \infty$, $H_0 < 1$, $0 < H_K$ and $(C_i, H_i) \in \mathbb{R}_+^* \times \mathbb{R}$ for $i = 1, \dots, K-1$. Then Condition (1.3) and Assumption F(H) are checked with $H = H_K$.
- 4. A stationary process with a bounded spectral density such as a Ornstein-Uhlenbeck process (for which $f(\xi) := \alpha (\pi(\alpha^2 + \xi^2))^{-1}$ with $\alpha > 0$).

The sample variance of wavelet coefficients $J_n(a)$ computed from the observed trajectory $(X(t_0^{(n)}), \ldots, X(t_n^{(n)}))$ and defined by (2.4) satisfies the following CLT:

Theorem 2.1 Let X be a Gaussian process defined by (1.1) or (1.4) with a spectral density f satisfying (1.3) and Assumption F(H), ψ satisfying Assumption W(1,3,1) and $(c_k)_k$ defining by (2.5). Under Assumption S(s) with $s > 2 + \frac{1}{2H} [1 - 3H]_+$ and if

$$I\!\!E(T_n) \times \delta_n^{(s-1)\left(\frac{(2H\wedge 1)}{1+(2H\wedge 1)}\right)\wedge\left(\frac{1+(H\wedge 1)}{s+(H\wedge 1)}\right)} \underset{n\to\infty}{\longrightarrow} 0. \tag{2.8}$$

Then for all a > 0,

$$\sqrt{I\!ET_n} \left(J_n(a) - \mathcal{I}_1(a) \right) \xrightarrow[n \to \infty]{\mathcal{D}} \mathcal{N} \left(0, 4\pi a^2 \int_{\mathbb{R}} \left| \widehat{\psi}(az) \right|^4 f^2(z) \, dz \right). \tag{2.9}$$

Remark 2.1 1. The convergence rate of the CLT (2.9) is $\sqrt{E(T_n)}$ when Condition (2.8) is satisfied. A natural question is what happens elsewhere? This leads to the following comments: roughly speaking, from Theorem 2.1 and Lemma 4.6, one can deduce

$$J_n(a) = \mathcal{I}_1(a) + \left[\mathbb{E}(T_n) \right]^{-1/2} \Gamma U + \zeta_n \tag{2.10}$$

where $U \sim \mathcal{N}(0,1)$, $\Gamma^2 = 4\pi a^2 \int_{\mathbb{R}} |\widehat{\psi}(az)|^4 f^2(z) dz$ corresponds to the variance in CLT (2.9) and ζ_n corresponds to the discretization error. As soon as Condition (2.8) is fulfilled, the discretization term ζ_n is negligible with respect to the CLT term and the rate of convergence is $\sqrt{\mathbb{E}(T_n)}$. If the condition (2.8) is not satisfied, then the upper bound of the mean square error does no more decrease when $\mathbb{E}(T_n) \to \infty$.

2. It also possible to specify Condition (2.8) by using a relation between δ_n and n; for this, let

$$\delta_n = C_\delta \, n^{-d}$$
 with $0 < d < 1$.

The following Table 1 summarizes the possible of choices of s and d and the supremum of the convergence rate of the CLT (2.9)) following several cases.

Table 1: Conditions on s, d and supremum of the convergence rate of the semiparametric estimator of the spectral density f (CLT (2.9)) and the nonparametric estimator of f (CLT (2.14) with $\lambda_n \simeq CT_n^{1/5+\kappa} \simeq Cn^{1/5(1-d)+\kappa}$ with $\kappa > 0$ arbitrary small) following the a priori on H.

Note that CLT (2.9) can be applied to an estimation of each H_i of a multiscale fractional Brownian motion when a trajectory is observed at random times. Indeed, in such a case and if ψ is chosen such as $\widehat{\psi}(\xi) \neq 0$ only for $\xi \in [-\beta, -\alpha] \cup [\alpha, \beta]$ then (see details in Bardet and Bertrand (2007b)):

$$\mathcal{I}_1(a) = a^{2H_i+1}C_{f,\psi}$$
 for all $\xi \in [\alpha/\omega_i, \beta/\omega_{i+1}],$

with $C_{f,\psi} > 0$ not depending on a. Therefore a log-log-regression of $J_n(a)$ onto a for several values of $a \in [\alpha/\omega_i, \beta/\omega_{i+1}]$ provides an estimator of H_i and C_i which follows a CLT with the same convergence rate than (2.9). Such a result may be of course also applied to a fBm without specifications on the scales a. This is more precisely stated in the following

Corollary 2.1 (parametric case) Let X be a fBm with parameters $H \in (0,1)$, C > 0, assume that $(X_{t_1^{(n)}}, \cdots, X_{t_1^{(n)}})$ is observed, that Assumption $S(\infty)$ is fulfilled, that ψ satisfies Assumption W(1,3,1) and that $\delta_n \mathbb{E} T_n \xrightarrow[n \to \infty]{} 0$, then there exists a constant C > 0 such as for n large enough,

$$\mathbb{E}\left[\left\| \left(\begin{array}{c} \widehat{H}_n \\ \widehat{C}_n \end{array} \right) - \left(\begin{array}{c} H_l \\ C_l \end{array} \right) \right\|^2 \right] \le \frac{C}{\mathbb{E}T_n}. \tag{2.11}$$

where \widehat{H}_n and \widehat{C}_n are the estimators obtained by log-log-regression of $J_n(a)$ onto a. If moreover, the Hurst index H is known in advance to lie in the interval (1/3,1), then Condition $S(\infty)$ can be replaced by Condition $S(2+\varepsilon)$ for any $\varepsilon > 0$.

To our knowledge, only Begyn (2005) provides an asymptotic result on the estimation of H under irregular observation times but only in the case of fBm and with a stronger condition than Assumption $S(\infty)$.

2.3 A nonparametric estimator of the spectral density

The third result of this paper deals with the pointwise estimation of f through a localization procedure in Theorem 2.1. Let us define the "rescaled" functions:

$$\psi_{\lambda}(x) := \frac{1}{\sqrt{\lambda}} e^{ix} \psi(\frac{x}{\lambda}) \tag{2.12}$$

in a way that enables the convergence, as $\lambda \to \infty$ of $|\widehat{\psi}_{\lambda}|^2$ to a Dirac mass concentrated at the frequency $\xi = 1$. Then a rescaled version of the estimator (2.3, 2.4) is introduced:

$$\widehat{f}_n^{(\lambda)}(\xi) := \frac{\xi}{\|\psi\|_{\mathcal{L}^2}^2} \frac{1}{n+1} \sum_{k=0}^n \Big| \sum_{i=0}^{n-1} X(t_i^{(n)}) \int_{t_i^{(n)}}^{t_{i+1}^{(n)}} \psi_\lambda(\xi(t-c_k)) dt \Big|^2.$$
 (2.13)

 ξ From (2.12), it is obvious that

$$\widehat{\psi}_{\lambda}(\xi) = \sqrt{\lambda} \, \widehat{\psi} \big(\lambda(\xi - 1) \big) \quad \forall \xi \in IR,$$

and after that

$$\mathcal{I}_{\lambda}(a) := \int_{\mathbb{R}} |\widehat{\psi}_{\lambda}(u)|^2 f(u/a) du \to f(1/a) \|\psi\|_{\mathcal{L}^2}^2 \quad \text{when} \quad \lambda \to \infty$$

under weak hypothesis. Then a CLT is established for the nonparametric estimator (2.13) with a sequence $(\lambda_n)_n$ satisfying $\lambda_n \to \infty$ and assumptions of Theorem 2.1. Note the first condition $\psi_{\lambda} \in W(1,3,1)$ is fulfilled as soon as $\lambda_n > \Lambda$ when $\widehat{\psi}$ is compactly supported in $[-\Lambda, \Lambda]$. Now, by using an appropriated choice of a sequence (ψ_{λ_n}) , one obtains:

Proposition 2.2 Assume that assumptions of Theorem 2.1 hold. Moreover, if the spectral density f is a twice continuously differentiable function on \mathbb{R}^* , if $\widehat{\psi}$ is compactly supported, and if the sequence $(\lambda_n)_n$ is such that $\frac{\lambda_n^2}{n\delta_n} \underset{n\to\infty}{\longrightarrow} 0$ and $\frac{\lambda_n^5}{n\delta_n} \underset{n\to\infty}{\longrightarrow} \infty$, then for all $\xi > 0$,

$$\sqrt{\frac{T_n}{\lambda_n}} \left(\widehat{f}_n^{(\lambda_n)}(\xi) - f(\xi) \right) \xrightarrow[n \to \infty]{\mathcal{D}} \mathcal{N} \left(0, \frac{4\pi}{\xi} f^2(\xi) \frac{\int_{\mathbb{R}} \left| \widehat{\psi}(u) \right|^4 du}{\left(\int_{\mathbb{R}} \left| \widehat{\psi}(u) \right|^2 du \right)^2} \right). \tag{2.14}$$

The rate of convergence of the parametric (or semiparametric) estimator is $T_n^{-1/2}$, see CLT (2.9). In the case of nonparametric estimator, with the optimal choice of λ_n , i.e. $\lambda_n = C(n\delta_n)^{1/5+\kappa} = O(T_n^{1/5+\kappa})$ with $\kappa > 0$ arbitrary small, the supremum of the convergence rate of this nonparametric estimator is $T_n^{-2/5}$. This is the same rate of convergence than for the periodogram of a stationary process in continuous time (Parzen,

1983) or observed during random times satisfying Masry's conditions (Lii and Masry, 1994). However, in this last case, $T_n \sim C n$ p.s. when $n \to \infty$. Our result, CLT (2.14), is clearly more general (processes having stationary increments and weak condition on the random observation times), but the prize to pay for obtaining the convergence rate $T_n^{-2/5}$ is that $T_n \sim C n^{1-d}$ with $d > \left(\frac{1 + (2H \wedge 1)}{1 + s(2H \wedge 1)}\right) \vee \left(\frac{s + (H \wedge 1)}{s(2 + (H \wedge 1)) - 1}\right)$ i.e. for instance $T_n \sim C n^{\frac{1}{2}}$ for s = 3 and $H \geq 1$, or for $s = \infty$ and H > 0; more details are provided in Table 1).

How to explain that this convergence rate depends on s and H? On the one hand, the smaller H the more irregular the trajectory of X when X is a process having stationary increments (the Hölder parameter of a trajectory of X is then H^+ for all $H^+ < H$). Therefore empirical wavelet coefficients, defined almost as a Riemann sum, approximate better a smooth paths than irregular paths and this explains that the smaller H the smaller the convergence rate of CLT (2.14). In the case of stationary processes, then $H \ge 1$ and the convergence rate does not depends on H. On the other hand, the smaller s the more variable the observed times. Then for each frequency there are not enough successive data with appropriated lag allowing to correctly estimate the spectral density around this frequency. Then the smaller s the smaller the convergence rate of CLT (2.14).

Moreover, under W(m, 3, 1), $\int t^n \psi(t) dt = 0$ for all $n \leq m$ and any wavelet coefficients of any polynomial function with degree less or equal to m are vanished. Therefore, the estimator $\hat{f}_n^{(\lambda_n)}$ is robust since

Corollary 2.2 Under Assumption W(m,3,1) with $m \in \mathbb{N}^*$, Proposition 2.2 holds when a polynomial trend with degree less or equal to m is added to X.

3 Numerical experiments

For the numerical applications, one has chosen:

- 1. ψ is chosen such as $\widehat{\psi}(\xi) = \exp\left(-(|\xi| \cdot (5-|\xi|))^{-1}\right) \mathbf{1}_{|\xi| \leq 5}(\xi)$ which satisfies Assumption W(m,r) for any (m,r) (and $\widehat{\psi}(\xi) = 0$ for $|\xi| \geq 5$).
- 2. $\delta_n = n^{-0.6}$ for insuring the convergence of $\widehat{f}_n^{(\lambda_n)}(\xi)$ for any H > 0 and $s \ge 3$.
- 3. $\lambda_n = n^{d'}$ with 1/6 < d' < 1/2. However, admissibility condition on wavelets (ψ_{λ_n}) requires that $n^{d'} \ge \Lambda = 5$. Moreover, for removing the bias term, d' has to be chosen large enough following n. Thus, after numerous simulations, we have chosen $d' = \log(15)/\log(n)$.

3.1 Estimation of the spectral density of a fractional Brownian motion observed at random times

For a standard $(EX^2(1) = 1)$ fBm with Hurst parameter H, $f(\xi) = C(H)|\xi|^{-2H-1}d\xi$ with $C(H) = (H\Gamma(2H)\sin(\pi H))/\pi$. Three different kind of independent and identically distributed random times are considered:

- (T1): non-random uniform sampling, such that $L_k = 1$ for all $k \in \mathbb{N}^*$;
- **(T2)**: exponential random times, such that $EL_k = 1$ for all $k \in \mathbb{N}^*$;
- (T3): random times such that for for all $k \in \mathbb{N}^*$, the cumulative distribution function of L_k is $F_{L_k}(x) = (1 x^{-4})\mathbf{1}_{x \ge 1} \Longrightarrow \mathbb{E}L_k^p < \infty$ for all p < 4 and $\mathbb{E}L_k^4 = \infty$. In this case Assumption S(s) is satisfied if and only if s < 4.
- (T4): random times such that for for all $k \in \mathbb{N}^*$, the cumulative distribution function of L_k is $F_{L_k}(x) = (1 x^{-2})\mathbf{1}_{x \ge 1} \Longrightarrow \mathbb{E}L_k^p < \infty$ for all p < 2 and $\mathbb{E}L_k^2 = \infty$. In this case Assumption S(s) is satisfied if and only if s < 2. As a consequence, this case does not satisfied the hypothesis of Theorem 2.1.




Fig. 1 An example of the estimation of the spectral density (left) and its logarithm (right) of a FBM observed at exponential random times (T2) with confidence intervals (H = 0.2, N = 50000). Comments on simulation results: 1. the larger N the more accurate the estimator of f except for case of random times T4 (which is a case not included in conditions of Proposition 2.2); 2. The results are similar for T1 and T2, a little less accurate for T3; 3. the smaller H the more accurate the estimator of f.

An example of such estimation of the spectral density for H = 0.2, N = 50000 and random times T2 is presented in Figure 1. The results of simulations are also provided in the Table 2.

3.2 Estimation of the spectral density of the stationary Ornstein-Uhlenbeck process


Here, instead of FBM which is a process having stationary increments, we consider the stationary Ornstein-Uhlenbeck process which is a Gaussian stationary process with covariance $r(t) := \exp(-\alpha|t|)$ and therefore with spectral density $f(\xi) := \alpha \left(\pi(\alpha^2 + \xi^2)\right)^{-1}$. In such case, since this spectral density is an analytic function, there exists more accurate nonparametric estimator (see for instance, Ibragimov, 2004). However, to our knowledge, the case of paths observed at random times is not considered is this literature. The results of simulations are provided in the Table 3.

Comments on simulation results: 1. the larger N the more accurate the estimator of f for all choice of

random time; 2. The results are similar for T1, T2, T3 and a less accurate for T4; 3. surprisingly, the case $\alpha = 1$ is not clearly better than $\alpha = 0.1$ despite the fact that the larger α the less correlated the process.

3.3 Estimation of the spectral density of heartbeat time series




Fig. 3.3 Log-log representation of the spectral density estimator during "Sleep" zone (up), "Quiet" activities (middle) and "Intensive activities" zone (down)

Heartbeats of several working people have been recorded during 24h (see an example in Figure 3.3). These data have been kindly furnished by professor Alain Chamoux and Gil Boudet (Faculty of Medicine, Occupational safety and health, University of Auvergne, Clermont-Ferrand).



Cardiologists are interested in the study of this signal in two frequency bands: the orthosympathetic and parasympathetic bands, i.e., the frequency bands $(0.04\,Hz,\,0.15\,Hz)$ and $(0.15\,Hz,\,0.5\,Hz)$ respectively. The definition of these bands is the outcome of research works, see e.g., Task force of the European Society of Cardiology and the North American Society of Pacing and Electrophysiology (1996), and is based on the fact that the behavior of the energy contained inside these bands would be a relevant indicator on the level of the stress of an individual.


Indeed, for the heart rate, the parasympathetic system is often compared to the brake while the orthosympathetic system would be a nice accelerator; see e.g. Goldberger (2001). At rest there is a permanent braking effect on the heart rate. Any solicitation of the cardiovascular system, any activity initially produces a reduction of parasympathetic brake followed by a gradual involvement of the sympathetic system. These mechanisms are very interesting to watch in many diseases including heart failure, but also rhythm disorders that may fall under one or other of these two effects, monitoring the therapeutic effect of several Medicines including some psychotropic. In the field of physiology such data are crucial for measuring the level of stress induced by physical activity or level of perceived stress, which can be considered as a criterion of overtraining in sport.


We decompose these data in 3 temporal zones following the activity:

- Quiet activities $(t \in [1, 28000] \text{ in seconds});$
- Intensive activities ($t \in [28000, 51400]$ in seconds);
- Sleep $(t \in [60000, 83400])$ in seconds).

Applying the spectral density estimator on those 3 sub-data and plotting its log-log representation for frequencies in [0.02, 1] Hz, we observe that:

- in zone "Sleep" (see Figure 3), only one regression line could be computed for frequencies in [0.04, 0.5] Hz which is the usual spectral interval considered by specialists; in this zone $\widehat{H} \simeq 0.99$;
- in zone "Quiet activities" (respectively "Intensive activities"), (see Figure 3), two regression lines could be drawn for frequencies in [0.04, 0.5] Hz, distinguishing the orthosympathetic and the parasympathetic spectral domains. Using an algorithm computing the "best" two regression lines (see for instance Bardet and Bertrand, 2007b), one obtains that $H \simeq 1.34$ (respectively $H \simeq 1.44$) in the orthosympathetic domain which is [0.04, 0.09] Hz (respectively [0.04, 0.11] Hz) and $H \simeq 0.89$ (respectively $H \simeq 0.79$) in the parasympathetic domain which is [0.09, 0.5] Hz (respectively [0.11, 0.5] Hz).

4 Proofs

4.1 Proofs of useful lemmas and Proposition 2.1

In the sequel, the following lemma will be useful:

Lemma 4.1 Let X be a Gaussian process defined by (1.1) with a spectral density function f satisfying (1.3) or by (1.4) with a spectral density satisfying (1.5). Then there exists a constant $C_0 > 0$ such that

$$|\mathbb{E}(X(t_1)X(t_2))| \le C_0(1+|t_1|)(1+|t_2|) \text{ for all } (t_1,t_2) \in \mathbb{R}^2.$$
 (4.1)

Proof. Firstly, let us consider X defined by (1.1). For all $t \in \mathbb{R}$, by using (1.2), we have

$$\mathbb{E}[X^{2}(t)] = \int_{\mathbb{R}} \left| e^{it\xi} - 1 \right|^{2} f(\xi) d\xi \le 2 \int_{0}^{1} |t\xi|^{2} f(\xi) d\xi + 8 \int_{1}^{\infty} f(\xi) d\xi
\le (2t^{2} + 8) \times \int_{0}^{\infty} (1 \wedge |\xi|^{2}) f(\xi) d\xi.$$

This implies $\mathbb{E}(X(t)^2) \leq C_0 (1+|t|^2)$ where $C_0 = 4 \int_{\mathbb{R}} (1 \wedge |\xi|^2) f(\xi) d\xi$. Then, by using Cauchy-Schwartz inequality, one deduces (4.1). Secondly, consider X defined by (1.4), then (1.2) and (1.5) imply that

$$|I\!\!E(X(t_1)X(t_2))| = \left| \int_{I\!\!R} e^{i(t_1-t_2)\xi} f(\xi) \, d\xi \right| \le \int_{I\!\!R} f(\xi) \, d\xi < \infty.$$

Therefore (4.1) is satisfied with $C_0 = \int_{\mathbb{R}} f(\xi) d\xi$. This finishes the proof of Lemma 4.1.

Proof. [of Proposition 2.1] We just give the proof for Gaussian processes defined by (1.1) with a spectral density function f satisfying (1.3). The key property, which explains that the same representation formula holds for Gaussian processes defined by (1.1) or (1.4), is Formula (4.2). Moreover, since Condition (1.5) implies Condition (1.3), all the convergence results remain valid under Condition (1.5).

Let X be defined by (1.1). Firstly, one can show that for all a > 0 and $b \in \mathbb{R}$, $\mathbb{E}\left[\left|d_X(a,b)\right|^2\right] < \infty$. This induces that $d_X(a,b)$ is well defined. Indeed, since X is a real valued process, one has

$$\mathbb{E}\left[\left|d_{X}(a,b)\right|^{2}\right] = \frac{1}{a} \int_{\mathbb{R}} \int_{\mathbb{R}} \psi\left(\frac{t_{1}-b}{a}\right) \overline{\psi\left(\frac{t_{2}-b}{a}\right)} \mathbb{E}\left(X(t_{1})X(t_{2})\right) dt_{1} dt_{2}$$

$$\leq \frac{C_{0}}{a} \int_{\mathbb{R}} \int_{\mathbb{R}} \left|\psi\left(\frac{t_{1}-b}{a}\right)\right| \left|\psi\left(\frac{t_{2}-b}{a}\right)\right| (1+|t_{1}|)(1+|t_{2}|) dt_{1} dt_{2}$$

$$\leq a C_{0} \left(\int_{\mathbb{R}} |\psi(u)| (1+|b|+|a u|) du\right)^{2} < \infty,$$

where we have used successively the bound (4.1), the change of variable u = (t - b)/a and the second condition of Assumption W(1,1,0). Next, one turns to the proof of the representation formula (2.1). Firstly, recall that the stochastic of a complex valued function $g = g_1 + ig_2$ against a complex Gaussian measure W with real part W_1 and imaginary part W_2 is defined by

$$\int_{\mathbb{R}} g(x) \, dW(x) = \int_{\mathbb{R}} g_1(x) \, dW_1(x) - \int_{\mathbb{R}} g_2(x) \, dW_2(x)$$

and that W_1 and W_2 are Wiener measures, see [31, (7.2.8) p.326]. Now, consider any interval $[\alpha, A] \subset]0, \infty[$, the function f is bounded on $[\alpha, A]$ and $\int_{\mathbb{R}} \left| \psi\left(\frac{t-b}{a}\right) \right| \, dt = a \int_{\mathbb{R}} |\psi(u)| \, du < \infty$. Therefore, one can

apply the Fubini-type Theorem for stochastic integral (see [20, Lemma 4.1, p. 116]) to the two integrals corresponding to the real and the imaginary part, then by summing up, we get

$$\int_{\alpha}^{A} \left[\int_{\mathbb{R}} \left(e^{it\xi} - 1 \right) \cdot \psi \left(\frac{t-b}{a} \right) \, dt \right] \, f^{1/2}(\xi) \, dW(\xi) \quad = \quad \int_{\mathbb{R}} \psi \left(\frac{t-b}{a} \right) \left[\int_{\alpha}^{A} \left(e^{it\xi} - 1 \right) \cdot f^{1/2}(\xi) \, dW(\xi) \right] \, dt$$

Since $\int_{\mathbb{R}} \psi(u) du = 0$, for all couple $(a, b) \in]0, \infty[\times \mathbb{R}]$, we have

$$\int_{\mathbb{R}} \left(e^{it\xi} - 1 \right) \psi \left(\frac{t - b}{a} \right) dt = \int_{\mathbb{R}} e^{it\xi} \psi \left(\frac{t - b}{a} \right) dt = a e^{ib\xi} \overline{\widehat{\psi}}(a\xi). \tag{4.2}$$

Thus, for all couple $(a, b) \in]0, \infty[\times \mathbb{R}]$ we have

$$a \int_{\alpha}^{A} e^{ib\xi} \, \overline{\widehat{\psi}}(a\xi) \, f^{1/2}(\xi) \, dW(\xi) = \int_{\mathbb{R}} \psi\left(\frac{t-b}{a}\right) \left[\int_{\alpha}^{A} \left(e^{it\xi} - 1\right) \cdot f^{1/2}(\xi) \, dW(\xi)\right] \, dt \tag{4.3}$$

From the one hand, the firs condition of W(1, 1, 0) and (1.3) imply that $\int_0^\infty \left| \widehat{\psi}(a\xi) \right|^2 f(\xi) d\xi < \infty$. Therefore, one can deduce that for any sequence of couples (α_n, A_n) converging to $(0, \infty)$, the sequence $\int_{\alpha_n}^{A_n} e^{iab\xi} \, \overline{\widehat{\psi}}(a\xi) \, f^{1/2}(\xi) \, dW(\xi)$ converges in $L^2(\Omega)$. From the other hand,

$$\int_{\mathbb{R}} \psi\left(\frac{t-b}{a}\right) \left[\int_{\alpha_n}^{A_n} \left(e^{it\xi} - 1\right) \cdot f^{1/2}(\xi) \, dW(\xi) \right] dt$$

converges also in $L^2(\Omega)$, because

$$\mathbb{E}\left|\int_{\mathbb{R}}\psi\left(\frac{t-b}{a}\right)\left[\int_{0}^{\infty}\left(e^{it\xi}-1\right)\cdot f^{1/2}(\xi)\,dW(\xi)\right]\,dt\right|^{2}<\infty.$$

Indeed, firstly, by using Cauchy-Schwarz inequality, we get that

$$\left| \int_{0}^{\infty} \left(e^{it_{1}\xi} - 1 \right) \cdot \left(e^{-it_{2}\xi} - 1 \right) f(\xi) d\xi \right| \leq \left(\int_{0}^{\infty} \left| e^{it_{1}\xi} - 1 \right|^{2} f(\xi) d\xi \right)^{1/2} \times \left(\int_{0}^{\infty} \left| e^{it_{2}\xi} - 1 \right|^{2} f(\xi) d\xi \right)^{1/2} \\ \leq \left(\int_{0}^{1} \left| t_{1}\xi \right|^{2} f(\xi) d\xi + 4 \int_{1}^{\infty} f(\xi) d\xi \right)^{1/2} \times \left(\int_{0}^{1} \left| t_{2}\xi \right|^{2} f(\xi) d\xi + 4 \int_{1}^{\infty} f(\xi) d\xi \right)^{1/2} \\ \leq \left((4 + t_{1}^{2}) \int_{\mathbb{R}} \left(1 \wedge |\xi|^{2} \right) \cdot f(\xi) d\xi \right)^{1/2} \times \left((4 + t_{2}^{2}) \int_{\mathbb{R}} \left(1 \wedge |\xi|^{2} \right) \cdot f(\xi) d\xi \right)^{1/2} \\ \leq (2 + t_{1}) \times (2 + t_{2}) \times \int_{\mathbb{R}} \left(1 \wedge |\xi|^{2} \right) \cdot f(\xi) d\xi.$$

Next, by using the isometry property (1.2), we get the following upper bound

$$\begin{split} E \left| \int_{\mathbb{R}} \psi \left(\frac{t-b}{a} \right) \left[\int_{0}^{\infty} \left(e^{it\xi} - 1 \right) \cdot f^{1/2}(\xi) \, dW(\xi) \right] \, dt \right|^{2} \\ &= \int_{\mathbb{R}} \int_{\mathbb{R}} \psi \left(\frac{t_{1}-b}{a} \right) \, \overline{\psi \left(\frac{t_{2}-b}{a} \right)} \left(\int_{0}^{\infty} \left(e^{it_{1}\xi} - 1 \right) \cdot \left(e^{-it_{2}\xi} - 1 \right) \, f(\xi) \, d\xi \right) \, dt_{1} \, dt_{2} \\ &\leq \left(\int_{\mathbb{R}} \left(1 \wedge |\xi|^{2} \right) \cdot f(\xi) \, d\xi \right) \times \int_{\mathbb{R}} \int_{\mathbb{R}} \psi \left(\frac{t_{1}-b}{a} \right) \, \overline{\psi \left(\frac{t_{2}-b}{a} \right)} (2+t_{1}) \times (2+t_{2}) \, dt_{1} \, dt_{2} \\ &= \left(\int_{\mathbb{R}} \left(1 \wedge |\xi|^{2} \right) \cdot f(\xi) \, d\xi \right) \times \left(\int_{\mathbb{R}} (2+t) \, \left| \psi \left(\frac{t-b}{a} \right) \right| \, dt \right)^{2} \\ &< \infty, \end{split}$$

where the last bound follows from Condition (1.3) and Condition W(1, 1, 0)). Eventually, one can pass to the limit in (4.3) which provides

$$a \int_0^\infty e^{ib\xi} \, \overline{\widehat{\psi}}(a\xi) \, f^{1/2}(\xi) \, dW(\xi) = \int_{\mathbb{R}} \psi\left(\frac{t-b}{a}\right) \left[\int_0^\infty \left(e^{it\xi} - 1\right) \cdot f^{1/2}(\xi) \, dW(\xi) \right] \, dt.$$

But similar calculations would lead to the same result between the bounds $-\infty$ and 0. By adding the two integrals between 0 and ∞ and between $-\infty$ and 0, one can obtain

$$a \int_{\mathbb{R}} e^{ib\xi} \, \overline{\hat{\psi}}(a\xi) \, f^{1/2}(\xi) \, dW(\xi) = \int_{\mathbb{R}} \psi\left(\frac{t-b}{a}\right) \left[\int_{\mathbb{R}} \left(e^{it\xi} - 1\right) \cdot f^{1/2}(\xi) \, dW(\xi)\right] \, dt$$
$$= \int_{\mathbb{R}} \psi\left(\frac{t-b}{a}\right) \, X(t) \, dt$$

which implies (2.1). Afterwards, formula (2.1) implies that for all a > 0, $b \in \mathbb{R}$, $d_X(a,b)$ is a Gaussian centered random variable with variance $\mathcal{I}_1(a)$. Moreover, for all a > 0 and $(b_1, b_2) \in \mathbb{R}^2$, we have

$$I\!\!E\left(d_X(a,b_1)\,\overline{d_X(a,b_2)}\right) = a \int_{\mathbb{R}} e^{ia(b_1-b_2)\xi} \left|\hat{\psi}(a\xi)\right|^2 f(\xi) \,d\xi$$

Thus for a given a > 0, $\mathbb{E}(d_X(a, b_1) d_X(a, b_2))$ is only depending on $(b_1 - b_2)$ which induces that $(d_X(a, b))_{b \in \mathbb{R}}$ is a stationary process. This finishes the proof of Proposition 2.1.

¿From formula (2.1), it is clear that for all $(a_1, a_2) \in (0, \infty)^2$ and for all $(b_1, b_2) \in \mathbb{R}^2$,

$$\mathbb{E}(d_X(a_1,b_1)\cdot\overline{d_X(a_2,b_2)}) = \sqrt{a_1a_2}\cdot\gamma(b_2-b_1,a_1,a_2)$$

where

$$\gamma(\theta, a_1, a_2) := \int_{\mathbb{R}} e^{i\theta\xi} \, \widehat{\psi}(a_1\xi) \, \overline{\widehat{\psi}(a_2\xi)} \, f(\xi) \, d\xi. \tag{4.4}$$

When (a_1, a_2) are positive numbers, the function γ and its first derivative with respect to θ can be bounded:

Lemma 4.2 Under Assumption W(1,0,1/2) and if f satisfies (1.3) and Assumption F(H) with H > 0:

- 1. for all $(a_1, a_2) \in (0, \infty)^2$, there exists C > 0 not depending on θ such that, $|\gamma(\theta, a_1, a_2)| < C(1 \wedge |\theta|^{-1})$ for all $\theta \in \mathbb{R}$.
- 2. the function γ is derivable with respect to θ and for all $(a_1, a_2) \in (0, \infty)^2$, there exists C > 0 not depending on θ such that, $|\gamma'(\theta, a_1, a_2)| := \left|\frac{\partial \gamma}{\partial \theta}(\theta, a_1, a_2)\right| \leq C'(1 \wedge |\theta|^{-1})$ for all $\theta \in \mathbb{R}$.

Proof. [of Lemma 4.2] Firstly, from Assumption W(1, 0, 0) (induced by Assumption W(1, 0, 1/2)), there exists a constant c > 0 such that

$$|\widehat{\psi}(\xi)| \le c \left(1 \wedge |\xi|^2\right) \quad \text{for all} \quad \xi \in \mathbb{R}.$$
 (4.5)

Indeed, from one hand, $|\widehat{\psi}(\xi)| \leq ||\psi||_{L^1(\mathbb{R})} < \infty$. From the other hand, $\psi \in W(1,0,0)$ implies that $\widehat{\psi}$ is twice continuously differentiable and $\widehat{\psi}(0) = \widehat{\psi}'(0) = 0$. From Taylor-Lagrange Formula, for all $\xi \in \mathbb{R}^*$, there exists $\xi_0 \in \mathbb{R}$ with $|\xi_0| \leq |\xi|$ such that $\widehat{\psi}(\xi) = \frac{1}{2} \xi^2 \times \widehat{\psi}''(\xi_0)$. This induces $|\widehat{\psi}(\xi)| \leq \frac{1}{2} |\xi|^2 \times \left(\int_{\mathbb{R}} t^2 |\psi(t)| dt\right)$ providing the second bound of (4.5).

Secondly, we show the first item. Inequality (4.5) implies that

$$\int_{\mathbb{R}} \left| \overline{\widehat{\psi}}(a\xi) \right|^2 f(\xi) d\xi \leq c^2 \left(\int_{|\xi| \le 1} |a\xi|^4 f(\xi) d\xi + \int_{|\xi| > 1} f(\xi) d\xi \right) \\
\leq c^2 (1 \vee a^4) \int_{\mathbb{R}} (1 \wedge \xi^2) f(\xi) d\xi < C,$$

with C > 0 not depending on θ . From Cauchy-Schwarz Inequality,

$$\gamma(\theta, a_1, a_2) \le c^2 \left(1 \vee a_1^2\right) \left(1 \vee a_2^2\right) \int_{\mathbb{R}} \left(1 \wedge \xi^2\right) f(\xi) \, d\xi.$$

Combined with (1.3), this means that $\gamma(\theta, a_1, a_2)$ is bounded by a constant. Moreover, with $f(\omega_k^+)$ and $f(\omega_k^-)$ denoting the right and left limits of f at ω_k , for all $1 \le k \le K - 1$, $\theta \in \mathbb{R}^*$ and $(a_1, a_2) \in (0, \infty)^2$,

$$\int_{\omega_{k}}^{\omega_{k+1}} e^{i\theta\xi} \overline{\widehat{\psi}}(a_{1}\xi) \,\widehat{\psi}(a_{2}\xi) \,f(\xi) \,d\xi
= \frac{1}{i\theta} \left(e^{i\theta\omega_{k+1}} f(\omega_{k+1}^{-}) \overline{\widehat{\psi}}(a_{1}\omega_{k+1}) \widehat{\psi}(a_{2}\omega_{k+1}) - e^{i\theta\omega_{k}} f(\omega_{k}^{+}) \overline{\widehat{\psi}}(a_{1}\omega_{k}) \widehat{\psi}(a_{2}\omega_{k}) \right)
- \int_{\omega_{k}}^{\omega_{k+1}} \frac{e^{i\theta\xi}}{i\theta} \left[f'(\xi) \overline{\widehat{\psi}}(a_{1}\xi) \widehat{\psi}(a_{2}\xi) + f(\xi) \left(a_{1} \overline{\widehat{\psi'}}(a_{1}\xi) \widehat{\psi}(a_{2}\xi) + a_{2} \overline{\widehat{\psi}}(a_{1}\xi) \widehat{\psi'}(a_{2}\xi) \right) \right] d\xi.$$

The same result remains in force for k = 0 and k = K. Indeed, by using (4.5) combined with Assumption F(H), one deduces that for all $\theta \in \mathbb{R}$ and $(a_1, a_2) \in (0, \infty)^2$,

$$\lim_{\xi \to 0} e^{i\theta\xi} f(\xi) \, \overline{\widehat{\psi}}(a_1 \xi) \, \widehat{\psi}(a_2 \xi) = 0 \qquad \text{and} \qquad \lim_{\xi \to \infty} e^{i\theta\xi} f(\xi) \, \overline{\widehat{\psi}}(a_1 \xi) \, \widehat{\psi}(a_2 \xi) = 0.$$

Moreover, since f is an even function,

$$\begin{split} \int_{-\omega_{k+1}}^{-\omega_{k}} e^{i\theta\xi} \overline{\widehat{\psi}}(a_{1}\xi) \, \widehat{\psi}(a_{2}\xi) \, f(\xi) \, dx \\ &= \frac{1}{i\theta} \left(e^{-i\theta\omega_{k}} f(\omega_{k}^{+}) \overline{\widehat{\psi}}(-a_{1}\omega_{k}) \widehat{\psi}(-a_{2}\omega_{k}) - e^{i\theta\omega_{k+1}} f(\omega_{k+1}^{-}) \overline{\widehat{\psi}}(a_{1}\omega_{k}) \widehat{\psi}(a_{2}\omega_{k}) \right) \\ &- \int_{-\omega_{k+1}}^{-\omega_{k}} \frac{e^{i\theta\xi}}{i\theta} \left[f'(\xi) \overline{\widehat{\psi}}(a_{1}\xi) \widehat{\psi}(a_{2}\xi) + f(\xi) \left(a_{1} \overline{\widehat{\psi}'}(a_{1}\xi) \widehat{\psi}(a_{2}\xi) + a_{2} \overline{\widehat{\psi}}(a_{1}\xi) \widehat{\psi'}(a_{2}\xi) \right) \right] d\xi. \end{split}$$

Thus, by summing up and using Assumption F(H), for all $\theta \in \mathbb{R}$ and $(a_1, a_2) \in (0, \infty)^2$,

$$\gamma(\theta, a_1, a_2) = \sum_{k=0}^{K} \int_{\omega_k}^{\omega_{k+1}} e^{i\theta\xi} \overline{\widehat{\psi}}(a_1\xi) \, \widehat{\psi}(a_2\xi) \, f(\xi) \, dx + \sum_{k=0}^{K} \int_{-\omega_{k+1}}^{-\omega_k} e^{i\theta\xi} \overline{\widehat{\psi}}(a_1\xi) \, \widehat{\psi}(a_2\xi) \, f(\xi) \, dx$$

$$= -\frac{1}{i\theta} \sum_{k=1}^{K} \left(e^{i\theta\omega_k} \overline{\widehat{\psi}}(a_1\omega_k) \widehat{\psi}(a_2\omega_k) - e^{-i\theta\omega_k} \overline{\widehat{\psi}}(-a_1\omega_k) \widehat{\psi}(-a_2\omega_k) \right) \left(f(\omega_k^+) - f(\omega_k^-) \right)$$

$$= -\frac{1}{i\theta} \int_{\mathbb{R}} e^{i\theta\xi} \left[f'(\xi) \overline{\widehat{\psi}}(a_1\xi) \, \widehat{\psi}(a_2\xi) + f(\xi) \left(a_1 \overline{\widehat{\psi}'}(a_1\xi) \widehat{\psi}(a_2\xi) + a_2 \overline{\widehat{\psi}}(a_1\xi) \widehat{\psi'}(a_2\xi) \right) \right] d\xi$$

since the integral of the r.h.s. of the previous equality is well defined. Then,

$$|\gamma(\theta, a_1, a_2)| \leq \frac{1}{|\theta|} \Big(2c \sum_{k=1}^K \left| f(\omega_k^+) - f(\omega_k^-) \right|$$

$$+ \int_{\mathbb{R}} \left[\left| f'(\xi) \overline{\widehat{\psi}}(a_1 \xi) \widehat{\psi}(a_2 \xi) \right| + |f(\xi)| \Big(|a_1| \left| \overline{\widehat{\psi}'}(a_1 \xi) \widehat{\psi}(a_2 \xi) \right| + |a_2| \left| \overline{\widehat{\psi}}(a_1 \xi) \widehat{\psi}'(a_2 \xi) \right| \right) \right] d\xi \Big).$$

It remains to show the convergence of the previous integral. Using the same trick as in Formula (4.5), under Assumption W(1,0,0), $|\widehat{\psi}'(\xi)| \leq c' (1 \wedge |\xi|)$ with c' not depending on ξ . So, for all $(a_1, a_2) \in (0, \infty)^2$

$$\int_{\mathbb{R}} \left[\left| f'(\xi) \overline{\widehat{\psi}}(a_{1}\xi) \widehat{\psi}(a_{2}\xi) \right| + \left| f(\xi) \right| \left(|a_{1}| |\overline{\widehat{\psi'}}(a_{1}\xi) \widehat{\psi}(a_{2}\xi) | + |a_{2}| |\overline{\widehat{\psi}}(a_{1}\xi) \widehat{\psi'}(a_{2}\xi) | \right) \right] d\xi
\leq C_{1} a_{1}^{2} a_{2}^{2} \int_{|\xi| \leq 1} \left| f'(\xi) |\xi^{4} + 2| f(\xi) \xi^{3} | d\xi + C_{2} \int_{|\xi| > 1} \left| f'(\xi) | + (|a_{1}| + |a_{2}|) | f(\xi) | d\xi
\leq C \int_{\mathbb{R}} \left[\left(1 \wedge |\xi|^{4} \right) \cdot |f'(\xi)| + \left(1 \wedge |\xi|^{3} \right) \cdot |f(\xi)| \right] d\xi$$

where C > 0 depends on c, c', a_1 and a_2 . But since $(1 \wedge |\xi|^4) \leq (1 \wedge |\xi|^3)$ and $(1 \wedge |\xi|^3) \leq (1 \wedge |\xi|^2)$, then from Assumption F(H), $\int_{\mathbb{R}} (1 \wedge |\xi|^4) \cdot |f'(\xi)| < \infty$ and $\int_{\mathbb{R}} (1 \wedge |\xi|^3) \cdot |f(\xi)| < \infty$ and this completes the proof of the first item. Eventually, one proves the second item. The differentiability is obvious and

$$\gamma'(\theta, a_1, a_2) = i \int_{\mathbb{R}} e^{i\theta\xi} \xi \, \overline{\widehat{\psi}}(a_1\xi) \, \widehat{\psi}(a_2\xi) \, f(\xi) \, d\xi.$$

Assumption W(1,0,1/2) implies that for all a > 0, $|a\xi|^{1/2}|\widehat{\psi}(a\xi)| \leq C_{\psi}$ for all $\xi \in \mathbb{R}$. Combined with (4.5), this induces that for all a > 0 and $\theta \in \mathbb{R}$,

$$\begin{aligned} |\varphi'(\theta, a_1, a_2)| &\leq \int_{\mathbb{R}} |\xi| \, |\widehat{\psi}(a_1 \xi)| \, |\widehat{\psi}(a_2 \xi)| \, f(\xi) \, d\xi \\ &\leq c^2 (a_1 \, a_2)^2 \int_{|\xi| \leq 1} |\xi|^5 \, f(\xi) \, d\xi + \frac{C_{\psi}^2}{\sqrt{a_1 \, a_2}} \int_{|\xi| > 1} f(\xi) \, d\xi \\ &\leq C, \end{aligned}$$

with C > 0 not depending on θ . Using the same arguments as above, for all $\theta \in \mathbb{R}^*$ and $(a_1, a_2) \in (0, \infty)^2$,

$$\gamma'(\theta, a_1, a_2) = -\frac{1}{\theta} \sum_{k=1}^{K} \left(e^{i\theta\omega_k} \omega_k \overline{\widehat{\psi}}(a_1\omega_k) \widehat{\psi}(a_2\omega_k) + e^{-i\theta\omega_k} \omega_k \overline{\widehat{\psi}}(-a_1\omega_k) \widehat{\psi}(-a_2\omega_k) \right) \left(f(\omega_k^+) - f(\omega_k^-) \right)$$

$$- \frac{1}{\theta} \int_{\mathbb{R}} e^{i\theta\xi} \left[f(\xi) \overline{\widehat{\psi}}(a_1\xi) \widehat{\psi}(a_2\xi) + \xi f'(\xi) \overline{\widehat{\psi}}(a_1\xi) \widehat{\psi}(a_2\xi) + \xi f'(\xi) \overline{\widehat{\psi}}(a_1\xi) \widehat{\psi}(a_2\xi) + \xi f'(\xi) \overline{\widehat{\psi}}(a_1\xi) \widehat{\psi}(a_2\xi) \right] d\xi$$

and therefore $|\gamma'(\theta, a_1, a_2)| \leq \frac{C}{|\theta|}$, with C > 0 not depending on θ . This finishes the proof.

4.2 Asymptotic behavior of sample variances of wavelet coefficients for continuous time processes

Since $\mathcal{I}_1(a)$ is obviously defined from $|d_X(a,b)|^2$, we begin with the study of

$$I_n(a) := \frac{1}{n+1} \sum_{k=0}^n |d_X(a, c_k)|^2, \quad \text{for } a > 0 \text{ and } n \in \mathbb{N}^*.$$
 (4.6)

For $n \in \mathbb{N}^*$ and a > 0, define also:

$$S_n^2(a) := \frac{2a^2}{(n+1)^2} \sum_{k=0}^n \sum_{\ell=0}^n \left| \int_{\mathbb{R}} e^{i\left(\mathbb{E}(c_k - c_\ell)\right)\xi} \left| \widehat{\psi}(a\xi) \right|^2 f(\xi) \, d\xi \right|^2. \tag{4.7}$$

Note that S_n depends on $\mathbb{E}(c_k - c_\ell)$ and therefore its formula is valid when (c_k) are r.v. However, we begin by proving the following proposition in the case of deterministic (c_k) and of course $\mathbb{E}(c_k - c_\ell)$ can be replaced by $c_k - c_\ell$ in (4.7).

Proposition 4.1 Let X be a Gaussian process defined by (1.1) or (1.4) with a spectral density f satisfying (1.3), ψ satisfying Assumption W(1,1,1/2). Then if $(c_k)_k$ is a family of real numbers such that $c_1 < c_2 < \ldots < c_n$, $n \max_{1 \le k \le n} \{c_{k+1} - c_k\} \underset{n \to \infty}{\longrightarrow} \infty$ and there exists a constant C'' > 0 such that for all $n \in \mathbb{N}^*$

$$\max_{1 \le k \le n} \{c_{k+1} - c_k\} \le C'' \min_{1 \le k \le n} \{c_{k+1} - c_k\} < \infty$$

then $\forall a > 0$,

$$\frac{1}{S_n(a)} \left(I_n(a) - \mathcal{I}_1(a) \right) \xrightarrow[n \to \infty]{\mathcal{D}} \mathcal{N}(0, 1). \tag{4.8}$$

Moreover, there exist $0 < C_m < C_M$ not depending on n such that $\forall n \in N^*$,

$$C_m \le S_n(a) \left(n \max_{1 \le k \le n} \{ c_{k+1} - c_k \} \right)^{1/2} \le C_M.$$
 (4.9)

The proof of Proposition 4.1 relies on Lemma 4.2 and the following Lemma which is a Lindeberg CLT (see a proof in Istas and Lang, 1997):

Lemma 4.3 Let $(Y_{N,i})_{1 \leq i \leq N, N \in \mathbb{N}^*}$ be a triangular array of zero-mean Gaussian r.v. Define $S_N^2 := var(V_N)$ with $V_N := \sum_{i=1}^N Y_{N,i}^2$ and $\beta_N := \max_{1 \leq i \leq N} \sum_{j=1}^N |cov(Y_{N,i}, Y_{N,j})|$. If $\lim_{N \to \infty} \frac{\beta_N}{S_N} = 0$, then $S_N^{-1}(V_N - \mathbb{E}(V_N))$ converges weakly to a standard Gaussian random variable.

Proof. [of Proposition 4.1]

Consider $Y_{n,i} = (n+1)^{-1/2} d_X(a, c_i)$ for i = 0, ..., n and

$$\begin{cases} \beta_n = (n+1)^{-1} \max_{1 \le i \le n} \left\{ \sum_{j=0}^n |\operatorname{cov} \left(d_X(a, c_i), d_X(a, c_j) \right)| \right\}, \\ S_n^2 = (n+1)^{-2} \sum_{i=0}^n \sum_{j=0}^n \operatorname{cov} \left(d_X^2(a, c_i), d_X^2(a, c_j) \right) \end{cases}$$

But, by using Formula (4.4), $\forall (a, a_1, a_2) \in (0, \infty[^3, (b_1, b_2) \in \mathbb{R}^2)$

$$\operatorname{cov} (d_X(a, b_1), d_X(a, b_2)) = a \gamma (b_1 - b_2, a, a)$$

$$\operatorname{cov} (d_X^2(a_1, b_1), d_X^2(a_2, b_2)) = 2 (a_1 a_2) \gamma^2 (b_1 - b_2, a_1, a_2),$$

since variables $d_X(a,b)$ are zero-mean Gaussian r.v. Therefore,

$$\begin{cases} \beta_n = a (n+1)^{-1} \max_{0 \le i \le n} \left\{ \sum_{j=0}^n |\gamma(c_i - c_j, a, a)| \right\} \\ S_n^2 = 2 a^2 (n+1)^{-2} \sum_{i=0}^n \sum_{j=0}^n \gamma^2(c_i - c_j, a, a) \end{cases}.$$

Let p and q be such that 1/p + 1/q = 1 with $(p,q) \in (1,\infty)^2$. Then the Hölder Inequality implies that

$$\beta_n \leq C a n^{1/q-1} \times \max_{0 \leq i \leq n} \left\{ \left(\sum_{j=0}^n \left| \gamma(c_i - c_j, a, a) \right|^p \right)^{1/p} \right\}.$$

Lemma 4.2 1) implies that for every $1 \le i \le n$, for n large enough,

$$\sum_{j=0}^{n} \left| \gamma \left(c_{i} - c_{j}, a, a \right) \right|^{p} \leq C \left(\# \left\{ 0 \leq j \leq n, \left| c_{i} - c_{j} \right| \leq 1 \right\} + \sum_{j=0}^{n} \left| c_{i} - c_{j} \right|^{-p} \mathbf{1}_{\left| c_{i} - c_{j} \right| > 1} \right)
\leq C \left(\# \left\{ 0 \leq j \leq n, \left| i - j \right| \min_{0 \leq k \leq n-1} \left| c_{k+1} - c_{k} \right| \leq 1 \right\}
+ \sum_{j=0}^{n} \left[\left| i - j \right| \min_{0 \leq k \leq n-1} \left| c_{k+1} - c_{k} \right| \right]^{-p} \mathbf{1}_{\left| i - j \right| \max_{0 \leq k \leq n-1} \left| c_{k+1} - c_{k} \right| > 1} \right)$$
(4.10)

$$\leq 2C \left(\min_{0 \leq k \leq n-1} \left| c_{k+1} - c_k \right| \right)^{-1} \left(1 + \left(\min_{0 \leq k \leq n-1} \left| c_{k+1} - c_k \right| \right)^{1-p} \sum_{\ell \geq (\max_{0 \leq k \leq n-1} \left| c_{k+1} - c_k \right|)^{-1}} |\ell|^{-p} \right).$$
(4.11)

Since p > 1, $\sum_{\ell=1}^{\infty} |\ell|^{-p} < \infty$ is finite and thus

$$\sum_{\ell \ge (\max_{0 \le k \le n-1} |c_{k+1} - c_k|)^{-1}} |\ell|^{-p} \le \frac{1}{p-1} \left(\max_{0 \le k \le n-1} |c_{k+1} - c_k| \right)^{p-1} \le \frac{C''}{p-1} \left(\min_{0 \le k \le n-1} |c_{k+1} - c_k| \right)^{p-1},$$

since by definition $\max_{1 \le k \le n} \{c_{k+1} - c_k\} \le C'' \min_{1 \le k \le n} \{c_{k+1} - c_k\} < \infty$. Therefore,

$$\beta_n \le C a \left\{ n \times \min_{0 \le k \le n-1} |c_{k+1} - c_k| \right\}^{-1/p},$$
 (4.12)

with C>0 not depending on n. Now, a lower bound for S_n^2 is required. For all a>0, $\theta\in\mathbb{R}\mapsto\gamma(\theta,a,a)$ is a continuous map and $\gamma(0,a,a)=\int_{\mathbb{R}}\left|\widehat{\psi}(a\xi)\right|^2f(\xi)\,d\xi>0$. Therefore, for all a>0, there exists $\theta_a>0$ such that $\gamma(\theta,a,a)\geq\frac{1}{2}\gamma(0,a,a)$ when $|\theta|\leq\theta_a$. Then,

$$S_{n}^{2}(a) \geq C_{1}' a^{2} n^{-2} \gamma^{2}(0, a, a) \# \left\{ 0 \leq i, j \leq n, \left| c_{i} - c_{j} \right| \leq \theta_{a} \right\}$$

$$\geq C_{1}' a^{2} n^{-2} \gamma^{2}(0, a, a) \# \left\{ 0 \leq i, j \leq n, \left| i - j \right| \max_{0 \leq k \leq n-1} \left| c_{k+1} - c_{k} \right| \leq \theta_{a} \right\}$$

$$\geq C_{1}' a^{2} n^{-2} \gamma^{2}(0, a, a) \frac{n}{2} \left(\left(\theta_{a} \max_{0 \leq k \leq n-1} \left| c_{k+1} - c_{k} \right| \right)^{-1} \wedge (n-1) \right),$$

since for $\mu > 0$, $\# \Big\{ 0 \le i, j \le n, |i-j| \le \mu \Big\} = 2 \sum_{k=0}^{[\mu] \wedge (n-1)} n - k \ge 2 \Big([\mu] \wedge (n-1) \Big) \frac{n}{2}$. Thus, since from assumptions $n \max_{0 \le k \le n-1} |c_{k+1} - c_k| \longrightarrow_{n \to \infty} \infty$, there exists $C_M > 0$ such that for n large enough:

$$S_n^2(a) \ge C_M \left(n \max_{0 \le k \le n-1} \left| c_{k+1} - c_k \right| \right)^{-1}. \tag{4.13}$$

Now, from (4.12) and (4.13),

$$\frac{\beta_n}{S_n} \le C \, n^{1/2 - 1/p} \Big(\max_{0 \le k \le n - 1} |c_{k+1} - c_k| \Big)^{1/2} \, \Big(\min_{0 \le k \le n - 1} |c_{k+1} - c_k| \Big)^{-1/p}.$$

Therefore $\beta_n/S_n \leq C \left(n \max_{0 \leq k \leq n-1} \left| c_{k+1} - c_k \right| \right)^{1/2 - 1/p}$ with C > 0. Next for any $p \in (1, 2)$,

 $\lim_{n\to\infty}\left(n\max_{0\leq k\leq n-1}\left|c_{k+1}-c_k\right|\right)^{1/2-1/p}=0 \text{ and thus, } \lim_{n\to\infty}\beta_n/S_n=0 \text{ and assumptions of Lemma 4.3 are fulfilled.}$

Finally, from (4.13), $S_n^2(a) \ge C_M \left(n \max_{0 \le k \le n-1} \left| c_{k+1} - c_k \right| \right)^{-1}$ with $C_M > 0$ for n large enough. Moreover, using the bound (4.11) for p=2 and the lines after (4.11),

$$\sum_{j=0}^{n} \gamma^{2} (c_{i} - c_{j}, a, a) \leq C \left(\min_{0 \leq k \leq n-1} |c_{k+1} - c_{k}| \right)^{-1}$$

$$\implies S_{n}^{2}(a) \leq C' a^{2} n^{-2} \sum_{i=0}^{n} \sum_{j=0}^{n} \gamma^{2} (c_{i} - c_{j}, a, a) \leq C_{m} \left(n \max_{0 \leq k \leq n-1} |c_{k+1} - c_{k}| \right)^{-1}.$$

Therefore, inequalities (4.9) are proved.

Proposition 4.2 Let X be a Gaussian process defined by (1.1) or (1.4) with a spectral density f satisfying (1.3), ψ satisfying Assumption W(1,1,r) with r > 1/2. Then if $(c_k)_k$ is a family of r.v. independent to \mathcal{F}_X such that $c_k = c_0 + \frac{k}{n}(c_n - c_0)$, with

$$n^{\frac{1}{2r}-1} \mathbb{E}(c_n - c_0) \underset{n \to \infty}{\longrightarrow} 0, \quad \frac{\mathbb{E}(c_n - c_0)}{\log n} \underset{n \to \infty}{\longrightarrow} \infty \quad and \quad var(c_n - c_0) \underset{n \to \infty}{\longrightarrow} 0.$$

Then (4.8) holds with

$$\lim_{n \to \infty} \left(\mathbb{E}(c_n - c_0) \right) S_n^2(a) = 4\pi \, a^2 \int_{\mathbb{R}} \left| \widehat{\psi}(az) \right|^4 f^2(z) \, dz. \tag{4.14}$$

Remark 4.1 For $(c_k)_k$ satisfying (2.5), under Assumption S(2), Proposition 4.2 holds when $n^{1/2} \delta_n \longrightarrow 0$ because $\mathbb{E}|T_n - \mathbb{E}T_n|^2 \le n \, \delta_n^2 \, \max_{1 \le k \le n} \mathbb{E}L_k$.

[of Proposition 4.2] The sequence of r.v. $(c_k)_{0 \le k \le n}$ is independent to \mathcal{F}_X . Therefore, $(d_X(a,c_k))_{0\leq k\leq n}$ as the same distribution than $(d_X(a,c_k-c_0))_{0\leq k\leq n}$. Indeed for a sequence of deterministic real numbers $(c_k)_{0 \le k \le n}$, $(d_X(a, c_k))_{0 \le k \le n}$ is a stationary sequence and after $(d_X(a, c_k))_{0 \le k \le n}$ has the same distribution than $(d_X(a, c_k - b_0))_{0 \le k \le n}$. Next, conditionally to the σ -algebra $\sigma((c_k)_{0 \le k \le n})$, $(d_X(a, c_k))_{0 \le k \le n}$ as the same distribution than $(d_X(a, c_k - c_0))_{0 \le k \le n}$. Finally, since $\sigma((c_k)_{0 \le k \le n})$ and \mathcal{F}_X are independent, $(d_X(a, c_k))_{0 \le k \le n}$ as the same distribution than $(d_X(a, c_k - c_0))_{0 \le k \le n}$.

Now, we can only consider the case: $c_k = k\tau_n/n$ with $\tau_n := c_n - c_0$. Define

$$I'_n(a) := \frac{1}{n} \sum_{k=0}^n d_X^2(a, \mathbb{E}c_k).$$

It is clear that $(Ec_k)_{1 \le k \le n}$ is a deterministic sequence. Thus

$$\frac{I_n'(a) - \mathcal{I}_1(a)}{S_n(a)} \xrightarrow[n \to \infty]{\mathcal{D}} \mathcal{N}(0, 1). \tag{4.15}$$

Nowadays, one has to check that the error $I'_n(a) - I_n(a)$ is negligible with respect to $S_n(a)$ in norm $L^2(\Omega)$. But

$$S_n(a) \ge C_M \cdot \left(n \max_{0 \le k \le n-1} | \mathbb{E} \left(c_{k+1} - c_k \right) | \right)^{-1/2} \ge C \times \left(\mathbb{E} \tau_n \right)^{-1/2}.$$

Therefore, it suffices to prove that $\lim_{n\to\infty} \mathbb{E}\tau_n \times \mathbb{E}\left[(I'_n(a) - I_n(a))^2\right] = 0$. Since the r.v. c_k are independent on \mathcal{F}_X , one gets

$$\mathbb{E}\left[(I'_{n}(a) - I_{n}(a))^{2}\right] = \mathbb{E}\left[\mathbb{E}\left[(I'_{n}(a) - I_{n}(a))^{2} \mid \mathcal{F}_{X}\right]\right] \\
= \frac{1}{(n+1)^{2}} \sum_{k,k'=0}^{n} \mathbb{E}\left[\mathbb{E}\left[\left(d_{X}^{2}(a,\mathbb{E}c_{k}) - d_{X}^{2}(a,c_{k})\right)\left(d_{X}^{2}(a,\mathbb{E}c_{k'}) - d_{X}^{2}(a,c_{k'})\right)\middle|\mathcal{F}_{X}\right]\right] \\
= \frac{2a^{2}}{(n+1)^{2}} \sum_{k,k'=0}^{n} \mathbb{E}\left[\gamma^{2}(\mathbb{E}c_{k} - \mathbb{E}c_{k'},a,a) - \gamma^{2}(\mathbb{E}c_{k} - c_{k'},a,a) - \gamma^{2}(c_{k} - c_{k'},a,a)\right] \\
-\gamma^{2}(c_{k} - \mathbb{E}c_{k'},a,a) + \gamma^{2}(c_{k} - c_{k'},a,a)\right].$$

Next, from Taylor expansions,

$$\gamma^{2}(Ec_{k} - c_{k'}, a, a) = \gamma^{2}(Ec_{k} - Ec_{k'}, a, a) + 2(Ec_{k'} - c_{k'}) \times \cdots
\int_{0}^{1} \gamma(Ec_{k} - Ec_{k'} + \lambda(Ec_{k'} - c_{k'}), a, a) \gamma'(Ec_{k} - Ec_{k'} + \lambda(Ec_{k'} - c_{k'}), a, a) d\lambda
\gamma^{2}(c_{k} - Ec_{k'}, a, a) = \gamma^{2}(c_{k} - c_{k'}, a, a) + 2(c_{k'} - Ec_{k'}) \times \cdots
\int_{0}^{1} \gamma(c_{k} - c_{k'} + \lambda(Ec_{k'} - c_{k'}), a, a) \gamma'(c_{k} - c_{k'} + \lambda(Ec_{k'} - c_{k'}), a, a) d\lambda.$$

¿From Lemma 4.2, $\exists C > 0$ such that $|\gamma(\theta, a, a)\gamma'(\theta, a, a)| \leq C \times (1 \wedge \theta^{-2})$ for all $\theta \in \mathbb{R}$. One can deduce that

$$\left| \gamma^{2} \left(\mathbb{E} c_{k} - \mathbb{E} c_{k'}, a, a \right) - \gamma^{2} \left(\mathbb{E} c_{k} - c_{k'}, a, a \right) - \gamma^{2} \left(c_{k} - \mathbb{E} c_{k'}, a, a \right) + \gamma^{2} \left(c_{k} - c_{k'}, a, a \right) \right|$$

$$\leq C \left| c_{k'} - \mathbb{E} c_{k'} \right| \times \int_{0}^{1} \left(1 \wedge \theta_{1,k,k'}^{-2}(\lambda) \right) + \left(1 \wedge \theta_{2,k,k'}^{-2}(\lambda) \right) d\lambda$$

with $\theta_{1,k,k'}(\lambda) = \mathbb{E}(c_k - c_{k'}) + \lambda(\mathbb{E}c_{k'} - c_{k'})$ and $\theta_{2,k,k'}(\lambda) = c_k - c_{k'} + \lambda(\mathbb{E}c_{k'} - c_{k'})$. Then,

$$\mathbb{E}\left[\left(I_n'(a) - I_n(a)\right)^2\right] \le 2a^2 \times \left(\mathfrak{Er}_1 + \mathfrak{Er}_2\right),\tag{4.16}$$

where, for i = 1, 2, $\mathfrak{Er}_i := \int_0^1 \mathbb{E}\left[\frac{1}{(n+1)^2} \sum_{k,k'=0}^n \left| c_{k'} - \mathbb{E}c_{k'} \right| \times \left(1 \wedge \theta_{i,k,k'}^{-2}(\lambda)\right)\right] d\lambda$. Thus $\theta_{1,k,k'}(\lambda) = \delta'_n((k-k') - \lambda k' z_n)$ with $\delta'_n := \frac{\mathbb{E}\tau_n}{n}$ and $z_n := \frac{\tau_n - \mathbb{E}\tau_n}{\mathbb{E}\tau_n}$. Then, using $\delta'_n \xrightarrow[n \to \infty]{} 0$, for n large enough,

$$\mathfrak{Er}_{1} = \int_{0}^{1} \mathbb{E}\left[\frac{C}{(n+1)^{2}} \sum_{k,k'=0}^{n} \left| (k'\delta'_{n}) z_{n} \right| \times \left(1 \wedge \left[\delta'_{n} \left((k-k') - \lambda k' z_{n}\right)\right]^{-2}\right) \right] d\lambda$$

$$\leq \int_{0}^{1} \mathbb{E}\left[\frac{C}{(\mathbb{E}\tau_{n})^{2}} \int_{0}^{\mathbb{E}\tau_{n}} \int_{0}^{\mathbb{E}\tau_{n}} dx dy \left| y z_{n} \right| \times \left(1 \wedge \left[(x-y) - \lambda y z_{n}\right]^{-2}\right) \right] d\lambda.$$

But, for all $\lambda \in (0,1)$, one has

$$\frac{1}{(E\tau_n)^2} \int_0^{E\tau_n} \int_0^{E\tau_n} |y| \times \left(1 \wedge [(x-y) - \lambda y \, z_n]^{-2}\right) dx \, dy$$

$$= E\tau_n \int_0^1 \int_0^1 |v| \times \left(1 \wedge (E\tau_n)^{-2} \left[(u-v) - \lambda v \, z_n\right]^{-2}\right) du \, dv$$

$$\leq 2E\tau_n \int_0^2 \int_0^\infty \left(1 \wedge (E\tau_n)^{-2} s^{-2}\right) ds \, dt \leq 4.$$

Therefore $\mathfrak{Er}_1 \leq 4\mathbb{E}|z_n|$. Now, using the same method for \mathfrak{Er}_2 , one obtains,

$$\mathbb{E}\tau_{n} \times \mathbb{E}\left[(I'_{n}(a) - I_{n}(a))^{2} \right] \leq C \mathbb{E}\tau_{n} \times \mathbb{E}|z_{n}| \\
\leq C \left(\operatorname{var}\left(c_{n} - c_{0} \right) \right)^{1/2} \\
\longrightarrow 0$$

from assumptions. This induces that CLT (4.8) holds.

Now the asymptotic expansion (4.14) can be proved. Consider first the deterministic case and since

$$\sum_{k,k'=0}^{n} e^{i(k-k')\alpha} = \left| \frac{1 - e^{i(n+1)\alpha}}{1 - e^{i\alpha}} \right|^2 = \frac{\sin^2((n+1)\alpha/2)}{\sin^2(\alpha/2)}$$

then,

$$\begin{split} S_n^2(a) &= \frac{2\,a^2}{(n+1)^2} \int_{\mathbb{R}^2} \big| \widehat{\psi}(a\xi) \big|^2 f(\xi) \big| \widehat{\psi}(a\xi') \big|^2 f(\xi') d\xi d\xi' \sum_{k,k'=0}^n e^{i(k-k')\frac{(c_n-c_0)}{n}(\xi-\xi')} \\ &= \frac{2\,a^2}{(n+1)^2} \int_{\mathbb{R}^2} \big| \widehat{\psi}(a\xi) \big|^2 f(\xi) \big| \widehat{\psi}(a\xi') \big|^2 f(\xi') \frac{\sin^2\left(\frac{c_n-c_0}{2}\frac{n+1}{n}(\xi-\xi')\right)}{\sin^2\left(\frac{c_n-c_0}{2n}(\xi-\xi')\right)} d\xi d\xi' \\ &= \frac{16a^2}{c_n-c_0} \int_{\mathbb{R}^2_+} \big| \widehat{\psi}(az') \big|^2 f(z') \Big| \widehat{\psi}\Big(a\big(z'+\frac{2z}{c_n-c_0}\big)\Big) \Big|^2 f\Big(z'+\frac{2z}{c_n-c_0}\Big) \frac{\sin^2\left(\frac{n+1}{n}z\right)}{n^2 \sin^2\left(\frac{z}{n}\right)} dz dz'. \end{split}$$

Let us define $h_n(x) := \frac{\sin\left(\frac{n+1}{n}x\right)}{n\sin\left(\frac{x}{n}\right)}$ and $h(x) := \frac{\sin x}{x}$. For all $(z, z') \in \mathbb{R}^2$,

$$\left|\widehat{\psi}\left(a\left(z'+\frac{2z}{c_n-c_0}\right)\right)\right|^2 f\left(z'+\frac{2z}{c_n-c_0}\right) \underset{n\to\infty}{\longrightarrow} \left|\widehat{\psi}(az')\right|^2 f(z') \quad \text{and} \quad h_n^2(z) \underset{n\to\infty}{\longrightarrow} h^2(z).$$

However Lebesgue Theorem cannot be applied. Denote $\nu(x) := |\psi(ax)|^2 f(x)$ for x > 0. From Assumptions F and W(1, r) with r > 1/2, ν is a differentiable function in $(0, \infty)$ and $\exists C > 0$, $\forall z', x > 0$, $|\nu'(z' + x)| \le C |\nu'(z')|$. Then,

$$\left| \nu \left(z' + \frac{2z}{c_n - c_0} \right) - \nu(z') \right| \le \frac{2z}{c_n - c_0} C \left| \nu'(z') \right|.$$

Moreover, $|h_n(z')| \leq 1$ for all $z' \in \mathbb{R}$, and

$$\int_{-n}^{n} h_n^2(z) dz = \frac{1}{n^2} \int_{-n}^{n} \sum_{k,k'=0}^{n} e^{2i(k-k')\frac{z}{n}} dz$$

$$= \frac{2}{n} \sum_{0 \le k' < k \le n} \frac{\sin(2(k-k'))}{(k-k')} + \frac{1}{n^2} \sum_{k=0}^{n} 2n$$

$$= \frac{2}{n} \left\{ \sum_{k=1}^{n} (n+1-k) \frac{\sin(2k)}{k} \right\} + 2(\frac{n+1}{n}).$$

Therefore,

$$\lim_{n \to \infty} \int_{-n}^{n} h_n^2(z) dz = 2 \left\{ \sum_{k=1}^{\infty} \frac{\sin(2k)}{k} \right\} + 2 = \pi, \tag{4.17}$$

since $\frac{2}{n} \sum_{1 \le k \le n} k \frac{\sin(2k)}{k} \le 4 \frac{\log n}{n} \xrightarrow[n \to \infty]{} 0$ and from Dirichlet Theorem, $x - \pi = -2 \sum_{n \ge 1} \frac{\sin(nx)}{n}$ for all $x \in (0, 2\pi)$. Now, for $z' \ge 0$ and n large enough,

$$\begin{split} \Big| \int_{\mathbb{R}_{+}} v \Big(z' + \frac{2z}{c_{n} - c_{0}} \Big) h_{n}^{2}(z) dz - v(z') \int_{0}^{n} h_{n}^{2}(z) dz \Big| \\ & \leq \frac{2C |v(z')|}{c_{n} - c_{0}} \int_{0}^{n} z h_{n}^{2}(z) dz + \int_{n}^{\infty} v \Big(z' + \frac{2z}{c_{n} - c_{0}} \Big) h_{n}^{2}(z) dz \\ & \leq \frac{2C |v(z')|}{c_{n} - c_{0}} \int_{0}^{n} z \frac{4 \sin^{2}(z)}{z^{2}} dz + \int_{n}^{\infty} v \Big(z' + \frac{2z}{c_{n} - c_{0}} \Big) dz \\ & \leq \frac{8C |v(z')|}{c_{n} - c_{0}} \Big(\int_{0}^{1} z dz + \int_{1}^{n} \frac{1}{z} dz \Big) + C f(z') \int_{n}^{\infty} \Big| \psi \Big(a \Big(z' + \frac{2z}{c_{n} - c_{0}} \Big) \Big) \Big|^{2} dz \\ & \leq \frac{8C |v(z')|}{c_{n} - c_{0}} \Big(\int_{0}^{1} z dz + \int_{1}^{n} \frac{1}{z} dz \Big) + C a^{-2r} f(z') \int_{n}^{\infty} \frac{C_{\psi}}{\Big(1 + \Big(z' + \frac{2z}{c_{n} - c_{0}} \Big) \Big)^{2r}} dz \end{split}$$

under Assumption W(1, 1, r). But when r > 1/2,

$$\int_{n}^{\infty} \frac{1}{\left(1 + \left(z' + \frac{2z}{c_n - c_0}\right)\right)^{2r}} dz \le \frac{c_n - c_0}{2} \int_{2n/(c_n - c_0)}^{\infty} \frac{1}{x^{2r}} dx \le \frac{2^{2r - 1}}{2(2r - 1)} \frac{(c_n - c_0)^{2r}}{n^{2r - 1}},$$

and therefore there exists C > 0 such that for all z' > 0 and for n large enough,

$$\left| \int_{\mathbb{R}_{+}} \upsilon \left(z' + \frac{2z}{c_{n} - c_{0}} \right) h_{n}^{2}(z) dz - \upsilon(z') \int_{0}^{n} h_{n}^{2}(z) dz \right|$$

$$\leq C \left(\frac{1 + \log(n)}{c_{n} - c_{0}} \left| \upsilon(z') \right| + f(z') \left(\frac{c_{n} - c_{0}}{n^{1 - \frac{1}{2r}}} \right)^{2r} \right)$$

$$\xrightarrow[n \to \infty]{} 0$$

under assumptions of Proposition 4.2. Finally, with (4.17) in mind, one deduces that for all $z' \geq 0$,

$$\lim_{n \to \infty} \int_{\mathbb{R}_+} v(z' + \frac{2z}{c_n - c_0}) h_n^2(z) dz = \lim_{n \to \infty} v(z') \int_0^n h_n^2(z) dz = \frac{\pi}{2} v(z').$$

Therefore, using the same method in \mathbb{R}_{-} as in \mathbb{R}_{+} , one obtains

$$\int_{\mathbb{R}} \left| \widehat{\psi}(az') \right|^2 f(z') \int_{\mathbb{R}} \left| \widehat{\psi} \left(a \left(z' + \frac{2z}{c_n - c_0} \right) \right) \right|^2 f\left(z' + \frac{2z}{c_n - c_0} \right) \frac{\sin^2(z)}{n^2 \sin^2\left(\frac{z}{n}\right)} dz dz'$$

$$\underset{n \to \infty}{\longrightarrow} \pi \int_{\mathbb{R}} \left| \widehat{\psi}(az') \right|^4 f^2(z') dz',$$

providing the asymptotic behavior of S_n^2 . The proof is similar in the stochastic case with $c_n - c_0$ replaced by $\mathbb{E}(c_n - c_0)$.

4.3 Proof of Theorem 2.1

The proof of Theorem 2.1 uses the following lemmas:

Lemma 4.4 Let X be a Gaussian process defined by (1.1) with a spectral density f satisfying (1.3) and Assumption F(H). Let us define,

$$R(t, u, t', u') := \mathbb{E}\Big[(X(t+u) - X(t)) \cdot (X(t'+u') - X(t')) \mid \mathcal{F}_X \Big],$$

for $(t,t') \in \mathbb{R}^2$, $(u,u') \in \mathbb{R}^2_+$. Then $\exists C_f > 0$ depending only on the spectral density f such that for all $(u,u',t,t') \in \mathbb{R}^2_+ \times \mathbb{R}^2$, with $\beta = (t'-t+u'-u)$,

$$|R(t, 2u, t', 2u')| \le C_f (u u' + (u u')^{(H+1)/2} |\beta|^{H-1} \mathbf{1}_{0 < H < 1}).$$

Proof. To begin with, remark that for all $(t,t') \in \mathbb{R}^2$, $(u,u') \in \mathbb{R}^2_+$,

$$= 8 \int_{0}^{\infty} \sin(u\xi) \cdot \sin(u'\xi) \cdot \cos(\xi(t'-t+u'-u)) f(\xi) d\xi$$

$$= 8 (I_1 + I_2)$$

with $I_1 := \int_0^{\omega_K} \cdots d\xi$ and $I_2 = \int_{\omega_K}^{\infty} \cdots d\xi$. From the one hand, with $|\sin a| \le |a|$ and $|\cos a| \le 1$,

$$|I_1| \le u u' \int_0^{\omega_K} \xi^2 f(\xi) d\xi \le C u u',$$

where the last inequality follows from (1.3). Now, if H > 1, then the same bound can be extended to I_2 since $|\xi^2 f(\xi)| \leq C \xi^{1-2H}$ and $\int_{\omega_K}^{\infty} \xi^{1-2H} d\xi < \infty$. Therefore if H > 1,

$$|R(t, 2u, t', 2u')| \le C_f u u'$$

with C_f only depending on f.

If 0 < H < 1, firstly one obtains with a change of variable, $|\cos a| \le 1$ and $|\sin a| \le (1 \land |a|)$

$$|I_{2}| \leq \frac{1}{\sqrt{u \, u'}} \int_{\omega_{K} \sqrt{u \, u'}}^{\infty} |\sin(u\xi/\sqrt{u \, u'}) \sin(u\xi/\sqrt{u \, u'})| f(\xi/\sqrt{u \, u'}) d\xi$$

$$\leq (u \, u')^{H} \int_{0}^{\infty} |\sin(u\xi/\sqrt{u \, u'}) \sin(u\xi/\sqrt{u \, u'})| \xi^{-2H-1} d\xi$$

$$\leq (u \, u')^{H} \Big(\int_{0}^{1} \xi^{-2H+1} d\xi + \int_{1}^{\infty} \xi^{-2H-1} d\xi \Big)$$

$$\leq C_{H} (u \, u')^{H}, \tag{4.18}$$

with $C_H > 0$ depending only on H. Secondly, with $\beta = (t' - t + u' - u)$ and an integration by parts,

$$I_{2} = \int_{\omega_{K}}^{\infty} \sin(u\,\xi) \sin(u'\,\xi) \cos(\beta\,\xi) f(\xi) d\xi$$
$$= \beta^{-1} \Big(\Big[\sin(u\,\xi) \sin(u'\,\xi) \sin(\beta\,\xi) f(\xi) \Big]_{\omega_{K}}^{\infty} - \int_{\omega_{K}}^{\infty} \sin(\beta\,\xi) \frac{\partial}{\partial x} \Big(\sin(u\,\xi) \sin(u'\,\xi) f(\xi) \Big) dx \Big),$$

where Assumption F(H) insures the convergence of bracket term at ∞ . Using again Assumption F(H) for f', changes of variables, $|\cos a| \le 1$ and $|\sin a| \le (1 \land |a|)$,

$$I_{2} \leq C_{f} u u' + C_{0} \beta^{-1} \int_{\omega_{K}}^{\infty} |\sin(\beta x)| \Big(u |\sin(u'x)| + u' |\sin(ux)| \Big) x^{-2H-1} dx$$

$$+ C'_{0} \beta^{-1} \int_{\omega_{K}}^{\infty} |\sin(\beta x) \sin(u x) \sin(u' x)| x^{-2H-2} dx$$

$$\leq C_{f} u u' + C_{0} \beta^{-1} (u u')^{H} \int_{0}^{\infty} |\sin(\beta x / \sqrt{u u'})| \Big(u |\sin(u' x / \sqrt{u u'})| + u' |\sin(u x / \sqrt{u u'})| \Big) x^{-2H-1} dx$$

$$+ C'_{0} \beta^{-1} (u u')^{H+1/2} \int_{0}^{\infty} |\sin(\beta x / \sqrt{u u'}) \sin(u' x / \sqrt{u u'}) \sin(u x / \sqrt{u u'})| \Big) x^{-2H-2} dx$$

$$\leq C_{f} u u' + C_{0} \Big(2 (u u')^{H} \int_{0}^{1} x^{-2H+1} dx + \beta^{-1} (u + u') (u u')^{H} \int_{1}^{\infty} x^{-2H-1} dx \Big)$$

$$+ C'_{0} \Big((u u')^{H} \int_{0}^{1} x^{-2H+1} dx + \beta^{-1} (u u')^{H+1/2} \int_{1}^{\infty} x^{-2H-2} dx \Big)$$

$$\leq C_{f} (u u' + (u u')^{H} + \beta^{-1} (u + u') (u u')^{H} + \beta^{-1} (u u')^{H+1/2} \Big),$$

where $C_f > 0$ only depends on f. Therefore with (4.18), for 0 < H < 1,

$$|I_2| \le C (u u')^H \wedge (\beta^{-1} (u + u') (u u')^H + \beta^{-1} (u u')^{H+1/2}).$$

But the inequality $(x \wedge y) \leq x^{\alpha}y^{1-\alpha}$ which is valid for all $x, y \geq 0$ and $0 \leq \alpha \leq 1$. Applied to previous inequality with appropriated choices of α , one obtains $|I_2| \leq C (u u')^{(H+1)/2} \beta^{H-1}$. This completes the proof of Lemma 4.4.

The error $\varepsilon(a,b)$ contains three different terms. The first one corresponds to the replacement of the integral onto the interval $[0,T_n]$ by its Riemann sum. The second and the third ones correspond to the replacement of the integral onto \mathbb{R} by the integral onto the interval $[0,T_N]$. More precisely, one has

$$\begin{split} \varepsilon_{1,n}(a,b) &:= a^{-1/2} \left\{ \int_0^{T_n} \psi \Big(\frac{t-b}{a} \Big) \, X(t) \, dt \, - \sum_{i=0}^{n-1} X \Big(t_i^{(n)} \Big) \times \int_{t_i^{(n)}}^{t_{i+1}^{(n)}} \psi \Big(\frac{t-b}{a} \Big) \right\}, \\ \varepsilon_{2,n}(a,b) &:= a^{-1/2} \int_{T_n}^{\infty} \psi \Big(\frac{t-b}{a} \Big) \, X(t) \, dt, \\ \varepsilon_{3,n}(a,b) &:= a^{-1/2} \int_{-\infty}^0 \psi \Big(\frac{t-b}{a} \Big) \, X(t) \, dt. \end{split}$$

The following lemma give bounds on $\mathbb{E}|\varepsilon_{i,n}(a,k)|^2$ for i=1,2,3.

Lemma 4.5 Let X be a Gaussian process defined by (1.1) with a spectral density f satisfying (1.3) and Assumption F(H). Assume also Assumptions W(1,3,0) and let $(p_1,p_2) \in [1,\infty)^2$ and (q_1,q_2) be defined by $\frac{1}{p_j} + \frac{1}{q_j} = 1$ for i = 1, 2. Then, there exist positive constants C_1 , C_2 and C_3 depending only on f, a_{min} , a_{max} , C_{ψ} and p_1 , p_2 , such that for any r.v. b independent on \mathcal{F}_X and satisfying $T_n^{\rho} \leq b \leq T_n - T_n^{\rho}$ with $\rho > 1/2$, we have

$$\mathbb{E}(\left|\varepsilon_{1,n}(a,b)\right|^{2} \mid \mathcal{F}_{X}) \leq C_{1} \left\{ \left\|\psi\right\|_{\mathcal{L}^{q_{1}}}^{2} \left(\sum_{i=0}^{n-1} L_{i}^{p_{1}+1}\right)^{2/p_{1}} \delta_{n}^{2+2/p_{1}} \right\}$$

$$(4.20)$$

$$+\mathbf{1}_{0< H< 1} \cdot \|\psi\|_{\mathcal{L}^{q_{2}}} \left(\|\psi\|_{\mathcal{L}^{q_{2}}} + \|\psi\|_{\infty}\right) \left(\sum_{i=0}^{n-1} L_{i}^{1+p_{2}(1+H)/2}\right)^{2/p_{2}} \delta_{n}^{1+H+2/p_{2}}$$

$$\mathbb{E}\left(\left|\varepsilon_{i,n}(a,b)\right|^{2} \mid \mathcal{F}_{X}\right) \leq C_{2} a^{5} T_{n}^{2-4\rho} \quad \text{for } n \text{ large enough and } i=2,3.$$

$$(4.21)$$

 $\mathbb{E}\left(\left|\varepsilon_{i,n}(a,0)\right| \mid \mathcal{F}_X\right) \leq C_2 a I_n \quad \text{for } n \text{ large enough and } i = 2, 3. \tag{4.21}$

Remark 4.2 When H=1, the term $\delta_n^{1+H+2/p_2}=\delta_n^{2+2/p_2}$ should be replaced by $\ln \delta_n \times \delta_n^{2+2/p_2}=\mathcal{O}\left(\delta_n^{2-\varepsilon+2/p_2}\right)$ for all $\varepsilon>0$. Thus, if H=1, it suffices to replace H by 1^- and formula (4.20) remains valid. This convention will be adopted in the following, in order to lighten the notations.

$$= \frac{1}{a} \sum_{i=0}^{n-1} \sum_{j=0}^{n-1} \int_{t_{i}^{(n)}}^{t_{i+1}^{(n)}} \int_{t_{j}}^{t_{j+1}^{(n)}} \psi(\frac{t-b}{a}) \overline{\psi(\frac{t'-b}{a})} R(t_{i}^{(n)}, t-t_{i}^{(n)}, t_{j}, t'-t_{j}) dt dt'.$$

Lemma 4.4, with $2u = t - t_i^{(n)}$, $2u' = t' - t_j$ and $\beta = t_j^{(n)} - t_i^{(n)} + \frac{1}{2}(t' - t_j^{(n)}) - \frac{1}{2}(t - t_i^{(n)}) = \frac{1}{2}(t' + t_j^{(n)} - t - t_i^{(n)})$, implies

$$\mathbb{E}(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X) \leq C_f a^{-1} (S_1 + S_2 \mathbf{1}_{0 < H < 1})$$

with

$$S_{1} := \sum_{i,j=0}^{n-1} \int_{t_{i}^{(n)}}^{t_{i+1}^{(n)}} \int_{t_{j}}^{t_{j+1}^{(n)}} u \, u' \Big| \psi \Big(\frac{t-b}{a} \Big) \Big| \Big| \psi \Big(\frac{t'-b}{a} \Big) \Big| dt dt'$$

$$S_{2} := \sum_{i,j=0}^{n-1} \int_{t_{i}^{(n)}}^{t_{i+1}^{(n)}} \int_{t_{j}^{(n)}}^{t_{j+1}^{(n)}} (u \, u')^{(H+1)/2} |\beta|^{H-1} \Big| \psi \Big(\frac{t-b}{a} \Big) \Big| \Big| \psi \Big(\frac{t'-b}{a} \Big) \Big| dt dt'.$$

Set

$$\chi(t) := \sum_{i=0}^{n-1} |t - t_i^{(n)}| \mathbf{1}_{[t_i^{(n)}, t_{i+1}^{(n)}]}(t). \tag{4.22}$$

We have $S_1 = \left(\int_0^{T_n} \chi(t) \left| \psi\left(\frac{t-b}{a}\right) \right| dt\right)^2$, then from Hölder Inequality, for $(p,q) \in [1,\infty]^2$ with 1/p + 1/q = 1, we have

$$S_1 \le \left\| \chi \right\|_{\mathcal{L}^p}^2 \left\| \psi \left(\frac{t-b}{a} \right) \right\|_{\mathcal{L}^q}^2.$$

Obviously $\|\psi\left(\frac{t-b}{a}\right)\|_{\mathcal{L}^q} = a^{1/q}\|\psi\|_{\mathcal{L}^q}$. ¿From the other hand, for $p < \infty$

$$\begin{aligned} \|\chi^{H}\|_{\mathcal{L}^{p}} &= \left(\int_{\mathbb{R}} \chi^{Hp}(t) dt\right)^{1/p} = \left(\int_{\mathbb{R}} \sum_{i=0}^{n-1} \mathbf{1}_{[t_{i}^{(n)}, t_{i+1}^{(n)}]}(t) |t - t_{i}^{(n)}|^{Hp} dt\right)^{1/p} \\ &= \left(\sum_{i=0}^{n-1} \int_{t_{i}^{(n)}}^{t_{i+1}^{(n)}} |t - t_{i}^{(n)}|^{Hp} dt\right)^{1/p} \\ &= (1 + Hp)^{-1/p} \left(\sum_{i=0}^{n-1} L_{i}^{1+Hp}\right)^{1/p} \delta_{n}^{H+1/p}. \end{aligned}$$

With the convention $1/\infty = 0$, this result remains in force for $p = \infty$. It follows for all $1 \le p_1 < \infty$,

$$S_1 \leq \frac{a^{2-2/p_1} \|\psi\|_{\mathcal{L}^{q_1}}^2}{(p_1+1)^{2/p_1}} \left(\sum_{i=0}^{n-1} L_i^{p_1+1}\right)^{2/p_1} \delta_n^{2+2/p_1}. \tag{4.23}$$

Next, in order to bound S_2 for 0 < H < 1, write

$$S_2 \leq C_f \sum_{0 \leq i \leq j \leq n-1} \int_{t_i^{(n)}}^{t_{i+1}^{(n)}} \int_{t_j}^{t_{j+1}^{(n)}} \left| \psi\left(\frac{t-b}{a}\right) \psi\left(\frac{t'-b}{a}\right) \right| (uu')^{(1+H)/2} |\beta|^{-(1-H)} dt dt',$$

where $u = \frac{1}{2}(t - t_i^{(n)})$, $u' = \frac{1}{2}(t' - t_j^{(n)})$ and $\beta = u' - u$. But since $\beta = \frac{1}{2}((t' + t_j) - (t + t_i))$ for $i \leq j$ and $t \in [t_i^{(n)}, t_{i+1}^{(n)}]$, $t' \in [t_j^{(n)}, t_{j+1}^{(n)}]$ then $|\beta| \geq \frac{1}{2}|t' - t|$. Therefore,

$$S_{2} \leq C_{f} \sum_{0 \leq i \leq j \leq n-1} \int_{t_{i}^{(n)}}^{t_{i+1}^{(n)}} \int_{t_{j}}^{t_{j+1}^{(n)}} \left| \psi\left(\frac{t-b}{a}\right) \psi\left(\frac{t'-b}{a}\right) \right| (uu')^{(1+H)/2} |t-t'|^{H-1} dt dt'$$

$$\leq \int_{0}^{T_{n}} \int_{0}^{T_{n}} \chi(t)^{(1+H)/2} \chi(t')^{(1+H)/2} \left| \psi\left(\frac{t-b}{a}\right) \psi\left(\frac{t'-b}{a}\right) \right| |t-t'|^{H-1} dt dt'$$

$$\leq \left\| \chi(t)^{(1+H)/2} \chi(t')^{(1+H)/2} \right\|_{\mathcal{L}^{p}(\mathbb{R}^{2})} \left\| \psi\left(\frac{t-b}{a}\right) \overline{\psi\left(\frac{t'-b}{a}\right)} |t-t'|^{H-1} \right\|_{\mathcal{L}^{q}(\mathbb{R}^{2})}$$

for any $(p,q) \in [1,\infty]^2$ with 1/p + 1/q = 1. But for all $p \ge 2$

$$\left\| \chi(t)^{(1+H)/2} \chi(t')^{(1+H)/2} \right\|_{\mathcal{L}^p(\mathbb{R}^2)} = \left(1 + p(1+H)/2 \right)^{-2/p} \left(\sum_{i=0}^{n-1} L_i^{1+p(1+H)/2} \right)^{2/p}$$

Next, with $u = (t - c_k)/a$ and $v = (t' - c_k)/a$, one gets

$$\|\psi\left(\frac{t-b}{a}\right)\psi\left(\frac{t'-b}{a}\right)|t-t'|^{H-1}\|_{\mathcal{L}^{q}(\mathbb{R}^{2})}^{q} \leq a^{2+q(1-H)} \int_{\mathbb{R}^{2}} \frac{|\psi(u)\psi(v)|^{q}}{|u-v|^{q(1-H)}} du dv$$

$$\leq a^{2+q(1-H)} \Big(\int_{\mathbb{R}^{2},|u-v|\geq 1} |\psi(u)\psi(v)|^{q} du dv + \int_{\mathbb{R}^{2},|u-v|<1} \frac{|\psi(u)\psi(v)|^{q}}{|u-v|^{q(1-H)}} du dv \Big)$$

$$\leq a^{2+q(1-H)} \Big(\|\psi\|_{\mathcal{L}^{q}}^{2q} + \|\psi\|_{\infty}^{q} \|\psi\|_{\mathcal{L}^{q}}^{q} \int_{0}^{1} s^{-q(1-H)} ds \Big).$$

The last integral is equal to $(1 - q(1 - H))^{-1}$ when p > 1/H. Thus, for all $p_2 > 1/H$,

$$S_2 \leq \frac{\|\psi\|_{\mathcal{L}^{q_2}} \left(\|\psi\|_{\mathcal{L}^{q_2}}^{q_2} + \frac{\|\psi\|_{\infty}^{q_2}}{1 - q_2(1 - H)}\right)^{1/q_2}}{a^{H - 3 + 2/p_2} \left(1 + p_2(1 + H)/2\right)^{2/p_2}} \left(\sum_{i=0}^{n-1} L_i^{1 + p_2(1 + H)/2}\right)^{2/p_2} \delta_n^{1 + H + 2/p_2}. \tag{4.24}$$

Finally by summing up (4.23) and (4.24), one gets the bounds of $\mathbb{E}(|\varepsilon_{1,n}(a,b)|^2 | \mathcal{F}_X)$.

(2) Bound of $\mathbb{E}(|\varepsilon_{2,n}(a,b)|^2 | \mathcal{F}_X)$. Since T_n is independent on \mathcal{F}_X ,

$$\mathbb{E}\left(\left|\varepsilon_{2,n}(a,b)\right|^{2}\mid\mathcal{F}_{X}\right) = \frac{1}{a}\int_{T_{n}}^{\infty}\int_{T_{n}}^{\infty}\psi\left(\frac{t-b}{a}\right)\overline{\psi\left(\frac{t'-b}{a}\right)}\mathbb{E}\left(X(t)X(t')\right)dtdt'$$

$$\leq \frac{C_{f}}{a}\left(\int_{T_{n}}^{\infty}\left|\psi\left(\frac{t-b}{a}\right)\right|\left(1+|t|\right)dt\right)^{2}.$$

from Lemma 4.1. But, according to Assumption W(1,3), $(1+|t|^3)|\psi(t)|$ is a bounded function and

$$\mathbb{E}\left(\varepsilon_{2,n}^2(a,b)\mid \mathcal{F}_X\right) \leq C_f C_\psi^2 a^{-1} \left(\int_T^\infty \left(1+t\right) \left(1+\left(t-b\right)/a\right)^{-3} dt\right)^2.$$

If $T_n \geq 1$, then $1 + (t - b)/a \leq 1 + (t - T_n + T_n^{\rho})/a$ for all $t \geq T_n$ and with the change of variable $v = (t - T_n + T_n^{\rho})/T_n$,

$$\int_{T_n}^{\infty} \frac{(1+t)}{(1+(t-b)/a)^3} dt \leq T_n a^3 \int_{T_n^{\rho-1}}^{\infty} \frac{(1+vT_n+T_n-T_n^{\rho})}{(a+vT_n)^3} dv$$

$$\leq T_n^{-1} a^3 \int_{T_n^{\rho-1}}^{\infty} \frac{(v+2)}{v^3} dv = a^3 \left[T_n^{1-2\rho} + T_n^{-\rho} \right]$$

If $T_n \leq 1$, by using $b \leq T_n$,

$$\int_{T_n}^{\infty} \frac{(1+t)}{(1+(t-b)/a)^3} dt \le \int_0^{\infty} \frac{(1+v+T_n)}{(1+v/a)^3} dv \le a + \frac{1}{2} a^2.$$

Eventually, one deduces the bound of $\mathbb{E}(|\varepsilon_{2,n}(a,b)|^2 | \mathcal{F}_X)$.

(3) Bound of $\mathbb{E}(|\varepsilon_{3,n}(a,b)|^2 | \mathcal{F}_X)$. Find a bound for $\mathbb{E}(|\varepsilon_{3,n}(a,b)|^2 | \mathcal{F}_X)$ follows the same steps than for bounding $\mathbb{E}(|\varepsilon_{2,n}(a,b)|^2 | \mathcal{F}_X)$.

Lemma 4.6 Under assumptions of Lemma 4.5 and if $s > 2 + \frac{1}{2H} [1 - 3H]_+$ and if

$$\delta_n = n^{-d}$$
 with $\left(\frac{1 + (2H \wedge 1)}{1 + s(2H \wedge 1)}\right) \vee \left(\frac{s + (H \wedge 1)}{s(2 + (H \wedge 1)) - 1}\right) < d < 1,$

then for all a > 0,

$$(n \,\delta_n) \, \mathbb{E}(\left|\varepsilon_n(a, c_k)\right|^2) \underset{n \to \infty}{\longrightarrow} 0 \quad \text{for all } 0 \le k \le n. \tag{4.25}$$

Proof. With $(x+y+z)^2 \le 3(x^2+y^2+z^2)$ for all real numbers x, y, z, z

$$\mathbb{E}(\left|\varepsilon_{n}(a,c_{k})\right|^{2}) \leq 3\mathbb{E}\left[\mathbb{E}(\left|\varepsilon_{1,n}(a,b)\right|^{2} \mid \mathcal{F}_{X})\right] + 6\mathbb{E}\left[\mathbb{E}(\left|\varepsilon_{2,n}(a,b)\right|^{2} \mid \mathcal{F}_{X})\right].$$

Then using Lemma 4.5, with $p_1 \ge 1$ and $p_2 > 1/H$, an optimal choice of p_1, p_2 depends on s. Hence, since $\mathbb{E}(|Z|^{\alpha}) \le (\mathbb{E}|Z|)^{\alpha}$ for any r.v. Z and $\alpha \in [0,1]$ from Jensen Inequality,

$$\begin{split} 1. & \text{ if } 3 \leq s, \quad \text{with } \ 1+p_1=s, \\ & E\Big(\sum_{i=0}^{n-1} L_i^{p_1+1}\Big)^{\frac{2}{p_1}} \delta_n^{2+\frac{2}{p_1}} \leq M_s^{\frac{2}{s-1}} \cdot (n \, \delta_n^s)^{\frac{2}{s-1}}; \\ 2. & \text{ if } \max\big(2+H, \frac{3}{2}+\frac{1}{2H}\big) \leq s, \quad \text{with } \ 1+\frac{1}{2} \, p_2(1+H)=s, \\ & E\Big(\sum_{i=0}^{n-1} L_i^{1+p_2(1+H)/2}\Big)^{\frac{2}{p_2}} \delta_n^{1+H+\frac{2}{p_2}} \leq M_s^{\frac{1+H}{s-1}} \cdot (n \, \delta_n^s)^{\frac{1+H}{s-1}}. \end{split}$$

However, these inequalities may be extended to smaller values of s by using the sharper inequality $\mathbb{E}\left(\sum |x_i|\right)^{\alpha\beta} \leq \mathbb{E}\left(\sum |x_i|^{\beta}\right)^{\alpha} \leq n^{\alpha}\left(\max_{0\leq i\leq n-1}\mathbb{E}(|x_i|^{\beta})\right)^{\alpha}$ when $(\alpha,\beta)\in(0,1]^2$ and therefore for r>1,

 $I\!\!E \big(\sum L_i^r\big)^{\alpha\beta} \leq n^\alpha \big(\max_{0 \leq i \leq n-1} I\!\!E (|L_i|^{r\beta})\big)^\alpha; \text{ it is then possible to choose } r\beta = s. \text{ Thus,}$

1'. if $2 < s \le 3$, with $\alpha \beta = \frac{2}{p_1}$ and $s = \beta + \frac{2}{\alpha}$, the best possible choice is $\alpha = 1$ and $\beta = s - 2$,

$$\mathbb{E}\Big(\sum_{i=0}^{n-1} L_i^{1+\frac{2}{\alpha\beta}}\Big)^{\alpha\beta} \delta_n^{2+\alpha\beta} \le M_s^s \cdot n\delta_n^s;$$

2'. if $H \ge 1/2$, and $1 + H < s \le 2 + H$, with $\alpha \beta = \frac{2}{p_2}$ and $s = \beta + \frac{1+H}{\alpha}$, the best possible choice is $\alpha = 1$ and $\beta = s - (H+1)$,

$$I\!\!E \Big(\sum_{i=0}^{n-1} L_i^{1+\frac{1+H}{\alpha\beta}} \Big)^{\alpha\beta} \delta_n^{1+H+\alpha\beta} \leq M_s^s \cdot n \delta_n^s;$$

2". if $0 < H \le 1/2$ and $\frac{1}{2} + \frac{1}{2H} < s \le \frac{3}{2} + \frac{1}{2H}$, with $\alpha \beta = \frac{2}{p_2}$ and $s = \beta + \frac{1+H}{\alpha}$, the best possible choice is $\alpha = 2H$ and $\beta = s - \frac{H+1}{2H}$

$$I\!\!E \Big(\sum_{i=0}^{n-1} L_i^{1+\frac{1+H}{\alpha\beta}} \Big)^{\alpha\beta} \delta_n^{1+H+\alpha\beta} \le M_s^{2H} \cdot \left(n \delta_n^s \right)^{2H}.$$

We finally obtain for n large enough and using $n \, \delta_n \longrightarrow \infty$ and $n \, \delta_n^s \longrightarrow 0$,

• if
$$H \ge 1/2$$
, $\mathbb{E}\left[\mathbb{E}\left(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X\right)\right] \le C\left(n\delta_n^s \mathbf{1}_{2 < s \le 2 + (H \land 1)} + (n\delta_n^s)^{\frac{1 + (H \land 1)}{s - 1}} \mathbf{1}_{2 + (H \land 1) \le s}\right);$

• if
$$0 < H \le 1/2$$
, $\mathbb{E}\left[\mathbb{E}\left(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X\right)\right] \le C\left(n\delta_n^s \mathbf{1}_{2\vee\left(\frac{1}{2}+\frac{1}{2H}\right)< s \le \frac{3}{2}+\frac{1}{2H}} + (n\delta_n^s)^{\frac{1+H}{s-1}} \mathbf{1}_{\frac{3}{2}+\frac{1}{2H}\le s}\right);$

Both these inequalities may be reduced to only one for all $s > 2 \lor (\frac{1}{2} + \frac{1}{2H})$ and H > 0:

Hence, with $\delta_n = C_\delta n^{-d}$,

$$\begin{array}{ll} \bullet & \frac{1+(2H\wedge 1)}{1+s(2H\wedge 1)} \leq d < 1 & \text{if } 2 \vee \left(\frac{1}{2} + \frac{1}{2H}\right) \leq s < \left(2 + (H\wedge 1)\right) \vee \left(\frac{3}{2} + \frac{1}{2H}\right) \\ \bullet & \frac{s+(H\wedge 1)}{s(2+(H\wedge 1))-1} \leq d < 1 & \text{if } \left(2 + (H\wedge 1)\right) \vee \left(\frac{3}{2} + \frac{1}{2H}\right) \leq s \leq \infty \end{array}$$

•
$$\frac{s+(H\wedge 1)}{s(2+(H\wedge 1))-1} \le d < 1$$
 if $(2+(H\wedge 1)) \lor (\frac{3}{2}+\frac{1}{2H}) \le s \le \infty$

then

$$(n\delta_n)\mathbb{E}\big[\mathbb{E}\big(\big|\varepsilon_{1,n}(a,b)\big|^2\mid\mathcal{F}_X\big)\big] \underset{n\to\infty}{\longrightarrow} 0.$$

To finish the proof of Lemma 4.6 it remains to show $(n\delta_n)\mathbb{E}\left[\mathbb{E}\left(\left|\varepsilon_{2,n}(a,b)\right|^2\mid\mathcal{F}_X\right)\right] \xrightarrow{n\to\infty} 0.$

¿From Lemma 4.5 it follows that $\mathbb{E}\left[\mathbb{E}\left(\left|\varepsilon_{2,n}(a,b)\right|^2\mid\mathcal{F}_X\right)\right] \leq C\int_0^\infty g(x)\,f_n(x)\,dx$ where f_n is the probability distribution function of T_n and $g(x)=\mathbf{1}_{(x<1)}+\mathbf{1}_{(x\geq 1)}\,x^{2-4\rho}$. Since $\rho>3/4,\ g(x)\leq 1$ for all x>0

and g is a non increasing map,

$$\int_{0}^{\infty} g(x) f_{n}(x) dx \leq \int_{0}^{\frac{1}{2} m_{s} n \delta_{n}} f_{n}(x) dx + g\left(\frac{1}{2} m_{s} n \delta_{n}\right) \int_{\frac{1}{2} m_{s} n \delta_{n}}^{\infty} f_{n}(x) dx
\leq \mathbb{P}\left(T_{n} \leq \frac{1}{2} m_{s} n \delta_{n}\right) + g\left(\frac{1}{2} m_{s} n \delta_{n}\right)
\leq \mathbb{P}\left(|T_{n} - \mathbb{E}[T_{n}]| \geq \mathbb{E}[T_{n}] - \frac{1}{2} m_{s} n \delta_{n}\right) + \left(\frac{1}{2} m_{s} n \delta_{n}\right)^{2-4\rho},
\leq 4 \frac{M_{s}}{m_{s}} \frac{n \delta_{n}^{2}}{n^{2} \delta_{n}^{2}} + \left(\frac{1}{2} m_{s} n \delta_{n}\right)^{2-4\rho},$$

from Bienaymé-Chebyshev Inequality since $s \geq 2$ and $\operatorname{var}(T_n) \leq M_s n \delta_n^2$ from the independence of $(L_i)_{i \in \mathbb{N}}$. Therefore $(n \delta_n) \mathbb{E}\left[\mathbb{E}\left(\left|\varepsilon_{2,n}(a,b)\right|^2 \mid \mathcal{F}_X\right)\right] \xrightarrow[n \to \infty]{} 0$.

Proof. [Theorem 2.1] Denote $v_n(a) = \left(n\delta_n^s\right)^{2H\wedge 1} + \left(n\delta_n^s\right)^{\frac{1+(H\wedge 1)}{s-1}} + \left(n\delta_n\right)^{2-4\rho}$. Then, following the same method that in Bardet and Bertrand (2007b), pp. 33-35, one obtains

$$\mathbb{E}|I_n(a) - J_n(a)| \le C v_n(a)^{1/2},\tag{4.26}$$

and from this, Lemmas 4.6 and Slutsky Lemma, the proof is achieved.

4.4 Proof of Proposition 2.2

Proof. It is obvious that

$$\mathcal{I}_{\lambda}(a) = \int_{\mathbb{R}} |\widehat{\psi}_{\lambda}(\xi)|^{2} f(\xi/a) d\xi = \lambda \int_{\mathbb{R}} |\widehat{\psi}(\lambda(\xi-1))|^{2} f(\xi/a) d\xi$$
$$= \int_{\mathbb{R}} |\widehat{\psi}(v)|^{2} f(\frac{1}{a} + \frac{v}{a\lambda}) dv.$$

Then, from a usual Taylor expansion, and since $\widehat{\psi}$ is supposed to be an even function supported in $[-\Lambda, \Lambda]$,

$$\left| \mathcal{I}_{\lambda}(a) - \left\| \widehat{\psi} \right\|_{\mathcal{L}^{2}(\mathbb{R})}^{2} f(1/a) \right| \leq \frac{1}{2a^{2}\lambda^{2}} \left(\sup_{-\Lambda/\lambda < h} \left\{ \left| f''\left(\frac{1+h}{a}\right) \right| \right\} \int_{-\Lambda}^{\Lambda} v^{2} \left| \widehat{\psi}(v) \right|^{2} dv \right).$$

For $\lambda > 2\Lambda$, then $\sup_{-\Lambda/\lambda \le h} \left\{ \left| f''(\frac{1+h}{a}) \right| \right\} \le \sup_{x>1/2a} \left\{ \left| f''(x) \right| \right\} < \infty$. Therefore, since ψ satisfies Assumption W(1,5), there exists C > 0 such that,

$$\left| \mathcal{I}_{\lambda}(a) - \left\| \widehat{\psi} \right\|_{\mathcal{L}^{2}(\mathbb{R})}^{2} f(1/a) \right| \le C \frac{1}{\lambda^{2}}. \tag{4.27}$$

Let us denote $I_n^{(\lambda)}(a)$ (respectively $\mathcal{I}_{\lambda}(a)$, $\beta_n^{(\lambda)}$ and $S_n^{(\lambda)}(a)$) instead on $I_n(a)$ (resp. $\mathcal{I}_1(a)$, β_n and $S_n(a)$) when ψ is replaced by ψ_{λ} . Firstly,

$$\frac{1}{\lambda} \left(4\pi a^2 \int_{\mathbb{R}} \left| \widehat{\psi_{\lambda}}(az) \right|^4 f^2(z) \, dz \right) = 4\pi a \int_{\mathbb{R}} \left| \widehat{\psi}(u) \right|^4 f^2 \left(\frac{1}{a} + \frac{u}{a\lambda} \right) du$$

$$\xrightarrow{\lambda \to \infty} 4\pi a f^2 (1/a) \int_{\mathbb{R}} \left| \widehat{\psi}(u) \right|^4 du,$$

from Lebesgue Theorem. Hence, if (λ_n) is a sequence such that $\lambda_n \underset{n \to \infty}{\longrightarrow} \infty$,

$$\frac{I\!\!E(T_n)}{\lambda_n} \left(S_n^{(\lambda_n)}(a) \right)^2 \underset{n \to \infty}{\longrightarrow} 4\pi \, a \, f^2(1/a) \, \int_{\mathbb{R}} \left| \widehat{\psi}(u) \right|^4 du. \tag{4.28}$$

Secondly, from the proof of Proposition 4.1 and inequalities (4.12) and (4.13), there exists C > 0 not depending on n and λ ,

$$\beta_n^{(\lambda)}/S_n^{(\lambda)} \le C \mathcal{I}_{\lambda}^{-1}(a) \left(n \max_{1 \le k \le n} |c_{k+1} - c_k| \right)^{1/2 - 1/q}$$
 for all $q \in (1, 2)$.

Thus, since $\mathcal{I}_{\lambda}(a)$ is bounded, $\beta_n^{(\lambda_n)}/S_n^{(\lambda_n)} \xrightarrow[n \to \infty]{} 0$ and Proposition 4.1 becomes:

$$\frac{I_n^{(\lambda_n)}(a) - \mathcal{I}_{\lambda_n}(a)}{S_n^{(\lambda_n)}(a)} \xrightarrow[n \to \infty]{\mathcal{D}} \mathcal{N}(0,1).$$

Finally, using (4.27) and (4.28), on deduces that for all a > 0,

$$\sqrt{\frac{I\!\!E T_n}{\lambda_n}} \big(I_n^{(\lambda_n)}(a) - \big\|\psi\big\|_{\mathcal{L}^2(I\!\!R)}^2 f(1/a)\big) \underset{n \to \infty}{\xrightarrow{\mathcal{D}}} \mathcal{N}\Big(0, 4\pi a f^2(1/a) \int_{I\!\!R} \big|\widehat{\psi}(u)\big|^4 du\Big),$$

when $(\lambda_n)_n$ is such that $\sqrt{\frac{ET_n}{\lambda_n}} \frac{1}{\lambda_n^2} \xrightarrow[n \to \infty]{} 0$, i.e. when $\lambda_n^{-5} n \, \delta_n \xrightarrow[n \to \infty]{} 0$. Since also $\lambda_n^{-1} n \delta_n \xrightarrow[n \to \infty]{} \infty$ (to obtain a consistent estimator), then with $\delta_n = n^{-d}$ and $\lambda_n = n^{d'}$,

$$\frac{1-d}{5} < d' < 1-d. \tag{4.29}$$

Moreover, Proposition 4.2 has also to be checked. In its proof, $\mathbb{E}\tau_n$ has to be replaced by $\mathbb{E}\tau_n/\lambda_n$ and since the bounds $C(1 \wedge |\theta|^{-1})$ in Lemma 4.2 have to be replaced by $C/\lambda_n^2(1 \wedge |\theta|^{-1})$, then condition $n\delta_n^2 \xrightarrow[n \to \infty]{} 0$ has to be replaced by $n\delta_n^2/\lambda_n^5 \xrightarrow[n \to \infty]{} 0$, that is $d' > \frac{1-2d}{5}$ which is satisfied when (4.29) is satisfied.

It remains to control $\varepsilon_n^2(a, c_k)$ with Lemma 4.5 and 4.6. For all $1 \le q \le \infty$, with $1/\infty = 0$ by convention,

$$\|\psi_{\lambda}\|_{\mathcal{L}^q} = \lambda^{(2-q)/2q} \|\psi\|_{\mathcal{L}^q} \quad \text{and} \quad \|\widehat{\psi}_{\lambda}\|_{\mathcal{L}^q} = \lambda^{(q-2)/2q} \|\widehat{\psi}\|_{\mathcal{L}^q}.$$

Then, Lemma 4.5 becomes (with $\lambda_n \longrightarrow_{n \to \infty} \infty$):

+ \|\psi\|_{\mathcal{L}^{q_{1}}}^{2} \lambda_{n}^{\frac{2}{q_{1}}-1} \left(\sum_{i=0}^{n-1} L_{i}^{p_{1}+1} \right)^{2/p_{1}} \delta_{n}^{2+2/p_{1}} \right\}, & \text{if } s < \infty.
\end{cases}$$

The case $s < \infty$ can be more detailed following the values of p_1 and p_2 considered in Lemma 4.6:

$$2 \vee \left(\frac{1}{2} + \frac{1}{2H}\right) < s \le \frac{3}{2} + \frac{1}{2H}$$
, then $2/p_1 = s - 2$ or $2/p_1 = \frac{2}{s-1}$ and $1/p_2 = H\left(s - \left(\frac{1}{2} + \frac{1}{2H}\right)\right)$ and therefore $\mathbb{E}\left(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X\right) \le C\left(\lambda_n^{3-s}\left(n\,\delta_n^s\right) + \lambda_n^{\frac{s-3}{s-1}}\left(n\,\delta_n^s\right)^{\frac{2}{s-1}} + \lambda_n^{1-2H\left(s - \left(\frac{1}{2} + \frac{1}{2H}\right)\right)}\left(n\,\delta_n^s\right)^{2H}\right)$

$$\implies \mathbb{E}\left(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X\right) \le C'\,\lambda_n\left(n\,\delta_n^s\right)^{2H};$$
• $\frac{3}{2} + \frac{1}{2H} \le s$, then $2/p_1 = s - 2$ or $2/p_1 = \frac{2}{s-1}$ and $1/p_2 = (1+H)/(2(s+1))$ and therefore
$$\mathbb{E}\left(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X\right) \le C\left(\lambda_n^{3-s}\left(n\,\delta_n^s\right) + \lambda_n^{\frac{s-3}{s-1}}\left(n\,\delta_n^s\right)^{\frac{2}{s-1}} + \lambda_n^{1-2H\left(s - \left(\frac{1}{2} + \frac{1}{2H}\right)\right)}\left(n\,\delta_n^s\right)^{2H}\right)$$

$$\implies \mathbb{E}\left(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X\right) \le C'\,\lambda_n\left(n\,\delta_n^s\right)^{\frac{1+H}{s-1}}.$$

Note that the bound is not always optimal but it simplifies a lot of different subcases. Condition (4.25) is now $\frac{n \, \delta_n}{\lambda_n} \mathbb{E}(\left|\varepsilon_{1,n}(a,b)\right|^2 \mid \mathcal{F}_X) \xrightarrow[n \to \infty]{} 0$. Therefore in any case this condition does not depend on λ_n and it can be summarize with $\delta_n = n^{-d}$ with (the case $s = \infty$ is obtained by replacing with the limit):

$$\leq C_{f}\left(a^{3}\lambda_{n}^{3}\right)\left(\int_{T_{n}^{\rho}/a\lambda_{n}}^{\infty}\left|\psi(u)\right|u\,du\right)^{2}$$

$$\leq \frac{1}{9}C_{f}C_{\psi}\left(a^{3}\lambda_{n}^{3}\right)\left(\left[u^{-3}\right]_{T_{n}^{\rho}/a\lambda_{n}}^{\infty}\right)^{2}\leq \frac{1}{9}C_{f}C_{\psi}\,a^{9}\lambda_{n}^{9}T_{n}^{-6\rho}.$$

Therefore the CLT holds when $\lambda_n^9 (n \, \delta_n)^{1-6\rho} \underset{n \to \infty}{\longrightarrow} 0$, i.e. $\frac{n \delta_n}{\lambda_n^2} \underset{n \to \infty}{\longrightarrow} \infty$ since $\rho > 3/4$.
