# Long-time extinction of solutions of some semilinear parabolic equations

#### Abstract

We study the long time behaviour of solutions of semi-linear parabolic equation of the following type $\partial_{t} u-\Delta u+a_{0}(x) u^{q}=0$ where $a_{0}(x) \geq d_{0} \exp \left(-\frac{\omega(|x|)}{|x|^{2}}\right), d_{0}>0$, $1>q>0$ and $\omega$ a positive continuous radial function. We give a Dini-like condition on the function $\omega$ by two different method which implies that any solution of the above equation vanishes in a finite time. The first one is a variant of a local energy method and the second one is derived from semi-classical limits of some Schrödinger operators.


Key words: nonlinear equation, energy method, vanishing solutions, semi-classical analysis

## 1 Introduction

Let $\Omega \subset \mathbb{R}^{N}, N \geq 1$, be a bounded domain with $C^{1}$-boundary, $0 \in \Omega$. The aim of this paper is to investigate the time vanishing properties of generalized (energy) solutions of initial-boundary problem to a wide class of quasilinear parabolic equations with the model representative:

where $0<q<1, a_{0}(x) \geq 0$ and $u_{0} \in L_{2}(\Omega)$. It is easy to see that if $a_{0}(x) \geq \varepsilon>0$, then the comparison with the solution of corresponding ordinary equation $\varphi_{t}+\varepsilon|\varphi|^{q-1} \varphi=0$ implies that the solution $u(x, t)$ of (1.1) vanishes for $t \geq T_{0}=\varepsilon^{-1}(1-q)^{-1}\left\|u_{0}\right\|_{L_{\infty}}^{1-q}$. The property that any solution of problem (1.1) becomes identically zero for $t$ large enough is called the time compact support property (TCS-property). On the opposite, if $a_{0}(x) \equiv 0$ for any $x$ from some connected open subset $\omega \subset \Omega$, then any solution $u(x, t)$ of problem (1.1) is bounded from below by $\sigma \exp \left(-t \lambda_{\omega}\right) \varphi_{\omega}(x)$ on $\omega \times(0, \infty)$, where $\sigma=\operatorname{essinf}_{\omega} u_{0}>0, \lambda_{\omega}$ and $\varphi_{\omega}$ are first eigenvalue and corresponding eigenfunction of $-\Delta$ in $W_{0}^{1,2}(\omega)$. It was Kondratiev and Veron [1] who first proposed a method of investigation of conditions of appearance of TCS-property in the case of general potential $a_{0} \geq 0$. They introduced the fundamental states of the associated Schrödinger operator
$\mu_{n}=\inf \left\{\int_{\Omega}\left(|\nabla \psi|^{2}+2^{n} a_{0}(x) \psi^{2}\right) d x: \psi \in W^{1,2}(\Omega), \quad \int_{\Omega} \psi^{2} d x=1\right\}, \quad n \in \mathbb{N}$,
and proved that, if

then (1.1) possesses the TCS-property. Starting from condition (1.3) in [2] an explicit conditions of appearance of TCS-property in terms of potential $a_{0}(x)$ was obtained. The analysis in [2] was based on the so-called semiclassical analysis [9], which uses sharp estimates of the spectrum of the Schrödinger operator $[6,10,11]$. Particularly, in the case of existence of the radially symmetric minorant

the following statements was obtained in [2]:
Proposition 1.1 (Th. 4.5 from [2]) In equation (1.1) let $a_{0}(x)=a(|x|)$, where $a(r)$ is defined by (1.4). Let $u_{0}(x) \geq \nu>0 \forall x \subseteq \bar{\Omega}$ and $\omega(r) \rightarrow \infty$ as $r \rightarrow 0$. Then arbitrary solution $u$ of problem (1.1) never vanishes on $\Omega$.

Proposition 1.2 (Corollary of Th. 3.1 in [2]) If in assumption (1.4) $a_{0}(x)=a(|x|)$ and $\omega(r)=r^{\alpha}$ with $0<\alpha<2$ then an arbitrary solution of (1.1) enjoys the TCS-property.

Thus, an open problem is to find sharp border which distinguish two different decay properties of solutions, described in Proposition 1.1 and Proposition 1.2. Moreover, the method of investigations used in [2,1] exploits essentially some regularity properties of solutions under consideration, particularly, sharp upper estimates of $\|u(x, t)\|_{L_{\infty}(\Omega)}$ with respect to $t$. Such an estimate is difficult to obtain or is unknown for solutions of equations of more general structure than (1.1). Particularly, it is absolutely impossible to have any information about such a behaviour for higher order parabolic equations. We propose here some new energy method of investigations, which deals with energy norms of solutions $u(x, t)$ only and, therefore, may be applied, particularly, for higher order equations, too.

We suppose that function $\omega(s)$ from condition (1.4) satisfies the conditions:
$\left(A_{1}\right) \quad \omega(r)$ is continuous and nondecreasing function $\forall r \geq 0$,
$\left(A_{2}\right) \quad \omega(0)=0, \omega(r)>0 \forall r>0$.
$\left(A_{3}\right) \quad \omega(s) \leq \omega_{0}<\infty \quad \forall s \in \mathbb{R}_{+}^{1}$
Our main result reads as follows
Theorem 1.1 Let $u_{0}(x)$ be an arbitrary function from $L_{2}\left(B_{1}\right)$, let function $\omega(r)$ from (1.4) satisfy assumptions $\left(A_{1}\right),\left(A_{2}\right),\left(A_{3}\right)$ and the following main condition:

\end{equation*}

Suppose also that $\omega(r)$ satisfies the following technical condition

Then an arbitrary energy solution $u(x, t)$ of the problem (1.1) vanishes on $\Omega$ in some finite time $T<\infty$.

In the sequel of the paper we show that the sufficiency of the Dini condition (1.5) for the validity of TCS-property can be proved also by the methods from [1,2] if one uses $L_{\infty}$ estimates of solution $u(x, t)$ of problem (1.1). This leads to the following result.

Proposition 1.3 The assertion of Theorem 1.1 holds if the function $\omega(s)$ satisfies conditions $\left(A_{1}\right)-\left(A_{3}\right)$, the Dini condition (1.5) and the following similar to (1.6) technical conditions:

\omega(s) \geq s^{2-\delta} \quad \forall s \in\left(0, s_{0}\right), s_{0}>0,2>\delta>0,  \tag{1.7}\\
\text { the function } \frac{\omega(s)}{s^{2}} \text { is decreasing on }\left(0, s_{0}\right) . \tag{1.8}
\end{gather*}
$$

Remark 1.1 It is easy to check that the function $\omega(s)=\left(\ln s^{-1}\right)^{-\beta}$ satisfies all the conditions of Theorem 1.1 and Proposition 1.3 for arbitrary $\beta>1$.

## 2 The proof of main result

The proof of Theorem 1.1 is based on some variant of the local energy method, which was developed, particularly in [3,4]. First, we introduce the following families of subdomains:

\Omega(\tau)=\Omega \cap\{|x|>\tau\}, \quad Q_{s}^{(T)}(\tau)=\Omega(\tau) \times(s, T), \quad T<\infty .

Definition 2.1 An energy solution of problem (1.1) is the function $u(x, t) \in$ $L_{2}\left(0, T ; W_{2}^{1}(\Omega)\right): \frac{\partial u}{\partial t} \in L_{2}\left(0, T ;\left(W_{2}^{1}(\Omega)\right)^{*}\right), u(x, 0)=u_{0}$, satisfying the following integral identity:

for arbitrary $\varphi \in L_{2}\left(0, T ; W_{2}^{1}(\Omega)\right) \forall T<\infty$.
Lemma 2.1 An arbitrary energy solution $u$ of the problem (1.1) satisfies the following global a priory estimate

Testing integral identity (2.1) by $\varphi(x, t)=u(x, t) \xi(x)$, where $\xi(x)$ is arbitrary $C^{1}$-function, due to formula of integration by parts [8], we derive the following equality:

& \quad+\int_{\Omega \times(s, \hat{t})} a_{0} \xi|u|^{q+1} d x d t=2^{-1} \int_{\Omega}|u(x, s)|^{2} \xi d x, \quad 0 \leq s<\hat{t}<\infty . \tag{2.3}

Let $\eta(r) \in C^{1}\left(\mathbb{R}^{1}\right)$ be such that $0 \leq \eta(r) \leq 1 \forall r \in \mathbb{R}^{1}, \eta(r)=0$ if $r \leq$ $0, \eta(r)=1$ if $r>1$. Fix arbitrary numbers $\tau>0, \nu>0$ and test (2.3) by

Then passing to the limit $\nu \rightarrow 0$ we obtain

& \quad=2^{-1} \int_{\Omega(\tau)}|u(x, s)|^{2} d x+\int_{s}^{\hat{t}} \int_{|x|=\tau} u \frac{\partial u}{\partial n} d \sigma d t \quad \forall \hat{t}: s<\hat{t}<\infty . \tag{2.4}
\end{align*}

From (2.4) with $\tau=0, s=0$ the necessary global estimate (2.2) follows. Further we will denote by $c, c_{i}$ different positive constants which depend on known parameters of the problem (1.1) only. Let us introduce the energy functions related to a fixed energy solution $u$ of problem (1.1):

E(t, \tau)=\int_{\Omega(\tau)}\left(\left|\nabla_{x} u(x, t)\right|^{2}+a(|x|)|u(x, t)|^{q+1}\right) d x \\
J_{s}^{(v)}(\tau)=\int_{s}^{v} \int_{|x|=\tau}\left|\nabla_{x} u\right|^{2} d x d t .
\end{gather*}

Lemma 2.2 Energy functions (2.5) related to arbitrary solution u of problem (1.1) satisfy the following relationship:

& +c_{1} a(\tau)^{-\frac{2}{q+1}} E(s, \tau)^{\frac{2}{q+1}}+c a(\tau)^{-\frac{2}{q+1}} J_{s}^{(T)}(\tau)^{\frac{2}{q+1}} \\
& +c a(\tau)^{-\frac{2\left(1-\theta_{1}\right)}{2-\left(1-\theta_{1}\right)(1-q)} J_{s}^{(T)}(\tau)^{\frac{(2}{2-\left(1-\theta_{1}\right)(1-q)}}}, \\
& \quad 0<\theta_{1}=\frac{(q+1)+n(1-q)}{2(q+1)+n(1-q)}<1, \quad \theta_{2}=\frac{n(1-q)}{2(q+1)+n(1-q)} . \tag{2.6}

Let us estimate the second term in right hand side of (2.4). By interpolation (see, for example, [7]) we have:

& +d_{2}\left(\int_{\Omega(\tau)}|u|^{q+1} d x\right)^{\frac{2}{q+1}} \forall \tau>0, \theta_{1} \text { is from (2.6). } \tag{2.7}
\end{align*}

Using (2.7) we easily arrive at

& \quad \times\left(\int_{\Omega(\tau)}\left|\nabla_{x} u\right|^{2} d x\right)^{\frac{\theta_{1}}{2}}\left(\int_{\Omega(\tau)}|u|^{q+1} d x\right)^{\frac{1-\theta_{1}}{2}}\left(\int_{\Omega(\tau)}|u|^{q+1} d x\right)^{\frac{(1-q)\left(1-\theta_{1}\right)}{2(q+1)}} \\
& \quad+c\left(\int_{|x|=\tau}\left|\nabla_{x} u\right|^{2} d \sigma\right)^{1 / 2}\left(\int_{\Omega(\tau)}|u|^{q+1} d x\right)^{1 / 2}\left(\int_{\Omega(\tau)}|u|^{q+1} d x\right)^{\frac{1-q}{2(q+1)}} \tag{2.8}
\end{align*}

From condition (1.6) the monotonicity of function $a(s)$ from (1.4) follows easily. Therefore we can continue estimating (2.8) as follows:

& \quad \times\left(\int_{\Omega(\tau)}|u|^{2} d x\right)^{\frac{(1-q)\left(1-\theta_{1}\right)}{4}} a(\tau)^{-\frac{1-\theta_{1}}{2}}\left(\int_{\Omega(\tau)}\left(\left|\nabla_{x} u\right|^{2}+a(|x|)\left|u^{q+1}\right|\right) d x\right)^{1 / 2} \\
& +c_{1} a(\tau)^{-1 / 2}\left(\int_{\Omega(\tau)}|u|^{2} d x\right)^{\frac{1-q}{4}}\left(\int_{|x|=\tau}\left|\nabla_{x} u\right|^{2} d \sigma\right)^{1 / 2}\left(\int_{\Omega(\tau)} a(|x|)|u|^{q+1} d x\right)^{1 / 2} . \tag{2.9}
\end{align*}
$$

Integrating (2.9) in $t$ and using the Young inequality with " $\varepsilon$ " we obtain:

& +c(\varepsilon) a(\tau)^{-\left(1-\theta_{1}\right)} \sup _{s<t<v}\left(\int_{\Omega(\tau)}|u(x, t)|^{2} d x\right)^{\frac{(1-q)\left(1-\theta_{1}\right)}{2}} \int_{s}^{v} \int_{|x|=\tau}\left|\nabla_{x} u\right|^{2} d \sigma d t \\
& \quad+c(\varepsilon) a(\tau)^{-1} \sup _{s<t<v}\left(\int_{\Omega(\tau)}|u(x, t)|^{2} d x\right)^{\frac{1-q}{2}} \int_{s}^{v} \int_{|x|=\tau}\left|\nabla_{x} u\right|^{2} d \sigma d t \quad(2.1 \tag{2.10}
\end{align*}

with arbitrary $v: s<v \leq T$. Let us fix now $v=\bar{v}=\bar{v}(\tau, s)$ such that the following inequality holds:

Inserting inequality (2.10) with $v=\bar{v}$ into (2.4) with $\hat{t}=\bar{v}$ and fixing " $\varepsilon$ " small enough we have:

where $J_{s}^{(v)}(\tau)$ is from (2.5). Using the Young inequality again we deduce from (2.12):

Fixing now $v=T$ in (2.10) and using property (2.11) we obtain the inequality:

By $\hat{t}=T$ it follows from (2.4) due to (2.14) with $\varepsilon=\frac{1}{2}$ :

Using this estimate with $\nu_{1}=\frac{(1-q)\left(1-\theta_{1}\right)}{2}$ and $\nu_{2}=\frac{1-q}{2}$ from (2.15) we deduce that

\frac{\left(\tau^{\prime \prime \prime}\right)^{2}}{\omega\left(\tau^{\prime \prime \prime}\right)} \leq c_{7}\left(\ln y_{0}^{-1}\right)^{-1}, \quad c_{7}=c_{7}\left(c_{6}, \nu, \omega_{0}\right), \quad \omega_{0} \quad \text { is from } \quad\left(A_{3}\right) \tag{2.48}
\end{equation*}
$$

Thus, the assertion of Lemma 2.4 holds with $\bar{\tau}(r)$ defined by:

\begin{equation*}
\frac{\bar{\tau}(r)^{2}}{\omega(\bar{\tau}(r))}=c_{7}\left(\ln r^{-1}\right)^{-1} \quad \forall r>0 \tag{2.49}
\end{equation*}
$$

Proof of Theorem 1.1. Due to Lemma A. 3 from Appendix we can suppose that

From definition (2.23) of function $y(\tau)$ due to Lemma 2.4 and property (2.29) it follows that

Therefore our solution $u(x, t)$ has the following property:

\end{equation*}

Due to (2.51) and the Poincaré inequality it follows from (2.52):

where $H(t):=H(t, 0), H(t, \tau)$ is defined by (2.9), constant $\bar{c}>0$ does not depend on $t$. Integrating ODI (2.53) we deduce the following relationship easily:

\end{equation*}

Due to (2.49) from (2.55) it follows that

t_{1}=\frac{\gamma c_{7}}{\bar{c}} \omega\left(\tau_{1}\right) \tag{2.56}
\end{equation*}

So, we finished first round of computations. For the second round we will consider our initial-boundary problem (1.1) in the domain $\Omega \times\left(t_{1}+s\left(\tau_{1}\right), \infty\right)$ with initial data (2.57) instead of (2.2). Repeating all previous computations we deduce the following analogue of estimate (2.57)

\end{equation*}
$$

Analogously to (2.56) we have also:

Due to condition $\left(A_{3}\right)$ it follows from (2.62):

From definition (2.21) of function $s(\tau)$ due to condition (1.6) it follows the estimate

Therefore inequality (2.62) yields:

Obviously, we have also: $t_{i}=\frac{\gamma c 7}{\bar{c}} \omega\left(\tau_{i}\right)$. Therefore, due to (2.62) we have:

where $C=\frac{\gamma c_{7}}{\bar{c}}, \quad C_{1}=\left(\frac{c_{7} \omega_{0}}{\ln y_{0}^{-1}(1+\gamma)}\right)^{1 / 2}, \lambda=(1+\gamma)^{-1 / 2}<1$. In virtue of condition (1.5) it is easy to check that

## 3 Dini condition (1.5) of extinction in finite time via semi-classical limit of Schrödinger operator

Here we prove Proposition 1.3. We recall the definition of $\lambda_{1}(h)$ and $\mu(\alpha)$ for $h>0$ and $\alpha>0$ :

We define $r(z)=a^{-1}(z)$ or equivalently $z=a(r(z))$ and $\rho(z)=z(r(z))^{2}$ for $z$ small enough. We will use the following technical statement

Lemma 3.1 (Corollaries 2.23, 2.31 in [5]) Under assumptions $\left(A_{1}\right)-\left(A_{3}\right)$ and (1.8), there exist four positives constants $C_{1}, C_{2}, C_{3}$ and $C_{4}$ such that for $h$ small enough,

C_{1} h^{-2} \rho^{-1}\left(C_{2} h^{2}\right) \leq \lambda_{1}(h) \leq C_{3} h^{-2} \rho^{-1}\left(C_{4} h^{2}\right) .
$$

Our main starting point in the proof of Proposition 1.3 is the following

Theorem A (Th. 2.2 in [2]). Under assumptions $\left(A_{1}\right)-\left(A_{3}\right)$, if there exists a decreasing sequence ( $\alpha_{n}$ ) of positive real numbers such that

\sum_{n=0}^{+\infty} \frac{1}{\mu\left(\alpha_{n}\right)}\left(\ln \left(\mu\left(\alpha_{n}\right)\right)+\ln \left(\frac{\alpha_{n}}{\alpha_{n+1}}\right)+1\right)<+\infty

then problem (1.1) satisfies the TCS-property.

The first step in the proof of Proposition 1.3 is the estimation of $\rho^{-1}$ in a neighbourhood of zero.

Lemma 3.2 Under assumptions $\left(A_{1}\right)-\left(A_{3}\right)$ with (1.7) there holds

$$
\begin{equation*}
\frac{s}{(1+\alpha)} \ln \left(\frac{1}{s}\right) \frac{1}{\omega\left(\left(\frac{\omega_{0}(1+\alpha)}{\ln \left(\frac{1}{s}\right)}\right)^{\frac{1}{2}}\right)} \leq \rho^{-1}(s) \leq s \ln \left(\frac{1}{s}\right) \frac{1}{\omega\left(\left(\frac{1}{\ln \left(\frac{1}{s}\right)}\right)^{\frac{1}{\delta}}\right)} \tag{3.1}
\end{equation*}
$$

for arbitrary $\alpha>0$, for all $s>0$ small enough.
First of all, we prove the following estimate for $\rho(z)$ :

$$

\rho(z) \ln \left(\frac{1}{z}\right)\left[\omega\left(\left(\frac{\omega_{0}}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{2}}\right)\right]^{-1} \leq z \leq \rho(z) \ln \left(\frac{1}{z}\right)\left[\omega\left(\left(\frac{1}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{\delta}}\right)\right]^{-1}(3 . \tag{3.2}
\end{equation*}
$$

Starting with $r>0$ small enough, we have from (1.7) the relationship $r^{2-\delta} \leq \omega(r) \leq \omega_{0}$ and since for $z>0$ small enough,

(r(z))^{2} \ln \left(\frac{1}{z}\right)=\omega(r(z)) \Longrightarrow r(z)^{2-\delta} \leq(r(z))^{2} \ln \left(\frac{1}{z}\right) \leq \omega_{0}
$$

Therefore, we obtain

\left(\frac{1}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{\delta}} \leq r(z) \leq\left(\frac{\omega_{0}}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{2}} . \tag{3.3}
\end{equation*}
$$

Since $\omega$ is a non decreasing function,

\omega\left(\left(\frac{1}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{\delta}}\right) \leq \omega(r(z)) \leq \omega\left(\left(\frac{\omega_{0}}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{2}}\right) .
$$

Substituting the definition of $\omega(r)$,

\omega\left(\left(\frac{1}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{\delta}}\right) \leq(r(z))^{2} \ln \left(\frac{1}{z}\right) \leq \omega\left(\left(\frac{\omega_{0}}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{2}}\right) .
$$

It follows the estimate for $\rho(z)$.

$$
\begin{equation*}
z \frac{1}{\ln \left(\frac{1}{z}\right)} \omega\left(\left(\frac{1}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{\delta}}\right) \leq \rho(z) \leq z \frac{1}{\ln \left(\frac{1}{z}\right)} \omega\left(\left(\frac{\omega_{0}}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{1}{2}}\right) . \tag{3.4}
\end{equation*}
$$

By an easy calculation, we have (3.2).
Here and further, $z=\rho^{-1}(s)$. By using (3.3) and $\rho(z)=z(r(z))^{2}$,

\rho(z) \geq z\left(\frac{1}{\ln \left(\frac{1}{z}\right)}\right)^{\frac{2}{\delta}} \Longleftrightarrow \frac{1}{\rho(z)} \leq \frac{1}{z}\left(\ln \left(\frac{1}{z}\right)\right)^{\frac{2}{\delta}}
$$

or equivalently,

\ln \left(\frac{1}{\rho(z)}\right) \leq \ln \left(\frac{1}{z}\right)+\frac{2}{\delta} \ln \left(\ln \left(\frac{1}{z}\right)\right) .
$$

Let $\alpha>0$. Then for $z$ small enough, since $\ln \left(\ln \left(z^{-1}\right)\right) \ll \ln z^{-1}$,

\frac{s}{(1+\alpha)} \ln \left(\frac{1}{s}\right)\left[\omega\left(\left(\frac{\omega_{0}(1+\alpha)}{\ln \left(\frac{1}{s}\right)}\right)^{\frac{1}{2}}\right)\right]^{-1} \leq \rho^{-1}(s)
$$

since $\omega$ is a nondecreasing function.
For the right-hand side of (3.1), we substitute $z=\rho^{-1}(s)$ in (3.2).

\rho^{-1}(s) \leq s \ln \left(\frac{1}{\rho^{-1}(s)}\right)\left[\omega\left(\left(\frac{1}{\ln \left(\frac{1}{\rho^{-1}(s)}\right)}\right)^{\frac{1}{\delta}}\right)\right]^{-1} .
$$

But from (3.3), $r(z) \rightarrow z$ so we have for $z$ small enough, $\rho(z) \leq z$, which gives $\rho^{-1}(s) \geq s$. Consequently,

\rho^{-1}(s) \leq s \ln \left(\frac{1}{s}\right)\left[\omega\left(\left(\frac{1}{\ln \left(\frac{1}{s}\right)}\right)^{\frac{1}{\delta}}\right)\right]^{-1}

which completes the proof.
Lemma 3.3 Under $\left(A_{1}\right)-\left(A_{3}\right)$ with (1.7) and (1.8), if

\sum_{n=n_{0}}^{+\infty} \frac{\omega\left(\frac{1}{(n \ln n)^{\frac{1}{2}}}\right)}{n}<+\infty \tag{3.6}
\end{equation*}
$$

then all solutions of (1.1) vanish in a finite time. Moreover,

$$
\begin{equation*}
\sum_{n=n_{0}}^{+\infty} \frac{\omega\left(\frac{1}{(n \ln n)^{\frac{1}{2}}}\right)}{n}<+\infty \Longleftrightarrow \int_{0}^{c} \frac{\omega(x)}{x} d x<+\infty \tag{3.7}
\end{equation*}
$$

From Lemma 3.3 and Lemma 3.1 we get

K_{1} \ln \left(\frac{1}{h}\right) \omega\left(\frac{K_{2}}{\left(\ln \left(\frac{1}{h}\right)\right)^{\frac{1}{2}}}\right) \leq \lambda_{1}(h) \leq K_{3} \ln \left(\frac{1}{h}\right)\left[\omega\left(\frac{K_{4}}{\left(\ln \left(\frac{1}{h}\right)\right)^{\frac{1}{\delta}}}\right)\right]^{-1}
$$

and since $\omega(r) \geq r^{\theta}$ for $r$ small enough, we have

K_{1} \ln \left(\frac{1}{h}\right)\left[\omega\left(\frac{K_{2}}{\left(\ln \left(\frac{1}{h}\right)\right)^{\frac{1}{2}}}\right)\right]^{-1} \leq \lambda_{1}(h) \leq K_{3}^{\prime} \ln \left(\frac{1}{h}\right)^{1+\frac{2-\delta}{\delta}},
$$

which leads to

$$
\begin{equation*}
C_{1}^{\prime} \ln \left(\frac{1}{h}\right)\left[\omega\left(\frac{C_{2}^{\prime}}{\left(\ln \left(\frac{1}{h}\right)\right)^{\frac{1}{2}}}\right)\right]^{-1} \leq \lambda_{1}(h) \leq C_{3}^{\prime} \ln \left(\frac{1}{h}\right)^{\frac{2}{\delta}} . \tag{3.8}
\end{equation*}
$$

The real number $\alpha$ is defined by $h=\alpha^{\frac{1-q}{2}}$ and thus,

$$
C_{1}^{\prime \prime} \ln \left(\frac{1}{\alpha}\right)\left[\omega\left(\frac{C_{2}^{\prime \prime}}{\left(\ln \left(\frac{1}{\alpha}\right)\right)^{\frac{1}{2}}}\right)\right]^{-1} \leq \mu(\alpha) \leq C_{3}^{\prime \prime} \ln \left(\frac{1}{\alpha}\right)^{\frac{2}{\delta}} .
$$

From Theorem A , if $\left(\alpha_{n}\right)$ is a decreasing sequence of positive real numbers and

$$
\sum_{n=n_{0}}^{+\infty} \frac{\omega\left(\frac{C_{2}^{\prime \prime}}{\left(\ln \left(\frac{1}{\alpha_{n}}\right)\right)^{\frac{1}{2}}}\right)}{\ln \left(\frac{1}{\alpha_{n}}\right)}\left[\ln \left(\ln \left(\frac{1}{\alpha_{n}}\right)\right)+\ln \left(\frac{\alpha_{n}}{\alpha_{n+1}}\right)+1\right]<+\infty
$$

then all the solutions of (1.1) vanish in a finite time.
The main point is the sequence $\left(\alpha_{n}\right)$. In [2], they set $\alpha_{n}=2^{-n}$. A better choice is $\alpha_{n}=n^{-K n}$ for some $K>0$ since $\ln \left(\ln \left(\frac{1}{\alpha_{n}}\right)\right) \sim \ln \left(\frac{\alpha_{n}}{\alpha_{n+1}}\right)$ which leads to (3.6).
Now, we have to show that

$$
\sum_{n=n_{0}}^{+\infty} \frac{\omega\left(\frac{1}{(n \ln n)^{\frac{1}{2}}}\right)}{n}<+\infty \Longleftrightarrow \int_{0}^{c} \frac{\omega(x)}{x} d x<+\infty
$$

The series is finite if and only if $\int_{n_{0}}^{+\infty} \frac{\omega\left(\frac{1}{(x \ln x)^{\frac{1}{2}}}\right)}{x} d x=\int_{0}^{1 / n_{0}} \frac{\omega\left(\left(\frac{x}{-\ln x}\right)^{\frac{1}{2}}\right)}{x} d x$ is finite. The following inequalities hold for $c>0$ small enough:

$$
\int_{0}^{c} \frac{\omega(x)}{x} d x \leq \int_{0}^{c} \frac{\omega\left(\left(\frac{x}{-\ln x}\right)^{\frac{1}{2}}\right)}{x} d x \leq \int_{0}^{c} \frac{\omega\left(x^{\frac{1}{2}}\right)}{x} d x=2 \int_{0}^{\sqrt{c}} \frac{\omega(x)}{x} d x
$$

which completes the proof of Proposition 1.3.

## 4 Appendix

Lemma A. 1 Let the nonnegative nondecreasing function $\omega(s), s \geq 0$, satisfy condition (1.6). Then for any $m \in \mathbb{R}^{1}, l \in \mathbb{R}^{1}, A>0$, one has

\times & {\left[(m+1)+l \frac{s \omega^{\prime}(s)}{\omega(s)}+\frac{A \omega(s)}{s^{2}}\left(2-\frac{s \omega^{\prime}(s)}{\omega(s)}\right)\right] \equiv s^{m} \omega(s)^{l} \exp \left(-\frac{A \omega(s)}{s^{2}}\right)\left[I_{1}+I_{2}+I_{3}\right] . } \tag{4.2}
\end{align*}
$$

Integrating condition (1.6) we get:

\omega(s) \geq s^{2-\delta} \quad \forall s \in\left(0, s_{0}\right), \tag{4.3}
\end{equation*}
$$

and, as a consequence, $\frac{\omega(s)}{s^{2}} \rightarrow \infty$ as $s \rightarrow 0$. Now due to (1.6) it follows that

\left(\int_{\Omega} v^{2}(x) d x\right)^{1 / 2} \leq c_{1}\left(\int_{\Omega}\left|\nabla_{x} v\right|^{2} d x\right)^{1 / 2}+c_{2}\left(\int_{\Omega_{0}}|v|^{\lambda} d x\right)^{1 / \lambda} \quad \forall v \in W_{2}^{1}(\Omega) \tag{4.4}
\end{equation*}
$$

where $\lambda: 1<\lambda \leq 2$, positive constants $c_{1}, c_{2}$ does not depend on $v$.
We start from the standard interpolation inequality

$$
\begin{equation*}
\left(\int_{\Omega} v^{2}(x) d x\right)^{1 / 2}<c_{1}\left(\int_{\Omega}\left|\nabla_{x} v\right|^{2} d x\right)^{1 / 2}+c_{2}\left(\int_{\Omega}|v|^{\lambda} d x\right)^{1 / \lambda} \quad \forall v \in W_{2}^{1}(\Omega), \tag{4.5}
\end{equation*}
$$

It is clear that

$$
\begin{equation*}
\left(\int_{\Omega}|v|^{\lambda} d x\right)^{1 / \lambda} \leq\left(\int_{\Omega_{0}}|v|^{\lambda} d x\right)^{1 / \lambda}+\left(\int_{\Omega \backslash \Omega_{0}}|v|^{\lambda} d x\right)^{1 / \lambda} \tag{4.6}
\end{equation*}
$$

Let $\Omega_{0}^{\prime}$ be a subdomain of $\Omega_{0}$ such that $\overline{\Omega^{\prime}}{ }_{0} \subset \Omega_{0}$. let $\xi(x) \geq 0$ be $C^{1}$-smooth function such that

$$
\begin{equation*}
\xi(x)=0 \quad \forall x \in{\overline{\Omega^{\prime}}}_{0}, \quad \xi(x)=1 \quad \forall x \in \Omega \backslash \Omega_{0} . \tag{4.7}
\end{equation*}
$$

Then we have due to the Poincaré inequality:

$$
\begin{align*}
& \left(\int_{\Omega \backslash \Omega_{0}}|v|^{\lambda} d x\right)^{1 / \lambda} \leq\left(\int_{\Omega \backslash \Omega_{0}^{\prime}}|v \xi|^{\lambda} d e\right)^{1 / \lambda} \\
& \quad \leq c\left(\int_{\Omega \backslash \Omega_{0}^{\prime}}\left|\nabla_{x}(b \xi)\right|^{\lambda} d x\right)^{1 / \lambda} \leq c\left(\int_{\Omega \backslash \Omega_{0}^{\prime}}|\nabla v|^{\lambda} d x\right)^{1 / \lambda} \\
& +  \tag{4.8}\\
& c\left(\int_{\Omega_{0} \backslash \Omega_{0}^{\prime}}|\nabla \xi|^{\lambda}|v|^{\lambda} d x\right)^{1 / \lambda} \leq c_{1}\left(\int_{\Omega \backslash \Omega_{0}^{\prime}}|\nabla v|^{2} d x\right)^{1 / 2}+c_{2}\left(\int_{\Omega_{0} \backslash \Omega_{0}^{\prime}}|v|^{\lambda} d x\right)^{1 / \lambda} .
\end{align*}
$$

From (4.5) due to (4.6)-(4.8) one obtains (4.4). Lemma A. 2 is proved.
Lemma A. 3 Let $u(x, t)$ be an arbitrary energy solution of problem (1.1). Then $H(t)=\int_{\Omega}|u(x, t)|^{2} d x \rightarrow 0$ as $t \rightarrow \infty$.

It is clear that there exists a constant $a_{0}>0$ and a subdomain $\Omega_{0} \subset \Omega$ such that $a(x) \geq a_{0}>0$ for all $x \in \bar{\Omega}_{0}$. From (2.54) it follows that

$$
\begin{equation*}
\frac{d}{d t} \int_{\Omega}|u(x, t)|^{2} d x+\int_{\Omega}\left|\nabla_{x} u(x, t)\right|^{2} d x+a_{0} \int_{\Omega_{0}}|u(x, t)|^{q+1} d x \leq 0 . \tag{4.9}
\end{equation*}
$$

Due to Lemma A. 2 we have

$$
\begin{equation*}
\varepsilon \int_{\Omega}|u|^{2} d x \leq \varepsilon c_{1} \int_{\Omega}\left|\nabla_{x} u\right|^{2} d x+\varepsilon c_{2}\left(\int_{\Omega_{0}}|u|^{q+1} d x\right)^{\frac{2}{1+q}} \quad \forall \varepsilon>0 . \tag{4.10}
\end{equation*}
$$

Adding (4.9) and (4.10) we get

$$
\begin{align*}
& \frac{d}{d t} \int_{\Omega}|u(x, t)|^{2} d x+\varepsilon \int_{\Omega}|u(x, t)|^{2} d x+\left(1-\varepsilon c_{1}\right) \int_{\Omega}\left|\nabla_{x} u\right|^{2} d x \\
& \quad+a_{0} \int_{\Omega_{0}}|u|^{q+1} d x-c_{2} \varepsilon\left(\int_{\Omega_{0}}|u|^{q+1 d x}\right)^{\frac{2}{q+1}} \leq 0 . \tag{4.11}
\end{align*}
$$

From (4.9) it follows that

$$
\begin{align*}
& \int_{\Omega}|u(x, t)|^{1+q} d x \leq(\operatorname{mes} \Omega)^{\frac{1-q}{2}}\left(\int_{\Omega}|u(x, t)|^{2} d x\right)^{\frac{q+1}{2}} \\
& \leq(\operatorname{mes} \Omega)^{\frac{1-q}{2}}\left(\int_{\Omega}\left|u_{0}(x)\right|^{2} d x\right)^{\frac{q+1}{2}}=(\operatorname{mes} \Omega)^{\frac{1-q}{2}} y_{0}^{\frac{q+1}{2}}=\widetilde{C}=\mathrm{const} \quad \forall t>0 \tag{4.12}
\end{align*}
$$

Now due to (4.12) we have

$$
\begin{align*}
& a_{0} \int_{\Omega_{0}}|u(x, t)|^{q+1} d x-c_{2} \varepsilon\left(\int_{\Omega_{0}}|u(x, t)|^{q+1} d x\right)^{\frac{2}{q+1}} \\
&=\int_{\Omega}|u(x, t)|^{q+1} d x\left(a_{0}-c_{2} \varepsilon\left(\int_{\Omega_{0}}|u(x, t)|^{q+1} d x\right)^{\frac{1-q}{1+q}}\right) \\
& \geq \int_{\Omega}|u(x, t)|^{q+1} d x\left(a_{0}-c_{2} \varepsilon \widetilde{C}^{\frac{1-q}{1+q}}\right) \geq 0 \tag{4.13}
\end{align*}
$$

if $\varepsilon$ is small enough, namely,

$$
\begin{equation*}
\varepsilon \leq \frac{a_{0}}{c_{2} \widetilde{C}^{\frac{1-q}{1+q}}} \tag{4.14}
\end{equation*}
$$

Thus, if $\varepsilon$ satisfies (4.14), then from (4.11) it follows that

$$
\frac{d}{d t} \int_{\Omega}|u(x, t)|^{2} d x+\varepsilon \int_{\Omega}|u(x, t)|^{2} d x \leq 0 \quad \forall t>0 .
$$

The last inequality implies the assertion of Lemma A.3.
