# LINEAR FRACTIONAL STABLE SHEETS: WAVELET EXPANSION AND SAMPLE PATH PROPERTIES

#### Abstract

In this paper we give a detailed description of the random wavelet series representation of real-valued linear fractional stable sheet introduced in 2]. By using this representation, in the case where the sample paths are continuous, an anisotropic uniform and quasi-optimal modulus of continuity of these paths is obtained as well as an upper bound for their behavior at infinity and around the coordinate axes. The Hausdorff dimensions of the range and graph of these stable random fields are then derived.


## 1. Introduction and main results

Let $0<\alpha<2$ and $H=\left(H_{1}, \ldots, H_{N}\right) \in(0,1)^{N}$ be given. We define an $\alpha$-stable random field $X_{0}=\left\{X_{0}(t), t \in \mathbb{R}^{N}\right\}$ with values in $\mathbb{R}$ by

\begin{equation*}
X_{0}(t)=\int_{\mathbb{R}^{N}} h_{H}(t, s) Z_{\alpha}(d s), \tag{1.1}
\end{equation*}
$$

where $Z_{\alpha}$ is a strictly $\alpha$-stable random measure on $\mathbb{R}^{N}$ with Lebesgue measure as its control measure and $\beta(s)$ as its skewness intensity. That is, for every Lebesgue measurable set $A \subseteq \mathbb{R}^{N}$ with Lebesgue measure $\lambda_{N}(A)<\infty, Z_{\alpha}(A)$ is a strictly $\alpha$-stable random variable with scale parameter $\lambda_{N}(A)^{1 / \alpha}$ and skewness parameter $\left(1 / \lambda_{N}(A)\right) \complement_{4} \beta(s) d s$. If $\beta(s) \equiv 0$, then $Z_{\alpha}$ is a symmetric $\alpha$-stable random measure on $\mathbb{R}^{N}$. We refer to 20 , Chapter 3] for more information on stable random measures and their integrals. Also in (1.1),

h_{H}(t, s)=\kappa \prod_{\ell=1}^{N}\left\{\left(t_{\ell}-s_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}-\left(-s_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}\right\}, \tag{1.2}
\end{equation*}

where $\kappa>0$ is a normalizing constant such that the scale parameter of $X_{0}(1)$, denoted by $\left\|X_{0}(1)\right\|_{\alpha}$, equals $1, t_{+}=\max \{t, 0\}$ and $0^{0}=1$. Observe that, if $H_{1}=\cdots=H_{N}=\frac{1}{\alpha}, X_{0}$ is the ordinary stable sheet studied in [9]. In general, the random field $X_{0}$ is called a linear fractional $\alpha$ stable sheet defined on $\mathbb{R}^{N}$ (or $(N, 1)$-LFSS for brevity) in $\mathbb{R}$ with index $H$. LFSS is an extension of both linear fractional stable motion (LFSM), which corresponds to the case where $N=1$, and ordinary fractional Brownian sheet (FBS) which corresponds to $\alpha=2$, that is, to replacing the stable measure in (1.1) by a Gaussian random measure.

We will also consider $(N, d)$-LFSS, with $d>1$, that is a linear fractional $\alpha$-stable sheet defined on $\mathbb{R}^{N}$ and taking its values in $\mathbb{R}^{d}$. The $(N, d)$-LFSS that we consider is the stable field $X=$ $\left\{X(t), t \in \mathbb{R}^{N}\right\}$ defined by

$$
\begin{equation*}
X(t)=\left(X_{1}(t), \ldots, X_{d}(t)\right), \quad \forall t \in \mathbb{R}^{N} \tag{1.3}
\end{equation*}
$$

where $X_{1}, \ldots, X_{d}$ are $d$ independent copies of $X_{0}$. It is easy to verify by using the representation (1.1) that $X$ satisfies the following scaling property: For any $N \times N$ diagonal matrix $A=\left(a_{i j}\right)$ with $a_{i i}=a_{i}>0$ for all $1 \leq i \leq N$ and $a_{i j}=0$ if $i \neq j$, we have

$$
\begin{equation*}
\left\{X(A t), t \in \mathbb{R}^{N}\right\} \stackrel{d}{=}\left\{\left(\prod_{j=1}^{N} a_{j}^{H_{j}}\right) X(t), t \in \mathbb{R}^{N}\right\} \tag{1.4}
\end{equation*}
$$

where $\stackrel{d}{=}$ denotes the equality in the sense of finite dimensional distributions, provided that the skewness intensity satisfies $\beta(A s)=\beta(s)$ for almost every $s \in \mathbb{R}^{N}$. Relation (1.4) means that the $(N, d)$-LFSS $X$ is an operator-self-similar [or operator-scaling] random field in the time variable (see [6, [23]). When the indices $H_{1}, \ldots, H_{N}$ are not the same, $X$ has different scaling behavior along different directions. This anisotropic nature of $X$ makes it a potential model for various spatial objects, as is already the case for anisotropic Gaussian fields ( 5 ] and [7]). We also mention that one can construct $(N, d)$-stable random fields which are self-similar in the space variables in the sense of [12, 14]. This will not be discussed in this paper.

Similarly to LFSM and FBS, see for instance 1, 3, 11, 13, 21, 24], there are close connections between sample path properties of LFSS and its parameters $H$ and $\alpha$. In this article we study some of these connections. In all the remainder of this paper we assume that the sample paths of $X$ are continuous, i.e. $\min \left(H_{1}, \ldots, H_{N}\right)>1 / \alpha$. For convenience we even assume that

$$
\begin{equation*}
1 / \alpha<H_{1} \leq \cdots \leq H_{N} \tag{1.5}
\end{equation*}
$$

Of course, there is no loss of generality in the arbitrary ordering of $H_{1}, \ldots, H_{N}$. Observe that, since $H \in(0,1)^{N}$, condition (1.5) implies $\alpha>1$.

Let us now state our main results. Theorem 1 below is an improved version of Theorems 1.2 and 1.3 in [2]. Relation (1.6) provides a sharp upper bound for the uniform modulus of continuity
of LFSS, while Relation (1.7) gives an upper bound for its asymptotic behavior at infinity and around the coordinate axes.

Theorem 1. Let $\Omega_{0}^{*}$ be the event of probability 1 that will be introduced in Corollary 5 . Then for every compact set $\mathcal{K} \subseteq \mathbb{R}^{N}$, all $\omega \in \Omega_{0}^{*}$ and any arbitrarily small $\eta>0$, one has

\sup _{s, t \in \mathcal{K}} \frac{\left|X_{0}(s, \omega)-X_{0}(t, \omega)\right|}{\sum_{j=1}^{N}\left|s_{j}-t_{j}\right|^{H_{j}-1 / \alpha}\left(1+|\log | s_{j}-t_{j}| |\right)^{2 / \alpha+\eta}}<\infty \tag{1.6}
\end{equation*}
$$

and

$$
\begin{equation*}
\sup _{t \in \mathbb{R}^{N}} \frac{\left|X_{0}(t, \omega)\right|}{\prod_{j=1}^{N}\left|t_{j}\right|^{H_{j}}\left(1+|\log | t_{j}| |\right)^{1 / \alpha+\eta}}<\infty . \tag{1.7}
\end{equation*}
$$

The following result can be viewed as an inverse of (1.6) in Theorem $\square$
Theorem 2. Let $\Omega_{3}^{*}$ be the event of probability 1 that will be introduced in Lemma 12 Then for all $\omega \in \Omega_{3}^{*}$, all vectors $\widehat{u}_{n} \in \mathbb{R}^{N-1}$ with non-vanishing coordinates, any $n=1, \ldots, N$ and any real numbers $y_{1}<y_{2}$ and $\epsilon>0$, one has

$$
\begin{equation*}
\sup _{s_{n}, t_{n} \in\left[y_{1}, y_{2}\right]} \frac{\left|X_{0}\left(s_{n}, \widehat{u}_{n}, \omega\right)-X_{0}\left(t_{n}, \widehat{u}_{n}, \omega\right)\right|}{\left|s_{n}-t_{n}\right|^{H_{n}-1 / \alpha}\left(1+|\log | s_{n}-t_{n}| |\right)^{-1 / \alpha-\epsilon}}=\infty, \tag{1.8}
\end{equation*}
$$

where, for every real $x_{n}$, we have set $\left(x_{n}, \widehat{u}_{n}\right)=\left(u_{1}, \ldots, u_{n-1}, x_{n}, u_{n+1}, \ldots, u_{N}\right)$.
Observe that Theorems $\square$ and 2have already been obtained by Takashima 21] in the particular case of LFSM (i.e., $N=1$ ). However, the proofs given by this author can hardly be adapted to LFSS. To establish the above theorems we introduce a wavelet series representation of $X_{0}$ and use wavelet methods which are, more or less, inspired from 3]. It is also worth noticing that the event $\Omega_{3}^{*}$ in Theorem 2 does not depend on $\widehat{u}_{n}$. This is why the latter theorem cannot be obtained by simply using the fact that LFSS is an LFSM of Hurst parameter $H_{n}$ along the direction of the $n$-th axis.

The next theorem gives the Hausdorff dimensions of the range

$$
X\left([0,1]^{N}\right)=\left\{X(t): t \in[0,1]^{N}\right\}
$$

and the graph

$$
\operatorname{Gr} X\left([0,1]^{N}\right)=\left\{(t, X(t)): t \in[0,1]^{N}\right\}
$$

of an $(N, d)$-LFSS $X$. We refer to 10$]$ for the definition and basic properties of Hausdorff dimension.

The following result extends Theorem 4 in [3] to the linear fractional stable sheets. Unlike the fractional Brownian sheet case, we remark that the Hausdorff dimensions of $X\left([0,1]^{N}\right)$ and $\operatorname{Gr} X\left([0,1]^{N}\right)$ are not determined by the uniform Hölder exponent of $X$ on $[0,1]^{N}$.

Theorem 3. Let the assumption (1.5) hold. Then, with probability 1 ,

$$
\begin{equation*}
\operatorname{dim}_{\mathrm{H}} X\left([0,1]^{N}\right)=\min \left\{d ; \quad \sum_{\ell=1}^{N} \frac{1}{H_{\ell}}\right\} \tag{1.9}
\end{equation*}
$$

and

$$
\begin{align*}
& \operatorname{dim}_{\mathrm{H}} \operatorname{Gr} X\left([0,1]^{N}\right)=\min \left\{\sum_{\ell=1}^{k} \frac{H_{k}}{H_{\ell}}+N-k+\left(1-H_{k}\right) d, 1 \leq k \leq N ; \sum_{\ell=1}^{N} \frac{1}{H_{\ell}}\right\} \\
& \quad=\left\{\begin{array}{ll}
\sum_{\ell=1}^{N} \frac{1}{H_{\ell}} \\
\sum_{\ell=1}^{k} \frac{H_{k}}{H_{\ell}}+N-k+\left(1-H_{k}\right) d & \text { if } \sum_{\ell=1}^{N-1} \frac{1}{H_{\ell}} \leq d, \\
H_{\ell}
\end{array} \leq d<\sum_{\ell=1}^{k} \frac{1}{H_{\ell}},\right. \tag{1.10}
\end{align*}
$$

where $\sum_{\ell=1}^{0} \frac{1}{H_{\ell}}:=0$.
Remark 4. The second equality in (1.10) can be verified by using (1.5) and some elementary computation; see (3].

In light of Theorem 3 it is a natural question to consider the Hausdorff dimensions of the image $X(E)$ and graph $\operatorname{Gr} X(E)$, where $E$ is an arbitrary Borel set in $\mathbb{R}^{N}$. As shown by Wu and Xiao [22] for fractional Brownian sheets, due to the anisotropic nature of $X$, the Hausdorff dimension of $E$ and the index $H$ alone are not enough to determine $\operatorname{dim}_{\mathrm{H}} X(E)$. By combining the methods in Wu and Xiao [22] and Xiao 23] with the moment argument in this paper we determine $\operatorname{dim}_{\mathrm{H}} X(E)$ for every nonrandom Borel set $E \subseteq(0, \infty)^{N}$; see Theorem 21,

We end the Introduction with some notation. Throughout this paper, the underlying parameter spaces are $\mathbb{R}^{N}, \mathbb{R}_{+}^{N}=[0, \infty)^{N}$ or $\mathbb{Z}^{N}$. A typical parameter, $t \in \mathbb{R}^{N}$ is written as $t=\left(t_{1}, \ldots, t_{N}\right)$ or $t=\left\langle t_{j}\right\rangle$ whichever is more convenient. For any $s, t \in \mathbb{R}^{N}$ such that $s_{j}<t_{j}(j=1, \ldots, N)$, the set $[s, t]=\prod_{j=1}^{N}\left[s_{j}, t_{j}\right]$ is called a closed interval (or a rectangle). Open or half-open intervals can be defined analogously. We will use capital letters $C, C_{1}, C_{2}, \ldots$ to denote positive and finite random variables and use $c, c_{1}, c_{2}, \ldots$ to denote unspecified positive and finite constants. Moreover, $C$ and $c$ may not be the same in each occurrence.

## 2. Wavelet expansion of LFSS

The goal of this section is to give a detailed description of the wavelet representations of LFSS $X_{0}$. First we need to introduce some notation that will be extensively used in all the sequel.
(i) The real-valued function $\psi$ denotes a well chosen compactly supported Daubechies wavelet (see [8, 16]). Contrary to the Gaussian case the fact that $\psi$ is compactly supported will play a crucial role in the proof of Theorem 2 (see the proof of Part (b) of Proposition (14).
(ii) For any $\ell=1, \ldots, N$, the real-valued functions $\psi^{H_{\ell}}$ and $\psi^{-H_{\ell}}$ respectively denote the leftsided fractional primitive of order $H_{\ell}+1-1 / \alpha$ and the right-sided fractional derivative of order $H_{\ell}+1-1 / \alpha$ of $\psi$, which are respectively defined for all $x \in \mathbb{R}$ by

$$
\begin{equation*}
\psi^{H_{\ell}}(x)=\int_{\mathbb{R}}(x-y)_{+}^{H_{\ell}-1 / \alpha} \psi(y) d y \text { and } \psi^{-H_{\ell}}(x)=\frac{d^{2}}{d x^{2}} \int_{\mathbb{R}}(y-x)_{+}^{1 / \alpha-H_{\ell}} \psi(y) d y \tag{2.1}
\end{equation*}
$$

Observe that the functions $\psi^{H_{\ell}}$ and $\psi^{-H_{\ell}}$ are well-defined, continuously differentiable and well-localized provided that $\psi$ has sufficiently many vanishing moments (and thus is smooth enough). By saying that a function $\phi: \mathbb{R} \rightarrow \mathbb{R}$ is well-localized we mean that

$$
\begin{equation*}
\sup _{x \in \mathbb{R}}(1+|x|)^{2}\left\{|\phi(x)|+\left|\phi^{\prime}(x)\right|\right\}<\infty . \tag{2.2}
\end{equation*}
$$

(iii) $\left\{\epsilon_{j, k},(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}\right\}$ will denote the sequence of random variables defined as

$$
\begin{equation*}
\epsilon_{j, k}=\int_{\mathbb{R}^{N}} \prod_{\ell=1}^{N}\left\{2^{j \ell / \alpha} \psi\left(2^{j \ell} s_{\ell}-k_{\ell}\right)\right\} Z_{\alpha}(d s) \tag{2.3}
\end{equation*}
$$

They are strictly $\alpha$-stable random variables all with the same scale parameter

$$
\left\|\epsilon_{j, k}\right\|_{\alpha}=\left\{\int_{\mathbb{R}}|\psi(t)|^{\alpha} d t\right\}^{N / \alpha}
$$

and skewness parameter

$$
\beta_{j, k}=\left\|\epsilon_{j, k}\right\|_{\alpha}^{-\alpha} \int_{\mathbb{R}^{N}} \prod_{\ell=1}^{N}\left\{2^{j \ell} \psi^{\langle\alpha>}\left(2^{j \ell} s_{\ell}-k_{\ell}\right)\right\} \beta(s) d s
$$

where $x^{<\alpha>}=|x|^{\alpha} \operatorname{sgn}(x)$ which is the number having the same sign as $x$ and absolute value $|x|^{\alpha}$. Moreover, if $L>0$ is a constant such that the support of $\psi$ is included in $[-L, L]$, then for any integers $p>2 L$, any $r \in\{0, \ldots, p-1\}^{N}$ and $j \in \mathbb{Z}^{N},\left\{\epsilon_{j, r+k p} ; k \in\right.$ $\left.\mathbb{Z}^{N}\right\}$ is a sequence of independent random variables.

A consequence of the above properties of the sequence $\left\{\epsilon_{j, k},(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}\right\}$ is the following.
Corollary 5. There exists an event $\Omega_{0}^{*}$ of probability 1 such that, for any $\eta>0$, for all $\omega \in \Omega_{0}^{*}$ and all $j, k \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}$,

$$
\left|\epsilon_{j, k}(\omega)\right| \leq C(\omega) \prod_{l=1}^{N}\left\{\left(1+\left|j_{l}\right|\right)^{1 / \alpha+\eta}\left(1+\left|k_{l}\right|\right)^{1 / \alpha} \log ^{1 / \alpha+\eta}\left(2+\left|k_{l}\right|\right)\right\}
$$

where $C$ is a finite positive random variable.
Proof. We apply Lemma 23,

It is worth noticing that, for every $\ell=1, \ldots, N$, the functions $\psi^{H_{\ell}}$ and $\psi^{-H_{\ell}}$ can be defined equivalently to (2.1), up to a multiplicative constant, but in the Fourier domain by (see e.g. [19])

\widehat{\psi^{H_{\ell}}}(\xi)=\mathrm{e}^{i \operatorname{sgn}(\xi)\left(H_{\ell}-1 / \alpha+1\right) \frac{\pi}{2}} \frac{\widehat{\psi}(\xi)}{|\xi|^{H_{\ell}-1 / \alpha+1}} \tag{2.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\widehat{\psi^{-H_{\ell}}}(\xi)=\mathrm{e}^{i \operatorname{sgn}(\xi)\left(H_{\ell}-1 / \alpha+1\right) \frac{\pi}{2}}|\xi|^{H_{\ell}-1 / \alpha+1} \widehat{\psi}(\xi) \tag{2.5}
\end{equation*}
$$

It follows from Parseval's Formula, (2.4), (2.5) and the orthonormality (in $L^{2}(\mathbb{R})$ ) of the sequence $\left\{2^{j / 2} \psi\left(2^{j} \cdot-k\right), j, k \in \mathbb{Z}\right\}$ that $\psi^{H_{\ell}}$ and $\psi^{-H_{\ell}}$ satisfy, for all $(J, K) \in \mathbb{Z}^{2}$ and $\left(J^{\prime}, K^{\prime}\right) \in \mathbb{Z}^{2}$, up to a multiplicative constant,

$$
\begin{equation*}
\int_{\mathbb{R}} \psi^{H_{\ell}}\left(2^{J} x-K\right) \overline{\psi^{-H_{\ell}\left(2^{J^{\prime}} x-K^{\prime}\right)}} d x=2^{-J} \delta\left(J, K ; J^{\prime}, K^{\prime}\right) \tag{2.6}
\end{equation*}
$$

where $\delta\left(J, K ; J^{\prime}, K^{\prime}\right)=1$ when $(J, K)=\left(J^{\prime}, K^{\prime}\right)$ and 0 otherwise. By putting together (2.4), (2.5) and the fact that $\widehat{\psi}(\xi)=O\left(\xi^{2}\right)$ as $|\xi| \rightarrow 0$, another useful property is obtained: for every $\ell=1, \ldots, N$, the first moment of the functions $\psi^{H_{\ell}}$ and $\psi^{-H_{\ell}}$ vanish, namely one has

$$
\begin{equation*}
\int_{\mathbb{R}} \psi^{H_{\ell}}(u) d u=\int_{\mathbb{R}} \psi^{-H_{\ell}}(u) d u=0 \tag{2.7}
\end{equation*}
$$

We are now in position to state the main results of this section.
Proposition 6. Let $\Omega_{1}^{*}$ be the event of probability 1 that will be introduced in Lemma [2. For every $n \in \mathbb{N}, M>0$ and $t \in \mathbb{R}^{N}$ we set

\begin{equation*}
U_{n, M}(t)=\sum_{(j, k) \in D_{n, M}^{N}} 2^{-\langle j, H\rangle} \epsilon_{j, k} \prod_{l=1}^{N}\left\{\psi^{H_{l}}\left(2^{j{ }_{l}} t_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right\} \tag{2.8}
\end{equation*}
$$

where the random variables $\left\{\epsilon_{j, k},(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}\right\}$ are defined by (2.3) and

$$
\begin{equation*}
D_{n, M}^{N}=\left\{(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}: \text { for all } l=1, \ldots, N\left|j_{l}\right| \leq n \text { and }\left|k_{l}\right| \leq M 2^{n+1}\right\} \tag{2.9}
\end{equation*}
$$

Then for every $\omega \in \Omega_{1}^{*}$ the functional sequence $\left(U_{n, M}(\cdot, \omega)\right)_{n \in \mathbb{N}}$ is a Cauchy sequence in the Hölder space $C^{\gamma}(\mathcal{K})$ for every $\gamma \in\left[0, H_{1}-1 / \alpha\right)$ and compact set $\mathcal{K} \subseteq[-M, M]^{N}$. We denote its limit by

$$
\sum_{(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}} 2^{-\langle j, H\rangle} \epsilon_{j, k} \prod_{l=1}^{N}\left\{\psi^{H_{l}}\left(2^{j_{l}} t_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right\}
$$

Proposition 7. With probability 1, the following holds for all $t \in \mathbb{R}^{N}$

$$
\begin{equation*}
X_{0}(t)=\sum_{(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}} 2^{-\langle j, H\rangle} \epsilon_{j, k} \prod_{l=1}^{N}\left\{\psi^{H_{l}}\left(2^{j_{l}} t_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right\} . \tag{2.10}
\end{equation*}
$$

Remark 8. By the definition of $X_{0}$ and by Proposition 6 both sides of (2.10) are continuous in $t$ with probability 1. Hence, to prove Proposition it is sufficient to show that

\left\{\sum_{(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}} 2^{-\langle j, H\rangle} \epsilon_{j, k} \prod_{l=1}^{N}\left\{\psi^{H_{l}}\left(2^{j_{l}} t_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right\}, t \in \mathbb{R}^{N}\right\}
$$

is a modification of $X_{0}$. This is a natural extension of the wavelet series representations both of LFSM and FBS (see 4, 1, 3]) and will be called the random wavelet series representation of LFSS.

Assume for a while that Proposition 6 holds and let us prove Proposition 7
Proof of Proposition 7, Let us fix $l \in\{1, \ldots, N\}$. For any $\left(j_{l}, k_{l}\right) \in \mathbb{Z} \times \mathbb{Z}$ and $s_{l} \in \mathbb{R}$ we set

Since $\left\{\psi_{j, k}, j \in \mathbb{Z}, k \in \mathbb{Z}\right\}$ is an unconditional basis of $L^{\alpha}(\mathbb{R})$ (see 15$]$ ) and, for every fixed $t_{l} \in \mathbb{R}$, the function $s_{l} \mapsto\left(t_{l}-s_{l}\right)_{+}^{H_{l}-1 / \alpha}-\left(-s_{l}\right)_{+}^{H_{n}-1 / \alpha} \in L^{\alpha}(\mathbb{R}) \cap L^{2}(\mathbb{R})$, one has

where the convergence of the series in the RHS of (2.12), as a function of $s_{l}$, holds in $L^{\alpha}(\mathbb{R})$. Next by using the Hölder inequality and the $L^{2}(\mathbb{R})$ orthonormality of the sequence $\left\{2^{j_{l}(1 / 2-1 / \alpha)} \psi_{j l, k}\right.$, $\left.j_{l} \in \mathbb{Z}, k_{l} \in \mathbb{Z}\right\}$, one can prove that

By inserting (2.12) into (1.1) for every $l=1, \ldots, N$, we get that for any fixed $t \in \mathbb{R}^{N}$, the series (2.10) converges in probability to $X_{0}(t)$ and Proposition 7 follows from Remark $\mathbb{8} \square$

From now on our goal will be to prove Proposition 6. We need some preliminary results.
Proof of Proposition 6. For the sake of simplicity we suppose that $N=2$. The proof for the general case is similar. The space $C^{\gamma}(\mathcal{K})$ is endowed with the norm

where $\|\cdot\|$ denotes the Euclidean norm in $\mathbb{R}^{2}$. For every $n \in \mathbb{N}$ we set $D_{n}^{c}=\left(\mathbb{Z}^{2} \times \mathbb{Z}^{2}\right) \backslash D_{n, M}^{2}$. Let us define $F_{n}(x, y)=F_{n}\left(x, y ; \psi^{H_{1}} ; M, \phi, \delta, \beta, \eta\right)$ and $E(x, y)=E(x, y ; \phi, \delta, \beta, \eta)$ by

Using (2.8), the triangle inequality and Lemma 22 one has for any $n, p \in \mathbb{N}$ and $s_{1}, s_{2}, t_{1}, t_{2} \in$ $[-M, M]$, denoting by $\Pi$ the product over indices $l=1,2$,

& =\left|\sum_{(j, k) \in D_{n+p, M}^{2} \backslash D_{n, M}^{2}} 2^{-\langle j, H\rangle} \epsilon_{j, k} \frac{\prod\left(\psi^{H_{l}}\left(2^{j_{l}} s_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right)-\prod\left(\psi^{H_{l}}\left(2^{j_{l}} t_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right)}{\left(\left|s_{1}-t_{1}\right|^{2}+\left|s_{2}-t_{2}\right|^{2}\right)^{\beta / 2}}\right| \\
& \leq \sum_{(j, k) \in D_{n}^{c}} 2^{-\langle j, H\rangle\rangle}\left|\epsilon_{j, k}\right| \frac{\left|\prod\left(\psi^{H_{l}}\left(2^{j_{l}} s_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right)-\prod\left(\psi^{H_{l}}\left(2^{j_{l}} t_{l}-k_{l}\right)-\psi^{H_{l}}\left(-k_{l}\right)\right)\right|}{\left(\left|s_{1}-t_{1}\right|^{2}+\left|s_{2}-t_{2}\right|^{2}\right)^{\beta / 2}} \\
& \leq C\left[\sum_{(j, k) \in D_{n}^{c}} 2^{-\langle j, H\rangle} \prod\left(3+\left|j_{l}\right|\right)^{1 / \alpha+\eta} \prod\left(3+\left|k_{l}\right|\right)^{1 / \alpha+\eta} \frac{\left|\psi^{H_{1}}\left(2^{j_{1}} s_{1}-k_{1}\right)-\psi^{H_{1}}\left(2^{j_{1}} t_{1}-k_{1}\right)\right|}{\left|s_{1}-t_{1}\right|^{\beta}}\right. \\
& \left.\times\left|\psi^{H_{2}}\left(2^{j_{2}} s_{2}-k_{2}\right)-\psi^{H_{2}}\left(-k_{2}\right)\right|+\text { similar term }\right],
\end{aligned}

where $C$ is a positive random variable. Observing that, for any non-negative array $\left(a_{j, k}\right)_{(j, k) \in \mathbb{Z}^{4}}$,

& \leq C\left[F_{n}\left(s_{1}, t_{1} ; \psi^{H_{1}} ; H_{1}, \beta, \eta\right) E\left(s_{2}, 0 ; \psi^{H_{2}} ; H_{2}, 0, \eta\right)+E\left(s_{1}, t_{1} ; \psi^{H_{1}} ; H_{1}, \beta, \eta\right) F_{n}\left(s_{2}, 0 ; \psi^{H_{2}} ; H_{2}, 0, \eta\right)\right. \\
& \left.\quad+F_{n}\left(s_{2}, t_{2} ; \psi^{H_{2}} ; H_{2}, \beta, \eta\right) E\left(t_{1}, 0 ; \psi^{H_{1}} ; H_{1}, 0, \eta\right)+E\left(s_{2}, t_{2} ; \psi^{H_{2}} ; H_{2}, \beta, \eta\right) F_{n}\left(t_{1}, 0 ; \psi^{H_{1}} ; H_{1}, 0, \eta\right)\right]
\end{aligned}

By Lemma 26] we have that $\sup _{x, y \in[-M, M]} F_{n}(x, y) \rightarrow 0$ as $n \rightarrow \infty$ and $\sup _{x, y \in[-M, M]} E(x, y)<$ $\infty$; hence the last display yields that $\sup _{p \geq 0}\left|U_{n+p, M}-U_{n, M}\right|_{\gamma} \rightarrow 0$ as $n \rightarrow \infty$. Observing that $U_{n, M}$ vanishes on the axes, the same result holds with $|\cdot|_{\gamma}$ replaced by $\|\cdot\|_{\gamma}$ and Proposition 6 is proved.

Remark 9. Proposition 6 is much easier to prove in the Gaussian case. Indeed, in this case, using the fact that the $\epsilon_{j, k}$ 's are independent $\mathcal{N}(0,1)$ Gaussian random variables one can easily show that the sequence $\left(U_{n, M}\right)_{n \in \mathbb{N}}$ is weakly relatively compact in the space $C(\mathcal{K})$. We refer to the proof of Proposition 3 in 3] for more details.

From now on we will always identify the LFSS $X_{0}$ with its random wavelet series representation (2.10).

## 3. Uniform modulus of continuity and behavior as $\left|t_{\ell}\right| \rightarrow 0$ or $\infty$

The goal of this section is to prove Theorem $\mathbb{1}$ An immediate consequence of Proposition 6 is that $X_{0}$ is locally $C^{\gamma}$ for any $\gamma \in\left(0, H_{1}-1 / \alpha\right)$, almost surely. Theorem $\square$ completes this result by providing a sharper estimate on the uniform modulus of continuity, see (1.6), and the behavior at infinity and around the axes, see (1.7). As in our note 2], these results are obtained by using the representation (2.10). However, we improved the modulus of continuity estimate by relying on the independence present in the coefficients $\left\{\epsilon_{j, k},(j, k) \in \mathbb{Z}^{N} \times \mathbb{Z}^{N}\right\}$, see Lemma 23] If this independence is not taken into account, an alternative result (i.e., Lemma 22) may be used, resulting in a less precise estimate. The latter result holds in a quite general framework since they can be extended to a more general class of random wavelet series, see Remark 10 below.
Proof of Theorem [1] It follows from (2.10), Corollary 5 and Lemma [27] that for every $\omega \in \Omega_{0}^{*}$ and every $s, t \in K$, the triangle inequality implies

& \times S_{H_{n}, 1 / \alpha, \eta}\left(t_{n}, s_{n} ; \psi^{H_{n}}\right)  \tag{3.1}\\
& \leq C_{2}(\omega) \sum_{n=1}^{N}\left|t_{n}-s_{n}\right|^{H_{n}-1 / \alpha}\left(1+|\log | t_{n}-s_{n}| |\right)^{2 / \alpha+2 \eta} .
\end{align*}

This shows (1.6).
Similarly, using (2.10), Corollary 回 and Lemma 27 we obtain, for every $\omega \in \Omega_{0}^{*}$ and every $t \in \mathbb{R}$,

The proof of Theorem $\square$ is finished.
Remark 10. Clearly Proposition 6 holds more generally for any process $Y=\left\{Y(t), t \in \mathbb{R}^{N}\right\}$ having a wavelet series representation of the form

$$

where the $\phi_{l}$ 's are well-localized functions, $\left\{c_{j, k}, j, k \in \mathbb{Z}^{N}\right\}$ is a sequence of complex-valued coefficients satisfying $\left|c_{j, k}\right| \leq c 2^{-\langle j, H\rangle}\left(c>0\right.$ being a constant) and $\left\{\lambda_{j, k}, j, k \in \mathbb{Z}^{N}\right\}$ is a sequence of complex-valued random variables satisfying $\sup _{j, k} \mathbb{E}\left[\left|\lambda_{j, k}\right|^{\nu}\right]<\infty$ for all $0<\nu<\alpha$. We can also show that (1.7) holds with probability 1 for such a process $Y$. In contrast, for this more general class of process, we cannot show (1.6) but a less precise estimate for the uniform modulus of continuity. Namely, as announced in our note 2], with probability 1,

for all compact sets $\mathcal{K} \subseteq \mathbb{R}^{N}$.

## 4. Optimality of the modulus of continuity estimate

The goal of this section is to prove Theorem 2 For every $n \in\{1, \ldots, N\}$ and $\left(j_{n}, k_{n}\right) \in \mathbb{N} \times \mathbb{Z}$, let $G_{j_{n}, k_{n}}=\left\{G_{j_{n}, k_{n}}\left(\widehat{u}_{n}\right), \widehat{u}_{n} \in \mathbb{R}^{N-1}\right\}$ be the $\alpha$-stable field defined as the following wavelet transformation:

where the notation $\left(s_{n}, \widehat{u}_{n}\right)$ is introduced in Theorem (2) By using (1.7) and the fact that the wavelet $\psi^{-H_{n}}$ is well-localized, the process $\left\{G_{j_{n}, k_{n}}(u), u \in \mathbb{R}^{N-1}\right\}$ is well-defined and its trajectories are continuous, almost surely. The proof of Theorem 2 mainly relies on the following Lemmas 11 and 12

Lemma 11. Let $\Omega_{0}^{*}$ be the event of probability 1 in Corollary 5 and let $n \in\{1, \ldots, N\}$. Suppose that there exist $\left(u_{n}, \widehat{u}_{n}\right) \in \mathbb{R}^{N}, \rho>0, \epsilon>0$ and $\omega \in \Omega_{0}^{*}$ such that

For all $\omega \in \Omega_{3}^{*}, n \in\{1, \ldots, N\}$, all integers $j_{n} \in \mathbb{N}$, real numbers $z_{1}<z_{2}$ and all $0<\tau_{1}<\tau_{2}$, one has

Before proving these lemmas, we show how they yield Theorem 2
Proof of Theorem 2. For the sake of simplicity we only consider the case where $\widehat{u}_{n}$ have positive and non-vanishing coordinates. The general case is similar. Suppose ad absurdum that
there exists $\omega \in \Omega_{3}^{*}$ such that (1.8) is not satisfied. Then, for some $n \in\{1, \ldots, N\}$, there exists $\widehat{u}_{n} \in \mathbb{R}^{N-1}$ with positive and non vanishing coordinates, some real number $u_{n}, \rho>0$ and $\epsilon>0$ arbitrary small such that (4.2) holds. By Lemma (11) this implies (4.3). Then the conclusion of Lemma 12 leads to a contradiction. This proves Theorem 2
Proof of Lemma 11. Let $j_{n} \in \mathbb{N}$ and $k_{n} \in \mathbb{Z}$ be such that

& =2^{j_{n}\left(1+H_{n}\right)}\left\{A_{j_{n}, k_{n}}\left(\widehat{u}_{n}, \omega\right)+B_{j_{n}, k_{n}}\left(\widehat{u}_{n}, \omega\right)\right\} \tag{4.6}
\end{align*}

\left\|M^{-j_{n}} \widehat{k}_{n}^{0}\left(j_{n}\right)-\widehat{u}_{n}^{0}\left(j_{n}\right)\right\|_{\infty} \leq M^{-j_{n}} . \tag{4.30}
\end{equation*}
$$

Then it follows from Proposition 16 that there exists a constant $c_{5}>0$ (independent of $\left(j_{n}, k_{n}\right)$ ) such that the following inequality holds

\left|G_{j_{n}, k_{n}}\left(M^{-j_{n}} \widehat{k}_{n}^{0}\left(j_{n}\right), \omega\right)-G_{j_{n}, k_{n}}\left(\widehat{u}_{n}^{0}\left(j_{n}\right), \omega\right)\right| \leq c_{5} 2^{j_{n} H_{n}} M^{-j_{n}\left(H_{1}-1 / \alpha-\eta\right)} .
$$

The last inequality implies that

f_{j_{n}}\left(M^{-j_{n}} \widehat{k}_{n}^{0}\left(j_{n}\right)\right) \leq f_{j_{n}}\left(\widehat{u}_{n}^{0}\left(j_{n}\right)\right)+c_{5} 2^{j_{n} H_{n}} M^{-j_{n}\left(H_{1}-1 / \alpha-\eta\right)} . \tag{4.31}
\end{equation*}
$$

By using (4.29) and (4.31) one obtains that

f_{j_{n}}\left(\widehat{u}_{n}^{0}\left(j_{n}\right)\right) & \leq \min \left\{f_{j_{n}}\left(M^{-j_{n}} \widehat{k}_{n}\right) ; \widehat{k}_{n} \in\left[M^{j_{n}} \tau_{1}, M^{j_{n}} \tau_{2}\right]^{n-1}\right\}  \tag{4.32}\\
& \leq f_{j_{n}}\left(\widehat{u}_{n}^{0}\left(j_{n}\right)\right)+c_{5} 2^{j_{n} H_{n}} M^{-j_{n}\left(H_{1}-1 / \alpha-\eta\right)} .
\end{align*}
$$

Let us choose $M$ large enough so that

$$
\frac{H_{N}-1 / \alpha}{H_{1}-1 / \alpha}<\frac{\log M}{\log 2} .
$$

and then, using (1.5), we choose $\eta>0$ and $\gamma>0$ small enough so that $2^{j_{n} H_{n}} M^{-j_{n}\left(H_{1}-1 / \alpha-\eta\right)}=$ $o\left(2^{-j_{n}(1 / \alpha-\gamma)}\right)$ as $j_{n} \rightarrow \infty$. Finally combining this with (4.31), we obtain (4.28). This proves Lemma 12

## 5. Proof of Theorem 3

As usual, the proof of Theorem 3 is divided into proving the upper and lower bounds separately. The proofs of the lower bounds rely on the standard capacity argument and the following Lemma 17. However, the proofs of the upper bounds are significantly different from that in [3], due to the fact that both $\operatorname{dim}_{\mathrm{H}} X\left([0,1]^{N}\right)$ and $\operatorname{dim}_{\mathrm{H}} \operatorname{Gr} X\left([0,1]^{N}\right)$ are not determined by the exponent for the uniform modulus of continuity of $X$. Our argument is based on the moment method in 12]. Combining this argument with the methods in 23], we are able to determine the Hausdorff dimension of the image $X(E)$ for all nonrandom Borel sets $E \subseteq(0, \infty)^{N}$.

We start by proving some results on the scale parameters of the increments of real-valued LFSS $X_{0}$ between two points (i.e., $\left.X_{0}(s)-X_{0}(t)\right)$ and over intervals; see Lemmas 17 and 18 below. Combining the latter with the maximal moment inequality due to Moricz [17], we derive sharp upper bounds for the moments of the supremum of $X_{0}$.

Lemma 17 is an extension of Lemma 3.4 in 3] for fractional Brownian sheets. Since $d(s, t):=$ $\left\|X_{0}(s)-X_{0}(t)\right\|_{\alpha}$ can be used as a pseudometric for characterizing the regularity properties of $X_{0}$ via metric entropy methods (cf. 20, Chapter 12]), these results will be useful for studying other properties of LFSS $X$ as well.

Lemma 17. For any constant $\varepsilon>0$, there exist positive and finite constants $c_{6}$ and $c_{7}$ such that for all $s, t \in[\varepsilon, 1]^{N}$,

\begin{equation*}
c_{6} \sum_{\ell=1}^{N}\left|s_{\ell}-t_{\ell}\right|^{H_{\ell}} \leq\left\|X_{0}(s)-X_{0}(t)\right\|_{\alpha} \leq c_{7} \sum_{\ell=1}^{N}\left|s_{\ell}-t_{\ell}\right|^{H_{\ell}} . \tag{5.1}
\end{equation*}
$$

Proof. To prove the upper bound in (5.1), we use induction on $N$. When $N=1, X_{0}$ is an $(H, \alpha)$-linear fractional stable motion and one can verify directly that (5.1) holds as an equality. Suppose the upper bound in (5.1) holds for any linear fractional stable sheet with $n$ parameters. We now show that it holds for a linear fractional stable sheet $X_{0}$ with $n+1$ parameters.

It follows from the representation (1.1) that, for any $s, t \in[\varepsilon, 1]^{n+1},\left\|X_{0}(s)-X_{0}(t)\right\|_{\alpha}^{\alpha}$ is a constant multiple of the following integral:

\begin{aligned}
& \int_{\mathbb{R}^{n+1}} \mid \prod_{\ell=1}^{n+1}\left\{\left(t_{\ell}-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}-\left(-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}\right\}-\left.\prod_{\ell=1}^{n+1}\left\{\left(s_{\ell}-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}-\left(-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}\right\}\right|^{\alpha} d r \\
& \leq c \int_{\mathbb{R}^{n}} \mid \\
&\left|\prod_{\ell=1}^{n}\left\{\left(t_{\ell}-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}-\left(-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}\right\}-\prod_{\ell=1}^{n}\left\{\left(s_{\ell}-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}-\left(-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}\right\}\right|^{\alpha} d r \\
& \times \int_{\mathbb{R}}\left\{\left(t_{n+1}-r_{n+1}\right)_{+}^{H_{n+1}-\frac{1}{\alpha}}-\left(-r_{n+1}\right)_{+}^{H_{n+1}-\frac{1}{\alpha}}\right\}^{\alpha} d r_{n+1} \\
&+c \int_{\mathbb{R}^{n}} {\left[\prod_{\ell=1}^{n}\left\{\left(s_{\ell}-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}-\left(-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}\right\}\right]^{\alpha} d r } \\
& \times \int_{\mathbb{R}}\left|\left(t_{n+1}-r_{n+1}\right)_{+}^{H_{n+1}-\frac{1}{\alpha}}-\left(s_{n+1}-r_{n+1}\right)_{+}^{H_{n+1}-\frac{1}{\alpha}}\right|^{\alpha} d r_{n+1} \\
& \leq c\left\{\left(\sum_{\ell=1}^{n}\left|s_{\ell}-t_{\ell}\right|^{H_{\ell}}\right)^{\alpha}+\left|t_{n+1}-s_{n+1}\right|^{H_{n+1} \alpha}\right\},
\end{aligned}
$$

where, in deriving the last inequality, we have used the induction hypothesis, the fact that the function $t \mapsto \int_{\mathbb{R}}\left\{(t-r)_{+}^{H-1 / \alpha}-(-r)_{+}^{H-1 / \alpha}\right\}^{\alpha} d r$ is locally uniformly bounded for any $H>1 / \alpha$ and that, by a change of variable $r_{n+1}=t_{n+1}+\left|t_{n+1}-s_{n+1}\right| u$, the last integral in the previous
display is less than $\left|t_{n+1}-s_{n+1}\right|^{\alpha H_{n+1}}$ up to a multiplicative constant. Hence we have proved the upper bound in (5.1).

For proving the lower bound in (5.1), we define the stable field $Y=\left\{Y(t), t \in \mathbb{R}_{+}^{N}\right\}$ by

$$
\begin{equation*}
Y(t)=\int_{[0, t]} h_{H}(t, r) Z_{\alpha}(d r) \tag{5.2}
\end{equation*}
$$

where the function $h_{H}(t, r)$ is defined in (1.2). Then by using (1.1) again we can write

\end{equation*}

To proceed, we use the same argument as in [3, pp. 428-429] to decompose $Y$ as a sum of independent stable random fields. For every $t \in[\varepsilon, 1]^{N}$, we decompose the rectangle $[0, t]$ into the following disjoint union:

[0, t]=[0, \varepsilon]^{N} \cup \bigcup_{j=1}^{N} R\left(t_{j}\right) \cup \Delta(\varepsilon, t), \tag{5.4}
\end{equation*}
$$

where $R\left(t_{j}\right)=\left\{r \in[0,1]^{N}: 0 \leq r_{i} \leq \varepsilon\right.$ if $\left.i \neq j, \varepsilon<r_{j} \leq t_{j}\right\}$ and $\Delta(\varepsilon, t)$ can be written as a union of $2^{N}-N-1$ sub-rectangles of $[0, t]$. It follows from (5.2) and (5.4) that for every $t \in[\varepsilon, 1]^{N}$,

Y(t) & =\int_{[0, \varepsilon]^{N}} h_{H}(t, r) Z_{\alpha}(d r)+\sum_{j=1}^{N} \int_{R\left(t_{j}\right)} h_{H}(t, r) Z_{\alpha}(d r)+\int_{\Delta(\varepsilon, t)} h_{H}(t, r) Z_{\alpha}(d r) \\
& :=Y(\varepsilon, t)+\sum_{j=1}^{N} Y_{j}(t)+Z(\varepsilon, t) \tag{5.5}
\end{align*}
$$

Since the processes $\left\{Y(\varepsilon, t), t \in \mathbb{R}^{N}\right\},\left\{Y_{j}(t), t \in \mathbb{R}^{N}\right\}(1 \leq j \leq N)$ and $\left\{Z(\varepsilon, t), t \in \mathbb{R}^{N}\right\}$ are defined by the stochastic integrals with respect to $Z_{\alpha}$ over disjoint sets, they are independent. Only the $Y_{j}(t)$ 's will be useful for proving the lower bound in (5.1).

Now let $s, t \in[\varepsilon, 1]^{N}$ and $j \in\{1, \ldots, N\}$ be fixed. Without loss of generality, we assume $s_{j} \leq t_{j}$. Then

\left\|Y_{j}(t)-Y_{j}(s)\right\|_{\alpha}^{\alpha}=\int_{R\left(s_{j}\right)}\left(h_{H}(t, r)-h_{H}(s, r)\right)^{\alpha} d r+\int_{R\left(s_{j}, t_{j}\right)} h_{H}^{\alpha}(t, r) d r \tag{5.6}
\end{equation*}
$$

where $R\left(s_{j}, t_{j}\right)=\left\{r \in[0,1]^{N}: 0 \leq r_{i} \leq \varepsilon\right.$ if $\left.i \neq j, s_{j}<r_{j} \leq t_{j}\right\}$. By (5.6) and some elementary calculations we derive

& =\int_{[0, \varepsilon]^{N-1}} \prod_{k \neq j}\left(t_{k}-r_{k}\right)^{\alpha H_{k}-1} \int_{s_{j}}^{t_{j}}\left(t_{j}-r_{j}\right)^{\alpha H_{j}-1} d r  \tag{5.7}\\
& \geq c\left|t_{j}-s_{j}\right|^{\alpha H_{j}},
\end{align*}
$$

where $c>0$ is a constant depending on $\varepsilon, \alpha$ and $H_{k}(1 \leq k \leq N)$ only. The lower bound in (5.1) follows from (5.5), (5.6) and (5.7).

Our next lemma determines the scalar parameter of the increment of $X_{0}$ over any interval $[s, t]=\prod_{j=1}^{N}\left[s_{j}, t_{j}\right]$. Recall that the increment of $X_{0}$ over $[s, t]$, denoted by $X_{0}([s, t])$, is defined as

X_{0}([s, t]):=\sum_{\delta \in\{0,1\}^{N}}(-1)^{N-\sum_{i} \delta_{i}} X_{0}\left(\left\langle s_{j}+\delta_{j}\left(t_{j}-s_{j}\right)\right\rangle\right) . \tag{5.8}
\end{equation*}
$$

This corresponds to the measure of the set $[s, t]$ by interpreting $X_{0}$ as a signed measure defined by $X_{0}([0, t])=X_{0}(t)$ for all $t \in \mathbb{R}^{N}$ (convention: $\left[0, t_{j}\right]:=\left[t_{j}, 0\right]$ if $\left.t_{j}<0\right)$. It may be helpful to note that for $N=2$, we have

X_{0}([s, t])=X_{0}(t)-X_{0}\left(\left(s_{1}, t_{2}\right)\right)-X_{0}\left(\left(t_{1}, s_{2}\right)\right)+X_{0}(s) .
$$

Similarly, we will denote the increment of the function $h_{H}(\cdot, r)$ over $[s, t]$ by $h_{H}([s, t], r)$.
Lemma 18. For any interval $[s, t]=\prod_{j=1}^{N}\left[s_{j}, t_{j}\right]$, we have

\left\|X_{0}([s, t])\right\|_{\alpha}^{\alpha}=\prod_{j=1}^{N}\left(t_{j}-s_{j}\right)^{\alpha H_{j}} \tag{5.9}
\end{equation*}
$$

Proof. Since the kernel $h_{H}(t, s)$ in (1.2) is a tensor product, it can be verified that

\begin{align*}
\left\|X_{0}([s, t])\right\|_{\alpha}^{\alpha} & =\int_{\mathbb{R}^{N}}\left|h_{H}([s, t], r)\right|^{\alpha} d r \\
& =\int_{\mathbb{R}^{N}} \kappa^{\alpha} \prod_{\ell=1}^{N}\left|\left(t_{\ell}-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}-\left(s_{\ell}-r_{\ell}\right)_{+}^{H_{\ell}-\frac{1}{\alpha}}\right|^{\alpha} d r  \tag{5.10}\\
& =\prod_{j=1}^{N}\left(t_{j}-s_{j}\right)^{\alpha H_{j}} .
\end{align*}
$$

This proves Lemma [18,
In order to estimate $\mathbb{E}\left[\sup _{t \in T}\left|X_{0}(t)-X_{0}(a)\right|\right]$ for all intervals $T=[a, b] \subseteq[\varepsilon, 1]^{N}$, we will make use of a general moment inequality of Móricz [17] for the maximum partial sums of multi-indexed random variables. This approach has the advantage that it is applicable to non-stable random fields as well. Another way for proving Lemma 20 below is to establish sharp upper bounds for the tail probability $\mathbb{P}\left[\sup _{t \in T}\left|X_{0}(t)-X_{0}(a)\right|>u\right]$ by modifying the arguments in 18].

First we adapt some notation from [17] to our setting. Let $\left\{\xi_{k}, k \in \mathbb{N}^{N}\right\}$ be a sequence of random variables. For any $m \in \mathbb{Z}_{+}^{N}\left(\mathbb{Z}_{+}\right.$is the set of nonnegative integers) and $k \in \mathbb{N}^{N}$, let $R=R(m, k)=(m, m+k] \cap \mathbb{Z}_{+}^{N}$, which will also be called a rectangle in $\mathbb{Z}_{+}^{N}$, and we denote

\begin{equation*}
S(R)=S(m, k)=\sum_{p \in R} \xi_{p} \quad \text { and } \quad M(R)=\max _{1 \leq q \leq k}|S(m, q)| . \tag{5.11}
\end{equation*}

It can be verified that $M(R) \leq \max _{Q \subseteq R}|S(Q)| \leq 2^{N} M(R)$, where the maximum is taken over all rectangles $Q \subseteq R$. Let $f(R)$ be a nonnegative function of the rectangle $R$ with left-lower vertex in $\mathbb{Z}_{+}^{N}$. We call $f$ superadditive if for every rectangle $R=R(m, k)$ the inequality

holds for every $1 \leq j \leq N$ and $1 \leq q_{j}<k_{j}$, where

R_{j 1}=R\left(\left(m_{1}, \ldots, m_{N}\right),\left(k_{1}, \ldots, k_{j-1}, q_{j}, k_{j+1}, \ldots, k_{N}\right)\right)
$$

and

$$
R_{j 2}=R\left(\left(m_{1}, \ldots, m_{j-1}, m_{j}+q_{j}, m_{j+1}, \ldots, m_{N}\right),\left(k_{1}, \ldots, k_{j-1}, k_{j}-q_{j}, k_{j+1}, \ldots, k_{N}\right)\right)
$$

In other words, $R_{j 1} \cup R_{j 2}=R$ is a disjoint decomposition of $R$ by a hyperplane which is perpendicular to the $j$ th axis. Together with the nonnegativity of $f$, (5.12) implies that, for every fixed $m \in \mathbb{Z}_{+}^{N}, f(R(m, k))$ is nondecreasing in each variable $k_{j}(1 \leq j \leq N)$.

The following moment inequality for the maximum $M(R)$ follows from Corollary 1 in [17].
Lemma 19. Let $\beta>1$ and $\gamma \geq 1$ be given constants. If there exists a nonnegative and superadditive function $f(R)$ of the rectangle $R$ in $\mathbb{Z}_{+}^{N}$ such that $\mathbb{E}\left[|S(R)|^{\gamma}\right] \leq f^{\beta}(R)$ for every $R$, then

$$
\begin{equation*}
\mathbb{E}\left[M(R)^{\gamma}\right] \leq\left(\frac{5}{2}\right)^{N}\left(1-2^{(1-\beta) / \gamma}\right)^{N \gamma} f^{\beta}(R) \tag{5.13}
\end{equation*}

for every rectangle $R$ in $\mathbb{Z}_{+}^{N}$.
It is useful to notice that the constant in (5.13) is independent of $R$. Applying Lemma 19 the linear fractional stable sheets, we obtain

Lemma 20. Let the assumption (1.5) hold. Then there exists a positive and finite constant $c_{8}$, independent of the skewness intensity $\beta(s)$, such that for all rectangles $T=[a, b] \subseteq[\varepsilon, 1]^{N}$,

\begin{equation*}
\mathbb{E}\left(\sup _{t \in T}\left|X_{0}(t)-X_{0}(a)\right|\right) \leq c_{8} \sum_{j=1}^{N}\left(b_{j}-a_{j}\right)^{H_{j}} . \tag{5.14}
\end{equation*}
$$

Proof. We prove this lemma by using induction on $N$. In the case of $N=1$ it is well known (cf. 12] or [21]) that (5.14) holds. Observe that the term $\delta=\langle 1\rangle$ in the sum appearing in (5.8) is $X_{0}(t)$, and since $\sum_{\delta \in\{0,1\}^{N}}(-1)^{N-\sum_{i} \delta_{i}}=0$, we have

X_{0}([s, t]) & =\sum_{\delta \in\{0,1\}^{N}}(-1)^{N-\sum_{i} \delta_{i}}\left(X_{0}\left(\left\langle s_{j}+\delta_{j}\left(t_{j}-s_{j}\right)\right\rangle\right)-X_{0}(s)\right) \\
& =X_{0}(t)-X_{0}(s)+\sum_{\left.\delta \in\{0,1\}^{N} \backslash \backslash 1\right\rangle}(-1)^{N-\sum_{i} \delta_{i}}\left\{X_{0}\left(\left\langle s_{j}+\delta_{j}\left(t_{j}-s_{j}\right)\right\rangle\right)-X_{0}(s)\right\} . \tag{5.15}
\end{align*}
$$

For every $\delta \in\{0,1\}^{N} \backslash\langle 1\rangle$, there is some $n \in\{1, \ldots, N\}$ such that $\delta_{n}=0$. Observing that, using the notation introduced in Theorem $2 \widehat{u}_{n} \mapsto X_{0}\left(a_{n}, \widehat{u}_{n}\right)$ is an $(N-1,1)$-LFSS as defined by (1.1) and (1.2) but with $N$ replaced by $N-1, \kappa$ multiplied by a constant only depending on $a_{n}$ and bounded independently of $a_{n}$ (since $a_{n} \in[\varepsilon, 1]$ ) and a modified skewness intensity $\widetilde{\beta}$. Hence using the induction hypothesis, we have, for every $\delta \in\{0,1\}^{N} \backslash\langle 1\rangle$,

\begin{equation*}
\mathbb{E}\left(\sup _{t \in T}\left|X_{0}\left(\left\langle a_{j}+\delta_{j}\left(t_{j}-a_{j}\right)\right\rangle\right)-X_{0}(a)\right|\right) \leq c \sum_{j=1}^{N}\left(b_{j}-a_{j}\right)^{H_{j}} . \tag{5.16}
\end{equation*}
$$

Applying (5.15) with $s=a$ and (5.16), the bound (5.14) is implied by

$$
\begin{equation*}
\mathbb{E}\left(\sup _{t \in T}\left|X_{0}([a, t])\right|\right) \leq c \prod_{j=1}^{N}\left(b_{j}-a_{j}\right)^{H_{j}} \tag{5.17}
\end{equation*}
$$

which we are now going to prove. This is where Lemmas 18 and 19 will be applied.
For all $n \in \mathbb{N}$ we define a grid in $[a, b]$ with mesh $2^{-n}$ by the collection of points

\tau_{n}(p)=\left\langle a_{j}+p_{j}\left(b_{j}-a_{j}\right) 2^{-n}\right\rangle, \quad p \in R\left(0,\left\langle 2^{n}\right\rangle\right)=\left\{1, \ldots, 2^{n}\right\}^{N} .
$$

For each $p \in R\left(0,\left\langle 2^{n}\right\rangle\right)$, we define the random variable $\xi_{p}$ to be the increment of $X_{0}$ over the elementary rectangle with upper-right vertex $\tau_{n}(p),\left[\tau_{n}(p-\langle 1\rangle), \tau_{n}(p)\right]$. Interpreting $X_{0}$ as a signed measure, we get that for any rectangle $R(m, k) \subseteq R\left(0,\left\langle 2^{n}\right\rangle\right)$ for $m \neq 0$,

$$
\begin{equation*}
\sum_{p \in R(m, k)} \xi_{p}=X_{0}\left(\left[\tau_{n}(m), \tau_{n}(m+k)\right]\right) . \tag{5.18}
\end{equation*}
$$

We are now ready to prove (5.17). By the continuity of the sample function $X_{0}(t)$ and the monotone convergence theorem, since the set $\cup_{n \geq 1}\left\{\tau_{n}(p): p \in R\left(0,\left\langle 2^{n}\right\rangle\right)\right\}$ is dense in $[a, b]$, it is sufficient to show that for all integers $n \geq 1$,

\begin{equation*}
\mathbb{E}\left(\max _{p \in R\left(0,\left\langle 2^{n}\right\rangle\right)}\left|X_{0}\left(\left[a, \tau_{n}(p)\right]\right)\right|\right) \leq c_{9} \prod_{j=1}^{N}\left(b_{j}-a_{j}\right)^{H_{j}}, \tag{5.19}
\end{equation*}
$$

where $c_{9}>0$ is a finite constant independent of $[a, b] \subseteq[\varepsilon, 1]^{N}$ and $n$.
It follows from Lemma 23 in the Appendix that for any strictly $\alpha$-stable random variable $Z$ with scale parameter 1 and every $0<\gamma<\alpha$, we have $\mathbb{E}\left(|Z|^{\gamma}\right) \leq c_{10}$, where $c_{10}$ depends on $\alpha$ and $\gamma$ only. This fact, (5.18) and Lemma 18 imply that for every $1<\gamma<\alpha$ and every rectangle
$R=R(m, k) \subseteq R\left(0,\left\langle 2^{n}\right\rangle\right)$,

$$
\begin{align*}
\mathbb{E}\left(\left|\sum_{p \in R} \xi_{p}\right|^{\gamma}\right) & =\mathbb{E}\left(\left|X_{0}\left(\left[\tau_{n}(m), \tau_{n}(m+k)\right]\right)\right|^{\gamma}\right) \\
& \leq c_{10}\left[\prod_{j=1}^{N}\left(\frac{k_{j}\left(b_{j}-a_{j}\right)}{2^{n}}\right)^{H_{j}}\right]^{\gamma}  \tag{5.20}\\
& \leq\left[c_{11} \prod_{j=1}^{N}\left(\frac{k_{j}\left(b_{j}-a_{j}\right)}{2^{n}}\right)^{H_{j} / H_{1}}\right]^{H_{1} \gamma},
\end{align*}
$$

where $c_{11}=c_{10}^{1 /\left(H_{1} \gamma\right)}$. For every rectangle $R=R(m, k)$ included in $R\left(0,\left\langle 2^{n}\right\rangle\right)$, let

$$
f(R)=c_{11} \prod_{j=1}^{N}\left(\frac{k_{j}\left(b_{j}-a_{j}\right)}{2^{n}}\right)^{H_{j} / H_{1}}
$$

Note that, under assumption (1.5), we have $\alpha \in(1,2), H_{1} \alpha>1$ and $H_{j} \geq H_{1}$ for $j=1, \ldots, N$. Hence the inequality $x^{H_{j} / H_{1}}+y^{H_{j} / H_{1}} \leq(x+y)^{H_{j} / H_{1}}$ for all $x, y>0$ implies that $f$ is superadditive.

We take $\gamma \in(1, \alpha)$ such that $\beta=\gamma H_{1}>1$ and apply Lemma 19 to derive

$$
\begin{align*}
\mathbb{E}\left(\sup _{k \in R\left(0,\left\langle 2^{n}\right\rangle\right)}\left|\sum_{p \in R(0, k)} \xi_{p}\right|^{\gamma}\right) & \leq c_{12}\left[\prod_{j=1}^{N}\left(b_{j}-a_{j}\right)^{H_{j} / H_{1}}\right]^{H_{1} \gamma}  \tag{5.21}\\
& =c_{12}\left[\prod_{j=1}^{N}\left(b_{j}-a_{j}\right)^{H_{j}}\right]^{\gamma}
\end{align*}
$$

where $c_{12}>0$ is a finite constant independent of $[a, b]$ and $n$. This proves (5.17) and thus Lemma 20.

We now proceed to prove Theorem 3
Proof of Theorem 3. We only prove (1.9), which is done by modifying the proof of Theorem 4 in (3) and by making use of Lemmas 17 and 20. The formula (1.10) can be proven using similar arguments and we leave it to the interested reader.

First we prove the lower bound in (1.9). Let $\varepsilon \in(0,1)$ be given and let $I=[\varepsilon, 1]^{N}$. We will prove that for every $0<\gamma<\min \left\{d, \sum_{\ell=1}^{N} \frac{1}{H_{\ell}}\right\}, \operatorname{dim}_{\mathrm{H}} X(I) \geq \gamma$ almost surely. By Frostman's theorem (see e.g. 10] pages 64 and 65), it is sufficient to show that we have

$$
\begin{equation*}
\mathbb{E} \int_{I} \int_{I} \frac{1}{\|X(s)-X(t)\|^{\gamma}} d s d t<\infty \tag{5.22}
\end{equation*}
$$

where $\|\cdot\|$ denotes the Euclidean norm in $\mathbb{R}^{d}$.
It is known that for any $d$-dimensional distribution function $F$ in $\mathbb{R}^{d}$ with characteristic function $\varphi$ and any $\gamma>0$, we have

$$
\begin{equation*}
2^{\gamma / 2-1} \Gamma\left(\frac{\gamma}{2}\right) \int_{\mathbb{R}^{d}}\|x\|^{-\gamma} F(d x)=(2 \pi)^{-d / 2} \int_{0}^{+\infty} u^{\gamma-1} d u \int_{\mathbb{R}^{d}} \exp \left(-\frac{\|x\|^{2}}{2}\right) \varphi(u x) d x . \tag{5.23}
\end{equation*}
$$

This equality can be verified by replacing $\varphi$ in the right side of (5.23) by its expression as a Fourier integral and then performing a routine calculation. Applying (5.23) to the distribution of the stable random variable $\xi=(X(s)-X(t)) /\|X(s)-X(t)\|_{\alpha}$ and using Fubini's theorem, we obtain

$$
\begin{align*}
\mathbb{E}\left(\|\xi\|^{-\gamma}\right) & \leq c_{14} \int_{\mathbb{R}^{d}} \exp \left(-\frac{\|x\|^{2}}{2}\right) d x \int_{0}^{\infty} u^{\gamma-1} \exp \left(-c_{15}|u|^{\alpha}\|x\|^{\alpha}\right) d u \\
& =c_{16} \int_{\mathbb{R}^{d}} \exp \left(-\frac{\|x\|^{2}}{2}\right)\|x\|^{-\gamma} d x<\infty \tag{5.24}
\end{align*}
$$

where the last integral is convergent because $\gamma<d$. Combining (5.24) with Lemma 17 yields

$$
\begin{equation*}
\mathbb{E} \int_{I} \int_{I} \frac{1}{\|X(s)-X(t)\|^{\gamma}} d s d t \leq \int_{I} \int_{I} \frac{1}{\left(\sum_{\ell=1}^{N}\left|s_{\ell}-t_{\ell}\right|^{H_{\ell}}\right)^{\gamma}} d s d t<\infty \tag{5.25}
\end{equation*}
$$

where the finiteness of the last integral is proved in 3, p. 432]. This proves (5.22) and hence the lower bound in (1.9).

To prove the upper bound in (1.9), we use the covering argument in 12] and 3]. Since clearly $\operatorname{dim}_{\mathrm{H}} X\left([0,1]^{N}\right) \leq d$ a.s. and Hausdorff dimension is $\sigma$-stable 10], it is sufficient to show that for every $\varepsilon \in(0,1)$,

$$
\begin{equation*}
\operatorname{dim}_{\mathrm{H}} X\left([\varepsilon, 1]^{N}\right) \leq \sum_{j=1}^{N} \frac{1}{H_{j}} \quad \text { a.s. } \tag{5.26}
\end{equation*}
$$

This will be done by using a covering argument.
For any integer $n \geq 2$, we divide $[\varepsilon, 1]^{N}$ into $m_{n}$ sub-rectangles $\left\{R_{n, i}\right\}$ with sides parallel to the axes and side-lengths $n^{-1 / H_{j}}(j=1, \ldots, N)$, respectively. Then

$$
\begin{equation*}
m_{n} \leq c n^{\sum_{j=1}^{N} \frac{1}{H_{j}}} \tag{5.27}
\end{equation*}
$$

and $X\left([\varepsilon, 1]^{N}\right)$ can be covered by $X\left(R_{n, i}\right)\left(1 \leq i \leq m_{n}\right)$. Denote the lower-left vertex of $R_{n, i}$ by $a_{n, i}$. Note that the image $X\left(R_{n, i}\right)$ is contained in a rectangle in $\mathbb{R}^{d}$ with sides parallel to the axes and side lengths at most $2 \sup _{s \in R_{n, i}}\left|X_{k}(s)-X_{k}\left(a_{n, i}\right)\right|(k=1, \ldots, d)$, respectively. Hence each $X\left(R_{n, i}\right)$ can be covered by at most

$$
\prod_{k=1}^{d}\left[\frac{2 \sup _{s \in R_{n, i}}\left|X_{k}(s)-X_{k}\left(a_{n, i}\right)\right|}{n^{-1}}+1\right]
$$

cubes of side-lengths $n^{-1}$. In this way, we have obtained a $\left(\sqrt{d} n^{-1}\right)$-covering for $X\left([\varepsilon, 1]^{N}\right)$.
By Lemma we derive that for every $1 \leq i \leq m_{n}$ and $1 \leq k \leq d$,

$$
\begin{equation*}
\mathbb{E}\left(\sup _{s \in R_{n, i}}\left|X_{k}(s)-X_{k}\left(a_{n, i}\right)\right|\right) \leq c n^{-1} . \tag{5.28}
\end{equation*}
$$

It follows from (5.27], (5.28) and the independence of $X_{1}, \ldots, X_{d}$ that for any $\gamma>\sum_{j=1}^{N} \frac{1}{H_{j}}$, we have

$$
\begin{align*}
& \mathbb{E}\left\{\sum_{i=1}^{m_{n}} \prod_{k=1}^{d}\left[\frac{2 \sup _{s \in R_{n, i}}\left|X_{k}(s)-X_{k}\left(a_{n, i}\right)\right|}{n^{-1}}+1\right]\left(\sqrt{d} n^{-1}\right)^{\gamma}\right\}  \tag{5.29}\\
& \quad \leq c n^{\sum_{j=1}^{N} \frac{1}{H_{j}}} n^{-\gamma} \rightarrow 0 \quad \text { as } n \rightarrow \infty
\end{align*}
$$

This and Fatou's lemma imply that $\operatorname{dim}_{\mathrm{H}} X\left([\varepsilon, 1]^{N}\right) \leq \gamma$ almost surely. By letting $\gamma \downarrow \sum_{j=1}^{N} \frac{1}{H_{j}}$ along rational numbers, we derive (5.26). This completes the proof of Theorem $3 \square$

The above method can be extended to determine the Hausdorff dimension of the image $X(E)$ for every nonrandom Borel set $E \subseteq(0, \infty)^{N}$, thus extending the results in Wu and Xiao 22] and Xiao [23] for anisotropic Gaussian random fields to ( $N, d$ )-LFSS.

For this purpose, let us first recall from [23] the definition of a Hausdorff-type dimension which is more convenient to capture the anisotropic nature of $X$.

For a fixed $\left(H_{1}, \ldots, H_{N}\right) \in(0,1)^{N}$, let $\rho$ be the metric on $\mathbb{R}^{N}$ defined by

$$
\begin{equation*}
\rho(s, t)=\sum_{j=1}^{N}\left|s_{j}-t_{j}\right|^{H_{j}}, \quad \forall s, t \in \mathbb{R}^{N} . \tag{5.30}
\end{equation*}
$$

For any $\beta>0$ and $E \subseteq \mathbb{R}^{N}$, define the $\beta$-dimensional Hausdorff measure [in the metric $\rho$ ] of $E$ by

$$
\begin{equation*}
\mathcal{H}_{\rho}^{\beta}(E)=\lim _{\delta \rightarrow 0} \inf \left\{\sum_{n=1}^{\infty}\left(2 r_{n}\right)^{\beta}: E \subseteq \bigcup_{n=1}^{\infty} B_{\rho}\left(r_{n}\right), r_{n} \leq \delta\right\}, \tag{5.31}
\end{equation*}
$$

where $B_{\rho}(r)$ denotes a closed (or open) ball of radius $r$ in the metric space $\left(\mathbb{R}^{N}, \rho\right)$. Then $\mathcal{H}_{\rho}^{\beta}$ is a metric outer measure and all Borel sets are $\mathcal{H}_{\rho}^{\beta}$-measurable. The corresponding Hausdorff dimension of $E$ is defined by

$$
\begin{equation*}
\operatorname{dim}_{\mathrm{H}}^{\rho} E=\inf \left\{\beta>0: \mathcal{H}_{\rho}^{\beta}(E)=0\right\} . \tag{5.32}
\end{equation*}
$$

We refer to [23] for more information on the history and basic properties of $\mathcal{H}_{\rho}^{\beta}$ and $\operatorname{dim}_{\mathrm{H}}^{\rho}$.
Theorem 21. Let the assumption (1.5) hold. Then, for every nonrandom Borel set $E \subseteq(0, \infty)^{N}$,

$$
\begin{equation*}
\operatorname{dim}_{\mathrm{H}} X(E)=\min \left\{d ; \operatorname{dim}_{\mathrm{H}}^{\rho} E\right\} \quad \text { a.s. } \tag{5.33}
\end{equation*}
$$

Proof. The proof is a modification of those of Theorem 3 above and Theorem 6.11 in [23]. For any $\gamma>\operatorname{dim}_{\mathrm{H}}^{\rho} E$, there is a covering $\left\{B_{\rho}\left(r_{n}\right), n \geq 1\right\}$ of $E$ such that $\sum_{n=1}^{\infty}\left(2 r_{n}\right)^{\gamma} \leq 1$. Note that $X(E) \subseteq \cup_{n=1}^{\infty} X\left(B_{\rho}\left(r_{n}\right)\right)$ and we can cover each $X\left(B_{\rho}\left(r_{n}\right)\right)$ as in the proof of Theorem 3 The same argument shows that $\operatorname{dim}_{\mathrm{H}} X(E) \leq \gamma$ almost surely, which yields the desired upper bound for $\operatorname{dim}_{\mathrm{H}} X(E)$.

By using the Frostman lemma for $\mathcal{H}_{\rho}^{\beta}$ (Lemma 6.10 in [23]) and the capacity argument in the proof of Theorem 3, one can show $\operatorname{dim}_{\mathrm{H}} X(E) \geq \min \left\{d ; \operatorname{dim}_{\mathrm{H}}^{\rho} E\right\}$ almost surely. We omit the details.

## Appendix A. Technical Lemmas

The following lemma allows to control the growth of an arbitrary sequence of strictly $\alpha$-stable random variables having the same scale parameter.

Lemma 22. Let $\left\{\epsilon_{\lambda}, \lambda \in \mathbb{Z}^{d}\right\}$ be an arbitrary sequence of strictly $\alpha$-stable random variables having the same scale parameter. Then, there exists an event $\Omega_{1}^{*}$ of probability 1 , such that for any $\eta>0$ and any $\omega \in \Omega_{1}^{*}$,

$$
\begin{equation*}
\left|\epsilon_{\lambda}(\omega)\right| \leq C(\omega) \prod_{l=1}^{d}\left(3+\left|\lambda_{l}\right|\right)^{1 / \alpha+\eta} \tag{A.1}
\end{equation*}
$$

where $C>0$ is an almost surely finite random variable, only depending on $\eta$.
Proof This lemma simply follows from the fact that for any $\nu \in\left((1 / \alpha+\eta)^{-1}, \alpha\right)$ one has

$$
\mathbb{E}\left(\sup _{\lambda \in \mathbb{Z}^{d}} \frac{\left|\epsilon_{\lambda}\right|^{\nu}}{\prod_{j=1}^{d}\left(3+\left|\lambda_{j}\right|\right)^{\nu(1 / \alpha+\eta)}}\right) \leq c \sum_{\lambda \in \mathbb{Z}^{d}} \prod_{j=1}^{d}\left(3+\left|\lambda_{j}\right|\right)^{-\nu(1 / \alpha+\eta)}<\infty
$$

Lemma 23. Let $\alpha \in(0,2)$. There exists a constant $c_{17}$ depending only on $\alpha$ such that for any strictly $\alpha$-stable random variable $Z$ with scale parameter $\|Z\|_{\alpha}>0$ and skewness parameter $\beta \in[-1,1]$ and all $t \geq\|Z\|_{\alpha}$,

$$
\begin{equation*}
c_{17}^{-1}\|Z\|_{\alpha}^{\alpha} t^{-\alpha} \leq \mathbb{P}(|Z|>t) \leq c_{17}\|Z\|_{\alpha}^{\alpha} t^{-\alpha} \tag{A.2}
\end{equation*}
$$

Let $N \geq 1$. Suppose now that $\left\{Z_{j, k}, j_{\ell} \geq 1, k_{\ell} \geq 2\right.$ for $\left.\ell=1, \ldots, N\right\}$ is a sequence of strictly $\alpha$-stable random variables such that
(i) For all $j \in(\mathbb{N} \backslash\{0\})^{N},\left\{Z_{j, k}, k_{\ell} \geq 2\right.$ for $\left.\ell=1, \ldots, N\right\}$ are independent;
(ii) For all $j \in(\mathbb{N} \backslash\{0\})^{N}$ and $k \in(\mathbb{N} \backslash\{0,1\})^{N},\left\|Z_{j, k}\right\|_{\alpha} \leq 1$.

Then, with probability 1, one has, for any $\gamma>0$,

$$
\begin{equation*}
\sup \left\{\left|Z_{j, k}\right| \prod_{\ell=1}^{N} j_{\ell}^{-1 / \alpha-\gamma} k_{\ell}^{-1 / \alpha} \log ^{-1 / \alpha-\gamma} k_{\ell}: j_{\ell} \geq 1, k_{\ell} \geq 2 \text { for } \ell=1, \ldots, N\right\}<\infty \tag{A.3}
\end{equation*}
$$

Proof Relation (A.2) follows from Property 1.2 .15 in 20]. Let us now show (A.3) for $N=1$, the proof for $N>1$ is similar. By using (A.2), we obtain, for all $j \geq 1$ and $n \geq 1$,

$$
\mathbb{P}\left(\max \left\{\left|Z_{j, 2}\right|, \ldots,\left|Z_{j, n}\right|\right\}>u_{j, n}\right) \leq 1-\left(1-c_{17} u_{j, n}^{-\alpha}\right)^{n}
$$

where $u_{j, n}=j^{1 / \alpha+\gamma} n^{1 / \alpha} \log ^{1 / \alpha+\gamma} n$. Defining $n_{m}=[\exp (m)]$, we obtain

$$
\mathbb{E}\left[\sum_{j \geq 1} \sum_{m \geq 1} \mathbb{1}_{\max \left\{\left|Z_{j, 2}\right|, \ldots,\left|Z_{j, n_{m}}\right|\right\}>u_{j, n_{m}}}\right]=\sum_{j \geq 1} \sum_{m \geq 1} \mathbb{P}\left(\max \left\{\left|Z_{j, 2}\right|, \ldots,\left|Z_{j, n_{m}}\right|\right\}>u_{j, n_{m}}\right)<\infty
$$

Thus the random variable $\sum_{j \geq 1} \sum_{m \geq 1} \mathbb{1}_{\max \left\{\left|Z_{j, 2}\right|, \ldots,\left|Z_{j, n_{m}}\right|\right\}>u_{j, n_{m}}}$ is a.s. finite. As a consequence there exists an a.s. finite positive random variable $C$ such that

$$
\max \left\{\left|Z_{j, 2}\right|, \ldots,\left|Z_{j, n_{m}}\right|\right\} \leq C u_{j, n_{m}} \quad \text { for all } \quad j \geq 1, m \geq 1
$$

Let $m(k)$ be the unique integer satisfying $n_{m(k)} \leq k<n_{m(k)+1}$. Thus for all $j \geq 1, k \geq 2$, we have

$$
\left|Z_{j, k}\right| \leq C u_{j, n_{m(k)+1}}=C j^{1 / \alpha+\gamma} n_{m(k)+1}^{1 / \alpha} \log ^{1 / \alpha+\gamma}\left(n_{m(k)+1}\right)
$$

Observe now that we have, for all $k \geq 2$,

$$
n_{m(k)+1} \leq \exp (m(k)+1) \leq \mathrm{e}\left(n_{m(k)}+1\right) \leq \mathrm{e}(k+1)
$$

Relation (A.3) follows from the last two displays.
Lemma 24. For any $\gamma \in[0,1)$ and $\eta \geq 0$, there exists a constant $c>0$ such that, for all $u \in \mathbb{R}$,

$$
\sum_{k \in \mathbb{Z}}(2+|u-k|)^{-2}(1+|k|)^{\gamma} \log ^{\eta}(2+|k|) \leq c(1+|u|)^{\gamma} \log ^{\eta}(2+|u|)
$$

Proof Put $k^{\prime}=[u]-k$, where $[u]$ is the integer part of $u$. Hence

$$
\begin{aligned}
\sum_{k \in \mathbb{Z}} \frac{(1+|k|)^{\gamma} \log ^{\eta}(2+|k|)}{(2+|u-k|)^{2}} & =\sum_{k^{\prime} \in \mathbb{Z}}\left(2+\left|u-[u]+k^{\prime}\right|\right)^{-2}\left(1+\left|[u]-k^{\prime}\right|\right)^{\gamma} \log ^{\eta}\left(2+\left|[u]-k^{\prime}\right|\right) \\
& \leq \sum_{k^{\prime} \in \mathbb{Z}}\left(1+\left|k^{\prime}\right|\right)^{-2}\left(2+|u|+\left|k^{\prime}\right|\right)^{\gamma} \log ^{\eta}\left(2+|u|+\left|k^{\prime}\right|\right)
\end{aligned}
$$

The result then follows by observing that $\left(2+|u|+\left|k^{\prime}\right|\right)^{\gamma} \leq(1+|u|)^{\gamma}\left(2+\left|k^{\prime}\right|\right)^{\gamma}, \log ^{\eta}\left(2+|u|+\left|k^{\prime}\right|\right) \leq$ $\left.c \log ^{\eta}(2+|u|) \log ^{\eta}\left(2+\left|k^{\prime}\right|\right)\right\}$ and $\gamma-2<-1$.

Lemma 25. Let $\theta \neq 0$ and $\gamma \in \mathbb{R}$. Set $c:=\sum_{n \geq 0} 2^{-|\theta| n}(1+n)^{|\gamma|}<\infty$. Then for any $n_{0}<n_{1}$ in $\{0, \pm 1, \pm 2, \ldots, \pm \infty\}$,

$$
\sum_{n=n_{0}}^{n_{1}} 2^{n \theta}(1+|n|)^{\gamma} \leq c \begin{cases}2^{n_{0} \theta}\left(1+\left|n_{0}\right|\right)^{\gamma} & \text { if } \theta<0  \tag{A.4}\\ 2^{n_{1} \theta}\left(1+\left|n_{1}\right|\right)^{\gamma} & \text { if } \theta>0\end{cases}
$$

Proof. Take e.g. $\theta<0$ and write

$$
\sum_{n=n_{0}}^{n_{1}} 2^{n \theta}(1+|n|)^{\gamma} \leq 2^{n_{0} \theta}\left(1+\left|n_{0}\right|\right)^{\gamma} \sum_{m \geq 0} 2^{m \theta}\left(\frac{1+\left|m+n_{0}\right|}{1+\left|n_{0}\right|}\right)^{\gamma}
$$

Now observe that

$$
\frac{1}{1+|m|} \leq \frac{1+\left|m+n_{0}\right|}{1+\left|n_{0}\right|} \leq 1+|m|
$$

so that $\sup _{n_{0}} \sum_{m \geq 0} 2^{m \theta}\left(\frac{1+\left|m+n_{0}\right|}{1+\left|n_{0}\right|}\right)^{\gamma}<\infty$ for any $\gamma \in \mathbb{R}$. $\square$
Lemma 26. For any $M>0, \eta>0$ small enough, $\delta \in(1 / \alpha+\eta, 1), \beta \in[0, \delta-1 / \alpha-\eta)$, any well-localized function $\phi$ and $x, y \in \mathbb{R}$, let $A_{n}(x, y):=A_{n}(x, y ; M, \phi, \delta, \beta, \eta)$ be the quantity defined as

$$
\begin{equation*}
A_{n}(x, y)=\sum_{|J| \leq n|K|>M 2^{n+1}} 2^{-J \delta} \frac{\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right|}{|x-y|^{\beta}}(3+|J|)^{1 / \alpha+\eta}(3+|K|)^{1 / \alpha+\eta} \tag{A.5}
\end{equation*}
$$

and let $B_{n}(x, y):=B_{n}(x, y ; \phi ; \delta, \beta, \eta)$ be the quantity defined as

$$
\begin{equation*}
B_{n}(x, y)=\sum_{|J| \geq n+1} \sum_{K \in \mathbb{Z}} 2^{-J \delta} \frac{\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right|}{|x-y|^{\beta}}(3+|J|)^{1 / \alpha+\eta}(3+|K|)^{1 / \alpha+\eta} \tag{A.6}
\end{equation*}
$$

with the convention that $A_{n}(x, x)=B_{n}(x, x)=0$ for any $x \in \mathbb{R}$. These quantities converge to 0 , uniformly in $x, y \in[-M, M]$, as $n$ goes to infinity.

Proof. Let $x, y \in[-M, M]$ and $J_{0} \geq-\log _{2}(2 M)$ be the unique integer such that

$$
\begin{equation*}
2^{-J_{0}-1}<|x-y| \leq 2^{-J_{0}} \tag{A.7}
\end{equation*}
$$

Let us first prove that $A_{n}(x, y)$ converges to 0 , uniformly in $x, y$ as $n$ goes to infinity. From now on we suppose that $J$ is an arbitrary integer satisfying $|J| \leq n$. We need to derive suitable upper bounds for the quantity

$$
\begin{equation*}
A_{n}^{(J)}(x, y)=\sum_{|K|>M 2^{n+1}} \frac{\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right|}{|x-y|^{\beta}}(3+|K|)^{1 / \alpha+\eta} . \tag{A.8}
\end{equation*}
$$

For this purpose, we consider two cases $J \leq J_{0}$ and $J \geq J_{0}+1$ separately. First we suppose that

$$
\begin{equation*}
J \leq J_{0} . \tag{A.9}
\end{equation*}
$$

Using the Mean Value Theorem, (2.2), (A.7) and A.9) one obtains that

$$
\begin{aligned}
\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right| & \leq c 2^{J}|x-y| \sup _{u \in I}(3+|u|)^{-2} \\
& \leq c 2^{J}|x-y|\left(2+\left|2^{J} x-K\right|\right)^{-2}
\end{aligned}
$$

where $I$ denotes the compact interval with end-points $2^{J} x-K$ and $2^{J} y-K$, whose length is at most 1 by (A.7) and (A.9). Next the last inequality and A.8) entail that

$$
\begin{equation*}
A_{n}^{(J)}(x, y) \leq c 2^{J}|x-y|^{1-\beta} \sum_{|K|>M 2^{n+1}} \frac{(3+|K|)^{1 / \alpha+\eta}}{\left(2+\left|2^{J} x-K\right|\right)^{2}} \tag{A.10}
\end{equation*}
$$

On the other hand, using that $|x| \leq M$ and $|J| \leq n$, for all $|K|>M 2^{n+1}$, one gets

$$
\begin{equation*}
\frac{(3+|K|)^{1 / \alpha+\eta}}{\left(2+\left|2^{J} x-K\right|\right)^{2}} \leq \frac{(3+|K|)^{1 / \alpha+\eta}}{\left(2+|K|-M 2^{n}\right)^{2}} \leq c(1+|K|)^{-(2-1 / \alpha-\eta)} . \tag{A.11}
\end{equation*}
$$

Putting together A.10, A.11 and A.7), one obtains that

$$
\begin{equation*}
A_{n}^{(J)}(x, y) \leq c 2^{J_{0}(\beta-1)} 2^{J-n(1-1 / \alpha-\eta)} \tag{A.12}
\end{equation*}
$$

Let us now study the second case where

$$
\begin{equation*}
J \geq J_{0}+1 \tag{A.13}
\end{equation*}
$$

It follows from A.7), A.13 and A.8 that

$$
\begin{equation*}
A_{n}^{(J)}(x, y) \leq 2^{J \beta} \sum_{|K|>M 2^{n+1}}\left\{\left|\phi\left(2^{J} x-K\right)\right|+\left|\phi\left(2^{J} x-K\right)\right|\right\}(3+|K|)^{1 / \alpha+\eta} \tag{A.14}
\end{equation*}
$$

On the other hand, using (2.2) and the fact that $|J| \leq n$ one has, for any real $u \in[-M, M]$ and any $K \in \mathbb{Z}$ satisfying $|K|>M 2^{n+1}$,

$$
\begin{equation*}
\left|\phi\left(2^{J} u-K\right)\right| \leq c\left(3+\left|2^{J} u-K\right|\right)^{-2} \leq c\left(3+|K|-M 2^{n}\right)^{-2} \leq c_{18}(3+|K|)^{-2} \tag{A.15}
\end{equation*}
$$

Combining A.14 with A.15 one gets that

$$
\begin{equation*}
A_{n}^{(J)}(x, y) \leq c_{19} 2^{J \beta-n(1-1 / \alpha-\eta)} \tag{A.16}
\end{equation*}
$$

It follows from A.5 (A.8), A.12 and A.16 that

$$
\begin{aligned}
A_{n}(x, y) & \leq c 2^{-n(1-1 / \alpha-\eta)}\left[2^{J_{0}(\beta-1)} \sum_{J=-\infty}^{J_{0}} 2^{J(1-\delta)}(3+|J|)^{1 / \alpha+\eta}+\sum_{J=J_{0}+1}^{\infty} 2^{J(\beta-\delta)}(3+|J|)^{1 / \alpha+\eta}\right] \\
& \leq c 2^{-n(1-1 / \alpha-\eta)} 2^{J_{0}(\beta-\delta)}\left(3+\left|J_{0}\right|\right)^{1 / \alpha+\eta} \\
& \leq c_{20} 2^{-n(1-1 / \alpha-\eta)}
\end{aligned}
$$

where we used Lemma 25 to bound the series and then the fact $2^{-J_{0}} \leq 2 M$ (see (A.7)). Since $c_{20}$ does not depend on $(x, y)$, the last inequality proves that $A_{n}(x, y)$ converges to 0 , uniformly in $x, y \in[-M, M]$ as $n$ goes to infinity.

Let us now prove that $B_{n}(x, y)$ converges to 0 , uniformly in $x, y$ as $n$ goes to infinity. In all the sequel $J$ denotes an arbitrary integer satisfying $|J| \geq n+1$. First, we derive a suitable upper bound for the quantity

$$
\begin{equation*}
B_{n}^{(J)}(x, y)=\sum_{K \in \mathbb{Z}} \frac{\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right|}{|x-y|^{\beta}}(3+|K|)^{1 / \alpha+\eta} \tag{A.17}
\end{equation*}
$$

As above, we distinguish two cases: $J \leq J_{0}$ and $J \geq J_{0}+1$. First we suppose that (A.9) is verified. As in (A.10), we have $B_{n}^{(J)}(x, y) \leq c 2^{J}|x-y|^{1-\beta} \sum_{K \in \mathbb{Z}}(3+|K|)^{1 / \alpha+\eta}\left(2+\left|2^{J} x-K\right|\right)^{-2}$. Next, using (A.7) and Lemma 24 and the fact that $|x| \leq M$, one obtains that

$$
\begin{equation*}
B_{n}^{(J)}(x, y) \leq c 2^{J+J_{0}(\beta-1)}\left(1+2^{J}\right)^{1 / \alpha+\eta} \tag{A.18}
\end{equation*}
$$

Now let us suppose that A.13) is verified. By using this relation, A.7), the triangle inequality, (2.2), Lemma 24 and the fact that $x, y \in[-M, M]$, one gets

$$
\begin{align*}
B_{n}^{(J)}(x, y) & \leq 2^{J \beta} \sum_{K \in \mathbb{Z}}\left\{\left|\phi\left(2^{J} x-K\right)\right|+\left|\phi\left(2^{J} y-K\right)\right|\right\}(3+|K|)^{1 / \alpha+\eta} \\
& \leq c 2^{J \beta} \sum_{K \in \mathbb{Z}}\left\{\left(3+\left|2^{J} x-K\right|\right)^{-2}+\left(3+\left|2^{J} y-K\right|\right)^{-2}\right\}(3+|K|)^{1 / \alpha+\eta} \\
& \leq c 2^{J \beta}\left\{\left(1+2^{J}|x|\right)^{1 / \alpha+\eta}+\left(1+2^{J}|y|\right)^{1 / \alpha+\eta}\right\} \\
& \leq c 2^{J(\beta+1 / \alpha+\eta)} . \tag{A.19}
\end{align*}
$$

Since $2^{-J_{0}} \leq M$, for all $n \geq \log _{2}(2 M)$, we have $-n \leq J_{0}$, and thus, by (A.18),

$$
\begin{align*}
\sum_{J \leq-n} 2^{-J \delta}(3+|J|)^{1 / \alpha+\eta} B_{n}^{(J)}(x, y) & \leq c 2^{J_{0}(\beta-1)} \sum_{J \leq-n} 2^{J(1-\delta)}(3+|J|)^{1 / \alpha+\eta} \\
& \leq c 2^{n(\delta-1)}(1+n)^{1 / \alpha+\eta} \tag{A.20}
\end{align*}
$$

where we used Lemma 25 and $2^{-J_{0}} \leq M$. Applying Lemma 25with A.18) and A.19) yields

$$
\begin{equation*}
\sum_{J \in \mathbb{Z}} 2^{-J \delta}(3+|J|)^{1 / \alpha+\eta} B_{n}^{(J)}(x, y) \leq c 2^{J_{0}(\beta+1 / a+\eta-\delta)}\left(3+\left|J_{0}\right|\right)^{1 / \alpha+\eta} \tag{A.21}
\end{equation*}
$$

and for any $n \geq J_{0}$,

$$
\begin{equation*}
\sum_{J \geq n} 2^{-J \delta}(3+|J|)^{1 / \alpha+\eta} B_{n}^{(J)}(x, y) \leq c 2^{n(\beta+1 / a+\eta-\delta)}(3+n)^{1 / \alpha+\eta} . \tag{A.22}
\end{equation*}
$$

Since $\beta+1 / a+\eta-\delta<0$, the function $t \mapsto 2^{t(\beta+1 / a+\eta-\delta)}(3+t)^{1 / \alpha+\eta}$ is decreasing for $t$ large enough, and hence for $n$ large enough, either $n \geq J_{0}$ and we may apply A.22), or $n \leq J_{0}$ and we may apply (A.21) whose right-hand side is smaller than the right-hand side of A.22). Hence (A.22) holds for all $n$ large enough independently of $J_{0}$. This, with A.20, shows that $B_{n}(x, y)$ converges uniformly in $x, y$, as $n$ goes to infinity.

Lemma 27. Let $\phi$ be a well-localized function i.e. a function satisfying the condition (2.2). For any $\delta \in(0,1), \gamma \in(0, \delta)$ and $\eta \geq 0$, define

$$
\begin{equation*}
S_{\delta, \gamma, \eta}(x, y ; \phi)=\sum_{(J, K) \in \mathbb{Z}^{2}} 2^{-J \delta}\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right|(3+|J|)^{\gamma+\eta}(3+|K|)^{\gamma} \log ^{\gamma+\eta}(2+|K|) \tag{A.23}
\end{equation*}
$$

and

$$
\begin{equation*}
T_{\delta, \gamma, \eta}(x ; \phi)=\sum_{(J, K) \in \mathbb{Z}^{2}} 2^{-J \delta}\left|\phi\left(2^{J} x-K\right)-\phi(-K)\right|(3+|J|)^{\gamma+\eta}(3+|K|)^{\gamma} \log ^{\gamma+\eta}(2+|K|) . \tag{A.24}
\end{equation*}
$$

Then, there exists a constant $c>0$, only depending on $\delta, \gamma$ and $\phi$, such that the inequalities

$$
\begin{align*}
S_{\delta, \gamma, \eta}(x, y ; \phi) \leq c|y-x|^{\delta-\gamma} & {\left[|y-x|^{\gamma}+|x|^{\gamma}+|y|^{\gamma}\right] } \\
& \times(1+|\log | y-x| |)^{2 \gamma+2 \eta}\left\{\log ^{\gamma+\eta}(2+|x|)+\log ^{\gamma+\eta}(2+|y|)\right\} \tag{A.25}
\end{align*}
$$

and

$$
\begin{equation*}
T_{\delta, \gamma, \eta}(x ; \phi) \leq c(1+|\log | x| |)^{\gamma+\eta}|x|^{\delta} \tag{A.26}
\end{equation*}
$$

hold for all $x, y \in \mathbb{R}$ (with the convention that $0^{a} \times \log ^{b} 0=0$ for all $a, b>0$ ).
Proof. We only prove (A.25), the proof of (A.26) is similar. By (2.2), there is a constant $c>0$ such that, for all $J, K \in \mathbb{Z}$ and $x, y \in \mathbb{R}$,

$$
\begin{equation*}
\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right| \leq c\left\{\left(2+\left|2^{J} x-K\right|\right)^{-2}+\left(2+\left|2^{J} y-K\right|\right)^{-2}\right\} . \tag{A.27}
\end{equation*}
$$

The quantity $\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right|$ can be bounded more sharply when the condition $2^{J}|x-y| \leq 1$ holds, namely by using (2.2) and the Mean Value Theorem one obtains that

$$
\begin{align*}
\left|\phi\left(2^{J} x-K\right)-\phi\left(2^{J} y-K\right)\right| & \leq c 2^{J}|x-y| \sup _{u \in I}\left(3+\left|2^{J} u-K\right|\right)^{-2} \\
& \leq c 2^{J}|x-y|\left(2+\left|2^{J} x-K\right|\right)^{-2} \tag{A.28}
\end{align*}
$$

where $I$ denotes the compact interval whose end-points are $x$ and $y$. From now on we will assume that $x \neq y$ (Relation (A.25) is trivial otherwise) and let $J_{0} \in \mathbb{Z}$ be the unique integer satisfying

$$
\begin{equation*}
1 / 2<2^{J_{0}}|y-x| \leq 1 \tag{A.29}
\end{equation*}
$$

The inequalities (A.27) and (A.28) entail that

$$
\begin{equation*}
S_{\delta, \gamma, \eta}(x, y ; \phi) \leq c\left(A_{J_{0}}|x-y|+B_{J_{0}}\right) \tag{A.30}
\end{equation*}
$$

where

$$
A_{J_{0}}=\sum_{J \leq J_{0}} \sum_{K \in \mathbb{Z}} 2^{J(1-\delta)}\left(2+\left|2^{J} x-K\right|\right)^{-2}(3+|J|)^{\gamma+\eta}(3+|K|)^{\gamma} \log ^{\gamma+\eta}(2+|K|)
$$

and
$B_{J_{0}}=\sum_{J>J_{0}} \sum_{K \in \mathbb{Z}} 2^{-J \delta}\left\{\left(2+\left|2^{J} x-K\right|\right)^{-2}+\left(2+\left|2^{J} y-K\right|\right)^{-2}\right\}(3+|J|)^{\gamma+\eta}(3+|K|)^{\gamma} \log ^{\gamma+\eta}(2+|K|)$.
Lemma 24 and Lemma 25 yield

$$
A_{J_{0}} \leq c 2^{J_{0}(1-\delta)}\left(1+|x|^{\gamma} 2^{J_{0} \gamma}\right)\left(1+\left|J_{0}\right|\right)^{2 \gamma+2 \eta} \log ^{\gamma+\eta}(2+|x|)
$$

and, since $\gamma-\delta<0$,

$$
B_{J_{0}} \leq c 2^{-J_{0} \delta}\left(1+\left(|x|^{\gamma}+|y|^{\gamma}\right) 2^{J_{0} \gamma}\right)\left(1+\left|J_{0}\right|\right)^{2 \gamma+2 \eta}\left\{\log ^{\gamma+\eta}(2+|x|)+\log ^{\gamma+\eta}(2+|y|)\right\} .
$$

Inserting these two bounds into (A.30) and using A.29), we get A.25) and the proof is finished.
