# GAUSSIAN MULTIPLICATIVE CHAOS REVISITED

#### Abstract

In this article, we extend the theory of multiplicative chaos for positive definite functions in $\mathbb{R}^{d}$ of the form $f(x)=\lambda^{2} \ln ^{+} \frac{T}{|x|}+g(x)$ where $g$ is a continuous and bounded function. The construction is simpler and more general than the one defined by Kahane in 1985. As main application, we give a rigorous mathematical meaning to the Kolmogorov-Obukhov model of energy dissipation in a turbulent flow.

## 1. Introduction

The theory of multiplicative chaos was first defined rigorously by Kahane in 1985 in the article [12]. More specifically, Kahane built a theory relying on the notion of $\sigma$-positive type kernel: a generalized function $K: \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}_{+} \cup\{\infty\}$ is of $\sigma$-positive type if there exists a sequence $K_{k}: \mathbb{R}^{d} \times \mathbb{R}^{d} \rightarrow \mathbb{R}_{+}$of continuous positive and positive definite kernels such that:

$$
\begin{equation*}
K(x, y)=\sum_{k \geqslant 1} K_{k}(x, y) . \tag{1.1}
\end{equation*}
$$

If $K$ is a $\sigma$-positive type kernel with decomposition (1.1), one can consider a sequence of gaussian processes $\left(X_{n}\right)_{n} \geqslant 1$ of covariance given by $\sum_{k=1}^{n} K_{k}$. It is proven in (12] that the sequence of random measures $m_{n}$ given by:

$$
\begin{equation*}
\forall A \in \mathcal{B}\left(\mathbb{R}^{d}\right), \quad m_{n}(A)=\int_{A} e^{X_{n}(x)-\frac{1}{2} E\left[X_{n}(x)^{2}\right]} d x \tag{1.2}
\end{equation*}
$$

converges almost surely in the space of Radon measures (equiped with the topology of weak convergence) towards a random measure $m$ and that the limit measure $m$ obtained does not depend on the sequence $\left(K_{k}\right)_{k} \geqslant 1$ used in the decomposition
(1.1) of $K$. Thus, the theory enables to give a unique and mathematically rigorous definition to a random measure $m$ in $\mathbb{R}^{d}$ defined formally by:

$$
\begin{equation*}
\forall A \in \mathcal{B}\left(\mathbb{R}^{d}\right), \quad m(A)=\int_{A} e^{X(x)-\frac{1}{2} E\left[X(x)^{2}\right]} d x \tag{1.3}
\end{equation*}
$$

where $(X(x))_{x \in \mathbb{R}^{d}}$ is a "gaussian field" whose covariance $K$ is a $\sigma$-positive type kernel. As it will appear later the $\sigma$-positive type condition is not easy to check in practice. From where the need to avoid this hypothesis.

The main application of the theory is to give a meaning to the "limit-lognormal" model introduced by Mandelbrot in [15]. In the sequel, we define $\ln ^{+} x$ for $x>0$ by the following formula:

$$
\ln ^{+} x=\max (\ln (x), 0) .
$$

The "limit-lognormal" model corresponds to the choice of a stationnary $K$ given by:

$$
\begin{equation*}
K(s, t)=\lambda^{2} \ln ^{+}(R /|x-y|)+O(1) \tag{1.4}
\end{equation*}
$$

where $\lambda^{2}, R$ are positive parameters and $O(1)$ is a bounded quantity as $|x-y| \rightarrow 0$. This model has many applications that we now review in the following subchapters.

### 1.1. Multplicative chaos in dimension 1: a model for the volatility of a

 financial asset. If $(X(t))_{t \geqslant 0}$ is the logarithm of the price of a financial asset, the volatility $m$ of the asset on the interval $[0, t]$ is by definition equal to the quadratic variation of $X$ :$$
m[0, t]=\lim _{n \rightarrow \infty} \sum_{k=1}^{n}(X(t k / n)-X(t(k-1) / n))^{2}
$$

The volatility $m$ can be viewed as a random measure on $\mathbb{R}$. The choice for $m$ of multiplicative chaos associated to the kernel $K(s, t)=\lambda^{2} \ln ^{+} \frac{T}{|t-s|}$ satisfies many empirical properties measured on financial markets: lognormality of the volatility, long range correlations (see [5] for a study of the SP500 index and components and [6] for a general review). Note that $K$ is indeed of $\sigma$-positive type (see example 2.3 below) so $m$ is well defined. In the context of finance, $\lambda^{2}$ is called the intermittency parameter in analogy with turbulence and $T$ is the correlation length. Volatility modeling and forecasting is an important field of finance since it is related to option pricing and risk forecasting: we refer to [8] for the problem of forecasting volatility with this choice of $m$.

Given the volatility $m$, the most natural way to construct a model for the (log) price $X$ is to set:

$$
\begin{equation*}
X(t)=B_{m[0, t]} \tag{1.5}
\end{equation*}
$$

where $\left(B_{t}\right)_{t} \geqslant 0$ is a brownian motion independent of $m$. Formula (1.5) defines the Multifractal Random Walk (MRW) first introduced in [1] (see [2] for a recent review of the financial applications of the MRW model).
1.2. Multiplicative chaos in dimension 3: a model for the energy dissipation in a turbulent fluid. We refer to [9] for an introduction to the statistical theory of 3 dimensional turbulence. Consider a stationnary flow at high Reynolds number; it is believed that at small scales the velocity field of the flow is homogeneous and isotropic in space. By small scales we mean scales much smaller than the integral scale $R$ charactersistic of the time stationnary force driving the flow. In the work [13] and [17], Kolmogorov and Obukhov propose to model the mean energy dissipation per unit mass in a ball $B(x, l)$ of center $x$ and radius $l \ll R$ by a random variable $\epsilon_{l}$ such that $\ln \left(\epsilon_{l}\right)$ is normal with variance $\sigma_{l}^{2}$ given by:

$$
\sigma_{l}^{2}=\lambda^{2} \ln \left(\frac{R}{l}\right)+A
$$

where $A$ is a constant and $\lambda^{2}$ is the intermittency parameter. As noted by Mandelbrot ( 150 ), the only way to define such a model is to construct a random measure $\epsilon$ by a limit procedure. Then, one can define $\epsilon_{l}$ by the formula:

$$
\epsilon_{l}=\frac{3<\epsilon>}{4 \pi l^{3}} \epsilon(B(x, l))
$$

where $\langle\epsilon>$ is the average mean energy disspation per unit mass. Formally, one is looking for a random measure $\epsilon$ such that:

$$
\begin{equation*}
\forall A \in \mathcal{B}\left(\mathbb{R}^{d}\right), \quad \epsilon(A)=\int_{A} e^{X(x)-\frac{1}{2} E\left[X(x)^{2}\right]} d x \tag{1.6}
\end{equation*}
$$

where $(X(x))_{x \in \mathbb{R}^{d}}$ is a "gaussian field" whose covariance $K$ is given by $K(x, y)=$ $\lambda^{2} \ln ^{+} \frac{R}{|x-y|}$. The kernel $\lambda^{2} \ln ^{+} \frac{R}{|x-y|}$ is positive definite considered as a tempered distribution (see (2.1) for a definition of positive definite distributions and lemma 3.2 for a proof). Therefore, one can give a rigorous meaning to (1.6) by using theoremdefinition 2.1 below.
However, it is not clear if $\lambda^{2} \ln ^{+} \frac{R}{|x-y|}$ is of $\sigma$-positive type in $\mathbb{R}^{3}$ and therefore, in [12], Kahane considers the $\sigma$-positive type kernel $K(x, y)=\int_{1 / T}^{\infty} \frac{e^{-u|x-y|}}{u} d u$ as an approximation of $\lambda^{2} \ln ^{+} \frac{R}{|x-y|}$ : indeed, one can show that $\int_{1 / T}^{\infty} \frac{e^{-u|x-y|}}{u} d u=\ln ^{+} \frac{R}{|x-y|}+$ $g(|x-y|)$ where $g$ is a bounded continuous function. Nevertheless, it is important to work with $\lambda^{2} \ln ^{+} \frac{R}{|x-y|}$ since this choice leads to measures which exhibit generalized scale invariance properties (see proposition (3.3).
1.3. Organization of the paper. In section 2 , we remind the definition of positive definite tempered distributions and we state theorem-definition 2.1 where we define multiplicative chaos $m$ associated to kernels of the type $\ln ^{+} \frac{R}{|x|}+O(1)$. In section 3, we review the main properties of the measure $m$ : existence of moments and density with respect to Lebesgue measure, multifractality and generalized scale invariance. In section 4 and 5, we give respectively the proofs of section 2 and 3 .

## 2. Definition of multiplicative chaos

2.1. Positive definite tempered distributions. Let $\mathcal{S}\left(\mathbb{R}^{d}\right)$ be the Schwartz space of smooth rapidly decreasing functions and $\mathcal{S}^{\prime}\left(\mathbb{R}^{d}\right)$ the space of tempered distributions (see [19]). A distribution $f$ in $\mathcal{S}^{\prime}\left(\mathbb{R}^{d}\right)$ is of positive definite if:

$$
\begin{equation*}
\forall \varphi \in \mathcal{S}\left(\mathbb{R}^{d}\right), \quad \int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}} f(x-y) \varphi(x) \overline{\varphi(y)} d x d y \geqslant 0 \tag{2.1}
\end{equation*}
$$

On $\mathcal{S}^{\prime}\left(\mathbb{R}^{d}\right)$, one can define the Fourier transform $\hat{f}$ of a tempered distribution by the formula:

$$
\begin{equation*}
\forall \varphi \in \mathcal{S}\left(\mathbb{R}^{d}\right), \quad \int_{\mathbb{R}^{d}} \hat{f}(\xi) \varphi(\xi) d \xi=\int_{\mathbb{R}^{d}} f(x) \hat{\varphi}(x) d x \tag{2.2}
\end{equation*}
$$

where $\hat{\varphi}(x)=\int_{\mathbb{R}^{d}} e^{-2 i \pi x . \xi} \varphi(\xi) d \xi$ is the Fourier transform of $\varphi$. An extension of Bochner's theorem (Schwartz, 19]) states that a tempered distribution $f$ is positive definite if and only if it's Fourier transform is a tempered positive measure.

By definition, a function $f$ in $\mathcal{S}^{\prime}\left(\mathbb{R}^{d}\right)$ is of $\sigma$-positive type if the associated kernel $K(x, y)=f(x-y)$ is of $\sigma$-positive type. As mentioned in the introduction, Kahane's theory of multiplicative chaos is defined for $\sigma$-positive type functions $f$. The main problem stems from the fact that definition (1.1) is not practical. Indeed, is there a simple characterization (like the computation of a Fourier transform) of functions whose associated kernel can be decomposed along (1.1)? If such a characterization exists, how does one find the kernels $K_{n}$ explicitely?

Finally, we recall the following simple implication: If $f$ belongs to $\mathcal{S}^{\prime}\left(\mathbb{R}^{d}\right)$ and is of $\sigma$-positive type, $f$ is positive and positive definite. However, the converse statement is not clear.
2.2. A generalized theory of multiplicative chaos. In this subsection, we contruct a theory of multiplicative chaos for positive definite functions of type $\lambda^{2} \ln ^{+} \frac{R}{|x|}+$ $O(1)$ without the assumption of $\sigma$-positivity for the underlying function. The theory is therefore much easier to use.

We consider in $\mathbb{R}^{d}$ a positive definite function $f$ such that

$$
\begin{equation*}
f(x)=\lambda^{2} \ln ^{+} \frac{R}{|x|}+g(x) \tag{2.3}
\end{equation*}
$$

where $\lambda^{2} \neq 2 d$ and $g(x)$ is a bounded continuous function. Let $\theta: \mathbb{R}^{d} \rightarrow \mathbb{R}$ be some continuous function with the following properties:
(1) $\theta$ is positive definite
(2) $|\theta(x)| \leqslant \frac{1}{1+|x|^{d+\gamma}}$ for some $\gamma>0$.
(3) $\int_{\mathbb{R}^{d}} \theta(x) d x=1$

Here is the main theorem of the article:
Theorem 2.1. (Definition of multiplicative chaos)
For all $\epsilon>0$, we consider the centered gaussian field $\left(X_{\epsilon}(x)\right)_{x \in \mathbb{R}^{d}}$ defined by the convolution:

$$
E\left[X_{\epsilon}(x) X_{\epsilon}(y)\right]=\left(\theta^{\epsilon} * f\right)(y-x),
$$

where $\theta^{\epsilon}=\frac{1}{\epsilon^{\theta}} \theta(\dot{\bar{\epsilon}})$. Then the associated random measure $m_{\epsilon}(d x)=e^{X_{\epsilon}(x)-\frac{1}{2} E\left[X_{\epsilon}(x)^{2}\right]} d x$ converges in law in the space of Radon mesures (equiped with the topology of weak convergence) as $\epsilon$ goes to 0 towards a random measure $m$ independent of the choice of the regularizing function $\theta$ with the properties (1), (2), (3). We call the measure $m$ the multiplicative chaos associated to the function $f$.

We review below two possible choices of the underlying function $f$. The first example is a $d$-dimensional generalization of the cone construction considered in [3]. The second example is $\lambda^{2} \ln ^{+} \frac{R}{|x|}$ for $d=1,2,3$ (the case $d=2,3$ seems to have never been considered in the litterature). Both examples are in fact of $\sigma$-positive type (except perhaps the crucial example of $\lambda^{2} \ln ^{+} \frac{R}{|x|}$ in dimension $d=3$ ) and it is easy to show that in these cases theorem-definition 2.1 and Kahane's theory lead to the same limit measure $m$.

Example 2.2. One can construct a positive definite function $f$ with decomposition (2.3) by generalizing to dimension d the cone construction of [3]. This was performed in 囷. For all $x$ in $\mathbb{R}^{d}$, we define the cone $C(x)$ in $\mathbb{R}^{d} \times \mathbb{R}_{+}$:

$$
C(x)=\left\{(y, t) \in \mathbb{R}^{d} \times \mathbb{R}_{+} ;|y-x| \leqslant \frac{t \wedge T}{2}\right\}
$$

The function $f$ is given by:

$$
\begin{equation*}
f(x)=\lambda^{2} \int_{C(0) \cap C(x)} \frac{d y d t}{t^{d+1}} \tag{2.4}
\end{equation*}
$$

One can show that $f$ has decomposition (2.3) (see [(]). The function $f$ is of $\sigma$-positive type in the sense of Kahane since one can write $f=\sum_{n \geqslant 1} f_{n}$ with $f_{n}$ given by:

$$
f_{n}(x)=\lambda^{2} \int_{C(0) \cap C(x) ; \frac{1}{n} \leqslant t<\frac{1}{n-1}} \frac{d y d t}{t^{d+1}}
$$

In dimension $d=1$, we get the simple formula $f(x)=\ln ^{+} \frac{R}{|x|}$.
Example 2.3. In dimension $d=1,2$, the function $f(x)=\ln ^{+} \frac{R}{|x|}$ is of $\sigma$-positive type in the sense of Kahane and in particular positive definite. Indeed, one has by straightforward calculations:

$$
\ln ^{+} \frac{T}{|x|}=\int_{0}^{\infty}(t-|x|)_{+} \nu_{T}(d t)
$$

where $\nu_{T}(d t)=1_{[0, T[ }(t) \frac{d t}{t^{2}}+\frac{\delta_{T}}{T}$. For all $\mu>0$, we have:

$$
\ln ^{+} \frac{T}{|x|}=\frac{1}{\mu} \ln ^{+} \frac{T^{\mu}}{|x|^{\mu}}=\frac{1}{\mu} \int_{0}^{\infty}\left(t-|x|^{\mu}\right)_{+} \nu_{T^{\mu}}(d t)
$$

We are therefore led to considering the $\mu>0$ such that $\left(1-|x|^{\mu}\right)_{+}$is positive definite (the so called Kuttner-Golubov problem: see (10] for an introduction).

For $d=1$, it is straightforward to show that $(1-|x|)_{+}$is of positive type. One can thus write $f=\sum_{n \geqslant 1} f_{n}$ with $f_{n}$ given by:

$$
f_{n}(x)=\int_{\frac{T}{n}}^{\frac{T}{n-1}}(t-|x|)_{+} \nu_{T}(d t) .
$$

For $d=2$, the function $\left(1-|x|^{1 / 2}\right)$ is positive definite (Pasenchenko, [18]). One can thus write $f=\sum_{n \geqslant 1} f_{n}$ with $f_{n}$ given by:

$$
f_{n}(x)=\int_{\frac{T^{1 / 2}}{n}}^{\frac{T^{1 / 2}}{n-1}}\left(t-|x|^{1 / 2}\right)+\nu_{T^{1 / 2}}(d t) .
$$

In dimension $d=3$, the function $\ln ^{+} \frac{R}{|x|}$ is positive definite (see lemma 3.2 below) but it is an open question whether it is of $\sigma$-positive type.

## 3. Main properties of multiplicative chaos

In the sequel, we will consider the structure functions $\zeta_{p}$ defined for all $p$ in $\mathbb{R}$ by:

$$
\begin{equation*}
\zeta_{p}=\left(d+\frac{\lambda^{2}}{2}\right) p-\frac{\lambda^{2} p^{2}}{2} \tag{3.1}
\end{equation*}
$$

3.1. Multiplicative chaos is equal to 0 for $\lambda^{2}>2 d$. The following proposition can be seen as a phase transition and shows that the logarithmic kernel is crucial in the theory of multiplicative chaos:
Proposition 3.1. If $\lambda^{2}>2 d$, the limit measure is equal to 0 .
3.2. Generalized scale invariance. In this subsection and the following, in view of proposition 3.1, we will suppose that $\lambda^{2}<2 d$ :

Let $m$ be a homogeneous random measure on $\mathbb{R}^{d}$. We note $B(0, R)$ the ball of center 0 and radius $R$ in $\mathbb{R}^{d}$. We say $m$ has the generalized scale invariance property with integral scale $R>0$ if for all $c$ in $] 0,1]$ the following equality in law holds:

$$
\begin{equation*}
(m(c A))_{A \subset B(0, R)} \stackrel{(L a w)}{=} e^{\Omega_{c}}(m(A))_{A \subset B(0, R)} \tag{3.2}
\end{equation*}
$$

where $\Omega_{c}$ is a random variable independent from $m$. If $m$ is different from 0 , then it is immediate to prove that $\left(\Omega_{e^{-t}}\right)_{t \geqslant 0}$ is a Levy process. In the context of gaussian multiplicative chaos, the process $\left(\Omega_{e^{-t}}\right)_{t \geqslant 0}$ will be Brownian motion with drift.

In order to get scale invariance with integral scale $R$, one can choose $f=\ln ^{+} \frac{R}{\mid .1}$. This is possible if and only if $\ln ^{+} \frac{R}{|.|}$ is positive defnite. This motivates the following lemma:

Lemma 3.2. Let $d \geqslant 1$ be the dimension of the space and $R>0$ the integral scale. We consider the function $f: \mathbb{R}^{d} \rightarrow \mathbb{R}_{+}$defined by:

$$
f(x)=\ln ^{+} \frac{R}{|x|}
$$

The function $f$ is positive definite if and only if $d \leqslant 3$.

The above choice of $f$ leads to measures that have the generalized scale invariance property.
Proposition 3.3. Let $d$ be less or equal to 3 and $m$ be the gaussian multplicative chaos with kernel $\lambda^{2} \ln ^{+} \frac{R}{|x|}$. Then $m$ is scale invariant; for all $c$ in $\left.] 0,1\right]$, the following equality holds:

$$
\begin{equation*}
(m(c A))_{A \subset B(0, R)} \stackrel{(\text { Law })}{=} e^{\Omega_{c}}(m(A))_{A \subset B(0, R)}, \tag{3.3}
\end{equation*}
$$

where $\Omega_{c}$ is a gaussian random variable independent of $m$ with mean $-\left(d+\frac{\lambda^{2}}{2}\right) \ln (1 / c)$ and variance $\lambda^{2} \ln (1 / c)$

The proof of the proposition is straightforward.
Remark 3.4. It remains an open question to construct homogeneous measures in dimension greater or equal to 4 which are scale invariant.
3.3. Existence of moments and multifractality. We remind that we suppose that $\lambda^{2}<2 d$ : this ensures the existence of $\epsilon>0$ such that $\zeta_{1+\epsilon}>d$. Therefore, there exists a unique $p_{*}>1$ such that $\zeta_{p_{*}}=d$. The following two propositions establish the existence of positive and negative moments for the limit measure.

Proposition 3.5. (Positive Moments)
Let $p$ belong to $] 0, p_{*}[$ and $m$ be the gaussian multiplicative chaos associated to the function $f$ given by (2.3). For all bounded $A$ in $\mathcal{B}\left(\mathbb{R}^{d}\right)$,

$$
\begin{equation*}
E\left[m(A)^{p}\right]<\infty \tag{3.4}
\end{equation*}
$$

Let $\theta$ be some function satisfying the conditions (1), (2), (3) of section 2.2. With the notations of theorem 2.1, we consider the random measure $m_{\epsilon}$ associated to $\theta$. We have the following convergence for all bounded $A$ in $\mathcal{B}\left(\mathbb{R}^{d}\right)$ :

$$
\begin{equation*}
E\left[m_{\epsilon}(A)^{p}\right] \underset{\epsilon \rightarrow 0}{\rightarrow} E\left[m(A)^{p}\right] . \tag{3.5}
\end{equation*}
$$

Proposition 3.6. (Negative Moments)
Let $p$ belong to ] $-\infty, 0]$ and $m$ be the gaussian multiplicative chaos associated to the function $f$ given by (2.3). For all $c>0$,

$$
\begin{equation*}
E\left[m(B(0, c))^{p}\right]<\infty \tag{3.6}
\end{equation*}
$$

Let $\theta$ be some function satisfying the conditions (1), (2), (3) of section 2.2. With the notations of theorem 2.1, we consider the random measure $m_{\epsilon}$ associated to $\theta$. We have the following convergence for all $c>0$ :

$$
\begin{equation*}
E\left[m_{\epsilon}(B(0, c))^{p}\right] \underset{\epsilon \rightarrow 0}{\rightarrow} E\left[m(B(0, c))^{p}\right] . \tag{3.7}
\end{equation*}
$$

The following proposition states the existence of the structure functions.
Proposition 3.7. Let $p$ belong to $]-\infty, p_{*}[$. Let $m$ be the gaussian multiplicative chaos associated to the function $f$ given by (2.3). There exists some $C_{p}>0$ (independent of $g$ and $R$ in decomposition (2.3): $C_{p}=C_{p}\left(\lambda^{2}\right)$ ) such that we have the following multifractal behaviour:

$$
\begin{equation*}
E\left[m\left([0, c]^{d}\right)^{p}\right] \underset{c \rightarrow 0}{\sim} e^{\frac{p(p-1) g(0)}{2}} C_{p}\left(\frac{c}{R}\right)^{\zeta_{p}} . \tag{3.8}
\end{equation*}
$$

In the next proposition, we will suppose that $d \leqslant 3$ and that $f(x)=\lambda^{2} \ln ^{+} \frac{R}{|x|}$. In this case, we can prove the existence of a $C^{\infty}$ density.

Proposition 3.8. Let $d$ be less or equal to 3 and $m$ be the gaussian multiplicative chaos with kernel $\lambda^{2} \ln ^{+} \frac{R}{|x|}$. For all $c<R$, the variable $m(B(0, c))$ has a $C^{\infty}$ density with respect to the Lebesgue measure.

## 4. Proof of theorem 2.1

4.1. A few intermediate lemmas. In order to prove the theorem, we start by giving some lemmas we will need in the proof.
Lemma 4.1. Let $\theta$ be some function on $\mathbb{R}^{d}$ such that there exists $\gamma, C>0$ with $|\theta(x)| \leqslant \frac{C}{1+|x|^{d+\gamma}}$. Then we have the following convergence:

$$
\begin{equation*}
\sup _{|z|>A}\left|\int_{\mathbb{R}^{d}}\right| \theta(v)|\ln | \frac{z}{z-v}|d v| \underset{A \rightarrow \infty}{\rightarrow} 0 . \tag{4.1}
\end{equation*}
$$

Proof. We have:

$$
\int_{\mathbb{R}^{d}}|\theta(v)| \ln \left|\frac{z}{z-v}\right| d v=\int_{|v| \leqslant \sqrt{|z|}}|\theta(v)| \ln \left|\frac{z}{z-v}\right| d v+\int_{|v|>\sqrt{|z|}}|\theta(v)| \ln \left|\frac{z}{z-v}\right| d v .
$$

Consider the first term: we have $1-\frac{|v|}{|z|} \leqslant \frac{|z-v|}{|z|} \leqslant 1+\frac{|v|}{|z|}$ so that for $|v| \leqslant \sqrt{|z|}$ :

$$
1-\frac{1}{\sqrt{|z|}} \leqslant \frac{|z-v|}{|z|} \leqslant 1+\frac{1}{\sqrt{|z|}}
$$

thus we get $\left|\ln \frac{|z-v|}{|z|}\right| \leqslant \ln \left(\frac{1}{1-\frac{1}{\sqrt{|z|}}}\right) \leqslant \frac{1}{\sqrt{|z|}-1}$. We conclude:

$$
\int_{|v| \leqslant \sqrt{|z|}}|\theta(v)| \ln \left|\frac{z}{z-v}\right| d v \leqslant \frac{1}{\sqrt{|z|}-1} \int_{\mathbb{R}^{d}}|\theta(v)| d v
$$

Consider the second term: we have:

$$
\int_{|v|>\sqrt{|z|}}|\theta(v)| \ln \left|\frac{z}{z-v}\right| d v \leqslant \ln |z| \int_{|v|>\sqrt{|z|}}|\theta(v)| d v+\int_{|v|>\sqrt{|z|}}|\theta(v)||\ln | z-v| | d v
$$

The first term above is obvious; we decompose the second:

$$
\int_{|v|>\sqrt{|z|}}|\theta(v)||\ln | z-v| | d v=\int_{\sqrt{|z|<|v|<|z|+1}}|\theta(v)||\ln | z-v| | d v+\int_{|v| \geqslant|z|+1}|\theta(v)||\ln | z-v| | d v
$$

For $|v| \geqslant|z|+1$, we have $1 \leqslant|z-v| \leqslant|z||v|$ and thus

$$
0 \leqslant \ln |z-v| \leqslant \ln |z|+\ln |v|
$$

which enables to handle the corresponding integral. Let us now estimate the remaining term $I=\int_{\sqrt{|z|}| | v|<|z|+1}|\theta(v)||\ln | z-v| | d v$. Applying Cauchy Schwarz gives:

$$
I \leqslant\left(\int_{\sqrt{|z|}<|v|<|z|+1}|\theta(v)|^{2} d v\right)^{1 / 2}\left(\int_{\sqrt{|z|}|<|v|<|z|+1}|\ln | z-\left.v\right|^{2} d v\right)^{1 / 2}
$$

from which we get straightforwardly:

$$
I \leqslant \frac{C \ln |z|}{|z|^{d / 2+\gamma / 2-d / 4}} \underset{|z| \rightarrow \infty}{\rightarrow} 0
$$

We will also use the following lemma:
Lemma 4.2. Let $\lambda$ be a positive number such that $\lambda^{2} \neq 2$ and $\left(X_{i}\right)_{1 \leqslant i \leqslant n}$ an i.i.d. sequence of centered gaussian variables with variance $\lambda^{2} \ln (n)$. For all positive $p$ such that $p<\max \left(\frac{2}{\lambda^{2}}, 1\right)$, there exists $0<x<1$ such that:

$$
\begin{equation*}
E\left[\sup _{1 \leqslant i \leqslant n} e^{p X_{i}-p \frac{\lambda^{2}}{2} \ln (n)}\right]=O\left(n^{x p}\right) \tag{4.2}
\end{equation*}
$$

Proof. By Fubini we get:

$$
\begin{align*}
& E\left[\sup _{1 \leqslant i \leqslant n} e^{p X_{i}-p \frac{\lambda^{2}}{2} \ln (n)}\right] \\
& =\int_{0}^{\infty} P\left(\sup _{1 \leqslant i \leqslant n} e^{p X_{i}-p \frac{\lambda^{2}}{2} \ln (n)}>v\right) d v \\
& =\int_{0}^{\infty} P\left(\sup _{1 \leqslant i \leqslant n} X_{i}>\frac{\ln (v)}{p}+\frac{\lambda^{2}}{2} \ln (n)\right) d v \\
& =\int_{-\infty}^{\infty} p e^{p u} P\left(\sup _{1 \leqslant i \leqslant n} X_{i}>u+\frac{\lambda^{2}}{2} \ln (n)\right) d u \\
& \leqslant 1+\int_{0}^{\infty} p e^{p u} P\left(\sup _{1 \leqslant i \leqslant n} X_{i}>u+\frac{\lambda^{2}}{2} \ln (n)\right) d u \tag{4.3}
\end{align*}
$$

where we performed the change of variable $u=\frac{\ln (v)}{p}$ in the above identities. If we define $\bar{F}(u)=P\left(X_{1}>u\right)$ then we have:

$$
P\left(\sup _{1 \leqslant i \leqslant n} X_{i}>u+\frac{\lambda^{2}}{2} \ln (n)\right)=1-e^{n \ln \left(1-\bar{F}\left(u+\frac{\lambda^{2}}{2} \ln (n)\right)\right)} .
$$

Let $x$ be some positive number such that $0<x<1$. Using (4.3), we get:

$$
\begin{align*}
E\left[\sup _{1 \leqslant i \leqslant n} e^{p X_{i}-p \frac{\lambda^{2}}{2} \ln (n)}\right] & \leqslant n^{x p}+p \int_{x \ln (n)}^{\infty} e^{p u}\left(1-e^{n \ln \left(1-\bar{F}\left(u+\frac{\lambda^{2}}{2} \ln (n)\right)\right.}\right) d u \\
& \leqslant n^{x p}+p n^{x p} \int_{0}^{\infty} e^{p \widetilde{u}}\left(1-e^{n \ln \left(1-\bar{F}\left(\widetilde{u}+\left(\frac{\lambda^{2}}{2}+x\right) \ln (n)\right)\right)}\right) d \widetilde{u} \tag{4.4}
\end{align*}
$$

We have:

$$
\begin{aligned}
\left.\bar{F}\left(\widetilde{u}+\left(\frac{\lambda^{2}}{2}+x\right) \ln (n)\right)\right) & =\frac{1}{\sqrt{2 \pi} \lambda \sqrt{\ln (n)}} \int_{\widetilde{u}+\left(\frac{\lambda^{2}}{2}+x\right) \ln (n)}^{\infty} e^{-\frac{v^{2}}{2 \lambda^{2} \ln (n)}} d v \\
& =\frac{n^{-\frac{\left(\lambda^{2} / 2+x\right)^{2}}{2 \lambda^{2}}}}{\sqrt{2 \pi} \lambda \sqrt{\ln (n)}} \int_{\widetilde{u}}^{\infty} e^{-\left(\frac{1}{2}+\frac{x}{\lambda^{2}}\right) \widetilde{v}-\frac{\tilde{\tau}^{2}}{2 \lambda^{2} \ln (n)}} d \widetilde{v}
\end{aligned}
$$

where we performed the change of variable $\widetilde{v}=v-\left(\frac{\lambda^{2}}{2}+x\right) \ln (n)$. Thus, we get:

$$
\begin{align*}
& n^{x p} \int_{0}^{\infty} e^{p \widetilde{u}}\left(1-e^{n \ln \left(1-\bar{F}\left(\widetilde{u}+\left(\frac{\lambda^{2}}{2}+x\right) \ln (n)\right)\right)}\right) d \widetilde{u} \\
& \leqslant n^{x p+1} \int_{0}^{\infty} e^{p \widetilde{u}} \bar{F}\left(\widetilde{u}+\left(\frac{\lambda^{2}}{2}+x\right) \ln (n)\right) d \widetilde{u} \\
& \leqslant \frac{n^{x p+1-\frac{\left(\lambda^{2} / 2+x\right)^{2}}{2 \lambda^{2}}}}{\sqrt{2 \pi} \lambda \sqrt{\ln (n)}} \int_{0}^{\infty} e^{p \widetilde{u}}\left(\int_{\widetilde{u}}^{\infty} e^{-\left(\frac{1}{2}+\frac{x}{\lambda^{2}}\right) \widetilde{v}-\frac{\tilde{v}^{2}}{2 \lambda^{2} \ln (n)}} d \widetilde{v}\right) d \widetilde{u} \\
& \leqslant \frac{n^{x p+1-\frac{\left(\lambda^{2} / 2+x\right)^{2}}{2 \lambda^{2}}}}{p \sqrt{2 \pi} \lambda \sqrt{\ln (n)}} \int_{0}^{\infty} e^{p \widetilde{v}-\left(\frac{1}{2}+\frac{x}{\lambda^{2}}\right) \widetilde{v}-\frac{\tilde{v}^{2}}{2 \lambda^{2} \ln (n)}} d \widetilde{v} \\
& \leqslant \frac{n^{x p+1-\frac{\left(\lambda^{2} / 2+x\right)^{2}}{2 \lambda^{2}}}}{p \sqrt{2 \pi} \lambda \sqrt{\ln (n)}} \int_{-\infty}^{\infty} e^{p \widetilde{v}-\left(\frac{1}{2}+\frac{x}{\lambda^{2}}\right) \tilde{v}-\frac{\tilde{v}^{2}}{2 \lambda^{2} \ln (n)}} d \widetilde{v} \\
& =\frac{n^{x p+\alpha(x, \lambda, p)}}{p}, \tag{4.5}
\end{align*}
$$

with $\alpha\left(x, \lambda^{2}, p\right)=1-\frac{\left(\lambda^{2} / 2+x\right)^{2}}{2 \lambda^{2}}+\left(p-\frac{1}{2}-\frac{x}{\lambda^{2}}\right)^{2} \frac{\lambda^{2}}{2}$. We have by combining (4.4) and (4.5):

$$
E\left[\sup _{1 \leqslant i \leqslant n} e^{p X_{i}-p \frac{\lambda^{2}}{2} \ln (n)}\right] \leqslant n^{x p}+n^{x p+\alpha(x, \lambda, p)},
$$

We focus on the case $p \in] \frac{1}{2}+\frac{1}{\lambda^{2}}, \max \left(\frac{2}{\lambda^{2}}, 1\right)$ [ (This implies inequality (4.2) for $p \leqslant \frac{1}{2}+$ $\frac{1}{\lambda^{2}}$ by Holders inequality).

First case: $\lambda^{2}<2$.
Note that $\alpha\left(1, \lambda^{2}, \frac{2}{\lambda^{2}}\right)=0$ so if $p<\frac{2}{\lambda^{2}}$ then there exists $0<x<1$ such that $\alpha\left(x, \lambda^{2}, p\right)<0$.

Second case: $\lambda^{2}>2$.
Note that $\alpha\left(1, \lambda^{2}, 1\right)=0$ so if $p<1$ then there exists $0<x<1$ such that $\alpha\left(x, \lambda^{2}, p\right)<0$.
4.2. Proof of theorem 2.1. For sake of simplicity, we give the proof in the case $d=1, R=1$ and the function $f(x)=\lambda^{2} \ln ^{+} \frac{1}{|x|}$. This is no restriction; indeed, the proof in the general case is an immediate adaptation of the following proof.

Uniqueness. Let $\alpha \in] 0,1 / 2[$. We consider $\theta$ and $\tilde{\theta}$ two continuous functions satisfying properties (1), (2) and (3). We note:

$$
m(d t)=e^{X(t)-\frac{1}{2} E\left[X(t)^{2}\right]} d t=\lim _{\epsilon \rightarrow 0} e^{X_{\epsilon}(t)-\frac{1}{2} E\left[X_{\epsilon}(t)^{2}\right]} d t
$$

where $\left(X_{\epsilon}(t)\right)_{t \in \mathbb{R}}$ is a gaussian process of covariance $q_{\epsilon}(|t-s|)$ with:

$$
q_{\epsilon}(x)=\left(\theta^{\epsilon} * f\right)(x)=\lambda^{2} \int_{\mathbb{R}} \theta(v) \ln ^{+}\left(\frac{1}{|x-\epsilon v|}\right) d v
$$

We define similarly the measure $\widetilde{m}, \widetilde{X}_{\epsilon}$ and $\widetilde{q}_{\epsilon}$ associated to the function $\widetilde{\theta}$. Note that we suppose that the random measures $m_{\epsilon}(d t)=e^{X_{\epsilon}(t)-\frac{1}{2} E\left[X_{\epsilon}(t)^{2}\right]} d t$ and $\widetilde{m}_{\epsilon}(d t)=$ $e^{\widetilde{X}_{\epsilon}(t)-\frac{1}{2} E\left[X_{\epsilon}(t)^{2}\right]} d t$ converge in law in the space of Radon measures: this is no restriction since the equality $E\left[m_{\epsilon}(A)\right]=E\left[\widetilde{m}_{\epsilon}(A)\right]=|A|$ for all bounded $A$ in $\mathcal{B}(\mathbb{R})$ implies the measures are tight.

We will show that:

$$
E\left[m[0,1]^{\alpha}\right]=E\left[\widetilde{m}[0,1]^{\alpha}\right]
$$

for $\alpha$ in the interval $] 0,1 / 2\left[\right.$. If we define $Z_{\epsilon}(t)(u)=\sqrt{t} \widetilde{X}_{\epsilon}(u)+\sqrt{1-t} X_{\epsilon}(u)$ with $X_{\epsilon}(u)$ and $\widetilde{X}_{\epsilon}(u)$ independent, we get by using a continuous version of lemma 6.1:

$$
\begin{equation*}
E\left[\widetilde{m}_{\epsilon}[0,1]^{\alpha}\right]-E\left[m_{\epsilon}[0,1]^{\alpha}\right]=\frac{\alpha(\alpha-1)}{2} \int_{0}^{1} \varphi_{\epsilon}(t) d t \tag{4.6}
\end{equation*}
$$

with $\varphi_{\epsilon}(t)$ defined by:

$$
\varphi_{\epsilon}(t)=\int_{[0,1]^{2}}\left(\widetilde{q}_{\epsilon}\left(\left|t_{2}-t_{1}\right|\right)-q_{\epsilon}\left(\left|t_{2}-t_{1}\right|\right) E\left[\mathcal{X}_{\epsilon}\left(t, t_{1}, t_{2}\right)\right] d t_{1} d t_{2},\right.
$$

where $\mathcal{X}_{\epsilon}\left(t, t_{1}, t_{2}\right)$ is given by:

$$
\mathcal{X}_{\epsilon}\left(t, t_{1}, t_{2}\right)=\frac{e^{Z_{\epsilon}(t)\left(t_{1}\right)+Z_{\epsilon}(t)\left(t_{2}\right)-\frac{1}{2} E\left[Z_{\epsilon}(t)\left(t_{1}\right)^{2}\right]-\frac{1}{2} E\left[Z_{\epsilon}(t)\left(t_{2}\right)^{2}\right]}}{\left(\int_{0}^{1} e^{Z_{\epsilon}(t)(u)-\frac{1}{2} E\left[Z_{\epsilon}(t)(u)^{2}\right]} d u\right)^{2-\alpha}} .
$$

We state and prove the following short lemma we will need in the sequel.
Lemma 4.3. For $A>0$, we denote $C_{A}^{\epsilon}=\sup _{|x| \geqslant A \epsilon}\left|q_{\epsilon}(x)-\widetilde{q}_{\epsilon}(x)\right|$. We have:

$$
\lim _{A \rightarrow \infty}\left(\varlimsup_{\epsilon \rightarrow 0} C_{A}^{\epsilon}\right)=0
$$

Proof. Let $|x| \geqslant A \epsilon$. If $|x| \geqslant 1 / 2$ then $q_{\epsilon}(x)$ and $\widetilde{q}_{\epsilon}$ converge uniformly towards $\ln ^{+} \frac{1}{|x|}$ thus $q_{\epsilon}(x)-\widetilde{q}_{\epsilon}$ converges uniformly to 0 . If $|x|<1 / 2$, we write:

$$
q_{\epsilon}(x)=\ln \frac{1}{\epsilon}+Q(x / \epsilon)+R_{\epsilon}(x)
$$

where $Q(x)=\int_{\mathbb{R}} \ln \frac{1}{|x-z|} \theta(z) d z$ and $R_{\epsilon}(x)$ converges uniformly to 0 (for $|x|<1 / 2$ ) as $\epsilon \rightarrow 0$. This follows from straightforward calculations. Applying lemma 4.1, we get that $Q(x)=\ln \frac{1}{|x|}+\Sigma(x)$ with $\Sigma(x) \rightarrow 0$ for $|x| \rightarrow \infty$. Thus $Q(x)-\widetilde{Q}(x)$ is a continuous function such that for $|x| \geqslant A \epsilon$ and $|x| \leqslant 1 / 2$ we have:

$$
\left|q_{\epsilon}(x)-\widetilde{q}_{\epsilon}(x)\right| \leqslant \sup _{|y| \geqslant A}|Q(y)-\widetilde{Q}(y)|+\sup _{|x| \leqslant 1 / 2}\left|R_{\epsilon}(x)-\widetilde{R}_{\epsilon}(x)\right|
$$

The result follows.
One can decompose expression (4.6) in the following way:

$$
\begin{equation*}
E\left[\widetilde{m}_{\epsilon}[0,1]^{\alpha}\right]-E\left[m_{\epsilon}[0,1]^{\alpha}\right]=\frac{\alpha(\alpha-1)}{2} \int_{0}^{1} \varphi_{\epsilon}^{A}(t) d t+\frac{\alpha(\alpha-1)}{2} \int_{0}^{1} \bar{\varphi}_{\epsilon}^{A}(t) d t \tag{4.7}
\end{equation*}
$$

where:

$$
\varphi_{\epsilon}^{A}(t)=\int_{[0,1]^{2},\left|t_{2}-t_{1}\right| \leqslant A \epsilon}\left(\widetilde{q}_{\epsilon}\left(\left|t_{2}-t_{1}\right|\right)-q_{\epsilon}\left(\left|t_{2}-t_{1}\right|\right) E\left[\mathcal{X}_{\epsilon}\left(t, t_{1}, t_{2}\right)\right] d t_{1} d t_{2}\right.
$$

and

$$
\bar{\varphi}_{\epsilon}^{A}(t)=\int_{[0,1]^{2},\left|t_{2}-t_{1}\right|>A \epsilon}\left(\widetilde{q}_{\epsilon}\left(\left|t_{2}-t_{1}\right|\right)-q_{\epsilon}\left(\left|t_{2}-t_{1}\right|\right) E\left[\mathcal{X}_{\epsilon}\left(t, t_{1}, t_{2}\right)\right] d t_{1} d t_{2} .\right.
$$

With the notations of lemma 4.3, we have:

$$
\begin{aligned}
\left|\bar{\varphi}_{\epsilon}^{A}(t)\right| & \leqslant \lambda^{2} C_{A}^{\epsilon} \int_{[0,1]^{2},\left|t_{2}-t_{1}\right|>A \epsilon} E\left[\mathcal{X}_{\epsilon}\left(t, t_{1}, t_{2}\right)\right] d t_{1} d t_{2} \\
& \leqslant \lambda^{2} C_{A}^{\epsilon} \int_{[0,1]^{2}} E\left[\mathcal{X}_{\epsilon}\left(t, t_{1}, t_{2}\right)\right] d t_{1} d t_{2} \\
& =\lambda^{2} C_{A}^{\epsilon} E\left[\left(\int_{0}^{1} e^{Z_{\epsilon}(t)(u)-\frac{1}{2} E\left[Z_{\epsilon}(t)(u)^{2}\right]} d u\right)^{\alpha}\right] \\
& \leqslant \lambda^{2} C_{A}^{\epsilon} .
\end{aligned}
$$

Thus, taking the limit as $\epsilon$ goes to 0 in (4.7) gives:

$$
\varlimsup_{\epsilon \rightarrow 0}\left|E\left[\widetilde{m}_{\epsilon}[0,1]^{\alpha}\right]-E\left[m_{\epsilon}[0,1]^{\alpha}\right]\right| \leqslant \frac{\alpha(1-\alpha)}{2} \lambda^{2} \overline{\lim _{\epsilon \rightarrow 0}} C_{A}^{\epsilon}+\frac{\alpha(1-\alpha)}{2} \overline{\lim }_{\epsilon \rightarrow 0} \int_{0}^{1}\left|\varphi_{\epsilon}^{A}(t)\right| d t
$$

We will show that $\lim _{\epsilon \rightarrow 0} \varphi_{\epsilon}^{A}(0)=0$ (the general case $\varphi_{\epsilon}^{A}(t)$ is similar). There exists a constant $\widetilde{C}_{A}>0$ independent of $\epsilon$ such that:

$$
\sup _{|x| \leqslant A \epsilon}\left|\widetilde{q}_{\epsilon}(x)-q_{\epsilon}(x)\right| \leqslant \widetilde{C}_{A} .
$$

Therefore, we have:

$$
\begin{align*}
\left|\varphi_{\epsilon}^{A}(0)\right| & \leqslant \widetilde{C}_{A} \int_{0}^{1} \int_{t_{1}-A \epsilon}^{t_{1}+A \epsilon} E\left[\mathcal{X}_{\epsilon}\left(0, t_{1}, t_{2}\right)\right] d t_{2} d t_{1} \\
& =\widetilde{C}_{A} E\left[\frac{\int_{0}^{1} \int_{t_{1}-A \epsilon}^{t_{1}+A \epsilon} e^{X_{\epsilon}\left(t_{1}\right)+X_{\epsilon}\left(t_{2}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{1}\right)^{2}\right]-\frac{1}{2} E\left[X_{\epsilon}\left(t_{2}\right)^{2}\right]} d t_{1} d t_{2}}{\left(\int_{0}^{1} e^{X_{\epsilon}(u)-\frac{1}{2} E\left[X_{\epsilon}(u)^{2}\right]} d u\right)^{2-\alpha}}\right] \tag{4.8}
\end{align*}
$$

Now we have:

$$
\begin{aligned}
& \int_{0}^{1} \int_{t_{1}-A \epsilon}^{t_{1}+A \epsilon} e^{X_{\epsilon}\left(t_{1}\right)+X_{\epsilon}\left(t_{2}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{1}\right)^{2}\right]-\frac{1}{2} E\left[X_{\epsilon}\left(t_{2}\right)^{2}\right]} d t_{1} d t_{2} \\
& \leqslant\left(\sup _{t_{1}} \int_{t_{1}-A \epsilon}^{t_{1}+A \epsilon} e^{X_{\epsilon}\left(t_{2}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{2}\right)^{2}\right]} d t_{2}\right) \int_{0}^{1} e^{X_{\epsilon}\left(t_{1}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{1}\right)^{2}\right]} d t_{1} \\
& \leqslant 2\left(\sup _{0 \leqslant i<\frac{1}{2 A \epsilon}} \int_{2 i A \epsilon}^{2(i+1) A \epsilon} e^{X_{\epsilon}\left(t_{2}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{2}\right)^{2}\right]} d t_{2}\right) \int_{0}^{1} e^{X_{\epsilon}\left(t_{1}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{1}\right)^{2}\right]} d t_{1}
\end{aligned}
$$

In view of (4.8), this implies:

$$
\begin{aligned}
\left|\varphi_{\epsilon}^{A}(0)\right| & \leqslant 2 \widetilde{C}_{A} E\left[\left(\sup _{0 \leqslant i<\frac{1}{2 A \epsilon}} \int_{2 i A \epsilon}^{2(i+1) A \epsilon} e^{X_{\epsilon}\left(t_{2}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{2}\right)^{2}\right]} d t_{2}\right)\left(\int_{0}^{1} e^{X_{\epsilon}\left(t_{1}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{1}\right)^{2}\right]} d t_{1}\right)^{\alpha-1}\right] \\
& \leqslant 2 \widetilde{C}_{A} E\left[\left(\sup _{0 \leqslant i<\frac{1}{2 A \epsilon}} \int_{2 i A \epsilon}^{2(i+1) A \epsilon} e^{X_{\epsilon}\left(t_{2}\right)-\frac{1}{2} E\left[X_{\epsilon}\left(t_{2}\right)^{2}\right]} d t_{2}\right)^{\alpha}\right]
\end{aligned}
$$

where we used the inequality $\frac{\sup _{i} a_{i}}{\left(\sum_{i} a_{i}\right)^{1-\alpha}} \leqslant\left(\sup _{i} a_{i}\right)^{\alpha}$. For sake of simplicity, we now replace $2 A$ by $A$.

The idea to study the above supremum is to make the approximation $X_{\epsilon}(t) \approx$ $X_{\epsilon}(A i \epsilon)$ for $t$ in $[A i \epsilon, A(i+1) \epsilon]$. If we define $\mathcal{C}_{\epsilon}$ by:

$$
\begin{equation*}
\mathcal{C}_{\epsilon}=\sup _{\substack{0 \leqslant i<\frac{1}{A \epsilon} \\ A i \epsilon \leqslant u \leqslant A(i+1) \epsilon}}\left(X_{\epsilon}(u)-X_{\epsilon}(A i \epsilon)\right), \tag{4.9}
\end{equation*}
$$

then we have:

$$
\begin{align*}
& E\left[\left(\sup _{0 \leqslant i<\frac{1}{A \epsilon}} \int_{A i \epsilon}^{A(i+1) \epsilon} e^{X_{\epsilon}(t)-\frac{1}{2} E\left[X_{\epsilon}(t)^{2}\right]} d t\right)^{\alpha}\right] \\
& \leqslant E\left[\left(\sup _{0 \leqslant i<\frac{1}{A \epsilon}} \int_{A i \epsilon}^{A(i+1) \epsilon} e^{X_{\epsilon}(A i \epsilon)-\frac{1}{2} E\left[X_{\epsilon}(A i \epsilon)^{2}\right]} d t\right)^{\alpha} e^{\alpha \mathcal{C}_{\epsilon}}\right] \\
& =E\left[\left(\epsilon A \sup _{0 \leqslant i<\frac{1}{A \epsilon}} e^{X_{\epsilon}(A i \epsilon)-\frac{1}{2} E\left[X_{\epsilon}(A i \epsilon)^{2}\right]}\right)^{\alpha} e^{\alpha \mathcal{C}_{\epsilon}}\right] \\
& \leqslant(\epsilon A)^{\alpha} E\left[\left(\sup _{0 \leqslant i<\frac{1}{A \epsilon}} e^{X_{\epsilon}(A i \epsilon)-\frac{1}{2} E\left[X_{\epsilon}(A i \epsilon)^{2}\right]}\right)^{2 \alpha}\right]^{1 / 2} E\left[e^{2 \alpha \mathcal{C}_{\epsilon}}\right]^{1 / 2} \tag{4.10}
\end{align*}
$$

It is straightforward to see that there exists some $c \geqslant 0$ (independent of $\epsilon$ ) such that for all $s, t$ in $[0,1]$ :

$$
E\left[X_{\epsilon}(s) X_{\epsilon}(t)\right] \geqslant-c
$$

We introduce a centered gaussian random variable $Z$ independent of $X_{\epsilon}$ and such that $E\left[Z^{2}\right]=c$. Let $\left(R_{i}^{\epsilon}\right)_{1 \leqslant i<\frac{1}{\epsilon \epsilon}}$ be a sequence of i.i.d gaussian random variables such that $E\left[\left(R_{i}^{\epsilon}\right)^{2}\right]=E\left[X_{\epsilon}(A i \epsilon)^{2}\right]+c$. By applying corollary 6.3, we get:

$$
\begin{aligned}
E\left[\left(\sup _{0 \leqslant i<\frac{1}{A \epsilon}} e^{X_{\epsilon}(A i \epsilon)-\frac{1}{2} E\left[X_{\epsilon}(A i \epsilon)^{2}\right]}\right)^{2 \alpha}\right] & =\frac{1}{e^{2 \alpha^{2} c-\alpha c}} E\left[\left(\sup _{0 \leqslant i<\frac{1}{A \epsilon}} e^{X_{\epsilon}(A i \epsilon)+Z-\frac{1}{2} E\left[X_{\epsilon}(A i \epsilon)^{2}\right]-\frac{c}{2}}\right)^{2 \alpha}\right] \\
& \leqslant \frac{1}{e^{2 \alpha^{2} c-\alpha c} E\left[\left(\sup _{0 \leqslant i<\frac{1}{A \epsilon}} e^{R_{i}^{\epsilon}-\frac{1}{2} E\left[\left(R_{i}^{\epsilon}\right)^{2}\right]}\right)^{2 \alpha}\right]}
\end{aligned}
$$

We have $E\left[\left(R_{i}^{\epsilon}\right)^{2}\right]=\lambda^{2} \ln \frac{1}{\epsilon}+C(\epsilon)$ with $C(\epsilon)$ converging to some constant as $\epsilon$ goes to 0 . Since $2 \alpha<1$, by appling lemma 4.2, there exists $0<x<1$ such that:

$$
E\left[\left(\sup _{0 \leqslant i<\frac{1}{4 \epsilon}} e^{R_{i}^{\epsilon}-\frac{1}{2} E\left[\left(R_{i}^{\epsilon}\right)^{2}\right]}\right)^{2 \alpha}\right] \leqslant C\left(\frac{1}{\epsilon}\right)^{2 \alpha x}
$$

and therefore we have:

$$
\left|\varphi_{\epsilon}^{A}(0)\right| \leqslant C \epsilon^{\gamma} E\left[e^{2 \alpha \mathcal{C}_{\epsilon}}\right]^{1 / 2}
$$

with $\gamma=\alpha(1-x)>0$.
One can write $\mathcal{C}_{\epsilon}=\sup _{\substack{0 \leqslant i<\frac{1}{A \epsilon} \\ 0 \leqslant \leqslant \leqslant 1}} W_{\epsilon}^{i}(v)$ where $W_{\epsilon}^{i}(v)=X_{\epsilon}(A i \epsilon+A \epsilon v)-X_{\epsilon}(A i \epsilon)$. We have:

$$
E\left[W_{\epsilon}^{i}(v) W_{\epsilon}^{i}\left(v^{\prime}\right)\right]=g_{\epsilon}\left(v-v^{\prime}\right)
$$

where $g_{\epsilon}$ is a continuous function bounded by $M$ independently of $\epsilon$. Let $Y$ be a centered Gaussian random variable independent of $W_{\epsilon}^{i}$ such that: $E\left[Y^{2}\right]=M$. Thus, we can write:

$$
E\left[e^{2 \alpha \mathcal{C}_{\epsilon}}\right]=\frac{E\left[e^{2 \alpha \sup _{i, v} W_{\epsilon}^{i}(v)}\right]}{e^{2 \alpha^{2} M^{2}}}
$$

Now let us consider a family $\left(\bar{W}_{\epsilon}^{i}\right)_{1 \leqslant i<\frac{1}{A \epsilon}}$ of centered i.i.d. Gaussian processes of law $\left(W_{\epsilon}^{0}(v)+Y\right)_{0 \leqslant v \leqslant 1}$. Applying corollary 6.3 of the appendix, we get:

$$
E\left[e^{2 \alpha \mathcal{C}_{\epsilon}}\right] \leqslant \frac{E\left[e^{2 \alpha \sup \bar{W}_{\epsilon}^{i}(v)}\right]}{e^{2 \alpha^{2} M^{2}}}
$$

We now estimate $E\left[e^{2 \alpha \sup \bar{W}_{\epsilon}^{i}(v)}\right]$. Let us denote $\mathcal{X}_{i}=\sup _{0 \leqslant v \leqslant 1} \bar{W}_{\epsilon}^{i}$. Applying Corollary 3.2 of (14 to the continuous gaussian process $\left(W_{\epsilon}^{0}(v)+Y\right)_{0 \leqslant v \leqslant 1}$, we get that the random variable has a Gaussian tail:

$$
P\left(\mathcal{X}_{i}>z\right) \leqslant C e^{-\frac{z^{2}}{2 \sigma^{2}}}, \quad \forall z>0
$$

for some $C$ and $\sigma$. The above tail inequality gives the existence of some constant $C>0$ such that:

$$
E\left[e^{2 \alpha \sup _{0 \leqslant i<\frac{1}{A \epsilon}} \mathcal{X}_{i}}\right] \leqslant C e^{C \sqrt{\ln \left(\frac{1}{\epsilon}\right)}} .
$$

Therefore we have $E\left[e^{2 \alpha \mathcal{C}_{\epsilon}}\right] \leqslant C e^{C \sqrt{\ln \left(\frac{1}{\epsilon}\right)}}$ and then:

$$
\left|\varphi_{\epsilon}^{A}(0)\right| \leqslant C \epsilon^{\gamma} e^{C \sqrt{\ln \left(\frac{1}{\epsilon}\right)}}
$$

It follows that $\varlimsup_{\epsilon \rightarrow 0}\left|\varphi_{\epsilon}^{A}(0)\right|=0$ so that for $\alpha<1 / 2$ :

$$
\overline{\lim }_{\epsilon \rightarrow 0}\left|E\left[\widetilde{m}_{\epsilon}[0,1]^{\alpha}\right]-E\left[m_{\epsilon}[0,1]^{\alpha}\right]\right| \leqslant \frac{\alpha(1-\alpha)}{2} \lambda^{2} \overline{\lim _{\epsilon \rightarrow 0}} C_{A}^{\epsilon} .
$$

Since $\varlimsup_{\epsilon \rightarrow 0} C_{A}^{\epsilon} \rightarrow 0$ as $A$ goes to infinity (lemma 4.3), we conclude that:

$$
\varlimsup_{\epsilon \rightarrow 0}\left|E\left[\widetilde{m}_{\epsilon}[0,1]^{\alpha}\right]-E\left[m_{\epsilon}[0,1]^{\alpha}\right]\right|=0
$$

It is straightforward to check that the above proof can be generalized to show that for all positive $\lambda_{1}, \ldots, \lambda_{n}$ and intervals $I_{1}, \ldots, I_{n}$ we have:

$$
E\left[\left(\sum_{k=1}^{n} \lambda_{k} m\left(I_{k}\right)\right)^{\alpha}\right]=E\left[\left(\sum_{k=1}^{n} \lambda_{k} \widetilde{m}\left(I_{k}\right)\right)^{\alpha}\right]
$$

This implies that the random measures $m$ and $\widetilde{m}$ are equal (see [7]).
Existence. Let $f(x)$ be a real positive definite function on $\mathbb{R}^{d}$ (note that this implies that $f$ is symmetric). Let us recall that the centered Gaussian field of correlation $f(x-y)$ is given by:

$$
X(x)=\int_{\mathbb{R}^{d}} \zeta(x, \xi) \sqrt{\hat{f}(\xi)} W(d \xi)
$$

where $\zeta(x, \xi)=\cos (2 \pi x . \xi)-\sin (2 \pi x . \xi)$ and $W(d \xi)$ is the standard white noise on $\mathbb{R}^{d}$. This can also be written:

$$
\begin{equation*}
X(x)=\int_{] 0, \infty\left[\times \mathbb{R}^{d}\right.} \zeta(x, \xi) \sqrt{\hat{f}(\xi)} g(t, \xi) W(d t, d \xi) \tag{4.11}
\end{equation*}
$$

where $W(d t, d \xi)$ is the white noise on $] 0, \infty\left[\times \mathbb{R}^{d}\right.$ and $\int_{0}^{\infty} g(t, \xi)^{2} d t=1$ for all $\xi$. The interest of the expression (4.11) appears in what follows. Let the function $\theta$ be radially symmetric and $\hat{\theta}$ be a decreasing function of $|\xi|$ (for instance take $\theta(x)=$ $\frac{e^{-|x|^{2} / 2}}{(2 \pi)^{d / 2}}$. Let us consider $g(t, \xi)=\sqrt{-\hat{\theta}^{\prime}(t|\xi|)|\xi|}$ so that $\int_{\epsilon}^{\infty} g(t, \xi)^{2} d t=\hat{\theta}(\epsilon|\xi|)$ for $|\xi| \neq 0$. Then if we consider the fields $X_{\epsilon}$ defined by:

$$
\begin{equation*}
X_{\epsilon}(x)=\int_{] \epsilon, \infty\left[\times \mathbb{R}^{d}\right.} \zeta(x, \xi) \sqrt{\hat{f}(\xi)} g(t, \xi) W(d t, d \xi) \tag{4.12}
\end{equation*}
$$

we will find:

$$
\begin{aligned}
E\left[X_{\epsilon}(x) X_{\epsilon}(y)\right] & =\int_{\mathbb{R}^{d}} \cos (2 \pi(x-y) \cdot \xi) \hat{f}(\xi) \hat{\theta}(\epsilon|\xi|) d \xi \\
& =\left(f * \theta^{\epsilon}\right)(x-y)
\end{aligned}
$$

The interest of (4.12) is to make the approximation process appear as a martingale. Indeed, if we define the filtration $\mathcal{F}_{\epsilon}=\sigma\{W(A, x), A \subset] \epsilon, \infty\left[, x \in \mathbb{R}^{d}\right\}$, we have that for all $A \in \mathcal{B}\left(\mathbb{R}^{d}\right),\left(m_{\epsilon}(A)\right)_{\epsilon>0}$ is a positive $\mathcal{F}_{\epsilon}$-martingale of expectation $|A|$ so it converges almost surely to a random variable $m(A)$ such that:

$$
\begin{equation*}
E[m(A)] \leqslant|A| \tag{4.13}
\end{equation*}
$$

This defines a collection $(m(A))_{A \in \mathcal{B}\left(\mathbb{R}^{d}\right)}$ of random variables such that:
(1) for all disjoint and bounded sets $A_{1}, A_{2}$ in $\mathcal{B}\left(\mathbb{R}^{d}\right)$,

$$
m\left(A_{1} \cup A_{2}\right)=m\left(A_{1}\right)+m\left(A_{2}\right) \quad \text { a.s. }
$$

(2) For any bounded sequence $\left(A_{n}\right)_{n} \geqslant 1$ decreasing to $\emptyset$ :

$$
m\left(A_{n}\right) \underset{n \rightarrow \infty}{\longrightarrow} 0 \text { a.s. }
$$

By theorem 6.1. VI. in [] , one can consider a version of the collection $(m(A))_{A \in \mathcal{B}\left(\mathbb{R}^{d}\right)}$ such that $m$ is a random measure. It is straightforward that $m_{\epsilon}$ converges almost surely towards $m$ in the space of Radon measures (equiped with the weak topology).

## 5. Proofs of section 3

### 5.1. Proof of proposition 3.1.

Proof. Since $\zeta_{1}=d$, note that $\lambda^{2}>2 d$ is equivalent to the existence of $\alpha<1$ such that $\zeta_{\alpha}>d$. Let $\alpha$ be fixed and such that $\zeta_{\alpha}>d$. We will show that $m\left[[0,1]^{d}\right]=0$. We partition the cube $[0,1]^{d}$ into $\frac{1}{\epsilon^{d}}$ subcubes $\left(I_{j}\right)_{1 \leqslant j \leqslant \frac{1}{\epsilon^{d}}}$ of size $\epsilon$. One has by subadditivity and homogeneity:

$$
\begin{aligned}
& E\left[\left(\int_{[0,1]^{d}} e^{X_{\epsilon}(x)-\frac{1}{2} E\left[X_{\epsilon}(x)^{2}\right]} d x\right)^{\alpha}\right] \\
& =E\left[\left(\sum_{1 \leqslant j \leqslant \frac{1}{\epsilon^{d}}} \int_{I_{j}} e^{X_{\epsilon}(x)-\frac{1}{2} E\left[X_{\epsilon}(x)^{2}\right]} d x\right)^{\alpha}\right] \\
& \leqslant E\left[\sum_{1 \leqslant j \leqslant \frac{1}{\epsilon^{d}}}\left(\int_{I_{j}} e^{X_{\epsilon}(x)-\frac{1}{2} E\left[X_{\epsilon}(x)^{2}\right]} d x\right)^{\alpha}\right] \\
& =\frac{1}{\epsilon^{d}} E\left[\left(\int_{[0, \epsilon]^{d}} e^{X_{\epsilon}(x)-\frac{1}{2} E\left[X_{\epsilon}(x)^{2}\right]} d x\right)^{\alpha}\right]
\end{aligned}
$$

Let $Y_{\epsilon}$ be a centered gaussian random variable of variance $\lambda^{2} \ln \left(\frac{1}{\epsilon}\right)+\lambda^{2} c$ where $c$ is such that:

$$
\theta^{\epsilon} * \ln ^{+} \frac{1}{|x|} \geqslant \ln \frac{1}{\epsilon}+c
$$

for $|x| \leqslant \epsilon$ and $\epsilon$ small enough. By definition of $c$, we have

$$
\forall t, t^{\prime} \in[0, \epsilon], \quad E\left[X_{\epsilon}(t) X_{\epsilon}\left(t^{\prime}\right)\right] \geqslant E\left[Y_{\epsilon}^{2}\right] .
$$

Using corollary (6.2) in a continuous version, this implies:

$$
\begin{aligned}
& E\left[\left(\int_{[0,1]^{d}} e^{X_{\epsilon}(t)-\frac{1}{2} E\left[X_{\epsilon}(t)^{2}\right]} d t\right)^{\alpha}\right] \\
& \leqslant \frac{1}{\epsilon^{d}} E\left[\left(\int_{[0, \epsilon]^{d}} e^{Y_{\epsilon}-\frac{1}{2} E\left[Y_{\epsilon}^{2}\right]} d t\right)^{\alpha}\right] \\
& =e^{\frac{\alpha^{2}-\alpha}{2} c} \epsilon^{\zeta_{\alpha}-d}
\end{aligned}
$$

Taking the limit as $\epsilon$ goes to 0 gives $m\left[[0,1]^{d}\right]=0$.

### 5.2. Proof of lemma 3.2.

Proof. One has the following general formula for the Fourier transform of radial functions:

$$
\begin{equation*}
\hat{f}(\xi)=\frac{2 \pi}{|\xi|^{\frac{d-2}{2}}} \int_{0}^{\infty} \rho^{\frac{d}{2}} J_{\frac{d-2}{2}}(2 \pi|\xi| \rho) f(\rho) d \rho \tag{5.1}
\end{equation*}
$$

where $J_{\nu}$ is the Bessel function of order $\nu$.

First case: $d \leqslant 3$.
It is enough to consider the case $d=3$ (Indeed, this implies that the same holds for smaller dimensions). Using the explicit formula $J_{\frac{1}{2}}(x)=\sqrt{\frac{2}{\pi x}} \sin (x)$, we conclude by integrating by parts:

$$
\begin{aligned}
\hat{f}(\xi) & =\frac{2}{|\xi|} \int_{0}^{T} \rho \sin (2 \pi|\xi| \rho) \ln \left(\frac{T}{\rho}\right) d \rho \\
& =\frac{1}{\pi|\xi|^{2}} \int_{0}^{T} \cos (2 \pi|\xi| \rho)\left(\ln \left(\frac{T}{\rho}\right)-1\right) d \rho \\
& =\frac{1}{2 \pi^{2}|\xi|^{3}}\left(\int_{0}^{T} \frac{\sin (2 \pi|\xi| \rho)}{\rho} d \rho-\sin (2 \pi|\xi| T)\right) \\
& =\frac{1}{2 \pi^{2}|\xi|^{3}}(\operatorname{sinc}(2 \pi|\xi| T)-\sin (2 \pi|\xi| T))
\end{aligned}
$$

where sinc is the sinus cardinal function:

$$
\operatorname{sinc}(x)=\int_{0}^{x} \frac{\sin (\rho)}{\rho} d \rho
$$

We introduce for $x \geqslant 0$ the function $l(x)=\operatorname{sinc}(x)-\sin (x)$. We have $l^{\prime}(x)=$ $\frac{\sin (x)-x \cos (x)}{x}$. Thus, there exists $\alpha$ in $] \pi, 2 \pi[$ such that $l$ is increasing on $] 0, \alpha[$ and decreasing on $] \alpha, 2 \pi\left[\right.$. Since $l(0)=0$ and $l(2 \pi)=\int_{0}^{2 \pi} \frac{\sin (\rho)}{\rho} d \rho \geqslant 0$, we conclude that for all $x$ in $[0,2 \pi], l(x) \geqslant 0$. A classical computation (Dirichlet integral) gives $\int_{0}^{\infty} \frac{\sin (\rho)}{\rho} d \rho=\frac{\pi}{2}$. Thus, we have by an integration by parts:

$$
\begin{aligned}
\int_{0}^{2 \pi} \frac{\sin (\rho)}{\rho} d \rho & =\frac{\pi}{2}-\int_{2 \pi}^{\infty} \frac{\sin (\rho)}{\rho} d \rho \\
& =\frac{\pi}{2}-\int_{2 \pi}^{\infty} \frac{1-\cos (\rho)}{\rho^{2}} d \rho \\
& \geqslant \frac{\pi}{2}-\frac{1}{2 \pi} \\
& \geqslant 1
\end{aligned}
$$

Therefore, if $x \geqslant 2 \pi$, we have:

$$
\begin{aligned}
l(x) & =\int_{0}^{x} \frac{\sin (\rho)}{\rho} d \rho-\sin (x) \\
& \geqslant \int_{0}^{2 \pi} \frac{\sin (\rho)}{\rho} d \rho-\sin (x) \\
& \geqslant 0
\end{aligned}
$$

Second case: $d \geqslant 4$. Combining (5.1) with the identity $\frac{d}{d x}\left(x^{\nu} J_{\nu}(x)\right)=x^{\nu} J_{\nu-1}(x)$, we get:

$$
\begin{align*}
\hat{f}(\xi) & =\frac{2 \pi}{|\xi|^{\frac{d-2}{2}}} \int_{0}^{T} \rho^{\frac{d}{2}} J_{\frac{d-2}{2}}(2 \pi|\xi| \rho) \ln \left(\frac{T}{\rho}\right) d \rho \\
& =\frac{1}{(2 \pi)^{d / 2}|\xi|^{d}} \int_{0}^{2 \pi|\xi| T} x^{\frac{d}{2}} J_{\frac{d-2}{2}}(x) \ln \left(\frac{2 \pi|\xi| T}{x}\right) d x \\
& =\frac{1}{(2 \pi)^{d / 2}|\xi|^{d}} \int_{0}^{2 \pi|\xi| T} x^{\frac{d}{2}-1} J_{\frac{d}{2}}(x) d x \tag{5.2}
\end{align*}
$$

One has the following asymptotic expansion as $x$ goes to $\infty$ ([1]):

$$
\begin{equation*}
J_{\nu}(x)=\sqrt{\frac{2}{\pi x}} \cos \left(x-\frac{(1+2 \nu) \pi}{4}\right)-\frac{\left(4 \nu^{2}-1\right) \sqrt{2}}{8 \sqrt{\pi} x^{3 / 2}} \sin \left(x-\frac{(1+2 \nu) \pi}{4}\right)+O\left(\frac{1}{x^{5 / 2}}\right) . \tag{5.3}
\end{equation*}
$$

Combining (5.2) with (5.3), we therefore get the following expansion as $|\xi|$ goes to infinity:

$$
\hat{f}(\xi)=\frac{1}{(2 \pi)^{d / 2}|\xi|^{d}}\left(\sqrt{\frac{2}{\pi}}(2 \pi|\xi| T)^{\frac{d-3}{2}} \sin \left(2 \pi|\xi| T-\frac{(1+2 \nu) \pi}{4}\right)+o\left(|\xi|^{\frac{d-3}{2}}\right)\right)
$$

Thus $\varlimsup_{|\xi| \rightarrow \infty}|\xi|^{d} \hat{f}(\xi)=-\underset{|\xi| \rightarrow \infty}{\lim }|\xi|^{d} \hat{f}(\xi)=+\infty$.

### 5.3. Proofs of section 3.3.

Proof of proposition 3.5 and proposition 3.6. Let $\theta$ be some function satisfying the conditions (1), (2), (3) of section 2.2 and $m_{\epsilon}$ be the random measure associated to $\theta^{\epsilon} * f$. We consider $\widetilde{m}_{\epsilon}$ the random measure associated to $\widetilde{f}_{\epsilon}$ where $\widetilde{f}_{\epsilon}$ is the function of example 2.2:

$$
\widetilde{f}_{\epsilon}(x)=\lambda^{2} \int_{C(0) \cap C(x) ; \epsilon<t<\infty} \frac{d y d t}{t^{d+1}}
$$

One can show that there exists $c, C>0$ such that for all $x$ we have:

$$
\widetilde{f}_{\epsilon}(x)-c \leqslant\left(\theta^{\epsilon} * f\right)(x) \leqslant \widetilde{f}_{\epsilon}(x)+C
$$

By using corollary 6.2 of the appendix in a continuous version, we conclude that there exists $c, C>0$ such that for all $\epsilon$ and all bounded $A$ in $\mathcal{B}\left(\mathbb{R}^{d}\right)$ :

$$
c E\left[\widetilde{m}_{\epsilon}(A)^{p}\right] \leqslant E\left[m_{\epsilon}(A)^{p}\right] \leqslant C E\left[\widetilde{m}_{\epsilon}(A)^{p}\right] .
$$

First case: $p$ belongs to $] 0, p_{*}[$.
Proposition 3.5 is therefore established if we can show that:

$$
\sup _{\epsilon>0} E\left[\tilde{m}_{\epsilon}(A)^{p}\right]<\infty
$$

The above bound can be proved by adapting the proof of theorem 3 in [3] .
Second case: $p$ belongs to $]-\infty, 0[$.
Proposition 3.5 is therefore established if we can show that for all $c>0$ :

$$
\sup _{\epsilon>0} E\left[\widetilde{m}_{\epsilon}(B(0, c))^{p}\right]<\infty
$$

The above bound can be proved by adapting the proof of the corresponding result in 16.

Proof of proposition 3.7. For the sake of simplicity, we consider the case $R=1$ and we will consider the case $p \in\left[1, p_{*}[\right.$. We consider $\theta$ a continuous and positive function with compact support $B(0, A)$ satisfying properties (1), (2) and (3) of section 2.2. We note:

$$
m_{\epsilon}(d x)=e^{X_{\epsilon}(x)-\frac{1}{2} E\left[X_{\epsilon}(x)^{2}\right]} d x
$$

where $\left(X_{\epsilon}(x)\right)_{x \in \mathbb{R}^{d}}$ is a gaussian field of covariance $q_{\epsilon}(x-y)$ with:

$$
q_{\epsilon}(x)=\left(\theta^{\epsilon} * f\right)(x)=\int_{\mathbb{R}^{d}} \theta(z)\left(\lambda^{2} \ln ^{+} \frac{1}{|x-\epsilon z|}+g(x-\epsilon z)\right) d z .
$$

Let $c, c^{\prime}$ be two positive numbers in $] 0, \frac{1}{2}\left[\right.$ such that $c<c^{\prime}$. If $\epsilon$ is sufficiently small and $u, v$ belong to $[0,1]^{d}$, we get:

$$
\begin{aligned}
q_{c \epsilon}(c(v-u)) & =\int_{\mathbb{R}^{d}} \theta(z)\left(\lambda^{2} \ln \frac{1}{|c(v-u)-c \epsilon z|}+g(c(v-u)-c \epsilon z)\right) d z \\
& =\lambda^{2} \ln \left(\frac{c^{\prime}}{c}\right)+\int_{\mathbb{R}^{d}} \theta(z)\left(\lambda^{2} \ln \frac{1}{\left|c^{\prime}(v-u)-c^{\prime} \epsilon z\right|}+g(c(v-u)-c \epsilon z)\right) d z \\
& \leqslant \lambda^{2} \ln \left(\frac{c^{\prime}}{c}\right)+q_{c^{\prime} \epsilon}\left(c^{\prime}(v-u)\right)+C_{c, c^{\prime}, \epsilon},
\end{aligned}
$$

where

$$
C_{c, c^{\prime}, \epsilon}=\sup _{\substack{|z| \leqslant A \\|v-u| \leqslant 1}}\left|g(c(v-u)-c \epsilon z)-g\left(c^{\prime}(v-u)-c^{\prime} \epsilon z\right)\right| .
$$

Let $Y_{c, c^{\prime}, \epsilon}$ be some centered gaussian variable with variance $C_{c, c^{\prime}, \epsilon}+\lambda^{2} \ln \left(\frac{c^{\prime}}{c}\right)$. By using corollary 6.2 of the appendix in a continuous version, we conclude that:

$$
\begin{aligned}
E\left[m_{c \epsilon}\left([0, c]^{d}\right)^{p}\right] & =E\left[\left(\int_{[0, c]^{d}} e^{X_{c \epsilon}(x)-\frac{1}{2} E\left[X_{c \epsilon}(x)^{2}\right]} d x\right)^{p}\right] \\
& =c^{d p} E\left[\left(\int_{[0,1]^{e}} e^{X_{c \epsilon}(c u)-\frac{1}{2} E\left[X_{c \epsilon}(c u)^{2}\right]} d u\right)^{p}\right] \\
& \leqslant c^{d p} E\left[\left(\int_{[0,1]]^{d}} e^{X_{c^{\prime} \epsilon}\left(c^{\prime} u\right)+Y_{c, c^{\prime}, \epsilon}, \epsilon^{\frac{1}{2}} E\left[\left(X_{c^{\prime} \epsilon}\left(c^{\prime} u\right)+Y_{c, c^{\prime}, \epsilon}\right)^{2}\right]} d u\right)^{p}\right] \\
& =c^{d p}\left(\frac{c^{\prime}}{c}\right)^{\frac{p(p-1) \lambda^{2}}{2}} e^{\frac{p(p-1) c_{c, c^{\prime}, \epsilon}}{2}} E\left[\left(\int_{[0,1]^{d}} e^{X_{c^{\prime} \epsilon}\left(c^{\prime} u\right)-\frac{1}{2} E\left[X_{c^{\prime} \epsilon}\left(c^{\prime} u\right)^{2}\right]} d u\right)^{p}\right] \\
& =\left(\frac{c}{c^{\prime}}\right)^{d p-\frac{p(p-1) \lambda^{2}}{2}} e^{\frac{p(p-1) c_{c, c^{\prime}, \epsilon}}{2}} E\left[\left(\int_{\left[0, c^{\prime}\right]^{\prime} d} e^{X_{c^{\prime} \epsilon}(x)-\frac{1}{2} E\left[X_{c^{\prime} \epsilon}(x)^{2}\right]} d x\right)\right. \\
& =\left(\frac{c}{c^{\prime}}\right)^{\zeta_{p}} e^{\frac{p(p-1) C_{c, c^{\prime}, \epsilon}}{2}} E\left[m_{c^{\prime} \epsilon}\left(\left[0, c^{\prime}\right]^{d}\right)^{p}\right]
\end{aligned}
$$

Taking the limit $\epsilon \rightarrow 0$ in the above inequality leads to:

$$
\begin{equation*}
\frac{E\left[m\left([0, c]^{d}\right)^{p}\right]}{c^{\zeta_{p}}} \leqslant e^{\frac{p(p-1) c_{c, c^{\prime}}}{2}} \frac{E\left[m\left(\left[0, c^{\prime}\right]^{d}\right)^{p}\right]}{c^{\prime \zeta_{p}}} \tag{5.4}
\end{equation*}
$$

where $C_{c, c^{\prime}}=\sup _{|v-u| \leqslant 1}\left|g(c(v-u))-g\left(c^{\prime}(v-u)\right)\right|$. Similarly, we have:

$$
\begin{equation*}
\frac{E\left[m\left(\left[0, c^{\prime}\right]^{d}\right)^{p}\right]}{c^{\prime \zeta_{p}}} \leqslant e^{\frac{p(p-1) C_{c, c^{\prime}}}{2}} \frac{E\left[m\left([0, c]^{d}\right)^{p}\right]}{c^{\zeta_{p}}} . \tag{5.5}
\end{equation*}
$$

Since $C_{c, c^{\prime}}$ goes to 0 as $c, c^{\prime} \rightarrow 0$, we conclude by inequality (5.4) and (5.5) that $\left(\frac{E\left[m\left(\left[0, c c^{d}\right)^{p}\right]\right.}{c^{G p}}\right)_{c>0}$ is a Cauchy sequence as $c \rightarrow 0$ bounded from below and above by positive constants. Therefore, there exists some $c_{p}>0$ such that:

$$
E\left[m\left([0, c]^{d}\right)^{p}\right] \underset{c \rightarrow 0}{\sim} c_{p} c^{\zeta_{p}}
$$

The same method can be applied to show that $\frac{c_{p}}{e^{\frac{p(p-1), g(0)}{2}}}$ is independent of $g$. This concludes the proof by setting $C_{p}=\frac{c_{p}}{e^{\frac{p(p-1) g(0)}{2}}}$.

Proof of proposition 3.8. We use the scaling relation (3.3) to compute the characteristic function of $m(B(0, c))$ for all $\xi$ in $\mathbb{R}$ :

$$
\begin{aligned}
E\left[e^{i \xi m(B(0, c))}\right] & =E\left[e^{i \xi e^{\Omega c} m(B(0, R))}\right] \\
& =E[\mathcal{F}(\xi m(B(0, R)))]
\end{aligned}
$$

where $\mathcal{F}$ is the characteristic function of $e^{\Omega_{c}}$. It is easy to show that for all $n \in \mathbb{N}$ there exists $C>0$ such that:

$$
|\mathcal{F}(\xi)| \leqslant \frac{C}{|\xi|^{n}}
$$

From this, we conclude by proposition 3.6 that:

$$
E\left[e^{i \xi m(B(0, c))}\right] \leqslant \frac{C}{|\xi|^{n}} E\left[\frac{1}{m(B(0, R))^{n}}\right] \leqslant \frac{C^{\prime}}{|\xi|^{n}}
$$

This implies the existence of a $C^{\infty}$ density.

## 6. Appendix

We give the following classical lemma first derived in (12).
Lemma 6.1. Let $\left(X_{i}\right)_{1 \leqslant i \leqslant n}$ and $\left(Y_{i}\right)_{1 \leqslant i \leqslant n}$ be two independent centered gaussian vectors and $\left(p_{i}\right)_{1 \leqslant i \leqslant n}$ a sequence of positive numbers. If $\phi: \mathbb{R}_{+} \rightarrow \mathbb{R}$ is some smooth function with polynomial growth at infinity, we define:

$$
\varphi(t)=E\left[\phi\left(\sum_{i=1}^{n} p_{i} e^{Z_{i}(t)-\frac{1}{2} E\left[Z_{i}(t)^{2}\right]}\right)\right],
$$

with $Z_{i}(t)=\sqrt{t} X_{i}+\sqrt{1-t} Y_{i}$. Then, we have the following formula for the derivative:

$$
\begin{equation*}
\varphi^{\prime}(t)=\frac{1}{2} \sum_{i=1}^{n} \sum_{j=1}^{n} p_{i} p_{j}\left(E\left[X_{i} X_{j}\right]-E\left[Y_{i} Y_{j}\right]\right) E\left[e^{Z_{i}(t)+Z_{j}(t)-\frac{1}{2} E\left[Z_{i}(t)^{2}\right]-\frac{1}{2} E\left[Z_{j}(t)^{2}\right]} \phi^{\prime \prime}\left(W_{n, t}\right)\right], \tag{6.1}
\end{equation*}
$$

where:

$$
W_{n, t}=\sum_{k=1}^{n} p_{k} e^{Z_{k}(t)-\frac{1}{2} E\left[Z_{k}(t)^{2}\right]}
$$

As a consequence of the above lemma, one can derive the following classical comparaison principle:

Corollary 6.2. Let $\left(p_{i}\right)_{1 \leqslant i \leqslant n}$ be a sequence of positive numbers. Consider $\left(X_{i}\right)_{1 \leqslant i \leqslant n}$ and $\left(Y_{i}\right)_{1 \leqslant i \leqslant n}$ two centered gaussian vectors such that:

$$
\forall i, j \quad E\left[X_{i} X_{j}\right] \leqslant E\left[Y_{i} Y_{j}\right] .
$$

Then, for all convex function $F: \mathbb{R} \rightarrow \mathbb{R}_{+}$, we have:

$$
\begin{equation*}
E\left[F\left(\sum_{i=1}^{n} p_{i} e^{X_{i}-\frac{1}{2} E\left[X_{i}^{2}\right]}\right)\right], \leqslant E\left[F\left(\sum_{i=1}^{n} p_{i} e^{Y_{i}-\frac{1}{2} E\left[Y_{i}^{2}\right]}\right)\right] \tag{6.2}
\end{equation*}
$$

We will also use another corollary:
Corollary 6.3. Let $\left(X_{i}\right)_{1 \leqslant i \leqslant n}$ and $\left(Y_{i}\right)_{1 \leqslant i \leqslant n}$ be two centered gaussian vectors such that:

- $\forall i, \quad E\left[X_{i}^{2}\right]=E\left[Y_{i}^{2}\right]$.
- $\forall i \neq j, \quad E\left[X_{i} X_{j}\right] \leqslant E\left[Y_{i} Y_{j}\right]$.

Then, for all increasing function $F: \mathbb{R} \rightarrow \mathbb{R}_{+}$, we have:

$$
\begin{equation*}
E\left[F\left(\sup _{1 \leqslant i \leqslant n} Y_{i}\right)\right] \leqslant E\left[F\left(\sup _{1 \leqslant i \leqslant n} X_{i}\right)\right] \tag{6.3}
\end{equation*}
$$

Proof. It is enough to show inequality (6.3) for $F=1_{] x,+\infty[ }$ for some $x \in \mathbb{R}$. Let $\beta$ be some positive parameter. Integrating equality (6.1) applied to the convex function $\phi: u \rightarrow e^{-e^{-\beta x} u}$ and the sequences $\left(\beta X_{i}\right),\left(\beta Y_{i}\right), p_{i}=e^{\frac{\beta^{2}}{2} E\left[X_{i}^{2}\right]}$, we get:

$$
E\left[e^{-\sum_{i=1}^{n} e^{\beta\left(X_{i}-x\right)}}\right] \leqslant E\left[e^{-\sum_{i=1}^{n} e^{\beta\left(Y_{i}-x\right)}}\right]
$$

By letting $\beta \rightarrow \infty$, we conclude:

$$
P\left(\sup _{1 \leqslant i \leqslant n} X_{i}<x\right) \leqslant P\left(\sup _{1 \leqslant i \leqslant n} Y_{i}<x\right) .
$$
