# On the stationary Oseen equations in $\mathbb{R}^{3}$

#### Abstract

The stationary Oseen equations are studied in $\mathbb{R}^{3}$ in its general form, that is, with a non-constant divergenceless function on the convective term. We prove existence, uniqueness and regularity results in weighted Sobolev spaces. From this new approach, we also state existence, uniqueness and regularity results for the generalized Oseen model which describes the rotating flows. The proofs are based on Laplace, Stokes and Oseen theories.

## 1 Introduction

We study the linearized Navier-Stokes equations at the steady state, that is, the Oseen equations

$$
\begin{equation*}
-\Delta \boldsymbol{u}+(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}+\nabla \pi=\boldsymbol{f}, \quad \operatorname{div} \boldsymbol{u}=g \quad \text { in } \mathbb{R}^{3} \tag{1.1}
\end{equation*}
$$

Here $\boldsymbol{u}$ and $\pi$ are unknown functions denoting the fluid velocity vector and the pressure function, respectively. The data are the external forces $f$ acting on the fluid, a function $g$ and a divergenceless function $\boldsymbol{a}$.

[^0]The presence of a non-constant function $a$, which is motivated by the rotating flows, does not allow the use of the potential theory. Indeed, we have no fundamental solution at all. Under the assumptions that the datum $f$ belongs to some weighted Sobolev spaces and the datum $\boldsymbol{a}$ belongs to some Lebesgue spaces, we will prove the existence of solution to the Oseen model (1.1). Namely, we state the existence, uniqueness and regularity of solutions when
(case i) $\boldsymbol{a} \in \mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$ with $\operatorname{div} \boldsymbol{a}=0$,
(case ii) $\boldsymbol{a} \in \mathbf{L}_{\text {loc }}^{3}\left(\mathbb{R}^{3}\right)$ with div $\boldsymbol{a}=0$, satisfying

$$
\exists k>0, \exists R_{0}>0: \quad a(x)=k \mathbf{e}_{1}, \quad|\boldsymbol{x}| \geq R_{0}
$$

Note that in the case ii, $\boldsymbol{a} \notin \mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$. Thus it is not included nor in the Oseen equations in the general form (1.1) nor in the simpler form of the Oseen equations

$$
\begin{equation*}
-\Delta \boldsymbol{u}+k \frac{\partial \boldsymbol{u}}{\partial x_{1}}+\nabla \pi=\boldsymbol{f}, \quad \operatorname{div} \boldsymbol{u}=g \quad \text { in } \mathbb{R}^{3} \tag{1.2}
\end{equation*}
$$

We refer that this classical steady Oseen model is studied by several authors [6,7,11,13].

We also study the Oseen model in the form, for a constant $k>0$, as in $[10,14]$

$$
\begin{equation*}
-\Delta \boldsymbol{u}+k \frac{\partial \boldsymbol{u}}{\partial x_{1}}+(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}+\nabla \pi=\boldsymbol{f}, \quad \operatorname{div} \boldsymbol{u}=g \quad \text { in } \mathbb{R}^{3} . \tag{1.3}
\end{equation*}
$$

The model (1.1) could be seen as a particular case $(k=0)$ of the model (1.3), however the additional term $k \frac{\partial u}{\partial x_{1}}$ is not a difficulty but it helps the existence results. We refer to $[10,14]$ and the references therein, where the study of rotating fluids is based on the decomposition of singular kernel in Fourier space and on the Littlewood-Paley theory.

Here we restricted our study to $\mathbb{R}^{3}$ but by identical arguments it can be done to $\mathbb{R}^{n}$ for any $n \in \mathbb{N}, n \geq 2$, provided that $\boldsymbol{a} \in \mathbf{L}^{n}\left(\mathbb{R}^{n}\right)$.

The outline of the work is as follows. Next section we introduce the functional framework in the scope of the weighted Sobolev spaces. We prove that the Oseen problem (1.1) case i has a unique weak solution in a Hilbert space, a unique generalized solution under the $L^{p}$-theory, strong solutions and very weak solutions in Sections 3, 4, 5 and 6, respectively. Section 7 is devoted to the proof of existence results of the weak, generalized and strong solutions for the generalized Oseen problem (1.3). Finally in Section 8, we solve the Oseen problem (1.1) case ii.

## 2 Preliminar results in weighted Sobolev spaces

Let us introduce the weighted Sobolev spaces with the logarithmic factor [3],

W_{\alpha}^{m, p}\left(\mathbb{R}^{3}\right)= & \left\{u \in \mathcal{D}^{\prime}\left(\mathbb{R}^{3}\right) ; \forall \boldsymbol{\lambda} \in \mathbb{N}^{3},\right. \\
& 0 \leq|\boldsymbol{\lambda}| \leq \varkappa, \rho^{\alpha-m+|\boldsymbol{\lambda}|} \ln ^{-1}\left(1+\rho^{2}\right) D^{\boldsymbol{\lambda}} u \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right) ; \\
& \left.\varkappa+1 \leq|\boldsymbol{\lambda}| \leq m, \rho^{\alpha-m+|\boldsymbol{\lambda}|} D^{\boldsymbol{\lambda}} u \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)\right\}
\end{aligned}
$$

for any positive integer $m$, real numbers $p>1, \alpha \in \mathbb{R}$ and

$$
\varkappa= \begin{cases}m-3 / p-\alpha & \text { if } 3 / p+\alpha \in\{1, \cdots, m\} \\ -1 & \text { otherwise }\end{cases}
$$

and for $m=0$, we set

$$
W_{\alpha}^{0, p}\left(\mathbb{R}^{3}\right)=\left\{u \in \mathcal{D}^{\prime}\left(\mathbb{R}^{3}\right) ; \rho^{\alpha} u \in L^{p}\left(\mathbb{R}^{3}\right)\right\} .
$$

Here $\rho=\sqrt{1+|\boldsymbol{x}|^{2}}$ denotes the weight function where $\boldsymbol{x}=\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}$ and $|\cdot|$ is the usual euclidean norm in $\mathbb{R}^{3}$. Throughout this paper, the bold type characters denote vector distributions or vector Sobolev spaces.

These spaces obey the following embedding

$$
\begin{equation*}
W_{\alpha}^{m, p}\left(\mathbb{R}^{3}\right) \hookrightarrow W_{\alpha-1}^{m-1, p}\left(\mathbb{R}^{3}\right) \tag{2.1}
\end{equation*}
$$

if and only if $m>0$ and $3 / p+\alpha \neq 1$. Note that $W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ is a reflexive Banach space endowed with the norm

$$
\|u\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)}= \begin{cases}\left(\left\|\frac{\rho^{-1}}{\ln \left(1+\rho^{2}\right)} u\right\|_{L^{p}\left(\mathbb{R}^{3}\right)}^{p}+\|\nabla u\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}^{p}\right)^{1 / p} & \text { if } p=3 \\ \left(\left\|\rho^{-1} u\right\|_{L^{p}\left(\mathbb{R}^{3}\right)}^{p}+\|\nabla u\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}^{p}\right)^{1 / p} & \text { otherwise. }\end{cases}
$$

For a detailed study of these spaces we refer to [3,15]. However, let us recall some properties that we will need in this paper. It is known that the space $\mathcal{D}\left(\mathbb{R}^{3}\right)$ is dense in $W_{\alpha}^{m, p}\left(\mathbb{R}^{3}\right)$. So that its dual space, denoted by $W_{-\alpha}^{-m, p^{\prime}}\left(\mathbb{R}^{3}\right)$, where $p^{\prime}=p /(p-1)$ is the conjugate exponent of $p$, is a space of distributions. The embedding (2.1) also holds for $m \leq 0$ and $3 / p+\alpha \neq 3$. Remark that $W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ has the following characterization, for all $p>1$,

W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)=\left\{f \in \mathcal{D}^{\prime}\left(\mathbb{R}^{3}\right) ; f=f_{0}+\operatorname{div} \boldsymbol{f}, f_{0} \in E, \boldsymbol{f} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)\right\}
$$

where E is one of the spaces, $W_{1}^{0, p}\left(\mathbb{R}^{3}\right)$ if $p \neq 3 / 2$, or

$$
W_{1,1}^{0, p}\left(\mathbb{R}^{3}\right)=\left\{u \in L^{p}\left(\mathbb{R}^{3}\right) ; \rho \ln \left(1+\rho^{2}\right) u \in L^{p}\left(\mathbb{R}^{3}\right)\right\}, \quad \text { if } p=3 / 2 .
$$

For $p>3 / 2$ we can take $f_{0}=0$ since the Hardy inequality holds

$$
\begin{equation*}
\forall u \in W_{0}^{1, q}\left(\mathbb{R}^{3}\right), \quad\|u\|_{W_{0}^{1, q}\left(\mathbb{R}^{3}\right)} \leq C\|\nabla u\|_{\mathbf{L}^{q}\left(\mathbb{R}^{3}\right)} \quad \text { if } q<3 \tag{2.2}
\end{equation*}
$$

Moreover, for all $p>1, \mathcal{D}\left(\mathbb{R}^{3}\right)$ is also dense in $W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$.
For $1<p<3$, we have the Sobolev embedding $W_{0}^{1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{p *}\left(\mathbb{R}^{3}\right)$, with $\frac{1}{p *}=\frac{1}{p}-\frac{1}{3}$. Consequently, by duality we have, for $p^{\prime}>3 / 2, L^{q}\left(\mathbb{R}^{3}\right) \hookrightarrow$ $W_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right)$, with $\frac{1}{q}=\frac{1}{p^{\prime}}+\frac{1}{3}$.

It is known that $W_{0}^{1,3}\left(\mathbb{R}^{3}\right) \hookrightarrow B M O$, where $B M O$ is the space of locally integrable functions $v$ such that

$$
\sup _{Q} \frac{1}{|Q|} \int_{Q}\left|v(\boldsymbol{x})-v_{Q}\right| d \boldsymbol{x}<\infty
$$

where $Q$ is an arbitrary cube and $v_{Q}=\frac{1}{|Q|} \int_{Q} v(\boldsymbol{x}) d \boldsymbol{x}$ is the average of $v$ on $Q$.
For $p \geq 3$, the space $W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ contains the constants and the weighted Poincaré inequality holds

$$
\begin{equation*}
\exists C=C(p)>0: \quad \forall u \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right), \quad\|u\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right) / \mathbb{R}} \leq C\|\nabla u\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)} \tag{2.3}
\end{equation*}
$$

For $3 / p \notin\{1, \cdots, m\}$, the spaces $W_{0}^{m, p}\left(\mathbb{R}^{3}\right)$ and $W_{1}^{m+1, p}\left(\mathbb{R}^{3}\right)$ contain the polynomial functions $\mathbb{P}_{[m-3 / p]}$ of degree lesser or equal than $[m-3 / p]$, where $[s]$ stands for the integer part of $s \in \mathbb{R}_{0}^{+}$.

Hence further $C$ will denote a generic positive constant that may vary from line to line.

Let us recall the following results about the behaviour at large distances of some functions. We begin by considering the case $1<p<3$ (see [5] or [12, pp. 60]).

Lemma 2.1. Assume $1<p<3$ and $u \in \mathcal{D}^{\prime}\left(\mathbb{R}^{3}\right)$ such that $\nabla u \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$. Then there exists a unique constant $u_{\infty}$ defined by

$$
\begin{equation*}
u_{\infty}=\frac{1}{4 \pi} \lim _{|x| \rightarrow \infty} \int_{S_{2}} u(\sigma|x|) d \sigma \tag{2.4}
\end{equation*}
$$

such that $u-u_{\infty} \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and where $S_{2}$ denotes the unit sphere of $\mathbb{R}^{3}$. Moreover, we have the following properties:

$$
\begin{equation*}
u-u_{\infty} \in L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right) \tag{2.5}
\end{equation*}
$$

with the estimate

$$
\begin{gather*}
\left\|u-u_{\infty}\right\|_{L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)} \leq C\|\nabla u\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)},  \tag{2.6}\\
\lim _{|x| \rightarrow \infty} \int_{S_{2}}\left|u(\sigma|x|)-u_{\infty}\right| d \sigma=\lim _{|x| \rightarrow \infty} \int_{S_{2}}\left|u(\sigma|x|)-u_{\infty}\right|^{p} d \sigma=0 \tag{2.7}
\end{gather*}
$$

and

$$
\begin{equation*}
\int_{S_{2}}\left|u(r \sigma)-u_{\infty}\right|^{p} d \sigma \leq C r^{p-3} \int_{\left\{x \in \mathbb{R}^{3},|x|>r\right\}}|\nabla u|^{p} d \boldsymbol{x} \tag{2.8}
\end{equation*}
$$

with $r>0$.
Definition 2.2. A function $u$ will be said to tend weakly to a constant $u_{\infty}$ at infinity if

$$
\lim _{|x| \rightarrow \infty} \int_{S_{2}}\left|u(\sigma|x|)-u_{\infty}\right| d \sigma=0
$$

Remark 2.3. Lemma 2.1 implies that, if $1<p<3$ and $u \in \mathcal{D}^{\prime}\left(\mathbb{R}^{3}\right)$ such that $\nabla u \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$, then the previous definition is equivalent to

$$
u-u_{\infty} \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)
$$

We now give a result for the case $p>3$ which can be obtained from the Sobolev inequalities.

Lemma 2.4. Let $r$ and $p$ be two reals such that $1<r<\infty$ and $p>3$. Let $u \in L^{r}\left(\mathbb{R}^{3}\right)$ and $\nabla u \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$. Then $u \in \mathcal{C}\left(\mathbb{R}^{3}\right)$ and

$$
\begin{equation*}
\lim _{|x| \rightarrow \infty} u(\boldsymbol{x})=0 \quad \text { pointwise } . \tag{2.9}
\end{equation*}
$$

Defining

$$
\begin{aligned}
& X_{\alpha}^{1, p}\left(\mathbb{R}^{3}\right)=\left\{v \in W_{\alpha}^{1, p}\left(\mathbb{R}^{3}\right) ; \frac{\partial v}{\partial x_{1}} \in W_{\alpha}^{-1, p}\left(\mathbb{R}^{3}\right)\right\} ; \\
& X_{\alpha}^{2, p}\left(\mathbb{R}^{3}\right)=\left\{v \in W_{\alpha}^{2, p}\left(\mathbb{R}^{3}\right) ; \frac{\partial v}{\partial x_{1}} \in W_{\alpha}^{0, p}\left(\mathbb{R}^{3}\right)\right\},
\end{aligned}
$$

where $\alpha$ will be taken equal to 0 or 1 , we recall that $\mathcal{D}\left(\mathbb{R}^{3}\right)$ is dense in $X_{\alpha}^{1, p}\left(\mathbb{R}^{3}\right)$ and $X_{\alpha}^{2, p}\left(\mathbb{R}^{3}\right)$ (see $\left.[6]\right)$. Note that the operator $\partial_{i}: X_{\alpha}^{2, p}\left(\mathbb{R}^{3}\right) \rightarrow X_{\alpha}^{1, p}\left(\mathbb{R}^{3}\right)$ is continuous.

Finally let us state the following auxiliary results.
Proposition 2.5. For $u \in X_{0}^{1, p}\left(\mathbb{R}^{3}\right)$, we have
i) if $1<p<3$, then $u \in L^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$ and the following estimate holds

$$
\begin{equation*}
\|u\|_{L^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)}+\|u\|_{L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)} \leq C\|u\|_{X_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \tag{2.10}
\end{equation*}
$$

ii) if $p=3$, then there exists a unique constant $\lambda$ such that $u+\lambda \in L^{12}\left(\mathbb{R}^{3}\right) \cap$ BMO. In particular, $u+\lambda \in L^{r}\left(\mathbb{R}^{3}\right)$ for any $r \geq 12$, and the following estimate holds

$$
\begin{equation*}
\|u+\lambda\|_{L^{r}\left(\mathbb{R}^{3}\right)} \leq C\|u\|_{X_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \tag{2.11}
\end{equation*}
$$

iii) if $3<p<4$, then there exists a unique constant $\lambda$ such that $u+\lambda \in$ $L^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathcal{C}\left(\mathbb{R}^{3}\right)$ and the following estimate holds

$$
\begin{equation*}
\|u+\lambda\|_{L^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)} \leq C\|u\|_{X_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \tag{2.12}
\end{equation*}
$$

Proof. i) This proof can be found in [4].
ii) For $u \in X_{0}^{1,3}\left(\mathbb{R}^{3}\right)$, we have $-\Delta u+\frac{\partial u}{\partial x_{1}} \in W_{0}^{-1,3}\left(\mathbb{R}^{3}\right)$. From scalar Oseen theory [5, Theorem 4.4], there exists a unique $v \in X_{0}^{1,3}\left(\mathbb{R}^{3}\right) \cap L^{12}\left(\mathbb{R}^{3}\right)$ verifying

$$
\begin{equation*}
\Delta v+\frac{\partial v}{\partial x_{1}}=\Delta u+\frac{\partial u}{\partial x_{1}} \quad \text { in } \mathbb{R}^{3} \tag{2.13}
\end{equation*}
$$

By uniqueness argument, we show that $\nabla u=\nabla v$, that means, there exists a unique constant $\lambda$ such that $u+\lambda=v$. As $v \in B M O$, we obtain $u+\lambda \in$ $L^{12}\left(\mathbb{R}^{3}\right) \cap B M O$, and consequently $u+\lambda \in L^{r}\left(\mathbb{R}^{3}\right)$ for any $r \geq 12$, verifying (2.11).
iii) For $u \in X_{0}^{1, p}\left(\mathbb{R}^{3}\right)$, similarly to the case ii, there exist a unique $v \in$ $X_{0}^{1, p}\left(\mathbb{R}^{3}\right) \cap L^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)$ verifying (2.13) and a unique constant $\lambda$ such that $u+\lambda=v$. Then we get $u+\lambda \in L^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)$ verifying (2.12). Applying Lemma 2.4 we conclude that $u+\lambda \in \mathcal{C}\left(\mathbb{R}^{3}\right)$.

Proposition 2.6. For $u \in X_{0}^{2, p}\left(\mathbb{R}^{3}\right)$, we have
i) if $1<p<3 / 2$, then $u \in L^{2 p /(2-p)}\left(\mathbb{R}^{3}\right) \cap L^{3 p /(3-2 p)}\left(\mathbb{R}^{3}\right)$;
ii) if $3 / 2 \leq p<2$, then there exists a unique constant $\lambda$ such that $u+\lambda \in$ $L^{q}\left(\mathbb{R}^{3}\right)$ for all $q \geq 2 p /(2-p)$;
iii) if $1<p<3$, then $\nabla u \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$;
iv) if $p=3$, then there exists a unique $\lambda \in \mathbb{P}_{1}$, independent on $x_{1}$, such that $\nabla(u+\lambda) \in \mathbf{L}^{12}\left(\mathbb{R}^{3}\right) \cap \mathbf{B M O}$. In particular, $\nabla(u+\lambda) \in \mathbf{L}^{r}\left(\mathbb{R}^{3}\right)$ for any $r \geq 12$;
v) if $3<p<4$, then there exists a unique $\lambda \in \mathbb{P}_{1}$, independent on $x_{1}$, such that $\nabla(u+\lambda) \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$.

Proof. The proof of i)-ii) can be found in [4], while iii)-v) easily follow from Proposition 2.5.

## 3 Weak solutions in $\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$

Let us introduce the spaces

$$
\begin{aligned}
& \mathcal{V}=\left\{\boldsymbol{v} \in \mathcal{D}\left(\mathbb{R}^{3}\right) ; \quad \operatorname{div} \boldsymbol{v}=0 \quad \text { in } \mathbb{R}^{3}\right\} ; \\
& \mathbf{H}_{p}=\left\{\boldsymbol{v} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right) ; \quad \operatorname{div} \boldsymbol{v}=0 \quad \text { in } \mathbb{R}^{3}\right\} ; \\
& \mathbf{V}_{p}=\left\{\boldsymbol{v} \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) ; \quad \operatorname{div} \boldsymbol{v}=0 \quad \text { in } \mathbb{R}^{3}\right\},
\end{aligned}
$$

and we suppose in this section that $\boldsymbol{a} \in \mathbf{H}_{3}$.
Definition 3.1. We say that $\boldsymbol{u} \in \mathbf{V}_{2}$ is a weak solution to the problem (1.1), with $g=0$, if it satisfies

$$
\begin{equation*}
\forall \boldsymbol{v} \in \mathbf{V}_{2}, \quad \int_{\mathbb{R}^{3}} \nabla \boldsymbol{u}: \nabla \boldsymbol{v} d \boldsymbol{x}+\int_{\mathbb{R}^{3}} \nabla \boldsymbol{u}:(\boldsymbol{a} \otimes \boldsymbol{v}) d \boldsymbol{x}=\langle\boldsymbol{f}, \boldsymbol{v}\rangle, \tag{3.1}
\end{equation*}
$$

where $\langle\cdot, \cdot\rangle$ denotes the duality bracket $\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$.
Remark 3.2. The Sobolev embedding theorem yields $W_{0}^{1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{p *}\left(\mathbb{R}^{3}\right)$ if $p<3$. If $\boldsymbol{a} \in \mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$, then for $\boldsymbol{u}, \boldsymbol{v} \in \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$, we have $\boldsymbol{a} \otimes \boldsymbol{v} \in \mathbf{L}^{2}\left(\mathbb{R}^{3}\right)$ and the second integral in (3.1) is meanful. Moreover, thanks to the density of $\mathcal{V}$ in $\mathbf{V}_{2}$ (see [1]), we have the property

$$
\begin{equation*}
\forall \boldsymbol{v} \in \mathbf{V}_{2}, \quad \int_{\mathbb{R}^{3}} \nabla \boldsymbol{v}:(\boldsymbol{a} \otimes \boldsymbol{v}) d \boldsymbol{x}=0 \tag{3.2}
\end{equation*}
$$

Theorem 3.3. Given $f \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right), a \in \mathbf{H}_{3}$ and $g=0$, there exists a unique weak solution $\boldsymbol{u} \in \mathbf{V}_{2}$ of the problem (3.1) and moreover $\boldsymbol{u}$ satisfies the estimate

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} \tag{3.3}
\end{equation*}
$$

and the energy equality

$$
\int_{\mathbb{R}^{3}}|\nabla \boldsymbol{u}|^{2} d \boldsymbol{x}=\langle\boldsymbol{f}, \boldsymbol{u}\rangle_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)} .
$$

Besides, there exists a unique function $\pi \in L^{2}\left(\mathbb{R}^{3}\right)$ such that $(\boldsymbol{u}, \pi)$ solves the problem (1.1) in the sense of distributions, and the following estimate holds

$$
\begin{equation*}
\|\pi\|_{L^{2}\left(\mathbb{R}^{3}\right)} \leq C\left(1+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\right)\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} . \tag{3.4}
\end{equation*}
$$

Proof. Let $\left\{R_{m}\right\}_{m \in \mathbb{N}}$ be an increasing sequence of positive reals such that $\lim _{m \rightarrow \infty} R_{m}=\infty$ and the sequence of approximate problems defined in the open balls centered at the origin $B_{m}=B_{R_{m}}(0) \subset \mathbb{R}^{3}$ :

Find $\boldsymbol{u}_{m} \in \mathbf{J}_{m}$ such that, for all $\boldsymbol{v} \in \mathbf{J}_{m}$,

$$
\begin{equation*}
\int_{B_{m}} \nabla \boldsymbol{u}_{m}: \nabla \boldsymbol{v} d \boldsymbol{x}+\int_{B_{m}} \nabla \boldsymbol{u}_{m}:(\boldsymbol{a} \otimes \boldsymbol{v}) d \boldsymbol{x}=\langle\boldsymbol{f}, \boldsymbol{v}\rangle_{\mathbf{H}^{-1}\left(B_{m}\right) \times \mathbf{H}_{0}^{1}\left(B_{m}\right)}, \tag{3.5}
\end{equation*}
$$

where

$$
\mathbf{J}_{m}=\left\{\boldsymbol{v} \in \mathbf{H}_{0}^{1}\left(B_{m}\right) ; \operatorname{div} \boldsymbol{v}=0 \text { in } B_{m}\right\} .
$$

Note that if $\boldsymbol{f} \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)$, then its restriction to $B_{m}$ belongs to $\mathbf{H}^{-1}\left(B_{m}\right)$ and it verifies

$$
\begin{equation*}
\|\boldsymbol{f}\|_{\mathbf{H}^{-1}\left(B_{m}\right)} \leq\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} . \tag{3.6}
\end{equation*}
$$

The existence of a unique solution, $\boldsymbol{u}_{m} \in \mathbf{J}_{m}$, of (3.5) is a consequence of the Lax-Milgram Lemma and the property

$$
\forall \boldsymbol{v} \in \mathbf{J}_{m}, \quad \int_{B_{m}} \nabla \boldsymbol{v}:(\boldsymbol{a} \otimes \boldsymbol{v}) d \boldsymbol{x}=0 .
$$

Let us take $\boldsymbol{v}=\boldsymbol{u}_{m}$ as a test function in (3.5). Thus the energy equality holds

$$
\int_{B_{m}}\left|\nabla \boldsymbol{u}_{m}\right|^{2} d \boldsymbol{x}=\left\langle\boldsymbol{f}, \boldsymbol{u}_{m}\right\rangle=-\int_{B_{m}} \mathbf{F} \cdot \nabla \boldsymbol{u}_{m} d \boldsymbol{x}
$$

observing that $f=\operatorname{div} \mathbf{F}$ with

$$
\mathbf{F} \in \mathbf{L}^{2}\left(\mathbb{R}^{3}\right): \quad\|\mathbf{F}\|_{\mathbf{L}^{2}\left(\mathbb{R}^{3}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}
$$

Consequently the estimate holds

$$
\left\|\nabla \boldsymbol{u}_{m}\right\|_{\mathbf{L}^{2}\left(B_{m}\right)}^{2} \leq\|\mathbf{F}\|_{\mathbf{L}^{2}\left(B_{m}\right)}\left\|\nabla \boldsymbol{u}_{m}\right\|_{\mathbf{L}^{2}\left(B_{m}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}\left\|\nabla \boldsymbol{u}_{m}\right\|_{\mathbf{L}^{2}\left(B_{m}\right)} .
$$

Denoting by $\tilde{\boldsymbol{u}}_{m}$, the extended function by zero in $\mathbb{R}^{n} \backslash B_{m}$, we have $\tilde{\boldsymbol{u}}_{m} \in$ $\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$ and

$$
\begin{equation*}
\left\|\nabla \tilde{\boldsymbol{u}}_{m}\right\|_{\mathbf{L}^{2}\left(\mathbb{R}^{3}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{W}^{-1,2}\left(\mathbb{R}^{3}\right)} . \tag{3.7}
\end{equation*}
$$

From the estimates (3.7) and (2.2) then, extracting subsequences if necessary, we get $\tilde{\boldsymbol{u}}_{m} \rightharpoonup \boldsymbol{u}$ in $\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$ and

$$
\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)} \leq C\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} .
$$

In order to prove that $\boldsymbol{u}$ is a weak solution to (3.1), let $\boldsymbol{v} \in \mathcal{D}\left(\mathbb{R}^{3}\right)$ such that $\operatorname{div} \boldsymbol{v}=0$. Choosing $n \in \mathbb{N}$ such that $\operatorname{supp} \boldsymbol{v} \subset B_{n}$, then for any $m \geq n$ it follows

$$
\begin{equation*}
\forall \boldsymbol{v} \in \mathcal{V}, \quad \int_{\mathbb{R}^{3}} \nabla \tilde{\boldsymbol{u}}_{m}: \nabla \boldsymbol{v} d \boldsymbol{x}+\int_{\mathbb{R}^{3}} \nabla \tilde{\boldsymbol{u}}_{m}:(\boldsymbol{a} \otimes \boldsymbol{v}) d \boldsymbol{x}=\langle\boldsymbol{f}, \boldsymbol{v}\rangle . \tag{3.8}
\end{equation*}
$$

So we can pass to the limit in (3.8) and therefore $\boldsymbol{u}$ satisfies (3.1), for any $\boldsymbol{v} \in \mathcal{V}$. Thanks to the density of $\mathcal{V}$ in $\mathbf{V}_{2}$ (cf. [1]), it is clear that (3.1) holds for any $\boldsymbol{v} \in \mathbf{V}_{2}$. Hence, the estimate (3.3) arises.

The solution $u$ is unique using the standard argument of taking two solutions $\boldsymbol{u}_{1}$ and $\boldsymbol{u}_{2}$ to the linear weak formulation (3.1). Indeed defining $\boldsymbol{w}=\boldsymbol{u}_{1}-\boldsymbol{u}_{2}$, by (3.2) it verifies

$$
\int_{\mathbb{R}^{3}}|\nabla \boldsymbol{w}|^{2} d \boldsymbol{x}=0
$$

then $\boldsymbol{w}=\mathbf{0}$ and $\boldsymbol{u}_{1}=\boldsymbol{u}_{2}$.
Since $\boldsymbol{a} \otimes \boldsymbol{u} \in \mathbf{L}^{2}\left(\mathbb{R}^{3}\right)$, so that $\boldsymbol{f}+\Delta \boldsymbol{u}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}) \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)$. Hence, we have

$$
\forall \boldsymbol{v} \in V_{2}, \quad\langle\boldsymbol{f}+\Delta \boldsymbol{u}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}), \boldsymbol{v}\rangle=0 .
$$

Therefore, De Rham Theorem in weighted spaces (cf. [1]) guarantees the existence of a unique pressure $\pi \in L^{2}\left(\mathbb{R}^{3}\right)$ such that $(\boldsymbol{u}, \pi)$ satisfies the Oseen problem (1.1) in the sense of distributions. Moreover, we get

$$
\|\nabla \pi\|_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} \leq\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+C\left(\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a} \otimes \boldsymbol{u}\|_{\mathbf{L}^{2}\left(\mathbb{R}^{3}\right)}\right) .
$$

Using the estimate (3.3), it follows

$$
\|\nabla \pi\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} \leq C\left(\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a} \otimes \boldsymbol{u}\|_{\mathbf{L}^{2}\left(\mathbb{R}^{3}\right)}\right)
$$

Applying Hölder inequality, Sobolev embedding and using again the estimate (3.3) we obtain

$$
\|\nabla \pi\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} \leq C\left(1+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\right)\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)} .
$$

Finally, using the fact that the operator gradient is an isomorphism from $L^{2}\left(\mathbb{R}^{3}\right)$ to $\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \perp \mathbf{V}_{2}$ (see [1]) we conclude (3.4). The previous notation means the subspace of $\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)$ orthogonal to $\mathbf{V}_{2}$, i.e.,

$$
\begin{aligned}
\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \perp \mathbf{V}_{2} & =\left\{\boldsymbol{f} \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) ; \forall \boldsymbol{v} \in \mathbf{V}_{2},\langle\boldsymbol{f}, \boldsymbol{v}\rangle=0\right\} \\
& =\left(\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) / \mathbf{V}_{2}\right)^{\prime}
\end{aligned}
$$

Theorem 3.4. Given $\boldsymbol{f} \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right), \boldsymbol{a} \in \mathbf{H}_{3}$ and $g \in L^{2}\left(\mathbb{R}^{3}\right)$, there exists a unique solution $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ of the problem (1.1) such that

$$
\begin{align*}
\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)} \leq C\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+\right. & \left.\|g\|_{L^{2}\left(\mathbb{R}^{3}\right)}\left(1+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\right)\right):=M  \tag{3.9}\\
& \|\pi\|_{L^{2}\left(\mathbb{R}^{3}\right)} \leq M\left(1+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\right), \tag{3.10}
\end{align*}
$$

and satisfying the energy equality

$$
\begin{equation*}
\int_{\mathbb{R}^{3}}|\nabla \boldsymbol{u}|^{2} d \boldsymbol{x}=\langle\boldsymbol{f}, \boldsymbol{u}\rangle_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)}+\int_{\mathbb{R}^{3}} \pi g d \boldsymbol{x} . \tag{3.11}
\end{equation*}
$$

Proof. Given $g \in L^{2}\left(\mathbb{R}^{3}\right)$, since the operator div is an isomorphism from $\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right) / \mathbf{V}_{2}$ to $L^{2}\left(\mathbb{R}^{3}\right)$ (see [1, Proposition 2.2]) there exists $\boldsymbol{w} \in \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$ such that $\operatorname{div} \boldsymbol{w}=g$ with the estimate

$$
\|\boldsymbol{w}\|_{\mathbf{w}_{0}^{1,2}\left(\mathbb{R}^{3}\right)} \leq C\|g\|_{L^{2}\left(\mathbb{R}^{3}\right)} .
$$

Since $\boldsymbol{f}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{w}) \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)$, then we can solve the Oseen problem:

$$
-\Delta \boldsymbol{v}+(\boldsymbol{a} \cdot \nabla) \boldsymbol{v}+\nabla \pi=\boldsymbol{f}+\Delta \boldsymbol{w}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{w}) \quad \text { and } \quad \operatorname{div} \boldsymbol{v}=0 \quad \text { in } \mathbb{R}^{3} .
$$

Indeed, the existence and uniqueness of $\boldsymbol{v} \in \mathbf{V}_{2}$ and $\pi \in L^{2}\left(\mathbb{R}^{3}\right)$ follow from Theorem 3.3. Moreover, we have

$$
\begin{gathered}
\|\boldsymbol{v}\|_{\mathbf{w}_{0}^{1,2}\left(\mathbb{R}^{3}\right)} \leq C\left(\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+\|\Delta \boldsymbol{w}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\|\boldsymbol{w}\|_{\mathbf{L}^{6}\left(\mathbb{R}^{3}\right)}\right) \\
\|\pi\|_{L^{2}\left(\mathbb{R}^{3}\right)} \leq C\left(\|\boldsymbol{f}+\Delta \boldsymbol{w}\|_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a} \otimes \boldsymbol{w}\|_{\mathbf{L}^{2}\left(\mathbb{R}^{3}\right)}\right)\left(1+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\right) .
\end{gathered}
$$

Choosing $\boldsymbol{u}=\boldsymbol{v}+\boldsymbol{w} \in \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$ then $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ is the required solution and it satisfies (3.9) and (3.10).

## 4 Generalized solutions in $\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$

Let us state the following generalized result using the known Stokes theory in $\mathbb{R}^{3}$.

Lemma 4.1. For $1<p<\infty$, let $f \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ satisfy the compatibility condition: for any $i=1,2,3$

$$
\begin{equation*}
\left\langle f_{i}, 1\right\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}=0 \quad \text { if } p \leq 3 / 2, \tag{4.1}
\end{equation*}
$$

$g \in L^{2}\left(\mathbb{R}^{3}\right) \cap L^{p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$. If additionally $\boldsymbol{a} \in \mathbf{L}^{6 p /(6-p)}\left(\mathbb{R}^{3}\right)$ for $1<$ $p<6$ or $\boldsymbol{a} \in \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$ for $p \geq 6$, then the solution $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ given by Theorem 3.4 is such that $\boldsymbol{u} \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\pi \in L^{p}\left(\mathbb{R}^{3}\right)$.

Proof. Considering that $\boldsymbol{f} \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right), g \in L^{2}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$, Theorem 3.4 yields the existence and uniqueness of $(\boldsymbol{u}, \pi)$ in the space $\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ verifying

$$
\begin{equation*}
-\Delta \boldsymbol{u}+\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u})+\nabla \pi=\boldsymbol{f} \quad \text { and } \quad \operatorname{div} \boldsymbol{u}=g \quad \text { in } \mathbb{R}^{3}, \tag{4.2}
\end{equation*}
$$

taking into account that div $\boldsymbol{a}=0$. From the Sobolev embedding (cf. Remark 3.2), note that $\boldsymbol{u} \in \mathbf{L}^{6}\left(\mathbb{R}^{3}\right)$.

Case 1: $1<p<6$. We have $\boldsymbol{a} \otimes \boldsymbol{u} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ considering that $\boldsymbol{a} \in \mathbf{L}^{6 p /(6-p)}\left(\mathbb{R}^{3}\right)$. Then $\boldsymbol{f}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}) \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$. Moreover, we have, for all $i=1,2,3$,

$$
\left\langle f_{i}-\operatorname{div}\left(\boldsymbol{a} u_{i}\right), 1\right\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}=0, \quad \text { if } p \leq 3 / 2 .
$$

Thus the Stokes theory [1, Proposition 3.3] guarantees the existence of a solution $(\boldsymbol{v}, \eta) \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$, where $\eta$ is unique and $\boldsymbol{v}$ is unique, up to a constant of $\mathbb{R}^{3}$ if $p \geq 3$, of the Stokes problem

$$
\begin{equation*}
-\Delta \boldsymbol{v}+\nabla \eta=\boldsymbol{f}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}), \quad \operatorname{div} \boldsymbol{v}=g \quad \text { in } \mathbb{R}^{3} \tag{4.3}
\end{equation*}
$$

Thus the uniqueness argument implies first that the harmonic function $\eta-\pi$ belonging to $\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)+\mathbf{L}^{2}\left(\mathbb{R}^{3}\right)$ is necessarily equal to zero and with similar argument, we obtain also $\nabla \boldsymbol{u}=\nabla \boldsymbol{v} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{2}\left(\mathbb{R}^{3}\right)$. Note that $\boldsymbol{u}=\boldsymbol{v}$ if $p<3$ and $\boldsymbol{u}=\boldsymbol{v}+\mathbf{k} \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ with $\mathbf{k} \in \mathbb{R}^{3}$, if $p \geq 3$.

Case 2: $p \geq 6$. We have, for all $2 \leq q \leq 6, \boldsymbol{f} \in \mathbf{W}_{0}^{-1, q}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \otimes \boldsymbol{u} \in$ $\mathbf{L}^{2}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{6}\left(\mathbb{R}^{3}\right)$. Then we can apply case 1 to obtain $\boldsymbol{u} \in \mathbf{W}_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ for all $2 \leq q<6$. In particular, we get $\boldsymbol{u} \in \mathbf{L}^{6}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$. Then $\boldsymbol{a} \otimes \boldsymbol{u} \in$ $\mathbf{L}^{2}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ and arguing as in the case 1 we conclude the proof of Lemma 4.1.

Lemma 4.2. Let $1<p<\infty$ and $\boldsymbol{a} \in \mathbf{H}_{p}$. Then, there exist $\boldsymbol{\psi} \in \mathbf{V}_{p}$ such that

$$
\begin{equation*}
a=\nabla \times \boldsymbol{\psi} \tag{4.4}
\end{equation*}
$$

and a sequence $\left\{\boldsymbol{a}_{m}\right\}_{m \in \mathbb{N}} \subset \mathcal{V}$ such that

$$
\begin{equation*}
\boldsymbol{a}_{m} \rightarrow \boldsymbol{a} \quad \text { in } \mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \tag{4.5}
\end{equation*}
$$

Proof. For $\boldsymbol{a} \in \mathbf{H}_{p}$, we get $\nabla \times \boldsymbol{a} \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \perp \mathbb{P}_{\left[1-3 / p^{\prime}\right]}$. From Laplace theory (see [3]), there exists $\boldsymbol{\psi} \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ such that $-\Delta \boldsymbol{\psi}=\nabla \times \boldsymbol{a}$ in $\mathbb{R}^{3}$ with

$$
\|\nabla \boldsymbol{\psi}\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)} \leq C\|\boldsymbol{a}\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)} .
$$

Then, we have $\operatorname{div} \boldsymbol{\psi} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ such that $\Delta(\operatorname{div} \boldsymbol{\psi})=0$ in $\mathbb{R}^{3}$. Thus it results that $\operatorname{div} \boldsymbol{\psi}=0$ and consequently $\boldsymbol{\psi} \in \mathbf{V}_{p}$. Since div $\boldsymbol{a}=0$, we deduce that

$$
\Delta(\nabla \times \psi)=-\nabla \times(\nabla \times a)=\Delta a
$$

Taking $\boldsymbol{w}=\nabla \times \boldsymbol{\psi}-\boldsymbol{a} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ we obtain $\Delta \boldsymbol{w}=0$ and we conclude $\boldsymbol{w}=\mathbf{0}$ and (4.4) holds.

Since $\mathcal{D}\left(\mathbb{R}^{3}\right)$ is dense in $W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$, we have

$$
\boldsymbol{\psi}=\lim _{m \rightarrow+\infty} \boldsymbol{\psi}_{m} \quad \text { in } \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right), \quad \psi_{m} \in \mathcal{D}\left(\mathbb{R}^{3}\right)
$$

Taking $\boldsymbol{a}_{m}=\nabla \times \boldsymbol{\psi}_{m} \in \mathcal{V}$, we obtain clearly (4.5).

The following results deal with the existence to the problem (1.1) under the data into Banach spaces with $p$-exponent.

Theorem 4.3. For $1<p<3$, let $\boldsymbol{f} \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ satisfy (4.1), $g \in L^{p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$. If there exists a positive constant $K$, only dependent on $p$, such that

$$
\begin{equation*}
\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}<K \tag{4.6}
\end{equation*}
$$

then the Oseen problem (1.1) has a unique solution $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ such that

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{w}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}+\|\pi\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq C_{K}\left(\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right) . \tag{4.7}
\end{equation*}
$$

Proof. By (4.1) and [3], we have $\boldsymbol{f}=\operatorname{div} \mathbf{F}$ with $\mathbf{F} \in L^{p}\left(\mathbb{R}^{3}\right)^{3 \times 3}$. Then, there exist sequences $\left\{\mathbf{F}_{m}\right\} \subset \mathcal{D}\left(\mathbb{R}^{3}\right)^{3 \times 3}$ and $\left\{g_{m}\right\} \subset \mathcal{D}\left(\mathbb{R}^{3}\right)$ such that

$$
\boldsymbol{f}_{m}=\operatorname{div} \mathbf{F}_{m} \rightarrow \boldsymbol{f} \text { in } \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \quad \text { and } \quad g_{m} \rightarrow g \text { in } L^{p}\left(\mathbb{R}^{3}\right),
$$

with $\boldsymbol{f}_{m}$ satisfying the condition (4.1). From Lemma 4.2, we can take a sequence $\left\{\boldsymbol{a}_{m}\right\} \subset \mathcal{V}$ convergent to $\boldsymbol{a}$ in $\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$. Thanks to Lemma 4.1, there exists a unique solution

$$
\boldsymbol{u}_{m} \in \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right), \quad \pi_{m} \in L^{2}\left(\mathbb{R}^{3}\right) \cap L^{p}\left(\mathbb{R}^{3}\right)
$$

satisfying

$$
\begin{equation*}
-\Delta \boldsymbol{u}_{m}+\nabla \pi_{m}=\mathbf{f}_{m}-\operatorname{div}\left(\boldsymbol{a}_{m} \otimes \boldsymbol{u}_{m}\right), \quad \operatorname{div} \boldsymbol{u}_{m}=g_{m} \text { in } \mathbb{R}^{3} . \tag{4.8}
\end{equation*}
$$

From the Stokes theory [1, Theorem 3.3] and applying Hölder and Sobolev inequalities, we obtain

$$
\begin{aligned}
& \left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}+\left\|\pi_{m}\right\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq \\
& \leq c\left(\left\|\boldsymbol{f}_{m}\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\left\|\boldsymbol{a}_{m} \otimes \boldsymbol{u}_{m}\right\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}+\left\|g_{m}\right\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right) \\
& \leq c_{1}\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{L}^{p *}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right) \\
& \leq c_{1}\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+c_{2}\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right),
\end{aligned}
$$

where $c_{1}, c_{2}>0$ are the Stokes and Sobolev constants, respectively. By the assumption (4.6), it follows

$$
\begin{aligned}
\left(1-c_{1} c_{2} K\right)\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)} & \leq c_{1}\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right) ; \\
\left\|\pi_{m}\right\|_{L^{p}\left(\mathbb{R}^{3}\right)} & \leq c_{1}\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right) .
\end{aligned}
$$

Taking $0<K<1 /\left(c_{1} c_{2}\right)$, we can extract subsequences of $\boldsymbol{u}_{m}$ and $\pi_{m}$, still denoted by $\boldsymbol{u}_{m}$ and $\pi_{m}$, such that

$$
\boldsymbol{u}_{m} \rightharpoonup \boldsymbol{u} \text { in } \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \quad \text { and } \quad \pi_{m} \rightharpoonup \pi \text { in } L^{p}\left(\mathbb{R}^{3}\right)
$$

where $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ verifies (1.1) and the estimate (4.7) holds. So the proof of Theorem 4.3 is finished.

Remark 4.4. For all $p<3$ and $\boldsymbol{u} \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$, as $\boldsymbol{a} \in \mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$ then we have $\boldsymbol{a} \otimes \boldsymbol{u} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ and $\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}) \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$.

Finally the following existence result can be stated via a dual argument.
Theorem 4.5. For $p \geq 3$, let $\boldsymbol{f} \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$, $g \in L^{p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfy (4.6). Then the Oseen problem (1.1) has a solution $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$, where $\boldsymbol{u}$ is unique up to a constant vector, such that

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-3 / p]}}+\|\pi\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq C_{K}\left(\|f\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right) . \tag{4.9}
\end{equation*}
$$

Proof. We will follow the duality argument already used in [2]. On one hand, Green formula yields, for all $\boldsymbol{v} \in \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)$ and $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$

$$
\begin{array}{r}
\langle-\Delta \boldsymbol{u}+(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}+\nabla \pi, \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}= \\
\langle\boldsymbol{u},-\Delta \boldsymbol{v}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v})\rangle_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{-1, p^{\prime}\left(\mathbb{R}^{3}\right)}}-\langle\pi, \operatorname{div} \boldsymbol{v}\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)},
\end{array}
$$

taking into account that $\boldsymbol{a} \in \mathbf{H}_{3}$ and $\boldsymbol{v} \in \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{L}^{3 p /(2 p-3)}\left(\mathbb{R}^{3}\right)$ imply that $\boldsymbol{a} \otimes \boldsymbol{v} \in \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)$ and consequently $\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v}) \in \mathbf{W}_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right)$.

On the other hand, for all $\eta \in L^{p^{\prime}}(\Omega)$,

$$
\langle\boldsymbol{u}, \nabla \eta\rangle_{\mathbf{w}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right)}=-\langle\operatorname{div} \boldsymbol{u}, \eta\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)} .
$$

Then the Oseen problem (1.1) has the following equivalent variational formulation:

Find $(\boldsymbol{u}, \pi) \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ such that for all $\boldsymbol{v} \in \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right), \eta \in L^{p^{\prime}}\left(\mathbb{R}^{3}\right)$,

$$
\begin{align*}
&\langle\boldsymbol{u},-\Delta \boldsymbol{v}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v})+\nabla \eta\rangle_{\mathbf{w}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle\pi, \operatorname{div} \boldsymbol{v}\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
&=\langle\boldsymbol{f}, \boldsymbol{v}\rangle_{\mathbf{w}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle g, \eta\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)} . \tag{4.10}
\end{align*}
$$

According to Theorem 4.3 applied with $p^{\prime} \leq 3 / 2$, for each $\left(\boldsymbol{f}^{\prime}, g^{\prime}\right) \in \mathbf{W}_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right) \times$
$L^{p^{\prime}}\left(\mathbb{R}^{3}\right)$ satisfying

$$
\left\langle f_{i}^{\prime}, 1\right\rangle_{W_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)}=0,
$$

there exists a unique solution $(\boldsymbol{v}, \eta) \in \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)$ such that

$$
-\Delta \boldsymbol{v}-(\boldsymbol{a} \cdot \nabla) \boldsymbol{v}+\nabla \eta=\boldsymbol{f}^{\prime}, \quad \operatorname{div} \boldsymbol{v}=g^{\prime} \quad \text { in } \mathbb{R}^{3},
$$

with the estimate

$$
\|\boldsymbol{v}\|_{\mathbf{w}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}+\|\eta\|_{L^{p^{\prime}}\left(\mathbb{R}^{3}\right)} \leq C_{K}\left(\left\|\boldsymbol{f}^{\prime}\right\|_{\mathbf{w}_{0}^{-1, p^{\prime}\left(\mathbb{R}^{3}\right)}}+\left\|g^{\prime}\right\|_{L^{p^{\prime}}\left(\mathbb{R}^{3}\right)}\right)
$$

Observe that the mapping

$$
T:\left(\boldsymbol{f}^{\prime}, g^{\prime}\right) \mapsto\langle\boldsymbol{f}, \boldsymbol{v}\rangle_{\mathbf{w}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle g, \eta\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}\left(\mathbb{R}^{3}\right)}},
$$

is linear and continuous with

$$
\begin{array}{r}
\left|T\left(\boldsymbol{f}^{\prime}, g^{\prime}\right)\right| \leq\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}\|\boldsymbol{v}\|_{\mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\|\eta\|_{L^{p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
\leq C_{K}\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right)\left(\left\|\boldsymbol{f}^{\prime}\right\|_{\mathbf{W}_{0}^{-1, p^{\prime}\left(\mathbb{R}^{3}\right)}}+\left\|g^{\prime}\right\|_{L^{p^{\prime}}\left(\mathbb{R}^{3}\right)}\right) .
\end{array}
$$

Note that $\boldsymbol{f}^{\prime}$ belongs to $\mathbf{W}_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{f}^{\prime} \perp \mathbb{R}^{3}$. Thus Riesz representation Theorem guarantees the existence of a unique $(\boldsymbol{u}, \pi) \in\left(\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-3 / p]}\right) \times$ $L^{p}\left(\mathbb{R}^{3}\right)$ such that

$$
T\left(\boldsymbol{f}^{\prime}, g^{\prime}\right)=\left\langle\boldsymbol{u}, \boldsymbol{f}^{\prime}\right\rangle_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{w}_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\left\langle\pi, g^{\prime}\right\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)},
$$

with

$$
\|\boldsymbol{u}\|_{\mathbf{w}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}+\|\pi\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq C_{K}\left(\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)}\right) .
$$

By definition of $T$, it follows

$$
\begin{aligned}
& \langle\boldsymbol{f}, \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle g, \eta\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
= & \left\langle\boldsymbol{u}, \boldsymbol{f}^{\prime}\right\rangle_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{-1, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\left\langle\pi, g^{\prime}\right\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)}
\end{aligned}
$$

which is the variational formulation (4.10).
Remark 4.6. Supposing that the data $f \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{-1, q}\left(\mathbb{R}^{3}\right)$ satisfies

$$
\left\langle f_{i}, 1\right\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}=\left\langle f_{i}, 1\right\rangle_{W_{0}^{-1, q}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, q^{\prime}}\left(\mathbb{R}^{3}\right)}=0 \quad \text { if } p, q \leq 3 / 2,
$$

$g \in L^{p}\left(\mathbb{R}^{3}\right) \cap L^{q}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfies (4.6), from Theorems 4.3 and 4.5 there exists a solution $(\boldsymbol{u}, \pi) \in\left(\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{1, q}\left(\mathbb{R}^{3}\right)\right) \times\left(L^{p}\left(\mathbb{R}^{3}\right) \cap L^{q}\left(\mathbb{R}^{3}\right)\right)$ to the Oseen problem (1.1), for any $1<p, q<\infty$.

## 5 Strong solutions in $\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right)$ and in $\mathbf{W}_{1}^{2, p}\left(\mathbb{R}^{3}\right)$

We begin by proving the existence of a unique strong solution in $\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times$ $W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ for $1<p<3$ in the following sense.

Theorem 5.1. For $1<p<3$, let $f \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right), g \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfy (4.6). Then the Oseen problem (1.1) has a unique solution $(\boldsymbol{u}, \pi) \in$ $\left(\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[2-3 / p]}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ such that

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{w}_{0}^{2, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[2-3 / p]}}+\|\pi\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \leq C\left(1+C_{K}\right)\left(\|f\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)}\right) . \tag{5.1}
\end{equation*}
$$

Proof. For all $1<p<3$, Sobolev embedding holds

$$
\mathbf{W}_{0}^{1,3 p^{\prime} /\left(3+p^{\prime}\right)}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)
$$

and by duality we obtain

$$
\begin{equation*}
\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{W}_{0}^{-1,3 p /(3-p)}\left(\mathbb{R}^{3}\right) \tag{5.2}
\end{equation*}
$$

Since $g \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$ and $f \in \mathbf{W}_{0}^{-1,3 p /(3-p)}\left(\mathbb{R}^{3}\right)$, Theorems 4.3 and 4.5 guarantee the existence of a solution

$$
(u, \pi) \in \mathbf{W}_{0}^{1,3 p /(3-p)}\left(\mathbb{R}^{3}\right) \times L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)
$$

to the Oseen problem (1.1) with the estimate

$$
\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1,3 p /(3-p)}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[2-3 / p]}}+\|\pi\|_{L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)} \leq C_{K}\left(\|\boldsymbol{f}\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)}\right) .
$$

Note that the compatibility condition (4.1) is not required because we have $3 p /(3-p)>3 / 2$. Besides, we have $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$. We can apply the Stokes regularity theory (cf. [1, Theorem 3.8]) to deduce the existence of $(\boldsymbol{v}, \eta) \in$ $\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ verifying (4.3), unique up to an element of $\mathbb{P}_{[2-3 / p]} \times\{0\}$.

Moreover, the estimate holds

$$
\begin{aligned}
& \inf _{\boldsymbol{\lambda} \in \mathbb{P}_{[2-3 / p]}}\|\boldsymbol{v}+\boldsymbol{\lambda}\|_{\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right)}+\|\eta\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \leq \\
& \leq C\left(\|\boldsymbol{f}\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\|\nabla \boldsymbol{u}\|_{\mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)}\right),
\end{aligned}
$$

with $C$ denoting a constant only dependent on $p$.
Let $\boldsymbol{w}=\boldsymbol{v}-\boldsymbol{u}$ and $\theta=\eta-\pi$, then

$$
-\Delta \boldsymbol{w}+\nabla \theta=0 \quad \text { and } \quad \operatorname{div} \boldsymbol{w}=0 \quad \text { in } \mathbb{R}^{3}
$$

with $\theta \in L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{w} \in \mathbf{W}_{0}^{1,3 p /(3-p)}\left(\mathbb{R}^{3}\right)$. As $\triangle \theta=0$ in $\mathbb{R}^{3}$, then $\theta=0$ and $\boldsymbol{w} \in \mathbb{P}_{[2-3 / p]} \subset \mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right)$. Consequently, $\boldsymbol{u} \in \mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right)$ and $\pi \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and we obtain the estimate (5.1).

Remark 5.2. Observe that Theorem 5.1 does not include the case $p \geq 3$, under its assumptions, that is, $\boldsymbol{f} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right), g \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$. Indeed if it would be possible to find $\boldsymbol{u} \in \mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right)$ and $\pi \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ such that

$$
(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}=\Delta \boldsymbol{u}-\nabla \pi+\boldsymbol{f} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)
$$

it would happen a contradiction, since $\boldsymbol{a} \in \mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$ and $\nabla \boldsymbol{u} \notin \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$.

In order to present a strong solution for $p \geq 3$, we state the following results.
Theorem 5.3. For $p \geq 3$, let $\boldsymbol{f} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right), g \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfy (4.6). If we additionally assume $\boldsymbol{f} \in \mathbf{L}^{q}\left(\mathbb{R}^{3}\right), g \in W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in$ $\mathbf{L}^{3 p q /(q(3+p)-3 p)}\left(\mathbb{R}^{3}\right)$ for some $3 p /(3+p) \leq q<3$, then the solution $(\boldsymbol{u}, \pi) \in$ $\mathbf{W}_{0}^{2, q}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ given by Theorem 5.1 belongs also to $\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and it satisfies

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[2-3 / p]}}+\|\pi\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \leq C\left(1+C_{K}\right)\left(\|\boldsymbol{f}\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{0}^{1, p}\left(\mathbb{R}^{3}\right)}\right) \tag{5.3}
\end{equation*}
$$

Proof. Since $\boldsymbol{f} \in \mathbf{L}^{q}\left(\mathbb{R}^{3}\right)$ and $g \in W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$, for $3 / 2 \leq q<3$, we can apply Theorem 5.1. Then there exists a unique solution $(\boldsymbol{u}, \pi) \in\left(\mathbf{W}_{0}^{2, q}\left(\mathbb{R}^{3}\right) / \mathbb{R}^{3}\right) \times$ $W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ satisfying the Oseen problem (1.1). Thus it results $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ since $\nabla \boldsymbol{u} \in \mathbf{L}^{3 q /(3-q)}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{L}^{3 p q /(q(3+p)-3 p)}\left(\mathbb{R}^{3}\right)$ for some $3 p /(3+p) \leq$ $q<3$. Next proceeding as in the proof of Theorem 5.1 we can conclude that $(\boldsymbol{u}, \pi) \in\left(\mathbf{W}_{0}^{2, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[2-3 / p]}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ verifies (5.3).

Note that in Theorem 5.3, $\boldsymbol{a} \in \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$ if $q=3 p /(3+p)$, and if $q$ is close to 3 then $3 p q /(q(3+p)-3 p)$ is close to $p$.

Finally, we take $\boldsymbol{f}$ in weighted $\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$, more precisely $\boldsymbol{f} \in \mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)$, and the data $g$ in the corresponding weighted Sobolev space $W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$.

Theorem 5.4. Let $p \neq 3 / 2, f \in \mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)$ satisfy (4.1), $g \in W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3} \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$ satisfy (4.6) and

$$
\begin{equation*}
\exists L>0, \quad|\boldsymbol{a}(\boldsymbol{x})| \leq \frac{L}{|\boldsymbol{x}|}, \quad \text { a.e. } \boldsymbol{x} \in \mathbb{R}^{3} \tag{5.4}
\end{equation*}
$$

Then the Oseen problem (1.1) has a unique solution $(\boldsymbol{u}, \pi) \in \mathbf{W}_{1}^{2, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-3 / p]} \times$ $W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$ satisfying

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{W}_{1}^{2, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-3 / p]}}+\|\pi\|_{W_{1}^{1, p}\left(\mathbb{R}^{3}\right)} \leq C\left(1+L C_{K}\right)\left(\|\boldsymbol{f}\|_{\mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{1}^{1, p}\left(\mathbb{R}^{3}\right)}\right) \tag{5.5}
\end{equation*}
$$

Proof. Since $W_{1}^{1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{p}\left(\mathbb{R}^{3}\right)$ and for $p \neq 3 / 2$ we have $\mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right) \hookrightarrow$ $\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$, thanks to Theorems 4.3 and 4.5 , there exists a solution $(\boldsymbol{u}, \pi) \in$ $\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ to the Oseen problem (1.1) satisfying (4.9).

Considering the assumption (5.4), we get $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u} \in \mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)$. Moreover, we have, for all $i=1,2,3$,

$$
\left\langle(\boldsymbol{a} \cdot \nabla) u_{i}+f_{i}, 1\right\rangle_{W_{1}^{0, p}\left(\mathbb{R}^{3}\right) \times W_{-1}^{0, p^{\prime}}\left(\mathbb{R}^{3}\right)}=0, \quad \text { if } p \leq 3 / 2 .
$$

Thus the conditions of Stokes regularity result are fulfilled (cf. [1, Theorem 3.1]) and we can conclude the existence of $(\boldsymbol{v}, \eta) \in \mathbf{W}_{1}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$, unique up to an element of $\mathbb{P}_{[1-3 / p]} \times\{0\}$ and satisfying

$$
\begin{aligned}
& \inf _{\boldsymbol{\lambda} \in \mathbb{P}_{(1-3 / p]}}\|\boldsymbol{v}+\boldsymbol{\lambda}\|_{\mathbf{W}_{1}^{2, p}\left(\mathbb{R}^{3}\right)}+\|\eta\|_{W_{1}^{1, p}\left(\mathbb{R}^{3}\right)} \leq \\
& \leq C\left(\|\boldsymbol{f}\|_{\mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)}+L\|\nabla \boldsymbol{u}\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{1}^{1, p}\left(\mathbb{R}^{3}\right)}\right) .
\end{aligned}
$$

Then the proof's conclusion of Theorem 5.4 is identical to the one of Theorem 5.1.

Remark 5.5. Observe that $W_{1}^{0, p}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{p}\left(\mathbb{R}^{3}\right), W_{1}^{1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and if $p \geq 3$ then $W_{1}^{0, p}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{q}\left(\mathbb{R}^{3}\right)$ for all $q \in[3 p /(3+p), 3[$. The assumptions on $\boldsymbol{a}$ stated in Theorem 5.4 are also stronger of those in Theorems 5.1 and 5.3.

Remark 5.6. i) It is known that $L^{3}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{3, \infty}\left(\mathbb{R}^{3}\right)$ and $1 /|x| \in L^{3, \infty}\left(\mathbb{R}^{3}\right)$, where $L^{3, \infty}\left(\mathbb{R}^{3}\right)$ is the space of measurable functions $v$ defined on $\mathbb{R}^{3}$ satisfying

$$
\exists C>0, \quad \forall t>0, \quad t^{3} \text { meas }\left\{\boldsymbol{x} \in \mathbb{R}^{3} ;|v(\boldsymbol{x})|>t\right\} \leq C .
$$

ii) When $p=3 / 2$, the previous existence result holds provided we suppose that $f \in \mathbf{W}_{1}^{0,3 / 2}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{-1,3 / 2}\left(\mathbb{R}^{3}\right)$ (see (2.1)).

## 6 Very weak solutions in $L^{p}\left(\mathbb{R}^{3}\right)$

In this section we show how very weak solutions to the problem (1.1) can easily been obtained from the existence of strong solutions as in Section 5 via a dual argument. We begin by precising the meaning of very weak variational formulation.

Lemma 6.1. For $p>3 / 2$, the problem of finding a pair $(\boldsymbol{u}, \pi) \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times$ $W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ verifying (1.1), with $f \in \mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right)$ and $g \in W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$, has the following variational formulation

$$
\begin{gather*}
\int_{\mathbb{R}^{3}} \boldsymbol{u} \cdot(-\Delta \boldsymbol{v}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v})+\nabla \eta) d \boldsymbol{x}-\langle\pi, \operatorname{div} \boldsymbol{v}\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
=\langle\boldsymbol{f}, \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle g, \eta\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)} \tag{6.1}
\end{gather*}
$$

for all $\boldsymbol{v} \in \mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)$ and $\eta \in W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)$.

Proof. By a density argument of $\mathcal{D}\left(\mathbb{R}^{3}\right)$ into respectively $W_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)$ and $W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)$, we have the following equalities

$$
\begin{array}{r}
\langle-\Delta \boldsymbol{u}, \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}=\langle\boldsymbol{u},-\Delta \boldsymbol{v}\rangle_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
\langle\nabla \pi, \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}=-\langle\pi, \operatorname{div} \boldsymbol{v}\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
\langle\operatorname{div} \boldsymbol{u}, \eta\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}=-\langle\boldsymbol{u}, \nabla \eta\rangle_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)}
\end{array}
$$

Since $\boldsymbol{a} \in \mathbf{H}_{3}$ and $p>3 / 2$, on one hand $\boldsymbol{a} \otimes \boldsymbol{u} \in \mathbf{L}^{3 p /(3+p)}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ and $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}=\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}) \in \mathbf{W}_{0}^{-1,3 p /(3+p)}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right)$. On the other hand, for any $\boldsymbol{v} \in \mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)$ we have $\nabla \boldsymbol{v} \in \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{L}^{3 p /(2 p-3)}\left(\mathbb{R}^{3}\right)$ and $\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v})=(\boldsymbol{a} \cdot \nabla) \boldsymbol{v} \in \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)$. Then we obtain

$$
\begin{aligned}
\langle\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}), \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)} & =-\langle\boldsymbol{a} \otimes \boldsymbol{u}, \nabla \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
& =\langle\boldsymbol{u},-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v})\rangle_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)} .
\end{aligned}
$$

Thus Lemma 6.1 holds.
Definition 6.2. We say that $(\boldsymbol{u}, \pi) \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ is a very weak solution to the problem (1.1) if it satisfies (6.1).

Theorem 6.3. For $p>3 / 2$, let $f \in \mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right)$ satisfy the compatibility condition: for any $i=1,2,3$

$$
\begin{equation*}
\left\langle f_{i}, 1\right\rangle_{W_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}=0 \quad \text { if } p \leq 3, \tag{6.2}
\end{equation*}
$$

$g \in W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfy (4.6). Then the Oseen problem (1.1) has a unique very weak solution $(\boldsymbol{u}, \pi) \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ such that

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)}+\|\pi\|_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)} \leq C\left(1+C_{K}\right)\left(\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-2, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}\right) \tag{6.3}
\end{equation*}
$$

Proof. In accordance to Theorem 5.1 for $p^{\prime}<3, \boldsymbol{f}^{\prime} \in \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)$ and $g^{\prime} \in$ $W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)$, there exists a unique solution $(\boldsymbol{v}, \eta) \in\left(\mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{\left[2-3 / p^{\prime}\right]}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)$ to the problem

$$
-\Delta \boldsymbol{v}-(\boldsymbol{a} \cdot \nabla) \boldsymbol{v}+\nabla \eta=\boldsymbol{f}^{\prime}, \quad \operatorname{div} \boldsymbol{v}=g^{\prime} \quad \text { in } \mathbb{R}^{3}
$$

satisfying the estimate

$$
\|\boldsymbol{v}\|_{\mathbf{W}_{0}^{2, p^{\prime}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{\left[2-3 / p^{\prime}\right]}}}+\|\eta\|_{W_{0}^{1, p^{\prime}\left(\mathbb{R}^{3}\right)}} \leq C\left(1+C_{K}\right)\left(\left\|\boldsymbol{f}^{\prime}\right\|_{\mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)}+\left\|g^{\prime}\right\|_{W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}\right) .
$$

Define the mapping

$$
T:\left(\boldsymbol{f}^{\prime}, g^{\prime}\right) \mapsto\langle\boldsymbol{f}, \boldsymbol{v}\rangle_{\mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle g, \eta\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)} .
$$

Then $T$ is linear and using (6.2) $T$ is continuous with

$$
\begin{aligned}
& \left|T\left(\boldsymbol{f}^{\prime}, g^{\prime}\right)\right| \leq\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right)}\|\boldsymbol{v}\|_{\mathbf{W}_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{\left[2-3 / p^{\prime}\right]}}+\|g\|_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}\|\eta\|_{W_{0}^{1, p^{\prime}\left(\mathbb{R}^{3}\right)}} \\
\leq & C\left(1+C_{K}\right)\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-2, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}\right)\left(\left\|\boldsymbol{f}^{\prime}\right\|_{\mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)}+\left\|g^{\prime}\right\|_{W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}\right) .
\end{aligned}
$$

Thanks to the Riesz representation Theorem, there exists a unique $(\boldsymbol{u}, \pi) \in$ $\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times W_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ such that

$$
T\left(\boldsymbol{f}^{\prime}, g^{\prime}\right)=\left\langle\boldsymbol{u}, \boldsymbol{f}^{\prime}\right\rangle_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \times \mathbf{L}^{p^{\prime}}\left(\mathbb{R}^{3}\right)}-\left\langle\pi, g^{\prime}\right\rangle_{W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)},
$$

and the estimate (6.3) is satisfied. By definition of $T$, it follows the very weak variational formulation (6.1).

Remark 6.4. Using Theorem 5.4 with $p^{\prime} \neq 3 / 2$ and similar dual argument we can conclude that for $p>3 / 2$ such that $p \neq 3, f \in \mathbf{W}_{-1}^{-2, p}\left(\mathbb{R}^{3}\right), g \in$ $W_{-1}^{-1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfying (4.6) and (5.4), there exists a very weak solution $(\boldsymbol{u}, \pi) \in \mathbf{W}_{-1}^{0, p}\left(\mathbb{R}^{3}\right) \times W_{-1}^{-1, p}\left(\mathbb{R}^{3}\right)$ to the problem (1.1) in the following sense

$$
\begin{array}{r}
\langle\boldsymbol{u},-\Delta \boldsymbol{v}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v})+\nabla \eta\rangle_{\mathbf{W}_{-1}^{0, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{1}^{0, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle\pi, \operatorname{div} \boldsymbol{v}\rangle_{W_{-1}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{1}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)} \\
=\langle\boldsymbol{f}, \boldsymbol{v}\rangle_{\mathbf{W}_{-1}^{-2, p}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{1}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}-\langle g, \eta\rangle_{W_{-1}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{1}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}
\end{array}
$$

for all $\boldsymbol{v} \in \mathbf{W}_{1}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)$ and $\eta \in W_{1}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)$. Indeed the above weak formulation has meanful for $p>3 / 2$, since $\boldsymbol{a} \in \mathbf{H}_{3}$ and $\nabla \boldsymbol{v} \in \mathbf{W}_{1}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right) \hookrightarrow$ $\mathbf{W}_{1}^{0,3 p /(2 p-3)}\left(\mathbb{R}^{3}\right)$ we have then $\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{v})=(\boldsymbol{a} \cdot \nabla) \boldsymbol{v} \in \mathbf{W}_{1}^{0, p^{\prime}}\left(\mathbb{R}^{3}\right)$.

## 7 The generalized Oseen problem (1.3)

In this section, we study the generalized Oseen problem (1.3):

$$
-\Delta \boldsymbol{u}+k \frac{\partial \boldsymbol{u}}{\partial x_{1}}+(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}+\nabla \pi=\boldsymbol{f}, \quad \operatorname{div} \boldsymbol{u}=g \quad \text { in } \mathbb{R}^{3}
$$

As in sections 3,4 and 5 where we applied the Stokes theory, here we can apply the theory concerning the Oseen system (1.2).

We introduce the following Banach space

$$
Z_{p}\left(\mathbb{R}^{3}\right)=\left\{v \in L^{p}\left(\mathbb{R}^{3}\right) ; \frac{\partial v}{\partial x_{1}} \in W_{0}^{-2, p}\left(\mathbb{R}^{3}\right)\right\}
$$

Next we prove some useful results.
Lemma 7.1. For every $1<p<\infty$ and $g \in Z_{p}\left(\mathbb{R}^{3}\right)$ verifying

$$
\begin{equation*}
\forall \lambda \in \mathbb{P}_{\left[2-3 / p^{\prime}\right]}, \quad\left\langle\frac{\partial g}{\partial x_{1}}, \lambda\right\rangle_{W_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}=0 \tag{7.1}
\end{equation*}
$$

there exists $\boldsymbol{w} \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ such that div $\boldsymbol{w}=g$ in $\mathbb{R}^{3}$ and satisfies the estimate

$$
\begin{equation*}
\|\boldsymbol{w}\|_{\mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \leq C\|g\|_{Z_{p}\left(\mathbb{R}^{3}\right)} \tag{7.2}
\end{equation*}
$$

Moreover $\boldsymbol{w} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$ if $1<p<3, \boldsymbol{w} \in \mathbf{L}^{12}\left(\mathbb{R}^{3}\right) \cap$ $\mathbf{B M O}$ if $p=3$, and $\boldsymbol{w} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$ if $3<p<4$ with estimates corresponding to (2.10), (2.11) and (2.12).

Proof. Let $g \in Z_{p}\left(\mathbb{R}^{3}\right)$. From $g \in L^{p}\left(\mathbb{R}^{3}\right)$ there exists $v \in W_{0}^{2, p}\left(\mathbb{R}^{3}\right)$ verifying

$$
\Delta v=g \text { in } \mathbb{R}^{3},
$$

where $v$ is unique up to a polynomial function of $\mathbb{P}_{[2-3 / p]}$ (see [3]). We can choose $v$ such that there exists a constant $C_{1}>0$ satisfying

$$
\begin{equation*}
\|\nabla v\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)} \leq C_{1}\|g\|_{L^{p}\left(\mathbb{R}^{3}\right)} \tag{7.3}
\end{equation*}
$$

From $\frac{\partial g}{\partial x_{1}} \in W_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \perp \mathbb{P}_{\left[2-3 / p^{\prime}\right]}$ there exists a unique $z \in L^{p}\left(\mathbb{R}^{3}\right)$ verifying

$$
\Delta z=\frac{\partial g}{\partial x_{1}} \text { in } \mathbb{R}^{3}
$$

and it is such that the following estimate holds

$$
\begin{equation*}
\|\nabla z\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)} \leq C_{2}\|z\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq C_{3}\left\|\frac{\partial g}{\partial x_{1}}\right\|_{W_{0}^{-2, p}\left(\mathbb{R}^{3}\right)} \tag{7.4}
\end{equation*}
$$

Then $\frac{\partial v}{\partial x_{1}}-z \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)+L^{p}\left(\mathbb{R}^{3}\right)$ is harmonic and $\frac{\partial v}{\partial x_{1}}-z \in \mathbb{P}_{[1-3 / p]}$, that means, $\frac{\partial v}{\partial x_{1}}=z$ if $p<3$ and $\frac{\partial v}{\partial x_{1}}-z=$ constant if $p \geq 3$.

Next let us take $\boldsymbol{w}=\nabla v$. Hence $\boldsymbol{w} \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right), \operatorname{div} \boldsymbol{w}=g$ and $\frac{\partial \boldsymbol{w}}{\partial x_{1}}=\nabla\left(\frac{\partial v}{\partial x_{1}}\right)=$ $\nabla z \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$.

Using (7.3) and (7.4) it follows

$$
\|\boldsymbol{w}\|_{\mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}=\|\boldsymbol{w}\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}+\left\|\frac{\partial \boldsymbol{w}}{\partial x_{1}}\right\|_{\mathbf{w}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)} \leq \max \left\{C_{1}, C_{3}\right\}\|g\|_{Z_{p}\left(\mathbb{R}^{3}\right)}
$$

Consequently we get (7.2). Applying Proposition 2.5 we conclude the proof of Lemma 7.1.

Remark 7.2. The condition (7.1) is equivalent to

$$
\left\langle\frac{\partial g}{\partial x_{1}}, x_{1}\right\rangle_{W_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)}=0, \quad \text { if } p^{\prime} \geq 3
$$

Indeed for all $\lambda \in \mathbb{P}_{\left[2-3 / p^{\prime}\right]}$ such that $\frac{\partial \lambda}{\partial x_{1}}=0$, we have

$$
\left\langle\frac{\partial g}{\partial x_{1}}, \lambda\right\rangle_{W_{0}^{-2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{2, p^{\prime}\left(\mathbb{R}^{3}\right)}}=-\left\langle g, \frac{\partial \lambda}{\partial x_{1}}\right\rangle_{L^{p}\left(\mathbb{R}^{3}\right) \times L^{p^{\prime}}\left(\mathbb{R}^{3}\right)}=0,
$$

taking into account the density of $\mathcal{D}\left(\mathbb{R}^{3}\right)$ in $X_{0}^{2, p^{\prime}}\left(\mathbb{R}^{3}\right)$.
Lemma 7.3. Let $g \in Z_{p}\left(\mathbb{R}^{3}\right)$ verifying the compatibility condition (7.1). Then, there exists a sequence $g_{m} \in \mathcal{D}\left(\mathbb{R}^{3}\right)$ satisfying (7.1) and such that $g_{m} \rightarrow g$ in $Z_{p}\left(\mathbb{R}^{3}\right)$.

Proof. Let $g \in Z_{p}\left(\mathbb{R}^{3}\right)$. Applying Lemma 7.1 there exists $\boldsymbol{w} \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ verifying $\operatorname{div} \boldsymbol{w}=g$ and (7.2). Since $\mathcal{D}\left(\mathbb{R}^{3}\right)$ is dense into $\mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$, there exists a sequence $\left\{\boldsymbol{w}_{m}\right\}_{m \in \mathbb{N}} \subset \mathcal{D}\left(\mathbb{R}^{3}\right)$ such that $\boldsymbol{w}_{m} \rightarrow \boldsymbol{w}$ in $\mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right)$. Taking $g_{m}=\operatorname{div} \boldsymbol{w}_{m} \in \mathcal{D}\left(\mathbb{R}^{3}\right)$ it follows $g_{m} \rightarrow g$ in $Z_{p}\left(\mathbb{R}^{3}\right)$. Observe that $g_{m}$ satisfies (7.1).

The first existence result to the problem (1.3) concerns the Hilbertian case $p=2$.

Proposition 7.4. Assume that $\boldsymbol{f} \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right), g \in Z_{2}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$. Then the problem (1.3) has a unique solution $(\boldsymbol{u}, \pi) \in\left(\mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{4}\left(\mathbb{R}^{3}\right)\right) \times L^{2}\left(\mathbb{R}^{3}\right)$. Moreover, the following estimate holds

$$
\begin{equation*}
\|\boldsymbol{u}\|_{\mathbf{X}_{0}^{1,2}}+\|\boldsymbol{u}\|_{\mathbf{L}^{4}}+\|\pi\|_{L^{2}} \leq C\left(\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+\left(1+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\right)\|g\|_{Z_{2}\left(\mathbb{R}^{3}\right)}\right) . \tag{7.5}
\end{equation*}
$$

Proof. Let $g \in Z_{2}\left(\mathbb{R}^{3}\right)$. Applying Lemma 7.1 and Remark 7.2, there exists $\boldsymbol{w} \in \mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$ satisfying $\operatorname{div} \boldsymbol{w}=g$ and (7.2) with $p=2$. Next let us take the
unique solution $(\boldsymbol{v}, \pi) \in\left(\mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{4}\left(\mathbb{R}^{3}\right)\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ to the Oseen problem (cf. [4, Lemma 4.1])
$-\Delta \boldsymbol{v}+k \frac{\partial \boldsymbol{v}}{\partial x_{1}}+(\boldsymbol{a} \cdot \nabla) \boldsymbol{v}+\nabla \pi=\boldsymbol{f}+\Delta \boldsymbol{w}-k \frac{\partial \boldsymbol{w}}{\partial x_{1}}-(\boldsymbol{a} \cdot \nabla) \boldsymbol{w}, \quad \operatorname{div} \boldsymbol{v}=0$ in $\mathbb{R}^{3}$,
satisfying the estimate

$$
\|\boldsymbol{v}\|_{\mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right)}+\|\pi\|_{L^{2}\left(\mathbb{R}^{3}\right)} \leq C\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{w}\|_{\mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\|\boldsymbol{w}\|_{\mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)}\right)
$$

Letting $\boldsymbol{u}=\boldsymbol{v}+\boldsymbol{w}$, we obtain $\boldsymbol{u} \in \mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right)$ that satisfies (1.3) and (7.5).
Proposition 7.5. Assume that $1<p<\infty, f \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$, $g \in Z_{2}\left(\mathbb{R}^{3}\right) \cap Z_{p}\left(\mathbb{R}^{3}\right)$ satisfy the compatibility conditions (4.1) and (7.1), respectively, and $\boldsymbol{a} \in \mathbf{H}_{3}$. If $\boldsymbol{a} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)$ for $1<p<4$ and $\boldsymbol{a} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ for $p \geq 4$, then the pair $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ given by Proposition 7.4 belongs also to $\mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$. Moreover

$$
\begin{array}{ll}
\boldsymbol{u} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{6}\left(\mathbb{R}^{3}\right) & \text { if } p<2 ; \\
\boldsymbol{u} \in \mathbf{L}^{4}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right) & \text { if } 2 \leq p<3 ; \\
\boldsymbol{u} \in \mathbf{L}^{r}\left(\mathbb{R}^{3}\right), \quad \forall r \geq 4, & \text { if } p=3 \\
\boldsymbol{u} \in \mathbf{L}^{4}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right), & \text { if } p>3 \tag{7.9}
\end{array}
$$

Proof. Under the assumptions on $\boldsymbol{f}, \boldsymbol{g}$ and $\boldsymbol{a}$, Proposition 7.4 yields the existence of a unique $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ verifying

$$
-\Delta \boldsymbol{u}+k \frac{\partial \boldsymbol{u}}{\partial x_{1}}+\nabla \pi=\boldsymbol{f}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}) \quad \text { in } \mathbb{R}^{3}
$$

From Proposition 2.5, we have $\boldsymbol{u} \in \mathbf{L}^{4}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{6}\left(\mathbb{R}^{3}\right)$.
Case 1: $1<p<4$. Considering that $\boldsymbol{a} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)$, we get $\boldsymbol{a} \otimes \boldsymbol{u} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ and then $\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}) \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \perp \mathbb{P}_{\left[1-3 / p^{\prime}\right]}$. From the Oseen theory $[6$, Theorem 2.2] there exists a unique solution $(\boldsymbol{v}, \eta) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ to the problem

$$
\begin{equation*}
-\Delta \boldsymbol{v}+k \frac{\partial \boldsymbol{v}}{\partial x_{1}}+\nabla \eta=\boldsymbol{f}-\operatorname{div}(\boldsymbol{a} \otimes \boldsymbol{u}) \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right), \quad \operatorname{div} \boldsymbol{v}=g \text { in } \mathbb{R}^{3} \tag{7.10}
\end{equation*}
$$

Moreover $\boldsymbol{v} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)$. Then a uniqueness argument implies that $\pi=\eta$ and next $\boldsymbol{u}=\boldsymbol{v}$. Thanks to Proposition 2.5 it follows (7.6)-(7.9).

Case 2: $p \geq$ 4. As $f \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{-1, q}\left(\mathbb{R}^{3}\right)$ and $g \in Z_{2}\left(\mathbb{R}^{3}\right) \cap Z_{q}\left(\mathbb{R}^{3}\right)$, for any $2 \leq q<4$, thanks to the case 1 we get $\boldsymbol{u} \in \mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{X}_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ and $\pi \in L^{2}\left(\mathbb{R}^{3}\right) \cap L^{q}\left(\mathbb{R}^{3}\right)$ for any $2 \leq q<4$. In particular, choosing $3<q<4$
we obtain $\boldsymbol{u} \in \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$ and then $\nabla \cdot(\boldsymbol{a} \otimes \boldsymbol{u}) \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ and also (7.9) holds. From the Oseen theory [6, Theorem 2.2] there exists a solution $(\boldsymbol{v}, \eta) \in$ $\mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ to the problem (7.10), where $\eta$ is unique and $\boldsymbol{v}$ is unique up to an element of $\mathbb{R}^{3}$. By a similar argument to the case 1 , we show that $(\nabla \boldsymbol{u}, \pi)=(\nabla \boldsymbol{v}, \eta)$ and $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ verifying (7.9).

Now we are able to prove the existence result in the non-Hilbertian case $p \neq 2$.
Theorem 7.6. Assume that $1<p<\infty, f \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right), g \in Z_{p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfy (4.1), (7.1) and (4.6), respectively. Then the problem (1.3) has a solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$, where $\pi$ is unique and $\boldsymbol{u}$ is unique if $1<p<4$ and up to an element of $\mathbb{R}^{3}$ otherwise. Moreover, we have the estimate
$\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-4 / p]}}+\left\|\frac{\partial \boldsymbol{u}}{\partial x_{1}}\right\|_{\mathbf{w}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|\pi\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq C_{K}\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{Z_{p}\left(\mathbb{R}^{3}\right)}\right)$
and also that $\boldsymbol{u} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$ if $1<p<3$, $\boldsymbol{u} \in \mathbf{L}^{r}\left(\mathbb{R}^{3}\right)$ for all $r \geq 12$ if $p=3$, and $\boldsymbol{u} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$ if $3<p<4$.

Proof. By (4.1), we have $\boldsymbol{f}=\operatorname{div} \mathbf{F}$ with $\mathbf{F} \in L^{p}\left(\mathbb{R}^{3}\right)^{3 \times 3}$. Thus, there exists a sequence $\left\{\mathbf{F}_{m}\right\} \subset \mathcal{D}\left(\mathbb{R}^{3}\right)^{3 \times 3}$ such that $\mathbf{F}_{m} \rightarrow \mathbf{F}$ in $\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$. Set $f_{m}=\operatorname{div} \mathbf{F}_{m}$. Then $f_{m}$ satisfying the condition (4.1) and $\boldsymbol{f}_{m}$ converges to $f$ in $\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$. Using the density properties of $\mathcal{D}\left(\mathbb{R}^{3}\right)$ into $Z_{p}\left(\mathbb{R}^{3}\right)$ (cf. Lemma 7.3) and of $\mathcal{V}$ into $\mathbf{H}_{3}$ (cf. Lemma 4.2), there exist $\left\{g_{m}\right\} \subset \mathcal{D}\left(\mathbb{R}^{3}\right)$ and $\left\{\boldsymbol{a}_{m}\right\} \subset \mathcal{V}$ such that

$$
g_{m} \rightarrow g \text { in } Z_{p}\left(\mathbb{R}^{3}\right) \quad \text { and } \quad \boldsymbol{a}_{m} \rightarrow \boldsymbol{a} \text { in } \mathbf{H}_{3} .
$$

Applying Proposition 7.5 , there exists $\left(\boldsymbol{u}_{m}, \pi_{m}\right) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ solution of the problem

$$
-\Delta \boldsymbol{u}_{m}+k \frac{\partial \boldsymbol{u}_{m}}{\partial x_{1}}+\operatorname{div}\left(\boldsymbol{a}_{m} \otimes \boldsymbol{u}_{m}\right)+\nabla \pi_{m}=\boldsymbol{f}_{m}, \quad \operatorname{div} \boldsymbol{u}_{m}=g_{m} \text { in } \mathbb{R}^{3},
$$

where $\boldsymbol{f}_{m}, g_{m}$ and $\boldsymbol{a}_{m}$ converge to $\boldsymbol{f}, g$ and $\boldsymbol{a}$ in $\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right), Z_{p}\left(\mathbb{R}^{3}\right)$ and $\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$, respectively. Now applying the Oseen theory [6, Theorem 2.2], there exists a unique solution $\left(\boldsymbol{v}_{m}, \eta_{m}\right) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ satisfying

$$
-\Delta \boldsymbol{v}_{m}+k \frac{\partial \boldsymbol{v}_{m}}{\partial x_{1}}+\nabla \eta_{m}=\boldsymbol{f}_{m}-\operatorname{div}\left(\boldsymbol{a}_{m} \otimes \boldsymbol{u}_{m}\right), \quad \operatorname{div} \boldsymbol{v}_{m}=g_{m} \text { in } \mathbb{R}^{3}
$$

Moreover, the estimate holds

$$
\begin{array}{r}
\left\|\boldsymbol{v}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-4 / p]}}+\left\|\frac{\partial \boldsymbol{v}_{m}}{\partial x_{1}}\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\left\|\eta_{m}\right\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq \\
\leq C\left(\left\|\boldsymbol{f}_{m}-\operatorname{div}\left(\boldsymbol{a}_{m} \otimes \boldsymbol{u}_{m}\right)\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\left\|g_{m}\right\|_{L^{p}\left(\mathbb{R}^{3}\right)}+\left\|\frac{\partial g_{m}}{\partial x_{1}}\right\|_{W_{0}^{-2, p}\left(\mathbb{R}^{3}\right)}\right) .
\end{array}
$$

By the uniqueness argument, it is clear that $\left(\nabla \boldsymbol{v}_{m}, \eta_{m}\right)=\left(\nabla \boldsymbol{u}_{m}, \pi_{m}\right)$. In order to obtain an estimate independent on $m$ we split into two cases.

Case 1: $p<3$. Observing that $\boldsymbol{u}_{m} \in \mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{L}^{p *}\left(\mathbb{R}^{3}\right)$, we have

$$
\left\|\operatorname{div}\left(\boldsymbol{a}_{m} \otimes \boldsymbol{u}_{m}\right)\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)} \leq\left\|\boldsymbol{a}_{m} \otimes \boldsymbol{u}_{m}\right\|_{\mathbf{L}^{p}\left(\mathbb{R}^{3}\right)} \leq C\left\|\boldsymbol{a}_{m}\right\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}
$$

Case 2: $p \geq 3$. Observing that $\left(\boldsymbol{a}_{m} \cdot \nabla\right) \boldsymbol{u}_{m} \in \mathbf{L}^{3 p /(3+p)}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$, we have

$$
\left\|\left(\boldsymbol{a}_{m} \cdot \nabla\right) \boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)} \leq C\left\|\left(\boldsymbol{a}_{m} \cdot \nabla\right) \boldsymbol{u}_{m}\right\|_{\mathbf{L}^{3 p /(3+p)}\left(\mathbb{R}^{3}\right)} \leq C\left\|\boldsymbol{a}_{m}\right\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}
$$

Hence in both cases it follows

$$
\begin{array}{r}
\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-4 / p]}}+\left\|\frac{\partial \boldsymbol{u}_{m}}{\partial x_{1}}\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\left\|\pi_{m}\right\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq \\
\leq C\left(\left\|\boldsymbol{f}_{m}\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\left\|\boldsymbol{a}_{m}\right\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}+\left\|g_{m}\right\|_{Z_{p}\left(\mathbb{R}^{3}\right)}\right) \\
\leq C\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|\boldsymbol{a}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)}\left\|\boldsymbol{u}_{m}\right\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{Z_{p}\left(\mathbb{R}^{3}\right)}\right) .
\end{array}
$$

Then, proceeding as in the proof of Theorem 4.3 and also using Proposition 2.5, we conclude Theorem 7.6.

Remark 7.7. If $3<p<4$, Lemma 2.4 yields that the solution $u$ given at Theorem 7.6 is a continuous function satisfying (2.9). If $p<3$, the unique solution to (1.1) in accordance to Theorem 7.6 tends weakly to zero at infinity (cf. Lemma 2.1 and Definition 2.2).

Next, let us state the existence of strong solutions to (1.3).
Theorem 7.8. Assume that $1<p<3, f \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right), g \in X_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in$ $\mathbf{H}_{3}$ such that (4.6) is satisfied. Then the problem (1.3) has a unique solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ satisfying

$$
\begin{array}{r}
\nabla \boldsymbol{u} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right) ; \\
\boldsymbol{u} \in \mathbf{L}^{3 p /(3-2 p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{2 p /(2-p)}\left(\mathbb{R}^{3}\right) \quad \text { if } p<3 / 2 ; \\
\boldsymbol{u} \in \mathbf{L}^{q}\left(\mathbb{R}^{3}\right), \quad \forall q \geq 2 p /(2-p) \quad \text { if } 3 / 2 \leq p<2 . \tag{7.13}
\end{array}
$$

Proof. As $1<p<3$, note that $\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{W}_{0}^{-1,3 p /(3-p)}\left(\mathbb{R}^{3}\right)$, see (5.2). Under the assumption on $g$ we get $g \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$ and the embedding $W_{0}^{2,3 p /(4 p-3)}\left(\mathbb{R}^{3}\right) \hookrightarrow W_{0}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)$ implies that $\frac{\partial g}{\partial x_{1}} \in W_{0}^{-1, p}\left(\mathbb{R}^{3}\right) \hookrightarrow$ $W_{0}^{-2,3 p /(3-p)}\left(\mathbb{R}^{3}\right)$. Moreover for $1<p<3$ we get $3 / 2<p *=3 p /(3-p)<\infty$. Thus Theorem 7.6 guarantees the existence of a solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1, p *}\left(\mathbb{R}^{3}\right) \times$
$L^{p *}\left(\mathbb{R}^{3}\right)$ to the problem (1.3). Then $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$ and we can apply the Oseen regularity theory $[6$, Theorem 2.6$]$ to conclude that $(u, \pi) \in$ $\mathbf{X}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$. Moreover, by Proposition 2.6 we have (7.11)-(7.13).

Theorem 7.9. For $p \geq 3$, let $\boldsymbol{f} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$, $g \in W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfy (4.6). If we additionally assume $f \in \mathbf{L}^{q}\left(\mathbb{R}^{3}\right), g \in W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a} \in$ $\mathbf{L}^{3 p q /(q(3+p)-3 p)}\left(\mathbb{R}^{3}\right)$ for some $3 p /(3+p) \leq q<3$, then the solution $(\boldsymbol{u}, \pi) \in$ $\mathbf{X}_{0}^{2, q}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ given by Theorem 7.8 belongs also to $\mathbf{X}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and it satisfies

$$
\begin{equation*}
\nabla u \in \mathbf{L}^{4 q /(4-q)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{3 q /(3-q)}\left(\mathbb{R}^{3}\right) \tag{7.14}
\end{equation*}
$$

Proof. Since $\boldsymbol{f} \in \mathbf{L}^{q}\left(\mathbb{R}^{3}\right)$ and $g \in W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$, with $3 / 2 \leq q<3$, we can apply Theorem 7.8. Then there exists a unique solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{2, q}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ satisfying the generalized Oseen problem (1.3). As in the proof of Theorem 5.3 it results $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u} \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right)$. Analogously to the proof of Theorem 7.8, applying the Oseen regularity theory [6, Theorem 2.6] we can conclude that $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$, and it verifies (7.14).

In order to prove the existence of stronger solutions of the generalized Oseen problem (1.3) under smoother data, let us state the following result.

Lemma 7.10. i) For every $p \neq 3 / 2$ and $g \in X_{1}^{1, p}\left(\mathbb{R}^{3}\right)$ verifying

$$
\begin{equation*}
\forall \lambda \in \mathbb{P}_{\left[2-3 / p^{\prime}\right]}, \quad\left\langle\frac{\partial g}{\partial x_{1}}, \lambda\right\rangle_{W_{1}^{-1, p}\left(\mathbb{R}^{3}\right) \times W_{-1}^{1, p^{\prime}}\left(\mathbb{R}^{3}\right)}=0, \tag{7.15}
\end{equation*}
$$

there exists $\boldsymbol{w} \in \mathbf{X}_{1}^{2, p}\left(\mathbb{R}^{3}\right)$ such that div $\boldsymbol{w}=g$ in $\mathbb{R}^{3}$ and satisfies the estimate

$$
\|\boldsymbol{w}\|_{\mathbf{X}_{1}^{2, p}\left(\mathbb{R}^{3}\right)} \leq C\|g\|_{X_{1}^{1, p}\left(\mathbb{R}^{3}\right)}
$$

ii) If moreover $g \in Z_{q}\left(\mathbb{R}^{3}\right)$ verifying (7.1), with $p$ changed in $q$, then we can choose $\boldsymbol{w} \in \mathbf{X}_{1}^{2, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{X}_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ with the corresponding estimate.

Proof. i) On one hand (cf. [3]), from $g \in W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$ there exists $v \in W_{1}^{3, p}\left(\mathbb{R}^{3}\right)$ verifying

$$
\Delta v=g \text { in } \mathbb{R}^{3}, \quad \text { with } \quad\|\nabla v\|_{\mathbf{w}_{1}^{2, p}\left(\mathbb{R}^{3}\right)} \leq C\|g\|_{W_{1}^{1, p}\left(\mathbb{R}^{3}\right)}
$$

On the other hand (cf. [3]), from $\frac{\partial g}{\partial x_{1}} \in W_{1}^{-1, p}\left(\mathbb{R}^{3}\right) \perp \mathbb{P}_{\left[2-3 / p^{\prime}\right]}$ there exists a unique $z \in W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$ verifying

$$
\Delta z=\frac{\partial g}{\partial x_{1}} \text { in } \mathbb{R}^{3}, \quad \text { with } \quad\|\nabla z\|_{\mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)} \leq C\left\|\frac{\partial g}{\partial x_{1}}\right\|_{W_{1}^{-1, p}\left(\mathbb{R}^{3}\right)}
$$

Then $\frac{\partial v}{\partial x_{1}}-z \in W_{1}^{2, p}\left(\mathbb{R}^{3}\right)+W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$ is harmonic and $\frac{\partial v}{\partial x_{1}}-z \in \mathbb{P}_{[1-3 / p]}$, that means, $\frac{\partial v}{\partial x_{1}}=z$ if $p<3$ and $\frac{\partial v}{\partial x_{1}}-z=$ constant if $p \geq 3$.

Next let us take $\boldsymbol{w}=\nabla v$. Hence $\boldsymbol{w} \in \mathbf{W}_{1}^{2, p}\left(\mathbb{R}^{3}\right)$, div $\boldsymbol{w}=g$ and $\frac{\partial \boldsymbol{w}}{\partial x_{1}}=\nabla\left(\frac{\partial v}{\partial x_{1}}\right)=$ $\nabla z \in \mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)$. Thus we can proceed as in the proof of Lemma 7.1 to conclude i).
ii) Using a similar argument as in i), we can choose $\boldsymbol{w}$ also belonging to $\mathbf{X}_{0}^{1, q}\left(\mathbb{R}^{3}\right)$.

In accordance with Oseen theory, we can prove the following regularity result.
Theorem 7.11. Let $p>3 / 2, q=3 p /(3+p), f \in \mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{W}_{0}^{-1, q}\left(\mathbb{R}^{3}\right)$ satisfy, for all $i=1,2,3$,

$$
\begin{equation*}
\left\langle f_{i}, 1\right\rangle_{W_{0}^{-1, q}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, q^{\prime}}\left(\mathbb{R}^{3}\right)}=0, \quad \text { if } 3 / 2<p \leq 3, \tag{7.16}
\end{equation*}
$$

$g \in X_{1}^{1, p}\left(\mathbb{R}^{3}\right) \cap Z_{q}\left(\mathbb{R}^{3}\right)$ satisfy (7.15) and

$$
\begin{equation*}
\left\langle\frac{\partial g}{\partial x_{1}}, x_{1}\right\rangle_{W_{0}^{-2, q}\left(\mathbb{R}^{3}\right) \times W_{0}^{2, q^{\prime}}\left(\mathbb{R}^{3}\right)}=0, \quad \text { if } q \leq 3 / 2, \tag{7.17}
\end{equation*}
$$

and $\boldsymbol{a} \in \mathbf{H}_{3}$ satisfy (4.6) and (5.4). Then the Oseen problem (1.3) has a unique solution ( $\boldsymbol{u}, \boldsymbol{\pi}$ ) satisfying

$$
\begin{equation*}
u \in \mathbf{X}_{1}^{2, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{X}_{0}^{1, q}\left(\mathbb{R}^{3}\right) ; \quad \pi \in W_{1}^{1, p}\left(\mathbb{R}^{3}\right) \cap L^{q}\left(\mathbb{R}^{3}\right) \tag{7.18}
\end{equation*}
$$

Proof. In order to apply Theorem 7.6, we consider the embedding $\mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right) \hookrightarrow$ $\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$, for $p \neq 3 / 2$. Then there exists a solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ to the Oseen problem (1.3). Thus the assumption (5.4) implies that $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u} \in$ $\mathbf{W}_{1}^{0, p}\left(\mathbb{R}^{3}\right)$.

We can also apply Theorem 7.6 for the existence of a solution $(\boldsymbol{z}, \eta) \in \mathbf{X}_{0}^{1, q}\left(\mathbb{R}^{3}\right) \times$ $L^{q}\left(\mathbb{R}^{3}\right)$ to the Oseen problem (1.3). Since $q=3 p /(3+p)<3$, we get $\boldsymbol{z}=\boldsymbol{u}$ and $\eta=\pi$. Thus we have $(\boldsymbol{a} \cdot \nabla) \boldsymbol{u} \in \mathbf{L}^{3 q /(3+q)}\left(\mathbb{R}^{3}\right) \hookrightarrow \mathbf{W}_{0}^{-1, q}\left(\mathbb{R}^{3}\right)$.

Since $g \in X_{1}^{1, p}\left(\mathbb{R}^{3}\right) \cap Z_{q}\left(\mathbb{R}^{3}\right)$ satisfies (7.15) and (7.17), considering Lemma 7.10 there exists $\boldsymbol{w} \in \mathbf{X}_{1}^{2, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{X}_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ such that $\operatorname{div} \boldsymbol{w}=g$ in $\mathbb{R}^{3}$. Set now $\boldsymbol{v}=\boldsymbol{u}-\boldsymbol{w}$, then $\boldsymbol{v} \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \cap \mathbf{X}_{0}^{1, q}\left(\mathbb{R}^{3}\right)$ and

$$
\begin{equation*}
-\Delta \boldsymbol{v}+k \frac{\partial \boldsymbol{v}}{\partial x_{1}}+\nabla \pi=\boldsymbol{f}-(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}+\Delta \boldsymbol{w}-k \frac{\partial \boldsymbol{w}}{\partial x_{1}}, \quad \operatorname{div} \boldsymbol{v}=0 \text { in } \mathbb{R}^{3} . \tag{7.19}
\end{equation*}
$$

Since the function $\mathbf{F}:=\boldsymbol{f}-(\boldsymbol{a} \cdot \nabla) \boldsymbol{u}+\Delta \boldsymbol{w}-k \frac{\partial \boldsymbol{w}}{\partial x_{1}} \in W_{1}^{0, p}\left(\mathbb{R}^{3}\right) \cap W_{0}^{-1, q}\left(\mathbb{R}^{3}\right)$
satisfies the compatibility conditions, for $3 / 2<p \leq 3$,

$$
\left\langle F_{i}, 1\right\rangle_{W_{1}^{0, p}\left(\mathbb{R}^{3}\right) \times W_{-1}^{0, p^{\prime}\left(\mathbb{R}^{3}\right)}}=\left\langle F_{i}, 1\right\rangle_{W_{0}^{-1, q}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, q^{\prime}}\left(\mathbb{R}^{3}\right)}=0,
$$

then applying the Oseen regularity theory [6, Theorem 2.12] we deduce that $\boldsymbol{v} \in \mathbf{X}_{1}^{2, p}\left(\mathbb{R}^{3}\right)$ and $\pi \in W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$. Then we conclude that $\pi$ and $\boldsymbol{u}=\boldsymbol{v}+\boldsymbol{w}$ satisfy (7.18).

Remark 7.12. The solution $\boldsymbol{u}$ found in Theorem 7.11 also belongs to $\mathbf{L}^{p}\left(\mathbb{R}^{3}\right) \cap$ $\mathbf{L}^{12 p /(12+p)}\left(\mathbb{R}^{3}\right)$. Additionally, if $p<4$ then $\boldsymbol{u} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right)$, and if $p<3$ then $\boldsymbol{u} \in \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$.

## 8 The Oseen problem (1.1) with $a$ not in $\mathrm{L}^{3}\left(\mathbb{R}^{3}\right)$

In this section we study the Oseen model (1.1) case ii). For the sake of simplicity, let us set $k=1$, which means that $\boldsymbol{a} \in \mathbf{L}_{\text {loc }}^{3}\left(\mathbb{R}^{3}\right)$ is such that $\operatorname{div} \boldsymbol{a}=0$ and

$$
\begin{equation*}
\exists R_{0}>0: \quad a(x)=\mathbf{e}_{1}, \quad|x| \geq R_{0}, \tag{8.1}
\end{equation*}
$$

are satisfied.
Theorem 8.1. Let $\boldsymbol{a} \in \mathbf{L}_{\text {loc }}^{3}\left(\mathbb{R}^{3}\right)$ satisfy div $\boldsymbol{a}=0$ and (8.1). For $\boldsymbol{f} \in \mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right)$ and $g \in Z_{2}\left(\mathbb{R}^{3}\right)$, there exists a unique pair $(\boldsymbol{u}, \pi) \in\left(\mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{4}\left(\mathbb{R}^{3}\right)\right) \times$ $L^{2}\left(\mathbb{R}^{3}\right)$ solving (1.1) such that

$$
\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1,2}}+\left\|\frac{\partial \boldsymbol{u}}{\partial x_{1}}\right\|_{\mathbf{W}_{0}^{-1,2}}+\|\pi\|_{L^{2}} \leq C\left(\|\boldsymbol{f}\|_{\mathbf{W}_{0}^{-1,2}}+\left(1+\left\|\boldsymbol{a}-\mathbf{e}_{1}\right\|_{\mathbf{L}^{3}}\right)\|g\|_{Z_{2}}\right) .
$$

Moreover such solution verifies the energy equality (3.11).

Proof. First note that $\operatorname{div}\left(\boldsymbol{a}-\mathbf{e}_{1}\right)=0$ in $\mathbb{R}^{3}$ and $\operatorname{supp}\left(\boldsymbol{a}-\mathbf{e}_{1}\right)$ is a compact set into the ball $B_{R_{0}}$. Then we obtain $\boldsymbol{a}-\mathbf{e}_{1} \in \mathbf{H}_{3}$. We can apply Proposition 7.4 with $k=1$ to the problem

$$
-\Delta \boldsymbol{u}+\frac{\partial \boldsymbol{u}}{\partial x_{1}}+\left(\left(\boldsymbol{a}-\mathbf{e}_{1}\right) \cdot \nabla\right) \boldsymbol{u}+\nabla \pi=\boldsymbol{f}, \quad \operatorname{div} \boldsymbol{u}=g \quad \text { in } \mathbb{R}^{3},
$$

concluding the existence and uniqueness of the required solution to (1.1). Moreover such solution verifies the energy equality (3.11), taking into account that

$$
\left\langle\frac{\partial \boldsymbol{u}}{\partial x_{1}}, \boldsymbol{u}\right\rangle_{\mathbf{W}_{0}^{-1,2}\left(\mathbb{R}^{3}\right) \times \mathbf{W}_{0}^{1,2}\left(\mathbb{R}^{3}\right)}=0 \quad \text { and } \quad \int_{\mathbb{R}^{3}} \nabla \boldsymbol{u}:\left(\boldsymbol{a}-\mathbf{e}_{1}\right) \otimes \boldsymbol{u} d \boldsymbol{x}=0 .
$$

Remark 8.2. The condition $\boldsymbol{a} \in \mathbf{L}^{3}\left(\mathbb{R}^{3}\right)$ is then not necessary to the existence of a solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1,2}\left(\mathbb{R}^{3}\right) \times L^{2}\left(\mathbb{R}^{3}\right)$ of the problem (1.1).

Theorem 8.3. For $1<p<\infty$, let $f \in \mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)$ and $g \in Z_{p}\left(\mathbb{R}^{3}\right)$ verify (4.1) and (7.1), respectively. Let $\boldsymbol{a}$ be as in Theorem 8.1 such that

$$
\begin{equation*}
\left\|\boldsymbol{a}-\mathbf{e}_{1}\right\|_{\mathbf{L}^{3}\left(B_{R_{0}}\right)} \leq K \tag{8.2}
\end{equation*}
$$

where $K$ is the constant introduced in (4.6). Then the Oseen problem (1.1) has a solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ such that
$\|\boldsymbol{u}\|_{\mathbf{W}_{0}^{1, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-4 / p]}}+\left\|\frac{\partial \boldsymbol{u}}{\partial x_{1}}\right\|_{\mathbf{W}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|\pi\|_{L^{p}\left(\mathbb{R}^{3}\right)} \leq C_{K}\left(\|\boldsymbol{f}\|_{\mathbf{w}_{0}^{-1, p}\left(\mathbb{R}^{3}\right)}+\|g\|_{Z_{p}\left(\mathbb{R}^{3}\right)}\right)$
and also that $\boldsymbol{u} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{3 p /(3-p)}\left(\mathbb{R}^{3}\right)$ if $1<p<3, \boldsymbol{u} \in \mathbf{L}^{r}\left(\mathbb{R}^{3}\right)$ for all $r \geq 12$ if $p=3$, and $\boldsymbol{u} \in \mathbf{L}^{4 p /(4-p)}\left(\mathbb{R}^{3}\right) \cap \mathbf{L}^{\infty}\left(\mathbb{R}^{3}\right)$ if $3<p<4$.

Proof. We proceed as in the proof of Theorem 8.1, taking

$$
\mathbf{c}=a-\mathbf{e}_{1} \in \mathbf{H}_{3} .
$$

Next we observe that $\|\mathbf{c}\|_{\mathbf{L}^{3}\left(\mathbb{R}^{3}\right)} \leq K$. Then according to Theorem 7.6 there exists a solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{1, p}\left(\mathbb{R}^{3}\right) \times L^{p}\left(\mathbb{R}^{3}\right)$ to (1.1) which concludes the desired existence result.

Remark 8.4. Similarly to Theorem 7.8 , for $1<p<3$, if $f \in \mathbf{L}^{p}\left(\mathbb{R}^{3}\right), g \in$ $X_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ and $\boldsymbol{a}$ as given at Theorem 8.3, then the Oseen problem (1.1) has a unique solution $(\boldsymbol{u}, \pi) \in \mathbf{X}_{0}^{2, p}\left(\mathbb{R}^{3}\right) \times W_{0}^{1, p}\left(\mathbb{R}^{3}\right)$ as in Theorem 7.8. Analogously to Theorem 7.9.

Remark 8.5. Analogously to Theorem 7.11, for $p>3 / 2, f$ and $g$ under the conditions of Theorem 7.11 and $\boldsymbol{a}$ as given at Theorem 8.3 and satisfy

$$
\exists L>0: \quad \sqrt{\left(a_{1}(\boldsymbol{x})-1\right)^{2}+a_{2}^{2}(\boldsymbol{x})+a_{3}^{2}(\boldsymbol{x})} \leq \frac{L}{|\boldsymbol{x}|}, \quad \text { a.e. } \boldsymbol{x} \in \mathbb{R}^{3}
$$

then the Oseen problem (1.1) has a unique solution $(\boldsymbol{u}, \pi) \in\left(\mathbf{X}_{1}^{2, p}\left(\mathbb{R}^{3}\right) / \mathbb{P}_{[1-4 / p]}\right) \times$ $W_{1}^{1, p}\left(\mathbb{R}^{3}\right)$ as in Theorem 7.11.
