# DECONVOLUTION WITH ESTIMATED CHARACTERISTIC FUNCTION OF THE ERRORS.

#### Abstract

We study the following model of deconvolution $Y=X+\varepsilon$ with i.i.d. observations $Y_{1}, \ldots, Y_{n}$ and $\varepsilon_{-1}, \ldots, \varepsilon_{-M}$. The $\left(X_{j}\right)_{1 \leq j \leq n}$ are i.i.d. with density $f$, independent of the $\varepsilon_{j}$. The aim of the paper is to estimate $f$ without knowing the density $f_{\varepsilon}$ of the $\varepsilon_{j}$. We first define a projection estimator, for which we provide bounds for the pointwise and the integrated $L^{2}$-risk. We consider ordinary smooth and supersmooth noise $\varepsilon$ with regard to ordinary smooth and supersmooth densities $f$. Then we present an adaptive estimator of the density of $f$. This estimator is obtained by penalization of the projection contrast, which provides model selection. Lastly, we present simulation experiments to illustrate the good performances of our estimator and study from the empirical point of view the importance of theoretical constraints.


## 1. Introduction.

1.1. Model. Let us consider the following model:

$$
\begin{equation*}
Y_{j}=X_{j}+\varepsilon_{j} \quad j=1, \ldots, n \tag{1.1}
\end{equation*}
$$

where $\left(X_{j}\right)_{1 \leq j \leq n}$ and $\left(\varepsilon_{j}\right)_{1 \leq j \leq n}$ are independent sequences of i.i.d. variables. We denote by $f$ the density of $X_{j}$ and by $f_{\varepsilon}$ the density of $\varepsilon_{j}$. The aim is to estimate $f$ when only $Y_{1}, \ldots, Y_{n}$ are observed, but, contrary to the classical convolution model, we do not assume that $f_{\varepsilon}$ is known. The knowledge of $f_{\varepsilon}$ is replaced by the observations of $\varepsilon_{-1}, \ldots, \varepsilon_{-M}$, a noise sample with distribution $f_{\varepsilon}$, independent of $\left(Y_{1}, \ldots, Y_{n}\right)$. Note that the availability of two distinct samples makes the problem identifiable.
1.2. Notations and Assumptions. For $z$ a complex number, $\bar{z}$ denotes its conjugate and $|z|$ its modulus. For functions $s, t: \mathbb{R} \mapsto \mathbb{R}$ belonging to $\mathbb{L}^{1} \cap \mathbb{L}^{2}(\mathbb{R})$, we denote by $\|t\|$ the $\mathbb{L}^{2}$ norm of $t$, that is $\|t\|^{2}=\int_{\mathbb{R}}|t(x)|^{2} d x$, and by $\langle s, t\rangle$ the scalar product: $\langle s, t\rangle=\int_{\mathbb{R}} s(x) \overline{t(x)} d x$. The Fourier transform $t^{*}$

[^0]of $t$ is defined by
$$
t^{*}(u)=\int e^{-i x u} t(x) d x
$$

Note that, if $t^{*}$ also belongs to $\mathbb{L}^{1} \cap \mathbb{L}^{2}(\mathbb{R})$, then the function $t$ is the inverse Fourier transform of $t^{*}$ and can be written $t(x)=1 /(2 \pi) \int e^{i x u} t^{*}(u) d u$.

Now the classical assumptions on the model are one or two of the following:
(A1) $\forall x \in \mathbb{R}, f_{\varepsilon}^{*}(x) \neq 0$.
(A2) There exist $s \geq 0, b>0, \gamma \in \mathbb{R}(\gamma>0$ if $s=0)$ and $k_{0}, k_{1}>0$ such that

$$
k_{0}\left(x^{2}+1\right)^{-\gamma / 2} \exp \left(-b|x|^{s}\right) \leq\left|f_{\varepsilon}^{*}(x)\right| \leq k_{1}\left(x^{2}+1\right)^{-\gamma / 2} \exp \left(-b|x|^{s}\right)
$$

Moreover, the distribution function $f$ to estimate can often belong to the following type of smoothness spaces:
$(1.2) \mathcal{A}_{\delta, r, a}(l)=\left\{f\right.$ density on $\mathbb{R}$ and $\left.\int\left|f^{*}(x)\right|^{2}\left(x^{2}+1\right)^{\delta} \exp \left(2 a|x|^{r}\right) d x \leq l\right\}$ with $r \geq 0, a>0, \quad \delta \in \mathbb{R}$ and $\delta>1 / 2$ if $r=0, l>0$.

When $r>0$, the function $f$ is known as supersmooth, and as ordinary smooth otherwise. In the same way, the noise distribution is called ordinary smooth if $s=0$ and supersmooth otherwise. The spaces of ordinary smooth functions correspond to classic Sobolev classes, while supersmooth functions are infinitely differentiable. It includes for example normal $(r=2)$ and Cauchy $(r=1)$ densities. We take the convention $(a, r)=(0,0)$ if $a=0$ or $r=0$ and $(b, s)=(0,0)$ if $b=0$ or $s=0$.
1.3. Bibliographical context. There exists a huge literature concerning the estimation of $f$ when $f_{\varepsilon}$ is known, which we do not detail here. Several authors have studied the exact problem which is considered in this paper, but only for particular type of smoothness for $f_{\varepsilon}$ or $f$ or other type of risks. In this regard, we provide the first study of pointwise mean square risk (MSE), and then we substantially generalize existing results. For that purpose, we use a projection estimator. In fact, we propose a collection of estimators, depending on a bandwidth-type parameter. Moreover, we also consider the difficult problem of automatic selection of a relevant estimator in the collection: the study of an adaptive procedure in this context is essentially new.

Let us describe what has been done on the subject.

- Diggle and Hall [8] consider the same model and obtain result of the same type of our first Proposition (see Proposition 3.2). But then, they study the case of ordinary smooth noise and distribution function under $M \geq n$.
- We may mention the work by Efromovich [9], but his context is slightly different, since he considers circular data. He assumes that the noise is supersmooth and the distribution function ordinary smooth. In this context, he proposes a data driven choice of $M$ to make his estimator adaptive.
- Our work is more related to the paper of Neumann [14], since our estimator is rather equivalent to his and we borrow a useful Lemma from his work. He mainly considers the case of both ordinary smooth noise and distribution function. He does not perform any bandwidth selection, but he proves the minimax optimality of the bound he obtains in the case he considers. We shall of course refer to this lower bound.
- Meister [13] takes a rather different point of view, compared to our problem: he studies what happens when the function $f_{\varepsilon}^{*}$ used for estimation is not the true one. For instance, he shows that it is safer to use an ordinary smooth noise characteristic function, if it is unknown.
- Lastly, Johannes [11] recently studied the density deconvolution with unknown (but observed) noise and he is interested in the relation between $M$ and $n$. Note that his estimator and his approach are very interesting and rather different from ours, his estimator depends on two bandwidth-type parameters, which, if relevantly chosen, lead to rate that are the same as in our work. But the data-driven selection of these bandwidths is not done.

Here is the plan of the present paper. In Section 2, we give the notations and define first a projection-type estimator. We study in Section 3 both the pointwise and the integrated mean square risk (MSE and MISE) of the projection estimator, which allows to build general tables for the rates in both cases. Then, we study the link between $M$ and $n$ if one wants to preserve the rate found in the case where $f_{\varepsilon}^{*}$ is known. Such a complete panorama is new in this setting. Next, we define and study in Section 4 an adaptive estimator by proposing a penalization device. A general integrated risk bound for the resulting estimator is given. The estimator is studied through simulation experiments, and its performances are compared with Neumann [14]'s and Johannes [11]'s ones. The influence of the size $M$ of the noise sample is studied as well as the importance of some other theoretical constraints on the size of the collection of models. Most proofs are gathered in Section 6.
2. Estimation procedure. All estimators defined here are projection estimators. We therefore start with describing the projection spaces.
2.1. Projection spaces. Let us consider the function

$$
\varphi(x)=\sin (\pi x) /(\pi x)
$$

and, for $m$ in $\mathbb{N}^{*}, j$ in $\mathbb{Z}, \varphi_{m, j}(x)=\sqrt{m} \varphi(m x-j)$.
As $\varphi^{*}(x)=\mathbb{1}_{[-\pi, \pi]}(x)$, we have, as a key property of the functions $\varphi_{m, j}$, that $\varphi_{m, j}^{*}(x)=e^{-i x j / m} \mathbb{1}_{[-\pi m, \pi m]}(x) / \sqrt{m}$. Note that $\left\{\varphi_{m, j}\right\}_{j \in \mathbb{Z}}$ is an orthonormal basis of the space of integrable functions having a Fourier transform with compact support included into $[-\pi m, \pi m]$. Note that $m$ can be chosen in other sets than $\mathbb{N}^{*}$, and thinner grids may be useful in practice.

In the sequel, we use the following notation:

$$
S_{m}=\operatorname{Span}\left\{\varphi_{m, j}\right\}_{j \in \mathbb{Z}} .
$$

We know (see Comte et al. [6]) that the orthogonal projection of a function $g$ in $\left(\mathbb{L}^{1} \cap \mathbb{L}^{2}\right)(\mathbb{R})$ on $S_{m}$, denoted by $g_{m}$, is such that $g_{m}^{*}=g^{*} \mathbb{1}_{[-\pi m, \pi m]}$, i.e. with Fourier inverse formula:

$$
\begin{equation*}
g_{m}(x)=\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u} g^{*}(u) d u . \tag{2.1}
\end{equation*}
$$

This explains the order of bias terms in the following.
2.2. Estimation of $f$ for the classical deconvolution problem. We want to estimate $f$, the density of the $X_{j}$ in model (1.1). When $f_{\varepsilon}$ is known, we can estimate $f$ by minimizing a contrast built as follows. A standard contrast in density estimation is $(1 / n) \sum_{j}\left[\|t\|^{2}-2 t\left(X_{j}\right)\right]$. It is not possible to use this contrast in the convolution model because we do not observe $X_{1}, \ldots, X_{n}$. Only the noisy data $Y_{j}$ are available. The solution is given by exploiting the following lemma.

Lemma 2.1. For any function $t$, let $v_{t}$ be the inverse Fourier transform of $t^{*} / f_{\varepsilon}^{*}(-$.$) , i.e.$

$$
v_{t}(x)=\frac{1}{2 \pi} \int e^{i x u} \frac{t^{*}(u)}{f_{\varepsilon}^{*}(-u)} d u .
$$

Then, for all $1 \leq j \leq n$,

1. $\mathbb{E}\left[v_{t}\left(Y_{j}\right) \mid X_{j}\right]=t\left(X_{j}\right)$
2. $\mathbb{E}\left[v_{t}\left(Y_{j}\right)\right]=\mathbb{E}\left[t\left(X_{j}\right)\right]$

The second assertion in Lemma 2.1 is an obvious consequence of the first one and leads us to consider the following contrast:

$$
\begin{aligned}
& \qquad \gamma_{n}^{0}(t)=\frac{1}{n} \sum_{j=1}^{n}\left[\|t\|^{2}-2 v_{t}\left(Y_{j}\right)\right] \quad \text { with } \quad v_{t}^{*}(u)=\frac{t^{*}(u)}{f_{\varepsilon}^{*}(-u)} \\

\end{aligned}
$$

Indeed, since $t\left(X_{j}\right)$ and $v_{t}\left(Y_{j}\right)$ have the same expectation, it is natural to replace the unknown quantity $t\left(X_{j}\right)$ in the contrast by $v_{t}\left(Y_{j}\right)$. We can observe that

$$
\begin{aligned}
\mathbb{E} \gamma_{n}^{0}(t) & =(1 / n) \sum_{j=1}^{n}\left[\|t\|^{2}-2 \mathbb{E}\left[v_{t}\left(Y_{j}\right)\right]\right]=(1 / n) \sum_{j=1}^{n}\left[\|t\|^{2}-2 \mathbb{E}\left[t\left(X_{j}\right)\right]\right] \\
& =\|t\|^{2}-2 \int t f=\|t-f\|^{2}-\|f\|^{2}
\end{aligned}
$$

This contrast is used in Comte et al. [6].
2.3. Estimation of $f$ if the distribution of $\varepsilon$ is unknown. Now, $f_{\varepsilon}^{*}$ is unknown and we have to estimate it. We define first

$$
\hat{f}_{\varepsilon}^{*}(x)=\frac{1}{M} \sum_{j=1}^{M} e^{-i x \varepsilon_{-j}}
$$

the natural estimator of $f_{\varepsilon}^{*}$ and next, we introduce as in Neumann [14] the truncated estimator:

$$
\frac{1}{\tilde{f}_{\varepsilon}^{*}(x)}=\frac{\mathbb{1}_{\left\{\left|\hat{f}_{\varepsilon}^{\hat{f}_{\varepsilon}}(x)\right| \geq M^{-1 / 2}\right\}}}{\hat{f}_{\varepsilon}^{*}(x)}= \begin{cases}\frac{1}{\hat{f}_{\varepsilon}^{*}(x)} & \text { if }\left|\hat{f}_{\varepsilon}^{*}(x)\right| \geq M^{-1 / 2} \\ 0 & \text { otherwise }\end{cases}
$$

Therefore, we shall study in the following the new contrast

$$
\begin{equation*}
\gamma_{n}(t)=\frac{1}{n} \sum_{j=1}^{n}\left[\|t\|^{2}-2 \tilde{v}_{t}\left(Y_{j}\right)\right] \quad \text { with } \quad \tilde{v}_{t}^{*}(u)=\frac{t^{*}(u)}{\tilde{f}_{\varepsilon}^{*}(-u)} . \tag{2.2}
\end{equation*}
$$

We define our estimators by minimizing this contrast on the projection spaces $S_{m}$ :

$$
\begin{equation*}
\hat{f}_{m}=\arg \min _{t \in S_{m}} \gamma_{n}(t) \tag{2.3}
\end{equation*}
$$

or, equivalently,

$$
\begin{equation*}
\hat{f}_{m}=\sum_{l \in \mathbb{Z}} \hat{a}_{m, l} \varphi_{m, l} \quad \text { with } \quad \hat{a}_{m, l}=\frac{1}{n} \sum_{j=1}^{n} \tilde{v}_{\varphi_{m, l}}\left(Y_{j}\right) \tag{2.4}
\end{equation*}
$$

It is sufficient to differentiate the contrast (2.2) to obtain formula (2.4). Actually, we should define $\hat{f}_{m}=\sum_{|l|<K_{n}} \hat{a}_{m l} \varphi_{m, l}$ because we can estimate only a finite number of coefficients. If $\bar{K}_{n}$ is suitably chosen, it does not change the rate of convergence since the additional terms can be made negligible.

For the sake of simplicity, we let the sum over $\mathbb{Z}$. For an example of detailed truncation see Comte et al. [6].

We can also mention that the following formula is available for our estimator. Let us denote by

$$
\hat{f_{Y}^{*}}(u)=\frac{1}{n} \sum_{j=1}^{n} e^{-i u Y_{j}}
$$

the estimator of $f_{Y}^{*}$, the characteristic function of $Y$. Then we have

$$
\begin{equation*}
\hat{f}_{m}(x)=\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u} \frac{\hat{f}_{Y}^{*}(u)}{\tilde{f}_{\varepsilon}^{*}(u)} d u \tag{2.5}
\end{equation*}
$$

It means that $\left(\hat{f}_{m}\right)^{*}=\left(\hat{f_{Y}^{*}} / \tilde{f}_{\varepsilon}^{*}\right) \mathbb{1}_{[-\pi m, \pi m]}$ which is intuitive since $f^{*}=f_{Y}^{*} / f_{\varepsilon}^{*}$. This comes from (2.4) and the following equalities:

\begin{aligned}
\hat{f}_{m}(x) & =\sum_{l \in \mathbb{Z}} \frac{1}{n} \sum_{j=1}^{n} \tilde{v}_{\varphi_{m, l}}\left(Y_{j}\right) \varphi_{m, l}(x)=\frac{1}{2 \pi} \sum_{l \in \mathbb{Z}}\left(\int \hat{f_{Y}^{*}}(-u) \frac{\varphi_{m, l}^{*}(u)}{\tilde{f}_{\varepsilon}(-u)} d u\right) \varphi_{m, l}(x) \\
(2.6) & =\frac{1}{2 \pi} \sum_{l \in \mathbb{Z}}\left\langle\frac{\hat{f_{Y}^{*}}}{\tilde{f}_{\varepsilon}^{*}}, \varphi_{m, l}^{*}\right\rangle \varphi_{m, l}(x)=\frac{1}{2 \pi} \sum_{l \in \mathbb{Z}}\left\langle\left(\frac{\hat{f_{Y}^{*}}}{\tilde{f}_{\varepsilon}^{*}}\right)^{*}(-.), \varphi_{m, l}\right\rangle \varphi_{m, l}(x)
\end{aligned}
$$

This is the expression of the orthogonal projection on $S_{m}$ of $(1 / 2 \pi)\left(\hat{f}_{Y}^{*} / \tilde{f}_{\varepsilon}^{*}\right)^{*}(-$.$) .$ Using (2.1) and (2.6) yields (2.5).

## 3. Bound on the $L^{2}$ risk.

3.1. Notations. Let us recall first the following key lemma, proved in Neumann [14] for $p=1$ :

Lemma 3.1. Let $p \geq 1$ be an integer and

$$
R(x)=\left(\frac{1}{\tilde{f}_{\varepsilon}^{*}(x)}-\frac{1}{f_{\varepsilon}^{*}(x)}\right)
$$

Then there exists a positive constant $C_{p}$ such that

$$
\mathbb{E} \left\lvert\,\left[\left.R(x)\right|^{2 p}\right] \leq C_{p}\left(\frac{1}{\left|f_{\varepsilon}^{*}(x)\right|^{2 p}} \wedge \frac{M^{-p}}{\left|f_{\varepsilon}^{*}(x)\right|^{4 p}}\right)\right.
$$

The extension from $p=1$ to any integer $p$ is straightforward and therefore the proof is omitted.

Moreover, we introduce the notations

$$
\begin{equation*}
\Delta(m)=\frac{1}{2 \pi} \int_{-\pi m}^{\pi m}\left|f_{\varepsilon}^{*}(u)\right|^{-2} d u, \Delta^{0}(m)=\frac{1}{2 \pi}\left(\int_{-\pi m}^{\pi m}\left|f_{\varepsilon}^{*}(u)\right|^{-1} d u\right)^{2} \tag{3.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\Delta_{f}(m)=\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} \frac{\left|f^{*}(u)\right|^{2}}{\left|f_{\varepsilon}^{*}(u)\right|^{2}} d u, \Delta_{f}^{0}(m)=\frac{1}{2 \pi}\left(\int_{-\pi m}^{\pi m} \frac{\left|f^{*}(u)\right|}{\left|f_{\varepsilon}^{*}(u)\right|} d u\right)^{2} . \tag{3.2}
\end{equation*}
$$

As we shall see, these quantities are involved in the bounds on the variance of our estimators.
3.2. Pointwise mean square risk. First, we study quickly the so-called MSE, the pointwise mean square error of the estimator. Let us denote by $f_{m}$ the orthogonal projection of $f$ on $S_{m}$. Then we have the following decomposition:

\begin{aligned}
\mathbb{E}\left[\left(\hat{f}_{m}(x)-f(x)\right)^{2}\right] \leq & 2\left(f_{m}(x)-f(x)\right)^{2}+2 \mathbb{E}\left[\left(\hat{f}_{m}(x)-f_{m}(x)\right)^{2}\right] \\
\leq & 2\left(f_{m}(x)-f(x)\right)^{2}+4 \operatorname{Var}\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u} \frac{\hat{f_{Y}^{*}}(u)}{f_{\varepsilon}^{*}(-u)} d u\right) \\
& +4 \mathbb{E}\left[\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u} \hat{f_{Y}^{*}}(u) R(u) d u\right)^{2}\right]
\end{aligned}
$$

The first (squared bias term) and second (variance term) terms of the right-hand-side of (3.3) are the usual ones, and are also found when $f_{\varepsilon}^{*}$ is known; they are studied in Butucea and Comte [3]. The last one is studied by analogous methods and Lemma 3.1, and is specific to the present context. We find that the following risk bound holds:

Proposition 3.1. Consider model (1.1) under (A1), then $\hat{f}_{m}$ defined by (2.3) satisfies:

$$
\begin{aligned}
\mathbb{E}\left[\left(\hat{f}_{m}(x)-f(x)\right)^{2}\right] \leq & 2\left(\frac{1}{2 \pi} \int_{|t| \geq \pi m}\left|f^{*}(t)\right| d t\right)^{2} \\
& +\frac{C}{n} \inf \left(\int\left|f_{Y}^{*}\right| \Delta(m), \Delta^{0}(m)\right)+C^{\prime} \frac{\Delta_{f}^{0}(m)}{M}
\end{aligned}
$$

It follows that, as $f$ belongs to $\mathbb{L}^{2}(\mathbb{R})$, if $\int\left|f_{Y}^{*}\right|<+\infty$ and $M \geq n$, then the risk bound obtained in Proposition 3.1 is the same as the one we get when $f_{\varepsilon}^{*}$ is known. Indeed,

$$
\Delta_{f}^{0}(m) \leq\|f\|^{2} \Delta(m) \text { and } \Delta_{f}^{0}(m) \leq \Delta^{0}(m) .
$$

This is summarized by the Corollary:

Corollary 3.1. Consider model (1.1) under (A1). Assume moreover that $\int\left|f_{Y}^{*}\right|<+\infty$ and $M \geq n$. Then $\hat{f}_{m}$ defined by (2.3) satisfies:

$$
\begin{equation*}
\mathbb{E}\left[\left(\hat{f}_{m}(x)-f(x)\right)^{2}\right] \leq 2\left(\frac{1}{2 \pi} \int_{|t| \geq \pi m}\left|f^{*}(t)\right| d t\right)^{2}+\frac{K}{n} \inf \left(\Delta(m), \Delta^{0}(m)\right) \tag{3.4}
\end{equation*}
$$

where $K$ is a constant depending on $\int\left|f_{Y}^{*}\right|$ and $\|f\|$.
Remark. If $f_{\varepsilon}^{*}$ satisfies (A2) and $f$ belongs to $\mathcal{A}_{\delta, r, a}(l)$ as defined in (1.2), then

$$
\left(\int\left|f_{Y}^{*}\right|\right)^{2}=\left(\int\left|f_{\varepsilon}^{*} f^{*}\right|\right)^{2} \leq k_{1}^{2} l \int\left(x^{2}+1\right)^{-(\gamma+\delta)} \exp \left(-2 b|x|^{s}-2 a|x|^{r}\right) d x .
$$

Thus definition (1.2) implies that $\int\left|f_{Y}^{*}\right|<+\infty$.

The optimality (minimaxity) of the rates resulting from (3.4) for known $f_{\varepsilon}^{*}$, when $f_{\varepsilon}^{*}$ satisfies (A2) and $f$ belongs to $\mathcal{A}_{\delta, r, a}(l)$, has been studied in Fan [10], Butucea [2] and Butucea and Tsybakov [5].

More generally, we can see that, if $f_{\varepsilon}^{*}$ satisfies (A2) and if $f \in \mathcal{A}_{\delta, r, a}(l)$ :

$$
\Delta_{f}^{0}(m) \leq \frac{l}{2 \pi k_{0}^{2}} \int_{-\pi m}^{\pi m}\left(x^{2}+1\right)^{\gamma-\delta} \exp \left(2 b|x|^{s}-2 a|x|^{r}\right) d x
$$

Now, we can combine the rates related to $M$ with standard pointwise rates (see Table 1 in Lacour [12] or Table 2 in Butucea and Comte [3]) and we obtain the Table 2 here.

We discuss the case $r>0, s>0$ for the integrated risk only, and thus omit this part of the study here. The principle would be the same, with slightly different orders. See also Lacour [12].
3.3. Bound on the MISE. We shall study in more detail the integrated mean square risk, which is slightly simpler. Indeed now, by Pythagoras theorem, we have

Moreover, writing $\hat{f}_{m}-f_{m}$ according to (2.1) and (2.5) and applying the Parseval formula, we obtain

\left\|f_{m}-\hat{f}_{m}\right\|^{2}=\frac{1}{2 \pi} \int_{-\pi m}^{\pi m}\left|\frac{\hat{f}_{Y}^{*}(u)}{\tilde{f}_{\varepsilon}^{*}(u)}-\frac{f_{Y}^{*}(u)}{f_{\varepsilon}^{*}(u)}\right|^{2} d u .
$$

It follows that

\left\|f_{m}-\hat{f}_{m}\right\|^{2} \leq \frac{1}{\pi} \int_{-\pi m}^{\pi m}\left|\hat{f_{Y}^{*}}(u)\right|^{2}|R(u)|^{2} d u+\frac{1}{\pi} \int_{-\pi m}^{\pi m} \frac{\left|\hat{f_{Y}^{*}}(u)-f_{Y}^{*}(u)\right|^{2}}{\left|f_{\varepsilon}^{*}(u)\right|^{2}} d u . \tag{3.6}
\end{equation*}
$$

The last term of the right-hand-side of (3.6) is the usual term that is found when $f_{\varepsilon}^{*}$ is known, and the first one is specific to the present framework.

We can prove the following result:
Proposition 3.2. Consider model (1.1) under (A1), then $\hat{f}_{m}$ defined by (2.3) satisfies:

with $C$ and $C^{\prime}$ numerical constants.
The first two terms in the right-hand-side of (3.7) are the usual terms when $f_{\varepsilon}^{*}$ is known (see Comte et al. [6]) and correspond to the bias and the variance term. The last term $\Delta_{f}(m) / M$ is due to the estimation of $f_{\varepsilon}^{*}$.

Remark. As $\left|f^{*}(x)\right| \leq 1$, we have $\Delta_{f}(m) \leq \Delta(m)$. It follows that for any $M \geq n$, then $\mathbb{E}\left\|\hat{f}_{m}-f\right\|^{2} \leq\left\|f_{m}-f\right\|^{2}+C \Delta(m) / n$ and we recover the usual risk bound for deconvolution estimation when $f_{\varepsilon}^{*}$ is known. Therefore, in all cases, the condition $M \geq n$ ensures that the rate of the estimator is the same as when $f_{\varepsilon}^{*}$ was known.
3.4. Discussion about the resulting rates. In this section, we assume that $f_{\varepsilon}^{*}$ satisfies Assumption (A2), with parameters $\gamma, b, s$ and that the unknown function $f$ belongs to a smoothness class $\mathcal{A}_{\delta, r, a}(l)$ given by (1.2). It is then possible to evaluate orders for the different terms involved in the bound (3.7).

Since $f_{m}^{*}=f^{*} \mathbb{1}_{[-\pi m, \pi m]}$, the biais term can be bounded in the following way

The other terms are evaluated in the following lemma proved in Section 6.
Lemma 3.2. If $f_{\varepsilon}^{*}$ satisfies Assumption (A2) then
(1) $\Delta(m) \lesssim(\pi m)^{2 \gamma+1-s} e^{2 b(\pi m)^{s}}$,
(2) $\Delta_{f}(m) \lesssim(\pi m)^{(1+2 \gamma-s) \wedge 2(\gamma-\delta)+} e^{2 b(\pi m)^{s}} 1_{\{s>r\}}$

$$
+(\pi m)^{2(\gamma-\delta)+} e^{2(b-a)(\pi m)^{s}} \mathbb{1}_{\{r=s, b \geq a\}}+\mathbb{1}_{\{r>s\} \cup\{r=s, b<a\}} .
$$

Now distinguishing the different cases, we can state the following propositions.

Proposition 3.3. Assume that (A2) holds and that $f \in \mathcal{A}_{\delta, r, a}(l)$ given by (1.2). If $s=0$ (ordinary smooth noise) and $r=0$ (ordinary smooth function f), then

\mathbb{E}\left\|\hat{f}_{m}-f\right\|^{2} \leq C_{0} m^{-2 \delta}+C \frac{m^{2 \gamma+1}}{n}+C^{\prime} \frac{m^{2(\gamma-\delta)_{+}}}{M}
$$

where $C_{0}, C$ and $C^{\prime}$ are constants which do not depend on $M$ nor $n$.
It is known from Fan [10], that the optimal minimax rate when $f_{\varepsilon}^{*}$ is known is $n^{\frac{-2 \delta}{2 \gamma+2 \delta+1}}$. It is preserved with unknown $f_{\varepsilon}^{*}$ as soon as $M \geq n^{\frac{2(\gamma \gamma \delta)}{2 \gamma+2 \delta+1}}$. This bound is tighter than $M \geq n$.
 part. We obtain

$$
\mathbb{E}\left\|\hat{f}_{m_{0}}-f\right\|^{2}=O\left(n^{-\frac{2 \delta}{2 \gamma+2 \delta+1}}+M^{-(1 \wedge(\delta / \gamma))}\right)
$$

This is the lower bound proved by Neumann [14], and thus the rate of our estimator is the optimal rate.

Proposition 3.4. Assume that (A2) holds and that $f \in \mathcal{A}_{\delta, r, a}(l)$ given by (1.2). If $s>0$ (supersmooth noise) and $r=0$ (ordinary smooth function $f$ ), then
$\mathbb{E}\left\|\hat{f}_{m}-f\right\|^{2} \leq C_{0} m^{-2 \delta}+C \frac{m^{2 \gamma+1-s} e^{2 b(\pi m)^{s}}}{n}+C^{\prime} \frac{m^{(1+2 \gamma-s) \wedge 2(\gamma-\delta)+} e^{2 b(\pi m)^{s}}}{M}$, where $C_{0}, C$ and $C^{\prime}$ are constants which do not depend on $M$ nor $n$.

For known $f_{\varepsilon}^{*}$, Fan [10] proves that the optimal rate is of order $(\log n)^{-\frac{2 \delta}{s}}$. It is preserved here with unknown $f_{\varepsilon}^{*}$ as soon as $M \geq n(\log n)^{-\frac{s+[2(\delta \wedge \gamma)+1-s]_{+}}{s}}$.

Choose
$m_{0}=\operatorname{Int}\left[(1 / \pi)\left(\frac{1}{2 b} \log \left[n(\log n)^{-\frac{2 \delta+2 \gamma+1}{s}} \wedge M(\log M)^{-\frac{2 \delta+s+(1+2 \gamma-s) \wedge 2(\gamma-\delta)+}{s}}\right]\right)^{1 / s}\right]$.
This yields

\mathbb{E}\left\|\hat{f}_{m_{0}}-f\right\|^{2}=O\left((\log n)^{\frac{-2 \delta}{s}}+(\log M)^{\frac{-2 \delta}{s}}\right) .
$$

Proposition 3.5. Assume that (A2) holds and that $f \in \mathcal{A}_{\delta, r, a}(l)$ given by (1.2). If $s=0$ (ordinary smooth noise) and $r>0$ (supersmooth function f), then

\mathbb{E}\left\|\hat{f}_{m}-f\right\|^{2} \leq C_{0} m^{-2 \delta} e^{-2 a(\pi m)^{r}}+C \frac{m^{2 \gamma+1}}{n}+\frac{C^{\prime}}{M}
$$

where $C_{0}, C$ and $C^{\prime}$ are constants which do not depend on $M$ nor $n$.
The optimal rate in this case is studied by Butucea [2] when $f_{\varepsilon}^{*}$ is known and is of order $(\log n)^{\frac{2 \gamma+1}{r}} / n$. It is preserved even when $f_{\varepsilon}^{*}$ is estimated, if the sample size for estimating it, $M$, is such that $M \geq n(\log n)^{-\frac{2 \gamma+1}{r}}$.
Let us choose now $m_{0}=\operatorname{Int}\left[(1 / \pi)\left(\frac{1}{2 a} \log \left[n(\log n)^{\frac{r-2 \delta-2 \gamma-1}{r}} \wedge M(\log M)^{\frac{-2 \delta}{r}}\right]\right)^{1 / r}\right]$. We get

\mathbb{E}\left\|\hat{f}_{m_{0}}-f\right\|^{2}=O\left(\frac{(\log n)^{\frac{2 \gamma+1}{r}}}{n}+\frac{1}{M}\right)
$$

This is summarized in Table 2.

The last case, when both functions are supersmooth, is much more tedious, in particular if one wants to evaluate the rates. These are implicitly given in Butucea and Tsybakov [5], who also study optimality; explicit formulae are available in Lacour [12], see Theorem 3.1 therein.

Proposition 3.6. Assume that (A2) holds and that $f \in \mathcal{A}_{\delta, r, a}(l)$ given by (1.2). If $s>0$ (supersmooth noise) and $r>0$ (supersmooth function $f$ ), then

\mathbb{E}\left\|\hat{f}_{m}-f\right\|^{2} \leq C_{0} m^{-2 \delta} e^{-2 a(\pi m)^{r}}+C \frac{m^{2 \gamma+1-s} e^{2 b(\pi m)^{s}}}{n}+C^{\prime} \frac{\Delta_{f}(m)}{M},
$$

where $C_{0}, C$ and $C^{\prime}$ are constants which do not depend on $M$ nor $n$.
Case $r=s$. We define $\xi=[2 b \delta-a(2 \gamma+1-s)] /[(a+b) s]$ and $\omega=[2(b-a) \delta-$ $\left.2 a(\gamma-\delta)_{+}\right] /[b s]$ if $b \geq a, \omega=0$ if $b<a$. It follows from Theorem 3.1 in Lacour [12] that

\text { for } \pi m_{0}=\operatorname{Int}\left[\left(\frac{\log (n)-(\alpha / s) \log \log (n)}{2 a+2 b}\right)^{1 / s} \wedge\left(\frac{\log (M)-(\beta / s) \log \log (M)}{2(a \vee b)}\right)^{1 / s}\right] \text { where } \\
\alpha=2 \delta+2 \gamma+1-s \text { and } \beta=2 \delta+2(\gamma-\delta)_{+} \mathbb{1}_{b \geq a}
\end{gathered}
$$

Case $r<s$. We define $k=\left\lceil(s / r-1)^{-1}\right\rceil-1$, where $\lceil$.$\rceil is the ceiling function$ (i.e. $\lceil x\rceil$ is the smallest integer larger than or equal to $x$ ). There exist coefficients $b_{i}$ recursively defined (see Theorem 3.1 in Lacour [12]) and a choice $m_{0}$ such that

& \left.+(\log M)^{-2 \delta / s} \exp \left[\sum_{i=0}^{k} b_{i}(\log M)^{(i+1) r / s-i}\right]\right)

Case $r>s$. We define $k=\left\lceil(r / s-1)^{-1}\right\rceil-1$. There exist coefficients $d_{i}$ recursively defined (see Theorem 3.1 in Lacour [12]) and a choice $m_{0}$ such that

3.5. A remark about lower bounds for the additional problem of estimating $f_{\varepsilon}$.. As mentioned above, Neumann [14] studied only one particular case from the lower bound point of view. But his proofs (for the additionnal problem of estimating $f_{\varepsilon}$ ) can be checked to be suitable in other cases. The following proposition establishes the optimality of our estimator with respect ot both risks in the cases where $f$ is smoother than $f_{\varepsilon}$ and $r \leq 1$.

Proposition 3.7. Let
$\mathcal{F}_{\gamma, b, s}=\left\{f_{\varepsilon}\right.$ density such that there exist $k_{0}, k_{1}>0$ such that

If $r=s=0$ and $\gamma<\delta-1 / 2$, or if $0 \leq s<r \leq 1$ then

$$
\begin{array}{r}
\inf _{\hat{f}} \sup _{f \in \mathcal{A}_{\delta, a, r}(l), f_{\varepsilon} \in \mathcal{F}_{\gamma, b, s}} \mathbb{E}\|\hat{f}-f\|_{2}^{2} \geq C M^{-1} \\
\inf _{\hat{f}} \sup _{f \in \mathcal{A}_{\delta, a, r}(l), f_{\varepsilon} \in \mathcal{F}_{\gamma, b, s}} \mathbb{E}|\hat{f}(x)-f(x)|^{2} \geq C M^{-1}
\end{array}
$$

Proof of Proposition 3.7. The proof of the lower bound (for the additional problem of estimating $f_{\varepsilon}$ ) given by Neumann [14] can be used for the study of the pointwise risk. Indeed it suffices to use the same hypothesis functions $f_{X, N, 1}$ and $f_{X, N, 2}$ shifted at point $x$ and to compute the distance $\mid f_{X, N, 1}(0)-$ $\left.f_{X, N, 2}(0)\right|^{2}$. These functions have been adjusted to deal with the integrated risk but in the case where the two risks have the same order, they can suit. Thus, if $r=s=0$ and $\gamma<\delta-1 / 2$, we obtain a lower bound $C M^{-1}$ which proves the optimality of our estimator in this case.

In addition, this result can be generalized to a supersmooth noise distribution if $s \leq 1$. Indeed, such densities verify the property (3.1) used by Neumann [14]. In the same way, an extension to supersmooth functions $f$ can be done provided that $r \leq 1$. Thus, if $0 \leq s<r \leq 1$, the rate of convergence $M^{-1}$ of our estimator is optimal for both the integrated and the pointwise risk.
4. Adaptation. The above study shows that the choice of $m$ is both crucial and difficult. Thus, we provide a data driven strategy to perform automatically this choice. We assume that we are in case $M \geq n$, so that our aim is to preserve here the rate corresponding to the case where $f_{\varepsilon}^{*}$ is known.

To complete the estimation procedure, we choose the best estimator among the collection $\left(\hat{f}_{m}\right)_{m \in \mathcal{M}_{n}}$. To do this, we select the model which minimizes the following penalized criterion. Let

$$

\hat{m}=\underset{m \in \mathcal{M}_{n}}{\arg \min }\left\{\gamma_{n}\left(\hat{f}_{m}\right)+\operatorname{pen}(m)\right\} \tag{4.1}
\end{equation*}
$$

where pen is a penalty term to be specified later. Finally, we consider $\hat{f}_{\hat{m}}$ as estimator of the density.

We will work under Assumption (A2) and the following one, concerning the collection of models $\mathcal{M}_{n}=\left\{1,2, \ldots, m_{n}\right\}$ :
(A3) $\exists \alpha \in] 0,1[, \beta \in] 0,1 / 2\left[,\left(\pi m_{n}\right)^{2 \gamma} e^{2 b\left(\pi m_{n}\right)^{s}} \lesssim M^{1-\alpha}, n \lesssim M \lesssim \exp \left(n^{1 / 2-\beta}\right)\right.$.
The first Inequality in (A3) together with (A2) implies that

$$
\forall x \in\left[-\pi m_{n}, \pi m_{n}\right],\left|f_{\varepsilon}^{*}\left(m_{n}\right)\right|^{-2} \lesssim M^{1-\alpha}
$$

If we choose $M=n$, we can see that Assumption (A3) is ensured if pen(.) is bounded over $\mathcal{M}_{n}$ in the case $b=s=0$ (that is if $\pi m_{n} \leq n^{1 /(2 \gamma+1)}$ ) and if $\pi m_{n} \leq(\log (n) /(2 b+1))^{1 / s}$ for $b>0, s>0$.

Clearly, it is difficult to choose $\mathcal{M}_{n}$ and thus $m_{n}$ so that (A3) is fulfilled. This is a problem in the practical procedure which requires an explicit upper bound $m_{n}$ of $\mathcal{M}_{n}$. Diggle and Hall [8] suggest that regression methods applied to $\log \left(\left|\hat{f}_{\varepsilon}^{*}\right|\right)$ may deliver some estimates of the parameter $\gamma$ in the ordinary smooth case. An estimator of $s$ is proposed in a semi-parametric framework in a recent work of Butucea et al. [4]: if it is known that $f_{\varepsilon}$ is supersmooth, this strategy may be used to estimate $s$. Lastly, one can think of taking $m_{n}$ of order $\left(\left|\hat{f}_{\varepsilon}^{*}\right|^{2}\right)^{-1}(\sqrt{M})$, where the exponent -1 here denotes the reciprocal function.

We can provide another set of assumptions ensuring (A3). Assume that $\gamma \in[\underline{\gamma}, \bar{\gamma}], s \in[\underline{s}, \bar{s}]$ and $b \in[\underline{b}, \bar{b}]$ with $\underline{s}>0, \underline{b}>0$ whenever $s>0, b>0$. And consider also the following assumption: $M \lesssim \exp \left(n^{1 / 4}\right)$ and

Case $(b, s)=(0,0)$ (ordinary smooth noise):
(A4) $\left\{\begin{array}{c}\mathcal{M}_{n}=\left\{m,(\pi m)^{2 \underline{\gamma}+1} \leq n\right\} \\ M \geq n^{\frac{2 \bar{\gamma}+1}{2 \underline{\gamma}+1}}\end{array}\right.$ or $\left\{\begin{array}{c}\mathcal{M}_{n}=\{m,(\pi m) \leq \sqrt{n}\} \\ M \geq n^{\bar{\gamma}+1 / 2} .\end{array}\right.$
Case $b>0, s>0$ (supersmooth noise)
(A4) $\left\{\begin{array}{c}\mathcal{M}_{n}=\left\{m,(\pi m)^{2 \underline{\gamma}+1-\bar{s}} e^{2 \underline{b}(\pi m)^{s}} \leq n\right\} \\ M \geq \exp \left\{2 \frac{2 \bar{b}}{(2 \underline{b})^{\underline{s}}}(\log n)^{\bar{s} / \underline{s}}\right\}\end{array}\right.$
Then (A4) may require greater values of $M$, but also ensures (A3).
The simulation experiments of Section 5 are very useful here, to study the influence of the value of $M$ and the importance of the set $\mathcal{M}_{n}$. It illustrates
that we obtain very good results in practice, even when arbitrary limitations are set on $m_{n}$ or $M$.

We can prove the preliminary result given in Theorem 4.1. Note that the proof of this theorem is not standard in the present setting for the following reason. Usually, the contrast decomposition gives two types of terms:

- supremum of centered empirical processes (which in the independent bounded case are controlled thanks to Talagrand's type results): these terms impose the form of the penalty function.
- residual terms which are of negligible orders and which are not centered.

Here, the residual terms which appear, even when controlled by using Lemma 3.1, are not negligible and have a weight in the penalty function. This makes the proof quite difficult.

Theorem 4.1. Assume that assumptions (A2) and (A3) are fulfilled and consider the estimator $\hat{f}_{\hat{m}}$ defined by (2.3) and (4.1) with

\operatorname{pen}(m)=K_{0}(\pi m)^{\left[s-(1-s)_{+} / 2\right]+} \frac{\Delta(m)}{n} .
$$

Then there exists $C>0$ such that

$$
\mathbb{E}\left\|\hat{f}_{\hat{m}}-f\right\|^{2} \leq 4 \inf _{m \in \mathcal{M}_{n}}\left\{\left\|f_{m}-f\right\|^{2}+\operatorname{pen}(m)\right\}+\frac{C}{n}
$$

where $f_{m}$ is the orthogonal projection of $f$ on $S_{m}$.
The presence of $\left|f_{\varepsilon}^{*}\right|$ and $s$ in the penalty is not admissible as it is an unknown quantity. That is why we state the following theorem.

Theorem 4.2. Assume that assumptions (A2) and (A3) are fulfilled and that $s \leq \bar{s}$ for some given upper value $\bar{s}$. Consider the estimator $\tilde{f}=\hat{f}_{\hat{\hat{m}}}$ defined by (2.3) and

$$

Then there exists $C>0$ such that

\mathbb{E}\|\tilde{f}-f\|^{2} \leq 4 \inf _{m \in \mathcal{M}_{n}}\left\{\left\|f_{m}-f\right\|^{2}+\mathbb{E} \widetilde{\operatorname{pen}}(m)\right\}+\frac{C}{n}
$$

Note that the restriction $s \leq 2$ is very classical, so that $\bar{s}=2$ is generally suitable.
 it follows from Theorem 4.2 that $\tilde{f}$ automatically reaches the same rate as when $f_{\varepsilon}$ is known if $\bar{s}=s$ or if $\bar{s}=0$ (and thus $s=0$ and this is known). For a discussion about the optimality of these rates (which holds in most cases), see Comte et al. [6].
5. Simulations. Let us describe the estimation procedure. As noticed in (2.4), for each $m$, the estimator $\hat{f}_{m}$ of $f$ can be written

\hat{f}_{m}=\sum_{|l| \leq K_{n}} \hat{a}_{m, l} \varphi_{m, l} \quad \text { with } \quad \hat{a}_{m, l}=\frac{1}{n} \sum_{j=1}^{n} \tilde{v}_{\varphi_{m, l}}\left(Y_{j}\right)
$$

To compute the coefficients $\hat{a}_{m, l}$, we use the Inverse Fast Fourier Transform. Indeed, using $\varphi_{m, l}^{*}(u)=e^{-i l u / m} \mathbb{1}_{[-\pi m, \pi m]} / \sqrt{m}$,
$\hat{a}_{m, l}=\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} \frac{1}{\sqrt{m}} e^{-i l u / m} \frac{\hat{f_{Y}^{*}}(-u)}{\tilde{f}_{\varepsilon}^{*}(-u)} d u=\frac{\sqrt{m}}{2}(-1)^{l} \int_{0}^{2} e^{i l \pi x} \frac{\hat{f_{Y}^{*}}}{\tilde{f}_{\varepsilon}^{*}}(\pi m(x-1)) d x$
Then, for $l=0, \ldots, N-1$, denoting $h_{m}(x)=\left(\hat{f}_{Y}^{*} / \tilde{f}_{\varepsilon}^{*}\right)(\pi m(x-1)), \hat{a}_{m, l}$ can be approximated by

$$
\sqrt{m}(-1)^{l} \frac{1}{N} \sum_{k=0}^{N-1} e^{i l \pi \frac{2 k}{N}} h_{m}\left(\frac{2 k}{N}\right)=\sqrt{m}(-1)^{l}(\operatorname{IFFT}(H))_{l}
$$

where $H$ is the vector $\left(h_{m}(0), h_{m}(2 / N), \ldots, h_{m}(2(N-1) / N)\right.$. For $l<0$, it is sufficient to replace $h_{m}(x)$ by $h_{m}(-x)=\overline{h_{m}(x)}$, i.e. $H$ by $\bar{H}$. Following Comte et al. [6], we choose $K_{n}=N-1=2^{8}-1$ : indeed, a larger $K_{n}$ does not significantly improve the results.

Thus, to compute $\tilde{f}$, we use the following steps:

- For each $m \in \mathcal{M}_{n}$ and for each $l$, compute $\hat{a}_{m, l}$ using function $\hat{f_{Y}^{*}} / \tilde{f}_{\varepsilon}^{*}$ and IFFT as described above
- For each $m$ compute $\gamma_{n}\left(\hat{f}_{m}\right)+\widetilde{\operatorname{pen}}(m)=-\sum_{l}\left|\hat{a}_{m, l}\right|^{2}+\widetilde{\operatorname{pen}}(m)$.
- Select the $\hat{\hat{m}}$ which minimizes $\gamma_{n}\left(\hat{f}_{m}\right)+\widetilde{\operatorname{pen}}(m)$.
- Compute $\tilde{f}=\sum_{|l| \leq K_{n}} \hat{a}_{\hat{\tilde{m}}, l} \varphi_{\hat{\tilde{m}}, l}$.

Clearly, the use of FFT makes the procedure very fast. The penalty is chosen according to Theorem 4.2 with $\bar{s}=2$. Indeed densities with $s>2$ are difficult to express in a closed form whereas usual densities all verify
$0 \leq s \leq 2$. The constant $K_{1}$ is chosen equal to $1 / 2$ after intensive simulation experiments. However other values of $K_{1}$ can suit and, empirically, the procedure seems rather robust with respect to the choice of this constant. Thus, in all the examples below, we take:

$$
\widetilde{\operatorname{pen}}(m)=\frac{1}{2 n}(\pi m)^{2} \int_{-\pi m}^{\pi m}\left|\tilde{f}_{\varepsilon}^{*}\right|^{-2} .
$$

Let us first compare our estimator to the one of Neumann [14]. He denotes by $f_{0}(x)=e^{-|x|} / 2$ and he considers two examples:

- example 1: $f=f_{0} * f_{0} * f_{0} * f_{0}$ and $f_{\varepsilon}=f_{0} * f_{0}$
- example 2: $f=f_{0} * f_{0}$ and $f_{\varepsilon}=f_{0} * f_{0} * f_{0} * f_{0}$

We set, as in Neumann [14], $n=200$ and $M=10$ and the $L^{2}$ risk is computed with 100 random samples. As in Comte et al. [7], we consider that $m$ can be fractional. More precisely, we take here

$$
\mathcal{M}_{n}=\left\{m=\frac{k}{4 \pi}, k \in \mathbb{N}^{*}, k \leq \sqrt{n}\right\}
$$

for the estimation with unknown noise. Actually, the bound on $m$, which is crucial in theory, turns out to be of little importance for practical purposes. The procedure chooses the appropriate model (often very small) even if the maximal model is very large. That is why in all our experiments we choose to keep a maximal $m$ with order $\sqrt{n}$. We also compute the estimator with known noise, replacing $\tilde{f}_{\varepsilon}$ by $f_{\varepsilon}$ in the procedure. In this case, the choice of the maximal model has more impact, so we choose $\mathcal{M}_{n}=\{m=$ $\left.k /(4 \pi), k \in \mathbb{N}^{*}, k \leq n^{1 / 4}\right\}$. Moreover, we take here $\operatorname{pen}(m)=4 \Delta(m) / n=$ $(2 / n \pi) \int_{-\pi m}^{\pi m}\left(1+x^{2}\right)^{2 d} d x$ with $d=2$ in example 1 and $d=4$ in example 2. The integrated $L^{2}$ risks for 100 replications are given in Table 3 and show our improvement of the results of Neumann [14].

In these examples, the signal and the noise are ordinary smooth $(r=s=$ 0 ): this induces the rates of convergence $n^{-\frac{15}{24}}+M^{-1}$ and $n^{-\frac{7}{24}}+M^{-\frac{7}{16}}$ for examples 1 and 2 respectively.

An example of estimation for supersmooth functions is given in Johannes [11]. In his example 5.1, he considers a standard Gaussian noise and $X \sim$ $\mathcal{N}(5,9)$. Again we use $\mathcal{M}_{n}=\left\{m=k /(4 \pi), k \in \mathbb{N}^{*}, k \leq \sqrt{n}\right\}$. The penalty
for a known noise is pen $(m)=(\pi m)^{3} \int_{0}^{1} \exp \left\{(\pi m x)^{2}\right\} d x /(2 n)$. As Johannes [11] presents only boxplots and for the sake of comparison, we give the third quartile for the $L^{2}$ risk in Table 4. In this case $r=2, \delta=1 / 2$ and $s=2, \gamma=0$ and the rate of convergence is $n^{-\frac{9}{10}}(\log n)^{-1 / 2}+M^{-1}$. The improvement brought by our method is striking.

Now we compute estimators for different signal densities and different noises. For the sake of simplicity (and since the chosen model are here larger), we take now

$$
\mathcal{M}_{n}=\left\{m=\frac{k}{2 \pi}, k \in \mathbb{N}^{*}, k \leq \sqrt{n}\right\}
$$

(for both known and unknown noise). Following Comte et al. [6] we study the following densities on the interval $I$ :
(i) Laplace distribution: $f(x)=e^{-\sqrt{2}|x|} / \sqrt{2}, I=[-5,5]$ (regularities $\delta=$ $2, r=0$ )
(ii) Mixed Gamma distribution: $X=W / \sqrt{5.48}$ with $W \sim 0.4 \Gamma(5,1)+$ $0.6 \Gamma(13,1)$,

$$
I=[-1.5,26] \text { (regularities } \delta=5, r=0)
$$

(iii) Cauchy distribution: $f(x)=\left(\pi\left(1+x^{2}\right)\right)^{-1}, I=[-10,10]$ (regularities $\delta=0, r=1$ )
(iv) Standard Gaussian distribution, $I=[-4,4]$ (regularities $\delta=1 / 2, r=2$ )

We consider two different noises with same variance $1 / 10$ :
Laplace noise In this case, the density of $\varepsilon_{i}$ is given by

$$
f_{\varepsilon}(x)=\frac{\lambda}{2} e^{-\lambda|x|} ; \quad f_{\varepsilon}^{*}(x)=\frac{\lambda^{2}}{\lambda^{2}+x^{2}} ; \quad \lambda=2 \sqrt{5} .
$$

The smoothness parameters are $\gamma=2$ and $b=s=0$. In the case when $f_{\varepsilon}$ is known, we use pen $(m)=4\left(\pi m+\left(2 /\left(3 \lambda^{2}\right)\right)(\pi m)^{3}+\left(1 /\left(5 \lambda^{4}\right)\right)(\pi m)^{5}\right) / n$.
Gaussian noise In this case, the density of $\varepsilon_{i}$ is given by

$$
f_{\varepsilon}(x)=\frac{1}{\lambda \sqrt{2 \pi}} e^{-\frac{x^{2}}{2 \lambda^{2}}} ; \quad f_{\varepsilon}^{*}(x)=e^{-\frac{\lambda^{2} x^{2}}{2}} ; \quad \lambda=\frac{1}{\sqrt{10}} .
$$

So $\gamma=0, b=\lambda^{2} / 2$ and $s=2$. In the case when $f_{\varepsilon}$ is known, we use $\operatorname{pen}(m)=0.5(\pi m)^{3} \int_{0}^{1} e^{(\lambda \pi m x)^{2}} d x / n$.

The results are given in Table 5 and are very comparable to those of Comte et al. [6]. We notice that the estimation of the characteristic function of the noise does not spoil so much the procedure. It even happens that the estimation with unknown noise works better. We can also observe that, as expected, the risk decreases when $M$ increases. The cases where the risk is larger for $M=n$ correspond to a stabilization of the decrease and are due to the variance of the results. Figure 1 illustrates these results for two cases: a mixed Gamma density estimated through Laplace noise and a Laplace density estimated through Gaussian noise.

Figure 2 shows the decrease of the integrated risk in these two cases. These curves confirm the theoretical result since the rate of convergence for a fixed $n$ is $M^{-1}$ in the first case and $(\log M)^{-2}$ in the second case.
6. Proofs. For two sequences $u_{n, M}$ and $v_{n, M}$, we denote $u_{n, M} \lesssim v_{n, M}$ if there exists a positive constant $C$ such that $u_{n, M} \leq C v_{n, M}$.
6.1. Proof of Lemma 2.1. It is sufficient to prove the first assertion. First we write that $v_{t}\left(Y_{j}\right)=(1 / 2 \pi) \int e^{i Y_{j} u} t^{*}(u) / f_{\varepsilon}^{*}(-u) d u$ so that

E\left[v_{t}\left(Y_{j}\right) \mid X_{j}\right]=\frac{1}{2 \pi} \int E\left[e^{i Y_{j} u} \mid X_{j}\right] \frac{t^{*}(u)}{f_{\varepsilon}^{*}(-u)} d u
$$

By using the independence between $X_{j}$ and $\varepsilon_{j}$, we compute

$$
E\left[e^{i Y_{j} u} \mid X_{j}\right]=E\left[e^{i X_{j} u} e^{i \varepsilon_{j} u} \mid X_{j}\right]=e^{i X_{j} u} E\left[e^{i \varepsilon_{j} u}\right]=e^{i X_{j} u} f_{\varepsilon}^{*}(-u)
$$

Then
$E\left[v_{t}\left(Y_{j}\right) \mid X_{j}\right]=\frac{1}{2 \pi} \int e^{i X_{j} u} f_{\varepsilon}^{*}(-u) \frac{t^{*}(u)}{f_{\varepsilon}^{*}(-u)} d u=\frac{1}{2 \pi} \int e^{i X_{j} u} t^{*}(u) d u=t\left(X_{j}\right)$.
6.2. Proof of Proposition 3.1. We start from Inequality (3.3). It follows from Butucea and Comte [3] that:

\operatorname{Var}\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u} \frac{{\hat{f_{Y}^{*}}}_{*}(u)}{f_{\varepsilon}^{*}(-u)} d u\right) \leq \frac{1}{2 \pi n} \inf \left(\int\left|f_{Y}^{*}\right| \Delta(m), \Delta^{0}(m)\right), \tag{6.1}
\end{equation*}
$$

and (also, to see this, use (2.1) and $\left.\left(f-f_{m}\right)(x)=(1 / 2 \pi)\left(f^{*}-f_{m}^{*}\right)^{*}(-x)\right)$,

\begin{equation*}
\left(f_{m}(x)-f(x)\right)^{2} \leq\left(\frac{1}{2 \pi} \int_{|t| \geq \pi m}\left|f^{*}(t)\right| d t\right)^{2} . \tag{6.2}
\end{equation*}

For the remaining term in (3.3), we write first:

& \mathbb{E}\left[\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u} \hat{f}_{Y}^{*}(u) R(u) d u\right)^{2}\right] \\
\leq & 2 \mathbb{E}\left[\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u}\left(\hat{f_{Y}^{*}}(u)-f_{Y}^{*}(u)\right) R(u) d u\right)^{2}\right] \\
& +2 \mathbb{E}\left[\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u} f_{Y}^{*}(u) R(u) d u\right)^{2}\right]:=2 T_{1}+2 T_{2} .
\end{aligned}

Then we find

T_{1} & =\frac{1}{4 \pi^{2}} \iint e^{i x(u-v)} \operatorname{cov}\left(\hat{f}_{Y}^{*}(u), \hat{f}_{Y}^{*}(v)\right) \mathbb{E}(R(u) \bar{R}(v)) d u d v \\
& \leq \frac{1}{4 \pi^{2} n} \iint\left|f_{Y}^{*}(u-v)\right| \sqrt{\mathbb{E}\left(|R(u)|^{2}\right) \mathbb{E}\left(|R(v)|^{2}\right)} d u d v \\
& \lesssim \frac{1}{4 \pi^{2} n} \iint\left|f_{Y}^{*}(u-v)\right| \frac{1}{\left|f_{\varepsilon}(u) f_{\varepsilon}(v)\right|} d u d v
\end{aligned}
$$

by using Lemma 3.1. This term is clearly bounded by $\Delta^{0}(m)$. Moreover writing it as

\iint \frac{\sqrt{\left|f_{Y}^{*}(u-v)\right|}}{\left|f_{\varepsilon}(u)\right|} \frac{\sqrt{\left|f_{Y}^{*}(u-v)\right|}}{\left|f_{\varepsilon}(v)\right|} d u d v

and using first the Schwarz Inequality, and second the Fubini Theorem yields the bound $\int\left|f_{Y}^{*}\right| \Delta(m)$. Therefore
$\mathbb{E}\left[\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} e^{i x u}\left(\hat{f}_{Y}^{*}(u)-f_{Y}^{*}(u)\right) R(u) d u\right)^{2}\right] \lesssim \frac{1}{2 \pi n} \inf \left(\int\left|f_{Y}^{*}\right| \Delta(m), \Delta^{0}(m)\right)$,
and thus it has the same order as the usual variance term. Lastly,

T_{2} & \leq \frac{1}{4 \pi^{2}} \iint_{|u|,|v| \leq \pi m}\left|f_{Y}^{*}(u) f_{Y}^{*}(v)\right| \sqrt{\mathbb{E}\left(|R(u)|^{2}\right) \mathbb{E}\left(|R(v)|^{2}\right)} d u d v \\
& \leq \frac{1}{4 \pi^{2}}\left(\int_{-\pi m}^{\pi m}\left|f_{Y}^{*}(u)\right| \sqrt{\mathbb{E}\left(|R(u)|^{2}\right)} d u\right)^{2} \\
& \lesssim \frac{1}{4 \pi^{2} M}\left(\int_{-\pi m}^{\pi m}\left|f_{Y}^{*}(u)\right| \frac{1}{\left|f_{\varepsilon}^{*}(u)\right|^{2}} d u\right)^{2} \\
& =\frac{1}{4 \pi^{2} M}\left(\int_{-\pi m}^{\pi m} \frac{\left|f^{*}(u)\right|}{\left|f_{\varepsilon}^{*}(u)\right|} d u\right)^{2}=\frac{\Delta_{f}^{0}(m)}{2 \pi M} \tag{6.4}
\end{align*}
$$

Inserting the bounds (6.1) to (6.4) in Inequality (3.3), we obtain the result of Proposition 3.1.
6.3. Proof of Proposition 3.2. We start from (3.6) and take the expectation:

\mathbb{E}\left(\left\|f_{m}-\hat{f}_{m}\right\|^{2}\right) \leq & \frac{2}{\pi} \int_{-\pi m}^{\pi m} \mathbb{E}\left(\left|f_{Y}^{*}(u)-f_{Y}^{*}(u)\right|^{2}|R(u)|^{2}\right) d u \\
& +\frac{2}{\pi} \int_{-\pi m}^{\pi m}\left|f_{Y}^{*}(u)\right|^{2} \mathbb{E}\left(|R(u)|^{2}\right) d u+\frac{1}{\pi} \int_{-\pi m}^{\pi m} \frac{n^{-1}}{\left|f_{\varepsilon}^{*}(u)\right|^{2}} d u .
\end{aligned}
$$

Applying Lemma 3.1 yields:

\mathbb{E}\left(\left\|f_{m}-\hat{f}_{m}\right\|^{2}\right) \leq & \frac{2}{\pi} \int_{-\pi m}^{\pi m} \mathbb{E}\left(\left|f_{Y}^{*}(u)-f_{Y}^{*}(u)\right|^{2}\right) \mathbb{E}\left(|R(u)|^{2}\right) d u \\
& +\frac{2}{\pi} \int_{-\pi m}^{\pi m}\left|f^{*}(u)\right|^{2}\left|f_{\varepsilon}^{*}(u)\right|^{2} \mathbb{E}|R(u)|^{2} d u+2 \frac{\Delta(m)}{n} \\
\lesssim & \int_{-\pi m}^{\pi m} n^{-1}\left|f_{\varepsilon}^{*}(u)\right|^{-2} d u \\
& +\int_{-\pi m}^{\pi m}\left|f^{*}(u)\right|^{2}\left|f_{\varepsilon}^{*}(u)\right|^{2} \frac{M^{-1}}{\left|f_{\varepsilon}^{*}(u)\right|^{4}} d u+\frac{\Delta(m)}{n} \\
\lesssim & \frac{1}{M} \int_{-\pi m}^{\pi m} \frac{\left|f^{*}(u)\right|^{2}}{\left|f_{\varepsilon}^{*}(u)\right|^{2}} d u+\frac{\Delta(m)}{n} \tag{6.5}
\end{align*}
$$

By gathering (3.5) and (6.5), we obtain the result.
6.4. Proof of Lemma 3.2. The proof of the first result is omitted. It is obtained by distinguishing the cases $s>2 \gamma+1$ and $s \leq 2 \gamma+1$ and with standard evaluations of integrals. For the second point, we first remark that $\Delta_{f}(m) \leq \Delta(m)$. Next, using Assumption (A2),

\Delta_{f}(m) & \leq \frac{k_{0}^{-2}}{2 \pi} \int_{-\pi m}^{\pi m}\left(x^{2}+1\right)^{\gamma} e^{2 b|x|^{s}}\left|f^{*}(x)\right|^{2} d x \\
& \leq \frac{k_{0}^{-2}}{2 \pi} l \sup _{x \in[-\pi m, \pi m]}\left(\left(x^{2}+1\right)^{\gamma-\delta} e^{2\left(b|x|^{s}-a|x|^{r}\right)}\right)
\end{aligned}
$$

Then, if $s>r$,

$$

$\mathbb{E}\left[\sup _{t \in B(m, \hat{m})}\left|R_{n, 3}(t)\right|^{2}-p_{3}(m, \hat{m})\right]_{+} \leq \sum_{m^{\prime} \in \mathcal{M}_{n}} \mathbb{E}\left[\sup _{t \in B\left(m, m^{\prime}\right)}\left|R_{n, 3}(t)\right|^{2}-p_{3}\left(m, m^{\prime}\right)\right]_{+}$
which replaces the supremum on a random unit ball ( $\hat{m}$ is random) by suprema on deterministic unit balls. Then we use the following Lemma

Lemma 6.1. Let $T_{1}, \ldots, T_{M}$ be independent random variables and $\nu_{M}(r)=$ $(1 / M) \sum_{j=1}^{M}\left[r\left(T_{j}\right)-\mathbb{E}\left(r\left(T_{j}\right)\right]\right.$, for $r$ belonging to a countable class $\mathcal{R}$ of measurable functions. Then, for $\epsilon>0$,

$$
\begin{equation*}
\mathbb{E}\left[\sup _{r \in \mathcal{R}}\left|\nu_{M}(r)\right|^{2}-(1+2 \epsilon) H^{2}\right]_{+} \leq C\left(\frac{v}{M} e^{-K_{1} \epsilon \frac{M H^{2}}{v}}+\frac{B^{2}}{M^{2} C^{2}(\epsilon)} e^{-K_{2} C(\epsilon) \sqrt{\epsilon} \frac{M H}{B}}\right) \tag{6.16}
\end{equation*}
$$

with $K_{1}=1 / 6, K_{2}=1 /(21 \sqrt{2}), C(\epsilon)=\sqrt{1+\epsilon}-1$ and $C$ a universal constant and where

$$
\sup _{r \in \mathcal{R}}\|r\|_{\infty} \leq B, \quad \mathbb{E}\left(\sup _{r \in \mathcal{R}}\left|\nu_{M}(r)\right|\right) \leq H, \quad \sup _{r \in \mathcal{R}} \frac{1}{M} \sum_{j=1}^{M} \operatorname{Var}\left(r\left(T_{j}\right) \leq v .\right.
$$

Inequality (6.16) is a straightforward consequence of the Talagrand [15] inequality given Birgé and Massart [1]. Moreover, standard density arguments allow to apply it to the unit ball of a finite dimensional linear space.

Let us determine $B, H$ and $v$ is our problem.
For $t \in S_{m}+S_{m^{\prime}}=S_{m^{\prime \prime}}$,

$$
\left\|F_{t}\right\|_{\infty}^{2} \leq\left.\frac{1}{4 \pi^{2}} \int_{-\pi m^{\prime \prime}}^{\pi m^{\prime \prime}}\left|\frac{\left|f^{*}(x)\right|^{2}}{\left|f_{\varepsilon}^{*}(x)\right|^{2}} d x \int_{-\pi m^{\prime \prime}}^{\pi m^{\prime \prime}}\right| t^{*}(-x)\right|^{2} d x
$$

Then $\sup _{t \in B\left(m, m^{\prime}\right)}\left\|F_{t}\right\|_{\infty}^{2} \leq \Delta_{f}\left(m^{\prime \prime}\right)$ and we set

$$
B=\sqrt{\Delta\left(m^{\prime \prime}\right)}
$$

If $t$ belongs to $B\left(m, m^{\prime}\right)$, it can be written $t=\sum_{l \in \mathbb{Z}} a_{m^{\prime \prime}, l} \varphi_{m^{\prime \prime}, l}$ and

$$
\left|R_{n, 3}(t)\right|^{2} \leq \sum_{l \in \mathbb{Z}} a_{m^{\prime \prime}, l}^{2} \sum_{l \in \mathbb{Z}}\left|\frac{1}{M} \sum_{j=1}^{M}\left[F_{\varphi_{m^{\prime \prime}, l}}\left(\varepsilon_{-j}\right)-\mathbb{E}\left(F_{\varphi_{m^{\prime \prime}, l}}\left(\varepsilon_{-j}\right)\right)\right]\right|^{2}
$$

As the $\varepsilon_{-j}$ are i.i.d.,

$$
\mathbb{E}\left(\sup _{t \in B\left(m, m^{\prime}\right)}\left|R_{n, 3}(t)\right|^{2}\right) \leq \sum_{l \in \mathbb{Z}} \operatorname{Var}\left(\frac{1}{M} \sum_{j=1}^{M} F_{\varphi_{m^{\prime \prime}, l}}\left(\varepsilon_{-j}\right)\right) \leq \frac{1}{M} \sum_{l \in \mathbb{Z}} \operatorname{Var}\left(F_{\varphi_{m^{\prime \prime}, l}}\left(\varepsilon_{1}\right)\right)
$$

Now, using the Parseval formula,

$$
\sum_{l \in \mathbb{Z}}\left|\frac{1}{2 \pi} \int \frac{f^{*}(x)}{f_{\varepsilon}^{*}(x)} \varphi_{m^{\prime \prime}, l}^{*}(-x) e^{-i x u} d x\right|^{2}=\frac{1}{2 \pi} \int_{-\pi m^{\prime \prime}}^{\pi m^{\prime \prime}}\left|\frac{f^{*}(x)}{f_{\varepsilon}^{*}(x)}\right|^{2} d x .
$$

Then

$$
\begin{aligned}
\mathbb{E}\left(\sup _{t \in B\left(m, m^{\prime}\right)}\left|R_{n, 3}(t)\right|^{2}\right) & \leq \frac{1}{M} \mathbb{E}\left(\sum_{l \in \mathbb{Z}}\left|F_{\varphi_{m^{\prime \prime}, l}}\left(\varepsilon_{1}\right)\right|^{2}\right) \\
& \leq \frac{1}{2 \pi M} \int_{-\pi m^{\prime \prime}}^{\pi m^{\prime \prime}}\left|\frac{f^{*}(x)}{f_{\varepsilon}^{*}(x)}\right|^{2} d x \leq \frac{\Delta_{f}\left(m^{\prime \prime}\right)}{M}
\end{aligned}
$$

and we set $H=\sqrt{\Delta\left(m^{\prime \prime}\right) / M}$ as $\|f\|_{1}=1$.
Lastly, standard methods give $v=C \min \left(\Delta\left(m^{\prime \prime}\right),\left\|f_{\varepsilon}\right\| \sqrt{\Delta_{2}\left(m^{\prime \prime}\right)}\right)$ with

$$
\Delta_{2}(m)=\int\left|\frac{1}{f_{\varepsilon}^{*}}\right|^{4}
$$

Then we insert these quantities in the Inequality given in Lemma 6.1. For the first term of the right-hand-side bound, we obtain

$$
\sum_{m^{\prime} \in \mathcal{M}_{n}} \frac{v}{M} \exp \left(-K_{1} \epsilon \frac{M H^{2}}{v}\right) \leq \frac{C}{M}
$$

with adequate choices of $\epsilon$. The study of this term is the same as in the proof of Theorem 1 in Comte et al. [6] and is omitted here. The second term of the right-hand-side bound is less than (up to multiplicative constants):

$$
\sum_{m^{\prime} \in \mathcal{M}_{n}} \frac{\Delta\left(m^{\prime \prime}\right)}{M^{2}} \exp (-C \sqrt{M}) \leq M^{1 / \tilde{\gamma}-1-\alpha} \exp (-C \sqrt{M}) \lesssim \frac{1}{M}
$$

Inserting the value of $\epsilon$ and applying Lemma 6.1 leads to

$$
\sum_{m^{\prime} \in \mathcal{M}_{n}} \mathbb{E}\left[\sup _{t \in B\left(m, m^{\prime}\right)}\left|R_{n, 3}(t)\right|^{2}-p_{3}\left(m, m^{\prime}\right)\right]_{+} \leq \frac{C}{M}
$$

which implies (6.13).
6.6.4. Study of $R_{n, 4}(t)$. It is easy to see that

$$
\sup _{t \in B(m, \hat{m})}\left|R_{n, 4}(t)\right|^{2} \leq \frac{1}{2 \pi} \int_{-\pi m^{*}}^{\pi m^{*}}\left|f^{*}(u)\right|^{2} \mathbb{1}_{E^{c}} d u,
$$

and thus

$$
\begin{aligned}
& \quad \mathbb{E}\left(\sup _{t \in B(m, \hat{m})}\left|R_{n, 4}(t)\right|^{2}\right) \leq \frac{1}{2 \pi} \int_{-\pi m_{n}}^{\pi m_{n}}\left|f^{*}(u)\right|^{2} \mathbb{P}\left(E^{c}\right) d u \\
& \text { imsart-aos ver. } 2007 / 12 / 10 \text { file: ComteLacour.tex date: July 18, } 2008
\end{aligned}
$$

Now, $\mathbb{P}\left(E^{c}\right)=\mathbb{P}\left(\left|\hat{f}_{\varepsilon}^{*}(x)\right| \leq 1 / \sqrt{M}\right)$. We use that, as $\left|f_{\varepsilon}^{*}(x)\right|^{-2} \leq M^{1-\alpha}$, it holds that $\left|f_{\varepsilon}^{*}(x)\right| \geq 2 / \sqrt{M}$. Thus, proceeding as in Neumann [14], we apply Bernstein Inequality and we get

$$
\begin{aligned}
\mathbb{P}\left(\left|\hat{f}_{\varepsilon}^{*}(x)\right|<M^{-1 / 2}\right) & \leq \mathbb{P}\left(\left|\hat{f}_{\varepsilon}^{*}(x)-f_{\varepsilon}^{*}(x)\right|>\left|f_{\varepsilon}^{*}(x)\right|-M^{-1 / 2}\right) \\
& \leq \mathbb{P}\left(\left|\hat{f}_{\varepsilon}^{*}(x)-f_{\varepsilon}^{*}(x)\right|>M^{-1 / 2}\right) \\
& \leq \kappa \exp \left(-\kappa M\left|f_{\varepsilon}^{*}(x)\right|^{2}\right)=O\left(M^{-p}\left|f_{\varepsilon}^{*}(x)\right|^{-2 p}\right),
\end{aligned}
$$

for all $p \geq 1$. Then

$$
\begin{aligned}
\mathbb{E}\left(\sup _{t \in B(m, \hat{m})}\left|R_{n, 4}(t)\right|^{2}\right) & \lesssim \int_{-\pi m_{n}}^{\pi m_{n}}\left|f^{*}(u)\right|^{2} M^{-p}\left|f_{\varepsilon}^{*}(u)\right|^{-2 p} d u \\
& \lesssim \Delta_{f}\left(m_{n}\right) M^{-p} M^{(1-\alpha)(p-1)}
\end{aligned}
$$

Then as $\Delta_{f}\left(m_{n}\right) \leq \Delta\left(m_{n}\right) \leq m_{n} M \leq M^{1+1 /(2 \tilde{\gamma})}$, it is sufficient to take $p \geq 2+1 /(2 \alpha \tilde{\gamma})>0$ to obtain

$$
\mathbb{E}\left(\sup _{t \in B(m, \hat{m})}\left|R_{n, 4}(t)\right|^{2}\right) \lesssim \frac{1}{M} \lesssim \frac{1}{n} .
$$

Therefore, (6.14) holds.
6.7. Proof of Theorem 4.2. We use the following set

$$
\Lambda=\left\{\forall m \in \mathcal{M}_{n}, \quad \frac{1}{2 \pi} \int_{-\pi m}^{\pi m}|R|^{2} \leq \frac{\Delta(m)}{4}\right\} .
$$

Let

$$
\widetilde{\Delta}(m)=\frac{1}{2 \pi} \int_{-\pi m}^{\pi m} d x /\left|\tilde{f}_{\varepsilon}(x)\right|^{2}
$$

Since $\Delta(m) \leq \frac{2}{2 \pi} \int_{-\pi m}^{\pi m}|R|^{2}+2 \widetilde{\Delta}(m)$, we can write on $\Lambda, \Delta(m) \leq \Delta(m) / 2+$ $2 \widetilde{\Delta}(m)$ and then

$$
\Delta(m) \mathbb{1}_{\Lambda} \leq 4 \widetilde{\Delta}(m) \mathbb{1}_{\Lambda}
$$

Reasoning as in the proof of Theorem 4.1, if $p$ is such that for all $m, m^{\prime}$, $4 p\left(m, m^{\prime}\right) \mathbb{1}_{\Lambda} \leq \widetilde{\operatorname{pen}}(m) \mathbb{1}_{\Lambda}+\widetilde{\operatorname{pen}}\left(m^{\prime}\right) \mathbb{1}_{\Lambda}$ then

$$
\|\tilde{f}-f\|^{2} \mathbb{1}_{\Lambda} \leq 3\left\|f_{m}-f\right\|^{2}+8\left[\sup _{t \in B(m, \hat{\tilde{m}})} \nu_{n}^{2}(t)-p(m, \hat{\hat{m}})\right] \mathbb{1}_{\Lambda}+4 \widetilde{\operatorname{pen}}(m) \mathbb{1}_{\Lambda}
$$

It follows from the proof of Theorem 4.1 that

$$
8 \mathbb{E}\left[\sup _{t \in B(m, \hat{\tilde{m}})} \nu_{n}^{2}(t)-p(m, \hat{\hat{m}})\right]_{+} \leq C / n
$$

with $p\left(m, m^{\prime}\right)=K\left(\pi m^{\prime \prime}\right)^{\left[s-(1-s)_{+} / 2\right]_{+}} \Delta\left(m^{\prime \prime}\right) / n$.
Thus, choosing $\widetilde{\operatorname{pen}}(m)=16 K(\pi m)^{\left[\bar{s}-(1-\bar{s})_{+} / 2\right]+} \widetilde{\Delta}(m) / n$, on $\Lambda$,

$$
\begin{aligned}
4 p\left(m, m^{\prime}\right) & =4 K\left(\pi m^{\prime \prime}\right)^{\left[s-(1-s)_{+} / 2\right]_{+}} \Delta\left(m^{\prime \prime}\right) / n \\
& \leq 4 K(\pi m)^{\left[\bar{s}-(1-\bar{s})_{+} / 2\right]_{+}} \Delta(m) / n+4 K\left(\pi m^{\prime}\right)^{\left[\bar{s}-(1-\bar{s})_{+} / 2\right]_{+}} \Delta\left(m^{\prime}\right) / n \\
& \leq 16 K(\pi m)^{\left[\bar{s}-(1-\bar{s})_{+} / 2\right]_{+}} \widetilde{\Delta}(m) / n+16 K\left(\pi m^{\prime}\right)^{\left[\bar{s}-(1-\bar{s})_{+} / 2\right]_{+}} \widetilde{\Delta}\left(m^{\prime}\right) / n \\
& \leq \widetilde{\operatorname{pen}}(m)+\widetilde{\operatorname{pen}}\left(m^{\prime}\right)
\end{aligned}
$$

Then

$$
\mathbb{E}\left(\|\tilde{f}-f\|^{2} \mathbb{1}_{\Lambda}\right) \leq 4 \inf _{m \in \mathcal{M}_{n}}\left\{\left\|f_{m}-f\right\|^{2}+\mathbb{E} \widetilde{\operatorname{pen}}(m)\right\}+\frac{C}{n}
$$

We still have to prove that

$$
\mathbb{E}\left(\|\tilde{f}-f\|^{2} \mathbb{1}_{\Lambda^{c}}\right) \leq \frac{C}{n}
$$

First we compute, using formula (2.5),

$$
\|\tilde{f}\|^{2}=\frac{1}{2 \pi} \int\left|\hat{f}_{\hat{\tilde{m}}}^{*}\right|^{2}=\frac{1}{2 \pi} \int_{-\pi \hat{\tilde{m}}}^{\pi \hat{\hat{m}}} \frac{\left|\hat{f}_{Y}^{*}\right|^{2}}{\left|\tilde{f}_{\varepsilon}^{*}\right|^{2}} \leq \frac{1}{2 \pi} \int_{-\pi \hat{\tilde{m}}}^{\pi \hat{\tilde{m}}}\left|\tilde{f}_{\varepsilon}^{*}\right|^{-2}
$$

But $\left|\tilde{f}_{\varepsilon}^{*}(x)\right|^{-2}=\left|\hat{f}_{\varepsilon}^{*}(x)\right|^{-2} \mathbb{1}_{\left\{\left|\hat{f}_{\varepsilon}^{*}(x)\right| \geq M^{-1 / 2}\right\}} \leq M$. Then

$$
\|\tilde{f}\|^{2} \leq M \hat{\hat{m}} \leq M m_{n} \leq M^{1 /(2 \tilde{\gamma})+1}
$$

and thus $\mathbb{E}\left(\|\tilde{f}-f\|^{2} \mathbb{1}_{\Lambda^{c}}\right) \lesssim M^{1 /(2 \tilde{\gamma})+1} P\left(\Lambda^{c}\right)$. Now, using Markov and Jensen inequalities,

$$
\begin{aligned}
\mathbb{P}\left(\Lambda^{c}\right) & \leq \sum_{m \in \mathcal{M}_{n}} \mathbb{P}\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m}|R|^{2}>\frac{\Delta(m)}{4}\right) \\
& \leq \sum_{m \in \mathcal{M}_{n}}\left(\frac{4}{\Delta(m)}\right)^{p} \mathbb{E}\left[\left(\frac{1}{2 \pi} \int_{-\pi m}^{\pi m}|R|^{2}\right)^{p}\right] \\
& \leq\left(\frac{4}{2 \pi}\right)^{p} \sum_{m \in \mathcal{M}_{n}} \Delta(m)^{-p} \mathbb{E}\left[(2 \pi m)^{p-1} \int_{-\pi m}^{\pi m}|R|^{2 p}\right] \\
& \leq \frac{4^{p}}{2 \pi} \sum_{m \in \mathcal{M}_{n}} \Delta(m)^{-p} m^{p-1} \int_{-\pi m}^{\pi m} \mathbb{E}|R|^{2 p}
\end{aligned}
$$

Since $\mathbb{E}|R|^{2 p} \lesssim M^{-p}\left|f_{\varepsilon}^{*}\right|^{-4 p}$ (Lemma 3.1),

$$
\mathbb{P}\left(\Lambda^{c}\right) \lesssim \frac{4^{p}}{2 \pi} M^{-p} \sum_{m \in \mathcal{M}_{n}} \Delta(m)^{-p} m^{p-1} \int_{-\pi m}^{\pi m}\left|f_{\varepsilon}^{*}\right|^{-4 p}
$$

Now, using assumption (A2),

$$
\int_{-\pi m}^{\pi m}\left|f_{\varepsilon}^{*}\right|^{-4 p} \leq k_{0}^{-4 p} \int_{-\pi m}^{\pi m}\left(x^{2}+1\right)^{2 \gamma p} \exp \left(4 p b|x|^{s}\right) d x \lesssim(\pi m)^{4 \gamma p+1-s} e^{4 p b(\pi m)^{s}}
$$

so that

$$
\begin{aligned}
\int_{-\pi m}^{\pi m}\left|f_{\varepsilon}^{*}\right|^{-4 p} & \lesssim\left[(\pi m)^{2 \gamma} e^{2 b(\pi m)^{s}}\right]^{p}\left[(\pi m)^{2 \gamma+1-s} e^{2 b(\pi m)^{s}}\right]^{p} m^{1-s-p+s p} \\
& \lesssim M^{(1-\alpha) p} \Delta(m)^{p} m^{1-s-p+s p}
\end{aligned}
$$

Hence

$$
\mathbb{P}\left(\Lambda^{c}\right) \lesssim M^{-a p} \sum_{m \in \mathcal{M}_{n}} m^{-s+s p} \lesssim M^{-\alpha p}\left(m_{n}\right)^{1+s(p-1)}
$$

Finally $\mathbb{E}\left(\|\tilde{f}-f\|^{2} \mathbb{1}_{\Lambda^{c}}\right) \lesssim M^{1+1 /(2 \tilde{\gamma})} P\left(\Lambda^{c}\right) \lesssim M^{-\alpha p+1+1 /(2 \tilde{\gamma})} m_{n}^{1+s(p-1)}$. If $s=0$, then $\gamma>0$ and the bound become $M^{-\alpha p+1+1 / \gamma}$, so that $p \geq$ $(2+1 / \gamma) / \alpha$ implies $\mathbb{E}\left(\|\tilde{f}-f\|^{2} \mathbb{1}_{\Lambda^{c}}\right) \lesssim M^{-1}$. If $s>0$, then under (A3), $m_{n} \lesssim(\log (M))^{1 / s}$, so that the previous inequality holds if $p>2 / \alpha$.
