# Medium-modified average multiplicity and multiplicity fluctuations in jets

#### Abstract

The energy evolution of medium-modified average multiplicities and multiplicity fluctuations in quark and gluon jets produced in heavy-ion collisions is discussed at next-to-leading order (NLO) in perturbative QCD. We use modified splitting functions, accounting for induced soft gluon radiation from a hard parton, which propagates through quark gluon plasma. The leading contribution of the standard production of soft hadrons is found to be enhanced by the factor $\sqrt{N_{s}}$ while NLO corrections are suppressed by $1 / \sqrt{N_{s}}$, where the parameter $N_{s}>1$ accounts for the induced-soft gluons in the hot medium. Our results for such global observables are cross-checked and compared with their limits in the vacuum.


Recent experiments at the Relativistic Heavy Ion Collider (RHIC) have established a phenomenon of strong high-transverse momentum hadron suppression [1], which supports the picture that hard partons going through dense matter suffer a significant energy loss prior to hadronization in the vacuum (for recent review see [2]).

Predictions concerning multi-particle production in such reactions can be carried out by using the QCD interpretation of the medium-induced modification of the one-particle single inclusive distribution inside high energy jets [3], the so-called "distorted hump-backed plateau", which was considered by Borghini and Wiedemann in (4). The Dokshitzer-Gribov-Lipatov-AltarelliParisi (DGLAP) splitting functions [3] of the QCD evolution equations were distorted so that the role of soft emissions was enhanced by introducing the medium factor $N_{s}$ in the infra-red singular terms.

In this letter we are concerned with multi-particle production in quark and gluon jets, $A=q, g$, produced in nucleus-nucleus collisions at very high energy. We make predictions at NLO for the medium-modified average multiplicity $N_{A}$, for the ratio $r=N_{G} / N_{Q}$ and finally for the second multiplicity correlators $\left\langle N_{A}\left(N_{A}-1\right)\right\rangle / N_{A}^{2}$ which defines the width of the multiplicity distribution.

The starting point of our analysis is the NLO or Modified-Leading-Logarithmic-Approximation (MLLA) master evolution equation for the generating functional [3] which determine the jet properties at all energies together with the initial conditions at threshold at small $x$, where $x$ is the fraction of the outgoing jet energy carried away by a single gluon. Their solutions with medium-modified splitting functions can be resummed in powers of $\sqrt{\alpha_{s} / N_{s}}$ and the leading contribution can be represented as an exponential of the medium-modified anomalous dimension which takes into account the $N_{s^{-}}$ dependence:

where $\gamma_{\text {med }}\left(\alpha_{s}\right)$ can be expressed as a power series of
$\sqrt{\alpha_{s} / N_{s}}$ in the symbolic form:

Within this logic, the leading double logarithmic approximation (DLA, $\mathcal{O}\left(\sqrt{N_{s} \alpha_{s}}\right)$, which resums both soft and collinear gluons, and NLO (MLLA, $\mathcal{O}\left(\alpha_{s}\right)$ ), which resums hard collinear partons and accounts for the running of the coupling constant $\alpha_{s}$, are complete. The choice $d Y=d \Theta / \Theta$, where $\Theta \ll 1$ is the angle between outgoing couples of partons in independent partonic emissions, follows from Angular Ordering (AO) in intra-jet cascades [3]. In order to obtain the hadronic spectra, we advocate for the Local Parton Hadron Duality (LPHD) hypothesis (5]: global and differential partonic observables can be normalized to the corresponding hadronic observables via a certain constant $\mathcal{K}$ that can be fitted to the data, i.e. $N_{g, q}^{h}=\mathcal{K} \times N_{g, q}$.

The evolution of a jet of energy $E$ and half-opening angle $\Theta$ involves the DLA anomalous dimension $\gamma_{0}$ related to the coupling constant $\alpha_{s}$ through $\gamma_{0}^{2}=2 N_{c} \alpha_{s} / \pi$, with $\alpha_{s}=2 \pi / 4 N_{c} \beta_{0}(Y+\lambda)$, where $Y=\ln \left(Q / Q_{0}\right)(Q=E \Theta$ is the hardness or maximum transverse momentum of the jet) and $\lambda=\ln \left(Q_{0} / \Lambda_{\mathrm{QCD}}\right)$ is a parameter associated with hadronization ( $Q_{0}$ is the collinear cut-off parameter, $k_{T}>Q_{0}$, and $\Lambda_{\mathrm{QCD}}$ is the intrinsic QCD scale). At MLLA, as a consequence of angular ordering in parton cascading, the average multiplicity inside a gluon and a quark jet, $N_{g, q}$, obey the system of two-coupled evolution equations [6] (the subscript $Y_{Y}$ denotes $d / d Y$ )

which follow from the MLLA master evolution equation for the generating functional; $n_{f}$ is the number of light quark flavors, $N_{g, q} \equiv N_{g, q}(Y), N_{g, q}(x) \equiv N_{g, q}(Y+\ln x)$, $N_{g, q}(1-x) \equiv N_{g, q}(Y+\ln (1-x)), \Phi_{A}^{B}$ denotes the
medium-modified DGLAP splitting functions:

which accounts for parton energy loss in the medium by enhancing the singular terms like $\Phi \approx N_{s} / x$ as $x \ll 1$ as proposed in the Borghini-Wiedemann model (4).

For $Y \gg \ln x \sim \ln (1-x), N_{g, q}(x)\left(N_{g, q}(1-x)\right)$ can be replaced by $N_{g, q}$ in the hard partonic splitting region $x \sim$ $1-x \sim 1$ (non-singular or regular parts of the splitting functions), while the dependence at small $x \ll 1$ is kept in the singular term $\Phi(x) \approx N_{s} / x$ as done in the vacuum. Furthermore, the integration over $x$ can be replaced by the integration over $Y(x)=\ln \left(\frac{x E \Theta}{Q_{0}}\right)$. Thus, one is left with the approximate system of two-coupled equations,

with the initial conditions at threshold $N_{A}(0)=1$ and $N_{A}^{\prime}(0)=0$ and the hard constants:

where we have introduced $T_{R}=n_{f} / 2$. The quantum corrections $\propto a_{1}, \tilde{a}_{1}$ in (7,8) arise from the integration over the regular part of the splitting functions, they are $\mathcal{O}\left(\sqrt{\alpha_{s} / N_{s}}\right)$ suppressed and partially account for energy conservation as happens in the vacuum.

These equations can be solved by applying the inverse Mellin transform to the self-contained gluonic equation (7), which leads to

where the contour $C$ lies to the right of all singularities of $N_{g}(\omega)$ in the complex plane. Since we are concerned with the asymptotic solution of the equation as $Y \gg 1$ $\left(E \Theta \gg Q_{0}\right)$, that is the high-energy limit, the inverse Mellin transform (9) can be estimated by the steepest descent method. Indeed, the large parameter is $Y$ and the function in the exponent presents a saddle point at $\omega_{0}=\sqrt{N_{s} / \beta_{0}(Y+\lambda)}$, such that the asymptotic solution reads

where $\sigma_{1}=\frac{a_{1}}{2}-\frac{\beta_{0}}{4}$ with $\beta_{0}=\frac{1}{4 N_{c}}\left(\frac{11}{3} N_{c}-\frac{4}{3} T_{R}\right)$. The constant $\sigma_{1}$ is $N_{s}$-independent because it resums vacuum

corrections. Therefore, the production of soft gluons in a dense medium becomes $\exp \left[2\left(\sqrt{N_{s}}-1\right) \sqrt{(Y+\lambda) / \beta_{0}}\right]$ higher than the standard production of soft gluons in the vacuum [3]. From (11) and (10) one obtains the medium-modified MLLA anomalous dimension $\gamma_{\text {med }}=$ $\frac{1}{N_{g}} \frac{d N_{g}}{d Y}=\sqrt{N_{s}} \gamma_{0}-\sigma_{1} \gamma_{0}^{2}$, which is nothing but the MLLA rate of multi-particle production with respect to the evolution-time variable $Y$ in the dense medium. Fixing $\gamma_{\text {med }}=$ const, we are able to give the rough dependence of the coupling constant as a function of $N_{s}$, that is $\alpha_{s}\left(N_{s}\right) \simeq 1 / N_{s}$. This behavior follows the trends first observed in [7, 8] with fixed-coupling numerical solution. In Fig. 1 , we display the medium-modified average multiplicity (10) with predictions in the vacuum $\left(N_{s}=1\right)$ in the range $10 \leq Q(\mathrm{GeV}) \leq 500$; we set $Q_{0}=\Lambda_{\mathrm{QCD}}=0.23 \mathrm{GeV}$ in the limiting spectrum approximation [6], and take $\mathcal{K}=0.2$ from [6]. The values $N_{s}=1.6$ and $N_{s}=1.8$ in the medium may be realistic for RHIC and LHC phenomenology [4]. We find, as expected, that the production of soft hadrons increases as $N_{s}>1$, which implies that the available phase space for the production of harder collinear hadrons is restricted.

The medium-modified MLLA gluon to quark average multiplicity ratio, $r=N_{g} / N_{q}=N_{g}^{h} / N_{q}^{h}$, following from (10) and (3) reads

where we introduced the coefficient $r_{1}=a_{1}-\tilde{a}_{1}$ in the term suppressed by $\gamma_{0} / \sqrt{N_{s}}$ as $N_{s}>1$. Therefore, $r$ approaches its asymptotic DLA limit $r_{0}=N_{c} / C_{F}=9 / 4$ when the coherent radiation of soft gluons is enhanced by the medium, as depicted in Fig. (2). Moreover, $r_{0}$ is not affected by $N_{s}$ and is seen to be universal. Setting $N_{s}=1$ in (11), one recovers the appropriate limits in the vacuum (3, 9) 10. This observable is interesting because it is $\mathcal{K}$-independent, and it is therefore expected to provide a pure test of multi-particle dynamics [5]. Finally, the

gluon jets are still more active than the quark jets in producing secondary particles and the shape of the curves are roughly the same.

The second multiplicity correlator in quark and gluon jets was first considered in (9] at MLLA in the vacuum. It is defined in the form $N_{A}^{(2)}=\left\langle N_{A}\left(N_{A}-1\right)\right\rangle$ in gluon $(A=$ $g)$ and quark $(A=q)$ jets. The normalized second multiplicity correlator defines the width of the multiplicity distribution and is related to its dispersion $D_{A}^{2}=\left\langle N_{A}\left(N_{A}-\right.\right.$ 1) $\rangle-N_{A}^{2}$ by the formula $D_{A}^{2}=\left(A_{2}-1\right) N_{A}^{2}+N_{A}$. The second multiplicity correlators normalized to their own squared average multiplicity are $G_{2}=\left\langle N_{g}\left(N_{g}-1\right)\right\rangle / N_{g}^{2}$ and $Q_{2}=\left\langle N_{q}\left(N_{q}-1\right)\right\rangle / N_{q}^{2}$ inside a gluon and a quark jet respectively. These moments, which are less inclusive than the average multiplicity, prove to be $\mathcal{K}$-independent. The medium-modified system of two-coupled evolution equations for this observable follows from the MLLA master equation for the azimuthally averaged generating functional (3) and can be written in the convenient form

which proves to be more suitable for obtaining analytical solutions in the following. We use a new method to compute solutions at MLLA by replacing $N_{A}^{(2)}=A_{2} N_{A}^{2}$ on both sides of the expanded equations at $x \sim 1-x \sim 1$. The notations in (12,13) follow the same logic as those in (7, 8).

Applying the analysis that led to the system (7,8), we obtain from (12,13)

The constant $N_{s}$ only affects the leading double logarithmic term of the equations. The terms proportional to $a_{1},\left(a_{1}-b_{1}\right)$ and $\tilde{a}_{1}$ are hard vacuum corrections, which partially account for energy conservation, indeed $\gamma_{0}^{2} \frac{d N}{d Y} \approx \sqrt{N_{s}} \gamma_{0}^{3}$ and the relative correction to DLA is $\mathcal{O}\left(\sqrt{\alpha_{s} / N_{s}}\right)$.
Setting $N_{g}^{(2)}=G_{2} N_{g}^{2}$ in (14) and making use of (10), the system can be solved iteratively by taking terms up to $\mathcal{O}\left(\alpha_{s}\right)$ into consideration. The exact analytical solution reads,

We use (17) and (11) and substitute $N_{q}^{(2)}=Q_{2} N_{q}^{2}$ into (15) such that the solution reads

where we obtain the combination of color factors

Setting $N_{s}=1$ in (17) and (19) we get a perfect agreement with the vacuum results [9]. Fixing $\gamma_{0}$, it is straightforward to obtain the rough behavior of $A_{2}$ as a function of $N_{s}: A_{2}=$ const $-1 / \sqrt{N_{s}}$, that is increasing with $N_{s}$ as $N_{s}>1$. For $A=Q$, const $=1+N_{c} / 3 C_{F}$ and for $A=G$, const $=4 / 3$. In Fig. 3 and Fig. 4 , we compare

our results for the medium-modified second multiplicity correlators (17) and (19) with the predictions in the vacuum $\left(N_{s}=1\right)$ in the limiting spectrum approximation. Similarly to the MLLA ratio $r\left(N_{s}\right)$, Eq. (11), the hard corrections $\mathcal{O}\left(\gamma_{0}\right)$ are suppressed by a factor $1 / \sqrt{N_{s}}$. As before, these results provide evidence for the softening of jets in the nuclear medium; moreover, the multiplicity fluctuations of individual events must be larger for quark jets as compared to gluon jets just like in the vacuum [9]. Another interesting feature of these observables concerns the shape of the curves. They are roughly identical and prove not to depend on the medium parameter $N_{s}$. Moreover, there exists evidence for a flattening of the slopes as the hardness of the jet $Q=E \Theta$ increases for $N_{s} \geq 1$ (vacuum and medium). This kind of scaling behavior is known as the Koba-Nielsen-Olsen (KNO) scaling [11]: it was discovered by Polyakov in quantum field theory 12 and experimentally confirmed by $e^{+} e^{-}$ measurements 13 for the second and higher order multiplicity correlators. Therefore, the KNO-scaling should
hold in heavy-ion collisions.
In this Letter we have dealt with the medium-modified average multiplicity and the medium-modified second multiplicity correlator in quark and gluon jets. The starting point of our calculations is based on the BorghiniWiedemann model $\lfloor 4$, which models parton energy loss in a dense nuclear medium. The average multiplicity is found, because of multiple rescattering of the hard parton in the medium, to be enhanced by the factor $\sqrt{N_{s}}$ on the exponential leading contribution (10). The former leads, in particular, to the rescaling of $\alpha_{s}\left(\alpha_{s} \rightarrow \alpha_{s} / N_{s}\right)$ and to the medium-modified anomalous dimension $\gamma_{\text {med }}$ $\left(\gamma \rightarrow \gamma_{\mathrm{med}} \approx \sqrt{N_{s}} \gamma_{0}\right)$. Furthermore, the energy increase of the medium-modified average multiplicity at precise values of $N_{s}$ can serve as a thermometer on the nuclear medium of deconfined partons. In general, hard corrections are suppressed by the extra factor $1 / \sqrt{N_{s}}$, which leads to the restriction on the production of hard partons in quark and gluon jets. Thus, $r, G_{2}$ and $Q_{2}$ approach the asymptotic DLA $r_{0}=N_{c} / C_{F}, G_{2}=4 / 3$ and $Q_{2}=1+N_{c} / 3 C_{F}$ [3]; consequently, these vacuum values do not take $N_{s}$-dependence and prove to be universal. The previously mentioned KNO-scaling experienced by $G_{2}$ and $Q_{2}$ also proves its universality.
