# DILATATION OF A ONE-DIMENSIONAL NONLINEAR CRACK IMPACTED BY A PERIODIC ELASTIC WAVE*

#### Abstract

The interactions between linear elastic waves and a nonlinear crack with finite compressibility are studied in the one-dimensional context. Numerical studies on a hyperbolic model of contact with sinusoidal forcing have shown that the mean values of the scattered elastic displacements are discontinuous across the crack. The mean dilatation of the crack also increases with the amplitude of the forcing levels. The aim of the present theoretical study is to analyse these nonlinear processes under a larger range of nonlinear jump conditions. For this purpose, the problem is reduced to a nonlinear differential equation. The dependence of the periodic solution on the forcing amplitude is quantified under sinusoidal forcing conditions. Bounds for the mean, maximum and minimum values of the solution are presented. Lastly, periodic forcing with a null mean value is addressed. In that case, only a result about the mean dilatation of the crack is obtained.


Key words. Elastic wave scattering, contact acoustic nonlinearity, nonlinear jump conditions, periodic solutions of differential equations, dependence of solutions on parameters

## 1. Introduction.

1.1. Aims. The modeling of interactions between ultrasonic waves and cracks is of great interest in many fields of applied mechanics. When the wavelengths are much larger than the width of the cracks, the latter are usually replaced by zero-thickness interfaces with appropriate jump conditions. Linear models for crack-face interactions have been widely developed 16]. However, these models do not prevent from the nonphysical penetration of crack faces. In addition, laboratory experiments have shown that ultrasonic methods based on linear models often fail to detect partially closed cracks [20].

A well-known nonlinear model for cracks is the unilateral contact model 17, 9. A more realistic hyperbolic model accounting for the finite compressibility of crack faces under normal loading conditions has been presented for applications in engineering [2] and geomechanical contexts [3]. The well-posedness and the numerical modeling of the latter model in the context of 1-D linear elastodynamics was previously studied in [12. The generation of harmonics and the distorsion of simulated scattered velocity and stress waves were also observed.

Subsequent numerical experiments have brought to light an interesting property. In the case of a sinusoidal incident wave, the mean values of the elastic displacements around a crack were found to be discontinuous. The simulations conducted also indicated that the mean dilatation of the crack increases with the amplitude of the forcing levels. This purely nonlinear phenomenon (the linear models predict no dilatation) is of physical interest: experimenters can measure the dilatation 11] and use the data obtained to deduce the properties of the crack.

A preliminary theoretical study based on the use of a perturbation method was presented in [13. An analytical expression for the dilatation was obtained in that

[^0]study and successfully compared with the numerical results. However, this expression gives only a local estimate, valid in the particular case of the hyperbolic model subjected to very low sinusoidal forcing levels. The aim of the present study is to provide a theoretical analysis which can be applied to any range of forcing levels and to a larger number of contact models.
1.2. Design of the study. The present paper is organized as follows:

- In section 2 , the physical configuration is described. The family of strictly increasing convex jump conditions dealt with in this study is introduced. Numerical simulations of the process of interest are presented;
- In section 3, the problem is reduced to a nonautonomous differential equation. Up to section 6, only the case of sinusoidal forcing, which gives fine estimates, is studied;
- In section 4, preliminary results on the differential equation are presented. Classical tools for dynamical systems are used: Poincaré map, phase portrait, lower and upper solutions \$8, 15];
- In section 5, the main qualitative results of this study are presented. The mean, maximum and minimum aperture of the crack are bounded, and local estimates for small forcing are also proved;
- In section 6 , some of the previous results are extended to periodic forcing conditions. We prove the existence of a unique and attractive periodic solution. The increase of the mean dilatation with the forcing parameter is also proved;
- In section 7, some conclusions are drawn about the physical observables. Some future perspectives are also suggested.

2. Statement of the problem.

2.1. Physical modeling. We consider the case of a single crack with rough faces separating two media $\Omega_{0}$ and $\Omega_{1}$, which are both linearly elastic and isotropic, taking $\rho$ to denote the density and $c$ to denote the elastic speed of the compressional waves. These parameters are piecewise constant and may be discontinuous around the crack: $\left(\rho_{0}, c_{0}\right)$ if $x \in \Omega_{0},\left(\rho_{1}, c_{1}\right)$ if $x \in \Omega_{1}$. The media are subject to a constant
static stress $p$. At rest, the distance between the planes of average height is $\xi_{0}(p)>0$ (figure 2.1, left).

Elastic compressional waves are emitted by a singular source of stress at $x=x_{s}<$ $\alpha$ in $\Omega_{0}$, where $\alpha$ is a median plane of the actual flaw surface. The wave impacting $\alpha$ gives rise to reflected (in $\Omega_{0}$ ) and transmitted (in $\Omega_{1}$ ) compressional waves. These perturbations in $\Omega_{0}$ and $\Omega_{1}$ are described by the 1-D elastodynamic equations

where $S(t)$ denotes the causal stress source, $v=\frac{\partial u}{\partial t}$ is the elastic velocity, $u$ is the elastic displacement, and $\sigma$ is the elastic stress perturbation around $p$. The dynamic stresses induced by the elastic waves affect the thickness $\xi(t)$ of the crack (figure 2.1, right). The constraint

must be satisfied, where $[u]=u^{+}-u^{-}$is the difference between the elastic displacements on the two sides of the crack, and $d(p)>0$ is the maximum allowable closure [3]. We also assume that the wavelengths are much larger than $\xi$, so that the propagation time across the crack is neglected, the latter being replaced by a zero-thickness interface at $x=\alpha:[u]=[u(\alpha, t)]=u\left(\alpha^{+}, t\right)-u\left(\alpha^{-}, t\right)$.

Two independent jump conditions at $\alpha$ need to be defined to obtain a well-posed problem. The discontinuity of $\sigma$ is proportional to the mass of the interstitial medium present between $\Omega_{0}$ and $\Omega_{1}$ 19]. Since the crack is dry and contains only air, the density of which is much smaller than $\rho_{0}$ or $\rho_{1}$, the elastic stress is assumed to be continuous:

Establishing the second jump condition is a more complex task. Experimental and theoretical studies have shown that $u$ is discontinuous, and that the discontinuity is proportional to the stress applied. The linear model has often been considered 16]:

where $K$ is the interfacial stiffness. Welded conditions $[u(\alpha, t)]=0$ are obtained if $K \rightarrow+\infty$. However, the linear condition (2.4) violates (2.2) under large compression
loadings conditions: $\sigma^{*}(t)<-K \delta \Rightarrow \xi<\xi_{0}-\delta$. The linear condition (2.4) is therefore realistic only with very small perturbations. With larger ones, a nonlinear jump condition is required.

To develop this relation, it should be noted that compression loading increases the surface area of the contacting faces. A smaller stress is therefore needed to open than to close a crack; an infinite stress is even required to close the crack completely. In addition, the constraint (2.2) must be satisfied, and the model must comply with (2.4) in the case of small stresses. Lastly, concave stress-closure relations have been observed experimentally 14. Dimensional analysis shows that the general relation

is suitable, where $\mathcal{F}$ is a smooth increasing concave function

Two models illustrate the nonlinear relation (2.5). First, the so-called model 1 presented in [2, 3] is

Secondly, the so-called model 2 presented in (14] is

These two models are sketched in figure 2.2. The straight line with a slope $K$ tangential to the curves at the origin gives the linear jump conditions (2.4).
2.2. Numerical experiments. Here, we describe the influence of the nonlinear jump condition (2.5) on the wave scattering. For this purpose, we consider a single crack described by model 1 (2.7), a sinusoidal source $S$ with a frequency of 50 Hz , and parameters

The amplitude $v_{0}$ of the incident elastic velocity ranges from $0.01 \mathrm{~m} / \mathrm{s}$ to $0.5 \mathrm{~m} / \mathrm{s}$. This set of parameters corresponds to a typical configuration of the kind used in seismic investigations. The linear first-order hyperbolic system (2.1) and the jump conditions (2.3) and (2.7) are solved numerically on a $(x, t)$ grid. For this purpose, a fourthorder finite-difference ADER scheme is combined with an immersed interface method to account for the jump conditions 12]. At each time step, numerical integration of $v$ also gives $u$.

Figure 2.3 shows snapshots of $u$ after the transients have disappeared and the periodic regime has been reached. The mean values of the incident and reflected displacements $(x<\alpha)$ and the transmitted displacement $(x>\alpha)$ are given by horizontal dotted lines. With $v_{0}=0.01 \mathrm{~m} / \mathrm{s}(\mathrm{a})$, these mean values are continuous across $\alpha$. At higher amplitudes, a positive jump from $\alpha^{-}$to $\alpha^{+}$is observed. This jump, which amounts to a mean dilatation of the crack, also increases with $v_{0}(\mathrm{~b}, \mathrm{c}, \mathrm{d})$.

These properties can be more clearly seen in figure 2.4, where the numerically measured time history of $[u]$ is shown, with $v_{0}=0.2 \mathrm{~m} / \mathrm{s}(\mathrm{a})$ and $v_{0}=0.5 \mathrm{~m} / \mathrm{s}(\mathrm{b})$. It can also be seen from this figure that the maximum value of $[u]$ increases with $v_{0}$, whereas the minimum value of $[u]$ decreases and is bounded by $-d$, as required by (2.2). These findings will be analysed whatever $\mathcal{F}$ in (2.5) in the following sections.

Distorsion of the scattered fields can also be observed in figures 2.3 and 2.4, increasing with the amplitude of the forcing levels. It is beyond the scope of this paper to sudy this classical nonlinear phenomenon. A local analysis in the case of model 1 (2.7) was presented in 13.

## 3. Model problem.

3.1. Link with an ODE. To explain the numerical findings, we look for an evolution equation satisfied by $[u(\alpha, t)]$. Considering the elastic wave emitted by the source $S$ in (2.1), which impacts a single crack modeled by (2.3) and (2.5), leads to

the following proposition.
Proposition 3.1. The adimensionalized jump in the displacement $y=[u(\alpha, t)] / d$ satisfies the nonautonomous scalar differential equation:

where $\beta=K\left(\left(\rho_{0} c_{0}\right)^{-1}+\left(\rho_{1} c_{1}\right)^{-1}\right)>0$. The time $t$ in (3.1) has been successively shifted: $t-\left(\alpha-x_{s}\right) / c_{0} \rightarrow t$, and rescaled: $t \rightarrow \beta t$.

Proof. We adapt a procedure described in [17, ©, 10]. The elastic displacement interacting with the crack is

where $u_{I}, u_{R}$ and $u_{T}$ are the incident, reflected and transmitted displacements, respectively. The elastic stress deduced from (3.2) is (1]

Calculations based on (3.2) and (3.3) yield

At $\alpha$, the jump in the displacement $\chi$ and the weighted displacement $\psi$ are introduced

The continuity of $\sigma$ (2.3) means

The nonlinear relation (2.5) and the first equation of (3.4) give

Using (3.5) and (3.6), we obtain after some operations

where $\beta$ is defined in proposition 3.1. Classical calculations of elastodynamics yield the incident elastic velocity generated by $S$ and impacting the crack (1]

The time shift $t-\left(\alpha-x_{s}\right) / c_{0} \rightarrow t$ therefore gives the differential equation

Adimensionalization $y=\chi / d$ and time scaling $t \rightarrow \beta t$ give the ODE (3.1). Since the source $S$ is causal and $x_{s}<\alpha$, then $y(0)=0$.
3.2. Sinusoidal forcing. From $t=0$, the source is assumed to be sinusoidal with the angular frequency $\Omega$

which results in an incident elastic velocity with the amplitude $v_{0}$ (3.7). The source (3.8) is injected in (3.1). Then, setting the adimensionalized parameters

we obtain the nonautonomous differential equation with sinusoidal forcing:

For the sake of generality, contrary to what occured in proposition 3.1, $y_{0}$ can differ here from 0 . The properties of $f$ in (3.10) mean that the reciprocal function $f^{-1}$ satisfies

In model 1 (2.7), $f$ is involutive and $f_{\min }=-1$. The function $f$ and its derivatives are

In model $2(2.8), f_{\text {min }}=-\infty$, and the function $f$ and its derivatives are

In the next sections, solutions of (3.10) and related ODE will be presented. These solutions are computed numerically using a fourth-order Runge-Kutta method, with model 1 (2.7). The parameters are those used in section 2.2 , with adimensionalization (3.9). In addition and for the sake of clarity, the dependence of solutions on the parameters $A$ and $\omega$ is omitted, except when necessary. Lastly, we use an overline to denote the mean value of a function during one period $[0, T]$ : given $s(t)$,

## 4. Preliminary results.

4.1. Existence and uniqueness of a periodic solution $Y$. The $T$-periodic isocline of zero slope deduced from (3.10) is

Proposition 4.1. There is a unique T-periodic solution $Y(t)$ of (3.10), with $Y(0)=Y_{0}$. This solution is asymptotically stable.

Proof. Three cases can be distinguished.
Case 1: $A=0$. Equation (3.10) becomes a scalar autonomous equation with the steady state solution $Y=0$. Since $f$ is a $C^{1}$ function and $f^{\prime}(0)=-1$, the fixed point 0 is asymptotically stable. In the case of model 1 (2.7), the exact solution is a known special function: $y e^{y}=y_{0} e^{y_{0}-t} \Rightarrow y(t)=\mathcal{L}\left(y_{0} e^{y_{0}-t}\right)$, where $\mathcal{L}$ is the Lambert function [5].

Case 2: $0<A<\left|f_{\text {min }}\right|$. The $T$-periodic isocline (4.1) is defined on $\mathbb{R}$ (figure 4.1 a). Below $I_{0}^{y}$, we obtain $\frac{d y}{d t}>0$; and above $I_{0}^{y}$, we obtain $\frac{d y}{d t}<0$. The horizontal lines $f^{-1}(A)$ and $f^{-1}(-A)$ are weak lower and weak upper fences for (3.10), respectively. Since $y \mapsto F(t, y)$ is Lipschitz continuous, $f^{-1}( \pm A)$ are nonporous fences [8]. Based on the funnel's theorem, the subset of the $(t, y)$ plane defined by

$$
K=\mathbb{R}^{+} \times K_{0}, \quad K_{0}=\left[f^{-1}(A), f^{-1}(-A)\right]
$$

is a funnel [8]: once a solution has entered $K$, it stays inside. Defining the subsets

$$
U^{+}=\left\{t \geq 0 ;-1<y<f^{-1}(A)\right\}, \quad U^{-}=\left\{t \geq 0 ; y>f^{-1}(-A)\right\}
$$

the solution of (3.10) increases in $U^{+}$and decreases in $U^{-}$as $t$ increases. In addition, zero slope $\frac{d y}{d t}=0$ in $U^{ \pm}$occurs only at $T / 4$ and $3 T / 4$. The solution therefore enters $K$ in finite time, and $K_{0}$ is invariant under the flow $\left.\varphi: \mathbb{R}^{+} \times\right]-1,+\infty[\rightarrow$ $]-1,+\infty\left[;\left(t, y_{0}\right) \mapsto y(t)=\varphi\left(t, y_{0}\right)\right.$. The solutions of (3.10) are therefore always bounded, which ensures that the solutions are global solutions in time.

The invariance of $K_{0}$ ensures $\Pi\left(K_{0}\right) \subset K_{0}$, with the Poincaré map $\Pi$ : $]-1,+\infty[\rightarrow$ $]-1,+\infty\left[; y_{0} \mapsto \Pi\left(y_{0}\right)=\varphi\left(T, y_{0}\right)\right.$. Since $\Pi$ is continuous on $K$, it has at least one fixed point $Y_{0}$. The solutions $Y(t)=\varphi\left(t, Y_{0}\right)$ and $Y_{T}(t)=\varphi\left(t+T, Y_{0}\right)$ both satisfy the same ODE with the same initial value: $Y_{T}(0)=\varphi\left(T, Y_{0}\right)=\Pi\left(Y_{0}\right)=Y_{0}=Y(0)$. Therefore $Y(t+T)=Y(t)$ at all values of $t$, which proves that $Y(t)$ is $T$-periodic.

Let us consider another $T$-periodic solution $\tilde{Y}(t)$ of (3.10), with $\tilde{Y}(0)=\tilde{Y}_{0}$. Assuming that $Y_{0}>\tilde{Y}_{0}$ yields $Y(t)>\tilde{Y}(t)$ at all values of $t \in[0, T]$, hence $f(Y(t))<$ $f(\tilde{Y}(t))$. The integral forms of $Y(T)$ and $\tilde{Y}(T)$, together with the $T$-periodicity, give

$$
\begin{align*}
Y_{T}-\tilde{Y}_{T} & =Y_{0}-\tilde{Y}_{0}+\int_{0}^{T}\left(f(Y(t))-f(\tilde{Y}(t)) d t<Y_{0}-\tilde{Y}_{0}\right.  \tag{4.2}\\
& =Y_{0}-\tilde{Y}_{0}
\end{align*}
$$

This results in $Y_{0}-\tilde{Y}_{0}<Y_{0}-\tilde{Y}_{0}$, which is impossible. The opposite case $Y_{0}<\tilde{Y}_{0}$ can be handled in the same way, which proves the uniqueness of the $T$-periodic solution. Lastly, the properties of $f$ in (3.10) mean that

$$
\begin{equation*}
a_{0}=\int_{0}^{T} \frac{\partial F}{\partial y}\left(t, \varphi\left(t, y_{0}\right)\right) d t=\int_{0}^{T} f^{\prime}\left(\varphi\left(t, y_{0}\right)\right) d t<0 \tag{4.3}
\end{equation*}
$$

therefore $Y(t)$ is asymptotically stable (see e.g. theorem 4-22 in (7]).

Case 3: $A \geq\left|f_{\min }\right|$. This case can occur only if $f_{\min }>-\infty$. The isocline (4.1) is defined outside the two vertical asymptotes at $T_{1}$ and $T_{2}$

$$
\begin{equation*}
0<T_{1}=\frac{1}{\omega} \arcsin \left(\frac{\left|f_{\min }\right|}{A}\right)<\frac{T}{4}<T_{2}=\frac{T}{2}-T_{1} . \tag{4.4}
\end{equation*}
$$

(figure 4.1-b). The set $\left[f^{-1}(A),+\infty[\right.$ is invariant under the flow but not compact. To prove the existence of solutions at all time, let us examine the subset of the $(t, y)$ plane where the solution can blow up: $\Gamma=\{0<t<T / 2 ; y>0\}$. In $\Gamma, y>0$ and $f(y)<0$, hence $\frac{d y}{d t}<A \sin \omega t$. By integrating, we obtain

$$
0<y<y_{0}+\int_{0}^{T / 2} A \sin \omega t d t=y_{0}+\frac{2 A}{\omega}<+\infty
$$

which proves that the solution is global in time.
To obtain an invariant set, we take $y>0$, which means that $f_{\min }<f(y)<0$ and thus $f_{\text {min }}+A \sin \omega t<\frac{d y}{d t}<A \sin \omega t$. As long as $y>0$, integration will ensure that $y$ is bounded by a lower solution and an upper solution

$$
y_{0}+f_{\min } t+\frac{A}{\omega}(1-\cos \omega t)<y(t)<y_{0}+\frac{A}{\omega}(1-\cos \omega t) .
$$

Taking $y_{0}>\left|f_{\min }\right| T$, for instance $y_{0}=2\left|f_{\min }\right| T$, ensures that $y>0$ for all values of $t \in[0, T]$ and that $y(T)<y_{0}$. Therefore, upon defining the subset of the $(t, y)$ plane

$$
K=\mathbb{R}^{+} \times K_{0}, \quad K_{0}=\left[f^{-1}(A), 2\left|f_{\min }\right| T\right]
$$

then $K_{0}$ is invariant under the Poincaré map, yielding $\Pi\left(K_{0}\right) \subset K_{0}$. The same arguments as those given in case 2 hold here, which proves the existence, uniqueness and asymptotic stability of the $T$-periodic solution.

As seen in the previous proof, the phase portrait of (3.10) depends on $A$. However, the evolution of $Y$ with $t$ is the same at all values of $A$, as seen in figure 4.1 and proved in section 可. Some auxiliary solutions are first introduced. These solutions make it possible to investigate how the attractive periodic solution $Y$ evolves with the parameter $A$.
4.2. Auxiliary solutions. The first derivative of $Y$ with respect to $A$ is introduced: $Z(t, A)=\frac{\partial Y}{\partial A}$. Applying the chain-rule to (3.10) shows that the $T$-periodic solution $Z$ satisfies

$$
\left\{\begin{array}{l}
\frac{d Z}{d t}=f^{\prime}(Y) Z+\sin \omega t  \tag{4.5}\\
Z(0, A)=Z_{0}=\frac{d Y_{0}}{d A}
\end{array}\right.
$$

The isocline of zero slope of (4.5) is deduced from (3.10):

$$
\begin{equation*}
I_{0}^{Z}(t)=-\frac{\sin \omega t}{f^{\prime}(Y(t))}=\frac{\sin \omega t}{\left|f^{\prime}(Y(t))\right|} \tag{4.6}
\end{equation*}
$$

Below $I_{0}^{Z}$, we obtain $\frac{d Z}{d t}>0$; and above $I_{0}^{Z}$, we obtain $\frac{d Z}{d t}<0$. The phase portrait of (4.5) obtained in the case of model 1 is displayed in figure 4.2, which shows the qualitative properties of $Z$ that will be described in the next lemma and proposition.

Lemma 4.2. Setting

B(s)=-\int_{0}^{s} f^{\prime}(Y(\tau)) d \tau>0
$$

the initial value of the $T$-periodic solution $Z$ in (4.5) satisfies

$$
\begin{equation*}
Z_{0}=\frac{1}{e^{B(T)}-1} \int_{0}^{T} e^{B(s)} \sin \omega s d s<0 \tag{4.7}
\end{equation*}
$$

Proof. Given $Y(t)$, the ODE (4.5) is linear, which leads to the closed-form expression

$$
Z(t)=\left(D+\int_{0}^{T} e^{B(s)} \sin \omega s d s\right) e^{-B(t)}
$$

$T$-periodicity of $Z$ gives $D$ and proves the equality established in (4.7). Since $s \mapsto e^{B(s)}$ is a strictly positive and increasing function of $s$, we obtain the following bound

$$
\int_{0}^{T} e^{B(s)} \sin \omega s d s<e^{B(T / 2)} \int_{0}^{T / 2} \sin \omega s d s+e^{B(T / 2)} \int_{T / 2}^{T} \sin \omega s d s=0
$$

Substituting this inequality into (4.7) proves that $Z_{0}<0$.
Proposition 4.3. In $[0, T]$, the $T$-periodic solution $Z$ of (4.5) has two roots $t_{Z_{1}}$ and $t_{Z_{2}}$, which are ordered as follows:

$$
0<t_{Z_{1}}<T / 2<t_{Z_{2}}<T
$$

Therefore $Z<0$ in $\left[0, t_{Z_{1}}[\cup] t_{Z_{2}} T\right]$, and $Z>0$ on $] t_{Z_{1}}, t_{Z_{2}}$ [. In the limit of nullforcing case $A=0, Z$ and its roots are determined analytically:

$$
\| \begin{align*}
& Z(t, 0)=\frac{1}{\sqrt{1+\omega^{2}}} \sin (\omega t-\theta), \quad \theta=\arctan \omega  \tag{4.8}\\
& t_{Z_{1}}(0)=\frac{\theta}{\omega}, \quad t_{Z_{2}}(0)=\frac{\theta}{\omega}+\frac{T}{2}
\end{align*}
$$

Proof. $T$-periodicity of $Z$ and integration of (4.5) over one period gives

$$
\int_{0}^{T} f^{\prime}(Y(\tau)) Z(\tau) d \tau=0
$$

Since $f^{\prime}<0$, the sign of $Z$ changes in $[0, T]$. From lemma 4.2 and the phase portrait of (4.5), it can be deduced that $Z$ must cross the $t$-axis twice, at $t_{Z_{1}}$ and $t_{Z_{2}}$ in $] 0, T\left[\right.$. Let us assume $t_{Z_{1}} \geq T / 2$, where the isocline (4.6) is negative (figure 4.2). Then $Z$ will intersect $I_{0}^{Z}$ twice at negative values and will never cross the $t$-axis, which is impossible. After $t_{Z_{1}}, Z$ increases and intersects $I_{0}^{Z}$ with a zero slope at $t_{Z_{1}}<t<T / 2$. It then decreases but cannot intersect again $I_{0}^{Z}$ as long as $I_{0}^{Z}>0$ i.e. at $t<T / 2$. This means that $t_{Z_{2}}>T / 2$.

Taking $A=0$ results in $Y=0$, as stated in the proof of proposition 4.1 (case 1), and hence (4.5) becomes the linear ODE

$$
Z^{\prime}=-Z+\sin \omega t
$$

the $T$-periodic solution of which is given in (4.8).

The second derivative of $Y$ with respect to $A$ is also introduced: $W(t, A)=\frac{\partial^{2} Y}{\partial A^{2}}$. Applying the chain-rule to (4.5) shows that the $T$-periodic solution $W$ satisfies

$$
\left\{\begin{array}{l}
\frac{d W}{d t}=f^{\prime \prime}(Y) Z^{2}+f^{\prime}(Y) W  \tag{4.9}\\
W(0, A)=W_{0}=\frac{d^{2} Y_{0}}{d A^{2}}
\end{array}\right.
$$

The isocline of zero slope of $W$, which is deduced from (3.10) and (4.9), is

$$
\begin{equation*}
I_{0}^{W}(t)=\frac{f^{\prime \prime}(Y(t))}{\left|f^{\prime}(Y(t))\right|} Z^{2}(t) \geq 0 \tag{4.10}
\end{equation*}
$$

This isocline, which is shown in figure 4.3, is equal to zero only at $t_{Z_{1}}$ and $t_{Z_{2}}$, when $Z$ vanishes (proposition 4.3). Below $I_{0}^{W}$, we obtain $\frac{d W}{d t}>0$; and above $I_{0}^{W}$, we obtain $\frac{d W}{d t}<0$.

Proposition 4.4. The T-periodic solution $W$ of (4.8) is strictly positive: at all $t \in[0, T], W(t, A)>0$.

Proof. If $W_{0} \leq 0$, the phase portrait of (4.9) entails that $W(T)>W_{0}$, which is contradictory with the $T$-periodicity of $W$ : hence, $W_{0}>0$. We then consider

$$
\left\{\begin{array}{l}
w^{\prime}=f^{\prime}(Y) w \\
0<w(0)<W_{0}
\end{array}\right.
$$

Since $f^{\prime \prime}>0$ and $W_{0}>w(0), w$ is a lower solution of $W$, hence $W(t)>w(t)$ at all $t$. However, the $T$-periodic lower solution is $w=0$, which completes the proof.

Lemma 4.5. In the limit case of null forcing, the T-periodic solution $W$ of (4.9) contains only the harmonics $\sin 2 \omega t$ and $\cos 2 \omega t$, and has a non-null mean value

$$
\begin{equation*}
\bar{W}(0)=\frac{f^{\prime \prime}(0)}{2} \frac{1}{1+\omega^{2}} . \tag{4.11}
\end{equation*}
$$

Proof. We inject $Y=0$ into (3.10) and (4.9). Using (4.8) gives

$$
W^{\prime}(t, 0)=\frac{f^{\prime \prime}(0)}{1+\omega^{2}} \sin ^{2}(\omega t-\theta)-W(t, 0)
$$

Integrating the latter equation over $[0, T]$ gives the result.
Lastly, the third derivative of $Y$ with respect to $A$ is introduced: $X(t, A)=\frac{\partial^{3} Y}{\partial A^{3}}$. Applying the chain-rule to (4.9) shows that the $T$-periodic solution $X$ satisfies

$$
\left\{\begin{array}{l}
\frac{d X}{d t}=f^{\prime \prime \prime}(Y) Z^{3}+3 f^{\prime \prime}(Y) Z W+f^{\prime}(Y) X  \tag{4.12}\\
X(0, A)=X_{0}=\frac{\partial^{3} Y_{0}}{\partial A^{3}}
\end{array}\right.
$$

Lemma 4.6. In the limit case of null forcing, the mean value of the T-periodic solution $X$ of (4.12) is $\bar{X}(0)=0$.

Proof. Upon substituting $Y=0$ into (3.10), then (4.12) becomes

$$
X^{\prime}(t, 0)=f^{\prime \prime \prime}(0) Z^{3}(t, 0)+3 f^{\prime \prime}(0) Z(t, 0) W(t, 0)-X(t, 0)
$$

Integrating this differential equation over $[0, T]$ and the $T$-periodicity of $X$ give

$$
\bar{X}(0)=f^{\prime \prime \prime}(0) \overline{Z(t, 0)^{3}}+3 f^{\prime \prime}(0) \overline{Z(t, 0) W(t, 0)}
$$

In (4.8), $Z(t, 0)$ is a sinusoidal function with a null mean value, hence $\overline{Z(0)^{3}}=0$. Likewise, (4.8) and the properties of $W(t, 0)$ stated in lemma 4.5 give $\overline{Z(t, 0) W(t, 0)}=0$, which proves the result obtained.

## 5. Qualitative properties of $Y$.

5.1. Phase portrait of $Y$. The properties of $Z$ and $W$ provide qualitative insight about $Y$, stated in the next propositions and corollary.

Proposition 5.1. The initial value $Y_{0}$ in (3.10) is a strictly decreasing convex function of $A$, which satisfies

$$
-1<\max \left(f^{-1}(A),-\frac{A \omega}{1+\omega^{2}}\right) \leq Y_{0}(A) \leq 0
$$

Equality $Y_{0}=0$ occurs only at $A=0$. At low forcing levels, we obtain the local estimate

$$
Y_{0}=-\frac{A \omega}{1+\omega^{2}}+\mathcal{O}\left(A^{2}\right)
$$

Proof. Propositions 4.3 and 4.4 yield $\frac{d Y_{0}}{d A}=Z(0, A)<0$ and $\frac{d^{2} Y_{0}}{d A^{2}}=W(0, A)>$ 0 , which proves the convex decreasing of $Y_{0}$. Since $Y_{0}(0)=Y(0,0)=0$, then $Y_{0}(A) \leq$ 0 , which gives the upper bound of $Y_{0}$.

We now prove the lower bounds of $Y_{0}$. In the proof of proposition 4.1, it was established that $f^{-1}(A)$ is a lower nonporous fence, which means that $Y(t) \geq f^{-1}(A)$, and hence that $Y_{0} \geq f^{-1}(A)$. On the other hand, lemma 4.2 and proposition 4.4 show that $A \mapsto Y_{0}(A)$ is a convex function, which reaches a maximum at $A=0$, with $Y_{0}(0)=0 . Y_{0}(A)$ is therefore always above the straight line going through the origin with slope $A \frac{\partial Y}{\partial A}(0): Y_{0} \geq A Z_{0}(0)$, where $Z_{0}(0)$ is deduced from (4.8).

At $A \ll 1$, a Taylor expansion of $Y$ is written as follows

$$
Y_{0}(A)=Y_{0}(0)+A \frac{\partial Y_{0}}{\partial A}(0)+\mathcal{O}\left(A^{2}\right)
$$

If $A=0$, then $Y_{0}=Y=0$, and (4.8) again provides $Z_{0}(0)=\frac{\partial Y_{0}}{\partial A}(0)$.
The evolution of $Y_{0}$ with $A$ is shown in figure 5.1. Critical times in $Y$ are defined and estimated in the following proposition and corollary.

Proposition 5.2. In $[0, T]$, the $T$-periodic solution $Y$ of (3.19), which has two roots $t_{Y_{1}}, t_{Y_{2}}$, is maximum and positive at $t_{Y_{\max }}$, and minimum and negative at $t_{Y_{\min }}$.

See proposition 5.8 and corollary 5.3 .

The critical points are ordered as follows:

$$
\begin{array}{ll}
0<t_{Y_{1}}<T / 2<t_{Y_{2}}<T, & t_{Y_{1}}<t_{Y_{\max }}<t_{Y_{2}}<t_{Y_{\min }} \\
T / 4<t_{Y_{\max }}<T / 2, & 3 T / 4<t_{Y_{\min }}<T .
\end{array}
$$

Wit $A \ll 1$ and using $\theta$ defined in (4.8), we also obtain the following local estimates

$$
\| \begin{align*}
& Y(t, A)=\frac{A}{\sqrt{1+\omega^{2}}} \sin (\omega t-\theta)+\mathcal{O}\left(A^{2}\right), \\
& t_{Y_{1}}\left(0^{+}\right)=\frac{\theta}{\omega}, \quad t_{Y_{\max }}\left(0^{+}\right)=\frac{\theta}{\omega}+\frac{T}{4}, \quad t_{Y_{2}}\left(0^{+}\right)=\frac{\theta}{\omega}+\frac{T}{2}, \quad t_{Y_{\min }}\left(0^{+}\right)=\frac{\theta}{\omega}+\frac{3 T}{4} . \tag{5.1}
\end{align*}
$$

Proof. The phase portrait of (3.10) and the proposition 5.1 mean that $Y(t)$ must cross the $t$-axis twice, at $t_{Y_{1}}$ and $t_{Y_{2}}$ in $] 0, T\left[\right.$. At $t \geq T / 2$, the isocline $I_{0}^{y}$ (4.1) is negative (figure 4.1). Consequently, $t_{Y_{1}} \geq T / 2$ means that $Y$ crosses $I_{0}^{y}$ twice at negative values of $Y$, preventing $Y$ from crossing the $t$-axis, which is impossible.

The slope of $Y$ is null at $t_{Y_{\max }}$, which means that $Y$ crosses $I_{0}^{y}$. This occurs only when the slope of $I_{0}^{y}$ is negative, between $T / 4$ and $3 T / 4$. Since $I_{0}^{y}$ must also be positive at the intersection point, it is possible only when $T / 4<t_{Y_{\max }}<T / 2$. $Y$ subsequently decreases but cannot cross the $t$-axis as long as $I_{0}^{y}$ positive, which means that $t_{Y_{2}}>T / 2$.

Lastly, the slope of $Y$ is equal to zero at $t_{Y_{\min }}$, which means that $Y$ crosses $I_{0}^{y}$. This is possible only when the slope of $I_{0}^{y}$ is positive. Since $I_{0}^{y}$ must also be negative, this means that $t_{Y_{\min }}>3 T / 4$.

To prove the local estimates, a Taylor expansion of $Y$ is written as follows

$$
\begin{aligned}
Y(t, A) & =Y(t, 0)+A \frac{\partial Y}{\partial A}(t, 0)+\mathcal{O}\left(A^{2}\right) \\
& =A Z(t, 0)+\mathcal{O}\left(A^{2}\right)
\end{aligned}
$$

Equation (4.8) and straightforward calculations complete the proof.
Corollary 5.3. The following properties hold for all $A>0$ :
(i) $\left[t_{Y_{1}}, t_{Y_{2}}\right] \subset\left[t_{Z_{1}}, t_{Z_{2}}\right]$, or equivalently $Z\left(t_{Y_{1}}, A\right) \geq 0$ and $Z\left(t_{Y_{2}}, A\right) \geq 0$;
(ii) $\frac{\partial t_{Y_{1}}}{\partial A}<0, \quad \frac{\partial t_{Y_{2}}}{\partial A}>0$;
(iii) $t_{Y_{1}}<\frac{\theta}{\omega}<\frac{T}{4}, \quad t_{Y_{2}}>\frac{\theta}{\omega}+\frac{T}{2}$;
(iv) if $\left|f_{\min }\right|<\infty$, then $\lim _{A \rightarrow+\infty} t_{Y_{\max }}=\frac{T}{2}$.

Proof.
$\underline{\text { Property (i). Two subsets of the } t \text {-plane are defined: }}$

$$
I(A)=\{t \in] 0, T[; Y(t, A)>0\}, \quad J(A)=\{t \in] 0, T[; Z(t, A)>0\} .
$$

Equations (4.8) and (5.1) prove that $I\left(0^{+}\right)=J(0)$. Phase portraits of (3.10) and (4.5) show that $I$ and $J$ are open intervals:

$$
I(A)=] t_{Y_{1}}, t_{Y_{2}}[, \quad J(A)=] t_{Z_{1}}, t_{Z_{2}}[
$$

Let us consider two forcing parameters $A_{1}$ and $A_{2}$, with $A_{2}>A_{1}>0$. Proposition 4.4 gives $\frac{\partial Z}{\partial A}>0$, and hence $Z\left(t, A_{1}\right)<Z\left(t, A_{2}\right)$. Taking $t \in J\left(A_{1}\right)$ gives $0<$ $Z\left(t, A_{1}\right)<Z\left(t, A_{2}\right)$, and therefore $t \in J\left(A_{2}\right)$ : the interval $J$ increases strictly with $A$. To prove $I(A) \subset J(A)$, we take $t \in I(A)$, and hence $Y(t, A)>0$. Two cases can be distinguished:

- $t \notin I\left(0^{+}\right) \Rightarrow Y\left(t, 0^{+}\right)<0$. The formula

$$
Y(t, A)=Y\left(t, 0^{+}\right)+\int_{0^{+}}^{A} Z(t, s) d s
$$

and the monotonic increase in $J$ with $A$ yields $Z(t, A)>0$, hence $t \in J(A)$;

- $t \in I\left(0^{+}\right)$. Arguments mentioned above yield $t \in J(0) \subset J(A)$, which completes the proof of (i).
Property (ii). First we differentiate $Y\left(t_{Y_{1}}, A\right)=0$ in terms of $A$ :

\frac{\partial Y}{\partial t} \frac{\partial t_{Y_{1}}}{\partial A}+\frac{\partial Y}{\partial A}=0
$$

The time derivative is replaced via (3.10)

$$
\left(f\left(Y\left(t_{Y_{1}}, A\right)\right)+A \sin \omega t_{Y_{1}}\right) \frac{\partial t_{Y_{1}}}{\partial A}+Z\left(t_{Y_{1}}, A\right)=0
$$

Since $f(0)=0$, we obtain

$$
\frac{\partial t_{Y_{1}}}{\partial A}=-\frac{Z\left(t_{Y_{1}}, A\right)}{A \sin \omega t_{Y_{1}}}
$$

Property (i) and proposition 5.2 then prove $\frac{\partial t_{Y_{1}}}{\partial A}<0$. A similar derivation gives

$$
\frac{\partial t_{Y_{2}}}{\partial A}=-\frac{Z\left(t_{Y_{2}}, A\right)}{A \sin \omega t_{Y_{2}}}
$$

Property (ii) and proposition 5.2 give $Z\left(t_{Y_{2}}, A\right) \geq 0$ and $\sin \omega t_{Y_{2}}<0$, and hence $\frac{\partial t_{Y_{2}}}{\partial A}>0$.

Property (iii). The bounds of $t_{Y_{1}}$ and $t_{Y_{2}}$ follow from (5.1) and property (ii). From the definition of $\theta$ (4.8) and the property of arctan, we also obtain

$$
\frac{\theta}{\omega} \leq \frac{1}{\omega} \frac{\pi}{2}=\frac{T}{4}
$$

which provides an additional bound for $t_{Y_{1}}$.
Property (iv). If $A \geq\left|f_{\min }\right|, Y$ crosses the isocline $I_{0}^{y}$ at $t_{Y_{\max }}>T_{2}$ : see (4.1), (4.4) and figure 4.1-(b). The bounds of proposition 5.2 ensure $T_{2}<t_{Y_{\max }}<T / 2$. Using $\lim _{A \rightarrow+\infty} T_{2}=T / 2$ completes the proof.

Numerical computations illustrating proposition 5.2 and corollary 5.3 are shown in figure 5.2. No theoretical results have been obtained about $\frac{\partial t_{Y_{\max }}}{\partial A}$ and $\frac{\partial t_{Y_{\min }}}{\partial A}$. The numerical simulations indicate that $t_{Y_{\max }}$ strictly increases with $A$, whereas $t_{Y_{\min }}$ first decreases up to a critical value, and then increases (b). Numerical simulations also indicate that $t_{Z_{2}}$ tends asymptotically towards $t_{Y_{\min }}$ at large values of $A$.

5.2. Mean dilatation of the crack. As stated in the introduction, the main aim of this study was to prove that a jump in the mean elastic displacement occurs around the crack, as observed numerically. This jump amounts to a mean dilatation of the crack. The next theorem addresses this typically nonlinear phenomenon.

THEOREM 5.4. The mean value of the T-periodic solution $Y$ in (3.1d) is positive and increases strictly with the forcing amplitude:

\bar{Y}>0, \quad \frac{\partial \bar{Y}}{\partial A}>0
$$

At small forcing levels, we also obtain the local estimate

$$
\begin{equation*}
\bar{Y}=\frac{f^{\prime \prime}(0)}{4} \frac{A^{2}}{1+\omega^{2}}+\mathcal{O}\left(A^{4}\right) \tag{5.2}
\end{equation*}
$$

Proof. T-periodicity of $Y$ and $\sin \omega t$ in (3.10) yields $\overline{f(Y)}=0$. Applying Jensen's inequality to convex $f$ gives $f(\bar{Y})<\overline{f(Y)}=0$. Since $f(0)=0$ and $f^{\prime}<0$, then $\bar{Y}>0$. Proposition 4.4 and (4.8) yield $\bar{Z}(0)=0$ and $\bar{W}=\frac{\partial \bar{Z}}{\partial A}>0$, and hence $\bar{Z}(A)=$ $\frac{\partial \bar{Y}}{\partial A}(A)>0$, which proves the second inequality. At $A \ll 1$, a Taylor expansion gives

$$
\begin{aligned}
\bar{Y}(A) & =\bar{Y}(0)+A \frac{\partial \bar{Y}}{\partial A}(0)+\frac{A^{2}}{2} \frac{\partial^{2} \bar{Y}}{\partial A^{2}}(0)+\frac{A^{3}}{6} \frac{\partial^{3} \bar{Y}}{\partial A^{3}}(0)+\mathcal{O}\left(A^{4}\right) \\
& =\bar{Y}(0)+A \bar{Z}(0)+\frac{A^{2}}{2} \bar{W}(0)+\frac{A^{3}}{6} \bar{X}(0)+\mathcal{O}\left(A^{4}\right)
\end{aligned}
$$

From (5.1) and (4.8), we obtain $\bar{Y}(0)=0$ and $\bar{Z}(0)=0$. Lemmas 4.5 and 4.6 then give the local estimate of $\bar{Y}$.

The evolution of $\bar{Y}$ with $A$ is presented in figure 5.3. With $A=2$, the relative error between $\bar{Y}$ and its local estimate (5.2) is less than $5 \%$. Figure 5.3 -(a) may be rather misleading as far as moderate values of $A$ are concerned: it might seem to suggest that $\bar{Y}$ is always greater than the local estimate in (5.2). This is not in fact the case with greater values of $A$ : the position of $\bar{Y}$ relative to its local estimate is not constant (b).

### 5.3. Maximum aperture of the crack. Let

$$
Y_{\max }=Y\left(t_{Y_{\max }}\right)=\sup _{t \in[0, T]} Y(t)
$$

be the maximum value of the $T$-periodic solution $Y$. We introduce a technical lemma.
Lemma 5.5. Let $h \in C^{3}(I \times \Lambda, \mathbb{R})$, where $I$ and $\Lambda$ are open subsets of $\mathbb{R}$. The following properties are assumed to hold whatever the value of $\lambda$ in $\Lambda$ :
(i) $h^{+}(\lambda)=\sup _{z \in I} h(z, \lambda)$ is reached at a single point $z^{+}(\lambda) \in I$;
(ii) $\frac{\partial^{2} h}{\partial z^{2}}\left(z^{+}(\lambda), \lambda\right)<0$;
(iii) $\forall z \in I, \frac{\partial h}{\partial \lambda}>0, \frac{\partial^{2} h}{\partial \lambda^{2}}>0$.

Then $h^{+}(\lambda) \in C^{2}(I, \mathbb{R})$, and $\lambda \mapsto h^{+}(\lambda)$ is a strictly increasing and convex function.
Proof. The definition of $z^{+}$in (i) gives

$$
\begin{equation*}
\frac{\partial h}{\partial z}\left(z^{+}(\lambda), \lambda\right)=0 \tag{5.3}
\end{equation*}
$$

In addition, (ii) ensures that $\frac{\partial^{2} h}{\partial z^{2}}\left(z^{+}(\lambda), \lambda\right) \neq 0$. The implicit function theorem can be applied to $\frac{\partial h}{\partial z} \in C^{2}(I \times \Lambda, \mathbb{R})$ : therefore, $\lambda \mapsto z^{+}(\lambda) \in C^{2}(\Lambda, \mathbb{R})$, and $h^{+}(\lambda)=$ $h\left(z^{+}, \lambda\right) \in C^{2}(I, \mathbb{R})$.

Based on the first property in (iii) and (5.3),

$$
\begin{aligned}
\frac{d h^{+}}{d \lambda}(\lambda) & =\frac{\partial h}{\partial \lambda}\left(z^{+}, \lambda\right)+\frac{\partial h}{\partial z}\left(z^{+}, \lambda\right) \frac{d z^{+}}{d \lambda} \\
& =\frac{\partial h}{\partial \lambda}\left(z^{+}, \lambda\right)>0
\end{aligned}
$$

which proves that $h^{+}$is a strictly increasing function of $\lambda$. On the other hand, differentiating (5.3) in terms of $\lambda$ gives

$$
\begin{equation*}
\frac{\partial^{2} h}{\partial \lambda \partial z}\left(z^{+}, \lambda\right)+\frac{\partial^{2} h}{\partial z^{2}}\left(z^{+}, \lambda\right) \frac{d z^{+}}{d \lambda}=0 \tag{5.4}
\end{equation*}
$$

Using (ii), the second property in (iii), and (5.4), we obtain

$$
\begin{aligned}
\frac{d^{2} h^{+}}{d \lambda^{2}}(\lambda) & =\frac{\partial^{2} h}{\partial \lambda^{2}}\left(z^{+}, \lambda\right)+\frac{\partial^{2} h}{\partial z \partial \lambda}\left(z^{+}, \lambda\right) \frac{d z^{+}}{d \lambda} \\
& =\frac{\partial^{2} h}{\partial \lambda^{2}}\left(z^{+}, \lambda\right)-\frac{\partial^{2} h}{\partial z^{2}}\left(z^{+}, \lambda\right)\left(\frac{d z^{+}}{d \lambda}\right)^{2}>0
\end{aligned}
$$

which proves that $h^{+}$is a strictly convex function of $\lambda$.
Theorem 5.6. $Y_{\max }$ is a strictly increasing convex function of $A$, and the following bounds hold for all $A$ :

$$
\begin{equation*}
\max \left(\frac{A}{\sqrt{1+\omega^{2}}}, \frac{A}{\omega} \frac{1}{\sqrt{1+\omega^{2}}}-\frac{T}{2}\left|f_{\min }\right|\right)<Y_{\max }<\frac{2 A}{\omega} . \tag{5.5}
\end{equation*}
$$

The first lower bound of $Y_{\max }$ is also a local estimate for small forcing levels $A \ll 1$

$$
\begin{equation*}
Y_{\max }=\frac{A}{\sqrt{1+\omega^{2}}}+\mathcal{O}\left(A^{2}\right) \tag{5.6}
\end{equation*}
$$

Proof. To analyse the evolution of $Y_{\max }$ in terms of $A$, we proceed in three steps. First, the phase portrait of $Y$ and the proposition 5.2 show that $Y(t, A)$ reaches its maximum value at a single time between $T / 4$ and $T / 2$. Secondly, the definition of $t_{Y_{\max }}$ and proposition 5.2 give

$$
\begin{aligned}
\frac{\partial^{2} Y}{\partial t^{2}}\left(t_{Y_{\max }}, A\right) & =f^{\prime}\left(Y_{\max }\right) \frac{\partial Y}{\partial t}\left(t_{Y_{\max }}, A\right)+A \omega \cos \omega t_{Y_{\max }} \\
& =A \omega \cos \omega t_{Y_{\max }}<0
\end{aligned}
$$

Thirdly, corollary 5.3 and proposition 4.4 yield $\frac{\partial Y}{\partial A}>0$ and $\frac{\partial Y^{2}}{\partial A^{2}}>0$ on $[T / 4, T / 2]$. The three hypotheses in lemma 5.5 are therefore satisfied, which proves the convex increasing of $Y_{\max }$ with $A$.

The bounds of $Y_{\max }$ are proved by building upper and lower solutions of $Y$, as in the proof of proposition 4.1, case 3. In $] t_{Y_{1}}, t_{Y_{\max }}$, proposition 5.2 ensures $Y>0$, which means that $f_{\min }<f(Y)<0$, and hence $f_{\min }+A \sin \omega t<\frac{d Y}{d t}<A \sin \omega t$. Integrating this inequality from $t_{Y_{1}}$ to $t_{Y_{\text {max }}}$ gives
$\frac{A}{\omega}\left(\cos \omega t_{Y_{1}}-\cos \omega t_{Y_{\max }}\right)+\left(t_{Y_{1}}-t_{Y_{\max }}\right)\left|f_{\min }\right|<Y_{\max }<\frac{A}{\omega}\left(\cos \omega t_{Y_{1}}-\cos \omega t_{Y_{\max }}\right)$.
Proposition 5.2 and corollary 5.3 (iii) give the bounds $T / 4<t_{Y_{\max }}<T / 2$ and $0<$ $t_{Y_{1}}<\theta / \omega$, and hence

$$
\left\{\begin{array}{l}
\cos \theta<\cos \omega t_{Y_{1}}<1 \\
0<-\cos \omega t_{Y_{\max }}<1
\end{array}\right.
$$

These inequalities, together with the definition of $\theta$ in (4.8), yield

$$
\frac{A}{\omega} \frac{1}{\sqrt{1+\omega^{2}}}<\frac{A}{\omega}\left(\cos \omega t_{Y_{1}}-\cos \omega t_{Y_{\max }}\right)<\frac{2 A}{\omega}
$$

Proposition 5.2 also gives $t_{Y_{1}}-t_{Y_{\max }}>-T / 2$, which gives the upper bound and a first lower bound in (5.5). The latter lower bound is not always an optimum bound: when $A<\frac{T}{2}\left|f_{\min }\right| \omega \sqrt{1+\omega^{2}}$, it is negative, whereas proposition 5.2 states that $Y_{\max }>0$ at all values of $A$. We therefore take advantage of the convex increasing of $Y_{\max }$ with $A$, which was previously proved. Since $Y_{\max }(0)=0$, then $Y_{\max }(A)$ is always above the straight line going through the origin with the slope $A Z\left(t_{Y_{\max }}\left(0^{+}\right), 0\right)$. Proposition 5.2 and equation (4.8) therefore give a second lower bound in (5.5). A second-order Taylor expansion of $Y_{\max }(A)$ proves that this lower bound is also the local estimate of $Y_{\max }$ when $A \ll 1$.

The evolution of $Y_{\max }$ stated in theorem 5.6 is shown in figure 5.4. If $\left|f_{\min }\right|<\infty$ and $\omega \neq 1$, the two lower bounds given in (5.5) intersect at $A=\frac{T}{2}\left|f_{\min }\right| \frac{\omega}{1-\omega} \sqrt{1+\omega^{2}}$. At higher values of $A$, the second lower bound is more relevant than the first one.

5.4. Maximum closure of the crack. Let

$$
Y_{\min }=Y\left(t_{Y_{\min }}\right)=\inf _{t \in[0, T]} Y(t)
$$

be the minimum value of the $T$-periodic solution $Y$.
Theorem 5.7. The following properties are satisfied by $Y_{\min }$ :
(i) for all $A$, we obtain the bounds:

$$
\begin{equation*}
-1<f^{-1}(A) \leq Y_{\min } \leq 0 \tag{5.7}
\end{equation*}
$$

(ii) at small forcing levels, we also obtain the local estimate

$$
\begin{equation*}
Y_{\min }=-\frac{A}{\sqrt{1+\omega^{2}}}+\mathcal{O}\left(A^{2}\right) \tag{5.8}
\end{equation*}
$$

(iii) at infinite forcing levels, the crack is completely closed:

$$
\lim _{A \rightarrow+\infty} Y_{\min }=-1
$$

Proof.
Property (i). Proposition 5.2 shows that $Y_{\min }$ is negative. As in the proof of proposition 5.1, the existence of the lower nonporous fence $f^{-1}(A)$ means that $Y_{\min } \geq$ $f^{-1}(A)$.

Property (ii). As in the proofs of proposition 5.1 and theorem 5.6, the local estimate when $A \ll 1$ follows from a second-order Taylor expansion of $Y$ and from (4.8).

Property (iii). First we consider the property $\overline{f(Y)}=0$ used in the proof of theorem 5.4. Evolution of $f$ in (3.10) and the definition of $t_{Y_{1}}, t_{Y_{2}}$ in proposition 5.2 give

$$
\begin{aligned}
0 & =\int_{0}^{t_{Y_{1}}} f(Y(\tau)) d \tau+\int_{t_{Y_{1}}}^{t_{Y_{2}}} f(Y(\tau)) d \tau+\int_{t_{Y_{2}}}^{T} f(Y(\tau)) d \tau \\
& =-\left(\int_{0}^{t_{Y_{1}}}|f(Y(\tau))| d \tau+\int_{t_{Y_{2}}}^{T}|f(Y(\tau))| d \tau\right)+\int_{t_{Y_{1}}}^{t_{Y_{2}}}|f(Y(\tau))| d \tau
\end{aligned}
$$

hence

$$
\begin{equation*}
\underbrace{\left(\int_{0}^{t_{Y_{1}}}|f(Y(\tau))| d \tau+\int_{t_{Y_{2}}}^{T}|f(Y(\tau))| d \tau\right)}_{I}=\underbrace{\int_{t_{Y_{1}}}^{t_{Y_{2}}}|f(Y(\tau))| d \tau}_{J} \tag{5.9}
\end{equation*}
$$

Secondly, let us consider the ODE

$$
\left\{\begin{array}{l}
\frac{d s}{d t}=-s+A \sin \omega t  \tag{5.10}\\
s\left(t_{Y_{1}}\right)=0
\end{array}\right.
$$

Straightforward calculations and property (iii) of corollary 5.3 give

$$
\begin{equation*}
s(t)=\frac{A}{\sqrt{1+\omega^{2}}}\left(\left|\sin \left(\omega t_{Y_{1}}-\theta\right)\right| e^{-\left(t-t_{Y_{1}}\right)}+\sin (\omega t-\theta)\right) \tag{5.11}
\end{equation*}
$$

with $\theta$ (4.8). Comparison between (3.10) and (5.10) shows that $s$ is a lower solution of $Y$ when $Y \geq 0: \forall t \in\left[t_{Y_{1}}, t_{Y_{2}}\right], Y(t) \geq s(t)$. Since $t_{Y_{\max }}<t_{Y_{2}}$, it follows from (5.9)
and (5.11) that

J & \geq \int_{t_{Y_{1}}}^{t_{Y_{\max }}}|f(Y(\tau))| d \tau \geq \int_{t_{Y_{1}}}^{t_{Y_{\max }}}|f(s(\tau))| d \tau \\
& \geq \frac{A}{\sqrt{1+\omega^{2}}} \int_{t_{Y_{1}}}^{t_{Y_{\max }}}\left(\left|\sin \left(\omega t_{Y_{1}}-\theta\right)\right| e^{-\left(\tau-t_{Y_{1}}\right)}+\sin (\omega \tau-\theta)\right) d \tau \\
& \geq \frac{A}{\sqrt{1+\omega^{2}}} \Delta
\end{aligned}
$$

with

$$
\Delta=\left|\sin \left(\omega t_{Y_{1}}-\theta\right)\right|\left(1-e^{\left(t_{Y_{\max }}-t_{Y_{1}}\right)}\right)+\frac{1}{\omega}\left(\cos \left(\omega t_{Y_{1}}-\theta\right)-\cos \left(\omega t_{Y_{\max }}-\theta\right)\right) .
$$

Proposition 5.2 and property (iii) of corollary 5.3 give

$$
\left\{\begin{array}{l}
1-e^{T / 2}<1-e^{\left(t_{Y_{\max }}-t_{Y_{1}}\right)}<1-e^{T / 4-\theta / \omega} \\
0<\left|\sin \left(\omega t_{Y_{1}}-\theta\right)\right|<\sin \theta \\
\frac{2 \cos \theta}{\omega}<\frac{1}{\omega}\left(\cos \left(\omega t_{Y_{1}}-\theta\right)-\cos \left(\omega t_{Y_{\max }}-\theta\right)\right)<\frac{1-\sin \theta}{\omega}
\end{array}\right.
$$

hence $\Delta$ is bounded independently of $A$. Finally, we obtain

$$
J \geq \frac{2 A}{\omega\left(1+\omega^{2}\right)}
$$

$J$ blows up when $A \rightarrow+\infty$. Equation (5.9) means that $I$ behaves in a similar way. Since $Y<0$ in $] 0, t_{Y_{1}}[\cup] t_{Y_{2}}, T[$ and given $f$ in (3.10), $Y$ must tend towards -1 when $A \rightarrow+\infty$, to make $I$ blow up, which concludes the proof.

The evolution of $Y_{\min }$ stated in theorem 5.7 is shown in figure 5.5. At moderate forcing levels (a), one cannot distinguish between $Y_{\min }$ and its lower bound. At higher forcing levels (b), one observes that $Y_{\min }$ is above its lower bound, as stated in theorem 5.7. Although no rigorous proof has been obtained so far, the numerical simulations indicate that $Y_{\min }$ decreases strictly as $A$ increases.

## 6. Generalization.

6.1. Periodic forcing. Most of the results obtained in sections 1 and 5 were based on the simple analytical expression of sinusoidal forcing. In the case of more general forcing, the key properties stated in proposition 5.2 and corollary 5.3 are lost, which makes it impossible to obtain estimates such as theorems 5.6 and 5.7. However, some properties are maintained if two assumptions are made about $S$ in (3.1): $T_{0^{-}}$ periodicity, and a null mean value. The latter assumption is physically meaningfull: as deduced from (3.7), a non-null mean value of $S$ results in an amplitude of $u_{I}$ that increases linearly with $t$.

Since the techniques required are the same as those used in the above sections, the derivations will be shortened. Setting the adimensionalized parameters and the functions as follows

$$
\begin{equation*}
A=\frac{1}{\beta d \rho_{0} c_{0}^{2}} \max _{t \in[0, T]}|S(t / \beta)|, \quad g(t)=\frac{S(t / \beta)}{\max _{t \in[0, T]}|S(t / \beta)|}, \quad T=\beta T_{0}, \quad f(y)=-\mathcal{F}(y) \tag{6.1}
\end{equation*}
$$

we obtain the model problem

$$
\left\{\begin{array}{l}
\frac{d y}{d t}=f(y)+A g(t)=F(t, y),  \tag{6.2}\\
f:]-1,+\infty[\rightarrow] f_{\min },+\infty\left[, \quad \lim _{y \rightarrow-1} f(y)=+\infty, \quad-\infty \leq f_{\min }<0,\right. \\
f(0)=0, \quad f^{\prime}(0)=-1, \quad f^{\prime}(y)<0<f^{\prime \prime}(y), \\
g(t+T)=g(t), \quad \bar{g}=0, \quad|g(t)| \leq 1, \quad \max _{t \in[0, T]}|g(t)|=1, \quad 0 \leq A<+\infty, \\
\left.y(0)=y_{0} \in\right]-1,+\infty[.
\end{array}\right.
$$

The isocline of zero slope of (6.2) is

$$
\begin{equation*}
I_{0}^{y}(t)=f^{-1}(-A g(t)) \tag{6.3}
\end{equation*}
$$

6.2. Periodic solution. The following result generalizes the proposition 4.1: since the same notations and processes are used, the proof is only sketched here.

Proposition 6.1. There is a unique T-periodic solution $Y(t)$ of (6.2), with $Y(0)=Y_{0}$. This solution is asymptotically stable.

Proof. Three cases can be distinguished.
Case 1: $A=0$. This case is identical to case 1 in proposition 4.1.
Case 2: $0<A<\left|f_{\text {min }}\right|$. Based on the funnel's theorem, the compact set

K_{0}=\left[f^{-1}(A), f^{-1}(-A)\right]

is invariant under the flow of $(6.2)$, and hence $\Pi\left(K_{0}\right) \subset K_{0}$. A fixed point argument shows the existence of a $T$-periodic solution $Y$. Equations (4.2) and (4.3) still hold: the uniqueness and attractivity of $Y$ are straightforward consequences of $f^{\prime}(y)<0$.

Case 3: $A \geq\left|f_{\min }\right|$. The isocline (6.3) is not defined when $\operatorname{Ag}(t) \geq-f_{\text {min }}$. In these cases, the invariant set deduced from the isocline is the non-compact set $\left[f^{-1}(A),+\infty[\right.$, which makes it impossible to apply the fixed point argument. To build a compact invariant set, we take $y>0$, which means that $f_{\min }+A g(t)<\frac{d y}{d t}<A g(t)$. As long as $y>0$, integration gives lower and upper solutions of $y$

$$
y_{0}+f_{\min } t+\int_{0}^{t} A g(\xi) d \xi<y(t)<y_{0}+\int_{0}^{t} A g(\xi) d \xi
$$

From the $T$-periodicity of $g$, it follows that

$$
y_{0}+f_{\min } T<y(T)<y_{0}
$$

It is then only necessary to bound $y_{0}$ to establish that $y>0$ on $[0, T]$. Setting

$$
g_{\min }=\min _{t \in[0, T]} g(t)<0
$$

the lower solution of $y$ gives

$$
y_{0}-t\left(\left|f_{\min }\right|+A\left|g_{\min }\right|\right) \leq y(t), \quad \forall t \in[0, T] .
$$

Taking $y_{0}>T\left(\left|f_{\min }\right|+A\left|g_{\text {min }}\right|\right)$ therefore gives $y>0$. The compact set

$$
K_{0}=\left[f^{-1}(A), 2 T\left(\left|f_{\min }\right|+A\left|g_{\min }\right|\right)\right]
$$

is therefore invariant under the Poincaré map, which completes the proof.
6.3. Mean dilatation of the crack. The next result extends the theorem 5.4. It shows that a positive jump in the mean elastic displacement still occurs.

Theorem 6.2. The mean value of the $T$-periodic solution $Y$ in (6.2) is positive and increases strictly with the forcing amplitude:

$$
\bar{Y}>0, \quad \frac{\partial \bar{Y}}{\partial A}>0
$$

At small forcing levels, we also obtain the local estimate

$$
\begin{equation*}
\bar{Y}=\frac{f^{\prime \prime}(0)}{2} \frac{A^{2}}{\overline{Z^{2}}(0)}+\mathcal{O}\left(A^{3}\right), \quad Z(t, 0)=e^{-t} \int_{0}^{t} e^{\xi} g(\xi) d \xi \tag{6.4}
\end{equation*}
$$

Proof. Based on the $T$-periodicity and the null mean value of $g$, the proof of theorem 5.4 can be straightforwardly extended. To prove the second inequality, we proceed in three steps. First, as stated in the proof of proposition 6.1, null forcing gives $Y=0$, and hence $\bar{Y}(0)=0$. Secondly, with $Y=0$, the $T$-periodic function $Z=\frac{\partial Y}{\partial A}$ satisfies the ODE

$$
\frac{d Z}{d t}=-Z+g(t)
$$

the $T$-solution of which is given in (6.4). The previous equation is integrated over $[0, T]$. $T$-periodicity of $Z$ and $\bar{g}=0$ mean that $\bar{Z}(0)=\bar{g} /\left|f^{\prime}(0)\right|=0$. Thirdly, the $T$-periodic function $W=\frac{\partial^{2} Y}{\partial A^{2}}=\frac{\partial Z}{\partial A}$ satisfies (4.9). The sign of $f^{\prime}$ and $f^{\prime \prime}$ in (6.2) show that the isocline of zero slope (4.10) is positive or null: $I_{0}^{W}(t)=0$ occurs only at points where $Z$ vanishes. The proof of proposition 4.4 therefore still holds here, yielding $W(t)>0$ at all $t \in[0, T]$. We therefore obtain $\bar{W}(A)>0$, and hence $\bar{Z}(A)>\bar{Z}(0)=0$, which proves the second inequality.

Lastly, a Taylor expansion of $Y$ when $A \ll 1$ gives

$$
\begin{aligned}
\bar{Y}(A) & =\bar{Y}(0)+A \frac{\partial \bar{Y}}{\partial A}(0)+\frac{A^{2}}{2} \frac{\partial^{2} \bar{Y}}{\partial A^{2}}(0)+\mathcal{O}\left(A^{3}\right) \\
& =\frac{A^{2}}{2} \bar{W}(0)+\mathcal{O}\left(A^{3}\right)
\end{aligned}
$$

Elementary calculations on (4.9) give

$$
\bar{W}(0)=\frac{f^{\prime \prime}(0)}{\left|f^{\prime}(0)\right|} \frac{1}{\overline{Z^{2}}(0)}, \quad Z(t, 0)=\int_{0}^{t} e^{f^{\prime}(0)(t-\xi)} g(\xi) d \xi
$$

where $Z$ is given in (6.4), which completes the proof.

## 7. Conclusion.

7.1. Physical observables. A set of adimensionalized parameters was used throughout this study. To recover the physical observables, we recall (3.9) and use the jump in the displacement across the crack $[u(\alpha, t)]=d y$. With a sinusoidal forcing (3.8), the results of physical interest are as follows.

- Theorem 5.4: mean dilatation of the crack

$$
\begin{align*}
& \overline{[u]}>0, \quad \frac{\partial \overline{[u]}}{\partial \frac{v_{0}}{\beta d}}>0 \\
& \overline{[u]}=\left|\mathcal{F}^{\prime \prime}(0)\right| \frac{v_{0}^{2}}{\beta^{2} d} \frac{1}{1+(\Omega / \beta)^{2}}+\mathcal{O}\left(\frac{v_{0}^{4}}{\beta^{4} d^{3}}\right) . \tag{7.1}
\end{align*}
$$

The main aim of the present study was to establish the validity of the inequalities in (7.1) with any set of parameters. In the case of model 1 (2.7), the local estimate obtained here matches the theoretical expression obtained in our previous study using a perturbation analysis method 13, with an improvement of one order of accuracy. Note that the local estimate with model 1 is twice that obtained with model 2 (2.8).

- Theorem 5.6: maximum aperture of the crack

$$
\begin{align*}
& \frac{\partial[u]_{\max }}{\partial \frac{v_{0}}{\beta d}}>0, \quad \frac{\partial^{2}[u]_{\max }}{\partial\left(\frac{v_{0}}{\beta d}\right)^{2}}>0 \\
& \max \left(\frac{2 v_{0}}{\beta} \frac{1}{\sqrt{1+(\Omega / \beta)^{2}}}, \frac{2 v_{0}}{\Omega} \frac{1+\Omega / \beta}{\sqrt{1+(\Omega / \beta)^{2}}}-\frac{2 \pi \beta d}{\Omega}\left|\mathcal{F}_{\max }\right|\right) \leq[u]_{\max } \leq \frac{4 v_{0}}{\Omega} \\
& {[u]_{\max }=\frac{2 v_{0}}{\beta} \frac{1}{\sqrt{1+(\Omega / \beta)^{2}}}+\mathcal{O}\left(\frac{v_{0}^{2}}{\beta^{2} d}\right)} \tag{7.2}
\end{align*}
$$

- Theorem 5.7: maximum closure of the crack

$$
\begin{align*}
& -d<d(-\mathcal{F})^{-1}\left(\frac{2 v_{0}}{\beta d}\right) \leq[u]_{\min } \leq 0 \\
& {[u]_{\min }=-\frac{2 v_{0}}{\beta} \frac{1}{\sqrt{1+(\Omega / \beta)^{2}}}+\mathcal{O}\left(\frac{v_{0}^{2}}{\beta^{2} d}\right),}  \tag{7.3}\\
& \lim _{\frac{v_{0}}{\beta d} \rightarrow+\infty}[u]_{\min }=-d
\end{align*}
$$

In the case of general periodic forcing with a null mean value (6.2), the inequalities presented in (7.1) still hold, and the local estimate of $\overline{[u]}$ is still proportional to $A^{2} / d$. It is worth noting that $[u]>0$ and $[u]_{\min }$ bounded are purely nonlinear phenomena: with the classical linear law (2.4), $\overline{[u]}=0$ and $[u]_{\text {min }}$ is not bounded independently of $v_{0}$.
7.2. Acoustic determination of the contact law. One of the applications of the present study is the characterization of the crack model. If [ $u$ ], the source, and the physical parameters of $\Omega_{0}$ and $\Omega_{1}$ are known, then the second equation in (7.1) provides a straightforward mean of determining $\left|\mathcal{F}^{\prime \prime}(0)\right| / d$. Note that the stiffness $K$, which is involved in $\beta$ via the proposition 3.1, is classically measured using acoustic methods 16]. It then suffices to measure [u]. For this purpose, two possible methods come to mind.

The first method consists in measuring the dilatation of the crack mechanically. This requires installing two strain gauges around the crack 11. However, in many contexts such as those encountered in geosciences, this is not practicable. The second method consists in performing acoustic measurements of the diffracted elastic waves far from the crack. The proposition 4.1 can be used here, by writing the Fourier series
of incident, reflected, and transmitted elastic displacements

$$
\begin{align*}
& u_{I}(x, t)=\frac{v_{0}}{\Omega}\left\{\cos \left(\Omega t-k_{0} x\right)-1\right\} \\
& u_{R}(x, t)=R_{0}^{a}+\sum_{n=1}^{\infty}\left\{R_{n}^{a} \sin n\left(\Omega t+k_{0} x\right)+R_{n}^{b} \cos n\left(\Omega t+k_{0} x\right)\right\}  \tag{7.4}\\
& u_{T}(x, t)=T_{0}^{a}+\sum_{n=1}^{\infty}\left\{T_{n}^{a} \sin n\left(\Omega t-k_{1} x\right)+T_{n}^{b} \cos n\left(\Omega t-k_{1} x\right)\right\}
\end{align*}
$$

where $k_{0}=\Omega / c_{1}$ and $k_{1}=\Omega / c_{1}$. Definition of $\overline{[u]}$ implies

$$
\begin{equation*}
\overline{[u]}=T_{0}^{a}-R_{0}^{a}+\frac{v_{0}}{\Omega} \tag{7.5}
\end{equation*}
$$

On the other hand, the causality of the source and the continuity of the stress (2.3) mean that

$$
\begin{equation*}
\rho_{1} c_{1} T_{0}^{a}+\rho_{0} c_{0} R_{0}^{a}=-\frac{\rho_{0} c_{0} v_{0}}{\Omega} \tag{7.6}
\end{equation*}
$$

Solving (7.5) and (7.6) gives

$$
\begin{align*}
& R_{0}^{a}=\frac{\rho_{1} c_{1}-\rho_{0} c_{0}}{\rho_{0} c_{0}+\rho_{1} c_{1}} \frac{v_{0}}{\Omega}-\frac{\rho_{1} c_{1}}{\rho_{0} c_{0}+\rho_{1} c_{1}} \overline{[u]}, \\
& T_{0}^{a}=\frac{-2 \rho_{0} c_{0}}{\rho_{0} c_{0}+\rho_{1} c_{1}} \frac{v_{0}}{\Omega}+\frac{\rho_{0} c_{0}}{\rho_{0} c_{0}+\rho_{1} c_{1}} \overline{[u] .} \tag{7.7}
\end{align*}
$$

Purely acoustic measurements of $R_{0}^{a}$ or $T_{0}^{a}$ therefore give $\overline{[u]}$, from which the nonlinear crack parameter can be easily determined.
7.3. Future lines of investigation. The monotonicity of $\mathcal{F}$ in (2.6) - or equivalently $f$ in (3.9) and (6.1) - was the key ingredient used here to prove the properties of the crack: the strict increasing of $\mathcal{F}$ - or the strict decreasing of $f$ - proves the uniqueness and attractivity of the periodic solution. In addition, the strict concavity of $\mathcal{F}$ - or the strict convexity of $f$ - shows that the mean value of the solution increases with the forcing parameter. Relaxing these hypotheses may lead to more complex situations, and require more sophisticated tools. One thinks for instance to the case of hysteretic models of interfaces [6].

Further studies are also needed on networks of nonlinear cracks 18]. These configurations frequently occur in applications. Direct numerical simulations have been carried out in [13], but a rigorous mathematical analysis is still required.
