A NEW GARSIDE STRUCTURE FOR BRAID GROUPS OF TYPE (e, e, r)

RUTH CORRAN AND MATTHIEU PICANTIN

ABSTRACT. We describe a new presentation for the complex reflection groups of type (e, e, r) and their braid groups. A diagram for this presentation is proposed. The presentation is a monoid presentation which is shown to give rise to a Garside structure. A detailed study of the combinatorics of this structure leads us to describe it as *post-classical*.

1. INTRODUCTION

A complex reflection group is a group acting on a finite-dimensional complex vector space, that is generated by complex reflections : non-trivial elements that fix a complex hyperplane in space pointwise. Any real reflection group becomes a complex reflection group if we extend the scalars from \mathbb{R} to \mathbb{C} . In particular all Coxeter groups or Weyl groups give examples of complex reflection groups. A general problem is to generalise to complex reflection groups as much as possible from the theory of Weyl groups and Coxeter groups.

For instance, according to Broué–Malle–Rouquier [BMR], one can define the braid group $\mathbf{B}(W)$ attached to a complex reflection group $\mathbf{G}(W)$ as the fundamental group of the space of regular orbits. When $\mathbf{G}(W)$ is real, the braid group $\mathbf{B}(W)$ is well understood owing to Brieskorn's presentation theorem and the subsequent structural study by Deligne and Brieskorn–Saito [Br, Del, BS] : their main combinatorial results express that $\mathbf{B}(W)$ is the group of fractions of a monoid in which divisibility has good properties, and, in addition, there exists a distinguished element whose divisors encode the whole structure : in modern terminology, such a monoid is called Garside. The group of fractions of a Garside monoid is called a Garside group. Garside groups enjoy many remarkable group-theoretical, cohomological and homotopy-theoretical properties. Find (possibly various) Garside structures for a given group becomes a natural challenge.

1.1. The groups G(e, e, r) and B(e, e, r). The classification of (irreducible) finite complex reflection groups was obtained by Shephard and Todd [ST] :

- an infinite family $\mathbf{G}(de, e, r)$ where d, e, r are arbitrary positive integral parameters;
- 34 exceptions, labelled $\mathbf{G}_4, \ldots, \mathbf{G}_{37}$.

The infinite family includes the four infinite families of finite Coxeter groups : $\mathbf{G}(1, 1, r) \sim \mathbf{G}(A_{r-1})$, $\mathbf{G}(2, 1, r) \sim \mathbf{G}(B_r)$, $\mathbf{G}(2, 2, r) \sim \mathbf{G}(D_r)$ and $\mathbf{G}(e, e, 2) \sim \mathbf{G}(I_2(e))$. For all other values of the parameters, $\mathbf{G}(de, e, r)$ is an irreducible monomial complex reflection group of rank r, with no real structure.

In the infinite family, one may consider, in addition to the real groups, the complex subfamily $\mathbf{G}(e, e, r)$ —note that this subseries contains the D-type and I_2 -type Coxeter series—and our objects of interest are the possible Garside structures for the braid group $\mathbf{B}(e, e, r)$.

The reflection groups of type (e, e, r) are defined in terms of positive integral parameters e, r:

$$\mathbf{G}(e, e, r) = \left\{ \begin{array}{c} r \times r \text{ monomial matrices} \\ (x_{ij}) \text{ over } \{0\} \cup \mu_e \end{array} \middle| \prod_{x_{ij} \neq 0} x_{ij} = 1 \right\},$$

that is, as the group of $r \times r$ matrices consisting of :

- monomial matrices (each row and column has a unique non-zero entry),
- with all non-zero entries lying in μ_e , the *e*-th roots of unity, and
- for which the product of the non-zero entries is 1.

The group $\mathbf{G}(e, e, r)$ is generated by reflections of \mathbb{C}^r . There are hyperplanes in \mathbb{C}^r corresponding to the reflections of the reflection group.

The corresponding *braid group* $\mathbf{B}(e, e, r)$ is defined in terms of the fundamental group of a quotient of the hyperplane complement. We do not make recourse to this definition ; our starting point will be known presentations for these braid groups.

1.2. Broué–Malle–Rouquier presentation. Such a presentation for the braid group $\mathbf{B}(e, e, r)$ may be found in [BMR] :

• Generators : $\{t_0, t_1\} \cup S_r$ with $S_r = \{s_3, \dots, s_r\}$, and

• Re	elations :	
(R_1)	$s_i s_j s_i = s_j s_i s_j$	for $ i - j = 1$,
(R_2)	$s_i s_j = s_j s_i$	for $ i - j > 1$,
(P_1)	$\langle t_1 t_0 \rangle^e = \langle t_0 t_1 \rangle^e$	
(P_2)	$s_3 t_i s_3 = t_i s_3 t_i$	for $i = 0, 1,$
(P_3)	$s_j t_i = t_i s_j$	for $i = 0, 1$, and $4 \le j \le r$, and
(P_4)	$(s_3 t_1 t_0)^2 = (t_1 t_0 s_3)^2,$	

where $\langle ab \rangle^e$ denotes the alternating product of a and b with e terms. The collections of relations (R_1) and (R_2) are the usual braid relations on those generators in S_r .

Furthermore, it is shown in [BMR] that by adding the relation $a^2 = 1$ for all generators a, a presentation for the reflection group $\mathbf{G}(e, e, r)$ is obtained. The generators in this case are all reflections in $\mathbf{G}(e, e, r)$.



FIGURE 1. The diagram of type (e, e, r) by [BMR].

A diagram shown in Figure 1 is proposed in [BMR] for this presentation. This diagram is interpreted, where possible, as a Coxeter diagram. The vertices correspond to generators, and the edges to relations : for each pair of vertices a and b,

- no edge connecting the vertices corresponds to a relation ab = ba,
- an unlabelled edge connecting the vertices corresponds to aba = bab,
- an edge labelled e connecting the vertices corresponds $\langle ab \rangle^e = \langle ba \rangle^e$.

The first two of these give the usual braid relations and the relations (P_2) and (P_3) ; the third gives the relation (P_1) . It remains to interpret the triangle with short double-line in the interior; in the diagram above, this represents the relation (P_4) : $s_3(t_1t_0)s_3(t_1t_0) = (t_1t_0)s_3(t_1t_0)s_3$. (This would be a relation corresponding to an edge labelled 4 between nodes s_3 and t_1t_0 , if the latter were a node. Conventionally, edges labelled by 4 in Coxeter diagrams are designated by double-lines.)

In the case of finite real reflection groups—that is, finite Coxeter groups an enormous amount of understanding about the reflection and braid groups arises from the Coxeter presentations coming from the choice of generators corresponding to a simple set of roots in a root system. In this paper we describe presentations of the reflection groups $\mathbf{G}(e, e, r)$ and their braid groups $\mathbf{B}(e, e, r)$ which have some properties like those of Coxeter presentations. 1.3. Classical vs dual braid monoids. The success of [BKL] about an alternative braid monoid for the ordinary braid group $\mathbf{B}(A_{n-1})$ provided the impetus to unify the different approaches by introducing a general framework : the Garside theory (see [DP, D2, BDM, B2]). This terminology refers to the fact that, although dealing only with the ordinary *n*-strand braid group $\mathbf{B}(A_{n-1})$, the pioneer paper by Garside [G] stands out in which the foundation is laid for a more systematic study of the divisibility theory in a well-chosen submonoid of the braid group.

Garside structures (see Subsection 3.1 for details) are desirable because they allow fast calculation in the group (solution to word and conjugacy problems) by convenient canonical or normal forms. A given Garside group admits possibly several Garside structures, each providing an associated biautomatic structure, etc. Known examples of Garside groups are braid groups, torus link groups, one-relator groups with center, etc. In the particular case which concerns us here, that is, in the case of braid groups, two Garside structures—when defined—seem to be most natural : we will use here the term of *classical braid monoid* (short for Artin–Brieskorn–Deligne–Garside–Saito–Tits monoid) and the term of *dual braid monoid* proposed by Bessis in [B2] (corresponding to those monoids studied in [BKL, B2, P, BC1, BC2, ...]. Given a reflection group $\mathbf{G}(de, e, r)$, when defined and when no confusion is possible, we will write $\mathbf{B}^+(de, e, r)$ for the classical braid monoid and $\mathbf{B}^{\times}(de, e, r)$ for the dual braid monoid.

The presentation in [BMR] does *not* give rise to a Garside structure¹. A presentation giving rise to a Garside monoid for $\mathbf{B}(e, e, r)$ was obtained in [BC2]; this monoid fits into the context of dual braid monoids and will be denoted by $\mathbf{B}^{\times}(e, e, r)$. In that case, the generators are in bijection with the reflections in $\mathbf{G}(e, e, r)$. In this paper we introduce a new presentation for $\mathbf{B}(e, e, r)$ which again gives rise to a Garside monoid, but which has more in common with the classical braid monoids than the dual braid monoids.

The organization of the rest part of the paper is as follows. In Section 2, a new presentation (with an associated diagram) for $\mathbf{B}(e, e, r)$ is shown (Theorem 2.1). In Section 3 we prove that this new presentation gives rise to a Garside monoid $\mathbf{B}^{\oplus}(e, e, r)$ (Theorem 3.2). The underlying Garside structure is then investigated (Theorem 3.7). Finally, this allows us to situate $\mathbf{B}^{\oplus}(e, e, r)$ as well as possible with respect to the dichotomy between classical and dual braid monoids (Subsection 3.4).

¹In particular, this presentation can be viewed as a monoid presentation ; now the associated monoid is not cancellative, so does not embed in a group (see [Co, BC2]).

2. A NEW PRESENTATION

In this section we first introduce the new presentation for the braid group $\mathbf{B}(e, e, r)$, propose a diagram for the presentation, and then discuss its relationship to the reflection group and to other braid groups. Finally, after considering the notion of circle, we prove that the given presentation does present the group $\mathbf{B}(e, e, r)$.

2.1. New presentation of type (e, e, r). Let $\mathcal{P}^{\oplus}(e, e, r)$ denote the presentation given by :

- Generators : $T_e \cup S_r$ with $T_e = \{t_i \mid i \in \mathbb{Z}/e\}$ and $S_r = \{s_3, \ldots, s_r\}$, and
- Relations :

$$\begin{array}{ll} (R_1) & s_i s_j s_i = s_j s_i s_j & \text{for } |i-j| = 1, \\ (R_2) & s_i s_j = s_j s_i & \text{for } |i-j| > 1, \\ (R_3) & s_3 t_i s_3 = t_i s_3 t_i & \text{for } i \in \mathbb{Z}/e, \\ (R_4) & s_j t_i = t_i s_j & \text{for } i \in \mathbb{Z}/e \text{ and } 4 \le i \le r, \text{ and} \\ (R_5) & t_i t_{i-1} = t_j t_{j-1} & \text{for } i, j \in \mathbb{Z}/e. \end{array}$$

We will show in Subsection 2.4:

Theorem 2.1. The presentation $\mathcal{P}^{\oplus}(e, e, r)$ is a group presentation for the braid group $\mathbf{B}(e, e, r)$. Furthermore, adding the relations $a^2 = 1$ for all generators a gives a presentation of the reflection group $\mathbf{G}(e, e, r)$. In particular, the generators of this presentation are all reflections.

The new generating set is a superset of the generating set of [BMR]. The new generators t_i for $2 \le i \le e - 1$ may be defined inductively by $t_i = t_{i-1}t_{i-2}t_{i-1}^{-1}$, and so are just conjugates of the original generators.

The presentation $\mathcal{P}^{\oplus}(e, e, r)$ can be viewed as a monoid presentation. The corresponding monoid $\mathbf{B}^{\oplus}(e, e, r)$ will be the starting point for constructing the Garside structure for $\mathbf{B}(e, e, r)$, and we will see :

Proposition 2.2. The submonoid of $\mathbf{B}(e, e, r)$ generated by $T_e \cup S_r$ is isomorphic to the monoid $\mathbf{B}^{\oplus}(e, e, r)$, that is, it can be presented by $\mathcal{P}^{\oplus}(e, e, r)$ considered as a monoid presentation.

2.2. New diagram of type (e, e, r). We propose the diagram shown in Figure 2 as a type (e, e, r) analogy to the Coxeter diagrams for the real reflection group case.

This diagram is again to be read as a Coxeter diagram where possible, that is, when vertices a and b are joined by an (unlabelled) edge, there is a relation aba = bab. The circle with e vertices at the left of the diagram corresponds to the circle $\{t_i \mid i \in \mathbb{Z}/e\}$ (see Subsection 2.4.1).



FIGURE 2. The new diagram of type (e, e, r): there are e nodes on the circle.

Whenever two vertices a and b lie on this circle, there is a relation of the form $aa^{\downarrow} = bb^{\downarrow}$ where a^{\downarrow} and b^{\downarrow} are the nodes immediately preceding a and b respectively on the circle. If two nodes a and b are neither connected by an edge nor both lie on the disc, then there is a relation of the form ab = ba—that is, the corresponding generators commute.

The diagram automorphism \downarrow and its inverse \uparrow . Define the map \downarrow by $s_j^{\downarrow} = s_j$ for all $3 \leq j \leq r$ and $t_i^{\downarrow} = t_{i-1}$ for all $i \in \mathbb{Z}/e$. Since $\rho_1^{\downarrow} = \rho_2^{\downarrow}$ itself is a defining relation whenever $\rho_1 = \rho_2$ is a defining relation, then \downarrow is a well-defined monoid morphism of $\mathbf{B}^{\oplus}(e, e, r)$. Furthermore, since the whole set of relations defining $\mathbf{B}^{\oplus}(e, e, r)$ is stable under \downarrow , the map \downarrow is an automorphism of $\mathbf{B}^{\oplus}(e, e, r)$. The automorphism \downarrow rotates the circle in the negative direction by a turn of $\frac{2\pi}{e}$. The same can be said for its inverse \uparrow . These diagram automorphisms give rise to automorphisms of the braid group $\mathbf{B}(e, e, r)$ as well as of the reflection group $\mathbf{G}(e, e, r)$. Moreover, these diagram automorphisms send (braid) reflections to (braid) reflections.

Proposition 2.3. The \downarrow -trivial subgroup of the braid group $\mathbf{B}(e, e, r)$ is isomorphic to the braid group $\mathbf{B}(B_{r-1})$.

Proof. The proof follows the one of [DP, Proposition 9.4].

The diagram antiisomorphism rev. Let $\operatorname{rev}(\mathcal{P}^{\oplus}(e, e, r))$ denote the presentation on the same generators as $\mathcal{P}^{\oplus}(e, e, r)$, and relations obtained by reversing all its relations. This presentation has a diagram corresponding to the mirror image of the diagram for $\mathcal{P}^{\oplus}(e, e, r)$. Let $\operatorname{rev}(\mathbf{B}^{\oplus}(e, e, r))$ be the monoid defined by $\operatorname{rev}(\mathcal{P}^{\oplus}(e, e, r))$.

Lemma 2.4. The monoid $\mathbf{B}^{\oplus}(e, e, r)$ is isomorphic to rev $(\mathbf{B}^{\oplus}(e, e, r))$ by the isomorphism φ which sends $t_i \mapsto t_{-i}$ and $s_j \mapsto s_j$. *Proof.* The map φ permutes the generators $T_e \cup S_r$, and is bijective between the relations of $\mathcal{P}^{\oplus}(e, e, r)$ and those of $\operatorname{rev}(\mathcal{P}^{\oplus}(e, e, r))$: the latter is clear for all types of relation possibly except (R_5) , and in this case we find :

$$\varphi(t_i t_{i-1}) = t_{-i} t_{1-i} =_{\operatorname{rev}(\mathcal{R})} t_{-i} t_{1-j} = \varphi(t_j t_{j-1}).$$

So φ is a well-defined monoid homomorphism, which is both surjective (as it permutes the generators) and injective (as it is bijective on the relations). Hence it is an isomorphism of monoids.

Thus 'mirror flipping' the diagram corresponds to a group isomorphism but not an equality, unlike for braid groups of Coxeter groups, this diagram morphism does not give rise to an automorphism of $\mathbf{B}(e, e, r)$.

2.3. Natural maps between different types. Parabolic subgroups of (braid groups of) Coxeter groups may be realized by considering subdiagrams of the corresponding diagrams. We describe here parabolics of type (e, e, r) and the corresponding subdiagrams of the diagram shown on Figure 2, as well as maps which arise by taking diagram quotients instead.

2.3.1. Maps related to parabolic subdiagrams. Following [BMR], for a given diagram, let us consider the equivalence relation between nodes defined by $s \sim s$ and for $s \neq t$

 $s \sim t \Leftrightarrow s$ and t are not in a homogeneous relation with support $\{s, t\}$.

Then, for the diagram of Figure 2, the equivalence classes have 1 or e elements and that there is at most one class with e elements.

An *admissible subdiagram* is a full subdiagram of the same type, that is, with 1 or e elements per class.

An admissible subdiagram of a diagram of type (e, e, r) is a union of a diagram of type (e_0, e_0, r_0) and of k diagram of type $(1, 1, r_i)$ with $e_0 \in \{0, 1, e\}$ and $\sum_{i=0}^{k} r_i \leq r$.

Particular examples are considered below, which show the relationship with braid groups of some real reflection groups.

- $\mathcal{P}^{\oplus}(e, e, r')$ with $r' \leq r$: the case of 'chopping off the tail' of the parachute. This corresponds to reducing the dimension from r to r'. A special case of this is $\mathcal{P}^{\oplus}(e, e, 2)$, where the whole tail is chopped off, leaving only the circle : this is a presentation of the dual braid monoid $\mathbf{B}^{\times}(I_2(e))$ (see Remark 1 on page 10).
- $\mathcal{P}^{\oplus}(0,0,r)$ is a presentation of the classical braid monoid $\mathbf{B}^+(A_{r-2})$.
- $\mathcal{P}^{\oplus}(1, 1, r)$ is a presentation of the classical braid monoid $\mathbf{B}^+(A_{r-1})$.
- $\mathcal{P}^{\oplus}(2,2,r)$ is a presentation of the classical braid monoid $\mathbf{B}^+(D_r)$.

These sub-presentations will be used in Subsection 3.2.1 in the context of cube condition calculations.

2.3.2. Maps related to foldings (diagram quotients).

- (1) Epimorphism $\mathbf{B}(e_2, e_2, r) \to \mathbf{B}(e_1, e_1, r)$ for e_1 dividing e_2 . The map induced by $t_j \mapsto t_{j \mod e_1}$ and $s_j \mapsto s_j$ defines an epimorphism $\nu : \mathbf{B}(e_2, e_2, r) \to \mathbf{B}(e_1, e_1, r)$. There is an analogous map between the corresponding monoids and reflection groups. This corresponds to a folding of the 'parachute' part of the diagram.
- (2) Type B embedding : $\mathbf{B}(2, 1, r-1) \hookrightarrow \mathbf{B}(e, e, r)$.

The type (2, 1, r - 1) corresponds to the Artin-Tits/Coxeter type B_{r-1} . The associated Coxeter diagram is :

(the double bar between nodes labelled q_1 and q_2 is equivalent to an edge labelled 4).

Whether an easy adaptation of [Cr, Lemma 1.2 & Theorem 1.3] or a direct application of [D1, Proposition 5.4], several embedding criteria can be applied successfully within the current framework. We obtain that the map induced by $q_1 \mapsto t_i t_{i-1}$ and $q_j \mapsto s_{j+1}$ for j > 1 gives rise to an injection $\mathbf{B}^+(B_{r-1}) \hookrightarrow$ $\mathbf{B}^{\oplus}(e, e, r)$, hence an injection $\mathbf{B}(B_{r-1}) \hookrightarrow \mathbf{B}(e, e, r)$. This will be used in Subsection 3.2.2.

2.4. The new presentation is B(e, e, r). Our aim in this subsection is to prove the theorem announced in the opening subsection :

Theorem 2.1. The presentation $\mathcal{P}^{\oplus}(e, e, r)$ is a group presentation for the braid group $\mathbf{B}(e, e, r)$. Furthermore, adding the relations $a^2 = 1$ for all generators a gives a presentation of the reflection group $\mathbf{G}(e, e, r)$. In particular, the generators of this presentation are all reflections.

We will use the presentation of [BMR] as our starting point, given on page 2. To this presentation we will add generators t_i for $2 \leq i \leq e$ corresponding to conjugates of t_0 and t_1 which may be defined inductively by :

$$t_i = t_{i-1} t_{i-2} t_{i-1}^{-1}$$
 for $i \ge 2$.

We then verify that the new relations given are both necessary and sufficient. To do this, we introduce the notion of a *circle of elements* in a group, as $T_e = \{t_i \mid i \in \mathbb{Z}/e\}$ turns out to be the circle on (t_1, t_0) in $\mathbf{B}(e, e, r)$.

2.4.1. Circles of elements in a group. Let G be a group and g_1, g_0 elements of G. Define elements g_i for $i \in \mathbb{Z}$ inductively by :

$$g_i = \begin{cases} g_{i-1}g_{i-2}g_{i-1}^{-1} & \text{if } i > 1, \text{ and} \\ g_{i+1}^{-1}g_{i+2}g_{i+1} & \text{if } i < 0. \end{cases}$$

Then for all $i, j \in \mathbb{Z}$, the relation

$$g_i g_{i-1} = g_j g_{j-1}$$

is satisfied. The element thus represented is g_1g_0 ; denote it by γ , and call it the *disk element*. We call the set $\{g_i | i \in \mathbb{Z}\}$ the *circle of elements* on (g_1, g_0) , and denote it $C(g_1, g_0)$. Observe that for any $i \in \mathbb{Z}$,

$$g_i = \gamma g_{i-1}^{-1} = g_{i+1}^{-1} \gamma.$$

Conversely, suppose that a group has a set of elements $K = \{h_i | i \in \mathbb{Z}\}$ (possibly with doubling up, that is, with $h_i = h_j$ for distinct i and j) such that $h_i h_{i-1} = h_j h_{j-1}$ for all $i, j \in \mathbb{Z}$. Then K is $C(h_p, h_{p-1})$ for any $p \in \mathbb{Z}$.

From now on, suppose that $C(g_1, g_0)$ is a circle with disk element γ .

Lemma 2.5. We have $\gamma g_i = g_{i+2}\gamma$ for all $i \in \mathbb{Z}$.

Proof. For all $i \in \mathbb{Z}$, we have $\gamma g_i = g_{i+2}g_{i+1}g_i = g_{i+2}\gamma$.

In general, the circle of elements obtained may be infinite : for example, in the rank two free group generated by $\{g_1, g_0\}$, the circle $C(g_1, g_0)$ is infinite. Obviously, if the group is finite, then any circle of elements is finite.

Lemma 2.6. If there exist $p \in \mathbb{Z}$ and $e \in \mathbb{N}$ satisfying $g_p = g_{p+e}$, then we have $g_i = g_{i+e}$ for all $i \in \mathbb{Z}$, and $|C(g_1, g_0)|$ divides e.

Proof. The proof goes by induction in two directions. Suppose first $q \ge p$ and $g_j = g_{j+e}$ for all j with $p \le j \le q$. Then we have $g_{q+1} = \gamma g_q^{-1} = \gamma g_{q+e}^{-1} = g_{q+e+1}$, so the result is true for all $j \ge p$. Similarly, for $q \le p$, $g_j = g_{j+e}$ for all $j \ge q$ implies $g_{q-1} = g_q^{-1}\gamma = g_{q+e}^{-1}\gamma = g_{q+e-1}$. Thus $C(g_1, g_0)$ is $\{g_i \mid i \in \mathbb{Z}/e\}$ and is of cardinality dividing e.

Lemma 2.7. The circle $C(g_1, g_0)$ is of finite cardinality if and only if $\langle g_1 g_0 \rangle^e = \langle g_0 g_1 \rangle^e$ holds for some $e \in \mathbb{N}$. The smallest e for which this relation holds is the cardinality of $C(g_1, g_0)$.

Proof. Suppose first $|C(g_1, g_0)| = e < \infty$. So $g_i = g_{i+e}$ holds for all $i \in \mathbb{Z}/e$. Using Lemma 2.5 above, we find, for e odd,

$$\langle g_1 g_0 \rangle^e = \gamma^{\frac{e-1}{2}} g_1 = g_{1+e-1} \gamma^{\frac{e-1}{2}} = g_0 \langle g_1 g_0 \rangle^{\frac{e-1}{2}} = \langle g_0 g_1 \rangle^e,$$

and, for e even,

$$\langle g_0 g_1 \rangle^e = g_0 \gamma^{\frac{e-2}{2}} g_1 = g_0 g_{1+e-2} \gamma^{\frac{e-2}{2}} = g_0 g_{-1} \gamma^{\frac{e-2}{2}} = \gamma^{\frac{e}{2}} = \langle g_1 g_0 \rangle^e.$$

Now assume that g_1, g_0 are elements satisfying $\langle g_1 g_0 \rangle^e = \langle g_0 g_1 \rangle^e$. We show

$$g_q = \langle g_1 g_0 \rangle^q \left(\langle g_1 g_0 \rangle^{q-1} \right)^{-1}$$

by induction on q > 1. It is certainly true for q = 1 and q = 2. Suppose $q \ge 2$. Then we obtain :

$$\begin{array}{rcl} g_{q+1} &=& g_q g_{q-1} g_q^{-1} \\ &=& \langle g_1 g_0 \rangle^q \big(\langle g_1 g_0 \rangle^{q-1} \big)^{-1} \langle g_1 g_0 \rangle^{q-1} \big(\langle g_1 g_0 \rangle^{q-2} \big)^{-1} \langle g_1 g_0 \rangle^{q-1} \big(\langle g_1 g_0 \rangle^q \big)^{-1} \\ &=& \langle g_1 g_0 \rangle^q \big(\langle g_1 g_0 \rangle^{q-2} \big)^{-1} \langle g_1 g_0 \rangle^{q-1} \big(\langle g_1 g_0 \rangle^q \big)^{-1} \\ &=& \langle g_1 g_0 \rangle^2 \langle g_1 g_0 \rangle^{q-1} \big(\langle g_1 g_0 \rangle^q \big)^{-1} \\ &=& \langle g_1 g_0 \rangle^2 \langle g_1 g_0 \rangle^{q-1} \big(\langle g_1 g_0 \rangle^q \big)^{-1} \\ &=& \langle g_1 g_0 \rangle^{q-1} \big(\langle g_1 g_0 \rangle^q \big)^{-1} \\ \end{array}$$

which concludes the induction. In particular, we find

$$g_e = \langle g_1 g_0 \rangle^e (\langle g_1 g_0 \rangle^{e-1})^{-1} = \langle g_0 g_1 \rangle^e (\langle g_1 g_0 \rangle^{e-1})^{-1} = g_0,$$

so by Lemma 2.6, $g_q = g_{q+e}$ holds for all $q \in \mathbb{Z}$ and $|C(g_1, g_0)|$ divides e.

Remark 1. Having as reflection group the dihedral group of order 2e, the braid group $\mathbf{B}(I_2(e))$ can be presented by $\langle a, b | \langle ab \rangle^e = \langle ba \rangle^e \rangle$. This presentation gives rise to a Garside structure (see Subsection 3.1 for details about Garside structures; this fact was proved in [BS, Del]) corresponding to the classical braid monoid $\mathbf{B}^+(I_2(e))$. Lemma 2.7 implies the known fact that $\mathbf{B}(I_2(e))$ also has the presentation $\langle a_i, i \in \mathbb{Z}/e |$ $a_i a_{i-1} = a_j a_{j-1}$ for all $i, j \in \mathbb{Z}/e \rangle$, which gives rise to an alternative Garside structure, corresponding to the dual braid monoid $\mathbf{B}^{\times}(I_2(e))$.

Lemma 2.8. Every element b satisfying $bg_i = g_i b$ for $i \in \{0, 1\}$ satisfies $bg_i = g_i b$ for all $i \in \mathbb{Z}$.

Proof. Clearly, all the elements of $C(g_1, g_0)$ lie in the subgroup generated by g_1 and g_0 . Thus if there is an element which commutes with g_1 and g_0 , then it commutes with the entire circle.

The last property below describes how certain relations on g_1 and g_0 may be extended to the entire circle $C(g_1, g_0)$.

Lemma 2.9. Every element a satisfying $ag_i a = g_i ag_i$ for $i \in \{0, 1\}$ satisfies

(a) $ag_i a = g_i ag_i$ for all $i \in \mathbb{Z}$, and (b) $a\gamma a\gamma = \gamma a\gamma a$.

Proof. (a) The proof is again by induction in two directions. We prove the case $i \ge 1$, the case i < 0 is similar. Using only the relations of the

form $g_i g_{i-1} = g_j g_{j-1}$ and those of the form $g_j a g_j = a g_j a$ for $0 \le j \le i$, we have (see Figure 3)

$$\begin{array}{rclcrcl} g_{i+1}ag_{i+1}^{-1} &=& g_ig_{i-1}g_i^{-1}ag_ig_{i-1}^{-1}g_i^{-1} \\ &=& g_ig_{i-1}ag_ia^{-1}g_{i-1}^{-1}g_i^{-1} \\ &=& g_ig_{i-1}ag_{i-1}g_{i-2}g_{i-1}^{-1}a^{-1}g_{i-1}^{-1}g_i^{-1} \\ &=& g_iag_{i-1}ag_{i-2}a^{-1}g_{i-1}^{-1}a^{-1}g_i^{-1} \\ &=& g_iag_{i-1}g_{i-2}^{-1}ag_{i-2}g_{i-1}^{-1}a^{-1}g_i^{-1} \\ &=& g_iag_i^{-1}g_{i-1}ag_{i-1}^{-1}g_ia^{-1}g_i^{-1} \\ &=& a^{-1}g_iaa^{-1}g_{i-1}a^{-1}g_i^{-1}a \\ &=& a^{-1}g_{i-1}aa^{-1}g_i^{-1}a \end{array}$$



FIGURE 3. Proof of $g_{i+1}ag_{i+1} = ag_{i+1}a$. The word $g_{i+1}ag_{i+1}$ can be read around the top, the word $ag_{i+1}a$ around the bottom. The positive relations can be read in opposite directions, starting from the corner of a given cell with the \bullet symbol.

(b) By the first part we have $g_2ag_2 = ag_2a$. We find (see Figure 4)

$$a\gamma a\gamma = ag_1g_0ag_1g_0 = ag_2g_1ag_1g_0 = ag_2ag_1ag_0 = g_2ag_2g_1ag_0$$

= $g_2ag_1g_0ag_0 = g_2g_1ag_1g_0a = g_1g_0ag_1g_0a = \gamma a\gamma a.$

2.4.2. *Proof of Theorem 2.1.* We now have enough to prove the theorem.



FIGURE 4. Proof of $\gamma a \gamma a = a \gamma a \gamma$. The word $\gamma a \gamma a$ can be read starting at the left around the top, the word $a \gamma a \gamma$ around the bottom. The interior cells are bounded by relators.

Proof of Theorem 2.1. Let J denote the group presented by $\mathcal{P}^{\oplus}(e, e, r)$. Relation (R_5) says that T_e is the circle $C(t_1, t_0)$. By Lemma 2.7, (P_1) holds in J. By definition, Relation (P_2) (resp. (P_3)) is a particular case of (R_3) (resp. (R_4)). Relation (P_4) is precisely a case of Lemma 2.9(b) with $a = s_3$. Thus all the relations of $\mathbf{B}(e, e, r)$ hold in J.

On the other hand, (P_1) says that if $T = \{t_i | i \in \mathbb{Z}\} = C(t_1, t_0)$ holds in $\mathbf{B}(e, e, r)$, then by Lemma 2.7, $t_i = t_{i+e}$ holds for all i, which implies (R_5) . Lemma 2.9(a) implies that (R_3) then holds for all $t_i \in T$. Lemma 2.8 ensures that (R_4) holds. Thus J and $\mathbf{B}(e, e, r)$ are isomorphic.

The new presentation has the same generators as the original, as well as some conjugates of the originals. Since it is the case for the presentation in [BMR], adding the relations $a^2 = 1$ for all generators a in the new presentation gives a presentation of the reflection group $\mathbf{G}(e, e, r)$. Since conjugates of reflections are reflections, the generators of this presentation are all reflections. Denote by - the natural map $\mathbf{B}(e, e, r) \rightarrow$ $\mathbf{G}(e, e, r)$. The generating reflections in the new presentation of $\mathbf{G}(e, e, r)$ are the matrices :

$$\overline{t_i} = \begin{pmatrix} 0 & \zeta_e^{-i} & 0 \\ \zeta_e^i & 0 & \\ \hline & & \\ 0 & & I_{r-2} \end{pmatrix} \quad \text{and} \quad \overline{s_j} = \text{ matrix of } (j-1 \quad j),$$

where ζ_e is a primitive *e*-th root of unity.

3. A NEW GARSIDE STRUCTURE

In this section, we first give a proof that the monoid $\mathbf{B}^{\oplus}(e, e, r)$ defined by the presentation studied in the previous section—is a Garside monoid. Then we find a precise description of the combinatorics of the underlying Garside structure. Finally we produce some arguments in order to convince the reader that this structure could be named post-classical.

3.1. Background on Garside theory. In this preliminary subsection, we list some basic definitions and summarize results by Dehornoy & Paris about Garside theory. For all the results quoted here, we refer the reader to [DP, D1, D2, D4].

For x, y in a monoid M, write $x \preccurlyeq y$ if there exists $z \in M$ satisfying xz = y, and say either that x left-divides y or that y is a right multiple of x.

There are similar definitions for right division and left multiplication (with the notation $y \succeq x$ if there exists z satisfying y = zx). Write $x \lor y$ for the right lcm of x and y, and write $x \land y$ for the left gcd. When M is cancellative, elements $(x \lor y)$ and $(y \lor x)$ are uniquely defined by :

$$x \lor y = x(x \backslash y) = y(y \backslash x).$$

A Garside monoid M is a cancellative monoid with lcm's and gcd's and admitting a Garside element, namely an element whose left and right divisors coincide, are finite in number² and generate M. There exists a minimal Garside element—usually denoted by Δ and then called the Garside element—whose divisors are called the simples of M.

By Ore's conditions, a Garside monoid embeds in a group of fractions. A *Garside group* is a group that is the group of fractions of (at least) one Garside monoid.

Recognize a Garside monoid from a presentation and compute in a Garside group given by a presentation are natural questions which can be solved by using *word reversing*, a syntactic method relevant for semigroup presentation.

Let ε denote the empty word. For $\langle \mathcal{A} | \mathcal{R} \rangle$ a semigroup presentation and w, w' words on $\mathcal{A} \cup \mathcal{A}^{-1}$, we say that w reverses to w' written $w \curvearrowright_{\mathcal{R}} w'$ —if w' is obtained from w by (iteratively)

- deleting some $x^{-1}x$ for $x \in \mathcal{A}$,
- replacing some $x^{-1}y$ with uv^{-1} for xu = yv a relation in \mathcal{R} .

This can be represented diagrammatically as shown in Figure 5.

²Finiteness is a quite technical condition which can be relaxed in some contexts.



FIGURE 5. Word reversing diagrams for $x^{-1}x \curvearrowright \varepsilon$ and $x^{-1}y \curvearrowright uv^{-1}$.

First, remark that, for all $u, v \in \mathcal{A}^*$, $u^{-1}v \curvearrowright_{\mathcal{R}} \varepsilon$ implies $u \equiv_{\mathcal{R}}^+ v$, where $\equiv_{\mathcal{R}}^+$ denotes the monoid congruence generated by \mathcal{R} . Then define a semigroup presentation $\langle \mathcal{A} | \mathcal{R} \rangle$ to be *complete (for reversing)* when the converse holds, that is, when word reversing detects equivalence.

Technically, $\langle \mathcal{A} | \mathcal{R} \rangle$ is complete if and only if every triple (u, v, w) of words over \mathcal{A} satisfies the *cube condition* (CC) modulo \mathcal{R} :

$$u^{-1}ww^{-1}v \curvearrowright_{\mathcal{R}} uv^{-1}$$
 for $u, v \in \mathcal{A}^*$ implies $(xu)^{-1}yv \curvearrowright_{\mathcal{R}} \varepsilon$.

The CC can be represented diagrammatically as shown in Figure 6.



FIGURE 6. Cube condition : $u^{-1}ww^{-1}v \curvearrowright v'u'^{-1} \Rightarrow (uv')^{-1}vu' \curvearrowright \varepsilon$.

In the general case, the cube condition have to be checked for all triples of words on \mathcal{A} , or for all triples of words in a supset of \mathcal{A} closed under \mathcal{A} . However, in the homogeneous case (that is, when every relation preserves the length of words), check the cube condition for all triples of generators suffices to decide completeness.

A semigroup presentation $\langle \mathcal{A} | \mathcal{R} \rangle$ is *complemented* if, for all generators x, y in \mathcal{A} , there is at most one relation of the type $x \cdots = y \cdots$ and no relation of the type $x \cdots = x \cdots$. We will use the following criterium :

Theorem 3.1. [D4] Every monoid defined by a complemented complete presentation and admitting a Garside element is a Garside monoid.

3.2. The braid monoid $\mathbf{B}^{\oplus}(e, e, r)$ is Garside. The aim of this subsection is to show :

Theorem 3.2. The braid monoid $\mathbf{B}^{\oplus}(e, e, r)$ is Garside.

We prove the theorem in two parts : first completeness, then the Garside element.

3.2.1. Completeness. Taking advantage from knowledge of completeness for presentations associated to certain parabolic subdiagrams, we can check completeness of $\mathcal{P}^{\oplus}(e, e, r)$ after computing only few cases.

Lemma 3.3. The presentation $\mathcal{P}^{\oplus}(e, e, r)$ is complemented and complete.

Proof. The presentation $\mathcal{P}^{\oplus}(e, e, r)$ is complemented and homogeneous. Now, it suffices to check whether every triple (x, y, z) of generators in $T_e \cup S_r$ satisfies the CC.

From Subsection 2.3.1 about parabolic subdiagrams, we deduce :

 $(\mathbf{0}+\mathbf{3})$ Every triple in S_r^3 satisfies the CC because it holds for $\mathbf{B}^+(A_{r-2})$.

- (1+2) Every triple in $(T_e \times S_r^2) \cup (S_r \times T_e \times S_r) \cup (S_r^2 \times T_e)$ satisfies the CC because it holds for $\mathbf{B}^+(A_{r-1})$.
- $(\mathbf{3} + \mathbf{0})$ Every triple in T_e^3 satisfies the CC, because it holds for $\mathbf{B}^{\times}(I_2(e))$.

Thus we need only verify the cube condition on triples of type $(\mathbf{2} + \mathbf{1})$, that is, containing two generators from T_e and one generator from S_r . This case can be decomposed into two subcases depending on whether this generator from S_r is s_3 (say case (**a**)) or not (case (**b**)). From Subsection 2.3.1 again, with $S_r^- = S_r \setminus \{s_3\}$, we find :

(2+1b) Every triple in $(T_e^2 \times S_r^-) \cup (T_e \times S_r^- \times T_e) \cup (S_r^- \times T_e^2)$ satisfies the CC because it holds for $\mathbf{B}^{\times}(I_2(e)) \times \mathbf{B}^+(A_{r-3})$.

Therefore we need only verify the CC on triples of type $(\mathbf{2} + \mathbf{1a})$, that is, containing two generators from T_e and the generator s_3 from S_r . Now, various symmetry considerations reduce again the number of cases that need be considered. On the one hand, triples of the form (x, y, x) and (x, x, y) always satisfy the CC.



On the other hand, a triple (x, y, z) satisfies the CC if and only if (y, x, z) satisfies the CC : this may be seen by reflecting the word reversing diagram through an axis at $\frac{3\pi}{4}$.

This results in the following two cases :

- case $(x, y, z) = (t_i, t_j, s_3)$ with *i* and *j* distinct ;
- case $(x, y, z) = (t_i, s_3, t_j)$ with *i* and *j* distinct.

The calculations are shown in Figures 7 and 8 respectively.

3.2.2. Garside element. Let τ be the element $t_i t_{i-1}$ of $\mathbf{B}^{\oplus}(e, e, r)$. Since $t_i t_{i-1} = t_j t_{j-1}$ holds for all i, j, τ is independent of i. It is a common

multiple of T_e ; and since no word of length one could be a multiple of all the t_i , τ is the lcm of T_e .

The classical braid monoid $\mathbf{B}^+(2, 1, n)$ for $\mathbf{B}(2, 1, n)$ (indeed, $\mathbf{B}(d, 1, n)$ for any $d \ge 2$) is defined by the following Coxeter diagram : $q_1 \qquad q_2 \qquad q_3 \qquad q_{n-1} \qquad q_n$

The Garside element Δ_{B_n} of $\mathbf{B}^+(2, 1, n) \sim \mathbf{B}^+(B_n)$ is the lcm of $Q_n = \{q_1, q_2, \ldots, q_n\}$, which can be written in the various forms :

$$\Delta_{B_n} = q_1(q_2q_1q_2)\cdots(q_n\cdots q_2q_1q_2\cdots q_n)$$

= $(q_n\cdots q_2q_1q_2\cdots q_n)\cdots(q_2q_1q_2)q_1$
= $(q_1q_2\cdots q_n)^n$
= $(q_n\cdots q_2q_1)^n$.

This is a central element of $\mathbf{B}^+(B_n)$.

Define
$$\psi : Q_{r-1}^* \to (T_e \cup S_r)^*$$
 by $\psi(q_i) = \begin{cases} \tau & \text{for } i = 1, \text{ and} \\ s_{i+1} & \text{for } i > 1. \end{cases}$

As mentioned in Subsection 2.3.2, ψ induced an injection $\mathbf{B}^+(B_{r-1}) \hookrightarrow \mathbf{B}^{\oplus}(e, e, r)$; in particular, the poset structures with respect to \preccurlyeq coincide on $\mathbf{B}^+(B_{r-1})$ and $\mathbf{B}^{\oplus}(e, e, r)$. We deduce that the element $\Lambda = \psi(\Delta_{B_{r-1}})$ in $\mathbf{B}^{\oplus}(e, e, r)$ has the following decompositions :

$$\Lambda = \tau(s_3 \tau s_3) \cdots (s_r \cdots s_4 s_3 \tau s_3 s_4 \cdots s_r) = (\tau s_3 \cdots s_r)^{r-1} = (s_r \cdots s_4 s_3 \tau s_3 s_4 \cdots s_r) \cdots (s_3 \tau s_3) \tau = (s_r \cdots s_3 \tau)^{r-1}$$

and is precisely the least common multiple of $\psi(Q_{r-1}) = \{\tau\} \cup S_r$. Since τ is the lcm of T_e , we deduce : **Lemma 3.4.** The element Λ is the lcm of $T_e \cup S_r$.

Also, by centrality of $\Delta_{B_{r-1}}$ in $\mathbf{B}^+(B_{r-1})$, we have $\Lambda \tau = \tau \Lambda$ and $\Lambda s_p = s_p \Lambda$ for $3 \leq p \leq r$.

Let $\Lambda_2 = \tau$, and $\Lambda_p = s_p \cdots s_3 \tau s_3 \cdots s_p$ for $3 \le p \le r$. We find :

$$\Lambda = \Lambda_2 \Lambda_3 \cdots \Lambda_r.$$

A balanced element in a monoid is an element β such that $x \preccurlyeq \beta$ holds precisely when $\beta \succeq x$ holds.

The following result could be deduced from older results (see for instance [DP] or [D3]), but the proof is straightforward and we include it to make the current work self-contained.

Proposition 3.5. Suppose that M is a cancellative monoid and β is an element in M such that for all $x \in M$ there exists an element $\phi(x)$ satisfying $\beta x = \phi(x)\beta$. If ϕ is surjective then β is balanced.

Proof. Suppose there exist $x, y \in M$ satisfying $\phi(x) = \phi(y)$. Then $\beta x = \beta y$ holds, hence x = y by left cancellation, so ϕ is injective. Thus ϕ is an automorphism of M.

For $x \preccurlyeq \beta$, denote by β_x the unique element of M satisfying $x \ \beta_x = \beta$ (uniqueness comes from left cancellation). Similarly, for $\beta \succeq x$ then write $_x\beta \ x = \beta$.

Suppose $x \preccurlyeq \beta$. Then we have $\beta = \phi(\beta) = \phi(x)\phi(\beta_x)$, hence $\phi(x) \preccurlyeq \beta$. By the same argument but using ϕ^{-1} instead, we deduce that $\phi(x) \preccurlyeq \beta$ implies $x \preccurlyeq \beta$. Thus $x \preccurlyeq \beta$ holds precisely when $\phi(x) \preccurlyeq \beta$ holds. A symmetric argument shows that $\beta \succeq x$ holds precisely when $\beta \succeq \phi(x)$ holds.

So finally, suppose $x \preccurlyeq \beta$, which implies $\phi(x) \preccurlyeq \beta$. Then we have

$$\phi(x)\beta_{\phi(x)}x = \beta x = \phi(x)\beta.$$

Left cancellation then gives $\beta_{\phi(x)}x = \beta$, hence $\beta \geq x$. A similar argument shows that $\beta \geq x$ implies $x \preccurlyeq \beta$. Hence $\beta \geq x$ holds precisely when $x \preccurlyeq \beta$ holds.

Proposition 3.6. The element Λ is balanced.

Proof. Let $i \in \mathbb{Z}/e$. From $(s_3\tau s_3)t_{i-1} = s_3t_it_{i-1}s_3t_{i-1} = s_3t_is_3t_{i-1}s_3 = t_is_3t_it_{i-1}s_3 = t_i(s_3\tau s_3)$, we deduce $\Lambda_2 t_{i-2} = t_i\Lambda_2$ and $\Lambda_p t_i^{\downarrow} = t_i\Lambda_p$ for $3 \leq p \leq r$, hence $\Lambda t_i = t_{i+r}\Lambda$.

Defining $\phi(s_p) = s_p$ and $\phi(t_i) = t_{i+r}$ for $i \in \mathbb{Z}/e$ gives rise to an automorphism ϕ of the cancellative monoid $\mathbf{B}^{\oplus}(e, e, r)$ satisfying $\Lambda x = \phi(x)\Lambda$. The result then follows by Proposition 3.5.

3.2.3. Proof of Theorem 3.2. We now have enough to complete the proof of Theorem 3.2, that $\mathbf{B}^{\oplus}(e, e, r)$ is a Garside monoid :

Proof of Theorem 3.2. On the one hand, by Lemma 3.3, $\mathbf{B}^{\oplus}(e, e, r)$ admits a complemented and complete presentation. On the other hand, the element $\Lambda_2\Lambda_3\cdots\Lambda_r$ —which we will henceforth denote by Δ —is the Garside element of $\mathbf{B}^{\oplus}(e, e, r)$. Indeed, Proposition 3.6 states that left and right divisors of Δ coincide and Lemma 3.4 insures that Δ is the lcm of the generators and, in particular, the set of divisors of Δ generates $\mathbf{B}^{\oplus}(e, e, r)$. Now, invoking Theorem 3.1, we obtain that $\mathbf{B}^{\oplus}(e, e, r)$ is a Garside monoid with Garside element $\Delta = \Lambda_2\Lambda_3\cdots\Lambda_r$.

Hence $\mathbf{B}^{\oplus}(e, e, r)$ embeds in the group $\mathbf{B}(e, e, r)$ defined by the same presentation. Furthermore, we have for free :

Proposition 2.2. The submonoid of $\mathbf{B}(e, e, r)$ generated by $T_e \cup S_r$ is isomorphic to the monoid $\mathbf{B}^{\oplus}(e, e, r)$, that is, it can be presented by $\mathcal{P}^{\oplus}(e, e, r)$ considered as a monoid presentation.

3.3. Structure of the lattice of simples in $\mathbf{B}^{\oplus}(e, e, r)$. Here we completely describe the structure of the lattice of simples in the Garside monoid $\mathbf{B}^{\oplus}(e, e, r)$. Though sometimes somewhat technical, our careful study leads to a limpid statement (Theorem 3.7) which fully explains the combinatorics of the Garside structure and which will allow to compute several attached numerical objects and then, in the next subsection, to appreciate how classical is $\mathbf{B}^{\oplus}(e, e, r)$.

Since the only relations from $\mathcal{P}^{\oplus}(e, e, r)$ which can be applied to Λ_k correspond to applications of (R_5) to τ , there are only four types of non-trivial left divisors of Λ_k :

(1) $s_k \cdots s_3 \tau s_3 \cdots s_{j-1} s_j$, (2) $s_k \cdots s_3 \tau$, (3) $s_k \cdots s_3 t_i$, and (4) $s_k \cdots s_{j+1} s_j$,

with $3 \leq j \leq k$ and i in \mathbb{Z}/e .

The following theorem together with the fact that we know precisely the form of the divisors of Λ_k for each k allows us to have precise control over the simples.

Theorem 3.7. The simples in $\mathbf{B}^{\oplus}(e, e, r)$ are precisely the elements of the form $p_2 \cdots p_r$ where p_k is a divisor of Λ_k for $2 \leq k \leq r$.

Define the polynomial $P_{(e,e,r)}^{\oplus}(q) = \sum a_n q^n$ where a_n is the number of length n simples in $\mathbf{B}^{\oplus}(e, e, r)$. See more about this polynomial in Subsection 3.4.2. Theorem 3.7 directly gives a factorization of it.

Corollary 3.8. We have :

$$P_{(e,e,r)}^{\oplus}(q) = \prod_{k=2} (1+q+\dots+q^{k-2}+eq^{k-1}+q^k+\dots+q^{2k-2}).$$

Corollary 3.9. The number of simples in $\mathbf{B}^{\oplus}(e, e, r)$ is

$$P_{(e,e,r)}^{\oplus}(1) = \prod_{k=2}^{r} (2(k-1)+e) = \frac{(2(r-1)+e)!!}{e!!},$$

where the notation n!! represents the product $n(n-2)\cdots 4\cdot 2$ for n even and the product $n(n-2)\cdots 5\cdot 3$ for n odd (see [Slo, sequences A000165 and A001147]).

Remark. For $q \neq 1$, we find

$$P_{(e,e,r)}^{\oplus}(q) = \prod_{k=2}^{r} \frac{q^{2k-1} + (e-1)q^k - (e-1)q^{k-1} - 1}{q-1}.$$

For instance, Figure 9 displays the lattice of simples in $\mathbf{B}^{\oplus}(3,3,3)$. We find :

$$P^{\oplus}_{(3,3,3)}(q) = 1 + 4q + 7q^2 + 11q^3 + 7q^4 + 4q^5 + q^6$$

= $(1 + 3q + q^2)(1 + q + 3q^2 + q^3 + q^4).$



FIGURE 9. The lattice of simples in $\mathbf{B}^{\oplus}(3,3,3)$.

To prove Theorem 3.7, we will use the following two lemmas.

Define a map Ht : $(T_e \cup S_r)^* \to \{1, 2, \ldots, r\}$ on generators by $\operatorname{Ht}(t_i) = 2$, $\operatorname{Ht}(s_q) = q$, and, for $w = a_1 \cdots a_k$, define $\operatorname{Ht}(w) = \max_{i=1}^k \operatorname{Ht}(a_i)$. Define the height of the empty word to be $\operatorname{Ht}(\varepsilon) = 1$. If $\rho_1 = \rho_2$ is a defining relation of $\mathbf{B}^{\oplus}(e, e, r)$, it is clear from inspection that $\operatorname{Ht}(\rho_1) = \operatorname{Ht}(\rho_2)$ holds. Thus $\operatorname{Ht}(w)$ only depends on the element in $\mathbf{B}^{\oplus}(e, e, r)$ represented by w. So the *height* map $\operatorname{Ht} : \mathbf{B}^{\oplus}(e, e, r) \to \{1, 2, \ldots, r\}$ is well-defined.

Lemma 3.10. Every $x \in \mathbf{B}^{\oplus}(e, e, r)$ with $\operatorname{Ht}(x) < k$ satisfies $x\Lambda_k = \Lambda_k x^{\downarrow}.$

Proof. For j < k, we find :

$$\begin{split} s_{j}\Lambda_{k} &= s_{j}s_{k}\cdots s_{j+1}s_{j}s_{j-1}\cdots s_{3}\tau s_{3}\cdots s_{k} \\ &= s_{k}\cdots s_{j+2}s_{j}s_{j+1}s_{j}s_{j-1}\cdots s_{3}\tau s_{3}\cdots s_{k} \\ &= s_{k}\cdots s_{j+2}s_{j+1}s_{j}s_{j+1}s_{j-1}\cdots s_{3}\tau s_{3}\cdots s_{k} \\ &= s_{k}\cdots s_{3}s_{j+1}\tau s_{3}\cdots s_{k} \\ &= s_{k}\cdots s_{3}\tau s_{j+1}s_{3}\cdots s_{j-1}s_{j}s_{j+1}\cdots s_{k} \\ &= s_{k}\cdots s_{3}\tau s_{3}\cdots s_{j-1}s_{j}s_{j+1}\cdots s_{k} \\ &= s_{k}\cdots s_{3}\tau s_{3}\cdots s_{j-1}s_{j}s_{j+1}s_{j}s_{j+2}\cdots s_{k} \\ &= s_{k}\cdots s_{3}\tau s_{3}\cdots s_{j-1}s_{j}s_{j+1}s_{j+2}\cdots s_{k}s_{j} \\ &= \Lambda_{k}s_{j}. \end{split}$$

For every k and $0 \le i < e$, we have :

$$\begin{aligned} t_i \Lambda_k &= t_i s_k \cdots s_3 \tau s_3 \cdots s_k \\ &= s_k \cdots s_4 t_i s_3 t_i t_{i-1} s_3 \cdots s_k \\ &= s_k \cdots s_4 s_3 t_i s_3 t_{i-1} s_3 \cdots s_k \\ &= s_k \cdots s_3 t_i t_{i-1} s_3 t_{i-1} s_4 \cdots s_k \\ &= s_k \cdots s_3 t_i t_{i-1} s_3 s_4 \cdots s_k t_{i-1} \\ &= \Lambda_k t_{i-1}. \end{aligned}$$

The result follows.

Recall that $a \lor b$ denotes the lcm of a and b and that, by cancellativity, elements $(a \land b)$ and $(b \land a)$ are uniquely defined by :

$$a \lor b = a(a \backslash b) = b(b \backslash a).$$

Lemma 3.11. Let a be an element in $T_e \cup S_r$ and q_k be a right divisor of some Λ_k . Then $a \wedge q_k = 1$ and $\operatorname{Ht}(q_k \setminus a) < k$ together imply $q_k \setminus a \in T_e \cup S_r$ and $a \setminus q_k = q_k$.

Proof. If q_k is trivial, then the result follows directly. Consider the remaining cases :

(1) Let $q_k = s_j \cdots s_k$ for some $3 \le j \le k$. First, $a \not\preccurlyeq q_k$ implies $a \ne s_j$. Next, $s_{j-1} \lor q_k = q_k s_{j-1} q_k$ (resp. $t_i \lor q_k = q_k t_i q_k$ for j = 3) and $\operatorname{Ht}(q_k) = k$ imply $a \neq s_{j-1}$ (resp. $a \neq t_i$ for j = 3). The only possible cases are then :

$$a \lor q_k = \begin{cases} s_l q_k = q_k s_l & \text{for } a = s_l \text{ with } 3 \le l < j - 1, \\ s_l q_k = q_k s_{l-1} & \text{for } a = s_l \text{ with } j < l \le k, \text{ and} \\ t_i q_k = q_k t_i & \text{for } a = t_i \text{ and } j \ne 3. \end{cases}$$

(2) Let $q_k = t_i s_3 \cdots s_k$ for some $i \in \mathbb{Z}/e$. First, $a \not\preccurlyeq q_k$ implies $a \neq t_i$. Next, $t_i \lor q_k = q_k t_{i-1} q_k$ and $\operatorname{Ht}(q_k) = k$ imply $a \neq t_j$ for $j \neq i$. The possible cases are then :

$$a \lor q_k = \begin{cases} s_3 q_k = q_k t_i & \text{for } a = s_3, \text{ and} \\ s_l q_k = q_k s_{l-1} & \text{for } a = s_l \text{ with } 3 < l \le k. \end{cases}$$

(3) Let $q_k = s_{j-1} \cdots s_3 \tau s_3 \cdots s_k$ for some $3 \le j \le k$. First, $a \not\preccurlyeq q_k$ implies $a \ne s_{j-1}$ (resp. $a \ne t_i$ for j = 3). Next, $s_j \lor q_k = q_k s_j q_k$ and $\operatorname{Ht}(q_k) = k$ imply $a \ne s_j$. The possible cases are then :

$$a \lor q_k = \begin{cases} s_l q_k = q_k s_l & \text{for } a = s_l \text{ with } 3 \le l < j - 1, \\ s_l q_k = q_k s_{l-1} & \text{for } a = s_l \text{ with } j < l \le k, \text{ and} \\ t_i q_k = q_k t_i & \text{for } a = t_i \text{ and } j \ne 3. \end{cases}$$

In each case, we find $a \lor q_k = aq_k = q_k a'$ with $a' = q_k \backslash a \in T_e \cup S_r$ and $a \backslash q_k = q_k$.

Proof of Theorem 3.7. We have to prove a double inclusion. First, we show that if, for each $k \in \{2, \ldots, r\}$, p_k is a divisor of Λ_k , then $p_2 p_3 \ldots p_r$ divides Δ . For each k, let q_k be the unique element of the monoid satisfying $p_k q_k = \Lambda_k$. Lemma 3.10 implies $\Lambda_j q_k^{\downarrow} = q_k \Lambda_j$ for each q_k and each j > k. Let q'_k be the element obtained by applying r - k times the map \downarrow to q_k . Then we obtain

$$\Delta = (p_2 q_2) \Lambda_3 \cdots \Lambda_r = p_2 \Lambda_3 \cdots \Lambda_r q'_2 = \cdots = p_2 p_3 \cdots p_r q_r q'_{r-1} \cdots q'_3 q'_2.$$

Thus $p_2 p_3 \cdots p_r$ is a divisor of Δ . This completes the first inclusion.

Now let $k \in \{2, ..., r\}$. We prove, by induction on $k \ge 2$, that if p left-divides $\Lambda_2 \cdots \Lambda_k$ then $p = p_2 \cdots p_k$ holds for some divisors p_j of Λ_j with $2 \le j \le k$. The result holds vacuously for k = 2.

Assume k > 2. By the induction hypothesis, $p \wedge \Lambda_2 \cdots \Lambda_{k-1}$ can be written as $p_2 \cdots p_{k-1}$, where Λ_j is $p_j q_j$ for some q_j with $\operatorname{Ht}(q_j) \leq j$. We obtain $p = p_2 \cdots p_{k-1} p_0$ for some $p_0 \preccurlyeq q'_{k-1} \cdots q'_2 \Lambda_k = \Lambda_k q'_{k-1} \cdots q'_2$ where q'_j is, as above, the element obtained by applying the map \downarrow , (k-j) times to q_j . Let $p_k = p_0 \wedge \Lambda_k$, $p_k q_k = \Lambda_k$ and $p_0 = p_k p'$.

We have to show that p' is trivial. Suppose instead that p' is not trivial. Then we may write $p' = ap'_a$ for some $a \in T_e \cup S_r$. We have $p' \preccurlyeq q_k q$ with $q = q'^{\downarrow}_{k-1} \cdots q'^{\downarrow}_2$ and $\operatorname{Ht}(q) < k$. Thus $a \lor q_k$ must divide $q_k q$, but $a \preccurlyeq q_k$ holds by gcd-ness of p_k . Therefore, by Lemma 3.11, there

exists $b \in T_e \cup S_r$ satisfying $aq_k = q_k b$, thus $p_k aq_k = \Lambda_k b$, hence $p_k a = b^{\uparrow} p_k$. We find $p = p_2 \cdots p_{k-1} b^{\uparrow} p_k p'_a$ with $p_2 \cdots p_{k-1} b^{\uparrow} \preccurlyeq \Lambda_2 \cdots \Lambda_{k-1}$, which contradicts $p_2 \cdots p_{k-1} = p \land \Lambda_2 \cdots \Lambda_{k-1}$. Therefore, p' is trivial, which concludes the induction.

A note on the reflection group $\mathbf{G}(e, e, r)$ and the Garside structure. The number of simples in $\mathbf{B}^{\oplus}(e, e, r)$ is $\frac{(2(r-1)+e)!!}{e!!}$, while the number of elements in $\mathbf{G}(e, e, r)$ is $e^{r-1}r!$. For e = 2, we have equality between these two expressions, corresponding to the classical type D_r case. For e > 2, we have $\frac{x+e}{e} < \frac{x}{2} + 1$, hence

$$\frac{(2(r-1)+e)!!}{e!!} = e^{r-1} \left(\frac{2(r-1)+e}{e}\right) \cdots \left(\frac{4+e}{e}\right) \left(\frac{2+e}{e}\right) < e^{r-1}r(r-1)\cdots(3)(2) = e^{r-1}r!$$

(For example, there are 35 simples in $\mathbf{B}^{\oplus}(3,3,3)$ —see Figure 9—and 54 elements in $\mathbf{G}(3,3,3)$.) In other words, not all elements of $\mathbf{G}(e,e,r)$ may be represented by simples from $\mathbf{B}^{\oplus}(e,e,r)$. For example, the element

$$\overline{t_0 t_1} = \begin{pmatrix} \zeta_e & 0 & & \\ 0 & \zeta_e^{-1} & 0 & \\ \hline & 0 & & I_{r-2} \end{pmatrix},$$

may not be represented by a simple from $\mathbf{B}^{\oplus}(e, e, r)$.

The known classical braid monoids for braid groups of real reflection groups all have equality between number of simples and size of reflection group. In this way the monoid $\mathbf{B}^{\oplus}(e, e, r)$ appears not to be strictly classical. However in a number of ways it is seen to be dual, or simply different from, the so-called dual braid monoids, and so deserves a name like post-classical. This is the content of the next subsection.

3.4. How classical is $\mathbf{B}^{\oplus}(e, e, r)$? The braid group $\mathbf{B}(e, e, r)$ seems to admit no classical braid monoid, in the sense that its submonoid generated by the generators of [BMR]—providing a minimal generating set—is indeed not finitely presented (see [Co, BC1, BC2]). Recall that the braid monoid $\mathbf{B}^{\oplus}(e, e, r)$ (resp. the dual braid monoid $\mathbf{B}^{\times}(e, e, r)$) coincides with the classical braid monoid $\mathbf{B}^{+}(D_r)$ (resp. the dual braid monoid $\mathbf{B}^{\times}(D_r)$) for e = 2 and with the dual braid monoid $\mathbf{B}^{\times}(I_2(e))$ for r = 2.

In this subsection we look at various properties of the monoid $\mathbf{B}^{\oplus}(e, e, r)$, which mainly deal with enumerative aspects, and consider them in relation to known classical and dual braid monoids for other braid groups. While it cannot be considered as strictly classical, $\mathbf{B}^{\oplus}(e, e, r)$ has much in common with the classical braid monoids than with the dual braid monoids, and it could be considered as a *post-classical* braid monoid. The following three observations allow to legitimate this terminology.

3.4.1. A kind of duality. According to [B2], the duality terminology in the context of Garside monoids for braid groups of finite real reflection groups W can be justified by the numerical facts summarized in the following table :

	$\mathbf{B}^+(W)$	$\mathbf{B}^{\times}(W)$
Product of the atoms Δ	$f c \ w_0$	\mathbf{w}_0 c
Number of atoms Length of Δ	$n \\ N$	$N \\ n$
Order of $a \mapsto a^{\Delta}$ Regular degree	2 h	h 2

A different kind of duality can be observed between the monoids ${\bf B}^\oplus(e,e,r)$ and ${\bf B}^\times(e,e,r)$:

	$\mathbf{B}^{\oplus}(e,e,r)$	$\mathbf{B}^{\times}(e,e,r)$
Number of atoms	e+r-2	(e+r-2)(r-1)
Length of Δ	r(r - 1)	r
Order of $a \mapsto a^{\Delta}$	$\frac{e}{e \wedge r}$	$\frac{e(\boldsymbol{r-1})}{e\wedge r}$

Thus the monoid $\mathbf{B}^{\oplus}(e, e, r)$ may be considered to be a kind of dual of the dual braid monoid $\mathbf{B}^{\times}(e, e, r)$. The latter fits into the general framework of dual braid monoids defined in [B2], but it satisfies only some of the numerical properties summarized in the first table above. In a parallel way, $\mathbf{B}^{\oplus}(e, e, r)$ could be named simply classical. Here, we could mention that neither $\mathbf{B}^{\oplus}(e, e, r)$ nor $\mathbf{B}^{\times}(e, e, r)$ can be produced by [B1, Theorem 0.1], so in particular, the notion of regular degree³ is not relevant.

3.4.2. Poincaré polynomial. For a given Garside monoid M, the polynomial P_M is defined by $P_M(q) = \sum a_n q^n$ where a_n denotes the number of length n simples in M (see earlier comments preceding Corollary 3.8). In the case of the classical braid monoids associated to finite Coxeter group W (for example $\mathbf{B}^+(A_n)$, $\mathbf{B}^+(B_n)$, $\mathbf{B}^+(D_n)$, etc), this polynomial coincides with the Poincaré polynomial of W, where a_n is the number of length n elements of with respect to a set of simple reflections. In these cases, we have :

$$P_W^+(q) = \prod_{k=1}^r (1 + q + \dots + q^{d_k - 1})$$

where the numbers d_k denote the reflection degrees. The polynomial $P_{(e,e,r)}^{\oplus}(q)$ does not satisfy this general formula, except for the cases e = 2 or r = 2. However the similarity of factorization of the Poincaré polynomial (see below) suggests describing $\mathbf{B}^{\oplus}(e,e,r)$ again as a post-classical braid monoid.

$$P_{(e,e,r)}^{\oplus}(q) = \prod_{k=1}^{r} (1+q+\dots+q^{k-2}+eq^{k-1}+q^{k}+\dots+q^{2k-2}),$$

$$P_{A_{n}}^{+}(q) = \prod_{k=1}^{n} (1+q+\dots+q^{k}),$$

$$P_{B_{n}}^{+}(q) = \prod_{k=1}^{n} (1+q+\dots+q^{2k-1}),$$

$$P_{D_{n}}^{+}(q) = (1+q+\dots+q^{n-1}) \prod_{k=1}^{n-1} (1+q+\dots+q^{2k-1}).$$

3.4.3. Zeta polynomial. For a given Garside monoid M, the zeta polynomial Z_M can be defined by requiring that $Z_M(q)$ be the number of length q-1 multichains $a_1 \leq \cdots \leq a_{q-1}$ in the lattice of simples of M.

³Each of the braid group presentations constructed in [B1] corresponds to a regular degree d. The product of the generators raised to the power d (which is the order of the image of this product in the reflection group), is always central. See also [B3].

Whenever $\mathbf{G}(de, e, r)$ is well-generated (which is the case for $\mathbf{G}(e, e, r)$), the zeta polynomial of the dual braid monoid $\mathbf{B}^{\times}(de, e, r)$ admits a nice factorization :

$$Z_{(de,e,r)}^{\times}(q) = \prod_{k=1}^{r} \frac{d_k + d_r(q-1)}{d_k}$$

where $d_1 \leq \cdots \leq d_r$ are the reflection degrees (see [Ch, R, AR]). On the contrary, the zeta polynomial $Z^+_{(de,e,r)}$ of the classical braid monoid $\mathbf{B}^+(de,e,r)$ (when defined) is not known to admit any nice factorization. In this way, $\mathbf{B}^{\oplus}(e,e,r)$ has more in common with classical braid monoids than dual braid monoids. For instance, we find :

$$Z^{\oplus}_{(3,3,3)}(q) = \frac{11q^6 + 171q^5 + 985q^4 + 2585q^3 + 2964q^2 + 1444q + 240}{240}$$
$$= \frac{(q+1)(q+6)(11q^4 + 94q^3 + 261q^2 + 194q + 40)}{240}.$$

3.5. Conclusion. While we feel that the new Garside monoid $\mathbf{B}(e, e, r)$ deserves the description post-classical, we do not exclude the possibility that this is the best presentation available, and would like to conclude with a motivating question :

Question 3.12. Does $\mathbf{B}(e, e, r)$ admit other Garside structures ?
