MODEL PREDICTIVE CONTROL OF THE WATER BASED PAINTING DRYING USING A HUMIDITY PROFILE SOFT SENSOR

1. Abstract: This paper deals with the model predictive control (MPC) of an infrared drying process of a water based epoxy-amine painting. During the drying cycle, the control problem is to minimize the processing time (hence maximizing the drying rate m) while accounting for any constraints dealing with the drying characteristics (i.e. the temperature T(t) and the humidity profile $X(\xi,t)$). This approach is based on a nonlinear dynamic unidirectional diffusional model of the infrared drying phenomena where both heat and mass transfers under shrinkage conditions are accounted for. For the on-line application, the nonlinear diffusional model is solved off-line whereas the infrared flow to apply is computed on-line by the MPC using a linearized model.






4. Optimal control strategies to minimize the processing time Unconstrained (left) and constrained (right) cases



The processing time is minimized: 180s when no constraints are specified and 290s when the difference of humidity constraint is accounted for and always satisfied.

5. Perspectives: No measure of the humidity profile required by the MPC is available. Therefore, an observer (model based soft-sensor) is under construction. It will estimate the entire humidity profile according to the infrared flow applied, the measured temperature and the model while real sensors are also needed for the observer validation. Moreover the constraints that really limit the processing time need to be defined before real validation of the approach.
