# Real zeros and size of Rankin-Selberg $L$-functions in the level aspect

#### Abstract

In this paper, some asymptotic formulas are proved for the harmonic mollified second moment of a family of Rankin-Selberg $L$-functions. One of the main new input is a substantial improvement of the admissible length of the mollifier which is done by solving a shifted convolution problem by a spectral method on average. A first consequence is a new subconvexity bound for Rankin-Selberg $L$-functions in the level aspect. Moreover, infinitely many Rankin-Selberg $L$-functions having at most eight non-trivial real zeros are produced and some new non-trivial estimates for the analytic rank of the family studied are obtained.

## 1 Introduction and statement of the results

This paper is motivated by the striking result of J.B. Conrey and K. Soundararajan proven in [CoSo]:

Theorem (J.B. Conrey-K. Soundararajan (2002)). There exists infinitely many (at least $20 \%$ in a suitable sense) primitive quadratic Dirichlet characters $\chi$ whose Dirichlet L-function $L(\chi, s):=\sum_{n} \chi(n) n^{-s}$ does not vanish on the critical segment [0,1].

The family of L-functions considered in [CoSo] is $\mathscr{G}:=\cup_{X \in\left\{2^{m}, m \in \mathbb{N}\right\}} \mathscr{G}(X)$ with

$$
\mathscr{G}(X):=\left\{L\left(\chi_{-8 d}, .\right), 2 \nmid d, \mu^{2}(d)=1, X \leq d \leq 2 X\right\}
$$

where $\chi_{-8 d}(n):=\left(\frac{-8 d}{n}\right)$ is the Kronecker symbol. The proof, which is based on the mollification method, exploits the following properties of the family $\mathscr{G}$ :

- the functional equation of each $L$-function of this family has the same sign;
- this sign equals +1 and consequently the order of vanishing at the critical point $\frac{1}{2}$ of each $L$-function is an even integer;
- the symmetry type of this family is symplectic - this entails that the first zero is repelled from the real axis and justifies the method used by the authors.
K. Soundararajan announced at the Journées Arithmétiques 2003 in Graz a similar result for the families $\mathscr{H}_{ \pm}:=\cup_{K \in\left\{2^{m}, m \in \mathbb{N}^{*}\right\}} \mathscr{H}_{ \pm}(K)$ with

$$
\begin{aligned}
\mathscr{H}_{+}(K) & :=\left\{L(f, .), f \in S_{k}^{p}(1), K \leq k \leq 2 K, k \equiv 0 \bmod 4\right\}, \\
\mathscr{H}_{-}(K) & :=\left\{L(f, .), f \in S_{k}^{p}(1), K \leq k \leq 2 K, k \equiv 2 \bmod 4\right\}
\end{aligned}
$$

where $S_{k}^{p}(1)$ denotes the set of primitive cusp forms of level 1, weight $k$ and trivial nebentypus. It is then natural to try to generalize these results to other families of L-functions. Throughout this article, $g$ will be a fixed primitive (arithmetically normalized namely with first Fourier coefficient equal to one) cusp form of square-free level $D$, weight $k_{g}$ and trivial nebentypus $\varepsilon_{D}$, and $f$ will be a varying primitive cusp form of level $q$, weight $k$ and trivial nebentypus $\varepsilon_{q}$ denoted by $f \in S_{k}^{p}(q)$. We prove a result cognate to that of [CoSol for the family of RankinSelberg $L$-functions $\mathscr{F}:=\underset{\substack{q \in \mathscr{P} \\ q \nmid D}}{\mathscr{F}(q) \text { where: }}$

$$
\forall q \in \mathscr{P}, \quad \mathscr{F}(q):=\left\{L(f \times g, .), f \in S_{k}^{p}(q)\right\} .
$$

From now on, $L(f \times g,$.$) is the Rankin-Selberg L-function described in section 4$ of [KoMiVa] associated to the pair $(f, g)$ and $\mathscr{P}$ denotes the set of prime numbers. The family $\mathscr{F}$ has the same properties (at least conjecturally) as the family $\mathscr{G}$. The challenge lies in the fact that the analytic conductor $Q(f \times g)$ say of any $L(f \times g,$.$) in \mathscr{F}(q)$ is large by comparison with the size of $|\mathscr{F}(q)|$; one has

$$
\frac{\log Q(f \times g)}{\log |\mathscr{F}(q)|} \rightarrow 2 \quad \text { as } \quad q \rightarrow+\infty
$$

while for the families $\mathscr{G}$ and $\mathscr{H}_{ \pm}$, one has

$$
\frac{\log Q\left(\chi_{-8 d}\right)}{\log |\mathscr{G}(X)|} \rightarrow 1, \frac{\log Q(f)}{\log \left|\mathscr{H}_{ \pm}(K)\right|} \rightarrow 1 \text { as respectively } X, K \rightarrow+\infty .
$$

In particular, the second moment in our case (whose evaluation is necessary to apply the mollification method) is already critical (in the sense of [Mi2]); this is not the case of the families $\mathscr{G}$ and $\mathscr{H}_{ \pm}$, for which the fourth moment is critical. Moreover, the L-functions of the family $\mathscr{F}$ are Euler products of degree four (rather than one or two) which significantly increases the combinatorial analysis.

For $q$ in $\mathscr{P}$ and $k \geq 2$ an even integer, we define the following harmonic averaging operator

$$
\forall q \in \mathscr{P}, \quad A_{q}^{h}[\alpha]:=\sum_{f \in S_{k}^{p}(q)}^{h} \alpha_{f}:=\sum_{f \in S_{k}^{p}(q)} \omega_{q}(f) \alpha_{f}
$$

for sequences of complex numbers indexed by $S_{k}^{p}(q)$ and with the harmonic weight $\omega_{q}(f):=\frac{\Gamma(k-1)}{(4 \pi)^{k-1}\langle f, f\rangle_{q}}\left(\langle., .\rangle_{q}\right.$ is the Petersson scalar product on the space of cusp forms of level $q$, weight $k$ and trivial nebentypus). We also define the harmonic probability measure on $S_{k}^{p}(q)$ by

$$
\mu_{q}^{h}(E):=\frac{1}{A_{q}^{h}[1]} \sum_{f \in E} \omega_{q}(f)
$$

for any subset $E$ of $S_{k}^{p}(q)$. With these notations, our analogue of the theorem of J.B. Conrey and K. Soundararajan is:

Theorem A. Let $g$ be a primitive cusp form of square-free level $D$, weight $k_{g} \geq 22$ and trivial nebentypus. As $q \rightarrow+\infty$ among primes and $f$ ranges over the set of primitive cusp forms of level $q$, weight $k \geq k_{g}+6$ and trivial nebentypus, there are infinitely many (at least $1.8 \%$ in a suitable sense) $f$ in $S_{k}^{p}(q)$ such that $L(f \times g$,.) has at most eight non-trivial real zeros. More precisely, for $q$ a prime coprime with $D$, and $k \geq k_{g}+6$, we have:

$$
\mu_{q}^{h}\left(\left\{f \in S_{k}^{p}(q), L(f \times g, .) \text { has at most } 8 \text { zeros in }[0,1]\right\}\right) \geq 0.018+o_{g}(1)
$$

Remark 1.1. Under the Ramanujan-Petersson-Selberg conjecture (confer $\mathrm{H}_{2}(0)$ next page), we would obtain $4 \%$ of $L(f \times g$,.) having at most 6 non-trivial real zeros. However, even this strong and deep hypothesis does not seem to give the existence of infinitely many Rankin-Selberg $L$-functions having no zeros in $[0,1]$ by the present method.

Remark 1.2. In the course of the proof of theorem A, we also prove that the analytic rank of the family $\mathscr{F}$ is bounded on average. More precisely, set

$$
\begin{equation*}
r(f \times g):=\operatorname{ord}_{s=\frac{1}{2}} L(f \times g, s) \tag{1.1}
\end{equation*}
$$

one has

$$
\frac{1}{A_{q}^{h}[1]} A_{q}^{h}[r(. \times g)] \leq 9.82+o_{g}(1)
$$

and we can replace the constant 9.82 by 7.66 under Ramanujan-Petersson-Selberg conjecture. Moreover, following the method of [H-BMi], one can even show the exponential decay of the analytic rank of the family $\mathscr{F}$ namely there exists some absolute constants $B, C>0$ such that:

$$
\frac{1}{A_{q}^{h}[1]} A_{q}^{h}[\exp (B r(. \times g))] \leq C
$$

The proof of theorem A relies on some asymptotic formulas for the harmonic mollified second moment of the family $\mathscr{F}$, which is defined by

$$
\begin{equation*}
\mathscr{W}^{h}(g ; \mu):=A_{q}^{h}\left[\left|\mathscr{L}\left(. \times g, \frac{1}{2}+\mu\right)\right|^{2}\right] \tag{1.2}
\end{equation*}
$$

where for $f \in S_{k}^{p}(q)$ and $s \in \mathbb{C}$ we have set

$$
\mathscr{L}(f \times g, s):=L(f \times g, s) M(f \times g, s)
$$

here, $M(f \times g$,.) is some Dirichlet polynomial (the so-called mollifier) of the following shape

$$
M(f \times g, s):=\sum_{1 \leq \ell \leq L} \frac{x_{\ell}(g, s)}{\ell^{s}} \lambda_{f}(\ell)
$$

where the length $L \geq 1$ has to be as large as possible. Here, the $\left(\lambda_{f}(\ell)\right)_{1 \leq \ell \leq L}$ are Hecke eigenvalues of $f$ and the $\left(x_{\ell}(g, s)\right)_{1 \leq \ell \leq L}$ are well chosen mollifying coefficients depending on $s$, $g$ on some parameter $0<\Upsilon<1$ and on some polynomial $P$ satisfying $P(0)=P^{\prime}(0)=P^{\prime}(\Upsilon)=0$ and $P(\Upsilon)=1$ (see section 4). Our key technical result is an asymptotic formula for $\mathscr{W}^{h}(g ; \mu)$ when

$$
\frac{\varepsilon_{0}}{\log q} \leq|\mu| \ll \frac{1}{\log q}
$$

for some small absolute constant $\varepsilon_{0}>0$. Given $u$ and $v$ two real numbers and $\Delta>0$, we define:

$$
\begin{aligned}
& \mathscr{V}(u, v):=1+\frac{\exp (-u)}{\Delta}\left(\frac{\sinh u}{u}-\frac{\sin v}{v}\right) \\
& \quad \times \int_{0}^{\Upsilon} \exp (-2 u \Delta(1-x))\left|P^{\prime}(x)+\frac{P^{\prime \prime}(x)}{2(u+i v) \Delta}\right|^{2} \mathrm{~d} x .
\end{aligned}
$$

Our main first result is an asymptotic formula for $\mathscr{W}^{h}(g ; \mu)$ in terms of $\mathcal{V}(u, v)$; namely for

$$
\Delta:=\frac{\log L}{\log \left(q^{2}\right)}
$$

which we call the relative (logarithmic) length of the mollifier, one has

$$
\begin{align*}
& \mathscr{W}^{h}(g ; \mu)=V /\left(\log \left(q^{2}\right) \Re(\mu), \log \left(q^{2}\right) \Im(\mu)\right)+\operatorname{Errsec}(q, L ; \mu)  \tag{1.3}\\
& +O_{k, g}\left(\frac{1}{q^{\delta}}+\frac{1}{\log q}\left\{\begin{array}{ll}
L^{-2 \Re(\mu)(1-\Upsilon)} & \text { if } \Re(\mu) \geq 0 \\
q^{-2 \Re(\mu)} L^{-4 \Re(\mu)} & \text { otherwise }
\end{array}\right)\right.
\end{align*}
$$

for $\delta>0$ an absolute constant and $\operatorname{Errsec}(q, L ; \mu)$ some error term:

$$
\begin{equation*}
\operatorname{Errsec}(q, L ; \mu)=O_{k, g}\left(\frac{1}{q^{\alpha}}\right) \tag{1.4}
\end{equation*}
$$

for some $\alpha>0$ as soon as $\Delta$ is small enough in which case $\Delta$ is said to be effective.

Remark 1.3. The asymptotic for the harmonic mollified second moment of this family is the same as the asymptotic for the mollified second moment of the family of Dirichlet L-functions considered by J.B. Conrey and K. Soundararajan. This is consistent with the Random Matrix Model, as these two families are expected to have the same symmetry type.

Remark 1.4. In fact, we also prove that (1.3) holds with some weaker assumptions on $\mu$; namely when $\mu$ satisfies $\frac{\varepsilon_{0}}{\log q} \leq|\mu|,-\frac{c}{\log q} \leq \Re(\mu) \leq \frac{f_{1}(q)}{\log q}$ and $|\Im(\mu)| \leq$ $\frac{f_{2}(q)}{\log q}$ for some $\varepsilon_{0}>0, c>0$ and some non-negative functions $f_{1}, f_{2}$ with the following properties:

$$
\lim _{q \rightarrow+\infty} f_{1}(q)=+\infty, f_{1}(q)=o(\log q), f_{2}(q)=O(\log q)
$$

In this case, (1.3) becomes:

$$
\begin{align*}
\mathscr{W}^{h}(g ; \mu)=V & \left(\log \left(q^{2}\right) \Re(\mu), \log \left(q^{2}\right) \Im(\mu)\right)+\operatorname{Errsec}(q, L ; \mu)  \tag{1.5}\\
& +O_{k, g}\left(\frac{1}{q^{\delta}}+\frac{f_{1}(q)+f_{2}(q)}{\log q} \begin{cases}L^{-2 \Re(\mu)(1-\Upsilon)} & \text { if } \Re(\mu) \leq 0, \\
q^{-2 \Re(\mu)} L^{-4 \Re(\mu)} & \text { otherwise. }\end{cases} \right.
\end{align*}
$$

Our task now is to produce effective positive $\Delta$. The existence of such $\Delta$ is a consequence of the work of E. Kowalski, P. Michel and J. Vanderkam ([KoMiVa]) and their result leads to:

Proposition C. Let g be a primitive cusp form of square-free level $D$ and trivial nebentypus. Assume that $q$ is prime, coprime with $D$. If $|\mu| \ll \frac{1}{\log q}$ then for any natural integer $L \geq 1$,

$$
\begin{equation*}
\operatorname{Errsec}(q, L ; \mu)=O_{\varepsilon, k, g}\left((q L)^{\varepsilon}\left(L^{\frac{5}{2}} q^{-\frac{1}{12}}+L^{\frac{21}{4}} q^{-\frac{1}{4}}\right)\right) \tag{1.6}
\end{equation*}
$$

for any $\varepsilon>0$. In particular, every $\Delta<\frac{1}{60}=0.01666 \ldots$ is effective.
This is a consequence of an asymptotic formula for the harmonic twisted second moment of this family given by

$$
\begin{equation*}
\mathscr{M}_{g}^{h}(\mu ; \ell):=A_{q}^{h}\left[L\left(\times g, \frac{1}{2}+\mu\right) L\left(. \times g, \frac{1}{2}+\bar{\mu}\right) \lambda .(\ell)\right] \tag{1.7}
\end{equation*}
$$

where $\mu \in \mathbb{C}, q \in \mathscr{P}, \ell \geq 1$ and $\lambda$. $(\ell)$ is a Hecke eigenvalue. It is shown in [KoMiVa] that (confer Theorem 5.1 in this paper):

Theorem (E. Kowalski-P. Michel-J. Vanderkam (2002)). Let g be a primitive cusp form of square-free level $D$ and trivial nebentypus and $\mu$ be a complex number. Assume that $q$ is prime, coprime with $D$. If $|\Re(\mu)| \ll \frac{1}{\log q}$ then for any natural integer $1 \leq \ell<q$,

$$
\begin{equation*}
(q D)^{2 \Re(\mu)} \mathscr{M}_{g}^{h}(\mu ; \ell)=M T(\mu)+\operatorname{Errtwist}(q, \ell ; \mu) \tag{1.8}
\end{equation*}
$$

where $M T(\mu)$ stands for the main term and is described in section 5 and a bound for the error term is given by

$$
\begin{equation*}
\operatorname{Errtwist}(q, \ell ; \mu)=O_{\varepsilon, k, g}\left((q \ell)^{\varepsilon}(1+|\Im(\mu)|)^{B}\left(\ell^{\frac{3}{4}} q^{-\frac{1}{12}}+\ell^{\frac{17}{8}} q^{-\frac{1}{4}}\right)\right) \tag{1.9}
\end{equation*}
$$

for some absolute constant $B>0$ and for any $\varepsilon>0$.
Nevertheless, this is not sufficient to obtain Theorem $A^{1}$. Our second main input is a large improvement of the effective value of $\Delta$ by the introduction of the spectral theory of automorphic forms. To state our result, we introduce the following hypothesis which measures the approximation towards the Ramanujan-Petersson-Selberg conjecture.

Hypothesis $\mathbf{H}_{2}(\theta)$. For any cuspidal automorphic form $\pi$ on $G L_{2}(\mathbb{Q}) \backslash G L_{2}\left(\mathbb{A}_{\mathbb{Q}}\right)$ with local Hecke parameters $\alpha_{\pi}^{(1)}(p), \alpha_{\pi}^{(2)}(p)$ for $p<\infty$ and $\mu_{\pi}^{(1)}(\infty), \mu_{\pi}^{(2)}(\infty)$ at infinity, the following bounds are available:

$$
\begin{aligned}
\left|\alpha_{\pi}^{(j)}(p)\right| & \leq p^{\theta}, j=1,2 \\
\left|\Re\left(\mu_{\pi}^{(j)}(\infty)\right)\right| & \leq \theta, j=1,2
\end{aligned}
$$

provided $\pi_{p}, \pi_{\infty}$ are unramified, respectively.
We say that $\theta$ is admissible if $H_{2}(\theta)$ is satisfied. At the moment, the smallest admissible value of $\theta$ is $\theta_{0}=\frac{7}{64}$ thanks to the works of H . Kim, F. Shahidi and P . Sarnak (confer [KiSh] and [KiSa]).

[^0]Proposition D. Let $\alpha$ be in $] 0,1[$. Let $g$ be a primitive cusp form of square-free level $D$, weight $k_{g}>1+\frac{5}{2(1-\alpha)}$ and trivial nebentypus and $\mu$ be a complex number. Assume that $q$ is prime, coprime with $D$ and that $k \geq k_{g}+6$. If $\theta$ is admissible and $|\Re(\mu)| \ll \frac{1}{\log q}$ then for any natural integer $\ell \geq 1$,

$$
\begin{equation*}
\text { Errtwist }(q, \ell ; \mu)=O_{\varepsilon, k, g}\left((q \ell)^{\varepsilon}(1+|\Im(\mu)|)^{B}\left(\ell^{2+\theta} q^{-\left(\frac{1}{2}-\theta\right)}+\ell^{\frac{9}{4}+\frac{\theta}{2}-\alpha} q^{-\left(\alpha-\frac{1}{2}-\theta\right)}\right)\right) \tag{1.10}
\end{equation*}
$$

and for any natural integer $L \geq 1$,

$$
\begin{equation*}
\operatorname{Errsec}(q, L ; \mu)=O_{\varepsilon, k, g}\left((q L)^{\varepsilon}(1+|\Im(\mu)|)^{B}\left(L^{2+2 \theta} q^{-\left(\frac{1}{2}-\theta\right)}+L^{\frac{11}{2}+\theta-2 \alpha} q^{-\left(\alpha-\frac{1}{2}-\theta\right)}\right)\right) \tag{1.11}
\end{equation*}
$$

for some absolute constant $B>0$ and for any $\varepsilon>0$. Consequently, under $H_{2}(\theta)$, every $\Delta<\Delta_{\max }(\theta):=\frac{1-2 \theta}{4(5+2 \theta)}$ is effective granted that $k$ and $k_{g}$ are large enough.

Remark 1.5. We note that:

$$
\begin{aligned}
\Delta_{\max }\left(\theta_{0}\right) & =\frac{25}{668}=0.03742 \ldots \\
\Delta_{\max }(0) & =\frac{1}{20}=0.05
\end{aligned}
$$

The error term in (1.8) comes from the resolution of a shifted convolution problem by the authors, which builds on the $\delta$-symbol method of W. Duke, J.B. Friedlander and H. Iwaniec ([DuFrIw]). This error term is improved using a technique of P. Sarnak (confer [Sa]) which makes systematic use of spectral theory of automorphic forms (see section 6). However, this method alone would only enable us to take $\Delta<\frac{1-2 \theta}{8(4+\theta)}$ and we have to supplement it by additional refinements (in particular by considering the shifted convolution problem on average and detecting cancellations throughout large sieve inequalities) which lead to an effective length of $\frac{1-2 \theta}{4(7+2 \theta)}$. Finally, Proposition D is obtained thanks to an estimate of triple products on average over the spectrum of B. Krötz and R.J. Stanton ([KrSt] and see also [Ko2]).

Another consequence of our refinements is an improvement over the previously known subconvexity bounds for Rankin-Selberg $L$-functions in the level aspect obtained by the amplification method:

Theorem B. Let $g$ be a primitive cusp form of square-free level D, weight $k_{g} \geq 20$ and trivial nebentypus. Let us assume that $q$ is a prime large enough and that $k \geq k_{g}+6$. If $\theta$ is admissible then for any natural integer $j$ and any $f$ in $S_{k}^{p}(q)$, we have

$$
\begin{equation*}
\left|L^{(j)}\left(f \times g, \frac{1}{2}+i t\right)\right|<_{\varepsilon, k, j, g}(1+|t|)^{B} q^{\frac{1}{2}-\omega(\theta)+\varepsilon}, \tag{1.12}
\end{equation*}
$$

for any $\varepsilon>0$ where $t$ is real, the exponent $B$ is absolute and $\omega(\theta):=\frac{1-2 \theta}{4(9+4 \theta)}$.

Remark 1.6. In $[\mathrm{KoMiVa}]$, a subconvex bound is obtained but with $\omega(\theta)$ replaced by $\frac{1}{80}=0.0125$. Note that $\omega\left(\theta_{0}\right)=\frac{25}{1208}=0.020695 \ldots$ and that $\omega(0)=\frac{1}{36}=0.027777 \ldots$

One may wonder what happens when one tries to remove the harmonic weights in Theorem A. In [KoMi], E. Kowalski and P. Michel provided a general technique to deduce asymptotic formulas for the natural average $A_{q}[\alpha]:=$ $\sum_{f \in S_{k}^{p}(q)} \alpha_{f}$ from asymptotic formulas for the harmonic average as long as the coefficients $\alpha_{f}$ do not increase or oscillate too much as $q$ goes to infinity. In our case, one can deduced the same asymptotic formula as in (1.3) for

$$
\mathscr{W}(g ; \mu):=\frac{1}{A_{q}[1]} A_{q}\left[\left|\mathscr{L}\left(. \times g, \frac{1}{2}+\mu\right)\right|^{2}\right]
$$

but with the length of the mollifier strictly smaller than $\omega(\theta)$. In other words, it seems that getting rid of the harmonic weights has a cost in this situation.

Notations. From now on, $\mu$ will denote a complex number and $\tau=\Re(\mu), t=$ $\Im(\mu), \delta=i \Im(\mu)$. We also set $\mu_{1}:=\mu$ and $\mu_{2}:=\bar{\mu}$. In several places, given an Euler product $L(s)=\prod_{p \in \mathscr{P}} L_{p}(s)$, we write $L_{(N)}(s):=\prod_{p \mid N} L_{p}(s)$ and $L^{(N)}(s):=$ $\Pi_{p \nmid N} L_{p}(s)$ for any natural integer $N$. We set: $\log _{2}(x):=\log (\log x)$. $\tau(n)$ equals the number of divisors of $n$ and $\mu(n)$ is the Möbius function at $n$. We will denote by $\varepsilon$ and $B>0$ some absolute positive constants whose definition may vary from line to line. The notations $f(q)<_{A} g(q)$ or $f(q)=O_{A}(q)$ mean that $|f(q)|$ is smaller than a constant which only depends on $A$ times $g(q)$ at least for $q$ large enough. Similarly, $f(q)=o(1)$ means that $\lim _{q \rightarrow+\infty} f(q)=0$. Finally, if $\mathscr{E}$ is a property, the Kronecker symbol $\delta_{\mathscr{E}}$ equals 1 if $\mathscr{E}$ is satisfied and 0 else.

For all background and notations about classical modular forms and RankinSelberg $L$-functions, we refer the reader to sections 3 and 4 of [KoMiVa] and to Appendix C.

## 2 A review of classical modular forms

In this section, we recall general facts about modular forms. The main reference is [?]. For $N \geq 1$, we consider $\Gamma_{0}(N)$ the congruence subgroup of level $N$ and $\varepsilon_{N}$ the trivial Dirichlet character of modulus $N$. All elements of $G L_{2}^{+}(\mathbb{R})$ act on the upper-half plane $\mathbb{H}$ by linear-fractional transformations and this defines an
action of the group $S L_{2}(\mathbb{R})$ on it. For $\gamma=\left(\begin{array}{ll}a & b \\ c & d\end{array}\right)$ in $G L_{2}^{+}(\mathbb{R})$ and $z$ in $\mathbb{H}$ we set $j(\gamma, z):=c z+d$. Let $m$ be an even natural integer. For $\gamma$ in $G L_{2}^{+}(\mathbb{R})$ and $h: \mathbb{H} \rightarrow \mathbb{C}$, we define:

$$
\forall z \in \mathbb{H},\left.\quad h\right|_{\gamma} ^{m}(z):=\frac{(\operatorname{det}(\gamma))^{\frac{m}{2}}}{j(\gamma, z)^{m}} h(\gamma . z) .
$$

This formula clearly defines an action of $S L_{2}(\mathbb{R})$ on the space of complex valued functions on $\mathbb{H}$, which is said to be of weight $m$.

### 2.1 Cusp forms

A holomorphic function $h: \mathbb{H} \mapsto \mathbb{C}$ which satisfies:

$$
\forall \gamma \in \Gamma_{0}(N),\left.\quad h\right|_{\gamma} ^{m}=h
$$

and is holomorphic at the cusps of $\Gamma_{0}(N)$ is a modular form of level $N$, weight $m$ and trivial nebentypus $\varepsilon_{N}$. Such a modular form is a cusp form if $y^{\frac{m}{2}} h(z)$ is bounded on the upper-half plane. We denote by $S_{m}(N)$ this set of cusp forms which is equipped with the Petersson inner product:

\left\langle h_{1}, h_{2}\right\rangle_{N}=\int_{\Gamma_{0}(N) \backslash \mathbb{H}} y^{m} h_{1}(z) \overline{h_{2}(z)} \frac{\mathrm{d} x \mathrm{~d} y}{y^{2}} .
$$

One can obtain the Fourier expansion at infinity of each such cusp form $h$ :

$$
\forall z \in \mathbb{H}, \quad h(z)=\sum_{n \geq 1} \psi_{h}(n) n^{\frac{m-1}{2}} e(n z)
$$

where $e(z):=\exp (2 i \pi z)$.

### 2.2 Hecke operators

For every natural integer $\ell \geq 1$, the Hecke operator of weight $m$, nebentypus $\varepsilon_{N}$ and rank $\ell$ on $S_{m}(N)$ is defined by:

$$
\forall z \in \mathbb{H}, \quad\left(T_{\ell}(h)\right)(z):=\frac{1}{\sqrt{\ell}} \sum_{a d=\ell} \varepsilon_{N}(a) \sum_{0 \leq b<d} h\left(\frac{a z+b}{d}\right) .
$$

Thus, we remark that $T_{\ell}$ is independent of $m$ and we can prove that it is hermitian if $\operatorname{gcd}(\ell, N)=1$. Moreover, we can show that the algebra spanned by the Hecke operators is a commutative one. More precisely, we have the following composition property:

$$
\begin{equation*}
\forall\left(\ell_{1}, \ell_{2}\right) \in\left(\mathbb{N}^{*}\right)^{2}, \quad T_{\ell_{1}} \circ T_{\ell_{2}}=\sum_{d \mid\left(\ell_{1}, \ell_{2}\right)} \varepsilon_{N}(d) T_{\frac{\ell_{1} \ell_{2}}{d^{2}}} \tag{2.1}
\end{equation*}
$$

A cusp form which is also an eigenfunction of the $T_{\ell}$ for $\operatorname{gcd}(\ell, N)=1$ is called a Hecke cusp form and an orthonormal basis of $S_{m}(N)$ made of Hecke cusp forms is called a Hecke eigenbasis.
Atkin-Lehner theory. The main reference of this part is [?]. Briefly speaking, we obtain, with the previous notations, a splitting of $S_{m}(N)$ in $S_{m}^{o}(N) \oplus^{\perp_{(.,)_{N}}} S_{m}^{n}(N)$ where:

\begin{align*}
& S_{m}^{o}(N)=\operatorname{Vect}_{\mathbb{C}}\left\{g(d z), N^{\prime}|N, d| \frac{N}{N^{\prime}}, d \neq 1, g \in S_{m}\left(N^{\prime}\right)\right\}  \tag{2.2}\\
& S_{m}^{n}(N)=\left(S_{m}^{o}(N)\right)^{\perp_{(\ldots,)_{N}}} \tag{2.3}
\end{align*}
$$

where " $o$ " stands for old and " $n$ " for new. These two spaces are invariant under the action of the Hecke operators $T_{l}$ for $\operatorname{gcd}(l, N)=1$. A primitive cusp form $h$ is a Hecke cusp form which is new and satisfies:

$$
\psi_{h}(1)=1
$$

Such an element $h$ is automatically an eigenfunction of the other Hecke operators and also of the Atkin-Lehner operators which will be defined later and satisfies $\psi_{h}(\ell)=\lambda_{h}(\ell)$ for all integer $\ell$ where $T_{\ell}(h)=\lambda_{h}(\ell) h\left(\lambda_{h}(\ell)\right.$ is the Hecke eigenvalue of rank $\ell$ ). The set of primitive cusp forms will be denoted by $S_{m}^{p}(N)$. Let $h$ be a cusp form with Hecke eigenvalues $\left(\lambda_{h}(\ell)\right)_{(\ell, N)=1}$. The composition property (2.1) of the Hecke operators entails that for all $\ell_{1}$ and for $\operatorname{gcd}\left(\ell_{2}, N\right)=1$ :

\psi_{h}\left(\ell_{1}\right) \lambda_{h}\left(\ell_{2}\right) & =\sum_{d \mid\left(\ell_{1}, \ell_{2}\right)} \varepsilon_{N}(d) \psi_{h}\left(\frac{\ell_{1} \ell_{2}}{d^{2}}\right)  \tag{2.4}\\
\psi_{h}\left(\ell_{1} \ell_{2}\right) & =\sum_{d \mid\left(\ell_{1}, \ell_{2}\right)} \mu(d) \varepsilon_{N}(d) \psi_{h}\left(\frac{\ell_{1}}{d}\right) \lambda_{h}\left(\frac{\ell_{2}}{d}\right) \tag{2.5}
\end{align*}
$$

and this relation holds for all $\ell_{1}, \ell_{2}$ if $h$ is primitive. The adjointness relation is:

$$
\begin{equation*}
\forall \operatorname{gcd}(\ell, N)=1, \quad \lambda_{h}(\ell)=\overline{\lambda_{h}(\ell)}, \quad \psi_{h}(\ell)=\overline{\psi_{h}(\ell)} \tag{2.6}
\end{equation*}
$$

and this remains true for all $\ell$ if $h$ is a primitive cusp form.

### 2.3 Bounds for Hecke eigenvalues of cusp forms

Let $h$ be a primitive cusp form of level $N$, weight $m$ and trivial nebentypus $\varepsilon_{N}$. Remember that:

\forall \ell \in \mathbb{N}^{*}, \quad T_{\ell} h=\lambda_{h}(\ell) h
$$

For a prime $p$, let $\alpha_{h, 1}(p)$ and $\alpha_{h, 2}(p)$ be the complex roots of the following quadratic equation:

X^{2}-\lambda_{h}(p) X+\varepsilon_{N}(p)=0
$$

It follows from the work of Eichler-Shimura-Igusa and Deligne that the RamanujanPetersson bound holds true:

$$
\begin{equation*}
\left|\alpha_{h, 1}(p)\right|,\left|\alpha_{h, 2}(p)\right| \leq 1 \text { and so } \forall \ell \geq 1,\left|\lambda_{h}(\ell)\right| \leq \tau(\ell) . \tag{2.7}
\end{equation*}
$$

Setting $\sigma_{h}(n):=\sum_{d \mid n}\left|\lambda_{h}(d)\right|$, it entails that:

\forall X>0, \quad \sum_{n \leq X} \sigma_{h}(n)^{2} \ll_{\varepsilon, h} X^{1+\varepsilon} \tag{2.8}
\end{equation*}
$$

for all $\varepsilon>0$.

### 2.4 Atkin-Lehner operators

The results of this part were established by A. Atkin and J. Lehner. We assume that $N=N_{1} N_{2}$ with $\operatorname{gcd}\left(N_{1}, N_{2}\right)=1$. Let $x, y, z, w$ four integers satisfying:

$$
\begin{aligned}
y & \equiv 1 \bmod \left(N_{1}\right), \\
x & \equiv 1 \bmod \left(N_{2}\right), \\
N_{1}^{2} x w-N y z & =N_{1} .
\end{aligned}
$$

If $\omega_{N_{1}}=\left(\begin{array}{cc}x N_{1} & y \\ z N & w N_{1}\end{array}\right)$ then $W_{N_{1}}=\left\lvert\, \begin{aligned} & m \\ & \omega_{N_{1}}\end{aligned}\right.$ is a linear endomorphism of $S_{m}(N)$ independent of $x, y, z$ and $w$. If $N_{1}=N$ then $W_{N_{1}}$ is the classical Fricke involution given by $\omega_{N}=\left(\begin{array}{cc}0 & 1 \\ -N & 0\end{array}\right)$. The following proposition holds:

Proposition 2.1 (A. Atkin-W. Li (1970)). If $N_{1} \mid N$ and $g c d\left(N_{1}, \frac{N}{N_{1}}\right)=1$ then:

$$
\forall h \in S_{m}^{n}(N), \quad W_{N_{1}} h=\eta_{h}\left(N_{1}\right) h
$$

where $\eta_{h}\left(N_{1}\right)= \pm 1$.

## 3 A review of Rankin-Selberg L-functions

Throughout this section, $g_{1}$ belongs to $S_{k_{1}}^{p}\left(D_{1}\right)$ and $g_{2}$ belongs to $S_{k_{2}}^{p}\left(D_{2}\right)$.

### 3.1 About Rankin-Selberg L-functions

The Rankin-Selberg L-function of $g_{1}$ and $g_{2}$ is the following $L$-function defined a priori for $\Re(s)>1$ by:

$$
L\left(g_{1} \times g_{2}, s\right):=\zeta^{\left(D_{1} D_{2}\right)}(2 s) \sum_{l \geq 1} \frac{\lambda_{g_{1}}(l) \lambda_{g_{2}}(l)}{l^{s}}
$$

It admits an Eulerian product $L\left(g_{1} \times g_{2},.\right):=\prod_{p \in \mathscr{P}} L_{p}\left(g_{1} \times g_{2},.\right)$ where:

$$
\forall p \in \mathscr{P}, \forall s \in \mathbb{C}, \quad L_{p}\left(g_{1} \times g_{2}, s\right)=\prod_{1 \leq i, j \leq 2}\left(1-\alpha_{g_{1}, i}(p) \alpha_{g_{2}, j}(p) p^{-s}\right)^{-1}
$$

By Rankin-Selberg theory, $L\left(g_{1} \times g_{2},.\right)$ admits a meromorphic continuation to the complex plane with at most simple poles at $s=0,1$ which occur only if $g_{1}=g_{2}$.

This L-function satisfies a functional equation. When $\operatorname{gcd}\left(D_{1}, D_{2}\right)=1$, it takes the following form. We set:
$\forall s \in \mathbb{C}, \quad \Lambda\left(g_{1} \times g_{2}, s\right):=\left(\frac{D_{1} D_{2}}{4 \pi^{2}}\right)^{s} \Gamma\left(s+\frac{\left|k_{1}-k_{2}\right|}{2}\right) \Gamma\left(s+\frac{k_{1}+k_{2}}{2}-1\right) L\left(g_{1} \times g_{2}, s\right)$.
The functional equation is then:

$$
\forall s \in \mathbb{C}, \quad \Lambda\left(g_{1} \times g_{2}, s\right)=\varepsilon\left(g_{1} \times g_{2}\right) \Lambda\left(g_{1} \times g_{2}, 1-s\right)
$$

where the sign of the functional equation in our case is $\varepsilon\left(g_{1} \times g_{2}\right)=1$.

### 3.2 About symmetric square L-functions

Closely related to $L\left(g_{1} \times g_{1},.\right)$ is the following Dirichlet series defined for $\Re(s)>1$ :

$$
L\left(\operatorname{Sym}^{2}\left(g_{1}\right), s\right):=\zeta^{\left(D_{1}\right)}(2 s) \sum_{l \geq 1} \frac{\lambda_{g_{1}}\left(l^{2}\right)}{l^{s}}
$$

The Eulerian product of $L\left(\operatorname{Sym}^{2}\left(g_{1}\right),.\right)$ is given by $\prod_{p \in \mathscr{P}} L_{p}\left(\operatorname{Sym}^{2}\left(g_{1}\right),.\right)$ with:

$$
\forall p \in \mathscr{P}, \forall s \in \mathbb{C}, \quad L_{p}\left(\operatorname{Sym}^{2}\left(g_{1}\right), s\right)=\prod_{1 \leq i \leq j \leq 2}\left(1-\alpha_{g_{1}, i}(p) \alpha_{g_{1}, j}(p) p^{-s}\right)^{-1}
$$

Hence, we get $L\left(g_{1} \times g_{1}, s\right)=\zeta^{\left(D_{1}\right)}(s) L\left(\operatorname{Sym}^{2} g_{1}, s\right)$ for all complex number $s$.

## 4 Proof of Theorem $A$ and estimates for the analytic rank

### 4.1 Principle of the proof

Let $b>0, c>0$ and $\sigma_{0}>1$ some real numbers. $\mathscr{B}(q)$ will denote the rectangular box with vertices $\left(\frac{1}{2}-\frac{c}{\log q}, \pm \frac{b}{\log q}\right)$ and $\left(\sigma_{0}, \pm \frac{b}{\log q}\right)$. Let $N$ be a natural integer and $S_{k}^{p}(q, N)$ be the set of primitive cusp forms $f$ in $S_{k}^{p}(q)$ whose Rankin-Selberg L-function $L(f \times g,$.$) admits$

- a zero of order $2 n_{1}$ at $\frac{1}{2}$,
- and $n_{2}$ zeros (counted with multiplicities) in $\left.] \frac{1}{2}, 1\right]$
such that $2 n_{1}+2 n_{2} \geq 2(N+1)$. Let us remark that $S_{k}^{p}(q) \backslash S_{k}^{p}(q, N)$ is precisely the set of modular forms $f$ in $S_{k}^{p}(q)$ whose Rankin-Selberg $L$-function $L(f \times g$, .) has at most $2 N$ zeros in $[0,1]$. We are producing some $N$ such that (as $q$ tends to infinity among the primes)

$$
\mu_{q}^{h}\left(S_{k}^{p}(q, N)\right) \leq s_{0}(N)+o_{g}(1)
$$

with $s_{0}(N)<1$ a constant which depends only on $N$ and conclude that for at least $100\left(1-s_{0}(N)\right)$ percent of primitive cusp forms of weight $k$ and trivial nebentypus, $L(f \times g,$.$) has at most 2 N$ non-trivial zeros on the real axis (and in fact in a small box $\mathscr{B}(q))$.

### 4.2 Selberg's lemma

Lemma 4.1. Let $\psi$ be a holomorphic function which does not vanish on a half plane $\Re(z) \geq W$. Let $\mathscr{B}$ be the rectangular box of vertices $W_{0} \pm i H, W_{1} \pm i H$ where $H>0$ and $W_{0}<W<W_{1}$. We have:

$$
\begin{array}{r}
4 H \sum_{\substack{\beta+i \gamma \in \mathscr{B} \\
\psi(\beta+i \gamma)=0}} \cos \left(\frac{\pi \gamma}{2 H}\right) \sinh \left(\frac{\pi\left(\beta-W_{0}\right)}{2 H}\right)=\int_{-H}^{H} \cos \left(\frac{\pi t}{2 H}\right) \log \left|\psi\left(W_{0}+i t\right)\right| \mathrm{d} t \\
+\int_{W_{0}}^{W_{1}} \sinh \left(\frac{\pi\left(\alpha-W_{0}\right.}{2 H}\right) \log |\psi(\alpha+i H) \psi(\alpha-i H)| \mathrm{d} \alpha \\
\\
-\Re\left(\int_{-H}^{H} \cos \left(\pi \frac{W_{1}-W_{0}+i t}{2 i H}\right)(\log \psi)\left(W_{1}+i t\right)\right) \mathrm{d} t .
\end{array}
$$

A proof of this lemma is given in [CoSo] and relies on the fact that

$$
\int_{\partial \mathscr{B}} k(s)(\log f)(s) \mathrm{d} s=0
$$

with $k(s):=\cos \left(\pi \frac{s-W_{0}}{2 i H}\right)$. Let us mention the properties which will be useful to us:

- $k$ is purely imaginary on $\Im(s)=H$ and satisfies over there $k(s)=-k(\bar{s})$,
- $\Re(k) \geq 0$ in $\mathscr{B}$.


### 4.3 The successive steps

We follow the method of J.B. Conrey and K. Soundararajan ([CoSo]). Lemma 4.1 applied to the box $\mathscr{B}(q)$ and the function $L(f \times g,$.$) entails that$
(4.1) $4 b \sinh \left(\frac{\pi c}{2 b}\right) r(f \times g)+4 b \sum_{\substack{\beta \geq \frac{1}{2}-\frac{c}{\log q} \\ \beta \neq \frac{1}{2} \\ L(f \times g, \beta)=0}} \sinh \left(\frac{\pi\left(c+\log q\left(\beta-\frac{1}{2}\right)\right)}{2 b}\right) \leq \sum_{j=1}^{3} I_{f}^{q}(j)$
where

$$
\begin{gathered}
I_{f}^{q}(1)=\int_{-b}^{b} \cos \left(\frac{\pi t}{2 b}\right) \log \left|L\left(f \times g, \frac{1}{2}-\frac{c}{\log q}+i \frac{t}{\log q}\right)\right| \mathrm{d} t \\
I_{f}^{q}(2)=\int_{-c}^{\left(\sigma_{0}-\frac{1}{2}\right) \log q} \sinh \left(\frac{\pi(x+c)}{2 b}\right) \log \left|L\left(f \times g, \frac{1}{2}+\frac{x}{\log q}+i \frac{b}{\log q}\right)\right|^{2} \mathrm{~d} x, \\
I_{f}^{q}(3)=-\Re\left(\int_{-b}^{b} \cos \left(\pi \frac{\left(\sigma_{0}-\frac{1}{2}\right) \log q+c+i t}{2 i b}\right)(\log L(f \times g, .))\left(\sigma_{0}+i \frac{t}{\log q}\right) \mathrm{d} t\right) .
\end{gathered}
$$

One can show (confer [Ri]) that if $f$ belongs to $S_{k}^{p}(q, N)$ then the left-hand side of $(4.1)$ is larger than $(N+1) \times 8 b \sinh \left(\frac{\pi c}{2 b}\right)$. Thus,

$$
\mu_{q}^{h}\left(S_{k}^{p}(q, N)\right) \leq \frac{1}{N+1} \frac{1}{8 b \sinh \left(\frac{\pi c}{2 b}\right)} \frac{1}{A_{q}^{h}[1]} A_{q}^{h}\left[\sum_{j=1}^{3} I^{q}(j)\right] .
$$

The concavity of the log function leads to

$$
\begin{equation*}
\mu_{q}^{h}\left(S_{k}^{p}(q, N)\right) \leq \frac{1}{N+1} \frac{1}{8 b \sinh \left(\frac{\pi c}{2 b}\right)}\left(J_{1}^{q, h}+J_{2}^{q, h}+\frac{1}{A_{q}^{h}[1]} A_{q}^{h}\left[I^{q}(3)\right]\right) \tag{4.2}
\end{equation*}
$$

where

$$
\begin{aligned}
J_{1}^{q, h} & :=\int_{0}^{b} \cos \left(\frac{\pi t}{2 b}\right) \log \left(\frac{1}{A_{q}^{h}[1]} A_{q}^{h}\left[\left|L\left(\times g, \frac{1}{2}+\frac{-c+i t}{\log q}\right)\right|^{2}\right]\right) \mathrm{d} t \\
J_{2}^{q, h} & :=\int_{-c}^{\left(\sigma_{0}-\frac{1}{2}\right) \log q} \sinh \left(\frac{\pi(x+c)}{2 b}\right) \log \left(\frac{1}{A_{q}^{h}[1]} A_{q}^{h}\left[\left|L\left(\times g, \frac{1}{2}+\frac{x+i b}{\log q}\right)\right|^{2}\right]\right) \mathrm{d} x .
\end{aligned}
$$

Similarly, we have from (4.1):

$$
\begin{equation*}
\frac{1}{A_{q}^{h}[1]} A_{q}^{h}[r(. \times g)] \leq 2 \frac{1}{8 b \sinh \left(\frac{\pi c}{2 b}\right)}\left(J_{1}^{q, h}+J_{2}^{q, h}+\frac{1}{A_{q}^{h}[1]} A_{q}^{h}\left[I^{q}(3)\right]\right) \tag{4.3}
\end{equation*}
$$

We need the right-hand side of (4.2) and (4.3) to be small. Unfortunately, the weight function $\sinh \left(\frac{\pi(x+c)}{2 b}\right)$ which appears in $J_{2}^{q, h}$ grows exponentially on the horizontal sides of the box. This problem is solved by mollifying: one replaces $L(f \times g,$.$) by \mathscr{L}(f \times g,$.$) such that the exponential growth of \sinh \left(\frac{\pi(x+c)}{2 b}\right)$ is balanced by the exponential decay of $\log \left(\frac{1}{A_{q}^{h}[1]} \mathscr{W}^{h}\left(g ; \frac{x+i b}{\log q}\right)\right)$.

Remark 4.1. Naively, one would like to be able to choose a kernel $k$ having the properties listed above in section 4.2 and such that the corresponding weight function (in $J_{2}^{q, h}$ ) does not grow exponentially on the horizontal sides of $\mathscr{B}(q)$. Unfortunately, as K. Soundararajan remarked at the Journées Arithmétiques 2003 in Graz, such kernel does not exist. So, it appears that the mollification step is a necessity.

### 4.4 Choosing the mollifier

Note that on the half plane $\Re(s)>1, L(f \times g, s)=\sum_{n \geq 1} a_{f \times g}(n) n^{-s}$ where

a_{f \times g}(n)=\sum_{n=n_{1}^{2} n_{2}} \varepsilon_{q}\left(n_{1}\right) \varepsilon_{D}\left(n_{1}\right) \lambda_{f}\left(n_{2}\right) \lambda_{g}\left(n_{2}\right)

satisfies $\left|a_{f \times g}(n)\right| \ll_{\varepsilon} n^{\varepsilon}$ for any $\varepsilon>0$. We need the Dirichlet coefficients of the inverse of $L(f \times g,$.$) :$

Lemma 4.2. For $\Re(s)>1$ one has

\frac{1}{L(f \times g, s)}=K(g, 2 s) \sum_{\ell=\ell_{1} \ell_{2}^{2} \ell_{3}^{3}} \frac{\mu^{2}\left(\ell_{1} \ell_{2} \ell_{3}\right) \mu\left(\ell_{1} \ell_{3}\right) \varepsilon_{q}\left(\ell_{3}\right) \varepsilon_{D}\left(\ell_{2} \ell_{3}\right) \lambda_{g}\left(\ell_{1} \ell_{3}\right)}{K_{(\ell)}(g, s) \ell^{s}} \lambda_{f}\left(\ell_{1} \ell_{2}^{2} \ell_{3}\right)
$$

where $K(g, s):=\prod_{p \in \mathscr{P}} K_{p}(g, s)$ is an absolutely convergent Euler product on $\Re(s)>$ 2 given by

\forall p \in \mathscr{P}, \quad K_{p}(g, s):=1+\varepsilon_{q}(p) \lambda_{g}\left(p^{2}\right) p^{-s}+\varepsilon_{q D}(p) p^{-2 s}
$$

Proof of lemma 4.2. We give no details. Setting $L(f \times g, s)^{-1}:=\sum_{\ell \geq 1} u_{\ell} \ell^{-s}$, one shows that $u_{\ell}=0$ except if $\ell=\ell_{1} \ell_{2}^{2} \ell_{3}^{3} \ell_{4}^{4}$ with $\ell_{1}, \ell_{2}, \ell_{3}, \ell_{4}$ square-free numbers pairwise coprime:

$$

Note that $K(g, s)$ is an absolutely convergent Euler on $\Re(s)>2$ as:

Let $0<\Upsilon<1$ be a real number and $P$ be a polynomial satisfying $P(\Upsilon)=1, P(0)=$ $P^{\prime}(0)=P^{\prime}(\Upsilon)=0$. Let $L \geq 1$ be a natural integer. We set:

The mollifier we choose is

M(f \times g, s)= & K(g, 2 s) \sum_{\ell=\ell_{1} \ell_{2}^{2} \ell_{3}^{3}} \frac{\mu^{2}\left(\ell_{1} \ell_{2} \ell_{3}\right) \mu\left(\ell_{1} \ell_{3}\right) \varepsilon_{D}\left(\ell_{3}\right) \varepsilon_{q}\left(\ell_{2} \ell_{3}\right) \lambda_{g}\left(\ell_{1} \ell_{3}\right)}{K_{(\ell)}(g, 2 s)^{-1} \ell^{s}} \\
& \lambda_{f}\left(\ell_{1} \ell_{2}^{2} \ell_{3}\right) F_{L}^{\Upsilon}\left(\ell_{1} \ell_{2}^{2} \ell_{3}\right) \\
= & \sum_{\ell \geq 1} \frac{x_{\ell}(g, s)}{\ell^{s}} \lambda_{f}(\ell)
\end{aligned}
$$

where

$$
x_{\ell}(g, s)=K(g, 2 s) \sum_{\ell=\ell_{1} \ell_{2}^{2} \ell_{3}} \frac{\mu^{2}\left(\ell_{1} \ell_{2} \ell_{3}\right) \mu\left(\ell_{1} \ell_{3}\right) \varepsilon_{q}\left(\ell_{3}\right) \varepsilon_{D}\left(\ell_{2} \ell_{3}\right) \lambda_{g}\left(\ell_{1} \ell_{3}\right) F_{L}^{\Upsilon}(\ell)}{K_{(\ell)}(g, 2 s) \ell_{3}^{2 s}}
$$

so that $M(f \times g,$.$) is a Dirichlet polynomial of length at most L$ which approximates $L(f \times g, .)^{-1}$. From the shape of the mollifier, we immediately deduce

on $\Re(s)>1+\varepsilon$ for any $\varepsilon>0$. As a consequence, $\mathscr{L}(f \times g$,.) has no zeros to the right of $1+\frac{\log _{2} q}{\log q}$ (at least for $q$ large enough). Moreover, for $q$ large enough, $|\mathscr{L}(f \times g, s)-1|<1$ on $\Re(s)>1+\varepsilon$ and we choose the branch of the logarithm given by

on $\Re(s)>1+\varepsilon$. We are going to give a useful integral expression of the coefficients $x_{\ell}(g, s)$ of the mollifier following a technique introduced in [KoMiVa2]. To each polynomial $A(X)=\sum_{k \geq 0} a_{k} X^{k}$ and to each real number $M$, we associate the following transform:

We have the following result:

## Lemma 4.3. Let $m \geq 1$ be a natural integer.

where $\int^{(1)} A$ is the first antiderivative of $A$ without constant of integration.
Proof of lemma 4.3. By linearity, it is enough to prove this lemma for $A(X)=X^{k}$ with $k \in \mathbb{N}^{*}$. Setting $y=\frac{M}{m}$, it consists in proving that

\frac{1}{2 i \pi} \int_{(3)} y^{s} \frac{\mathrm{~d} s}{s^{k+2}}=\delta_{y>1} \frac{\log ^{k+1}(y)}{(k+1)!}
$$

which is standard using suitable contour shifts (confer [KoMiVa2]).

To the polynomial $P$, we associate $R(X):=P((1-\Upsilon) X+\Upsilon)-1$ and we have the integral expression of the coefficients of the mollifier:

Proposition 4.4. Let $\ell \geq 1$ be a natural integer and $s$ be a complex number.

x_{\ell}(g, s)=\frac{1}{2 i \pi \log L} & \int_{(3)} L^{(1-\Upsilon) s}\left(\widehat{P_{L}^{\prime}}(s) L^{\Upsilon s}-\frac{1}{1-\Upsilon} \widehat{R_{L^{1-\Upsilon}}^{\prime}}(s)\right) K(g, 2 s) \\
& \times \sum_{\ell=\ell_{1} \ell_{2}^{2} \ell_{3}} \frac{\mu^{2}\left(\ell_{1} \ell_{2} \ell_{3}\right) \mu\left(\ell_{1} \ell_{3}\right) \varepsilon_{q}\left(\ell_{3}\right) \varepsilon_{D}\left(\ell_{2} \ell_{3}\right) \lambda_{g}\left(\ell_{1} \ell_{3}\right)}{K_{(\ell)}(g, 2 s) \ell_{3}^{2 s} \ell^{s}} \frac{\mathrm{~d} s}{s^{2}}
\end{aligned}
$$

Proof of proposition 4.4. The main point is that we have:

F_{L}^{\Upsilon}(\ell)=\frac{1}{2 i \pi \log L} \int_{(3)}\left(\frac{L^{1-\Upsilon}}{\ell}\right)^{s}\left(\widehat{P_{L}^{\prime}}(s) L^{\Upsilon s}-\frac{1}{1-\Upsilon} \widehat{R_{L^{1-\Upsilon}}^{\prime}}(s)\right) \frac{\mathrm{d} s}{s^{2}} .
$$

The previous integral expression of $F_{L}^{\Upsilon}(\ell)$ is a direct consequence of lemma 4.3.

### 4.5 End of the proof

We repeat the same procedure as in section 4.3 but with the mollified RankinSelberg $L$-function instead of the Rankin-Selberg $L$-function itself. Then, (4.2) and (4.3) become

\frac{1}{A_{q}^{h}[1]} A_{q}^{h}[r(. \times g)] \leq 2 \frac{1}{8 b \sinh \left(\frac{\pi c}{2 b}\right)}\left(J_{1}^{q, h}+J_{2}^{q, h}+\frac{1}{A_{q}^{h}[1]} A_{q}^{h}\left[I^{q}(3)\right]\right) \tag{4.6}
\end{equation*}
$$

where

$$
\begin{aligned}
J_{1}^{q, h} & :=\int_{0}^{b} \cos \left(\frac{\pi t}{2 b}\right) \log \left(\frac{1}{A_{q}^{h}[1]} \mathscr{W}^{h}\left(g ; \frac{-c+i t}{\log q}\right)\right) \mathrm{d} t \\
J_{2}^{q, h} & :=\int_{-c}^{\left(\sigma_{0}-\frac{1}{2}\right) \log q} \sinh \left(\frac{\pi(x+c)}{2 b}\right) \log \left(\frac{1}{A_{q}^{h}[1]} W^{h}\left(g ; \frac{x+i b}{\log q}\right)\right) \mathrm{d} x .
\end{aligned}
$$

We set $\tilde{b}:=2 b, \tilde{c}:=2 c$ and we choose $\sigma_{0}:=1+\frac{\log _{2} q}{\log q}$ and we assume that $\Delta$ is effective. Theorem A. 1 leads to:

This is an error term under the following assumption on the height of the box:

Our choice of the height of the box (so that all integrals converge), Proposition D , Remark 1.4 and (1.3) entail that

J_{2,2}^{q, h} & \ll \exp \left(-\left(4 \Delta(1-\Upsilon)-\frac{\pi}{\tilde{b}}\right)\right) \log ^{\beta}(q)
\end{aligned}
$$

and we conclude that

\mu_{q}^{h}\left(S_{k}^{p}(q, N)\right) \leq \frac{1}{N+1} \frac{1}{8 \tilde{b} \sinh \left(\frac{\pi \tilde{c}}{2 \tilde{b}}\right)} & \left(\int_{0}^{\tilde{b}} \cos \left(\frac{\pi t}{2 \tilde{b}}\right) \log (V(-\tilde{c}, t)) \mathrm{d} t\right. \\
& \left.+\int_{0}^{\infty} \sinh \left(\frac{\pi x}{2 \tilde{b}}\right) \log (V(x-\tilde{c}, \tilde{b})) \mathrm{d} x\right)+o_{g}(1)
\end{aligned}
$$

and that

$$
\begin{aligned}
\frac{1}{A_{q}^{h}[1]} A_{q}^{h}[r(. \times g)] \leq 2 \frac{1}{8 \tilde{b} \sinh \left(\frac{\pi \tilde{c}}{2 \tilde{b}}\right)} & \left(\int_{0}^{\tilde{b}} \cos \left(\frac{\pi t}{2 \tilde{b}}\right) \log (V(-\tilde{c}, t)) \mathrm{d} t\right. \\
+ & \left.\int_{0}^{\infty} \sinh \left(\frac{\pi x}{2 \tilde{b}}\right) \log (V(x-\tilde{c}, \tilde{b})) \mathrm{d} x\right)+o_{g}(1)
\end{aligned}
$$

We choose under $H_{2}(\theta), P(x)=3\left(\frac{x}{\Upsilon}\right)^{2}-2\left(\frac{x}{\Upsilon}\right)^{3}, \tilde{b}=\frac{\pi}{4 \Delta(1-\Upsilon)-10^{-10}}, \Delta=\Delta_{\max }(\theta)-$ $10^{-10}$ and we minimize ${ }^{2}$ the right-hand side by a numerical choice of the remaining parameters. Under $H_{2}\left(\theta_{0}\right)^{3}$, the choice $\Upsilon=0.44, \tilde{c}=23$ gives

Finally, $N$ must be 4.

## 5 The harmonic mollified second moment near the critical point

### 5.1 The second harmonic twisted moment

E. Kowalski, P. Michel and J. Vanderkam computed this moment under some sensible conditions on $D$ and $k, q$.

We recall here some notations used in [KoMiVa]. For $z, s$ some complex numbers, we set

[^1]where $\xi(s)=s(1-s) \pi^{-\frac{s}{2}} \Gamma\left(\frac{s}{2}\right) \zeta(s)$ and $P_{g}(s)$ is an even polynomial whose coefficients are real and depend only on $k$ and $k_{g}$ chosen such that the function $P_{g}(s) \Gamma\left(\frac{1}{2}+s+\frac{\left|k-k_{g}\right|}{2}\right) \Gamma\left(\frac{1}{2}+s+\frac{k+k_{g}}{2}-1\right)$ is analytic on $\Re(s)>-A$ where $A>\frac{1}{2}$. We observe that

\forall(z, s) \in \mathbb{C}^{2}, \quad G_{g, z}(-s)=\varepsilon_{z}(f \times g) G_{g,-z}(s) \tag{5.1}
\end{equation*}
$$

\]

with

$$
\varepsilon_{z}(f \times g):=\frac{\left(4 \pi^{2}\right)^{z} \Gamma\left(\frac{1}{2}-z+\frac{\left|k-k_{g}\right|}{2}\right) \Gamma\left(\frac{1}{2}-z+\frac{k+k_{g}}{2}-1\right)}{\left(4 \pi^{2}\right)^{-z} \Gamma\left(\frac{1}{2}+z+\frac{\left|k-k_{g}\right|}{2}\right) \Gamma\left(\frac{1}{2}+z+\frac{k+k_{g}}{2}-1\right)}
$$

Then, we set:

H_{g, z}(s):=\left(4 \pi^{2}\right)^{-s} \Gamma\left(\frac{1}{2}+s+\frac{\left|k-k_{g}\right|}{2}\right) \Gamma\left(\frac{1}{2}+s+\frac{k+k_{g}}{2}-1\right) G_{g, z}(s)
$$

So, it follows that $H_{g, z}(z)=1$.
We need to introduce some extra notations. For any $(\alpha, \beta)=( \pm \mu, \pm \bar{\mu})$ and any natural integer $\ell \geq 1$, we set

with

& J_{g}(u, v ;(\alpha, \beta) ; \ell):=H_{g, \alpha}(u) \zeta^{(D)}(1+2 u) H_{g, \beta}(v) \zeta^{(q D)}(1+2 v) \\
& \times v_{g}(\ell ; u, v) \frac{L(g \times g, 1+u+v)}{\zeta^{D}(2(1+u+v))}
\end{aligned}

$v_{g}(\ell ; u, v):=\sum_{\delta \varepsilon=\ell} \frac{1}{\delta^{u} \varepsilon^{v}} \prod_{p \mid \delta \varepsilon}\left(\sum_{k \geq 0} \frac{\lambda_{g}\left(p^{k+v_{p}(\delta)}\right) \lambda_{g}\left(p^{k+v_{p}(\varepsilon)}\right)}{p^{k(1+u+v)}}\right)\left(\sum_{k \geq 0} \frac{\lambda_{g}\left(p^{k}\right) \lambda_{g}\left(p^{k}\right)}{p^{k(1+u+v)}}\right)^{-1}$.
Finally, we set:

\varepsilon_{f \times g}(-\mu, \bar{\mu}) & =\varepsilon_{\mu}(f \times g), \\
\varepsilon_{f \times g}(\mu,-\bar{\mu}) & =\varepsilon_{\bar{\mu}}(f \times g), \\
\varepsilon_{f \times g}(-\mu,-\bar{\mu}) & =\varepsilon_{\mu}(f \times g) \varepsilon_{\bar{\mu}}(f \times g) .
\end{aligned}
$$

One has:

Theorem 5.1 (E. Kowalski-P. Michel-J. Vanderkam (2002)). Let $g$ be a primitive cusp form of square-free level $D$ and trivial nebentypus. Assume that $q$ is prime, coprime with $D$. If $|\tau| \ll \frac{1}{\log q}$ then for any natural integer $1 \leq \ell<q$,

(q D)^{2 \tau} \mathscr{M}_{g}^{h}(\mu ; \ell)=\sum_{(\alpha, \beta)=( \pm \mu, \pm \bar{\mu})} \varepsilon_{f \times g}(\alpha, \beta) \mathrm{M}_{g}((\alpha, \beta) ; \ell)+\operatorname{Errtwist}(q, \ell ; \mu)
$$

where

$$
\operatorname{Errtwist}(q, \ell ; \mu)=O_{\varepsilon, k, g}\left((q \ell)^{\varepsilon}(1+|t|)^{B}\left(\ell^{a_{1}} q^{-b_{1}}+\ell^{a_{2}} q^{-b_{2}}\right)\right)
$$

for any $\varepsilon>0$ with $a_{1}=\frac{3}{4}, b_{1}=\frac{1}{12}$ and $a_{2}=\frac{17}{8}, b_{2}=\frac{1}{4}$.
Remark 5.1. Actually, theorem 5.1 was only proved for $k<12$ so that $S_{k}(q)$ has no old forms. We explain in appendix B how to remove this condition using a technique of H. Iwaniec, W. Luo and P. Sarnak ([IwLuSa]).

Coming back to the notation of the introduction, we have:

### 5.2 The harmonic mollified second moment near $\frac{1}{2}$

By opening the square and using multiplicative properties of Hecke eigenvalues, one gets

\mathscr{W}^{h}(g ; \mu)=(q D)^{-2 \tau} \sum_{\ell_{1}, \ell_{2} \geq 1} \frac{1}{\ell_{1}^{\frac{1}{2}+\mu_{1}} \ell_{2}^{\frac{1}{2}+\mu_{2}}} \sum_{d \geq 1} \frac{\varepsilon_{q}(d)}{d^{1+2 \tau}} x_{d \ell_{1}}\left(g, \frac{1}{2}+\mu_{1}\right) x_{d \ell_{2}}\left(g, \frac{1}{2}+\mu_{2}\right) \\
\times(q D)^{2 \tau} \mu_{g}^{h}\left(\mu ; \ell_{1} \ell_{2}\right)
\end{array}
$$

where one has set $\mu_{1}:=\mu$ and $\mu_{2}:=\bar{\mu}$. Our next step is to evaluate $W^{h}(g ; \mu)$ for $\mu$ within a distance $O\left(\frac{1}{\log q}\right)$ of the origin (Proposition C). We set for $(\alpha, \beta)=$ $( \pm \mu, \pm \bar{\mu})$ :

Remark 5.2. Equation (5.19) is the result of tedious but elementary computations which are carried out in Appendix D. One may find it surprising that this apparently rather complicated Euler product turns out to a have very simple expression (which in fact is crucial for the method to work). This however is a consequence of our choice of mollifier. It is very plausible that a more conceptual explanation of this phenomenon can be gotten from the random matrix model for the family $\mathscr{F}$ of Rankin-Selberg $L$-functions and the vertical SatoTate laws satisfied by the Hecke eigenvalues of modular forms. For this, we refer to the recent work of J.B. Conrey, D. Farmer, J. Keating, M. Rubinstein and N. Snaith ([CoFaKeRuSn]) who formulate very precise conjectures for the moments of central value for many families of $L$-functions (although not for our peculiar family, which certainly can be investigated along the same lines) and the talk of C. Hughes at the Newton Institute on amplified and mollified moments of families of $L$-functions ([Hu]).

Moreover, $\widetilde{\Psi}(\alpha, \beta)=\frac{1}{4 \alpha \beta(\alpha+\beta)} \frac{h_{2}(0,0,0)}{\zeta^{(D)}(2)}+O_{g}\left(\log ^{3}(q)\right)$ and $I_{\alpha, \beta}(L, \Upsilon, P ; \mu) \ll \frac{L^{-2 \tau(1-\Upsilon)}}{\log ^{4}(q)}$.
According to proposition D.3, we have

\frac{h_{2}(0,0,0)}{\zeta^{(D)}(2)}=1+O_{g}\left(\frac{1}{q^{\delta}}\right) \tag{5.23}
\end{equation*}
$$

for some $\delta>0$. Thus, the contribution of the long range terms is

which is exactly the main term of (5.22) according to lemma 5.12.

## 6 Averaged shifted convolution problems

This section is the central part of this paper. We give here a way of solving shifted convolution problems on average.

### 6.1 Introduction and first result

Let $\Psi: \mathbb{R}_{+}^{*} \times \mathbb{R}_{+}^{*} \rightarrow \mathbb{R}$ be a smooth compactly supported function

for some real numbers $Z, Y>0$ satisfying

\exists P>0, \forall(\alpha, \beta) \in \mathbb{N}^{2}, \forall(z, y) \in\left(\mathbb{R}_{+}^{*}\right)^{2}, \quad z^{\alpha} y^{\beta} \frac{\partial^{\alpha+\beta} \Psi}{\partial z^{\alpha} \partial y^{\beta}}(z, y) \ll_{\alpha, \beta} P^{\alpha+\beta} \tag{6.2}
\end{equation*}
$$

Let $a_{1}, a_{2} \geq 1$ with $a_{1} a_{2}<q$ be some natural integers. One considers the shifted convolution problem

\forall h \in \mathbb{Z}^{*}, \quad S_{h}\left(\Psi, g ; a_{1}, a_{2}\right):=\sum_{a_{1} m-a_{2} n=h} \lambda_{g}(m) \lambda_{g}(n) \Psi\left(a_{1} m, a_{2} n\right)
$$

and the shifted convolution problem on average

$$
\Sigma_{r}\left(\Psi, g ; a_{1}, a_{2}\right):=\sum_{\substack{h \in \mathbb{Z}^{*} \\ h \equiv 0}} S_{h}\left(\Psi, g ; a_{1}, a_{2}\right)
$$

for any natural integer $r \geq 1$. Note that the $h$-sum is of length $\sup (Z, Y)$. Solving the shifted convolution problem (respectively the shifted convolution problem on average) consists in finding a non-trivial bound for $S_{h}\left(\Psi, g ; a_{1}, a_{2}\right)$ (respectively $\left.\Sigma_{r}\left(\Psi, g ; a_{1}, a_{2}\right)\right)$. The $\delta$-symbol method of W. Duke, J. Friedlander and H. Iwaniec (confer [DuFrIw] and [KoMiVa]) leads to:

Theorem 6.1. Let $h \in \mathbb{Z}^{*}$ and $r \in \mathbb{N}^{*}$. If $a_{1} \wedge a_{2}=1$ and $\Psi$ satisfies (6.1) and (6.2) then

S_{h}\left(\Psi, g ; a_{1}, a_{2}\right)<_{\varepsilon, g} P^{\frac{5}{4}}(Z+Y)^{\frac{1}{4}}(Y Z)^{\frac{1}{4}+\varepsilon}

for any $\varepsilon>0$. Thus,

\Sigma_{r}\left(\Psi, g ; a_{1}, a_{2}\right) \ll_{\varepsilon, g} P^{\frac{5}{4}}(Z+Y)^{\frac{1}{4}}(Y Z)^{\frac{1}{4}+\varepsilon} \frac{\sup (Z, Y)}{r}
$$

for any $\varepsilon>0$.

### 6.2 The spectral method on average

For some background and notations about Maass forms we refer to appendix C. All is based on the analytic properties of the following Dirichlet series (confer [Sa] and [Mi1])

$$

which is linked to our problem by Mellin's inversion formula

S_{h}\left(g, a_{1}, a_{2}\right)=\frac{1}{2 i \pi} \int_{(2)} D_{h}\left(g, a_{1}, a_{2} ; s\right) \widehat{\Psi}(h, s) \mathrm{d} s \tag{6.3}
\end{equation*}

where
(6.4) $\widehat{\Psi}(h, s)=\int_{\sup \left(|h|, h+N a_{2}\right)}^{h+4 N a_{2}} \Psi\left(\frac{u+h}{2}, \frac{u-h}{2}\right)\left(4+\frac{2 h}{u-h}-\frac{2 h}{u+h}\right)^{\frac{k g-1}{2}} u^{s} \frac{\mathrm{~d} u}{u}$.

Note that $\widehat{\Psi}(h, s)=0$ if $|h| \gg \sup (Z, Y)$. The spectral method consists in getting a non-trivial individual estimate of $D_{h}\left(g, a_{1}, a_{2} ; s\right)$ whereas the spectral method on average takes care of the extra average over $h$.

Lemma 6.2. If $\Psi$ satisfies (6.1) and (6.2) then:

Proof of lemma 6.2. According to the support properties of $\Psi$ and by $\eta$ integration by parts, we have

with $\gamma(u)=\Psi\left(\frac{u+h}{2}, \frac{u-h}{2}\right)\left(4+\frac{2 h}{u-h}-\frac{2 h}{u+h}\right)^{\frac{k g-1}{2}}$. One shows with (6.2) that

A straightforward computation gives:

Let $\beta:=\left(u_{j}\right)_{j \geq 1}$ a Hecke eigenbasis of $\mathscr{C}_{0}\left(D a_{1} a_{2}\right)$ satisfying $\left(\Delta_{0}+\lambda_{j}\right) u_{j}=0$ with $\lambda_{j}:=\frac{1}{4}+r_{j}^{2}$ and made of eigenfunctions of the reflexion operator namely: $\forall n \in$ $\mathbb{Z}^{*}, \rho_{j}(-n)=\varepsilon_{j} \rho_{j}(n)$ for some $\varepsilon_{j} \in\{ \pm 1\}$. Parseval's equality leads to:

The hypothesis $H_{2}(\theta)$ described in the introduction is a very natural one as it allows us to control the size of the discrete part of the right-hand side of (6.5). In fact, H. Iwaniec, W. Luo and P. Sarnak ([IwLuSa]) showed that if $\theta$ is admissible then it is possible to choose $\beta$ with:
(6.6) $\quad \forall h \in \mathbb{Z}^{*}, \quad \rho_{j}(h) \ll_{\varepsilon} \frac{\left(|h| a_{1} a_{2}\left(1+\left|r_{j}\right|\right)\right)^{\varepsilon}}{\sqrt{a_{1} a_{2}}} \cosh \left(\frac{\pi r_{j}}{2}\right)|h|^{\theta-\frac{1}{2}}$
for any $j \geq 1$ and for any $\varepsilon>0^{4}$. P. Sarnak ([Sa]) proved the following highly non-trivial individual estimate for the triple products $\left(u_{j}, \bar{V}\right)$ :

\forall j \geq 1, \quad\left(u_{j}, \bar{V}\right) \ll g \sqrt{a_{1} a_{2}}\left(1+\left|r_{j}\right|\right)^{k_{g}+1} \exp \left(\frac{-\pi\left|r_{j}\right|}{2}\right) \tag{6.7}
\end{equation*}
$$

The crucial fact is that the exponential growth in $j$ of $\rho_{j}(h)$ is balanced by the exponential decay in $j$ of $\left(u_{j}, \bar{V}\right)$. Using this, P. Sarnak proved that $D_{h}\left(g, a_{1}, a_{2} ; s\right)$ admits an holomorphic continuation to $\Re(s)>\frac{1}{2}+\theta+\varepsilon$ under $H_{2}(\theta)$ for any $\varepsilon>0$

[^2]([Sa]). The continuous analogue being true, one obtains thanks to Weyl's law for the spectrum and an estimate for the number of cusps of the congruence subgroup $\Gamma_{0}\left(D a_{1} a_{2}\right)$ the following estimate for the triple products on average over the spectrum
\[

with $\mathbf{x}=$ 4. In fact, B. Krötz and R.J. Stanton ([KrSt]) obtained the same estimate but with $\mathbf{x}=\mathbf{0}$. Note that the optimality of this last estimate with respect to the parameter $R$ was already proved by A. Good ([Go]). Moreover E. Kowalski ([Ko2]) computed the dependency in the level of $g$. We can now state:

Theorem 6.3. Let $r=q^{\alpha} \tilde{r} \in \mathbb{N}^{*}$ with $\alpha \in \mathbb{N}$ and $\tilde{r} \wedge q=1$. If $\theta$ is admissible and $\Psi$ satisfies (6.1) and (6.2) then

\Sigma_{r}\left(\Psi, g ; a_{1}, a_{2}\right) & <_{\varepsilon, g} q^{\varepsilon}\left(\frac{\sup (Z, Y)}{\inf (Z, Y)}\right)^{\frac{k_{g}-1}{2}+1+\varepsilon} \frac{\left(a_{1} a_{2}\right)^{\frac{1}{2}}}{q^{\frac{\alpha}{2}} \tilde{r}^{\frac{1}{2}+\theta}} P^{2+\varepsilon} \sup (Z, Y)^{1+\theta+\varepsilon} \\
& \times\left(\sup \left(1, \frac{\sup (Z, Y)^{\frac{1}{2}+\varepsilon}}{q^{\frac{\alpha}{2}+\varepsilon} \sqrt{a_{1} a_{2}}}\right)+\frac{\delta_{q \mid r}}{q^{\frac{1}{2}+\theta(\alpha+1)}} \sup \left(1, \frac{\sup (Z, Y)^{\frac{1}{2}+\varepsilon}}{q^{\frac{\alpha+1}{2}+\varepsilon} \sqrt{a_{1} a_{2}}}\right)\right)
\end{aligned}
$$

for any $\varepsilon>0$.
Remark 6.1. The shifted convolution problem is said to be balanced when $Y$ and $Z$ are of the same size and unbalanced else. In the balanced case, theorem 6.3 is better than theorem 6.1 whereas it is not the case in the unbalanced case. At least two reasons for that:

- in theorem 6.1, $Y$ and $Z$ are almost symmetric parameters,
- in theorem 6.3, $\left(\frac{\sup (Z, Y)}{\inf (Z, Y)}\right)^{\frac{k g-1}{2}+1}$ is large in the unbalanced case (especially when the weight of $g$ is large).

Our next applications will require the use of both theorems depending on the range of the parameters $Y$ and $Z$.

## Flavour of the proof of theorem 6.3

When solving the shifted convolution problem on average via the spectral method on average, the main issue is to deal with smooth sums of Fourier coefficients of automorphic forms of the following shape

$$

with $\Re(s)=\frac{1}{2}+\theta+\varepsilon$. Up to harmless factors, such a sum equals

\frac{1}{2 i \pi} \int_{\left(\frac{1}{2}-\theta\right)} L\left(\overline{\widetilde{u_{j}}}, z+s-\frac{1}{2}\right) q^{-(s+z-1)} \widetilde{\Psi}(z, s) \mathrm{d} z

where $\widetilde{u_{j}}$ is the underlying primitive form of $u_{j}$ of level at most $D a_{1} a_{2}$ and $\widetilde{\Psi}$ is an integral transform of $\widehat{\Psi}$. Thus, bounding sums of Fourier coefficients like (6.9) turns out to bounding $L$-functions like $L\left(\widetilde{\widetilde{u_{j}}},.\right)$ on the critical line in the level aspect. Of course, the maximal saving would come from Lindelöf hypothesis but as we average over a family of Maass forms of level $D a_{1} a_{2}$ large sieve inequalities will achieve Lindelöf hypothesis on average.

## Proof of theorem 6.3

is the contribution of the discrete spectrum and

& \times \int_{t=-\infty}^{+\infty} \frac{\Gamma\left(\frac{1}{2}\right) \Gamma\left(\frac{\frac{1}{2}+i t}{2}\right)}{\Gamma\left(s+k_{g}-1\right)} \sum_{\kappa \in \operatorname{Cusp}\left(\Gamma_{0}\left(D a_{1} a_{2}\right)\right)}\left(E_{\kappa}\left(., \frac{1}{2}+i t\right), \bar{V}\right) \\

is the contribution of the continuous spectrum. We will only give some details for the estimate of $\Sigma_{r}^{\mathrm{disc}}\left(\Psi, g ; a_{1}, a_{2}\right)$ but the same method is available for $\sum_{r}^{\text {cont }}\left(\Psi, g ; a_{1}, a_{2}\right)$ (confer [Ri]). As $q$ is coprime with $D a_{1} a_{2}$, (C.7) implies that
(6.12) $\forall h \in \mathbb{Z}^{*}, \quad \sqrt{r|h|} \rho_{j}(r h)=\sqrt{\tilde{r}|h|} \rho_{j}(\tilde{r} h) \lambda_{j}\left(q^{\alpha}\right)-\delta_{q \mid r} \delta_{q \mid h} \sqrt{\tilde{r} \frac{h}{q}} \rho_{j}\left(\tilde{r} \frac{h}{q}\right)$.

We study only the contribution coming from the first term of (6.12). By Strirling's formula and Cauchy-Schwarz inequality, the contribution of the discrete
spectrum is bounded by

and we choose $\eta=\frac{\mathrm{x}}{2}+1+(1+\varepsilon)=2+\varepsilon$ to make convergent the $s$-integral in $\sum_{r}^{\text {disc }}\left(\Psi, g ; a_{1}, a_{2}\right)$.

Remark 6.2. We want to take $\mathbf{x}$ as small as possible in (6.8) because following large sieve inequality, there appears a power of $P$ and $P$ may be large in our next applications. This power is precisely the number of integration by parts we have to do and grows linearly with $\mathbf{x}$. This feature puts the stress on the fact that the spectral method is not really smooth in the length of the spectrum aspect (namely in the $R$-aspect in (6.8)).

## 7 Proofs of Proposition D and Theorem B

Following the results of section 6, we prove Proposition D in subsection 7.2 and Theorem B in subsection 7.3. These proofs are based on some better bound for $\operatorname{Errtwist}(q, \ell ; \mu)$ than the one given in (1.9). Remember that the bound (1.9) was obtained in [KoMiVa] by implementing the $\delta$-symbol method. If we use the spectral method on average described in the previous section for certain ranges which depend on the weight functions instead of the $\delta$-symbol method, we can get better bounds. Once again, a key ingredient is a uniform estimate of P. Sarnak and some technical issues involve verifying that weight functions can be handled appropriately (subsection 7.1).

### 7.1 Description of Errtwist $(q, \ell ; \mu)$

In [KoMiVa], the authors are looking for asymptotic formulas for the harmonic twisted second moments $\mathscr{M}_{g}^{h}(\mu ; \ell)$. By a standard approximate functional equation for Rankin-Selberg $L$-functions (Theorem 5.3. page 98 of [IwKo]), they are reduced to estimate sums of the form (equation (4.16) page 138 of [KoMiVa])

for some $\delta>0$. The long range terms "weakly" restrict the length of the mollifier. This is mainly caused by the factor $\left(\frac{\mathbf{Z}}{Z}\right)^{A_{1}}$ in theorem 7.2 with $A_{1}$ as large as
needed. Applying this theorem (that is to say the spectral method on average), one gets for $\theta$ admissible and $k>k_{g}+\frac{21}{4}+\frac{\theta}{2}$ :

### 7.3 A new subconvexity bound

As a consequence of the improvement of the bound of $\operatorname{Errtwist}(q, \ell ; \mu)$, we prove the new subconvexity bound of Rankin-Selberg $L$-functions given in Theorem B by applying the amplification method. Setting (as in [KoMiVa]) for $L \geq 1$ an
integer and $\vec{x}=\left(x_{\ell}\right)_{1 \leq \ell \leq L}$ a sequence of complex numbers satisfying $x_{\ell}=0$ if $q \mid \ell$

Assume that $q$ is a prime coprime with $D$ and that $k \geq k_{g}+6$. If $\theta$ is admissible and $|\Re(\mu)| \ll \frac{1}{\log q}$ then for any $1 \leq L<q$,

Finally, we choose $x=\frac{1-2 \theta}{2(9+4 \theta)}$ and $\alpha:=\frac{19}{22}+\frac{2}{11} \theta+\frac{2}{11} \theta^{2}$ to minimize the right-hand side which achieves the proof of Theorem B for $j=0$ in a neighbourhood of the critical line. The other cases $(j \neq 0)$ follow from Cauchy's inequalities.

## A The harmonic mollified second moment away from the critical point

The aim of this part is to prove the following bound of $\mathscr{W}^{h}(g ; \mu)$ when $\mu$ is on the right of the origin:

Then, we shift the $s_{1}$ contour to $\left(-\frac{c_{2}}{\log q}\right)$ with $c_{1}<(1-\Upsilon) c_{2}<2(1-\Upsilon)$ hitting some poles at $s_{1}=0$ and $s_{1}=s_{2}-2 \tau$. The residual integral is bounded by $\log ^{A}(q) \exp \left(-4 \Delta\left((1-\Upsilon) c_{2}-c_{1}\right) f(q)\right)$ for some $A$ which is admissible. The contribution of the pole at $s_{1}=s_{2}-2 \tau$ is bounded by $\exp \left(-2 \Delta\left(2(1-\Upsilon)-c_{1}\right) f(q)\right)$ $\times \log ^{A}(q)$ for some $A$ which is admissible. The contribution of the pole at $s_{1}=0$ is given by

We shift the $s_{2}$-contour to $\left(-\frac{f(q)}{\log q}\right)$ hitting only a pole at $s_{2}=0$. The residual integral is bounded by $\log ^{A}(q) \exp (-2 \Delta f(q))$ for some $A$ which is still admissible
and the contribution of the pole is given by:

## B Bounding the contribution of old forms

The main purpose of this appendix is to deal with the eventual existence of old forms in $S_{k}(q)$ (when $k \geq 12$ ). In other words, we prove that (1.8) still holds even if there are some old forms in $S_{k}(q)$. Let $N \geq 1$. We define for every integers $m, n \geq 1$ the operator $\Delta_{N}$ by:

## C A review of Maass forms

In this appendix, we only give the minimal knowledge about Maass forms in order to follow the notations which are used in this paper. The reader may see [DuFrIw2] for all the details. Let $N \geq 1$ be a natural integer. A function $f: \mathbb{H} \rightarrow \mathbb{C}$ is said to be $\Gamma_{0}(N)$-automorphic of weight 0 and trivial nebentypus if it satisfies $f(\gamma . z)=f(z)$ for any $\gamma \in \Gamma_{0}(N)$. We denote by $\mathscr{L}_{0}(N)$ the space of squareintegrable $\Gamma_{0}(N)$-automorphic functions with respect to the scalar product:

There are two components: a discrete one spanned by the so-called Maass cusp forms and a continuous one spanned by the Eisenstein series which are given for any cusp $\kappa$ of $\Gamma_{0}(N)$ by

## D The computation of an Euler product

The purpose of this appendix is to prove that the arithmetical constants which appear in the asymptotic formulas of the harmonic mollified second moment equal one. More precisely, we prove that equations (5.19) and (5.23) hold.

Remember that, according to lemma 5.8, $h_{2}(\mu+\bar{\mu}, \mu, \bar{\mu})$ is an absolutely convergent Euler product when the real part of $\mu$ is greater than a small negative real number (say $10^{-6}$ ) namely $h_{2}(\mu+\bar{\mu}, \mu, \bar{\mu})=\prod_{p \in \mathscr{P}} h_{2, p}(\mu+\bar{\mu}, \mu, \bar{\mu})$ with (confer (5.15)):

& \frac{1+Q U V}{\left(1-Q U^{2}\right)\left(1-Q V^{2}\right)(1-Q U V)\left(1+2 Q U V-\lambda_{g}(p)^{2} Q U V+Q^{2} U^{2} V^{2}\right)}
\end{aligned}
$$

if $p \nmid(D q)$. According to lemma D. 1 and its definition, $L_{p}(\mu+\bar{\mu}, \mu, \bar{\mu})$ for any prime number $p$ is, a priori, a rational fraction in three variables $Q, U$ and $V$; namely it looks like

$$
L_{p}(\mu+\bar{\mu}, \mu, \bar{\mu})=\frac{P_{1}(Q, U, V)}{P_{2}(Q, U, V)}
$$

for some polynomials $P_{1}$ and $P_{2}$ of total degrees less than 20 whose coefficients depend on $\varepsilon_{q}(p), \varepsilon_{D}(p)$ and on the Hecke eigenvalues of $g$ at the powers of $p$ namely $\lambda_{g}(p)^{k}$ for $1 \leq k \leq 4$. To factor this fraction we have used a computational algebra system; for instance the scripts of this computation (vg.mws, ctemumubar.mws and cte.mws) are available at http://www.dms.umontreal.ca/~ricotta. We obtain

$$
\begin{equation*}
L_{p}(\mu+\bar{\mu}, \mu, \bar{\mu})=1-\lambda_{g}(p)^{2} Q U V \tag{D.4}
\end{equation*}
$$

if $p \mid D$ and $p \nmid q$ and
(D.5)
$L_{p}(\mu+\bar{\mu}, \mu, \bar{\mu})=\frac{\left(1-Q U^{2}\right)\left(1-Q V^{2}\right)(1-Q U V)\left(1+2 Q U V-\lambda_{g}(p)^{2} Q U V+Q^{2} U^{2} V^{2}\right)}{1+Q U V}$
if $p \nmid D q$. Note that the computations above are purely formal (no numerical approximation is made); in fact, once the above factorizations have been obtained, it is possible (but lenghtly) to check them directly by hand. Then we finish the proof of lemma D. 2 by simplifying (D.2) with (D.4) and (D.3) with (D.5).

We can now state the main result:
Proposition D.3. Let $\mu$ be a complex number with $\tau:=\Re(\mu) \geq-\gamma$ for some $\gamma>0$ small enough. We have:

$$
\frac{h_{2}(\mu+\bar{\mu}, \mu, \bar{\mu})}{\zeta^{(D)}(2(1+\mu+\bar{\mu}))}=1+O_{g}\left(\frac{1}{q^{\delta}}\right)
$$

for some $\delta>0$.
Proof of proposition D.3. The proof is an immediate consequence of the previous lemma as the various Euler products are absolutely convergent under the assumption made on $\mu$. The admissible error term comes from the local factor of the Euler product at the primes which divide $q$.
