Approximation of maximal Cheeger sets by projection

Abstract

This article deals with the numerical computation of the Cheeger constant and the approximation of the maximal Cheeger set of a given subset of $\mathbb{R}^d$. This problem is motivated by landslide modelling as well as by the continuous maximal flow problem. Using the fact that the maximal Cheeger set can be approximated by solving a rather simple projection problem, we propose a numerical strategy to compute maximal Cheeger sets and Cheeger constants.

Keywords: Cheeger sets, Cheeger constant, total variation minimization, projections.

1 Introduction

Given Ω , a Lipschitz bounded open subset of $\mathbb{R}^d$ and two functions $f \in L^\infty(\Omega)$ and $g \in C^0(\overline{\Omega})$ such that $\min(f, g) \geq c$ on Ω for some constant $c > 0$, let us consider:

$$\inf \left\{ \frac{\int_{\Omega} g |\nabla u|}{\int_{\Omega} f |u|}, u \in W_0^{1,1}(\Omega) \right\}. \quad (1)$$

In general, the previous problem is ill-posed, so it is natural to consider its relaxation in $BV(\Omega)$:

$$h(\Omega) := \inf \left\{ \frac{\int_{\Omega} g d|Du| + \int_{\partial\Omega} g |u| d\mathcal{H}^{d-1}}{\int_{\Omega} f |u|}, u \in BV(\Omega) \right\} \quad (2)$$

where $\mathcal{H}^{d-1}$ denotes the $(d-1)$ -dimensional Hausdorff measure (see [17]). The fact that the values of (1) and (2) are the same is well-known and follows from standard approximation results (see for instance [3]). Using the coarea formula (see [17]), it is easy to see that the quantity $h(\Omega)$ can also be expressed as

$$h(\Omega) := \inf \left\{ \frac{\int_{\partial^* A} g d\mathcal{H}^{d-1}}{\int_A f}, A \subset \overline{\Omega} \text{ of finite perimeter} \right\} \quad (3)$$

where $\partial^* A$ stands for the reduced boundary of A (see [17], [3]).

When $f \equiv g \equiv 1$, $h(\Omega)$ is known as the Cheeger constant of Ω and solutions of (3) are called Cheeger sets of Ω , and, in this case, it can be also considered as the first eigenvalue of the degenerate 1-Laplacian operator, see for instance Demengel [14], [15]. With weights f and g as above, we will again refer to $h(\Omega)$ as the Cheeger constant and to solutions of (3) as Cheeger sets. In this case, the minimization problem (2) and the value $h(\Omega)$ are related to the so-called maximal flow problem, see Strang [24], [25] and subsection 2.2 below.

The existence of Cheeger sets i.e. of solutions of (3) is well-known and we refer the reader to [7] for the precise links between Cheeger sets and the variational problem (2) and various qualitative properties of solutions of (2). It was recently proved in [1]-[8], that the Cheeger set is unique when $f \equiv g \equiv 1$ and Ω is convex. For a general Ω and/or general weights f and g , Cheeger sets need not be unique. This makes the selection of a particular Cheeger set and the numerical computation of Cheeger constants and Cheeger sets

a relevant issue, potentially important in view of applications to landslide modelling and the blocking property described in subsection 2.1.

Let us consider the following closed and convex subset of $L^2(\Omega)$:

$$K = \left\{ u \in L^2(\Omega) : \int_{\Omega} \operatorname{div}(gp)u \leq 1, \forall p \in C^1(\Omega, \mathbb{R}^d), \|p\|_{\infty} \leq 1 \right\}.$$

The numerical approach of the present paper is based on the fact that the projection (for some suitably weighted L^2 norm) of the constant function ε^{-1} onto K converges as $\varepsilon \rightarrow 0$ to a multiple of the characteristic function of the maximal Cheeger set (see [6] and section 3 below for details). This projection problem presents of course great similarities with the famous Rudin-Osher-Fatemi problem in computer vision ([23]). Indeed, if the value of Lagrange multiplier associated to the total variation constraint was known, then one could rewrite the projection problem in the form of the Rudin-Osher-Fatemi, for which one can use for instance the algorithm of Chambolle ([9]). In [9], Chambolle also shows how to update the Lagrange multipliers for total variation minimization with an L^2 equality constraint (known variance of the noise). In our projection problem, we do not have such a consistent updating rule and it is not clear how to adapt the algorithm of Chambolle. We therefore prefer to take advantage of the special structure of the problem (projection with linear constraint) for which we can use the algorithm of Combettes and Pesquet [11]. This algorithm performs iterative sub-gradient projections in order to enforce the total variation and minimize the distance to the function ε^{-1} . Let us also mention the article of Alter, Caselles and Chambolle [2], where the evolution of convex sets in the plane by the flow of the total variation is explicitly given (with some natural connections with maximal Cheeger sets) and some numerical results are obtained.

The paper is organized as follows. We first spend some time in section 2 to motivate the interest of problem (2) with general weights f and g . More precisely, we describe two different applied settings where (2) and the Cheeger constant $h(\Omega)$ naturally arise: landslide modelling ([13], [19], [20], [21]) and the continuous maximal flow problem (see Strang [24], [25]). In section 3, we recall the results of [6] on the selection of the maximal Cheeger set. Taking a quadratic perturbation, this gives an approximation strategy based on simple L^2 projection problems. The discretization of these projections is detailed, with a convergence result in section 4. Numerical results are given in section 5.

2 Motivations

2.1 Landslides

In [13], the authors' approach to landslides modelling is to consider that the soil behaves like a Bingham inhomogeneous fluid. In this model, the inhomogeneous yield limit g is an important parameter in describing landslide phenomenon. Indeed, due to their own weight, the geomaterials are compacted so that their mechanical properties also vary with depth. Therefore the yield limit g and the body forces $\mathbf{f}$ cannot be supposed homogeneous.

The evolution equations describing the flow of an inhomogeneous Bingham fluid in a domain $\mathbf{D} \subset \mathbb{R}^3$ in the time interval $(0, T)$ are

$$\frac{\partial \mathbf{u}}{\partial t} + (\mathbf{u} \cdot \nabla) \mathbf{u} - \operatorname{div} \boldsymbol{\sigma}' + \nabla p = \mathbf{f} \quad (4)$$

$$\operatorname{div} \mathbf{u} = 0, \quad (5)$$

where $\mathbf{u}$ is the velocity field, $\boldsymbol{\sigma}$ denotes the Cauchy stress tensor field, $p = -\operatorname{trace}(\boldsymbol{\sigma})/3$ represents the pressure and $\boldsymbol{\sigma}' = \boldsymbol{\sigma} + pI$ is the deviatoric part of the stress tensor and $\mathbf{f}$ denotes the body forces. The constitutive equation of the Bingham fluid is:

$$\begin{aligned} \boldsymbol{\sigma}' &= 2\eta D(\mathbf{u}) + g \frac{D(\mathbf{u})}{|D(\mathbf{u})|} & \text{if } |D(\mathbf{u})| \neq 0, \\ |\boldsymbol{\sigma}'| &\leq g & \text{if } |D(\mathbf{u})| = 0, \end{aligned}$$

where $D(\mathbf{u}) = (\nabla \mathbf{u} + \nabla^T \mathbf{u})/2$, $\eta(x) \geq \eta_0 > 0$ is the viscosity distribution and $g = g(x) > 0$ on $\overline{\mathbf{D}}$ is the (non homogeneous) yield limit distribution in $\mathbf{D}$.

The boundary conditions are $\mathbf{u} = 0$ on $\partial \mathbf{D} \times (0, T)$ and $\mathbf{u}|_{t=0} = \mathbf{u}_0$. Writing the problem under variational form leads to

$$\begin{aligned} &\int_{\mathbf{D}} \left(\frac{\partial \mathbf{u}}{\partial t} + (\mathbf{u} \cdot \nabla) \mathbf{u} \right) \cdot (\mathbf{v} - \mathbf{u}) + \int_{\mathbf{D}} 2\eta D(\mathbf{u}) \cdot (D(\mathbf{v}) - D(\mathbf{u})) \\ &+ \int_{\mathbf{D}} g(|D(\mathbf{v})| - |D(\mathbf{u})|) \geq \int_{\mathbf{D}} \mathbf{f} \cdot (\mathbf{v} - \mathbf{u}). \end{aligned} \quad (6)$$

for all $t \in (0, T)$, $\mathbf{u}$ and $\mathbf{v}$ in some suitable space, see [18]. If we consider the stationary *anti-plane* flow, that is $\mathbf{D} = \Omega \times \mathbb{R}$ with Ω open domain of $\mathbb{R}^2$ with lipschitz boundary, $\mathbf{u} = (0, 0, u(x_1, x_2))$ and similar hypotheses for

$\mathbf{f}$, etc. Problem (6) then becomes

$$\begin{aligned} \int_{\Omega} 2\eta(x) \nabla u(x) \cdot \nabla (v(x) - u(x)) dx + \int_{\Omega} g(x) (|\nabla v(x)| - |\nabla u(x)|) dx \\ \geq \int_{\Omega} f(x) (v(x) - u(x)) dx. \end{aligned} \quad (7)$$

for all u, v in some suitable functional space, see [20]. Since u is the velocity of the fluid, the Bingham fluid is blocked, that is there is no landslide, if $u \equiv 0$ is a solution of (7). Hence the blocking property reads as

$$1 \leq \mu := \inf_{v \in W_0^{1,1}(\Omega)} \frac{\int_{\Omega} g(x) |\nabla v(x)| dx}{\left| \int_{\Omega} f(x) v(x) dx \right|}. \quad (8)$$

Thus μ has been considered in [19] as a safety factor and it is important to know for given f and g , if μ is larger than 1 (blocking property).

2.2 Maximal flow, minimum cut duality and Cheeger sets

Another motivation for (2) comes from its relation with the so-called maximal flow problem. The duality between (1) and the continuous maximal flow problem is essentially due to Strang [24]. We refer to the papers of Strang [24] and [25] for a detailed exposition of the problem, extensions and related questions. This continuous duality is used by Appleton and Talbot [4] to solve computer vision problems such as image segmentation.

First, it is easy to see that

$$-\frac{1}{h(\Omega)} = \inf \{ F(u) + H(\nabla u) : u \in W_0^{1,1}(\Omega) \} \quad (9)$$

where

$$F(u) = - \int_{\Omega} f u, \quad H(\mathbf{q}) = \begin{cases} 0 & \text{if } \|g\mathbf{q}\|_{L^1} = \int_{\Omega} g|\mathbf{q}| \leq 1 \\ +\infty & \text{otherwise,} \end{cases}$$

for all $u \in W_0^{1,1}(\Omega)$ and $\mathbf{q} \in L^1(\Omega, \mathbb{R}^d)$. Since F and G are convex l.s.c. functionals with F everywhere finite and G continuous at 0, the Fenchel-Rockafellar duality theorem (see Ekeland and Temam [16]) yields

$$\frac{1}{h(\Omega)} = \min \{ F^*(-\operatorname{div}(\mathbf{v})) + H^*(-\mathbf{v}), \mathbf{v} \in L^\infty(\Omega, \mathbb{R}^d) \}$$

where F^* and H^* denote the Fenchel conjugates of F and H . By direct computation, we then get:

$$\frac{1}{h(\Omega)} = \min \left\{ \left\| \frac{\mathbf{v}}{g} \right\|_{L^\infty} : \mathbf{v} \in L^\infty(\Omega, \mathbb{R}^d), \operatorname{div}(\mathbf{v}) = f \right\}.$$

Which enables us to rewrite the Cheeger constant as

$$h(\Omega) = \max \left\{ \lambda \in \mathbb{R} : (\lambda, \mathbf{v}) \in \mathbb{R} \times L^\infty(\Omega, \mathbb{R}^d), \operatorname{div}(\mathbf{v}) = \lambda f, |\mathbf{v}| \leq g \right\}. \quad (10)$$

The duality relation (10) is known as the maximal flow-minimal cut theorem. The maximization problem in (10) is a continuous version of the problem that consists in finding the largest flow that can be sent through the edges of a graph given their capacity (the function g in a continuous setting) and subject to the mass conservation constraint (Kirchoff's law on a graph and $\operatorname{div}(\mathbf{v}) = \lambda f$ in a continuous setting). The natural assumption on f is that it has zero average and can be written as $f = f^+ - f^-$ with f^+ and f^- giving the distribution of sinks and sources. Also, the maximal flow problem described above is isotropic in the sense that the capacity constraint simply is $|\mathbf{v}| \leq g$ and does not depend on the direction of the flow, we refer to Nozawa [22] for a general anisotropic formulation. As usual in convex duality, one expects useful relations between maximal flows and all the solutions of the primal problem (in particular characteristic functions of Cheeger sets). In fact, it follows from the maximal flow-minimal cut theorem that if C is a Cheeger set and $\mathbf{v}$ a maximal flow then (at least formally, i.e. ignoring regularity issues) $\mathbf{v} \cdot \mathbf{n} = g$ on ∂C . Therefore ∂C is filled to its maximum capacity, ∂C is then referred to as a *minimum cut*.

3 Selection of the maximal Cheeger set

As already pointed out, Cheeger sets i.e. solutions of (3) are non-unique in general, however there exists a unique maximal Cheeger set i.e. a solution of (3) that contains any other one up to a negligible set. We refer to [6] for a proof of the next result:

Proposition 1 *There exists a unique maximal Cheeger set, i.e. a unique C_0 solving (3) such that for every C solving (3), C is included in C_0 up to a Lebesgue negligible set.*

In [6], the question of whether some natural perturbations of (2) select at the limit the maximal Cheeger set is addressed. In particular, if we rewrite

the Cheeger constant as

$$\frac{1}{h(\Omega)} = \sup \left\{ \int_{\Omega} f u \, dx : \int_{\Omega} g \, d|Du| + \int_{\partial\Omega} g|u| \, d\mathcal{H}^{d-1} \leq 1, u \in BV(\Omega) \right\} \quad (11)$$

Following the approach of [6], we approximate (11) by the strictly concave penalization

$$\sup \left\{ \int_{\Omega} f(u - \varepsilon \Phi(u)) \, dx : \int_{\Omega} g \, d|Du| + \int_{\partial\Omega} g|u| \, d\mathcal{H}^{d-1} \leq 1, u \in BV(\Omega) \right\} \quad (12)$$

where $\varepsilon > 0$ is a perturbation parameter and Φ is a strictly convex even function that satisfies

$$\Phi(0) = 0, \quad 0 \leq \Phi(t) < +\infty \quad \forall t \in \mathbb{R}^+. \quad (13)$$

Denoting by χ_A the characteristic function of a set A , the following convergence¹ result states that solutions of the penalized problems converge to a multiple of the characteristic function of the maximal Cheeger set (see [6] for a proof).

Theorem 1 *Let u_{ε} be the unique solution of (12). Then $(u_{\varepsilon})_{\varepsilon}$ converges in $L^1(\Omega)$, as $\varepsilon \rightarrow 0^+$, to $\bar{u} = \alpha \chi_{C_0}$, where $\alpha > 0$ and $C_0 \subset \overline{\Omega}$ is the maximal Cheeger set.*

A natural choice for the perturbation Φ is of course

$$\Phi(t) := \frac{t^2}{2}$$

in which case, the perturbed problem (12) is easily seen to be equivalent to the projection problem

$$\inf \left\{ \int_{\Omega} f \left(u - \frac{1}{\varepsilon} \right)^2 \, dx : \int_{\Omega} g \, d|Du| + \int_{\partial\Omega} g|u| \, d\mathcal{H}^{d-1} \leq 1, u \in BV(\Omega) \right\}. \quad (14)$$

The solution of the previous problem u_{ε} can of course be expressed as

$$u_{\varepsilon} = \Pi_K \left(\frac{1}{\varepsilon} \right) \quad (15)$$

¹the fact that we do not have to impose any growth condition on Φ comes from the fact that solutions of (2) are all L^{∞} , see [7].

where Π_K denotes the projection (for the weighted L^2 inner product $(u, v) := \int_{\Omega} fuv$) on the closed subset K of $L^2(\Omega)$ defined by

$$K := \left\{ u \in L^2(\Omega) \cap BV(\Omega) : \int_{\Omega} g d|Du| + \int_{\partial\Omega} g|u| d\mathcal{H}^{d-1} \leq 1 \right\}. \quad (16)$$

It is convenient to extend every $u \in BV(\Omega)$ (or $L^2(\Omega)$) by 0 outside $\overline{\Omega}$, doing so we have:

$$\int_{\Omega} g d|Du| + \int_{\partial\Omega} g|u| d\mathcal{H}^{d-1} = \int_{\mathbb{R}^d} g d|Du|.$$

If we further assume that $g \in C^1(\overline{\Omega})$ then it is well-known that K can be described by a set of linear constraints as follows

$$K = \left\{ u \in L^2(\Omega) : \int_{\Omega} \operatorname{div}(gp)u \leq 1, \forall p \in C^1(\Omega, \mathbb{R}^d), \|p\|_{\infty} \leq 1 \right\}. \quad (17)$$

4 Discretization and projection

4.1 Discretization

We aim now to discretize our projection problem to approximate the projection $u_{\varepsilon} = \Pi_K\left(\frac{1}{\varepsilon}\right)$ with K defined by (17). For the sake of simplicity, we shall from now on assume that the ambient space dimension is $d = 2$ and that $\Omega = (0, 1)^2$. More generally, given $u^0 \in L^2(\Omega)$, we are interested in projecting u^0 onto K i.e.

$$\inf_{u \in K} F(u) = \int_{\Omega} f(u - u^0)^2 \quad (18)$$

with K defined as before by $K = \{u \in BV(\Omega) : G(u) \leq 1\}$ where

$$G(u) := \int_{\Omega} g d|Du| + \int_{\partial\Omega} g|u| d\mathcal{H}^{d-1}.$$

We assume that the weights f and g are respectively continuous and C^1 on some neighbourhood of Ω and bounded by below by some strictly positive constant. We denote by $\Pi_K(u^0)$ the solution of (18). Given a step size $h = 1/N$, we then consider the following discretization of (18). First, let E_h be the set of matrices u with entries $u_{i,j}$, $i, j \in \{0, N\}^2$, by convention we extend u by setting $u_{i,j} = 0$ when either i or j belongs to $\{-1, N+1\}$. For $u = (u_{i,j})_{ij} \in E_h$ we set

$$\partial_x^h u_{i,j} := \begin{cases} h^{-1}(u_{i+1,j} - u_{i,j}) & \text{if } -1 \leq i \leq N, -1 \leq j \leq N-1 \\ 0 & \text{if } -1 \leq i \leq N, j = N. \end{cases}$$

$$\partial_y^h u_{i,j} := \begin{cases} h^{-1}(u_{i,j+1} - u_{i,j}) & \text{if } -1 \leq i \leq N-1, -1 \leq j \leq N \\ 0, & \text{if } -1 \leq j \leq N, i = N. \end{cases}$$

We also set $\nabla^h u_{i,j} = (\partial_x^h u_{i,j}, \partial_y^h u_{i,j})$. Denoting $f_{i,j}^h$ and $g_{i,j}^h$ some discrete approximation of the weights f and g (e.g. $f_{i,j}^h = f(ih, jh)$, $g_{i,j}^h = g(ih, jh)$) and $u_{i,j}^0$ some discretization of u^0 (approximation by mean values say) we then discretize G by defining, for all $u \in E_h$:

$$G_h(u) := h^2 \sum_{i=-1}^N \sum_{j=-1}^N g_{i,j}^h |\nabla^h u_{i,j}|$$

which can be rewritten as

$$\begin{aligned} G_h(u) &= h^2 \sum_{i=0}^{N-1} \sum_{j=0}^{N-1} g_{i,j}^h |\nabla^h u_{i,j}| \\ &+ h \sum_{i=0}^N \left(g_{i,-1}^h |u_{i,0}| + g_{i,N}^h |u_{i,N}| \right) + h \sum_{j=0}^N \left(g_{-1,j}^h |u_{0,j}| + g_{N,j}^h |u_{N,j}| \right). \end{aligned}$$

Defining K_h by $K_h := \{u \in E_h : G_h(u) \leq 1\}$ and

$$F_h(u) := h^2 \sum_{i=0}^{N-1} \sum_{j=0}^{N-1} f_{i,j}^h (u_{i,j} - u_{i,j}^0)^2,$$

we then approximate (18) by

$$\inf_{u \in K_h} F_h(u) \tag{19}$$

and denote by u^h the solution of (19). Denoting by C_{ij} the square $(ih, (i+1)h) \times (jh, (j+1)h)$, we define v_h as the piecewise constant function having value $u_{i,j}^h$ on C_{ij} . Denoting by $\mathcal{M}(\overline{\Omega}, \mathbb{R}^2)$ the space of bounded $\mathbb{R}^2$ -valued measures on $\overline{\Omega}$, we then have the following convergence result.

Theorem 2 *Let v_h be defined as above, then v_h converges to $\Pi_K(u^0)$ strongly in $L^2(\Omega)$ and ∇v_h converges weakly $\star$ to $\nabla \Pi_K(u^0)$ in $\mathcal{M}(\overline{\Omega}, \mathbb{R}^2)$ as $h \rightarrow 0$.*

Proof. It is easy to see that $(v_h)_h$ is bounded in BV and in L^2 hence admits a (not relabeled) subsequence that strongly converges in L^1 and weakly in L^2 to some $v \in BV \cap L^2$ and such that ∇v_h converges to ∇v weakly $\star$ in $\mathcal{M}(\overline{\Omega}, \mathbb{R}^2)$. Let us prove that $v \in K$, i.e. (recalling (17))

$$\int_{\Omega} \operatorname{div}(gp)v \leq 1$$

for every $p \in C^1(\overline{\Omega}, \mathbb{R}^2)$ such that $\|p\|_\infty \leq 1$. For such a $p = (p^1, p^2)$ we obviously have

$$\int_{\Omega} \operatorname{div}(gp)v = \lim_h h \left(\sum_{j=0}^{N-1} \sum_{i=0}^N (a_{i,j} - a_{i-1,j}) u_{i,j}^h + \sum_{i=0}^{N-1} \sum_{j=0}^N (b_{i,j} - b_{i,j-1}) u_{i,j}^h \right)$$

where we have set

$$a_{i,j} = g_{i,j} p^1(ih, jh) \text{ and } b_{i,j} = g_{i,j} p^2(ih, jh).$$

Rearranging terms, we have

$$\begin{aligned} & h \left(\sum_{j=0}^{N-1} \sum_{i=0}^N (a_{i,j} - a_{i,j-1}) u_{i,j}^h + \sum_{i=0}^{N-1} \sum_{j=0}^N (b_{i,j} - b_{i,j-1}) u_{i,j}^h \right) \\ &= -h^2 \sum_{i=0}^{N-1} \sum_{j=0}^{N-1} (a_{i,j}, b_{i,j}) \cdot \nabla^h u_{i,j}^h + h \sum_{i=0}^{N-1} (b_{i,N} u_{i,N}^h - b_{i,-1} u_{i,0}^h) \\ &+ h \sum_{j=0}^{N-1} (a_{N,j} u_{N,j}^h - a_{-1,j} u_{0,j}^h) \end{aligned}$$

we thus deduce from $|(a_{i,j}, b_{i,j})| \leq g_{i,j}$ and the continuity of g

$$\int_{\Omega} \operatorname{div}(gp)v \leq \limsup_h G_h(u^h) \leq 1$$

which proves that $v \in K$.

Let us now prove that $v = \Pi_K(u^0)$. Let $\varphi \in C^1(\overline{\Omega}) \cap K$ and φ_h be the affine interpolate of φ on the triangles (T_{ij}^+, T_{ij}^-) where T_{ij}^- has vertices (ih, jh) , $((i+1)h, jh)$ and $(ih, (j+1)h)$ and T_{ij}^+ is the complement of T_{ij}^- in C_{ij} . It is obvious that

$$G(\varphi) = \lim_h G_h(\varphi_h)$$

hence for every $\delta > 0$, $\varphi_h/(1+\delta) \in K_h$ for h small enough. We then have (also denoting by φ_h the values of φ at the nodes)

$$F_h(v_h) \leq F_h\left(\frac{\varphi_h}{1+\delta}\right)$$

and then

$$F(v) \leq \liminf_h F_h(v_h) \leq \liminf_h F_h\left(\frac{\varphi_h}{1+\delta}\right) = F\left(\frac{\varphi}{1+\delta}\right).$$

Since $\delta > 0$ is arbitrary we deduce that $F(v) \leq F(\varphi)$ for every $\varphi \in C^1(\overline{\Omega}) \cap K$, it then follows from standard approximation arguments in BV (see [15] and remark 3.22 p.132 in [3]) that $v = \Pi_K(u^0)$. It is then easy to check that $\|v_h\|_{L^2}$ converges to $\|v\|_{L^2}$, so that by classical arguments the whole sequence v_h converges strongly in L^2 to $v = \Pi_K(u^0)$.

□

4.2 Algorithm for the discrete projection problem

The projection (19) of the discretized problem is computed numerically using the iterative algorithm of Combettes and Pesquet [11]. It corresponds to a subgradient projection method that only requires, at each iteration, the projection of the current estimate on the intersection of two half spaces. The iterative algorithm [11] needs to be modified to take into account the weight f in the least square objective function. We thus use the algorithm to compute the projection of $\sqrt{f}u_0$ where $u_0 = \varepsilon^{-1}$.

We now detail the steps of this algorithm. For clarity we drop the dependancies on the grid size $h = 1/N$ of the processed vectors.

1. *Initialization.* Set $u^{(0)} = \sqrt{f}u_0$ and set $k \leftarrow 0$.
2. *Sub-gradient computation:* Define the sub-gradient of the total variation at the current iterate as

$$t^{(k)} = \frac{1}{\sqrt{f}} \operatorname{div}(gp^{(k)}) \quad (20)$$

$$\text{with } p_{i,j}^{(k)} = \begin{cases} \frac{\nabla \tilde{u}_{i,j}^{(k)}}{\|\nabla \tilde{u}_{i,j}^{(k)}\|} & \text{if } \nabla \tilde{u}_{i,j}^{(k)} \neq 0, \\ 0 & \text{otherwise.} \end{cases} \quad (21)$$

where $\tilde{u} = u/\sqrt{f}$.

3. *Sub-gradient projection computation.* Define

$$z^{(k)} = \begin{cases} u^{(k)} - (G(\tilde{u}^{(k)}) - 1) \frac{t^{(k)}}{\|t^{(k)}\|^2} & \text{if } G(\tilde{u}^{(k)}) > 1, \\ u^{(k)} & \text{otherwise.} \end{cases}$$

as the sub-gradient projection of the current estimate.

4. *Projection onto half-spaces.* Define the two half spaces

$$\begin{aligned} D^{(k)} &= \left\{ v : \langle u^{(k)} - v, u^{(k)} - u^{(0)} \rangle \leq 0 \right\}, \\ H^{(k)} &= \left\{ v : \langle v - z^{(k)}, u^{(k)} - z^{(k)} \rangle \leq 0 \right\}. \end{aligned}$$

The new iterate is defined as the following projection

$$u^{(k+1)} = \Pi_{D^{(k)} \cap H^{(k)}} \left(u^{(0)} \right). \quad (22)$$

5. *Boundary correction.* Constrain the current estimate to vanish outside Ω by defining

$$u_{i,j}^{(k+1)} = \begin{cases} u_{i,j}^{(k+1)} & \text{if } (i,j)/N \in \Omega, \\ 0 & \text{otherwise.} \end{cases}$$

6. *Stopping criterion.* While $\|u^{(k-1)} - u^{(k)}\| > Tol$, set $k \leftarrow k + 1$ and go back to 2. If the algorithm has converged, return $u = u^{(k)}/\sqrt{f}$.

As shown in [11]-[12], the iterates $u^{(k)}/\sqrt{f}$ converge when $k \rightarrow +\infty$ to the solution u^h of the discrete optimization problem (19). The algorithm is stopped when $\|u^{(k-1)} - u^{(k)}\|$ is smaller than a given tolerance value Tol .

Let us remark that, by construction, $D^{(k)} \cap H^{(k)}$ contains $\sqrt{f}K = \{v : G(\tilde{v}) \leq 1\}$ hence is nonempty. Indeed (taking $f = 1$ for the sake of simplicity and without loss of generality) let $v \in K$ and let us prove that $v \in H^{(k)}$. If $G(u^{(k)}) \leq 1$, there is nothing to prove, we may then assume that $G(u^{(k)}) > 1$, since $t^{(k)} \in \partial G(u^{(k)})$, we have

$$\langle v - z^{(k)}, t^{(k)} \rangle = \langle v - u^{(k)}, t^{(k)} \rangle + \langle u^{(k)} - z^{(k)}, t^{(k)} \rangle \leq G(v) - 1 \leq 0$$

so that $v \in H^{(k)}$. Now assume that $v \in D^{(k)}$ (which is the case for $k = 0$), since $u^{(k+1)}$ is the projection of $u^{(0)}$ on $D^{(k)} \cap H^{(k)}$, we have

$$\langle u^{(k+1)} - v, u^{(k+1)} - u^{(0)} \rangle \leq 0$$

hence $v \in D^{(k+1)}$.

The main step of the algorithm is the computation of (22) which is an euclidean projection on the (nonempty) intersection of two half spaces. As explained in [12], such a projection is computed as follows.

Lemma 1 *Let u, u_0 and z be vectors in $\mathbb{R}^n$ and define the half planes*

$$D = \{v : \langle u - v, u - u_0 \rangle \leq 0\} \quad \text{and} \quad H = \{v : \langle v - z, u - z \rangle \leq 0\}.$$

Let $\pi = \langle u_0 - u, u - z \rangle$, $\mu = \|u_0 - u\|^2$, $\nu = \|u - z\|^2$ and $\rho = \mu\nu - \pi^2$. If $D \cap H \neq \emptyset$, the orthogonal projection of u_0 on $D \cap H$ satisfies

$$\Pi_{D \cap H}(u_0) = \begin{cases} z & \text{if } \rho = 0 \text{ and } \pi \geq 0, \\ u_0 + (1 + \pi/\nu)(z - u) & \text{if } \rho > 0 \text{ and } \pi\nu \geq \rho, \\ u + \frac{\nu}{\rho}(\pi(u_0 - u) + \mu(z - u)) & \text{if } \rho > 0 \text{ and } \pi\nu \leq \rho. \end{cases}$$

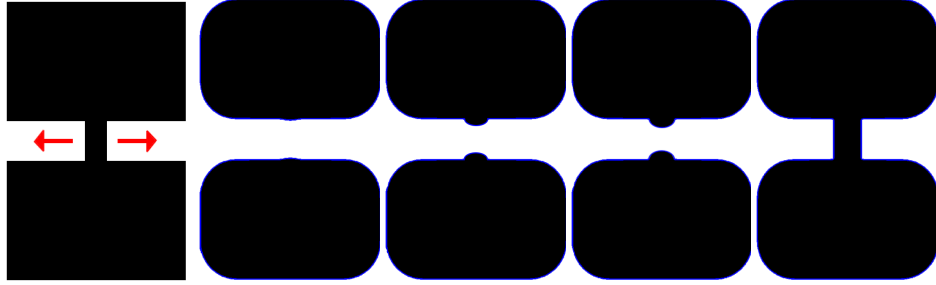


Figure 1: *The original shape is composed of two rectangles linked with a tube of increasing width. The corresponding Cheeger sets are displayed on the right.*

5 Numerical results

For the numerical experiments, we have used $\varepsilon = 1/100$ which results in an approximate solution u_ε with sharp transitions. The discretization step size $h = 1/N$ is set with $N = 400$ for $d = 2$ (2D computations) and $N = 50$ for $d = 3$ (3D computations).

Convergence study. The convergence of our projection algorithm is studied for a square domain Ω of unit side length, for $f = g = 1$. In this case, the Cheeger set C_0 is unique and known, since it is composed of parts of the square edges and arcs of a circle of radius $(2 + \sqrt{\pi})^{-1}$, as shown in Figure 4, left. Figure 4, right, shows the convergence of the iterates $u^{(k)}$ toward the normalized indicator function $\alpha\chi_{C_0}$, where $\alpha = \frac{1}{|\partial^* C_0|}$. The L^∞ error converges toward a non-zero residual error $\|\alpha\chi_{C_0} - u^{(+\infty)}\|_\infty$ that decreases if the value ε is reduced.

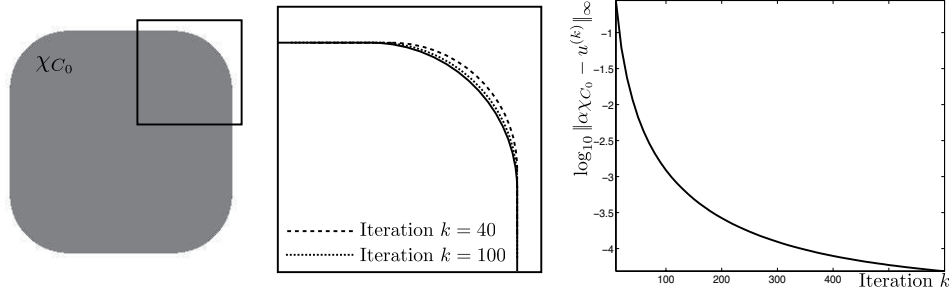


Figure 2: *Left: Cheeger set C_0 of a square. Center: zoom on the exact Cheeger boundary $\partial^* C_0$ together with the curves extracted by our algorithm after $k = 40$ and $k = 100$ iterations (dotted line). Right: convergence of the L^∞ error $\log_{10} \|\alpha \chi_{C_0} - u^{(k)}\|_\infty$ during the iterations of the projection algorithm.*

Cheeger sets in 2D and 3D. Figure 1 shows the extraction of the Cheeger set for two squares connected by a rectangle of increasing width. Our algorithm is able to extract the maximum Cheeger although these shapes do not have an unique Cheeger. Figure 6 (second column) shows examples of Cheeger sets for 2D shapes and for constant weights $f = g = 1$. In these examples, the original domain Ω is non-convex, and the projection algorithm correctly identifies the maximum Cheeger set.

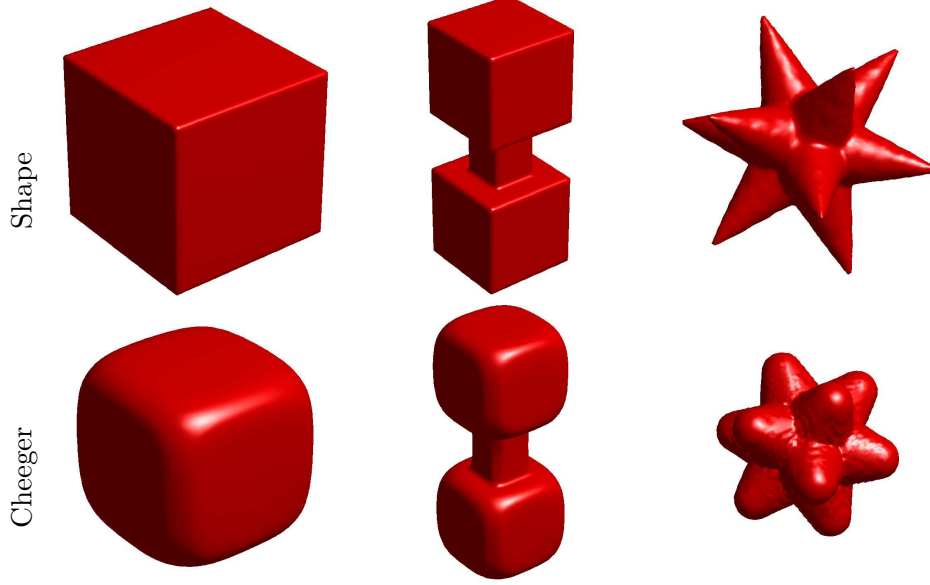


Figure 3: *Cheeger sets in 3D with constant weights $f = g = 1$.*

Our projection algorithm works in arbitrary dimension d , and Figure 3 shows examples of Cheeger sets for 3D shapes with constant weights $f = g = 1$.

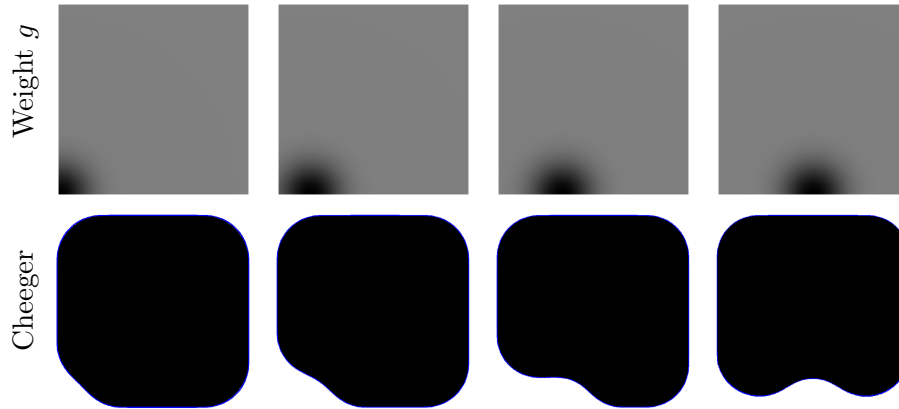


Figure 4: *Cheeger sets in a 2D square with $f = 1$ and several non-constant weights g .*

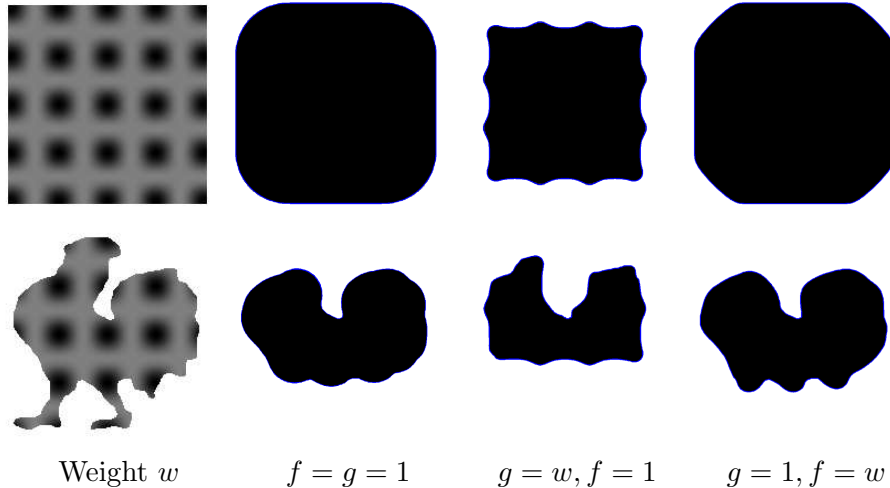


Figure 5: Comparison of the Cheeger with constant weights and with varying weights g or f .

Cheeger sets with non-constant weights. Figure 4 shows examples of Cheeger sets for a non-constant weight g . This particular choice of weight (a gaussian bump with a varying position) causes the boundary of the Cheeger set to deviate from its original position for $g = 1$. Figure 5 shows others examples of non-constant weights f and g .

Crystalline total variation. The Cheeger extraction algorithm presented in this paper can be extended to handle non isotropic total variation (see [5]). Such a total variation is defined as

$$G_\phi(u) = \int_{\Omega} \phi(\nabla u)$$

where $\phi : \mathbb{R}^2 \mapsto \mathbb{R}^+$ is a convex, continuous, and positively homogeneous function. In the numerical simulation we consider the L^1 and L^∞ crystalline total variation G_1 and G_∞ which corresponds to taking ϕ equal respectively to

$$\|(x_1, x_2)\|_1 = |x_1| + |x_2| \quad \text{and} \quad \|(x_1, x_2)\|_\infty = \max(|x_1|, |x_2|).$$

The discrete projection algorithm presented in section 4.2 can be used in order to compute the Cheeger for a crystalline norm. The only modification is that the sub-gradient $t^{(k)}$ computed following (20) should be modified as follow

$$t^{(k)} = \frac{1}{\sqrt{f}} \operatorname{div} \left(g D\phi^*(\nabla \tilde{u}^{(k)}) \right),$$

where the function $D\phi^* : \mathbb{R}^2 \rightarrow \mathbb{R}^2$ is defined differently for the L^1 and L^∞ total variations

$$\begin{aligned} D\phi_1^*(x_1, x_2) &= (\operatorname{sign}(x_1), \operatorname{sign}(x_2)) \\ D\phi_\infty^*((x_1, x_2)) &= \begin{cases} (\operatorname{sign}(x_1), 0) & \text{if } |x_1| > |x_2|, \\ (0, \operatorname{sign}(x_2)) & \text{otherwise.} \end{cases} \end{aligned}$$

Figure 6, third and fourth rows, show examples of Cheeger sets for 2D shapes with constant weights $f = g = 1$ and crystalline total variations.

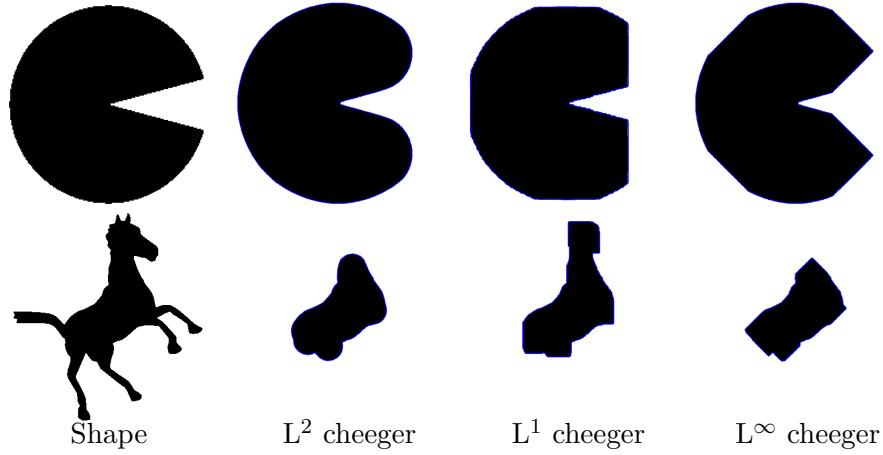


Figure 6: *Cheeger sets in 2D with constant weights $f = g = 1$ and for both euclidean (second row) and crystalline (third and fourth row) total variation.*
