Hamilton-Jacobi-Bellman equations for the optimal control of a state equation with memory

Abstract

This article is devoted to the optimal control of state equations with memory of the form:

$$\dot{x}(t) = F\left(x(t), u(t), \int_0^{+\infty} A(s)x(t-s)ds\right), \ t > 0,$$
with initial conditions $x(0) = x_0 x(s)$, $x(s) > 0$

with initial conditions x(0) = x, x(-s) = z(s), s > 0.

Denoting by $y_{x,z,u}$ the solution of the previous Cauchy problem and:

$$v(x,z) := \inf_{u \in V} \left\{ \int_0^{+\infty} e^{-\lambda s} L(y_{x,z,u}(s), u(s)) ds \right\}$$

where V is a class of admissible controls, we prove that v is the only viscosity solution of an Hamilton-Jacobi-Bellman equation of the form:

$$\lambda v(x,z) + H(x,z,\nabla_x v(x,z)) + \langle D_z v(x,z), \dot{z} \rangle = 0$$

in the sense of the theory of viscosity solutions in infinite-dimensions of M. Crandall and P.-L. Lions.

Keywords: dynamic programming, state equations with memory, viscosity solutions, Hamilton-Jacobi-Bellman equations in infinite dimensions.

1 Introduction

The optimal control of dynamics with memory is an issue that naturally arises in many different applied settings both in engineering and decision sciences. It is typically the case when studying the optimal performances of a system in which the response to a given input occurs not instantaneously but only after a certain elapse of time. To cite some recent related contributions, in a stochastic framework, we refer to I. Elsanosi, B. Øksendal, A. Sulem [12], for applications to mathematical finance, and to F. Gozzi and C. Marinelli [13] for applications to advertising modelling. In the deterministic case, we refer to R. Boucekkine et al. [4] for a generalization of Ramsey's economic growth model with memory effects and, in the field of biosciences modelling, we refer to the survey of C.T. H. Baker et al. [1].

The aim of the present article is to study, by dynamic programming arguments, the optimal control of (deterministic) state equations with memory. For the sake of simplicity, we will restrict the analysis to (finite-dimensional) dynamics of the form:

$$\dot{x}(t) = F\left(x(t), u(t), \int_0^{+\infty} A(s)x(t-s)ds\right), \ t > 0,$$

with initial conditions x(0) = x and x(-s) = z(s), s > 0. We will also focus on the discounted infinite horizon problem:

$$v(x,z) := \inf_{u \in V} \left\{ \int_0^{+\infty} e^{-\lambda s} L(y_{x,z,u}(s), u(s)) ds \right\}$$
 (1)

where V is some admissible class of controls. Of course, there are other forms of memory effects than the one we treat here: systems with lags or with deviating arguments for instance (see for instance [5], [15], [16] and the references therein).

As is obvious from (1), the value function depends not only on the current state of the system x but also on the whole past of the trajectory i.e. z (note that we have not required z(0) = x in (1)). Hence the state space for problem (1) is infinite-dimensional. Note that if we had imposed an additional continuity condition ensuring x = z(0), then the value function would have been a function of the past z only. There are several reasons why we have not adopted this point of view and have prefered to write everywhere x and z as if they were independent variables. The main one, is that it enables to understand the tight connections between the control problem (1) and the Hamilton-Jacobi-Bellman equation:

$$\lambda v(x,z) + H(x,z,\nabla_x v(x,z)) + \langle D_z v(x,z), \dot{z} \rangle = 0 \text{ if } z(0) = x.$$
 (2)

The previous equation presents several difficulties. The first one is of course its infinite-dimensional nature. The second one comes from the presence of the time derivative of z, \dot{z} in the equation and the third one from the restriction x=z(0). In a series of articles ([6, 7, 8, 9, 10, 11]), M. Crandall and P.-L. Lions developed a general theory of viscosity solutions in infinite dimensions. This theory is of course of particular interest for the optimal control of infinite-dimensional systems. In such problems, the Hamilton-Jacobi equation frequently contains an unbounded linear term (as in (2)) and in ([9, 10, 11]), M. Crandall and P.-L. Lions showed how to overcome this additional difficulty. The main contribution of the present paper is to show, in a rather simple and self-contained way, how the theory of viscosity solutions in infinite dimensions of M. Crandall and P.-L. Lions can be applied to fully characterize the value function (1) as the unique solution of (2). For the sake of simplicity, we will work in a hilbertian framework i.e. in the state space $E := \mathbb{R}^d \times L^2(\mathbb{R}_+, \mathbb{R}^d)$ and defining:

$$E_0 := \{ (z(0), z), z \in H^1(\mathbb{R}_+, \mathbb{R}^d) \},$$

v will be said to be a viscosity subsolution of (2) if for every $(x_0, z_0) \in \mathbb{R}^d \times L^2$ and every $\phi \in C^1(\mathbb{R}^d \times L^2, \mathbb{R})$ such that $v - \phi$ has a local maximum (in the sense of the strong topology of $\mathbb{R}^d \times L^2$) at (x_0, z_0) , one has:

$$\lambda v(x_0, z_0) + H(x_0, z_0, \nabla_x \phi(x_0, z_0)) + \lim\inf_{(x, z) \in E_0 \to (x_0, z_0)} \langle D_z \phi(x, z), \dot{z} \rangle \le 0.$$

Supersolutions of (2) are defined in a similar way. Now, a convenient way to study (2) is to rewrite it as an Hamilton-Jacobi equation with an unbounded linear term as in M. Crandall and P.-L. Lions [9, 10, 11]. Namely, defining $\alpha = (x, z)$, the equation reads as:

$$\lambda v(\alpha) + H(\alpha, \nabla_x v(\alpha)) - x \cdot \nabla_x v(\alpha) + \langle T^*(\alpha), Dv(\alpha) \rangle = 0, \alpha \in D(T^*).$$
 (3)

Where T is the linear unbounded operator on E with domain $D(T) = \mathbb{R}^d \times H^1$ defined by

$$T(y, w) := (y - w(0), -\dot{w}), \ \forall (y, w) \in D(T).$$
 (4)

So that its adjoint, T^* has domain $D(T^*) = E_0$ and is given by

$$T^*(x,z) := (z(0),\dot{z}) = (x,\dot{z}), \ \forall (x,z) \in D(T^*) = E_0.$$
 (5)

Section 2 is devoted to some preliminaries on the Cauchy problem and continuity properties of the value function. Section 3 concerns the dynamic programming principle. In section 4, we identify the Hamilton-Jacobi-Bellman equation of the problem and establish that the value function is a viscosity solution of this equation. In section 5, we prove a comparison result. Finally, in section 6, we end the paper by some concluding remarks.

2 Assumptions and preliminaries

2.1 On the Cauchy problem

Let K be a compact metric space, we define the set of admissible controls V as the set of measurable functions on $(0, +\infty)$ with values in K. For $z \in L^2 := L^2((0, +\infty), \mathbb{R}^d)$, $x \in \mathbb{R}^d$ and $u \in V$ an admissible control, we consider the following controlled equation

$$\dot{x}(t) = F\left(x(t), u(t), \int_0^{+\infty} A(s)x(t-s)ds\right), \ t > 0, \tag{6}$$

together with the boundary conditions:

$$x(0) = x, \ x(-s) = z(s), \ s > 0.$$
 (7)

In the paper, d and k are given positive integers and we will always assume the following on the data A and F:

• (H1) $F \in C^0(\mathbb{R}^d \times K \times \mathbb{R}^k, \mathbb{R}^d)$ and there exists a constant $C_1 \geq 0$ such that:

$$|F(x, u, \alpha) - F(y, u, \beta)| \le C_1(|x - y| + |\alpha - \beta|), \tag{8}$$

for every $(x, y, \alpha, \beta, u) \in \mathbb{R}^d \times \mathbb{R}^d \times \mathbb{R}^k \times \mathbb{R}^k \times V$,

• **(H2)** $A \in L^2((0, +\infty), M_{k \times d}) \cap L^1((0, +\infty), M_{k \times d})$ ($M_{k \times d}$ standing for the space of real matrices with k rows and d columns).

In the sequel, we shall sometimes use a stronger assumption than **(H2)**. Namely: **(H2')** $A \in H^1((0, +\infty), M_{k \times d}) \cap L^1((0, +\infty), M_{k \times d})$.

Before studying the optimal control of equations with memory of type (6), let us establish the existence, uniqueness and continuous dependence with respect to initial conditions for the Cauchy problem (6)-(7). The results of this section (Propositions 1 and 2) are fairly standard but we give proofs for the sake of completeness and to keep the present paper self-contained. Conditions (H1) and (H2) of course ensure existence and uniqueness of a solution to the Cauchy problem (6)-(7):

Proposition 1 Assume that **(H1)** and **(H2)** hold. For every $(x, z, u) \in \mathbb{R}^d \times L^2 \times V$, the Cauchy problem (6)-(7) admits a unique solution.

Proof. For $\theta > 0$, define

$$E_{\theta} := \{ y \in C^{0}(\mathbb{R}_{+}, \mathbb{R}^{d}), \sup_{t>0} e^{-\theta t} |y(t)| < +\infty \}$$

and equip E_{θ} with the norm:

$$||y||_{\theta} := \sup_{t>0} e^{-\theta t} |y(t)|.$$

Of course, $(E_{\theta}, ||.||_{\theta})$ is a Banach space. For $y \in E_{\theta}$, let us define:

$$Ty(t) := x + \int_0^t F(y(s), u(s), G_y(s)) ds, \ \forall t \ge 0$$

where

$$G_y(s) := \int_0^s A(\tau)y(s-\tau)d\tau + \int_s^{+\infty} A(\tau)z(\tau-s)d\tau.$$

Until the end of the proof, C will denote a positive constant (only depending on F and A) which may vary from one line to another. Let $y \in E_{\theta}$, with our assumptions on F, we first get:

$$|Ty(t)| \le |x| + C\left(t + \frac{e^{\theta t}}{\theta} ||y||_{\theta} + \int_0^t |G_y(s)|ds\right). \tag{9}$$

Now, we also have

$$|G_{y}(s)| \leq \left(\int_{0}^{s} |A(\tau)||y(s-\tau)|d\tau + ||A||_{L^{2}}||z||_{L^{2}}\right)$$

$$\leq ||A||_{L^{2}} \left(||y||_{\theta} \left(\int_{0}^{s} e^{2\theta(s-\tau)}d\tau\right)^{1/2} + ||z||_{L^{2}}\right)$$

$$\leq C\left(1 + \frac{e^{\theta s}||y||_{\theta}}{\sqrt{2\theta}}\right).$$

Together with (9), we then have

$$|Ty(t)|e^{-\theta t} \le |x|e^{-\theta t} + C\left(te^{-\theta t} + ||y||_{\theta}\left(\frac{1}{\theta} + \frac{1}{\sqrt{2}\theta^{3/2}}\right)\right)$$

which proves that $T(E_{\theta}) \subset E_{\theta}$. For y_1 and y_2 in E_{θ} and $t \geq 0$, on the one hand, we have:

$$|Ty_1(t) - Ty_2(t)| \le C\left(\frac{e^{\theta t}}{\theta}||y_1 - y_2||_{\theta} + \int_0^t |G_{y_1}(s) - G_{y_2}(s)|ds\right)$$

on the other hand:

$$|G_{y_1}(s) - G_{y_2}(s)| \le \frac{Ce^{\theta s}}{\sqrt{2\theta}} ||y_1 - y_2||_{\theta}$$

so that:

$$||Ty_1 - Ty_2||_{\theta} \le C||y_1 - y_2||_{\theta} \left(\frac{1}{\theta} + \frac{1}{\sqrt{2}\theta^{3/2}}\right).$$

For θ large enough ($\theta \ge 2C + 1$, say), T is a contraction of E_{θ} hence admits a unique fixed-point. This clearly proves the desired result.

From now on, for every $(x, z, u) \in \mathbb{R}^d \times L^2 \times V$, we denote by $y_{x,z,u}$ the solution of the Cauchy problem (6)-(7). The continuous dependence with respect to (x, z) of trajectories of (6)-(7) is given by:

Proposition 2 Assume that **(H1)** and **(H2)** hold. Let $u \in V$, (x_0, z_0) and (x, z) be in $\mathbb{R}^d \times L^2$ and define $y_0 := y_{x_0, z_0, u}$, $y := y_{x, z, u}$, then we have

$$|y(t) - y_0(t)| \le Ce^{\theta t}(|x - x_0| + ||z - z_0||_{L^2}), \ \forall t \ge 0$$

for some constants C and θ depending only on F and A.

Proof. In this proof, C will denote a positive constant that only depends on F and A but which may vary from one line to another. Defining for $s \ge 0$

$$\beta(s) := \int_0^s A(s-\tau)y(\tau)d\tau + \int_0^{+\infty} A(s+\tau)z(\tau)d\tau,$$

$$\beta_0(s) := \int_0^s A(s-\tau)y_0(\tau)d\tau + \int_0^{+\infty} A(s+\tau)z_0(\tau)d\tau,$$

$$\gamma(s) := \sup_{[0,s]} |y-y_0|, \ \Gamma(s) := \int_0^s \gamma,$$

we first have:

$$|y(s) - y_0(s)| \le |x - x_0| + C\left(\int_0^s (|y - y_0| + |\beta - \beta_0|)\right)$$

Since we also have

$$|\beta(\tau) - \beta_0(\tau)| \le C(\gamma(\tau)||A||_{L^1} + ||A||_{L^2}||z - z_0||_{L^2})$$

for t > 0, we then get:

$$\Gamma'(t) \le |x - x_0| + C \left(\Gamma(t) + \|z - z_0\|_{L^2}t\right)$$

which, together with Gronwall's Lemma gives the desired result.

Remark 1. Let us remark that when one further assumes that **(H'2)** holds (i.e. A is further assumed to be H^1), then the estimate of proposition 2 also holds true when one replaces $||z-z_0||_{L^2}$ by $||z-z_0||_{(H^1)'}$.

2.2 The optimal control problem

For $(x,z) \in \mathbb{R}^d \times L^2$, we consider the optimal control problem

$$v(x,z) := \inf_{u \in V} \int_0^{+\infty} e^{-\lambda s} L(y_{x,z,u}(s), u(s)) ds.$$
 (10)

where **(H3)**: $\lambda > 0$ and $L : \mathbb{R}^d \times K \to \mathbb{R}$ is assumed to be bounded, continuous and to satisfy

$$|L(x,u) - L(y,u)| \le C_2|x - y|, \ \forall (x,y,u) \in \mathbb{R}^d \times \mathbb{R}^d \times K \tag{11}$$

for some $C_2 \geq 0$. Throughout the paper, we will assume that **(H1)**, **(H2)** and **(H3)** hold.

2.3 Continuity properties of the value function

As a consequence of proposition 2, we deduce that v is bounded and uniformly continuous on $\mathbb{R}^d \times L^2$, which we denote $v \in \mathrm{BUC}(\mathbb{R}^d \times L^2, \mathbb{R})$. More precisely, adapting classical arguments (see e.g. G. Barles [3]) to our context, we have:

Proposition 3 Assume that **(H1)**, **(H2)** and **(H3)** hold, then $v \in BUC(\mathbb{R}^d \times L^2, \mathbb{R})$ and more precisely, defining θ as in proposition 2, one has:

- 1. v is Lipschitz continuous on $\mathbb{R}^d \times L^2$ if $\lambda > \theta$,
- 2. $v \in C^{0,\alpha}(\mathbb{R}^d \times L^2, \mathbb{R})$ for every $\alpha \in (0,1)$ if $\lambda = \theta$,
- 3. $v \in C^{0,\lambda/\theta}(\mathbb{R}^d \times L^2, \mathbb{R})$ if $\lambda < \theta$.

Proof. Let us define

$$\delta := |x - x_0| + ||z - z_0||_{L^2}.$$

Let $\varepsilon > 0$ and u_{ε} be such that

$$\int_0^{+\infty} e^{-\lambda s} L(y_{x,z,u_{\varepsilon}}(s), u_{\varepsilon}(s)) ds \le v(x,z) + \varepsilon$$

setting $y^{\varepsilon} := y_{x,z,u_{\varepsilon}}, y_0^{\varepsilon} := y_{x_0,z_0,u_{\varepsilon}}$ we then have:

$$v(x_0, z_0) - v(x, z) \le \int_0^{+\infty} e^{-\lambda s} \left(L(y_0^{\varepsilon}(s), u_{\varepsilon}(s)) - L(y^{\varepsilon}(s), u_{\varepsilon}(s)) \right) ds + \varepsilon.$$

Using proposition 2 and our assumptions on L, we then get, for some $C \ge 0$ and all $T \ge 0$:

$$v(x_0, z_0) - v(x, z) \le C\left(\int_0^T \delta e^{(\theta - \lambda)s} ds + e^{-\lambda T}\right). \tag{12}$$

If $\lambda > \theta$, we then have:

$$v(x_0, z_0) - v(x, z) \le \frac{C\delta}{\lambda - \theta}$$

which proves the first claim.

If $\lambda < \theta$ and if $\delta < 1$ (which may be assumed to prove that v is Hölder) taking $e^{-\lambda T} := \delta^{\lambda/\theta}$ in (12) then yields

$$v(x_0, z_0) - v(x, z) \le C \left(1 + \frac{1}{\theta - \lambda}\right) \delta^{\lambda/\theta}$$

which proves the second claim.

Finally, if $\lambda = \theta$ (and again assuming $\delta < 1$), taking $e^{-\lambda T} = \delta$ in (12) yields:

$$v(x_0, z_0) - v(x, z) \le C\left(\frac{-\delta \log(\delta)}{\lambda} + \delta\right)$$

which proves the last claim.

Remark 2. Again, if A is further assumed to be H^1 (i.e. when **(H'2)** holds) then the uniform continuity of v also holds true for the norm $(x, z) \mapsto |x| + ||z||_{(H^1)'}$ i.e. when in the previous proof δ is replaced by $\delta := |x - x_0| + ||z - z_0||_{(H^1)'}$. This fact will be useful later on when proving the comparison result.

In the sequel, we shall denote by $C^0(\mathbb{R}^d \times L^2_w, \mathbb{R})$ the class of real-valued functions defined on $\mathbb{R}^d \times L^2$ which are sequentially continuous for the weak topology of $\mathbb{R}^d \times L^2$, we then have the following:

Proposition 4 Assume that **(H1)**, **(H2)** and **(H3)** hold, then $v \in C^0(\mathbb{R}^d \times L^2_w, \mathbb{R})$.

Proof. Let $(\alpha_n)_n := (z_n, x_n)_n$ be a weakly convergent sequence in $\mathbb{R}^d \times L^2$ and let us denote by $\alpha := (x, z) \in \mathbb{R}^d \times L^2$ its weak limit. Let $u \in V$ be some admissible control and simply denote $y_n := y_{\alpha_n, u}$ and $y := y_{\alpha, u}$ the

trajectories of (6) associated respectively to the initial conditions α_n and α . If we prove that y_n converges uniformly on compact subsets to y as n tends to $+\infty$ then the desired result will easily follow from our assumptions on L. Let us define

$$\delta_n(t) := \int_0^{+\infty} A(t+s)z_n(s)ds, \ \delta(t) := \int_0^{+\infty} A(t+s)z(s)ds.$$

Since $A \in L^2$ by **(H2)**, we have:

$$|\delta_n(t)| \le ||A||_{L^2} ||z_n||_{L^2} \le C.$$

Thanks to **(H2)** again, δ_n converges pointwise to δ . Rewriting the state equation as:

$$\dot{y}(t) = F\left(y(t), u(t), \delta(t) + \int_0^t A(t-s)y(s)ds\right),$$

$$\dot{y}_n(t) = F\left(y_n(t), u(t), \delta_n(t) + \int_0^t A(t-s)y_n(s)ds\right)$$

we get:

$$|\dot{y}_n - \dot{y}|(t) \le C \left(|y_n - y|(t) + |\delta_n - \delta|(t) + \int_0^t |A(t - s)(y_n - y)(s)| ds \right)$$
(13)

(where again in this proof C denotes a nonnegative constant depending only on F and A but possibly changing from one line to another). Defining

$$\gamma_n(t) := \sup_{[0,t]} |y_n - y|, \ \Gamma_n(t) := \int_0^t \gamma_n,$$

inequality (13) yields for all $s \in [0, t]$:

$$|\dot{y}_n - \dot{y}|(s) \le C (|y_n - y|(s) + |\delta_n - \delta|(s) + ||A||_{L^1(0,t)} \gamma_n(s)).$$

Integrating the previous yields:

$$|y_n - y|(s) \le |x_n - x| + C\left(\Gamma_n(t) + \int_0^t |\delta_n - \delta|\right), \ \forall s \in [0, t].$$

Hence

$$\gamma_n(t) = \dot{\Gamma}_n(t) \le |x_n - x| + C\left(\Gamma_n(t) + \int_0^t |\delta_n - \delta|\right). \tag{14}$$

On the one hand, Dominated convergence implies that

$$\lim_{n} \int_{0}^{+\infty} |\delta_{n} - \delta| = 0,$$

on the other hand, (14) and Gronwall's Lemma imply that $\Gamma_n(t)$ tends to 0 as n tends to $+\infty$. With (14), this proves that $\gamma_n(t)$ tends to 0 as n tends to $+\infty$ and the desired result follows. Let us remark that, with (13), this of course also implies that $(y_n)_n$ converges to y in $W_{loc}^{1,\infty}(\mathbb{R}_+,\mathbb{R}^d)$.

3 Dynamic programming principle

Our aim now is to prove that the value function v obeys the following dynamic programming principle:

Proposition 5 Let $(x, z) \in \mathbb{R}^d \times L^2$ and $t \geq 0$, we then have:

$$v(x,z) = \inf_{u \in V} \left\{ \int_0^t e^{-\lambda s} L(y_{x,z,u}(s), u(s)) ds + e^{-\lambda t} v(y_{x,z,u}(t), y_{x,z,u}(t-.)) \right\}$$

$$(y_{x,z,u}(t-.)(s) := y_{x,z,u}(t-s) \text{ for all } s > 0).$$

Proof. Let $\varepsilon > 0$ and $u_{\varepsilon} \in V$ be such that

$$\int_0^{+\infty} e^{-\lambda s} L(y_{x,z,u_{\varepsilon}}(s), u_{\varepsilon}(s)) ds \le v(x,z) + \varepsilon$$

we then have

$$v(x,z) + \varepsilon \ge \int_0^t e^{-\lambda s} L(y_{x,z,u_{\varepsilon}}(s), u_{\varepsilon}(s)) ds$$
$$+ e^{-\lambda t} \int_0^{+\infty} e^{-\lambda \tau} L(y_{x,z,u_{\varepsilon}}(t+\tau), u_{\varepsilon}(t+\tau)) d\tau.$$

Using the fact that $y_{x,z,u_{\varepsilon}}(t+.)$ is the trajectory associated to the initial conditions $(y_{x,z,u_{\varepsilon}}(t), y_{x,z,u_{\varepsilon}}(t-.))$ and the control $u_{\varepsilon}(t+.)$, we deduce:

$$v(x,z) + \varepsilon \ge \int_0^t e^{-\lambda s} L(y_{x,z,u_{\varepsilon}}(s), u_{\varepsilon}(s)) ds + e^{-\lambda t} v(y_{x,z,u_{\varepsilon}}(t), y_{x,z,u_{\varepsilon}}(t-.))$$

$$\ge \inf_{u \in V} \left\{ \int_0^t e^{-\lambda s} L(y_{x,z,u}(s), u(s)) ds + e^{-\lambda t} v(y_{x,z,u}(t), y_{x,z,u}(t-.)) \right\}.$$

To prove the converse inequality, let $u \in V$,

$$x_t := y_{x,z,u}(t), \ z_t := y_{x,z,u}(t-.),$$

 $\varepsilon > 0$ and $\omega_{\varepsilon} \in V$ be such that:

$$\int_0^{+\infty} e^{-\lambda s} L(y_{x_t, z_t, \omega_{\varepsilon}}(s), \omega_{\varepsilon}(s)) ds \le v(x_t, z_t) + \varepsilon.$$

defining

$$u_{\varepsilon}(s) := \begin{cases} u(s) & \text{if } s \in [0, t] \\ \omega_{\varepsilon}(s - t) & \text{if } s > t \end{cases}$$

we have

$$y_{x,z,u_{\varepsilon}}(s) := \begin{cases} y_{x,z,u}(s) & \text{if } s \in [0,t] \\ y_{x_t,z_t,\omega_{\varepsilon}}(s-t) & \text{if } s > t \end{cases}$$

hence

$$v(x,z) \leq \int_0^t e^{-\lambda s} L(y_{x,z,u}(s), u(s)) ds + \int_t^{+\infty} e^{-\lambda s} L(y_{x_t,z_t,\omega_{\varepsilon}}(s-t), \omega_{\varepsilon}(s-t)) ds$$
$$\leq \int_0^t e^{-\lambda s} L(y_{x,z,u}(s), u(s)) ds + e^{-\lambda t} (v(x_t, z_t) + \varepsilon)$$

since u and $\varepsilon > 0$ are arbitrary, we get the desired result.

4 Viscosity solutions and Hamilton-Jacobi-Bellman equations

4.1 Preliminaries

Let us define

$$E_0 := \{ (z(0), z), z \in H^1((0, +\infty), \mathbb{R}^d) \}$$
(16)

and remark that E_0 is a dense subspace of our initial state space $E := \mathbb{R}^d \times L^2$. With the uniform continuity of v on $\mathbb{R}^d \times L^2$, this implies that v is fully determined by its restriction to E_0 . In fact, we will derive from the dynamic programming principle a PDE satisfied by v (a priori only on E_0) and by a comparison result we will see that in fact this equation (satisfied in some

appropriate viscosity sense) fully characterizes the value function v. Let us define

$$\mathcal{F}(x,z,u) := F\left(x,u,\int_0^{+\infty} A(s)z(s)ds\right), \ \forall (x,z,u) \in \mathbb{R}^d \times L^2 \times K.$$
 (17)

Before going further, we need the following classical lemma:

Lemma 1 Let $\delta > 0$ and $z \in L^2((-\delta, +\infty), \mathbb{R}^d)$ for $t \in [0, \delta]$, define $z_t(s) := z(s-t)$ for $s \geq 0$, then z_t converges to z in $L^2(\mathbb{R}_+, \mathbb{R}^d)$ as t goes to 0^+ .

Proof. First, let us remark that $||z_t||_{L^2(\mathbb{R}_+)}$ converges to $||z||_{L^2(\mathbb{R}_+)}$ hence it is enough to prove that z_t converges weakly to z in $L^2(\mathbb{R}_+, \mathbb{R}^d)$. To see this, let $f \in C_c^0(\mathbb{R}_+, \mathbb{R}^d)$, and remark that

$$\int_{\mathbb{R}_{+}} (z_{t} - z) \cdot f = \int_{-t}^{0} z(s) \cdot f(s+t) ds + \int_{\mathbb{R}_{+}} z(s) \cdot (f(s+t) - f(s)) ds$$

Since both terms in the right-hand side tend to 0 as t tends to 0, this proves that z is the only weak limit point of the bounded sequence z_t hence that z_t converges weakly to z in $L^2(\mathbb{R}_+, \mathbb{R}^d)$.

We will also need the following

Lemma 2 Let $(x, z) \in E_0$, $u \in V$ and for t > 0 define:

$$x_t := y_{x,z,u}(t), \ z_t(\tau) := y_{x,z,u}(t-\tau), \ \forall \tau > 0,$$

then $t \mapsto (x_t, z_t)$ is locally Lipschitz in t (uniformly in the control $u \in V$) for the $\mathbb{R}^d \times L^2$ norm. Moreover, for all $t \geq 0$

$$\lim_{s \to 0^+} \frac{z_{t+s} - z_t}{s} = -\dot{z}_t \text{ in } L^2, \tag{18}$$

and, for every t which is a Lebesgue point of $t \mapsto \mathcal{F}(x_t, z_t, u(t))$

$$\lim_{s \to 0^+} \frac{x_{t+s} - x_t}{s} = \mathcal{F}(x_t, z_t, u(t)). \tag{19}$$

Proof. The lipschitzianity of $t \mapsto x_t$ and the proof of (19) are straightforward. To shorten notation, we define $y := y_{x,z,u}$ and remark that for every $t \geq 0, y \in H^1((-\infty,t),\mathbb{R}^d)$ and that $y \in W^{1,\infty}_{loc}((0,+\infty),\mathbb{R}^d)$ so that (18) will

imply the local lipschitzianity of $t \mapsto z_t$. To prove (18), let us introduce for s > 0 and $\tau \ge 0$:

$$\Delta_s(\tau) := \frac{z_{t+s}(\tau) - z_t(\tau)}{s} + \dot{z}_t(\tau)$$

which can be rewritten as:

$$\Delta_s(\tau) = \frac{y(t+s-\tau) - y(t-\tau)}{s} - \dot{y}(t-\tau)$$
$$= \frac{1}{s} \int_0^s (\dot{y}(t-\tau+\alpha) - \dot{y}(t-\tau)) d\alpha$$

Jensen's inequality first yields:

$$\Delta_s(\tau)^2 \le \frac{1}{s} \int_0^s \left(\dot{y}(t - \tau + \alpha) - \dot{y}(t - \tau) \right)^2 d\alpha$$

using Fubini's theorem, we then get:

$$\|\Delta_s\|_{L^2}^2 \le \frac{1}{s} \int_0^s \left(\int_{\mathbb{R}_+} \left(\dot{y}(t - \tau + \alpha) - \dot{y}(t - \tau) \right)^2 d\tau \right) d\alpha.$$

By the same arguments as in lemma 1 and since $y \in H^1((-\infty, t), \mathbb{R}^d)$, for every $t \geq 0$, we deduce that for every $\varepsilon > 0$, there exists $s_{\varepsilon} > 0$ such that for all $\alpha \in [0, s_{\varepsilon}]$, one has:

$$\left(\int_{\mathbb{R}_+} \left(\dot{y}(t-\tau+\alpha) - \dot{y}(t-\tau)\right)^2 d\tau\right) \le \varepsilon$$

which proves that Δ_s converges to 0 in L^2 as s goes to 0.

Remark 3. It follows from lemma 2 that if $\psi \in C^1(\mathbb{R} \times \mathbb{R}^d \times L^2, \mathbb{R})$ then the function $t \mapsto \psi(t, x_t, z_t)$ is locally Lipschitz in t (in fact, uniformly in the control $u \in V$) and for all $t \geq 0$, one has:

$$\psi(t, x_t, z_t) = \psi(0, x_0, z_0)$$

$$+ \int_0^t \left(\partial_t \psi(s, x_s, z_s) + \nabla_x \psi(s, x_s, z_s) \cdot \mathcal{F}(x_s, z_s, u(s)) - \langle D_z \psi(s, x_s, z_s), \dot{z}_s \rangle \right) ds.$$

4.2 Formal derivation of the equation

To formally derive the Hamilton-Jacobi-Bellman equation of our problem, let us assume for a moment that v is of class C^1 on $\mathbb{R}^d \times L^2$. Let $(x, z) \in E_0$, $u \in K$ be some admissible constant control, and set

$$(x_t, z_t) := (y_{x,z,y}(t), y_{x,z,y}(t-.)),$$

by the dynamic programming principle, we first have:

$$v(x,z) \le \int_0^t e^{-\lambda s} L(x_s, u) ds + e^{-\lambda t} v(x_t, z_t)$$

so that

$$L(x, u) + \lim_{t \to 0^+} \frac{1}{t} \left(e^{-\lambda t} v(x_t, z_t) - v(x, z) \right) \ge 0$$

together with lemma 2, this reads as

$$L(x, u) + \nabla_x v(x, z) \cdot \mathcal{F}(x, z, u) - \lambda v(x, z) - \langle D_z v(x, z), \dot{z} \rangle \ge 0$$

and since u is arbitrary, this yields

$$\lambda v(x,z) + \langle D_z v(x,z), \dot{z} \rangle + \sup_{u \in K} \{ -L(x,u) - \nabla_x v(x,z) \cdot \mathcal{F}(x,z,u) \} \le 0.$$

We then define the Hamiltonian:

$$H(x,z,p) := \sup_{u \in K} \{-L(x,u) - p \cdot \mathcal{F}(x,z,u)\}, \ \forall (x,z,p) \in \mathbb{R}^d \times L^2 \times \mathbb{R}^d.$$
 (20)

Let $u \in V$, and simply denote $(x_{t,u}, z_{t,u}) := (y_{x,z,u}(t), y_{x,z,u}(t-.))$. Using remark 3 following lemma 2, with $\psi(t, x, z) := e^{-\lambda t} v(x, z)$, we have:

$$e^{-\lambda t}v(x_{t,u}, z_{t,u}) = v(x, z) - \int_0^t e^{-\lambda s} \lambda v(x_{s,u}, z_{s,u}) ds$$
$$+ \int_0^t e^{-\lambda s} \left(\nabla_x v(x_{s,u}, z_{s,u}) \cdot \mathcal{F}(x_{s,u}, z_{s,u}, u(s)) - \langle D_z v(x_{s,u}, z_{s,u}), \dot{z}_{s,u} \rangle \right) ds$$

so that the dynamic programming principle yields:

$$0 = \inf_{u \in V} \{ \int_{0}^{t} e^{-\lambda s} (L(x_{s,u}, u(s)) - \lambda v(x_{s,u}, z_{s,u}) + \nabla_{x} v(x_{s,u}, z_{s,u}) \cdot \mathcal{F}(x_{s,u}, z_{s,u}, u(s)) - \langle D_{z} v(x_{s,u}, z_{s,u}), \dot{z}_{s,u} \rangle) ds \}$$

$$\geq \inf_{u \in V} \{ \int_{0}^{t} e^{-\lambda s} (-H(x_{s,u}, z_{s,u}, \nabla_{x} v(x_{s,u}, z_{s,u})) - \lambda v(x_{s,u}, z_{s,u}) - \langle D_{z} v(x_{s,u}, z_{s,u}), \dot{z}_{s,u} \rangle) ds \}.$$

It is natural to expect the integrand above to converge as $t \to 0^+$, uniformly in u to

$$-H(x, z, \nabla_x v(x, z)) - \lambda v(x, z) - \langle D_z v(x, z), \dot{z} \rangle$$

so that:

$$\lambda v(x,z) + \langle D_z v(x,z), \dot{z} \rangle + H(x,z,\nabla_x v(x,z)) \ge 0.$$

Thus, at least formally, the Hamilton-Jacobi-Bellman equation satisfied by the value function v can be written as:

$$\lambda v(x,z) + H(x,z,\nabla_x v(x,z)) + \langle D_z v(x,z), \dot{z} \rangle = 0 \text{ on } E_0.$$
 (21)

with H defined by (20).

The next lemma whose easy proof is left to the reader gives the regularity properties of ${\cal H}$

Lemma 3 Let H be the Hamiltonian defined by (20). Assume that (H1), (H2) and (H3) hold, then there exists a nonnegative constant C such that:

$$|H(x,z,p) - H(y,w,p)| \le C(|x-y| + ||z-w||_{L^2})(1+|p|), \qquad (22)$$

and

$$|H(x,z,p) - H(x,z,q)| \le C|p-q|(1+|x|+||z||_{L^2}),$$
 (23)

for every $(x, z, y, w, p, q) \in (\mathbb{R}^d \times L^2)^2 \times \mathbb{R}^d \times \mathbb{R}^d$. If, in addition **(H'2)** is satisfied, then (22) can be improved by:

$$|H(x,z,p) - H(y,w,p)| \le C (|x-y| + ||z-w||_{(H^1)'}) (1+|p|),$$
 (24)

for every $(x, z, y, w, p) \in (\mathbb{R}^d \times L^2)^2 \times \mathbb{R}^d$.

4.3 Definition of viscosity solutions

The formal manipulations above actually suggest that the natural definition of viscosity solutions in the present context should read as:

Definition 1 Let $w \in BUC(\mathbb{R}^d \times L^2, \mathbb{R}) \cap C^0(\mathbb{R}^d \times L^2_w, \mathbb{R})$, then w is said to be

1. a viscosity subsolution of (21) on $\mathbb{R}^d \times L^2$ if for every $(x_0, z_0) \in \mathbb{R}^d \times L^2$ and every $\phi \in C^1(\mathbb{R}^d \times L^2, \mathbb{R})$ such that $w - \phi$ has a local maximum (in the sense of the strong topology of $\mathbb{R}^d \times L^2$) at (x_0, z_0) , one has:

$$\lambda w(x_0, z_0) + H(x_0, z_0, \nabla_x \phi(x_0, z_0)) + \liminf_{(x, z) \in E_0 \to (x_0, z_0)} \langle D_z \phi(x, z), \dot{z} \rangle \le 0,$$

where the convergence $(x, z) \in E_0 \to (x_0, z_0)$ has to be understood in the strong $\mathbb{R}^d \times L^2$ sense,

2. a viscosity supersolution of (21) on $\mathbb{R}^d \times L^2$ if for every $(x_0, z_0) \in \mathbb{R}^d \times L^2$ and every $\phi \in C^1(\mathbb{R}^d \times L^2, \mathbb{R})$ such that $w - \phi$ has a local minimum (in the sense of the strong topology of $\mathbb{R}^d \times L^2$) at (x_0, z_0) , one has:

$$\lambda w(x_0, z_0) + H(x_0, z_0, \nabla_x \phi(x_0, z_0)) + \limsup_{(x,z) \in E_0 \to (x_0, z_0)} \langle D_z \phi(x, z), \dot{z} \rangle \ge 0,$$

where the convergence $(x, z) \in E_0 \to (x_0, z_0)$ has to be understood in the strong $\mathbb{R}^d \times L^2$ sense,

3. a viscosity solution of (21) on $\mathbb{R}^d \times L^2$ if it is both a viscosity subsolution of (21) and a viscosity supersolution of (21) on $\mathbb{R}^d \times L^2$.

4.4 The value function is a viscosity solution

Proposition 6 Assume that **(H1)**, **(H2)** and **(H3)** hold. The value function v defined by (10) is a viscosity solution of (21) on $\mathbb{R}^d \times L^2$.

Proof. Step 1: v is a viscosity subsolution.

Let $\alpha_0 := (x_0, z_0) \in \mathbb{R}^d \times L^2$ and $\phi \in C^1(\mathbb{R}^d \times L^2, \mathbb{R})$ such that $v(x_0, z_0) = \phi(x_0, z_0)$ and $\phi \geq v$ on the ball $B_r := B((x_0, z_0), r)$ of $\mathbb{R}^d \times L^2$. Let $u \in K$ be some constant control. For all $\varepsilon > 0$, there is some $\alpha_{\varepsilon} := (x_{\varepsilon}, z_{\varepsilon}) \in E_0$ such that

$$\phi(\alpha_{\varepsilon}) - \varepsilon^2 \le v(\alpha_{\varepsilon}) \le \phi(\alpha_{\varepsilon}), \lim_{\varepsilon} \alpha_{\varepsilon} = \alpha_0 \text{ in } \mathbb{R}^d \times L^2$$

and such that $\alpha_{\varepsilon,s} = (x_{\varepsilon,s}, z_{\varepsilon,s}) = (y_{\alpha_{\varepsilon},u}(s), y_{\alpha_{\varepsilon},u}(s-.))$ belongs to B_r for all $s \in [0, \varepsilon]$. Note that by construction, $\alpha_{\varepsilon,s}$ belongs to E_0 for every $s \in [0, \varepsilon]$. The dynamic programming principle first yields

$$\phi(\alpha_{\varepsilon}) - \varepsilon^2 \le \int_0^{\varepsilon} e^{-\lambda s} L(x_{\varepsilon,s}, u) ds + e^{-\lambda \varepsilon} \phi(\alpha_{\varepsilon,\varepsilon}).$$
 (25)

Thanks to the smoothness of ϕ , lemma 2 and remark 3, we can write:

$$e^{-\lambda\varepsilon}\phi(\alpha_{\varepsilon,\varepsilon}) = \phi(\alpha_{\varepsilon}) + \varepsilon(\nabla_x\phi(\alpha_{\varepsilon})\cdot\mathcal{F}(\alpha_{\varepsilon},u) - \lambda\phi(\alpha_{\varepsilon}))$$
$$-\int_0^\varepsilon e^{-\lambda s} \langle D_z\phi(\alpha_{\varepsilon,s}), \dot{z}_{\varepsilon,s}\rangle ds + o(\varepsilon)$$

Using (25), dividing by ε and taking the liminf as $\varepsilon \to 0^+$, we then get:

$$\begin{split} 0 & \geq \operatorname{liminf}_{\varepsilon \to 0^{+}} \left(-\frac{1}{\varepsilon} \int_{0}^{\varepsilon} e^{-\lambda s} L(x_{\varepsilon,s}, u) ds - \nabla_{x} \phi(\alpha_{\varepsilon}) \cdot \mathcal{F}(\alpha_{\varepsilon}, u) + \lambda \phi(\alpha_{\varepsilon}) \right) \\ & + \operatorname{liminf}_{\varepsilon \to 0^{+}} \frac{1}{\varepsilon} \int_{0}^{\varepsilon} e^{-\lambda s} \left\langle D_{z} \phi(\alpha_{\varepsilon,s}), \dot{z}_{\varepsilon,s} \right\rangle ds \end{split}.$$

Since we have:

$$\operatorname{liminf}_{\varepsilon \to 0^{+}} \frac{1}{\varepsilon} \int_{0}^{\varepsilon} e^{-\lambda s} \left\langle D_{z} \phi(\alpha_{\varepsilon,s}), \dot{z}_{\varepsilon,s} \right\rangle ds \geq \operatorname{liminf}_{(x,z) \in E_{0} \to \alpha_{0}} \left\langle D_{z} \phi(x,z), \dot{z} \right\rangle,$$

we then obtain:

$$0 \ge -L(x_0, u) - \nabla_x \phi(\alpha_0) \cdot \mathcal{F}(\alpha_0, u) + \lambda v(\alpha_0) + \liminf_{(x, z) \in E_0 \to \alpha_0} \langle D_z \phi(x, z), \dot{z} \rangle.$$

Since $u \in K$ is arbitrary in the previous inequality, taking the supremum with respect to u and using the very definition of H given in (20), we thus deduce:

$$\lambda v(\alpha_0) + H(\alpha_0, \nabla_x \phi(\alpha_0)) + \liminf_{(x,z) \in E_0 \to \alpha_0} \langle D_z \phi(x,z), \dot{z} \rangle \leq 0,$$

which proves that v is a viscosity subsolution of (21) on $\mathbb{R}^d \times L^2$.

Step 2: v is a viscosity supersolution.

Now let $\phi \in C^1(\mathbb{R}^d \times L^2, \mathbb{R})$ be such that $v(\alpha_0) = \phi(\alpha_0)$ and $v \ge \phi$ on the ball $B_r := B(\alpha_0, r)$ of $\mathbb{R}^d \times L^2$. For all $\varepsilon > 0$, there is some $\alpha_{\varepsilon} := (x_{\varepsilon}, z_{\varepsilon}) \in E_0$ such that

$$\phi(\alpha_{\varepsilon}) + \varepsilon^2 \ge v(\alpha_{\varepsilon}) \ge \phi(\alpha_{\varepsilon})$$

and such that for every $u \in V$, $\alpha_{\varepsilon,s,u} = (x_{\varepsilon,s,u}, z_{\varepsilon,s,u}) = (y_{\alpha_{\varepsilon},u}(s), y_{\alpha_{\varepsilon},u}(s-.))$ belongs to B_r for all $s \in [0, \varepsilon]$. The dynamic programming principle then gives:

$$\phi(\alpha_{\varepsilon}) + \varepsilon^{2} \ge \inf_{u \in V} \left\{ \int_{0}^{\varepsilon} e^{-\lambda s} L(x_{\varepsilon,s,u}, u(s)) ds + e^{-\lambda \varepsilon} \phi(\alpha_{\varepsilon,\varepsilon,u}) \right\}$$
 (26)

With lemma 2 and remark 3, we can rewrite

$$e^{-\lambda\varepsilon}\phi(\alpha_{\varepsilon,\varepsilon,u}) = \phi(\alpha_{\varepsilon}) - \int_0^{\varepsilon} e^{-\lambda s} \lambda \phi(\alpha_{\varepsilon,s,u}) ds$$
$$+ \int_0^{\varepsilon} e^{-\lambda s} \left(\nabla_x \phi(\alpha_{\varepsilon,s,u}) \cdot \mathcal{F}(\alpha_{\varepsilon,s,u}, u(s)) - \langle D_z \phi(\alpha_{\varepsilon,s,u}), \dot{z}_{\varepsilon,s,u} \rangle \right) ds$$

Using (26), we then get:

$$\varepsilon^{2} \geq \inf_{u \in V} \left\{ \int_{0}^{\varepsilon} e^{-\lambda s} (L(x_{\varepsilon,s,u}, u(s)) - \lambda \phi(\alpha_{\varepsilon,s,u}) + \nabla_{x} \phi(\alpha_{\varepsilon,s,u}) \cdot \mathcal{F}(\alpha_{\varepsilon,s,u}, u(s)) - \langle D_{z} \phi(\alpha_{\varepsilon,s,u}), \dot{z}_{\varepsilon,s,u} \rangle) ds \right\}$$

$$\geq \inf_{u \in V} \left\{ \int_{0}^{\varepsilon} e^{-\lambda s} (-H(\alpha_{\varepsilon,s,u}, \nabla_{x} \phi(\alpha_{\varepsilon,s,u})) - \lambda \phi(\alpha_{\varepsilon,s,u}) - \langle D_{z} \phi(\alpha_{\varepsilon,s,u}, \dot{z}_{\varepsilon,s,u} \rangle) ds \right\}$$

From the continuity of $\nabla_x \phi$, $D_z \phi$, and H, we deduce the (uniform in u) convergence as $\varepsilon \to 0^+$ and $s \in [0, \varepsilon]$, of $\nabla_x \phi(\alpha_{\varepsilon,s,u})$, $D_z \phi(\alpha_{\varepsilon,s,u})$ and $H(\alpha_{\varepsilon,s,u}, \nabla_x \phi(\alpha_{\varepsilon,s,u}))$ respectively to $\nabla_x \phi(\alpha_0)$, $D_z \phi(\alpha_0)$ and $H(\alpha_0, \nabla_x \phi(\alpha_0))$. Dividing by $-\varepsilon$ the last inequality and taking the limsup as $\varepsilon \to 0^+$, we thus get:

$$\lambda v(\alpha_0) + H(\alpha_0, \nabla_x \phi(\alpha_0)) + \limsup_{(x,z) \in E_0 \to \alpha_0} \langle D_z \phi(x,z), \dot{z} \rangle \ge 0$$

which proves that v is a viscosity supersolution of (21) on $\mathbb{R}^d \times L^2$.

5 Comparison and uniqueness

5.1 Preliminaries

Our aim now is to prove that v is the unique viscosity subsolution of the Hamilton-Jacobi-Bellman equation:

$$\lambda v(x,z) + H(x,z,\nabla_x v(x,z)) + \langle D_z v(x,z), \dot{z} \rangle = 0.$$

This will of course follow from a comparison result stating that if v_1 and v_2 (in a suitable class of continuous functions) are respectively a viscosity subsolution and a viscosity supersolution of the equation then $v_1 \leq v_2$ on $E := \mathbb{R}^d \times L^2$. As usual, the comparison result is proved, by introducing a doubling of variables and by considering perturbed problems of the form:

$$\sup \{v_1(\alpha_1) - v_2(\alpha_2) - P_{\theta}(\alpha_1, \alpha_2) : (\alpha_1, \alpha_2) \in (\mathbb{R}^d \times L^2)^2\}$$

where P_{θ} is some perturbation function (depending on small parameters θ). This perturbation includes a penalization of the doubling of variables and coercive terms that ensure the existence of maxima say α_1^{θ} and α_2^{θ} . Then one uses the fact that v_1 is a viscosity subsolution by taking $\phi := P_{\theta}(., \alpha_2^{\theta})$ as test-function.

To overcome the difficulties due to the fact that the term $\langle D_z \phi(\alpha), \dot{z} \rangle$ is only defined for $z \in H^1$ and that the equation is only justified when in addition z(0) = x, one has to be careful on the choice of the perturbation P_{θ} . For general infinite-dimensional Hamilton-Jacobi equations with an unbounded linear term, these difficulties were solved in a general way by M. Crandall and P.-L. Lions in [9, 10, 11]. One of the key arguments of M. Crandall and P.-L. Lions in [9] is to use a suitable norm to penalize the doubling of

variables. In our context this, roughly speaking, amounts to use a kind of $(H^1)'$ norm instead of the L^2 norm in the doubling of variables. As usual, the comparison proof will very much rely on the use of quadratic test-functions of the form:

$$\phi(\alpha) = \Phi_1(x) + \Phi_2(\alpha) + \Phi_3(z) := a|x|^2 + b \langle B(\alpha - \alpha_0), \alpha - \alpha_0 \rangle + c||z||^2$$

where a and b and c are constants and B is a bounded positive self-adjoint operator of $\mathbb{R}^d \times L^2$. Let us first note that in our case the term $\langle \Phi_3'(z), \dot{z} \rangle = 2c \langle z, \dot{z} \rangle$ can be dealt easily since, if $z \in H^1$, one has:

$$\langle z, \dot{z} \rangle = -\frac{1}{2} |z(0)|^2$$

and since in the definition of viscosity solutions, we have imposed the convergence of the initial value z(0), it is easy to figure out that this term won't be a big problem in the proof. The difficulty of dealing with the second term $\langle D_z \Phi_2(\alpha), \dot{z} \rangle$ can be solved by properly choosing B as in M. Crandall and P.-L. Lions [10] who emphasized the good properties B should enjoy for the comparison proof to work. We now proceed to the explicit construction of such a B in our context.

Let us endow $E:=\mathbb{R}^d\times L^2$ with its standard Hilbertian structure, i.e. with the norm:

$$\|\alpha\|^2 := |x|^2 + \|z\|_{L^2}^2, \ \forall \alpha = (x, z) \in E$$

and the corresponding inner product $\langle ., . \rangle$. Let T be the linear unbounded operator on E with domain $D(T) = \mathbb{R}^d \times H^1$ and defined by

$$T(y, w) := (y - w(0), -\dot{w}), \ \forall (y, w) \in D(T).$$
 (27)

Its adjoint T^* has domain $D(T^*) = E_0 = \{(x, z) \in E : z \in H^1, z(0) = x\}$ and is given by

$$T^*(x,z) := (z(0),\dot{z}) = (x,\dot{z}), \ \forall (x,z) \in D(T^*) = E_0.$$
 (28)

The unbounded operator $I + T^*T$ therefore has domain

$$D(T^*T) = \{(y, w) \in E : w \in H^2, y = w(0) - \dot{w}(0)\}$$

and is given by

$$(I + T^*T)(y, w) := (2y - w(0), -\ddot{w} + w), \ \forall (y, w) \in D(T^*T). \tag{29}$$

Now, let us set $B := (I + T^*T)^{-1}$. For $\alpha = (x, z) \in E$, $(y, w) := B(\alpha)$ is defined as follows: firtsly, $w \in H^2$ is the solution of

$$\begin{cases}
-\ddot{w} + w = z & \text{in } (0, +\infty) \\
-2\dot{w}(0) + w(0) = x,
\end{cases} (30)$$

secondly, y is defined by

$$y = \frac{x + w(0)}{2} = w(0) - \dot{w}(0). \tag{31}$$

In the sequel we shall also denote $B = (B_1, B_2)$ where $B_2(x, z) = w$ is defined by (30) and $B_1(x, z) = y$ is given by (30) and (31). Setting:

$$\|\alpha\|_B^2 := \langle B(\alpha), \alpha \rangle, \ \forall \alpha = (x, z) \in E,$$

and defining $w := B_2(\alpha)$ by (30), an elementary computation shows that

$$\|\alpha\|_B^2 = \frac{|x|^2}{2} + \frac{|w(0)|^2}{2} + \|w\|_{H^1}^2$$
(32)

which in particular shows that there is some constant C > 0, such that

$$\|(x,z)\|_B^2 \ge C\left(|x|^2 + \|z\|_{(H^1)'}^2\right), \ \forall (x,z) \in E.$$
 (33)

Obviously, by construction B is a self-adjoint, nonnegative compact operator on E and TB is a bounded operator on E. For $\alpha = (x, z) \in E_0 = D(T^*)$ and $w := B_2(\alpha)$, some computations lead to:

$$\langle TB(\alpha), \alpha \rangle = \langle B(\alpha), T^*(\alpha) \rangle = \frac{3}{8} |x - w(0)|^2 + \frac{x \cdot w(0)}{2} \ge \frac{1}{8} |x - w(0)|^2,$$

and since TB is continuous and E_0 is dense in E this proves

$$\langle TB(\alpha), \alpha \rangle \ge 0, \ \forall \alpha \in E.$$
 (34)

Let us also remark that for $\alpha \in E$ and $\beta := B(\alpha)$ one has:

$$\|\alpha\|_B^2 = \langle \alpha, \beta \rangle = \langle (I + T^*T)(\beta), \beta \rangle \ge \|\beta\|^2,$$

so that

$$||B(\alpha)|| \le ||\alpha||_B, \ \forall \alpha \in E. \tag{35}$$

In the sequel we will denote by $BUC(E_B, \mathbb{R})$ the space of bounded and uniformly continuous functions on E equipped with the norm $\|.\|_B$. Let us

remark that because of (33), bounded functions which are uniformly continuous on E equipped with the usual norm of $\mathbb{R}^d \times (H^1)'$ belong to BUC(E_B, \mathbb{R}). In particular if A is H^1 then the value function v defined by (10) belongs to BUC(E_B, \mathbb{R}).

We end this paragraph by remarking that equation (21) now can (at least formally) be rewritten as

$$\lambda v(\alpha) + H(\alpha, \nabla_x v(\alpha)) - x \cdot \nabla_x v(\alpha) + \langle T^*(\alpha), Dv(\alpha) \rangle = 0, \alpha \in D(T^*).$$
 (36)

As in M. Crandall and P.L. Lions [10], we will take advantage of this structure (where $\langle T^*(\alpha), Dv(\alpha) \rangle$ has to be understood as $\langle \alpha, T(Dv(\alpha)) \rangle$) by imposing restrictions on test-functions (typically of the form $\|\alpha - \alpha_0\|_B^2$) rather than on α .

5.2 Comparison theorem

The comparison result for (21) then reads as

Theorem 1 Assume that **(H1)**, **(H'2)** and **(H3)** hold. Let v_1 and v_2 be in $BUC(E_B, \mathbb{R}) \cap C^0(E_w, \mathbb{R})$ respectively a viscosity subsolution and a viscosity supersolution of (21) on $\mathbb{R}^d \times L^2$ then $v_1 \leq v_2$ on $\mathbb{R}^d \times L^2$.

Proof. Let us define $M := \sup_E (v_1 - v_2), B := (I + T^*T)^{-1}$ and

$$\|\alpha\|_B^2 := \langle B(\alpha), \alpha \rangle, \ \forall \alpha = (x, z) \in E$$

as before. For all $\varepsilon > 0$, $\delta > 0$ and $\alpha_1 := (x_1, z_1)$, $\alpha_2 := (x_2, z_2)$, in $\mathbb{R}^d \times L^2$, let us set $\theta := (\varepsilon, \delta)$ and

$$\Phi_{\theta}(\alpha_1, \alpha_2) := v_1(\alpha_1) - v_2(\alpha_2) - \frac{1}{2\varepsilon} \|\alpha_1 - \alpha_2\|_B^2 - \frac{\delta}{2} (\|\alpha_1\|^2 + \|\alpha_2\|^2).$$

Let us also define:

$$M_{\varepsilon,\delta} = M_{\theta} = \sup \{ \Phi_{\theta}(\alpha_1, \alpha_2), (\alpha_1, \alpha_2) \in E \times E \}.$$

The weak continuity and boundedness properties of v_1 , v_2 ensure that the supremum M_{θ} is attained at some points $\alpha_i^{\theta} = (x_i^{\theta}, z_i^{\theta})$ for i = 1, 2.

Let us set

$$\Phi_1(\alpha) := \frac{1}{2\varepsilon} \|\alpha - \alpha_2^{\theta}\|_B^2 + \frac{\delta}{2} \|\alpha\|^2, \ \forall \alpha \in E,$$

we then have:

$$D\Phi_1(\alpha) = \left(\frac{1}{\varepsilon}B_1(\alpha - \alpha_2^{\theta}) + \delta x, \frac{1}{\varepsilon}B_2(\alpha - \alpha_2^{\theta}) + \delta z\right), \ \forall \alpha = (x, z) \in E.$$

Since α_1^{θ} is a maximum of $v_1 - \Phi_1$ on E and since v_1 is a viscosity subsolution of (21), we get from definition 1:

$$\lambda v_1(\alpha_1^{\theta}) + H(\alpha_1^{\theta}, q_{\theta} + \delta x_1^{\theta}) + \lim_{\alpha = (x, z) \in E_0 \to \alpha_1^{\theta}} \left\langle \frac{1}{\varepsilon} B_2(\alpha - \alpha_2^{\theta}) + \delta z, \dot{z} \right\rangle \le 0,$$
(37)

where

$$q_{\theta} := \frac{1}{\varepsilon} B_1(\alpha_1^{\theta} - \alpha_2^{\theta}). \tag{38}$$

We then remark that

$$\langle z, \dot{z} \rangle = -\frac{1}{2} |z(0)|^2 \to -\frac{1}{2} |x_1^{\theta}|^2 \text{ as } \alpha \in E_0 \to \alpha_1^{\theta}.$$

Next, we write:

$$\langle B_2(\alpha - \alpha_2^{\theta}), \dot{z} \rangle = \langle B(\alpha - \alpha_2^{\theta}), T^*(\alpha) \rangle - B_1(\alpha - \alpha_2^{\theta}) \cdot x$$
$$= \langle TB(\alpha - \alpha_2^{\theta}), \alpha \rangle - B_1(\alpha - \alpha_2^{\theta}) \cdot x$$

and since TB and B_1 are continuous, we get:

$$\langle B_2(\alpha - \alpha_2^{\theta}), \dot{z} \rangle \rightarrow \langle TB(\alpha_1^{\theta} - \alpha_2^{\theta}), \alpha_1^{\theta} \rangle - B_1(\alpha_1^{\theta} - \alpha_2^{\theta}) \cdot x_1^{\theta} \text{ as } \alpha \in E_0 \rightarrow \alpha_1^{\theta}.$$

Hence (37) can be rewritten as:

$$\lambda v_1(\alpha_1^{\theta}) + H(\alpha_1^{\theta}, q_{\theta} + \delta x_1^{\theta}) - q_{\theta} \cdot x_1^{\theta} - \frac{\delta}{2} |x_1^{\theta}|^2 + \frac{1}{\varepsilon} \left\langle TB(\alpha_1^{\theta} - \alpha_2^{\theta}), \alpha_1^{\theta} \right\rangle \le 0. \tag{39}$$

Using in a similar way the fact that v_2 is a viscosity supersolution, we arrive at:

$$\lambda v_2(\alpha_2^{\theta}) + H(\alpha_2^{\theta}, q_{\theta} - \delta x_2^{\theta}) - q_{\theta} \cdot x_2^{\theta} + \frac{\delta}{2} |x_2^{\theta}|^2 - \frac{1}{\varepsilon} \left\langle TB(\alpha_2^{\theta} - \alpha_1^{\theta}), \alpha_2^{\theta} \right\rangle \ge 0. \tag{40}$$

Substracting (39) and (40) then yields:

$$\lambda(v_{1}(\alpha_{1}^{\theta}) - v_{2}(\alpha_{2}^{\theta})) + H(\alpha_{1}^{\theta}, q_{\theta} + \delta x_{1}^{\theta}) - H(\alpha_{2}^{\theta}, q_{\theta} - \delta x_{2}^{\theta}) + q_{\theta} \cdot (x_{2}^{\theta} - x_{1}^{\theta}) - \frac{\delta}{2}(|x_{1}^{\theta}|^{2} + |x_{1}^{\theta}|^{2}) + \frac{1}{\varepsilon} \langle TB(\alpha_{1}^{\theta} - \alpha_{2}^{\theta}), \alpha_{1}^{\theta} - \alpha_{2}^{\theta} \rangle \leq 0.$$

Now, thanks to (34), the last term is nonnegative, which gives:

$$\lambda(v_1(\alpha_1^{\theta}) - v_2(\alpha_2^{\theta})) + H(\alpha_1^{\theta}, q_{\theta} + \delta x_1^{\theta}) - H(\alpha_2^{\theta}, q_{\theta} - \delta x_2^{\theta})$$

$$+ q_{\theta} \cdot (x_2^{\theta} - x_1^{\theta}) \le \frac{\delta}{2} (|x_1^{\theta}|^2 + |x_1^{\theta}|^2).$$
(41)

By standard arguments (see for instance [3] or [2]) and thanks to the fact that v_1 and v_2 belong to BUC(E_B, \mathbb{R}), one easily obtains:

$$\lim_{\theta \to (0^+, 0^+)} \left(\delta \|\alpha_i^{\theta}\|^2, \varepsilon^{-1} \|\alpha_1^{\theta} - \alpha_2^{\theta}\|_B^2, M_{\theta}, v_1(\alpha_1^{\theta}) - v_2(\alpha_2^{\theta}) \right) = (0, 0, M, M).$$
(42)

On the one hand, using (32) and (42), we have:

$$|x_1^{\theta} - x_2^{\theta}| \le \sqrt{2} \|\alpha_1^{\theta} - \alpha_2^{\theta}\|_B = o(\sqrt{\varepsilon})$$

on the other hand, using (35), we have

$$|q_{\theta}| \le \frac{1}{\varepsilon} \|B(\alpha_1^{\theta} - \alpha_2^{\theta})\| \le \frac{1}{\varepsilon} \|\alpha_1^{\theta} - \alpha_2^{\theta}\|_B = o(\frac{1}{\sqrt{\varepsilon}})$$

so that

$$\lim_{\theta \to (0^+, 0^+)} q_{\theta} \cdot (x_2^{\theta} - x_1^{\theta}) = 0.$$

Lemma 3 and (33) then imply that there is a nonnegative constant C such that:

$$|H(\alpha, p) - H(\beta, p)| \le C||\alpha - \beta||_B(1 + |p|), \ \forall (\alpha, \beta, p) \in E^2 \times \mathbb{R}^d, \tag{43}$$

and

$$|H(\alpha, p) - H(\alpha, q)| \le C|p - q|(1 + ||\alpha||), \ \forall (\alpha, p, q) \in E \times \mathbb{R}^d \times \mathbb{R}^d.$$
 (44)

We thus deduce

$$H(\alpha_1^{\theta}, q_{\theta} + \delta x_1^{\theta}) - H(\alpha_2^{\theta}, q_{\theta} - \delta x_2^{\theta}) = H(\alpha_1^{\theta}, q_{\theta} + \delta x_1^{\theta}) - H(\alpha_2^{\theta}, q_{\theta} + \delta x_1^{\theta})$$

$$+ H(\alpha_2^{\theta}, q_{\theta} + \delta x_1^{\theta}) - H(\alpha_2^{\theta}, q_{\theta} - \delta x_2^{\theta})$$

$$\leq C \left(\|\alpha_1^{\theta} - \alpha_2^{\theta}\|_B (1 + |q_{\theta}| + \delta(|x_1^{\theta}| + |x_2^{\theta}|)) \right)$$

$$+ C \left((1 + \|\alpha_2^{\theta}\|) \delta(|x_1^{\theta}| + |x_2^{\theta}|) \right)$$

$$= o(\sqrt{\varepsilon}) o(\frac{1}{\sqrt{\varepsilon}}) + o(\frac{1}{\sqrt{\delta}}) o(\sqrt{\delta}) \to 0 \text{ as } \theta \to (0^+, 0^+).$$

Putting everything together and passing to the limit in (41) then yields $\lambda M \leq 0$ so that the proof is complete.

We have already noticed that if A is H^1 then v defined by (10) actually belongs to $BUC(E_B, \mathbb{R})$. We thus deduce the following

Theorem 2 Assume that **(H1)**, **(H'2)** and **(H3)** hold, then the value function v defined by (10) is the only $BUC(E_B, \mathbb{R}) \cap C^0(E_w, \mathbb{R})$ viscosity solution of (21) on $\mathbb{R}^d \times L^2$.

6 Variants and concluding remarks

6.1 Finite-dimensional reduction

For the sake of simplicity, let us assume in this paragraph that d = k = 1 and that A is an exponential weight:

$$A(s) = e^{-\delta s}, \ \forall s > 0 \text{ with } \delta > 0.$$
 (45)

Defining the optimal control problem and its value function v as in (10), it is easy to see that, under the special exponential form of A, v actually depends on z only through the scalar parameter $y(z) := \int_0^\infty e^{-\delta s} z(s) ds$. More precisely, setting:

$$v(x,z) = w(x,y(z)), \ \forall (x,z) \in E \text{ and } y(z) := \int_0^{+\infty} e^{-\delta s} z(s) ds. \tag{46}$$

it is easy to check that v solves the infinite-dimensional Hamilton-Jacobi equation (21) if and only if v is given by (46) and w solves the two-dimensional equation:

$$\lambda w(x,y) + H_0(x,y,\partial_x w(x,y)) - \partial_y w(x,y)(\delta y + x) = 0, \tag{47}$$

where

$$H_0(x, y, p) := \sup_{u \in K} \{-L(x, u) - p \cdot F(x, u, y)\}, \ \forall (x, y, p) \in \mathbb{R}^3.$$

This finite-dimensional reduction of the problem of course heavily relies on the exponential form (45). We refer to [14] for the extension of such finitedimensional reduction in a stochastic setting.

6.2 The evolutionary problem

In the present article, we have focused on the stationary case. If we consider, the finite horizon optimal control problem

$$v(t,x,z) := \inf_{u \in V} \left\{ \int_{t}^{T} L(s, y_{t,x,z,u}(s), u(s)) ds + g(y_{t,x,z,u}(T)) \right\}$$
(48)

where $y_{t,x,z,u}$ denotes the solution of the Cauchy problem

$$\dot{x}(s) = F\left(s, x(s), u(s), \int_0^{+\infty} A(\tau) x(s-\tau) d\tau\right), \ t>0,$$
 with initial conditions $x(t) = x, \ x(t-s) = z(s), s>0,$

this leads to the following evolution equation for v:

$$\partial_t v(t, x, z) + \inf_{u \in K} \left\{ L(t, x, u) + \nabla_x v(t, x, z) \cdot \mathcal{F}(t, x, z, u) \right\} - \langle D_z v(t, x, z), \dot{z} \rangle = 0,$$

together with the boundary condition

$$v(T, x, z) = g(x), \ \forall (x, z) \in E.$$
