# Stability of Unit Hopf Vector Fields on Quotients of Spheres

#### Abstract

The volume of a unit vector field $V$ of a Riemannian manifold ( $M, g$ ) ( $n$ odd) is the volume of its image $V\left(M^{n}\right)$ in the unit tangent bundle endowed with the Sasaki metric. Unit Hopf vector fields, that is, unit vector fields that are tangent to the fiber of a Hopf fibration $\mathbb{S}^{n} \rightarrow \mathbb{C} P^{\frac{n-1}{2}}$ are well known to be critical for the volume functional on the round $n$-dimensional sphere $\mathbb{S}^{n}(r)$ for every radius $r>1$. Regarding the Hessian, it turns out that its positivity actually depends on the radius. Indeed, in [2], it is proven that for $n \geq 5$ there is a critical radius $r_{c}=\frac{1}{\sqrt{n-4}}$ such that Hopf vector fields are stable if and only if $r \leq r_{c}$. In this paper we consider the question of the existence of a critical radius for space forms $M^{n}(c)$ ( $n$ odd) of positive curvature $c$. These space forms are isometric quotients $\mathbb{S}^{n}(r) / \Gamma$ of round spheres and naturally carry a unit Hopf vector field which is critical for the volume functional. We prove that $r_{c}=+\infty$, unless $\Gamma$ is trivial. So, in contrast with the situation for the sphere, the Hopf field is stable on $\mathbb{S}^{n}(r) / \Gamma, \Gamma \neq\{I d\}$, whatever the radius.

## 1 Introduction and Main Results

In [7], H. Gluck and W. Ziller raised the question of finding unit vector fields of $\mathbb{S}^{2 m+1}$ which are the "best organised" ones. Precisely, they first defined a volume functional Vol on the space of unit vector fields and then asked for finding the infimum of Vol and possibly its minimizers. This volume functional is the natural one: it maps a unit vector field $V$ onto the volume of the image submanifold in the unit tangent bundle $V\left(\mathbb{S}^{2 m+1}\right) \subset T^{1} \mathbb{S}^{2 m+1}$ endowed with the Sasaki metric (the metric which canonically extends the metric of the base space to the tangent space). For $m=1$, Gluck and Ziller showed that the infimum is reached by Hopf fields, i. e. unit vector fields tangent to the fibers of a Hopf fibration $\mathbb{S}^{2 m+1} \rightarrow \mathbb{C} P^{m}$. For $m>1$, the
question revealed to be more muddled than initially expected and gave rise to a sizeable amount of work (see [4] for a survey). In particular, Hopf fields are no longer minimizers of the volume on the unit sphere $\mathbb{S}^{2 m+1}, m>1$. In $1993, \mathrm{~S}$. L. Pedersen conjectured that for $m>1$ the infimum is reached by a singular field derived from a Pontrjagin cycle [14]. This conjecture is still open. In 2004, a non-trivial lower bound for the volume is obtained by F. Brito, P. Chacón and A. Naveira [3], in an other hand the regularity of minimisers is investigated by D. Johnson and P. Smith in a sequel of articles [11],[12] and [13]. It was suspected in [6] that the radius of the base sphere could play a role and this was confirmed in [2]. Precisely, whatever the radius of $\mathbb{S}^{2 m+1}(r)$ Hopf vector fields are minimal but, as soon as $m>1$, the non-negativity of the Hessian, that is their stability, depends on the radius. In fact, for each odd-dimensional sphere $\mathbb{S}^{2 m+1}, m>1$, there exists a critical radius $r_{c}=\frac{1}{\sqrt{2 m-3}}$ such that Hopf fields are stable if and only if $r \leq r_{c}$. It was then noticed that a similar phenomenon occurs in a more general setting, namely for $K$-contact manifolds [10] (see also [15]). The goal of this article is to investigate the question of the existence of critical radius for quotients of spheres. Any space form with positive sectional curvature is a quotient of a $\mathbb{S}^{2 m+1}(r)$ by a finite fixed point free isometry subgroup $\Gamma$ of $O(2 m+2)$. It turns out that there is still (at least) a Hopf field $H_{\Gamma}$ on the quotient $\mathbb{S}^{2 m+1}(r) / \Gamma$ which remains critical for the volume functional. But something a priori unexpected occurs: the field $H_{\Gamma}$ is always stable, whatever the radius $r>0$.

Theorem 1.- Let $M=\mathbb{S}^{2 m+1}(r) / \Gamma$ be a space form with $\Gamma \neq\{e\}$, then the Hopf field $H_{\Gamma}$ is stable on $\mathbb{S}^{2 m+1}(r) / \Gamma$.

As a consequence, there is no critical radius for quotients $\mathbb{S}^{2 m+1}(r) / \Gamma, \Gamma \neq$ $\{e\}$. Technics used to prove this theorem differ from the ones of [2]. In that last article the crucial point to prove the non negativity of the Hessian for $r \leq r_{c}$ was to take advantage of the Hopf fibration to read any vector field as a Fourier serie along the fibers of the fibration. Here, our starting point is the fact that the non negativity of the Hessian of the volume is implied by the non negativity of the Hessian of a simpler functional : the energy. Given a vector field $V$, its energy is the number

E(V):=\frac{1}{2} \int_{\mathbb{S}^{2 m+1}(r)}\left(2 m+1+\|\nabla V\|^{2}\right) d v o l
$$

the relevant term $B(V):=\int_{\mathbb{S}^{2 m+1}(r)}\|\nabla V\|^{2} d v o l$ being called the bending of $V$. In constrast with the volume, the Hessian of the energy behaves homogeneously with the radius and no critical radius phenomenon can appear for it. We then observe that the stability of the energy at the Hopf field is equivalent to a certain minoration of the first eigenvalue of an elliptic
operator acting over vector fields orthogonal to the Hopf distribution. This minoration is obtained by relating the elliptic operator with the ordinary Laplacian for functions over the sphere. The key point is that the geometry of any quotient $\mathbb{S}^{2 m+1}(r) / \Gamma, \Gamma \neq\{e\}$ forces the vanishing of the constant term of the homogeneous harmonic decomposition of a vector field. That is why vector fields that give unstable directions for the Hessian of volume on spheres do not descend to the quotient.

In $\S 4$, we inspect the situation for quotients of Berger spheres. A Berger sphere $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right)$ is a sphere in which the usual metric has been modified of a factor $\mu$ in the Hopf direction (see $\S 4$ for a precise definition). In a Berger sphere, the stability of both the volume and the energy at the Hopf fields depends on $\mu$, precisely there exists $\mu_{v o l}$ (resp. $\mu_{e}$ ) such that the Hopf field is stable for the volume (resp. the energy) if and only if $\mu \leq \mu_{v o l}$ (resp. $\mu \leq \mu_{e}$ ) [6]. The numbers $\mu_{v o l}$ and $\mu_{e}$ are both equal to 1 for $\mathbb{S}^{3}$ and decrease toward zero when the dimension of the sphere increases. Once again the situation simplifies for quotients due to the fact that certain unstable directions on $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right)$ do not descend to $\left(\mathbb{S}^{2 m+1} / \Gamma, g_{\mu}\right)$.

Theorem 2 and 3.- Let $0<\mu \leq 1$ then the Hopf field $H_{\Gamma}^{\mu}$ is stable for both energy and volume on $\left(\mathbb{S}^{2 m+1} / \Gamma, g_{\mu}\right), \Gamma \neq\{i d\}, m \geq 1$. Moreover any non identically zero vector field provides an unstable direction for both energy and volume if $\mu$ is large enough.

This result is sharp in the following sense: it cannot be improved for Berger projective spaces $\left(\mathbb{R} P^{4 m-1}, g_{\mu}\right), m \geq 1$.

Proposition 4.- Let $\Gamma=\mathbb{Z}_{2}$. If $\mu>1$, the Hopf vector field of $H_{\Gamma}^{\mu}$ is unstable for both energy and volume on $\left(\mathbb{R} P^{4 m-1}, g_{\mu}\right), m \geq 1$.

## 2 Hopf Fields on Spherical Space Forms

### 2.1 Spherical Space forms

For the sake of completeness, we recall in this subsection the basic facts about spherical space forms that will be needed in the sequel of the article. Our reference is [18].

A well-known result of W. Killing and H. Hopf states that any complete connected manifold $M^{n}$ with constant positive sectional curvature is isometric to a quotient $\mathbb{S}^{n}(r) / \Gamma$ of a sphere of radius $r>0$ by a finite group
$\Gamma<O(n+1)$ of fixed point free isometries ${ }^{1}$. The free action of $\Gamma$ just means that only the identity element of $\Gamma$ has +1 as eigenvalue. If $G$ is a subgroup of $O(n+1)$ conjugate to $\Gamma\left(i . e . \quad \exists h \in O(n+1)\right.$ such that $\left.\Gamma=h G h^{-1}\right)$ then $h$ induces an isometry $\bar{h}: \mathbb{S}^{n}(r) / \Gamma \rightarrow \mathbb{S}^{n}(r) / G$ by conjugating classes. Conversely, if $\bar{h}: \mathbb{S}^{n}(r) / \Gamma \rightarrow \mathbb{S}^{n}(r) / G$ is an isometry, standard arguments of Riemannian coverings theory show that $\Gamma$ and $G$ are conjugate.

The classification problem for complete connected Riemannian manifolds of constant positive curvature was solved by G. Vincent in the late 1940s [17]. Its main conceptual technique was to view $\Gamma$ as the image of an abstract group $G$ by a fixed point free real orthogonal representation $\sigma: G \rightarrow O(n+$ 1): every complete connected Riemannian manifold $M^{n}$ of positive constant sectional curvature is isometric to a quotient

$$
\mathbb{S}^{n}(r) / \sigma(G)=\mathbb{S}^{n}(r) /\left(\sigma_{1} \oplus \ldots \oplus \sigma_{r}\right)(G)
$$

where $\sigma=\oplus_{i=1}^{r}, \sigma_{i}: G \rightarrow O\left(W_{i}\right)$ are irreducible and fixed point free and $\sum_{i=1}^{r} \operatorname{dim} W_{i}=n+1$. We then need to determine groups which admit fixed point free irreducible representations and then to classify irreductible representations of such groups. This last point is achieved with the help of the Frobenius-Schur theorem by classifying complex irreducible representations $\pi: G \rightarrow \operatorname{End}(V \otimes \mathbb{C})$. Every real representation $\sigma: G \rightarrow \operatorname{End}(V)$ induces a complex representation $\sigma^{\mathbb{C}}: G \rightarrow \operatorname{End}(V \otimes \mathbb{C})$ by $\mathbb{C}$-linear extension. Conversely, if $\bar{\pi}$ is the conjugate representation of $\pi$, then $\pi \oplus \bar{\pi}$ is equivalent to a representation $\sigma^{\mathbb{C}}$ with $\sigma$ real. ${ }^{2}$ Indeed, if $\pi(g)=X+i Y$ with $X, Y$ real matrices and if

Frobenius-Schur theorem states that for every irreducible real representation $\sigma: G \rightarrow G l(W)$ there exists an irreducible complex representation $\pi$

[^0]such that:

- either $\sigma^{\mathbb{C}}$ is equivalent to $\pi \oplus \widehat{\pi}$ with $\pi: G \rightarrow \operatorname{End}(V \otimes \mathbb{C}), V \oplus V=W$,
- either $\sigma^{\mathbb{C}}$ is equivalent to $\pi$ with $\pi: G \rightarrow \operatorname{End}(W \otimes \mathbb{C})$, then we commit an abuse of language and say that $\pi$ is equivalent to a real representation.

The classification of fixe point free irreducible complex representations $\pi$ shows that they are not equivalent to a real representation except if $G=i d$ or $\mathbb{Z}_{2}$. In other words, if $M^{n}$ is complete, connected and with positive sectional curvature then:

- either $M^{n}$ is isometric to $\mathbb{S}^{n}(r)$ or $\mathbb{R} P^{n}(r)$,
- either $n$ is odd, $M^{n}$ is isometric to $\mathbb{S}^{n}(r) / \Gamma$ with $\Gamma<U\left(\frac{n+1}{2}\right)$.

Indeed, $\Gamma=\left(\sigma_{1} \oplus \ldots \oplus \sigma_{r}\right)(G)$ with $\sigma_{i}: G \rightarrow O\left(W_{i}\right)$ and if $G \neq i d$ and $G \neq \mathbb{Z}_{2}$ then, from the Frobenius-Schur theorem, for all $g \in G$ and for all $i \in\{1, \ldots, r\}, \sigma_{i}(g)$ is of the form

$$

where $W_{i}=V_{i} \oplus V_{i}$. In particular, if $M^{2 m+1}$ is complete, connected and with positive sectional curvature then $M^{2 m+1}$ is orientable.

### 2.2 Hopf fields

Definition.- Let $M^{2 m+1}$ be a complete connected manifold with positive constant sectional curvature. We say that a unit vector field $V: M \rightarrow T^{1} M$ is a unit Hopf field on $M^{2 m+1}$ if there exists an isometry from $M^{2 m+1}$ to some $\mathbb{S}^{2 m+1}(r) / \Gamma$ such that the image of $V$ lifts to a unit Hopf vector field of $\mathbb{S}^{2 m+1}$.

Proposition 1.- Every complete connected manifold $M^{2 m+1}$ with positive constant sectional curvature admit (at least) one unit Hopf vector field.

Proof.- The result is obvious if $M^{2 m+1}$ is isometric to $\mathbb{S}^{2 m+1}(r)$. If $M^{2 m+1}$ is isometric to $\mathbb{R} P^{2 m+1}$, then the Hopf field $H(x)=J x$ on $\mathbb{S}^{2 m+1}(r) \subset$ $\left(\mathbb{R}^{2 m+2}, J\right) \approx \mathbb{C}^{m+1}$ defined a Hopf field on the quotient $\mathbb{R} P^{2 m+1}(r)$ since $H(-x)=-H(x)$. In the other cases, from the results mentioned above, $M^{2 m+1}$ is isometric to $\mathbb{S}^{2 m+1}(r) / \Gamma$ where $\Gamma<U(m+1)$. The field $H(x)=J x$ of $\mathbb{S}^{2 m+1}(r) \subset\left(\mathbb{R}^{2 m+2}, J\right)$ induces a well-defined vector field on the quotient $\mathbb{S}^{2 m+1}(r) / \Gamma$ if and only if

$$
\forall g \in \Gamma, \forall x \in \mathbb{S}^{2 m+1}(r): d \pi_{x}(H(x))=d \pi_{g(x)}(H(g(x)))
$$

where $\pi: \mathbb{S}^{2 m+1}(r) \rightarrow \mathbb{S}^{2 m+1}(r) / \Gamma$ is the Riemannian covering. Since $\pi \circ g=\pi$ we have $d \pi_{x}(H(x))=d \pi_{g(x)}(g(H(x)))$. It ensues that

$$
d \pi_{g(x)}(g(H(x)))=d \pi_{g(x)}(H(g(x))) .
$$

Since $d \pi_{x}: T_{x} \mathbb{S}^{2 m+1}(r) \rightarrow T_{\pi(x)}\left(\mathbb{S}^{2 m+1}(r) / \Gamma\right)$ is an isomorphism we deduce that
$H(g(x))=g(H(x))$ i. e. $g J=J g$ for every $g \in \Gamma$ and this last condition is fulfilled since $\Gamma<U(m+1)$.

Notation. We denote by $H_{\Gamma}$ the unit Hopf vector field on $\mathbb{S}^{2 m+1}(r) / \Gamma$ induced by the unit Hopf vector field $H(x)=J x$ of $\mathbb{S}^{2 m+1}(r) \subset\left(\mathbb{R}^{2 m+2}, J\right)$. Given an isometry $f: \mathbb{S}^{2 m+1}(r) / \Gamma \rightarrow M^{2 m+1}$ the image $f_{*} H_{\Gamma}$ is a unit Hopf field of $M^{2 m+1}$. By a slight abuse of notation, we will still denote by $H_{\Gamma}$ any vector field of $M^{2 m+1}$ of the form $f_{*} H_{\Gamma}$ for some isometry $f$.

Lemma 1.- Unit Hopf fields are minimal and harmonic.
Proof.- This is obvious since unit Hopf fields of the $\mathbb{S}^{2 m+1}(r)$ are minimal and harmonic and $\pi: \mathbb{S}^{2 m+1}(r) \rightarrow \mathbb{S}^{2 m+1}(r) / \Gamma$ is a Riemannian covering.

## 3 Bending over Sections of the Orthogonal Distribution of the Hopf Field

The key point in the proof of our main result is to obtain the following lower bound for the bending of vector fields orthogonal to $H_{\Gamma}$.

Proposition 2. - Let $V$ be a smooth vector field of $\mathbb{S}^{2 m+1}(r) / \Gamma, \Gamma \neq\{e\}$, such that at every point $\left\langle H_{\Gamma}, V\right\rangle=0$, then:

$$
\int_{\mathbb{S}^{2 m+1}(r) / \Gamma}\|\nabla V\|^{2} d v o l \geq \frac{2 m}{r^{2}} \int_{\mathbb{S}^{2 m+1}(r) / \Gamma}\|V\|^{2} d v o l
$$

Let $\Delta$ be the ordinary Laplacian on sections of $T \mathbb{S}^{2 m+1}(r)$, that is $\Delta=\nabla^{*} \nabla$ where $\nabla^{*}$ is the $L_{2}$-adjoint of $\nabla$. Given a Hopf field $H$, we denote by $\mathcal{E}=\Gamma\left(H^{\perp}\right)$ the space of sections of the orthogonal distribution to $H$ and we define an operator $L: \mathcal{E} \rightarrow \mathcal{E}$ by:

$$
L(V):=\Delta V-\langle\Delta V, H\rangle H
$$

Since $L$ is an elliptic operator, the set of its eigenvalues is countably infinite with $+\infty$ as limit point. Moreover:

$$
\begin{aligned}
\int_{\mathbb{S}^{2 m+1}(r)}\langle L(V), V\rangle d v o l & =\int_{\mathbb{S}^{2 m+1}(r)}(\langle\Delta V, V\rangle-\langle\Delta V, H\rangle\langle V, H\rangle) d v o l \\
& =\int_{\mathbb{S}^{2 m+1}(r)}\langle\Delta(V), V\rangle d v o l \\
& =\int_{\mathbb{S}^{2 m+1}(r)}\|\nabla V\|^{2} d v o l \geq 0
\end{aligned}
$$

since $\langle V, H\rangle=0$. Therefore Proposition 2 reduces to an estimation of the lowest eigenvalue of $L$. The precise computation of eigenvalues of $L$ proves to be difficult, we bypass this by introducing another operator $\bar{L}: \mathcal{E} \rightarrow \mathcal{E}$ the eigenvalues of which are easier to control. Precisely let

$$
\bar{L}(V)=\pi \circ \bar{\Delta} V
$$

where $\pi$ is the canonical projection onto the orthogonal distribution $H^{\perp}$ of H:

\pi: T \mathbb{S}^{2 m+1}(r) \rightarrow H^{\perp}
$$

and $\bar{\Delta}$ is the ordinary Laplacian on sections of the trivial bundle

$$
\left.T \mathbb{R}^{2 m+2}\right|_{\mathbb{S}^{2 m+1}(r)}=\mathbb{S}^{2 m+1}(r) \times \mathbb{R}^{2 m+2} \rightarrow \mathbb{S}^{2 m+1}(r)
$$

In particular, if $\left(E_{1}, \ldots, E_{2 m+1}\right)$ is a local orthonormal frame of $T \mathbb{S}^{2 m+1}(r)$, $\bar{\nabla}$ is the standard connection of $\mathbb{R}^{2 m+2} \supset \mathbb{S}^{2 m+1}(r)$ and $V$ is a vector field of the sphere considered as a map from $\mathbb{S}^{2 m+1}(r)$ to $\mathbb{R}^{2 m+2}$, then

$$
\bar{\Delta} V=\sum_{i=1}^{2 m+1}\left(\bar{\nabla}_{E_{i}} \bar{\nabla}_{E_{i}} V-\bar{\nabla}_{\left.\nabla_{E_{i} E_{i}} V\right) .}\right.
$$

Lemma 2. - If $V$ is a section of $H^{\perp} \rightarrow \mathbb{S}^{2 m+1}(r)$ then $L(V)=\bar{L}(V)-\frac{1}{r^{2}} V$.
Proof. - Let $\left(E_{1}, \ldots, E_{m}, J E_{1}, \ldots, J E_{m}, H\right)$ be a local orthonormal basis of $\mathbb{S}^{2 m+1}(r)$, we have:

\end{aligned}
$$

Since $\bar{\nabla}_{E_{i}} E_{i}=\nabla_{E_{i}} E_{i}+\left\langle\bar{\nabla}_{E_{i}} E_{i}, N\right\rangle=-\frac{1}{r} N$, we have

$$
\nabla_{E_{i}} \nabla_{E_{i}} V=\bar{\nabla}_{E_{i}} \bar{\nabla}_{E_{i}} V-\left\langle\bar{\nabla}_{E_{i}} \bar{\nabla}_{E_{i}} V, N\right\rangle N+\frac{1}{r^{2}}\left\langle V, E_{i}\right\rangle E_{i} .
$$

Therefore

$$
\left(\nabla_{E_{i}} \nabla_{E_{i}} V\right)^{H^{\perp}}=\bar{\nabla}_{E_{i}} \bar{\nabla}_{E_{i}} V+\frac{1}{r^{2}}\left\langle V, E_{i}\right\rangle E_{i} .
$$

It remains to deal with $\nabla_{H}\left(\nabla_{H} V\right)$, we have:

$$
\begin{aligned}
\nabla_{H} V & =\bar{\nabla}_{H} V-\left\langle\bar{\nabla}_{H} V, N\right\rangle N \\
& =\bar{\nabla}_{H} V+\frac{1}{r}\langle V, H\rangle N \\
& =\bar{\nabla}_{H} V
\end{aligned}
$$

and

$$
\begin{aligned}
\nabla_{H} \nabla_{H} V & =\bar{\nabla}_{H} \bar{\nabla}_{H} V-\left\langle\bar{\nabla}_{H} \bar{\nabla}_{H} V, N\right\rangle N \\
& \left.=\bar{\nabla}_{H} \bar{\nabla}_{H} V+\bar{\nabla}_{H} V, \bar{\nabla}_{H} N\right\rangle N \\
& =\bar{\nabla}_{H} \bar{\nabla}_{H} V+\langle V, N\rangle N \\
& =\bar{\nabla}_{H} \bar{\nabla}_{H} V .
\end{aligned}
$$

Finally, we obtain

$$
\begin{aligned}
L(V) & =-\sum_{i=1}^{2 m}\left(\bar{\nabla}_{E_{i}} \bar{\nabla}_{E_{i}} V+\frac{1}{r^{2}}\left\langle V, E_{i}\right\rangle E_{i}\right)-\bar{\nabla}_{H} \bar{\nabla}_{H} V \\
& =-\sum_{i=1}^{2 m+1} \bar{\nabla}_{E_{i}} \bar{\nabla}_{E_{i}} V-\frac{1}{r^{2}} V=\bar{L}-\frac{1}{r^{2}} V
\end{aligned}
$$

Let $\left(e_{1}, \ldots, e_{2 m+2}\right)$ be the standard basis of $\mathbb{R}^{2 m+2}$ and $V=\sum_{i=1}^{2 m+2} V_{i} e_{i}$, then a direct computation shows that

$$
\bar{\Delta} V=\sum_{i=1}^{2 m+2}\left(\Delta V_{i}\right) e_{i}
$$

where $\Delta$ is the Laplacian on functions of the sphere. The link between $\bar{L}$ and $\Delta$ is crucial to estimate the first eigenvalue of $L$ but we need an extra argument to show that this eigenvalue is not too small, $i . e$. greater or equal to $2 m$. This will be a consequence of the following lemma.

Lemma 3.- Let $\Gamma=\mathbb{Z}_{p} \simeq\left\{1, g, \ldots \ldots ., g^{p-1}\right\}$ be a non trivial cyclic group acting isometrically on $\mathbb{S}^{2 m+1}(r), p \neq 1$, and let $f \in C^{0}\left(\mathbb{S}^{2 m+1}(r)\right)$ be a continuous function equivariant for this action (i.e. $f \circ g=g \circ f$ ) then $\int_{\mathbb{S}^{2 m+1}(r)} f=0$.
Proof.- The proof is straightforward. Let $X \subset \mathbb{S}^{2 m+1}$ be a fundamental domain for the $\mathbb{Z}_{p}$-action: $X \cup g X \cup \ldots \cup g^{p-1} X=\mathbb{S}^{2 m+1}$. We have:

$$
\begin{aligned}
\int_{\mathbb{S}^{2 m+1}(r)} f & =\int_{X} f+\int_{g X} f+\ldots+\int_{g^{p-1} X} f \\
& =\int_{X} f+\int_{X} f \circ g+\ldots+\int_{X} f \circ g^{p-1}
\end{aligned}
$$

$$
\begin{aligned}
& =\int_{X} f+\int_{X} g \circ f+\ldots+\int_{X} g^{p-1} \circ f \\
& =\int_{X}\left(1+g+\ldots . g^{p-1}\right) f
\end{aligned}
$$

Since $g^{p}=1, g \neq 1$, then $1+g+\ldots . . g^{p-1}=0$ and thus $\int_{\mathbb{S}^{2 m+1}(r)} f=0$.
Proposition 3.- Let $\Gamma=\mathbb{Z}_{p}$ be a non trivial cyclic group acting isometrically on $\mathbb{S}^{2 m+1}(r)$. If $V \in \Gamma\left(H_{\Gamma}^{\perp}\right)$ descends to the quotient $\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}$ then

$$
\int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\langle\bar{\Delta} V, V\rangle d \text { vol } \geq \frac{2 m+1}{r^{2}} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\|V\|^{2} d v o l .
$$

Remark. - In that proposition $\bar{\Delta}$ must be understood as an operator of the space $\mathcal{E}_{\Gamma}$ of sections of the distribution $H_{\Gamma}^{\perp}$ over $\mathbb{S}^{2 m+1}(r) / \Gamma$. Note that $\mathcal{E}_{\Gamma}$ can be identified with the space of vector fields of $\mathbb{S}^{2 m+1}(r)$ that are both equivariant for the action of $\Gamma$ and orthogonal to the distribution $H$. This last space is stable by $L$ and $\bar{L}$, we denote by $L_{\Gamma}$ and $\bar{L}_{\Gamma}$ the restriction of these operators on that space. Of course, we can also consider these new operators $L_{\Gamma}$ and $\bar{L}_{\Gamma}$ as operators on $\mathcal{E}_{\Gamma}$.

Proof.- From the density of polynomial functions in $C^{0}\left(\mathbb{S}^{n}\right)$, it is enough to show the proposition in the case where the components ( $V^{1}, V^{2}, \ldots, V^{2 m+2}$ ) of $V=\sum_{i=1}^{2 m+2} V^{i} e_{i}$ are polynomial functions (we see $V$ as an equivariant vector field of $\mathbb{S}^{2 m+1}(r) \subset \mathbb{R}^{2 m+2}$, thus defining a map $\left.V: \mathbb{S}^{2 m+1}(r) \rightarrow \mathbb{R}^{2 m+2}\right)$. Let $k \geq 0$, we set:

$$
\begin{aligned}
\mathcal{P}_{\leq k}:= & \left\{\text { restrictions }\left.P\right|_{\mathbb{S}^{2 m+1}(r)} \text { of polynomial functions } P: \mathbb{R}^{2 m+2} \rightarrow \mathbb{R}\right. \\
& \text { of degree } \leq k\}
\end{aligned}
$$

and
$\mathcal{H}_{k}:=\left\{\right.$ restrictions $\left.P\right|_{\mathbb{S}^{2 m+1}(r)}$ of homogeneous harmonic polynomial functions $P: \mathbb{R}^{2 m+2} \rightarrow \mathbb{R}$ of degree $\left.k\right\}$.

It is well-known (see [8] for instance) that homogeneous harmonic polynomial functions are eigenvector for the Laplacian on the sphere $\mathbb{S}^{2 m+1}(r)$ :

\forall P \in \mathcal{H}_{k}, \quad \Delta P=\lambda_{k} P \quad \text { with } \lambda_{k}=\frac{k(k+2 m)}{r^{2}} .
$$

Moreover $\mathcal{P}_{\leq k}$ admits an orthogonal decomposition $\mathcal{P}_{\leq k}=\bigoplus_{j=0}^{k} \mathcal{H}_{j}$, hence $V$ has an orthogonal decomposition:

V=V_{0}+V_{1}+\ldots+V_{k}
$$

with

$$
V_{j}=\left(\begin{array}{c}
V_{j}^{1} \\
\cdot \\
\cdot \\
\cdot \\
V_{j}^{2 m+2}
\end{array}\right) \quad j \in\{0, \ldots, k\} \quad V_{j} \in \overbrace{\mathcal{H}_{j} \times \ldots \times \mathcal{H}_{j}}^{(2 m+2) \text { times }}
$$

It ensues that

$$
\bar{\Delta} V=\lambda_{1} V_{1}+\ldots+\lambda_{k} V_{k}
$$

since $\lambda_{0}=0$. From Lemma 3, and since $V$ descends to the quotient $\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}$, we have:

\int_{\mathbb{S}^{2 m+1}(r)} V d v o l=0 \in \mathbb{R}^{2 m+2}
$$

For $j>0$ we have $\lambda_{j} \neq 0$ and therefore:

\begin{aligned}
\int_{\mathbb{S}^{2 m+1}(r)} V_{j} d v o l & =\frac{1}{\lambda_{j}} \int_{\mathbb{S}^{2 m+1}(r)} \lambda_{j} V_{j} d \text { vol } \\
& =\frac{1}{\lambda_{j}} \int_{\mathbb{S}^{2 m+1}(r)} \bar{\Delta} V_{j} d v o l=0
\end{aligned}
$$

since $\mathbb{S}^{2 m+1}(r)$ is compact. Thus the relation $\int_{\mathbb{S}^{2 m+1}(r)} V d v o l=0$ implies that $\int_{\mathbb{S}^{2 m+1}(r)} V_{0} d v o l=0$ which in turn implies that $V_{0}=0$ since $\mathcal{H}_{0}$ is the space of constant functions. We have:

$$
\begin{aligned}
\int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\langle\bar{\Delta} V, V\rangle d v o l & =\sum_{j=1}^{k} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}} \lambda_{j}\left\|V_{j}\right\|^{2} d v o l \\
& \geq \lambda_{1} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\left(\sum_{j=1}^{k}\left\|V_{j}\right\|^{2}\right) d v o l \\
& \geq \lambda_{1} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\|V\|^{2} d v o l .
\end{aligned}
$$

Since $\lambda_{1}=\frac{2 m+1}{r^{2}}$ we obtain the proposition.
The proof of Proposition 2 now follows easily from Proposition 1 since:

\int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\langle L(V), V\rangle d v o l & =\int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\left(\langle\bar{L}(V), V\rangle-\frac{1}{r^{2}}\|V\|^{2}\right) d v o l \\
& =\int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\left(\langle\bar{\Delta}(V), V\rangle-\frac{1}{r^{2}}\|V\|^{2}\right) d v o l \\
& \geq\left(\lambda_{1}-\frac{1}{r^{2}}\right) \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\|V\|^{2} d v o l \\
& \geq \frac{2 m}{r^{2}} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\|V\|^{2} d v o l .
\end{aligned}
$$

## Proof of Theorem 1

Theorem 1.- Let $M=\mathbb{S}^{2 m+1}(r) / \Gamma$ be a space form with $\Gamma \neq\{e\}$, then the Hopf field $H_{\Gamma}$ is stable on $\mathbb{S}^{2 m+1}(r) / \Gamma$ for both energy and volume.

Proof.- It is enough to prove the theorem for quotients $\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}, p>1$. Indeed, if $\Gamma \neq\{e\}$, a careful inspection of the possible $\Gamma$ in the classification reveals that each of them has a normal cyclic subgroup $\mathbb{Z}_{p}$ with $p>1$ (cf. Wolf [18], pp. 198-218). The quotient manifold $\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}$ (with the induced metric) is a Riemannian covering of $\mathbb{S}^{2 m+1}(r) / \Gamma$, therefore the stability of the Hopf field on $\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}$ implies the stability of the Hopf field on $\mathbb{S}^{2 m+1}(r) / \Gamma$.

Energy.- Let $V \in E_{\Gamma}$, from Lemma 10 of [6] the Hessian of the energy functional $E$ at $H_{\Gamma}$ has the following expression:

$$
(\text { Hess } E)_{H_{\Gamma}}(V)=\int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\left(-\frac{2 m}{r^{2}}\|V\|^{2}+\|\nabla V\|^{2}\right) d v o l .
$$

From Proposition 2 we have:

$$
\int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\|\nabla V\|^{2} d v o l \geq \frac{2 m}{r^{2}} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}\|V\|^{2} d v o l
$$

thus $(\text { Hess } E)_{H_{\Gamma}}(V) \geq 0$ and the Hopf field $H_{\Gamma}$ is stable for $E$ on $\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}$.
Volume.- Let $V \in E_{\Gamma}$, the volume of $V$ is given by

$$
\operatorname{Vol}(V):=\frac{1}{2} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}} \sqrt{\operatorname{det} L_{V}} d v o l
$$

where $L_{V}=I d+{ }^{T} \nabla V \circ \nabla V$. From the expression of the Hessian of the volume functional Vol at $H_{\Gamma}$ given in the Main Proposition of [2] we deduce:

$$
\begin{aligned}
(\text { Hess Vol })_{H_{\Gamma}}(V)=\left(1+\frac{1}{r^{2}}\right)^{m-2} \int_{\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}}( & -\frac{2 m}{r^{2}}\|V\|^{2}+\|\nabla V\|^{2} \\
& \left.+\frac{1}{r^{2}}\left\|\nabla_{H_{\Gamma}} V+\frac{1}{r} J V\right\|^{2}\right) d v o l
\end{aligned}
$$

hence

$$
(\text { Hess Vol })_{H_{\Gamma}}(V) \geq\left(1+\frac{1}{r^{2}}\right)^{m-2}(\text { Hess } E)_{H_{\Gamma}}(V)
$$

Therefore the Hopf field $H_{\Gamma}$ is stable for $V o l$ on $\mathbb{S}^{2 m+1}(r) / \mathbb{Z}_{p}$.

## 4 Energy, Volume and Quotients of Berger Spheres

### 4.1 Hopf Fields on Berger Spheres

Recall that the Berger metric on $\mathbb{S}^{2 m+1}(1) \subset\left(\mathbb{R}^{2 m+2},\langle\rangle,\right)$ is the oneparameter family of metrics $\left(g_{\mu}\right)_{\mu>0}$ defined by:

$$
\left.g_{\mu}\right|_{\mathcal{H}}=\mu\langle,\rangle,\left.\quad g_{\mu}\right|_{\mathcal{H}^{\perp}}=\langle,\rangle \quad \text { and } \quad g_{\mu}\left(\mathcal{H}, \mathcal{H}^{\perp}\right)=0
$$

where $\mathcal{H}$ denotes the distribution spanned by $H(p)=J p$. The unit vector field $H^{\mu}(p)=\frac{1}{\sqrt{\mu}} J p$ is called the Hopf field of the Berger sphere $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right)$. Let $\Gamma$ be a finite subgroup of $U(m+1)$, the component of the isometry group of the Berger sphere $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right), \mu \neq 1$, which contains the identity. We will always assume that $\Gamma$ is finite and acts freely so that $\mathbb{S}^{2 m+1} / \Gamma$ is a manifold locally isometric to $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right)$ and that the Hopf field $H^{\mu}$ descends to a "Hopf vector field" $H_{\Gamma}^{\mu}$ on the quotient. In [5], it is shown that the Hopf field $H^{\mu}$ is harmonic and minimal on $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right)$, it ensues that $H_{\Gamma}^{\mu}$ is itself harmonic and minimal.

### 4.2 Stability for $0<\mu \leq 1$

Theorem 2.- Let $0<\mu \leq 1$ then the Hopf field $H_{\Gamma}^{\mu}$ is stable for both energy and volume on $\left(\mathbb{S}^{2 m+1} / \Gamma, g_{\mu}\right), \Gamma \neq\{i d\}, m \geq 1$.

Remark.- The case $m=1$ of this theorem follows from the following result of [5]: Hopf fields minimise both energy and volume in $\left(\mathbb{S}^{3}, g_{\mu}\right)$ if $\mu \leq 1$.

Proof.- The proof of this theorem is similar to the one of Theorem 1 but more involved. In particular it is enough to prove it only for $\Gamma=\mathbb{Z}_{p}, p>1$. We just give the main steps.

STEP 1: Notations and a first minoration.- We denote by $\nabla^{\mu}$ the Levi-Civita connection of $g_{\mu}$, it is related to the Levi-Civita connection $\nabla$ of the standard metric of the sphere by the following relations (see. [5]):

$$
\nabla_{H}^{\mu} X=\nabla_{H} X+(\mu-1) \nabla_{X} H, \quad \nabla_{X}^{\mu} H=\mu \nabla_{X} H \quad \text { and } \quad \nabla_{X}^{\mu} Y=\nabla_{X} Y
$$

for every $X, Y$ in $\mathcal{H}^{\perp}$. We denote indifferently by $\Delta^{\mu}$ the ordinary Laplacian on functions or vector fields of $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right)$. If $\left(E_{1}, \ldots, E_{2 m+1}\right)$ is a local $g_{\mu}$-orthonormal frame and $V$ a vector field we have:

$$
\Delta^{\mu} V=\sum_{i=1}^{2 m+1}\left(\nabla_{E_{i}}^{\mu} \nabla_{E_{i}}^{\mu} V-\nabla_{\nabla_{E_{i}}^{\mu} E_{i}}^{\mu} V\right)
$$

This Laplacian on functions is studied in [1] (see also [16]). From these papers it is easily deduced that the first non zero eigenvalue of $\Delta^{\mu}$ is $\lambda_{1}^{\mu}=$
$2 m+\frac{1}{\mu}$. We also denote by $\bar{\Delta}^{\mu}$ the ordinary Laplacian on the trivial bundle over $\left(\mathbb{S}^{2 m+1}, g_{\mu}\right)$ with fiber $\mathbb{R}^{2 m+2}$ :

$$
\bar{\Delta}^{\mu} V=\sum_{i=1}^{2 m+1}\left(\bar{\nabla}_{E_{i}} \bar{\nabla}_{E_{i}} V-\bar{\nabla}_{\nabla_{E_{i}}^{\mu} E_{i}} V\right)
$$

As before, $\bar{\nabla}$ denotes the usual connection of $\mathbb{R}^{2 m+2}$. In particular, if $\left(e_{1}, \ldots, e_{2 m+2}\right)$ is the standard frame of $\mathbb{R}^{2 m+2}$ and $V=\sum_{i}^{2 m+2} V_{i} e_{i}$ then:

$$
\bar{\Delta}^{\mu} V=\sum_{i}^{2 m+2}\left(\Delta^{\mu} V_{i}\right) e_{i}
$$

Arguments similar to those seen above show that

$$
\int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}} g_{\mu}\left(\bar{\Delta}^{\mu} V, V\right) d v_{g_{\mu}} \geq\left(2 m+\frac{1}{\mu}\right) \int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}}\|V\|^{2} d v_{g_{\mu}}
$$

with $p>1$.

STEP 2.- In that step we prove that

$$
\int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}}\left\|\nabla^{\mu} V\right\|_{\mu}^{2} d v_{g_{\mu}} \geq C(\mu, m) \int_{\mathbb{S}^{2} m+1} \mathbb{Z}_{p}\|V\|^{2} d v_{g_{\mu}}
$$

with

$$
C(\mu, m)=\frac{2 m^{2} \mu+(1-\mu)(2+\mu+2 m-2 m \mu)}{m \mu-\mu+1}
$$

if $0<\mu \leq 1$. For every $V \in E$ we put:

$$
L^{\mu}(V)=\pi \circ \Delta^{\mu} V \quad \text { and } \quad \bar{L}^{\mu}(V)=\pi \circ \bar{\Delta}^{\mu} V
$$

where $\pi$ is the orthogonal projection $T \mathbb{S}^{2 m+1} \rightarrow \mathcal{H}^{\perp}$. A computation yields to:

$$
L^{\mu}(V)=\bar{L}^{\mu}(V)+\frac{2 \mu^{2}-4 \mu+1}{\mu} V-\frac{2(\mu-1)}{\mu} J \nabla_{H_{\Gamma}} V
$$

From this:

$$
\begin{align*}
\int_{\mathbb{S}^{2} m+1} g_{\mu}\left(L^{\mu}(V), V\right) d v_{g_{\mu}}= & \int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}}\left(g_{\mu}\left(\bar{L}^{\mu}(V), V\right)+\frac{2 \mu^{2}-4 \mu+1}{\mu}\|V\|^{2}\right) d v_{g_{\mu}} \\
& +\frac{2(\mu-1)}{\sqrt{\mu}} \int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}} g_{\mu}\left(\nabla_{H_{\Gamma}} V, J V\right) d v_{g_{\mu}} \tag{*}
\end{align*}
$$

The presence of the last term introduces a technical difficulty. Using the relation between $\nabla$ and $\nabla^{\mu}$ we can write:

$$
\left.\begin{array}{rl}
\frac{2(\mu-1)}{\sqrt{\mu}} \int_{\mathbb{S}^{2} m+1} g_{\mu}\left(\nabla_{\mathbb{Z}_{p}}\right. \\
\left.H_{\Gamma} V, J V\right) d v_{g_{\mu}}= & \frac{2(\mu-1)}{\sqrt{\mu}} \int_{\mathbb{S}^{2} m+1} g_{\mu}\left(\nabla_{\mathbb{Z}_{p}}^{\mu}\right. \\
& -\frac{2(\mu-1)^{2}}{\mu} \int_{\mathbb{S}^{2} m+1} / \mathbb{Z}_{p}
\end{array}\|V\|^{2} d v_{g_{\mu}} . J V\right) d v_{g_{\mu}} .
$$

And in [5], it is shown that:

$$
\begin{aligned}
& \frac{-2(1-\mu)}{\sqrt{\mu}} \int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}} g_{\mu}\left(\nabla_{H_{\Gamma}^{\mu}}^{\mu} V, J V\right) d v_{g_{\mu}}= \frac{1-\mu}{m \mu} \int_{\mathbb{S}^{2} m+1}\left(\| \mathbb{Z}_{p}\right. \\
&\left(\nabla_{\Gamma}^{\mu} V\left\|_{\mu}^{2}-\right\| \nabla^{\mu} V \|_{\mu}^{2}\right. \\
&+\frac{1}{2}\left\|\pi \circ D^{\mathbb{C}} V\right\|_{\mu, \mathcal{H}^{\perp}}^{2} \\
&+(2+\mu-2 m \mu\left.+2 m)\|V\|^{2}\right) d v_{g_{\mu}}
\end{aligned}
$$

where $D^{\mathbb{C}} V$ denotes the operator $D_{X}^{\mathbb{C}} V=\bar{\nabla}_{J X} V-J \bar{\nabla}_{X} V$ and the norm is taken on the orthogonal distribution $\mathcal{H}^{\perp}$. Thus, in one hand we have (we assume $0<\mu \leq 1$ ):

$$
\begin{gathered}
\frac{-2(1-\mu)}{\sqrt{\mu}} \int_{\mathbb{S}^{2} m+1 / \mathbb{Z}_{p}} g_{\mu}\left(\nabla_{H_{\Gamma}^{\mu}}^{\mu} V, J V\right) d v_{g_{\mu}} \geq \\
\frac{1-\mu}{m \mu} \int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}}\left((2+\mu-2 m \mu+2 m)\|V\|^{2}-\left\|\nabla^{\mu} V\right\|_{\mu}^{2}\right) d v_{g_{\mu}} .
\end{gathered}
$$

In an other hand, from Step 1:

$$
\int_{\mathbb{S}^{2 m+1} / \mathbb{Z}_{p}} g_{\mu}\left(\bar{L}^{\mu} V, V\right) d v_{g_{\mu}} \geq\left(2 m+\frac{1}{\mu}\right) \int_{\mathbb{S}^{2} m+1 / \mathbb{Z}_{p}}\|V\|^{2} d v_{g_{\mu}} .
$$

Putting these together in the relation (*) we obtain

$$
\int_{\mathbb{S}^{2} m+1 / \mathbb{Z}_{p}} g_{\mu}\left(L^{\mu} V, V\right) d v_{g_{\mu}} \geq C(\mu, m) \int_{\mathbb{S}^{2} m+1 / \mathbb{Z}_{p}}\|V\|^{2} d v_{g_{\mu}}
$$

STEP 3: Energy.- Let $\Gamma=\mathbb{Z}_{p}$, since $0<\mu \leq 1$ we have:

$$
\begin{aligned}
(\text { Hess } E)_{H_{\Gamma}^{\mu}}(V) & =\int_{\mathbb{S}^{2 m+1} / \Gamma}\left(-2 m \mu\|V\|^{2}+\left\|\nabla^{\mu} V\right\|_{\mu}^{2}\right) d v_{g_{\mu}} \\
& \geq(1-\mu) \frac{2 m+2 m \mu(m-2)+\mu+2}{m \mu-\mu+1} \int_{\mathbb{S}^{2} m+1 / \Gamma}\|V\|^{2} d v_{g_{\mu}} \\
& \geq 0 .
\end{aligned}
$$

Hence the stability for $E$ of the Hopf field $H_{\Gamma}^{\mu}$ on $\mathbb{S}^{2 m+1} / \Gamma$ for $0<\mu \leq 1$ and $m \geq 1$.

STEP 4: Volume.- Since $0<\mu \leq 1$ we have:

$$
\begin{aligned}
(\text { Hess Vol })_{H_{\Gamma}^{\mu}}(V)= & (1+\mu)^{m-2} \int_{\mathbb{S}^{2} m+1 / \Gamma}\left(\left\|\nabla^{\mu} V\right\|_{\mu}^{2}+\mu\left\|\nabla_{H_{\Gamma}^{\mu}}^{\mu} V+\sqrt{\mu} J V\right\|_{\mu}^{2}\right. \\
& \left.+\mu(2-2 m \mu-2 \mu)\|V\|^{2}\right) d v_{g_{\mu}} \\
\geq & (1+\mu)^{m-2} \int_{\mathbb{S}^{2} m+1 / \Gamma}\left(\left\|\nabla_{\mu}^{\mu} V\right\|_{\mu}^{2}+\mu(2-2 m \mu-2 \mu)\|V\|^{2}\right) d v_{g_{\mu}} \\
\geq & C_{1}(\mu, m) \int_{\mathbb{S}^{2} m+1 / \Gamma}\|V\|^{2} d v_{g_{\mu}} \geq 0
\end{aligned}
$$

where

$$
C_{1}(\mu, m)=(1+\mu)^{m-2}(1-\mu) \frac{2 \mu m^{2}(1+\mu)+2(\mu+m)(1-\mu)+\mu+2}{m \mu-\mu+1} .
$$

Hence the stability for $V o l$ of the Hopf field $H_{\Gamma}^{\mu}$ on $\mathbb{S}^{2 m+1} / \Gamma$ for $0<\mu \leq 1$ and $m \geq 1$.

### 4.3 Unstability for Large $\mu$

Theorem 3.- Let $m>1$. Every non identically zero vector field $V$ in the orthogonal distribution $\mathcal{H}^{\perp}$ gives an unstable direction of the Hopf field $H_{\Gamma}^{\mu}$ in $\left(\mathbb{S}^{2 m+1} / \Gamma, g_{\mu}\right)$ for both energy and volume $H_{\Gamma}^{\mu}$ provided $\mu$ is large enough. In particular these two functionals are unstable at $H_{\Gamma}^{\mu}$ for large $\mu$.

Proof.- Let $V \in \Gamma\left(\mathcal{H}^{\perp}\right)$ be a non zero vector field. Theorem 3 follows from the expansions in $\mu$ of the Hessians (Hess E) $H_{H_{\Gamma}^{\mu}}(V)$ and (Hess Vol) $)_{H_{\Gamma}^{\mu}}(V)$ since the coefficients of the leading terms when $\mu$ is large are negative. Here are some details.

The point is, in the expressions of the two Hessians, to get rid of the $\mu$ in the $\|\cdot\|_{\mu}$ 's and in $H_{\Gamma}^{\mu}$. We have:

$$
\begin{aligned}
\left\|\nabla^{\mu} V\right\|_{\mu}^{2}= & \sum_{i=1}^{2 m}\left\|\nabla_{E_{i}}^{\mu} V\right\|_{\mu}^{2}+\left\|\nabla_{H_{\Gamma}^{\mu}}^{\mu} V\right\|_{\mu}^{2} \\
= & \sum_{i, j}^{2 m}\left\langle\nabla_{E_{i}} V, E_{j}\right\rangle^{2}+\mu\|V\|^{2}+\left\|\nabla_{H_{\Gamma}^{\mu}}^{\mu} V\right\|^{2} \\
= & \sum_{i, j=1}^{2 m}\left\langle\nabla_{E_{i}} V, E_{j}\right\rangle^{2}-2\|V\|^{2}+2\left\langle\nabla_{H_{\Gamma}} V, J V\right\rangle+2 \mu\|V\|^{2} \\
& +\frac{1}{\mu}\left(\left\|\nabla_{H_{\Gamma}} V\right\|^{2}+\|V\|^{2}-2\left\langle\nabla_{H_{\Gamma}} V, J V\right\rangle\right) .
\end{aligned}
$$

Substituing in the expression of the Hessian of $E$ at $H_{\Gamma}^{\mu}$, we obtain:

$$
\begin{aligned}
(\text { Hess } E)_{H_{\Gamma}^{\mu}}(V) & =\int_{\mathbb{S}^{2 m+1}}\left(2 \mu(1-m)\|V\|^{2}+\frac{1}{\mu}\left\|\nabla_{H_{\Gamma}} V\right\|-J V \|^{2}\right. \\
& \left.+\sum_{i, j=1}^{2 m}\left\langle\nabla_{E_{i}} V, E_{j}\right\rangle^{2}-2\|V\|^{2}+2\left\langle\nabla_{H_{\Gamma}} V, J V\right\rangle\right) d v_{g_{\mu}}
\end{aligned}
$$

If $m \neq 1$, the leading term for $\mu$ large is

$$
\int_{\mathbb{S}^{2} m+1} 2 \mu(1-m)\|V\|^{2} d v_{g_{\mu}}
$$

which is negative if $m>1$, hence the unstability of $E$ at $H_{\Gamma}^{\mu}$ is $\mu$ is large enough. For the volume we have:

$$
\begin{aligned}
(\text { Hess Vol })_{H_{\Gamma}^{\mu}}(V)= & (1+\mu)^{m-2} \int_{\mathbb{S}^{2} m+1}\left(\left\|\nabla^{\mu} V\right\|_{\mu}^{2}+\mu\left\|\nabla_{H_{\Gamma}^{\mu}}^{\mu} V+\sqrt{\mu} J V\right\|_{\mu}^{2}\right. \\
& \left.+\mu(2-2 m \mu-2 \mu)\|V\|_{\mu}^{2}\right) d v_{g_{\mu}} .
\end{aligned}
$$

Using the relation $\nabla_{H_{\Gamma}}^{\mu} V=\nabla_{H_{\Gamma}} V+(\mu-1) \nabla_{V} H_{\Gamma}$, we obtain

$$
\begin{aligned}
\left\|\nabla_{H_{\Gamma}^{\mu}}^{\mu} V+\sqrt{\mu} J V\right\|_{\mu}^{2}= & \frac{1}{\mu}\left\|\nabla_{H_{\Gamma}}^{\mu} V\right\|^{2}+\mu\|V\|^{2}+2\left\langle\nabla_{H_{\Gamma}}^{\mu} V, J V\right\rangle \\
= & \frac{1}{\mu}\left(\left\|\nabla_{H_{\Gamma}} V\right\|^{2}+\|V\|^{2}-2\left\langle\nabla_{H_{\Gamma}} V, J V\right\rangle\right) \\
& +4 \mu\|V\|^{2}-4\|V\|^{2}+4\left\langle\nabla_{H_{\Gamma}} V, J V\right\rangle
\end{aligned}
$$

It ensues that

$$
\begin{aligned}
(\text { Hess Vol })_{H_{\Gamma}^{\mu}}(V)= & (1+\mu)^{m-2} \int_{\mathbb{S}^{2 m+1}}\left(2 \mu^{2}(1-m)\|V\|^{2}+\frac{1}{\mu}\left\|\nabla_{H_{\Gamma}} V\right\|^{2}\right. \\
& \left.-\|J V\|^{2}+4 \mu\left\langle\nabla_{H_{\Gamma}} V, J V\right\rangle+\left\|\nabla_{H_{\Gamma}} V\right\|^{2}\right) d v_{g_{\mu}} .
\end{aligned}
$$

If $m>1$, the leading term for $\mu$ large is

$$
(1+\mu)^{m-2} \int_{\mathbb{S}^{2} m+1} 2 \mu^{2}(1-m)\|V\|^{2} d v_{g_{\mu}}
$$

hence the unstability of $V o l$ at $H_{\Gamma}^{\mu}$ for large $\mu$.

### 4.4 Critical Radii for Berger Projective Spaces

In this subsection we completely solve the stability question for $\Gamma=\mathbb{Z}_{2}$ in dimension $4 m-1$, that is for Berger Projective Spaces $\left(\mathbb{R} P^{4 m-1}, g_{\mu}\right)$, $\mu>0$ et $m \geq 1$. From theorem 3 we already know that, if $0<\mu \leq 1$, the Hopf field $H_{\Gamma}^{\mu}$ is stable for both energy and volume on $\left(\mathbb{R} P^{4 m-1}, g_{\mu}\right), m \geq 1$.

Proposition 4.- Let $\Gamma=\mathbb{Z}_{2}$. If $\mu>1$, the Hopf vector field $H_{\Gamma}^{\mu}$ is unstable for both energy and volume on $\left(\mathbb{R} P^{4 m-1}, g_{\mu}\right), m \geq 1$.

Proof.- Consider $\mathbb{S}^{4 m-1}(1) \subset \mathbb{H}^{m}$ as the hypersphere of the $m$-th Cartesian power of the quaternionic field $\mathbb{H}=\operatorname{Span}(1, i, j, k)$. Let $J_{1}$ be the complex structure of $\mathbb{R}^{4 m}=\mathbb{H}^{m}$ induced by the multiplication by $j$. We define a unit vector field $V$ of $\left(\mathbb{S}^{4 m-1}(1), g_{\mu}\right)$ orthogonal to $H$ by putting

$$
\forall p \in \mathbb{S}^{4 m-1}(1), \quad V(p)=J_{1} p
$$

This field obviously descends to the quotient $\left(\mathbb{R} P^{4 m-1}, g_{\mu}\right)$. If $m>1$ a direct computation then shows:

$$
\begin{aligned}
& (\text { Hess } E)_{H_{\Gamma}^{\mu}}(V)=\frac{4}{\sqrt{\mu}}(1-m)(\mu-1)\left(\mu+\frac{1}{m-1}\right) \text { vol }_{m} \\
& (\text { Hess } V o l)_{H_{\Gamma}^{\mu}}(V)=\frac{4}{\sqrt{\mu}}(1+\mu)^{2 m-3}(1-m)(\mu-1)(\mu+1)\left(\mu+\frac{1}{m-1}\right) \text { vol }_{m}
\end{aligned}
$$

where $\operatorname{vol}_{m}$ stands for the volume of $\mathbb{S}^{4 m-1}(1)$ with the round metric. If $\mu>1$ and $m>1$ these expressions are negative.

If $m=1$ the instability of $H^{\mu}$ over $\left(\mathbb{S}^{3}, g_{\mu}\right), \mu>1$, is also obtained in the direction given by $V(p)=J_{1} p$. The computations essentially reduce to the ones already done in [5].
