# A NOTE ON UNIQUENESS OF ENTROPY SOLUTIONS TO DEGENERATE PARABOLIC EQUATIONS IN $\mathbb{R}^N$ .

ABSTRACT. We study the Cauchy problem in  $\mathbb{R}^N$  for the parabolic equation  $u_t + \operatorname{div} F(u) = \Delta \varphi(u)$ , which can degenerate into a hyperbolic equation for some intervals of values of u. In the context of conservation laws (the case  $\varphi \equiv 0$ ), it is known that an entropy solution can be non-unique when F' has strong singularities. We show the uniqueness of an entropy solution to the general parabolic problem for all  $L^\infty$  initial datum, under the isotropic condition on the flux F known for conservation laws. The only assumption on the diffusion term is that  $\varphi$  is a non-decreasing continuous function.

#### 1. INTRODUCTION

Consider the convection-diffusion problem

(1) 
$$u_t + \operatorname{div} F(u) - \Delta \varphi(u) = f \quad \text{in } (0,T) \times \mathbb{R}^N, \quad u|_{t=0} = u_0$$

with a source f measurable on  $(0,T) \times \mathbb{R}^N$ , with  $\int_0^T ||f(t,\cdot)||_{L^{\infty}} dt < +\infty$  and an initial datum  $u_0 \in L^{\infty}(\mathbb{R}^N)$ . Here  $F = (F_1, \ldots, F_N) : \mathbb{R} \mapsto \mathbb{R}^N$  is assumed merely continuous (a quantitative continuity assumption on F will be imposed in the sequel), and  $\varphi : \mathbb{R} \mapsto \mathbb{R}$  is a continuous non-decreasing function.

Degenerate and non-degenerate problems of the kind (1), often investigated under the local Lipschitz continuity assumption on  $\varphi$  and F, appear in various phisical contexts, including e.g. flows and sedimentation in porous media. Mathematical treatment of these problems was boosted some ten years ago by the introduction of the adequate notion of entropy solution (see Carrillo [8]).

Indeed, the framework (1) includes conservation laws as a particular case. It is well known that in general, classical solutions of (1) may not exist; and that a weak solution in the sense of distributions may not be unique. The standard way to fix this problem is to work with the socalled entropy solutions (see Kruzhkov [9] for the case of conservation laws, and Carrillo [8] for the adaptation of this notion to the case of a degenerate elliptic-parabolic-hyperbolic equation, of which (1) is a particular case). The classical result of Kruzhkov establishes uniqueness of an entropy solution (together with the property of finite domain of dependence on initial data) for the case where  $\varphi \equiv 0$  and F is locally Lipschitz continuous. When the Lipschitz continuity assumption is dropped, uniqueness of entropy solutions for a conservation law can be lost (see the works [16, 13, 10, 14] of Kruzhkov and Panov). The effect of non-uniqueness is

closely connected to the property of "infinite speed of propagation", which arises when  $\ F'$  is unbounded.

This is the goal of this note to investigate the question of uniqueness of entropy solutions of (1) for a general nonlinearity  $\varphi$  in the diffusion term. Technically, the problem amounts to the difficulty of exploiting the so-called Kato inequality

(2) 
$$(u-\hat{u})_t^+ + \operatorname{div}\left(\operatorname{sign}^+(u-\hat{u})(F(u)-F(\hat{u})\right)$$
  
 $\leq \Delta(\varphi(u)-\varphi(\hat{u}))^+ + (f-\hat{f})^+ \quad \text{in } \mathcal{D}'([0,T)\times\mathbb{R}^N);$ 

here  $u, \hat{u}$  are two entropy solutions of (1) corresponding to source terms  $f, \hat{f}$ . Formally, if we let the test function in (2) converge to zero, we get the inequality

$$\frac{d}{dt} \int_{\mathbb{R}^N} (u - \hat{u})^+(t) \le \int_{\mathbb{R}^N} (f - \hat{f})^+ \quad \text{in } \mathcal{D}'([0, T)) \ .$$

which implies uniqueness of an entropy solution. Even if  $u - \hat{u} \in L^{\infty}(0, T; L^{1}(\mathbb{R}^{N}))$ , a too slow decrease of  $|F(u) - F(\hat{u})|$  as  $|x| \to \infty$  could be an obstacle to this formal reasoning. In fact, the issue of uniqueness of  $L^{1} \cap L^{\infty}$  solutions for the conservation law  $u_{t} + \operatorname{div} F(u) = 0, u|_{t=0} = u_{0}$  is not yet clearly understood; see [2] for a discussion of the relevancy of known conditions.

For the case  $\varphi \equiv 0$  and  $L^{\infty}$  entropy solutions, sufficient uniqueness conditions for (1) in terms of the moduli of continuity of F were first formulated by Kruzhkov and Hil'debrand ([12]) (after that Bénilan ([5] obtained the same condition for mild solutions in  $L^1$ ). Roughly speaking, the conditions of [5, 12] (see also [11]) amount to the Hölder continuity of F of order  $\alpha = 1 - \frac{1}{N}$ . This condition is "isotropic": the possibility that some of the components  $F_1, \ldots, F_N$  of F may have a "better" modulus of continuity then the vector-function F is not exploited. This contrasts with the following "anisotropic" assumption

(3) 
$$\liminf_{r\downarrow 0} \frac{\prod_{i=1}^{N} \omega_i(r)}{r^{N-1}} < +\infty$$

due to Kruzhkov and Panov ([13, 16]); here for i = 1, ..., N,  $\omega_i : \mathbb{R}^+ \to \mathbb{R}^+$  is a modulus of continuity of  $F_i$  on the interval [-M, M] containing the values of u. Assumption (3) restricts the behaviour of the moduli of continuity  $\omega_i(r)$  of  $F_i$  at r = 0. Assumption (3) is also sufficient for the uniqueness of entropy solutions of a scalar conservation law. A sharper condition is given in [14]. Notice that for the  $L^1 \cap L^\infty$  data, sufficient uniqueness conditions of a completely different nature were found by Bénilan and Kruzhkov in [6] (see also [2]).

In [15], together with Touré the second author of the present paper proved uniqueness of an entropy solution to the equation (1) upon replacing  $\omega_i(r)$  in (3) with  $(\omega_i(r) + (r\omega_{\varphi}(r))^{1/2})$ ; here  $\omega_{\varphi} : \mathbb{R}^+ \to \mathbb{R}^+$  is a modulus of continuity of  $\varphi$ . Let us point out that, if the space dimension N equals 1, both the Kruzhkov-Panov and the Maliki-Touré conditions are always satisfied. If the space dimension is equal to 2, then the Maliki-Touré condition contains no restriction on the function  $\varphi$ .

In the work [3] we have investigated the exactness of the assumption of [15] for the case of a pure diffusion equation (i.e.,  $F \equiv 0$ ). It turns out that uniqueness of  $L^{\infty}$  solutions for this case holds for all  $\varphi$ . In the present paper, we show a similar result for the full convection-diffusion equation (1). More exactly, we show uniqueness of an entropy solution for (1) for all continuous non-decreasing  $\varphi$ , but under the assumption that F satisfies an isotropic condition

which essentially means that F is Hölder continuous of order  $\alpha = 1 - \frac{1}{N}$ . According to the previous remark, we can restrict our attention to the case  $N \ge 3$ .

Our technique does not allow to benefit from the anisotropy of the flux F; in particular, unlike in [15], our result does not reduce (3) in the trivial case  $\varphi \equiv 0$ . The case of an anisotropic diffusion of the form  $\sum_{i=1}^{N} \partial_{x_i x_i} \varphi_i(u)$  cannot be covered neither; we refer to Maliki and Ouedraogo [1] for results on this non-isotropic diffusion case under suitable assumptions on the moduli of continuity of  $\varphi_i$ . The problem where the quasilinear diffusion operator  $\Delta \varphi(u)$ is replaced with a fully nonlinear diffusion operator such as the *p*-laplacian  $\Delta_p \varphi(u)$  is even more difficult; to our knowledge, no uniqueness result for entropy solutions in  $\mathbb{R}^N$  is available when p > 2.

#### 2. Definitions and results

Recall that  $\varphi$  is a continuous function on  $\mathbb{R}$ . For M > 0, we say that a sub-additive, continuous function  $\omega_{\varphi} : [0, 2M] \mapsto \mathbb{R}^+$  such that  $\omega_{\varphi}(0) = 0$  is a modulus of continuity of  $\varphi$ , if

(4) 
$$\forall z, \hat{z} \in [-M, M] \quad |\varphi(z) - \varphi(\hat{z})| \le \omega_{\varphi}(|z - \hat{z}|).$$

Recall that we only work with bounded solutions of (1). Without loss of generality, we can assume that M is fixed, moreover,  $\omega_{\varphi}$  is strictly convex (and thus, strictly increasing) and extended to the whole of  $\mathbb{R}^+$ ; we denote its inverse function by  $\alpha_{\varphi}$ . We use the Fenchel (Legendre) transform of  $\alpha_{\varphi}$ :

$$\Omega_{\varphi}^{*}(t) = \sup_{z \in \mathbb{R}} \left( zt - \Omega_{\varphi}(z) \right).$$

It easily follows that  $\alpha_{\varphi}^*$  is strictly increasing, thus it is invertible. We denote by  $\omega_{\varphi}^*$  the inverse of  $\alpha_{\varphi}$ . With the above notation, we have for all  $z, t \in \mathbb{R}^+$ ,

(5) 
$$zt \le \alpha_{\varphi}(z) + \alpha_{\varphi}^{*}(t), \quad (\alpha_{\varphi} \circ \omega_{\varphi})(z) = z, \text{ and } (\alpha_{\varphi}^{*} \circ \omega_{\varphi}^{*})(t) = t.$$

For a vector-valued function  $F : \mathbb{R} \mapsto \mathbb{R}^N$ , we introduce the (isotropic) modulus of continuity  $\omega_F$  and the related functions  $\alpha_F, \alpha_F^*$  and  $\omega_F^*$  in the same way, replacing  $|\varphi(z) - \varphi(\hat{z})|$  in (4) with  $|F(z) - F(\hat{z})|$ . Here and in the sequel, we mean that  $\mathbb{R}^N$  is endowed with the euclidean norm, which we denote by  $|\cdot|$ .

**Definition 1.** An entropy solution of (1) is a function  $u \in L^{\infty}((0,T) \times \mathbb{R}^N)$  such that  $\varphi(u) \in L^2(0,T; H^1_{loc}(\mathbb{R}^N))$  and the inequalities

$$-\int_{0}^{T} \int_{\mathbb{R}^{N}} \left( |u-k|\xi_{t} + \operatorname{sign} (u-k)(F(u) - F(k)) \cdot \nabla \xi + \operatorname{sign} (u-k) \nabla \varphi(u) \cdot \nabla \xi \right)$$
(6)
$$\leq \int_{0}^{T} \int_{\mathbb{R}^{N}} \operatorname{sign} (u-k) f \xi + \int_{\mathbb{R}^{N}} |u_{0} - k| \xi(0, \cdot)$$
hold for all  $k \in \mathbb{P}$  and all  $\xi \in \mathcal{D}([0, T]) \times \mathbb{P}^{N}$ 

hold for all  $k \in \mathbb{R}$  and all  $\xi \in \mathcal{D}([0,T) \times \mathbb{R}^N)$ .

Here and in the sequel, we mean that  $u_0 \in L^{\infty}(\mathbb{R}^N)$  and  $||f(t, \cdot)||_{L^{\infty}} \in L^1(0, T)$ . It is clear that an entropy solution is also a solution in the sense of distributions; it suffices to use (6) with  $k = ||u||_{L^{\infty}}$ . It follows that in (6), one can replace sign (u-k) and |u-k| with sign  $^+(u-k)$  and  $(u-k)^+$ , respectively, where sign  $^+(r) := \max\{\text{sign } r, 0\}$  and  $r^+ := \max\{r, 0\}$ .

Existence of an entropy solution is standard; it can be obtained, e.g., by a regularization of F and  $\varphi$  (when  $\varphi \equiv 0$ , one takes  $\varphi_{\varepsilon}(z) = \varepsilon z$ , which is the so-called "vanishing viscosity" approximation), with the help of the translation invariance in x of the left-hand side of (1) and the  $L^1$  contraction result of Maliki and Touré [15].

Definition 1 implies the Kato inequality (2), with the help of the doubling-of-variables approach of Kruzhkov ([9]) and the techniques of Carrillo ([8]) and Blanchard and Porretta ([7]) (see e.g. [15, 4, 3]). Inequality (2) can also be obtained without doubling the variables, with the help of the so-called kinetic formulation (see Perthame [17] for the case of a conservation law). Uniqueness of an entropy solution of (1) (and, more generally, the  $L^1$  contraction and comparison principle) follows whenever we can pass to the limit in the Kato inequality (2) with test functions  $\xi \to 1$  on  $\mathbb{R}^N$ .

We assume that  $N \ge 3$  (for  $N \le 2$ , the results of [15] apply with no restriction on  $\varphi$ ).

**Theorem 2.** Let  $N \geq 3$ . Consider an arbitrary non-decreasing continuous function  $\varphi : \mathbb{R} \mapsto \mathbb{R}$ . Consider a continuous function  $F : \mathbb{R} \mapsto \mathbb{R}^N$  which possesses a modulus of continuity  $\omega_F$  such that, with the notation introduced above, there holds

(7) 
$$I_F(R,\varepsilon) := R^{N-2+\varepsilon} \int_R^{+\infty} \alpha_F^*\left(\frac{1}{r}\right) r^{1-\varepsilon} dr \le const \qquad uniformly in \ \varepsilon > 0, R > 1.$$

Assume in addition that the " $\Delta_2$ -condition" on  $\Omega_F$  holds:

(8) 
$$\Omega_F(2z) \leq const \ \Omega(z) \quad \forall z \in \mathbb{R}^+.$$

Then whenever  $(u_0 - \hat{u}_0)^+ \in L^1(\mathbb{R}^N)$ ,  $(f - \hat{f})^+ \in L^1((0, T) \times \mathbb{R}^N)$ ,

(9) 
$$\int_{\mathbb{R}^N} (u - \hat{u})^+(t, \cdot) \le \int_{\mathbb{R}^N} (u_0 - \hat{u}_0)^+ + \int_0^t \int_{\mathbb{R}^N} (f - \hat{f})^+ \quad a.e. \ on \ (0, T) ,$$

where  $u, \hat{u}$  are entropy solutions corresponding, respectively, to given initial data  $u_0, \hat{u}_0 \in L^{\infty}(\mathbb{R}^N)$  and sources  $f, \hat{f}$  with  $||f(t, \cdot)||_{L^{\infty}(\mathbb{R})}, ||\hat{f}(t, \cdot)||_{L^{\infty}(\mathbb{R})} \in L^1(0, T)$ . In particular, under assumptions (7), (8) there exists a unique entropy solution  $u_{u_0,f}$  for given data  $u_0, f$ ; the map  $(u_0, f) \mapsto u_{u_0,f}$  is order-preserving, and the map  $u_0 \in L^{\infty}(\mathbb{R}^N) \cap L^1(\mathbb{R}^N) \mapsto u_{u_0,0}$  is a *T*-contraction in  $L^1$ .

#### Remark 3.

- (i) If we replace (7) by the stronger requirement that  $\sup_{\varepsilon>0} I_F(R,\varepsilon) \to 0$  as  $R \to +\infty$ , the assumption (8) can be dropped and the claim of the theorem continues to hold (see the proof of Theorem 2).
- (ii) A sufficient condition is that  $\omega_F(z) \leq \text{const } z^{\alpha}$  with  $\alpha = 1 \frac{1}{N}$  (i.e., that F is Hölder continuous of order  $1 - \frac{1}{N}$ ); in this case, we can pick  $\Omega_F(z) = \text{const } z^{\frac{1}{\alpha}}$  and  $\Omega_F^*(t) = \text{const } t^{\frac{1}{1-\alpha}} \equiv \text{const } t^N$ , for which conditions (7), (8) are easy to check.

#### 3. Proof of Theorem 2

The technique of the proof of the theorem is closely related to the previous work [3]. Roughly speaking, we take in the Kato inequality (2) radial test functions  $\xi$  such that  $\Delta \xi \leq 0$ . This allows us to drop the second term in the right-hand side of (2); thus restrictions on  $\varphi$ 

are by passed. The test functions are constructed by truncating the laplacian's fundamental solution profile  $\frac{1}{|x|^{N-2}}$ .

We are intended to use (2) with the test functions  $\rho_{\varepsilon}(x) = \left(\max\{\frac{|x|}{R}, 1\}\right)^{2-N-\varepsilon}$ ,  $\varepsilon > 0$ , R > 1 (in order to lighten the notation, we do not indicate explicitly that  $\rho_{\varepsilon}$  also depends on R). Then we let  $\varepsilon \to 0$ , and finally we let  $R \to +\infty$ .

To this end, let  $\rho_{\varepsilon,L}(x) = R^{N-2+\varepsilon} \left( \left( \max\{|x|, R\} \right)^{2-N-\varepsilon} - \left( L \right)^{2-N-\varepsilon} \right)^+$ , L > R. By a density argument, we take in (2) test functions under the form  $\xi(t, x) = \mu(t)\rho_{\varepsilon,L}(x)$ , where  $\mu \in \mathcal{D}([0,T))^+$ . Indeed, regularizing  $\rho_{\varepsilon,L}$  by convolution, dropping the negative measure part of the distribution  $\Delta \rho_{\varepsilon,L}$  concentrated of  $\{x \in \mathbb{R}^N \mid |x| = R\}$ , using the definition of  $\omega_{\varphi}, \omega_F$  we deduce

$$\int_{0}^{T} \int_{\mathbb{R}^{N}} (u-\hat{u})^{+} \rho_{\varepsilon,L} (-\mu_{t}) \leq \int_{0}^{T} \int_{\mathbb{R}^{N}} \omega_{F}((u-\hat{u})^{+}) |\nabla \rho_{\varepsilon,L}| \mu + \int_{0}^{T} \int_{\mathbb{R}^{N}} \omega_{\varphi}((u-\hat{u})^{+}) \Delta \rho_{\varepsilon,L} \mu + \int_{\{|x|=L\}} \omega_{\varphi}((u-\hat{u})^{+}) (2-N-\varepsilon)L^{1-N-\varepsilon} \mu + \int_{0}^{T} \int_{\mathbb{R}^{N}} (f-\hat{f}) \operatorname{sign}^{+} (u-\hat{u}) \rho_{\varepsilon,L} \mu + \int_{\mathbb{R}^{N}} (u_{0}-\hat{u}_{0})^{+} \rho_{\varepsilon,L} \mu(0) d\mu + \int_{0}^{T} \int_{\mathbb{R}^{N}} (f-\hat{f}) \operatorname{sign}^{+} (u-\hat{u}) \rho_{\varepsilon,L} \mu + \int_{\mathbb{R}^{N}} (u_{0}-\hat{u}_{0})^{+} \rho_{\varepsilon,L} \mu(0) d\mu + \int_{0}^{T} (u_{0}-\hat{u}_{0})^{+} \rho_{\varepsilon,L} \mu(0) d\mu + \int_{0}^{T} (u_{0}-\hat{u}_{0})^{+} \rho_{\varepsilon,L} \mu(0) d\mu +$$

for a.e. L > R'; here  $\Delta \rho_{\varepsilon,L}$  is taken in the pointwise (a.e. on  $\mathbb{R}^N$ ) sense. Because  $u, \hat{u}$  are bounded, the integral on the sphere  $\{|x| = L\}$  is majorated by  $const L^{N-1}L^{1-N-\varepsilon} = const L^{-\varepsilon}$ . We calculate  $\Delta \rho_{\varepsilon,L} = \varepsilon (N-2+\varepsilon)|x|^{-2}\rho_{\varepsilon} \mathbb{1}_{R < |x| < L}$  and  $|\nabla \rho_{\varepsilon,L}| = (N-2+\varepsilon)|x|^{-1}\rho_{\varepsilon} \mathbb{1}_{R < |x| < L}$ . Notice that  $|\rho_{\varepsilon,L}| \leq 1$  for all  $\varepsilon, R, L$ . Now we let  $L \to \infty$ . Thanks to the boundedness of  $u, \hat{u}$  and to the integrability assumption on  $(u_0 - \hat{u}_0)^+$ ,  $(f - \hat{f})^+$  we deduce that

$$\int_{0}^{T} \int_{\mathbb{R}^{N}} (u - \hat{u})^{+} \rho_{\varepsilon} (-\mu_{t}) \leq c \int_{0}^{T} \int_{\{|x| > R\}} \left( \omega_{F}((u - \hat{u})^{+})|x|^{-1} + \varepsilon \, \omega_{\varphi}((u - \hat{u})^{+})|x|^{-2} \right) \rho_{\varepsilon} \\
(10) + \int_{0}^{T} \int_{\mathbb{R}^{N}} (f - \hat{f}) \operatorname{sign}^{+} (u - \hat{u}) \, \mu + \int_{\mathbb{R}^{N}} (u_{0} - \hat{u}_{0})^{+} \, \mu(0).$$

Here and in the sequel, we fix  $c = (N-1) \|\mu\|_{L^{\infty}}$  for  $\varepsilon \in (0,1)$ .

Our goal is to show that, letting  $\varepsilon \to 0$  and  $R \to \infty$ , we can drop the first term in the right-hand side of (10). The first step is to prove that  $(u - \hat{u})^+$  is integrable on  $(0, T) \times \mathbb{R}^N$ . To this end, fix  $\delta > 0$ . Let us show that

(11) 
$$c \varepsilon \int_0^T \int_{\{|x|>R\}} \omega_{\varphi}((u-\hat{u})^+) |x|^{-2} \rho_{\varepsilon} \leq \delta \int_0^T \int_{\{|x|>R\}} (u-\hat{u})^+ \rho_{\varepsilon} + r^{\delta,R}(\varepsilon),$$

where for all fixed  $\delta > 0$ , R > 1, the quantity  $r^{\delta,R}(\varepsilon)$  tends to zero as  $\varepsilon$  decreases to zero. Indeed, using (5), we get

$$c\varepsilon \ \omega_{\varphi}((u-\hat{u})^{+}) |x|^{-2} = \delta \left( \ \omega_{\varphi}((u-\hat{u})^{+}) \ \frac{c\varepsilon}{\delta} |x|^{-2} \right) \le \delta (u-\hat{u})^{+} + \delta \Omega_{\varphi}^{*}(\frac{c\varepsilon}{\delta} |x|^{-2});$$

thus (11) holds with

$$r^{\delta,R}(\varepsilon) := T\delta \int_{\{|x|>R\}} \alpha_{\varphi}^*(\frac{c\varepsilon}{\delta}|x|^{-2})\rho_{\varepsilon}$$

By the convexity of  $\alpha_{\varphi}^*$ , we have  $\alpha_{\varphi}^*(\frac{c\varepsilon}{\delta}|x|^{-2}) \leq (\alpha_{\varphi}^*)'(\frac{c\varepsilon}{\delta}R^{-2})\frac{c\varepsilon}{\delta}|x|^{-2}$  whenever  $|x| \geq R$ . Without loss of generality, we can assume that  $\alpha_{\varphi}$  is convex and strictly increasing; then it is not difficult to prove that  $\operatorname{ess} \lim_{t\downarrow 0} (\alpha_{\varphi}^*)'(t) = 0$  (see e.g. [3]). Hence we deduce that  $(\alpha_{\varphi}^*)'(\frac{c\varepsilon}{\delta}R^{-2}) =: \overline{o}_{\varepsilon}$  tends to zero as  $\varepsilon \to 0$ . Therefore using polar coordinates, we get

$$0 \le r^{\delta,R}(\varepsilon) = \delta T \int_{\{|x|>R\}} \Omega_{\varphi}^{*} \left(\frac{c\varepsilon}{\delta} |x|^{-2}\right) \rho_{\varepsilon} \le \overline{o}_{\varepsilon} cT \varepsilon \int_{\{|x|>R\}} |x|^{-2} \rho_{\varepsilon}$$

$$(12) \qquad = cT \varepsilon R^{N-2+\varepsilon} \overline{o}_{\varepsilon} \int_{R}^{+\infty} r^{-2+2-N-\varepsilon} r^{N-1} dr = cT \varepsilon R^{N-2+\varepsilon} \frac{R^{-\varepsilon}}{\varepsilon} \overline{o}_{\varepsilon} \to 0 \quad \text{as } \varepsilon \to 0.$$

Similarly, from (5) we deduce

(13) 
$$c\omega_F((u-\hat{u})^+) |x|^{-1} \rho_{\varepsilon} \le \frac{1}{2} (u-\hat{u})^+ \rho_{\varepsilon} + \Omega_F^*(2c|x|^{-1}) \rho_{\varepsilon};$$

moreover, using assumption (7) we get

(14) 
$$\int_0^T \int_{\{|x|>R\}} \Omega_F^*(2c|x|^{-1})\rho_\varepsilon = T \ R^{N-2+\varepsilon} \int_R^{+\infty} \Omega_F^*\left(\frac{2c}{r}\right) \ r^{1-\varepsilon} \, dr \le const \ I_F(R/(2c),\varepsilon) \le const.$$

By density, we can take  $\mu(\cdot) = (T - \cdot)^+$  in (10), so that  $-\mu_t(t) = \mathbb{1}_{(0,T)}(t)$ . Putting  $\delta = 1/2$  and letting  $\varepsilon \to 0$ , from (10) and (11)–(14) we deduce that

$$\int_{0}^{s} \int_{\{|x| < R\}} (u - \hat{u})^{+} \le T \int_{\mathbb{R}^{N}} (u_{0} - \hat{u}_{0})^{+} + T \int_{0}^{T} \int_{\mathbb{R}^{N}} (f - \hat{f})^{+} + const \le const.$$

Letting  $R \to \infty$  and  $s \to T$ , by the monotone convergence theorem we deduce that (15)  $(u - \hat{u})^+ \in L^1((0, T) \times \mathbb{R}^N).$ 

In order to conclude the proof, we return to (10). We now replace (13) with the estimate

(16) 
$$c\omega_F((u-\hat{u})^+)|x|^{-1}\rho_{\varepsilon} \leq \delta c \,\Omega_F\left(\frac{1}{\delta}\omega_F((u-\hat{u})^+)\right)\rho_{\varepsilon} + \delta c \,\Omega_F^*(|x|^{-1})\rho_{\varepsilon}.$$

Denote by  $C(\delta)$  a generic constant that does not depend on  $\varepsilon, R$ . Assumption (8) implies that for  $t \in \mathbb{R}^+$ ,  $\alpha_F(\frac{1}{\delta}\omega_F(t)) \leq C(\delta) \alpha_F(\omega_F(t)) = C(\delta) t$ . Now using (7), we infer

(17)  
$$c \int_{0}^{T} \int_{\{|x|>R\}} \omega_{F}((u-\hat{u})^{+}) |x|^{-1} \rho_{\varepsilon} \leq C(\delta) \int_{0}^{T} \int_{\{|x|>R\}} (u-\hat{u})^{+} + \delta cT \int_{\{|x|>R\}} \alpha_{F}^{*}(|x|^{-1}) \rho_{\varepsilon} \leq C(\delta) \int_{0}^{T} \int_{\{|x|>R\}} (u-\hat{u})^{+} + const \,\delta;$$

The left-hand side of (17) converges to zero as  $R \to \infty$ , uniformly in  $\varepsilon$ ; indeed, (15) yields

(18) 
$$\inf_{\delta>0} \left( C(\delta) \int_0^T \int_{\{|x|>R\}} (u-\hat{u})^+ + \operatorname{const} \delta \right) \to 0 \quad \text{as } R \to \infty.$$

Using (11) and (12) once more, from (15) we get

(19)  

$$c \varepsilon \int_{0}^{T} \int_{\{|x|>R\}} \omega_{\varphi}((u-\hat{u})^{+}) |x|^{-2} \rho_{\varepsilon} \leq \inf_{\delta>0} \left( \delta \int_{0}^{T} \int_{\{|x|>R\}} (u-\hat{u})^{+} + r^{\delta,R}(\varepsilon) \right) \rightarrow 0 \text{ as } \varepsilon \to 0 \text{ and then } R \to \infty.$$

Now we let  $\varepsilon \to 0$  and  $R \to +\infty$  in (10); notice that  $\rho_{\varepsilon}$  converge to 1 and remains bounded. With the help of (17),(18) and (19), we deduce

(20) 
$$\int_0^T \int_{\mathbb{R}^N} (u - \hat{u})^+ (-\mu_t) \leq \int_0^T \int_{\mathbb{R}^N} (f - \hat{f}) \operatorname{sign}^+ (u - \hat{u}) \mu + \int_{\mathbb{R}^N} (u_0 - \hat{u}_0)^+ \mu(0).$$

The claim (9) follows readily from (20). Because the existence of an entropy solution is already known, this ends the proof of Theorem 2.
