# On the uniqueness of solutions to quadratic BSDEs with convex generators and unbounded terminal conditions

#### Abstract

In [ 4$]$, the authors proved the uniqueness among the solutions which admit every exponential moments. In this paper, we prove that uniqueness holds among solutions which admit some given exponential moments. These exponential moments are natural as they are given by the existence theorem. Thanks to this uniqueness result we can strengthen the nonlinear Feynman-Kac formula proved in 4 .


## 1 Introduction

In this paper, we consider the following quadratic backward stochastic differential equation (BSDE in short for the remaining of the paper)

$$
\begin{equation*}
Y_{t}=\xi-\int_{t}^{T} g\left(s, Y_{s}, Z_{s}\right) d s+\int_{t}^{T} Z_{s} d W_{s}, \quad 0 \leqslant t \leqslant T \tag{1.1}
\end{equation*}
$$

where the generator $-g$ is a continuous real function that is concave and has a quadratic growth with respect to the variable $z$. Moreover $\xi$ is an unbounded random variable (see e.g. [8] for the case of quadratic BSDEs with bounded terminal conditions). Let us recall that, in the previous equation, we are looking for a pair of process $(Y, Z)$ which is required to be adapted with respect to the filtration generated by the $\mathbb{R}^{d}$-valued Brownian motion $W$. In [ $\left.\AA\right]$, the authors prove the uniqueness among the solutions which satisfy for any $p>0$,

$$
\mathbb{E}\left[e^{p \sup _{0 \leqslant t \leqslant T}\left|Y_{t}\right|}\right]<\infty
$$

The main contribution of this paper is to strengthen their uniqueness result. More precisely, we prove the uniqueness among the solutions satisfying:

$$
\exists p>\bar{\gamma}, \exists \varepsilon>0, \quad \mathbb{E}\left[e^{p \sup _{0 \leqslant t \leqslant T}\left(Y_{t}^{-}+\int_{0}^{t} \bar{\alpha}_{s} d s\right)}+e^{\varepsilon \sup _{0 \leqslant t \leqslant T} Y_{t}^{+}}\right]<+\infty
$$

where $\bar{\gamma}>0$ and $\left(\alpha_{t}\right)_{t \in[0, T]}$ is a progressively measurable nonnegative stochastic process such that, P-a.s.,

$$
\forall(t, y, z) \in[0, T] \times \mathbb{R} \times \mathbb{R}^{1 \times d}, \quad g(t, y, z) \leqslant \bar{\alpha}_{t}+\bar{\beta}|y|+\frac{\bar{\gamma}}{2}|z|^{2} .
$$

Our method is different of that in [4] where the authors apply the so-called $\theta$-difference method, i.e. estimating $Y^{1}-\theta Y^{2}$, for $\theta \in(0,1)$, and then letting $\theta \rightarrow 0$. Whereas in this paper, we apply a verification method: first we define a stochastic control problem and then we prove that the first component of any solution of the BSDE is the optimal value of this associated control problem. Thus the uniqueness follows immediately. Moreover, using this representation, we are able to give a probabilistic representation of the following PDE:

$$
\partial_{t} u(t, x)+\mathcal{L} u(t, x)-g\left(t, x, u(t, x),-\sigma^{*} \nabla_{x} u(t, x)\right)=0, \quad u(T, .)=h,
$$

where $h$ and $g$ have a "not too high" quadratic growth with respect to the variable $x$. We remark that the probabilistic representation is also given by [ 4 ] under the condition that $h$ and $g$ are subquadratic, i.e.:

$$
\forall(t, x, y, z) \in[0, T] \times \mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{1 \times d}, \quad|h(x)|+|g(t, x, y, z)| \leqslant f(t, y, z)+C|x|^{p}
$$

with $f \geqslant 0, C>0$ and $p<2$.
The paper is organized as follows. In section 2, we prove an existence result in the spirit of [3] and [母]: here we work with generators $-g$ such that $g^{-}$has a linear growth with respect to variables $y$ and $z$. As in part 5 of [ 3$]$, this assumption allows us to reduce hypothesis of [ 4$]$. Section 3 is devoted to the optimal control problem from which we get as a byproduct a uniqueness result for quadratic BSDEs with unbounded terminal conditions. Finally, in the last section we derive the nonlinear Feynman-Kac formula in this framework.

Let us close this introduction by giving the notations that we will use in all the paper. For the remaining of the paper, let us fix a nonnegative real number $T>0$. First of all, $\left(W_{t}\right)_{t \in[0, T]}$ is a standard Brownian motion with values in $\mathbb{R}^{d}$ defined on some complete probability space $(\Omega, \mathcal{F}, \mathbb{P}) .\left(\mathcal{F}_{t}\right)_{t \geqslant 0}$ is the natural filtration of the Brownian motion $W$ augmented by the $\mathbb{P}$-null sets of $\mathcal{F}$. The sigma-field of predictable subsets of $[0, T] \times \Omega$ is denoted $\mathcal{P}$.

As mentioned in the introduction, we will deal only with real valued BSDEs which are equations of type (1.1). The function $-g$ is called the generator and $\xi$ the terminal condition. Let us recall that a generator is a random function $[0, T] \times \Omega \times \mathbb{R} \times \mathbb{R}^{1 \times d} \rightarrow \mathbb{R}$ which is measurable with respect to $\mathcal{P} \otimes \mathcal{B}(\mathbb{R}) \otimes \mathcal{B}\left(\mathbb{R}^{1 \times d}\right)$ and a terminal condition is simply a real $\mathcal{F}_{T}$-measurable random variable. By a solution to the $\operatorname{BSDE}(1.1)$ we mean a pair $\left(Y_{t}, Z_{t}\right)_{t \in[0, T]}$ of predictable processes with values in $\mathbb{R} \times \mathbb{R}^{1 \times d}$ such that $\mathbb{P}$-a.s., $t \mapsto Y_{t}$ is continuous, $t \mapsto Z_{t}$ belongs to $L^{2}(0, T), t \mapsto g\left(t, Y_{t}, Z_{t}\right)$ belongs to $L^{1}(0, T)$ and $\mathbb{P}$-a.s. $(Y, Z)$ verifies (1.1). We will sometimes use the notation $\operatorname{BSDE}(\xi, g)$ to say that we consider the BSDE whose generator is $g$ and whose terminal condition is $\xi$.

For any real $p \geqslant 1, \mathcal{S}^{p}$ denotes the set of real-valued, adapted and càdlàg processes $\left(Y_{t}\right)_{t \in[0, T]}$ such that

$$
\|Y\|_{\mathcal{S}^{p}}:=\mathbb{E}\left[\sup _{0 \leqslant t \leqslant T}\left|Y_{t}\right|^{p}\right]^{1 / p}<+\infty
$$

$M^{p}$ denotes the set of (equivalent class of) predictable processes $\left(Z_{t}\right)_{t \in[0, T]}$ with values in $\mathbb{R}^{1 \times d}$ such that

$$
\|Z\|_{M^{p}}:=\mathbb{E}\left[\left(\int_{0}^{T}\left|Z_{s}\right|^{2} d s\right)^{p / 2}\right]^{1 / p}<+\infty
$$

Finally, we will use the notation $Y^{*}:=\sup _{0 \leqslant t \leqslant T}\left|Y_{t}\right|$ and we recall that $Y$ belongs to the class (D) as soon as the family $\left\{Y_{\tau}: \tau \leqslant T\right.$ stopping time $\}$ is uniformly integrable.

## 2 An existence result

In this section, we prove a mere modification of the existence result for quadratic BSDEs obtained in [ 4 by using a method applied in section 5 of [ 4$]$. We consider here the case where $g^{-}$has a linear growth with respect to variables $y$ and $z$. Let us assume the following on the generator.

Assumption (A.1). There exist three constants $\beta \geqslant 0, \gamma>0$ and $r \geqslant 0$ together with two progressively measurable nonnegative stochastic processes $\left(\bar{\alpha}_{t}\right)_{0 \leqslant t \leqslant T},\left(\underline{\alpha}_{t}\right)_{0 \leqslant t \leqslant T}$ and a deterministic continuous nondecreasing function $\phi: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$with $\phi(0)=0$ such that, $\mathbb{P}$-a.s.,

1. for all $t \in[0, T],(y, z) \mapsto g(t, y, z)$ is continuous;
2. monotonicity in $y$ : for each $(t, z) \in[0, T] \times \mathbb{R}^{1 \times d}$,

$$
\forall y \in \mathbb{R}, \quad y(g(t, 0, z)-g(t, y, z)) \leqslant \beta|y|^{2} ;
$$

3. growth condition: $\forall(t, y, z) \in[0, T] \times \mathbb{R} \times \mathbb{R}^{1 \times d}$,

$$
-\underline{\alpha}_{t}-r(|y|+|z|) \leqslant g(t, y, z) \leqslant \bar{\alpha}_{t}+\phi(|y|)+\frac{\gamma}{2}|z|^{2} .
$$

Theorem 2.1 Let (A.1) hold. If there exists $p>1$ such that

$$
\mathbb{E}\left[\exp \left(\gamma e^{\beta T} \xi^{-}+\gamma \int_{0}^{T} \bar{\alpha}_{t} e^{\beta t} d t\right)+\left(\xi^{+}\right)^{p}+\left(\int_{0}^{T} \underline{\alpha}_{t} d t\right)^{p}\right]<+\infty
$$

then the BSDE (1.1) has a solution $(Y, Z)$ such that
$-\frac{1}{\gamma} \log \mathbb{E}\left[\exp \left(\gamma e^{\beta(T-t)} \xi^{-}+\gamma \int_{t}^{T} \bar{\alpha}_{r} e^{\beta(r-t)} d r\right) \mid \mathcal{F}_{t}\right] \leqslant Y_{t} \leqslant C e^{C T}\left(\mathbb{E}\left[\left(\xi^{+}\right)^{p}+\left(\int_{t}^{T} \underline{\alpha}_{r} d r\right)^{p} \mid \mathcal{F}_{t}\right]\right)^{1 / p}$,
with $C$ a constant that does not depend on $T$.
Proof. We will fit the proof of Proposition 4 in [3] to our situation. Without loss of generality, let us assume that $r$ is an integer. For each integer $n \geqslant r$, let us consider the function

$$
g_{n}(t, y, z):=\inf \left\{g(t, p, q)+n|p-y|+n|q-z|,(p, q) \in \mathbb{Q}^{1+d}\right\} .
$$

$g_{n}$ is well defined and it is globally Lipschitz continuous with constant $n$. Moreover $\left(g_{n}\right)_{n \geqslant r}$ is increasing and converges pointwise to $g$. Dini's theorem implies that the convergence is also uniform on compact sets. We have also, for all $n \geqslant r$,

$$
h(t, y, z):=-\underline{\alpha}_{t}-r(|y|+|z|) \leqslant g_{n}(t, y, z) \leqslant g(t, y, z) .
$$

Let $\left(Y^{n}, Z^{n}\right)$ be the unique solution in $\mathcal{S}^{p} \times M^{p}$ to $\operatorname{BSDE}\left(\xi,-g_{n}\right)$. It follows from the classical comparison theorem that

$$
Y_{t}^{n+1} \leqslant Y_{t}^{n} \leqslant Y_{t}^{r} .
$$

Let us prove that for each $n \geqslant r$

$$
Y_{t}^{n} \geqslant-\frac{1}{\gamma} \log \mathbb{E}\left[\exp \left(\gamma e^{\beta(T-t)} \xi^{-}+\gamma \int_{t}^{T} \bar{\alpha}_{r} e^{\beta(r-t)} d r\right) \mid \mathcal{F}_{t}\right]:=X_{t}
$$

Let $\left(\tilde{Y}^{n}, \tilde{Z}^{n}\right)$ be the unique solution $\mathcal{S}^{p} \times M^{p}$ to $\operatorname{BSDE}\left(-\xi^{-},-g_{n}^{+}\right)$. It follows from the classical comparison theorem that $\tilde{Y}^{n} \leqslant Y^{n}$ and $\tilde{Y}^{n} \leqslant 0$. Then, according to Proposition 3 in $\llbracket$, we have $\tilde{Y}^{n} \geqslant X$ and so $Y^{n} \geqslant X$ for all $n \geqslant r$. We set $Y=\inf _{n \geqslant r} Y^{n}$ and, arguing as in the proof of Proposition 3 in $屯$ or Theorem 2 in [了] with a localization argument, we construct a process $Z$ such that $(Y, Z)$ is a solution to $\operatorname{BSDE}(\xi,-g)$. For the upper bound, let $(\bar{Y}, \bar{Z})$ be the unique solution $\mathcal{S}^{p} \times M^{p}$ to $\operatorname{BSDE}\left(\xi^{+},-f\right)$. Then the classical comparison theorem gives us that $Y \leqslant \bar{Y}$ and we apply a classical a priori estimate for $L^{p}$ solutions of BSDEs in [2] to $\bar{Y}$.

Corollary 2.2 Let (A.1) hold. We suppose that $\xi^{-}+\int_{0}^{T} \bar{\alpha}_{t} d t$ has an exponential moment of order $\gamma e^{\beta T}$ and there exists $p>1$ such that $\xi^{+} \in L^{p}$ and $\int_{0}^{T} \underline{\alpha}_{t} d t \in L^{p}$.

- If $\xi^{-}+\int_{0}^{T} \bar{\alpha}_{t} d t$ has an exponential moment of order $q e^{\beta T}$ with $q>\gamma$ then the BSDE (1.1) has a solution $(Y, Z)$ such that $\mathbb{E}\left[e^{q A^{*}}\right]<+\infty$ with $A_{t}:=Y_{t}^{-}+\int_{0}^{t} \bar{\alpha}_{s} d$ s.
- If $\xi^{+}+\int_{0}^{T} \underline{\alpha}_{t} d t$ has an exponential moment of order $\varepsilon$ then the BSDE (I.1) has a solution $(Y, Z)$ such that $\mathbb{E}\left[e^{\varepsilon\left(Y^{+}\right)^{*}}\right]<+\infty$.

Proof. Let us apply the existence result : BSDE (1.1) has a solution $(Y, Z)$ and we have

$$
A_{t}=Y_{t}^{-}+\int_{0}^{t} \bar{\alpha}_{s} d s \leqslant \frac{1}{\gamma} \log \underbrace{\mathbb{E}\left[\exp \left(\gamma e^{\beta T}\left(\xi^{-}+\int_{0}^{T} \bar{\alpha}_{r} d r\right)\right) \mid \mathcal{F}_{t}\right]}_{:=M_{t}} .
$$

So $e^{q A_{t}} \leqslant\left(M_{t}\right)^{q / \gamma}$ with $q / \gamma>1$. Since $M^{p / \gamma}$ is a submartingale, we are able to apply the Doob's maximal inequality to obtain

$$
\mathbb{E}\left[e^{q A^{*}}\right] \leqslant C_{q} \mathbb{E}\left[e^{q e^{\beta T}}\left(\xi^{-}+\int_{0}^{T} \bar{\alpha}_{s} d s\right)\right]<+\infty
$$

To prove the second part of the corollary, we define

$$
N_{t}:=\mathbb{E}\left[\left(\xi^{+}\right)^{p}+\left|\int_{0}^{T} \underline{\alpha}_{s} d s\right|^{p} \mid \mathcal{F}_{t}\right] .
$$

We set $q>1$. There exists $C_{\varepsilon, p, q} \geqslant 0$ such that $x \mapsto e^{x^{1 / p} \varepsilon / q}$ is convex on $\left[C_{\varepsilon, p, q},+\infty[\right.$. We have $e^{\varepsilon / q Y_{t}^{+}} \leqslant e^{\left(C_{\varepsilon, p, q}+N_{t}\right)^{1 / p} \varepsilon / q}$. Since $e^{\left(C_{\varepsilon, p, q}+N\right)^{1 / p} \varepsilon / q}$ is a submartingale, we are able to apply the Doob's maximal inequality to obtain

$$
\mathbb{E}\left[e^{\varepsilon\left(Y^{+}\right)^{*}}\right] \leqslant C \mathbb{E}\left[e^{\varepsilon\left(C_{\varepsilon, p, q}+\left(\xi^{+}\right)^{p}+\left(\int_{0}^{T} \underline{\alpha}_{s} d s\right)^{p}\right)^{1 / p}}\right] \leqslant C \mathbb{E}\left[e^{\varepsilon\left(\xi^{+}+\int_{0}^{T} \underline{\alpha}_{s} d s\right)}\right]<+\infty
$$

## 3 A uniqueness result

To prove our uniqueness result for the BSDE (1.1), we will introduce a stochastic control problem. For this purpose, we use the following assumption on $g$ :

Assumption (A.2). There exist three constants $K_{g, y} \geqslant 0, \bar{\beta} \geqslant 0$ and $\bar{\gamma}>0$ together with a progressively measurable nonnegative stochastic process $\left(\bar{\alpha}_{t}\right)_{t \in[0, T]}$ such that, $\mathbb{P}$-a.s.,

- for each $(t, z) \in[0, T] \times \mathbb{R}^{1 \times d}$,

$$
\left|g(t, y, z)-g\left(t, y^{\prime}, z\right)\right| \leqslant K_{g, y}\left|y-y^{\prime}\right|, \quad \forall\left(y, y^{\prime}\right) \in \mathbb{R}^{2}
$$

- for each $(t, y, z) \in[0, T] \times \mathbb{R} \times \mathbb{R}^{1 \times d}$,

$$
g(t, y, z) \leqslant \bar{\alpha}_{t}+\bar{\beta}|y|+\frac{\bar{\gamma}}{2}|z|^{2},
$$

- $z \mapsto g(t, y, z)$ is a convex function $\forall(t, y) \in[0, T] \times \mathbb{R}$.

Since $g(t, y,$.$) is a convex function we can define the Legendre-Fenchel transformation of g$ :

$$
f(t, y, q)=\sup _{z}(z q-g(t, y, z)), \quad \forall t \in[0, T], q \in \mathbb{R}^{d}, y \in \mathbb{R}
$$

$f$ is a function with values in $\mathbb{R} \cup\{+\infty\}$ that verifies direct properties.

## Proposition 3.1

- $\forall\left(t, y, y^{\prime}, q\right) \in[0, T] \times \mathbb{R} \times \mathbb{R} \times \mathbb{R}^{d}$ such that $f(t, y, q)<+\infty$,

$$
f\left(t, y^{\prime}, q\right)<+\infty \quad \text { and } \quad\left|f(t, y, z)-f\left(t, y^{\prime}, z\right)\right| \leqslant K_{g, y}\left|y-y^{\prime}\right| .
$$

- $f$ is a convex function in $q$,
- $f(t, y, q) \geqslant-\bar{\alpha}_{t}-\bar{\beta}|y|+\frac{1}{2 \bar{\gamma}}|q|^{2}$.

We set $N \in \mathbb{N}^{*}$ such that

$$
\begin{equation*}
\frac{T}{N}<\left(\frac{1}{\bar{\gamma}}-\frac{1}{p}\right) \frac{1}{\bar{\beta}(1 / p+1 / \varepsilon)} \tag{3.1}
\end{equation*}
$$

For $i \in\{0, \ldots, N\}$ we define $t_{i}:=\frac{i T}{N}$ and

$$
\begin{aligned}
\mathcal{A}_{t_{i}, t_{i+1}}(\eta):= & \left\{\left(q_{s}\right)_{s \in\left[t_{i}, t_{i+1}\right]}, \quad \int_{t_{i}}^{t_{i+1}}\left|q_{s}\right|^{2} d s<+\infty \mathbb{P}-\right.\text { a.s., } \\
& \left(M_{t}^{i}\right)_{t \in\left[t_{i}, t_{i+1}\right]} \text { is a martingale, } \mathbb{E}^{\mathbb{Q}^{i}}\left[|\eta|+\int_{t_{i}}^{t_{i+1}}\left|f\left(s, 0, q_{s}\right)\right| d s\right]<+\infty, \\
& \text { with } \left.M_{t}^{i}:=\exp \left(\int_{t_{i}}^{t} q_{s} d W_{s}-\frac{1}{2} \int_{t_{i}}^{t}\left|q_{s}\right|^{2} d s\right) \text { and } \frac{d \mathbb{Q}^{i}}{d \mathbb{P}}:=M_{t_{i+1}}^{i}\right\} .
\end{aligned}
$$

Let $q$ be in $\mathcal{A}_{t_{i}, t_{i+1}}(\eta)$. We define $d W_{t}^{q}:=d W_{t}-q_{t} d t$. Thanks to the Girsanov theorem, $\left(W_{t_{i}+h}^{q}-\right.$ $\left.W_{t_{i}}^{q}\right)_{h \in[0,1 / N]}$ is a Brownian motion under the probability $\mathbb{Q}^{i}$. So, we are able to apply Proposition 6.4 in 2 to show this existence result:

Proposition 3.2 There exist two processes $\left(Y^{\eta, q}, Z^{\eta, q}\right)$ such that $\left(Y_{t}^{\eta, q}\right)_{t \in\left[t_{i}, t_{i+1}\right]}$ belongs to the class (D) $\int_{t_{i}}^{t_{i+1}}\left|Z_{s}^{\eta, q}\right|^{2} d s<+\infty \mathbb{P}-$ a.s., $\int_{t_{i}}^{t_{i+1}}\left|f\left(s, Y_{s}^{\eta, q}, q_{s}\right)\right| d s<+\infty \mathbb{P}-$ a.s. and

$$
Y_{t}^{\eta, q}=\eta+\int_{t}^{t_{i+1}} f\left(s, Y_{s}^{\eta, q}, q_{s}\right) d s+\int_{t}^{t_{i+1}} Z_{s}^{\eta, q} d W_{s}^{q}, \quad t_{i} \leqslant t \leqslant t_{i+1}
$$

We are now able to define the admissible control set:

$$
\begin{aligned}
\mathcal{A}:= & \left\{\left(q_{s}\right)_{s \in[0, T]}, \quad q_{\left[\left[t_{N-1}, T\right]\right.} \in \mathcal{A}_{t_{N-1}, T}(\xi), \forall i \in\{N-2, \ldots, 0\}, q_{\left[\left[t_{i}, t_{i+1}\right]\right.} \in \mathcal{A}_{t_{i}, t_{i+1}}\left(Y_{t_{i+1}}^{q}\right)\right. \\
& \text { with } \left.Y_{t_{i+1}}^{q}:=Y_{t_{i+1}}^{Y_{t_{i+2}}^{q}, q_{\left[t_{i+1}, t_{i+2}\right]}} \text { and } Y_{T}^{q}:=\xi\right\} .
\end{aligned}
$$

$\mathcal{A}$ is well defined by a decreasing recursion on $i \in\{0, \ldots, N-1\}$. For $q \in \mathcal{A}$ we can define our cost functional $Y^{q}$ on $[0, T]$ by

$$
\forall i \in\{N-1, \ldots, 0\}, \forall t \in\left[t_{i}, t_{i+1}\right], \quad Y_{t}^{q}:=Y_{t}^{Y_{t_{i+1}}^{q}, q_{\left[t_{i}, t_{i+1}\right]}}
$$

$Y^{q}$ is also well defined by a decreasing recursion on $i \in\{0, \ldots, N-1\}$. Finally, the stochastic control problem consists in minimizing $Y^{q}$ among all the admissible controls $q \in \mathcal{A}$. Our strategy to prove the uniqueness is to prove that given a solution $(Y, Z)$, the first component is the optimal value.
Theorem 3.3 We suppose that there exists a solution $(Y, Z)$ of the BSDE (1.1) verifying

$$
\exists p>\bar{\gamma}, \exists \varepsilon>0, \quad \mathbb{E}\left[\exp \left(p A^{*}\right)+\exp \left(\varepsilon\left(Y^{+}\right)^{*}\right)\right]<+\infty
$$

with $A_{t}:=Y_{t}^{-}+\int_{0}^{t} \bar{\alpha}_{s} d s$. Then we have $Y=$ ess $\inf _{q \in \mathcal{A}} Y^{q}$, and there exists $q^{*} \in \mathcal{A}$ such that $Y=Y^{q^{*}}$. Moreover, this implies that the solution $(Y, Z)$ is unique among solutions verifying such condition.

Proof. Let us first prove that for any $q$ admissible, we have $Y \leqslant Y^{q}$. To do this, we will show that $Y_{\left[\left[t_{i}, t_{i+1}\right]\right.} \leqslant Y_{\mid\left[t_{i}, t_{i+1}\right]}^{q}$ by decreasing recurrence on $i \in\{0, N-1\}$. Firstly, we have $Y_{T}=Y_{T}^{q}=\xi$. Then we suppose that $Y_{t} \leqslant Y_{t}^{q}, \forall t \in\left[t_{i+1}, T\right]$. We set $t \in\left[t_{i}, t_{i+1}\right]$,

\tau_{n}^{i}:=\inf \left\{s \geqslant t, \sup \left\{\int_{t}^{s}\left|Z_{u}\right|^{2} d u, \int_{t}^{s}\left|Z_{u}^{q}\right|^{2} d u, \int_{t}^{s}\left|q_{u}\right|^{2} d u\right\}>n\right\} \wedge t_{i+1}
$$

$h(s, y, z):=-g(s, y, z)+z q_{s}$, and

$$
h_{s}:=\left\{\begin{array}{cl}
\frac{h\left(s, Y_{s}^{q}, Z_{s}\right)-h\left(s, Y_{s}, Z_{s}\right)}{Y_{s}^{q}-Y_{s}} & \text { if } Y_{s}^{q}-Y_{s} \neq 0 \\
0 & \text { otherwise } .
\end{array}\right.
$$

We observe that $\left|h_{s}\right| \leqslant K_{g, y}$. Then, by applying Itô formula to the process $\left(Y_{s}^{q}-Y_{s}\right) e^{\int_{t}^{s} h_{u} d u}$ we obtain $Y_{t}^{q}-Y_{t}=e^{\int_{t}^{\tau_{n}^{i}} h_{s} d s}\left[Y_{\tau_{n}^{i}}^{q}-Y_{\tau_{n}^{i}}\right]+\int_{t}^{\tau_{n}^{i}} e^{\int_{t}^{s} h_{u} d u}\left[f\left(s, Y_{s}^{q}, q_{s}\right)-h\left(s, Y_{s}^{q}, Z_{s}\right)\right] d s+\int_{t}^{\tau_{n}^{i}} e^{\int_{t}^{s} h_{u} d u}\left[Z_{s}^{q}-Z_{s}\right] d W_{s}^{q}$.

By definition, $f\left(s, Y_{s}^{q}, q_{s}\right)-h\left(s, Y_{s}^{q}, Z_{s}\right) \geqslant 0$, so

Y_{t}^{q}-Y_{t} \geqslant \mathbb{E}^{\mathbb{Q}^{i}}\left[e^{\int_{t}^{\tau_{n}^{i}} h_{s} d s}\left[Y_{\tau_{n}^{i}}^{q}-Y_{\tau_{n}^{i}}\right] \mid \mathcal{F}_{t}\right]
$$

Since $\left(Y_{\tau_{n}^{i}}^{q} e^{\int_{t}^{\tau_{n}^{i}} h_{s} d s}\right)_{n}$ tends to $Y_{t_{i+1}}^{q} e^{\int_{t}^{t_{i+1}} h_{s} d s}$ almost surely and is uniformly integrable, we have

$$
\lim _{n \rightarrow+\infty} \mathbb{E}^{\mathbb{Q}^{i}}\left[e^{\int_{t}^{\tau_{n}^{i}} h_{s} d s} Y_{\tau_{n}^{i}}^{q} \mid \mathcal{F}_{t}\right]=\mathbb{E}^{\mathbb{Q}^{i}}\left[e^{\int_{t}^{t_{i+1}} h_{s} d s} Y_{t_{i+1}}^{q} \mid \mathcal{F}_{t}\right] .
$$

Moreover, $\left|Y_{\tau_{n}^{i}} e^{{\tau_{t}^{i}}_{n}^{i}} h_{s} d s\right| \leqslant\left(Y^{+}\right)^{*} e^{T K_{g, y}}+\left(Y^{-}\right)^{*} e^{T K_{g, y}}$, so, by the dominated convergence theorem we obtain

$$
\lim _{n \rightarrow+\infty} \mathbb{E}^{\mathbb{Q}^{i}}\left[e^{\int_{t}^{\tau_{n}^{i}} h_{s} d s} Y_{\tau_{n}^{i}} \mid \mathcal{F}_{t}\right]=\mathbb{E}^{\mathbb{Q}^{i}}\left[e^{\int_{t}^{t_{i+1}} h_{s} d s} Y_{t_{i+1}} \mid \mathcal{F}_{t}\right] .
$$

Finally,

$$
Y_{t}^{q}-Y_{t} \geqslant \lim _{n \rightarrow+\infty} \mathbb{E}^{\mathbb{Q}^{i}}\left[e^{\int_{t}^{\tau_{n}^{i}} h_{s} d s}\left[Y_{\tau_{n}^{i}}^{q}-Y_{\tau_{n}^{i}}\right] \mid \mathcal{F}_{t}\right]=\mathbb{E}^{\mathbb{Q}^{i}}\left[e^{\int_{t}^{t_{i+1}} h_{s} d s}\left(Y_{t_{i+1}}^{q}-Y_{t_{i+1}}\right) \mid \mathcal{F}_{t}\right] \geqslant 0
$$

because $Y_{t_{i+1}}^{q} \geqslant Y_{t_{i+1}}$ by the recurrence's hypothesis.
Now we set ${ }^{t} q_{s}^{*} \in \partial_{z} g\left(s, Y_{s}, Z_{s}\right)$ with $\partial_{z} g\left(s, Y_{s}, Z_{s}\right)$ the subdifferential of $z \mapsto g\left(s, Y_{s}, z\right)$ at $Z_{s}$. We recall that for a convex function $l: \mathbb{R}^{1 \times d} \rightarrow \mathbb{R}$, the subdifferential of $l$ at $x_{0}$ is the non-empty convex compact set of $u \in \mathbb{R}^{1 \times d}$ such that

l(x)-l\left(x_{0}\right) \geqslant u^{t}\left(x-x_{0}\right), \quad \forall x \in \mathbb{R}^{1 \times d}
$$

We have $f\left(s, Y_{s}, q_{s}^{*}\right)=z q_{s}^{*}-g\left(s, Y_{s}, Z_{s}\right)$ for all $s \in[0, T]$, so

\begin{aligned}
g\left(s, Y_{s}, Z_{s}\right) & \leqslant Z_{s} q_{s}^{*}-\frac{1}{2 \bar{\gamma}}\left|q_{s}^{*}\right|^{2}+\bar{\beta}\left|Y_{s}\right|+\bar{\alpha}_{s} \\
& \leqslant \frac{1}{2}\left(2 \bar{\gamma}\left|Z_{s}\right|^{2}+\frac{\left|q_{s}^{*}\right|^{2}}{2 \bar{\gamma}}\right)-\frac{1}{2 \bar{\gamma}}\left|q_{s}^{*}\right|^{2}+\bar{\beta}\left|Y_{s}\right|+\bar{\alpha}_{s} \\
\frac{\left|q_{s}^{*}\right|^{2}}{4 \bar{\gamma}} & \leqslant-g\left(s, Y_{s}, Z_{s}\right)+\bar{\gamma}\left|Z_{s}\right|^{2}+\bar{\beta}\left|Y_{s}\right|+\bar{\alpha}_{s}
\end{aligned}
$$

and finally, $\int_{0}^{T}\left|q_{s}^{*}\right|^{2} d s<+\infty, \mathbb{P}$-a.s.. Moreover, $\forall t, t^{\prime} \in[0, T]$,

$$
Y_{t}=Y_{t^{\prime}}+\int_{t}^{t^{\prime}} f\left(s, Y_{s}, q_{s}^{*}\right) d s+\int_{t}^{t^{\prime}} Z_{s}\left(d W_{s}+q_{s}^{*} d s\right)
$$

Thus, we just have to show that $q^{*}$ is admissible to prove that $q^{*}$ is optimal, i.e. $Y=Y^{q^{*}}$. For this, we must prove that $\left(q_{s}^{*}\right)_{s \in\left[t_{i}, t_{i+1}\right]} \in \mathcal{A}_{t_{i}, t_{i+1}}\left(Y_{t_{i+1}}\right)$ for $i \in\{0, \ldots, N-1\}$. We define

$$
\begin{gathered}
M_{t}^{i}:=\exp \left(\int_{t_{i}}^{t} q_{s}^{*} d W_{s}-\frac{1}{2} \int_{t_{i}}^{t}\left|q_{s}^{*}\right|^{2} d s\right), \frac{d \mathbb{Q}^{*, i}}{d \mathbb{P}}:=M_{t_{i+1}}^{i}, \\
\tau_{n}^{i}=\inf \left\{t \in\left[t_{i}, t_{i+1}\right], \sup \left(\int_{t_{i}}^{t}\left|q_{s}^{*}\right|^{2} d s, \int_{t_{i}}^{t}\left|Z_{s}\right|^{2} d s\right)>n\right\} \wedge t_{i+1}, \quad \frac{d \mathbb{Q}_{n}^{*, i}}{d \mathbb{P}}:=M_{\tau_{n}^{i}}^{i} .
\end{gathered}
$$

Let us show the following lemma:
Lemma $3.4\left(M_{\tau_{n}^{i}}^{i}\right)_{n}$ is uniformly integrable.

Proof. Firstly, from

x y \leqslant \exp (x)+y(\log (y)-1), \quad \forall(x, y) \in \mathbb{R} \times \mathbb{R}^{+*}
$$

we deduce

x y=p x \frac{y}{p} \leqslant \exp (p x)+\frac{y}{p}(\log y-\log p-1) \tag{3.2}
\end{equation*}
$$

Thus

\begin{aligned}
\mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[A^{*}\right] & =\mathbb{E}\left[M_{\tau_{n}^{i}}^{i} A^{*}\right] \leqslant \mathbb{E}\left[\exp \left(p A^{*}\right)\right]+\frac{1}{p} \mathbb{E}\left[M_{\tau_{n}^{i}}^{i}\left(\log M_{\tau_{n}^{i}}^{i}-\log p-1\right)\right] \\
& \leqslant C_{p}+\frac{1}{2 p} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|q_{s}^{*}\right|^{2} d s\right]
\end{aligned}
$$

and, in the same manner,

$$
\mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\left(Y^{+}\right)^{*}\right] \leqslant C_{\varepsilon}+\frac{1}{2 \varepsilon} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|q_{s}^{*}\right|^{2} d s\right]
$$

Since $g\left(s, Y_{s}, Z_{s}\right)=Z_{s} q_{s}^{*}-f\left(s, Y_{s}, q_{s}^{*}\right)$ and $\left(M_{t \wedge \tau_{n}^{i}}^{i}\right)_{t \in\left[t_{i}, t_{i+1}\right]}$ is a martingale, we can apply the Girsanov theorem and we obtain

$$
\mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[Y_{\tau_{n}^{i}}+\int_{t_{i}}^{\tau_{n}^{i}} f\left(s, Y_{s}, q_{s}^{*}\right) d s\right]=\mathbb{E}_{n}^{\mathbb{Q}_{n}^{*, i}}\left[Y_{t_{i}}\right]=\mathbb{E}\left[M_{\tau_{n}^{i}}^{i} Y_{t_{i}}\right]=\mathbb{E}\left[Y_{t_{i}}\right]
$$

Moreover $f(t, y, q) \geqslant \frac{1}{2 \bar{\gamma}}|q|^{2}-\bar{\beta}|y|-\bar{\alpha}_{t}$ and $Y_{\tau_{n}^{i}} \geqslant-Y_{\tau_{n}^{i}}^{-}$, so

$$
\begin{aligned}
\mathbb{E}\left[Y_{t_{i}}\right] & \geqslant-\mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[Y_{\tau_{n}^{i}}^{-}\right]-\mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}} \bar{\alpha}_{s} d s\right]+\frac{1}{2 \bar{\gamma}} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|q_{s}^{*}\right|^{2} d s\right]-\bar{\beta} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|Y_{s}\right| d s\right] \\
& \geqslant C-\mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[A^{*}\right]+\frac{1}{2 \bar{\gamma}} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|q_{s}^{*}\right|^{2} d s\right]-\frac{T}{N}\left(\bar{\beta} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\left(Y^{-}\right)^{*}+\left(Y^{+}\right)^{*}\right]\right) \\
& \geqslant C_{p, \varepsilon}+\frac{1}{2} \underbrace{\left(\frac{1}{\bar{\gamma}}-\frac{1}{p}-\frac{T}{N}\left(\frac{\bar{\beta}}{p}+\frac{\bar{\beta}}{\varepsilon}\right)\right)}_{>0} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|q_{s}^{*}\right|^{2} d s\right] .
\end{aligned}
$$

This inequality explains why we take N verifying (3.1). Finally we get that

$$
\begin{equation*}
2 \mathbb{E}\left[M_{\tau_{n}^{i}}^{i} \log M_{\tau_{n}^{i}}^{i}\right]=\mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|q_{s}^{*}\right|^{2} d s\right] \leqslant C_{p, \varepsilon} \tag{3.3}
\end{equation*}
$$

Then we conclude the proof of the lemma by using the de La Vallée Poussin lemma.
Thanks to this lemma, we have that $\mathbb{E}\left[M_{t_{i+1}}^{i}\right]=1$ and so $\left(M_{t}^{i}\right)_{t \in\left[t_{i}, t_{i+1}\right]}$ is a Martingale. Moreover, applying Fatou's lemma and inequality (3.3), we obtain

2 \mathbb{E}\left[M_{t_{i+1}}^{i} \log M_{t_{i+1}}^{i}\right]=\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}}\left|q_{s}^{*}\right|^{2} d s\right] \leqslant \liminf _{n} \mathbb{E}^{\mathbb{Q}_{n}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}}\left|q_{s}^{*}\right|^{2} d s\right]<+\infty \tag{3.4}
\end{equation*}
$$

So, by using this result and inequality (3.2) we easily show that $\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\left(Y^{+}\right)^{*}+\left(Y^{-}\right)^{*}\right]<+\infty$. To conclude we have to prove that $\mathbb{E}^{\mathbb{Q}^{*}, i}\left[\int_{t_{i}}^{t_{i+1}}\left|f\left(s, 0, q_{s}^{*}\right)\right| d s\right]<+\infty$ :

\begin{aligned}
\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}}\left|f\left(s, 0, q_{s}^{*}\right)\right| d s\right] & \leqslant \mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}}\left|f\left(s, Y_{s}, q_{s}^{*}\right)\right|+K_{g, y}\left|Y_{s}\right| d s\right] \\
& \leqslant \mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}}\left|f\left(s, Y_{s}, q_{s}^{*}\right)\right| d s+K_{g, y} T\left(\left(Y^{+}\right)^{*}+\left(Y^{-}\right)^{*}\right)\right] \\
& \leqslant C+\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}} f^{+}\left(s, Y_{s}, q_{s}^{*}\right)+f^{-}\left(s, Y_{s}, q_{s}^{*}\right) d s\right]
\end{aligned}
$$

Firstly,

$$
\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}} f^{-}\left(s, Y_{s}, q_{s}^{*}\right) d s\right] \leqslant \mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}} \bar{\alpha}_{s}+\bar{\beta}\left|Y_{s}\right| d s\right]<+\infty
$$

Moreover, thanks to the Girsanov theorem we have

$$
\mathbb{E}^{\mathbb{Q}^{*, i}}\left[Y_{t_{i}}\right]=\mathbb{E}^{\mathbb{Q}^{*, i}}\left[Y_{\tau_{n}^{i}}+\int_{t_{i}}^{\tau_{n}^{i}} f\left(s, Y_{s}, q_{s}^{*}\right) d s\right]
$$

so

$$
\begin{aligned}
\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}} f^{+}\left(s, Y_{s}, q_{s}^{*}\right) d s\right] & \leqslant \mathbb{E}^{\mathbb{Q}^{*, i}}\left[Y_{t_{i}}-Y_{\tau_{n}^{i}}\right]+\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{\tau_{n}^{i}} f^{-}\left(s, Y_{s}, q_{s}^{*}\right) d s\right] \\
& \leqslant C+\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}} f^{-}\left(s, Y_{s}, q_{s}^{*}\right) d s\right] \leqslant C
\end{aligned}
$$

Finally, $\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}} f^{+}\left(s, Y_{s}, q_{s}^{*}\right) d s\right]<+\infty$ and $\mathbb{E}^{\mathbb{Q}^{*, i}}\left[\int_{t_{i}}^{t_{i+1}}\left|f\left(s, 0, q_{s}^{*}\right)\right| d s\right]<+\infty$. Thus, we prove that $q^{*}$ is optimal, i.e. $Y^{q^{*}}=Y$.

The uniqueness of $Y$ is a mere consequence of the fact that $Y=Y^{q^{*}}=\operatorname{ess}_{\inf }^{q \in \mathcal{A}} 1 Y^{q}$. The uniqueness of $Z$ follows immediately.
Remark 3.5 By taking into consideration the inequality (3.4) it is possible to restrict the admissible control set by considering

$$
\tilde{\mathcal{A}}_{t_{i}, t_{i+1}}(\eta):=\mathcal{A}_{t_{i}, t_{i+1}}(\eta) \cap\left\{\left(q_{s}\right)_{s \in\left[t_{i}, t_{i+1}\right]}, \quad \mathbb{E}^{\mathbb{Q}^{i}}\left[\int_{t_{i}}^{t_{i+1}}\left|q_{s}\right|^{2} d s\right]<+\infty\right\}
$$

instead of $\mathcal{A}_{t_{i}, t_{i+1}}(\eta)$.
Remark 3.6 If we have $g(t, y, z) \leqslant g(t, 0, z)$, then $f(t, y, q) \geqslant f(t, 0, q) \geqslant \frac{1}{2 \tilde{\gamma}}|q|^{2}-\bar{\alpha}_{t}$ and we do not have to introduce $N$ in the proof of lemma 3.4. So we have a simpler representation theorem:

$$
Y_{t}=\underset{q \in \mathcal{A}_{0, T}(\xi)}{\operatorname{ess} \inf } Y_{t}^{q}, \quad \forall t \in[0, T]
$$

For example, when $g$ is independent of $y$, we obtain

$$
Y_{t}=\underset{q \in \mathcal{A}_{0, T}(\xi)}{\operatorname{ess} \inf } \mathbb{E}^{\mathbb{Q}}\left[\xi+\int_{t}^{T} f\left(s, q_{s}\right) d s \mid \mathcal{F}_{t}\right], \quad \forall t \in[0, T]
$$

## 4 Application to quadratic PDEs

In this section we give an application of our results concerning BSDEs to PDEs which are quadratic with respect to the gradient of the solution. Let us consider the following semilinear PDE

$$
\begin{equation*}
\partial_{t} u(t, x)+\mathcal{L} u(t, x)-g\left(t, x, u(t, x),-\sigma^{*} \nabla_{x} u(t, x)\right)=0, \quad u(T, .)=h, \tag{4.1}
\end{equation*}
$$

where $\mathcal{L}$ is the infinitesimal generator of the diffusion $X^{t, x}$ solution to the SDE

$$
\begin{equation*}
X_{s}^{t, x}=x+\int_{t}^{s} b\left(u, X_{u}^{t, x}\right) d s+\int_{t}^{s} \sigma(u) d W_{u}, \quad t \leqslant s \leqslant T, \text { and } X_{s}^{t, x}=x, \quad s \leqslant t \tag{4.2}
\end{equation*}
$$

The nonlinear Feynman-Kac formula consists in proving that the function defined by the formula

$$
\begin{equation*}
\forall(t, x) \in[0, T] \times \mathbb{R}^{d}, \quad u(t, x):=Y_{t}^{t, x} \tag{4.3}
\end{equation*}
$$

where, for each $\left(t_{0}, x_{0}\right) \in[0, T] \times \mathbb{R}^{d},\left(Y^{t_{0}, x_{0}}, Z^{t_{0}, x_{0}}\right)$ stands for the solution to the following BSDE

$$
\begin{equation*}
Y_{t}=h\left(X_{T}^{t_{0}, x_{0}}\right)-\int_{t}^{T} g\left(s, X_{s}^{t_{0}, x_{0}}, Y_{s}, Z_{s}\right) d s-\int_{t}^{T} Z_{s} d W_{s}, \quad 0 \leqslant t \leqslant T \tag{4.4}
\end{equation*}
$$

is a solution, at least a viscosity solution, to the PDE (4.1).
Assumption (A.3). Let $b:[0, T] \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ and $\sigma:[0, T] \rightarrow \mathbb{R}^{d \times d}$ be continuous functions and let us assume that there exists $K \geqslant 0$ such that:

1. for all $t \in[0, T],|b(t, 0)| \leqslant K$, and

$$
\forall\left(x, x^{\prime}\right) \in \mathbb{R}^{d} \times \mathbb{R}^{d}, \quad\left|b(t, x)-b\left(t, x^{\prime}\right)\right| \leqslant K\left|x-x^{\prime}\right|
$$

2. $\sigma$ is bounded.

## Lemma 4.1

We define $\tilde{\lambda}:=\lambda(1+\varepsilon) e^{2 K T}$. It follows from the Dambis-Dubins-Schwarz representation theorem and the Doob's maximal inequality that

With this observation in hands, we can give our assumptions on the nonlinear term of the PDE and the terminal condition.

Thanks to Lemma 4.1, we see that there exist $q>\gamma e^{\beta T}$ and $\varepsilon>0$ such that $h^{-}\left(X_{T}^{t_{0}, x_{0}}\right)+\int_{0}^{T}(C+$ $\left.\alpha\left|X_{t}^{t_{0}, x_{0}}\right|^{2}\right) d t$ has an exponential moment of order $q$ and $h^{+}\left(X_{T}^{t_{0}, x_{0}}\right)+\int_{0}^{T}\left(r+r\left|X_{t}^{t_{0}, x_{0}}\right|^{2}\right) d t$ has an exponential moment of order $\varepsilon$. So we are able to apply Corollary 2.2 and Theorem 3.3 to construct a unique solution $\left(Y^{t_{0}, x_{0}}, Z^{t_{0}, x_{0}}\right)$ to the $\operatorname{BSDE}$ (4.4). Let us prove that $u$ is a viscosity solution to the PDE 4.1.
Proposition 4.2 Let assumptions (A.3) and (A.4) hold. The function $u$ defined by (4.3) is continuous on $[0, T] \times \mathbb{R}^{d}$ and satisfies

We have already notice in Remark 3.6 that we have a simpler representation theorem when $T$ is small enough to take $N=1$ in (3.1). So we define a constant $T_{1}>0$ such that for all $T \in\left[0, T_{1}\right]$ we are allowed to set $N=1$. We will reuse notations of section 3. By using Remark 3.5. for all $T \in\left[0, T_{1}\right], t \in[0, T]$, $x \in \mathbb{R}^{d}$, we define the admissible control set

& \left(M_{t}\right)_{t \in[0, T]} \text { is a martingale, } \quad \mathbb{E}^{\mathbb{Q}}\left[\left|h\left(X_{T}^{t, x}\right)\right|+\int_{0}^{T}\left|f\left(s, X_{s}^{t, x}, 0, q_{s}\right)\right| d s\right]<+\infty \\
& \text { with } \left.M_{t}:=\exp \left(\int_{0}^{t} q_{s} d W_{s}-\frac{1}{2} \int_{0}^{t}\left|q_{s}\right|^{2} d s\right) \text { and } \frac{d \mathbb{Q}}{d \mathbb{P}}:=M_{T}\right\} .
\end{aligned}
$$

We will prove a first lemma and then we will use it to show that this admissible control set does not depend on $t$ and $x$.

& +\frac{1}{2 \gamma} \mathbb{E}^{\mathbb{Q}^{*}}\left[\int_{0}^{T}\left|q_{u}^{*}\right|^{2} d u\right]-\alpha \mathbb{E}^{\mathbb{Q}^{*}}\left[\int_{0}^{T}\left|X_{s}^{t, x}\right|^{2} d s\right]-\beta \mathbb{E}^{\mathbb{Q}^{*}}\left[\int_{0}^{T}\left|Y_{s}^{t, x}\right| d s\right] .
\end{aligned}

& \leqslant C\left(\left|t^{\prime}-t\right|+\left|t^{\prime}-t\right| \int_{t}^{t^{\prime}} \mathbb{E}^{\mathbb{Q}}\left[\left|X_{u}^{t, x^{\prime}}\right|^{2}\right] d u+\left|t^{\prime}-t\right| \int_{t}^{t^{\prime}} \mathbb{E}^{\mathbb{Q}}\left[\left|q_{u}\right|^{2}\right] d u\right) \\

Let us begin with the fist term. We define $r:=|x| \vee\left|x_{0}\right|$.Thanks to the representation theorem, we have

$$
Y_{t}^{t, x}=\underset{q \in \mathcal{A}_{0, T}^{r}}{\operatorname{ess} \inf } Y_{t}^{q, t, x} \quad \text { and } \quad Y_{t}^{t, x_{0}}=\underset{q \in \mathcal{A}_{0, T}^{r}}{\operatorname{ess} \inf } Y_{t}^{q, t, x_{0}} .
$$

So,

$$
\left|Y_{t}^{t, x}-Y_{t}^{t, x_{0}}\right| \leqslant \underset{q \in \mathcal{A}_{0, T}^{r}}{\operatorname{ess} \sup }\left|Y_{t}^{q, t, x}-Y_{t}^{q, t, x_{0}}\right| .
$$

But, for $t \leqslant s \leqslant T$,

$$
\begin{aligned}
\left|Y_{s}^{q, t, x}-Y_{s}^{q, t, x_{0}}\right|= & \mid \mathbb{E}^{\mathbb{Q}}\left[h\left(X_{T}^{t, x}\right)-h\left(X_{T}^{t, x_{0}}\right)\right. \\
& \left.+\int_{s}^{T}\left(f\left(u, X_{u}^{t, x}, Y_{u}^{q, t, x}, q_{u}\right)-f\left(u, X_{u}^{t, x_{0}}, Y_{u}^{q, t, x_{0}}, q_{u}\right)\right) d u \mid \mathcal{F}_{s}\right] \mid \\
\leqslant & \mathbb{E}^{\mathbb{Q}}\left[C\left(1+\left|X_{T}^{t, x}\right|^{2}+\left|X_{T}^{t, x_{0}}\right|^{2}\right)\right]^{1 / 2} \mathbb{E}^{\mathbb{Q}}\left[\left|X_{T}^{t, x}-X_{T}^{t, x_{0}}\right|^{2}\right]^{1 / 2} \\
& +\int_{s}^{T} \mathbb{E}^{\mathbb{Q}}\left[C\left(1+\left|X_{u}^{t, x}\right|^{2}+\left|X_{u}^{t, x_{0}}\right|^{2}\right)\right]^{1 / 2} \mathbb{E}^{\mathbb{Q}}\left[\left|X_{u}^{t, x}-X_{u}^{t, x_{0}}\right|^{2}\right]^{1 / 2} d u \\
& +C \int_{s}^{T} \mathbb{E}^{\mathbb{Q}}\left[\left|Y_{u}^{q, t, x}-Y_{u}^{q, t, x_{0}}\right|\right] d u,
\end{aligned}
$$

thanks to Assumption (A.4) and Hölder's inequality. According to Lemma 4.3, the definition of $\mathcal{A}_{0, T}^{r}$ and Proposition 4.7, we obtain

$$
\mathbb{E}^{\mathbb{Q}}\left[\left|Y_{s}^{q, t, x}-Y_{s}^{q, t, x_{0}}\right|\right] \leqslant C\left(1+|x|^{2}+\left|x_{0}\right|^{2}\right)^{1 / 2}\left|x-x_{0}\right|+C \int_{s}^{T} \mathbb{E}^{\mathbb{Q}}\left[\left|Y_{u}^{q, t, x}-Y_{u}^{q, t, x_{0}}\right|\right] d u
$$

Then, Gronwall's lemma gives us $\left|Y_{t}^{q, t, x}-Y_{t}^{q, t, x_{0}}\right| \leqslant C\left(1+|x|+\left|x_{0}\right|\right)\left|x-x_{0}\right|$. Since this bound is independent of $q$, we finally obtain that

$$
\left|Y_{t}^{t, x}-Y_{t}^{t, x_{0}}\right| \leqslant C\left(1+|x|+\left|x_{0}\right|\right)\left|x-x_{0}\right| .
$$

Now, we will study the second term. Without loss of generality, let us assume that $t<t_{0}$.

$$
\begin{aligned}
\left|Y_{t}^{t, x_{0}}-Y_{t_{0}}^{t_{0}, x_{0}}\right| & \leqslant\left|Y_{t}^{t, x_{0}}-Y_{t}^{t_{0}, x_{0}}\right|+\int_{t}^{t_{0}}\left|g\left(s, x_{0}, Y_{s}^{t_{0}, x_{0}}, 0\right)\right| d s \\
& \leqslant\left|Y_{t}^{t, x_{0}}-Y_{t}^{t_{0}, x_{0}}\right|+\int_{t}^{t_{0}} C\left(1+\left|x_{0}\right|^{2}+\left|Y_{s}^{t_{0}, x_{0}}\right|\right) d s
\end{aligned}
$$

We apply Proposition 4.6 to obtain

$$
\left|Y_{t}^{t, x_{0}}-Y_{t_{0}}^{t_{0}, x_{0}}\right| \leqslant\left|Y_{t}^{t, x_{0}}-Y_{t}^{t_{0}, x_{0}}\right|+C\left(1+\left|x_{0}\right|^{2}\right)\left(t-t_{0}\right)
$$

We still have

$$
\left|Y_{t}^{t, x_{0}}-Y_{t}^{t_{0}, x_{0}}\right| \leqslant \underset{q \in \mathcal{A}_{0, T}^{r}}{\operatorname{ess} \sup }\left|Y_{t}^{q, t, x_{0}}-Y_{t}^{q, t_{0}, x_{0}}\right|
$$

Moreover, exactly as the bound estimation for $\mathbb{E}^{\mathbb{Q}}\left|Y_{s}^{q, t, x}-Y_{s}^{q, t, x_{0}}\right|$, we have, for $t \leqslant s \leqslant T$,

$$
\begin{aligned}
\mathbb{E}^{\mathbb{Q}}\left[\left|Y_{s}^{q, t, x_{0}}-Y_{s}^{q, t_{0}, x_{0}}\right|\right] \leqslant & \mathbb{E}^{\mathbb{Q}}\left[C\left(1+\left|X_{T}^{t, x_{0}}\right|^{2}+\left|X_{T}^{t_{0}, x_{0}}\right|^{2}\right)\right]^{1 / 2} \mathbb{E}^{\mathbb{Q}}\left[\left|X_{T}^{t, x_{0}}-X_{T}^{t_{0}, x_{0}}\right|^{2}\right]^{1 / 2} \\
& +\int_{s}^{T} \mathbb{E}^{\mathbb{Q}}\left[C\left(1+\left|X_{u}^{t, x_{0}}\right|^{2}+\left|X_{u}^{t_{0}, x_{0}}\right|^{2}\right)\right]^{1 / 2} \mathbb{E}^{\mathbb{Q}}\left[\left|X_{u}^{t, x_{0}}-X_{u}^{t_{0}, x_{0}}\right|^{2}\right]^{1 / 2} d u \\
& +C \int_{s}^{T} \mathbb{E}^{\mathbb{Q}}\left[\left|Y_{u}^{q, t, x_{0}}-Y_{u}^{q, t_{0}, x_{0}}\right|\right] d u .
\end{aligned}
$$

According to Lemma 4.3, the definition of $\mathcal{A}_{0, T}^{r}$, Proposition 4.7 and Gronwall's Lemma, we obtain $\left|Y_{t}^{q, t, x_{0}}-Y_{t}^{q, t_{0}, x_{0}}\right| \leqslant C\left(1+|x|^{2}+\left|x_{0}\right|^{2}\right)\left|t-t_{0}\right|^{1 / 2}$. Since this bound is independent of $q$, we finally obtain that

$$
\left|Y_{t}^{t, x}-Y_{t}^{t, x_{0}}\right| \leqslant C\left(1+|x|^{2}+\left|x_{0}\right|^{2}\right)\left|t-t_{0}\right|^{1 / 2}
$$

So,

$$
\left|u(t, x)-u\left(t_{0}, x_{0}\right)\right| \leqslant C\left(1+|x|+\left|x_{0}\right|\right)\left|x-x_{0}\right|+C\left(1+|x|^{2}+\left|x_{0}\right|^{2}\right)\left|t-t_{0}\right|^{1 / 2} .
$$

We now return to the general case (for $T$ ) : we set $N \in \mathbb{N}$ such that $T / N<T_{2}$ and, for $i \in\{0, \ldots, N\}$, we define $t_{i}:=i T / N$. According to the beginning of the proof, $u$ is continuous on $\left[t_{N-1}, T\right] \times \mathbb{R}^{d}$. We define $h_{N-1}(x):=Y_{t_{N-1}}^{t_{N-1}, x}$. Since $\left|h_{N-1}(x)-h_{N-1}\left(x^{\prime}\right)\right| \leqslant C\left(1+|x|+\left|x^{\prime}\right|\right)\left|x-x^{\prime}\right|$, we are allowed to reuse previous results to show the continuity of $u$ on $\left[t_{N-2}, T_{N-1}\right] \times \mathbb{R}^{d}$. Thus, we can iterate this argument to show the continuity of $u$ on $[0, T] \times \mathbb{R}^{d}$. Moreover the quadratic increase of $u$ with respect to the variable $x$ results from the quadratic increase of $u$ on each interval.

Finally, we will use a stability result to show that $u$ is a viscosity solution to the PDE (4.1). As in the proof of Theorem 2.1, let us consider the function

$$
g_{n}(t, x, y, z):=\inf \left\{g(t, x, p, q)+n|p-y|+n|q-z|,(p, q) \in \mathbb{Q}^{1+d}\right\}
$$

We have already seen that $\left(g_{n}\right)_{n \geqslant\lceil r\rceil}$ is increasing and converges uniformly on compact sets to $g$. Let $\left(Y^{n, t, x}, Z^{n, t, x}\right)$ be the unique solution in $\mathcal{S}^{2} \times M^{2}$ to $\operatorname{BSDE}\left(h\left(X_{T}^{t, x}\right),-g_{n}\left(., X^{t, x}, .,.\right)\right)$. We define $u_{n}(t, x):=Y_{t}^{n, t, x}$. Then by a classical theorem (see e.g. [7]), $u_{n}$ is a viscosity solution to the PDE

$$
\partial_{t} u(t, x)+\mathcal{L} u(t, x)-g_{n}\left(t, x, u(t, x),-\sigma^{*} \nabla_{x} u(t, x)\right)=0, \quad u(T, .)=h .
$$

Moreover, it follows from the classical comparison theorem that $\left(u_{n}\right)_{n \geqslant\lceil r\rceil}$ is decreasing and, by construction, converges pointwise to $u$. Since $u$ is continuous, Dini's theorem implies that the convergence is also uniform on compacts sets. Then, we apply a stability result (see e.g. Theorem 1.7. of chapter 5 in [1]) to prove that $u$ is a viscosity solution to the PDE (4.1).

Remark. The uniqueness of viscosity solution to PDE is considered by Da Lio and Ley in [6] and [5].
