# Embeddings of the braid groups of covering spaces, classification of the finite subgroups of the braid groups of the real projective plane, and linearity of braid groups of low-genus surfaces

#### **Abstract**

Let *M* be a compact, connected surface, possibly with a finite set of points removed from its interior. Let  $d, n \in \mathbb{N}$ , and let  $\overline{M}$  be a  $d$ -fold covering space of  $M$ . We show that the covering map induces an embedding of the  $n^{\text{th}}$  braid group  $B_n(M)$  of *M* in the *dn*<sup>th</sup> braid group  $B_{dn}(\widetilde{M})$  of  $\widetilde{M}$ , and give several applications of this result. First, we classify the finite subgroups of the *n*<sup>th</sup> braid group of the real projective plane, from which we deduce an alternative proof of the classification of the finite subgroups of the mapping class group of the *n*-punctured real projective plane due to Bujalance, Cirre and Gamboa. Secondly, using the linearity of *B<sup>n</sup>* due to Bigelow and Krammer, we show that the braid groups of compact, connected surfaces of low genus are linear.

### <span id="page-2-0"></span>**1 Introduction**

The braid groups  $B_n$  of the plane were introduced by E. Artin in 1925 [[A1,](#page-15-0) [A2\]](#page-16-0). Braid groups of surfaces were studied by Zariski [\[Z](#page-17-0)]. They were later generalised by Fox to braid groups of arbitrary topological spaces via the following definition [\[FoN](#page-16-0)]. Let *M* be a compact, connected surface, and let  $n \in \mathbb{N}$ . We denote the set of all ordered *n*-tuples of distinct points of *M*, known as the *n th configuration space of M*, by:

$$
F_n(M) = \{(p_1, \ldots, p_n) \mid p_i \in M \text{ and } p_i \neq p_j \text{ if } i \neq j\}.
$$

Configuration spaces play an important rôle in several branches of mathematics and have been extensively studied, see [[CG, FH](#page-16-0)] for example.

The symmetric group  $S_n$  on *n* letters acts freely on  $F_n(M)$  by permuting coordinates. The corresponding quotient will be denoted by  $D_n(M)$ , and will be termed the  $n^{th}$  *permuted configuration space of M.* The  $n^{th}$  *pure braid group*  $P_n(M)$  *(respectively the*  $n^{th}$  *braid group*  $B_n(M)$ *) is defined to be the fundamental group of*  $F_n(M)$  *(respectively of D<sub>n</sub>*(*M*)). If *N* is a subsurface of *M* and  $m \ge 0$ , Paris and Rolfsen study the homomorphism  $B_n(N) \longrightarrow B_{n+m}(M)$  of braid groups induced by inclusion of *N* in *M*, and give necessary and sufficient conditions for it to be injective [\[PR\]](#page-17-0). In this paper, we study the relationship between the braid groups of covering spaces. In Section [2](#page-5-0), we prove the following result which we hope will be useful in the understanding of various aspects of surface braid groups, especially the relationship between the braid groups of a non-orientable surface and those of its orientable double covering.

THEOREM 1. *Let M be a compact, connected surface, possibly with a finite set of points removed from its interior.* Let  $d, n \in \mathbb{N}$ , and let  $\overline{M}$  be a d-fold covering space of M. Then the *covering map induces an embedding of the n<sup>th</sup> braid group*  $B_n(M)$  *of M in the dn<sup>th</sup> braid group*  $B_{dn}(M)$  of  $\overline{M}$ .

We have the following immediate consequence of Theorem 1:

COROLLARY 2. Let  $n \in \mathbb{N}$ . The  $n^{th}$  braid group of a non-orientable surface embeds in the  $2n^{th}$ braid group of its orientable double cover. In particular,  $B_n(\mathbb{R}P^2)$  embeds in  $B_{2n}(\mathbb{S}^2).$ 

Note however that if  $n \geq 2$ , such an embedding does not restrict to an embedding of the corresponding pure braid subgroups since  $P_n(\mathbb{R}P^2)$  has torsion 4 (see Proposi-tion [3\(d\)](#page-3-0)) and  $P_{2n}(\mathbb{S}^2)$  has torsion 2.

Together with the 2-sphere  $\mathbb{S}^2$ , the braid groups of the real projective plane  $\mathbb{R}P^2$ are of particular interest, notably because they have non-trivial centre [\[VB,](#page-17-0) [GG2\]](#page-16-0), and torsion elements [\[VB](#page-17-0), [Mu\]](#page-17-0). Indeed, Van Buskirk showed that S <sup>2</sup> and R*P* <sup>2</sup> are the only surfaces whose braid groups have torsion [\[VB](#page-17-0)]. Let us recall briefly some properties of  $B_n(\mathbb{R}P^2)$ .

If  $\mathbb{D}^2 \subseteq \mathbb{R}P^2$  is a topological disc, there is a group homomorphism  $\iota\colon\thinspace B_n \longrightarrow B_n(\mathbb{R}P^2)$ induced by the inclusion. If  $\beta \in B_n$  then we shall denote its image  $\iota(\beta)$  simply by  $\beta$ . In

<span id="page-3-0"></span>Proposition [13,](#page-12-0) we recall a presentation of  $B_n(\mathbb{R}P^2)$  due to Van Buskirk [\[VB](#page-17-0)]. In [[GG3](#page-16-0)], a presentation of  $P_n(\mathbb{R}P^2)$  was given, and the splitting problem for the Fadell-Neuwirth short exact sequence of its pure braid groups was solved. The first two braid groups of  $\mathbb{R}P^2$  are finite:  $B_1(\mathbb{R}P^2) = P_1(\mathbb{R}P^2) \cong \mathbb{Z}_2$ ,  $P_2(\mathbb{R}P^2)$  is isomorphic to the quaternion group  $\mathfrak{Q}_8$  of order 8, and  $\mathcal{B}_2(\mathbb{R}P^2)$  is isomorphic to the generalised quaternion group of order 16. For  $n \ge 3$ ,  $B_n(\mathbb{R}P^2)$  is infinite. The pure braid group  $P_3(\mathbb{R}P^2)$  is isomorphic to a semi-direct product of a free group of rank 2 by  $\mathcal{Q}_8$  [\[VB](#page-17-0)]; an explicit action was given in [[GG2](#page-16-0)].

The so-called 'full twist' braid of  $B_n(\mathbb{R}P^2)$  is defined by  $\Delta_n^2 = (\sigma_1 \cdots \sigma_{n-1})^n$ , where  $\sigma_1, \ldots, \sigma_{n-1}$  are the standard generators of  $B_n$ , and is the square of the 'half twist' braid ∆*<sup>n</sup>* defined by

$$
\Delta_n = (\sigma_1 \cdots \sigma_{n-1})(\sigma_1 \cdots \sigma_{n-2}) \cdots (\sigma_1 \sigma_2)\sigma_1.
$$
 (1)

For *n*  $\geq$  2, Murasugi showed that  $\Delta_n^2$  generates the centre of  $B_n(\mathbb{R}P^2)$ , and he characterised the finite order elements of  $B_n(\mathbb{R}P^2)$  [[Mu](#page-17-0)], although their orders are not clear, even for elements of  $P_n(\mathbb{R}P^2)$ . In [\[GG2,](#page-16-0) [GG7](#page-17-0)], we proved the following results that include the classification of the finite subgroups of  $P_n(\mathbb{R}P^2)$ :

PROPOSITION 3 ([\[GG2](#page-16-0), [GG7\]](#page-17-0)). Let  $n \geq 2$ . Then:

- *(a)*  $B_n(\mathbb{R}P^2)$  has an element of order  $\ell$  if and only if  $\ell$  divides either 4*n* or 4 $(n-1)$ .
- *(b)* the (non-trivial) torsion of  $P_n(\mathbb{R}P^2)$  is precisely 2 and 4.
- *(c)* the full twist  $\Delta_n^2$  is the unique element of  $B_n(\mathbb{R}P^2)$  of order 2.

*(d)* up to isomorphism, the maximal finite subgroups of  $P_n(\mathbb{R}P^2)$  are  $\mathcal{Q}_8$  if  $n = 2, 3$ , and  $\mathbb{Z}_4$  if  $n \geqslant 4$ *.* 

*(e)* if  $n \geqslant 3$ , then up to isomorphism, the infinite virtually cyclic subgroups of  $P_n(\mathbb{R}P^2)$  are  $\mathbb{Z}$ ,  $\mathbb{Z}_2 \times \mathbb{Z}$  and  $\mathbb{Z}_4 *_{\mathbb{Z}_2} \mathbb{Z}_4$ .

For  $m \ge 2$ , let Dic<sub>4m</sub> denote the dicyclic group of order 4*m*. It has the following presentation:

$$
\text{Dic}_{4m}=\left\langle x,y\right| x^m=y^2,\ yxy^{-1}=x^{-1}\left.\right\rangle.
$$

The classification of the finite subgroups of  $B_n(\mathbb{S}^2)$  and  $B_n(\mathbb{R}P^2)$  is an interesting problem, and helps us to better understand their group structure. In the case of  $\mathbb{S}^2$ , this was undertaken in [\[GG4](#page-16-0), [GG5\]](#page-16-0):

THEOREM 4 ([\[GG5\]](#page-16-0)). Let  $n \geqslant 3$ . The maximal finite subgroups of  $B_n(\mathbb{S}^2)$  are:

- *(a)*  $\mathbb{Z}_{2(n-1)}$  *if*  $n \ge 5$ *.*
- (b)  $Dic_{4n}$ .
- *(c)*  $Dic_{4(n-2)}$  *if*  $n = 5$  *or*  $n \ge 7$ *.*
- *(d)* the binary tetrahedral group, denoted by  $T^*$ , if  $n \equiv 4 \pmod{6}$ .
- *(e)* the binary octahedral group, denoted by  $O^*$  , if  $n \equiv 0, 2 \pmod{6}$ .
- *(f)* the binary icosahedral group, denoted by  $I^*$ , if  $n \equiv 0, 2, 12, 20 \pmod{30}$ .

<span id="page-4-0"></span>More information concerning the binary polyhedral groups  $T^*$ ,  $O^*$  and  $I^*$  may be found in [\[AM\]](#page-15-0). The result of Theorem [4](#page-3-0) leads us to ask which finite groups are realised as subgroups of  $B_n(\mathbb{R}P^2)$ . As in the case of  $B_n(\mathbb{S}^2)$ , one common property of such subgroups is that they are finite periodic groups of cohomological period 2 or 4. Indeed, by [\[GG2](#page-16-0), Proposition 6], for all  $n \ge 2$ , the universal covering X of  $F_n(\mathbb{R}P^2)$  is a finitedimensional complex which has the homotopy type of  $\mathbb{S}^3$ . Thus any finite subgroup of  $B_n(\mathbb{R}P^2)$  acts freely on *X*, and so has period 2 or 4 by [[Br,](#page-16-0) Proposition 10.2, Section 10, Chapter VII]. Since  $\Delta_n^2$  is the unique element of order 2 of  $B_n(\mathbb{R}P^2)$ , and it generates the centre of  $B_n(\mathbb{R}P^2)$ , the Milnor property must be satisfied for any finite subgroup of  $B_n(\mathbb{R}P^2)$ . As an application of Corollary [2,](#page-2-0) we classifiy the finite subgroups of  $\overline{B}_n(\mathbb{R}P^2)$ .

THEOREM 5. Let  $n \geq 2$ . The maximal finite subgroups of  $B_n(\mathbb{R}P^2)$  are isomorphic to the *following groups:*

- *(a) Dic*8*n.*
- *(b)*  $Dic_{8(n-1)}$  *if*  $n \ge 3$ *.*
- *(c)*  $O^*$  *if*  $n \equiv 0, 1 \pmod{3}$ *.*
- *(d)* I<sup>\*</sup> *if*  $n \equiv 0, 1, 6, 10 \pmod{15}$ *.*

The proof of Theorem 5 is given in Section [3,](#page-9-0) and is obtained by combining Corollary [2](#page-2-0) with Theorem [4](#page-3-0). In this way, we obtain a list of possible finite subgroups of  $B_n(\mathbb{R}P^2)$  in Section [3.1.](#page-10-0) Some of these possibilities are not realised (notably  $T^*$  is not realised if  $n \equiv 2 \pmod{3}$ , despite apparently being compatible with the embedding). The final step is to prove that the subgroups given in the statement of Theorem 5 are indeed realised for the given values of *n*. This is achieved in Section [3.2](#page-10-0) using the geo-metric constructions of [[GG5\]](#page-16-0) of the finite subgroups of  $B_n(\mathbb{S}^2)$ , as well as Corollary [2](#page-2-0) and the following short exact sequence due to Scott [\[Sc](#page-17-0)], which exists if  $n \geq 2$ :

$$
1 \longrightarrow \left\langle \Delta_n^2 \right\rangle \longrightarrow B_n(\mathbb{R}P^2) \longrightarrow \mathcal{MCG}(\mathbb{R}P^2, n) \longrightarrow 1,
$$
 (2)

where  $\text{MCG}(\mathbb{R}P^2, n)$  denotes the *mapping class group* of the projective plane relative to the *n*-point subset X that consists of the basepoints of the strands of  $B_n(\mathbb{R}P^2)$ , that is, the set of isotopy classes of homeomorphisms of R*P* 2 that leave *X* invariant (we allow the points of *X* to be permuted). In Section [4,](#page-12-0) we give explicit algebraic realisations of the dicyclic subgroups of  $B_n(\mathbb{R}P^2)$  in terms of Van Buskirk's presentation of  $B_n(\mathbb{R}P^2)$  [\[VB](#page-17-0)].

The finite subgroups of  $\mathcal{MCG}(\mathbb{R}P^2, n)$  were classified by Bujalance, Cirre and Gamboa [[BCG\]](#page-16-0). In Section [3.3](#page-12-0), we use Theorem 5 and equation (2) to obtain an alternative proof of their result.

THEOREM 6 ([[BCG\]](#page-16-0)). Let  $n \geq 2$ . The maximal finite subgroups of  $\mathcal{MCS}(\mathbb{R}P^2, n)$  are isomor*phic to the following groups:*

- *(a) the dihedral group Dih*4*<sup>n</sup> of order* 4*n.*
- *(b)* the dihedral group  $Dih_{4(n-1)}$  if  $n \geq 3$ .
- *(c)*  $S_4$  *if*  $n \equiv 0, 1 \pmod{3}$ .
- *(d)*  $A_5$  *if*  $n \equiv 0, 1, 6, 10 \pmod{15}$ *.*

<span id="page-5-0"></span>Another application of Theorem [1](#page-2-0) concerns the linearity of certain surface braid groups. Recall that a group is said to be *linear* if it admits a faithful representation in a multiplicative group of matrices over some field. Krammer [\[Kr1](#page-17-0), [Kr2](#page-17-0)] and Bigelow [\[Bi](#page-16-0)] showed that  $B_n$  is linear. The linearity of  $\mathcal{MCS}(\mathbb{S}^2, n)$  was proved in [\[Ba, BB,](#page-16-0) [Ko](#page-17-0)], and that of  $B_n(\mathbb{S}^2)$  was obtained in [\[Ba](#page-16-0), [BB\]](#page-16-0). If  $n \leq 2$  then  $B_n(\mathbb{R}P^2)$  is linear because it is finite, while  $B_3(\mathbb{R}P^2)$  is known to be isomorphic to a subgroup of  $\text{GL}(96,\mathbb{Z})$  [[Ba](#page-16-0)]. To the best of our knowledge, nothing is known about the linearity of  $n^{\text{th}}$  braid groups,  $n \geq 2$ , for other surfaces (in the case  $n = 1$ , surface groups are known to be linear). In Section [5](#page-15-0) we give a short alternative proof in Proposition [17](#page-15-0) of the linearity of  $B_n(\mathbb{S}^2)$ , and with the aid of Corollary [2](#page-2-0), we deduce the following results.

THEOREM 7. Let  $n \in \mathbb{N}$ .

*(a) Let M be a compact, connected surface, possibly with boundary, of genus zero if M is orientable, and of genus one if* M *is non-orientable. Then*  $B_n(M)$  *is linear.* (b) Let  $\mathbb{T}^2$  denote the 2-torus, and let  $x \in \mathbb{T}^2$ . Then  $B_{n+1}(\mathbb{T}^2)$  is linear if and only if  $B_n(\mathbb{T}^2\setminus\{x\})$ is linear. Consequently,  $B_2(\mathbb{T}^2)$  is linear.

In particular, the braid groups of  $\mathbb{R}P^2$  and the Möbius band are linear.

## **2 Embeddings of the braid groups of coverings**

Let *N* be a compact, connected surface, let *X* be an *r*-point subset in the interior of *N*, where  $r \ge 0$ , and let  $M = N \setminus X$ . Let  $d, n \in \mathbb{N}$ , and let  $p: M \longrightarrow M$  be a *d*-fold covering map of *M*. The aim of this section is to prove Theorem [1](#page-2-0). We use the covering map *p* to construct a map  $\psi_n$ :  $D_n(M) \longrightarrow D_{dn}(\widetilde{M})$  of configuration spaces, and then go on

<span id="page-6-0"></span>to show that  $\psi_n$  induces an injective homomorphism  $\psi_{n\#}$ :  $B_n(M) \longrightarrow B_{dn}(\widetilde{M})$ . This homomorphism may be used to compare the braid groups of *M* with those of *M*, and its existence seems like an interesting fact in its own right.

Let  $z_1, \ldots, z_n$  be *n* base points lying in a small disc in the interior of *M*. Given a subset *A* of *n* distinct unordered points in *M* (an element of  $D_n(M)$  in other words),  $p^{-1}(A)$  is a subset of  $\widetilde{M}$  consisting of *dn* distinct unordered points, and so is an element of  $D_{dn}(\widetilde{M})$ . The correspondence  $A \mapsto p^{-1}(A)$  thus defines a continuous map  $\psi_n$ :  $D_n(M) \longrightarrow D_{dn}(\widetilde{M})$  of permuted configuration spaces whose base points are the sets  $\{z_1, \ldots, z_n\}$  and  $\{p^{-1}(z_1), \ldots, p^{-1}(z_n)\}$  respectively. So the map  $\psi_n$  induces a homomorphism  $\psi_{n\#}$ :  $B_n(M) \longrightarrow B_{dn}(\widetilde{M})$  on the level of the fundamental groups (with the given base points).

We now prove that  $\psi_{n\#}$  is injective by induction on *n*. We first deal with the case  $n=1$ .

LEMMA 8. *The homomorphism*  $\psi_{1\#}\colon\thinspace B_1(M)\longrightarrow B_d(M)$  *is injective. Furthermore, for all*  $q\geqslant$ 2, the induced homomorphisms  $\pi_q(M) \longrightarrow \pi_q\big(D_d(\bar{M})\big)$  of the higher homotopy groups of M and  $D_d(M)$  are isomorphisms.

*Proof.* Let  $\tilde{z}_1 \in p^{-1}(z_1)$ , let  $\Gamma$  be the group of covering transformations of the covering map  $p: \widetilde{M} \longrightarrow M$ , and let  $\gamma_1 = Id$ ,  $\gamma_2, \ldots, \gamma_d$  denote the elements of Γ. We thus have a map  $\psi_1\colon M\longrightarrow F_d(M)$  given by  $\widetilde{x}\longmapsto (\gamma_1(\widetilde{x}),\gamma_2(\widetilde{x}),\ldots,\gamma_d(\widetilde{x}))$  that makes the following diagram commute:



where  $\alpha\colon\, F_d(M)\longrightarrow D_d(M)$  is the usual quotient map. From this diagram, we obtain the following commutative diagram of short exact sequences:



where  $q_1$ ,  $q_2$  are the canonical quotient homomorphisms, and the homomorphism  $\rho$  is that induced by the rest of the diagram. The homomorphism  $\psi_{1\#}$  is injective since its composition with the homomorphism  $p_{1#}: P_d(M) \longrightarrow \pi_1(M)$  induced by the projection  $p_1: F_d(M) \longrightarrow M$  onto the first coordinate is the identity.

<span id="page-7-0"></span>We claim that  $\rho$  is injective. To see this, let  $\gamma \in \text{Ker}(\rho)$ , and let *c* be a loop in *M* based at *z*<sub>1</sub> such that  $q_1(\langle c \rangle) = \gamma$ . Let  $\tilde{c}$  be the lift of *c* based at  $\tilde{z_1}$ . We have that  $q_2 \circ \psi_{1\#}(\langle c \rangle) = \rho \circ q_1(\langle c \rangle) = \text{Id}$ , so  $\psi_{1\#}(\langle c \rangle) \in \text{Ker}(q_2) = P_d(M)$ . Further,  $\psi_1(c) = c$  $p^{-1}(c) = \{\gamma_1(\widetilde{c}), \gamma_2(\widetilde{c}), \ldots, \gamma_d(\widetilde{c})\}.$  For each  $i = 1, \ldots, d$ ,  $\gamma_i(\widetilde{c})$  is an arc between  $\gamma_i(\widetilde{z_1})$ and  $\gamma_j(\widetilde{z_1})$  for some  $j \,\in\, \{1,\ldots,d\}.$  But  $\psi_{1\#}(\langle c \rangle) \,\in\, P_d(M)$ , so  $j\,\,=\,\,i$ , and thus each *γ*<sub>*i*</sub>( $\tilde{c}$ ) is a loop based at  $\gamma$ <sub>*i*</sub>( $\tilde{z}$ <sub>1</sub>). In particular  $\langle \tilde{c} \rangle \in \pi_1(M, \tilde{z_1})$ , and  $\langle c \rangle = p$ <sub>#</sub>( $\langle \tilde{c} \rangle$ ), so  $\gamma = q_1(\langle c \rangle) = q_1 \circ p_*(\langle \tilde{c} \rangle) = \text{Id}$ . Hence  $\rho$  is injective, as claimed. The first part of the lemma then follows from the Short 5-Lemma [[Mac](#page-17-0), Lemma 3.1, page 14].

For the second part, if M is different from  $\mathbb{R}P^2$  and  $\mathbb{S}^2$  then it and its configuration spaces are finite-dimensional *CW*-complexes that are Eilenberg-MacLane spaces of type  $K(\pi, 1)$ , and so the result is clearly true. If  $M = \mathbb{S}^2$  then since p is a covering map*, d* = 1,  $\widetilde{M}$  =  $\mathbb{S}^2$ , and again the result follows directly.

So suppose that  $M = \mathbb{R}P^2$ . By the Riemann-Hurwitz formula, we either have  $d = 1$ and  $\widetilde{M}\,=\,\mathbb{R}P^2$ , in which case the result is again clear, or else  $d\ =\ 2$  and  $\widetilde{M}\,=\,\mathbb{S}^2.$ From the first part, the homomorphism  $\psi_{1\#}$ :  $\pi_1(\R P^2) \longrightarrow B_2(\mathbb{S}^2)$  is injective, and since  $\pi_1(\mathbb{R}P^2) \cong B_2(\mathbb{S}^2) \cong \mathbb{Z}_2$ , it is an isomorphism. The projection  $p_1: F_2(\mathbb{S}^2) \longrightarrow \mathbb{S}^2$  onto the first coordinate is a fibration whose fibre over a point  $x_0 \in \mathbb{S}^2$  is  $\mathbb{S}^2 \setminus \{x_0\}$  which is contractible, and hence it induces isomorphisms of the homotopy groups of  $F_2(\mathbb{S}^2)$  and  $\mathbb{S}^2$ . Moreover, it is a homotopy equivalence: the map  $\widetilde{\psi_1} \colon \, \mathbb{S}^2 \longrightarrow F_2(\mathbb{S}^2)$  is a homotopy inverse of  $p_1$ . It remains to show that  $D_2(\mathbb{S}^2)$  has the homotopy type of  $\mathbb{R}P^2$ . Observe that  $\widetilde{\psi_1}$  is a  $\mathbb{Z}_2$ -equivariant map with respect to the free action on  $\mathbb{S}^2$  given by the antipodal map and the free action on  $F_2(\mathbb{S}^2) \longrightarrow F_2(\mathbb{S}^2)$  given by the map that exchanges coordinates. The induced map on the quotient is  $\psi_1\colon\mathbb{R}P^2\longrightarrow D_2(\mathbb{S}^2)$ , and since  $\widetilde{\psi_1}$ induces isomorphisms of the homotopy groups of  $\mathbb{S}^2$  and  $F_2(\mathbb{S}^2)$  and the stated actions are free,  $\psi_1$  induces isomorphisms of the homotopy groups of  $\mathbb{R}P^2$  and  $D_2(\mathbb{S}^2)$ . This completes the proof of the lemma.  $\Box$ 

Let

$$
D_{d,\ldots,d}(\widetilde{M})=F_{dn}(\widetilde{M})/(S_d\times\cdots\times S_d),
$$

where for  $i = 1, ..., n$ , the *i*<sup>th</sup> copy of  $S_d$  is the symmetric group on the letters  $i, i +$  $n, \ldots, i + (d-1)n$ , and let

$$
B_{d,\ldots,d}(\widetilde{M})=\pi_1(D_{d,\ldots,d}(\widetilde{M})).
$$

Define the map  $\psi_n$ :  $F_n(M) \longrightarrow D_{d,\dots,d}(M)$  by

$$
\widetilde{\psi_n}((x_1,\ldots,x_n))=(p^{-1}(\{x_1\}),\ldots,p^{-1}(\{x_n\})).
$$
\n(3)

In a similar manner to  $\psi_n$ ,  $\psi_n$  induces a homomorphism  $\psi_{n\#}$ :  $P_n(M) \longrightarrow B_{d,\dots,d}(M)$ which is the restriction of  $\psi_{n#}$  to  $P_n(M)$ .

 $\text{PROPOSITION 9.}$  Let  $n \geqslant 1$ . The homomorphism  $\psi_{n\#} \colon\thinspace P_n(M) \longrightarrow B_{d,\dots,d}(M)$  is injective.

*Proof.* If  $d = 1$  there is nothing to prove. So suppose that  $d \ge 2$ , in which case  $M \ne \mathbb{S}^2$ . The proof is by induction on *n*. For  $n = 1$ ,  $\widetilde{\psi}_1 = \psi_1$ , and the result follows from Lemma [8.](#page-6-0) The case  $n = 2$  is special and will be treated separately at the end of the proof. Suppose then that the result is true for some integer  $n \ge 2$ . Consider the commutative diagram of fibrations:

$$
F_1(M \setminus \{x_1, \ldots, x_n\}) \longrightarrow F_{n+1}(M) \xrightarrow{p} F_n(M)
$$
\n
$$
\widetilde{\psi_{n+1}}|_{M \setminus \{x_1, \ldots, x_n\}} \downarrow \qquad \widetilde{\psi_{n+1}}|_{M \setminus \{x_1, \ldots, x_n\}} \longrightarrow D_{d,\ldots,d,d}(\widetilde{M}) \xrightarrow{\widetilde{p}} D_{d,\ldots,d}(\widetilde{M}),
$$
\n(4)

where  $p: F_{n+1}(M) \longrightarrow F_n(M)$  is the map that forgets the last point,

$$
\widetilde{p} \colon D_{d,\dots,d,d}(M) \longrightarrow D_{d,\dots,d}(M)
$$

is the map that forgets the last *d* points. The long exact sequences in homotopy of these fibrations yield the following commutative diagram:

$$
\begin{array}{c}\n1 \longrightarrow \pi_1(M \setminus \{x_1, \ldots, x_n\}) \longrightarrow P_{n+1}(M) \xrightarrow{p_{\#}} P_n(M) \longrightarrow 1 \\
\widetilde{\psi_{n+1}} \Big|_{\pi_1(M \setminus \{x_1, \ldots, x_n\})} \Big\downarrow \qquad \widetilde{\psi_{n+1}} \Big\downarrow \qquad \widetilde{\psi_{n}} \Big\downarrow \\
1 \longrightarrow B_d(\widetilde{M} \setminus p^{-1}(\{x_1, \ldots, x_n\})) \longrightarrow B_{d, \ldots, d, d}(\widetilde{M}) \xrightarrow{\widetilde{p}_{\#}} B_{d, \ldots, d}(\widetilde{M}) \longrightarrow 1.\n\end{array}
$$

The fact that  $M \neq \mathbb{S}^2$  implies the exactness of the first row. Noting that the *d*-fold covering  $p: \widetilde{M} \longrightarrow M$  induces a *d*-fold covering map

$$
\widehat{p}\colon\thinspace \widetilde{M}\backslash\left\{p^{-1}\left(\{x_1,\ldots,x_n\}\right)\right\}\longrightarrow M\backslash\left\{x_1,\ldots,x_n\right\},\,
$$

and that  $\widetilde{\psi_{n+1}}\left|_{\pi_1(M\setminus\{x_1,\dots,x_n\})}\right|$  is equal to the map

$$
\psi_1\colon F_1(M\setminus\{x_1,\ldots,x_n\})\longrightarrow D_d(\widetilde{M}\setminus p^{-1}(\{x_1,\ldots,x_n\}))
$$

for the space  $F_1(M \setminus \{x_1, \ldots, x_n\})$ , it follows by applying Lemma [8](#page-6-0) that the homomorphism  $\widehat{\psi_{n+1}}$   $\neq$   $\pi_1(M \setminus \{x_1,...,x_n\})$  is injective. The injectivity of  $\widehat{\psi_{n+1}}$  is then a consequence of the 5-Lemma and the induction hypothesis.

It remains to prove the result in the case  $n = 2$ . Since  $d \ge 2$ , observe that *M* is not simply connected. So if  $M \neq \mathbb{R}P^2$ ,  $\pi_2(M) = \pi_2(F_1(M)) = \{1\}$ , and the proof for the case  $n = 2$  follows from the case  $n = 1$  using exactly the same induction argument as in the previous paragraph. So suppose that  $M = \mathbb{R}P^2$ . In this case, we have the same commutative diagram (4), but the long exact sequence in homotopy of the fibrations yields the following commutative diagram:

$$
\pi_2(\mathbb{R}P^2) \cong \mathbb{Z} \longrightarrow \pi_1(\mathbb{R}P^2 \setminus \{x_1\}) \cong \mathbb{Z} \longrightarrow P_2(\mathbb{R}P^2) \cong \mathbb{Q}_8 \longrightarrow P_1(\mathbb{R}P^2) \cong \mathbb{Z}_2 \longrightarrow 1
$$
\n
$$
\downarrow \qquad \qquad \widetilde{\psi}_{1\#} \downarrow \qquad \qquad \widetilde{\psi}_{2\#} \downarrow \qquad \qquad \widetilde{\psi}_{1\#} \downarrow
$$
\n
$$
\pi_2(D_2(\mathbb{S}^2)) \cong \mathbb{Z} \longrightarrow B_2(\mathbb{S}^2 \setminus \{p^{-1}(x_1)\}) \longrightarrow B_{2,2}(\mathbb{S}^2) \longrightarrow B_2(\mathbb{S}^2) \cong \mathbb{Z}_2 \longrightarrow 1.
$$

<span id="page-9-0"></span>The first vertical arrow is the homomorphism induced on the  $\pi_2$ -level by the map  $\widetilde{\psi_1}$ . The first (resp. second) vertical homomorphism is an isomorphism (resp. is injective) by Lemma [8](#page-6-0). The fourth vertical homomorphism is an isomorphism using the injectivity of  $\widetilde{\psi}_{1\#} = \psi_{1\#}$  given by Lemma [8](#page-6-0) and the fact that  $P_1(\mathbb{R}P^2) \cong B_2(\mathbb{S}^2) \cong \mathbb{Z}_2$ . It follows from the strong 4-Lemma [\[Mac](#page-17-0), Lemma 3.2, page 14] that  $\psi_{2\#}$  is injective, and the result follows.  $\Box$ 

Now we come to the main result of this section which immediately implies Theorem [1](#page-2-0).

**THEOREM 10.** *The homomorphism*  $\psi_{n#}: B_n(M) \longrightarrow B_{dn}(\widetilde{M})$  *is injective.* 

*Proof.* Let  $x \in \text{Ker}(\psi_{n\#})$ . We take the base points  $z_1, \ldots, z_n$  of the braid strings to be contained within a small disc D lying in the interior of *M*. The inclusion of D in *M* induces a homomorphism  $B_n(\mathcal{D}) \longrightarrow B_n(M)$ . Let  $\pi: B_n(M) \longrightarrow S_n$  denote the natural braid permutation homomorphism. A generating set of  $B_n(M)$  may be obtained by adding a set of 'surface generators' (whose representatives are loops based at *z*<sub>1</sub>) to a set of standard generators  $\sigma_1, \ldots, \sigma_{n-1}$  of  $B_n(\mathcal{D})$  via the short exact sequence  $1 \longrightarrow P_n(M) \longrightarrow B_n(M) \stackrel{\pi}{\longrightarrow} S_n \longrightarrow 1$ . Let *C* be a set of *n*! permutation braids, in other words a set of coset representatives of  $B_n(M)$  modulo  $P_n(M)$ . The elements of C may be chosen to belong to  $B_n(\mathcal{D})$ , and we may take the representative of the identity permutation to be the identity braid. Thus there exist  $y \in P_n(M)$  and  $w \in C$  such that  $x = y$ . *w*. Now  $x \in \text{Ker}(\psi_{n\#})$ , and we have that  $\psi_{n\#}(y) = \psi_{n\#}(w^{-1})$ . But  $w \in B_n(\mathcal{D})$ , so the permutation  $\pi(\psi_{n\#}(w^{-1}))$  of  $\psi_{n\#}(w^{-1})$  permutes the elements  $jn+1,\ldots,jn+n$ for each  $j = 0, \ldots, d-1$ , while the permutation  $\pi(\psi_{n\#}(y))$  of  $\psi_{n\#}(y)$  permutes the elements  $i, i + n, \ldots, i + (d-1)n$  for each  $i = 1, \ldots, n$  by equation ([3\)](#page-7-0). Since  $\pi(\psi_{n#}(w^{-1})) =$  $\pi(\psi_{n\#}(y))$ , it follows that this permutation must be the identity, hence  $w = Id$ , and thus  $x = y \in P_n(M)$ . By Proposition [9](#page-7-0), the restriction  $\psi_{n\#}$  of  $\psi_{n\#}$  to  $P_n(M)$  is injective, and we conclude that  $x = Id$ , hence  $\psi_{n#}$  is injective.  $\Box$ 

# **3** The classification of the finite subgroups of  $B_n(\mathbb{R}P^2)$ and  $\mathcal{MCG}(\mathbb{R}P^2, n)$

In this section, we prove Theorems [5](#page-4-0) and [6.](#page-4-0) Since  $B_n(\mathbb{R}P^2)$  and  $\mathcal{MCG}(\mathbb{R}P^2,n)$  are finite for  $n \in \{1, 2\}$ , we shall suppose in what follows that  $n \geq 3$ . The proof of Theorem [5](#page-4-0) is divided into two parts:

(*a*) in Section [3.1](#page-10-0), using Theorem [1](#page-2-0) in the case  $M = \mathbb{R}P^2$ , and applying Theorem [4](#page-3-0), we obtain necessary conditions for a finite group to be realised as a subgroup of  $B_n(\mathbb{R}P^2)$ . This enables us to establish a list in Proposition [11](#page-10-0) of the finite groups that are candidates to be subgroups of  $B_n(\mathbb{R}P^2)$ .

<span id="page-10-0"></span>*(b)* in Section 3.2, we show in Proposition 12 that the candidates of Proposition 11 are indeed realised as subgroups of  $\bar{B}_n(\mathbb{R}P^2)$  $\bar{B}_n(\mathbb{R}P^2)$  using equation (2) and geometric construc-tions similar to those of [\[GG5](#page-16-0)] for  $B_n(\mathbb{S}^2)$ .

The proof of Theorem [6](#page-4-0) is given in Section [3.3.](#page-12-0)

## ${\bf 3.1} \quad$  Necessary conditions for a finite group to be a subgroup of  $B_n(\mathbb{R}P^2)$

In this section, we prove the following necessary condition for a finite subgroup *H* to be realised as a subgroup of  $B_n(\mathbb{R}P^2)$ .

 ${\rm PROPOSITION~11.}$  Let  $n\geqslant 3$ , and let H be a finite subgroup of  ${\overline{B}}_n({\mathbb R} P^2).$  Then H is isomorphic *to a subgroup of one of the following groups:*  $Dic_{8n}$ *,*  $Dic_{8(n-1)}$ *,*  $O^*$  *if*  $n\equiv 0,1\pmod 3$ *, or*  $I^*$  $if n \equiv 0, 1, 6, 10 \pmod{15}$ .

*Proof.* Take  $M = \mathbb{R}P^2$ ,  $\widetilde{M} = \mathbb{S}^2$  and  $d = 2$  in the statement of Theorem [1.](#page-2-0) Let m denote the order of *H*. With the notation of Section [2,](#page-5-0)  $\psi_{n#}(H)$  is a subgroup of  $B_{2n}(\mathbb{S}^2)$ isomorphic to *H*. In particular,  $\psi_{n\#}(H)$  is of order *m*. Applying Theorem [4,](#page-3-0) it follows that *H* is isomorphic to a subgroup of one of the following maximal finite groups of  $B_{2n}(\mathbb{S}^2)$ :

*(a)*  $\mathbb{Z}_{2(2n-1)}$ .

- *(b)* Dic $_{8n}$ .
- *(c)*  $\text{Dic}_{8(n-1)}$ .

*(d)*  $T^*$  if  $2n \equiv 4 \pmod{6}$ , *i.e.*  $n \equiv 2 \pmod{3}$ .

(*e*)  $O^*$  if  $2n \equiv 0, 2 \pmod{6}$ , *i.e.*  $n \equiv 0, 1 \pmod{3}$ .

(*f*) I<sup>\*</sup> if  $2n \equiv 0, 2, 12, 20 \pmod{30}$ , *i.e.*  $n \equiv 0, 1, 6, 10 \pmod{15}$ .

The fact that  $n \geq 3$  implies that  $\mathbb{Z}_{2(2n-1)}$  and  $\text{Dic}_{8(n-1)}$  are maximal in  $B_{2n}(\mathbb{S}^2)$ .

Case (a) may be deleted from the list. To see this, note that if  $\psi_{n\#}(H)$  is a subgroup of  $\mathbb{Z}_{2(2n-1)}$  then *H* is cyclic of order a divisor of  $2(2n - 1)$ . On the other hand, its order  $m$  must divide the torsion of  $B_n(\mathbb{R}P^2)$ , which is  $4n$  and  $4(n-1)$  by Proposition [3\(a](#page-3-0)). But  $gcd(2n - 1, 2n) = gcd(2n - 1, 2(n - 1)) = 1$ , and so  $m = 1$  or 2. Hence *H* is either trivial or equal to  $\langle \Delta_n^2 \rangle$  (by Proposition [3\(c\)](#page-3-0)), and both are contained in Dic<sub>8*n*</sub>, for example.

Case (d) may be also be deleted from the list. To see this, assume that  $n \equiv 2$ (mod 3). Suppose that *H* is a subgroup of  $T^* \cong Q_8 \rtimes \mathbb{Z}_3$  not contained in the  $Q_8$ -factor. Then *H* contains elements of order 3, and hence 3 divides the torsion of  $B_n(\mathbb{R}P^2)$ . Once more, by Proposition [3\(a\)](#page-3-0), 3 divides *n* or  $n-1$ , which contradicts the fact that  $n \equiv 2$ (mod 3). Hence *H* is isomorphic to a subgroup of  $\mathcal{Q}_8$ , which is realised as a subgroup of Dic8*n*, for example. This completes the proof of the proposition.  $\Box$ 

## $3.2$  The realisation of the finite subgroups of  $B_n(\mathbb{R}P^2)$

In this section, we prove that the groups listed in Proposition 11 are indeed realised as subgroups of  $B_n(\mathbb{R}P^2)$ .

<span id="page-11-0"></span>PROPOSITION 12. Let  $n \geqslant 3$ , and let H be one of the following groups:  $\text{Dic}_{8n}$ ;  $\text{Dic}_{8(n-1)}$ ;  $\text{O}^{*}$ *if*  $n \equiv 0, 1 \pmod{3}$ ; or  $I^*$  *if*  $n \equiv 0, 1, 6, 10 \pmod{15}$ . Then  $B_n(\mathbb{R}P^2)$  contains an isomorphic *copy of H.*

*Proof.* Let  $X \subset \mathbb{R}P^2$  be an *n*-point subset, let  $\left\{p: \mathbb{S}^2 \longrightarrow \mathbb{R}P^2\right\}$  $x \mapsto [x]$ denote the natural projection, and let  $\widetilde X=p^{-1}(X)$ . Let  $\mathfrak{H}(\mathbb{R} P^2, X)$  (resp.  $\mathfrak{H}(\mathbb{S}^2,\widetilde X)$ ) denote the group of homeomorphisms of  $\mathbb{R}P^2$  (resp.  $\mathbb{S}^2$ ) that leave *X* (resp.  $\widetilde{X}$ ) invariant, and let  $\mathfrak{H}^+(\mathbb{S}^2,\widetilde{X})$ ) denote the index 2 subgroup of  $\mathfrak{H}(\mathbb{S}^2, \widetilde{X})$  consisting of orientation-preserving homeomorphisms. Given *H* as in the statement of the proposition, let *G* be the quotient of *H* by its (normal) subgroup of order 2. Then

$$
G \cong \begin{cases} \text{Dih}_{4(n-i)} & \text{if } H = \text{Dic}_{8(n-i)}, \text{ where } i = 0, 1\\ S_4 & \text{if } H = \text{O}^*\\ A_5 & \text{if } H = \text{I}^*. \end{cases} \tag{5}
$$

Note that *G* consists of rotations and may be realised as a subgroup of  $\mathfrak{H}^{+}(\mathbb{S}^{2}, \widetilde{X})$  (*cf.* the solution of the Nielsen realisation problem [\[Ke\]](#page-17-0)). We may assume that the points of  $\widetilde{X}$  are symmetrically arranged with respect to the regular polyhedron associated with *G*.

The antipodal map  $\tau: S^2 \longrightarrow S^2$ , defined by  $\tau(\widetilde{x}) = -\widetilde{x}$  for all  $\widetilde{x} \in S^2$ , belongs to  $\mathcal H(\mathbb S^2, \widetilde X)\backslash\,\mathcal H^+(\mathbb S^2, \widetilde X)$ , and commutes with any rotation. In particular,  $\tau$  commutes with all of the elements of *G*, and so *G* is a subgroup of

$$
\Gamma = \left\{ \gamma \in \mathfrak{H}^{+}(\mathbb{S}^{2}, \widetilde{X}) \middle| \gamma \circ \tau = \tau \circ \gamma \right\}.
$$

For each  $\gamma \in \Gamma$ , the map  $\hat{\gamma}$  defined by  $\hat{\gamma}(y) = p(\gamma(x))$ , where  $y \in \mathbb{R}P^2$  and  $x \in p^{-1}(\{y\})$ , is a well-defined homeomorphism of R*P* 2 that leaves *X* invariant. The correspondence  $\gamma \mapsto \hat{\gamma}$  defines an injective group homomorphism  $\psi \colon \Gamma \longrightarrow \mathcal{H}(\mathbb{R}P^2, X)$ . The injectivity of  $\psi$  follows from that fact that there are exactly two elements, Id<sub>S2</sub> and τ, of  $\mathcal{H}(\mathbb{S}^2, \widetilde{X})$  that cover  $\mathrm{Id}_{\mathbb{R}P^2}$ , but  $\tau \notin \mathcal{H}^+(\mathbb{S}^2, \widetilde{X})$ .

It follows that  $\psi(\overrightarrow{G}) \cong G$ , and thus  $\mathcal{H}(\mathbb{R}P^2, X)$  contains an isomorphic copy of *G*. Let  $\mathcal{MCG}(\mathbb{R}P^2, n)$  denote the mapping class group of the projective plane relative to *X*. There is a natural homomorphism  $\varphi$ :  $\mathcal{H}(\mathbb{R}P^2, X) \longrightarrow \mathcal{M}C\mathcal{G}(\mathbb{R}P^2, n)$  given by associating the isotopy class of the homeomorphism relative to *X*. The restriction of this homomorphism to  $\psi(G)$  is injective. To see this, let  $f \in \psi(G)$  be such that  $\varphi(f)$  is the trivial mapping class, and let  $g \in G$  be such that  $\psi(g) = f$ . Then there exists an isotopy  ${f_t}_{t \in [0,1]}$  from Id<sub>R</sub><sub>*P*2</sub> to *f* relative to *X*. This isotopy lifts to an isotopy  $\{$  $\widetilde{f}_t$  $t \in [0,1]$  from  ${\rm Id}_{\mathbb{S}^2}$  to some lift  $\widetilde f\in\mathfrak{H}^+(\mathbb{S}^2,\widetilde X)$  of  $f$  relative to  $\widetilde X.$  By construction,  $\widetilde f\in\Gamma$ , and since  $\widetilde f$ and *g* are both sent to *f* by  $\psi$ , the injectivity of  $\psi$  implies that  $f = g$ . Now the isotopy

<span id="page-12-0"></span>!  $\widetilde{f}_t$ is relative to *X*, so *g* is a finite-order homeomorphism that fixes the points  $t \in [0,1]$ of *X* (of which there are at least 6), and thus  $g = Id_{\mathbb{S}^2}$  by [\[E,](#page-16-0) [vK\]](#page-17-0), and  $f = Id_{\mathbb{R}P^2}$ . This proves the injectivity of  $\varphi|_{\psi(G)}$ .

It follows that  $\mathcal{MCS}(\mathbb{R}P^2, n)$  contains an isomorphic copy of *G*. Finally, the short exact sequence ([2\)](#page-4-0) is the analogue for  $\mathbb{R}P^2$  of the short exact sequence (1-1) of [[GG5](#page-16-0), page 760]. It is derived as for S 2 (see equation (1-2) of [[GG5,](#page-16-0) page 760]), by taking the long exact sequence in homotopy of the fibration  $\mathcal{H}(\mathbb{R}P^2) \longrightarrow D_n(\mathbb{R}P^2)$  defined by  $f \mapsto f(X)$ , and whose fibre over *X* is  $\mathcal{H}(\mathbb{R}P^2, X)$ . As in equation (1-2), the homomorphism  $B_n(\mathbb{R}P^2) \longrightarrow \mathcal{M}CS(\mathbb{R}P^2, n)$  $B_n(\mathbb{R}P^2) \longrightarrow \mathcal{M}CS(\mathbb{R}P^2, n)$  $B_n(\mathbb{R}P^2) \longrightarrow \mathcal{M}CS(\mathbb{R}P^2, n)$  of (2) is a boundary operator. Following the proof of [\[GG5](#page-16-0), Theorem 1.3, pages 764–765], we see that *G* lifts to an isomorphic copy of *H* lying in  $B_n(\mathbb{R}P^2)$ . This completes the proof of the proposition, and together with Proposition [11,](#page-10-0) that of Theorem [5](#page-4-0).

## **3.3** The classification of the finite subgroups of  $\mathcal{MCG}(\mathbb{R}P^2, n)$

We close Section [3](#page-9-0) by proving Theorem [6.](#page-4-0)

*Proof of Theorem [6](#page-4-0).* As in the case of S 2 [\[GG5](#page-16-0), Remarks 2.1], the short exact sequence [\(2](#page-4-0)) induces a bijection between the maximal finite subgroups of  $B_n(\mathbb{R}P^2)$  and those of  $\text{MCG}(\mathbb{R}P^2, n)$ . The result then follows from Theorem [5](#page-4-0) and equation [\(5](#page-11-0)). □

# **4 The algebraic realisation of the finite dicyclic subgroups of**  $B_n(\mathbb{R}P^2)$

In this section, we show in Proposition [15](#page-13-0) that  $\text{Dic}_{8n}$  and  $\text{Dic}_{8(n-1)}$  are realised as subgroups of  $B_n(\mathbb{R}P^2)$  for all  $n \geqslant 2$  by giving explicit algebraic realisations. We first recall Van Buskirk's presentation of  $B_n(\mathbb{R}P^2)$ .

PROPOSITION 13 (Van Buskirk [[VB\]](#page-17-0)). *The following constitutes a presentation of the group*  $B_n(\mathbb{R}P^2)$ :

 $\mathbf{generators:} \sigma_1, \ldots, \sigma_{n-1}, \rho_1, \ldots, \rho_n.$ *relations:*

$$
\sigma_i \sigma_j = \sigma_j \sigma_i \quad \text{if } |i - j| \geq 2,
$$
\n
$$
\sigma_i \sigma_{i+1} \sigma_i = \sigma_{i+1} \sigma_i \sigma_{i+1} \quad \text{for } 1 \leq i \leq n - 2,
$$
\n
$$
\sigma_i \rho_j = \rho_j \sigma_i \quad \text{for } j \neq i, i + 1,
$$
\n(6)

$$
\rho_{i+1} = \sigma_i^{-1} \rho_i \sigma_i^{-1} \quad \text{for } 1 \le i \le n-1,
$$
 (7)

$$
\rho_{i+1}^{-1} \rho_i^{-1} \rho_{i+1} \rho_i = \sigma_i^2 \quad \text{for } 1 \le i \le n-1, \\
\rho_1^2 = \sigma_1 \sigma_2 \cdots \sigma_{n-2} \sigma_{n-1}^2 \sigma_{n-2} \cdots \sigma_2 \sigma_1.
$$

<span id="page-13-0"></span>In terms of this presentation, by [[GG2](#page-16-0), equations (4) and (7), pages 770–771], we have the following useful identities:

$$
\rho_j = \sigma_{j-1}^{-1} \cdots \sigma_1^{-1} \rho_1 \sigma_1^{-1} \cdots \sigma_{j-1}^{-1} \quad \text{for } j = 1, \dots, n
$$
 (8)

$$
\rho_n^{-2} = \sigma_{n-1} \cdots \sigma_2 \sigma_1^2 \sigma_2 \cdots \sigma_{n-1},\tag{9}
$$

as well as elements of  $B_n(\mathbb{R}P^2)$  of order  $4n$  and of order  $4(n-1)$  respectively [[GG2](#page-16-0), Proposition 26]:

$$
a = \sigma_{n-1}^{-1} \cdots \sigma_1^{-1} \cdot \rho_1
$$
  

$$
b = \sigma_{n-2}^{-1} \cdots \sigma_1^{-1} \cdot \rho_1
$$

that by [\[GG2,](#page-16-0) Remark 27] satisfy

$$
a^n = \rho_n \cdots \rho_1
$$
 and  $b^{n-1} = \rho_{n-1} \cdots \rho_1$ . (10)

REMARK 14. From [\[GG2,](#page-16-0) pages 777–778], we have:

(*a*) conjugation by  $a^{-1}$  permutes cyclically the following elements:

$$
\sigma_1, \ldots, \sigma_{n-1}, a^{-1}\sigma_{n-1}a, \sigma_1^{-1}, \ldots, \sigma_{n-1}^{-1}, a^{-1}\sigma_{n-1}^{-1}a.
$$

*(b)* conjugation by  $a^{-1}$  permutes cyclically the following elements:

$$
\rho_1,\ldots,\rho_n,\rho_1^{-1},\ldots,\rho_n^{-1}.
$$

(*c*) conjugation by  $b^{-1}$  permutes cyclically the following elements:

$$
\sigma_1, \ldots, \sigma_{n-2}, b^{-1}\sigma_{n-2}b, \sigma_1^{-1}, \ldots, \sigma_{n-2}^{-1}, b^{-1}\sigma_{n-1}^{-1}b.
$$

Note that there is a typographical error in line 16 of [[GG2](#page-16-0), page 778]: it should read '...shows that  $b^{-2}\sigma_{n-2}b^2 = \sigma_1^{-1}$  $i_1^{-1}$  ...', and not '...shows that  $b^{-2}\sigma_{n-1}b^2 = \sigma_1^{-1}$  $\frac{1}{1}$  ...'.

Let  $n \ge 2$ . From Proposition [3\(a](#page-3-0)), the maximal finite cyclic subgroups of  $B_n(\mathbb{R}P^2)$ are  $\mathbb{Z}_{4n}$  and  $\mathbb{Z}_{4(n-1)}$ . Considered as an element of  $B_n$ , the half twist braid  $\Delta_n$  satisfies the relation:

$$
\Delta_n^{-1} \sigma_i \Delta_n = \sigma_{n-i} \quad \text{for all } i = 1, \dots, n-1,
$$
 (11)

and since there is a group homomorphism  $B_n \longrightarrow B_n(\mathbb{R}P^2)$  induced by inclusion of a topological disc in  $\mathbb{R}P^2$ , the same relation holds in  $B_n(\mathbb{R}P^2)$ . We then have the following algebraic realisations of the dicyclic subgroups given by Theorem [5](#page-4-0):

PROPOSITION 15. Let  $n \geq 2$ . Then:

(a) 
$$
\langle a, \Delta_n \rangle \cong \text{Dic}_{8n}
$$
.  
(b)  $\langle b, \Delta_n a^{-1} \rangle \cong \text{Dic}_{8(n-1)}$ .

<span id="page-14-0"></span>Before proving Proposition [15](#page-13-0), let us state and prove the following useful lemma. LEMMA 16. For all  $1 \leq i \leq n$ ,  $\Delta_n^{-1} \rho_i \Delta_n = \rho_{n+1}^{-1}$  $\frac{n+1}{n+1-i}$ 

*Proof of Lemma 16.* We prove the result by induction on *i*. First let  $i = 1$ . Using equation [\(1](#page-3-0)), we have

$$
\Delta_n^{-1} \rho_1 \Delta_n = (\sigma_1)^{-1} (\sigma_1 \sigma_2)^{-1} \cdots (\sigma_1 \cdots \sigma_{n-2})^{-1} \sigma_{n-1}^{-1} \cdots \sigma_1^{-1} \cdot \rho_1 \cdot \sigma_1^{-1} \cdots \sigma_{n-1}^{-1} \cdot \sigma_{n-1} \cdots \sigma_1
$$
  
\n
$$
(\sigma_1 \cdots \sigma_{n-1}) (\sigma_1 \cdots \sigma_{n-2}) \cdots (\sigma_1 \sigma_2) (\sigma_1)
$$
  
\n
$$
= (\sigma_1)^{-1} (\sigma_1 \sigma_2)^{-1} \cdots (\sigma_1 \cdots \sigma_{n-2})^{-1} \rho_n \cdot \rho_n^{-2}.
$$
  
\n
$$
(\sigma_1 \cdots \sigma_{n-2}) \cdots (\sigma_1 \sigma_2) (\sigma_1) \text{ by equations (8) and (9)}
$$
  
\n
$$
= \rho_n^{-1} \text{ by equation (6).}
$$

Now suppose that the result is true for  $1 \le i \le n - 1$ . By equation [\(7](#page-12-0)) we have

$$
\rho_i^{-1} = \sigma_i^{-1} \rho_{i+1}^{-1} \sigma_i^{-1}.
$$
\n(12)

 $\Box$ 

So

$$
\Delta_n^{-1} \rho_{i+1} \Delta_n = \Delta_n^{-1} \sigma_i^{-1} \rho_i \sigma_i^{-1} \Delta_n \text{ by equation (7)}
$$
  
=  $\sigma_{n-i}^{-1} \rho_{(n-i)+1}^{-1} \sigma_{n-i}^{-1}$  by induction and equation (11)  
=  $\rho_{n-i}^{-1}$  by equation (12).

The result follows by induction.

*Proof of Proposition [15](#page-13-0).*

*(a)* We know that *a* is of order  $4n$ ,  $\Delta_n$  is of order 4, and that  $a^{2n} = \Delta_n^2 = \Delta_n^2$  by Proposition [3\(c\)](#page-3-0). By Lemma 16, we obtain

$$
\Delta_n a \Delta_n^{-1} = \Delta_n \sigma_{n-1}^{-1} \cdots \sigma_1^{-1} \rho_1 \Delta_n^{-1}
$$
  
=  $\sigma_1^{-1} \cdots \sigma_{n-1}^{-1} \rho_n^{-1} = (\rho_n \sigma_{n-1} \cdots \sigma_1)^{-1} = a^{-1}$  by equation (8).

This proves that the subgroup  $\langle a,\Delta_{n}\rangle$  of  $B_{n}(\mathbb{R}P^{2})$  is isomorphic to a quotient of Dic $_{8n}.$ Now  $\Delta_n$  is a non-pure braid of order 4, and the elements of  $\bar{\langle a \rangle}$  of order 4 are  $a^{\pm n}$  which are pure braids by equation ([10\)](#page-13-0). This implies that  $\langle a \rangle \cap \langle \Delta_n \rangle = \emptyset$ , thus  $\langle a, \Delta_n \rangle$  contains at least  $4n + 1$  distinct elements, and so is isomorphic to  $Dic_{8n}$ .

*(b)* We know that *b* is of order  $4(n - 1)$ . Moreover, since  $\langle a, \Delta_n \rangle \cong \text{Dic}_{8n}$  and *a* generates its subgroup of order 4*n*, it follows from standard properties of the dicyclic group that  $\Delta_n a^{-1}$  is of order 4. Again by Proposition [3](#page-3-0)([c](#page-3-0)),  $b^{2(n-1)} = (\Delta_n a^{-1})^2 = \Delta_n^2$ . Further,

$$
\Delta_n a^{-1} \cdot b \cdot a \Delta_n^{-1} = \Delta_n a^{-1} \cdot \sigma_{n-2}^{-1} \cdot \sigma_1^{-1} \cdot \rho_1 \cdot a \Delta_n^{-1}
$$
  
=  $\Delta_n \sigma_{n-1}^{-1} \cdot \cdot \sigma_2^{-1} \rho_2 \Delta_n^{-1}$  by Remarks 14(a) and (b)  
=  $\sigma_1^{-1} \cdot \cdot \sigma_{n-2}^{-1} \rho_{n-1}^{-1}$  by Lemma 16  
=  $(\rho_{n-1} \sigma_{n-2} \cdot \cdot \cdot \sigma_1)^{-1} = b^{-1}$  by equation (8).

<span id="page-15-0"></span>This proves that the subgroup of  $B_n(\mathbb{R}P^2)$  generated by  $b$  and  $\Delta_na^{-1}$  is isomorphic to a quotient of the dicyclic group of order  $8(n - 1)$ . An argument similar to that of [\(a](#page-14-0)) above shows that  $\langle b, \Delta_n a^{-1} \rangle$  contains at least  $4(n-1) + 1$  distinct elements, and so is isomorphic to  $Dic_{8(n-1)}$ .  $\Box$ 

### **5 The linearity of braid groups of low-genus surfaces**

In this section, we prove Theorem [7.](#page-5-0) Using the theorem due to Malcev [[Mal](#page-17-0), [W](#page-17-0)] that a group is linear if it contains a finite-index linear subgroup, we first give a short proof of the linearity of  $B_n(\mathbb{S}^2)$  different from those in [\[Ba](#page-16-0), [BB\]](#page-16-0).

PROPOSITION 17 ([\[Ba](#page-16-0), [BB\]](#page-16-0)). Let  $n \in \mathbb{N}$ . Then  $B_n(\mathbb{S}^2)$  is linear.

*Proof.* If  $n \leq 3$  then  $B_n(\mathbb{S}^2)$  is finite, and so is linear. Assume then that  $n \geq 4$ . Since  $P_n(\dot{\mathbb{S}}^2) \cong P_{n-3}(\mathbb{S}^2\backslash\left\{x_1,x_2,x_3\right\})\times\mathbb{Z}_2$  by [\[GG1,](#page-16-0) Theorem 4] and  $P_n(\mathbb{S}^2)$  is of finite index in  $B_n(\mathbb{S}^2)$ , it suffices to prove the linearity of  $P_{n-3}(\mathbb{S}^2 \setminus \{x_1, x_2, x_3\})$ . Now by [[GG6,](#page-16-0) Proposition 2.5],  $P_{n-3}(\mathbb{S}^2 \setminus \{x_1, x_2, x_3\})$  is isomorphic to  $P_{n-3}(\mathbb{D}^2 \setminus \{x_1, x_2\})$ , which in turn is isomorphic to a subgroup of  $P_{n-1}$ . The linearity of  $B_{n-1}$  implies that of  $P_{n-3}(\mathbb{S}^2 \setminus \{x_1, x_2, x_3\})$ as required.  $\Box$ 

#### *Proof of Theorem [7](#page-5-0).*

*(a)* Let  $n \in \mathbb{N}$ , and let *M* be a compact, connected surface. First, suppose that *M* is orientable of genus zero. Then *M* is homeomorphic to  $\mathbb{S}^2$  with a finite number,  $r \geq 0$ say, of disjoint open discs removed. If  $r = 0$  then we are in the case of  $\mathbb{S}^2$  which follows from [[Ba, BB](#page-16-0)] or from Proposition 17, while if  $r \ge 1$ ,  $B_n(M)$  is isomorphic to the *n*<sup>th</sup> braid group of the disc with  $(r - 1)$  discs removed. By [[GG6\]](#page-16-0), it is isomorphic a subgroup of  $B_{n+r-1}$ , so is linear. Now suppose that *M* is non-orientable of genus 1. Then it is homeomorphic to  $\mathbb{R}P^2$  with a finite number of disjoint open discs removed. By Corollary [2,](#page-2-0)  $B_n(M)$  embeds in  $B_{2n}(\widetilde{M})$ , where  $\widetilde{M}$  is the orientable double covering of *M*. But *M*is of genus zero, and the result follows from the previous case.

*(b)* Let  $x \in \mathbb{T}^2$  and let  $n \in \mathbb{N}$ . By [[BGG,](#page-16-0) Lemma 17],  $P_{n+1}(\mathbb{T}^2)$  is isomorphic to the direct product of  $\mathbb{Z}^2$  with  $P_n(\mathbb{T}^2\setminus\{x\})$ . The linearity of  $\mathbb{Z}^2$ , the fact that the  $n^{\text{th}}$  pure braid group is of finite index in the corresponding  $n<sup>th</sup>$  braid group and Malcev's theorem then imply the first statement. The second statement is a consequence of the first, noting that  $P_1(\mathbb{T}^2\setminus\{x\})$  is a free group of rank 2.  $\Box$
