# Mathematical Analysis for some Hyperbolic-Parabolic Coupled Problems

#### Abstract

We deal with the mathematical analysis of the coupling problem in a bounded domain of $\mathbb{R}^{n}$, $n \geq 1$, between a purely quasilinear first-order hyperbolic equation set on a subdomain and a parabolic one, set on its complementary. We start by providing the definition of a weak solution through an entropy inequality on the whole domain. The uniqueness property relies on a pointwise inequality along the interface between the two subdomains and on the method of doubling variables. The existence proof is based on a vanishing viscosity method.


## 1 Introduction

### 1.1 Presentation

Let $\Omega$ be a bounded domain of $\mathbb{R}^{n}$ with a Lipschitz boundary $\Gamma=\partial \Omega, n \geq 1$, such that $\bar{\Omega}=\bar{\Omega}_{h} \cup \bar{\Omega}_{p}$. We suppose that $\Omega_{h}$ (the hyperbolic zone) and $\Omega_{p}$ (the parabolic one) are two disjoint bounded domains with Lipschitz boundaries $\Gamma_{l} \equiv \partial \Omega_{l}, l \in\{h, p\}$. We denote the interface by $\Gamma_{h p}=\Gamma_{h} \cap \Gamma_{p}$ and assume that for $l$ in $\{h, p\}$, the set $\left(\bar{\Gamma}_{h p} \cap\left(\overline{\Gamma_{l} \backslash \Gamma_{h p}}\right)\right)$ has a zero $\mathcal{H}^{n-1}$-measure. Let $T$ be a finite positive real number: we are interested in the uniqueness and existence of a measurable and bounded function $u$ on $Q \equiv(0, T) \times \Omega$ satisfying (at least in a distributional sense)

for discontinuous fluxes and reaction terms given by:

Here for each set $A \subset \Omega, \mathbb{I}_{A}(x)=\left\{\begin{array}{l}1 \text { if } x \in A, \\ 0 \text { else } .\end{array}\right.$
With these notations, the equation in (1) is reduced to the hyperbolic first-order equation

Furthermore it implicitly contains the (formal) transmission condition along the interface:

As mentioned in [6], this type of problem arises from several physical applications that are modelled by a global advection-diffusion-reaction in the whole $\Omega$. However, in these problems, the diffusive term may be relevant only in a subregion $\Omega_{p}$ (which clearly depends on the problem in hands) while it can be neglected in the rest of the domain $\Omega$, without affecting the solution in a sensible way.

Fluid dynamics is among the field that benefit largely from a coupling approach of the type considered here. For example, we may consider viscous-compressible flows around a rigid profile (e.g. an aerofoil). Physical evidence suggests that viscosity effects are negligible apart from a small region close to the rigid body. So that the mathematical modelling of the problem may lead to use equations with different character (precisely Euler, Navier-Stokes equations) in separate regions, by dropping viscous terms when they are very small.

Another example is provided by a heat transfer problem such as a forced incompressible flow over a heated plate. In such a case, the thermal diffusivity is much more important in the boundary layer than elsewhere (here the reduced equation of conservation of energy can be assumed to describe the flows field). The velocity field can be evaluated independently from the temperature while the latter is the solution to an advection-diffusion equation in which the transport field is given precisely by the (known) velocity. Away from the boundary layer, the diffusive term may be neglected.

We complete this introduction with a last example, within the framework of infiltration processes through a stratified subsoil viewed as an heterogeneous porous medium with different geological characteristics in each layer, and such that, depending of the physical properties of the rocks, the diffusivity effects may be neglected with respect to the transport ones. This approach has mainly motivated the previous studies in [1],[2], and [7].

### 1.2 Notations and main assumptions on data

Throughout this paper, we give by a subscript $h$ when referring to the hyperbolic zone and a subscript $p$ for the parabolic one. Then, for $l \in\{h, p\}$,

- the coefficients $b_{l}$ are elements of $W^{2, \infty}\left(\Omega_{l}\right)$ and the vector flux function $\boldsymbol{f}_{l}=\left(f_{l, 1}, \ldots, f_{l, n}\right)$ belongs to $W^{2, \infty}(\mathbb{R})^{n}$. For $i=1, \ldots, n$, the positive real $M_{f_{i}}$ denotes the Lipschitz constant of $f_{i}$ and set $M_{\boldsymbol{f}}=\max _{i=1, \ldots, n} M_{f_{i}}$,
- the source term $g_{l}$ is in $W^{1, \infty}(] 0, T\left[\times \Omega_{l} \times \mathbb{R}\right)$, such that

We set $M_{g}=M_{g_{h}}+M_{g_{p}}$.

- the diffusion term $\phi$ is an increasing function of $W^{1, \infty}(\mathbb{R})$. By normalization, we suppose that $\phi(0)=0$. In addition, we assume that $\phi^{-1}$ exists on $\operatorname{Im}(\phi)$. That means that the second order operator set on the parabolic area is weakly degenerated. This is in particular fulfilled when $\{x \in$ $\left.\mathbb{R}, \phi^{\prime}(x)=0\right\}$ has a zero Lebesgue measure.
- in order to deal with bounded solutions, the initial datum $u_{0}$ belongs to $L^{\infty}(\Omega)$ and takes values in $[m, M]$ where $m$ and $M$ are two fixed real numbers and we introduce a nondecreasing smooth function $M_{1}$ of the time variable and a nonincreasing smooth function $M_{2}$ of the time variable such that

Observe that one can propose

- Since $\Gamma_{p} \backslash \Gamma_{h p}$ has a non zero $\mathcal{H}^{n-1}$-measure we may consider the Hilbert space

endowed with the norm $\|v\|_{V}=\|\nabla v\|_{L^{2}\left(\Omega_{p}\right)^{n}}$, which is equivalent to the classical $H^{1}\left(\Omega_{p}\right)$-norm. Then we denote $\langle\langle.,\rangle$.$\rangle the duality pairing between V$ and $V^{\prime}$.

- The notation $|.|_{n}$ stands for the Euclidian norm on $\mathbb{R}^{n}$.
- For any real numbers $a, b$, we set $I(a, b)$ is the closed interval bounded by $a$ and $b$.
- The function $s g n_{\eta}$ stands for the Lipschitzian approximation of the function $\operatorname{sgn}$ given for any positive $\eta$ and any nonnegative real number $x$ by $\operatorname{sgn} n_{\eta}(x)=\min \left(\frac{x}{\eta}, 1\right)$ and $\operatorname{sgn} n_{\eta}(-x)=-\operatorname{sgn} n_{\eta}(x)$. Lastly, for any real numbers $\tau, k$, we introduce the classical Otto flux $[9,10]$ which is now a standard and useful tool to transcript - through an integral inequality - the boundary condition along the hyperbolic frontier (see (5) below)

This paper is organized as follows. In Section 2 we give the definition of a weak entropy solution to (1). We show in Section 3 the uniqueness of such a solution while Section 4 is mainly devoted to the proof of the existence property, by the vanishing viscosity method.

## 2 A notion of weak entropy solution

We want to take into account not only the coexistence of known hyperbolic and parabolic areas in the studied field but also the unknown ones in $\Omega_{p}$ coming from the degeneracy of the second order operator set in $\Omega_{p}$. With this view we define a weak solution to (1) through a global entropy inequality on the whole domain $Q$ in the same spirit as in [7].

To this end we introduce the next mollified entropy pairs:

Definition 1. A measurable function $u$ on $Q$ is a weak entropy solution to (1) if (i) $u \in L^{\infty}(Q), \phi(u) \in L^{2}(0, T ; V)$,

where $\sigma=(t, \bar{\sigma}) \in \Sigma$.
Entropy inequality (3) is expressed with a mollification of the classical Kruzhkov entropy pairs. This will be used in Lemma 2 to transcript an entropy jump condition across the interface $\Sigma_{h p}$ for a weak entropy solution. This regularization was not needed in [7], where the characteristics along $\Sigma_{h p}$ were known so that this jump condition was automatically fulfilled. This is the main feature and contribution of this work in comparison with the previous ones $[1,2,7]$
Remark 1. When we take the limit with respect to $\eta$ in (3), since for $l=h, p$,

where $\boldsymbol{\Phi}(u, k)=\operatorname{sgn}(u-k)(\boldsymbol{f}(u)-\boldsymbol{f}(k))$ is the Kruzhkov flux.
Remark 2. If $u$ is a weak entropy solution then $u$ is a solution to (1) in the sense of distributions, that is to say, for all $\varphi \in \mathcal{D}(Q)$,

and the transmission condition (2) in a formal sense at this stage.

## 3 The uniqueness property

Our aim is to establish a time-Lipschitzian dependence in $L^{1}(\Omega)$ of a weak entropy solution $u$ to (1) with respect to its corresponding initial datum. The idea of the proof is to derive from (3) two local formulations, one in $Q_{h}$ and one in $Q_{p}$ and an entropy jump condition along the interface $\Sigma_{h p}$. To transcript the latter, we need to define, in a certain way, a trace for $u$ coming from the hyperbolic zone. Observe that a trace for $u$ coming from the parabolic zone is given by the trace of $\phi(u)$ that belongs to $L^{2}\left(0, T ; H^{1 / 2}\left(\Gamma_{p}\right)\right)$. So we assume now that the flux function satisfies a non-degeneracy condition i.e. for almost all $x \in \Omega_{h}$, for all $\xi \in \mathbb{R}^{n}$ with $\xi \neq 0$, the function

Assumption (8) will allow us to define strong traces as explained in Section 2 (see Lemma 1). Indeed, following the works of E. Yu. Panov [12] or A. Vasseur [15], it comes:

Lemma 1. Let $u$ be a function of $L^{\infty}(Q)$ satisfying (3). Under (8) there exists a function $u^{\tau}$ of $L^{\infty}\left(\Sigma_{h}\right)$ such that, for every compact $K$ of $\Sigma_{h}$ and every regular Lipschitz deformation $\Psi$ of $\Omega_{h}$,

Let us note that a regular Lipschitz deformation can be defined if $\Omega_{h}$ is, for example, a star-shaped domain (see [4] for more details).

In this framework, the boundary condition (5) on the outer frontier of the hyperbolic zone is written for almost all $t \in(0, T), \mathcal{H}^{n-1}$-a.e. on $\Gamma_{h} \backslash \Gamma_{h p}, \forall k \in \mathbb{R}$,

which is equivalent to the well-known pointwise Bardos, LeRoux and Nédélec formulation given in [3].
To begin with, let us highlight some local informations included in inequality (3). Indeed, it first contains an entropy formulation on the hyperbolic domain since,

Proposition 1. Let $u$ be a weak entropy solution to (1). Then for any real number $k$ and any $\varphi \in$ $\mathcal{D}\left((0, T) \times \mathbb{R}^{n}\right)$ with $\varphi \geq 0$,

Let $\left(\omega_{\varepsilon}\right)_{\varepsilon>0}$ be a sequence of functions such that for every $\varepsilon, \omega_{\varepsilon} \in \mathcal{C}^{\infty}\left(\bar{\Omega}_{h}\right)$ and

The conclusion follows.
Entropy inequality (11) is not sufficient to prove the uniqueness on the hyperbolic area: as stated forward in , in (19), it only provides an $L^{1}\left(Q_{h}\right)$-error between two solutions with respect to their interface values and initial data. That is why we are interested now in the behavior of a weak entropy solution $u$ to (1) on the parabolic zone. We prove that it fulfills a local variational equality that involves entering data from the hyperbolic domain:

Proposition 2. Let $u$ be a weak entropy solution to (1). Then $\partial_{t} u$ belongs to $L^{2}\left(0, T ; V^{\prime}\right)$. Moreover, for any $\varphi \in L^{2}(0, T ; V)$,

Let $\xi \in \mathcal{D}(0, T ; V)$ and $\hat{\xi}$ an extension of $\xi$ to $\mathcal{D}\left(0, T ; H_{0}^{1}(\Omega)\right)$ . We choose in (7) the test function $\varphi=\hat{\xi} \lambda_{\varepsilon}$ with, for any positive constant $\varepsilon, \lambda_{\varepsilon} \in \mathcal{C}^{\infty}\left(\bar{\Omega}_{p}\right)$ such that

Lemma 2 allows us to write a transmission condition along $\Sigma_{h p}$ that is in fact included in the global formulation (3) on the whole $Q$. This is a key point of the uniqueness proof. Observe that this interface relation is written as a pointwise inequality on $\Sigma_{h p}$ that requires the knowledge of strong traces coming from the hyperbolic area and from the parabolic one for a weak entropy solution to (1). Indeed the next entropy jump condition holds:

Then we choose in (13) written for $u$ in variables $(t, x)$, the test function $\varphi(t, x)=\operatorname{sgn}_{\eta}(\phi(u(t, x))-\phi(v(\tilde{t}, x))) \alpha_{j}(t, \tilde{t})$ and we integrate with respect to $\tilde{t}$ over $[0, T]$. In (13) written for $v$ in variables $(\tilde{t}, x)$ the test function $\varphi(\tilde{t}, x)=$ $-\operatorname{sgn}_{\eta}(\phi(u(t, x))-\phi(v(\tilde{t}, x)))$ and we integrate with respect to $t$ over $[0, T]$. We add up and it comes (by sake of simplicity, we add a "tilde" superscript to any unknown in the $\tilde{t}$ variable).

Next we focus on the hyperbolic area. We use here the classical method of doubling (all) the variables due to S.N.Kruzhkov [8]. Briefly speaking, for all $(p, \tilde{p}) \in\left((0, T) \times \mathbb{R}^{n}\right)^{2}$, we set

Now, the variable $(t, x)$ being frozen in (11) written for $\tilde{v}$ in variables $(\tilde{t}, \tilde{x})$, we choose $k=u=u(t, x)$ and $\varphi(\tilde{t}, \tilde{x})=\psi_{j}(p, \tilde{p})$. We integrate over $Q_{h}$ with respect to the corresponding frozen variables and we add the two resulting
inequalities. That yields

Observe that as soon as, for a.e. $\bar{\sigma}$ in $\Sigma_{h p}$, the mapping $\tau \rightarrow b_{h}(\bar{\sigma}) \boldsymbol{f}_{h}(\tau) \cdot \boldsymbol{\nu}_{h}(\bar{\sigma})$ is nondecreasing, the second term in the right hand side of (19) falls. As a consequence, it warrants the uniqueness on the hyperbolic zone in first and then on the parabolic one by coming back to (18) and using that $u^{\tau}=v^{\tau}$ a.e. on $\Sigma_{h p}$. This framework that has been investigated in earlier works [1, 7]. Here, we add inequalities (18) and (19). Consequently

If $\operatorname{sgn}\left(u^{\phi}-v^{\phi}\right)=\operatorname{sgn}\left(u^{\tau}-v^{\tau}\right)$ or $u^{\tau}=v^{\tau}$, then $J=0$.
If $\left(\operatorname{sgn}\left(u^{\phi}-v^{\phi}\right)=-\operatorname{sgn}\left(u^{\tau}-v^{\tau}\right)\right.$ or $\left.u^{\phi}=v^{\phi}\right)$ and $u^{\tau} \neq v^{\tau}$, then

i) if $\left.v^{\phi} \in\right] u^{\tau}, v^{\tau}$, we choose $k=v^{\phi}$ in (15) written for $u$ and for $v$ and we add the two resulting inequalities. We have

iii) if $v^{\phi} \geq v^{\tau}$, then $u^{\tau}<v^{\tau}<u^{\phi}$. We choose $k=v^{\tau}$ in (15) written for $u$ and $-b_{h}\left(\boldsymbol{f}_{h}\left(u^{\tau}\right)-\boldsymbol{f}_{h}\left(v^{\tau}\right)\right) \geq$ 0.

## 4 The existence property

We use the vanishing viscosity method to approximate a weak entropy solution to (1). To do so we introduce a viscous problem related to (1) and prove that it has a unique weak solution that fulfills some a priori estimates uniform with respect to the viscous parameter. Then by applying E.Yu.Panov's works [11, 13] providing - under suitable non-degeneracy conditions for the flux $\boldsymbol{f}_{h}$ and $\boldsymbol{f}_{p}$ - a precompactness property in $L^{1}$ for the sequence of viscous solutions - we are able to establish that this sequence converges (in the $L^{1}$-sense) towards a weak entropy solution to (1).

### 4.1 The viscous problem

Let $\mu$ be a positive real number. We set

To obtain the majorization for $u_{\mu}$ in (24) we may consider in (27) the test-function $v_{\eta}=\operatorname{sgn}_{\eta}\left(u_{\mu}-M_{1}(t)\right)^{+}$and we integrate over $(0, s)$, for any $s \in(0, T)$. One adds and substracts $\left\langle\partial_{t} M_{1}(t), u_{\mu}\right\rangle$ in the evolution term. Furthermore, since $v_{\eta}$ is supported on $\left\{u_{\mu}>M_{1}(t)\right\}$ we have (by denoting $\left.Q_{s}=(0, s) \times \Omega\right)$

M_{1}^{\prime}(t)+\left(\boldsymbol{f}_{i}\left(M_{1}(t)\right) \cdot \nabla b_{i}+g_{i}\left(t, x, M_{1}(t)\right)\right) \geq 0
$$

and the conclusion follows.
In a similar way, to prove the minorization in (24) we may consider the test function $v_{\eta}=-s g n_{\eta}\left(u_{\mu}-\right.$ $\left.M_{2}(t)\right)^{-}$in (27) and we use (23) to state that the integral over $\Sigma_{h p}$ that appears when we deal with the convection term is nonnegative.

Thus the existence property for (21) is reduced to an existence result to (27). To do so we use the Schauder-Tychonoff fixed point Theorem as in [7] while the uniqueness of a solution to (24)-(26) is obtained by a Holmgren-type duality method (see [7]).

Let us now collect an a priori estimate for the sequence $\left(u_{\mu}\right)_{\mu>0}$ proper to study its limit when $\mu$ goes to $0^{+}$.
Proposition 4. There exists a positive constant $C$ independent of $\mu$ such that

$$
\begin{equation*}
\left\|\left(\lambda_{\mu}\right)^{1 / 2} \nabla \widehat{\phi}\left(u_{\mu}\right)\right\|_{L^{2}(Q)^{n}}^{2}+\left\|\left(\mu \lambda_{\mu}\right)^{1 / 2} \nabla u_{\mu}\right\|_{L^{2}(Q)^{n}}^{2} \leq C \tag{28}
\end{equation*}
$$

where $\widehat{\phi}\left(u_{\mu}\right)=\int_{0}^{u_{\mu}} \sqrt{\phi^{\prime}(\tau)} d \tau$.

Proof. We choose $v=u_{\mu}$ in (26) and integrate over $] 0, T[$. We have:

$$
\int_{0}^{T}\left\langle\partial_{t} u, u\right\rangle d t=\frac{1}{2}\left\|u_{\mu}(T, .)\right\|_{L^{2}(\Omega)}^{2}-\frac{1}{2}\left\|u_{0}\right\|_{L^{2}(\Omega)}^{2} \leq \frac{1}{2}\left\|u_{\mu}(T, .)\right\|_{L^{2}(\Omega)}^{2}
$$

Moreover,

$$
\begin{aligned}
\int_{Q} b(x) \boldsymbol{f}\left(u_{\mu}\right) \cdot \nabla u_{\mu} d x d t & =\int_{Q} b(x) \operatorname{div}\left(\int_{0}^{u_{\mu}} \boldsymbol{f}(\tau) d \tau\right) d x d t \\
& =\sum_{i \in\{h, p\}} \int_{Q_{i}} b_{i}(x) \operatorname{div} \boldsymbol{F}_{i}\left(u_{\mu}\right) d x d t
\end{aligned}
$$

where $\boldsymbol{F}_{i}\left(u_{\mu}\right)=\int_{0}^{u_{\mu}} \boldsymbol{f}_{i}(\tau) d \tau$.
So by a Green's formula on each $Q_{i}, i=h, p$, the convection term can be written as

$$
\left.\sum_{i \in\{h, p\}} \int_{Q_{i}} \nabla b_{( } x\right) \boldsymbol{F}_{i}\left(u_{\mu}\right) d x d t+\int_{\Sigma_{h p}}\left(b_{p}(\bar{\sigma}) \boldsymbol{F}_{p}\left(u_{\mu}\right)-b_{h}(\bar{\sigma}) \boldsymbol{F}_{h}\left(u_{\mu}\right)\right) \cdot \boldsymbol{\nu}_{h} d t d \mathcal{H}^{n-1}
$$

Thanks to (24), we assert that the convection term is bounded independently of $\mu$. The reaction term is also clearly bounded (as a consequence of (24) and for the diffusion term we write:

$$
\int_{Q} \lambda_{\mu} \nabla \phi_{\mu}\left(u_{\mu}\right) \cdot \nabla u_{\mu} d x d t=\int_{Q} \lambda_{\mu} \phi^{\prime}\left(u_{\mu}\right)\left|\nabla u_{\mu}\right|_{n}^{2} d x d t+\mu \int_{Q} \lambda_{\mu}\left|\nabla u_{\mu}\right|_{n}^{2} d x d t
$$

where,

$$
\int_{Q} \lambda_{\mu} \phi^{\prime}\left(u_{\mu}\right)\left|\nabla u_{\mu}\right|_{n}^{2} d x d t=\int_{Q}\left(\sqrt{\lambda_{\mu}}\left|\nabla \widehat{\phi}\left(u_{\mu}\right)\right|_{n}\right)^{2} d x d t .
$$

This way,

$$
\int_{Q} \lambda_{\mu} \nabla \phi_{\mu}\left(u_{\mu}\right) \cdot \nabla u_{\mu} d x d t=\left\|\left(\lambda_{\mu}\right)^{1 / 2} \nabla \widehat{\phi}\left(u_{\mu}\right)\right\|_{L^{2}(Q)^{n}}^{2}+\left\|\left(\mu \lambda_{\mu}\right)^{1 / 2} \nabla u_{\mu}\right\|_{L^{2}(Q)^{n}}^{2}
$$

The conclusion follows.

### 4.2 The viscous limit

Since the estimates (24) and (28) are not sufficient not allow us to pass to the limit with $\mu$ on the parabolic zone (mainly it misses an estimate on the time derivative of $u_{\mu_{Q_{p}}}$ in $L^{2}\left(0, T ; V^{\prime}\right)$ ), we use E.Yu.Panov's results in [13]. The author introduces a so-called nonlinear condition for the flux $\boldsymbol{f}_{p}$ so that the sequence $\left(u_{\mu \mid Q_{p}}\right){ }_{\mu>0}$ is precompact in $L^{1}\left(Q_{p}\right)$. Indeed assume that:
Assumption 1. For almost all $x \in \Omega_{p}$, for all $\xi \in \mathbb{R}^{n}$ with $\xi \neq 0$, the functions $\lambda \mapsto b_{p}(x) \boldsymbol{f}_{p}(\lambda) \cdot \xi$ and $\lambda \mapsto \phi(\lambda) \xi^{2}$ are not linear simultaneously on any non-degenerate intervals.

Then, as soon as (24) and (28) hold, there exists a subsequence, still denoted $\left(u_{\left.\mu\right|_{Q_{p}}}\right)_{\mu>0}$, that converges strongly in $L^{1}\left(Q_{p}\right)$. This way, we may state:
Theorem 2. The sequence $\left(u_{\mu}\right)_{\mu>0}$ of solutions to (21), admits a subsequence that converges strongly in $L^{1}(Q)$ towards a function $u \in L^{\infty}(Q)$.
Moreover $u$ is the weak entropy solution of the problem (1).
Remark 3. The strong convergence property on $Q_{p}$ could also be obtained if we replace Assumption 1 by the following one $\phi$ is Hölder continuous with an exponent $\tau \in(0,1)$,
as it is supposed in [7].

Proof of theorem 2. Thanks to Assumption 1 we make sure that we can extract a subsequence of $\left(u_{\left.\mu\right|_{Q_{p}}}\right)_{\mu>0}$ that strongly converges in $L^{1}\left(Q_{p}\right)$. Besides, from [13] and by virtue of (8) we know that we can extract a subsequence of $\left(u_{\left.\mu\right|_{Q_{h}}}\right)_{\mu>0}$ that strongly converges in $L^{1}\left(Q_{h}\right)$. Thus there exists a subsequence of $\left(u_{\mu}\right)_{\mu>0}$ that converges strongly in $L^{1}(Q)$ towards a function $u$ of $L^{\infty}(Q)$. It remains to show that $u$ is a weak entropy solution to (1). To this purpose we choose in (26) the test function $v_{\mu}^{\eta}=\operatorname{sgn} n_{\eta}\left(\phi\left(u_{\mu}\right)-\phi(k)\right) \varphi$, where $k \in \mathbb{R}, \varphi \in \mathcal{D}([0, T) \times \Omega), \varphi \geq 0$. We integrate over $[0, T]$ to have

$$
\begin{equation*}
\int_{0}^{T}\left\langle\partial_{t} u_{\mu}, v_{\mu}^{\eta}\right\rangle d t+\int_{Q}\left(\left(\lambda_{\mu} \nabla \phi_{\mu}\left(u_{\mu}\right)-b(x) \boldsymbol{f}\left(u_{\mu}\right)\right) \cdot \nabla v_{\mu}^{\eta}+g\left(t, x, u_{\mu}\right) v_{\eta}^{\mu}\right) d x d t=0 \tag{29}
\end{equation*}
$$

An integration-by-parts in the evolution term gives

$$
\int_{0}^{T}\left\langle\partial_{t} u_{\mu}, v_{\mu}^{\eta}\right\rangle d t=-\int_{Q} I_{\eta}\left(u_{\mu}, k\right) \partial_{t} \varphi d x d t-\int_{\Omega} I_{\eta}\left(u_{0}, k\right) \varphi(0, .) d x
$$

Due to the definition of $s g n_{\eta}$ and $\phi_{\mu}$, we obtain for the diffusion term

$$
\begin{aligned}
\int_{Q} \lambda_{\mu} \nabla \phi_{\mu}\left(u_{\mu}\right) \cdot \nabla v_{\mu}^{\eta} d x d t & \geq \int_{Q} \lambda_{\mu} \operatorname{sgn}_{\eta}\left(\phi\left(u_{\mu}\right)-\phi(k)\right) \nabla \phi\left(u_{\mu}\right) \cdot \nabla \varphi d x d t \\
& +\mu \int_{Q} \lambda_{\mu} \operatorname{sgn}_{\eta}\left(\phi\left(u_{\mu}\right)-\phi(k)\right) \nabla u_{\mu} \cdot \nabla \varphi d x d t
\end{aligned}
$$

Note that the second term of the right-hand side goes to zero with $\mu$ thanks to estimate (28). The convection term is written as

$$
\begin{aligned}
& -\sum_{i \in\{h, p\}} \int_{Q} b_{i}(x) \boldsymbol{f}_{i}\left(u_{\mu}\right) \cdot \nabla \phi\left(u_{\mu}\right) \operatorname{sgn}_{\eta}^{\prime}\left(\phi\left(u_{\mu}\right)-\phi(k)\right) \varphi d x d t \\
& -\sum_{i \in\{h, p\}} \int_{Q} b_{i}(x) \operatorname{sgn}_{\eta}\left(\phi\left(u_{\mu}\right)-\phi(k)\right) \boldsymbol{f}_{i}\left(u_{\mu}\right) \cdot \nabla \varphi d x d t
\end{aligned}
$$

Since the $\mu$ and $\eta$-limits in second line does not bring difficulties we focus on the first line for $i=h$, the reasoning for $i=p$ being similar. We denote

$$
J_{\mu, \eta}=-\int_{Q_{h}} b_{h}(x) \boldsymbol{f}_{h}\left(u_{\mu}\right) \cdot \nabla \phi\left(u_{\mu}\right) \operatorname{sgn}_{\eta}^{\prime}\left(\phi\left(u_{\mu}\right)-\phi(k)\right) \varphi d x d t
$$

Thus, owing to definition of $\boldsymbol{F}_{h, \eta}$,

$$
J_{\mu, \eta}=-\int_{Q_{h}} b(x) \operatorname{div} \boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right) \varphi d x d t
$$

So, by a Green's formula, we have

$$
\begin{aligned}
J_{\mu, \eta}= & \int_{Q_{h}} \boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right) \cdot\left(\nabla b_{h} \varphi_{2}+\nabla \varphi b_{h}\right) d x d t \\
& -\int_{\Sigma_{h p}} b_{h} \boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right) \cdot \boldsymbol{\nu}_{h} \varphi d \mathcal{H}^{n-1} d t .
\end{aligned}
$$

Now we take the limit with respect to $\mu$. For the interface integral we assert that the sequence $\left(\boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right) \varphi\right)_{\mu>0}$ weakly converges towards $\boldsymbol{F}_{h, \eta}(u, k) \varphi$ in $L^{2}\left(\Sigma_{h p}\right)^{n}$. Indeed, we notice first that since $\phi\left(u_{\mu}\right) \in L^{2}\left(0, T ; H^{1}(\Omega)\right)$, for almost all $t \in(0, T), \mathcal{H}^{n-1}$ a.e., $\left(\phi\left(u_{\mu}\right)_{\mid \Omega_{h}}\right)_{\mid \Gamma_{h p}}=\left(\phi\left(u_{\mu}\right)_{\mid \Omega_{p}}\right)_{\mid \Gamma_{h p}}$.
Moreover, $\boldsymbol{F}_{h, \eta}(., k)$ being a Lipschitz function, for $1 \leq q<\infty$,
$\left(\boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right)\right)_{\mu>0}$ strongly converges towards $\boldsymbol{F}_{h, \eta}(u, k)$ in $L^{q}\left(Q_{p}\right)^{n}$.
Besides, by virtue of (28), the sequence
$\left(\boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right)\right)_{\mu>0}$ is uniformly bounded in $L^{2}(0, T ; V)^{n} \cap L^{\infty}(Q)^{n}$.
So $\left(\boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right) \varphi\right)_{\mu>0}$ weakly converges, up to a subsequence, towards
$\boldsymbol{F}_{h, \eta}(u, k) \varphi$ in $L^{2}(0, T ; V)^{n}$.
Therefore, as the trace operator from $L^{2}(0, T ; V)$ into $L^{2}\left(\Sigma_{h p}\right)$ is linear and continuous, $\left(\boldsymbol{F}_{h, \eta}\left(u_{\mu}, k\right) \varphi\right)_{\mu>0}$ weakly converges towards
$\boldsymbol{F}_{h, \eta}(u, k) \varphi$ in $L^{2}\left(\Sigma_{p}\right)^{n}$ and then in $L^{2}\left(\Sigma_{h p}\right)^{n}$.
Consequently, $\lim _{\mu \rightarrow 0^{+}} J_{\mu, \eta}=J_{\eta}$ where

$$
\begin{aligned}
J_{\eta}= & \int_{Q_{h}} \boldsymbol{F}_{h, \eta}(u, k) \cdot\left(\nabla b_{h} \varphi+\nabla \varphi b_{h}\right) d x d t \\
& -\int_{\Sigma_{h p}} b_{h} \boldsymbol{F}_{h, \eta}(u, k) \cdot \boldsymbol{\nu}_{h} \varphi d \mathcal{H}^{n-1} d t .
\end{aligned}
$$

Then, we can pass to the limit with respect to $\mu$ in each term of (26) to have

$$
\begin{align*}
& \int_{Q} I_{\eta}\left(u_{\mu}, k\right) \partial_{t} \varphi d x d t+\int_{\Omega} I_{\eta}\left(u_{0}, k\right) \varphi(0, .) d x \\
& -\int_{Q} s g n_{\eta}(\phi(u)-\phi(k)) \nabla \phi(u) \cdot \nabla \varphi d x d t \\
& +\int_{Q} b(x)\left\{\operatorname{sgn}_{\eta}(\phi(u)-\phi(k)) \boldsymbol{f}(u)-\boldsymbol{F}_{\eta}(u, k)\right\} \cdot \nabla \varphi d x d t  \tag{30}\\
& -\int_{Q}\left\{s g n_{\eta}(\phi(u)-\phi(k)) g(t, x, u)+\nabla b(x) \cdot \boldsymbol{F}_{\eta}(u, k)\right\} \varphi d x d t \\
& +\int_{\Sigma_{h p}}\left(b_{h} \boldsymbol{F}_{h, \eta}(u, k)-b_{p} \boldsymbol{F}_{p, \eta}(u, k)\right) \varphi \cdot \boldsymbol{\nu}_{h} d t d \mathcal{H}^{n-1} \geq 0,
\end{align*}
$$

and (3) follows.
Now it remains to prove that $u$ fulfills (4)-(5). We consider in (30) a test function $\varphi$ in $\mathcal{D}\left(\left[0, T\left[\times \Omega_{h}\right)\right.\right.$ and take the limit with respect to $\eta$. We obtain

$$
\begin{aligned}
& -\int_{Q_{h}}\left(|u-k| \partial_{t} \varphi+b_{h}(x) \boldsymbol{\Phi}(u, k) \cdot \nabla \varphi\right) d x d t \\
& +\int_{Q_{h}} \operatorname{sgn}(u-k)\left(g_{h}(t, x, u)+\nabla b_{h}(x) \cdot \boldsymbol{f}_{h}(k)\right) \varphi d x d t \\
& \leq \int_{\Omega_{h}}\left|u_{0}-k\right| \varphi(0, .) d x .
\end{aligned}
$$

Thus, we refer to F.Otto's work in [10] (see also [9, Chap. 2]) to ensure that

$$
\underset{t \rightarrow 0^{+}}{\operatorname{ess} \lim _{\Omega_{h}}}\left|u(t, x)-u_{0}(x)\right| d x=0 .
$$

In order to show that $u$ fulfills the initial condition on the parabolic zone, we choose a test function $\varphi=\varphi_{1} \varphi_{2}$ where $\varphi_{1}$ belongs to $\mathcal{D}\left(\left[0, T[)\right.\right.$ and $\varphi_{2}$ to $\mathcal{D}\left(\Omega_{p}\right), \varphi_{1}, \varphi_{2} \geq 0$. We pass to the limit with respect to $\eta$ and we can state that

$$
-\int_{0}^{T}\left(\int_{\Omega_{p}}|u-k| \varphi_{2} d x+h(t)\right) \varphi_{1}^{\prime}(t) \leq \int_{\Omega_{p}}\left|u_{0}-k\right| \varphi_{2} \varphi_{1}(0) d x
$$

where

$$
\begin{aligned}
& h(t)=\int_{\Omega_{p}} \int_{0}^{t} b_{p}(x) \boldsymbol{\Phi}_{p}(u(\tau, x), k) \cdot \nabla \varphi_{2} d \tau d x \\
& +\int_{\Omega_{p}} \int_{0}^{t} \operatorname{sgn}(u(\tau, x)-k) g_{p}(\tau, x, u(\tau, x)) \varphi_{2}-|\phi(u(\tau, x))-\phi(k)| \Delta \varphi_{2} d \tau d x
\end{aligned}
$$

So the time-depending function

$$
t \mapsto \int_{\Omega_{p}}|u-k| \varphi_{2} d x+h(t)
$$

is identified with a nonincreasing and bounded function and consequently has an essential limit when $t$ tends to $0^{+}$. Since $h$ goes to zero with $t$ it comes, for any $\varphi_{2} \in \mathcal{C}_{c}^{\infty}\left(\Omega_{p}\right)$ with $\varphi_{2} \geq 0$,

$$
\underset{t \rightarrow 0^{+}}{\operatorname{ess}} \int_{\Omega_{p}}|u(t, x)-k| \varphi_{2} d x \leq \int_{\Omega_{p}}\left|u_{0}-k\right| \varphi_{2} d x
$$

The above inequality implies that $u$ satisfies (4) (see [9] for more details).

To prove (5), we consider the family of boundary entropy - entropy flux pair (see [9, 10]) defined by, for any $\delta>0$,

$$
H_{\delta}(\tau, k)=\left((\operatorname{dist}(\tau, I[0, k]))^{2}+\delta^{2}\right)^{1 / 2}-\delta
$$

and

$$
\boldsymbol{Q}_{h, \delta}(\tau, k)=\int_{k}^{\tau} \partial_{1} H_{\delta}(\lambda, k) \boldsymbol{f}_{h}^{\prime}(\lambda) d \lambda
$$

Then we come back to the viscous problem (21) and choose in (26) the test function $v=\partial_{1} H_{\delta}\left(u_{\mu}, k\right) \varphi$ where $\varphi$ belongs to $\mathcal{D}\left((0, T) \times \bar{\Omega}_{h}\right), \varphi \geq 0$ and $\varphi_{2}=0$ on $\Gamma_{h p}$. Let us note that $\partial_{1} H_{\delta}\left(u_{\mu}, k\right) \varphi$ is an element of $L^{2}\left(0, T ; H_{0}^{1}\left(\Omega_{h}\right)\right)$ so that Green's formula does not give rise to integrals over $\Sigma_{h p}$. We integrate over $(0, T)$ and, noticing that $\tau \mapsto H_{\delta}(\tau,$.$) is a convex function, it provides$

$$
\begin{aligned}
& -\int_{Q_{h}}\left(H_{\delta}\left(u_{\mu}, k\right) \partial_{t} \varphi+b_{h} \mathbf{Q}_{h, \delta}\left(u_{\mu}, k\right) \cdot \nabla \varphi-\boldsymbol{G}_{h, \delta}\left(u_{\mu}, k\right) \varphi\right) d x d t \\
& \leq-\mu \int_{Q_{h}} \partial_{1} H_{\delta}\left(u_{\mu}, k\right) \nabla \varphi \cdot \nabla \phi\left(u_{\mu}\right) d x d t
\end{aligned}
$$

where

$$
\boldsymbol{G}_{h, \delta}\left(u_{\mu}, k\right)=\int_{k}^{u_{\mu}} \partial_{11}^{2} H_{\delta}(\tau, k) \boldsymbol{f}_{h}(\tau) d \tau \cdot \nabla b_{h}+g_{h}\left(t, x, u_{\mu}\right) \partial_{1} H_{\delta}\left(u_{\mu}, k\right) .
$$

By virtue of Theorem 2 and (28) to deal with the right hand side, there is no difficulties to take the limit with respect to $\mu$. That gives

$$
-\int_{Q_{h}}\left(H_{\delta}(u, k) \partial_{t} \varphi+b_{h} \mathbf{Q}_{h, \delta}(u, k) \nabla \varphi-\boldsymbol{G}_{h, \delta}(u, k) \varphi\right) d x d t \leq 0 .
$$

From [10] it follows that, for any $\zeta$ in $L^{1}\left(\Sigma_{h} \backslash \Sigma_{h p}\right)$ with $\zeta \geq 0$,

$$
\underset{s \rightarrow 0^{-}}{\operatorname{ess} \lim _{\Sigma_{h} \backslash \Sigma_{h p}} b_{h} \boldsymbol{G}_{h, \delta}\left(u\left(\sigma+s \boldsymbol{\nu}_{h}\right), k\right) \cdot \boldsymbol{\nu}_{h} \zeta d t d \mathcal{H}^{n-1} \geq 0, ~, ~, ~}
$$

that is

$$
\int_{\Sigma_{h} \backslash \Sigma_{h p}} b_{h} \boldsymbol{G}_{h, \delta}\left(u^{\tau}, k\right) \cdot \boldsymbol{\nu}_{h} \zeta d t d \mathcal{H}^{n-1} \geq 0,
$$

in view of (9).
That yields first to boundary condition (5) by observing that $\left(\boldsymbol{Q}_{h, \delta}\right)_{\delta}$ uniformly converges towards $\mathcal{F}_{h}$ as $\delta$ goes to $0^{+}$et so to (10).
