# Singular limit of a two-phase flow problem in porous medium as the air viscosity tends to zero*

#### Abstract

In this paper we consider a two-phase flow problem in porous media and study its singular limit as the viscosity of the air tends to zero; more precisely, we prove the convergence of subsequences to solutions of a generalized Richards model.


## 1 Introduction

Hydrologists have studied air-water flow in soils, mainly using the so-called Richards approximation. At least two hypotheses are physically required for this model to be applicable: the water pressure in the saturated region must be larger than the atmospheric pressure and all the unsaturated regions must have a boundary connected to the surface. However, in many situations, these hypotheses are not satisfied and a more general twophase flow model must be considered. This work explores the limit of this general model as the viscosity of the air tends to zero, which is one of the hypotheses required in the Richards model. To that purpose we prove the existence of a weak solution of the twophase flow problem and prove estimates which are uniform in the air viscosity. In this paper, we assume that the air and water phases are incompressible and immiscible. The geometric domain is supposed to be horizontal, homogeneous and isotropic. Our starting point is the following two-phase flow model, which one can deduce from Darcy's law

[^0]where $u$ and $p$ are respectively the saturation and the pressure of the water phase, $k_{w}$ and $k_{a}$ are respectively the relative permeabilities of the water and the air phase, $\mu$ is the ratio between the viscosity of the air phase and that of the water phase, $p_{c}$ is the capillary pressure, $s_{w}$ is an internal source term for the water phase and $s_{a}$ is an internal source term for the air phase; these source terms are used to represent exchanges with the outside. We suppose in particular that the physical functions $k_{w}, k_{a}$ and $p_{c}$ only depend on the saturation $u$ of the water phase, and that $k_{w}(1)=k_{a}(0)=1$. The aim of this paper is the study of the limit of the two-phase flow problem as $\mu \downarrow 0$.

The classical Richards model as formulated by the engineers is given by

where the properties of capillary pressure $p_{c}=p_{c}(u)$ are describes in hypothesis $\left(H_{8}\right)$ below. For the existence and uniqueness of the solution of Richards model together with suitable initial and boundary conditions as well as qualitative properties of the solution and methods for numerical approximations we refer to [1], [6], [10], [11]. In this article, we will show that the singular limit as $\mu \downarrow 0$ of the two phase flow problem $(\mathcal{T P})$ has the form

We remark that a solution of $(\mathcal{R})$ with $u>0$ satisfies $(\mathcal{F B P})$.
This paper is organized as follows. In Section 2 we present a complete mathematical formulation of the problem, and state the main mathematical results, which include a precise formulation of the singular limit problem. We give a sequence of regularized problems in Section 3, and prove the existence of a classical solution. In Section 4 we present a priori estimates, which are uniform in an extra regularization parameter $\delta$ and in the air viscosity $\mu$. In Section 5 , we let $\delta \downarrow 0$ and prove that the solution converges to a solution of the two phase flow problem. We study its limiting behavior as the air viscosity $\mu$ tends to zero in Section 6. Finally in Section 7 we propose a finite volume algorithm in a one dimensional context and present a variety of numerical solutions.

## 2 Mathematical formulation and main results

We consider the two-phase flow problem

where $T$ is a positive constant, $Q_{T}:=\Omega \times(0, T)$ and where we suppose that

In this model, $u$ and $p$ are respectively the saturation and the pressure of the water phase, $k_{w}$ and $k_{a}$ are respectively the mobilities of the water phase and the mobility of the non-water phase and $p_{c}$ is the capillary pressure. We assume in particular that the permeability functions $k_{w}, k_{a}$ and the capillary pressure $p_{c}$ only depend on the saturation $u$ of the water phase. Here, we suppose that the flow of the water phase in the reservoir is driven by an injection term $f^{\mu}(c) \bar{s}$ and an extraction term $f^{\mu}(u) \underline{s}$ where $\bar{s}$ and $\underline{s}$ are given space dependent functions, $c$ is the saturation of the injected fluid; if $c=1$, only water will be injected, if $c=0$, only air will be injected, whereas a mixture of water and air will be injected if $0<c<1$. The function $f^{\mu}$ is the fractional flow of the water phase, namely

Our first result, which we prove in Section 3, is the following

Theorem 2.2 Suppose that the hypotheses $\left(H_{1}\right)-\left(H_{9}\right)$ are satisfied, then there exists a weak solution $\left(u^{\mu}, p^{\mu}\right)$ of Problem $\left(S^{\mu}\right)$.

Next we define the discontinuous function $\chi$ by

The main goal of this paper is to prove the following convergence result,

Finally we remark that another form of the limit problem involves a parabolic equation, which is close to the standard Richards equation. Indeed if we set $\phi(s):=p_{c}(0)-p_{c}(s)$ and denote by $\beta$ the inverse function of $\phi$, the function $v:=\phi(u)$ is a weak solution of the problem

## 3 Existence of a solution of an approximate problem $\left(S_{\delta}^{\mu}\right)$ of Problem $\left(S^{\mu}\right)$

Let $\delta$ be an arbitrary positive constant. In order to prove the existence of a solution of Problem $\left(S^{\mu}\right)$ we introduce a sequence of regularized problems $\left(S_{\delta}^{\mu}\right)$, namely

where $u_{0}^{\delta}, c_{\delta}, \bar{s}_{\delta}$ and $\underline{s}_{\delta}$ are smooth functions such that $u_{0}^{\delta}$ tends to $u_{0}$ in $L^{2}(\Omega)$ and $c_{\delta}, \bar{s}_{\delta}$ and $\underline{s}_{\delta}$ tend respectively to $c, \bar{s}$ and $\underline{s}$ in $L^{2}\left(Q_{T}\right)$, as $\delta \downarrow 0$. In particular we suppose that there exists a positive constant $C$ such that

In order to prove the existence of a smooth solution of $\left(S_{\delta}^{\mu}\right)$, we introduce the set

Suppose that a sequence $\left(V_{m}\right)_{m \in N}$ converges to a limit $V \in \mathcal{K}$ in $C^{1+\alpha, \frac{1+\alpha}{2}}\left(\bar{Q}_{T}\right)$, as $m \rightarrow \infty$. Since $\left(V_{m}\right)_{m \in N}$ is bounded in $C^{1+\alpha, \frac{1+\alpha}{2}}\left(\bar{Q}_{T}\right)$, it follows from (3.20) that the sequence $\left(W_{m}:=T^{1}\left(V_{m}\right)\right)_{m \in N}$, where $W_{m}$ is the solution of $\left(Q_{V_{m}}^{1}\right)$, is bounded in $C^{1+\alpha, \frac{1+\alpha}{2}}\left(\bar{Q}_{T}\right)$, so that as $m \rightarrow \infty, W_{m}$ converges to the unique solution $W$ of Problem $\left(Q_{V}^{1}\right)$ in $C^{1+\beta, \frac{1+\beta}{2}}\left(\bar{Q}_{T}\right)$ for all $\beta \in(0, \alpha)$. Moreover $W \in C^{1+\alpha, \frac{1+\alpha}{2}}\left(\bar{Q}_{T}\right)$. Further it also follows from (3.20) that $\left(\nabla W_{m}\right)_{m \in N}$ is bounded in $C^{1+\alpha, \frac{1+\alpha}{2}}\left(\bar{Q}_{T}\right)$, so that the solution $\hat{V}_{m}=T^{2}\left(W_{m}\right)$ of Problem $\left(Q_{W_{m}}^{2}\right)$ is bounded in $C^{2+\alpha, \frac{2+\alpha}{2}}\left(\bar{Q}_{T}\right)$. Since $\hat{V}_{m}=T^{2}\left(W_{m}\right)=T\left(V_{m}\right),\left(T\left(V_{m}\right)\right)_{m \in N}$ converges to the unique solution $\hat{V}$ of Problem $\left(Q_{W}^{2}\right)$
in $C^{2+\beta, \frac{2+\beta}{2}}\left(\bar{Q}_{T}\right)$ for all $\beta \in(0, \alpha)$, as $m \rightarrow \infty$, so that $\hat{V}=T^{2}(W)=T^{2} \circ T^{1}(V)$. Therefore we have just proved that $\left(T^{2} \circ T^{1}\left(V_{m}\right)\right)_{m \in N}$ converges to $T^{2} \circ T^{1}(V)$ in $C^{2+\beta, \frac{2+\beta}{2}}\left(\bar{Q}_{T}\right)$ for all $\beta \in(0, \alpha)$, as $m \rightarrow \infty$, which ensures the continuity of the map $T$. It follows from the Schauder fixed point theorem that there exists a solution $\left(u_{\delta}^{\mu}, \mathcal{P}_{\delta}^{\mu}\right)$ of $\left(\tilde{S}_{\delta}^{\mu}\right)$ such that

## 4 A priori Estimates

Using the fact that $\nabla p_{\delta_{n}}^{\mu}$ converges to $\nabla p^{\mu}$ weakly in $L^{2}\left(Q_{T}\right)$ as $\delta_{n} \downarrow 0$, we deduce, since $k_{a}\left(u^{\mu}\right) \varphi \in L^{2}\left(Q_{T}\right)$, that

$$
\begin{equation*}
\left|I_{\delta_{n}}^{2}\right| \text { tends to } 0 \text { as } \delta_{n} \downarrow 0 \text {. } \tag{5.16}
\end{equation*}
$$

Moreover we have by (4.10) that

$$
\begin{aligned}
\left|I_{\delta_{n}}^{1}\right| & \leq\left(\int_{Q_{T}}\left|k_{a}\left(u_{\delta_{n}}^{\mu}\right)-k_{a}\left(u^{\mu}\right)\right|^{2} \varphi^{2} d x d t\right)^{1 / 2}\left(\int_{Q_{T}}\left|\nabla p_{\delta_{n}}^{\mu}\right|^{2} d x d t\right)^{1 / 2} \\
& \leq C\left(\int_{Q_{T}}\left|k_{a}\left(u_{\delta_{n}}^{\mu}\right)-k_{a}\left(u^{\mu}\right)\right|^{2} \varphi^{2} d x d t\right)^{1 / 2} .
\end{aligned}
$$

Since $\left|k_{a}\left(u_{\delta_{n}}^{\mu}\right)-k_{a}\left(u^{\mu}\right)\right|^{2} \varphi^{2} \leq 4 \varphi^{2}$ and since $k_{a}\left(u_{\delta_{n}}^{\mu}\right)$ tends to $k_{a}\left(u^{\mu}\right)$ almost everywhere, we deduce from the Dominated Convergence Theorem that $I_{\delta_{n}}^{1}$ tends to 0 as $\delta_{n} \downarrow 0$. This with (5.16) implies (5.14), which with (5.9) gives that

$$
\begin{equation*}
k_{a}\left(u_{\delta_{n}}^{\mu}\right)\left[\nabla p_{\delta_{n}}^{\mu}+\nabla p_{c}\left(u_{\delta_{n}}^{\mu}\right)\right] \text { tends to } k_{a}\left(u^{\mu}\right)\left[\nabla p^{\mu}+\nabla p_{c}\left(u^{\mu}\right)\right] \text { weakly in } L^{2}\left(Q_{T}\right) \tag{5.17}
\end{equation*}
$$

The functional $v \mapsto \int_{Q_{T}} v^{2} d x d t$ is convex and lower semi continuous from $L^{2}\left(Q_{T}\right)$ to $\bar{R}$ therefore it is also weakly l.s.c. (see [2] Corollary III.8) and thus we deduce from (4.4), (4.9) and (5.17) that

$$
\begin{aligned}
\int_{Q_{T}}\left[k_{a}\left(u^{\mu}\right)\right]^{2}\left[\nabla p^{\mu}+\nabla p_{c}\left(u^{\mu}\right)\right]^{2} d x d t & \leq \liminf _{\delta_{n} \downarrow 0} \int_{Q_{T}}\left[k_{a}\left(u_{\delta_{n}}^{\mu}\right)\right]^{2}\left[\nabla p_{\delta_{n}}^{\mu}+\nabla p_{c}\left(u_{\delta_{n}}^{\mu}\right)\right]^{2} d x d t \\
& \leq \liminf _{\delta_{n} \downarrow 0} \int_{Q_{T}} k_{a}\left(u_{\delta_{n}}^{\mu}\right)\left[\nabla p_{\delta_{n}}^{\mu}+\nabla p_{c}\left(u_{\delta_{n}}^{\mu}\right)\right]^{2} d x d t \\
& \leq C \mu,
\end{aligned}
$$

which coincides with (5.1). Finally, we deduce respectively from (4.10), (4.13), (4.30) and (4.31) the estimates (5.2), (5.3), (5.4) and (5.5). This concludes the proof of Lemma 5.1.

## 6 Convergence as $\mu \downarrow 0$.

The goal of this section is to prove Theorem 2.3. We first deduce from the estimates (5.2), (5.4) and (5.5) that there exists a couple of functions ( $u, p$ ) and a subsequence $\left(\left(u^{\mu_{n}}, p^{\mu_{n}}\right)\right)_{n \in N}$ such that
$\left(u^{\mu_{n}}\right)_{n \in N}$ tends to $u$ strongly in $L^{2}\left(Q_{T}\right)$ and almost everywhere in $Q_{T}$, $\left(p^{\mu_{n}}\right)_{n \in N}$ tends to $p$ weakly in $L^{2}\left(0, T ; H^{1}(\Omega)\right)$,
as $\mu_{n}$ tends to zero. Moreover since

$$
0 \leq f^{\mu_{n}}\left(u^{\mu_{n}}\right) \leq 1,
$$

there exists a function $\hat{f} \in L^{2}\left(Q_{T}\right)$ with $0 \leq \hat{f} \leq 1$ and a subsequence $\left(f^{\mu_{n_{m}}}\left(u^{\mu_{n_{m}}}\right)\right)_{n_{m} \in N}$ of $\left(f^{\mu_{n}}\left(u^{\mu_{n}}\right)\right)_{n \in N}$ such that $\left(f^{\mu_{n_{m}}}\left(u^{\mu_{n_{m}}}\right)\right)_{n_{m} \in N}$ tends to $\hat{f}$ weakly in $L^{2}\left(Q_{T}\right)$ as $\mu_{n_{m}}$ tends to zero. Moreover we deduce respectively from (5.10) and (5.11) that $0 \leq u \leq 1$ and that

$$
\int_{\Omega} p(x, t) d x=0, \text { for almost every } t \in(0, T)
$$

which gives (2.18). As it is done in Section 6 in the proof of (5.1), one can first check that

$$
k_{a}\left(u^{\mu_{n_{m}}}\right)\left(\nabla p^{\mu_{n_{m}}}+\nabla p_{c}\left(u^{\mu_{n_{m}}}\right)\right) \text { tends to } k_{a}(u)\left(\nabla p+\nabla p_{c}(u)\right) \text { weakly in } L^{2}\left(Q_{T}\right)
$$

as $\mu_{n_{m}} \downarrow 0$ and then deduce from (5.1) the estimate (2.17). Furthermore letting $\mu_{n_{m}}$ tends to zero into (5.12) we obtain, since $\lim _{\mu_{n_{m} \downarrow 0}} f^{\mu_{n_{m}}}(s)=\chi(s)$ for all $s \in[0,1]$, that

$$
\begin{aligned}
\int_{0}^{T} \int_{\Omega} u \varphi_{t} d x d t= & \int_{0}^{T} \int_{\Omega} k_{w}(u) \nabla p \cdot \nabla \varphi d x d t-\int_{0}^{T} \int_{\Omega}\left(\chi(c) \bar{s}-\hat{f}_{\underline{s}}\right) \varphi d x d t \\
& -\int_{\Omega} u_{0}(x) \varphi(x, 0) d x
\end{aligned}
$$

which coincides with (2.16) and concludes the proof of Theorem 2.3.

## 7 Numerical simulations

### 7.1 The saturation equation and the numerical algorithm

In this section we present numerical simulations in one space dimension. To that purpose we apply the finite volume method, which we present below. To begin with, we rewrite the equations (2.1) and (2.2) in the case that $\Omega=(0,1)$; this gives for $(x, t) \in(0,1) \times(0, T)$

$$
\begin{align*}
& u_{t}^{\mu}=\partial_{x}\left(k_{w}\left(u^{\mu}\right) \partial_{x} p^{\mu}\right)+f^{\mu}(c) \bar{s}-f^{\mu}\left(u^{\mu}\right) \underline{s}  \tag{7.1}\\
& \left(1-u^{\mu}\right)_{t}=\partial_{x}\left(\frac{1}{\mu} k_{a}\left(u^{\mu}\right) \partial_{x}\left(p^{\mu}+p_{c}\left(u^{\mu}\right)\right)\right)+\left(1-f^{\mu}(c)\right) \bar{s}-\left(1-f^{\mu}\left(u^{\mu}\right)\right) \underline{s} \tag{7.2}
\end{align*}
$$

Adding up both equations and using the boundary conditions (2.4) and (2.5) we obtain

$$
\begin{equation*}
\partial_{x} p^{\mu}=-\frac{k_{a}\left(u^{\mu}\right)}{k_{a}\left(u^{\mu}\right)+\mu k_{w}\left(u^{\mu}\right)} \partial_{x}\left(p_{c}\left(u^{\mu}\right)\right) . \tag{7.3}
\end{equation*}
$$

Substituting (7.3) into (7.1) yields

$$
\begin{equation*}
u_{t}^{\mu}=-\partial_{x}\left[f^{\mu}\left(u^{\mu}\right) \frac{k_{a}\left(u^{\mu}\right)}{\mu} \partial_{x}\left(p_{c}\left(u^{\mu}\right)\right)\right]+f^{\mu}(c) \bar{s}-f^{\mu}\left(u^{\mu}\right) \underline{s} \tag{7.4}
\end{equation*}
$$

Moreover we deduce from (7.3) and the definition (2.12) of $\mathcal{R}^{\mu}$ that $\partial_{x} p^{\mu}=-\partial_{x}\left(\mathcal{R}^{\mu}\left(u^{\mu}\right)\right.$, so that in view of (2.3) we have

$$
\begin{equation*}
p^{\mu}(x, t)=-\mathcal{R}^{\mu}\left(u^{\mu}\right)(x, t)+\int_{0}^{1} \mathcal{R}^{\mu}\left(u^{\mu}\right)(y, t) d y \tag{7.5}
\end{equation*}
$$

In the sequel, we compare numerically the solution $u^{\mu}$ of (7.4) with the solution $u$ of the limit equation in the case that $u<1$, namely

$$
\begin{equation*}
u_{t}=-\partial_{x}\left(k_{w}(u) \partial_{x} p_{c}(u)\right)+\chi(c) \bar{s} \tag{7.6}
\end{equation*}
$$

We discretize the time evolution equation (7.4) together with the initial condition and the homogeneous Neumann boundary condition. The time explicit finite volume scheme is defined by the following equations in which $\mathcal{K}>0$ and $\mathcal{J}>0$ denote respectively the time and the space step.
(i) The discrete initial condition is given for $i \in\{0, \ldots,[1 / \mathcal{J}]\}$ by

$$
\begin{equation*}
\left[U^{\mu}\right]_{i}^{0}=u^{\mu}(i \mathcal{J}, 0) \tag{7.7}
\end{equation*}
$$

(ii) For $i \in\{0, \ldots,[1 / \mathcal{J}]\}$ and for $n \in\{0, \ldots,[T / \mathcal{K}]\}$ the discrete equation is given by

$$
\begin{equation*}
\frac{1}{\mathcal{K}}\left(\left[U^{\mu}\right]_{i}^{n+1}-\left[U^{\mu}\right]_{i}^{n}\right)=\left[F^{\mu}\right]_{i+1}^{n}-\left[F^{\mu}\right]_{i}^{n}+f^{\mu}\left(C_{i}^{n}\right) \bar{S}_{i}^{n}-f^{\mu}\left(\left[U^{\mu}\right]_{i}^{n}\right) \underline{S}_{i}^{n} \tag{7.8}
\end{equation*}
$$

where

$$
\left[F^{\mu}\right]_{i}^{n}=-\frac{1}{\mathcal{J}}\left(p_{c}\left(\left[U^{\mu}\right]_{i+1}^{n}\right)-p_{c}\left(\left[U^{\mu}\right]_{i}^{n}\right) \frac{k_{w}\left(\left[U^{\mu}\right]_{i+1}^{n}\right) k_{a}\left(\left[U^{\mu}\right]_{i}^{n}\right)}{\mu k_{w}\left(\left[U^{\mu}\right]_{i+1}^{n}\right)+k_{a}\left(\left[U^{\mu}\right]_{i}^{n}\right)} .\right.
$$

(iii) For $n \in\{0, \ldots,[T / \mathcal{K}]\}$ the discrete Neumann condition is defined by

$$
\begin{equation*}
\left[F^{\mu}\right]_{0}^{n}=0 \text { and }\left[F^{\mu}\right]_{[1 / \mathcal{J}]}^{n}=0 \tag{7.9}
\end{equation*}
$$

The numerical scheme (7.7)-(7.9) allows to build an approximate solution, $u_{\mathcal{J}, \mathcal{K}}:[0,1] \times$ $[0, T] \rightarrow \mathbf{R}$ for all $i \in\{0, \ldots,[1 / \mathcal{J}]\}$ and all $n \in\{0, \ldots,[T / \mathcal{K}]\}$, which is given by

$$
\begin{equation*}
u_{\mathcal{J}, \mathcal{K}}(x, t)=u_{i}^{n} \text {, for all } x \in(i \mathcal{J},(i+1) \mathcal{J}] \text { and for all } t \in(n \mathcal{K},(n+1) \mathcal{K}] . \tag{7.10}
\end{equation*}
$$

In order to also compute the pressures, we propose the following discrete equation corresponding to (7.5)

$$
\begin{equation*}
\left[P^{\mu}\right]_{i}^{n}=-\mathcal{R}\left(\left[U^{\mu}\right]_{i}^{n}\right)+\mathcal{J} \Sigma_{j=1}^{[1 / \mathcal{J}]} \mathcal{R}\left(\left[U^{\mu}\right]_{j}^{n}\right) . \tag{7.11}
\end{equation*}
$$

Finally, setting $p_{g}^{\mu}(x, t)=p^{\mu}(x, t)+p_{c}\left(u^{\mu}\right)(x, t)$ we deduce that

$$
\begin{equation*}
\left(\left[P_{g}^{\mu}\right]\right)_{i}^{n}=-\mathcal{R}\left(\left[U^{\mu}\right]_{i}^{n}+p_{c}\left(\left[U^{\mu}\right]_{i}^{n}\right)+\mathcal{J} \Sigma_{j=1}^{[1 / \mathcal{J}]} \mathcal{R}\left(\left[U^{\mu}\right]_{j}^{n}\right)\right. \tag{7.12}
\end{equation*}
$$

for all $i \in\{0, \ldots,[1 / \mathcal{J}]\}$ and all $n \in\{0, \ldots,[T / \mathcal{K}]\}$. Similarly we propose a finite volume scheme corresponding to the equation (7.6), namely

$$
\begin{equation*}
\frac{1}{\mathcal{K}}\left(U_{i}^{n+1}-U_{i}^{n}\right)=F_{i+1}^{n}-F_{i}^{n}+\chi\left(C_{i}^{n}\right) \bar{S}_{i}^{n} \tag{7.13}
\end{equation*}
$$

where

$$
F_{i}^{n}=-\frac{1}{\mathcal{J}}\left(p_{c}\left(U_{i+1}^{n}\right)-p_{c}\left(U_{i}^{n}\right) k_{w}\left(U_{i+1}^{n}\right)\right.
$$

for all $(i, n) \in\{0, \ldots,[1 / \mathcal{J}]\} \times\{0, \ldots,[T / \mathcal{K}]\}$.

### 7.2 Numerical tests

For the numerical computation we take $\mu=10^{-8}, p_{c}(z)=0,1 \sqrt{1-z}, k_{a}(z)=(1-z)^{2}$, $k_{w}(z)=\sqrt{z}$ and $\bar{s}(z)=\delta_{0}(z), \underline{s}(z)=\delta_{1}(z)$, where $\delta_{a}$ is the Dirac function at the point $a$. Furthermore $u^{\mu}$ is given by the line with crosses, $p_{g}^{\mu}$ is given by the lines with diam and the limit function $u$ corresponds to the continuous line.
$\underline{\text { First test case: }}$ The case that $c=0,7$ and $u_{0}=1$ on $[0,1]$. We obtain at $t=0,01$ the following pictures

We note that, for $\mu$ small, the functions $u$ and $u^{\mu}$ are very close. Here we only start with water and inject a mixture of water and air. The air immediately invades the whole domain. Figure 1 illustrates the result which we proved in this paper, namely that $u^{\mu}$ tends to the solution $u$ of the limit equation (7.6) as $\mu$ tends to 0 and moreover that the pressure $p_{a}^{\mu}$ is constant. This is indeed the case since $u<1$.
$\underline{\text { Second test case: }}$ The case that $c=0,7$ and $u_{0}(x)=\left\{\begin{array}{l}0,1 \text { on }[0,1 / 3] \\ 0,7 \text { on }(1 / 3,1]\end{array}\right.$. We obtain the following pictures for $t=0,01$ and for $t=0,1$ respectively

The injection of a mixture of water and air $(c=0.7)$ takes place in a region of low water saturation. We first remark that both functions $u^{\mu}$ and $u$ evolve very slowly. Here again we have that $u(x, t)<1$ for all $(x, t) \in(0,1) \times(0, T)$ and we remark that the graphs of the two functions $u^{\mu}$ and $u$ nearly coincide.

Third test case: The case that $c=1$ and $u_{0}(x)=\left\{\begin{array}{l}0,1 \text { on }[0,1 / 3] \\ 0,7 \text { on }(1 / 3,1]\end{array}\right.$. We obtain the following pictures for $t=0,01$ and for $t=0,1$ respectively

Here only water is injected; note that the saturation $u^{\mu}$ evolves rather fast.
